# A NOTE ON THE NEW *q*-EXTENSION OF FROBENIUS-EULER NUMBERS AND POLYNOMIALS

ABSTRACT. In this paper, we consider the new q-extension of Frobenius-Euler numbers and polynomials and we derive some interesting identities from the orthogonality type properties for the new q-extension of Frobenius-Euler polynomials. Finally we suggest one open question related to orthogonality of polynomials.

## 1. Introduction

For  $q \in [0,1]$ , we define the q-shifted factorials by  $(a:q)_0 = 1$ ,  $(a:q)_n = \prod_{i=0}^{n-1}(1-aq^i)$ ,  $(a:q)_{\infty} = \prod_{i=0}^{\infty}(1-aq^i)$ . If x is classical object, such as a complex number, its q-version is defined by  $[x]_q = \frac{1-q^x}{1-q}$ . As is well known, the q-exponential function is given by

$$e_q(z) = \sum_{n=0}^{\infty} \frac{z^n}{[n]_q!} = \frac{1}{((1-q)z:q)_{\infty}}, \quad (\text{see } [5], [7]), \tag{1.1}$$

where  $z \in \mathbb{C}$  with |z| < 1. The q-derivative is defined by

$$D_q f(x) = \frac{f(x) - f(qx)}{(1 - q)x}, \quad (\text{see } [5], [8], [9], [10]). \tag{1.2}$$

Note that  $\lim_{q\to 1} D_q f(x) = \frac{df(x)}{dx}$ . The definite *q*-integral is given by

$$\int_0^x f(t)d_q t = (1-q)\sum_{a=0}^\infty f(q^a x)xq^a, \quad (\text{see } [4], [7], [10]). \tag{1.3}$$

From (1.2) to (1.3), we have

$$\int_0^x t^n d_q t = \frac{1}{[n+1]_q} x^{n+1}, \quad D_q x^n = [n]_q x^{n-1}.$$

The  $q-{\rm Bernoulli}$  polynomials of Hegazi and Mansour are defined by the generating function to be

$$\sum_{n=0}^{\infty} B_{n,q}(x) \frac{t^n}{[n]_q!} = \frac{t}{e_q(t) - 1} e_q(xt), \quad (\text{see } [4]).$$
(1.5)

In the special case,  $x = 0, B_{n,q}(0) = B_{n,q}$  are called the *n*-th *q*-Bernoulli numbers.

By(1.5), we get

$$\sum_{n=0}^{\infty} B_{n,q}(x) \frac{t^n}{[n]_q!} = \left(\sum_{l=0}^{\infty} B_{l,q} \frac{t^l}{[l]_q!}\right) \left(\sum_{m=0}^{\infty} \frac{x^m}{[m]_q!} t^m\right)$$
$$= \sum_{n=0}^{\infty} \left(\sum_{l=0}^n \binom{n}{l}_q B_{l,q} x^{n-l}\right) \frac{t^n}{[n]_q!}$$
(1.6)

where  $\binom{n}{k}_{q} = \frac{[n]_{q}!}{[k]_{q}![n-k]_{q}!}, \quad [n]_{q}! = [n]_{q}[n-1]_{q} \cdots [2]_{q}[1]_{q}.$ Thus, from (1.6), we have

$$B_{n,q}(x) = \sum_{l=0}^{n} \binom{n}{l}_{q} B_{l,q} x^{n-l}.$$
 (1.7)

In [1.6], the new q-extension of Euler polynomials are also defined by the generating function to be

$$\frac{2}{e_q(t)+1}e_q(xt) = \sum_{n=0}^{\infty} E_{n,q}(x)\frac{t^n}{[n]_q!}.$$
(1.8)

In the special case, x = 0,  $E_{n,q}(0) = E_{n,q}$  are called the *n*-th *q*-Euler numbers.

By (1.8), we easily get

$$E_{n,q}(x) = \sum_{k=0}^{n} \binom{n}{k}_{q} E_{k,q} x^{n-k}, \quad (\text{see } [7]).$$
(1.9)

More than five decades age, Carlitz(see [8],[9]) defined a q-extension of Bernoulli and Euler polynomials. In a recent paper(see [10]), B.A. Kupershmidt constructed reflection symmetries of q-Bernoulli numbers and polynomials. From the methods of B.A. Kupershmidt, Hegazi and Mansour derived some interesting identities and properties related to q-Bernoulli and Euler polynomials. Recently, several authors have studied various q-extention of Bernoulli, Euler and Genocchi polynomials (see [1],[2],[4]-[14]). Let  $\mathcal{F}$  be the set of all formal power series in variable t over  $\mathbb{C}$  with

$$\mathcal{F} = \left\{ f(t) = \sum_{k=0}^{\infty} \frac{a_k}{[k]_q} t^k \mid a_k \in \mathbb{C} \right\}.$$
 (1.10)

Let  $\mathbb{P} = \mathbb{C}[x]$  and let  $\mathbb{P}^*$  be the vector space of all linear functionals on  $\mathbb{P}$ .  $< L \mid p(x) >$  denotes the action of linear functional L on the polynomials p(x), and it is well know that the vector space operation on  $\mathbb{P}^*$  defined by  $< L + M \mid p(x) > = < L \mid p(x) > + < M \mid p(x) >, < cL \mid p(x) > = c < L \mid p(x) >,$  where c is complex constant. For  $f(t) = \sum_{k=0}^{\infty} = \frac{a_k}{[k]_q!} t^k \in \mathcal{F}$ , Let us define the linear functional on  $\mathbb{P}$  by setting

$$\langle f(t) | x^n \rangle = a_n \ (n \ge 0).$$
 (1.11)

By (1.11), we get

$$< t^k \mid x^n >= [n]_q! \ \delta_{n,k}, \ (n,k \ge 0),$$
 (1.12)

where  $\delta_{n,k}$  is Kronecker's symbol.

Let  $f_L(t) = \sum_{k=0}^{\infty} \langle L | x^k \rangle \frac{t^k}{[k]_{q!}}$ . Then, by (1.12), we get

$$< f_L(t) \mid x^n > = < L \mid x^n > .$$
 (1.13)

Additionally, the map  $L \to f_L(t)$  is a vector space isomorphism from  $\mathbb{P}^*$  onto  $\mathbb{F}$ . Henceforth,  $\mathbb{F}$  denotes both the algebra of formal power series in t and the vector space of all linear functionals on  $\mathbb{P}$ , and so an element f(t) of  $\mathbb{F}$  will be thought as a formal power series and a linear functional. We call  $\mathbb{F}$  the q-umbral algebra. The q-umbral calculus is the study of q-umbral algebra. By (1.1) and (1.11), we easily see that  $\langle e_q(yt) | x^n \rangle = y^n$  and so  $\langle e_q(yt) | p(x) \rangle = p(y)$  for  $p(x) \in \mathbb{P}$ . The order O(f(t)) of the power series  $f(t) \neq 0$  is the smallest positive integer for which  $a_k$  does not vanish. If O(f(t)) = 0, then f(t) is called an invertible series. If O(f(t)) = 1, then f(t) is called a delta series(see[13], [14]).

For  $f(t) \in \mathbb{F}(t)$ ,  $p(x) \in \mathbb{P}$ , we have

$$f(t) = \sum_{k=0}^{\infty} \langle f(t) \mid t^k \rangle \frac{t^k}{[k]_q!}, \quad p(x) = \sum_{k=0}^{\infty} \langle t^k \mid p(x) \rangle \frac{x^k}{[k]_q!}.$$
 (1.14)

Thus, by (1.14), we get

$$p^{(k)}(0) = \langle t^k \mid p(x) \rangle, \quad \langle 1 \mid p^{(k)}(x) \rangle = p^{(k)}(0), \tag{1.15}$$

where  $p^{(k)}(x) = D_q^k p(x)$  (see[13], [14]). From (1.15), we have

$$t^{k}p(x) = p^{(k)}(x) = D_{q}^{k}p(x).$$
 (1.16)

For  $f(t), g(t) \in \mathbb{F}$  with O(f(t)) = 1, O(g(t)) = 0, there exists a unique sequence  $S_n(x)$   $(degS_n(x) = n)$  of polynomial such that  $\langle g(t)f(t)^k | S_n(x) \rangle = [n]_q! \delta_{n,k}$ ,  $(n, k \ge 0)$ . The sequence  $S_n(x)$  is called the q-Sheffer sequence for (g(t), f(t)) which is denoted by  $S_n(x) \sim (g(t), f(t))$ . For  $S_n(x) \sim (g(t), f(t))$ , we have

$$\frac{1}{g(\overline{f}(t))}e_q(y\overline{f}(t)) = \sum_{k=0}^{\infty} \frac{S_k(y)}{[k]_q!} t^k, \text{ for all } y \in \mathbb{C},$$
(1.17)

where  $\overline{f}(t)$  is the compositional inverse of f(t) (see[13]). Many researchers told that the properties of the q-extension of Frobenius-Euler polynomials are valuable and worthwhile in the areas of both number theory and mathematical physics (see[1],[2],[4]-[12]). In this paper, we consider new approach to q-extension of Frobenius-Euler numbers and polynomials which are derived from q-umbral Calculus and we give some interesting identities of our q-Frobenius-Euler numbers and polynomials. Finally, we suggest one open question related to orthogonality of Carlitz's q-Bernoulli polynomials.

## 2. q-extension of Frobenius-Euler polynomials

In this section, we assume that  $\lambda \in \mathbb{C}$  with  $\lambda \neq 1$ . Now, we consider new q-extension of Frobenius-Euler polynomials which are derived form the generating function as follows:

$$\frac{1-\lambda}{e_q(t)-\lambda}e_q(xt) = \sum_{n=0}^{\infty} H_{n,q}(x \mid \lambda) \frac{t^n}{[n]_q!}.$$
(2.1)

In the special case, x = 0,  $H_{n,q}(0 \mid \lambda) = H_{n,q}(\lambda)$  are called the *n*-th *q*-Frobenius-Euler numbers. Note that  $\lim_{q\to 1} H_{n,q}(x \mid \lambda) = H_n(x \mid \lambda)$ , where  $H_n(x \mid \lambda)$  are the *n*-th ordinary Frobenius-Euler polynomials. By (2.1), we easily see that

$$\sum_{n=0}^{\infty} H_{n,q}(x \mid \lambda) \frac{t^n}{[n]_q!} = \left(\sum_{l=0}^{\infty} H_{l,q}(\lambda) \frac{t^l}{[l]_q!}\right) \left(\sum_{m=0}^{\infty} \frac{x^m}{[m]_q!} t^m\right)$$
$$= \sum_{n=0}^{\infty} \left(\sum_{l=0}^n \binom{n}{l}_q H_{l,q}(\lambda) x^{n-l}\right) \frac{t^n}{[n]_q!}.$$
(2.2)

Thus, from (2.2), we have

$$H_{n.q}(x \mid \lambda) = \sum_{l=0}^{n} \binom{n}{l}_{q} H_{l,q}(\lambda) x^{n-l}.$$
(2.3)

By the definition of q-Frobenius-Euler numbers, we get

$$1 - \lambda = \left(\sum_{l=0}^{\infty} H_{l,q}(\lambda) \frac{t^l}{[l]_q!}\right) (e_q(t) - \lambda)$$
  
$$= \sum_{n=0}^{\infty} \left\{\sum_{m=o}^n \binom{n}{m}_q H_{n-m,q}(\lambda)\right\} \frac{t^n}{[n]_q!} - \lambda \sum_{n=0}^{\infty} H_{n,q}(\lambda) \frac{t^n}{[n]_q!} \qquad (2.4)$$
  
$$= \sum_{n=0}^{\infty} \left\{H_{n,q}(1 \mid \lambda) - \lambda H_{n,q}(\lambda)\right\} \frac{t^n}{[n]_q!}.$$

By comparing the coefficients on the both sides, we get

$$H_{0,q}(\lambda) = 1, \ H_{n,q}(1 \mid \lambda) - \lambda H_{n,q}(\lambda) = \begin{cases} 1 - \lambda, & \text{if } n = 0\\ 0, & \text{if } n > 0. \end{cases}$$
(2.5)

Therefore, by (2.3) and (2.5), we obtain the following theorem.

**Theorem 2.1.** For  $n \ge 0$ , we have

$$H_{n,q}(x \mid \lambda) = \sum_{l=0}^{n} \binom{n}{l}_{q} H_{n-l,q}(\lambda) x^{l}.$$

Moreover,

$$H_{0,q}(\lambda) = 1, \ H_{n,q}(1 \mid \lambda) - \lambda H_{n,q}(\lambda) = (1 - \lambda)\delta_{0,n}.$$

For examples,  $H_{0,q}(\lambda) = 1$ ,  $H_{1,q}(\lambda) = \frac{-1}{1-\lambda}$ ,  $H_{2,q}(\lambda) = \frac{\lambda+q}{(1-\lambda)^2}$ ,  $\cdots$ . From (1.17) and (2.1), we have

$$H_{n,q}(x \mid \lambda) \sim \left(\frac{e_q(t) - \lambda}{1 - \lambda}, t\right),$$
 (2.6)

and

$$\frac{1-\lambda}{e_q(t)-\lambda}e_q(xt) = \sum_{n=0}^{\infty} H_{n,q}(x\mid\lambda)\frac{t^n}{[n]_q!}.$$
(2.7)

Thus, by (2.7), we get

$$\frac{1-\lambda}{e_q(t)-\lambda}x^n = H_{n,q}(x \mid \lambda), \ (n \ge 0).$$
(2.8)

From (1.4), (1.16) and (2.8), we have

$$tH_{n,q}(x \mid \lambda) = \frac{1-\lambda}{e_q(t)-\lambda} tx^n = [n]_q \frac{1-\lambda}{e_q(t)-\lambda} x^{n-1}$$
  
=  $[n]_q H_{n-1,q}(x \mid \lambda).$  (2.9)

Therefore, by (2.8) and (2.9), we obtain the following lemma.

**Lemma 2.2.** For  $n \ge 0$ , we have

$$H_{n,q}(x \mid \lambda) = \frac{1-\lambda}{e_q(t) - \lambda} x^n, \ tH_{n,q}(x \mid \lambda) = [n]_q H_{n-1,q}(x \mid \lambda).$$

By (2.9), we get

$$\left\langle \frac{e_q(t) - \lambda}{1 - \lambda} t^k \mid H_{n,q}(x \mid \lambda) \right\rangle = \frac{[k]_q!}{1 - \lambda} \binom{n}{k}_q \left\langle e_q(t) - \lambda \mid H_{n-k,q}(x \mid \lambda) \right\rangle$$
$$= \frac{[k]_q!}{1 - \lambda} \binom{n}{k}_q \left\{ H_{n-k,q}(1 \mid \lambda) - \lambda H_{n-k,q}(\lambda) \right\}.$$
(2.10)

From (2.6), we have

$$\left\langle \frac{e_q(t) - \lambda}{1 - \lambda} t^k \mid H_{n,q}(x \mid \lambda) \right\rangle = [n]_q! \,\delta_{n,k}.$$
(2.11)

By (2.10) and (2.11), we get

$$0 = \frac{1}{1-\lambda} \left( H_{n-k,q}(1 \mid \lambda) - \lambda H_{n-k,q}(\lambda) \right)$$
  
= 
$$\sum_{l=0}^{n-k-l} \binom{n-k}{l}_{q} H_{l,q}(\lambda) + (1-\lambda) H_{n-k,q}(\lambda),$$
 (2.12)

where  $n, k \in \mathbb{Z}_{\geq 0}$  with n > k. Thus, from (2.12), we have

$$H_{n-k,q}(\lambda) = \frac{1}{\lambda - 1} \sum_{l=0}^{n-k-l} \binom{n-k}{l} H_{l,q}(\lambda),$$
(2.13)

where  $n, k \in \mathbb{Z}_{\geq 0}$  with n > k.

Therefore, by (2.13), we obtain the following theorem.

**Theorem 2.3.** For  $n \ge 1$ , we have

$$H_{n,q}(\lambda) = \frac{1}{\lambda - 1} \sum_{l=0}^{n-l} \binom{n}{l} H_{l,q}(\lambda).$$

A note on the new q-extension of Frobenius-Euler numbers and polynomials

From (1.4) and (2.3), we have

$$\int_{x}^{x+y} H_{n,q}(u \mid \lambda) d_{q} u = \frac{1}{[n+1]_{q}} \sum_{l=0}^{n} \binom{n+1}{l+1}_{q} H_{n-l,q}(\lambda) \left\{ (x+y)^{l+1} - x^{l+1} \right\}$$
$$= \frac{1}{[n+1]_{q}} \sum_{l=0}^{n+1} \binom{n+1}{l}_{q} H_{n+1-l,q}(\lambda) \left\{ (x+y)^{l} - x^{l} \right\}$$
$$= \frac{1}{[n+1]_{q}} \left\{ H_{n+1,q}(x+y \mid \lambda) - H_{n+1,q}(x \mid \lambda) \right\}.$$
(2.14)

Thus, by (2.14), we get

$$\left\langle \frac{e_q(t) - 1}{t} \mid H_{n,q}(x \mid \lambda) \right\rangle = \frac{1}{[n+1]_q} \left\langle \frac{e_q(t) - 1}{t} \mid tH_{n+1,q}(x \mid \lambda) \right\rangle$$
$$= \frac{1}{[n+1]_q} \left\langle e_q(t) - 1 \mid H_{n+1,q}(x \mid \lambda) \right\rangle$$
$$= \frac{1}{[n+1]_q} \left\{ H_{n+1,q}(1 \mid \lambda) - H_{n+1,q}(\lambda) \right\}$$
$$= \int_0^1 H_{n,q}(u \mid \lambda) d_q u.$$
(2.15)

Therefore, by (2.15), we obtain the following theorem.

**Theorem 2.4.** For  $n \ge 0$ , we have

$$\left\langle \frac{e_q(t)-1}{t} \mid H_{n,q}(x \mid \lambda) \right\rangle = \int_0^1 H_{n,q}(u \mid \lambda) d_q u.$$

Let

$$\mathbb{P}_n = \left\{ p(x) \in \mathbb{C}[x] \mid \deg \ p(x) \le n \right\}, \tag{2.16}$$

be the (n+1)-dimensional vector space over  $\mathbb{C}$ . For  $p(x) \in \mathbb{P}_n$ , let us assume that

$$p(x) = \sum_{k=0}^{n} C_k H_{k,q}(x \mid \lambda), \quad (n \ge 0).$$
(2.17)

Then, by (2.6), (2.11) and (2.17), we get

$$\left\langle \left(\frac{e_q(t) - \lambda}{1 - \lambda}\right) t^k \mid p(x) \right\rangle = \sum_{l=0}^n C_l \left\langle \left(\frac{e_q(t) - \lambda}{1 - \lambda}\right) t^k \mid H_{l,q}(x \mid \lambda) \right\rangle$$
  
$$= \sum_{l=0}^n C_l[l]_q! \ \delta_{l,k} = [k]_q! \ C_k.$$
(2.18)

By (2.18), we get

$$C_{k} = \frac{1}{[k]_{q}!} \left\langle \left( \frac{e_{q}(t) - \lambda}{1 - \lambda} \right) t^{k} \mid p(x) \right\rangle$$
  
=  $\frac{1}{(1 - \lambda)[k]_{q}!} \left\{ p^{(k)}(1) - \lambda p^{(k)}(0) \right\},$  (2.19)

where  $p^{(k)}(x) = D_q^k p(x)$ . Therefore, by (2.17) and (2.19), we obtain the following theorem.

**Theorem 2.5.** For  $p(x) \in \mathbb{P}_n$ , let  $p(x) = \sum_{k=0}^n C_k H_{k,q}(x \mid \lambda)$ Then we have

$$C_k = \frac{1}{[k]_q! (1-\lambda)} \left\{ p^{(k)}(1) - \lambda p^{(k)}(0) \right\},$$

where  $p^{(k)}(x) = D_q^k p(x)$ .

Let us take  $p(x) = B_{n,q}(x)$  with

$$B_{n,q}(x) = p(x) = \sum_{k=0}^{n} C_k H_{k,q}(x \mid \lambda).$$
(2.20)

Then, by Theorem 2.5, we get

$$C_{k} = \frac{1}{[k]_{q}! (1 - \lambda)} \times \{ [n]_{q} [n - 1]_{q} \cdots [n - k + 1]_{q} B_{n-k,q}(1) - \lambda [n]_{q} \cdots [n - k + 1]_{q} B_{n-k,q} \} = {\binom{n}{k}}_{q} \frac{1}{1 - \lambda} \{ B_{n-k,q}(1) - \lambda B_{n-k,q} \}.$$
(2.21)

Therefore, by (2.21), we obtain the following theorem.

**Theorem 2.6.** For  $n, k \ge 0$ , with n - k > 0, we have

$$B_{n,q}(x) = \frac{1}{1-\lambda} \sum_{k=0}^{n} \binom{n}{k}_{q} \{B_{n-k,q}(1) - \lambda B_{n-k,q}\} H_{k,q}(x \mid \lambda).$$

Let us take  $p(x) = x^n$  with

$$x^{n} = p(x) = \sum_{k=0}^{n} C_{k} H_{k,q}(x \mid \lambda).$$
(2.22)

From (1.5), we have

$$C_k = \frac{1}{1-\lambda} \binom{n}{k}_q - \frac{\lambda}{1-\lambda} \binom{n}{k}_q 0^{n-k}.$$
(2.23)

Thus, we have

$$x^{n} = \frac{1}{1-\lambda} \sum_{k=0}^{n} \binom{n}{k}_{q} H_{k,q}(x \mid \lambda) - \frac{\lambda}{1-\lambda} H_{n,q}(x \mid \lambda)$$
$$= \frac{1}{1-\lambda} \sum_{k=0}^{n-1} \binom{n}{k}_{q} H_{k,q}(x \mid \lambda) - H_{n,q}(x \mid \lambda).$$

By the same method, we easily see that

$$E_{n,q}(x) = \frac{1}{1-\lambda} \sum_{k=0}^{n} \binom{n}{k} \{ E_{n-k,q}(1) - \lambda E_{n-k,q} \} H_{k,q}(x \mid \lambda).$$

The q-extension of Frobenius-Euler polynomials of order  $r \ (r \in \mathbb{N})$  are defined by the generating function to be

$$\left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r e_q(xt) = \sum_{n=0}^{\infty} H_{n,q}^{(r)}(x\mid\lambda) \frac{t^n}{[n]_q!}.$$
(2.24)

In the special case, x = 0,  $H_{n,q}^{(r)}(0 \mid \lambda) = H_{n,q}^{(r)}(\lambda)$  are called the *n*-th *q*-Frobenius-Euler numbers of order *r*.

From (2.24), we can derive the following equation (2.25):

$$H_{n,q}^{(r)}(x \mid \lambda) = \sum_{l=0}^{n} {\binom{n}{l}}_{q} H_{n-l,q}^{(r)}(\lambda) x^{l}.$$
 (2.25)

by (1.17) and (2.24), we get

$$H_{n,q}^{(r)}(x \mid \lambda) \sim \left( \left( \frac{e_q(t) - \lambda}{1 - \lambda} \right)^r, t \right).$$
(2.26)

Thus, from (2.26), we have

$$\left\langle \left(\frac{e_q(t) - \lambda}{1 - \lambda}\right)^r t^k \mid H_{n,q}^{(r)}(x \mid \lambda) \right\rangle = [n]_q! \ \delta_{n,k}.$$
(2.27)

For  $p(x) \in \mathbb{P}_n$ , let us assume that

$$p(x) = \sum_{k=0}^{n} C_k^r H_{k,q}^{(r)}(x \mid \lambda), \ (n \ge 0).$$
(2.28)

From (2.27) and (2.28), we can derive the following equation (2.29):

$$\left\langle \left(\frac{e_q(t)-\lambda}{1-\lambda}\right)^r t^k \mid p(x) \right\rangle = \sum_{l=0}^n C_l^r \left\langle \left(\frac{e_q(t)-\lambda}{1-\lambda}\right)^r t^k \mid H_{l,q}^{(r)}(x \mid \lambda) \right\rangle$$

$$= \sum_{l=0}^n C_l^r [l]_q! \delta_{l,k} = C_k^r [k]_q!.$$
(2.29)

Thus, by (2.29), we get

$$C_{k}^{r} = \frac{1}{[k]_{q}!} \left\langle \left(\frac{e_{q}(t) - \lambda}{1 - \lambda}\right)^{r} t^{k} | p(x) \right\rangle$$
  
$$= \frac{1}{[k]_{q}!(1 - \lambda)^{r}} \sum_{j=0}^{r} {r \choose j} (-\lambda)^{r-j} \left\langle (e_{q}(t))^{j} | t^{k} p(x) \right\rangle$$
  
$$= \frac{1}{[k]_{q}!(1 - \lambda)^{r}} \sum_{j=0}^{r} {r \choose j} (-\lambda)^{r-j} \sum_{l=0}^{\infty} \sum_{l_{1}+\dots+l_{j}=l} \frac{\langle 1 | p^{(k+l)}(x) \rangle}{[l_{1}]_{q}! \cdots [l_{j}]_{q}!}$$
(2.30)  
$$= \frac{1}{[k]_{q}!(1 - \lambda)^{r}} \sum_{l=0}^{\infty} \sum_{j=0}^{r} \sum_{l_{1}+\dots+l_{j}=l} \frac{{r \choose j} (-\lambda)^{r-j}}{[l_{1}]_{q}! \cdots [l_{j}]_{q}!} p^{(k+l)}(0).$$

Therefore, by (2.28) and (2.30), we obtain the following theorem.

**Theorem 2.7.** For  $p(x) \in \mathbb{P}_n$ , let  $p(x) = \sum_{k=0}^n C_k^r H_{k,q}^{(r)}(x \mid \lambda)$ .

Then we have

$$C_k^r = \frac{1}{[k]_q!(1-\lambda)^r} \sum_{l=0}^{\infty} \sum_{j=0}^r \sum_{l_1+\dots+l_j=l} \frac{\binom{r}{j}(-\lambda)^{r-j}}{[l_1]_q!\cdots[l_j]_q!} p^{(k+l)}(0),$$

where  $p^{(k+l)}(x) = D_q^{k+l}p(x)$ .

From (1.17) and (2.30), we have

$$\sum_{n=0}^{\infty} H_{n,q}^{(r)}(x \mid \lambda) \frac{t^n}{[n]_q!} = \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r e_q(xt).$$
(2.31)

Thus, from (2.31), we have.

$$H_{n,q}^{(r)}(x \mid \lambda) = \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r x^n, \quad (n \ge 0),$$
(2.32)

and

A note on the new q-extension of Frobenius-Euler numbers and polynomials

$$tH_{n,q}^{(r)}(x \mid \lambda) = \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r tx^n = [n]_q \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r x^{n-1}$$
$$= [n]_q H_{n-1,q}^{(r)}(x \mid \lambda).$$
(2.33)

Indeed,

$$\left\langle \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r e_q(yt) \mid x^n \right\rangle = H_{n,q}^{(r)}(y \mid \lambda) = \sum_{l=0}^n \binom{n}{l}_q H_{n-l,q}^{(r)}(\lambda) y^l, \quad (2.34)$$

and

$$\left\langle \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r \mid x^n \right\rangle = \sum_{m=0}^{\infty} \left( \sum_{i_1+\dots+i_r=m} \frac{H_{i_1,q}(\lambda)\cdots H_{i_r,q}(\lambda)}{[i_1]_q!\cdots [i_r]_q!} \right) \langle t^m \mid x^n \rangle$$
$$= \sum_{i_1+\dots+i_r=n} \frac{[n]_q!}{[i_1]_q!\cdots [i_r]_q!} H_{i_1,q}(\lambda)\cdots H_{i_r,q}(\lambda)$$
$$= \sum_{i_1+\dots+i_r=n} \left( \frac{n}{i_1,\dots,i_r} \right)_q H_{i_1,q}(\lambda)\cdots H_{i_r,q}(\lambda),$$
(2.35)

where  $\binom{n}{i_1, \dots, i_r}_q = \frac{[n]_q!}{[i_1]_q! \cdots [i_r]_q!}$ . From (2.34), we note that

$$\left\langle \left(\frac{1-\lambda}{e_q(t)-\lambda}\right)^r \mid x^n \right\rangle = H_{n,q}^{(r)}(\lambda), \ (n \ge 0).$$
(2.36)

Therefore, by (2.35) and (2.36), we obtain the following theorem.

**Theorem 2.8.** For  $n \ge 0$ , we have

$$H_{n,q}^{(r)}(\lambda) = \sum_{i_1+\dots+i_r=n} \binom{n}{i_1,\dots,i_r}_q H_{i_1,q}(\lambda)\cdots H_{i_r,q}(\lambda).$$

Let us take  $p(x) = H_{n,q}^{(r)}(x \mid \lambda) \in \mathbb{P}_n$  with

 $\begin{array}{l} H_{n,q}^{(r)}(x \mid \lambda) = p(x) = \sum_{k=0}^{n} C_k H_{k,q}(x \mid \lambda). \end{array}$ Then, by Theorem2.5, we get

$$C_{k} = \frac{1}{(1-\lambda) [k]_{q}!} \left\langle \left(e_{q}(t) - \lambda\right) t^{k} \mid p(x) \right\rangle$$
  
$$= \frac{1}{1-\lambda} {n \choose k}_{q} \left\langle e_{q}(t) - \lambda \mid H_{n-k,q}^{(r)}(x \mid \lambda) \right\rangle$$
  
$$= \frac{{n \choose k}_{q}}{1-\lambda} \left\{ H_{n-k,q}^{(r)}(1 \mid \lambda) - \lambda H_{n-k,q}^{(r)}(\lambda) \right\}.$$
(2.37)

From (2.24), we can readily derive the following equation (2.38):

$$\sum_{n=0}^{\infty} \left\{ H_{n,q}^{(r)}(1 \mid \lambda) - \lambda H_{n,q}(\lambda) \right\} \frac{t^n}{[n]_q!}$$

$$= \left( \frac{1-\lambda}{e_q(t) - \lambda} \right)^r (e_q(t) - \lambda) = (1-\lambda) \left( \frac{1-\lambda}{e_q(t) - \lambda} \right)^{r-1} \qquad (2.38)$$

$$= (1-\lambda) \sum_{n=0}^{\infty} H_{n,q}^{(r-1)}(\lambda) \frac{t^n}{[n]_q!}.$$

By comparing the coefficients on the both sides of (2.38), we get

$$H_{n,q}^{(r)}(1 \mid \lambda) - \lambda H_{n,q}^{(r)}(\lambda) = (1 - \lambda) H_{n,q}^{(r-1)}(\lambda).$$
(2.39)

Therefore, by (2.37) and (2.39), we obtain the following theorem.

**Theorem 2.9.** For  $n \in \mathbb{Z}_{\geq 0}$  and  $r \in \mathbb{N}$ , we have

$$H_{n,q}^{(r)}(x \mid \lambda) = \sum_{k=0}^{n} \binom{n}{k}_{q} H_{n-k,q}^{(r-1)}(\lambda) H_{k,q}(x \mid \lambda).$$

Let us assume that  $p(x) = H_{n,q}(x \mid \lambda) \in \mathbb{P}_n$  with

$$H_{n,q}(x \mid \lambda) = p(x) = \sum_{k=0}^{n} C_k^r H_{k,q}^{(r)}(x \mid \lambda).$$
 (2.40)

Then, by Theorem 2.7, we get

$$C_{k}^{r} = \frac{1}{(1-\lambda)^{r} [k]_{q}!} \sum_{m=0}^{n-k} \sum_{l=0}^{r} {\binom{r}{l}} (-\lambda)^{r-l} \\ \times \sum_{i_{1}+\dots+i_{l}=m} {\binom{m}{i_{1},\dots,i_{l}}}_{q} \frac{[n]_{q}\dots[n-m-k+1]_{q}}{[m]_{q}!} H_{n-m-k,q}(\lambda) \\ = \frac{1}{(1-\lambda)} \sum_{m=0}^{n-k} \sum_{l=0}^{r} {\binom{r}{l}} (-\lambda)^{r-l} \sum_{i_{1}+\dots+i_{l}=m} {\binom{m}{i_{1},\dots,i_{l}}}_{q} \\ \times \frac{[m+k]_{q}!}{[m]_{q}[k]_{q}!} \times \frac{[n]_{q}\dots[n-m-k+1]_{q}}{[m+k]_{q}!} H_{n-m-k,q}(\lambda) \\ = \frac{1}{(1-\lambda)^{r}} \sum_{m=0}^{n-k} \sum_{l=0}^{r} \sum_{i_{1}+\dots+i_{l}=m} {\binom{r}{l}} \\ \times {\binom{m}{i_{1},\dots,i_{l}}}_{q} {\binom{m+k}{m}}_{q} {\binom{n}{m+k}}_{q} (-\lambda)^{r-l} H_{n-m-k,q}(\lambda).$$

$$(2.41)$$

Therefore, by (2.40) and (2.41), we obtain the following theorem.

**Theorem 2.10.** For  $n, r \ge 0$ , we have

$$H_{n,q}(x \mid \lambda) = \frac{1}{(1-\lambda)^r} \sum_{k=0}^n \left\{ \sum_{m=0}^{n-k} \sum_{l=0}^r \sum_{i_1+\dots+i_l=m} \binom{r}{l} (-\lambda)^{r-l} \binom{m}{i_1,\dots,i_l}_q \binom{m+k}{m}_q \binom{m}{m+k}_q H_{n-m-k,q}(\lambda) \right\} \times H_{k,q}^{(r)}(x \mid \lambda).$$

Remark. By the same method, we can see that

$$B_{n,q}^{(r)}(x) = \frac{1}{(1-\lambda)^r} \sum_{k=0}^n \left\{ \sum_{m=0}^{n-k} \sum_{l=0}^r \sum_{i_1+\dots+i_l=m} \binom{r}{l} (-\lambda)^{r-l} \binom{m}{i_1,\dots,i_l}_q \binom{m+k}{m}_q \binom{n}{m+k}_q B_{n-m-k,q}^{(r)} \right\} \times H_{k,q}^{(r)}(x \mid \lambda).$$

As is well known, the Carltz's q-Bernoullli polynomials are defined by the generating function to be

$$f(t,x) = \sum_{n=0}^{\infty} \beta_{n,q} \frac{t^n}{n!}$$
  
=  $-t \sum_{m=0}^{\infty} q^{2m} e^{[m+x]_q t} + (1-q) \sum_{m=0}^{\infty} q^m e^{[m+x]_q t}.$  (2.42)

Thus, we note that f(t, x) is an invertible series. From (2.42), we note that

$$\beta_{n,q}(x) = \frac{1}{(1-q)^n} \sum_{l=0}^n \binom{n}{l} (-1)^l q^{lx} \frac{l+1}{[l+1]_q}, \text{ (see [3])}.$$
(2.43)

In the special case, x = 0,  $\beta_{n,q} = \beta_{n,q}(0)$  are called the *n*-th Carlitz's *q*-Bernoulli numbers.

By (2.42) and (2.43), we readily see that

$$\beta_{n,q}(x) = \sum_{l=0}^{n} \binom{n}{l} q^{lx} \beta_{l,q}[x]_q^{n-l} \sim (f(t,x),t)$$

**Open Problem**. Let

$$\mathbb{P}_{n,q} = \{p([x]_q) \in \mathbb{C}[[x]_q] | \deg p([x]_q) \le n\}$$

For  $p([x]_q) \in \mathbb{P}_{n,q}$ , let us assume that  $p([x]_q) = \sum_{k=0}^n C_{k,q} \beta_{k,q}(x)$ . Determine the coefficient  $C_{k,q}$
