Limiting behavior of the Jeffreys Power-Expected-Posterior Bayes Factor in Gaussian Linear Models

Summary: Expected-posterior priors (EPP) have been proved to be extremely useful for testing hypothesis on the regression coefficients of normal linear models. One of the advantages of using EPPs is that impropriety of baseline priors causes no indeterminacy. However, in regression problems, they based on one or more training samples, that could influence the resulting posterior distribution. The power-expected-posterior priors are minimally-informative priors that diminishing the effect of training samples on the EPP approach, by combining ideas from the power-prior and unit-information-prior methodologies. In this paper we show the consistency of the Bayes factors when using the power-expected-posterior priors, with the independence Jeffreys (or reference) prior as a baseline, for normal linear models under very mild conditions on the design matrix.

Keywords: Bayesian variable selection; Bayes factors; Consistency; Expected-posterior priors; Gaussian linear models; Objective model selection methods; Power-expected-posterior priors; Power prior; Training sample; Unit-information prior.

1 Introduction

Pérez and Berger (2002) developed priors for use in model comparison, through utilization of the device of "imaginary training samples" (Good, 2004, Spiegelhalter and Smith, 1988, Iwaki, 1997). They defined the expected-posterior prior (EPP) as the posterior distribution of a parameter vector for the model under consideration, averaged over all possible imaginary samples \mathbf{y}^* coming from a "suitable" predictive distribution $m^*(\mathbf{y}^*)$. Hence the EPP for the parameters of any model $M_{\ell} \in \mathcal{M}$, with \mathcal{M} denoting the model space, is

$$\pi_{\ell}^{E}(\boldsymbol{\theta}_{\ell}) = \int \pi_{\ell}^{N}(\boldsymbol{\theta}_{\ell}|\boldsymbol{y}^{*}) \, m^{*}(\boldsymbol{y}^{*}) \, d\boldsymbol{y}^{*}, \qquad (1)$$

where $\pi_{\ell}^{N}(\boldsymbol{\theta}_{\ell}|\boldsymbol{y}^{*})$ is the posterior of $\boldsymbol{\theta}_{\ell}$ for model M_{ℓ} using a baseline prior $\pi_{\ell}^{N}(\boldsymbol{\theta}_{\ell})$ and data \boldsymbol{y}^{*} .

An attractive option for m^* arises from selecting a "reference" or "base" model M_0 for the training sample and defining $m^*(\boldsymbol{y}^*) = m_0^N(\boldsymbol{y}^*) \equiv f(\boldsymbol{y}^*|M_0)$ to be the prior predictive distribution, evaluated at \boldsymbol{y}^* , for the reference model M_0 under the baseline prior $\pi_0^N(\boldsymbol{\theta}_0)$. In the

variable-selection problem that we consider in this paper, following the skeptical-prior approach described by Spiegelhalter, Abrams and Myles (2004, Section 5.5.2), the constant model (with no predictors) is a good reference model. This selection makes calculations simpler, and additionally makes the EPP approach essentially equivalent to the arithmetic intrinsic Bayes factor approach of Berger and Pericchi (1996).

One of the advantages of using EPPs is that impropriety of baseline priors causes no indeterminacy. There is no problem with the use of an improper baseline prior $\pi_{\ell}^{N}(\boldsymbol{\theta}_{\ell})$ in (1); the arbitrary constants cancel out in the calculation of any Bayes factor. However, in regression problems, EPPs are based on one or more training samples, that could influence the resulting posterior distribution.

To diminish the effect of training samples on the EPP approach and simultaneously to produce a minimally-informative prior, Fouskakis, Ntzoufras and Draper (2013) introduce the power-expected-posterior priors (PEP), by combining ideas from the power-prior approach of Ibrahim and Chen (2000) and the unit-information-prior approach of Kass and Wasserman (1995). As a first step, the likelihoods involved in the EPP distribution are raised to the power $\frac{1}{\delta}$ and density-normalized. This power parameter δ is set equal to the size of the training sample n^* , to represent information equal to one data point. Regarding the size of the training sample, n^* , this is set equal to the sample size n; in this way the selection of a training sample and its effects on the posterior model comparison is completely avoided.

In what follows, we examine variable-selection problems in Gaussian regression models. Thus, for any model M_{ℓ} , with parameters $\boldsymbol{\theta}_{\ell} = (\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^2)$, the likelihood is specified by

$$(\mathbf{Y}|\mathbf{X}_{\ell},\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2},M_{\ell}) \sim N_{n}(\mathbf{X}_{\ell}\,\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2}\,\mathbf{I}_{n}),$$
 (2)

where $\mathbf{Y} = (Y_1, \dots, Y_n)$ is a vector containing the (real-valued) responses for all subjects, X_ℓ is an $n \times d_\ell$ design matrix containing the values of the explanatory variables in its columns, I_n is the $n \times n$ identity matrix, $\boldsymbol{\beta}_\ell$ is a vector of length d_ℓ summarizing the effects of the covariates in model M_ℓ on the response \mathbf{Y} and σ_ℓ^2 is the error variance. Furthermore we denote the imaginary/training data set \mathbf{y}^* , their size by n^* , and the corresponding imaginary design matrix by X^* of size $n^* \times (p+1)$, where p denotes the total number of available covariates. Following the PEP methodology we set $n^* = n$ and $X^* = X$.

For any $M_{\ell} \in \mathcal{M}$, we denote by $\pi_{\ell}^{N}(\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2}|\mathbf{X}_{\ell}^{*})$ the baseline prior for model parameters $\boldsymbol{\beta}_{\ell}$ and σ_{ℓ}^{2} . Then the power-expected-posterior (PEP) prior $\pi_{\ell}^{PEP}(\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2}|\mathbf{X}_{\ell}^{*}, \delta)$ takes the following form:

$$\pi_{\ell}^{PEP}(\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2} | \mathbf{X}_{\ell}^{*}, \delta) = \pi_{\ell}^{N}(\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2} | \mathbf{X}_{\ell}^{*}) \int \frac{m_{0}^{N}(\boldsymbol{y}^{*} | \mathbf{X}_{0}^{*}, \delta)}{m_{\ell}^{N}(\boldsymbol{y}^{*} | \mathbf{X}_{\ell}^{*}, \delta)} f(\boldsymbol{y}^{*} | \boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2}, M_{\ell}; \mathbf{X}_{\ell}^{*}, \delta) d\boldsymbol{y}^{*},$$

where $f(\boldsymbol{y}^*|\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^2, M_{\ell}; X_{\ell}^*, \delta) \propto f(\boldsymbol{y}^*|\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^2, M_{\ell}; X_{\ell}^*)^{\frac{1}{\delta}}$ is the EPP likelihood raised to the power of $\frac{1}{\delta}$ and density-normalized, i.e.,

$$f(\boldsymbol{y}^{*}|\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2},M_{\ell};X_{\ell}^{*},\delta) = \frac{f(\boldsymbol{y}^{*}|\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2},M_{\ell};X_{\ell}^{*})^{\frac{1}{\delta}}}{\int f(\boldsymbol{y}^{*}|\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2},M_{\ell};X_{\ell}^{*})^{\frac{1}{\delta}}d\boldsymbol{y}^{*}} = \frac{f_{N_{n^{*}}}(\boldsymbol{y}^{*};X_{\ell}^{*}\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2}I_{n^{*}})^{\frac{1}{\delta}}}{\int f_{N_{n^{*}}}(\boldsymbol{y}^{*};X_{\ell}^{*}\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2}I_{n^{*}})^{\frac{1}{\delta}}d\boldsymbol{y}^{*}}$$
$$= f_{N_{n^{*}}}(\boldsymbol{y}^{*};X_{\ell}^{*}\boldsymbol{\beta}_{\ell},\delta\sigma_{\ell}^{2}I_{n^{*}}); \qquad (4)$$

here $f_{N_d}(\boldsymbol{y}; \boldsymbol{\mu}, \boldsymbol{\Sigma})$ is the density of the *d*-dimensional Normal distribution with mean $\boldsymbol{\mu}$ and covariance matrix $\boldsymbol{\Sigma}$, evaluated at \boldsymbol{y} .

The distribution $m_{\ell}^{N}(\boldsymbol{y}^{*}|X_{\ell}^{*},\delta)$ appearing in (3) is the prior predictive distribution (or the marginal likelihood), evaluated at \boldsymbol{y}^{*} , of model M_{ℓ} with the power likelihood defined in (4) under

the baseline prior $\pi_{\ell}^{N}(\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2} \mid \mathbf{X}_{\ell}^{*})$, i.e.,

$$m_{\ell}^{N}(\boldsymbol{y}^{*}|X_{\ell}^{*},\delta) = \iint f_{N_{n^{*}}}(\boldsymbol{y}^{*};X_{\ell}^{*}\boldsymbol{\beta}_{\ell},\delta\,\sigma_{\ell}^{2}I_{n^{*}})\,\pi_{\ell}^{N}(\boldsymbol{\beta}_{\ell},\sigma_{\ell}^{2}|X_{\ell}^{*})\,d\boldsymbol{\beta}_{\ell}\,d\sigma_{\ell}^{2}.$$

Here we use the independence Jeffreys prior (or reference prior) as the baseline prior distribution. Hence for any $M_{\ell} \in \mathcal{M}$ we have

$$\pi_{\ell}^{N}(\boldsymbol{\beta}_{\ell}, \sigma^{2} \mid \mathbf{X}_{\ell}^{*}) = \frac{c_{\ell}}{\sigma_{\ell}^{2}}, \tag{6}$$

where c_{ℓ} is an unknown normalizing constant; we refer to the resulting PEP prior as *J-PEP*.

2 The conditional J-PEP prior distribution

In the following, we denote by

$$H_{\ell} = X_{\ell} (X_{\ell}^T X_{\ell})^{-1} X_{\ell}^T$$
 and $P_{\ell} = I_n - H_{\ell}$

and the corresponding measures based on X_ℓ^* by H_ℓ^* and P_ℓ^* , respectively.

Under (6), the corresponding marginal likelihood with response data y^* explanatory variables X_{ℓ}^* and likelihood function raised to the power of $1/\delta$ is given by

$$m_{\ell}^{N}(\boldsymbol{y}^{*}|\mathbf{X}_{\ell}^{*},\delta) = c_{\ell} \pi^{\frac{1}{2}(d_{\ell}-n^{*})} |\mathbf{X}_{\ell}^{T^{*}}\mathbf{X}_{\ell}^{*}|^{-1/2} \Gamma\left(\frac{n^{*}-d_{\ell}}{2}\right) RSS_{\ell}^{*-\frac{n^{*}-d_{\ell}}{2}},$$

where RSS_{ℓ}^* is the residual sum of squares given by $RSS_{\ell}^* = \boldsymbol{y}^{*T} P_{\ell}^* \boldsymbol{y}^*$.

The J-PEP prior for the parameters of model M_{ℓ} is given by

with the conditional J-PEP prior given by

$$\pi_{\ell}^{J-PEP}(\boldsymbol{\beta}_{\ell}, \sigma_{\ell}^{2} | \boldsymbol{\beta}_{0}, \sigma_{0}^{2}; \mathbf{X}_{\ell}^{*}, \delta) = \int \frac{f_{N_{n^{*}}}(\boldsymbol{y}^{*}; \mathbf{X}_{\ell} \boldsymbol{\beta}_{\ell}, \delta \sigma_{\ell}^{2} \mathbf{I}_{n^{*}}) f_{N_{n^{*}}}(\boldsymbol{y}^{*}; \mathbf{X}_{0} \boldsymbol{\beta}_{0}, \delta \sigma_{0}^{2} \mathbf{I}_{n^{*}}) c_{\ell} / \sigma_{\ell}^{2}}{c_{\ell} \pi^{\frac{1}{2}(d_{\ell}-n^{*})} |\mathbf{X}_{\ell}^{*T} \mathbf{X}_{\ell}^{*}|^{-1/2} \Gamma\left(\frac{n^{*}-d_{\ell}}{2}\right) RSS_{\ell}^{*} - \frac{n^{*}-d_{\ell}}{2}} d\boldsymbol{y}^{*}}$$

$$= \frac{\pi^{-\frac{1}{2}(d_{\ell}-n^{*})}}{\sigma_{\ell}^{2} \Gamma\left(\frac{n^{*}-d_{\ell}}{2}\right)} |\mathbf{X}_{\ell}^{*T} \mathbf{X}_{\ell}^{*}|^{1/2} \int RSS_{\ell}^{*} \frac{n^{*}-d_{\ell}}{2} f_{N_{n^{*}}}(\boldsymbol{y}^{*}; \mathbf{X}_{\ell} \boldsymbol{\beta}_{\ell}, \delta \sigma_{\ell}^{2} \mathbf{I}_{n^{*}}) f_{N_{n^{*}}}(\boldsymbol{y}^{*}; \mathbf{X}_{\ell} \overline{\boldsymbol{\beta}}_{0}, \delta \sigma_{0}^{2} \mathbf{I}_{n^{*}}) d\boldsymbol{y}^{*}$$

where $\overline{\overline{\beta}}_0 = (\beta_0^T, \mathbf{0}_{d_\ell - d_0}^T)^T$ and $\mathbf{0}_k$ being a vector of zeros of length k. The product of the two normal densities involved in the integrand is given by

Note that (8) was obtained from the property

 and $D=A_1^{-1}X\Theta_1+A_2^{-1}X\Theta_2$.

Expression (9) can be easily obtained using the identity:

with C a $n \times n$ lower triangular matrix (the Cholesky decomposition) with non zero elements in the diagonal such that $E = CC^T$.

Replacing (8) in (7), we obtain

\times \int \left(\boldsymbol{y}^{*T} \mathbf{P}_{\ell}^{*} \boldsymbol{y}^{*}\right)^{\frac{n^{*}-d_{\ell}}{2}} f_{N_{n^{*}}} \left(\boldsymbol{y}^{*}; \mathbf{E}^{-1} \mathbf{D}, \mathbf{E}^{-1}\right) d\boldsymbol{y}^{*}. \tag{10}$$

We set

$$z = E^{1/2} (y^* - E^{-1}D) = \zeta^{1/2} (y^* - X_{\ell}^*\Gamma)$$

where $\zeta = \left(\frac{\sigma_\ell^2 + \sigma_0^2}{\delta \sigma_0^2 \sigma_\ell^2}\right)$ and $\Gamma = (\zeta \delta)^{-1} \left(\frac{\sigma_\ell^2}{\sigma_\ell^2 + \sigma_0^2} \overline{\overline{\beta}}_0 + \frac{\sigma_0^2}{\sigma_\ell^2 + \sigma_0^2} \beta_\ell\right)$. Therefore we have $\boldsymbol{y}^* = \zeta^{-1/2} \boldsymbol{z} + X_\ell^* \Gamma$, $d\boldsymbol{y}^* = \zeta^{-n^*/2} d\boldsymbol{z}$ and

$$f_{N_{n^*}}\left(\boldsymbol{y}^*; \mathbf{E}^{-1}\mathbf{D}, \mathbf{E}^{-1}\right) d\boldsymbol{y}^* = f_{N_{n^*}}\left(\boldsymbol{z}; \mathbf{0}, \mathbf{I}_{n^*}\right) d\boldsymbol{z}$$

since the term $\zeta^{-n^*/2}$, coming from the Jacobian of the transformation, cancels out with the determinant of the variance, that is $|\mathbf{E}|^{1/2} = \zeta^{n^*/2}$. Moreover,

$$= 4c_0(2\pi)^{-\frac{n-d_0}{2}} \frac{\Gamma(n^* - d_\ell)}{\Gamma(\frac{n^* - d_\ell}{2})^2} \int_0^{\pi/2} \frac{(\sin\phi\cos\phi)^{n^* - d_\ell - 1}}{|B(\phi)|^{1/2}|A(\phi)|^{1/2}D(\phi)} E_R(w^{n-d_0 - 2}; D(\phi)^{-1}) d\phi,$$

where $f_R(w; s^2)$ is the density function of the Rayleigh distribution with scale parameter s^2 (which here is equal to $D(\phi)^{-1}$) and variance $s^2(4-\pi)/2$. Moreover, by $E_R(w^k; s^2)$ we denote the corresponding k^{th} moment about zero which is given by $s^k 2^{k/2} \Gamma(1+k/2)$. Therefore we have:

$$\begin{split} m_{\ell}^{J-PEP}(\boldsymbol{y}|\mathbf{X}_{\ell}, \mathbf{X}_{\ell}^{*}, \delta) &= \\ &= 4c_{0}(2\pi)^{-\frac{n-d_{0}}{2}} \frac{\Gamma\left(n^{*}-d_{\ell}\right)}{\Gamma\left(\frac{n^{*}-d_{\ell}}{2}\right)^{2}} \int_{0}^{\pi/2} \frac{(\sin\phi\cos\phi)^{n^{*}-d_{\ell}-1}2^{(n-d_{0}-2)/2}\Gamma\left(1+\frac{n-d_{0}-2}{2}\right)}{|B(\phi)|^{1/2}|A(\phi)|^{1/2}[D(\phi)]^{1+(n-d_{0}-2)/2}} d\phi, \\ &= 4c_{0}(2\pi)^{-\frac{n-d_{0}}{2}} \frac{\Gamma\left(n^{*}-d_{\ell}\right)}{\Gamma\left(\frac{n^{*}-d_{\ell}}{2}\right)^{2}} 2^{(n-d_{0})/2-1}\Gamma\left(\frac{n-d_{0}}{2}\right) \int_{0}^{\pi/2} \frac{(\sin\phi\cos\phi)^{n^{*}-d_{\ell}-1}}{|B(\phi)|^{1/2}|A(\phi)|^{1/2}[D(\phi)]^{(n-d_{0})/2}} d\phi, \\ &= 2c_{0}\pi^{-\frac{n-d_{0}}{2}} \frac{\Gamma\left(n^{*}-d_{\ell}\right)\Gamma\left(\frac{n-d_{0}}{2}\right)}{\Gamma\left(\frac{n^{*}-d_{\ell}}{2}\right)^{2}} \int_{0}^{\pi/2} \frac{(\sin\phi\cos\phi)^{n^{*}-d_{\ell}-1}}{|B(\phi)|^{1/2}|A(\phi)|^{1/2}[D(\phi)]^{(n-d_{0})/2}} d\phi. \end{split}$$

Hence the Bayes factor of model M_{ℓ} versus the reference model M_0 , under the J-PEP prior approach, is given by

$$BF_{\ell 0}^{J-PEP} = \frac{2c_0\pi^{-\frac{n-d_0}{2}}\frac{\Gamma(n^*-d_\ell)\Gamma(\frac{n-d_0}{2})}{\Gamma(\frac{n^*-d_\ell}{2})^2} \int_{0}^{\pi/2} \frac{(\sin\phi\cos\phi)^{n^*-d_\ell-1}}{|B(\phi)|^{1/2}|A(\phi)|^{1/2}[D(\phi)]^{(n-d_0)/2}} d\phi.$$

$$= 2\frac{\Gamma(n^*-d_\ell)}{\Gamma(\frac{n^*-d_\ell}{2})^2} |X_0^T X_0|^{\frac{1}{2}} RSS_0^{\frac{n-d_0}{2}} \int_{0}^{\pi/2} \frac{(\sin\phi\cos\phi)^{n^*-d_\ell-1}}{|B(\phi)|^{1/2}|A(\phi)|^{1/2}[D(\phi)]^{(n-d_0)/2}} d\phi. \tag{24}$$

Under the J-PEP approach we set $(X_{\ell}^{*T}X_{\ell}^{*}) = (X_{\ell}^{T}X_{\ell}), n^{*} = n$ and $\delta = n$ and thus

$$B(\phi) = \sin^2 \phi \, \mathbf{I}_n + \delta \mathbf{X}_\ell (\mathbf{X}_\ell^T \mathbf{X}_\ell)^{-1} \mathbf{X}_\ell^T = \sin^2 \phi \, \mathbf{I}_n + \delta \mathbf{H}_\ell .$$

Moreover,

$$B^{-1}(\phi) = \left[\sin^{2}\phi \ I_{n} + \delta H_{\ell}\right]^{-1} = \frac{1}{\sin^{2}\phi} \left[I_{n} + \frac{\delta}{\sin^{2}\phi} X_{\ell} (X_{\ell}^{T} X_{\ell})^{-1} X_{\ell}^{T}\right]^{-1}$$

$$= \frac{1}{\sin^{2}\phi} \left[I_{n}^{-1} - I_{n}^{-1} \frac{\delta}{\sin^{2}\phi} X_{\ell} \left(\left[(X_{\ell}^{T} X_{\ell})^{-1}\right]^{-1} + \frac{\delta}{\sin^{2}\phi} X_{\ell}^{T} X_{\ell}\right)^{-1} X_{\ell}^{T} I_{n}^{-1}\right]$$

$$= \frac{1}{\sin^{2}\phi} \left[I_{n} - \frac{\delta}{\sin^{2}\phi} \frac{\sin^{2}\phi}{\delta + \sin^{2}\phi} H_{\ell}\right] = \frac{1}{\sin^{2}\phi} \left[I_{n} - \frac{\delta}{\delta + \sin^{2}\phi} H_{\ell}\right]$$

$$= \frac{1}{\sin^{2}\phi} \frac{\delta}{\delta + \sin^{2}\phi} \left[I_{n} - H_{\ell}\right] + \frac{1}{\sin^{2}\phi} \frac{\sin^{2}\phi}{\delta + \sin^{2}\phi} I_{n}$$

$$= \frac{\delta}{\sin^{2}\phi(\delta + \sin^{2}\phi)} P_{\ell} + \frac{1}{\delta + \sin^{2}\phi} I_{n}$$
(25)

and $|B(\phi)| = |\sin^2 \phi \ \mathrm{I}_n + \delta \mathrm{H}_\ell| = (\sin^2 \phi)^n \ | \ \mathrm{I}_n + \frac{\delta}{\sin^2 \phi} \mathrm{H}_\ell| = (\sin^2 \phi)^n \ | \ \mathrm{I}_{d_\ell} + \frac{\delta}{\sin^2 \phi} (\mathrm{X}_\ell^T \mathrm{X}_\ell) (\mathrm{X}_\ell^T \mathrm{X}_\ell)^{-1} |$ resulting in

$$|B(\phi)| = (\sin^2 \phi)^n \left(1 + \frac{\delta}{\sin^2 \phi}\right)^{d_\ell} = (\sin^2 \phi)^{n - d_\ell} (\delta + \sin^2 \phi)^{d_\ell}.$$

Also $\boldsymbol{y}^T B^{-1}(\phi) \boldsymbol{y} = \frac{\delta}{\sin^2 \phi (\delta + \sin^2 \phi)} \boldsymbol{y}^T [I_n - H_\ell] \boldsymbol{y} + \frac{1}{\delta + \sin^2 \phi} \boldsymbol{y}^T \boldsymbol{y} = \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \boldsymbol{y}^T \boldsymbol{y} \right)$. From (19), $A(\phi)$ is now given by

$$A(\phi) = X_0^T B^{-1}(\phi) X_0 = \frac{1}{\sin^2 \phi} X_0^T \left[I_n - \frac{\delta}{\delta + \sin^2 \phi} H_\ell \right] X_0$$

$$= \frac{1}{\sin^2 \phi} \left[X_0^T X_0 - \frac{\delta}{\delta + \sin^2 \phi} X_0^T H_\ell X_0 \right] = \frac{1}{\sin^2 \phi} \left[X_0^T X_0 - \frac{\delta}{\delta + \sin^2 \phi} X_0^T X_0 \right]$$

$$= \frac{1}{\delta + \sin^2 \phi} X_0^T X_0$$

since H_{ℓ} is idempotent and $X_0^T H_{\ell} = X_0$ for any model M_0 nested in M_{ℓ} . This comes from the blockwize formula where for any $X_{\ell} = [X_0, X_{\ell \setminus 0}]$ we have

$$H_{\ell} = H_{0} + H_{(I_{n} - H_{0})X_{\ell \setminus 0}} \Leftrightarrow X_{0}^{T} H_{\ell} = X_{0}^{T} H_{0} + X_{0}^{T} H_{P_{0}X_{\ell \setminus 0}}$$

$$= X_{0}^{T} + X_{0}^{T} P_{0} X_{\ell \setminus 0} \left\{ [P_{0} X_{\ell \setminus 0}]^{T} P_{0} X_{\ell \setminus 0} \right\}^{-1} [P_{0} X_{\ell \setminus 0}]^{T}$$

$$= X_{0}^{T} + (X_{0}^{T} - X_{0}^{T} H_{0}) X_{\ell \setminus 0} \left\{ [P_{0} X_{\ell \setminus 0}]^{T} (P_{0} X_{\ell \setminus 0}) \right\}^{-1} [P_{0} X_{\ell \setminus 0}]^{T} = X_{0}^{T}$$

Therefore $|A(\phi)| = (\delta + \sin^2 \phi)^{-d_0} |X_0^T X_0|$ and $X_0 A^{-1}(\phi) X_0 = (\delta + \sin^2 \phi) H_0$. From (21), we obtain

that

$$\begin{split} D(\phi) &= & \mathbf{y}^T B^{-1}(\phi) \mathbf{y} - \mathbf{y}^T B^{-1}(\phi) \mathbf{X}_0 A^{-1}(\phi) \mathbf{X}_0^T B^{-1}(\phi) \mathbf{y} \\ &= & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \mathbf{y}^T \mathbf{y} \right) - \mathbf{y}^T B^{-1}(\phi) [(\delta + \sin^2 \phi) \mathbf{H}_0] B^{-1}(\phi) \mathbf{y} \\ &= & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \mathbf{y}^T \mathbf{y} \right) - (\delta + \sin^2 \phi) \mathbf{y}^T \\ &= & \left[\frac{1}{\sin^2 \phi} \left(\mathbf{I}_n - \frac{\delta}{\delta + \sin^2 \phi} \mathbf{H}_\ell \right) \right] \mathbf{H}_0 \left[\frac{1}{\sin^2 \phi} \left(\mathbf{I}_n - \frac{\delta}{\delta + \sin^2 \phi} \mathbf{H}_\ell \right) \right] \mathbf{y} \\ &= & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \mathbf{y}^T \mathbf{y} \right) \\ &- \frac{\delta + \sin^2 \phi}{\sin^4 \phi} \mathbf{y}^T \left(\mathbf{I}_n - \frac{\delta}{\delta + \sin^2 \phi} \mathbf{H}_\ell \right) \mathbf{H}_0 \left(\mathbf{I}_n - \frac{\delta}{\delta + \sin^2 \phi} \mathbf{H}_\ell \right) \mathbf{y} \\ &= & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \mathbf{y}^T \mathbf{y} \right) \\ &- \frac{\delta + \sin^2 \phi}{\sin^4 \phi} \mathbf{y}^T \left(\mathbf{H}_0 - \frac{\delta}{\delta + \sin^2 \phi} \mathbf{H}_\ell \mathbf{H}_0 - \frac{\delta}{\delta + \sin^2 \phi} \mathbf{H}_0 \mathbf{H}_\ell + \left[\frac{\delta}{\delta + \sin^2 \phi} \right]^2 \mathbf{H}_\ell \mathbf{H}_0 \mathbf{H}_\ell \right) \mathbf{y} \\ &\stackrel{(\mathbf{H}_0 \mathbf{H}_\ell = \mathbf{H}_0)}{=} & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \mathbf{y}^T \mathbf{y} \right) - \frac{\delta + \sin^2 \phi}{\sin^4 \phi} \left[\frac{\sin^2 \phi}{\delta + \sin^2 \phi} \right]^2 \mathbf{y}^T \mathbf{H}_0 \mathbf{y} \\ &= & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + \mathbf{y}^T \mathbf{y} - \mathbf{y}^T \mathbf{H}_0 \mathbf{y} \right) \\ &= & \frac{1}{\delta + \sin^2 \phi} \left(\frac{\delta}{\sin^2 \phi} RSS_\ell + RSS_0 \right). \end{split}$$

By substituting the above equations in (24), we obtain

$$\begin{split} B_{\ell 0}^{J-PEP} &= 2 \; \frac{\Gamma \left(n - d_{\ell} \right)}{\Gamma \left(\frac{n - d_{\ell}}{2} \right)^{2}} | \mathbf{X}_{0}^{T} \mathbf{X}_{0} |^{\frac{1}{2}} RSS_{0}^{\frac{n - d_{0}}{2}} \int_{0}^{\pi/2} \frac{(\sin \phi \cos \phi)^{n - d_{\ell} - 1}}{|B(\phi)|^{1/2} |A(\phi)|^{1/2} [D(\phi)]^{(n - d_{0})/2}} d\phi \\ &= 2 \; \frac{\Gamma \left(n - d_{\ell} \right)}{\Gamma \left(\frac{n - d_{\ell}}{2} \right)^{2}} | \mathbf{X}_{0}^{T} \mathbf{X}_{0} |^{\frac{1}{2}} RSS_{0}^{\frac{n - d_{0}}{2}} \\ & \int_{0}^{\pi/2} \frac{(\sin \phi \cos \phi)^{n - d_{\ell} - 1} (n + \sin^{2} \phi)^{\frac{n - d_{0}}{2}} \left(\frac{n}{\sin^{2} \phi} RSS_{\ell} + RSS_{0} \right)^{-\frac{n - d_{0}}{2}}}{(\sin^{2} \phi)^{\frac{n - d_{\ell}}{2}} (n + \sin^{2} \phi)^{\frac{d_{\ell}}{2}} (n + \sin^{2} \phi)^{-\frac{d_{0}}{2}} |\mathbf{X}_{0}^{T} \mathbf{X}_{0}|^{1/2}} d\phi \\ &= 2 \; \frac{\Gamma \left(n - d_{\ell} \right)}{\Gamma \left(\frac{n - d_{\ell}}{2} \right)^{2}} \int_{0}^{\pi/2} \frac{(\sin \phi \cos \phi)^{n - d_{\ell} - 1} (n + \sin^{2} \phi)^{\frac{n - d_{0}}{2}} (\sin^{2} \phi)^{\frac{n - d_{0}}{2}} \left(n + \sin^{2} \phi)^{-\frac{d_{0}}{2}} \right)^{-\frac{n - d_{0}}{2}}}{(\sin^{2} \phi)^{\frac{n - d_{\ell}}{2}} (n + \sin^{2} \phi)^{\frac{d_{\ell}}{2}} (n + \sin^{2} \phi)^{-\frac{d_{0}}{2}}} d\phi \\ &= 2 \; \frac{\Gamma \left(n - d_{\ell} \right)}{\Gamma \left(\frac{n - d_{\ell}}{2} \right)^{2}} \int_{0}^{\pi/2} \frac{(\sin \phi)^{n - d_{0} - 1} (\cos \phi)^{n - d_{\ell} - 1} (n + \sin^{2} \phi)^{\frac{n - d_{0}}{2}}}{\left(n + \frac{n - d_{0}}{2} \right)^{\frac{n - d_{0}}{2}}} d\phi \end{aligned} \tag{26}$$

For large n, we can write

$$(n + \sin^2 \phi)^{\frac{n - d_{\ell}}{2}} = (n + \sin^2 \phi)^{\frac{n}{2}} (n + \sin^2 \phi)^{\frac{-d_{\ell}}{2}} = n^{\frac{n}{2}} \left(1 + \frac{\sin^2 \phi/2}{n/2} \right)^{\frac{n}{2}} (n + \sin^2 \phi)^{\frac{-d_{\ell}}{2}}$$

$$\approx n^{\frac{n}{2}} (n + \sin^2 \phi)^{\frac{-d_{\ell}}{2}} \exp\left(\frac{\sin^2 \phi}{2}\right)$$

$$\approx n^{\frac{n - d_{\ell}}{2}} \exp\left(\frac{\sin^2 \phi}{2}\right) .$$

Similarly,

$$\left(n\frac{RSS_{\ell}}{RSS_{0}} + \sin^{2}\phi\right)^{\frac{n-d_{0}}{2}} = \left[n\frac{RSS_{\ell}}{RSS_{0}}\right]^{\frac{n-d_{0}}{2}} \left(1 + \frac{\frac{1}{2}\sin^{2}\phi\frac{RSS_{0}}{RSS_{\ell}}}{n/2}\right)^{\frac{n}{2}} \left(1 + \frac{\sin^{2}\phi\frac{RSS_{0}}{RSS_{\ell}}}{n}\right)^{\frac{-d_{0}}{2}} \\
\approx \left[n\frac{RSS_{\ell}}{RSS_{0}}\right]^{\frac{n-d_{0}}{2}} \exp\left(\frac{1}{2}\sin^{2}\phi\frac{RSS_{0}}{RSS_{\ell}}\right).$$

Moreover, for large z we have

$$\log \Gamma(z) \approx \left(z - \frac{1}{2}\right) \log z - z + \frac{1}{2} \log(2\pi).$$

Hence

$$\log \Gamma(n - d_{\ell}) \approx \left(n - d_{\ell} - \frac{1}{2}\right) \log(n - d_{\ell}) - (n - d_{\ell}) + \frac{1}{2} \log(2\pi)$$

$$\log \Gamma\left(\frac{n - d_{\ell}}{2}\right) \approx \left(\frac{n - d_{\ell} - 1}{2}\right) \log\left(\frac{n - d_{\ell}}{2}\right) - \left(\frac{n - d_{\ell}}{2}\right) + \frac{1}{2} \log(2\pi)$$

$$\log \Gamma(n - d_{\ell}) - 2 \log \Gamma\left(\frac{n - d_{\ell}}{2}\right) \approx \left(n - d_{\ell} - \frac{1}{2}\right) \log(n - d_{\ell}) - (n - d_{\ell}) + \frac{1}{2} \log(2\pi)$$

$$-2\left(\frac{n - d_{\ell} - 1}{2}\right) \log\left(\frac{n - d_{\ell}}{2}\right) + 2\left(\frac{n - d_{\ell}}{2}\right) - 2\frac{1}{2} \log(2\pi)$$

$$\approx \frac{1}{2} \log(n - d_{\ell}) - \frac{1}{2} \log(2\pi) + (n - d_{\ell} - 1) \log 2$$

$$\approx \frac{1}{2} \log(n) + n \log 2.$$

From the above we obtain that

$$\log B_{\ell 0}^{J-PEP} \approx \frac{1}{2} \log(n - d_{\ell}) - \frac{1}{2} \log(2\pi) + (n - d_{\ell}) \log 2$$

$$+ \log \int_{0}^{\pi/2} \frac{(\sin \phi)^{n - d_{0} - 1} (\cos \phi)^{n - d_{\ell} - 1} n^{\frac{n - d_{\ell}}{2}} \exp\left(\frac{\sin^{2} \phi}{2}\right)}{\left[n^{\frac{RSS_{\ell}}{RSS_{0}}}\right]^{\frac{n - d_{0}}{2}}} \exp\left(\frac{1}{2} \sin^{2} \phi \frac{RSS_{0}}{RSS_{\ell}}\right)$$

$$\approx \frac{1}{2} \log(n - d_{\ell}) - \frac{1}{2} \log(2\pi) + (n - d_{\ell}) \log 2 + \frac{n - d_{\ell}}{2} \log n - \frac{n - d_{0}}{2} \log n \log 2$$

$$- \frac{n - d_{0}}{2} \log \frac{RSS_{\ell}}{RSS_{0}} + \log \int_{0}^{\pi/2} \frac{(\sin \phi)^{n - d_{0} - 1} (\cos \phi)^{n - d_{\ell} - 1} \exp\left(\frac{\sin^{2} \phi}{2}\right)}{\exp\left(\frac{1}{2} \sin^{2} \phi \frac{RSS_{0}}{RSS_{\ell}}\right)} d\phi$$

$$\approx \frac{1}{2} \log(n - d_{\ell}) - \frac{1}{2} \log(2\pi) + (n - d_{\ell}) \log 2 - \frac{d_{\ell} - d_{0}}{2} \log n$$

$$- \frac{n - d_{0}}{2} \log \frac{RSS_{\ell}}{RSS_{0}} + \log \int_{0}^{\pi/2} \frac{(\sin \phi)^{n - d_{0} - 1} (\cos \phi)^{n - d_{\ell} - 1} \exp\left(\frac{\sin^{2} \phi}{2}\right)}{\exp\left(\frac{1}{2} \sin^{2} \phi \frac{RSS_{0}}{RSS_{\ell}}\right)} d\phi$$

$$\approx \frac{1}{2} \log n + n \log 2 - \frac{d_{\ell} - d_{0}}{2} \log n - \frac{n}{2} \log \frac{RSS_{\ell}}{RSS_{0}}$$

$$(27)$$

since the integral

$$\int_{0}^{\pi/2} \frac{(\sin\phi)^{n-d_0-1}(\cos\phi)^{n-d_\ell-1} \exp\left(\frac{\sin^2\phi}{2}\right)}{\exp\left(\frac{1}{2}\sin^2\phi\frac{RSS_0}{RSS_\ell}\right)} d\phi \le \int_{0}^{\pi/2} \exp\left(\frac{\sin^2\phi}{2}\left[1 - \frac{RSS_0}{RSS_\ell}\right]\right) d\phi$$

when $n \geq d_0 + 1$ and $n \geq d_\ell + 1$. The latter integral has a finite value for all n according to Casella, Girón, Martínez and Moreno (2009, p.1216) Hence the interval involved in the $B_{\ell 0}^{PE}$ has also a finite value for all n.

If we compare any two models M_{ℓ} versus M_k (both of them different than the reference model) we have that

$$-2\log B_{\ell k}^{PE} \approx n\log \frac{RSS_{\ell}}{RSS_{k}} + (d_{\ell} - d_{k})\log n = BIC_{\ell} - BIC_{k}.$$
 (28)

Therefore the J-PEP approach has the same asymptotic behavior as the BIC-based variable-selection procedure. The following Lemma is a direct result of (28) and of Theorem 4 of Casella et al. (2009).

LEMMA 1: Let $M_{\ell} \in \mathcal{M}$ be a normal regression model of type (2) such that

$$\lim_{n\to\infty} \frac{X_T \left(I_n - X_\ell (X_\ell^T X_\ell)^{-1} X_\ell^T\right) X_T}{n} \text{ is a positive semidefinite matrix,}$$

with X_T being the design matrix of the true data generating regression model $M_T \neq M_j$. Then, the variable selection procedure based on J-PEP Bayes factor is consistent since $BF_{jT}^{J-PEP} \to 0$ as $n \to \infty$.

4 Discussion

Under the *power-expected-posterior priors* (PEP) approach, ideas from the power-prior and unit-information-prior methodologies are combined. As a result the resulting priors are minimally-informative and additionally the effect of training samples that is a big issue on the expected-posterior prior approach is diminishing. When using the independence Jeffreys (or reference) prior as a baseline prior for normal linear models we prove that PEP approach has the same asymptotic behavior as the BIC-based variable-selection procedure. Therefore under very mild conditions on the design matrix is a consistent variable selection technique.
