# Local Existence of Strong Solutions to the 3D Zakharov-Kuznestov Equation in a Bounded Domain

#### Abstract

We consider here the local existence of strong solutions for the Zakharov-Kuznestov (ZK) equation posed in a limited domain  $\mathcal{M} = (0,1)_x \times (-\pi/2, \pi/2)^d$ ,  $d = 1,2$ . We prove that in space dimensions 2 and 3, there exists a strong solution on a short time interval, whose length only depends on the given data. We use the parabolic regularization of the ZK equation as in [\[STW12\]](#page-17-0) to derive the global and local bounds independent of  $\epsilon$  for various norms of the solution. In particular, we derive the local bound of the nonlinear term by a singular perturbation argument. Then we can pass to the limit and hence deduce the local existence of strong solutions.

Keywords: Zakharov-Kuznetsov equation, Korteweg-de Vries equation, Local existence of strong solutions in 3D

## <span id="page-1-0"></span>1 Introduction

The Zakharov-Kuznetsov equation

$$
\frac{\partial u}{\partial t} + \Delta \frac{\partial u}{\partial x} + c \frac{\partial u}{\partial x} + u \frac{\partial u}{\partial x} = f,\tag{1.1}
$$

where  $u = u(x, x^{\perp}, t)$ ,  $x^{\perp} = y$  or  $x^{\perp} = (y, z)$ , describes the propagation of nonlinear ionic-sonic waves in a plasma submitted to a magnetic field directed along the x-axis. Here  $c > 0$  is the sound velocity. It has been derived formally in a long wave, weakly nonlinear regime from the Euler-Poisson system in [\[ZK74\]](#page-18-0) and [\[LS82\]](#page-17-1). A rigorous derivation is provided in [\[LLS13\]](#page-17-2). For more general physical references, see [\[BPS81\]](#page-17-3) and [\[BPS83\]](#page-17-4). When u depends only on x and t, [\(1.1\)](#page-1-1) reduces to the classical Korteweg-de Vries (KdV) equation.

Concerning the initial and boundary value problems of the Korteweg-de Vries equation posed on a bounded interval  $(0, L)$ , we refer the interested readers to e.g. [\[BSZ03\]](#page-17-5), [\[CG01a\]](#page-17-6) and [\[CG01b\]](#page-17-7).

The initial and boundary value problem associated with [\(1.1\)](#page-1-1) has been studied in the half space  $\{(x,y): x > 0\}$  ([\[Fam06\]](#page-17-8)), on a strip like  $\{(x,y): x \in \mathbb{R}, 0 < y < L\}$  ([\[BF13\]](#page-17-9)) or  $\{(x, x^{\perp}) : 0 < x < 1, x^{\perp} \in \mathbb{R}^d, d = 1, 2\}$  ([\[Fam08\]](#page-17-10) and [\[ST10\]](#page-17-11)), and in a rectangle  $\{(x, x^{\perp}) : 0 < x < 1, x^{\perp} \in \mathbb{R}^d, d = 1, 2\}$  $0 < x < 1, x^{\perp} \in (-\pi/2, \pi/2)^d, d = 1, 2$  ([\[STW12\]](#page-17-0)). Specifically in [\[STW12\]](#page-17-0), the authors have established, for arbitrary large initial data, the existence of global weak solutions in space dimensions 2 and 3 ( $d = 1$  and 2 respectively) and a result of uniqueness of such solutions in the two-dimensional case.

As for the existence of strong solutions, the global existence in space dimension 2 has been proven in a half strip  $\{(x, y): x > 0, y \in (0, L)\}\$ in [\[LT13\]](#page-17-12). The existence and exponential decay of regular solutions to the linearized ZK equation in a rectangle  $\{(x, y) : x \in (0, L), y \in (0, B)\}\$ has been studied in [\[DL13\]](#page-17-13).

However, to the best of our knowledge, there has been no result so far for the local existence of strong solutions in  $3D$  in a limited domain. In the present article we prove the short time existence of strong solutions in a 3D rectangular domain as in [\[STW12\]](#page-17-0) .

The article is organized as follows.

Firstly we introduce the basic settings of the equation and the related functional spaces in Section [2.](#page-2-0)

Secondly we introduce the parabolic regularization as in [\[ST10\]](#page-17-11) and [\[STW12\]](#page-17-0). We derive the global bounds on  $u^{\epsilon}$  independent of  $\epsilon$  in Section [3.1.](#page-4-0) Then we derive the local bounds on  $[0, T_*)$ , where  $T_* > 0$  depends only on the data (Sections [3.2](#page-4-1) and [3.3\)](#page-12-0). In particular, we use a singular perturbation argument in the  $x$  direction to deduce the local bounds on the nonlinear term in Section [3.3.](#page-12-0)

Finally we pass to the limit on the regularized equation and obtain the local existence of a strong solution (Section [4\)](#page-15-0).

In the Appendix, we recall from [\[ST10\]](#page-17-11) and [\[STW12\]](#page-17-0) a trace result concerning a singular perturbation problem in the x direction.

#### <span id="page-2-0"></span>2 The ZK equation in a rectangle

We aim to study the ZK equation:

\frac{\partial u}{\partial t} + \Delta \frac{\partial u}{\partial x} + c \frac{\partial u}{\partial x} + u \frac{\partial u}{\partial x} = f,
$$
\n(2.1)

in a rectangle or parallelepiped domain in  $\mathbb{R}^n$  with  $n = 2$  or 3, denoted as  $\mathcal{M} = (0, 1)_x \times$  $(-\pi/2, \pi/2)^d$ , with  $d=1$  or 2,  $\Delta u = u_{xx} + \Delta^{\perp} u$ ,  $\Delta^{\perp} u = u_{yy}$  or  $u_{yy} + u_{zz}$ . In the sequel we will use the notations  $I_x = (0, 1)_x$ ,  $I_y = (-\pi/2, \pi/2)_y$ ,  $I_z = (-\pi/2, \pi/2)_z$ , and  $I_{x^\perp} = I_y$  or  $I_y \times I_z$ . We assume the boundary conditions on  $x = 0, 1$  to be

u(0, x^{\perp}, t) = u(1, x^{\perp}, t) = u_x(1, x^{\perp}, t) = 0,
$$
\n(2.2)

and the initial condition reads:

$$
u(x, x^{\perp}, 0) = u_0(x, x^{\perp}).
$$
\n(2.3)

We also need suitable boundary conditions in the y and z directions. As in  $STW12$ , we will choose either the Dirichlet boundary conditions

$$
u = 0
$$
 at  $y = \pm \frac{\pi}{2}$   $(z = \pm \frac{\pi}{2}),$  (2.4)

or the periodic boundary conditions

<span id="page-2-5"></span>
$$
u\Big|_{y=-\frac{\pi}{2}}^{y=\frac{\pi}{2}} = u_y\Big|_{y=-\frac{\pi}{2}}^{y=\frac{\pi}{2}} = 0 \ \ (u\Big|_{z=-\frac{\pi}{2}}^{z=\frac{\pi}{2}} = u_z\Big|_{z=-\frac{\pi}{2}}^{z=\frac{\pi}{2}} = 0\big). \tag{2.5}
$$

We will study the initial and boundary value problem  $(2.1)-(2.3)$  $(2.1)-(2.3)$  supplemented with the boundary condition [\(2.4\)](#page-2-3), that is, in the Dirichlet case, and we will make some remarks on the extension to the periodic boundary condition case.

We will denote by  $|\cdot|$  and  $(\cdot, \cdot)$  the norm and the inner product of  $L^2(\mathcal{M})$ .

We use the following functional space in the sequel:

$$
Au := \Delta u_x + cu_x, \qquad \forall \ u \in D(A),
$$

where  $D(A) = \{u \in L^2(\mathcal{M}) : A u \in L^2(\mathcal{M}), u = 0 \text{ on } \partial \mathcal{M}, u_x(1, x^{\perp}, t) = 0\}.$  Note that the trace theorem proven in [\[STW12\]](#page-17-0) shows that if  $u \in L^2(\mathcal{M})$  and  $Au \in L^2(\mathcal{M})$  then the traces of u on  $\partial \mathcal{M}$ , and of  $u_x$  at  $x = 1$  make sense.

We also consider the space

$$
\Xi = \{ u \in H^2(\mathcal{M}) \cap H_0^1(\mathcal{M}), \ u_x \big|_{x=1} = 0 \}, \tag{2.6}
$$

and endow this space with the scalar product and norm  $[\cdot, \cdot]_2$  and  $[\cdot]_2$ ,

$$
[u, v]_2 = (u_{xx}, v_{xx}) + (u_{yy}, v_{yy}) + (u_{zz}, v_{zz}),
$$
  

$$
[u]_2^2 = |u_{xx}|^2 + |u_{yy}|^2 + |u_{zz}|^2,
$$
 (2.7)

which make it a Hilbert space, thanks to the Dirichlet boundary condition and the Poincaré inequality and elliptic boundary regularity (see [\[ST10\]](#page-17-11) and [\[STW12\]](#page-17-0)). Furthermore by a result proven in [\[STW12\]](#page-17-0), we know that  $D(A) \subset H^2(\mathcal{M}) \cap H_0^1(\mathcal{M})$ , and hence

D(A) \subset \Xi. \tag{2.8}
$$

#### <span id="page-3-0"></span>3 Parabolic regularization

For the sake of simplicity we will only treat the more complicated case when  $d = 2$ ; the case when  $d = 1$  is easier. To begin with, we recall the parabolic regularization introduced in [\[ST10\]](#page-17-11) and [\[STW12\]](#page-17-0), that is, for  $\epsilon > 0$  "small", we consider the parabolic equation,

$$
\begin{cases}\n\frac{\partial u^{\epsilon}}{\partial t} + \Delta \frac{\partial u^{\epsilon}}{\partial x} + c \frac{\partial u^{\epsilon}}{\partial x} + u^{\epsilon} \frac{\partial u^{\epsilon}}{\partial x} + \epsilon L u^{\epsilon} = f, \\
u^{\epsilon}(0) = u_0,\n\end{cases} \tag{3.1}
$$

,

where

$$
Lu^{\epsilon} := \frac{\partial^4 u^{\epsilon}}{\partial x^4} + \frac{\partial^4 u^{\epsilon}}{\partial y^4} + \frac{\partial^4 u^{\epsilon}}{\partial z^4}
$$

supplemented with the boundary conditions  $(2.2)$ ,  $(2.4)$  and the additional boundary conditions

u_{yy}^{\epsilon}|_{y=\pm\frac{\pi}{2}} = u_{zz}^{\epsilon}|_{z=\pm\frac{\pi}{2}} = 0,
$$
\n(3.2)

u_{xx}^{\epsilon}|_{x=0} = 0.\t\t(3.3)
$$

Note that since  $u_{yy}^{\epsilon} = u_{zz}^{\epsilon} = 0$  at  $x = 0$ , [\(3.3\)](#page-3-1) is equivalent to

$$
\Delta u^{\epsilon}\big|_{x=0} = 0.
$$

It is a classical result (see e.g. [\[Lio69\]](#page-17-14), [\[LSU68\]](#page-17-15) or also [\[STW12\]](#page-17-0)) that there exists a unique solution to the parabolic problem which is sufficiently regular for all the subsequent calculations to be valid; in particular,

$$
u^{\epsilon} \in L^{2}(0, T; H^{4}(\mathcal{M})) \cap C^{1}([0, T]; \Xi). \tag{3.4}
$$

# <span id="page-4-0"></span>3.1 Global bounds independent of  $\epsilon$  for  $u^{\epsilon}$

Firstly, we prove the following global bounds:

<span id="page-4-2"></span>Lemma 3.1. We assume that

$$
u_0 \in L^2(\mathcal{M}),\tag{3.5}
$$

f \in L^2(0, T; L^2(\mathcal{M})), \tag{3.6}
$$

then, for every  $T > 0$  the following estimates independent of  $\epsilon$  hold:

$$
\begin{cases}\n u^{\epsilon} \text{ is bounded in } L^{\infty}(0,T; L^{2}(\mathcal{M})), \\
 u^{\epsilon} \text{ is bounded in } L^{2}(0,T; H_{0}^{1}(\mathcal{M})), \\
 u^{\epsilon}_{x}(0,\cdot,\cdot) \text{ is bounded in } L^{2}(0,T; L^{2}(I_{x^{\perp}})).\n\end{cases} \tag{3.7}
$$

**Proof.** As in [\[STW12\]](#page-17-0), we multiply  $(3.1)$  with  $u^{\epsilon}$  and  $xu^{\epsilon}$ , integrate over M and integrate by parts.

# <span id="page-4-1"></span>3.2 Local bounds independent of  $\epsilon$  for  $u^{\epsilon}$

We first introduce a useful result:

<span id="page-4-7"></span>Lemma 3.2. Under the same assumptions as in Lemma [3.1,](#page-4-2) if we further suppose that

$$
f \in L^{\infty}(0, T; L^{2}(\mathcal{M})), \tag{3.8}
$$

then we have

<span id="page-4-6"></span>
$$
|u_x^{\epsilon}(t)|^2 \le |u_t^{\epsilon}(t)|^2 + \kappa, \qquad 0 \le t \le T,
$$
\n(3.9)

where  $\kappa$  is a constant depending only on  $|u_0|, |f|_{L^{\infty}(0,T;L^2(\mathcal{M}))}$  and T.

**Proof.** We rewrite  $(3.1)<sub>1</sub>$  as

<span id="page-4-3"></span>
$$
\Delta \frac{\partial u^{\epsilon}}{\partial x} + c \frac{\partial u^{\epsilon}}{\partial x} + u^{\epsilon} \frac{\partial u^{\epsilon}}{\partial x} + \epsilon L u^{\epsilon} = - \frac{\partial u^{\epsilon}}{\partial t} + f. \tag{3.10}
$$

We multiply  $(3.10)$  by  $(1+x)u^{\epsilon}$ , integrate over M, integrate by parts, and follow the same calculations as in [\[STW12\]](#page-17-0); we find when  $\epsilon \leq \frac{1}{4}$  $\frac{1}{4}$ ,

$$
|u_{x}^{\epsilon}|^{2} \leq -\int_{\mathcal{M}} u_{t}^{\epsilon} (1+x) u^{\epsilon} d\mathcal{M} + |f|^{2} + |(1+x)u^{\epsilon}|^{2} + c|u^{\epsilon}|^{2} + c'|u^{\epsilon}|^{6}
$$
  

$$
\leq |u_{t}^{\epsilon}|^{2} + |f|^{2} + c'|u^{\epsilon}|^{2} + c'|u^{\epsilon}|^{6}, \tag{3.11}
$$

Here and below c' indicates an absolute constant which may be different at each occurrence. Hence if we call  $\nu$  a bound of  $|u^{\epsilon}|_{L^{\infty}(0,T;L^{2}(\mathcal{M}))}$  as in  $(3.7)_1$ , we can set

$$
\kappa = |f|_{L^{\infty}(0,T;L^{2}(\mathcal{M}))}^{2} + c'\nu^{2} + c'\nu^{6} + |u_{0x}|^{2};
$$
\n(3.12)

 $\Box$ 

and by  $(3.8)$  we obtain  $(3.9)$ . Thus we have completed the proof of Lemma [3.2.](#page-4-7)

Now we are ready to prove the following result giving the local bounds on  $u^{\epsilon}$  independent of ǫ:

<span id="page-5-12"></span>
$$
\nabla^{\perp} u_0, u_{0yy}, u_{0zz} \in L^2(\mathcal{M}), \tag{3.17}
$$

then there exists  $T_* = \min(T, T_1)$ ,

$$
T_1 = \frac{c_3}{\mu^4},\tag{3.18}
$$

 $\mu = \mu(\kappa, |f_t|_{L^{\infty}(0,T;L^2(\mathcal{M}))}, |Lu_0|, |\Delta u_{0x} + u_0u_{0x} + cu_{0x} - f(0)|),$ 

such that for every t,  $0 \le t \le T_*$ ,

|u_t^{\epsilon}(t)| \lesssim \mu,\tag{3.19}
$$

\int_0^{T_*} |\nabla u_t^\epsilon(s)|^2 ds \lesssim \mu,

$$
|\nabla u^{\epsilon}(t)| \le C(\mu),\tag{3.21}
$$

$$
\int_0^{T_*} |\nabla u_y^{\epsilon}(s)|^2 ds \le C(\mu), \quad \int_0^{T_*} |\nabla u_z^{\epsilon}(s)|^2 ds \le C(\mu), \tag{3.22}

|u_{yy}^{\epsilon}(t)| \le C(\mu), \qquad |u_{zz}^{\epsilon}(t)| \le C(\mu), \tag{3.23}

where  $\leq$  means  $\leq$  up to a multiplicative constant independent of  $\epsilon$ , the constant  $c_3$  depends only on the data, and the constant  $C(\mu)$  depends only on  $\mu$  and the data and may be different at each occurrence.

**Proof.** We differentiate [\(3.1\)](#page-3-2) in t, write  $u_t^{\epsilon} = v^{\epsilon}$  and we find:

\begin{cases}\n\frac{\partial v^{\epsilon}}{\partial t} + \Delta \frac{\partial v^{\epsilon}}{\partial x} + c \frac{\partial v^{\epsilon}}{\partial x} + u^{\epsilon} \frac{\partial v^{\epsilon}}{\partial x} + v^{\epsilon} \frac{\partial u^{\epsilon}}{\partial x} + \epsilon L v^{\epsilon} = f_t, \\
v^{\epsilon}(0) = u^{\epsilon}_{t0} = -\epsilon L u_0 - \Delta u_{0x} - u_0 u_{0x} - cu_{0x} + f(0).\n\end{cases} (3.26)
$$

Thus when  $\epsilon \leq 1$ ,

$$
|u_{t0}^{\epsilon}| \le |Lu_0| + |\Delta u_{0x} + u_0 u_{0x} + cu_{0x} - f(0)|. \tag{3.27}
$$

From  $(3.15)$  and  $(3.16)$ , we obtain

Multiplying [\(3.26\)](#page-5-2) by  $(1+x)v^{\epsilon}$ , integrating over M and integrating by parts, dropping  $\epsilon$  for the moment we find

$$
\begin{split}\n\bullet \int_{\mathcal{M}} \frac{\partial v}{\partial t} (1+x)v \, d\mathcal{M} &= \frac{1}{2} \frac{d}{dt} |\sqrt{1+x} \, v|^2, \\
\bullet \int_{\mathcal{M}} \Delta \frac{\partial v}{\partial x} \, v \, d\mathcal{M} &= \frac{1}{2} \int_{I_{x^\perp}} (v_x|_{x=0})^2 \, dx^\perp, \\
\bullet \int_{\mathcal{M}} \Delta \frac{\partial v}{\partial x} \, xv \, d\mathcal{M} &= \frac{3}{2} |v_x|^2 + \frac{1}{2} |\nabla^\perp v|^2, \\
\bullet \int_{\mathcal{M}} cv_x (1+x)v \, d\mathcal{M} &= -\frac{c}{2} \int_{\mathcal{M}} v^2 \, d\mathcal{M}, \\
\bullet \int_{\mathcal{M}} uv_x (1+x)v \, d\mathcal{M} &= -\frac{1}{2} \int_{\mathcal{M}} (1+x) u_x v^2 \, d\mathcal{M} - \frac{1}{2} \int_{\mathcal{M}} uv^2 \, d\mathcal{M}, \\
\bullet \int_{\mathcal{M}} vu_x (1+x)v \, d\mathcal{M} &= \int_{\mathcal{M}} (1+x) u_x v^2 \, d\mathcal{M}, \\
\bullet \int_{\mathcal{M}} f_t (1+x)v \, d\mathcal{M} & \leq \frac{1}{2} |f_t|^2 + \frac{1}{2} |(1+x)v|^2 \leq \frac{1}{2} |f_t|^2 + |v|^2, \\
\bullet \epsilon \int_{\mathcal{M}} \frac{\partial^4 v}{\partial x^4} (1+x)v \, dx \, dx^\perp &= \epsilon |\sqrt{1+x} \, v_{xx}|^2 - \epsilon \int_{I_{x^\perp}} (v_x|_{x=0})^2 \, dx^\perp, \\
\bullet \epsilon \int_{\mathcal{M}} (\frac{\partial^4 v}{\partial y^4} + \frac{\partial^4 v}{\partial z^4}) (1+x)v \, d\mathcal{M} &= \epsilon \left( |\sqrt{1+x} \, v_{yy}|^2 + |\sqrt{1+x} \, v_{zz}|^2 \right). \n\end{split}
$$

Hence we arrive, when  $\epsilon \leq \frac{1}{4}$  $\frac{1}{4}$ , at

\frac{d}{dt} |\sqrt{1+x} u_t^{\epsilon}|^2 + |\nabla u_t^{\epsilon}|^2 + \frac{1}{4} |u_{tx}^{\epsilon}|_{x=0}|_{L^2(I_{x}\perp)}^2 \n+ 2\epsilon \left( |\sqrt{1+x} u_{txx}^{\epsilon}|^2 + |\sqrt{1+x} u_{tyy}^{\epsilon}|^2 + |\sqrt{1+x} u_{tzz}^{\epsilon}|^2 \right) \n\leq \left| \int_{\mathcal{M}} \left( (1+x) u_x^{\epsilon} - u^{\epsilon} \right) (u_t^{\epsilon})^2 d\mathcal{M} \right| + (c+2) |u_t^{\epsilon}|^2 + |f_t|^2.
$$
\n(3.29)

For the first term on the right-hand-side of [\(3.29\)](#page-6-0), we have

In particular, setting  $\eta^{\epsilon}(t) = c'(\mu^4 + |u^{\epsilon}|^4 + C(\mu)|\nabla u_y^{\epsilon}|^{3/2} + C(\mu)|u_{yy}^{\epsilon}| + c + 1)$ , from [\(3.53\)](#page-11-5) we infer that

$$
\frac{d}{dt} |\sqrt{1+x} u_{yy}^{\epsilon}|^2 \leq \eta^{\epsilon}(t) |\sqrt{1+x} u_{yy}^{\epsilon}|^2 + C(\mu) |\nabla u_y^{\epsilon}|^{3/2} + C(\mu) + |f_{yy}|^2, \quad 0 \leq t \leq T_*.
$$
 (3.54)

Since  $|\nabla u_y^{\epsilon}|^{3/2} \leq |\nabla u_y^{\epsilon}|^2 + c'$ , along with  $(3.41)$  we deduce

$$
\int_0^{T_*} \eta^{\epsilon}(s) ds \le C(\mu).
$$

We can then close the Gronwall inequality on the time interval  $(0, T_*)$  in  $(3.53)$ , and obtain

$$
|\sqrt{1+x} u_{yy}^{\epsilon}(t)| \le C(\mu, |u_{0yy}|, |f_{yy}|_{L^2(0,T;L^2(\mathcal{M})))}, \quad 0 \le t \le T_*,
$$

which implies

$$
|u_{yy}^{\epsilon}(t)| \le C(\mu), \quad 0 \le t \le T_*.
$$
\n(3.55)

By  $(3.55)$  and  $(3.44)$  we obtain

$$
\int_0^{T_*} |\nabla u_{yy}^{\epsilon}(s)|^2 ds \le C(\mu),\tag{3.56}
$$

$$
\epsilon \int_0^{T_*} [u_{yy}^{\epsilon}]_2^2 ds \le C(\mu), \quad 0 \le t \le T_*.
$$
 (3.57)

Similarly we can obtain the same kind of estimates for  $u_{zz}^{\epsilon}$ ,  $\nabla u_{zz}^{\epsilon}$  and  $\epsilon [u_{zz}^{\epsilon}]_2^2$ .

Combining all the previous local bounds, we obtain  $(3.19)-(3.25)$  $(3.19)-(3.25)$ . Hence we have completed the proof of Proposition [3.1.](#page-5-8)  $\Box$ 

#### <span id="page-12-0"></span>3.3 A singular perturbation argument

We are now ready to show the local estimates for  $u_{xx}^{\epsilon}$  and  $u^{\epsilon} u_x^{\epsilon}$  by singular perturbation.

<span id="page-12-4"></span>Proposition 3.2. Under the same assumptions as in Proposition [3.1,](#page-5-8) we have

$$

u^{\epsilon}u_{x}^{\epsilon} \text{ is bounded independently of } \epsilon \text{ in } L^{2}(0,T_{*};L^{2}(\mathcal{M})).
$$
\n(3.59)

<span id="page-12-5"></span>**Remark 3.1.** Note that by  $(3.58)$  and  $(3.23)$  we deduce that

u^{\epsilon} \text{ is bounded independently of } \epsilon \text{ in } L^{2}(0, T_{*}, \Xi). \tag{3.60}
$$

Remark 3.2. We know that

$$
\int_{\mathcal{M}} (u^{\epsilon} u_x^{\epsilon})^{3/2} d\mathcal{M} \le \left( \int_{\mathcal{M}} (u^{\epsilon})^6 d\mathcal{M} \right)^{1/4} \left( \int_{\mathcal{M}} (u_x^{\epsilon})^2 d\mathcal{M} \right)^{3/4}
$$
  
\n
$$
= |u^{\epsilon}|_{L^6(\mathcal{M})}^{3/2} |u_x^{\epsilon}|^{3/2}
$$
  
\n
$$
\le (by H^1(\mathcal{M}) \subset L^6(\mathcal{M}) \text{ in } 3D)
$$
  
\n
$$
\lesssim |\nabla u^{\epsilon}|^3.
$$

Hence

ess sup 
$$
|u^{\epsilon}u_{x}^{\epsilon}(t)|_{L^{3/2}(\mathcal{M})}
$$
  $\lesssim$  ess sup  $|\nabla u^{\epsilon}(t)|^{2} \lesssim (by (3.21)) \lesssim C(\mu)^{2}$ ,  
 $t \in (0,T_*)$ 

which implies that

$$
u^{\epsilon}u_{x}^{\epsilon}
$$
 is bounded independently of  $\epsilon$  in  $L^{\infty}(0, T_{*}; L^{3/2}(\mathcal{M}))$ ,  
and hence in  $L^{3/2}(I_{x}; L^{3/2}((0, T_{*}) \times I_{x^{\perp}}))$ .

Thus we can apply Lemma [5.1](#page-16-1) in the Appendix with  $p = 3/2$  and  $Y = L^{3/2}((0, T_*) \times I_{x^{\perp}})$ , and obtain  $\frac{1}{2}$ 

$$
u_{xx}^{\epsilon} \text{ is bounded independently of } \epsilon \text{ in } L^{\infty}(I_x; L^{3/2}((0,T_*) \times I_{x^{\perp}})).
$$
 (3.61)

However, to obtain more useful estimates as in  $(3.58)$  and  $(3.59)$ , we need to use the following proof which provides a stronger result.

**Proof of Proposition [3.2.](#page-12-4)** We rewrite the regularized equation  $(3.1)$  as follows:

where  $g^{\epsilon} := -u^{\epsilon}_t - \Delta^{\perp} u^{\epsilon}_x - cu^{\epsilon}_x - \epsilon u^{\epsilon}_{yyyy} - \epsilon u^{\epsilon}_{zzzz} + f$ . Hence by [\(3.19\)](#page-5-6), [\(3.24\)](#page-5-10) and [\(3.25\)](#page-5-7), we know that each term in  $g^{\epsilon}$  is bounded independently of  $\epsilon$  in  $L^2(0,T_*, L^2(\mathcal{M}))$ , and thus

 is bounded independently of  $\epsilon$  in  $L^{2}(0, T_*, L^{2}(\mathcal{M}))$ . (3.63)

Multiplying  $(3.62)$  by x and integrating in x from 0 to 1, we find

\begin{aligned}\n\bullet \int_0^1 x u_{xxx} \, dx &= -\int_0^1 u_{xx} \, dx + u_{xx} x \big|_{x=0}^{x=1} = u_x \big|_{x=0} + u_{xx} \big|_{x=1}, \\
\bullet \int_0^1 x u u_x \, dx &= \int_0^1 \frac{\partial}{\partial x} \left( \frac{u^2}{2} \right) dx = -\frac{1}{2} \int_0^1 u^2 \, dx, \\
\bullet \epsilon \int_0^1 x u_{xxxx} \, dx &= -\epsilon \int_0^1 u_{xxx} \, dx + \epsilon u_{xxx} x \big|_{x=0}^{x=1} = -\epsilon u_{xx} \big|_{x=1} + \epsilon u_{xxx} \big|_{x=1}.\n\end{aligned}
$$

Hence

<span id="page-13-1"></span>
$$
u_x^{\epsilon}|_{x=0} + u_{xx}^{\epsilon}|_{x=1} - \frac{1}{2} \int_0^1 (u^{\epsilon})^2 dx - \epsilon u_{xx}^{\epsilon}|_{x=1} + \epsilon u_{xxx}^{\epsilon}|_{x=1} = \int_0^1 g^{\epsilon} x dx.
$$
 (3.64)

Integrating  $(3.62)$  in x from  $\tilde{x}$  to 1, we obtain

$$
\begin{aligned}\n\bullet \int_{\tilde{x}}^1 u_{xxx} \, dx &= u_{xx}\big|_{x=1} - u_{xx}, \\
\bullet \int_{\tilde{x}}^1 u u_x \, dx &= -\frac{1}{2}u^2, \\
\bullet \epsilon \int_{\tilde{x}}^1 u_{xxxx} \, dx &= \epsilon u_{xxx}\big|_{x=1} - \epsilon u_{xxx}.\n\end{aligned}
$$

Hence

$$
u_{xx}^{\epsilon}|_{x=1} - u_{xx}^{\epsilon} - \frac{1}{2}(u^{\epsilon})^2 + \epsilon u_{xxx}^{\epsilon}|_{x=1} - \epsilon u_{xxx}^{\epsilon} = \int_{\tilde{x}}^{1} g^{\epsilon} dx.
$$
 (3.65)

Then [\(3.64\)](#page-13-1) and [\(3.65\)](#page-14-0) imply

$$
u_x^{\epsilon}|_{x=0} - \frac{1}{2} \int_0^1 (u^{\epsilon})^2 dx - \epsilon u_{xx}^{\epsilon}|_{x=1} + u_{xx}^{\epsilon} + \frac{1}{2} (u^{\epsilon})^2 + \epsilon u_{xxx}^{\epsilon} = \int_0^1 g^{\epsilon} x dx - \int_{\tilde{x}}^1 g^{\epsilon} dx,
$$

which we rewrite as

<span id="page-14-3"></span>
$$
u_{xx}^{\epsilon} + \epsilon u_{xxx}^{\epsilon} = \epsilon u_{xx}^{\epsilon}|_{x=1} + h^{\epsilon},\tag{3.66}
$$

where

<span id="page-14-1"></span>
$$
h^{\epsilon} = -u^{\epsilon}_{x}|_{x=0} + \frac{1}{2} \int_{0}^{1} (u^{\epsilon})^{2} dx - \frac{1}{2} (u^{\epsilon})^{2} + \int_{0}^{1} g^{\epsilon} x dx - \int_{\tilde{x}}^{1} g^{\epsilon} dx.
$$
 (3.67)

Now we estimate the term  $(u^{\epsilon})^2$  in  $(3.67)$ . Since

$$
|(u^{\epsilon})^2|^2 \le |u^{\epsilon}|^4_{L^4(\mathcal{M})} \lesssim \text{(by } H^{3/4}(\mathcal{M}) \subset L^4(\mathcal{M}) \text{ in } 3D) \lesssim |\nabla u^{\epsilon}|^3 |u^{\epsilon}|,
$$

we have

$$
\int_0^{T_*} |(u^{\epsilon})^2|^2 ds \lesssim \int_0^{T_*} |\nabla u^{\epsilon}|^3 |u^{\epsilon}| ds \le (\text{by (3.21) and the Poincaré inequality}) \lesssim C(\mu)^4 T_*.
$$
\n(3.68)

Thus

<span id="page-14-2"></span>
$$
(u^{\epsilon})^2
$$
 is bounded independently of  $\epsilon$  in  $L^2(0, T_*, L^2(\mathcal{M}))$ . (3.69)

Applying  $(3.7)_4$ ,  $(3.63)$  and  $(3.69)$  to  $(3.67)$  we find

h^{\epsilon} \text{ is bounded independently of } \epsilon \text{ in } L^{2}(0, T_{*}, L^{2}(\mathcal{M})).
$$
\n(3.70)

Multiplying [\(3.66\)](#page-14-3) by  $u_{xx}^{\epsilon}$ , integrating in x from 0 to 1, we obtain

$$
\epsilon \int_0^1 u_{xxx} u_{xx} dx = \frac{\epsilon}{2} u_{xx}^2 \big|_{x=1},
$$
  
\n•  $\epsilon \int_0^1 u_{xx} \big|_{x=1} u_{xx} dx = \epsilon u_{xx} \big|_{x=1} \int_0^1 u_{xx} dx = -\epsilon u_{xx} \big|_{x=1} u_x \big|_{x=0};$ 

hence we arrive at

$$
\int_0^1 (u_{xx}^\epsilon)^2 dx + \frac{\epsilon}{2} (u_{xx}^\epsilon)^2 \big|_{x=1} = -\epsilon u_{xx}^\epsilon \big|_{x=1} u_x^\epsilon \big|_{x=0} + \int_0^1 u_{xx}^\epsilon h^\epsilon dx,
$$
  

$$
\leq \frac{\epsilon}{4} (u_{xx}^\epsilon \big|_{x=1})^2 + c' \epsilon (u_x^\epsilon \big|_{x=0})^2 + \frac{1}{2} |u_{xx}^\epsilon|_{L^2(I_x)}^2 + \frac{1}{2} |h^\epsilon|_{L^2(I_x)}^2.
$$

Thus

<span id="page-14-4"></span>
$$
\frac{1}{2} \int_0^1 (u_{xx}^\epsilon)^2 dx + \frac{\epsilon}{4} (u_{xx}^\epsilon|_{x=1})^2 \le c' \epsilon (u_x^\epsilon|_{x=0})^2 + \frac{1}{2} |h^\epsilon|_{L^2(I_x)}^2.
$$
\n(3.71)

We integrate both sides of [\(3.71\)](#page-14-4) in  $I_{x^{\perp}}$  and then in time from 0 to  $T_*$ ; by [\(3.70\)](#page-14-5) and [\(3.7\)](#page-4-4)<sub>4</sub> we obtain  $(3.58)$ . As in Remark [3.1,](#page-12-5) we thus have  $(3.60)$ .

Now since

$$
|u^{\epsilon}u_{x}^{\epsilon}|^{2} \leq |u^{\epsilon}|_{L^{4}(\mathcal{M})}^{2} |u_{x}^{\epsilon}|_{L^{4}(\mathcal{M})}^{2}
$$
  
\n
$$
\lesssim (\text{by } H^{3/4}(\mathcal{M}) \subset L^{4}(\mathcal{M}) \text{ in } 3D)
$$
  
\n
$$
\lesssim |u^{\epsilon}|^{1/2} |\nabla u^{\epsilon}|^{3/2} |u_{x}^{\epsilon}|^{1/2} |u^{\epsilon}|_{2}^{3/2}
$$
  
\n
$$
\lesssim |u^{\epsilon}|^{2} |\nabla u^{\epsilon}|^{4} + |u^{\epsilon}|_{2}^{2},
$$

hence we obtain

$$
\int_0^{T_*} |u^\epsilon u^\epsilon_x|^2\,ds \lesssim \int_0^{T_*} |u^\epsilon|^2 |\nabla u^\epsilon|^4\,ds + \int_0^{T_*} [u]_2^2\,ds.
$$

This together with  $(3.21)$  and  $(3.60)$  implies  $(3.59)$ .

# <span id="page-15-0"></span>4 Passage to the limit

Using a compactness argument, we can pass to the limit in  $(3.1)$ . Hence we obtain  $(2.1)$ , with a function  $u \in C^1([0,T_*]; L^2(\mathcal{M})) \cap L^2(0,T; H_0^1(\mathcal{M}))$ . Then we rewrite  $(2.1)$  as

u_{xxx} = -u_t - \Delta^{\perp} u_x - cu_x - uu_x - f.
$$
 (4.1)

From  $(3.19)$ ,  $(3.24)$  and  $(3.59)$ , we infer that each term in the right-hand-side of  $(4.1)$  belongs to  $L^2(0,T_*;L^2(\mathcal{M}))$ , and hence

$$
u_{xxx} \in L^2(0, T_*; L^2(\mathcal{M})).
$$
\n(4.2)

Now we are ready to state the main result: the local existence of strong solutions.

**Theorem 4.1.** The assumptions are the same as in Proposition [3.1,](#page-5-8) that is  $(3.5)$ ,  $(3.6)$ ,  $(3.8)$ and  $(3.13)-(3.17)$  $(3.13)-(3.17)$ . We suppose also that the following compatibility conditions hold:

$$
u_0 = 0 \text{ on } \partial \mathcal{M}, \ u_{0x}\big|_{x=1} = 0, \ u_{0yy}\big|_{y=\pm \frac{\pi}{2}} = u_{0zz}\big|_{z=\pm \frac{\pi}{2}} = 0,\tag{4.3}
$$

$$
u_{t0} = 0 \text{ on } \partial \mathcal{M}, \left. \frac{\partial u_{t0}}{\partial x} \right|_{x=1} = 0, \left. \frac{\partial^2 u_{t0}}{\partial y^2} \right|_{y=\pm \frac{\pi}{2}} = \frac{\partial^2 u_{t0}}{\partial z^2} \Big|_{z=\pm \frac{\pi}{2}} = 0, \tag{4.4}
$$

where  $u_{t0} = -\Delta u_{0x} - u_0 u_{0x} - cu_{0x} + f(0)$ . Then there exists a local strong solution to [\(2.1\)](#page-2-1)-[\(2.4\)](#page-2-3) on some time interval  $[0, T_*)$ ,  $T_* > 0$  depending only on the data as in Proposition [3.1,](#page-5-8) such that

$$
\nabla u, u_{yy}, u_{zz}, u_t \in L^{\infty}(0, T_*; L^2(\mathcal{M})),
$$
\n(4.5)

<span id="page-15-2"></span>
$$
u \in L^2(0, T_*; D(A)), \tag{4.6}
$$

<span id="page-15-3"></span>
$$
u \in L^2(0, T_*; \Xi), \tag{4.7}
$$

$$
u \in L^{2}(0, T_{*}; H^{3}(I_{x}; L^{2}(I_{x+})) \cap H^{3}(I_{x+}; L^{2}(I_{x}))), \qquad (4.8)
$$

 $\Box$ 

$$
u_t \in L^2(0, T_*; H^1(\mathcal{M})).
$$
\n(4.9)

Moreover, we have for every  $t \in (0, T_*)$ ,

<span id="page-16-3"></span>
$$
u_{yy}(t)|_{y=\pm\frac{\pi}{2}} = u_{zz}(t)|_{z=\pm\frac{\pi}{2}} = 0.
$$
\n(4.10)

Remark 4.1. We have proven that all the spatial derivatives of the third order of u are in  $L^2(0,T_*;L^2(\mathcal{M}))$ , except for  $u_{xxy}$  and  $u_{xxx}$ .

**Proof.** We rewrite  $(2.1)$  as

<span id="page-16-2"></span>
$$
Au = -u_t - uu_x - f; \t\t(4.11)
$$

□

from [\(3.19\)](#page-5-6) and [\(3.59\)](#page-12-3) we know that each term on the right-hand side of [\(4.11\)](#page-16-2) belongs to  $L^2(0,T_*;L^2(\mathcal{M}))$ . Hence Au belongs to the same space. We also know that  $u_x(1,x^{\perp},t)=0$ ,  $t \in [0, T]$  using the same argument as in [\[STW12\]](#page-17-0). Hence we obtain [\(4.6\)](#page-15-2). Now by [\(2.8\)](#page-3-3) and  $(4.6)$ , we deduce  $(4.7)$ .

By [\(3.22\)](#page-5-13), we know that  $u_{yyy}$ ,  $u_{zzz}$  both belong to  $L^2(0,T_*;L^2(\mathcal{M}))$ . Hence we can apply the trace theorem and pass to the limit on the boundary conditions in [\(3.2\)](#page-3-4) to obtain [\(4.10\)](#page-16-3).

The other results can be deduced directly from  $(3.19)-(3.24)$  $(3.19)-(3.24)$  and  $(4.2)$ .

**Remark 4.2.** As for the periodic case, that is,  $(2.1)$  and the boundary and initial conditions  $(2.2)$ ,  $(2.3)$  and  $(2.5)$ , the results are exactly the same as in the Dirichlet case discussed above. The reasoning is totally the same and therefore we skip it.

## <span id="page-16-0"></span>5 Appendix: a trace result

We recall a trace result from [\[STW12\]](#page-17-0), which is used in the article.

<span id="page-16-1"></span>**Lemma 5.1.** Let Y be a (not necessarily reflexive) Banach space and let  $p \geq 1$ . Assume that two sequences of functions  $u^{\epsilon}$ ,  $g^{\epsilon} \in L_x^p(I_x;Y)$  satisfy

$$
\begin{cases}\n u_{xxx}^{\epsilon} + \epsilon u_{xxxx}^{\epsilon} = g^{\epsilon}, \\
 u^{\epsilon}(0) = u^{\epsilon}(1) = u_x^{\epsilon}(1) = u_{xx}^{\epsilon}(0) = 0,\n\end{cases}
$$
\n(5.1)

with  $g^{\epsilon}$  bounded in  $L_x^p(I_x;Y)$  as  $\epsilon \to 0$ . Then  $u_{xx}^{\epsilon}$  (and hence  $u_x^{\epsilon}$ , and  $u^{\epsilon}$ ) is bounded in  $L_x^{\infty}(I_x;Y)$ as  $\epsilon \to 0$ . Furthermore if Y is reflexive, then for any subsequence  $u^{\epsilon} \to u$  converging strongly or weakly in  $L_x^q(I_x; Y)$ ,  $1 < q < \infty$ ,  $u_x^{\epsilon}(1)$  converges to  $u_x(1)$  in Y (weakly at least), and hence  $u_x(1) = 0.$
