Local Existence of Strong Solutions to the 3DZakharov-Kuznestov Equation in a Bounded Domain

Abstract

We consider here the local existence of strong solutions for the Zakharov-Kuznestov (ZK) equation posed in a limited domain $\mathcal{M} = (0,1)_x \times (-\pi/2,\pi/2)^d$, d=1,2. We prove that in space dimensions 2 and 3, there exists a strong solution on a short time interval, whose length only depends on the given data. We use the parabolic regularization of the ZK equation as in [STW12] to derive the global and local bounds independent of ϵ for various norms of the solution. In particular, we derive the local bound of the nonlinear term by a singular perturbation argument. Then we can pass to the limit and hence deduce the local existence of strong solutions.

Keywords: Zakharov-Kuznetsov equation, Korteweg-de Vries equation, Local existence of strong solutions in 3D

1 Introduction

The Zakharov-Kuznetsov equation

$$\frac{\partial u}{\partial t} + \Delta \frac{\partial u}{\partial x} + c \frac{\partial u}{\partial x} + u \frac{\partial u}{\partial x} = f, \tag{1.1}$$

where $u = u(x, x^{\perp}, t)$, $x^{\perp} = y$ or $x^{\perp} = (y, z)$, describes the propagation of nonlinear ionic-sonic waves in a plasma submitted to a magnetic field directed along the x-axis. Here c > 0 is the sound velocity. It has been derived formally in a long wave, weakly nonlinear regime from the Euler-Poisson system in [ZK74] and [LS82]. A rigorous derivation is provided in [LLS13]. For more general physical references, see [BPS81] and [BPS83]. When u depends only on x and t, (1.1) reduces to the classical Korteweg-de Vries (KdV) equation.

Concerning the initial and boundary value problems of the Korteweg-de Vries equation posed on a bounded interval (0, L), we refer the interested readers to e.g. [BSZ03], [CG01a] and [CG01b].

The initial and boundary value problem associated with (1.1) has been studied in the half space $\{(x,y): x>0\}$ ([Fam06]), on a strip like $\{(x,y): x\in\mathbb{R}, 0< y< L\}$ ([BF13]) or $\{(x,x^{\perp}): 0< x<1, x^{\perp}\in\mathbb{R}^d, d=1,2\}$ ([Fam08] and [ST10]), and in a rectangle $\{(x,x^{\perp}): 0< x<1, x^{\perp}\in(-\pi/2,\pi/2)^d, d=1,2\}$ ([STW12]). Specifically in [STW12], the authors have established, for arbitrary large initial data, the existence of global weak solutions in space dimensions 2 and 3 (d=1 and 2 respectively) and a result of uniqueness of such solutions in the two-dimensional case.

As for the existence of strong solutions, the global existence in space dimension 2 has been proven in a half strip $\{(x,y): x>0, y\in(0,L)\}$ in [LT13]. The existence and exponential decay of regular solutions to the linearized ZK equation in a rectangle $\{(x,y): x\in(0,L), y\in(0,B)\}$ has been studied in [DL13].

However, to the best of our knowledge, there has been no result so far for the local existence of strong solutions in 3D in a limited domain. In the present article we prove the short time existence of strong solutions in a 3D rectangular domain as in [STW12].

The article is organized as follows.

Firstly we introduce the basic settings of the equation and the related functional spaces in Section 2.

Secondly we introduce the parabolic regularization as in [ST10] and [STW12]. We derive the global bounds on u^{ϵ} independent of ϵ in Section 3.1. Then we derive the local bounds on $[0, T_*)$, where $T_* > 0$ depends only on the data (Sections 3.2 and 3.3). In particular, we use a singular perturbation argument in the x direction to deduce the local bounds on the nonlinear term in Section 3.3.

Finally we pass to the limit on the regularized equation and obtain the local existence of a strong solution (Section 4).

In the Appendix, we recall from [ST10] and [STW12] a trace result concerning a singular perturbation problem in the x direction.

2 The ZK equation in a rectangle

We aim to study the ZK equation:

$$\frac{\partial u}{\partial t} + \Delta \frac{\partial u}{\partial x} + c \frac{\partial u}{\partial x} + u \frac{\partial u}{\partial x} = f, \tag{2.1}$$

in a rectangle or parallelepiped domain in \mathbb{R}^n with n=2 or 3, denoted as $\mathcal{M}=(0,1)_x\times (-\pi/2,\pi/2)^d$, with d=1 or 2, $\Delta u=u_{xx}+\Delta^\perp u$, $\Delta^\perp u=u_{yy}$ or $u_{yy}+u_{zz}$. In the sequel we will use the notations $I_x=(0,1)_x$, $I_y=(-\pi/2,\pi/2)_y$, $I_z=(-\pi/2,\pi/2)_z$, and $I_{x^\perp}=I_y$ or $I_y\times I_z$. We assume the boundary conditions on x=0,1 to be

$$u(0, x^{\perp}, t) = u(1, x^{\perp}, t) = u_x(1, x^{\perp}, t) = 0,$$
 (2.2)

and the initial condition reads:

$$u(x, x^{\perp}, 0) = u_0(x, x^{\perp}).$$
 (2.3)

We also need suitable boundary conditions in the y and z directions. As in [STW12], we will choose either the Dirichlet boundary conditions

$$u = 0 \text{ at } y = \pm \frac{\pi}{2} \ (z = \pm \frac{\pi}{2}),$$
 (2.4)

or the periodic boundary conditions

$$u\Big|_{y=-\frac{\pi}{2}}^{y=\frac{\pi}{2}} = u_y\Big|_{y=-\frac{\pi}{2}}^{y=\frac{\pi}{2}} = 0 \ (u\Big|_{z=-\frac{\pi}{2}}^{z=\frac{\pi}{2}} = u_z\Big|_{z=-\frac{\pi}{2}}^{z=\frac{\pi}{2}} = 0).$$
 (2.5)

We will study the initial and boundary value problem (2.1)-(2.3) supplemented with the boundary condition (2.4), that is, in the Dirichlet case, and we will make some remarks on the extension to the periodic boundary condition case.

We will denote by $|\cdot|$ and (\cdot,\cdot) the norm and the inner product of $L^2(\mathcal{M})$.

We use the following functional space in the sequel:

$$Au := \Delta u_x + cu_x, \quad \forall \ u \in D(A),$$

where $D(A) = \{u \in L^2(\mathcal{M}) : Au \in L^2(\mathcal{M}), u = 0 \text{ on } \partial \mathcal{M}, u_x(1, x^{\perp}, t) = 0\}$. Note that the trace theorem proven in [STW12] shows that if $u \in L^2(\mathcal{M})$ and $Au \in L^2(\mathcal{M})$ then the traces of u on $\partial \mathcal{M}$, and of u_x at x = 1 make sense.

We also consider the space

$$\Xi = \left\{ u \in H^2(\mathcal{M}) \cap H_0^1(\mathcal{M}), \ u_x \Big|_{x=1} = 0 \right\}, \tag{2.6}$$

and endow this space with the scalar product and norm $[\cdot, \cdot]_2$ and $[\cdot]_2$,

$$[u, v]_2 = (u_{xx}, v_{xx}) + (u_{yy}, v_{yy}) + (u_{zz}, v_{zz}),$$

$$[u]_2^2 = |u_{xx}|^2 + |u_{yy}|^2 + |u_{zz}|^2,$$
 (2.7)

which make it a Hilbert space, thanks to the Dirichlet boundary condition and the Poincaré inequality and elliptic boundary regularity (see [ST10] and [STW12]). Furthermore by a result proven in [STW12], we know that $D(A) \subset H^2(\mathcal{M}) \cap H^1_0(\mathcal{M})$, and hence

$$D(A) \subset \Xi.$$
 (2.8)

3 Parabolic regularization

For the sake of simplicity we will only treat the more complicated case when d=2; the case when d=1 is easier. To begin with, we recall the parabolic regularization introduced in [ST10] and [STW12], that is, for $\epsilon > 0$ "small", we consider the parabolic equation,

$$\begin{cases}
\frac{\partial u^{\epsilon}}{\partial t} + \Delta \frac{\partial u^{\epsilon}}{\partial x} + c \frac{\partial u^{\epsilon}}{\partial x} + u^{\epsilon} \frac{\partial u^{\epsilon}}{\partial x} + \epsilon L u^{\epsilon} = f, \\
u^{\epsilon}(0) = u_{0},
\end{cases} (3.1)$$

where

$$Lu^{\epsilon} := \frac{\partial^4 u^{\epsilon}}{\partial x^4} + \frac{\partial^4 u^{\epsilon}}{\partial y^4} + \frac{\partial^4 u^{\epsilon}}{\partial z^4},$$

supplemented with the boundary conditions (2.2), (2.4) and the additional boundary conditions

$$u_{yy}^{\epsilon}\big|_{y=\pm\frac{\pi}{2}} = u_{zz}^{\epsilon}\big|_{z=\pm\frac{\pi}{2}} = 0, \tag{3.2}$$

$$u_{xx}^{\epsilon}\big|_{x=0} = 0. (3.3)$$

Note that since $u_{yy}^{\epsilon} = u_{zz}^{\epsilon} = 0$ at x = 0, (3.3) is equivalent to

$$\Delta u^{\epsilon}\big|_{r=0} = 0.$$

It is a classical result (see e.g. [Lio69], [LSU68] or also [STW12]) that there exists a unique solution to the parabolic problem which is sufficiently regular for all the subsequent calculations to be valid; in particular,

$$u^{\epsilon} \in L^{2}(0,T;H^{4}(\mathcal{M})) \cap \mathcal{C}^{1}([0,T];\Xi). \tag{3.4}$$

3.1 Global bounds independent of ϵ for u^{ϵ}

Firstly, we prove the following global bounds:

Lemma 3.1. We assume that

$$u_0 \in L^2(\mathcal{M}),\tag{3.5}$$

$$f \in L^2(0, T; L^2(\mathcal{M})),$$
 (3.6)

then, for every T > 0 the following estimates independent of ϵ hold:

$$\begin{cases}
 u^{\epsilon} \text{ is bounded in } L^{\infty}(0,T;L^{2}(\mathcal{M})), \\
 u^{\epsilon} \text{ is bounded in } L^{2}(0,T;H_{0}^{1}(\mathcal{M})), \\
 u_{x}^{\epsilon}(0,\cdot,\cdot) \text{ is bounded in } L^{2}(0,T;L^{2}(I_{x^{\perp}})).
\end{cases} (3.7)$$

Proof. As in [STW12], we multiply (3.1) with u^{ϵ} and xu^{ϵ} , integrate over \mathcal{M} and integrate by parts.

3.2 Local bounds independent of ϵ for u^{ϵ}

We first introduce a useful result:

Lemma 3.2. Under the same assumptions as in Lemma 3.1, if we further suppose that

$$f \in L^{\infty}(0, T; L^2(\mathcal{M})), \tag{3.8}$$

then we have

$$|u_x^{\epsilon}(t)|^2 \le |u_t^{\epsilon}(t)|^2 + \kappa, \qquad 0 \le t \le T, \tag{3.9}$$

where κ is a constant depending only on $|u_0|$, $|f|_{L^{\infty}(0,T;L^2(\mathcal{M}))}$ and T.

Proof. We rewrite $(3.1)_1$ as

$$\Delta \frac{\partial u^{\epsilon}}{\partial x} + c \frac{\partial u^{\epsilon}}{\partial x} + u^{\epsilon} \frac{\partial u^{\epsilon}}{\partial x} + \epsilon L u^{\epsilon} = -\frac{\partial u^{\epsilon}}{\partial t} + f.$$
 (3.10)

We multiply (3.10) by $(1+x)u^{\epsilon}$, integrate over \mathcal{M} , integrate by parts, and follow the same calculations as in [STW12]; we find when $\epsilon \leq \frac{1}{4}$,

$$|u_x^{\epsilon}|^2 \le -\int_{\mathcal{M}} u_t^{\epsilon} (1+x) u^{\epsilon} d\mathcal{M} + |f|^2 + |(1+x)u^{\epsilon}|^2 + c|u^{\epsilon}|^2 + c'|u^{\epsilon}|^6$$

$$\le |u_t^{\epsilon}|^2 + |f|^2 + c'|u^{\epsilon}|^2 + c'|u^{\epsilon}|^6,$$
(3.11)

Here and below c' indicates an absolute constant which may be different at each occurrence. Hence if we call ν a bound of $|u^{\epsilon}|_{L^{\infty}(0,T;L^{2}(\mathcal{M}))}$ as in $(3.7)_{1}$, we can set

$$\kappa = |f|_{L^{\infty}(0,T;L^{2}(\mathcal{M}))}^{2} + c'\nu^{2} + c'\nu^{6} + |u_{0x}|^{2};$$
(3.12)

and by (3.8) we obtain (3.9). Thus we have completed the proof of Lemma 3.2.

Now we are ready to prove the following result giving the local bounds on u^{ϵ} independent of ϵ :

Proposition 3.1. Under the same assumptions as in Lemma 3.2, if we further suppose that

$$f_t \in L^{\infty}(0, T; L^2(\mathcal{M})), \tag{3.13}$$

$$f \in L^2(0,T; L^2(I_x; H^2(I_{r^{\perp}}))),$$
 (3.14)

$$Lu_0 \in L^2(\mathcal{M}), \tag{3.15}$$

$$\Delta u_{0x} + u_0 u_{0x} + c u_{0x} - f(0) \in L^2(\mathcal{M}), \tag{3.16}$$

$$\nabla^{\perp} u_0, u_{0yy}, u_{0zz} \in L^2(\mathcal{M}),$$
 (3.17)

then there exists $T_* = \min(T, T_1)$,

$$T_1 = \frac{c_3}{u^4},\tag{3.18}$$

 $\mu = \mu(\kappa, |f_t|_{L^{\infty}(0,T;L^2(\mathcal{M}))}, |Lu_0|, |\Delta u_{0x} + u_0 u_{0x} + c u_{0x} - f(0)|),$

such that for every t, $0 \le t \le T_*$,

$$|u_t^{\epsilon}(t)| \lesssim \mu,\tag{3.19}$$

$$\int_0^{T_*} |\nabla u_t^{\epsilon}(s)|^2 \, ds \lesssim \mu,\tag{3.20}$$

$$|\nabla u^{\epsilon}(t)| \le C(\mu), \tag{3.21}$$

$$\int_{0}^{T_{*}} |\nabla u_{y}^{\epsilon}(s)|^{2} ds \le C(\mu), \quad \int_{0}^{T_{*}} |\nabla u_{z}^{\epsilon}(s)|^{2} ds \le C(\mu), \tag{3.22}$$

$$|u_{yy}^{\epsilon}(t)| \le C(\mu), \qquad |u_{zz}^{\epsilon}(t)| \le C(\mu), \tag{3.23}$$

$$\int_{0}^{T_{*}} |\nabla u_{yy}^{\epsilon}(s)|^{2} ds \le C(\mu), \quad \int_{0}^{T_{*}} |\nabla u_{zz}^{\epsilon}(s)|^{2} ds \le C(\mu), \tag{3.24}$$

$$\epsilon \int_0^{T_*} [u_{yy}^{\epsilon}]_2^2 ds \le C(\mu), \quad \epsilon \int_0^{T_*} [u_{zz}^{\epsilon}]_2^2 ds \le C(\mu),$$
 (3.25)

where \lesssim means \leq up to a multiplicative constant independent of ϵ , the constant c_3 depends only on the data, and the constant $C(\mu)$ depends only on μ and the data and may be different at each occurrence.

Proof. We differentiate (3.1) in t, write $u_t^{\epsilon} = v^{\epsilon}$ and we find:

$$\begin{cases}
\frac{\partial v^{\epsilon}}{\partial t} + \Delta \frac{\partial v^{\epsilon}}{\partial x} + c \frac{\partial v^{\epsilon}}{\partial x} + u^{\epsilon} \frac{\partial v^{\epsilon}}{\partial x} + v^{\epsilon} \frac{\partial u^{\epsilon}}{\partial x} + \epsilon L v^{\epsilon} = f_{t}, \\
v^{\epsilon}(0) = u_{t0}^{\epsilon} = -\epsilon L u_{0} - \Delta u_{0x} - u_{0} u_{0x} - c u_{0x} + f(0).
\end{cases} (3.26)$$

Thus when $\epsilon \leq 1$,

$$|u_{t0}^{\epsilon}| \le |Lu_0| + |\Delta u_{0x} + u_0 u_{0x} + c u_{0x} - f(0)|. \tag{3.27}$$

From (3.15) and (3.16), we obtain

$$u_{t0}^{\epsilon}$$
 is bounded independently of ϵ in $L^{2}(\mathcal{M})$. (3.28)

Multiplying (3.26) by $(1+x)v^{\epsilon}$, integrating over \mathcal{M} and integrating by parts, dropping ϵ for the moment we find

Hence we arrive, when $\epsilon \leq \frac{1}{4}$, at

$$\frac{d}{dt} |\sqrt{1+x} u_t^{\epsilon}|^2 + |\nabla u_t^{\epsilon}|^2 + \frac{1}{4} |u_{tx}^{\epsilon}|_{x=0}|_{L^2(I_{x^{\perp}})}^2
+ 2\epsilon \left(|\sqrt{1+x} u_{txx}^{\epsilon}|^2 + |\sqrt{1+x} u_{tyy}^{\epsilon}|^2 + |\sqrt{1+x} u_{tzz}^{\epsilon}|^2 \right)
\leq \left| \int_{\mathcal{M}} \left((1+x) u_x^{\epsilon} - u^{\epsilon} \right) (u_t^{\epsilon})^2 d\mathcal{M} \right| + (c+2) |u_t^{\epsilon}|^2 + |f_t|^2.$$
(3.29)

For the first term on the right-hand-side of (3.29), we have

$$\left| \int_{\mathcal{M}} \left((1+x)u_{x}^{\epsilon} - u^{\epsilon} \right) (u_{t}^{\epsilon})^{2} d\mathcal{M} \right| \lesssim \left(\text{with } \sigma^{\epsilon}(t) := |u_{x}^{\epsilon}| + |u^{\epsilon}| \right)$$

$$\lesssim \sigma^{\epsilon}(t) |u_{t}^{\epsilon}|_{L^{4}(\mathcal{M})}^{2}$$

$$\lesssim \left(\text{by } H^{3/4} \subset L^{4} \text{ in } 3D \right)$$

$$\lesssim \sigma^{\epsilon}(t) |u_{t}^{\epsilon}|^{1/2} |\nabla u_{t}^{\epsilon}|^{3/2}$$

$$\leq c'(\sigma^{\epsilon}(t))^{4} |u_{t}^{\epsilon}|^{2} + \frac{1}{8} |\nabla u_{t}^{\epsilon}|^{2}$$

$$\leq \left(\text{by } (3.9) \right)$$

$$\leq c'\left(|u_{t}^{\epsilon}|^{6} + \kappa^{2} |u_{t}^{\epsilon}|^{2} + |u^{\epsilon}|^{4} |u_{t}^{\epsilon}|^{2} \right) + \frac{1}{8} |\nabla u_{t}^{\epsilon}|^{2}.$$

$$(3.30)$$

Applying (3.30) to (3.29), we obtain

$$\frac{d}{dt}|\sqrt{1+x}u_{t}^{\epsilon}|^{2} + \frac{7}{8}|\nabla u_{t}^{\epsilon}|^{2} + \frac{1}{4}|u_{tx}^{\epsilon}|_{x=0}|_{L^{2}(I_{x^{\perp}})}^{2}
+ 2\epsilon\left(|\sqrt{1+x}u_{yxx}^{\epsilon}|^{2} + |\sqrt{1+x}u_{yyy}^{\epsilon}|^{2} + |\sqrt{1+x}u_{yzz}^{\epsilon}|^{2}\right)
\leq c_{1}(|u_{t}^{\epsilon}|^{2} + 1)^{3} + |f_{t}|^{2}
\leq c_{1}(|\sqrt{1+x}u_{t}^{\epsilon}|^{2} + 1)^{3} + |f_{t}|^{2}.$$
(3.31)

where c_1 depends only on κ . Setting $|\sqrt{1+x} u_t^{\epsilon}|^2 + 1 := \mathcal{Y}^{\epsilon}$, (3.31) implies that

$$\frac{d}{dt}\mathcal{Y}^{\epsilon} \le c_2(\mathcal{Y}^{\epsilon})^3,\tag{3.32}$$

with $c_2 := c_1 + |f_t|_{L^{\infty}(0,T;L^2(\mathcal{M}))}^2$. Thus

$$\mathcal{Y}^{\epsilon}(t) \le 2\mu_0^2, \quad 0 \le t \le \frac{3}{8c_2\mu_0^4},$$
 (3.33)

where μ_0 is a bound of $\sqrt{\mathcal{Y}^{\epsilon}(0)}$ independent of ϵ as provided by (3.28). Now (3.33) implies that

$$|u_t^{\epsilon}(t)| \lesssim \mu_0, \quad 0 \le t \le \frac{3}{8c_2\mu_0^4}.$$
 (3.34)

Then by (3.34) and (3.9) we deduce that

$$|u_x^{\epsilon}(t)| \lesssim \mu, \quad 0 \le t \le T_*.$$
 (3.35)

with $\mu := \mu_0 + \sqrt{\kappa}$, and $T_* = \min(T, T_1)$,

$$T_1 = \frac{c_3}{\mu^4} \le \frac{3}{8c_2\mu_0^4}. (3.36)$$

By (3.34), (3.36) and (3.31) we obtain (3.20).

We multiply (3.1) by $(1+x)u_{yy}^{\epsilon}$, integrate over \mathcal{M} and integrate by parts, dropping ϵ for the moment, we find

$$\begin{split} & \bullet \int_{\mathcal{M}} u_t \, (1+x) u_{yy} \, d\mathcal{M} = -\frac{1}{2} \frac{d}{dt} |\sqrt{1+x} \, u_y|^2, \\ & \bullet \int_{\mathcal{M}} u_{xxx} \, (1+x) u_{yy} \, d\mathcal{M} = -\frac{3}{2} |u_{xy}^2| - \frac{1}{2} \left| u_{xy}^2 \right|_{x=0} \big|_{L^2(I_y)}, \\ & \bullet \int_{\mathcal{M}} u_{xyy} \, (1+x) u_{yy} \, d\mathcal{M} = -\frac{1}{2} |u_{yy}^2|, \\ & \bullet \int_{\mathcal{M}} u_{xzz} \, (1+x) u_{yy} \, d\mathcal{M} = -\frac{1}{2} |u_{zy}^2|, \end{split}$$

+ 2 \left| \int_{\mathcal{M}} u_{y}^{2} (1+x) u_{xyy} d\mathcal{M} \right| + (c+1) |u_{yy}^{\epsilon}|^{2} + |f_{yy}|^{2} \\
:= I_{1}^{\epsilon} + I_{2}^{\epsilon} + I_{3}^{\epsilon} + (c+1) |u_{yy}^{\epsilon}|^{2} + |f_{yy}|^{2}. \tag{3.44}$$

For I_1^{ϵ} , by the similar calculations in (3.38) we deduce

$$\leq (\text{by }(3.40))$$

$$\leq C(\mu)|\nabla u_{y}^{\epsilon}|^{3/2}|u_{yy}^{\epsilon}|$$

$$\leq C(\mu)|\nabla u_{y}^{\epsilon}|^{3/2}|u_{yy}^{\epsilon}|^{3/2}, \quad 0 \leq t \leq T_{*}.$$

3.3 A singular perturbation argument

We are now ready to show the local estimates for u_{xx}^{ϵ} and $u^{\epsilon}u_{x}^{\epsilon}$ by singular perturbation.

$$u_x^{\epsilon}\big|_{x=0} - \frac{1}{2} \int_0^1 (u^{\epsilon})^2 dx - \epsilon u_{xx}^{\epsilon}\big|_{x=1} + u_{xx}^{\epsilon} + \frac{1}{2} (u^{\epsilon})^2 + \epsilon u_{xxx}^{\epsilon} = \int_0^1 g^{\epsilon} x dx - \int_{\tilde{x}}^1 g^{\epsilon} dx,$$

which we rewrite as

$$u_{xx}^{\epsilon} + \epsilon u_{xxx}^{\epsilon} = \epsilon u_{xx}^{\epsilon} \Big|_{x=1} + h^{\epsilon}, \tag{3.66}$$

where

$$h^{\epsilon} = -u_x^{\epsilon}\big|_{x=0} + \frac{1}{2} \int_0^1 (u^{\epsilon})^2 dx - \frac{1}{2} (u^{\epsilon})^2 + \int_0^1 g^{\epsilon} x dx - \int_{\tilde{x}}^1 g^{\epsilon} dx.$$
 (3.67)

Now we estimate the term $(u^{\epsilon})^2$ in (3.67). Since

$$|(u^{\epsilon})^2|^2 \le |u^{\epsilon}|_{L^4(\mathcal{M})}^4 \lesssim \text{(by } H^{3/4}(\mathcal{M}) \subset L^4(\mathcal{M}) \text{ in 3D)} \lesssim |\nabla u^{\epsilon}|^3 |u^{\epsilon}|,$$

we have

$$\int_0^{T_*} |(u^{\epsilon})^2|^2 ds \lesssim \int_0^{T_*} |\nabla u^{\epsilon}|^3 |u^{\epsilon}| ds \leq \text{(by (3.21) and the Poincar\'e inequality)} \lesssim C(\mu)^4 T_*. \tag{3.68}$$

Thus

$$(u^{\epsilon})^2$$
 is bounded independently of ϵ in $L^2(0, T_*; L^2(\mathcal{M}))$. (3.69)

Applying $(3.7)_4$, (3.63) and (3.69) to (3.67) we find

$$h^{\epsilon}$$
 is bounded independently of ϵ in $L^{2}(0, T_{*}, L^{2}(\mathcal{M}))$. (3.70)

Multiplying (3.66) by u_{xx}^{ϵ} , integrating in x from 0 to 1, we obtain

$$\bullet \epsilon \int_0^1 u_{xxx} u_{xx} dx = \frac{\epsilon}{2} u_{xx}^2 \big|_{x=1},$$

$$\bullet \epsilon \int_0^1 u_{xx} \big|_{x=1} u_{xx} dx = \epsilon u_{xx} \big|_{x=1} \int_0^1 u_{xx} dx = -\epsilon u_{xx} \big|_{x=1} u_x \big|_{x=0};$$

hence we arrive at

$$\int_{0}^{1} (u_{xx}^{\epsilon})^{2} dx + \frac{\epsilon}{2} (u_{xx}^{\epsilon})^{2} \Big|_{x=1} = -\epsilon u_{xx}^{\epsilon} \Big|_{x=1} u_{x}^{\epsilon} \Big|_{x=0} + \int_{0}^{1} u_{xx}^{\epsilon} h^{\epsilon} dx,$$

$$\leq \frac{\epsilon}{4} (u_{xx}^{\epsilon} \Big|_{x=1})^{2} + c' \epsilon (u_{x}^{\epsilon} \Big|_{x=0})^{2} + \frac{1}{2} |u_{xx}^{\epsilon}|_{L^{2}(I_{x})}^{2} + \frac{1}{2} |h^{\epsilon}|_{L^{2}(I_{x})}^{2}.$$

Thus

$$\frac{1}{2} \int_0^1 (u_{xx}^{\epsilon})^2 dx + \frac{\epsilon}{4} (u_{xx}^{\epsilon}\big|_{x=1})^2 \le c' \epsilon (u_x^{\epsilon}\big|_{x=0})^2 + \frac{1}{2} |h^{\epsilon}|_{L^2(I_x)}^2. \tag{3.71}$$

We integrate both sides of (3.71) in $I_{x^{\perp}}$ and then in time from 0 to T_* ; by (3.70) and (3.7)₄ we obtain (3.58). As in Remark 3.1, we thus have (3.60).

Now since

$$|u^{\epsilon}u_{x}^{\epsilon}|^{2} \leq |u^{\epsilon}|_{L^{4}(\mathcal{M})}^{2}|u_{x}^{\epsilon}|_{L^{4}(\mathcal{M})}^{2}$$

$$\lesssim (\text{by }H^{3/4}(\mathcal{M}) \subset L^{4}(\mathcal{M}) \text{ in 3D})$$

$$\lesssim |u^{\epsilon}|^{1/2}|\nabla u^{\epsilon}|^{3/2}|u_{x}^{\epsilon}|^{1/2}[u^{\epsilon}]_{2}^{3/2}$$

$$\lesssim |u^{\epsilon}|^{2}|\nabla u^{\epsilon}|^{4} + [u^{\epsilon}]_{2}^{2},$$

hence we obtain

$$\int_0^{T_*} |u^{\epsilon} u_x^{\epsilon}|^2 \, ds \lesssim \int_0^{T_*} |u^{\epsilon}|^2 |\nabla u^{\epsilon}|^4 \, ds + \int_0^{T_*} [u]_2^2 \, ds.$$

This together with (3.21) and (3.60) implies (3.59).

4 Passage to the limit

Using a compactness argument, we can pass to the limit in (3.1). Hence we obtain (2.1), with a function $u \in C^1([0,T_*];L^2(\mathcal{M})) \cap L^2(0,T;H^1_0(\mathcal{M}))$. Then we rewrite (2.1) as

$$u_{xxx} = -u_t - \Delta^{\perp} u_x - cu_x - uu_x - f. \tag{4.1}$$

From (3.19), (3.24) and (3.59), we infer that each term in the right-hand-side of (4.1) belongs to $L^2(0, T_*; L^2(\mathcal{M}))$, and hence

$$u_{xxx} \in L^2(0, T_*; L^2(\mathcal{M})).$$
 (4.2)

Now we are ready to state the main result: the local existence of strong solutions.

Theorem 4.1. The assumptions are the same as in Proposition 3.1, that is (3.5), (3.6), (3.8) and (3.13)-(3.17). We suppose also that the following compatibility conditions hold:

$$u_0 = 0 \text{ on } \partial \mathcal{M}, \ u_{0x}\big|_{x=1} = 0, \ u_{0yy}\big|_{y=\pm\frac{\pi}{2}} = u_{0zz}\big|_{z=\pm\frac{\pi}{2}} = 0,$$
 (4.3)

$$u_{t0} = 0 \text{ on } \partial \mathcal{M}, \ \frac{\partial u_{t0}}{\partial x}\Big|_{x=1} = 0, \ \frac{\partial^2 u_{t0}}{\partial y^2}\Big|_{y=\pm\frac{\pi}{2}} = \frac{\partial^2 u_{t0}}{\partial z^2}\Big|_{z=\pm\frac{\pi}{2}} = 0,$$
 (4.4)

where $u_{t0} = -\Delta u_{0x} - u_{0}u_{0x} - cu_{0x} + f(0)$. Then there exists a local strong solution to (2.1)-(2.4) on some time interval $[0, T_*)$, $T_* > 0$ depending only on the data as in Proposition 3.1, such that

$$\nabla u, u_{yy}, u_{zz}, u_t \in L^{\infty}(0, T_*; L^2(\mathcal{M})), \tag{4.5}$$

$$u \in L^2(0, T_*; D(A)),$$
 (4.6)

$$u \in L^2(0, T_*; \Xi),$$
 (4.7)

$$u \in L^2(0, T_*; H^3(I_x; L^2(I_{x^{\perp}})) \cap H^3(I_{x^{\perp}}; L^2(I_x))),$$
 (4.8)

$$u_t \in L^2(0, T_*; H^1(\mathcal{M})).$$
 (4.9)

Moreover, we have for every $t \in (0, T_*)$,

$$u_{yy}(t)\big|_{y=\pm\frac{\pi}{2}} = u_{zz}(t)\big|_{z=\pm\frac{\pi}{2}} = 0.$$
 (4.10)

Remark 4.1. We have proven that all the spatial derivatives of the third order of u are in $L^2(0,T_*;L^2(\mathcal{M}))$, except for u_{xxy} and u_{xxz} .

Proof. We rewrite (2.1) as

$$Au = -u_t - uu_x - f; (4.11)$$

from (3.19) and (3.59) we know that each term on the right-hand side of (4.11) belongs to $L^2(0, T_*; L^2(\mathcal{M}))$. Hence Au belongs to the same space. We also know that $u_x(1, x^{\perp}, t) = 0$, $t \in [0, T]$ using the same argument as in [STW12]. Hence we obtain (4.6). Now by (2.8) and (4.6), we deduce (4.7).

By (3.22), we know that u_{yyy} , u_{zzz} both belong to $L^2(0, T_*; L^2(\mathcal{M}))$. Hence we can apply the trace theorem and pass to the limit on the boundary conditions in (3.2) to obtain (4.10).

The other results can be deduced directly from (3.19)-(3.24) and (4.2).

Remark 4.2. As for the periodic case, that is, (2.1) and the boundary and initial conditions (2.2), (2.3) and (2.5), the results are exactly the same as in the Dirichlet case discussed above. The reasoning is totally the same and therefore we skip it.

5 Appendix: a trace result

We recall a trace result from [STW12], which is used in the article.

Lemma 5.1. Let Y be a (not necessarily reflexive) Banach space and let $p \ge 1$. Assume that two sequences of functions u^{ϵ} , $g^{\epsilon} \in L^p_x(I_x; Y)$ satisfy

$$\begin{cases}
 u_{xxx}^{\epsilon} + \epsilon u_{xxxx}^{\epsilon} = g^{\epsilon}, \\
 u^{\epsilon}(0) = u^{\epsilon}(1) = u_{x}^{\epsilon}(1) = u_{xx}^{\epsilon}(0) = 0,
\end{cases}$$
(5.1)

with g^{ϵ} bounded in $L_x^p(I_x; Y)$ as $\epsilon \to 0$. Then u_{xx}^{ϵ} (and hence u_x^{ϵ} , and u^{ϵ}) is bounded in $L_x^{\infty}(I_x; Y)$ as $\epsilon \to 0$. Furthermore if Y is reflexive, then for any subsequence $u^{\epsilon} \to u$ converging strongly or weakly in $L_x^q(I_x; Y)$, $1 < q < \infty$, $u_x^{\epsilon}(1)$ converges to $u_x(1)$ in Y (weakly at least), and hence $u_x(1) = 0$.
