## Abstract

## «Stochastic Manifolds»

Malliavin Calculus can be seen as a differential calculus on Wiener spaces. We present the notion of stochastic manifold for which the Malliavin Calculus plays the same role as the classical differential calculus for the $\mathbb{C}^{\infty}$ differential manifolds. The set of the paths in a Riemmanian compact manifold is then seen as a particular case of the above structure.

## 0. Introduction

"To do a geometry you do not need a space, you only need an algeba of functions on this would-be space."
A. Grothendieck

The Malliavin Calculus can be seen as a differential calculus on Wiener spaces. It is then possible to establish a new dimensionless differential geometry, for which the Malliavin calculus plays the same role as the one played by the classical differential calculus in the theory of $n$-dimensional manifolds.

Moreover, is it also possible to obtain a Variational Calculus on a random structure, which is built by constraints subjected to infinitesimal variation? This sort of problem is recurrent in Physics and Econometry.

Such a Variational Calculus imposes a reasonnable space of "measurable and regular" functions, with a compatibility between associated differentiation and integration processes, from which a generalized divergence operator.

As such a problem requires an infinite dimensional space, it becomes needed to have an infinite dimensional differential calculus with a related good notion of a divergence.

The Malliavin Calculus provides such a tool. More precisely: in $\mathbb{R}^{n}$, there is compatibility between differentiation and integration because the Lebesgue measure is translation invariant. Unfortunately, in the case of an infinite dimensional topological vector space $E$, such a non-trivial translation measure does not exist. But there can be quasi-invariant measures $\mu$, that is : there is a dense subspace $H$ of $E$, such that the image measure of $\mu$ by a translation with the vector $h \in H$, admits a density relatively to $\mu$.

A natural is $E=$ Wiener space $\mathcal{W}$, with $\mu=$ Gaussian measure, and $H$ being the Cameron-Martin space which then is an Hilbert space.

More precisely, given a basis manifold $V$ and a fiber space $F$ on $V$, it is possible to endow the space of the random sections of $F$, witch a reasonable measure so that there is a Variational calculus.

Two particular cases which are extreme case have already been studied : random Brownian fields (maps from $V$ in a Gaussian space), and the set of continuous paths in a Compact Riemannian manifold.

In the first case, there has been the Wiemann (Wiener + Riemann) manifold $[9,10,11,14]$.

But it brought several very strong limitations:
(1) a Wiemann manifold is a triple $(W, \tau, g)$ Banach $C^{j}$-manifold, modelled on an abstract Wiener space $(H, B)$ with $j \geq 1$. And: $\forall x \in W, \tau_{x}$ is a norm on $T_{x} W$ and $g(x)$ is a densely defined inner product on $T_{x} W$
(2) The chart change maps must be of the form $I_{B}+K, K$ having to fulfill several conditions [10, 14].

Moreover the set of continuous paths on a compact Riemannian manifold $V_{n}$, starting from $m_{0}$ (denoted in this paper $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ ) cannot be naturally described as a Wiemann structure, while we will prove that $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ is a $\mathbb{D}^{\infty}$-stochastic manifold [4].

A slightly different definition of a Wiemann manifold, $\mathcal{W}$, is given by
G. Peters [2], which does not impose that $\mathcal{W}$ be a Riemannian manifold, but instead, that $\mathcal{W}$ be a measure space, its $\sigma$-algebra being generated by a locally-finite countable family of subsets of $\mathcal{W},\left(\mathcal{U}_{\alpha}\right)_{\alpha \in \mathbb{N}_{\star}}$, each $\mathcal{U}_{\alpha}$ being a $H-C^{k}$ set and the family $\left(\mathcal{U}_{\alpha}\right)_{\alpha \in \mathbb{N}_{\star}}$ must admit a subordinate $\mathbb{D}^{\infty}$-unity partition.

Moreover the chart change maps must admit similar conditions as in the previous definition above.

The other extremal case has been studied by P . Malliavin and A. B. Cruzeiro, [4], and it also brought major constraints:
(1) $C_{0}\left([0,1], \mathbb{R}^{2}\right)$ and $C_{0}\left([0,1], \mathbb{R}^{3}\right)$ are not diffeomorphic, although, as Wiener spaces, they are isomorphic.
(2) $\mathbb{P}\left(m_{0}, V_{n}\right)$ is seen by the authors as the domain of a single chart, with the Itō map. But the Itō map does not admit a natural linear tangent map. So the authors had to enlarge the tangent space with particular processes, called tangent spaces, which are semi-martingales. So the time filtration becomes invariant. This invariance has important consequences, among them the impossibility to include the Brownian fields in this framework. And if a manifold structure could be endowed on $P_{m_{0}}\left(V_{n}, g\right)$, this structure would strictly depend on the time filtration.

We offer here a new mathematical structure named: the $\mathbb{D}^{\infty}$-stochastic manifold, which overcomes the Wiemann structure, and its limitations, for which $P_{m_{0}}\left(V_{n}, g\right)$ is a particular case, $C_{0}\left([0,1], \mathbb{R}^{n}\right)$ and $C_{0}\left([0,1], \mathbb{R}^{m}\right), n \neq m$ being $\mathbb{D}^{\infty}$-diffeomorphic.

Moreover, with such a structure:
(1) the notion of time (filtration) does not play any role anymore
(2) in the case of $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$, dim $V_{n}$ is not anymore relevant.
(3) given a metric on $V_{n}$, the various connections compatible with the metric, induce canonical associated Itō maps, and $\mathbb{D}^{\infty}$-diffeomorphisms on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$.

To build the general theory of $\mathbb{D}^{\infty}$-stochastic manifolds, a source will be the Grothendieck identification of an $n$-dimensional manifold with a sheaf of $C^{\infty}$-functions; here, $C^{\infty}$ will be replaced by $\mathbb{D}^{\infty}(\Omega)$, and a diffeomorphism will be a map between two Gaussian spaces that will keep the $\mathbb{D}^{\infty}$ property through right-composition and this diffeomorphism will have a canonical "cotangent" linear map.

A generalisation of the notion of metric will be established, which will live on the "cotangent spaces" (and not on the "tangent spaces"). And $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ will be a particular case of this $\mathbb{D}^{\infty}$-structure.

Moreover, for the general $\mathbb{D}^{\infty}$-structure, it is possible to define the notions of curvature and torsion, but they can become infinite. But nevertheless, a variational calculus of the curvature, function of the metric, can be realized.

Among the notable differences between a $\mathbb{D}^{\infty}$-stochastic structure on a set, and a $C^{\infty}-n$-dimensional manifold, we have:
(1) in a $C^{\infty}-n$-dimensional manifold, vector fields and derivations coincide; such is not the case for a $\mathbb{D}^{\infty}$-stochastic manifold.
(2) on a Riemannian $n$-dimensional manifold, $C^{\infty}$ functions can be defined either through $C^{\infty}$-charts reading, or by iteration of the Laplacian; both definitions coincide.

On a $\mathbb{D}^{\infty}$-stochastic manifold we can define a $\mathbb{D}^{\infty}$-function either through charts reading or, if there is a metric and probabilistic measure, by iteration
of the Ornstein-Uhlenbeck operator: these two definitions, in general, do not coincide but for $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ there is an inclusion.

More diffeomorphisms give more changes of variables thus more opportunities to compute integrals. In all the following, we suppose that all Cameron-Martin spaces have countable Hilbertian bases, but this is just for simplification for the reader and is not a loss of generality.

## 1. $\mathbb{D}_{r}^{\infty}$-Stochastic Manifold, $r \in \mathbb{N}_{*}$

Here we will study the $\mathbb{D}_{r}^{\infty}$-stochastic manifold structure. In this particular case, any map, change of charts, admits a tangent linear map between the respective Cameron-Martin spaces; such a tangent linear map does not exist anymore in the case of the $\mathbb{D}^{\infty}$ structure.

Moreover this $D_{r}^{\infty}$ type of structure is not satisfying because it does not include as a particular case the set of the continuous paths in a compact manifold $V_{n}$, starting from $m_{0}$ (denoted $\mathbb{P}\left(m_{0}, V_{n}\right)$ ).

Reminder: 1) all $\sigma$-fields are complete,
2) a Gaussian probability space [13] is given by the following elements:
i) $(\Omega, \mathcal{F}, \mathbb{P})$ a probability space,
ii) a closed subspace $H$ of $L^{2}(\Omega, \mathcal{F}, \mathbb{P})$ such that all the random variables belonging to $H$ have a centered Gaussian law,
iii) the $\sigma$-field generated by these variables is $\mathcal{F}$.
3) $\mathbb{D}_{r}^{\infty}(\Omega)$ is a Frechet space, and its distance is denoted by $d$ :

## 1. 1 Definition and charts exchange maps

Definition 1..1. Let $\mathcal{S}$ be a set; a stochastic chart on $\mathcal{S}$ is given by a subset of $\mathcal{S}$ denoted $\mathcal{U}$, named: domain of the chart, a Gaussian space $(\Omega, \mathcal{F}, \mathbb{P}, H)$ and a bijection b from $\mathcal{U}$ onto $\Omega$.

This chart is denoted $(\mathcal{U}, b, \Omega, \mathcal{F}, H)$ or in short: $(\mathcal{U}, b, \Omega)$.
Definition 1..2. Two stochastic maps $\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right), i=1,2$, will be said to be $\mathbb{D}_{r}^{\infty}$-compatibles if and only if:
i) $b_{1} \circ b_{2}^{-1}=b_{21}$ and $b_{2} \circ b_{1}^{-1}=b_{12}$ are measurable maps between
$\left(b_{2}\left(\mathcal{U}_{2} \cap \mathcal{U}_{1}\right),\left.\mathcal{F}_{2}\right|_{b_{2}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}\right)$ and $\left(b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right),\left.\mathcal{F}_{1}\right|_{b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}\right)$
ii) $b_{12}$ and $b_{21}$ exchange the $\mathbb{P}_{i}$-null sets of $\left.\mathcal{F}_{i}\right|_{b_{i}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}, i=1,2$
iii) $\forall A \subset b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right), A \in \mathcal{F}_{1}, \mathbb{P}_{1}(A)>0, \exists A_{1} \subset A,\left.A_{1} \in \mathcal{F}_{1}\right|_{b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}$,
$\mathbb{P}_{1}\left(A_{1}\right)>0$ such that $\forall \varphi \in \mathbb{D}_{r}^{\infty}\left(\Omega_{2}\right)$, $\left.\varphi \circ b_{12}\right|_{A_{1}}$ admits an extension map, denoted $\left.\varphi \circ b_{12}\right|_{A_{1}}$ and $\left.\varphi \circ b_{12}\right|_{A_{1}} \in \mathbb{D}_{r}^{\infty}\left(\Omega_{1}\right)$ and conversely, the same extension property is valid for $B \subset b_{2}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right), B \in \mathcal{F}_{2}, \mathbb{P}_{2}(B)>0, \varphi \in \mathbb{D}_{r}^{\infty}\left(\Omega_{1}\right)$. $b_{12}$ and $b_{21}$ are called charts changes, or charts maps.

Definition 1..3. $A \mathbb{D}_{r}^{\infty}$-stochastic manifold is a set $\mathcal{S}$ and a family $\mathcal{A}$ of stochastic charts, which are $\mathbb{D}_{r}^{\infty}$-compatibles, and such that the union of the domains of the charts covers $\mathcal{S}$. It is denoted: $\left(\mathcal{S},\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}\right)_{i \in I}\right)$.
$\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}\right)_{i \in I}$ being the family of charts.

Such a family is called an $\mathbb{D}_{r}^{\infty}$-atlas of $\mathcal{S}$.
DEFINITION 1..4. Let $\left(\mathcal{S},\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}\right)_{i \in I}\right)$ a $\mathbb{D}_{r}^{\infty}$-stochastic manifold, and $(A, \mathcal{F}, \mathbb{P})$ a probability space with $A \subset \mathcal{S}$. The atlas $\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}\right)_{i \in I}$ will be said to cover $A$ if and only if: $\forall B \subset A, \exists i \in I$ and $B_{1} \in \mathcal{F}$, such that $B_{1} \subset \mathcal{U}_{i} \cap B$ and $\mathbb{P}\left(B_{1}\right)>0$.

LEmma 1..1. With the notations of definition 1.4, there exist a countable family of charts from the atlas $\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}\right)_{i \in I},\left(\mathcal{U}_{j}, b_{j}, \Omega_{j}\right)_{j \in \mathbb{N}_{*}}$ such that:

$$
A \subset \bigcup_{j \in \mathbb{N}_{*}} \mathcal{U}_{j}
$$

The notions of a compatible chart to an atlas, or of equivalent atlases, will be given in the case of the $\mathbb{D}^{\infty}$-stochastic manifold.

## 1. 2 Existence of a tangent linear maps

## Morphisms associated to chart changes

Let $\mathcal{S}$ be a set, and $\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right), i=1,2$ two charts on $\mathcal{S}, \mathbb{D}_{r}^{\infty}$-compatibles. We denote again by $\mathbb{P}_{1}$ and $\mathbb{P}_{2}$ the probability measures restricted to $\left.\mathcal{F}_{1}\right|_{b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}$ and $\left.\mathcal{F}_{2}\right|_{b_{2}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}$. Let $A_{0} \subset A_{1} \subset \ldots \subset A_{k} \subset \ldots$ an increasing sequence of items in $\tilde{\mathcal{F}} ; A=\cup_{k} A_{k}$. $\forall k \in \mathbb{N}$ there exist sequences of functions $\varphi_{n}^{(k)}$ and $\psi_{n}^{(k)}$ with the related properties because $A_{k} \in \tilde{\mathcal{F}}$. Then with the dominated convergence theorem:

This last equation shows that on $A_{i} \cap A_{j}, T_{A_{i}}=T_{A_{j}}, \mathbb{P}_{1}$-a.s; so there exists a linear bounded operator from $H_{1}$ in $H_{2}$, such that: $\mathbb{P}_{1}$-a.s on $b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)$ : $\forall \varphi \in \mathbb{D}_{r}^{\infty}\left(\Omega_{2}\right)$ and $\forall u \in H_{1}$, denoted $T_{12}$ :

<T_{12}(\omega) \cdot u, \operatorname{grad} \varphi>_{H_{2}}=<u, \operatorname{grad}\left[\overline{\left.\left.\varphi \circ b_{12}\right|_{A_{1}}\right]}>_{H_{1}} \circ b_{21}\right.

It is easy to show the transitivity of these $T_{i j}$ : if we have three compatible charts $\left(\mathcal{U}_{i}, b_{i}, \Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right), i=1,2,3$ such that $\mathbb{P}_{i}\left[b_{i}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2} \cap \mathcal{U}_{3}\right)\right]>0$, then $T_{i j} \circ T_{j k}=T_{i k}$, a.s. on $b_{i}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2} \cap \mathcal{U}_{3}\right)$.

Last, this bounded linear map $T_{12}$, is measurable from $\left(b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right),\left.\mathcal{F}_{1}\right|_{b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)}\right)$ in $\mathcal{L}\left(H_{1}, H_{2}\right)$ and is $L^{\infty-0}\left(b_{1}\left(\mathcal{U}_{1} \cap \mathcal{U}_{2}\right)\right)$ : the constant $C(p, q)$ in (7) might be dependent of $A_{1}$.

## 2. Preliminaries

$(\Omega, \mathcal{F}, \mathbb{P}, H)$ being a Gaussian space: Here we state some definitions of mathematical tools that will be needed, and some of their properties, and prove:
i) some theorems about the existence of unique continuous linear extensions of continuous linear operators from $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega)$
ii) $\mathbb{D}_{\infty}^{2}(\Omega) \cap L^{\infty-0}(\Omega)=\mathbb{D}^{\infty}(\Omega)$
iii) Any continuous derivation on $\mathbb{D}^{\infty}(\Omega)$ is a strong limit of $\mathbb{D}^{\infty}$-vector fields, and some properties of these continuous derivations.

Whenever no particular setting is specified, it is assumed that we deal with a Gaussian space $(\Omega, \mathcal{F}, \mathbb{P}, H)$.

The theorems proved here will be needed for the development, but the reader can also go directly to Section 3 and use the results of this section, which will be referred to when they appear.

On $\mathbb{D}_{r}^{p}(\Omega)$, the two following norms are equivalent:

& \left.\left\|\operatorname{grad}^{j} f\right\|_{\dot{\otimes} H}^{p} \mathbb{P}(d \omega)\right)^{\frac{1}{p}} \text { (Malliavin) }
\end{aligned}
$$

We have: $\|f\|_{\mathbb{D}_{r}^{p}(\Omega)}^{(1)} \leq\|f\|_{\mathbb{D}_{r}^{p}(\Omega)}^{(2)} \leq r^{1-\frac{1}{p}}\|f\|_{\mathbb{D}_{r}^{p}(\Omega)}^{(1)}$

Notation. If $\left(\Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right)$ are two Gaussian spaces $(i=1,2)$, we denote by $K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ :
$K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)=\left\{\sum_{j \in J} \alpha_{j}\left(\omega_{1}\right) \beta_{j}\left(\omega_{2}\right) \mid J\right.$ finite , $\left.\alpha_{j}\left(\omega_{1}\right) \in \mathbb{D}^{\infty}\left(\Omega_{1}\right), \beta_{j}\left(\omega_{2}\right) \in \mathbb{D}^{\infty}\left(\Omega_{2}\right)\right\}$
Then $K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ is a $\mathbb{D}^{\infty}$-dense subset of $\mathbb{D}^{\infty}\left(\Omega_{1}, \Omega_{2}\right)$.

## 2. 1 Some extensions of continuous linear maps

Definition 2..1. i) A subset $D \subset \mathbb{D}^{\infty}(\Omega)$ will be said to be $\mathbb{D}^{\infty}$-bounded iff:
$\forall(p, r), p>1, r \in \mathbb{N}, \exists a$ constant $C(p, r)$ such that:

ii) a process $\varphi(t, \omega):[0,1] \times \Omega \rightarrow \mathbb{R}$ will be said to be $\mathbb{D}^{\infty}$-bounded iff:
$\forall(p, r), p>1, r \in \mathbb{N}_{\star}, \exists$ a constant $C(p, r)$ such that:

\sup _{t \in[0,1]}\|\varphi\|_{\mathbb{D}_{r}^{p}(\Omega)} \leq C(p, r)

Theorem 2..1. i) Let $(\Omega, \mathcal{F}, \mathbb{P})$ and $\left(\Omega_{1}, \mathcal{F}_{1}, \mathbb{P}_{1}\right)$ be two probability spaces, and $T$ a continuous linear operator from $L^{q}\left(\Omega, H_{1}\right)$ in $L^{p}\left(\Omega, H_{2}\right)$ with $q \geq p$, $H_{1}$ and $H_{2}$ being two abstract Hilbert spaces.

Denote $\tilde{T}$ the linear operator defined on:

$$
K_{q, p}\left(\Omega \times \Omega_{1}\right)=\left\{\sum_{j \in J} \alpha_{j}(\omega) \beta_{j}\left(\omega_{1}\right) \mid J \text { finite, } \alpha_{j} \in L^{q}\left(\Omega, H_{1}\right), \beta_{j} \in L^{q}\left(\Omega_{1}, \mathbb{R}\right)\right\}
$$

by $\tilde{T}\left(\sum_{j \in J} \alpha_{j}(.) \beta_{j}().\right)=\sum_{j \in J} \beta_{j}\left(\omega_{2}\right)\left(T \alpha_{j}\right)\left(\omega_{1}\right)$.
Then there is a unique linear continuous extension of $\tilde{T}$, denoted $\tilde{T}$, from $L^{q}\left(\Omega \times \Omega_{1}, H_{1}\right)$ to $L^{p}\left(\Omega \times \Omega_{1}, H_{2}\right)$.
ii) If $T_{k}$ is a sequence of continuous linear operators from $L^{q}\left(\Omega, H_{1}\right)$ to $L^{p}\left(\Omega, H_{2}\right), k$-uniformly continuous, then the sequence $\tilde{T}^{k}$ is $k$-uniformly continuous from $L^{q}\left(\Omega \times \Omega_{1}, H_{1}\right)$ to $L^{p}\left(\Omega \times \Omega_{1}, H_{2}\right)$.

Proof. i) Let $\omega \in \Omega, \omega_{1} \in \Omega_{1}$ :

& =\int \mathbb{P}\left(d \omega_{1}\right)\left\|T\left(\sum_{j \in J} \alpha_{j}(.) \beta_{j}\left(\omega_{1}\right)\right)\right\|_{L^{p}\left(\Omega, H_{2}\right)}^{p}
\end{aligned}
$$

$$
\begin{aligned}
& \leq\|T\|^{p} \int \mathbb{P}\left(d \omega_{1}\right)\left\|\sum_{j \in J} \alpha_{j}(.) \beta_{j}\left(\omega_{1}\right)\right\|_{L^{q}\left(\Omega, H_{1}\right)}^{p} \\
& =\|T\|^{p}\| \| \sum_{j \in J} \alpha_{j}(.) \beta_{j}\left(\omega_{1}\right)\left\|_{L^{q}\left(\Omega, H_{1}\right)}^{p}\right\|_{L^{1}\left(\Omega_{1}, \mathbb{R}\right)}^{p} \\
& \leq\|T\|^{p}\| \| \sum_{j \in J} \alpha_{j}(.) \beta_{j}\left(\omega_{1}\right)\left\|_{L^{q}\left(\Omega, H_{1}\right)}^{p}\right\|_{L^{q / p}\left(\Omega_{1}, \mathbb{R}\right)} \\
& =\|T\|^{p}\left\|\sum_{j \in J} \alpha_{j}(.) \beta_{j}(.)\right\|_{L^{q}\left(\Omega \times \Omega_{1}, H_{1}\right)}^{p}
\end{aligned}
$$

ii) immediate from above.

Corollary 2..1. If $T$ is a continuous linear operator of $L^{\infty-0}\left(\Omega, H_{1}\right)$ in $L^{\infty-0}\left(\Omega, H_{2}\right)$, then $\tilde{T}$ is a continuous linear operator from $L^{\infty-0}\left(\Omega \times \Omega_{1}, H_{1}\right)$ to $L^{\infty-0}\left(\Omega \times \Omega_{1}, H_{2}\right)$.

Theorem 2..2. Let $\left(\Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right)_{i=1,2}$ be two Gaussian spaces and $H_{3}$ and $H_{4}$ two abstract Hilbert spaces.
i) If $T$ is a linear continuous operator from $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{3}\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{4}\right)$, there exists a unique linear extension $\tilde{T}$ of $T$, from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H_{3}\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H_{4}\right)$.
ii) If $T_{k}$ is a $k$-uniformly convergent sequence from $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{3}\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{4}\right)$, then the sequence $\tilde{T}_{k}$ is $k$-uniformly convergent from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H_{3}\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H_{4}\right)$.
Proof. i) to simplify, we suppose $H_{3}=H_{4}=\mathbb{R}$. Let $L_{1}$ and $L_{2}$ be the O.U. operators on $\mathbb{D}^{\infty}\left(\Omega_{1}\right)$ and $\mathbb{D}^{\infty}\left(\Omega_{2}\right)$, and $L$ the O.U. operator on $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$. $\tilde{L}_{1}$ is $\mathbb{D}^{\infty}$-continuous on $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ : if $r \in \mathbb{N}_{\star}$ and $\varphi$ in $K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$, we have $\tilde{L}_{1}+\tilde{L}_{2}=L$, so

& =\left\|\tilde{L}_{1}(1-L)^{r / 2} \varphi\right\|_{L^{p}\left(\Omega_{1} \times \Omega_{2}\right)} \\
& \leq C\left\|(1-L)^{r / 2} \varphi\right\|_{L^{q}\left(\Omega_{1} \times \Omega_{2}\right)} \\
& \leq C\|\varphi\|_{\mathbb{D}_{r}^{q}\left(\Omega_{1} \times \Omega_{2}\right)}
\end{aligned}
$$

$C$ being a constant, $q>1$.
Therefore, $\tilde{L}_{2}$ is $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$-continuous.
We will prove by induction that $\tilde{T}$ is $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$-continuous.
Corollary $2 . .1$ shows that $\tilde{T}$ is continuous from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$
to $L^{\infty-0}\left(\Omega_{1} \times \Omega_{2}\right)$.
We suppose that $\tilde{T}$ is continuous from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ to $\mathbb{D}_{r}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$.
On $K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$, we have $\tilde{L}_{2} \circ \tilde{T}=\tilde{T} \circ \tilde{L_{2}}$.
So using the induction hypothesis: $\exists(q, s), q>1, s \in \mathbb{N}_{\star}$ and a constant $C_{1}$ such that $\forall \varphi \in K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ :

Again with the induction hypothesis on $r$, there exists $\left(q^{\prime}, s^{\prime}\right), q>1, s^{\prime} \in \mathbb{N}_{\star}$ and a constant $C_{2}$ such that:

Then: $\|((1-L) \circ \tilde{T}) \varphi\|_{\mathbb{D}_{r}^{p}} \leq\left(C_{1} \vee C_{2}\right)\|\varphi\|_{s \vee s^{\prime}}^{q \vee q^{\prime}}$
So $(1-L) \circ \tilde{T}$ is continuous from $K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ in $\mathbb{D}_{r}^{p}\left(\Omega_{1} \times \Omega_{2}\right)$. So $\tilde{T}$ is continuous from $K^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ to $\mathbb{D}_{r+2}^{p}\left(\Omega_{1} \times \Omega_{2}\right)$ and then from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ to $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$.

Theorem 2..3. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space, $\tilde{H}$ an abstract Hilbert space, $\left(e_{i}\right)_{i \in \mathbb{N}_{\star}}$ an Hilbertian basis of $\tilde{H}$, and $T$ a linear continuous operator from $L^{p}(\Omega)$ to $L^{q}(\Omega)$.

Denote $\tilde{T}$ the linear operator defined by the serie:
if $X(\omega)=\sum_{i=1}^{\infty} f_{i}(\omega) e_{i}, X \in \mathbb{D}^{\infty}(\Omega, \tilde{H}), f_{i}(\omega) \in \mathbb{D}^{\infty}(\Omega)$
then $\tilde{T}(X)=\sum_{i=1}^{\infty}\left(T f_{i}\right)(\omega) e_{i}$.
This definition of $\tilde{T}$ is meaningful, and $\tilde{T}$ is a continuous linear operator from $L^{p}(\Omega, \tilde{H})$ to $L^{q}(\Omega, \tilde{H})$.

Proof. Let $\left(\Omega_{1}, \mathcal{F}_{1}, \mathbb{P}_{1}, H_{1}\right)$ be a Gaussian space, independent of $(\Omega, \mathcal{F}, \mathbb{P}, H)$, and $\left(e_{j}\right)_{j \in \mathbb{N}_{\star}}$ an Hilbertian basis of $H_{1}$.

Denote $Y_{j}=W\left(e_{j}\right)$; then the random variable $\sum_{i=1}^{\infty} f_{i}(\omega) Y_{i}\left(\omega_{1}\right)$ is correctly defined because its $L^{p}\left(\Omega \times \Omega_{1}\right)$ norm is equivalent to the $L^{p}(\Omega, \tilde{H})$ norm of X:

and $\sum_{i=1}^{\infty} f_{i}(\omega) Y_{i}\left(\omega_{1}\right)$ is a Gaussian variable with law $N\left(0, \sqrt{\sum_{i=1}^{\infty}\left|f_{i}(\omega)\right|^{2}}\right)$, for almost all $\omega \in \Omega$.

Similarly, we have: $\|\tilde{T}(X)\|_{L^{q}(\Omega, \tilde{H})} \sim\left\|\sum_{i=1}^{\infty}\left(T f_{i}\right)(\omega) Y_{i}\left(\omega_{1}\right)\right\|_{L^{q}\left(\Omega \times \Omega_{1}\right)}$.
To prove that $\tilde{T}$ is continuous, it is enough to show the inequality; $C$ being a constant:

As $\sum_{i=1}^{\infty} f_{i}(\omega) Y_{i}\left(\omega_{1}\right) \in L^{p}\left(\Omega \times \Omega_{1}\right)$ we have $\mathbb{P}\left(d \omega_{1}\right)$-a.s.:

There are two cases to study:
a) $1<q \leq p<+\infty ; T$ being continuous from $L^{p}(\Omega)$ in $L^{q}(\Omega)$, there exists a constant $C_{0}$ such that $\mathbb{P}\left(d \omega_{1}\right)$-a.s.:

\int \mathbb{P}(d \omega)\left|\sum_{i=1}^{\infty}\left(T f_{i}\right)(\omega) Y_{i}\left(\omega_{1}\right)\right|^{q} \leq C_{0}\left[\int\left|\sum_{i=1}^{\infty} f_{i}(\omega) Y_{i}\left(\omega_{1}\right)\right|^{p} \mathbb{P}(d \omega)\right]^{q / p}
$$

which implies the following inequalities:

\int \mathbb{P}(d \omega) \otimes \mathbb{P}\left(d \omega_{1}\right)\left|\sum_{i=1}^{\infty}\left(T f_{i}\right)(\omega) Y_{i}\left(\omega_{1}\right)\right|^{q} & \leq C_{0} \int \mathbb{P}\left(d \omega_{1}\right)\left[\int\left|\sum_{i=1}^{\infty} f_{i}(\omega) Y_{i}\left(\omega_{1}\right)\right|^{p} \mathbb{P}(d \omega)\right]^{q / p} \\
& \leq C_{0}\left[\int \mathbb{P}(d \omega) \otimes \mathbb{P}\left(d \omega_{1}\right)\left|\sum_{i=1}^{\infty} f_{i}(\omega) Y_{i}\left(\omega_{1}\right)\right|^{p}\right]^{q / p} \tag{Hölder}
\end{align*}
$$

b) $1<p<q<+\infty$ Let $r$ be such that $\frac{1}{q}+\frac{1}{r}=\frac{1}{p}$ and $g \in L^{r}(\Omega)$. We define $T_{g} f=g \cdot T f$. Then $T_{g}: L^{p}(\Omega) \rightarrow L^{p}(\Omega)$, and $\left\|T_{g}\right\|_{L^{p}} \leq\|T\| .\|g\|_{L^{r}}$. We apply case a) above to $T_{g}$, with $C_{1}=\|T\|$ :

\left\|g \cdot\left[\sum_{i=1}^{\infty}\left(T f_{i}\right)(.)^{2}\right]^{\frac{1}{2}}\right\|_{L^{p}(\Omega)} \leq C_{1}\|g\|_{L^{r}}\|X\|_{L^{p}(\Omega, \tilde{H})} \tag{1}
\end{equation*}
$$

And (1) is valid for all $g \in L^{r}(\Omega)$.
Let $p^{\prime}$ and $q^{\prime}$ be such that $\frac{1}{p}+\frac{1}{p^{\prime}}=1$ and $\frac{1}{q}+\frac{1}{q^{\prime}}=1 ; \forall h \in L^{q^{\prime}}, h^{q^{\prime} / r} \in L^{r}(\Omega)$, and $\left\|h^{q^{\prime} / r}\right\|_{L^{r}}=\|h\|_{L^{q^{\prime}}}^{q^{\prime} / r}$.

With (1) we have:

\left\|h^{q^{\prime} / r}\left[\sum_{i=1}^{\infty}\left|T f_{i}\right|^{2}\right]^{\frac{1}{2}}\right\|_{L^{p}} \leq C_{1}\|h\|_{L^{q^{\prime}}}^{q^{\prime} / r}\|X\|_{L^{p}(\Omega, \tilde{H})}
$$

which implies:

\left\|h^{\left(q^{\prime} / r+q^{\prime} / p^{\prime}\right)}\left[\sum_{i=1}^{\infty}\left|T f_{i}\right|^{2}\right]^{\frac{1}{2}}\right\|_{L^{1}} \leq C_{1}\|h\|_{L^{q^{\prime}}}^{\left(q^{\prime} / r+q^{\prime} / p^{\prime}\right)} \cdot\|X\|_{L^{p}(\Omega, \tilde{H})}
$$

But $\frac{q^{\prime}}{r}+\frac{q^{\prime}}{p^{\prime}}=q^{\prime}\left(1-\frac{1}{q}\right)=1$. So:

\|h\| \tilde{T} X\left\|_{H}\right\|_{L^{1}(\Omega)} \leq C_{1}\|h\|_{L^{q^{\prime}}} \cdot\|X\|_{L^{p}(\Omega, \tilde{H})}
$$

which implies that $\tilde{T}$ is continuous from $L^{p}(\Omega, \tilde{H})$ to $L^{q}(\Omega, \tilde{H})$.
Corollary 2..2. Let $T$ be a continuous linear operator from $\mathbb{D}_{r}^{p}(\Omega)$ in $\mathbb{D}_{s}^{q}(\Omega)$, and $\tilde{H}$ be an abstract Hilbert space. Then $\tilde{T}$ is a continuous linear operator from $\mathbb{D}_{r}^{p}(\Omega, \tilde{H})$ to $\mathbb{D}_{s}^{q}(\Omega, \tilde{H})$.

Proof. We denote by $T^{\prime}$ the continuous linear operator, with which the following diagram is commutative:


Then we denote by $(I d-L)_{\tilde{H}}$ the O.U. operator on $\mathbb{D}^{\infty}(\Omega, \tilde{H})$. Then we use Theorem 2.3 to define $\tilde{T}: L^{p}(\Omega, \tilde{H}) \rightarrow L^{q}(\Omega, \tilde{H})$ and

\tilde{T}=(I d-L)_{\tilde{H}}^{-s / 2} \circ \tilde{T}^{\prime} \circ(I d-L)_{\tilde{H}}^{r / 2}
$$

Now another extension theorem: $H_{1}, H_{2}, H^{\prime}$ being three abstract Hilbert spaces and $\left(e_{i}\right)_{i \in \mathbb{N}_{\star}}$ an Hilbertian basis of $H^{\prime}$. Let $T$ be a continuous linear operator from $L^{p}\left(\Omega, H_{1}\right)$ in $L^{q}\left(\Omega, H_{2}\right)$. On the subset of $L^{p}\left(\Omega, H_{1} \otimes H^{\prime}\right)$, with $J$ finite, $J \subset \mathbb{N}_{\star}$ defined by $\left\{\sum_{j \in J} X_{j} \otimes e_{j} / X_{j} \in L^{p}\left(\Omega, H_{1}\right)\right\}$, we define an operator $\tilde{T}$ by: $\tilde{T}\left(\sum_{j \in J} X_{j} \otimes e_{j}\right)=\sum_{j \in J} T X_{j} \otimes e_{j}$; and we have:

Theorem 2..4. If $p \geq q$, there exists an unique extension of $\tilde{T}$, which is continuous linear, from $L^{p}\left(\Omega, H_{1} \otimes H^{\prime}\right)$ in $L^{q}\left(\Omega, H_{2} \otimes H^{\prime}\right)$.

Proof. We will first prove that:

$$

$\left(\Omega_{1}, \mathcal{F}_{1}, \mathbb{P}_{1}, H^{\prime}\right)$ being a Gaussian space, independent of $\left(\Omega, \mathcal{F}, \mathbb{P}, H_{1}\right)$, but with its chaos $\mathcal{C}_{1}\left(\Omega_{1}\right)$ being generated by the $\left(W\left(e_{i}\right)\right)_{i \in \mathbb{N}_{*}}$.

Denote $U=\sum_{j \in J} X_{j} \otimes e_{j}$. Then with $\omega \in \Omega, \omega_{1} \in \Omega_{1}$ :

$$

Let $\omega$ be fixed and $\left(\Omega_{2}, \mathcal{F}_{2}, \mathbb{P}_{2}, H_{1}\right)$ be another Gaussian space, independent of the first two others, and whose chaos $\mathcal{C}_{1}\left(\Omega_{2}\right)$ includes the
$W\left[X_{j}(\omega)\right]\left(\omega_{2}\right), j \in J$. Then:

\|U\|_{L^{p}\left(\Omega, H_{1} \otimes H^{\prime}\right)}=\| \| \sum_{j \in J} W\left(e_{j}\right)\left(\omega_{1}\right) W\left[X_{j}(\omega)\right]\left(\omega_{2}\right)\left\|_{L^{p}\left(\Omega_{1} \times \Omega_{2}\right)}\right\|_{L^{p}(\Omega)}
$$

$\omega$ being fixed, $\sum_{j \in J} W\left(e_{j}\right)\left(\omega_{1}\right) W\left[X_{j}(\omega)\right]\left(\omega_{2}\right)$ is in $\mathcal{C}_{2}\left(\Omega_{1} \times \Omega_{2}\right)$.
All $L^{p}$ norms being equivalent on this chaos $\mathcal{C}_{2}\left(\Omega_{1} \times \Omega_{2}\right)$, we get:

& =\left\{\int \mathbb{P}(d \omega) \otimes \mathbb{P}\left(d \omega_{1}\right) \otimes \mathbb{P}\left(d \omega_{2}\right)\left|\sum_{j \in J} W\left(e_{j}\right)\left(\omega_{1}\right) W\left[X_{j}(\omega)\right]\left(\omega_{2}\right)\right|^{p}\right\}^{\frac{1}{p}}
\end{aligned}
$$

Now we fix $\omega$ and $\omega_{1}$ :
$\sum_{j \in J} W\left(e_{j}\right)\left(\omega_{1}\right) W\left[X_{j}(\omega)\right]\left(\omega_{2}\right)$ is a Gaussian $\in \mathcal{C}_{1}\left(\Omega_{2}\right) ;$ as all $L^{p}$ norms are equivalent on $\mathcal{C}_{1}\left(\Omega_{2}\right)$,
we have:

& =\left\|\sum_{j \in J} W\left(e_{j}\right)\left(\omega_{1}\right) X_{j}(\omega)\right\|_{L^{p}\left(\Omega \times \Omega_{1}, H_{1}\right)} \tag{2}
\end{align*}

A similar computation proves that:

& \leq C\left\|\sum_{j \in J} W\left(e_{j}\right) X_{j}\right\|_{L^{p}\left(\Omega \otimes \Omega_{1}, H_{2}\right)} \simeq C\left\|\sum_{j \in J} X_{j} \otimes e_{j}\right\|_{L^{p}\left(\Omega, H_{1} \otimes H^{\prime}\right)}
\end{aligned}
$$

Then $\tilde{T}\left(\sum_{j \in J} X_{j} \otimes Y_{j}\right)$ can be defined, using the decomposition of $Y_{j}$ on the basis $\left(e_{i}\right)_{i \in \mathbb{N}_{\star}}$ of $H^{\prime}$.

Finally, we have an extension of $\tilde{T}$, continuous linear operator from
$L^{p}\left(\Omega, H \otimes H^{\prime}\right)$ to $L^{q}\left(\Omega, H \otimes H^{\prime}\right)$.
This extension, denoted again $\tilde{T}$, does not depend on the Hilbertian basis of $H^{\prime}$ : if $B$ and $B^{\prime}$ are two Hilbertian bases of $H^{\prime}$, we have with obvious notations:

In the same setting as in Theorem 2..4, if $T$ is a continuous linear operator from $L^{\infty-0}\left(\Omega, H_{1}\right)$ in $L^{\infty-0}\left(\Omega, H_{2}\right)$, then $\tilde{T}$ is continuous linear from $L^{\infty-0}\left(\Omega, H_{1} \otimes H^{\prime}\right)$ in $L^{\infty-0}\left(\Omega, H_{2} \otimes H^{\prime}\right)$

Corollary 2..4. In the same setting as in Theorem 2..4, if T is a continuous linear operator from $\mathbb{D}^{\infty}\left(\Omega, H_{1}\right)$ in $\mathbb{D}^{\infty}\left(\Omega, H_{2}\right)$, then $\tilde{T}$ is continuous linear from $\mathbb{D}^{\infty}\left(\Omega, H_{1} \otimes H^{\prime}\right)$ in $\mathbb{D}^{\infty}\left(\Omega, H_{2} \otimes H^{\prime}\right)$.

Proof. same proof as in Corollary 2..2.
2. $2 \mathbb{D}_{\infty}^{2} \cap L^{\infty-0}=\mathbb{D}^{\infty}$

Theorem 2..5.

Proof. $\mathbb{D}^{\infty} \subset \mathbb{D}_{\infty}^{2} \cap L^{\infty-0}$. For the reverse inclusion, we will need the Phragmen-Lindelof method [16].
$\forall z \in \mathbb{C}$ with $\operatorname{Re} z \geq 0$ and $\forall f \in \mathbb{D}_{\infty}^{2} \cap L^{\infty-0}$, we define $(I d-L)^{-z} f$ by:
$f_{n}$ being the component of $f$ in the chaos $\mathcal{C}_{n}:(I d-L)^{-z} f=\sum_{n=1}^{\infty} \frac{1}{(1+n)^{z}} f_{n}$. This definition is meaningful and coincides with the classic definition when $\operatorname{Re} z>0$ :

If $r>0,1>\epsilon>0$ fixed, we denote by $g: g=(1-L)^{r} f$, then: $\forall t \geq 0$ : $(1-L)^{-(r+\epsilon+i t)} g \in L^{\infty-0}$, because $\forall \psi \in L^{q_{0}}, q_{0}>1$, and $\|\psi\|_{L^{q_{0}}} \leq 1$, we have:

& \leq \frac{\Gamma(\epsilon)}{|\Gamma(\epsilon+i t)|}\|f\|_{L^{q_{0}}} \tag{5}

Let $1<q_{0}<2,1<q_{0}<q^{\prime}<2$ and $\varphi \in L^{\infty-0}$. We denote, with $i=\sqrt{-1}$ :

Then $|\theta(z)|$ is bounded on $\Delta$ and is continuous on $\bar{\Delta}$, because:

Computing $|\theta(0+i t)|$ and $|\theta(r+\epsilon+i t)|$, we get, $C$ being a constant:

|\theta(r+\epsilon+i t)| \leq C t^{\frac{1}{2}} e^{-\frac{\pi}{2} t}\left\|(I d-L)^{-(r+\epsilon+i t} g\right\|_{L^{p_{0}}}\left\|\varphi^{\frac{q^{\prime}}{q_{0}}}\right\|_{L^{q_{0}}}
\end{array}
$$

Using (6), we get:

We choose $\varphi \in L^{\infty-0}$ such that $\|\varphi\|_{L^{q^{\prime}}} \leq 1$. Now, when $t \uparrow \infty, \frac{\Gamma(\epsilon)}{|\Gamma(\epsilon+i t)|} \sim e^{\frac{\pi}{2} t} t^{-\frac{1}{2}}(0<\epsilon<1)$, so we have:

Then: $\left.\forall 1<q^{\prime}<2, \exists a \in\right] 0, r\left[\right.$ such that: $\frac{r-a}{r+\epsilon} \cdot q^{\prime} \cdot\left(\frac{1}{q_{0}}-\frac{1}{2}\right)+\frac{q^{\prime}}{2}=1$ :
$a=r-(r+\epsilon)\left(\frac{\frac{1}{q^{\prime}}-\frac{1}{2}}{\frac{1}{q_{0}}-\frac{1}{2}}\right)$ and we have $\left.a \in\right] 0, r\left[\right.$ if $\epsilon<r\left(\frac{\frac{1}{q_{0}}-\frac{1}{q^{\prime}}}{\frac{1}{q^{\prime}}-\frac{1}{2}}\right)$.
Then $\theta(r-a)=\sqrt{i(r-a)} e^{i \frac{\pi}{2}(r-a)} \int \mathbb{P}(d \omega) \varphi(I d-L)^{-(r-a)} g$, so
$\left|\int \mathbb{P}(d \omega) \varphi(I d-L)^{-(r-a)} g\right| \leq C$
which implies: $(I d-L)^{-(r-a)} g \in L^{p^{\prime}}(\Omega)$ with $\frac{1}{p^{\prime}}+\frac{1}{q^{\prime}}=1$.
Finally: $\forall a \in] 0, r\left[\right.$ and $\forall p^{\prime}>2:(I d-L)^{a} f \in L^{p^{\prime}}(\Omega)$ then $f \in \mathbb{D}^{\infty}(\Omega)$.
Proposition 2..1. The O.U. operator commutes with the conditional expectation.
Proof. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space and $\mathcal{F}_{t}, t \in[0,1]$ be a filtration; $\forall \varphi \in \mathcal{F}_{t}$, grad being the Malliavin derivative and div its adjoint: $f \in \mathbb{D}^{\infty}(\Omega)$ :

& =-\int\left\langle\mathbb{E}\left[\operatorname{grad} \varphi \mid \mathcal{F}_{t}\right] \mathbb{1}_{[0, t]}(.), \operatorname{grad} f\right\rangle_{H} \mathbb{P}(d \omega) \\
& =-\int\left\langle\operatorname{grad} \mathbb{E}\left[\varphi \mid \mathcal{F}_{t}\right], \operatorname{grad} f\right\rangle_{H} \mathbb{P}(d \omega)
\end{aligned}
$$

$$
\begin{aligned}
& =+\int f \cdot \operatorname{div} \operatorname{grad} \mathbb{E}\left[\varphi \mid \mathcal{F}_{t}\right] \mathbb{P}(d \omega) \\
& =+\int \mathbb{E}\left[\varphi \mid \mathcal{F}_{t}\right] \operatorname{div} \operatorname{grad} f \mathbb{P}(d \omega) \\
& =+\int \varphi \mathbb{E}\left[\operatorname{div} \operatorname{grad} f \mid \mathcal{F}_{t}\right] \mathbb{P}(d \omega)
\end{aligned}

## 2. 3 Existence of a sequence of $\mathbb{D}^{\infty}$-vector fields converging $\mathbb{D}^{\infty}$-strongly to wards a derivation

Theorem 2..6. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space and $\left(e_{i}\right)_{i \in \mathbb{N}_{\star}}$ an Hilbertian basis of $H$; we denote by $\mathcal{F}_{n}$ the $\sigma$-algebra $\mathcal{F}_{n}=\sigma\left(W\left(e_{i}\right) / i \leq n\right)$. Let $\delta$ be a continuous derivation from $\mathbb{D}^{\infty}$ to $L^{\infty-0}$. Then the sequence of vector fields $X_{N}=\sum_{i=1}^{N} \mathbb{E}\left[\delta\left(W\left(e_{i}\right) \mid \mathcal{F}_{N}\right] e_{i}\right.$ strongly converges towards $\delta$ in $L^{\infty-0}(\Omega)$.

Proof. Let $f_{N, k}\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right), W\left(e_{N+1}\right), \ldots, W\left(e_{N+k}\right)\right]$ be a cylindrical function; $\xi_{1}, \ldots, \xi_{k}$ being parameters. We denote $f_{N, k, \xi}=f_{N, k}\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right), \xi_{1}, \ldots, \xi_{k}\right]$. Then:

$$
\left\|f_{N, k, \xi}\right\|_{\mathbb{D}_{s}^{q}}=\sum_{j=0}^{s}\left(\int\left\|\operatorname{grad}^{j} f_{N, k, \xi}\right\|_{\dot{j} H}^{q} \mathbb{P}(d \omega)\right)^{\frac{1}{q}}
$$

so:

$$
\begin{equation*}
\frac{1}{(\sqrt{2 \pi})^{k}} \int_{\mathbb{R}^{k}} d \xi_{1} \ldots d \xi_{k} e^{-\frac{1}{2} \sum_{i=1}^{k} \xi_{i}^{2}}\left\|f_{N, k, \xi}\right\|_{\mathbb{D}_{s}^{q}}^{q} \leq\left\|f_{N, k}\right\|_{\mathbb{D}_{s}^{q}}^{q} \tag{8}
\end{equation*}
$$

Let $\varphi \in \mathbb{D}^{\infty}(\Omega)$; there exists a sequence of cylindrical functions denoted $\varphi_{N, k}\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right), W\left(e_{N+1}\right), \ldots, W\left(e_{N+k}\right)\right]$ which $\mathbb{D}^{\infty}$-converges towards $\varphi$.

Then direct computation shows that $\forall q>1, \exists(p, s), p>1, s \in \mathbb{N}_{\star}$ such that there exists a constant $C(p, q, s)$ with $\left\|X_{N} \cdot \varphi_{N, k, \xi}\right\|_{L^{q}(\Omega)} \leq C(p, q, s)\left\|\varphi_{N, k, \xi}\right\|_{\mathbb{D}_{s}^{p}(\Omega)}$

We choose $p>q$. Then, using (8), we have:

\frac{1}{(\sqrt{2 \pi})^{k}} \int\left\|X_{N} \cdot \varphi_{N, k, \xi}\right\|_{L^{q}(\Omega)}^{p} e^{-\frac{1}{2} \sum_{i=1}^{k} \xi_{i}^{2}} d \xi_{1} \ldots d \xi_{k} \leq C^{p}(p, q, s)\left\|\varphi_{N, k}\right\|_{\mathbb{D}_{s}^{p}(\Omega)}^{p}
$$

The l.h.s. of the above inequality is bigger than:

\left[\frac{1}{(\sqrt{2 \pi})^{k}} \int\left\|X_{N} \cdot \varphi_{N, k, \xi}\right\|_{L^{q}(\Omega)}^{q} e^{-\frac{1}{2} \sum_{i=1}^{k} \xi_{i}^{2}} d \xi_{1} \ldots d \xi_{k}\right]^{\frac{p}{q}}=\left\|X_{N} \cdot \varphi_{N, k}\right\|_{L^{q}}^{p}
$$

So we have $\left\|X_{N} \cdot \varphi_{N, k}\right\|_{L^{q}(\Omega)} \leq C(p, q, s)\left\|\varphi_{N, k}\right\|_{\mathbb{D}_{s}^{p}}$
which implies:

\left\|X_{N} \cdot \varphi\right\|_{L^{q}(\Omega)} \leq C(p, q, s)\|\varphi\|_{\mathbb{D}_{s}^{p}} \tag{9}
\end{equation*}
$$

Then the triangle inequality

\left\|\delta \varphi-X_{N, k} \cdot \varphi\right\|_{L^{q}} & \leq\left\|\delta \varphi-\delta \varphi_{N, k}\right\|_{L^{q}}+\left\|\delta \varphi_{N, k}-\mathbb{E}\left[\delta \varphi_{N, k} \mid \mathcal{F}_{N+k}\right]\right\|_{L^{q}} \\
& +\left\|\mathbb{E}\left[\delta \varphi_{N, k} \mid \mathcal{F}_{N+k}\right]-X_{N+k} \cdot \varphi_{N, k}\right\|_{L^{q}}+\left\|X_{N+k} \cdot\left(\varphi_{N, k}-\varphi\right)\right\|_{L^{q}}
\end{aligned}
$$

with $\mathbb{E}\left[\delta \varphi_{N, k} \mid \mathcal{F}_{N+k}\right]=X_{N+k} \cdot \varphi_{N, k}$; and (9) shows that $X_{N} \rightarrow \delta$ and the convergence is $L^{\infty-0}$-strong from $\mathbb{D}^{\infty}$ in $L^{\infty-0}$.

Corollary 2..5. If $\delta$ is a continuous derivation from $\mathbb{D}^{\infty}(\Omega)$ to $L^{\infty-0}(\Omega)$, for each $f \in \mathbb{D}^{\infty}(\Omega)$, A being a measurable subset of $\Omega$, then $\mathbb{1}_{A} \operatorname{grad} f=0$ implies $\mathbb{1}_{A} \delta f=0$.

Proof. Let $X_{N}$ be the sequence of vector fields as in Theorem 2..6. Then from the hypothesis, we have: $\mathbb{1}_{A}\left(X_{N} \cdot f\right)=0$; and at the limit when $N \uparrow \infty$, we have $\mathbb{1}_{A} \delta f=0$.

Theorem 2..7. If $\delta$ is a continuous derivation of $\mathbb{D}^{\infty}(\Omega)$, there exists a sequence of vector fields $\tilde{X}_{N}$, which converges $\mathbb{D}^{\infty}$-strongly towards $\delta$.

Proof. Let $N$ be fixed and $X_{N}=\sum_{i=1}^{N} \mathbb{E}\left[\delta\left(W\left(e_{i}\right)\right) \mid \mathcal{F}_{N}\right] e_{i}$. If $f\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right)\right]$ is a cylindrical function, direct calculus shows that:

$$
X_{N} \cdot f\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right)\right]=\mathbb{E}\left[\delta f \mid \mathcal{F}_{N}\right]
$$

So $X_{N}$ is $\mathbb{D}^{\infty}$-continuous from $\mathbb{D}^{\infty}\left(\Omega, \mathcal{F}_{N}, \mathbb{P}\right)$ in itself. We extend $X_{N}$ to $\mathbb{D}^{\infty}\left(\Omega, \mathcal{F}_{N}, \mathbb{P}\right) \times \mathbb{D}^{\infty}\left(\Omega, \mathcal{F}_{N}^{\perp}, \mathbb{P}\right) \simeq \mathbb{D}^{\infty}(\Omega, \mathcal{F}, \mathbb{P})$ denoted $\tilde{X}_{N}$
as in Theorem 2, 2, i); $\tilde{X}_{N}$ is again $\mathbb{D}^{\infty}$-continuous and is a vector field. With Theorem 2, 2, ii), the sequence ( $\tilde{X}_{N}$ ) is $N$-uniformly bounded when the $\tilde{X}_{N}$ are considered as operators from $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega)$.

The convergence of $\tilde{X}_{N}$ towards $\delta$, strong convergence as operators, is obtained by: $\forall f \in \mathbb{D}^{\infty}, \forall(p, r), p>1, r \in \mathbb{N}_{\star}$ :

$$
\begin{aligned}
\left\|\delta f-\tilde{X}_{N} \cdot f\right\|_{\mathbb{D}_{r}^{p}} & \leq\left\|\delta f-\mathbb{E}\left[\delta f \mid \mathcal{F}_{N}\right]\right\|_{\mathbb{D}_{r}^{p}}+\left\|\mathbb{E}\left[\delta f \mid \mathcal{F}_{N}\right]-\mathbb{E}\left[\delta f_{N} \mid \mathcal{F}_{N}\right]\right\|_{\mathbb{D}_{r}^{p}}+\left\|\mathbb{E}\left[\delta f_{N} \mid \mathcal{F}_{N}\right]-X_{N} \cdot f_{N}\right\|_{\mathbb{D}_{r}^{p}} \\
& +\left\|X_{N} \cdot f_{N}-\tilde{X}_{N} \cdot f_{N}\right\|_{\mathbb{D}_{r}^{p}}+\left\|\tilde{X}_{N} \cdot\left(f_{N}-f\right)\right\|_{\mathbb{D}_{r}^{p}}
\end{aligned}
$$

$f_{N}$ being a sequence of cylindrical functions, with $f_{N}(\omega)=f_{N}\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right)\right]$, converging $\mathbb{D}^{\infty}$ towards $f$.

Definition 2..2. A process $X:[0,1] \times \Omega \rightarrow \mathbb{R}$ is said to be completely $\mathbb{D}^{\infty}$ iff: $\forall r \in \mathbb{R}$ :

$$
(1-L)^{r / 2} X \in L^{\infty-0}([0,1] \times \Omega, d t \otimes \mathbb{P}(d \omega))
$$

Lemma 2..1. i) The space of the completely $\mathbb{D}^{\infty}$-processes $\mathscr{S}$ is a Frechet space.
ii) If $F$ is a continuous linear map from $\mathscr{S}$ in $\mathscr{S}$, there is a unique continuous linear extension of $F$, denoted $\tilde{F}$, from the space of completely $\mathbb{D}^{\infty}$-processes with values in an Hilbert $\tilde{H}$, in itself.

Proposition 2..2. Some properties of the convolution and the fractionnal derivation:
$f$ being a function: $[0,1] \rightarrow \mathbb{R}$ with $f(0)=0$, we extend $f$ in $\tilde{f}$ by
$\left.\tilde{f}\right|_{\mathbb{R}_{-}}=\left.\tilde{f}\right|_{[2,+\infty}[=0$ and by an afine function on $[1,2]$ such that
$\tilde{f}(1)=f(1)$ and $\tilde{f}(2)=0$. Then, we denote by $\beta_{s}$ the function: $\mathbb{R} \rightarrow \mathbb{R}$ defined by: $\beta_{s}(x)=0, x \leq 0$ and $\beta_{s}(x)=\frac{1}{\Gamma(1-s)} \frac{1}{x^{s}}$ for $x>0$. Then:
i) If $f$ is $\alpha$-Hölderian, $\forall s$ with $0<s<\alpha<1, \tilde{f} \star \beta_{s} \in C^{1}(\mathbb{R})$
ii) $f$ being $\alpha$-Hölderian, we have: $\left(\tilde{f} \star \beta_{s}\right)^{\prime} \star \beta_{1-s}=f$.
iii) If $f$ is a $\mathbb{D}_{r}^{p}$-bounded process, $\tilde{f} \star \beta_{s}$ is $(1-s)-\mathbb{D}_{r}^{p}$-Hölderian (see Definition 2..3).
iv) The convolution of $\beta_{s}$ with an adapted process is again an adapted process.

## 2. $4 \mathbb{D}^{\infty}$-Hölderian process and divergence of a derivation

DEFINITION 2..3. A real-valued process $\Phi(t, \omega)$ will be said to be $\mathbb{D}^{\infty}-\alpha$-Hölderian iff: $\forall t \in[0,1], \forall t^{\prime} \in[0,1]: \forall(p, r), p>1, r \in \mathbb{N}_{\star}, \exists$ constant $C(p, r)$ such that:

$$
\sup _{t, t^{\prime}}\left\|\Phi\left(t^{\prime}, \omega\right)-\Phi(t, \omega)\right\|_{\mathbb{D}_{r}^{p}} \leq C(p, r)\left|t^{\prime}-t\right|^{\alpha}
$$

There is an analogous definition for a matrix-valued process.
TheOrem 2..8. Let $X:[0,1] \times \Omega \rightarrow \mathbb{R}$ be an $\mathbb{D}^{\infty}-\alpha$-Hölderian process. Then $\exists s, 0<s<1$ such that if $Y=\frac{d}{d t}\left[X \star \beta_{1-s}\right], X=Y \star \beta_{s}$, and $Y$ being a completely $\mathbb{D}^{\infty}$-process.

Definition 2..4. A $\mathbb{D}^{\infty}$-process defined on $[0,1] \times \Omega$ with values in the $n \times n$ matrices, will be said to be $\mathbb{D}^{\infty}$-bounded iff:
$\forall(p, r) p>1, r \in \mathbb{N}_{\star}, \exists C(p, r)>0$ such that:
$\sup _{t \in[0,1]}\|A(t, .)\|_{\mathbb{D}_{r}^{p}} \leq C(p, r)$, where $\|A(t, .)\|_{\mathbb{D}_{r}^{p}}$ denotes the $\mathbb{D}_{r}^{p}$-norm of any $n \times n$ matrix norm, which are all equivalent.

Lemma 2..2. Let $A$ be a $\mathbb{D}^{\infty}$-bounded matrix process. Then the process: $\Phi(t, \omega)=\int_{0}^{t} A d B, B$ being a n-valued Brownian motion, is $\frac{1}{2}-\mathbb{D}^{\infty}$-Hölderian.

Proof. $A$ being a $n \times n$ matrix, $\int_{t}^{t+h} A d B$ being a Skorokhod integral, we have: $\int_{t}^{t+h} A d B=\sqrt{h} \operatorname{div}\left(A \cdot X_{h}\right)$ where:
$X_{h}$ is the vector $X_{h}=s \rightarrow \frac{1}{\sqrt{h}} \int_{0}^{s} \sum_{i=1}^{n} \mathbb{1}_{[t, t+h]}(u) e_{i} d u,\left(e_{i}\right)_{i=1, \ldots, n}$ being the canonical basis of $\mathbb{R}^{n}$, because $A X_{h}$ is $\mathbb{D}^{\infty}(\Omega, H)$-bounded.

The operator div, being continuous:

$$
\exists C(p, r):\left\|\Phi\left(t^{\prime}, \omega\right)-\Phi(t, \omega)\right\|_{\mathbb{D}_{r}^{p}} \leq C(p, r) \sqrt{h}
$$

Definition 2..5. Let $\delta$ be a continuous derivation of $\mathbb{D}^{\infty}(\Omega)$.
i) an element $T$ in $\mathbb{D}^{-\infty}$ will be called divergence of $\delta$, denoted div $\delta$, iff: $\forall \varphi \in \mathbb{D}^{\infty}(\Omega):-\int \delta \varphi \mathbb{P}(d \omega)=+(\operatorname{div} \delta, \varphi)((\operatorname{div} \delta, \varphi)$ is the duality bracket).
ii) a continuous derivation $\delta$ of $\mathbb{D}^{\infty}(\Omega)$ is said to be an adapted derivation iff: $\forall$ adapted process $\Phi(t, \omega),(\delta \Phi)(t, \omega)$ is an adapted process.

Remark 2..1. If $U$ is a vector field, $\operatorname{div} U$ as in Definition $2 . .5$ coincides with the classical definition of divergence of a $\mathbb{D}^{\infty}$-vector field.

Remark 2..2. i) If $\operatorname{div} \delta=0$, then $\delta$ is $L^{2}$-antisymmetrical.
ii) $(\Omega, \mathcal{F}, \mathbb{P}, H)$ being a Gaussian space, if $A$ is a $n \times n$-A.M. matrix such that $\forall \varphi \in \mathbb{D}^{\infty}(\Omega), A \operatorname{grad} \phi \in \mathbb{D}^{\infty}(\Omega, H)$, then $\operatorname{div} A \operatorname{grad}$ is $a \mathbb{D}^{\infty}$-derivation, and $\operatorname{div}(\operatorname{div} A \operatorname{grad})=0$. Such an $A$ is called a multiplicator and they will be studied in Section 4.
Theorem 2..9. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space.
If $V(s, \omega): t \rightarrow \int_{0}^{t} \dot{h}(s, \omega) d s$ is $a \mathbb{D}^{\infty}$-vector field, then $t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s$ is a $\mathbb{D}^{\infty}$-vector field.

Proof. The O.U. operator commutes with the conditional expectation (Proposition 2.1) so:

$$
t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in \mathbb{D}_{\infty}^{2}(\Omega, H)
$$

Thanks to the Theorem 2.5, we only have to prove:

$$
t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in L^{\infty-0}(\Omega, H)
$$

We denote by $L_{a d}^{1+0}(\Omega, H)$ the set of $\mathbb{D}^{\infty}$-vector fields $Z(t, \omega)=\int_{0}^{t} \dot{Z}(s, \omega) d s$ such that $\dot{Z}(s, \omega)$ is an adapted process.

We have:
$\mathbb{E}\left[\langle V(., \omega), Z(., \omega)\rangle_{H}\right]<+\infty$. so:
$\mathbb{E}\left[\int_{0}^{1}\langle\dot{h}(s, \omega), \dot{Z}(s, \omega)\rangle_{\mathbb{R}^{n}} d s\right]=\mathbb{E}\left[\int_{0}^{1}\left\langle\mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right], \dot{Z}(s, \omega)\right\rangle_{\mathbb{R}^{n}} d s\right]<+\infty$
which implies that:

$$
\begin{equation*}
\mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] \in\left(L_{a d}^{1+0}(\Omega, H)\right)^{\star} \tag{10}
\end{equation*}
$$

Let $g \in L^{q}(\Omega)$ with $\frac{1}{2}+\frac{1}{q}<1$; then there exists $p^{\prime}$ with $1<p^{\prime}<2$ such that $u \rightarrow \int_{0}^{u} \mathbb{E}\left[g \mid \mathcal{F}_{s}\right] . \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in L^{p^{\prime}}(\Omega, H)$, because:

$$
\int \mathbb{P}(d \omega)\left[\int_{0}^{1} d s \mathbb{E}\left[g \mid \mathcal{F}_{s}\right]^{2} \cdot \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2}\right]^{\frac{p^{\prime}}{2}} \leq \int \mathbb{P}(d \omega)\left\{\sup _{s \in[0,1]} \mathbb{E}\left[g \mid \mathcal{F}_{s}\right]^{2} \int_{0}^{1} d s \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2}\right\}^{\frac{p^{\prime}}{2}}
$$

From the Doob inequality:

$$
\sup _{s \in[0,1]}\left|\mathbb{E}\left[g \mid \mathcal{F}_{s}\right]\right|^{2} \in L^{\frac{q}{2}}(\Omega)
$$

and: $\left[\int_{0}^{1} d s \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2}\right]^{\frac{1}{2}} \in L^{2}(\Omega)$, we have:

$$
\left[\int_{0}^{1} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2} d s\right]^{\frac{p^{\prime}}{2}} \in L^{\frac{2}{p^{\prime}}}(\Omega)
$$

And from: $\frac{1}{q}+\frac{1}{2}<1, \exists p^{\prime}$ with $\frac{1}{q / p^{\prime}}+\frac{1}{2 / p^{\prime}}=1,1<p^{\prime}<2$ and so for this $p^{\prime}$ we have:

\int \mathbb{P}(d \omega)\left[\int_{0}^{1} d s \mathbb{E}\left[g \mid \mathcal{F}_{s}\right]^{2} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2}\right]^{\frac{p^{\prime}}{2}}<+\infty
$$

which implies:

\begin{equation*}
t \rightarrow \int_{0}^{t} \mathbb{E}\left[g \mid \mathcal{F}_{s}\right] \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in L_{a d}^{1+0}(\Omega, H) \tag{11}
\end{equation*}
$$

To prove that the vector field $t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s$ belongs to $L^{\infty-0}(\Omega, H)$, we use an induction:
we have already $t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in L^{2}(\Omega, H)$. Let $g \in L^{q^{\prime}}(\Omega)$ with $\frac{1}{p}+\frac{1}{q^{\prime}}<1 ;$ Let $t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in L^{p}(\Omega, H) ;$ From (9) and (11), we get:

$$
\int \mathbb{P}(d \omega) \int_{0}^{1} d s \mathbb{E}\left[g \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2} \mid \mathcal{F}_{s}\right]<+\infty
$$

which implies:

\int \mathbb{P}(d \omega) g(\omega) \int_{0}^{1} d s \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2}<+\infty
$$

then: $\int_{0}^{1} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right]^{2} d s \in L^{p-0}(\Omega)$ and:
$t \rightarrow \int_{0}^{t} \mathbb{E}\left[\dot{h}(s, \omega) \mid \mathcal{F}_{s}\right] d s \in L^{2 p-0}(\Omega, H)$.

THEOREM 2..10. Let $V_{n}$ be a sequence of $\mathbb{D}^{\infty}$-vector fields such that the associated derivations $\delta_{n}$ are adapted and converge pointwise in $\mathbb{D}^{\infty}(\Omega)$ towards a derivation $\delta$ verifying $\operatorname{div} \delta=0$; then $\delta \equiv 0$.

Proof.

$$
\forall \varphi \in \mathbb{D}^{\infty}(\Omega): \int \delta_{n} \varphi \mathbb{P}(d \omega)=\int\left\langle V_{n}, \operatorname{grad} \varphi\right\rangle_{H} \mathbb{P}(d \omega)=-\int \varphi \operatorname{div} V_{n} \mathbb{P}(d \omega)
$$

which implies that $\int \varphi$ div $V_{n} \mathbb{P}(d \omega)$ converges towards
$-\int \varphi \operatorname{div} \delta \cdot \mathbb{P}(d \omega)=0$.
So $\forall V$ vector field $\in \mathbb{D}^{\infty}(\Omega, H): \int\left\langle\operatorname{grad}\left(\operatorname{div} V_{n}\right), V\right\rangle_{H} \mathbb{P}(d \omega)$ converges towards 0.

With Theorem $2 . .9, t \rightarrow \int_{0}^{t} \mathbb{E}\left[\operatorname{grad} \operatorname{div} V_{n} \mid \mathcal{F}_{s}\right] d s$ is also a $\mathbb{D}^{\infty}$-vector field, and an adapted process:
we have:

$$
\int\left\langle\mathbb{E}\left[\operatorname{grad} \operatorname{div} V_{n} \mid \mathcal{F}_{t}\right], V\right\rangle_{H} \mathbb{P}(d \omega)=\int\left\langle\operatorname{grad} \operatorname{div} V_{n}, \mathbb{E}\left[V \mid \mathcal{F}_{t}\right]\right\rangle_{H} \mathbb{P}(d \omega) \rightarrow 0
$$

But using the Clark-Ocone formula:

$$
\int_{0}^{1} \mathbb{E}\left[\operatorname{grad} \operatorname{div} V_{n} \mid \mathcal{F}_{t}\right] d B=\operatorname{div} V_{n}
$$

And $V_{n}$ being an adapted process, using a result on the Skorokhod integral: $\operatorname{div} V_{n}=\int_{0}^{1} V_{n} \cdot d B$, Itō Integral.

Then: $\mathbb{E}\left[\operatorname{grad} \operatorname{div} V_{n} \mid \mathcal{F}_{t}\right]=V_{n}$ and so $V_{n}$ is a sequence of $\mathbb{D}^{-\infty}$ which converges towards 0 . Then let $\varphi, \psi \in \mathbb{D}^{\infty}(\Omega): \varphi \operatorname{grad} \psi \in \mathbb{D}^{\infty}(\Omega, H)$ and:

$$
\begin{aligned}
\left(V_{n}, \varphi \operatorname{grad} \psi\right) & =\int \varphi(\omega)\left\langle V_{n}, \operatorname{grad} \psi\right\rangle_{H} \mathbb{P}(d \omega) \\
& =\int \varphi(\omega)\left(\delta_{n} \psi\right)(\omega) \mathbb{P}(d \omega) \rightarrow \int \varphi(\omega)(\delta \psi)(\omega) \mathbb{P}(d \omega)
\end{aligned}
$$

So $\int \varphi(\omega)(\delta \psi)(\omega) \mathbb{P}(d \omega)=0$ which implies $\delta=0$.
REMARK 2..3. A consequence of Theorem $2 . .10$ is that a $\mathbb{D}^{\infty}$ adapted derivation is not in general a limit of a sequence of $\mathbb{D}^{\infty}$-adapted vector fields.

DEFINITION 2..6. Let $\theta$ be a continuous map from $\mathbb{D}^{\infty}(\Omega)$ to $\mathbb{D}^{\infty}(\Omega)$. Then a linear map $\delta$ from $\mathbb{D}^{\infty}(\Omega)$ to $\mathbb{D}^{\infty}(\Omega)$ is said to be a $\theta$-derivation iff:

$$
\forall f, g \in \mathbb{D}^{\infty}(\Omega): \delta(f g)=\theta(f) \delta(g)+\theta(g) \delta(f)
$$

Now we state a version of the Dini-Lipschitz theorem for an Hölderian functon $f$, piecewise continuous, on a closed interval, with values in a Frechet space $F$.

## 2. 5 A generalisation of the Dimi-Lipschitz theorem and interpolation between $\mathbb{D}_{r}^{P}$ spaces

THEOREM 2..11. (Dini-Lipschitz) Let $f$ be a function as above. Then its Fourier series is uniformly convergent piecewise, that is on each closed interval on which it is continuous, and converges towards the half-value of the jump on each discontinuity point.

Moreover, the convergence of its Fourier series is uniformly bounded, relatively to the partial sums of the Fourier series.

Last, an interpolation theorem which will often be used:
THEOREM 2..12. Let $T$ be a linear continuous operator from $\mathbb{D}_{r}^{p}(\Omega)$ to $\mathbb{D}_{s}^{q}(\Omega)$, and $\mathbb{D}_{r^{\prime}}^{p^{\prime}}(\Omega)$ to $\mathbb{D}_{s^{\prime}}^{q^{\prime}}(\Omega) . \forall \alpha \in[0,1], T$ is continuous from $\mathbb{D}_{\alpha r+(1-\alpha) r^{\prime}}^{\left(\frac{\alpha}{p}+\frac{(1-\alpha)}{p^{\prime}}\right)^{-1}}$ to $\mathbb{D}_{\alpha s+(1-\alpha) s^{\prime}}^{\left(\frac{\alpha}{q}+\frac{(1-\alpha)}{q^{\prime}}\right)^{-1}}$.

## 3. $\mathbb{D}^{\infty}$-stochastic manifolds

In this section we study the general notion of a $\mathbb{D}^{\infty}$-stochastic manifold, and the following themes:
i) we will examine the notion of $\mathbb{D}^{\infty}$-equivalent atlases, which is more complex than in the case of $n$-dimensional differential manifolds
ii) we will exhibit a $\mathbb{D}^{\infty}$-chart change which does not admit a linear tangent map in $\mathcal{L}(H)$
iii) we will study the space of $\mathbb{D}^{\infty}$-continuous derivations on $\mathbb{D}^{\infty}(\Omega)$, denoted $\operatorname{Der}(\Omega)$ and its dual $\operatorname{Der}(\Omega)^{\star}\left(\right.$ denoted also $\left.\left(\operatorname{Der} \Omega^{\star}\right)\right)$
iv) we will study the notion of a derivation field on a $\mathbb{D}^{\infty}$-stochastic manifold.
v) we study then the notion of metric (this time on $\left.\operatorname{Der}(\Omega)^{\star}\right)$, and the fundamental metric; then an important subspace of $\operatorname{Der}(\Omega)$, denoted $\mathcal{D}_{0}(\Omega)$, the Levi-Civita connection, the curvature and the torsion.

When no particular setting is specified, we assume that the context is a Gaussian space $(\Omega, \mathcal{F}, \mathbb{P}, H)$.

## 3. 1 Definition

Let $\mathscr{S}$ be a set. The definitions of $\mathbb{D}^{\infty}$-charts, of two $\mathbb{D}^{\infty}$-compatible charts and of a $\mathbb{D}^{\infty}$-atlas, on $\mathscr{S}$ are direct generalisations of the $\mathbb{D}_{r}^{\infty}$ case. We first define the notion of canonical tribe on a set $\mathscr{S}$, endowed with a $\mathbb{D}^{\infty}$-atlas:

## 3. 2 Canonical $\sigma$-algebra associated to a $\mathbb{D}^{\infty}$-stochastic manifold

Proposition 3..1. Let $\mathscr{S}$ a $\mathbb{D}^{\infty}$-stochastic manifold with the atlas: $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}\right)_{i \in I}$. Then if

$$
\mathscr{C}_{1}=\left\{A \subset \mathscr{S} / \forall i \in I, b_{i}\left(A \cap U_{i}\right) \in \mathcal{F}_{i}\right\}
$$

and

$$
\mathscr{C}_{2}=\left\{A \subset \mathscr{S} / \forall A_{i} \in \mathcal{F}_{i}, b_{i}\left(A \cap b_{i}^{-1}\left(A_{i}\right)\right) \in \mathcal{F}_{i}\right\}
$$

we have $\mathscr{C}_{1}=\mathscr{C}_{2}$ and $\mathscr{C}_{1}$ is a $\sigma$-algebra.
Proof.
i) $\mathscr{C}_{2} \subset \mathscr{C}_{1}$ : let $A_{i}=\Omega$
ii) $\mathscr{C}_{1} \subset \mathscr{C}_{2}$ : let $A \in \mathscr{C}_{1}$,

$$
\begin{aligned}
b_{i}\left[A \cap b_{i}^{-1}\left(A_{i}\right)\right] & =b_{i}\left[A \cap\left(U_{i} \cap b_{i}^{-1}\left(A_{i}\right)\right)\right] \\
& =b_{i}\left[\left(A \cap U_{i}\right) \cap b_{i}^{-1}\left(A_{i}\right)\right] \\
& =b_{i}\left(A \cap U_{i}\right) \cap A_{i} \in \mathcal{F}_{i}
\end{aligned}
$$

iii) $\mathscr{C}_{1}$ is a $\sigma$-algebra: obvious.

We denote by $\mathscr{C}(\mathscr{S}, \mathscr{A})$ this $\sigma$-algebra, or in short $\mathscr{C}(\mathscr{S})$. We also denote by: $\mathscr{N}(\mathscr{S}, \mathscr{A})$ or by $\mathscr{N}(\mathscr{S})$ :

$$
\mathscr{N}(\mathscr{S}, \mathscr{A})=\left\{N \subset \mathscr{S} / \forall i \in I, \mathbb{P}_{i}\left[b_{i}\left(N \cap U_{i}\right)\right]=0\right\}
$$

The definition of $\mathscr{N}(\mathscr{S}, \mathscr{A})$ is meaningful thanks to the Lemma 1.2,iii: we know that if there is $i \in I$ such that $\mathbb{P}_{i}\left[b_{i}\left(A \cap U_{i}\right)\right]>0$, then $\forall j \in I: \mathbb{P}_{j}\left[b_{j}\left(A \cap U_{j}\right)\right]>0$.

## 3. $3 \mathbb{D}^{\infty}$-morphismes between $\mathbb{D}^{\infty}$-stochastic manifolds

Definition 3..1. $\mathscr{S}_{1}$ and $\mathscr{S}_{2}$ being two $\mathbb{D}^{\infty}$-stochastic manifolds, the map $\varphi: \mathscr{S}_{1} \rightarrow \mathscr{S}_{2}$ will be said to be measurable iff it is measurable relatively to the $\sigma$-algebra $\mathscr{C}\left(\mathscr{S}_{1}\right)$ and $\mathscr{C}\left(\mathscr{S}_{2}\right)$ and if $\varphi^{-1}\left[\mathscr{N}\left(\mathscr{S}_{2}\right)\right] \subset \mathscr{N}\left(\mathscr{S}_{1}\right)$.

Definition 3..2. Let $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right)_{i \in I}$, a $\mathbb{D}^{\infty}$-atlas on the set $\mathscr{S}_{1}$, and $\left(V_{\ell}, \widetilde{b}_{\ell}, \widetilde{\Omega}_{\ell}\right)_{\ell \in L}=\mathscr{B}$ a $\mathbb{D}^{\infty}$-atlas on the set $\mathscr{S}_{2}$; let $\varphi$ be a measurable map from $\mathscr{S}_{1}$ in $\mathscr{S}_{2}$.

The subset $A \subset U_{i}$ will be said to be $(\varphi, \mathscr{A}, \mathscr{B})$-balanced iff $A \in \mathcal{F}_{i}$, $\mathbb{P}_{i}(A)>0$ and $\exists \ell_{0} \in L$ such that: $\varphi(A) \subset V_{\ell_{0}}$ and $\forall f \in \mathbb{D}^{\infty}\left(\widetilde{\Omega}_{\ell_{0}}\right)$, then $\left.f \circ \widetilde{b}_{\ell_{0}} \circ \varphi \circ b_{i}^{-1}\right|_{b_{i}(A)}$ admits an extension, denoted $\widetilde{f}_{i, \ell_{0}, A}$, or $\widetilde{f}_{A}$ and $\widetilde{f}_{i, \ell_{0}, A} \in \mathbb{D}^{\infty}\left(\Omega_{i}\right)$. $A$ will also be said to be $\left(\varphi, U_{i}, V_{\ell_{0}}\right)$-balanced.

Remark 3..1. Using the $\mathbb{D}^{\infty}$-structure of the atlas $\mathscr{A}$, it is immediate to see that if $A$ is $\left(\varphi, U_{i}, V_{\ell_{0}}\right)$-balanced and if $A \subset U_{j}, j \neq i$, then $A$ is
$\left(\varphi, U_{j}, V_{\ell_{0}}\right)$-balanced. So this definition of the balanced set does not depend on the chart domain in $\mathscr{A}$, where $A$ lies.

REmARK 3..2. If $\mathscr{S}$ is a $\mathbb{D}^{\infty}$-stochastic manifold, with the atlas $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}\right)_{i \in I}$, and denoting $\operatorname{Id}_{\mathscr{S}}$ the identity on $\mathscr{S}$, we have that: for every $i, j \in I$ with $U_{i} \cap U_{j} \notin \mathscr{N}(\mathscr{S}, \mathscr{A}): U_{i} \cap U_{j}$ is a $\left(\operatorname{Id}_{\mathscr{S}}, U_{i}, U_{j}\right)$-balanced set of $\mathscr{S}$.

Now to simplify the notations, we identify the domain $U_{i}$ of a chart with its image on the Gaussian space $\left(\Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right)$ through the bijection $b_{i}$. So now $U_{i}$ is endowed with the $\sigma$-algebra $b_{i}^{-1}\left(\mathcal{F}_{i}\right)$ which is also the restriction to $U_{i}$ of $\mathscr{C}(\mathscr{S}, \mathscr{A})$, and with a probability measure $\left(b_{i}^{-1}\right)_{*} \mathbb{P}_{i}$. So the property of a balanced subset of $U_{i}, A$, can be restated: $\forall f \in \mathbb{D}^{\infty}\left(V_{\ell_{0}}\right),\left.\quad f \circ \varphi\right|_{A}$ admits an extension denoted $\widetilde{f}_{A}$, with $\widetilde{f}_{A} \in \mathbb{D}^{\infty}\left(U_{i}\right)$. If $A \subset U_{i}$, we denote by $L^{0}(A)$ the $\mathbb{R}$-valued functions on $A$, measurable relatively to the $\sigma$-algebra $b_{i}^{-1}\left(\mathcal{F}_{i}\right)$

Definition 3..3. Let $\mathscr{S}_{1}$ and $\mathscr{S}_{2}$ two $\mathbb{D}^{\infty}$-stochastic manifolds, $\mathscr{S}_{1}$ being endowed with a $\mathbb{D}^{\infty}$-atlas $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right)_{i \in I}$ and $\mathscr{S}_{2}$ being endowed with the $\mathbb{D}^{\infty}$-atlas $\mathscr{B}=\left(V_{\ell}, \widetilde{b}_{\ell}, \widetilde{\Omega}_{\ell}\right)_{\ell \in L}$. Let $\varphi$ be a map from $\mathscr{S}_{1}$ to $\mathscr{S}_{2}, \varphi$ will be said to be a $\mathbb{D}^{\infty}$-morphism from $\mathscr{S}_{1}$ to $\mathscr{S}_{2}$, iff:
i) $\varphi$ is measureable with respect to the canonical $\sigma$-algebras on $\mathscr{S}_{1}$ and $\mathscr{S}_{2}$;
ii) $\forall i \in I$, there is a countable set of indices, denoted $L_{i}, L_{i} \subset L$, such that $U_{i} \in \bigcup_{\ell \in L_{i}} \varphi^{-1}\left(V_{\ell}\right)$;
iii) $\forall i \in I, \forall \ell \in L$ with $\mathbb{P}_{i}\left[\varphi^{-1}\left(V_{\ell}\right) \cap U_{i}\right]>0$ and $\forall A \in \mathcal{F}_{i}$, with $A \subset \varphi^{-1}\left(V_{\ell}\right) \cap U_{i}$ and $\mathbb{P}_{i}(A)>0: \exists A^{\prime} \subset A, A^{\prime} \in \mathcal{F}_{i}, \mathbb{P}_{i}\left(A^{\prime}\right)>0$ such that $A^{\prime}$ is $\left(\varphi, U_{i}, V_{\ell}\right)$-balanced;
iv) $\forall A \subset U_{i}, A \in \mathcal{F}_{i}, \mathbb{P}_{i}(A)>0$ and $\forall g \in L^{0}(A)$ if $\forall A_{\ell},\left(\varphi, U_{i}, V_{\ell}\right)$-balanced, there exists $f_{\ell} \in \mathbb{D}^{\infty}\left(V_{\ell}\right)$ such that $\left.f_{\ell} \circ \varphi\right|_{A \cap A_{\ell}}=\left.g\right|_{A \cap A_{\ell}}$, then $g$ admits an extension $\widetilde{g}$ such that $\widetilde{g} \in \mathbb{D}^{\infty}\left(U_{i}\right)$.

Remark 3..3. From iii) we see that $\forall i \in I, \exists \ell(i) \in L$ such that $\mathbb{P}_{i}\left[\varphi^{-1}\left(V_{\ell(i)}\right) \cap U_{i}\right]>0$ otherwise $\mathbb{P}_{i}\left[\bigcup_{\ell \in L_{i}} \varphi^{-1}\left(V_{\ell}\right) \cap U_{i}\right]=\mathbb{P}_{i}\left(U_{i}\right)=0$. And we also have that $\forall A \in$ $\mathcal{F}_{i}, A \subset \varphi^{-1}\left(V_{\ell(i)}\right) \cap U_{i}$ and $\mathbb{P}_{i}(A)>0$, there exists a countable subset of $L$ denoted $L_{\ell(i)}$ and a family of $\left(\varphi, U_{i}, V_{j_{i}}\right)_{j_{i} \in L_{\ell(i)}}$-balanced sets $\varepsilon_{j_{i}}$, such that they form a partition of $A$. And there exists a countable subset of $L, L_{0}$, such that:

$$
U_{i}=\bigcup_{i \in L_{0}}\left(\bigcup_{j_{i} \in L_{\ell(i)}} \varepsilon_{j_{i}}\right)
$$

with $\mathbb{P}_{i}\left(\varepsilon_{j_{i}} \cap \varepsilon_{j_{k}}\right)=0, \forall j_{i} \in L_{\ell(i)}$ and $\forall j_{k} \in L_{\ell(k)}$.
Proposition 3..2. The composition of $\mathbb{D}^{\infty}$-morphisms is a $\mathbb{D}^{\infty}$-morphism.
Proof. Let $\mathscr{S}_{1}, \mathscr{S}_{2}, \mathscr{S}_{3}$ be three $\mathbb{D}^{\infty}$-stochastic manifolds with respectively the $\mathbb{D}^{\infty}$-atlases

$$
\mathscr{A}=\left(U_{i}\right)_{i \in I}, \quad \mathscr{B}=\left(V_{j}\right)_{j \in J}, \quad \mathscr{C}\left(W_{k}\right)_{k \in K}
$$

and $\varphi_{1}$ a $\mathbb{D} " \infty$-morphism from $\mathscr{S}_{1}$ to $\mathscr{S}_{2}$, and $\varphi_{2}$ a $\mathbb{D}^{\infty}$-morphism from $\mathscr{S}_{2}$ to $\mathscr{S}_{3}$.
i) and ii) are trivially verified by $\varphi_{2} \circ \varphi_{1}\left(\varphi_{2} \circ \varphi_{1}\right.$ is measurable);
iii) Let $i_{0} \in I$ and $k \in K$. We have to prove that for $A \subset \varphi_{1}^{-1} \circ \varphi_{2}^{-1}\left(W_{k}\right) \cap U_{i_{0}}$, $A \in \mathcal{F}_{i_{0}}, \mathbb{P}_{i_{0}}\left(A_{i_{0}}\right)>0 \exists A^{\prime} \subset A, A^{\prime} \in \mathcal{F}_{i_{0}}, \mathbb{P}_{i_{0}}\left(A^{\prime}\right)>0$ such that $A^{\prime}$ is $\left(\varphi_{2} \circ \varphi_{1}, U_{i_{0}}, W_{k}\right)$ balanced. Without loss of generality, we can suppose $\exists j_{0} \in J$ such that $\varphi_{1}(A) \subset V_{j_{0}}$. Then, $\varphi_{2}$ being a $\mathbb{D}^{\infty}$-morphism, there exists $B \subset \varphi_{1}(A), B$ being $\left(\varphi_{2}, V_{j_{0}}, W_{k}\right)$-balanced (and $\left.\mathbb{P}_{j_{0}}(B)>0\right)$. So for $g \in \mathbb{D}^{\infty}\left(W_{k}\right)$ there exists an extension of $\left.g \circ \varphi_{2}\right|_{B}$, denoted $\widetilde{g}$, such that $\widetilde{g} \in \mathbb{D}^{\infty}\left(V_{j_{0}}\right)$. But $\varphi_{1}$ being a $\mathbb{D}^{\infty}$-morphism, there exists a subset $A^{\prime}$ of $\varphi_{1}^{-1}(B)$ (remind $\left.\mathbb{P}_{i_{0}}\left(\varphi_{1}^{-1}(B)\right)>0\right)$, which is $\left(\varphi_{1}, U_{i_{0}}, V_{j_{0}}\right)$-balanced. So $\left.\widetilde{g} \circ \varphi_{1}\right|_{A^{\prime}}=\left.g \circ \varphi_{2} \circ \varphi_{1}\right|_{A^{\prime}}$, and there exists an extension of $\left.\widetilde{g} \circ \varphi_{1}\right|_{A^{\prime}}$ ( $A^{\prime}$ is a $\left(\varphi_{1}, U_{i_{0}}, V_{j_{0}}\right)$-balanced subset $)$, denoted $\widehat{g}$, which is $\in \mathbb{D}^{\infty}\left(U_{i_{0}}\right)$; and $\widehat{g}$ is an extension of $\left.g \circ \varphi_{2} \circ \varphi_{1}\right|_{A^{\prime}}$
iv) We have to show that if $i_{0} \in I$ and $A \subset U_{i_{0}}, A \in \mathcal{F}_{i_{0}}, \mathbb{P}_{i_{0}}(A)>0$ and $g \in L^{0}(A)$; We suppose that $\forall A_{i_{0} k},\left(\varphi_{2} \circ \varphi_{1}, U_{i_{0}}, W_{k}\right)$-balanced set there exists $f \in \mathbb{D}^{\infty}\left(W_{k}\right)$ such that

$$
\left.f \circ \varphi_{2} \circ \varphi_{1}\right|_{A \cap A_{i_{0} k}}=\left.g\right|_{A \cap A_{i_{0} k}}
$$

Then we must show that $g$ admits an extension $\widetilde{g}$ such that $\widetilde{g} \in \mathbb{D}^{\infty}\left(U_{i_{0}}\right)$ and $\left.\widetilde{g}\right|_{A}=g$. As in iii) we can suppose without loss of generality that there exists $j_{0} \in J$ such that $\varphi_{1}(A) \subset V_{j_{0}}$. We know, from Remark 3.3, that there exists a countable partition of $V_{j_{0}}$ made with $\left(\varphi_{2}, V_{j_{0}}, W_{k}\right)$-balanced sets, denoted here $\left(\varepsilon_{\alpha}\right)_{\alpha \in \mathbb{N}_{*}}$, such that

$$
\mathbb{P}_{j_{0}}\left[V_{j_{0}} \backslash \bigcup_{\alpha \in \mathbb{N}_{*}} \varepsilon_{\alpha}\right]=0
$$

We define then $\left.h_{\alpha}\right|_{\varepsilon_{\alpha}}=\left.f \circ \varphi_{2}\right|_{\varepsilon_{\alpha}}$ and 0 on $\complement \varepsilon_{\alpha}$. Then $h_{\alpha} \in L^{0}\left(V_{j_{0}}\right)$; and $h=\sum_{\alpha=1}^{\infty} \mathbf{1}_{\varepsilon_{\alpha}} h_{\alpha} \in J^{0}\left(V_{j_{0}}\right) . \quad \forall B_{j_{0} k},\left(\varphi_{2}, V_{j_{0}}, W_{k}\right)$-balanced set, there exists a countable extracted partition of the $\left(\varepsilon_{\alpha}\right)_{\alpha \in \mathbb{N}_{*}}$, denoted $\left(\varepsilon_{\beta}\right)_{\beta \in \mathbb{N}_{*}}$, such that $B_{j_{0} k}=\bigcup_{\beta \in \mathbb{N}_{*}} \varepsilon_{\beta}, \mathbb{P}_{j_{0}}$-a.s. Then:

$$
\begin{aligned}
\left.h\right|_{V_{j_{0}} \cap B_{j_{0} k}} & =\left.h\right|_{B_{j_{0}} k} \\
& =\left.h\right|_{\beta \in \mathbb{N}_{*}} \varepsilon_{\beta} \\
& =\sum_{\beta \in \mathbb{N}_{*}} \mathbf{1}_{\beta} h_{\beta} \\
& =\left.\sum_{\beta \in \mathbb{N}_{*}} f \circ \varphi_{2}\right|_{\varepsilon_{\beta}} \\
& =\left.f \circ \varphi_{2}\right|_{B_{j_{0} k}}
\end{aligned}
$$

$\varphi_{2}$ being a $\mathbb{D}^{\infty}$-morphism, there exists an extension $\tilde{h}$ of $h$ which is $\in \mathbb{D}^{\infty}\left(V_{j_{0}}\right)$. Then:

$$
\begin{aligned}
\left.g\right|_{A \cap A_{i_{0} k}} & =\left.f \circ \varphi_{2} \circ \varphi_{1}\right|_{A \cap A_{i_{0} k}} \\
& =\left.f \circ \varphi_{2}\right|_{\varphi_{1}\left(A \cap A_{i_{0} k}\right)} \\
& =\left.\widetilde{h}\right|_{\varphi_{1}\left(A \cap A_{i_{0} k}\right)}
\end{aligned}
$$

This last equality being $\mathbb{P}_{j_{0}}$-a.s. As $A \cap A_{i_{0} k} \subset \varphi^{-1}\left[\varphi\left(A \cap A_{i_{0} k}\right)\right]$, we have $\left.g\right|_{A \cap A_{i_{0} k}}=\left.\widetilde{h} \circ \varphi_{1}\right|_{A \cap A_{i_{0} k}}, \mathbb{P}_{i_{0}-\text { a.s. and }} \widetilde{h} \in \mathbb{D}^{\infty}\left(V_{j_{0}}\right)$.
$\varphi_{1}$ being a $\mathbb{D}^{\infty}$-morphism, with iv) we have that there exists an extension $\widetilde{g} \in \mathbb{D}^{\infty}\left(U_{i_{0}}\right)$ such that $\left.\widetilde{g}\right|_{A}=\left.g\right|_{A}$. So $\varphi_{2} \circ \varphi_{1}$ is a $\mathbb{D}^{\infty}$-morphism.

## Definition 3..4.

i) Two $\mathbb{D}^{\infty}$-atlases on the set $\mathscr{S}$ are said to be $\mathbb{D}^{\infty}$ equivalent iff the identity $\operatorname{Id}_{\mathscr{S}}$ is a $\mathbb{D}^{\infty}$-isomorphism;
ii) Let $\mathscr{S}$ be a $\mathbb{D}^{\infty}$-stochastic manifold with the $\mathbb{D}^{\infty}$-atlas $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}\right)_{i \in I}$; the chart $(U, b, \Omega, \mathcal{F}, \mathbb{P}, H)$, with $U \subset \mathscr{S}$ is said to be $\mathbb{D}^{\infty}$-compatible with $\mathscr{A}$, if the atlases $\mathscr{A}$ and $\mathscr{A} \cup\{(U, b, \Omega)\}$ are equivalent.

Remark 3..4. We will here give the Definition 3.3.iv. but without identifying the domain $U$ of a chart $(U, b, \Omega)$ with $\Omega: \forall A \in \Omega, A \in \mathcal{F}_{i}, \mathbb{P}_{i}(A)>0$ and $\forall g \in L^{0}(A):$ If $\forall A_{\ell},\left(\varphi, U_{i}, V_{\ell}\right)$-balanced set, there exists $f_{\ell} \in \mathbb{D}^{\infty}\left(\widetilde{\Omega}_{\ell}\right)$ such that $\left.f \circ \widetilde{b}_{\ell} \circ \varphi \circ b_{i}^{-1}\right|_{A \cap b_{i}\left(A_{\ell}\right)}=\left.g\right|_{A \cap b_{i}\left(A_{\ell}\right)}$ then $g$ admits an extension $\widetilde{g} \in \mathbb{D}^{\infty}\left(\Omega_{i}\right)$.

Remark 3..5. If the $\mathbb{D}^{\infty}$-atlas $\mathscr{A}$ verifies the condition iv) of the Definition 3.3, then $\mathbb{D}^{\infty}$-compatibility between two charts of $A$ is equivalent to: $\forall \varphi \in \mathbb{D}^{\infty}\left(\Omega_{i}\right)$, $\exists$ an extension $\widetilde{\varphi} \in \mathbb{D}^{\infty}\left(\Omega_{j}\right)$ of $\left.\varphi \circ b_{i j}\right|_{b_{i}\left(U_{i} \cap U_{j}\right)}$, and moreover this extension is unique.

Now we will show that there exists a derivation from $\mathbb{D}^{\infty}(\Omega)$ to $\mathbb{D}^{\infty}(\Omega)$ which is not a vector field so to prove after this, that there are $\mathbb{D}^{\infty}$-charts, $\mathbb{D}^{\infty}$-compatible, which do have linear tangent maps.

## 3. 4 Existence of a $\mathbb{D}^{\infty}$-derivation which is not a vector field

Let $\mathscr{S}$ be a $\mathbb{D}^{\infty}$-stochastic manifold, with an atlas having only one chart $(\Omega, \mathcal{F}, \mathbb{P}, H)$. Let $\left\{\left(e_{i}\right)_{i \in \mathbb{N}_{*}},\left(\varepsilon_{j}\right)_{j \in \mathbb{N}_{*}}\right\}$ be a Hilbert basis of $H$ and let $A$ be the bounded operator on $H$ defined by:

$$
A\left(e_{i}\right)=\varepsilon_{i} \quad \text { and } \quad A\left(\varepsilon_{j}\right)=-e_{j}
$$

We denote by $\delta$ the operator on $\mathbb{D}^{\infty}(\Omega)$ defined by:

$$
\forall \varphi \in \mathbb{D}^{\infty}(\Omega), \quad \delta \varphi=\operatorname{div} A \operatorname{grad} \varphi
$$

Then direct computation shows that $\delta$ is a derivation. If there existed a $\mathbb{D}^{\infty}$-vector field $X$ such that

$$
\forall \varphi \in \mathbb{D}^{\infty}(\Omega), \quad X \cdot \varphi=\operatorname{div} A \operatorname{grad} \varphi=\delta \varphi
$$

then we write:

$$
X=\sum_{i \geq 1} X^{i} e_{i}+\sum_{j \geq 1} Y^{j} \varepsilon_{j}
$$

and we would have

$$
\begin{aligned}
X_{i} & =X \cdot W\left(e_{i}\right)=\delta\left(W\left(e_{i}\right)\right)=W\left(\varepsilon_{i}\right) \\
\text { and } Y_{j} & =X \cdot W\left(\varepsilon_{j}\right)=\delta\left(W\left(\varepsilon_{j}\right)\right)=-W\left(e_{j}\right)
\end{aligned}
$$

But

$$
\begin{aligned}
\sum_{i, j}\left(\int_{\Omega} X_{i}^{2} \mathbb{P}(\mathrm{~d} \omega)+\int_{\Omega} Y_{j}^{2} \mathbb{P}(\mathrm{~d} \omega)\right) & =\sum_{i, j}\left(\int_{\Omega} W\left(\varepsilon_{j}\right)^{2} \mathbb{P}(\mathrm{~d} \omega)+\int_{\Omega} W\left(e_{i}\right)^{2} \mathbb{P}(\mathrm{~d} \omega)\right) \\
& =+\infty
\end{aligned}
$$

Now we can prove that there exists compatible $\mathbb{D}^{\infty}$-charts for which, the change maps do not admit a linear tangent map. Let $\mathscr{S}_{1}$ be a $\mathbb{D}^{\infty}$-stochastic manifold with an atlas reduced to one chart $(\Omega, \mathcal{F}, \mathbb{P}, H)$ and $\left\{\left(e_{i}\right)_{i \in \mathbb{N}_{*}},\left(\varepsilon_{j}\right)_{j \in \mathbb{N}_{*}} h\right\}$ a Hilbert basis of $H$. Denote $X_{i}=W\left(e_{i}\right), Y_{j}=W\left(\varepsilon_{j}\right)$ and $Z=h$. We define an inversible map $\psi$ by:

$$
\begin{array}{rlrl}
\bar{X}_{i} & =X_{i} \cos Z+Y_{i} \sin Z & X_{i} & =\bar{X}_{i} \cos \bar{Z}-\bar{Y}_{i} \sin \bar{Z} \\
\bar{Y}_{i} & =-X_{i} \sin Z+Y_{i} \cos Z & Y_{i} & =\bar{X}_{i} \sin \bar{Z}+\bar{Y}_{i} \cos \bar{Z} \\
\bar{Z} & =Z & Z & =\bar{Z}
\end{array}
$$

The system $\left(\bar{X}_{i}, \bar{Y}_{j}, \bar{Z}\right)$ is a Gaussian system and has the same laws as the system $\left(X_{i}, Y_{j}, Z\right)$. We define an isometric morphism again denoted $\psi$, from a dense domain of $L^{\infty-0}$ to $L^{\infty-0}$ by:

$$
\forall n \in \mathbb{N}_{*}, \text { if } f \in \mathscr{S}\left(\mathbb{R}^{2 n+1}\right), \quad(\psi f)(\bar{X}, \bar{Y}, \bar{Z})=f(\psi(X), \psi(Y), \psi(Z))
$$

$\mathscr{S}\left(\mathbb{R}^{2 n+1}\right)$ being the set of fast decreasing functions.
This morphism preverses laws, so it can be extended to a bijective and isometric map from $L^{\infty-0}(\Omega)$ into $L^{\infty-0}(\Omega)$. $L$ and $\bar{L}$ being the O.U. operator respectively in the charts $(\Omega, \mathcal{F}, \mathbb{P}, H)$ and $(\Omega, \overline{\mathcal{F}}, \overline{\mathbb{P}}, \bar{H})$, we have:

$$
\begin{align*}
\psi^{-1} \circ \bar{L}(\psi f) & =L f+\psi^{-1} \circ \frac{\partial^{2}(\psi f)}{\partial \bar{Z}^{2}}-\psi^{-1} \circ\left(\bar{Z} \frac{\partial(\psi f)}{\partial \bar{Z}}\right) \\
& =L f+\left(\psi^{-1} \circ \frac{\partial}{\partial \bar{Z}} \circ \psi\right) \circ\left(\psi^{-1} \circ \frac{\partial}{\partial \bar{Z}} \circ \psi f\right)-\psi^{-1}\left(\bar{Z} \frac{\partial(\psi f)}{\partial \bar{Z}}\right) \tag{1}
\end{align*}
$$

And

$$
\begin{aligned}
\psi^{-1} \circ \frac{\partial}{\partial \bar{Z}}(\psi f) & =\sum_{i=1}^{n} X_{i} \frac{\partial f}{\partial Y_{i}}-Y_{i} \frac{\partial f}{\partial X^{i}}+\frac{\partial f}{\partial Z} \\
& =\operatorname{div} A_{n} \operatorname{grad} f+\frac{\partial f}{\partial Z}
\end{aligned}
$$

where $A_{n}$ is the determinist operator defined by $A_{n}\left(e_{i}\right)=\varepsilon_{i}, A_{n}\left(\varepsilon_{i}\right)=-e_{i}$, $1, \ldots, n$. If we denote by $\operatorname{div} A_{n} \operatorname{grad}$ by $\delta_{n}$ we have

$$
\begin{aligned}
\psi^{-1} \circ \frac{\partial}{\partial \bar{Z}}(\psi f) & =\delta_{n} f+\frac{\partial f}{\partial Z} \\
& =\operatorname{div} A \operatorname{grad} f+\frac{\partial f}{\partial Z}
\end{aligned}
$$

where $A$ is the bounded operator on $H$ such that $A\left(e_{i}\right)=\varepsilon_{i}, A\left(\varepsilon_{j}\right)=-e_{j}$, and $A(h)=h$. Now we show by induction that $\psi$ sends $\mathbb{D}^{\infty}$ in $\mathbb{D}^{\infty}$. We know already that $\psi$ sends $\mathbb{D}^{\infty}$ in $L^{\infty-0}$. Suppose that $\psi: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{r}^{\infty}$, let $f \in \mathbb{D}^{\infty}(\Omega)$. From (1), we see that, as div $A \operatorname{grad} f \in \mathbb{D}^{\infty}$ and $\left(\psi^{-1} \frac{\partial}{\partial \bar{Z}} \psi\right)(f)$ is also $\in \mathbb{D}^{\infty}$ : $\left(\psi^{-1} \circ \bar{L} \circ \psi\right) f \in \mathbb{D}^{\infty}$ so $(\bar{L} \circ \psi)(f) \in \mathbb{D}_{r}^{\infty}$ which implies that $\psi \in \mathbb{D}_{r+2}^{\infty}$. And we have seen previously that div $A$ grad is a derivation which cannot be a vector field. But if the linear tangent map of $\psi$ existed we would have

$$
T_{p s i} \frac{\partial}{\partial \bar{Z}}=\psi^{-1} \circ \frac{\partial}{\partial \bar{Z}} \psi
$$

Now we study the sets $\operatorname{Der}(\Omega)$ and $\operatorname{Der}(\Omega)^{*}$.
Definition 3..5. Given a Gaussian space $(\Omega, \mathcal{F}, \mathbb{P}, H)$, we denote $\operatorname{Der}(\Omega)$ the set of $\mathbb{D}^{\infty}$-continuous derivations from $\mathbb{D}^{\infty}(\Omega)$ to $\mathbb{D}^{\infty}(\Omega)$.
$\operatorname{Der}(\Omega)$ is then a non-metrisable topological space when endowed with the single point convergence.

Definition 3..6. A subset $A$ of $\operatorname{Der}(\Omega)$ is said to be bounded or $\operatorname{Der}-$ bounded iff $\forall(p, q), \exists(q, s),\left(p, q>1 ; r, s \in \mathbb{N}_{*}\right), \forall \mathbb{D}^{\infty}$-bounded subset $D \subset \mathbb{D}^{\infty}(\Omega)$, $\exists C(p, q, s, r, s, D)$ a constant such that

$$
\forall f \in D, \quad \sup _{\delta \in A}\|\delta f\|_{\mathbb{D}_{r}^{p}} \leq C(p, q, r, s, D)\|f\|_{\mathbb{D}_{s}^{q}}
$$

Definition 3..7. We denote by $\operatorname{Der}(\Omega)^{*}$ the set of $\mathbb{D}^{\infty}$-linear maps on $\operatorname{Der}(\Omega)$ which are verifying this continuity property: let $A$ be a bounded set in $\operatorname{Der}(\Omega)$, and $\left(\delta_{i}\right)_{i \in I}$ a net in A, converging towards $\delta \in \operatorname{Der}$. Then for $u \in \operatorname{Der}(\Omega)^{*}$, the net $\left(u\left(\delta_{i}\right)\right)_{i \in I}$ converges $\mathbb{D}^{\infty}$ towards $u(\delta)$.

Definition 3..8. A subset $\left(\alpha_{i}\right)_{i \in I}$ of $\operatorname{Der}(\Omega)^{*}$ is said to be bounded iff for each bounded subset $A \subset \operatorname{Der}(\Omega), \sup _{i \in I}\left|\alpha_{i}(A)\right|<+\infty$.

Lemma 3..1. Let $u \in \operatorname{Der}(\Omega)^{*}$. Then $\forall$ bounded subset $A$ of $\operatorname{Der}(\Omega)$, the set $\{u(\delta) / \delta \in A\}$ is $\mathbb{D}^{\infty}$-bounded in $\mathbb{D}^{\infty}(\Omega)$.

Proof. Suppose $\exists A$ subset bounded in $\operatorname{Der}(\Omega), \exists(p, r), p>1, r \in \mathbb{N}_{*}$ and $\exists \delta_{n} \in A$ such that $\left\|u\left(\delta_{n}\right)\right\|_{\mathbb{D}_{r}^{p}}>n$. Let $\alpha_{n}$ a sequence of numbers $>0$, which converges towards 0 . Then $\left\{\alpha_{n} \delta_{n} / n \in \mathbb{N}_{*}\right\}$ is bounded in $\operatorname{Der}(\Omega)$ and $\alpha_{n} \delta_{n} \rightarrow 0$ in Der so $u\left(\alpha_{n} \delta_{n}\right) \rightarrow 0$ which is contradictory.

Remark 3..6. If $\left(f_{i}\right)_{i \in I}$ is a $\mathbb{D}^{\infty}$-bounded family of $\mathbb{D}^{\infty}(\Omega)$, then $\left(\operatorname{grad} f_{i}\right)_{i \in I}$ is a bounded family in $\operatorname{Der}(\Omega)$.

## 3. 5 Derivation field on a $\mathbb{D}^{\infty}$-stochastic manifold

Given a $\mathbb{D}^{\infty}$-stochastic manifold, endowed with the atlas $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}\right)_{i \in I}$, a family of $\mathbb{D}^{\infty}$-continuous derivations $\delta_{i} \in \operatorname{Der}\left(\Omega_{i}\right), i \in I$, is said to be a $\mathbb{D}^{\infty}$-derivation field on $\mathscr{S}$ iff $\forall(i, j) \in I^{2}$ and $\forall f \in \mathbb{D}^{\infty}\left(\Omega_{j}\right)$ :

$$
\left.\delta_{j} f\right|_{b_{j}\left(U_{i} \cap U_{j}\right)}=\left.\delta_{i}\left(\widetilde{f \circ b_{i j}}\right)\right|_{b_{i}\left(U_{i} \cap U_{j}\right)} \circ b_{j i}
$$

$b_{i j}$ and $b_{j i}$ being the $\mathbb{D}^{\infty}$-chart changes between the charts $\left(U_{i}, b_{i}, \Omega_{i}\right)$ and $\left(U_{j}, b_{j}, \Omega_{j}\right), \overline{f \circ b_{i j}}$ being a $\mathbb{D}^{\infty}$-extension of $\left.f \circ b_{i j}\right|_{b_{i}\left(U_{i} \cap U_{j}\right)}$.

This definition is legitimate: If ${\overline{f \circ b_{i j}}}^{(1)}$ and ${\overline{f \circ b_{i j}}}^{(2)}$ are two extensions on $\mathbb{D}^{\infty}\left(\Omega_{i}\right)$, of $\left.f \circ b_{i j}\right|_{b_{i}\left(U_{i} \cap U_{j}\right)}$, we have:

$$
\left.\left({\widehat{f \circ b_{i j}}}^{(1)}-{\widehat{f \circ b_{i j}}}^{(2)}\right)\right|_{b_{i}\left(U_{i} \cap U_{j}\right)}=0
$$

So with Corollary 2.5, we have:

$$
\left.\delta_{i}\left({\widehat{f \circ b_{i j}}}^{(1)}\right)\right|_{b_{i}\left(U_{i} \cap U_{j}\right)}=\left.\delta_{i}\left({\widehat{f \circ b_{i j}}}^{(2)}\right)\right|_{b_{i}\left(U_{i} \cap U_{j}\right)}
$$

Now, using the definition of an admissible $\mathbb{D}^{\infty}$-chart to a $\mathbb{D}^{\infty}$-atlas, we prove that the definition of a derivation field is consistent, that is: we can build on this $\mathbb{D}^{\infty}$-admissible chart a derivation such that the new derivation field (the initial one + this new derivation) has the same action as the first derivation field.

From this we can deduce that if we have a derivation field associated to a $\mathbb{D}^{\infty}$-atlas, on another equivalent $\mathbb{D}^{\infty}$-atlas can be built a derivation field which has the same action as the initial one.

Let $(U, b, \Omega, \mathcal{F}, \mathbb{P})$ be a $\mathbb{D}^{\infty}$-admissible chart to the $\mathbb{D}^{\infty}$-atlas $\mathscr{A}=\left(U_{i}, b_{i}, \Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}\right)_{i \in I}$, then the identity is a $\mathbb{D}^{\infty}$-isomorphism between $\mathscr{A}$. and the atlas $\mathscr{A} \cup\{(U, b, \Omega, \mathcal{F}, \mathbb{P})\}$.
$\Omega$ can be covered by a countable collection of sets $b\left(U \cap U_{j}\right), j \in J$. Denote by $\varphi_{j}$ the map change of charts between $\Omega_{j}$ and $\Omega, \varphi_{j}=b \circ b_{j}^{-1}$.
$\forall j \in J$, we define $\left.\delta f\right|_{b\left(U \cap U_{j}\right)}, \forall f \in \mathbb{D}^{\infty}(\Omega)$, by:

$$
\left.\delta f\right|_{b\left(U \cap U_{j}\right)}=\left.\delta_{j} \overline{\left(f \circ \varphi_{j}\right) \circ \varphi_{j}^{-1}}\right|_{b\left(U \cap U_{j}\right)}
$$

The symbol ${ }^{\sim}$ is for the $\mathbb{D}^{\infty}(\Omega)$ extension of $\delta_{j}\left(f \circ \varphi_{j}\right) \circ \varphi_{j}^{-1}$ which exists because the chart $(U, b, \Omega)$ is $\mathbb{D}^{\infty}$-admissible to the $\mathbb{D}^{\infty}$-atlas $\mathscr{A}$.

Then

$$
\left.\delta f\right|_{b\left(U \cap U_{j}\right)}=\left.\delta_{j} \overline{\left(f \circ \varphi_{j}\right) \circ \varphi_{j}^{-1}}\right|_{b\left(U \cap U_{j}\right)} \circ \operatorname{Id}_{\mathscr{I}}
$$

Then we define:

$$
\delta f=\left.\sum_{j \in J} \mathbf{1}_{b\left(U \cap U_{j}\right)} \cdot \delta f\right|_{b\left(U \cap U_{j}\right)}
$$

The definition is legitimate because if $\omega \in b\left(U \cap U_{j_{1}}\right) \cap b\left(U \cap U_{j_{2}}\right)$ the map change of charts shows:

$$
\left.\delta f\right|_{b\left(U \cap U_{j_{1}}\right)}(\omega)=\left.\delta f\right|_{b\left(U \cap U_{j_{2}}\right)}(\omega)
$$

## 3. 6 Metric and fundamental bilinear form on a $\mathbb{D}^{\infty}$-stochastic manifold

Definition 3..9. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space. $A \mathbb{D}^{\infty}$-valued bilinear form on $(\operatorname{Der} \Omega)^{*}$ is a $\mathbb{D}^{\infty}$-bilinear form on $\operatorname{Der} \Omega$ denoted $q$, which is continuous relatively to each of its arguments. $q$ is said to be positive definite if $\alpha \in(\operatorname{Der} \Omega)^{*}$ is such that if $q(\alpha, \alpha)=0$ then $\alpha=0$.

Remark 3..7. The continuity of $q$ means that if a net $\left(\alpha_{i}\right)_{i \in I}$, included in a bounded part of $(\operatorname{Der} \Omega)^{*}$ converges towards $\alpha \in(\operatorname{Der} \Omega)^{*}$, then $\forall \beta \in(\operatorname{Der} \Omega)^{*}$, $q\left(\alpha_{i}, \beta\right)$ converges in $\mathbb{D}^{\infty}$ towards $q(\alpha, \beta)$.

Notation. Let $q$ be a bilinear form on $(\operatorname{Der} \Omega)^{*}$,
i) $\forall f \in \mathbb{D}^{\infty}(\Omega)$, we denote $\lambda_{f} \in(\operatorname{Der} \Omega)^{*}$ defined by:

$$
\forall \delta \in \operatorname{Der}, \lambda_{f}(\delta)=\delta(f) \quad\left(\in \mathbb{D}^{\infty}(\Omega)\right)
$$

ii) If $u \in(\operatorname{Der} \Omega)^{*}$, we denote $\delta_{u} \in \operatorname{Der} \Omega$ defined by:

$$
\forall f \in \mathbb{D}^{\infty}(\Omega), \delta_{u} f=q\left(\lambda_{f}, u\right)
$$

Definition 3..10. The fundamental bilinear form on $(\operatorname{Der} \Omega)^{*}$, also named the fundamental metric, denoted $q_{0}$, is defined by: if $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ is a Hilbert basis of $H$, and $\alpha, \beta \in(\operatorname{Der} \Omega)^{*}$,

$$
q_{0}(\alpha, \beta)=\sum_{i=1}^{\infty} \alpha\left(e_{i}\right) \beta\left(e_{i}\right)
$$

We have to show that this series is $\mathbb{D}^{\infty}$-convergent and that this definition does not depend on the choice of basis $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$.

Remark 3..8. $q_{0}$ being the fundamental metric, we have:

$$
\forall u \in(\operatorname{Der} \Omega)^{*}, \delta_{u}(f)=u(\operatorname{grad} f)
$$

Theorem 3..1. The fundamental form $q_{0}$ is well defined on $(\operatorname{Der} \Omega)^{*}$, and if $\alpha, \beta \in(\operatorname{Der} \Omega)^{*}$, we have $q_{0}(\alpha, \beta)=\alpha\left(\delta_{\beta}\right)=\beta\left(\delta_{\alpha}\right)$; and $q_{0}$ is non degenerate.

## Proof.

i) We know that (Theorem 2.7) given $\alpha \in(\operatorname{Der} \Omega)^{*}$, the sequence

$$
X_{N}=\sum_{k=1}^{N} \mathrm{E}\left[\alpha\left(e_{k}\right) \mid \mathcal{F}_{n}\right] e_{k}
$$

converges towards $\delta_{\alpha}\left(\left(e_{k}\right)_{k \in \mathbb{N}_{*}}\right.$ is a Hilbert basis of $H$, as usual). Then $\alpha\left(X_{N}\right) \xrightarrow{\mathbb{D}^{\infty}} \alpha\left(\delta_{\alpha}\right)$ implies

ii) From $X_{N} \xrightarrow{\mathbb{D}^{\infty}} \delta_{\alpha}$, we deduce: $\forall p>1, \beta\left(X_{N}\right) \xrightarrow{L^{p}} \beta\left(\delta_{\alpha}\right)$, then $\forall \varepsilon>0, \exists N_{0}>0, \forall k \in \mathbb{N}_{*}, \forall \ell \in \mathbb{N}_{*},\left\|\beta\left(\delta_{\alpha}\right)-\beta\left(X_{N_{0}+k+\ell}\right)\right\|_{L^{p}} \leq \varepsilon$ So

$$

$$
\leq \varepsilon+\left[\int\left(\sum_{i=1}^{\ell} \beta\left(e_{N_{0}+k+i}\right)^{2}\right)^{p}\right]^{\frac{1}{2 p}} \times\left[\int\left(\sum_{i=1}^{\ell} \mathrm{E}\left[\alpha\left(e_{N_{0}+k+i}\right) \mid \mathcal{F}_{N_{0}+k+\ell}\right]^{2}\right)^{p}\right]^{\frac{1}{2 p}}
$$

From (2) we know that the series $\sum_{k=1}^{\infty} \mathrm{E}\left[\alpha\left(e_{j}\right) \mid \mathcal{F}_{N}\right]^{2}$ is convergent so we can find $\ell_{0}$ such that for all $\ell \geq \ell_{0}$,

Now if we write $Y_{N}=\sum_{i=1}^{N} \mathrm{E}\left[\beta\left(e_{i}\right) \mid \mathcal{F}_{N}\right] e_{i}$ repeating the same calculus than in $i$, we get that the series $\sum_{j=1}^{\infty} \beta\left(e_{j}\right)^{2}$ is convergent; so we can find $\ell_{1}$ such that for all $\ell>\ell_{1}$,

Corollary 3..1. The map $(\operatorname{Der} \Omega)^{*} \ni \alpha \rightarrow \delta_{\alpha} \in \operatorname{Der} \Omega$ is injective
Proof. If $\delta_{\alpha}=\delta_{\beta}, \forall f \in \mathbb{D}^{\infty}(\Omega), q_{0}\left(\alpha-\beta, \lambda_{f}\right)=\lambda_{f}\left(\delta_{\alpha}-\delta_{\beta}\right)=0$. So with $f=W\left(e_{k}\right), q_{0}\left(\alpha-\beta, \lambda_{W\left(e_{k}\right)}\right)=\sum_{j=1}^{\infty}\left[\alpha\left(e_{j}\right)-\beta\left(e_{j}\right)\right] \delta_{j k}=0$

REMARK 3..9. $\forall f, g \in \mathbb{D}^{\infty}(\Omega)$,

& =\langle\operatorname{grad} f, \operatorname{grad} g\rangle_{H}
\end{aligned}

Definition 3..11. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space and $q$ a $\mathbb{D}^{\infty}$-bilinear form on $(\operatorname{Der} \Omega)^{*}, \mathbb{D}^{\infty}$-valued, continuous for each of its arguments. We define a map $T_{q}$ from $(\operatorname{Der} \Omega)^{*}$ to $\operatorname{Der} \Omega$ by

ii) $T_{q}\left(\lambda_{f}\right)=\delta_{f},\left(\delta_{f}(g)=\langle\operatorname{grad} f, \operatorname{grad} g\rangle_{H}\right)$

ii) $\forall i \in I, u_{i}=\sum_{j_{i} \in A_{i}} f_{j_{i}} \lambda_{g_{j_{i}}}, A_{i}$ being a finite subset of $\mathbb{N}_{*}, f_{j_{i}}, g_{j_{i}} \in \mathbb{D}^{\infty}(\Omega)$
iii) The net $\left(u_{i}\right)_{i \in I}$ converges towards $u$ in $(\operatorname{Der} \Omega)^{*}$.

To prove this result we need a lemma:
Lemma 3..3. Let $(\Omega, \mathcal{F}, \mathbb{P}, H)$ be a Gaussian space, $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ a Hilbert basis of $H$; denote $\mathcal{F}_{N}=\sigma\left[W\left(e_{1}\right), \ldots, W\left(e_{N}\right)\right]$ the $\sigma$-algebra generated by $\sigma\left(W\left(e_{i}\right)\right)$, $i \in\{1, \ldots, N\}$ and by $\mathcal{F}_{\frac{1}{N}}^{\perp}$ the $\sigma$-algebra $\sigma\left[W\left(e_{N+1}\right), \ldots\right]$.

Let $\delta \in \operatorname{Der} \Omega$; with

we have $\sup _{N, M}\left\|V_{N}\left(X_{M}\right)\right\|_{\mathbb{D}_{r}^{p}}<+\infty$ and $\sup _{N}\left\|V_{N}(\delta)\right\|_{L^{2}}<+\infty$. We remind that we denote by $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ a Hilbert basis of $H$.

## Proof.

a) We denote by $\theta_{N}$ the $L^{2}$-isometric map:

We will show in this section that

It is enough to prove that this is true for a dense subset of $L^{2}$, and we choose the subset composed by finite linear combinations of products of Hermite polynomials $P$ in Gaussian variables, $P_{1}$ and $P_{2}, P_{1}$ and $P_{2}$ being polynomials on Gaussian variables respectively in $\mathcal{F}_{N}$ and $\mathcal{F}_{N}^{\perp}$.

If $P=P_{1} \times P_{2}, P_{2}$ being a constant, the result is trivial and is independent of $N$.

If $P_{2}$ is not a constant, let $\alpha=\max \left|r_{1}-r_{2}\right|, r_{1}$ and $r_{2}$ being rhe indices of the Gaussian variables appearing in $P_{1}$ and $P_{2}$, then

& \quad \leq \frac{1}{k+1}\left\{m_{0}\left\|\sum_{\gamma=0}^{\alpha-1} \theta_{N}^{m_{0} \gamma} \theta_{N}^{m_{0} \gamma}\left(P_{1} \times P_{2}\right)\right\|_{L^{2}}+r \mid P_{1} \times P_{2} \|_{L^{2}}\right\}
\end{aligned}
$$

For $\forall(p, r)$

& =e_{\ell} \cdot P\left[W\left(e_{a}\right), W\left(e_{b}\right)\right]
\end{aligned}

which proves $\widetilde{\theta}_{N}^{j}\left(e_{\ell}\right)=e_{\ell}$.

With $W\left(e_{b}\right) \in \mathcal{F}_{N}^{\perp}$ we have
$\widetilde{\theta}_{N}^{j}\left(e_{\ell}\right)\left(W\left(e_{b}\right)\right)=\theta_{N}^{-j}\left[e_{\ell} \cdot W\left(e_{b+j}\right)\right]=\theta_{N}^{-j}\left(\delta_{b+j}^{\ell}\right)=\delta_{b+j}^{\ell}$
$\delta_{b+j}^{\ell}$ being the Kronecker symbol.
So $\widetilde{\theta}_{N}^{j}\left(e_{\ell}\right)=e_{\ell-j}$.
Then (6) becomes, with $W\left(e_{\ell}\right) \in \mathcal{F}_{\stackrel{1}{N}}^{\perp}$ :

\lim _{k}\left[\frac{1}{k+1} \sum_{j=0}^{k}\left(\widehat{\theta}_{N}^{j} u\right)\left(e_{\ell}\right)\right]=\lim _{k}\left[\frac{1}{k+1} \sum_{j=0}^{k} \theta_{N}^{j}\left(u\left(e_{\ell-j}\right)\right)\right] \\
\left\|\lim _{k}\left[\frac{1}{k+1} \sum_{j=0}^{k}\left(\theta_{N}^{j} u\right)\left(e_{\ell}\right)\right]\right\|_{L^{2}(\Omega)} \leq \lim _{k}\left[\frac{1}{k+1}\left\|\sum_{j=0}^{k} u\left(e_{\ell-j}\right)\right\|_{L^{2}}\right]
\end{gathered}
$$

But we know with Theorem 3.1 that

$$
q_{0}(u, u)=\sum_{i \leq N} u\left(e_{i}\right)^{2}+\sum_{\ell \in \mathbb{Z}} u\left(e_{\ell}\right)^{2}

Using this result, we deduce that (6) in the case of $e_{\ell}$, with $W\left(e_{\ell}\right) \in \mathcal{F}_{N}^{\perp}$, converges $L^{2}$ towards 0 .
We recapitulate:

for $e_{\ell}$ such that $W\left(e_{\ell}\right) \in \mathcal{F} \frac{\perp}{N}$, the convergenge being $L^{2}$ and being independent of $N$.
e) We compute $V_{N}\left(X_{M}\right)$ :

As each $\widehat{\theta}_{N}^{j} u \in(\operatorname{Der} \Omega)^{*}$ and is $\mathbb{D}^{\infty}$-linear, we have

\end{equation*}

From (8), we know that

$$

$X_{M}$ can be decomposed, with respect to $\mathcal{F}_{N}$ and $\mathcal{F}_{N}$ :

X_{M}=\sum_{i=1}^{N} \mathrm{E}\left[\delta\left(W\left(e_{i}\right)\right) \mid \mathcal{F}_{M}\right] e_{i}+\sum_{b \in B} \mathrm{E}\left[\delta\left(W\left(e_{k}\right)\right) \mid \mathcal{F}_{M}\right] e_{b}
$$

with Card $B$ finite. Using (8), we can rewrite (9) as:

Then we prove that $\left\|\left(\widehat{\theta}_{N}^{j} u\right) X_{M}\right\|_{\mathbb{D}_{r}^{p}}$ is uniformly, in $j$ and $M, \mathbb{D}^{\infty}$-bounded.

\left\|\left(\widehat{\theta}_{N}^{j} u\right)\left(X_{M}\right)\right\|_{\mathbb{D}_{r}^{p}} & =\left\|\theta_{N}^{j}(1-L)^{\frac{r}{2}}\left(u \cdot\left(\widetilde{\theta}_{N}^{j}\left(X_{M}\right)\right)\right)\right\|_{L^{p}} \\
& =\left\|(1-L)^{\frac{r}{2}}\left\{u\left(\widetilde{\theta}_{N}^{j}\left(X_{M}\right)\right)\right\}\right\|_{L^{p}} \\
& =\left\|u \cdot\left(\widetilde{\theta}_{N}^{j}\left(X_{M}\right)\right)\right\|_{\mathbb{D}_{r}^{p}}
\end{aligned}
$$

But $\left\{\widetilde{\theta}_{N}^{j}\left(X_{M}\right) / j \in \mathbb{N}_{*} ; N, M \in \mathbb{N}_{*}\right\}$ is a bounded subset of Der: let $f \in D, D$ being a $\mathbb{D}^{\infty}$-bounded set of $\mathbb{D}^{\infty}(\Omega)$ :

From $\left\{\theta_{N}^{j} f / j \in \mathbb{N}_{*} ; N \in \mathbb{N}_{*} ; f \in D\right\}$ is a $\mathbb{D}^{\infty}$-bounded set and that $X_{M} \rightarrow \delta$ in Der $\Omega$, we get that the set $\left\{\widetilde{\theta}_{N}^{j}\left(X_{M}\right) / j \in \mathbb{N}_{*} ; N \in \mathbb{N}_{*} ; M \in \mathbb{N}_{*}\right\}$ is bounded in Der, uniformly in $j, N, M$. And so is the set

$$
\left\{\left(\widehat{\theta}_{N}^{j} u\right)\left(X_{M}\right) / j \in \mathbb{N}_{*} ; N \in \mathbb{N}_{*} ; M \in \mathbb{N}_{*}\right\}
$$

uniformly in $j, N, M$. Which proves that the $\operatorname{set}\left\{V_{N}\left(X_{M}\right) / N \in \mathbb{N}_{*} ; M \in \mathbb{N}_{*}\right\}$ is uniformly in $N, M, \mathbb{D}^{\infty}$-bounded.

Now we go back to the proof of Theorem 3.2: we have by direct computation:

this limit being a $L^{2}$-limit. But from e) we also have $\sup _{N}\left\|V_{N}(\delta)\right\|_{L^{2}}<+\infty$.
These two properties of the sequence $V_{N}(\delta)$ imply $V_{N}(\delta) \rightharpoonup u(\delta),\left(V_{N}(\delta)\right)_{N}$ converges weakly towards $u(\delta)$.

As the $\left(V_{N}(\delta)\right)$ converges weakly towards $u(\delta)$, there is a net of barycenters, built on the $V_{N}(\delta)$, which will strongly converge towards $u(\delta)$. Each item of this net has the form:

B\left(A_{j}\right)=\sum_{j=1}^{n} \alpha_{j}\left(\sum_{i_{j} \in A_{j}} \mathrm{E}\left[u\left(e_{i_{j}}\right) \mid \mathcal{F}_{A_{j}}\right] \lambda_{W\left(e_{i j}\right)}\right)
$$

where $\alpha_{j} \geq 0$ and $A_{j}$ being a finite subset of $\mathbb{N}_{*}$. Then $\left\|B\left(A_{j}\right)\right\|_{\mathbb{D}_{r}^{p}}<+\infty$, independently of the $\left(A_{j}\right)$

Then the net $\left\{B\left(A_{j}\right)(\delta) / A_{j} \in \mathbb{N}_{*}\right\}$ converges towards $u(\delta)$ and we also have $\sup _{A_{j}}\left\|B\left(A_{j}\right)(\delta)\right\|_{\mathbb{D}_{r}^{p}}<+\infty$.

From these two properties, using the interpolation (Theorem 2.12), we deduce that the net $B\left(A_{j}\right)(\delta)$ converges $D^{\infty}$ towards $u(\delta)$.

Corollary 3..2. Given a bilinear positive form $q$ on Der*, the map $(\operatorname{Der} \Omega) * \ni \rightarrow T_{u} \in \operatorname{Der} \Omega$ is injective

Proof. Let $u \in(\operatorname{Der} \Omega)^{*}$ such that $T_{u}=0$. There exists a net $u_{F_{i}}=\sum_{f \in F_{i}} a_{f} \lambda_{b_{f}}, a_{f}$ and $b_{f} \in \mathbb{D}^{\infty}(\Omega)$ and $i \in I$, which converges towards $u$ in $(\operatorname{Der} \Omega)^{*}$. Then $q\left(u, \sum_{f \in F_{i}} a_{f} \lambda_{b_{f}}\right)=\sum_{f \in F_{i}} T_{u}\left(b_{f}\right)$ converges towards 0 ; so $q(u, u)=0$.

## 3. 7 Metric, Levi-Civita connection, curvature

We now study the notions of Levi-Civita connection, the curvature, and the torsion.

Let $q$ be a bilinear form, positive an non degenerate on $(\operatorname{Der} \Omega)^{*} ; q$ induces a $\operatorname{map} T_{q}$ :

$$
\forall \alpha \in(\operatorname{Der} \Omega)^{*},\left(T_{q} \alpha\right) \cdot f=q\left(\alpha, \lambda_{f}\right)=\delta_{\alpha}(f)
$$

We denote by $\mathscr{D}_{q}=\left\{T_{q} \alpha / \alpha \in(\operatorname{Der} \Omega)^{*}\right\} \subset \operatorname{Der} \Omega$
Definition $3 . .12$ (of the bilinear form $q_{0}$ on $\mathscr{D}_{q}$ ). On $\mathscr{D}_{q}$ we define $\widehat{q}\left(\delta_{\alpha}, \delta_{\beta}\right)=$ $q(\alpha, \beta)$. This definition is legitimate because $T_{q}$ is injective.

Definition $3 . .13$ (of the Levi-Civita connection associated to $\widehat{q}$ ). Let $\delta_{\alpha}, \delta_{\beta}, \delta_{\gamma} \in \mathscr{D}_{q}$, we define $\nabla_{\delta_{\alpha}} \delta_{\beta} \in \operatorname{Der} \Omega$ by

$$
\begin{aligned}
2 \gamma\left(\nabla_{\delta_{\alpha}} \delta_{\beta}\right)= & \delta_{\alpha} \cdot \widehat{q}\left(\delta_{\beta}, \delta_{\gamma}\right)+\delta_{\beta} \cdot \widehat{q}\left(\delta_{\alpha}, \delta_{\gamma}\right)-\delta_{\gamma} \cdot \widehat{q}\left(\delta_{\alpha}, \delta_{\beta}\right) \\
& -T^{-1}\left(\delta_{\alpha}\right)\left(\left[\delta_{\beta}, \delta_{\gamma}\right]\right)+T^{-1}\left(\delta_{\beta}\right)\left(\left[\delta_{\gamma}, \delta_{\alpha}\right]\right)+T^{-1}\left(\delta_{\gamma}\right)\left(\left[\delta_{\alpha}, \delta_{\beta}\right]\right)
\end{aligned}
$$

Each term of the r.h.s. of the above equation is meaningful because $T^{-1}: \mathscr{D}_{q} \rightarrow(\operatorname{Der} \Omega)^{*}$ and $\left[\delta_{\alpha}, \delta_{\beta}\right] \in \operatorname{Der} \Omega$. We now denote $\nabla_{\delta_{\alpha}} \delta_{\beta}$ by $\nabla_{\alpha} \beta$. Then we define $\left(\nabla_{\alpha} \beta\right) \cdot f=\lambda_{f}\left(\nabla_{\alpha} \beta\right)$, where $f \in \mathbb{D}^{\infty}(\Omega)$ and $\lambda_{f} \in(\operatorname{Der} \Omega)^{*}$.

Now we write improperly $\widehat{q}\left(\nabla_{\alpha} \beta, \delta_{\gamma}\right)=\gamma\left(\nabla_{\alpha} \beta\right)$. With this notation, it is easy to show that:

- $\nabla_{\alpha} \beta$ verifies the Leibniz formula,
- $\delta_{\alpha} \cdot \widehat{q}\left(\delta_{\beta}, \delta_{\gamma}\right)=\widehat{q}\left(\nabla_{\alpha} \beta, \delta_{\gamma}\right)+\widehat{q}\left(\delta_{\beta}, \nabla_{\alpha} \gamma\right)$ (compatibility with the metric)
- $\widehat{q}\left(\nabla_{\alpha} \beta, \delta_{\gamma}\right)-\widehat{q}\left(\nabla_{\beta} \alpha, \delta_{\gamma}\right)=\left(T^{-1} \delta_{\gamma}\right)\left(\left[\delta_{\alpha}, \delta_{\beta}\right]\right)$ (the torsion is zero)
which implies $\forall \gamma \in(\operatorname{Der} \Omega)^{*}$,

$$
\gamma\left(\nabla_{\alpha} \beta-\nabla_{\beta} \alpha-\left[\delta_{\alpha}, \delta_{\beta}\right]\right)=0
$$

or $\nabla_{\alpha} \beta-\nabla_{\beta} \alpha-\left[\delta_{\alpha}, \delta_{\beta}\right]=0$.
Lemma 3..4. $\delta_{\alpha} \in \mathscr{D}_{q} \Rightarrow \nabla_{\alpha} \alpha \in \mathscr{D}_{q}$.
Proof. Using the definition of the Levi-Civita connection, we have

$$
\widehat{q}\left(\nabla_{\alpha} \alpha, \delta_{\beta}\right)=\delta_{\alpha} \cdot \widehat{q}\left(\delta_{\alpha}, \delta_{\beta}\right)+\alpha\left(\left[\delta_{\beta}, \delta_{\alpha}\right]\right)-\frac{1}{2} \delta_{\beta} \cdot \widehat{q}\left(\delta_{\alpha}, \delta_{\alpha}\right)
$$

For all $\delta \in \operatorname{Der} \Omega$, the map which associates $\delta$ with

$$
\delta_{\alpha} \cdot \alpha(\delta)-\frac{1}{2} \delta \cdot \widehat{q}\left(\delta_{\alpha}, \delta_{\alpha}\right)+\alpha\left(\left[\delta, \delta_{\alpha}\right]\right)
$$

is an element of $(\operatorname{Der} \Omega)^{*}$; we denote it by $\rho$, then we have:

$$
\widehat{q}\left(\nabla_{\alpha} \alpha, \delta_{\beta}\right)=q\left(\rho, T_{q}^{-1}\left(\delta_{\beta}\right)\right)=\widehat{q}\left(\delta_{\rho}, \delta_{\beta}\right)
$$

Since $\widehat{q}$ is non degenerate, $\nabla_{\alpha} \alpha=\delta_{\rho} \in \mathscr{D}_{q}$.
Corollary 3..3. $\delta_{\alpha}, \delta_{\beta} \in \mathscr{D}_{q} \Rightarrow \nabla_{\alpha} \beta+\nabla_{\beta} \alpha \in \mathscr{D}_{q}$.
Proof. $\nabla_{\alpha+\beta}(\alpha+\beta)-\nabla_{\alpha} \alpha-\nabla_{\beta} \beta \in \mathscr{D}_{q}$.
Definition $3 . .14$ (formal definition of the curvature). Let $\widehat{q}$ be the positive non degenerate bilinear form on $\mathscr{D}_{q}$, for $\delta_{\alpha}, \delta_{\beta} \in \mathscr{D}_{q}$, we define only formally first:

$$
R\left(\delta_{\alpha}, \delta_{\beta}, \delta_{\alpha}, \delta_{\beta}\right)=\widehat{q}\left(\nabla_{\alpha}\left(\nabla_{\beta} \alpha\right), \delta_{\beta}\right)-\widehat{q}\left(\nabla_{\beta}\left(\nabla_{\alpha} \alpha\right), \delta_{\beta}\right)-\widehat{q}\left(\nabla_{\left[\delta_{\alpha}, \delta_{\beta}\right]} \delta_{\alpha}, \delta_{\beta}\right)
$$

Using the compatibility with the Levi-Civita connection and the torsion being null, we get, still formally:

$$
\begin{aligned}
\delta_{\alpha} \cdot \widehat{q}\left(\nabla_{\beta} \alpha, \delta_{\beta}\right) & =\widehat{q}\left(\nabla_{\alpha}\left(\nabla_{\beta} \alpha\right), \delta_{\beta}\right)+\widehat{q}\left(\nabla_{\beta} \alpha, \nabla_{\alpha} \beta\right) \\
\widehat{q}\left(\nabla_{\left[\delta_{\alpha}, \delta_{\beta}\right]}, \delta_{\alpha}\right) & =\widehat{q}\left(\left[\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\alpha}\right], \delta_{\beta}\right)+\widehat{q}\left(\nabla_{\alpha}\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\beta}\right)
\end{aligned}
$$

So, still formally,

$$
\begin{align*}
R\left(\delta_{\alpha}, \delta_{\beta}, \delta_{\alpha}, \delta_{\beta}\right)= & \delta_{\alpha} \cdot \widehat{q}\left(\nabla_{\beta} \alpha, \delta_{\beta}\right)-\widehat{q}\left(\nabla_{\beta} \alpha, \nabla_{\alpha} \beta\right)-\delta_{\beta} \cdot \widehat{q}\left(\nabla_{\alpha} \alpha, \delta_{\beta}\right) \\
& +\widehat{q}\left(\nabla_{\alpha} \alpha, \nabla_{\beta} \beta\right)-\widehat{q}\left(\nabla_{\left[\delta_{\alpha}, \delta_{\beta}\right]} \delta_{\alpha}, \delta_{\beta}\right) \tag{10}
\end{align*}
$$

The zero torsion implies:

$$
\begin{equation*}
\widehat{q}\left(\nabla_{\left[\delta_{\alpha}, \delta_{\beta}\right]} \delta_{\alpha}, \delta_{\beta}\right)=\widehat{q}\left(\left[\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\alpha}\right], \delta_{\beta}\right)+\delta_{\alpha} \cdot \widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\beta}\right)-\widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right], \nabla_{\alpha} \beta\right) \tag{11}
\end{equation*}
$$

Using (11) in (10), and denoting $\left\{\delta_{\alpha}, \delta_{\beta}\right\}=\frac{1}{2}\left(\nabla_{\alpha} \beta+\nabla_{\beta} \alpha\right) \in \mathscr{D}_{q}$ :

\begin{align*}
R\left(\delta_{\alpha}, \delta_{\beta}, \delta_{\alpha}, \delta_{\beta}\right)= & \delta_{\alpha} \cdot \widehat{q}\left(\nabla_{\beta} \alpha, \delta_{\beta}\right)-\widehat{q}\left(\left\{\delta_{\alpha}, \delta_{\beta}\right\},\left\{\delta_{\alpha}, \delta_{\beta}\right\}\right) \\
& +\frac{3}{4} \widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right],\left[\delta_{\alpha}, \delta_{\beta}\right]\right)-\delta_{\beta} \cdot \widehat{q}\left(\nabla_{\alpha} \alpha, \delta_{\beta}\right) \\
& +\widehat{q}\left(\nabla_{\alpha} \alpha, \nabla_{\beta} \beta\right)-\widehat{q}\left(\left[\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\alpha}\right], \delta_{\beta}\right) \\
& -\delta_{\alpha} \cdot \widehat{q}\left(\left[\delta_{\alpha}, \delta \beta\right], \delta_{\beta}\right)+\widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right],\left\{\delta_{\alpha}, \delta_{\beta}\right\}\right) \tag{12}
\end{align*}
$$

As $\widehat{q}\left(\left[\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\alpha}\right], \delta_{\beta}\right)=\beta \cdot\left(\left[\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\alpha}\right]\right)$,

$$
\widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right], \delta_{\beta}\right)=\beta \cdot\left(\left[\delta_{\alpha}, \delta_{\beta}\right]\right)
$$

and

$$
\widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right],\left\{\delta_{\alpha}, \delta_{\beta}\right\}\right)=T_{q}^{-1}\left(\left\{\delta_{\alpha}, \delta_{\beta}\right\}\right) \cdot\left(\left[\delta_{\alpha}, \delta_{\beta}\right]\right)
$$

The only element in (12) which does not have any meaning is $\widehat{q}\left(\left[\delta_{\alpha}, \delta_{\beta}\right],\left[\delta_{\alpha}, \delta_{\beta}\right]\right)$.
Then if we have on $(\operatorname{Der} \Omega)^{*}$ two non degenerate positive bilinear forms $q_{1}$ and $q_{2}$, and if the difference of $\widehat{q_{1}-q_{2}}$ is defined on all Der $\Omega$, the difference of the associated curvatures, $R_{1}-R_{2}$, is meaningful.

## 4. Multiplicators, derivations

Here we will characterize $\mathbb{D}^{\infty}$-continuous derivations which are also adapted and with zero-divergence. They bijectively correspond to some particularly important operators, named multiplicators, which we will first study. The general setting unless otherwise specified is a Wiener space $(\Omega, \mathcal{F}, \mathbb{P}, H)$ where $H$, the C-M. space is the set of functions $[0,1] \rightarrow \mathbb{R}^{n}$ verifying the usual conditions of the C-M. space.

## 4. 1 Definition of $\mathbb{D}^{\infty}$-bounded processes and of multiplicators

Definition 4..1. $A \mathbb{D}^{\infty}$ process $A(t, \omega)$, defined on $[0,1] \times \mathbb{R}$ with values in the $n \times n$ antisymmetrical matrices (denoted in short: $n \times n$-A.M.), will be said to be $\mathbb{D}^{\infty}$-bounded iff:
$\forall(p, r), p>1, r \in \mathbb{N}_{\star}, \exists C(p, r)>0$ such that:
$\sup _{t \in[0,1]}\||A(t, \omega)|\|_{\mathbb{D}_{r}^{p}} \leq C(p, r)$, where $|A(t, \omega)|$ denotes any $n \times n$ matrix norm, which are all equivalent.

Notation. $A \mathbb{D}^{\infty}$-vector field $X(\omega)$ is a map from $\Omega$ in $H$; this vector field generates a process on $[0,1] \times \Omega$, with values in $\mathbb{R}^{n}$, and then is denoted: $X(t, \omega)$.

Definition 4..2. An adapted vector field $X$, is a vector field $X(t, \omega)$ which, when read as a process $X(t, \omega)$ is an adapted process.

Definition 4..3. $A \mathbb{D}^{\infty}$-process $A(t, \omega):[0,1] \times \Omega \rightarrow n \times n-A$.M. will be said to be a multiplicator iff its image of a $\mathbb{D}^{\infty}$-vector field $V(\omega)$ is again $a \mathbb{D}^{\infty}$-vector field. That means: if $t \rightarrow \int_{0}^{t} \dot{V}(s, \omega) d s$ is a $\mathbb{D}^{\infty}$-vector field, then $t \rightarrow \int_{0}^{t} A(s, \omega) \dot{V}(s, \omega) d s$ is again a $\mathbb{D}^{\infty}$-vector field.

Lemma 4..1. Let $A=\left(a_{i j}\right)$ be a $n \times n-A . M$. matricial process on $[0,1] \times \Omega$ :
i) $A$ is a multiplicator $\Leftrightarrow \forall i, j: a_{i j}$ is a multiplicator.
ii) $A$ is a multiplicator implies: $A$ is a linear continuous operator.
iii) A multiplicator implies $A$ is $\mathbb{D}^{\infty}$-bounded.

Proof. i) trivial.
ii) direct application of the closed graph theorem.
iii) let $\left(e_{i}\right)_{i \in\{1, \ldots, n\}}$ be the canonical basis of $\mathbb{R}^{n}$ and $X_{k}(t, \epsilon, \omega): u \rightarrow \frac{1}{\sqrt{\epsilon}} \int_{0}^{u} \mathbb{1}_{[t, t+\epsilon[ }(s) d s . e_{k}$ a $\mathbb{D}^{\infty}$-vector field.
$\left((1-L)^{r / 2} A X_{k}\right)(t, \epsilon, \omega): u \rightarrow \sum_{j=1}^{n} \frac{1}{\sqrt{\epsilon}} \int_{0}^{u}\left((1-L)^{r / 2} a_{k j}\right)(s, \omega) \mathbb{1}_{[t, t+\epsilon[ }(s) d s . e_{j}$
which implies:

$$
\begin{aligned}
\left\|(1-L)^{r / 2} A \cdot X_{k}(t, \epsilon, \omega)\right\|_{H}^{2} & =\sum_{j=1}^{n} \frac{1}{\epsilon} \int_{0}^{1} d u\left|(1-L)^{r / 2} a_{k j}(u, \omega)\right|^{2} \mathbb{1}_{[t, t+\epsilon[ }(u) \\
& =\sum_{j=1}^{n} \frac{1}{\epsilon} \int_{t}^{t+\epsilon}\left|(1-L)^{r / 2} a_{k j}(u, \omega)\right|^{2} d u \\
& \geq \frac{1}{\epsilon} \int_{t}^{t+\epsilon} d u\left|(1-L)^{r / 2} a_{k j}\right|^{2}, \forall k, j
\end{aligned}
$$

By the continuity of $A$, we get:

$$
\begin{aligned}
& \forall(p, r) \exists(q, s), \exists \text { constant } C: \\
& \quad\left\|A \cdot X_{k}(t, \epsilon)\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)} \leq C\left\|X_{k}(t, \epsilon)\right\|_{\mathbb{D}_{s}^{q}(\Omega, H)} \leq \mathrm{C}
\end{aligned}
$$

Combining these two inequalities, we have:

\left\|\left[\int_{t}^{t+\epsilon} \frac{1}{\epsilon} d u\left|(1-L)^{r / 2} a_{k j}\right|^{2}\right]^{\frac{1}{2}}\right\|_{L^{p}(\Omega)} \leq \mathrm{C}

## Examples of multiplicators

Criterion 4..1. Let $A(t, \omega):[0,1] \times \Omega \rightarrow n \times n-A . M$. be a
$\mathbb{D}^{\infty}$-matricial process such that: $\forall f \in \mathbb{D}_{\infty}^{2}\left(\Omega, \mathbb{R}^{n}\right): f \rightarrow A f$ is continuous from $\mathbb{D}_{\infty}^{2}$ to $\mathbb{D}_{\infty}^{2}$,t-uniformly. Then $A$ is a multiplicator.

The proof will be given later (Lemma 4..7).
Criterion 4..2. Let $A(t, \omega):[0,1] \times \Omega \rightarrow n \times n$-A.M. be a
$\mathbb{D}^{\infty}$-matricial process such that with $A=\left(a_{i j}\right), \forall i, j, r$ such that:
$\sup _{t \in[0,1]}(1-L)^{r / 2} a_{i j}$ is bounded by a function $\in L^{\infty-0}(\Omega)$; then $\sup _{t \in[0,1]}\left\|D^{r} a_{i j}\right\|_{\otimes H}^{r}$ is also bounded by a function $\in L^{\infty-0}(\Omega)$ and $A$ is a multiplicator.

Proof. Let $f \in \mathbb{D}^{\infty}(\Omega)$; we denote $D_{i} f=\left\langle\operatorname{grad} f, e_{i}\right\rangle_{H},\left(e_{i}\right)_{i \in \mathbb{N}_{\star}}$ being an Hilbertian basis of $H$.

With the Mehler formula:

$$
\left[D_{i}\left((1-L)^{-1} f\right)\right](x)=D_{i}\left[\int_{0}^{\infty} e^{-t} d t \int_{\mathbb{R}^{n}} f\left(x e^{-t}+y \sqrt{1-e^{-2 t}}\right) d \gamma^{\mathbb{N}}(y)\right]
$$

$d \gamma^{\mathbb{N}}(y)$ being the Wiener measure; so:

$$
\left[D_{i}\left((1-L)^{-1} f\right)\right](x)=\int_{0}^{\infty} \frac{e^{-2 t} d t}{\left(1-e^{-2 t}\right)^{\frac{1}{2}}} \int_{\mathbb{R}^{n}} y^{i} f\left(x e^{-t}+y \sqrt{1-e^{-2 t}}\right) d \gamma^{\mathbb{N}}(y)
$$

The $y^{i}$ are i.i.d. Gaussian variables. So Bessel-Perseval implies:

$$
\begin{aligned}
\left\|\operatorname{grad}\left[(1-L)^{-1} f\right]\right\|_{H}^{2}(x) & =\sum_{i=1}^{\infty}\left|D_{i}(1-L)^{-1} f\right|^{2}(x) \\
& =\sum_{i}\left[\int_{\mathbb{R}^{n}} d \gamma^{\mathbb{N}}(y) y^{i}\left\{\int_{0}^{\infty} \frac{e^{-2 t}}{\sqrt{1-e^{-2 t}}} f\left(x e^{-t}+y \sqrt{1-e^{-2 t}}\right) d t\right\}\right]^{2} \\
& \leq\left[\int_{\mathbb{R}^{n}} d \gamma^{\mathbb{N}}(y) \int_{0}^{\infty} \frac{e^{-2 t} d t}{\left(1-e^{-2 t}\right)^{\frac{1}{2}}} f\left(x e^{-t}+y \sqrt{1-e^{-2 t}}\right) d t\right]^{2}
\end{aligned}
$$

which implies:

$$
\begin{equation*}
\left\|\operatorname{grad}(1-L)^{-1} f\right\|_{H}(\omega) \leq \int_{0}^{\infty} \frac{e^{-2 t} d t}{\left(1-e^{-2 t}\right)^{\frac{1}{2}}}\left(P_{t} f\right)(\omega) \tag{1}
\end{equation*}
$$

where $P_{t}$ is the generator of the O.U. semi-group.
Now, we have by hypothesis: $(1-L) a_{i j} \leq \alpha_{i j}, \alpha_{i j} \in L^{\infty-0}(\Omega)$, so:
$\left\|\operatorname{grad} a_{i j}\right\|_{H}(\omega)=\left\|\operatorname{grad}(1-L)^{-1}(1-L) a_{i j}\right\|_{H}(\omega)$; Using (1):

&\left\|\operatorname{grad} a_{i j}\right\|_{H}(\omega) \leq \int_{0}^{\infty} \frac{e^{-2 t} d t}{\left(1-e^{-2 t}\right)^{\frac{1}{2}}} P_{t}\left[(1-L) a_{i j}\right] \leq \int_{0}^{\infty} \frac{e^{-2 t} d t}{\left(1-e^{-2 t}\right)^{\frac{1}{2}}}\left(P_{t} \alpha_{i j}\right) d t \\
& \text { so: } \int \mathbb{P}(d \omega)\left(\int_{0}^{1} d s\left\|\operatorname{grad} a_{i j}\right\|_{H}^{2}\right)^{p / 2} \leq \int \mathbb{P}(d \omega) \int_{0}^{1} d s\left\|\operatorname{grad} a_{i j}\right\|_{H}^{p} \\
& \leq \int \mathbb{P}(d \omega)\left|\int_{0}^{\infty} \frac{e^{-2 t} d t}{\left(1-e^{-2 t}\right)^{\frac{1}{2}}} d t . P_{t} \alpha_{i j}\right|^{p} \leq \int \mathbb{P}(d \omega) \int_{0}^{\infty} \frac{e^{-2 p t} d t}{\left(1-e^{-2 t}\right)^{\frac{p}{2}}}\left|P_{t} \alpha_{i j}\right|^{p} \\
& \leq \int_{0}^{\infty} \frac{e^{-2 p t} d t}{\left(1-e^{-2 t}\right)^{p}}\left\|\alpha_{i j}\right\|_{L^{p}(\Omega)}^{p}
\end{aligned}
$$

Remark 4..1. If the $\stackrel{r}{\otimes} H$-norms of the iterated Malliavin derivation of $f \in \mathbb{D}^{\infty}(\Omega)$ are bounded by elements of $L^{\infty-0}$, this does not imply that the iterated O.U. of $f$ are bounded by $L^{\infty-0}$ functions.

Example: $f=\cos \frac{B_{t}}{\sqrt{t}}, B_{t}$ being Brownian.
Remark 4..2. If $A$ is a $\mathbb{D}^{\infty}$ process from $[0,1] \times \Omega$, valued in the
$n \times n$-A.M. but with the items being vectors of $H, A=\left(h_{i j}\right)$,
if $\sup _{t \in[0,1]}\left\|(1-L)^{r / 2} h_{i j}\right\|_{H}$ is bounded by a function in $L^{\infty-0}(\Omega)$ then $\operatorname{grad} A=\left(\operatorname{grad} h_{i j}\right)$ is a multiplicator from $\mathbb{D}^{\infty}(\Omega, H)$ to $\mathbb{D}^{\infty}(\Omega, H \otimes H)$

## 4. 2 Example of $\mathbb{D}^{\infty}$-bounded processes which is not a multiplicator

Proposition 4..1. The set of $\mathbb{D}^{\infty}$-multiplicators is strictly included in the set of $\mathbb{D}^{\infty}$-bounded processes.

Proof. Let

$$
\begin{aligned}
& f(x)=0 \text { if } x \in]-\infty, 0] \cup[1,+\infty[ \\
& \left.f(x)=e^{-\frac{1}{x(1-x)}} \text { if } x \in\right] 0,1[
\end{aligned}
$$

and $\varphi(x)=\int_{x}^{\infty} f(t) d t / \int_{-\infty}^{+\infty} f(t) d t$; then $\varphi(x)=1$ if $x<0, \varphi(x)=0$ if $x>1$, and $\varphi$ is strictly decreasing on $] 0,1[$.

Let $\varphi_{n}=\varphi(x-\sqrt{2 \log n})$.
An Hilbertian basis of $L^{2}([0,1])$ is: $k \in \mathbb{N}_{\star}$ :

$$
e_{k}: t \rightarrow \int_{0}^{t} 2^{\frac{k+1}{2}} \mathbb{1}_{\left.11-\frac{1}{2^{k}}, 1-\frac{1}{2^{k+1}}\right]}(s) d s
$$

Then we define the vector field $V$ as:

$$
V=\sum_{n=1}^{\infty}\left(\prod_{k=1}^{n-1} \varphi_{k}\left(X_{k}\right)\right)\left(1-\varphi_{n}\left(X_{n}\right)\right) e^{-\frac{1}{2} \sqrt{1+X_{n}^{2}}} e_{n}
$$

$X_{1}, \ldots, X_{n}, \ldots$ being independent, centered, identically distributed Gaussian variables.
The candidate multiplicator process is:

$$
C=\sum_{k=0}^{\infty} e^{\sqrt{1+X_{k}^{2}}} \mathbb{1}_{] 1-\frac{1}{2^{k}}, 1-\frac{1}{\left.2^{k+1}\right]}}(t)
$$

i) $C$ is $\mathbb{D}^{\infty}$-bounded: let $t=t_{0}$ and $k_{0}$ be such that $\left.\left.t \in\right] 1-\frac{1}{2^{k_{0}}}, 1-\frac{1}{2^{k_{0}+1}}\right]$; we have:
$\left\|C\left(t_{0}, \omega\right)\right\|_{\mathbb{D}_{r}^{p}}^{p}=\left\|(1-L)^{r / 2} C\left(t_{0}, \omega\right)\right\|_{L^{p}}^{p}=\int\left|(1-L)^{r / 2} e^{\sqrt{1+X_{k_{0}}^{2}}}\right|^{p} \mathbb{P}(d \omega)<+\infty$,
uniformly relatively to $t$.
ii) Now we show that $V \in \mathbb{D}^{\infty}(\Omega, H)$. It is enough to show that $V \in$ $L^{\infty-0} \cap \mathbb{D}_{\infty}^{2}$ (Theorem 2, 5). We have $\|V\|_{H} \leq 1$. We will show that $V \in \mathbb{D}_{\infty}^{2}$ by bounding $\left\|L^{r} V\right\|_{L^{2}(\Omega, H)}, r \in \mathbb{N}_{\star}$, with a convergent serie:

Let $\psi_{k}\left(X_{k}\right)=\varphi_{k}\left(X_{k}\right)$ if $k \leq n-1, \psi_{n}\left(X_{n}\right)=\left(1-\varphi_{n}\left(X_{n}\right)\right) e^{-\frac{1}{2} \sqrt{1+X_{n}^{2}}}$ if $k=n$.

Then:

$$
\begin{array}{r}
\int \mathbb{P}(d \omega)\left|L^{r}\left(\prod_{k=1}^{n} \psi_{k}\left(X_{k}\right)\right)\right|^{2}=\int\left[\prod_{k=1}^{n} \psi_{k}\left(X_{k}\right)\right] \cdot\left[L^{2 r}\left\{\prod_{j=1}^{n} \psi_{j}\left(X_{j}\right)\right\}\right] \mathbb{P}(d \omega) \\
=\sum_{\alpha_{1}+\cdots+\alpha_{n}=2 r} \int\left(\prod_{k=1}^{n} \psi_{k}\left(X_{k}\right)\right) \frac{(2 r)!}{\alpha_{1}!\ldots \alpha_{n}!}\left(\prod_{i=1}^{n} L^{\alpha_{i}}\left(\psi_{i}\left(X_{i}\right)\right)\right) \mathbb{P}(d \omega) \\
=\sum_{\alpha_{1}+\cdots+\alpha_{n}=2 r} \frac{(2 r)!}{\alpha_{1}!\ldots \alpha_{n}!} \prod_{k=1}^{n} \int \mathbb{P}(d \omega) \psi_{k}\left(X_{k}\right) L^{\alpha_{k}}\left(\psi_{k}\left(X_{k}\right)\right)
\end{array}
$$

For each factor $I_{k}=\int \mathbb{P}(d \omega) \psi_{k}\left(X_{k}\right) L^{\alpha_{k}} \cdot \psi_{k}$ we have four possibilities:
a) $1 \leq k \leq n-1$ and $\alpha_{k} \neq 0$ : Then:

$$
I_{k}^{(1)}=\frac{1}{\sqrt{2 \pi}} \int_{\sqrt{2 \log k}}^{\sqrt{2 \log k}+1} \varphi(x-\sqrt{2 \log k}) L^{\alpha_{k}}[\varphi(x-\sqrt{2 \log k})] e^{-\frac{x^{2}}{2}} d x
$$

then:

$$
\begin{aligned}
\left|I_{k}^{(1)}\right| & \leq \frac{1}{\sqrt{2 \pi}} \frac{1}{k} \int_{\sqrt{2 \log k}}^{\sqrt{2 \log k}+1}\left|L^{\alpha_{k}} \varphi(x-\sqrt{2 \log k})\right| d x \\
& =\frac{1}{\sqrt{2 \pi}} \frac{1}{k} \int_{0}^{1}\left|L^{\alpha_{k}} \varphi(u)\right| d u \leq \frac{1}{k \sqrt{2 \pi}} M_{1}
\end{aligned}
$$

with $M_{1}=\sup _{1 \leq j \leq r} \int_{0}^{1}\left|L^{j} \varphi(u)\right| d u$.
b) $1 \leq k \leq n-1$ and $\alpha_{k}=0$ :

\begin{aligned}
\left|I_{k}^{(2)}\right|=\frac{1}{\sqrt{2 \pi}} & \int_{-\infty}^{\sqrt{2 \log k+1}} \varphi(x-\sqrt{2 \log k})^{2} e^{-\frac{x^{2}}{2}} d x \leq \frac{1}{\sqrt{2 \pi}} \int_{-\infty}^{\sqrt{2 \log k+1}} e^{-\frac{x^{2}}{2}} d x \leq 1 \\
\text { c) } k & =n, \alpha_{n}=0 \\
I_{n}^{(1)} & =\frac{1}{\sqrt{2 \pi}} \int_{\sqrt{2 \log n}}^{+\infty}(1-\varphi(x-\sqrt{2 \log k}))^{2} e^{-\sqrt{1+x^{2}}} e^{-\frac{x^{2}}{2}} d x \\
& \leq \frac{1}{\sqrt{2 \pi}} \int_{\sqrt{2 \log n}}^{+\infty} e^{-\sqrt{1+x^{2}}} e^{-\frac{x^{2}}{2}} d x \\
& \leq \frac{1}{\sqrt{2 \pi}} \cdot \frac{1}{e^{\sqrt{1+2 \log n}} \int_{\sqrt{2 \log n}}^{\infty} e^{-\frac{x^{2}}{2}} d x}
\end{aligned}
$$

$$
\leq \frac{1}{\sqrt{2 \pi}} \cdot \frac{1}{e^{\sqrt{1+2 \log n}}} \cdot \frac{2}{n} \cdot \frac{1}{\sqrt{2 \log n}}
$$

d) $k=n, \alpha_{n} \neq 0$ :

I_{n}^{(2)}=\int_{\sqrt{2 \log n}}^{+\infty}(1-\varphi(x-\sqrt{2 \log n})) e^{-\frac{1}{2} \sqrt{1+x^{2}}} L^{\alpha_{n}}\left((1-\varphi(x-\sqrt{2 \log k})) e^{-\frac{1}{2} \sqrt{1+x^{2}}}\right) e^{-\frac{x^{2}}{2}} d x
$$

and $L^{\alpha_{n}}=P_{\alpha_{n}}\left(\frac{\partial}{\partial x}\right)$ where $P_{\alpha_{n}}$ is a polynomial such that:
$1 \leq \operatorname{deg}\left(P_{\alpha_{n}}\right) \leq 4 r$.
So:

I_{n}^{(2)} \leq \frac{1}{\sqrt{2 \pi}} \int_{\sqrt{2 \log n}}^{\infty} e^{-\frac{1}{2} \sqrt{1+x^{2}}} P_{\alpha_{n}}\left(\frac{\partial}{\partial x}\right)\left((1-\varphi(x-\sqrt{2 \log n})) e^{-\frac{1}{2} \sqrt{1+x^{2}}}\right) e^{-\frac{x^{2}}{2}} d x
$$

and: $I_{n}^{(2)} \leq \frac{1}{\sqrt{2 \pi} e^{\frac{1}{2} \sqrt{1+2 \log n}}} \int_{\sqrt{2 \log n}}^{\infty} P_{\alpha_{n}}\left(\frac{\partial}{\partial x}\right)\left((1-\varphi(x-\sqrt{2 \log n})) e^{-\frac{1}{2} \sqrt{1+x^{2}}}\right) e^{-\frac{x^{2}}{2}} d x$
But $P_{\alpha_{n}}\left(\frac{\partial}{\partial x}\right)\left\{(1-\varphi(x-\sqrt{2 \log n})) e^{-\frac{1}{2} \sqrt{1+x^{2}}}\right\}$ can be rewritten as:

$$
P_{\alpha_{n}}\left(\frac{\partial}{\partial x}\right)\left\{(1-\varphi(x-\sqrt{2 \log n})) e^{-\frac{1}{2} \sqrt{1+x^{2}}}\right\}=e^{-\frac{1}{2} \sqrt{1+x^{2}}}\left[\sum_{i=1}^{\alpha_{n}+1} \frac{P_{i}\left(x, \varphi^{(j)}\right)}{\left(1+x^{2}\right)^{i / 2}}\right]
$$

where $P_{i}$ is a polynomial in $x$, and $\varphi^{(j)}$ being the $j^{\text {th }}$ derivative of $\varphi$ $\left(j=1, \ldots, \alpha_{n}\right)$.

Using the same type of development for $P_{2 r}\left(\frac{\partial}{\partial x}\right),\left|\varphi^{(j)}\right| \leq 1$, and substituting each coefficient with its module, we get: $\forall \alpha_{n}: 1 \leq \alpha_{n} \leq$ $2 r$ :

\left|P_{\alpha_{n}}\left(\frac{\partial}{\partial x}\right)\left\{(1-\varphi(x-\sqrt{2 \log n})) e^{-\frac{1}{2} \sqrt{1+x^{2}}}\right\}\right| \leq e^{-\frac{1}{2} \sqrt{1+x^{2}}}\left[\sum_{i=1}^{2 n+1} \frac{\left|P_{i}(x, 1)\right|}{\left(1+x^{2}\right)^{1 / 2}}\right]=R(x)
$$

So there exists $N_{0} \in \mathbb{N}$ such that: $\forall x \geq \sqrt{2 \log N_{0}}$, we have $R(x) \leq 1$; Which implies:

$$
I_{n}^{(2)} \leq \frac{1}{\sqrt{2 \pi}} \cdot \frac{1}{e^{\frac{1}{2} \sqrt{1+2 \log n}}} \int_{\sqrt{2 \log n}}^{\infty} e^{-\frac{x^{2}}{2}} d x=\frac{1}{\sqrt{2 \pi}} \cdot \frac{1}{e^{\frac{1}{2} \sqrt{1+2 \log n}}} \cdot \frac{1}{n \sqrt{2 \log n}}
$$

Now, the entry of rank $n$ of the serie defining $\|V\|_{\mathbb{D}_{r}^{2}}$ can be rewritten as:
$\sum_{\alpha_{1}+\cdots+\alpha_{n}=2 r} \frac{(2 r)!}{\alpha_{1}!\ldots \alpha_{n}!} \prod_{k=1}^{n-1} I_{k} I_{n}+\sum_{\alpha_{n}=1}^{2 r}\left(\sum_{\alpha_{1}+\cdots+\alpha_{n-1}=2 r-\alpha_{n}} \frac{2 r!}{\alpha_{1}!\ldots \alpha_{n}!} \prod_{k=1}^{n-1} I_{k} I_{n}\right)$

Let $J$ be a finite subset of $\{2, \ldots, n-1\}$, of size $\lambda$ with: $0 \leq \lambda \leq 2 r$. We denote by $P(J)=\prod_{k \in J} I_{k} \leq \mathrm{C} \prod_{k \in J} \frac{1}{k}, C$ being a constant.

Then we know that there is a set $\widetilde{J}$ of $\alpha_{k}, k \in J$, such that for each $\alpha_{k} \in \widetilde{J}: \alpha_{k} \neq 0$ and $\alpha_{k} \leq 2 r$ and $\sum_{k \in J} \alpha_{k}=2 r$.

From the above decomposition of $2 r$ we can construct another decomposition of $2 r$ such that $\forall j \in J: \alpha_{j}=1$, and
$\alpha_{1}=2 r-\lambda\left(=2 r-\sum_{j \in J} j\right)$.
Then: $P(J) I_{\alpha_{1}} \leq \mathrm{C} \prod_{k \in J} \frac{1}{k}$.
Now this item $\prod_{k \in J} \frac{1}{k}$ appear in the development of:

The number of sums that can be used with $\lambda$ integers to obtain $2 r$ (each of the integers beging less or equal to $2 r$ ) is bounded by $C(r)$, a constant which depends only on $r$, and not on $n$.

So each $\sum_{\alpha_{1}+\cdots+\alpha_{\lambda}=2 r} \frac{(2 r)!}{\alpha_{1}!\ldots \alpha_{\lambda}!} \prod_{k \in J} I_{k}$ can be bounded by $(2 r)!C(r)\left(1+\cdots+\frac{1}{n-1}\right)^{2 r}$. So (1') can be bounded by: $C(r)$, being an "absorbing" constant:

This last inequality shows that the serie defining $\|V\|_{\mathbb{D}_{r}^{2}}$ is bounded by a convergent serie, so $V \in \mathbb{D}^{\infty}(\Omega, H)$.
iii) Now we prove that $C . V \notin L^{2}(\Omega, H)$, which will prove that although $C$ is $\mathbb{D}^{\infty}$-bounded, it is not a multiplicator. We have:

& \geq(1-\varphi(\epsilon))^{2} e^{\sqrt{1+2 \log n}} e^{-\frac{1}{2}\left(1+\epsilon+\sqrt{2 \log n)^{2}}\right.}
\end{aligned}

Now we will show that the serie with the general term:

We need the following lemma:

With Lemma $4 . .2$ we get: $\prod_{k=2}^{n-1}\left(1-\frac{1}{k \sqrt{4 \pi \log k}}\right) \geq C_{0} e^{-\sqrt{\frac{\log (n-1)}{\pi}}}$
Then the general term in (2) is bigger than

Now: $e^{-\frac{a^{2}}{2}}-e^{-\frac{(a+1)^{2}}{2}} \sim e^{-\frac{a^{2}}{2}}$ when $a \uparrow \infty$ and $e^{\sqrt{1+(\sqrt{2 \log n}+\epsilon)^{2}}} \sim$ $e^{\sqrt{2 \log n}+\epsilon}$ when $n \uparrow \infty$.

So the general term above is equivalent to, $C_{1}$ being a constant:

So choosing $\epsilon$ such that: $0<\epsilon<1-\frac{1}{\sqrt{2 \pi}}$, (3) is the general of a divergent serie which is less than: $\int\|C \cdot V\|_{H}^{2} \mathbb{P}(d \omega)$.

## 4. 3 Identity of $\mathbb{D}^{\infty}$-derivations which null-divergence adapted multiplicators

Now we will study the relation between adapted multiplicators and adapted derivations with null divergence.

Let $A=\left(a_{j}^{i}\right)$ be an adapted multiplicator process taking its values in $n \times n$-A.M. We define a map $D_{A}$ from the Gaussian variables in $\mathbb{D}^{\infty}(\Omega)$ by:
let $B$ be an $\mathbb{R}^{n}$-valued Brownian on $W\left(h_{1}, \ldots, h_{n}\right)$ :
$D_{A}\left[W\left(h_{1}, \ldots, h_{n}\right)\right]=-\int_{0}^{1}\left(\dot{h_{1}}, \ldots, \dot{h_{n}}\right) A d B$
$D_{A}$ can be extented on the set of polynomials in Gaussian variables with the Leibniz rule.
$A$ being an antisymmetrical matrix, $\operatorname{div} A$ grad is a derivation; $P$ being a polynomial of Gaussian variables, and $A$ being adapted, $\operatorname{div} A \operatorname{grad} P$ can be written with an Itō integral which coincides with $D_{A} P$. So $D_{A}$ can be extended in a $\mathbb{D}^{\infty}$-continuous derivation from $\mathbb{D}^{\infty}$ to $\mathbb{D}^{\infty}$.

Theorem 4..1. Conversely, each $\mathbb{D}^{\infty}$-continuous derivation $\delta$ of $\mathbb{D}^{\infty}$ in $\mathbb{D}^{\infty}$, which is adapted and with a null divergence, has the form $D_{A}, A$ being an adapted multiplicator process with values in the $n \times n-A . M$. .

The proof of Theorem $4 . .1$ needs several lemmas. We first define the coefficients $a_{j}^{i}$ of the candidate $A$ : let $\left(B_{t}^{1}, \ldots, B_{t}^{n}\right)$ be an n-uple of independent Brownian processes. Then by the Clark-Ocone formula we have:
$\delta B_{1}^{i}=\int_{0}^{1} t_{\mathbb{E}}\left[\operatorname{grad}\left(\delta B_{1}^{i}\right)_{j}(s) \mid \mathcal{F}_{s}\right] d B_{s}^{j}, \operatorname{grad}\left(\delta B_{1}^{i}\right)_{j}$ being the $j^{\text {th }}$ component of the vector $\operatorname{grad}\left(\delta B_{1}^{i}\right)$ which is a process, for which the value in $s$ is taken. We define $A={ }^{t}\left(a_{j}^{i}\right)(t, \omega)=^{t} \mathbb{E}\left[\operatorname{grad}\left(\delta B_{1}^{i}\right)_{j}(t) \mid \mathcal{F}_{t}\right]$ and will show that $A$ is an adapted multiplicator with values in $n \times n$-A.M., and that $D_{A}=\operatorname{div} A \operatorname{grad}=\delta$.

It is obvious from the definition of $A$ that $A$ is adapted. We first prove that $A$ is antisymmetric.

LEMMA 4..3. $\delta$ being an $\mathbb{D}^{\infty}$-continuous derivation, adapted and with null divergence, then $B_{t}$ being a Brownian process:
i) $\delta B_{t}, t \in[0,1]$ is a martingale.
ii) $\forall W\left(h_{1}, \ldots, h_{n}\right): \delta\left(\mathbb{E}\left[W\left(h_{1}, \ldots, h_{n}\right) \mid \mathcal{F}_{t}\right]\right)$ is a $\mathcal{F}_{t}$-martingale.
iii) $\delta\left(\mathbb{E}\left[W\left(h_{1}, \ldots, h_{n}\right) \mid \mathcal{F}_{t}\right]\right) \mathbb{E}\left[W\left(h_{1}, \ldots, h_{n}\right) \mid \mathcal{F}_{t}\right]$ is a $\mathcal{F}_{t}$-martingale.
iv) ${ }^{t} a_{j}^{i}=\mathbb{E}\left[\operatorname{grad}\left(\delta B_{1}^{i}\right)_{j}(s) \mid \mathcal{F}_{s}\right]$ is antisymmetrical.

Proof. i) straightforward: $\forall \varphi \in \mathcal{F}_{s}: \int \varphi\left[\delta B_{s}-\mathbb{E}\left[\delta B_{t} \mid \mathcal{F}_{s}\right]\right]=\int \varphi \delta\left(B_{s}-B_{t}\right)=$ 0,
$\delta$ being adapted.
ii) $\forall \varphi \in \mathcal{F}_{s}$ :

iii) Denote $M_{s}=\mathbb{E}\left[W\left(h_{1}, \ldots, h_{n}\right) \mid \mathcal{F}_{s}\right]$. Let: $0 \leq u \leq s$.

with Itō formula, $M^{(1)}$ and $M^{(2)}$ being the obvious martingales.
Let $\epsilon \rightarrow 0$ : the r.h.s. of the above equation converges $L^{1}(\Omega)$ towards ${ }^{t} a_{k}^{i}$, and is $\mathbb{D}^{\infty}$-bounded, so $a_{k}^{i}$ is $\mathbb{D}^{\infty}$-bounded.

Now $A$ being antisymmetric, $\operatorname{div} A$ grad is a derivation on the domain of the polynomials in Gaussian variables, which coincides with $\delta$ on this domain.

The only property left to verify is that $A$ is a multiplicator and then: $D_{A}=\operatorname{div} A \operatorname{grad}$ will be a derivation on $\mathbb{D}^{\infty}(\Omega)$, which will coincide with $\delta$ on $\mathbb{D}^{\infty}(\Omega)$.

For this, the following lemmas are needed:
Lemma 4..5. i) If $P \in \mathcal{C}_{n}, Q \in \mathcal{C}_{m}, \exists k(n) \in \mathbb{N}$ so that:

\left\|\int_{0}^{1} d t \mathbb{E}\left[(\operatorname{grad} P)(t) \mid \mathcal{F}_{t}\right] \cdot \mathbb{E}\left[(\operatorname{grad} Q)(t) \mid \mathcal{F}_{t}\right]\right\|_{L^{2}(\Omega)} \leq \int_{0}^{1} d t\left\|\mathbb{E}\left[(\operatorname{grad} P)(t) \mid \mathcal{F}_{t}\right] \cdot \mathbb{E}\left[(\operatorname{grad} Q)(t) \mid \mathcal{F}_{t}\right]\right\|_{L^{2}(\Omega)} \\
\leq \int_{0}^{1} d t A_{n-1, m-1}\left\|\mathbb{E}\left[(\operatorname{grad} P)(t) \mid \mathcal{F}_{t}\right]\right\|_{L^{2}} \cdot\left\|\mathbb{E}\left[(\operatorname{grad} Q)(t) \mid \mathcal{F}_{t}\right]\right\|_{L^{2}} \\
\leq A_{n-1, m-1}\left[\int_{0}^{1} d t\left\|\mathbb{E}\left[(\operatorname{grad} P)(t) \mid \mathcal{F}_{t}\right]\right\|_{L^{2}}\right]^{\frac{1}{2}}\left[\int_{0}^{1} d t\left\|\mathbb{E}\left[(\operatorname{grad} Q)(t) \mid \mathcal{F}_{t}\right]\right\|_{L^{2}}\right]^{\frac{1}{2}}
\end{array}
$$

So at the end:

\|P Q\|_{L^{2}} \leq\left(A_{n-1, m}+A_{n, m-1}+A_{n-1, m-1}\right)\|P\|_{L^{2}} .\|Q\|_{L^{2}}
$$

So we have: $A_{n-1, m}+A_{n, m-1}+A_{n-1, m-1} \geq A_{n, m}$.
Let's write: $A_{n, m}=k(n)(m+1)^{n}$ then $k(n)=k(n-1)\left(2^{n-1}+1\right)$ fits.
ii) Let $\alpha \in \mathbb{D}_{\infty}^{2}(\Omega) ; \alpha=\sum_{n=1}^{\infty} \alpha_{n}, \alpha_{n} \in \mathcal{C}_{n}(\Omega)$.

Let $\beta \in \mathcal{C}_{m}$; the sequence of $L^{2}$-norms $\left\|\alpha_{n}\right\|_{L^{2}}$ is fast decreasing; each $\beta \alpha_{n}$ is then a polynomial with terms belonging to the chaos of orders
$|n-m|, \ldots, n+m$; and the multiplication of a fast decreasing $L^{2}$-norm sequence, by a fixed polynomial is again a sequence of fast decreasing $L^{2}$-norms.

Lemma 4..6. i) Let $A$ be a $\mathbb{D}^{\infty}$-bounded process with values in
$n \times n-A . M$., and $\delta_{A}$ defined on the finite linear combinations of polynomials in Gaussian variables, by div $A$ grad.

Then: $\delta\left(\mathcal{C}_{m}\right) \subset \mathbb{D}^{\infty}(\Omega)$, and if $P$ is a polynomial in Gaussian variables, $\delta(P) \in \mathbb{D}^{\infty}(\Omega)$.
ii) Moreover if $\delta_{A}$ is defined on $\mathbb{D}_{\infty}^{2}$ and sends continuously $\mathbb{D}_{\infty}^{2}$ in $\mathbb{D}_{\infty}^{2}$, then $\delta_{A}$ sends $\mathbb{D}^{\infty}$-continuously $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega)$.

Remark 4..3. $\mathbb{D}_{\infty}^{2}$ is not an algebra, so $\delta_{A}$ cannot be called a derivation on $\mathbb{D}_{\infty}^{2}$.

Proof. i) Let $Q \in \mathcal{C}_{m}(\Omega)$. Then $\operatorname{grad} Q \in \mathcal{C}_{m-1}(\Omega, H)$ which can be written $(m>1)$ :

& =\int_{0}^{t} A_{k}^{j} \frac{Z_{j}(s, \omega)}{\sqrt{1+\|Z(s, .)\|_{L^{2}\left(\Omega, \mathbb{R}^{n}\right)}}} \sqrt{1+\|Z(s, .)\|_{L^{2}\left(\Omega, \mathbb{R}^{n}\right)}} d s \tag{6}
\end{align*}
$$

In this last integral $\frac{Z_{j}}{\sqrt{1+\|Z(s,)\|_{L^{2}\left(\Omega, \mathbb{R}^{n}\right)}}}$ belongs to $\mathcal{C}_{m-1}(\Omega)$ on which all $L^{p}$ norms are equivalent.

So $A_{k}^{j} \frac{Z_{j}(s, \omega)}{\sqrt{1+\|Z(s,)\|_{L^{2}\left(\Omega, \mathbb{R}^{n}\right)}}}$ is $\mathbb{D}^{\infty}$-bounded; and the measure $\sqrt{1+\|Z(s, .)\|_{L^{2}\left(\Omega, \mathbb{R}^{n}\right)}} \cdot d s$ is $L^{2}([0,1])$-bounded, so the r.h.s. integral in (6) is $\mathbb{D}^{\infty}$-bounded, which implies $\delta_{A} Q \in \mathbb{D}^{\infty}$.
ii) $\delta_{A}^{2}\left(e^{i P}\right), P$ being a polynomial in Gaussian variables is meaningful because $P \in \mathbb{D}_{\infty}^{2}$ implies $\delta_{A}\left(e^{i P}\right) \in \mathbb{D}_{\infty}^{2}$ so $\delta_{A}\left(\delta_{A} \cdot e^{i P}\right) \in \mathbb{D}_{\infty}^{2}$. Then $\operatorname{grad}\left(\delta_{A} e^{i P}\right)$ formally equals to $i e^{i P} \operatorname{grad}\left(\delta_{A} P\right)-e^{i P} \delta_{A} P . \operatorname{grad} P$ which is meaningful as a definition because $\mathbb{D}^{\infty}$ is an algebra.

Then div $\left[A \operatorname{grad} e^{i P}\right]=i e^{i P} \delta_{A} P=\delta_{A}\left(e^{i P}\right)$.
And $\delta_{A}^{2}\left(e^{i P}\right)=\operatorname{div} A \operatorname{grad}\left(\delta_{A}\left(e^{i P}\right)\right)$ which formally equals to:

since $A$ is antisymmetric.
Each of the two terms in the above sum is meaningful because

\mathbb{D}^{\infty} \times \mathbb{D}_{\infty}^{2}=\mathbb{D}_{\infty}^{2-0} ; \text { so: } \delta_{A}^{2}\left(e^{i P}\right)=i e^{i P} \delta_{A}^{2} P-e^{i P}\left(\delta_{A} P\right)^{2} \text { and } \\
\left(\delta_{A} P\right)^{2}=i \delta_{A}^{2} P-e^{-i P} \delta_{A}^{2}\left(e^{i P}\right) \tag{7}
\end{gather*}
$$

So with a sequence of polynomials in Gaussian variable $\mathbb{D}^{\infty}$-converging towards $f \in \mathbb{D}^{\infty}(\Omega)$, with (7) we see that $\delta_{A} f \in L^{4}(\Omega)$.

Then we have: $\delta_{A}: \mathbb{D}_{\infty}^{2} \rightarrow \mathbb{D}_{\infty}^{2}$ and also: $\delta_{A}: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{\infty}^{2} \cap L^{4}(\Omega)$.
By interpolation, we get: $\delta_{A}: \mathbb{D}_{\infty}^{2+} \rightarrow \mathbb{D}_{\infty}^{2+}$.
Now let $f \in \mathbb{D}^{\infty}(\Omega)$ and $g \in \mathbb{D}_{\infty}^{2+}$ : then $f g \in \mathbb{D}_{\infty}^{2+}$ and
$\delta_{A}(f g)=f \delta_{a} g+g \delta_{A} f$ which implies: $g \delta_{A} f \in \mathbb{D}_{\infty}^{2+}(\Omega)$.
So the operator multiplication by $\delta_{A} f$ is such that: $\mathbb{D}_{\infty}^{2+} \rightarrow \mathbb{D}_{\infty}^{2+}$; so $\delta_{A} f \in \mathbb{D}_{\infty}^{2+}($ with $g=1)$.

Then all powers of $\delta_{A} f$ are in $\mathbb{D}_{\infty}^{2+}$, which implies $\delta_{A} f \in \mathbb{D}^{\infty}$.
The $\mathbb{D}^{\infty}$-continuity of $\delta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}^{\infty}$ is obtained by the closed graph theorem and by the continuity of $\delta_{A}: \mathbb{D}_{\infty}^{2} \rightarrow \mathbb{D}_{\infty}^{2}$.

DEFINITION 4..4. $A \mathbb{D}_{\infty}^{2}$ multiplicative operator $A$, process from
$[0,1] \times \Omega$ to the $n \times n-A . M$. is an operator which acts $\mathbb{D}_{\infty}^{2}$-continuously by simple multiplication on functions: $\Omega \rightarrow \mathbb{R}^{n}$ that is:
$\forall r>1, \exists r^{\prime}>1, \exists C\left(r, r^{\prime}\right)>0: \forall f=\left(f_{1}, \ldots, f_{n}\right):$

LEmma 4..7. Let $A(t, \omega)$ be a $\mathbb{D}_{\infty}^{2}$-multiplicative operator, $n \times n$-A.M. valued. Then $A(t, \omega)$ is a multiplicator from $\mathbb{D}^{\infty}(\Omega, H)$ in $\mathbb{D}^{\infty}(\Omega, H)$.

Proof. let $\theta$ be the morphism defined on $\mathcal{C}_{1}(\Omega)$ by:

$\theta$ can be extended as a morphism from $\mathbb{D}_{\infty}^{2}$ in $\mathbb{D}_{\infty}^{2}$ because it leaves invariant the $L^{2}$ scalar product, each chaos $\mathcal{C}_{n}$, and it commutes with the O.U. operator.

Then $\theta$ is bijective and isometric from $\left(\mathcal{C}_{1}, \mathcal{F}_{1}\right)$ into $\left(\mathcal{C}_{1}, \mathcal{F}_{\frac{1}{2}}\right)$, so it induces a bijection from $L^{2}\left(\Omega, \mathcal{F}_{1}, \mathbb{P}\right)$ into $L^{2}\left(\Omega, \mathcal{F}_{\frac{1}{2}}, \mathbb{P}\right)$, and from $\mathbb{D}_{r}^{2}\left(\Omega, \mathcal{F}_{1}, \mathbb{P}\right)$ into $\mathbb{D}_{r}^{2}\left(\Omega, \mathcal{F}_{\frac{1}{2}}, \mathbb{P}\right)$.

We define: $\check{A}(s, \omega)=0$ if $s \leq \frac{1}{2}$
$\check{A}(s, \omega)=\theta A(2 s-1, \omega)$ if $\frac{1}{2}<s \leq 1$.
$\check{A}$ is an adapted process $\left(\theta: \mathcal{F}_{1} \rightarrow \mathcal{F}_{\frac{1}{2}}\right)$. Direct computation shows that $\check{A}$ is a $\mathbb{D}_{\infty}^{2} \cap \mathcal{F}_{\frac{1}{2}}$ multiplicative operator:

Then $\check{A}$ is a $\mathbb{D}_{\infty}^{2}(\Omega, H) \cap \mathcal{F}_{\frac{1}{2}}$ multiplicator.

\left.\begin{array}{l}
\forall X \in \mathbb{D}_{\infty}^{2}(\Omega, H) \cap \mathcal{F}_{\frac{1}{2}}: \\
\|\check{A} \cdot X\|_{\mathbb{D}_{r}^{2}(\Omega, H)}
\end{array}=\int \mathbb{P}(d \omega) \int_{0}^{1} d s\left\|(1-L)^{r / 2}\{\check{A}(s, \omega) X(s, \omega)\}\right\|_{\mathbb{R}^{n}}^{2}\right)
$$

Then $\delta_{\check{A}}=\operatorname{div} A$ grad is a $\mathbb{D}_{\infty}^{2}$-continuous operator on $\mathbb{D}_{\infty}^{2} \cap \mathcal{F}_{\frac{1}{2}}$.
With Theorem 2, 2, we get an extension $\widetilde{\delta}_{\check{A}}$ on
$\mathbb{D}_{\infty}^{2}\left[\left(\Omega, \mathcal{F}_{\frac{1}{2}}, \mathbb{P}\right) \times\left(\Omega, \mathcal{F}_{\frac{1}{2}}^{\perp}, \mathbb{P}\right)\right]=\mathbb{D}_{\infty}^{2}(\Omega)$.
This extension is $\mathbb{D}_{\infty}^{2}$-continuous. With Lemma $4 . .6$ ii) it is $\mathbb{D}^{\infty}$-continuous from $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega)$; using this continuity and direct computation, $\widetilde{\delta}_{\breve{A}}$ is a derivation, which is adapted because $\check{A}$ is adapted, so $\delta_{\check{A}}$ is an adapted derivation.

Now let $\left(V_{i}(s, \omega)\right)_{i=1, \ldots, n}$ be a $\mathbb{D}^{\infty}$-adapted vector field. Then $\int_{0}^{1} t V_{i} d B^{i}$ is an Itō integral, and:

\end{aligned}

Let $F=\widetilde{\delta}_{\tilde{A}}\left(\int_{0}^{1 t} V_{i} d B^{i}\right)$; with Clark-Ocone we have:

In this last equation, all integrals are Itō integrals so:

With Theorem $2,8, \mathbb{E}\left[(\operatorname{grad} F)_{i}(t) \mid \mathcal{F}_{t}\right]$ is a $\mathbb{D}^{\infty}$-vector field; which proves that ${ }^{t} V_{i}{ }^{t} \check{A}$ is a $\mathbb{D}^{\infty}$-vector field.

The map: $X \xrightarrow{\mu} \hat{X}(s, \omega)=X\left(\frac{s+1}{2}, \omega\right)$ is the left inverse of: $X \xrightarrow{\lambda} \check{X}$ and $\mu \circ \lambda(X(s, \omega))=X(s, \omega)$.

Let $V(s, \omega)$ be a possibly non-adapted $\mathbb{D}^{\infty}$-vector field; then ${ }^{t} \check{V}(s, \omega)$ is an adapted $\mathbb{D}^{\infty}$-vector field, and so is ${ }^{t} A .{ }^{t} \check{V}$; so using the left inverse map $\mu$ above, $A . V$ is a $\mathbb{D}^{\infty}$-vector field.

So $A$ is $\mathbb{D}^{\infty}(\Omega, H)$ multiplicator.
Corollary 4..1. If $A(s, \omega)$ is a process with values in $n \times n-A . M$., such that $\exists m \in \mathbb{N}_{\star}: \forall s \in[0,1]: A(s, \omega) \in \mathcal{C}_{m}$ and $\|A(s, .)\|_{L^{2}}$ is uniformly bounded (in s), then $A$ is a multiplicator.

Proof. Use Lemma 4..5, ii), and Lemma $4 . .7$
Now we go back to the end of the proof of Theorem 4..1:
We already know that $A$ being the $n \times n$ matrix with ${ }^{t} a_{j}^{i}(t, \omega)=\mathbb{E}\left[\left(\delta B_{1}^{i}\right)_{j}(t) \mid \mathcal{F}_{t}\right]$ is asymetrical, adapted. We now show that $A$ is a $\mathbb{D}^{\infty}(\Omega, H)$ multiplicator process.

The family $t \rightarrow \frac{B^{i}(t+\epsilon)-B_{t}^{i}}{\sqrt{\epsilon}}$ is in $\mathcal{C}_{1}(\Omega)$ and is $(t, \epsilon)$-uniformly $L^{2}$-bounded, and so is a family of multiplicators (Corollary 3,1 ), uniformly in $(t, \epsilon)$.

And if $h(t, \omega)=\int_{0}^{t} \dot{h}(s, \omega) d s$ is a $\mathbb{D}^{\infty}$-vector field then $\forall i=1, \ldots, n: t \rightarrow$ $\int_{0}^{t} \frac{B_{t+\epsilon}^{i}-B_{t}^{i}}{\sqrt{\epsilon}} \dot{h}(s, \omega) d s$ is a $\mathbb{D}^{\infty}$-vector field and:
$\delta\left[\int_{0}^{t}\left(\frac{B_{s+\epsilon}^{i}-B_{s}^{i}}{\sqrt{\epsilon}}\right) \dot{h}(s, \omega) d s\right]=\int_{0}^{t} \delta\left(\frac{B_{s+\epsilon}^{i}-B_{s}^{i}}{\sqrt{\epsilon}}\right) \dot{h}(s, \omega) d s+\int_{0}^{t}\left(\frac{B_{s+\epsilon}^{i}-B_{s}^{i}}{\sqrt{\epsilon}}\right) \delta \dot{h}(s, \omega) d s$
In the above equation, the first and last items are vector fields (in the first integral, $\delta$ is the extension of Corollary 2, 4); so $t \rightarrow \int_{0}^{t} \delta\left(\frac{B_{t+\epsilon}^{i}-B_{t}^{i}}{\sqrt{\epsilon}}\right) \dot{h}(s, \omega) d s$ is a $\mathbb{D}^{\infty}$-vector field, which proves that: $s \rightarrow \delta \frac{\left[B_{s+\epsilon}^{i}-B_{s}^{i}\right]}{\sqrt{\epsilon}}$ are multiplicators, $\epsilon$-uniformly $(0<\epsilon<1)$.

Then, with the Itō formula, and Lemma $4 . .3$ i):

& +\frac{1}{\epsilon}\left[\int_{s}^{s+\epsilon} d u \mathbb{E}\left[\sum_{k=1}^{n}\left(\int_{s}^{u} d B^{j}\right)^{2} \cdot\left({ }^{t} a_{k}^{i}\right)^{2}\right]\right]^{\frac{1}{2}} \tag{8}
\end{align*}

as ${ }^{t} a_{k}^{i}$ is $\mathbb{D}^{\infty}$-bounded (Lemma 4..4), we see that the r.h.s. of (8) is $L^{2}$-bounded.
But $F^{i, j}(\epsilon) \in \mathcal{F}_{s}^{\perp} \cap \mathcal{F}_{s+\epsilon}$; the filtration being right-continuous:

So $\left(F^{i, j}(\epsilon)\right)$ admits an adherence value, which is 0 , to which $F^{i, j}(\epsilon)$ converges $L^{2}$-weakly.

And as from (8) we see that $F^{i, j}(\epsilon)-\frac{1}{\epsilon} \int_{s}^{s+\epsilon} a_{i}^{j} d u$ admits a $L^{2}$-weak limit, we see that:

Then a net of barycenters $b_{i j}(\epsilon)$ constructed using the items of the sequence $\frac{B^{i}(s+\epsilon)-B^{i}(s)}{\sqrt{\epsilon}} \cdot \delta \frac{\left[B^{j}(s+\epsilon)-B^{j}(s)\right]}{\sqrt{\epsilon}}$ is $L^{2}$-strongly convergent towards ${ }^{t} a_{i}^{j}$.

But the $\frac{B^{i}(s+\epsilon)-B^{i}(s)}{\sqrt{\epsilon}} \cdot \delta \frac{\left[B^{j}(s+\epsilon)-B^{j}(s)\right]}{\sqrt{\epsilon}}$ are $\epsilon$-uniformly multiplicators; so are the $b_{i j}(\epsilon)$, as they are barycenters built on multiplicators.

Then, for $X \in \mathbb{D}^{\infty}(\Omega, H), b_{i j}(\epsilon) \cdot X$ converges in $L^{2}$ towards ${ }^{t} a_{i}^{j} X$ and the $b_{i j}(\epsilon) . X$ are uniformly $\mathbb{D}^{\infty}$-bounded; so by interpolation, the convergence of the $b_{i j}(\epsilon) . X$ is $\mathbb{D}^{\infty}(\Omega, H)$, which proves that ${ }^{t} a_{j}^{i}$ is a $\mathbb{D}^{\infty}$-multiplicator.

THEOREM 4..2. Let $U_{n}$ be a sequence of adapted $\mathbb{D}^{\infty}$-vector fields such that the associated derivations converge pointwise towards a derivation $\delta$, with zero divergence. Then $\delta \equiv 0$.

Proof. We remind that for $\delta \in D e r, \operatorname{div} \delta$ is an operator such that: $\forall \varphi \in$ $\mathbb{D}^{\infty}(\Omega):(\operatorname{div} \delta) \cdot \varphi=\int \delta \varphi$.

Denote by $\delta_{n}$ the derivation associated with $U_{n}$ :
$\forall \varphi \in \mathbb{D}^{\infty}(\Omega): \delta_{n} \varphi=U_{n} \cdot \varphi=\left\langle U_{n}, \operatorname{grad} \varphi\right\rangle_{H}$
Then $\operatorname{div} \delta_{n} \rightarrow \operatorname{div} \delta$ in the "distribution" meaning, that is:
$\int\left\langle U_{n}, \operatorname{grad} \varphi\right\rangle_{H} \rightarrow \int \delta \varphi, \forall \varphi \in \mathbb{D}^{\infty}(\Omega)$
By hypothesis: $\int\left\langle U_{n}, \operatorname{grad} \varphi\right\rangle_{H} d \mathbb{P} \rightarrow 0$,
Then: $\int\left(\operatorname{div} U_{n}\right) \cdot \varphi \mathbb{P}(d \omega) \rightarrow 0$, so $\operatorname{div} U_{n} \rightarrow 0$ as distributions $\in\left(\mathbb{D}^{\infty}\right)^{\star}$.

Then $\operatorname{grad}\left(\operatorname{div} U_{n}\right) \rightarrow 0$ as distributions $\in\left(\mathbb{D}^{\infty}(\Omega, H)\right)^{\star}$.
Then $\mathbb{E}\left[\overrightarrow{\operatorname{grad} \operatorname{div}} U_{n} \mid \mathcal{F}_{t}\right]$ is also a sequence of adapted vector fields, which as distributions of $\left(\mathbb{D}^{\infty}(\Omega, H)\right)^{\star}$ converges towards 0 as the operator projection on $\mathcal{F}_{t}$ is continuous.

$\int U_{n} d B=\operatorname{div} U_{n}$ (Skorokhod integral)
So $\mathbb{E}\left[\overrightarrow{\operatorname{grad} \operatorname{div}} U_{n} \mid \mathcal{F}_{t}\right]=U_{n}$ (Fundamental isometry).
Then $U_{n} \rightarrow 0$ as distributions $\in\left(\mathbb{D}^{\infty}(\Omega, H)\right)^{\star}$.
With: $\varphi \in \mathbb{D}^{\infty}(\Omega), \psi \in \mathbb{D}^{\infty}(\Omega)$, we have: $\varphi \operatorname{grad} \psi \in \mathbb{D}^{\infty}(\Omega, H)$ which implies:

$$
\int\left\langle U_{n}, \varphi \operatorname{grad} \psi\right\rangle_{H} \mathbb{P}(d \omega)=\int \varphi \cdot U_{n}(\psi) \mathbb{P}(d \omega) \rightarrow \int \varphi(\delta \psi) \mathbb{P}(d \omega)=0
$$

Corollary 4..2. An adapted derivation is not generally a limit of a sequence of adapted vector fields.

For the Corollary $4 . .3$ that follows, the notion of stochastic parallel transport of a vector $X$ in a Riemannian manifold is needed. It will be defined later in Section 5, and denoted $X_{/ /}(t, \omega)$.

Corollary 4..3. Given a compact Riemannian manifold $\left(V_{n}, g\right)$ and $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ being the set of continuous paths: $[0,1] \rightarrow V_{n}$, starting from
$m_{0} \in V_{n}$, there cannot be a global chart from $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ into the Wiener space such that:
i) it leaves the measure invariant.
ii) it has a continuous linear tangent map on the associated spaced of $\mathbb{D}^{\infty}$-continuous derivations.
iii) this tangent map sends a dense subset $\mathfrak{X}$ of the adapted vector fields:

$$
\mathfrak{X}=\left\{\sum_{i=1}^{n} a_{i}(t, \omega) e_{i / /}(t, \omega) \mid a_{i}(t, \omega) \text { adapted }\right\}
$$

in a dense subset of the adapted vector fields on the Wiener space; $\left(e_{i}\right)_{i=1, \ldots, n}$ being an orthonormal basis of $T_{m_{0}} V_{n}$.

Remark 4..4. This result proves that even another chart map than the Itō map, satisfying reasonable conditions, does not have a linear tangent map.

Proof. Suppose there exists such a global chart $\psi$ and that $T_{\psi}$ is the associated linear tangent map. From Theorem 4.1, we know that there is a derivation $\delta$ adapted, with a null divergence, and three vector fields $u, v, w$,
such that: $\delta=[u, v]-w$. Then from iii) there exist three sequences of $X$, $\left(u_{n}\right)_{n \in \mathbb{N}_{\star}},\left(v_{n}\right)_{n \in \mathbb{N}_{\star}},\left(w_{n}\right)_{n \in \mathbb{N}_{\star}}$, such that: $u_{n} \xrightarrow{\text { Der }} u, v_{n} \xrightarrow{\text { Der }} v, w_{n} \xrightarrow{\text { Der }} w ;$ as $\left(u_{n}\right)_{n \in \mathbb{N}_{\star}}$ is bounded in Der, by Banach-Steinhaus we have:
$\left[u_{n}, v_{n}\right] \xrightarrow{\text { Der }}[u, v]$; so $\left[u_{n}, v_{n}\right]-w_{n} \xrightarrow{\text { Der }} \delta$
and $T_{\psi}\left(\left[u_{n}, v_{n}\right]-w_{n}\right)=\left[T_{\psi} u_{n}, T_{\psi} v_{n}\right]-T_{\psi} w_{n} \xrightarrow{\text { Der }} T \delta$.
But by i): $\operatorname{div}\left(T_{\psi} \delta\right)=0$ ), and $\left[T_{\psi} u_{n}, T_{\psi} v_{n}\right]-T_{\psi} w_{n}$ is an adapted vector field.

Then Theorem 4..2 proves that $T_{\psi} \delta=0$, which implies $\delta=0$.

Remark 4..5. It is the property of adaptation that is at the root of this impossibility to find a regular enough global chart, which would admit a linear tangent map.

Remark 4..6. Instead of $\mathfrak{X}$ being the set of the adapted vector fields, we could have chosen any dense subset of adapted vector fields, because later we will see that the $\mathbb{D}^{\infty}$-module generated by such a subset is dense in the $\mathbb{D}^{\infty}$-continuous derivations.

Theorem 4..3. Let $X:[0,1] \times \Omega \rightarrow \mathbb{R}$ be an $\alpha$ - $\mathbb{D}^{\infty}$-Holderian process. Then $X$ is a $\mathbb{D}^{\infty}$-multiplicator.

Proof. From Theorem 2, 10, we know that $X=Y \star \beta_{s}$ with
$Y=\frac{d}{d t}\left(X \star \beta_{1-s}\right)$ and Y is completely $\mathbb{D}^{\infty}$.
Then fixing $\gamma>1$, and $q$ such that $0<q s<1$, there exists $p>1$ with $1+\frac{1}{\gamma}=\frac{1}{p}+\frac{1}{q}$.

Y being completely $\mathbb{D}^{\infty},\|Y(\omega, .)\|_{L^{p}([0,1], d t)} \in L^{\infty-0}(\Omega)$. So:

$$
\forall t:|X(t, \omega)|=\left|Y(., \omega) \star \beta_{s}(.)(t)\right| \leq\|Y(\omega, .)\|_{L^{p}([0,1], d t)}\left\|\beta_{s}\right\|_{L^{q}([0,1], d t)}
$$

And $\|Y(\omega, .)\|_{L^{p}([0,1], d t)} \in L^{\infty-0}(\Omega)$.
So with the Criterion 2, 2, we have that $X$ is a multiplicator.
Corollary 4..4. If $X: t \rightarrow \int_{0}^{t} \dot{h}(s, \omega) d s$ is a $\mathbb{D}^{\infty}$-vector field, then the process $X(t, \omega)$ is a $\mathbb{D}^{\infty}$-multiplicator.

## Proof.

$$
(1-L)^{r / 2}(X(t+\epsilon, \omega)-X(t, \omega))=\int_{t}^{t+\epsilon}(1-L)^{r / 2} \dot{h}(s, \omega) d s
$$

Then:

$$
\|X(t+\epsilon, .)-X(t, .)\|_{\mathbb{D}_{r}^{p}(\omega)} \leq \epsilon^{\frac{1}{2}}\left\|\left[\int_{0}^{1}\left|(1-L)^{r / 2} \dot{h}(s, \omega)\right|^{2} d s\right]^{\frac{1}{2}}\right\|_{L^{p}(\Omega)}
$$

so:

$$
\|X(t+\epsilon, .)-X(t, .)\|_{\mathbb{D}_{r}^{p}(\omega)} \leq \epsilon^{\frac{1}{2}}\|X\|_{\mathbb{D}_{r}^{p}(\Omega, H)}
$$

Theorem 4..4. If $X_{n}(t, \omega)$ is a sequence of processes, converging $\mathbb{D}^{\infty}$-towards $X(t, \omega)$, $t$-uniformly, then the vector fields $Y_{n}: t \rightarrow \int_{0}^{t} X_{n}(s, \omega) d s$ converges $\mathbb{D}^{\infty}(\Omega, H)$ towards the vector field $Y: t \rightarrow \int_{0}^{t} X(s, \omega) d s$.

Proof. Suppose $X(t, \omega)=0, \mathbb{P}-$ a.s.. Then:

$$
\begin{aligned}
\left\|Y_{n}\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}^{p} & =\int \mathbb{P}(d \omega)\left(\int_{0}^{1} d s\left|(1-L)^{r / 2} X_{n}(s, \omega)\right|^{2}\right)^{p / 2} \\
& \leq \int \mathbb{P}(d \omega) \int_{0}^{1} d s\left|(1-L)^{r / 2} X_{n}(s, \omega)\right|^{p} \\
& =\int_{0}^{1} d s\left\|X_{n}\right\|_{\mathbb{D}_{r}^{p}(\Omega)}^{p}
\end{aligned}
$$

Theorem 4..5. If $X$ is a $\mathbb{D}^{\infty}$-vector field, the associated process is $\mathbb{D}^{\infty}$-bounded.

Proof. $X(t, \omega)=\int_{0}^{t} \dot{h}(s, \omega) d s$. Then: $X(t, \omega)=\left\langle h(s, \omega), u \rightarrow \int_{0}^{u} \mathbb{1}_{[0, t]}(s) d s\right\rangle_{H}$.

ThEOREM 4..6. If $A_{n}(t, \omega)$ is a $n$-uniform sequence of multiplicators, and if $A_{n}(t, \omega)$ converges $\mathbb{P}(d \omega) \otimes d s[0,1]$-a.s. towards $A$, then $A_{n}$ converges, in the multiplicator sense, towards $A$.

Remark 4..7. Convergence in the multiplicator sense means that $\forall(p, r)$ $A_{n}$ converges strongly as operators towards $A$ :

$$
\forall X \in H,\left\|A_{n} X-A X\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)} \rightarrow 0
$$

Proof. Using the theorem on conditions of equivalence of $L^{p}$-convergence and a.s.-convergence, when the $L^{p}$ norms of the sequence are uniformly bounded and the measure is finite.

## 4. 4 Any adapted multiplicator is a limit of a sequence of "step-multiplicators"

Theorem 4..7. Any adapted multiplicator $A$ is a limit in the multiplicator sense of a sequence of adapted "step multiplicators", that is that have the form:

$$
\sum_{i=0}^{k} \mathbb{1}_{\left[t_{i}, t_{i+1}[ \right.}(t) A\left(t_{i}, \omega\right),
$$

where $A\left(t_{i}, \omega\right) \in \mathcal{F}_{t_{i}}$ and $A\left(t_{i}, \omega\right)$ being a multiplicator. $\left(t_{0}=0, t_{k-1}=1\right)$.
Proof. a) We first prove than any adapted multiplicator is a limit of a sequence $A_{n}$ of continuous multiplicators, in a "multiplicator sense", that is $A_{n}$ converges towards $A$, strongly as operators;
for each $\mathbb{D}_{r}^{p}(\Omega, H): \forall X \in H: A_{n} X \xrightarrow{\mathbb{D}_{r}^{p}(\Omega, H)} A X$.
b) Let $u(t, \omega)$ be a $\mathbb{D}^{\infty}$-vector field and for $\left.\lambda \in\right] 0,1\left[\right.$, we denote by $v_{\lambda}$ the vector field:
$v_{\lambda}(t, \omega)=\int_{0}^{t} \mathbb{1}_{[0, \lambda]}(s) \dot{u}\left(\frac{s}{\lambda}, \omega\right) \frac{1}{\sqrt{\lambda}} d s$
Then straightforward computation shows that: $\left\|v_{\lambda}\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}=\|u\|_{\mathbb{D}_{r}^{p}(\Omega, H)}$. Now we denote by $A_{\lambda}(t, \omega)=A(\lambda t, \omega)$.

Straight computation gives:

$$
\begin{aligned}
\left\|A_{\lambda}(t, \omega) u(t, \omega)\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)} & =\left\|A(t, \omega) v_{\lambda}(t, \omega)\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)} \\
& \leq C\left(p, r, p^{\prime}, r^{\prime}\right)\left\|v_{\lambda}(r, \omega)\right\|_{\mathbb{D}_{r^{\prime}}^{p^{\prime}}(\Omega, H)} \\
& \leq C\left(p, r, p^{\prime}, r^{\prime}\right)\|u(t, \omega)\|_{\mathbb{D}_{r^{\prime}}^{p^{\prime}}(\Omega, H)}
\end{aligned}
$$

$C\left(p, r, p^{\prime}, r^{\prime}\right)$ being a constant.
So the family $A_{\lambda}$ is a $\lambda$-uniform family of multiplicators.
Then the $\widetilde{A}_{n}(t, \omega)=n \int_{1-\frac{1}{n}}^{1} A_{\lambda}(t, \omega) d \lambda$ are $n$-uniformly multiplicators.

$$
\left\|\widetilde{A}_{n} X\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)} \leq n \int_{1-\frac{1}{n}}^{1}\left\|A_{\lambda}(t, \omega) X\right\|_{\mathbb{D}_{r}^{p}} d \lambda \leq C\left(p, r, p^{\prime}, r^{\prime}\right)\|X\|_{\mathbb{D}_{r^{\prime}}^{p^{\prime}}(\Omega, H)}
$$

As $\widetilde{A}_{n} \rightarrow A, L^{2}([0,1] \times \Omega)$-a.s., we have with Theorem 4..6, that $t^{\frac{1}{n}} \widetilde{A}_{n} \rightarrow A$ in the multiplicator sense, and each $\widetilde{A}_{n}$ is continuous and adapted.
b) Now we prove that any continuous, adapted multiplicator is a limit, in the multiplicator sense, of adapted step-multiplicators.

If $u(t, \omega)=\int_{0}^{t} \dot{u}(s, \omega) d s$, let $\varphi$ be an increasing bijection of $[0,1]$ on itself, such that $\varphi \in \mathcal{C}^{1}([0,1])$, and $\varphi^{\prime}(t)>C_{0}, C_{0}$ constant $>0$.

And we denote by: $u_{\varphi}(t, \omega)=\int_{0}^{t} \dot{u}\left(\varphi^{-1}(s), \omega\right) \sqrt{\left(\varphi^{-1}\right)^{\prime}(s)} d s, \varphi^{-1}$ being the inverse function of $\varphi$.

Straight computation shows that: $\left\|u_{\varphi}\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}=\|u\|_{\mathbb{D}_{r}^{p}(\Omega, H)}$
Then we define $\left(A_{\varphi} u\right)(t, \omega)=\int_{0}^{t} A[\varphi(s), \omega] \dot{u}(\beta, \omega) d s$.

Straight computation shows: $\left\|A_{\varphi} u\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}=\left\|A u_{\varphi}\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}$
So the family $A_{\varphi}$ is $\varphi$-uniformly a family of adapted multiplicators.
c) If $\psi$ is a step function on $[0,1]$, there exists a sequence $\varphi_{k}$ of functions like in b), which converges towards $\psi$.

Then $A_{n}\left(\varphi_{k}(),. \omega\right)$ converges towards $A_{n}(\varphi(),. \omega)$ in the multiplicator sense thanks to the continuity of $A_{n}$, and this convergence is uniform relatively to the step functions $\psi$.
d) Now there exists a sequence of step functions converging towards $t$ on $[0,1]$ from below, denoted $\psi_{l}, l \in \mathbb{N}_{\star}$. Then $A_{n}\left(\psi_{l}(),. \omega\right)$ will converge in the multiplicator sense towards $A_{n}(t, \omega)$, which converges in the multiplicator sense towards $A(t, \omega)$.

And $A\left(\sum_{i=0}^{k} a_{i} \mathbb{1}_{\left[t_{i}, t_{i+1}\right]}(t), \omega\right)=\sum_{i=0}^{k} \mathbb{1}_{\left[t_{i}, t_{i+1}\right]} A\left(a_{i}, \omega\right)$.

## 5. $\mathbb{D}^{\infty}$-morphisms, charts maps, and inversibility

## 5. 1 Theorems showing under which conditions a $\mathbb{D}^{\infty}$-morphism is a $\mathbb{D}^{\infty}$-diffeomorphism

Unless otherwise specified, the setting is a Gaussian space $(\Omega, \mathcal{F}, \mathbb{P}, H) . \mathcal{U}$ is an adapted process with values in $n \times n$ unitary matrices, and a multiplicator; the map $\theta_{\mathcal{U}}$ on $\mathcal{C}_{1}(\Omega)$ :

$$
\theta_{\mathcal{U}}(W(h))=\int_{0}^{1}{ }^{t} \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B
$$

where B is a $n$-dimensional Brownian, and $h \in H$, can be extended in an injective morphism on $\mathrm{L}^{\infty-0}(\Omega)$, because it preserves laws. In this chapter we will study some conditions under which $\theta$ can be a $\mathbb{D}^{\infty}$-morphism, or a $\mathbb{D}^{\infty}$-isomorphism.

Let $\left(\Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right), i=1,2$, two Gaussian spaces and denote by $\mathcal{M}$ :
$\mathcal{M}=\left\{m / m\right.$ map of $\Omega_{1}$ in unitary operators on $H_{2}$ such that $m$ is a $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right)$-multiplicator and there exists $m^{-1} \in \mathcal{M}$ such that: $\left.m^{-1}\left(\omega_{1}\right)=\left(m\left(\omega_{1}\right)\right)^{-1}\right\}$.

Remark 5..1. $m$, $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right)$-multiplicator, means that:

$$
\forall \alpha \in \mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right), m\left(\omega_{1}\right) \alpha\left(\omega_{1}\right) \text { is a } \mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right) \text { vector field. }
$$

Remark 5..2. The existence's condition of $m^{-1}$ is useless if $m$ has the form $\mathcal{U}(t, \omega)$ where $\mathcal{U}$ is a unitary operator on a finite dimensional space $\mathcal{U}^{-1}=$ $\left.\mathcal{U}^{*}\right)$.

Notation. We denote by $W_{i}\left(h_{i}\right), \operatorname{grad}_{i}, \operatorname{div}_{i}$, Gaussian variables, Malliavin derivatives, and divergences built respectively on $\left(\Omega_{i}, \mathcal{F}_{i}, \mathbb{P}_{i}, H_{i}\right), i=1,2$; otherwise $W$, grad, and div relate to $\left(\Omega_{1} \times \Omega_{2}, \mathcal{F}_{1} \otimes \mathcal{F}_{2}, \mathbb{P}_{1} \otimes \mathbb{P}_{2}, H_{1} \oplus H_{2}\right)$.

Let $m \in \mathcal{M}$, and denote $\theta_{m}: \mathcal{C}_{1}\left(\Omega_{1} \times \Omega_{2}\right) \rightarrow \mathrm{L}^{\infty-0}\left(\Omega_{1} \times \Omega_{2}\right)$ an $\mathbb{R}$-linear map defined by:

$$
\begin{aligned}
\theta_{m}\left[W_{1}\left(h_{1}\right)\right] & =W_{1}\left(h_{1}\right), \quad h_{1} \in H_{1}, \\
\theta_{m}\left[W_{2}\left(h_{2}\right)\right] & =\left(\omega_{1} \rightarrow W_{2}\left(m\left(\omega_{1}\right) h_{2}\right)\right), \quad h_{2} \in H_{2} .
\end{aligned}
$$

Then we extend $\theta_{m}$ on Gaussian polynomials as an algebraic morphism and denote it again by $\theta_{m}$.

Theorem 5..1.
i) if $m \in \mathcal{M}$, Range $\theta_{m} \in \mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$.
ii) $\theta_{m}$ can be extended in a bicontinuous bijection of $\mathrm{L}^{\infty-0}$ on itself.

Proof. i). Let $\left(\varepsilon_{j}\right)_{j \in \mathbb{N}_{*}}$ be an Hilbertian basis of $H_{2}$ and $h_{2} \in H_{2}$ :

$$
\begin{aligned}
\operatorname{div}\left[m\left(\omega_{1}\right) h_{2}\right] & =\sum_{j=1}^{\infty} \operatorname{div}\left[f^{j}\left(\omega_{1}\right) \varepsilon_{j}\right] \\
& =\sum_{j=1}^{\infty} f^{j}\left(\omega_{1}\right) W_{2}\left(\varepsilon_{j}\right)+\left\langle\operatorname{grad}_{1} f^{j}\left(\omega_{1}\right), \varepsilon_{j}\right\rangle_{H_{1} \oplus H_{2}} \\
& =W_{2}\left[\sum_{j=1}^{\infty} f^{j}\left(\omega_{1}\right) \varepsilon_{j}\right] \\
& =\theta_{m}\left[W_{2}\left(h_{2}\right)\right] \Longrightarrow \theta_{m}\left[W_{2}\left(h_{2}\right)\right] \in \mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right) .
\end{aligned}
$$

ii). $a_{1}$ and $a_{2}$ being numerical constants, direct calculation shows:
$\theta_{m}\left[a_{1} W_{1}\left(h_{1}\right)+a_{2} W_{2}\left(h_{2}\right)\right]$ is a Gaussian variable which has the same law than $W\left[a_{1} h_{1}+a_{2} h_{2}\right]$. So $\theta_{m}$ can be extended by continuity to $\mathrm{L}^{\infty-0}\left(\Omega_{1} \times \Omega_{2}\right)$ and is a map of $\mathrm{L}^{\infty-0}\left(\Omega_{1} \times \Omega_{2}\right)$ in itself, again denoted $\theta_{m}$. Then:

\theta_{m^{-1}} \circ \theta_{m}\left[W_{1}\left(h_{1}\right)\right]=W\left(h_{1}\right)
$$

and

\begin{aligned}
\theta_{m^{-1}} \circ \theta_{m}\left[W_{2}\left(h_{2}\right)\right] & =\theta_{m^{-1}}\left[\operatorname{div}\left(m\left(\omega_{1}\right) h_{2}\right)\right] \\
& =\theta_{m^{-1}}\left[\sum_{j=1}^{\infty} f^{j}\left(\omega_{1}\right) W_{2}\left(\varepsilon_{j}\right)\right]
\end{aligned}
$$

$$
\begin{aligned}
& =\sum_{j=1}^{\infty} f^{j}\left(\omega_{1}\right) \theta_{m^{-1}}\left[W_{2}\left(\varepsilon_{j}\right)\right] \\
& =\sum_{j=1}^{\infty} f^{j}\left(\omega_{1}\right) \operatorname{div}\left[m^{-1}\left(\omega_{1}\right) \varepsilon_{j}\right] \\
& =\sum_{j=1}^{\infty} \operatorname{div}\left[f^{j}\left(\omega_{1}\right) m^{-1}\left(\omega_{1}\right) \varepsilon_{j}\right] \\
& =\operatorname{div}\left[m^{-1}\left(\omega_{1}\right)\left(\sum_{j=1}^{\infty} f^{j}\left(\omega_{1}\right) \varepsilon_{j}\right)\right] \\
& =\operatorname{div} h_{2}=W_{2}\left(h_{2}\right) .
\end{aligned}
$$

We extend $m$ to $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{1} \oplus H_{2}\right)$, again denoted by $m$, by:

\forall V \in \mathbb{D}^{\infty}\left(\Omega_{1}, H_{1}\right), m\left(\omega_{1}\right) V=V .

Then, we extend $m$ to $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H_{1} \oplus H_{2}\right)$ in intself denoted again by $m$, with Theorem 2.2.i. This last extension is $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$-linear because it is $\mathbb{D}^{\infty}\left(\Omega_{i}\right)$-linear $(i=1,2)$, so is linear for finite sum of products like $\alpha\left(\omega_{1}\right) \beta\left(\omega_{2}\right), \alpha\left(\omega_{1}\right) \in \mathbb{D}^{\infty}\left(\Omega_{1}\right), \beta\left(\omega_{2}\right) \in \mathbb{D}^{\infty}\left(\Omega_{2}\right)$ and, by $\mathbb{D}^{\infty}$-density of these linear combinations in $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$, is $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$-linear.

Denote $H=H_{1} \oplus H_{2} .\left(e_{j}\right)_{j \in \mathbb{N}_{*}}$ being an Hilbertian basis of $H$, we define $m_{R}$, a linear operation from a subset of $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H \otimes H\right)$ by $m_{R}\left(\sum_{j=1}^{k} e_{j} \otimes Y_{j}\right)=e_{j} \otimes m\left(Y_{j}\right)$, the $Y_{j}$ being $\mathbb{D}^{\infty}$-vector fields in $\mathbb{D}^{\infty}(\Omega, H)$. Then it is easy to check that: if $X_{j}, j=1, \ldots, k$ are constant vectors of $H$,

so the definition of $m_{R}$ does not depend on the choosen Hilbertian basis. With Theorem 2.4 and Corollary 2.4, we extend $m_{R}$ in an $\mathbb{D}^{\infty}$-continuous operator on $\mathbb{D}^{\infty}\left(\Omega, H_{1} \oplus H_{2}\right)$. We can also define an operator, $\operatorname{div}_{R}$, on $\sum_{j=1}^{k} X_{j} \otimes Y_{j}$, the $X_{j}$ being constant vectors of $H$, by

\operatorname{div}_{R}\left(\sum_{j=1}^{k} X_{j} \otimes Y_{j}\right)=\sum_{j=1}^{k}\left(\operatorname{div} Y_{j}\right) X_{j} .

Again, thanks to the extension Theorem 2.4 and Corollary 2.4, we can extend $\operatorname{div}_{R}$ in an $\mathbb{D}^{\infty}$-continuous operator from $\mathbb{D}^{\infty}(\Omega, H \otimes H)$ in $\mathbb{D}^{\infty}(\Omega, H)$, denoted again $\operatorname{div}_{R}$. Then:

Lemma 5..1. If $X \in \mathbb{D}^{\infty}(\Omega, H)$, $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ being an Hibertian basis of $H$, then

& =\sum_{i=1}^{\infty}\left(\sum_{j=1}^{N}\left\langle\operatorname{grad}\left(\left\langle\operatorname{grad} X^{j}, e_{j}\right\rangle_{H}\right), e_{i}\right\rangle_{H} e_{i}\right)+\sum_{j=1}^{N}\left(\operatorname{grad} X^{j}\right) W\left(e_{j}\right) \\
& =\lim _{\substack{k \uparrow \infty \\
k>N}}\left[\sum_{i=1}^{k} \sum_{j=1}^{N}\left\langle\operatorname{grad}\left(\left\langle\operatorname{grad} X^{j}, e_{j}\right\rangle_{H}\right), e_{i}\right\rangle_{H} e_{i}\right]+\sum_{j=1}^{N}\left(\operatorname{grad} X^{j}\right) W\left(e_{j}\right) \\
& =\operatorname{div}_{R}(\operatorname{grad} X),
\end{aligned}
$$

because

$$
\operatorname{grad} X=\sum_{j=1}^{N} \operatorname{grad} X^{j} \otimes e_{j}=\lim _{k \uparrow \infty} \sum_{i=1}^{k}\left[e_{i} \otimes\left(\sum_{j=1}^{N}\left\langle\operatorname{grad} X^{j}, e_{i}\right\rangle_{H} e_{j}\right)\right],
$$

and

$$
\begin{gathered}
\operatorname{div}_{R}(\operatorname{grad} X)=\lim _{k \uparrow \infty} \sum_{i=1}^{k}\left[e_{i} \operatorname{div}\left(\sum_{j=1}^{N}\left\langle\operatorname{grad} X^{j}, e_{i}\right\rangle_{H} e_{j}\right)\right] \\
=\lim _{k \uparrow \infty} \sum_{i=1}^{k} \sum_{j=1}^{N} e_{i}\left[\left\langle\operatorname{grad} X^{j}, e_{i}\right\rangle_{H} W\left(e_{j}\right)+\left\langle e_{j}, \operatorname{grad}\left(\left\langle\operatorname{grad} X^{j}, e_{i}\right\rangle_{H}\right)\right\rangle_{H}\right] \\
=\sum_{j=1}^{N} \operatorname{grad} X^{j} W\left(e_{j}\right)+\lim _{k \uparrow \infty} \sum_{i=1}^{k} \sum_{j=1}^{N}\left\langle e_{j}, \operatorname{grad}\left(\left\langle\operatorname{grad} X^{j}, e_{i}\right\rangle_{H}\right)\right\rangle_{H} e_{i}
\end{gathered}
$$

and as $X \in \mathbb{D}^{\infty}(\Omega, H)$, we have

\left\langle e_{j}, \operatorname{grad}\left(\left\langle\operatorname{grad} X^{j}, e_{i}\right\rangle_{H}\right)\right\rangle_{H}=\left\langle e_{i}, \operatorname{grad}\left(\left\langle\operatorname{grad} X^{j}, e_{j}\right\rangle_{H}\right)\right\rangle_{H} .
$$

Let $V \in \mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$. We define an $\mathbb{R}$-linear operator $\delta$ on $\mathbb{D}^{\infty}\left(\Omega_{1} \times\right.$ $\left.\Omega_{2}, H\right)$ by:

$\delta$ is well defined and goes from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$ in itself.

Lemma 5..2. If $V_{1}\left(\omega_{1}\right) \in H_{1}, V_{2}\left(\omega_{2}\right) \in H_{2}$, then

\operatorname{div}_{R}\left[m_{R}\left(V_{1} \otimes V_{2}\right)\right]=\tilde{\theta}_{m}\left(\operatorname{div}_{R}\left(V_{1} \otimes V_{2}\right)\right)
$$

$\tilde{\theta}_{m}$ being the extension of $\theta_{m}$, as in Corollary 2.3.
Proof. Straightforward computation.
We now return to the operator $\delta$ defined in (1).
Theorem 5..2. i) $\delta$ sends $\mathbb{D}^{\infty}(\Omega, H)$ in $\mathbb{D}^{\infty}(\Omega, H)$, continuously. ii) $\delta[\operatorname{grad}(f g)]=f \delta(\operatorname{grad} g)+g \delta(\operatorname{grad} f)$, for all $f, g \in \mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$.

Proof. i). All operators in $\delta$ are continuous from $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H \otimes H\right)$, or $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H \otimes H\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$.
ii). Direct calculus on the following cases: $f_{1}\left(\omega_{1}\right) g_{1}\left(\omega_{1}\right), f_{1}\left(\omega_{1}\right) g_{2}\left(\omega_{2}\right)$, $f_{2}\left(\omega_{2}\right) g_{2}\left(\omega_{2}\right), f_{i}, g_{i}, i=1,2$ being functions of $\mathbb{D}^{\infty}\left(\Omega_{i}\right)$.

Theorem 5..3. $\theta_{m}$ can be extended in a bicontinuous bijection of $\mathbb{D}^{\infty}\left(\Omega_{1} \times\right.$ $\Omega_{2}$ ) in itself.

Proof. The only points left to prove, after Theorem 5..1, are Range $\theta_{m} \subset$ $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ and the $\mathbb{D}^{\infty}$-continuity of $\theta_{m}$. If we denote $\tilde{\theta}_{m}$ the extension of $\theta_{m}$ to $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$ in $\mathrm{L}^{\infty-0}(\Omega, H)$ as in Corollary 2.3, we have:

$\tilde{\theta}_{m} \circ \delta(\operatorname{grad})$ and $\operatorname{grad} \theta_{m}$ are two $\theta$-derivations (cf. Definition 2.3) which coincide on $W\left(h_{1}\right), h_{1}$ constant vector of $H_{1}$ and $W\left(h_{2}\right), h_{2}$ constant vector of $H_{2}$ : with lemmas $5 . .1$ and $5 . .2$, we have

& =\operatorname{div}_{R}\left(m_{R} m_{R}^{-1} \operatorname{grad} m h_{2}\right)+m h_{2} \\
& =\operatorname{div}_{R}\left(\operatorname{grad} m h_{2}\right)+m h_{2} \\
& =\operatorname{grad}\left(\operatorname{div} m h_{2}\right)-m h_{2}+m h_{2} \\
& =\operatorname{grad} \operatorname{div}\left(m h_{2}\right) \\
& =\operatorname{grad} \theta_{m}\left[W_{2}\left(h_{2}\right)\right] .
\end{aligned}
$$

Then $\tilde{\theta}_{m} \circ \delta(\operatorname{grad})$ and $\operatorname{grad} \theta_{m}$ coincide on all polynomials on Gaussian variables, and as they both are $\mathbb{D}^{\infty}$-continuous $\theta$-derivations, then on $\mathbb{D}^{\infty}$-functions.

Now we proceed by induction: suppose $\theta_{m}$ sends continuously $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ in $\mathbb{D}_{r}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$; then $\tilde{\theta}_{m}$ sends continuously $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$ in $\mathbb{D}_{r}^{\infty}\left(\Omega_{1} \times \Omega_{2}, H\right)$.

And for all $f \in \mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$, we will have

\tilde{\theta}_{m}[\delta \operatorname{grad} f]=\operatorname{grad} \theta_{m} f
$$

which implies $\theta_{m} f \in \mathbb{D}_{r+1}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$. The $\mathbb{D}^{\infty}$-continuity of $\theta_{m}$ is obtained with the closed graph theorem.

Theorem 5..4 (Reciprocal of Theorem 5..3). In the same setting than previously, let $m$ be an operator from $\Omega_{1}$ into the unitary operators on $H_{2}$; we can define a map $\theta_{m}$ :

\theta_{m}\left[W_{1}\left(H_{1}\right)\right] & =W_{1}\left(h_{1}\right), h_{1} \in H_{1}, \\
\theta_{m}\left[W_{2}\left(h_{2}\right)\right] & =\operatorname{div}\left(m h_{2}\right), h_{2} \in H_{2} .
\end{aligned}
$$

And suppose that $\theta_{m}$ can be extended in a diffeomorphism of $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$ in itself. Then $m$, and $m^{-1}$, are $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right)$ multiplicators.

Proof. Straightforward computation shows that if if $X \in \mathbb{D}^{\infty}\left(\Omega_{2}, H_{2}\right), X$ constant, then $m X=\operatorname{grad}_{2} \theta_{m}[\operatorname{div} X]$ because $m$ depends only of varaibles in $\Omega_{1}$, and so relatively to the $\Omega_{2}$-variables, is constant.

If $f \in \mathbb{D}^{\infty}\left(\Omega_{1}\right)$, we also have

$$
\theta_{m}(f \operatorname{div} X)=f \theta_{m}(\operatorname{div} X),
$$

and again

\operatorname{grad}_{2} \theta_{m}[f \operatorname{div} X]=f m X=m\left(f\left(\omega_{1}\right) X\right)
$$

Now $m\left(\omega_{1}\right)$ is $\mathrm{L}^{\infty-0}\left(\Omega_{1}, H_{2}\right)$-continuous became $m$ is unitary ; so $m(\cdot)$ is closed in the $\mathbb{D}^{\infty}$-topology which is finer than the $\mathrm{L}^{\infty-0}$-topology. So the finite linear sums like:

$\left(\varepsilon_{i}\right)_{i \in \mathbb{N}_{*}}$ an Hilbertian basis of $H_{2}$ and $f\left(\omega_{1}\right) \in \mathbb{D}^{\infty}\left(\Omega_{1}\right)$, being a dense set in $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right), m$ is a multiplicator from $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right)$ in itself.

Same demonstration for $m^{-1}$.
Remark 5..3. A particular case of 5 ..2 2 is the following: let $\left.t_{0} \in\right] 0,1\left[, \mathcal{W}_{1}\right.$ the Wiener space built on $\left[0, t_{0}\right]$ and $\mathcal{W}_{2}$ the Wiener space built on $\left[t_{0}, 1\right]$, and $\mathcal{U}_{1}\left(t, \omega_{1}\right)$ an unitary operator of $\mathbb{R}^{n}$ to $\mathbb{R}^{n}$, which is a multiplicator and such that $\forall t \in\left[t_{0}, 1\right], \mathcal{U}_{1}\left(t, \omega_{1}\right) \in \mathcal{F}_{t_{0}}$. Let

\mathcal{U}\left(t, \omega_{1}\right)=\mathbb{1}_{\left[0, t_{0}[ \right.}(t) \operatorname{Id}_{\mathbb{R}^{n}}+\mathcal{U}_{1}\left(t, \omega_{1}\right) \mathbb{1}_{\left[t_{0}, 1\right]}(t),
$$

and let
$m\left(\omega_{1}\right) h_{1}(t)=\int_{0}^{t \wedge t_{0}} \dot{h}_{1}(s) \mathrm{d} s, h_{1} \in H_{1} \quad\left(H_{1}\right.$ the Cameron-Martin space of $\left.\mathcal{W}_{1}\right)$
and
$m\left(\omega_{1}\right) h_{2}(t)=\int_{t_{0}}^{t} \mathcal{U}^{-1}\left(s, \omega_{1}\right) \dot{h}_{2}(s) \mathrm{d} s, h_{2} \in H_{2} \quad\left(H_{2}\right.$ the Cameron-Martin space of $\left.\mathcal{W}_{2}\right)$.
It is easy to see that such an operator $m$ is a multiplicator of $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right)$ in $\mathbb{D}^{\infty}\left(\Omega_{1}, H_{2}\right)$ and that $m\left(\omega_{1}\right)$ is an unitary operator on $H_{2}$. So as in Theorem 5.3, if we denote

\theta_{m}\left[W\left(h_{1}\right)\right] & =W\left(h_{1}\right), \\
\text { and } \theta_{m}\left[W\left(h_{2}\right)\right] & =\int_{0}^{1}{ }^{t} \dot{h}_{2} \mathcal{U}^{-1} \cdot \mathrm{~d} B,
\end{aligned}
$$

$\theta_{m}$ can be extende in a $\mathbb{D}^{\infty}$-diffeomorphism of $\mathbb{D}^{\infty}\left(\mathcal{W}_{1} \times \mathcal{W}_{2}\right)$ in itself.
Conversely, if $\mathcal{U}_{1}$ is such as in this remark $5 . .3$ and if the $\theta_{m}$ associated to $\mathcal{U}_{1}$ is a $\mathbb{D}^{\infty}$-diffeomorphism, then $m$ is a multiplicator.

Proof. Use Theorem 5..4.
Example (Process $\mathcal{U}$, adapted, multiplicator, with values in $n \times n$-unitary matrices such that the associated $\theta_{\mathcal{U}}\left(\theta_{\mathcal{U}}(W(h))=\int_{0}^{1} t \dot{\mathcal{U}}^{-1} \cdot \mathrm{~d} B\right)$ is not a $\mathbb{D}^{\infty}$-diffeomorphism). Let $\left(X_{t}, Y_{t}\right)$ a standard brownian on $\mathbb{R}^{2}$ and let

\end{array}\right) .

$\mathcal{U}(t, \omega)$ is an unitary operator on $H_{1} \oplus H_{2}$.
To show that $\mathcal{U}(t, \omega)$ is a multiuplicator, we use the criterium 4.1:
$\forall r>1, \exists s>1, \exists C(r, s), \forall f \in \mathbb{D}_{\infty}^{2}\left(\Omega, \mathbb{R}^{2}\right)$, the map $f \mapsto \mathcal{U}(t, w) f\left(\mathbb{D}_{r}^{2} \rightarrow \mathbb{D}_{s}^{2}\right)$ is bounded with a norm less or equal than $C(r, s)$; we note that $X_{t} / \sqrt{t}$ is in $\mathcal{C}^{1}$ (for a fixed $t$ ) so $\exists h_{t} \in H_{1}, X_{t} / \sqrt{t}=W\left(h_{t}\right)$. Then

Then straightforward computation shows that the map $f \mapsto \mathcal{U}(t, \omega) f$ verifies the above mentionned criterium 4.1. (To simplify the calculus, use lemma 4.1.i).

Now let $A$ the process

D_{a} Y_{t} & =\int_{0}^{t} a(s, \omega) \cdot \mathrm{d} X_{s}
\end{aligned}

Then
$\theta_{\mathcal{U}}\binom{X_{t}}{Y_{t}}=\int_{0}^{t}\left(\begin{array}{cc}\cos \frac{X_{s}}{\sqrt{s}} & -\sin \frac{X_{s}}{\sqrt{s}} \\ \sin \frac{X_{s}}{\sqrt{s}} & \cos \frac{X_{s}}{\sqrt{s}}\end{array}\right) \cdot\binom{\mathrm{d} X_{s}}{\mathrm{~d} Y_{s}}=\binom{\int_{0}^{t} \cos \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} X_{s}-\int_{0}^{t} \sin \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} Y_{s}}{\int_{0}^{t} \sin \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} X_{s}+\int_{0}^{t} \cos \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} Y_{s}}$
From that we deduce

& +\int_{0}^{t} \frac{1}{\sqrt{s}} \cos \frac{X_{s}}{\sqrt{s}}\left(\int_{0}^{s} a(u, \omega) \cdot \mathrm{d} Y_{u}\right) \cdot \mathrm{d} Y_{s}-\int_{0}^{t} \sin \frac{X_{s}}{\sqrt{s}} a(s, \omega) \cdot \mathrm{d} X_{s}, \\
D_{a}\left(\theta_{u}\left(Y_{t}\right)\right) & =-\int_{0}^{t} \frac{1}{\sqrt{s}} \cos \frac{X_{s}}{\sqrt{s}}\left(\int_{0}^{s} a(u, \omega) \cdot \mathrm{d} Y_{u}\right) \cdot \mathrm{d} X_{s}-\int_{0}^{t} \sin \frac{X_{s}}{\sqrt{s}} a(s, \omega) \cdot \mathrm{d} Y_{s} \\

Now let suppose that $\theta_{\mathcal{U}}$ admits an inverse which is a $\mathbb{D}^{\infty}$-morphism ; we will show that

Lemma 5..3. $\theta_{\mathcal{U}}^{-1}\left(D_{a}\left(\theta_{\mathcal{U}}\right)\right)$ is a $\mathbb{D}^{\infty}$-continuous derivation of $\mathbb{D}^{\infty}\left(\Omega_{1} \times \Omega_{2}\right)$, which has the form: $\operatorname{div} \tilde{A}$ grad.

Proof. i). $\theta_{\mathcal{U}}\left(\mathcal{F}_{t}\right) \subset \mathcal{F}_{t}$ : if $W(h) \in \mathcal{F}_{t}$, then $\dot{h}(s)=0$ for $s>t$ and

\theta[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B=\int_{0}^{t} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B \in \mathcal{F}_{t} .

If $f \in \mathcal{F}_{t}^{\perp}$, then $\exists b(s, \omega) \in \mathbb{D}^{\infty}$ such that $f=\int_{t}^{1} b(s, \omega) \cdot \mathrm{d} B_{s}$ implies $\theta_{\mathcal{U}}(f)=\int_{t}^{1} \theta b(s, \omega) \mathcal{U}^{-1} \cdot \mathrm{~d} B_{s} \in \mathcal{F}_{t}^{\perp}$. So $\theta_{\mathcal{U}}(f) \in \mathcal{F}_{t}^{\perp}$ implies $\theta_{\mathcal{U}}^{*} f \in \mathcal{F}_{t}$ if $f \in \mathcal{F}_{t}$ $\left(\theta_{\mathcal{U}}^{-1}=\theta_{\mathcal{U}}^{*}\right.$ sends $\mathcal{F}_{t}$ in $\mathcal{F}_{t}, \theta_{\mathcal{U}}$ is an $\mathrm{L}^{2}$-isometry). So $\theta_{\mathcal{U}}^{-1} D_{a} \theta_{\mathcal{U}}$ is adapted.
iii). $\forall f \in \mathbb{D}^{\infty}$, we have

D_{\tilde{a}}\binom{X_{t}}{Y_{t}}=\binom{-\int_{0}^{t} \tilde{a}(s) \cdot \mathrm{d} Y_{s}}{+\int_{0}^{t} \tilde{a}(s) \cdot \mathrm{d} X_{s}}
\end{gathered}
$$

so

\theta_{\mathcal{U}} D_{\tilde{a}}\binom{X_{t}}{Y_{t}} & =\binom{\theta_{\mathcal{U}}\left(-\int_{0}^{t} \tilde{a}(s) \cdot \mathrm{d} Y_{s}\right)}{\theta_{\mathcal{U}}\left(+\int_{0}^{t} \tilde{a}(s) \cdot \mathrm{d} X_{s}\right)} \\
& =\binom{-\int_{0}^{t} \tilde{a}(s) \theta_{\mathcal{U}} \cdot\left(\mathrm{d} Y_{s}\right)}{+\int_{0}^{t} \tilde{a}(s) \theta_{\mathcal{U}} \cdot\left(\mathrm{d} X_{s}\right)} \\
& =\binom{-\int_{0}^{t} \tilde{a}\left(\sin \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} X_{s}+\cos \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} Y_{s}\right)}{+\int_{0}^{t} \tilde{a}\left(\cos \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} X_{s}-\sin \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} Y_{s}\right)} \\
& =\binom{-\int_{0}^{t} \tilde{a} \sin \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} X_{s}-\int_{0}^{t} \tilde{a} \cos \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} Y_{s}}{+\int_{0}^{t} \tilde{a} \cos \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} X_{s}-\int_{0}^{t} \tilde{a} \sin \left(X_{s} / \sqrt{s}\right) \cdot \mathrm{d} Y_{s}} .

& =-\int_{0}^{t} \tilde{a} \sin \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} X_{s}-\int_{0}^{t} \tilde{a} \cos \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} Y_{s}
\end{aligned}
$$

and

-\int_{0}^{t} \cos \frac{X_{s}}{\sqrt{s}} F(s, \omega) \cdot \mathrm{d} X_{s}+\int_{0}^{t} \sin \frac{X_{s}}{\sqrt{s}} & F(s, \omega) \cdot \mathrm{d} Y_{s} \\
& =+\int_{0}^{t} \tilde{a} \cos \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} X_{s}-\int_{0}^{t} \tilde{a} \sin \frac{X_{s}}{\sqrt{s}} \cdot \mathrm{~d} Y_{s}
\end{aligned}

From these two last equations:

## 5. 2 Some other conditions to obtain a $\mathbb{D}^{\infty}$-morphism

Now we show that if $\sup _{t \in[0,1]}\left\|\operatorname{grad}^{j} \mathcal{U}\right\|_{\otimes^{j} H}<+\infty, \theta_{\mathcal{U}}$ is a $\mathbb{D}^{\infty}$-morphism.
Theorem 5..5. If $\mathcal{U}(t, \omega)$ is an adapted process from $[0,1] \times \Omega$ with values in the $n \times n$-unitary matrices (on $\mathbb{R}^{n}$ ) and such that each $\left\|\operatorname{grad}^{j} \mathcal{U}\right\|_{\otimes^{j} H}, j \in \mathbb{N}_{*}$ is also uniformly (for $t \in[0,1]$ ) bounded, then $\theta_{\mathcal{U}}$ being the $\mathrm{L}^{\infty-0}$-morphism associated to $\mathcal{U}$, is a $\mathbb{D}^{\infty}$-morphism.

Proof. For $h \in H$, we have $\theta_{\mathcal{U}}(W(h))=\int_{0}^{1} t \dot{\mathcal{H}} \mathcal{U}^{-1} \cdot \mathrm{~d} B$. First, we show that if $f \in \mathcal{C}_{k}$, then there exists a polynomial $P_{r}(k)$ such that: $\|f\|_{\mathbb{D}_{r}^{2}}^{2}=P_{r}(k)\|f\|_{\mathrm{L}^{2}}^{2}$. $L$ denoting as usual the O.U. operator, as $\mathbb{D}_{r}^{p}$-norm, we use

\|f\|_{\mathbb{D}_{r}^{p}}=\left(\sum_{j=0}^{r}\left\|\operatorname{grad}^{j} f\right\|_{L^{p}\left(\Omega, \otimes^{j} H\right)}^{p}\right)^{1 / p}
$$

From $L \operatorname{grad} f-\operatorname{grad} L f=\operatorname{grad} f$, we have $L\left(\operatorname{grad}^{r} f\right)-\operatorname{grad}^{r}(L f)=r \operatorname{grad}^{r} f$ and

\left\langle\operatorname{grad}^{r} f, \operatorname{grad}^{r} f\right\rangle_{\otimes^{r} H} & =-\left\langle L\left(\operatorname{grad}^{r-1} f\right), \operatorname{grad}^{r-1} f\right\rangle_{\otimes^{r-1} H} \\
& =(k-r+1)\left\langle\operatorname{grad}^{r} f, \operatorname{grad}^{r} f\right\rangle_{\otimes^{r} H},
\end{aligned}
$$

so

\left\|\operatorname{grad}^{r} f\right\|_{\mathrm{L}^{2}}^{2}=\frac{k!}{(n-k)!}\|f\|_{\mathrm{L}^{2}}^{2} .
$$

But $\left\|(I-L)^{r / 2} f\right\|_{\mathrm{L}^{2}}=(1+k)^{r}\|f\|_{\mathrm{L}^{2}}^{2}$, so with $\|f\|_{\mathbb{D}_{r}^{2}}^{2}=\sum_{j=0}^{r}\left\|D^{j} f\right\|_{\mathrm{L}^{2}}^{2}$, we get: $\|f\|_{\mathbb{D}_{r}^{2}}^{2} \simeq k^{r}$ when $k \rightarrow+\infty$, and

Now with $f=\left(f_{1}, \ldots, f_{n}\right)$ and the hypothesis on $\mathcal{U}(t, \omega)$, Leibnitz formula implies, by induction, with $f^{i} \in \mathbb{D}^{\infty}$ :

$K(r)$ being a constant, $r$-depending.

Now if $f=\left(f_{1}, \ldots, f_{n}\right)$ and $f_{i} \in \mathcal{C}_{k}, i=1, \ldots, n$, we have (Clark-Ocone): $f^{i}=\int_{0}^{1} g_{j}^{i} \cdot \mathrm{~d} B^{j}$, with $g_{j}^{i} \in \mathcal{C}_{k-1}$. And

\end{array}\right)=\int_{0}^{1} \theta_{\mathcal{U}}\left(g_{j}^{i}\right)\left(\mathcal{U}^{-1}\right)_{\ell}^{j} \cdot \mathrm{~d} B^{\ell}, \quad i=1, \ldots, n
$$

If $\vec{g}=\left(g_{1}, \ldots, g_{n}\right)$, vector of $n$ functions in $\mathbb{D}^{\infty}$, we write

\left\|D^{r} \vec{g}\right\|_{\otimes^{r} H} \leq \sum_{\ell=1}^{n}\left\|D^{r} g_{\ell}\right\|_{\otimes^{r} H}
$$

Then, if $f \in \mathbb{D}^{\infty}(\Omega)$, we can write:

$B^{1}, \ldots, B^{n}$ being $n$ independants Brownians, and $g_{\ell} \in \mathbb{D}^{\infty}(\Omega)$. If $E(f)=0$, we have

$K_{2}(r)$ being an $r$-depending constant.
But $\theta_{\mathcal{U}}(f)=\int_{0}^{1} \theta_{\mathcal{U}}\left(g_{\ell}\right)\left(\mathcal{U}^{-1}\right)_{j}^{\ell} \cdot \mathrm{d} B^{j}, j=1, \ldots, n$. With (5), we have:

Suppose $f \in \mathcal{C}_{k}$, then $g \in \mathcal{C}_{k-1}$ and denoting $C(m, r)=\left\|\theta_{\mathcal{U}} f\right\|_{\mathbb{D}_{r}^{2}} /\|f\|_{\mathbb{D}_{r}^{2}}$, with (3), we have:

& +K_{3}(r) C(k-1, r-1)\left(\int_{0}^{1} \mathrm{~d} s\left\|\overrightarrow{\theta_{\mathcal{U}}(g)}\right\|_{\mathbb{D}_{r-1}^{2}}\right)^{1 / 2}
\end{align*}

Using (2) in (7),

which implies, as soon as $k$ is big enough $\left(k \geq k_{0}\right)$ :

So, by induction, we see that for $k \geq k_{0}, C(k, r)$ has a polynomial growth ; then (8) implies that $\theta_{\mathcal{U}} f \in \mathbb{D}_{r}^{2}$. Then with $f \in \mathbb{D}_{\infty}^{2}$ now, we write $f=\sum_{k=1}^{\infty} f_{k}$; then

Each $\left\|\theta_{\mathcal{U}} f_{k}\right\|_{\mathbb{D}_{r}^{2}}$ has polynomial growth when $k \geq k_{0} ;$ but the sequence $\left(\left\|\theta_{\mathcal{U}} f_{k}\right\|\right)_{\mathbb{D}_{r}^{2}}$ is fast decreasing ; so $\left\|\theta_{\mathcal{U}} f\right\|_{\mathbb{D}_{r}^{2}}<+\infty$, and $\theta_{\mathcal{U}} f \in \mathbb{D}_{r}^{2}$. Now by interpolation $\theta_{\mathcal{U}}: \mathbb{D}^{\infty} \rightarrow \mathrm{L}^{\infty-0}$ and $\theta_{\mathcal{U}}: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{r}^{2}$; so $\theta_{\mathcal{U}}: \mathbb{D}^{\infty} \rightarrow \mathbb{D}^{\infty}$.

Definition 5..1. Let (H) be the set
$\{\mathcal{U} / \mathcal{U}$ process with values in $n \times n$ unitary matrices,

\text { adapted, } \left.[0,1] \times \Omega \text {-mesurable, in } \mathrm{L}^{\infty-0}(\Omega)\right\} \text {. }
$$

Then we denote by $\|\mathcal{U}(s, \omega)\|_{\mathrm{op}}$ the operator norm of $\mathcal{U}(s, \omega)$ on $\mathbb{R}^{n}$, and if $\mathcal{U}_{1}, \mathcal{U}_{2} \in(H)$, we denote by

$$
d\left(\mathcal{U}_{1}, \mathcal{U}_{2}\right)=\sup _{t \in[0,1]}\| \| \mathcal{U}_{1}(t, \cdot)-\mathcal{U}_{2}(t, \cdot)\left\|_{\mathrm{op}}\right\|_{\mathrm{L}^{2}(\Omega)} .
$$

Then $d$ is a distance on (H), for wich (H) is complete.
Definition 5..2. We denote by $\theta_{\mathcal{U}}$ the $\mathrm{L}^{\infty-0}$-morphism generated by $\theta_{\mathcal{U}}(W(h))=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B$. Then a $n \times n$-matrix $\mathcal{V}$ will be said to be $k$-Lipschitzian if and only if

$$
\forall \mathcal{U}_{1}, \mathcal{U}_{2} \in(H),\| \| \theta_{\mathcal{U}_{1}}(\mathcal{V})-\theta_{\mathcal{U}_{2}}(\mathcal{V})\left\|_{\mathrm{op}\left(\mathbb{R}^{m}\right)}\right\|_{\mathrm{L}^{2}(\Omega)} \leq k d\left(\mathcal{U}_{1}, \mathcal{U}_{2}\right) .
$$

Theorem 5..6. Let $\mathcal{U} \in(H)$ such that there exists $k, 0<k<1$ so that for all $s \in[0,1], \mathcal{U}(s, \cdot)$ is $k$-Lipschitzian. Then $\theta_{\mathcal{U}}$ is a bijection on $\mathrm{L}^{\infty-0}(\Omega)$.

Proof. For every $\mathcal{U} \in(H), \mathcal{V} \mapsto \theta_{\mathcal{V}}\left(\mathcal{U}^{-1}\right)$ is $k$-Lipschitzian because $\mathcal{U} \mapsto \mathcal{U}^{-1}$ is 1-Lipschitzian. Then, the Picard theorem asserts that: there exists $\mathcal{V}_{0} \in\left(\begin{array}{l}H\end{array}\right.$ such that $\theta_{\nu_{0}}\left(\mathcal{U}^{-1}\right)=\mathcal{V}_{0}$. And

$$
\forall h \in H, \theta_{\mathcal{V}_{0}}\left(\int_{0}^{1}{ }^{t} \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B\right)=\int_{0}^{1}{ }^{t} \dot{h} \theta \mathcal{V}_{0}\left(\mathcal{U}^{-1}\right) \mathcal{V}_{0}^{-1} \cdot \mathrm{~d} B=\int_{0}^{1}{ }^{t} \dot{h} \mathcal{V}_{0} \mathcal{V}_{0}^{-1} \cdot \mathrm{~d} B
$$

So $\theta_{\mathcal{V}_{0}} \circ \theta_{\mathcal{U}}=\mathrm{Id}$ which proves that $\theta_{\nu_{0}}$ is surjective ; and as we know already that $\theta_{\mathcal{V}_{0}}$ is injective on $\mathrm{L}^{\infty-0}, \theta_{\mathcal{U}}$ is a bijection on $\mathrm{L}^{\infty-0}(\Omega)$.

Remark 5..4. The set of $k$-Lipschitzian processes is not limited to the determinist functions: any $W(h)$, with $\|h\|_{\mathrm{L}^{2}}=k<1$, is a $k$-Lipschitzian process (straightforward computation).

Now we define the notion of $\mathbb{D}^{\infty}-\alpha$-Holderian processes, which will allow us to study cases when the morphism $\theta$, defined on $\mathcal{C}_{1}(\Omega)$ by $\theta[W(h)]=$ $\int_{0}^{1} t \mathcal{U}^{-1} \cdot \mathrm{~d} B$, can be extended in a continuous morphism on $\mathbb{D}^{\infty}(\Omega)$.

Definition 5 .. 3 (Same as definition 2.3). A process $X:[0,1] \times \Omega \rightarrow \mathbb{R}^{n}$ is said to be $\mathbb{D}^{\infty}-\alpha$-Holderian if and only if $\forall t_{1}, t_{2} \in[0,1], \forall(p, r) \in\left[1,+\infty\left[\times \mathbb{N}_{*}\right.\right.$, $\exists C(p, r)$ constant such that,

$$
\left\|X\left(t_{2}, \omega\right)-X\left(t_{1}, \omega\right)\right\|_{\mathbb{D}_{r}^{p}} \leq C(p, r)\left|t_{2}-t_{1}\right|^{\alpha} .
$$

Theorem 5..7. Let $\mathcal{U}$ be a $\mathbb{D}^{\infty}$-adapted process, with values in $n \times n$ unitary matrices, $\mathbb{D}^{\infty}-\alpha$-Holderian, with $\alpha>1 / 2$. Then the operator $\theta$ defined on $\mathcal{C}_{1}$ by:

$$
\theta_{\mathcal{U}}[W(h)]=\int_{0}^{1}{ }^{t} \dot{\mathcal{L}} \mathcal{U}^{-1} \cdot \mathrm{~d} B, \quad(h \in H, B \text { an } n \text {-Brownian }),
$$

can be extended in a continuous morphism of $\mathbb{D}^{\infty}(\Omega)$ in itself.
Proof. We know already that $\theta$ can be extended in a morphism of $\mathrm{L}^{\infty-0}(\Omega)$ in $L^{\infty-0}(\Omega)$, because $\theta$ preserves laws. We will need the three following lemmas.

Lemma 5..4. Let $E$ be a $n \times n$ antisymmetrical constant matrix, and $t \in$ $[0,1]$. For $f \in \mathbb{D}^{\infty}(\Omega)$, we define $D_{E, t} f$ by:

D_{E, t} f=\operatorname{div}\left(\mathbb{1}_{[0, t[ }(\cdot) E\right) \operatorname{grad} f .

If $\Delta$ is a finite subdivision of $[0,1], \Delta=\left\{0=t_{0}<t_{1}<\cdots<t_{n}=1\right\}$, denote $S_{\Delta}(f)=\sum_{i=0}^{n}\left|D_{E, t_{i+1}}(f)-D_{E, t_{i}}(f)\right|^{2}$.

Then $\forall(p, r) \in\left[1, \infty\left[\times \mathbb{N}_{*}, \exists C(p, r, f)\right.\right.$ constant, such that

\sup _{\Delta}\left\|S_{\Delta}(f)\right\|_{\mathbb{D}_{r}^{p}} \leq C(p, r, f) .
$$

Proof. Let $\Delta=\left\{0=t_{0}<t_{1}<\cdots<t_{n}=1\right\}$ a fixed finite subdivision and $\varepsilon_{i}= \pm 1, i=1, \ldots, n$. Denote

\tilde{S}_{\Delta}\left(\left\{\varepsilon_{i}\right\}\right)(f)=\sum_{i=0}^{n} \varepsilon_{i}\left[D_{E, t_{i+1}}(f)-D_{E, t_{i}}(f)\right] .
$$

Then

\tilde{S}_{\Delta}\left(\left\{\varepsilon_{i}\right\}\right)(f)=\operatorname{div} B_{E}\left(\left\{\varepsilon_{i}\right\}\right) \operatorname{grad} f
$$

with $B_{E}(\{\varepsilon\})=\sum_{i=0}^{n} \varepsilon_{i} \mathbb{1}_{\left[t_{i}, t_{i+1}\right]}(\cdot) E$. The operators $B_{E}\left(\left\{\varepsilon_{i}\right\}\right)$ are operators on $\mathbb{R}^{n}$, and as such, are uniformly bounded, relatively to the set $\left\{\varepsilon_{i}\right\}$, when the subdivision is fixed, and relatively to the subdivisions $\Delta$, and are $\Delta,\left\{\varepsilon_{i}\right\}$-uniformly determinists.

So the $\tilde{S}_{\Delta}\left(\left\{\varepsilon_{i}\right\}\right)$ are linear operators on $\mathbb{D}^{\infty}(\Omega), \mathbb{D}^{\infty}$-uniformly bounded relatively to the sets $\left\{\varepsilon_{i}\right\}$ and the subdivisions $\Delta$. But

$$
\frac{1}{2^{\sharp\left(\left\{\varepsilon_{i}\right\}\right)}} \sum_{\left\{\varepsilon_{i}\right\}}\left|\tilde{S}_{\Delta}\left(\left\{\varepsilon_{i}\right\}\right)(f)\right|^{2}=S_{\Delta}(f),
$$

the sum being taken on all sets $\left\{\varepsilon_{i}\right\}$, once the subdivision $\Delta$ is fixed. $S_{\Delta}(f)$ belonging to the convex enveloppe of elements whose $\mathbb{D}_{r}^{p}$-norms do not depend either of the finite subdivision $\Delta$ or of the set $\left\{\varepsilon_{i}\right\}$, there exists a constant $C(p, r, f)$ such that $\sup _{\Delta}\left\|S_{\Delta}(f)\right\|_{\mathbb{D}_{r}^{p}} \leq C(p, r, f)$.

REMARK 5..5. Later we will suppose $\theta_{\mathcal{U}}: \mathbb{D}^{\infty}(\Omega) \rightarrow \mathbb{D}_{r}^{\infty}(\Omega)$ (Theorem 5..11). Then the same demonstration as in Lemma 5..4, applied to $\forall \alpha, 1 \leq$ $\alpha \leq r$,

S_{\Delta}\left[\operatorname{grad}^{\alpha} \theta_{\mathcal{U}}\left(D_{E, t} f\right)\right]=\sum_{i=0}^{n}\left\|\operatorname{grad}^{\alpha} \theta_{\mathcal{U}}\left(D_{E, t_{i+1}} f\right)-\operatorname{grad}^{\alpha} \theta_{\mathcal{U}}\left(D_{E, t_{i}} f\right)\right\|_{\otimes^{\alpha} H},
$$

proves that there exists, for every $p$, a constant $C(\alpha, p, f)$ such that

\sup _{\Delta}\left\|S_{\Delta}\left(\operatorname{grad}^{\alpha} \theta_{\mathcal{U}}\left(D_{E, t} f\right)\right)\right\|_{L^{p}\left(\Omega, \otimes^{\alpha} H\right)} \leq C(\alpha, p, f) .

Now we denote: for a subdivision $\Delta$ of $\mathbb{R}, r \in \mathbb{N}_{*}$ and $f$ a process $\mathbb{R} \times \Omega \rightarrow \mathbb{R}$,

V_{\Delta, \mathbb{R}}\left(\operatorname{grad}^{r} f\right)=\sum_{i}\left\|\operatorname{grad}^{r} f\left(x_{i+1}, \cdot\right)-\operatorname{grad}^{r} f\left(x_{i}, \cdot\right)\right\|_{\otimes^{r} H}^{2}
$$

and by $V_{\Delta}$, when the subdivision is on $[0,1]$.
Lemma 5..5. Let $f:[0,1] \times \Omega \rightarrow \mathbb{R}$ a process such that
i) $\forall t \in[0,1], f(t, \cdot) \in \mathbb{D}^{\infty}(\Omega)$ and $f(0, \omega)=0 \mathbb{P}$-almost surely.
ii) $\forall r \in \mathbb{N}_{*}, \forall p>1, \exists C(p, r, f), \sup _{\Delta}\left\|V_{\Delta} \operatorname{grad}^{r} f\right\|_{L^{p} \Omega}<C(p, r, f)$.
iii) $\forall r \in \mathbb{N}_{*}, \int_{0}^{1}\left\|\operatorname{grad}^{r} f\right\|_{\otimes^{r} H}^{2} \mathrm{~d} t \in \mathrm{~L}^{\infty-0}(\Omega)$.

Then, the extension of $f$, denoted $\tilde{f}$, which equals 0 on $]-\infty, 0] \cup[2, \infty[$, and is an affine process $g$ on $[1,2]$ with $g(1, \omega)=f(1, \omega)$ and $g(t, \omega)=0 \mathbb{P}$-almost surely on $[2, \infty[$, we have:
I)

is $\mathrm{L}^{\infty-0}$-bounded, $h$-uniformly.
II) $\left\|\operatorname{grad}^{r} \tilde{f}\right\|_{B_{2,2}^{\varepsilon / 2}} \in \mathrm{~L}^{\infty-0}(\Omega), \forall r \in \mathbb{N}_{*}$ and $0<\varepsilon<1$.

Proof. I).

&=\left\|\int_{0}^{h} \sum_{n \in \mathbb{Z}}\right\| \frac{\operatorname{grad}^{r} \tilde{f}(x+(n+1) h)-\operatorname{grad}^{r} \tilde{f}(x+n h)}{\sqrt{h}}\left\|_{\otimes^{r} H}^{2} \mathrm{~d} x\right\|_{\mathrm{L}^{p}(\Omega)} \\
& \quad \leq \frac{1}{h}\left\|\int_{0}^{h} C(p, r) \mathrm{d} x\right\|_{\mathrm{L}^{p}(\Omega)}=C(p, r, f) .
\end{aligned}

$I I)$. We have to show that:

The left-hand side of the above inequality is bounded by:

& +\left\|\int_{1}^{\infty} \mathrm{d} h \frac{\left\|\operatorname{grad}^{r} \tilde{f}(x+h)-\operatorname{grad}^{r} \tilde{f}(x)\right\|_{\mathrm{L}^{2}\left(\mathrm{~d} x, \otimes^{r} H\right)}^{2}}{h^{1+\varepsilon}}\right\|_{\mathrm{L}^{p}(\Omega)}
\end{aligned} .

The first integral above is bounded because $\mathrm{d} h / h^{\varepsilon}$ is a bounded measure on $[0,1]$, and with $I)$. The second integral is bounded by:

ii) $f(0, \cdot)=0, \mathbb{P}$-almost surely.

Then, $\tilde{f}$ being as in Lemma 5..3, we have:

& +\left\|\int_{1}^{\infty} \mathrm{d} h \frac{\left\|\operatorname{grad}^{r} \tilde{f}(x+h)-\operatorname{grad}^{r} \tilde{f}(x)\right\|_{\mathrm{L}^{2}\left(\mathrm{~d} x, \otimes^{r} H\right)}^{2}}{h^{1+2(1-\varepsilon / 2)}}\right\|_{\mathrm{L}^{p}(\Omega)}
\end{aligned}

$\operatorname{grad}^{r} \tilde{f}$ is also $\mathbb{D}^{\infty}(\Omega, H)$ - $\alpha$-Holderian, so: the first integral is bounded if $2 \alpha-2+1>0$ so if $\alpha>1 / 2$; the second integral is bounded by

$\left(t \mapsto\left(\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \mathrm{~d} s\right)\right)$ being a $\mathbb{D}^{\infty}(\Omega, H)$-vector field. We want to generalize (9) to a function $f \in \mathbb{D}^{\infty}(\Omega)$. The generalization of $t \mapsto\left(\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \mathrm{~d} s\right)$ is straightforward: using Theorem 2.3, we generalize it by

We extend $f_{k}^{\ell}$ by 0 on $\left.]-\infty, 0\right]$, and with the affine function, $-f_{k}^{\ell}(1, \omega) t+$ $2 f_{k}^{\ell}(1, \omega)$ on $t \in[1,2]$, and 0 after 2 . This extension of $f_{k}^{\ell}$ is again denoted $f_{k}^{\ell}$ and by using it, we have an extension of $\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right)_{\ell}^{k}$, denoted again $\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right)_{\ell}^{k}$. We denote again $\theta\left[D_{E_{k}^{\ell}, t} f\right]$, the result of the same extension procedure applied to $\theta_{\mathcal{U}}\left[D_{E_{k}^{e}, t} f\right]$.

And the generalisation of the first integral in (9) is given by:

$B_{p, q}^{\lambda}$ being the Besov space with indexes $\lambda, p, q ;\left\|f_{k}^{\ell}\right\|_{B_{2,2}^{1-\varepsilon / 2}(H)} \in \mathrm{L}^{\infty-0}$ because $f_{k}^{\ell}$ is $\mathbb{D}^{\infty}-\alpha$-Holderian $\left(\mathcal{U}, \operatorname{grad} \mathcal{U}^{-1}\right.$ are $\mathbb{D}^{\infty}-\alpha$-Holderians), so Lemma $5 . .6$ applies to $f_{k}^{\ell}$.

And $B_{2,2}^{\varepsilon / 2}$ and $B_{2,2}^{1-\varepsilon / 2}$ are conjugate Besov spaces, so (10) is legitimate.
Now $\operatorname{grad} \theta_{\mathcal{U}}(f)$ is in $\mathbb{D}^{\infty}$ when $f$ is a polynomial of a finite number of Gaussian variables, $P\left[W\left(h_{1}\right), \ldots, W\left(h_{r}\right)\right]$. Then

If $f \in \mathbb{D}^{\infty}$, then $\operatorname{grad} \theta_{\mathcal{U}}(f)$ can be defined as a distribution on $\mathbb{D}^{\infty}(\Omega, H)$ by: if $X \in \mathbb{D}^{\infty}(\Omega, H)$,

$$
\left(\operatorname{grad} \theta_{\mathcal{U}}(f), X\right)=-\int \theta_{\mathcal{U}} \operatorname{div} X \mathbb{P}(\mathrm{~d} \omega)
$$

Then $f \mapsto \operatorname{grad} \theta_{\mathcal{U}}(f)$ is a weakly closed operator, and with Hahn-Banach, its graph is strongly closed, so is a closed operator.

Last, $\operatorname{grad} \theta_{\mathcal{U}}(f)$ is a $\theta$-derivation (Definition 2.3).
Now we look for a $\theta$-derivation $\check{D}$ such that:
a) if $f=W(h), \check{D}[W(h)]=\operatorname{grad} \theta_{\mathcal{U}}(W(h))$,
b) $D$ is a $\theta_{\mathcal{U}}$-derivation,
c) $\check{D}$ is continuous from $\mathbb{D}^{\infty}(\Omega)$ to $\mathbb{D}^{\infty}(\Omega, H)$.

Using the generalisations of the two integrals in (9), we define: for $f \in \mathbb{D}^{\infty}(\Omega)$,

$$
\check{D} f=\int_{\mathbb{R}} f_{k}^{\ell} \mathrm{d}\left(\theta_{\mathcal{U}} D_{E_{\ell, t}^{k}} f\right)+\left(t \mapsto \int_{0}^{t}{ }^{t} \theta_{\mathcal{U}}(\operatorname{grad} f) \mathcal{U}^{-1} \mathrm{~d} s\right) .
$$

Then: a) Straightforward computation, using $f_{k}^{\ell} E_{\ell}^{k}=\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}$ proves a).
b) $\check{D}$ is a $\theta_{\mathcal{U}}$-derivation thanks to the presence of $\theta_{\mathcal{U}}$ in $\mathrm{d}\left(\theta_{\mathcal{U}} D_{E_{\ell, t}^{k}} f\right)$.
c) The Russo-Valois inequality: $C_{0}$ being a constant,

$$
\left\|\int_{\mathbb{R}} f_{k}^{\ell} \mathrm{d}\left(\theta_{\mathcal{U}} D_{E_{\ell, t}^{k}} f\right)\right\|_{H} \leq C_{0} \times\left\|f_{k}^{\ell}\right\|_{B_{2,2}^{1-\varepsilon / 2}(H)} \times\left\|\theta_{\mathcal{U}}\left(D_{E_{\ell, t}^{k}} f\right)\right\|_{B_{2,2}^{\varepsilon / 2}} .
$$

As $\left\|f_{k}^{\ell}\right\|_{B_{2,2}^{1-\varepsilon / 2}(H)} \in \mathrm{L}^{\infty-0}(\Omega)$ and $\left\|\theta_{\mathcal{U}}\left(D_{E_{\ell, t}^{k}} f\right)\right\|_{B_{2,2}^{\varepsilon / 2}} \in \mathrm{~L}^{\infty-0}(\Omega)$, we see that $\check{D}$ is continuous from $\mathbb{D}^{\infty}$ in $\mathrm{L}^{\infty-0}(\Omega, H)$. Now we prove that: $\check{D}$ sends $\mathbb{D}^{\infty}$ in $\mathbb{D}^{\infty}(\Omega, H)$. We have:

$$
\begin{equation*}
\check{D} f=\int_{\mathbb{R}} f_{k}^{\ell} \mathrm{d}\left(\theta_{\mathcal{U}} D_{E_{\ell, t}^{k}} f\right)+\left(t \mapsto \int_{0}^{t}{ }^{t} \theta_{\mathcal{U}}(\operatorname{grad} f) \mathcal{U}^{-1} \mathrm{~d} s\right) . \tag{11}
\end{equation*}
$$

A grad acts only on $\omega$, grad and $\int_{\mathbb{R}}$ (Russo-Valois) commute; for the same reason: grad and d(Russo-Valois) commute.

We know already that $\theta_{\mathcal{U}}: \mathbb{D}^{\infty} \rightarrow \mathrm{L}^{\infty-0}(\Omega)$. We suppose that $\theta_{\mathcal{U}}: \mathbb{D}^{\infty} \rightarrow$ $\mathbb{D}_{r}^{\infty}(\Omega)$ and proceed by induction. We apply now grad to the two sides of (11): grad on the vector field

$$
t \mapsto \int_{0}^{t}{ }^{t} \theta_{\mathcal{U}}(\operatorname{grad} f) \mathcal{U}^{-1} \mathrm{~d} s
$$

is legitimate and in $\mathbb{D}_{r-1}^{\infty}(\Omega, H \otimes H)$. And grad applied to the first integral of the right-hand side of (11) gives two Russo-Valois integrals,

$$
\left.\int_{0}^{1}\left(\operatorname{grad} f_{k}^{\ell}\right) \mathrm{d}\left(\theta_{\mathcal{U}} D_{E_{\ell, t}^{k}} f\right) \quad \text { and } \quad \int_{0}^{1} f_{k}^{\ell} \otimes \mathrm{d}\left[\operatorname{grad} \theta_{\mathcal{U}} D_{E_{\ell, t}^{k}} f\right)\right] .
$$

The first one is in $\mathbb{D}_{r}^{\infty}(\Omega, H \otimes H)$ and the second one is legitimate thanks to the hypothesis $\theta_{\mathcal{U}}\left(D_{E_{\ell, t}^{k}} f\right) \in \mathbb{D}_{r}^{\infty}(\Omega)$. So we see that $\operatorname{grad} \check{D} f \in \mathrm{~L}^{\infty-0}(\Omega, H \otimes H)$, so $\check{D} f \in \mathbb{D}_{1}^{\infty}(\Omega, H)$. We can repeat $r$ times this operation, and we get that: $\operatorname{grad}^{r} \check{D} f \in \mathrm{~L}^{\infty-0}\left(\Omega, \bigotimes^{r+1} H\right)$ and is continuous from $\mathbb{D}^{\infty}$ in $\mathrm{L}^{\infty-0}\left(\Omega, \bigotimes^{r+1} H\right)$. Now $D$ and $\operatorname{grad} \theta$ are two $\theta$-derivations which coincide on polynomials built with Gaussian variables, $\check{D}$ is continuous from $\mathbb{D}^{\infty}$ in $\mathbb{D}_{r}^{\infty}(\Omega, H)$ and $\operatorname{grad} \theta$ is strongly closed as an operator of $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega, H)$; then $\check{D}$ and $\operatorname{grad} \theta$ coincide, so $\operatorname{grad} \theta(f) \in \mathbb{D}_{r}^{\infty}$ which implies $\theta(f) \in \mathbb{D}_{r+1}^{\infty}(\Omega)$. The continuity of $\theta(f)$ from $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega)$ is obvious.

Remark 5..6. If $f_{k}^{\ell}$ was an S.M., and not a $\mathbb{D}^{\infty}{ }_{-} \alpha$-Holderian process with $\alpha>1 / 2$, the Russo-Valois inequality is not valid anymore. We will see later that
such is the case for the $\mathbb{D}^{\infty}$-manifold $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$, which is the set of continuous paths in a compact Riemannian manifold, $\left(V_{n}, g\right)$, starting from $m_{0}$.

Theorem 5..8. Let $\mathcal{U}$ be a $\mathbb{D}^{\infty}$-process, with values in $n \times n$ unitary matrices, adapted and $\alpha$-Holderian, $0<\alpha<1$, and $\theta$ being the morphism from $\mathrm{L}^{\infty-0}$ in $\mathrm{L}^{\infty-0}$ generated by

$$
\theta[W(h)]=\int_{0}^{1}{ }^{t} \dot{\mathcal{L}} \mathcal{U}^{-1} \cdot \mathrm{~d} B .
$$

Suppose that $\theta^{-1}$ exists and is a $\mathbb{D}^{\infty}$-morphism of $\mathbb{D}^{\infty}(\Omega)$ in itself, then $\theta$ is a $\mathbb{D}^{\infty}$-isomorphism.

Remark 5..7. From Theorem 5..7, we know that if $\alpha>1 / 2$, Theorem $5 . .8$ is automatically verified.

Proof. $\theta^{-1}$ sends $\mathcal{F}_{t}$ in $\mathcal{F}_{t}: \theta$ sends $\mathcal{F}_{t}^{\perp}$ in $\mathcal{F}_{t}^{\perp}$ because

$$
\theta\left[\int_{t}^{1} X \cdot \mathrm{~d} B\right]=\int_{t}^{1} \theta(X) \mathcal{U}^{-1} \cdot \mathrm{~d} B \in \mathcal{F}_{t}^{\perp}
$$

and $\theta^{-1}=\theta^{*}$ (adjoint of $\theta$ ). So $\forall f \in \mathbb{D}^{\infty} \cap \mathcal{F}_{t}, \forall g \in \mathrm{~L}^{\infty-0} \cap \mathcal{F}_{t}^{\perp}$,

$$
\left\langle\theta^{-1}(f), g\right\rangle_{\mathrm{L}^{2}(\Omega)}=\left\langle\theta^{*}(f), g\right\rangle_{\mathrm{L}^{2}(\Omega)}=\langle f, \theta(g)\rangle_{\mathrm{L}^{2}(\Omega)}=0 .
$$

Now, $\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}$ is $\mathbb{D}^{\infty}-\alpha$-Holderian, as a product of two $\mathbb{D}^{\infty}$ - $\alpha$-matrix processes and $\theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right)$ is also $\mathbb{D}^{\infty}-\alpha$-Holderian because $\theta^{-1}$ acts only on $\omega$. Then from $\theta[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B$, and as $\theta^{-1}\left(\mathcal{U}^{-1} \cdot \mathrm{~d} B\right)=\mathrm{d} B$, we have

$$
\theta^{-1} \operatorname{grad}(\theta[W(h)])=\int_{0}^{1} t \dot{h} \theta^{-1}\left[\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right] \cdot \mathrm{d} B+\left(t \mapsto \int_{0}^{t}{ }^{t} \dot{h} \theta^{-1}\left(\mathcal{U}^{-1}\right) \mathrm{d} s\right) .
$$

We denote by $Z(f)$ :

$$
Z(f)=\operatorname{div} A \operatorname{grad} f+t \mapsto \int_{0}^{t}\left({ }^{t} \operatorname{grad} f\right) \theta^{-1}\left(\mathcal{U}^{-1}\right) \mathrm{d} s
$$

where $A=\theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right)$ is a vector matrix, $(A)_{i}^{j} \in H$, and $(A(\operatorname{grad} f))_{i}=\sum_{j=1}^{n}\left\langle\operatorname{grad} f, e_{j}\right\rangle(A)_{i}^{j} \in H . \operatorname{As} \theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right)$ is $\mathbb{D}^{\infty}{ }_{-} \alpha$-Holderian, $\theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right)$ is a $\mathbb{D}^{\infty}(\Omega, H)$ multiplicator (Theorem 4.3), so $Z(f) \in \mathbb{D}^{\infty}(\Omega, H)$. Moreover, $Z(f)$ and $\theta^{-1}[\operatorname{grad} \theta(f)]$ coincide when $f$ is a polynomial in Gaussian variables, because both are $\theta$-derivations, and direct computation show that

$$
Z[W(h)]=\theta^{-1}[\operatorname{grad} \theta(W(h))] .
$$

So we extend $\theta^{-1}[\operatorname{grad} \theta]$ as an operator on $f \in \mathbb{D}^{\infty}$, with $Z(f)$.
Now we prove that $\theta$ sends $\mathbb{D}^{\infty}$ in $\mathbb{D}^{\infty}$ by induction ; we know already that $\theta: \mathbb{D}^{\infty} \rightarrow \mathrm{L}^{\infty-0}$. Then assume that $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{r}^{\infty}$, and let $f \in \mathbb{D}^{\infty}$ : as $\theta^{-1}[\operatorname{grad} \theta(f)]=Z(f) \in \mathbb{D}^{\infty}(\Omega, H)$,

$$
\theta \theta^{-1}[\operatorname{grad} \theta(f)]=\theta(Z(f)) \in \mathbb{D}_{r}^{\infty}(\Omega, H)
$$

which implies $\operatorname{grad} \theta(f) \in \mathbb{D}_{r}^{\infty}(\Omega, H)$ so $\theta(f) \in \mathbb{D}_{r+1}^{\infty}(\Omega)$.
Let $\mathcal{U}$ be an adapted process, $\mathbb{D}^{\infty}$ - $\alpha$-Holderian, with values in the unitary $n \times n$ matrices on $\mathbb{R}^{n}$. The map $\theta$ defined on $W(h), h \in H$, by

$$
\theta[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B
$$

can be extended in a morphism from $\mathrm{L}^{\infty-0}(\Omega)$ in $\mathrm{L}^{\infty-0}(\Omega)$, because it preserve laws.

Let $A$ be an adapted process, valued in the space of $n \times n$-A.M., $A$ being moreover a multiplicator. Following Malliavin [ ], we call such a process an elementary tangent process. We define the operator $T_{\mathcal{U}}(A)$ by:

$$
T_{\mathcal{U}}(A)=\mathcal{U}\left(D_{A} \mathcal{U}^{-1}\right)+A
$$

where $D_{A}=\operatorname{div} A$ grad. Now we will prove:
Theorem 5..9. If $T_{\mathcal{U}}$ admits an inverse operator $\left(T_{\mathcal{U}}\right)^{-1}$ from the space of elementary tangent processes in itself, and if $\theta: \mathrm{L}^{\infty-0} \rightarrow \mathrm{~L}^{\infty-0}$ admits an inverse from $\mathrm{L}^{\infty-0}$ in itself, then $\theta$ is a $\mathbb{D}^{\infty}$-diffeomorphism.

Before proving this theorem, we need several lemmas.
Lemma 5..7. The operator $T_{\mathcal{U}}$ takes its values in the $n \times n-A . M$., $T_{\mathcal{U}}(A)$ is an adapted process, and a multiplicator: $T_{\mathcal{U}}(A)$ is an elementary tangent process.

Proof. As $D_{A}$ is an adapted derivation, $T_{\mathcal{U}}$ is adapted. Then $\mathcal{U}^{-1}$ being $\mathbb{D}^{\infty}{ }^{-} \alpha$-Holderian, $D_{A} \mathcal{U}^{-1}$ is also $\mathbb{D}^{\infty}-\alpha$-Holderian $\left(D_{A}\right.$ acts only on $\left.\omega\right)$; and a process which is $\mathbb{D}^{\infty}-\alpha$-Holderian is a multiplicator (Theorem 4.3).

Remark 5..8. As $\theta: \mathrm{L}^{\infty-0} \rightarrow \mathrm{~L}^{\infty-0}$ preserves laws, $\theta: \mathrm{L}_{1}^{+}(\Omega) \rightarrow \mathrm{L}_{1}^{+}(\Omega)$, so $\theta^{*}: \mathrm{L}^{\infty-0}(\Omega) \rightarrow \mathrm{L}^{\infty-0}(\Omega)$. Then $\theta^{*}$ is a morphism $\left(\theta^{*}=\theta^{-1}\right)$.

Lemma 5..8. Suppose $\left(T_{\mathcal{U}}\right)^{-1}$ exists as an operator from the space of adapted multiplicators, $n \times n$-A.M., in itself. Then if $Y$ is $\mathbb{D}^{\infty}-\alpha$-Holderian, $\left(T_{\mathcal{U}}\right)^{-1} Y$ is also $\mathbb{D}^{\infty}-\alpha$-Holderian.

Proof. Denote $A=\left(T_{\mathcal{U}}\right)^{-1} Y$; then $T_{\mathcal{U}} A$ is $\mathbb{D}^{\infty}-\alpha$-Holderian by hypothesis ; so $\mathcal{U} D_{A} \mathcal{U}^{-1}+A$ is $\mathbb{D}^{\infty}-\alpha$-Holderian and so is $\mathcal{U}^{-1} D_{A} \mathcal{U}$, which implies $A=$ $Y-\mathcal{U} D_{A} \mathcal{U}^{-1}$ is $\mathbb{D}^{\infty}-\alpha$-Holderian.

Lemma 5..9. In the same setting than in Lemma 5.8, $H^{\prime}$ being an Hilbert space, the extension of $\left(T_{\mathcal{U}}\right)^{-1}$ (Corollary 2.2) will send the space of the $\mathbb{D}^{\infty}\left(\Omega, H^{\prime}\right)$ - $\alpha$-Holderian elementary tangent process (with items in $H^{\prime}$ ) in $\mathbb{D}^{\infty}-\alpha^{\prime}$-Holderian processes, $\alpha^{\prime}<\alpha$.

Remark. We cannot apply directly Corollary 2.2, because the space of $\mathbb{D}^{\infty}-\alpha$-Holderian processes is not $\mathbb{D}^{\infty}$-closed.

Proof of Lemma 5..9. a) Let X be a completely $\mathbb{D}^{\infty}$-process with $\mathbb{R}$-valued matrix items (see Definition 2.2 for a completely $\mathbb{D}^{\infty}$-process). Then $E\left[X \mid \mathcal{F}_{t}\right]$ is an adapted process ; $E\left[X \mid \mathcal{F}_{t}\right] * \beta_{1-s}$ is a $\mathbb{D}^{\infty}$-Holderian process which implies $\left(T_{\mathcal{U}}\right)^{-1}\left[E\left[X \mid \mathcal{F}_{t}\right] * \beta_{1-s}\right]$ is again $\mathbb{D}^{\infty}$-Holderian (Lemma 5.8) ; $\left\{\left(T_{\mathcal{U}}\right)^{-1}\left[E\left[X \mid \mathcal{F}_{t}\right] * \beta_{1-s}\right] * \beta_{s^{\prime}}\right\}^{\prime}, s^{\prime}>s$, is a completely $\mathbb{D}^{\infty}$-process, denoted $\hat{X}$.

Then $X \mapsto \hat{X}$ is a transformation denoted (H) which sends a complete $\mathbb{D}^{\infty}$-elementary tangent process in a completely $\mathbb{D}^{\infty}$-elementary tangent process. With Lemma 2.1.ii, we have an extension map denoted $\widetilde{(H)}$ which sends the space of completely $\mathbb{D}^{\infty}$-elementary tangent process with matrix items in $H^{\prime}$, in itself.
b) Now let $Y$ an $\mathbb{D}^{\infty}-\alpha$-Holderian elementary tangent process with matrix items in $H^{\prime}$. With Theorem 2.8, we know that $X=\left(Y * \beta_{s_{0}}\right)^{\prime}, s_{0}<\alpha$, is completely $\mathbb{D}^{\infty}$. So we denote by:

$$
\overline{\left(T_{\mathcal{U}}\right)^{-1}}(Y)=\widetilde{\mathbb{H}}\left(\left(Y * \beta_{s_{0}}\right)^{\prime}\right) * \beta_{1-s_{0}} .
$$

Remind that according to Proposition 2.2.iv, the convolution by $\beta_{s_{0}}$ or $\beta_{1-s_{0}}$ leaves the adaptation property invariant. Then $\widehat{\left(T_{\mathcal{U}}\right)^{-1} Y}$ is an $\mathbb{D}^{\infty}{ }_{-\alpha}$-Hölderian elementary process.
c) Each matrix item of $Y$ can be written $Y_{i}^{j}=a_{i}^{j} h$ where $h$ is a constant vector of $H^{\prime}$. Then

$$
\begin{aligned}
\widetilde{\left(T_{\mathcal{U}}\right)^{-1}} Y_{i}^{j} & \left.=(\mathbb{H})\left(a_{i}^{j} * \beta_{s_{0}}\right)^{\prime}\right) * \beta_{1-s_{0}} h \\
& =\left\{\left[\left(T_{\mathcal{U}}\right)^{-1}\left(\mathbb{E}\left[\left(a_{i}^{j} * \beta_{s_{0}}\right)^{\prime} \mid \mathcal{F}_{t}\right] * \beta_{1-s_{0}}\right] * \beta_{s_{0}}\right\}^{\prime} * \beta_{1-s_{0}} h\right. \\
& =\left(T_{\mathcal{U}}\right)^{-1}\left(\mathbb{E}\left[\left(a_{i}^{j} * \beta_{s_{0}}\right)^{\prime} \mid \mathcal{F}_{t}\right] * \beta_{1-s_{0}}\right) h \\
& =\left(T_{\mathcal{U}}\right)^{-1}\left(\mathbb{E}\left[\left(a_{i}^{j} * \beta_{s_{0}}\right)^{\prime} * \beta_{1-s_{0}} \mid \mathcal{F}_{t}\right]\right) h \\
& =\left(T_{\mathcal{U}}\right)^{-1}\left(\mathbb{E}\left[a_{i}^{j} \mid \mathcal{F}_{t}\right]\right) h \\
& =\left(\left(T_{\mathcal{U}}\right)^{-1} a_{i}^{j}\right) h \\
& =\left(T_{\mathcal{U}}\right)^{-1} Y_{i}^{j} .
\end{aligned}
$$

Definition 5..4. Let $X \in \mathbb{D}^{\infty}(\Omega, H)$ and $Z$, an $n \times n$-A.M. process with its items belonging to $H$ (Cameron-Martin space). We define $D_{Z} f$, for $f \in$ $\mathbb{D}^{\infty}(\Omega)$ by

$$
D_{Z} f=\operatorname{div}_{R}(Z \otimes \operatorname{grad} f),
$$

then $D_{Z} f \in \mathbb{D}^{\infty}(\Omega, H)$.
(Remind $\operatorname{div}_{R}$ already defined in Theorem 5.1.) Then $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ being an Hibertian basis of $H$, straightforward computation shows:

$$
D_{Z} f=\sum_{i=1}^{\infty}\left(\operatorname{div}\left(\left\langle Z, e_{i}\right\rangle_{H}\right) \operatorname{grad} f\right) e_{i}
$$

Lemma 5..10. $D_{Z}^{*}$ being the adjoint of $D_{Z}$, for all $V \in \mathbb{D}^{\infty}(\Omega, H)$, we have, with $f \in \mathbb{D}^{\infty}(\Omega)$ :

$$
D_{Z}^{*}(f V)=f D_{Z}^{*} V-\left\langle D_{Z} f, V\right\rangle_{H}
$$

Proof. $\forall g \in \mathbb{D}^{\infty}(\Omega)$,

$$
\begin{aligned}
\left(D_{Z}^{*}(f V), g\right) & =\left\langle f V, D_{Z} g\right\rangle_{\mathrm{L}^{2}(\Omega, H)} \\
& =\sum_{i=1}^{\infty}\left\langle f V,\left(D_{Z_{i}} g\right) e_{i}\right\rangle_{\mathrm{L}^{2}(\Omega, H)} \\
& =\sum_{i=1}^{\infty}\left(\left(f D_{Z_{i}} g\right),\left\langle V, e_{i}\right\rangle_{H}\right)_{\mathrm{L}^{2}(\Omega)} \\
& =\sum_{i=1}^{\infty}\left[\left(D_{Z_{i}}(f g),\left\langle V, e_{i}\right\rangle_{H}\right)_{\mathrm{L}^{2}(\Omega)}-\left(g D_{Z_{i}} f,\left\langle V, e_{i}\right\rangle_{H}\right)_{\mathrm{L}^{2}(\Omega)}\right] \\
& =\sum_{i=1}^{\infty}\left[\left(V, D_{Z_{i}}(f g) e_{i}\right)_{\mathrm{L}^{2}(\Omega)}-\left(g,\left\langle V, D_{Z_{i}} f e_{i}\right\rangle_{H}\right)_{\mathrm{L}^{2}(\Omega)}\right] \\
& =\left(g, f D_{Z}^{*} V\right)-\left(g,\left\langle V, D_{Z} f\right\rangle_{H}\right) .
\end{aligned}
$$

Now we go back to the proof of Theorem 5..9.
Proof of Theorem 5..9. From $\theta[W(h)]=\int_{0}^{1}{ }^{t} \mathcal{U}^{-1} \cdot \mathrm{~d} B$, we get:

Let $Z$ such that $T_{\mathcal{U}}(Z)=\mathcal{U} Y \mathcal{U}^{-1}$ so $Z=T_{\mathcal{U}}^{-1}\left(\mathcal{U} Y \mathcal{U}^{-1}\right)$. With Lemma 5.9, $Z$ is a $\mathbb{D}^{\infty}-\alpha$-Holderian $n \times n$-A.M. matrix process with items in $H$; and we have:

\end{aligned}

Using Lemma 5..10, we get:

& +\left\langle f, \theta^{*}\left(\left\langle D_{Z} g, \mathcal{U} e_{i}\right\rangle_{H}\right)\right\rangle_{\mathrm{L}^{2}(\Omega)}
\end{align*}

From the formula $D_{Z} f=\sum_{i=1}^{\infty}\left(\operatorname{div} Z_{i} \operatorname{grad} f\right) e_{i}=\sum_{i=1}^{\infty}\left(D_{Z_{i}} f\right) e_{i}$, in Definition $5 . .4$, we deduce by duality that if $X \in \mathbb{D}^{\infty}(\Omega, H)$, then $D_{Z}^{*} X \in \mathbb{D}^{\infty}(\Omega)$. Then $D_{Z}^{*}\left(\mathcal{U} e_{i}\right) \in \mathbb{D}^{\infty}(\Omega)$, so $\theta^{*}\left(g D_{Z}^{*} \mathcal{U} e_{i}\right)$ is legitimate, and is a function. Then (19) becomes:

In this last equation, $\theta^{*}\left(\mathcal{U}^{-1} \operatorname{grad} g\right)$ and $\theta^{*}\left(\mathcal{U}^{-1} D_{Z} g\right)$ are $\mathrm{L}^{\infty-0}$-functions and $\operatorname{grad}\left(\theta^{*} g\right)$ a distribution ; so as distributions, we have:

As $\theta$ is the adjoint of $\theta^{*}, \theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}^{\infty}(\Omega)$.

Now we prove the converse of Theorem 5..9.
Theorem 5..10. If $\theta$, the $\mathrm{L}^{\infty-0}$-morphism generated by $\theta[W(h)]=\int_{0}^{1} t \dot{\mathcal{H}} \mathcal{U}^{-1} \cdot \mathrm{~d} B$, is a $\mathbb{D}^{\infty}$-diffeomorphism of $\mathbb{D}^{\infty}(\Omega)$ in itself, the linear pseudo-tangent map admits an inverse, in the space of the elementary tangent processes.

& =\int_{0}^{1}{ }^{t} \dot{h}\left(\mathcal{U}^{-1} T \mathcal{U} A \mathcal{U}\right) \mathcal{U}^{-1} \cdot \mathrm{~d} B \\
& =\theta\left[\int_{0}^{1}{ }^{t} \dot{h} \theta^{-1}\left(\mathcal{U}^{-1} T_{\mathcal{U}} A \mathcal{U}\right) \cdot \mathrm{d} B\right]
\end{aligned}
\end{aligned}

So the map $A \mapsto \theta^{-1}\left(\mathcal{U}^{-1} T_{\mathcal{U}} A \mathcal{U}\right)$ is inversible. Then the map $A \mapsto \mathcal{U}^{-1} T_{\mathcal{U}} A \mathcal{U}$ is inversible, so $A \mapsto T_{\mathcal{U}} A$ is inversible.

Before the next theorem, we first remark that: if $f$ is a polynomial in Gaussian variables, $f\left[W\left(h_{1}\right), \ldots, W\left(h_{n}\right)\right]$, then $\theta_{\mathcal{U}}(f) \in \mathbb{D}^{\infty}(\Omega)$; then if $z=$ it $+s$, and $s>0,(1-L)^{-(i t+s)}$ is legitimate as

LEMMA 5..11. If $\rho$ is an $\mathbb{D}^{\infty}-\alpha$-Holderian process, there exists $s, 0<$ $s<1$ and $\alpha+s>1$, such that $\rho * \beta_{1-s} \in \mathcal{C}^{1}$ and $g=\left(\rho * \beta_{1-s}\right)^{\prime}$ will be in $\mathrm{L}^{\infty-0}([0,1] \times \Omega)$

Proof. Proposition 2.2.i.
The next theorem of "local inversibility" is:
THEOREM 5..11. If $T_{\mathcal{U}}$ is inversible from the space of adapted $\mathbb{D}^{\infty}{ }^{\text {-multiplicators }}$ in itself, and ifU is $\mathbb{D}^{\infty}-\alpha$-Holderian with $\alpha>1 / 4$, then the morphism generated by $\theta, \theta[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B$, is a $\mathbb{D}^{\infty}$-morphism of $\mathbb{D}^{\infty}$ in itself.

As the proof of this theorem is more difficult and involves a fractionnal induction, we give the followed plan of the proof:
a) We first recall some notations in Lemma $5 . .4$, and establish that: if $\rho$ is a $\mathbb{D}^{\infty}-\alpha$-Holderian function with $\alpha>1 / 2$ then there exist a quantity $S\left(\rho E_{\ell, t}^{k}\right)$ such that

b) We then suppose that: $\theta: \mathbb{D}^{\infty}(\Omega) \rightarrow \mathbb{D}_{s}^{\infty}(\Omega)$. We will prove, using the above formula in a), that if $f \in \mathbb{D}^{\infty}(\Omega), D_{S\left(\rho E_{\ell}^{k}\right), t} \theta(f) \in \mathbb{D}_{s}^{\infty}(\Omega)$.

For this, first we prove it for $s \in \mathbb{N}_{*}$; and then if $s \notin \mathbb{N}_{*}, s>0$, we will use the Phragmen-Lindelöf method with an interpolation in the domain delimited by $E[s]$ and $E[s+1]$ to get this result.
c) There we will prove that $\rho$ being $\mathbb{D}^{\infty}{ }_{-} \alpha$-Holderian with $\alpha>0$, then $D_{S\left(\rho E_{\ell}^{k}\right)} \theta(f) \in \mathbb{D}_{s-2}^{\infty}$.
d) Then another interpolation, using the Phragmen-Lindelöf method, interpolation on $t$ this time, will proves Theorem 5..10.

Proof. a) $E_{\ell}^{k}$ is the $n \times n$-elementary antisymmetrical matrix, $D_{E_{\ell, t}^{k}} f=\operatorname{div} E_{\ell}^{k} \mathbb{1}_{[0, t]}(\cdot) \operatorname{grad} f$, with $f \in \mathbb{D}^{\infty}(\Omega)$ and if $\rho(t, \omega)$ is an $\mathbb{D}^{\infty}-\alpha$-Holderian process, $H$-valued, the integral $\int_{0}^{1} \rho \mathrm{~d}\left[\theta\left(D_{E_{\ell, t}^{k}} f\right)\right]$ is to be understood as a Russo-Valois integral, with $E_{\ell, t}^{k}=\mathbb{1}_{[0, t]}(\cdot) E_{\ell}^{k}$. $\quad \rho$ is $\mathbb{D}^{\infty}{ }_{-\alpha}$-Holderian, $H$ valued ; so $\rho$ is $\mathbb{D}^{\infty}$-bounded. Using the decomposition: $\rho=g * \beta_{s}$ with $g \in \mathrm{~L}^{p}(\Omega \times[0,1])$ and $\beta_{s} \in \mathrm{~L}^{1}$, uneasy computation shows that there exists $\varepsilon, 0<\varepsilon<\alpha-1 / 2$ such that

Now as we consider $f \in \mathbb{D}^{\infty}(\Omega)$, then $\theta\left(D_{E_{\ell, t}^{k}} f\right) \in \mathrm{L}^{\infty-0}(\Omega)$; suppose $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{s}^{\infty}, s \in \mathbb{N}_{*}$. But the lemma $5 . .5$, in which hypothesis are only i) and ii) brings as a result I), then $\operatorname{grad}^{s} \theta\left(D_{E_{\ell, t}^{k}} f\right)$ is an $1 / 2$-Holderian process $\left(s \in \mathbb{N}_{*}\right)$ and so

So $\int_{0}^{1} \rho \mathrm{~d}\left(\theta D_{E_{\ell, t}^{k}} f\right)$ exists as a Russo-Valois integral ; same for $\operatorname{grad}^{s}\left(\int_{0}^{1} \rho \mathrm{~d}\left(\theta D_{E_{\ell, t}^{k}} f\right)\right)$, with $s \in \mathbb{N}_{*}$, if $\rho \in \mathbb{D}^{\infty}(\Omega, H)$ and $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{s}^{\infty}(\Omega)$.

Now $T_{\mathcal{U}}$ being inversible, if $C=\rho E_{\ell, t}^{k}=\rho E_{\ell}^{k} \mathbb{1}_{[0, t[ }(\cdot), T_{\mathcal{U}}^{-1}\left(\mathcal{U C U}^{-1}\right)$ is denoted $S(C)$. We have:

If $\theta$ sends $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}_{s}^{\infty}(\Omega)$, but with $s$ non-integer, we will prove that $D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s}^{\infty}(\Omega)$ using the Phragmen-Lindelöf method on the strip of $\mathbb{R}^{2}$ delimited by $0 \leq s-E[s] \leq 1$, denoted $\Delta$.


Let $f$ be a polynomial on Gaussian variables and consider the function of $z, 0 \leq \mathfrak{R e}(z) \leq 1, \varphi$ being in $\mathbb{D}^{\infty}$, and $r=E[s]$; denote:

$$
F(z)=\left\langle\mathrm{e}^{z^{2}}(1-L)^{\frac{r+z}{2}}\left[\int_{\mathbb{R}} \rho(1-L)^{a z+b} \mathrm{~d}\left(\theta D_{E_{\ell, t}^{k}} f\right)\right], \varphi\right\rangle_{\mathrm{L}^{2}(\Omega)}
$$

We want that if $\mathfrak{R e}(z)=0,(1-L)^{a z+b} \theta\left(D_{E_{\ell, t}^{k}} f\right) \in \mathbb{D}_{r}^{\infty}$ and if $\mathfrak{R e}(z)=1$, $(1-L)^{a z+b} \theta\left(D_{E_{\ell, t}^{k}} f\right) \in \mathbb{D}_{r+1}^{\infty}$. These requirements imply: $a=-1 / 2, b=$ $(s-r) / 2 . \quad F(z)$ is holomorphic on $\Delta$ and is continuous on $\bar{\Delta} . \varphi$ being in $\mathbb{D}^{\infty}(\Omega),(1-L)^{\frac{r+z}{2}} \varphi$ exists and is in $\mathbb{D}^{\infty}(\Omega)$. So $|F(z)|$ is bounded on $\Delta$. Now $\forall p>1, \forall q$ such that $1 / p+1 / q=1$,

$$
|F(i \lambda)| \leq\|\varphi\|_{\mathrm{L}^{q}(\Omega)}\left\|\mathrm{e}^{-\lambda^{2}}(1-L)^{\frac{r+i \lambda}{2}} \int_{\mathbb{R}} \rho \mathrm{d}\left((1-L)^{a i \lambda+b} \theta D_{E_{\ell, t}^{k}} f\right)\right\|_{\mathrm{L}^{p}(\Omega)} .
$$

With the Sobolev logarithmic inequality, as $\theta\left(D_{E_{e, t}^{k}} f\right) \in \mathbb{D}_{s}^{\infty}$,

$$
(1-L)^{\frac{-i \lambda}{2}+\frac{s-r}{2}} \theta\left(D_{E_{\ell, t}^{k}} f\right) \in \mathbb{D}_{r}^{\infty},
$$

so

$$
\int_{\mathbb{R}} \rho \mathrm{d}\left((1-L)^{\frac{-i \lambda}{2}+\frac{s-r}{2}} \theta\left(D_{E_{\ell, t}^{k}} f\right)\right) \in \mathbb{D}_{r}^{\infty}(\Omega)
$$

and

$$
(1-L)^{\frac{r+i \lambda}{2}} \int_{\mathbb{R}} \rho \mathrm{d}\left((1-L)^{\frac{-i \lambda}{2}+\frac{s-r}{2}} \theta\left(D_{E_{\ell, t}^{k}} f\right)\right) \in \mathrm{L}^{\infty-0}(\Omega) .
$$

So $|F(i \lambda)| \leq\|\varphi\|_{L^{q}(\omega)} \times C_{1}(f), C_{1}(f)$ constant, $f$-dependant. A similar computation shows that: $|F(1+i \lambda)| \leq\|\varphi\|_{L^{q}(\omega)} \times C_{2}(f), C_{2}(f)$ constant, $f$-dependant. So
thanks to the Phragmen-Lindelöf method, we have:
$|F(s-r)| \leq\|\varphi\|_{\mathrm{L}^{q}(\Omega)} \times C_{3}(f), C_{3}(f) \in \mathrm{L}^{\infty-0}(\Omega)$. And

F(s-r)=(1-L)^{\frac{1}{2}} \int_{\mathbb{R}} \rho \mathrm{d}\left(\theta D_{E_{\ell, t}^{k}} f\right) \in \mathrm{L}^{\infty-0} .
$$

So $\int_{\mathbb{R}} \rho \mathrm{d}\left(\theta D_{E_{\ell, t}^{k}} f\right) \in \mathbb{D}_{s}^{\infty}(\Omega)$. As $\int_{\mathbb{R}} \rho \mathrm{d}\left(\theta D_{E_{\ell, t}^{k}} f\right)=D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f), \rho$ being $\mathbb{D}^{\infty}{ }_{-} \alpha$-Holderian with $\alpha>1 / 2$, if $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{s}^{\infty}$, then $D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f)$ sends $\mathbb{D}^{\infty}$ to $\mathbb{D}_{s}^{\infty}$.
c) Now we suppose again $s \in \mathbb{N}_{*}$ and $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{s}^{\infty}(\Omega)$. Then $D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f)=\operatorname{div} S\left(\rho E_{\ell, t}^{k}\right) \operatorname{grad} \theta(f)$ which shows that $D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s-2}^{\infty}(\Omega)$. If $\theta: \mathbb{D}^{\infty}(\Omega) \rightarrow \mathbb{D}_{s+1}^{\infty}(\Omega)$ then $D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s-1}^{\infty}(\Omega)$. So by interpolation, we have: for all $s \in \mathbb{R}$, if $\theta: \mathbb{D}^{\infty}(\Omega) \rightarrow \mathbb{D}_{s}^{\infty}(\Omega)$, then $D_{S\left(\rho E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s-2}^{\infty}(\Omega)$.
d) Now $\tilde{\rho}$ being an $\mathbb{D}^{\infty}-\alpha$-Holderian function, with $1>\alpha>0$, we consider $\tilde{\rho} * \beta_{1-z}, 0 \leq \mathfrak{R e}(z) \leq 1$; then $\tilde{\rho} * \beta_{1-z}$ is a $\gamma-\mathbb{D}^{\infty}$-Holderian function with $\gamma>\alpha+\mathfrak{R e}(z)$ and

$$
\left|\tilde{\rho} * \beta_{1-z}(t+h)-\tilde{\rho} * \beta_{1-z}(t)\right| \leq C h^{\alpha+\Re \mathfrak{i c}(z)}(1+|z|) .
$$

Now consider the function

$$
\tilde{F}(z)=\mathrm{e}^{z^{2}}\left\langle(1-L)^{a z+b} D_{S\left(\tilde{\rho} * \beta_{1-z} E_{\ell, t}^{k}\right)} \theta(f), \varphi\right\rangle_{\mathrm{L}^{2}(\Omega)}
$$

with $f$ a polynomial in Gaussian variables and $\varphi \in \mathbb{D}^{\infty}(\Omega), z$ such that $0 \leq$ $\mathfrak{R e}(z) \leq 1 / 2$. We will apply the Phragmen-Lindelöf method to $\tilde{F}(z)$, on the strip $0 \leq \mathfrak{R e}(z) \leq 1 / 2 . \tilde{F}(z)$ is holomorphic on $0<\mathfrak{R e}(z)<1 / 2$, continuous on $0 \leq \mathfrak{R e}(z) \leq 1 / 2$ and bounded on this domain thanks to the Sobolev logarithmic inequality.

$$
\begin{aligned}
& \text { If } \mathfrak{R e}(z)=0, \\
& \qquad \tilde{F}(i \lambda)=\mathrm{e}^{-\lambda^{2}}\left\langle(1-L)^{i a \lambda+b} D_{S\left(\tilde{\rho} * \beta_{1-i \lambda} E_{\ell, t}^{k}\right)} \theta(f), \varphi\right\rangle_{\mathrm{L}^{2}(\Omega)},
\end{aligned}
$$

then $\tilde{\rho} * \beta_{1-i \lambda}$ is Holderian with yield strictly greather than 0 and $D_{S\left(\tilde{\rho} * \beta_{1-i \lambda} E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s-2}^{\infty}$ (remind that we supposed $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{s}^{\infty}$ ). As we want $\tilde{F}(i \lambda) \in \mathrm{L}^{\infty-0}$, this implies: $-2 b+s-2=0$ so $b=s / 2-1$.

If $\mathfrak{R e}(z)=1 / 2$,

$$
\left.\tilde{F}\left(\frac{1}{2}+i \lambda\right)=\mathrm{e}^{\frac{1}{4}-\lambda^{2}+i \lambda}\left\langle(1-L)^{\left(\frac{1}{2}+i \lambda\right) a+b} D_{S\left(\tilde{\rho} * \beta_{\frac{1}{2}}-i \lambda\right.} E_{\ell, t}^{k}\right) \theta(f), \varphi\right\rangle_{\mathrm{L}^{2}(\Omega)},
$$

$\tilde{\rho} * \beta_{1 / 2-i \lambda}$ is $\mathbb{D}^{\infty}-\alpha$-Holderian with yield strictly greather than $1 / 2$, and

$$
D_{S\left(\tilde{\rho} * \beta_{1 / 2-i \lambda} E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s}^{\infty} .
$$

As we want: $\tilde{F}(1 / 2+i \lambda) \in \mathrm{L}^{\infty-0}$, we must have: $-(a+2 b)+s=0$ so $a=2$. Then $|\tilde{F}(z)|$ is bounded on the whole band $0 \leq \mathfrak{R e}(z) \leq 1 / 2$.

Now we remind equation (16) in Theorem 5..9, which is still valid in our setting:

\operatorname{grad} \theta[f]=D_{S\left(\tilde{\rho} * \beta_{1-z} E_{\ell, t}^{k}\right)} \theta(f)+\mathcal{U}(\theta(\operatorname{grad} f))
$$

Then for an induction to begin, we need $\operatorname{grad} \theta(f) \in \mathbb{D}_{s-1+\delta}^{\infty}, \delta>0$. For this, it is enough that $D_{S\left(\tilde{\rho} * \beta_{1-z} E_{\ell, t}^{k}\right)} \theta(f) \in \mathbb{D}_{s-1+\delta}^{\infty}, \delta>0$. Now we know that: for all $z$ such that $0 \leq \mathfrak{R e}(z) \leq 1 / 2,|\tilde{F}(z)| \in \mathrm{L}^{\infty-0}(\Omega)$. So we look for a $z \in[0,1 / 2]$ such that:

(1-L)^{2 \mathfrak{R c}(z)+\frac{s}{2}-1} D_{S\left(\tilde{\rho} * \beta_{1-z}\right)} \theta(f) \in \mathrm{L}^{\infty-0}
$$

with $D_{S\left(\tilde{\rho} * \beta_{1-z}\right)} \theta(f) \in \mathbb{D}_{s-1+\delta}^{\infty}$. This implies $-2(2 \mathfrak{R e}(z)+s / 2-1)+s-1+\delta=0$ wich implies $\mathfrak{R e}(z)>1 / 4$. Then $\operatorname{grad} \theta(f) \in \mathbb{D}_{s-1+\delta}^{\infty}$ and the induction can begin, so $\theta(f) \in \mathbb{D}^{\infty}$. Now we show that as $\mathcal{U}$ is $\gamma$-Holderian with $\gamma>1 / 4$, then the condition $\mathfrak{R e}(z)>1 / 4$ is fulfilled.

Now if we choose $\rho=f_{k}^{\ell}$, with

$$
\left(\operatorname{grad} \mathcal{U}^{-1}\right) \mathcal{U}=\sum_{k, \ell=1}^{n} f_{k}^{\ell} E_{\ell}^{k},
$$

( $f_{k}^{\ell}$ being extended as 0 on $\mathbb{R}_{-} \cup[2,+\infty[$, and affine on $[1,2]$ ). We have that each $f_{k}^{\ell}$ is $\alpha$-Holderian, $\gamma>1 / 4$. Then for all $(\ell, k), f_{k}^{\ell} * \beta_{z}$, with $\mathfrak{R e}(z)=1 / 4$, is in $\mathcal{C}^{1}$. So $\tilde{\varphi}_{k}^{\ell}=\left(f_{k}^{\ell} * \beta_{z}\right)^{\prime}$ exists (Proposition 2.2.i) and $\tilde{\rho}_{k}^{\ell} * \beta_{1-z}=f_{k}^{\ell}$, which is $\gamma$-Holderian with $\gamma>1 / 4$ (Proposition 2.2.iii).

Now we will prove another theorem of inversibility and $\mathbb{D}^{\infty}$-morphism, with another hypothesis on $\left(T_{\mathcal{U}}\right)^{-1}$.

Definition 5..5. A family $\left(A_{i}\right)_{i \in \mathbb{N}_{*}}$ of elementary tangent processes will be said to be a multiplicative family if and only if it verifies the following two conditions: $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ being an Hilbertian basis of $H$,
a) if $X \in \mathbb{D}^{\infty}(\Omega, H)$, then $\sum_{i=1}^{\infty} e_{i} \otimes A_{i} X \in \mathbb{D}^{\infty}(\Omega, H \otimes H)$,
b) $\left(X_{i}\right)_{i \in \mathbb{N}_{*}}$ being such that $\sum_{i=1}^{\infty} e_{i} \otimes X_{i} \in \mathbb{D}^{\infty}(\Omega, H \otimes H)$, then

$$
\sum_{i=1}^{\infty} A_{i} X_{i} \in \mathbb{D}^{\infty}(\Omega, H) .
$$

Lemma 5..12. The family $A_{i}=\mathcal{U}(t, \omega) e_{i} \cdot \mathcal{U}^{-1}(t, w), i \in \mathbb{N}_{*}$ is a mutiplicative family.

Proof. Condition a) of Definition 5..5. As $\mathcal{U}$ is a multiplicator, if $X \in$ $\mathbb{D}^{\infty}(\Omega, H), \mathcal{U} \cdot X \in \mathbb{D}^{\infty}(\Omega, H)$. Then:

$$
(\operatorname{grad} \mathcal{U}) \cdot X=\operatorname{grad}(\mathcal{U} \cdot X)-\mathcal{U}_{R}(\operatorname{grad} X)
$$

and

$$
\sum_{i=1}^{\infty} e_{i} \otimes A_{i} X=\mathcal{U}_{R}^{-1}(\operatorname{grad} \mathcal{U} \cdot X)
$$

Condition b) of Definition 5..5. $B$ being an $n \times n$-matrix, let $X \in \mathbb{D}^{-\infty}(\Omega, H)$; we define $B \cdot X$ by:

$$
\forall Y \in \mathbb{D}^{\infty}(\Omega, H),(B \cdot X, Y)=\left(X,{ }^{t} B Y\right)
$$

We will give meaning to $\operatorname{grad}(B \cdot X)$ with $X \in \mathbb{D}^{-\infty}(\Omega, H)$ by:

$$
\operatorname{grad}(B \cdot X)=(\operatorname{grad} B) \cdot X+B_{R}(\operatorname{grad} X)
$$

with $(\operatorname{grad} B) \cdot X$ defined on $Y \in \mathbb{D}^{\infty}(\Omega, H \otimes H)$ by

\begin{aligned}
(\operatorname{grad} B \cdot X, Y) & =\left(\operatorname{grad} B \cdot X, \sum_{k, \ell} Y^{k \ell} e_{k} \otimes e_{\ell}\right) \\
& =\left(X, \sum_{k=1}^{\infty}\left(e_{k}^{t} B\right)\left(\sum_{\ell=1}^{\infty} Y^{k \ell} e_{\ell}\right)\right)
\end{aligned}
$$

and $(B \operatorname{grad} X, Y)=\left(\operatorname{grad} X,{ }^{t} B Y\right)$.
Following a similar proof as in condition a) in the same way we have: if $X \in \mathbb{D}^{-\infty}(\Omega, H)$, then $\sum_{i=1}^{\infty} e_{i} \otimes A_{i} X \in \mathbb{D}^{-\infty}(\Omega, H \otimes H)$. Then the map $\Phi: \mathbb{D}^{-\infty}(\Omega, H) \rightarrow \mathbb{D}^{-\infty}(\Omega, H \otimes H)$,

\Phi(X)=\sum_{i=1}^{\infty} e_{i} \otimes A_{i} X \in \mathbb{D}^{-\infty}(\Omega, H \otimes H),
$$

admits as dual map:

\begin{aligned}
& \Phi^{*}: \mathbb{D}^{\infty}(\Omega, H \otimes H) \rightarrow \mathbb{D}^{\infty}(\Omega, H) \\
& \Phi^{*}\left(Y^{k \ell} e_{k} \otimes e_{\ell}\right)=-\sum_{i=1}^{\infty} A_{i}\left(Y^{i \ell} e_{\ell}\right) \in \mathbb{D}^{\infty}(\Omega, H)
\end{aligned}
$$

Now let a family of $\left(X_{i}\right)_{i \in \mathbb{N}_{*}}$ such that:

$$
\sum_{i=1}^{\infty} e_{i} \otimes X_{i} \in \mathbb{D}^{\infty}(\Omega, H \otimes H)
$$

Then $X_{i}=Y_{i}^{\ell} e_{\ell}$ is such that $Y=\sum_{i=1}^{\infty} Y_{i}^{\ell} e_{i} \otimes e_{\ell} \in \mathbb{D}^{\infty}(\Omega, H \otimes H)$ and

$$
\Phi^{*}(Y)=-\sum_{i=1}^{\infty} A_{i}\left(Y^{i \ell} e_{\ell}\right)=-\sum_{i=1}^{\infty} A_{i} X_{i} \in \mathbb{D}^{\infty}(\Omega, H)
$$

Theorem 5..12. Let $\mathcal{U}$ an adapted process, multiplicator with values in $n \times n$-unitary matrices ; and let $\theta_{\mathcal{U}}$ the associated morphism from $\mathrm{L}^{\infty-0}$ in itself. Let $A$ be an elementary tangent process, that is each $A$ is an $n \times n-A . M$., and is a multiplicator ; we define $T_{\mathcal{U}}$ by:

$$
T_{\mathcal{U}}(A)=\mathcal{U} D_{A} \mathcal{U}^{-1}+A
$$

$T$ is a "pseudo linear tangent map" of $\theta$.

We suppose that $T_{\mathcal{U}}$ admits an inverse $\left(T_{\mathcal{U}}\right)^{-1}$, which verifies the additional property: for each multiplicative family $\left(A_{i}\right)_{i \in \mathbb{N}_{*}},\left(T_{\mathcal{U}}\right)^{-1}\left(A_{i}\right)_{i \in \mathbb{N}_{*}}$ is a multiplicative family. Then if $\left(\theta_{\mathcal{U}}\right)^{-1}$ exists from $\mathrm{L}^{\infty-0}(\Omega)$ in itself, $\left(\theta_{\mathcal{U}}\right)^{-1}$ is a $\mathbb{D}^{\infty}$-morphism.

Proof. We write $\left(T_{\mathcal{U}}\right)^{-1}\left(A_{i}\right)=C_{i}$, with $A_{i}=\mathcal{U}(t, \omega)\left(e_{i} \cdot \mathcal{U}^{-1}\right)(t, \omega)$. $\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ being an Hilbertian basis of $H$, and $h \in H$, then straightforward computation shows that:

\begin{equation*}
e_{i} \cdot \theta[W(h)]-D_{C_{i}} \theta[W(h)]=\int_{0}^{1}{ }^{t} \dot{h} \mathcal{U}^{-1} e_{i} \mathrm{~d} s=\left\langle\mathcal{U} \theta(\operatorname{grad} W(h)), e_{i}\right\rangle_{H} . \tag{24}
\end{equation*}
$$

Both members of (24) are $\theta$-derivations, so (24) is still valid for polynomials in Gaussian variables.

Let $f$ such that $\theta(f) \in \mathbb{D}^{\infty}$; then $f \in \mathrm{~L}^{\infty-0}(\Omega)$ and if $f_{n}$ is a sequence of polynomials in Gaussian variables which converges $\mathrm{L}^{\infty-0}$ towards $f$ then (24) is still valid with $f$ as above, but (24) has to be rewritten:

\sum_{i=1}^{\infty} D_{C_{i}}[\theta(f)] e_{i}=\operatorname{grad} \theta(f)-\mathcal{U}[\theta \operatorname{grad} f] \tag{25}
\end{equation*}
$$

and is an equation using distributions. If $\alpha \in \mathrm{L}^{\infty-0}(\Omega), \sum_{i=1}^{\infty} D_{C_{i}}(\alpha) e_{i}$ is a distribution because

\begin{aligned}
\forall g \in \mathbb{D}^{\infty}(\Omega, H),\left(\sum_{i=1}^{\infty} D_{C_{i}}(\alpha) e_{i}, g\right) & =\left(\alpha, \sum_{i=1}^{\infty} D_{C_{i}}\left(\left\langle e_{i}, g\right\rangle_{H}\right)\right) \\
& =\left(\alpha, \operatorname{div}\left(\sum_{i=1}^{\infty} C_{i} \operatorname{grad}\left\langle e_{i}, g\right\rangle_{H}\right)\right)
\end{aligned}
$$

and now using Definition 5..5.b, as $\theta(f) \in \mathbb{D}^{\infty}(\Omega)$, we have:

$$
\sum_{i=1}^{\infty} D_{C_{i}}(\theta(f)) e_{i}=\operatorname{div}_{R}\left(\sum_{i=1}^{\infty} e_{i} \otimes C_{i} \operatorname{grad} \theta(f)\right)
$$

which is in $\mathbb{D}^{\infty}(\Omega, H)$ thanks to Definition 5..5.a; $\operatorname{grad} \theta(f) \in \mathbb{D}^{\infty}(\Omega, H)$ because $\theta(f) \in D^{\infty}$. Now we apply each item of (25) to $\mathcal{U} \theta(g)$ where $g$ is a polynomial vector map: so we see that there exist a $\mathbb{D}^{\infty}(\Omega, H)$ vector field $W$ such that

$$
\begin{equation*}
\int_{\Omega}\langle W, \mathcal{U} \theta(g)\rangle_{H}=(\operatorname{grad} f, g) \tag{26}
\end{equation*}
$$

Now we take a sequence, $g_{n}$, of polynomials vector maps, converging in $\mathbb{D}^{\infty}(\Omega, H)$ towards $g \in \mathbb{D}^{\infty}(\Omega, H)$. From (26), we see that the $L^{\infty-0}$-limit $(\operatorname{grad} f, g)$ exists and this for $f$ such that $\theta(f) \in \mathbb{D}^{\infty}$.

The set $\left\{f / \theta(f) \in \mathbb{D}^{\infty}\right\}$ is $L^{\infty-0}$-dense in $\mathrm{L}^{\infty-0}(\Omega)$ which implies $\operatorname{grad} f \in$ $\mathbb{D}^{\infty}(\Omega, H)$, so $f \in \mathbb{D}_{1}^{\infty}(\Omega)$. So (24) is then an equation in which, each item is a function.

Now we proceed by induction: we know, by hypothesis, that $\theta^{-1}: \mathbb{D}^{\infty} \rightarrow$ $\mathrm{L}^{\infty-0}$. Suppose that for all $f$ such that $\theta(f) \in \mathbb{D}^{\infty}$, then $f \in \mathbb{D}_{r}^{\infty}(\Omega)$. Then (25) can be rewritten:

$$
\operatorname{grad} f=\theta^{-1} \mathcal{U}^{-1}\left[\operatorname{grad} \theta(f)-\sum_{i=1}^{\infty} D_{C_{i}} \theta(f) e_{i}\right]
$$

which implies $\operatorname{grad} f \in \mathbb{D}_{r}^{\infty}(\Omega, H)$, so $f \in \mathbb{D}_{r+1}^{\infty}(\Omega)$ and $\theta^{-1}$ is a $\mathbb{D}^{\infty}$-morphism of $\mathbb{D}^{\infty}(\Omega)$ in itself.

Remark 5..9. If $\theta$ is a $\mathbb{D}^{\infty}$-diffeomorphism, $\left(T_{\mathcal{U}}\right)^{-1}$ will transform a multiplicative family $\left(A_{i}\right)_{i \in \mathbb{N}_{*}}$ in a multiplicative family $\left(\left(T_{\mathcal{U}}\right)^{-1} A_{i}\right)_{i \in \mathbb{N}_{*}}$.

Proof.

$$
T_{\mathcal{U}} A_{i}=\mathcal{U} D_{A} \mathcal{U}^{-1}+A_{i}=-\left(D_{A_{i}} \mathcal{U}\right) \mathcal{U}^{-1}+A_{i} .
$$

For the condition a): we have to show that if $X \in \mathbb{D}^{\infty}(\Omega, H)$,

$$
\sum_{i=1}^{\infty} e_{i} \otimes\left(T_{\mathcal{U}} A_{i}\right) X \in \mathbb{D}^{\infty}(\Omega, H \otimes H)
$$

It is enough to show that $\sum_{i=1}^{\infty} e_{i} \otimes\left(D_{A_{i}} \mathcal{U}\right) \mathcal{U}^{-1} X \in \mathbb{D}^{\infty}(\Omega, H \otimes H)$. As

$$
\sum_{i=1}^{\infty} e_{i} \otimes D_{A_{i}} f=\operatorname{div}_{R}\left(\sum_{i=1}^{\infty} e_{i} \otimes A_{i} \operatorname{grad} f\right)
$$

we see that: $f \mapsto \sum_{i=1}^{\infty} D_{A_{i}} f e_{i}$ is a derivation, that sends $\mathbb{D}^{\infty}(\Omega)$ in $\mathbb{D}^{\infty}(\Omega, H)$. So $\sum_{i=1}^{\infty} e_{i} \otimes\left(D_{A_{i}} \mathcal{U}\right) \mathcal{U}^{-1} X$ is in $\mathbb{D}^{\infty}(\Omega, H \otimes H)$.

Condition b): let $\Phi$ the map : $\mathbb{D}^{\infty}(\Omega, H \otimes H) \rightarrow \mathbb{D}^{\infty}(\Omega, H)$ that sends $\Phi\left(\sum_{i=1}^{\infty} e_{i} \otimes X_{i}\right)=\sum_{i=1}^{\infty} A_{i} X_{i}$. As $\left(A_{i}\right)_{i \in \mathbb{N}_{*}}$ is a multiplicative family, $\Phi$ is legitimate. Then, if $Z \in \mathbb{D}^{\infty}(\Omega, H)$ :

$$
\Phi^{*}: \mathbb{D}^{-\infty}(\Omega, H) \rightarrow \mathbb{D}^{-\infty}(\Omega, H \otimes H)
$$

and

$$
\Phi^{*}(Z)=-\sum_{i=1}^{\infty} e_{i} \otimes A_{i} Z
$$

So the same treatment as in condition a) above proves that the condition b) is fulfilled.

Now we know that $\left(T_{\mathcal{U}} A_{i}\right)_{i \in \mathbb{N}_{*}}$ is a multiplicative family. We will compute $\left(T_{\mathcal{U}}\right)^{-1}$ to prove that $\left(\left(T_{\mathcal{U}}\right)^{-1} A_{i}\right)_{i \in \mathbb{N}_{*}}$ is a multiplicative family. From $\theta[W(h)]=$ $\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B$ and $\theta^{-1}[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{V}^{-1} \cdot \mathrm{~d} B$, we deduce:

$$
\mathcal{V}=\theta^{-1}(\mathcal{U})
$$

Then

$$
\left(\theta^{-1} \circ D_{A} \circ \theta\right)(W(h))=\int_{0}^{1}{ }^{t} \dot{h} \theta^{-1}\left(D_{A} \mathcal{U}^{-1}\right) \mathcal{V} \cdot \mathrm{d} B+\int_{0}^{1}{ }^{t} \dot{h} \theta^{-1}\left(\mathcal{U}^{-1} A\right) \mathcal{V} \cdot \mathrm{d} B
$$

which implies:

$$
\left.\left(\theta^{-1} \circ D_{A} \circ \theta\right)(W(h))=D_{\theta^{-1}[\mathcal{U}-1} T_{\mathcal{U}}(A) \mathcal{U}\right](W(h)) .
$$

As we have supposed $\theta$ to be a $\mathbb{D}^{\infty}$-diffeomorphism:

$$
\left.\forall f \in \mathbb{D}^{\infty}(\Omega), \theta^{-1} \circ D_{A} \circ \theta=D_{\theta^{-1}[\mathcal{U}-1} T_{\mathcal{U}}(A) \mathcal{U}\right]
$$

We denote $S_{\mathcal{U}}(A)=\mathcal{U}^{-1} T_{\mathcal{U}}(A) \mathcal{U}$, then:

$$
\theta^{-1} \circ D_{A} \circ \theta=D_{\theta^{-1}\left(S_{\mathcal{u}}(A)\right)}
$$

We also have: $\theta \circ D_{A^{\prime}} \circ \theta^{-1}=D_{\theta\left[S_{\theta(\mathcal{U})}\right.} A^{\prime}$. So the maps $A \mapsto \theta^{-1}\left(S_{\mathcal{U}}(A)\right)$ and $A^{\prime} \mapsto \theta\left(S_{\theta(\mathcal{U})}\left(A^{\prime}\right)\right)$ are inverses.

So we have:

$$
\theta^{-1} \circ S_{\mathcal{U}} \circ \theta \circ S_{\theta(\mathcal{U})}=\mathrm{Id}
$$

So

$$
S_{\mathcal{U}} \circ \theta \circ S_{\theta(\mathcal{U})} \circ \theta^{-1}=\mathrm{Id}
$$

so $\theta \circ S_{\theta(\mathcal{U})} \circ \theta^{-1}$ is the inverse of $S_{\mathcal{U}}$. Then $T_{\mathcal{U}}$ is inversible, and $\left(\left(T_{\mathcal{U}}\right)^{-1} A_{i}\right)_{i \in \mathbb{N}_{*}}$ is a multiplicative family.

Two examples showing that the transformation $\theta: \theta[W(h)]=\int_{0}^{1} t \mathcal{U}^{-1} \cdot \mathrm{~d} B$, extended to $L^{\infty-0} \rightarrow L^{\infty-0}$, does not admit an inverse, even if $\mathcal{U}$ admits one.

Counter Example 5..1. Let $\left(B_{t}^{(1)}, B_{t}^{(2)}\right)$ an $\mathbb{R}^{2}$-Brownian, with $B_{0}^{(1)}=$ $B_{0}^{(2)}=0$, and denote $\Delta=\sqrt{\left(B_{t}^{(1)}\right)^{2}+\left(B_{t}^{(2)}\right)^{2}}$. And let

$$
\mathcal{U}(t, \omega)=\left(\begin{array}{cc}
\frac{B_{t}^{(1)}}{\Delta} & \frac{B_{t}^{(2)}}{\Delta} \\
-\frac{B_{t}^{(2)}}{\Delta} & \frac{B_{t}^{(1)}}{\Delta}
\end{array}\right) \quad \text { and } \quad \mathcal{U}(0, \omega)=\operatorname{Id}_{\mathbb{R}^{2}} .
$$

Then $\theta[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} \cdot \mathrm{~d} B$ can be extended in an $\mathrm{L}^{\infty-0}$-morphism, denoted again $\theta$. Then, if $R$ is a rotation with angle $\alpha$, in $\mathbb{R}^{2}$, with origin 0 ,

$$
R[\theta(W(h))]=\int_{0}^{1} R\left({ }^{t} \dot{\mathcal{h}} \mathcal{U}^{-1} \cdot \mathrm{~d} B\right)=\int_{0}^{1}{ }^{t} \dot{\mathcal{U}} \mathcal{U}^{-1} \cdot \mathrm{~d} B=\theta[W(h)] .
$$

Then by extension: $R(\theta(f))=\theta(f), \forall f \in \mathrm{~L}^{\infty-0}(\Omega)$. So $\theta$ cannot be surjective because there exists elements of $\mathrm{L}^{\infty-0}(\Omega)$ which are not invariant for rotations.

Counter Example 5..2. Let $W\left[\mathbb{1}_{[0, t]}(\cdot)\right]=\int_{0}^{t} \mathcal{U}_{s} \cdot \mathrm{~d} B_{s}$, with:
$\mathcal{U}_{s}=+1 \Longleftrightarrow B_{s} \geq 0$ and $\mathcal{U}_{s}=-1 \Longleftrightarrow B_{s}<0$. Then

$$
X_{t}=W\left[\mathbb{1}_{[0, t]}(\cdot)\right]=\int_{0}^{t}\left(\mathbb{1}_{\left\{B_{s} \geq 0\right\}}-\mathbb{1}_{\left\{B_{s}<0\right\}}\right) \cdot \mathrm{d} B_{s}=\int_{0}^{t}\left(\mathbb{1}_{\left\{B_{s}>0\right\}}-\mathbb{1}_{\left\{B_{s}<0\right\}}\right) \cdot \mathrm{d} B_{s} .
$$

And let $\theta$ the map $\mathcal{C}_{0}([0,1], \mathbb{R}) \rightarrow \mathcal{C}_{0}([0,1], \mathbb{R})$ defined by: $\theta(x)=-x$. Then

$$
\theta \circ X_{t}=\int_{0}^{t}\left(-\mathbb{1}_{\left\{B_{s}>0\right\}}+\mathbb{1}_{\left\{B_{s}<0\right\}}\right) \cdot\left(-\mathrm{d} B_{s}\right)=X_{t} .
$$

So the $\sigma$-algebra generated by the $X_{t}, \sigma\left(X_{t}\right)=\left\{X_{t} / t \in[0,1]\right\}$, is left invariant by $\theta$. But $\theta$ is not surjective because $\sigma\left(X_{t}\right) \subsetneq \mathcal{F}_{1}$, where $\sigma\left(X_{t}\right)$ is the $\sigma$-algebra generated by $\left\{X_{t} / t \in[0,1]\right\}$.

## 6. $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ is a $\mathbb{D}^{\infty}$-stochastic manifold

Let $V_{n}$ be an $n$-dimensional compact Riemannian manifold with the metric $g$, and let $\nabla$ be a connection on $V_{n}$, compatible with $g^{(1)}$; and $\Gamma_{j k}^{i}$ the Christoffel symbols.

## 6. 1 Introduction

We recall the definition of a Brownian motion $p_{t}, V_{n}$-valued, starting from $p(0)=m_{0} \in V_{n}$, and some of the properties of the stochastic parallel transport (SPT in short).
a) $\forall f \in C^{\infty}\left(V_{n}, g\right): f \circ p_{t}-f \circ p_{0}-\frac{1}{2} \int_{0}^{t} \Delta f \circ p_{s} \cdot d s=M_{f}(t), M_{f}(t)$ being a martingale.
b) The SPT is an intrinsic notion.
c) The scalar product is invariant by SPT: if $X_{1}$ and $X_{2}$ are two vectors in $T_{m_{0}} V_{n}$ and $X_{i}(t, \omega) \in T_{\omega(t)} V_{n}(i=1,2)$ are the SPT of $X_{1}$ and $X_{2}$ "along $\omega(t)$ ", then:

$$
g_{\omega(t)}\left(X_{1}(t, \omega), X_{2}(t, \omega)\right)=g_{m_{0}}\left(X_{1}, X_{2}\right)
$$

d) In a local chart of $\left(V_{n}, g\right), X^{k}(\omega, t)$ being the $k^{t h}$ coordinate of the SPT vector $X$, we have:

$$
\begin{equation*}
X^{k}(t, \omega)=-\int_{0}^{t} \Gamma_{i j}^{k}(p(s)) X^{j} \circ d p_{s}^{j} \tag{1}
\end{equation*}
$$

We will also denote by $X_{/ /}(t, \omega)$ the SPT of the vector $X \in T_{m_{0}} V_{n}$ "along the curve $(\omega(t))^{\prime \prime}$, at time $t$.
e) Let $(\mathcal{U}, \theta)$ be a chart centered on $m \in V_{n}, \mathcal{U}$ being the domain of the chart and $\theta$ the coordinate map. $u$ being an isomorphism of $\mathbb{R}^{n}$ in $T_{m_{0}} V_{n}$, and $e_{\alpha}, \alpha=1, \ldots, n$ the canonical basis unit vectors of $\mathbb{R}^{n}$, we denote $u_{\alpha}(t, \omega)$ the SPT of $u e_{\alpha}$, "along the curve $\omega(t)$ ", and by $Z_{\alpha}^{k}(t, \omega)=\left(\theta_{\star} u_{\alpha}(t, \omega)\right)^{k}$, the $k^{\text {th }}$ component of the vector $u_{\alpha}(t, \omega)$, when read in the chart $(\mathcal{U}, \theta)$. Then the matrix $Z_{\alpha}^{k}$ is invertible and if we write $d \tilde{B}_{t}^{k}=\left(Z^{-1}\right)_{\mu}^{k} d M_{f}^{\mu}(t), \tilde{B}_{t}$ is an $n$-dimensional Brownian motion, and we have:

$$
\begin{equation*}
d p_{t}^{k}=\frac{1}{2} \Delta p^{k} d s+Z_{\mu}^{k} \cdot d \tilde{B}^{\mu} \tag{2}
\end{equation*}
$$

(1) with possibly a non-vanishing torsion.

And direct calculus shows that:

$$
\begin{equation*}
d p_{t}^{k}=Z_{\mu}^{k} \circ d \tilde{B}^{\mu} \tag{3}
\end{equation*}
$$

Definition 6..1.
$H$ being the canonical C.M. space, $u$ an isomorphism of $\mathbb{R}^{n}$ in $T_{m_{0}} V_{n}$, and $u_{\alpha}(t, \omega)=\left(u e_{\alpha}\right)_{/ /}(t, \omega)$ as above, we denote:

$$
\tilde{H}=\left\{v(t, \omega)=\sum_{\mu=1}^{n} f^{\mu}(t) u_{\mu}(t, \omega) \mid f^{\mu} \in H\right\}
$$

$\tilde{H}$ is called the new Cameron-Martin space, in short: N.C.M.. A scalar product on $\tilde{H}$ is defined by:

$$
\left\langle v_{1}(t, \omega), v_{2}(t, \omega)\right\rangle_{\tilde{H}}=\sum_{\mu=1}^{n} \int_{0}^{1} \dot{f}_{1}(s) \dot{f}_{2}(s) d s
$$

With $\langle,\rangle_{\tilde{H}}, \tilde{H}$ is an Hilbert space.
Each $v(t, \omega) \in \tilde{H}$ is a process, valued in the fiber-tangent $T V_{n}$.
We recall the theorem of moment inequalities for martingales [8, p.110].
Theorem 6..1. If $\mathcal{M}$ is the set of continuous locally square integrable martingales, there exist universal constants $c_{p}$ and $C_{p}(1<p<+\infty)$ such that $\forall M \in \mathcal{M}$, and $t \geq 0$ :

$$
c_{p} \mathbb{E}\left[\max _{0 \leq s \leq t}\left|M_{s}\right|^{2 p}\right] \leq \mathbb{E}\left[\langle M, M\rangle_{t}^{p}\right] \leq C_{p} \mathbb{E}\left[\max _{0 \leq s \leq t}\left|M_{s}\right|^{2 p}\right]
$$

Corollary 6..1. The solution of the equation of the SPT, (1), is $\mathbb{D}^{\infty}$-bounded.

Proof. $\left(V_{n}, g\right)$ is a compact Riemannian manifold, and $0 \leq t \leq 1$.
The equation (1) shows that $X^{k}$ is $\in L^{\infty-0}(\Omega, H)$, but we do not know if $X^{k}$ admits as gradient a function. We can deduce from (1), that $X^{k}$ admits as gradient, a distribution; but we do not know if this distribution is a function.

To overcome this difficulty, we proceed as such:
If gradient $X^{k}$ exists, as a function, it will verify the equation:

$$
\begin{equation*}
\operatorname{grad} X^{k}=-\int_{0}^{t}\left(\operatorname{grad} \Gamma_{i j}^{k}\right) X^{j} \circ d p^{i}-\int_{0}^{t} \Gamma_{i j}^{k}\left(\operatorname{grad} X^{j}\right) \circ d p^{i}-\int_{0}^{t} \Gamma_{i j}^{k} X^{j} \circ \operatorname{grad} d p^{i} \tag{4}
\end{equation*}
$$

and $\operatorname{grad}\left(d p^{i}\right)$ can be computed with (2).

So we can look for a system of two unknown functions verifying equations (1) and (4): $V_{n}$ being a $C^{\infty}$ compact manifold, the coefficients of this system of two equations are all $C^{\infty}$-bounded; so the system ((1), (4)) admits a unique solution which is $L^{\infty-0}$-bounded. Iterating this process shows that the solution of $(1)$ is $\mathbb{D}^{\infty}$-bounded.

Corollary 6..2. If $u_{1}, \ldots, u_{k}$ are $k$ SPT vectors, and $\mathcal{T}$ is a $C^{\infty} k$-invariant tensor on $\left(V_{n}, g\right)$, then $\mathcal{T}\left(u_{1}, \ldots, u_{n}\right)$ is $\mathbb{D}^{\infty}$-bounded.

Proof. all derivatives of $\mathcal{T}$ are bounded on $\left(V_{n}, g\right)$ and
$\sup _{t \in[0,1]}\left\|u_{\mu}\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}, \mu=1, \ldots, k$ are all bounded. Then for the Malliavin derivative of order $r$ :
$\sup _{0 \leq 0 \leq 1}\left\|\operatorname{grad}^{r}\left(\mathcal{T}\left(u_{1}, \ldots, u_{n}\right)\right)\right\|_{\otimes H}^{r}$ is $L^{p}$-bounded.

## 6. 2 Construction of a $\mathbb{D}^{\infty}$-atlas on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$

Now we will construct on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ a $\mathbb{D}^{\infty}$-atlas:
Let two connections $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$ compatible with the metric $g$; the $\mathbb{D}^{\infty}$-atlas $\mathcal{A}$ on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ consists of two Wiener spaces $\mathcal{W}_{1}$ and $\mathcal{W}_{2}$, and the corresponding Itō maps $I_{1}$ and $I_{2}$. The chart change maps are then:

$$
J_{1}=I_{2}^{-1} \circ I_{1}, J_{2}=I_{1}^{-1} \circ I_{2}
$$

Now we limit ourselves to the case for which the trace of the tensor $\stackrel{(1)}{\nabla}-\stackrel{(2)}{\nabla}$ is zero, so that the Laplacian is invariant.

Otherwise $\mathcal{A}$ is still a $\mathbb{D}^{\infty}$-atlas on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$, but the calculus is more complex because the Brownians associated to the two connections differ by a drift (a vector field on $V_{n}$ ); and the image of the probability on the first chart, by any of the $J$ 's, differs from the probability on the second chart by a density.

Let $\theta$ be the morphism associated to the chart change map $J ; \theta$ leaves invariant laws and filtrations, so it leaves invariant the quadratic variations and the martingale property. So there exists an $n \times n$ matrix $\mathcal{V}$ such that $\theta\left(d B_{2}\right)=\mathcal{V} d B_{1}$, which implies if $h \in H_{2}: \theta[W(h)]=\int^{t} \dot{\mathcal{V}} \mathcal{V} d B_{1},{ }^{t} \dot{h}$ being the $n$-linear vector obtained by transposition of the $n$-column vector $\dot{h}$.

As $\theta$ keeps invariant the quadratic variation, we have ${ }^{t} \mathcal{V} \mathcal{V}=I d$; and as $\theta$ leaves invariant the filtrations, $\mathcal{V}$ is also an adapted process.

Lemma 6..1. $\mathcal{V}$ is a $\mathbb{D}^{\infty}$-process and a multiplicator.
Proof. We denote by $E(t, \omega)$ and $F(t, \omega)$ the frames on $V_{n}$, obtained by SPT when using the two connections $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$

From (1), we know that the SPT vectors which form the basis $E(t, \omega)$, $F(t, \omega)$ are $\mathbb{D}^{\infty}$-semi-martingales with martingales parts, $\alpha$-Hölderian $\left(\alpha<\frac{1}{2}\right)$, and bounded variations parts of class $C^{1}$.

Then from $\mathcal{V} E=F$, we get using Corollary $6 . .1$ that $\mathcal{V}$ is $\mathbb{D}^{\infty}$. As:

$$
\begin{equation*}
d \mathcal{V}=d F \cdot E^{-1}+F \cdot d E^{-1} \tag{5}
\end{equation*}
$$

$\mathcal{V}$ is a semi-martingale, with the martingale part being $\alpha$-Hölderian and the bounded variation part being of class $C^{1}$. The iterated gradients of $\mathcal{V}$ will verify similar equations, and so will be also semi-martingales with martingales parts being $\alpha$-Hölderian, and bounded variations parts being of class $C^{1}$. So $\mathcal{V}$ is a $\mathbb{D}^{\infty}$-multiplicator.

Now we write $\mathcal{U}^{-1}=\mathcal{V}$.

LEMMA 6..2. With the previous notations, if $\theta^{-1}(\mathcal{U})$ is a multiplicator from $\mathbb{D}^{\infty}\left(\Omega, L^{2}\left([0,1], \mathbb{R}^{n}\right)\right)$ in itself, and if $\theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right)$ is a multiplicator from $\mathbb{D}^{\infty}\left(\Omega, L^{2}\left([0,1], \mathbb{R}^{n}\right)\right)$ to $\mathbb{D}^{\infty}\left(\Omega, H \otimes L^{2}\left([0,1], \mathbb{R}^{n}\right)\right)$, then $\theta\left(\mathbb{D}^{\infty}\right) \subset \mathbb{D}^{\infty}(\Omega)$.

Note: $\theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right)$ acts on $\mathbb{D}^{\infty}\left(\Omega, L^{2}\left([0,1], \mathbb{R}^{n}\right)\right)$ by left-tensor
matrix multiplication; if $\vec{X}_{i j}$ is the $(i, j)$ vector entry of the
$n \times n$-matrix $\theta^{-1}\left[\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right]$, and if $\alpha_{k}(t, \omega), k=1, \ldots, n$ is an item of $\mathbb{D}^{\infty}\left(\Omega, L^{2}\left([0,1], \mathbb{R}^{n}\right)\right)$, we have:

$$
\left[\left(\theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right)\right)\left(\alpha_{k}\right)\right]_{i}=\sum_{l=1}^{m} \alpha_{l} \otimes \vec{X}_{i l}
$$

Proof. first we remind the definition of the operator denoted $\operatorname{div}_{R}$ :
If $X_{1}, \ldots, X_{k}$ are constant vectors of $H$, and if $Y_{1}, \ldots, Y_{k}$ are $\mathbb{D}^{\infty}$-vector fields, by definition:

$$
\operatorname{div}_{R}\left(\sum_{i=1}^{k} X_{i} \otimes Y_{i}\right)=\sum_{i=1}^{k}\left(\operatorname{div} Y_{i}\right) \cdot X_{i}(\text { see Chap. 5, before Lemma } 5,1)
$$

With Theorem 2, 4, and Corollary $2,4, \operatorname{div}_{R}$ can be extended in a continuous linear operator from $\mathbb{D}^{\infty}(\Omega, H \otimes H)$ to $\mathbb{D}^{\infty}(\Omega, H)$.
$\theta^{-1}$ being a continuous $\mathbb{D}^{\infty}$-morphism, for $h \in H$, we have:

\theta[W(h)]=\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} . d B
$$

so:

\operatorname{grad}[\theta(W(h))] & =\int_{0}^{1}{ }^{t} \dot{h} \operatorname{grad} \mathcal{U}^{-1} \cdot d B+\left(t \rightarrow \int_{0}^{t} \mathcal{U}^{-1} \dot{h} d s\right) \\
& =\int_{0}^{1}{ }^{t} \dot{h}\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right) \mathcal{U}^{-1} . d B+\left(t \rightarrow \int_{0}^{t} \mathcal{U}^{-1} \dot{h} d s\right)
\end{aligned}
$$

And:

$$
\begin{align*}
\theta^{-1}[\operatorname{grad} \theta(W(h))] & =\int_{0}^{1}{ }^{t} \dot{h} \theta^{-1}\left[\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right] \theta^{-1}\left(\mathcal{U}^{-1} \cdot d B\right)+\left(t \rightarrow \int_{0}^{t} \theta^{-1}\left(\mathcal{U}^{-1}\right) \dot{h} d s\right) \\
& =\int_{0}^{1}{ }^{t} \dot{h} \theta^{-1}\left[\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right] \cdot d B+\left(t \rightarrow \int_{0}^{t} \theta^{-1}\left(\mathcal{U}^{-1}\right) \dot{h} d s\right) \tag{6}
\end{align*}
$$

$\left(e_{i}\right)_{i \in \mathbb{N}_{\star}}$ being an Hilbertian basis of $H$, we define:
$\theta^{-1}[\operatorname{grad} \theta(f)]=\operatorname{div}_{R}\left[\sum_{l=1}^{\infty} e_{l} \otimes\left\langle e_{l}, \theta^{-1}\left(\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right)\right\rangle_{H} \operatorname{grad} f\right]+\left(t \rightarrow \int_{0}^{t} \theta^{-1}\left(\mathcal{U}^{-1}\right) \operatorname{grad} f d s\right)$

From the r.h.s. of (7), one can verify that the definition of $\theta^{-1}[\operatorname{grad} \theta(f)]$ is legitimate, and that it is a derivation on $\mathbb{D}^{\infty}(\Omega)$, by using $\mathcal{U}^{\star} \cdot \mathcal{U}=I d$; and that if $f=W(h)(h \in H)$, then (7) is identical to (6).

Moreover, $\theta^{-1}[\operatorname{grad} \theta(f)]$ is a $\mathbb{D}^{\infty}$-continuous derivation.
Now we proceed by induction:
we know that $\theta: \mathbb{D}^{\infty} \rightarrow L^{\infty-0}$. Suppose $\theta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}_{r}^{\infty}, r \in \mathbb{N}_{\star}$.
The r.h.s. of (7) implies that $\theta^{-1}[\operatorname{grad} \theta(f)] \in \mathbb{D}^{\infty}(\Omega, H)$, so:
$\theta \circ \theta^{-1}[\operatorname{grad} \theta(f)] \in \mathbb{D}_{r}^{\infty}$, which implies: $\operatorname{grad} \theta(f) \in \mathbb{D}_{r}^{\infty}$, so $\theta(f) \in \mathbb{D}_{r+1}^{\infty}$.
Lemma 6..3. If $\theta$ is an auto-diffeomorphism of $\mathbb{D}^{\infty}$ :
i) the associated $\mathcal{U}$ to $\theta$ is a $\mathbb{D}^{\infty}$-multiplicator.
ii) $\theta^{-1}(\mathcal{U})$ and $\theta\left(\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}\right)$ are multiplicators.

Proof. $\mathcal{U}$ being associated to the diffeomorphism $\theta$, is $\mathbb{D}^{\infty}$-bounded. From Corollary 4, 1 , we see that $\frac{B_{i}(t+h)-B_{i}(t)}{\sqrt{h}}$ are $h$-uniformly multiplicators which implies tha the same is true for the processes; $\frac{1}{h} \int_{t}^{t+h} \mathcal{U}_{i j} d B^{j}$, because:
let $V$ be a $\mathbb{D}^{\infty}$-vector field; $\theta^{-1}(V)$ is also a $\mathbb{D}^{\infty}$-vector field; then $\left(t \rightarrow \frac{B_{i}(t+h)-B_{i}(t)}{\sqrt{h}} \cdot \theta^{-1}(V)\right)$ is a $\mathbb{D}^{\infty}$-vector field and so is: $\left(t \rightarrow \theta\left\{\frac{B_{i}(t+h)-B_{i}(t)}{\sqrt{h}} \cdot \theta^{-1}(V)\right\}\right)$
which equals: $\left(t \rightarrow \theta\left[\frac{B_{i}(t+h)-B_{i}(t)}{\sqrt{h}}\right] \cdot V\right)$
or equals: $\left(t \rightarrow \frac{1}{\sqrt{h}} \int_{t}^{t+h} \mathcal{U}_{i j}^{-1} \cdot d B^{j}\right) . V$.
Then $\frac{1}{h}\left(\int_{t}^{t+h} \mathcal{U}_{i j}^{-1} . d B^{j}\right) \cdot\left(B_{k}(t+h)-B_{k}(t)\right)$ are $h$-uniformly
multiplicators, and with Itō's formula, denoting $M_{i}^{(1)}=\frac{1}{h} \int_{t}^{t+h} \mathcal{U}_{i j}^{-1} \cdot d B^{j}$ and $M_{k}^{(2)}=B_{k}(t+h)-B_{k}(t)$, we get:

Direct calculus shows that: $\int_{t}^{t+h} M_{i}^{(1)} \cdot d M_{k}^{(2)}+\int_{t}^{t+h} M_{k}^{(2)} . d M_{i}^{(1)}$ is $L^{2}$-bounded, $h$-uniformly.

So an extracted sequence of

converges $L^{2}$-weakly towards a limit.
But: $\frac{1}{h}\left(\int_{t}^{t+h} \mathcal{U}_{i j}^{-1} \cdot d B^{j}\right) \cdot\left(B_{k}(t+h)-B_{k}(t)\right) \in \mathcal{F}_{t}^{\perp} \cap \mathcal{F}_{t+h}$.
As the filtration is right-continuous, we have: $\lim _{h \downarrow 0} \mathcal{F}_{t}^{\perp} \cap \mathcal{F}_{t+h}=\{0\}$
Then an extracted sequence of $\frac{1}{h}\left(\int_{t}^{t+h} \mathcal{U}_{i j}^{-1} \cdot d B^{j}\right) \cdot\left(B_{k}(t+h)-B_{k}(t)\right)$ converges $L^{2}$-weakly towards 0 .

Combining these two extractions, we get a new sequence denoted again $\Phi_{h}^{i k}$ such that $\Phi_{h}^{i k}$ converges $L^{2}$-weakly towards $\mathcal{U}_{i k}^{-1}$ and such that:
$\frac{1}{h}\left(\int_{t}^{t+h} \mathcal{U}_{i j}^{-1} \cdot d B^{j}\right) \cdot\left(B_{k}(t+h)-B_{k}(t)\right)$ converges $L^{2}$-weakly towards 0.
Then a barycentric net $B_{h}^{i k}$ built with the $\Phi_{h}^{i k}$, will converge $L^{2}$ strongly towards $\mathcal{U}_{i k}^{-1}$.

With the same barycentric combination that was used to get $B_{h}^{i k}$ from the sequence $\left(\Phi_{h}^{i k} / h \downarrow 0\right)$, but this time applied to the sequence
$\left\{\left(\frac{1}{h} \int_{t}^{t+h} \mathcal{U}_{i j}^{-1} . d B^{j}\right) \cdot\left(B_{t+h}^{k}-B_{t}^{k}\right) / h \downarrow 0\right\}$, we get a net of $h$-uniform multiplicators, denoted $M_{h}^{i k}$.

Then: $\forall X \in \mathbb{D}^{\infty}(\Omega, H)$, we have:
$\forall(p, r)$ and $\forall(i, k) \in \mathbb{N}_{\star} \times \mathbb{N}_{\star}: \sup _{h}\left\|M_{h}^{i k} \cdot X\right\|_{\mathbb{D}_{r}^{p}(\Omega, H)}$ bounded and $M_{h}^{i k} X$ converges $L^{2}$-strongly towards $\mathcal{U}_{i k}^{-1} X$.

Then, by interpolation, we have that $\mathcal{U}_{i k}^{-1}$ is a $\mathbb{D}^{\infty}(\Omega, H)$ multiplicator.
ii) $\mathcal{U}$ is a $\mathbb{D}^{\infty}$ multiplicator: so if $V$ is a $\mathbb{D}^{\infty}$-vector field, $\mathcal{U} \cdot \theta(V)$ is also a $\mathbb{D}^{\infty}$-vector field; and then $\theta^{-1}(\mathcal{U}) \cdot \theta^{-1} \theta(V)$ is a $\mathbb{D}^{\infty}$-vector field which implies that: $\theta^{-1}(\mathcal{U})$ is a $\mathbb{D}^{\infty}$-multiplicator.

Similar proof for $\operatorname{grad} \mathcal{U}^{-1} \cdot \mathcal{U}$, with a vector field $V \in \mathbb{D}^{\infty}(\mathcal{W}, H)$, then $\left(\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}\right) \theta(V) \in \mathbb{D}^{\infty}(\mathcal{W}, H \otimes H)$.

Now we have:
Theorem 6..2. The set $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ can be endowed with a $\mathbb{D}^{\infty}$-stochastic manifold structure.

Proof. Let $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$ be two connections on $\left(V_{n}, g\right)$, both compatible with $g, I_{1}$ and $I_{2}$ the respectively associated Ito maps, $J=I_{2}^{-1} \circ I_{1}$ the chart change map, and $\theta$ the morphism associated with $J$.

We suppose that $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$ both verify the Driver condition, so the associated Laplacians $\stackrel{(1)}{\Delta}$ and $\stackrel{(2)}{\Delta}$ are equal (see following Lemma 6, 4).

Then if $\tilde{B}_{1}$ and $\tilde{B}_{2}$ are the associated Brownians, we have:

d \tilde{B}_{2}=\mathcal{U}^{-1} d \tilde{B}_{1}=\theta\left(d \tilde{B}_{1}\right) \tag{8}

$\tilde{B}_{1}$ and $\tilde{B}_{2}$ being as in (2), and $\mathcal{U}$ being associated to $\theta$, such that: $\theta[W(h)]=$ $\int_{0}^{1} t \dot{h} \mathcal{U}^{-1} . d \tilde{B}_{1}$.

From (8), we get: $\mathcal{U}\left(\omega_{1}\right) d \tilde{B}_{2}=d \tilde{B}_{1}$, so: $\theta(\mathcal{U}) d \tilde{B}_{2}=d \tilde{B}_{1}$, which implies that $\theta(\mathcal{U})$ is a $\mathbb{D}^{\infty}$-multiplicator.

From $\mathcal{U} d \tilde{B}_{2}=d \tilde{B}_{1}$, we deduce:

\operatorname{grad} \mathcal{U}^{-1} \cdot d \tilde{B}_{1}+\mathcal{U}^{-1} \cdot \operatorname{grad}\left(d \tilde{B}_{1}\right)=\operatorname{grad}\left(d \tilde{B}_{2}\right)

This last SDE shows that grad $\mathcal{U}^{-1}$ is a $\mathbb{D}^{\infty}$-multiplicator, and then $\operatorname{grad} \mathcal{U}^{-1} \mathcal{U}$ is a $\mathbb{D}^{\infty}$-multiplicator.

Then from Lemma 4,2 , we get that $\theta$ is a $\mathbb{D}^{\infty}$-diffeomorphism and that $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ with this chosen atlas is a $\mathbb{D}^{\infty}$-stochastic manifold.

Lemma 6..4. If two connections $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$ on the $n$-dimensional compact manifold $V_{n}$ are compatible with the metric $g$, and if both connections verify the
(1) (2)

Driver condition, then the Laplacians $\Delta$ and $\Delta$ are identical.
Proof. Denote $M(u, v)=\stackrel{(1)}{\nabla}_{u} v-\stackrel{(2)}{\nabla}_{u} v$.
 torsions of the connections $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$.

Then from $u . g(v, v)-u . g(v, v)=0$, we have:

From $v \cdot g(u, v)-v \cdot g(u, v)=0$, we have:

And because $\stackrel{(1)}{\nabla}$ and $\stackrel{(2)}{\nabla}$ verify the Driver condition, we have:

\end{equation*}
$$

From (9), (10), (11) we get: $g(u, M(v, v))=0$, so: $M(v, v)=0, \forall v$.
As $\stackrel{(1)}{\Delta}-\stackrel{(2)}{\Delta}=\sum_{i=1}^{n} \stackrel{(1)}{\nabla}_{e_{i} e_{i}}-\sum_{i=1}^{n} \stackrel{(2)}{\nabla}_{e_{i}} e_{i}$, we get: $: \stackrel{(1)}{\Delta}=\stackrel{(2)}{\Delta}$.

## 7. Derivations on $\mathbb{P}_{m_{0}}\left(V_{n}\right)$

Let $\left(V_{n}, g\right)$ be a Riemannian $n$-dimensional compact manifold with connection $\nabla$, compatible with $g$, and $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ be as usual the set of all continuous paths: $[0,1] \rightarrow V_{n}$, starting from $m_{0} \in V_{n}$.

We now want to prove that under the Driver condition, the $\mathbb{D}^{\infty}$-module generated by a specific type of derivations (being built using $C^{\infty}$ vector fields on $V_{n}$ ), is "dense" in the set of all $\mathbb{D}^{\infty}$-continuous derivations.

## 7. 1 If any $D_{v}$-type of derivation has an unique $\mathbb{D}^{\infty}$-derivation extension, the Driver condition is fullfilled

We denote by $I$ the Ito application of the Wiener space $\mathcal{W}$ into $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$, and if $f \in C^{\infty}\left(V_{n}\right)$, by

F_{f, t}(\omega)=(f \circ I)(\omega)(t) \tag{1}
\end{equation*}
$$

$\tilde{H}$ being the NCM as in Definition $(5,1)$, we define, with $v \in \tilde{H}$, an operator $\mathrm{D}_{v}$ by:

\mathrm{D}_{v}\left(F_{f, t}\right)(\omega)=\left.(v \cdot f)\right|_{I(\omega)(t)} \tag{2}
\end{equation*}
$$

We will show that if the Driver condition is satisfied, $\mathrm{D}_{v}$ can be extended in a $\mathbb{D}^{\infty}$-continuous derivation on $\mathbb{D}^{\infty}(\Omega)$, and conversely.

The Driver condition being: if $T$ is the torsion of the manifold,

$$
\forall u, v \in \Gamma\left(V_{n}\right), \quad g(T(u, v), v)=0 .
$$

We first show that $D_{v}$ is an adapted derivation, assuming it has a unique extension on $\mathbb{D}^{\infty}$, denoted again $D_{v}$. For this we need:

Lemma 7..1.

\sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right]=\mathcal{F}_{t}
$$

Proof. The inclusion

\sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right] \subset \mathcal{F}_{t}
$$

is trivial. To prove the reverse inclusion, it is enough to prove that

\tilde{B}_{t} \in \sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right]
$$

$\tilde{B}_{t}$ being defined as in Section 6, introduction a).

$$
\mathrm{d} \tilde{B}_{t}^{k}=\left(Z^{-1}\right)_{\mu}^{k} \mathrm{~d} M_{t}^{\mu}
$$

We have with Section 6 notations:

Z_{\mu}^{k} & =\left(\theta_{*} u_{\mu}(\omega, t)\right)^{k}, \\
\mathrm{~d} Z_{\mu}^{k} & =-\Gamma_{i \ell}^{k} Z_{\mu}^{\ell} \circ \mathrm{d} p^{i}
\end{aligned}

so $Z_{\mu}^{k}$ is the solution of a SDE with coefficients in $\sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right]$, so $Z_{\mu}^{k} \in \sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right]$.

Now from (6,3) we have

\mathrm{d} \tilde{B}_{t}^{\ell}=\left(Z^{-1}\right)_{k}^{\ell} \circ \mathrm{d} p_{t}^{k}
$$

Then, as $\left(Z^{-1}\right)_{\ell}^{k} \in \sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right]$,

\tilde{B}_{t} \in \sigma\left[F_{f, s} / s \leq t, f \in C^{\infty}\left(V_{n}\right)\right] .
$$

Theorem 7..1. Assuming there exists a unique extension of $D_{v}$, defined on its domain by (2), this extension is an adapted derivation.

Proof. The definition (2) of $D_{v}$ and Lemma $7 . .1$ show that: $D_{v} F_{f, t} \in \mathcal{F}_{t}$. So the extension of $D_{v}$ to $\mathbb{D}^{\infty}$ being supposed $\mathbb{D}^{\infty}$-continuous, $D_{v}$ is an adapted derivation.

Theorem 7..2. The NSC for $D_{v}(v \in \tilde{H})$ to have a unique $\mathbb{D}^{\infty}$-continuous, adapted extension on $\mathbb{D}^{\infty}(\mathcal{W})$ with zero divergence is the Driver condition: if $T$ is the torsion of $\nabla$,

$$

\forall u, v \in \Gamma\left(V_{n}\right), \quad g(T(u, v), u)=0 \tag{3}
\end{equation*}
$$

Before proving Theorem 7..2, we need some lemmas.
Lemma 7..2. $Z_{\mu}^{k}=(Z(t, \omega))_{\mu}^{k}$ is a $\mathbb{D}^{\infty}$-bounded process.
Proof. This is corollary 6, 1 .
To prove that (3) is a necessary condition, we suppose now that $D_{v}$ can be extended in a $\mathbb{D}^{\infty}$-continuous unique adapted derivation on $\mathbb{D}^{\infty}(\mathcal{W})$, again denoted $D_{v}$.

Lemma 7..3. If $v \in \tilde{H}, D_{v}\left(Z_{\mu}^{k}\right)$ and $\Gamma_{i j}^{k} Z_{\mu}^{i} v^{j}$ are $\mathbb{D}^{\infty}$-bounded semi-martingales.
Proof.
i)

\begin{aligned}
\mathrm{d} Z_{\mu}^{k} & =-\Gamma_{i j}^{k} Z_{\mu}^{j} \circ \mathrm{~d} p^{i} \\
& =-\Gamma_{i j}^{k} Z_{\mu}^{j} \cdot \mathrm{~d} p^{i}-\frac{1}{2}\left[\mathrm{~d}\left(\Gamma_{i j}^{k} Z_{\mu}^{j}\right), \mathrm{d} p^{i}\right]
\end{aligned}
$$

The bracket gives a $\mathbb{D}^{\infty}$-bounded process $\times \mathrm{d} t$ denoted: $\widehat{Z}_{\mu}^{k} \cdot \mathrm{~d} t$ and $D_{v} \widehat{Z}_{\mu}^{k}$ has meaning because we have supposed that $D_{v}$ is a derivation on $\mathbb{D}^{\infty}(\mathcal{W})$. Then:

D_{v}\left(\Gamma_{i j}^{k} Z_{\mu}^{j} \cdot \mathrm{~d} p^{i}\right)=\left(D_{v} \Gamma_{i j}^{k}\right) Z_{\mu}^{j} \cdot \mathrm{~d} p^{i}+\Gamma_{i j}^{k}\left(D_{v} Z_{\mu}^{j}\right) \cdot \mathrm{d} p^{i}+\Gamma_{i j}^{k} Z_{\mu}^{j} D_{v}\left(\mathrm{~d} p^{i}\right)
$$

But

D_{v}\left(\mathrm{~d} p^{i}\right)=\mathrm{d}\left(D_{v} p^{i}\right)=d v^{i} \tag{4}
\end{equation*}

and $v^{i}$ is a $\mathbb{D}^{\infty}$-S.M.
ii) $\Gamma_{i j}^{k}\left(p_{t}\right)$ is a S.M, and $\Gamma_{i j}^{k} Z_{\mu}^{i} v^{j}$ is the product of three S.M.

Proof of the necessary condition. Now, from

We suppose that $D_{v}\left(\mathrm{~d} \tilde{B}^{k}\right)$ has the form

where $t \mapsto \int_{0}^{t} \dot{h}_{1} \mathrm{~d} s$ is a $\mathbb{D}^{\infty}$-vector field. Reporting (6) and (4) in (5):

From $g(T(X, Y), X)=0$, we deduce $g(T(U, Y), V)=-g(T(V, Y), U)$.

& =\left(v \cdot \mathscr{C}_{i_{j}}\right)\left(x_{j}^{i_{j}}\right)-\mathscr{C}_{i_{j}}\left(\Gamma_{\alpha_{j}, \beta_{j}}^{i_{j}} x_{j}^{\beta_{j}} v^{\alpha_{j}}\right)-\mathscr{C}_{i_{j}}\left(T_{\alpha_{j}, \beta_{j}}^{i_{j}} v^{\beta_{j}} x_{j}^{\alpha_{j}}\right)-\mathscr{C}_{i_{j}}\left(x_{\lambda_{j}}^{i_{j}} A_{j}^{\lambda_{j}}\right) \\
& =\left(\nabla_{v} \mathscr{C}\right)\left(x_{j}\right)-\mathscr{C}_{i_{j}}\left(T^{i_{j}}\left(x_{j}, v\right)+x_{\lambda_{j}}^{i_{j}} A_{j}^{\lambda_{j}}\right)
\end{aligned}
$$

So

$$
D_{v}\left[\mathscr{C}\left[x_{1}, \ldots, x_{k}\right]\right]=\left(\nabla_{v} \mathscr{C}\right)\left(x_{1}, \ldots, x_{k}\right)-\sum_{j=1}^{k} \mathscr{C}\left(x_{1}, \ldots, x_{j-1}, T\left(x_{j}, v\right)+A_{j}^{\lambda_{j}} x_{\lambda_{j}}, \ldots, x_{k}\right)
$$

We now apply this result to a bilinear symmetrical form on $\left(V_{n}, g\right)$, denoted $q$, and compatible with the operator $\nabla$ of the connection on $\left(V_{n}, g\right)$ :

0 & =D_{v} q\left(x_{1}(t, \omega), x_{2}(t, \omega)\right) \\
& =\left(\nabla_{v} q\right)\left(x_{1}, x_{2}\right)-q\left(x_{1}, A x_{2}+T\left(x_{2}, v\right)\right)-q\left(A x_{1}+T\left(x_{1}, v\right), x_{2}\right) \\
& =\left(\nabla_{v} q\right)\left(x_{1}, x_{2}\right)-q\left(x_{1}, A x_{2}\right)-q\left(x_{1}, T\left(x_{2}, v\right)\right)-q\left(A x_{1}, x_{2}\right)-q\left(T\left(x_{1}, v\right), x_{2}\right) \\
& =q\left(T\left(x_{1}, v\right), x_{2}\right)-q\left(x_{1}, T\left(x_{2}, v\right)\right)
\end{aligned}
$$

because $\nabla_{v} q=0$ and the antisymmetry of $A$. Which implies $q(T(x, y), x)=0$.
We recall that $\tilde{H}$, the NCM (New Cameron-Martin space) is the set

\left\{\sum_{\mu=1}^{n} f^{\mu}(t) u_{\mu}(t, \omega) / f^{\mu} \in H \text { and } u_{\mu}(t, \omega)=u e_{\mu}\right\}
$$

$u_{\mu}(t, \omega)$ is the SPT of $u e_{\mu}$, evaluated at instant $t \in[0,1]$ "along $\omega^{\prime \prime} ;\left(e_{\mu}\right)_{\mu=1, \ldots, n}$ is the canonical basis of $\mathbb{R}^{n}$ and $u$ is the isomorphism between $\mathbb{R}^{n}$ and $T_{m_{0}} V_{n}$.

The scalar product on $\tilde{H}$ is

$$
\left\langle\sum_{\mu=1}^{n} f^{\mu}(\cdot) u_{\mu}, \sum_{\nu=1}^{n} g^{\mu}(\cdot) u_{\nu}\right\rangle_{\tilde{H}}=\sum_{\mu=1}^{n} \int_{0}^{t} \dot{f}^{\mu}(t) \dot{g}^{\mu}(t) \mathrm{d} t
$$

with this scalar product, $\tilde{H}$ is complete.
There is a correspondence between $\tilde{H}$ and $H: \forall v \in \tilde{H}, v=\sum f^{\mu} u_{\mu}(t, \omega)$, we associate the element of $H:\left(f^{\mu}(t)\right)_{\mu=1, \ldots, n}$. This correspondence is an isometry and the image of v is denoted $h(v): h(v)=\left(f^{\mu}(t)\right)_{\mu=1, \ldots, n}$. As a basis $\check{B}$ of $\tilde{H}$, we choose the following elements of $\tilde{H}$ :

\varepsilon_{k, j}^{\prime}=t \mapsto\left(\sqrt{2} \int_{0}^{t} \sin 2 \pi k s \cdot \mathrm{~d} s\right) u_{j}(t, \omega) \\
\varepsilon_{j}^{\prime \prime}=t \mapsto\left(\int_{0}^{t} 1 \cdot \mathrm{~d} s\right) u_{j}(t, \omega)
\end{array}\right.
$$

$\check{B}$ is a basis of $\tilde{H}$. We denote by $\varepsilon_{\rho}$ (or $\varepsilon_{i}$ ) the generic basis vector of $\check{B}$. Now we will define an operator denoted again grad, but associated to the NCM. $\varepsilon$
being a vector of $\check{B}$, we recall that

(A(\varepsilon))_{\mu}^{k}(t, \omega)=\int_{0}^{t} a_{1, \mu}^{k}(\varepsilon) \mathrm{d} s+\int_{0}^{t} b_{\mu, \rho}(\varepsilon) \cdot \mathrm{d} \tilde{B}^{\rho} \tag{24}
\end{equation*}
$$

and

$$
\begin{align*}
b_{\mu, \rho}^{k}(\varepsilon) & =\left(R_{j r i}^{\alpha}+\nabla_{r} T_{j i}^{\alpha}\right) Z_{\mu}^{i} Z_{\rho}^{r}\left(Z^{-1}\right)_{\alpha}^{k} \varepsilon^{j}  \tag{25}\\
a_{2, \mu}^{k}(\varepsilon) & =\dot{h}^{\alpha}(\varepsilon)(t) T_{s r}^{\nu} Z_{\mu}^{r} Z_{\alpha}^{s}\left(Z^{-1}\right)_{\nu}^{k} \tag{26}
\end{align*}
$$

## 7. 4 Definition of the new-gradient on $\mathbb{D}^{\infty}$.

Definition 7..1. $\left(v_{i}\right)_{i \in \mathbb{N}_{*}}$ being a basis of $\tilde{H}$, we define, for $f \in \mathbb{D}^{\infty}$

\operatorname{grad} f=\sum_{i=1}^{\infty}\left(D_{v_{i}} f\right) v_{i} \tag{34}
\end{equation*}
$$

We have to show that this definition is legitimate and that $\operatorname{grad} f$ is a derivation (trivial). We will show that first, with the basis $\check{B}$, the defining series in (33) is $\mathbb{D}^{\infty}$-convergent. For this it is enough to prove:

Lemma 7..4. If $f, g \in \mathbb{D}^{\infty}$, then $\sum_{\rho=1}^{\infty} D_{\varepsilon_{\rho}} f \cdot D_{\varepsilon_{\rho}} g$ is $\mathbb{D}^{\infty}$-convergent. Nota: $\varepsilon_{\rho}$ is either $\varepsilon_{\ell, j}, \varepsilon_{k, j}^{\prime}$ or $\varepsilon_{j}^{\prime \prime}$, basis vectors of $\check{B}$.

To prove Lemma $7 . .4$, it is enough to prove that $\left(D_{\varepsilon_{\rho}} f\right)_{\rho \in \mathbb{N}_{*}}$ is a $\mathbb{D}^{\infty}$ vector field. From (23), we have:

D_{\varepsilon_{\rho}} f=\operatorname{div} A\left(\varepsilon_{\rho}\right) \operatorname{grad} f+\left(t \mapsto \int_{0}^{t} \dot{h}_{1}\left(\varepsilon_{\rho}\right)(s) \mathrm{d} s\right) \\
\dot{h}_{1}\left(\varepsilon_{\rho}\right)=\sqrt{2} \cos (2 \pi \rho t)+\frac{1}{2} \sum_{\mu=1}^{n} b_{\mu, \mu}  \tag{33}\\
\text { or } \sqrt{2} \sin (2 \pi \rho t)+\frac{1}{2} \sum_{\mu=1}^{n} b_{\mu, \mu} \tag{27}
\end{gather*}
$$

with

$$
b_{\mu, \mu}(\varepsilon)=\left(R_{j r i}^{\alpha}+\nabla_{r} T_{j i}^{\alpha}\right) Z_{\mu}^{i} Z_{\mu}^{r}\left(Z^{-1}\right)_{\alpha}^{j} h\left(\varepsilon_{\rho}\right)
$$

$\left(\dot{h}\left(\varepsilon_{\rho}\right) \neq \dot{h}_{1}\left(\varepsilon_{\rho}\right)\right)$. Now, using $\left|\int_{0}^{t} \cos 2 \pi \ell s \mathrm{~d} s\right| \leq \frac{C_{0}}{\ell}$ and $\left|\int_{0}^{t} \sin 2 \pi k s \mathrm{~d} s\right| \leq \frac{C_{0}}{k}$, $C_{0}$ being a constant, we see that

$$
\left(t \mapsto \int_{0}^{t} \dot{h}_{1}\left(\varepsilon_{\rho}\right)(s) \mathrm{d} s\right)_{\rho \in \mathbb{N}_{*}}
$$

is a $\mathbb{D}^{\infty}$-vector field.

To be able to do the same trick with $\operatorname{div} A\left(\varepsilon_{\rho}\right) \operatorname{grad} f$, we know that:

A\left(\varepsilon_{\rho}\right)_{\mu}^{k}=\int_{0}^{t} a_{1, \mu}^{k}\left(\varepsilon_{\rho}\right) \mathrm{d} s+\int_{0}^{t} b_{\mu, \alpha}^{k}\left(\varepsilon_{\rho}\right) \cdot \mathrm{d} \tilde{B}^{\alpha} \tag{24}
\end{equation*}
$$

with

$$
b_{\mu, \alpha}^{k}\left(\varepsilon_{\rho}\right)=\left(R_{j r i}+\nabla_{r} T_{j i}^{m}\right) Z_{\mu}^{i} Z_{\alpha}^{r}\left(Z^{-1}\right)_{m}^{k} \varepsilon_{\rho}
$$

and

$$
a_{1, \mu}^{k}\left(\varepsilon_{\rho}\right)=\dot{h}\left(\varepsilon_{\rho}\right)^{\alpha} T_{s r}^{\nu} Z_{\mu}^{r} Z_{\alpha}^{s}\left(Z^{-1}\right)_{\nu}^{k}+\frac{1}{2} b_{\mu, \mu}^{k}
$$

(Eq. 25 and 26)
The only item for which the trick is not directly possible is $a_{2, \mu}^{k}\left(\varepsilon_{\rho}\right)$. So we make a Stratonovitch integration by parts and we get:

$$
\begin{align*}
\int_{0}^{t} a_{2, \mu}^{k}\left(\varepsilon_{\rho}\right) \mathrm{d} s= & \int_{0}^{t} \dot{h}\left(\varepsilon_{\rho}\right)^{\alpha} T_{s r}^{\nu} Z_{\mu}^{r} Z_{\alpha}^{s}\left(Z^{-1}\right)_{\nu}^{k} \mathrm{~d} s \\
= & \left(\int_{0}^{t} h\left(\varepsilon_{\rho}\right)^{\alpha} \mathrm{d} s\right) \times \int_{0}^{t} T_{s r}^{\nu} Z_{\mu}^{r} Z_{\alpha}^{s}\left(Z^{-1}\right)_{\nu}^{k} \circ \mathrm{~d} \tilde{B} \\
& -\int_{0}^{t} h\left(\varepsilon_{\rho}\right)^{\alpha} \circ \mathrm{d}\left(T_{s r}^{\nu} Z_{\mu}^{r} Z_{\alpha}^{s}\left(Z^{-1}\right)_{\nu}^{k}\right) \tag{35}
\end{align*}
$$

As $a_{1, \mu}^{k}, T_{s r}^{\nu}, Z_{\mu}^{r}, Z_{\alpha}^{s}$, and $\left(Z^{-1}\right)_{\nu}^{k}$ are $\mathbb{D}^{\infty}$-semi-martingales, we can make this integration by parts. Then each Stratonovitch integral in (35) is $\alpha$-Hölderian, $\alpha<\frac{1}{2}, \rho$-uniformly, and is multiplied by $\frac{1}{\rho}$, which is due to the presence of $h\left(\varepsilon_{\rho}\right)^{\alpha}$.

The Lebesgue integral in the r.h.s. of (35) is also a Stratonovitch integral multiplied by $\frac{1}{\rho}$ which appears because of $\int_{0}^{t} h\left(\varepsilon_{\rho}\right)^{\alpha}(s) \mathrm{d} s$.

So $\left(D_{\varepsilon_{\rho}} f\right)_{\rho \in \mathbb{N}_{*}}$ is a $\mathbb{D}^{\infty}$-vector field. We also have to prove that the definition of the new grad does not depend on the basis $\left(v_{j}\right)_{j \in \mathbb{N}_{*}}$. For this, we prove first that the map $\tilde{H} \ni v \mapsto D_{v} f \in \mathbb{D}^{\infty}$ is continuous;

$$
\begin{equation*}
D_{v} f=\operatorname{div} A_{v} \operatorname{grad} f+t \mapsto \int_{0}^{t} \dot{h}_{1}(v)(s) \mathrm{d} s \tag{23}
\end{equation*}
$$

From (27), we see that $v \mapsto\left(t \mapsto \int_{0}^{t} \dot{h}_{1}(v)(s) \mathrm{d} s\right)$ is continuous, when seen as a vector field. The map $v \mapsto \operatorname{div} A_{v} \operatorname{grad} f$ is continuous because with (24), (25), (26), we see from the equations defining $b(v)$ and $a(v)$, so $A(v)$, that $A(v)$ is uniformly multiplicator.

Then if $\left(v_{i}\right)_{i \in \mathbb{N}_{*}}$ is a basis of $\tilde{H}$, and which $w \in \tilde{H}$, we have

\left\langle\sum_{i=1}^{L} D_{v_{i}} f \cdot v_{i}, w\right\rangle_{\tilde{H}} & =\sum_{i=1}^{L}\left(D_{v_{i}} f\right)\left\langle v_{i}, w\right\rangle_{\tilde{H}} \\
& =D_{\sum_{i=1}^{L}\left\langle v_{i}, w\right\rangle_{\tilde{H}} v_{i}} f
\end{aligned}
$$

so, when $L \uparrow \infty$, we get

\langle\operatorname{grad} f, w\rangle_{\tilde{H}}=D_{w} f
$$

REmARK 7..1. If $\overrightarrow{\operatorname{grad}} f$ denotes the gradient of a function $f \in C^{\infty}\left(V_{n}\right)$

\overrightarrow{\operatorname{grad}} f=\sum_{i=1}^{n} \frac{\partial f}{\partial x^{i}} \frac{\partial}{\partial x^{i}}
$$

then $F_{f, t}$ being $F_{f, t}(\omega)=f(I(\omega)(t)$, I being the Itô map, we have

$$
\left\langle v, \operatorname{grad} F_{f, t}\right\rangle_{\tilde{H}}(\omega)=\langle v, \overrightarrow{\operatorname{grad}} f\rangle_{V_{n}}(I(\omega)(t))
$$

## 8. Standard Quadratic form on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$

This section is dedicated to the study of the standard quadratic form on the $\mathbb{D}^{\infty}$-stochastic manifold $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$.

We recall the theorem of Dini-Lipshitz:
If $f$ is a real function which is piecewise of class $C^{1}$ on a bounded interval, its Fourier series converges uniformly where $f$ is $C^{1}$, and on the finite number of discontinuity points, $f$ converges towards the half sum of $f$ 's right and left limits.

This theorem is still valid if $f$ is piecewise $\alpha$-Hölderian $(0<\alpha<1)$, and the proof is similar.

We suppose from now on, that the metric $g$ satisfies the Driver condition: $V_{1}$ and $V_{2}$ being $C^{\infty}$ vector fields on $V_{n}, T$ the torsion, $g\left(T\left(V_{1}, V_{2}\right), V_{1}\right)=0$.

## 8. 1 Definition of the New Cameron-Martin space and of the standard bilinear form

We recall some properties of the NCM (new Cameron-Martin) $\left\{e_{\mu} / \mu=1, \ldots, n\right\}$ being the canonical basis of $\mathbb{R}^{n}$, NCM denoted $\tilde{H}$ is: $\tilde{H}=\left\{\sum_{\mu=1}^{n} f^{\mu}(t) u_{\mu}(t, \omega) / u_{\mu}\right.$ being the SPT of $u e_{\mu}$ and $\left.f^{\mu}(t) \in H\right\}$
Scalar product on $\tilde{H}$ :
If $v_{i}=\sum_{\mu=1}^{n} f_{i}^{\mu}(t) u_{\mu}(t, w) \in \tilde{H}, i=1,2$ :

$$
<v_{1}, v_{2}>_{\tilde{H}}=\int_{0}^{1} \dot{f}_{1}^{\mu}(t) \dot{f}_{2}^{\mu}(t) d t
$$

- $\tilde{H}$ is complete.
- A basis of $\tilde{H}$ is:
$\left\{v_{i}=\sum_{\mu=1}^{n} f_{i}^{\mu}(t) u_{\mu}(t, w) /{ }^{t}\left(f_{i}^{1}, \ldots, f_{i}^{n}\right), i \in \mathbb{N}_{*}\right.$ being a basis of $H$, $\left(u_{\mu}(t, w) / \mu=1, \ldots, n\right)$ being the SPT of a basis in $\left.T_{m_{0}} V_{n}\right\}$

Definition 8..1.
i) If $\delta \in \operatorname{Der}(\Omega), f \in \mathbb{D}^{\infty}(\Omega): d f(\delta)=\delta(f)$, then $d f \in \operatorname{Der}^{*}(\Omega)$.
ii) If $\left(v_{i}\right)_{i \in \mathbb{N}_{*}}$ is a basis of $\tilde{H}$, we define $\delta_{f} \in$ Der by:

$$
\delta_{f}(g)=\sum_{i=1}^{\infty} D_{v_{i}} f \cdot D_{v_{i}} g .
$$

$\delta_{f} \in \operatorname{Der}(\Omega)$ because $\delta_{f}(g)=<\operatorname{grad} f, \operatorname{grad} g>_{\tilde{H}}$.
iii) If $\alpha \in \operatorname{Der}^{*}(\Omega): \delta_{\alpha}(f)=\alpha\left(\delta_{f}\right)$, then $\delta_{\alpha} \in \operatorname{Der}(\Omega)$.

REmark 8..1. If the set $\left(f_{k}\right)_{k \in K}$ is bounded in $\mathbb{D}^{\infty}(\Omega)$, the set $\left(\delta_{f_{k}}\right)_{k \in K}$ is bounded in $\operatorname{Der}(\Omega)$.

Definition 8..2. If $\alpha, \beta \in \operatorname{Der}^{*}(\Omega)$, we define the standard bilinear form on Der* by:

$$
q(\alpha, \beta)=\sum_{i=1}^{\infty} \alpha\left(D_{v_{i}}\right) \beta\left(D_{v_{i}}\right)
$$

We have to show that this definition does not depend of the chosen basis, that this series is $\mathbb{D}^{\infty}$-convergent, and that $q$ is $\mathbb{D}^{\infty}$-continuous relatively to each of its argument.

We first prove that the series defining $q(\alpha, \beta)$ is $\mathbb{D}^{\infty}$-convergent.
a) If $\alpha=d f, \beta=d g, f$ and $g \in \mathbb{D}^{\infty}(\Omega)$,

$$
q(\alpha, \beta)=\sum_{i=1}^{\infty} d f\left(D_{v_{i}}\right) \cdot d g\left(D_{v_{i}}\right)=<\operatorname{grad} f, \operatorname{grad} g>_{\tilde{H}}
$$

b) If $\beta=d g$ and $\alpha \in \operatorname{Der}^{*}$

$$
q(\alpha, \beta)=\alpha\left(\sum_{i=1}^{\infty} D_{v_{i}} g \cdot D_{v_{i}}\right)
$$

As $\sum_{i=1}^{\infty} D_{v_{i}} g \cdot D_{v_{i}}=\delta_{g} \in \operatorname{Der}(\Omega)$, and as $\alpha$ is continuous, $q(\alpha, \beta)$ is legitimate. c) Let $\alpha \in$ Der $^{*}$, with theorem 3,2, there exists a bounded net $\left(\alpha_{k}\right)_{k \in K}$ in Der* which converges towards $\alpha$, and:

$$
\alpha_{k}=\sum_{i_{k} \in I_{k}} h_{i_{k}} d g_{i_{k}}, I_{k} \text { finite, } h_{i_{k}} \in \mathbb{D}^{\infty}(\Omega) \text { and } g_{i_{k}} \in \mathbb{D}^{\infty}(\Omega)
$$

Then direct computation shows that:

$$
\delta_{\alpha_{k}}=\sum_{i_{k} \in I_{k}} h_{i_{k}} \sum_{j=1}^{\infty} D_{v_{j}} g_{i_{k}} \cdot D_{v_{j}}
$$

Moreover the set $\left(\delta_{\alpha_{k}}\right)_{k \in K}$ is a bounded set in $\operatorname{Der}(\Omega),\left(v_{j}\right)_{j \in \mathbb{N}_{*}}$ being a base of $\tilde{H}$, then:

$$
q\left(\alpha_{k}, \alpha_{k}\right)=\sum_{j \in \mathbb{N}_{*}}\left|\alpha_{k}\left(D_{v_{j}}\right)\right|^{2}=\alpha_{k}\left(\delta_{\alpha_{k}}\right)
$$

because we have:

$$
\begin{aligned}
q\left(\alpha_{k}, \alpha_{k}\right) & =q\left(\alpha_{k}, \sum_{i_{k} \in I_{k}} h_{i_{k}} d g_{i_{k}}\right)=\sum_{i_{k} \in I_{k}} h_{i_{k}} q\left(\alpha_{k}, d g_{i_{k}}\right) \\
& =\sum_{i_{k} \in I_{k}} h_{i_{k}} \sum_{j=1}^{\infty} \alpha_{k}\left(D_{v_{j}}\right) d g_{i_{k}}\left(D_{v_{j}}\right) \\
& =\sum_{i_{k} \in I_{k}} h_{i_{k}} \sum_{j=1}^{\infty} \alpha_{k}\left(D_{v_{j}}\right) D_{v_{j}}\left(g_{i_{k}}\right) \\
& =\alpha_{k}\left(\delta_{\alpha_{k}}\right)
\end{aligned}
$$

The sets $\left(\alpha_{k}\right)_{k \in K}$ and $\left(\delta_{\alpha_{k}}\right)_{k \in K}$ are bounded in Der* and Der, so the finite sums $\sum_{i=1}^{L}\left|\alpha_{k}\left(D_{v_{i}}\right)\right|^{2}$ are $\mathbb{D}^{\infty}$-bounded uniformly in $L$ and in $k$, so $q(\alpha, \alpha)$ exists and is $\in L^{\infty-0}(\Omega)$. But the set $\left\{\alpha_{k}\left(\delta_{\alpha_{k}}\right) / k \in \mathbb{N}_{*}\right\}$ is $\mathbb{D}^{\infty}$-bounded, then by interpolation, $q(\alpha, \alpha) \in \mathbb{D}^{\infty}$.

The net $q\left(\alpha_{k}, \alpha_{k}\right)-q(\alpha, \alpha)$ is $L^{p^{\prime}}$-convergent for each $p^{\prime}>1$ and is $\mathbb{D}_{r}^{p}$-bounded, $p>1, r \in \mathbb{N}_{*}$. By interpolation this net converges towards 0 in $\mathbb{D}^{\infty}(\Omega)$, so $q(\alpha, \alpha) \in \mathbb{D}^{\infty}(\Omega)$.

Now we want to prove the continuity of $q(\alpha, \beta)$ relatively to each of its arguments. If $\alpha \in \operatorname{Der}^{*}$ and $\beta \in \operatorname{Der}^{*}$, we know that there exists a net $\left(\alpha_{k}\right)_{k \in K}$ as in theorem 3,2 such that: $\alpha_{k} \xrightarrow{\text { Der* }^{*}} \alpha$, then we have seen that

$$
\begin{equation*}
\lim _{k} q\left(\alpha_{k}, \beta\right)=q(\alpha, \beta)=\lim _{k} \alpha_{k}\left(\delta_{\beta}\right)=\beta\left(\delta_{\alpha}\right) \tag{1}
\end{equation*}
$$

Then the continuity of $q$ relatively to each of its arguments is trivial.
The independence of the the definition of $q$ relatively to the chosen basis is given by:

$$
q(\alpha, \beta)=\beta\left(\delta_{\alpha}\right) \quad(\text { definition } 8 . .1) \text { and (1) }
$$

Remark 8..2. $\theta$ being the bijection between $\operatorname{Der}^{*}(\Omega)$ and $D_{0}(\Omega)$, obtained through the standard bilinear form, we have: $\forall \alpha \in \operatorname{Der}^{*}(\Omega),\left(v_{i}\right)_{i \in \mathbb{N}_{*}}$ being an Hilbertian basis of $\tilde{H}$ :

\theta(\alpha)=\sum_{i=1}^{\infty} \alpha\left(v_{i}\right) v_{i}
$$

## 8. 2 Non degenerescence of the standard quadratic form

We will now prove that the standard bilinear form is non degenerate. It is enough to prove that if $\alpha \in \operatorname{Der}^{*} \backslash\{0\}$, there exists $v \in \tilde{H}$ such that $\alpha\left(D_{v}\right) \neq 0$, $D_{v}$ being the derivation associated to $v$ as (7.23).

We first, will prove that the "derivation adherence" of a particular $\mathbb{D}^{\infty}$-module $\mathfrak{D}$, contains all $\mathbb{D}^{\infty}$-vector fields. The derivative adherence means that it includes all limits of bounded nets of $\mathfrak{D}$, which converges as derivations:

$$
\left(\delta_{i}\right)_{i \in I} \rightarrow \delta \Leftrightarrow \forall f \in \mathbb{D}^{\infty}(\Omega), \quad \delta_{i} f \xrightarrow{\mathbb{D} \infty} \delta f .
$$

We consider the following operator: $B$ is a constant antisymmetrical $n \times n$ matrix, if $h \in H$, we denote $(\hat{A} h)(t)=\int_{0}^{t} B \dot{h}(s) d s$. $\hat{A}$ is a bounded operator on $H$. As basis of $\tilde{H}$, we take (7.33) and denote the generic item of this basis $\check{B}$ by $\varepsilon_{j}$.

We recall that to $v \in \tilde{H}$, we can associate a derivation

\end{equation*}
$$

Now, as basis of $\tilde{H}$, we take $\check{B}(7.33)$. $P_{N}$ being the projection on the subspace of $H$ generated by the: $h\left(\varepsilon_{l, j}\right), h\left(\varepsilon_{l, j}^{\prime}\right)$ and $h\left(\varepsilon_{j}^{\prime \prime}\right)$ with $l=1, \ldots, N$ and $j=1, \ldots, n$, denote $\hat{A}_{N}=P_{N} \hat{A} P_{N}$.

We recall that if $v(t, \omega)=\sum_{\mu=1}^{n} f^{\mu}(t) u_{\mu}(t, \omega)$ with $u_{\mu}(t, \omega)$ being the SPT of $u e_{\mu}$ and $\left(f^{\mu}\right)_{\mu=1, \ldots, n} \in H$, then $v \in \tilde{H}$ and $h(v)^{\mu}=f^{\mu}(t)$.

Taking in account the special form of the basis vectors of $\check{B}$, we deduce $\left[\hat{A}, P_{N}\right]=0$. We denote by $h\left(\varepsilon_{i}\right)$ the generic item obtained from $\varepsilon_{i} \in \check{B}$, with the bijection $\tilde{H} \rightarrow H$ :

\tilde{H} \ni v=h(t) u(t, \omega) \rightarrow h(v)(t)=h(t) \in H
$$

We now will study the limit, as a derivation, of:

\sum_{i, j \leqslant N} a_{i j}\left\{W\left(h\left(\varepsilon_{i}\right)\right) D_{\varepsilon_{j}}-W\left(h\left(\varepsilon_{j}\right)\right) D_{\varepsilon_{i}}\right\} \tag{2}
\end{equation*}

where $a_{i j}=<h\left(\varepsilon_{i}\right), \hat{A} h\left(\varepsilon_{j}\right)>_{H}$.
With (7.23) and (7.27), and denoting $Z\left(\varepsilon_{i}\right)=\frac{1}{2} \sum_{\mu=1}^{n} b_{\mu \mu}\left(\varepsilon_{i}\right)$, we get from (2):

(2) & =\sum_{i, j \leqslant N} a_{i j}\left\{W\left(h\left(\varepsilon_{i}\right)\right) h\left(\varepsilon_{j}\right)-W\left(h\left(\varepsilon_{j}\right)\right) h\left(\varepsilon_{i}\right)\right\}  \tag{T1}\\
& +\sum_{i, j \leqslant N} a_{i j}\left\{W\left(h\left(\varepsilon_{i}\right)\right) \int_{0}^{t} Z\left(\varepsilon_{j}\right) d s-W\left(h\left(\varepsilon_{j}\right)\right) \int_{0}^{t} Z\left(\varepsilon_{i}\right) d s\right\}  \tag{T2}\\
& -\sum_{i, j \leqslant N} a_{i j}\left\{<h\left(\varepsilon_{i}\right), A\left(\varepsilon_{j}\right) \operatorname{grad}(\cdot)>_{H}-<h\left(\varepsilon_{j}\right), A\left(\varepsilon_{i}\right) \operatorname{grad}(\cdot)>_{H}\right\}  \tag{T3}\\
& +\sum_{i, j \leqslant N} a_{i j}\left\{\operatorname{div}\left(W\left(h\left(\varepsilon_{i}\right)\right) A\left(\varepsilon_{j}\right)-W\left(h\left(\varepsilon_{j}\right)\right) A\left(\varepsilon_{i}\right)\right)\right\} \operatorname{grad}(\cdot) \tag{T4}
\end{align*}
$$

We want to prove that each of the $T i, i=1,2,3,4$, converges when $N \rightarrow \infty$, as derivations, towards a $\mathbb{D}^{\infty}$-continuous derivation.

For (T1):

(T 1)=2 \operatorname{div} \hat{A}_{N} \operatorname{grad}(\cdot)
$$

As bounded operators, we have: $\hat{A}_{N} \rightarrow \hat{A}$, so:

div being a $\mathbb{D}^{\infty}$-continuous operator, $\forall f \in \mathbb{D}^{\infty}(\Omega)$ :

\lim _{N \rightarrow \infty} \operatorname{div} \hat{A}_{N} \operatorname{grad} f=\operatorname{div} \hat{A} \operatorname{grad} f \quad\left(\operatorname{in} \mathbb{D}^{\infty}(\Omega)\right)
$$

For (T2):
We can rewrite (T2) as the vector field:

t \rightarrow 2 \int_{0}^{t} Z\left[W\left(\sum_{j=1}^{N} \hat{A}_{N} h\left(\varepsilon_{j}\right)\right) \cdot \varepsilon_{j}\right] d s

Now $\varepsilon_{j}(s, \omega)=\sum_{\alpha=1}^{n} h^{\alpha}\left(\varepsilon_{j}\right)(s) u_{\alpha}(s, \omega)$, where as usual: $u_{\alpha}(s, \omega)=\operatorname{SPT}$ of $u e_{\alpha}$, at time $s$ "along $\omega^{\prime \prime},\left(e_{\alpha}\right)_{\alpha=1, \ldots, n}$ canonical unit vectors of $\mathbb{R}^{n}$.

We denote by $\left(k_{s}^{\alpha}\right)_{\alpha=1, \ldots, n}$ this element of $H: \rho \in[0,1]$

\end{equation*}

Then (T2) becomes, with Einstein summation convention:

& =2 \int_{0}^{t} Z\left[W\left(\hat{A}\left(\sum_{j=1}^{N}<k_{s}^{\alpha}, h\left(\varepsilon_{j}\right)>_{H} h\left(\varepsilon_{j}\right)\right)\right) u_{\alpha}(s, \omega)\right] d s
\end{aligned}
$$

But $Z$ is $\mathbb{R}$-linear, so:

\text { (T2) }=2 \int_{0}^{t} W\left(\hat{A}\left(\sum_{j=1}^{N}<k_{s}^{\alpha}, h\left(\varepsilon_{j}\right)>_{H} h\left(\varepsilon_{j}\right)\right)\right) Z\left(u_{\alpha}(s, \omega)\right) d s
$$

With corollary 6.1, we know that $\sup _{\alpha \in\{1, \ldots, n\}} Z\left(u_{\alpha}(s, \omega)\right)$ is $\mathbb{D}^{\infty}$-bounded. Now

& =\left\|\hat{A}\left(\sum_{j=1}^{N}<k_{s}^{\alpha}, h\left(\varepsilon_{j}\right)>_{H} h\left(\varepsilon_{j}\right)\right)\right\|_{H} \leqslant\|\hat{A}\| \cdot\left\|k_{s}^{\alpha}\right\|_{H} \tag{4}
\end{align*}
$$

and $\left\|k_{s}^{\alpha}\right\|_{H}^{2}=\int_{0}^{1} \mathbb{1}_{[0, s]}(u) d u$.
As on $\mathcal{C}_{1}$ all $\mathbb{D}_{r}^{p}$-norms are equivalent, the l.h.s. of (4) is $\mathbb{D}^{\infty}$-bounded, uniformly relatively to $s$ and $N$. So (T2) converges, as multiplicators, towards: $2 \int_{0}^{t} W\left[\hat{A} k_{s}^{\alpha}\right] Z\left(u_{\alpha}\right) d s$.

For (T3): (T3) can be rewritten as:

To prove that this sequence of derivations is $\mathbb{D}^{\infty}$-converging towards a $\mathbb{D}^{\infty}$-continuous derivation, the convergence being a derivation convergence, it is enough to prove that: $2 \sum_{1 \leqslant i, j \leqslant N} a_{i j} A\left(\varepsilon_{j}\right) h\left(\varepsilon_{i}\right)$ converges, as vector fields, towards a $\mathbb{D}^{\infty}$-vector field.

With (7.24) we can write, with shorter notations:

where $\gamma_{1, \alpha}(s)$ and $Z_{1, \alpha}(s)$ are:

$$

and

\left(Z_{1, \alpha}(s)\right)_{\mu, \rho}^{\nu}=g\left(R\left(u_{\alpha}, u_{\rho}, u_{\mu}\right), u_{\nu}\right)+g\left(\left(\nabla_{u_{\rho}} T\right)\left(u_{\alpha}, u_{\mu}\right), u_{\nu}\right)
$$

$Z_{1}$ and $\gamma_{1}$ are $\mathbb{D}^{\infty}$-semi-martingales, $\frac{1}{2}-\mathbb{D}^{\infty}$-Holderian processes and $\mathbb{R}$-multilinear for the variables $u_{\alpha}, u_{\rho}, u_{\mu}, u_{\nu}$.

We use the Stratonovich integration by parts on

\int_{0}^{t} h_{\alpha}\left(\varepsilon_{j}\right) \times Z_{1}\left(u_{\alpha}, u_{\rho}, u_{\mu}, u_{\nu}\right) \circ d \tilde{B}^{\rho}
$$

and we get:

\end{equation*}
$$

where again $\gamma_{2, \alpha}$ and $Z_{2, \alpha}$ are $\mathbb{D}^{\infty}$-semi-martingales, $\frac{1}{2}-\mathbb{D}^{\infty}$-Holderian processes and $\mathbb{R}$-multilinear for their variables $u_{\alpha}, u_{\rho}, u_{\mu}, u_{\nu}$,

Z_{2, \alpha}=\int_{0}^{t} Z_{1}\left(u_{\alpha}, u_{\rho}, u_{\mu}, u_{l}\right) \circ d \tilde{B}^{l}
$$

and

\gamma_{2, \alpha}=\gamma_{1, \alpha}-\int_{0}^{s} Z_{1}\left(u_{\alpha}, u_{\rho}, u_{\mu}, u_{l}\right) \circ d \tilde{B}^{\rho}
$$

So $\gamma_{2, \alpha}(s)$ can be written $\gamma_{2}\left(u_{\alpha}, u_{\mu}, u_{l}\right)$.
Then $A\left(\varepsilon_{j}\right)$ acting on the vector $h\left(\varepsilon_{i}\right)$ is given by:

\end{align*}

We define a vector field $w_{s}\left(u_{\mu}, u_{l}\right)$ by:

& +\int_{0}^{t}<w_{s}, \sum_{i, j \leqslant N} a_{i j} h\left(\varepsilon_{j}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s
\end{aligned}
$$

Using: $\sum_{i, j \leqslant N} a_{i j} h\left(\varepsilon_{j}\right)=-\hat{A}_{N} h\left(\varepsilon_{i}\right)$ and (3): $<k_{s}^{\alpha}, h\left(\varepsilon_{j}\right)>_{H}=h^{\alpha}\left(\varepsilon_{j}\right)$, we get:

\sum_{i, j \leqslant N} a_{i j}\left(A\left(\varepsilon_{j}\right) \cdot h\left(\varepsilon_{i}\right)\right)(t) & =-\int_{0}^{t} Z_{2, \alpha}(s) \sum_{i \leqslant N}<k_{s}^{\alpha}, \hat{A}_{N}\left(h\left(\varepsilon_{i}\right)\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s \\
& -\int_{0}^{t} \sum_{i \leqslant N}<w_{s}, \hat{A}_{N}\left(h\left(\varepsilon_{i}\right)\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s \\
& =\int_{0}^{t} \sum_{i \leqslant N} Z_{2, \alpha}(s)<\hat{A}_{N} k_{s}^{\alpha}, h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s \\
& +\int_{0}^{t} \sum_{i \leqslant N}<\hat{A}_{N}\left(w_{s}\right), h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s \\
& =\int_{0}^{t} Z_{2, \alpha}(s) \sum_{i \leqslant N}<\hat{A}_{N} k_{s}^{\alpha}, h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s \\
& +\int_{0}^{t} \sum_{i \leqslant N}<\hat{A} w_{s}, h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right) d s
\end{align*}
$$

In the first integral of $\left(7^{\prime}\right)$, the series, $\sum_{i \leqslant N}<\hat{A} k_{s}^{\alpha}, h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right)(r)$ is independent of $\omega$, and depends only of $s$. The theorem of Dini-Lipschitz (Theorem 2.11) applied to this series shows that it converges uniformly on each compact of $[0,1]$ which does not include discontinuity points, relatively to $r$, and on the discontinuity points, the series converges towards the half sum of the left and right limits. Here the only discontinuity point is $s=r$, so on this point the series converges towards

$$
\frac{1}{2}\left(\dot{\hat{A}} k_{s-}^{\alpha}+\dot{\hat{\hat{A}}} k_{s+}^{\alpha}\right)=\frac{1}{2} B e_{\alpha}
$$

As $s \in[0,1]$, we see that the integrand in the first integral in $\left(7^{\prime}\right)$ is $\mathbb{D}^{\infty}$-bounded, uniformly in $s\left(Z_{2, \alpha}\right.$ is $1 / 2-\mathbb{D}^{\infty}$-Holderian). So the first integral in ( $7^{\prime}$ ), converges $\mathbb{D}^{\infty}$ towards $\sum_{\alpha=1}^{n} \int_{0}^{t} Z_{2, \alpha}(s) B e_{\alpha} d s$; if we apply the O.U. operator to this first integral, we get:

\sum_{\alpha=1}^{n} \int_{0}^{t}\left((1-L)^{r / 2} Z_{2, \alpha}\right) \sum_{i \leqslant N}<\hat{A} k_{s}^{\alpha}, h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right)(s) d s
$$

The same reasoning shows that this new sequence will $\mathbb{D}^{\infty}$-converge towards $\sum_{\alpha=1}^{n} \int_{0}^{t}\left((1-L)^{r / 2} Z_{2, \alpha}\right) B e_{\alpha} d s$. So the first integral of $\left(7^{\prime}\right) \mathbb{D}^{\infty}$-converges as vectors fields towards $\sum_{\alpha=1}^{n} \int_{0}^{t} Z_{2, \alpha} B e_{\alpha} d s$.

For the second integral in $\left(7^{\prime}\right)$, the same reasoning on the series

$$
\sum_{i \leqslant N}<\hat{A} w_{s}, h\left(\varepsilon_{i}\right)>_{H} \dot{h}\left(\varepsilon_{i}\right)(r)
$$

but considering the Dini-Lipschitz convergence in the Frechet space $\mathbb{D}^{\infty}(\Omega)$, shows that this series converges on the unique discontinuity point $(r=s)$, and that this $\mathbb{D}^{\infty}$-convergence towards the half value of the jump in $r=s$, is uniformly, in $s$, bounded.

Then the second integral of $\left(7^{\prime}\right)$ will $\mathbb{D}^{\infty}(\Omega, H)$-converges towards the vectors field:

t \rightarrow \sum_{\alpha=1}^{n} \int_{0}^{t} \frac{1}{2} B \gamma_{2, \alpha} e_{\alpha} d s
$$

Now, for (T4), we will need the following lemma.
Lemma 8..1. The vector field $s \rightarrow w_{s}$ is $\frac{1}{2}-\mathbb{D}^{\infty}$-Holderian.
Proof. Recall (6'):

& \leqslant \int_{t}^{t+\varepsilon} d s \int \mathbb{P}(d \omega)\left|\frac{1}{\sqrt{\varepsilon}}(1-L)^{r / 2} \gamma_{2}\right|^{p}
\end{aligned}
$$

Last, we study (T4):

We want to prove that when $N \rightarrow \infty$, (T4) converges, as a sequence of derivation, towards a $\mathbb{D}^{\infty}$-continuous derivation, div $Q$ grad, when $Q$ is a $\mathbb{D}^{\infty}$-multiplicator. For this, it is enough to prove that the sequence:

As $W\left[\hat{A}\left(\sum_{j \leqslant N} h^{\alpha}\left(\varepsilon_{j}\right)(s) h\left(\varepsilon_{j}\right)\right)\right] \in \mathcal{C}^{1}$, and converges towards $W\left(\hat{A} k_{s}^{\alpha}\right)$ uniformly relatively to $s$, the same is true for $\mathbb{E}\left[W\left(\hat{A}\left(\sum_{j \leqslant N} h^{\alpha}\left(\varepsilon_{j}\right)(s) h\left(\varepsilon_{j}\right)\right)\right) \mid \mathcal{F}_{s}\right]$ and so the sequence $\mathbb{E}\left[W\left(\hat{A}\left(\sum_{j \leqslant N} h^{\alpha}\left(\varepsilon_{j}\right)(s) h\left(\varepsilon_{j}\right)\right)\right) \mid \mathcal{F}_{s}\right]$ converges towards $\mathbb{E}\left[W\left(\hat{A} k_{s}^{\alpha}\right) \mid \mathcal{F}_{s}\right]$ as multiplicators. Instead of the Fourier basis $\check{B}(7.33)$ on $[0,1]$, we could have chosen the same type of Fourier basis but on $\left[t_{0}, 1\right]\left(0<t_{0}<1\right)$. Then if the matrix $B$ is multiplied by a function $f(w) \in \mathcal{F}_{t_{0}}$, as all coefficients in (T1),(T2),(T3),(T4)
are adapted, the similar limits obtained in the case of this Fourier basis on $\left[t_{0}, 1\right]$ and with $f B \cdot \mathbb{1}_{\left[t_{0}, t\right]}$ will have the same form.

Now we make the same transfer in (22'), using (7.24), (7.25) and (7.26) to eliminate $A$ in (22'), $A$ being linearly dependent of $v$, so of $h(v)$ with the
canonical isometry. This last equation is denoted ( $22^{\prime \prime}$ ). So finally we get three equations, $\left(21^{\prime}\right),\left(22^{\prime \prime}\right)$ and (26) with three unknown variables $h(v), B$, $X$. These three equations make a system of three linear equations, linear in the variables $h(v), B, X$, as direct inspection of these equations shows.

In these three equations $\left(21^{\prime}\right),\left(22^{\prime \prime}\right)$ and (26), there are two coefficients which are not $L_{\infty}(\Omega \times[0,1])$ bounded: $\gamma_{2, \alpha}$ and $Z_{2, \alpha}$, because they are formed with $\int_{0}^{t} Z_{1, \alpha} \circ d \tilde{B}$ (see ( $5^{\prime}$ ) and ( $\left.5^{\prime \prime}\right)$ ).

To be able to use the classical theorem on solutions of a system of linear SDE, we will truncate this system with a sequence of stopping times, so we need the following lemma:

Lemma $8 . .2 . \forall \lambda \in \mathbb{R}, \mathbb{E}\left[e^{\lambda \sup _{t \in[0,1]}\left|Z_{2}(t)\right|}\right]<+\infty$.
Proof. We denote: $\tilde{Z}_{2, \alpha}(t)=\int_{0}^{t} Z_{1, \alpha} \cdot d \tilde{B}$ and $Z_{1, \alpha} \in L^{\infty}(\Omega \times[0,1])$. With the Ito formula:

So $e^{\lambda \tilde{Z}_{2, \alpha}(t)-\frac{1}{2} \lambda^{2} \int_{0}^{t} Z_{1, \alpha}(s)^{2} d s}$ is a local martingale. Let $\left(\tau_{k}\right)_{k \in N^{*}}$ a sequence of stopping times converging towards $+\infty$, then:

e^{\lambda \tilde{Z}_{2, \alpha}\left(t \wedge \tau_{k}\right)-\frac{1}{2} \lambda^{2} \int_{0}^{t \wedge \tau_{k}} Z_{1, \alpha}^{2} d s}=\lambda \int_{0}^{t \wedge \tau_{k}} e^{\lambda \tilde{Z}_{2, \alpha}-\frac{\lambda^{2}}{2} \int_{0}^{s} Z_{1, \alpha}^{2} d s} \cdot Z_{1} d \tilde{B}+1
$$

And

\mathbb{E}\left[e^{\lambda \tilde{Z}_{2, \alpha}\left(t \wedge \tau_{k}\right)-\frac{\lambda^{2}}{2} \int_{0}^{t \wedge \tau_{k}} Z_{1}^{2} d s}\right]=1
$$

So $\mathbb{E}\left[e^{\lambda \tilde{Z}_{2, \alpha}\left(t \wedge \tau_{k}\right)}\right] \leqslant C_{0}(\lambda), C_{0}$ constant is dependent of $k$. Then, with the Fatou Lemma: $\mathbb{E}\left[e^{\lambda \tilde{Z}_{2, \alpha}(t)}\right] \leqslant C_{0}(\lambda)$. But: $\forall p>1, \mathbb{E}\left[e^{p \lambda \tilde{Z}_{2, \alpha}(t)}\right] \leqslant C_{0}(p)$. So the local martingale is a martingale. Moreover,

$$
\sup _{t} e^{\lambda \tilde{Z}_{2, \alpha}(t)}+\sup _{t} e^{-\lambda \tilde{Z}_{2, \alpha}(t)} \geqslant e^{\sup _{t} \lambda\left|\tilde{Z}_{2, \alpha}(t)\right|}
$$

So as $\int_{0}^{t}\left[d Z_{1}, d \tilde{B}\right]$ is $L_{\infty}(\Omega \times[0,1])$, we have $\mathbb{E}\left[e^{\lambda \sup _{t \in[0,1]}\left|Z_{2, \alpha}(t)\right|}\right]<+\infty$.
Now we denote by $\tau_{k}: \tau_{k}=\inf _{t}\left|Z_{2, \alpha}(t)\right| \geqslant k$, so $\left|Z_{2, \alpha}\left(t \wedge \tau_{k}\right)\right| \leqslant k$. Then the solution $S_{k}$ of the localized SDE is unique and verifies:
$\left\|S_{k}\left(t \wedge \tau_{k}\right)\right\|_{L^{p}} \leqslant C(p) e^{\beta k t}, \beta$ constant. So $\left\|S(t) \mathbb{1}_{\left[\tau_{k}, \tau_{k+1}\right]}\right\|_{L^{p}} \leqslant C(p) e^{\beta k t}$. As in $\left[\tau_{k}, \tau_{k+1}\right], \sup _{t} Z_{2, \alpha}(t)$ is $\in[k, k+1]$, we have $\mathbb{E}\left[\mathbb{1}_{\left[\tau_{k}, \tau_{k+1}\right]} e^{\lambda \sup _{t}\left|Z_{2, \alpha}(t)\right|}\right]<C_{1}(\lambda)$ and $\mathbb{E}\left[\mathbb{1}_{\left[\tau_{k}, \tau_{k+1}\right]}\right]<C_{1}(\lambda) e^{-\lambda k}$.

Then if $1<p^{\prime}<p$, with Holder:

$$
\left\|S(t) \mathbb{1}_{\left[\tau_{k}, \tau_{k+1}\right]} \mathbb{1}_{\left[\tau_{k}, \tau_{k+1}\right]}\right\|_{L^{p^{\prime}}}=\left\|S(t) \mathbb{1}_{\left[\tau_{k}, \tau_{k+1}\right]}\right\|_{L^{p^{\prime}}} \leqslant\left(C_{2} e^{k \beta}\right)^{r_{1}}\left(C_{1}(\lambda) e^{-k \lambda}\right)^{r_{2}}
$$

with $r_{1}, r_{2}>1$.

We can choose $\lambda$ so that the r.h.s. of the last equation is like $e^{-k} \times C_{3}(\lambda)$. Then the series defining $S(t)$ is $L^{p^{\prime}}(\Omega), \forall p^{\prime}$, so $S(t) \in L^{\infty-0}$, uniformly in $t$.

We can repeat this process for the gradient of $S$ and then $S(t) \in \mathbb{D}^{\infty}(\Omega)$, uniformly relatively to $t$, and so is $\frac{1}{2}-\mathbb{D}^{\infty}$-Holderian, so is a multiplicator.

Now let suppose that if $q$ is the quadratic form and that there exists $\alpha \in$ Der $^{*}$ such that $q(\alpha, \alpha)=0$. Then $\forall j \in \mathbb{N}_{*}$, if $\left(v_{j}\right)_{j \in \mathbb{N}_{*}}$ is an Hilbertian basis of $\tilde{H}: \alpha\left(D_{V_{j}}\right)=0$. Now $\mathcal{D}$ being the set of the combinations of $D_{V_{j}}$ which was used to obtain the $\operatorname{limits:~} \lim _{N} T_{1}, \lim _{N} T_{2}, \lim _{N} T_{3}, \lim _{N} T_{4}$, we have $\alpha\left(\lim _{N} T_{1}\right)=\alpha\left(\lim _{N} T_{2}\right)=\alpha\left(\lim _{N} T_{3}\right)=\alpha\left(\lim _{N} T_{4}\right)=0$. So when $B$ is built with step functions like Theorem 4.7, if we denote by $\delta_{B}$ the derivation associated to $B$, we have $\alpha\left(\delta_{B}\right)=0$. As $\alpha\left(D_{v}\right)=0$, we get from the system of linear SDE, $\alpha(u)=0, u$ being read as the derivation associated to the vector field $u \in C^{2}\left([0,1], \mathbf{R}^{n}\right) \cap H$.

Then with Theorem 2.7, we get $\alpha(\operatorname{Der})=0$, so $q$ is non-degenerate.

## 9. Some Tools on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$

Now we are going to study some properties of some mathematical tools on a $\mathbb{P}_{m_{0}}\left(V_{n}\right)$-stochastic manifold, and draw an incomplete list of opened questions.

## 9. 1 Some"renormalisation" theorem

Theorem 9..1. Let $T \in\left(\bigotimes^{p} \operatorname{Der}\right)^{*}$, If $\left(\varepsilon_{i}\right)_{i \in \mathbb{N}_{*}}$ is a basis of $H$, then

$$
\sum_{\varepsilon_{i_{1}}, \ldots, \varepsilon_{i_{p}}} T\left(\varepsilon_{i_{1}}, \ldots, \varepsilon_{i_{p}}\right)^{2} \in \mathbb{D}^{\infty}
$$

the sum being on all p-uples that can be extracted from the basis $\left(\varepsilon_{i}\right)_{i \in \mathbb{N}_{*}}$.
To prove this theorem, we need two lemmas.
Lemma 9..1. A continuous $\mathbb{R}$-bilinear form on $\operatorname{Der}(\Omega), \mathbb{R}$-valued, which is continuous for each of its arguments, is bounded on each part of $\operatorname{Der}(\Omega)$.

Proof. Denote by $B\left(p, r, p^{\prime}, r^{\prime}\right)$ the set of all $\mathbb{R}$-linear continuous maps of $\mathbb{D}_{r}^{p}(\Omega)$ in $\mathbb{D}_{r^{\prime}}^{p^{\prime}}(\Omega)$ and let $B\left(p_{n}, r_{n}, p_{n}^{\prime}, r_{n}^{\prime}\right), n \in \mathbb{N}_{*}$ a sequence of such sets: the projective limit of this sequence is denoted $B\left(s, s^{\prime}\right)$ with $s=\left(p_{n}, r_{n}\right)_{n \in \mathbb{N}_{*}}$, $s^{\prime}=\left(p_{n}^{\prime}, r_{n}^{\prime}\right)_{n \in \mathbb{N}_{*}} ; B\left(s, s^{\prime}\right)$ is a Fréchet space.

We denote by ${\underset{\longrightarrow}{\lim }}_{s, s^{\prime}} B\left(s, s^{\prime}\right)$ the inductive limit of the $B\left(s, s^{\prime}\right)$; we have $\underline{\longrightarrow}_{\left(s, s^{\prime}\right)} B\left(s, s^{\prime}\right)=$ Der and if $D$ is a bounded part of Der, $\exists B\left(s_{0}, s_{0}^{\prime}\right)$ with $D \subset B\left(s_{0}, s_{0}^{\prime}\right)$ and $D$ is a bounded subset of $B\left(s_{0}, s_{0}^{\prime}\right)$ relatively to the Fréchet structure of $B\left(s_{0}, s_{0}^{\prime}\right)$.

Let $D$ be a bounded part of Der, and $q$ an $\mathbb{R}$-bilinear form on Der, and $v \in D$ fixed. We want to show that there exists $C_{0}(v)$ constant such that $\forall u \in \operatorname{Der}, \quad|q(u, v)| \leq C_{0}(v)$.

Suppose that $\exists\left(u_{n}\right)_{n \in \mathbb{N}_{*}} \in D$ such that $\left|q\left(u_{n}, v\right)\right| \rightarrow \infty$. Then there exist $\left(\alpha_{n}\right)_{n \in \mathbb{N}_{*}}, \alpha_{n} \in \mathbb{R}, \alpha_{n}>0$, such that $\alpha_{n} \rightarrow 0$ and $\alpha_{n} q\left(u_{n}, v\right) \nrightarrow 0$. But $\alpha_{n} u_{n} \rightarrow 0$ in $D$ ( $D$ bounded), so $q$ being continuous, $\lim _{n \rightarrow \infty} q\left(\alpha_{n} u_{n}, v\right)=0$.

As $D \subset \operatorname{Der} \cap B\left(s_{0}, s_{0}^{\prime}\right)$ and as the topology on $D$ is the restriction of the Fréchet topology on $B\left(s_{0}, s_{0}^{\prime}\right)$ we can apply the Banach-Steinhaus theorem:
$\exists$ a constant $C$, such that $\forall u \in D, \forall v \in D, \quad|q(u, v)| \leq C$

Lemma 9..2. Let $q$ be an $\mathbb{R}$-bilinear form on $\operatorname{Der}(\Omega)$, positive, bounded on each bounded part of Der and symmetric: that is $\forall f \in \mathbb{D}^{\infty}, \forall u, \forall v \in$ Der, $q(f u, v)=q(u, f v) ;\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$ being an OTHN basis of $H$, then

$$
\sum_{i=1}^{\infty} q\left(e_{i}, e_{i}\right)<+\infty
$$

Proof. Let $\varepsilon(j)= \pm 1, j \in\{1, \ldots, n\}$. Denote

$$
D_{\varepsilon}=\sum_{j=1}^{n} \varepsilon(j)\left(W\left(h_{j}\right) k_{j}-W\left(k_{j}\right) h_{j}\right)
$$

$\left(h_{j}\right)_{j \in \mathbb{N}_{*}},\left(k_{j}\right)_{j \in \mathbb{N}_{*}}$ being two OTHN bases of H, we have $D_{\varepsilon}=\operatorname{div} A_{n}$ grad where

$$
A_{n}=\left(\begin{array}{cccc}
\varepsilon(1)\left(\begin{array}{cc}
0 & -1 \\
1 & 0
\end{array}\right) & & & \\
& \varepsilon(2)\left(\begin{array}{cc}
0 & -1 \\
1 & 0
\end{array}\right) & & \\
& & & \ddots
\end{array}\right]
$$

So on a bounded part of $\mathbb{D}^{\infty}, D_{\varepsilon}$ is bounded, $\varepsilon$-uniformly.
Then $\frac{1}{2^{n}} \sum_{\varepsilon} q\left(D_{\varepsilon}, D_{\varepsilon}\right)$ is also $n$-uniformly bounded on the subset of Der constitued by the $D_{\varepsilon}$.

This bound does not depend on the chosen basis of H because if we change this basis, the new basis is obtained from the initial basis by a unitary transformation.

Then we have:

& -\frac{1}{2^{n}} 2 \sum_{\varepsilon} \sum_{j=1}^{n} \sum_{\ell=1}^{n} \varepsilon(j) \varepsilon(\ell) q\left(W\left(h_{j}\right) k_{j}, W\left(k_{\ell}\right) h_{\ell}\right)
\end{aligned}
$$

\begin{align*}
& +\frac{1}{2^{n}} \sum_{\varepsilon} \sum_{j=1}^{n} \sum_{\ell=1}^{n} \varepsilon(j) \varepsilon(\ell) q\left(W\left(k_{j}\right) h_{j}, W\left(k_{\ell}\right) h_{\ell}\right) \\
= & \sum_{j=1}^{n} q\left(W\left(h_{j}\right) k_{j}, W\left(h_{j}\right) k_{j}\right)-2 \sum_{j=1}^{n} q\left(W\left(h_{j}\right) k_{j}, W\left(k_{j}\right) h_{j}\right) \\
& +\sum_{j=1}^{n} q\left(W\left(k_{j}\right) h_{j}, W\left(k_{j}\right) h_{j}\right) \tag{1}
\end{align*}

So the r.h.s. member of (1) is $n$-uniformly bounded by a constant $C_{0}$. We fix n , and choose for $k$ : $k_{\ell}=h_{n+\ell-1+j}$ and rewrite the r.h.s. of (1) with these new values, and average it on $\ell=1, \ldots, r$

$\sum_{j=1}^{n}\left\|a_{r, j}\right\|_{L^{2}(\Omega)} q\left[\frac{1}{\left\|a_{r, j}\right\|_{L^{2}(\Omega)}} \times\left(\frac{1}{r} \sum_{\ell=1}^{r} W\left(h_{n+\ell-1+j}\right)^{2}-1\right) h_{j}, h_{j}\right]+\sum_{j=1}^{n} q\left(h_{j}, h_{j}\right)$
$\frac{1}{\left\|a_{r, j}\right\|_{L^{2}(\Omega)}} \times \frac{1}{r}\left(\sum_{\ell=1}^{r} W\left(h_{n+\ell-1+j}\right)^{2}-1\right) h_{j}$ is a set of derivations $\left(r \in \mathbb{N}_{*}\right)$ which is bounded in Der ( $n$ being previously fixed); so

$$
q\left[\frac{1}{\left\|a_{r, j}\right\|_{L^{2}(\Omega)}} \times\left(\frac{1}{r} \sum_{\ell=1}^{n} W\left(h_{n+\ell-1+j}\right)^{2}-1\right) h_{j}, h_{j}\right]
$$

is bounded and as $\left\|a_{r, j}\right\|_{L^{2}(\Omega)} \rightarrow 0$ for each $j=1, \ldots, n$, (4) is reduced to $\sum_{j=1}^{n} q\left(h_{j}, h_{j}\right)$.

In (2), the only item left to compute is

The $L^{2}(\Omega, H)$-norm of $\frac{1}{r} \sum_{\ell=1}^{r} W\left(h_{n+\ell-1+j}\right) h_{n+\ell-1+j}$ converges towards 0 , so we can apply the same method as above and

So at the end we have $\sum_{j=1}^{n} q\left(h_{j}, h_{j}\right)<C_{1}, C_{1}$ constant, which implies $\sum_{j=1}^{\infty} q\left(h_{j}, h_{j}\right)<+\infty$

Proof of the theorem. $T$ is a $p$-linear form, $\mathbb{D}^{\infty}$-linear, continous for each of its arguments. We proceed with an induction: suppose the property is true for $T \in\left(\otimes^{p-1} \operatorname{Der}\right)^{*}$. Fix $u_{i_{1}}, \ldots, u_{i_{p-1}}$ vectors of a basis of $H$ and $u$ another vector of this basis; and $\psi \in L^{1+0}=\left(L^{\infty-0}\right)^{*}, \psi \geq 0$. Then

\sum_{\left(u_{i_{1}}, \ldots, u_{i_{p-1}}\right)} \int \mathbb{P}(\mathrm{d} \omega) \psi\left[(1-L)^{\frac{r}{2}} T\left(u, u_{i_{1}}, \ldots, u_{i_{p-1}}\right)\right]^{2}
$$

is correctly defined (induction hypothesis) and $\geq 0$, and

$$
u \mapsto \sum_{\left(u_{i_{1}}, \ldots, u_{i_{p-1}}\right)} \int \mathbb{P}(\mathrm{d} \omega) \psi\left[(1-L)^{\frac{r}{2}} T\left(u, u_{i_{1}}, \ldots, u_{i_{p-1}}\right)\right]^{2}
$$

defines an $\mathbb{R}$-valued quadratic form, positive, which satisfies the symmetry property, and bounded on any bounded part of Der. We can apply to this quadratic form the result of Lemma 9,2 to get the result.

Now we will study the link of the operator divergence, when defined on $\operatorname{Der}(\Omega)$ (Definition 2,4 , Remarks 2,1 and 2,2 ) with the NCM $\tilde{H}$, and the new gradient (Definition 7, 1).

Recall that div : $\operatorname{Der}(\Omega) \rightarrow \mathbb{D}^{-\infty}(\Omega)$ is such that: if $\delta \in \operatorname{Der}(\Omega), \forall \varphi \in$ $\mathbb{D}^{\infty}(\Omega)$,

(\operatorname{div} \delta, \varphi)=-\int \delta \varphi \mathbb{P}(\mathrm{d} \omega)
$$

div is a continuous operator.
Now, given a Hilbertian basis of $\tilde{H},\left(v_{i}\right)_{i \in \mathbb{N}_{*}}$ and $\alpha_{i}(\omega), i \in \mathbb{N}_{*}$ being the components of a vector field in $H, \sum_{i=1}^{\infty} \alpha_{i} v_{i} \in \mathbb{D}^{\infty}(\Omega, \tilde{H})$; we denote as usual $D_{v_{i}}$ the derivation associated to $v_{i} \in \tilde{H}$. Then:

where $D_{v_{i}}=h_{1}+\operatorname{div} A\left(v_{i}\right) \operatorname{grad}(\operatorname{Eq} 7,23), h_{1}$ being the vector field of $H$ such as $h_{1}=h_{2}+h_{3}(\operatorname{Eq} 7,27), h_{2}\left(v_{i}\right)=h\left(v_{i}\right)(\operatorname{Eq} 7,11)$.

Now $\sum_{i=1}^{\infty} \alpha_{i} h\left(v_{i}\right) \in \mathbb{D}^{\infty}(\Omega, H)$, so $\operatorname{div}\left(\sum_{i=1}^{\infty} \alpha_{i} h\left(v_{i}\right)\right) \in \mathbb{D}^{\infty}(\Omega)$.
It remains to show that $\lim _{N \uparrow \infty} \operatorname{div}\left(\sum_{i=1}^{N} \alpha_{i}\left(D_{v_{i}}-h\left(v_{i}\right)\right)\right) \in \mathbb{D}^{\infty}(\Omega)$. But

$$
\operatorname{div}\left(\sum_{i=1}^{N} \alpha_{i}\left(D_{v_{i}}-h\left(v_{i}\right)\right)\right)=\sum_{i=1}^{N} \alpha_{i} \operatorname{div}\left(D_{v_{i}}-h\left(v_{i}\right)\right)+\sum_{i=1}^{N}\left(D_{v_{i}}-h\left(v_{i}\right)\right) \cdot \alpha_{i}
$$

According to (Eq 7, 23), and Remark 2, 2, iii,

$$
\operatorname{div}\left(D_{v_{i}}-h\left(v_{i}\right)\right)=0
$$

We therefore just need to prove that $\lim _{N \uparrow \infty} \sum_{i=1}^{N}\left(D_{v_{i}}-h\left(v_{i}\right)\right) \cdot \alpha_{i} \in \mathbb{D}^{\infty}(\Omega)$, and with (Eq 26, 27),

D_{v_{i}}-h\left(v_{i}\right)=h_{3}\left(v_{i}\right)+\operatorname{div} A\left(v_{i}\right) \operatorname{grad}
$$

We need the following lemma:
Lemma 9..3. The set $\left(b_{i j}\right)_{i, j \in \mathbb{N}_{*}}$ being the components of a vector field in $\mathbb{D}^{\infty}(\Omega, H \otimes H)$, we denote by $T$ an operator defined only on the finite sums like $\sum_{i=1}^{m} b_{i j} h\left(v_{i}\right) \otimes h\left(v_{j}\right) b y$

$$
T\left(\sum_{i=1}^{m} b_{i j} h\left(v_{i}\right) \otimes h\left(v_{j}\right)\right)=\sum_{i, j=1}^{m} b_{i j}(\omega) A\left(v_{i}\right) \cdot h\left(v_{j}\right)
$$

Then there is a unique extension of $T$, which is a multiplicator from

$$
\mathbb{D}^{\infty}(\Omega, H \otimes H)
$$

to $\mathbb{D}^{\infty}(\Omega, H)$.
Proof. Let $d \in \mathbb{D}^{-\infty}(\Omega, H)$. Then straightforward computation shows that, if $T^{*}$ exists,
$\left(T^{*} d, \sum_{i, j=1}^{m} b_{i j}(\omega) h\left(v_{i}\right) \otimes h\left(v_{j}\right)\right)=-\left(\sum_{i=1}^{m} A\left(v_{i}\right)(d) \otimes h\left(v_{i}\right), \sum_{j, k=1}^{m} b_{k j} h\left(v_{k}\right) \otimes h\left(v_{j}\right)\right)$ So $T^{*} d=+\sum_{i=1}^{m} A^{*}\left(v_{i}\right)(d) \otimes h\left(v_{i}\right)$.

Each $A^{*}\left(v_{i}\right) \otimes h\left(v_{i}\right)$ can be considered as a vector matrix $\vec{A}_{i}$ with entries $\left(\vec{A}_{i}^{*}\right)_{k}^{\ell}=-\left(a\left(v_{i}\right)_{\ell}^{k} h\left(v_{i}\right)\right.$.

As shown previously in the proof of Lemma 7,4, ia $\left(v_{i}\right)_{\ell}^{k}$ are $i$-uniformly $\mathbb{D}^{\infty}$-Hölderian, and as $\left|h\left(v_{i}\right)\right|$ is bounded by $\frac{\text { constant }}{i}$, the sum

\sum_{i=1}^{\infty} A^{*}\left(v_{i}\right) \otimes h\left(v_{i}\right)
$$

is $\mathbb{D}^{\infty}$-Hölderian, so $\sum_{i=1}^{\infty} A^{*}\left(v_{i}\right) \otimes h\left(v_{i}\right)$ is a multiplicator from $\mathbb{D}^{-\infty}(\Omega, H)$ to $\mathbb{D}^{-\infty}(\Omega, H \otimes H)$.

Now we go back to $\sum_{i=1}^{\infty} \operatorname{div} A\left(v_{i}\right) \operatorname{grad} \alpha_{i},\left(\alpha_{i}\right)_{i \in \mathbb{N}_{*}}$ being by hypothesis the coordinates of a $D^{\infty}$-vector field in $H,\left(\operatorname{grad} \alpha_{i}\right)_{i \in \mathbb{N}_{*}} \in \mathbb{D}^{\infty}(\Omega, H \otimes H)$.

Then $\sum_{i=1}^{\infty} \operatorname{div} A\left(v_{i}\right)\left(\operatorname{grad} \alpha_{i}\right) \in \mathbb{D}^{\infty}(\Omega)$ because $\sum_{i=1}^{\infty} A\left(v_{i}\right)\left(\operatorname{grad} \alpha_{i}\right)$ can be written as $\sum_{i, j=1}^{\infty} b_{i j} h\left(v_{i}\right) \otimes h\left(v_{j}\right)$.

The last sum for which the convergence is to be proven is $\sum_{i=1}^{\infty} h_{3}\left(v_{i}\right) \cdot \alpha_{i}$. We can write

\sum_{i=1}^{\infty} h_{3}\left(v_{i}\right) \cdot \alpha_{i}=\left\langle\sum_{i=1}^{\infty} h_{3}\left(v_{i}\right) \otimes h\left(v_{i}\right), \sum_{j=1}^{\infty} \operatorname{grad} \alpha_{j} \otimes h\left(v_{j}\right)\right\rangle_{H \otimes H}
$$

and as $\left\|h_{3}\left(v_{i}\right)\right\|_{\mathbb{D}_{r}^{p}(\Omega)} \leq \frac{C_{2}(p, r)}{i}, C_{2}(p, r)$ being a constant $\sum_{i=1}^{\infty} h_{3}\left(v_{i}\right) \otimes h\left(v_{i}\right)$ is $\mathbb{D}^{\infty}(\Omega, H \otimes H)$-convergent, and so is $\sum_{j=1}^{\infty} \operatorname{grad} \alpha_{j} \otimes h\left(v_{j}\right)$; and the scalar product of two vector fields which are $\mathbb{D}^{\infty}(\Omega, H \otimes H)$ is in $\mathbb{D}^{\infty}(\Omega)$.

Now we will study the new O.U. operator built with the new grad (Def 7, 1) and the new div (Theorem 9, 2): div grad.

Lemma 9..4. If $V_{n}$ is a compact Riemannian manifold, then there exist $C^{\infty}\left(V_{n}\right)$ functions $\varphi_{i}, \psi_{i}, \alpha_{i}, i=1, \ldots, M$, such that for any $C^{\infty}$-vector field $U$ on $V_{n}$, we have:

U=\sum_{i=1}^{M} \psi_{i}\left\langle U, \operatorname{grad} \varphi_{i}\right\rangle_{V_{n}} \operatorname{grad} \alpha_{i} \tag{5}
\end{equation*}

Proof. Given a chart on $V_{n}$ with coordinates $x_{i},\left(\frac{\partial}{\partial x_{i}}\right), i=1, \ldots, n$, are the canonical basis vectors on each point of this chart; with the Gram-Schmidt process, we get an orthonormal basis, denoted $\left(v_{j}\right)_{j=1, \ldots, n}$.

Then $\sum_{j=1}^{n}\left\langle U, v_{j}\right\rangle_{V_{n}} v_{j}=U$.
Then using a finite partition of unity on $V_{n}$, we have the desired result.
We recall that if $f \in C^{\infty}\left(V_{n}\right)$, we denote by $F_{f, t}(\omega)=f \circ I(\omega)(t), I$ being the Itô map from $\mathcal{W}\left(\mathbb{R}^{n}\right)$ into $\mathbb{P}_{m_{0}}\left(V_{n}\right)$. We denote by $k_{j, t}$ the vector field of $\tilde{H}$ defined by

k_{j, t}(s)=(s \wedge t)\left(u e_{j}\right)(s, \omega)
$$

$u e_{j}(s, \omega)$ being the SPT of $u e_{\mu}$ at time $s$ "along $\omega$ ", and $j=1, \ldots, n$.
Definition 9..1. With $t_{0} \in[0,1]$, we call a $\mathcal{F}_{t_{0}}$-vector field a vector field which when written as a process $\varphi(t, \omega)$ is such that
i) $\dot{\varphi}(t, \omega)=0 \quad \forall t \geq t_{0}$ a.s.;
ii) $\varphi(t, \omega) \in \mathcal{F}_{t_{0}} \quad \forall t \in[0,1]$

REmARK 9..1. The scalar product in $\tilde{H}$ of two $\mathcal{F}_{t_{0}}$-vector fields is again in $\mathcal{F}_{t_{0}}$.

TheOrem 9..3. The new $O$.U. operator, div grad, verifies: if $f \in \mathcal{F}_{t}$, $\operatorname{div} \operatorname{grad} f \notin \mathcal{F}_{t}$ in general.

Proof. We know that $k_{j, t} \in \mathcal{F}_{t}$, with $j=1, \ldots, n$. With Lemma 9, 4, we can write

\sum_{i=1}^{M} \psi_{i}[I(\omega)(t)]\left\langle\overrightarrow{\operatorname{grad}} \varphi_{i}, k_{t}\right\rangle_{V_{n}}(I(\omega)(t))\left(\overrightarrow{\operatorname{grad}} \alpha_{i}\right)(I(\omega)(t))=k_{t}
$$

where $\overrightarrow{g r a d}$ is the usual gradient on the manifold $V_{n}$. With Remark 7 , 1 , we get

\sum_{i=1}^{M} \psi_{i}(I(\omega)(t))\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}}(\omega) \cdot\left(\overrightarrow{\operatorname{grad}} \alpha_{i}\right)(I(\omega)(t))=k_{t}(I(\omega)(t))
$$

We make the scalar product on $V_{n}$ of both members of this last equation, with a determinist vector field $V$ and get:

\sum_{i=1}^{M} \psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}}\left\langle V, \overrightarrow{\operatorname{grad}} \alpha_{i}\right\rangle_{V_{n}}=\left\langle k_{t}, V\right\rangle_{V_{n}} \tag{6}
\end{equation*}
$$

But

\left\langle k_{t}, V\right\rangle_{\tilde{H}}=V(t)=\frac{1}{t}\left\langle k_{t}, V\right\rangle_{V_{n}}
$$

so (6) becomes

\sum_{i=1}^{M} \psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}}\left\langle V, \overrightarrow{\operatorname{grad}} \alpha_{i}\right\rangle_{V_{n}}=t\left\langle k_{t}, V\right\rangle_{\tilde{H}} \tag{7}
\end{equation*}
$$

As $V \in \tilde{H}$, we have

\left\langle V, \overrightarrow{\operatorname{grad}} \alpha_{i}\right\rangle_{V_{n}}=\left\langle V, \operatorname{grad} \alpha_{i}\right\rangle_{\tilde{H}}

and (7) becomes:

From which we deduce

which proves that $k_{t} \in \tilde{H}$.
Now we show that $\operatorname{div} k_{t} \notin \mathcal{F}_{t}: k_{t} \in \tilde{H}$ so $k_{t}$ as an operator is $D_{k_{t}}$, with $D_{k_{t}}=h_{1}\left(k_{t}\right)+\operatorname{div} A\left(k_{t}\right)$ grad, $h\left(k_{t}\right)$ being a vector field and $A\left(k_{t}\right)$ a multiplicator.

Then $\operatorname{div} D_{k_{t}}=\operatorname{div}\left(h_{1}\left(k_{t}\right)\right)+\operatorname{div}\left(\operatorname{div} A\left(k_{t}\right) \operatorname{grad}\right)$. With Remark 2, 2, iii, $\operatorname{div}\left(\operatorname{div} A\left(k_{t}\right) \operatorname{grad}\right)=0$ so

\operatorname{div} D_{k_{t}}=\operatorname{div}\left[h_{2}\left(k_{t}\right)\right]+\operatorname{div}\left[h_{3}\left(k_{t}\right)\right] \tag{Eq7,27}
\end{equation*}

As

h_{3}\left(k_{t}\right)(s)=\frac{1}{2} \int_{0}^{s} \sum_{\mu=1}^{n} b_{\mu, \mu}\left(k_{t}\right)(r, \omega) \mathrm{d} r \tag{Eq7,25}
\end{equation*}
$$

we see that generally, $\operatorname{div} h_{3} \notin \mathcal{F}_{t}$.
Now we apply div to both members of (8),

$$
\begin{aligned}
\operatorname{div}\left(t k_{t}\right)= & \operatorname{div}\left(\sum_{i=1}^{M} \psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}} \operatorname{grad} F_{\alpha_{i}, t}\right) \\
= & \sum_{i=1}^{M} \psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}} \cdot \operatorname{div} \operatorname{grad} F_{\alpha_{i}, t} \\
& +\sum_{i=1}^{M}\left\langle\operatorname{grad} F_{\alpha_{i}, t}, \operatorname{grad}\left(\psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}}\right)\right\rangle_{\tilde{H}}
\end{aligned}
$$

but as $F_{\alpha_{i}, t} \in \mathcal{F}_{t}, \operatorname{grad} F_{\alpha_{i}, t}$ is a $\mathcal{F}_{t}$-vector field, $\psi_{i} \in \mathcal{F}_{t}$ and $F_{\varphi_{i}, t} \in \mathcal{F}_{t}$ so $\operatorname{grad}\left[\psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}}\right]$ is a $\mathcal{F}_{t}$-vector field, and with Remark 9, 1,

$$
\sum_{i=1}^{M}\left\langle\operatorname{grad} F_{\alpha_{i}, t}, \operatorname{grad}\left(\psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}}\right)\right\rangle_{\tilde{H}} \in \mathcal{F}_{t}
$$

So at least one term $\psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}} \cdot \operatorname{div} \operatorname{grad} F_{\alpha_{i}, t}$ is not in $\mathcal{F}_{t}$. But $\psi_{i}\left\langle k_{t}, \operatorname{grad} F_{\varphi_{i}, t}\right\rangle_{\tilde{H}} \in$ $\mathcal{F}_{t}$; so there exists an $i$ such that

\operatorname{div} \operatorname{grad} F_{\alpha_{i}, t} \notin \mathcal{F}_{t}
$$

while

F_{\alpha_{i}, t}=\alpha_{i}[I(\omega)(t)] \in \mathcal{F}_{t}
$$

The same method can be used to show that if $A$ is an adapted multiplicator, then $\operatorname{div} A g r a d$ will not, in general, sends $\mathcal{F}_{t}$ in $\mathcal{F}_{t}$.

Theorem 9..4. Using again the notation $D_{0}(\Omega)$ for the subset of $\operatorname{Der}(\Omega)$ that is in bijection with $\operatorname{Der}^{*}(\Omega)$, we have: $D_{0} \subset \tilde{H}$ and $D_{0}$ is dense in $\tilde{H}$, the density being conceived as usual, as simple convergence on $\mathbb{D}^{\infty}$-bounded subsets of $\mathbb{D}^{\infty}(\Omega)$.

Proof. The $(\mathrm{Eq} 9,8)$ show that $k_{t} \in D_{0}(\Omega)$. And the $\mathbb{D}^{\infty}$-linear sums of $k_{t}$ will be dense in $\tilde{H}$.

ThEOREM 9..5. Let $q_{1}$ a bilinear form, positive definite on $\operatorname{Der}^{*}(\Omega) \times \operatorname{Der}^{*}(\Omega)$, with values in $\mathbb{D}^{\infty}(\Omega), D_{0}^{(1)}(\Omega)$ being the subset of $\operatorname{Der}(\Omega)$ which is in bijective correspondence to $\operatorname{Der}^{*}(\Omega)$, thanks to $q_{1}$. This bijection being denoted $\theta_{1}$, let $\alpha$ a map

$$
\alpha: D_{0}^{(1)}(\Omega) \times D_{0}^{(1)}(\Omega) \rightarrow \mathbb{D}^{\infty}(\Omega)
$$

such that
i) $\alpha$ admits an extension on $\operatorname{Der}(\Omega) \times \operatorname{Der}(\Omega) \rightarrow \mathbb{D}^{\infty}(\Omega)$
ii) $q_{1}+\alpha \circ \theta_{1}=q_{2}$ is a bilinear form, positive definite and continuous from $\operatorname{Der}^{*}(\Omega) \times \operatorname{Der}^{*}(\Omega)$ to $\mathbb{D}^{\infty}(\Omega)$.
Then the extension of $\alpha$ is unique, and $D_{0}^{(2)} \subset D_{0}^{(1)}(\Omega)$.

## Proof.

i) Let $\tilde{\alpha}_{1}$ and $\tilde{\alpha}_{2}$ be two extensions of $\alpha$ which are equal on $D_{0}^{(1)} \times D_{0}^{(1)}$. Suppose that there exists $v_{0} \in D_{0}^{(1)}(\Omega)$ such that $\gamma(v)=\left(\tilde{\alpha}_{1}-\tilde{\alpha}_{2}\right)\left(v_{0}, v\right)$; then $\gamma \in \operatorname{Der}^{*}(\Omega)$ and $\gamma\left(D_{0}^{(1)}(\Omega)\right)=0$. But $\theta(\gamma) \in D_{0}^{(1)}(\Omega)$. Then $\gamma(\theta(\gamma))=0=q_{1}(\gamma, \gamma)$ so $\gamma=0$. Same proof for $\gamma^{\prime}(\omega)=\left(\tilde{\alpha}_{1}-\tilde{\alpha}_{2}\right)(v, w)$ with $v \in \operatorname{Der}(\Omega)$ fixed.
ii) Let $\beta$ and $\beta^{\prime} \in \operatorname{Der}^{*}(\Omega)$,

$$
q_{1}\left(\beta, \beta^{\prime}\right)+\alpha\left(\theta_{1}(\beta), \theta_{1}\left(\beta^{\prime}\right)\right)=q_{2}\left(\beta, \beta^{\prime}\right)
$$

Then $\beta\left(\theta_{1}\left(\beta^{\prime}\right)\right)+\alpha\left(\theta_{1}(\beta), \theta_{1}\left(\beta^{\prime}\right)\right)=\beta\left(\theta_{2}\left(\beta^{\prime}\right)\right), \theta_{1}$ and $\theta_{2}$ are the bijections of $\operatorname{Der}^{*}(\Omega)$ on $D_{0}^{(i)}(\Omega), i=1,2$, obtained with $q_{1}$ and $q_{2}$.

Let $\mu\left(\beta^{\prime \prime}\right)=\alpha\left(\theta_{1}(\beta), \beta^{\prime \prime}\right)$. Then $\mu \in \operatorname{Der}^{*}(\Omega)$ and

$$
\beta\left(\theta_{1}\left(\beta^{\prime}\right)\right)+\mu\left(\theta_{1}\left(\beta^{\prime}\right)\right)=\beta\left(\theta_{2}\left(\beta^{\prime}\right)\right)=\beta^{\prime}\left(\theta_{2}(\beta)\right)
$$

as $q_{2}$ is symmetrical. So $(\beta+\mu)\left(\theta_{1}\left(\beta^{\prime}\right)\right)=\beta^{\prime}\left(\theta_{2}(\beta)\right)$ which implies $\beta^{\prime}\left(\theta_{1}(\beta+\mu)\right)=\beta^{\prime}\left(\theta_{2}(\beta)\right)$. As this is valid $\forall \beta^{\prime} \in \operatorname{Der}^{*}(\Omega)$,

$$
\theta_{1}(\beta+\mu)=\theta_{2}(\beta)
$$

which implies $D_{0}^{(2)}(\Omega) \subset D_{0}^{(1)}(\Omega)$.
So on $D_{0}^{(2)}(\Omega)$, it is possible to make some variational calculus.

## 9. 2 Another "renormalisation" theorem

Let $V_{n}$ an $n$-dimensional manifold, $q$ a metric on $V_{n}(q$ is bilinear, symmetrical and positive definite), $\mu_{q}$ the canonical measure on $V_{n}$ associated to $q, \nabla$ the Levi-Civita connection related to $q, \phi$ a $C^{\infty}$ density on $V_{n}, \phi>0$, and $m_{0} \in V_{n}$.

We recall the following formulas:
If $f, g$ are $C^{\infty}$ functions on $V_{n}$, and $u, v \in \Gamma\left(V_{n}\right)$ ( $u$ and $v$ are vector fields), we have:

$$
\begin{aligned}
u \cdot f & =q(\operatorname{grad} f, u) \\
(\operatorname{Hess} f)(u, v) & =u \cdot(v \cdot f)-\left(\nabla_{u} v\right) \cdot f \\
& =(\operatorname{Hess} f)(v, u)
\end{aligned}
$$

If $\left(e_{i}\right)_{i=1, \ldots, n}$ is an orthonormal basis on $T_{m} V_{n}, m$ being in a small neighbourhood of $m_{0} \in V_{n}$ :

$$
\begin{aligned}
\Delta f & =\sum_{i=1}^{n}\left\{e_{i} \cdot\left(e_{i} \cdot f\right)-\left(\nabla_{e_{i}} e_{i}\right) \cdot f\right\} \\
& =\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, e_{i}\right) \\
\operatorname{div} u & =\sum_{i=1}^{n} q\left(\nabla_{e_{i}} u, e_{i}\right)
\end{aligned}
$$

Then we define:

$$
\Delta u=\sum_{i=1}^{n}\left\{\nabla_{e_{i}}\left(\nabla_{e_{i}} u\right)-\nabla_{\nabla_{e_{i}} e_{i}} u\right\}
$$

and the O.U. operator $L$ by

$$
\forall f, \forall g \in C^{\infty}\left(V_{n}\right), \quad \int g L(f) \cdot \phi \mathrm{d} \mu_{q}=\int q(\operatorname{grad} f, \operatorname{grad} g) \phi \cdot \mathrm{d} \mu_{q}
$$

From the last equation, we deduce:

$$
L(f)=-\Delta f-q(\operatorname{grad} \log \varphi, \operatorname{grad} f)
$$

Then we define the operator div by

$$
\int g\left(\operatorname{div}_{\varphi} f\right) \varphi \mathrm{d} \mu_{q}=-\int q(\operatorname{grad} f, \operatorname{grad} g) \varphi \mathrm{d} \mu_{q}
$$

and

$$
L(u)=-\Delta u-\nabla_{\operatorname{grad} \log \varphi} u
$$

From the symmetry of the Hessian, we have

$$
q\left(v, \nabla_{u} \operatorname{grad} f\right)=q\left(u, \nabla_{v} \operatorname{grad} f\right)
$$

and

$$
\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{u} e_{i}\right)=\sum_{i=1}^{n} \sum_{j=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, e_{j}\right) q\left(e_{j}, \nabla_{u} e_{i}\right)=0
$$

because $q\left(e_{i}, e_{j}\right)=0$ and the connection is the Levi-Civita connection. Now we are going to compute $q(\operatorname{grad} L(f), u)$ :

$$
\begin{align*}
q(\operatorname{grad} L(f), u)= & -q(\operatorname{grad} \Delta(f), u)-q(\operatorname{grad} q(\operatorname{grad} \log \varphi, \operatorname{grad} f), u) \\
= & -u \cdot \sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, e_{i}\right)-u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f) \\
=- & \sum_{i=1}^{n} q\left(\nabla_{u}\left(\nabla_{e_{i}} \operatorname{grad} f\right), e_{i}\right)-\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{u} e_{i}\right) \\
& -u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f) \\
= & -\sum_{i=1}^{n} q\left(\nabla_{u}\left(\nabla_{e_{i}} \operatorname{grad} f\right), e_{i}\right)-u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f) \\
= & R(u, \operatorname{grad} f)-\sum_{i=1}^{n} q\left(\nabla_{e_{i}}\left(\nabla_{u} \operatorname{grad} f\right), e_{i}\right) \\
& \quad-\sum_{i=1}^{n} q\left(\nabla_{\left[u, e_{i}\right]} \operatorname{grad} f, e_{i}\right)-u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f)
\end{align*}
$$

Using the Hessian symmetry:

$$
\begin{aligned}
q(\operatorname{grad} L(f), u)= & R(u, \operatorname{grad} f)-\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right) \\
& -\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f,\left[u, e_{i}\right]\right)-u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f)
\end{aligned}
$$

Now we compute $\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f,\left[u, e_{i}\right]\right)$ :

$$
\begin{aligned}
\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f,\left[u, e_{i}\right]\right) & =\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{u} e_{i}\right)-\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{e_{i}} u\right) \\
& =-\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{e_{i}} u\right)
\end{aligned}
$$

So

$$
\begin{aligned}
q(\operatorname{grad} L(f), u)= & R(u, \operatorname{grad} f)-\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right) \\
& +\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{e_{i}} u\right)-u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f)
\end{aligned}
$$

Now we compute $\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right)$ :

$$
\begin{aligned}
\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right)= & \sum_{i=1}^{n} e_{i} \cdot q\left(\nabla_{u} \operatorname{grad} f, e_{i}\right)-\sum_{i=1}^{n} q\left(\nabla_{u} \operatorname{grad} f, \nabla_{e_{i}} e_{i}\right) \\
= & \sum_{i=1}^{n} e_{i} \cdot q\left(\nabla_{e_{i}} \operatorname{grad} f, u\right)-\sum_{i=1}^{n} q\left(\nabla_{u} \operatorname{grad} f, \nabla_{e_{i}} e_{i}\right) \\
= & \sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{e_{i}} \operatorname{grad} f, u\right)-\sum_{i=1}^{n} q\left(\nabla_{u} \operatorname{grad} f, \nabla_{e_{i}} e_{i}\right) \\
& \quad+\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \operatorname{grad} f, \nabla_{e_{i}} u\right)
\end{aligned}
$$

Using this equality in (8') we have

$$
\begin{aligned}
q(\operatorname{grad} L(f), u)= & R(u, \operatorname{grad} f)-q(\Delta \operatorname{grad} f, u)-u \cdot q(\operatorname{grad} \log \varphi, \operatorname{grad} f) \\
= & R(u, \operatorname{grad} f)-q(\Delta \operatorname{grad} f, u)-q\left(\nabla_{u} \operatorname{grad} \log \varphi, \operatorname{grad} f\right) \\
& -q\left(\operatorname{grad} \log \varphi, \nabla_{u} \operatorname{grad} f\right)
\end{aligned}
$$

We denote $Z(u)=\nabla_{u} \operatorname{grad} \log \varphi$ and

$$
\tilde{R}(u, v)=\operatorname{Ricc}(u, v)-q(Z(u), v)
$$

Then

$$
\begin{equation*}
q(\operatorname{grad} L(f), u)=\tilde{R}(u, \operatorname{grad} f)+q(L(\operatorname{grad} f), u) \tag{9}
\end{equation*}
$$

Now we compute $L(u \cdot f)$ :

$$
\begin{equation*}
L(u \cdot f)=q(L(u), \operatorname{grad} f)+q\left(u, L(\operatorname{grad} f)-2 \sum_{i=1}^{n} q\left(\nabla_{e_{i}} u, \nabla_{e_{i}} \operatorname{grad} f\right)\right) \tag{10}
\end{equation*}
$$

and
$\sum_{i=1}^{n} q\left(\nabla_{e_{i}} u, \nabla_{e_{i}} \operatorname{grad} f\right)=\sum_{i=1}^{n}\left\{e_{i} \cdot q\left(u, \nabla_{e_{i}} \operatorname{grad} f\right)-q\left(u, \nabla_{e_{i}} \nabla_{e_{i}} \operatorname{grad} f\right)\right\}$

$$
\begin{align*}
& =\sum_{i=1}^{n} e_{i} \cdot q\left(e_{i}, \nabla_{u} \operatorname{grad} f\right)-\sum_{i=1}^{n} q\left(u, \nabla_{e_{i}} \nabla_{e_{i}} \operatorname{grad} f f\right) \\
& =\sum_{i=1}^{n}\left\{q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right)+q\left(\nabla_{u} \operatorname{grad} f, \nabla_{e_{i}} e_{i}\right)-q\left(u, \nabla_{e_{i}} \nabla_{e_{i}} \operatorname{grad} f\right)\right\} \\
& =\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right)-q(u, \Delta(\operatorname{grad} f)) \\
& =\sum_{i=1}^{n} q\left(\nabla_{e_{i}} \nabla_{u} \operatorname{grad} f, e_{i}\right)+q(u, L(\operatorname{grad} f))+q\left(\nabla_{u} \operatorname{grad} f, \operatorname{grad} \log \varphi\right) \\
& =q\left(u, L(\operatorname{grad} f)+\frac{1}{\varphi} \operatorname{div}\left(\varphi\left\{\nabla_{u} \operatorname{grad} f\right\}\right)\right. \tag{11}
\end{align*}
$$

Using (9), (10) in (11), we get:

$$
\begin{aligned}
L(u \cdot f) & =q(L(u), \operatorname{grad} f)+\tilde{R}(u, \operatorname{grad} f)-q(\operatorname{grad} L(f), u)-\frac{2}{\varphi} \operatorname{div}\left\{\varphi \cdot \nabla_{u} \operatorname{grad} f\right\} \\
& =q(L(u), \operatorname{grad} f)+\tilde{R}(u, \operatorname{grad} f)-q(\operatorname{grad} L(f), u)-2 \operatorname{div}_{\varphi}\left(\nabla_{u} \operatorname{grad} f\right)
\end{aligned}
$$

Finally:

$$
\begin{equation*}
q(L(u)+\tilde{R}(u), \operatorname{grad} f)=L(u \cdot f)+q(\operatorname{grad} L(f), u)+2 \operatorname{div}_{\varphi}\left(\nabla_{u} \operatorname{grad} f\right) \tag{12}
\end{equation*}
$$

Now we will extrapolate the previous formula for a $\mathbb{D}^{\infty}$-stochastic manifold, with an atlas having only one global chart, and such that the operator div sends $\mathcal{D}_{0}$ in $\mathbb{D}^{\infty}$ 。

Then, if $u$ and $v$ are elements of $\mathcal{D}_{0}$ :

$$
\operatorname{div}([u, v])=(u \cdot \operatorname{div} v)-v \cdot(\operatorname{div} u) \in \mathbb{D}^{\infty}
$$

because $u, v \in \mathcal{D}_{0}$ and $\operatorname{div} u, \operatorname{div} v \in \mathbb{D}^{\infty}$.
Remark 9..2. Without the hypothesis

$$
\text { div : } \mathcal{D}_{0} \rightarrow \mathbb{D}^{\infty}
$$

we only have

$$
\operatorname{div} u \in \mathbb{D}^{-\infty}
$$

But with this hypothesis on $\operatorname{div}$, we have if $u, v \in \mathcal{D}_{0}$ : $\operatorname{div} \nabla_{u} v \in \mathbb{D}^{\infty}$, because

$$
\frac{1}{2} \operatorname{div}\left(\nabla_{u+v} u+v\right)-\frac{1}{2} \operatorname{div} \nabla_{u} u-\frac{1}{2} \operatorname{div} \nabla_{v} v
$$

and we know that (Lemma 3, 4) $\nabla_{u} u \in \mathcal{D}_{0}$ if $u \in \mathcal{D}_{0}$.
Now $\frac{2}{\varphi} \operatorname{div}\left\{\varphi \nabla_{u} \operatorname{grad} f\right\}$, the last item in (12), can be extrapolated by $\operatorname{div} \nabla_{u} \operatorname{grad} f$, and as $f \in \mathbb{D}^{\infty}, \operatorname{grad} f \in \mathcal{D}_{0}$, and $\operatorname{div}\left(\nabla_{u} \operatorname{grad} f\right) \in \mathbb{D}^{\infty}$.

In (12) we have two more items, $L(u \cdot f)$ and $q(\operatorname{grad} L(f), u)$. As $u \in \mathcal{D}_{0}$, and $\operatorname{grad} L(f) \in \mathcal{D}_{0}, q(\operatorname{grad} L(f), u) \in \mathbb{D}^{\infty}$ and $u \cdot f \in \mathbb{D}^{\infty}, L(u \cdot f) \in \mathbb{D}^{\infty}$.

So although quantities like $\tilde{R}$ and $L(u)$ cannot, generally, be defined on such a stochastic manifold, the quantity $\tilde{R}(u, \operatorname{grad} f)+L(u)$ can be given a meaning by

$$
\begin{equation*}
q(\tilde{R}(u, \operatorname{grad} f)+L(u), \operatorname{grad} f)=L(u \cdot f)+q(\operatorname{grad} L(f), u)+\operatorname{div}\left(\nabla_{u} \operatorname{grad} f\right) \tag{13}
\end{equation*}
$$

This extrapolation is legitimate because in the case of the Wiener space "with $N$ dimensions",

$$
\begin{aligned}
\varphi & =e^{-\frac{1}{2} \sum_{i=1}^{N} W\left(e_{i}\right)^{2}} \\
\nabla_{u} \operatorname{grad} f & =\sum_{i=1}^{N}\left(u \cdot e_{i} \cdot f\right) e_{i} \\
\operatorname{div} \nabla_{u} \operatorname{grad} f & =-\sum_{i=1}\left\{\left(u \cdot e_{i} f\right) W\left(e_{i}\right)+e_{i} \cdot\left(u \cdot e_{i} f\right)\right\}
\end{aligned}
$$

In these two last formulas, $\nabla_{u}$ and div are operators on the Wiener space.
And

$$
\operatorname{div}_{\varphi}\left[\nabla_{u} \operatorname{grad} f\right]=q\left(\operatorname{grad} \log \varphi, \nabla_{u} \operatorname{grad} f\right)+\operatorname{div}\left(\nabla_{u} \operatorname{grad} f\right)
$$

so when $\varphi=e^{-\frac{1}{2} \sum_{i=1}^{N} W\left(e_{i}\right)^{2}}$,

$$
\begin{aligned}
\operatorname{grad} \log \varphi & =-\sum_{i=1}^{N} W\left(e_{i}\right) e_{i} \\
q\left(\operatorname{grad} \log \varphi, \nabla_{u} \operatorname{grad} f\right) & =-\sum_{i=1} W\left(e_{i}\right) \cdot u \cdot\left(e_{i} f\right) \\
\nabla_{u} \operatorname{grad} f & =\sum_{i=1}^{N}\left(u \cdot\left(e_{i} \cdot f\right)\right) \cdot e_{i} \\
\operatorname{div}\left(\nabla_{u} \operatorname{grad} f\right) & =\sum_{i, j=1}^{N} q\left(\nabla_{e_{j}}\left(\left(u \cdot\left(e_{i} \cdot f\right)\right) e_{i}\right), e_{j}\right) \\
& =\sum_{i=1}^{N} e_{i} \cdot u \cdot\left(e_{i} \cdot f\right)
\end{aligned}
$$

So the formula (13) is valid when the density is $\varphi=e^{-\frac{1}{2} \sum_{i=1}^{N} W\left(e_{i}\right)^{2}}$ and it does not depend on N ; so it is valid when $N=+\infty$; in this case, the Wiener space comes with the standard quadratic form, $\tilde{R}=\mathrm{Id}$; so $L(u)$ then has meaning, even when $u \in$ Der, because we can give meaning to $\nabla_{u} \operatorname{grad} f$ with $u \in$ Der, thanks to the extension theorem (tensor product by $H$ ).

Remark 9..3. If $\mathcal{U}(t, \omega)$ is a unitary process, adapted and multiplicator, but not continuous, it is still possible to approximate $\mathcal{U}$, in the multiplicator sense, with a sequence $\mathcal{U}_{n}$ of step-processes, adapted and n-uniformly multiplicators.

The proof will use the Egorov theorem.

## 9. 3 Some open questions

(1) $A$ being an adapted process such that it sends $\mathbb{D}^{\infty}$-adapted vector fields in $\mathbb{D}^{\infty}$-adapted vector fields, is $A$ a $\mathbb{D}^{\infty}$-multiplicator?
(2) If $\mathcal{U}$, unitary operator, sends $\mathbb{D}^{\infty}$-vector fields in $\mathbb{D}^{\infty}$-vector fields, and admits an inverse, is $\mathcal{U}^{-1}$ a multiplicator?
(3) In the Wiener space case, is any $\mathbb{D}^{\infty}$-derivation the sum of a vector field and an operator which can be written as div Agrad? We know that if the derivation is adapted with a null divergence, this is true.
(4) Does the $\mathbb{D}^{\infty}$-dual of $\mathbb{D}^{\infty}$-vector fields consist only of $\mathbb{D}^{\infty}$-vector fields?
(5) Is it possible to generalize the results about operators of the $\mathcal{U} \mathrm{d} B$ form with multiples times Brownians?
(6) Given a Gaussian space $\Omega$, and a bilinear form $q$ on $\operatorname{Der}^{*}$, it is possible to obtain an O.U. operator associated with $q$, and then a $\mathbb{D}^{\infty}(q)$ space. Under which conditions will we have $\mathbb{D}^{\infty}(q) \subseteq \mathbb{D}^{\infty}(\Omega)$ ?
(7) Given the map $\theta$ generated by a $\mathcal{U} \mathrm{d} B$ type of map, $\mathcal{U}$ being an adapted multiplicator, is $\theta$ a $\mathbb{D}^{\infty}$-morphism? We know already that generally, it is not a $\mathbb{D}^{\infty}$-isomorphism.
(8) In the same setting than in (7), if $\mathcal{U}$ moreover is continuous relatively to $t, \mathbb{P}$-a.s., then is $\theta$ inversible in $L^{\infty-0}$ ?
(9) Given a diffeomorphism of $\mathbb{D}^{\infty}$ to $\mathbb{D}^{\infty}$, does it imply the existence of a $\mathbb{D}^{\infty}$-density?
(10) Given a derivation on $\mathbb{D}^{\infty}$, is its divergence an item of $\mathbb{D}^{\infty}$ ? If (3) is true, then (10) is true.
(11) If $\theta$ is a diffeomorphism generated by a $\mathcal{U} \mathrm{d} B$ type of map, of the Wiener in itself, does it induce a diffeomorphism of Wiener ${ }^{\mathbb{N}}$ in itself?
(12) If we have a $p$-linear form $\varphi$ on $(\otimes \operatorname{Der})^{p}$ and a $\mathbb{D}^{\infty}$-bilinear positive form $q$ on Der $\times$ Der, after having chosen a basis of the Cameron-Martin space $H,\left(e_{i}\right)_{i \in \mathbb{N}_{*}}$, such that $q\left(e_{i}, e_{j}\right)=\delta_{i j}$, what are the NSC to have

$$
\sum_{\left(e_{i_{1}}, \ldots, e_{i_{p}}\right)} \varphi\left(e_{i_{1}}, \ldots, e_{i_{p}}\right)^{2} \in \mathbb{D}^{\infty} \quad ?
$$

(13) Is it possible to give meaning to the O.U. operator when it acts on a $\mathbb{D}^{\infty}$-derivation $\delta$ such that $(\mathrm{O} . \mathrm{U})(\delta) \in$ Der? Same question with O.U. acting on Der*.
(14) If a $\mathbb{D}^{\infty}$-derivation has the form div $A$ grad, is the choice for $A$ unique? We know that it is true when the derivation is adapted, with zero divergence.
(15) If the matrix process defined by the antisymmetrical matrix $A$ is not adapted, is the multiplicator condition on $A$ necessary, so that div $A$ grad is a derivation on $\mathbb{D}^{\infty}$ ?
(16) Let $A$ be a multiplicator on the $\mathbb{D}^{\infty}$-module $\mathbb{D}^{\infty}(\Omega, H), A: \mathbb{D}^{\infty}(\Omega, H) \rightarrow$ $\mathbb{D}^{\infty}(\Omega, H)$. Can $A$ be written as a finite $\mathbb{D}^{\infty}$-linear arrangement of unitary multiplicators?
(17) Is it possible to generalize to the $n$ - $\mathbb{D}^{\infty}$-linear forms on Der, the approximation theorem 3, 2 ?
(18) Given an infinite sequence of morphisms $\varphi_{n}$, from a Wiener $\mathcal{W}$ to a Wiener $\mathcal{W}$ under which conditions can we get an induced $\mathbb{D}^{\infty}$-morphism from $\mathcal{W}^{\mathbb{N}}$ to $\mathcal{W}^{\mathbb{N}}$ ?
(19) Given $r \in \mathbb{N}_{*}$, does a derivation $\delta: \mathbb{D}^{\infty} \rightarrow \mathbb{D}^{\infty}$ exist, such that there exists $f \in \mathbb{D}_{r}^{\infty}$ with $\delta f \in L^{\infty-0}$ and $\delta f \notin \mathbb{D}_{1}^{\infty}$ ?
(20) If we define as a multiplicator, an operator $A$ that sends continuously $\mathbb{D}^{\infty}(\Omega, H)$ to $\mathbb{D}^{\infty}(\Omega, H)$, then as in the adapted case, is it enough for $A$ to send continuously $\mathbb{D}_{\infty}^{2}(\Omega, H)$ to $\mathbb{D}_{\infty}^{2}(\Omega, H)$ to be a multiplicator?
(21) $V_{n}$ being a Riemannian manifold, we define a random connection on $V_{n}$, the randomness according to $\omega \in \mathbb{P}\left(m_{0}, V_{n}\right)$. Then which results, that were sound for $\mathbb{P}\left(m_{0}, V_{n}\right)$, remain valid?
(22) Let us consider a map from a probabilised space to a subset of finite dimensional manifolds. Under which conditions can the graph of this map be endowed with a $\mathbb{D}^{\infty}$-stochastic atlas?
(23) Under which conditions on the bilinear positive form $q$ can we generalize the results that were obtained for the standard bilinear form?
(24) In the case where $V_{n}$ is not a compact Riemannian manifold, let $\tau_{B}$ be the exit stopping time of the Brownian on $V_{n}$, distinct from $\infty$ when the manifold $V_{n}$ is not Brownian complete. Does a sequence of stopping times exist, $\tau_{j}, j \in \mathbb{N}_{*}, \tau_{j} \uparrow \tau_{B}$, such that on each stochastic interval $\llbracket 0, \tau_{j} \rrbracket$, there exists a $\mathbb{D}^{\infty}$-manifold structure on $\mathbb{P}_{m_{0}}\left(V_{n}, g\right)$ and that the restriction to $\llbracket 0, \tau_{j} \rrbracket$ of the $\mathbb{D}^{\infty}$-stochastic process on $\llbracket 0, \tau_{j+1} \rrbracket$ is the $\mathbb{D}^{\infty}$-stochastic structure of $\llbracket 0, \tau_{j} \rrbracket$ ?
