Dynamic Limit Growth Indices in Discrete Time

Abstract

We propose a new class of mappings, called Dynamic Limit Growth Indices, that are designed to measure the long-run performance of a financial portfolio in discrete time setup. We study various important properties for this new class of measures, and in particular, we provide necessary and sufficient condition for a Dynamic Limit Growth Index to be a dynamic assessment index. We also establish their connection with classical dynamic acceptability indices, and we show how to construct examples of Dynamic Limit Growth Indices using dynamic risk measures and dynamic certainty equivalents. Finally, we propose a new definition of time consistency, suitable for these indices, and we study time consistency for the most notable representative of this class – the dynamic analog of risk sensitive criterion.

1 Introduction

In this paper we study some mappings that are designed to measure the long-run performance of a financial portfolio. Importance of measurement of the long run growth of a portfolio is widely recognized among financial practitioners, and has been extensively discussed in the literature (see for instance [\[2](#page-22-0), [15](#page-23-0)], and references therein).

Here, we shall focus on measures that quantify the tradeoff between portfolio growth and the risk associated with it, appropriately normalized in time. Among several such possible measures, the one which has attracted the most attention, is the so called Risk Sensitive Criterion [\[17](#page-23-1), [6](#page-22-1), [7](#page-23-2)].

In fact, the starting point of this paper was to investigate whether the Risk Sensitive Criterion belongs to the family of so called dynamic acceptability indices [\[11](#page-23-3), [5](#page-22-2)], which are known to provide a unifying framework for classical financial measures of performance such as Sharpe Ratio, Gain to Loss Ratio, etc. It turns out that indeed the Risk Sensitive Criterion is a dynamic acceptability index. But, this investigation also led us to introducing a new class of mappings designed to measure the efficiency of the long run cumulative growth of a portfolio, which we named Dynamic Limit Growth Indices. Since, in this paper, we measure time according to discrete quanta, we only consider here dynamic limit growth indices in discrete time.

In some of the previous works studying the dynamic acceptability indices [\[11,](#page-23-3) [5\]](#page-22-2), the so called normalization postulate was adopted. Here, we remove the normalization postulate, thereby opening a doorway to a much richer class of dynamic performance measures, such as the class of our dynamic limit growth indices.

In this paper we study all sorts of important properties for this new class. In particular, we provide necessary and sufficient condition for Dynamic Limit Growth Index to be a dynamic assessment index (cf. [\[4](#page-22-3)]), we study their connection with classical dynamic acceptability indices, we show how to construct examples of dynamic limit growth indices using dynamic risk measures and dynamic certainty equivalents [\[9](#page-23-4)], we propose and study a definition of time consistency.

The paper is organized as follows. In Section [2](#page-1-0) we provide a set of some underlying concepts that will be used throughout the paper. In Section [3](#page-4-0) we introduce the notion of Dynamic Limit Growth Indices (DLGI), which is the main object of study of this work. Also here, we present necessary and sufficient conditions for a DLGI to be a dynamic assessment indices. Next we show a connection between dynamic limit growth indices and dynamic acceptability indices. We conclude the section by providing several classes of functions that are DLGI. In Section [4](#page-6-0) we study the time consistency of DLGI. We propose a new definition of time consistency, and relate it to the existing literature. Finally, in Section [5](#page-7-0) we study into details the dynamic risk sensitive criterion. We prove that the dynamic risk sensitive criterion a dynamic assessment index, and study its time consistency with respect to risk-sensitivity parameter. All the proofs are deferred to the Appendix.

2 Preliminaries

Let $(\Omega, \mathcal{F}, \mathbb{F} = {\{\mathcal{F}_t\}}_{t \in \mathbb{T}}, P)$ be a filtered probability space, with $\mathbb{T} = \mathbb{N} \cup \{0\}$ and $\mathcal{F}_0 = {\{\Omega, \emptyset\}}$. For $\mathcal{G} \subseteq \mathcal{F}$ we denote by $L^0(\Omega, \mathcal{G}, P)$, $\widehat{L}^0(\Omega, \mathcal{G}, P)$ and $\overline{L}^0(\Omega, \mathcal{G}, P)$ the sets of all \mathcal{G} -measurable random variables with values in $(-\infty,\infty)$, $[-\infty,\infty)$ and $[-\infty,\infty]$, respectively. In addition, we will use the notation $L^p := L^p(\Omega, \mathcal{F}, P)$, $L^p(\mathcal{G}) := L^p(\Omega, \mathcal{G}, P)$ and L_t^p $t^p := L^p(\Omega, \mathcal{F}_t, P)$ for $p \in \{0, 1, \infty\}$. Analogous definitions will apply to \widehat{L}^0 and \overline{L}^0 . Throughout, we will use the convention that $\infty - \infty = -\infty$ and $0 \cdot \pm \infty = 0$. In particular we use this convention for \mathcal{F}_t -conditional expectation, i.e. for $X \in \overline{L}^0$, $E[X|\mathcal{F}_t] := E[X^+|\mathcal{F}_t] - E[X^-|\mathcal{F}_t]$, where $X^+ = (X \vee 0)$ and $X^- = (-X \vee 0)$, with $E[X|\mathcal{F}_t] = \lim_{n \to \infty} E[X \wedge n|\mathcal{F}_t]$, for $X \geq 0$.

Throughout this paper, $\mathcal X$ will denote either the space of random variables, i.e. L^0 , or the space of adapted processes, i.e. $\{(V_t)_{t\in\mathbb{T}} | V_t \in L_t^0\}$. For both cases we will consider standard pointwise order, understood in the almost sure sense. In what follows, we will also make use of the multiplication operator denoted as \cdot_t and defined by:

m \cdot_t V := (V_0, \dots, V_{t-1}, mV_t, mV_{t+1}, \dots),
$$

m \cdot_t X := mX,
$$
\n(2.1)

for $V \in \{(V_t)_{t\in\mathbb{T}} \mid V_t \in L_t^0\}$, $X \in L^0$ and $m \in L_t^0$. In order to ease the notation, if no confusion arises, we will drop \cdot_t from the above product, and we will simply write mV and mX instead of $m \cdot_t V$ and $m \cdot_t X$, respectively.

We note that X is not an L^0 -module [\[14](#page-23-5)], due to the definition of the multiplication \cdot_t . However, in what follows, we will adopt some concepts from L^0 -module theory, which naturally fit into our study. Specifically, let $\mathcal{K} \subseteq \mathcal{X}$ be an L_t^{∞} -convex cone, i.e. $(m_1 \cdot_t X + m_2 \cdot_t Y) \in \mathcal{K}$, for $X, Y \in \mathcal{K}$ and nonnegative $m_1, m_2 \in L_t^{\infty}$. The map $f: \mathcal{K} \to \overline{L}^0$ is:

- L_t^{∞} -local if $I_A f(X) = I_A f(I_A \cdot_t X);$
- L_t^{∞} -quasi-concave if $f(\lambda \cdot_t X + (1 \lambda) \cdot_t Y) \ge f(X) \wedge f(Y);$
- L_t^{∞} -scale invariant if $f(\beta \cdot_t X) = f(X);$
- Monotone if $X \leq Y \Rightarrow f(X) \leq f(Y)$,

for any $X, Y \in \mathcal{K}, A \in \mathcal{F}_t, \lambda, \beta \in L_t^{\infty}$ and $0 \leq \lambda \leq 1, \beta > 0$.

In what follows, we will make use of the sets V and \widetilde{V} defined, respectively, by

$$
\mathbb{V} := \left\{ (V_t)_{t \in \mathbb{T}} \mid V_t \ge 0, \ V_t \in L_t^0, \text{ and } V_t = V_{t \wedge \tau^V}, \ t \in \mathbb{T} \right\},\
$$

and

$$
\widetilde{\mathbb{V}} := \left\{ V \in \mathbb{V} \mid V_t > 0, \ln V_t \in L_t^1, \ t \in \mathbb{T} \right\},\
$$

where $\tau^V := \inf\{t \in \mathbb{T} \mid V_t = 0\}$. Note that for any $t \in \mathbb{T}$, \mathbb{V} is an L_t^{∞} -convex cone contained in $\{(V_t)_{t\in\mathbb{T}} \mid V_t \in L_t^0\}$. The elements of V can be viewed as (cumulative) value processes of portfolios of financial securities. In this paper we are primarily interested in portfolios that have integrable growth (cumulative log-return), and this is the reason why we introduced the set $\widetilde{\mathbb{V}}$.

For K equal to L⁰ or equal to V we will say that a family $\{f_t\}_{t\in\mathbb{T}}$ of mappings $f_t:\mathcal{K}\to\overline{L}_t^0$ is local, monotone, etc., if for every $t \in \mathbb{T}$ the mapping f_t is L_t^{∞} -local, monotone, etc. Moreover, if $K = L^0$ then we recall that a family $\{f_t\}_{t \in \mathbb{T}}$ of maps $f_t: L^0 \to \overline{L}^0$ is said to be:

- Cash additive if for any $t \in \mathbb{T}$ the function f_t is L_t^0 -cash additive, i.e. $f_t(X+m) = f_t(X)+m$, for any $X \in L^0$ and $m \in L_t^0$;
- *Normalized* if $f_t(0) = 0$, for any $t \in \mathbb{T}$;
- Strongly time consistent in L^1 if $f_s(X) \ge f_s(Y) \Rightarrow f_t(X) \ge f_t(Y)$, for $s, t \in \mathbb{T}, s \ge t$, $X, Y \in L^1$.
- Dynamic risk measure if $\{-f_t\}_{t\in\mathbb{T}}$ is monotone, normalized, cash additive and local;
- Dynamic certainty equivalent if there exists $U : \overline{\mathbb{R}} \to \overline{\mathbb{R}}$, U strictly increasing and continuous on \mathbb{R}^1 \mathbb{R}^1 , such that for any $X \in L^0$ and $t \in \mathbb{T}$:

$$
f_t(X) = U^{-1}(E[U(X)|\mathcal{F}_t]);
$$
\n(2.2)

• Dynamic monetary entropic utility^{[2](#page-3-1)} if there exists $\gamma \in \mathbb{R}$, such that for all $t \in \mathbb{T}$, and $X \in L^0$,

$$
f_t(X) = \begin{cases} \frac{1}{\gamma} \ln E[\exp(\gamma X)|\mathcal{F}_t] & \text{if } \gamma \neq 0\\ E[X|\mathcal{F}_t] & \text{if } \gamma = 0 \end{cases}
$$
 (2.3)

In what follows we will denote the dynamic monetary entropic utilities, with parameter γ , by $\mu^{\gamma}{}_{t\in\mathbb{T}}$;

• Dynamic assessment index for random variables if $\{f_t\}_{t\in\mathbb{T}}$ is local, monotone and quasi-concave.

On the other hand, if $K = V$ the family $\{f_t\}_{t \in \mathbb{T}}$ of maps $f_t : V \to \overline{L}^0$ is said to be:

- Translation invariant if $f_t(X + m \cdot_t I_{\{k=t\}}) = f_t(X + m \cdot_t I_{\{s=t\}})$ for $t \in \mathbb{T}$, $m \in L_t^0$, $X \in \mathbb{V}$ and $k, s \geq t$, such that $(X + m \cdot_t I_{\{k=t\}}) \in \mathbb{V}$ and $(X + m \cdot_t I_{\{s=t\}}) \in \mathbb{V}$;
- Independent of the past if $f_t(X) = f_t(X')$ for $t \in \mathbb{T}$ and all $X, X' \in \mathbb{V}$ such that $X_s = X'_s$ for any $s \ge t$;
- Dynamic assessment index for processes (DAI) if $\{f_t\}_{t\in\mathbb{T}}$ is local, monotone and quasiconcave.

Let $f_t: L^0 \to \bar{L}_t^0$, and define a mapping $\widehat{f}_t: \widehat{L}^0 \to \bar{L}_t^0$ as

$$
\widehat{f}_t(X) := \liminf_{n \to \infty} f_t\Big(X \vee (-n)\Big), \quad n \in \mathbb{N}.
$$
\n(2.4)

Clearly, for monotone f_t , one can replace liminf with lim in (2.4) . Next proposition shows that the function f_t inherits most of the properties of f_t , although generally speaking, f_t is not an extension of f_t unless it satisfies the Fatou property^{[3](#page-3-3)} (see Remark [2.2\)](#page-4-1).

²Note that (2.3) is negative of a dynamic entropic risk measure, and by analogy to 'dynamic monetary' utility function' introduced in [\[8](#page-23-6)], we use the name 'dynamic monetary entropic utility'.

³There are several versions of Fatou property in the existing literature on risk and performance measures, and we use the one from [\[3\]](#page-22-4). We say that $\{X_n\}_{n\in\mathbb{N}}$ is an L^0 -dominated sequence if there exists $Y \in L^0$ such that for all $n \in \mathbb{N}$ we have $|X_n| \leq |Y|$. Function f admitts Fatou property if for any L^0 -dominated sequence such $\{X_n\}_{n\in\mathbb{N}}$ that $X_n \xrightarrow{a.s.} X$, we have that $f(X) \geq \limsup_{n\to\infty} f_t(X_n)$.

Proposition 2.1. Let $f_t: L^0 \to \overline{L}_t^0$ be L_t^0 -local and monotone. Then

- 1) \hat{f}_t is monotone, i.e. if $X \geq Y$, then $\hat{f}_t(X) \geq \hat{f}_t(Y)$ for $X, Y \in \hat{L}^0$;
- 2) \hat{f}_t is L_t^0 -local, i.e. $I_A \hat{f}_t(X) = I_A \hat{f}_t(I_A X)$ for $A \in \mathcal{F}_t, X \in \hat{L}^0$;
- 3) If f_t is L_t^0 -cash additive and $f_t(0) \neq \infty$, then $\widehat{f}_t(X+m) = \widehat{f}_t(X) + m$, for $X \in \widehat{L}^0$, $m \in \widehat{L}_t^0;$
- 4) $f_t(X) = \hat{f}_t(X)$ for $X \in L^{\infty}$. Moreover, if f_t has the Fatou property then $f_t(X) = \hat{f}_t(X)$ for $X \in L^0$.

Remark 2.2. In general f_t might not be an extension of f_t . For $t = 0$ it is sufficient to consider the example $f_0(X) = \operatorname{ess} \operatorname{sup}(X) + \operatorname{ess} \operatorname{inf}(X)$. This function is monotone and L_0^0 -local. For $X \sim N(0, 1)$ we have $f_0(X) = \infty - \infty = -\infty$ and $f_0(X) = \liminf_{n \to \infty} (\infty - n) = \infty$.

Remark 2.3. In what follows, the function $f_t: \hat{L}_0 \to \bar{L}_t^0$ will be understood as \hat{f}_t for corresponding $f_t: L^0 \to \bar{L}_t^0$, i.e. we will drop the notation used in [\(2.4\)](#page-3-2).

3 Dynamic Limit Growth Indices

The main object studied in this paper is the Dynamic Limit Growth Index and a modification of it that are introduced below.

Definition 3.1. A *Dynamic Limit Growth Index* (DLGI) is a family $\{\varphi_t\}_{t\in\mathbb{T}}$ of mappings $\varphi_t : \mathbb{V} \to \bar{L}_t^0$ such that

$$
\varphi_t(V) = \liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T}{V_t})}{T},\tag{3.1}
$$

where $\mu_t : \hat{L}^0 \to \bar{L}_t^0$, and $\{\mu_t\}_{t \in \mathbb{T}}$ is local and monotone. We will say that DLGI is risk seeking, if additionally $\{\mu_t\}_{t\in\mathbb{T}}$ is such that $\mu_t(X) = \mu_t(X^+)$ for $t \in \mathbb{T}$ and $X \in \widehat{L}^0$.

We will often refer to $\{\mu_t\}_{t\in\mathbb{T}}$ as a family of mappings that defines DLGI. The maps introduced in Definition [3.1](#page-4-2) have a natural financial interpretation. The cumulative logreturn over the period (t, T) is a common way to measure the process growth. Because it is a random variable, we use a utility measure, say μ_t , which represents our preferences (at time t). Finally we divide the outcome by T to normalize it in time. Taking the liminf as T goes to infinity allows us to measure the long-time efficiency of our value process. We use liminf because we want to measure the actual (worst case) efficiency of our portfolio. It also makes this measure more robust (at least to losses).

We also introduce the risk seeking DLGI because it is a more suitable criterion choice for risk seeking investors. Note that if the family of mappings $\{\mu_t\}_{t\in\mathbb{T}}$ generates a DLGI, then the family of mappings $\tilde{\mu}_t(X) := \mu_t(X^+), t \in \mathbb{T}$, generates a risk seeking DLGI. A risk seeking DLGI ignores the losses in the sense that it substitutes all losses (negative log returns) by 0.

We want to use DLGI to assess performance of value processes: the greater the value of DLGI the better the performance of the portfolio. This is in line with the theory of dynamic assessment indices developed in [\[4\]](#page-22-3). Therefore, we are interested in identifying conditions under which DLGIs are DAIs. Towards this end, we provide Proposition [3.2](#page-5-0) that give sufficient and necessary conditions for DLGI to be DAI.

Proposition 3.2. Let $\{\varphi_t\}_{t\in\mathbb{T}}$ be a DLGI defined in terms of $\{\mu_t\}_{t\in\mathbb{T}}$. Then, $\{\varphi_t\}_{t\in\mathbb{T}}$ is DAI if and only if for any $t \in \mathbb{T}$, and any $V \in \mathbb{V}$,

$$
\liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T}{V_t})}{T} = \liminf_{T \to \infty} \frac{\mu_t(\ln V_T)}{T}.
$$
\n(3.2)

Relation (3.2) says that the value of the DLGI at time t is independent of the value of the process V at time t. As mentioned above, the purpose of DLGI is to measure the long term growth of V , which intuitively should not depend on the current state.

Remark 3.3. An equivalent formulation of condition [\(3.2\)](#page-5-1) is to require that for any $t \in \mathbb{T}$, $m \in L_t^0$ and $\{X_T\}_{T \in \mathbb{N}}$ such that $X_T \in \widehat{L}^0$ we have that

$$
\liminf_{T \to \infty} \frac{\mu_t(X_T + m)}{T} = \liminf_{T \to \infty} \frac{\mu_t(X_T)}{T}.
$$

In particular, this will be satisfied if there exists a family of maps $f_t: L_t^0 \to L_t^0$ such that for all $X \in \widehat{L}^0$, $|\mu_t(X+m) - \mu_t(X)| \leq f_t(m)$ on the set $\{\mu_t(X) \neq \pm \infty\}$, and $\mu_t(X+m) = \mu_t(X)$ on $\{\mu_t(X) = \pm \infty\}$. For example, if μ_t is cash-additive then $f_t(m) = |m|$ (see also Proposition [3.6\)](#page-6-1).

Corollary 3.4. Let $\{\mu_t\}_{t\in\mathbb{T}}$ be local and monotone, and let $\{\varphi_t\}_{t\in\mathbb{T}}$ be a DLGI generated by $\{\mu_t\}_{t\in\mathbb{T}}$. Then $\{\varphi_t\}_{t\in\mathbb{T}}$ is adapted, local, scale invariant and independent of the past. Moreover, if $\{\mu_t\}_{t\in\mathbb{T}}$ satisfies [\(3.2\)](#page-5-1), then $\{\varphi_t\}_{t\in\mathbb{T}}$ is monotone, quasi-concave and translation invariant.

Remark 3.5. Thus, by Corollary [3.4,](#page-5-2) any DLGI that is generated by $\{\mu_t\}_{t\in\mathbb{T}}$ which admits representation [\(3.2\)](#page-5-1) fulfils all core conditions of Dynamic Acceptability Index introduced in [\[5](#page-22-2)] (except of time consistency and positiveness), and for static case introduced in [\[11\]](#page-23-3). Recall that Dynamic Acceptability Indices are measures of performance, and hence, DLGI can be seen as a dynamic measure of performance of a given value process. Similar remark applies to DLGIs defined as $[\varphi_t(V)]^+$. It should be mentioned that this class of maps is not normalized in the sense of $[11]^4$ $[11]^4$.

Next we will show that DLGIs that are also DAIs could be easily generated through dynamic risk measures or dynamic certainty equivalents, as shown in the next two propositions.

⁴i.e. $\varphi_t(V) = \infty$, if $V \ge 0$ and $\varphi_t(V) = 0$, if $V < 0$.

Proposition 3.6. For any dynamic risk measure $\{\rho_t\}_{t\in\mathbb{T}}$, the family $\{-\rho_t\}_{t\in\mathbb{T}}$ is local, monotone (hence generates a DLGI) and satisfies condition [\(3.2\)](#page-5-1). Moreover, if $\{\tilde{\rho}_t\}_{t\in\mathbb{T}}$ is given by $\widetilde{\rho}_t(X) = \rho_t(X^+)$, then $\{-\widetilde{\rho}_t\}_{t\in\mathbb{T}}$ is also local, monotone and satisfies condition [\(3.2\)](#page-5-1).

Proposition 3.7. Let $\{\mu_t\}_{t\in\mathbb{T}}$ be a dynamic certainty equivalent. Then, $\{\mu_t\}_{t\in\mathbb{T}}$ is local and monotone (and hence generates a $DLGI$). Moreover, if additionally U from (2.2) is bi-Lipschitz on $\mathbb R$ (i.e. U and U^{-1} are Lipschitz^{[5](#page-6-2)}.), then $\{\mu_t\}_{t\in\mathbb T}$ satisfies [\(3.2\)](#page-5-1).

Corollary 3.8. By Proposition [3.6](#page-6-1) and Proposition [3.2,](#page-5-0) any DLGI generated by $\mu_t = -\rho_t$, $t \in \mathbb{T}$, with $\{\rho_t\}_{t \in \mathbb{T}}$ being a dynamic risk measure, is a DAI (for processes).

4 Time consistency of DLGIs

One of the key properties in the theory of dynamic risk measures and dynamic performance measures is the dynamic time consistency property. For risk measures, this property is usually associated with dynamic programming principle (see for instance the review paper [\[1\]](#page-22-5)), however as shown in [\[5\]](#page-22-2) the time consistency for dynamic acceptability indices is of different nature. As we have mentioned in Remark [3.5,](#page-5-4) the family of DLGIs is scale-invariant and thus closely related to the latter. Because of that we introduce the concept of time consis-tency related to the one introduced in [\[5\]](#page-22-2). As above, $\mathcal X$ will denote the space of random variables L^0 or adapted processes $\{(V_t)_{t\in\mathbb{T}} | V_t \in L_t^0\}$, and $\mathcal{K} \subseteq \mathcal{X}$. We are now ready to propose a definition of time consistency.

Definition 4.1. We will say that a family $\{f_t\}_{t\in\mathbb{T}}$ of maps $f_t: \mathcal{X} \to \bar{L}_t^0$ is supermartingale time consistent in K if

$$
f_s(X) \ge m_s \quad \Longrightarrow \quad f_t(X) \ge E[m_s|\mathcal{F}_t],\tag{4.1}
$$

for all $s, t \in \mathbb{T}$ such that $s > t \geq 0$, $X \in \mathcal{K}$ and $m_s \in \overline{L}_s^0$. Respectively, we say that $\{f_t\}_{t \in \mathbb{T}}$ is submartingale time consistent in K if

$$
f_s(X) \le m_s \quad \Longrightarrow \quad f_t(X) \le E[m_s|\mathcal{F}_t],\tag{4.2}
$$

for all $s, t \in \mathbb{T}$ such that $s > t \geq 0$, $X \in \mathcal{K}$ and $m_s \in \overline{L}_s^0$.

Remark 4.2. The terminology supermatingale/submartingale time consistent is motivated in Proposition [4.3](#page-7-1) below.

If we only consider $m_s \in \bar{L}_t^0$ in [\(4.1\)](#page-6-3) and in [\(4.2\)](#page-6-4) then we get essentially the definition of time consistency for dynamic acceptability indices introduced in [\[5](#page-22-2)], which shows that our definition is slightly stronger. Moreover, for $m_s \in \bar{L}_t^0$ and $\{f_t\}_{t \in \mathbb{T}}$ being a dynamic risk measure the definition of submartingale time consistency [\(4.2\)](#page-6-4) is equivalent to the concept of weak time consistency introduced in [\[1\]](#page-22-5). Hence, our definition of submartingale time

⁵Although U is defined on $\overline{\mathbb{R}}$, we require U to be bi-Lipschitz only on \mathbb{R}

consistency is stronger than the definition of weak time consistency (for random variables) studied in [\[1\]](#page-22-5). On the other hand, submartingale time consistency does not imply nor is implied by strong time consistency. For example, the negative of Dynamic Average Value at Risk is submartingale time consistent but not strongly time consistent [\[12](#page-23-7)]. On the contrary, the monetary entropic utility is strongly time consistent but it is not submartingale time consistent for $\gamma > 0$, see Proposition [5.3.](#page-8-0) Analogous reasonings apply with regard to supermartingale time consistency.

The following proposition shows that our definitions of supermartingale/submartingale time consistency can be characterised in terms of supermartingale/submartingale property.

Proposition 4.3. Let $\{f_t\}_{t\in\mathbb{T}}$ be a family of maps $f_t: \mathcal{X} \to \overline{L}_t^0$. Then

- 1) $\{f_t\}_{t\in\mathbb{T}}$ is supermartingale time consistent in K if and only if $\{f_t\}_{t\in\mathbb{T}}$ is a supermartingale in K, i.e. $f_t(X) \ge E[f_s(X)|\mathcal{F}_t]$ for all $X \in \mathcal{K}$ and $s, t \in \mathbb{T}$ such that $s > t \ge 0$.
- 2) $\{f_t\}_{t\in\mathbb{T}}$ is submartingale time consistent in K if and only if $\{f_t\}_{t\in\mathbb{T}}$ is a submartingale in K, i.e. $f_t(X) \le E[f_s(X)|\mathcal{F}_t]$ for all $X \in \mathcal{K}$ and $s, t \in \mathbb{T}$ such that $s > t \ge 0$.

We close this section with an intuitive interpretation of our definitions of time consistency. As time evolves, the information about the value process increases in the sense that $\mathcal{F}_t \subseteq \mathcal{F}_s$, for $t \leq s$. Thus, if the index is submartingale time consistent, then one would expect that the additional information will have positive impact on the (conditional) mean value of the index, in the sense that the projection of the future value of the index on the currently available information is no less that the current value of the index. This indeed is confirmed by property 2) in Proposition [4.3.](#page-7-1) On the other hand supermartingale time consistency yields that the impact of the additional information is negative on average. Refer to examples [\(5.2\)](#page-9-0), [\(A.31\)](#page-21-0) and [\(A.30\)](#page-21-1) for more insight.

5 Dynamic Risk Sensitive Criterion

Dynamic analog of Risk Sensitive Criterion [\[6\]](#page-22-1), that we study in this section, is one of the most notable examples of DLGI.

Definition 5.1. A Dynamic Risk Sensitive Criterion is a family $\{\varphi_t^{\gamma}\}$ $\{t\}_{t\in\mathbb{T}}$ of mappings φ_t^γ $t^{\gamma}: \mathbb{V} \to \bar{L}^0_t$, indexed by $\gamma \in \mathbb{R}$, and defined by

$$
\varphi_t^{\gamma}(V) = \begin{cases} \liminf_{T \to \infty} \frac{1}{T} \frac{1}{\gamma} \ln E[V_T^{\gamma} | \mathcal{F}_t] & \text{if } \gamma \neq 0, \\ \liminf_{T \to \infty} \frac{1}{T} E[\ln V_T | \mathcal{F}_t] & \text{if } \gamma = 0. \end{cases}
$$
(5.1)

Remark 5.2. It is well known (cf. [\[13\]](#page-23-8), and references therein) that for some processes V that are Markovian, the value of φ_t^{γ} $t(t)$ is constant (independent of t in particular). In such cases of course, the analysis carried below trivialises. For example, let $V \in V$ be such that $V_0 > 0$ and $V_t = V_0 \exp(\sum_{i=1}^t X_i)$, where $\{X_t\}_{t\in\mathbb{T}}$ is adapted, X_t is independent of \mathcal{F}_{t-1} and $X_t \sim \mathcal{N}(0, 1)$. In this case, φ_t^{γ} $t^{\gamma}(V) \equiv \frac{\gamma}{2}$ $\frac{\gamma}{2}$. Nevertheless, the class of processes V, for which φ_t^γ $t^{\gamma}(V)$ is a non-constant process, is quite rich; see e.g. [\(5.2\)](#page-9-0) and [\(A.31\)](#page-21-0).

We say that the Dynamic Risk Sensitive Criterion is risk-averse if $\gamma < 0$, risk neutral if $\gamma = 0$, and risk-seeking if $\gamma > 0$. Please note that with $t = 0$ we get the standard definition of (static) Risk Sensitive Criterion [\[6](#page-22-1)]; in particular, when $\gamma = 0$, the Risk Sensitive Criterion is called the Kelly criterion.

In order to proceed, we first need to recall some facts about Dynamic Monetary Entropic Utilities.

Proposition 5.3. Let $\{\mu_t^{\gamma}\}$ $t^γ$ _t \in ^T be a dynamic monetary entropic utility with $γ \in \mathbb{R}$. Then

- 1) $\{\mu_t^{\gamma}$ $\{t_i^{\gamma}\}_{t\in\mathbb{T}}$ is a dynamic certainty equivalent;
- 2) $\{\mu_t^{\gamma}$ $\{^\gamma_t\}_{t\in\mathbb{T}}$ is strongly time consistent in $L^1;$
- 3) $\{\mu_t^{\gamma}$ $\{t\}_{t\in\mathbb{T}}$ is increasing with γ in L^1 ;
- 4) if $\gamma \geq 0$, then $\{\mu_t^{\gamma}\}$ $t^{\gamma}\}_{t\in\mathbb{T}}$ is supermartingale time consistent in $L^1;$
- 5) if $\gamma \leq 0$, $\{\mu_t^{\gamma}\}$ $t^{\gamma}\}_{t\in\mathbb{T}}$ is submartingale time consistent in $L^1.$

For the proof of [1\)](#page-8-1), see e.g. [\[16](#page-23-9)]; the proof in [\[16\]](#page-23-9) is given for the case of L^{∞} , but can be adapted to the case of L^0 . For the proof of [2\)](#page-8-2), we first need to recall that the dynamic entropic risk measure is upper-semicontinuous in L^1 (cf. [\[3](#page-22-4), [10](#page-23-10)]), and then refer to [\[4\]](#page-22-3). For the proof of [3\)](#page-8-3), we need to recall that the robust representation of dynamic entropic risk measures holds in the L^1 framework [\[10\]](#page-23-10), and then refer to [\[16](#page-23-9)]. Properties [4\)](#page-8-4) and [5\)](#page-8-5) follow directly from property [3\)](#page-8-3), combined with dynamic programming reformulation of property [2\)](#page-8-2); see [\[1\]](#page-22-5) and [\[12](#page-23-7), Proposition 6], where the proofs are done for the case of L^{∞} , but can be adapted to the case of L^1 .

We are now ready to present the main result of this section. Arguably, properties 5) and 6) stated in Theorem [5.4](#page-8-6) are the most interesting ones.

Theorem 5.4. Let $\gamma \in \mathbb{R}$ and let $\{\varphi_t^{\gamma}\}$ \hat{t}^{γ}_{t} _{t∈}T be a Dynamic Risk Sensitive Criterion. Then

- 1) $\{\varphi_t^{\gamma}\}$ $\{t\}_{t\in\mathbb{T}}$ is DLGI generated by $\{\mu_t^{\gamma}\}$ $_t^\gamma\}_{t\in\mathbb{T}}$;
- 2) $\{\varphi_t^{\gamma}\}$ $_{t}^{\gamma}\}_{t\in\mathbb{T}}$ is DAI;
- 3) if $\gamma > 0$, then φ_t^{γ} $\left[\begin{matrix} \gamma \\ t \end{matrix}\right]^+$ is a risk seeking DLGI.
- 4) $\{\varphi_t^{\gamma}\}$ $\{t\}_{t\in\mathbb{T}}$ is increasing with γ in $\widetilde{\mathbb{V}}$;
- 5) if $\gamma > 0$, then $\{\varphi_t^{\gamma}\}$ $t^{\gamma}\}_{t\in\mathbb{T}}$ is supermartingale time consistent in $\widetilde{\mathbb{V}}$;
- 6) if $\gamma < 0$, then $\{\varphi_t^{\gamma}\}$ $t^{\gamma}\}_{t\in\mathbb{T}}$ is submartingale time consistent in $\widetilde{\mathbb{V}}$.

Next we will show that properties 3, 5 and 6 from Theorem 5.4 are in fact necessary and sufficient conditions in case of a large class of filtered probability spaces.

Proposition 5.5. If $(\Omega, \mathcal{F}, \mathbb{F}, P)$ contains a subspace isomorphic to $([0, 1], \mathcal{B}([0, 1]), \{\mathcal{H}\}_{t \in \mathbb{T}}, \lambda)$, where λ is the Borel measure, \mathcal{H}_0 is trivial, $\mathcal{H}_1 = \mathcal{B}([0,1])$ and $\mathcal{H}_1 = \mathcal{H}_2 = \ldots$, then prop-erties 3), 5) and 6) from Theorem [5.4](#page-8-6) become if and only if conditions, i.e.

3') if $\gamma \leq 0$, then $\lceil \varphi_t^{\gamma} \rceil$ $\left.\begin{array}{c} \gamma \ \gamma(t')\end{array}\right]^+$ is not a risk seeking DLGI;

- 5') if $\gamma \leq 0$, then $\{\varphi_t^{\gamma}\}$ $t^{\gamma}_t\}_{t\in\mathbb{T}}$ is not supermartingale time consistent in $\widetilde{\mathbb{V}}$;
- 6') if $\gamma \geq 0$, then $\{\varphi_t^{\gamma}\}$ $t^{\gamma}\}_{t\in\mathbb{T}}$ is not submartingale time consistent in $\widetilde{\mathbb{V}}.$

Remark 5.6. In particular, Proposition [5.5](#page-9-1) is true for a standard filtered probability space.^{[6](#page-9-2)}

We conclude this section by presenting an example that is related to properties $4, 5$ $4, 5$ $4, 5$ and 6 .

Example 5.7. Let $([0,1], \mathcal{B}([0,1]), \{\mathcal{F}_t\}_{t \in \mathbb{N}_0}, P)$ be a filtered probability space, where P is the standard Lebesgue measure, \mathcal{F}_0 is trivial and $\mathcal{F}_t = \sigma(K_t^1, \ldots, K_t^{2^t})$ t^{2t} , where $K_t^i := \left[\frac{2(i-1)}{2^{t+1}}, \frac{2i}{2^{t+1}}\right]$ $\frac{2i}{2^{t+1}}$. Let $X(\omega) = \omega$ for $\omega \in [0, 1]$, and let $\{\widehat{V}_T\}_{T \in \mathbb{N}_0}$ be defined by

$$
\widehat{V}_T(\omega) = e^{TE[X|\mathcal{F}_T](\omega)}.
$$
\n(5.2)

We will derive explicit formula for the dynamic risk sensitive criterion φ_t^{γ} \tilde{t} . We start with the case of $\gamma = -1$. For fixed $t \in \mathbb{N}_0$, we get

$$
\varphi_t^{-1}(\widehat{V}) = \liminf_{T \to \infty} \frac{-1}{T} \ln E[e^{-TE[X|\mathcal{F}_T]} | \mathcal{F}_t] = \liminf_{T \to \infty} (-1) \ln E[(e^{-E[X|\mathcal{F}_T]})^T | \mathcal{F}_t]^{1/T}.
$$

Next for $\omega \in K_t^i$ and $T \in \mathbb{T}$, noting that $E[(e^{-E[X|\mathcal{F}_T]})^T | \mathcal{F}_t]^{1/T}(\omega)$ is in fact a power mean, we obtain

$$
\limsup_{T \to \infty} E[(e^{-E[X|\mathcal{F}_T]})^T |\mathcal{F}_t]^{1/T}(\omega) \le \limsup_{T \to \infty} [\text{ess}\sup_{\omega \in K_t^i} (e^{-E[X|\mathcal{F}_T](\omega)})] \le \text{ess}\sup_{\omega \in K_t^i} e^{-X(\omega)} = e^{-\frac{2(i-1)}{2^{t+1}}}.
$$
\n(5.3)

On the other hand using Jensen inequality, for any $T_0 \in \mathbb{T}$, such that $T_0 > t$, we get

$$
\limsup_{T \to \infty} E[(e^{-E[X|\mathcal{F}_T]})^T |\mathcal{F}_t]^{1/T}(\omega) = \limsup_{T \to \infty} E[E[e^{-TE[X|\mathcal{F}_T]} |\mathcal{F}_{T_0}]|\mathcal{F}_t]^{1/T}(\omega)
$$
\n
$$
\geq \limsup_{T \to \infty} E[e^{-TE[E[X|\mathcal{F}_T]|\mathcal{F}_{T_0}]} |\mathcal{F}_t]^{1/T}(\omega)
$$
\n
$$
= \limsup_{T \to \infty} E[(e^{-E[X|\mathcal{F}_{T_0}]})^T |\mathcal{F}_t]^{1/T}(\omega)
$$
\n
$$
= \operatorname{ess} \sup_{\omega \in K_t^i} e^{-E[X|\mathcal{F}_{T_0}]} = e^{-\left(\frac{2(i-1)}{2^{i+1}} + \frac{1}{2^{T_0+1}}\right)}. \tag{5.4}
$$

Letting $T_0 \to \infty$, and combining [\(5.3\)](#page-9-3) with [\(5.4\)](#page-9-4), we conclude that for $\omega \in K_t^i$,

$$
\varphi_t^{-1}(\widehat{V})(\omega) = (-1) \ln e^{-\frac{2(i-1)}{2^{t+1}}} = \frac{2(i-1)}{2^{t+1}}.
$$

⁶i.e. the spaces which are isomorphic to $([0,1]^{\mathbb{N}_0}, \mathcal{B}([0,1]^{\mathbb{N}_0}), \{\mathcal{F}_t'\}_{t \in \mathbb{N}_0}, \lambda^{\mathbb{N}^0}),$ where $\mathcal B$ is the Borel σ algebra, $\lambda^{\mathbb{N}_0}$ is a product of the Borel measures and $\{\mathcal{F}'_t\}_{t\in\mathbb{N}_0}$ is the filtration generated by the coordinate functions (cf. [\[16](#page-23-9)]).

Using similar computations, it is easy to show that, for $\gamma \in \mathbb{R}$ and $\omega \in K_t^i$, we have

$$
\varphi_t^{\gamma}(\widehat{V})(\omega) = \begin{cases} \frac{2(i-1)}{2^{t+1}} & \gamma < 0, \\ \frac{2(i-1)+2i}{2^{t+2}} & \gamma = 0, \\ \frac{2i}{2^{t+1}} & \gamma > 0. \end{cases}
$$

Now, it clear from the above formula that φ_t^{γ} $t^{\gamma}(V)$ is increasing in γ , so that property 4) is fulfilled. In addition, one can easily check that process φ_t^{γ} $t^{\gamma}(V)$ is a submartingale (resp. supermartingale), with respect to the filtration $\{\mathcal{F}_t\}_{t\in\mathbb{N}_0}$, when $\gamma < 0$ (resp. $\gamma > 0$).

It is interesting to note that the values of φ_t^{γ} $t^{\gamma}(V)$ are separated into three regimes: riskseeking ($\gamma > 0$), risk-neutral ($\gamma = 0$) and risk-averse ($\gamma < 0$).

A Appendix

Proof of Proposition [2.1.](#page-4-3) Let $f_t: L^0 \to \overline{L}_t^0$ be local and monotone.

1) Monotonicity follows immediately.

2) As for locality, we have

$$
I_A \hat{f}_t(I_A X) = I_A \lim_{n \to \infty} f_t \Big((I_A X) \vee (-n) \Big) = I_A \lim_{n \to \infty} f_t \Big(I_A (X \vee (-n)) \Big)
$$

=
$$
\lim_{n \to \infty} I_A f_t \Big(I_A (X \vee (-n)) \Big) = \lim_{n \to \infty} I_A f_t \Big(X \vee (-n) \Big) = I_A \lim_{n \to \infty} f_t \Big(X \vee (-n) \Big)
$$

=
$$
I_A \hat{f}_t(X),
$$

where we use appropriately the convention $0 \cdot \infty = 0$.

3) Assume that f_t is cash additive and let $X \in \widehat{L}^0(\Omega, \mathcal{F}, P)$. First, we will prove cash additivity of \hat{f}_t for $m \in L_t^0$. We know that

$$
\widehat{f}_t(X+m) = \lim_{n \to \infty} f_t\Big((X+m) \vee (-n)\Big) = \lim_{n \to \infty} f_t\Big(X \vee (-n-m) + m\Big)
$$

$$
= \lim_{n \to \infty} f_t\Big(X \vee (-n-m)\Big) + m.
$$

Thus, it is enough to show that

$$
\widehat{f}_t(X) = \lim_{n \to \infty} f_t\Big(X \vee (-n - m)\Big). \tag{A.1}
$$

For any $k \in \mathbb{N}$, we have that

$$
\mathcal{I}_{\{-k < m < k\}}\Big[X \vee (-n - k)\Big] \leq \mathcal{I}_{\{-k < m < k\}}\Big[X \vee (-n - m)\Big] \leq \mathcal{I}_{\{-k < m < k\}}\Big[X \vee (-n + k)\Big].
$$

Due to L_t^{∞} -locality of f_t , we get that

$$
I_{\{-k < m < k\}}\hat{f}_t(X) = I_{\{-k < m < k\}}\lim_{n \to \infty} f_t\Big(X \vee (-n-m)\Big).
$$

Since $m \in L_t^0$, we have that $P[\{-k < m < k\}] \to 1$ as $k \to \infty$ which proves the equality $(A.1).$ $(A.1).$

Now, let $m \in \widehat{L}^0(\Omega, \mathcal{F}, P)$. Using the above result, and because of locality of \hat{f}_t and the fact that $I_{\{m>-\infty\}}m \in L_t^0$, we deduce that

$$
I_{\{m>-\infty\}}\hat{f}_t(X+m) = I_{\{m>-\infty\}}(\hat{f}_t(X)+m).
$$

On the other hand

$$
I_{\{m=-\infty\}}\hat{f}_t(X+m) = I_{\{m=-\infty\}}\lim_{n\to\infty} f_t((-\infty) \vee (-n)) = I_{\{m=-\infty\}}\lim_{n\to\infty} (f_t(0)-n)
$$

= $I_{\{m=-\infty\}}(-\infty) = I_{\{m=-\infty\}}(\hat{f}_t(X)+m).$

Combining those above two equalities, cash-additivity of \hat{f}_t follows immediately.

4) If $X \in L^{\infty}$, then there exists $n \in \mathbb{N}$ such that $X \vee (-n) = X$ which concludes the proof. Now let $X \in L^0$ and let us assume that f_t has the Fatou property. Put $X_n := X \vee (-n)$ for $n \in \mathbb{N}$. The sequence $\{X\}_{n\in\mathbb{N}}$ is L^0 - dominated by X. Moreover $X_n \xrightarrow{a.s.} X$. Hence, we have that

$$
\widehat{f}_t(X) = \lim_{n \to \infty} f_t(X_n) \le \limsup_{n \to \infty} f_t(X_n) \le f_t(X) \le \lim_{n \to \infty} f_t(X_n) = \widehat{f}_t(X),
$$

where the last inequality is the consequence of the fact that for any $n \in \mathbb{N}$ we have $X \leq X_n$, which implies $f_t(X) \leq f_t(X_n)$. \Box

Proof of Proposition [3.2.](#page-5-0) Let $\{\varphi_t\}_{t\in\mathbb{T}}$ be DLGI generated by $\{\mu_t\}_{t\in\mathbb{T}}$, and thus $\{\mu_t\}_{t\in\mathbb{T}}$ is local and monotone.

(←) Let $\{\mu_t\}_{t\in\mathbb{T}}$ satisfy [\(3.2\)](#page-5-1), and we will show that $\{\varphi_t\}_{t\in\mathbb{T}}$ is a DAI.

Monotonicity is straightforward. Let $V, V' \in V$, such that $V \geq V'$. We will show that $\varphi_t(V) \geq \varphi_t(V')$ for any $t \in \mathbb{T}$. Consider $t, T \in \mathbb{T}$, such that $T \geq t$. Since $V_T \geq V'_T$, we have that $\ln V_T \geq \ln V'_T$, and consequently $\frac{\mu_t(\ln V_T)}{T} \geq \frac{\mu_t(\ln V'_T)}{T}$ $\frac{\ln v_T}{T}$, for any $T \geq t$. Hence,

$$
\liminf_{T \to \infty} \frac{\mu_t(\ln V_T)}{T} \ge \liminf_{T \to \infty} \frac{\mu_t(\ln V'_T)}{T}.
$$

Next we prove locality. Let us fix $t \in \mathbb{T}$ and $A \in \mathcal{F}_t$. For $T \geq t$, using locality of μ_t and the convention $0 \cdot \infty = 0$, we deduce

$$
\mathbf{1}_A \varphi_t (\mathbf{1}_A \cdot_t V) = \mathbf{1}_A \liminf_{T \to \infty} \frac{\mu_t (\ln \mathbf{1}_A V_T)}{T} = \liminf_{T \to \infty} \frac{\mathbf{1}_A \mu_t (\ln \mathbf{1}_A V_T)}{T}
$$

=
$$
\liminf_{T \to \infty} \frac{\mathbf{1}_A \mu_t (\mathbf{1}_A \ln \mathbf{1}_A V_T)}{T} = \liminf_{T \to \infty} \frac{\mathbf{1}_A \mu_t (\mathbf{1}_A \ln V_T + \mathbf{1}_A \ln \mathbf{1}_A)}{T}
$$

=
$$
\liminf_{T \to \infty} \frac{\mathbf{1}_A \mu_t (\mathbf{1}_A \ln V_T)}{T} = \liminf_{T \to \infty} \frac{\mathbf{1}_A \mu_t (\ln V_T)}{T} = \mathbf{1}_A \varphi_t (V).
$$

Finally, let us prove quasiconcavity. Let $t \in \mathbb{T}$, $V, V' \in \mathbb{V}$ and $\lambda \in L_t^0$, $0 \leq \lambda \leq 1$. Without loss of generality, due to locality of μ_t , we assume that $0 < \lambda < 1$. Since log is monotone, and $V, V' \geq 0$, we have

$$
\varphi_t(\lambda \cdot_t V + (1 - \lambda) \cdot_t V') = \liminf_{T \to \infty} \frac{\mu_t(\ln[\lambda V_T + (1 - \lambda)V'_T])}{T}
$$

\n
$$
\geq \liminf_{T \to \infty} \left[\min \left\{ \frac{\mu_t(\ln \lambda V_T)}{T}, \frac{\mu_t(\ln(1 - \lambda)V'_T)}{T} \right\} \right]
$$

\n
$$
= \min \left(\liminf_{T \to \infty} \frac{\mu_t(\ln V_T) + \ln \lambda}{T}, \liminf_{T \to \infty} \frac{\mu_t(\ln V'_T) + \ln(1 - \lambda)}{T} \right)
$$

\n
$$
= \varphi_t(V) \wedge \varphi_t(V'),
$$

which completes this part of the proof.

(⇒) Assume that $\{\varphi_t\}_{t\in\mathbb{T}}$ is a DAI. Let $t \in \mathbb{T}$, $V \in \mathbb{V}$, and define $V_s' = V_s$ for $s \neq t$, and $V'_t = \min(1, V_t)$. Note that $V' \in \mathbb{V}$, and $V \geq V'$. By monotonicity of φ_t , we get

$$
\liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T}{V_t})}{T} \ge \liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T'}{V_t'})}{T},
$$

and due to L_t^0 -locality of μ_t , we continue

$$
1_{\{V_t \geq 1\}} \liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T}{V_t})}{T} \geq 1_{\{V_t \geq 1\}} \liminf_{T \to \infty} \frac{\mu_t(1_{\{V_t \geq 1\}} \ln \frac{V_T'}{V_t'})}{T}.
$$

Next, since $V'_t = 1$ on the set $\{V_t \geq 1\}$, we have

$$
1_{\{V_t \ge 1\}} \liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T}{V_t})}{T} \ge 1_{\{V_t \ge 1\}} \liminf_{T \to \infty} \frac{\mu_t(1_{\{V_t \ge 1\}} \ln V'_T)}{T},
$$

and since $V_T = V'_T$ for $T > t$, we finally conclude

$$
1_{\{V_t \geq 1\}} \liminf_{T \to \infty} \frac{\mu_t(\ln \frac{V_T}{V_t})}{T} \geq 1_{\{V_t \geq 1\}} \liminf_{T \to \infty} \frac{\mu_t(\ln V_T)}{T}.
$$

Note that $1_{\{V_t \geq 1\}} \ln \frac{V_T}{V_t} \leq 1_{\{V_t \geq 1\}} \ln V_T$ for $T > t$. By monotonicity of μ_t , we get

Proof of Proposition [3.6.](#page-6-1) Let $\{\rho_t\}_{t\in\mathbb{T}}$ be a dynamic risk measure. Monotonicity and locality of $\{-\rho_t\}_{t\in\mathbb{T}}$ follow directly from the definition of dynamic risk measures. Let us fix $t \in \mathbb{T}$. First we will prove that condition [\(3.2\)](#page-5-1) is satisfied by $\{-\rho_t\}_{t\in\mathbb{T}}$. For $V \in \mathbb{V}$, we have

\liminf_{T \to \infty} \frac{-\rho_t(\ln \frac{V_T}{V_t})}{T} = \liminf_{T \to \infty} \frac{-\rho_t(\ln V_T) - \ln V_t}{T} = \liminf_{T \to \infty} \frac{-\rho_t(\ln V_T)}{T}.

Next, monotonicity and locality of $\{-\widetilde{\rho}_t\}_{t\in\mathbb{T}}$ is straightforward. = \liminf_{T \to \infty} \frac{-\rho_t(I_{\{V_T > V_t\}} \ln V_T - I_{\{V_T > V_t\}} \ln V_t)}{T}.
$$

Also, one can easily deduce the following inequalities

I_{\{V_T > 1\}} \ln V_T - 2|\ln V_t| \le I_{\{V_T > V_t\}} \ln V_T - I_{\{V_T > V_t\}} \ln V_t \le I_{\{V_T > 1\}} \ln V_T + |\ln V_t|.

From the above, and monotonicity of the dynamic risk measure, we get

Since $-\rho_t$ is cash additive, continue

\liminf_{T \to \infty} \frac{-\rho_t([\ln V_T]^+ \pm 2|\ln V_t|)}{T} = \liminf_{T \to \infty} \frac{-\rho_t([\ln V_T]^+) \pm 2|\ln V_t|}{T} = \liminf_{T \to \infty} \frac{-\rho_t([\ln V_T]^+)}{T},
$$

which concludes the proof.

Proof of Proposition [3.7](#page-6-5). Let $\{\mu_t\}_{t\in\mathbb{T}}$ be a dynamic certainty equivalent defined as in (2.2) , with U being a continuous an increasing function. Clearly μ_t is \mathcal{F}_t -measurable.

Monotonicity is straightforward. Let us fix $t \in \mathbb{T}$. Let $X, Y \in \widehat{L}^0$, $X \ge Y$. Because U is increasing transform we get $U(X) \ge U(Y)$, and $E[U(X)|\mathcal{F}_t] \ge E[U(Y)|\mathcal{F}_t]$. Now, U^{-1} is also an increasing function, so $U^{-1}(E[U(X)|\mathcal{F}_t]) \geq U^{-1}(E[U(Y)|\mathcal{F}_t]).$

Finally we will prove the second part of the Proposition [3.7.](#page-6-5) Let U be a bi-Lipschitz function with $L_U \in \mathbb{R}$ and $L_{U^{-1}} \in \mathbb{R}$ being the corresponding Lipschitz constants. From now on we make a (reasonable) assumption that $P[V_t > 0] > 0$, which due to locality of μ_t , allows us to assume that $P[V_t > 0] = 1$.

= E[1_{B \cap \{V_T > \frac{1}{n_0}\}} U(\ln \frac{1}{n_0}) + 1_{B \cap \{V_T \le \frac{1}{n_0}\}} U(-\infty)]
$$

\n
$$
> E[1_B U(-\infty)]. \tag{A.6}
$$

Inequality $(A.6)$ jointly with the definition of B leads to contradiction with the assumption that $P(B) > 0$, which verifies that $(A.4)$ is true. The proof of $(A.5)$ is analogous, since $P(V_t > 0) = 1.$

Case b) It is enough to show that

\{E[U(\ln V_T)|\mathcal{F}_t] = -\infty\} = \{E[U(\ln \frac{V_T}{V_t})|\mathcal{F}_t] = -\infty\}.

Now, because U is Lipschitz and $V_t > 0$, then, on the set $\{V_T > 0\}$ we get

$$

Combining [\(A.2\)](#page-14-0) and [\(A.11\)](#page-15-2) we obtain $\mu_t(\ln V_T) = \mu_t(\ln \frac{V_T}{V_t})$, on \mathcal{F}_t -measurable set $K_T^- \cup K_T^+$. On the set $(K_T^- \cup K_T^+)$ $(T_T^+)^c$ we get $|\mu_t(\ln V_T)| < \infty$ and $|\mu_t(\ln \frac{V_T}{V_t})| < \infty$. We are now finally ready to prove the main statement. Let

K^- := \{ \omega \in \Omega : \sum_{T \in \mathbb{T}} 1_{K^-_T}(\omega) < \infty \}, \quad K^+ := \{ \omega \in \Omega : \sum_{T \in \mathbb{T}} 1_{(K^+_T)^c}(\omega) = \infty \}.

Using [\(A.12\)](#page-15-3), on the set $K^- \cap K^+$ we obtain

= \liminf_{T \to \infty} \frac{1}{T} \frac{1}{\gamma} \ln E\Big[\frac{\max(V_T, V_t)^\gamma}{V_t^\gamma} |\mathcal{F}_t\Big] = \liminf_{T \to \infty} \Big[\frac{1}{T} \frac{1}{\gamma} \ln E[\max(V_T, V_t)^\gamma |\mathcal{F}_t] - \frac{1}{T} \ln V_t\Big]
$$
\n
$$
= \liminf_{T \to \infty} \frac{1}{T} \frac{1}{\gamma} \ln E[\max(V_T, V_t)^\gamma |\mathcal{F}_t]. \tag{A.15}
$$

 \Box

Using the above, and the fact that $V_T \le \max(V_T, V_t)$, and μ_t^{γ} $t^{\gamma}(\left[\ln \frac{V_T}{V_t}\right]^+) \geq 0$, for all $V \in \mathbb{V}$, we have the following inequality

Since, $E[V_T^{\gamma}]$ $T_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}}$ is non-negative for every $T \in \mathbb{T}$, by Fatou lemma, we conclude

$$
\liminf_{T \to \infty} E\big[E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}}|\mathcal{F}_t\big] \ge E\big[\liminf_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}}|\mathcal{F}_t\big].
$$

Finally, using the fact that $\liminf_{T\to\infty} E[V_T^{\gamma}]$ $T_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}} \geq e^{m_s}$, and by Jensen's inequality for $f(x) = e^x$, we get

$$
E\left[\liminf_{T\to\infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}}|\mathcal{F}_t]\geq E[e^{m_s}|\mathcal{F}_t]\geq e^{E[m_s|\mathcal{F}_t]},
$$

which completes the proof.

6) Let $t \in \mathbb{T}$, $V \in \widetilde{\mathbb{V}}$ and $\gamma < 0$. We want to prove that for $s \in \mathbb{T}$, $s > t$, and $m_s \in \overline{L}_s^0$, we have

$$
\varphi_s^{\gamma}(V) \le m_s \Rightarrow \varphi_t^{\gamma}(V) \le E[m_s|\mathcal{F}_t]. \tag{A.21}
$$

Doing similar operations as in 5), we deduce that $(A.21)$ is equivalent to

$$
\liminf_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}} \le e^{m_s} \Rightarrow \liminf_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{\gamma T}} \le e^{E[m_s|\mathcal{F}_t]}.
$$
\n(A.22)

Since for $\gamma < 0$ and nonnegative x the function $f(x) = x^{\gamma}$ is decreasing, we have that $(A.22)$ is equivalent to

$$
\left[\liminf_{T\to\infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}}\right]^{\gamma} \geq e^{\gamma m_s} \Rightarrow \left[\liminf_{T\to\infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{\gamma T}}\right]^{\gamma} \geq e^{\gamma E[m_s|\mathcal{F}_t]}
$$

which is consequently equivalent to

$$
\limsup_{T \to \infty} \left[E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{\gamma T}} \right]^{\gamma} \ge e^{\gamma m_s} \Rightarrow \limsup_{T \to \infty} \left[E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{\gamma T}} \right]^{\gamma} \ge e^{\gamma E[m_s|\mathcal{F}_t]},
$$

From here, we conclude that $(A.19)$ is equivalent to

$$
\limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{T}} \ge e^{\gamma m_s} \Rightarrow \limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{T}} \ge e^{\gamma E[m_s|\mathcal{F}_t]},\tag{A.23}
$$

and thus we will verify this implication.

To give a better intuition of the proof of $(A.23)$, first we will consider $t = 0$, i.e we will show that that for any $m_s \in \bar{L}_s^0$, we have that

$$
\limsup_{T \to \infty} E[V_T^{\gamma} | \mathcal{F}_s]^{\frac{1}{T}} \ge e^{\gamma m_s} \Rightarrow \limsup_{T \to \infty} E[V_T^{\gamma}]^{\frac{1}{T}} \ge e^{\gamma E[m_s]}.
$$
\n(A.24)

Assume that $s > 0$, $m_s \in \bar{L}_s^0$, and such that

$$
\limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{T}} \ge e^{\gamma m_s}.
$$

Note that, there exists a set $C \in \mathcal{F}_s$, such that $P[C] > 0$ and $I_C e^{\gamma m_s} \ge I_C E[e^{\gamma m_s}]$. Hence,

$$
I_C \limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{T}} \ge I_C E[e^{\gamma m_s}].
$$

By Jensen's inequality, we continue

$$
\operatorname{I}_C \limsup_{T \to \infty} E[V_T^{\gamma} | \mathcal{F}_s]^{\frac{1}{T}} \ge \operatorname{I}_C e^{\gamma E[m_s]}.
$$
\n(A.25)

Let $\epsilon > 0$, and put $B_T^{\epsilon} := {\omega \in \Omega : E[V_T^{\gamma}]}$ $T_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{T}}(\omega) \geq e^{\gamma E[m_s]-\epsilon}$. Notice that

$$
C \subset \limsup_{T \to \infty} B_T^{\epsilon},
$$

which consequently implies that

$$
P\left[\limsup_{T \to \infty} B_T^{\epsilon}\right] > 0. \tag{A.26}
$$

From here, by Borel-Cantelli Lemma, we get that $\sum_{T=1}^{\infty} P[B_T^{\epsilon}] = \infty$. Since the last series is divergent, there exists a subsequence $\{T_k^{\epsilon}\}_{(k=1,2,\ldots)}$ such that

$$
P[B_{T_k^{\epsilon}}^{\epsilon}] \ge \frac{1}{(T_k^{\epsilon})^2}
$$

.

Using this, we have the following chain of inequalities

$$
\limsup_{T \to \infty} E[V_T^{\gamma}]^{\frac{1}{T}} = \limsup_{T \to \infty} E[E[V_T^{\gamma}|\mathcal{F}_s]]^{\frac{1}{T}} \ge \limsup_{T \to \infty} E[I_{B_T^{\epsilon}} E[V_T^{\gamma}|\mathcal{F}_s]]^{\frac{1}{T}}
$$
\n
$$
\ge \limsup_{T \to \infty} E[I_{B_T^{\epsilon}} e^{(\gamma E[m_s] - \epsilon)T}]^{\frac{1}{T}} \ge e^{\gamma E[m_s] - \epsilon} \limsup_{T \to \infty} P[B_T^{\epsilon}]^{\frac{1}{T}}
$$
\n
$$
\ge e^{\gamma E[m_s] - \epsilon} \limsup_{T_k^{\epsilon} \to \infty} P[B_{T_k^{\epsilon}}^{\epsilon}]^{\frac{1}{T_k^{\epsilon}}} \ge e^{\gamma E[m_s] - \epsilon} \limsup_{T_k^{\epsilon} \to \infty} \left[\frac{1}{(T_k^{\epsilon})^2}\right]^{\frac{1}{T_k^{\epsilon}}}
$$
\n
$$
= e^{\gamma E[m_s] - \epsilon}.
$$

Hence, taking into account that $\epsilon > 0$ was arbitrary chosen, implication [\(A.24\)](#page-18-3) follows immediately.

The proof for $t > 0$ follows similar line of ideas as for $t = 0$, although it is a bit more technical. For sake of completeness we will present the proof here too. The proof is done by contradiction: assume that $(A.21)$ is not true for some $s \in \mathbb{T}$, $s > t$. Then, since $(A.21)$ is equivalent to [\(A.23\)](#page-18-2), there exists $V \in \tilde{\mathbb{V}}$, $m_s \in \bar{L}_s^0$ and $A \in \mathcal{F}_t$, $P[A] > 0$ such that for

$$
\limsup_{T \to \infty} E[V_T^{\gamma} | \mathcal{F}_s]^{\frac{1}{T}} \ge e^{\gamma m_s} \quad \text{and} \quad \limsup_{T \to \infty} E[V_T^{\gamma} | \mathcal{F}_t]^{\frac{1}{T}} < e^{\gamma E[m_s | \mathcal{F}_t]}.
$$
\n(A.27)

almost surely on A. Note that there exists $\epsilon > 0$ and $A_2 \in \mathcal{F}_t$, $A_2 \subset A$, $P[A_2] > 0$, such that

$$
1_{A_2} \limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{T}} \le 1_{A_2} e^{\gamma E[m_s|\mathcal{F}_t] - 2\epsilon}.
$$
 (A.28)

Let us consider the following sets

$$
B_T^{\epsilon} := \{ \omega \in A_2 : E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{T}}(\omega) \ge e^{\gamma E[m_s|\mathcal{F}_t](\omega) - \epsilon} \},
$$

$$
D_{\alpha} := \{ \omega \in A_2 : \sum_{T=1}^{\infty} E[1_{B_T^{\epsilon}}|\mathcal{F}_t] < \alpha \}, \qquad \alpha \in \mathbb{N} \cup \{ +\infty \}.
$$

Note that $D_n \in \mathcal{F}_t$ for any $n \in \mathbb{N}$, $D_n \subset D_m$ for $n \leq m$, and $D_\infty = \cup_{n \in \mathbb{N}} D_n \in \mathcal{F}_t$. Next we consider two cases: a) $P[D_{\infty}] > 0$ and b) $P[D_{\infty}] = 0$.

Case a) Since $P[D_{\infty}] = P[\lim_{n \to \infty} D_n] = \lim_{n \to \infty} P[D_n] > 0$, there exists $n_0 > 0$ such that $P[D_{n_0}] > 0$. Consequently,

$$
\sum_{T=1}^{\infty} P[B_T^{\epsilon} \cap D_{n_0}] < n_0.
$$

From here, by Borel-Cantelli Lemma, we get

$$
P\Big[\limsup_{T\to\infty}[B_T^{\epsilon}\cap D_{n_0}]\Big]=0,
$$

which implies that

$$
1_{D_{n_0}} \limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_s]^{\frac{1}{T}} \le 1_{D_{n_0}} e^{\gamma E[m_s|\mathcal{F}_t] - \epsilon}.
$$

that contradicts $(A.27)$ on some set of positive measure. Case b) Let $P[D_\infty] = 0$. First note that,

$$
\limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{T}} = \limsup_{T \to \infty} E[E[V_T^{\gamma}|\mathcal{F}_s]|\mathcal{F}_t]^{\frac{1}{T}} \ge \limsup_{T \to \infty} E[I_{B_T^{\epsilon}}E[V_T^{\gamma}|\mathcal{F}_s]|\mathcal{F}_t]^{\frac{1}{T}}
$$
\n
$$
\ge \limsup_{T \to \infty} E[I_{B_T^{\epsilon}}e^{(\gamma E[m_s|\mathcal{F}_t]-\epsilon)T}|\mathcal{F}_t]^{\frac{1}{T}} \ge e^{\gamma E[m_s|\mathcal{F}_t]-\epsilon} \limsup_{T \to \infty} E[1_{B_T^{\epsilon}}|\mathcal{F}_t]^{\frac{1}{T}}. \tag{A.29}
$$

Since $D_{\infty} \subset A_2$, and $P[D_{\infty}] = 0$, we have that for (almost) every $\omega \in A_2$ there exists a subsequence $\{T_k^{\epsilon,\omega}\}$ $\{k, \omega\}_{k \in \mathbb{N}}$ such that

$$
E\left[1_{B_{T_k^{\epsilon,\omega}}^{\epsilon}}|\mathcal{F}_t\right](\omega) \ge \frac{1}{(T_k^{\epsilon,\omega})^2}
$$

.

Using this, and [\(A.29\)](#page-20-0), we conclude that for (almost) every $\omega \in A_2$

$$
\limsup_{T \to \infty} E[1_{B_T^{\epsilon}}|\mathcal{F}_t]^{\frac{1}{T}}(\omega) \ge \limsup_{T_k^{\epsilon,\omega} \to \infty} E[1_{B_{T_k^{\epsilon,\omega}}}|\mathcal{F}_t]^{\frac{1}{T_k^{\epsilon,\omega}}}(\omega) \ge \limsup_{T_k^{\epsilon,\omega} \to \infty} \left[\frac{1}{(T_k^{\epsilon,\omega})^2}\right]^{\frac{1}{T_k^{\epsilon,\omega}}} = 1.
$$

Thus, almost everywhere on A_2

$$
\limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{T}} \ge e^{\gamma E[m_s|\mathcal{F}_t] - \epsilon}.
$$

Combining the last inequality with $(A.28)$, we get

$$
1_{A_2}e^{\gamma E[m_s|\mathcal{F}_t]-2\epsilon} \ge 1_{A_2} \limsup_{T \to \infty} E[V_T^{\gamma}|\mathcal{F}_t]^{\frac{1}{T}} \ge 1_{A_2}e^{\gamma E[m_s|\mathcal{F}_t]-\epsilon},
$$

which leads to contradiction, as $P[A_2] > 0$.

 \Box

Proof of Proposition [5.5](#page-9-1). Let $([0,1], \mathcal{B}([0,1]), \{\mathcal{F}_t\}_{t \in \mathbb{N}_0}, \lambda)$ be a filtered probability space, with $\mathcal{F}_0 = \{ [0, 1], \emptyset \}$ and $\mathcal{F}_1 = \mathcal{B}([0, 1]).$

3') For $\gamma = -1$ it is enough to consider a simple example

$$
\widehat{V}_T(\omega) = \begin{cases}\ne^{-T} & \omega \in [0, e^{-T}], \\
e^T & \omega \in [e^{-T}, 1].\n\end{cases}
$$

This example could be easily modified for any $\gamma < 0$. For $\gamma = 0$ it is enough to consider

$$
\widehat{V}'_T(\omega) = \begin{cases}\ne^{-T^2} & \omega \in [0, \frac{1}{T}], \\
e^T & \omega \in [\frac{1}{T}, 1].\n\end{cases}
$$

5') Let $\gamma = 1$, and let $\{\widehat{V}_T\}_{T \in \mathbb{N}}$ be defined by

$$
\widehat{V}_T(\omega) = \begin{cases}\n\frac{1}{T} & \omega \in [0, \frac{1}{T}], \\
e^T & \omega \in [\frac{1}{T}, 1].\n\end{cases}
$$
\n(A.30)

For $\omega \neq 0$, we have

$$
\varphi_1^{-1}(\widehat{V}_T)(\omega) = \liminf_{T \to \infty} \frac{-1}{T} \ln \frac{1}{\widehat{V}_T(\omega)} = \liminf_{T \to \infty} [(-\frac{\ln T}{T}) \cdot I_{[0,\frac{1}{T}]}(\omega) + 1 \cdot I_{[\frac{1}{T},1]}(\omega)] = 1.
$$

On the other hand

$$
\varphi_0^{-1}(\widehat{V}_T) = \liminf_{T \to \infty} \frac{-1}{T} \ln E(\frac{1}{\widehat{V}_T}) = \liminf_{T \to \infty} \frac{-1}{T} \ln(1 + \frac{T - 1}{T} e^{-T}) \le \liminf_{T \to \infty} \frac{-\ln 1}{T} = 0.
$$

Thus, with $m_1 = 1$, we get

$$
\varphi_1^{-1}(\widehat{V}) \ge m_1 \neq \varphi_0^{-1}(\widehat{V}) \ge E[m_1|\mathcal{F}_0],
$$

which contradicts supermartingale consistency. This counterexample can be easily adjusted for any $\gamma < 0$.

Similarly, for $\gamma = 0$, we consider

$$
\widehat{V}'_T(\omega) := \begin{cases}\ne^{-T^2} & \omega \in [0, \frac{1}{T}], \\
e^T & \omega \in [\frac{1}{T}, 1].\n\end{cases}
$$

6') As in the previous case we will consider only $\gamma = 1$ and $\gamma = 0$. For $\gamma = 1$, we take $\{\widehat{V}_T\}_{T \in \mathbb{N}}$ defined by

$$
\widehat{V}_T(\omega) = \begin{cases}\nT e^T & \omega \in [0, \frac{1}{T}], \\
1 & \omega \in [\frac{1}{T}, 1].\n\end{cases}
$$
\n(A.31)

Then, we have

$$
\varphi_1^1(\widehat{V}_T)(\omega) = \liminf_{T \to \infty} \frac{1}{T} \ln \widehat{V}_{T(\omega)} = \liminf_{T \to \infty} [(1 + \frac{\ln T}{T}) \cdot I_{[0, \frac{1}{T}]}(\omega) + 0 \cdot I_{[\frac{1}{T}, 1]}(\omega)] = 0, \quad \omega \neq 0.
$$

On the other hand

$$
\varphi_0^1(\widehat{V}_T) = \liminf_{T \to \infty} \frac{1}{T} \ln E(\widehat{V}_T) = \liminf_{T \to \infty} \frac{1}{T} \ln(e^T + \frac{T-1}{T}) \ge \liminf_{T \to \infty} \frac{T}{T} = 1.
$$

Thus, with $m_1 = 0$, we get

$$
\varphi_1^1(\widehat{V}) \le m_1 \neq \varphi_0^1(\widehat{V}) \le E[m_1|\mathcal{F}_0],
$$

which contradicts submartingale consistency.

Similarly, for $\gamma = 0$, we consider

$$
\widehat{V}'_T(\omega) = \begin{cases}\ne^{T^2} & \omega \in [0, \frac{1}{T}], \\
1 & \omega \in [\frac{1}{T}, 1].\n\end{cases}
$$
