# ON SOME NEW INEQUALITIES INVOLVING GENERALIZED ERDÉLYI-KOBER FRACTIONAL q-INTEGRAL OPERATOR

**Abstract.** In the present investigation, we aim to establish some inequalities involving generalized  $\operatorname{Erd}e$  lyi-Kober fractional q-integral operator of the two parameters of deformation  $q_1$  and  $q_2$  due to Gaulue, by following the same lines used by Baleanu and Agarwal [4] in their recent paper. Relevant connections of the results presented here with those earlier ones are also pointed out.

### 1. Introduction and Preliminaries

Throughout this paper,  $\mathbb{N}$ ,  $\mathbb{R}$ ,  $\mathbb{C}$ , and  $\mathbb{Z}_0^-$  denote the sets of positive integers, real numbers, complex numbers, and nonpositive integers, respectively, and  $\mathbb{N}_0 := \mathbb{N} \cup \{0\}$ . The enormous success of the theory of integral inequalities involving various fractional integral operators has stimulated the development of a corresponding theory in qfractional integral inequalities (see, e.g., [2, 3, 5, 6, 7, 8, 9, 13, 15]). In this paper we aim to present some inequalities involving generalized Erdélyi-Kober fractional q-integral operator of the two parameters of deformation  $q_1$  and  $q_2$ due to Gaulué [10], by following the same lines used by Baleanu and Agarwal [4] in their recent paper. Relevant connections of the results presented here with those earlier ones are also pointed out.

Here, we recall the following definitions (see, e.g., [14, Section 6]) and some earlier works.

The *q*-shifted factorial  $(a;q)_n$  is defined by

$$(a;q)_n := \begin{cases} 1 & (n=0) \\ \prod_{k=0}^{n-1} (1-a q^k) & (n \in \mathbb{N}), \end{cases}$$

where  $a, q \in \mathbb{C}$  and it is assumed that  $a \neq q^{-m}$   $(m \in \mathbb{N}_0)$ .

The *q*-shifted factorial for negative subscript is defined by

$$(a;q)_{-n} := \frac{1}{(1-a\,q^{-1})\,(1-a\,q^{-2})\cdots(1-a\,q^{-n})} \quad (n\in\mathbb{N}_0)\,.$$

We also write

$$(a;q)_{\infty} := \prod_{k=0}^{\infty} (1 - a q^k) \quad (a, q \in \mathbb{C}; |q| < 1).$$

It follows from (1.1), (1.2) and (1.3) that

$$(a;q)_n = \frac{(a;q)_\infty}{(a\,q^n;q)_\infty} \quad (n \in \mathbb{Z}), \tag{1.4}$$

which can be extended to  $n = \alpha \in \mathbb{C}$  as follows:

$$(a;q)_{\alpha} = \frac{(a;q)_{\infty}}{(a q^{\alpha};q)_{\infty}} \quad (\alpha \in \mathbb{C}; \ |q| < 1),$$

where the principal value of  $q^{\alpha}$  is taken.

We begin by noting that Jackson [11] was the first to develop q-calculus in a systematic way, this topic is also developed in the recent monograph [12].

The *q*-derivative of a function f(t) is defined by

$$D_q\{f(t)\} := \frac{d_q}{d_q t}\{f(t)\} = \frac{f(qt) - f(t)}{(q-1)t}.$$

For  $q \to 1$  we obtain the definition of differential function, being:

$$\lim_{q \to 1} D_q\{f(t)\} = \frac{d}{dt}\{f(t)\},$$

if we assume that f(t) is a differentiable function.

The function F(t) is a q-antiderivative of f(t) if  $D_q\{F(t)\} = f(t)$ . It is denoted by

$$\int f(t) d_q t. \tag{1.7}$$

The Jackson integral of f(t) is thus defined, formally, by

$$\int f(t) d_q t := (1-q)t \sum_{j=0}^{\infty} q^j f(q^j t), \qquad (1.8)$$

which can be easily generalized in the Stieltjes sense as follows:

$$\int f(t) d_q g(t) = \sum_{j=0}^{\infty} f(q^j t) \left( g(q^j t) - g(q^{j+1} t) \right).$$

Suppose that 0 < a < b. The definite q-integral is defined as follows:

$$\int_{0}^{b} f(t) d_{q} t := (1-q)b \sum_{j=0}^{\infty} q^{j} f\left(q^{j} b\right)$$

and

$$\int_{a}^{b} f(t) d_{q} t = \int_{0}^{b} f(t) d_{q} t - \int_{0}^{a} f(t) d_{q} t.$$

A more general version of (1.10) is given by

$$\int_{0}^{b} f(t) d_{q} g(t) = \sum_{j=0}^{\infty} f\left(q^{j} b\right) \left(g\left(q^{j} b\right) - g\left(q^{j+1} b\right)\right).$$

The classical Gamma function  $\Gamma(z)$  (see, e.g., [14, Section 1.1]) was introduced by Leonhard Euler in 1729 while he was trying to extend the factorial  $n! = \Gamma(n+1)$   $(n \in \mathbb{N}_0)$  to real numbers. The q-factorial function  $(n)_q!$   $(n \in \mathbb{N}_0)$ of n! defined by

$$(n)_{q}! := \begin{cases} 1 & (n=0), \\ (n)_{q} (n-1)_{q} \cdots (2)_{q} (1)_{q} & (n \in \mathbb{N}). \end{cases}$$

can be rewritten as follows:

$$(1-q)^{-n} \prod_{k=0}^{\infty} \frac{\left(1-q^{k+1}\right)}{\left(1-q^{k+1+n}\right)} = \frac{(q;q)_{\infty}}{\left(q^{n+1};q\right)_{\infty}} (1-q)^{-n} := \Gamma_q(n+1) \quad (0 < q < 1).$$

Replacing n by a - 1 in (1.14), Jackson [11] defined the q-Gamma function  $\Gamma_q(a)$  by

$$\Gamma_q(a) := \frac{(q;q)_{\infty}}{(q^a;q)_{\infty}} (1-q)^{1-a} \quad (0 < q < 1).$$

The q-analogue of  $(t-a)^n$  is defined by the polynomial

$$(t-a)_{q}^{n} := \begin{cases} 1 & (n=0), \\ (t-a)(t-qa)\cdots(t-q^{n-1}a) & (n\in\mathbb{N}). \\ =t^{n}\left(\frac{a}{t};q\right)_{n} & (n\in\mathbb{N}_{0}). \end{cases}$$

**Definition 1.** A real-valued function f(t) (t > 0) is said to be in the space  $C_{\lambda}$   $(\lambda \in \mathbb{R})$  if there exists a real number  $p > \lambda$  such that  $f(t) = t^p \phi(t)$ , where  $\phi(t) \in C(0, \infty)$ .

**Definition 2.** A function f(t) (t > 0) is said to be in the space  $C_{\lambda}^n$   $(n \in \mathbb{R})$  if  $f^{(n)} \in C_{\lambda}$ .

**Definition 3.** Let  $0 < q < 1, f \in C_{\lambda}$ . Then for  $\Re(\beta), \Re(\mu) > 0$ , and  $\eta \in \mathbb{C}$  we define a generalized Erdélyi-Kober fractional integral  $I_q^{\alpha,\beta,\eta}$  as follows (see, [10]) :

$$I_{q}^{\eta,\mu,\beta}\left\{f(t)\right\} = \frac{\beta t^{-\beta(\eta+\mu)}}{\Gamma_{q}(\mu)} \int_{0}^{t} (t^{\beta} - \tau^{\beta} q)_{\mu-1} \tau^{\beta(\eta+1)-1} f(\tau) d_{q}\tau,$$

$$= \beta(1 - q^{1/\beta})(1 - q)^{\mu-1} \sum_{k=0}^{\infty} \frac{(q^{\mu};q)_{k}}{(q;q)_{k}} q^{k(\eta+1)} f(tq^{k/\beta}).$$

**Definition 4.** Let  $0 < q < 1, f \in C_{\lambda}$ . Then for  $\Re(\mu) > 0$  and  $\eta \in \mathbb{C}$  a q-analogue of the Kober fractional integral operator is given by (see [1])

$$I_{q}^{\eta,\mu}\left\{f(t)\right\} = \frac{t^{-\eta-\mu}}{\Gamma_{q}(\mu)} \int_{0}^{t} (t-\tau q)_{\mu-1} \tau^{\eta} f(\tau) d_{q} \tau.$$

**Remark 1.** It is easy to see that

$$\Gamma_q(\mu) > 0; \quad (q^{\mu}; q)_k > 0,$$

for all  $\mu > 0$  and  $k \in \mathbb{N}_0$ . If  $f : [0, \infty) \to [0, \infty)$  is a continuous function. Then we conclude that, under the given conditions in (1.17), each term in the series of generalized Erdélyi-Kober *q*-integral operator is nonnegative defined by

$$I_q^{\eta,\mu,\beta} \{ f(t) \} \ge 0, \tag{1.20}$$

for all  $\mu > 0$  and  $\eta \in \mathbb{C}$ .

On the same way each term in the series of Kober q-integral operator (1.18) is also nonnegative defined by

$$I_q^{\eta,\mu} \{ f(t) \} \ge 0. \tag{1.21}$$

for all  $\mu > 0$  and  $\eta \in \mathbb{C}$ .

## 2. Generalized Erdélyi-Kober q-integral Inequalities

In this section, we present six q-integral inequalities, which are the core of our research, involving the generalized Erdélyi-Kober q-integral (1.17) stated in Theorem 1 to 6 below. Before we recall, as stated in [6, p. 1, Eq. 2] therein, that if f, g are two real function defined and integrable on a real interval  $(I \equiv I \in [a, b])$ , we say that f and g are synchronous on I if for each  $x, y \in I$  the following inequality holds:

$$(f(x) - f(y))(g(x) - g(y)) \ge 0.$$

Similarly f and g are asynchronous on I if for any  $x, y \in I$  the inequality is reversed, that is:

$$(f(x) - f(y))(g(x) - g(y)) \le 0.$$

**Theorem 1.** Let  $0 < q_1 < 1$  and  $0 < q_2 < 1$  with  $f, g, h \in C_{\lambda}$  are three synchronous functions on  $[0, \infty)$ . If  $u : [0, \infty) \to [0, \infty)$  is a continuous function, then the following inequality holds true:

$$\begin{split} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) g(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) h(t) \right\} \\ & + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) h(t) \right\} \\ & \geq I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) g(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) g(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} . \end{split}$$

for all t > 0,  $\mu, \nu, \beta, \delta > 0$  and  $\eta, \zeta \in \mathbb{C}$ .

*Proof:* Let f, g and h are three continuous and synchronous functions on  $[0, \infty)$  and (2.1) is satisfied. Then for all  $\tau, \rho \geq 0$ , we have

$$((f(\tau) - f(\rho))(g(\tau) - g(\rho))(h(\tau) + h(\rho))) \ge 0,$$

which implies that

$$f(\tau)g(\tau)h(\tau) + f(\rho)g(\rho)h(\rho) + f(\tau)g(\tau)h(\rho) + f(\rho)g(\rho)h(\tau)$$
  

$$\geq f(\tau)g(\rho)h(\tau) + f(\tau)g(\rho)h(\rho) + f(\rho)g(\tau)h(\tau) + f(\rho)g(\tau)h(\rho).$$

Now, multiplying both sides of (2.5) by

$$\frac{\beta t^{-\beta(\eta+\mu)}}{\Gamma_{q_1}(\mu)} (\tau^{\beta} - \tau^{\beta} q_1)_{\mu-1} \tau^{\beta(\eta+1)-1} u(\tau)$$

and integrating the resulting inequality with respect to  $\tau$  from 0 to t, and using (1.17), we get

$$I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) h(t) \right\} + h(\rho) I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) \right\} + f(\rho) g(\rho) I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) h(t) \right\} + f(\rho) g(\rho) h(\rho) I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} \ge g(\rho) I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) h(t) \right\} + g(\rho) h(\rho) I_{q_{1}}^{v} \left\{ u(t) f(t) \right\} + f(\rho) I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} + f(\rho) h(\rho) I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) \right\}.$$

Next, multiply both sides of (2.6) by

$$\frac{\delta t^{-\delta(\zeta+\nu)}}{\Gamma_{q_2}(\nu)}(t^{\delta}-\rho^{\delta} q_2)_{\nu-1}\rho^{\delta(\zeta+1)-1}u(\rho),$$

which remains nonnegative under the conditions in (1.20) and integrating the resulting inequality with respect to  $\rho$  from 0 to t, and using (1.17), we are led to the desired result (2.3). This complete the proof of Theorem 1.

**Theorem 2.** Let  $0 < q_1 < 1$ ,  $0 < q_2 < 1$  and  $f, g, h \in C_{\lambda}$  satisfying the condition (2.1) on  $[0, \infty)$ . If, we assume  $u, v : [0, \infty) \to [0, \infty)$  are continuous functions. Then the following inequality holds true:

$$\begin{split} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) g(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) h(t) \right\} \\ & + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) h(t) \right\} \\ & \geq I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) g(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) g(t) h(t) \right\} I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} . \end{split}$$

for all t > 0,  $\mu, \nu, \beta, \delta > 0$  and  $\eta, \zeta \in \mathbb{C}$ .

*Proof*: To prove the above result, multiplying both sides of (2.6) by

$$\frac{\delta t^{-\delta(\zeta+\nu)}}{\Gamma_{q_2}(\nu)}(t^{\delta}-\rho^{\delta} q_2)_{\nu-1}\rho^{\delta(\zeta+1)-1}v(\rho),$$

which remains nonnegative under the conditions in (1.20) and integrating the resulting inequality with respect to  $\rho$  from 0 to t, and using (1.17), we are led to the desired result (2.7). This complete the proof of Theorem 2.

**Remark 1.** It may be noted that the inequalities in (2.3) and (2.7) are reversed if functions f, g and h are asynchronous. It is also easily seen that the special case u = v of (2.7) in Theorem 2 reduces to that in Theorem 1.

**Theorem 3.** Let  $0 < q_1 < 1$ ,  $0 < q_2 < 1$  and  $u : [0, \infty) \to [0, \infty)$  be a continuous function with we assume  $f, g, h \in C_{\lambda}$ , are three synchronous functions on  $[0, \infty)$ , for which the following condition are satisfied:

$$\psi \le f(x) \le \Psi, \quad \phi \le g(x) \le \Phi \quad and \quad \omega \le h(x) \le \Omega, \quad (\phi, \psi, \omega, \Phi, \Psi, \Omega \in \mathbb{R}; x \in [0, \infty)).$$

Then the following inequality holds true:

*Proof:* Since f, g and h are three continuous and synchronous functions on  $[0, \infty)$ , for all  $\tau, \rho \ge 0$ , the inequality (2.1) is satisfied. we have from (2.8):

$$|f(\tau) - f(\rho)| \le (\Psi - \psi), \quad |g(\tau) - g(\rho)| \le (\Phi - \phi), \quad |h(\tau) - h(\rho)| \le (\Omega - \omega),$$

which implies that

$$|(f(\tau) - f(\rho)) (g(\tau) - g(\rho)) (h(\tau) - h(\rho))| \le (\Psi - \psi) (\Phi - \phi) (\Omega - \omega).$$

taking q-integration of the resulting inequality with respect to  $\tau$  from 0 to t and using (1.17), we get:

then q-integrate of the resulting inequality with respect to  $\rho$  from 0 to t, and use (1.17), so that

= I_{q_{1}}^{\eta,\mu,\beta} \{u(t) f(t) g(t) h(t)\} I_{q_{2}}^{\gamma,\delta,\zeta} \{u(t)\} + I_{q_{1}}^{\eta,\mu,\beta} \{u(t) h(t)\} I_{q_{2}}^{\gamma,\delta,\zeta} \{u(t) f(t) g(t)\} 
+ I_{q_{1}}^{\eta,\mu,\beta} \{u(t) g(t)\} I_{q_{2}}^{\gamma,\delta,\zeta} \{u(t) f(t) h(t)\} + I_{q_{1}}^{\eta,\mu,\beta} \{u(t) f(t)\} I_{q_{2}}^{\gamma,\delta,\zeta} \{g(t) h(t) u(t)\} 
- I_{q_{1}}^{\eta,\mu,\beta} \{u(t) g(t) h(t)\} I_{q_{2}}^{\gamma,\delta,\zeta} \{u(t) f(t)\} - I_{q_{1}}^{\eta,\mu,\beta} \{u(t) f(t) h(t)\} I_{q_{2}}^{\gamma,\delta,\zeta} \{u(t) g(t) h(t)\}.$$

Finally, by using (2.10) on to (2.13), we arrive at the desired result (2.9), involve in Theorem 3, after a little simplification.

**Theorem 4.** Let  $0 < q_1 < 1$ ,  $0 < q_2 < 1$  and  $u, v : [0, \infty) \to [0, \infty)$  are continuous synchronous functions with  $f, g, h \in C_{\lambda}$  satisfying the condition (2.1) on  $[0, \infty)$  and the following condition:

$$\psi \le f(x) \le \Psi, \quad \phi \le g(x) \le \Phi \quad and \quad \omega \le h(x) \le \Omega \quad (\phi, \psi, \omega, \Phi, \Psi, \Omega \in \mathbb{R}; x \in [0, \infty)) \tag{2.14}$$

Then the following inequality holds true:

$$\begin{aligned} \left| {}_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) h(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) \right\} + I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) h(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) g(t) \right\} \\ + I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) h(t) \right\} + I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ g(t) h(t) v(t) \right\} \\ - I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) \right\} - I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) h(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) g(t) \right\} \\ - I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) h(t) \right\} - I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) g(t) h(t) \right\} \\ & \leq I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} \left\{ v(t) \left\{ \Psi - \psi \right\} (\Phi - \phi) (\Omega - \omega), \end{aligned}$$

for all  $t > 0, \mu, \nu, \beta, \delta > 0$  and  $\eta, \zeta \in \mathbb{C}$ .

*Proof*: Multiplying both sides of (2.12) by

$$\frac{\delta t^{-\delta(\zeta+\nu)}}{\Gamma_{q_2}(\nu)} (t^{\delta} - \rho^{\delta} q_2)_{\nu-1} \rho^{\delta(\zeta+1)-1} v(\rho)$$

and taking the q-integration of the resulting inequality with respect to  $\rho$  from 0 to t with the aid of Definition 1 and then applying (2.10) on the resulting inequality, we get the desired result (2.15).

**Remark 2.** It is easily seen that the special case u = v of (2.15) in Theorem 4 reduces to that in Theorem 3.

**Theorem 5.** Let  $0 < q_1 < 1$ ,  $0 < q_2 < 1$  and  $u : [0, \infty) \to [0, \infty)$  be a continuous function. we assume that  $f, g, h \in C_{\lambda}$  satisfying the condition (2.1) on  $[0, \infty)$  with constants  $L_1, L_2$  and  $L_3$ , respectively. Then the following inequality holds true:

$$\begin{aligned} |I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) g(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) h(t) \right\} \\ &+ I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) h(t) \right\} \\ &- I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) \right\} - I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} - I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} \\ &- I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) f(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} - I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) g(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) h(t) \right\} | \\ &\leq L_{1} L_{2} L_{3} \left[ I_{q_{1}}^{\eta,\mu,\beta} \left\{ \tau^{3} u(t) \right\} & I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) \right\} + 3I_{q_{1}}^{\eta,\mu,\beta} \left\{ \tau u(t) \right\} & I_{q_{2}}^{\zeta,\nu,\delta} \left\{ \rho^{3} u(t) \right\} \right] . \end{aligned}$$

for all t > 0,  $\mu, \nu, \beta, \delta > 0$  and  $\eta, \zeta \in \mathbb{C}$ .

*Proof*: Let us define the following relations for all  $\tau, \rho \in [0, \infty)$ :

$$|f(\tau) - f(\rho)| \le L_1(\tau - \rho), \quad |g(\tau) - g(\rho)| \le L_2(\tau - \rho), \quad |h(\tau) - h(\rho)| \le L_3(\tau - \rho), \tag{2.17}$$

which implies that

$$|\mathcal{A}(\tau,\rho)| \le L_1 L_2 L_3 (\tau-\rho)^3, \tag{2.18}$$

where,  $\mathcal{A}(\tau, \rho)$  is given by (2.11). Then, by setting:

$$\mathcal{B}(\tau,\rho) := L_1 L_2 L_3 (\tau - \rho)^3.$$
(2.19)

First, we multiplying both sides of (2.19) by

$$\frac{\beta t^{-\beta(\eta+\mu)}}{\Gamma_{q_1}(\mu)} (\tau^{\beta} - \tau^{\beta} q_1)_{\mu-1} \tau^{\beta(\eta+1)-1} u(\tau)$$

and

$$\frac{\delta t^{-\delta(\zeta+\nu)}}{\Gamma_{q_2}(\nu)} (t^{\delta} - \rho^{\delta} q_2)_{\nu-1} \rho^{\delta(\zeta+1)-1} u(\rho),$$

respectively, and taking the q-integration of the resulting inequality with respect to  $\tau$  and  $\rho$  from 0 to t with the aid of Definition 1 and then applying (2.10) and (2.18) on the resulting inequality, we get the desired result (2.16). This complete the proof of Theorem 5.

**Theorem 6.** Let  $0 < q_1 < 1$ ,  $0 < q_2 < 1$  and assume that  $u, v : [0, \infty) \to [0, \infty)$  are continuous functions and suppose  $f, g, h \in C_{\lambda}$  synchronous on  $[0, \infty)$  and satisfying (2.1) with constants  $L_1, L_2$  and  $L_3$ , respectively. Then the following inequality holds true:

$$\begin{aligned} |I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) g(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) h(t) \right\} \\ &+ I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) \right\} + I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) g(t) h(t) \right\} \\ &- I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) g(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) \right\} - I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) h(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} \\ &- I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) f(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) g(t) h(t) \right\} - I_{q_{2}}^{\zeta,\nu,\delta} \left\{ v(t) g(t) \right\} & I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) f(t) h(t) \right\} | \\ &\leq L_{1} L_{2} L_{3} \left[ I_{q_{1}}^{\eta,\mu,\beta} \left\{ \tau^{3} u(t) \right\} & I_{q_{2}}^{\zeta,\nu,\delta} \left\{ u(t) \right\} + 3I_{q_{1}}^{\eta,\mu,\beta} \left\{ \tau u(t) \right\} & I_{q_{2}}^{\zeta,\nu,\delta} \left\{ \rho^{3} v(t) \right\} \\ &- 3I_{q_{1}}^{\eta,\mu,\beta} \left\{ \tau^{2} u(t) \right\} & I_{q_{2}}^{\zeta,\nu,\delta} \left\{ \rho v(t) \right\} - I_{q_{1}}^{\eta,\mu,\beta} \left\{ u(t) \right\} & I_{q_{2}}^{\zeta,\nu,\delta} \left\{ \rho^{3} v(t) \right\} \right]. \end{aligned}$$

for all t > 0,  $\mu, \nu, \beta, \delta > 0$  and  $\eta, \zeta \in \mathbb{C}$ .

*Proof*: Multiplying both sides of (2.19) by

$$\frac{\beta t^{-\beta(\eta+\mu)}}{\Gamma_{q_1}(\mu)} (\tau^{\beta} - \tau^{\beta} q_1)_{\mu-1} \tau^{\beta(\eta+1)-1} u(\tau)$$
$$\frac{\delta t^{-\delta(\zeta+\nu)}}{(\tau^{\beta} - q^{\delta} q_2)_{\nu-1}} u^{\delta(\zeta+1)-1} u(q)$$

and

$$\frac{\partial t}{\Gamma_{q_2}(\nu)} (t^{\delta} - \rho^{\delta} q_2)_{\nu-1} \rho^{\delta(\zeta+1)-1} v(\rho)$$

respectively, and taking the q-integration of the resulting inequality with respect to  $\tau$  and  $\rho$  from 0 to t with the aid of Definition 1 and then applying (2.10) and (2.18) on the resulting inequality, we get the desired result (2.20). This complete the proof of Theorem 6.

**Remark 3.** It is easily seen that the special case u = v of (2.20) in Theorem 6 reduces to that in Theorem 5.

### **Concluding Remarks**

We can present a large number of special cases of our main inequalities in Theorems 1 to 6. Here we give only one example: Setting  $\beta = 1$  in Theorem 1- 6, we get the known results given by Baleanu and Agarwal [4].

Therefore, we arrived at the conclusion that our present investigation are general in character and useful in deriving various q-inequalities in the theory of fractional q-integral operators.
