CONVERGENCE OF A CRYSTALLINE ALGORITHM FOR THE HEAT EQUATION IN ONE DIMENSION AND FOR THE MOTION OF A GRAPH BY WEIGHTED CURVATURE

ABSTRACT. Motion by (weighted) mean curvature is a geometric evolution law for surfaces, representing steepest descent with respect to (an)isotropic surface energy. It has been proposed that this motion could be computed by solving the analogous evolution law using a "crystalline" approximation to the surface energy. We present the first convergence analysis for a numerical scheme of this type. Our treatment is restricted to one dimensional surfaces (curves in the plane) which are graphs. In this context, the scheme amounts to a new algorithm for solving quasilinear parabolic equations in one space dimension.

1. INTRODUCTION

In the modeling of phase transformations it is often of interest to consider surfaceenergy-driven motion of interfaces (see the work of Gurtin [14] [15] [16], the recent review by Taylor, Cahn, and Handwerker [27], and the references therein). If the surface energy is isotropic this leads to motion by mean curvature, i.e. the normal velocity of the interface equals its mean curvature. If the surface energy is anisotropic the associated evolution equation has been called "motion by weighted mean curvature" (see the review Taylor [25]).

When the surface energy is "strictly convex" the evolution law is a quasilinear parabolic equation. The isotropic case falls in this class. When the surface energy is "crystalline" the surface must be faceted and its evolution law reduces to a family of ordinary differential equations for the lengths of the faces. The mathematical theory of surface-energy-driven motion of interfaces is discussed at length in Angenent and Gurtin [2], developing upon an extensive materials science literature of which Herring [17] is representative. The essential aspects are summarized in an appendix, for the reader's convenience. We emphasize that familiarity with this theory is *not* assumed in the present work, though it provides the motivation and the context for what we do.

There has recently been intense mathematical activity concerning the analysis of motion by (weighted) mean curvature (see for example Angenent and Gurtin [2] [3], Brakke [4], Chen, Giga, and Goto [5], de Mottoni and Schatzman [6], Evans and Spruck [7] [8], Gage and Hamilton [11], Grayson [13], Gurtin [16], Huisken [18], and Sethian [22]). The analysis of crystalline surface energies has also received considerable attention both with regard to statics (energy minimization) (see Sullivan [23] and Taylor [24]) and with regard to dynamics (motion by weighted mean curvature) (see Almgren, Taylor and Wang [1], Angenent and Gurtin [2], Ohnuma and Sato [20], and Roosen and Taylor [21]). We provide these references for the interested reader; the only one we actually need in this paper is [2].

It is a geometrically natural idea to approximate a strictly convex energy by a crystalline one. This idea has recently been analyzed by Sullivan in [23], but only for problems of energy minimization. "Crystalline approximation" has been used in applications without rigorous justification as a method for computing motion by weighted mean curvature in the context of closed curves and surfaces, because it replaces a parabolic differential equation with a system of ordinary differential equations. This paper represents a first attempt to establish its convergence. We study the simplest possible case: the interface is the graph of a function of one variable. Our main result is the convergence of a "crystalline" scheme for solving a quasilinear parabolic equation in one space dimension. We prove convergence in H^1 , with a specified rate. Our method is somewhat similar to the convergence analysis for a Galerkin approximation (see e.g. Thomée [28]).

We emphasize that the "crystalline" discretization considered here is quite different from any of the more standard schemes from numerical analysis. The approximate solution is a piecewise linear function of the spatial variable, with "pieces" that have fixed slopes and variable lengths. This is in sharp contrast to finite difference and finite element methods (where it is the spatial grid that is fixed), to front tracking (which places no constraint on the slopes of the approximate solution), and to spectral methods.

The recent paper of Fukui and Giga [10] is closely related to the present work. They prove a general existence and uniqueness theorem for motion of graphs by weighted curvature (by adapting the theory of nonlinear semigroups), which applies to a wider class of interfacial energies and even to "incompatible" initial data. When the surface energy is "crystalline" and the initial data is piecewise linear and compatible (i.e. has the "right" slopes) their solution is the same as ours. They prove continuous dependence on the initial data and on the form of the interfacial energy. This fact would suffice to prove convergence of our approximation scheme. The result we prove here is sharper, however, because we get a specific convergence rate in the H^1 norm.

In another paper [12] we prove convergence of the crystalline algorithm for the motion of a simple closed convex curve by weighted curvature. This is done by parametrizing the weighted curvature by the angle between the interface normal and a fixed coordinate axis, and comparing it with the weighted curvature of the approximate solution. It turns out that the crystalline approximation scheme corresponds to a standard finite difference scheme for the (nonlinear) evolution equation for the weighted curvature.

The organization of this paper is as follows: in Section 2 we set up the scheme and make some preliminary observations. In Section 3 we study the case of the ordinary heat equation. In Section 4 we prove convergence for general convex energies and constant Dirichlet boundary conditions. In Section 5 we prove convergence for constant Neumann boundary conditions. In Section 6 we set up the general Dirichlet problem. However, for general Dirichlet boundary conditions we do not prove convergence of the scheme because we have been unable to prove that the approximate solution exists up to a fixed time as the discretization gets finer. It seems plausible that, under suitable growth conditions on the energy, one should be able to bound the slope of the approximate solutions. Then convergence would follow as in Section 4. Finally, Section 7 is an appendix which outlines the physical and mathematical context of our work.

This paper is part of the first author's Ph.D. thesis.

2. Setup and preliminary observations

This paper is concerned with the convergence of an approximation scheme for the equation

$$\begin{cases} \frac{u_t}{\sqrt{1+u_x^2}} = W''(u_x) \ u_{xx} & \text{if } 0 \le x \le 1\\ u(x,0) = u_0(x) \end{cases}$$
(1.1)

For now we focus on the case of homogeneous Dirichlet boundary conditions,

$$u(0,t) = u(1,t) = 0, (1.2)$$

postponing consideration of other boundary conditions to Sections 5 and 6. If $W(u_x) = \sqrt{1 + u_x^2}$, $W''(u_x) u_{xx}$ is the curvature of the graph of u, and in general it is the negative of the gradient of

$$E(u) \stackrel{\Delta}{=} \int_0^1 W(u_x) \, dx,$$

or the weighted curvature of the graph of u. So Eq. (1) says that the normal velocity of the graph of u equals its weighted curvature.

We assume throughout that W is strictly convex and C^3 , and that Eq. (1) has a C^3 solution in $[0, 1] \times [0, T]$. The existence of a C^3 solution is guaranteed by Theorem VI.5.2 and the regularity results of Ladyženskaja, Solonnikov, and Ural'ceva [19] when W and u_0 are sufficiently smooth, u_0 satisfies compatibility conditions at zero and one, and W satisfies certain growth conditions. Appropriate growth conditions are discussed in Section 6 (see especially conditions (32)).

The numerical scheme considered in this paper arises by deriving an analogue of Eq. (1) in the setting where W is substituted by a piecewise linear function, \overline{W} , which coincides with W at its corners (see Figure 1). We now carry out this derivation. As explained in the Appendix, this has been done in a slightly different way by Gibbs (see the review Taylor [25]). The equations we will arrive at have been obtained in a physical context by Angenent and Gurtin [2].



Figure 1. The energy density W approximated by a piecewise linear function \overline{W} . The function \overline{W} coincides with W at its corners.

The approximation scheme should deal with continuous piecewise linear functions, u^m , where each segment, which from now on will be called face, has an admissible slope, i.e. has slope equal to a value of u_x corresponding to one of the corners of \overline{W} . We will refer to the set of all such functions as the set of admissible functions. For now, the parameter m has no meaning by itself, but later on it will be the maximum distance between two such adjacent values of u_x , and it will determine the rate of convergence of the scheme, thus playing a role similar to the one that the mesh size does in a finite difference scheme. We order the faces from left to right. At selected times faces will disappear and each time this happens we reorder them. So the number of faces is a piecewise constant function of time denoted simply by N. We usually keep the time dependence of such functions implicit. The exception will be u's time dependence and that of its first argument, when that argument is itself a function, which we often make explicit. Let x_i ($0 = x_0 < x_1 \cdots < x_{i-1} < x_i < \cdots < x_{N-1} < x_N = 1$) be the abscissa of the *i*th corner of u^m , l_i be the length of the projection of the *i*th face on the x-axis, and $(u_x^m)_i$ and $(u_t^m)_i$ be the values of u_x^m and u_t^m , respectively, for the *i*th face of u^m .

First of all, we focus on the initial data. Define $u_0^m(x) \stackrel{\triangle}{=} u^m(x,0)$. We assume that

 u_0^m belongs to the set of admissible functions, satisfies the boundary conditions, and jumps in $((u_0^m)_x)_i$ correspond to adjacent corners of \overline{W} (see Figure 2). (2)

This is a reasonable assumption, and we make it because our scheme will move but not create faces.





Second, we impose the boundary conditions. Since u(0,t) = u(1,t) = 0 we have to choose

$$u_t^m)_1 = 0$$
 and $(u_t^m)_N = 0$ (3)

for them to be satisfied.

Our next goal is to derive the evolution equation of u^m . Before doing this, however, we use the fact that u^m is continuous to derive some important relations. The functions u_x^m and u_t^m are discontinuous, but the vertical velocity of the *i*th corner of u^m is the same whether computed using the *i*th or (i + 1)th face. So, differentiating $u^m(x_i(t), t)$ with respect to t,

$$\dot{x}_i = -\frac{(u_t^m)_{i+1} - (u_t^m)_i}{(u_x^m)_{i+1} - (u_x^m)_i}, \quad \text{for } 1 \le i \le N - 1.$$
(4)

It is sometimes more convenient to work with the lengths of the faces rather than with the positions of the corners of u^m . Eqs. (4) imply

$$\dot{l}_{1} = \dot{x}_{1} = -\frac{(u_{t}^{m})_{2} - (u_{t}^{m})_{1}}{(u_{x}^{m})_{2} - (u_{x}^{m})_{1}},
\dot{l}_{N} = -\dot{x}_{N-1} = \frac{(u_{t}^{m})_{N} - (u_{t}^{m})_{N-1}}{(u_{x}^{m})_{N} - (u_{x}^{m})_{N-1}},$$
(5.1')

but these can be simplified using the boundary conditions. We get

$$\dot{l}_1 = \dot{x}_1 = c_1^1(u_t^m)_2, \qquad \dot{l}_N = -\dot{x}_{N-1} = c_N^{-1}(u_t^m)_{N-1}, \qquad (5.1)$$

and also (see Eqs. (10.18) of [2])

$$\dot{l}_i = \dot{x}_i - \dot{x}_{i-1} = c_i^0(u_t^m)_i + c_i^{-1}(u_t^m)_{i-1} + c_i^1(u_t^m)_{i+1}, \qquad (5.2)$$

for $2 \leq i \leq N-1$, with

$$c_{i}^{0} = \frac{1}{(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1}} + \frac{1}{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i}},$$

$$c_{i}^{-1} = -\frac{1}{(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1}},$$

$$c_{i}^{1} = -\frac{1}{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i}}.$$
(6)

Finally, we turn to determining the evolution equation of u^m . We compute the normal velocities of the faces of u^m in terms of the l_i 's. They should equal the negative of the gradient of

$$\bar{E}(u) \stackrel{\Delta}{=} \int_0^1 \bar{W}(u_x) \, dx,$$

on the space of admissible functions, at u^m . By the definition of \overline{W} ,

$$\bar{E}(u^m) = \sum_{i=1}^N W[(u^m_x)_i] \ l_i.$$

We now compute the negative of the gradient of E. Eqs. (4) imply that the rate of change of energy "at" the *i*th corner is

$$- \{ W[(u_x^m)_i] - W[(u_x^m)_{i+1}] \} \cdot \frac{(u_t^m)_{i+1} - (u_t^m)_i}{(u_x^m)_{i+1} - (u_x^m)_i}$$

and, summing in i from 1 to N-1, that the (total) rate of change in energy is

$$-\sum_{i=2}^{N-1} \left\{ \frac{W[(u_x^m)_{i+1}] - W[(u_x^m)_i]}{(u_x^m)_{i+1} - (u_x^m)_i} - \frac{W[(u_x^m)_i] - W[(u_x^m)_{i-1}]}{(u_x^m)_i - (u_x^m)_{i-1}} \right\} \cdot (u_t^m)_i \\ - \frac{W[(u_x^m)_2] - W[(u_x^m)_1]}{(u_x^m)_2 - (u_x^m)_1} \cdot (u_t^m)_1 + \frac{W[(u_x^m)_N] - W[(u_x^m)_{N-1}]}{(u_x^m)_N - (u_x^m)_{N-1}} \cdot (u_t^m)_N .$$

The boundary terms cancel because of the boundary conditions.

The preceding expression is the directional derivative of \overline{E} , in the direction of the piecewise constant function which has value $(u_t^m)_i$ for x in (x_{i-1}, x_i) , at u^m . In other words, it is equal to

$$\frac{d}{dh} \bar{E}(\phi_h) \bigg|_{h=0}$$

where ϕ_h is admissible, $\phi_0 = u^m$, and

$$\left. \frac{d\phi_h}{dh} \right|_{h=0} = (u_t^m)_i$$

for x in (x_{i-1}, x_i) .

Our space of admissible functions is somewhat unfamiliar, so perhaps some elaboration is appropriate. Suppose ϕ_h is a curve in the space of admissible functions such that $\phi_0 = u^m$. Since ϕ_h is admissible and $\phi_0 = u^m$, we see that $\frac{d\phi_h}{dh}\Big|_{h=0}$ is a piecewise constant function which is constant, with value say $(u_t^m)_i$, in the interval (x_{i-1}, x_i) . Conversely, given a piecewise constant function which is constant, so a family of admissible functions ϕ_h such that $\phi_0 = u^m$ and $\frac{d\phi_h}{dh}\Big|_{h=0} = (u_t^m)_i$ in (x_{i-1}, x_i) . To obtain such a ϕ_h one can, for example, translate the *i*th face of u^m (for each *i*) vertically by $h(u_t^m)_i$. It follows that directional derivatives of \overline{E} at u^m on the space of admissible

functions are directional derivatives in the direction of piecewise constant functions which are constant in (x_{i-1}, x_i) .

So the negative of the gradient of \overline{E} at u^m is a piecewise constant function that has value

$$\frac{\Delta_i}{l_i}, \quad \text{for } x \text{ in } (x_{i-1}, x_i), \\
\Delta_i \stackrel{\triangle}{=} \frac{W[(u_x^m)_{i+1}] - W[(u_x^m)_i]}{(u_x^m)_{i+1} - (u_x^m)_i} - \frac{W[(u_x^m)_i] - W[(u_x^m)_{i-1}]}{(u_x^m)_i - (u_x^m)_{i-1}}, \quad (7)$$

and for $2 \leq i \leq N-1$, and has value zero for x in (x_0, x_1) and (x_{N-1}, x_N) . We conclude that, for $2 \leq i \leq N-1$, the *i*th face should have

$$(u_t^m)_i = \sqrt{1 + (u_x^m)_i^2} \cdot \frac{\Delta_i}{l_i}.$$
 (8)

In summary, u^m is determined by solving Eqs. (5) with the c_i^j 's given by Eqs. (6), the $(u_t^m)_i$'s by Eqs. (3) and (8), and the Δ_i 's by Eqs. (7); the initial data should satisfy condition (2). This amounts to solving a nonlinear system of ordinary differential equations for the l_i 's.

We make here a few comments.

• For reference we note the following elementary "summation by parts" formulas:

$$\begin{split} \sum_{i=1}^{N-1} a_i(b_{i+1}-b_i) &= -\sum_{i=2}^{N-1} b_i(a_i-a_{i-1}) - a_1b_1 + a_{N-1}b_N, \\ \sum_{i=1}^{N} a_i(b_i-b_{i-1}) &= -\sum_{i=1}^{N-1} b_i(a_{i+1}-a_i) - a_1b_0 + a_Nb_N, \\ \sum_{i=1}^{N-1} a_i(b_{i+1}-b_i) &= -\sum_{i=1}^{N} b_i(a_i-a_{i-1}) - a_0b_1 + a_Nb_N. \end{split}$$

- Henceforth we write Σ_i for Σ^N_{i=1}.
 Later we will use the fact that if (u^m_x)_{i+1} = (u^m_x)_{i-1} then Δ_i = 0.
- If $W(\cdot) = \sqrt{1 + (\cdot)^2}$ then $\frac{\Delta_i}{l_i}$ may be interpreted as the "curvature of u^m at its *i*th segment."

We now make some preliminary observations about this scheme.

First, note that one can think of u^m as being defined on the whole real line, the extension being odd with period two. Then $(u_x^m)_0 = (u_x^m)_2$ implies $(u_t^m)_1 = 0$, and $(u_r^m)_{N+1} = (u_r^m)_{N-1}$ implies $(u_t^m)_N = 0$. This is important because it shows that for certain qualitative features (such as our next observation) there is no need to consider the end intervals separately. It will also be useful in our computations when we want to extend the range of some summations by adding and subtracting boundary terms. For example, in the expression for the total rate of change of energy we can let the sum run from 1 to N. Then the new boundary term at x = 0 is

$$-\frac{W[(u_x^m)_1] - W[(u_x^m)_0]}{(u_x^m)_1 - (u_x^m)_0} \cdot (u_t^m)_1.$$

Remark: Eqs. (7) and (8) now hold for *i* equal to 1 and *N*.

Second. we show that

even as time evolves and certain faces disappear, jumps in $(u_x^m)_i$ correspond to adjacent corners of \overline{W} , (9)

(10)

the maximum principle holds for u_t^m ,

i.e. u_t^m is bounded above by its maximum at time zero. Statement (9) has also been noted by Taylor [26]. Notice the simple but important consequence of statement (9) that if $(u_x^m)_i$ is smaller or greater than both $(u_x^m)_{i-1}$ and $(u_x^m)_{i+1}$ then $(u_x^m)_{i-1} = (u_x^m)_{i+1}$. Preparing for the proof, we note that if statement (9) is true at time t then, at that time,

$$c_i^0 (u_t^m)_i \ge 0, \qquad c_i^{-1} (u_t^m)_{i-1} \le 0, \qquad c_i^1 (u_t^m)_{i+1} \le 0,$$

since Δ_i , and consequently $(u_t^m)_i$, has the same sign as $(u_x^m)_{i+1} - (u_x^m)_{i-1}$, due to the convexity of W. We proceed in four steps:

- Statement (9) holds at time zero, by condition (2). It clearly continues to hold until the time t₁ when one or more faces disappear.
- The maximum principle holds for u_t^m for $t < t_1$. This is a consequence of the fact that if $\max_{1 \le i \le N} (u_t^m)_i$ is positive then it is non-increasing. For the proof, suppose the maximum occurs at the *i*th face. Then $(u_x^m)_{i+1} - (u_x^m)_{i-1} > 0$. This together with statement (9) implies $(u_x^m)_{i-1} < (u_x^m)_i < (u_x^m)_{i+1}$; the first of these inequalities gives $c_i^{-1} < 0$ and the second $c_i^1 < 0$. It follows that the right hand side of Eq. (5.2) is bounded below by $c_i^0 (u_t^m)_i + c_i^{-1} (u_t^m)_i + c_i^1 (u_t^m)_i = 0$. The left hand side of Eq. (5.2) is

$$\dot{l}_i = -\sqrt{1 + (u_x^m)_i^2} \frac{\Delta_i}{(u_t^m)_i^2} (u_t^m)_i',$$

by Eq. (8), where $(u_t^m)'_i$ is the derivative of $(u_t^m)_i$ $((u_t^m)'_i = (u_{tt}^m)_i)$. Therefore $(u_t^m)'_i \leq 0$.

- Statement (9) holds at time t_1 . Appealing again to Eq. (8), we see that only inflection faces can disappear, and the l_i 's have well defined limits at time t_1 . Of course, no three or more adjacent faces i, \ldots, j can disappear at time t_1 for, if that were the case, by Eqs. (5.2), $\dot{l}_{i+1} = \cdots = \dot{l}_{j-1} = 0$ for $t < t_1$. At time t_1 two cases are possible:
 - Case (i) The face i disappears without its adjacent neighbors disappearing. Then $\Delta_i = 0$ and $(u_x^m)_{i+1} = (u_x^m)_{i-1}$. At time t_1 the faces i 1 and i + 1 join to from a single face. (Note that in this case, for $t < t_1, \Delta_{i-1}\Delta_{i+1} \leq 0$, since either we have $(u_x^m)_{i-1} < (u_x^m)_i$ and $(u_x^m)_i > (u_x^m)_{i+1}$, or else the opposite of both of these inequalities.) - Case (ii) The faces i - 1 and i disappear without their adjacent neighbors doing so. Then $\Delta_{i-1} = \Delta_i = 0, (u_x^m)_{i-2} = (u_x^m)_i$ and
 - $(u_x^m)_{i-1} = (u_x^m)_{i+1}$, and $(u_x^m)_{i-2}$ and $(u_x^m)_{i+1}$ correspond to adjacent corners of \overline{W} .
- If the maximum of u_t^m is discontinuous at time t_1 then it can only jump down. In fact, consider what happens in each of the cases above:
 - Case (i) If the (i 1)th and (i + 1)th faces join to form an inflection face then for this new face $u_t^m = 0$. Otherwise the new face has a value of Δ different from zero. If $\Delta_{i-1}\Delta_{i+1} < 0$ for $t < t_1$ then the new face has a Δ equal to Δ_{i-1} or Δ_{i+1} (and the length of the new face at time t_1 is greater than the limit of the lengths of both l_{i-1} and l_{i+1} as t approaches t_1 from below). If $\Delta_{i-1}\Delta_{i+1} = 0$ for $t < t_1$ then the new face might have a Δ different from Δ_{i-1} and Δ_{i+1} . But then its Δ must be equal to the value of Δ_j for some j such that the jth face joins the (i - 1)th and (i + 1)th ones at time t_1 to form the new face. (In this case the length of the new face at time t_1 is greater than the limit of the length of l_j as t approaches t_1 .)

- Case (*ii*) The faces i - 2 and i + 1 do not join to form a new face. Therefore at time t_1 the maximum of u_t^m can only decrease.

By applying the above reasoning repeatedly, we conclude that statement (9) and the maximum principle for u_t^m hold for all time. The above shows in particular that u^m exists for all time.

Third, we note the discrete analogue of $\frac{d}{dt} \frac{1}{2} \int_0^1 u_x^2 dx = -\int_0^1 u_t u_{xx} dx + u_t(1,t) u_x(1,t) - u_t(0,t) u_x(0,t)$. This is an identity valid for any function u. The discrete version applies to any admissible function u^m , i.e. one which is piecewise linear in space with slopes $(u_x^m)_i$, such that the jumps in $(u_x^m)_i$ correspond to adjacent corners of \overline{W} . The proof uses only Eqs. (5.1') and (5.2), not the discretized differential equation (8) or the Dirichlet boundary condition (5.1):

$$\frac{d}{dt} \frac{1}{2} \sum_{i} (u_{x}^{m})_{i}^{2} l_{i} = \frac{1}{2} \sum_{i=2}^{N-1} (u_{x}^{m})_{i}^{2} [c_{i}^{0}(u_{t}^{m})_{i} + c_{i}^{-1}(u_{t}^{m})_{i-1} + c_{i}^{1}(u_{t}^{m})_{i+1}] \\
+ \frac{1}{2} (u_{x}^{m})_{1}^{2} c_{1}^{1}(u_{t}^{m})_{2} + \frac{1}{2} (u_{x}^{m})_{N}^{2} c_{N}^{-1}(u_{t}^{m})_{N-1} \\
- \frac{1}{2} (u_{x}^{m})_{1}^{2} c_{1}^{1}(u_{t}^{m})_{1} - \frac{1}{2} (u_{x}^{m})_{N}^{2} c_{N}^{-1}(u_{t}^{m})_{N} \\
= \frac{1}{2} \sum_{i=2}^{N-1} (u_{t}^{m})_{i} [c_{i}^{0}(u_{x}^{m})_{i}^{2} + c_{i+1}^{-1}(u_{x}^{m})_{i+1}^{2} + c_{i-1}^{1}(u_{x}^{m})_{i-1}^{2}] \\
- \frac{1}{2} (u_{x}^{m})_{1}^{2} c_{1}^{1}(u_{t}^{m})_{1} - \frac{1}{2} (u_{x}^{m})_{N}^{2} c_{N}^{-1}(u_{t}^{m})_{N} \\
+ \frac{1}{2} (u_{x}^{m})_{2}^{2} c_{2}^{-1}(u_{t}^{m})_{1} + \frac{1}{2} (u_{x}^{m})_{N-1}^{2} c_{N-1}^{1}(u_{t}^{m})_{N} \\
= - \frac{1}{2} \sum_{i=2}^{N-1} (u_{t}^{m})_{i} [(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i-1}] \\
- \frac{1}{2} (u_{t}^{m})_{1} [(u_{x}^{m})_{1} + (u_{x}^{m})_{2}] \\
+ \frac{1}{2} (u_{t}^{m})_{N} [(u_{x}^{m})_{N-1} + (u_{x}^{m})_{N}].$$

For the solution of Eq. (1) we have $\frac{d}{dt} \int_0^1 u_x^2 dx \leq 0$. Similarly, for the solution of the discretized problem with homogeneous Dirichlet boundary condition we see from Eq. (11) that $\frac{d}{dt} \sum_i (u_x^m)_i^2 l_i \leq 0$.

Fourth, $\overline{E}(u^m)(\cdot)$ is a continuous function of t but is only piecewise C^1 because faces disappear at selected times. We will not mention this restriction again, although it will come up repeatedly, since it is of no consequence for our analysis.

Fifth and last, the maximum principle holds for u^m because an interior maximum will occur at the *i*th corner $(1 \leq i \leq N - 1)$ only if $(u_x^m)_i > (u_x^m)_{i+1}$ and in this case both $(u_t^m)_i$ and $(u_t^m)_{i+1}$ are nonpositive.

3. Convergence for the heat equation

Before proving convergence of the approximation scheme for Eq. (1), let us treat the simpler case of the corresponding approximation scheme for the heat equation,

$$\begin{cases} u_t = u_{xx} & \text{if } 0 \le x \le 1\\ u(x,0) = u_0(x) & .\\ u(0,t) = u(1,t) = 0 \end{cases}$$
(12)

In this case

$$W(u_x) = \frac{1}{2} u_x^2$$

and

$$(u_t^m)_i = \frac{\Delta_i}{l_i}, \qquad \Delta_i = \frac{(u_x^m)_{i+1} - (u_x^m)_{i-1}}{2}.$$
 (13)

We shall estimate the growth of the H^1 norm of $u - u^m$.

The calculation in this section would be simplest if we took full advantage of the boundary conditions, dropping terms such as $u_t(0,t)$ or $(u_t^m)_1$ which vanish due to Eqs. (1.2) and (3). This would be inefficient because it would force us to repeat many calculations in Sections 5 and 6, where we consider other boundary conditions. We therefore proceed as follows:

- The Dirichlet boundary conditions u(1,t) = 0 and $(u_t^m)_N = 0$ will be used at x = 1, and we shall drop terms which vanish as a result.
- The Dirichlet boundary conditions will also be used at x = 0, but we shall label ((i) through (vii)) the associated boundary terms the first time they appear for future reference. Then these terms will be dropped since they vanish due to u(0,t) = 0 and $(u_t^m)_1 = 0$.
- In Sections 5 and 6 we will deal with boundary conditions other than the homogeneous one $u(0,t) = (u_t^m)_1 = 0$. Specialized to the case of the heat equation, they lead to relations of the form

$$(u_t^m)_1 = \frac{\Delta_1}{l_1} r_1, \tag{14}$$

where r_1 is a function of time, $0 < r_1 \leq 1$, and Δ_1 is defined by Eq. (7) for i = 1. Notice that Δ_1 depends on $(u_x^m)_0, (u_x^m)_1$, and $(u_x^m)_2$.

- To impose the Dirichlet boundary condition $u^m(0,t) = 0$, one should take $(u_x^m)_0 = (u_x^m)_2$, corresponding to the odd, periodic extension of u^m . This yields $\Delta_1 = 0$ and $(u_t^m)_1 = 0$, as noted above. In this case we may as well set $r_1 = 1$ since both sides of Eq. (14) vanish.
- It is convenient to unify Eqs. (13) and (14) by writing

$$(u_t^m)_i = \frac{\Delta_i}{l_i} r_i,$$

for $1 \leq i \leq N$, with $r_2 = \cdots = r_N = 1$, and $0 < r_1 \leq 1$. Zero boundary conditions at x = 1 imply $\Delta_N = 0$, just as zero boundary conditions at x = 0 imply $\Delta_1 = 0$.

• At risk of redundancy, we emphasize: for homogeneous Dirichlet boundary conditions it suffices to set $u_t(0,t) = 0$, $(u_t^m)_1 = 0$, $r_1 = r_2 = \cdots = r_N = 1$, and $(u_x^m)_0 = (u_x^m)_2$ in the calculation that follows, and the boundary terms (i) through (vii) all vanish.

One further remark. The right hand side of Eq. (11) can be written

$$-\frac{1}{2} \sum_{i=2}^{N-1} (u_t^m)_i \left[(u_x^m)_{i+1} - (u_x^m)_{i-1} \right] -\frac{1}{2} (u_t^m)_1 \left[(u_x^m)_2 - (u_x^m)_0 \right] r_1 -\frac{1}{2} (u_t^m)_1 \left[(u_x^m)_0 r_1 + (u_x^m)_1 + (u_x^m)_2 (1 - r_1) \right].$$
(15)

For the case of the heat equation, discretized as above, this becomes

$$-\sum_{i=2}^{N-1} (u_t^m)_i^2 l_i - (u_t^m)_1^2 l_1$$
$$-\frac{1}{2} (u_t^m)_1 [(u_x^m)_0 r_1 + (u_x^m)_1 + (u_x^m)_2 (1 - r_1)].$$

Now we begin the convergence analysis. We have

$$\frac{d}{dt} \frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx = \frac{d}{dt} \left[\frac{1}{2} \int_0^1 u_x^2 dx + \frac{1}{2} \sum_i (u_x^m)_i^2 l_i - \sum_i \int_{x_{i-1}}^{x_i} u_x u_x^m \right]$$
$$= -\int_0^1 u_t^2 dx \underbrace{-u_t(0,t) \ u_x(0,t)}_{(i)} - \sum_i (u_t^m)_i^2 l_i$$

$$\underbrace{-\frac{1}{2} (u_t^m)_1 [(u_x^m)_0 r_1 + (u_x^m)_1 + (u_x^m)_2 (1 - r_1)]}_{\text{(ii)}}_{\text{(ii)}} \\ - \frac{d}{dt} \sum_i (u_x^m)_i [u(x_i(t), t) - u(x_{i-1}(t), t)] \\ = -\int_0^1 |u_t - u_t^m|^2 dx \underbrace{-2 \int_0^1 u_t u_t^m dx}_A \\ - \underbrace{\sum_i (u_x^m)_i [u_x(x_i(t), t) \dot{x}_i - u_x(x_{i-1}(t), t) \dot{x}_{i-1}]}_B \\ - \underbrace{\sum_i (u_x^m)_i [u_t(x_i(t), t) - u_t(x_{i-1}(t), t)]}_C$$

We have dropped the terms which vanish due to the homogeneous boundary condition, as we announced we would do. We rewrite A and B:

$$A = -2 \sum_{i} (u_{t}^{m})_{i} [u_{x}(x_{i}(t), t) - u_{x}(x_{i-1}(t), t)],$$

$$B = \sum_{i=1}^{N-1} u_{x}(x_{i}(t), t) [(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i}] \dot{x}_{i} + u_{x}(0, t) (u_{x}^{m})_{1} \dot{x}_{0}$$

$$= -\sum_{i=1}^{N-1} u_{x}(x_{i}(t), t) [(u_{t}^{m})_{i+1} - (u_{t}^{m})_{i}]$$

$$= \sum_{i} (u_{t}^{m})_{i} [u_{x}(x_{i}(t), t) - u_{x}(x_{i-1}(t), t)] + (u_{t}^{m})_{1} u_{x}(0, t). \quad (16)$$

Note that we have used Eqs. (4). So,

$$A + B = -\sum_{i} (u_t^m)_i \left[u_x(x_i(t), t) - u_x(x_{i-1}(t), t) \right]$$

$$= \sum_{i} \left[\frac{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i-1}}{2 l_{i}} r_{i} \right] \left[-u_{x}(x_{i}(t), t) + u_{x}(x_{i-1}(t), t) \right]$$

$$= \frac{1}{2} \sum_{i} \left[(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i} \right] \left[-\frac{u_{x}(x_{i}(t), t) - u_{x}(x_{i-1}(t), t)}{l_{i}} \right] r_{i}$$

$$+ \frac{1}{2} \sum_{i} \left[(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1} \right] \left[-\frac{u_{x}(x_{i}(t), t) - u_{x}(x_{i-1}(t), t)}{l_{i}} \right] r_{i}.$$

On the other hand,

$$C = \sum_{i=1}^{N-1} u_t(x_i(t), t) \cdot [(u_x^m)_{i+1} - (u_x^m)_i] + u_t(0, t) (u_x^m)_1}{(iv)}$$
(17)
$$= \frac{1}{2} \sum_i [(u_x^m)_{i+1} - (u_x^m)_i] \cdot [u_t(x_i(t), t)]$$
$$+ \frac{1}{2} \sum_i [(u_x^m)_i - (u_x^m)_{i-1}] \cdot [u_t(x_{i-1}(t), t)]$$
$$- \frac{1}{2} u_t(0, t) [(u_x^m)_1 - (u_x^m)_0].$$
(v)

Hence, A + B + C equals

$$+\sum_{i} \frac{1}{4} \left[(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i} \right] \cdot \left[u_{xxx}(\alpha_{i}(t), t) \right] r_{i} l_{i}$$

$$-\sum_{i} \frac{1}{4} \left[(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1} \right] \cdot \left[u_{xxx}(\beta_{i}(t), t) \right] r_{i} l_{i}$$

$$+\frac{1}{2} u_{t}(0, t) \left[(u_{x}^{m})_{1} - (u_{x}^{m})_{0} \right] (1 - r_{1})$$
(vi)
$$+\frac{1}{2} u_{t}(x_{1}(t), t) \left[(u_{x}^{m})_{2} - (u_{x}^{m})_{1} \right] (1 - r_{1}),$$

for some α_i and β_i belonging to (x_{i-1}, x_i) . The last term in this sum can be written as

$$\frac{1}{2} u_t(x_1(t), t) [(u_x^m)_2 - (u_x^m)_1] (1 - r_1)$$

$$= \underbrace{+ \frac{1}{2} u_t(0, t) [(u_x^m)_2 - (u_x^m)_1] (1 - r_1)}_{(\text{vii})}$$

$$+ \frac{1}{2} [(u_x^m)_2 - (u_x^m)_1] u_{xxx}(\gamma_1(t), t) (1 - r_1) l_1,$$

for some γ_1 belonging to $(0, x_1)$. For zero boundary conditions each of (i) through (vii) vanishes. We stop to note that our calculation was exact up to here. We will now bound A + B + C. The final bound for the L^2 norm of $u_x - u_x^m$ will be sharp inasmuch as the next bound is optimum. The terms corresponding to α_1 and γ_1 combine and we obtain

$$|A + B + C| \leq \frac{1}{2} ||u_{xxx}||_{\infty}(t) \max_{1 \leq i \leq N+1} |(u_x^m)_i - (u_x^m)_{i-1}|;$$

here $|| ||_{\infty}$ is the supremum norm in x on the interval [0, 1]. Thus the accuracy of the discretization is governed by

$$m \stackrel{\Delta}{=} \max_{1 \le i \le N+1} | (u_x^m)_i - (u_x^m)_{i-1} |.$$
(18)

The parameter m controls the convergence of the scheme in much the way the mesh size controls the behavior of a finite difference approximation. Notice that our estimates do not require any uniformity on the quantities $|(u_x^m)_i - (u_x^m)_{i-1}|$ as i varies.

To recapitulate, we have shown that if u solves the heat equation (12) and u^m solves its discretized version, both with homogeneous Dirichlet boundary conditions, then

$$\frac{d}{dt} \frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx \leq -\int_0^1 |u_t - u_t^m|^2 dx + \frac{1}{2} m ||u_{xxx}||_{\infty}(t),$$

Suppose that the discrete initial data u_0^m have been chosen so that

$$|| (u_0^m)_x - (u_0)_x ||_{\infty} \le m.$$
(19)

Then the error at time t is

$$\frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx \le \frac{1}{2} m^2 + \frac{1}{2} m \int_0^t ||u_{xxx}||_{\infty}(\tau) d\tau.$$
(20)

By Poincaré's inequality the L^2 norm of $u\ -\ u^m$ is controlled by the L^2 norm of its spatial derivative. We conclude that

$$\sup_{0 \le t \le T} || u - u^m ||_{H^1([0,1])} \le c m^{\frac{1}{2}},$$

with c depending on u and T but not on m.

Since we are assuming u_0 is C^3 , one can choose u_0^m such that the hypothesis (19) is satisfied. For example, one can proceed as follows. First, identify all the points where $(u_0)_x$ is admissible and draw the tangents to u_0 through those points. Next, draw a line through each inflection point \check{x} of u^m with the admissible slope $(u_x^m)_i$ closest to the value of $(u_0)_x(\check{x})$ and such that $|(u_x^m)_i| > |(u_0)_x(\check{x})|$. Then, draw a line through (0,0) with the admissible slope closest to the value of $(u_0)_x(0)$ and greater than (respectively, less than) $(u_0)_x(0)$ if $(u_0)_{xx}(0) < 0$ $((u_0)_{xx}(0) > 0)$; if zero is an inflection point of u_0 disregard this step. Do a similar construction at the point one. Finally, obtain u_0^m by the union of segments on the lines above.

It is worth noting that, for relatively large times t, error estimate (20) is dominated by the term $m \int_0^t ||u_{xxx}||_{\infty}(\tau) d\tau$, not by the approximation of the initial data. A cruder approximation of the initial data, $||(u_0^m)_x - (u_0)_x||_{L^2([0,1])}^2 = O(m)$, would not affect the order of convergence.

Remark. We collect the boundary terms which entered in the calculation above because we will need them later. They were:

(i) =
$$-u_t(0,t) u_x(0,t)$$
,
(ii) = $-\frac{1}{2}(u_t^m)_1 [(u_x^m)_0 r_1 + (u_x^m)_1 + (u_x^m)_2(1-r_1)]$,
(iii) = $(u_t^m)_1 u_x(0,t)$,
(iv) + (v) + (vi) + (vii) = $\frac{1}{2}u_t(0,t) [(u_x^m)_0 r_1 + (u_x^m)_1 + (u_x^m)_2(1-r_1)]$.

If $(u_t^m)_1 = u_t(0,t)$, as in Section 6, then the sum (i) through (vii) is zero. Alternatively, if $(u_x^m)_1 = u_x(0,t)$, as in Section 5, then

(ii) + (iii) =
$$\frac{1}{2}(u_t^m)_1[-(u_x^m)_0r_1 + (u_x^m)_1 - (u_x^m)_2(1-r_1)],$$

(i) + (iv) + (v) + (vi) + (vii) = $\frac{1}{2}u_t(0,t) [(u_x^m)_0r_1 - (u_x^m)_1 + (u_x^m)_2(1-r_1)].$

Before proceeding to the next section we make a final remark. If the distance between any two adjacent admissible slopes is a fixed constant, i.e. the mesh in the u_x -axis of Figure 1 is uniform, then it might be possible to improve the bound for A + B + C. In fact, if the *i*th is not an inflection face of u^m then either $(u_x^m)_{i-1} < (u_x^m)_i < (u_x^m)_{i+1}$ or both these inequalities are reversed. In either case the absolute value of the *i*th term in the expression for the sum of A + B + Cis equal to

$$\frac{1}{4} m \mid u_{xxxx}(\mu_i(t), t) \ l_i \ (\alpha_i(t) - \beta_i(t)) \mid,$$

for some μ_i belonging to (x_{i-1}, x_i) , so less than

$$\frac{1}{4} m \mid\mid u_{xxxx} \mid\mid_{\infty}(t) l_i^2$$

If the *i*th is an inflection face of u^m then the *i*th term of A + B + C is bounded by

$$\frac{1}{2} m \mid\mid u_{xxx} \mid\mid_{\infty}(t) l_i.$$

Hence

$$|A + B + C| \leq \frac{1}{4} m || u_{xxxx} ||_{\infty}(t) \sum_{i} l_{i}^{2} + \frac{1}{2} m || u_{xxxx} ||_{\infty}(t) \sum_{\substack{i \text{ th an} \\ infl_{face}}} l_{i}$$

This suggests that to get a sharper estimate than the one obtained above one should bound $\max_i l_i$ on an interval [0, T] in terms of m. Note that for the present case Eqs. (5.2) reduce to

between inflection faces.

4. Convergence for general convex energies

We turn now to proving convergence of the approximation scheme described in Section 2, for Eq. (1). The argument is in many respects similar to that for the heat equation. Of course, the functions u and u^m are defined differently than they were in Section 3, because we are solving different differential equations. However, we shall keep the notation and labels used in the previous section to highlight the parallels between the two calculations. We shall also keep the conventions concerning the handling of boundary terms.

The main idea is, once again, to control the evolution of the H^1 norm of $u - u^m$. Arguing as before, we get

$$\frac{d}{dt} \frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx = \frac{d}{dt} \left[\frac{1}{2} \int_0^1 u_x^2 dx + \frac{1}{2} \sum_i (u_x^m)_i^2 l_i - \sum_i \int_{x_{i-1}}^{x_i} u_x u_x^m \right]$$

We have used expression (15) and Eqs. (16) and (17). It is still convenient to rewrite B:

if for the values of i such that $(u^m_x)_{i+1} = (u^m_x)_{i-1}$ we define

$$\frac{(u_t^m)_i}{(u_x^m)_{i+1} - (u_x^m)_{i-1}} r_i$$

to be zero. For such an i the ith term in I + II is

$$-\int_{x_{i-1}}^{x_i} \sqrt{1 + u_x^2} W''(u_x) u_{xx}^2 dx.$$

The term I is analogous to the term $-\int_0^1 |u_t - u_t^m|^2 dx$ in Section 3. It is negative. The analogue of II is identically zero for the heat equation. So II is an error term due to the nonlinearity of the equation. The terms C and D will combine much as A + B + C did above.

To estimate C + D, it is convenient to introduce \tilde{W} ,

$$\tilde{W}''(y) \stackrel{\triangle}{=} \sqrt{1 + y^2} W''(y). \tag{22}$$

Notice that Eq. (1.1) can be written in divergence form

$$u_t = (\tilde{W}'(u_x))'$$

We proceed essentially as we did for the heat equation. On the one hand,

$$u_t(x_i(t), t) = \sqrt{1 + u_x^2(x_i(t), t)} W''(u_x(x_i(t), t)) u_{xx}(x_i(t), t)$$

= $\frac{d}{dx} \tilde{W}'(u_x(x, t)) \Big|_{x = x_i(t)}$.

On the other hand, D equals

$$-\sum_{i} \left[\tilde{W}'(u_{x}(x_{i}(t),t)) - \tilde{W}'(u_{x}(x_{i-1}(t),t)) \right] \frac{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i-1}}{2l_{i}} r_{i} = \frac{1}{2} \sum_{i} \left[(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i} \right] \left[- \frac{\tilde{W}'(u_{x}(x_{i}(t),t)) - \tilde{W}'(u_{x}(x_{i-1}(t),t))}{l_{i}} \right] r_{i} + \frac{1}{2} \sum_{i} \left[(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1} \right] \left[- \frac{\tilde{W}'(u_{x}(x_{i}(t),t)) - \tilde{W}'(u_{x}(x_{i-1}(t),t))}{l_{i}} \right] r_{i} .$$

Therefore C + D equals

$$-\sum_{i} \frac{1}{4} \left[(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1} \right] \cdot \frac{d^{2}}{dx^{2}} \left[\tilde{W}'(u_{x}(x,t)) \right] \Big|_{x = \zeta_{i}(t)} r_{i} l_{i} \qquad (24)$$

$$+ \frac{1}{2} u_{t}(x_{1}(t), t) \left[(u_{x}^{m})_{2} - (u_{x}^{m})_{1} \right] (1 - r_{1}) + (vi).$$
some ξ_{i} and ζ_{i} belonging to $(r_{i-1} - r_{i})$ But

for some ξ_i and ζ_i belonging to (x_{i-1}, x_i) . But,

$$\frac{1}{2} u_t(x_1(t), t) \left[(u_x^m)_2 - (u_x^m)_1 \right] (1 - r_1) = \\ \frac{1}{2} \left[(u_x^m)_2 - (u_x^m)_1 \right] \cdot \frac{d^2}{dx^2} \left[\tilde{W}'(u_x(x, t)) \right] \Big|_{x = \varphi_1(t)} (1 - r_1) l_1 + (\text{vii}),$$

for some φ_1 belonging to $(0, x_1)$. For zero boundary conditions each of (i) through (vii) vanishes. The terms corresponding to ξ_1 and φ_1 combine and we obtain

$$|C + D| \leq \frac{1}{2} m \left\| \frac{d^2}{dx^2} \tilde{W}'(u_x) \right\|_{\infty} (t).$$
 (25)

It remains to estimate II, which we write $II = \sum_i II_i$. If $(u_x^m)_{i+1} = (u_x^m)_{i-1}$ then

$$II_i = -\int_{x_{i-1}}^{x_i} \sqrt{1 + u_x^2} W''(u_x) u_{xx}^2 dx$$

is negative. So we need only consider i such that $(u_x^m)_{i+1} \neq (u_x^m)_{i-1}$. By the inequality $ab \leq \frac{\delta}{2}a^2 + \frac{1}{2\delta}b^2$,

$$| II_{i} | \leq \underbrace{\frac{\delta}{2} \int_{x_{i-1}}^{x_{i}} \left[u_{xx} - \frac{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i-1}}{2l_{i}} r_{i} \right]^{2} dx}_{(II_{1})_{i}} + \frac{1}{2\delta} \int_{x_{i-1}}^{x_{i}} u_{xx}^{2} \left[\sqrt{1 + u_{x}^{2}} W''(u_{x}) - \frac{(u_{t}^{m})_{i}}{\frac{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i-1}}{2l_{i}}} r_{i}} \right]^{2} dx, \underbrace{(II_{2})_{i}}_{(II_{2})_{i}}$$

with δ an arbitrary positive number. We shall control $(II_1)_i$ later, by showing that it is dominated by the corresponding term of I, if δ is sufficiently small. In order to estimate the term $(II_2)_i$, we rewrite the two terms on the right hand side of Eqs. (7) using Taylor's expansion,

$$\begin{aligned} \frac{W[(u_x^m)_{i+1}] - W[(u_x^m)_i]}{(u_x^m)_{i+1} - (u_x^m)_i} &= W'[(u_x^m)_i] + \frac{1}{2} W''[(u_x^m)_i] \left[(u_x^m)_{i+1} - (u_x^m)_i \right] \\ &+ \frac{1}{6} W'''(\theta_i) \left[(u_x^m)_{i+1} - (u_x^m)_i \right]^2, \\ \frac{W[(u_x^m)_i] - W[(u_x^m)_{i-1}]}{(u_x^m)_i - (u_x^m)_{i-1}} &= W'[(u_x^m)_i] - \frac{1}{2} W''[(u_x^m)_i] \left[(u_x^m)_i - (u_x^m)_{i-1} \right] \\ &+ \frac{1}{6} W'''(\vartheta_{i-1}) \left[(u_x^m)_i - (u_x^m)_{i-1} \right]^2, \end{aligned}$$

where θ_i , ϑ_i belong to the interval with endpoints $(u_x^m)_i$ and $(u_x^m)_{i+1}$. We have not yet used the discretized differential equation; recall that $(u_t^m)_i = \sqrt{1 + (u_x^m)_i^2} \frac{\Delta_i}{l_i} r_i$. We get

$$\frac{(u_t^m)_i}{(u_x^m)_{i+1} - (u_x^m)_{i-1}} r_i = \sqrt{1 + (u_x^m)_i^2} \frac{\Delta_i}{(u_x^m)_{i+1} - (u_x^m)_{i-1}}$$
$$= \sqrt{1 + (u_x^m)_i^2} W''[(u_x^m)_i] + \hat{E}_i, \quad (26)$$

where

_

$$|\hat{E}_{i}| \leq \frac{1}{3}\sqrt{1 + (u_{x}^{m})_{i}^{2}} |W^{\prime\prime\prime}(\theta_{i})| |(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i}| + \frac{1}{3}\sqrt{1 + (u_{x}^{m})_{i}^{2}} |W^{\prime\prime\prime}(\vartheta_{i-1})| |(u_{x}^{m})_{i} - (u_{x}^{m})_{i-1}|.$$

$$(27)$$

We use here the fact that $|(u_x^m)_{i+1} - (u_x^m)_i|$, $|(u_x^m)_i - (u_x^m)_{i-1}| \le |(u_x^m)_{i+1} - (u_x^m)_{i-1}|$, since $(u_x^m)_i$ is between $(u_x^m)_{i-1}$ and $(u_x^m)_{i+1}$, because $(u_x^m)_{i+1} \ne (u_x^m)_{i-1}$. It follows that

$$\sqrt{1 + u_x^2} W''(u_x) - \frac{(u_x^m)_i}{(u_x^m)_{i+1} - (u_x^m)_{i-1}} r_i = \\ \tilde{W}'''(\eta_i(x,t)) [u_x - (u_x^m)_i] - \hat{E}_i$$

for some η_i in the interval with endpoints $(u_x^m)_i$ and $u_x(x,t)$, and thus

$$|(\Pi_{2})_{i}| \leq \frac{1}{\delta} \int_{x_{i-1}}^{x_{i}} u_{xx}^{2} [\tilde{W}^{\prime\prime\prime}(\eta_{i}(x,t))]^{2} |u_{x} - (u_{x}^{m})_{i}|^{2} dx$$

$$\underbrace{+ \frac{1}{\delta} \int_{x_{i-1}}^{x_{i}} u_{xx}^{2} \hat{E}_{i}^{2} dx}_{E_{i}}.$$

$$\underbrace{E_{i}}$$

These terms are clearly controllable.

We reorganize, $I + II + C + D = (I + II_1) + (II_2 - E) + C + D + E$ (there is no risk of confusing this E with the energy). We have shown that

$$\frac{d}{dt} \frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx = \underbrace{\sum_{i \in III_i} H_i}_{III} + \underbrace{\sum_{i \in IV_i} H_i}_{IV} + C + D + \underbrace{\sum_{i \in E_i} H_i}_{E},$$

with

$$\begin{split} III_{i} & \triangleq \begin{cases} -\int_{x_{i-1}}^{x_{i}} \Xi_{i} \left[u_{xx} - \frac{(u_{x}^{m})_{i+1} - (u_{x}^{m})_{i-1}}{2l_{i}} r_{i} \right]^{2} dx \\ & \text{if } (u_{x}^{m})_{i+1} \neq (u_{x}^{m})_{i-1} \\ -\int_{x_{i-1}}^{x_{i}} \sqrt{1 + u_{x}^{2}} W''(u_{x}) u_{xx}^{2} dx & \text{if } (u_{x}^{m})_{i+1} = (u_{x}^{m})_{i-1} \end{cases}, \\ IV_{i} & \triangleq \begin{cases} \frac{1}{\delta} \int_{x_{i-1}}^{x_{i}} u_{xx}^{2} \left[\tilde{W}'''(\eta_{i}(x,t)) \right]^{2} \mid u_{x} - (u_{x}^{m})_{i} \mid^{2} dx \\ 0 & \text{if } (u_{x}^{m})_{i+1} \neq (u_{x}^{m})_{i-1} \end{cases}, \\ 0 & \text{if } (u_{x}^{m})_{i+1} = (u_{x}^{m})_{i-1} \\ 0 & \text{if } (u_{x}^{m})_{i+1} = (u_{x}^{m})_{i-1} \end{cases}, \\ E_{i} & \triangleq \begin{cases} \frac{1}{\delta} \int_{x_{i-1}}^{x_{i}} u_{xx}^{2} \hat{E}_{i}^{2} dx & \text{if } (u_{x}^{m})_{i+1} \neq (u_{x}^{m})_{i-1} \\ 0 & \text{if } (u_{x}^{m})_{i+1} = (u_{x}^{m})_{i-1} \end{cases}, \end{split}$$

and

$$\Xi_i \stackrel{\triangle}{=} \frac{(u_t^m)_i}{\frac{(u_x^m)_{i+1} - (u_x^m)_{i-1}}{2 \, l_i} r_i} - \frac{\delta}{2}.$$

We can now prove the following

Theorem: Let u be a C^3 solution of Eq. (1.1) with homogeneous Dirichlet boundary condition Eq. (1.2). Let u^m solve the discretized problem presented in Section 2. Suppose that the initial data for u^m satisfies

$$|| (u_0^m)_x - (u_0)_x ||_{\infty} \le m$$
(28)

and

$$|[(u_0^m)_x]_i - [(u_0^m)_x]_{i-1}| \le m \quad \text{for all } i.$$
(29)

Then

$$\Upsilon \stackrel{\triangle}{=} \frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx \tag{30}$$

satisfies a differential inequality of the form

$$\frac{d\Upsilon}{dt} \leq \Lambda(t) \Upsilon + \Gamma(t) m \tag{31}$$

when m is sufficiently small. The coefficients Λ and Γ are independent of m, though they depend upon the underlying solution u. In particular, for any T > 0,

$$\sup_{0 \le t \le T} || u - u^m ||_{H^1([0,1])} \le C_T m^{\frac{1}{2}}$$

Proof. Before we start, note that it is always possible to choose initial data satisfying conditions (28) and (29). This was discussed in Section 3.

Recall from Section 2 that the discrete evolution never introduces new faces after the initial time. This fact together with hypothesis (28) implies that $\max_i \{(u_x^m)_i\}$ is bounded with the bound uniform in m. Furthermore, because of (9) on page 6 and hypothesis (29),

$$\max_{i} |(u_x^m)_i - (u_x^m)_{i-1}| \le m$$

for all time, not just for time zero.

Almost all the work for the theorem has already been done. The principal task that remains is to choose the parameter δ in such a way that $\Xi_i \geq 0$ whenever $(u_x^m)_{i+1} \neq (u_x^m)_{i-1}$. From Eq. (26) and inequality (27) we see that there exist constants c_1 and c_2 such that

$$\frac{(u_t^m)_i}{(u_x^m)_{i+1} - (u_x^m)_{i-1}} \ge c_1 - c_2 m,$$

with both these quantities strictly positive. Their values depend only on the maximum and minimum slopes of the initial data, and on the properties of the "surface energy" function W. We restrict m to $m \leq c_1/(2c_2)$ and take $\delta = c_1$. Then $\Xi_i \geq 0$ and III is nonpositive.

We may now estimate C, D, E, and IV. By inequality (25),

$$|C + D| \leq \frac{1}{2} m \left\| \frac{d^2}{dx^2} \tilde{W}'(u_x) \right\|_{\infty} (t);$$

by inequality (27),

$$|E| \leq c_1^{-1} (c_2 m)^2 \int_0^1 u_{xx}^2 dx;$$

and from the expression for IV_i ,

$$| IV | \leq c_1^{-1} || u_{xx}^2 ||_{\infty} \max_{\eta} [\tilde{W}^{\prime\prime\prime}(\eta)]^2 \cdot \int_0^1 |u_x - u_x^m|^2 dx.$$

The maximum in the last formula is not taken over all values of η , but rather over the range of possible values of u_x and u_x^m ; these values lie in a bounded interval which depends only on the initial data for u. Clearly,

$$|C + D + E| \leq \Gamma(t) m,$$

with the function Γ independent of m. The estimate for IV can be expressed as

$$| W | \leq \Lambda(t) \frac{1}{2} \int_0^1 |u_x - u_x^m|^2 dx.$$

This yields inequality (30), and a standard application of Gronwall's inequality gives inequality (31).

Eq. (1) has the form

$$u_t = \psi(u_x) W''(u_x) u_{xx}, \qquad (32)$$

with $\psi(\nu) = (1 + \nu^2)^{\frac{1}{2}}$. We have made no particular use of the form of ψ . A similar convergence theorem holds for Eq. (32) with any ψ , continuously differentiable, positive, and bounded away from zero.

One final remark. For the case of the heat equation it was clear that $m = \max_i | (u_x^m)_i - (u_x^m)_{i-1} |$ was the parameter controlling the accuracy of the approximation. In the general case one might have expected something different, for example that one should take a coarser discretization where W'' is smaller. Our estimates do not support such an idea. In fact, the argument at the end of Section 3 suggests that if one chooses the admissible slopes so that the distance between any two adjacent ones is a fixed constant, then one might be able to prove quadratic convergence in m.

5. Convergence for the Neumann problem

Here we study the Neumann problem

$$\begin{cases} \frac{u_t}{\sqrt{1+u_x^2}} = W''(u_x) \ u_{xx} & \text{if } 0 \le x \le 1\\ u(x,0) = u_0(x) & , \\ u_x(0,t) = a, \quad u_x(1,t) = b \end{cases}$$
(33)

with a and b constants. We consider only discretizations for which a and b are admissible slopes and we choose

$$(u_x^m)_1 = a$$
 and $(u_x^m)_N = b$

for the boundary conditions to be satisfied.

r

We want to insure that faces 1 and N do not disappear and that statement (9) holds. So at each time we extend u^m in such a way that $(u_x^m)_0$ and $(u_x^m)_1$ correspond to adjacent corners of \overline{W} , $(u_x^m)_1$ lies between $(u_x^m)_0$ and $(u_x^m)_2$, and the length of the first face of the extension of u^m is l_1 / r_1 where

$$r_1 = \frac{(u_x^m)_2 - (u_x^m)_1}{(u_x^m)_2 - (u_x^m)_0}$$
(34.1)

(note that $0 < r_1 < 1$ and if the value of $(u_x^m)_2$ changes then r_1 might jump). The reason for this choice of r_1 will become clear below, when we prove convergence of the approximation scheme. Similar conditions apply to the extension at the right endpoint with

$$r_N = \frac{(u_x^m)_N - (u_x^m)_{N-1}}{(u_x^m)_{N+1} - (u_x^m)_{N-1}}.$$
(34.2)

Furthermore, we impose that for the extension of u^m Eqs. (7) and (8) (for Δ_i and $(u_t^m)_i$, respectively) are valid for *i* equal to 1 and *N*, i.e.

$$\begin{aligned} (u_t^m)_1 &= \sqrt{1 + (u_x^m)_1^2} \, \frac{\Delta_1}{l_1} \, r_1, \\ (u_t^m)_N &= \sqrt{1 + (u_x^m)_N^2} \, \frac{\Delta_N}{l_N} \, r_N; \end{aligned}$$
 (3')

it is natural to do so since we want our scheme to amount to motion by weighted curvature. The idea is that the law governing the evolution of u^m should be the same in both the interior and boundary of the interval [0, 1] (recall also, from the Remark on page 6, that for homogeneous Dirichlet boundary conditions one could think of u^m as being defined on the whole real line, the extension being odd with period two; in that case Eqs. (7) and (8) were satisfied for i = 1 and i = N, i.e. the law governing the evolution of u^m was the same in both the interior and boundary of the interval [0, 1]).

The function u^m is determined by solving Eqs. (5.1') and (5.2) with the c_i^{j} 's given by Eqs. (6), the $(u_t^m)_i$'s by Eqs. (3') and (8), the Δ_i 's by Eqs. (7), and r_1 and r_N by Eqs. (34); the initial data should satisfy condition (2).

Arguing as in Section 2, we see that faces 1 and N of the extension of u^m and of u^m do not disappear and that statement (9) holds, namely, even as time evolves and certain faces disappear, jumps in $(u_x^m)_i$ correspond to adjacent corners of \overline{W} .

Suppose now that we want u^m to approximate the motion of u. Then we assume, in addition, that the number of faces of u_0^m is

$$N \leq \frac{c}{m},\tag{35}$$

with c a constant. One can, for example, construct u_0^m using the method described on page 13 (basically, by taking the union of segments on lines tangent to u_0 and with admissible slopes) to get $N \leq [\text{Total Variation of } u_0'] /m$.

We want to estimate the H^1 norm of $u - u^m$. The values of r_1 and r_N have been chosen so that the sum of the boundary terms (i) through (vii) of the previous section vanish (see the Remark on page 13). So the estimate of the L^2 norm of $u_x - u_x^m$ given in the previous section remains valid. However, to control the H^1 norm of $u - u^m$ we need some additional information, since we cannot use Poincaré's inequality. For any $g: [0,1] \mapsto \mathbf{R}$ we have

$$\int_{0}^{1} |g - \langle g \rangle |^{2} dx \leq \frac{1}{\pi^{2}} \int_{0}^{1} g_{x}^{2} dx, \qquad (36)$$

with $\langle g \rangle = \int_0^1 g \, dx$, so it suffices to control $\langle u - u^m \rangle$. The rate of change of the average of u is

$$\frac{d}{dt} \int_0^1 u \, dx = \int_0^1 \sqrt{1 + u_x^2} \, W''(u_x) \, u_{xx} \, dx$$
$$= \int_0^1 \frac{d}{dx} \, \tilde{W}'(u_x) \, dx$$
$$= \tilde{W}'(u_x(1,t)) - \tilde{W}'(u_x(0,t)) = \tilde{W}'(b) - \tilde{W}'(a).$$

with \tilde{W} as in Eq. (22). On the other hand, the rate of change of the average of u^m is

$$\frac{d}{dt} \int_0^1 u^m \, dx = \frac{d}{dt} \sum_i \int_{x_{i-1}}^{x_i} u^m \, dx = \sum_i \int_{x_{i-1}}^{x_i} (u_t^m)_i \, dx$$

since u^m is continuous and $\dot{x}_0 = \dot{x}_N = 0$. Hence, by Eqs. (26) and (27),

$$\frac{d}{dt} \int_0^1 u^m \, dx = \sum_i \sqrt{1 + (u_x^m)_i^2} \, \Delta_i \, r_i$$
$$= \sum_i \sqrt{1 + (u_x^m)_i^2} \, W''[(u_x^m)_i] \, \frac{(u_x^m)_{i+1} - (u_x^m)_{i-1}}{2} \, r_i$$
$$+ \sum_i O(m^2).$$

By assumption (35),

$$\begin{aligned} \frac{d}{dt} \int_0^1 u^m \, dx &= \sum_i \tilde{W}''[(u_x^m)_i] \; \frac{(u_x^m)_{i+1} - (u_x^m)_{i-1}}{2} \; r_i \, + \, \mathcal{O}(m) \\ &= \sum_i \frac{\tilde{W}'[(u_x^m)_{i+1}] - \tilde{W}'[(u_x^m)_{i-1}]}{2} \; r_i \, + \, \mathcal{O}(m) \\ &= \frac{\tilde{W}'[(u_x^m)_{N+1}]r_N \, + \, \tilde{W}'[(u_x^m)_N] \, + \, \tilde{W}'[(u_x^m)_{N-1}](1 - r_N)}{2} \\ &- \frac{\tilde{W}'[(u_x^m)_2](1 - r_1) \, + \, \tilde{W}'[(u_x^m)_1] \, + \, \tilde{W}'[(u_x^m)_0]r_1}{2} \\ &+ \mathcal{O}(m) \\ &= \; \tilde{W}'[(u_x^m)_N] \, - \, \tilde{W}'[(u_x^m)_1] \, + \, \mathcal{O}(m) \\ &= \; \tilde{W}'(b) \, - \, \tilde{W}'(a) \, + \, \mathcal{O}(m). \end{aligned}$$

(Observe that in this calculation we only need that $0 < r_1, r_N \leq 1$; if the distance between any two adjacent admissible slopes is a fixed constant then, with the choice of r_1 and r_N made in Eqs. (34), one can improve this result to $\frac{d}{dt} \int_0^1 u^m dx = \tilde{W}'(b) - \tilde{W}'(a) + O(m^2)$.) It follows that

$$\frac{d}{dt} \int_0^1 (u - u^m) \, dx \, \bigg| \leq C \, m. \tag{37}$$

The constant C depends only on $\max_i | (u_x^m)_i |$ and on the constant appearing in hypothesis (35). If the initial data satisfies inequality (28) then $\max_i | (u_x^m)_i |$ is uniformly bounded. If, in addition, the initial data satisfies inequality (29) then, by combining Eqs. (31), (36), and (37), we easily deduce that

$$\sup_{0 \le t \le T} || u - u^m ||_{H^1([0,1])} \le C_T m^{\frac{1}{2}}$$

6. Setup of the general Dirichlet problem

In this section we show how one can set up a crystalline algorithm for the general Dirichlet problem

$$\begin{cases} \frac{u_t}{\sqrt{1+u_x^2}} = W''(u_x) \ u_{xx} & \text{if } 0 \le x \le 1\\ u(x,0) = u_0(x) & & \\ u(0,t) = a(t), & u(1,t) = b(t) \end{cases}$$
(38)

There is a new feature in this case: the time dependent boundary condition can lead to the *creation of new faces* at x = 0 and x = 1. This causes our convergence argument to break down, and, in fact, we do not prove that the algorithm converges. It seems natural to choose

$$(u_t^m)_1 = a' \quad \text{and} \quad (u_t^m)_N = b', \quad (3'')$$

instead of Eqs. (3), so the boundary conditions are satisfied.

We also want to insure statement (9), i.e. that even as time evolves and certain faces disappear, jumps in $(u_x^m)_i$ correspond to adjacent corners of \overline{W} . To do this we impose the following condition: there should be an extension of u^m for which Eqs. (7) and (8) (for Δ_i and $(u_t^m)_i$, respectively) are valid for *i* equal to 1 and N, and such that $(u_x^m)_0$ and $(u_x^m)_1$, and $(u_x^m)_{N+1}$ and $(u_x^m)_N$ correspond to adjacent corners of \overline{W} . (For the extension of u^m , faces 1 and N are now longer in general. In the following we focus our attention on the left endpoint and of course corresponding statements hold for the right one.) Observe that:

- Eq. (8) for i = 1 forces Δ_1 and $a' = (u_t^m)_1$ to have the same sign.
- Since l_1 is smaller than the length of the first face of the extension of u^m , we have

$$l_1 \leq \sqrt{1 + (u_x^m)_1^2} \ \frac{\Delta_1}{(u_t^m)_1} \tag{39}$$

if $(u_t^m)_1 \neq 0$ (otherwise there is no restriction on l_1).

These conditions might break down when a' changes sign or when equality holds in inequality (39). More specifically:

- There might not exist a $(u_x^m)_0$ adjacent to $(u_x^m)_1$ such that Δ_1 and a' have the same sign. Such a $(u_x^m)_0$ does not exist if, and only if, a' < 0 and $(u_x^m)_2 > (u_x^m)_1$, or a' > 0 and $(u_x^m)_2 < (u_x^m)_1$. (When it does exist it is unique.)
- The length l_1 might not satisfy inequality (39).

Under these circumstances, we have to allow a new face to appear at the boundary. The introduction of the new face makes it possible to meet the requirements above; it is necessary in two cases:

- **Case** (i): If a' is zero and about to become negative and $(u_x^m)_2 > (u_x^m)_1$, or a' is zero and about to become positive and $(u_x^m)_2 < (u_x^m)_1$, we introduce a new face with slope $(u_x^m)_2$, now $(u_x^m)_3$ (see Figure 3). With the new ordering $(u_x^m)_1 > (u_x^m)_2$ and $(u_x^m)_1 < (u_x^m)_2$, respectively, enabling us to pick the new $(u_x^m)_0$ uniquely.
- **Case** (ii): If equality holds in inequality (39) and l_1 is positive we introduce a new face with slope $(u_x^m)_0$, now $(u_x^m)_1$ (see Figure 4). Note that when a new face appears it has zero length so thereafter Eq. (39) is satisfied during some nonzero time interval.



Figure 3. A new face is about to appear in the interval [0, 1]. Case (i).

As long as neither Case (i) nor Case (ii) occurs u^m is determined by solving Eqs. (5.1') and (5.2) with the c_i^j 's given by Eqs. (6), the $(u_t^m)_i$'s by Eqs. (3") and (8), and the Δ_i 's by Eqs. (7); the initial data should satisfy condition (2).

For general Dirichlet boundary conditions we have not been able to prove convergence. Nevertheless we examine how one can adapt part of the argument given in Section 4 to the present case and see where it breaks down. Here (contrary to what happened in Section 4) $(u_t^m)_1$ does not equal $\sqrt{1 + (u_x^m)_1^2} \frac{\Delta_1}{l_1}$, in general. For equality to hold we should substitute l_1 by the length of the first face of the extension of $u^m (\sqrt{1 + (u_x^m)_1^2} \Delta_1 / (u_t^m)_1 \text{ if } (u_t^m)_1$ is not zero, otherwise it is not determined uniquely). We take

$$r_1 = \frac{l_1 (u_t^m)_1}{\sqrt{1 + (u_x^m)_1^2} \Delta_1} \quad \text{if} \ (u_t^m)_1 \neq 0.$$

We can take r_1 to be one if $(u_t^m)_1 = 0$, since $(u_t^m)_1 = \sqrt{1 + (u_x^m)_1^2} \frac{\Delta_1}{l_1}$, as $\Delta_1 = 0$. Note that for the extension of u^m we considered in Section 4 (odd and periodic) the ratio of the length of the first face of u^m to the length of the first face of the extension of u^m is one half, but we could have extended u^m so that this ratio was one. Eq. (39) says that $r_1 \leq 1$. The length of the first face of the extension of u^m is l_1 / r_1 .

With the r_i 's as in the previous paragraph we can estimate the growth of the H^1 norm of $u - u^m$ as was done in Section 4. Now the boundary terms do not vanish, but using Eqs. (3") we see that they add up to zero (see the Remark on page 13). However, our argument also used that $\max_{1 \le i \le N} |(u_x^m)_i|$ stays bounded as $m \to 0$, for $0 \le t \le T$. It seems plausible that this should be the case if the solution of the differential equation (38) is such that $\sup_{0 \le t \le T} || u_x ||_{\infty}$ is finite. This quantity is finite if, for example, we assume that

$$\frac{c_1}{1 + u_x^2} \le \sqrt{1 + u_x^2} W''(u_x) \le \frac{c_2}{1 + u_x^2}$$
(40.1)

and

$$\sqrt{1 + u_x^2} | W'''(u_x) | \le \frac{c_3}{\sqrt{(1 + u_x^2)^3}}$$
 (40.2)

for some c_1 , c_2 , and $c_3 > 0$. Condition (40.1) assures that Eq. (38) is uniformly parabolic. For a proof that (40.2) implies $\sup_{0 \le t \le T} || u_x ||_{\infty}$ finite see inequalities (VI.5.10) and (VI.5.11) in Ladyženskaja, Solonnikov, and Ural'ceva [19] with their parameter m equal to zero. [Their m is of course unrelated ours. By giving it values other than zero, one can get alternatives to inequalities (40). For example, in the case of the heat equation the inequalities in [19] just mentioned are satisfied with their m equal to two instead of zero, since in this case $W''(u_x) = 1 / \sqrt{1 + u_x^2}$.] Conditions (40) hold for motion by weighted curvature, as we verify in the Appendix.

The proof of Section 4 would go through if one could bound $\max_{1 \le i \le N} |(u_x^m)_i|$ for $0 \le t \le T$ by a constant independent independent of m.

7. Appendix: Physical and mathematical context

We summarize here the relation between this work and the literature on surface energy driven motion of phase boundaries, especially the papers by Angenent and Gurtin [2] and Taylor [25]. Consider an interface between two phases moving isothermally according to the balance of capillary forces and constitutive equations compatible with thermodynamics. An evolution equation for the interface is derived in [2]. When the phases have the same energy and the kinetic coefficient (which measures the drag opposing interfacial motion) is one, it has the form (see Eq. (4.11) of [2])

$$V = [f(\theta) + f''(\theta)] K, \tag{41}$$

where V is the normal velocity of the smooth interface and K is its curvature, θ is the angle from a fixed coordinate axis to the normal to the interface, and f (assumed smooth) is the interfacial energy per unit length. So fix a coordinate system. Let $u(\cdot, t)$ be the interface at time t and

$$\theta = - \arctan \frac{1}{u_x},$$

 $0 \leq \theta \leq \pi$, be the angle between the normal (to the graph of u with positive coordinate in y) and the x-axis. (We do not use the standard definition of arctan but rather one with range in the interval $[-\pi, 0]$.) The expressions of V and K in terms of u are

$$V = \frac{u_t}{\sqrt{1 + u_x^2}}$$
 and $K = \frac{u_{xx}}{\sqrt{(1 + u_x^2)^3}}$

We are led to consider Eq. (1) by taking

$$W(u_x) = f\left(-\arctan\frac{1}{u_x}\right)\sqrt{1 + u_x^2}, \qquad (42)$$

because

$$W''(u_x) = \frac{f(\theta) + f''(\theta)}{\sqrt{(1 + u_x^2)^3}}.$$
(43)

The function f is the energy per unit length (of the interface) whereas W is energy per unit length of the projection of the interface on the x-axis. Note that the right hand side of Eq. (41) is the negative of the gradient of

$$E(u) = \int W(u_x) \, dx = \int f\left(-\arctan\frac{1}{u_x}\right) \sqrt{1 + u_x^2} \, dx.$$

Taylor calls the negative of the gradient of E the weighted curvature of the interface (see Sections 2.2 and 2.3 of [25]).

The interfacial energy per unit length, f, is usually represented in a polar diagram for 1/f, called Frank diagram. The function f is said to be strictly stable when f + f'' > 0. This condition corresponds to a strictly convex Frank diagram, and to W'' > 0. On the other hand, f is usually said to be crystalline if its convexified Frank diagram is a polygon, and if the vertices of this polygon form the complete set of globally convex sections of the Frank diagram (i.e. the original diagram and the convexified one meet only at the vertices of the latter) (see Section 10.3 of [2]). We prefer a slightly broader definition. We shall call such an energy *strictly* crystalline and do not require that a crystalline energy satisfy the second condition. Hence, if the Frank diagram is a polygon then f is crystalline, but not strictly crystalline. In general, we denote by \overline{f} the function whose Frank diagram is the convexification of the Frank diagram of f. There is an equivalent characterization of crystalline energies. It is obtained as follows. Let $n(\theta) \stackrel{\triangle}{=} (\cos \theta, \sin \theta)$. For any surface energy f, we may extend f to \mathbf{R}^2 as a homogeneous function of degree one,

$$f_0(x) \triangleq \begin{cases} ||x|| \ f\left(\arg \frac{x}{||x||}\right) & \text{if } x \neq 0 \\ 0 & \text{if } x = 0 \end{cases}.$$

Recall that the Fenchel transform of f_0 is the function $f_0^* : \mathbf{R}^2 \mapsto [-\infty, +\infty]$ given by

$$f_0^*(y) \stackrel{\triangle}{=} \sup_{x \in \mathbf{R}^2} \{x \cdot y - f_0(x)\},$$

and that the Wulff set of f is

$$W_f \stackrel{\Delta}{=} \{ x \in \mathbf{R}^2 \mid x \cdot n(\theta) \leq f(\theta) \text{ for all } \theta \}.$$

The function f is crystalline if W_f is polyhedral, and it is strictly crystalline if in addition $f(\theta) > f_0^{**}(n(\theta))$ (= $\sup_{y \in W_f} \{y \cdot n(\theta)\}$) unless $n(\theta)$ is normal to ∂W_f (see, for example, Fonseca [9]). One can check that $\bar{f}(\theta) = f_0^{**}(n(\theta))$.

An evolution equation for an interface with a strictly crystalline energy is derived in [2] using the same physical laws which gave Eq. (41). For such an energy Eq. (41) is backward-parabolic. Therefore, one restricts crystalline interfaces to a space \mathcal{M} , consisting of continuous piecewise linear functions such that the normal to each face makes an angle with the x-axis corresponding to one of the corners of the polygon $1/\bar{f} \times n$. The normal velocity of a face is (see Eq. (10.12) of [2])

$$V = \sigma \, \frac{\tilde{\Delta}}{L},\tag{44}$$

where $\tilde{\Delta}$ and σ are constants for each face, and L is the length of the face. For a face with normal $n(\theta)$

$$\tilde{\Delta} = [\bar{f}'(\theta+0) - \bar{f}'(\theta-0)],$$

and $\sigma = +1$ if θ increases across the face, $\sigma = -1$ if θ decreases across the face, and $\sigma = 0$ if the face is nontransitional. Geometrically, $\tilde{\Delta}$ is the length of the segment in the Wulff set of f with normal $n(\theta)$. Using this formula, one can compute the velocity V_i in terms of f, the θ_i 's, and L_i (the subindex i refers to the *i*th face):

$$V_{i} = + \frac{1}{L_{i}} f(\theta_{i-1}) \operatorname{csc}(\theta_{i} - \theta_{i-1}) - \frac{1}{L_{i}} f(\theta_{i}) \left[\operatorname{cot}(\theta_{i} - \theta_{i-1}) + \operatorname{cot}(\theta_{i+1} - \theta_{i}) \right] + \frac{1}{L_{i}} f(\theta_{i+1}) \operatorname{csc}(\theta_{i+1} - \theta_{i}).$$

$$(45)$$

Since

$$(u_x^m)_i = -\cot\theta_i,$$

$$V_i = \frac{(u_t^m)_i}{\sqrt{1 + (u_x^m)_i^2}},$$

$$W[(u_x^m)_i] = f\left(-\arctan\frac{1}{(u_x^m)_i}\right)\sqrt{1 + (u_x^m)_i^2} = \frac{f(\theta_i)}{\sin\theta_i},$$

and $l_i = L_i \sin \theta_i$ (we recall that l_i is the length of the projection of the *i*th face on the *x*-axis), one easily checks that this is Eq. (8), i.e. $\frac{\Delta}{L} = \sigma \frac{\tilde{\Delta}}{L}$. Notice that

$$\overline{W}(u_x) = \overline{f}\left(-\arctan\frac{1}{u_x}\right)\sqrt{1 + u_x^2},$$

where \bar{f} is as above and \bar{W} is as in Section 2. Hence the right hand side of Eq. (44) is the negative of the gradient of

$$\bar{E}(u) = \int \bar{W}(u_x) \, dx = \int \bar{f}\left(-\arctan\frac{1}{u_x}\right) \sqrt{1 + u_x^2} \, dx$$

on \mathcal{M} , in other words the weighted curvature of the interface (see Sections 4.2 and 4.3 of [25]).

In summary, we have checked that if W is given by Eq. (42), Eq. (1) is Eq. (41) (with initial data and boundary conditions), and Eq. (8) is Eq. (44). Our approximation scheme is crystalline in the sense that it approximates the motion of an interface with a strictly convex energy by the motion of an interface with a strictly crystalline energy and in the sense that \bar{f} is crystalline.

In Sections 4 and 5, we proved convergence of the crystalline approximation scheme for homogeneous Dirichlet and Neumann boundary conditions, respectively. In such cases it follows from the maximum principle that $|| u_x ||_{\infty}$ is bounded. In Section 6 we discussed the general Dirichlet problem, and noted that growth conditions of the form (40) are sufficient to prove L^{∞} bounds on u_x . Let us verify that these conditions hold when W is determined by Eq. (43), with f strictly stable and smooth. Then condition (40.1) is obvious and condition (40.2) follows from the identity

$$W'''(u_x) = \frac{-3u_x f(\theta) + f'(\theta) - 3u_x f''(\theta) + f'''(\theta)}{\sqrt{(1 + u_x^2)^5}}$$
