# Bases of the Galois Ring $G R\left(p^{r}, m\right)$ over the Integer Ring $\mathbb{Z}_{p^{r}}$

#### Abstract

The Galois ring $\boldsymbol{G R}\left(\boldsymbol{p}^{\boldsymbol{r}}, \boldsymbol{m}\right)$ of characteristic $\boldsymbol{p}^{\boldsymbol{r}}$ and cardinality $\boldsymbol{p}^{r \boldsymbol{m}}$, where $\boldsymbol{p}$ is a prime and $\boldsymbol{r}, \boldsymbol{m} \geq \mathbf{1}$ are integers, is a Galois extension of the residue class ring $\mathbb{Z}_{p^{r}}$ by a root $\boldsymbol{\omega}$ of a monic basic irreducible polynomial of degree $\boldsymbol{m}$ over $\mathbb{Z}_{\boldsymbol{p}^{r}}$. Every element of $\boldsymbol{G} \boldsymbol{R}\left(\boldsymbol{p}^{\boldsymbol{r}}, \boldsymbol{m}\right)$ can be expressed uniquely as a polynomial in $\boldsymbol{\omega}$ with coefficients in $\mathbb{Z}_{\boldsymbol{p}^{r}}$ and degree less than or equal to $\boldsymbol{m}-\mathbf{1}$, thus $\boldsymbol{G} \boldsymbol{R}\left(\boldsymbol{p}^{r}, \boldsymbol{m}\right)$ is a free module of rank $\boldsymbol{m}$ over $\mathbb{Z}_{\boldsymbol{p}^{r}}$ with basis $\left\{1, \omega, \omega^{2}, \ldots, \omega^{m-1}\right\}$. The ring $\mathbb{Z}_{p^{r}}$ satisfies the invariant dimension property, hence any other basis of $\boldsymbol{G} \boldsymbol{R}\left(\boldsymbol{p}^{r}, \boldsymbol{m}\right)$, if it exists, will have cardinality $m$.

This paper was motivated by the code-theoretic problem of finding the homogeneous bound on the $\boldsymbol{p}^{r}$-image of a linear block code over $\boldsymbol{G} \boldsymbol{R}\left(\boldsymbol{p}^{r}, \boldsymbol{m}\right)$ with respect to any basis. It would be interesting to consider the dual and normal bases of $\boldsymbol{G} \boldsymbol{R}\left(\boldsymbol{p}^{r}, \boldsymbol{m}\right)$.


By using a Vandermonde matrix over $\boldsymbol{G R}\left(\boldsymbol{p}^{r}, \boldsymbol{m}\right)$ in terms of the generalized Frobenius automorphism, a constructive proof that every basis of $\boldsymbol{G R}\left(\boldsymbol{p}^{r}, \boldsymbol{m}\right)$ has a unique dual basis is given. The notion of normal bases was also generalized from the classic case for Galois fields.
Keywords - Galois rings, trace function, Frobenius automorphism, Vandermonde matrix, dual basis, normal basis

## 1 Introduction

It was proved in [1] that every basis of the Galois ring $G R(4, m)$ has a dual basis, by treating each linear transformation from $G R(4, m)$ to $\mathbb{Z}_{4}$ as being uniquely determined in terms of the generalized trace function on $G R(4, m)$. In this paper this

[^0]result is generalized to the Galois ring $G R\left(p^{r}, m\right)$ following the alternate method of MacWilliams and Sloane [8] which constructs the dual basis using simple matrix algebra involving the generalized Frobenius automorphism. The material is organized as follows: Section 2 gives the preliminaries and basic definitions, while Section 3 gives the results.

## 2 Preliminaries and definitions

An overview of Galois fields and Galois rings, the Frobenius automorphism and the trace function, is presented in this section. For a thorough discussion of these topics, we refer the reader to [7], 8] and [11].

### 2.1 Galois fields and Galois rings

Let $p$ be a prime number and $r \geq 1$ an integer. Consider the ring $\mathbb{Z}_{p^{r}}$ of integers modulo $p^{r}$. When $r=1$ the ring $\mathbb{Z}_{p}$ with $p$ elements is a field and is usually denoted by $\mathbb{F}_{p}$. Let $\mathbb{Z}_{p^{r}}[x]$ be the ring of polynomials in the indeterminate $x$ with coefficients in $\mathbb{Z}_{p^{r}}$.

The Galois field with $p^{m}$ elements, denoted $\mathbb{F}_{p^{m}}$, is a field extension $\mathbb{F}_{p}[\alpha]$ of $\mathbb{F}_{p}$ by a root $\alpha$ of an irreducible polynomial $\pi(x)$ of degree $m$ in $\mathbb{F}_{p}[x]$. Thus every element $z$ of $\mathbb{F}_{p^{m}}$ can be expressed uniquely as a polynomial in $\alpha$ of the form

$$
\begin{equation*}
z=a_{0}+a_{1} \alpha+a_{2} \alpha^{2}+\ldots+a_{m-1} \alpha^{m-1} \tag{1}
\end{equation*}
$$

with degree at most $m-1$ with the coefficients $a_{i}$ coming from $\mathbb{F}_{p}$, and hence can also be written as an $m$-tuple $\left(a_{0}, a_{1}, \ldots, a_{m-1}\right)$ in $\mathbb{F}_{p}^{m}$. Elements of $\mathbb{F}_{p^{m}}$ may also be described as residue classes of the polynomials in $x$ with coefficients in $\mathbb{F}_{p}$ reduced modulo $\pi(x)$. When $m=1$ we again have the field $\mathbb{F}_{p}$.

The canonical projection homomorphism $\mu: \mathbb{Z}_{p^{r}} \rightarrow \mathbb{F}_{p}$ is the mod- $p$ reduction map, and can be extended naturally as a map from $\mathbb{Z}_{p^{r}}[x]$ onto $\mathbb{F}_{p}[x]$. This extended map is a ring homomorphism with kernel $(p)=\mathbb{Z}_{p^{r}}[x] p=\left\{f(x) p \mid f(x) \in \mathbb{Z}_{p^{r}}[x]\right\}$.

Let $g(x)$ be a monic polynomial of degree $m \geq 1$ in $\mathbb{Z}_{p^{r}}[x]$. If $\mu(g(x))$ is irreducible in $\mathbb{F}_{p}[x]$, then $g(x)$ is said to be monic basic irreducible. If $\mu(g(x))$ is primitive in $\mathbb{F}_{p}[x]$, then $g(x)$ is said to be monic basic primitive. Clearly, monic basic primitive polynomials in $\mathbb{Z}_{p^{r}}[x]$ are monic basic irreducible.

In the general sense, a Galois ring is a finite commutative local ring with identity $1 \neq 0$ such that the set of zero divisors together with the zero element forms the unique maximal principal ideal ( $p 1$ ) for some prime number $p$. The residue class ring $\mathbb{Z}_{p^{r}}[x] /(h(x))$, where $h(x)$ is a monic basic irreducible polynomial of degree $m$ in $\mathbb{Z}_{p^{r}}[x]$, is a Galois ring with characteristic $p^{r}$ and cardinality $p^{r m}$. The elements of $\mathbb{Z}_{p^{r}}[x] /(h(x))$ are residue classes of the form

$$
\begin{equation*}
a_{0}+a_{1} x+\ldots+a_{m-1} x^{m-1}+(h(x)) \tag{2}
\end{equation*}
$$

where $a_{i} \in \mathbb{Z}_{p^{r}}$. The identity is $1+(h(x))$ and the zero element is $(h(x))$. The principal ideal $(p[1+(h(x))])=(p+(h(x)))$ consists of all the zero divisors and the zero element, and is the only maximal ideal.

If $\operatorname{deg} h(x)=1$ then $\mathbb{Z}_{p^{r}}[x] /(h(x))$ is the ring $\mathbb{Z}_{p^{r}}$. If $r=1$, the canonical homomorphism $\mu$ becomes the identity map and $\mathbb{Z}_{p^{r}}[x] /(h(x))=\mathbb{F}_{p}[x] /(h(x)) \cong$ $\mathbb{F}_{p^{m}}$. Now let $\omega=x+(h(x))$, then $h(\omega)=0$ and every element $z$ of $\mathbb{Z}_{p^{r}}[x] /(h(x))$ can be expressed uniquely in the form

$$
\begin{equation*}
z=a_{0}+a_{1} \omega+\ldots+a_{m-1} \omega^{m-1} \tag{3}
\end{equation*}
$$

where $a_{i} \in \mathbb{Z}_{p^{r}}$. We can thus think of $\mathbb{Z}_{p^{r}}[x] /(h(x))$ as a Galois extension $\mathbb{Z}_{p^{r}}[\omega]$ of $\mathbb{Z}_{p^{r}}$ by $\omega$. The elements take the additive representation (3), a generalization of (11) for $\mathbb{F}_{p^{m}}$. Since any two Galois rings of the same characteristic and the same cardinality are isomorphic, we simply use the notation $G R\left(p^{r}, m\right)$ for any Galois ring with characteristic $p^{r}$ and cardinality $p^{r m}$.

The Galois ring $\mathcal{R}=G R\left(p^{r}, m\right)$ is a finite chain ring of length $r$, its ideals $p^{i} \mathcal{R}$ with $p^{(r-i) m}$ elements are linearly ordered by inclusion,

$$
\begin{equation*}
\{0\}=p^{r} \mathcal{R} \subset p^{r-1} \mathcal{R} \subset \ldots \subset p \mathcal{R} \subset \mathcal{R} \tag{4}
\end{equation*}
$$

The quotient ring $\mathcal{R} / p \mathcal{R} \cong \mathbb{F}_{p^{m}}$ is the residue field of $\mathcal{R}$. There exists a nonzero element $\xi$ of order $p^{m}-1$, which is a root of a unique monic basic primitive polynomial $h(x)$ of degree $m$ over $\mathbb{Z}_{p^{r}}$ and dividing $x^{p^{m}-1}-1$ in $\mathbb{Z}_{p^{r}}[x]$. Consider the set

$$
\begin{equation*}
\mathcal{T}=\left\{0,1, \xi, \xi^{2}, \ldots, \xi^{p^{m}-2}\right\} \tag{5}
\end{equation*}
$$

of Tëichmuller representatives. In this case, every element $z$ of $G R\left(p^{r}, m\right)$ has a unique mutiplicative or p-adic representation as follows

$$
\begin{equation*}
z=z_{0}+p z_{1}+p^{2} z_{2}+\ldots+p^{r-1} z_{r-1} \tag{6}
\end{equation*}
$$

where $z_{i} \in \mathcal{T}$. We have that $z$ is a unit if and only if $z_{0} \neq 0$, and $z$ is a zero divisor or 0 if and only if $z_{0}=0$. The units form a multiplicative group of order $\left(p^{m}-1\right) p^{(r-1) m}$, which is a direct product $\langle\omega\rangle \times \mathcal{E}$, where $\langle\omega\rangle$ is the cyclic group of order $p^{m}-1$ that is isomorphic to $\mathbb{Z}_{p^{m}-1}$ and $\mathcal{E}=\{1+\pi \mid \pi \in(p)\}$ is a group of order $p^{(r-1) m}$. Let $\mu(\xi)=\alpha$. It can be shown that $\alpha$ is a primitive element in $\mathbb{F}_{p^{m}}$, and thus $\mu(\mathcal{T})=\mathbb{F}_{p^{m}}$. The $p$-adic representation in (6) is a generalization of the power representation of an element of $\mathbb{F}_{p^{m}}$.

We realize that $G R\left(p^{r}, m\right)$ is a free module of rank $m$ over $\mathbb{Z}_{p^{r}}$ with the set

$$
\begin{equation*}
\mathcal{P}_{m}(\omega)=\left\{1, \omega, \omega^{2}, \ldots, \omega^{m-1}\right\} \tag{7}
\end{equation*}
$$

as a free basis. The set $\mathcal{P}_{m}(\omega)$ is called the standard or polynomial basis of $G R\left(p^{r}, m\right)$. The ring $\mathbb{Z}_{p^{r}}$ satisfies the invariant dimension property, hence any other basis of $G R\left(p^{r}, m\right)$, if it exists, will have cardinality $m$.

### 2.2 Generalized Frobenius automorphism and trace

The Generalized Frobenius map $f$ on the Galois ring $\mathcal{R}=G R\left(p^{r}, m\right)$ is defined by

$$
\begin{equation*}
z^{f}:=z_{0}^{p}+p z_{1}^{p}+p^{2} z_{2}^{p}+\ldots+p^{r-1} z_{r-1}^{p} \tag{8}
\end{equation*}
$$

where $z$ has the $p$-adic representation given in (6). The map $f$ satisfies the following properties.
(i) $f$ is a ring automorphism of $\mathcal{R}$.
(ii) $f$ fixes every element of $\mathbb{Z}_{p^{r}}$.
(iii) $f$ is of order $m$ and generates the cyclic Galois group of $\mathcal{R}$ over $\mathbb{Z}_{p^{r}}$.

When $r=1$, the automorphism $f$ reduces to the usual Frobenius automorphism $\sigma$ of $\mathbb{F}_{p^{m}}$ defined by $\sigma(z)=z^{p}$.

The generalized trace map $T$ from $\mathcal{R}$ down to $\mathbb{Z}_{p^{r}}$ is given by

$$
\begin{equation*}
T(z):=z+z^{f}+z^{f^{2}}+\ldots+z^{f^{m-1}} \tag{9}
\end{equation*}
$$

and satisfies the following properties.
(i) $T$ is surjective and $\mathcal{R} / \operatorname{ker} T \cong \mathbb{Z}_{p^{r}}$.
(ii) $T$ takes on each value of $\mathbb{Z}_{p^{r}}$ equally often $p^{r(m-1)}$ times.
(iii) $T(\alpha+\beta)=T(\alpha)+T(\beta)$ for all $\alpha, \beta \in \mathcal{R}$.
(iv) $T(\lambda \alpha)=\lambda T(\alpha)$ for all $\lambda \in \mathbb{Z}_{p^{r}}, \alpha \in \mathcal{R}$.
(v) $T\left(\alpha^{f}\right)=(T(\alpha))^{f}=T(\alpha)$ for all $\alpha \in \mathcal{R}$.

Again when $r=1$ the generalized trace map $T$ reduces to the trace map $t$ : $\mathbb{F}_{p^{m}} \rightarrow \mathbb{F}_{p}$ defined by

$$
\begin{equation*}
t(\beta)=\beta+\beta^{p}+\beta^{p^{2}}+\ldots+\beta^{p^{m-1}} \tag{10}
\end{equation*}
$$

### 2.3 Homogeneous weight on $G R\left(p^{r}, m\right)$

Let $R$ be a finite ring with identity $1 \neq 0$, and $\mathbb{T}$ be the multiplicative group of unit complex numbers. The group $\mathbb{T}$ is a one-dimensional torus. A character of $R$ (considered as an additive abelian group) is a group homomorphism $\chi: R \rightarrow \mathbb{T}$. The set of all characters $\widehat{R}$ (called the character module of $R$ ) is a right (resp. left) $R$-module whose group operation is pointwise multiplication of characters and scalar multiplication is given by $\chi^{r}(x)=\chi(r x)$ (resp. ${ }^{r} \chi(x)=\chi(x r)$ ). A character $\chi$ of $R$ is called a right (resp. left) generating character if the mapping $\phi: R \rightarrow \widehat{R}$ given by $\phi(r)=\chi^{r}$ (resp. $\phi(r)={ }^{r} \chi$ ) is an isomorphism of right (resp. left) $R$-modules. The ring $R$ is called Frobenius if and only if $R$ admits a right or a left generating character, or alternatively, if and only if $\widehat{R} \cong R$ as right or left $R$-modules. It is known that for finite rings, a character $\chi$ on $R$ is a right generating character if and only if it is a left generating character. Further $\chi$ is a right generating character if and only if ker $\chi$ contains no non-zero right ideals.

Let $\mathbb{R}$ be the set of real numbers. We define a homogeneous weight on an arbitrary finite ring $R$ with identity in the sense of [4]. Let $R x$ denote the principal (left) ideal generated by $x \in R$.

Definition 2.1 $A$ weight function $w: R \rightarrow \mathbb{R}$ on a finite ring $R$ is called (left) homogeneous if $w(0)=0$ and the following is true.
(i) If $R x=R y$, then $w(x)=w(y)$ for all $x, y \in R$.
(ii) There exists a real number $\Gamma \geq 0$ such that

$$
\begin{equation*}
\sum_{y \in R x} w(y)=\Gamma \cdot|R x|, \text { for all } x \in R \backslash\{0\} \tag{11}
\end{equation*}
$$

Right homogeneous weights are defined accordingly. If a weight is both left homogeneous and right homogeneous, we call it simply as a homogeneous weight. The constant $\Gamma$ in (11) is called the average value of $w$. A homogeneous weight is said to be normalized if its average value is 1 . We can normalize the weight $w$ in Definition 2.1 by replacing it with $\widetilde{w}=\Gamma^{-1} w$ [6]. The weight $w$ is extended naturally to $R^{n}$, the free module of rank $n$ consisting of $n$-tuples of elements from $R$, via $w(z)=\sum_{i=0}^{n-1} w\left(z_{i}\right)$ for $z=\left(z_{0}, z_{1}, \ldots, z_{n-1}\right) \in R^{n}$. The homogeneous distance metric $\delta: R^{n} \times R^{n} \longrightarrow \mathbb{R}$ is defined by $\delta(x, y)=w(x-y)$, for $x, y \in R^{n}$.

It was proved in [5] that, if $R$ is Frobenius with generating character $\chi$, then every homogeneous weight $w$ on $R$ can be expressed in terms of $\chi$ as follows.

$$
\begin{equation*}
w(x)=\Gamma\left[1-\frac{1}{\left|R^{\times}\right|} \sum_{u \in R^{\times}} \chi(x u)\right] \tag{12}
\end{equation*}
$$

where $R^{\times}$is the group of units of $R$.
For the Galois ring $G R\left(p^{r}, m\right)$ we apply the following homogeneous weight given in [3] for finite chain rings.

$$
w_{\mathrm{hom}}(x)= \begin{cases}0 & \text { if } x=0  \tag{13}\\ p^{m(r-1)} & \text { if } x \in\left(p^{r-1}\right) \backslash\{0\} \\ \left(p^{m}-1\right) p^{m(r-2)} & \text { otherwise }\end{cases}
$$

where $\left(p^{r-1}\right)$ is the principal ideal generated by the element $p^{r-1}$ of $G R\left(p^{r}, m\right)$. Since the Galois ring $G R\left(p^{r}, m\right)$ is a commutative Frobenius ring with identity whose generating character is $\chi(z)=\xi^{b_{m-1}}$, where $\xi=\exp \left(2 \pi i / p^{r}\right)$ for $z=\sum_{i=0}^{m-1} b_{i} \omega^{i}$, the weight (13) can be derived from (12). The group of units of $G R\left(p^{r}, m\right)$ has cardinality $p^{m(r-1)}\left(p^{m}-1\right)$ and it easy to compute from (11) that its average value is equal to

$$
\begin{equation*}
\Gamma=\left(p^{m}-1\right) p^{m(r-2)} \tag{14}
\end{equation*}
$$

which is its minimum non-zero value. When $r=1$, we have $\Gamma=\left(p^{m}-1\right) / p^{m}$ and $w_{\text {hom }}$ is just the usual Hamming weight $w_{\text {Ham }}$ on $\mathbb{F}_{p^{m}}$. When $m=1$, the average value is $\Gamma=(p-1) p^{r-2}$ for the integer ring $\mathbb{Z}_{p^{r}}$.

### 2.4 Codes over $G R\left(p^{r}, m\right)$

A block code $C$ of length $n$ over an arbitrary finite ring $R$ is a nonempty subset of $R^{n}$. The code $C$ is called right (resp. left) $R$-linear if $C$ is a right (resp. left) $R$-submodule of $R^{n}$. If $C$ is both left $R$-linear and right $R$-linear, we simply call $C$ a linear block code over $R$. A $k \times n$ matrix over $R$ is called a generator matrix of a
linear block code $C$ if the rows span $C$ and no proper subset of the rows generates $C$.

Let the set $\mathcal{B}_{m}=\left\{\beta_{0}, \beta_{1}, \ldots, \beta_{m-1}\right\}$ be a basis of the Galois ring $\mathcal{R}$ over $\mathbb{Z}_{p^{r}}$, and $B$ be a linear block code of length $n$ over $\mathcal{R}$. We consider the map $\tau: \mathcal{R} \longrightarrow \mathbb{Z}_{p^{r}}^{m}$ defined by

$$
\begin{equation*}
\tau(z)=\left(a_{0}, a_{1}, \ldots, a_{m-1}\right) \tag{15}
\end{equation*}
$$

for $z=a_{0} \beta_{0}+a_{1} \beta_{1}+\ldots+a_{m-1} \beta_{m-1} \in \mathcal{R}, a_{i} \in \mathbb{Z}_{p^{r}}$. This map is a bijection and can be extended coordinate-wise to $\mathcal{R}^{n}$. Thus, if $c \in B$ and $c=\left(c_{0}, c_{1}, \ldots, c_{n-1}\right)$, $c_{i}=\sum_{j=0}^{m-1} a_{i j} \beta_{j}, a_{i j} \in \mathbb{Z}_{p^{r}}$, then

$$
\begin{equation*}
\tau(c)=\left(a_{00}, \ldots, a_{0, m-1}, \ldots, a_{n-1,0}, \ldots a_{n-1, m-1}\right) \tag{16}
\end{equation*}
$$

in $\mathbb{Z}_{p^{r}}^{m n}$. The image $\tau(B)$ of $B$ under $\tau$ with respect to $\mathcal{B}_{m}$ is called the $p^{r}$-ary image of $B$, and is obtained by simply substituting each element of $\mathcal{R}$ by the $m$-tuple of its coordinates over $B$. It is easy to prove that $\tau(B)$ is a linear block code of length $m n$ over $\mathbb{Z}_{p^{r}}$. For the degenerate case $m=1$, the block code $B$ is a code over $\mathbb{Z}_{p^{r}}$ and the map $\tau$ is the identity map on $B$. We equip $\tau(B)$ with a homogeneous distance metric with respect to the weight $w_{\text {hom }}$ as given in (13).

The following lemma from [2] will be very useful in the succeeding discussion.
Lemma 2.2 (Constantinescu, Heise and Honold, 1996) For any linear block code $C \subseteq \mathbb{Z}_{p^{r}}^{n}$ we have

$$
\frac{w_{\mathrm{hom}}(C)}{|C|}=\Gamma \cdot\left|\left\{i \mid \pi_{i}(C) \neq 0\right\}\right|
$$

where $w_{\text {hom }}(C)$ is the sum of the homogeneous weights of all codewords of $C$, and $\pi_{i}$ is the projection from $\mathbb{Z}_{p^{r}}^{n}$ onto the $i$-th coordinate.

## 3 Major Results

We denote by $w_{\text {hom }}(S)$ the sum of the homogeneous weights of the elements of set $S$, that is,

$$
\begin{equation*}
w_{\mathrm{hom}}(S)=\sum_{x \in S} w_{\mathrm{hom}}(x) . \tag{17}
\end{equation*}
$$

Proposition 3.1 For any basis $\mathcal{B}_{m}=\left\{\beta_{0}, \beta_{1}, \ldots, \beta_{m-1}\right\}$ of $G R\left(p^{r}, m\right)$ over $\mathbb{Z}_{p^{r}}$ we have

$$
\begin{equation*}
\sum_{x \in G R\left(p^{r}, m\right)} w_{\text {hom }}(\tau(x))=m(p-1) p^{r m+r-2} . \tag{18}
\end{equation*}
$$

Proof: Let $S=\left\{x \mid x \in G R\left(p^{r}, m\right)\right\}$. Then $\tau(S)$ is a linear block code over $\mathbb{Z}_{p^{r}}$ of length $m$ and cardinality $p^{r m}$. Applying Lemma 2.2 to $\tau(S)$ gives us

$$
\frac{w_{\mathrm{hom}}(\tau(S))}{|\tau(S)|}=\Gamma \cdot w_{s}(\tau(S)) .
$$

Therefore we have $w_{\text {hom }}(\tau(S))=|\tau(S)| \cdot \Gamma \cdot w_{s}(S)$. The value of $\Gamma$ is given in (14), and the support size $w_{s}(\tau(S))$ of $\tau(S)$ is $m$. Using the notation in (17), the result now follows.

This proposition gives the simple corollary below which was used to prove the bound of Rabizzoni in [9, Theorem 1].
Corollary 3.2 For any basis $\mathcal{B}_{m}=\left\{\beta_{0}, \beta_{1}, \ldots, \beta_{m-1}\right\}$ of $\mathbb{F}_{p^{m}}$ over $\mathbb{F}_{p}$ we have

$$
\sum_{x \in \mathbb{F}_{p^{m}}} w_{\text {Ham }}(\tau(x))=m(p-1) p^{m-1}
$$

Proof: The Galois ring $G R(p, m)$ is the Galois field $\mathbb{F}_{p^{m}}$, and the homogeneous weight $w_{\text {hom }}$ given in (13) is the Hamming weight $w_{\text {Ham }}$ on $\mathbb{F}_{p}$ with $\Gamma=(p-1) / p$.

The bound of Rabizzoni in [9, Theorem 1] was extended to linear block codes over Galois rings in [10].

Denote by $\operatorname{Mat}_{m}(\mathcal{R})$ the ring of $m \times m$ matrices over the Galois ring $\mathcal{R}=$ $G R\left(p^{r}, m\right)$. It is known that a matrix $A$ in $\operatorname{Mat}_{m}(\mathcal{R})$ is nonsingular (or invertible) if and only if $\operatorname{det} A$ is a unit in $\mathcal{R}$. We will also use the usual notation $|A|$ for the determinant of $A$. The matrix $A$ is symmetric if and only if $A=A^{t}$, and is orthogonal if and only if $A A^{t}=A^{t} A=I$, where $A^{t}$ is the transpose of $A$ and $I$ is the identity matrix. We propose the following definition.

Definition 3.3 Two bases $\left\{\alpha_{i}\right\}=\left\{\alpha_{1}, \alpha_{2}, \ldots, \alpha_{m}\right\}$ and $\left\{\beta_{j}\right\}=\left\{\beta_{1}, \beta_{2}, \ldots, \beta_{m}\right\}$ of $G R\left(p^{r}, m\right)$ over $\mathbb{Z}_{p^{r}}$ are said to be dual) if $T\left(\beta_{i} \alpha_{j}\right)=\delta_{i j}$, where $\delta_{i j}$ is the Kronecker delta.

Lemma 3.4 The matrix $\Omega \in \operatorname{Mat}_{m}(\mathcal{R})$ given by

$$
\Omega=\left(\begin{array}{ccccc}
1 & 1 & 1 & \ldots & 1 \\
\omega & \omega^{f} & \omega^{f^{2}} & \ldots & \omega^{f^{m-1}} \\
\omega^{2} & \left(\omega^{2}\right)^{f} & \left(\omega^{2}\right)^{f^{2}} & \ldots & \left(\omega^{2}\right)^{f^{m-1}} \\
\vdots & & & & \vdots \\
\omega^{m-1} & \left(\omega^{m-1}\right)^{f} & \left(\omega^{m-1}\right)^{f^{2}} & \ldots & \left(\omega^{m-1}\right)^{f^{m-1}}
\end{array}\right)
$$

is nonsingular.
Proof: By the definition of the generalized Frobenius automorphism (8), it easy to show that $\left(\omega^{j}\right)^{f^{i}}=\left(\omega^{p^{i}}\right)^{j}$ for $i, j=0,1, \ldots, m-1$. Hence,

$$
\Omega=\left(\begin{array}{ccccc}
1 & 1 & 1 & \ldots & 1 \\
\omega & \omega^{p} & \omega^{p^{2}} & \ldots & \omega^{p^{m-1}} \\
\omega^{2} & \left(\omega^{p}\right)^{2} & \left(\omega^{p^{2}}\right)^{2} & \ldots & \left(\omega^{p^{m-1}}\right)^{2} \\
\vdots & & & & \vdots \\
\omega^{m-1} & \left(\omega^{p}\right)^{m-1} & \left(\omega^{p^{2}}\right)^{m-1} & \ldots & \left(\omega^{p^{m-1}}\right)^{m-1}
\end{array}\right)
$$

which is a Vandermonde matrix whose determinant is

$$
\begin{equation*}
\operatorname{det} \Omega=\prod_{j=1}^{m-1} \prod_{i=j+1}^{m}\left(\omega^{p^{i-1}}-\omega^{p^{j-1}}\right) \tag{19}
\end{equation*}
$$

Each factor in this product is a unit of $\mathcal{R}$ so that $\operatorname{det} \Omega$ is a unit in $\mathcal{R}$.

Lemma 3.5 Let $\left\{\beta_{j}\right\}=\left\{\beta_{1}, \beta_{2}, \ldots, \beta_{m}\right\}$ be a basis. The matrix

$$
B=\left(\begin{array}{ccccc}
\beta_{1} & \beta_{1}^{f} & \beta_{1}^{f^{2}} & \ldots & \beta_{1}^{f^{m-1}}  \tag{20}\\
\beta_{2} & \beta_{2}^{f} & \beta_{2}^{f^{2}} & \ldots & \beta_{2}^{f^{m-1}} \\
\vdots & & & & \vdots \\
\beta_{m} & \beta_{m}^{f} & \beta_{m}^{f^{2}} & \ldots & \beta_{m}^{f^{m-1}}
\end{array}\right)
$$

is invertible.
Proof: Express the polynomial basis $\mathcal{P}_{m}(\omega)$ in (7) in terms of the basis $\left\{\beta_{j}\right\}$ as follows.

$$
\left(\begin{array}{c}
1 \\
\omega \\
\omega^{2} \\
\vdots \\
\omega^{m-1}
\end{array}\right)=\left(\begin{array}{cccc}
a_{11} & a_{12} & \ldots & a_{1 m} \\
a_{21} & a_{22} & \ldots & a_{2 m} \\
a_{31} & a_{32} & \ldots & a_{3 m} \\
\vdots & & & \vdots \\
a_{m 1} & a_{m 2} & \ldots & a_{m m}
\end{array}\right)\left(\begin{array}{c}
\beta_{1} \\
\beta_{2} \\
\beta_{3} \\
\vdots \\
\beta_{m}
\end{array}\right)
$$

where $A=\left(a_{i j}\right)$ is a nonsingular matrix over $\mathbb{Z}_{p^{r}}$. We compute the matrix product $A B$. The fact that the Frobenius automorphism $f$ fixes each $a_{i j}$ implies that $A B$ is the Vandermonde matrix $\Omega$. Hence by Lemma [3.4, $\operatorname{det} A B$ is a unit in $\mathcal{R}$. Consequently, $\operatorname{det} B$ is a unit in $\mathcal{R}$.

We shall call the matrix $B$ the automorphism matrix of $\mathcal{R}$ relative to the basis $\left\{\beta_{j}\right\}$.

Corollary $3.6(\operatorname{det} B)^{2}$ is a unit in $\mathbb{Z}_{p^{r}}$.
Proof: It can be shown that

$$
B B^{t}=\left(\begin{array}{cccc}
T\left(\beta_{1}^{2}\right) & T\left(\beta_{1} \beta_{2}\right) & \ldots & T\left(\beta_{1} \beta_{m}\right)  \tag{21}\\
T\left(\beta_{2} \beta_{1}\right) & T\left(\beta_{2}^{2}\right) & \ldots & T\left(\beta_{2} \beta_{m}\right) \\
\vdots & & & \vdots \\
T\left(\beta_{m} \lambda_{1}\right) & T\left(\beta_{m} \lambda_{2}\right) & \ldots & T\left(\beta_{m}^{2}\right)
\end{array}\right)
$$

which is a matrix over $\mathbb{Z}_{p^{r}}$. It follows that $(\operatorname{det} B)^{2}$ is an element of $\mathbb{Z}_{p^{r}}$. By Lemma 3.5, we get the result.

Of course, $\operatorname{det} B$ is not necessarily a unit in the base ring $\mathbb{Z}_{p^{r}}$, although it is a unit in $\mathcal{R}$ according to Lemma 3.5. Please see Example 3.8,

Theorem 3.7 Every basis has a unique dual basis.
Proof: We show the proof for $m=3$ without loss of essential generality. Let $\left\{\beta_{1}, \beta_{2}, \beta_{3}\right\}$ be a basis, and consider the automorphism matrix

$$
B=\left(\begin{array}{ccc}
\beta_{1} & \beta_{1}^{f} & \beta_{1}^{f^{2}} \\
\beta_{2} & \beta_{2}^{f} & \beta_{2}^{f^{2}} \\
\beta_{3} & \beta_{3}^{f} & \beta_{3}^{f^{2}}
\end{array}\right)
$$

which is nonsingular by Lemma 3.5, Let adj $\mathrm{B}=\left(b_{i j}\right)$ where $b_{i j}=(-1)^{i+j}\left|B_{j i}\right|$. Then

$$
\operatorname{adj} \mathrm{B}=\left(\begin{array}{ccc}
\lambda_{1} & \lambda_{2} & \lambda_{3} \\
\lambda_{1}^{f} & \lambda_{2}^{f} & \lambda_{3}^{f} \\
\lambda_{1}^{f^{2}} & \lambda_{2}^{f^{2}} & \lambda_{3}^{f^{2}}
\end{array}\right)
$$

where $\lambda_{1}=\beta_{2}^{f} \beta_{3}^{f^{2}}-\beta_{2}^{f^{2}} \beta_{3}^{f}, \lambda_{2}=\beta_{1}^{f^{2}} \beta_{3}^{f}-\beta_{1}^{f} \beta_{3}^{f^{2}}$, and $\lambda_{3}=\beta_{1}^{f} \beta_{2}^{f^{2}}-\beta_{1}^{f^{2}} \beta_{2}^{f}$ so that $B^{-1}=|B|^{-1}$ adj B. Note that

$$
B B^{-1}=|B|^{-1}\left(\begin{array}{ccc}
T\left(\beta_{1} \lambda_{1}\right) & T\left(\beta_{1} \lambda_{2}\right) & T\left(\beta_{1} \lambda_{3}\right) \\
T\left(\beta_{2} \lambda_{1}\right) & T\left(\beta_{2} \lambda_{2}\right) & T\left(\beta_{2} \lambda_{3}\right) \\
T\left(\beta_{3} \lambda_{1}\right) & T\left(\beta_{3} \lambda_{2}\right) & T\left(\beta_{3} \lambda_{3}\right)
\end{array}\right)
$$

Following the argument of [1] it can be shown by using the generalized trace that $\left\{\lambda_{1} /|B|, \lambda_{2} /|B|, \lambda_{3} /|B|\right\}$ is a linearly independent set, and hence is the unique dual of $\left\{\beta_{j}\right\}$.

Example 3.8 The polynomial basis for $G R(4,2)$ is the set $\{1, \omega\}$ where $1+\omega+\omega^{2}=$ 0 . The automorphism matrix is

$$
B=\left(\begin{array}{cc}
1 & 1 \\
\omega & 3+3 \omega
\end{array}\right)
$$

with determinant $3+2 \omega$ which is a unit in $G R(4,2)$. Observe that $(3+2 \omega)^{2}=1$ is a unit in $\mathbb{Z}_{4}$. The inverse

$$
B^{-1}=\left(\begin{array}{cc}
3+\omega & 1+2 \omega \\
2+3 \omega & 3+2 \omega
\end{array}\right)
$$

gives $\{3+\omega, 1+2 \omega\}$ as the dual of the polynomial basis.
Example 3.9 The polynomial basis for $G R(4,3)$ is the set $\left\{1, \omega, \omega^{2}\right\}$ where $\omega$ is the root of the basic primitive polynomial $x^{3}+2 x^{2}+x-1$ over $\mathbb{Z}_{4}$. The automorphism matrix is given by

$$
B=\left(\begin{array}{ccc}
1 & 1 & 1 \\
\omega & \omega^{2} & \omega^{4} \\
\omega^{2} & \omega^{4} & \omega
\end{array}\right)
$$

with determinant 3 . The inverse is given by

$$
B^{-1}=\left(\begin{array}{ccc}
\omega+3 \omega^{3} & w+3 \omega^{4} & w^{2}+3 \omega^{4} \\
\omega^{2}+3 \omega^{6} & 3 \omega+\omega^{2} & 3 \omega+\omega^{4} \\
\omega^{4}+3 \omega^{5} & 3 \omega^{2}+\omega^{4} & \omega+3 \omega^{2}
\end{array}\right)
$$

so that $\left\{3+2 \omega+2 \omega^{2}, 2+2 \omega+\omega^{2}, 2+\omega+2 \omega^{2}\right\}$ is the dual basis. This corrects the mistake in [1, Example 1].

Example 3.10 The dual of the polynomial basis for $\mathbb{Z}_{8}[\omega]$, where $\omega$ is the root of the basic primitive polynomial $7+5 x+6 x^{2}+x^{3}$ over $\mathbb{Z}_{8}$, is the set $\left\{3+6 \omega+6 \omega^{2}\right.$, $\left.6+2 \omega+5 \omega^{2}, 6+5 \omega+2 \omega^{2}\right\}$.

We apply Definition 3.3 for the notion of self-dual basis.
Definition 3.11 The basis $\left\{\beta_{1}, \beta_{2}, \ldots, \beta_{m}\right\}$ is self-dual if $T\left(\beta_{i} \beta_{j}\right)=\delta_{i j}$.
Definition 3.12 A normal basis of $G R\left(p^{r}, m\right)$ is a basis of the form $\left\{\alpha, \alpha^{f}, \alpha^{f^{2}}, \ldots, \alpha^{f m-1}\right\}$ where $\alpha \in G R\left(p^{r}, m\right)$ and $f$ is the generalized Frobenius automorphism given in (8). In this case we say that $\alpha$ generates $\beta_{m}$.

We have the following immediate results.
Theorem 3.13 Let $\left\{\beta_{j}\right\}$ be a basis with automorphism matrix $B$. Then $B$ is orthogonal if and only if $\left\{\beta_{j}\right\}$ is self-dual.

Proof: From (21) we get $B B^{t}=I \Leftrightarrow T\left(\beta_{i} \beta_{j}\right)=\delta_{i j}$.
Theorem 3.14 Let $\left\{\beta_{j}\right\}$ be a basis with automorphism matrix B. Then the following statements are equivalent.
(i) The basis $\left\{\beta_{j}\right\}$ is a normal basis.
(ii) The automorphism matrix $B$ is a symmetric matrix.
(iii) The Frobenius automorphism $f$ is the $m$-cycle $\beta_{1} \mapsto \beta_{2}, \beta_{2} \mapsto \beta_{3}, \ldots, \beta_{m} \mapsto \beta_{1}$.

Proof: This equivalence is evident from the construction of the automorphism matrix in (20). The basis $\mathcal{B}_{m}=\left\{\beta_{j}\right\}$ is normal $\Leftrightarrow \beta_{1}$ generates $\mathcal{B}_{m}$, that is, $\beta_{2}=$ $\beta_{1}^{f}, \beta_{3}=\beta_{2}^{f}=\beta_{1}^{f^{2}}, \beta_{3}=\beta_{2}^{f}=\beta_{1}^{f^{3}}, \ldots, \beta_{m-1}=\beta_{m-2}^{f}=\beta_{1}^{f^{m-1}}, \beta_{m}=\beta_{m-1}^{f}=$ $\beta_{1}^{f^{m-1}}, \beta_{m}^{f}=\beta_{1}^{f^{m}}=\beta_{1} \Leftrightarrow B$ is symmetric $\Leftrightarrow f$ is the $m$-cycle $\beta_{1} \mapsto \beta_{2}, \beta_{2} \mapsto$ $\beta_{3}, \ldots, \beta_{m} \mapsto \beta_{1}$.

Example 3.15 The set $\mathcal{B}_{2}=\left\{\omega, \omega^{2}=3+3 \omega\right\}$ is a normal basis for $\mathbb{Z}_{4}[x] /\left(x^{2}+\right.$ $x+1)$. The automorphism matrix relative to this basis is given by

$$
\left(\begin{array}{cc}
\omega & 3+3 \omega \\
3+3 \omega & \omega
\end{array}\right)
$$

which is not orthogonal, hence $\mathcal{B}_{2}$ is not self-dual. However $B$ is symmetric.
Example 3.16 The set $\mathcal{B}_{3}=\left\{1+\omega, 1+\omega^{2}, 3+3 \omega+3 \omega^{2}\right\}$ of $G R(4,3)=\mathbb{Z}_{4}[x] /\left(x^{3}+\right.$ $2 x^{2}+x+3$ ) is a self-dual normal basis as the automorphism matrix is both orthogonal and symmetric.
