# On the $n$-dominating graph of specific graphs

#### Abstract

Let $G=(V, E)$ be a graph. A set $S \subseteq V(G)$ is a dominating set, if every vertex in $V(G) \backslash S$ is adjacent to at least one vertex in $S$. The $k$-dominating graph of $G, D_{k}(G)$, is defined to be the graph whose vertices correspond to the dominating sets of $G$ that have cardinality at most $k$. Two vertices in $D_{k}(G)$ are adjacent if and only if the corresponding dominating sets of $G$ differ by either adding or deleting a single vertex. In this paper we consider and study the $n$-dominating graph of specific graphs.

## 1 Introduction

Let $G=(V, E)$ be a simple graph. For any vertex $v \in V$, the open neighborhood of $v$ is the set $N(v)=\{u \in V \mid u v \in E\}$ and the closed neighborhood of $v$ is the set $N[v]=N(v) \cup v$. For a set $S \subseteq V$, the open neighborhood of $S$ is $N(S)=\bigcup_{v \in S} N(v)$ and the closed neighborhood of $S$ is $N[S]=N(S) \cup S$. A set $S \subseteq V$ is a dominating set of $G$, if $N[S]=V$, or equivalently, every vertex in $V \backslash S$ is adjacent to at least one vertex in $S$. The domination number $\gamma(G)$ is the minimum cardinality of a dominating set in $G$. For more study in domination theory, the reader is referred to [9]. A dominating set with cardinality $\gamma(G)$ is called a $\gamma$-set.

Given a graph $G$, the $k$-dominating graph of $G, D_{k}(G)$, is defined to be the graph whose vertices correspond to the dominating sets of $G$ that have cardinality at most $k$. Two vertices in $D_{k}(G)$ are adjacent if and only if the corresponding dominating sets of $G$ differ by either adding or deleting a single vertex ([8]).

[^0]A motivation for the study of the $k$-dominating graph is relationships between dominating sets. In particular, given dominating sets $S$ and $T$, is there a sequence of dominating sets $S_{0}=S_{1}, S_{2}, \ldots, S_{k}=T$ such that each $S_{i+1}$ is obtained from $S_{i}$ by deleting or adding a single vertex? (see [8]).

A reconfiguration problem asks whether (when) one feasible solution to a problem can be transformed into another by some allowable set of moves, while maintaining feasibility at all steps. The graph $D_{k}(G)$ aids in studying the reconfiguration problem for dominating sets (see [8]). Authors in [8] gave conditions that ensure $D_{k}(G)$ is connected. As usual we denote the maximum and minimum degree of a graph $G$, by $\delta(G)$ and $\Delta(G)$, respectively.

In the next section we study the $n$-dominating graph of the complete graph $K_{n}$. In Section 3, we consider the $n$-dominating graphs of the path graph $P_{n}$ and the cycle graph $C_{n}$ and obtain some properties of these kind of graphs. Finally, we study the order of dominating graph of some graph products, in Section 4.

## 2 The $n$-dominating graph of $K_{n}$

Let $G$ be a simple graph of order $n$. Since the order of $n$-dominating graph of $G$ is the number of all dominating sets of $G$, so counting of the number of dominating sets of graphs is important in the study of this subject. We state the following theorem:

Theorem 1. [1, 6] For every connected graph $G$, the number of dominating sets is odd.

The following corollary is an immediate consequence of Theorem

Corollary 1. For every connected graph $G$, the order of $n$-dominating graph of $G$ is odd.

Author in 1 has given a construction showing that for each odd number $n$ there is a connected graph $G$ such that the number of its dominating sets is $n$. So we have the following corollary:

Corollary 2. For each odd number $n$, there is a connected graph $G$, such that its $n$-dominating graph has order $n$.

The following theorem is about the $n$-dominating graph of $G$.

## Theorem 2.

(i) For every graph $G$ the $n$-dominating graph $D_{n}(G)$ is a bipartite graph.
(ii) For every graph $G \neq O_{n}, D_{n}(G)$ is not regular.

## Proof.

(i) Let $X$ be the set of dominating sets of $G$ with odd cardinality and $Y$ be the set of dominating sets of even cardinality. It is clear that $X \cup Y=V\left(D_{n}(G)\right)$ and $X \cap Y=\phi$. Suppose that $A, B \in X$, then $(A \backslash B) \cup(B \backslash A)$ cannot be a vertex of $D_{n}(G)$. Because $|A|=|B|$ or $||A|-|B|| \geq 2$. So $A B$ is not an edge of $D_{n}(G)$ and with similar argument we have this for two vertices in $Y$. Therefore $D_{n}(G)$ is a bipartite graph with parts $X$ and $Y$.
(ii) The degree of $V(G)$ as a vertex in $D_{n}(G)$ is $n$. Now consider a vertex of $D_{n}(G)$ which is a $\gamma$-set of $G$. It's degree is $n-\gamma<n$. So the graph $D_{n}(G)$ is not regular.

First we consider the $k$-dominating graph of complete graph $K_{n}$. It is easy to see that for every $n \in \mathbb{N}, D_{1}\left(K_{n}\right)=\overline{K_{n}}$ and $D_{2}\left(K_{n}\right)=K_{\frac{n(n+1)}{2}}$. Here we consider $n$-dominating graph of $K_{n}$, $D_{n}\left(K_{n}\right)$. The Figure 1 shows $D_{3}\left(K_{3}\right)$.

Now we state and prove some elementary results related to geometrical structure of $D_{n}\left(K_{n}\right)$.

## Theorem 3.

(i) The number of vertices of $D_{n}\left(K_{n}\right)$ is $2^{n}-1$.

(ii) The $n$-dominating graph $D_{n}\left(K_{n}\right)$ is a bipartite graph with parts $X$ and $Y$, with $|X|=2^{n-1}$ and $|Y|=2^{n-1}-1$.
(iii) For every $n \geq 3, \delta\left(D_{n}\left(K_{n}\right)\right)=n-1$ and $\Delta\left(D_{n}\left(K_{n}\right)\right)=n$.
(iv) For every $n \geq 3,\left|E\left(D_{n}\left(K_{n}\right)\right)\right|=n\left(2^{n-1}-1\right)$.

## Proof.

(i) It is easy to see that the number of dominating sets of $K_{n}$ with cardinality $i$ is $\binom{n}{i}$, and since $\sum_{i=1}^{n}\binom{n}{i}=2^{n}-1$, we have the result.
(ii) Let $X$ be the set of dominating sets of $K_{n}$ with odd cardinality and $Y$ be the set of dominating sets of even cardinality of $K_{n}$. By theorem 2, $D_{n}\left(K_{n}\right)$ is a bipartite graph with parts $X$ and $Y$. Now we obtain the cardinality of $X$ and $Y$. Obviously $|X|=$ $\sum_{k=1}^{\left\lfloor\frac{n}{2}\right\rfloor}\binom{n}{2 k-1}$ and $|Y|=\sum_{k=1}^{\left\lfloor\frac{n}{2}\right\rfloor}\binom{n}{2 k}$, therefore the result follows from well-known identities $\sum_{k=1}^{n}\binom{n}{k}=2^{n}-1$ and $\sum_{k=1}^{n}(-1)^{k}\binom{n}{k}=-1$.
(iii) For each vertex of $D_{n}\left(K_{n}\right)$, which is a dominating set of $K_{n}$ with cardinality one, there exists $n-1$ dominating sets with cardinality 2 , such that their symmetric difference is a single set, and thus both are adjacent. So, the degree of these kind of dominating set in
$D_{n}\left(K_{n}\right)$ is $n-1$.
Now suppose that $S$ is a dominating set of $K_{n}$ with $|S|=m$, where $2 \leq m \leq n$. There are $m$ dominating sets of $K_{n}$ of size $m-1$ and $n-m$ dominating sets of $K_{n}$ of size $m+1$ which are adjacent with $S$. So, the degree of each members of $S$ in $D_{n}\left(K_{n}\right)$ is equal to $n$. Therefore $\delta\left(D_{n}\left(K_{n}\right)\right)=n-1$ and $\Delta\left(D_{n}\left(K_{n}\right)\right)=n$.
(iv) By Part (i) and Hand-shaking lemma, the size of graph is $\frac{1}{2}\left(n(n-1)+n\left(2^{n}-1-n\right)\right)$ which is equal to $n\left(2^{n-1}-1\right)$.

We have shown the graph $D_{3}\left(K_{3}\right)$ as a bipartite graph in Figure 2,


Figure 2: Bipartite graph $D_{3}\left(K_{3}\right)$.

Remark. Since a bipartite graph with different number of vertices in its parts is not a Hamiltonian graph, so $D_{n}(G)$ is not Hamiltonian, for any graph $G$. Also it is easy to see that for every $n \geq 3, D_{n}\left(K_{n}\right)$ is not Eulerian and even it doesn't have an Eulerian trail.

## 3 The $n$-dominating graph of path and cycle

In this section we study the $n$-dominating graph of the path and the cycle graph.
A path is a connected graph in which two vertices have degree one and the remaining
vertices have degree two. Let $P_{n}$ be the path with $V\left(P_{n}\right)=\{1,2, \ldots, n\}$ and $E\left(P_{n}\right)=$ $\{\{1,2\},\{2,3\}, \ldots\{n-1, n\}\}$, see Figure 3,


Figure 3: The path $P_{n}$ with vertices labeled $\{1,2, \ldots, n\}$.
By the definition of $n$-dominating graph, $D_{n}\left(P_{n}\right)$ is a graph, which its vertices are dominating sets of the path graph $P_{n}$ and its two vertices are adjacent if and only if their symmetric difference is a single-member set of vertices of $P_{n}$. We have shown $D_{3}\left(P_{3}\right)$ in Figure 4 .


Figure 4: graph $D_{3}\left(P_{3}\right)$.

To study the properties of $D_{n}\left(P_{n}\right)$, we need some results about the dominating sets of $P_{n}$.

Lemma 1. [7] For every $n \in \mathbb{N}, \gamma\left(P_{n}\right)=\left\lceil\frac{n}{3}\right\rceil$

We recall that a dominating set is minimal if all its proper subsets are not dominating. Let to denote the maximum cardinality of minimal dominating sets of a graph $G$, by $\Gamma(G)$. This parameter has not been widely studied. A dominating set with cardinality $\Gamma(G)$ is called a $\Gamma$-set. The following theorem give $\Gamma\left(P_{n}\right)$ :

Theorem 4. For every $n \in \mathbb{N}, \Gamma\left(P_{n}\right)=\left\lceil\frac{n}{2}\right\rceil$.

Proof. Consider the path $P_{n}$ has shown in Figure 3. It is easy to see that for odd $n$, the set $\{1,3,5, \ldots, n\}$ is a minimal dominating set of $P_{n}$ with maximum cardinality. Also for even $n$, the
two sets $\{1,3,5, \ldots, n-1\}$ and $\{2,4,6, \ldots, n\}$ are minimal dominating sets of $P_{n}$ with maximum cardinality. Obviously the cardinality of these sets is $\left\lceil\frac{n}{2}\right\rceil$. So $\Gamma\left(P_{n}\right)=\left\lceil\frac{n}{2}\right\rceil$.

By the proof of Theorem 4, we have the following easy result:

Corollary 3. For even $n \neq 4$, there are two $\Gamma$-sets for $P_{n}$, and for odd $n$ there is a unique $\Gamma$-set for $P_{n}$.

Now consider the $n$-dominating graph of $P_{n}, D_{n}\left(P_{n}\right)$. Let $\mathcal{D}\left(P_{n}, i\right)$ denote the family of all dominating sets of $P_{n}$ with cardinality $i$. Suppose that $A, B \in \mathcal{D}\left(P_{n}, i\right)$ are two distinct dominating sets of $P_{n}$ with cardinality $i$ (or two distinct vertices of $D_{n}\left(P_{n}\right)$ ). Let $\partial(A, B)$ denote the distance between two vertices $A$ and $B$. We state and prove the following theorem:

Theorem 5. Suppose that $A, B \in \mathcal{D}\left(P_{n}, i\right)$. We have $\partial(A, B)=2$ if and only if $|A \cap B|=i-1$

Proof. Let $\partial(A, B)=2$. So there exists a dominating set of $P_{n}$ with cardinality $i+1$, say $S$ such that $S \backslash A=\{x\}$ and $S \backslash B=\{y\}$. Therefore $A \bigcap B=S \backslash\{x, y\}$. Hence

$$
|A \bigcap B|=i+1-2=i-1
$$

Now let $|A \bigcap B|=i-1$, so there exist $x \in A$ and $y \in B$ such that $x \notin B$ and $y \notin A$. Consider $S=A \bigcup\{y\}=B \bigcup\{x\}$. The set $S$ is a dominating set of $P_{n}$, because $A$ and $B$ are dominating sets and hence $S$ is a vertex of $D_{n}\left(P_{n}\right)$. Note that the vertex $S$ is adjacent to $A$ and $B$, but $A$ is not adjacent to $B$ because $|A|=|B|$. Therefore $\partial(A, B)=2$.

Suppose that $d\left(P_{n}, j\right)$, is the number of dominating sets of $P_{n}$ with cardinality $j$. We need the following results:

Lemma 2. 3 If $\mathfrak{p}_{n}^{i}$ is the family of dominating sets with cardinality $i$ of $P_{n}$, then

$$
\left|\mathfrak{p}_{n}^{i}\right|=\left|\mathfrak{p}_{n-1}^{i-1}\right|+\left|\mathfrak{p}_{n-2}^{i-1}\right|+\left|\mathfrak{p}_{n-3}^{i-1}\right| .
$$

Theorem 6. 3] The following properties hold for $d\left(P_{n}, j\right)$ :
(i) For every $n \in \mathbb{N}, d\left(P_{3 n}, n\right)=1$.
(ii) For every $n \in \mathbb{N}, d\left(P_{3 n}+2, n+1\right)=n+2$.
(iii) For every $n \in \mathbb{N}, d\left(P_{3 n+1}, n+1\right)=\frac{(n+2)(n+3)}{2}-2$.
(iv) For every $n \in \mathbb{N}, d\left(P_{3 n}, n+1\right)=\frac{n(n+1)(n+8)}{6}$.
(v) If $s_{n}=\sum_{j=\lceil n / 3\rceil}^{n} d\left(P_{n}, j\right)$, then for every $n \geq 4, s_{n}=s_{n-1}+s_{n-2}+s_{n-3}$ with initial values $s_{1}=1, s_{2}=3$ and $s_{3}=5$.
(vi) For every $n \in \mathbb{N}, d\left(P_{n}, n-1\right)=n$.

We have the following properties for order of $n$-dominating graph of $P_{n}$ which is an immediate consequence of Theorem 6:

Corollary 4. For every $n \geq 4$,

$$
\mid V\left(D _ { n } ( P _ { n } ) | = | V \left(D _ { n - 1 } ( P _ { n - 1 } ) | + | V \left(D _ { n - 2 } ( P _ { n - 2 } ) | + | V \left(D_{n-3}\left(P_{n-3}\right) \mid,\right.\right.\right.\right.
$$

with initial values $\mid V\left(D_{1}\left(P_{1}\right)|=1| V,\left(D_{2}\left(P_{2}\right) \mid=3\right.\right.$ and $\mid V\left(D_{3}\left(P_{3}\right) \mid=5\right.$.

We have the following results for the number of the dominating sets of $P_{n}$, i.e., $\left|V\left(D_{n}\left(P_{n}\right)\right)\right|$ which are easy and straightforward to obtain:

## Theorem 7.

(i) The generating function of $\left|V\left(D_{n}\left(P_{n}\right)\right)\right|$ is $T(x)=-\frac{(x+1)^{2}}{x^{3}+x^{2}+x-1}$.
(ii) The order of $D_{n}\left(P_{n}\right)$ satisfies

$$
\left|V\left(D_{n}\left(P_{n}\right)\right)\right|=\frac{(-1)^{n}\left(A\left(\tau_{1}^{-1}\right)^{n} \tau_{2} \tau_{3}+B\left(\tau_{2}^{-1}\right)^{n} \tau_{1} \tau_{3}+C\left(\tau_{3}^{-1}\right)^{n} \tau_{1} \tau_{2}\right)}{\tau_{1} \tau_{2} \tau_{3}}
$$

where $\tau_{1}, \tau_{2}$ and $\tau_{3}$ are the roots of $x^{3}+x^{2}+x-1=0$ and $A, B$ and $C$ are $\frac{\left(\tau_{1}-1\right)^{2}}{\left(\tau_{3}-\tau_{1}\right)\left(\tau_{2}-\tau_{1}\right)}, \frac{\left(\tau_{2}-1\right)^{2}}{\left(\tau_{3}-\tau_{2}\right)\left(\tau_{1}-\tau_{2}\right)}$ and $\frac{\left(\tau_{3}-1\right)^{2}}{\left(\tau_{2}-\tau_{3}\right)\left(\tau_{1}-\tau_{3}\right)}$, respectively.

Here we state and prove more results on the number of $\gamma$-sets and $(\gamma+1)$-sets of paths:

Corollary 5. The number of $\gamma$-sets of $P_{3 k}, P_{3 k+1}$ and $P_{3 k+2}$ are $1, \frac{k^{2}+5 k+2}{2}$ and $k+2$, respectively.

Proof. It follows from Lemma 1 and Theorem 6 (i),(ii) and (iii).

We know that one or two members of the family of dominating sets with cardinality $\gamma+1$ are $\Gamma$-sets. We shall find the cardinality of these families. Our objective is finding any $\gamma$-set by adding or deleting some vertices of another $\gamma$-set.

By Theorem 6 (iv), the number of $(\gamma+1)$-sets of $P_{3 n}$ is $d\left(P_{3 n}, n+1\right)=\frac{n(n+1)(n+8)}{6}$. Here we obtain the number of $(\gamma+1)$-sets of $P_{3 n+1}$ and $P_{3 n+2}$ :

Theorem 8. For every $n \in \mathbb{N}$,
(i) the number of $(\gamma+1)$-sets of $P_{3 n+1}$ is $\frac{1}{24}\left(n^{4}+18 n^{3}+71 n^{2}+78 n+24\right)$.
(ii) the number of $(\gamma+1)$-sets of $P_{3 n+2}$ is $\frac{1}{120} n(n+1)\left(n^{3}+24 n^{2}+121 n+94\right)$.

## Proof.

(i) We shall prove $d\left(P_{3 n+2}, n+2\right)=\frac{1}{24}\left(n^{4}+18 n^{3}+71 n^{2}+78 n+24\right)$. We use induction on $n$. Since $d\left(P_{5}, 3\right)=8$, the result is true for $n=1$. Now suppose that the result is true for all natural numbers less than $n$, and we prove it for $n$. By Lemma 2,

$$
d\left(P_{3 n+2}, n+2\right)=d\left(P_{3 n+1}, n+1\right)+d\left(P_{3 n}, n+1\right)+d\left(P_{3 n-1}, n+1\right) .
$$

Since $d\left(P_{3 n-1}, n+1\right)=d\left(P_{3(n-1)+2},(n-1)+2\right)$, by Theorem 6 (iii), (iv) and induction hypothesis, we have

$$
\begin{aligned}
d\left(P_{3 n+2}, n+2\right) & =\frac{(n+2)(n+3)}{2}-2+\frac{n(n+1)(n+8)}{6}+\frac{1}{24} n\left(n^{3}+14 n^{2}+23 n-14\right) \\
& =\frac{1}{24}\left(n^{4}+18 n^{3}+71 n^{2}+78 n+24\right) .
\end{aligned}
$$

(ii) We use induction on $n$. Since $d\left(P_{4}, 3\right)=4$, The result is true for $n=1$. Now suppose that the result is true for all natural numbers less than $n$, and we prove it for $n$. By Lemma 2 ,

$$
d\left(P_{3 n+1}, n+2\right)=d\left(P_{3 n}, n+1\right)+d\left(P_{3 n-1}, n+1\right)+d\left(P_{3 n-2}, n+1\right) .
$$

Since $d\left(P_{3 n-1}, n+1\right)=d\left(P_{3(n-1)+2},(n-1)+2\right)$ and $d\left(P_{3 n-2}, n+1\right)=d\left(P_{3(n-1)+1},(n-\right.$ 1) +2 ), by Theorem 6 (i), (iv) and induction hypothesis, we have

$$
\begin{aligned}
d\left(P_{3 n+1}, n+2\right) & =\frac{n(n+1)(n+8)}{6}+\frac{1}{24} n\left(n^{3}+14 n^{2}+23 n-14\right) \\
& +\frac{1}{120}(n-1) n\left(n^{3}+21 n^{2}+76 n-4\right) \\
& =\frac{1}{120} n(n+1)\left(n^{3}+24 n^{2}+121 n+94\right)
\end{aligned}
$$

The following theorem is about the minimum and maximum degree of $D_{n}\left(P_{n}\right)$ :

Theorem 9. For n-dominating graph of $P_{n}$ we have $\Delta\left(D_{n}\left(P_{n}\right)\right)=n$ and $\delta\left(D_{n}\left(P_{n}\right)\right)=n-\left\lceil\frac{n}{2}\right\rceil$.

Proof. By Theorem [6(vi), $D_{n}\left(P_{n}\right)$ has $n$ vertices of cardinality $n-1$ and these are all vertices adjacent to vertex $V\left(P_{n}\right)$, and so $\operatorname{deg}\left(V\left(P_{n}\right)\right)=n$. For every $\lceil n / 3\rceil<i<n$, there are at most $i$ vertices $A \in \mathcal{D}\left(P_{n}, i-1\right)$ and exactly $n-i$ vertices $B \in \mathcal{D}\left(P_{n}, i+1\right)$ adjacent to $C \in \mathcal{D}\left(P_{n}, i\right)$. For all vertices in $\mathcal{D}\left(P_{n},\lceil n / 3\rceil\right)$ there are $n-\gamma$ adjacent vertices of $\mathcal{D}\left(P_{n}, \gamma+1\right)$ and for vertices in $\mathcal{D}\left(P_{n}, \Gamma\right)$ there are $n-\Gamma\left(P_{n}\right)$ adjacent vertices of $\mathcal{D}\left(P_{n}, \Gamma+1\right)$. So $\delta\left(D_{n}\left(P_{n}\right)\right)=n-\Gamma$ and $\Delta\left(D_{n}\left(P_{n}\right)\right)=n$. We have the result by Theorem 4.

Theorem 10. The graph $D_{n}\left(P_{n}\right)$ is a connected graph.

Proof. Let $A \in \mathcal{D}\left(P_{n}, i\right)$ and $B \in \mathcal{D}\left(P_{n}, j\right)$ are two vertices of $D_{n}\left(P_{n}\right)$, where $i<j$. Step by step, we add a vertex to $A$ to reach a vertex in $\mathcal{D}\left(P_{n}, n\right)$. Then step by step remove a vertex to reach to a vertex in $\mathcal{D}\left(P_{n}, j\right)$. Note that all the sets obtained in these steps are dominating sets of $P_{n}$ and so are vertices of $D_{n}\left(P_{n}\right)$. Hence we have found a path between $A$ and $B$. Therefore $D_{n}\left(P_{n}\right)$ is a connected graph.

Here we consider cycles. Let $C_{n}, n \geq 3$, be the cycle with $n$ vertices $V\left(C_{n}\right)=\{1,2, \ldots, n\}$ and $E\left(C_{n}\right)=\{\{1,2\},\{2,3\}, \ldots,\{n-1, n\},\{n, 1\}\}$, see Figure 5 .


Figure 5: The cycle $C_{n}$ with vertices labeled $\{1,2, \ldots, n\}$.
Suppose that $\mathcal{D}\left(C_{n}, i\right)$ or simply $\mathcal{C}_{n}^{i}$ denote the family of dominating set of $C_{n}$ with cardinality $i$. The following theorem gives a recurrence relation for the number of dominating sets of cycles with cardinality $i$ :

Theorem 11. 4
(i) If $\mathcal{C}_{n}^{i}$ is the family of dominating set of $C_{n}$ with cardinality $i$, then $\left|\mathcal{C}_{n}^{i}\right|=\left|\mathcal{C}_{n-1}^{i-1}\right|+\left|\mathcal{C}_{n-2}^{i-1}\right|+$ $\left|\mathcal{C}_{n-3}^{i-1}\right|$.
(ii) If $S_{n}=\sum_{j=\left\lceil\frac{n}{3}\right\rceil}^{n}\left|\mathcal{C}_{n}^{j}\right|$, then for every $n \geq 4, S_{n}=S_{n-1}+S_{n-2}+S_{n-3}$ with initial values $S_{1}=1, S_{2}=3$ and $S_{3}=7$.

We have the following properties for order of $n$-dominating graph of $C_{n}$ which is an immediate consequence of Theorem 11 (see Figure (6):

Corollary 6. For every $n \geq 4$,

$$
\mid V\left(D _ { n } ( C _ { n } ) | = | V \left(D _ { n - 1 } ( C _ { n - 1 } ) | + | V \left(D _ { n - 2 } ( C _ { n - 2 } ) | + | V \left(D_{n-3}\left(C_{n-3}\right) \mid,\right.\right.\right.\right.
$$

with initial values $\mid V\left(D_{1}\left(C_{1}\right)|=1| V,\left(D_{2}\left(C_{2}\right) \mid=3\right.\right.$ and $\mid V\left(D_{3}\left(C_{3}\right) \mid=5\right.$.

Theorem 12. For every $n \in \mathbb{N}, \Gamma\left(C_{n}\right)=\left\lfloor\frac{n}{2}\right\rfloor$.

Proof. Consider the cycle $C_{n}$ has shown in Figure [5. It is easy to see that for even $n$, the two sets $\{1,3,5, \ldots, n-1\}$ and $\{2,4,6, \ldots, n\}$ are minimal dominating sets of $C_{n}$ with maximum cardinality. For odd $n$ all the sets of the form $\left\{i \oplus 2 k: 1 \leq i \leq n, 1 \leq k \leq\left\lfloor\frac{n}{2}\right\rfloor\right\}$ are the $\Gamma$-sets of $C_{n}$, where $\oplus$ is sum modulo $n$. Obviously the cardinality of these sets is $\left\lfloor\frac{n}{2}\right\rfloor$. So $\Gamma\left(C_{n}\right)=\left\lfloor\frac{n}{2}\right\rfloor$.

Similar to $n$-dominating of $P_{n}$, we have the following results:

## Theorem 13.

(i) For even $n>4$, there are two $\Gamma$-sets and for odd $n$ there are $n \Gamma$-sets for $C_{n}$.
(ii) $\Delta\left(D_{n}\left(C_{n}\right)\right)=n$ and $\delta\left(D_{n}\left(C_{n}\right)\right)=n-\Gamma$.
(iii) The graph $D_{n}\left(C_{n}\right)$ is a connected graph.

The following result is easy to obtain:

Theorem 14.
(i) The generating function of $\left|V\left(D_{n}\left(C_{n}\right)\right)\right|$ is $T(x)=-\frac{3 x^{2}+2 x+1}{x^{3}+x^{2}+x-1}$.
(ii) The order of $D_{n}\left(C_{n}\right)$ satisfies

$$
\left|V\left(D_{n}\left(C_{n}\right)\right)\right|=\frac{(-1)^{n}\left(A\left(\tau_{1}^{-1}\right)^{n} \tau_{2} \tau_{3}+B\left(\tau_{2}^{-1}\right)^{n} \tau_{1} \tau_{3}+C\left(\tau_{3}^{-1}\right)^{n} \tau_{1} \tau_{2}\right)}{\tau_{1} \tau_{2} \tau_{3}},
$$

where $\tau_{1}, \tau_{2}$ and $\tau_{3}$ are the roots of $x^{3}+x^{2}+x-1=0$ and $A, B$ and $C$ are $\frac{3 \tau_{1}^{2}-2 \tau_{1}+1}{\left(\tau_{3}-\tau_{1}\right)\left(\tau_{2}-\tau_{1}\right)}, \frac{3 \tau_{2}^{2}-2 \tau_{2}+1}{\left(\tau_{3}-\tau_{2}\right)\left(\tau_{1}-\tau_{2}\right)}$ and $\frac{3 \tau_{3}^{2}-2 \tau_{3}+1}{\left(\tau_{3}-\tau_{2}\right)\left(\tau_{3}-\tau_{1}\right)}$, respectively.

## 4 The order of $n$-dominating graph of graph products

We would like to end this paper by stating some results on the order of $n$-dominating graph of some operations of two graphs. The join $G=G+H$ of two graph $G$ and $H$ with disjoint vertex sets $V_{1}$ and $V_{2}$ and edge sets $E_{1}$ and $E_{2}$ is the graph union $G \cup H$ together with all the edges joining $V_{1}$ and $V_{2}$. The corona of two graphs $G$ and $H$ is the graph $G \circ H$ formed from one copy of $G$ and $|V(G)|$ copies of $H$, where the $i$-th vertex of $G$ is adjacent to every vertex in the $i$-th copy of $H$.

The following theorem gives the order of number of $D_{n}(G+H)$ and $D_{n}(G \circ H)$. This theorem can be found in domination polynomial format in [2]:

Theorem 15. Let $G$ and $H$ be graphs of order $p$ and $q$, respectively, and $n=p+q$. Then
(i) $\left|V\left(D_{n}(G+H)\right)\right|=\left(2^{p}-1\right)\left(2^{q}-1\right)+\left|V\left(D_{p}(G)\right)\right|+\left|V\left(D_{q}(H)\right)\right|$.
(ii) $\left|V\left(D_{n}(G \circ H)\right)\right|=\left(2^{q}+\left|V\left(D_{q}(H)\right)\right|\right)^{p}$.

## Proof.

(i) Let $i$ be a natural number $1 \leq i \leq p+q$. We shall count the number of dominating sets of $G+H$. If $i_{1}$ and $i_{2}$ are two natural numbers such that $i_{1}+i_{2}=i$, then clearly, for every $D_{1} \subseteq V(G)$ and $D_{2} \subseteq V(H)$, such that $\left|D_{j}\right|=i_{j}, j=1,2, D_{1} \cup D_{2}$ is a dominating set of $G+H$. Also, if $D$ is a dominating set of $G$ of size $i$, then $D$ is a dominating set for $G+H$ of size $i$. The same is true for every dominating $D$ of size $i$. Thus we have the result.
(ii) In the corona of two graphs $G$ and $H$, every vertex $u \in V(G)$ is adjacent to all vertices of the corresponding copy of $H$. So, we can delete all edges in $E$ in the corona. Therefore, the arising graph is the disjoint union of $p$ copies of the corona $K_{1} \circ H$. Therefore, the number of dominating sets of $G \circ H$ is $\mid V\left(\left.D_{q+1}\left(K_{1} \circ H\right)\right|^{p}\right.$. It remains to obtain the number of dominating sets of $K_{1} \circ H$. We have two cases for a dominating set $S$ of every graph of form $K_{1} \circ H$.

Case 1. $S$ includes the vertex originally in $K_{1}$ and an arbitrary subset of the $q$ vertices from the copy of $H$. In this case we have $2^{q}$ dominating sets.

Case 2. $S$ does not include the vertex in $K_{1}$ and it is exactly a dominating set of $H$. In this case there are $\left|V\left(D_{q}(H)\right)\right|$ dominating sets.

By addition principle we have $\mid V\left(D_{q+1}\left(K_{1} \circ H\right)\left|=2^{m}+\left|V\left(D_{q}(H)\right)\right|\right.\right.$.

Given any two graphs $G$ and $H$ we define the Cartesian product, denoted $G \square H$, to be the graph with vertex set $V(G) \times V(H)$ and edges between two vertices $\left(u_{1}, v_{1}\right)$ and ( $u_{2}, v_{2}$ ) if and only if either $u_{1}=u_{2}$ and $v_{1} v_{2} \in E(H)$ or $u_{1} u_{2} \in E(G)$ and $v_{1}=v_{2}$. We think that computing of the order of Cartesian product of two graphs $G$ and $H$, i.e. the number of dominating sets of $G \square H$ is not easy. Using Theorem 4.2. of [10] we have the following recurrence relation for the order of Ladder graph $L_{n}$ which is $P_{n} \square K_{2}$.

Theorem 16. 10] Let $G$ be a graph of order n, then

$$
\begin{aligned}
\left|V\left(D_{2 n}\left(L_{n}\right)\right)\right| & =3\left|V\left(D_{2 n-2}\left(L_{n-1}\right)\right)\right|+2\left|V\left(D_{2 n-4}\left(L_{n-2}\right)\right)\right|+2\left|V\left(D_{2 n-6}\left(L_{n-3}\right)\right)\right| \\
& -\left|V\left(D_{2 n-8}\left(L_{n-4}\right)\right)\right|-\left|V\left(D_{2 n-10}\left(L_{n-5}\right)\right)\right| .
\end{aligned}
$$

In this section we studied the order of $|V|$-dominating graph of some graph operations. Study the geometrical properties and parameters of these kind of graphs remain as open problems which we believe deserve attention.
