ON QUOTIENT MODULES OF $H^2(\mathbb{D}^n)$: ESSENTIAL NORMALITY AND BOUNDARY REPRESENTATIONS

ABSTRACT. Let \mathbb{D}^n be the open unit polydisc in \mathbb{C}^n , $n \geq 1$, and let $H^2(\mathbb{D}^n)$ be the Hardy space over \mathbb{D}^n . For $n \geq 3$, we show that if $\theta \in H^{\infty}(\mathbb{D}^n)$ is an inner function, then the *n*-tuple of commuting operators $(C_{z_1},...,C_{z_n})$ on the Beurling type quotient module \mathcal{Q}_{θ} is not essentially normal, where

 $\mathcal{Q}_{\theta} = H^2(\mathbb{D}^n)/\theta H^2(\mathbb{D}^n)$ and $C_{z_j} = P_{\mathcal{Q}_{\theta}} M_{z_j}|_{\mathcal{Q}_{\theta}}$ $(j = 1, ..., n)$.

Rudin's quotient modules of $H^2(\mathbb{D}^2)$ are also shown to be not essentially normal. We obtain a complete characterization for essential normality of doubly commuting quotient modules of an analytic Hilbert module over $\mathbb{C}[z_1, \ldots, z_n]$. Finally, we prove several results concerning boundary representations of C^* -algebras corresponding to different classes of quotient modules including doubly commuting quotient modules, and homogenous quotient modules.

1. Introduction

Let $H^2(\mathbb{D}^n)$, $n \geq 1$, denote the Hardy space of holomorphic functions on the unit polydisc $\mathbb{D}^n = \{ \boldsymbol{z} = (z_1, \ldots, z_n) \in \mathbb{C}^n : |z_i| \leq 1, i = 1, \ldots, n \},\$ that is,

$$
H^{2}(\mathbb{D}^{n})=\Big\{f=\sum_{\boldsymbol{k}\in\mathbb{N}^{n}}a_{\boldsymbol{k}}\boldsymbol{z}^{\boldsymbol{k}}\in\mathcal{O}(\mathbb{D}^{n}):||f||^{2}:=\sum_{\boldsymbol{k}\in\mathbb{N}^{n}}|a_{\boldsymbol{k}}|^{2}<\infty\Big\},\
$$

where N is the set of all natural numbers including 0, $\mathbb{N}^n = {\mathbf{k} = (k_1, \ldots, k_n) : k_j \in \mathbb{N}, j =$ $1, \ldots, n$ and $\boldsymbol{z^k} := z_1^{k_1}$ $i_1^{k_1} \cdots i_n^{k_n}$. It is well known that $H^2(\mathbb{D}^n)$ is a reproducing kernel Hilbert space corresponding to the Szegö kernel

$$
\mathbb{S}(\boldsymbol{z},\boldsymbol{w})=\prod_{i=1}^n(1-z_i\bar{w}_i)^{-1},\qquad(\boldsymbol{z},\boldsymbol{w}\in\mathbb{D}^n)
$$

and $(M_{z_1},...,M_{z_n})$ is a commuting tuple of isometries on $H^2(\mathbb{D}^n)$, where

$$
(M_{z_i}f)(\mathbf{w})=w_i f(\mathbf{w}) \qquad (f\in H^2(\mathbb{D}^n), \mathbf{w}\in \mathbb{D}^n, i=1,\ldots,n).
$$

We represent the *n*-tuple of multiplication operators $(M_{z_1},...,M_{z_n})$ on $H^2(\mathbb{D}^n)$ as a Hilbert module over $\mathbb{C}[z] := \mathbb{C}[z_1, \ldots, z_n]$ in the following sense:

$$
\mathbb{C}[\boldsymbol{z}] \times H^2(\mathbb{D}^n) \to H^2(\mathbb{D}^n), \quad (p, f) \mapsto p(M_{z_1}, \dots, M_{z_n})f.
$$

With the above module action $H^2(\mathbb{D}^n)$ is called the Hardy module over $\mathbb{C}[z]$. A closed subspace S of $H^2(\mathbb{D}^n)$ is called a *submodule* if $M_{z_i}S \subseteq S$ for all $i=1,\ldots,n$, and a closed

subspace Q of $H^2(\mathbb{D}^n)$ is a *quotient module* if \mathcal{Q}^{\perp} ($\cong H^2(\mathbb{D}^n)/\mathcal{Q}$) is a submodule. A quotient module Q is said to be of *Beurling type* if

$$
\mathcal{Q} = \mathcal{Q}_{\theta} := H^2(\mathbb{D}^n)/\theta H^2(\mathbb{D}^n) \cong H^2(\mathbb{D}^n) \ominus \theta H^2(\mathbb{D}^n)
$$

for some inner function $\theta \in H^{\infty}(\mathbb{D}^n)$ (that is, θ is a bounded analytic function on \mathbb{D}^n and $|\theta| = 1$ a.e. on the distinguished boundary \mathbb{T}^n of \mathbb{D}^n). We use the notation \mathcal{S}_{θ} to denote the submodule $\theta H^2(\mathbb{D}^n)$.

A quotient module Q of $H^2(\mathbb{D}^n)$ is essentially normal if the commutator $[C_{z_i}^{\mathcal{Q}}, C_{z_j}^{\mathcal{Q}*}]$ is compact for all $1 \leq i, j \leq n$, where

$$
C_{z_i}^{\mathcal{Q}} := P_{\mathcal{Q}} M_{z_i} |_{\mathcal{Q}} \quad (i = 1, \dots, n)
$$

is the compression of the shift M_{z_i} to Q. We use the notation C_{z_i} instead of $C_{z_i}^{\mathcal{Q}}$ when the quotient module Q is understood from the context. Essential normality of Hilbert modules is a much studied object in operator theory. It establishes important connections between operator theory, algebraic geometry, homology theory and complex analysis through the BDF theory [\[3\]](#page-17-0). An incomplete list of references on the study of essential normality of quotient modules over bidisc is: [\[6\]](#page-17-1), [\[7\]](#page-17-2), [\[10\]](#page-17-3), [\[11\]](#page-17-4), [\[12\]](#page-17-5) and [\[20\]](#page-18-0).

It is well known that any proper quotient module of $H^2(\mathbb{D})$ is of Beurling-type and essentially normal (see [\[16\]](#page-18-1) for more details). This, however, does not hold in general:

- (1) Let $n \geq 2$. Then Q is a Beurling type quotient module of $H^2(\mathbb{D}^n)$ if and only if \mathcal{Q}^{\perp} is a doubly commuting submodule (see [\[19\]](#page-18-2)).
- (2) A Beurling type quotient module $\mathcal{Q}_{\theta} \subseteq H^2(\mathbb{D}^2)$ is essentially normal if and only if θ is a rational inner function of degree at most $(1, 1)$ (see [\[11\]](#page-17-4)).

This paper is concerned with the essential normality of certain classes of quotient modules including Beurling-type quotient modules of $H^2(\mathbb{D}^n)$, $n \geq 3$. An added benefit of this consideration is the study of boundary representations, in the sense of Arveson ([\[1\]](#page-17-6), [\[2\]](#page-17-7)), of C^* -algebras generated by $\{I_{\mathcal{Q}}, C_{z_1}, \ldots, C_{z_n}\}.$

We now recall the notion of boundary representation. Let A be an operator algebra with identity, and let $C^*(A)$ be the C^* -algebra generated by A. An irreducible representation ω of $C^*(A)$ is a boundary representation relative to A if $\omega|_A$ has a unique completely positive (CP) extension to $C^*(A)$. An operator algebra A has sufficiently many boundary representations if

$$
\bigcap_{\omega\in{\rm bdy}(A)}\ker\omega=\{0\},
$$

where bdy(A) denotes the set of all boundary representations of $C^*(A)$ relative to A. It is worth mentioning here that, by a recent work of Davidson and Kenedy ([\[9\]](#page-17-8)), the Silov boundary ideal of A (in the sense of Arveson [\[1\]](#page-17-6)) is $\bigcap_{\omega \in \text{bdy}(A)} \ker \omega$. Arveson showed that if A has sufficiently many boundary representations then certain isometric linear maps of A are implemented by \ast -isomorphisms on $C^*(A)$ (see [\[2,](#page-17-7) Theorem 0.3]). Therefore, it is important to identify operator algebras with sufficiently many boundary representations. The following result provides us a class of operator algebras for which we know precisely when it has sufficiently many boundary representations.

THEOREM 1.1 ([\[2\]](#page-17-7)). Let A be an irreducible operator algebra with identity, and let $C^*(A)$ contain all the compact operators. Then A has sufficiently many boundary representations if and only if the identity representation of $C^*(A)$ is a boundary representation relative to A.

Now if Q is an essentially normal quotient module of $H^2(\mathbb{D}^n)$, then it is easy to see that the C^{*}-algebra $C^*(\mathcal{Q})$ — generated by the irreducible operator algebra $B(\mathcal{Q})$ — contains all the compact operators on \mathcal{Q} . Here

$$
B(\mathcal{Q}) := B(C_{z_1}, \ldots, C_{z_n})
$$

and

$$
C^*(\mathcal{Q}) := C^*(C_{z_1}, \ldots, C_{z_n})
$$

are the Banach algebra and the C^{*}-algebra generated by $\{I_{\mathcal{Q}}, C_{z_i}\}_{i=1}^n$ respectively. Therefore, by Theorem [1.1,](#page-2-0) it is of interest to determine whether the identity representation of $C^*(\mathcal{Q})$ is a boundary representation relative to $B(Q)$. This problem has a complete solution for the case $n = 1$ ([\[1\]](#page-17-6),[\[2\]](#page-17-7)):

THEOREM 1.2 (Arveson). Let \mathcal{Q}_{θ} be a quotient module of $H^2(\mathbb{D})$. Then the identity representation of $C^*(\mathcal{Q}_{\theta})$ is a boundary representation relative to $B(\mathcal{Q}_{\theta})$ if and only if Z_{θ} is a proper subset of $\mathbb T$, where Z_θ consists of all points λ on $\mathbb T$ for which θ cannot be continued analytically from $\mathbb D$ to λ .

For the class of essentially normal Beurling type quotient modules of $H^2(\mathbb{D}^2)$, the following characterization was obtained in [\[11\]](#page-17-4).

THEOREM 1.3 (Guo & Wang). Let $\theta \in H^{\infty}(\mathbb{D}^2)$ be a rational inner function of degree at most $(1,1)$, and \mathcal{Q}_{θ} be the corresponding essentially normal quotient module of $H^2(\mathbb{D}^2)$. Then the identity representation of $C^*(\mathcal{Q}_{\theta})$ is a boundary representation relative to $B(\mathcal{Q}_{\theta})$ if and only if θ is not a one variable Blaschke factor.

In this paper, we study similar problems of essential normality and boundary representations for several classes of quotient modules of $H^2(\mathbb{D}^n)$, $n \geq 2$. Namely, we prove that the Beurling type quotient modules of $H^2(\mathbb{D}^n)$ $(n \geq 3)$ and Rudin quotient modules of $H^2(\mathbb{D}^2)$ are not essentially normal. We also obtain a complete characterization for essential normality of doubly commuting quotient modules of an analytic Hilbert module (defined in Section 2) over $\mathbb{C}[z]$ including $H^2(\mathbb{D}^n)$ and the weighted Bergman modules $L^2_{a,\alpha}(\mathbb{D}^n)$ $(\alpha \in \mathbb{Z}^n, \alpha_i > -1, i = 1, \ldots, n)$ as special cases $(n \geq 2)$. We discuss these results in Section 3. In Section 4, we study boundary representations for doubly commuting quotient modules of an analytic Hilbert module over $\mathbb{C}[z]$, and obtain some direct results for the case of $H^2(\mathbb{D}^n)$ and $L^2_a(\mathbb{D}^n)$ $(n \geq 2)$ (see Theorems [4.4](#page-10-0) and [4.5\)](#page-10-1). The final section is devoted to the study of boundary representations of homogeneous quotient modules of $H^2(\mathbb{D}^2)$.

2. Preparatory results

In this section we recall some definitions, and prove some elementary results which will be used later. For each $w \in \mathbb{D}^n$, the normalized kernel function K_w of $H^2(\mathbb{D}^n)$ is defined by

$$
K_{\mathbf{w}}(\mathbf{z}) := \frac{1}{\|\mathbb{S}(\cdot,\mathbf{w})\|} \mathbb{S}(\mathbf{z},\mathbf{w}) = \prod_{i=1}^{n} \sqrt{(1-|w_i|^2)} \left(\frac{1}{1-\overline{w}_i z_i}\right), \qquad (\mathbf{z} \in \mathbb{D}^n)
$$

where $\mathbb{S}(\cdot, \mathbf{w})(\mathbf{z}) = \mathbb{S}(\mathbf{z}, \mathbf{w})$ for all $\mathbf{z} \in \mathbb{D}^n$.

LEMMA 2.1. Let $l \in \{1, \ldots, n\}$ be a fixed integer, and let $\mathbf{w}_l = (w_1, \ldots, w_{l-1}, w_{l+1}, \ldots, w_n)$ be a fixed point in \mathbb{D}^{n-1} . Then $K_{(\mathbf{w}_l,w)}$ converges weakly to 0 as w approaches to $\partial\mathbb{D}$, where $(w_l, w) = (w_1, \ldots, w_{l-1}, w, w_{l+1}, \ldots, w_n).$

Proof. For each $p \in \mathbb{C}[z]$,

(2.1)
$$
\langle K_{(\mathbf{w}_l,w)}, p \rangle = \overline{p(\mathbf{w}_l,w)} \sqrt{1-|w|^2} \prod_{i=1, i \neq l}^{n} \sqrt{1-|w_i|^2},
$$

which converges to zero as w approaches to $\partial \mathbb{D}$. For an arbitrary $f \in H^2(\mathbb{D}^n)$, the result now follows from the fact that $||K_{\mu}|| = 1$ for all $\mu \in \mathbb{D}^n$ and $\mathbb{C}[z]$ is dense in $H^2(\mathbb{D}^n)$ \Box

For a closed subspace S of a Hilbert space \mathcal{H} , the orthogonal projection of \mathcal{H} onto S is denoted by $P_{\mathcal{S}}$. For an inner function $\theta \in H^{\infty}(\mathbb{D}^n)$, it is well known that

$$
P_{\mathcal{S}_{\theta}} = M_{\theta} M_{\theta}^* \text{ and } P_{\mathcal{Q}_{\theta}} = I_{H^2(\mathbb{D}^n)} - M_{\theta} M_{\theta}^*,
$$

where M_{θ} is the multiplication operator defined by $M_{\theta} f = \theta f$, $f \in H^2(\mathbb{D}^n)$. It follows from the reproducing property of the Szegö kernel that

$$
M_{\theta}^*K(\cdot, \boldsymbol{w}) = \overline{\theta(\boldsymbol{w})}K(\cdot, \boldsymbol{w}),
$$

where $K(\cdot, \mathbf{w}) := K_{\mathbf{w}}, \mathbf{w} \in \mathbb{D}^n$. In particular, one has

$$
P_{\mathcal{S}_{\theta}}(K_{\mathbf{w}}) = M_{\theta}M_{\theta}^*K_{\mathbf{w}} = \overline{\theta(\mathbf{w})}\theta K_{\mathbf{w}} \qquad (\mathbf{w} \in \mathbb{D}^n).
$$

These observations yield the next lemma.

LEMMA 2.2. Let θ be an inner function in $H^{\infty}(\mathbb{D}^n)$. Then

(2.2)
$$
P_{\mathcal{Q}_{\theta}}(K_{\mathbf{w}})=(1-\overline{\theta(\mathbf{w})}\theta)K_{\mathbf{w}} \qquad (\mathbf{w}\in\mathbb{D}^n).
$$

We now recall the definition of an analytic Hilbert module over $\mathbb{C}[z]$ (see [\[4\]](#page-17-9)). Let k: $\mathbb{D} \times \mathbb{D} \to \mathbb{C}$ be a positive definite function such that $k(z, w)$ is analytic in z and anti-analytic in w. Let $\mathcal{H}_k \subseteq \mathcal{O}(\mathbb{D}, \mathbb{C})$ be the corresponding reproducing kernel Hilbert space. The Hilbert space \mathcal{H}_k is said to be *reproducing kernel Hilbert module* over $\mathbb{C}[z]$ if the multiplication operator M_z is bounded on \mathcal{H}_k .

DEFINITION 2.3. A reproducing kernel Hilbert module \mathcal{H}_k over $\mathbb{C}[z]$ is said to be an analytic Hilbert module over $\mathbb{C}[z]$ if $k^{-1}(z,w)$ is a polynomial in z and \bar{w} .

Typical examples of analytic Hilbert modules are the Hardy module $H^2(\mathbb{D})$ and the weighted Bergman modules $L^2_{a,\alpha}(\mathbb{D})$ $(\alpha > -1, \alpha \in \mathbb{Z})$. It is known that a quotient module of an analytic Hilbert module is irreducible, that is, C_z does not have any non-trivial reducing subspace (see Theorem 3.3 and Lemma 3.4 in [\[4\]](#page-17-9)). Using this, we obtain the next lemma.

LEMMA 2.4. Let Q be a non-zero quotient module of an analytic Hilbert module $\mathcal H$ over $\mathbb C[z]$. Then $[C_z, C_z^*]=0$ if and only if Q is one dimensional.

Proof. First note that for any non-zero quotient module Q of H, the C^{*}-algebra $C^*(\mathcal{Q})$ is irreducible. If C_z is normal, then $C^*(\mathcal{Q}) \subseteq C^*(\mathcal{Q})' = \mathbb{C}I$. Thus $C^*(\mathcal{Q}) = \mathbb{C}I$, and therefore, $\mathcal Q$ is one dimensional. The converse part is trivial, and the proof follows.

Let $\{k_i\}_{i=1}^n$ be positive definite functions on \mathbb{D} . Then $\mathcal{H}_K := \mathcal{H}_{k_1} \otimes \cdots \otimes \mathcal{H}_{k_n}$ is said to be an *analytic Hilbert module over* $\mathbb{C}[z]$ if H_{k_i} is an analytic Hilbert module over $\mathbb{C}[z]$ for all $i = 1, \ldots, n$. In this case, $\mathcal{H}_K \subseteq \mathcal{O}(\mathbb{D}^n, \mathbb{C})$ and $K(z, w) = \prod_{i=1}^n k_i(z_i, w_i)$ is the reproducing kernel function of \mathcal{H}_K (see [\[4\]](#page-17-9)).

In the sequel, we will often identify M_{z_i} on $H^2(\mathbb{D}^n)$ with $I_{H^2(\mathbb{D})}\otimes\cdots\otimes M_z$ $\sum_{i-th \text{ place}}$ $\otimes \cdots \otimes I_{H^2(\mathbb{D})},$

 $i = 1, \ldots, n$, on $H^2(\mathbb{D}) \otimes \cdots \otimes H^2(\mathbb{D})$, the *n*-fold Hilbert space tensor product of the Hardy module.

We end this section with a result on essential normality of a Beurling type quotient module \mathcal{Q}_{θ} , where θ is a one variable inner function.

LEMMA 2.5. Let $\theta \in H^{\infty}(\mathbb{D}^n)$ be a one variable inner function and $n \geq 3$. Then \mathcal{Q}_{θ} is not essentially normal.

Proof. Without loss of generality we may assume that $\theta(z) = \theta'(z_1)$ for some inner function $\theta' \in H^{\infty}(\mathbb{D})$. Then it follows that $\mathcal{S}_{\theta} = \mathcal{S}_{\theta'} \otimes H^2(\mathbb{D}^{n-1})$ and

$$
\mathcal{Q}_{\theta} = H^2(\mathbb{D}^n) \ominus \theta H^2(\mathbb{D}^n) = \mathcal{Q}_{\theta'} \otimes H^2(\mathbb{D}^{n-1}).
$$

Now we compute the self commutator of C_{z_2} :

$$
\begin{aligned} [C_{z_2}, C_{z_2}^*] &= P_{\mathcal{Q}_{\theta}} M_{z_2} M_{z_2}^* |_{\mathcal{Q}_{\theta}} - P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{\mathcal{Q}_{\theta}} M_{z_2} |_{\mathcal{Q}_{\theta}} \\ &= P_{\mathcal{Q}_{\theta}} M_{z_2} M_{z_2}^* |_{\mathcal{Q}_{\theta}} - I_{\mathcal{Q}_{\theta}} + P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{\mathcal{S}_{\theta}} M_{z_2} |_{\mathcal{Q}_{\theta}}. \end{aligned}
$$

Using the fact

$$
P_{\mathcal{S}_{\theta}}M_{z_2}|_{\mathcal{Q}_{\theta'}\otimes\mathbb{C}\otimes H^2(\mathbb{D}^{n-2})}=(P_{\mathcal{S}_{\theta'}}\otimes I_{H^2(\mathbb{D})}\otimes I_{H^2(\mathbb{D}^{n-2})})M_{z_2}|_{\mathcal{Q}_{\theta'}\otimes\mathbb{C}\otimes H^2(\mathbb{D}^{n-2})}=0,
$$

and

$$
M_{z_2}^*|_{\mathcal{Q}_{\theta'}\otimes\mathbb{C}\otimes H^2(\mathbb{D}^{n-2})}=0,
$$

we conclude that

$$
[C_{z_2},C_{z_2}^*] \vert_{\mathcal{Q}_{\theta'}\otimes\mathbb{C}\otimes H^2(\mathbb{D}^{n-2})} = -I_{\mathcal{Q}_{\theta}}\vert_{\mathcal{Q}_{\theta'}\otimes\mathbb{C}\otimes H^2(\mathbb{D}^{n-2})} = -I_{\mathcal{Q}_{\theta'}\otimes\mathbb{C}\otimes H^2(\mathbb{D}^{n-2})}.
$$

Since $n \geq 3$, $[C_{z_2}, C_{z_2}^*] \vert_{\mathcal{Q}_{\theta}(\mathcal{Q}) \subset \mathcal{Q}} F^2(\mathbb{D}^{n-2})}$ is not compact, and hence the commutator $[C_{z_2}, C_{z_2}^*]$ is not compact. This completes the proof.

3. Essential normality

Our purpose in this section is to prove a list of results concerning essential normality for certain classes of quotient modules. We begin with the class of Beurling type quotient modules of $H^2(\mathbb{D}^n)$, $n \geq 3$.

THEOREM 3.1. Let θ be an inner function in $H^{\infty}(\mathbb{D}^n)$ and $n \geq 3$. Then \mathcal{Q}_{θ} is not essentially normal.

Proof. By Lemma [2.5,](#page-4-0) we may assume without loss of generality that θ depends on both z_1 and z_2 variables. We now show that $[C_{z_1}, C_{z_2}^*]$ is not compact. To see this, we compute

$$
\begin{aligned} [C_{z_1}, C_{z_2}^*] &= P_{\mathcal{Q}_{\theta}} M_{z_1} M_{z_2}^* \vert_{\mathcal{Q}_{\theta}} - P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{\mathcal{Q}_{\theta}} M_{z_1} \vert_{\mathcal{Q}_{\theta}} = P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{\mathcal{S}_{\theta}} M_{z_1} \vert_{\mathcal{Q}_{\theta}} \\ &= P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{\mathcal{S}_{\theta} \ominus (z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta})} M_{z_1} \vert_{\mathcal{Q}_{\theta}} + P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta}} M_{z_1} \vert_{\mathcal{Q}_{\theta}}. \end{aligned}
$$

Since M_{z_1} and M_{z_2} are isometries, we have

$$
P_{z_1S_{\theta}}M_{z_1}P_{\mathcal{Q}_{\theta}} = 0
$$
 and $P_{\mathcal{Q}_{\theta}}M_{z_2}^*P_{z_2S_{\theta}} = 0$.

This implies

$$
P_{\mathcal{Q}_{\theta}}M_{z_2}^*P_{z_1\mathcal{S}_{\theta}+z_2\mathcal{S}_{\theta}}M_{z_1}|_{\mathcal{Q}_{\theta}}=0,
$$

and

$$
[C_{z_1}, C_{z_2}^*] = P_{\mathcal{Q}_{\theta}} M_{z_2}^* P_{\mathcal{S}_{\theta} \ominus (z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta})} M_{z_1} |_{\mathcal{Q}_{\theta}}.
$$

On the other hand, since $S_{\theta} = \theta H^2(\mathbb{D}^n)$, we must have

$$
\mathcal{S}_{\theta} \ominus (z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta}) = \theta(\mathbb{C} \otimes \mathbb{C} \otimes H^2(\mathbb{D}^{n-2})),
$$

and therefore, $M_{z_2}^*(\mathcal{S}_{\theta} \ominus (z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta})) \subseteq \mathcal{Q}_{\theta}$. Consequently,

$$
[C_{z_1}, C_{z_2}^*] = M_{z_2}^* P_{\mathcal{S}_{\theta} \ominus (z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta})} M_{z_1} |_{\mathcal{Q}_{\theta}}.
$$

By Lemma [2.1,](#page-3-0) it is enough to show that $\langle [C_{z_1}, C_{z_2}^*]K_w, K_w \rangle$ does not approach to 0 as w_j approaches to $\partial\mathbb{D}$ for some fixed $3 \leq j \leq n$, and keeping all other co-ordinates of $\mathbf{w} =$ $(w_1,\ldots w_{j-1},w_j,w_{j+1},\ldots,w_n)\in\mathbb{D}^n$ fixed. To this end, let $\boldsymbol{w}\in\mathbb{D}^n$. Since $\{\theta z_3^{m_3}\cdots z_n^{m_n}$: $m_3, \ldots, m_n \in \mathbb{N}$ is an orthonormal basis of $\mathcal{S}_{\theta} \ominus (z_1 \mathcal{S}_{\theta} + z_2 \mathcal{S}_{\theta})$, we have

$$
P_{\mathcal{S}_{\theta}\ominus(z_{1}\mathcal{S}_{\theta}+z_{2}\mathcal{S}_{\theta})}(z_{2}K_{\mathbf{w}})=\sum_{m_{3},...,m_{n}\in\mathbb{N}}\langle z_{2}K_{\mathbf{w}},\theta z_{3}^{m_{3}}\cdots z_{n}^{m_{n}}\rangle\theta z_{3}^{m_{3}}\cdots z_{n}^{m_{n}}
$$

$$
=\sum_{m_{3},...,m_{n}\in\mathbb{N}}\langle K_{\mathbf{w}},z_{3}^{m_{3}}\cdots z_{n}^{m_{n}}(M_{z_{2}}^{*}\theta)\rangle\theta z_{3}^{m_{3}}\cdots z_{n}^{m_{n}}
$$

$$
=\frac{1}{\|\mathbb{S}(\cdot,\mathbf{w})\|}\theta\sum_{m_{3},...,m_{n}\in\mathbb{N}}(\overline{w_{3}}z_{3})^{m_{3}}\cdots(\overline{w_{n}}z_{n})^{m_{n}}\overline{M_{z_{2}}^{*}\theta(\mathbf{w})}
$$

$$
=\overline{M_{z_{2}}^{*}\theta(\mathbf{w})}\prod_{j=1}^{2}(1-|w_{j}|^{2})^{\frac{1}{2}}\Big(\prod_{i=3}^{n}K_{w_{i}}\Big)\theta.
$$

Thus

$$
\langle [C_{z_1}, C_{z_2}^*] K_{\mathbf{w}}, K_{\mathbf{w}} \rangle = \langle M_{z_2}^* P_{S_{\theta} \ominus (z_1 S_{\theta} + z_2 S_{\theta})} M_{z_1} P_{\mathcal{Q}_{\theta}} K_{\mathbf{w}}, K_{\mathbf{w}} \rangle
$$

\n
$$
= \langle M_{z_1} P_{\mathcal{Q}_{\theta}} K_{\mathbf{w}}, P_{S_{\theta} \ominus (z_1 S_{\theta} + z_2 S_{\theta})} (z_2 K_{\mathbf{w}}) \rangle
$$

\n
$$
= \overline{(M_{z_2}^* \theta)(\mathbf{w})} \prod_{j=1}^2 (1 - |w_j|^2)^{\frac{1}{2}} \langle M_{z_1} P_{\mathcal{Q}_{\theta}} K_{\mathbf{w}}, \prod_{i=3}^n K_{w_i} \theta \rangle
$$

\n
$$
= \overline{(M_{z_2}^* \theta)(\mathbf{w})} \prod_{j=1}^2 (1 - |w_j|^2)^{\frac{1}{2}} \langle M_{z_1} (1 - \overline{\theta(\mathbf{w})} \theta) K_{\mathbf{w}}, \prod_{i=3}^n K_{w_i} \theta \rangle,
$$

where the last equality follows from [\(2.2\)](#page-3-1). Since $M_{z_1}^*(\prod_{i=3}^n K_{w_i}) = 0$ and $M_{\theta}^* M_{\theta} = I_{H^2(\mathbb{D}^n)}$, we have

$$
\langle M_{z_1}\theta K_{\boldsymbol{w}}, \prod_{i=3}^n K_{w_i}\theta \rangle = \langle \theta M_{z_1} K_{\boldsymbol{w}}, \prod_{i=3}^n K_{w_i}\theta \rangle = \langle K_{\boldsymbol{w}}, M_{z_1}^*(\prod_{i=3}^n K_{w_i}) \rangle = 0.
$$

Therefore,

$$
\langle [C_{z_1}, C_{z_2}^*] K_{\mathbf{w}}, K_{\mathbf{w}} \rangle = \overline{(M_{z_2}^* \theta)(\mathbf{w})} \prod_{j=1}^2 (1 - |w_j|^2)^{\frac{1}{2}} \Big\langle M_{z_1} K_{\mathbf{w}}, \prod_{i=3}^n K_{w_i} \theta \Big\rangle
$$

\n
$$
= \overline{(M_{z_2}^* \theta)(\mathbf{w})} \prod_{j=1}^2 (1 - |w_j|^2)^{\frac{1}{2}} \Big\langle K_{\mathbf{w}}, \prod_{i=3}^n K_{w_i} (M_{z_1}^* \theta) \Big\rangle
$$

\n
$$
= \overline{(M_{z_2}^* \theta)(\mathbf{w})} \prod_{j=1}^2 (1 - |w_j|^2)^{\frac{1}{2}} \left(\overline{M_{z_1}^* \theta(\mathbf{w})} \frac{1}{\|\mathbb{S}(\cdot, \mathbf{w})\|} \prod_{i=3}^n \frac{1}{(1 - |w_j|^2)^{\frac{1}{2}}} \right)
$$

\n
$$
= \overline{(M_{z_2}^* \theta)(\mathbf{w})} \overline{(M_{z_1}^* \theta)(\mathbf{w})} \prod_{j=1}^2 (1 - |w_j|^2).
$$

Since θ depends on both z_1 and z_2 variables, $M_{z_1}^*\theta$ and $M_{z_2}^*\theta$ are non-zero functions. Therefore it follows that there exists an $l \in \{3, \ldots, n\}$ such that the limit of

$$
\overline{(M_{z_2}^*\theta)(\boldsymbol{w})}\,\overline{(M_{z_1}^*\theta)(\boldsymbol{w})}\prod_{j=1}^2(1-|w_j|^2)
$$

as w_l approaches to $\partial\mathbb{D}$, keeping all other coordinates of w fixed, is a non-zero number. This completes the proof. \Box

We now proceed to the case of doubly commuting quotient modules of an analytic Hilbert module over $\mathbb{C}[z]$. Let Q be a quotient module of an analytic Hilbert module \mathcal{H}_K over $\mathbb{C}[z]$. It is known that Q is doubly commuting (that is, $[C_{z_i}, C^*_{z_j}] = 0$ for all $1 \leq i < j \leq n$) if and only if $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ for some quotient module \mathcal{Q}_i of \mathcal{H}_{k_i} , $i = 1, \ldots, n$ (see [\[4\]](#page-17-9), [\[14\]](#page-17-10) and $[17]$).

THEOREM 3.2. Let $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ be a doubly commuting quotient module of an analytic Hilbert module $\mathcal{H}_K = \mathcal{H}_{k_1} \otimes \cdots \otimes \mathcal{H}_{k_n}$ over $\mathbb{C}[z]$, $n \geq 2$. Then Q is essentially normal if and only if one of the following holds:

- (i) Q is finite dimensional.
- (ii) There exits an $i \in \{1, \ldots, n\}$ such that \mathcal{Q}_i is an infinite dimensional essentially normal quotient module of \mathcal{H}_{k_i} , and $\mathcal{Q}_j \cong \mathbb{C}$ for all $j \neq i$.

Proof. Let $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ be an infinite dimensional essentially normal quotient module. Then at least one of Q_1, \ldots, Q_n is infinite dimensional. Without loss of generality we assume that \mathcal{Q}_n is infinite dimensional. For each $i = 1, \ldots, n$, we now compute the self-commutator:

(3.3)
$$
[C_{z_i}, C_{z_i}^*] = P_Q M_{z_i} M_{z_i}^*|_Q - P_Q M_{z_i}^* P_Q M_{z_i}|_Q
$$

$$
= P_{Q_1} \otimes \cdots \otimes P_{Q_{i-1}} \otimes \underbrace{[C_z, C_z^*]_i}_{\text{i-th place}} \otimes P_{Q_{i+1}} \otimes \cdots \otimes P_{Q_n},
$$

where $[C_z, C_z^*]_i$ is the self-commutator corresponding to the quotient module \mathcal{Q}_i . Since \mathcal{Q}_n is infinite dimensional, the compactness of $[C_{z_i}, C_{z_i}^*]$ implies that $[C_z, C_z^*]_i = 0$ for all $i =$ $1, \ldots, n-1$. Therefore, by Lemma [2.4,](#page-3-2) it follows that $\mathcal{Q}_i \cong \mathbb{C}, i = 1, \ldots, n-1$.

Finally, for $i = n$, the compactness of $[C_{z_n}, C_{z_n}^*] = P_{\mathcal{Q}_1} \otimes \cdots \otimes P_{\mathcal{Q}_{n-1}} \otimes [C_z, C_z^*]_n$ implies that $[C_z, C_z^*]_n$ is compact, that is, \mathcal{Q}_n is essentially normal.

For the converse, it is enough to show that (ii) implies Q is essentially normal. Again, without loss of generality, we assume that \mathcal{Q}_n is infinite dimensional essentially normal quotient module. Then it readily follows from [\(3.3\)](#page-7-0) that $[C_{z_i}, C_{z_i}^*] = 0$, $i = 1, \ldots, n-1$, and $[C_{z_n}, C_{z_n}^*]$ is compact. Now the proof follows from Fuglede-Putnam theorem.

Since $H^2(\mathbb{D}^n)$ and the weighted Bergman modules $L^2_{a,\alpha}(\mathbb{D}^n)$ $(\alpha \in \mathbb{Z}^n, \alpha_i > -1, i = 1, \ldots, n)$ are analytic Hilbert modules over $\mathbb{C}[z]$, the above theorem is applicable. But, for $H^2(\mathbb{D}^n)$ and the Bergman module $L^2_a(\mathbb{D}^n)$ ($\alpha = 0$), we can reformulate it as follows. Recall that every quotient module of $H^2(\mathbb{D})$ is essentially normal.

COROLLARY 3.3. Let $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ be a doubly commuting quotient module of $H^2(\mathbb{D}^n)$, $n \geq 2$. Then Q is essentially normal if and only if one of the following holds:

- (i) Q is finite dimensional.
- (ii) There exits an $i \in \{1, \ldots, n\}$ such that \mathcal{Q}_i is infinite dimensional, and $\mathcal{Q}_j \cong \mathbb{C}$ for all $j \neq i$.

It is also well known that a quotient module $\mathcal Q$ of the Bergman module $L^2_a(\mathbb D)$ is essentially normal if and only if

$$
\dim(\mathcal{S}\ominus z\mathcal{S})<\infty,
$$

where $S := L^2_a(\mathbb{D}) \oplus \mathcal{Q}$ is the corresponding submodule (see [\[21,](#page-18-4) Theorem 3.1]). Using this and Theorem [3.2,](#page-6-0) we have the following result.

COROLLARY 3.4. Let $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ be a doubly commuting quotient module of $L^2_a(\mathbb{D}^n)$, $n \geq 2$. Then Q is essentially normal if and only if one of the following holds:

- (i) Q is finite dimensional.
- (ii) There exits an $i \in \{1, \ldots, n\}$ such that \mathcal{Q}_i is infinite dimensional with $dim(\mathcal{S}_i \ominus z\mathcal{S}_i)$ ∞ and $\mathcal{Q}_j \cong \mathbb{C}$ for all $j \neq i$, where $\mathcal{S}_i = L^2_a(\mathbb{D}) \ominus \mathcal{Q}_i$.

We now restrict our attention to $H^2(\mathbb{D}^2)$, and formulate the definition of the Rudin quotient module of $H^2(\mathbb{D}^2)$ (see [\[5\]](#page-17-11), [\[8\]](#page-17-12)). Let $\Psi = {\psi_n}_{n=0}^{\infty} \subseteq H^2(\mathbb{D})$ be an increasing sequence of finite Blaschke products and $\Phi = {\{\varphi_n\}}_{n=0}^{\infty} \subseteq H^2(\mathbb{D})$ be a decreasing sequence of Blaschke products, that is, ψ_{n+1}/ψ_n and φ_n/φ_{n+1} are non-constant inner functions for all $n \in \mathbb{N}$. Then the Rudin quotient module corresponding to Ψ and Φ is denoted by $\mathcal{Q}_{\Psi,\Phi}$, and defined by

$$
\mathcal{Q}_{\Psi,\Phi}:=\bigvee_{n=0}^{\infty}\big(\mathcal{Q}_{\psi_n}\otimes\mathcal{Q}_{\varphi_n}\big).
$$

We denote by $\mathcal{S}_{\Psi,\Phi}$ the submodule $H^2(\mathbb{D}^2) \oplus \mathcal{Q}_{\Psi,\Phi}$ corresponding to $\mathcal{Q}_{\Psi,\Phi}$. The following representations of $\mathcal{Q}_{\Psi,\Phi}$ and $\mathcal{S}_{\Psi,\Phi}$ are very useful (see [\[5\]](#page-17-11)):

$$
(3.4) \quad \mathcal{Q}_{\Psi,\Phi} = \bigoplus_{n\geq 0} (\mathcal{Q}_{\psi_n} \ominus \mathcal{Q}_{\psi_{n-1}}) \otimes \mathcal{Q}_{\varphi_n} \text{ and } \mathcal{S}_{\Psi,\Phi} = \mathcal{Q}' \otimes H^2(\mathbb{D}) \bigoplus_{n\geq 0} (\mathcal{Q}_{\psi_n} \ominus \mathcal{Q}_{\psi_{n-1}}) \otimes \mathcal{S}_{\varphi_n},
$$

where $\mathcal{Q}_{\psi_{-1}} := \{0\}$ and $\mathcal{Q}' = H^2(\mathbb{D}) \oplus \vee_{n \geq 0} \mathcal{Q}_{\psi_n}$.

Next we show that the Rudin quotient modules are not essentially normal.

THEOREM 3.5. Let $\mathcal{Q}_{\Psi,\Phi}$ be a Rudin quotient module of $H^2(\mathbb{D}^2)$ corresponding to an increasing sequence of finite Blaschke products $\Psi = {\psi_n}_{n\geq 0}$ and a decreasing sequence of Blaschke products $\Phi = {\varphi_n}_{n>0}$. Then $\mathcal{Q}_{\Psi,\Phi}$ is not essentially normal.

Proof. Let b_{β} , the Blaschke factor corresponding to $\beta \in \mathbb{D}$, be a factor of ψ_{m+1}/ψ_m for some $m \geq 0$. For contradiction, we assume that $\mathcal{Q}_{\Psi,\Phi}$ is essentially normal. Then, as ψ_m is a finite Blaschke product, $[C_{\psi_m(z_1)}, C^*_{\psi_m(z_1)}]$ is compact, where $C_{\psi_m(z_1)} = P_{\mathcal{Q}} M_{\psi_m(z_1)}|_{\mathcal{Q}}$ and $\mathcal{Q} := \mathcal{Q}_{\Psi, \Phi}$. Now setting $S := \mathcal{S}_{\Psi,\Phi}$, we have

$$
[C_{\psi_m(z_1)}, C_{\psi_m(z_1)}^*] = P_{\mathcal{Q}} M_{\psi_m(z_1)} M_{\psi_m(z_1)}^* |_{\mathcal{Q}} - P_{\mathcal{Q}} M_{\psi_m(z_1)}^* P_{\mathcal{Q}} M_{\psi_m(z_1)} |_{\mathcal{Q}} = -P_{\mathcal{Q}} (I - M_{\psi_m(z_1)} M_{\psi_m(z_1)}^*) |_{\mathcal{Q}} + P_{\mathcal{Q}} M_{\psi_m(z_1)}^* P_{\mathcal{S}} M_{\psi_m(z_1)} |_{\mathcal{Q}} = -P_{\mathcal{Q}} (P_{\mathcal{Q}_{\psi_m}} \otimes I) |_{\mathcal{Q}} + P_{\mathcal{Q}} M_{\psi_m(z_1)}^* P_{\mathcal{S}} M_{\psi_m(z_1)} |_{\mathcal{Q}}.
$$

Since φ_{m+1} is an infinite Blaschke product, there exists a sequence $\{\lambda_i\} \subset \mathbb{D}$ such that $K_{\lambda_i} \in \mathcal{Q}_{\varphi_{m+1}}$ and λ_i approaches to $\partial \mathbb{D}$ as $i \to \infty$. Furthermore, since $K_{\beta} \otimes K_{\lambda_i} \in \mathcal{Q}$ and $\psi_m K_{\beta} \otimes K_{\lambda_i} \in (Q_{\psi_{m+1}} \ominus Q_{\psi_m}) \otimes Q_{\varphi_{m+1}}$, we have $P_{\mathcal{S}}(\psi_m K_{\beta} \otimes K_{\lambda_i}) = 0$, $i = 1, \ldots, n$ (by [\(3.4\)](#page-8-0)). Thus

$$
P_{\mathcal{Q}}M_{\psi_m(z_1)}^*P_{\mathcal{S}}M_{\psi_m(z_1)}(K_{\beta}\otimes K_{\lambda_i})=0.
$$

Finally, from [\(3.5\)](#page-8-1), we have

$$
\langle [C_{\psi_m(z_1)}, C_{\psi_m(z_1)}^*](K_{\beta} \otimes K_{\lambda_i}), K_{\beta} \otimes K_{\lambda_i} \rangle = -\langle (P_{\mathcal{Q}_{\psi_m}} K_{\beta}) \otimes K_{\lambda_i}, K_{\beta} \otimes K_{\lambda_i} \rangle
$$

= -\langle (1 - \overline{\psi_m(\beta)} \psi_m) K_{\beta}, K_{\beta} \rangle
= -(1 - |\psi_m(\beta)|^2),

which does not converges to 0 as λ_i approaches to $\partial \mathbb{D}$. This completes the proof. \Box

REMARK 3.6. Let $m > 1$. For a decreasing Blaschke products $\{\varphi_n\}_{n=1}^m$ and an increasing finite Blaschke products $\{\psi_n\}_{n=1}^m$, we consider the quotient module

$$
\mathcal{Q}=\bigvee_{n=1}^{m}\mathcal{Q}_{\psi_{n}}\otimes\mathcal{Q}_{\varphi_{n}}.
$$

Adapting the proof of the above theorem, one can conclude that Q is essentially normal if and only if φ_n is finite Blaschke products for all $n = 1, \ldots, m$. In other words, Q is essentially normal if and only if Q is finite dimensional.

4. Boundary Representations for doubly commuting quotient modules

In this section, we study boundary representations for doubly commuting quotient modules of an analytic Hilbert module over $\mathbb{C}[z]$. First, we prove a general result in the setting of minimal tensor products of C^* -algebras. Before that we fix some notations. We denote by $V_1 \otimes V_2$ the algebraic tensor product of two vector spaces V_1 and V_2 , and by $A_1 \otimes A_2$ the minimal tensor product of two C^* -algebras A_1 and A_2 .

THEOREM 4.1. Let A_i be a unital subalgebra of $\mathcal{B}(\mathcal{H}_i)$ for some Hilbert space \mathcal{H}_i , and let $C^*(A_i)$ be the irreducible C^* -algebra generated by A_i in $\mathcal{B}(\mathcal{H}_i)$, $i=1,2$. Set $A:=\overline{(A_1\otimes A_2)}$, the norm closure of $A_1 \otimes A_2$ in $\mathcal{B}(\mathcal{H}_1 \otimes \mathcal{H}_2)$. Then the following are equivalent.

- (i) The identity representation of $C^*(A_1) \otimes C^*(A_2)$ is a boundary representation relative to A.
- (ii) The identity representation of $C^*(A_i)$ is a boundary representation relative to A_i for all $i = 1, 2$.

Proof. Suppose (i) holds, and for contradiction, we assume that the identity representation of $C^*(A_1)$ is not a boundary representation relative to A_1 . Then there exists a CP map $\tau: C^*(A_1) \to \mathcal{B}(\mathcal{H}_1)$ different from $\mathrm{id}_{C^*(A_1)}$, but $\tau = \mathrm{id}_{C^*(A_1)}$ on A_1 . Then the CP map $\tau \otimes id_{C^*(A_2)} : C^*(A_1) \otimes C^*(A_2) \to B(\mathcal{H}_1 \otimes \mathcal{H}_2)$ is a CP extension of the map $id_{C^*(A_1) \otimes C^*(A_2)}|_{A_1}$ to $C^*(A_1) \otimes C^*(A_2)$, and $\tau \otimes id_{C^*(A_2)} \neq id_{C^*(A_1) \otimes C^*(A_2)}$. This is a contradiction.

On the other hand suppose (ii) holds. It follows from $[1,$ Theorem 2.2.7 that the identity representation of $C^*(A_1) \otimes C^*(A_2)$ is a boundary representation relative to the linear subspace $\mathbb{C}I \otimes C^*(A_1) \bigvee C^*(A_1) \otimes \mathbb{C}I$. Thus it is enough to show that any CP extension $\tau: C^*(A_1) \otimes$ $C^*(A_2) \to \mathcal{B}(\mathcal{H}_1 \otimes \mathcal{H}_2)$ of $\mathrm{id}_{C^*(A_1) \otimes C^*(A_2)}|_A$ agrees with $\mathrm{id}_{C^*(A_1) \otimes C^*(A_2)}$ on the subspace $\mathbb{C}I \otimes$ $C^*(A_1) \bigvee C^*(A_1) \otimes \mathbb{C}I$, that is,

$$
\tau(I \otimes T_2) = I \otimes T_2 \text{ and } \tau(T_1 \otimes I) = T_1 \otimes I \qquad (T_1 \in C^*(A_1), T_2 \in C^*(A_2)).
$$

To this end, let ω be a positive linear functional on $\mathcal{B}(\mathcal{H}_1)$, and

$$
(\omega \overline{\otimes} \mathrm{id}_{\mathcal{B}(\mathcal{H}_2)}) \circ \tau : C^*(A_1) \otimes C^*(A_2) \to \mathcal{B}(\mathcal{H}_2)
$$

be the corresponding CP map. By identifying $\mathbb{C} I \otimes C^*(A_2)$ with $C^*(A_2)$, one sees that the CP map $(\omega \otimes id_{\mathcal{B}(\mathcal{H}_2)}) \circ \tau|_{\mathbb{C}I \otimes C^*(A_2)}$ is an extension of $\omega(I) id_{C^*(A_2)}|_{A_2}$. Then, by the assumption, we have

$$
(\omega \overline{\otimes} \mathrm{id}_{\mathcal{B}(\mathcal{H}_2)}) \circ \tau(I \otimes T) = \omega(I)T = \omega \overline{\otimes} \mathrm{id}_{C^*(A_2)}(I \otimes T) \quad (T \in C^*(A_2)).
$$

By linearity, the above equality is also true for any linear functional ω on $\mathcal{B}(\mathcal{H}_1)$, and this suggests that

$$
\tau = \mathrm{id}_{C^*(A_1) \otimes C^*(A_2)} \text{ on } \mathbb{C}I \otimes C^*(A_2).
$$

Similarly, by considering linear functionals on $\mathcal{B}(\mathcal{H}_2)$ and repeating the above arguments, we get that $\tau = id_{C^*(A_1) \otimes C^*(A_2)}$ on $C^*(A_1) \otimes \mathbb{C}I$. This completes the proof.

REMARK 4.2. The above result can be easily generalized for finite number of irreducible generating C[∗]-algebras corresponding to unital subalgebras.

As a straightforward consequence of Remark [4.2](#page-9-0) we have the following:

THEOREM 4.3. Let $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ be a doubly commuting quotient module of an analytic Hilbert module $\mathcal{H} = \mathcal{H}_{K_1} \otimes \cdots \otimes \mathcal{H}_{K_n}$ over $\mathbb{C}[z]$. Then the following are equivalent.

- (i) The identity representation of $C^*(\mathcal{Q})$ is a boundary representation relative to $B(\mathcal{Q})$.
- (ii) The identity representation of $C^*(\mathcal{Q}_i)$ is a boundary representation relative to $B(\mathcal{Q}_i)$ for all $i = 1, \ldots, n$.

Proof. The result follows from Remark [4.2](#page-9-0) and the fact that

$$
C^*(\mathcal{Q})=C^*(\mathcal{Q}_1)\otimes\cdots\otimes C^*(\mathcal{Q}_n),
$$

and

$$
B(\mathcal{Q}) = \overline{B(\mathcal{Q}_1) \underline{\otimes} \cdots \underline{\otimes} B(\mathcal{Q}_n)},
$$

where the closure is under the norm topology of $B(Q)$.

The following result is now an immediate consequence of Theorems [1.2](#page-2-1) and [4.3.](#page-10-2)

THEOREM 4.4. Let $\mathcal{Q} = \mathcal{Q}_{\theta_1} \otimes \cdots \otimes \mathcal{Q}_{\theta_n}$ be a doubly commuting quotient module of $H^2(\mathbb{D}^n)$, where θ_i $(i = 1, \ldots, n)$ is a one variable inner function. Then the following are equivalent.

- (i) The identity representation of $C^*(\mathcal{Q})$ is a boundary representation relative to $B(\mathcal{Q})$.
- (ii) The identity representation of $C^*(\mathcal{Q}_{\theta_i})$ is a boundary representation relative to $B(\mathcal{Q}_{\theta_i})$ for all $i = 1, \ldots, n$.
- (iii) For all $i = 1, \ldots, n$, Z_{θ_i} is a proper subset of \mathbb{T} , where Z_{θ_i} consists of all points λ on $\mathbb T$ for which θ_i cannot be continued analytically from $\mathbb D$ to λ .

Now we turn to the case of the Bergman module $L^2_a(\mathbb{D}^n)$. For $n=1$, boundary representations corresponding to a quotient module of $L^2_a(\mathbb{D})$ are studied in [\[13\]](#page-17-13). For a submodule S of $L^2_a(\mathbb{D}), \text{ set}$

$$
Z_*(\mathcal{S}) := \bigcap_{f \in \mathcal{S}} Z_*(f),
$$

where

$$
Z_*(f) = \left\{ \lambda \in \mathbb{D} : f(\lambda) = 0 \right\} \cup \left\{ \lambda \in \mathbb{T} : \liminf_{z \in \mathbb{D}, z \to \lambda} |f(z)| = 0 \right\}.
$$

It is easy to see that for a finite dimensional quotient module $\mathcal Q$ of $L^2_a(\mathbb D)$, the identity representation of $C^*(\mathcal{Q})$ is always a boundary representation relative to $B(\mathcal{Q})$. On the other hand, for an infinite dimensional \mathcal{Q} , the identity representation of $C^*(\mathcal{Q})$ is a boundary representation relative to $B(Q)$ if and only if $\dim(\mathcal{S} \ominus z\mathcal{S}) = 1$ and $Z_*(\mathcal{S})$ is a proper subset of \mathbb{T} , where $\mathcal{S} = L^2_a(\mathbb{D}) \oplus \mathcal{Q}$ is the corresponding submodule (see [\[13,](#page-17-13) Theorem 1.2]). Using this and Theorem [4.3,](#page-10-2) we have the following result.

THEOREM 4.5. Let $\mathcal{Q} = \mathcal{Q}_1 \otimes \cdots \otimes \mathcal{Q}_n$ be a doubly commuting quotient module of $L^2_a(\mathbb{D}^n)$. Then the following are equivalent.

- (i) The identity representation of $C^*(\mathcal{Q})$ is a boundary representation relative to $B(\mathcal{Q})$.
- (ii) The identity representation of $C^*(\mathcal{Q}_i)$ is a boundary representation relative to $B(\mathcal{Q}_i)$ for all $i = 1, \ldots, n$.
- (iii) If \mathcal{Q}_i (1 ≤ i ≤ n) is infinite dimensional then $dim(\mathcal{S}_i \ominus z\mathcal{S}_i) = 1$ and $Z_*(\mathcal{S}_i)$ is a proper subset of \mathbb{T} , where $\mathcal{S}_i = L^2_a(\mathbb{D}) \ominus \mathcal{Q}_i$ is the corresponding submodule.

5. Boundary representation for homogeneous quotient modules

In this section we study of boundary representations for homogeneous quotient modules of $H^2(\mathbb{D}^2)$. To begin with, we establish a general result, which might be well-known to the experts. For an essentially normal quotient module $\mathcal Q$ of $H^2(\mathbb D^n)$, $\sigma_e(\mathcal Q)$ denotes the essential joint spectrum of the tuple $(C_{z_1},...,C_{z_n})$. Recall that the notations $C^*(\mathcal{Q})$ and $B(\mathcal{Q})$ denote the C^{*}-algebra and the Banach algebra generated by $\{I_{\mathcal{Q}}, C_{z_1}, \ldots, C_{z_n}\}\)$ respectively, where $C_{z_i} = P_{\mathcal{Q}} M_{z_i} |_{\mathcal{Q}}$ for all $i = 1, \ldots, n$.

LEMMA 5.1. Let Q be an essentially normal quotient module of $H^2(\mathbb{D}^n)$.

(a) If there exists a matrix-valued polynomial p such that

$$
||p(C_{z_1},...,C_{z_n})|| > ||p||_{\sigma_e(Q)}^{\infty},
$$

then the identity representation of $C^*(\mathcal{Q})$ is a boundary representation relative to $\mathcal{B}(\mathcal{Q})$.

(b) If the commuting tuple $(C_{z_1},...,C_{z_n})$ has a normal dilation on $\sigma_e(Q)$, then the identity representation of $C^*(\mathcal{Q})$ is not a boundary representation relative to $\mathcal{B}(\mathcal{Q})$.

Proof. (a) Since Q is essentially normal then we have an extension

$$
0 \longrightarrow K(\mathcal{Q}) \hookrightarrow C^*(\mathcal{Q}) \longrightarrow C(\sigma_e(\mathcal{Q})) \longrightarrow 0.
$$

Now suppose there exists a matrix-valued polynomial p such that

$$
||p(C_{z_1},...,C_{z_n})|| > ||p||_{\sigma_e(Q)}^{\infty}.
$$

Then the restriction of the canonical contractive homomorphism

$$
q: C^*(\mathcal{Q}) \to C^*(\mathcal{Q})/K(\mathcal{Q}) \cong C(\sigma_e(\mathcal{Q}))
$$

to $\mathcal{B}(Q)$ is not a complete isometry. Therefore the conclusion now follows from [\[2,](#page-17-7) Theorem 2.1.1].

(b) The existence of normal dilation implies that the above completely contractive map q restricted to the linear span of $\mathcal{B}(Q) \cup \mathcal{B}(Q)^*$ is a complete isometry. The proof again follows from $[2,$ Theorem 2.1.1.].

We now consider boundary representations for \mathcal{Q}_{η} type quotient modules (defined below) of $H^2(\mathbb{D}^n)$, which—when restricted to $n=2$ —will play a crucial role in the study of boundary representations of homogeneous quotient modules of $H^2(\mathbb{D}^2)$. Given an *n*-tuple of one variable inner functions $\eta = (\eta_1(z_1), \ldots, \eta_n(z_n))$, denote by

(5.6)
$$
\mathcal{S}_{\underline{\eta}} = [\eta_1(z_1) - \eta_2(z_2), \eta_2(z_2) - \eta_3(z_3), \dots, \eta_{n-1}(z_{n-1}) - \eta_n(z_n)],
$$

the submodule of $H^2(\mathbb{D}^n)$ generated by $\eta_{i-1}(z_{i-1}) - \eta_i(z_i)$, $i = 2, \ldots, n$. The corresponding quotient module is denoted by $\mathcal{Q}_{\underline{\eta}} = \mathcal{S}_{\eta}^{\perp}$. The essential normality of $\mathcal{Q}_{\underline{\eta}}$ -type quotient modules is studied by Clark [\[7\]](#page-17-2) and Wang [\[20\]](#page-18-0). The complete characterisation of their essential normality is as follows.

THEOREM 5.2 ([\[7\]](#page-17-2) & [\[20\]](#page-18-0)). Let η_i be a non-constant inner function of $H^2(\mathbb{D})$, $i = 1, ..., n$. Then the quotient module \mathcal{Q}_{η} is essentially normal if and only if η_i is a finite Blaschke product for all $i = 1, \ldots, n$.

For a quotient module \mathcal{Q}_η , define

$$
V_{\underline{\eta}} := \{ (z_1, \ldots, z_n) \in \mathbb{D}^n : \eta_1(z_1) = \cdots = \eta_n(z_n) \},
$$

and

$$
\partial V_{\underline{\eta}} := \{ (z_1, \ldots, z_n) \in \partial \mathbb{D}^n : \eta_1(z_1) = \cdots = \eta_n(z_n) \}.
$$

Then one can easily check that

$$
Z(\mathcal{S}_{\underline{n}}) = \{(z_1, \ldots, z_n) \in \mathbb{D}^n : f(z_1, \ldots, z_n) = 0, \text{ for all } f \in \mathcal{S}_{\underline{n}}\} = V_{\underline{n}},
$$

and

$$
Z_{\partial}(\mathcal{S}_{\underline{\eta}}) = \left\{ \boldsymbol{z} = (z_1, \ldots, z_n) \in \partial \mathbb{D}^n : \exists \{ \boldsymbol{z}_k \} \subset Z(\mathcal{S}_{\underline{\eta}}) \text{ such that } \lim_{k \to \infty} \boldsymbol{z}_k = z \right\} = \partial V_{\underline{\eta}}.
$$

The following lemma will be useful to study the boundary representations of these quotient modules.

LEMMA 5.3. Let \mathcal{Q}_{η} be an essentially normal quotient module of $H^2(\mathbb{D}^n)$, as in Theorem [5.2.](#page-11-0) Then

$$
\sigma_e(\mathcal{Q}_{\underline{\eta}}) = \partial V_{\underline{\eta}},
$$

where $\sigma_e(\mathcal{Q}_\eta)$ is the essential joint spectrum of the tuple $(C_{z_1}, \ldots, C_{z_n})$.

Proof. It is shown in [\[12,](#page-17-5) Theorem 6.1] that $Z_{\partial}(\mathcal{S}_{\eta}) = \partial V_{\eta} \subseteq \sigma_e(\mathcal{Q}_{\eta})$. On the other hand, by [\[7,](#page-17-2) Theorem 5.1, the tuple $(C_{z_1},...,C_{z_n})$ is unitarily equivalent to the co-ordinate multiplication operator $(T_{z_1}, \ldots, T_{z_n})$ on $A^{2,n-2}(V_\eta)$, and by [\[7,](#page-17-2) Theorem 7.1] $\sigma_e(T_{z_i}) \subseteq \mathbb{T}$. Thus $\sigma_e(\mathcal{Q}_{\eta}) \subseteq \mathbb{T}^n$. Also note that since η_i 's are finite Blaschke products,

$$
(\eta_i(z_i) - \eta_{i+1}(z_{i+1})) (C_{z_1}, \ldots, C_{z_n}) = 0 \quad (i = 1, \ldots, n-1).
$$

Hence, for each $i = 1, \ldots, n - 1$, by spectral mapping theorem, $\eta_i(z_i) = \eta_{i+1}(z_{i+1})$ whenever $(z_1, \ldots, z_n) \in \sigma_e(\mathcal{Q}_\eta)$. Thus $\sigma_e(\mathcal{Q}_\eta) \subseteq \mathbb{T}^n \cap V_\eta = \partial V_\eta$. The proof follows.

A characterisation of boundary representations is given next.

THEOREM 5.4. Let \mathcal{Q}_η be an essentially normal quotient module of $H^2(\mathbb{D}^n)$ corresponding to η . Then the identity representation of $C^*(\mathcal{Q}_\eta)$ is not a boundary representation relative to $B(\mathcal{Q}_\eta).$

Proof. Since \mathcal{Q}_η is essentially normal, by Lemma [5.1](#page-11-1) and Lemma [5.3](#page-12-0) it is enough to show that the tuple $(C_{z_1},...,C_{z_n})$ has a normal dilation on ∂V_{η} . It is shown in [\[7,](#page-17-2) Theorem 5.1] that the tuple $(C_{z_1}, \ldots, C_{z_n})$ is unitary equivalent to the *n*-tuple of co-ordinate multiplication operators $(T_{z_1},...,T_{z_n})$ on $A^{2,n-2}(V_{\eta})$. Now it follows that $A^{2,n-2}(V_{\eta}) \subset L^2(d\mu)$ for some measure μ on V_{η} (see the appendix of this article for more details). Thus the tuple $(T_{z_1},...,T_{z_n})$ has a normal dilation on V_η . Since ∂V_η is the Shilov boundary of V_η , the proof follows.

Now we turn our attention to homogeneous quotient modules of $H^2(\mathbb{D}^2)$. First we recall the complete characterisation of their essential normality obtained in [\[12\]](#page-17-5). Let p be a homogeneous polynomial in $\mathbb{C}[z_1, z_2]$, then p can be factorised uniquely, up to a scalar multiple of modulus one, as

$$
p=p_1p_2,
$$

where p_1 and p_2 are homogeneous polynomial with the following property:

 $Z(p_1) \cap \partial \mathbb{D}^2 \subset \mathbb{T}^2$ and $Z(p_2) \cap \partial \mathbb{D}^2 \subset (\mathbb{D} \times \mathbb{T}) \cup (\mathbb{T} \times \mathbb{D}).$

For a homogeneous polynomial p, essential normality of $\mathcal{Q}_p := H^2(\mathbb{D}^2)/[p]$ in term of the above factorisation of p is studied in [\[12\]](#page-17-5).

THEOREM 5.5 (Guo & Wang, [\[12\]](#page-17-5)). Let p be a non-zero homogeneous polynomial in $\mathbb{C}[z_1, z_2]$, and $p = p_1p_2$ be the factorisation of p as above. Then the quotient module \mathcal{Q}_p is essentially normal if and only if p_2 has one of the following forms:

- (i) $p_2 = c$ with $c \neq 0$,
- (ii) $p_2 = \alpha z_1 + \beta z_2$ with $|\alpha| \neq |\beta|$,
- (iii) $p_2 = c(z_1 \alpha z_2)(z_2 \beta z_1)$ with $|\alpha| < 1, |\beta| < 1$ and $c \neq 0$.

The following result in [\[12\]](#page-17-5) gives a description of the essential joint spectrum of the above type of quotient modules. For a proof see [\[12,](#page-17-5) Theorem 6.2].

LEMMA 5.6 (Guo & Wang, [\[12\]](#page-17-5)). Let p be a homogeneous polynomial. Then $\sigma_e(\mathcal{Q}_p) = Z(p) \cap$ $\partial \mathbb{D}^2 = Z(p) \cap \mathbb{T}^2$.

For our purpose we do not need the full strength of the above lemma. To be precise we only need $\sigma_e(Q_p) \subset Z(p)$. The next two lemmas are the first step towards a characteristion of boundary representations for homogeneous quotient modules.

LEMMA 5.7. Let $p = c \prod_{i=1}^{m} (z_1 - \alpha_i z_2)^{n_i}$ be a homogeneous polynomial with $c \neq 0$ and α_i 's are distinct scalars of modulus one. Assume further that $n_i > 1$ for some $i = 1, \ldots, m$. Then the identity representation of $C^*(\mathcal{Q}_p)$ is a boundary representation relative to $B(\mathcal{Q}_p)$.

Proof. Without loss of any generality assume that $n_1 > 1$. Then for

$$
q := (z_1 - \alpha_1 z_2) \prod_{i=2}^m (z_1 - \alpha_i z_2)^{n_i},
$$

we have $||q||_{Z(p)}^{\infty} = 0$, but the operator $q(C_{z_1}, C_{z_2})$ is a non-zero operator on \mathcal{Q}_p . Thus the proof follows from Lemma [5.1.](#page-11-1)

LEMMA 5.8. Let $p = c(z_1 - \alpha z_2)$, for some $\alpha \in \mathbb{C}$ with $|\alpha| \neq 1$. Then the identity representation of $C^*(\mathcal{Q}_p)$ is not a boundary representation relative to $B(\mathcal{Q}_p)$.

Proof. First note that if $\alpha = 0$, then \mathcal{Q}_p is unitarily equivalent to $H^2(\mathbb{D})$; and in this case we already know the result is true. If $\alpha \neq 0$, then $C^*(\mathcal{Q}_p)$ is generated by C_{z_1} as $\frac{1}{\alpha}C_{z_1} = C_{z_2}$. Thus it is enough to study the operator C_{z_1} only. To this end, we assume that $|\alpha| > 1$. The case when $|\alpha| < 1$ can be treated similarly. Set $\beta := \frac{\alpha}{|\alpha|^2}$, and for all $n \in \mathbb{N}$ set $c_n := (\sum_{i=0}^n |\beta|^{2i})^{1/2}$. Then a straight forward calculation confirms that the sequence of homogeneous polynomials

$$
p_n = \frac{1}{c_n} \sum_{i=0}^n z_1^i (\beta z_2)^{n-i} \quad (n \in \mathbb{N})
$$

gives an orthonormal basis for \mathcal{Q}_p . With respect to this orthonormal basis, the operator C_{z_1} has the following form:

$$
C_{z_1}(p_n) = P_{\mathcal{Q}_p}\left(\frac{1}{c_n}\sum_{i=0}^n z_1^{i+1}(\beta z_2)^{n-i}\right)
$$

= $\frac{1}{c_n}\left\langle p_{n+1}, \sum_{i=0}^n z_1^{i+1}(\beta z_2)^{n-i}\right\rangle p_{n+1}$
= $\frac{c_n}{c_{n+1}}p_{n+1}.$

The above equality is true for $n \geq 0$. Therefore, C_{z_1} is a weighted shift with weights $\{\frac{c_n}{c_{n+1}}\}$ $\frac{c_n}{c_{n+1}}\}_n \geq 0.$ Since $\limsup_n \frac{c_n}{c_{n+1}}$ $\frac{c_n}{c_{n+1}} = \sup_n \frac{c_n}{c_{n+1}}$ $\frac{c_n}{c_{n+1}}$, the result now follows from [\[2,](#page-17-7) Corollary 2].

THEOREM 5.9. Let \mathcal{Q}_p be an essentially normal quotient module of $H^2(\mathbb{D}^2)$ for a homogeneous polynomial p. Then the identity representation of $C^*(\mathcal{Q}_p)$ is a boundary representation relative to $B(\mathcal{Q}_p)$ if and only if p is not of the following forms: (i) $p = c(z_1^m - \alpha z_2^m)$ for some $m \in \mathbb{N}$, $c \neq 0$ and $|\alpha| = 1$, (ii) $p = \alpha z_1 + \beta z_2$ with $|\alpha| \neq |\beta|$.

Proof. If $p = c(z_1^m - \alpha z_2^m)$, then \mathcal{Q}_p is of the form \mathcal{Q}_p , where $\underline{\eta} = (z_1^m, \alpha z_2^m)$. Now it follows from Theorem [5.4](#page-12-1) that identity representation of $C^*(\mathcal{Q}_p)$ is not a boundary representation relative to $B(\mathcal{Q}_p)$. Also if $p = \alpha z_1 + \beta z_2$, then by Lemma [5.8](#page-13-0) we have the desire conclusion.

For the other direction fist note that since \mathcal{Q}_p is essentially normal then p is of the form as in Theorem [5.5.](#page-13-1) Now by Lemma [5.7,](#page-13-2) is it enough to consider $p = p_1p_2$, where $p_1 = \prod_{i=1}^{m} (z_1 - \alpha_i z_2)$ with α_i 's are all distinct scalar of modulus one and p_2 is as in Theorem [5.5.](#page-13-1) In view of the forms of p_2 in Theorem [5.5](#page-13-1) we divide this family of polynomials in four subfamilies. For each of the subfamilies we establish that the identity representation is a boundary representation.

Case I: Let $p_2 = c$ and $p_1 = \prod_{i=1}^m (z_1 - \alpha_i z_2)$, for distinct scalars α_i 's with modulus one, such that $p = p_1 p_2$ is not of the form $c(z_1^m - \alpha z_2^m)$. Thus, in this case, $m > 1$. Consider the polynomial (5.7)

$$
q = \frac{\prod_{i=1}^{m} (z_1 - \alpha_i z_2) - (-1)^m (\prod_{i=1}^{m} \alpha_i) z_2^m}{z_1} = \sum_{k=0}^{m-1} (-1)^k \left(\sum_{1 \le i_1 < \dots < i_k \le m} \alpha_{i_1} \dots \alpha_{i_k} \right) z_1^{m-k-1} z_2^k.
$$

A simple calculation shows that

$$
\|q\|_{Z(p)\cap \partial \mathbb{D}^2}^\infty=1.
$$

On the other hand

$$
||q(C_{z_1}, C_{z_2})|| \ge ||q||_{H^2(\mathbb{D}^2)} = \sqrt{1 + \sum_{k=1}^{m-1} \left| \sum_{1 \le i_1 < \dots < i_k \le m} \alpha_{i_1} \dots \alpha_{i_k} \right|^2}.
$$

Now if $\sum_{k=1}^{m-1} \left| \sum_{1 \leq i_1 < \dots < i_k \leq m} \alpha_{i_1} \dots \alpha_{i_k} \right|$ ² = 0, then by [\(5.7\)](#page-14-0) $\prod_{i=1}^{m} (z_1 - \alpha_i z_2)$ can be written as $z_1^m - \alpha z_2^m$ for some α of unit modulus, which is a contradiction. Thus $\|q(C_{z_1}, C_{z_2})\| > 1$, and therefore, by Lemma [5.1](#page-11-1) the identity representation is a boundary representation in this case.

Case II: Let $p_2 = (z_1 - \gamma z_2), |\gamma| \neq 1$ and $p_1 = \prod_{i=1}^m (z_1 - \alpha_i z_2)$ for distinct scalars α_i 's with modulus one. Without loss of generality we assume that $|\gamma|$ < 1 (otherwise, by interchanging the role of z_1 and z_2 , one could consider $p_2 = (z_2 - \frac{1}{\gamma})$ $(\frac{1}{\gamma}z_1)$ and $p_1 = \prod_{i=1}^m (z_2 - \frac{1}{\alpha})$ $(\frac{1}{\alpha_i}z_1)$. Letting $\alpha_{m+1} = \gamma$, consider the polynomial q as in [\(5.7\)](#page-14-0), that is,

$$
q = \frac{\prod_{i=1}^{m+1} (z_1 - \alpha_i z_2) - (-1)^{m+1} \prod_{i=1}^{m+1} \alpha_i z_2^{m+1}}{z_1}.
$$

Again, by similar computations as in the previous case,

$$
||q||_{Z(p)\cap \partial \mathbb{D}^2}^{\infty} = 1
$$
 and $||q(C_{z_1}, C_{z_2})|| \ge \sqrt{1 + \sum_{k=1}^{m} \left| \sum_{1 \le i_1 < \dots < i_k \le m+1} \alpha_{i_1} \dots \alpha_{i_k} \right|^2}.$

Now if $\sum_{k=1}^{m} \left| \sum_{1 \leq i_1 < \cdots < i_k \leq m+1} \alpha_{i_1} \ldots \alpha_{i_k} \right|$ $2^2 = 0$, then $\prod_{i=1}^{m+1} (z_1 - \alpha_i z_2) = z_1^{m+1} - \alpha z_2^{m+1}$ for some scalar α with $|\alpha| \neq 1$. This implies that $|\alpha_1| = \cdots = |\alpha_{m+1}| = |\alpha|^{1/(m+1)} \neq 1$, which is a contradiction. Thus $||q(C_{z_1}, C_{z_2})|| > 1$, and the conclusion again follows from Lemma [5.1.](#page-11-1)

Case III: Let $p = p_2 = (z_1 - \gamma_1 z_2)(z_1 - \gamma_2 z_2)$ with $|\gamma_1| < 1, |\gamma_2| > 1$. In this case, for $\epsilon > 0$ is a positive real numberwe consider the polynomial $q_{\epsilon} := (z_1 - \epsilon \gamma_2 z_2)$. Set

$$
V_1 := \{ (\gamma_1 z_2, z_2) \in \partial \mathbb{D}^2 : |z_2| = 1 \} \text{ and } V_2 := \{ (\gamma_2 z_2, z_2) \in \partial \mathbb{D}^2 : |\gamma_2 z_2| = 1 \}.
$$

We now note that $Z(p) \cap \partial \mathbb{D}^2 = V_1 \cup V_2$, and the following equalities hold:

$$
||q_{\epsilon}||^{\infty}_{V_1}=|\gamma_1-\epsilon\gamma_2|, \quad ||q_{\epsilon}||^{\infty}_{V_2}=(1-\epsilon).
$$

Thus, by choosing $0 < \epsilon < 1$ small enough, one can have $||q_{\epsilon}||_{Z(p) \cap \partial \mathbb{D}^2}^{\infty} < 1$. On the other hand, for any $0 < \epsilon < 1$

$$
||q_{\epsilon}(C_{z_1}, C_{z_2})|| \geq \sqrt{1+|\epsilon \gamma_2|^2} > 1.
$$

Now Lemma [5.1](#page-11-1) applies.

Case IV: Let $p_2 = (z_1 - \gamma_1 z_2)(z_1 - \gamma_2 z_2)$, $|\gamma_1| < 1$, $|\gamma_2| > 1$ and $p_1 = \prod_{i=1}^{m} (z_1 - \alpha_i z_2)$ for distinct scalars α_i 's with modulus one. For notational simplicity we set

$$
V_{\gamma_1} := \{ (\gamma_1 z_2, z_2) \in \partial \mathbb{D}^2 : |z_2| = 1 \}, \quad V_{\gamma_2} := \{ (\gamma_2 z_2, z_2) \in \partial \mathbb{D}^2 : |\gamma_2 z_2| = 1 \},
$$

and

$$
V_{\alpha_i} := \{ (\alpha_i z_2, z_2) \in \partial \mathbb{D}^2 : |z_2| = 1 \}, \quad i = 1, \dots, m.
$$

Now for $\epsilon > 0$, consider the polynomial

$$
q_{\epsilon}=z_2(z_1^m-\epsilon q'), \text{ where } q'=\sum_{k=1}^m\left(\sum_{1\leq i_1<\cdots
$$

Then it can be easily verified that

$$
||q_{\epsilon}||^{\infty}_{V_{\gamma_1}} \leq |\gamma_1^m| - \epsilon M, \quad ||q_{\epsilon}||^{\infty}_{V_{\gamma_2}} \leq |\frac{1}{\gamma_2}| - \epsilon M,
$$

and

$$
||q_{\epsilon}||_{V_{\alpha_i}}^{\infty} = |(1-\epsilon)|, \quad i = 1,\ldots,m,
$$

where $M = \max\{|q'(\gamma_1, 1)|, |q'(\frac{1}{\gamma_1})|\}$ $\frac{1}{\gamma_2}$, 1)|}. We now choose $0 < \epsilon < 1$ for which $||q_{\epsilon}||_{Z(p) \cap \partial \mathbb{D}^2}^{\infty} < 1$. On the other hand $||q_{\epsilon}(C_{z_1}, C_{z_2})|| \ge ||q_{\epsilon}|| > 1$. This completes the proof.

APPENDIX: A MEASURE ON V_{η}

We first look at the holomorphic functions on V_{η} as given in [\[7\]](#page-17-2). By definition, a function f is holomorphic in an analytic variety V of a complex manifold M if for every $x \in V$, there is a neighbourhood $U_x \subset M$ and a holomorphic function F on U_x such that $F|_{V \cap U_x} = f|_{V \cap U_x}$. Clark [\[7\]](#page-17-2) showed that a holomorphic function f on $V_{\underline{\eta}}$ can be recovered in following way: Define a function h on \mathbb{D}^{n+1} by

$$
h(z_1,\ldots,z_n;\lambda)=\sum_{k=1}^m f(b_k(\lambda))\prod_{j=1}^n\frac{(\lambda-\eta_j(z_j))}{((b_k(\lambda))_j-z_j)\eta_j'((b_k(\lambda))_j)},
$$

where $b_k(\lambda)$ $(k = 1, \ldots, m)$ is a pre-image of $\lambda \in \mathbb{D}$ under the map $\phi: V_\eta \to \overline{\mathbb{D}}, \phi(z_1, \ldots, z_n) =$ $\eta_1(z_1)$, and $(b_k(\lambda))_j$ is the j-th coordinate of $b_k(\lambda)$. The following lemma is due to Clark [\[7\]](#page-17-2).

LEMMA 5.10. ([\[7\]](#page-17-2)) As a function of λ , $h(z_1, \ldots, z_n; \lambda)$ extends to a holomorphic $\mathcal{Q}_{\eta_1} \otimes \ldots \otimes$ \mathcal{Q}_{η_n} -valued function in \mathbb{D} , and $h(z_1,\ldots,z_n;\eta_1(z_1))=f(z_1,\ldots,z_n)$ for all $(z_1,\ldots,z_n)\in V$.

A holomorphic function f on V_{η} can also be written as

$$
f(z_1,...,z_n) = \sum_{\nu=0}^{\infty} f_{\nu}(z_1,...,z_n) (\eta_1(z_1))^{\nu},
$$

where $f_{\nu} \in \mathcal{Q}_{\eta_1} \otimes \ldots \otimes \mathcal{Q}_{\eta_n}$. In the same paper [\[7\]](#page-17-2) Clark defined a class of norms in the space of holomorphic functions on $V_{\underline{\eta}}.$ In that process he defined

$$
f_{[r]}(z_1,\ldots,z_n):=\sum_{\nu=0}^{\infty}f_{\nu}(z_1,\ldots,z_n)r^{\nu}(\eta_1(z_1))^{\nu}.
$$

From the definition of the function h we have for $(z_1, \ldots, z_n) \in \partial V_{\eta}$:

$$
(5.8) \t f_{[r]}(z_1,\ldots,z_n) = \sum_{k=1}^m f(b_k(r\eta_1(z_1))) \prod_{j=1}^n \frac{r\eta_1(z_1) - \eta_j(z_j)}{((b_k(r\eta_1(z_1)))_j - z_j)\eta'_1((b_k(r\eta_1(z_1)))_j)}.
$$

The norm in the space $A^{2,n}(V_{\eta})$ is defined by

$$
||f||_{2,n}^2 = 2(n+1) \int_0^1 ||f_{[r]}(z_1,\ldots,z_n)||_2^2 (1-r^2)^n r dr,
$$

where

$$
||f_{[r]}||_2 = \sup_{0 \leq s < 1} \left(\int_0^{2\pi} \int |f_{[rs]}(w_1, \ldots, w_n)|^2 d\mu_{e^{i\theta}}(w) d\theta \right)^{1/2}.
$$

Here the measure $d\mu_{e^{i\theta}}$ is a measure supported in the fibre over the point $e^{i\theta}$ under the map ϕ ; more precisely,

$$
\mu_{e^{i\theta}}(b_k(e^{i\theta})) = |\eta'_1((b_k(e^{i\theta}))_1) \dots \eta'_n((b_k(e^{i\theta}))_n)|^{-1}.
$$

We can rewrite the norm of f as

(5.9)
$$
||f||_{2,n}^2 = 2(n+1) \int_0^1 \int_0^{2\pi} \int |f_{[r]}(w_1,\ldots,w_n)|^2 r (1-r^2)^n d\mu_{e^{i\theta}}(w) d\theta dr.
$$

The space $A^{2,n}(V_{\eta})$ is the collection of holomorphic functions on V_{η} such that $||f||_{2,n} < \infty$. From [\[7,](#page-17-2) Lemma 4.1] we can deduce that the constant function 1 lies in $A^{2,n}(V_n)$.

We can now define a measure μ on V_{η} as

$$
\mu(E) = ||\chi_E||_{2,n}^2,
$$

where χ_E is the characteristic function of the Borel set $E \subset V_\eta$. With this measure we have $A^{2,n}(V_{\eta}) \subset L^2(\mu).$
