# Convergence of a $\theta$ -scheme to solve the stochastic nonlinear Schrödinger equation with Stratonovich noise

# Abstract

We propose a  $\theta$ -scheme to discretize the *d*-dimensional stochastic cubic Schrödinger equation in Stratonovich sense. A uniform bound for the Hamiltonian of the discrete problem is obtained, which is a crucial property to verify the convergence in probability towards a mild solution. Furthermore, based on the uniform bounds of iterates in  $\mathbb{H}^2(\mathcal{O})$  for  $\mathcal{O} \subset \mathbb{R}^1$ , the convergence order  $\frac{1}{2}$  in strong local sense is obtained.

#### **Index Terms**

stochastic nonlinear Schrödinger equation, Stratonovich noise, temporal discretization,  $\theta$ -scheme, rates of convergence

# I. INTRODUCTION

Let  $\mathscr{O} \subset \mathbb{R}^d$  be a bounded domain with  $C^2$  boundary. We study different discretizations for the following stochastic cubic Schrödinger equation with multiplicative noise of Stratonovich type ( $\lambda \in \{-1, 1\}$ ),

$$id \psi + (\Delta \psi + \lambda |\psi|^2 \psi) dt = \psi \circ dW(t) \quad \text{in } \mathscr{O}_T := \mathscr{O} \times (0, T),$$
  
$$\psi = 0 \quad \text{on } \partial \mathscr{O} \times (0, T), \qquad (1)$$
  
$$\psi(0) = \psi_0 \quad \text{in } \mathscr{O}.$$

Here, W denotes a real-valued trace-class Q-Wiener process. This problem was e.g. studied in [9] to motivate the possible role of noise to prevent or delay collapse formation; see also [6] for the case  $\lambda = 1$ . It is due to the special type of the multiplicative noise that the mass of solutions of (1) is preserved *P*-a.s.,

$$\|\psi(t)\|_{\mathbb{L}^2} = \|\psi_0\|_{\mathbb{L}^2} \qquad \forall t \in [0,T],$$
(2)

which is similar to the deterministic case. For the deterministic cubic Schrödinger equation, the Hamiltonian  $\mathscr{H}(\psi) = \frac{1}{2} \int_{\mathscr{O}} |\nabla \psi|^2 dx - \frac{\lambda}{4} \int_{\mathscr{O}} |\psi|^4 dx$  is another invariant quantity, which is also essential to construct a solution to this problem. In the stochastic case (1), it is no longer preserved and satisfies (see [2])

$$\mathscr{H}(\boldsymbol{\psi}(t)) = \mathscr{H}(\boldsymbol{\psi}_0) - \mathfrak{I}\int_0^t \int_\mathscr{O} \bar{\boldsymbol{\psi}} \nabla \boldsymbol{\psi} d(\nabla W(s)) ds + \frac{1}{2} \int_0^t \int_\mathscr{O} |\boldsymbol{\psi}|^2 \sum_{\ell} |\nabla \mathbf{Q}|^2 e_{\ell}|^2 ds ds \qquad P-a.s.$$
(3)

Corresponding uniform bounds for its expectation in the case of Galerkin approximations of (1) and  $\mathcal{O} = \mathbb{R}^d$  then allow a compactness argument to construct a global  $\mathbb{H}^1$ -valued mild solution for  $\lambda = -1$  in [2]; and for the case  $\lambda = 1$  with the nonlinear term being replaced by  $|\psi|^{2\sigma}\psi$ , the condition for global existence is  $0 < \sigma < \frac{2}{d}$ .

A relevant work on the numerical analysis of (1) and  $\mathscr{O} = \mathbb{R}^d$  is [3], where iterates  $\{\phi_R^n; n \in \mathbb{N}\}$  of the temporal discretization with underlying mesh of size  $\tau > 0$  covering [0, T] are studied,

$$i(\phi_R^{n+1} - \phi_R^n) + \tau \Delta \phi_R^{n+1/2} + \frac{\lambda \tau}{2} (|\phi_R^{n+1}|^2 + |\phi_R^n|^2) \phi_R^{n+1/2} = \theta_R(\phi_R^n) \theta_R(\phi_R^{n+1}) \phi_R^{n+1/2} \Delta_n W \qquad (n \ge 0), \qquad \phi_R^0 = \psi_0,$$
(4)

where  $\phi_R^{n+\frac{1}{2}} = \frac{1}{2} (\phi_R^n + \phi_R^{n+1})$  and  $\Delta_n W = W(t_{n+1}) - W(t_n)$ . This scheme is constructed in a way that iterates preserve the  $\mathbb{L}^2$ -norm, i.e., *P*-a.s.  $\|\phi_R^n\|_{\mathbb{L}^2} = \|\psi_0\|_{\mathbb{L}^2}$  for  $n \in \mathbb{N}$ . However, such a bound is not sufficient for the use of compactness methods to construct the  $\mathbb{H}^1$ -valued solution of (1), which requires a uniform bound for the Hamiltonian  $\mathscr{H}(\phi_R^n) := \frac{1}{2} \int_{\mathscr{O}} |\nabla \phi_R^n|^2 dx - \frac{\lambda}{4} \int_{\mathscr{O}} |\phi_R^n|^4 dx$  for every finite time T > 0, i.e.,

$$\mathbb{E}\Big[\max_{0 \le n \le [\frac{T}{\tau}]} \mathscr{H}(\phi_R^n)\Big] \le C(T).$$
(5)

Since the scheme (4) with  $\theta_R \equiv 1$  is not known to yield this property, a truncation concept is applied in [3] where e.g.  $\theta_R(\cdot) = \rho\left(\frac{\|\cdot\|_{\mathbb{L}^6}}{R}\right)$ , for some  $\rho \in C_0^{\infty}\left((-1,1);[0,1]\right)$  such that  $\rho|_{\left[-\frac{1}{2},\frac{1}{2}\right]} \equiv 1$ , and some fixed  $R \in \mathbb{R}^+$ ; in this case, the right-hand side in (5) needs to be replaced by a constant  $C_R(T)$ . By tending  $\tau^{-1}, R \to \infty$ , it is shown in [3, Theorem 2.2] that iterates construct the mild solution of (1), where the convergence of the iterates is in probability sense.

This practical construction of the mild solution of (1) is valid for initial data  $\psi_0$  having a finite Hamiltonian, and a given real-valued trace-class **Q**-Wiener process. In [4], the authors study rates of convergence of the following different time semi-discretization

$$i(\phi_{R}^{n+1} - \phi_{R}^{n}) - \tau \Delta \phi_{R}^{n+1/2} - \frac{\lambda \tau}{2} \theta_{R}(\phi_{R}^{n}) \theta_{R}(\phi_{R}^{n+1}) (|\phi_{R}^{n+1}|^{2} + |\phi_{R}^{n}|^{2}) \phi_{R}^{n+1/2} = \phi_{R}^{n} \Delta_{n} W$$
(6)

to approximate the stochastic Schrödinger equation in Itô sense

$$id\psi - (\Delta\psi + \lambda |\psi|^2 \psi)dt = \psi dW(t) \quad \text{on } (0,T) \times \mathbb{R}^d, \qquad \psi(0) = \psi_0, \tag{7}$$

for more regular initial data  $\psi_0 \in \mathbb{H}^{\frac{3}{2}+s}$ ,  $s > \max\{\frac{d}{2}, 1\}$ , and a more regular **Q**-Wiener process *W*. The view-point to achieve this goal is different to the one above: a truncation  $\theta_R(\cdot)$  with R > 0 of the drift term is employed which hinders a (direct) bound for the Hamiltonian but allows to apply semigroup methods for the convergence analysis of this semilinear SPDE with Lipschitz drift: for  $\psi_0 \in \mathbb{H}^{\frac{3}{2}+s}$ ,  $s > \max\{\frac{d}{2}, 1\}$ , the (locally) existing mild solution  $\psi$  is approximated at a rate  $\frac{1}{2}$  in the following sense,

$$\lim_{C\to\infty} P\Big[\max_{n=0,\cdots,K_{\tau^*}} \|\phi^n - \psi(t_n)\|_{\mathbb{H}^s} \ge C\tau^{\frac{1}{2}}\Big] = 0,$$
(8)

see [4, Theorem 5.6].

A further step towards constructing efficient discretizations of (1) is the work [7] which uses a Lie-type time-splitting method. This scheme amounts to solving a family of timely explicitly discretized SODEs for all  $x \in \mathbb{R}^d$ , and a linear PDE with random force. Iterates  $\{\xi^n; n \in \mathbb{N}\}$  preserve mass, but again no uniform bounds for the Hamiltonian are known to hold in the case  $\psi_0 \in \mathbb{H}^1$ , thus leaving unclear convergence behavior towards a solution of (1) under minimum regularity requirements. However, some strong rates are obtained in the presence of regular data. The strategy to validate this result is again based on a proper truncation argument.

The main goal of this work is to propose and study a new discretization (9) of (1) which inherits a uniform estimate for the related Hamiltonian,

$$i(\phi^{n+1} - \phi^n) + \tau(\theta \Delta \phi^{n+1} + (1 - \theta)\Delta \phi^n) + \frac{\lambda \tau}{2} (|\phi^{n+1}|^2 + |\phi^n|^2) \phi^{n+1/2} = \phi^{n+1/2} \Delta_n W \qquad (n \ge 0).$$
(9)

For the case  $\theta \in [\frac{1}{2} + c\sqrt{\tau}), 1]$  with  $c \ge c^* > 0$ , and  $\mathscr{O} \subset \mathbb{R}^d$  a bounded Lipschitz domain,  $\lambda = -1$ , and initial data  $\psi_0 \in L^2(\Omega; \mathbb{H}^1_0(\mathscr{O}))$ , iterates  $\{\phi^n; n \in \mathbb{N}\}$  satisfy

$$E\left[\max_{0\le n\le [\frac{T}{\tau}]}\mathscr{H}(\phi^n)\right]\le C(c^*,T).$$
(10)

In order to derive this result, we multiply (9) with  $\bar{\phi}^{n+1} - \bar{\phi}^n$ , integrate in space and then take the real part of the resulting equality. It is then obvious from the stability analysis which leads to Lemma 7 that

the parameter  $\theta$  has to be chosen from the range  $[\frac{1}{2} + c\sqrt{\tau}, 1]$  ( $c \ge c^* > 0$ ) to generate enough numerical dissipativity to control discretization effects of the noise term. This uniform boundedness of the discrete Hamiltonian allows a brief and concise approach by a compactness argument which constructs a family of solution processes related to (9) converging to the mild solution of (1) for  $\mathcal{O} \subset \mathbb{R}^1$ ; see Remark 4. No additional truncation concept is needed here — which is a relevant tool in [3], [4] (see also (4) and (6)) to compensate for the lack of (10) in the case  $\theta = \frac{1}{2}$ ; we remark that the involved truncation and discretization parameters require a proper balancing for the convergence proof in [3], [4]. Finally, Lemmas 9 and 11 favor the choice  $\theta = \frac{1}{2} + \sqrt{\tau}$  in order to guarantee an approximate conservation of the expectation of the  $\mathbb{L}^2$ -norm of iterates.

In the second part of this work, we study pathwise approximation of the solution (1), which requires initial data  $\psi_0 \in L^8(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2)$ . In particular, we are interested in the concept of local rates of convergence for iterates of (9), see [5], which is stronger than that of rates in probability given above, and requires to deal with the discretization of the nonlinear drift term directly. A relevant prerequisite for this purpose is to provide strong stability results for the non-truncated original problem (1), and also for the discretization (9). However, it is due to the interaction of the cubic nonlinearity with the stochastic term that we are only able to provide the corresponding uniform bounds in higher spatial norms for d = 1. These estimates are then essential for the error analysis, which allows to establish optimal strong convergence rates on large subsets of  $\Omega$  (see Theorem 1). An immediate consequence of this result is the following version of rates of convergence in probability (see Corollary 2),

$$\exists C > 0: \qquad \lim_{\tau \to 0} P\Big[\max_{0 \le n \le M} \|\psi(t_n) - \phi^n\|_{\mathbb{L}^2} \ge C\tau^{\alpha}\Big] = 0, \tag{11}$$

for all  $\alpha < \frac{1}{2}$ . Note that *C* is a constant which does not depend on  $\alpha$  and  $\tau$ .

This paper is organized as follows. In section II, some preliminaries are stated, including the notion of a mild solution of (1) and some properties of the linear Schrödinger semigroup  $\{S(t); t \ge 0\}$ . In section III, uniform bounds in higher 'spatial' norms, together with the Hölder continuity in time for solutions  $\{\psi(t); t \in [0,T]\}$  of equation (1) are obtained. In section IV, the bound (10) for iterates  $\{\phi^n; 0 \le n \le M\}$ of (9) is shown  $(d \ge 1)$ , and uniform bounds in higher spatial norms are proven (d = 1). These results in sections III and IV are used in section V to establish strong rate of convergence  $\frac{1}{2}$  for iterates of (9) in local sense, and in the probability sense (11) for  $\mathcal{O} \subset \mathbb{R}^1$  as a simple consequence. Some computational studies are presented in section VI which complement the theoretical results.

#### **II. PRELIMINARIES**

Throughout this work, let *W* be a **Q**-Wiener process defined on a given filtered probability space  $(\Omega, \mathscr{F}, \{\mathscr{F}_t\}_{0 \le t \le T}, P)$ , with values in the real-valued Hilbert space  $\mathbb{U} = \mathbb{L}^2(\mathscr{O}, \mathbb{R})$ . Here  $\mathbf{Q} \in \mathscr{L}(\mathbb{U})$  is a non-negative, symmetric operator with finite trace.

Equation (1) with  $\lambda = -1$  has an equivalent Itô form (see [2])

$$id\psi + \Delta\psi dt - (|\psi|^2\psi - \frac{i}{2}\psi F_{\mathbf{Q}})dt = \psi dW(t).$$
<sup>(12)</sup>

Here  $F_{\mathbf{Q}}(x) = \sum_{\ell \in \mathbf{N}} (\mathbf{Q}^{\frac{1}{2}} e_{\ell}(x))^2$  for  $x \in \mathcal{O}$ , with  $\{e_{\ell}\}_{\ell \in \mathbb{N}}$  being an orthonomal basis of  $\mathbb{U}$ .

To study (12), we introduce  $\mathscr{L}_2(\mathbb{U}, \mathbb{H})$ , the space of Hilbert-Schmidt operators from Hilbert space  $\mathbb{U}$  to another Hilbert space  $\mathbb{H}$ , where the corresponding norm is defined by  $\|\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U}, \mathbb{H})} = \left(\sum_{\ell \in \mathbb{N}} \|\mathbf{Q}^{\frac{1}{2}}e_\ell\|_{\mathbb{H}}^2\right)^{\frac{1}{2}}$ . In the following analysis, we always assume  $\mathbf{Q}^{\frac{1}{2}} \in \mathscr{L}_2(\mathbb{U}, \mathbb{H}^3(\mathscr{O}))$ .

We recall the mild solution concept for the Itô equation (12) from [2], [4].

**Definition** 1: An  $\mathbb{H}_0^1$ -valued  $\{\mathscr{F}_t\}_{0 \le t \le T}$ -adapted process  $\{\psi(t); t \in [0,T]\}$ , is called a mild solution of problem (12) if for  $\forall t \in [0,T]$  holds P-a.s.

$$\psi(t) = S(t)\psi(0) - i\int_0^t S(t-r)|\psi(r)|^2\psi dr - \frac{1}{2}\int_0^t S(t-r)\psi(r)F_{\mathbf{Q}}dr - i\int_0^t S(t-r)\psi(r)dW(r), \quad (13)$$

where  $S \equiv \{S(t); t \in \mathbb{R}\}$ , with  $S(t) = e^{it\Delta}$  denotes the semigroup of the solution operator of the deterministic linear differential equation

$$i\frac{d\psi}{dt} + \Delta \psi = 0$$
 in  $\mathcal{O}_T$ ,  $\psi = 0$  on  $\partial \mathcal{O} \times (0,T)$ ,  $\psi(0) = \psi_0$  in  $\mathcal{O}$ . (14)

*Remark 1:* Due to the regularity estimate given in Corollary 1, and to [8, Proposition F.0.5, (ii)], we also have the following representation for the mild solution of (12): for every  $t \in [0, T]$ , and all  $z \in \mathbb{H}_0^1$ , there holds *P*-a.s.

$$i\int_{\mathscr{O}} \Psi(t)zdx - \int_{0}^{t}\int_{\mathscr{O}} \nabla \psi \nabla zdxds - \int_{0}^{t}\int_{\mathscr{O}} \left(|\Psi|^{2}\Psi - \frac{i}{2}\Psi F_{\mathbf{Q}}\right)zdxds = i\int_{\mathscr{O}} \Psi_{0}zdx + \int_{0}^{t}\int_{\mathscr{O}} \Psi zdW(s)dx.$$
(15)

We will use this form in the error analysis in section V.

We end this section with some useful properties of  $\{S(t); t \ge 0\}$ , which will be needed in Lemma 5 and Lemma 6 (see [4] for a corresponding study in the case  $\mathscr{O} = \mathbb{R}^d$ ).

In the following, the constant K > 0 differs from line to line; it depends on the initial value  $\psi_0$ , T,  $\mathbf{Q}^{\frac{1}{2}}$ , and  $\mathcal{O}$ , but not on  $\tau$ , n.

*Lemma 1:* The semigroup  $\{S(t); t \ge 0\}$  is an isometry in  $\mathbb{L}^2(\mathcal{O})$ , and it holds that

$$\|S(t) - Id\|_{\mathscr{L}(\mathbb{H}^1_0, \mathbb{L}^2)} \le Kt^{\frac{1}{2}}.$$

where K does not depend on t.

*Proof:* To show the isometry property of S(t), we multiply (14) by  $\psi$ , integrate in  $\mathcal{O}_T$  and take the imaginary part. We get

$$\|\boldsymbol{\psi}(t)\|_{\mathbb{L}^2} = \|\boldsymbol{\psi}_0\|_{\mathbb{L}^2},$$

which implies that  $||S(t)||_{\mathscr{L}(\mathbb{L}^2, \mathbb{L}^2)} = 1$ .

Next, let  $\psi_0 \in \mathbb{H}_0^1(\mathscr{O})$ . By multiplying (14) by  $\Delta \bar{\psi}$ , integrating in  $\mathscr{O}_T$  and taking the imaginary part, we easily deduce  $\|S(t)\|_{\mathscr{L}(\mathbb{H}_0^1, \mathbb{H}_0^1)} = 1$ . The assertion (i) is equivalent to  $\|\psi(t) - \psi_0\|_{\mathbb{L}^2} = \|(S(t) - Id)\psi_0\|_{\mathbb{L}^2} \leq K \|\psi_0\|_{\mathbb{H}^1} t^{\frac{1}{2}}$ . In fact, we may conclude from (14) that

$$i\int_{\mathscr{O}}\psi(t)\xi dx-i\int_{\mathscr{O}}\psi_{0}\xi dx=\int_{0}^{t}\int_{\mathscr{O}}\nabla\psi(\lambda)\nabla\xi dxd\lambda\qquad\forall\xi\in\mathbb{H}_{0}^{1}(\mathscr{O}).$$

We choose  $\xi = \bar{\psi}(t)$ , and take the imaginary part to get

$$\begin{aligned} \frac{1}{2} \Big( \| \boldsymbol{\psi}(t) \|_{\mathbb{L}^2}^2 - \| \boldsymbol{\psi}_0 \|_{\mathbb{L}^2}^2 + \| \boldsymbol{\psi}(t) - \boldsymbol{\psi}_0 \|_{\mathbb{L}^2}^2 \Big) &= \Im \int_0^t \int_{\mathscr{O}} \nabla \boldsymbol{\psi}(\lambda) \nabla \bar{\boldsymbol{\psi}}(t) dx d\lambda \\ &\leq \int_0^t \| \nabla \boldsymbol{\psi}(\lambda) \|_{\mathbb{L}^2} \| \nabla \boldsymbol{\psi}(t) \|_{\mathbb{L}^2} d\lambda \leq K \| \boldsymbol{\psi}_0 \|_{\mathbb{H}^1}^2 t. \end{aligned}$$

The proof of the assertion is finished.

# III. STABILITY RESULTS IN HIGHER NORMS FOR MORE REGULAR INITIAL DATA

In this section, we study stability properties of solutions of (1) with  $\lambda = -1$ . A formal application of Itô's formula shows that the pathwise  $\mathbb{L}^2$ -norm of the solution of (1) is preserved as in the deterministic case. The Hamiltonian  $\mathscr{H}(\Psi)$ , however, is no longer preserved for (1), but one can obtain its boundedness in  $L^p(\Omega)$  for any finite time T > 0; see Lemma 2. For  $\Psi_0 \in L^p(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O}))$  and  $\mathscr{O} \subset \mathbb{R}^1$ , we show that the solution is also  $\mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O})$ -valued and that its  $L^p(\Omega; L^{\infty}(0, T; \mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O})))$ -norm is bounded; see Lemma 4. Those bounds in strong (spatial) norms for the mild solution of (1) may be used to prove Hölder regularity with respect to time in strong norms; see Lemma 5 and 6. They are useful in section V to establish rates of convergence for the  $\theta$ -scheme (9).

In the following lemmas, the application of Itô formula is formal; the argument can, however, be made rigorous by using a truncated version of (12), and passing to the limit after Itô's formula has been applied; we refer to [2] for a corresponding argumentation.

*Lemma 2:* Let  $\mathscr{O} \subset \mathbb{R}^d$  be a bounded Lipschitz domain,  $\mathscr{H}(\psi_0) \in L^p(\Omega)$  for some  $p \ge 1$  with  $\psi_0 = 0$ 

on  $\partial \mathcal{O}$ , and and  $\psi$  be a mild solution of (12). Then there exists a constant  $K \equiv K(p,T) > 0$  such that

(i) 
$$\sup_{0 \le t \le T} E\left[\left(\mathscr{H}(\psi(t))\right)^{p}\right] \le K,$$
  
(ii) 
$$E\left[\sup_{0 \le t \le T}\left(\mathscr{H}(\psi(t))\right)^{p}\right] \le K.$$

*Proof: Step 1: Case p=1.* Applying expectation to (3), we have

$$E\left(\mathscr{H}(\boldsymbol{\psi}(t))\right) = E\left(\mathscr{H}(\boldsymbol{\psi}_0)\right) + \frac{1}{2}E\left(\int_0^t \int_{\mathscr{O}} |\boldsymbol{\psi}|^2 \sum_{\ell} |\nabla \mathbf{Q}^{\frac{1}{2}} \boldsymbol{e}_{\ell}|^2 dx ds\right).$$

Since

$$\int_{\mathscr{O}} |\psi|^2 \sum_{\ell} |\nabla \mathbf{Q}^{\frac{1}{2}} e_{\ell}|^2 dx \le \|\psi\|_{\mathbb{L}^4}^2 \sum_{\ell} \|\nabla \mathbf{Q}^{\frac{1}{2}} e_{\ell}\|_{\mathbb{L}^4}^2 \le \frac{1}{4} \|\psi\|_{\mathbb{L}^4}^4 + \|\nabla \mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U}, \mathbb{L}^4)}^4$$
(16)

we get the following estimate for  $E(\mathscr{H}(\psi(t)))$ ,

$$E\left(\mathscr{H}(\boldsymbol{\psi}(t))\right) \leq E\left(\mathscr{H}(\boldsymbol{\psi}_0)\right) + Kt \|\nabla \mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U}, \mathbb{L}^4)}^4 + E\int_0^t \|\boldsymbol{\psi}\|_{\mathbb{L}^4}^4 ds.$$

From the definition of the Hamiltonian  $\mathscr{H}(\psi)$ , we know that  $\|\psi\|_{\mathbb{L}^4}^4 \leq 4\mathscr{H}(\psi)$ , which leads to

$$\sup_{0\leq t\leq T} E\Big(\mathscr{H}(\psi(t))\Big) \leq K + KE\int_0^T \mathscr{H}(\psi(s))ds.$$

Gronwall's Lemma then implies the assertion (i) of the lemma.

To show assertion (ii) for p = 1, we take the supremum over  $t \in [0,T]$  in (3) before taking the expectation. If compared to assertion (i), the main difference is the appearance of the supremum of a stochastic integral, whose expectation can be estimated by the Burkholder-Davis-Gundy inequality:

$$E\left[\sup_{0\leq t\leq T}\left(-\Im\int_{0}^{t}\int_{\mathscr{O}}\bar{\psi}\nabla\psi d(\nabla W(s))ds\right)\right]$$

$$\leq KE\left[\left(\int_{0}^{T}\|\psi\|_{\mathbb{L}^{4}}^{2}\|\nabla\psi\|_{\mathbb{L}^{2}}^{2}\|\nabla\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_{2}(\mathbb{U},\mathbb{L}^{4})}^{2}ds\right)^{\frac{1}{2}}\right]$$

$$\leq KE\left[\sup_{0\leq t\leq T}\|\nabla\psi(t)\|_{\mathbb{L}^{2}}\left(\int_{0}^{T}\|\psi\|_{\mathbb{L}^{4}}^{2}\|\nabla\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_{2}(\mathbb{U},\mathbb{L}^{4})}^{2}ds\right)^{\frac{1}{2}}\right]$$

$$\leq \frac{1}{8}E\left[\sup_{0\leq t\leq T}\|\nabla\psi(t)\|_{\mathbb{L}^{2}}^{2}\right] + KE\int_{0}^{T}\left(\|\psi\|_{\mathbb{L}^{4}}^{4} + \|\nabla\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_{2}(\mathbb{U},\mathbb{L}^{4})}^{4}\right)ds$$

$$\leq 4E\left[\sup_{0\leq t\leq T}\mathscr{H}(\psi(t))\right] + KE\int_{0}^{T}\left(\mathscr{H}(\psi(s)) + \|\nabla\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_{2}(\mathbb{U},\mathbb{L}^{4})}^{4}\right)ds,$$
(17)

where in the last line we use  $\|\nabla \psi\|_{\mathbb{L}^2}^2 \leq 2\mathscr{H}(\psi)$  and  $\|\psi\|_{\mathbb{L}^4}^4 \leq 4\mathscr{H}(\psi)$ . Then proceeding as in the proof of assertion (i), we can absorb the first term on the left-hand side, and use Gronwall's lemma.

Step 2:  $p \ge 2$ . We apply Itô's formula to  $(\mathscr{H}(\psi))^p$ , where  $\mathscr{H}(\psi(t))$  satisfies (3).

$$\left(\mathscr{H}(\boldsymbol{\psi}(t))\right)^{p} = \left(\mathscr{H}(\boldsymbol{\psi}_{0})\right)^{p} + \frac{1}{2}\int_{0}^{t}p\left(\mathscr{H}(\boldsymbol{\psi})\right)^{p-1}\int_{\mathscr{O}}|\boldsymbol{\psi}|^{2}\sum_{\ell}|\nabla\mathbf{Q}^{\frac{1}{2}}e_{\ell}|^{2}dxds$$
$$+ \frac{1}{2}\int_{0}^{t}p(p-1)\left(\mathscr{H}(\boldsymbol{\psi})\right)^{p-2}\sum_{\ell}\left(\Im\int_{\mathscr{O}}\bar{\boldsymbol{\psi}}\nabla\boldsymbol{\psi}\nabla\mathbf{Q}^{\frac{1}{2}}e_{\ell}dx\right)^{2}ds$$
$$+ \frac{1}{2}\int_{0}^{t}p\left(\mathscr{H}(\boldsymbol{\psi})\right)^{p-1}\int_{\mathscr{O}}\bar{\boldsymbol{\psi}}\nabla\boldsymbol{\psi}d(\nabla W(s))dx.$$
(18)

Since the last term on the right-hand side vanishes after applying expectation, there remains to estimate the term

$$\sum_{\ell} \left( \int_{\mathscr{O}} \bar{\psi} \nabla \psi \nabla \mathbf{Q}^{\frac{1}{2}} e_{\ell} dx \right)^2 \le \|\psi\|_{\mathbb{L}^4}^2 \|\nabla \mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U}, \mathbb{L}^4)}^2 \|\nabla \psi\|_{\mathbb{L}^2}^2 \le K \Big(\mathscr{H}(\psi)\Big)^2 + \|\nabla \mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U}, \mathbb{L}^4)}^8.$$
(19)

Because of (16), (19), and Hölder's inequality, we have

$$\sup_{0 \le t \le T} E\left(\mathscr{H}(\psi(t))\right)^p \le K + KE \int_0^T \left(\mathscr{H}(\psi(s))\right)^p ds$$

We may now apply Gronwall's lemma to obtain the estimate (i).

The assertion (ii) for  $p \ge 2$  now uses arguments similar to (17), so we skip the details here.

**Remark** 2: In [2, Theorem 4.6], a uniform bound for the Hamiltonian is used to construct a global unique solution with continuous  $\mathbb{H}^1(\mathbb{R}^d)$ -valued paths for equation (1) with  $\lambda = -1$  or d = 1. To accomplish this result, the unique local mild solution is constructed by a contraction argument, which is then shown to be global by a bound for the Hamiltonian. We can follow the same strategy in [2] to construct the global unique mild solution with continuous  $\mathbb{H}^1_0(\mathcal{O})$ -valued paths in the case of a bounded Lipschitz domain  $\mathcal{O} \subset \mathbb{R}^1$ . It is an open problem to prove existence and uniqueness of a continuous solution in the case of a bounded domain in higher dimensions.

**Corollary** 1: Let  $p \ge 1$ ,  $\mathcal{O} \subset \mathbb{R}^d$  be a bounded Lipschitz domain,  $E(\mathscr{H}(\psi_0))^p < \infty$  such that  $\psi_0 = 0$  on  $\partial \mathcal{O}$ , and  $\psi$  be a mild solution. There exists a constant  $K \equiv K(p,T) > 0$  such that

(i) 
$$\sup_{0 \le t \le T} \left( E \| \nabla \psi(t) \|_{\mathbb{L}^2}^{2p} + E \| \psi(t) \|_{\mathbb{L}^4}^{4p} \right) \le K,$$
  
(ii) 
$$E \left[ \sup_{0 \le t \le T} \left( \| \nabla \psi(t) \|_{\mathbb{L}^2}^{2p} + \| \psi(t) \|_{\mathbb{L}^4}^{4p} \right) \right] \le K.$$

In order to verify improved stability properties for the solution of (1), we have to restrict to bounded domains  $\mathscr{O} \subset \mathbb{R}^1$ ; the technical reason for this restriction is discussed in Remark 3 below.

*Lemma 3:* Let  $\mathscr{O} \subset \mathbb{R}^1$ , and suppose that  $\psi_0 \in L^{2p}(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O}))$  for some  $p \ge 1$ . Then there exists a constant K = K(p,T) > 0 such that

$$\sup_{0 \le t \le T} E\left(\|\psi(t)\|_{\mathbb{H}^2}^{2p}\right) \le K.$$
(20)

*Proof:* To simplify notations, we present the proof of (20) for the case p = 1. We formally apply Itô's formula to the function  $f(\psi(\cdot))$ , where

$$f(\boldsymbol{\psi}) = \int_{\mathscr{O}} |(Id - \Delta)\boldsymbol{\psi}|^2 dx + \Re \int_{\mathscr{O}} ((Id - \Delta)\bar{\boldsymbol{\psi}}) |\boldsymbol{\psi}|^2 \boldsymbol{\psi} dx,$$

since for the leading term we have  $\|\psi\|_{\mathbb{H}^2}^2 \leq \|(Id - \Delta)\psi\|_{\mathbb{L}^2}^2 \leq 2\|\psi\|_{\mathbb{H}^2}^2$ , i.e., its square-root is equivalent to the norm  $\mathbb{H}^1_0 \cap \mathbb{H}^2$ . We use (12) to get

$$f(\psi(t)) = f(\psi_0) + \int_0^t Df(\psi) \Big( i\Delta\psi - i|\psi|^2 \psi - \frac{1}{2} \psi F_{\mathbf{Q}} \Big) ds + \frac{1}{2} \int_0^t \mathrm{Tr} \Big[ D^2 f(\psi) (-i\psi \mathbf{Q}^{\frac{1}{2}}) (-i\psi \mathbf{Q}^{\frac{1}{2}})^* \Big] ds + \int_0^t Df(\psi) (-i\psi dW(s))$$
  
=:  $f(\psi_0) + I + II + III,$  (21)

with the first and second order derivatives

$$\begin{split} Df(\psi)(u) =& 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \left( (Id - \Delta)u \right) dx + \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \psi(\bar{\psi}u + \psi\bar{u}) dx \\ &+ \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) |\psi|^2 u dx + \Re \int_{\mathscr{O}} \left( (Id - \Delta)(|\psi|^2\psi) \right) \bar{u} dx \quad \forall u \in \mathbb{C}_0^{\infty}(\mathscr{O}), \end{split}$$

and

$$\begin{split} D^{2}f(\psi)(u,v) =& 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{u} \right) \left( (Id - \Delta)v \right) dx + 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \psi \Re(\bar{u}v) dx \\ &+ 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) u \Re(\bar{\psi}v) dx + 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{u} \right) \psi \Re(\bar{\psi}v) dx \\ &+ 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \Re(\bar{\psi}u) v dx + \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{u} \right) |\psi|^{2} v dx \\ &+ \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{v} \right) |\psi|^{2} u dx + 2\Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{v} \right) \Re(\bar{\psi}u) \psi dx \quad \forall u, v \in \mathbb{C}_{0}^{\infty}(\mathscr{O}). \end{split}$$

For the term  $f(\psi_0)$ , we use the continuous embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^6$ ,

$$E(f(\psi_0)) \le 2E \|\psi_0\|_{\mathbb{H}^2}^2 + KE(\|\psi_0\|_{\mathbb{H}^2} \|\psi_0\|_{\mathbb{L}^6}^3) \le KE \|\psi_0\|_{\mathbb{H}^2}^2 + KE \|\psi_0\|_{\mathbb{H}^1}^6 \le KE \|\psi_0\|_{\mathbb{H}^2}^6 \le KE \|\psi_0\|_{\mathbb{H}$$

The term I is the most difficult one: by the expression for  $Df(\psi)$  above, we may represent it in the following form.

$$\begin{split} I =& 2\int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \left( (Id - \Delta)(i\Delta\psi - i|\psi|^2\psi - \frac{1}{2}\psi F_{\mathbf{Q}}) \right) dxds \\ &+ \int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \psi \Big[ \bar{\psi}(i\Delta\psi - i|\psi|^2\psi - \frac{1}{2}\psi F_{\mathbf{Q}}) + \psi(-i\Delta\bar{\psi} + i|\psi|^2\bar{\psi} - \frac{1}{2}\bar{\psi}F_{\mathbf{Q}}) \Big] dxds \\ &+ \int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) |\psi|^2 (i\Delta\psi - i|\psi|^2\psi - \frac{1}{2}\psi F_{\mathbf{Q}}) dxds \\ &+ \int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta)(|\psi|^2\psi) \right) (-i\Delta\bar{\psi} + i|\psi|^2\bar{\psi} - \frac{1}{2}\bar{\psi}F_{\mathbf{Q}}) dxds \\ &=: I^1 + I^2 + I^3 + I^4. \end{split}$$

We treat terms  $I^1$ ,  $I^2$  and  $I^4$  together, for they have troublesome terms which cancel each other. For this purpose, we first consider terms  $I^1$ ,  $I^4$  and  $I^2$  independently. For the first term in I, we compute

$$I^{1} = -2 \int_{0}^{t} \Re \int_{\mathscr{O}} i((Id - \Delta)\bar{\psi}) ((Id - \Delta)(|\psi|^{2}\psi)) dxds$$
$$-\int_{0}^{t} \Re \int_{\mathscr{O}} ((Id - \Delta)\bar{\psi}) ((Id - \Delta)(\psi F_{\mathbf{Q}})) dxds$$
$$=:I_{a}^{1} + I_{b}^{1}.$$

We conclude that

$$E(I_b^1) \le E \int_0^t \|\psi\|_{\mathbb{H}^2}^2 \|F_{\mathbf{Q}}\|_{\mathbb{H}^2} ds \le KE \int_0^t \|\psi\|_{\mathbb{H}^2}^2 ds.$$

By  $\Re \int_{\mathscr{O}} i((Id - \Delta)|\psi|^2 \psi) |\psi|^2 \psi dx = 0$ , we can rewrite the term  $I^4$  in the following two parts,

$$\begin{split} I^{4} &= \int_{0}^{t} \Re \int_{\mathscr{O}} (-i) \left( (Id - \Delta) (|\psi|^{2} \psi) \right) \Delta \bar{\psi} dx ds + \int_{0}^{t} \Re \int_{\mathscr{O}} \left( (Id - \Delta) (|\psi|^{2} \psi) \right) (i|\psi|^{2} \bar{\psi} - \frac{1}{2} \bar{\psi} F_{\mathbf{Q}}) dx ds \\ &= \int_{0}^{t} \Re \int_{\mathscr{O}} (-i) \left( (Id - \Delta) (|\psi|^{2} \psi) \right) \Delta \bar{\psi} dx ds - \frac{1}{2} \int_{0}^{t} \Re \int_{\mathscr{O}} \left( (Id - \Delta) (|\psi|^{2} \psi) \right) (\bar{\psi} F_{\mathbf{Q}}) dx ds \\ &=: I_{a}^{4} + I_{b}^{4}. \end{split}$$

Summing the terms  $\frac{1}{2}I_a^1$  and  $I_a^4$  leads to

$$\begin{split} &-\int_0^t \Re \int_{\mathscr{O}} i\big((Id - \Delta)\bar{\psi}\big)\big((Id - \Delta)(|\psi|^2\psi)\big)dxds - \int_0^t \Re \int_{\mathscr{O}} i\big((Id - \Delta)(|\psi|^2\psi)\big)\Delta\bar{\psi}dxds \\ &= -\int_0^t \Re \int_{\mathscr{O}} i\bar{\psi}\big((Id - \Delta)(|\psi|^2\psi)\big)dxds \\ &=: I_a^{14}. \end{split}$$

This term and the term  $I_b^4$  can be bounded by integration by parts, using the embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^6$ , and Corollary 1, that is

$$\begin{split} E(I_a^{14} + I_b^4) &= -\frac{1}{2} \int_0^t \Re \int_{\mathscr{O}} (|\psi|^2 \psi) \big( (Id - \Delta)(\bar{\psi}F_{\mathbf{Q}}) \big) dx ds - \int_0^t \Re \int_{\mathscr{O}} i \big( (Id - \Delta)\bar{\psi} \big) (|\psi|^2 \psi) dx ds \\ &\leq KE \int_0^t \|\psi F_{\mathbf{Q}}\|_{\mathbb{H}^2} \|\psi\|_{\mathbb{L}^6}^3 ds + KE \int_0^t \|\psi\|_{\mathbb{H}^2}^2 \|\psi\|_{\mathbb{L}^6}^3 ds \\ &\leq KE \int_0^t (\|\psi\|_{\mathbb{H}^1}^6 + \|\psi\|_{\mathbb{H}^2}^2) ds \\ &\leq K + KE \int_0^t \|\psi\|_{\mathbb{H}^2}^2 ds. \end{split}$$

Next, we consider the term  $I^2$  and use the identity  $a\bar{b} + \bar{a}b = 2\Re(a\bar{b})$  for  $a, b \in \mathbb{C}$  to rewrite its part

$$\begin{split} \bar{\psi}(i\Delta\psi - i|\psi|^2\psi - \frac{1}{2}\psi F_{\mathbf{Q}}) + \psi(-i\Delta\bar{\psi} + i|\psi|^2\bar{\psi} - \frac{1}{2}\bar{\psi}F_{\mathbf{Q}}) \\ &= i\bar{\psi}(\Delta\psi) - i\psi(\Delta\bar{\psi}) + 2\Re\left(\bar{\psi}(-i|\psi|^2\psi - \frac{1}{2}\psi F_{\mathbf{Q}})\right) \\ &= i\bar{\psi}(\Delta\psi) - i\psi(\Delta\bar{\psi}) - |\psi|^2F_{\mathbf{Q}} \end{split}$$

Then the term  $I^2$  equals to

$$\begin{split} I^{2} &= -\int_{0}^{t} \Re \int_{\mathscr{O}} \left( (Id - \Delta)\bar{\psi} \right) \psi |\psi|^{2} F_{\mathbf{Q}} dx ds + \int_{0}^{t} \Re \int_{\mathscr{O}} i \left( (Id - \Delta)\bar{\psi} \right) |\psi|^{2} \Delta \psi dx ds \\ &+ \int_{0}^{t} \Re \int_{\mathscr{O}} (-i) |\psi|^{2} \psi \Delta \bar{\psi} dx ds - \int_{0}^{t} \Re \int_{\mathscr{O}} (-i) (\Delta \bar{\psi} \psi)^{2} dx ds \\ &= :I_{b}^{2} + I_{a}^{2}, \end{split}$$

where  $I_a^2 = -\int_0^t \Re \int_{\mathscr{O}} (-i) (\Delta \bar{\psi} \psi)^2 dx ds$ , while  $I_b^2$  denotes the remainder terms in  $I^2$ .

We rewrite the term  $\frac{1}{2}I_a^1$  in the form

$$\frac{1}{2}I_a^1 = -2\int_0^t \Re \int_{\mathscr{O}} i\nabla \bar{\psi} \nabla (|\psi|^2 \psi) dx ds - \int_0^t \Re \int_{\mathscr{O}} i\Delta \bar{\psi} \Delta (|\psi|^2 \psi) dx.$$

We insert the identity  $\Delta(|a|^2a) = 2\Delta a|a|^2 + 4|\nabla a|^2a + 2(\nabla a)^2\bar{a} + (a)^2\Delta\bar{a}$ , for a complex-valued function  $a(x) \in \mathbb{C}$  into the second integral in the above equation, add the terms  $\frac{1}{2}I_a^1$  and  $I_a^2$  to get

$$\frac{1}{2}I_a^1 + I_a^2 = -2\int_0^t \Re \int_{\mathscr{O}} i\nabla \bar{\psi} \nabla (|\psi|^2 \psi) dx ds - 2\int_0^t \Re \int_{\mathscr{O}} i \Big( \bar{\psi} \Delta \bar{\psi} (\nabla \psi)^2 + 2\psi \Delta \bar{\psi} |\nabla \psi|^2 \Big) dx ds.$$

To estimate this term, we use integration by parts, Hölder inequality, the embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^{\infty}$  for  $\mathscr{O} \subset \mathbb{R}^1$ and interpolation of  $\mathbb{L}^4$  between  $\mathbb{L}^2$  and  $\mathbb{H}^1$ ,

$$E\left(\frac{1}{2}I_{a}^{1}+I_{a}^{2}\right) = -2E\int_{0}^{t}\Re\int_{\mathscr{O}}i\nabla\bar{\psi}\nabla(|\psi|^{2}\psi)dxds - 2\int_{0}^{t}\Re\int_{\mathscr{O}}i\left(\bar{\psi}(\nabla\psi)^{2}\Delta\bar{\psi}+2\psi|\nabla\psi|^{2}\Delta\bar{\psi}\right)dxds \quad (22)$$

$$\leq KE\int_{0}^{t}||\psi||_{\mathbb{H}^{1}}^{4}ds + KE\int_{0}^{t}\|\psi\|_{\mathbb{L}^{\infty}}^{2}\|\nabla\psi\|_{\mathbb{L}^{4}}^{4}ds + KE\int_{0}^{t}\|\Delta\psi\|_{\mathbb{L}^{2}}^{2}ds$$

$$\leq KE\int_{0}^{t}||\psi||_{\mathbb{H}^{1}}^{4}ds + KE\int_{0}^{t}\|\nabla\psi\|_{\mathbb{L}^{2}}^{10}ds + KE\int_{0}^{t}\|\Delta\psi\|_{\mathbb{L}^{2}}^{2}ds$$

$$\leq K+KE\int_{0}^{t}\|\Delta\psi\|_{\mathbb{L}^{2}}^{2}ds,$$

where for the last inequality we use Corollary 1 and equation (2). Here, to estimate the second integral in (22), we have to restrict to  $\mathscr{O} \subset \mathbb{R}^1$ .

After using  $\Re(i|\Delta \psi|^2|\psi|^2) = 0$ , the estimate of term  $I_b^2$  is similar as before, and we have

$$E(I_b^2) \le K + \int_0^t \|\psi\|_{\mathbb{H}^2}^2 ds.$$
 (23)

Because of  $\Re(i|\Delta \psi|^2|\psi|^2) = 0$ , the term  $I^3$  can be estimated in a similar way by using Hölder's inequality and some embedding inequalities. It can be bounded by  $K + KE \int_0^t ||\psi||_{\mathbb{H}^2}^2 ds$ .

By the expression for  $D^2 f(\psi)$  and since  $\Re(\bar{\psi}(-i\psi \mathbf{Q}^{\frac{1}{2}})) = 0$ , we have for term *II*,

$$\begin{split} II &= \int_0^t \Re \int_{\mathscr{O}} \mathrm{Tr} \Big[ \Big( (Id - \Delta) \overline{(-i\psi \mathbf{Q}^{\frac{1}{2}})} \Big) \Big( (Id - \Delta) (-i\psi \mathbf{Q}^{\frac{1}{2}}) \Big) \Big] dxds \\ &+ \int_0^t \Re \int_{\mathscr{O}} \mathrm{Tr} \Big[ \Big( (Id - \Delta) \overline{\psi} \Big) \psi \Re \Big( \overline{(-i\psi \mathbf{Q}^{\frac{1}{2}})} (-i\psi \mathbf{Q}^{\frac{1}{2}}) \Big) \Big] dxds \\ &+ \int_0^t \Re \int_{\mathscr{O}} \mathrm{Tr} \Big[ \Big( (Id - \Delta) \overline{(-i\psi \mathbf{Q}^{\frac{1}{2}})} \Big) |\psi|^2 (-i\psi \mathbf{Q}^{\frac{1}{2}}) \Big] dxds \\ &+ \int_0^t \Re \int_{\mathscr{O}} \mathrm{Tr} \Big[ \Big( (Id - \Delta) \overline{(-i\psi \mathbf{Q}^{\frac{1}{2}})} \Big) \psi \Re \big( \overline{\psi} (-i\psi \mathbf{Q}^{\frac{1}{2}}) \big) \Big] dxds. \end{split}$$

The estimate of term II is similar to that of term  $I^3$ , using Hölder's inequality and embedding estimates.

Because of the property of the Itô stochastic integral, we know that the expectation of term *III* equals to 0.

Combining these together, we have

$$\begin{split} \sup_{0 \le t \le T} E \|\psi(t)\|_{\mathbb{H}^2}^2 &\le |E(f(\psi(t)))| + \left| E \Re \int_{\mathscr{O}} \left( (Id - \Delta) \bar{\psi}(t) \right) |\psi(t)|^2 \psi(t) dx \\ &\le \frac{1}{2} \sup_{0 \le t \le T} E \|\psi(t)\|_{\mathbb{H}^2}^2 + K + K \int_0^T E \|\psi(s)\|_{\mathbb{H}^2}^2 ds, \end{split}$$

where in the last step, we use continuous embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^6$  and Corollary 1. Then the conclusion follows from Gronwall's lemma.

Remark 3: There is only one term that requires a '1D-argument', which is the second term in (22),

$$-2\int_0^t \Re \int_{\mathscr{O}} i\Big(\bar{\psi}(\nabla \psi)^2 \Delta \bar{\psi} + 2\psi |\nabla \psi|^2 \Delta \bar{\psi}\Big) dx ds = -8\int_0^t \Re \int_{\mathscr{O}} i\psi |\nabla \psi|^2 \Delta \bar{\psi} dx ds.$$

*Lemma 4:* Let  $\mathscr{O} \subset \mathbb{R}^1$ , and suppose that  $\psi_0 \in L^{2p}(\Omega, \mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O}))$ . Then there exists a constant  $K \equiv K(p,T) > 0$  such that

$$E\left(\sup_{0\le t\le T} \|\psi(t)\|_{\mathbb{H}^2}^{2p}\right) \le K.$$
(24)

*Proof:* If compared to Lemma 3, the main difference of proof is the appearance of the supremum of stochastic integrals *III* in (21), whose expectations do not vanish anymore. By the expression of  $Df(\psi)$ , we know

$$III = 2 \int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta) \bar{\psi} \right) (Id - \Delta) (-i\psi dW(s)) dx + \int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta) \bar{\psi} \right) |\psi|^2 (-i\psi dW(s)) dx + \int_0^t \Re \int_{\mathscr{O}} \left( (Id - \Delta) |\psi|^2 \psi \right) (i\bar{\psi} dW(s)) dx.$$
(25)

We deal with the first term in *III* as an example, since the other two terms can be done similarly with Burkholder-Davis-Gundy inequality as well.

$$\begin{split} & E\Big[\sup_{0\leq t\leq T}\|\int_0^t \Re \int_{\mathscr{O}} \left((Id-\Delta)\bar{\psi}\right)\left((Id-\Delta)(-i\psi dW(s))\right)dx\|_{\mathbb{L}^2}^p\Big] \\ &\leq E\Big[\int_0^T\|\psi\|_{\mathbb{H}^2}^4\|\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U},\mathbb{H}^2)}^2dt\Big]^{\frac{p}{2}} \\ &\leq E\Big[\sup_{0\leq t\leq T}\|\psi(t)\|_{\mathbb{H}^2}^p\left(\int_0^T\|\psi\|_{\mathbb{H}^2}^2\|\mathbf{Q}^{\frac{1}{2}}\|_{\mathscr{L}_2(\mathbb{U},\mathbb{H}^2)}^2dt\right)^{\frac{p}{2}}\Big] \\ &\leq \frac{1}{8}E\Big(\sup_{0\leq t\leq T}\|\psi(t)\|_{\mathbb{H}^2}^{2p}\Big) + KE\int_0^T\|\psi(t)\|_{\mathbb{H}^2}^{2p}dt. \end{split}$$

Similar as the proof of Lemma 3, Gronwall's lemma leads to the assertion.

*Lemma 5:* Let  $p \ge 1$ ,  $\mathscr{O} \subset \mathbb{R}^1$  and  $\psi_0 \in L^{2p}(\Omega, \mathbb{H}^1_0(\mathscr{O}))$ . There exists a constant  $K \equiv K(p)$  such that

$$E\left(\|\psi(t_1) - \psi(t_2)\|_{\mathbb{L}^2}^{2p}\right) \le K|t_1 - t_2|^p \qquad (0 \le t_2 \le t_1 \le T).$$

*Proof:* From equation (13), we have the following expression for  $\psi(t_1) - \psi(t_2)$ ,

$$\begin{aligned} \psi(t_{1}) - \psi(t_{2}) &= (S(t_{1}) - S(t_{2}))\psi_{0} \\ &+ i \Big[ \int_{0}^{t_{1}} S(t_{1} - r) \big( -|\psi|^{2}\psi + \frac{i}{2}\psi F_{\mathbf{Q}} \big) dr - \int_{0}^{t_{2}} S(t_{2} - r) \big( -|\psi|^{2}\psi + \frac{i}{2}\psi F_{\mathbf{Q}} \big) dr \Big] \\ &- i \Big[ \int_{0}^{t_{1}} S(t_{1} - r)\psi dW(r) - \int_{0}^{t_{2}} S(t_{2} - r)\psi dW(r) \Big] \\ &=: I + II + III. \end{aligned}$$
(26)

Because of Lemma 1 (i),

$$\begin{split} \|S(t_1) - S(t_2)\|_{\mathscr{L}(\mathbb{H}^1_0, \mathbb{L}^2)} &= \|S(t_2)(S(t_1 - t_2) - Id)\|_{\mathscr{L}(\mathbb{H}^1_0, \mathbb{L}^2)} \\ &\leq \|S(t_2)\|_{\mathscr{L}(\mathbb{H}^1_0, \mathbb{H}^1_0)} \|S(t_1 - t_2) - Id\|_{\mathscr{L}(\mathbb{H}^1_0, \mathbb{L}^2)} \\ &\leq K|t_1 - t_2|^{\frac{1}{2}}, \end{split}$$

such that

$$E\|I\|_{\mathbb{L}^2}^{2p} \leq KE\|\psi_0\|_{\mathbb{H}^1_0}^{2p}|t_1-t_2|^p \leq K|t_1-t_2|^p.$$

We divide II into two parts,

$$II = i \int_{0}^{t_{2}} (S(t_{1} - r) - S(t_{2} - r))(-|\psi|^{2}\psi + \frac{i}{2}\psi F_{\mathbf{Q}})dr + i \int_{t_{2}}^{t_{1}} S(t_{1} - r)(-|\psi|^{2}\psi + \frac{i}{2}\psi F_{\mathbf{Q}})dr$$
  
=:  $II^{A} + II^{B}$ . (27)

We use  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^{\infty}$  to estimate  $II^A$  as follows,

$$\begin{split} \|II^{A}\|_{\mathbb{L}^{2}} &\leq K|t_{1}-t_{2}|^{\frac{1}{2}} \int_{0}^{t_{2}} \|-|\psi|^{2}\psi + \frac{i}{2}\psi F_{\mathbf{Q}}\|_{\mathbb{H}_{1}} dr \\ &\leq K|t_{1}-t_{2}|^{\frac{1}{2}} \int_{0}^{t_{2}} (\|\psi\|_{\mathbb{H}^{1}}^{3} + \|\psi\|_{\mathbb{H}^{1}}) dr, \end{split}$$

hence  $E || II^A ||_{\mathbb{L}^2}^{2p} \leq K |t_1 - t_2|^p$  follows from (2) and Corollary 1. By the embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^2$ , the estimation of  $II^B$  is

$$\|II^{B}\|_{\mathbb{L}^{2}} \leq K \int_{t_{1}}^{t_{2}} \|-|\psi|^{2}\psi + \frac{i}{2}\psi F_{\mathbf{Q}}\|_{\mathbb{L}^{2}} dr \leq K \int_{t_{1}}^{t_{2}} (\|\psi\|_{\mathbb{H}^{1}}^{3} + \|\psi\|_{\mathbb{H}^{1}}) dr,$$

thus  $E ||II^B||_{\mathbb{L}^2}^{2p} \le K|t_1 - t_2|^{2p}$ . We split term *III* as (27). Based on the Burkholder-Davis-Gundy inequality, Lemma 1 (i) and Lemma 3, the first stochastic term may be estimated as follows,

$$E\left(\|\int_{0}^{t_{2}} (S(t_{1}-r)-S(t_{2}-r))\psi dW(r)\|_{\mathbb{L}^{2}}^{2p}\right) \leq KE\left(\int_{0}^{t_{2}} \|(S(t_{1}-r)-S(t_{2}-r))\psi\|_{\mathbb{L}^{2}}^{2}dr\right)^{p}$$
$$\leq KE\left(\int_{0}^{t_{2}} (t_{1}-t_{2})\|\psi\|_{\mathbb{H}^{1}}^{2}dr\right)^{p}$$
$$\leq K|t_{1}-t_{2}|^{p},$$

and the estimate of the second stochastic term is

$$E\left(\|\int_{t_2}^{t_1} S(t_1-r)\psi dW(r)\|_{\mathbb{L}^2}^2\right) \leq E\left(\int_{t_1}^{t_2} \|\psi\|_{\mathbb{L}^2}^2 dr\right)^p \leq K|t_1-t_2|^p.$$

Thus we have

$$E \|III\|_{\mathbb{L}^2}^{2p} \leq K |t_1 - t_2|^p.$$

Inserting all these estimates into (26) establishes the result.

From Lemma 1 (i), i.e.,  $||S(t_1) - S(t_2)||_{\mathscr{L}(\mathbb{H}^1_0, \mathbb{L}^2)} \leq K|t_1 - t_2|^{\frac{1}{2}}$ , we may conclude that if we want to show the Hölder continuity property of the solution of (1) in the  $\mathbb{H}^1_0(\mathscr{O})$ -norm, we need the boundedness of the  $\mathbb{H}^2(\mathscr{O})$ -norm of the solution, which is stated in Lemma 3. Therefore we present the following lemma without proof.

*Lemma 6:* Let  $p \ge 1$ ,  $\mathscr{O} \subset \mathbb{R}^1$  and  $\psi_0 \in L^{2p}(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O}))$ . There exists  $K \equiv K(p) > 0$  such that

$$E\left(\|\psi(t_1)-\psi(t_2)\|_{\mathbb{H}^1}^{2p}\right) \le K|t_1-t_2|^p \qquad (0 \le t_2 \le t_1 \le T).$$

# IV. Stability of the $\theta$ -scheme

In this section, we consider the following  $\theta$ -scheme on the uniform partition  $I_n := \{t_n\}_{n=0}^M$  covering [0,T] with mesh-size  $\tau = T/M > 0$ , where  $t_0 = 0$  and  $t_M = T$ .

Algorithm 1: Let  $\phi^0 = \psi(t_0)$  be a given  $\mathbb{H}^1_0(\mathscr{O})$ -valued random variable and let  $\theta \in [0,1]$ . Find for every  $n \in \{0, \dots, M\}$  a  $\mathscr{F}_{t_{n+1}}$ -adapted random variable  $\phi^{n+1}$  with values in  $\mathbb{H}^1_0(\mathscr{O})$  such that *P*-a.s.

$$i\int_{\mathscr{O}} \left(\phi^{n+1} - \phi^n\right) z dx - \tau \int_{\mathscr{O}} \left(\theta \nabla \phi^{n+1} + (1-\theta) \nabla \phi^n\right) \nabla z dx - \frac{\tau}{2} \int_{\mathscr{O}} \left(|\phi^{n+1}|^2 + |\phi^n|^2\right) \phi^{n+\frac{1}{2}} z dx = \int_{\mathscr{O}} \phi^{n+\frac{1}{2}} \Delta_n W z dx \qquad \forall z \in \mathbb{H}^1_0(\mathscr{O}),$$
(28)

where  $\Delta_n W = W(t_{n+1}) - W(t_n)$ .

A relevant property of the limiting system (1) is a bound for the Hamiltonian of its solution; see (10). This property is not known for the Crank-Nicolson scheme ( $\theta = \frac{1}{2}$ ), which is why a truncation strategy is applied to the nonlinearity (see [7]) or the noise term ([3]), leading to a truncated Crank-Nicolson scheme. The next lemma establishes this property for the  $\theta$ -scheme and values  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$  with  $c \ge c^* > 0$ , avoiding any truncation. For simplicity, we assume  $\phi^0 \in \mathbb{H}_0^1(\mathcal{O})$ .

*Lemma* 7: Let  $p \ge 1$  and  $\mathscr{O} \subset \mathbb{R}^d$  be a bounded Lipschitz domain. Fix  $T \equiv t_M > 0$ , and let  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$  with  $c \ge c^* > 0$ . Suppose  $\tau \le \tau^*$ , where  $\tau^* \equiv \tau^*(\|\phi^0\|_{\mathbb{H}^1_0}, T)$ . There exist a  $\mathbb{H}^1_0(\mathscr{O})$ -valued  $\{\mathscr{F}_{t_n}\}_{0 \le n \le M}$ -adapted solution  $\{\phi^n; n = 0, 1, \dots, M\}$  of the  $\theta$ -scheme (28), and a constant  $K \equiv K(p, T, c^*) > 0$  such that

(i) 
$$\max_{1 \le n \le M} \left[ E \left( \| \phi^n \|_{\mathbb{L}^2}^{2^p} + (\mathscr{H}(\phi^n))^{2^{(p-1)}} \right) \right] \le K,$$
  
(ii) 
$$\max_{1 \le n \le M} E \| \phi^{n+1} - \phi^n \|_{\mathbb{L}^2}^{2p} \le K \tau^p,$$
  
(iii) 
$$\max_{1 \le n \le M} \left[ (2\theta - 1) \sum_{k=0}^n E \| \nabla (\phi^{k+1} - \phi^k) \|_{\mathbb{L}^2}^2 \right] \le K.$$

Proof: Step 1: Existence and  $\mathscr{F}_{t_n}$ -adaptedness. Fix a set  $\Omega' \subset \Omega$ ,  $P(\Omega') = 1$  such that  $W(t,x) \in \mathbb{U}$ for all  $t \in [0,T]$  and  $\omega \in \Omega'$ . In the following, let us assume that  $\omega \in \Omega'$ . The existence of iterates  $\{\phi^n; n = 0, 1, \dots, M\}$  follows from a standard Galerkin method and Brouwer's theorem, in combination with assertion (i).

Define a map

$$\Lambda: \mathbb{H}^1_0 \times \mathbb{U} \ni \left(\phi^n, \Delta_n W\right) \to \Lambda(\phi^n, \Delta_n W) \in \mathscr{P}(\mathbb{H}^1_0),$$

where  $\mathscr{P}(\mathbb{H}_0^1)$  denotes the set of all subsets of  $\mathbb{H}_0^1(\mathscr{O})$ , and  $\Lambda(\phi^n, \Delta_n W)$  is the set of solutions  $\phi^{n+1}$  of (28). By the closedness of the graph of  $\Lambda$  and a selector theorem ([1], Theorem 3.1), there exists a universally and Borel measurable map  $\lambda_n : \mathbb{H}_0^1 \times \mathbb{U} \to \mathbb{H}_0^1$  such that  $\lambda_n(s_1, s_2) \in \Lambda(s_1 s_2)$  for all  $(s_1, s_2) \in \mathbb{H}_0^1 \times \mathbb{U}$ . Therefore,  $\mathscr{F}_{t_{n+1}}$ -measurability of  $\phi^{n+1}$  follows from the Doob-Dynkin lemma. Step 2: Case p = 1 for (i), (ii) and (iii). Consider equation (28) for one  $\omega \in \Omega$  and choose  $z = \overline{\phi}^{n+\frac{1}{2}}(\omega)$ . Then take the imaginary part to get

$$\frac{1}{2} \|\phi^{n+1}\|_{\mathbb{L}^{2}}^{2} - \frac{1}{2} \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} = \tau \Im \int_{\mathscr{O}} \left(\theta \nabla \phi^{n+1} + (1-\theta) \nabla \phi^{n}\right) \nabla \bar{\phi}^{n+\frac{1}{2}} dx$$

$$= \frac{(1-2\theta)\tau}{2} \Im \int_{\mathscr{O}} \nabla \phi^{n} \nabla \bar{\phi}^{n+1} dx$$

$$\leq \frac{2\theta - 1}{4} \tau \left( \|\nabla \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \|\nabla \phi^{n}\|_{\mathbb{L}^{2}}^{2} \right),$$
(29)

where  $\Re[(a-b)(\bar{a}+\bar{b})] = |a|^2 - |b|^2$  is used on the left-hand side. Next, we choose  $z = -(\bar{\phi}^{n+1} - \bar{\phi}^n)(\omega)$  in (28), and take the real part. We obtain

$$\left(\frac{1}{2} \|\nabla \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{4} \|\phi^{n+1}\|_{\mathbb{L}^{4}}^{4}\right) - \left(\frac{1}{2} \|\nabla \phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{4} \|\phi^{n}\|_{\mathbb{L}^{4}}^{4}\right) + \frac{(2\theta - 1)}{2} \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2}$$

$$= -\frac{1}{\tau} \int_{\mathscr{O}} (|\phi^{n+1}|^{2} - |\phi^{n}|^{2}) \Delta_{n} W dx.$$

$$(30)$$

We will see that the last term on the left-hand side helps to bound the stochastic integral term, which is restated as follows by using the equation (28), properties of the real and imaginary parts of a complex number, and the fact that W is real-valued,

$$\begin{split} &\int_{\mathscr{O}} (|\phi^{n+1}|^2 - |\phi^n|^2) \Delta_n W dx \\ &= 2\Re \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} (\phi^{n+1} - \phi^n) \Delta_n W dx \\ &= 2\Re \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \left( i\tau \left( \theta \Delta \phi^{n+1} + (1-\theta) \Delta \phi^n \right) - i\frac{\tau}{2} (|\phi^{n+1}|^2 + |\phi^n|^2) \phi^{n+\frac{1}{2}} - i\phi^{n+\frac{1}{2}} \Delta_n W \right) \Delta_n W dx \\ &= (1-2\theta)\tau \Im \int_{\mathscr{O}} \nabla \bar{\phi}^n \nabla \phi^{n+1} \Delta_n W dx - 2\tau \theta \Im \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \nabla \phi^{n+1} \nabla (\Delta_n W) dx - 2\tau (1-\theta) \Im \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \nabla \phi^n \nabla (\Delta_n W) dx \end{split}$$

We used integration by parts in the last step. By plugging it into equation (30), we find

$$\mathcal{H}(\phi^{n+1}) - \mathcal{H}(\phi^n) + \frac{2\theta - 1}{2} \|\nabla(\phi^{n+1} - \phi^n)\|_{\mathbb{L}^2}^2$$
  
=  $(2\theta - 1)\Im \int_{\mathscr{O}} \nabla \bar{\phi}^n \nabla \phi^{n+1} \Delta_n W dx + 2\theta\Im \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \nabla \phi^{n+1} \nabla (\Delta_n W) dx + 2(1 - \theta)\Im \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \nabla \phi^n \nabla (\Delta_n W) dx$   
=:  $I_1 + I_2 + I_3.$  (31)

Next we estimate the three terms separately. Because of  $\Im(|\nabla \phi^n|^2) = 0$ , we have

$$I_{1} = (2\theta - 1)\Im \int_{\mathscr{O}} \nabla \bar{\phi}^{n} (\nabla \phi^{n+1} - \nabla \phi^{n}) \Delta_{n} W dx$$
  
$$\leq \frac{2\theta - 1}{8} \|\nabla \phi^{n+1} - \nabla \phi^{n}\|_{\mathbb{L}^{2}}^{2} + 2(2\theta - 1) \|\nabla \phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta_{n} W\|_{\mathbb{L}^{\infty}}^{2}$$

Rearranging terms and the identity  $\phi^{n+\frac{1}{2}} = \phi^n + \frac{\phi^{n+1} - \phi^n}{2}$  lead to

$$I_{2}+I_{3} = 2\theta \Im \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \left( \nabla \phi^{n+1} - \nabla \phi^{n} \right) \nabla (\Delta_{n}W) dx + 2\Im \int_{\mathscr{O}} \bar{\phi}^{n+\frac{1}{2}} \nabla \phi^{n} \nabla (\Delta_{n}W) dx = 2\theta \Im \int_{\mathscr{O}} \bar{\phi}^{n} \left( \nabla \phi^{n+1} - \nabla \phi^{n} \right) \nabla (\Delta_{n}W) dx + \theta \Im \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) \left( \nabla \phi^{n+1} - \nabla \phi^{n} \right) \nabla (\Delta_{n}W) dx + 2\Im \int_{\mathscr{O}} \bar{\phi}^{n} \nabla \phi^{n} \nabla (\Delta_{n}W) dx + \Im \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) \nabla \phi^{n} \nabla (\Delta_{n}W) dx$$
(32)

Integration by parts for the first term, and using  $\Im(a) = -\Im(\bar{a}) \ (a \in \mathbb{C})$  lead to

$$I_{2}+I_{3} = (1+2\theta)\Im \int_{\mathscr{O}} \nabla \phi^{n} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) \nabla (\Delta_{n}W) dx + 2\Im \int_{\mathscr{O}} \nabla \phi^{n} \bar{\phi}^{n} \nabla (\Delta_{n}W) dx - 2\theta\Im \int_{\mathscr{O}} \bar{\phi}^{n} (\phi^{n+1} - \phi^{n}) \Delta (\Delta_{n}W) dx + \theta\Im \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) (\nabla \phi^{n+1} - \nabla \phi^{n}) \nabla (\Delta_{n}W) dx = : I_{23}^{a} + I_{23}^{b} + I_{23}^{c} + I_{23}^{d}.$$

$$(33)$$

The estimation of the first three terms is as follows,

$$I_{23}^{a} + I_{23}^{b} + I_{23}^{c} \leq \frac{1}{4} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} + K \|\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{2} + K \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{2} + 2\Im \int_{\mathscr{O}} \nabla\phi^{n} \bar{\phi}^{n} \nabla(\Delta_{n}W) dx.$$
(34)

The troublesome term is  $I_{23}^d$ , we estimate it as follows,

$$I_{23}^{d} \leq \|\nabla\phi^{n+1} - \nabla\phi^{n}\|_{\mathbb{L}^{2}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}} \|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}$$

$$\leq \frac{2\theta - 1}{8} \|\nabla\phi^{n+1} - \nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{2}{2\theta - 1} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{2}$$

$$\leq \frac{2\theta - 1}{8} \|\nabla\phi^{n+1} - \nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{8} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{2}{(2\theta - 1)^{2}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{4}$$

$$\leq \frac{2\theta - 1}{8} \|\nabla\phi^{n+1} - \nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{8} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} + K\tau \Big( \|\phi^{n+1}\|_{\mathbb{L}^{4}}^{4} + \|\phi^{n}\|_{\mathbb{L}^{4}}^{4} \Big) + \frac{1}{\tau (2\theta - 1)^{4}} \|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{8},$$

$$(35)$$

where we use the embedding  $\mathbb{L}^4(\mathscr{O}) \hookrightarrow \mathbb{L}^2(\mathscr{O})$  in the last step. In order to complete the proof for (i) and (ii), we need to bound  $\|\phi^{n+1} - \phi^n\|_{\mathbb{L}^2}^2$ , which appears in the last two estimates (34) and (35). For this purpose, we test the equation (28) with  $(\bar{\phi}^{n+1} - \bar{\phi}^n)(\omega)$ , then take the imaginary part. Because of  $\phi^{n+\frac{1}{2}} = \phi^n + \frac{\phi^{n+1} - \phi^n}{2}$ , we get

$$\begin{split} \|\phi^{n+1} - \phi^n\|_{\mathbb{L}^2}^2 = \tau \Im \int_{\mathscr{O}} \left(\theta \nabla \phi^{n+1} + (1-\theta) \nabla \phi^n\right) \nabla (\bar{\phi}^{n+1} - \bar{\phi}^n) dx + \frac{\tau}{2} \Im \int_{\mathscr{O}} (|\phi^{n+1}|^2 + |\phi^n|^2) \phi^n \bar{\phi}^{n+1} dx \\ + \Im \int_{\mathscr{O}} \phi^n (\bar{\phi}^{n+1} - \bar{\phi}^n) \Delta W_n dx. \end{split}$$

Estimating this equality leads to

$$\frac{1}{2} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} \leq K\tau \left(\frac{1}{2} \|\nabla\phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{2} \|\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{4} \|\phi^{n+1}\|_{\mathbb{L}^{4}}^{4} + \frac{1}{4} \|\phi^{n}\|_{\mathbb{L}^{4}}^{4} \right) + K \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta_{n}W\|_{\mathbb{L}^{\infty}}^{2} 
= K\tau \left(\mathscr{H}(\phi^{n+1}) + \mathscr{H}(\phi^{n})\right) + K \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta_{n}W\|_{\mathbb{L}^{\infty}}^{2},$$
(36)

where Young's inequality is applied, and the term  $\frac{1}{2} \|\phi^{n+1} - \phi^n\|_{\mathbb{L}^2}^2$  which appears from the stochastic term is absorbed in the left-hand side.

We may now combine estimate (36) with (29) and (31). By denoting  $\mathscr{K}^n = \frac{1}{2} \|\phi^n\|_{\mathbb{L}^2}^2 + \mathscr{H}(\phi^n)$ , we obtain

$$\mathcal{K}^{n+1} - \mathcal{K}^{n} + \frac{1}{8} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{2\theta - 1}{4} \|\nabla\phi^{n+1} - \nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2}$$

$$\leq K\tau \Big( \mathcal{K}^{n+1} + \mathcal{K}^{n} \Big) + K \|\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta_{n}W\|_{\mathbb{L}^{\infty}}^{2} + K \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{2} + K \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} \|\Delta_{n}W\|_{\mathbb{L}^{\infty}}^{2}$$

$$+ 2\Im \int_{\mathscr{O}} \nabla\phi^{n} \bar{\phi}^{n} \nabla(\Delta_{n}W) dx + \frac{1}{\tau(2\theta - 1)^{4}} \|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{8}$$

$$=: K\tau \Big( \mathcal{K}^{n+1} + \mathcal{K}^{n} \Big) + A. \tag{37}$$

In order to efficiently bound the expectation of the last term, we recall that  $E \|\nabla(\Delta_n W)\|_{\mathbb{L}^{\infty}}^8 = O(\tau^4)$  to admit  $2\theta - 1 \ge c\sqrt{\tau}$  with  $c \ge c^* > 0$ .

After applying expectations on both sides of (37), one arrives at

$$E\mathscr{K}^{n+1} - E\mathscr{K}^n + \frac{1}{8}E\|\phi^{n+1} - \phi^n\|_{\mathbb{L}^2}^2 + \frac{2\theta - 1}{4}E\|\nabla\phi^{n+1} - \nabla\phi^n\|_{\mathbb{L}^2}^2 \le K\tau + K\tau\Big(E\mathscr{K}^{n+1} + E\mathscr{K}^n\Big).$$

The discrete Gronwall's lemma then leads to the assertions of this lemma in case  $\tau \leq \tau^*$  is chosen.

Step 3: Case  $p \ge 2$  for (i). In order to show the assertion (i), we employ an inductive argument. To obtain the result for p = 2, we multiply equality (37) by  $\mathscr{K}^{n+1}$  and use the identity  $(a-b)a = \frac{1}{2}(a^2 - b^2 + (a-b)^2)$ , where  $a, b \in \mathbb{R}$ , to get

$$\frac{1}{2} \Big[ (\mathscr{K}^{n+1})^2 - (\mathscr{K}^n)^2 \Big] + \frac{1}{2} (\mathscr{K}^{n+1} - \mathscr{K}^n)^2 \le K\tau \Big( (\mathscr{K}^{n+1})^2 + (\mathscr{K}^n)^2 \Big) + A\mathscr{K}^{n+1},$$
(38)

where A is from (37). Applying expectation on both sides of (38), we have

$$\frac{1}{2}E\left[\left(\mathscr{K}^{n+1}\right)^{2}-\left(\mathscr{K}^{n}\right)^{2}\right]+\frac{1}{2}E\left(\mathscr{K}^{n+1}-\mathscr{K}^{n}\right)^{2} \\
\leq K\tau\left(E\left(\mathscr{K}^{n+1}\right)^{2}+E\left(\mathscr{K}^{n}\right)^{2}\right)+\frac{1}{4}E\left(\mathscr{K}^{n+1}-\mathscr{K}^{n}\right)^{2}+K\tau.$$
(39)

In order to verify this inequality, we may restrict ourselves to the integral term in (37), since other terms can be easily estimated by Young's inequality. By the independency property of increments of the Wiener

process, we obtain

$$\begin{split} E\Big[\mathscr{K}^{n+1}\Im\int_{\mathscr{O}}\nabla\phi^{n}\bar{\phi}^{n}\nabla(\Delta_{n}W)dx\Big] &= E\Big[\Big(\mathscr{K}^{n+1}-\mathscr{K}^{n}\Big)\Im\int_{\mathscr{O}}\nabla\phi^{n}\bar{\phi}^{n}\nabla(\Delta_{n}W)dx\Big] \\ &\leq \frac{1}{4}E(\mathscr{K}^{n+1}-\mathscr{K}^{n})^{2}+K\tau E(\mathscr{K}^{n})^{2}, \end{split}$$

and the leading term may be absorbed by the left-hand side of (39). Therefore we have the conclusion of (i) in the case p = 2 via the discrete Gronwall's lemma. By repeating this procedure, one obtains the result for each  $p \in \mathbb{N}$ .

Step 4: Case  $p \ge 2$  for (ii). We prove it for the case p = 2, since for general p, the result follows from assertion (i). We deal with inequality (36) by squaring it,

$$\|\phi^{n+1} - \phi^n\|_{\mathbb{L}^2}^4 \le K\tau^2 \left( (\mathscr{K}^{n+1})^2 + (\mathscr{K}^n)^2 \right) + K \|\phi^n\|_{\mathbb{L}^2}^4 \|\Delta_n W\|_{\mathbb{L}^\infty}^4.$$

Applying expectations leads to assertion (ii) in the case of p = 2. By repeating this procedure, one obtains the result for each  $p \in \mathbb{N}$ .

**Remark** 4: A compactness argument is used in [3] to prove convergence of a family of (adapted, continuous) interpolating processes of the numerical solution towards a mild solution of (12) for the case  $\mathcal{O} = \mathbb{R}^d$ ; a crucial prerequisite for it are the lemmas [3, Lemmas 3.3 and 3.4], which here are sharpened to Lemma 7.

As is stated in Remark 2, a mild solution of (12) may be constructed for the bounded domain case  $\mathscr{O} \subset \mathbb{R}^1$  by a contraction argument following [2]; alternatively, we may follow the strategy of [3] and use the uniform bounds in Lemma 7 for a compactness argument which establishes convergence of (interpolated in time) iterates  $\{\phi^n; n = 0, 1, \dots, M\}$  solving Algorithm 1 towards the unique mild solution of (12) for the case  $\mathscr{O} \subset \mathbb{R}^1$ . No additional truncation parameter (and related stopping times) is involved in this construction based on Algorithm 1, which would otherwise require a proper balancing with the discretization parameter in this (practical) construction process of a solution for (12) as in [3].

*Lemma* 8: Let  $p \ge 1$ . Under the assumptions made in Lemma 7, we have

$$E\Big[\max_{1\leq n\leq M}\Big(\|\phi^n\|_{\mathbb{L}^2}^2+\mathscr{H}(\phi^n)\Big)^{2^{p-1}}\Big]\leq K(p,T).$$

*Proof:* We only present the proof for p = 1. We start from (37) for some  $0 \le \ell \le M$ , sum over the index from  $\ell = 0$  to *n*, take the maximum between 0 and  $m \le M$ , and apply expectations. We may now employ the result of Lemma 7 to conclude that

$$E\left(\max_{0\leq n\leq m}\mathscr{K}^{n}\right)\leq K+K\tau\sum_{\ell=0}^{m}E\left(\max_{0\leq j\leq \ell}\mathscr{K}^{j}\right)+E\left[\max_{0\leq n\leq m}\sum_{\ell=0}^{n}\int_{\mathscr{O}}\nabla\phi^{\ell}\bar{\phi}^{\ell}\nabla(\Delta_{\ell}W)dx\right].$$
(40)

The bound of the last term is similar to (17), using Burkholder-Davis-Gundy inequality.

The following lemma asserts approximate conservation of mass (in statistical average) for  $\theta \downarrow \frac{1}{2}$ .

*Lemma 9:* Let  $\mathscr{O} \subset \mathbb{R}^d$  be a bounded Lipschitz domain,  $T \equiv t_M > 0$  be fixed, and  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$ with  $c \geq c^* > 0$ . There exist a constant  $K \equiv K(T, c^*) > 0$  and  $\tau^* \equiv \tau^*(\|\phi^0\|_{\mathbb{H}^1_0}, T)$  such that for all  $\tau \leq \tau^*$ , we have

$$\max_{1 \le n \le \lfloor T/\tau \rfloor} E \|\phi^n\|_{\mathbb{L}^2}^2 - E \|\phi^0\|_{\mathbb{L}^2}^2 \le K \Big(\tau^{\frac{3}{4}} + (1 - 2\theta)\tau^{\frac{1}{4}}\Big).$$
(41)

Proof: Recall (29) and use properties of the imaginary part of a complex number to conclude

$$\begin{aligned} \|\phi^{n+1}\|_{\mathbb{L}^{2}}^{2} - \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} &= (1-2\theta)\tau \Im \int_{\mathscr{O}} (\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}) \nabla \phi^{n} dx \\ &\leq (2\theta-1) \Big(\tau^{\frac{3}{8}} \|\nabla \phi^{n+1} - \nabla \phi^{n}\|_{\mathbb{L}^{2}} \Big) \Big(\tau^{\frac{5}{8}} \|\nabla \phi^{n}\|_{\mathbb{L}^{2}} \Big) \\ &\leq \frac{(2\theta-1)\tau^{\frac{3}{4}}}{2} \|\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{(2\theta-1)\tau^{\frac{5}{4}}}{2} \|\nabla \bar{\phi}^{n}\|_{\mathbb{L}^{2}}^{2}. \end{aligned}$$
(42)

Now consider the above inequality for some  $0 \le \ell \le M$ , sum over the index from  $\ell = 0$  to *n*, take the expectation, and use Lemma 7 (i) and (iii) to establish the assertion.

A comparison of Lemma 7 and Lemma 9 illustrates the role of numerical dissipation in the  $\theta$ -scheme and suggests a choice  $\theta = \frac{1}{2} + c\sqrt{\tau}$  to minimize this effect and approximately preserve the  $\mathbb{L}^2$ -norm of iterates.

The following lemma validates improved stability properties for solutions of Algorithm 1 for  $\mathscr{O} \subset \mathbb{R}^1$ , which will be relevant in the error analysis below. In fact, a consequence of it will be an improved preservation of mass; see Lemma 11.

*Lemma 10:* Let  $p \ge 1$ ,  $\mathscr{O} \subset \mathbb{R}^1$ ,  $T \equiv t_M > 0$  be fixed,  $\phi^0 \in L^{2p}(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2(\mathscr{O}))$ , and W be  $\mathbb{H}^2_0 \cap \mathbb{H}^3$ -valued. Suppose  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$  with  $c \ge c^* > 0$ . There exist a constant  $K \equiv K(p, T, c^*) > 0$ , and  $\tau^* \equiv \tau^*(\|\phi^0\|_{\mathbb{H}^1_n \cap \mathbb{H}^2}, T)$  such that for all  $\tau \le \tau^*$  holds

$$\begin{aligned} &(1) \quad \max_{1 \le n \le M} \left[ E \left( \|\phi^n\|_{\mathbb{H}^2}^2 + \sum_{k=0}^n \|\phi^{k+1} - \phi^k\|_{\mathbb{H}^1}^2 + (2\theta - 1) \sum_{k=0}^n \|\phi^{k+1} - \phi^k\|_{\mathbb{H}^2}^2 \right) \right] \le K, \\ &(\text{ii}) \quad \max_{1 \le n \le M} E \left( \|\phi^n\|_{\mathbb{H}^2}^{2^p} \right) \le K, \\ &(\text{iii}) \quad \max_{1 \le n \le M} E \|\phi^{n+1} - \phi^n\|_{\mathbb{H}^1}^{2^p} \le K \tau^p, \\ &(\text{iv}) \quad E \left( \max_{1 \le n \le M} \|\phi^n\|_{\mathbb{H}^2}^{2^p} \right) \le K. \end{aligned}$$

*Proof:* We formally test equation (28) with  $z = \Delta \left(\bar{\phi}^{n+1} - \bar{\phi}^n\right)$  and take the real part. Because of  $\theta \Delta \phi^{n+1} + (1-\theta)\Delta \phi^n = \Delta \phi^{n+1} + (\theta-1)(\Delta \phi^{n+1} - \Delta \phi^n)$  and  $\Re \left(a(\bar{a}-\bar{b})\right) = \frac{1}{2}\left(|a|^2 - |b|^2 + |a-b|^2\right)$ , we

Step 1: Estimate of the stochastic integral term B. We use integration by parts to benefit from equation (28) and W being real-valued,

$$B = \frac{2}{\tau} \Re \int_{\mathscr{O}} \phi^{n+\frac{1}{2}} \Delta_{n} W(\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^{n}) dx$$

$$= \frac{2}{\tau} \Re \int_{\mathscr{O}} \Delta(\bar{\phi}^{n+\frac{1}{2}} \Delta_{n} W)(\phi^{n+1} - \phi^{n}) dx$$

$$= \frac{2}{\tau} \Re \int_{\mathscr{O}} \Delta(\bar{\phi}^{n+\frac{1}{2}} \Delta_{n} W) \Big[ i\tau \big( \theta \Delta \phi^{n+1} + (1-\theta) \Delta \phi^{n} \big) - i\frac{\tau}{2} (|\phi^{n+1}|^{2} + |\phi^{n}|^{2}) \phi^{n+\frac{1}{2}} - i\phi^{n+\frac{1}{2}} \Delta_{n} W \Big] dx$$

$$= 2 \Re \int_{\mathscr{O}} i\Delta(\bar{\phi}^{n+\frac{1}{2}} \Delta_{n} W) \big( \theta \Delta \phi^{n+1} + (1-\theta) \Delta \phi^{n} \big) dx - \Re \int_{\mathscr{O}} i\Delta(\bar{\phi}^{n+\frac{1}{2}} \Delta_{n} W) (|\phi^{n+1}|^{2} + |\phi^{n}|^{2}) \phi^{n+\frac{1}{2}} dx$$

$$=: B^{1} + B^{2}.$$

Step 2: Estimate of term  $B^1$ . We rewrite the term  $B^1$  as follows,

$$B^{1} = 2\Re \int_{\mathscr{O}} i\Delta(\bar{\phi}^{n+\frac{1}{2}}\Delta_{n}W) \left(\theta\Delta\phi^{n+1} + (1-\theta)\Delta\phi^{n}\right) dx$$
  

$$= 2\Re \int_{\mathscr{O}} i\Delta\bar{\phi}^{n+\frac{1}{2}} \left(\theta\Delta\phi^{n+1} + (1-\theta)\Delta\phi^{n}\right) \Delta_{n}W dx + 2\Re \int_{\mathscr{O}} i\bar{\phi}^{n+\frac{1}{2}}\Delta(\Delta_{n}W) \left(\theta\Delta\phi^{n+1} + (1-\theta)\Delta\phi^{n}\right) dx$$
  

$$+ 4\Re \int_{\mathscr{O}} i\nabla\bar{\phi}^{n+\frac{1}{2}}\nabla(\Delta_{n}W) \left(\theta\Delta\phi^{n+1} + (1-\theta)\Delta\phi^{n}\right) dx$$
  

$$=: B^{1}_{a} + B^{1}_{b} + B^{1}_{c}.$$
(45)

Since  $\theta \Re (i \| \Delta \phi^{n+1} \|_{\mathbb{L}^2}^2) + (1-\theta) \Re (i \| \Delta \phi^n \|_{\mathbb{L}^2}^2) = 0$ , we have

$$B_a^1 = \theta \Re \int_{\mathscr{O}} i\Delta \bar{\phi}^n \Delta \phi^{n+1} \Delta_n W dx + (1-\theta) \Re \int_{\mathscr{O}} i\Delta \bar{\phi}^{n+1} \Delta \phi^n \Delta_n W dx$$
  
$$= (2\theta - 1) \Re \int_{\mathscr{O}} i\Delta \bar{\phi}^n \Delta \phi^{n+1} \Delta_n W dx$$

Therefore  $E(B_a^1) \leq \frac{2\theta-1}{8}E \|\Delta \phi^{n+1} - \Delta \phi^n\|_{\mathbb{L}^2}^2 + K\tau E \|\Delta \phi^n\|_{\mathbb{L}^2}^2.$ 

Since  $\phi^{n+\frac{1}{2}} = \phi^n + \frac{\phi^{n+1} - \phi^n}{2}$ , we have the following estimate for the term  $B_b^1$  in (45),

$$\begin{split} B_{b}^{1} &= 2\Re \int_{\mathscr{O}} i\bar{\phi}^{n} \Delta(\Delta_{n}W) \left(\theta \Delta \phi^{n+1} + (1-\theta)\Delta \phi^{n}\right) dx + \Re \int_{\mathscr{O}} i(\bar{\phi}^{n+1} - \bar{\phi}^{n}) \Delta(\Delta_{n}W) \left(\theta \Delta \phi^{n+1} + (1-\theta)\Delta \phi^{n}\right) dx \\ &= 2\theta \Re \int_{\mathscr{O}} i\bar{\phi}^{n} \Delta(\Delta_{n}W) \Delta(\phi^{n+1} - \phi^{n}) dx + 2\Re \int_{\mathscr{O}} i\bar{\phi}^{n} \Delta(\Delta_{n}W) \Delta \phi^{n} dx \\ &+ \Re \int_{\mathscr{O}} i(\bar{\phi}^{n+1} - \bar{\phi}^{n}) \Delta(\Delta_{n}W) \left(\theta \Delta \phi^{n+1} + (1-\theta)\Delta \phi^{n}\right) dx \end{split}$$

Integration by parts for the first term leads to

$$\begin{split} B_b^1 &= -2\theta \Re \int_{\mathscr{O}} i\nabla \left(\bar{\phi}^n \Delta(\Delta_n W)\right) (\nabla \phi^{n+1} - \nabla \phi^n) dx + 2\Re \int_{\mathscr{O}} i\bar{\phi}^n \Delta(\Delta_n W) \Delta \phi^n dx \\ &+ \Re \int_{\mathscr{O}} i(\bar{\phi}^{n+1} - \bar{\phi}^n) \Delta(\Delta_n W) \left(\theta \Delta \phi^{n+1} + (1-\theta) \Delta \phi^n\right) dx \\ &\leq \frac{1}{8} \|\nabla \phi^{n+1} - \nabla \phi^n\|_{\mathbb{L}^2}^2 + 8\|\nabla \left(\bar{\phi}^n \Delta(\Delta_n W)\right)\|_{\mathbb{L}^2}^2 + K \frac{1}{\tau} \|\phi^{n+1} - \phi^n\|_{\mathbb{L}^2}^4 \\ &+ K \frac{1}{\tau} \|\Delta(\Delta_n W)\|_{\mathbb{L}^\infty}^4 + \tau \left(\|\Delta \phi^{n+1}\|_{\mathbb{L}^2}^2 + \|\Delta \phi^n\|_{\mathbb{L}^2}^2\right) + 2\Re \int_{\mathscr{O}} i\bar{\phi}^n \Delta(\Delta_n W) \Delta \phi^n dx. \end{split}$$

By assertion (i) and (ii) of Lemma 7, we get

$$E(B_b^1) \leq \frac{1}{8} E \|\nabla \phi^{n+1} - \nabla \phi^n\|_{\mathbb{L}^2}^2 + K\tau + K\tau \Big( \|\Delta \phi^{n+1}\|_{\mathbb{L}^2}^2 + \|\Delta \phi^n\|_{\mathbb{L}^2}^2 \Big).$$

For term  $B_c^1$ , we use again  $\phi^{n+\frac{1}{2}} = \phi^n + \frac{\phi^{n+1} - \phi^n}{2}$  to obtain

$$\begin{split} B_{c}^{1} =& 4\theta \Re \int_{\mathscr{O}} i \nabla \bar{\phi}^{n+\frac{1}{2}} \nabla (\Delta_{n} W) \Delta \phi^{n+1} dx + 4(1-\theta) \Re \int_{\mathscr{O}} i \nabla \bar{\phi}^{n+\frac{1}{2}} \nabla (\Delta_{n} W) \Delta \phi^{n} dx \\ =& 4\theta \Re \int_{\mathscr{O}} i \Big( \nabla \bar{\phi}^{n} + \frac{\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}}{2} \Big) \nabla (\Delta_{n} W) \Big( (\Delta \phi^{n+1} - \Delta \phi^{n}) + \Delta \phi^{n} \Big) dx \\ &+ 4(1-\theta) \Re \int_{\mathscr{O}} i \Big( \nabla \bar{\phi}^{n} + \frac{\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}}{2} \Big) \nabla (\Delta_{n} W) \Delta \phi^{n} dx \,. \end{split}$$

In the following step, we use that the Wiener process is  $\mathbb{H}^2_0$ -valued to allow for integration by parts,

$$=4\theta\Re\int_{\mathscr{O}}i\nabla\bar{\phi}^{n}\nabla(\Delta_{n}W)\Delta(\phi^{n+1}-\phi^{n})dx+2\Re\int_{\mathscr{O}}i\nabla(\bar{\phi}^{n+1}-\bar{\phi}^{n})\nabla(\Delta_{n}W)\Delta\phi^{n}dx$$
$$+4\Re\int_{\mathscr{O}}i\nabla\bar{\phi}^{n}\nabla(\Delta_{n}W)\Delta\phi^{n}dx+2\theta\Re\int_{\mathscr{O}}i(\nabla\bar{\phi}^{n+1}-\nabla\bar{\phi}^{n})\nabla(\Delta_{n}W)(\Delta\phi^{n+1}-\Delta\phi^{n})dx$$

Integration by parts for the first term then leads to

$$B_{c}^{1} = -4\theta \Re \int_{\mathscr{O}} i\nabla \bar{\phi}^{n} \Delta(\Delta_{n}W) (\nabla \phi^{n+1} - \nabla \phi^{n}) dx + 2(1+2\theta) \Re \int_{\mathscr{O}} i(\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}) \nabla(\Delta_{n}W) \Delta \phi^{n} dx + 4\Re \int_{\mathscr{O}} i\nabla \bar{\phi}^{n} \nabla(\Delta_{n}W) \Delta \phi^{n} dx + 2\theta \Re \int_{\mathscr{O}} i(\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}) \nabla(\Delta_{n}W) (\Delta \phi^{n+1} - \Delta \phi^{n}) dx.$$

We only present the estimate of the last term, the remainder terms can be easily bounded as before.

$$\begin{split} &2\theta\Re\int_{\mathscr{O}}i(\nabla\bar{\phi}^{n+1}-\nabla\bar{\phi}^{n})\nabla(\Delta_{n}W)(\Delta\phi^{n+1}-\Delta\phi^{n})dx\\ &\leq 2\|\Delta\phi^{n+1}-\Delta\phi^{n}\|_{\mathbb{L}^{2}}\|\nabla\phi^{n+1}-\nabla\phi^{n}\|_{\mathbb{L}^{2}}\|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}\\ &\leq \frac{2\theta-1}{8}\|\Delta\phi^{n+1}-\Delta\phi^{n}\|_{\mathbb{L}^{2}}^{2}+\frac{8}{2\theta-1}\|\nabla\phi^{n+1}-\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2}\|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{2}\\ &\leq \frac{2\theta-1}{8}\|\Delta\phi^{n+1}-\Delta\phi^{n}\|_{\mathbb{L}^{2}}^{2}+\frac{1}{8}\|\nabla\phi^{n+1}-\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2}+\frac{32}{(2\theta-1)^{2}}\|\nabla\phi^{n+1}-\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2}\|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{4}\\ &\leq \frac{2\theta-1}{8}\|\Delta\phi^{n+1}-\Delta\phi^{n}\|_{\mathbb{L}^{2}}^{2}+\frac{1}{8}\|\nabla\phi^{n+1}-\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2}+K\tau\Big(\|\nabla\phi^{n+1}\|_{\mathbb{L}^{2}}^{4}+\|\nabla\phi^{n}\|_{\mathbb{L}^{2}}^{4}\Big)+\frac{1}{\tau(2\theta-1)^{4}}\|\nabla(\Delta_{n}W)\|_{\mathbb{L}^{\infty}}^{8}. \end{split}$$

Therefore, for  $2\theta - 1 \ge c\sqrt{\tau}$  with  $c \ge c^* > 0$  and since  $E \|\nabla(\Delta_n W)\|_{\mathbb{L}^{\infty}}^8 = O(\tau^4)$ , by Lemma 7 (i) we obtain

$$E(B_{c}^{1}) \leq K\tau + \frac{2\theta - 1}{8}E\|\Delta\phi^{n+1} - \Delta\phi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{3}{8}\|\nabla\phi^{n+1} - \nabla\phi^{n}\|_{\mathbb{L}^{2}}^{2} + K\tau\|\Delta\phi^{n}\|_{\mathbb{L}^{2}}^{2}.$$

Step 3: Estimate of term  $B^2$ . By integration by parts,

$$\begin{split} B^{2} &= \frac{1}{4} \Re \int_{\mathscr{O}} i \nabla \Big( (\bar{\phi}^{n+1} + \bar{\phi}^{n}) \Delta_{n} W \Big) \nabla \Big( (|\phi^{n+1}|^{2} + |\phi^{n}|^{2}) (\phi^{n+1} + \phi^{n}) \Big) dx \\ &= \frac{1}{4} \Re \int_{\mathscr{O}} i \Big( \nabla \bar{\phi}^{n+1} \Delta_{n} W + \nabla \bar{\phi}^{n} \Delta_{n} W + \bar{\phi}^{n+1} \nabla (\Delta_{n} W) + \bar{\phi}^{n} \nabla (\Delta_{n} W) \Big) \Big( (\phi^{n+1})^{2} \nabla \bar{\phi}^{n+1} + 2 \nabla \phi^{n+1} |\bar{\phi}^{n+1}|^{2} \\ &+ \nabla \phi^{n+1} \bar{\phi}^{n+1} \phi^{n} + \phi^{n+1} \phi^{n} \nabla \bar{\phi}^{n+1} + |\phi^{n+1}|^{2} \nabla \phi^{n} + \nabla \phi^{n} \bar{\phi}^{n} \phi^{n+1} + 2 \nabla \phi^{n} |\phi^{n}|^{2} + \nabla \bar{\phi}^{n} \phi^{n} \phi^{n+1} \\ &+ \nabla \bar{\phi}^{n} (\phi^{n})^{2} + |\phi^{n}|^{2} \nabla \phi^{n+1} \Big) dx \end{split}$$

The estimates of these terms are done by inserting functions of  $\phi^n$  and using the fact that  $E(\Delta_n W | \mathscr{F}_{t_n}) = 0$ . So here we only present one troublesome term in  $B^2$  as an example.

$$\begin{split} \Re & \int_{\mathscr{O}} i (\nabla \bar{\phi}^{n+1} \phi^{n+1})^2 \Delta_n W dx \\ &= \Re \int_{\mathscr{O}} i \Big( (\nabla \bar{\phi}^{n+1} \phi^{n+1})^2 - (\nabla \bar{\phi}^n \phi^n)^2 \Big) \Delta_n W dx + \Re \int_{\mathscr{O}} i (\nabla \bar{\phi}^n \phi^n)^2 \Delta_n W dx. \end{split}$$

The expectation of the second term is zero. By the identity  $a^2 - b^2 = (a+b)(a-b)$ , we deal with the first term below.

$$\begin{split} \Re & \int_{\mathscr{O}} i \Big( (\nabla \bar{\phi}^{n+1} \phi^{n+1})^2 - (\nabla \bar{\phi}^n \phi^n)^2 \Big) \Delta_n W dx \\ &= \Re \int_{\mathscr{O}} i (\nabla \bar{\phi}^{n+1} \phi^{n+1} + \nabla \bar{\phi}^n \phi^n) (\nabla \bar{\phi}^{n+1} \phi^{n+1} - \nabla \bar{\phi}^n \phi^n) \Delta_n W dx \\ &= \Re \int_{\mathscr{O}} i (\nabla \bar{\phi}^{n+1} \phi^{n+1} + \nabla \bar{\phi}^n \phi^n) (\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^n) \phi^n \Delta_n W dx \\ &+ \Re \int_{\mathscr{O}} i (\nabla \bar{\phi}^{n+1} \phi^{n+1} + \nabla \bar{\phi}^n \phi^n) \nabla \bar{\phi}^{n+1} (\phi^{n+1} - \phi^n) \Delta_n W dx. \end{split}$$
(46)

For the first term, we use  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^\infty$  and Young's inequality to conclude

$$\begin{split} \Re &\int_{\mathscr{O}} i(\nabla \bar{\phi}^{n+1} \phi^{n+1} + \nabla \bar{\phi}^{n} \phi^{n})(\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}) \phi^{n} \Delta_{n} W dx \\ &\leq \left( \|\nabla \phi^{n+1}\|_{\mathbb{L}^{2}} \|\phi^{n+1}\|_{\mathbb{L}^{\infty}} + \|\nabla \phi^{n}\|_{\mathbb{L}^{2}} \|\phi^{n}\|_{\mathbb{L}^{\infty}} \right) \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}} \|\phi^{n}\|_{\mathbb{L}^{\infty}} \|\Delta_{n} W\|_{\mathbb{L}^{\infty}} \\ &\leq \frac{1}{8} \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} + \frac{1}{\tau} \|\Delta_{n} W\|_{\mathbb{L}^{\infty}}^{4} + K\tau \|\phi^{n+1}\|_{\mathbb{H}^{1}}^{8} \|\phi^{n}\|_{\mathbb{H}^{1}}^{4} + K\tau \|\phi^{n}\|_{\mathbb{H}^{1}}^{12}, \end{split}$$

Similarly, by embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^{\infty}$  and Hölder inequality, we get the estimation of the second term in (46),

$$\begin{split} &\Re \int_{\mathscr{O}} i(\nabla \bar{\phi}^{n+1} \phi^{n+1} + \nabla \bar{\phi}^{n} \phi^{n}) \nabla \bar{\phi}^{n+1} (\phi^{n+1} - \phi^{n}) \Delta_{n} W dx \\ &\leq \left( \|\nabla \phi^{n+1}\|_{\mathbb{L}^{2}} \|\phi^{n+1}\|_{\mathbb{L}^{\infty}} + \|\nabla \phi^{n}\|_{\mathbb{L}^{2}} \|\phi^{n}\|_{\mathbb{L}^{\infty}} \right) \|\nabla \phi^{n+1}\|_{\mathbb{L}^{2}} \|\phi^{n+1} - \phi^{n+1}\|_{\mathbb{L}^{\infty}} \|\Delta_{n} W\|_{\mathbb{L}^{\infty}} \\ &\leq \|\phi^{n+1} - \phi^{n}\|_{\mathbb{H}^{1}}^{2} + \frac{1}{\tau} \|\Delta_{n} W\|_{\mathbb{L}^{\infty}}^{4} + K\tau \|\phi^{n+1}\|_{\mathbb{H}^{1}}^{12} + K\tau \|\phi^{n}\|_{\mathbb{H}^{1}}^{12}. \end{split}$$

Therefore, from Lemma 7 (i) and (ii), we have

$$E(B^{2}) \leq K\tau + K\tau \left( E \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + E \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2} \right) + \frac{1}{8} E \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2}.$$

Step 4: Estimate of term A. Because of  $(|a|^2 + |b|^2)(a+b) = 2|a|^2a + 2|b|^2b - (|b|^2 - |a|^2)(b-a)$  for  $a, b \in \mathbb{C}$ , we split term A further into

$$\begin{split} A &= \Re \int_{\mathscr{O}} \left( |\phi^{n+1}|^2 + |\phi^n|^2 \right) \phi^{n+\frac{1}{2}} (\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^n) dx \\ &= -\frac{1}{2} \Re \int_{\mathscr{O}} (|\phi^{n+1}|^2 - |\phi^n|^2) (\phi^{n+1} - \phi^n) (\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^n) dx \\ &+ \Re \int_{\mathscr{O}} |\phi^n|^2 \phi^n (\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^n) dx + \Re \int_{\mathscr{O}} |\phi^{n+1}|^2 \phi^{n+1} (\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^n) dx \\ &= :A^1 + A^2 + A^3. \end{split}$$

We use the identity  $|a|^2a - |b|^2b = |a|^2(a-b) + |b|^2(a-b) + ab(\bar{a}-\bar{b})$  for  $a, b \in \mathbb{C}$  to rewrite term  $A^2$  as

$$A^{2} = \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} |\phi^{n+1}|^{2} \phi^{n+1} dx - \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n} |\phi^{n}|^{2} \phi^{n} dx - \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} (|\phi^{n+1}|^{2} \phi^{n+1} - |\phi^{n}|^{2} \phi^{n}) dx$$
  

$$= \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} |\phi^{n+1}|^{2} \phi^{n+1} dx - \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n} |\phi^{n}|^{2} \phi^{n} dx - \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} |\phi^{n+1}|^{2} (\phi^{n+1} - \phi^{n}) dx$$
  

$$- \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} |\phi^{n}|^{2} (\phi^{n+1} - \phi^{n}) dx + \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} \phi^{n+1} |\phi^{n+1} - \phi^{n}|^{2} dx - \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} (\phi^{n+1})^{2} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) dx.$$
  
(48)

where for the last two terms in (48), we use

$$\Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} \phi^{n+1} \phi^n (\bar{\phi}^{n+1} - \bar{\phi}^n) dx = -\Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} \phi^{n+1} |\phi^{n+1} - \phi^n|^2 dx + \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} (\phi^{n+1})^2 (\bar{\phi}^{n+1} - \bar{\phi}^n) dx.$$

We use integration by parts and product formula to rewrite term  $A^3$ .

$$A^{3} = \Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) \Delta (|\phi^{n+1}|^{2} \phi^{n+1}) dx$$
  
=  $2 \Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) \Delta \phi^{n+1} |\phi^{n+1}|^{2} dx + \Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) (\phi^{n+1})^{2} \Delta \bar{\phi}^{n+1} dx$   
+  $2 \Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) (\nabla \phi^{n+1})^{2} \bar{\phi}^{n+1} dx + 4 \Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) |\nabla \phi^{n+1}|^{2} \phi^{n+1} dx.$  (49)

Summing up (48) and (49) and  $\Re(a) = \Re(\bar{a})$  for  $a \in \mathbb{C}$  lead to

$$A^{2} + A^{3} = \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} |\phi^{n+1}|^{2} \phi^{n+1} dx - \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n} |\phi^{n}|^{2} \phi^{n} dx + \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} (|\phi^{n+1}|^{2} - |\phi^{n}|^{2}) (\phi^{n+1} - \phi^{n}) dx + \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} \phi^{n+1} |\phi^{n+1} - \phi^{n}|^{2} dx + 2\Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) (\nabla \phi^{n+1})^{2} \bar{\phi}^{n+1} dx + 4\Re \int_{\mathscr{O}} (\bar{\phi}^{n+1} - \bar{\phi}^{n}) |\nabla \phi^{n+1}|^{2} \phi^{n+1} dx.$$

Plugging equation (50) into (47), one has

We estimate the terms separately. The estimation of the terms  $A_{a,n+1}$  and  $A_{a,n}$  follows from their special structure (when taking the sum with respect to *n*, all middle term are canceled) and Lemma 7. For term  $A_b$ , we use binomial formula, and interpolation of  $\mathbb{L}^4$  between  $\mathbb{L}^2$  and  $\mathbb{H}^1$  for d = 1.

$$\begin{split} A_{b} &= \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+\frac{1}{2}} (|\phi^{n+1}|^{2} - |\phi^{n}|^{2}) (\phi^{n+1} - \phi^{n}) dx \\ &\leq 2 \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{4}}^{2} \|\Delta \phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{2}} \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}} \\ &\leq \tau \left( \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2} \right) + \frac{1}{\tau} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{4}}^{4} \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}}^{2} \\ &\leq \tau \left( \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2} \right) + \frac{K}{\tau} \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{3} \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}}^{2} \\ &\leq \tau \left( \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2} \right) + \frac{1}{8} \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} + K\tau \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}}^{8} + \frac{1}{\tau^{5}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{12}. \end{split}$$
For term  $A^{1}$ , we use  $\|\phi^{n+1}\|^{2} - \|\phi^{n}\|^{2} = 2\Re \left( \phi^{n+\frac{1}{2}} (\phi^{n+1} - \phi^{n}) \right)$  and  $\|\Delta (\phi^{n+1} - \Delta^{n})\|_{\mathbb{L}^{2}} \leq \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}} + K\tau \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}}^{8}$ 

 $\|\Delta \phi^n\|_{\mathbb{L}^2}$  to have

$$A^{1} \leq K ( \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}) \|\phi^{n+1} - \phi^{n+1}\|_{\mathbb{L}^{4}}^{2} \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}}$$
  
$$\leq K \tau ( \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2}) + K \frac{1}{\tau} \|\phi^{n+1} - \phi^{n+1}\|_{\mathbb{L}^{4}}^{4} \|\phi^{n+\frac{1}{2}}\|_{\mathbb{L}^{\infty}}^{2}.$$

Now follow the steps for  $A_b$  to estimate the right-hand side. In order to bound the term  $A_c$ , we use once more the interpolation result for  $\mathbb{L}^4$  which holds for d = 1.

$$\begin{split} A_{c} &= \Re \int_{\mathscr{O}} \Delta \bar{\phi}^{n+1} \phi^{n+1} |\phi^{n+1} - \phi^{n}|^{2} dx \\ &\leq \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}} \|\phi^{n+1}\|_{\mathbb{L}^{\infty}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{4}}^{2} \\ &\leq K \tau \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + K \frac{1}{\tau} \|\phi^{n+1}\|_{\mathbb{L}^{\infty}}^{2} \|\nabla \phi^{n+1} - \nabla \phi^{n}\|_{\mathbb{L}^{2}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{3} \\ &\leq K \tau \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{8} \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} + K \tau \|\phi^{n+1}\|_{\mathbb{L}^{\infty}}^{8} + K \frac{1}{\tau^{5}} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{12}. \end{split}$$

For the last two terms  $A_d + A_e$ , we replace the expression  $\bar{\phi}^{n+1} - \bar{\phi}^n = -i\tau \left(\theta \Delta \bar{\phi}^{n+1} + (1-\theta)\Delta \bar{\phi}^n\right) + \frac{i}{2}\tau \left(|\phi^{n+1}|^2 + |\phi^n|^2\right)\bar{\phi}^{n+\frac{1}{2}} + i\bar{\phi}^{n+\frac{1}{2}}\Delta_n W$ , then for the second term and third terms of the resulting equality, we can estimate them as before.

Here by the interpolation of  $\mathbb{L}^4$  between  $\mathbb{H}^1$  and  $\mathbb{L}^2$ , and the continuous embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^\infty$ , we estimate the first term of resulting equality after replacing  $\bar{\phi}^{n+1} - \bar{\phi}^n$  into  $A_d$ ,

$$\begin{aligned} &2\tau \Re \int_{\mathscr{O}} (-i) (\nabla \phi^{n+1})^2 \bar{\phi}^{n+1} \left( \theta \Delta \bar{\phi}^{n+1} + (1-\theta) \Delta \bar{\phi}^n \right) dx \\ &+ 4\tau \Re \int_{\mathscr{O}} (-i) \phi^{n+1} |\nabla \phi^{n+1}|^2 \left( \theta \Delta \bar{\phi}^{n+1} + (1-\theta) \Delta \bar{\phi}^n \right) dx \\ &\leq 6\tau \left( \|\Delta \phi^{n+1}\|_{\mathbb{L}^2}^2 + \|\Delta \phi^n\|_{\mathbb{L}^2}^2 \right) \|\nabla \phi^{n+1}\|_{\mathbb{L}^4}^2 \|\phi^{n+1}\|_{\mathbb{L}^\infty} \\ &\leq K\tau \left( \|\Delta \phi^{n+1}\|_{\mathbb{L}^2}^2 + \|\Delta \phi^n\|_{\mathbb{L}^2}^2 \right) + K\tau \|\nabla \phi^{n+1}\|_{\mathbb{L}^2}^5 \|\Delta \phi^{n+1}\|_{\mathbb{L}^2} \\ &\leq K\tau \left( \|\Delta \phi^{n+1}\|_{\mathbb{L}^2}^2 + \|\Delta \phi^n\|_{\mathbb{L}^2}^2 \right) + K\tau \|\nabla \phi^{n+1}\|_{\mathbb{L}^2}^5. \end{aligned}$$

As a consequence, all terms on the right-hand side of (43) may be controlled with the help of Lemma 7 and a Gronwall's argument, apart from the term  $\|\nabla(\phi^{n+1} - \phi^n)\|_{\mathbb{L}^2}$ .

Step 5: Estimate of the term  $\|\nabla(\phi^{n+1} - \phi^n)\|_{\mathbb{L}^2}$ . We formally test equation (28) with  $-\Delta(\bar{\phi}^{n+1} - \bar{\phi}^n)$  and take the imaginary part. We repeatedly use properties of the imaginary part of a complex number to obtain

$$\begin{split} \|\nabla(\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} = &\tau \Im \int_{\mathscr{O}} \Delta \phi^{n+1} \Delta \bar{\phi}^{n} dx - \frac{\tau}{2} \Im \int_{\mathscr{O}} \left( |\phi^{n+1}|^{2} + |\phi^{n}|^{2} \right) \phi^{n+\frac{1}{2}} (\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^{n}) dx \\ &+ \Im \int_{\mathscr{O}} \nabla(\phi^{n} \Delta_{n} W) (\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}) dx - \frac{1}{2} \Im \int_{\mathscr{O}} (\phi^{n+1} - \phi^{n}) \Delta_{n} W (\Delta \bar{\phi}^{n+1} - \Delta \bar{\phi}^{n}) dx \\ \leq & K \tau \Big( \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2} \Big) + \frac{\tau}{16} \|\Delta (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} + K \tau \Big( \|\phi^{n+1}\|_{\mathbb{L}^{6}}^{6} + \|\phi^{n}\|_{\mathbb{L}^{6}}^{6} \Big) \\ &+ \frac{1}{2} \|\nabla (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} + K \|\nabla (\phi^{n} \Delta_{n} W)\|_{\mathbb{L}^{2}}^{2} + \frac{2\theta - 1}{16} \|\Delta (\phi^{n+1} - \phi^{n})\|_{\mathbb{L}^{2}}^{2} \\ &+ \frac{1}{2\theta - 1} \|\phi^{n+1} - \phi^{n}\|_{\mathbb{L}^{2}}^{4} + \frac{1}{2\theta - 1} \|\Delta_{n} W\|_{\mathbb{L}^{\infty}}^{4}. \end{split}$$

By the continuous embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^6$ , and Lemma 7 (i), the term  $\|\phi^{n+1}\|_{\mathbb{L}^6}^6 + \|\phi^n\|_{\mathbb{L}^6}^6$  can be bounded. Other terms can be bounded by assertions (i) and (ii) of Lemma 7. Therefore

$$\begin{split} E \|\nabla(\phi^{n+1} - \phi^n)\|_{\mathbb{L}^2}^2 &\leq K \Big(\tau + \frac{\tau^2}{2\theta - 1}\Big) + K\tau \Big(E \|\Delta\phi^{n+1}\|_{\mathbb{L}^2}^2 + E \|\Delta\phi^n\|_{\mathbb{L}^2}^2\Big) \\ &+ \Big(\frac{2\theta - 1}{16} + \frac{\tau}{16}\Big)E \|\Delta(\phi^{n+1} - \phi^n)\|_{\mathbb{L}^2}^2. \end{split}$$

Step 6: Gronwall argument. We may combine these estimates for the terms on the right-hand side of (43). For  $\tau \leq \tau^*$  sufficiently small, we prove the assertion (i) to benefit from Gronwall's inequality and Lemma 7.

The proof of assertion (ii) is similar to Lemma 7 (i). Property (ii) then allow to validate assertion (iii). The proof of assertion (iv) is similar to Lemma 8.

**Remark** 5: To derive uniform bounds in higher norms for iterates of Algorithm 1 is a bit more complicated than for the continuous problem (Lemma 3). Terms  $A^1$ ,  $A^b$  to  $A^e$  can only be estimated in 1D.

Since we get a better estimate for  $\|\nabla(\bar{\phi}^{n+1} - \bar{\phi}^n)\|_{\mathbb{L}^2}$  in Lemma 10, we can get a better conservation of the  $\mathbb{L}^2$ -norm for domains  $\mathscr{O} \subset \mathbb{R}^1$ ; in fact, the next lemma asserts that the conservation of the  $\mathbb{L}^2$ -norm is of order  $\frac{1}{2}$  for  $2\theta - 1 = c\sqrt{\tau}$  with  $c \ge c^* > 0$ .

*Lemma 11:* Let  $\mathscr{O} \subset \mathbb{R}^1$ ,  $T \equiv t_M > 0$  be fixed, and  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$  with  $c \geq c^* > 0$ . There exist a constant  $K \equiv K(T, c^*) > 0$  and  $\tau^* \equiv \tau^*(\|\phi^0\|_{\mathbb{H}^1_0 \cap \mathbb{H}^2}, T)$  such that for all  $\tau \leq \tau^*$  holds

$$\max_{1 \le n \le M} E \|\phi^n\|_{\mathbb{L}^2}^2 - E \|\phi^0\|_{\mathbb{L}^2}^2 \le K(2\theta - 1)\tau^{\frac{1}{2}}.$$
(52)

Proof: Recall (42), but now scale factors differently.

$$\begin{split} \|\phi^{n+1}\|_{\mathbb{L}^{2}}^{2} &- \|\phi^{n}\|_{\mathbb{L}^{2}}^{2} = (1-2\theta)\tau \Im \int_{\mathscr{O}} (\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}) \nabla \phi^{n} dx \\ &\leq (2\theta-1)\tau^{\frac{1}{2}} \Big( \|\nabla \phi^{n+1} - \nabla \phi^{n}\|_{\mathbb{L}^{2}}) (\tau^{\frac{1}{2}} \|\nabla \phi^{n}\|_{\mathbb{L}^{2}} \Big) \\ &\leq \frac{(2\theta-1)\tau^{\frac{1}{2}}}{2} \|\nabla \bar{\phi}^{n+1} - \nabla \bar{\phi}^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{(2\theta-1)\tau^{\frac{3}{2}}}{2} \|\nabla \bar{\phi}^{n}\|_{\mathbb{L}^{2}}^{2}. \end{split}$$

Now consider the above inequality for some  $0 \le \ell \le M$ , sum over the index from  $\ell = 0$  to *n*, take the expectation, and use Lemma 7 (i) and Lemma 10 to establish the assertion.

### V. Rates of convergence for the $\theta$ -scheme

Let  $e^n := \psi(t_n) - \phi^n$ , where  $\psi$  solves (15) and  $\{\phi^n\}$  solves Algorithm 1. The error equation then reads for all  $n \ge 0$ ,

$$i \int_{\mathscr{O}} (e^{n+1} - e^n) z dx - \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} (\nabla \psi(s) - \theta \nabla \phi^{n+1} - (1 - \theta) \nabla \phi^n) \nabla z dx ds$$

$$- \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} (|\psi(s)|^2 \psi(s) - \frac{1}{2} (|\phi^{n+1}|^2 + |\phi^n|^2) \phi^{n+\frac{1}{2}}) z dx ds = \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} (\psi(s) - \phi^n) z dx dW(s)$$

$$- \frac{i}{2} \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} \psi(s) F_{\mathbf{Q}} z dx ds - \frac{1}{2} \int_{\mathscr{O}} (\phi^{n+1} - \phi^n) z \Delta W_n dx \qquad \forall z \in \mathbb{H}_0^1.$$
(53)

The following theorem states strong rates of convergence for the  $\theta$ -scheme for initial data  $\psi_0 \in L^8(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2)$ ,  $\mathscr{O} \subset \mathbb{R}^1$  and  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$  with  $c \ge c^* > 0$ . Since its proof requires properties which are stated in Lemma 10, we again consider  $\mathbb{H}^2_0 \cap \mathbb{H}^3$ -valued driving Wiener processes.

**Theorem 1:** Consider  $\mathscr{O} \subset \mathbb{R}^1$ ,  $T \equiv t_M > 0$  and  $\theta \in [\frac{1}{2} + c\sqrt{\tau}, 1]$  with  $c \ge c^* > 0$ . Let  $\{\psi(t); 0 \le t \le T\}$  be the solution of equation (1) with  $\lambda = -1$ ,  $\psi_0 \in L^8(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2)$ , and driving  $\mathbb{H}^2_0 \cap \mathbb{H}^3$ -valued Wiener process W. Let  $\{\phi^n; 0 \le n \le M\}$  solve (28). Then there exist a constant  $K \equiv K(T, c^*) > 0$  and  $\tau^* \equiv \tau^*(\|\psi_0\|_{L^8(\Omega; \mathbb{H}^1_0 \cap \mathbb{H}^2)}, T) > 0$  such that for every  $0 < \tau \le \tau^*$ , we have

$$E\left(\mathbf{1}_{\tilde{\Omega}_{\kappa}}\max_{0\leq n\leq M}\|e^{n}\|_{\mathbb{L}^{2}}^{2}\right)\leq Ke^{K\kappa}\tau$$

for any fixed  $\kappa > 0$ , and

$$\tilde{\Omega}_{\kappa} := \tilde{\Omega}_{\kappa,M} = \left\{ \omega \in \Omega \left| \left( \sup_{0 \le t \le t_M} \| \psi(t) \|_{\mathbb{H}^1}^2 + \max_{0 \le l \le M} \| \phi^l \|_{\mathbb{H}^1}^2 \right) \le \kappa \right\}$$

Let  $\kappa = K^{-1}\log(\tau^{-\varepsilon})$  for some  $\varepsilon > 0$ . We may employ stability properties of both  $\psi$  and  $\{\phi^n\}$  to conclude

$$\lim_{\tau \to 0} P(\tilde{\Omega}_{\kappa}) = 1.$$
(54)

Then Theorem 1 amounts to

$$E\left(\mathbf{1}_{\tilde{\Omega}_{\kappa}}\max_{0\leq n\leq M}\|e^n\|_{\mathbb{L}^2}^2\right)\leq K\tau^{1-\varepsilon}.$$

For the subset  $\tilde{\Omega}_{\kappa}$ , by Corollary 1 and Lemma 8, there holds ( $\tau < 1$ )

$$P(\tilde{\Omega}_{\kappa}) \geq 1 - \frac{E\left(\sup_{t \in [0,T]} \|\psi(t)\|_{\mathbb{H}^{1}}^{2}\right) + E\left(\max_{0 \leq n \leq M} \|\phi^{n}\|_{\mathbb{H}^{1}}^{2}\right)}{K^{-1}\log(\tau^{-\varepsilon})} \geq 1 + \frac{1}{\tilde{\varepsilon}\log(\tau)},$$
  
for  $\tilde{\varepsilon} = \varepsilon \left[K\left(E(\sup_{t \in [0,T]} \|\psi(t)\|_{\mathbb{H}^{1}}^{2}) + E(\max_{0 \leq n \leq M} \|\phi^{n}\|_{\mathbb{H}^{1}}^{2})\right)\right]^{-1}$ . Therefore, (54) is valid.

A consequence of Theorem 1 is convergence with rates in probability sense for iterates of the scheme. For every  $\alpha < \frac{1}{2}$  and C > 0, we estimate

$$egin{aligned} &P\Big[\max_{0\leq n\leq M}\|e^n\|_{\mathbb{L}^2}\geq C au^lpha\Big]\leq P\Big[\Big\{\max_{0\leq n\leq M}\|e^n\|_{\mathbb{L}^2}\geq C au^lpha\Big\}\cap ilde{\Omega}_\kappa\Big]+P[\Omega\setminus ilde{\Omega}_\kappa]\ &\leq rac{K au}{C^2 au^{2lpha}}-rac{1}{arepsilon\log au}. \end{aligned}$$

Therefore, we obtain the following corollary.

**Corollary** 2: There exists a constant C > 0 such that for all  $\alpha < \frac{1}{2}$ ,

$$\lim_{\tau\to 0} P\Big[\max_{0\leq n\leq M} \|\psi(t_n)-\phi^n\|_{\mathbb{L}^2}\geq C\tau^{\alpha}\Big]=0.$$

The constant C > 0 used in this corollary may be determined from the constant K > 0 in Theorem 1.

*Proof:* (of Theorem 1) We test equation (53) with  $z = \bar{e}^{n+1}$ , and take the imaginary part. In below, we address the three terms on the left-hand sides resp. the three terms on the right-hand side independently.

LHS (first term I). Because of the identity  $\Re\left(a(\bar{a}-\bar{b})\right) = \frac{1}{2}\left(|a|^2 - |b|^2 + |a-b|^2\right)$  for  $a, b \in \mathbb{C}$ , we have

$$I = \Im\left(i\int_{\mathscr{O}} (e^{n+1} - e^n)\bar{e}^{n+1}dx\right) = \frac{1}{2}(\|e^{n+1}\|_{\mathbb{L}^2}^2 - \|e^n\|_{\mathbb{L}^2}^2 + \|e^{n+1} - e^n\|_{\mathbb{L}^2}^2).$$
(55)

LHS (second term II). We decompose the negative of term II as follows,

$$-II = \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} \left( \nabla \psi(s) - \theta \nabla \phi^{n+1} - (1-\theta) \nabla \phi^n \right) \nabla \bar{e}^{n+1} dx ds$$
  
$$= \theta \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} \left( \nabla \psi(s) - \nabla \psi(t_{n+1}) \right) \nabla \bar{e}^{n+1} dx ds + (1-\theta) \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} \left( \nabla \psi(s) - \nabla \psi(t_n) \right) \nabla \bar{e}^{n+1} dx ds$$
  
$$+ \tau \Im \int_{\mathscr{O}} \left( \theta \nabla e^{n+1} + (1-\theta) \nabla e^n \right) \nabla \bar{e}^{n+1} dx$$
  
$$= II^1 + II^2 + II^3.$$
(56)

The estimates of terms  $II^1$  and  $II^2$  are similar, we use integration by parts and equation (12). Taking  $II^1$  as an example, we know that

$$\begin{split} II^{1} &= -\theta \Im \int_{t_{n}}^{t_{n+1}} \int_{\mathscr{O}} \Delta \bar{e}^{n+1} \int_{t_{n+1}}^{s} \left( i\Delta \psi(\mathbf{v}) - i|\psi(\mathbf{v})|^{2} \psi(\mathbf{v}) - \frac{1}{2} \psi(\mathbf{v}) F_{\mathbf{Q}} \right) d\mathbf{v} dx ds \\ &- \theta \Im \int_{t_{n}}^{t_{n+1}} \int_{\mathscr{O}} \Delta \bar{e}^{n+1} \int_{t_{n+1}}^{s} i\psi(\mathbf{v}) dW(\mathbf{v}) dx ds \\ &= II_{a}^{1} + II_{b}^{1}. \end{split}$$

We use the embedding  $\mathbb{H}^1 \hookrightarrow \mathbb{L}^6$  and the stability of solution  $\{\psi(t); t \in [0,T]\}$  and iterates  $\{\phi^n; n = 0, 1, \dots, M\}$ ; i.e., Corollary 1, Lemma 3 and Lemma 10 to obtain

$$\begin{split} II_{a}^{1} &\leq \int_{t_{n}}^{t_{n+1}} \int_{t_{n+1}}^{s} \|\Delta \bar{e}^{n+1}\|_{\mathbb{L}^{2}} \Big( \|\Delta \psi(\nu)\|_{\mathbb{L}^{2}} + \|\psi(\nu)\|_{\mathbb{H}^{1}}^{3} + \|\psi(\nu)\|_{\mathbb{L}^{2}}^{2} \|F_{\mathbf{Q}}\|_{\mathbb{L}^{\infty}} \Big) d\nu ds \\ &\leq K\tau^{2} \Big( \|\Delta \psi(t_{n+1})\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n+1}\|_{\mathbb{L}^{2}}^{2} \Big) + K \int_{t_{n}}^{t_{n+1}} \int_{t_{n+1}}^{s} \Big( \|\psi(\nu)\|_{\mathbb{H}^{2}}^{2} + \|\psi(\nu)\|_{\mathbb{H}^{1}}^{6} + \|\psi(\nu)\|_{\mathbb{L}^{2}}^{2} \Big) d\nu ds, \end{split}$$

where we use  $\|\Delta e^{n+1}\|_{\mathbb{L}^2} \leq \|\Delta \psi(t_{n+1})\|_{\mathbb{L}^2} + \|\Delta \phi^{n+1}\|_{\mathbb{L}^2}$ . For the estimate of the term  $H_b^1$ , we use integration by parts twice and Young's inequality to get

Using a property of complex numbers, integration by parts and the triangle inequality we get

$$II^{3} = \tau(1-\theta)\Im \int_{\mathscr{O}} \Delta e^{n} (\bar{e}^{n+1} - \bar{e}^{n}) dx \leq K\tau \|\Delta e^{n}\|_{\mathbb{L}^{2}} \|e^{n+1} - e^{n}\|_{\mathbb{L}^{2}}$$
$$\leq \frac{1}{16} \|e^{n+1} - e^{n}\|_{\mathbb{L}^{2}}^{2} + K\tau^{2} \Big( \|\Delta \psi(t_{n})\|_{\mathbb{L}^{2}}^{2} + \|\Delta \phi^{n}\|_{\mathbb{L}^{2}}^{2} \Big).$$

LHS (third term III). The negative of the term III is

$$\begin{split} III &= \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} \left( |\Psi(s)|^2 \Psi(s) - |\Psi(t_n)|^2 \Psi(t_n) \right) \bar{e}^{n+1} dx ds - \frac{1}{2} \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} (|\phi^{n+1}|^2 - |\phi^n|^2) \phi^{n+\frac{1}{2}} \bar{e}^{n+1} dx ds \\ &- \frac{1}{2} \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} |\phi^n|^2 (\phi^{n+1} - \phi^n) \bar{e}^{n+1} dx ds + \Im \int_{t_n}^{t_{n+1}} \int_{\mathscr{O}} \left( |\Psi(t_n)|^2 \Psi(t_n) - |\phi^n|^2 \phi^n \right) \bar{e}^{n+1} dx ds \\ &= III^1 + III^2 + III^3 + III^4. \end{split}$$

Below we only present the estimate of the first term in the above equality. We benefit from the identity  $|a|^2a - |b|^2b = |a|^2(a-b) + |b|^2(a-b) + ab(\bar{a}-\bar{b})$  for  $a, b \in \mathbb{C}$  to obtain

Now consider the error inequality (57) for some  $0 \le \ell \le M$ , multiply it by  $\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}$ , sum over the index from  $\ell = 0$  to *n*, take the maximum between 0 and  $m \le M$ , and then take the expectation. The choice of this indicator function is necessary such that the term corresponding to the stochastic integral  $\mathscr{M}^{\ell}$  is a martingale, which allows the use of the Burkholder-Davis-Gundy inequality. So we obtain correspondingly for the first term on the left-hand side of (57)

$$E\left[\max_{0\leq n\leq m}\sum_{\ell=0}^{n}\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\mathscr{G}^{\ell}\right] = \sum_{\ell=0}^{m}E\left[\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\mathscr{G}^{\ell}\right] \leq K\tau + K\tau(1+\kappa)\sum_{\ell=0}^{m}E\left(\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\|e^{\ell+1}\|_{\mathbb{L}^{2}}^{2}\right).$$

In particular here, by Burkholder-Davis-Gundy inequality,

$$\begin{split} &E\left[\max_{0\leq n\leq m}\sum_{\ell=0}^{n}\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\Im\int_{t_{\ell}}^{t_{\ell+1}}\int_{\mathscr{O}}(\boldsymbol{\psi}(s)-\boldsymbol{\psi}(t_{\ell}))\bar{e}^{\ell}dxdW(s)\right]\\ &\leq KE\left[\left(\sum_{\ell=0}^{m}\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\int_{t_{\ell}}^{t_{\ell+1}}\|\boldsymbol{\psi}(s)-\boldsymbol{\psi}(t_{\ell})\|_{\mathbb{L}^{2}}^{2}\|F_{\mathbf{Q}}\|_{\mathbb{L}^{\infty}}^{2}\|e^{\ell}\|_{\mathbb{L}^{2}}^{2}ds\right)^{\frac{1}{2}}\right]\\ &\leq KE\left[\left(\max_{0\leq n\leq m}\mathbf{1}_{\tilde{\Omega}_{\kappa,n}}\|e^{n}\|_{\mathbb{L}^{2}}\right)\left(\sum_{\ell=0}^{m}\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\int_{t_{\ell}}^{t_{\ell+1}}\|\boldsymbol{\psi}(s)-\boldsymbol{\psi}(t_{n})\|_{\mathbb{L}^{2}}^{2}ds\right)^{\frac{1}{2}}\right]\\ &\leq \frac{1}{4}E\left[\max_{0\leq n\leq m}\mathbf{1}_{\tilde{\Omega}_{\kappa,n}}\|e^{n+1}\|_{\mathbb{L}^{2}}^{2}\right]+K\tau. \end{split}$$

For the second term, one needs to prove the martingale property first, which is equivalent to proving

$$E\Big[\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\Re\int_{\mathscr{O}}\phi^{\ell}\bar{e}^{\ell}\Delta_{\ell}\tilde{W}dx\Big|\mathscr{F}_{t_{j}}\Big]=0,$$

where  $\Delta_{\ell} \tilde{W} = (\Delta_{\ell} W)^2 - F_{\mathbf{Q}} \tau$  for  $j \leq \ell \leq n$ . In fact, we have

$$\begin{split} E\Big[\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\Re\int_{\mathcal{O}}\phi^{\ell}\bar{e}^{\ell}\Delta_{\ell}\tilde{W}dx\Big|\mathscr{F}_{t_{j}}\Big] &= E\Big[E\Big(\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\Re\int_{\mathcal{O}}\phi^{\ell}\bar{e}^{\ell}\Delta_{\ell}\tilde{W}dx\Big|\mathscr{F}_{t_{\ell}}\Big)\Big|\mathscr{F}_{t_{j}}\Big]\\ &= E\Big[\Re\int_{\mathcal{O}}\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\phi^{\ell}\bar{e}^{\ell}E\big(\Delta_{\ell}\tilde{W}\big|\mathscr{F}_{t_{\ell}}\big)dx\Big|\mathscr{F}_{t_{j}}\Big] = 0, \end{split}$$

the last line holds since

$$E\left[\Delta_{\ell}\tilde{W}\big|\mathscr{F}_{t_{\ell}}\right] = E\left[(\Delta_{\ell}W)^{2}\big|\mathscr{F}_{t_{\ell}}\right] - F_{\mathbf{Q}}\tau = 0.$$

Similar to before, we may estimate by Burkholder-Davis-Gundy inequality

$$E\left[\max_{0\leq n\leq m}\sum_{\ell=0}^{n}\mathbf{1}_{\tilde{\Omega}_{\kappa,\ell}}\Re\int_{\mathscr{O}}\phi^{\ell}\bar{e}^{\ell}\Delta_{\ell}\tilde{W}dx\right]\leq\frac{1}{4}E\left(\max_{0\leq n\leq m}\mathbf{1}_{\tilde{\Omega}_{\kappa,n}}\|e^{n+1}\|_{\mathbb{L}^{2}}^{2}\right)+K\tau.$$

Combining these estimates together, we have

$$\frac{1}{2}E\Big[\max_{0\leq n\leq m}\mathbf{1}_{\tilde{\boldsymbol{\Omega}}_{\kappa,n}}\|e^{n+1}\|_{\mathbb{L}^{2}}^{2}\Big]\leq K\tau+K\tau(1+\kappa)\sum_{\ell=0}^{m}E\Big(\mathbf{1}_{\tilde{\boldsymbol{\Omega}}_{\kappa,\ell}}\|e^{\ell+1}\|_{\mathbb{L}^{2}}^{2}\Big).$$

The discrete Gronwall's lemma then leads to

$$E\left[\max_{0\leq n\leq m}\mathbf{1}_{\tilde{\Omega}_{\kappa,n}}\|e^{n+1}\|_{\mathbb{L}^{2}}^{2}\right]\leq Ke^{Kt_{m}\kappa}\tau.$$

Using the nestedness of property  $\tilde{\Omega}_{\kappa,m} \subset \tilde{\Omega}_{\kappa,n}$  for all  $0 \leq n \leq m$  one obtains

$$E\left(\mathbf{1}_{\tilde{\Omega}_{\kappa,m}}\max_{0\leq n\leq m}\|e^{n+1}\|_{\mathbb{L}^{2}}^{2}\right)\leq E\left[\max_{0\leq n\leq m}\mathbf{1}_{\tilde{\Omega}_{\kappa,n}}\|e^{n+1}\|_{\mathbb{L}^{2}}^{2}\right]\leq Ke^{Kt_{m}\kappa}\tau.$$

The proof is completed by letting m = M.

The following remark discusses uniqueness of solutions of (28) on 'large' subsets of  $\Omega$ , on subsets of which the error estimate in Theorem 1 is applied.

**Remark** 6: Let  $T \equiv t_M > 0$ , and  $\{\phi_j^n; 0 \le n \le M\}$ , j = 1, 2 be two solutions of (28), and denote  $\xi^n := \phi_1^n - \phi_2^n$ , as well as  $\xi^{n+\theta} := \theta \xi^{n+1} + (1-\theta) \xi^n$  to obtain

$$i\int_{\mathscr{O}}(\xi^{n+\theta}-\xi^n)zdx-\tau\theta\int_{\mathscr{O}}\nabla\xi^{n+\theta}\nabla zdx-\frac{\tau\theta}{2}\int_{\mathscr{O}}\mathscr{F}(\phi^n_j,\phi^{n+1}_j)zdx=\theta\int_{\mathscr{O}}\phi^{n+1/2}\Delta_nWzdx\qquad\forall z\in\mathbb{H}^1_0,$$

where

$$\mathscr{F}(\phi_j^n,\phi_j^{n+1}) := \left( |\phi_1^{n+1}|^2 + |\phi_1^n|^2 \right) \phi_1^{n+1/2} - \left( |\phi_2^{n+1}|^2 + |\phi_2^n|^2 \right) \phi_1^{n+1/2}$$

Then put  $z = \overline{\xi}^{n+\theta}$ , and take imaginary parts; by arguments which are similar to those in the proof of Theorem 1, and using the algebraic identities

$$\xi^{n+1/2} = \frac{1}{2\theta} \left( \xi^{n+\theta} + [2\theta - 1]\xi^n \right) \qquad \text{resp.} \qquad \xi^{n+1} = \frac{1}{\theta} \left( \xi^{n+\theta} - \xi^n \right) + \xi^n \,, \tag{58}$$

we arrive at

$$\frac{1}{2} \left( \|\xi^{n+\theta}\|_{\mathbb{L}^2}^2 - \|\xi^n\|_{\mathbb{L}^2}^2 + \|\xi^{n+\theta} - \xi^n\|_{\mathbb{L}^2}^2 \right) = I + \theta \Im \int_{\mathscr{O}} \xi^{n+1/2} \bar{\xi}^{n+\theta} \Delta_n W \, dx, \tag{59}$$

where

$$I = \frac{\tau\theta}{2}\Im \int_{\mathscr{O}} \left( |\phi_1^{n+1}|^2 + |\phi_1^n|^2 \right) \xi^{n+1/2} \bar{\xi}^{n+\theta} \, dx + \frac{\tau\theta}{2} \Im \int_{\mathscr{O}} \left( |\phi_1^{n+1}|^2 - |\phi_2^{n+1}|^2 + |\phi_1^n|^2 - |\phi_2^n|^2 \right) \phi_2^{n+\frac{1}{2}} \bar{\xi}^{n+\theta} \, dx$$
  
=:  $I_a + I_b$ .

We use (58) to compute for the last term in (59) that

$$\theta \Im \int_{\mathscr{O}} \xi^{n+1/2} \bar{\xi}^{n+\theta} \Delta_n W \, dx = \frac{2\theta - 1}{2} \Im \int_{\mathscr{O}} \xi^n \bar{\xi}^{n+\theta} \Delta_n W \, dx = \frac{2\theta - 1}{2} \Im \int_{\mathscr{O}} \xi^n (\bar{\xi}^{n+\theta} - \bar{\xi}^n) \Delta_n W \, dx$$

$$\leq \frac{1}{4} \| \bar{\xi}^{n+\theta} - \bar{\xi}^n \|_{\mathbb{L}^2}^2 + \left(\frac{2\theta - 1}{2}\right)^2 \| \xi^n \Delta_n W \|_{\mathbb{L}^2}^2. \tag{60}$$

For the first term  $I_a$  we have by (58)

$$\begin{aligned} \frac{\tau\theta}{2}\Im\int_{\mathscr{O}}\left[|\phi_{1}^{n+1}|^{2}+|\phi_{1}^{n}|^{2}\right]\xi^{n+1/2}\bar{\xi}^{n+\theta}\,dx &= \frac{\tau}{2}\Im\int_{\mathscr{O}}\left[|\phi_{1}^{n+1}|^{2}+|\phi_{1}^{n}|^{2}\right]\left(\frac{2\theta-1}{2\theta}\xi^{n}\right)\bar{\xi}^{n+\theta}\,dx \\ &= \frac{\tau(2\theta-1)}{4}\Im\int_{\mathscr{O}}\left[|\phi_{1}^{n+1}|^{2}+|\phi_{1}^{n}|^{2}\right]\xi^{n}(\bar{\xi}^{n+\theta}-\bar{\xi}^{n})\,dx.\end{aligned}$$

In order to estimate the term  $I_b$  we use again (58) to calculate for the relevant term

$$\begin{split} |\phi_1^{n+1}|^2 &- |\phi_2^{n+1}|^2 = \xi^{n+1} \bar{\phi}_1^{n+1} - \phi_2^{n+1} \bar{\xi}^{n+1} \\ &= \frac{1}{\theta} (\xi^{n+\theta} - \xi^n) \bar{\phi}_1^{n+1} + \xi^n \bar{\phi}_1^{n+1} - \frac{1}{\theta} (\bar{\xi}^{n+\theta} - \xi^n) \phi_2^{n+1} - \bar{\xi}^n \phi_2^{n+1}. \end{split}$$

We may then use  $\mathbb{H}^1(\mathscr{O}) \hookrightarrow \mathbb{L}^\infty(\mathscr{O})$  to estimate

$$I \leq K\tau^{2} \max_{1 \leq j \leq 2} \left( \|\phi_{j}^{n+1}\|_{\mathbb{H}^{1}}^{4} + \|\phi_{j}^{n}\|_{\mathbb{H}^{1}}^{4} \right) \|\xi^{n}\|_{\mathbb{L}^{2}}^{2} + \frac{1}{4} \|\xi^{n+\theta} - \xi^{n}\|_{\mathbb{L}^{2}}^{2} \\ + K\tau \max_{1 \leq j \leq 2} \left( \|\phi_{j}^{n+1}\|_{\mathbb{H}^{1}}^{2} + \|\phi_{j}^{n}\|_{\mathbb{H}^{1}}^{2} \right) \|\xi^{n+\theta} - \xi^{n}\|_{\mathbb{L}^{2}}^{2}.$$

Now multiply (59) with  $\mathbf{1}_{\widehat{\Omega}_{\kappa_{n+1}}}$ , where

$$\widehat{\Omega}_{\kappa,n+1} = \left\{ \omega \in \Omega \Big| \max_{0 \le \ell \le n+1} \| \phi^l \|_{\mathbb{H}^1}^2 \le \kappa \right\} \supset \tilde{\Omega}_{\kappa,n+1}.$$

Note that again  $\widehat{\Omega}_{\kappa,n+1} \subset \widehat{\Omega}_{\kappa,n}$ . We then obtain from the above considerations, for  $\kappa \leq \tau^{-\alpha}$  ( $\alpha < 1$ ) and  $\tau \leq \tau^*$  sufficiently small the estimate

$$\mathbf{1}_{\widehat{\Omega}_{\kappa,n+1}} \| \boldsymbol{\xi}^{n+\theta} \|_{\mathbb{L}^2}^2 \leq \mathbf{1}_{\widehat{\Omega}_{\kappa,n}} \| \boldsymbol{\xi}^n \|_{\mathbb{L}^2}^2 \Big( 1 + \Big(\frac{2\theta-1}{2}\Big)^2 \| \Delta_n W \|_{\mathbb{H}^1}^2 + K \tau^{2(1-\alpha)} \Big).$$
(61)

We may now proceed by induction: for n = 0 we have  $\xi^0 = 0$  *P*-a.s. on  $\widehat{\Omega}_{\kappa,0}$ , in particular. Therefore, we may deduce  $\theta^2 \mathbf{1}_{\widehat{\Omega}_{\kappa,1}} \|\xi^1\|_{\mathbb{L}^2}^2 = 0$ , and hence  $\xi^1 = 0$  on  $\widehat{\Omega}_{\kappa,1}$ . Correspondingly, we find

$$\mathbf{1}_{\widehat{\Omega}_{\kappa,n+1}} \| \boldsymbol{\xi}^{n+1} \|_{\mathbb{L}^2}^2 = 0 \quad P\text{-a.s.} \qquad (0 \le n \le M).$$

For  $\Omega_{\kappa} := \Omega_{\kappa,M}$ , (54) implies  $\lim_{\tau \to 0} P(\widehat{\Omega}_{\kappa}) = 1$  for  $\kappa \propto \log(\tau^{-\varepsilon})$  for every  $0 < \varepsilon < 1$ , and thus we retrieve uniqueness of solutions for the limiting problem (1) with  $\lambda = -1$ . — In the practical studies performed in Section VI we had that *all* simulations are included in  $\widehat{\Omega}_{\kappa}$  for some moderate  $\kappa = O(1)$ ; see Figure 2, (c).

# VI. NUMERICAL EXPERIMENTS

In the previous sections, we showed stability and convergence  $(\mathcal{O} \subset \mathbb{R}^d)$ , and convergence with local rates  $(\mathcal{O} \subset \mathbb{R}^1)$  for the  $\theta$ -scheme (28) and the defocusing nonlinearity ( $\lambda = -1$ ) in (1) with spatially regular noise. The following example is chosen to computationally study stability and rates of convergence for different values  $\theta_i \in \{\frac{1}{2}, \frac{1}{2} + \sqrt{\tau}, 1\}$  in the  $\theta$ -scheme (28) to solve the stochastic cubic Schrödinger equation ( $\lambda = -1$ ) with colored in space noise. In order to better clarify the interplay of nonlinearity and noise, we scale the noise in (1) and (28) by a parameter  $v \in \mathbb{R}$ .

*Example 1:* Let  $\mathscr{O} = (-1,1)$ ,  $T = \frac{1}{4}$ , and  $\psi_0(x) = \sin^2(\pi x)$ . For  $1 \le L \le 8$ , and  $\{\beta_\ell; 1 \le \ell \le L\}$  a family of independent  $\mathbb{R}$ -valued Wiener processes, consider the real-valued Wiener process  $W \equiv \{W_t; t \ge 0\}$ ,  $W(t) = \sum_{\ell=1}^{L} \frac{1}{\ell} \sin(\pi \ell x) \beta_\ell(t)$ , and  $v = \sqrt{2}$  in (1). We use the  $\theta$ -scheme (28) with values  $\theta_1 = \frac{1}{2}$ ,  $\theta_2 = \frac{1}{2} + \sqrt{\tau}$ , and  $\theta_3 = 1$  for the numerical approximation. Let  $I_{\tau} = \{t_n; 0 \le n \le M\}$  be the uniform discretization of [0, T] of size  $\tau > 0$ , and  $\mathscr{T}_h$  be the uniform triangulation of  $\mathscr{O}$  of size  $h = \frac{1}{256}$ , on which the lowest-order  $\mathbb{H}^1$ -conforming finite element discretization of (28) is realized. The reference values (for Figure 1 a) and b)) are generated for the smallest mesh size  $\tilde{\tau} = 2^{-14}$ . Newton's method is used, and 500 realizations are chosen to approximate the expectations.

We consider v = 0 first: Figure 1 a) shows order 2 for the  $\mathbb{L}^2$ -error of the  $\theta$ -scheme for  $\theta = \frac{1}{2}$ ; the order drops to 1.5 for  $\theta = \frac{1}{2} + \sqrt{\tau}$ , and to order 1 for the implicit Euler scheme ( $\theta = 1$ ). The observations

are different in the stochastic case ( $v = \sqrt{2}$ ) where different sorts of Wiener processes depending on *L* are used: as is displayed in Figure 1 c), the strong order of convergence for  $\theta \in \{\theta_1, \theta_2\}$  drops from approximately 1 to 0.5 for values 1 to 8 of *L*. The choice  $\theta = \theta_3$  is exceptional since we obtain the approximate order 0.5 for all values of *L*. Figure 1 b) compares typical trajectories for  $L \in \{1,4,8\}$ .

The box plot in Figure 2 c) complements this result: the set  $\widehat{\Omega}_{\kappa} := \{\max_{0 \le n \le M} \|\nabla \phi^n\|_{\mathbb{L}^2} \le \kappa\}$  is  $\Omega$  for values of  $\kappa$  exceeding approximately 6.5. Figures 2 a), b) study the conservation of mass for the three schemes: we observe a mild decrease for  $\theta = \frac{1}{2} + \sqrt{\tau}$ , which is far more pronounced for  $\theta = 1$ .
