STRONG CONVERGENCE THEOREMS OF WALSH-FEJÉR MEANS

Abstract. As main result we prove that Fejér means of Walsh-Fourier series are uniformly bounded operators from H_p to H_p ($0 < p \leq 1/2$).

1. INTRODUCTION

It is well-known that Walsh-Paley system forms not basis in the space $L_1(G)$. Moreover, there is a function in the dyadic Hardy space $H_1(G)$, such that the partial sums of F are not bounded in L_1 -norm. However, in Simon [\[19\]](#page-14-0) the following estimation was obtained for all $F \in H_1(G)$:

\frac{1}{\log n} \sum_{k=1}^{n} \frac{\|S_k F\|_1}{k} \le c \, \|F\|_{H_1} \,,
$$

where S_kF denotes the k-th partial sum of the Walsh-Fourier series of F. (For the trigonometric analogue see in Smith [\[21\]](#page-14-1), for the Vilenkin system in Gát [\[5\]](#page-13-0)). Simon [\[18\]](#page-14-2) (see also [\[20\]](#page-14-3) and [\[28\]](#page-14-4)) proved that there is an absolute constant c_p , depending only on p, such that

\frac{1}{\log^{[p]} n} \sum_{k=1}^n \frac{\|S_k F\|_p^p}{k^{2-p}} \le c_p \|F\|_{H_p}^p, \quad (0 < p \le 1),
$$

for all $F \in H_p$, where $[p]$ denotes integer part of p.

Weisz [\[30\]](#page-14-5) considered the norm convergence of Fejér means of Walsh-Fourier series and proved the following:

Theorem W1 (Weisz). Let $p > 1/2$ and $F \in H_p$. Then

$$
\|\sigma_k F\|_{H_p} \leq c_p \|F\|_{H_p}.
$$

This theorem implies that

$$
\frac{1}{n^{2p-1}}\!\sum_{k=1}^n \!\frac{\|\sigma_k F\|_{H_p}^p}{k^{2-2p}} \leq c_p \, \|F\|_{H_p}^p\,, \qquad (1/2 < p < \infty)\,.
$$

If Theorem W1 holds for $0 < p \leq 1/2$, then we would have

(2)
$$
\frac{1}{\log^{[1/2+p]} n} \sum_{k=1}^n \frac{\|\sigma_k F\|_{H_p}^p}{k^{2-2p}} \le c_p \|F\|_{H_p}^p, \qquad (0 < p \le 1/2).
$$

However, Goginava [\[10\]](#page-14-6) (see also [\[22\]](#page-14-7)) proved that the assumption $p > 1/2$ in Theorem W1 is essential. In particular, the following is true:

Theorem G (Goginava). Let $0 < p \leq 1/2$. Then there exists a martingale $F \in H_p$, such that

$$
\sup_{n} \|\sigma_n F\|_p = +\infty.
$$

As main result we prove that [\(2\)](#page-1-0) holds, though Theorem W1 is not true for $0 < p \leq 1/2$.

The results for summability of Fejér means of Walsh-Fourier series can be found in [\[3,](#page-13-1) [4\]](#page-13-2), [\[7,](#page-13-3) [8\]](#page-14-8), [\[12\]](#page-14-9), [\[14,](#page-14-10) [16\]](#page-14-11), [\[23,](#page-14-12) [27\]](#page-14-13).

2. Definitions and Notations

Let \mathbb{N}_+ denote the set of the positive integers, $\mathbb{N} := \mathbb{N}_+ \cup \{0\}$. Denote by Z_2 the discrete cyclic group of order 2, that is $Z_2 := \{0, 1\}$, where the group operation is the modulo 2 addition and every subset is open. The Haar measure on Z_2 is given so that the measure of a singleton is $1/2$.

Define the group G as the complete direct product of the group Z_2 with the product of the discrete topologies of Z_2 's.

The elements of G represented by sequences

x := (x_0, x_1, ..., x_j, ...)
$$
 $(x_k = 0, 1).$

It is easy to give a base for the neighborhood of G

$$
I_{0}\left(x\right) :=G,
$$

$$
I_n(x) := \{ y \in G \mid y_0 = x_0, ..., y_{n-1} = x_{n-1} \} \ (x \in G, \ n \in \mathbb{N}).
$$

Denote $I_n := I_n(0)$ for $n \in \mathbb{N}$ and $\overline{I_n} := G \setminus I_n$.

Let

$$
e_n := (0, ..., 0, x_n = 1, 0, ...) \in G \qquad (n \in \mathbb{N}).
$$

It is evident

(3)
$$
\overline{I_M} = \left(\bigcup_{k=0}^{M-2} \bigcup_{l=k+1}^{M-1} I_{l+1} (e_k + e_l) \right) \bigcup \left(\bigcup_{k=0}^{M-1} I_M (e_k) \right).
$$

If $n \in \mathbb{N}$, then every n can be uniquely expressed as $n = \sum_{k=0}^{\infty} n_j 2^j$ where $n_j \in Z_2 \quad (j \in \mathbb{N})$ and only a finite number of n_j 's differ from zero. Let $|n| := \max \{j \in \mathbb{N}, n_j \neq 0\},\$ that is $2^{|n|} \le n \le 2^{|n|+1}$.

Define the variation of an $n \in \mathbb{N}$ with binary coefficients $(n_k, k \in \mathbb{N})$ by

V(n) = n_0 + \sum_{k=1}^{\infty} |n_k - n_{k-1}|.
$$

For
$$
n = \sum_{i=1}^{s} 2^{n_i}
$$
, $n_1 < n_2 < ... < n_s$ we denote

$$
n^{(i)} = 2^{n_1} + \dots + 2^{n_{i-1}}, \quad i = 2, \dots, s
$$

and

$$
\mathbb{A}_{0,2} = \left\{ n \in \mathbb{N} : n = 2^0 + 2^2 + \sum_{i=3}^{s_n} 2^{n_i} \right\}.
$$

For every $n \in \mathbb{N}$ there exists numbers $0 \leq l_1 \leq m_1 \leq l_2 - 2 < l_2 \leq$ $m_2 \leq ... \leq l_s - 2 < l_s \leq m_s$ such that it can be uniquely expressed as $n = \sum_{i=1}^{s} \sum_{k=l_i}^{m_i} 2^k$, where s is depending only on n. It is easy to show that $s \le V(n) \le 2s + 1.$

Define k-th Rademacher functions as

$$
r_k(x) := (-1)^{x_k} \qquad (x \in G, k \in \mathbb{N}).
$$

Now, define the Walsh system $w := (w_n : n \in \mathbb{N})$ on G in the following way:

$$
w_n(x) := \prod_{k=0}^{\infty} r_k^{n_k}(x) = r_{|n|}(x) (-1)^{\sum_{k=0}^{|n|-1} n_k x_k} \qquad (n \in \mathbb{N}).
$$

The Walsh system is orthonormal and complete in $L_2(G)$ (see [\[13\]](#page-14-14)).

If $f \in L_1(G)$ we can establish the Fourier coefficients, the partial sums of the Fourier series, the Fejér means, the Dirichlet and Fejér kernels in the usual manner:

\hat{f}(k) := \int_G f w_k d\mu \qquad (k \in \mathbb{N}),
$$

\n

S_n f := \sum_{k=0}^{n-1} \hat{f}(k) w_k \qquad (n \in \mathbb{N}_+, S_0 f := 0),
$$

\n
$$
\sigma_n f := \frac{1}{n} \sum_{k=1}^n S_k f \qquad (n \in \mathbb{N}_+),
$$

\n
$$
D_n := \sum_{k=0}^{n-1} w_k \qquad (n \in \mathbb{N}_+),
$$

\n
$$
K_n := \frac{1}{n} \sum_{k=1}^n D_k \qquad (n \in \mathbb{N}_+).
$$

Recall that

(4)
$$
D_{2^n}(x) = \begin{cases} 2^n, & \text{if } x \in I_n, \\ 0, & \text{if } x \notin I_n. \end{cases}
$$

Let $n \in \mathbb{N}$. Then (see [\[13\]](#page-14-14))

(5)
$$
\frac{1}{8}V(n) \leq ||D_n||_1 \leq V(n).
$$

It is well-known that (see [\[11,](#page-14-15) [13\]](#page-14-14))

(6)
$$
\sup_{n} \int_{G} |K_{n}(x)| d\mu(x) \leq c < \infty
$$

and

(7)
$$
nK_n = \sum_{r=1}^s \left(\prod_{j=r+1}^s w_{2^{n_j}} \right) 2^{n_r} K_{2^{n_r}} + \sum_{t=2}^s \left(\prod_{j=t+1}^s w_{2^{n_j}} \right) n^{(t)} D_{2^{n_t}},
$$

for $n = \sum_{i=1}^{s} 2^{n_i}$, $n_1 < n_2 < ... < n_s$.

For 2^n -th Fejér kernel we have following equality:

(8)

K_{2^n}(x) = \begin{cases} 2^{t-1}, & \text{if } x \in I_n(e_t), \\ \frac{2^n + 1}{2}, & \text{if } x \in I_n, \\ 0, & \text{otherwise.} \end{cases}
$$

for $n > t$ and $t, n \in \mathbb{N}$, (see [\[6\]](#page-13-4)).

The norm (or quasinorm) of the space $L_p(G)$ is defined by

$$
||f||_p := \left(\int_G |f|^p \, d\mu\right)^{1/p} \qquad (0 < p < \infty).
$$

The space $L_{p,\infty}(G)$ consists of all measurable functions f for which

$$
||f||_{L_{p,\infty}} := \sup_{\lambda>0} \lambda \mu (f > \lambda)^{1/p} < +\infty.
$$

The σ −algebra generated by the intervals $\{I_n(x): x \in G\}$ will be denoted by \mathcal{F}_n ($n \in \mathbb{N}$). The conditional expectation operators relative to \mathcal{F}_n ($n \in \mathbb{N}$) are denoted by E_n .

A sequence $F = (F_n, n \in \mathbb{N})$ of functions $F_n \in L_1(G)$ is said to be a dyadic martingale if (for details see e.g. [\[13\]](#page-14-14))

(i) F_n is F_n measurable for all $n \in \mathbb{N}$,

(*ii*) $E_n F_m = F_n$ for all $n \leq m$.

The maximal function of a martingale F is defined by

$$
F^* = \sup_{n \in \mathbb{N}} |F_n| \, .
$$

In case $f \in L_1(G)$, the maximal functions are also be given by

$$
f^{*}(x) = \sup_{n \in \mathbb{N}} \frac{1}{\mu(I_{n}(x))} \left| \int_{I_{n}(x)} f(u) d\mu(u) \right|.
$$

For $0 < p < \infty$ the Hardy martingale spaces $H_p(G)$ consist of all martingale for which

$$
\|F\|_{H_p}:=\|F^*\|_p<\infty.
$$

A bounded measurable function a is p-atom, if there exist a dyadic interval I, such that

$$
\begin{cases}\n a) & \int_I ad\mu = 0, \\
 b) & \|a\|_{\infty} \leq \mu (I)^{-1/p}, \\
 c) & \text{supp } (a) \subset I.\n\end{cases}
$$

The dyadic Hardy martingale spaces $H_p(G)$ for $0 < p \leq 1$ have an atomic characterization. Namely the following theorem is true (see [\[17\]](#page-14-16) and [\[27\]](#page-14-13)):

Theorem W2: A martingale $F = (F_n, n \in \mathbb{N})$ is in $H_p (0 < p \le 1)$ if and only if there exists a sequence $(a_k, k \in \mathbb{N})$ of p-atoms and a sequence $(\mu_k, k \in \mathbb{N})$ of a real numbers such that for every $n \in \mathbb{N}$

(9)
$$
\sum_{k=0}^{\infty} \mu_k S_{2^n} a_k = F_n
$$

and

$$
\sum_{k=0}^{\infty} |\mu_k|^p < \infty,
$$

Moreover, $||F||_{H_p} \backsim \inf \left(\sum_{k=0}^{\infty} |\mu_k|^p \right)^{1/p}$, where the infimum is taken over all decomposition of F of the form (9) .

It is easy to check that for every martingale $F = (F_n, n \in \mathbb{N})$ and every $k \in \mathbb{N}$ the limit

$$
\widehat{F}(k) := \lim_{n \to \infty} \int_G F_n(x) w_k(x) d\mu(x)
$$

exists and it is called the k-th Walsh-Fourier coefficients of F.

If $F := (E_n f : n \in \mathbb{N})$ is regular martingale generated by $f \in L_1(G)$, then

$$
\widehat{F}(k) = \int_G f(x) w_k(x) d\mu(x) = \widehat{f}(k), \ k \in \mathbb{N}.
$$

For the martingale

$$
F = \sum_{n=0}^{\infty} (F_n - F_{n-1})
$$

the conjugate transforms are defined as

$$
\widetilde{F^{(t)}} = \sum_{n=0}^{\infty} r_n(t) (F_n - F_{n-1}),
$$

where $t \in G$ is fixed. Note that $\widetilde{F^{(0)}} = F$. As is well known (see [\[30\]](#page-14-5))

(11)
$$
\left\| \widetilde{F^{(t)}} \right\|_{H_p} = \left\| F \right\|_{H_p}
$$

and

(12)
$$
||F||_{H_p}^p \sim \int_G \left\| \widetilde{F^{(t)}} \right\|_p^p dt.
$$

3. Formulation of Main Results

Theorem 1. a) Let $0 < p \leq 1/2$. Then there exists absolute constant c_p , depending only on p, such that

$$
\frac{1}{\log^{[1/2+p] } n} \sum_{m=1}^n \frac{\|\sigma_m F\|_{H_p}^p}{m^{2-2p}} \leq c_p \left\|F\right\|_{H_p}^p.
$$

b) Let $0 < p < 1/2$ and $\Phi : \mathbb{N}_+ \to [1, \infty)$ is any nondecreasing function, satisfying the conditions $\Phi(n) \uparrow \infty$ and

$$
\overline{\lim_{k \to \infty}} \frac{2^{k(2-2p)}}{\Phi(2^k)} = \infty.
$$

Then there exists a martingale $F \in H_p$, such that

$$
\sum_{m=1}^{\infty}\frac{\left\Vert \sigma _{m}F\right\Vert _{L_{p,\infty}}^{p}}{\Phi\left(m\right)}=\infty.
$$

Theorem 2. Let $F \in H_{1/2}$. Then

$$
\sup_{n\in\mathbb{N}_+}\sup_{\|F\|_{H_p}\le 1}\frac{1}{n}\sum_{m=1}^n\|\sigma_mF\|_{1/2}^{1/2}=\infty.
$$

4. AUXILIARY PROPOSITIONS

Lemma 1. [\[29\]](#page-14-17) Suppose that an operator T is sublinear and for some $0 <$ $p\leq 1$

$$
\int\limits_{\overline{I}} |Ta|^p \, d\mu \le c_p < \infty,
$$

for every p-atom a, where I denote the support of the atom. If T is bounded from L_{∞} to L_{∞} , then

$$
||TF||_p \leq c_p ||F||_{H_p}.
$$

Lemma 2. [\[9\]](#page-14-18) Let $x \in I_{l+1}$ $(e_k + e_l)$, $k = 0, ..., M-2$, $l = 0, ..., M-1$. Then

$$
\int_{I_M} |K_n(x+t)| d\mu(t) \le \frac{c2^{l+k}}{n2^M}, \quad \text{for} \ \ n > 2^M.
$$

Let $x \in I_M(e_k)$, $m = 0, ..., M - 1$. Then

$$
\int_{I_M} |K_n(x+t)| d\mu(t) \le \frac{c2^k}{2^M}, \quad \text{for} \quad n > 2^M.
$$

The next estimation of Fejér kernel is generalized of Lemma 2 in [\[1\]](#page-13-5) (see also [\[2\]](#page-13-6)).

Lemma 3. Let $n = \sum_{i=1}^{s} \sum_{k=l_i}^{m_i} 2^k$, where $0 \leq l_1 \leq m_1 \leq l_2 - 2 < l_2 \leq$ $m_2 \leq \ldots \leq l_s - 2 < l_s \leq m_s$. Then

n |K_n(x)| \ge \frac{2^{2l_i}}{16}
$$
, for $x \in I_{l_i+1}(e_{l_i-1} + e_{l_i})$.

Proof: From (7) we have

$$
nK_n = \sum_{r=1}^{s} \sum_{k=l_r}^{m_r} \left(\prod_{j=r+1}^{s} \prod_{q=l_j}^{m_j} w_{2q} \prod_{j=k+1}^{m_r} w_{2j} \right) 2^k K_{2^k}
$$

+
$$
\sum_{r=1}^{s} \sum_{k=l_r}^{m_r} \left(\prod_{j=r+1}^{s} \prod_{q=l_j}^{m_j} w_{2q} \prod_{j=k+1}^{m_r} w_{2j} \right) \left(\sum_{t=1}^{r-1} \sum_{q=l_t}^{m_t} 2^q + \sum_{q=l_r}^{k-1} 2^q \right) D_{2^k}.
$$

Let $x \in I_{l_i+1}(e_{l_i-1}+e_{l_i})$. Then

$$
n |K_n| \ge \left| 2^{l_i} K_{2^{l_i}} \right| - \sum_{r=1}^{i-1} \sum_{k=l_r}^{m_r} \left| 2^k K_{2^k} \right| - \sum_{r=1}^{i-1} \sum_{k=l_r}^{m_r} \left| 2^k D_{2^k} \right| = I - II - III.
$$

Using [\(8\)](#page-3-1) we have

(13)
$$
I = \left| 2^{l_i} K_{2^{l_i}}(x) \right| = \frac{2^{2l_i}}{4}.
$$

Since $m_{i-1} \leq l_i - 2$ we obtain that

(14)
$$
II \leq \sum_{n=0}^{l_i-2} |2^n K_{2^n}(x)| \leq \sum_{n=0}^{l_i-2} 2^n \frac{(2^n+1)}{2} \leq \frac{2^{2l_i}}{24} + \frac{2^{l_i}}{4} - \frac{2}{3}.
$$

For III we have

(15)
$$
III \leq \sum_{k=0}^{l_i-2} \left| 2^k D_{2^k}(x) \right| \leq \sum_{k=0}^{l_i-2} 4^k = \frac{2^{2l_i}}{12} - \frac{1}{3}.
$$

Combining [\(13](#page-6-0)[-15\)](#page-6-1) we have

(16)
$$
n |K_n(x)| \geq I - II - III \geq \frac{2^{2l_i}}{8} - \frac{2^{l_i}}{4} + 1.
$$

Suppose that $l_i \geq 2$. Then

$$
n |K_n(x)| \ge \frac{2^{2l_i}}{8} - \frac{2^{2l_i}}{16} \ge \frac{2^{2l_i}}{16}.
$$

If $l_i = 0$ or $l_i = 1$ using [\(16\)](#page-6-2) we have

$$
n |K_n(x)| \ge \frac{7}{8} \ge \frac{2^{2l_i}}{16}.
$$

Lemma 3 is proved.

5. Proof of the Theorems

Proof of Theorem 1. Suppose that

$$
\frac{1}{\log^{[1/2+p] } n} \sum_{m=1}^n \frac{\|\sigma_m F\|_p^p}{m^{2-2p}} \leq c_p \, \|F\|_{H_p}^p \, .
$$

Combining [\(11\)](#page-4-1) and [\(12\)](#page-5-0) we have

(17)

\frac{1}{\log^{[1/2+p]} n} \sum_{m=1}^{n} \frac{\|\sigma_m F\|_{H_p}^p}{m^{2-2p}}
$$
\n
$$
= \frac{1}{\log^{[1/2+p]} n} \sum_{m=1}^{n} \frac{\int_G \left\|\widehat{\sigma_m F^{(t)}}\right\|_p^p dt}{m^{2-2p}}
$$
\n
$$
= \frac{1}{\log^{[1/2+p]} n} \sum_{m=1}^{n} \frac{\int_G \left\|\widehat{\sigma_m F^{(t)}}\right\|_p^p dt}{m^{2-2p}}
$$
\n
$$
= \int_G \frac{1}{\log^{[1/2+p]} n} \sum_{m=1}^{n} \frac{\left\|\widehat{\sigma_m F^{(t)}}\right\|_p^p}{m^{2-2p}} dt
$$
\n
$$
\leq c_p \int_G \left\|\widehat{F^{(t)}}\right\|_{H_p}^p dt \sim c_p \int_G \left\|F\right\|_{H_p}^p dt = c_p \left\|F\right\|
$$

By Lemma [1](#page-5-1) and [\(17\)](#page-7-0) the proof of theorem 1 will be complete, if we show that

\frac{1}{\log^{[1/2+p] } n} \!\!\sum_{m=1}^{n} \!\frac{\|\sigma_m a\|_p^p}{m^{2-2p}} \leq c < \infty, \quad \ m=1,2,\ldots
$$

for every p-atom a. We may assume that a be an arbitrary p-atom with support I, $\mu(I) = 2^{-M}$ and $I = I_M$. It is easy to see that $\sigma_n(a) = 0$, when $n \leq 2^M$. Therefore we can suppose that $n > 2^M$.

Let $x \in I_M$. Since σ_n is bounded from L_∞ to L_∞ (the boundedness follows from [\(6\)](#page-3-2)) and $||a||_{\infty} \le 2^{M/p}$ we obtain

\int_{I_M} |\sigma_m a(x)|^p d\mu(x) \le ||\sigma_m a||^p_{\infty}/2^M \le c < \infty, \ 0 < p \le 1/2.
$$

Let $0 < p \leq 1/2.$ Hence

$$
\frac{1}{\log^{\left[1/2+p \right]} n} \sum_{m=1}^{n} \frac{\int_{I_{M}} \left| \sigma_{m} a\left(x \right) \right|^{p} d\mu \left(x \right)}{m^{2-2p}} \leq \frac{c}{\log^{\left[1/2+p \right]} n} \sum_{m=1}^{n} \frac{1}{m^{2-2p}} \leq c < \infty.
$$

It is easy to show that

$$
|\sigma_{m} a(x)| \leq \int_{I_{M}} |a(t)| \, |K_{m}(x+t)| \, d\mu(t) \leq 2^{M/p} \int_{I_{M}} |K_{m}(x+t)| \, d\mu(t).
$$

From Lemma [2](#page-5-2) we get

(18)

|\sigma_m a(x)| \le \frac{c2^{k+l} 2^{M(1/p-1)}}{m}, \quad x \in I_{l+1}(e_k + e_l), 0 \le k < l < M,
$$

and

(19)
$$
|\sigma_m a(x)| \le c 2^{M(1/p-1)} 2^k, \ \ x \in I_M(e_k), \ 0 \le k < M.
$$

Combining [\(3\)](#page-1-1) and [\(18](#page-8-0)[-19\)](#page-8-1) we obtain

(20) \quad \int_{\overline{I_M}} |\sigma_m a(x)|^p d\mu(x)
$$

= \sum_{k=0}^{M-2} \sum_{l=k+1}^{M-1} \int_{I_{l+1}(e_k+e_l)} |\sigma_m a(x)|^p d\mu(x) + \sum_{k=0}^{M-1} \int_{I_M(e_k)} |\sigma_m a(x)|^p d\mu(x)
$$

\n
$$
\leq c \sum_{k=0}^{M-2} \sum_{l=k+1}^{M-1} \frac{1}{2^l} \frac{2^{p(k+l)} 2^{M(1-p)}}{m^p} + c \sum_{k=0}^{M-1} \frac{1}{2^M} 2^{M(1-p)} 2^{pk}
$$

\n
$$
\leq \frac{c 2^{M(1-p)}}{m^p} \sum_{k=0}^{M-2} \sum_{l=k+1}^{M-1} \frac{2^{p(k+l)}}{2^l} + c \sum_{k=0}^{M-1} \frac{2^{pk}}{2^{pM}}
$$

\n
$$
\leq \frac{c 2^{M(1-p)} M^{[1/2+p]}}{m^p} + c.
$$

Hence

$$
\begin{array}{lcl} \displaystyle \frac{1}{\log^{[1/2+p]} n} \displaystyle \sum_{m=2^{M}+1}^{n} \frac{\int_{\overline{I_{M}}} \left|\sigma_{m} a\left(x\right)\right|^{p} d\mu\left(x\right)}{m^{2-2p}} \\ \leq & \displaystyle \frac{1}{\log^{[1/2+p]} n} \left(\displaystyle \sum_{m=2^{M}+1}^{n} \frac{c2^{M\left(1-p\right)} M^{[1/2+p]}}{m^{2-p}} + \displaystyle \sum_{m=2^{M}+1}^{n} \frac{c}{m^{2-2p}} \right) < c < \infty. \end{array}
$$

Which complete the proof of first part of Theorem 1.

Now we proof second part of Theorem 1. Let $\Phi(n)$ is nondecreasing function, satisfying condition

\lim_{k \to \infty} \frac{2^{(|n_k|+1)(2-2p)}}{\Phi(2^{|n_k|+1})} = \infty.

Under condition [\(21\)](#page-9-0), there exists a sequence $\{\alpha_k: k \geq 0\} \subset \{n_k: k \geq 0\}$ such that

\sum_{\eta=0}^{\infty} \frac{\Phi^{1/2} (2^{|\alpha_{\eta}|+1})}{2^{|\alpha_{\eta}|(1-p)}} = 2^{1-p} \sum_{\eta=0}^{\infty} \frac{\Phi^{1/2} (2^{|\alpha_{\eta}|+1})}{2^{(|\alpha_{\eta}|+1)(1-p)}} < c < \infty.
$$

Let

F_n = \sum_{\{k: |\alpha_k| < n\}} \lambda_k a_k,
$$

where

\lambda_k = \frac{\Phi^{1/2p} (2^{|\alpha_k|+1})}{2^{(|\alpha_k|)(1/p-1)}}
$$

and

$$
a_k=2^{|\alpha_k|(1/p-1)}\left(D_{2^{|\alpha_k|+1}}-D_{2^{|\alpha_k|}}\right).
$$

It is easy to show that the martingale $F = (F_n, n \in \mathbb{N}) \in H_p$. Indeed, since

S_{2^n} a_k = \begin{cases} a_k, & |\alpha_k| < n, \\ 0, & |\alpha_k| \ge n, \end{cases}
$$

\text{supp}(a_k) = I_{|\alpha_k|},
$$

$$
\int_{I_{|\alpha_k|}} a_k d\mu = 0
$$

and

$$
||a_k||_{\infty} \le 2^{|\alpha_k|/p} = (\text{supp } a_k)^{-1/p}
$$

if we apply Theorem W2 and [\(23\)](#page-9-1) we conclude that $F \in H_p$. It is easy to show that

= \begin{cases}\n\Phi^{1/2p} (2^{|\alpha_k|+1}), & \text{if } j \in \{2^{|\alpha_k|}, ..., 2^{|\alpha_k|+1}-1\}, k = 0, 1, 2..., \\
0, & \text{if } j \notin \bigcup_{k=0}^{\infty} \{2^{|\alpha_k|}, ..., 2^{|\alpha_k|+1}-1\}.\n\end{cases}
$$

Let $2^{|\alpha_k|} < n < 2^{|\alpha_k|+1}$. Using [\(24\)](#page-9-2) we can write

Suppose that $2^{|\alpha_s|} < j \leq 2^{|\alpha_s|+1}$, for some $s = 1, 2, ..., k$. Then applying [\(24\)](#page-9-2) we have

= \sum_{\eta=0}^{s-1} \sum_{\substack{v=2^{|\alpha_{\eta}|+1}-1\\v=2^{|\alpha_{\eta}|}}}^{j-1} \widehat{F}(v)w_v + \sum_{\substack{v=2^{|\alpha_{s}|}\\v=2^{|\alpha_{s}|}}}^{j-1} \widehat{F}(v)w_v
$$

\n

= \sum_{\eta=0}^{s-1} \sum_{\substack{v=2^{|\alpha_{\eta}|+1}-1\\v=2^{|\alpha_{\eta}|}}}^{j-1} \Phi^{1/2p} (2^{|\alpha_{\eta}|+1}) w_v + \Phi^{1/2p} (2^{|\alpha_{s}|+1}) \sum_{\substack{v=2^{|\alpha_{s}|}\\v=2^{|\alpha_{s}|}}}^{j-1} w_v
$$

\n
$$
= \sum_{\eta=0}^{s-1} \Phi^{1/2p} (2^{|\alpha_{\eta}|+1}) (D_{2^{|\alpha_{\eta}|+1}} - D_{2^{|\alpha_{\eta}|}})
$$

\n
$$
+ \Phi^{1/2p} (2^{|\alpha_{s}|+1}) (D_{j} - D_{2^{|\alpha_{s}|}}).
$$

Let $2^{|\alpha_s|+1} \leq j \leq 2^{|\alpha_{s+1}|}, s = 0, 1, ...k-1$. Analogously of [\(27\)](#page-10-0) we get

(28)

S_j F = \sum_{v=0}^{2^{|\alpha_s|+1}} \widehat{F}(v) w_v = \sum_{\eta=0}^s \Phi^{1/2p} \left(2^{|\alpha_\eta|+1} \right) \left(D_{2^{|\alpha_\eta|+1}} - D_{2^{|\alpha_\eta|}} \right).
$$

Let $x \in I_2(e_0 + e_1)$. Since (see [\(4\)](#page-2-0) and [\(8\)](#page-3-1))

D_{2^n}(x) = K_{2^n}(x) = 0, \text{ for } n \ge 2,
$$

from (22) and $(27-28)$ $(27-28)$ we obtain

III = \frac{1}{n} \sum_{\eta=0}^{k-1} \Phi^{1/2p} \left(2^{|\alpha_{\eta}|+1} \right) \sum_{v=2^{|\alpha_{\eta}|+1}}^{2^{|\alpha_{\eta}|+1}} D_v(x)

= \frac{1}{n} \sum_{\eta=0}^{k-1} \Phi^{1/2p} \left(2^{|\alpha_{\eta}|+1} \right) \left(2^{|\alpha_{\eta}|+1} K_{2^{|\alpha_{\eta}|+1}} \left(x \right) - 2^{|\alpha_{\eta}|} K_{2^{|\alpha_{\eta}|}} \left(x \right) \right) = 0.
$$

Applying [\(27\)](#page-10-0), when $s = k$ in IV we have

IV = \frac{n - 2^{|\alpha_k|}}{n} \sum_{\eta=0}^{k-1} \Phi^{1/2p} \left(2^{|\alpha_{\eta}|+1} \right) \left(D_{2^{|\alpha_{\eta}|+1}} - D_{2^{|\alpha_{\eta}|}} \right) + \frac{\Phi^{1/2p} \left(2^{|\alpha_k|+1} \right)}{n} \sum_{j=2^{|\alpha_k|}+1}^{n} \left(D_j - D_{2^{|\alpha_k|}} \right) = IV_1 + IV_2.
$$

Combining [\(22\)](#page-9-3) and [\(29\)](#page-10-2) we get

IV_1 = 0, \text{ for } x \in I_2(e_0 + e_1).
$$

Let $\alpha_k \in \mathbb{A}_{0,2}$, $2^{|\alpha_k|} < n < 2^{|\alpha_k|+1}$ and $x \in I_2(e_0 + e_1)$. Since $n - 2^{|\alpha_k|} \in$ $\mathbb{A}_{0,2}$ and

D_{j+2^m} = D_{2^m} + w_{2^m} D_j, \text{ when } j < 2^m
$$

from [\(7\)](#page-3-0) and [\(29\)](#page-10-2) we obtain

|IV_2| = \frac{\Phi^{1/2p} (2^{|\alpha_k|+1})}{n} \left| \sum_{j=1}^{n-2^{|\alpha_k|}} \left(D_{j+2^{|\alpha_k|}}(x) - D_{2^{|\alpha_k|}}(x) \right) \right|
$$

$$
= \frac{\Phi^{1/2p} (2^{|\alpha_k|+1})}{n} \left| \sum_{j=1}^{n-2^{|\alpha_k|}} D_j(x) \right|
$$

=
$$
\frac{\Phi^{1/2p} (2^{|\alpha_k|+1})}{n} |(n-2^{|\alpha_k|}) K_{n-2^{|\alpha_k|}} (x)| \ge \frac{\Phi^{1/2p} (2^{|\alpha_k|+1})}{2^{|\alpha_k|+1}}.
$$

Let $0 < p < 1/2$ and $n \in \mathbb{A}_{0,2}.$ Combining [\(25-](#page-10-3)[34\)](#page-11-0) we have

\geq \frac{c_p \Phi^{1/2} (2^{|\alpha_k|+1})}{2^{p(|\alpha_k|+1)}} \mu \left\{ x \in I_2(e_0 + e_1) : |\sigma_n F| \geq \frac{c_p \Phi^{1/2p} (2^{|\alpha_k|+1})}{2^{|\alpha_k|+1}} \right\}
$$

\n

\geq \frac{c_p \Phi^{1/2} (2^{|\alpha_k|+1})}{2^{p(|\alpha_k|+1)}} \mu \left\{ I_2(e_0 + e_1) \right\} \geq \frac{c_p \Phi^{1/2} (2^{|\alpha_k|+1})}{2^{p(|\alpha_k|+1)}}.
$$

Hence

\sum_{n=1}^{\infty} \frac{\|\sigma_n F\|_{L_{p,\infty}}^p}{\Phi(n)} \ge \sum_{\begin{cases} n \in \mathbb{A}_{0,2}: 2^{|\alpha_k|} < n < 2^{|\alpha_k|+1} \\ n \in \mathbb{A}_{0,2}: 2^{|\alpha_k|} < n < 2^{|\alpha_k|+1} \end{cases}} \frac{\|\sigma_n F\|_{L_{p,\infty}}^p}{\Phi(n)}

\ge \frac{1}{\Phi^{1/2} (2^{|\alpha_k|+1})} \sum_{\begin{subarray}{c} n \in \mathbb{A}_{0,2}: 2^{|\alpha_k|} < n < 2^{|\alpha_k|+1} \end{subarray}} \frac{1}{2^{p(|\alpha_k|+1)}} \ge \frac{c_p 2^{(1-p)(|\alpha_k|+1)}}{\Phi^{1/2} (2^{|\alpha_k|+1)}} \to \infty, \quad \text{when} \quad k \to \infty.
$$

Which complete the proof of Theorem 1. Proof of Theorem 2. Let

F_m = 2^m \left(D_{2^m + 1} - D_{2^m} \right).
$$

It is evident

(36)

\widehat{F}_m(i) = \begin{cases} 2^m, & \text{if } i = 2^m, ..., 2^{m+1} - 1, \\ 0, & \text{otherwise.} \end{cases}
$$

We can write

S_i F_m = \begin{cases} 2^m (D_i - D_{2^m}), & \text{if } i = 2^m + 1, ..., 2^{m+1} - 1, \\ F_m, & \text{if } i \ge 2^{m+1}, \\ 0, & \text{otherwise.} \end{cases}
$$

From [\(4\)](#page-2-0) we get

||F_m||_{H_{1/2}} = ||\sup_{k \in \mathbb{N}} |S_{2^k}F_m||_{1/2} = 2^m ||D_{2^m+1} - D_{2^m}||_{1/2}
$$

$$
= 2^m ||D_{2^m}||_{1/2} \le 1.
$$

Let $0 < n < 2^m$. Using [\(33\)](#page-11-1) we obtain

|\sigma_{n+2^m} F_m| = \frac{1}{n+2^m} \left| \sum_{j=2^m+1}^{n+2^m} S_j F_m \right|
$$

$$
= \frac{1}{n+2^m} \left| 2^m \sum_{j=2^m+1}^{n+2^m} (D_j - D_{2^m}) \right|
$$

$$
= \frac{1}{n+2^m} \left| 2^m \sum_{j=1}^n (D_{j+2^m} - D_{2^m}) \right|
$$

$$
= \frac{1}{n+2^m} \left| 2^m \sum_{j=1}^n D_j \right| = \frac{2^m}{n+2^m} n |K_n|.
$$

Let $n = \sum_{i=1}^{s} \sum_{k=l_i}^{m_i} 2^k$, where $0 \leq l_1 \leq m_1 \leq l_2 - 2 < l_2 \leq m_2 \leq ... \leq$ $l_s - 2 < l_s \leq m_s$. Combining Lemma [3](#page-6-3) and [\(39\)](#page-12-0) we write

|\sigma_{n+2^m} F_m(x)| \ge c2^{2l_i}, \quad \text{for } x \in I_{l_i+1} (e_{l_i-1} + e_{l_i}).
$$

It follows that

\geq \sum_{i=0}^{s} \int_{I_{l_i+1}(e_{l_i-1}+e_{l_i})} |\sigma_{n+2^{m}} F_m(x)|^{1/2} d\mu(x)

\geq c \sum_{i=0}^{s} \frac{1}{2^{l_i}} 2^{l_i} \geq c s \geq cV(n).
$$

On the other hand, Fine [\[3\]](#page-13-1) proved that

\frac{1}{n \log n} \sum_{k=1}^{n} V(k) = \frac{1}{4 \log 2} + o(1).

\ge \frac{1}{2^{m+1}} \sum_{k=2^{m+1}}^{2^{m+1}-1} \|\sigma_k F_m\|_{1/2}^{1/2}

\ge \frac{c}{2^{m+1}} \sum_{k=2^{m+1}-1}^{2^{m+1}-1} V(k-2^m) \ge \frac{c}{2^{m+1}} \sum_{k=1}^{2^{m}-1} V(k)
$$
\n
$$
\ge \log m \to \infty, \text{ when } m \to \infty.
$$

Which complete the proof of Theorem 2.
