CROSSED PRODUCTS BY HILBERT PRO-C^{*}-BIMODULES VERSUS TENSOR PRODUCTS

ABSTRACT. We show that if $(X.A)$ and (Y, B) are two isomorphic Hilbert pro- C^* -bimodules, then the crossed product $A \times_X \mathbb{Z}$ of A by X and the crossed product $B \times_Y \mathbb{Z}$ of B by Y are isomorphic as pro- C^* -algebras. We also prove a property of "associativity" between " \otimes_{\min} " and " \times_X " as well as " \otimes_{\max} " and " \times x". As an application of these results we show that the crossed product of a nuclear pro- C^* -algebra A by a full Hilbert pro- C^* -bimodule X is a nuclear pro-C[∗] -algebra.

1. INTRODUCTION

The crossed product $A \times_{\alpha} \mathbb{Z}$ of a C^* -algebra A by an automorphism α is isomorphic with the C^{*}-algebra generated by the spectral subspaces $(A \times_{\alpha} \mathbb{Z})_0$ and $(A \times_{\alpha} \mathbb{Z})_1$ of the dual action of the unit circle on $A \times_{\alpha} \mathbb{Z}$ induced by α . A natural question is when given a C^* -algebra B and an action of the unit circle on B, there is a C^* -algebra B_0 and an automorphism α_0 of B_0 such that B is isomorphic to the crossed product of B_0 by α_0 . To answer to this question, B. Abadie, S. Eilers and R. Exel [\[AEE\]](#page-10-0) introduced the notion of crossed product by Hilbert C^* -bimodules that is a generalization of the notion of crossed product by automorphisms. Here, the automorphism α of A is replaced by a Hilbert C^* -bimodule X over A. It is known that the crossed product of C^* -algebras by automorphisms is invariant under conjugacy, and the minimal tensor product $(A \times_{\alpha} \mathbb{Z}) \otimes_{\min} B$ of the crossed product $A \times_{\alpha} \mathbb{Z}$ of A by α is isomorphic to the crossed product of $A \otimes_{\min} B$ by the automorphism $\alpha \otimes_{\text{min}} id_B$. It is natural to ask if these results can be extended in the context of crossed products by Hilbert C^* -bimodules. Crossed products of pro-C^{*}-algebras by inverse limit actions of locally compact groups were first considered by N.C. Philips $[P1]$ and secondly by M. Joita $[J2]$. In $[J21]$, M. Joita and I. Zarakas extended the construction of B. Abadie, S. Eilers and R. Exel in the context of $pro-C^*$ -algebras.

In this paper we prove that if two Hilbert (pro-) C^* -bimodules are isomorphic, then the crossed products associated are isomorphic. Also we show that given a Hilbert (pro-) C^* -bimodule (X, A) and a (pro-) C^* -algebra B, the crossed product associated to $(X \otimes_{\min} B, A \otimes_{\min} B)$ is isomorphic to the minimal tensor product of the crossed product associated to (X, A) and B, and the crossed product associated to $(X \otimes_{\text{max}} B, A \otimes_{\text{max}} B)$ is isomorphic to the maximal tensor product of the crossed product associated to (X, A) and B. As an application of these results we show

that the crossed product $A \times_X \mathbb{Z}$ of a nuclear pro- C^* -algebra A by a full Hilbert pro- C^* -bimodule X is a nuclear pro- C^* -algebra.

2. Preliminaries

A pro-C^{*}-algebra is a complete Hausdorff topological *-algebra A whose topology is given by a directed family of C^* -seminorms $\{p_\lambda; \lambda \in \Lambda\}.$

Throughout this paper all vector spaces are considered over the field $\mathbb C$ of complex numbers and all topological spaces are assumed to be Hausdorff. Also the topology on the pro- C^* -algebras A and B is given by the family of C^* -seminorms $\Gamma =$ $\{p_{\lambda}; \lambda \in \Lambda\},$ respectively $\Gamma' = \{q_{\delta}; \delta \in \Delta\}.$

A pro-C^{*}-morphism is a continuous *-morphism $\varphi : A \to B$ (that is, φ is linear, $\varphi(ab) = \varphi(a)\varphi(b)$ or all $a, b \in A$, $\varphi(a^*) = \varphi(a)^*$ for all $a \in A$ and for each $q_\delta \in \Gamma'$, there is $p_{\lambda} \in \Gamma$ such that $q_{\delta}(\varphi(a)) \leq p_{\lambda}(a)$ for all $a \in A$). An invertible pro-C^{*}morphism $\varphi: A \to B$ is a pro-C^{*}-isomorphism if φ^{-1} is also pro-C^{*}-morphism.

For $\lambda \in \Lambda$, ker p_{λ} is a closed *-bilateral ideal and $A_{\lambda} = A/\ker p_{\lambda}$ is a C^* -algebra in the C^{*}-norm $\left\|\cdot\right\|_{p_{\lambda}}$ induced by p_{λ} (that is, $\left\|a+\ker p_{\lambda}\right\|_{p_{\lambda}}=p_{\lambda}(a)$, for all $a \in A$). The canonical map from A to A_{λ} is denoted by π_{λ}^{A} , $\pi_{\lambda}^{A}(a) = a + \ker p_{\lambda}$ for all $a \in A$. For $\lambda, \mu \in \Lambda$ with $\mu \leq \lambda$ there is a surjective C^* -morphism $\pi_{\lambda\mu}^A : A_{\lambda} \to A_{\mu}$ such that $\pi_{\lambda\mu}^A(a + \ker p_\lambda) = a + \ker p_\mu$, and then $\{A_\lambda; \pi_{\lambda\mu}^A\}_{\lambda,\mu \in \Lambda}$ is an inverse system of C^* -algebras. Moreover, pro- C^* -algebras A and $\lim_{\leftarrow \lambda} A_\lambda$ are isomorphic (the Arens-

Michael decomposition of A). For more details we refer the reader [\[F,](#page-10-4) [P\]](#page-10-5).

Here we recall some basic facts from [\[J1\]](#page-10-6) and [\[Z\]](#page-10-7) regarding Hilbert pro- C^* modules and Hilbert pro- C^* -bimodules respectively.

A right Hilbert pro-C^{*}-module over A (or just Hilbert A-module), is a linear space X that is also a right A -module equipped with a right A -valued inner product $\langle \cdot, \cdot \rangle_A$, that is \mathbb{C} - and A-linear in the second variable and conjugate linear in the first variable, with the following properties:

- (1) $\langle x, x \rangle_A \ge 0$ and $\langle x, x \rangle_A = 0$ if and only if $x = 0$;
- $(2) \ \left(\langle x, y \rangle_A\right)^* = \langle y, x \rangle_A$

and which is complete with respect to the topology given by the family of seminorms $\{p^A_\lambda\}_{\lambda\in\Lambda}$, with $p^A_\lambda(x) = p_\lambda (\langle x, x\rangle_A)^{\frac{1}{2}}$, $x \in X$. A Hilbert A-module is full if the pro- C^* - subalgebra of A generated by $\{\langle x, y \rangle_A; x, y \in X\}$ coincides with A.

A left Hilbert pro- C^* -module X over a pro- C^* -algebra A is defined in the same way, where for instance the completeness is requested with respect to the family of seminorms $\{^A p_\lambda\}_{\lambda \in \Lambda}$, where $^A p_\lambda(x) = p_\lambda (A \langle x, x \rangle)^{\frac{1}{2}}$, $x \in X$.

In case X is a left Hilbert pro- C^* -module over A and a right Hilbert pro- C^* -module over B, the topology on B is given by the family of C^* -seminorms $\{q_\lambda\}_{\lambda \in \Lambda}$, such that the following relations hold:

- $_A \langle x, y \rangle z = x \langle y, z \rangle_B$ for all $x, y, z \in X$,
- $q_\lambda^B(ax) \leq p_\lambda(a)q_\lambda^B(x)$ and ${}^A p_\lambda(xb) \leq q_\lambda(b){}^A p_\lambda(x)$ for all $x \in X$, $a \in A$, $b \in$ B and for all $\lambda \in \Lambda$,

then we say that X is a Hilbert $A - B$ pro- C^* -bimodule.

A Hilbert $A - B$ pro- C^* -bimodule X is *full* if it is full as a right and as a left Hilbert pro- C^* -module. Clearly, any pro- C^* -algebra A has a canonical structure of Hilbert $A - A$ bimodule with the inner products given by $_A \langle a, b \rangle = ab^*$, respectively $\langle a,b\rangle_A = a^*b$ for all $a,b\in A.$

A morphism of Hilbert pro-C^{*}-bimodules from a Hilbert $A - A$ pro-C^{*}-bimodule X to a Hilbert $B - B$ pro-C^{*}-bimodule Y is a pair (Φ, φ) consisting of a pro-C^{*}morphism $\varphi : A \to B$ and a map $\Phi : X \to Y$, such that the following relations hold:

- $B \langle \Phi(x), \Phi(y) \rangle = \varphi(A \langle x, y \rangle)$ and $\Phi(ax) = \varphi(a) \Phi(x)$ for all $x, y \in X$, $a \in A$,
- $\langle \Phi(x), \Phi(y) \rangle_B = \varphi(\langle x, y \rangle_A)$ and $\Phi(xa) = \Phi(x) \varphi(a)$ for all $x, y \in X$, $a \in A$.

A morphism of Hilbert pro-C^{*}-bimodules $(\Phi, \varphi) : (X, A) \to (Y, B)$ is an isomorphism of Hilbert pro-C^{*}-bimodules if Φ and φ are invertible and $(\Phi^{-1}, \varphi^{-1})$: $(Y, B) \to (X, A)$ is a morphism of Hilbert pro-C^{*}-bimodules.

Let X be a Hilbert $A - A$ pro-C^{*}-bimodule. Then, for each $\lambda \in \Lambda$, ${}^A p_\lambda(x) =$ $p_\lambda^A(x)$ for all $x \in X$, and the normed space $X_\lambda = X/\ker p_\lambda^A$, where $\ker p_\lambda^A =$ $\{x \in X; p_\lambda^A(x) = 0\}$, is complete in the norm $||x + \ker p_\lambda^A||_{X_\lambda} = p_\lambda^A(x), x \in$ X. Moreover, X_{λ} has a canonical structure of a Hilbert $A_{\lambda} - A_{\lambda} C^*$ -bimodule $\operatorname{with} \langle x + \ker p_\lambda^A, y + \ker p_\lambda^A \rangle_{A_\lambda} = \langle x, y \rangle_A + \ker p_\lambda \text{ and } A_\lambda \langle x + \ker p_\lambda^A, y + \ker p_\lambda^A \rangle =$ $_A \langle x, y \rangle + \ker p_\lambda$ for all $x, y \in X$. The canonical surjection from X to X_λ is denoted by σ_{λ}^X . For $\lambda, \mu \in \Lambda$ with $\lambda \geq \mu$, there is a canonical surjective linear map $\sigma_{\lambda\mu}^X : X_{\lambda} \to X_{\mu}$ such that $\sigma_{\lambda\mu}^X(x + \ker p_{\lambda}^A) = x + \ker p_{\mu}^A$ for all $x \in X$. For $\lambda, \mu \in \Lambda$ with $\lambda \geq \mu$, $(\sigma_{\lambda\mu}^X, \pi_{\lambda\mu}^A)$ is a morphism of Hilbert C^* -bimodule and $\lim_{\lambda\to\infty} X_\lambda$ has a canonical structure of Hilbert $\lim_{\leftarrow \lambda} A_{\lambda} - \lim_{\leftarrow \lambda} A_{\lambda}$ bimodule. Moreover, $X = \lim_{\leftarrow \lambda} X_{\lambda}$, up to an isomorphism of Hilbert pro- C^* - bimodules.

A covariant representation of a Hilbert pro-C^{*}-bimodule (X, A) on a pro-C^{*}algebra B is a morphism of Hilbert pro- C^* -bimodules from (X, A) to the Hilbert pro- C^* -bimodule (B, B) .

The crossed product of A by a Hilbert pro-C^{*}-bimodule (X, A) is a pro-C^{*}algebra, denoted by $A \times_X \mathbb{Z}$, and a covariant representation (i_X, i_A) of (X, A) on $A \times_X \mathbb{Z}$ with the property that for any covariant representation (φ_X, φ_A) of (X, A) on a pro- C^* -algebra B, there is a unique pro- C^* -morphism $\Phi: A \times_X \mathbb{Z} \to B$ such that $\Phi \circ i_X = \varphi_X$ and $\Phi \circ i_A = \varphi_A$ [\[JZ1,](#page-10-3) Definition 3.3].

Remark 2.1. If (Φ, φ) is a morphism of Hilbert pro-C^{*}-bimodules from (X, A) to (Y, B) , then $(i_Y \circ \Phi, i_B \circ \varphi)$ is a covariant representation of (X, A) on $B \times_Y \mathbb{Z}$ and by the universal property of $A \times_X \mathbb{Z}$ there is a unique pro- C^* -morphism $\Phi \times \varphi$ from $A \times_X \mathbb{Z}$ to $B \times_Y \mathbb{Z}$ such that $(\Phi \times \varphi) \circ i_A = i_B \circ \varphi$ and $(\Phi \times \varphi) \circ i_X = i_Y \circ \Phi$.

3. Crossed products by Hilbert bimodules and tensor products

An automorphism α of a pro-C^{*}-algebra A such that $p_{\lambda}(\alpha(a)) = p_{\lambda}(a)$ for all $a \in A$ and $\lambda \in \Lambda'$, where Λ' is a cofinal subset of Λ , is called an inverse limit automorphism. If α is an inverse limit automorphism of the pro- C^* -algebra A, then $X_{\alpha} = {\xi_x; x \in A}$ is a Hilbert $A - A$ pro-C^{*}-bimodule with the bimodule structure defined as $\xi_x a = \xi_{xa}$, respectively $a\xi_x = \xi_{\alpha^{-1}(a)x}$, and the inner products are defined as $\langle \xi_x, \xi_y \rangle_A = x^*y$, respectively $_A \langle \xi_x, \xi_y \rangle = \alpha (xy^*)$.

Let α and β be two inverse limit automorphisms of the pro-C^{*}-algebras A, respectively B. It is well known that if the pro-C^{*}-dynamical systems (A, α, \mathbb{Z}) and (B, β, \mathbb{Z}) are conjugate (that is, there is a pro- C^* -morphism $\varphi : A \to B$ such that $\varphi \circ \alpha = \beta \circ \varphi$, then the crossed product $A \times_{\alpha} \mathbb{Z}$ of A by α and the crossed

product $B \times_{\beta} \mathbb{Z}$ of B by β are isomorphic as pro-C^{*}-algebras (see, for example, [\[W,](#page-10-8) [J2\]](#page-10-2)). Proposition [3.3](#page-3-0) extends this result for crossed products by Hilbert pro- C^* -bimodules.

Remark 3.1. Suppose that α and β are inverse limit automorphisms of the pro-C^{*}algebras A, respectively B and $\varphi : A \to B$ is a pro-C^{*}-isomorphism such that $\varphi \circ \alpha =$ $\beta \circ \varphi$. Then the Hilbert pro-C^{*}-bimodules (X_{α}, A) and (X_{β}, B) are isomorphic. Indeed, it is easy to check that $(\varphi_{X_\alpha}, \varphi_A)$, where $\varphi_{X_\alpha}(\xi_x) = \xi_{\varphi(x)}$ for all $x \in A$ and $\varphi_A = \varphi$, is an isomorphism of Hilbert pro-C^{*}-bimodules.

To prove the following proposition we will use the following lemma.

Lemma 3.2. [\[JZ2,](#page-10-9) Lemma 4.2] Let (Φ, φ) be a morphism of Hilbert pro-C^{*}bimodules from (X, A) to (Y, B) . If Γ and Γ' have the same index set, Λ , and $\varphi = \lim_{\leftarrow \lambda} \varphi_{\lambda}, \text{ then } \Phi = \lim_{\leftarrow \lambda} \Phi_{\lambda}, \text{ for each } \lambda \in \Lambda, (\Phi_{\lambda}, \varphi_{\lambda}) \text{ is a morphism of Hilbert }$ C^* -bimodules, $(\Phi_{\lambda} \times \varphi_{\lambda})_{\lambda}$ is an inverse system of C^* -morphisms and $\Phi \times \varphi =$ $\lim_{\leftarrow \lambda} \Phi_{\lambda} \times \varphi_{\lambda}$. Moreover, if (Φ, φ) is an isomorphism of Hilbert pro-C*-bimodules and $\varphi_{\lambda}, \lambda \in \Lambda$ are C^{*}-isomorphisms, then $(\Phi_{\lambda}, \varphi_{\lambda}), \lambda \in \Lambda$ are isomorphisms of $Hilbert C[*]-bimodules.$

Proposition 3.3. Let (X, A) and (Y, B) be Hilbert pro-C^{*}-bimodules. If the Hilbert pro-C^{*}-bimodules (X, A) and (Y, B) are isomorphic, then the pro-C^{*}-algebras $A \times_X$ $\mathbb Z$ to $B \times_Y \mathbb Z$ are isomorphic.

Proof. Let $(\Phi, \varphi) : (X, A) \to (Y, B)$ be an isomorphism of Hilbert pro-C^{*}-bimodules. Since φ is a pro- C^* -isomorphism, we can suppose that Γ and Γ' have the same index set, Λ , and $\varphi = \lim_{\longleftrightarrow} \varphi_{\lambda}$, where $\varphi_{\lambda} : A_{\lambda} \to B_{\lambda}$, $\lambda \in \Lambda$ are C^* -isomorphisms [\[JZ1,](#page-10-3) Lemma 3.7. Then, by Lemma [3.2,](#page-3-1) $\Phi = \lim_{\leftarrow \lambda} \Phi_{\lambda}$ and $(\Phi_{\lambda}, \varphi_{\lambda})$ is an isomorphism of Hilbert C^{*}-bimodules for all $\lambda \in \Lambda$. By [\[A,](#page-10-10) Remark 2.2], for each $\lambda \in \Lambda$, $\Phi_{\lambda} \times \varphi_{\lambda}$: $A_{\lambda} \times_{X_{\lambda}} \mathbb{Z} \to B_{\lambda} \times_{Y_{\lambda}} \mathbb{Z}$ is a C^{*}-isomorphism. Moreover, $(\Phi_{\lambda} \times \varphi_{\lambda})_{\lambda}$ is an inverse system of C^* -isomorphisms, and then $\Phi \times \varphi = \lim_{\leftarrow \lambda} \Phi_\lambda \times \varphi_\lambda$ is a pro- C^* -isomorphism. Therefore, the pro-C^{*}-algebras $A \times_X \mathbb{Z}$ to $B \times_Y \mathbb{Z}$ are isomorphic.

By [\[J2\]](#page-10-2), if α is an inverse limit automorphism of a pro-C^{*}-algebra A and B is another pro-C^{*}-algebra, then the minimal tensor product $(A \times_{\alpha} \mathbb{Z}) \otimes_{\min} B$ of the crossed product $A\times_{\alpha}\mathbb{Z}$ of A by α and B and the crossed product $(A\otimes_{\min} B)\times_{\alpha\otimes_{\min} \mathrm{id}} A$ $\mathbb Z$ of the minimal tensor product $A \otimes_{\min} B$ of A and B by the automorphism $\alpha \otimes_{\min}$ id are isomorphic as pro-C^{*}-algebras. Also the maximal tensor product $(A \times_{\alpha} \mathbb{Z}) \otimes_{\text{max}} B$ of the crossed product $A \times_{\alpha} \mathbb{Z}$ of A by α and B and the crossed product $(A \otimes_{\text{max}} B) \times_{\alpha \otimes_{\text{max}} \text{id}} \mathbb{Z}$ of the maximal tensor product $A \otimes_{\text{max}} B$ of A and B by the automorphism $\alpha \otimes_{\text{max}}$ id are isomorphic as pro-C^{*}-algebras. We refer the reader to $[F]$ for further information about tensor products of pro- C^* -algebras. The following theorems extend these results for crossed products by Hilbert (pro-) C^* -bimodules.

Let (X, A) and (Y, B) be two Hilbert pro-C^{*}-bimodules. Then $X \otimes_{\text{alg}} Y$ has a natural structure of pre-Hilbert $A \otimes_{\text{alg}} B$ - $A \otimes_{\text{alg}} B$ bimodule with the bimodule structure given by

 $(a \otimes b) (x \otimes y) = ax \otimes by$ and $(x \otimes y) (a \otimes b) = xa \otimes yb$

for all $a \in A, b \in B, x \in X$ and $y \in Y$, and the inner products given by

$$
A \otimes_{\text{alg}} B \langle x_1 \otimes y_1, x_2 \otimes y_2 \rangle = A \langle x_1, x_2 \rangle \otimes B \langle y_1, y_2 \rangle
$$

and

$$
\langle x_1 \otimes y_1, x_2 \otimes y_2 \rangle_{A \otimes_{\text{alg}}} B = \langle x_1, x_2 \rangle_A \otimes \langle y_1, y_2 \rangle_B
$$

for all $x_1, x_2 \in X$ and $y_1, y_2 \in Y$. Clearly,

 $A\otimes_{\mathrm{alg}} B \langle x_1 \otimes y_1, x_2 \otimes y_2 \rangle (x_3 \otimes y_3) = (x_1 \otimes y_1)\langle x_2 \otimes y_2, x_3 \otimes y_3 \rangle_{A\otimes_{\mathrm{alg}} B}$

for all $x_1, x_2, x_3 \in X$ and for all $y_1, y_2, y_3 \in Y$. It is easy to check that

$$
p_{(\lambda,\delta)}^{A\otimes_{\min} B}(x\otimes y)=\ {}^{A\otimes_{\min} B}p_{(\lambda,\delta)}(x\otimes y)
$$

and

$$
p_{(\lambda,\delta)}^{A\otimes_{\max} B} (x\otimes y) = \sqrt[A\otimes_{\max} B} p_{(\lambda,\delta)} (x\otimes y)
$$

for all $x \in X$, $y \in Y$ and $(\lambda, \delta) \in \Lambda \times \Delta$. Then the completion of $X \otimes_{\text{alg}} Y$ with respect to the topology given by the family of seminorms $\{p_{(\lambda,\delta)}^{A\otimes_{\min}B}\}_{(\lambda,\delta)\in\Lambda\times\Delta}$ is a Hilbert $A \otimes_{\min} B \text{-} A \otimes_{\min} B$ pro-C^{*}-bimodule, denoted by $\hat{X} \otimes_{\min} Y$ (see, [\[J1\]](#page-10-6)), and it is called the minimal tensor product of (X, A) and (Y, B) . The completion of $X \otimes_{\text{alg}} Y$ with respect to the topology given by the family of seminorms ${p_{(\lambda,\delta)}^{A\otimes_{\max}B}}_{(\lambda,\delta)\in \Lambda\times\Delta}$ is a Hilbert $A\otimes_{\max} B-A\otimes_{\max} B$ pro-C*-bimodule, denoted by $X \otimes_{\text{max}} Y$, and it is called the maximal tensor product of (X, A) and (Y, B) . It is easy to check that for each $(\lambda, \delta) \in \Lambda \times \Delta$, the Hilbert C^* -bimodules $(X \otimes_{\min} Y)_{(\lambda, \delta)}$ and $X_{\lambda} \otimes_{\min} Y_{\delta}$ are isomarphic, as well as, the Hilbert C^* -bimodules $(X \otimes_{\max} Y)_{(\lambda,\delta)}$ and $X_{\lambda} \otimes_{\text{max}} Y_{\delta}$.

Suppose (X_i, A_i) and (Y_i, B_i) , $i = 1, 2$ are four Hilbert pro-C^{*}-bimodules, and $(\varphi_{X_i}, \varphi_{A_i}) : (X_i, A_i) \to (Y_i, B_i), i = 1, 2$ are two morphisms of Hilbert pro-C^{*}bimodules. It is not difficult to check that the pair $(\varphi_{X_1} \otimes \varphi_{X_2}, \varphi_{A_1} \otimes \varphi_{A_2})$ of linear maps, where $\varphi_{X_1} \otimes \varphi_{X_2} : X_1 \otimes_{\text{alg}} X_2 \to Y_1 \otimes_{\text{alg}} Y_2$ is given by $\varphi_{X_1} \otimes \varphi_{X_2} (x_1 \otimes x_2) =$ $\varphi_{X_1}\left(x_1\right) \otimes \varphi_{X_2}\left(x_2\right), x_i \in X_i, i = 1, 2 \text{ and } \varphi_{A_1} \otimes \varphi_{A_2} : A_1 \otimes_{\text{alg}} A_2 \rightarrow B_1 \otimes_{\text{alg}} B_2$ is given by $\varphi_{A_1} \otimes \varphi_{A_2} (a_1 \otimes a_2) = \varphi_{A_1} (a_1) \otimes \varphi_{A_2} (a_2), a_i \in A_i, i = 1, 2$, extends to a morphism of Hilbert pro-C^{*}-bimodules $(\varphi_{X_1} \otimes_{\min} \varphi_{X_2}, \varphi_{A_1} \otimes_{\min} \varphi_{A_2})$ from $(X_1 \otimes_{\min} X_2, A_1 \otimes_{\min} A_2)$ to $(Y_1 \otimes_{\min} Y_2, B_1 \otimes_{\min} B_2)$ and a morphism of Hilbert $\text{pro-}C^*$ -bimodules $(\varphi_{X_1} \otimes_{\text{max}} \varphi_{X_2}, \varphi_{A_1} \otimes_{\text{max}} \varphi_{A_2})$ from $(X_1 \otimes_{\text{max}} X_2, A_1 \otimes_{\text{max}} A_2)$ to $(Y_1 \otimes_{\text{max}} Y_2, B_1 \otimes_{\text{max}} B_2).$

We remark that if α is an inverse limit automorphism of A and B is a pro- C^* -algebra, then the Hilbert pro- C^* -bimodules $X_{\alpha\otimes_{\min}id}$ and $X\otimes_{\min}B$ are isomorphic, as well as, the Hilbert pro-C^{*}-bimodules $X_{\alpha\otimes_{\text{max}}\text{id}}$ and $X\otimes_{\text{max}} B$. The isomorphism is given by $(\varphi_{X_{\alpha\otimes_{\min} \mathrm{id}}}, \varphi_{A\otimes_{\min} B})$, where $\varphi_{X_{\alpha\otimes_{\min} \mathrm{id}}}(\xi_{x\otimes y}) = \xi_{\alpha(x)} \otimes$ ξ_{y} ; $x \in A, y \in B$ and, $\varphi_{A \otimes_{\min} B} (a \otimes b) = \alpha(a) \otimes b$; $a \in A, b \in B$, respectively $(\varphi_{X_{\alpha\otimes_{\text{max}}B}},\varphi_{A\otimes_{\text{max}}B})$, where $\varphi_{X_{\alpha\otimes_{\text{max}}B}}(\xi_{x\otimes b}) = \xi_{\alpha(x)} \otimes \xi_y; x \in A, y \in B$ and $\varphi_{A\otimes_{\max}B}\left(a\otimes b\right)=\alpha\left(a\right)\otimes b; a\in A, b\in B.$

In order to prove Theorem [3.4](#page-4-0) below we are going to use the notion of dual action on crossed products by Hilbert bimodules [\[AEE,](#page-10-0) Section 3]. Let (X, A) be a Hilbert C^* -bimodule. Then there is an action δ^X of $\mathbb T$ on $A \times_X \mathbb Z$, called the dual action, which is identity on $i_A(A)$ and $\delta_t^X(i_X(x)) = ti_X(x)$ for all $t \in \mathbb{T}$ and for all $x \in X$.

Theorem 3.4. Let (X, A) be a Hilbert pro-C^{*}-bimodule and let B be a pro-C^{*}algebra. Then the pro-C^{*}-algebras $(A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z}$ and $(A \times_X \mathbb{Z}) \otimes_{\min} B$ are isomorphic.

Proof. We divide the proof into two parts.

Step 1. We suppose that A and B are C^* -algebras.

It is easy to check that $(i_X \otimes_{\min} id_B, i_A \otimes_{\min} id_B)$ is a covariant representation of $(X \otimes_{\min} B, A \otimes_{\min} B)$ on $(A \times_X Z) \otimes_{\min} B$. By the universal property of the crossed product by Hilbert C^* -bimodules, there is a unique C^* -morphism $\Phi: (A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z} \to (A \times_X \mathbb{Z}) \otimes_{\min} B$ such that $\Phi \circ i_{X \otimes_{\min} B} = i_X \otimes_{\min} id_B$ and $\Phi \circ i_{A\otimes_{\min}B} = i_A \otimes_{\min} id_B$. Since Φ is a C^* -morphism, and since $(A \times_X \mathbb{Z}) \otimes_{\min}$ B is generated by $i_X(X) \otimes_{\text{alg}} B$ and $i_A(A) \otimes_{\text{alg}} B$, Φ is surjective.

On the other hand, $\Phi|_{i_{A\otimes_{\min}B}(A\otimes_{\min}B)}$ is injective, since $\Phi|_{i_{A\otimes_{\min}B}(A\otimes_{\min}B)}=$ $i_A \otimes id_B$ and i_A is injective. If $\delta^{X \otimes_{\min} B}$ and δ^{X} are the dual actions of T on $(A\otimes_{\min} B) \times_{X\otimes_{\min} B} \mathbb{Z}$, respectively $A \times_X \mathbb{Z}$ (see [\[AEE,](#page-10-0) Section 3]), and $\delta^X \otimes id$ is an action of \mathbb{T} on $(A \times_X \mathbb{Z}) \otimes_{\min} B$ given by $(\delta^X \otimes id)_t = \delta_t^X \otimes id_B$, then Φ is $\left(\delta^{X\otimes_{\min} B},\delta^X\otimes \mathrm{id}\right)$ -covariant, that is $\Phi\circ \delta_t^{X\otimes_{\min} B} = \left(\delta^X\otimes \mathrm{id}\right)_t \circ \Phi$ for all $t \in \mathbb{T}$, since

for all $x \in X$, $b \in B$, $t \in \mathbb{T}$ and

&= \left(\left(\delta^X \otimes \mathrm{id}\right)_t \circ \Phi\right) (i_{A \otimes_{\min} B} (a \otimes b))\n\end{aligned}

for all $a \in A$, $b \in B$ and $t \in \mathbb{T}$. Then, by [\[E,](#page-10-11) Proposition 2.9], Φ is injective, and so it is a C^* -isomorphism.

Step 2. We suppose that A and B are pro- C^* -algebras.

By [\[JZ1,](#page-10-3) Proposition 3.8], we can suppose that $A \times_X \mathbb{Z} = \lim_{\leftarrow \lambda} A_{\lambda} \times_{X_{\lambda}} \mathbb{Z}$ with $(A \times_X \mathbb{Z})_\lambda = A_\lambda \times_{X_\lambda} \mathbb{Z}$ for each $\lambda \in \Lambda$, and $(A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z} = \lim_{\leftarrow (\lambda, \delta)}$ $(A_\lambda \otimes_{\min} B_\delta) \times_{X_\lambda \otimes_{\min} B_\delta} \mathbb{Z}$ with $((A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z})_{(\lambda, \delta)} = (A_\lambda \otimes_{\min} B_\delta)$ $\times_{X_\lambda\otimes_{\min}B_\delta}\mathbb{Z}$ for each $(\lambda,\delta)\in\Lambda\times\Delta$.

Let $(\lambda, \delta) \in \Lambda \times \Delta$. According to Step 1, there is a C^{*}-isomorphism $\Phi_{(\lambda, \delta)}$: $(A_{\lambda} \otimes_{\min} B_{\delta}) \times_{X_{\lambda} \otimes_{\min} B_{\delta}} \mathbb{Z} \to (A_{\lambda} \times_{X_{\lambda}} \mathbb{Z}) \otimes_{\min} B_{\delta}$ such that $\Phi_{(\lambda, \delta)} \circ i_{X_{\lambda} \otimes_{\min} B_{\delta}} =$ $i_{X_{\lambda}} \otimes id_{B_{\delta}}$ and $\Phi_{(\lambda,\delta)} \circ i_{A_{\lambda} \otimes \min B_{\delta}} = i_{A_{\lambda}} \otimes id_{B_{\delta}}$. From

for all $a \in A_{\lambda_1}, b \in B_{\delta_1}$ and for all $(\lambda_1, \delta_1), (\lambda_2, \delta_2) \in \Lambda \times \Delta$ with $(\lambda_1, \delta_1) \geq$ (λ_2, δ_2) , and taking into account that $(A_\lambda \otimes_{\min} B_\delta) \times_{X_\lambda \otimes_{\min} B_\delta} \mathbb{Z}$ is generated by $i_{X_{\lambda}\otimes_{\min}B_{\delta}}(z)$ and $i_{A_{\lambda}\otimes_{\min}B_{\delta}}(a\otimes b)$ with $z\in X_{\lambda}\otimes_{\min}B_{\delta}$ and $a\in A_{\lambda}, b\in B_{\delta}$, we deduce that $(\Phi_{(\lambda,\delta)})_{(\lambda,\delta)}$ is an inverse system of C^{*}-isomorphisms. Then $\Phi =$ $\lim_{\leftarrow (\lambda,\delta)} \Phi_{(\lambda,\delta)}$ is a pro-C^{*}-isomorphism from $(A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z}$ to $(A \times_X \mathbb{Z}) \otimes$ $\min_{\text{min}} B$.

Let X and Y be Hilbert pro- C^* -modules over A. A morphism $T: X \to Y$ of right modules is *adjointable* if there is another morphism of modules $T^* : Y \to X$ such that $\langle Tx_1, x_2 \rangle_A = \langle x_1, T^*x_2 \rangle_A$ for all $x_1, x_2 \in X$. The vector space $L_A(X, Y)$ of all adjointable module morphisms from X to Y has a structure of locally convex space under the topology given by the family of seminorms $\{p_{\lambda,L_A(X,Y)}\}_{\lambda\in\Lambda}$, where $p_{\lambda, L_A(X,Y)}(T) = \sup \{ p_{\lambda}^A(Tx); p_{\lambda}^A(x) \le 1 \}.$

For $Y = X$, $L_A(X) = L_A(X, X)$ is a pro-C^{*}-algebra with $(L_A(X))_{\lambda} = L_{A_{\lambda}}(X_{\lambda})$ for each $\lambda \in \Lambda$,

The vector space $L_A(X, Y)$ of all adjointable module map from X to Y has a natural structure of Hilbert $\hat{L}_A(Y) - L_A(X)$ pro-C^{*}-bimodule with the bimodule structure given by

Suppose that X is a full Hilbert $A - A$ pro-C^{*}-bimodule. Then $L_A(X)$ can be identified with $M(A)$, the multiplier algebra of A, and $L_A(A, X)$, has a structure of Hilbert $M(A) - M(A)$ pro-C^{*}-bimodule. $L_A(A, X)$ is denoted by $M(X)$ and it is called the *multiplier bimodule* of X (see [\[JMZ\]](#page-10-12)). Moreover, X can be regarded as a pro-C^{*}-sub-bimodule of $M(X)$, and $M(X)_{\lambda} = M(X_{\lambda})$ for all $\lambda \in \Lambda$.

A morphism of Hilbert pro-C^{*}-bimodules $(\Phi, \varphi) : (X, A) \to (M(Y), M(B))$ is *nondegenerate if* the pro-C^{*}-subalgebra generated by $\{\varphi(a) b; a \in A, b \in B\}$ is dense in B and vector space generated by $\{\Phi(x) b; x \in X, b \in B\}$ is dense in Y. A nondegenerate morphism of Hilbert pro-C^{*}-bimodules $(\Phi, \varphi) : (X, A) \to$ $(M(Y), M(B))$ extends to a unique morphism of Hilbert pro-C^{*}-bimodules $(\overline{\Phi}, \overline{\varphi})$: $(M(X), M(A)) \to (M(Y), M(B))$. The canonical representation (i_X, i_A) of (X, A) on $A \times_X \mathbb{Z}$ is nondegenerate.

Lemma 3.5. Let (X, A) be a full Hilbert pro- C^* -bimodule and let B be a pro- C^* -algebra. Then there is a nondegenerate morphism of Hilbert pro- C^* -bimodules $(\rho_{X\otimes_{\max} B}^X, \rho_{A\otimes_{\max} B}^A) : (X, A) \to (M(X\otimes_{\max} B), M(A\otimes_{\max} B))$ such that $\rho^X_{X\otimes_{\max} B}(x)$ $(a\otimes b)=xa\otimes b$ for all $x\in X, a\in A$ and $b\in B$ and $\rho^A_{A\otimes_{\max} B}(c)$ $(a\otimes b)=$ $ca \otimes b$ for all $a, c \in A$ and $b \in B$.

Proof. We divide the proof into two parts.

Step 1. Suppose that A and B are C^* -algebras.

Let $x \in X$. Consider the linear maps $\rho_{X\otimes_{\max}B}^X(x) : A \otimes_{\text{alg}} B \to X \otimes_{\text{alg}} B$ given by $\rho_{X\otimes_{\text{max}}B}^X(x)$ $(a\otimes b) = xa \otimes b$, and $\rho_{X\otimes_{\text{max}}B}^X(x)^* : X \otimes_{\text{alg}}^X B \to A \otimes_{\text{alg}}^B B$ given by $\rho_{X\otimes_{\max}B}^X(x)^*(y\otimes b)=\langle x,y\rangle_A\otimes b.$ From

Let $\rho_{A \otimes_{\text{max}} B}^A$ be the inclusion of A into $M(A \otimes_{\text{max}} B)$ (see, for example, [\[RW,](#page-10-13) Theorem B27]). Then $\rho_{A\otimes_{\max}B}^A(c)$ $(a \otimes b) = ca \otimes b$ for all $a, c \in A$, $b \in B$, and it is easy to check that $(\rho_{X\otimes_{\max} B}^X, \rho_{A\otimes_{\max} B}^A)$ is a morphism of Hilbert C^* -bimodules. Moreover, $(\rho_{X\otimes_{\max}B}^X, \rho_{A\otimes_{\max}B}^A)$ is nondegenerate.

Step 2. Suppose that A and B are pro-C^{*}-algebras. Let $(\lambda, \delta) \in \Lambda \times \Delta$ and $\left(\rho_{X_{\lambda}\otimes_{\max}B_{\delta}}^{X_{\lambda}},\rho_{A_{\lambda}\otimes_{\max}B_{\delta}}^{A_{\lambda}}\right)$ $\bigg): (X_{\lambda}, A_{\lambda}) \to (M(X_{\lambda} \otimes_{\max} B_{\delta}), M(A_{\lambda} \otimes_{\max} B_{\delta}))$ be the nondegenerate morphism of Hilbert C^* -bimodules constructed in $Step 1$. It is easy to check that $\left(\rho_{X_{\lambda}\otimes_{\max}B_{\delta}}^{X_{\lambda}}\right)$ $\overline{ }$ $(\lambda,\delta) \in \Lambda \times \Delta$ and $(\rho_{A_{\lambda} \otimes_{\max} B_{\delta}}^{A_{\lambda}})$ $\overline{ }$ $(\lambda,\delta) \in \Lambda \times \Delta$ are inverse systems of

 $\lim_{\epsilon \to 0} \max_{\lambda} \mathcal{L}^*$ = morphisms, and $\left(\lim_{\epsilon \to (\lambda,\delta)} \rho_{X_{\lambda} \otimes_{\max} B_{\delta}}^{X_{\lambda}}, \lim_{\epsilon \to (\lambda,\delta)} \rho_{A_{\lambda} \otimes_{\max} B_{\delta}}^{A_{\lambda}} \right)$ \setminus $\sqrt{ }$ $\lim_{\leftarrow \lambda} X_{\lambda}, \lim_{\leftarrow \lambda} A_{\lambda}$ \setminus \rightarrow $\sqrt{ }$ $\lim_{\leftarrow (\lambda,\delta)} X_\lambda \otimes_{\max} B_\delta, \lim_{\leftarrow (\lambda,\delta)} A_\lambda \otimes_{\max} B_\delta$ \setminus is a morphism of $\text{Hilbert pro-}C^*\text{-bimodules}. \quad \text{Identifying} \quad \left(\lim_{\leftarrow (\lambda,\delta)} X_\lambda \otimes_{\text{max}} B_\delta, \lim_{\leftarrow (\lambda,\delta)} A_\lambda \otimes_{\text{max}} B_\delta \right) \right)$ $\overline{ }$ with $(X \otimes_{\max} B, A \otimes_{\max} B)$ and $\left(\lim_{\leftarrow \lambda} X_{\lambda}, \lim_{\leftarrow \lambda} A_{\lambda}\right)$ $\overline{}$ with (X, A) , we obtain a nondegenerate morphism of Hilbert pro-C^{*}-bimodules $(\rho_{X\otimes_{\max} B}^X, \rho_{A\otimes_{\max} B}^A) : (X, A) \to$ $(M(X \otimes_{\text{max}} B), M (A \otimes_{\text{max}} B))$ such that $\rho_{X \otimes_{\text{max}} B}^X(x)$ $(a \otimes b) = xa \otimes b$ for all $x \in X, a \in A$ and $b \in B$ and $\rho_{A \otimes_{\max} B}^A(c)$ $(a \otimes b) = ca \otimes b$ for all $a, c \in A$ and $b \in B$.

Theorem 3.6. Let (X, A) be a full Hilbert pro-C^{*}-bimodule and let B be a pro- C^* -algebra. Then the pro- C^* -algebras $(A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z}$ and $(A \times_X \mathbb{Z}) \otimes_{\max}$ B are isomorphic.

Proof. Step 1. Suppose that A and B are C^* -algebras.

Since $(i_X \otimes_{\text{max}} id_B, i_A \otimes_{\text{max}} id_B)$ is a covariant representation of $(X \otimes_{\text{max}} B,$ $A \otimes_{\max} B$ on $(A \times_X \mathbb{Z}) \otimes_{\max} B$, there is a unique C^* -morphism $\Phi : (A \otimes_{\max} B)$ $\times_{X\otimes_{\text{max}}B}Z \to (A \times_X \mathbb{Z})\otimes_{\text{max}}B$ such that $\Phi \circ i_{X\otimes_{\text{max}}B} = i_X \otimes_{\text{max}} id_B$ and $\Phi \circ i_Y \otimes_{\text{max}} B$ $i_{A\otimes_{\text{max}}B} = i_A\otimes_{\text{max}} id_B$. Moreover, Φ is surjective.

Let $\rho_{A\otimes_{\max}B}^A$ and $\rho_{A\otimes_{\max}B}^B$ the canonical inclusions of A and B in $M(A\otimes_{\max} B)$ and $\rho_{X\otimes_{\max}B}^X : X \to M(X\otimes_{\max}B)$ the map constructed in Lemma [3.5.](#page-6-0) Then $\left(i_{i_{X\otimes_{\max}B}}\circ\rho^X_{X\otimes_{\max}B},\overline{i_{A\otimes_{\max}B}}\circ\rho^A_{A\otimes_{\max}B}\right)$ is a covariant representation of (X,A) on $M((A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z})$, and by the universal property, there is a unique C^* -morphism $\Psi_1: A \times_X \mathbb{Z} \to M((A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z})$ such that $\Psi_1 \circ i_X =$ $i_{X\otimes_{\max}B}\circ \rho^X_{X\otimes_{\max}B}$ and $\Psi_1\circ i_A=i_{A\otimes_{\max}B}\circ \rho^A_{A\otimes_{\max}B}.$

Let $\Psi_2 = \overline{i_{A\otimes_{\max}B}} \circ \rho_{A\otimes_{\max}B}^B : B \to M((A\otimes_{\max}B)\times_{X\otimes_{\max}B}\mathbb{Z}).$ Since

\Psi_1(i_A(a))\Psi_2(b) = \overline{i_{A\otimes_{\max}B}}\left(\rho^A_{A\otimes_{\max}B}(a)\rho^B_{A\otimes_{\max}B}(b)\right) = i_{A\otimes_{\max}B}(a\otimes b)

\overline{i_{A\otimes_{\max}B}}\left(\rho^B_{A\otimes_{\max}B}(b)\rho^A_{A\otimes_{\max}B}(a)\right) = \Psi_2(b)\Psi_1(i_A(a))
$$

for all $a \in A, b \in B$ and

\Psi_{1}\left(i_{X}\left(x\right)\right)\Psi_{2}\left(b\right)=\overline{i_{X\otimes_{\max}B}\left(\rho_{X\otimes_{\max}B}^{X}\left(x\right)\right)\overline{i_{A\otimes_{\max}B}\left(\rho_{A\otimes_{\max}B}^{B}\left(b\right)\right)}
$$

=\overline{i_{X\otimes_{\max}B}\left(\rho_{X\otimes_{\max}B}^{X}\left(x\right)\rho_{A\otimes_{\max}B}^{B}\left(b\right)\right)}=i_{X\otimes_{\max}B}\left(x\otimes b\right)=\Psi_{2}\left(b\right)\Psi_{1}\left(i_{X}\left(x\right)\right)
$$

for all $x \in X, b \in B$, and since $i_A(A)$ and $i_X(X)$ generate $A \times_X \mathbb{Z}$, there is a unique C^* -morphism $\Psi : (A \times_X \mathbb{Z}) \otimes_{\max} B \to M((A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z})$ such that $\Psi(c \otimes b) = \Psi_1(c) \Psi_2(b)$ for all $c \in A \times_X \mathbb{Z}$ and $b \in B$. Moreover, $\Psi((A \times_X \mathbb{Z}) \otimes_{\max} B)$ $\subseteq (A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z}.$

From

$$
\Psi \circ \Phi (i_{X \otimes_{\max} B} (x \otimes b)) = \Psi (i_X (x) \otimes b) = \Psi_2 (b) \Psi_1 (i_X (x)) = i_{X \otimes_{\max} B} (x \otimes b)
$$

and

 $\Psi \circ \Phi (i_{A\otimes_{\max} B}(a\otimes b)) = \Psi (i_A(a)\otimes b) = \Psi_2(b)\Psi_1(i_A(a)) = i_{A\otimes_{\max} B}(a\otimes b)$

for all $a \in A$, $b \in B$ and for all $x \in X$ and taking into account that $i_{X\otimes_{\max} B} (X \otimes_{\max} B)$ and $i_{A\otimes_{\max}B}(A\otimes_{\max}B)$ generate $(A\otimes_{\max}B)\times_{X\otimes_{\max}B}\mathbb{Z}$, we conclude $\Psi\circ\Phi=$

 $id_{(A\otimes_{\max}B)\times_{X\otimes_{\max}B}\mathbb{Z}}$, where using the fact that Φ is surjective, we deduce that Φ is α $\overline{C^*}$ -isomorphism.

Step 2. The general case. Let $(\lambda, \delta) \in \Lambda \times \Delta$ and let $\Phi_{(\lambda,\delta)} : (A_{\lambda} \otimes_{\max} B_{\delta}) \times_{X_{\lambda} \otimes_{\max} B_{\delta}}$ $Z \to (A_{\lambda} \times_{X_{\lambda}} \mathbb{Z}) \otimes_{\max} B_{\delta}$ be the C*-isomorphism constructed in Step 1. Following the proof of Theorem [3.4](#page-4-0) Step 2, we obtain a pro-C^{*}-isomorphism $\Phi = \lim_{\delta \to 0} \Phi_{(\lambda, \delta)}$ $\leftarrow (\lambda, \delta)$

from $(A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z}$ to $(A \times_X \mathbb{Z}) \otimes_{\max} B$.

4. An application

A pro-C^{*}-algebra A is nuclear if for any pro-C^{*}-algebra B, $A \otimes_{min} B = A \otimes_{max}$ B [\[P,](#page-10-5) p. 126].

Remark 4.1. If X is a Hilbert C^* -bimodule over a nuclear pro- C^* -algebra A, then, clearly, $X \otimes_{\min} B = X \otimes_{\max} B$ for any pro-C^{*}-algebra B, and $(A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z}$ $=(A\otimes_{\max} B)\times_{X\otimes_{\max} B}\mathbb{Z}.$

Suppose that the topology on A is given by the family of C^* -seminorms $\Gamma =$ $\{p_{\lambda}; \lambda \in \Lambda\}$. Then A is nuclear if only if the C^{*}-algebras $A_{\lambda}, \lambda \in \Lambda$ are nuclear [\[P,](#page-10-5) p. 126]. Recall that a C^* -algebra A is nuclear if and only if for any C^* -algebra B, the canonical map $k_{A,B}$: $A \otimes_{\text{max}} B \to A \otimes_{\text{min}} B$, $k_{A,B} (a \otimes b) = a \otimes b$ is a C ∗ -isomorphism.

Remark 4.2. Let (X, A) be a full Hilbert C^* -bimodule. If A is nuclear, then for any C^* -algebra B, the pair of maps $(k_{X,B}, k_{A,B})$, where $k_{X,B}: X \otimes_{\max} B \to X \otimes_{\min} B$, $k_{X,B}(x\otimes b)=x\otimes b$, is an isomorphism of Hilbert C^* -bimodules and it induces a unique C^{*}-isomorphism $k : (A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z} \to (A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z}$ such that $k \circ i_{X\otimes_{\min}B} = i_{X\otimes_{\min}B} \circ k_{X,B}$ and $k \circ i_{A\otimes_{\max}B} = i_{A\otimes_{\min}B} \circ k_{A,B}$.

Proposition 4.3. Let (X, A) be a full Hilbert pro-C^{*}-bimodule. Then $A \times_X \mathbb{Z}$ is nuclear if and only if A is nuclear.

Proof. According to [\[JZ1,](#page-10-3) Proposition 3.8], to prove this proposition it is sufficient to show that if (X, A) is a full Hilbert C^{*}-bimodule, then $A \times_X \mathbb{Z}$ is nuclear if and only if A is nuclear.

If A is nuclear and B a C^* -algebra, then $\Phi \circ k \circ \Psi$, where Ψ is the C^* -isomorphism from $(A \times_X \mathbb{Z}) \otimes_{\text{max}} B$ onto $(A \otimes_{\text{max}} B) \times_{X \otimes_{\text{max}} B} \mathbb{Z}$ constructed in the proof of Theorem [3.6,](#page-8-0) k is the C^{*}-isomorphism from $(A \otimes_{\max} B) \times_{X \otimes_{\max} B} \mathbb{Z}$ onto $(A \otimes_{\min} B)$ $\times_{X\otimes_{\text{min}} B} \mathbb{Z}$ (Remark [4.2\)](#page-9-0), and Φ is the C^{*}-isomorphism from $(A \times_X \mathbb{Z}) \otimes_{\text{min}} B$ onto $(A \otimes_{\min} B) \times_{X \otimes_{\min} B} \mathbb{Z}$ constructed in the proof of Theorem [3.4,](#page-4-0) is a C^* isomorphism. Moreover, $(\Phi \circ k \circ \Psi)(c \otimes b) = c \otimes b$ for all $c \in A \times \mathcal{X} \mathbb{Z}$ and for all $b \in B$. These show that, $A \times_X \mathbb{Z}$ is nuclear.

Conversely, suppose that $A \times_X \mathbb{Z}$ is nuclear. If A is not nuclear, there is a C^* algebra B_0 such that the canonical map $k_{A,B_0}: A \otimes_{\text{max}} B_0 \to A \otimes_{\text{min}} B_0$ is not injective. Then the C^{*}-morphism $k_0: (A \otimes_{\max} B_0) \times_{X \otimes_{\max} B_0} \mathbb{Z} \to (A \otimes_{\min} B_0) \times_{X \otimes_{\min} B_0}$ $\mathbb Z$ induced by (k_{X,B_0}, k_{A,B_0}) is not injective.

On the other hand, because $A \times_X \mathbb{Z}$ is nuclear, the canonical map $k_{A \times_X \mathbb{Z}, B_0}$: $(A \times X \mathbb{Z}) \otimes_{\text{max}} B_0 \to (A \times X \mathbb{Z}) \otimes_{\text{min}} B_0$ is a C^* -isomorphism, and then $\widetilde{k} =$ $\Phi^{-1} \circ k_{A \times_X \mathbb{Z}, B_0} \circ \Psi^{-1}$ is a C^* -isomorphism from $(A \otimes_{\max} B_0) \times_{X \otimes_{\max} B_0} \mathbb{Z}$ onto $(A\otimes_{\min} B_0) \times_{X\otimes_{\min} B_0} \mathbb{Z}$. Moreover, it is easy to check that $k \circ i_{X\otimes_{\max} B_0} =$ $i_{X\otimes_{\min}B_0} \circ k_{X,B_0}$ and $k \circ i_{A\otimes_{\max}B_0} = i_{A\otimes_{\min}B_0} \circ k_{A,B_0}$ and then, by Remark [4.2,](#page-9-0) $k = k_0$, a contradiction. Therefore, if $A \times_X \mathbb{Z}$ is nuclear, then A is nuclear. \square

Another proof of the above proposition was given by Katsura([\[K,](#page-10-14) Proposition 7.8]).
