APPROXIMATION BY WALSH-KACZMARZ-FEJÉR MEANS ON THE HARDY SPACE

ABSTRACT. The main aim of this paper is to find necessary and sufficient conditions for the convergence of Walsh-Kaczmarz-Fejér means in the terms of the modulus of continuity on the Hardy spaces H_p , when $0 < p \leq 1/2$.

1. INTRODUCTION

The a.e. convergence of Walsh-Fejér means $\sigma_n f$ was proved by Fine [\[1\]](#page-10-0). Yano [\[35\]](#page-11-0) has proved that $||K_n|| \leq 2$ ($n \in \mathbb{N}$).Consequently, $||\sigma_n f - f||_p \to$ 0, as $n \to \infty$ ($f \in L_p$, $1 \leq p \leq \infty$). However (see [\[13,](#page-10-1) [19\]](#page-11-1)) the rate of convergence can not be better then $O(n^{-1})$ $(n \to \infty)$ for nonconstant functions. Fridli [\[2\]](#page-10-2) use dyadic modulus of continuity to characterize the set of functions in the space L_p , whose Walsh-Fejér means converge at the given rate.

In 1975 Schipp [\[20\]](#page-11-2) showed that the maximal operator σ^* is of weak type $(1, 1)$ and of type (p, p) for $1 < p \leq \infty$. The boundedness fails to hold for $p = 1$. But, Fujii [\[4\]](#page-10-3) proved that σ^* is bounded from the dyadic Hardy space H_1 to the space L_1 . The theorem of Fujii was extended by Weisz [\[33\]](#page-11-3). he showed that the maximal operator σ^* is bounded from the martingale Hardy space H_p to the space L_p for $p > 1/2$. Simon gave a counterexample [\[22\]](#page-11-4), which shows that the boundedness does not hold for $0 < p < 1/2$. The counterexample for $p = 1/2$ due to Goginava [\[9\]](#page-10-4) (see also [\[26\]](#page-11-5)). In the endpoint case $p = 1/2$ Weisz [\[34\]](#page-11-6) proved that σ^* is bounded from the Hardy space $H_{1/2}$ to the space weak- $L_{1/2}$.

In 1948 Sneider [\[25\]](#page-11-7) introduced the Walsh-Kaczmarz system and showed that the inequality

holds a.e. In 1974 Schipp [\[21\]](#page-11-8) and Young [\[36\]](#page-11-9) proved that the Walsh-Kaczmarz system is a convergence system. In 1981, Skvortsov [\[24\]](#page-11-10) showed

that the Fejér means with respect to the Walsh-Kaczmarz system converge uniformly to f for any continuous functions f. Gát $[5]$ proved that, for any integrable functions, the Fejér means with respect to the Walsh-Kaczmarz system converge almost everywhere to the function. He showed that the maximal operator of Walsh-Kaczmarz-Fejér means $\sigma^{\kappa,*}$ is weak type $(1,1)$ and of type (p, p) for all $1 < p \leq \infty$. Gát's result was generalized by Si-mon [\[23\]](#page-11-11), who showed that the maximal operator $\sigma^{\kappa,*}$ is of type (H_p, L_p) for $p > 1/2$. In the endpoint case $p = 1/2$ Goginava [\[8\]](#page-10-6) (see also [\[7,](#page-10-7) [6\]](#page-10-8)) proved that maximal operator $\sigma^{\kappa,*}$ is not of type $(H_{1/2}, L_{1/2})$ and Weisz [\[34\]](#page-11-6) showed that the maximal operator is of weak type $(H_{1/2}, L_{1/2})$. In [\[7\]](#page-10-7) and [\[29\]](#page-11-12) it is proved that the maximal operator $\tilde{\sigma}^{\kappa,*}$ defined by

\widetilde{\sigma}_p^{\kappa,*} := \sup_{n \in \mathbb{N}} \frac{|\sigma_n^{\kappa}|}{(n+1)^{1/p-2} \log^{2[1/2+p]}(n+1)},
$$

where $0 < p \leq 1/2$ and $[1/2 + p]$ denotes integer part of $1/2 + p$, is bounded from the Hardy space H_p to the space L_p . As a corollary we get

(1)

\|\sigma_n^{\kappa}f\|_p \leq c_p (n+1)^{1/p-2} \log^{2[1/2+p]} (n+1) \|f\|_{H_p}.
$$

Moreover, for any nondecreasing function $\varphi : \mathbb{N}_+ \to [1, \infty)$ satisfying the condition

(2)

\lim_{n \to \infty} \frac{(n+1)^{1/p-2} \log^{2[1/2+p]}(n+1)}{\varphi(n)} = +\infty,
$$

there exists a martingale $f \in H_p$, such that

$$
\sup_{n\in\mathbb{N}}\left\|\frac{\sigma_n^{\kappa}f}{\varphi(n)}\right\|_p=\infty.
$$

For Walsh system analogical theorems are proved in [\[10\]](#page-10-9), [\[27\]](#page-11-13) and [\[28\]](#page-11-14). It is well-known (see [\[31\]](#page-11-15)) that

\|\sigma_{2^n}^{\kappa}(f) - f\|_{H_p} \to 0, \text{ when } n \to \infty, \quad (f \in H_p, \ p > 0).
$$

Móricz and Siddiqi [\[14\]](#page-10-10) investigates the approximation properties of some special Nörlund means of Walsh-Fourier series of L_p function in norm. Fridli, Manchanda and Siddiqi [\[3\]](#page-10-11) improved and extended the results of Móricz and Siddiqi [\[14\]](#page-10-10) among them in H_p norm, where $0 < p < 1$. In [\[12\]](#page-10-12) Goginava investigated the behavior of Cesáro means of Walsh-Fourier series in detail. Analogical results for Walsh-Kaczmarz-Fourier series were proved by Nagy in [\[15,](#page-11-16) [16,](#page-11-17) [17,](#page-11-18) [18\]](#page-11-19).

The main aim of this paper is to find necessary and sufficient conditions for the convergence of Fejér means in the terms of the modulus of continuity on the Hardy spaces H_p , when $0 < p < 1/2$ and $p = 1/2$, respectively. That is, the most investigated end point case $p = 1/2$ is also discussed.

The paper is organized as following: In Section 3 we present and discuss the main results and in Section 4 the auxiliary propositions will be given. In Section 5 the the proofs can be found. Moreover, in order not to disturb

our discussions in these Sections some definitions and notations are given in Section 2.

2. Definitions and Notations

Now, we give a brief introduction to the theory of dyadic analysis [\[19\]](#page-11-1). Let \mathbb{N}_+ denote the set of the positive integers, $\mathbb{N} := \mathbb{N}_+ \cup \{0\}$. Denote \mathbb{Z}_2 the discrete cyclic group of order 2, that is $\mathbb{Z}_2 = \{0,1\}$, where the group operation is the modulo 2 addition and every subset is open. The Haar measure on \mathbb{Z}_2 is given such that the measure of a singleton is $1/2$. Let G be the complete direct product of the countable infinite copies of the compact groups \mathbb{Z}_2 . The elements of G are of the form $x = (x_0, x_1, ..., x_k, ...)$ with $x_k \in \{0,1\}$ ($k \in \mathbb{N}$). The group operation on G is the coordinatewise addition, the measure (denoted by μ) and the topology are the product measure and topology. The compact Abelian group G is called the Walsh group. A base for the neighborhoods of G can be given in the following way:

I_n(x) := I_n(x_0, ..., x_{n-1}) := \{ y \in G : y = (x_0, ..., x_{n-1}, y_n, y_{n+1}, ...) \},

where $x \in G$ and $n \in \mathbb{N}$. These sets are called dyadic intervals. Let $0 =$ $(0 : i \in \mathbb{N}) \in G$ denote the null element of G, and $I_n := I_n(0)$ $(n \in \mathbb{N})$. Set $e_n := (0, ..., 0, x_n = 1, 0, ...) \in G$ and

J_N^{m,l} := I_N(x_0, ..., x_m = 1, 0, ..., x_l = 1, 0, ..., 0), \quad l = 0, ..., N-1, \quad m = -1, ..., l.
$$

For $k \in \mathbb{N}$ and $x \in G$ denote

$$
r_k(x) := (-1)^{x_k}
$$

the k-th Rademacher function.

If $n \in \mathbb{N}$, then $n = \sum_{n=0}^{\infty}$ $i=0$ $n_i 2^i$ can be written, where $n_i \in \{0, 1\}$ $(i \in \mathbb{N})$, i. e. *n* is expressed in the number system of base 2. Denote $|n| := \max\{j \in$ $\mathbb{N}: n_j \neq 0$, that is $2^{|n|} \leq n < 2^{|n|+1}$.

The Walsh-Paley system is defined as the sequence of Walsh-Paley functions:

w_n(x) := \prod_{k=0}^{\infty} (r_k(x))^{n_k} = r_{|n|}(x) (-1)^{\sum_{k=0}^{|n|-1} n_k x_k} \quad (x \in G, n \in \mathbb{N}).
$$

The Walsh-Kaczmarz functions are defined by $\kappa_0 = 1$ and for $n \geq 1$

\kappa_{n}\left(x\right):=r_{|n|}\left(x\right)\prod_{k=0}^{|n|-1}\left(r_{|n|-1-k}\left(x\right)\right)^{n_{k}}=r_{|n|}\left(x\right)\left(-1\right)^{\sum_{k=0}^{|n|-1}n_{k}x_{|n|-1-k}}.
$$

Skvortsov (see [\[24\]](#page-11-10)) gave a relation between the Walsh-Kaczmarz functions and Walsh-Paley functions by the of the transformation $\tau_A : G \to G$ defined by

\tau_A(x) := (x_{A-1}, x_{A-2}, ..., x_1, x_0, x_A, x_{A+1}, ...),
$$

for $A \in \mathbb{N}$. By the definition we have

$$
\kappa_{n}\left(x\right)=r_{\left|n\right|}\left(x\right)w_{n-2^{\left|n\right|}}\left(\tau_{\left|n\right|}\left(x\right)\right),\qquad\left(n\in\mathbb{N},\,x\in G\right).
$$

The Dirichlet kernels are defined

$$
D_n^{\alpha} := \sum_{k=0}^{n-1} \alpha_k ,
$$

where $\alpha_n = w_n$ or κ_n ($n \in \mathbb{N}$), $D_0^{\alpha} := 0$. the 2ⁿ-th Dirichlet kernels have a closed form (see e.g. [\[19\]](#page-11-1))

(4)
$$
D_{2^n}^w(x) = D_{2^n}^{\kappa}(x) = D_{2^n}(x) = \begin{cases} 2^n & \text{if } x \in I_n, \\ 0 & \text{if } x \notin I_n \end{cases}
$$

The norm (or quasi-norm) of the space $L_p(G)$ is defined by

$$
\|f\|_p:=\left(\int_G|f|^p\,d\mu\right)^{1/p}\qquad(0
$$

The space $L_{p,\infty}(G)$ consists of all measurable functions f for which

$$
||f||_{L_{p,\infty}} := \sup_{\lambda>0} \lambda \mu \{|f| > \lambda\}^{1/p} \le c < \infty.
$$

The σ -algebra generated by the dyadic intervals of measure 2^{-k} will be denoted by F_k $(k \in \mathbb{N})$. Denote by $f = (f^{(n)}, n \in \mathbb{N})$ a martingale with respect to $(F_n, n \in \mathbb{N})$ (for details see, e. g. [\[31\]](#page-11-15)). The maximal function of a martingale f is defined by

f^* = \sup_{n \in \mathbb{N}} \left| f^{(n)} \right|.
$$

In case $f \in L_1(G)$, the maximal function can also be given by

$$
f^{*}(x) = \sup_{n \in \mathbb{N}} \frac{1}{\mu(I_{n}(x))} \left| \int_{I_{n}(x)} f(u) d\mu(u) \right|, \quad x \in G.
$$

For $0 < p < \infty$ the Hardy martingale space $H_p(G)$ consists of all martingales for which

$$
||f||_{H_p} := ||f^*||_p < \infty.
$$

The best approximation of $f \in L_p(G)$ $(1 \leq p \in \infty)$ is defined as

$$
E_n(f, L_p) = \inf_{\psi \in p_n} ||f - \psi||_p
$$

where p_n is set of all Walsh-Kaczmarz polynomials of order less than $n \in \mathbb{N}$.

The integrated modulus of continuity of the function $f \in L_p(G)$, is defined by

$$
\omega_p(1/2^n, f) = \sup_{h \in I_n} ||f(\cdot + h) - f(\cdot)||_p.
$$

The concept of modulus of continuity in $H_p(G)$ $(0 < p \le 1)$ is defined in the following way

$$
\omega_{H_p}(1/2^n, f) := \|f - S_{2^n}f\|_{H_p}.
$$

Since $||f||_{H_p} \sim ||f||_p$, when $p > 1$, we obtain that

$$
\omega_{H_p} (1/2^n, f) \sim \|f - S_{2^n} f\|_p, \quad p > 1.
$$

On the ather hand Watari [\[30\]](#page-11-20) showed that there are strong connection among $\omega_p(1/2^n, f)$, $E_{2^n}(f, L_p)$ and $||f - S_{2^n}f||_p$, $p \ge 1$, $n \in \mathbb{N}$. In particular

$$
\omega_p(1/2^n, f)/2 \le ||f - S_{2^n}f||_p \le \omega_p(1/2^n, f),
$$

and

$$
||f - S_{2^n}f||_p / 2 \le E_{2^n} (f, L_p) \le ||f - S_{2^n}f||_p.
$$

If $f \in L_1(G)$, then it is easy to show that the sequence $(S_{2^n} f : n \in \mathbb{N})$ is a martingale. If f is a martingale, that is $f = (f^{(0)}, f^{(1)}, ...)$ then the Walsh-(Kaczmarz)-Fourier coefficients must be defined in a little bit different way:

\widehat{f}(i) = \lim_{k \to \infty} \int_{G} f^{(k)}(x) \alpha_i(x) d\mu(x), \quad (\alpha_i = w_i \text{ or } \kappa_i).
$$

The Walsh-(Kaczmarz)-Fourier coefficients of $f \in L_1(G)$ are the same as the ones of the martingale $(S_{2^n} f : n \in \mathbb{N})$ obtained from f.

The partial sums and Fejér means of the Walsh-(Kaczmarz)-Fourier v of martingale $f \in H_p$ are defined by

$$
S_n^{\alpha}(f) := \sum_{i=0}^{n-1} \widehat{f}(i) \alpha_i, \quad \sigma_n^{\alpha}(f) = \frac{1}{n} \sum_{j=1}^{n} S_j^{\alpha}(f), \quad (\alpha = w \text{ or } \kappa)
$$

respectively.

The Fejér kernel of order n of the Walsh-(Kaczmarz)-Fourier series defined by

$$
K_n^{\alpha} := \frac{1}{n} \sum_{k=1}^n D_k^{\alpha}, \qquad (\alpha = w \text{ or } \kappa).
$$

A bounded measurable function a is p-atom, if there exists an interval I , such that

$$
\int_{I} ad\mu = 0, \qquad \|a\|_{\infty} \le \mu(I)^{-1/p}, \qquad \text{supp}\,(a) \subset I.
$$

For the martingale $f = \sum_{n=0}^{\infty} (f_n - f_{n-1})$ the conjugate transforms are defined as

$$
\widetilde{f^{(t)}} = \sum_{n=0}^{\infty} r_n(t) (f_n - f_{n-1}),
$$

where $t \in G$ is fixed. Note that $f^{(0)} = f$. As is well known (see [\[31\]](#page-11-15))

\left\| \widetilde{f^{(t)}} \right\|_{H_p} = \left\| f \right\|_{H_p}, \quad \left\| f \right\|_{H_p}^p \sim \int_G \left\| \widetilde{f^{(t)}} \right\|_p^p dt, \quad \widetilde{\sigma_n^{\kappa} f^{(t)}} = \sigma_n^{\kappa} \widetilde{f^{(t)}}.
$$

3. Formulation of Main Results

Theorem 1. a) Let $0 < p < 1/2$ and

$$
\omega_{H_p}\left(1/2^k,f\right)=o\left(1/2^{k(1/p-2)}\right), \text{ as } k\to\infty.
$$

Then

\|\sigma_n^{\kappa}(f) - f\|_{H_p} \to 0, \text{ when } n \to \infty.
$$

b) For any $p \in (0, 1/2)$ there exists a martingale $f \in H_p(G)$ for which

(7)
$$
\omega_{H_p}\left(1/2^k, f\right) = O\left(1/2^{k(1/p-2)}\right), \text{ as } k \to \infty.
$$

and

$$
\left\Vert \sigma_{n}^{\kappa}\left(f\right)-f\right\Vert _{L_{p,\infty}}\nrightarrow0,\text{ as }n\rightarrow\infty.
$$

Theorem 2. $a)$ Let

(8)
$$
\omega_{H_{1/2}}(1/2^k, f) = o(1/k^2), \text{ as } k \to \infty.
$$

Then

$$
\left\Vert \sigma_{n}^{\kappa}\left(f\right)-f\right\Vert _{H_{1/2}}\rightarrow0,\text{ when }n\rightarrow\infty.
$$

b) There exists a martingale $f \in H_{1/2}(G)$, for which

$$
\omega_{H_{1/2}}\left(1/2^k, f\right) = O\left(1/k^2\right), \quad \text{as } k \to \infty.
$$

and

$$
\left\|\sigma_n\left(f\right)-f\right\|_{1/2} \to 0 \text{ as } n \to \infty.
$$

4. AUXILIARY PROPOSITIONS

Lemma 1. [\[31\]](#page-11-15) A martingale $f = (f_n, n \in \mathbb{N})$ is in $H_p (0 < p \le 1)$ if and only if there exists a sequence $(a_k, k \in \mathbb{N})$ of p-atoms and a sequence $(\mu_k, k \in \mathbb{N})$ of real numbers such that for every $n \in \mathbb{N}$

(9)
$$
\sum_{k=0}^{\infty} \mu_k S_{M_n} a_k = f_n, \quad \text{a.e.}
$$

and

$$
\sum_{k=0}^{\infty} |\mu_k|^p < \infty.
$$

Moreover, $||f||_{H_p} \backsim \inf (\sum_{k=0}^{\infty} |\mu_k|^p)^{1/p}$, where the infimum is taken over all decomposition of f of the form [\(9\)](#page-5-0).

Lemma 2. [11] Let

5. Proof of the Theorems

Proof of Theorem 1. Let $0 < p < 1/2$. Combining [\(1\)](#page-1-0) and [\(5\)](#page-5-1) we conclude that

\|\sigma_n^{\kappa}f\|_{H_p}^p = \int_G \left\|\widetilde{\sigma_n^{\kappa}f^{(t)}}\right\|_p^p dt
$$

= \int_G \left\|\sigma_n^{\kappa}\widetilde{f^{(t)}}\right\|_p^p dt \le c_p n^{1-2p} \int_G \left\|\widetilde{f^{(t)}}\right\|_{H_p}^p dt
$$
\n

\sim c_p n^{1-2p} \int_G \|f\|_{H_p}^p dt = c_p n^{1-2p} \|f\|_{H_p}^p.
$$

Let $2^m < n \le 2^{m+1}$. Using [\(10\)](#page-6-0) we have that

\begin{aligned}\n&\|\sigma_n^{\kappa}f - f\|_{H_p}^p \\
&\leq \| \sigma_n^{\kappa}f - \sigma_n^{\kappa}S_{2^m}f\|_{H_p}^p + \|\sigma_n^{\kappa}S_{2^m}f - S_{2^m}f\|_{H_p}^p + \|S_{2^m}f - f\|_{H_p}^p \\
&= \| \sigma_n^{\kappa}(S_{2^m}f - f)\|_{H_p}^p + \|S_{2^m}f - f\|_{H_p}^p + \|\sigma_n^{\kappa}S_{2^m}f - S_{2^m}f\|_{H_p}^p \\
&\leq c_p \left(n^{1-2p} + 1 \right) \omega_{H_p}^p \left(1/2^m, f \right) + \| \sigma_n^{\kappa}S_{2^m}f - S_{2^m}f\|_{H_p}^p.\n\end{aligned}
$$

By simple calculation we get that

\sigma_n^{\kappa} S_{2^m} f - S_{2^m} f = \frac{2^m}{n} (S_{2^m} \sigma_{2^m} f - S_{2^m} f)
$$

$$
= \frac{2^m}{n} S_{2^m} (\sigma_{2^m} f - f).
$$

Let $p > 0$. By applying [\(3\)](#page-1-1) we obtain that

\begin{aligned}\n\|\sigma_n^{\kappa} S_{2^m} f - S_{2^m} f\|_{H_p}^p \\
&\leq \frac{2^{pm}}{n^p} \|S_{2^m} (\sigma_{2^m} f - f)\|_{H_p}^p \\
&\leq \|\sigma_{2^m} f - f\|_{H_p}^p \to 0, \text{ when } k \to \infty.\n\end{aligned}
$$

It follows that if

\omega_{H_p}(1/2^m, f) = o\left(1/2^{m(1/p-2)}\right), \text{ as } m \to \infty.
$$

then

\|\sigma_n^\kappa f-f\|_{H_p}\to 0, \text{ when } n\to\infty.
$$

Now, we are ready to prove second part of Theorem 1. We set

a_i(x) = 2^{i(1/p-1)} (D_{2^{i+1}}(x) - D_{2^i}(x)),
$$

and

f^{(n)}(x) = \sum_{i=0}^{n} \frac{1}{2^{(1/p-2)i}} a_i(x), \ n \in \mathbb{N}.
$$

It is easy to show that $f = (f^{(1)}, f^{(2)}, ..., f^{(n)}, ...) \in H_p$. Indeed, since

supp(a_i) = I_i, \quad \int_{I_i} a_i d\mu = 0

if we apply Lemma 1 we conclude that $f \in H_p$.

It is easy to show that

is a martingale. By using [\(13\)](#page-7-0) we get that

\omega_{H_p}(1/2^n, f)
$$

\leq \sum_{i=n+1}^{\infty} 1/2^{(1/p-2)i} \leq c/2^{(1/p-2)n} = O\left(1/2^{(1/p-2)n}\right).
$$

It is easy to show that

\hat{f}(j) = 2^i
$$
, if $j \in \{2^i, ..., 2^{i+1} - 1\}$, $i = 0, 1, ...$

By applying [\(3\)](#page-1-1) and [\(14\)](#page-7-1) we have that

\limsup_{n \to \infty} \|\sigma_{2n+1}^{\kappa}(f) - f\|_{L_{p,\infty}}\n= \limsup_{n \to \infty} \|\frac{2^n \sigma_{2n}^{\kappa}(f)}{2^n + 1} + \frac{S_{2n}(f)}{2^n + 1} + \frac{2^n \kappa_{2n}}{2^n + 1} - \frac{2^n f}{2^n + 1} - \frac{f}{2^n + 1}\|_{L_{p,\infty}}\n\geq \limsup_{n \to \infty} \frac{2^n}{2^n + 1} \|\kappa_{2n}\|_{L_{p,\infty}}\n- \limsup_{n \to \infty} \frac{2^n}{2^n + 1} \|\sigma_{2n}^{\kappa}(f) - f\|_{L_{p,\infty}}\n- \limsup_{n \to \infty} \frac{1}{2^n + 1} \|S_{2n}(f) - f\|_{L_{p,\infty}}\n> \limsup_{n \to \infty} \frac{2^n}{2^n + 1} - o(1) > 0.
$$

Theorem 1 is proved.

Proof of Theorem 2. Analogously of first part of Theorem 1 we can show that if modulus of continuity of the martingale $f \in H_{1/2}$ satisfies the condition [\(8\)](#page-5-2), then $\|\sigma_n^{\kappa}f - f\|_{H_{1/2}} \to \infty$, when $n \to \infty$.

Now, we are ready to prove the second part of theorem 1. We set

$$
a_i(x) = 2^{2^i} \left(D_{2^{2^i+1}}(x) - D_{2^{2^i}}(x) \right)
$$

and

$$
f^{(n)}(x) = \sum_{i=1}^{n} \frac{a_i(x)}{2^{2i}}.
$$

It is easy to show that $f = (f^{(1)}, f^{(2)}, ..., f^{(n)}, ...) \in H_{1/2}$. Indeed, since

S_{2^{A}}a_{i}(x) = \begin{cases} a_{i}(x), & 2^{i} < A, \\ 0, & 2^{i} \ge A \end{cases}

supp(a_i) = I_{2^i}, \quad \int_{I_{2^i}} a_i d\mu = 0, \quad \|a_i\|_{\infty} \leq (2^{2^i})^2 = (\mu(\text{supp } a_i))^2,
$$

if we apply Lemma 1 we conclude that $f \in H_{1/2}$. By simple calculation we get that

It is easy to show that

(16)

\widehat{f}(j) = \begin{cases} \frac{2^{2^i}}{2^{2i}}, & \text{if } j \in \left\{2^{2^i}, ..., 2^{2^i+1} - 1\right\}, i = 0, 1, ...\\ 0, & \text{if } j \notin \bigcup_{n=0}^{\infty} \left\{2^{2^n}, ..., 2^{2^n+1} - 1\right\}. \end{cases}
$$

Let $2^{2^i} < j \le q_{2^{i-1}}$. Since

$$
D_{s+2^{2i}}^{\kappa} = D_{2^{2i}} + r_{2^i} D_s^w (\tau_{2^i}), \quad \text{when } s < 2^{2^i}
$$

by applying [\(16\)](#page-9-0) we obtain that

$$
S_j^{\kappa} f = S_{2^{2^i}} f + \sum_{v=2^{2^i}}^{j-1} \widehat{f}(v) \kappa_v = S_{2^{2^i}} f + \frac{2^{2^i}}{2^{2i}} \sum_{v=2^i}^{j-1} \kappa_v
$$

=
$$
S_{2^{2^i}} f + \frac{2^{2^i}}{2^{2i}} \left(D_j^{\kappa} - D_{2^{2^i}} \right) = S_{2^{2^i}} f + \frac{2^{2^i} r_{2^i} D_{j-2^{2^i}}^w (\tau_{2^i})}{2^{2i}}.
$$

Hence

\sum_{j=2^{2^{i}}+1}^{q_{2^{i-1}}} S_{j}^{\kappa} f = \frac{q_{2^{i-1}-1} S_{2^{2^{i}}} f}{q_{2^{i-1}}} + \frac{2^{2^{i}} r_{2^{i}}}{q_{2^{i}} 2^{2^{i}}} \sum_{j=2^{2^{i}}+1}^{q_{2^{i-1}}} D_{j-2^{2k}}^{w} (\tau_{2^{i}})
$$

$$
= \frac{q_{2^{i-1}-1} S_{2^{2^{i}}} f}{q_{2^{i-1}}} + \frac{2^{2^{i}} r_{2^{i}}}{q_{2^{i-1}} 2^{2^{i}}} \sum_{j=1}^{q_{2^{i-1}-1}} D_{j}^{w} (\tau_{2^{i}})
$$

$$
= \frac{q_{2^{i-1}-1} S_{2^{2^{i}}} f}{q_{2^{i-1}}} + \frac{2^{2^{i}} r_{2^{i}} q_{2^{i-1}-1} K_{q_{2^{i-1}-1}}^{w} (\tau_{2^{i}})}{q_{2^{i-1}} 2^{2^{i}}}.
$$

By using [\(15\)](#page-8-0) we get that

$$

\geq \frac{c}{2^i} \|q_{2i-1-1} K_{q_{2i-1-1}}^w (\tau_{2i})\|_{1/2}^{1/2} - \left(\frac{2^{2^i}}{q_{2i-1}}\right)^{1/2} \|\sigma_{2^{2i}} f - f\|_{1/2}^{1/2}
$$

\n
$$
- \left(\frac{q_{2i-1}}{q_{2i-1}}\right)^{1/2} \|S_{2^{2i}} f - f\|_{1/2}^{1/2} = IV - V - VI.
$$

Let $x \in \underset{2^i}{J_2^{2^i-2s-1,2^i-2\eta-1}}$ $a_2^{2^i-2s-1,2^i-2\eta-1}$, where $\eta = 1,...,2^i-3, s = \eta + 3,...,2^i - 1$. By applying Lemma 2 we have that

q_{2^{i-1}-1}\left|K_{q_{2^{i-1}-1}}^{w}\left(\tau_{2^i}\left(x\right)\right)\right|\geq 2^{2\eta+2s-3}.
$$

By using [\(17\)](#page-9-1) we have that

\limsup_{i \to \infty} \|\sigma_{q_{2^{i-1}}}^{\kappa}(f) - f\|_{1/2} \ge c > 0.
$$

Theorem 2 is proved.
