# On the Existence of Rightly Continuous in  $H$  Leray-Hopf Solutions for the 3D Navier-Stokes Equations

#### **Abstract**

Kanyanov<sup>3</sup>, and take Tokano<sup>3</sup>.<br>In this ca In this note we prove that for each finite time interval [ $\tau$ , T] and each initial data  $y_\tau$  from the standard phase space H there exists a Leray-Hopf solution y on  $[\tau, T]$  of the 3D Navier-Stokes system such that  $y(\tau) = y_{\tau}$  and y is rightly continuous at each  $t \in [\tau, T)$  in the space H endowed with the strong convergence topology. Moreover, the real function  $t \to \|y(t)\|_H^2$  has a bounded total variation on  $[\tau, T]$ . The stronger, than Leray-Hopf one, energy inequalities for such solutions are obtained.

# **1 Introduction and Main Result**

Let  $\Omega \subset \mathbb{R}^3$  be a bounded domain with rather smooth boundary  $\Gamma = \partial \Omega$ , and  $[\tau, T]$  be a fixed time interval with  $-\infty < \tau < T < +\infty$ . We consider 3D Navier-Stokes system in  $\Omega \times [\tau, T]$

where  $y(x, t)$  means the unknown velocity,  $p(x, t)$  the unknown pressure,  $f(x, t)$  the given exterior force, and  $y_\tau(x)$  the given initial velocity with  $t \in [\tau, T]$ ,  $x \in \Omega$ ,  $\nu > 0$  means the viscosity constant.

Throughout this note we consider generalized setting of Problem (1.1). For this purpose define the usual function spaces

$$
\mathcal{V} = \{ u \in (C_0^{\infty}(\Omega))^3 : \text{div } u = 0 \}, \ V_{\sigma} = \text{cl}_{(H_0^{\sigma}(\Omega))^3} \mathcal{V}, \ \sigma \ge 0,
$$

where  $cl_X$  denotes the closure in the space X. Set  $H := V_0$ ,  $V := V_1$ . It is well known that each  $V_{\sigma}$ ,  $\sigma > 0$ , is a separable Hilbert space and identifying H and its dual  $H^*$  we have  $V_{\sigma} \subset H \subset V_{\sigma}^*$  with dense and

compact embedding for each  $\sigma > 0$ . We denote by  $(\cdot, \cdot)$ ,  $\|\cdot\|$  and  $((\cdot, \cdot))$ ,  $\|\cdot\|_V$  the inner product and norm in H and V, respectively;  $\langle \cdot, \cdot \rangle$  will denote pairing between V and V<sup>\*</sup> that coincides on  $H \times V$  with the inner product  $(\cdot, \cdot)$ . Let  $H_w$  be the space H endowed with the weak topology. For  $u, v, w \in V$  we put

$$
b(u,v,w)=\int_{\Omega}\sum_{i,j=1}^3u_i\frac{\partial v_j}{\partial x_i}w_jdx.
$$

It is known that b is a trilinear continuous form on V and  $b(u, v, v) = 0$ , if  $u, v \in V$ . As usual, for  $u, v \in V$ we denote by  $B(u, v)$  the element of  $V^*$  defined by  $\langle B(u, v), w \rangle = b(u, v, w)$ , for all  $w \in V$ .

Let  $f \in L^2(\tau, T; V^*) + L^1(\tau, T; H)$  and  $y_\tau \in H$ . Recall that the function  $y \in L^\infty(\tau, T; H)$  $L^2(\tau, T; V)$  with  $\frac{dy}{dt} \in L^1(\tau, T; V^*)$  is a *Leray-Hopf solution* of Problem (1.1) on  $[\tau, T]$ , if  $y(\tau) = y_\tau$ ,

\frac{d}{dt}(y,v) + \nu((y,v)) + b(y,y,v) = \langle f,v \rangle \text{, for all } v \in V,

and  $\gamma$  satisfies the energy inequality:

V_{\tau}(y(t)) \le V_{\tau}(y(s)) \quad \text{for all } t \in [s, T], \text{ a.e. } s > \tau \text{ and } s = \tau,
$$

For each  $f \in L^2(\tau, T; V^*) + L^1(\tau, T; H)$  and  $y_\tau \in H$  there exists at least one Leray-Hopf solution of Problem (1.1); Temam [11, Chapter III].

We recall that a realvalued function  $\psi$  on an interval  $[\tau, T] \subset \mathbb{R}$  is said to be of bounded variation on  $[\tau, T]$  if its total variation is finite, that is,  $\psi \in BV([\tau,T])$  if and only if  $\text{Var}_{[\tau,T]}(\psi) < \infty$ ; Guisty [7, p. 3]. According to Ziemer [\[12,](#page-5-1) p. 227 and Exercise 5.1 on p. 277]

for each  $\psi \in BV([\tau, T])$ .

The main result of this note has the following formulation.

<span id="page-1-1"></span>**Theorem 1.1.** *Let*  $-\infty < \tau < T < +\infty$ ,  $y_{\tau} \in H$ , and  $f \in L^2(\tau, T; V^*) + L^1(\tau, T; H)$ . Then there exists *a Leray-Hopf solution* y *of Problem (1.1) on* [τ, T] *that satisfies the following properties:*

- *(a)* the function  $t \to ||y(t)||_H^2$  is of bounded variation on  $[\tau, T]$ ;
- *(b) for each*  $t \in [\tau, T)$  *the following convergence holds:*

y(s) \rightarrow y(t)

 strongly in H as  $s \rightarrow t+$ ;

*(c)* y *satisfies the energy inequality*

$$
V_{\tau}(y(t)) \le V_{\tau}(y(s)) \quad \text{for all } t, s \in [\tau, T], \ t \ge s,

*where*  $V_{\tau}$  *is defined in formula (1.4).* 

**Remark 1.2.** Since a real function of bounded variation has no more than countable set of discontinuity points, then statement (a) of Theorem 1.1, weak continuity in Hilbert space  $H$  of each weak solution of Problem (1.1) on  $[\tau, T]$ , yield that the weak solution of Problem (1.1) on  $[\tau, T]$  from Theorem [1.1](#page-1-1) has no more than countable set of discontinuity points in the phase space  $H$  endowed with the strong convergence topology. Theorem 1.1 partially clarifies the results provided in Ball [1]; Balibrea et al. [2]; Barbu et al. [\[3\]](#page-4-3); Cao and Titi [4]; Chepyzhov and Vishik [5]; Cheskidov and Shvydkoy [6]; Kapustyan et al. [8]; Kloeden et al. [9]; Sohr [10] and references therein.

Remains 1.2, Since a real function of bended v *Proof of Theorem 1.1.* According to Temam [11, Chapter III] (see also Sohr [10, Chapter V] and references therein) there exists a Leray-Hopf solution y of Problem (1.1) on  $[\tau, T]$ , obtained via standard Galerkin arguments, that is if the following conditions hold:  $(i_1)$   $\{w_1, w_2, \ldots\} \subset V_{\frac{3}{2}}$  is the special basis, that is  $((w_j, v)) = \lambda_j(w_j, v)$  for each  $v \in V$  and  $j = 1, 2, \ldots$ , where  $0 < \lambda_1 \leq \lambda_2 \leq \ldots$  is the sequence of eigenvalues;  $(i_2)$   $P_m$  is the projection operator of H onto  $\text{span}\{w_1, \ldots, w_m\}$ , that is  $P_m v = \sum_{i=1}^m (v, w_i) w_i$ for each  $v \in H$ ,  $m = 1, 2, \ldots$  (of course we may consider  $P_m$  as a projection operator that acts from  $V_{\sigma}$ onto  $H_m$  for each  $\sigma \in [0, \frac{3}{2}]$  $\frac{3}{2}$ ] and, since  $P_m^* = P_m$ , we deduce that, for example,  $||P_m||_{\mathcal{L}(V^*_{\frac{3}{2}}; V^*_{\frac{3}{2}})} \leq 1$ ); (*i*<sub>3</sub>)

According to (2.10) and (2.11), we obtain

Since  $j = 1, 2, \ldots$  be an arbitrary and  $\varepsilon_j \to 0+$  as  $j \to \infty$ , then formulae (2.12) and (1.5) yield that J is nonincreasing on  $[\tau, T)$ . Therefore,

\text{Var}_{[\tau,T]}(J) \le |J(\tau) - J(T-)| + |J(T-) - J(T)| < \infty,
$$

that is statement (a) of Theorem 1.1 holds, and for each  $s \in [\tau, T)$

According  $u(2,10)$  and ( because  $\langle f(\,\cdot\,), y(\,\cdot\,)\rangle \in L^1(\tau,T)$  and  $\int_s^t \langle f(\xi), y(\xi)\rangle d\xi \to 0$  as  $t \to s+.$  Thus, statement (b) of Theorem [1.1](#page-1-1) holds, because  $y \in C([\tau, T]; H_w)$ , H is a Hilbert space, and inequality (2.13) takes place. Statement (c) of Theorem 1.1 follows from (2.3) and (2.13).
