# GAMMA CONVERGENCE OF A FAMILY OF SURFACE-DIRECTOR BENDING ENERGIES WITH SMALL TILT

#### Abstract

We prove a Gamma-convergence result for a family of bending energies defined on smooth surfaces in $\mathbb{R}^{3}$ equipped with a director field. The energies strongly penalize the deviation of the director from the surface unit normal and control the derivatives of the director. Such type of energies for example arise in a model for bilayer membranes introduced by Peletier and Röger [Arch. Ration. Mech. Anal. 193 (2009)]. Here we prove in three space dimensions in the vanishing-tilt limit a Gamma-liminf estimate with respect to a specific curvature energy. In order to obtain appropriate compactness and lower semi-continuity properties we use tools from geometric measure theory, in particular the concept of generalized Gauss graphs and curvature varifolds.

## 1. Introduction

Curvature functionals arise in many applications from physics and biology and have been intensively studied over the past decades. In the modeling of biomembranes a prominent example are shape energies of Canham-Helfrich type [4, 10]. These are of the general form

where $S$ denotes a surface in $\mathbb{R}^{3}$, $H$ and $K$ its mean and Gaussian curvature, and where the bending moduli $k_{1}, k_{2}$ and the spontaneous curvature $H_{0}$ are constant. In the simplest case of zero spontaneous curvature and for fixed topological type the functionals basically reduce to the Willmore functional, that has attracted a lot of attention [23, 13, 20].

Several refined models and variational approaches to derive such bending energies have been recently investigated, see for example [15, 16, 18, 21]. In [19] a meso-scale model for biomembranes has been introduced and has been shown to converge in the macro-scale limit in two dimensions to a generalized elastica functional. Together with M. A. Peletier we have addressed the three dimensional case [14] and have proved a general lower bound for the approximate functionals. Moreover we have (formally) identified the Gamma limit and have provided a corresponding limsup construction.

In this paper we study the asymptotic behavior of a closely related family of functionals and prove a compactness and liminf statement. The functionals are defined on compact
orientable surfaces $S \subset \mathbb{R}^{3}$ given as boundary of an open set in $\mathbb{R}^{3}$ and equipped with a Lipschitz continuous unit-vector field $\theta: S \rightarrow S^{2}$ satisfying $\theta \cdot \nu>0$, where $\nu: S \rightarrow S^{2}$ denotes the outer unit normal field of $S$. For such pairs we consider

where the linear map $L(p): \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ denotes the extension of $D_{S} \theta$ by $L \theta=0$, and where the quadratic form $Q$ is defined for an arbitrary square matrix $A \in \mathbb{R}^{3 \times 3}$ by

Q(A):=\frac{1}{4}(\operatorname{trace} A)^{2}-\frac{1}{6} \operatorname{trace} \operatorname{cof} A
$$

with cof $A$ denoting the cofactor matrix of $A$. Note that the first term in $\mathcal{Q}_{\varepsilon}$ penalizes the deviation of $\theta$ from the unit normal whereas the second term in the case of $\nu \equiv \theta$ reduces to the curvature functional

see Lemma A. 1 below.
The particular form $\mathcal{Q}_{\varepsilon}$ arises from [14], but can also be seen as a specific example of a more general class of functionals that are not only determined by the surface and its unit normal, but also depend on a director field and its deviation from the normal direction. This situation appears quite natural, see for example the discussion in Section 4 of 21] or the membrane energy in [11. We expect that our strategy to prove the variational convergence for the particular functionals $\mathcal{Q}_{\varepsilon}$ applies to a large class of similar models.

Letting $\varepsilon \rightarrow 0$ the functional $\mathcal{Q}_{0}$ is the natural candidate for the Gamma limit of $\mathcal{Q}_{\varepsilon}$ (with respect to convergence of the associated surface measures), at least in $C^{2}$-regular limit points. The corresponding limsup estimate follows from the existence of a recovery sequences proved in [14, Theorem 2.5]. Addressing the liminf inequality and compactness properties we face substantial difficulties: For a sequence $\left(S_{\varepsilon}, \theta_{\varepsilon}\right)$ as above, even in the 'best case' that $\theta_{\varepsilon} \equiv \nu_{\varepsilon}$ we only obtain an $L^{2}$-bound for the second fundamental form. This however only ensures weak compactness properties in spaces of generalized surfaces (for example in the class of Hutchinson's curvature varifolds, see below). In general, the situation is much worse: if $\theta_{\varepsilon}$ deviates from $\nu_{\varepsilon}$ we do not control the second fundamental form (not even the mean curvature) of the surfaces $S_{\varepsilon}$. This makes any partial integration formulas for derivatives of $\theta_{\varepsilon}$ (typically used to characterize curvatures in the limit) useless, as non-controlled curvature terms would appear. We therefore do not pass to the limit in the sense of varifolds but use rather techniques motivated by the theory of generalized Gauss graphs as developed by Anzellotti, Serapioni and Tamanini [2] and further developed in particular by Delladio in a series of papers [3, 5, 6, 7]. For a similar strategy in a related but different problem see [17.

Let us describe our approach in more detail: We consider the graphs $G_{\varepsilon}:=\left\{\left(p, \theta_{\varepsilon}(p)\right): p \in\right.$ $\left.S_{\varepsilon}\right\}$ of $\theta_{\varepsilon}$ over $S_{\varepsilon}$ and the associated currents. A bound on $\mathcal{Q}_{\varepsilon}\left(S_{\varepsilon}, \theta_{\varepsilon}\right)$ then implies a bound on the area of $G_{\varepsilon}$. Next, we expect that $\theta_{\varepsilon}$ becomes orthogonal to $S_{\varepsilon}$ when $\varepsilon$ is small (see the very definition of $\mathcal{Q}_{\varepsilon}$, and thus we expect that the limit $G$ of $G_{\varepsilon}$, in the sense of currents, is
the graph of a normal to a generalized surface $S$ in $\mathbb{R}^{3}$, that is a so called generalized Gauss graphs. For such currents a theory has been developed (see [2]) and precisely there exists a good and stable notion of curvatures which permits us to prove the key lower bound for the limit functional. Therefore we rephrase the energy functional in terms of the graph associated to $\left(S_{\varepsilon}, \theta_{\varepsilon}\right)$ and prove appropriate lower semicontinuity properties. Finally, we obtain that the limit is given by a curvature varifold in the sense of Hutchinson [12, which also induces a more concise form of the generalized limit energy.

The paper is organized as follows. First of all we give a precise introduction of the problem and we state the main results in Section 2 In Section 3 we review some facts from differential geometry and geometric measure theory that we need, in particular regarding generalized Gauss graphs and varifolds. Then, Section 4 is dedicated to the proof of the main Theorem [2.2 Finally, in the appendix we provide a more detailed description of the relation of the energy (1.2) to the mesoscale biomembrane energy analyzed in [19, [14] and recall some facts from linear and exterior algebra.

## 2. Setting of the problem and main results

We fix $\Omega \subset \mathbb{R}^{3}$ open. Let $\mathcal{M}$ be the set of tuples $(S, \theta)$, where $S$ is a compact and orientable surface of class $C^{2}$ in $\mathbb{R}^{3}$ that is given by the boundary of an open set $A(S) \subset \subset \Omega$, and where $\theta: S \rightarrow \mathbb{R}^{3}$ is a Lipschitz vector field such that

where $\nu: S \rightarrow \mathbb{R}^{3}$ denotes the outer unit normal field on $S$, and where $L(p): \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ is the extension of $D \theta(p): T_{p} S \rightarrow \mathbb{R}^{3}$ defined by the properties

Together with $|\theta|=1$ on $S$ this implies that

We next define the functional $\mathcal{Q}_{\varepsilon}: \mathcal{M} \rightarrow \mathbb{R}_{0}^{+}, \varepsilon>0$ by

for $(S, \theta) \in \mathcal{M}$, where the quadratic form $Q$ is defined for an arbitrary square matrix $A$ by

with $\operatorname{cof} A$ denoting the cofactor matrix of $A$.
Remark 2.1. By [14, Lemma 3.6] (see Lemma A.1 in the Appendix) $Q$ is a positive quadratic form in the 'nontrivial' eigenvalues of $D \theta$, more precisely: for any $p \in S$ such that $D \theta(p) \in$
$\mathbb{R}^{3 \times 3}$ exists,

where $\lambda_{1}(p), \lambda_{2}(p) \in \mathbb{R}$ are the eigenvalues of the restriction of $D \theta(p)$ to $\theta(p)^{\perp}$. This shows in particular, that $Q$ controls the full matrix $D \theta(p)$ and that in the case $\theta=\nu$ we have $Q(D \nu)=\frac{1}{4} H^{2}-\frac{1}{6} K$ and an $L^{2}$-control on the second fundamental form.

The main result are the following compactness and lower bound statements.
Theorem 2.2. Let $\left(\varepsilon_{j}\right)_{j \in \mathbb{N}}$ be an infinitesimal sequence of positive numbers and $\left(S_{j}, \theta_{j}\right)_{j \in \mathbb{N}}$ be a sequence in $\mathcal{M}$ such that

Assume furthermore that in the sense of Radon measures on $\Omega$

Then $\mu=\mu_{V}$ where $V$ is an integral varifold with generalized second fundamental form in $L^{2}$ and

holds, where $H$ and $K$ are, respectively, the mean curvature and the Gauss curvature of $V$ in the sense of Definition 3.3.

## 3. Currents and generalized Gauss graphs

Here we review some notions from differential geometry and discuss two generalizations of surfaces that we will use in the sequel: generalized Gauss graphs introduced by Anzellotti, Serapioni and Tamanini [2], and curvature varifolds in the sense of Hutchinson [12].
3.1. Differential geometry of smooth surfaces. Let $S$ be an oriented compact surface of class $C^{2}$, embedded in $\mathbb{R}^{3}$ and without boundary. Let $\nu: S \rightarrow S^{2}$ denote a $C^{1}$ unit normal field (Gauss map). The differential of the Gauss map in $p \in S$ defines a self-adjont linear map $D \nu(p): T_{p} S \rightarrow T_{p} S$, thus $D \nu(p)$ has two real eigenvalues $\kappa_{1}(p), \kappa_{2}(p)$, the principal curvatures of $S$ in $p$. We define the mean and Gaussian curvature by

H(p):=\operatorname{trace} D \nu(p)=\kappa_{1}(p)+\kappa_{2}(p), \quad K(p):=\operatorname{det} D \nu(p)=\kappa_{1}(p) \kappa_{2}(p),
$$

respectively. We denote by $P(p): \mathbb{R}^{3} \rightarrow T_{p} S$ the orthogonal projection on the tangent space. Extending functions $f \in C^{1}(S)$ to $C^{1}$-functions in a neighborhood of $S$ the covariant
derivative is expressed by $\delta_{i} f:=\sum_{j} P_{i j} \partial_{j} f, i=1,2,3$, on $S$ and is independent of the choice of extension.

By the divergence theorem on surfaces one derives [12, Sec. 5.1] that for all $\varphi \in C^{1}\left(\mathbb{R}^{3} \times\right.$ $\left.\mathbb{R}^{3 \times 3}\right), \varphi=\varphi(x, P)$

holds, where $\partial^{*}$ denotes derivatives with respect to the $P$ variables. This relation has been used by Hutchinson [12] to define a suitable notion of generalized surfaces as a class of integral varifolds with generalized second fundamental form, see Section 3.4 below.

To give a generalized formulation of the mean and Gaussian curvature we will use the following identities that hold in the smooth case.

Lemma 3.1. For a smooth surface $S$ with $C^{1}$ unit normal field $\nu$ let us extend $D \nu(p): T_{p} S \rightarrow$ $T_{p} S$ to a map $L(p): \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ by setting $L(p):=D \nu(p) \circ P(p)$. Then for all $p \in S$

hold, where $A_{i j k}:=\delta_{i} P_{j k}$.
Proof. We drop the dependence on $p$ for simplicity. To prove (3.2) we have, by the very definition of $L$,

To prove (3.3) first of all we notice that

& +\left(L_{11} \nu_{k}+L_{1 k} \nu_{1}\right)\left(L_{33} \nu_{k}+L_{3 k} \nu_{3}\right)-\left(L_{13} \nu_{k}+L_{1 k} \nu_{3}\right)\left(L_{31} \nu_{k}+L_{3 k} \nu_{1}\right) \\
& +\left(L_{22} \nu_{k}+L_{2 k} \nu_{2}\right)\left(L_{33} \nu_{k}+L_{3 k} \nu_{3}\right)-\left(L_{23} \nu_{k}+L_{2 k} \nu_{3}\right)\left(L_{32} \nu_{k}+L_{3 k} \nu_{2}\right) .

Now, by simple algebra, we obtain, since $\sum_{k} \nu_{k}^{2}=1$,

which yields the conclusion.
3.2. Rectifiable currents. We first fix some notation from exterior algebra, see the Appendix for a more detailed exposition.
We denote by $\Lambda^{k}\left(\mathbb{R}^{n}\right), 0 \leq k \leq n$ and by $\Lambda_{k}\left(\mathbb{R}^{n}\right)$ the spaces of all $k$-vectors and $k$-covectors, respectively, in $\mathbb{R}^{n}$. We call $v$ a simple 2-vector if $v$ can be written as $v=v_{1} \wedge v_{2}$. If in addition $v \neq 0$ the space $\operatorname{span}\left(v_{1}, v_{2}\right)$ is called the enveloping subspace. In the context of graphs it will be useful to distinguish two copies $\mathbb{R}_{x}^{3}$ and $\mathbb{R}_{y}^{3}$ of $\mathbb{R}^{3}$. The stratification of a 2 -vector $\Lambda^{2}\left(\mathbb{R}_{x}^{3} \otimes \mathbb{R}_{y}^{3}\right)$ is the unique decomposition

and is given by

where $\left\{e_{1}, e_{2}, e_{3}\right\}$ and $\left\{\varepsilon_{1}, \varepsilon_{2}, \varepsilon_{3}\right\}$ denote the standard basis for $\mathbb{R}_{x}^{3}$ and $\mathbb{R}_{y}^{3}$, respectively, and $\left\{d x^{1}, d x^{2}, d x^{3}\right\},\left\{d y^{1}, d y^{2}, d y^{3}\right\}$ the corresponding dual basis.

For $U \subseteq \mathbb{R}^{n}$ open and $k \in\{0, \ldots, n\}$ we denote by $\mathcal{D}^{k}(U)$ the space of all $k$-differential forms with compact support in $U$, equipped with usual topology of distributions.

The space $\mathcal{D}_{k}(U)$ of $k$-currents on $U$ is the dual of $\mathcal{D}^{k}(U)$. We denote by $\partial T \in \mathcal{D}_{k-1}(U)$ the boundary of $T \in \mathcal{D}_{k}(U)$ and the mass of $T \in \mathcal{D}_{k}(U)$ in $W \subset U$ open by $\mathbb{M}_{W}(T)$.

Given $E \subseteq \mathbb{R}^{n}$ we say that $E$ is $k$-rectifiable if $E$ can be covered by a countable family of sets $\left\{S_{j}\right\}, j \in \mathbb{N}$, such that $S_{0}$ is $\mathcal{H}^{k}$-negligible and $S_{j}$ is a $k$-dimensional surface in $\mathbb{R}^{n}$ of class $C^{1}$, for any $j>0$. It turns out that for $\mathcal{H}^{k}$-almost any $p \in E$ there is a well-defined measure-theoretic tangent space $T_{p} E$. We say that a map $p \in E \mapsto \eta(p)$ is an orientation on $E$ if such a map is $\mathcal{H}^{k}$-measurable and $\eta(p)$ is a unit simple $k$-vector on $\mathbb{R}^{n}$ that spans $T_{p} E$ for $\mathcal{H}^{k}$-almost any point $p \in E$. Let $\beta: E \rightarrow \mathbb{N}$ be a $\mathcal{H}^{k}$-locally summable function. Then, if $E \subset U$ with $U$ open in $\mathbb{R}^{n}$ we can define a current $T=\tau(E, \beta, \eta) \in \mathcal{D}_{k}(U)$ by

The function $\beta$ is also called the multiplicity of $T$. The set $\mathcal{R}_{k}(U)$ of currents $T \in \mathcal{D}_{k}(U)$ which can be written in the form $T=\tau(E, \beta, \eta)$ as above are called rectifiable currents.

The importance of the class of rectifiable currents stems mainly from the compactness property given by the following celebrated Federer-Fleming theorem (see for example [8]).

Theorem 3.2. Let $\left(T_{l}\right)_{l \in \mathbb{N}}$ be a sequence in $\mathcal{R}_{k}(U)$ such that $\partial T_{l} \in \mathcal{R}_{k-1}(U)$ for any $l \in \mathbb{N}$. Assume that for any $W$ relatively compact in $U$ there exists a constant $c_{W}>0$ such that

$$
\mathbb{M}_{W}\left(T_{l}\right)+\mathbb{M}_{W}\left(\partial T_{l}\right)<c_{W}
$$

Then, there exist a subsequence $l_{j} \rightarrow \infty$ and $T \in \mathcal{R}_{k}(U)$ such that $T_{l_{j}} \rightharpoonup T$ as $j \rightarrow+\infty$.
3.3. Generalized Gauss graphs. For the general theory of generalized Gauss graphs we refer the reader to [2]. To recall the motivation let first $S$ be a 2 -dimensional surface of class $C^{2}$ embedded in $\mathbb{R}^{3}$ and contained in an open set $\Omega \subset \mathbb{R}^{3}$, and let $\nu: S \rightarrow S^{2}$ be its Gauss map. It is convenient to distinguish the ambient space $\mathbb{R}_{x}^{3}$ of $S$ and the ambient space $\mathbb{R}_{y}^{3}$ of $\nu(S)$. Consider the graph of the Gauss map

$$
G:=\left\{(p, \nu(p)) \in \mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}: p \in S\right\}
$$

Then, $G$ is a 2-dimensional $C^{1}$ surface embedded in $\mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}$; if $S$ has boundary $\partial S$ then also $G$ has boundary given by

$$
\partial G=\{(p, \nu(p)): p \in \partial S\}
$$

We let $\Phi: S \rightarrow \mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}$ be given by $\Phi(p):=(p, \nu(p))$ which is of class $C^{1}$ on $S$. We equip $S$ with the orientation induced by $\nu$ and let $\tau(p):=* \nu(p)$, where

$$
*: \Lambda^{1}\left(\mathbb{R}^{3}\right) \rightarrow \Lambda^{2}\left(\mathbb{R}^{3}\right)
$$

is the Hodge operator.
Notice that in particular $\tau(p) \in \Lambda^{2}\left(T_{p} S\right)$ for any $p \in S$, thus the field $p \mapsto \tau(p)$ is a tangent 2 -vector field on $S$. We then define $\xi: G \rightarrow \Lambda^{2}\left(\mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}\right)$ as

$$
\xi(p, \nu(p)):=D \Phi_{p}\left(\tau_{1}(p)\right) \wedge D \Phi_{p}\left(\tau_{2}(p)\right), \quad \tau=\tau_{1} \wedge \tau_{2} .
$$

It is easy to see that $|\xi| \geq 1$, and thus we can normalize $\xi$ obtaining

$$
\eta:=\frac{\xi}{|\xi|}
$$

which is an orientation on $G$.
We then can associate to $G$ the current $T_{G} \in \mathcal{R}_{2}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$ given by $T=\tau(G, 1, \eta)$. This leads to the definition of generalized Gauss graphs as currents $T \in \mathcal{R}_{2}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$ that share certain additional properties which are in particular satisfied by weak limits of Gauss graphs $T_{G}$ associated to graphs of $C^{2}$ surfaces as above (see for example [2]). To prepare the definition we introduce two forms $\varphi^{*} \in \mathcal{D}^{2}\left(\mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}\right)$ and $\varphi \in \mathcal{D}^{1}\left(\mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}\right)$ given by

$$
\begin{align*}
\varphi(x, y) & :=\sum_{j=1}^{3} y_{j} d x^{j}  \tag{3.6}\\
\varphi^{*}(x, y) & :=\sum_{j=1}^{3}(-1)^{j+1} y_{j} d x^{1} \wedge \cdots \wedge d x^{j-1} \wedge d x^{j+1} \wedge \cdots \wedge d x^{3} . \tag{3.7}
\end{align*}
$$

Then we say that a current $T \in \mathcal{R}_{2}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$ is a generalized Gauss graph on $\Omega$ if $T=\tau(G, \beta, \eta)$ satisfies the following conditions:

$$
\begin{array}{r}
T \text { and } \partial T \text { are supported on } \Omega \times S^{2}, \\
\langle T, \varphi \wedge \omega\rangle=0, \quad \text { for all } \omega \in \mathcal{D}^{1}\left(\Omega \times \mathbb{R}_{y}^{3}\right), \\
\left\langle T, g \varphi^{*}\right\rangle \geq 0, \quad \text { for all } g \in C_{c}^{0}\left(\Omega \times \mathbb{R}_{y}^{3}\right) \text { such that } g \geq 0 . \tag{3.10}
\end{array}
$$

We denote by $\operatorname{curv}_{2}(\Omega)$ the set of generalized Gauss graphs on $\Omega$.
Condition (3.9) is equivalent to the orthogonality of $y$ and the enveloping subspace of $\eta(x, y)$ for $\mathcal{H}^{2}$ almost every $(x, y) \in G$ (see [7, Prop. 3.1]). The condition (3.10) fixes the orientation of $G$.

We associate to $T=\tau(G, \beta, \eta) \in \operatorname{curv}_{2}(\Omega)$ the stratifications $\eta_{0}, \eta_{1}, \eta_{2}$ as in (3.4) and define the Radon measures $|T|,\left|T_{0}\right|$ on $\Omega \times \mathbb{R}_{y}^{3}$ by

$$
\begin{equation*}
|T|:=\beta \mathcal{H}^{2}\left\llcorner G, \quad\left|T_{0}\right|:=\beta\left|\eta_{0}\right| \mathcal{H}^{2}\left\llcorner G, \quad\left|T_{1}\right|:=\beta\left|\eta_{1}\right| \mathcal{H}^{2}\llcorner G\right.\right. \tag{3.11}
\end{equation*}
$$

and the subset

$$
\begin{equation*}
G^{*}:=\left\{(x, y) \in G:\left|\eta_{0}\right|(x, y)>0\right\}, \tag{3.12}
\end{equation*}
$$

where the enveloping subspace of $\eta$ is not vertical.
3.4. Curvature varifolds. Let $G(2,3)$ denote the Grassmann manifold of all two-dimensional unoriented planes in $\mathbb{R}^{3}$. An integral 2 -dimensional varifold $V$ in $\mathbb{R}^{3}$ is a Radon measure on $\mathbb{R}^{3} \times G(2,3)$ of the special form $V=\mathcal{V}(S, \beta)$, i.e. it is characterized by

$$
V(\psi)=\int_{S} \psi\left(x, T_{x} S\right) \beta(x) d \mathcal{H}^{2}(x), \quad \text { for all } \psi \in C_{c}^{0}\left(\mathbb{R}^{3} \times G(2,3)\right)
$$

where $S \subset \mathbb{R}^{3}$ is a 2 -rectifiable set and where $\beta: S \rightarrow \mathbb{N}$ is locally $\mathcal{H}^{2}$-integrable. Then $\mu_{V}:=\beta \mathcal{H}^{2}\left\llcorner S\right.$ is a Radon measure on $\mathbb{R}^{3}$.

Following Hutchinson [12] an integral 2-varifold $V=\mathcal{V}(S, \beta)$ in $\mathbb{R}^{3}$ is a curvature varifold if there exist $V$-measurable functions $A_{i j k}: \mathbb{R}^{3} \times G(2,3) \rightarrow \mathbb{R}, 1 \leq i, j, k \leq 3$ such that for any $\varphi \in C^{1}\left(\mathbb{R}^{3} \times \mathbb{R}^{3 \times 3}\right)$ compactly supported with respect to the first variable

$$
\begin{equation*}
0=\int\left(\sum_{j} P_{i j} \partial_{j} \varphi+\sum_{j, k} A_{i j k} \partial_{j k}^{*} \varphi+\sum_{j} A_{j i j} \varphi\right) d V(x, P) \tag{3.13}
\end{equation*}
$$

where $P(x)=P_{i j}(x)$ denote the orthogonal projection on $T_{x} S$ and where we have used the notation from Section 3.1. Note that the latter equation corresponds to (3.1) for classical surfaces and that the function $A_{i j k}$ generalizes the derivative $\delta_{i} P_{j k}$ of the projection. In analogy with the representation for the smooth case given in Lemma 3.1] we define a generalized mean curvature and Gauss curvature for Hutchinson's varifolds.

Definition 3.3. For an curvature varifold $V$ as above and $\left(x, y^{\perp}\right) \in \operatorname{spt} V$ we define

$$
H_{j}\left(x, y^{\perp}\right):=\sum_{i} A_{i j i}\left(x, y^{\perp}\right), \quad K\left(x, y^{\perp}\right):=\sum_{k} \operatorname{trace} \operatorname{cof}\left(A_{i j k}\left(x, y^{\perp}\right)\right)_{i j} .
$$

For a curvature varifold $V$ there exist the weak mean curvature $\vec{H}_{V}$ of $V$ in the sense of Allard [1] and we have for almost all $\left(x, y^{\perp}\right) \in \operatorname{spt}(V)$ that $H_{j}\left(x, y^{\perp}\right)=\vec{H}_{V}(x) \cdot \overrightarrow{e_{j}}$. The functions $A_{i j k}$ are $V$-almost everywhere uniquely defined.

Consider now an oriented integral 2-dimensional varifold $V=\mathcal{V}^{o}\left(S, \tau, \beta_{+}, \beta_{-}\right)$, where $S$ is a 2-rectifiable set, $\beta_{ \pm}: S \rightarrow \mathbb{N}_{0}$ are $\mathcal{H}^{2}$-measurable with $\beta_{+}+\beta_{-} \geq 1$ and $\tau(x)$ is an orientation of $T_{x} S$, and where $V^{o}=\mathcal{V}^{o}\left(S, \tau, \beta_{+}, \beta_{-}\right)$is characterized by

$$
V^{o}(\psi):=\int_{S}\left[\psi(x, \tau(x)) \beta_{+}(x)+\psi(x,-\tau(x)) \beta_{-}(x)\right] d \mathcal{H}^{2}(x), \quad \text { for all } \psi \in C_{c}^{0}\left(\mathbb{R}^{3} \times \Lambda^{2}\left(\mathbb{R}^{3}\right)\right)
$$

According to [6, Def. 3.2] we call $V$ an oriented curvature varifold if there exist $\mathcal{H}^{2}$-measurable functions $B_{i j k}: S \times \Lambda^{2}\left(\mathbb{R}^{3}\right) \rightarrow \mathbb{R}$ such that for all $\psi \in C_{c}^{1}\left(\mathbb{R}_{x}^{3} \times \Lambda^{2}\left(\mathbb{R}^{3}\right)\right)$ and all $1 \leq i \leq 3$

$$
\begin{equation*}
\int\left(\sum_{j} \pi_{i j} \partial_{j} \psi+\sum_{l<m} B_{i l m} \partial_{l m}^{*} \psi+\psi \sum_{\substack{k<l}} \frac{\partial \pi_{i j}}{\partial p_{k l}} B_{j k l}\right) d V=0 \tag{3.14}
\end{equation*}
$$

where $\partial^{*}$ denotes derivatives with respect to the second component of $\psi$ and the map $\pi_{i j}: \mathbb{R}^{3} \times$ $\Lambda^{2}\left(\mathbb{R}^{3}\right) \rightarrow \mathbb{R}$ is given by $\pi_{i j}(x, w):=\left\langle w\left\llcorner e_{i}, w\left\llcorner e_{j}\right\rangle\right.\right.$. We notice that $\pi_{i j}(x, \tau)$ is the orthogonal projection on the enveloping subspace of $\tau$ whenever $\tau$ is simple.
3.5. Relation between curvature varifolds and generalized Gauss graphs. Let us associate to a generalized Gauss graph $T=\tau(G, \beta, \eta) \in \operatorname{curv}_{2}(\Omega)$ as above the set $S:=$ $\pi_{1} G \subset \mathbb{R}_{x}^{3}$, where $\pi_{1}: \mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3} \rightarrow \mathbb{R}_{x}^{3}$ denotes the projection on the first component. By the structure Theorem [2, Thm. 2.9] the set $S$ is 2-rectifiable and for any $\mathcal{H}^{2}$-measurable function $\nu: S \rightarrow \mathbb{R}^{3}$ with $\nu(x) \perp T_{x} S$ for $\mathcal{H}^{2}$-almost all $x \in S$

$$
\left.\pi_{1}\right|_{S} ^{-1}(x) \subset\{(x, \nu(x)),(x,-\nu(x))\}
$$

holds. We then let $V_{T}^{o}=\mathcal{V}^{o}(S, * \nu, \beta(\cdot, \nu), \beta(\cdot,-\nu))$ be the associated unoriented varifold to $T$. Moreover, we define an $\mathcal{H}^{2}$-measurable function $\gamma: S \rightarrow \mathbb{N}$ by

$$
\gamma(x):=\beta(x, \nu(x))+\beta(x,-\nu(x))
$$

and the associated integral 2-varifold $V_{T}=\mathcal{V}(S, \gamma)$.
We remark that by [6, Thm. 4.3] the set $\pi_{1}\left(G \backslash G^{*}\right)$ has $\mathcal{H}^{2}$-measure zero, where $G^{*}$ was defined in (3.12).

The following proposition relates the two concepts of Hutchinson's curvature varifolds and generalized Gauss graphs.

Proposition 3.4. Let $T=\tau(G, \beta, \eta) \in \operatorname{curv}_{2}(\Omega)$ be given and let $V_{T}=\mathcal{V}(S, \gamma)$ be the associated varifold as defined above. If $T$ satisfies $\partial T=0$ and $\left|T_{1}\right| \ll\left|T_{0}\right|$ then $V_{T}$ is a
curvature varifold and the functions $A_{i j k}$ in (3.13) and the mean curvature $H$ are given by

$$
\begin{align*}
A_{i j k}\left(x, y^{\perp}\right) & =\sum_{r} \xi_{0}^{i r}(x, y)\left(\bar{\xi}_{1}^{r j}\left(x, y^{\perp}\right) y_{k}+\bar{\xi}_{1}^{r k}\left(x, y^{\perp}\right) y_{j}\right)  \tag{3.15}\\
\bar{\xi}_{1}^{r j}\left(x, y^{\perp}\right) & =\frac{1}{\gamma(x)}\left(\beta(x, y) \xi_{1}^{r j}(x, y)+\beta(x,-y) \xi_{1}^{r j}(x,-y)\right)  \tag{3.16}\\
H_{j}\left(x, y^{\perp}\right) & =\sum_{i} A_{i j i}\left(x, y^{\perp}\right)=\sum_{i, r} \xi_{0}^{i r}(x, y) \bar{\xi}_{1}^{r i}\left(x, y^{\perp}\right) y_{j} \tag{3.17}
\end{align*}
$$

where $x \in S, \xi:=\frac{\eta}{\left|\eta_{0}\right|}$ on $G^{*}$ and where $y \perp T_{x} S,|y|=1$. (Note that the right-hand sides in (3.15) and (3.17) are in fact invariant under $y \mapsto-y$ since $\xi_{0}(x,-y)=-\xi_{0}(x, y)$.)

Proof. By [6, Thm. 3.1] since $\partial T=0$ and $\left|T_{1}\right| \ll\left|T_{0}\right|$ we have for the functions $B_{i j k}$ in (3.14)

$$
B_{i j k}(x, \tau)=\sum_{l} \varepsilon_{j k l}\left\langle\xi_{1}(x, * \tau), \varepsilon_{l} \wedge\left(\tau\left\llcorner e_{i}\right)\right\rangle,\right.
$$

where $x \in S, \tau=\tau_{1} \wedge \tau_{2}$ and $\xi:=\frac{\eta}{\left|\eta_{0}\right|}$ on $G^{*}$.
Observe now that $\tau=* y$ and $* \tau=y$ for some $y \perp T_{x} S$ with $|y|=1$. We therefore find that $\tau\left\llcorner e_{i}=\sum_{r} \xi_{0}^{i r}(x, y) e_{r}\right.$ and $\varepsilon_{l} \wedge\left(\tau\left\llcorner e_{i}\right)=-\sum_{r} \xi_{0}^{i r}(x, y) e_{r} \wedge \varepsilon_{l}\right.$, thus

$$
B_{i j k}(x, \tau)=-\sum_{r, l} \varepsilon_{j k l} \xi_{0}^{i r}(x, y) \xi_{1}^{r l}(x, y)
$$

Comparing (3.13) with (3.14) for $\psi(\cdot, \tau)=\varphi(\cdot, \pi)$ and using $\frac{\partial \pi_{j k}}{\partial p_{l m}}=-\varepsilon_{j l m} y_{k}-\varepsilon_{k l m} y_{j}$ we arrive at

$$
\begin{aligned}
& A_{i j k}\left(x, y^{\perp}\right)= \frac{1}{\gamma(x)} \sum_{l<m} \frac{\partial \pi_{j k}}{\partial p_{l m}}\left(\beta(x, y) B_{i l m}(x, \tau)-\beta(x,-y) B_{i l m}(x,-\tau)\right) \\
&= \frac{1}{\gamma(x)} \sum_{l<m}\left(\varepsilon_{j l m} y_{k}+\varepsilon_{k l m} y_{j}\right) \\
& \quad \cdot \sum_{r, s}\left(\beta(x, y) \varepsilon_{l m s} \xi_{0}^{i r}(x, y) \xi_{1}^{r s}(x, y)-\beta(x,-y) \varepsilon_{l m s} \xi_{0}^{i r}(x,-y) \xi_{1}^{r s}(x,-y)\right) \\
&= \frac{1}{\gamma(x)} \sum_{r}\left(\beta(x, y) \xi_{0}^{i r}(x, y)\left(y_{k} \xi_{1}^{r j}(x, y)+y_{j} \xi_{1}^{r k}(x, y)\right)-\right. \\
&\left.\quad-\beta(x,-y) \xi_{0}^{i r}(x,-y)\left(y_{k} \xi_{1}^{r j}(x,-y)+y_{j} \xi_{1}^{r k}(x,-y)\right)\right) \\
&= \frac{1}{\gamma(x)} \sum_{r} \xi_{0}^{i r}(x, y) y_{k}\left(\beta(x, y) \xi_{1}^{r j}(x, y)+\beta(x,-y) \xi_{1}^{r j}(x,-y)\right)+ \\
& \quad+\xi_{0}^{i r}(x, y) y_{j}\left(\beta(x, y) \xi_{1}^{r k}(x, y)+\beta(x,-y) \xi_{1}^{r k}(x,-y)\right)
\end{aligned}
$$

where we have used that $\xi_{0}(x,-y)=-\xi_{0}(x, y)$. This shows (3.15). For (3.17) observe that $\sum_{i} \xi_{0}^{i r}(x, y) y_{i}=0$ since $\xi_{0}=* y$.

## 4. Proof of theorem 2.2

In this section we prove Theorem 2.2. In order to characterize compactness properties of the sequence $\left(S_{j}, \theta_{j}\right), j \in \mathbb{N}$ we will associate to any $(S, \theta) \in \mathcal{M}$ a rectifiable current, given by the graph of $\theta$ over $S$. To be more precise let

$$
\begin{equation*}
G:=\{(p, \theta(p)): p \in S\} . \tag{4.1}
\end{equation*}
$$

Notice that $\theta$ is in general not orthogonal to $S$ and that $G$ therefore is not necessarily a Gauss graph. As above we distinguish the space $\mathbb{R}_{x}^{3}$, where the surface $S$ is embedded, and the ambient space $\mathbb{R}_{y}^{3}$ of the image of $\theta, \nu$. Consider the parametrization $\Phi: S \rightarrow \Omega \times \mathbb{R}_{y}^{3}$,

$$
\begin{equation*}
\Phi(p):=(p, \theta(p)), \quad \text { for } p \in S, \tag{4.2}
\end{equation*}
$$

of $G$ over the surface $S$.
From the calculations in Lemma A. 1 we know that $L(p)$ has eigenvalues $\lambda_{1}(p), \lambda_{2}(p), 0$ with an associated positively oriented orthonormal basis $\left\{v_{1}(p), v_{2}(p), \theta(p)\right\}$ of $\mathbb{R}^{3}$ given by eigenvectors of $L(p)$. Moreover, by (A.3) the eigenvalues of $L(p)$ are controlled by

$$
\begin{equation*}
\int_{S}\left(\lambda_{1}(p)^{2}+\lambda_{2}(p)^{2}\right) d \mathcal{H}^{2}(p) \leq 12 \int_{S} Q(L(p)) d \mathcal{H}^{2}(p) \tag{4.3}
\end{equation*}
$$

One key bound to obtain the compactness of the graphs $G_{j}$ associated to $\left(S_{j}, Q_{j}\right)$ is the control of their area.

Proposition 4.1. For $(S, \theta) \in \mathcal{M}, L$ as defined above, and the associated graph $G$ as in (4.1) we have

$$
\begin{equation*}
\mathcal{H}^{2}(G) \leq \mathcal{H}^{2}(S)+12 \int_{S} Q(L(p)) d \mathcal{H}^{2}(p) . \tag{4.4}
\end{equation*}
$$

Proof. Choose an orthonormal basis $\tau_{1}(p), \tau_{2}(p)$ of $T_{p} S$ and let us drop for the moment all arguments $p$. We then have

$$
\begin{equation*}
D \theta \tau_{i}=\sum_{k=1,2}\left(v_{k} \cdot D \theta \tau_{i}\right) v_{k}=\sum_{k=1,2} \lambda_{k}\left(v_{k} \cdot \tau_{i}\right) v_{k} . \tag{4.5}
\end{equation*}
$$

and obtain for the Jacobian of the parametrization $\Phi: S \rightarrow G$ of $G$

$$
\begin{align*}
(\mathrm{J} \Phi)^{2} & =\operatorname{det}\left(\binom{\tau_{i}}{D \theta \tau_{i}} \cdot\binom{\tau_{j}}{D \theta \tau_{j}}\right)_{i, j=1,2} \\
& =1+\left|D \theta \tau_{1}\right|^{2}+\left|D \theta \tau_{2}\right|^{2}+\left|D \theta \tau_{1}\right|^{2}\left|D \theta \tau_{2}\right|^{2}-\left(D \theta \tau_{1} \cdot D \theta \tau_{2}\right)^{2} \\
& =1+\lambda_{1}^{2}\left(1-\left(v_{1} \cdot \nu\right)^{2}\right)+\lambda_{2}^{2}\left(1-\left(v_{2} \cdot \nu\right)^{2}\right)+\lambda_{1}^{2} \lambda_{2}^{2}(\theta \cdot \nu)^{2} . \tag{4.6}
\end{align*}
$$

In particular we deduce that

$$
\begin{equation*}
1 \leq|\mathrm{J} \Phi| \leq 1+\left(\lambda_{1}^{2}+\lambda_{2}^{2}\right) . \tag{4.7}
\end{equation*}
$$

By (4.3) and the area formula we then obtain

$$
\mathcal{H}^{2}(G)=\int_{S}|\mathrm{~J} \Phi| \leq \mathcal{H}^{2}(S)+12 \int_{S} Q(L(p)) d \mathcal{H}^{2}(p)
$$

We next turn to some estimates related to the current associated to $G$. Let $\tau:=* \nu$ and note that $\nu=\tau_{1} \wedge \tau_{2}$, where $\left\{\tau_{1}(p), \tau_{2}(p), \nu(p)\right\}$ is any positively oriented orthornomal basis of $\mathbb{R}^{3}$. We then consider the tangent 2 -vector field $\xi$ on $G$ and the unit tangent 2-vector field $\eta$ on $G$, given by

$$
\begin{equation*}
\xi(p):=D \Phi_{p}\left(\tau_{1}(p)\right) \wedge D \Phi_{p}\left(\tau_{2}(p)\right), \quad \eta(p):=\frac{\xi(p)}{|\xi(p)|} \tag{4.8}
\end{equation*}
$$

and define the current $T_{G} \in \mathcal{R}_{2}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$ by

$$
\begin{equation*}
T_{G}:=\tau(G, 1, \eta), \tag{4.9}
\end{equation*}
$$

see Section 3. We first collect some useful information on $\xi$ and its stratifications, cf. (3.4).
Lemma 4.2. Let $\left\{e_{1}, e_{2}, e_{3}\right\}$ and $\left\{\varepsilon_{1}, \varepsilon_{2}, \varepsilon_{3}\right\}$ denote the standard basis of $\mathbb{R}_{x}^{3}$, $\mathbb{R}_{y}^{3}$, respectively. Let us further represent $\xi=\xi_{0}+\xi_{1}+\xi_{2}$ by its stratifications,

\xi_{2} & =D \theta \tau_{1} \wedge D \theta \tau_{2}, \quad \xi_{2}^{i j}=\sum_{k=1}^{3}\left(D \theta \tau_{1} \times D \theta \tau_{2}\right)_{k} \varepsilon_{i j k}=\lambda_{1} \lambda_{2}(\theta \cdot \nu)\left(v_{1} \wedge v_{2}\right)_{i j} \tag{4.13}

Proof. The assertions follow by straightforward calculations: concerning the identities involving $\lambda_{1}, \lambda_{2}$ we recall that

Then there exist a subsequence $j \rightarrow \infty$ (not relabeled) and generalized Gauss graph $T \in \operatorname{curv}_{2}(\Omega), T=\tau(G, \beta, \eta)$, such that

Applying the Federer-Fleming compactness Theorem 3.2 we deduce that $T_{j_{k}} \rightharpoonup T$ for some $T \in \mathcal{R}_{2}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$.

It remains to show that $T \in \operatorname{curv}_{2}(\Omega)$, i.e. that (3.8), (3.9) and (3.10) hold. First of all, since $T_{j}$ is supported in $\tilde{\Omega} \times S^{2}$ for any $j \in \mathbb{N}$ we obtain that $T$ is supported in $\Omega \times S^{2}$. Moreover, since $\partial T_{j}=\emptyset$ the convergence as currents also implies $\partial T=\emptyset$. Therefore, (3.8) is satisfied by $T$.

Since (4.17) holds for all $T_{j}$ we deduce that for any $\omega \in \mathcal{D}^{1}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$

where we have used (2.7) and (2.9). This shows (3.9). Similarly, from (4.18) for $T$ replaced by $T_{j}$ we obtain in the limit $j \rightarrow \infty$ (3.10). This concludes the proof that $T \in \operatorname{curv}_{2}(\Omega)$.

For the proof of (4.23) we follow [2, Prop. 2.8]. By (4.21) we have that for all $g \in C_{c}^{0}\left(\Omega \times \mathbb{R}_{y}^{3}\right)$

\end{align*}

where $\eta$ is evalutated at $(x, y)$, and where we have used that $G=\Phi(S)$ and

In our situation this is not the case, but the projection onto that eigenspace is small, see Lemma 4.10. We therefore consider a suitable modification of the quadratic form $u \mapsto u \cdot A_{y} u$.

for all $\phi \in C_{c}^{0}\left(\Omega \times \mathbb{R}_{y}^{3}, \Lambda^{2}\left(\mathbb{R}_{x}^{3} \times \mathbb{R}_{y}^{3}\right)\right)$. Thus we further obtain $\left|T_{1}\right| \ll\left|T_{0}\right|$ and, by (4.53)

It remains to show that we can identify the limit $\mu$ in (2.10) with the mass measure $\mu_{V_{T}}$ of the varifold $V_{T}$ associated to $T$. We first obtain for any $\psi \in C_{c}^{0}(\Omega)$ by the co-area formula and by (4.23)

As above, by [2, Theorem 2.10] we can choose for $\mathcal{H}^{2}$-almost every $(x, y) \in G^{*}$ an embedded $C^{1}$ surface $\Sigma \subset \mathbb{R}^{3}$ and a $C^{1} \operatorname{map} \zeta: \Sigma \rightarrow S^{2}$ with (4.29). In particular we then have

## Appendix A. Origin of the energy $\mathcal{Q}_{\varepsilon}$ and results from [14]

Here we briefly describe the origin of the energy $\mathcal{Q}_{\varepsilon}$ considered in this paper and recall some properties from [14.

Biomembranes are formed by lipid molecules that self-assemble into thin bilayer structures. In [19] a mesoscale model was introduced that prescribes an energy for idealized and rescaled head and tail densities; such a model arises from a micro-scale description in which heads and tails are treated as separate particles. Evaluated in density functions $u, v$ of tail and head particles, respectively, the energy takes the form

where $\int|\nabla u|$ is the total variation of $u, d_{1}(u, v)$ denotes the Monge-Kantorovich distance between $u$ and $v$ and for any $\varepsilon>0$ and fixed total mass $M_{T}>0$ we have set
$\mathcal{K}_{\varepsilon}:=\left\{(u, v) \in B V\left(\mathbb{R}^{n} ;\left\{0, \varepsilon^{-1}\right\}\right) \times L^{1}\left(\mathbb{R}^{n} ;\left\{0, \varepsilon^{-1}\right\}\right): \int u=\int v=M_{T}, u v=0\right.$ a.e. in $\left.\mathbb{R}^{n}\right\}$.
It was shown in [19] that this energy favors structures where the $u$ mass is organized in thin layers of thickness $2 \varepsilon$, surrounded by two $v$ layers. More precisely, it was proved in [19] that the rescaled energy functional

\mathcal{G}_{\varepsilon}:=\frac{\mathcal{F}_{\varepsilon}-2 M_{T}}{\varepsilon^{2}}
$$

in two space dimensions Gamma-converges to a generalized Euler elastica energy. In [14] an analysis of the three-dimensional case has been started. In Theorem 2.1 of that paper a lower estimate for $F_{\varepsilon}(u, v)$ was proved. This estimate is given in terms of the boundary of the set $\{u>0\}$ and the ray directions $\theta$ associated to the Monge-Kantorovich mass transport problem and takes the following form: Consider a smooth connected compact surface $S$ that is part of the boundary of $\{u>0\}$, let $\nu$ denote the inner unit normal field of $S$ and consider the Lipschitz vector field $\theta=\nabla \phi: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3},|\theta|=1$ that describes the ray direction. Then there exists a nonnegative measurable function $M: S \rightarrow \mathbb{R}$ such that $\theta \cdot \nu>0$ everywhere on $\{M>0\}$, and such that

with $Q$ as defined in (2.6). Considering a sequence ( $u_{\varepsilon}, v_{\varepsilon}$ ) with uniformly bounded energy we thus deduce that the mass distribution functions $M_{\varepsilon}$ have to approach 1, and that the ray directions have to become orthogonal to the boundary surfaces as $\varepsilon$ tends to zero.

This estimate suggests that the Gamma-limit of $\mathcal{G}_{\varepsilon}$ (with respect of convergence of $u_{\varepsilon}$ as measures) is given - for limit measures given by a sufficiently regular surface $S$ equipped with
unit density - by

where $H$ and $K$ are, respectively, the mean curvature and the Gauss curvature of $S$.
The corresponding upper estimate for $\mathcal{G}_{\varepsilon}$ has been proved in [14, Theorem 1.5]. The corresponding liminf estimate is much harder to obtain. The contribution of this paper is a major step in this direction: The functional $\mathcal{Q}_{\varepsilon}$ exactly corresponds to the right-hand side of (A.1), when we restrict ourselves to constant mass $M_{\varepsilon} \equiv 1$ and just one connected component $S_{\varepsilon}$ of the boundary $\partial\left\{u_{\varepsilon}>0\right\}$. In this sense we have addressed here the deviation of the director field from the normal, but have neglected an additional deviation in the mass distribution on the surfaces.

We finally restate a Lemma on the quadratic form $Q$ in (2.6) that we have used in the current paper.

Lemma B.1. Let $A, B \in \mathbb{R}^{3 \times 3}, y \in \mathbb{R}^{3}$ with $|y|=1$ and $B_{i j}:=\sum_{k} \varepsilon_{i j k} y_{k}$. Then

$$
\begin{align*}
& y \cdot \operatorname{cof} A y=\operatorname{trace} \operatorname{cof} B A,  \tag{B.2}\\
& y \cdot \operatorname{cof} A y=\sum_{k} \operatorname{trace} \operatorname{cof}\left(\sum_{r}\left(B_{i r} A_{r j} y_{k}+B_{i r} A_{r k} y_{j}\right)\right)_{i j} . \tag{B.3}
\end{align*}
$$

If additionaly $A y=0$ and $A^{T} y=0$ then we have

$$
\begin{align*}
& y \cdot \operatorname{cof} A y=\operatorname{trace} \operatorname{cof} A  \tag{B.4}\\
& y \cdot \operatorname{cof} A y=\sum_{k} \operatorname{trace} \operatorname{cof}\left(-A_{i j} y_{k}-A_{i k} y_{j}\right)_{i j} \tag{B.5}
\end{align*}
$$

Proof. Since $(\operatorname{cof} B)_{i j}=y_{i} y_{j}$ we have

$$
\text { trace } \operatorname{cof} B A=\sum_{i, k}(\operatorname{cof} A)_{i k}(\operatorname{cof} B)_{k i}=\sum_{i, k}(\operatorname{cof} A)_{i k} y_{i} y_{k}=y \cdot \operatorname{cof} A y
$$

which proves (B.2). Formula (B.3) follows by direct computation. For any $k=1,2,3$ let $C^{k} \in \mathbb{R}^{3 \times 3}$ with entries

$$
C_{i j}^{k}:=\sum_{r} B_{i r}\left(A_{r j} y_{k}+A_{r k} y_{j}\right)
$$

Then

$$
C^{k}=\left(\begin{array}{ccc}
0 & y_{3} & -y_{2} \\
-y_{3} & 0 & y_{1} \\
y_{2} & -y_{1} & 0
\end{array}\right)\left(\begin{array}{ccc}
A_{11} y_{k}+A_{1 k} y_{1} & A_{12} y_{k}+A_{1 k} y_{2} & A_{13} y_{k}+A_{1 k} y_{3} \\
A_{21} y_{k}+A_{2 k} y_{1} & A_{22} y_{k}+A_{2 k} y_{2} & A_{23} y_{k}+A_{2 k} y_{3} \\
A_{31} y_{k}+A_{3 k} y_{1} & A_{32} y_{k}+A_{3 k} y_{2} & A_{33} y_{k}+A_{3 k} y_{3}
\end{array}\right)
$$

By straightforward calculations we obtain, using $y_{1}^{2}+y_{2}^{2}+y_{3}^{2}=1$,

$$
\sum_{k} \operatorname{trace} \operatorname{cof} C^{k}=\sum_{i, j}(\operatorname{cof} A)_{i j} y_{i} y_{j}=y \cdot \operatorname{cof} A y
$$

Now assume that $A y=0$ and $A^{T} y=0$. In order to prove (B.4) we need two general results from the theory of matrices. First of all the equality

$$
\begin{equation*}
\operatorname{det}\left(M+y y^{T}\right)=\operatorname{det} M+y \cdot \operatorname{cof} M y \tag{B.6}
\end{equation*}
$$

holds true for any $M \in \mathbb{R}^{n \times n}$ and for any $y \in \mathbb{R}^{n}$ (see [22, Prop. 3.21]); moreover, the CayleyHamilton Theorem for a matrix $N \in \mathbb{R}^{3 \times 3}$ says that

$$
\begin{equation*}
\operatorname{det} N=\frac{(\operatorname{trace} N)^{3}-3 \operatorname{trace} N \operatorname{trace}\left(N^{2}\right)+2 \operatorname{trace}\left(N^{3}\right)}{6} \tag{B.7}
\end{equation*}
$$

Notice that since $A y=0$ and $y \neq 0$ we must have $\operatorname{det} A=0$, and therefore in order to prove (B.4), taking into account (B.6), it is sufficient to show that

$$
\begin{equation*}
\operatorname{det}\left(A+y y^{T}\right)=\operatorname{trace} \operatorname{cof} A \tag{B.8}
\end{equation*}
$$

Since $A y=A^{T} y=0$ we easily get

$$
\operatorname{trace}\left(\left(A+y y^{T}\right)^{2}\right)=\operatorname{trace}\left(A^{2}\right)+\operatorname{trace}\left(y y^{T} y y^{T}\right)=\operatorname{trace}\left(A^{2}\right)+1
$$

and

$$
\operatorname{trace}\left(\left(A+y y^{T}\right)^{3}\right)=\operatorname{trace}\left(A^{3}\right)+\operatorname{trace}\left(y y^{T} y y^{T} y y^{T}\right)=\operatorname{trace}\left(A^{3}\right)+1
$$

Using (B.7) we therefore obtain, since $\operatorname{det} A=0$,

$$
\begin{aligned}
\operatorname{det}\left(A+y y^{T}\right) & =\frac{(\operatorname{trace} A+1)^{3}-3(\operatorname{trace} A+1) \operatorname{trace}\left(\left(A+y y^{T}\right)^{2}\right)+2 \operatorname{trace}\left(\left(A+y y^{T}\right)^{3}\right)}{6} \\
& =\frac{(\operatorname{trace} A)^{2}-\operatorname{trace}\left(A^{2}\right)}{2} \\
& =(\operatorname{cof} A)_{11}+(\operatorname{cof} A)_{22}+(\operatorname{cof} A)_{33}
\end{aligned}
$$

which completes the proof of (B.8). Finally, (B.5) follows by direct computation: we easily have, for any $i=1,2,3$, using $y_{1}^{2}+y_{2}^{2}+y_{3}^{2}=1$ and $A y=A^{T} y=0$,

$$
\sum_{k} \operatorname{cof}\left(\begin{array}{lll}
-A_{11} y_{k}-A_{1 k} y_{1} & -A_{12} y_{k}-A_{1 k} y_{2} & -A_{13} y_{k}-A_{1 k} y_{3} \\
-A_{21} y_{k}-A_{2 k} y_{1} & -A_{22} y_{k}-A_{2 k} y_{2} & -A_{23} y_{k}-A_{2 k} y_{3} \\
-A_{31} y_{k}-A_{3 k} y_{1} & -A_{32} y_{k}-A_{3 k} y_{2} & -A_{33} y_{k}-A_{3 k} y_{3}
\end{array}\right)_{i i}=(\operatorname{cof} A)_{i i}
$$

and then (B.5) follows.
