Sum of states approximation by Laplace method with estimated error and application to limit theorems

Abstract

In this paper we consider a discrete many states system with given Entropy. We approximate the systems sum of states by using methodology of Laplace method for integrals. The estimate of the error term is included and two cases of Entropy are considered. When the maximum of the Entropy is in the interior of the domain of summation of states and on the boundary. As an application we obtain systems most probable state and its fluctuations in the thermodynamic limit. For that we prove weak law of large numbers and central limit theorem. The second result gives different limiting distributions for two cases mentioned above. When the maximum of the Entropy is in the interior of the summation domain it is Normal distribution and if it is on the boundary, it is Exponential or Discrete in one direction of summation and Normal in other directions.

1 Introduction

We consider a system with many accessible states, which are represented as the nods on some lattice of rational numbers. For each nod, i.e. state, we are given the number of configurations which system can take, i.e. Entropy. The number of accessible states and the Entropy depends on some parameter. As it increases the Entropy increases and the number of states also increase and the distances between nods become smaller. The function representing Entropy has a unique maximum on appropriate domain and is sufficiently regular.

The main results of the paper are approximations of the sum of states, i.e. sum of exponent of Entropies. Let us start with a result for one dimensional Entropy with maximum on the boundary of the domain of states summation. The methodology of the proof is based on analogical result for Laplace integral in [\[4\]](#page-20-0). Although this univariate case is rather insignificant in the physics context we need a specific estimates for further development.

Our main concern is with finite dimensional sums of states. For the integral instead of the sum it is proved in [\[4\]](#page-20-0) and in simplified form also in [\[3\]](#page-20-1). Here we use the same method and also include reminder estimate.

Let us consider an open set $\Omega \subset \mathbb{R}^m$ and lattice $L_N := \{ \frac{x}{N} \}$ $\frac{x}{N}: x \in \mathbb{N}^m$ where $N \in \mathbb{Z}_+$. Particularly for the system of particles N can represent number of particles and the set $\Omega \cap L_N$ accesible states of the system. Then we define a sum of states

where functions f, g and h are sufficiently regular and $f(\cdot, N)$ has as a unique maximum in the interior of Ω . Functions from the exponent represents Entropy of particular state.

The next result is an approximation of the sum We also define

with q , h as in [\(1\)](#page-1-0) and sufficiently regular f with unique non-critical maximum on the boundary $\{x : x_1 = 0\}$. Analogical result for integral is proved in [\[4](#page-20-0)]. This result, again, uses the same methodology and also includes the rate of convergence and explicit remainder estimate.

An alternative way of approximating sum of states of certain class of systems is developed in [\[6\]](#page-20-2).

For the application, we consider probability mass function where the probability of an event is constructed by taking sum of certain stats for the event and normalizing with the whole sum of states. We also consider a random vector whose values are the points of the domain of summation. This is usual approach in statistical mechanics to find most probable or mean states, see e..g [\[5\]](#page-20-3).

The first limit theorem, law of large numbers, gives us most probable state in the limit of N. It is equal to the point of maximum of the Entropy. The second result, central limit theorem, gives the distributions of the fluctuations from that state. They are different for two cases of maximum. When it is in the interior of the domain it is Normal, and when it is on the boundary there can be further two cases depending on how fast function h in the exponent increases. When it increases linearly it is Exponential in one direction and Normal in other directions. When slower than linearly it is Discrete in one direction and Normal in other directions.

Similar limit theorems but for integral instead of sum are developed in [\[4](#page-20-0)] and also for different class of systems are proved in [\[1](#page-20-4)]. Furthermore, the law of large numbers in this context is well understood in the theory of Large Deviation see e.g. [\[2\]](#page-20-5), so our main contribution are the precise rate of convergence under certain regularity assumptions on f and g .

2 Approximation by Laplace method

We consider an open set $\Omega \subset \mathbb{R}^m$ and a closed ball $\Omega' \subset \Omega$ with the center at the origin, radius ε and volume $|\Omega'|$. Further, for all $N \ge N_0$ with some $N_0 \in \mathbb{Z}_+$ we consider a lattice $L_N := \left\{ \frac{x}{N} \right\}$ $\frac{x}{N}, x \in \mathbb{N}^m$.

Then we introduce a function $f : \Omega \times \mathbb{Z}_+ \to \mathbb{R}$ for which derivatives up to third order exists on Ω' and are uniformly bounded. For all $N \geq N_0$, function $f(\cdot, N)$ have a unique maximum at $x^*(N) \in \Omega'$ such that

We choose the origin of our coordinate system to be the point $x^* = \lim_{N \to \infty} x^*(N)$. Further, we introduce a positive and increasing function $h : \mathbb{R}_+ \to \mathbb{R}$ such that $\lim_{N \to \infty} \frac{h(N)}{N} =$ 0 or $h(N) = N$.

We also consider function $g : \Omega \to \mathbb{R}$ differentiable in Ω' and define constants

Let us assume partition functions [\(1\)](#page-1-0) and [\(2\)](#page-1-1) are finite. Further,

(a) for the partition functions [\(1\)](#page-1-0) we assume $f(\cdot, N)$ has a nondegenerate maximum in the interior of Ω' and we introduce a constants

(b) for the partition function [\(2\)](#page-1-1) we assume $f(\cdot, N)$ has unique maximum on the boundary, i.e. $x^*(N) \in \{x : x_1 = 0\}$ and $\frac{\partial f(x^*(N), N)}{\partial x_1}$ $\frac{\Gamma(N),N}{\partial x_1} \neq 0$. We also introduce a constants

where $y = (x_2, \ldots, x_m)$ and D_y is a differential operator in that coordinates. Furthermore, we assume than on every section $\Omega'(x_1) = \{y : (x_1, y) \in \Omega'\}, x_1 \in [0, \varepsilon)$ we have a unique nondegenerate maximum.

Remark 1. The situation when the boundary of the domain is $\{x : x_1 = a\}$ with $a \in \mathbb{Q}_+$ can be reduced to the case of the boundary $\{x : x_1 = 0\}$ if we only consider N such that $Na \in \mathbb{Z}$. This is due to the fact that for those values the lattice L_N is preserved after appropriate shift of the coordinate system.

2.1 Univariate partition function

For the function f, h in [\(2\)](#page-1-1) with $\Omega = [0, \infty)$ we define a set

where parameter $\delta \in (0,1)$.

Additionally, let us define $N_1 := \max\left\{ \left[h^{-1} \left(\varepsilon^{\frac{1}{\delta-1}} \right) \right], N_0 \right\}$. For all $N \ge N_1$ set $U_N \subset \Omega'$ and we have following results

Preposition 1. For the function f in [\(2\)](#page-1-1) with $\Omega = [0, \infty)$ following approximation holds

Theorem 1. For the partition function [\(2\)](#page-1-1) with $\Omega = [0, \infty)$ following approximation holds

where $\delta \in (0, \frac{1}{2})$ $(\frac{1}{2}), \omega_B(N) = O(1)$ as $N \to \infty$ and

where ω_{UB} is defined in Preposition [1.](#page-3-0)

Proof of Preposition [1.](#page-3-0) Let us consider that $x = \frac{i}{\Delta}$ $\frac{i}{N}, i = 0, \ldots, I_N$, with $I_N = \left\lfloor \frac{N}{h(N)^{1-\delta}} \right\rfloor$, then we have $I_{\mathbf{M}}$

by the formula for the geometric series.

Then we estimate the last term by simple approximation of the sum with an integral

where the expression in the exponent is negative since by (10) derivative f' is negative in Ω' and as $I_N \geq \frac{N}{h(N)}$ $\frac{N}{h(N)^{1-\delta}}-1.$ \Box Hence we get the result of preposition.

Proof of Theorem [1.](#page-3-1) Let us introduce $S_B(N)$, $Z_B(N)$ and using Taylor's Theorem decompose $Z(N)$

Here and everywhere in the proofs x_{θ} denotes a point between x and the point at which the expansion is performed. It might be different in different instances. Now we put together above expressions

The the second term in the Taylor's Theorem can be bounded, $|f''(x_{\theta}, N)x^2| \leq F^{(2)}x^2$, where $F^{(2)}$ is defined by [\(13\)](#page-2-1).

Next, using above result, inequality $|e^t - 1| \leq |t|e^{|t|}$ and the fact that $x \leq h(N)^{-1+\delta}$ for any $x \in U_N$ yields

where G is defined by (4) . We need the last term in above inequality to be bounded, hence we set $\delta \in \left(0, \frac{1}{2}\right)$ $\frac{1}{2}$.

Then with use of Preposition [1](#page-3-0) we obtain an estimate

Next expression to approximate, $|Z_B(N) - S_B(N)|$, can be directly obtained from Preposition [1](#page-3-0)

Now let us consider sum $Z_{12}(N)$. Here again we apply second order Taylor's Theorem to obtain

since g has bounded derivative in U_N and $G^{(1)}$ is defined by [\(4\)](#page-2-2). Applying Preposition [1](#page-3-0) and using that $x \leq h(N)^{-1+\delta}$ we obtain

The size of the set $\Omega' \cap L_N$, which is the number of points of the lattice L_N in the interval $[0, \varepsilon)$, is bounded by $\varepsilon N + 1$. Hence we get

In case of $|Z_3(N)|$ we have following upper bound

2.2 Multivariate partition function with the maximum in the interior

For the function f in (1) we define sets

Remark 2. The situation when the boundary is an arbitrary hyperplane with rational coefficients can be reduced to the case with boundary $\{x : x_1 \geq 0\}$. This is due to that after appropriate rotation of coordinate system structure of the lattice essential for the application of the Theorem is preserved. That is, all the point of the domain can be represented as a series of equally spaced hyperplanes parallel to the boundary.

Due to summation over the set $\Omega' \cap L_N(x_1)$ the constants which occurs as a result of application of Theorem 2 can be replaced by the appropriate constants for a larger set Ω' which are independent of x_1 , that is [\(11\)](#page-2-8), [\(12\)](#page-2-9), [\(13\)](#page-2-1) and [\(14\)](#page-2-10).

3 Limit theorems

For the function f in [\(1\)](#page-1-0) and [\(2\)](#page-1-1) let us assume

Furthermore, for f in [\(1\)](#page-1-0) we assume that at x^* there is a nondegenerate maximum. In case of [\(2\)](#page-1-1) we assume $\frac{\partial f(x^*)}{\partial x_1}$ $\frac{f(x)}{\partial x_1}$ < 0 and w.r.t. coordinates (x_2, \ldots, x_m) there is a nondegenerate maximum at x^* .

Above equation implies

3.1 Weak law of large numbers

Theorem 4 (Weak law of large numbers). As $N \to \infty$ the random vector $X(N)$ converges in distribution to a constant x^* and following estimate of the mgf holds

Dividing the approximations of denominators and numerators yields

Preposition 3. For the function $\tilde{f}(x, N) := f(x, N) + \frac{1}{\sqrt{h}}$ $\frac{1}{h(N)}\xi^T(x^* - x)$ with $\xi > 0$ following approximations holds

Now, with use of above result we can prove following limit theorems valid for sufficiently large N

Theorem 5 (Central limit theorem I). For $X(N)$ with distribution [\(17\)](#page-15-2) the random vector $Z(N) = \sqrt{h(N)}(x^* - X(N))$ converges weakly to $\mathcal{N}(0, D^2 f(x^*)^{-1})$ and following estimate of the mgf holds

For $X(N)$ with distribution [\(18\)](#page-15-3) and assuming $\lim_{N\to\infty}\frac{h(N)}{N}=0$, the random vector $Z(N)=\big(h(N)(x_1^*-X_1(N)),\sqrt{h(N)}(y^*-Y(N))\big)$ $converges \ weakly\ to \ Exp\left|\frac{\partial f(x^*)}{\partial x_1}\right|$ $\frac{f(x^*)}{\partial x_1}$ | for $Z_1(N)$ and to $\mathcal{N}(0, D_y^2 f(x^*)^{-1})$ for $(Z_2(N), \ldots, Z_m(N))$. Furthermore, following estimate of the mgf holds

Theorem 7 (Central limit theorem III). For $X(N)$ with distribution [\(18\)](#page-15-3) and assuming $h(N) = N$ the random vector $Z(N) = (h(N)(x_1^* - X_1(N)), \sqrt{h(N)}(y^* - Y(N)))$ converges weakly to a discrete distribution with pmf

M_{Z(N)}(\xi) = \exp\left(h(N)\tilde{f}(\tilde{x}^*(N),N) - Nf(x^*(N),N)\right) \frac{1 - \left(\frac{h(N)}{N}\frac{\partial f(x^*(N),N)}{\partial x_1}\right)}{1 - \left(\frac{h(N)}{N}\frac{\partial \tilde{f}(\tilde{x}^*(N),N)}{\partial x_1}\right)} \times \frac{\sqrt{|\det D_y^2 f(x^*(N),N)|}}{\sqrt{|\det D_y^2 \tilde{f}(\tilde{x}^*(N),N)|}} \left(1 + \frac{O(1)}{h(N)^{1/2-3\delta}} + O(1)\frac{h(N)^{1/2+(m+1)\delta}}{N}\right).
$$

Since the first coordinate of $x^*(N)$ is independent of N we can consider f as a function of remaining $n-1$ coordinates. In that case it will have properties of f in [\(1\)](#page-1-0) and we can apply results of Preposition [3](#page-17-3) to obtain

$$
M_{Z(N)}(\xi) = \frac{1 - \left(\frac{h(N)}{N} \frac{\partial f(x^*(N), N)}{\partial x_1}\right)}{1 - \exp\left(\frac{h(N)}{N} \frac{\partial f(\tilde{x}^*(N), N)}{\partial x_1} - \frac{h(N)}{N} \xi_1\right)} \exp\left(\frac{1}{2} \xi_y^T D^2 f(x^*)^{-1} \xi_y\right) \times \\ \times \left(1 + \frac{O(1)}{h(N)^{1/2 - 3\delta}} + O(1) \frac{h(N)^{1/2 + (m+1)\delta}}{N} + O(1)\epsilon(N)\sqrt{h(N)}\right),
$$

where $\xi_y = (\xi_2, \ldots, \xi_m)$.

Next, we use first order Taylor's Theorem to obtain

$$
\left|\frac{\partial f(\widetilde{x}^*(N),N)}{\partial x_1} - \frac{\partial f(x^*,N)}{\partial x_1}\right| \le F^{(2)}\big(|\widetilde{x}^*(N) - x^*(N)| + |x^*(N) - x^*|\big),
$$

and with use of (15) , (16) and (19) get

$$
\frac{\partial f(\widetilde{x}^*(N), N)}{\partial x_1} = \frac{\partial f(x^*)}{\partial x_1} + \frac{O(1)}{\sqrt{h(N)}}.
$$

Analogical estimation procedure is for other derivative

$$
\frac{\partial f(x^*(N), N)}{\partial x_1} = \frac{\partial f(x^*)}{\partial x_1} + O(1)\epsilon(N).
$$

Using above estimates and approximation $e^x = 1 + x + O(x^2)$ if $x \to 0$ we obtain

$$
\left|\frac{1-\exp\left(\frac{h(N)}{N}\frac{\partial f(x^*(N),N)}{\partial x_1}\right)}{1-\exp\left(\frac{h(N)}{N}\frac{\partial f(\tilde{x}^*(N),N)}{\partial x_1}-\frac{h(N)}{N}\xi_1\right)}\right| = \left|\frac{\frac{\partial f(x^*(N),N)}{\partial x_1} + \frac{h(N)}{N}\frac{\partial f(x^*(N),N)}{\partial x_1}}{\partial x_1}}{\frac{\partial f(\tilde{x}^*(N),N)}{\partial x_1}-\xi_1+\frac{h(N)}{N}\frac{\partial f(\tilde{x}^*(N),N)}{\partial x_1}}{\frac{\partial f(\tilde{x}^*(N),N)}{\partial x_1}}\right| = \left|\frac{\frac{f(x^*)}{\partial x_1}\left(1+O(1)\varepsilon(N)+O(1)\frac{h(N)}{N}\right)}{\left(\frac{\partial f(x^*)}{\partial x_1}-\xi_1\right)\left(1+O(1)\frac{h(N)}{N}+\frac{O(1)}{\sqrt{h(N)}}\right)}\right| = \frac{\left|\frac{\partial f(x^*)}{\partial x_1}\right|}{\left|\frac{\partial f(x^*)}{\partial x_1}-\xi_1\right|}\left(1+\frac{O(1)}{\sqrt{h(N)}}+O(1)\frac{h(N)}{N}\right),
$$

and substituting that into last estimate of mgf yields the final result.

Proof of Theorem [7.](#page-17-6) The proof is similar to the previous one. Here we have $h(N) = N$ and therefore the main difference is in the last step. That is, using $e^x = 1 + O(x)$ if $x \to 0$ we obtain

$$
\left| \frac{1 - \exp\left(\frac{\partial f(x^*(N), N)}{\partial x_1}\right)}{1 - \exp\left(\frac{\partial f(\tilde{x}^*(N), N)}{\partial x_1} - \xi_1\right)} \right| = \frac{\left| 1 - \exp\left(\frac{\partial f(x^*)}{\partial x_1}\right) \right|}{\left| 1 - \exp\left(\frac{\partial f(\tilde{x}^*)}{\partial x_1} - \xi_1\right) + \frac{O(1)}{\sqrt{h(N)}} \right|} (1 + O(1)\varepsilon(N)) =
$$

=
$$
\frac{\left| 1 - \exp\left(\frac{\partial f(x^*)}{\partial x_1}\right) \right|}{\left| 1 - \exp\left(\frac{\partial f(\tilde{x}^*)}{\partial x_1} - \xi_1\right) \right|} \left(1 + \frac{O(1)}{\sqrt{h(N)}} \right),
$$

and substituting that into last estimate of mgf yields the final result.
