# Correlation functions in loop models B. Estienne and Y. Ikhlef

October 1, 2018

### Abstract

In this paper we provide a step towards the understanding of the  $O(n)$  bulk operator algebra. By using a mixture of analytical and numerical methods, we compute (ratios of) structure constants, and analyse the logarithmic structure of the transfer matrix. We believe that the  $O(n)$  model for a generic value of  $n = q + q^{-1}$  (*i.e.* for q not a root of unity) provides a toy model of a bulk logarithmic CFT that is considerably simpler than its counterparts at  $q$  a root of unity.

## <span id="page-1-0"></span>1 Introduction

The most striking phenomenon in statistical physics is maybe universality in the vicinity of a critical point. As a statistical system undergoes a second order phase transition, the correlation length diverges, various quantities become related through scaling relations, and many power-law divergences occur, governed by universal critical exponents. While this phenomenon is well explained in all dimensions by the ideas underlying the renormalisation group approach, it is extremely difficult to compute the universal properties in general. At the critical point the system becomes scale invariant, which is usually promoted to conformal invariance, and the system exhibits fractal behaviour. The corresponding field theory is called a conformal field theory (CFT).

Unlike in higher dimensions, the bidimensional conformal symmetry has infinitely many generators. This makes the CFT approach extremely powerful, and many critical exponents have been calculated exactly. This is the case for loop models such as the  $O(n)$  loop model and the Q-state Potts model, where the full spectrum has been known for some time [\[1\]](#page-44-0), including the critical exponents for geometric objects such as the fractal dimension of interfaces. These models are particularly interesting as they contain many primary fields which are non-scalar (*i.e.* fields with a non zero conformal spin). Both the  $O(n)$  model and the Q-state Potts model can be written as (non-local) loop models, which are well known to exhibit logarithmic behaviour. For this reason, the underlying CFTs are poorly understood beyond their spectrum.

A crucial part of the CFT data is given by its Operator Product Expansions (OPE), which are characterized by two main ingredients. The first one is the set of fusion rules, and the second one is the set of all structure constants, *i.e.* the three point functions between primary fields. Together these define the operator algebra, which has to be associative in a consistent field theory. For the  $O(n)$  model and  $Q$ state Potts model the operator algebra is mostly unknown, which means that we do not have a complete understanding of how to compute correlation functions. Only a handful of structure constants have been obtained through an analytic continuation of the Liouville theory [\[2,](#page-44-1) [3\]](#page-44-2), but this method does not work for fields with a nonzero magnetic charge: a simple example where it fails is the probability for three given points to lie on the same loop.

Our objective is to describe the full operator algebra of these models, and in this paper we present a step in that direction. We focus on the Temperley-Lieb (TL) model, which is the loop model description of the Q-state Potts model. Moreover we restrict ourselves to generic values of the loop weight n (*i.e.*  $n = q + q^{-1}$  with q not a root a unity).

The first tool we use is the Coulomb Gas description of the TL model. We extend the analysis of crossing symmetry of four-point functions to the case of non-scalar primary fields. While a subset of the structure constants can be extracted this way, charge neutrality proves to be a strong limitation on the set of structure constants for non-scalar fields that can be accessed with this approach. Therefore we turn to a more powerful approach inspired by the bootstrap of Liouville theory [\[4\]](#page-44-3). It is a well known fact of CFT that the decoupling of a null vector yields a differential equation for correlation functions. In conjunction with crossing symmetry, it is possible to compute ratios of structure constants. Using an extension of the bootstrap method to the case of non-scalar fields, we make predictions for many ratios of structure constants. An interesting remark is the appearance of logarithms in some four-point functions, as expected from such non-diagonalisable CFTs. We also compute numerically these structure constants on the lattice, and we find an excellent agreement with our analytical calculation.

The logarithmic nature of the CFT raises a fundamental question regarding the bootstrap approach : do null-vectors decouple in the scaling theory of the  $O(n)$ model? Indeed, while in a unitary CFT the null vectors  $-i.e.$  states with a vanishing norm – always decouple, logarithmic CFTs [\[5,](#page-44-4) [6,](#page-44-5) [7,](#page-44-6) [8\]](#page-44-7) are known to have a nondefinite inner product, allowing states of zero norm to have a non-vanishing inner product with other states. This is typically what happens in non-trivial Jordan cells of a logarithmic CFT. These questions can be also be addressed on the lattice: for the TL model the Jordan cells can already be observed in finite size on the lattice model (see [\[9,](#page-44-8) [10,](#page-45-0) [11,](#page-45-1) [12,](#page-45-2) [13\]](#page-45-3)), and this provides a powerful tool to analyse the decoupling of null-vectors.

The paper is organised as follows. In Sec. [2,](#page-3-0) we recall the definition of lattice loop models, and review the operator content of the corresponding compact boson CFT (with a background charge) in the scaling limit [\[14,](#page-45-4) [1\]](#page-44-0). In Sec. [3,](#page-8-0) we generalise the Coulomb-Gas [\[15,](#page-45-5) [16\]](#page-45-6) and conformal bootstrap [\[4,](#page-44-3) [17\]](#page-45-7) approaches to determine a family of OPE coefficients in this CFT. In Sec. [4,](#page-23-0) we come back to the lattice to study the exact Jordan blocks appearing in the spectrum of the transfer matrix (or Hamiltonian) of the loop models, and then discuss the associated structures in the CFT. Moreover, we give an example of analytic calculation of the indecomposability parameter  $\beta$  in one of these Jordan blocks. Finally, we present some open questions and perspectives in Sec. [5.](#page-37-0) In the Appendix, some technical details of our analytical calculations are given, and our numerical method to compute OPE coefficients is outlined.

## <span id="page-3-0"></span>2 The  $O(n)$  and Temperley-Lieb loop models

## <span id="page-3-1"></span>2.1 Lattice models

The  $O(n)$  loop model on the honeycomb lattice [\[14\]](#page-45-4) consists in configurations of non-intersecting closed polygons. A configuration  $C$  is given the Boltzmann weight

$$
W_{O(n)}(C) = K^{\ell(C)} n^{N_c(C)} \tilde{n}^{N_{\rm nc}(C)}, \qquad (2.1)
$$

where  $\ell(C)$  is the total length of polygons in C,  $N_c(C)$  is the number of contractible loops in C, and  $N_{\rm nc}(C)$  is the number of non-contractible loops in C (see Fig. [1\)](#page-4-0).

For fixed  $n, \tilde{n}$  both in the interval  $[-2, 2]$ , the  $O(n)$  loop model has two distinct critical regimes: (i) when K is at the critical value  $K_c = 1/\sqrt{2 + \sqrt{2-n}}$ , for example critical polymers  $(n = 0)$ , critical Ising domain walls  $(n = 1)$ , XY model  $(n = 2)$ ; (ii) when  $K > K_c$ , the model is in the universality class of the Q-state Potts model, with  $n = \sqrt{Q}$ . In this paper, we will mainly focus on the universality class ii, since it has a simpler realisation, namely the Temperley-Lieb model.

The Temperley-Lieb model is defined on the square lattice, and consists in completely packed configurations of non-intersecting closed polygons, as shown in Fig. [2.](#page-4-1) A configuration  $C$  is given the Boltzmann weight

$$
W_{\rm TL}(C) = n^{N_c(C)} \tilde{n}^{N_{\rm nc}(C)}, \qquad (2.2)
$$

with the same notations as above. For completeness, we recall the relation [\[18\]](#page-45-8) between the Potts and TL models, in the case of a planar domain, and for  $n = \tilde{n}$ . Consider the Q-state Potts model on the lattice  $\mathcal{L}$ , with spin variables  $\{s_i\}$  and Boltzmann weights  $\exp(J\sum_{\langle ij\rangle}\delta_{s_i,s_j})$ . The partition function can be graphically expanded using the identity  $\exp(J\delta_{s_i,s_j}) = 1 + v\delta_{s_i,s_j}$ , where  $v = e^J - 1$ . This gives the Fortuin-Kasteleyn partition function

$$
Z_{\text{Potts}} = \sum_{\text{clusters}} Q^{\text{\#connected components}} v^{\text{\#occupied edges}}, \qquad (2.3)
$$

where the sum is over all possible subgraphs (or "cluster configurations") of the lattice  $\mathcal{L}$ . Each cluster configuration can in turn be associated uniquely to a loop configuration of the TL model on the medial lattice  $\mathcal{M}$ , i.e. the lattice connecting the midpoints of adjacent edges of  $\mathcal{L}$ : see Fig. [2.](#page-4-1) Using the Euler relation, one gets

$$
Z_{\text{Potts}} = Q^{N_s(\mathcal{L})} \times \sum_{\text{loop config. } C} (v/\sqrt{Q})^{N_e(C)} \sqrt{Q}^{N_\ell(C)}, \qquad (2.4)
$$

where  $N_s(\mathcal{L})$  is the number of sites of  $\mathcal{L}$ ,  $N_e(C)$  is the number of edges of  $\mathcal{L}$  not crossed by the loops, and  $N_{\ell}(C)$  is the number of closed loops.

## <span id="page-3-2"></span>2.2 Scaling limit: compact boson CFT

The emergence of a compact boson in the scaling limit is best described for the honeycomb  $O(n)$  model on a torus. Take a configuration C of the  $O(n)$  model, and

give an orientation to each loop, independently of the others. Then, define discrete height variables  $\{\phi_i\}$  at the centers of faces of the honeycomb lattice, so that the oriented loops are their contour lines, with a step  $\pm\pi$  across each contour line: see Fig. [3.](#page-6-1)

Note that, for a contractible loop oriented anti-clockwise (resp. clockwise), the algebraic number of turns to the left is  $+6$  (resp.  $-6$ ). Hence, the factor  $n^{N_c(C)}$ in [\(2.2\)](#page-3-3) can be distributed locally by assigning each left (resp. right) turn a phase factor  $e^{i\chi}$  (resp.  $e^{-i\chi}$ ), with  $n = 2\cos 6\chi$ .

In the scaling limit, it can be argued that the coarse-grained analog of  $\phi_j$  is a free scalar field  $\phi(\vec{r})$ . Moreover, the free scalar field  $\phi(\vec{r})$  has to be compact. Indeed, a given cycle of the torus may be crossed by a non-zero flux  $2m$  of arrows (with  $m \in \mathbb{Z}/2$  for honeycomb  $O(n)$  and  $m \in \mathbb{Z}$  for TL), which results in a defect  $\delta\phi = 2\pi m$  for the height variable. The effective model for both critical regimes of the  $O(n)$  model and for the TL model is thus a compactified boson

$$
A[\phi] = \frac{g}{4\pi} \int d^2r \, (\nabla \phi)^2, \qquad \begin{cases} \phi \equiv \phi + \pi & \text{for honeycomb } O(n), \\ \phi \equiv \phi + 2\pi & \text{for TL.} \end{cases} \tag{2.5}
$$

The renormalised value of the coupling constant  $q$  can be fixed in terms of  $n$  using e.g. exact Bethe Ansatz determination of one critical exponent [\[18\]](#page-45-8). It is found to be

$$
n = -2\cos\pi g, \qquad \begin{cases} 1 < g < 2 \quad \text{for } K = K_c, \\ 0 < g < 1 \quad \text{for } K > K_c \text{ or in the TL model.} \end{cases} \tag{2.6}
$$

For non-contractible loops, the local phase factors defined above cancel each other, so one must introduce an additional topological factor related to the height defects  $\delta\phi$  and  $\delta'\phi$  along the two cycles of the torus. Simple geometric arguments show that the partition function on the torus is given by [\[1\]](#page-44-0)

$$
Z_{\mathcal{O}(n)} = \sum_{m,m' \in \mathbb{Z}/2} \int_{\delta\phi = 2\pi m} [D\phi] e^{-A[\phi]} \cos[\pi e_0 (2m) \wedge (2m')] , \qquad (2.7)
$$

where the symbol ∧ stands for the greatest common divider, and

$$
\widetilde{n} = 2\cos\pi e_0. \tag{2.8}
$$

For the TL model, we consider a torus consisting of  $L \times M$  lattice steps, with L and M both even. Then the defects must be of the form  $\delta \phi = 2\pi m$ , with  $m \in \mathbb{Z}$ . Using the same line of argument as for the honeycomb  $O(n)$  model, one gets the partition function

$$
Z_{\text{TL}} = \sum_{m,m' \in \mathbb{Z}} \int_{\delta\phi = 2\pi m} [D\phi] e^{-A[\phi]} \cos(\pi e_0 m \wedge m'). \qquad (2.9)
$$

In both cases, the insertion of the topological factor changes the dependence of Z on the system size, and hence it affects the central charge, which becomes

$$
c = 1 - \frac{6e_0^2}{g}.
$$
\n(2.10)

To make contact with the Coulomb-gas notations [\[15,](#page-45-5) [16\]](#page-45-6), we introduce the background charge  $-2\alpha_0 = e_0/\sqrt{g}$ , and the central charge is given by  $c = 1 - 24\alpha_0^2$ .

## <span id="page-6-0"></span>2.3 Vertex operators

To discuss the operator content of the CFT associated to the loop model, we shall use the geometry of the plane, with complex coordinates  $(z, \bar{z})$ . The height field  $\phi$ can be expanded on holomorphic and anti-holomorphic modes, and one defines the dual field  $\theta$  as:

$$
\phi(z,\bar{z}) = \varphi(z) + \bar{\varphi}(\bar{z}), \qquad \theta(z,\bar{z}) = \varphi(z) - \bar{\varphi}(\bar{z}). \tag{2.11}
$$

A chiral vertex operator  $V_{\alpha}$ , with conformal dimension  $h(\alpha)$ , is given by

$$
V_{\alpha}(z) = : \exp[i\sqrt{4g} \; \alpha \; \varphi(z)] : \qquad h(\alpha) = \alpha^2 - 2\alpha\alpha_0, \tag{2.12}
$$

where  $:\cdots:$  denotes normal ordering. A general vertex operator is of the form

$$
\mathcal{V}_{\alpha,\bar{\alpha}}(z,\bar{z}) = :e^{i\sqrt{4g}[\alpha\varphi(z)+\bar{\alpha}\bar{\varphi}(\bar{z})]}:
$$
\n(2.13)

Let us recall a heuristic argument relating vertex operators to "spin-wave" (electric) and "vortex" (magnetic) excitations of the height variable  $\phi$ . First, if  $\alpha = \bar{\alpha} = \alpha_{el}$ , the vertex operator has the form  $V_{\text{el}} = \exp(i \sqrt{4g} \alpha_{\text{el}} \phi)$ : and is single-valued only if  $\sqrt{4g\alpha_{\rm el}}$  is a multiple of the inverse compactification radius :

$$
\alpha_{\rm el} = \frac{k}{\sqrt{4g}}, \qquad \begin{cases} k \in 2\mathbb{Z} & \text{for honeycomb } O(n), \\ k \in \mathbb{Z} & \text{for TL.} \end{cases} \tag{2.14}
$$

A second interesting case is when  $\alpha = 2\alpha_0 - \bar{\alpha} = \alpha_{\text{mag}}$ . Then the vertex operator has the form

$$
\mathcal{V}_{\text{mag}} = :\exp(i\sqrt{4g} \; \alpha_0 \; \phi) \times \exp[i\sqrt{4g} \; (\alpha_{\text{mag}} - \alpha_0)\theta]: \tag{2.15}
$$

where the first factor cancels the background charge, and the second factor creates a defect of height  $\delta\phi = 8\pi(\alpha_{\text{mag}} - \alpha_0)/\sqrt{4g}$ , which must be a (half-)integer multiple of  $2\pi$ :

$$
\alpha_{\text{mag}} = \alpha_0 - \frac{m\sqrt{g}}{2}, \qquad \begin{cases} m \in \mathbb{Z}/2 & \text{for honeycomb } O(n), \\ m \in \mathbb{Z} & \text{for TL.} \end{cases} \tag{2.16}
$$

More generally, we introduce the notation for vertex operator charges

$$
\alpha_{me} = \alpha_0 - \frac{m\sqrt{g}}{2} + \frac{e}{2\sqrt{g}}, \qquad \bar{\alpha}_{me} = \alpha_0 + \frac{m\sqrt{g}}{2} + \frac{e}{2\sqrt{g}}, \qquad (2.17)
$$

and the corresponding conformal dimensions

$$
h_{me} = \frac{1}{4} \left( m\sqrt{g} - \frac{e}{\sqrt{g}} \right)^2 - \frac{e_0^2}{4g}, \qquad \bar{h}_{me} = h_{me} + me. \tag{2.18}
$$

The limit  $\tilde{n} \to n$  corresponds to  $e_0 \to 1 - g$ , which gives  $2\alpha_0 \to \sqrt{g} - 1/\sqrt{g}$ . Thus if one sets  $\alpha_{-} = \sqrt{g}$  and  $\alpha_{+} = -1/\sqrt{g}$ , one gets

$$
2\alpha_0 \underset{\tilde{n} \to n}{\longrightarrow} \alpha_+ + \alpha_-, \qquad \alpha_+ \alpha_- = -1, \tag{2.19}
$$

$$
\alpha_{me} \xrightarrow{\lambda} \frac{1}{2} (1 - m)\alpha_{-} + \frac{1}{2} (1 - e)\alpha_{+}, \qquad (2.20)
$$

which is, for  $m, e$  integers, the Coulomb-gas parameterisation of the Kac table.

## <span id="page-7-0"></span>2.4 Operator spectrum

Let us go back to the toroidal geometry, and consider the transfer matrix (or Hamiltonian) propagating along one cycle of the torus. The transfer matrix conserves the total flux of arrows in the time direction, which we denote  $2m$ . We distinguish two types of sectors:

1. The sector  $m = 0$  corresponds to the situation where no loop cycles in the transfer direction. It contains the ground state, and the allowed excitations in this sector are of the electric type,

$$
\alpha = \bar{\alpha} = \alpha_{0e}, \qquad e = e_0 + k, \qquad \begin{cases} k \in 2\mathbb{Z} & \text{for honeycomb } O(n), \\ k \in \mathbb{Z} & \text{for TL.} \end{cases} \tag{2.21}
$$

and we denote the corresponding operator as  $V_{0e}$ . Note that, in the limit  $\tilde{n} \to n$ , the charge  $\alpha_{0,e_0+k} \to \alpha_{1,1+k}$ , and we obtain the scalar degenerate fields  $\mathcal{V}_{0e} \to \mathcal{V}_{1,1+k} = \Phi_{1,1+k}$  with  $k \in 2\mathbb{Z}$  (resp.  $k \in \mathbb{Z}$ ) for the honeycomb  $O(n)$ model (resp. for the TL model).

2. A sector with  $m \neq 0$  corresponds to 2m strings propagating in the time direction. The lowest energy state in this sector is the "purely magnetic" state with  $\alpha = 2\alpha_0 - \alpha = \alpha_{m0}$ , and the allowed excitations are of the form

$$
(\alpha, \bar{\alpha}) = (\alpha_{me}, \alpha_{-m,e}), \qquad \begin{cases} m \in \frac{\mathbb{Z}^+}{2}, e \in \mathbb{Z}/m & \text{for honeycomb } O(n) \\ m \in \mathbb{Z}^+, e \in \mathbb{Z}/m & \text{for TL} \end{cases}
$$
 (2.22)

and we denote the corresponding operator as  $\mathcal{W}_{me}$ . This operator has conformal spin  $h_{me} - h_{-me} = -me$ . Note that, for  $m > 1$ , "fractional" electric charges,  $e = p/m$  with p integer, are allowed.

To summarise, for a transfer matrix with periodic boundary conditions, the states present in the scaling theory are the  $V_{0e}$ 's in the zero-string sector, the  $W_{me}$ 's in the 2m-string sector, and their descendants under the action of the Virasoro generators  $\{L_n, \bar{L}_n\}.$ 

## <span id="page-8-0"></span>3 Conformal bootstrap for mixed electric/magnetic operators

Throughout Sec. [3](#page-8-0) we will restrict to the case  $n = \tilde{n}$ . For the sake of completeness, and to fix notations, we first review the Coulomb-gas approach [\[15,](#page-45-5) [16\]](#page-45-6) for the case of scalar electric operators, and present a generalisation to mixed electric/magnetic operators, also with the help of functional relations in the fashion of [\[4\]](#page-44-3).

## <span id="page-8-1"></span>3.1 Coulomb-gas approach for purely electric operators

## 3.1.1 Four-point function

We denote  $\mathcal{V}_{\alpha}(z,\bar{z}) =: e^{i\sqrt{4g}\alpha\phi(z,\bar{z})}$ : a generic electric operator. Recall that  $\mathcal{V}_{\alpha}$  and  $\mathcal{V}_{2\alpha_0-\alpha}$  have the same conformal dimensions  $h=\bar{h}=\alpha^2-2\alpha_0\alpha$ , and they represent the same operator  $\Phi_{h,h}$  in the CFT. We consider the four-point function

$$
\mathcal{C}(z,\bar{z}) = \langle \mathcal{V}_{\alpha_1}(0) \mathcal{V}_{\alpha_2}(z,\bar{z}) \mathcal{V}_{\alpha_3}(1) \mathcal{V}_{\alpha_4}(\infty) \rangle, \qquad (3.1)
$$

and we assume that the charges  $\{\alpha_i\}$  satisfy the neutrality condition after insertion of  $(p-1)$  screening charges  $\mathcal{V}_{\alpha_+}$ :

<span id="page-8-6"></span>
$$
\alpha_1 + \alpha_2 + \alpha_3 + \alpha_4 + (p-1)\alpha_+ = 2\alpha_0. \tag{3.2}
$$

Under these conditions, the four-point function can be written

<span id="page-8-4"></span>
$$
\mathcal{C}(z,\bar{z}) = (z\bar{z})^{2\alpha_1\alpha_2} \left[ (z-1)(\bar{z}-1) \right]^{2\alpha_2\alpha_3} \times G(z,\bar{z}), \tag{3.3}
$$

where  $G(z, \bar{z})$  is a bilinear combination of p independent conformal blocks

$$
G(z,\bar{z}) = \sum_{k=1}^{p} \sum_{\bar{k}=1}^{p} X_{k,\bar{k}} \mathcal{F}_k(z|\alpha_1, \alpha_2, \alpha_3, \alpha_4) \overline{\mathcal{F}_{\bar{k}}(z|\alpha_1, \alpha_2, \alpha_3, \alpha_4)}.
$$
 (3.4)

#### 3.1.2 Conformal blocks

The conformal block  $\mathcal{F}_k(z|\alpha_1,\alpha_2,\alpha_3,\alpha_4)$  is defined as the contour integral over the positions  $\{v_i\}$  of the  $(p-1)$  charges

\mathcal{F}_k(z|\{\alpha_i\}) = \oint_{C_k} \prod_{j=1}^{p-1} dv_j \prod_{j=1}^{p-1} v_j^a (v_j - 1)^b (v_j - z)^c \times \prod_{1 \le i < j \le p-1} (v_i - v_j)^{2\rho}, \qquad (3.5)
$$

where

$$
a = 2\alpha_+ \alpha_1
$$
,  $b = 2\alpha_+ \alpha_3$ ,  $c = 2\alpha_+ \alpha_2$ ,  $d = 2\alpha_+ \alpha_4$ ,  $(3.6)$ 

and  $\rho = \alpha_+^2$ , and the integration contour  $C_k$  is shown in Fig. [11a](#page-39-0). The behaviour of  $\mathcal{F}_k$  at  $z \to 0$  is

$$
z^{2\alpha_1\alpha_2} \mathcal{F}_k(z) \underset{z \to 0}{\sim} N_k \times z^{-h(\alpha_1) - h(\alpha_2) + h(\beta_k)}, \tag{3.7}
$$

where  $\beta_k = \alpha_1 + \alpha_2 + (k-1)\alpha_+$ , and the normalisation factor  $N_k$  is given in [\(A.1\)](#page-38-1). Thus, the conformal block  $\mathcal{F}_k$  corresponds to the fusion diagram shown in Fig. [4a](#page-9-0), and the term  $(k, \bar{k})$  in [\(3.4\)](#page-8-2) corresponds to the fusions

$$
\mathcal{V}_{\alpha_1} \times \mathcal{V}_{\alpha_2} \to \mathcal{V}_{\beta_k, \beta_{\bar{k}}} \leftarrow \mathcal{V}_{\alpha_3} \times \mathcal{V}_{\alpha_4} \,. \tag{3.8}
$$

### 3.1.3 Dual basis

Another basis of conformal blocks  $\widetilde{\mathcal{F}}_{\ell}(z|\alpha_1, \alpha_2, \alpha_3, \alpha_4)$  is given by the same integrals as in [\(3.5\)](#page-8-3), but with the integration contour  $C_k$  replaced by  $\widetilde{C}_{\ell}$  (see Fig. [11b](#page-39-0)), and they correspond to the fusion diagram of Fig. [4b](#page-9-0), with the charge  $\beta_{\ell} = \alpha_2 + \alpha_3 + \beta_4$  $(\ell - 1)\alpha_+$  in the fusion channel. The correlation function may be written

<span id="page-9-1"></span>
$$
G(z,\bar{z}) = \sum_{\ell,\bar{\ell}} \widetilde{X}_{\ell,\bar{\ell}} \, \widetilde{\mathcal{F}}_{\ell}(z|\{\alpha_i\}) \, \overline{\widetilde{\mathcal{F}}_{\bar{\ell}}(z|\{\alpha_i\})} \, . \tag{3.9}
$$

The change of basis is given by the matrix A and its inverse  $\widetilde{A}$ :

<span id="page-9-3"></span>
$$
\mathcal{F}_k(z) = \sum_{\ell=1}^p A_{k\ell} \widetilde{\mathcal{F}}_\ell(z), \qquad \widetilde{\mathcal{F}}_\ell(z) = \sum_{k=1}^p \widetilde{A}_{\ell k} \mathcal{F}_k(z), \qquad (3.10)
$$

with the matrix elements of A and  $\widetilde{A}$  given in [\(A.2–](#page-38-2)[A.3\)](#page-38-3). The expansion coefficients of  $G$  in  $(3.4)$  and  $(3.9)$  are related by

$$
\widetilde{X}_{\ell,\bar{\ell}} = \sum_{k,\bar{k}} A_{k\ell} A_{\bar{k}\bar{\ell}} X_{k,\bar{k}}, \qquad X_{k,\bar{k}} = \sum_{\ell,\bar{\ell}} \widetilde{A}_{\ell k} \ \widetilde{A}_{\bar{\ell}\bar{k}} \ \widetilde{X}_{\ell,\bar{\ell}}, \tag{3.11}
$$

where we have used the fact that the coefficients  $A_{k\ell}$  and  $\widetilde{A}_{\ell k}$  are real.

#### 3.1.4 Monodromy conditions

Under analytic continuation of  $\mathcal{C}(z,\bar{z})$  as z goes around zero, the term  $(k,\bar{k})$  in the decomposition [\(3.3–](#page-8-4)[3.4\)](#page-8-2) acquires a phase  $e^{2i\pi\mu_{k\bar{k}}},$  where [see [\(3.7\)](#page-9-2)]

$$
\mu_{k\bar{k}} = h(\beta_k) - h(\beta_{\bar{k}}). \tag{3.12}
$$

Note that  $\mu_{k\bar{k}}$  is simply the conformal spin of the vertex operator  $\mathcal{V}_{\beta_k,\beta_{\bar{k}}}$  in the fusion channel. Similarly, under analytic continuation of  $\mathcal{C}(z,\bar{z})$  as z goes around one, the phase for the term  $(\ell, \bar{\ell})$  in  $(3.9)$  is  $e^{2i\pi \tilde{\mu}_{\ell} \tilde{\ell}},$  where

$$
\widetilde{\mu}_{\ell\bar{\ell}} = h(\widetilde{\beta}_{\ell}) - h(\widetilde{\beta}_{\bar{\ell}}), \tag{3.13}
$$

which is, again, the conformal spin of the operator in the dual fusion channel.

We require  $G(z, \bar{z})$  to be monodromy invariant: this selects the terms in the expansions [\(3.4\)](#page-8-2) and [\(3.9\)](#page-9-1), such that  $\mu_{k\bar{k}}$  and  $\tilde{\mu}_{\ell\bar{\ell}}$  are integers. There are in general several possibilities, depending on the values of the external charges  $\{\alpha_i\}$ , but we consider here the generic solution, where the selection rules are:

$$
k = \bar{k} \qquad \text{and} \qquad \ell = \bar{\ell}. \tag{3.14}
$$

In other words, we must have  $X_{k,\bar{k}} = 0$  for all  $k \neq \bar{k}$ , and  $\widetilde{X}_{\ell,\bar{\ell}} = 0$  for all  $\ell \neq \bar{\ell}$ . This yields the "diagonal form"

$$
G(z,\bar{z}) = \sum_{k=1}^{p} X_k \, |\mathcal{F}_k(z|\{\alpha_i\})|^2 \,, \tag{3.15}
$$

and the homogeneous linear system

<span id="page-10-0"></span>
$$
\forall \ell \neq \bar{\ell}, \qquad \sum_{k=1}^{p} A_{k\ell} \ A_{k\bar{\ell}} \ X_{k} = 0. \tag{3.16}
$$

The system [\(3.16\)](#page-10-0) consists in  $p(p-1)$  linearly related equations, for p unknowns  $\{X_1, \ldots, X_p\}$ . It can be shown that [\(3.16\)](#page-10-0) is equivalent to the subsystem obtained by taking  $\ell \in \{1, \ldots, p - 1\}$  and  $\overline{\ell} = p$ :

$$
\forall \ell \in \{1, \ldots, p-1\}, \qquad \sum_{k=1}^{p} A_{k\ell} A_{kp} X_k = 0, \qquad (3.17)
$$

which has the simple solution  $X_k \propto \widetilde{A}_{pk}/A_{kp}$ . To get a meaningful set of coefficients, we need to work with the normalised conformal blocks:

<span id="page-10-2"></span>
$$
G(z,\bar{z}) = \sum_{k=1}^{p} S_k \left| \frac{1}{N_k} \mathcal{F}_k(z) \right|^2, \qquad S_k = |N_k|^2 \times X_k. \tag{3.18}
$$

After some simple manipulations described in Appendix [A,](#page-38-0) we obtain

<span id="page-10-1"></span>
$$
S_k = \prod_{j=0}^{k-2} \gamma[(j+1)\rho] \frac{\gamma(1+a+j\rho)\gamma(1+c+j\rho)}{\gamma[2+a+c+(k-2+j)\rho]}
$$
  
 
$$
\times \prod_{j=0}^{p-k-1} \gamma[(j+1)\rho] \frac{\gamma(1+b+j\rho)\gamma(1+d+j\rho)}{\gamma[2+b+d+(p-k-1+j)\rho]}, \qquad (3.19)
$$

where we have used the notation  $\gamma(x) = \Gamma(x)/\Gamma(1-x)$ . Similarly, in the basis  $\{\widetilde{\mathcal{F}}_{\ell}\},$ we have the expansion

$$
G(z,\bar{z}) = \sum_{\ell=1}^{p} \widetilde{S}_{\ell} \left| \frac{1}{\widetilde{N}_{\ell}} \widetilde{\mathcal{F}}_{\ell}(z) \right|^{2}, \qquad (3.20)
$$

where  $S_{\ell}$  is obtained by changing  $k \leftrightarrow \ell$  and  $a \leftrightarrow b$  in [\(3.19\)](#page-10-1).

#### 3.1.5 Restricted case

To lighten the notation, we define  $\mathcal{V}_{rs} := \mathcal{V}_{\alpha_{rs}}$ . Let us consider a particular case of [\(3.1–](#page-8-5)[3.2\)](#page-8-6):

<span id="page-11-1"></span>
$$
\mathcal{C}(z,\bar{z}) = \langle \mathcal{V}_{\alpha}(0) \mathcal{V}_{2\alpha_0 - \alpha}(z,\bar{z}) \mathcal{V}_{1p}(1) \mathcal{V}_{1p}(\infty) \rangle, \qquad (3.21)
$$

where  $\alpha$  is a generic charge. Note that, after proper normalisation  $\mathcal{V}_{\alpha} \equiv \mathcal{V}_{2\alpha_0-\alpha}$ , but we use the above convention to ensure the neutrality condition  $(3.2)$ . The term k in [\(3.18\)](#page-10-2) corresponds to the fusion channel:

<span id="page-11-0"></span>
$$
\mathcal{V}_{\alpha} \times \mathcal{V}_{2\alpha_0 - \alpha} \to \mathcal{V}_{\beta_k} \leftarrow \mathcal{V}_{1p} \times \mathcal{V}_{1p} , \qquad (3.22)
$$

where  $\beta_k = 2\alpha_0 - \alpha_{1,2k-1}$ . The coefficients  $S_k$  then read

$$
S_k = S_k^{(p)}(a, a') = \prod_{j=0}^{k-2} \gamma[(j+1)\rho] \frac{\gamma(1+a+j\rho)\gamma(1+a'+j\rho)}{\gamma[(k+j)\rho]}
$$
  
 
$$
\times \prod_{j=0}^{p-k-1} \gamma[(j+1)\rho] \frac{\gamma^2(1-(p-j-1)\rho)}{\gamma[2-(p+k-j-1)\rho]}, \qquad (3.23)
$$

where  $a = 2\alpha_+\alpha$ , and  $a' = 2\alpha_+(2\alpha_0 - \alpha)$ .

## 3.1.6 Extraction of OPE coefficients

The expansion coefficients  $S_k$  are related to OPE constants by

$$
S_k \propto C(\mathcal{V}_{\alpha}, \mathcal{V}_{\alpha}, \mathcal{V}_{1,2k-1}) \times C(\mathcal{V}_{1,2k-1}, \mathcal{V}_{1p}, \mathcal{V}_{1p}). \tag{3.24}
$$

Using the result [\(3.23\)](#page-11-0), and after a few simple steps described in Appendix [A,](#page-38-0) we obtain the compact form

<span id="page-11-2"></span>
$$
C^{2}(\mathcal{V}_{\alpha}, \mathcal{V}_{\alpha}, \mathcal{V}_{1,2k-1}) = \prod_{j=0}^{k-2} \frac{\gamma^{3}[(j+1)\rho]\gamma^{2}(1+a+j\rho)\gamma^{2}(1+a'+j\rho)}{\gamma[(j+k)\rho]}
$$
  
 
$$
\times \prod_{j=0}^{2k-3} \gamma[2-(j+2)\rho]. \qquad (3.25)
$$

where  $a = 2\alpha_+\alpha$ , and  $a' = 2\alpha_+(2\alpha_0 - \alpha)$ . Similarly, the dual coefficients for [\(3.21\)](#page-11-1) give the OPE constants:

$$
\widetilde{S}_{\ell} \propto C^2(\mathcal{V}_{1p}, \mathcal{V}_{\alpha}, \mathcal{V}_{\alpha+(p+1-2\ell)\alpha+/2}). \tag{3.26}
$$

In this case, the OPE constants are determined up to an overall constant (independent of  $q$ :

<span id="page-12-0"></span>
$$
C^{2}(\mathcal{V}_{1p}, \mathcal{V}_{\alpha}, \mathcal{V}_{\alpha+q\alpha+}) \propto
$$
\n
$$
\prod_{j=0}^{\ell-2} \gamma^{2}[(j+1)\rho] \gamma(1+a'+j\rho) \gamma[1+a+(p-\ell-1-j)\rho]
$$
\n
$$
\times \prod_{j=0}^{p-\ell-1} \gamma^{2}[(j+1)\rho] \gamma(1+a+j\rho) \gamma[1+a'+(\ell-2-j)\rho],
$$
\n(3.27)

where  $q \in \{-\frac{p-1}{2}, \ldots, \frac{p-1}{2}\}$  $\frac{-1}{2}$ , and  $\ell = \frac{p+1}{2} - q$ . An important example is the fusion with  $\mathcal{V}_{12}$ :

$$
\mathcal{V}_{12} \times \mathcal{V}_{\alpha} \to \mathcal{V}_{\alpha \pm \alpha_+/2} \,. \tag{3.28}
$$

Using  $(3.27)$ , we get

<span id="page-12-1"></span>
$$
\frac{C^2(\mathcal{V}_{12}, \mathcal{V}_{\alpha}, \mathcal{V}_{\alpha-\alpha+}/2)}{C^2(\mathcal{V}_{12}, \mathcal{V}_{\alpha}, \mathcal{V}_{\alpha+\alpha+}/2)} = \frac{\gamma(1+a')\gamma(1+a-\rho)}{\gamma(1+a)\gamma(1+a'-\rho)}.
$$
\n(3.29)

### 3.1.7 Comparison with the DOZZ formula

As it was noted in [\[2,](#page-44-1) [3\]](#page-44-2), some of the structure constants of CFTs with  $c < 1$ associated to statistical models satisfy the same functional relations as those of the Liouville theory defined by the Lagrangian

$$
\mathcal{L} = \frac{1}{4\pi} (\nabla \phi)^2 + \mu e^{2b\phi}, \qquad (3.30)
$$

with the coupling constant b continued to an imaginary value:  $b = i\beta$ . In this context, the central charge reads:

<span id="page-12-2"></span>
$$
c = 1 - 6(\beta - 1/\beta)^2.
$$
 (3.31)

The solution of the functional relations (conformal bootstrap) for the Liouville theory is given by [\[19,](#page-45-9) [20,](#page-45-10) [17,](#page-45-7) [4\]](#page-44-3)

$$
C_{\mathcal{L}}(\mathcal{V}_{\alpha_1}, \mathcal{V}_{\alpha_2}, \mathcal{V}_{\alpha_3}) =
$$
\n
$$
\text{const} \times \frac{\Upsilon_{\beta}(\beta - \alpha_{12}^3)\Upsilon_{\beta}(\beta - \alpha_{23}^1)\Upsilon_{\beta}(\beta - \alpha_{31}^2)\Upsilon_{\beta}(2\beta - \beta^{-1} - \sum_{i=1}^3 \alpha_i)}{\left[\prod_{i=1}^3 \Upsilon_{\beta}(\beta - 2\alpha_i)\Upsilon_{\beta}(2\beta - \beta^{-1} - 2\alpha_i)\right]^{1/2}},
$$
\n(3.32)

where  $\alpha_{ij}^k = \alpha_i + \alpha_j - \alpha_k$ , and the multiplicative constant is simply determined by  $C_{\mathcal{L}}(\mathcal{V}_{\alpha}, \mathcal{V}_{\alpha}, 1) = 1$ . To define the function  $\Upsilon_{\beta}(x)$ , it is convenient to introduce  $Q = \beta + \beta^{-1}$ . On the interval  $0 < x < Q$ , the function  $\Upsilon_{\beta}(x)$  is given by

$$
\Upsilon_{\beta}(x) = \int_0^{\infty} \frac{dt}{t} \left[ (Q/2 - x)^2 \ e^{-t} - \frac{\sinh^2(Q/2 - x) \frac{t}{2}}{\sinh \frac{\beta t}{2} \sinh \frac{t}{2\beta}} \right],
$$
 (3.33)

and the function is fully determined for  $x \in \mathbb{R}$  by the relation

$$
\frac{\Upsilon_{\beta}(x+\beta)}{\Upsilon_{\beta}(x)} = \gamma(\beta x) \ \beta^{1-2\beta x} \,. \tag{3.34}
$$

This solution is usually called the Dorn–Otto–Zamolodchikov–Zamolodchikov (DOZZ) formula. It can be checked explicitly that the OPE coefficients [\(3.25–](#page-11-2)[3.29\)](#page-12-1), found from the integral representation of the conformal blocks, coincide with [\(3.32\)](#page-12-2).

## <span id="page-13-0"></span>3.2 Coulomb-gas approach in the presence of magnetic operators

We shall generalise slightly the Coulomb-gas approach described above to the case of vertex operators  $\mathcal{V}_{\alpha,\bar{\alpha}}$  with  $\alpha \neq \bar{\alpha}$ .

### 3.2.1 Four-point function

We consider the correlation function

$$
\mathcal{C}(z,\bar{z}) = \langle \mathcal{V}_{\alpha_1,\bar{\alpha}_1}(0)\mathcal{V}_{\alpha_2,\bar{\alpha}_2}(z,\bar{z})\mathcal{V}_{\alpha_3,\bar{\alpha}_3}(1)\mathcal{V}_{\alpha_4,\bar{\alpha}_4}(\infty)\rangle, \qquad (3.35)
$$

subject to the neutrality conditions

$$
\alpha_1 + \alpha_2 + \alpha_3 + \alpha_4 + (p - 1)\alpha_+ = 2\alpha_0 ,\n\bar{\alpha}_1 + \bar{\alpha}_2 + \bar{\alpha}_3 + \bar{\alpha}_4 + (p - 1)\alpha_+ = 2\alpha_0 .
$$
\n(3.36)

We can then write

$$
\mathcal{C}(z,\bar{z}) = z^{2\alpha_1\alpha_2} \bar{z}^{2\bar{\alpha}_1\bar{\alpha}_2} (z-1)^{4\alpha_2\alpha_3} (\bar{z}-1)^{4\bar{\alpha}_2\bar{\alpha}_3} \times G(z,\bar{z}), \tag{3.37}
$$

with

<span id="page-13-1"></span>
$$
G(z,\bar{z}) = \sum_{k=1}^{p} \sum_{\bar{k}=1}^{p} X_{k,\bar{k}} \mathcal{F}_k(z|\alpha_1, \alpha_2, \alpha_3, \alpha_4) \overline{\mathcal{F}_{\bar{k}}(z|\bar{\alpha}_1, \bar{\alpha}_2, \bar{\alpha}_3, \bar{\alpha}_4)},
$$
(3.38)

where the  $F_k$ 's are the same conformal blocks as in  $(3.4)$ , but the charges in the holomorphic and anti-holomorphic sectors can be different. In the dual basis we write

<span id="page-13-2"></span>
$$
G(z,\bar{z}) = \sum_{\ell=1}^{p} \sum_{\bar{\ell}=1}^{p} \widetilde{X}_{\ell,\bar{\ell}} \, \widetilde{\mathcal{F}}_{\ell}(z|\alpha_1,\alpha_2,\alpha_3,\alpha_4) \, \overline{\widetilde{\mathcal{F}}_{\bar{\ell}}(z|\bar{\alpha}_1,\bar{\alpha}_2,\bar{\alpha}_3,\bar{\alpha}_4)}.
$$
 (3.39)

We introduce the notations

$$
a = 2\alpha_+\alpha_1, \quad b = 2\alpha_+\alpha_3, \quad c = 2\alpha_+\alpha_2, \quad d = 2\alpha_+\alpha_4,
$$
  
\n
$$
\bar{a} = 2\alpha_+\bar{\alpha}_1, \quad \bar{b} = 2\alpha_+\bar{\alpha}_3, \quad \bar{c} = 2\alpha_+\bar{\alpha}_2, \quad \bar{d} = 2\alpha_+\bar{\alpha}_4.
$$
\n(3.40)

### 3.2.2 Monodromy conditions

The term  $k, \bar{k}$  in [\(3.38\)](#page-13-1) corresponds to the fusions

$$
\mathcal{V}_{\alpha_1,\bar{\alpha}_1} \times \mathcal{V}_{\alpha_2,\bar{\alpha}_2} \to \mathcal{V}_{\beta_k,\bar{\beta}_k} \leftarrow \mathcal{V}_{\alpha_3,\bar{\alpha}_3} \times \mathcal{V}_{\alpha_4,\bar{\alpha}_4}
$$
\n(3.41)

with the charges in the fusion channel:

$$
\begin{aligned} \beta_k &= \alpha_1 + \alpha_2 + (k - 1)\alpha_+ \,, \\ \bar{\beta}_{\bar{k}} &= \bar{\alpha}_1 + \bar{\alpha}_2 + (\bar{k} - 1)\alpha_+ \,. \end{aligned} \tag{3.42}
$$

Under analytic continuation of  $\mathcal{C}(z,\bar{z})$  as z goes around zero, this term gets a phase factor  $e^{2i\pi\mu_{k,\bar{k}}},$  where

$$
\mu_{k,\bar{k}} = [h(\beta_k) - h(\alpha_1) - h(\alpha_2)] - [h(\bar{\beta}_{\bar{k}}) - h(\bar{\alpha}_1) - h(\bar{\alpha}_2)]
$$
  
= spin $(\mathcal{V}_{\beta_k, \bar{\beta}_k})$  - spin $(\mathcal{V}_{\alpha_1, \bar{\alpha}_1})$  - spin $(\mathcal{V}_{\alpha_2, \bar{\alpha}_2})$ . (3.43)

Similarly, under analytic continuation of  $\mathcal{C}(z, \bar{z})$  as z goes around one, the term  $\ell, \bar{\ell}$ in [\(3.39\)](#page-13-2) gets a factor  $e^{2i\pi\tilde{\mu}_{\ell,\bar{\ell}}},$  where

$$
\widetilde{\mu}_{\ell,\bar{\ell}} = \text{spin}(\mathcal{V}_{\widetilde{\beta}_{\ell},\widetilde{\beta}_{\bar{\ell}}}) - \text{spin}(\mathcal{V}_{\alpha_2,\bar{\alpha}_2}) - \text{spin}(\mathcal{V}_{\alpha_3,\bar{\alpha}_3}).\tag{3.44}
$$

In general, to construct a monodromy invariant four-point function, one must select the terms such that  $\mu_{k,\bar{k}}$  and  $\widetilde{\mu}_{\ell,\bar{\ell}}$  are integers.

#### <span id="page-14-0"></span>3.2.3 Restricted case

From now on, let us focus on the particular case:

$$
\mathcal{C}(z,\bar{z}) = \langle \mathcal{V}_{\alpha,\bar{\alpha}}(0) \mathcal{V}_{2\alpha_0-\alpha,2\alpha_0-\bar{\alpha}}(z,\bar{z}) \mathcal{V}_{1p}(1) \mathcal{V}_{1p}(\infty) \rangle, \qquad (3.45)
$$

where we require that

- (i) the operator  $\mathcal{V}_{\alpha,\bar{\alpha}}$  has integer conformal spin;
- (ii) the difference  $(\alpha \bar{\alpha}) \in \mathbb{Z} \alpha_-/2$ .

Note that these two conditions are satisfied by the electric operators  $\{V_{1,1+k}\}\$  and the 2m-string excitations  $\{W_{me}\}\$ . We then have

$$
a + c = \bar{a} + \bar{c} = 2(\rho - 1),
$$
  $b = \bar{b} = d = \bar{d} = b_p = (1 - p)\rho,$  (3.46)

and the condition (ii) translates into

$$
a - \bar{a} = \bar{c} - c \in \mathbb{Z} \,. \tag{3.47}
$$

In this context, we can again construct a monodromy invariant by selecting only the terms  $k = \overline{k}$  and  $\ell = \overline{\ell}$ . We get a "diagonal" decomposition

$$
G(z,\bar{z}) = \sum_{k=1}^{p} X_k \mathcal{F}_k(z|\{\alpha_i\}) \overline{\mathcal{F}_k(z|\{\bar{\alpha}_i\})},
$$
\n(3.48)

with coefficients  $X_k$  subject to the linear system

<span id="page-15-2"></span>
$$
\forall \ell \neq \overline{\ell}, \qquad \sum_{k=1}^{p} A_{k\ell}(\{\alpha_i\}) A_{k\overline{\ell}}(\{\bar{\alpha}_i\}) X_k = 0. \tag{3.49}
$$

The above condition (ii) ensures that this system still admits a solution<sup>[1](#page-15-0)</sup>, which has the form

<span id="page-15-1"></span>
$$
X_k \propto \frac{\widetilde{A}_{pk}(\{\alpha_i\})}{A_{kp}(\{\bar{\alpha}_i\})}.
$$
\n(3.50)

Introducing the coefficients  $S_k$  on normalised conformal blocks:

$$
G(z,\bar{z}) = \sum_{k=1}^{p} S_k \frac{\mathcal{F}_k(z|\{\alpha_i\})}{N_k(\{\alpha_i\})} \times \frac{\overline{\mathcal{F}_k(z|\{\bar{\alpha}_i\})}}{N_k(\{\bar{\alpha}_i\})},
$$
(3.51)

we obtain from [\(3.19\)](#page-10-1):

$$
S_k = \sqrt{S_k^{(p)}(a, a') S_k^{(p)}(\bar{a}, \bar{a}')}, \qquad (3.52)
$$

where

$$
a = 2\alpha_+\alpha \,, \quad a' = 2\alpha_+(2\alpha_0 - \alpha) \,, \quad \bar{a} = 2\alpha_+\bar{\alpha} \,, \quad \bar{a}' = 2\alpha_+(2\alpha_0 - \bar{\alpha}) \,, \tag{3.53}
$$
  
and  $S_k^{(p)}(a, a')$  is defined in (3.23).

#### 3.2.4 Extraction of OPE coefficients

The above expansion coefficients give access to the OPE constants through the relation

$$
S_k \propto C(\mathcal{V}_{\alpha,\bar{\alpha}}, \mathcal{V}_{\alpha,\bar{\alpha}}, \mathcal{V}_{1,2k-1}) \times C(\mathcal{V}_{1,2k-1}, \mathcal{V}_{1p}, \mathcal{V}_{1p}). \tag{3.54}
$$

٦

٦

Using the results for purely electric operators, we get

<span id="page-15-3"></span>
$$
C(\mathcal{V}_{\alpha,\bar{\alpha}},\mathcal{V}_{\alpha,\bar{\alpha}},\mathcal{V}_{1,2k-1})=\sqrt{C(\mathcal{V}_{\alpha},\mathcal{V}_{\alpha},\mathcal{V}_{1,2k-1})\;C(\mathcal{V}_{\bar{\alpha}},\mathcal{V}_{\bar{\alpha}},\mathcal{V}_{1,2k-1})}\,,\tag{3.55}
$$

where  $C(\mathcal{V}_{\alpha}, \mathcal{V}_{\alpha}, \mathcal{V}_{1,2k-1})$  is the purely electric coefficient given in [\(3.25\)](#page-11-2). Similarly, using the dual expansion we obtain

<span id="page-15-5"></span>
$$
C(\mathcal{V}_{1p}, \mathcal{V}_{\alpha,\bar{\alpha}}, \mathcal{V}_{\alpha+q\alpha_+,\bar{\alpha}+q\alpha_+}) \propto \sqrt{C(\mathcal{V}_{1p}, \mathcal{V}_{\alpha}, \mathcal{V}_{\alpha+q\alpha_+})} C(\mathcal{V}_{1p}, \mathcal{V}_{\bar{\alpha}}, \mathcal{V}_{\bar{\alpha}+q\alpha_+})
$$
, (3.56)

where  $q \in \{-\frac{p-1}{2}, \ldots, \frac{p-1}{2}\}$  $\frac{-1}{2}$ , and  $C(\mathcal{V}_{1p}, \mathcal{V}_{\alpha}, \mathcal{V}_{\alpha+q\alpha_{+}})$  was given in [\(3.27\)](#page-12-0). In particular, for  $p = 2$ , we get

<span id="page-15-4"></span>
$$
\frac{C^2(\mathcal{V}_{12}, \mathcal{V}_{\alpha,\bar{\alpha}}, \mathcal{V}_{\alpha-\frac{\alpha_{+}}{2},\bar{\alpha}-\frac{\alpha_{+}}{2})}}{C^2(\mathcal{V}_{12}, \mathcal{V}_{\alpha,\bar{\alpha}}, \mathcal{V}_{\alpha+\frac{\alpha_{+}}{2},\bar{\alpha}+\frac{\alpha_{+}}{2}})} = \sqrt{\frac{\gamma(1+a')\gamma(1+\bar{a}')\gamma(1+a-\rho)\gamma(1+\bar{a}-\rho)}{\gamma(1+a)\gamma(1+\bar{a})\gamma(1+a'-\rho)\gamma(1+\bar{a}'-\rho)}}.
$$
\n(3.57)

<span id="page-15-0"></span><sup>1</sup> If (ii) is relaxed, then [\(3.50\)](#page-15-1) is a solution of [\(3.49\)](#page-15-2) only for  $\ell < \overline{\ell}$ .

Like for purely electric operators, these coefficients are simply related to the DOZZ formula [\(3.32\)](#page-12-2):  $C(\mathcal{V}_{\alpha_1,\bar{\alpha}_1}, \mathcal{V}_{\alpha_2,\bar{\alpha}_2}, \mathcal{V}_{\alpha_3,\bar{\alpha}_3}) = \sqrt{C_{\mathcal{L}}(\mathcal{V}_{\alpha_1}, \mathcal{V}_{\alpha_2}, \mathcal{V}_{\alpha_3}) C_{\mathcal{L}}(\mathcal{V}_{\bar{\alpha}_1}, \mathcal{V}_{\bar{\alpha}_2}, \mathcal{V}_{\bar{\alpha}_3})}.$  However, note that this simple form of the OPE coefficients [\(3.55–](#page-15-3)[3.57\)](#page-15-4) as geometric means of the holomorphic and anti-holomorphic parts is only valid under the as-sumptions (i) and (ii) of Sec. [3.2.3.](#page-14-0) For instance, the OPE coefficient of purely magnetic operators  $C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{10})$  is expected to be finite, whereas the formula [\(3.32\)](#page-12-2) with charges  $\alpha_i = \alpha_{10}$  gives an infinite coefficient.

## <span id="page-16-0"></span>3.3 Functional relation on OPE coefficients

## 3.3.1 General setting

Throughout this section we move away from the  $O(n)$  loop model and consider a generic CFT with a central charge of the form

$$
c = 1 - 6\frac{(1 - g)^2}{g} = 1 - 24\alpha_0^2\tag{3.58}
$$

with  $q$  irrational. We the following assumptions about this CFT:

- (i) There are no degeneracies in the spectrum.
- (ii) The spectrum contains a scalar field  $\Phi_{12}(z,\bar{z})$  with conformal dimension  $h_{12} =$  $\bar{h}_{12} = (3 - 2g)/4g$ . This field is degenerate at level 2, namely the descendents

$$
\chi_{12} = (L_{-2} - gL_{-1}^2) \Phi_{12}
$$
 and  $\bar{\chi}_{1,2} = (\bar{L}_{-2} - g\bar{L}_{-1}^2) \Phi_{12}$  (3.59)

have zero norm.

(iii) Finally the last assumption we make is that both  $\chi_{12}$  and  $\bar{\chi}_{12}$  decouple from the theory. Note that, in unitary CFTs, this last assumption follows from the previous ones, but not in logarithmic CFTs, where a null vector can still have non-zero overlap with its logarithmic partner.

It is well known that the decoupling of  $\chi_{12}$  yields a differential equation for any correlation function that involves the field  $\Phi_{12}$ . In particular it yields a functional equation for the structure constants of scalar fields [\[4\]](#page-44-3). In this section we extend this result to the case of primary fields  $\Phi_{h,\bar{h}}$  with arbitrary spins. The method is essentially the same as in [\[4\]](#page-44-3), and relies on locality and crossing symmetry of the four-point functions.

#### 3.3.2 Four-point function involving  $\Phi_{12}$

Let us consider a four-point function of primary fields

<span id="page-16-1"></span>
$$
G(z,\bar{z}) = \langle \Phi_{h_1,\bar{h}_1}(0)\Phi_{12}(z,\bar{z})\Phi_{h_3,\bar{h}_3}(1)\Phi_{h_4,\bar{h}_4}(\infty)\rangle.
$$
 (3.60)

The decoupling of  $\chi_{12}$  implies the following (holomorphic) differential equation:

$$
\left[g\partial_z^2 + \left(\frac{1}{z} + \frac{1}{z-1}\right)\partial_z + \left(\frac{h_1}{z} - \frac{h_3}{z-1} + h_2 - h_4\right)\frac{1}{z(z-1)}\right]G(z,\bar{z}) = 0. \quad (3.61)
$$

Likewise, the decoupling of  $\bar{\chi}_{12}$  yields a similar antiholomorphic PDE, with  $h_i \to \bar{h}_i$ ,  $z \to \bar{z}, \partial_z \to \partial_{\bar{z}}$ . In order to write down the solutions of these differential equations, it is convenient to parametrise the conformal dimensions  $\dot{a}$  la Coulomb gas, namely

$$
h = \alpha(\alpha - 2\alpha_0), \qquad \bar{h} = \bar{\alpha}(\bar{\alpha} - 2\alpha_0) \tag{3.62}
$$

We stress that this is purely a convenient parametrisation of the conformal dimensions  $(h, \bar{h})$ , and that we are in no way working with a Coulomb gas CFT. Note that the two values  $\alpha$  and  $\alpha' = 2\alpha_0 - \alpha$  lead to the same conformal dimension  $h(\alpha) = -\alpha \alpha'$ . As a consequence, there are four ways to parametrise a field with given left and right conformal dimensions  $h = h(\alpha)$ ,  $h = h(\bar{\alpha})$ :

$$
(\alpha, \bar{\alpha}), \quad (\alpha', \bar{\alpha}), \quad (\alpha, \bar{\alpha}'), \quad (\alpha', \bar{\alpha}'). \tag{3.63}
$$

In the following we will write  $\Phi_{\alpha,\bar{\alpha}}$  as a short-hand for  $\Phi_{h(\alpha),\bar{h}(\bar{\alpha})}$ . At this point we put no constraint on the spectrum, but it will turn out that the decoupling of  $\chi_{12}$ and  $\bar{\chi}_{12}$  severely constrains the admissible values of  $(\alpha, \bar{\alpha})$ .

#### 3.3.3 Conformal blocks

Let us focus for now on the holomorphic conformal blocks, which are given by the two independent solutions of the PDE [\(3.61\)](#page-16-1). The Coulomb gas parametrisation of the conformal dimensions is very convenient to write down explicit expressions for the conformal blocks. For this purpose we adopt the same notations as in Sec. [3.2:](#page-13-0)

$$
a = 2\alpha_{+}\alpha_{1}
$$
,  $b = 2\alpha_{+}\alpha_{3}$ ,  $d = 2\alpha_{+}\alpha_{4}$ ,  
\n $a' = 2\alpha_{+}\alpha'_{1}$ ,  $b' = 2\alpha_{+}\alpha'_{3}$ ,  $d' = 2\alpha_{+}\alpha'_{4}$ . (3.64)

We will restrict ourselves to the generic situation in which the exponents at the singularities of the PDE do not differ by an integer. This means  $a - a'$ ,  $b - b'$  and  $d - d' \notin 2\mathbb{Z}$ . This ensures that the conformal blocks have no logarithm in their expansion<sup>[2](#page-17-0)</sup>.

Several basis of conformal blocks can be considered. In the following we will use two such bases. The first one  $\{I_1(z), I_2(z)\}$  corresponds to the expansion around the singularity  $z = 0$ :

$$
I_1(z) = z^{-\frac{a}{2}} (1-z)^{-\frac{b}{2}} {}_2F_1\left(\frac{d-a-b+\rho}{2}, \frac{d'-a-b+\rho}{2}; 1+\frac{a'-a}{2}; z\right),
$$
  
\n
$$
I_2(z) = z^{-\frac{a'}{2}} (1-z)^{-\frac{b'}{2}} {}_2F_1\left(\frac{d'-a'-b'+\rho}{2}, \frac{d-a'-b'+\rho}{2}; 1+\frac{a-a'}{2}; z\right),
$$
\n(3.65)

and they correspond to the following holomorphic fusion rules

$$
I_1(z): \qquad \Phi_{\alpha_1} \times \Phi_{12} \to \Phi_{\alpha_1 - \frac{\alpha_+}{2}},
$$
  
\n
$$
I_2(z): \qquad \Phi_{\alpha_1} \times \Phi_{12} \to \Phi_{\alpha_1 + \frac{\alpha_+}{2}}.
$$
\n
$$
(3.66)
$$

The constraint  $a-a' \notin 2\mathbb{Z}$  ensures that the two fields produced in the fusion  $\Phi_{\alpha_1} \times \Phi_{12}$ do not have conformal dimensions that differ by an integer. In turn this imposes

<span id="page-17-0"></span><sup>&</sup>lt;sup>2</sup>In the Appendix, we comment on the case  $a - a' \in 2\mathbb{Z}$ , for which logarithms appear in the conformal blocks. In the loop model at  $\tilde{n} = n$  this occurs for operators  $\mathcal{W}_{m,0}$ , with  $m \in \mathbb{Z}$ .

that the two conformal blocks  $I_1(z)$  and  $I_2(z)$  have different monodromies around  $z=0$ :

$$
I_1(z) \to e^{-i\pi a} I_1(z), \qquad I_2(z) \to e^{-i\pi a'} I_2(z).
$$
 (3.67)

While  $I_1(z)$  and  $I_2(z)$  have Abelian monodromy around  $z = 0$ , they have a more complicated monodromy around  $z = 1$ . Another convenient basis  $\{J_1(z), J_2(z)\}$ corresponds to the expansion around the singularity  $z = 1$ , and has Abelian monodromy around it:

$$
J_1(z) \to e^{-i\pi b} J_1(z)
$$
,  $J_2(z) \to e^{-i\pi b'} J_2(z)$ . (3.68)

Their explicit expressions, which can be found in Appendix [B,](#page-40-0) are readily obtained from  $I_1(z)$  and  $I_2(z)$  by exchanging  $z \leftrightarrow (1-z)$  and  $(a, a') \leftrightarrow (b, b')$ . These two bases are related through

$$
I_k(z) = \sum_{\ell=1}^2 M_{k\ell}(a, b, d) J_{\ell}(z), \qquad (3.69)
$$

where the explicit expression of the matrix  $M(a, b, c)$  is given in Appendix [B.](#page-40-0) For the antiholomorphic side, we have similar expressions for the bases  $\{\bar{I}_1(\bar{z}), \bar{I}_2(\bar{z})\}$ and  $\{\bar{J}_1(\bar{z}), \bar{J}_2(\bar{z})\}$ , with  $\alpha_i \to \bar{\alpha}_i$ . Since it obeys both PDEs, the full four-point function  $G(z, \bar{z})$  has to be of the form

$$
G(z,\bar{z}) = \sum_{k,\bar{k}} X_{k\bar{k}} I_k(z) \bar{I}_{\bar{k}}(\bar{z}).
$$
\n(3.70)

#### 3.3.4 Consequences of locality

Locality enforces the function  $G(z, \bar{z})$  to have a monodromy around  $z = 0$  of the form

<span id="page-18-0"></span>
$$
G(z,\bar{z}) \to e^{2i\pi\mu} G(z,\bar{z}). \tag{3.71}
$$

Note that this phase factor is non-trivial when the fields  $\Phi_{\alpha_1,\bar{\alpha}_1}$  and  $\Phi_{12}$  are mutually semi-local. A typical exemple would be the spin and disorder operators for the Ising model, for which  $e^{2i\pi\mu} = -1$ . Since we consider the case when  $a - a' \notin 2\mathbb{Z}$  and  $\bar{a} - \bar{a}' \notin 2\mathbb{Z}$ , the equality of phase factors  $e^{i\pi(\bar{a}-a)} = e^{i\pi(\bar{a}-a')} = e^{i\pi(\bar{a}'-a)} = e^{i\pi(\bar{a}'-a')}$ can only be satisfied if  $X_{k\bar{k}}$  is a diagonal or anti-diagonal matrix. Since the change  $\alpha_1 \to \alpha'_1$  (resp.  $\bar{\alpha}_1 \to \bar{\alpha}'_1$ ) is simply a reparameterisation of the field  $\Phi_{\alpha_1,\bar{\alpha}_1}$  which exchanges the roles of  $I_1(z)$  and  $I_2(z)$  (resp.  $I_1(z)$  and  $I_2(z)$ ), we can assume without any loss of generality a diagonal decomposition

$$
G(z,\bar{z}) = X_1 I_1(z)\bar{I}_1(\bar{z}) + X_2 I_2(z)\bar{I}_2(\bar{z}), \qquad (3.72)
$$

where we have renamed  $X_{11}$  to  $X_1$  and  $X_{22}$  to  $X_2$ . These two constants are closely related to the OPE structure constants:

<span id="page-18-1"></span>
$$
X_1 = A \ C \left( \Phi_{12}, \Phi_{\alpha_1, \bar{\alpha}_1}, \Phi_{\alpha_1 - \frac{\alpha_+}{2}, \bar{\alpha}_1 - \frac{\alpha_+}{2}} \right) C \left( \Phi_{\alpha_3, \bar{\alpha}_3}, \Phi_{\alpha_4, \bar{\alpha}_4}, \Phi_{\alpha_1 - \frac{\alpha_+}{2}, \bar{\alpha}_1 - \frac{\alpha_+}{2}} \right),
$$
  
\n
$$
X_2 = A \ C \left( \Phi_{12}, \Phi_{\alpha_1, \bar{\alpha}_1}, \Phi_{\alpha_1 + \frac{\alpha_+}{2}, \bar{\alpha}_1 + \frac{\alpha_+}{2}} \right) C \left( \Phi_{\alpha_3, \bar{\alpha}_3}, \Phi_{\alpha_4, \bar{\alpha}_4}, \Phi_{\alpha_1 + \frac{\alpha_+}{2}, \bar{\alpha}_1 + \frac{\alpha_+}{2}} \right),
$$
\n(3.73)

where A is an unknown constant.

It follows that the monodromy between  $\Phi_{12}$  and an arbitrary field  $\Phi_{h,\bar{h}}$  can only be  $e^{2i\pi\mu} = \pm 1$ . Indeed, the monodromy around  $z = 0$  is

$$
G(z,\bar{z}) \to e^{i\pi(\bar{a}-a)} X_1 I_1(z)\bar{I}_1(\bar{z}) + e^{i\pi(\bar{a}'-a')} X_2 I_2(z)\bar{I}_2(\bar{z}), \qquad (3.74)
$$

and generically we expect both  $X_1$  and  $X_2$  to be non zero. This requires  $2\mu \equiv$  $a - \bar{a} \equiv a' - \bar{a}' \mod 2$ , which boils down to<sup>[3](#page-19-0)</sup>

<span id="page-19-1"></span>
$$
a - \bar{a} \in \mathbb{Z},\tag{3.75}
$$

and therefore  $\mu \in \mathbb{Z}/2$ . We prove in the Appendix that this condition has to be obeyed by all primary fields. Let us stress out the meaning of this relation. The decoupling of the null vectors of  $\Phi_{12}$  puts strong constraints on the spectrum of the CFT : the conformal dimensions of the primary fields  $\Phi_{h,\bar{h}}$  must be of the form

$$
h = \alpha(\alpha - 2\alpha_0), \qquad \bar{h} = \beta(\beta - 2\alpha_0), \qquad \text{with} \qquad (\alpha - \beta) \in \frac{\mathbb{Z}\alpha_-}{2}. \qquad (3.76)
$$

While this holds trivially for spinless fields, for which we can choose  $\alpha = \beta$ , this is a severe constraint for non scalar fields. The full spectra of both the TL and  $O(n)$ loop models satisfy this condition, although  $\Phi_{12}$  does not belong to the spectrum of  $O(n)$ . This is perhaps not so surprising. Indeed, the  $O(n)$  loop model contains the field  $\Phi_{13}$ , and the corresponding differential equation naively yields the constraint :  $h(\alpha+\alpha_+) - h(\bar{\alpha}+\alpha_+) \equiv h(\alpha) - h(\bar{\alpha}) \equiv h(\alpha-\alpha_+) - h(\bar{\alpha}-\alpha_+) \mod 1$ , which boils down to  $a - \bar{a} \in \mathbb{Z}$ . More generally, we expect the differential equation corresponding to  $\Phi_{1k}$  to be consistent with locality as long as  $a-\bar{a}$  is integer. From now on, we assume that all fields obey this constraint, namely  $(\alpha - \bar{\alpha}) \in \mathbb{Z} \alpha_{-}/2$  [or  $(\alpha' - \bar{\alpha}) \in \mathbb{Z} \alpha_{-}/2$ ].

As a side remark, if a CFT contains both  $\Phi_{12}$  and  $\Phi_{21}$  (and if their null vectors decouple), fields in the spectrum must belong to one of the two following families:

- Scalar fields  $\alpha = \bar{\alpha}$ , with  $\alpha$  arbitrary. This is the case for all fields in Liouville.
- Spinful fields  $\alpha = \alpha_{m,e}$ ,  $\bar{\alpha} = \alpha_{-m,e}$ , with  $e, m \in \mathbb{Z}/2$ , with spin  $s = -me \in \mathbb{Z}/2$  $\mathbb{Z}/4.$

While a continuum of scalar fields is possible, only a discrete set of spinful fields is allowed in that case. Let us stress that the spin fields of the loop models under consideration do not fall into this classification, since these models contain fields with  $m = -\bar{m} \neq 0$  and  $e \notin \mathbb{Z}/2$ . This is allowed because  $\Phi_{21}$  is absent from the spectrum of the loop models.

<span id="page-19-0"></span><sup>&</sup>lt;sup>3</sup>This comes from our choice of working with a diagonal matrix X. If one works with an antidiagonal X instead the conditions becomes  $2\mu = a - \bar{a}^{\prime} = a^{\prime} - \bar{a} \mod 2$ , or equivalently  $a^{\prime} - \bar{a} \in \mathbb{Z}$ . But as we already mentioned this is a pure matter of convention.

### 3.3.5 Solution of the monodromy problem

Let us go back to the four-point function  $G(z, \bar{z})$  of [\(3.72\)](#page-18-0). Repeating the same arguments around  $z = 1$  yields a decomposition on the  $\{J_1(z), J_2(z)\}\$  basis :

$$
G(z,\bar{z}) = Y_1 J_1(z)\bar{J}_1(\bar{z}) + Y_2 J_1(z)\bar{J}_2(\bar{z}).
$$
\n(3.77)

Compatibility with the change of bases yields two consistency relations :

<span id="page-20-0"></span>
$$
M_{11}\bar{M}_{12}X_1 + M_{21}\bar{M}_{22}X_2 = 0,
$$
  
\n
$$
M_{12}\bar{M}_{11}X_1 + M_{22}\bar{M}_{21}X_2 = 0.
$$
\n(3.78)

For the two linear equations [\(3.78\)](#page-20-0) to have a non-zero solution  $(X_1, X_2)$  (and therefore a non-vanishing four-point function), we must have

$$
\det\left(\begin{array}{cc} M_{11}\bar{M}_{12} & M_{21}\bar{M}_{22} \\ M_{12}\bar{M}_{11} & M_{22}\bar{M}_{21} \end{array}\right) = 0 \qquad \Leftrightarrow \qquad \frac{M_{11}M_{22}}{M_{12}M_{21}} = \frac{\bar{M}_{11}\bar{M}_{22}}{\bar{M}_{12}\bar{M}_{21}}, \qquad (3.79)
$$

or more explicitly

$$
\frac{\sin \pi \left(\frac{\rho+a-b-d}{2}\right) \sin \pi \left(\frac{\rho+b-a-d}{2}\right)}{\sin \pi \left(\frac{\rho+d-a-b}{2}\right) \sin \pi \left(\frac{3\rho-d-a-b}{2}\right)} = \frac{\sin \pi \left(\frac{\rho+\bar{a}-\bar{b}-\bar{d}}{2}\right) \sin \pi \left(\frac{\rho+\bar{b}-\bar{a}-\bar{d}}{2}\right)}{\sin \pi \left(\frac{\rho+\bar{d}-\bar{a}-\bar{b}}{2}\right) \sin \pi \left(\frac{3\rho-\bar{d}-\bar{a}-\bar{b}}{2}\right)},\tag{3.80}
$$

where  $a-\bar{a}$ ,  $b-\bar{b}$  and  $d-\bar{d}$  are all integers. This constraint is manifestly symmetric under exchange of  $a$  and  $b$ , but not under exchange of  $a$  and  $d$ . This is because our analysis has singled out the relation between the conformal blocks around  $z = 0$  and  $z = 1$ . Repeating the same steps around  $z = \infty$ , we would end up with two more relations: one symmetric under  $a \leftrightarrow d$  and another symmetric under  $b \leftrightarrow d$ . When a, b and d are generic, all these constraints boil down to

$$
(\bar{a} + \bar{b} + \bar{d}) \equiv (a + b + d) \mod 2. \tag{3.81}
$$

The solution can then be written as

$$
\frac{X_1}{X_2} = -\frac{M_{21}\bar{M}_{22}}{M_{11}\bar{M}_{12}} = -\frac{M_{22}\bar{M}_{21}}{M_{12}\bar{M}_{11}},
$$
\n(3.82)

or in a more symmetric fashion

<span id="page-20-1"></span>
$$
\left(\frac{X_1}{X_2}\right)^2 = \frac{M_{22}M_{21}}{M_{11}M_{12}} \frac{\bar{M}_{22}\bar{M}_{21}}{\bar{M}_{11}\bar{M}_{12}}.
$$
\n(3.83)

This leads to

$$
\left(\frac{X_1}{X_2}\right)^2 = \frac{\gamma\left(\frac{a-a'}{2}\right)}{\gamma\left(\frac{a'-a}{2}\right)} \frac{\gamma\left(\frac{d-a-b'+\rho}{2}\right)}{\gamma\left(\frac{d-a'-b'+\rho}{2}\right)} \frac{\gamma\left(\frac{d-a-b+\rho}{2}\right)}{\gamma\left(\frac{d-a'-b'+\rho}{2}\right)} \times (\alpha_i \to \bar{\alpha}_i) . \tag{3.84}
$$

This expression is invariant under  $b \leftrightarrow b'$ ,  $d \leftrightarrow d'$  or  $b \leftrightarrow d$ , as it should be. In particular, taking  $b = \bar{b} = -\rho$  and  $(d, \bar{d}) = (a, \bar{a})$  we recover equation [\(3.57\)](#page-15-4), obtained in the framework of the Coulomb gas.

#### 3.3.6 OPE coefficients

Using  $(3.57)$ ,  $(3.73)$  and  $(3.84)$ , we can extract a ratio of OPE coefficients, and if we denote  $\Phi_2 = \Phi_{\alpha_3,\bar{\alpha}_3}$  and  $\Phi_3 = \Phi_{\alpha_4,\bar{\alpha}_4}$ , we get

<span id="page-21-1"></span>
$$
\begin{bmatrix}\n\frac{C\left(\Phi_{\alpha_{1}-\frac{\alpha_{+}}{2},\bar{\alpha}_{1}-\frac{\alpha_{+}}{2}},\Phi_{2},\Phi_{3}\right)}{C\left(\Phi_{\alpha_{1}+\frac{\alpha_{+}}{2},\bar{\alpha}_{1}+\frac{\alpha_{+}}{2}},\Phi_{2},\Phi_{3}\right)}\n\end{bmatrix}^{2} = \sqrt{\frac{\gamma\left(\frac{a-a'}{2}\right)\gamma(1+a)}{\gamma\left(\frac{a'-a'}{2}\right)\gamma(1+a')}} \frac{\gamma\left(\frac{d-a-b'+\rho}{2}\right)\gamma\left(\frac{d-a-b+\rho}{2}\right)}{\gamma\left(\frac{d-a'-b'+\rho}{2}\right)\gamma\left(\frac{d-a'-b+\rho}{2}\right)} \times (\alpha_{i} \to \bar{\alpha}_{i}).
$$
\n(3.85)

This formula immediately applies to the loop model CFT, since the latter satisfies the assumptions made in the beginning of this section. Like in [\(3.57\)](#page-15-4), although it is valid in the presence of electromagnetic operators  $\mathcal{W}_{me}$ , it only gives a recursion relation on the electric charge.

Equation [\(3.85\)](#page-21-1) is a functional relation satisfied by the OPE coefficients. One can check that the RHS of [\(3.85\)](#page-21-1) is what one would get if one replaced  $C(\ldots \Phi_{\alpha_i,\bar{\alpha}_i} \ldots)$ by  $\sqrt{C_{\mathcal{L}}(\ldots \mathcal{V}_{\alpha_i} \ldots)C_{\mathcal{L}}(\ldots \mathcal{V}_{\bar{\alpha}_i} \ldots)}$ . However, unlike the Liouville theory where two functional relations (coming from the degeneracy of  $\Phi_{12}$  and  $\Phi_{21}$ ) determine uniquely the solution  $C_{\mathcal{L}}$ , in our situation the field  $\Phi_{21}$  is absent from the spectrum, and we only have one functional relation, which only determines the OPE coefficients up to a periodic factor.

#### 3.3.7 Application to the loop model

When specialised to the TL loop model, [\(3.85\)](#page-21-1) yields, in particular, the ratio

$$
\frac{C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{12})}{C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{10})} = \left[ \frac{\gamma (1 - \rho) \gamma (-1 - \rho)}{\gamma (-1 + 2\rho) \gamma (1 + 2\rho) \gamma (-1 + \rho) \gamma (1 + \rho)} \right]^{1/4} \times \left[ \frac{\gamma^3 (\rho/2) \gamma (-1 + \rho/2)}{\gamma^3 (-\rho/2) \gamma (-1 - \rho/2)} \right]^{1/2},
$$
\n(3.86)

which is checked numerically in Sec. [3.4.](#page-21-0) Besides the precise expression of the ratio, it is important to notice the non-vanishing of the numerator:

<span id="page-21-2"></span>
$$
C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{12}) \neq 0 \qquad \text{for} \quad 0 < n < 2. \tag{3.87}
$$

Indeed, since  $\mathcal{W}_{12}$  has conformal dimension  $h_{12}$  in the holomorphic sector, one could have expected that it obeys fusion rules of the form  $\mathcal{W}_{12} \times \mathcal{V}_{\alpha,\bar{\alpha}} \to \mathcal{V}_{\beta,\bar{\beta}}$ , with  $\beta = \alpha \pm \alpha_{+}/2$ , whereas this rule is clearly violated by  $C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{12})$ . As we shall see in Sec. [4,](#page-23-0) this is due to the presence of a logarithmic partner for  $\mathcal{W}_{10}$ .

## <span id="page-21-0"></span>3.4 Numerical checks

Using a numerical algorithm based on transfer-matrix diagonalisation (see Appendix [D\)](#page-43-1), we have computed numerically the OPE coefficients in the TL loop model at the point  $n = \tilde{n}$ , for  $0 < n < 2$ . We can then compare these data to our predictions [\(3.55\)](#page-15-3), [\(3.56\)](#page-15-5), [\(3.57\)](#page-15-4) and , [\(3.85\)](#page-21-1), in particular in the presence of watermelon operators  $\mathcal{W}_{me}$ .

## **3.4.1** The OPE coefficient  $C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{V}_{13})$

This OPE coefficient involves two spinless operators together with a degenerate operator of the form  $\mathcal{V}_{1,2k-1}$ , and thus one expects it to be given by [\(3.25\)](#page-11-2):

<span id="page-22-1"></span>
$$
C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{V}_{13}) = \sqrt{\frac{\gamma^3(\rho)\gamma(2 - 2\rho)\gamma(2 - 3\rho)}{\gamma(2\rho)}} \gamma(\rho + 1)\gamma(\rho - 1).
$$
 (3.88)

The agreement with numerical data on cylinders of circumference  $L = 10$  sites to  $L = 18$  sites is good, as shown in Fig. [5.](#page-23-2)

### **3.4.2** The OPE coefficient  $C(\mathcal{W}_{11}, \mathcal{W}_{11}, \mathcal{V}_{13})$

In this case we use the prediction of  $(3.55)$  with  $k = 2$ :

<span id="page-22-0"></span>
$$
C(\mathcal{V}_{\alpha,\bar{\alpha}},\mathcal{V}_{\alpha,\bar{\alpha}},\mathcal{V}_{13}) = \sqrt{\frac{\gamma^3(\rho)\gamma(2-2\rho)\gamma(2-3\rho)}{\gamma(2\rho)}}\gamma(1+a)\gamma(1+a')\gamma(1+\bar{a})\gamma(1+\bar{a}') ,\tag{3.89}
$$

where

$$
a = 2\alpha_{+}\alpha
$$
,  $\bar{a} = 2\alpha_{+}\bar{\alpha}$ ,  $a' = 2\alpha_{+}(2\alpha_{0} - \alpha)$ ,  $\bar{a}' = 2\alpha_{+}(2\alpha_{0} - \bar{\alpha})$ . (3.90)

The expression [\(3.89\)](#page-22-0) is ill-defined when  $\alpha \to \alpha_{11}$  and  $\bar{\alpha} \to \alpha_{-1,1}$ , and hence we need a regularisation procedure to extract  $C(\mathcal{W}_{11}, \mathcal{W}_{11}, \mathcal{V}_{13})$ . Indeed, if we set  $\alpha = \alpha_{11} + \epsilon$ and  $\bar{\alpha} = \alpha_{-1,1} + \bar{\epsilon}$  with  $\epsilon, \bar{\epsilon} \to 0$ , we get  $\gamma(1 + a)\gamma(1 + \bar{a}) \sim \epsilon/\bar{\epsilon}$ . The condition [\(3.75\)](#page-19-1) imposed by locality of the four-point functions yields a unique possible relation  $\epsilon = \bar{\epsilon}$ , which finally leads to

<span id="page-22-2"></span>
$$
C(\mathcal{W}_{11}, \mathcal{W}_{11}, \mathcal{V}_{13}) = \sqrt{\frac{\gamma^3(\rho)\rho(2 - 3\rho)\gamma(1 + 2\rho)}{\gamma(2\rho)}}.
$$
\n(3.91)

The agreement with numerical data is good, as shown in Fig. [6.](#page-24-0) The numerical data show an apparent divergence at  $n = 1$ , but the height of the corresponding peak decays as L grows. We interpret this peak as a numerical artefact arising from a level crossing in the zero-leg sector with zero momentum, between the states  $|\mathcal{V}_{13}\rangle$ and  $L_{-2}\overline{L}_{-2}|0\rangle$ .

## **3.4.3** The ratio  $C(\mathcal{V}_{12}, \mathcal{W}_{11}, \mathcal{W}_{12})/C(\mathcal{V}_{12}, \mathcal{W}_{11}, \mathcal{W}_{10})$

This ratio is predicted by [\(3.57\)](#page-15-4), using the same regularisation procedure for  $\mathcal{W}_{11}$ as above:

<span id="page-22-3"></span>
$$
\frac{C(\mathcal{V}_{12}, \mathcal{W}_{11}, \mathcal{W}_{12})}{C(\mathcal{V}_{12}, \mathcal{W}_{11}, \mathcal{W}_{10})} = \left[ \frac{\gamma(-1 + 2\rho)\gamma(1 + 2\rho)\gamma(1 - \rho)\gamma(-1 - \rho)}{\gamma(-1 + \rho)\gamma(1 + \rho)} \right]^{1/4}.
$$
(3.92)

The agreement with numerical data is good, as shown in Fig. [7.](#page-24-1) In this case, although  $h_{12} + h_{-1,2} < 2h_{10} + 4$  on the whole interval  $0 < n < 2$ , in finite size some level crossing occursat  $n = n^*$  between the lattice representatives of  $|W_{12}\rangle$  and some fourth-level descendents of  $|\mathcal{W}_{10}\rangle$ . This affects the numerical data close to  $n = 0$ , but the crossing location  $n^* \to 0$  as the system size grows.

## **3.4.4** The ratio  $C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{12})/C(\mathcal{W}_{10}, \mathcal{W}_{10}, \mathcal{W}_{10})$

This ratio is predicted by [\(3.86\)](#page-21-2). The agreement with numerical data is good, as shown in Fig. [8,](#page-25-0) although the data still suffer from the finite-size level crossing of  $|W_{12}\rangle$  with the descendents of  $|W_{10}\rangle$  discussed above.

## <span id="page-23-0"></span>4 Indecomposability in the bulk theory of generic loop models

## <span id="page-23-1"></span>4.1 The periodic Temperley-Lieb algebra

Following the discussion in [\[13\]](#page-45-3), let us first describe the diagrams defining the algebra, and then give the algebraic rules between generators. We consider an annulus with L marked points on the inner boundary and L marked points on the outer boundary (L is an even integer). Actually, we shall depict the annulus as a rectangle with periodic conditions across the vertical sides, and draw the inner (resp. outer) boundary at the bottom (resp. the top) of the rectangle: see Fig. [9.](#page-25-1)

<span id="page-26-0"></span>Definition 1. A diagram w is a set of lines inside the annulus, connecting the 2L marked points with no intersections. The arches (resp. the legs) of w are the lines connecting two points on the same boundary (resp. opposite boundaries).

We can consider diagrams as basis elements of an associative algebra:

<span id="page-26-1"></span>**Definition 2.** The periodic Temperley-Lieb algebra  $\text{PTL}_L$  is the algebra generated by the diagrams on an annulus with 2L marked points, where any two diagrams  $(w_1, w_2)$ are identified (up to a multiplicative factor) according to the following rules:

- if  $w_2$  can be obtained from  $w_1$  by a continuous deformation of the lines, then  $w_1 = w_2$ ;
- if  $w_2$  can be obtained from  $w_1$  by a rotation of angle  $2\pi$  of one of the boundaries, then  $w_1 = w_2$ ;
- if  $w_2$  can be obtained from  $w_1$  by removing a closed, contractible loop, then  $w_1 = n \ w_2$ ;
- if  $w_2$  can be obtained from  $w_1$  by removing a closed, non-contractible loop, then  $w_1 = \widetilde{n} \ w_2;$

and the product  $w_1w_2$  of two diagrams is obtained by gluing the bottom (or inner) boundary of  $w_1$  onto the top (or outer) boundary of  $w_2$ .

Equivalently, we can formulate the above rules in terms of generators, which act by convention from bottom to top (or inner to outer) boundary:

<span id="page-26-2"></span>**Definition 3.** The periodic Temperley-Lieb algebra  $\text{PTL}_L$  is the algebra generated by  $e_1, \ldots e_L$  and the right-shift operator  $\tau$ , subject to the relations for  $1 \leq j, k \leq L$ :

$$
e_j e_{j\pm 1} e_j = e_j,
$$
  
\n
$$
e_j^2 = n e_j,
$$
  
\n
$$
e_j e_k = e_k e_j \qquad if \quad 1 < |j - k| < L - 1,
$$
  
\n
$$
\tau^L = 1,
$$
  
\n
$$
\tau e_j \tau^{-1} = e_{j+1},
$$
  
\n
$$
e_1 e_2 \dots e_{L-1} = \tau^2 e_{L-1},
$$
  
\n
$$
(e_2 e_4 \dots e_L)(e_1 e_3 \dots e_{L-1}) = \tilde{n} \tau(e_1 e_3 \dots e_{L-1}),
$$
  
\n(4.1)

where  $e_{L+1} \equiv e_1$ .

Finally, let us define a notion of parity:

<span id="page-26-3"></span>**Definition 4.** The parity of a diagram w is  $\epsilon(w) = +1$  (resp.  $\epsilon(w) = -1$ ) if the lines of w intersect the vertical boundary an even (resp. odd) total number of times.

With this definition, we see readily that  $\epsilon(w_1w_2) = \epsilon(w_1)\epsilon(w_2)$ .



Figure 10: The basis states of  $W_0$ ,  $W_1$  for  $L = 4$  and  $W_2$  for  $L = 8$ .

## <span id="page-27-0"></span>4.2 Representations of  $PTL<sub>L</sub>$

#### 4.2.1 The spaces  $W_{\ell}$  and the TL scalar product

Under the action of the above algebra, the bottom arches are left unchanged, while the number of legs never increases. This suggests to define the action of  $\text{PTL}_L$  on the "top-half" of the diagram only. For this, we now consider a circle with  $L$  marked points, with a cutline connecting the origin to the exterior of the circle. Equivalently, we can place the points on a horizontal segment, with periodic conditions across a vertical cutline.

**Definition 5.** A state a (also denoted  $|a\rangle$ ) is a set of non-intersecting lines drawn in the lower-half plane, with some lines (arches) connecting  $(L - 2\ell)$  marked points among themselves, and  $2\ell$  vertical labelled lines (legs) attached to the remaining marked points, so that the labels form a cyclic permutation of  $(1, 2, \ldots, 2\ell)$ , and a leg attached to the point  $j \in \{1, \ldots, L\}$  carries a label with the same parity as j.

In particular, the top-half of a diagram  $w$ , consisting in the arches on the top boundary of w together with the legs of  $w$ , defines a state. If we fix the number of legs, we get a representation of  $\text{PTL}_L$ :

**Definition 6.** The representation  $W_{\ell}$  is defined as the geometric action of PTL<sub>L</sub> on the vector space generated by the states with  $2\ell$  legs, where the contraction of any two legs gives zero.

**Definition 7.** The space  $W = W_0 \oplus W_1 \oplus W_2 \oplus \ldots$  is equipped with a bilinear, symmetric form  $\langle \cdot, \cdot \rangle$ , defined as follows. Let a and b be two states with  $\ell_a$  and  $\ell_b$ legs, respectively. Consider the set of lines  $g(a, b)$  obtained by gluing the reflection of a around a horizontal axis with b, and set

$$
\langle a,b\rangle = \begin{cases} 0 & \text{if any two legs of a are joined in } g(a,b), \\ 0 & \text{if any two legs of b are joined in } g(a,b), \\ n^{N_c(a,b)} \ \widetilde{n}^{N_{nc}(a,b)} & \text{otherwise,} \end{cases}
$$
 (4.2)

where  $N_c(a, b)$  (resp.  $N_{nc}(a, b)$ ) is the number of contractible (resp. non-contractible) loops in  $g(a, b)$ . In particular, if  $\ell_a \neq \ell_b$  then  $\langle a, b \rangle = 0$  automatically.

**Proposition 1.** The generators  $e_i$  are self-adjoint for the bilinear form  $\langle \cdot, \cdot \rangle$  on the space W:

$$
\forall (a, b) \in W^2 \,, \qquad \langle e_j a, b \rangle = \langle a, e_j b \rangle \,. \tag{4.3}
$$

### 4.2.2 The map  $\varphi$

Let us now describe a linear map whose properties will allow us to relate the spaces  $W_0$  and  $W_1$ .

**Definition 8.** Let  $\varphi$  be the linear map defined as:

<span id="page-28-0"></span>
$$
\varphi : \left\{ \begin{array}{ccc} W_1 & \to & W_0 \\ | \cdots | \cdots | \cdots \rangle & \mapsto & \frac{(-1)^{j+1}}{2} \left( | \cdots | \cdots \rangle - | \cdots | \cdots \rangle \right) \end{array} \right. \tag{4.4}
$$

 $\bigcup_{j...k}^{j...k}$  (resp.  $\bigcup_{j...k}^{j...k}$ ) means that the points j and k are connected by an arch which intersects the cutline an even (resp. odd) number of times.

We see immediately that

$$
e_j \varphi | \cdots | \stackrel{j}{\mid} \cdots \rangle = \frac{(-1)^{j+1}}{2} (n - \widetilde{n}) | \cdots \stackrel{j}{\cup} \cdots \rangle.
$$
 (4.5)

Hence, taking all the signs into account,  $\varphi$  is a morphism of algebras, up to a parity sign:

### <span id="page-28-1"></span>**Proposition 2.** If  $n = \tilde{n}$ , then

$$
\forall w \,, \quad \forall a \in W_1 \,, \qquad w \, \varphi |a\rangle = \epsilon(w) \, \varphi w |a\rangle \,.
$$
 (4.6)

<span id="page-28-2"></span>**Proposition 3.** If  $n = \tilde{n}$ , then

$$
\forall a \in W_0, \quad \forall b \in W_1, \qquad \langle a, \varphi(b) \rangle = 0. \tag{4.7}
$$

In particular,  $\varphi(b)$  has zero norm:  $\langle \varphi(b), \varphi(b) \rangle = 0$ .

Note that a state with no legs can be specified by a planar pairing of the L marked points, with each arch decorated by the parity of its number of intersections with the cutline. In the case  $n = \tilde{n}$ , one may define a representation which ignores the parities:

**Definition 9.** A zero-leg reduced state  $|\hat{a}\rangle$  is a planar pairing of the L marked points. When  $n = \tilde{n}$ , the representation  $\widehat{W}_0$  is defined as the geometric action of PTL<sub>L</sub> on the vector space generated by the zero-leg reduced states.

With some simple counting, one gets the dimensions of the above representations:

<span id="page-29-0"></span>
$$
\dim W_{\ell} = \begin{pmatrix} L \\ L/2 - \ell \end{pmatrix}, \qquad \dim \widehat{W}_0 = \frac{L!}{(L/2)!(L/2+1)!}.
$$
 (4.8)

<span id="page-29-1"></span>**Proposition 4.** If  $n = \tilde{n}$ , then  $\varphi$  is injective, and

$$
W_0 = \widehat{W}_0 \oplus \text{Im}(\varphi), \qquad \text{Im}(\varphi) \cong W_1. \tag{4.9}
$$

*Proof.* Consider a state  $a \in W_0$ . If a has no arch with odd parity, then  $a \in \widehat{W}_0$ . Otherwise, we consider the most external arch of a with odd parity, and denote by  $j < k$  the ends of this arch. We define

$$
|a\rangle = |\dots \overset{j\dots k}{\cup} \dots \rangle, \quad |a'\rangle = |\dots \overset{j\dots k}{\cup} \dots \rangle, \quad |b\rangle = 2(-1)^j |\dots \overset{j}{|\dots} \dots \overset{k}{|\dots} \rangle. \tag{4.10}
$$

From [\(4.4\)](#page-28-0), we have

$$
|a\rangle = |a'\rangle + \varphi|b\rangle, \qquad (4.11)
$$

where  $a$  has one less arch with odd parity than  $a$ . By iterating this process, we can write *a* as

$$
|a\rangle = |a'_k\rangle + \varphi|b_k\rangle, \qquad a'_k \in \widehat{W}_0, \quad b_k \in W_1. \tag{4.12}
$$

Hence, we see that

$$
W_0 \subseteq \widehat{W}_0 + \operatorname{Im}(\varphi) \quad \Rightarrow \quad \dim W_0 \le \dim \widehat{W}_0 + \operatorname{rk}(\varphi). \tag{4.13}
$$

But, from  $(4.8)$ , we have

$$
\dim W_0 = \dim W_0 + \dim W_1, \qquad (4.14)
$$

which leads to  $\text{rk}(\varphi) \geq \dim W_1$ , and proves that  $\varphi$  is injective.

## 4.2.3 Degeneracies of H between the  $W_0$  and  $W_1$  sectors

Let us consider, for  $n = \tilde{n}$ , the Hamiltonian associated to the TL model:

$$
H = -\sum_{j=1}^{L} e_j.
$$
 (4.15)

 $\Box$ 

<span id="page-29-2"></span>**Proposition 5.** To any eigenstate  $|W\rangle \in W_1$  of H, one can associate a degenerate eigenstate  $|\chi\rangle = \varphi| \mathcal{W} \rangle \in W_0$ , and  $|\chi\rangle$  is orthogonal to W. In particular,  $\langle \chi, \chi \rangle = 0$ .

*Proof.* Consider an eigenstate  $|W\rangle \in W_1$ , with energy E:

$$
H|\mathcal{W}\rangle = E|\mathcal{W}\rangle. \tag{4.16}
$$

From Prop. [4,](#page-29-1) the state  $|\chi\rangle = \varphi| \mathcal{W} \rangle \in W_0$  is non-zero. Moreover, since every term in  $H$  has even parity, we have from Prop. [2:](#page-28-1)

$$
H|\chi\rangle = H\varphi|\mathcal{W}\rangle = \varphi H|\mathcal{W}\rangle = E|\chi\rangle, \qquad (4.17)
$$

and hence  $|\chi\rangle$  is also an eigenstate of H, with eigenvalue E. Note that, from Prop. [3,](#page-28-2)  $|\chi\rangle$  is orthogonal to the space  $W_0$ , and therefore it is orthogonal to every state in  $W$ : we say that  $|\chi\rangle$  is a decoupling state. W: we say that  $|\chi\rangle$  is a decoupling state.

From the expression [\(2.18\)](#page-7-1) of conformal dimensions, which determine the energies in the continuum limit, we see that, for generic  $n$ , the above are the only possible degeneracies between two sectors  $W_{\ell}$  and  $W_{\ell'}$  with  $\ell \neq \ell'$ . Note that the situation is very different when  $g$  is rational (see e.g. [\[13\]](#page-45-3)).

#### 4.2.4 Mixed representation

Some of the correlation functions in the loop model cannot be expressed in terms of scalar products in  $W$ , but instead they impose the use of a representation in which the contraction of two legs is allowed.

**Definition 10.** The representation  $W_{\leq 1}$  is defined as the geometric action of  $\text{PTL}_{L}$ on the space  $W_0 \oplus W_1$ , with the following coefficients for contractions:

$$
e_j | \dots | \stackrel{j \ j+1}{|} \dots \rangle = \epsilon_j | \dots \stackrel{j \ j+1}{\cup} \dots \rangle ,
$$
  
\n
$$
e_L | \stackrel{1}{|} \dots | \rangle = \epsilon_L | \stackrel{1 \dots L}{\cup} \rangle ,
$$
  
\n(4.18)

with  $\epsilon_j = (-1)^{j+1}$ .

**Definition 11.** The space  $W_{\leq 1}$  is equipped with a symmetric, bilinear form  $\langle \langle \cdot, \cdot \rangle \rangle$ , defined as

$$
\langle\!\langle a,b\rangle\!\rangle = \sigma(a,b) \; \sigma'(a,b) \; n^{N_c(a,b)} \; \widetilde{n}^{N_{\rm nc}(a,b)}, \tag{4.19}
$$

where the notations are the same as in the definition of  $\langle a, b \rangle$ , and

$$
\sigma(a,b) = \begin{cases}\n(-1)^{p_{ab}+j_a+1} & \text{if two legs of a, connected to the points } j_a < k_a \\
 & \text{are joined in } g(a,b) \text{ by crossing the culture } p_{ab} \text{ times,} \\
1 & \text{otherwise,}\n\end{cases}
$$

and  $\sigma'(a, b)$  is defined similarly in terms of the legs of b.

**Proposition 6.** The generators  $e_i$  are self-adjoint for the bilinear form  $\langle \langle \cdot, \cdot \rangle \rangle$  on the space  $W_{\leq 1}$ :

$$
\forall (a, b) \in W_{\leq 1}^2, \qquad \langle\!\langle e_j a, b \rangle\!\rangle = \langle\!\langle a, e_j b \rangle\!\rangle. \tag{4.20}
$$

### 4.2.5 Jordan blocks

Let us set  $n = \tilde{n}$ . For any pair of degenerate eigenstates  $|W\rangle$  and  $|\chi\rangle = \varphi|W\rangle$ discussed in Prop. [5,](#page-29-2) we shall argue that  $H$  has a Jordan block in the representation  $W_{\leq 1}$ , with matrix:

<span id="page-31-2"></span>
$$
\left(\begin{array}{cc} E & 1 \\ 0 & E \end{array}\right). \tag{4.21}
$$

Let us view  $|W\rangle$  and  $|\chi\rangle$  as vectors in the representation  $W_{\leq 1}$ . The action of H on  $|\chi\rangle$  is unchanged, since  $|\chi\rangle$  is in the zero-leg sector. For  $|W\rangle$ , we have to include the zero-leg terms arising after a contraction, which we denote  $|\mathcal{W}_c\rangle$ :

$$
H|\mathcal{W}\rangle = E|\mathcal{W}\rangle + |\mathcal{W}_c\rangle. \tag{4.22}
$$

Suppose there exists a solution  $|W'\rangle$  of the linear system in  $W_0$ :  $(H - E)|W'\rangle =$  $|\chi\rangle - |\mathcal{W}_c\rangle$ . We have checked numerically the existence of a solution<sup>[4](#page-31-1)</sup> in many cases, including all the pairs of degenerate states mentioned in this paper. Note that for any scalar  $\lambda$ , the change  $|W'\rangle \rightarrow |W'\rangle + \lambda |\chi\rangle$  does not affect the above linear system, and thus the solution is not unique. We introduce the states

$$
|\chi\rangle\rangle = |\chi\rangle, \qquad |\mathcal{W}\rangle\rangle = |\mathcal{W}\rangle + |\mathcal{W}'\rangle, \qquad (4.23)
$$

and we get

$$
H|\chi\rangle\rangle = E|\chi\rangle\rangle, \qquad H|\mathcal{W}\rangle\rangle = E|\mathcal{W}\rangle\rangle + |\chi\rangle\rangle. \qquad (4.24)
$$

In summary, given an eigenstate  $|W\rangle$  with energy E in the two-leg representation  $W_1$ , we have constructed a pair of states  $(|\chi\rangle\rangle, |\mathcal{W}\rangle\rangle)$  in the representation  $W_{\leq 1}$  so that H has the Jordan form  $(4.21)$  in span $(|\chi\rangle\rangle, |\mathcal{W}\rangle\rangle)$ , and  $|\chi\rangle\rangle$  is a state in the zero-leg sector of  $W_{\leq 1}$  with vanishing norm:  $\langle\langle \chi, \chi \rangle\rangle = 0$ .

## <span id="page-31-0"></span>4.3 Scaling limit

Throughout this section, we set  $n = \tilde{n}$ .

#### 4.3.1 Identification of states

The states  $\{|\mathcal{V}_{1k}\rangle\}$  and  $\{|\mathcal{W}_{me}\rangle\}$  defined by vertex operators in Sec. [2.3](#page-6-0) can be identified as the scaling analogs of states in the representations  $\{W_{\ell}\}\$ . The general idea is that the continuous analog of  $\text{PTL}_L$  is made of two copies of the Virasoro algebra: Vir  $\oplus \overline{\text{Vir}}$ , and that the discrete quantum numbers of H survive in the scaling limit.

For clarity, we denote  $|\Phi\rangle_L$  and  $|\Phi\rangle_L$  a state in  $W_\ell$  and  $W_{\leq 1}$  respectively, and  $|\Phi\rangle$  the corresponding state in the CFT Hilbert space. We use a similar notation for scalar products.

<span id="page-31-1"></span><sup>&</sup>lt;sup>4</sup>Note that the signs  $\epsilon_i$  in the action of H on  $W_{\leq 1}$  are crucial, since the momenta of  $|W\rangle$ and  $|\chi\rangle = \varphi|\mathcal{W}\rangle$  differ by  $\pi$ . If instead we had set  $\epsilon_j = 1$  (and  $\sigma(a, b) = \sigma'(a, b) = 1$  in the corresponding scalar product so that  $H$  is still Hermitian), then  $H$  would have a diagonal form in the block  $(|\chi\rangle\!\rangle, |\mathcal{W}\rangle\!\rangle).$ 

- The state  $|V_{1k}\rangle_L$ , with  $k \geq 1$ , belongs to  $\widehat{W}_0 \subset W_0$ , and it has finite norm (which is set to one by convention), since the scalar product  $\langle \cdot, \cdot \rangle$  is nondegenerate in  $\hat{W}_0$  for generic *n*.
- The state  $|V_{1k}\rangle_L$ , with  $k \leq 0$ , belongs to Im  $\varphi \subset W_0$ , and it totally decouples:

$$
\forall k \leq 0, \quad \forall a \in W_0, \qquad \langle \mathcal{V}_{1k}, a \rangle_L = 0. \tag{4.25}
$$

• The state  $|W_{me}\rangle_L$ , with  $m \geq 1$  and  $e \in \mathbb{Z}$ , belongs to  $W_m$ . Recall that the allowed electric charges are of the form  $e = p/m$ , with  $p \in \mathbb{Z}$ , which may be interpreted as follows. Consider the cyclic translation  $R$  of the leg labels by two units:

$$
R\left|\ldots\right|\left|\ldots\right|\left|\ldots\right|\left|\ldots\right\rangle = \left|\ldots\right|\left|\ldots\right|\left|\ldots\right|\left|\ldots\right|\left|\ldots\right\rangle,
$$
\n(4.26)

where the labels are considered modulo  $2m$ . The action of H on  $W_m$  commutes with  $R$ , and we can label the eigenstates of  $H$  according to the eigenvalues  $r_q = \exp(2i\pi q/m)$  of R, with  $q = 0, \ldots, m-1$ . Then the state  $|W_{me}\rangle_L$  with  $e = p/m$  is in the sector  $r_q$  such that  $p \equiv q \mod m$ . Again, since the scalar product  $\langle \cdot, \cdot \rangle$  is non-degenerate in  $W_m$ , one can set  $\langle \mathcal{W}_{me}, \mathcal{W}_{me} \rangle_L = 1$ .

• For  $m = 1$  and  $k \geq 1$ ,  $\mathcal{W}_{1k}$  is degenerate with the null descendant of  $\mathcal{V}_{1k}$ (under the action of Vir) at level k, which we denote  $\bar{\chi}_{1k}$ . In the representation  $W_0 \oplus W_1$ , the two corresponding states  $(|\bar{\chi}_{1k}\rangle_L, |\mathcal{W}_{1k}\rangle_L)$  are related by

$$
|\bar{\chi}_{1k}\rangle_L = \varphi | \mathcal{W}_{1k}\rangle_L , \qquad (4.27)
$$

and they are independent, orthogonal eigenstates. In contrast, in  $W_{\leq 1}$ , the corresponding states form a Jordan block, and we use a disctinct notation  $(|\bar{\chi}_{1k}\rangle_L, |\mathcal{W}_{1k}\rangle_L)$  for them. The Jordan block [\(4.21\)](#page-31-2) becomes, in the scaling limit:

$$
L_0 + \bar{L}_0 = \begin{pmatrix} h_{1k} + h_{1,-k} & 1 \\ 0 & h_{1k} + h_{1,-k} \end{pmatrix} . \tag{4.28}
$$

There is a similar relation between  $\mathcal{W}_{1,-k}$  and  $\chi_{1k}$ , the null descendant of  $\mathcal{V}_{1k}$ under the action of Vir.

Moreover, as we have argued above, any eigenstate in  $W_1$  produces a  $2 \times 2$ Jordan block in  $W_{\leq 1}$ . In particular, since  $\varphi$  commutes with the action of  $\text{PTL}_L$ (which generates Vir  $\oplus \overline{\text{Vir}}$  in the scaling limit), we expect that in the scaling limit

$$
\varphi L_{-n_1} \dots L_{-n_p} |\mathcal{W}_{1k}\rangle = L_{-n_1} \dots L_{-n_p} \varphi |\mathcal{W}_{1k}\rangle = L_{-n_1} \dots L_{-n_p} |\bar{\chi}_{1k}\rangle \qquad (4.29)
$$

and thus  $L_{-n_1} \ldots L_{-n_p} | \mathcal{W}_{1k} \rangle \rangle$  and  $L_{-n_1} \ldots L_{-n_p} | \bar{\chi}_{1k} \rangle \rangle$  will also form a Jordan block.

• Finally, let us comment on the case of  $\mathcal{W}_{10}$ . Here, the vertex operator  $\mathcal{V}_{10}$  is a null state, and in  $W_{\leq 1}$  we have a Jordan block for the pair  $(|\mathcal{V}_{10}\rangle_L, |\mathcal{W}_{10}\rangle_L)$ .

#### 4.3.2 Hilbert space

A crucial question is then to decide which representations should be included in the Hilbert space, so that the scaling limit results in a consistent CFT, *i.e.* with a consistent operator algebra. Indeed, several unequivalent representations correspond to the same spectrum in the continuum limit.

Let us first examine the choice  $W = W_0 \oplus W_1 \oplus W_2 \ldots$  as the Hilbert space, with the associated scalar product  $\langle \cdot, \cdot \rangle$ . In this representation, the zero-norm vectors span the subspace Im  $(\varphi) \subset W_0$ , and they actually decouple from the whole vector space W. Once they have been removed, we are left with  $\widehat{W} = \widehat{W}_0 \oplus W_1 \oplus W_2 \dots$ , where the scalar product  $\langle \cdot, \cdot \rangle$  is non-degenerate for generic n. Hence, in the corresponding CFT in the scaling limit, the 2- and 3-point functions will have the standard form, and the ordinary differential equations arising from null-vector conditions will hold. These two facts are sufficient to ensure fusion rules of the form

$$
\Phi_{1,m} \times \Phi_{1,n} \to \Phi_{1,|n-m|+1} + \dots + \Phi_{1,n+m-1},
$$
\n(4.30)

separately in the holomorphic and anti-holomorphic sectors. However, the results exposed in the end of Sec. [3.3](#page-16-0) show that these rules are not obeyed, e.g. the fusion  $\mathcal{W}_{12} \times \mathcal{W}_{10} \rightarrow \mathcal{W}_{10}$  is allowed.

This contradiction is resolved if we use instead:

<span id="page-33-0"></span>
$$
\mathcal{H} = W_{\leq 1} \oplus W_2 \oplus W_3 \oplus \dots \tag{4.31}
$$

with the associated scalar product  $\langle \langle \cdot, \cdot \rangle \rangle$ . In simple terms, it means we take the same basis of states as in  $W$ , but we allow the mixing of some states from the zeroand two-leg sectors, both in the action of the algebra and in the scalar product.

In the following, we shall assume that the representation [\(4.31\)](#page-33-0) is the one that produces a consistent operator algebra in the scaling limit.

#### 4.3.3 Decoupling states

We are now ready to discuss which of the zero-norm states actually decouple from the whole Hilbert space H under the scalar product  $\langle\langle \cdot, \cdot \rangle\rangle$ . Let us denote by  $A_{1k} \in \text{Vir}$ the combination of generators which produces a null descendant at level  $k$  in the module of  $\mathcal{V}_{1k}$ , and  $\overline{A}_{1k}$  the analogous object in  $\overline{\text{Vir}}$ :

$$
|\chi_{1k}\rangle = A_{1k}|\mathcal{V}_{1k}\rangle, \qquad |\bar{\chi}_{1k}\rangle = \bar{A}_{1k}|\mathcal{V}_{1k}\rangle. \tag{4.32}
$$

As explained above, the zero-norm state  $|\chi_{1k}\rangle$  (resp.  $|\bar{\chi}_{1k}\rangle$ ) forms a Jordan block with  $|W_{1,-k}\rangle$  (resp.  $|W_{1,k}\rangle$ ). However, this fact does not tell us anything about the scalar products  $\langle \chi_{1k}, \mathcal{W}_{1,-k} \rangle = \langle \bar{\chi}_{1k}, \mathcal{W}_{1k} \rangle$ , and at present we are not in a position to make any statement on the decoupling of the vectors  $|\chi_{1k}\rangle$  and  $|\bar{\chi}_{1k}\rangle$ . We did check numerically that the scalar products  $\langle\langle \bar{\chi}_{1k}, \mathcal{W}_{1k} \rangle\rangle_L = \langle\langle \chi_{1k}, \mathcal{W}_{1,-k} \rangle\rangle_L$  for  $k = 0, 1, 2$ (setting  $\chi_{10} = \bar{\chi}_{10} \equiv V_{10}$ ) do not vanish at finite size  $L = 2, \ldots, 12$ , but considerable additional work is needed to conclude about the scaling limit of these scalar products.

The operator  $\mathcal{W}_{1k}$  (resp.  $\mathcal{W}_{1,-k}$ ) also admits a null descendant  $A_{1k}\mathcal{W}_{1k}$  (resp.  $\bar{A}_{1k}W_{1,-k}$ , since it has conformal dimensions  $(h_{1k}, h_{1,-k})$  [resp.  $(h_{1,-k}, h_{1,k})$ ]. Acting with  $\varphi$  in the scaling limit, we get

$$
\varphi(A_{1k}|\mathcal{W}_{1k}\rangle) = \varphi(\bar{A}_{1k}|\mathcal{W}_{1,-k}\rangle) = A_{1k}\bar{A}_{1k}|\mathcal{V}_{1k}\rangle, \qquad (4.33)
$$

and thus  $A_{1k}|\mathcal{W}_{1k}\rangle = \bar{A}_{1k}|\mathcal{W}_{1,-k}\rangle$ , since  $\varphi$  is injective. Indeed, in the lattice model, we find a unique state in  $W_1$  with energy  $\sim \frac{2\pi}{L} \times 2h_{1,-k}$  and zero momentum, degenerate with a unique state in  $W_0$ . In the scaling limit, the scalar product between the corresponding states is  $\langle A_{1k}\overline{A}_{1k}V_{1k}, A_{1k}W_{1k}\rangle = 0$ , because  $A_{1k}^{\dagger}A_{1k}|W_{1k}\rangle = 0$ by construction. Hence, the states  $A_{1k}|\mathcal{W}_{1k}\rangle = \overline{A}_{1k}|\mathcal{W}_{1,-k}\rangle$  and  $\overline{A}_{1k}\overline{A}_{1k}|\mathcal{V}_{1k}\rangle$  are totally decoupled, and we may set them to zero in the Hilbert space of the CFT:

$$
A_{1k}|\mathcal{W}_{1k}\rangle = \bar{A}_{1k}|\mathcal{W}_{1,-k}\rangle \equiv 0, \quad \text{and} \quad A_{1k}\bar{A}_{1k}|\mathcal{V}_{1k}\rangle \equiv 0. \quad (4.34)
$$

Note that, in the case  $k = 1$ , the lattice analogs of  $W_{1,\pm 1}$  are two of the "discrete" parafermions" [\[21,](#page-45-11) [22\]](#page-45-12) of the TL or  $O(n)$  model, i.e. lattice operators satisfying a discrete version of the Cauchy-Riemann equations  $\partial W_{1,1} = 0$  and  $\partial W_{1,-1} = 0$ .

## <span id="page-34-0"></span>4.4 OPEs in the presence of Jordan blocks

#### 4.4.1 Limiting procedure

The Jordan block structures discussed in previous sections appear at the point  $n = \tilde{n}$ , for generic n. We can thus follow a treatment of the singular OPEs similar to the  $c \to 0$  limit of [\[7,](#page-44-6) [23\]](#page-45-13), except that in our case we have a two-parameter family of CFTs (labelled by g and  $e_0$  in the notations of Sec. [2\)](#page-3-0): we shall fix the coupling constant g, and let the background charge  $e_0$  tend to  $(1 - g)$ .

More specifically, we have seen that for general parameters  $(n, \tilde{n})$ , we get for the TL loop model the central charge and dimensions [\(2.18\)](#page-7-1) of the form:

$$
c(g, e_0) = 1 - \frac{6e_0^2}{g}, \qquad h_{me}(g, e_0) = \frac{1}{4} \left( m\sqrt{g} - \frac{e}{\sqrt{g}} \right)^2 - \frac{e_0^2}{4g}, \tag{4.35}
$$

where  $m = 0, e \in e_0 + \mathbb{Z}$  for electric operators  $\mathcal{V}_{0e}$ , and  $m \in \{1, 2, 3, \dots\}, e \in \mathbb{Z}/m$ for electro-magnetic operators  $\mathcal{W}_{me}$ , and

$$
n = -2\cos\pi g, \qquad \tilde{n} = 2\cos\pi e_0. \tag{4.36}
$$

In contrast, the dimensions of the Kac table for central charge  $c(g, e_0)$  are of the form

$$
h_{rs}^{(K)}(g, e_0) = (r\alpha_- + s\alpha_+)^2 - \frac{e_0^2}{4g}, \qquad (4.37)
$$

with  $(r, s)$  integers, and

$$
\alpha_{+} + \alpha_{-} = -\frac{e_0}{\sqrt{g}}, \qquad \alpha_{+}\alpha_{-} = -1.
$$
 (4.38)

The general idea which we develop in the following is to consider an OPE of two operators, such that one of the terms in the expansion is a null state belonging to

a Jordan block of  $L_0 + \bar{L}_0$  for  $n = \tilde{n}$ , and analyse the behaviour of OPE coefficients in the limit  $\widetilde{n} \to n$ .

In particular, the following dimensions of vertex operators coincide with the first row of the Kac table in this limit:

$$
h_{0,e_0+k} \to h_{1,k+1}^{(K)}, \qquad h_{1,k+1} \to h_{1,k+1}^{(K)}.
$$
\n(4.39)

### 4.4.2 OPE coefficients

Consider the OPE between two primary fields  $\Phi_1$  and  $\Phi_2$ , with dimensions  $(h_1, \bar{h}_1)$ and  $(h_2, \bar{h}_2)$ :

<span id="page-35-0"></span>
$$
\Phi_1(z,\bar{z})\Phi_2(0) = \sum_p C(\Phi_1,\Phi_2,\Phi_p) z^{-h_1-h_2+h_p} \bar{z}^{-\bar{h}_1-\bar{h}_2+\bar{h}_p} \left[\Phi_p(0)+\dots\right],\qquad(4.40)
$$

where the sum is over all the primary fields  $\Phi_p$  appearing in the fusion  $\Phi_1 \times \Phi_2$ , and the ... denote the contributions from the descendants of  $\Phi_p$ . In the following, we shall need the precise expression of the OPE coefficients of some of these descendants. By the standard methods of CFT, we obtain

$$
C(\Phi_1, \Phi_2, L_{-k_1} \dots L_{-k_m} \Phi_p) = C(\Phi_1, \Phi_2, \Phi_p) \times \beta_{12}^{p(k_1, \dots, k_m)},
$$
\n(4.41)

where the  $\beta_{12}^{p(k_1,...k_m)}$  satisfy a set of linear recursion identities. At level one we have

$$
2h_p \beta_1^{p(1)} = h_1 - h_2 + h_p. \tag{4.42}
$$

At level two, the coefficients of  $L_{-1}^2 \Phi_p$  and  $L_{-2} \Phi_p$  are determined by the system

$$
2(2h_p + 1)\beta_{12}^{p(1,1)} + 3\beta_{12}^{p(2)} = (h_1 - h_2 + h_p + 1)\beta_{12}^{p(1)},
$$
  
\n
$$
6h_p\beta_{12}^{p(1,1)} + (4h_p + c/2)\beta_{12}^{p(2)} = (2h_1 - h_2 + h_p),
$$
\n(4.43)

whose solution may be written as

$$
\beta_{12}^{p(2)} = \frac{P(h_1, h_2, h_p)}{16h_p^2 + 2(c - 5)h_p + c},
$$
\n
$$
\beta_{12}^{p(1,1)} = \frac{2(2h_1 - h_2 + h_p) - (8h_p + c)\beta_{12}^{p(2)}}{12h_p},
$$
\n(4.44)

where

$$
P(h_1, h_2, h_p) = -3(h_1 - h_2 + h_p)(h_1 - h_2 + h_p + 1) + 2(2h_p + 1)(2h_1 - h_2 + h_p).
$$
 (4.45)

### 4.4.3 Null states in the OPE

As we have seen in previous sections, at  $n = \tilde{n}$ , the null descendant  $\chi_{1k}$  at level k of the primary operator  $\mathcal{V}_{1k}$  may survive in the theory, forming a Jordan block in  $L_0 + \bar{L}_0$  with its logarithmic partner  $\mathcal{W}_{1,-k}$ . Let us analyse in detail the case of  $\mathcal{V}_{12}$ , which is the energy operator in the TL loop model.

Consider two primary fields  $\Phi_1$  and  $\Phi_2$ , such that their fusion contains the terms

$$
\Phi_1 \times \Phi_2 \to \mathcal{V}_{0, e_0+1} + \mathcal{W}_{1, -2} + \dots \tag{4.46}
$$

where the ... denote primary fields with distinct dimensions. In the limit  $\tilde{n} \to n$ , we have

$$
h = h_{0, e_0 + 1} \to h_{12}^{(K)}, \qquad h' = h_{12} \to h_{12}^{(K)}.
$$
 (4.47)

The contributions from level-two descendants of  $V_h = V_{0,eq+1}$  in the OPE [\(4.40\)](#page-35-0) can be organised as

<span id="page-36-0"></span>
$$
\frac{P(h_1, h_2, h)}{16h^2 + 2(c - 5)h + c} \left( L_{-2} - \frac{8h + c}{12h} L_{-1}^2 \right) \mathcal{V}_h + \frac{2h_1 - h_2 + h}{6h} L_{-1}^2 \mathcal{V}_h. \tag{4.48}
$$

The numerator  $P(h_1, h_2, h)$  of the first term is a polynomial which vanishes if  $h =$  $h_{12}^{(K)}$  and  $(h_1, h_2)$  obey the standard fusion rule with  $\Phi_{12}$  (expressed in vertex charges  $h_j = \alpha_j^2 - 2\alpha_0 \alpha_j$   $\alpha_2 = \alpha_1 \pm \alpha_+/2$ , whereas the denominator has roots  $h_{12}^{(K)}$  and  $h_{21}^{(K)}$ .

If the dimensions  $h_1$  and  $h_2$  obey the standard fusion rule with  $\Phi_{12}$  in the limit  $\tilde{n} \to n$ , then all the coefficients in [\(4.48\)](#page-36-0) remain finite. As  $\tilde{n} \to n$ , the first term converges to the null state

$$
(L_{-2} - gL_{-1}^2) V_{12} \equiv \chi_{12}. \tag{4.49}
$$

On the other hand, more interestingly, we shall now show that the presence of the operator  $W_{1,-2}$  allows the fusion  $\Phi_1 \times \Phi_2 \to V_{12}$ , even if  $\alpha_2 \neq \alpha_1 \pm \alpha_2/2$ . In this case, we define the finite quantity

$$
Q_{12} = \frac{P(h_1, h_2, h)}{16(h - h_{21}^{(K)})},
$$
\n(4.50)

and [\(4.48\)](#page-36-0) takes the form

<span id="page-36-1"></span>
$$
\frac{Q_{12}}{h - h_{12}^{(K)}} (L_{-2} - gL_{-1}^2) \mathcal{V}_h + \# L_{-1}^2 \mathcal{V}_h, \qquad (4.51)
$$

where # denotes a finite coefficient. Hence, in the limit  $\tilde{n} \to n$ , the null state  $\chi_{12}$ appears in the OPE of  $\Phi_1 \times \Phi_2$  with a diverging coefficient. This diverging term in the OPE [\(4.40\)](#page-35-0) should be cancelled by a term coming from  $\mathcal{W}_{1,-2}$ , which tells us that the latter operator should decompose as

<span id="page-36-2"></span>
$$
\mathcal{W}_{1,-2} = \frac{C(\Phi_1, \Phi_2, \mathcal{V}_h)}{C(\Phi_1, \Phi_2, \mathcal{W}_{1,-2})} \times \frac{Q_{12}}{h - h_{12}^{(K)}} \left[ -(L_{-2} - g L_{-1}^2) \mathcal{V}_h + \kappa \ w_{1,-2} \right], \quad (4.52)
$$

where  $w_{1,-2}$  has a finite limit as  $\widetilde{n} \to n$ , and  $\kappa$  is a vanishing coefficient. Note that  $w_{1,-2}$  is not defined uniquely, since it we can add a term  $\propto (L_{-2} - g L_{-1}^2) \mathcal{V}_h$  to it.

We expand the power factors which multiply the term  $(4.51)$  in the OPE:

$$
z^{-h_1-h_2+h+2} \overline{z}^{-h_1-h_2+h} =
$$
  

$$
z^{-h_1-h_2+h'+2} \overline{z}^{-h_1-h_2+h'} \times [1 + (h-h') \log(z\overline{z}) + O(\widetilde{n} - n)].
$$
 (4.53)

Then, if we set the normalising factor in [\(4.52\)](#page-36-2) to  $\kappa = h - h'$ , the OPE [\(4.40\)](#page-35-0) takes the well-defined form

$$
\Phi_1(z,\bar{z})\Phi_2(0) = z^{-h_1-h_2+h_{12}+2}\bar{z}^{-h_1-h_2+h_{12}}C(\Phi_1,\Phi_2,w_{1,-2})\times \{w_{1,-2}(0)+[(L_{-2}-gL_{-1}^2)\mathcal{V}_{0,e_0+1}](0)\log(z\bar{z})\} + \dots
$$
\n(4.54)

where the ... denote contributions from other vertex operators and other descendants, and the OPE coefficient is given by

$$
C(\Phi_1, \Phi_2, w_{1,-2}) = C(\Phi_1, \Phi_2, \mathcal{V}_h) \times Q_{12} \times \left(\frac{h - h'}{h - h_{12}^{(K)}}\right). \tag{4.55}
$$

Finally, combining the definition [\(4.52\)](#page-36-2) of  $w_{1,-2}$  and the well-known two-point functions for  $\widetilde{n} \neq n$ :

$$
\langle \mathcal{V}_h(z,\bar{z})\mathcal{V}_h(0)\rangle = |z|^{-4h}, \qquad \langle \mathcal{W}_{1,-2}(z,\bar{z})\mathcal{W}_{1,-2}(0)\rangle = |z|^{-4h'}, \langle \mathcal{V}_h(z,\bar{z})\mathcal{W}_{1,-2}(0)\rangle = 0,
$$
\n(4.56)

we obtain the two-point functions in the limit  $\widetilde{n} \to n$ :

$$
\langle \chi_{12}(z,\bar{z})\chi_{12}(0)\rangle = 0, \qquad \langle w_{1,-2}(z,\bar{z})w_{1,-2}(0)\rangle = \frac{\theta - 2\beta \log(z\bar{z})}{z^{2h_{1,-2}}\,\bar{z}^{2h_{12}}},
$$
  

$$
\langle \chi_{12}(z,\bar{z})w_{1,-2}(0)\rangle = \frac{\beta}{z^{2h_{1,-2}}\,\bar{z}^{2h_{12}}},
$$
\n(4.57)

where  $\theta$  is arbitrary, and the indecomposability parameter  $\beta$  is given by

$$
\beta = \lim_{e_0 \to 1-g} \frac{\langle \mathcal{V}_h | (L_2 - g L_1^2)(L_{-2} - g L_{-1}^2) | \mathcal{V}_h \rangle}{h - h'}, \qquad (4.58)
$$

where  $h = h_{0, e_0+1}$  and  $h' = h_{12}$ . A little algebra gives the final result

$$
\beta = 4(1 - g). \tag{4.59}
$$

## <span id="page-37-0"></span>5 Conclusion

In this work, we have shown how to adapt the conformal bootstrap approach to the case of operators with conformal spin, and applied it to compute some OPE coefficients involving some mixed electric-magnetic operators in the  $O(n)$  loop model. It turns out that, in all the cases where this approach applies, the result is particularly simple: the OPE coefficient is the geometric mean of the timelike-Liouville DOZZ formula [\[19,](#page-45-9) [17\]](#page-45-7) on the holomorphic and anti-holomorphic sectors. Our results are supported by economical, yet precise numerical calculations based on the transfer matrix of the loop model. In doing so, we used a numerical method which can be exploited more extensively to test many predictions on OPE coefficients.

Many OPE coefficients remain out of reach for this conformal bootstrap approach, including some very natural observables from the geometric point of view, e.g. the probability that three points lie on the same loop. We have traced these difficulties to the non-diagonalisability of the dilatation operator  $(L_0+\bar{L}_0)$ , and proposed a simplistic analysis of the representation theory of the periodic Temperley-Lieb algebra, along the lines of  $[9, 10, 11, 12, 13]$  $[9, 10, 11, 12, 13]$  $[9, 10, 11, 12, 13]$  $[9, 10, 11, 12, 13]$  $[9, 10, 11, 12, 13]$ , to account for this effect at the lattice level. Similarly to the representation theory of quantum groups, this problem is much simpler for generic values of the loop fugacity  $n = q + q^{-1}$  when q is not a root of unity, which is the case under study, but many questions still remain unsolved, the most important one being: do the null vectors descending from electric operators  $|V_{1k}\rangle$  become decoupled or not in the scaling limit? Answering this type of questions would require a substantially deeper analysis of the loop model for generic loop fugacity, which we leave for future work.

We shall give here the explicit calculation leading from the expansion coefficients [\(3.23\)](#page-11-0) to the expression [\(3.25\)](#page-11-2) of the OPE constants. First, let us notice that the case  $k = 1$  corresponds to  $C^2(\mathcal{V}_\alpha, \mathcal{V}_\alpha, \mathcal{V}_{11}) = 1$ , since  $\mathcal{V}_{11} = 1$ . while the second basis  $\{J_1(z), J_2(z)\}\$  has simple monodromy around  $z = 1$ :

J_1(z) = z^{-\frac{a}{2}} (1-z)^{-\frac{b}{2}} {}_2F_1\left(\frac{d-a-b+\rho}{2}, \frac{d'-a-b+\rho}{2}; 1+\frac{b'-b}{2}; 1-z\right) ,\qquad (B.5)

It is useful to know how these conformal blocks transform under the various reparameterisations  $\alpha_i \leftrightarrow \alpha'_i$ :

As long as all four conformal blocks are well defined (i.e.  $a'-a \notin 2\mathbb{Z}$  and  $b'-b \notin 2\mathbb{Z}$ ), this matrix is invertible, with inverse  $M^{-1}(a, b, d) = M(b, a, d)$ .

Suppose now the indicial equation around the singularity  $z = 0$  is degenerate, namely  $a - a' \in 2\mathbb{Z}$ . Without any loss of generality we can assume  $a' - a = 2m$  where m is a positive integer. Since we have  $a' + a = 2p - 2$ , this means

On the other hand, [\(B.4\)](#page-40-4) is no longer well-defined, since its third argument is a non-positive integer. We can approach the degenerate case as

with small  $\epsilon$ . Let us denote  $\{I_{1,\epsilon}(z), I_{2,\epsilon}(z)\}\)$  the corresponding solutions. The first conformal block encounters no issues as  $\epsilon \to 0$ :

On the other hand, the second conformal block, as given by [\(B.4\)](#page-40-4), has a first order pole

where  $(x)_n = x(x+1)...(x+n-1)$  is the Pochhammer symbol. For instance the second conformal block can be chosen as the limit

\widetilde{I}_2(z) = \frac{(-1)^m m!}{2} \lim_{\epsilon \to 0} \left[ \frac{\Gamma\left(\frac{d-a'-b+\rho}{2}\right) \Gamma\left(\frac{d'-a'-b+\rho}{2}\right)}{\Gamma\left(1+\frac{b'-b}{2}\right)} I_{1,\epsilon}(z) + \frac{\Gamma\left(\frac{d-a'-b'+\rho}{2}\right) \Gamma\left(\frac{d'-a'-b'+\rho}{2}\right)}{\Gamma\left(1+\frac{b-b'}{2}\right)} I_{2,\epsilon}(z) \right],

with  $a$  and  $a'$  given by  $(B.11)$ . Note that this expression still makes sense for  $b'-b \in 2\mathbb{Z}$ , since the r.h.s. has a well-defined limit as  $b'-b \to 2n$ ,  $n \in \mathbb{Z}$ . Moreover

we have chosen the second conformal block to be invariant under  $b \leftrightarrow b'$ . This gives a solution of the form

$$
\widetilde{I}_2(z) = I_1(z) \log z + H(z) z^{(1-m-\rho)/2}, \tag{B.15}
$$

where  $H(z)$  is a regular function around  $z = 0$ , whose explicit expression we will not need. The monodromy around  $z = 0$  is no longer diagonal:

I_1(z) \to e^{-i\pi a} I_1(z), \qquad \widetilde{I}_2(z) \to e^{-i\pi a} \left[ 2i\pi I_1(z) + \widetilde{I}_2(z) \right]. \tag{B.16}

In this appendix we explain how locality imposes the constraint :

a - \bar{a} \in \mathbb{Z} \qquad \text{or} \qquad a' - \bar{a} \in \mathbb{Z} \,. \tag{C.1}

We first prove this in the generic case  $(a' - a \notin 2\mathbb{Z})$  before doing the log case  $(a' - a \in 2\mathbb{Z}).$

Note that this four-point function cannot vanish due to the trivial fusion channel to the vacuum. To describe this four-point function we can choose  $b = \bar{b} = 3\rho - 2$  and  $d = a$ . If there are two fusion channels, then we must have  $a - \bar{a} \in \mathbb{Z}$  or  $a' - \bar{a} \in \mathbb{Z}$  as we explained in the main text. Suppose now there is a single fusion channel around  $z = 0$ . Using the freedom to change  $a \to a'$ , we can assume

$$
G(z, \bar{z}) = X_1 I_1(z) \bar{I}_1(\bar{z}).
$$
\n(C.3)

Since there is a single fusion channel as  $z \to 0$ , there is also a single fusion channel as  $z \to 1^6$  $z \to 1^6$ . There we know that this fusion has to be  $\Phi_{1,2} \times \Phi_{1,2} \to 1$ , which corresponds to

$$
G(z, \bar{z}) = J_1(z)\bar{J}_1(\bar{z}).
$$
 (C.4)

Consistency of these two relations enforces  $M_{12} = \overline{M}_{12} = 0$ , where M is given by [\(B.8\)](#page-41-2) with  $b = 3\rho - 2$  and  $d = a$ . This requires respectively  $a \in \mathbb{Z}$  and  $\bar{a} \in \mathbb{Z}$ , and in particular  $a - \bar{a} \in \mathbb{Z}$  is obeyed.

## <span id="page-43-0"></span>C.2 Logarithmic case

Let us now consider the logarithmic case, namely  $a' - a = 2m$  with  $m \in \mathbb{N}$ . This means  $a = \rho - 1 - m$  and  $a' = \rho - 1 + m$ . If we also have  $\bar{a}' - \bar{a} = 2\bar{m}$  with  $\bar{m} \in \mathbb{N}$ , then  $a - \bar{a} = \bar{m} - m \in \mathbb{Z}$ . Out of interest we mention the form of the four-point function compatible with locality:

$$
G(z,\bar{z}) = X_1 I_1(z)\bar{I}_1(\bar{z}) + X_2 \left[ I_1(z)\overline{\tilde{I}_2}(\bar{z}) + \tilde{I}_2(z)\bar{I}_1(\bar{z}) \right],
$$
 (C.5)

with monodromy factor  $e^{i\pi(\bar{a}-a)}$  as in the generic case.

This only leaves the hybrid case to consider : a logarithmic holomorphic side, say  $a'-a=2m$  with  $m \in \mathbb{N}$ , coupled to a generic antiholomorphic behavior,  $\bar{a}'-\bar{a} \notin 2\mathbb{Z}$ . In this case locality demands a single fusion channel, which we can choose to be

$$
G(z, \bar{z}) = X_1 I_1(z) \bar{I}_1(\bar{z}).
$$
\n(C.6)

The same arguments as in the generic case apply, and we find that a and  $\bar{a}$  have to be integers. This is impossible since  $a = \rho - 1 - m$ . Therefore the hybrid case is ruled out by locality.

## <span id="page-43-1"></span>D Numerical determination of OPE coefficients from the transfer matrix

In this section, we describe a simple algorithm to compute OPE coefficients numerically using the eigenstates of the transfer matrix or Hamiltonian. Only the principle of the method is given here, and we will expose all the implementation details for its application to loop models in a future publication.

Let  $(\phi_1, \phi_2, \phi_3)$  be three quasi-primary operators of a CFT, and suppose we want to determine numerically the OPE coefficient  $C(\phi_1, \phi_2, \phi_3)$ . This coefficient can be expressed as the scalar product

$$
C(\phi_1, \phi_2, \phi_3) = \langle \phi_1 | \phi_2 | \phi_3 \rangle.
$$
 (D.1)

Let us consider the transfer matrix  $t_L$  for a periodic system of circumference  $L$ , denote by  $|\phi_i\rangle_L$  the eigenstate of  $t_L$  corresponding to the state  $|\phi_i\rangle$  in the CFT, and

suppose that  $|\phi_1\rangle_L$  and  $|\phi_3\rangle_L$  are obtained numerically by a partial diagonalisation of  $t_L$ . Moreover, suppose that one is able to construct a lattice operator  $\phi_2^{(L)}$  $\mathcal{L}^{(L)}(\vec{r})$ which behaves as  $\phi_2^{(L)} \sim N_2 L^{-x_2} \phi_2$  in the scaling limit, where  $N_2$  is some nonuniversal normalisation constant. More precisely, there will exist a series of operators  $\phi_2, \phi'_2 \dots$  of increasing scaling dimensions  $x_2 < x'_2 < \dots$  and some normalisation factors  $N_2, N'_2, \ldots$  so that

<span id="page-44-9"></span>
$$
\phi_2^{(L)} = N_2 L^{-x_2} \phi_2 + N'_2 L^{-x'_2} \phi'_2 + \dots \tag{D.2}
$$

in the scaling limit. Clearly, with the standard normalisation of CFT states  $\langle \phi_j | \phi_j \rangle =$ 1, and denoting  $|0\rangle$  the ground state, one has  $\phi_2^{(L)}$  $\langle L \rangle_0$   $\langle L \rangle_L \sim N_2 L^{-x_2} |\phi_2\rangle$ . Then one obtains:

$$
\frac{L\langle\phi_1|\phi_2^{(L)}|\phi_3\rangle_L}{L\langle\phi_2|\phi_2^{(L)}|0\rangle_L} = C(\phi_1, \phi_2, \phi_3) + O(1/L^{x_2''-x_2}),
$$
\n(D.3)

where  $x_2''$  is the scaling dimension of the most relevant subleading operator in the expansion [\(D.2\)](#page-44-9) contributing to  $_L\langle \phi_1 | \phi_2^{(L)} \rangle$  $\binom{L}{2} \ket{\phi_3}_L$  or  $\binom{L}{\phi_2} \ket{\phi_2^{(L)}}$  $\binom{L}{2} \ket{0}_L$ .
