# A Class of Hamiltonians for a Three-Particle Fermionic System at Unitarity

#### Abstract

We consider a quantum mechanical three-particle system made of two identical fermions of mass one and a different particle of mass  $m$ , where each fermion interacts via a zero-range force with the different particle. In particular we study the unitary regime, i.e., the case of infinite twobody scattering length. The Hamiltonians describing the system are, by definition, self-adjoint extensions of the free Hamiltonian restricted on smooth functions vanishing at the two-body coincidence planes, i.e., where the positions of two interacting particles coincide.

It is known that for m larger than a critical value  $m^* \simeq (13.607)^{-1}$  a self-adjoint and lower bounded Hamiltonian  $H_0$  can be constructed, whose domain is characterized in terms of the standard point-interaction boundary condition at each coincidence plane.

Here we prove that for  $m \in (m^*, m^{**})$ , where  $m^{**} \simeq (8.62)^{-1}$ , there is a further family of selfadjoint and lower bounded Hamiltonians  $H_{0,\beta}$ ,  $\beta \in \mathbb{R}$ , describing the system. Using a quadratic form method, we give a rigorous construction of such Hamiltonians and we show that the elements of their domains satisfy a further boundary condition, characterizing the singular behavior when the positions of all the three particles coincide.

# 1 Introduction

The theoretical analysis of the quantum mechanical three-body problem with pairwise zero-range interactions is a subject to considerable interest in the physics of cold atoms. This is essentially due to the recently achieved possibility to realize experimental conditions where the interaction is well described by a zero-range force, in particular in the unitary limit. Roughly speaking, unitary limit means that the two-body interaction is characterized by a zero-energy resonance or, equivalently, by an infinite value of the scattering length. The correct definition of the model, the occurrence of the Efimov effect and the analysis of the stability problem, i.e., the existence of a finite lower bound for the Hamiltonian, have been widely studied both in the physical [\[BH,](#page-28-0) [CMP,](#page-28-1) [CT,](#page-28-2) [CW,](#page-29-0) [KM,](#page-29-1) [TC,](#page-29-2) [WC1,](#page-29-3) [WC2\]](#page-29-4) and in the mathematical [\[CDFMT,](#page-29-5) [DFT,](#page-29-6) [FM,](#page-29-7) [FT,](#page-29-8) [MS,](#page-29-9) [M1,](#page-29-10) [M3,](#page-29-11) [M4\]](#page-29-12) literature.

Here we consider the  $2+1$  fermionic problem, where two identical fermions of mass one interact with a particle of different nature and mass m at unitarity. Setting  $\hbar = 1$ , the formal Hamiltonian of the system reads

$$
\mathcal{H} = -\frac{1}{2m}\Delta_{\mathbf{x}_0} - \frac{1}{2}\Delta_{\mathbf{x}_1} - \frac{1}{2}\Delta_{\mathbf{x}_2} + \mu\delta(\mathbf{x}_1 - \mathbf{x}_0) + \mu\delta(\mathbf{x}_2 - \mathbf{x}_0),\tag{1.1}
$$

where the fermions are labelled by 1,2 and  $\mu \in \mathbb{R}$ . We denote vectors in  $\mathbb{R}^d$  by bold-face symbols x, while we will set  $x = |x|$ . Extracting the center of mass motion and introducing the relative coordinates  $y_i = x_0 - x_i$ ,  $i = 1, 2$ , we can reduce to study the formal operator

H = -\Delta_{\mathbf{y}_1} - \Delta_{\mathbf{y}_2} - \frac{2}{m+1} \nabla_{\mathbf{y}_1} \cdot \nabla_{\mathbf{y}_2} + \mu \delta(\mathbf{y}_1) + \mu \delta(\mathbf{y}_2). \tag{1.2}
$$

Due to the symmetry constraint, the Hamiltonian acts on the Hilbert space given by square integrable functions which are antisymmetric under exchange  $y_1 \rightarrow y_2$ , i.e.,

$$
L_{\mathbf{f}}^{2}(\mathbb{R}^{6}) = \{ \Psi \in L^{2}(\mathbb{R}^{6}) \mid \Psi(\mathbf{y}_{1}, \mathbf{y}_{2}) = -\Psi(\mathbf{y}_{2}, \mathbf{y}_{1}) \}.
$$
 (1.3)

There are several possible ways to give the formal expression [\(1.2\)](#page-1-0) a mathematically rigorous meaning, where the formal coupling constant  $\mu$  must be replaced by a new renormalized parameter. A typical approach which exploits the theory of self-adjoint extensions of symmetric operators goes through the analysis of the symmetric operator given by the free kinetic energy of the three particles acting on the domain of regular functions vanishing on the planes  $\{y_i = 0\}$ ,  $i = 1, 2$ , i.e., where the point interaction is supported. Such operators are not self-adjoint but only symmetric, and they admit a huge number of self-adjoint extensions (both deficiency indices equal  $+\infty$ ). Among all possible extensions a special role is played by a rather small class, the so-called Skornyakov Ter-Martirosyan (STM) operators, which are the natural generalization to the three-body case of the Schrödinger operator with a point interaction in the two-body case, and come up with a domain of functions that, as we shall discuss in a moment, have the expected asymptotic behaviour prescribed by physical heuristics, whenever two particles come on top of each other.

This is a major point that we want to emphasize already at this qualitative stage, before proceeding with the details and remarking it further once the appropriate notation will be set up. Indeed, the result of our work here is two-fold. On the one hand we construct a class of self-adjoint operators for our three-body system (see Proposition [2.1\)](#page-8-0), by means of the corresponding quadratic forms, which are all of the STM form, namely reproduce the "physical" boundary condition in the vicinity of the coincidence planes  $\{y_i = 0\}$ , and in which the scattering length of the two-body, zero-range interaction is set to infinity (the so-called "unitary regime"). On the other hand, we show that, precisely in the same regime of masses determined in the physical literature through formal arguments, in the domain of each such Hamiltonian certain ("most singular") wave-functions display a further asymptotic behaviour in the vicinity of the *triple coincidence point*  ${y_1 = y_2 = 0}$ , a behaviour that we can cast in the form under which is usually known in the physical literature (see Proposition [2.2](#page-8-1) and Remark [2.8\)](#page-9-0).

The existence, for a special regime of masses, of additional STM extensions besides the natural ("Friedrichs") extension that we constructed and studied in a previous work of ours [\[CDFMT\]](#page-29-5) was already known in the case of finite scattering length. We now build these extra STM extensions also at unitarity, we reproduce for each of them the physical triple-point asymptotics, and we show that in the present case of infinite scattering length the regime of masses for the existence of such STM

extensions is *larger* than the corresponding regime found recently in the mathematical literature [\[M3,](#page-29-11) [M4\]](#page-29-12) for finite scattering length, and it coincides precisely with the regime of masses predicted by physical heuristics.

In order to develop these arguments, let us quickly revisit first the construction of a point interaction between two particles in 3 dimensions and then the natural STM generalisation for three particles. For a two-particle system it is known (see, e.g., [\[AGH-KH\]](#page-28-3)) that, extracting the center of mass motion and denoting by  $x$  the relative coordinate, the self-adjoint operator describing the Hamiltonian  $h_{\alpha}$  with zero-range interaction has a domain consisting of functions  $\Psi(\mathbf{x})$ , which have the following asymptotics when  $\mathbf{x} \to 0$ :

where  $q \in \mathbb{C}$  is a complex number uniquely associated with  $\Psi$  and  $\alpha \in \mathbb{R}$  labels the self-adjoint extension. Moreover,  $h_{\alpha}$  acts as the free Laplacian outside the origin. More precisely, the Hamiltonian can be defined as follows

where

G(\mathbf{x}) := \frac{1}{4\pi|\mathbf{x}|}\tag{1.6}
$$

and  $\dot{H}^n(\mathbb{R}^d)$  denotes the homogeneous space of functions u such that  $|\mathbf{k}|^n\hat{u}(\mathbf{k}) \in L^2(\mathbb{R}^d)$ . We recall that functions in  $\dot{H}^n(\mathbb{R}^d)$  are in particular continuous, so that the value of the function at the origin  $\phi(0)$  is well defined. Moreover it can be easily seen that the condition  $\phi(0) = \alpha q$  in [\(1.5\)](#page-2-0) is equivalent to [\(1.4\)](#page-2-1). The physical meaning of the parameter  $\alpha$  is related to the notion of scattering length, which for such model equals  $(-4\pi\alpha)^{-1}$ . The free Hamiltonian is recovered for  $\alpha \to \infty$ , while particularly relevant for our purposes is the case  $\alpha = 0$ , corresponding to infinite scattering length. Notice that the Hamiltonian  $h_0$  admits a zero-energy resonance, provided by the function  $(1.6)$ . Indeed G locally belongs to  $\mathscr{D}(h_0)$  or, more precisely, it satisfies all the conditions in [\(1.5\)](#page-2-0) but the required decay at  $|\mathbf{x}| \to \infty$  to ensure that the function belongs to  $L^2(\mathbb{R}^3)$  ( $G \notin L^2(\mathbb{R}^3)$  but  $G \in L^2_{loc}(\mathbb{R}^3)$ ). Moreover, according to the action of the operator described in [\(1.5\)](#page-2-0)

$$
h_0G=0.
$$

The above considerations lead to define a STM operator  $H_{\alpha}$  for our  $2+1$  fermionic system on a domain given by functions Ψ belonging to

$$
H_{\mathbf{f}}^{2}\left(\mathbb{R}^{6}\setminus\cup_{i=1,2}\{\mathbf{y}_{i}=0\}\right)\cap L_{\mathbf{f}}^{2}(\mathbb{R}^{6}),
$$

such that

\Psi(\mathbf{y}_1, \mathbf{y}_2) = \frac{(-1)^{i+1}\xi(\mathbf{y}_j)}{4\pi|\mathbf{y}_i|} + \alpha(-1)^{i+1}\xi(\mathbf{y}_j) + o(1), \quad \text{as } |\mathbf{y}_i| \to 0, \ i, j = 1, 2, \ i \neq j,
$$
 (1.7)

where  $\xi$  is a smooth (i.e.,  $C_0^{\infty}(\mathbb{R}^3)$ ) complex function defined on  $\mathbb{R}^3$ , uniquely associated with  $\Psi$ . Moreover,  $\tilde{H}_{\alpha}$  acts as the free Hamiltonian outside the planes  $\{y_i = 0\}$ . The STM operator is symmetric but not self-adjoint and then one can investigate the existence of possible self-adjoint extensions.

In [\[CDFMT\]](#page-29-5) we have approached the problem using the theory of quadratic forms in Hilbert spaces (for a different approach see, e.g., [\[M1,](#page-29-10) [M3,](#page-29-11) [M4\]](#page-29-12)). In particular we have introduced the following quadratic form which can be easily seen (see, e.g., [\[CFT\]](#page-29-13)) to be the most natural one associated to the STM operator  $\tilde{H}_0$

where  $\hat{f}$  denotes the Fourier transform of f (recall that the label 0 does not stand for the free Hamiltonian but rather for the Hamiltonian with  $\alpha = 0$ , i.e., with infinite two-body scattering length). Moreover the "potential" generated by the "charge"  $\xi$  (we will often use this terminology borrowed from electrostatics) is defined by

One of the result proven in [\[CDFMT\]](#page-29-5) is that there exists a critical value of the mass  $m^*$ , approximately given by

$$
m^* \simeq 0.0735 = (13.607)^{-1},\tag{1.13}
$$

such that, if  $m > m^*$  the quadratic form  $\mathcal{F}_0$  is closed and bounded from below (in fact positive) on its domain, so defining a self-adjoint operator  $H_0$  which turns out to be the Friedrichs extension of  $H_0$ . On the other hand, for  $m < m^*$  it is shown that the form is unbounded from below, which implies that the operator can not be at the same time self-adjoint and bounded from below (see, e.g., [\[FT,](#page-29-8) Proposition 4.1]).

In the stable case  $m > m^*$ ,  $H_0$  is the following operator

$$
\mathcal{D}(H_0) = \left\{ u \in L^2_f(\mathbb{R}^6) \mid u = w + \mathcal{G}\xi, w \in \dot{H}^2_f(\mathbb{R}^6), \xi \in \mathcal{D}_0, \int_{\mathbb{R}^3} d\mathbf{k}' \,\hat{w}(\mathbf{k}', \mathbf{k}) = \left(\widehat{\Gamma_0 \xi}\right)(\mathbf{k})\right\}
$$
  
\n
$$
H_0 u = H_{\text{free}} w,
$$
\n(1.14)

where  $H_{\text{free}}$  is the free Laplacian in the center of mass coordinates, i.e., the multiplication operator by  $k_1^2 + k_2^2 + \frac{2}{m+1}k_1 \cdot k_2$  in Fourier transform,  $\Gamma_0$  is the self-adjoint operator in  $L^2(\mathbb{R}^3)$  associated with the closed and positive quadratic form  $\Phi_0$ , i.e.,

\left(\widehat{\Gamma_0 \xi}\right)(\mathbf{p}) := 2\pi^2 \sqrt{\frac{m(m+2)}{(m+1)^2}} p \hat{\xi}(\mathbf{p}) + \int_{\mathbb{R}^3} d\mathbf{q} \, \frac{\hat{\xi}(\mathbf{q})}{p^2 + q^2 + \frac{2}{m+1}\mathbf{p} \cdot \mathbf{q}},\tag{1.15}
$$

and  $\mathscr{D}_0$  is its natural domain of self-adjointness. It is easy to verify that if  $u \in \mathscr{D}(H_0)$  then the condition [\(1.7\)](#page-2-3) is satisfied for  $\xi \in \mathcal{D}_0$  and  $\alpha = 0$ . Indeed, applying the Fourier transform, (1.7) can be translated into the boundary condition

$$
\int_{|k'| \le N} \mathrm{d}\mathbf{k}' \,\hat{u}(\mathbf{k}, \mathbf{k}') = N \,\xi(\mathbf{k}) + o(1), \qquad \text{as } N \to \infty,
$$
\n(1.16)

which is satisfied by any function in  $\mathscr{D}(H_0)$ . Such results extend to the case of N fermions of one species interacting with a different test particle, although in that case the condition on the mass for stability is not optimal.

At least at a numerical or heuristic level, it is however known, as discussed, e.g., in [\[CT,](#page-28-2) [WC1\]](#page-29-3), that there are other possible extensions of the STM operator for  $\alpha = 0$  (for the characterization of the extensions in the case  $\alpha \neq 0$  see [\[M3,](#page-29-11) [M4\]](#page-29-12)). More precisely, there exists  $m^{\star\star} > m^{\star}$ , approximately given by

$$
m^{\star\star} \simeq 0.116 = (8.62)^{-1},
$$

such that for

$$
m^* < m < m^{**} \tag{1.17}
$$

there exists a family of self-adjoint extensions of  $H_0$  whose domains are given by functions decomposing as in  $\mathscr{D}(H_0)$  but with singular charges  $\xi$  not belonging to  $H^{1/2}(\mathbb{R}^3)$ . More precisely, their asymptotic behavior is characterized as follows

with

\tilde{\xi}_n(k) \propto \frac{q}{k^{2-s}} + \frac{\beta q}{k^{2+s}} + o(k^{-2-s}), \quad \text{as } k \to \infty,

where  $Y_l^n$  denotes the spherical harmonics of indices  $(l,n)$ , q is a complex number,  $\beta \in \mathbb{R}$  is a parameter labeling such operators and  $0 < s = s(m) < 1$  is another parameter depending on the mass m (see next Section for further details). Notice that the 3 dimensional Fourier anti-transform of  $k^{-2+s}$  does not belong to  $\dot{H}^{1/2}(\mathbb{R}^3)$  for any  $s > 0$ , since the function does not decay sufficiently fast as  $k \to \infty$ . In terms of self-adjoint extensions the one studied in [\[CDFMT\]](#page-29-5) belongs to the family and is (formally) recoverd for  $\beta = +\infty$ . Such an extension has indeed the smallest possible domain (Friedrichs extension), whereas the one with  $\beta = 0$  show the largest domain (Krein extension).

It is worth noticing that the parameter  $s(m)$  is determined by requiring that a charge of the form  $k^{-2+s} Y_1^n(\vartheta_k, \varphi_k)$  is formally in the kernel of the operator [\(1.15\)](#page-3-0) (see eq. [\(2.1\)](#page-5-0) below). As we shall see, the existence of charges of the form [\(1.18\)](#page-4-0), [\(1.19\)](#page-4-1) implies a further boundary condition satisfied by the wave function at the triple coincidence point  $y_1 = y_2 = 0$ . Therefore, following the analogy with the two-body case, one can say that in the special case  $\beta = 0$  the Hamiltonian exhibits a "three-body resonance".

The aim of this paper is to give a rigorous construction of such self-adjoint extensions. Following the line of [\[CDFMT\]](#page-29-5), the method of the proof is again based on the theory of quadratic forms in Hilbert spaces. In Section 2 we give the precise formulation of the problem and state the main results. The proofs are postponed in Section 3. The Appendices collect some technical results used in the rest of the paper.

# 2 Main Results

In this section we formulate the main results contained in the paper. First we introduce a suitable quadratic form and prove its closedness. Next we derive the self-adjoint operator associated with such form which turns out to be a self-adjoint extension of the STM operator. Finally the end of the Section is devoted to some comments and remarks.

## 2.1 Quadratic form

We introduce here the main object under investigation, namely the quadratic form  $\mathcal{F}_{0,\beta}$  and study its properties. We start by defining the critical masses which will play a crucial role in the following analysis. For any  $s \in [0, 1]$ , we consider the equation

As we mentioned in the introduction, such an equation follows by imposing that the function  $k^{-2+s} Y_1^n(\vartheta_k, \varphi_k)$  is formally in the kernel of the operator [\(1.15\)](#page-3-0) and therefore it corresponds to a "three-body resonance" condition.

One can show (see proposition [A.2\)](#page-23-0) that [\(2.1\)](#page-5-0) has a unique solution  $m(s)$ , monotonically increasing in s. We call  $s(m)$  the inverse function of  $m(s)$ , namely the unique solution of  $(2.1)$  w.r.t. s, for given  $m > 0$ . The most relevant quantities are introduced in the next definition.

Definition 2.1 (Critical masses). We define the critical masses  $m^* < m^{**}$  as

From now on we fix the value of the mass  $m$  in such a way that

$$
m^* < m < m^{**}.\tag{2.3}
$$

We also denote for short

with  $\beta_n \in \mathbb{R} \cup \{+\infty\}$ . The quadratic form we are going to study is the following

with

$$
\widehat{\Xi_n} = \tilde{\xi}^- Y_1^n, \qquad \tilde{\xi}^-(k) = \frac{1}{k^{2-s(m)}}\tag{2.7}

Before stating the main result it is worth discussing further the above expression of the quadratic form. First of all the quadratic form discussed in [\[CDFMT\]](#page-29-5) is obtained for  $\beta_n = +\infty$ , which in turn implies  $q_n = 0$  for all n. Moreover the quadratic form  $\mathcal{F}_{0,\beta}$  is a perturbation of the quadratic form associated with the free Hamiltonian  $H_{\text{free}}$ , which is supported on the coincidence planes  $\{y_i = 0\}$ , i.e., a zero-range perturbation. Concerning the regularity class of the charges, we stress that the assumption  $\eta \in H^{-1/2}(\mathbb{R}^3)$  is a necessary condition implied by the requirement

$$
u = w + \mathcal{G}\eta \in L^2_f(\mathbb{R}^3), \quad \text{with} \quad w \in \dot{H}^1_f(\mathbb{R}^6). \tag{2.8}
$$

This fact will be discussed in details in Appendix [B.](#page-24-0) Notice that  $k^{-1/2}\Xi_n^{-}(\mathbf{k})$  is  $L^2$ -summable for large k if and only if

$$
s(m) < 1, \quad \text{or equivalently,} \quad m < m^{\star\star}.\tag{2.9}
$$

We also note that the assumption  $\eta \in H^{-1/2}(\mathbb{R}^3)$  imposes a further constraint on the behavior of the charge  $\hat{\xi}(\mathbf{k})$  only for k small. More precisely, for  $0 < s(m) \leq 1/2$  the charge  $\hat{\xi}$  must compensate the singularity at the origin of  $\tilde{\xi}^-$  in order to have  $\hat{\eta} \in L^2_{\text{loc}}(\mathbb{R}^3)$  (recall that  $\eta \in H^{-1/2}(\mathbb{R}^3)$  implies  $\hat{\eta} \in L^2_{\text{loc}}(\mathbb{R}^3)$ . For  $1/2 < s(m) < 1$  one has  $\tilde{\xi}^- \in L^2_{\text{loc}}(\mathbb{R}^3)$  and then also  $\hat{\xi} \in L^2_{\text{loc}}(\mathbb{R}^3)$ . Therefore, in this case we have  $\xi \in H^{1/2}(\mathbb{R}^3)$ .

The main result about the quadratic form  $\mathcal{F}_{0,\beta}$  is formulated in the next theorem, proved in Section 3.1.

#### <span id="page-6-5"></span>**Theorem 2.1** (Closedness of  $\mathcal{F}_{0,\beta}$ ).

For any  $m^*$   $< m < m^{**}$  and  $\beta$ , the quadratic form  $\mathcal{F}_{0,\beta}$  is closed and bounded from below on the domain  $\mathscr{D}[\mathcal{F}_{0,\beta}].$ 

<span id="page-6-2"></span>**Remark 2.1** (Boundedness from below of  $\mathcal{F}_{0,\beta}$ ).

From the proof of Proposition [3.1](#page-11-0) it is clear that the quadratic form  $\mathcal{F}_{0,\beta}$  is positive for  $\beta_n \geq 0$  for any  $n = -1, 0, +1$ , while if  $\beta_n < 0$  for some n a lower bound is explicitly given by

$$
E_0(m) = -\left[2(1 - s(m))\frac{D_1c_1 + D_2(D_1 + 1)}{D_1D_2c_1}\max_{n \in \{-1, 0, +1\}}|\beta_n|\right]^{1/s(m)},\tag{2.10}
$$

where  $c_1, D_1, D_2$  are finite constants inherited from previous inequalities in the proof (see Section [3.1](#page-10-0)) and specifically [\(3.13\)](#page-12-0) and [\(B.4\)](#page-24-1)). Notice that  $E_0 \to -\infty$  as  $m \to m^*$  and  $E_0 \to 0$  as  $m \to m^{**}$ .

#### <span id="page-6-4"></span>**Remark 2.2** (Parameter  $s(m)$ ).

By direct inspection of the proof one can realize that the parameter  $s(m)$  can be replaced with any positive real number  $0 < s < 1$ , i.e., not solving the algebraic equation [\(2.1\)](#page-5-0), and the closedness of  $\mathcal{F}_{0,\beta}$  would not be affected. On the other hand, the corresponding self-adjoint operator is an extension of the STM operator if and only if  $s = s(m)$  (see next Section [2.2\)](#page-6-0).

## <span id="page-6-0"></span>2.2 Self-adjoint extensions of the STM operator

We are now able to introduce the operator associated with  $\mathcal{F}_{0,\beta}$ . We set

\Gamma_{0}\xi \in L^{2}(\mathbb{R}^{3}), q_{n} \in \mathbb{C}, \int_{\mathbb{R}^{3}} d\mathbf{k}' \hat{w}(\mathbf{k}', \mathbf{k}) = \left(\widehat{\Gamma_{0}\xi}\right)(\mathbf{k}),
$$
  

$$
\beta_{n}q_{n} = 2 \lim_{\varepsilon \to 0} \left(\Xi_{n}^{-}, \Gamma_{0}\xi\right)_{L^{2}(\mathbb{R}^{3}_{\varepsilon})}\right\}
$$
  

$$
H_{0,\beta}u = H_{\mathrm{free}}w,
$$
  
(2.11)

where  $\Gamma_0 \xi$  is given by the following expression

$$
\left(\widehat{\Gamma_{0}}\widehat{\xi}\right)(\mathbf{p}) := 2\pi^{2} \sqrt{\frac{m(m+2)}{(m+1)^{2}}} p \,\hat{\xi}(\mathbf{p}) + \int_{\mathbb{R}^{3}} d\mathbf{q} \,\frac{\hat{\xi}(\mathbf{q})}{p^{2} + q^{2} + \frac{2}{m+1}\mathbf{p} \cdot \mathbf{q}},\tag{2.12}
$$

and we have denoted for short

$$
\mathbb{R}_{\varepsilon}^{d} := \left\{ \mathbf{k} \in \mathbb{R}^{d} \mid k \ge \varepsilon \right\}.
$$
\n(2.13)

In the previous definitions  $\Gamma_0$  has to be understood as the formal action of the integral operator [\(2.12\)](#page-7-0), without any reference to its counterpart as operator on a Hilbert space. Note however that if  $\Gamma_0$  given in [\(2.12\)](#page-7-0) is properly restricted to its maximal domain within the Hilbert space  $L^2(\mathbb{R}^3)$ , then it coincides with positive, self-adjoint operator associated with the quadratic form  $\Phi_0$  with maximal domain (Friedrichs extension). A closer inspection on the condition  $\Gamma_0 \xi \in L^2(\mathbb{R}^3)$  reveals that it is certainly satisfied by  $H^1$ –functions since both the diagonal and off-diagonal term in [\(2.12\)](#page-7-0) can be easily bounded by the  $H^1$ –norm of ξ. However, there exist  $H^{1/2}$ –functions ξ so that both the diagonal and off-diagonal terms are not in  $L^2(\mathbb{R}^3)$  but their sum, i.e.,  $\Gamma_0 \xi$ , is finite almost everywhere and defines a function in  $L^2(\mathbb{R}^3)$ . Concerning the operator  $H_{0,\beta}$ , in Section 3.2 we prove the following theorem.

# **Theorem 2.2** (Self-adjointness of  $H_{0,\beta}$ ).

For any  $m^* < m < m^{**}$  and  $\beta$ , the operator  $H_{0,\beta}$  with domain  $\mathscr{D}(H_{0,\beta})$  is self-adjoint and bounded from below, and its quadratic form is  $\mathcal{F}_{0,\beta}$ .

#### Remark 2.3 (Comparison with [\[M2\]](#page-29-14)).

As already pointed out, in  $[M2]$  it was studied the case  $\alpha \in \mathbb{R}$  by an operator theoretical approach: by studying the deficiency indeces of the STM operator, it is proven that the STM operator admits a one parameter family of self-adjoint extensions whenever

$$
m < \tilde{m}^{\star\star}, \qquad \text{with } \tilde{m}^{\star\star} \simeq 0.0812 \tag{2.14}
$$

A direct comparison with our result immediately shows that the region above  $m<sup>*</sup>$  where such selfadjoint extensions exist is narrower, since trivially

$$
\tilde{m}^{\star\star} < m^{\star\star}.\tag{2.15}
$$

It is important to remark however that the threshold  $m^{\star\star}$  is the one obtained by heuristic arguments in the physics literature (see [\[W,](#page-29-15) p. 45] or [\[E\]](#page-29-16)) for the unitary regime  $\alpha = 0$ .

#### Remark 2.4 (Operator theoretical approach).

The possible discrepancy with the result obtained in [\[M2\]](#page-29-14) motivates a comment about the differences in the approach to the problem. Indeed the work  $[M2]$  is based on a standard operator theoretical analysis of the deficiency indeces of the STM operator for  $\alpha \in \mathbb{R}$ . More precisely the deficiency spaces turn out to be subspaces of the space of charges  $\eta$ , living on the coincidence planes  $\{x_i = x_j\}$ . Such methods apply as well to the case  $\alpha = 0$ . However what makes the extension non trivial is that, while for  $\alpha \neq 0$  the condition  $\eta \in L^2(\mathbb{R}^3)$  is required and the usual theory of operators in Hilbert spaces can be applied, on the opposite for  $\alpha = 0$  the space of charges is much larger, i.e.,  $\eta \in H^{-1/2}(\mathbb{R}^3)$ (see Appendix [B\)](#page-24-0). At the level of quadratic forms this can be easily understood by observing that if  $\alpha \neq 0$  an additional term proportional to  $\alpha ||\eta||_{L^2(\mathbb{R}^3)}^2$  arises and therefore the assumption  $\eta \in L^2(\mathbb{R}^3)$ can not be avoided to obtain a meaningful expression. Obviously for  $\alpha = 0$  such a term is absent and the only constraint to  $\eta$  is  $\mathcal{G}\eta \in L^2_{loc}(\mathbb{R}^6)$ , which yields the condition  $\eta \in H^{-1/2}(\mathbb{R}^3)$  as proven in Appendix [B.](#page-24-0)

In the next proposition we establish the relation between  $H_{0,\beta}$  and the STM operator.

#### <span id="page-8-0"></span>Proposition 2.1 (STM extensions).

The operator  $H_{0,\beta}$  with domain  $\mathscr{D}(H_{0,\beta})$  is a self-adjoint extension of the STM operator  $\tilde{H}_0$ .

The domain of  $H_{0,\beta}$  contains also charges with a singular behavior for  $k \to \infty$ . More precisely, denoting

$$
\nu(m) := \frac{8\pi}{m+1} \int_1^{\infty} dp \, \frac{1}{p} \int_0^1 dt \, t^2 \int_0^{1/p} dq \frac{q^{1-s(m)}}{(q^2+1)^2 - \frac{4}{(m+1)^2} q^2},\tag{2.16}
$$

we prove the following result.

<span id="page-8-1"></span>Proposition 2.2 (Charge asymptotics).

The domain  $\mathscr{D}(H_{0,\beta})$  (recall [\(2.4\)](#page-5-1) and [\(2.11\)](#page-6-1)) contains charges  $\eta(\mathbf{k})$  such that

<span id="page-8-2"></span>
$$
\hat{\eta}(\mathbf{k}) = \sum_{n=-1}^{1} \tilde{\eta}_n(k) Y_1^n(\vartheta_k, \varphi_k), \n\tilde{\eta}_n(k) \sum_{k \to \infty} \frac{q_n}{k^{2-s(m)}} + \frac{r_n}{k^{2+s(m)}} + o(k^{-2-s(m)}),
$$
\n(2.17)

$$
r_n = \frac{\beta_n}{\nu(m)} q_n. \tag{2.18}
$$

The above propositions will be proved in Section 3.2. Here we notice that [\(2.18\)](#page-8-2) represents a further boundary condition (see the analogy with [\(1.4\)](#page-2-1)) satisfied by the elements of  $\mathscr{D}(H_{0,\beta})$ , besides the standard boundary condition characterizing the STM operator [\(1.7\)](#page-2-3). Condition [\(2.18\)](#page-8-2) is equivalent to the boundary condition known in the physical literature characterizing the behavior of the wave function at short distances (see, e.g., [\[WC1\]](#page-29-3)).

Let us conclude this Section on our main results with a few additional remarks that clarify the relevance of our work.

#### **Remark 2.5** (Boundedness from below of  $H_{0,\beta}$ ).

The lower bound discussed in Remark [2.1](#page-6-2) clearly applies to  $H_{0,\beta}$  too, and therefore  $H_{0,\beta}$  is a positive operator if  $\beta_n \geq 0$ , whereas it is semi-bounded if some  $\beta_n < 0$ , with the r.h.s. of [\(2.10\)](#page-6-3) providing a bound from below.

# **Remark 2.6** (Parameter  $s(m)$  and STM extensions).

As anticipated in the Remark [2.2](#page-6-4) the specific choice  $s = s(m)$  is crucial only to capture STM-type operators. The above Proposition indeed guarantees that, if such a choice is made,  $H_{0,\mathcal{B}}$  extends the STM operator. However one can also realize that the converse is true, namely if  $s \neq s(m)$  then there is still a self-adjoint operator  $H_{0,\beta}$  which however is not an extension of  $H_0$ . A simple way to prove this is by looking at the first boundary condition in  $(2.11)$ : whenever  $s = s(m)$ , the formal action of  $\Gamma_0$  on  $\Xi_n^-$  identically vanishes (see [\(3.52\)](#page-18-0)), i.e.,  $\Gamma_0 \Xi_n^- = 0$ , so that the condition can be rewritten

<span id="page-8-3"></span>
$$
\int_{\mathbb{R}^3} \mathrm{d}\mathbf{k}' \,\hat{w}(\mathbf{k}', \mathbf{k}) = \left(\widehat{\Gamma_0 \eta}\right)(\mathbf{k}),\tag{2.19}
$$

i.e., on the r.h.s.  $\xi$  can be replaced with  $\eta$ , the full charge. This qualifies the STM extensions, since if it applies, any wave function in  $\mathscr{D}(H_{0,\mathcal{B}})$  has the STM behavior [\(1.7\)](#page-2-3) on the planes where the interaction is supported, i.e.,

$$
\Psi(\mathbf{y}_1, \mathbf{y}_2) = \frac{(-1)^{i+1}\eta(\mathbf{y}_j)}{4\pi|\mathbf{y}_i|} + \alpha(-1)^{i+1}\eta(\mathbf{y}_j) + o(1), \qquad \text{as } |\mathbf{y}_i| \to 0, \ i, j = 1, 2, \ i \neq j. \tag{2.20}
$$

Obviously the same does not hold for a generic  $s \neq s(m)$ , since the boundary condition can not be cast in the [\(2.19\)](#page-8-3) form.

## **Remark 2.7** (Self-adjoint extension above  $m^{\star\star}$ ).

As discussed in the previous Remark the self-adjoint extensions considered in this paper exist only for  $m < m^{\star\star}$ . For  $m > m^{\star\star}$  no such extension exists and the STM operator is in fact essentially self-adjoint. The unique self-adjoint extension is for  $m > m^{\star\star}$  the one studied in [\[CDFMT\]](#page-29-5), or the one corresponding formally to  $\beta = +\infty$ : by taking  $\beta = +\infty$  we mean that  $q = 0$  for any charge  $\eta$  and therefore functions in the domain of the operator have no singularity at the triple point  $\{x_1 = x_2 = 0\}$ (see next Remark [2.8\)](#page-9-0).

## <span id="page-9-0"></span>Remark 2.8 (Asymptotics at the triple coincidence point).

The second boundary condition in  $(2.11)$  can be interpreted also as a prescription about the asymptotic behavior of singularities in position space at  $y_1 = y_2 = 0$ , i.e., when the positions of the three particles coincide. Indeed, if we look at the behavior of the potentials generated by  $\tilde{\xi}^-$  and  $\tilde{\xi}^+$ , we have by scaling

$$
\mathcal{G}(\tilde{\xi}^{-}Y_{1}^{n})(\mu\mathbf{y}_{1},\mu\mathbf{y}_{2})=\frac{1}{\mu^{2+s}}\mathcal{G}(\tilde{\xi}^{-}Y_{1}^{n})(\mathbf{y}_{1},\mathbf{y}_{2}), \qquad \mathcal{G}(\tilde{\xi}^{+}Y_{1}^{n})(\mu\mathbf{y}_{1},\mu\mathbf{y}_{2})=\frac{1}{\mu^{2-s}}\mathcal{G}(\tilde{\xi}^{+}Y_{1}^{n})(\mathbf{y}_{1},\mathbf{y}_{2}).
$$

Therefore we have

<span id="page-9-2"></span>
$$
\mathcal{G}\eta(\mu\hat{\mathbf{y}}_1, \mu\hat{\mathbf{y}}_2) \underset{\mu \to 0}{\sim} \frac{1}{\mu^2} \left( g_1(m)\frac{q}{\mu^s} + g_2(m)\frac{\beta q}{\nu(m)}\mu^s + o(\mu^s) \right), \tag{2.21}
$$

where we have denoted by  $\hat{\mathbf{y}}_i$  any unit vector in  $\mathbb{R}^3$ , i.e., such that  $|\hat{\mathbf{y}}_i| = 1$  $|\hat{\mathbf{y}}_i| = 1$ , and<sup>1</sup>

$$
g_{1,2}(m) = \frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} d\mathbf{k}_1 d\mathbf{k}_2 \, \frac{e^{i\mathbf{k}_1 \cdot \hat{\mathbf{y}}_1 + i\mathbf{k}_2 \cdot \hat{\mathbf{y}}_2}}{k_1^2 + k_2^2 + \frac{2}{m+1} \mathbf{k}_1 \cdot \mathbf{k}_2} \left\{ \frac{Y_{1,n}(\vartheta_1, \varphi_1)}{k_1^{2 \pm s(m)}} - \frac{Y_{1,n}(\vartheta_2, \varphi_2)}{k_2^{2 \pm s(m)}} \right\}.
$$
 (2.22)

We see that the coefficients of the two more singular terms must be proportional as is customary stated in the physical literature [\[WC1,](#page-29-3) note 43].

**Remark 2.9** (Further extensions for  $\ell > 1$ ).

A priori one could imagine of reproducing the analysis performed here within any sector with angular momentum  $\ell > 1$  odd, and therefore costruct other families of self-adjoint extensions of the STM operator with a larger domain in the subspace of charge with angular momentum  $\ell > 1$ . Obviously this would introduce further thresholds  $m_{\ell}^{**}$  depending on  $\ell$  for the existence of such extensions, which are allowed only for  $m < m_{\ell}^{\star\star}$ . However the analysis contained in [A](#page-20-0)ppendix A shows that  $m_{\ell}^{\star\star}$ is a decreasing function of  $\ell$  (see Lemma [A.1\)](#page-20-1), i.e.,  $m_{\ell}^{**} \leq m_3^{**}$  for any  $\ell \geq 3$  odd, and already for  $\ell = 3$  one has  $(A.9)$ 

$$
m_3^{\star\star} < m^\star. \tag{2.23}
$$

Hence all those possible extensions are certainly unbounded from below. This is why we do not investigate this question further.

It is worth to comment further on the peculiar structure of the 3-body Hamiltonians constructed and discussed in this work, which is typical for self-adjoint extensions of bounded-below symmetric operators (in our case, the operator  $H_0$  we started with). Our findings first of all recover the natural self-adjoint Hamiltonian of STM type  $H_{0,\infty}$  (that is,  $\beta = \infty$  in the present notation): this is precisely

<span id="page-9-1"></span><sup>&</sup>lt;sup>1</sup>Note that by rotational invariance  $g_{1,2}$  are both independent of  $\hat{\mathbf{y}}_{1,2}$ .

the Hamiltonian associated with the quadratic form  $\mathcal{F}_0$  defined in [\(1.8\)](#page-3-1)-[\(1.11\)](#page-3-1). Next to it, for each fixed m in the considered regime, all other Hamiltonians  $H_{0,\beta}$  have been obtained by enlarging the domain of the quadratic form  $\mathcal{F}_0$ , as done in [\(2.5\)](#page-5-2)-[\(2.6\)](#page-5-2), and this enlargement consisted of adding each time a one-dimensional subspace of charges spanned by a function that has, radially in the momentum coordinate, the singularity  $\xi^-(k) = k^{-2+s(m)}$ . This is a general fact for the quadratic form of each extension of a semi-bounded symmetric operator, that is, such a form is defined also on a suitable additional one-dimensional subspace of the defect subspace of the initial operator (see, e.g., [\[AS,](#page-28-4) [B\]](#page-28-5)).

In our case, we see that the singular behaviour of the extra charge qualifies the domain of the extended quadratic form. We then demonstrated that for each such enlarged forms the domain of the corresponding self-adjoint Hamiltonian not only reproduces the standard STM condition at the coincidence hyperplane, but it is further characterised by an additional relation between the extra (singular) charge and the regular charge – this is the second condition in [\(2.11\)](#page-6-1). Last, and physically most relevant, we cast this constraint on the singular charge in a form [\(2.18\)](#page-8-2) that, when applicable, has a natural interpretation as boundary condition of the three-body wave function at the triple coincidence point [\(2.21\)](#page-9-2).

In short we may say that, fixed  $m$ , each Hamiltonian of the class considered in this work is eventually characterised by the worse (most singular) behaviour that the wave-functions of its domain undergo in the vicinity of the triple coincidence point.

# <span id="page-10-0"></span>3 Proofs

#### 3.1 Closedness of the quadratic form

This Section is devoted to the proof of the closedness of the quadratic form  $\mathcal{F}_{0,\beta}$  on the domain  $\mathscr{D}[\mathcal{F}_{0,\beta}]$  given by  $(2.5)$ .

The first trivial but useful observation it that the quadratic form  $\Phi_0$  acting on the charge is invariant under rotations, i.e., it is block diagonal in the subspace decomposition of the Hilbert space induced by eigenvectors of the angular momentum. More precisely, let us introduce the subspaces

$$
\mathcal{H}_{\ell} = \left\{ \eta \in L^{2}(\mathbb{R}^{3}) \mid \hat{\eta}(\mathbf{k}) = \sum_{n=-\ell}^{\ell} \tilde{\eta}_{\ell,n}(k) Y_{\ell}^{n}(\vartheta_{k}, \varphi_{k}) \right\}
$$
(3.1)

and

$$
\mathcal{H}_{\ell,n} = \left\{ \eta \in L^2(\mathbb{R}^3) \mid \hat{\eta}(\mathbf{k}) = \tilde{\eta}_{\ell,n}(k) Y_{\ell}^n(\vartheta_k, \varphi_k) \right\}.
$$
 (3.2)

We can thus consider separately the closure of the form restricted to any given subspace  $\mathscr{H}_{\ell,n}$  of the charge space. Indeed, for any admissible charge  $\eta$  in  $\mathscr{D}[\mathcal{F}_{0,\beta}]$ , the decomposition

$$
\hat{\eta}(\mathbf{k}) = \sum_{\ell \in \mathbb{N}} \sum_{n=-\ell}^{\ell} \tilde{\eta}_{\ell,n}(k) Y_{\ell}^{n}(\vartheta_k, \varphi_k), \tag{3.3}
$$

implies the splitting [\[CDFMT,](#page-29-5) Lemma 4.2]

$$
\Phi_0[\xi] = \sum_{\ell \in \mathbb{N}} \sum_{n=-\ell}^{\ell} \Phi_0[\tilde{\xi}_{\ell,n}],\tag{3.4}
$$

where (recall that  $P_{\ell}$  is the  $\ell$ -th Legendre polynomial)

$$
\Phi_0[\tilde{\xi}_{\ell,n}] := 2\pi^2 \frac{\sqrt{m(m+2)}}{m+1} \int_0^\infty dp \, p^3 \, |\tilde{\xi}_{\ell,n}(p)|^2 \n+ 2\pi \int_{-1}^1 dt \, P_\ell(t) \int_0^\infty dp \, p^2 \int_0^\infty dq \, q^2 \frac{\tilde{\xi}_{\ell,n}^*(p)\tilde{\xi}_{\ell,n}(q)}{p^2 + q^2 + \frac{2}{m+1}pqt}.
$$
\n(3.5)

Note that the angular momentum decomposition [\(3.3\)](#page-10-1) is not the one associated with the whole wave function u but the one inherited from the function  $\eta$  of the singular term  $\mathcal{G}\eta$ .

On the other hand it is obvious from the definition that for any  $u \in \mathscr{D}[\mathcal{F}_{0,\beta}]$  such that  $u = w + \mathcal{G}\eta$ , with

$$
\eta \in \left(\bigoplus_{\ell \neq 1} \mathcal{H}_{\ell}\right) \bigcap H^{-1/2}(\mathbb{R}^3),\tag{3.6}
$$

then

$$
\mathcal{F}_{0,\beta}[u] = \mathcal{F}_0[u],\tag{3.7}
$$

i.e., the only subspace on which the quadratic form  $\mathcal{F}_{0,\beta}$  differs from  $\mathcal{F}_0$  is the one identified by the condition  $\eta \in \mathcal{H}_1$ . We thus restrict our analysis to the quadratic forms

$$
\mathcal{D}\left[\mathcal{F}_{0,\beta}^{(n)}\right] = \left\{ u \in \mathcal{D}[\mathcal{F}_{0,\beta}] \mid \eta \in \mathcal{H}_{1,n} \cap H^{-1/2}(\mathbb{R}^3), \eta = \xi + q\Xi_n^-, \xi \in \dot{H}^{1/2}(\mathbb{R}^3), q \in \mathbb{C} \right\}, (3.8)
$$
  

$$
\mathcal{F}_{0,\beta}^{(n)}[u] = F[w] + 2\Phi_0[\xi] + \beta |q|^2.
$$
 (3.9)

where  $n = -1, 0, +1$  and  $\beta \in \mathbb{R}$ . Note that the n-dependence of  $\mathcal{F}_{0,\beta}^{(n)}$  is in fact trivial, namely it appears only in the domain decomposition whereas the action of both forms  $\mathcal{F}_{0,\beta}^{(n)}$  and  $\Phi_0^{(1)}$  does not depend on *n*. Hence if one proves closedness of each form  $\mathcal{F}_{0,\beta}^{(n)}$  separately, Theorem [2.1](#page-6-5) is proven as well. From now on we will simplify the notation by redefining

$$
\Phi_0 := \Phi_0^{(1)}, \qquad \Xi^- := \Xi_n^-.
$$
\n(3.10)

<span id="page-11-0"></span>**Proposition 3.1** (Closedness of  $\mathcal{F}_{0,\beta}^{(n)}$ ).

For any  $n = -1, 0, +1, \beta \in \mathbb{R}$  and  $m^* < m < m^{**}$ , the quadratic form  $\mathcal{F}_{0,\beta}^{(n)}$  is closed and bounded from below on  $\mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}].$ 

*Proof.* The proof is slightly simpler in the case  $\beta \geq 0$ , that we will consider first, since boundedness from below is much easier to show. All the terms of the quadratic form are indeed positive in this case and the only one whose positivity is non-trivial is  $\Phi_0$ , but the assumption  $m > m^*$  directly implies  $\Phi_0 \geq 0$  (see [\[CDFMT,](#page-29-5) Proposition 3.1]).

Let us then consider a sequence  $u_i \in \mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}]$  such that  $\mathcal{F}_{0,\beta}^{(n)}[u_i - u_j] \to 0$  for  $i, j \to \infty$  and  $u_i \to u$ in  $L_f^2(\mathbb{R}^6)$  for  $i \to \infty$ . Since  $u_i \in \mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}],$  there exist  $w_i \in \dot{H}^1(\mathbb{R}^6)$ ,  $\xi_i \in \dot{H}^{1/2}(\mathbb{R}^3)$  and  $q_i \in \mathbb{C}$  such that

$$
u_i = w_i + \mathcal{G}\left(\xi_i + q_i \Xi^{-}\right). \tag{3.11}
$$

Moreover using the lower bound in [\[CDFMT,](#page-29-5) Eq.  $(3.13)$ ] for  $\Phi_0$ , we have

$$
\mathcal{F}_{0,\beta}^{(n)}[u_i - u_j] \ge \mathcal{F}_0[w_i - w_j] + 2\Phi_0[\xi_i - \xi_j]
$$
\n
$$
\ge D_1 \int_{\mathbb{R}^6} d\mathbf{k}_1 d\mathbf{k}_2 \left( k_1^2 + k_2^2 \right) |(\hat{w}_i - \hat{w}_j)(\mathbf{k}_1, \mathbf{k}_2)|^2 + D_2 \int_{\mathbb{R}^3} d\mathbf{p} \, p \left| (\hat{\xi}_i - \hat{\xi}_j)(\mathbf{p}) \right|^2 \tag{3.12}
$$

<span id="page-12-0"></span>
$$
D_1 = \frac{m}{m+1}, \qquad D_2 = 4\pi^2 \frac{\sqrt{m(m+2)}}{m+1} \left(1 - \Lambda_1(m)\right) \tag{3.13}
$$

where  $\Lambda_1(m) < 1$  as long as  $m > m^*$ . Hence

<span id="page-12-1"></span>
$$
\int_{\mathbb{R}^6} d\mathbf{k}_1 d\mathbf{k}_2 \left(k_1^2 + k_2^2\right) \left| (\hat{w}_i - \hat{w}_j)(\mathbf{k}_1, \mathbf{k}_2) \right|^2 \underset{i,j \to \infty}{\longrightarrow} 0 \tag{3.14}
$$

and

<span id="page-12-2"></span>
$$
\int_{\mathbb{R}^3} d\mathbf{p} \, p \, |(\hat{\xi}_i - \hat{\xi}_j)(\mathbf{p})|^2 \underset{i,j \to \infty}{\longrightarrow} 0. \tag{3.15}
$$

Due to [\(3.14\)](#page-12-1), there exists  $\hat{g} \in L^2_f(\mathbb{R}^6)$  such that

$$
\int_{\mathbb{R}^6} d\mathbf{k}_1 d\mathbf{k}_2 \left| \sqrt{k_1^2 + k_2^2} \,\hat{w}_i(\mathbf{k}_1, \mathbf{k}_2) - \hat{g}(\mathbf{k}_1, \mathbf{k}_2) \right|^2 \underset{i \to \infty}{\longrightarrow} 0 \tag{3.16}
$$

and for any  $\varepsilon > 0$ 

<span id="page-12-4"></span>
$$
\int_{\mathbb{R}_{\varepsilon}^{6}} d\mathbf{k}_{1} d\mathbf{k}_{2} \left| \hat{w}_{i}(\mathbf{k}_{1}, \mathbf{k}_{2}) - \hat{w}(\mathbf{k}_{1}, \mathbf{k}_{2}) \right|^{2} \underset{i \to \infty}{\longrightarrow} 0, \tag{3.17}
$$

where  $\mathbb{R}_{\varepsilon}^d$  is defined in [\(2.13\)](#page-7-1) and  $w \in \dot{H}^1(\mathbb{R}^6)$  with

$$
\hat{w}(\mathbf{k}_1, \mathbf{k}_2) = \frac{\hat{g}(\mathbf{k}_1, \mathbf{k}_2)}{\sqrt{k_1^2 + k_2^2}}.
$$
\n(3.18)

Analogously, from [\(3.15\)](#page-12-2) there exists  $\hat{\nu} \in L^2(\mathbb{R}^3)$  such that

<span id="page-12-3"></span>
$$
\int_{\mathbb{R}^3} \mathrm{d} \mathbf{p} \left| \sqrt{p} \hat{\xi}_i(\mathbf{p}) - \hat{\nu}(\mathbf{p}) \right|^2 \underset{i \to \infty}{\longrightarrow} 0, \qquad \int_{\mathbb{R}^3_{\varepsilon}} \mathrm{d} \mathbf{p} \left| \hat{\xi}_i(\mathbf{p}) - \hat{\xi}(\mathbf{p}) \right|^2 \underset{i \to \infty}{\longrightarrow} 0, \tag{3.19}
$$

where  $\xi \in \dot{H}^{1/2}(\mathbb{R}^3)$  and

$$
\hat{\xi}(\mathbf{p}) = \frac{\hat{\nu}(\mathbf{p})}{\sqrt{p}}.\tag{3.20}
$$

Notice that [\(3.19\)](#page-12-3) also implies

$$
\int_{\mathbb{R}_{\varepsilon}^{6}} \mathrm{d}\mathbf{k}_{1} \mathrm{d}\mathbf{k}_{2} \left| \widehat{\mathcal{G}\xi}_{i}(\mathbf{k}_{1}, \mathbf{k}_{2}) - \widehat{\mathcal{G}\xi}(\mathbf{k}_{1}, \mathbf{k}_{2}) \right|^{2} \underset{i \to \infty}{\longrightarrow} 0. \tag{3.21}
$$

From [\(3.17\)](#page-12-4), [\(3.19\)](#page-12-3) and the  $L^2$ -convergence of  $u_i$  to  $u_j$ , we have convergence of  $\mathcal{G}(q_i \Xi^-)$  in  $L^2(\mathbb{R}_{\varepsilon}^6)$ . Hence  $q_i$  is a Cauchy sequence in  $\mathbb C$  and there exists  $q \in \mathbb C$  such that  $q_i \to q$  and  $\mathcal{G}(q_i \Xi^-) \to \mathcal{G}(q \Xi^-)$ in  $L^2(\mathbb{R}^6_\varepsilon)$  for  $i \to \infty$ . Thus we obtain

<span id="page-12-5"></span>
$$
u = w + \mathcal{G}\left(\xi + q\Xi^{-}\right),\tag{3.22}
$$

which means  $u \in \mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}]$ . It is now straightforward to verify that  $\mathcal{F}_{0,\beta}^{(n)}[u_i] \to \mathcal{F}_{0,\beta}^{(n)}[u]$  as  $i \to \infty$ , concluding this first part of the proof.

In other case  $\beta < 0$  we have to be more careful in bounding from below the form. For any  $\lambda > 0$ , from  $(3.12)$  we have

$$
\mathcal{F}_{0,\beta}^{(n)}[u] + \lambda \|u\|_{L^{2}(\mathbb{R}^{6})}^{2}
$$
\n
$$
\geq (D_{1} - \delta_{1}) \int_{\mathbb{R}^{6}} d\mathbf{k}_{1} d\mathbf{k}_{2} (k_{1}^{2} + k_{2}^{2}) |\hat{w}(\mathbf{k}_{1}, \mathbf{k}_{2})|^{2} + (D_{2} - \delta_{2}) \int_{\mathbb{R}^{3}} d\mathbf{p} p |\hat{\xi}(\mathbf{p})|^{2} + Q_{\lambda}(u) \quad (3.23)
$$

where

$$
Q_{\lambda}(u) := \delta_1 \int_{\mathbb{R}^6} d\mathbf{k}_1 d\mathbf{k}_2 \left( k_1^2 + k_2^2 \right) |\hat{w}(\mathbf{k}_1, \mathbf{k}_2)|^2 + \delta_2 \int_{\mathbb{R}^3} d\mathbf{p} \, p \, \left| \hat{\xi}(\mathbf{p}) \right|^2 + \lambda \|w + \mathcal{G}\eta\|_{L^2(\mathbb{R}^6)}^2 + \beta |q|^2 \tag{3.24}
$$

and  $\delta_i \in (0, D_i)$ ,  $i = 1, 2$ . For the estimate of  $Q_\lambda$  we first notice that

$$
\int_{\mathbb{R}^6} \mathrm{d}\mathbf{k}_1 \mathrm{d}\mathbf{k}_2 \left(k_1^2 + k_2^2\right) |\hat{w}(\mathbf{k}_1, \mathbf{k}_2)|^2 \ge \lambda \int_{k_1^2 + k_2^2 > \lambda} \mathrm{d}\mathbf{k}_1 \mathrm{d}\mathbf{k}_2 \left|\hat{w}(\mathbf{k}_1, \mathbf{k}_2)\right|^2 =: \lambda \, \|w\|_{\lambda, 1}^2 \tag{3.25}
$$

and

$$
\int_{\mathbb{R}^3} \mathrm{d} \mathbf{p} \, p \, \left| \hat{\xi}(\mathbf{p}) \right|^2 \ge \lambda \int_{p > \sqrt{\lambda}} \mathrm{d} \mathbf{p} \, \frac{1}{p} \, \left| \hat{\xi}(\mathbf{p}) \right|^2 =: \lambda \, \left\| \xi \right\|_{\lambda, 2}^2. \tag{3.26}
$$

Therefore

$$
Q_{\lambda}(u) \geq \lambda \left( \delta_1 \|w\|_{\lambda 1}^2 + \delta_2 \|\xi\|_{\lambda,2}^2 + \|w + \mathcal{G}\eta\|_{\lambda,1}^2 \right) + \beta |q|^2
$$
  
\n
$$
\geq \lambda \left[ (\delta_1 + 1) \|w\|_{\lambda,1}^2 - 2\|w\|_{\lambda,1} \|\mathcal{G}\eta\|_{\lambda,1} + \|\mathcal{G}\eta\|_{\lambda,1}^2 + \delta_2 \|\xi\|_{\lambda,2}^2 \right] + \beta |q|^2
$$
  
\n
$$
= \lambda \left[ \left( \sqrt{\delta_1 + 1} \|w\|_{\lambda,1} - \frac{1}{\sqrt{\delta_1 + 1}} \|\mathcal{G}\eta\|_{\lambda,1} \right)^2 + \frac{\delta_1}{\delta_1 + 1} \|\mathcal{G}\eta\|_{\lambda,1}^2 + \delta_2 \|\xi\|_{\lambda,2}^2 \right] + \beta |q|^2
$$
  
\n
$$
\geq \lambda \left( \frac{\delta_1}{\delta_1 + 1} \|\mathcal{G}\eta\|_{\lambda,1}^2 + \delta_2 \|\xi\|_{\lambda,2}^2 \right) + \beta |q|^2 \quad (3.27)
$$

where we have used the inequality  $||a + b||^2 \ge ||a||^2 + ||b||^2 - 2||a|| ||b||$ . Using the lower bound in Lemma [B.1](#page-24-2) we have

$$
\|\mathcal{G}\eta\|_{\lambda,1}^2 \ge c_1 \|\xi + q\Xi^-\|_{\lambda,2}^2 \ge c_1 \|\xi\|_{\lambda,2}^2 + c_1|q|^2 \|\Xi^-\|_{\lambda,2}^2 - 2c_1|q|\|\xi\|_{\lambda,2}\|\Xi^-\|_{\lambda,2}.\tag{3.28}
$$

Then, proceeding as before, we find

$$
Q_{\lambda}(u) \geq \lambda \left[ \left( \frac{\delta_1 c_1}{\delta_1 + 1} + \delta_2 \right) \|\xi\|_{\lambda,2}^2 - 2 \frac{\delta_1 c_1}{\delta_1 + 1} |q| \|\xi\|_{\lambda,2} \|\Xi^-\|_{\lambda,2} + \frac{\delta_1 c_1}{\delta_1 + 1} |q|^2 \|\Xi^-\|_{\lambda,2}^2 \right] + \beta |q|^2
$$
  
 
$$
\geq \lambda \frac{\delta_1 \delta_2 c_1}{\delta_1 c_1 + \delta_2 (\delta_1 + 1)} |q|^2 \|\Xi^-\|_{\lambda,2}^2 + \beta |q|^2. \tag{3.29}
$$

An explicit computation of  $\|\Xi^-\|_{\lambda,2}^2$  yields

$$
\|\Xi^-\|_{\lambda,2}^2 = \int_{\sqrt{\lambda}}^{\infty} \mathrm{d}k \, k^{-3+2s(m)} = \frac{\lambda^{-1+s(m)}}{2(1-s(m))}.
$$
 (3.30)

Inserting [\(3.30\)](#page-13-0) in [\(3.29\)](#page-13-1), we conclude that there exists  $\lambda_0 > 0$  such that  $Q_\lambda(u) > 0$  for any  $\lambda > \lambda_0$ . Taking into account [\(3.23\)](#page-12-5), this implies that the form is lower bounded. Furthermore, proceeding as in the case  $\beta \geq 0$ , one can easily show that the form is also closed, concluding the proof.  $\Box$ 

# 3.2 Self-adjoint extensions

We now construct the self-adjoint operator associated with the quadratic form  $\mathcal{F}_{0,\beta}$ . Thanks to the rotational invariance, we can restrict to one single form  $\mathcal{F}_{0,\beta}^{(n)}$ , for  $n = -1,0,+1$  and find the associated self-adjoint operator  $H_{0,\beta}^{(n)}$ .

**Proposition 3.2** (Self-adjointness of  $H_{0,\beta}$ ).

For any  $n = -1, 0, +1, \beta \in \mathbb{R}$  and  $m^* < m < m^{**}$ , the unique self-adjoint operator  $H_{0,\beta}^{(n)}$  associated with the closed and bounded from below quadratic form  $\mathcal{F}_{0,\beta}^{(n)}$  coincides with the restriction of  $H_{0,\beta}$  to  $\mathscr{H}_n.$ 

*Proof.* By quadratic form theory the domain of the operator  $H_{0,\beta}^{(n)}$  corresponding to  $\mathcal{F}_{0,\beta}^{(n)}$  is given by

$$
\mathscr{D}\left(H_{0,\beta}^{(n)}\right) = \left\{ u \in \mathscr{D}\left[\mathcal{F}_{0,\beta}^{(n)}\right] \middle| \exists \psi \in L^{2}(\mathbb{R}^{6}), \mathcal{F}_{0,\beta}^{(n)}[v, u] = (v, \psi), \forall v \in \mathscr{D}\left[\mathcal{F}_{0,\beta}^{(n)}\right] \right\},\tag{3.31}
$$

and moreover  $\psi =: H_{0,\beta}^{(n)}u$ .

We notice that any  $u \in \mathscr{D}\left(H_{0,\beta}^{(n)}\right)$  must decompose as

$$
u = w_u + \mathcal{G}\eta_u, \qquad \eta_u = \xi_u + q_u \Xi^{-}
$$
\n
$$
(3.32)
$$

with  $w \in \dot{H}^1_f(\mathbb{R}^6)$ ,  $\eta_u \in \mathcal{H}_{1,n}$  and  $q_u \in \mathbb{C}$ . Now we characterize the domain  $\mathscr{D}\left(H_{0,\beta}^{(n)}\right)$ , by picking some special subclasses of vectors  $v \in \mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}]$ :

(a) Let us first pick some  $v \in H^1_f(\mathbb{R}^6)$ , i.e., a wave function with no singular part. In this case we obtain for any u in the domain  $\mathscr{D}\left(H_{0,\beta}^{(n)}\right)$ 

$$
\mathcal{F}_{0,\beta}^{(n)}[v,u] = F[v,w_u] = \int_{\mathbb{R}^6} d\mathbf{k}_1 d\mathbf{k}_2 \left(k_1^2 + k_2^2 + \frac{2}{m+1}\mathbf{k}_1 \cdot \mathbf{k}_2\right) \hat{v}^*(\mathbf{k}_1, \mathbf{k}_2) \hat{w}_u(\mathbf{k}_1, \mathbf{k}_2)
$$
  
=  $(v, \psi)_{L_f^2(\mathbb{R}^6)}$ , (3.33)

for some  $\psi \in L^2_f(\mathbb{R}^6)$ . Since this is finite for any v it implies that

$$
(k_1^2 + k_2^2 + \frac{2}{m+1}\mathbf{k}_1 \cdot \mathbf{k}_2) \,\hat{w}_u(\mathbf{k}_1, \mathbf{k}_2) \in L^2_f(\mathbb{R}^6),
$$

i.e.,  $w_u \in \dot{H}_{\text{f}}^2(\mathbb{R}^6)$ . Moreover a straightforward consequence is that

<span id="page-14-0"></span>
$$
H_{0,\beta}^{(n)}u = \psi = H_{\text{free}}w_u.
$$
\n(3.34)

(b) Now we take

$$
v=w_v+\mathcal{G}\xi_v,
$$

for some  $\xi_v \in H^{1/2}(\mathbb{R}^3) \cap \mathcal{H}_{1,n}$ , and we obtain via [\(3.34\)](#page-14-0)

$$
\mathcal{F}_{0,\beta}^{(n)}[v,u] = F[w_v, w_u] + 2\Phi_0[\xi_v, \xi_u] = (v, \psi)_{L^2_f(\mathbb{R}^6)} = (w_v + \mathcal{G}\xi_v, H_{\text{free}}w_u)_{L^2_f(\mathbb{R}^6)}.
$$
(3.35)

Now, even if their sum belongs to  $L^2(\mathbb{R}^6)$  neither  $w_v$  nor  $\mathcal{G}\xi_v$  does. Still, since

$$
(w_v, H_{\text{free}}w_u)_{L^2_{\text{f}}(\mathbb{R}^6)} = F[w_v, w_u] < \infty,
$$

we must have

$$
\int_{\mathbb{R}^6} \mathrm{d}\mathbf{k}_1 \mathrm{d}\mathbf{k}_2 \frac{\left(\hat{\xi}^*_v(\mathbf{k}_1)-\hat{\xi}^*_v(\mathbf{k}_2)\right)\left(H_{\mathrm{free}} w_u\right)(\mathbf{k}_1,\mathbf{k}_2)}{k_1^2+k_2^2+\frac{2}{m+1}\mathbf{k}_1\cdot\mathbf{k}_2} <+\infty.
$$

On the other hand  $H_{\text{free}}w_u \in L^2(\mathbb{R}^6)$  for any  $w_u$  and therefore  $\mathcal{G}\xi_v \in L^2(\mathbb{R}^6)$ . Hence we can write

$$
(w_v + \mathcal{G}\xi_v, H_{\text{free}}w_u)_{L^2_f(\mathbb{R}^6)} = (w_v, H_{\text{free}}w_u)_{L^2_f(\mathbb{R}^6)} + (\mathcal{G}\xi_v, H_{\text{free}}w_u)_{L^2_f(\mathbb{R}^6)}.
$$

Since both terms on the r.h.s. are separately finite, we arrive at

$$
2\Phi_0[\xi_v,\xi_u] = (\mathcal{G}\xi_v,H_{\text{free}}w_u)_{L^2_{\text{f}}(\mathbb{R}^6)}
$$

The previous equation can be rewritten as:

<span id="page-15-0"></span>
$$
\Phi_0[\xi_v, \xi_u] = \left(\xi_v, w_u|_{\mathbf{y}_2 = 0}\right)_{L^2(\mathbb{R}^3)}.
$$
\n(3.36)

the r.h.s. of [\(3.36\)](#page-15-0) is finite under our hypothesis. This statement will be proved in [\(3.48\)](#page-17-0) contained in Lemma [3.1.](#page-17-1)

Before going on we have to discuss the regularity of  $\xi_u$  according to  $q_u$ . If  $q_u = 0$ , then  $\eta_u = \xi_u$ and  $\xi_u \in H^{1/2}(\mathbb{R}^3)$ . Since  $\Phi_0$  is closed and positive, identity [\(3.36\)](#page-15-0) together with [\(3.48\)](#page-17-0) imply that  $\xi_u \in \mathscr{D}_0$  and

$$
\Phi_0[\xi_v, \xi_u] = (\xi_v, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)},
$$

where with a small abuse of notation we have denoted the restriction of  $\Gamma_0$  to  $\mathscr{H}_{1,n}$  by the same symbol, so that we obtain the boundary condition

<span id="page-15-1"></span>
$$
w_u(\mathbf{y},0) = (\Gamma_0 \xi_u)(\mathbf{y}). \tag{3.37}
$$

We remark that this boundary condition implies more regularity on  $\xi_u$  than the one assumed a priori in the domain definition [\(2.11\)](#page-6-1): next Lemma [3.1](#page-17-1) shows that a consequence of [\(3.37\)](#page-15-1) is

<span id="page-15-2"></span>
$$
\Gamma_0 \xi_u \in H^{1/2}(\mathbb{R}^3). \tag{3.38}
$$

On the opposite if  $q_u \neq 0$ , we should distinguish two cases according to s.

- If  $1/2 < s(m) < 1$  then the same argument as before applies since by definition  $\xi_u \in$  $H^{1/2}(\mathbb{R}^3);$
- If  $0 \lt s(m) \lt 1/2$  we can decompose

$$
\xi_u = \xi_{<} - \Xi_{<} ,\tag{3.39}
$$

where  $\xi_{\leq} \in H^{1/2}(\mathbb{R}^3)$  and  $\Xi_{\leq} \in \dot{H}^{1/2}(\mathbb{R}^3)$  are given by (recall the notation [\(3.10\)](#page-11-2))

<span id="page-15-3"></span>
$$
\hat{\xi}_{<} := \hat{\xi}_u + q_u \mathbb{1}_{\{k \le \varepsilon\}} \widehat{\Xi}^-(\mathbf{k}),\tag{3.40}
$$

and

<span id="page-15-4"></span>
$$
\widehat{\Xi}_{<}(\mathbf{k}) := q_u \mathbb{1}_{\{k \le \varepsilon\}} \widehat{\Xi}^{-}(\mathbf{k}).\tag{3.41}
$$

Then the condition [\(3.36\)](#page-15-0) becomes

$$
\Phi_0[\xi_v, \xi_{<}] = \left(\xi_v, w_u|_{\mathbf{y}_2=0}\right)_{L^2(\mathbb{R}^3)} + \Phi_0[\xi_v, \Xi_{<}],
$$

where all the three terms are separately finite. Now we notice that although  $\Xi_{\leq \epsilon} \notin L^2(\mathbb{R}^3)$ we have  $\Gamma_0 \Xi_< \in L^2(\mathbb{R}^3)$  where  $\Gamma_0$  stands now for the formal action of the integral operator [\(2.12\)](#page-7-0) due to the cut-off we have introduced.

$$
\Phi_0[\xi_v, \Xi_<] = (\xi_v, \Gamma_0 \Xi_<)_{L^2(\mathbb{R}^3)},
$$

and we obtain

$$
\Phi_0[\xi_v, \xi_{<}] = \left(\xi_v, w_u|_{\mathbf{y}_2=0} + \Gamma_0 \Xi_{<} \right)_{L^2(\mathbb{R}^3)}.
$$
\n(3.42)

Since  $w_u|_{\mathbf{y}_2=0} + \Gamma_0 \Xi_< \in L^2(\mathbb{R}^3)$  by [\(3.48\)](#page-17-0), this implies that  $\xi_<$  must belong to  $\mathscr{D}_0$  and the boundary condition [\(3.37\)](#page-15-1) is satisfied as well. Notice however that since in this case  $\xi_u \notin L^2(\mathbb{R}^3)$  the expression  $\Gamma_0 \xi_u$  should be meant as the formal action of the operator, i.e., [\(2.12\)](#page-7-0).

(c) To complete the derivation of  $\mathscr{D}$ , it remains to verify what is the condition implied by a more generic v, decomposing as  $v = w_v + \mathcal{G}(\xi_v + q_v \Xi_n^-)$ : in this case we get

$$
\mathcal{F}_{0,\beta}^{(n)}[v,u] = F[w_v, w_u] + 2\Phi_0[\xi_v, \xi_u] + \beta q_v^* q_u = (v, \psi)_{L^2_{\text{f}}(\mathbb{R}^6)}
$$
  
=  $(w_v, H_{\text{free}}w_u)_{L^2_{\text{f}}(\mathbb{R}^6)} + (\mathcal{G}(\xi_v + q_v \Xi_n^{-}), H_{\text{free}}w_u)_{L^2_{\text{f}}(\mathbb{R}^6)}.$  (3.43)

After a cancellation, using [\(3.37\)](#page-15-1) we arrive at

<span id="page-16-0"></span>
$$
2\Phi_0[\xi_v, \xi_u] + \beta q_v^* q_u = 2(\xi_v + q_v \Xi_n^-, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)}.
$$
\n(3.44)

Now we would like to decompose the scalar product into the sum of two scalar products in order to exploit the cancellation with the term  $2\Phi_0$  on the l.h.s., but in order to do that we have to make a distinction according to the value of  $s(m)$ :

• If  $1/2 < s(m) < 1$  since  $\xi_v \in H^{1/2}(\mathbb{R}^3)$  we can break the scalar product obtaining

$$
\beta q_u = 2\left(\Xi_n^-, \Gamma_0 \xi_u\right)_{L^2(\mathbb{R}^3)},\tag{3.45}
$$

i.e.,

$$
\lim_{\varepsilon \to 0} \left( \Xi_n^-, \Gamma_0 \xi_u \right)_{L^2(\mathbb{R}^3_\varepsilon)} = \left( \Xi_n^-, \Gamma_0 \xi_u \right)_{L^2(\mathbb{R}^3)}
$$

by dominated convergence and [\(2.11\)](#page-6-1) is proven.

• If  $0 \lt s(m) \lt 1/2$ , we have to go through a limit procedure: for any  $\varepsilon > 0$ , we have

$$
(\xi_v + q_v \Xi^-, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)} = (\xi_<, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)} + (\Xi_>, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)} = \Phi_0[\xi_<, \xi_u] + (\Xi_>, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)},
$$

where

$$
\Xi_{>} := \Xi_n^- - \Xi_{<} \tag{3.46}
$$

The l.h.s. is finite therefore in order to prove that this decomposition is meaningful it is sufficient to prove that  $(\Xi_{\gt}, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)}$  is finite. By [\(3.38\)](#page-15-2), we have

$$
\left| (\Xi_{>}, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3)} \right| \leq ||\Xi_{>}||_{H^{-1/2}(\mathbb{R}^3)} \, ||\Gamma_0 \xi_u||_{H^{1/2}(\mathbb{R}^3)} \leq c \, ||\Gamma_0 \xi_u||_{H^{1/2}(\mathbb{R}^3)} \left( \int_{\varepsilon}^{\infty} dk \, k^{-3+2s(m)} \right)^{1/2} < \infty.
$$

Due to the definition of  $\Xi$  in [\(3.44\)](#page-16-0), we get

$$
\beta q_v^* q_u = 2\Phi_0[\Xi_<, \xi_u] + 2q_v^* \left(\tilde{\xi}^-, \Gamma_0 \xi_u\right)_{L^2(\mathbb{R}^3_\varepsilon)}.
$$
\n(3.47)

Notice that as  $\varepsilon \to 0$  the first term on the r.h.s. vanishes:

$$
|\Phi_0[\Xi_<,\xi_u]| \le C \, \|\xi_u\|_{\dot{H}^{1/2}(\mathbb{R}^3)} \int_0^\varepsilon dk \, k^{-1+2s(m)} \le C\varepsilon^{2s(m)} \xrightarrow[\varepsilon \to 0]{} 0,
$$

since  $\xi_u \in \dot{H}^{1/2}(\mathbb{R}^3)$  by hypothesis and  $(2.11)$  is proven.



<span id="page-17-1"></span>Lemma 3.1. Let  $u \in \mathscr{D}\left(H_{0,\beta}^{(n)}\right)$  and  $w_u$  be its regular part of u, then

<span id="page-17-0"></span>
$$
w_u(\mathbf{y}, 0) \in H^{1/2}(\mathbb{R}^3). \tag{3.48}
$$

*Proof.* We first note that  $u \in \mathscr{D}\left(H_{0,\beta}^{(n)}\right)$  implies the decomposition  $u = w_u + \mathcal{G}\eta$  with  $w_u \in \dot{H}_{f}^{2}(\mathbb{R}^6)$ . However by decomposing  $\mathcal{G}\eta$  into high and low frequency contributions one immediately obtains that  $w_u + \mathcal{G}_{\leq \eta} \in L^2_f(\mathbb{R}^6)$ , and therefore also  $w_u + \mathcal{G}_{\leq \eta} \in H^2_f(\mathbb{R}^6)$  holds, where  $\mathcal{G}_{\leq \eta}$  stands for the potential of the charge  $\eta$  cut for momenta  $k_1^2 + k_2^2 \le \varepsilon^2$ ,  $\varepsilon > 0$ , i.e.,

$$
\widehat{g_{<\eta}}(\mathbf{k}_1, \mathbf{k}_2) := 1\!\!1_{\{k_1^2 + k_2^2 \leq \varepsilon^2\}} \frac{\hat{\eta}(\mathbf{k}_1) - \hat{\eta}(\mathbf{k}_2)}{k_1^2 + k_2^2 + \frac{2}{m+1}\mathbf{k}_1 \cdot \mathbf{k}_2}.
$$

Then by standard Sobolev trace theorems, the trace  $(w_u + \mathcal{G}_{\leq \eta})(y,0)$  belongs to  $H^{1/2}(\mathbb{R}^3)$ . To complete the proof it only remains to show that  $(\mathcal{G}_{\leq \eta})(y, 0)$  belongs to  $H^{1/2}(\mathbb{R}^3)$ . This can be proven by direct inspection thanks to the assumption  $\eta \in L^2(\mathbb{R}^3)$ . In order to show it, we write

$$
g(\mathbf{y}) := (\mathcal{G}_{<} \eta) \left( \mathbf{y}, 0 \right) = \frac{1}{(2\pi)^3} \int_{k_1^2 + k_2^2 \le \varepsilon^2} dk_1 dk_2 \, \frac{e^{i\mathbf{k_1} \mathbf{y}} \left( \hat{\eta}(\mathbf{k}_1) - \hat{\eta}(\mathbf{k}_2) \right)}{k_1^2 + k_2^2 + \frac{2}{m+1} \mathbf{k_1} \cdot \mathbf{k_2}},
$$

and compute

$$
\hat{g}(\mathbf{k}) = \int_{\mathbb{R}^3} d\mathbf{k}_2 \, \frac{\mathbb{1}_{\{k^2 + k_2^2 \le \varepsilon^2\}} (\hat{\eta}(\mathbf{k}) - \hat{\eta}(\mathbf{k}_2))}{k^2 + k_2^2 + \frac{2}{m+1} \mathbf{k} \cdot \mathbf{k}_2},
$$

so that

$$
\begin{split} |\hat{g}(\mathbf{k})| &\leq C \mathbb{1}_{\{k \leq \varepsilon\}} \int_{k_2 \leq \varepsilon} \mathrm{d}\mathbf{k}_2 \, \frac{|\hat{\eta}(\mathbf{k}) - \hat{\eta}(\mathbf{k}_2)|}{k^2 + k_2^2} \\ &\leq C \mathbb{1}_{\{k \leq \varepsilon\}} \bigg[ \left| \hat{\eta}(\mathbf{k}) \right| + \|\eta\|_{H^{-1/2}(\mathbb{R}^3)} \left( \int_0^{\varepsilon} \mathrm{d}k_2 \frac{k_2^2 \sqrt{1 + \varepsilon^2}}{(k^2 + k_2^2)^2} \right)^{1/2} \bigg], \\ &\leq C \mathbb{1}_{\{k \leq \varepsilon\}} \bigg[ |\hat{\eta}(\mathbf{k})| + \|\eta\|_{H^{-1/2}(\mathbb{R}^3)} \, k^{-1} \bigg] \,, \end{split}
$$

which compactly supported and square integrable as  $k \to 0$ , thanks to the hypothesis on  $\eta$ , i.e.,  $\eta \in H^{-1/2}(\mathbb{R}^3)$ , then g is square integrable. Since  $\hat{g}$  is compactly supported then  $g \in H^p(\mathbb{R}^3)$  for  $p \geq 0$  $\Box$ 

We now prove Proposition [2.1](#page-8-0) and, as in the above analysis, we restrict ourselves to the operator  $H_{0,\beta}^{(n)}$ .

*Proof of Proposition [2.1.](#page-8-0)* Let  $u \in \mathscr{D}(H_{0,\beta}^{(n)})$  with  $\xi_u \in C_0^{\infty}(\mathbb{R}^3) \cap \mathscr{H}_{1,n}$ , then we want to show that

$$
H_{0,\beta}^{(n)}u = H_{\text{free}}w_u,
$$
  
\n
$$
w_u(\mathbf{y},0) = (\Gamma_0 \eta_u)(\mathbf{y}),
$$
\n(3.49)

which is equivalent to prove that

$$
q_u = 0.\t\t(3.50)
$$

Notice that we have taken a smooth charge  $\xi_u$  as in the definition of  $H_0$  but a direct inspection of the following argument reveals that it could be applied as well to any  $\xi_u$ , e.g., in  $H^{3/2}(\mathbb{R}^3)$ .

The only non trivial point is the analysis of the second boundary condition, which must result in a trivial identity. Indeed we shall now prove that, for any such  $\xi_u$ , one has

$$
\lim_{\varepsilon \to 0} \left( \Xi_n^-, \Gamma_0 \xi_u \right)_{L^2(\mathbb{R}^3_\varepsilon)} = 0.
$$

The simplest way to prove it is by noting that the order of the integrals in the above expression can be exchanged:

$$
\lim_{\varepsilon \to 0} (\Xi_n^-, \Gamma_0 \xi_u)_{L^2(\mathbb{R}^3_\varepsilon)} = \lim_{\varepsilon \to 0} \int_{\mathbb{R}^3_\varepsilon} d\mathbf{p} \, \Xi_n^-(\mathbf{p}) \Big\{ 2\pi^2 \sqrt{\frac{m(m+2)}{(m+1)^2}} p \, \widehat{\xi}_u(\mathbf{p}) + \int_{\mathbb{R}^3_\varepsilon} d\mathbf{q} \, \frac{\widehat{\xi}_u(\mathbf{q})}{p^2 + q^2 + \frac{2}{m+1} \mathbf{p} \cdot \mathbf{q}} \Big\}
$$
\n
$$
= \lim_{\varepsilon \to 0} \left[ 2\pi^2 \sqrt{\frac{m(m+2)}{(m+1)^2}} \int_{\mathbb{R}^3_\varepsilon} d\mathbf{p} \, p \, \Xi_n^-(\mathbf{p}) \widehat{\xi}_u(\mathbf{p}) + \int_{\mathbb{R}^3_\varepsilon} d\mathbf{p} d\mathbf{q} \, \frac{\Xi_n^-(\mathbf{p}) \widehat{\xi}_u(\mathbf{q})}{p^2 + q^2 + \frac{2}{m+1} \mathbf{p} \cdot \mathbf{q}} \right] = \lim_{\varepsilon \to 0} \left( \Gamma_0 \Xi_n^-, \xi_u \right)_{L^2(\mathbb{R}^3_\varepsilon)} = 0,
$$

where we have exchanged the order of integration thanks to the finiteness of both integrals, as one can easily prove by exploiting the regularity of  $\xi_u$  and Cauchy-Schwarz inequality:

$$
\left| \int_{\mathbb{R}_{\varepsilon}^{3}} d\mathbf{p} \, p \, \Xi_{n}^{-}(\mathbf{p}) \widehat{\xi}_{u}(\mathbf{p}) \right| \leq C \bigg[ \bigg( \int_{\mathbb{R}^{3}} d\mathbf{p} \, p^{3} \left| \widehat{\xi}_{u}(\mathbf{p}) \right|^{2} \bigg)^{1/2} \bigg( \int_{1}^{\infty} d\mathbf{p} \, p^{-3+2s(m)} \bigg)^{1/2} + \bigg( \int_{0}^{1} d\mathbf{p} \, p^{2s(m)} \bigg)^{1/2} \bigg( \int_{p \leq 1} d\mathbf{p} \left| \widehat{\xi}_{u}(\mathbf{p}) \right|^{2} \bigg)^{1/2} \bigg] \leq C \, \|\xi_{u}\|_{H^{1}(\mathbb{R}^{3})},
$$

for any  $0 < s(m) < 1$ . As last thing, we prove that  $\Gamma_0 \Xi_n^- = 0$ . For simplicity from now on we make a little abuse of notation, setting

$$
\Gamma_0 := \Gamma_0|_{\mathcal{H}_{1,n}},\tag{3.51}
$$

<span id="page-18-0"></span> $\Box$ 

and compute

$$
\left(\Gamma_0 \tilde{\xi}^-\right)(p) = 2\pi^2 \sqrt{\frac{m(m+2)}{(m+1)^2}} \frac{1}{p^{1-s}} + 2\pi \int_{-1}^1 dt \, t \int_0^\infty dq \, \frac{q^s}{q^2 + p^2 + \frac{2}{m+1} t p q}
$$

$$
= \frac{2\pi}{p^{1-s}} \left[ \pi \sqrt{\frac{m(m+2)}{(m+1)^2}} + \int_{-1}^1 dt \, t \int_0^\infty dq \, \frac{q^s}{q^2 + 1 + \frac{2}{m+1} t q} \right] = 0, \quad (3.52)
$$

where in the last step we have used the definition of  $s(m)$  (see [\(2.1\)](#page-5-0)).

We conclude the Section with an investigation of the asymptotic behavior of charges in  $\mathscr{D}(H_{0,\beta}^{(n)})$ .

*Proof of Proposition [2.2.](#page-8-1)* Let  $\eta$  be an admissible charge belonging to  $\mathscr{D}(H_{0,\beta}^{(n)})$  and  $\xi$  its regular part, then we can find  $\xi$  of the form

$$
\hat{\xi}_{>}(\mathbf{k}) = \left(\frac{A}{k^{2+s(m)}} 1\!\!1_{\{k \ge R\}} + \chi(k)\right) Y_1^n(\vartheta_k, \varphi_k),\tag{3.53}
$$

with  $\chi \in H^{1/2}(\mathbb{R}^3)$  and

<span id="page-19-0"></span>
$$
|\chi(k)| \le \frac{C}{k^{\gamma}}, \qquad \gamma > 2 + s(m), \tag{3.54}
$$

for  $0 \lt s(m) \lt 1/2$ . The same argument can be repeated when  $1/2 \lt s(m) \lt 1$  taking the whole  $\xi$ as above. For such regular parts the overall charge  $\eta$  is

$$
\hat{\eta}(\mathbf{k}) = \left(\frac{q}{k^{2-s(m)}} + \frac{A}{k^{2+s(m)}} 1\!\!1_{\{k \ge R\}} + \chi(k)\right) Y_1^n(\vartheta_k, \varphi_k) :=
$$
\n
$$
\left(q\tilde{\xi}^-(k) + A\tilde{\xi}^+(k)1\!\!1_{\{k \ge R\}} + \chi(k)\right) Y_1^n(\vartheta_k, \varphi_k) \quad (3.55)
$$

where

<span id="page-19-1"></span>
$$
\tilde{\xi}^+(k) := \frac{1}{k^{2+s(m)}}\tag{3.56}
$$

and the coefficient A must satisfy the second boundary condition, i.e.,

$$
\beta q = \lim_{\varepsilon \to 0} \left( \tilde{\xi}^-, \Gamma_0 \xi \right)_{L^2(\mathbb{R}^3_\varepsilon)} = \lim_{\varepsilon \to 0} \left[ A \left( \tilde{\xi}^-, \Gamma_0 \left( \mathbb{1}_{\{k \ge R\}} \tilde{\xi}^+ \right) \right)_{L^2(\mathbb{R}^3_\varepsilon)} + \left( \tilde{\xi}^-, \Gamma_0 \chi \right)_{L^2(\mathbb{R}^3_\varepsilon)} \right] \n= A \lim_{\varepsilon \to 0} \left( \tilde{\xi}^-, \Gamma_0 \left( \mathbb{1}_{\{k \ge R\}} \tilde{\xi}^+ \right) \right)_{L^2(\mathbb{R}^3_\varepsilon)}.
$$
\n(3.57)

The vanishing of the second term can be proven as in the proof of Proposition [2.1.](#page-8-0) Since the diagonal term in the expression is absolutely convergent

$$
\left| \int_{\mathbb{R}_{\varepsilon}^3} dk \, \frac{1}{k^{1-s(m)}} \chi(k) \right| \le C \int_{\varepsilon}^{\infty} dk \, k^{-\gamma + 1 + s(m)} < +\infty,
$$
\n(3.58)

thanks to [\(3.54\)](#page-19-0), then the order of the integrals in the off-diagonal term can be exchanged and  $\Gamma_0 \tilde{\xi}^- = 0$  appears.

Then it remains to compute the integral in [\(3.57\)](#page-19-1). Using [\(2.1\)](#page-5-0) which provides cancellations and scale invariance w.r.t.  $R$ , we have

$$
\lim_{\varepsilon \to 0} \left( \tilde{\xi}^-, \Gamma_0 \left( 1\!\!1_{\{k \ge R\}} \tilde{\xi}^+ \right) \right)_{L^2(\mathbb{R}^3_\varepsilon)} = \int_R^\infty dp \, \frac{1}{p} \left[ 2\pi^2 \sqrt{\frac{m(m+2)}{(m+1)^2}} + 2\pi \int_{-1}^1 dt \, t \int_{R/p}^\infty dq \, \frac{q^{-s(m)}}{q^2 + 1 + \frac{2}{m+1}qt} \right]
$$
\n
$$
= -2\pi \int_1^\infty dp \, \frac{1}{p} \int_{-1}^1 dt \, t \int_0^{1/p} dq \, \frac{q^{-s(m)}}{q^2 + 1 + \frac{2}{m+1}qt} = \nu(m). \quad (3.59)
$$

In order to see that  $\nu(m)$  is finite it suffices to estimate the large p asymptotics of the last integral, which behaves like  $p^{-1+s(m)}$ , so that the integrand goes asymptotically as  $p^{-2+s(m)}$ , which is integrable. Moreover splitting the integral over  $t$  one gets

$$
\nu(m) = \frac{8\pi}{m+1} \int_1^{\infty} dp \, \frac{1}{p} \int_0^1 dt \, t^2 \int_0^{1/p} dq \frac{q^{1-s(m)}}{(q^2+1)^2 - \frac{4}{(m+1)^2}q^2},\tag{3.60}
$$

which shows that  $\nu(m) > 0$ .

Then going back to [\(3.57\)](#page-19-1)

$$
A = \frac{\beta q}{\nu(m)},\tag{3.61}
$$

and asymptotically

$$
\eta_1(k) \propto \frac{q}{k^{2-s(m)}} + \frac{\beta q}{\nu(m)} \frac{1}{k^{2+s(m)}} + o(k^{-2-s(m)}).
$$
\n(3.62)

 $\Box$ 

# <span id="page-20-0"></span>A Critical Masses

In this Appendix we study equation [\(2.1\)](#page-5-0) and we prove that the critical masses  $m^*$ ,  $m^{**}$ , are well defined and  $m^*$  <  $m^{**}$ . Some of these properties were proved in [\[CDFMT\]](#page-29-5) and [\[FT\]](#page-29-8) in a lesser generality but we prefer to give the analysis here for sake of completeness.

Let us denote by  $F_{\ell}(m, s) : [0, +\infty) \times [0, 1] \to \mathbb{R}$  the following function:

$$
F_{\ell}(m, s) := \pi \sqrt{\frac{m(m+2)}{(m+1)^2}} + \int_{-1}^{1} dt \, P_{\ell}(t) \int_{0}^{\infty} dp \, \frac{p^s}{p^2 + 1 + \frac{2}{m+1}tp} =: F_{\ell,1}(m) + F_{\ell,2}(m, s). \tag{A.1}
$$

<span id="page-20-1"></span>**Lemma A.1** (Properties of  $F_\ell$ ).

For odd  $\ell$  the function  $F_{\ell}$  enjoys the following properties:

a)  $F_{\ell}$  is continuous and bounded;

b) for fixed s,  $F_{\ell}(\cdot, s)$  is an increasing function; moreover  $F_{\ell}(0, s) < 0$  and  $\lim_{m \to \infty} F_{\ell}(m, s) = 2\pi^2$ ;

- c) for fixed m,  $F_{\ell}(m, \cdot)$  is a decreasing function;
- d) for fixed  $(m, s)$ , we have  $F_\ell(m, s) < F_{\ell+2}(m, s)$ .

Proof. Continuity in the interior of the domain of definition follows from the integrability of the integrand. Some remarks are in order when  $s \to 1$  or  $m \to 0$ . Using the parity of Legendre polynomials we can cast  $F_{\ell}$  in the following form:

$$
F_{\ell}(m, s) = \pi \sqrt{\frac{m(m+2)}{(m+1)^2}} + \int_0^1 dt \, P_{\ell}(t) \int_0^{\infty} dp \, p^s \left( \frac{1}{p^2 + 1 + \frac{2}{m+1}tp} - \frac{1}{p^2 + 1 - \frac{2}{m+1}tp} \right)
$$
  
=  $\pi \sqrt{\frac{m(m+2)}{(m+1)^2}} - \frac{4}{m+1} \int_0^1 dt \, t \, P_{\ell}(t) \int_0^{\infty} dp \, \frac{p^{s+1}}{(p^2 + 1 + \frac{2}{m+1}tp)(p^2 + 1 - \frac{2}{m+1}tp)},$  (A.2)

and we see that the limit  $s \to 1$  is harmless by dominated convergence. When  $m \to 0$  a summable singularity appears in the integral with respect to t, that is as  $t \to -1$  we have

$$
\int_0^\infty \mathrm{d}p \, \frac{p^s}{p^2 + 1 + 2tp} \sim \frac{1}{\sqrt{t+1}}.
$$

Due to the integrability of the singularity,  $F_{\ell}$  is finite and continuous by dominated convergence and property a) is proved.

In order to prove b), it is convenient to use a series representation of  $F_{\ell}$ , that is:

$$
F_{\ell}(m, s) = \pi \sqrt{1 - \frac{1}{(m+1)^2}} + \int_{-1}^{1} dt \, P_{\ell}(t) \int_{0}^{\infty} dp \, \frac{p^s}{p^2 + 1} \sum_{k=0}^{\infty} \left( -\frac{2}{m+1} \frac{tp}{p^2 + 1} \right)^k
$$
  
=  $\pi \sqrt{1 - \frac{1}{(m+1)^2}} + \sum_{k=0}^{\infty} \left( \frac{-2}{m+1} \right)^k \int_{-1}^{1} dt \, t^k \, P_{\ell}(t) \int_{0}^{\infty} dp \, \frac{p^{s+k}}{(p^2 + 1)^{k+1}}.$ 

Notice that for even  $k$ 

$$
\int_{-1}^1 \mathrm{d}t \, t^k \, P_\ell(t) = 0
$$

and therefore only the odd terms actually appear in the series. In facts, we have

F_{\ell}(m, s) = \pi \sqrt{1 - \frac{1}{(m+1)^2}} - \sum_{n=0}^{\infty} \left(\frac{2}{m+1}\right)^{2n+1} \int_{-1}^{1} dt \, t^{2n+1} P_{\ell}(t) \int_{0}^{\infty} dp \, \frac{p^{s+2n+1}}{(p^2+1)^{2n+2}}.
$$
 (A.3)

Moreover, using the definition of Legendre polynomial

$$
P_{\ell}(t) = \frac{1}{2^{\ell} \ell!} \frac{d^{l}}{dt^{l}} (t^{2} - 1)^{\ell},
$$

and integrating by parts, we have

$$
\int_{-1}^{1} dt \, t^{2n+1} \, P_{\ell}(t) = \begin{cases} 0, & \text{if } 2n+1 < \ell, \\ \frac{1}{2^l} \binom{2n+1}{\ell} \int_{-1}^{1} dt \, t^{2n+1-\ell} \, (1-t^2)^{\ell}, & \text{if } 2n+1 \geq \ell. \end{cases}
$$

With the change of index  $2n + 1 - \ell = 2k$  in the series, [\(A.3\)](#page-21-0) becomes

$$
F_{\ell}(m, s) = \pi \sqrt{1 - \frac{1}{(m+1)^2}} + \frac{1}{2^{\ell}} \sum_{k=0}^{\infty} \left(\frac{2}{m+1}\right)^{2k+\ell} \binom{2k+\ell}{\ell} \int_{-1}^{1} dt \ (1-t^2)^{\ell} t^{2k} \int_{0}^{\infty} dp \ \frac{p^{s+2k+\ell}}{(p^2+1)^{2k+\ell+1}}. \tag{A.4}
$$

Since in [\(A.4\)](#page-21-1) it appears, up to a global sign, an absolutely convergent, positive term series of monotone functions, then  $F_{\ell,2}$  is negative and increasing. Since  $F_{\ell,1}$  is increasing the also  $F_{\ell}$  is an increasing function of m for fixed s. Clearly  $F_{\ell,1}(0) =$  and  $F_{\ell,2}(0,s) < 0$  due to the above representation. Notice that the finiteness of the series is not obvious but we know that this is the case due to the integral representation and the above remarks. Concerning the behavior at infinity, by representation [\(A.2\)](#page-20-2) we have

$$
F_{\ell,2}(m,s) = -\frac{4}{m+1} \int_0^1 dt \, t \, P_{\ell}(t) \int_0^{\infty} dp \, \frac{p^{s+1}}{(p^2+1+\frac{2}{m+1}tp)(p^2+1-\frac{2}{m+1}tp)}
$$

Since

$$
\frac{1}{p^2+1-\frac{2}{m+1}p}\leq \frac{m+1}{m}\frac{1}{p^2+1},
$$

we have

$$
|F_{\ell,2}(m,s)| \le \frac{4}{m+1} \left| \int_0^1 \mathrm{d}t \, t \, P_{\ell}(t) \right| \int_0^{\infty} \mathrm{d}p \, \frac{p^{s+1}}{(p^2+1)(p^2+1-\frac{2}{m+1}p)} \le \frac{4}{m} \left| \int_0^1 \mathrm{d}t \, t \, P_{\ell}(t) \right| \int_0^{\infty} \mathrm{d}p \, \frac{p^{s+1}}{(p^2+1)^2},
$$

then

$$
\lim_{m\to\infty}F_{\ell,2}(m,s)=0
$$

and b) is proved. In order to prove property c), it is sufficient to prove that each term of the representation of  $F_{\ell,2}$  by series in [\(A.4\)](#page-21-1) is a monotone function of s due to the positivity of coefficients. This is straightforward since

$$
\int_0^\infty dp \, \frac{p^{s+2k+\ell}}{(p^2+1)^{2k+\ell+1}} = \int_{\mathbb{R}} dx \, \frac{e^{(2k+\ell+1)x}}{(e^{2x}+1)^{2k+\ell+1}} e^{sx} = \int_{\mathbb{R}} dx \, \frac{e^{sx}}{(2\cosh x)^{2k+\ell+1}}
$$

$$
= 2 \int_0^\infty dx \, \frac{\sinh(sx)}{(2\cosh x)^{2k+\ell+1}}
$$

and c) follows from the monotonicity of sinh. Last we prove d). Since only  $F_{\ell,2}$  actually depends on  $\ell$ , we have to prove  $F_{\ell,2}(m,\cdot,s) < F_{\ell+2,2}(m,\cdot,s)$ . We rewrite  $F_{\ell,2}(m,\cdot,s)$  extracting the first term of the series.

$$
F_{\ell,2}(m,\cdot,s) = -\frac{1}{2^{\ell}} \left(\frac{2}{m+1}\right)^{\ell} \int_{-1}^{1} dt \ (1-t^2)^{\ell} \int_{0}^{\infty} dp \ \frac{p^{s+\ell}}{(p^2+1)^{\ell+1}} - \frac{1}{2^{\ell}} \sum_{k=0}^{\infty} \left(\frac{2}{m+1}\right)^{2k+2+\ell} \left(\frac{2k+2+\ell}{\ell}\right) \int_{-1}^{1} dt \ (1-t^2)^{\ell} t^{2k+2} \int_{0}^{\infty} dp \ \frac{p^{s+2k+2+\ell}}{(p^2+1)^{2k+2+\ell+1}}. \tag{A.5}
$$

This has to be compared with:

$$
F_{\ell+2,2}(m,\cdot,s) = -\frac{1}{2^{\ell+2}} \sum_{k=0}^{\infty} \left(\frac{2}{m+1}\right)^{2k+2+\ell} {2k+2+\ell \choose \ell+2} \times \int_{-1}^{1} dt \ (1-t^2)^{\ell+2} t^{2k} \int_{0}^{\infty} dp \ \frac{p^{s+2k+2+\ell}}{(p^2+1)^{2k+2+\ell+1}}.\tag{A.6}
$$

A comparison between  $(A.5)$  and  $(A.6)$  shows that d) holds true if

 (A.7)

We rewrite the l.h.s. of [\(A.7\)](#page-22-2) integrating by parts twice

$$
\frac{(2k+2)(2k+1)}{4} \int_{-1}^{1} dt \ (1-t^2)^{\ell+2} t^{2k} = \frac{1}{4} \int_{-1}^{1} dt \ (1-t^2)^{\ell+2} \frac{d^2 t^{2k+2}}{dt^2}
$$

$$
= \frac{1}{4} \int_{-1}^{1} dt \ \frac{d^2}{dt^2} (1-t^2)^{\ell+2} t^{2k+2}
$$

$$
= (\ell+2)(\ell+1) \int_{-1}^{1} dt \ (1-t^2)^{\ell} t^{2k+4} - \frac{\ell+2}{2} \int_{-1}^{1} dt \ (1-t^2)^{\ell+1} t^{2k+2}
$$

$$
< (\ell+2)(\ell+1) \int_{-1}^{1} dt \ (1-t^2)^{\ell} t^{2k+2} - \frac{\ell+2}{2} \int_{-1}^{1} dt \ (1-t^2)^{\ell+1} t^{2k+2},
$$

and d) is proved.

## <span id="page-23-0"></span>Proposition A.2 (Critical masses).

Moreover it is monotone increasing in s by c). Notice also that the functions  $m_{\ell}(s)$  are decreasing in  $\ell$  due to d). We set  $m(s) := m_1(s)$  and

m^* := m(0), \qquad m^{**} := m(1)
$$

and  $m^* < m^{**}$  follows from the monotonicity of  $m(s)$ .

Notice that if  $\ell$  is even then  $F_{\ell,2} > 0$  and  $(A.8)$  has no solutions. Furthermore one could try repeating the arguments in this paper for  $\ell > 1$ , introducing  $s_{\ell}(m)$  as the inverse of and  $m_{\ell}(s)$  and

which are the cornerstones of our construction. The proofs would work without modifications and we could construct extension of the STM operators with singular charge asymptotic for several  $\ell$ . In order to be able to do so, it is necessary that the intervals  $[m_\ell^{\star}, m_\ell^{\star\star}]$  overlap for different  $\ell$ , where we have put

A numerical analysis shows that

$$
m_3^{\star\star} = 0.0142.

Since  $m_3^{\star\star} < m^{\star}$  no overlap is possible due to monotonicity properties already proved.

In this Appendix we investigate the conditions to impose on the charge  $\eta$  so that it belongs to  $\mathscr{D}[\mathcal{F}_{0,\beta}]$ . It is clear that in order for the decomposition [\(2.5\)](#page-5-2) to make sense and to fulfill the request  $u \in L^2_f(\mathbb{R}^6)$ , it must be

$$
\mathcal{G}\eta \in L^2_{\text{loc}}(\mathbb{R}^6),\tag{B.1}
$$

where we have removed the fermionic restriction since it is satisfied by construction. In next Lemma we are going to show that this is equivalent to assume that

The r.h.s. of the above expression is bounded by

$$
4\int_{\mathbb{R}^{6}} d\mathbf{k}_{1} d\mathbf{k}_{2} \, \mathbb{1}_{\{k_{2}\geq\varepsilon\}} \frac{|\eta(\mathbf{k}_{1})|^{2}}{(k_{1}^{2} + k_{2}^{2} + \frac{2}{m+1}\mathbf{k}_{1} \cdot \mathbf{k}_{2})^{2}} \leq 4\int_{\mathbb{R}^{6}} d\mathbf{k}_{1} d\mathbf{k}_{2} \, \mathbb{1}_{\{k_{1}\geq\varepsilon\}} \mathbb{1}_{\{k_{2}\geq\varepsilon\}} \frac{|\eta(\mathbf{k}_{1})|^{2}}{(k_{1}^{2} + k_{2}^{2} - \frac{2}{m+1}k_{1}k_{2})^{2}} \leq 4\int_{\mathbb{R}^{3}} d\mathbf{q} \frac{1}{(1 + q^{2} - \frac{2}{m+1}q)^{2}} \int_{\mathbb{R}^{3}} d\mathbf{k}_{1} \, \mathbb{1}_{\{k_{1}\geq\varepsilon\}} k_{1}^{-1} |\eta(\mathbf{k}_{1})|^{2}, \quad (B.6)

$$
\le 2 \|K\| \int_{\mathbb{R}^3} dk_1 \, \mathbb{1}_{\{k_1 \ge \varepsilon\}} k_1^{-1} |\eta(\mathbf{k}_1)|^2 \quad (B.10)

The condition [\(B.2\)](#page-24-3) does not give any information on the integrability of  $\hat{\eta}$  close to the origin. It is therefore more convenient to exploit an equivalent but slightly different decomposition of functions in  $\mathscr{D}[\mathcal{F}_{0,\beta}]$ , where the potential  $\mathcal G$  is replaced by  $\mathcal{G}_{\lambda}, \lambda > 0$ , defined as follows

$$
\left(\widehat{\mathcal{G}_{\lambda}\eta}\right)(\mathbf{k}_1,\mathbf{k}_2) = \frac{\hat{\eta}(\mathbf{k}_1) - \hat{\eta}(\mathbf{k}_2)}{k_1^2 + k_2^2 + \frac{2}{m+1}\mathbf{k}_1 \cdot \mathbf{k}_2 + \lambda}.
$$
\n(B.16)

More precisely, any  $u \in \mathscr{D}[\mathcal{F}_{0,\beta}]$  is decomposed as  $u = w_{\lambda} + \mathcal{G}_{\lambda}\eta$ , with  $w_{\lambda} \in H_{f}^{1}(\mathbb{R}^{6})$ . Since  $u \in L_{f}^{2}(\mathbb{R}^{6})$ , one has simply to require that

$$
\mathcal{G}_{\lambda}\eta \in L^2_{\text{f}}(\mathbb{R}^6)
$$
 (B.17)

for any  $\eta$  admissible, i.e., belonging to  $\mathscr{D}[\mathcal{F}_{0,\beta}]$ . Next Lemma [B.2](#page-26-0) shows that this is equivalent to the requirement

$$
\eta \in H^{-1/2}(\mathbb{R}^3),\tag{B.18}
$$

which has to be satisfied by any charge in [\(2.5\)](#page-5-2).

## <span id="page-26-0"></span>Lemma B.2.

For any  $\lambda > 0$ , there exist two constants  $0 < c_1, c_2 < \infty$  independent of  $\lambda$ , such that

$$
c_1 \|\eta\|_{H_{\lambda}^{-1/2}(\mathbb{R}^3)}^2 \le \|\mathcal{G}_{\lambda}\eta\|_{L^2(\mathbb{R}^6)}^2 \le c_2 \|\eta\|_{H_{\lambda}^{-1/2}(\mathbb{R}^3)}^2
$$
\n(B.19)

where

$$
\|\eta\|_{H_{\lambda}^{-1/2}(\mathbb{R}^3)}^2 = \int_{\mathbb{R}^3} d\mathbf{k} \, \frac{|\hat{\eta}(\mathbf{k})|^2}{\sqrt{k^2 + \lambda}}.
$$

*Proof.* The r.h.s. of the inequality can be proven as in  $[FT, Proposition 6.1]$  via an estimate analogous to [\(B.6\)](#page-24-4).

For the l.h.s. we first bound from below  $\|\mathcal{G}_{\lambda}\eta\|_{L^2(\mathbb{R}^6)}^2$  by cutting the integral domain where  $k_2 \leq a\sqrt{k_1^2 + \lambda}$ , where a is any positive number to be chosen later large enough. Dropping one of the positive term coming from  $|\eta(\mathbf{k}_1) - \eta(\mathbf{k}_2)|^2$ , we get

$$
\|\mathcal{G}_{\lambda}\eta\|_{L^{2}(\mathbb{R}^{6})}^{2} \geq \int_{\mathbb{R}^{6}} d\mathbf{k}_{1} d\mathbf{k}_{2} \, \mathbb{1}_{\left\{k_{2} \geq a\sqrt{k_{1}^{2} + \lambda}\right\}} \frac{|\hat{\eta}(\mathbf{k}_{1})|^{2}}{(k_{1}^{2} + k_{2}^{2} + \frac{2}{m+1}\mathbf{k}_{1} \cdot \mathbf{k}_{2} + \lambda)^{2}} - 2 \int_{\mathbb{R}^{6}} d\mathbf{k}_{1} d\mathbf{k}_{2} \, \mathbb{1}_{\left\{k_{2} \geq a\sqrt{k_{1}^{2} + \lambda}\right\}} \frac{|\hat{\eta}(\mathbf{k}_{1})||\hat{\eta}(\mathbf{k}_{2})|}{(k_{1}^{2} + k_{2}^{2} + \frac{2}{m+1}\mathbf{k}_{1} \cdot \mathbf{k}_{2} + \lambda)^{2}} =: (III) + (IV). \quad (B.20)
$$

The positive term  $(III)$  can be estimated from below as

$$
(III) \geq \int_{\mathbb{R}^3} d\mathbf{k}_1 |\hat{\eta}(\mathbf{k}_1)|^2 \int_{\mathbb{R}^3} d\mathbf{k}_2 \, \mathbb{1}_{\left\{k_2 \geq a\sqrt{k_1^2 + \lambda}\right\}} \frac{1}{(k_1^2 + k_2^2 + \frac{2}{m+1}k_1k_2 + \lambda)^2}
$$
  
=  $4\pi \int_{\mathbb{R}^3} d\mathbf{k}_1 \, \frac{|\hat{\eta}(\mathbf{k}_1)|^2}{\sqrt{k_1^2 + \lambda}} \int_a^\infty dq \, \frac{q^2}{(1 + q^2 + \frac{2}{m+1} \frac{k_1}{\sqrt{k_1^2 + \lambda}} q)^2} \geq c_0(a) \, \|\eta\|_{H_{\lambda}^{-1/2}(\mathbb{R}^3)}^2 \quad (B.21)$ 

where  $c_0(a)$  has been defined in [\(B.8\)](#page-25-1). For the negative term  $(IV)$  we write

$$
|(IV)| = 2 \int_{\mathbb{R}^3} dk_1 \frac{|\hat{\eta}(\mathbf{k}_1)|^2}{(k_1^2 + \lambda)^{1/4}} \int_{\mathbb{R}^3} dk_2 \frac{|\hat{\eta}(\mathbf{k}_2)|^2}{(k_2^2 + \lambda)^{1/4}} K_\lambda(\mathbf{k}_1, \mathbf{k}_2) \leq 2 \|K_\lambda\| \|\eta\|_{H_\lambda^{-1/2}(\mathbb{R}^3)}^2 \quad (B.22)
$$

where  $K_{\lambda}$  is the integral operator in  $L^2(\mathbb{R}^3)$  with kernel

$$
K_{\lambda}(\mathbf{k}_1, \mathbf{k}_2) = \mathbb{1}_{\left\{k_2 \ge a\sqrt{k_1^2 + \lambda}\right\}} \frac{(k_1^2 + \lambda)^{1/4} (k_2^2 + \lambda)^{1/4}}{(k_1^2 + k_2^2 + \frac{2}{m+1} \mathbf{k}_1 \cdot \mathbf{k}_2 + \lambda)^2}.
$$
\n(B.23)

We use again Schur's test to estimate  $||K_\lambda||$ .

$$
\int_{\mathbb{R}^3} d\mathbf{k}_2 K_{\lambda}(\mathbf{k}_1, \mathbf{k}_2) \le 4\pi (k_1^2 + \lambda)^{1/4} \int_{a\sqrt{k_1^2 + \lambda}}^{\infty} \frac{k_2^2 (k_2^2 + \lambda)^{1/4}}{(k_1^2 + k_2^2 - \frac{2}{m+1}k_1k_2 + \lambda)^2}
$$
  
=  $4\pi \int_a^{\infty} dq \frac{q^2 (q^2 + \lambda(k_1^2 + \lambda)^{-1})^{1/4}}{(1 + q^2 - \frac{2}{m+1}\frac{k_1}{\sqrt{k_1^2 + \lambda}}q)^2} \le 4\pi \int_a^{\infty} dq \frac{q^{5/2} (1 + q^{-2})^{1/4}}{(1 + q^2 - \frac{2}{m+1}q)^2} =: \tilde{c}_1(a),$  (B.24)

where  $a^{1/2}\tilde{c}_1(a) \to \tilde{l}_1$ , with  $0 < \tilde{l}_1 < \infty$ , for  $a \to \infty$ . Moreover

$$
\int_{\mathbb{R}^3} d\mathbf{k}_1 K_{\lambda}(\mathbf{k}_1, \mathbf{k}_2) \le 4\pi (k_2^2 + \lambda)^{1/4} \int_0^{\frac{\sqrt{k_2^2 - \lambda a^2}}{a}} dk_1 \frac{k_1^2 (k_1^2 + \lambda)^{1/4}}{(k_1^2 + k_2^2 - \frac{2}{m+1}k_1k_2 + \lambda)^2} \n= 4\pi \int_0^{q(a)} dq \frac{q^2 (q^2 + \lambda (k_2^2 + \lambda)^{-1})^{1/4}}{(1 + q^2 - \frac{2}{m+1} \sqrt{k_2^2 + \lambda}} q)^2}, \quad (B.25)
$$

where  $q(a) =$  $\sqrt{k_2^2 - \lambda a^2}$  $\frac{\sqrt{\kappa_2^2 - \lambda a^2}}{a\sqrt{\kappa_2^2 + \lambda}} \leq a^{-1}$ . Therefore

$$
\int_{\mathbb{R}^3} d\mathbf{k}_1 \, K_\lambda(\mathbf{k}_1, \mathbf{k}_2) \le 4\pi \int_0^{1/a} dq \, \frac{q^2 (q^2 + 1)^{1/4}}{(1 + q^2 - \frac{2}{m+1}q)^2} =: \tilde{c}_2(a),\tag{B.26}
$$

where  $a^3\tilde{c}_2(a) \rightarrow \tilde{l}_2$ , with  $0 < \tilde{l}_2 < \infty$ , for  $a \rightarrow \infty$ . Hence we obtain the estimate  $||K_\lambda|| \leq \sqrt{\tilde{c}_1(a)\tilde{c}_2(a)}$ . We can now conclude the proof proceeding along the same line of Lemma B.1.  $\tilde{c}_1(a)\,\tilde{c}_2(a)$ . We can now conclude the proof proceeding along the same line of Lemma [B.1.](#page-24-2)

According to the decomposition  $u = w_{\lambda} + \mathcal{G}_{\lambda}\eta$ , with  $w_{\lambda} \in H^1_f(\mathbb{R}^6)$ , for any  $u \in \mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}]$ , and the charge decomposition  $\eta = \xi < +\Xi_{>}$ , with  $\xi < \in H^{1/2}(\mathbb{R}^3)$  and  $\Xi_{>} \in H^{-1/2}(\mathbb{R}^3)$ , introduced in [\(3.40\)](#page-15-3) and [\(3.41\)](#page-15-4), in the following proposition we derive an equivalent expression for our quadratic form.

**Proposition B.1** (Alternative expression of  $\mathcal{F}_{0,\beta}^{(n)}$ ). For any  $\beta$  and  $\lambda > 0$ , the quadratic form [\(3.8\)](#page-11-3), [\(3.9\)](#page-11-3) can be equivalently rewritten as

$$
\mathscr{D}[\mathcal{F}_{0,\beta}^{(n)}] = \left\{ u \in L^2_{\text{f}}(\mathbb{R}^6) \mid u = w_{\lambda} + \mathcal{G}_{\lambda}\eta, w_{\lambda} \in H^1_{\text{f}}(\mathbb{R}^6), \eta \in H^{-1/2}(\mathbb{R}^3), \eta = \xi_{<} + \Xi_{>}, \right\}
$$
\n
$$
\xi_{<} \in H^{1/2}(\mathbb{R}^3) \left\}, \tag{B.27}
$$

$$
\mathcal{F}_{0,\beta}^{(n)}[u] = F_{\lambda}[w_{\lambda}] - \lambda ||u||_{L_{\mathbf{f}}^2(\mathbb{R}^6)}^2 + 2\Phi_{\lambda}[\xi_{<}] + 2\Phi_{0}[\Xi_{<}] - 4\Re\Phi_{0}[\xi_{<},\Xi_{<}] + 2\lambda\Re(\mathcal{G}\Xi_{>},\mathcal{G}_{\lambda}\xi_{<})_{L^2(\mathbb{R}^6)} + \lambda(\mathcal{G}\Xi_{>},\mathcal{G}_{\lambda}\Xi_{>})_{L^2(\mathbb{R}^6)} + \beta |q|^2,
$$
\n(B.28)

where

$$
F_{\lambda}[w] = (w, (H_{\text{free}} + \lambda)w),
$$
\n
$$
\Phi_{\lambda}[\xi] = 2\pi^2 \frac{\sqrt{m(m+2)}}{m+1} \int_{\mathbb{R}^3} d\mathbf{p} \sqrt{p^2 + \lambda} |\hat{\xi}(\mathbf{p})|^2 + \int_{\mathbb{R}^6} d\mathbf{p} d\mathbf{q} \frac{\hat{\xi}^*(\mathbf{p})\hat{\xi}(\mathbf{q})}{p^2 + q^2 + \frac{2}{m+1}\mathbf{p} \cdot \mathbf{q} + \lambda}.
$$
\n(B.29)

and  $\Phi_0[\cdot,\cdot]$  denotes the bilinear form associated to  $\Phi_0[\cdot]$ .

*Proof.* Uniqueness of the decomposition  $u = w_{\lambda} + \mathcal{G}_{\lambda} \eta$  follows from the fact that  $w_{\lambda} \in H^1_f(\mathbb{R}^6)$  while  $\mathcal{G}_{\lambda}\eta \notin H^1_f(\mathbb{R}^6)$ , for any  $\eta$ . Moreover the domain is independent of  $\lambda$  as a consequence of the regularity of  $(\mathcal{G}_{\lambda} - \mathcal{G}_{\mu})\eta$  for any  $\lambda, \mu > 0$ . Indeed, the resolvent identity yields

$$
(\mathcal{G}_{\lambda} - \mathcal{G}_{\mu})\eta = (\mu - \lambda) (H_{\text{free}} + \mu)^{-1} \mathcal{G}_{\lambda}\eta,
$$

which is clearly in the domain of  $H_{\text{free}}$ , i.e.,  $H_{\text{f}}^2(\mathbb{R}^6)$ , any time  $\mathcal{G}_{\lambda}\eta \in L_{\text{f}}^2(\mathbb{R}^6)$ . It remains then to show that the equivalence holds true also for  $\mu = 0$ . In this case it suffices to set

$$
w := w_{\lambda} + (\mathcal{G}_{\lambda} - \mathcal{G}) \eta,
$$
\n(B.31)

which belongs to  $H^1_f(\mathbb{R}^6)$ , if  $w_\lambda \in H^1_f(\mathbb{R}^6)$  and  $\mathcal{G}\eta \in L^2_{loc}(\mathbb{R}^6)$ , and this follows from the condition  $\xi \in \dot{H}^{1/2}(\mathbb{R}^3)$  and a direct inspection of the other term  $\mathcal{G}\Xi^-$ .

The expression of the quadratic form is a direct consequence of the above definition and therefore we give only a sketch of the computation. Writing  $w = w_{\lambda} + (\mathcal{G}_{\lambda} - \mathcal{G})\eta$  and  $\eta = \xi < +\Xi_{>},$  we find

$$
\mathcal{F}_{0,\beta}^{(n)}[u] = (w_{\lambda}, (H_{\text{free}} + \lambda)w_{\lambda})_{L^{2}(\mathbb{R}^{6})} - \lambda \|u\|_{L_{\text{f}}^{2}(\mathbb{R}^{6})}^{2} + \lambda \Big(\mathcal{G}(\xi_{<} + \Xi_{>}), \mathcal{G}_{\lambda}(\xi_{<} + \Xi_{>})\Big)_{L^{2}(\mathbb{R}^{6})} \n+ 2\Phi_{0}[\xi_{<} - \Xi_{>}] + \beta |q|^{2} \n= F_{\lambda}[w_{\lambda}] - \lambda \|u\|_{L_{\text{f}}^{2}(\mathbb{R}^{6})}^{2} + 2\Phi_{0}[\Xi_{<}] - 4\Re\Phi_{0}[\xi_{<}, \Xi_{<}] + 2\lambda\Re\Big(\mathcal{G}\Xi_{>}, \mathcal{G}_{\lambda}\xi_{<}\Big)_{L^{2}(\mathbb{R}^{6})} \n+ \lambda \Big(\mathcal{G}\Xi_{>}, \mathcal{G}_{\lambda}\Xi_{>}\Big)_{L^{2}(\mathbb{R}^{6})} + \beta |q|^{2} + \lambda \Big(\mathcal{G}\xi_{<}, \mathcal{G}_{\lambda}\xi_{<}\Big)_{L^{2}(\mathbb{R}^{6})} + 2\Phi_{0}[\xi_{<}] \quad (B.32)
$$

By an explicit computation we obtain

$$
\lambda \Big(\mathcal{G}\xi_{<} \mathcal{G}\lambda\xi_{<} \Big)_{L^2(\mathbb{R}^6)} + 2\Phi_0[\xi_{<}] = 2\Phi_\lambda[\xi_{<}] \tag{B.33}
$$

and then [\(B.28\)](#page-27-0) is proved. Notice that all the terms of the quadratic form in [\(B.28\)](#page-27-0) are separately finite thanks to the properties of  $\xi_<$ ,  $\Xi_<$  and  $\Xi_>$ . □
