SUSLIN HOMOLOGY OF RELATIVE CURVES WITH MODULUS

KAY RÜLLING AND TAKAO YAMAZAKI

ABSTRACT. We compute the Suslin homology of relative curves with modulus. This result may be regarded as a modulus version of the computation of motives for curves, due to Suslin and Voevodsky.

1. INTRODUCTION

Let B be a variety over a field k. The relative Suslin homology $H_i^S(X/B)$ of a B-scheme X is introduced in [\[SV96,](#page-22-1) §3] and is computed when $X \rightarrow B$ is a relative curve that admits a good compactification([\[SV96,](#page-22-1) Thm. 3.1]; see also [\[Lic93\]](#page-22-2)). This result is later interpreted as a computation of motives of curves in Voevodsky's triangulated category of motives [\[Voe00,](#page-23-0) Thm. 3.4.2].

In the present note we introduce Suslin homology $H_i^S(X/B, D)$ with modulus D (see Def. [3.1\)](#page-7-1). Here B is a smooth k-scheme, $X \to B$ is a proper k-morphism, and D is an effective Cartier divisor on X such that $U := X \setminus |D|$ is smooth and equidimensional over k. When $B = \text{Spec } k$, the definition of $H_i^S(X/B, D)$ is due to S. Saito and is studied in [\[KSYa\]](#page-22-3). There is a canonical homomorphism $H_i^S(X/B,D) \to H_i^S(U/B)$ (see [3.4](#page-8-0) [\(6\)](#page-9-1)), but it is usually far from being bijective. Our main result describes $H_i^S(X/B, D)$ when $X \to B$ is a relative curve (see Remark [4.5\)](#page-11-1):

Theorem 1.1. Let S be a smooth connected k-scheme, C an integral normal kscheme, and $p: \mathcal{C} \to S$ a proper k-morphism. Suppose that the generic fiber of p is

1-dimensional, that $U := \mathcal{C} \setminus |D|$ is smooth over k, that $p|_U : U \to S$ is affine, and that D is contained in an affine open neighborhood in X . Then we have

$$
H_i^S(\mathcal{C}/S,D) = \begin{cases} \text{Pic}(\mathcal{C},D), & \text{if } i = 0, \\ 0, & \text{if } i \ge 1. \end{cases}
$$

Here $Pic(C, D)$ denotes the relative Picard group (see [4.1\)](#page-9-2).

By comparison with [\[SV96\]](#page-22-1), we find that the canonical map $H_i^S(\mathcal{C}/S,D) \to$ $H_i^S(U/S)$ is bijective if D is reduced. Our proof of Theorem [1.1](#page-0-1) is, however, totally different from [\[SV96\]](#page-22-1) (or from [\[Lic93\]](#page-22-2)). Indeed, in loc. cit. the starting point of the proof (for reduced D) is the homotopy invariance of $Pic(\mathcal{C}, D)$, which is no longer valid if D is not reduced. Our proof is rather reminiscent of [\[BS,](#page-22-4) Thm. 4.3].

Actually we shall show a slightly more general result, see Theorem [4.4.](#page-10-0) We expect that our result will be interpreted as a computation of "motives with modulus" for curves, just like the case for "motives without modulus".

Convention 1.2. By convention a k -scheme is a scheme which is separated and of finite type over a field k. We denote by $CDiv(X)$ the group of Cartier divisors on X. If D is an effective Cartier divisor we denote by $|D|$ its support. If X and Y are k-schemes we write $X \times Y = X \times_k Y$.

2. Relative finite correspondences

2.1. We recall a criterion for the pullback of an Cartier divisor to exist. Let X be a k-scheme and D a Cartier divisor on X. Let $f: Y \to X$ be a morphism of k-schemes and assume that $f(Ass(\mathcal{O}_X)) \subset X \setminus [D]$, where $Ass(\mathcal{O}_X)$ denotes the set of associated points of X, (e.g. Y is integral and $f(Y)$ is not contained in $|D|$). Then the pullback f^*D exists as a Cartier divisor. (Indeed, we may assume that D is effective and then it suffices to show that the pullback of a local equation of D to Y is a regular element. This is a local question so let $y \in Y$ be a point, $x = f(y)$ and $d \in \mathcal{O}_{X,x}$ be a local equation of D. By assumption the image of d under $f^* : \mathcal{O}_{X,x} \to \mathcal{O}_{Y,y}$ is not contained in an associated prime of $\mathcal{O}_{Y,y}$, hence is regular, see [\[Mat89,](#page-22-5) 6.].)

The following definition is reminiscent of the modulus condition introduced in [\[BE03\]](#page-22-6) and in its more general form in [\[BS\]](#page-22-4).

Definition 2.2. Let X be a k-scheme and D, E effective Cartier divisors on X. Then we write

$$
D \prec E : \Longleftrightarrow \nu^* D \le \nu^* E,
$$

where $\nu : \tilde{X} \to X$ is the normalization and ν^*D , ν^*E is the pullback of Cartier divisors. (Recall that ν is the composition $\sqcup_i \tilde{X}_i \xrightarrow{\sqcup \nu_i} \sqcup_i X_i \to X_{\text{red}} \xrightarrow{\iota} X$, where ι is the closed immersion of the reduced scheme underlying X, the X_i are the irreducible components (with reduced scheme structure) of X_{red} and $\nu_i : \tilde{X}_i \to X_i$ is the normalization of X_i in its function field.)

Versions of the following proposition can be found e.g. in [\[KP12,](#page-22-7) 2.].

Proposition 2.3. Let X be a k-scheme and D, E effective Cartier divisors on X.

- (1) $D \leq E \Longrightarrow D \prec E$.
- (2) If F is another effective Cartier divisor on X , then

$$
D \prec E \text{ and } E \prec F \Longrightarrow D \prec F.
$$

(3) Let n be a positive integer. Then

$$
nD \prec nE \Longleftrightarrow D \prec E.
$$

(4) Let $f: Y \to X$ be a morphism of k-schemes and assume that $f(\text{Ass}(\mathcal{O}_X)) \subset$ $X \setminus (E \cup D)$. Then the pullbacks f^*D and f^*E exist as effective Cartier divisors (see [2.1\)](#page-1-2) and

$$
D \prec E \Longrightarrow f^*D \prec f^*E.
$$

Furthermore if X is irreducible and $f: Y \rightarrow X$ is proper and surjective then this \leq implication also holds.

(5) Let Z be a normal k-scheme and $g: X \rightarrow Z$ be a finite and surjective kmorphism. Then the pushforwards q_*D and q_*E exist as effective Cartier Divisors and we have

$$
D \prec E \Longrightarrow g_*D \prec g_*E.
$$

Remark 2.4. Warning: $D \prec E$ and $E \prec D$ does not imply $D = E$. If X is reduced, the kernel of $\nu^* : \text{CDiv}(X) \to \text{CDiv}(\tilde{X})$ is given by $H^0(X, \nu_* \mathcal{O}_{\tilde{X}}^{\times}/\mathcal{O}_{X}^{\times})$, see [\[Gro67,](#page-22-8) Prop (21.8.5)].

Proof. Let $X_{\text{red}} = \bigcup_i X_i$ be the decomposition into irreducible components (with reduced scheme structure). Then by definition of the normalization we have $D \prec E$ iff $D_{|X_i} \prec E_{|X_i}$, for all i. Hence we can assume that the schemes X, Y and Z in the statements are integral k-schemes. The statements (1) and (2) are immediate and [\(3\)](#page-2-2) follows from the fact that on a normal scheme the natural map from the group of Cartier divisors to the group of Weil divisors is injective. We prove ' \implies ' of [\(4\)](#page-2-3). The question is local on Y. We may therefore assume that $f: Y \to X$ is induced by a homomorphism between integral k-algebras $\varphi : A \to B$ and $D = \text{div}(d)$, $E = \text{div}(e)$, with $d, e \in A \setminus \{0\}$. Then $D \prec E$ means that the element $e/d \in k(X)^{\times}$ is integral over A, i.e. there exists an $n \geq 1$ and $a_i \in A$ with

$$
(e/d)^n + a_{n-1}(e/d)^{n-1} + \dots + a_0 = 0 \text{ in } k(X)
$$

$$
\iff e^n + a_{n-1}de^{n-1} + \dots + a_0d^n = 0 \text{ in } A.
$$

By assumption $\varphi(e), \varphi(d) \in B \setminus \{0\}$. Applying φ to the equation above yields that $\varphi(e)/\varphi(d) \in k(Y)^{\times}$ is integral over B. Hence $f^*D \prec f^*E$. For the other implication notice that $f: Y \to X$ also induces a proper, and surjective map between the normalizations of X and Y . Therefore we can assume that X and Y are normal and integral. Furthermore the question is local on X . Hence we can assume $X = \text{Spec } A$ is affine and $D = \text{div}(d)$, $E = \text{div}(e)$ as above. Since Y is normal, $f^*D \prec f^*E$ is equivalent to $f^*\mathcal{O}_X(D - E) \subset \mathcal{O}_Y$. Applying $H^0(Y, -)$ we obtain $e/d \in H^0(Y, \mathcal{O}_Y)$. Since f is proper, $H^0(Y, \mathcal{O}_Y)$ is a finite A-module. It follows that e/d is integral over A. The normality of A gives $e/d \in A$, i.e. $D \leq E$.

Finally for [\(5\)](#page-2-4) we first notice that the Cartier divisors g_*D and g_*E exist by [\[Gro67,](#page-22-8) Def (21.5.5)]. If $U \subset Z$ is open and on $g^{-1}(U)$ we have $D = \text{div}(d)$ then

 $g_*D = \text{div}(\text{Nm}(d)),$ where $\text{Nm}_{k(X)/k(Z)} : k(X) \to k(Z)$ is the norm map. It follows from this formula that we have $(g \circ \nu)_* \nu^* D = g_* D$, where $\nu : \tilde{X} \to X$ is the normalization. Since the pushforward $(g \circ \nu)_*$ preserves the ordering on CDiv(X) the statement follows. \Box

Definition 2.5. Let X and Y be k -schemes and D and E effective Cartier divisors on X and Y, respectively. Assume that $U = X \setminus |D|$ and $V = Y \setminus |E|$ are smooth and equidimensional over k. Denote by $Cor(U, V)$ the group of finite correspondences from U to V , i.e. the free abelian group generated on prime correspondences from U to V, i.e integral closed subschemes $S \subset U \times V$ which are finite and surjective over a connected component of U (see e.g. [\[MVW06,](#page-22-9) Def 1.1]). The group of finite correspondences from (X, D) to (Y, E) is by definition the subgroup

$$
Cor((X, D), (Y, E)) \subset Cor(U, V)
$$

generated by those prime correspondences $S \subset U \times V$ which satisfy

$$
(2.5.1) \t\t E_{\overline{S}} \prec D_{\overline{S}},
$$

where $S \subset X \times Y$ is the closure of S and $D_{\overline{S}}$ and $E_{\overline{S}}$ denote the pullback of D and E along the projections $\overline{S} \hookrightarrow X \times Y \to X$ and $\overline{S} \hookrightarrow X \times Y \to Y$, respectively, see [2.1.](#page-1-2)

Remark 2.6. There is a choice in $(2.5.1)$, one could also ask for the other inequality \succ . Our choice is made in such a way that in case X is *smooth* and connected a finite correspondence $\alpha \in \mathrm{Cor}((X,D),(Y,E))$ induces maps

$$
\alpha^*: H^i(Y, \mathcal{O}_Y(E)) \to H^i(X, \mathcal{O}_X(D))
$$

and

$$
\alpha_*: H^i(X, \pi_X^!(k) \otimes_{\mathcal{O}_X} \mathcal{O}_X(-D)) \to H^i(Y, \pi_Y^!(k) \otimes_{\mathcal{O}_Y} \mathcal{O}_Y(-E)),
$$

where $\pi_X : X \to \text{Spec } k$ and $\pi_Y : Y \to \text{Spec } k$ are the structure maps. (Notice that since X is smooth we have $\pi_X^! k = \Omega_X^{\dim X}[\dim X]$.) Indeed if $\alpha = S \subset U \times V$ is a prime correspondence these maps are defined as follows: Let $\overline{S} \subset X \times Y$ be the closure of S and $\nu : \tilde{S} \to \overline{S}$ its normalization. Since the natural map induced by projection $p_X : \tilde{S} \to X$ is surjective and generically finite we have a natural map $c_{p_X}: \mathcal{O}_{\tilde{S}} \to p_X^! \mathcal{O}_X$ at our disposal, see e.g. [\[CR,](#page-22-10) Prop 2.6]; by adjointness we obtain a map $p_{X*}: Rp_{X*}\mathcal{O}_{\tilde{S}} \to \mathcal{O}_X$. Then we define α^* as the composition

$$
H^{i}(Y, \mathcal{O}_{Y}(E)) \xrightarrow{\frac{p_{Y}^{*}}{2}} H^{i}(\tilde{S}, \mathcal{O}_{\tilde{S}}(E_{\tilde{S}}))
$$

$$
\xrightarrow{(2.5.1)} H^{i}(\tilde{S}, \mathcal{O}_{\tilde{S}}(D_{\tilde{S}})) \cong H^{i}(X, (Rp_{X*}\mathcal{O}_{\tilde{S}}) \otimes_{\mathcal{O}_{X}} \mathcal{O}_{X}(D))
$$

$$
\xrightarrow{px_{*}} H^{i}(X, \mathcal{O}_{X}(D)).
$$

Similarly, we define α_* as the composition

$$
H^{i}(X, \pi_{X}^{!}(k) \otimes_{\mathcal{O}_{X}} \mathcal{O}_{X}(-D)) \xrightarrow{\mathrm{id} \to Rp_{X*} Lp_{X}^{*}} H^{i}(\tilde{S}, p_{X}^{*}(\pi_{X}^{!}k) \otimes_{\mathcal{O}_{\tilde{S}}} \mathcal{O}_{\tilde{S}}(-D_{\tilde{S}}))
$$

\n
$$
\xrightarrow{c_{p_{X}}} H^{i}(\tilde{S}, p_{X}^{!}(\mathcal{O}_{X}) \otimes_{\mathcal{O}_{\tilde{S}}} p_{X}^{*}(\pi_{X}^{!}k) \otimes_{\mathcal{O}_{\tilde{S}}} \mathcal{O}_{\tilde{S}}(-D_{\tilde{S}}))
$$

$$
\xrightarrow{(2.5.1)} H^{i}(\tilde{S}, \pi_{\tilde{S}}^{!}(k) \otimes_{\mathcal{O}_{\tilde{S}}} \mathcal{O}_{\tilde{S}}(-D_{\tilde{S}}))
$$

\xrightarrow{(2.5.1)} H^{i}(\tilde{S}, \pi_{\tilde{S}}^{!}(k) \otimes_{\mathcal{O}_{S}} \mathcal{O}_{\tilde{S}}(-E_{\tilde{S}}))

\xrightarrow{H^{i}(Y, Rp_{Y*}p_{Y}^{!}(\pi_{Y}^{!}k) \otimes_{\mathcal{O}_{Y}} \mathcal{O}_{Y}(-E))}

\xrightarrow{Rp_{Y*}p_{Y}^{!} \to \mathrm{id}} H^{i}(Y, \pi_{Y}^{!}(k) \otimes_{\mathcal{O}_{Y}} \mathcal{O}_{Y}(-E)).

Here for the isomorphism in the third row we use $\pi_S^! \cong p_X^! \pi_X^! \cong p_X^! (\mathcal{O}_X) \otimes_{\mathcal{O}_X}^L L p_X^*$. If π_X and π_Y are projective, then α_* and α^* are dual to each other. If we chose in $(2.5.1)$ this '≻' relation, then we have to switch the signs in front of D and E for the maps above.

Definition 2.7. Let B be a k-scheme, X, Y B-schemes and D, E effective Cartier divisors on X, Y, respectively. Assume that $U = X \setminus |D|$, $V = Y \setminus |E|$ are smooth and equidimensional over k . Then we denote by

$$
Cor_B((X, D), (Y, E))
$$

the subgroup of $Cor((X, D), (Y, E))$ which consists of all cycles whose support is contained in the closed subscheme $X \times_B Y \subset X \times Y$.

Proposition 2.8. Let B be a k-scheme, X, Y, Z B-schemes and D, E, F effective Cartier divisors on X, Y, Z, respectively. Assume that $U = X \setminus |D|$, $V = Y \setminus |E|$ and $W = Z \setminus |F|$ are smooth and equidimensional over k and that Y is proper over B. Then the usual composition of finite correspondences $Cor(U, V) \times Cor(V, W) \rightarrow$ $Cor(U, W), (\alpha, \beta) \mapsto \beta \circ \alpha$ (see [\[MVW06,](#page-22-9) 1.]) restricts to a morphism

$$
(2.8.1) \quad \operatorname{Cor}_{B}((X,D),(Y,E)) \times \operatorname{Cor}_{B}((Y,E),(Z,F)) \xrightarrow{\circ} \operatorname{Cor}_{B}((X,D),(Z,F)).
$$

Proof. Let $S \subset U \times_B V$ and $T \subset V \times_B W$ be prime correspondence from (X, D) to (Y, E) and from (Y, E) to (Z, F) , respectively. Let $R \subset S \times_V T$ be an irreducible component and denote by $p : S \times_V T \subset U \times_B V \times_B W \to U \times_B W$ the natural map induced by projection. (It is finite.) Then the prime correspondences appearing in $T \circ S$ are $\{p(R)\}_R$, where R runs through all irreducible components of $S \times_V T$. Hence we have to show that $p(R)$ lies in Cor_B((X, D),(Z, F)). Denote by $\overline{S} \subset$ $X \times_B Y \subset X \times Y$ and $\overline{T} \subset Y \times_B Z \subset Y \times Z$ the closure of S and T, respectively, and by $R \subset S \times_Y T$ the closure of R. By definition we have $E_{\overline{S}} \prec D_{\overline{S}}$ and $F_{\overline{T}} \prec E_{\overline{T}}$. By the first part of [\(4\)](#page-2-3) of Proposition [2.3](#page-2-5) we have

$$
F_{\overline{R}} \prec E_{\overline{R}} \prec D_{\overline{R}}.
$$

Denote by \overline{p} : $\overline{S} \times_Y \overline{T} \subset X \times_B Y \times_B Z \to X \times_B Z$ the natural map induced by projection. Since Y is proper over B so is \overline{p} . Hence $\overline{p}_{|\overline{R}}: R \to p(R)$ is proper, surjective and generically finite. By the second part of [\(4\)](#page-2-3) of Proposition [2.3](#page-2-5) we get

$$
F_{\overline{p(R)}} \prec D_{\overline{p(R)}},
$$

i.e. $p(R) \in \text{Cor}_B((X, D), (Z, F)).$

Corollary 2.9. The composition defined in $(2.8.1)$ is associative in the obvious sense. Furthermore, if X is a B-scheme and D is an effective Cartier divisor on X such that $X \setminus |D|$ is smooth and equidimensional over k, then the graph of the diagonal $\Delta_X \subset X \times_B X$ naturally defines an element in $\text{Cor}_B((X,D), (X,D))$. If X is proper over B, then

$$
Cor_B((X, D), (Y, E)) \xrightarrow{\Delta_X \circ} Cor_B((X, D), (Y, E))
$$

is the identity, where Y is a B-scheme and E is an effective Cartier divisor E on Y such that $Y \setminus |E|$ is smooth and equidimensional over k. If Y is proper over B, then similarly $\circ \Delta_Y$ is the identity.

Proof. This follows immediately from the corresponding properties of the composition for the usual finite correspondences between smooth k-schemes. \Box

Remark 2.10. Let $f: X \to Y$ be an alteration between integral B-schemes and assume that there is an effective Cartier divisor E on Y such that $U := X \setminus |f^*E|$ and $V := Y \setminus E$ are smooth and f restricts to a finite map $f_{|U} : U \to V$. Denote by $\Gamma \subset U \times V$ the graph of $f_{|U}$ and by $\Gamma^t \subset V \times U$ its transpose. Then we have

$$
\Gamma \in \mathrm{Cor}_B((X,D),(Y,E)), \quad \text{for all } D \succ f^*E
$$

and

$$
{}^{t}\Gamma \in \text{Cor}_B((Y, E'), (X, f^*E)), \text{ for all } E' \succ E.
$$

If we take $E' = E$ and $D = f^*E$ we get

$$
{}^{t}\Gamma \circ \Gamma = d \cdot \Delta_X \quad \text{in } \text{Cor}_B((X, f^*E), (X, f^*E)),
$$

where d is the generic degree of f. If f is birational, i.e. $d = 1$ we furthermore get

 $\Gamma \circ {}^t\Gamma = \Delta_Y \text{ in } \text{Cor}_B((Y, E), (Y, E)).$

This all follows immediately from the definitions and the corresponding properties for the usual finite correspondences.

Definition 2.11. Let B be a k-scheme. We define Sm_B^* Cor to be the category with objects the pairs $(X \to B, D)$, where $X \to B$ is a proper k-morphism, D is an effective Cartier divisor on X and $X \setminus |D|$ is smooth and equidimensional over k ; the morphisms are by definition

$$
\mathrm{Hom}_{\mathrm{Sm}_B^*\mathrm{Cor}}((X \to B, D), (Y \to B, E)) := \mathrm{Cor}_B((X, D), (Y, E)).
$$

It follows from Proposition [2.8](#page-4-1) and Corollary [2.9](#page-5-0) that this defines a category. We set $Sm^*Cor := Sm^*_{Spec\,k}Cor$.

For $(X \to B, D), (Y \to B, E) \in \text{Sm}_B^*$ Cor with $X \setminus |D|$ and $Y \setminus |E|$ smooth and equidimensional over B we set

$$
(X,D)\times_B(Y,E)=(X\times_BY,p_X^*D+p_Y^*E),
$$

where $p_X : X \times_B Y \to X$ and $p_Y : X \times_B Y \to Y$ are the projections. It is clear that with this definition the full subcategory of Sm_B^* Cor consisting of those pairs $(X \to B, D)$ with $X \setminus D$ smooth and equidimensional over B has the structure of a symmetric monoidal category with the unit element given by $(B, 0)$. In particular, Sm∗Cor has the structure of a symmetric monoidal category.

2.12. Recall from [\[Lev09,](#page-22-11) 1.1] that Cube is the category with objects given by the sets $\underline{n} := \{0,1\}^n$, $n = 0,1,2,...$, and the morphisms are generated by:

- (1) Inclusions $\eta_{n,i,\epsilon} : \underline{n} \hookrightarrow \underline{n+1}, (\epsilon_1,\ldots,\epsilon_n) \mapsto (\epsilon_1,\ldots,\epsilon_{i-1},\epsilon,\epsilon_i,\ldots,\epsilon_n), n \geq 1$ $0, i \in [0, n+1], \epsilon \in \{0, 1\}.$
- (2) Projections $p_{n,i} : \underline{n} \to \underline{n-1}$, $(\epsilon_1, \ldots, \epsilon_n) \mapsto (\epsilon_1, \ldots, \epsilon_{i-1}, \epsilon_{i+1}, \ldots, \epsilon_n)$, $n \geq$ $1, i \in [1, n]$
- (3) Permutation of factors $\underline{n} \to \underline{n}$, $(\epsilon_1, \ldots, \epsilon_n) \mapsto (\epsilon_{\sigma(1)}, \ldots, \epsilon_{\sigma(n)})$, for σ a permutation of $\{1, 2, \ldots, n\}, n \geq 1$.
- (4) Involutions $\tau_{n,i} : \underline{n} \to \underline{n}$ switching 0 and 1 in the *i*-th spot, $n \geq 1$, $i \in [1, n]$.

The product of sets induces on Cube the structure of a symmetric monoidal category. The category $\bf ECube$ is by definition (see [\[Lev09,](#page-22-11) 1.5]) the smallest symmetric monoidal subcategory of the category of sets which has the same objects as Cube and contains all morphisms in Cube and

$$
\mu: \underline{2} \to \underline{1}, \quad (\epsilon_1, \epsilon_2) \mapsto \begin{cases} 1, & \text{if } (\epsilon_1, \epsilon_2) = (1, 1), \\ 0, & \text{else.} \end{cases}
$$

We set $\Box^1 := \mathbb{P}^1 \setminus \{1\} := \mathbb{P}^1_k \setminus \{1\}$ and $\Box^n := (\Box^1)^{\times n} = (\mathbb{P}^1 \setminus \{1\})^n$. In the following we fix coordinates $(\mathbb{P}^1 \setminus {\{\infty\}})^n = \mathrm{Spec} k[y_1, \ldots, y_n]$. In Sm^* Cor we define

$$
\overline{\square}^1 := (\mathbb{P}^1, \{1\}), \quad \overline{\square}^n := (\overline{\square}^1)^{\times n}
$$

.

Denote by $\square(\eta_{n,i,\epsilon}): \square^n \hookrightarrow \square^{n+1}$ the inclusion given by $y_i = \frac{\epsilon}{\epsilon-1} \in \{0,\infty\}$, for $\epsilon \in \mathbb{R}$ $\{0,1\}$. Denote by $\square(p_{n,i}): \square^n \to \square^{n-1}$ the projection omitting the *i*-th factor and by $\Box(\sigma): \Box^n \to \Box^n$ the permutation of the factors given by $\Box(\sigma)^*(y_i) = y_{\sigma^{-1}(i)}$. Finally denote by $\square(\tau_{n,i}) : \square^n \to \square^n$ the morphism which is the identity on all factors except the *i*-th factor, where it is induced by the unique isomorphism of \mathbb{P}^1 which fixes 1 and switches 0 and ∞ . It is straightforward to check that the graphs of these maps define elements

$$
\overline{\Box}(\eta_{n,i,\epsilon}) \in \mathrm{Cor}(\overline{\Box}^{n}, \overline{\Box}^{n+1}), \quad \overline{\Box}(p_{n,i}) \in \mathrm{Cor}(\overline{\Box}^{n}, \overline{\Box}^{n-1}),
$$

$$
\overline{\Box}(\sigma) \in \mathrm{Cor}(\overline{\Box}^{n}, \overline{\Box}^{n}), \quad \overline{\Box}(\tau_{n,i}) \in \mathrm{Cor}(\overline{\Box}^{n}, \overline{\Box}^{n})
$$

and that we obtain in this way a strict monoidal functor, in particular a co-cubical object,

$$
\overline{\Box} : \mathbf{Cube} \to \mathrm{Sm}^*\mathrm{Cor}, \quad \underline{n} \mapsto \overline{\Box}^n.
$$

Finally using the k-isomorphism $\mathbb{P}^1 \setminus \{1\} \xrightarrow{\simeq} \mathbb{A}^1$, which sends 0 to 0 and ∞ to 1 we define $\square(\mu)$ as the composition

$$
\Box(\mu) : \Box^2 \cong \mathbb{A}^2 \xrightarrow{\text{multiplication}} \mathbb{A}^1 \cong \Box^1.
$$

Let $\overline{\Box}(\mu) \subset (\mathbb{P}^1)^2 \times \mathbb{P}^1$ be the closure of the graph of $\Box(\mu)$. If we write $(\mathbb{P}^1 \setminus {\{\infty\}})^2 \times$ $(\mathbb{P}^1 \setminus {\tilde{\infty}}) = \operatorname{Spec} k[y_1, y_2, z],$ then

 $\overline{\Box}(\mu) \cap (\mathbb{P}^1 \setminus {\{\infty\}})^2 \times (\mathbb{P}^1 \setminus {\{\infty\}}) = \operatorname{Spec} k[y_1, y_2, z]/((z-1)y_1y_2 - (y_1-1)(y_2-1)z).$ Hence if we denote by $p_i : \overline{\Box}(\mu) \to \mathbb{P}^1$, $i = 1, 2, 3$ the three projections we obtain the following inequality of Cartier divisors on the smooth scheme $\overline{\Box}(\mu)$

$$
p_1^*(\{1\}) + p_2^*(\{1\}) =
$$

$$
(\{1\} \times \mathbb{P}^1 \times \{1\}) + (\{1\} \times \{0\} \times \mathbb{P}^1) + (\mathbb{P}^1 \times \{1\} \times \{1\}) + (\{0\} \times \{1\} \times \mathbb{P}^1)
$$

$$
\geq (\{1\} \times \mathbb{P}^1 \times \{1\}) + (\mathbb{P}^1 \times \{1\} \times \{1\}) = p_3^*(\{1\}).
$$

Thus

$$
\overline{\Box}(\mu) \in \mathrm{Cor}(\overline{\Box}^2, \overline{\Box}^1).
$$

It follows that the functor $\overline{\Box}$ extends to a strict monoidal functor

(2.12.1)
$$
\overline{\Box}: \mathbf{ECube} \to \mathrm{Sm}^*\mathrm{Cor}.
$$

2.13. Let S be a smooth equidimensional k -scheme. We set

$$
\overline{\square}_{S} ^n:=\overline{\square} ^n\times S:=\Big((\mathbb{P}^1)^n\times S,\Big(\sum_{i=1}^n(\mathbb{P}^1)^{i-1}\times\{1\}\times(\mathbb{P}^1)^{n-i}\Big)\times S\Big).
$$

This is an object in Sm_S^* Cor, where the structure map $(\mathbb{P}^1)^n \times S \to S$ is given by the projection. If we take the cartesian product of the correspondences $\overline{\Box}(\eta_{n,i,\epsilon})$, $\overline{\Box}(p_{n,i}), \overline{\Box}(\sigma), \overline{\Box}(\tau_{n,i}), \overline{\Box}(\mu)$ in [2.12](#page-5-1) with the diagonal $\Delta_S \subset S \times S$ we obtain correspondences

$$
\overline{\Box}_S(\eta_{n,i,\epsilon}) \in \text{Cor}_S(\overline{\Box}_S^n, \overline{\Box}_S^{n+1}), \quad \overline{\Box}_S(p_{n,i}) \in \text{Cor}_S(\overline{\Box}_S^n, \overline{\Box}_S^{n-1}),
$$

$$
\overline{\Box}_S(\sigma) \in \text{Cor}_S(\overline{\Box}_S^n, \overline{\Box}_S^n), \quad \overline{\Box}_S(\tau_{n,i}) \in \text{Cor}_S(\overline{\Box}_S^n, \overline{\Box}_S^n), \quad \overline{\Box}_S(\mu) \in \text{Cor}_S(\overline{\Box}_S^2, \overline{\Box}_S^1).
$$

This clearly induces a functor

$$
\overline{\Box}_S : \mathbf{ECube} \to \mathrm{Sm}_S^*\mathrm{Cor}.
$$

3. Relative Suslin homology with modulus

The following definition is a modulus version of relative Suslin homology defined in [\[SV00,](#page-23-1) §3].

Definition 3.1. Let S be a smooth equidimensional k-scheme and $(X/S, D) \in$ Sm^{*}_SCor. For $n \geq 0$ set

$$
\tilde{C}_n(X/S, D) := \text{Cor}_S(\overline{\square}_S^n, (X, D)).
$$

By [2.13](#page-7-2) we obtain an extended cubical object in the sense of [\[Lev09,](#page-22-11) 1.5]

$$
\textbf{ECube}^{\text{opp}} \to (\textbf{abelian groups}), \quad \underline{n} \mapsto \tilde{C}_n(X/S, D).
$$

We set

$$
C_n(X/S, D)^{\text{degn}} := \sum_{i=1}^n \text{Im}(\overline{\Box}_S(p_{n,i}) \circ : C_{n-1}(X/S, D) \to C_n(X/S, D)),
$$

$$
C_n(X/S, D) := \tilde{C}_n(X/S, D) / C_n(X/S, D)^{\text{degn}}
$$

and

$$
\partial_{n,i,\epsilon} := \overline{\Box}_S(\eta_{n-1,i,\epsilon}) \circ : C_n(X/S, D) \to C_{n-1}(X/S, D).
$$

We denote by $(C_{\bullet}(X/S, D), d)$ the complex with differential given by

$$
d_n = \sum_{i=1}^n (-1)^i (\partial_{n,i,\infty} - \partial_{n,i,0}) : C_n(X/S, D) \to C_{n-1}(X/S, D).
$$

Finally for $i \in \mathbb{Z}$ we denote by

$$
H_i^S(X/S, D) := H_i(C_{\bullet}(X/S, D), d),
$$

the *i*-th Suslin homology of $(X/S, D)$. If $S = \operatorname{Spec} k$ we simply write

$$
H_i^S(X, D) := H_i^S(X/\operatorname{Spec} k, D).
$$

Remark 3.2. Notice that by definition an integral correspondence $Z \in C_n(X/S, D)$ can be identified with an integral closed subscheme $Z \subset (\mathbb{P}^1 \setminus \{1\})^n \times (X \setminus |D|)$ such that the map $Z \to (\mathbb{P}^1 \setminus \{1\})^n \times S$ induced by $X \to S$ is finite and surjective and if $\overline{Z} \subset (\mathbb{P}^1)^n \times X$ denotes the closure of Z then

(3.2.1)
$$
D_{\overline{Z}} \prec \left(\sum_{i=1}^{n} (\mathbb{P}^1)^{i-1} \times \{1\} \times (\mathbb{P}^1)^{n-i}\right)_{\overline{Z}}.
$$

Also notice that because of this last condition Z is actually closed in $(\mathbb{P}^1 \setminus \{1\})^n \times X$.

Furthermore by definition (or convention) the group $C_0(X/S, D)$ is equal to the closed integral subschemes $Z \subset X$ which are finite and surjective over a connected component of S and are contained in $X \setminus |D|$.

Lemma 3.3 (Levine). Let S be a smooth k-scheme and $(X/S, D) \in \text{Sm}_S^*$ Cor. For $n \geq 0$ set

$$
NC_n(X/S,D) := \bigcap_{i=2}^n \text{Ker}(\partial_{n,i,0}) \cap \bigcap_{i=1}^n \text{Ker}(\partial_{n,i,\infty}).
$$

Then the differential d_n : $C_n(X/S, D) \to C_{n-1}(X/S, D)$ restricts to

$$
\partial_{n,1,0} : NC_n(X/S, D) \to NC_{n-1}(X/S, D)
$$

and the natural inclusion of complexes

$$
(NC_{\bullet}(X/S, D), \partial_{\bullet,1,0}) \hookrightarrow (C_{\bullet}(X/S, D), d)
$$

is a homotopy equivalence. In particular

$$
H_i^S(X/S, D) = H_i(NC_{\bullet}(X/S, D)).
$$

Proof. This follows from the fact that $\underline{n} \mapsto \widetilde{C}_n(X/S, D)$ is an extended cubical object and [\[Lev09,](#page-22-11) Lem 1.6]. \square

3.4. We give some further properties of the groups $H_i^S(X/S, D)$.

- (1) Sm^{*}₅Cor $\rightarrow D^-$ (abelian groups), $(X/S, D) \rightarrow C_{\bullet}(X/S, D)$ is a covariant functor. In particular, $Sm_S^*Cor \rightarrow$ (abelian groups), $(X/S, D) \rightarrow$ $H_i^S(X/S, D)$ is a covariant functor for all *i*.
- (2) Let $\mathrm{CH}^r(X|D, n)$ be the higher Chow groups with modulus from [\[BS\]](#page-22-4) which are the *n*-th homology groups of the cycle complex $z^{r}(X|D, \bullet)$ defined in [\[BS,](#page-22-4) Def 2.5]. If $d = \dim X$, then there is a natural map $C_{\bullet}(X, D) \rightarrow$ $z^d(X|D, \bullet)$ inducing maps

(3.4.1)
$$
H_i^S(X, D) \to \text{CH}^d(X|D, i),
$$

cf. [\[SV00,](#page-23-1) Conj 1.2].

- (3) For $i = 0$, the map $H_0^S(X, D) \xrightarrow{(3.4.1)} CH^d(X|D) = CH_0(X|D)$ $H_0^S(X, D) \xrightarrow{(3.4.1)} CH^d(X|D) = CH_0(X|D)$ $H_0^S(X, D) \xrightarrow{(3.4.1)} CH^d(X|D) = CH_0(X|D)$ is an isomorphism. Indeed, this follows directly from the definition and the fact that a 1-dimensional closed subscheme in $(X \setminus |D|) \times \square^1$, which intersects the faces of \Box^1 properly, has either trivial boundary or is finite and surjective over \Box^1 . (Here we use that X is proper over k.)
- (4) For $(X/S, D) \in Sm_S^*$ Cor and D' an effective Cartier divisor on X with $|D'| = |D|$ and $D' \ge D$ the identity on X induces a map $(X/S, D') \rightarrow$ $(X/S, D)$ in Sm^{*}_sCor. Now let U be an S-scheme which is smooth and equidimensional over k . Using Nagata compactification we find a pair

 $(X/S, D) \in Sm_S^*$ Cor with an S-isomorphism $U \cong X \setminus |D|$. By the comment above we obtain a projective system $(H_i^S(X/S, m \cdot D))_{m \in \mathbb{N}}$. We set

$$
H_{c,i}^S(U/S) := \varprojlim_m H_i^S(X/S, m \cdot D).
$$

Notice that this definition is independent of the choice $(X/S, D)$. Indeed as usual this follows from the two observations: 1. Any two choices of $(X/S, D)$ and $(X'/S, D')$ can be dominated by a third object $(X''/S, D'') \in \mathrm{Sm}^*_S\mathrm{Cor}$ with $X''\setminus|D''|\cong U$. 2. If $(X'/S, D')\to (X/S, D)$ is a morphism in Sm_{S}^* Cor inducing an S-isomorphism on $X' \setminus |D'| \stackrel{\simeq}{\to} X \setminus |D|$, then it also induces an isomorphism

$$
\varprojlim_{m} H_{i}^{S}(X'/S, m \cdot D') \xrightarrow{\simeq} \varprojlim_{m} H_{i}^{S}(X/S, m \cdot D).
$$

The latter fact follows directly from Remark [2.10](#page-5-2) (the case of a birational map).

(5) Assume k is a finite field of characteristic $\neq 2$ and U a smooth and integral k-scheme. Then using (3) above and $[BS, Thm 3.3]$ the Theorem of Kerz and Saito [\[KS14,](#page-22-12) Thm III] can be reformulated as an isomorphism

$$
H_{c,0}^{S}(U) \xrightarrow{\simeq} W^{\text{ab}}(U),
$$

where $W^{\text{ab}}(U) \subset \pi_1^{\text{ab}}(U)$ is the abelianized Weil group of U.

(6) Let $(X/S, D) \in \mathrm{Sm}_S^*$ Cor and put $U = X \setminus |D|$. The relative Suslin homology $H_i^S(U/S)$ is defined in [\[SV96,](#page-22-1) §3] as the homology group of a simplicial complex $C^S_{\bullet}(U/S)$. As usual it can be rewritten as a homology group of a cubical complex. Namely, by forgetting modulus in the construction of $C_{\bullet}(X/S, D)$, one gets a complex $C_{\bullet}(U/S)$ which is quasi-isomorphic to $C_{\bullet}^{S}(U/S)$. Then $C_{\bullet}(X/S, D)$ is a subcomplex of $C_{\bullet}(U/S)$, hence there is a canonical homomorphism $H_i^S(X/S, D) \to H_i^S(U/S)$. It is not clear if this is bijective when D is reduced (compare [\[KSYb,](#page-22-13) Remark 3.5]).

4. The main theorem

We state the main result of this note in Theorem [4.4](#page-10-0) below.

4.1. We recall some notations from [\[SV96\]](#page-22-1) and [\[KSYb\]](#page-22-13). For X an integral k-scheme and D an effective Cartier divisor on X we denote

$$
\mathcal{O}_{X|D}^{\times} := \text{Ker}(\mathcal{O}_{X}^{\times} \to \mathcal{O}_{D}^{\times}).
$$

We set $Pic(X, D) := H^1(X, \mathcal{O}_{X|D}^{\times})$. Recall that this group can be identified with the group of isomorphism classes of pairs (\mathcal{L}, α) , where $\mathcal L$ is a line bundle on X and α is an isomorphism $\mathcal{L}_{|D} \xrightarrow{\simeq} \mathcal{O}_D$. We denote by $\widetilde{\text{Pic}}(X,D) \subset \text{Pic}(X,D)$ the subgroup of isomorphism classes of pairs (\mathcal{L}, α) , for which there exists an open subset $V \subset X$ with $|D| \subset V$ and such that α is the restriction of an isomorphism $\mathcal{L}_{|V} \cong \mathcal{O}_V$. If D has an open affine neighborhood, then $\widetilde{\text{Pic}}(X,D) = \text{Pic}(X,D)$, see [\[SV96,](#page-22-1) 2.]. Further, we set

$$
G(X, D) := \bigcap_{x \in |D|} \text{Ker}(\mathcal{O}_{X,x}^{\times} \to \mathcal{O}_{D,x}^{\times}).
$$

We denote by $X^{(1)}$ the set points $x \in X$ whose closure $\overline{\{x\}} \subset X$ has codimension one. Notice that if X is normal and we write $D = \sum_i n_i D_i$, where the D_i are the

irreducible components of D, and if we denote by $v_x : k(X)^{\times} \to \mathbb{Z}$ the normalized discrete valuation defined by a 1-codimensional point $x \in X^{(1)}$, then

$$
G(X, D) =
$$

{ $f \in k(X)^\times | v_x(f) = 0, x \in X^{(1)}$ with $\overline{\{x\}} \cap D \neq \emptyset$, and $v_x(f-1) \ge n_i$, if $\overline{\{x\}} = D_i$ }.

Indeed, since X is normal the condition $v_x(f) = 0$, for all $x \in X^{(1)}$ with $\overline{\{x\}} \cap D \neq \emptyset$, implies that f is regular on a neighborhood containing D (e.g. the complement of the pole divisor of f). Further since D is a Cartier divisor it has no embedded components; hence if a function is regular in a neighborhood of D and its image in \mathcal{O}_D is equal to 1 in all generic points of D, then it is equal to 1 on all of D. Finally we denote by

 $Div(X, D)$

the group of Cartier divisors on X with support in $X \setminus |D|$. By [\[KSYb,](#page-22-13) Lem 3.2] there is an exact sequence

(4.1.1)
$$
0 \to H^0(X, \mathcal{O}_{X|D}^{\times}) \to G(X, D) \xrightarrow{\text{div}} \text{Div}(X, D) \to \widetilde{\text{Pic}}(X, D) \to 0.
$$

4.2. For the rest of this note, we fix a smooth connected k-scheme S and $(C/S, D) \in$ Sm_S^* Cor such that:

- (1) $\mathcal C$ is integral and normal.
- (2) $C \rightarrow S$ is proper and the generic relative dimension is equal to 1, i.e. $trdeg(k(\mathcal{C})/k(S)) = 1.$
- (3) $U = C \setminus D$ is smooth over k and $U \to S$ is affine.
- (4) There is an open affine subscheme of $\mathcal C$ which contains all the generic points of D.

Lemma 4.3. Under the above assumptions, we have $C_0(\mathcal{C}/S, D) = \text{Div}(\mathcal{C}, D)$.

Proof. First recall that $C_0(C/S, D)$ is the free abelian group generated by integral closed subschemes $Z \subset U$ which are finite and surjective over S. Since U is smooth and $U \to S$ has generic relative dimension 1, Z has to be a Cartier divisor on U which is actually closed in C. Therefore $C_0(\mathcal{C}/S, D)$ is a subgroup of $Div(\mathcal{C}, D)$. On the other hand if $Z \subset \mathcal{C}$ is a prime Cartier divisor whose support is contained in U , then by the assumptions in [4.2](#page-10-1) it has to be affine and proper over S and hence finite. Therefore its image is a reduced closed subscheme $Z_0 \subset S$. If Z_0 is strictly contained in S, then the dimension formula yields trdeg($k(Z)/k(Z_0) \geq 1$. But since Z is finite over S this is impossible. Therefore Z is surjective over S and hence an element in $C_0(\mathcal{C}/S, D)$.

The following theorem is a modulus version of [\[SV96,](#page-22-1) Thm. 3.1] (see also [\[Lic93\]](#page-22-2)).

Theorem 4.4. Let $(C \rightarrow S, D)$ be as in [4.2.](#page-10-1) Then

$$
C_{\bullet}(\mathcal{C}/S,D) \cong [G(\mathcal{C}, D) \xrightarrow{\text{div}} \text{Div}(\mathcal{C}, D)] \text{ in } D^{-}(\text{abelian groups}),
$$

where the complex on the right sits in homological degree 1 and 0. In particular, by [\(4.1.1\)](#page-10-2) we have $\widetilde{\mathbb{G}}$ is n

$$
H_i^S(\mathcal{C}/S, D) = \begin{cases} \text{Pic}(\mathcal{C}, D), & \text{if } i = 0, \\ H^0(\mathcal{C}, \mathcal{O}_{\mathcal{C}|D}^\times), & \text{if } i = 1, \\ 0, & \text{if } i \ge 2. \end{cases}
$$

Remark 4.5. If D is contained in an affine open neighborhood, then $H^0(X, \mathcal{O}_{X|D}^{\times})$ vanishes (see [\[SV96,](#page-22-1) Proof of Thm 3.1]) and $\widetilde{\text{Pic}}(\mathcal{C}, D) = \text{Pic}(\mathcal{C}, D)$. This shows Theorem [1.1.](#page-0-1)

The proof of Theorem [4.4](#page-10-0) will occupy the rest of this note. We start with some preliminary observations.

5. An auxiliary construction

5.1. We fix the following notation for this section: Let A be a semilocal Dedekind domain (thus a PID) with field of fractions $K = \text{Frac}(A)$. We denote by $\mathfrak{m}_1, \ldots, \mathfrak{m}_r$ the maximal ideals of A and by $v_1, \ldots, v_r : K^\times \to \mathbb{Z}$ the corresponding normalized discrete valuations. We fix an element $s \in \mathfrak{m}_1 \cdots \mathfrak{m}_r$ and a set of normalized discrete valuations V on K, which does not contain v_1, \ldots, v_r .

Given a discrete valuation v on K there exists a *canonical extension* of v to the field of rational functions $K(t_1, \ldots, t_n)$, which we denote again by v, such that for all $0 \neq f = \sum a_{i_1,...,i_n} t_1^{i_1} \cdots t_n^{i_n} \in K[t_1,...,t_n]$ we have

(5.1.1)
$$
v(f) = \min\{v(a_{i_1,\ldots,i_n}), \text{ all } i_1,\ldots,i_n\},\
$$

see e.g. [\[Bou72,](#page-22-14) VI, §10.1, Prop 2].

Definition 5.2. For $n \geq 1$ we define $Q_n(A, V, s) := Q_n$ to be the set of all polynomials

(5.2.1)
$$
f = \sum_{i_1=0}^{N_1} \cdots \sum_{i_n=0}^{N_n} a_{i_1,\ldots,i_n} \cdot t_1^{i_1} \cdots t_n^{i_n} \in A[t_1,\ldots,t_n]
$$

such that

(1)
$$
a_{i_1,...,i_n} \in s^{\max_{j=1}^n (N_j - i_j)} \cdot A
$$
, all $i_1,...,i_n$.
\n(2) $a_{N_1,...,N_n} \in A^{\times}$.
\n(3) $v(f/a_{N_1,...,N_n}) = 0$, for all $v \in V$.
\n(4) For all $j \in [1, n]$ we have $f(t_1,...,t_{j-1}, 0, t_{j+1},..., t_n) \neq 0$.

Notice that $A^{\times} \subset Q_n$.

Definition 5.3. Let $f \in A[t_1, \ldots, t_n]$ be a polynomial as in [\(5.2.1\)](#page-11-2). Then we say that f has a leading coefficient if $a_{N_1,...,N_n} \neq 0$, in which case we call $a_{N_1,...,N_n}$ the leading coefficient of f.

Definition 5.4. Let $f \in A[t_1, \ldots, t_n]$ be a polynomial and assume it satisfies the conditions [\(1\)](#page-11-3),[\(2\)](#page-11-4) and [\(3\)](#page-11-5) of Definition [5.2.](#page-11-6) Then we denote by $\rho(f)$ the unique polynomial which satisfies

(1)
$$
\rho(f) \in Q_n
$$
.
(2) $f = t_1^{m_1} \cdots t_n^{m_n} \cdot \rho(f)$, for non-negative integers m_1, \ldots, m_n .

Lemma 5.5. Assume $n \geq 2$. For $j \in [1, n]$ denote by $A^{(j)}$ the localization of $A[t_j]$ with respect to $\cup_{i=1}^r (\mathfrak{m}_i \cdot A[t_j])$. If v is a valuation on K denote by $v^{(j)}$ its canonical extension to $K(t_j)$ and set $\mathcal{V}^{(j)} := \{v^{(j)} | v \in \mathcal{V}\}\)$. Denote by

$$
\iota_j: A[t_1,\ldots,t_n] \hookrightarrow A^{(j)}[t_1,\ldots,\widehat{t_j},\ldots,t_n]
$$

the natural inclusion, where the hat $\overline{(\)}$ means omission. In particular, $A^{(j)}$ is a semilocal Dedekind domain with maximal ideals $\mathfrak{m}_i^{(j)} = \mathfrak{m}_i A^{(j)}$, and $s \in$ $\mathfrak{m}_1^{(j)} \cdots \mathfrak{m}_r^{(j)}$. We denote by $(1)^{(j)}$ $(1)^{(j)}$, $(2)^{(j)}$ $(2)^{(j)}$ the properties (1) , (2) from Definition [5.2](#page-11-6) with A, V replaced by $A^{(j)}, V^{(j)}$. Then, for $f \in A[t_1, \ldots, t_n]$ we have

f satisfies [\(1\)](#page-11-3) and [\(2\)](#page-11-4) $\Longleftrightarrow \iota_j(f)$ satisfies $(1)^{(j)}$ and $(2)^{(j)}$, for all $j \in [1, n]$. *Proof.* For $j \in [1, n]$ write

$$
f = \sum_{i_1=0}^{N_1} \cdots \widehat{\sum_{i_j=0}^{N_j}} \cdots \sum_{i_n=0}^{N_n} a_{i_1,\ldots,\widehat{i_j},\ldots,i_n}^{(j)} t_1^{i_1} \cdots \widehat{t_j^{i_j}} \cdots t_n^{i_n},
$$

where

$$
a_{i_1,\dots,\widehat{i_j},\dots,i_n}^{(j)} = \sum_{i_j=0}^{N_j} a_{i_1,\dots,i_n} t_j^{i_j} \in A[t_j] \subset A^{(j)}.
$$

We write $(1)^{(j)}(\iota_j(f))$ for $\iota_j(f)$ satisfies $(1)^{(j)}$ etc. Then,

$$
(1)^{(j)}(\iota_j(f))
$$

\n
$$
\Leftrightarrow v_e^{(j)}(a_{i_1,\ldots,\widehat{i_j},\ldots,i_n}^{(j)}) \ge (\max_{\substack{c \in [1,n] \\ c \neq j}} (N_c - i_c)) \cdot v_e^{(j)}(s), \text{ all } e \in [1,r], i_1,\ldots,\widehat{i_j},\ldots,i_n
$$

\n
$$
\Leftrightarrow \min_{i_j=0}^{N_j} (v_e(a_{i_1,\ldots,i_n})) \ge (\max_{\substack{c \in [1,n] \\ c \neq j}} (N_c - i_c)) \cdot v_e(s), \text{ all } e \in [1,r], i_1,\ldots,\widehat{i_j},\ldots,i_n.
$$

Hence

$$
(1)^{(j)}(\iota_j(f)), \text{ for all } j \in [1, n] \Longleftrightarrow (1)(f).
$$

Furthermore,

$$
(2)^{(j)}(\iota_j(f)) \Longleftrightarrow v_e^{(j)}(a_{N_1,\ldots,\widehat{N_j},\ldots,N_n}^{(j)}) = 0, \text{ all } e \in [1, r]
$$

$$
\Longleftrightarrow \min_{i_j=0}^{N_j} (v_e(a_{N_1,\ldots,i_j,\ldots,N_n})) = 0, \text{ all } e \in [1, r]
$$

$$
\Longleftrightarrow v_e(a_{N_1,\ldots,N_n}) = 0, \text{ all } e \in [1, r]
$$

$$
\Longleftrightarrow (2)(f).
$$

Hence the lemma. \Box

Lemma 5.6. Let $f \in A[t_1, \ldots, t_n]$ be a polynomial. Then f satisfies properties [\(1\)](#page-11-3) and (2) of Definition [5.2](#page-11-6) if and only if f satisfies the following two properties:

(1) There exist $N \in \mathbb{Z}_{\geq 0}$ and $g_1, \ldots, g_n, h \in A[t_1, \ldots, t_n]$ such that

$$
f \cdot h = (t_1 \cdots t_n)^N + s \cdot (t_1 \cdots t_n)^{N-1} \cdot g_1 + \cdots + s^N \cdot g_N.
$$

 (2) $f(t_1, \ldots, t_{j-1}, \infty, t_{j+1}, \ldots, t_n) \notin \mathfrak{m}_i A[t_1, \ldots, t_j, \ldots, t_n],$ for all $j \in [1, n]$ and $i \in [1, r]$. (Here $f(t_1, \ldots, t_{j-1}, \infty, t_{j+1}, \ldots, t_n)$) denotes the leading term of f viewed as a polynomial in t_i .)

Proof. Assume f satisfies the conditions (1) and (2) from the statement. We have to show that f has the properties (1) and (2) of Definition [5.2.](#page-11-6) We prove this by induction over *n*. First assume $n = 1$ and write $t = t_1$. In this case clearly [\(2\)](#page-12-1) of the statement implies [\(2\)](#page-11-4) of Definition [5.2.](#page-11-6) Set $g(t) := t^N + s \cdot t^{N-1} \cdot g_1(t) + \cdots$ $s^N \cdot g_N(t) \in A[t]$. Let b be a root of f in some finite extension L of K. By [\(1\)](#page-12-0) we have $g(b) = 0$ and hence the element b lies in the integral closure B of A in L. By the Krull-Akizuki theorem B is still a semi-local Dedekind domain. Using that B is factorial and the special shape of g it is direct to check that $s|b$. Taking L large enough we can assume that all roots of f lie in B. Hence $f = u \prod_i (t - s b_i)$, with $u \in A^{\times}$ and $b_i \in B$. This implies f satisfies [\(1\)](#page-11-3) of Definition [5.2.](#page-11-6) Now if $n \geq 2$ we observe that for all $j \in [1, n]$ the polynomials $\iota_j(f) \in A^{(j)}[t_1, \ldots, \widehat{t_j}, \ldots, t_n]$ satisfy the analogs of $(1),(2)$ $(1),(2)$ of the statement, where we use the notation from Lemma [5.5.](#page-11-7) (Notice that t_j^N is a unit in $A^{(j)}$.) Hence by induction $\iota_j(f)$ satisfies $(1)^{(j)}$, $(2)^{(j)}$ of Definition [5.2](#page-11-6) for all $j \in [1, n]$. We conclude with Lemma [5.5.](#page-11-7)

Conversely, if f has the properties (1) and (2) of Definition [5.2.](#page-11-6) Then it clearly satisfies (2) of the statement. We show that it also satisfies (1) . To this end let f be as in [\(5.2.1\)](#page-11-2). Set $M := \max\{N_1, \ldots, N_n\}$. Then by condition [\(1\)](#page-11-3) of Definition [5.2](#page-11-6) for all tuples $(i_1, \ldots, i_n) \neq (N_1, \ldots, N_n)$ there exist an $i \in [0, M - 1]$ such that $\max_{j=0}^{n}(N_j - i_j) = M - i$ and $a_{i_1,...,i_n} = s^{M-i}b_{i_1,...,i_n} \in A$ with $b_{i_1,...,i_n} \in A$. We get

$$
(5.6.1) \ f \cdot (a_{N_1,\ldots,N_n}^{-1} t_1^{M-N_1} \cdots t_n^{M-N_n}) = (t_1 \cdots t_n)^M + \sum_{i=1}^M s^{M-i} (t_1 \cdots t_n)^i \cdot g_{M-i},
$$

where

$$
g_{M-i} = \sum_{\substack{(i_1,\ldots,i_n) \\ \max_{j=1}^n (N_j-i_j)=M-i}} b_{i_1,\ldots,i_n} t_1^{M-i-N_1+i_1} \cdots t_n^{M-i-N_n+i_n} \in A[t_1,\ldots,t_n].
$$

Thus f satisfies [\(1\)](#page-12-0).

Lemma 5.7. Let $f, g \in A[t_1, \ldots, t_n]$ be polynomials. Then

$$
f \cdot g \in Q_n \Longleftrightarrow f, g \in Q_n.
$$

Proof. This ' \leftarrow ' direction is easy. We prove the other direction. Clearly f and g satisfy condition [\(4\)](#page-11-8) of Definition [5.2.](#page-11-6) By Lemma [5.6](#page-12-2) $f \cdot g \in Q_n$ implies that $f \cdot g$ satisfies the conditions $(1),(2)$ $(1),(2)$ of Lemma [5.6](#page-12-2) and then also each of f and g satisfies these conditions. Hence f and g satisfy (1) , (2) of Definition [5.2.](#page-11-6) Furthermore if a, b are the leading coefficients of f, g , then ab is the leading coefficient of fg and we have by assumption $0 = v(fg/ab) = v(f/a) + v(g/b)$, for all $v \in V$. Since f/a , g/b have leading coefficient equal to 1 we have $v(f/a) \leq 0$ and $v(g/b) \leq 0$, by the formula in [\(5.1.1\)](#page-11-9). Hence $v(f/a) = v(g/b) = 0$. Thus $f, g \in Q_n$.

Corollary 5.8. Q_n/A^{\times} is the free abelian monoid generated on polynomials $f \in Q_n$ which are irreducible and are normalized such that the leading coefficient is 1.

Proof. This follows from Lemma [5.7](#page-13-1) and the fact that $A[t_1, \ldots, t_n]$ is factorial. \Box

6. Proof of the main theorem

6.1. Let $(C/S, D)$ be as in [4.2.](#page-10-1) Let $D_{red} = \bigcup_i D_i$ be the decomposition into irreducible components. We denote by A the semilocalization of $\mathcal{O}_{\mathcal{C}}$ at the generic points of D. (By assumption [4.2](#page-10-1) (4) there is an open affine subscheme Spec $B \subset \mathcal{C}$ containing all the generic points of D , then A is the localization of B at the union of the prime ideals corresponding to these points.) In particular, A is a semilocal Dedekind domain. Let $s \in A$ be an equation for D, i.e.

$$
D_{|Spec\,A} = \operatorname{Spec} A/(s).
$$

Set $U := \mathcal{C} \setminus |D|$ and

$$
\mathcal{V} := \{ v_x \, | \, x \in U^{(1)} \text{with } \overline{\{x\}} \cap |D| \neq \emptyset \},
$$

where we denote by $v_x : k(\mathcal{C})^{\times} \to \mathbb{Z}$ the normalized discrete valuation corresponding to x. We have two maps

(6.1.1)
$$
U \times \square^n \stackrel{j}{\to} C \times (\mathbb{P}^1)^n \stackrel{\alpha}{\leftarrow} \text{Spec } A \times \mathbb{A}^n,
$$

where j is the natural open immersion and α is the product of the natural map Spec $A \to C$ and the composition

(6.1.2)
$$
\mathbb{A}^n = \operatorname{Spec} k[t_1, \dots, t_n] \to \operatorname{Spec} k[y_1, \dots, y_n] = (\mathbb{P}^1 \setminus \{\infty\})^n \hookrightarrow (\mathbb{P}^1)^n,
$$

where the first map is induced by $y_i \mapsto 1 - t_i$.

Let $Z \subset U \times \square^n$ be an integral closed subscheme which is finite and surjective over $S \times \Box^n$ and denote by $\overline{Z} \subset \mathcal{C} \times (\mathbb{P}^1)^n$ its closure. In particular codim $(\overline{Z}, \mathcal{C} \times (\mathbb{P}^1)^n) =$ 1. Denote by $Z_0 \subset \mathcal{C}$ the image of \overline{Z} . Since Z_0 surjects onto S the dimension formula yields

$$
1 = \operatorname{trdeg}(k(Z_0)/k(S)) + \operatorname{codim}(Z_0, \mathcal{C}).
$$

Therefore we arrive in one of the following two cases:

(1) codim(Z_0 , C) = 1 and hence $\overline{Z} = Z_0 \times (\mathbb{P}^1)^n$.

(2) $Z_0 = C$.

In the second case the scheme-theoretic inverse image $\alpha^{-1}(\overline{Z})$ is an integral closed subscheme of codimension one in Spec $A \times \mathbb{A}^n$. Since $A[t_1, \ldots, t_n]$ is factorial there is an irreducible polynomial $p(Z) \in A[t_1, \ldots, t_n]$ such that

(6.1.3)
$$
\alpha^{-1}(\overline{Z}) = \text{div}(p(Z)).
$$

Notice that $p(Z)$ is only well-defined up to multiplication with an element from A^{\times} .

Lemma 6.2. Let $Z \subset U \times \square^n$ be as above. If $Z \in \tilde{C}_n(\mathcal{C}/S, D)$, then one of the following two conditions is satisfied (with the notations from above):

- (1) codim $(Z_0, C) = 1$ and $Z_0 \in C_0(C/S, D)$ (i.e. Z_0 is finite and surjective over S and contained in U).
- (2) $Z_0 = C$ and $p(Z) \in Q_n(A, V, s)$, with A, V and s as chosen above.

Proof. In case $\text{codim}(Z_0, C) = 1$ we have $\overline{Z} = Z_0 \times (\mathbb{P}^1)^n$. Hence [\(3.2.1\)](#page-8-3) implies $Z_0 \cap D = \emptyset$, i.e. $Z_0 \subset U$. Now assume that $Z_0 = \mathcal{C}$. We have to check that

$$
f := p(Z)
$$

satisfies [\(1\)](#page-11-3)-[\(4\)](#page-11-8) of Definition [5.2.](#page-11-6) In fact [\(4\)](#page-11-8) is clear since we start with $Z \subset U \times \square^n$. For [\(2\)](#page-12-1) of Lemma [5.6](#page-12-2) we have to show that \overline{Z} does not contain a closed subset of the form $D_i \times (\mathbb{P}^1)^{j-1} \times \{\infty\} \times (\mathbb{P}^1)^{n-j}$, for some *i*, *j*. But this is excluded by the modulus condition [\(3.2.1\)](#page-8-3). Pulling back the modulus condition along α from $(6.1.1)$ we obtain

(6.2.1)
$$
D_{\alpha^{-1}(\overline{Z})} \prec V(t_1 \cdots t_n)_{\alpha^{-1}(\overline{Z})}.
$$

By definition of f in $(6.1.3)$ this means that the element

$$
\frac{t_1 \cdots t_n}{s} \in \text{Frac}\left(\frac{A[t_1, \ldots, t_n]}{(f)}\right)
$$

is integral over $A[t_1, \ldots, t_n]/(f)$. This directly translates into [\(1\)](#page-12-0) of Lemma [5.6.](#page-12-2) Hence f satisfies the conditions [\(1\)](#page-11-3) and [\(2\)](#page-11-4) of Definition [\(5.2\)](#page-11-6). Finally, if $x \in U^{(1)}$

with $\overline{\{x\}} \cap D \neq \emptyset$ we want to show that $v_x(f/a) = 0$, where a is the leading coefficient of f. We may assume $a = 1$ and hence we have to show $v_x(f) = 0$. Take $y \in \overline{\{x\}} \cap |D|$ and set $B := \mathcal{O}_{\mathcal{C},y}$ and $V := \text{Spec } B$. Denote by $\mathfrak{c}_y(f) \subset k(\mathcal{C})$ the B-submodule given by

$$
\mathfrak{c}_y(f) = \{c \in k(\mathcal{C}) \,|\, c \cdot f \in B[t_1,\ldots,t_n]\}.
$$

Then $\overline{Z} \times_{\mathcal{C} \times (\mathbb{P}^1)^n} (V \times \mathbb{A}^n)$ is the closed subscheme of $\text{Spec } B[t_1, \ldots, t_n]$ given by the ideal $c_y(f) \cdot f \cdot B[t_1, \ldots, t_n]$. Since the leading coefficient of f is equal to 1, we have $\mathfrak{c}_y(f) \subset B$. The modulus condition [\(3.2.1\)](#page-8-3) tells us in particular that $\overline{Z} \cap (D \mid \times \square^n) = \emptyset$. Hence $\overline{Z} \times_{\mathcal{C} \times (\mathbb{P}^1)^n} (\{y\} \times (\mathbb{A}^1 \setminus \{0\})^n) = \emptyset$. If $\mathfrak{m} \subset B$ denotes the maximal ideal this means that

$$
\frac{\mathfrak{c}_y(f) \cdot f \cdot B[t_1^{\pm 1}, \dots, t_n^{\pm 1}]}{\mathfrak{m} \cdot B[t_1^{\pm 1}, \dots, t_n^{\pm 1}]} = \frac{B[t_1^{\pm 1}, \dots, t_n^{\pm 1}]}{\mathfrak{m} \cdot B[t_1^{\pm 1}, \dots, t_n^{\pm 1}]},
$$

i.e. there exists an element $b \in \mathfrak{c}_y(f) \subset B$ and $M_1, \ldots, M_n \in \mathbb{Z}$ such that

(6.2.2)
$$
b \cdot f \in (t_1^{M_1} \cdots t_n^{M_n}) \cdot B^{\times} + \mathfrak{m} B[t_1^{\pm 1}, \ldots, t_n^{\pm 1}].
$$

Now write f as in [\(5.2.1\)](#page-11-2) (with $a_{N_1,...,N_n} = 1$). We claim that $M_i = N_i$ for all i. Indeed, [\(6.2.2\)](#page-15-0) yields that $b \cdot a_{M_1,...,M_n} \in B^{\times}$. If D_j is an irreducible component of D passing through y and with generic point η_j , then we have a natural map $B\to\mathcal{O}_{\mathcal{C},\eta_j}$ and hence $b\cdot a_{M_1,\dots,M_n}\in\mathcal{O}_{\mathcal{C},\eta_j}^\times$. In particular $a_{M_1,\dots,M_n}\in\mathcal{O}_{\mathcal{C},\eta_j}^\times$ which by [\(1\)](#page-11-3) of Definition [5.2](#page-11-6) is only possible if $M_i = N_i$. Since $a_{N_1,...,N_n} = 1$ [\(6.2.2\)](#page-15-0) yields that $b \in B^{\times}$ and hence $\mathfrak{c}_y(f) = B$. If $\pi \in \mathcal{O}_{\mathcal{C},x}$ is a local parameter then we obtain

$$
\pi^{-v_x(f)} \cdot \mathcal{O}_{\mathcal{C},x} = \{c \in k(\mathcal{C}) \mid c \cdot f \in \mathcal{O}_{\mathcal{C},x}[t_1,\ldots,t_n]\} = \mathfrak{c}_y(f) \cdot \mathcal{O}_{\mathcal{C},x} = \mathcal{O}_{\mathcal{C},x},
$$

i.e. $v_x(f) = 0$. This proves the lemma.

Proposition 6.3. Denote by $\tilde{C}_n(\mathcal{C}/S,D)$ ^{eff} the free submonoid of $\tilde{C}_n(\mathcal{C}/S,D)$ generated by prime correspondences. Then with the notation from [6.1](#page-13-2) above there is an isomorphism of monoids for all $n \geq 1$

(6.3.1)
$$
\tilde{C}_n(\mathcal{C}/S,D)^{\text{eff}} \xrightarrow{\simeq} C_0(\mathcal{C}/S,D)^{\text{eff}} \oplus (Q_n(A,\mathcal{V},s)/A^\times),
$$

which is given by

$$
Z \subset U \times \square^n (integral) \mapsto \begin{cases} Z_0, & \text{if } \overline{Z} = Z_0 \times (\mathbb{P}^1)^n, \\ p(Z) \mod A^{\times}, & \text{else.} \end{cases}
$$

Proof. The map is well-defined by Lemma [6.2.](#page-14-2) It is clearly injective and surjects onto the generators of the first factor. Let $f \in Q_n(A, V, s)$ be a non-constant irreducible polynomial. Then with the notation from [6.1](#page-13-2) it defines a point $(f) \in$ Spec $A \times \mathbb{A}^n$ and we denote by \overline{Z} the closure of $\alpha((f))$ in $\mathcal{C} \times (\mathbb{P}^1)^n$ and set $Z :=$ $j^{-1}(\overline{Z})$. We claim

$$
(6.3.2) \t\t Z \in \tilde{C}_n(\mathcal{C}/S, D).
$$

Then clearly $p(Z) = f \mod A^{\times}$ and the surjectivity follows from Corollary [5.8.](#page-13-3) We prove $(6.3.2)$. Since f satisfies [\(4\)](#page-11-8) of Definition [5.2,](#page-11-6) we see that Z is not empty and is henceforth an integral closed subscheme of codimension 1 inside $U \times \square^n$. Since f is non-constant \overline{Z} surjects onto C. Further the property [\(2\)](#page-11-4) of Definition [5.2](#page-11-6) implies that \overline{Z} does not contain closed subschemes of the form $D_i \times (\mathbb{P}^1)^{j-1} \times \{\infty\} \times (\mathbb{P}^1)^{n-j}$, for any *i*, *j*. Hence there is no irreducible component of $\overline{Z} \cap (D \times (\mathbb{P}^1)^n)$ which maps

to $\infty \in \mathbb{P}^1$ under any of the *n* projections. Thus it suffices to check the modulus condition [\(3.2.1\)](#page-8-3) after pulling \overline{Z} back along the composition

$$
\mathcal{C} \times \mathbb{A}^n \xrightarrow{\mathrm{id}_{\mathcal{C}} \times (6.1.2)} \mathcal{C} \times (\mathbb{P}^1 \setminus {\infty})^n \hookrightarrow \mathcal{C} \times (\mathbb{P}^1)^n.
$$

To this end write f as in [\(5.2.1\)](#page-11-2); we may assume $a_{N_1,...,N_n} = 1$. Property [\(3\)](#page-11-5) of Definition [5.2](#page-11-6) then implies that there exists an open subset $V \subset \mathcal{C}$ with $D \subset V$ such that $a_{i_1,\dots,i_n} \in \mathcal{O}_{\mathcal{C}}(V)$. (Here we use that C is normal.) Set $M := \max\{N_1,\dots,N_n\}$ and denote by $\eta_j \in D$ the generic points. Then by [\(1\)](#page-11-3) of Definition [5.2](#page-11-6) the a_{i_1,\dots,i_n} map to zero in $\mathcal{O}_{(M-i)\cdot D,\eta_j}$ for all j and all tuples (i_1,\ldots,i_n) with $\max_{j=1}^n (N_j-i_j)$ $M-i$, for some $i \in [0, M-1]$. Since D has no embedded components, this implies that $a_{i_1,\dots,i_n} \in H^0(V, \mathcal{O}_{\mathcal{C}}(-(M-i)\cdot D))$, for these tuples (i_1,\dots,i_n) . Therefore, if $V' \subset V$ is an open affine subset on which D is given by an equation σ one gets a similar equation as in [\(5.6.1\)](#page-13-4) and concludes that $t_1 \cdots t_n/\sigma$ is integral over $\mathcal{O}(V')[t_1, \cdots, t_n]/(f)$. This directly translates into the modulus condition [\(3.2.1\)](#page-8-3) over V' . Since $V' \subset V$ was arbitrary the modulus condition holds in general. In particular Z is closed in $\mathcal{C} \times \square^n$ and hence is proper over $S \times \square^n$. Since $U \to S$ is affine so is $Z \to S \times \square^n$ and therefore Z is finite over $S \times \square^n$. Then Z is also surjective onto $S \times \square^n$ for dimension reasons and hence $Z \in \tilde{C}_n(\mathcal{C}/S, D)$.

6.4. Let $f \in Q_{n+1}$ be a non-constant irreducible polynomial and write f as in [\(5.2.1\)](#page-11-2). Then for $j \in [1, n + 1]$ and $\epsilon \in \{0, \infty\}$ we define the correspondence

$$
Z_{j,\epsilon}(f) \in C_0(\mathcal{C}/S,D)^{\text{eff}}
$$

as follows: For a prime correspondence $Z \in C_0(\mathcal{C}/S, D)$ denote by $v_Z : k(\mathcal{C})^\times \to \mathbb{Z}$ the corresponding normalized discrete valuation; it extends canonically to valuations on $k(\mathcal{C} \times \square^n)$ and on $k(\mathcal{C} \times \square^{n+1})$, see [5.1.1.](#page-11-9) Then

$$
Z_{j,\epsilon}(f) := \sum_{Z \in C_0(C/S,D)} (-v_Z(f) + b_{j,\epsilon}(f)_Z) \cdot Z,
$$

with

$$
b_{j,\epsilon}(f)_Z := v_Z(f(t_1,\ldots,t_{j-1},\epsilon+1,t_j,\ldots,t_n)).
$$

(By convention we put $\infty + 1 = \infty$. We also use the notation from Lemma [5.6.](#page-12-2)) Notice that $b_{j,\epsilon}(f)_Z \ge \min\{v_Z(a_{i_1,\ldots,i_{n+1}})\}\$ and hence $-v_Z(f) + b_{j,\epsilon}(f)_Z \ge 0$, for all Z. Also for $u \in A^{\times}$ we have $Z_{j,\epsilon}(f) = Z_{j,\epsilon}(uf)$. If $f = \prod_i f_i \in Q_{n+1}$ with f_i irreducible then we set $Z_{j,\epsilon}(f) = \sum_i Z_{j,\epsilon}(f_i)$. By Corollary [5.8](#page-13-3) this yields a morphism of monoids

$$
Z_{j,\epsilon}: Q_{n+1}/A^{\times} \to C_0(\mathcal{C}/S,D)^{\text{eff}}.
$$

Denote by $(Q_{n+1}/A^{\times})^{\text{gp}}$ the group generated by the monoid Q_{n+1}/A^{\times} . Then we obtain a group homomorphism

$$
Z_{j,\epsilon}: (Q_{n+1}/A^\times)^{\rm gp} \to C_0(\mathcal{C}/S,D), \quad f/g \mapsto Z_{j,\epsilon}(f) - Z_{j,\epsilon}(g).
$$

Lemma 6.5. The following diagram commutes for all $n \geq 1$, $j \in [1, n]$ and $\epsilon \in$ $\{0,\infty\}$

$$
\tilde{C}_{n+1}(\mathcal{C}/S, D) \xrightarrow{\partial_{\epsilon}^j} \tilde{C}_n(\mathcal{C}/S, D)
$$
\n
$$
\stackrel{(6.3.1)}{\sim} \sim \tilde{C}_0(\mathcal{C}/S, D) \oplus (Q_{n+1}/A^{\times})^{\text{gp}} \xrightarrow{\partial_{\epsilon}^j} C_0(\mathcal{C}/S, D) \oplus (Q_n/A^{\times})^{\text{gp}},
$$

where the lower map is given by

$$
\left(Z, \frac{f(t_1,\ldots,t_{n+1})}{g(t_1,\ldots,t_{n+1})}\right) \mapsto \left(Z+Z_{j,\epsilon}(f/g), \frac{\rho(f(t_1,\ldots,t_{j-1},1+\epsilon,t_j,\ldots,t_n))}{\rho(g(t_1,\ldots,t_{j-1},1+\epsilon,t_j,\ldots,t_n))}\right),
$$

with $Z_{j,\epsilon}(f)$ as defined in [6.4](#page-16-0) and $\rho(f)$ as in Definition [5.4.](#page-11-10) In particular the following diagram commutes:

$$
\tilde{C}_1(\mathcal{C}/S, D) \longrightarrow \begin{array}{c} \partial_0 - \partial_{\infty} & \longrightarrow C_0(\mathcal{C}/S, D) \\ \cong \downarrow & \downarrow \\ C_0(\mathcal{C}/S, D) \oplus (Q_1/A^{\times})^{\text{gp}} & \xrightarrow{(Z, f(t)) \mapsto Z_{1,0}(f) - Z_{1,\infty}(f)} C_0(\mathcal{C}/S, D). \end{array}
$$

Proof. Let $Z \in C_{n+1}(\mathcal{C}/S, D)$ be a prime correspondence. If $Z = Z_0 \times \Box^{n+1}$ with $Z_0 \in C_0(\mathcal{C}/S, D)$ a prime correspondence, then $\partial_{\epsilon}^j(Z) = Z_0 \times \square^n$. Therefore $Z \mapsto$ $\partial_{\epsilon}^{j}(Z)$ translates under [\(6.3.1\)](#page-15-2) into $(Z_0,0) \mapsto (Z_0,0)$. Now assume Z dominates C and set $f := p(Z)$ with the notation from [\(6.1.3\)](#page-14-1) (this is well defined up to multiplication with an element from A^{\times}). Denote by $Z' \subset U \times (\mathbb{P}^1 \setminus \{0\})^{n+1}$ the image of Z under the isomorphism

(6.5.1)
$$
U \times (\mathbb{P}^1 \setminus \{1\})^{n+1} \xrightarrow{\simeq} U \times (\mathbb{P}^1 \setminus \{0\})^{n+1},
$$

which is induced by the unique isomorphism of \mathcal{O}_U -algebras $\mathcal{O}_U[t_1, \ldots, t_{n+1}] \rightarrow$ $\mathcal{O}_U[y_1,\ldots,y_{n+1}]$ given by $t_i \mapsto 1-y_i$. We have to compute $\partial_{1+\epsilon}^j(Z')$. We restrict to the case $\epsilon = 0$ and $j = n + 1$, the other cases are similar. Set $B = H^0(U, \mathcal{O}_{\mathcal{C}})$ and $K = \text{Frac}(B) = \text{Frac}(A)$. Then by definition of f the ideal of Z' in $U \times (\mathbb{P}^1 \setminus$ $\{0,\infty\}$ ⁿ⁺¹ is given by

$$
\mathfrak{p} = \{cf \mid c \in K \text{ with } cf \in B[t_1,\ldots,t_{n+1}]\} \cdot B[t_1,\ldots,t_{n+1},\frac{1}{t_1\cdots t_{n+1}}].
$$

Let x be the generic point of a prime correspondence in $C_n(\mathcal{C}/S, D)$ and denote by $x' \in U \times (\mathbb{P}^1 \setminus \{0\})^n$ its image under the isomorphism [\(6.5.1\)](#page-17-0). Denote by R the localization of $B[t_1, \ldots, t_{n+1}]$ with respect to the prime ideal defined by $x' \times \{1\}$ and by $v_{x'}$: Frac $(R/(t_{n+1}-1))^{\times} \to \mathbb{Z}$ the valuation defined by x'. Then the multiplicity with which the correspondence $\overline{\{x'\}}$ occurs in $\partial_1^{n+1}(Z')$ is equal to $v_{x'}(\mathfrak{p}R/(t_{n+1}-1))$. (Notice that $\mathfrak{p}R/(t_{n+1}-1)$ is a principal ideal so that the latter expression makes sense.) Now if x' dominates C we have $K \subset R$ so that $\mathfrak{p}R = (f)$ and

$$
v_{x'}(\mathfrak{p}R/(t_{n+1}-1))=v_{x'}(f(t_1,\ldots,t_n,1))=v_{x'}(\rho(f(t_1,\ldots,t_n,1))).
$$

Otherwise there is a point $x_0 \in U^{(1)}$ which dominates S and such that x' is the generic point of $x_0 \times (\mathbb{P}^1 \setminus \{0,\infty\})^n$. In this case $v_{x'}$ extends the valuation v_{x_0} defined by x_0 and if $\pi \in \mathcal{O}_{U,x_0}$ is a local parameter we have

$$
\mathfrak{p}R = (\pi^{-v_{x'}(f)} \cdot f).
$$

Hence $v_{x'}(\mathfrak{p}R/(t_{n+1}-1)) = -v_{x'}(f) + b_{n+1,0}(f) \frac{1}{x'}$. This proves the lemma. \square

Lemma 6.6. Let $f \in Q_1$ be non-constant. Then $f(1)/f(\infty) \in G(C, D)$ (see [4.1](#page-9-2)) for the notation) and $Z_{1,0}(f) - Z_{1,\infty}(f) = \text{div}(f(1)/f(\infty)).$

Proof. The first part is immediate from Definition [5.2.](#page-11-6) The second part follows from the exact sequence [\(4.1.1\)](#page-10-2), Lemma [4.3](#page-10-3) and the definition of $Z_{j,\epsilon}(f)$ in [6.4.](#page-16-0) \Box **Definition 6.7.** For $n \geq 1$ we define $NQ_n(A, V, s) := NQ_n$ to be the set of all elements in $\text{Frac}(A[t_1,\ldots,t_n])^{\times}/A^{\times}$ such that:

(1) it has a representation f/g with $f, g \in Q_n$ satisfying [\(2\)](#page-18-0)-[\(4\)](#page-18-1) below. (2)

$$
\beta_{j,0}(f/g) := \frac{\rho(f(t_1,\ldots,t_{j-1},1,t_{j+1},\ldots,t_n))}{\rho(g(t_1,\ldots,t_{j-1},1,t_{j+1},\ldots,t_n))} \in A^\times, \text{ for all } j \in [2,n].
$$

(3)

$$
\beta_{j,\infty}(f/g) := \frac{\rho(f(t_1,\ldots,t_{j-1},\infty,t_{j+1},\ldots,t_n))}{\rho(g(t_1,\ldots,t_{j-1},\infty,t_{j+1},\ldots,t_n))} \in A^\times, \text{ for all } j \in [1,n].
$$
\n(4)

$$
\beta_{j,\epsilon}(f/g)/\beta_{j',\epsilon'}(f/g) \in H^0(\mathcal{C}, \mathcal{O}_{\mathcal{C}|D}^{\times}),
$$

where $(j, \epsilon), (j', \epsilon') \in ([1, n] \times {\infty}) \cup ([2, n] \times {0})$ and we use the notation from [4.1.](#page-9-2)

Notice that NQ_n is a group. We obtain a homological complex

$$
NQ_{\bullet} : \ldots \to NQ_n \xrightarrow{\delta_n} NQ_{n-1} \xrightarrow{\delta_{n-1}} \ldots \to NQ_1 \xrightarrow{\delta_1} NQ_0 := C_0(\mathcal{C}/S, D) \to 0,
$$

where

$$
\delta_n\left(\frac{f(t_1,\ldots,t_n)}{g(t_1,\ldots,t_n)}\right) = \begin{cases} \frac{\rho(f(1,t_1,\ldots,t_{n-1}))}{\rho(g(1,t_1,\ldots,t_{n-1}))}, & \text{if } n \ge 2\\ \text{div}(\frac{f(1)}{g(1)}\frac{g(\infty)}{f(\infty)}), & \text{if } n = 1. \end{cases}
$$

Corollary 6.8. The isomorphism from Proposition [6.3](#page-15-3) induces an isomorphism

 $NC_{\bullet}(\mathcal{C}/S,D) \stackrel{\simeq}{\rightarrow} NQ_{\bullet},$

where $NC_{\bullet}(\mathcal{C}/S, D)$ is the normalized chain complex from Lemma [3.3.](#page-8-4) In particular, by the latter lemma NQ $_{\bullet}$ is homotopy equivalent to $C_{\bullet}(\mathcal{C}/S, D)$.

Proof. Consider the homological complex $C_0(C/S, D) \oplus (Q_{\bullet}/A^{\times})^{\text{gp}}$ with differentials as described in Lemma [6.5.](#page-16-1) It suffices to show that the normalized complex of $C_0(\mathcal{C}/S,D) \oplus (Q_{\bullet}/A^{\times})^{\text{gp}}$ (in the sense of Lemma [3.3\)](#page-8-4) is equal to NQ_{\bullet} . To this end, we take $(\alpha, f/g) \in C_0(\mathcal{C}/S, D) \oplus (Q_n/A^\times)^{\text{gp}}$. We can assume that f and g have leading coefficient equal to 1. Assume that $\partial_{\epsilon}^{j}(\alpha, f/g) = 0$ for all $(j, \epsilon) \in$ $([1, n] \times {\infty}) \cup ([2, n] \times {0})$. By Lemma [6.5](#page-16-1) this is equivalent to $\beta_{j,\epsilon}(f/g) \in A^{\times}$ and $\alpha = -Z_{j,\epsilon}(f/g)$ for all $(j,\epsilon) \in ([1,n] \times {\infty}) \cup ([2,n] \times {0})$. Finally notice that under the above conditions

$$
Z_{j,\epsilon}(f/g) = Z_{j',\epsilon'}(f/g)
$$

is by the definition of $Z_{j,\epsilon}$ in [6.4](#page-16-0) equivalent to

$$
\operatorname{div}(\beta_{j,\epsilon}(f/g)) = \operatorname{div}(\beta_{j',\epsilon'}(f/g)) \quad \text{on } \mathcal{C}.
$$

Hence $\beta_{j,\epsilon}(f/g)/\beta_{j',\epsilon'}(f/g)$ is a global unit of C. Furthermore since f and g have leading coefficient equal to 1 condition [\(1\)](#page-11-3) of Definition [5.2](#page-11-6) says that f and g map to 1 in the residue fields of the generic points of D . Since D is a Cartier divisor, it has no embedded components and therefore $f = g = 1$ on all of D. This gives $\beta_{j,\epsilon}(f/g)/\beta_{j',\epsilon'}(f/g) \in H^0(\mathcal{C}, \mathcal{O}_{\mathcal{C}|D}^{\times}).$

We define θ_0 : $NQ_0 \rightarrow C_0(\mathcal{C}/S, D)$ to be the identity map and for $n \geq 1$,

$$
\theta_n: NQ_n \to C_0(\mathcal{C}/S, D) \oplus (Q_n/A^\times)^{\rm gp}, \quad f/g \mapsto (-Z_{1,\infty}(f/g), f/g).
$$

We claim that the diagram

(6.8.1)
$$
NQ_n \xrightarrow{\theta_n} C_0(\mathcal{C}/S, D) \oplus (Q_n/A^\times)^{\text{gp}}
$$

$$
\delta_n \downarrow \qquad \qquad \downarrow \delta_0^1
$$

$$
NQ_{n-1} \xrightarrow{\theta_{n-1}} C_0(\mathcal{C}/S, D) \oplus (Q_{n-1}/A^\times)^{\text{gp}}
$$

commutes for all $n \geq 1$. It is then clear that θ induces an isomorphism from NQ_{\bullet} to the normalized complex of $C_0(\mathcal{C}/S,D) \oplus (Q_{\bullet}/A^{\times})^{\text{gp}}$, which proves the corollary. For $n = 1$ the commutativity of [\(6.8.1\)](#page-19-0) follows directly from the definition of δ_1 , Lemma [6.5](#page-16-1) and Lemma [6.6.](#page-17-1) For $n \geq 2$ the commutativity amounts to show

$$
(6.8.2) \quad -Z_{1,\infty}(f/g) + Z_{1,0}(f/g) = -Z_{1,\infty}(f(1,t_1,\ldots,t_{n-1})/g(1,t_1,\ldots,t_{n-1})).
$$

To this end, let $Z \in C_0(\mathcal{C}/S, D)$ be a prime correspondence. With the notation from [6.4](#page-16-0) we compute

$$
-(-v_Z(f/g) + b_{1,\infty}(f/g)_Z) + (-v_Z(f/g) + b_{1,0}(f/g)_Z)
$$

= $-v_Z \left(\frac{f(\infty, t_1, \dots, t_{n-1})}{g(\infty, t_1, \dots, t_{n-1})} \right) + v_Z \left(\frac{f(1, t_1, \dots, t_{n-1})}{g(1, t_1, \dots, t_{n-1})} \right)$
= $-v_Z \left(\frac{f(1, \infty, t_1, \dots, t_{n-2})}{g(1, \infty, t_1, \dots, t_{n-2})} \right) + v_Z \left(\frac{f(1, t_1, \dots, t_{n-1})}{g(1, t_1, \dots, t_{n-1})} \right)$
= $- \left(b_{1,\infty} \left(\frac{f(1, t_1, \dots, t_{n-1})}{g(1, t_1, \dots, t_{n-1})} \right)_Z - v_Z \left(\frac{f(1, t_1, \dots, t_{n-1})}{g(1, t_1, \dots, t_{n-1})} \right) \right),$

where for the second equality we used that f/g has the properties [\(3\)](#page-18-2) and [\(4\)](#page-18-1) of Definition [6.7.](#page-18-3) This gives [\(6.8.2\)](#page-19-1) and finishes the proof. \Box

Lemma 6.9. Assume $n \geq 2$ and take $f, g \in Q_n$ with $f/g \in NQ_n$. Denote by $a \in A^{\times}$ the leading coefficient of f and by $b \in A^{\times}$ the leading coefficient of g (see Definition [5.2\)](#page-11-6). Then for all $(j, \epsilon) \in ([1, n] \times \{\infty\}) \cup ([2, n] \times \{0\})$ we have

(6.9.1)
$$
\frac{f(t_1,\ldots,t_{j-1},1+\epsilon,t_{j+1},\ldots,t_n)}{g(t_1,\ldots,t_{j-1},1+\epsilon,t_{j+1},\ldots,t_n)} = \frac{a}{b} \cdot t_1^{m_1} \cdots \widehat{t_j^{m_j}} \cdots t_n^{m_n},
$$

where $m_i = \deg_{t_i}(f) - \deg_{t_i}(g_i)$, $i \in [1, n]$. If furthermore $\delta_n(f/g) = 1$, then [\(6.9.1\)](#page-19-2) also holds for $(j, \epsilon) = (1, 0)$.

Proof. Write

$$
f = \sum_{i_1=0}^{N_1} \cdots \sum_{i_n=0}^{N_n} a_{i_1,\dots,i_n} \cdot t_1^{i_1} \cdots t_n^{i_n}
$$

and

$$
g = \sum_{j_1=0}^{M_1} \cdots \sum_{j_n=0}^{M_n} b_{j_1,\ldots,j_n} \cdot t_1^{j_1} \cdots t_n^{j_n}.
$$

Then

$$
f(t_1,\ldots,t_{n-1},\infty)=\sum_{i_1=0}^{N_1}\cdots\sum_{i_{n-1}=0}^{N_{n-1}}a_{i_1,\ldots,i_{n-1},N_n}\cdot t_1^{i_1}\cdots t_{n-1}^{i_{n-1}}
$$

and

$$
g(t_1,\ldots,t_{n-1},\infty)=\sum_{j_1=0}^{M_1}\cdots\sum_{j_{n-1}=0}^{M_{n-1}}b_{j_1,\ldots,j_{n-1},M_n}\cdot t_1^{i_1}\cdots t_{n-1}^{i_{n-1}}.
$$

Since $n \geq 2$ we can only have an equality $\beta_{n,\infty}(f/g) = c_{n,\infty} \in A^{\times}$ if there exist non-negative integers $r_i \in [0, N_i]$ and $s_i \in [0, M_i]$ such that

(6.9.2)
$$
a_{i_1+r_1,...,i_{n-1}+r_{n-1},N_n} = c_{n,\infty} \cdot b_{i_1+s_1,...,i_{n-1}+s_{n-1},M_n}
$$
, for all $i_1,...,i_{n-1}$.
We set $m_i(n) := r_i - s_i$. Then plugging in $i_j = N_j - r_j$ we see that

$$
b_{N_1-m_1(n),...,N_n-m_n(n)} \in A^{\times}.
$$

By definition of Q_n this is only possible if

$$
(6.9.3) \qquad \deg_{t_i}(f) = N_i = M_i + m_i(n) = \deg_{t_i}(g) + m_i(n), \quad \text{for } i \in [1, n-1].
$$

Furthermore we get

$$
\beta_{n,\infty}(f/g) = c_{n,\infty} = a_{N_1,...,N_n}/b_{M_1,...,M_n} = a/b.
$$

We can play the same game with $\beta_{j,\infty}(f/g)$ for all $j \in [1,n]$ and get similar as in [\(6.9.3\)](#page-20-0)

$$
m_i(j) = N_i - M_i
$$
, for all $i \in [1, n] \setminus \{j\}, j \in [1, n]$.

Hence $m_i(j)$ is constant for i fixed and j running; we set $m_i := m_i(j)$. Furthermore similar as above we get

$$
\beta_{j,\infty}(f/g) = a/b, \text{ for all } j \in [1, n].
$$

This proves [\(6.9.1\)](#page-19-2) for $(j, \epsilon) \in [1, n] \times \{\infty\}$. The equality $\beta_{n,0}(f/g) = c_{n,0} \in A^{\times}$ implies that there exist non-negative integers $r'_i \in [0, N_i]$ and $s'_i \in [0, M_i]$ such that

$$
\sum_{i=0}^{N_n} a_{i_1+r'_1,\dots,i_{n-1}+r'_{n-1},i} = c_{n,0} \cdot \sum_{i=0}^{M_n} b_{i_1+s'_1,\dots,i_{n-1}+s'_{n-1},i}, \text{ for all } i_1,\dots,i_{n-1}.
$$

If we plug in $N_j - r'_j$ for the i_j 's, the left hand side of the above equality is in A^{\times} (by [\(1\)](#page-11-3) and [\(2\)](#page-11-4) of Definition [5.2\)](#page-11-6). Hence the right hand side is also a unit in this case; this is only possible if

$$
b_{N_1-r'_1+s'_1,...,N_{n-1}-r'_{n-1}+s'_{n-1},M_n}\in A^\times
$$

which is only possible if

$$
N_i - (r'_i - s'_i) = M_i
$$
, for all $i \in [1, n-1]$.

Hence $r'_i - s'_i = m_i$ for $i \in [1, n-1]$. As above $\beta_{1,\infty}(f/g) = a/b$ implies, cf. [\(6.9.2\)](#page-20-1),

$$
a_{N_1,...,N_{n-1},i} = \begin{cases} a/b \cdot b_{M_1,...,M_{n-1},i-m_n}, & \text{if } i \ge m_n, \\ 0, & \text{if } i < m_n. \end{cases}
$$

Hence

$$
a/b \cdot \sum_{i=0}^{M_n} b_{M_1,...,M_{n-1},i} = \sum_{i=0}^{M_n} a_{N_1,...,N_{n-1},i+m_n}
$$

=
$$
\sum_{i=0}^{N_n} a_{N_1,...,N_{n-1},i} = c_{n,0} \cdot \sum_{i=0}^{M_n} b_{M_1,...,M_{n-1},i}.
$$

Hence $c_{n,0} = a/b$. Similarly $\beta_{j,0}(f/g) \in A^{\times}$ implies $\beta_{j,0}(f/g) = a/b$ for all $j \in [2, n]$
and if $\delta_n(f/g) = 1$ also for $j = 1$. Hence the lemma. and if $\delta_n(f/g) = 1$ also for $j = 1$. Hence the lemma.

Proof of Theorem [4.4.](#page-10-0) We start by showing that $H_n^S(C/S, D) = 0$, for $n \geq 2$. Take $f, g \in Q_n$ with $f/g \in NQ_n$ and assume $\delta_n(f/g) = 1$. We have to show that f/g lies in the image of $\delta_{n+1} : NQ_{n+1} \to NQ_n$. To this end we may assume that the leading coefficients of f, g are equal to 1. We denote by $N_i = \deg_{t_i}(f)$ and $M_i = \deg_{t_i}(g)$ their degrees. Set $m_i := N_i - M_i$. We define

$$
m_i^+ := \begin{cases} m_i, & \text{if } m_i \ge 0, \\ 0, & \text{if } m_i < 0 \end{cases}, \quad m_i^- := \begin{cases} 0, & \text{if } m_i \ge 0, \\ -m_i, & \text{if } m_i < 0. \end{cases}
$$

and

$$
h_1(t_1, \ldots, t_{n+1}) := t_1 \cdot (\prod_{i=2}^{n+1} t_i^{m_{i-1}^-}) \cdot f(t_2, \ldots, t_{n+1}),
$$

$$
h_2(t_1, \ldots, t_{n+1}) := (\prod_{i=2}^{n+1} t_i^{m_{i-1}^-}) \cdot f(t_2, \ldots, t_{n+1}) - (\prod_{i=2}^{n+1} t_i^{m_{i-1}^+}) \cdot g(t_2, \ldots, t_{n+1}).
$$

Then h_1 satisfies properties [\(1\)](#page-11-3)-[\(3\)](#page-11-5) of Definition [5.2.](#page-11-6) If we set $R_i := \deg_{t_i}(h_1)$, then $R_1 = 1$ and $R_i = \max\{N_{i-1}, M_{i-1}\}\$, for $i \in [2, n+1]$. By definition we have $\deg_{t_i}(h_2) \leq R_i$ and the coefficients of h_2 before $\prod_{i=1}^{n+1} t_i^{R_i}$ and $\prod_{i=2}^{n+1} t_i^{R_i}$ are zero. If we have a tuple $(i_2, \ldots, i_{n+1}) \in \prod_{i=2}^{n+1} [1, R_i]$ in which $i_j < R_j$ for at least one j, and $c_{0,i_2,...,i_{n+1}}$ is the coefficient of h_2 in front of $\prod_{j=2}^{n+1} t_j^{i_j}$, then

$$
c_{0,i_2,...,i_{n+1}} \in s^{\max_j \{R_j - i_j\}} \cdot A.
$$

This follows from $f, g \in Q_n$ and

$$
\min\{\max_j\{N_{j-1}-(i_j-m_{j-1}^-\}),\max_j\{M_{j-1}-(i_j-m_{j-1}^+)\}\}=\max_j\{R_j-i_j\}.
$$

Furthermore condition [\(3\)](#page-11-5) of Definition [5.2](#page-11-6) for f, g clearly implies $v(c_{0,i_2,...,i_{n+1}}) \geq 0$ for all $v \in V$. Hence $h_1 - h_2$ satisfies condition [\(1\)](#page-11-3) - [\(3\)](#page-11-5) of Definition [5.2.](#page-11-6) Thus

$$
h := \rho(h_1 - h_2) \in Q_{n+1}.
$$

We claim

$$
q := f(t_2, \ldots, t_{n+1})/h(t_1, \ldots, t_{n+1}) \in NQ_{n+1}.
$$

Indeed, since $f/g \in NQ_n$ and $\delta_n(f/g) = 1$ it follows from Lemma [6.9](#page-19-3) that under $t_i \mapsto 1+\epsilon$ the polynomial h_2 is mapped to zero, for all $i \in [2, n+1]$ and $\epsilon \in \{0, \infty\}$. Hence with the notation from Definition [6.7](#page-18-3) we have

$$
\beta_{j,\epsilon}(q) = 1, \quad \text{for all } j \in [2, n+1], \epsilon \in \{0, \infty\}.
$$

One checks directly that the same holds for $j = 1$ and $\epsilon = \infty$. Hence $q \in NQ_{n+1}$. Finally we observe

$$
\delta_{n+1}(q) = \frac{f(t_1,\ldots,t_n)}{g(t_1,\ldots,t_n)}.
$$

This finishes the prove of $H_i^S(\mathcal{C}/S, D) = 0$ for $i \geq 2$.

We are left to show that $NQ_1/\text{Im}(\delta_2) \stackrel{\delta_1}{\longrightarrow} NQ_0$ is quasi-isomorphic to $G(\mathcal{C}, D) \to$ Div(C, D). First we claim that for $f, g \in Q_1$ we have

(6.9.4)
$$
\frac{f(1)}{f(\infty)} = \frac{g(1)}{g(\infty)} \iff f/g \in \text{Im}(\delta_2).
$$

Indeed, to see this ' \implies ' direction we may assume that $f(\infty) = g(\infty) = 1$ and that $n := \deg(f) \geq \deg(g) := m.$ Set

$$
h(t_1, t_2) := \frac{f(t_2)}{\rho(t_1 f(t_2) - (f(t_2) - t_2^{n-m} g(t_2)))}.
$$

As above one checks that $h \in NQ_2$ and $\delta_2(h) = f/g$. The other direction follows immediately from Lemma [6.9.](#page-19-3)

We define the following map

$$
\varphi: G(\mathcal{C}, D) \to NQ_1/\text{Im}(\delta_2), \quad a \mapsto \rho((1-t_1)-a) \text{ mod } \text{Im}(\delta_2).
$$

Notice that φ is a group homomorphism since $f(t_1) = \rho((1 - t_1) - ab)$ and $g(t_1) =$ $\rho((1-t_1)-a)\rho((1-t_1)-b)$ satisfy the condition on the left of [\(6.9.4\)](#page-21-0). By ' \Leftarrow ' of [\(6.9.4\)](#page-21-0) φ is injective. By ' \implies ' of (6.9.4) and Lemma [6.6](#page-17-1) the map φ is also surjective. Altogether we see that φ is an isomorphism which clearly fits into the following commutative diagram

$$
G(C, D) \xrightarrow{\text{div}} \text{Div}(C, D)
$$

\n
$$
\simeq \bigvee_{i=1}^{d_{\varphi}} \varphi \qquad \text{Lem 4.3}
$$

\n
$$
NQ_1/\text{Im}(\delta_2) \xrightarrow{\delta_1} NQ_0.
$$

This finishes the proof. \Box
