# REPRESENTATIONS OF THE DOUBLE BURNSIDE ALGEBRA AND COHOMOLOGY OF THE EXTRASPECIAL $p$-GROUP II

#### Abstract

Let $E$ be the extraspecial $p$-group of order $p^{3}$ and exponent $p$ where $p$ is an odd prime. We determine the $\bmod p$ cohomology $H^{*}\left(X, \mathbb{F}_{p}\right)$ of a summand $X$ in the stable splitting of $p$-completed classifying space $B E$. In the previous paper [Representations of the double Burnside algebra and cohomology of the extraspecial $p$-group, J. Algebra 409 (2014) 265-319], we determined these cohomology modulo nilpotence. In this paper, we consider the whole part of the cohomology. Moreover, we consider the stable splittings of $B G$ for some finite groups with Sylow $p$-subgroup $E$ related with the three dimensional linear group $L_{3}(p)$.


## 1. Introduction

Let $p$ be an odd prime and $E=p_{+}^{1+2}$ the extraspecial $p$-group of order $p^{3}$ and exponent $p$. In the previous paper [7], we determined the composition factor of $H^{*}(E)=\left(\mathbb{F}_{p} \otimes\right.$ $\left.H^{*}(E, \mathbb{Z})\right) / \sqrt{(0)}$ as a right $A_{p}(E, E)$-module, where $A_{p}(E, E)$ is a double Burnside algebra of $E$ over $\mathbb{F}_{p}=\mathbb{Z} / p \mathbb{Z}$. In this paper, we consider the whole part of the cohomology $H^{*}\left(E, \mathbb{F}_{p}\right)$ and determine the composition factor of $H^{*}\left(E, \mathbb{F}_{p}\right)$ as an $A_{p}(E, E)$-module.

The $\bmod p$ cohomology ring $H^{*}\left(E, \mathbb{F}_{p}\right)$ of $E$ is completely known by [9], but the structure is very complicated. We shall study $H^{*}\left(E, \mathbb{F}_{p}\right)$ through the integral cohomology ring $H^{*}(E, \mathbb{Z})$ as in [13] and [14]. Let $H^{\text {even }}(E, \mathbb{Z})$ (resp. $\left.H^{\text {odd }}(E, \mathbb{Z})\right)$ be the even (resp. odd) degree part of $H^{*}(E, \mathbb{Z})$. Let $N=\sqrt{(0)}$ in $\mathbb{F}_{p} \otimes H^{\text {even }}(E, \mathbb{Z})$. Then we have that $\mathbb{F}_{p} \otimes H^{\text {even }}(E, \mathbb{Z}) / N \cong H^{*}(E)$. On the other hand, the Milnor operator $Q_{1}$ induces an isomorphism $H^{\text {odd }}(E, \mathbb{Z}) \cong\left(y_{1} v, y_{2} v\right) H^{*}(E)$ where $\left(y_{1} v, y_{2} v\right) H^{*}(E)$ is the ideal of $H^{*}(E)$ generated by $y_{1} v, y_{2} v \in H^{2 p+2}(E)$ (see the first part of section 2 ).

Let $M=\oplus M^{n}$ and $L=\oplus L^{n}$ be graded $A_{p}(E, E)$-modules such that $M^{n}$ and $L^{n}$ are finite dimensional for every $n$. We write as $M \leftrightarrow L$ if $M^{n}$ and $L^{n}$ have same composition factors (with same multiplicity), that is, $\left[M^{n}\right]=\left[L^{n}\right]$ in the Grothendieck group $K_{0}\left(A_{p}(E, E)\right)$.

Using this notation, the structure of $H^{*}\left(E, \mathbb{F}_{p}\right)$ can be stated as follows.
Theorem 1.1. (1) As $A_{p}(E, E)$-modules,

H^{\text {even }}\left(E, \mathbb{F}_{p}\right) \leftrightarrow H^{*}(E) \oplus N \oplus\left(y_{1} v, y_{2} v\right) H^{*}(E)[-2 p] .
$$

(2) As $A_{p}(E, E)$-modules,

$$
H^{\text {odd }}\left(E, \mathbb{F}_{p}\right) \leftrightarrow\left(y_{1} v, y_{2} v\right) H^{*}(E)[-2 p+1] \oplus\left(N \oplus H^{+}(E)\right)[-1] .
$$

Here, for a graded $\mathbb{F}_{p}$-subspace $M$ of $H^{*}(E)$, we denote by $M[i]$ the graded vector space with $M[i]^{n}=M^{n-i}$. Since the composition factors of $N$ and $\left(y_{1} v, y_{2} v\right) H^{*}(E)$ are determined in Proposition 3.1 and Theorem [3.5, we can get the composition factors of $H^{*}\left(E, \mathbb{F}_{p}\right)$ completely.

The indecomposable summands in the complete stable splitting of the $p$-completed classifying space $B E_{p}^{\wedge}$ correspond to primitive idempotents in $A_{p}(E, E)$. Moreover they corresponds to simple $A_{p}(E, E)$-modules. We simply write $B E$ for $B E_{p}^{\wedge}$. Let $X$ be a summand in $B E$ which corresponds to a simple $A_{p}(E, E)$-module $S$. Then the multiplicity of $X$ in $B E$ is equal to the dimension of $S$ as an $\mathbb{F}_{p}$-vector space since $\mathbb{F}_{p}$ is a splitting field for $A_{p}(E, E)$. By results above, we can get the cohomology $H^{*}\left(X, \mathbb{F}_{p}\right)$ (See Remark (3.6).

Let $G$ be a finite group with Sylow $p$-subgroup $E$. Then the multiplicity of $X$ in $B G$ is equal to the dimension of $S[G]$ where $[G]$ is an element of $A_{p}(E, E)$ corresponds to the $(E, E)$-biset $G$. See [1], [2], [11] for details.

In [15], the second author studied the splitting of $B G$ for various finite groups $G$ whose Sylow $p$-subgroup is $E$ and $p$-local finite groups on $E$. In this paper, we consider the stable splitting for groups related with the linear group $L_{3}(p)$ which were not treated in [15] in general. We use some simple $A_{p}(E, E)$-submodules of $H^{*}(E)$ and determine the multiplicity of summands in $B G$ for $G=L_{3}(p), L_{3}(p): 2, L_{3}(p) .3, L_{3}(p) . S_{3}$ (Theorem 4.17, 4.18, 4.19, 4.20).

Combining these results and results in [15], we have the complete information on the stable splitting of finite groups or $p$-local finite groups which have at least two $\mathcal{F}$-radical maximal elementary abelian $p$-subgroups in $E$, by the classification in [12], where $\mathcal{F}$ is a fusion system of $G$.

In particular, for $p=7$, we obtain a diagram which describes inclusions of some fusion systems and stable splitting (Theorem 4.23). This result supplements the results of 15, section 9], in which the splitting of sporadic simple groups are mainly studied.

In section 2, we review the main results of [7] which will be used in section 3. In section 3, we prove Theorem 1.1 and determine the structures of ideals $N$ and $\left(y_{1} v, y_{2} v\right) H^{*}(E)$. In section 4, we consider $H^{*}(G)$ and the stable splitting for finite group $G$ which has a Sylow $p$-subgroup $E$. Finally, in section 5 , we consider the case $p=3$ and state some remarks.

## 2. Preliminary results on $H^{*}(E)$

In this section, we quote some results from [7]. Let $p$ be an odd prime. Let

E=\left\langle a, b, c \mid[a, b]=c, a^{p}=b^{p}=c^{p}=[a, c]=[b, c]=1\right\rangle
$$

be the extraspecial $p$-group of order $p^{3}$ and exponent $p$. Let $A_{i}=\left\langle c, a b^{i}\right\rangle$ for $0 \leq i \leq p-1$ and $A_{\infty}=\langle c, b\rangle$. Then

\mathcal{A}(E)=\left\{A_{0}, A_{1}, \ldots, A_{p-1}, A_{\infty}\right\}
$$

is the set of all maximal elementary abelian $p$-subgroups of $E$.
The cohomology of $E$ is known by [8], [9], [15]. In particular, $H^{*}(E)=\left(\mathbb{F}_{p} \otimes\right.$ $\left.H^{*}(E, \mathbb{Z})\right) / \sqrt{(0)}$ is generated by

with

\operatorname{deg} y_{i}=2, \operatorname{deg} C=2 p-2, \operatorname{deg} v=2 p
$$

subject to the following relations:

y_{1}^{p} y_{2}-y_{1} y_{2}^{p}=0, C y_{i}=y_{i}^{p}, C^{2}=y_{1}^{2 p-2}+y_{2}^{2 p-2}-y_{1}^{p-1} y_{2}^{p-1}
$$

We set $V=v^{p-1}$ and $Y_{i}=y_{i}^{p-1}$.

Let $R$ be a subalgebra of $H^{*}(E)$ and $x_{1}, \ldots, x_{r}$ elements of $H^{*}(E)$. We set

R\left\{x_{1}, \ldots, x_{r}\right\}=\sum_{i=1}^{r} R x_{i}
$$

if $x_{1}, \ldots, x_{r}$ are linearly independent over $R$. Moreover, if $W=\sum_{i=1}^{r} \mathbb{F}_{p} x_{i}$ is a $\mathbb{F}_{p}$-vector space spanned by $x_{1}, \ldots, x_{r}$, then we set

R\{W\}=R\left\{x_{1}, \ldots, x_{r}\right\} .
$$

We consider the action of $\operatorname{Out}(E)=\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$ on $H^{*}(E)$. Let $S^{i}$ be the homogeneous part of degree $2 i$ in $\mathbb{F}_{p}\left[y_{1}, y_{2}\right]$. Then $p(p-1)$ simple $\mathbb{F}_{p} \operatorname{Out}(E)$-modules

S^{i} v^{q} \cong S^{i} \otimes(\operatorname{det})^{q} \quad(0 \leq i \leq p-1,0 \leq q \leq p-2)
$$

give the complete set of representatives of nonisomorphic simple $\mathbb{F}_{p} \operatorname{Out}(E)$-modules. Let us write

\mathbb{C} \mathbb{A}=\mathbb{F}_{p}[C, V]
$$

and

\mathbb{D} \mathbb{A}=\mathbb{F}_{p}\left[D_{1}, D_{2}\right]
$$

where $D_{1}=C^{p}+V, D_{2}=C V$. Then $\mathbb{C A}=H^{*}(E)^{\operatorname{Out}(E)}$, the Out $(E)$-invariants, and the restriction map induces an isomorphism

for all $A \in \mathcal{A}(E)$.
Let

T^{i}=\mathbb{F}_{p}\left\{y_{1}^{p-1} y_{2}^{i}, y_{1}^{p-2} y_{2}^{i+1}, \ldots, y_{1}^{i} y_{2}^{p-1}\right\}
$$

for $1 \leq i \leq p-2$. Then $S^{p-1+i}=C S^{i}+T^{i}$. The $\mathbb{F}_{p}$-subspace $C S^{i}$ is a $\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$-submodule of $C S^{i}+T^{i}$ and

\left(C S^{i}+T^{i}\right) / C S^{i} \cong\left(S^{p-1-i} \otimes \operatorname{det}^{i}\right)
$$

Moreover we have the following expression [7, Theorem 4.4]:

\left.H^{*}(E)=\mathbb{F}_{p}[C, v]\left\{\left(\bigoplus_{i=0}^{p-1} S^{i}\right) \oplus\left(\bigoplus_{i=1}^{p-2} T^{i}\right)\right\}=\mathbb{C} \mathbb{A}\left\{\bigoplus_{i=0}^{p-2} \bigoplus_{q=0}^{p-2}\left(S^{i} v^{q} \oplus T^{i} v^{q}\right)\right)\right\}
$$

where $S^{0}=\mathbb{F}_{p}$ and $T^{0}=S^{p-1}$.
Let $C_{p}$ be a cyclic group of order $p$ and let $U_{i}=H^{2 i}\left(C_{p}, \mathbb{F}_{p}\right)(0 \leq i \leq p-2)$. Then $U_{i}$ are simple $\mathbb{F}_{p} \operatorname{Out}\left(C_{p}\right)$-modules. Let $A \in \mathcal{A}(E)$ be a maximal elementary abelian $p$-subgroup of $E$. Let $S(A)^{i}=H^{2 i}(A)$. Then $S(A)^{i} \otimes \operatorname{det}^{q}(0 \leq i \leq p-1,0 \leq q \leq p-2)$ are simple modules for $\operatorname{Out}(A)=\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$.

Let $P$ be a general finite $p$-group and $A_{p}(P, P)$ the double Burnside algebra of $P$ over $\mathbb{F}_{p}$. The simple $A_{p}(P, P)$-modules corresponds to some pairs $(Q, V)$ where $Q \leq P$ and $V$ is a simple $\mathbb{F}_{p} \operatorname{Out}(Q)$-module, see [2], [4], [11]. In this paper, we denote the simple $A_{p}(P, P)$-module corresponds to the pair $(Q, V)$ by $S(P, Q, V)$.

On the other hand, Dietz and Pridy [5] studied the stable splitting of $B E$ and determined the multiplicity of each summand. In particular, their result implies the classification of simple $A_{p}(E, E)$-modules.

Proposition 2.1 ([5], [7, Proposition 10.1]). The simple $A_{p}(E, E)$-modules are given as follows:
(1) $S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right)$ for $0 \leq i \leq p-1,0 \leq q \leq p-2$,

\operatorname{dim} S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right)=i+1
$$

(2) $S\left(E, A, S(A)^{p-1} \otimes \operatorname{det}^{q}\right)$ for $0 \leq q \leq p-2$,

\operatorname{dim} S\left(E, A, S(A)^{p-1} \otimes \operatorname{det}^{q}\right)=p+1
$$

(3) $S\left(E, C_{p}, U_{i}\right)$ for $0 \leq i \leq p-2$,

$$
\operatorname{dim} S\left(E, C_{p}, U_{i}\right)= \begin{cases}p+1 & (i=0) \\ i+1 & (1 \leq i \leq p-2)\end{cases}
$$

(4) $S\left(E, 1, \mathbb{F}_{p}\right), \operatorname{dim} S\left(E, 1, \mathbb{F}_{p}\right)=1$.

To describe the composition factor of $H^{*}(E)$ as an $A_{p}(E, E)$-module, we need the following $\mathbb{F}_{p}$-subspace of $H^{*}(E)$.

Definition 2.2. Let $S$ be a simple $A_{p}(E, E)$-module. Let $\Gamma_{S}$ be the following $\mathbb{F}_{p}$-subspace of $H^{*}(E)$ :
(1) If $S=S\left(E, C_{p}, U_{i}\right)$, then

\Gamma_{S}=\left\{\begin{array}{lc}
\mathbb{F}_{p}[C]\left\{\mathbb{F}_{p} C+S^{p-1}\right\} & (i=0) \\
\mathbb{F}_{p}[C]\left\{S^{i}\right\} & (1 \leq i \leq p-2)
\end{array}\right.
$$

(2) If $S=S\left(E, A, S(A)^{p-1} \otimes \operatorname{det}^{q}\right)$, then

\mathbb{D} \mathbb{A}\left\{\oplus_{0 \leq j \leq p-1} v^{q} C^{j}\left(C S^{q}+T^{q}\right)\right\} & (1 \leq q \leq p-2)

\Gamma_{S}= \begin{cases}\mathbb{D} \mathbb{A}^{+} & \left(S=S\left(E, E, S^{0}\right)\right)  \tag{3}\\ \mathbb{C} \mathbb{A}\left\{v^{q}\right\} & \left(S=S\left(E, E, \operatorname{det}^{q}\right), 1 \leq q \leq p-2\right) \\ \mathbb{D} \mathbb{A}\left\{V S^{p-1}\right\} & \left(S=S\left(E, E, S^{p-1}\right)\right. \\ \mathbb{C} \mathbb{A}\left\{v^{q} S^{p-1}\right\} & \left(S=S\left(E, E, S^{p-1} \otimes \operatorname{det}^{q}\right), 1 \leq q \leq p-2\right)\end{cases}

(4) Let

for $1 \leq i \leq p-2,0 \leq q \leq p-2$, where $s \equiv i+q(\bmod p-1), 0 \leq s \leq p-2$. Let $\Gamma_{S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right)}$ be the following $\mathbb{F}_{p}$-subspace:

The following theorem is the main result of [7]. If $S$ is a simple $A_{p}(E, E)$-module, then there exists an idempotent $e_{S}$ such that $S e_{S}=S$ and $S^{\prime} e_{S}=0$ for any simple module $S^{\prime} \neq S$. We call $e_{S}$ an idempotent which corresponds to $S$.
Theorem 2.3 ([7, Theorem 10.2, 10.3, 10.4, 10.5]). Let $S$ be a simple $A_{p}(E, E)$-module. Then there exists an idempotent $e_{S}$ which corresponds to $S$ such that

H^{*}(E) e_{S}=\Gamma_{S} e_{S} \cong \Gamma_{S}
$$

If we see the minimal degree of non zero part of $\Gamma_{S}$, we have the following corollary.
Corollary 2.4. Every simple $A_{p}(E, E)$-module appears as a composition factor in $H^{2 n}(E)$ for some $n \leq(p+2)(p-1)$.

Let $\Gamma_{S}^{n}=\Gamma_{S} \cap H^{n}(E)$ be the degree $n$ part of $\Gamma_{S}$. Then by Theorem [2.3,

\sum_{S} \operatorname{dim} \Gamma_{S}^{n}=\operatorname{dim} H^{n}(E)
$$

for any $n \geq 0$. In fact we have the following.
Proposition 2.5. $H^{*}(E)$ is a direct sum of $\mathbb{F}_{p}$-subspaces $\Gamma_{S}$ where $S$ runs over the representatives of the isomorphism classes of simple $A_{p}(E, E)$-modules.
Proof. By Theorem [2.3, it suffices to show that $H^{*}(E)=\sum \Gamma_{S}$. We shall show that $\mathbb{C} \mathbb{A}\left\{S^{i} v^{q}\right\}(0 \leq i \leq p-1,0 \leq q \leq p-2)$ and $\mathbb{C} \mathbb{A}\left\{T^{i} v^{q}\right\}(1 \leq i \leq p-2,0 \leq q \leq p-2)$ are contained in $\sum \Gamma_{S}$.

First consider $\mathbb{C} \mathbb{A}\left\{S^{i} v^{q}\right\}$. If $(i, q)=(0,0)$,

& =\mathbb{F}\left[D_{1}\right] \oplus \mathbb{F}[C]\{C\} \oplus \sum_{j=0}^{p-1} \mathbb{D} \mathbb{A}\left\{D_{2} C^{j+1}\right\} \oplus \mathbb{D} \mathbb{A}\left\{D_{2}\right\} \\
& =\mathbb{D} \mathbb{A} \oplus \mathbb{F}[C]\{C\} \oplus \sum_{j=0}^{p-1} \mathbb{D} \mathbb{A}\left\{D_{2} C^{j+1}\right\}
\end{aligned}
$$

and this is contained in the sum of the subspaces of Definition 2.2(1)(2)(3)(5). If $(i, q)=$ $(0, q), 1 \leq q \leq p-2$, or $(i, q)=(p-1, q), 1 \leq q \leq p-2$, then $\mathbb{C} \mathbb{A} v^{q}$ and $\mathbb{C} \mathbb{A} S^{p-1} v^{q}$ are contained in the subspace of Definition 2.2 (3). If $(i, q)=(p-1,0)$, then

and we have

\mathbb{C} \mathbb{A}\left\{S^{p-1}\right\}=\mathbb{F}_{p}[C]\left\{S^{p-1}\right\} \oplus \mathbb{D} \mathbb{A}\left\{V S^{p-1}\right\} \oplus\left(\oplus_{j=0}^{p-1} \mathbb{D} \mathbb{A}\left\{D_{2} C^{j} S^{p-1}\right\}\right)
$$

This is contained in the sum of subspaces of Definition $2.2(1)(2)(3)$.
Consider $(i, q)(1 \leq i \leq p-2,0 \leq q \leq p-2)$. If $q=0$, then

\mathbb{C} \mathbb{A}\left\{S^{i}\right\}=\mathbb{F}_{p}[C]\left\{S^{i}\right\} \oplus \mathbb{C} \mathbb{A}\left\{V S^{i}\right\}
$$

and this is contained in the sum of subspaces of Definition 2.2 (1)(4). If $i=q$, then

\mathbb{C} \mathbb{A}\left\{S^{i} v^{i}\right\}=\mathbb{D} \mathbb{A}\left\{S^{i} v^{i}\right\} \oplus\left(\oplus_{j=0}^{p-1} \mathbb{D} \mathbb{A}\left\{C^{j+1} S^{i} v^{i}\right\}\right)
$$

and this is contained in the sum of the subspaces of Definition 2.2 (2)(4). If $q \neq 0$ and $i \neq q$, then $\mathbb{C} \mathbb{A}\left\{S^{i} v^{q}\right\}$ is contained in the subspace of Definition 2.2 (4).

Next, consider $T^{k} v^{m}(1 \leq k \leq p-2,0 \leq m \leq p-2)$. Let $i=p-k-1, q \equiv$ $m+k \bmod (p-1), 0 \leq q \leq p-2, s=m$. Then

T^{k} v^{m}=T^{p-i-1} v^{s}
$$

where $1 \leq i \leq p-2,0 \leq q \leq p-2, s \equiv i+q \bmod (p-1)$ and

$$
q+2 i \equiv m+k+2(p-k-1) \equiv m-k \bmod (p-1) .
$$

If $k \neq m$, then $q+2 i \not \equiv 0$ and $\mathbb{C}\left\{T^{k} v^{m}\right\}$ is contained in the subspace of Definition 2.2 (4). If $k=m$, then $q+2 i \equiv 0$ and

$$
\mathbb{C} \mathbb{A}\left\{T^{k} v^{m}\right\}=\mathbb{D} \mathbb{A}\left\{\oplus_{j=0}^{p-1} T^{k} C^{j} v^{m}\right\} \oplus \mathbb{D} \mathbb{A}\left\{T^{k} V v^{m}\right\}
$$

since $\mathbb{C} \mathbb{A}=\mathbb{D} \mathbb{A}\left\{1, C, \ldots, C^{p-1}, V\right\}$. This is contained in the sum of the subspaces of Definition 2.2 (2)(4).

## 3. Composition factors of $H^{*}\left(E, \mathbb{F}_{p}\right)$

In this section, we study the $A_{p}(E, E)$-module structure of $H^{*}\left(E, \mathbb{F}_{p}\right)$. First, we shall prove Theorem 1.1. The even degree part $H^{\text {even }}(E, \mathbb{Z})$ of integral cohomology ring is generated by

$$
y_{1}, y_{2}, b_{2}, \ldots, b_{p-2}, C, v
$$

with

$$
\operatorname{deg} y_{i}=2, \quad \operatorname{deg} b_{i}=2 i
$$

subject to the following relations:

$$
\begin{gathered}
p y_{i}=p b_{j}=p C=0, p^{2} v=0 \\
y_{1} y_{2}^{p}-y_{1}^{p} y_{2}=0 \\
y_{i} b_{k}=b_{k} b_{j}=C b_{j}=0 \\
y_{i} C=y_{i}^{p}, C^{2}=y_{1}^{2 p-2}+y_{2}^{2 p-2}-y_{1}^{p-1} y_{2}^{p-1}
\end{gathered}
$$

by [10] or [8, Theorem 3] (see [13] also). In particular, $p^{2}\left(H^{2 n}(E, \mathbb{Z})\right)=0$ for any $n>0$.
On the other hand, the odd degree part of integral cohomology ring $H^{\text {odd }}(E, \mathbb{Z})$ is annihilate by $p$ and so it is considered as an $\mathbb{F}_{p}\left[y_{1}, y_{2}, v\right]$-module. As an $\mathbb{F}_{p}\left[y_{1}, y_{2}, v\right]$ module, $H^{\text {odd }}(E, \mathbb{Z})$ is generated by two elements $a_{1}$ and $a_{2}$ with $\operatorname{deg} a_{i}=3$ subject to the following relations:

y_{1} a_{2}-y_{2} a_{1}=0, y_{1}^{p} a_{2}-y_{2}^{p} a_{1}=0
$$

Let $H^{*}(E, \mathbb{Z}) \longrightarrow H^{*}\left(E, \mathbb{F}_{p}\right)$ be the natural map induced by $\mathbb{Z} \longrightarrow \mathbb{F}_{p}$. We use the same letters for the images of $y_{i}, b_{j}, C, v$ in $H^{*}\left(E, \mathbb{F}_{p}\right)$. Then

$$
N=\mathbb{F}_{p}[v]\left\{b_{2}, \ldots, b_{p-2}\right\}=\sqrt{0}
$$

in

$$
H^{\text {even }}(E, \mathbb{Z}) / p H^{\text {even }}(E, \mathbb{Z})=\mathbb{F}_{p} \otimes_{\mathbb{Z}} H^{\text {even }}(E, \mathbb{Z})
$$

Since

$$
H^{*}(E)=\left(\mathbb{F}_{p} \otimes_{\mathbb{Z}} H^{*}(E, \mathbb{Z})\right) / \sqrt{0}=\left(\mathbb{F}_{p} \otimes_{\mathbb{Z}} H^{\text {even }}(E, \mathbb{Z})\right) / N
$$

there is a short exact sequence of $A_{p}(E, E)$-modules,

$$
\begin{equation*}
0 \longrightarrow N \longrightarrow H^{\text {even }}(E, \mathbb{Z}) / p H^{\text {even }}(E, \mathbb{Z}) \longrightarrow H^{*}(E) \longrightarrow 0 \tag{3.1}
\end{equation*}
$$

On the other hand, since $p H^{\text {odd }}(E, \mathbb{Z})=0$, there is a short exact sequence of $A_{p}(E, E)$ modules,

$$
\begin{equation*}
0 \longrightarrow H^{\text {even }}(E, \mathbb{Z}) / p H^{\text {even }}(E, \mathbb{Z}) \longrightarrow H^{\text {even }}\left(E, \mathbb{F}_{p}\right) \longrightarrow H^{\text {odd }}(E, \mathbb{Z})[-1] \longrightarrow 0 \tag{3.2}
\end{equation*}
$$

Let $\left(y_{1} v, y_{2} v\right) H^{\text {even }}(E, \mathbb{Z})$ (resp. $\left.\left(y_{1} v, y_{2} v\right) H^{*}(E)\right)$ be the ideal of $H^{\text {even }}(E, \mathbb{Z})$ (resp. $\left.H^{*}(E)\right)$ generated by $y_{1} v$ and $y_{2} v$. Since $p y_{i}=0$ and $y_{i} N=0$, it follows that

$$
\left(y_{1} v, y_{2} v\right) H^{\text {even }}(E, \mathbb{Z}) \cong\left(y_{1} v, y_{2} v\right) H^{*}(E)
$$

Here we use Milnor's primitive operator $Q_{1}=P^{1} \beta-\beta P^{1}$ on $H^{*}\left(-, \mathbb{F}_{p}\right)$. This operator induces a map $Q_{1}$ on $H^{*}(-, \mathbb{Z})$ such that the following diagram commutes:


Moreover, $Q_{1}$ induces an isomorphism of $A_{p}(E, E)$-modules,

$$
\begin{gathered}
Q_{1}: H^{\text {odd }}(E, \mathbb{Z}) \xrightarrow{\sim}\left(y_{1} v, y_{2} v\right) H^{\text {even }}(E, \mathbb{Z}) \cong\left(y_{1} v, y_{2} v\right) H^{*}(E) \\
Q_{1}\left(a_{i}\right)=y_{i} v
\end{gathered}
$$

(see [14, section 1]). Then we have

$$
\begin{equation*}
H^{o d d}(E, \mathbb{Z}) \cong\left(y_{1} v, y_{2} v\right) H^{*}(E)[-2 p+1] \tag{3.3}
\end{equation*}
$$

and the proof of the first part of Theorem 1.1 is completed by the exact sequences (3.1) and (3.2).

Next we consider the odd degree part $H^{\text {odd }}\left(E, \mathbb{F}_{p}\right)$. Let $K=\left\{x \in H^{\text {even }}(E, \mathbb{Z}) \mid p x=0\right\}$. Then there exists a short exact sequence of $A_{p}(E, E)$-modules,

$$

0 \longrightarrow H^{\text {odd }}(E, \mathbb{Z}) \longrightarrow H^{\text {odd }}\left(E, \mathbb{F}_{p}\right) \longrightarrow K[-1] \longrightarrow 0 \tag{3.4}
\end{equation*}
$$

Let $H=H^{\text {even }}(E, \mathbb{Z}) \cap H^{+}(E, \mathbb{Z})$. Since $p^{2} H=0, p H \subset K$. Moreover, $K, p H$ and $H / K$ are $A_{p}(E, E)$-modules.

Since the map $p: H \longrightarrow H$ is a homomorphism of $A_{\mathbb{Z}}(E, E)$-modules,

$$
H / K \cong p H
$$

as $A_{\mathbb{Z}}(E, E)$-modules. Since these are modules for $A_{p}(E, E)=A_{\mathbb{Z}}(E, E) / p A_{\mathbb{Z}}(E, E)$, these are isomorphic as $A_{p}(E, E)$-modules. Hence we have

$$
K \leftrightarrow p H \oplus K / p H \leftrightarrow H / K \oplus K / p H \leftrightarrow H / p H
$$

Moreover, since

H / p H=\mathbb{F}_{p} \otimes H \leftrightarrow N \oplus H^{+}(E)
$$

the proof of the second part of Theorem 1.1 is completed by (3.3) and (3.4).
Next we shall see the structure of $N$. Note that $\operatorname{res}_{A}^{E}\left(b_{i}^{\prime}\right)=0$ for any $i$ and any maximal elementary abelian $p$-subgroup $A$ of $E$. Since the action of $g \in \mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$ is given by

$$
g^{*}\left(b_{i}\right)=\operatorname{det}(g)^{i} b_{i}, g^{*}(v)=\operatorname{det}(g) v
$$

(see [8, Theorem 3]), $N$ is a direct sum of simple $A_{p}(E, E)$-modules isomorphic to $S\left(E, E, \operatorname{det}^{i}\right)$ for $0 \leq i \leq p-2$. Hence we have the following:

Proposition 3.1. Let

$$
N_{q}=\mathbb{F}_{p}\left\{v^{k} b_{i}^{\prime} \mid k \geq 0, k+i \equiv q \bmod (p-1)\right\}
$$

for $0 \leq q \leq p-2$. Then

N=\bigoplus_{0 \leq q \leq p-2} N_{q}
$$

and

N_{q} \cong \bigoplus S\left(E, E, \operatorname{det}^{q}\right)
$$

as $A_{p}(E, E)$-modules.
Next, we shall consider the structure of the ideal $\left(y_{1} v, y_{2} v\right) H^{*}(E)$. Let $I=\left(y_{1} v, y_{2} v\right) H^{*}(E)$. Let $\Gamma_{S}$ be the $\mathbb{F}_{p}$-subspace defined in Definition 2.2 for each simple $A_{p}(E, E)$-module $S$. We shall show that

$$
I e_{S} \cong I \cap \Gamma_{S}
$$

for an idempotent $e_{S}$ which corresponds to $S$ and determine the $\mathbb{F}_{p}$-subspace $I \cap \Gamma_{S}$ explicitly.

Lemma 3.2. Let

$$
L=\mathbb{F}_{p}\left[y_{1}, y_{2}, C\right] \oplus \mathbb{F}_{p}[V]\left\{v, \ldots, v^{p-2}, C v, \ldots, C v^{p-2}\right\} \oplus \mathbb{F}_{p}\left[D_{1}\right]\left\{D_{1}\right\} \oplus \mathbb{F}_{p}\left[D_{1}\right]\left\{D_{2}\right\}
$$

where $\mathbb{F}_{p}\left[y_{1}, y_{2}, C\right]$ is the subalgebra of $H^{*}(E)$ generated by $y_{1}, y_{2}$ and $C$. Then

H^{*}(E)=I \oplus L
$$

Proof. Let $\left(y_{1}, y_{2}, C\right)$ be the ideal of $H^{*}(E)$ generated by $y_{1}, y_{2}$ and $C$. Since

D_{1}=C^{p}+V \equiv V \bmod \left(y_{1}, y_{2}, C\right)
$$

we have

\begin{aligned}
H^{*}(E) & =\mathbb{F}_{p}[v] \oplus\left(y_{1}, y_{2}, C\right) \\
& =\mathbb{F}_{p} \oplus \mathbb{F}_{p}[V]\left\{v, \ldots, v^{p-2}\right\} \oplus \mathbb{F}[V]\{V\} \oplus\left(y_{1}, y_{2}, C\right) \\
& =\mathbb{F}_{p} \oplus \mathbb{F}_{p}[V]\left\{v, \ldots, v^{p-2}\right\} \oplus \mathbb{F}\left[D_{1}\right]\left\{D_{1}\right\} \oplus\left(y_{1}, y_{2}, C\right)
\end{aligned}
$$

On the other hand, since

$$
D_{2} D_{1}=C V\left(C^{p}+V\right) \equiv D_{2} V \bmod I
$$

it follows that

$$
\begin{aligned}
& \mathbb{F}_{p} \oplus\left(y_{1}, y_{2}, C\right) \\
= & \mathbb{F}_{p}\left[y_{1}, y_{2}, C\right] \oplus \mathbb{F}_{p}[v]\{C v\} \oplus I \\
= & \mathbb{F}_{p}\left[y_{1}, y_{2}, C\right] \oplus \mathbb{F}_{p}[V]\left\{C v, \ldots, C v^{p-2}\right\} \oplus \mathbb{F}_{p}[V]\{C V\} \oplus I \\
= & \mathbb{F}_{p}\left[y_{1}, y_{2}, C\right] \oplus \mathbb{F}_{p}[V]\left\{C v, \ldots, C v^{p-2}\right\} \oplus \mathbb{F}_{p}\left[D_{1}\right]\left\{D_{2}\right\} \oplus I
\end{aligned}
$$

and we have $H^{*}(E)=I \oplus L$.
Lemma 3.3. For each simple $A_{p}(E, E)$-module $S$, we have

$$
\Gamma_{S}=\left(I \cap \Gamma_{S}\right) \oplus\left(L \cap \Gamma_{S}\right)
$$

where $I=\left(y_{1} v, y_{2} v\right) H^{*}(E)$ and $L$ is an $\mathbb{F}_{p}$-subspace defined in Lemma 3.2. Moreover,
(1) If $S=S\left(E, C_{p}, U_{i}\right)$, then $I \cap \Gamma_{S}=0$.
(2) If $S=S\left(E, A, S^{p-1} \otimes \operatorname{det}^{q}\right)$, then

I \cap \Gamma_{S}=\Gamma_{S}=\left\{\begin{array}{cc}
\mathbb{D} \mathbb{A}\left\{\bigoplus_{0 \leq j \leq p-1} D_{2} C^{j}\left(\mathbb{F}_{p} C+S^{p-1}\right)\right\} \\
\mathbb{D} \mathbb{A}\left\{\bigoplus_{0 \leq j \leq p-1} v^{q} C^{j}\left(C S^{q}+T^{q}\right)\right\} & (1 \leq q \leq p) \\
\hline q-2)
\end{array}\right.
$$

$$
I \cap \Gamma_{S}= \begin{cases}\mathbb{D} \mathbb{A}\left\{D_{2}^{2}\right\} & \left(S=S\left(E, E, S^{0}\right)\right)  \tag{3}\\ \left.\mathbb{C} A A^{2} v^{q}\right\} & \left(S=S\left(E, E, \operatorname{det}^{q}\right), 1 \leq q \leq p-2\right) \\ \mathbb{D} \mathbb{A}\left\{V S^{p-1}\right\} & \left(S=S\left(E, E, S^{p-1}\right)\right) \\ \mathbb{C} \mathbb{A}\left\{v^{q} S^{p-1}\right\} & \left(S=S\left(E, E, S^{p-1} \otimes \operatorname{det}^{q}\right), 1 \leq q \leq p-2\right)\end{cases}
$$

(4) Let

S=S^{i} v^{q}, \quad T=T^{p-i-1} v^{s}

for $1 \leq i \leq p-2,0 \leq q \leq p-2$, where $s \equiv i+q(\bmod p-1), 0 \leq s \leq p-2$. Then $I \cap \Gamma_{S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right)}$ is the following $\mathbb{F}_{p}$-subspace:

(2) If $S=S\left(E, A, S^{p-1} \otimes \operatorname{det}^{q}\right)(0 \leq q \leq p-2)$, then $\Gamma_{S} \subset I$ since $D_{2} C=C^{2} V \in I$.
(3) If $S=S\left(E, E, S^{0}\right)$, then $\Gamma_{S}=\mathbb{D} \mathbb{A}^{+}$,

\mathbb{D}^{+}=\mathbb{D} \mathbb{A}\left\{D_{2}^{2}\right\} \oplus \mathbb{F}_{p}\left[D_{1}\right]\left\{D_{1}, D_{2}\right\}

Since $\mathbb{D} \mathbb{A}\left\{D_{2}^{2}\right\} \subset I$ and $\mathbb{F}_{p}\left[D_{1}\right]\left\{D_{1}, D_{2}\right\} \subset L$, we have

\mathbb{D} \mathbb{A}^{+}=\left(I \cap \Gamma_{S}\right) \oplus\left(L \cap \Gamma_{S}\right)
$$

and $I \cap \Gamma_{S}=\mathbb{D} \mathbb{A}\left\{D_{2}^{2}\right\}$.
If $S=S\left(E, E, \operatorname{det}^{q}\right)(1 \leq q \leq p-2)$, then $\Gamma_{S}=\mathbb{C} \mathbb{A}\left\{v^{q}\right\}$,

$$
\mathbb{C} \mathbb{A}\left\{v^{q}\right\}=\mathbb{C} \mathbb{A}\left\{C^{2} v^{q}\right\} \oplus \mathbb{F}_{p}[V]\left\{v^{q}, C v^{q}\right\} .
$$

Since $C^{2} v^{q} \in I$ and $\mathbb{F}_{p}[V]\left\{v^{q}, C v^{q}\right\} \subset L$, it follows that

$$
\mathbb{C} \mathbb{A}\left\{v^{q}\right\}=\left(I \cap \Gamma_{S}\right) \oplus\left(L \cap \Gamma_{S}\right)
$$

and $I \cap \Gamma_{S}=\mathbb{C} \mathbb{A}\left\{C^{2} v^{q}\right\}$.
If $S=S\left(E, E, S^{p-1}\right)$, then $\Gamma_{S}=\mathbb{D} \mathbb{A}\left\{V S^{p-1}\right\}$. If $S=S\left(E, E, S^{p-1} \otimes \operatorname{det}^{q}\right)(1 \leq q \leq$ $p-2), \Gamma_{S}=\mathbb{C} \mathbb{A}\left\{v^{q} S^{p-1}\right\}$. In these cases, $\Gamma_{S} \subset I$.
(4) Let $S=S^{i} v^{q}(1 \leq i \leq p-2,0 \leq q \leq p-2)$. If $q=0$ then $S V \subset I$. If $q \neq 0$ then $S \subset I$. Hence the first term of $\Gamma_{S}$ is contained in $I$.

Let $T=T^{p-i-1} v^{s}, s \equiv i+q \bmod (p-1), 0 \leq s \leq p-2$. If $s \equiv 0$, then $V T \subset I$. If $i+q \not \equiv 0$, then $T \subset I$. Hence the second term of $\Gamma_{S}$ is contained in $I$ unless $i=q, 3 i \not \equiv$ $0,2 i \equiv 0$, or $q \neq 0, i \neq q, q+2 i \not \equiv 0, i+q \equiv 0$. In these cases,

$$
\mathbb{C} \mathbb{A}\{T\}=\mathbb{F}_{p}[C]\{T\} \oplus \mathbb{C} \mathbb{A}\{V T\}
$$

where $\mathbb{C} \mathbb{A}\{V T\} \subset I, \mathbb{F}_{p}[C]\{T\} \subset L$. Hence

$$
\mathbb{C} \mathbb{A}\{T\}=\mathbb{C} \mathbb{A}\{T\} \cap I \oplus \mathbb{F}_{p}[C]\{T\} \cap I
$$

and $\mathbb{C} \mathbb{A}\{T\} \cap I=\mathbb{C} \mathbb{A}\{V T\}$.
Lemma 3.4. Let $I=\left(y_{1} v, y_{2} v\right) H^{*}(E)$. Then

$$
I=\bigoplus_{S}\left(I \cap \Gamma_{S}\right)
$$

Proof. First, $H^{*}(E)=\oplus_{S} \Gamma_{S}=I \oplus L$ by Proposition 2.5 and Lemma 3.2. On the other hand,

$$
\Gamma_{S}=\left(I \cap \Gamma_{S}\right) \oplus\left(L \cap \Gamma_{S}\right)
$$

by Lemma 3.3. Hence

$$
\begin{aligned}
H^{*}(E) & =\oplus \Gamma_{S}=\oplus\left(\left(I \cap \Gamma_{S}\right) \oplus\left(L \cap \Gamma_{S}\right)\right) \\
& =\left(\oplus\left(I \cap \Gamma_{S}\right)\right) \oplus\left(\oplus\left(L \cap \Gamma_{S}\right)\right) \subset I \oplus L=H^{*}(E)
\end{aligned}
$$

Hence we have

$$
I=\bigoplus_{S}\left(I \cap \Gamma_{S}\right)
$$

Now, we determine the $\mathbb{F}_{p}$-vector space $I e_{S}$ for any simple $A_{p}(E, E)$-module $S$.
Theorem 3.5. Let $S$ be a simple $A_{p}(E, E)$-module. Then there exists an idempotent $e_{S}$ corresponding to $S$ such that

$$
I e_{S}=\left(I \cap \Gamma_{S}\right) e_{S} \cong I \cap \Gamma_{S}
$$

Proof. By Theorem 2.3, $\Gamma_{S} \cong \Gamma_{S} e_{S}$ for some idempotent corresponding to $S$. Hence $e_{S}$ induces an isomorphism

$$
I \cap \Gamma_{S} \cong\left(I \cap \Gamma_{S}\right) e_{S}
$$

For a graded $\mathbb{F}_{p}$-subspace $M \subset H^{*}(E)$, let $M^{n}=H^{n}(E) \cap M$. Then

$$
\begin{aligned}
\operatorname{dim} I^{n} & =\sum_{S} \operatorname{dim}\left(I^{n}\right) e_{S} \geq \sum_{S} \operatorname{dim}\left(I^{n} \cap \Gamma_{S}\right) e_{S} \\
& =\sum_{S} \operatorname{dim} I^{n} \cap \Gamma_{S}=\operatorname{dim} I^{n}
\end{aligned}
$$

The last equality follows from Lemma 3.4. Hence we have

$$
I e_{S}=\left(I \cap \Gamma_{S}\right) e_{S}
$$

Remark 3.6. Let $X$ be the indecomposable summand in the complete stable splitting of $B E$ which corresponds to a simple $A_{p}(E, E)$-modules $S$. Let $e_{S}$ be an idempotent which correspond to $S$ as above. Then we can get the $\mathbb{F}_{p}$-vector space

$$
H^{*}\left(E, \mathbb{F}_{p}\right) e_{S} \cong H^{*}\left(\vee X, \mathbb{F}_{p}\right) \cong \stackrel{d}{\bigoplus} H^{*}\left(X, \mathbb{F}_{p}\right)
$$

where $\vee X$ is a wedge sum of $d=\operatorname{dim} S$ copies of $X$, from Theorem 1.1, Proposition 3.1 and Theorem 3.5.

Corollary 3.7. Every simple $A_{p}(E, E)$-module appears as a composition factor in $H^{2 n}\left(E, \mathbb{F}_{p}\right)$ for some $n \leq p^{2}-2$.
Proof. Let $H\left(p^{2}-2\right)=\oplus_{n=0}^{p^{2}-2} H^{2 n}\left(E, \mathbb{F}_{p}\right)$. For a simple $A_{p}(E, E)$-module $S$, let $2 \gamma(S)$ be the lowest degree such that $\left(\Gamma_{S} \cap I\right)^{2 \gamma(S)} \neq 0$. If $2 \gamma(S) \leq 2(p+2)(p-1)$, then $2(\gamma(S)-p) \leq 2\left(p^{2}-2\right)$. Since $S$ appears in the degree $2(\gamma(S)-p)$ part of $I[-2 p]$, it follows that $S$ appears in $H^{2(\gamma(S)-p)}\left(E, \mathbb{F}_{p}\right)$ by Theorem [1.1. Hence $S$ appears in $H\left(p^{2}-2\right)$. In particular, if $\Gamma_{S} \leq I$, then $S$ appears in $H\left(p^{2}-2\right)$ by Corollary 2.4. This implies that simple modules

$$
S\left(E, A, S(A)^{p-1} \otimes \operatorname{det}^{q}\right)(0 \leq q \leq p-2), S\left(E, E, S^{p-1} \otimes \operatorname{det}^{q}\right)(0 \leq q \leq p-2)
$$

appear in $H\left(p^{2}-2\right)$.
On the other hand, since the degrees of $C^{2} v^{q},(1 \leq q \leq p-2)$ and $V S^{i}, S^{i} v^{q},(1 \leq i \leq$ $p-2,0 \leq q \leq p-2)$ are all smaller than $\operatorname{deg} D_{2} S^{p-1}=2(p+2)(p-1)$, we have that $S\left(E, E, \operatorname{det}^{q}\right),(1 \leq q \leq p-2)$ and $S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right),(1 \leq i \leq p-2,0 \leq q \leq p-2)$ appear in $H\left(p^{2}-2\right)$.

Moreover, since $S\left(E, C_{p}, U_{i}\right)(0 \leq i \leq p-2)$ appears in $H^{2}(E) \oplus \cdots \oplus H^{2(p-1)}(E)$, it appears in $H\left(p^{2}-2\right)$. Finally, we consider $S\left(E, E, S^{0}\right)$. Since it appears in $H^{2 p(p-1)}(E)$ and $2 p(p-1)\left(=\operatorname{deg} D_{1}\right) \leq 2\left(p^{2}-2\right), S\left(E, E, S^{0}\right)$ appears in $H\left(p^{2}-2\right)$. This completes the proof.

## 4. Stable splitting of groups Related to $L_{3}(p)$

In this section, we consider the stable splitting of $B G$ for groups $G$ having $E$ as a Sylow $p$-subgroup, in particular the linear group $L_{3}(p)$ and its extensions.

Benson and Fechbach [2], Martino and Priddy [11] prove the following theorem on complete stable splitting. Let $P$ be a finite $p$-group. If $G$ is a finite group which contains $E$, then $G$ is considered as an $(E, E)$-biset. We denote by $[G]$ the element of $A_{p}(E, E)$ corresponding to $G$. Let $S(P, Q, V)$ be the simple $A_{p}(P, P)$-module which corresponds to $(Q, V)$ where $Q$ is a subgroup of $P$ and $V$ is a simple $\mathbb{F}_{p} \operatorname{Out}(P)$-module.
Theorem 4.1 ([2], [11]). Let $G$ be a finite group with Sylow p-subgroup P. The complete stable splitting of $B G$ is given by

$$
B G \sim \bigvee_{(Q, V)} \operatorname{dim}(S(G, Q, V)) X_{S(P, Q, V)}
$$

where $S(G, Q, V)=S(P, Q, V)[G]$.
Let

$$
H^{*}(G)=\left(\mathbb{F}_{p} \otimes H^{*}(G, \mathbb{Z})\right) / \sqrt{(0)}
$$

for a finite group $G$. From Corollary 2.4 and Corollary 3.7, we have the following.

Corollary 4.2. Let $G_{1}, G_{2}$ have the same p-Sylow subgroup E. Suppose that $G_{1} \leq G_{2}$. (1) If

$$
\operatorname{dim} H^{2 n}\left(G_{1}\right)=\operatorname{dim} H^{2 n}\left(G_{2}\right)
$$

for all $0 \leq n \leq(p+2)(p-1)$, then $B G_{1} \sim B G_{2}$.
(2) If

$$
\operatorname{dim} H^{2 n}\left(G_{1}, \mathbb{F}_{p}\right)=\operatorname{dim} H^{2 n}\left(G_{2}, \mathbb{F}_{p}\right)
$$

for all $0 \leq n \leq p^{2}-2$, then $B G_{1} \sim B G_{2}$.
In general, the computation of these $\operatorname{dim} S(G, Q, V)$ is not so easy. Hence we study the way to compute it from the information on the cohomology $H^{*}(G)$. (In fact, in [15], most direct summands in the stable splitting of $B G$ are computed from $H^{*}(G)$.)

Let $\mathcal{F}_{G}$ be the fusion system on $E$ determined by $G$. Let $\mathcal{F}_{G}^{e c}$-rad be the set of $\mathcal{F}_{G}^{e c}-$ radical maximal elementary abelian $p$-subgroups of $E$. If $A$ is a maximal elementary abelian $p$-subgroup of $E$, then $A \in \mathcal{F}_{G}^{e c}$-rad if and only if $W_{G}(A)=N_{G}(A) / C_{G}(A)=$ $\operatorname{Out}_{\mathcal{F}_{G}}(A) \geq S L_{2}\left(\mathbb{F}_{p}\right)$ by [12, Lemma 4.1]. Let $W_{G}(E)=N_{G}(E) / E C_{G}(E)=\operatorname{Out}_{\mathcal{F}_{G}}(E)$.
Theorem 4.3 ([13, Theorem 4.3],[15, Theorem 3.1]). Let $G$ have the Sylow p-subgroup $E$, then

$$
H^{*}(G) \cong H^{*}(E)[G]=H^{*}(E)^{W_{G}(E)} \cap\left(\cap_{A \in \mathcal{F}_{G}^{e c}-\operatorname{rad}}\left(\operatorname{res}_{A}^{E}\right)^{-1}\left(H^{*}(A)^{W_{G}(A)}\right)\right)
$$

Moreover, if $M$ is an $A_{p}(E, E)$-submodule of $H^{*}(E)$, then

$$
M[G]=M^{W_{G}(E)} \cap\left(\cap_{A \in \mathcal{F}_{G}^{e c}-\operatorname{rad}}\left(\operatorname{res}_{A}^{E}\right)^{-1}\left(H^{*}(A)^{W_{G}(A)}\right)\right)
$$

Proof. The first part follows from Alperin's fusion theorem ([3, Theorem A.10]). Let $M$ be an $A_{p}(E, E)$-submodule of $H^{*}(E)$. Since $[G][G] \in \mathbb{F}_{p}[G]$, it follows that $M[G]=$ $M \cap H^{*}(E)[G]$. Hence the result follows from the first part.

Let $X_{i, q}$ be the indecomposable summand in the stable splitting of $B E$ which corresponds to the simple $A_{p}(E, E)$-module $S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right)$. For $0 \leq q \leq p-2$, let $L(2, q)$ (resp. $L(1, q)$ ) be the summand which corresponds to the simple $A_{p}(E, E)$-module $S\left(E, A, S(A)^{p-1} \otimes \operatorname{det}^{q}\right)\left(\right.$ resp. $\left.S\left(E, C_{p}, U_{q}\right)\right)$. We set $M(2)=L(1,0) \vee L(2,0)$.

Suppose that the stable splitting of $B G$ is written as

$$
B G \sim\left(\vee_{i, q} n(G)_{i, q} X_{i, q}\right) \vee\left(\vee_{q} m(G, 2)_{q} L(2, q)\right) \vee\left(\vee_{q} m(G, 1)_{q} L(1, q)\right)
$$

Recall that

$$
H^{2 q}(E) \cong \begin{cases}S\left(E, C_{p}, U_{i}\right) & (1 \leq q \leq p-2) \\ S\left(E, C_{p}, U_{0}\right) & (q=p-1)\end{cases}
$$

by Theorem 2.3. Hence,
Lemma 4.4 ([15, Corollary 4.6]). The multiplicity $m(G, 1)_{q}$ for $L(1, q)$ is given by

$$
m(G, 1)_{q}= \begin{cases}\operatorname{dim} H^{2 q}(G) & (1 \leq q \leq p-2) \\ \operatorname{dim} H^{2(p-1)}(G) & (q=0)\end{cases}
$$

The multiplicity $n(G)_{i, q}$ of $X_{i, q}$ depends only on $W_{G}(E)=N_{G}(E) / E C_{G}(E)$. For $H \leq$ $\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$ and $\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$-submodule $M$ of $H^{*}(E)$, let

$$
M^{H}=\{m \in M \mid m h=m \text { for any } h \in H\}
$$

denotes the subspace consists of $H$-invariant elements. Then we have the following lemma.

Lemma 4.5 ([15], Lemma 4.7]). The multiplicity $n(G)_{i, q}$ of $X_{i, q}$ in $B G$ is given by

$$
n(G)_{i, q}=\operatorname{dim}\left(S^{i} v^{q}\right)^{W_{G}(E)}
$$

Next problem is to seek the multiplicity $m(G, 2)_{q}$ for the summand $L(2, q)$ in $B G$. We can prove,

Lemma 4.6 ([15, Proposition 4.9]). The multiplicity of $L(2,0)$ in $B G$ is given by

$$
m(G, 2)_{0}=\sharp_{G}(A)-\sharp_{G}\left(F^{e c} A\right)
$$

where $\sharp_{G}(A)\left(r e s p . \sharp_{G}\left(F^{e c} A\right)\right)$ is the number of $G$-conjugacy classes of rank two elementary abelian p-subgroups in $E$ (resp. subgroups in $\mathcal{F}_{G}^{e c}$-rad).

Lemma 4.7 ([15, Corollary 4.10]). The multiplicity of $L(1,0)$ in $B G$ is given by

$$
m(G, 1)_{0}=\operatorname{dim} H^{2(p-1)}(G)=\sharp_{G}(A)-\sharp_{G}\left(F^{e c} A\right) .
$$

Remark 4.8. By Lemma 4.6 and 4.7, $m(G, 1)_{0}=m(G, 2)_{0}$, namely, $L(1,0)$ and $L(2,0)$ always appear in $B G$ as $M(2)=L(1,0) \vee L(2,0)$. On the other hand, in Corollary 2.4, all simple modules except for $S\left(E, A, S^{p-1}\right)$ appear in $H^{2 n}(E)$ for $n \leq p^{2}-1$. Note that the minimal $n$ such that $S\left(E, E, S^{p-1}\right)$ appears in $H^{2 n}(E)$ is $p^{2}-1=\frac{1}{2} \operatorname{deg}\left(V S^{p-1}\right)$. Hence we may replace the bound $(p+2)(p-1)$ by $p^{2}-1$ in Corollary 4.2 (1).

For the number $m(G, 2)_{q}$ for $q \neq 0$, it seems that there is not a good way to find it. However we give some condition such that $m(G, 2)_{q}=0$.

Lemma 4.9 ([15, Lemma 4.11]). Let $\xi \in \mathbb{F}_{p}^{*}$ be a primitive $(p-1)$-th root of 1 . Suppose that $G \supset E:\langle\operatorname{diag}(\xi, \xi)\rangle$. If $\xi^{3 k} \neq 1$, then $B G$ does not contain the summand $L(2, k)$, i.e., $m(G, 2)_{k}=0$.

Let $\xi$ be the multiplicative generator of $\mathbb{F}_{p}^{*}$ as above. Let

$$
w=\left(\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right) \in \mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)
$$

Let

$$
T=\langle\operatorname{diag}(\xi, \xi), \operatorname{diag}(\xi, 1)\rangle
$$

be a torus in $\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$. Then $w$ normalizes $T$. Let $T\langle w\rangle$ be the semidirect product of $T$ by $\langle w\rangle$

Lemma 4.10. Assume that $1 \leq l \leq p-1,0 \leq k \leq p-2$. Then

$$
\left(S^{l} v^{k}\right)^{T}= \begin{cases}\mathbb{F}_{p} y_{1}^{i} y_{2}^{i} v^{p-1-i} & \left(l=2 i, k=p-1-i, 1 \leq i \leq \frac{p-1}{2}\right) \\ \mathbb{F}_{p} y_{1}^{p-1} \oplus \mathbb{F}_{p} y_{2}^{p-1} & (l=p-1, k=0) \\ 0 & (\text { otherwise })\end{cases}
$$

and

$$
\left(S^{l} v^{k}\right)^{T\langle w\rangle}= \begin{cases}\mathbb{F}_{p} y_{1}^{2 j} y_{2}^{2 j} v^{p-1-2 j} & \left(l=4 j, k=p-1-2 j, 1 \leq j \leq \frac{p-1}{4}\right) \\ \mathbb{F}_{p}\left(y_{1}^{p-1}+y_{2}^{p-1}\right) & (l=p-1, k=0) \\ 0 & (\text { otherwise })\end{cases}
$$

Proof. We consider the action of $\operatorname{diag}(\xi, 1)$ and $\operatorname{diag}(1, \xi)$. For $0 \leq i \leq l$, we have

$$
\begin{gathered}
\operatorname{diag}(\xi, 1) y_{1}^{i} y_{2}^{l-i} v^{k}=\xi^{i+k} y_{1}^{i} y_{2}^{l-i} v^{k} \\
\operatorname{diag}(1, \xi) y_{1}^{i} y_{2}^{l-i} v^{k}=\xi^{l-i+k} y_{1}^{i} y_{2}^{l-i} v^{k}
\end{gathered}
$$

Hence $y_{1}^{i} y_{2}^{l-i} v^{k}$ is $T$-invariant if and only if $i+k \equiv l-i+k \equiv 0 \bmod p-1$, namely, $l \equiv 2 i$ $\bmod p-1$ and $i+k \equiv 0 \bmod p-1$. If $k=0$, then $i=0, p-1, l=p-1$. If $k>0$, then $i=p-1-k, l=2 i$. Since $1 \leq l \leq p-1$, it follows that $i \leq \frac{p-1}{2}$.

Next consider the action of $w$. Since $w$ interchanges $y_{1}$ and $y_{2}, w v=-v, y_{1}^{i} y_{2}^{i} v^{p-1-i}$ is $w$-invariant if and only if $i$ is even.

Now assume that $p-1=3 m$. Note that $m$ is even. We set

$$
H=\left\langle\operatorname{diag}(\xi, \xi), \operatorname{diag}\left(\xi^{3}, 1\right)\right\rangle
$$

Then $w$ normalizes $H$. Let $H\langle w\rangle$ be the semidirect product of $H$ by $\langle w\rangle$.
Lemma 4.11. Assume that $p-1=3 m$. Let $m=2 n$. Assume that $1 \leq l \leq p-1$, $0 \leq k \leq p-2$. Then $\left(S^{l} v^{k}\right)^{H}$ is equal to the following vector space.

$$
\begin{cases}\mathbb{F}_{p}\left\{y_{1}^{p-1}, y_{1}^{2 m} y_{2}^{m}, y_{1}^{m} y_{2}^{2 m}, y_{2}^{p-1}\right\} & (l=p-1, k=0) \\ \mathbb{F}_{p}\left\{y_{1}^{i-n} y_{2}^{i+n} v^{3 n-i}, y_{1}^{i+n} y_{2}^{i-n} v^{3 n-i}\right\} & (l=2 i, k=3 n-i, n \leq i<3 n) \\ \mathbb{F}_{p}\left\{y_{1}^{i} y_{2}^{i} v^{3 m-i}\right\} & (l=2 i, k=(p-1)-i, 1 \leq i<m) \\ \mathbb{F}_{p}\left\{y_{1}^{i-m} y_{2}^{i+m} v^{3 m-i}, y_{1}^{i} y_{2}^{i} v^{3 m-i}, y_{1}^{i+m} y_{2}^{i-m} v^{3 m-i}\right\} & (l=2 i, k=(p-1)-i, m \leq i \leq 3 n) \\ 0 & \\ & \text { (otherwise) }\end{cases}
$$

Proof. We consider the action of $\operatorname{diag}(\xi, \xi)$ and $\operatorname{diag}\left(\xi^{3}, 1\right)$ on $y_{1}^{j} y_{2}^{l-j} v_{k}$ for $0 \leq j \leq l$. Since

$$
\operatorname{diag}(\xi, \xi) y_{1}^{j} y_{2}^{l-j} v^{k}=\xi^{l+2 k} y_{1}^{j} y_{2}^{l-j} v^{k}
$$

and

$$
\operatorname{diag}\left(\xi^{3}, 1\right) y_{1}^{j} y_{2}^{l-j} v^{k}=\xi^{3 j+3 k} y_{1}^{j} y_{2}^{l-j} v^{k}
$$

$y_{1}^{j} y_{2}^{l-j} v^{k}$ is $H$-invariant if and only if

$$
\begin{cases}l+2 k \equiv 0 & \bmod p-1 \\ j+k \equiv 0 & \bmod m\end{cases}
$$

Note that the condition $l+2 k \equiv 0 \bmod p-1$ implies that $l$ is even, so we set $l=2 i$, $1 \leq i \leq 3 n$. Then $y_{1}^{j} y_{2}^{l-j} v^{k} \in\left(S^{l} v^{k}\right)^{H}$ if and only if

$$
\begin{cases}i+k \equiv 0 & \bmod 3 n \\ j+k \equiv 0 & \bmod m\end{cases}
$$

Since $0 \leq k \leq p-2, k \equiv-i \bmod 3 n$ if and only if

$$
k=3 n-i \text { or }(p-1)-i
$$

First, assume $k=3 n-i$. Then $j \equiv-k=i-3 n \bmod m$ if and only if $j=i+s n$ for some integer $s \in \mathbb{Z}$ such that $s \equiv 1 \bmod 2$. Then

$$
\begin{aligned}
0 \leq j \leq l=2 i & \Longleftrightarrow 0 \leq i+s n \leq 2 i \\
& \Longleftrightarrow-i \leq s n \leq i \\
& \Longleftrightarrow|s| \leq \frac{i}{n}
\end{aligned}
$$

If $1 \leq i<n$, namely, $\frac{i}{n}<1$, then there is no $s \in \mathbb{Z}$ such that $|s| \leq \frac{i}{n}$ with $s \equiv 1 \bmod 2$.
Assume that $n \leq i \leq 3 n$. If $i=3 n$, namely, $l=p-1$ and $k=0$, then, since $\frac{i}{n}=3$, $|s| \leq \frac{i}{n}$ if and only if $s=-3,-1,1,3$. Then

$$
j=i+s n=(3+s) n=0, m, 2 m, 3 m .
$$

If $n \leq i<3 n$, namely, $1 \leq \frac{i}{n}<3$, then $|s| \leq \frac{i}{n}$ if and only if $s=-1,1$ since $s \equiv 1$ $\bmod 2$. So we have

$$
j=i+s n=i \pm n
$$

Next we consider the case $k=(p-1)-i$. Then,

$$
j \equiv-k=i-(p-1) \quad \bmod m
$$

if and only if $j=i+s m$ for some $s \in \mathbb{Z}$. Then,

$$
\begin{aligned}
0 \leq j=i+s m \leq l=2 i & \Longleftrightarrow-i \leq s m \leq i \\
& \Longleftrightarrow|s| \leq \frac{i}{m} .
\end{aligned}
$$

If $1 \leq i<m$, then this implies $s=0$ and $j=i$. If $m \leq i \leq 3 n$, namely, $1 \leq \frac{i}{m} \leq \frac{3}{2}<2$, then this implies $s=0, \pm 1$. Hence we have $j=i, i \pm m$. This completes the proof.

Lemma 4.12. Assume that $p-1=3 m$. Let $m=2 n$. Assume that $1 \leq l \leq p-1$, $0 \leq k \leq p-2$. Then $\left(S^{l} v^{k}\right)^{H\langle w\rangle}$ is equal to the following vector space.

$$
\begin{cases}\mathbb{F}_{p}\left\{y_{1}^{p-1}+y_{2}^{p-1}, y_{1}^{2 m} y_{2}^{m}+y_{1}^{m} y_{2}^{2 m}\right\} & (l=p-1, k=0) \\ \mathbb{F}_{p}\left\{\left(y_{1}^{i-n} y_{2}^{i+n}+(-1)^{3 n-i} y_{1}^{i+n} y_{2}^{i-n}\right) v^{3 n-i}\right\} & (l=2 i, k=3 n-i, n \leq i<3 n) \\ \mathbb{F}_{p}\left\{y_{1}^{i} y_{2}^{i} v^{3 m-i}\right\} & (l=2 i, k=(p-1)-i, 1 \leq i<m, i: \text { even }) \\ \mathbb{F}_{p}\left\{\left(y_{1}^{i-m} y_{2}^{i+m}+y_{1}^{i+m} y_{2}^{i-m}\right) v^{3 m-i}, y_{1}^{i} y_{2}^{i} v^{3 m-i}\right\} & (l=2 i, k=(p-1)-i, m \leq i \leq 3 n, i: \text { even }) \\ \mathbb{F}_{p}\left\{\left(y_{1}^{i-m} y_{2}^{i+m}-y_{1}^{i+m} y_{2}^{i-m}\right) v^{3 m-i}\right\} & (l=2 i, k=(p-1)-i, m \leq i \leq 3 n, i: \text { odd }) \\ 0 & \text { (otherwise }) .\end{cases}
$$

Proof. Since $w$ interchanges $y_{1}$ and $y_{2}, v w=(\operatorname{det} w) v=-v$, this lemma follows from the previous lemma.

Let $p-1=3 m$. We consider the multiplicity $m(G, 2)_{m}$ and $m(G, 2)_{2 m}$ in some cases. Recall that $\left(C S^{q}+T^{q}\right) v^{q} \cong S\left(E, A, S(A)^{p-1} \otimes \operatorname{det}^{q}\right)$ for $1 \leq q \leq p-2$ by [7, Corollary 9.3]. This module has a basis

$$
\left(y_{1}^{i} y_{2}^{j}\right) v^{q}, \quad(i=0, q \leq i \leq p-1+q, j=p-1+q-i)
$$

Note that

$$
y_{1}^{i} y_{2}^{j}, \quad(i=0, p \leq i \leq p-1+q, j=p-1+q-i)
$$

is a basis of $C S^{q}$. On the other hand,

$$
y_{1}^{i} y_{2}^{j}, \quad(q \leq i \leq p-1, j=p-1+q-i)
$$

is a basis of $T^{q}$. Moreover, if $q=m$ or $q=2 m$, then all elements in $\left(C S^{q}+T^{q}\right) v^{q}$ are $\operatorname{diag}(\xi, \xi)$-invariant since

$$
\operatorname{diag}(\xi, \xi)\left(y_{1}^{i} y_{2}^{j} v^{q}\right)=\xi^{i+j+2 q}\left(y_{1}^{i} y_{2}^{j} v^{q}\right)=\xi^{p-1+3 q}\left(y_{1}^{i} y_{2}^{j} v^{q}\right)=\left(y_{1}^{i} y_{2}^{j} v^{q}\right)
$$

Lemma 4.13. Let $M=\left(C S^{m}+T^{m}\right) v^{m}$.
(1) $M^{T}$ has a basis

$$
y_{1}^{2 m} y_{2}^{2 m} v^{m}
$$

(2) $M^{H}$ has a basis

$$
y_{1}^{4 m} v^{m}, y_{1}^{3 m} y_{2}^{m} v^{m}, y_{1}^{2 m} y_{2}^{2 m} v^{m}, y_{1}^{m} y_{2}^{3 m} v^{m}, y_{2}^{4 m} v^{m}
$$

(3) $M^{T\langle w\rangle}$ has a basis

$$
y_{1}^{2 m} y_{2}^{2 m} v^{m}
$$

(4) $M^{H\langle w\rangle}$ has a basis

$$
\left(y_{1}^{4 m}+y_{2}^{4 m}\right) v^{m}=C\left(y_{1}^{m}+y_{2}^{m}\right) v^{m}, y_{1}^{m} y_{2}^{m}\left(y_{1}^{2 m}+y_{2}^{2 m}\right) v^{m}, y_{1}^{2 m} y_{2}^{2 m} v^{m}
$$

Proof. Since

$$
\operatorname{diag}(\xi, 1)\left(y_{1}^{i} y_{2}^{j} v^{m}\right)=\xi^{i+m}\left(y_{1}^{i} y_{2}^{j} v^{m}\right)
$$

and

$$
\operatorname{diag}\left(\xi^{3}, 1\right)\left(y_{1}^{i} y_{2}^{j} v^{m}\right)=\xi^{3(i+m)}\left(y_{1}^{i} y_{2}^{j} v^{m}\right)=\xi^{3 i}\left(y_{1}^{i} y_{2}^{j} v^{m}\right)

$y_{1}^{i} y_{2}^{j} v^{m}$ is $T$-invariant if and only if $i+m \equiv 0 \bmod p-1$. Moreover, $y_{1}^{i} y_{2}^{j} v^{m}$ is $H$-invariant $i \equiv 0 \bmod m$.
(1) Since $i=0$ or $m \leq i \leq p-1+m=4 m, i+m \equiv 0 \bmod p-1$ if and only if $i=2 m$.
(2) Since $i=0$ or $m \leq i \leq p-1+m=4 m, i \equiv 0 \bmod m$ if and only if $i=$ $0, m, 2 m, 3 m, 4 m$.
(3) (4) Since $m$ is even, $w$ acts on $v^{m}$ trivially. On the other hand $w$ interchanges $y_{1}$ and $y_{2}$. Hence the results follows from (1) and (2).

Similarly, we have the following.

and

\operatorname{res}_{A_{\infty}}^{E}\left(y_{1}\right)=0, \operatorname{res}_{A_{\infty}}^{E}\left(y_{2}\right)=y_{A_{\infty}}
$$

Moreover,

for any $A \in \mathcal{A}(E)$ (see [7, section 4]).

Proposition 4.16. Suppose that $\mathcal{F}_{G}^{e c}-\mathrm{rad}=\left\{A_{0}, A_{\infty}\right\}$. Then $m(G, 2)_{m}=m(G, 2)_{2 m}$ and we have the following values:

Next we study the stable splitting of $B G$ for some $G$ related to the linear group $L_{3}(p)$. There are 6 saturated fusion systems related to $L_{3}(p)$ [12, p. 46, Table 1.1].

We determine the stable splittings of these 6 groups. Note that the these results, with the results in [15], give a complete information on the splitting for fusion systems on $E$ with $\mid \mathcal{F}^{e c}$-rad $\mid \geq 2$ by the classification in [12].

Theorem 4.17. Suppose that $W_{G}(E)=T$ and $\mathcal{F}_{G}^{e c}-\mathrm{rad}=\left\{A_{0}, A_{\infty}\right\}$. If $3 \nmid p-1$ then $B G$ is stably homotopic to $X$. If $p-1=3 m$, then $B G$ is stably homotopic to $X \vee L(2, m) \vee$ $L(2,2 m)$.

Proof. By Lemma 4.4 and Lemma 4.10, $L(1, q)(1 \leq q \leq p-2)$ is not contained in $B G$. Since $A_{i}(1 \leq i \leq p-1)$ are $T$-conjugate, there are three conjugacy classes of maximal elementary abelian $p$-subgroups and two of them consist of $\mathcal{F}_{G}^{e c}$-radical subgroups. From Lemma 4.6 and Lemma 4.7, just one $L(2,0)$ (and one $L(1,0)$ ) is contained in $B G$. Moreover if 3 does not divide $p-1$, then $L(2, q)$ is not contained in $B G$ for each $1 \leq q \leq p-2$ from Lemma 4.9.

Moreover, by Lemma 4.5 and Lemma 4.10,

On the other hand, if $p-1=3 m$, then $m(G, 2)_{m}=m(G, 2)_{2 m}=1$ by Proposition 4.16, This completes the proof.

Theorem 4.18. Suppose that $W_{G}(E)=T\langle w\rangle$ and $\mathcal{F}_{G}^{e c}-\mathrm{rad}=\left\{A_{0}, A_{\infty}\right\}$. If $3 \nmid p-1$ then $B G$ is stably homotopic to $X^{\prime}$. If $p-1=3 m$, then $B G$ is stably homotopic to $X^{\prime} \vee L(2, m) \vee L(2,2 m)$.

Proof. The proof is similar to that of previous Theorem. By Lemma 4.4 and Lemma 4.10, $L(1, q)(1 \leq q \leq p-2)$ is not contained in $B G$. Since $A_{i}(1 \leq i \leq p-1)$ are $T$-conjugate, there are two conjugacy classes of maximal elementary abelian $p$-subgroups and one of them consists of $\mathcal{F}_{G}^{e c}$-radical subgroups. From Lemma 4.6 and Lemma4.7, just one $L(2, p-1)$ (and one $L(1, p-1)$ ) is contained in $B G$. Moreover if 3 does not divide $p-1$, then $L(2, q)$ is not contained in $B G$ for each $1 \leq q \leq p-2$ from Lemma 4.9,

Moreover, by Lemma 4.5 and Lemma 4.10,

n(G)_{l, k}= \begin{cases}1 & \left(l=4 j, k=p-1-2 j, 1 \leq j \leq \frac{p-1}{4}\right) \\ 1 & (l=p-1, k=0) \\ 0 & \text { (otherwise) }\end{cases}

On the other hand, if $p-1=3 m$, then $m(G, 2)_{m}=m(G, 2)_{2 m}=1$ by Proposition 4.16, This completes the proof.

Next assume that $p-1=3 m$. Let $m=2 n$.
Theorem 4.19. Suppose that $W_{G}(E)=H$ and $\mathcal{F}_{G}^{e c}-\mathrm{rad}=\left\{A_{0}, A_{\infty}\right\}$. Then $B G$ is stably homotopic to

& \vee 3\left(\vee_{m \leq i \leq 3 n} X_{2 i, 3 m-i}\right) \vee 3(M(2) \vee L(2, m) \vee L(2,2 m))
\end{aligned}
$$

Proof. By Lemma 4.4 and Lemma 4.11, $m(G, 1)_{q}=0$ for $1 \leq q \leq p-2$. On the other hand, by Lemma 4.6 and Corollary 4.7, $m(G, 1)_{0}=m(G, 2)_{0}=5-2=3$. By Lemma 4.9, $m(G, 2)_{k}=0$ for $1 \leq k \leq p-2, k \neq m, 2 m$. By Proposition 4.16, $m(G, 2)_{m}=$
$m(G, 2)_{2 m}=3$. The multiplicity $n(G)_{i, q}$ is obtained by Lemma 4.11. By Lemma 4.11,

n(G)_{i, q}= \begin{cases}4 & (l=p-1, q=0) \\ 2 & (l=2 i, q=3 n-i, n \leq i<3 n) \\ 1 & (l=2 i, q=(p-1)-i, 1 \leq i<m) \\ 3 & (l=2 i, q=(p-1)-i, m \leq i \leq 3 n) \\ 0 & \text { (otherwise) } .\end{cases}
$$

Theorem 4.20. Suppose that $W_{G}(E)=H\langle w\rangle$ and $\mathcal{F}_{G}^{e c}-\mathrm{rad}=\left\{A_{0}, A_{\infty}\right\}$. Then $B G$ is stably homotopic to

X_{0,0} \vee 2 X_{p-1,0} \vee\left(\vee_{n \leq i<3 n} X_{2 i, 3 n-i}\right) \vee\left(\vee_{1 \leq j \leq 3 n / 2} X_{4 j, 3 m-2 j}\right) \vee\left(\vee_{m \leq i \leq 3 n} X_{2 i,(p-1)-i}\right) \\
\vee 2(M(2) \vee L(2, m) \vee L(2,2 m)) .
\end{gathered}
$$

Proof. By Lemma 4.4 and Lemma 4.12, $m(G, 1)_{q}=0$ for $1 \leq q \leq p-2$. By Lemma 4.6 and Corollary 4.7, $m(G, 1)_{0}=m(G, 2)_{0}=3-1=2$. By Lemma 4.9, $m(G, 2)_{k}=0$ for $1 \leq k \leq p-2, k \neq m, 2 m$. By Proposition 4.16, $m(G, 2)_{m}=m(G, 2)_{2 m}=2$. The multiplicity $n(G)_{i, q}$ is obtained by Lemma 4.12. By Lemma 4.12,

n(G)_{i, q}= \begin{cases}2 & (l=p-1, q=0) \\ 1 & (l=2 i, q=3 n-i, n \leq i<3 n) \\ 1 & (l=2 i, q=(p-1)-i, 1 \leq i<m, i: \text { even }) \\ 2 & (l=2 i, q=(p-1)-i, m \leq i \leq 3 n, i: \text { even }) \\ 1 & (l=2 i, q=(p-1)-i, m \leq i \leq 3 n, i \text { : odd }) \\ 0 & \text { (otherwise })\end{cases}
$$

Moreover, consider the 3rd, 4th and 5th cases. We have

Next we consider the specific case, that is, $p=7$. We give a result which supplements the result on splitting for $p=7$ in [15].

Let $G_{1}$ and $G_{2}$ be finite groups with Sylow $p$-subgroup $E$. If $\mathcal{F}_{G_{1}}$ is (isomorphic to) a subfusion system of $\mathcal{F}_{G_{2}}$, then $B G_{1} \sim B G_{2} \vee X$ for some summand $X$ of $B G_{1}$. In this case, we write

We use same notation for fusion systems.
In [15], the second author considered the graphs related to the splitting of sporadic simple groups and some exotic fusion system for $p=7$ and obtained the following.

where $R V_{1}, R V_{2}, R V_{3}$ are the exotic fusion systems of Ruiz and Viruel [12].
Now we add more information on the splittings for $p=7$.

The set $\mathcal{F}^{e c}$-rad is separated by conjugacy classes and $\operatorname{Out}_{\mathcal{F}}(A)$ is described for each representative $A$ of conjugacy classes in $\mathcal{F}^{e c}$ _rad if they are different. Note that if we take the generators $a$ and $b$ of $E$ suitably, we can obtained the two rows in the case of $L_{3}(7)$ and $L_{3}(7): 2$. For example, consider $G=L_{3}(7)$. Let $E$ be the group of all upper triangular matrices with diagonal entry 1 . The subgroups in $\mathcal{F}_{G}^{e c}$-rad are

0 & 1 & \beta \\
0 & 0 & 1
\end{array}\right] \right\rvert\, \alpha, \beta \in \mathbb{F}_{p}\right\} .
$$

If we take

$$
a=\left[\begin{array}{lll}
1 & 1 & 0 \\
0 & 1 & 0 \\
0 & 0 & 1
\end{array}\right], \quad b=\left[\begin{array}{lll}
1 & 0 & 0 \\
0 & 1 & 1 \\
0 & 0 & 1
\end{array}\right]
$$

then $\mathcal{F}_{G}^{e c}-\operatorname{rad}=\left\{A_{0}, A_{\infty}\right\}$ and $\operatorname{Out}_{\mathcal{F}_{G}}(E)=\langle 3 I, u\rangle=H$. On the other hand, if we take

$$
a=\left[\begin{array}{lll}
1 & 1 & 0 \\
0 & 1 & 1 \\
0 & 0 & 1
\end{array}\right], \quad b=\left[\begin{array}{ccc}
1 & 1 & 0 \\
0 & 1 & -1 \\
0 & 0 & 1
\end{array}\right]
$$

then $\mathcal{F}_{G}^{e c}-\mathrm{rad}=\left\{A_{1}, A_{6}\right\}$ and $\operatorname{Out}_{\mathcal{F}_{G}}(E)=\langle 3 I, w\rangle$.
The inclusions of fusion systems are obtained by the table above. For $F i_{24}^{\prime} \longleftarrow L_{3}(7)$ and $F i_{24} \longleftarrow L_{3}(7): 2$, we use the second rows of $L_{3}(7)$ and $L_{3}(7): 2$. The information on the summands are obtained by Example 4.21 and Theorem 4.22 ,

Remark 4.24. As we can see from Theorem 4.22 or 4.23 above, $B\left(F i_{24}\right)$ is a stable summand of $B\left(O^{\prime} N\right), B\left(O^{\prime} N\right) \sim B\left(F i_{24}\right) \vee Y \vee Z \vee \tilde{L}$, but the fusion system of $O^{\prime} N$ is not isomorphic to a subfusion system of fusion system of $F i_{24}$, namely,

$$
F i_{24} \stackrel{Y \vee Z \vee \tilde{L}}{\longleftarrow} O^{\prime} N
$$

does not hold.

Let $\mathcal{F}_{0}=\mathcal{F}_{O^{\prime} N}, \mathcal{F}_{1}=\mathcal{F}_{F i_{24}}$. By [12, Lemma 4.3], for each $A_{i} \in \mathcal{F}_{0}^{e c}$-rad, there exists an element of order 6 in $\operatorname{Out}_{\mathcal{F}_{0}}(E) \leq \mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$ which has an eigenvalue 3 with eigenvector $\binom{1}{i}\left(\binom{0}{1}\right.$ if $\left.i=\infty\right)$ and determinant 5 . Hence there exists an involution in $\operatorname{Out}_{\mathcal{F}_{0}}(E)$ which has an eigenvalue -1 with eigenvector $\binom{1}{i}\left(\binom{0}{1}\right.$ if $\left.i=\infty\right)$ and determinant -1 .

We may assume that $\operatorname{Out}_{\mathcal{F}_{1}}(E)=6^{2}: 2=T\langle w\rangle$ and $\mathcal{F}_{1}^{e c}$-rad $=\left\{A_{1}, \ldots, A_{6}\right\}$ as above. Suppose that $K=\operatorname{Out}_{\mathcal{F}_{0}}(E)(\cong(6 \times 2): 2) \leq \operatorname{Out}_{\mathcal{F}_{1}}(E)$. Then $K$ contains exactly 4 involutions with determinant -1 . Moreover $K \supset\langle\operatorname{diag}(-1,1), \operatorname{diag}(1,-1)\rangle$ since $\langle\operatorname{diag}(-1,1), \operatorname{diag}(1,-1)\rangle \triangleleft\left(6^{2}: 2\right)$. Note that $\left|\mathcal{F}_{0}^{e c}-\mathrm{rad}\right|=4$. Since $\operatorname{diag}(-1,1)$ (resp. $\operatorname{diag}(1,-1)$ ) has an eigenvalue -1 with eigenvector $\binom{1}{0}$ (resp. $\binom{0}{1}$ ) and determinant -1 , it follows that $A_{0}, A_{\infty} \in \mathcal{F}_{0}^{e c}$-rad for any choice of $K \leq 6^{2}: 2=T\langle w\rangle$. Hence $\mathcal{F}_{0}$ is not isomorphic to a subfusion system of $\mathcal{F}_{1}$.

## 5. Some remarks on the case $p=3$

Recall that $H^{3}(E, \mathbb{Z})=\mathbb{F}_{p}\left\{a_{1}, a_{2}\right\}$. The short exact sequence

$$
0 \longrightarrow \mathbb{Z} \xrightarrow{p} \mathbb{Z} \xrightarrow{j} \mathbb{F}_{p} \longrightarrow 0
$$

induces the following short exact sequence

$$
\begin{equation*}
0 \longrightarrow H^{2}(E, \mathbb{Z}) \xrightarrow{j_{*}} H^{2}\left(E, \mathbb{F}_{p}\right) \xrightarrow{\hat{\beta}} H^{3}(E, \mathbb{Z}) \longrightarrow 0 \tag{5.1}
\end{equation*}
$$

Hence there exist elements $a_{1}^{\prime}, a_{2}^{\prime} \in H^{2}\left(E, \mathbb{F}_{p}\right)$ such that $\hat{\beta}\left(a_{i}^{\prime}\right)=a_{i}$ and

$$
H^{2}\left(E, \mathbb{F}_{p}\right)=\mathbb{F}_{p}\left\{y_{1}, y_{2}, a_{1}^{\prime}, a_{2}^{\prime}\right\}
$$

We consider the action of $\operatorname{Out}(E)=\mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$. The sequence (5.1) is a sequence of $\mathbb{F}_{p} \mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$-modules and the map $Q_{1} \hat{\beta}$ induces an isomorphism of $\mathbb{F}_{p} \mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$-modules,

$$
H^{2}\left(E, \mathbb{F}_{p}\right) / H^{2}(E, \mathbb{Z}) \longrightarrow H^{3}(E, \mathbb{Z}) \longrightarrow \mathbb{F}_{p}\left\{y_{1} v, y_{2} v\right\} \cong S^{1} \otimes \operatorname{det}
$$

Now, consider the sequence

$$
\begin{aligned}
& H^{2 p}(E, \mathbb{Z}) \xrightarrow{j_{*}} \quad H^{2 p}\left(E, \mathbb{F}_{p}\right) \quad \xrightarrow{\hat{\beta}} H^{2 p+1}(E, \mathbb{Z}) \\
& \xrightarrow{p} H^{2 p+1}(E, \mathbb{Z}) \xrightarrow{j_{*}} H^{2 p+1}\left(E, \mathbb{F}_{p}\right) .
\end{aligned}
$$

By taking the $p$-th power, we have an $\mathbb{F}_{p} \mathrm{GL}_{2}\left(\mathbb{F}_{p}\right)$-morphism,

$$
H^{2}\left(E, \mathbb{F}_{p}\right) \longrightarrow H^{2 p}\left(E, \mathbb{F}_{p}\right) .
$$

Since $\beta=j_{*} \hat{\beta}$ is the Bockstein homomorphism, we have $\beta\left(\left(a_{i}^{\prime}\right)^{p}\right)=0$. Moreover, since $j_{*}: H^{2 p+1}(E, \mathbb{Z}) \longrightarrow H^{2 p+1}\left(E, \mathbb{F}_{p}\right)$ is injective, $\hat{\beta}\left(\left(a_{i}^{\prime}\right)^{p}\right)=0$. Hence, it follows that

$$
\left(a_{i}^{\prime}\right)^{p} \in j_{*}\left(H^{2 p}(E, \mathbb{Z})\right) \cong H^{2 p}(E)
$$

On the other hand, since

$$
H^{2 p}(E)=C S^{1}+T^{1}+\mathbb{F}_{p}\{v\} \leftrightarrow S^{1} \oplus\left(S^{p-2} \otimes \operatorname{det}\right) \oplus \operatorname{det},
$$

we see that if $p>3$ then $\left(a_{i}^{\prime}\right)^{p}=0$. Since $H^{\text {even }}\left(E, \mathbb{F}_{p}\right)$ is generated by $1, a_{1}^{\prime}, a_{2}^{\prime}$ as a module over $\mathbb{F}_{p} \otimes H^{\text {even }}(E, \mathbb{Z})$, it follows that

$$
H^{\text {even }}\left(E, \mathbb{F}_{p}\right) / \sqrt{(0)}=\left(\mathbb{F}_{p} \otimes H^{\text {even }}(E, \mathbb{Z})\right) / \sqrt{(0)}
$$

and in particular,

$$
H^{*}\left(E, \mathbb{F}_{p}\right) / \sqrt{(0)}=\left(\mathbb{F}_{p} \otimes H^{*}(E, \mathbb{Z})\right) / \sqrt{(0)}=H^{*}(E)
$$

for $p>3$.
On the other hand, if $p=3$, then the sequence (5.1) does not split and $\mathbb{F}_{3}\left\{y_{1}, y_{2}\right\}$ is the unique nontrivial $\mathbb{F}_{3} \mathrm{GL}_{2}\left(\mathbb{F}_{3}\right)$-submodule of $H^{2}\left(E, \mathbb{F}_{3}\right)$ (cf. [9, p.74]). This implies that $\left(a_{i}^{\prime}\right)^{p^{n}} \neq 0$ for any $n>0$ and in particular, we see that $a_{i}^{\prime}$ is not nilpotent.

In fact, the structure of $H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{(0)}$ is known by the result of Leary [9, Theorem 7] and we have the following:
Proposition 5.1. Assume that $p=3$. Then $H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}$ is generated by

$$
y_{1}, y_{2}, a_{1}^{\prime}, a_{2}^{\prime}, v
$$

with

$$
\operatorname{deg} y_{i}=\operatorname{deg} a_{i}^{\prime}=2, \operatorname{deg} v=6
$$

subject to the following relations:

$$
\begin{gathered}
y_{1}^{3} y_{2}-y_{1} y_{2}^{3}=0 \\
a_{1}^{\prime} a_{2}^{\prime}=a_{1}^{\prime} y_{1}=a_{2}^{\prime} y_{2}=y_{1} y_{2},\left(a_{1}^{\prime}\right)^{2}=\left(a_{2}^{\prime}\right)^{2}=a_{1}^{\prime} y_{2}=a_{2}^{\prime} y_{1} .
\end{gathered}
$$

Since $H^{4}\left(E, \mathbb{F}_{3}\right) /\left(H^{4}\left(E, \mathbb{F}_{3}\right) \cap \sqrt{0}\right)$ is spanned by $y_{1}^{2}, y_{1} y_{2}, y_{2}^{2},\left(a_{1}^{\prime}\right)^{2}$ and $\operatorname{dim}_{\mathbb{F}_{3}} H^{4}(E)=4$,

$$
H^{4}\left(E, \mathbb{F}_{3}\right) /\left(H^{4}\left(E, \mathbb{F}_{3}\right) \cap \sqrt{0}\right)=H^{4}(E)
$$

In particular, $\left(a_{i}^{\prime}\right)^{2} \in H^{4}(E)$ and hence we have

$$
H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}=H^{*}(E) \oplus \mathbb{F}_{3}[v]\left\{\mathbb{F}_{3} a_{1}^{\prime}+\mathbb{F}_{3} a_{2}^{\prime}\right\}
$$

Since $H^{2}\left(E, \mathbb{F}_{3}\right) / H^{2}(E) \cong S^{1} \otimes \operatorname{det}$ as $\mathbb{F} \mathrm{GL}_{2}\left(\mathbb{F}_{3}\right)$-modules,

$$
\left(H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}\right) / H^{*}(E) \cong \mathbb{F}_{3}[v] \otimes\left(S^{1} \otimes \operatorname{det}\right)
$$

as $\mathbb{F}_{3} \mathrm{GL}_{2}\left(\mathbb{F}_{3}\right)$-modules. If $Q$ is a proper subgroup of $E$, then $H^{*}\left(Q, \mathbb{F}_{3}\right) / \sqrt{0}=H^{*}(Q)$. Hence

$$
\begin{aligned}
\left(H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}\right) A_{3}(Q, E) A_{3}(E, Q) & \subset\left(H^{*}\left(Q, \mathbb{F}_{3}\right) / \sqrt{0}\right) A_{3}(E, Q) \\
& =H^{*}(Q) A_{3}(E, Q) \subset H^{*}(E)
\end{aligned}
$$

In particular, $\left(H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}\right) / H^{*}(E)$ is annihilated by $A_{3}(Q, E) A_{3}(E, Q)$ for any $Q<E$. Hence, every composition factors of $\left(H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}\right) / H^{*}(E)$ as an $A_{3}(E, E)$-module is isomorphic to $S\left(E, E, S^{i} \otimes \operatorname{det}^{q}\right)$ for some $i, q$ and we have the following:

## Proposition 5.2.

$$
\left(H^{n}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}\right) / H^{n}(E) \cong \begin{cases}S\left(E, E, S^{1} \otimes \operatorname{det}\right) & (n \equiv 2 \bmod 12) \\ S\left(E, E, S^{1}\right) & (n \equiv 8 \bmod 12) \\ 0 & (\text { otherwise })\end{cases}
$$

Corollary 5.3. Let $X_{0,0}$ be the summand which corresponding to the simple module $S\left(E, E, \mathbb{F}_{p}\right)$ and e be the corresponding idempotent in $A_{p}(E, E)$. Then

$$
\left(H^{*}\left(E, \mathbb{F}_{3}\right) / \sqrt{0}\right) e \cong H^{*}(E) e \cong \mathbb{D}^{+}
$$

At last of this paper, we see more closely the cohomology $H^{*}(X)$ of a summand $X$ in the stable splitting of $B G$ with $E \in \operatorname{Syl}_{3}(G)$ in the case $p=3$. The lowest degree and some of the second lowest degree $*>0$ with $H^{2 *}(X) \neq 0$ are given as follows:

$$
\begin{array}{rllll}
L(1,1) & :\left|S^{1}\right|=1 & L(1,0) & :\left|y^{2}\right|=2, \\
L(2,1) & :\left|C S^{1} v\right|=6 & L(2,0) & :\left|S^{2} D_{2}\right|=10, \\
X_{0,0} & :|V|=6 & X_{0,1} & :|v|=3(|C v|=5) \\
X_{1,0} & :\left|S^{1} V\right|=7, & X_{1,1} & :\left|T^{1}\right|=3\left(\left|S^{1} v\right|=4\right) \\
X_{2,0} & :\left|S^{2} V\right|=8 & X_{2,1} & :\left|S^{2} v\right|=5
\end{array}
$$

where $|x|=\frac{1}{2} \operatorname{deg} x$ for an element or a subspace of $H^{*}(E)$. First note that $B G$ always contains $X_{0,0}$. The lowest degree of nonzero elements in $H^{2 *}(L(i, j))$ or $H^{2 *}\left(X_{i, q}\right),(i, q) \neq$ $(0,0)$ are all different except for $X_{0,1}$ and $X_{1,1}$. On the other hand we see $H^{4}\left(X_{0,1}\right)=0$ but $H^{4}\left(X_{1,1}\right) \cong \mathbb{F}_{3}$. Moreover $L(1,0)$ and $L(2,0)$ have same multiplicity by Lemma 4.6 and 4.7. Hence we can count the numbers of

$$
L(1,1), M(2)=L(1,0) \vee L(2,0), X_{1,1}, X_{0,1}, X_{2,1}, L(2,1), X_{1,0}, X_{2,0}
$$

from $H^{2 *}(G)$ for $*=1,2,4,3,5,6,7,8$. Thus we have the following result which is similar to Corollary 4.2 (1) (See Remark 4.8).

Theorem 5.4. Let $G_{1}$ and $G_{2}$ be finite groups with same Sylow 3-subgroup E. If

$$
\operatorname{dim} H^{2 n}\left(G_{1}\right)=\operatorname{dim} H^{2 n}\left(G_{2}\right)
$$

for $n \leq 8$, then $B G_{1} \sim B G_{2}$.
For example, let $G_{1}={ }^{2} F_{4}(2)^{\prime}$ and $G_{2}=J_{4}$. Then by [15, Theorem 6.2],

$$
B\left({ }^{2} F_{4}(2)^{\prime}\right) \sim B J_{4} \vee X_{2,0}
$$

Hence $H^{2 n}\left({ }^{2} F_{4}(2)^{\prime}\right) \cong H^{2 n}\left(J_{4}\right)$ for $n<8$ and $\operatorname{dim} H^{16}\left({ }^{2} F_{4}(2)^{\prime}\right)>\operatorname{dim} H^{16}\left(J_{4}\right)$. See [15, section 6] for details.

Remark 5.5. If $G$ has a Sylow 3-subgroup $E$, then $B G$ is homotopic to the classifying space of one of the groups listed in [15, Theorem 6.2]. Moreover the cohomology of each dominant summand $X_{i, j}$ of $B E$, expect for $X_{1,0}$ and $X_{1,1}$, is deduced from the cohomology of those finite groups.

On the other hand, as we can see from the graph in [15, Theorem 6.2], $X_{1,0}$ and $X_{1,1}$ always appear as $X_{1,0} \vee X_{1,1}$. We shall give an brief explanation of this fact. Let

$$
H=W_{G}(E)=N_{G}(E) / E C_{G}(E) \leq \operatorname{Out}(E)=\mathrm{GL}_{2}\left(\mathbb{F}_{3}\right)
$$

Note that $H$ is a $3^{\prime}$-group, in fact, 2 -group. The multiplicity of $X_{1, j}$ in the stable splitting of $B G$ is equal to $\operatorname{dim}\left(S^{1} \otimes \operatorname{det}^{j}\right)^{H}$. We have to show that

$$
\operatorname{dim}\left(S^{1}\right)^{H}=\operatorname{dim}\left(S^{1} \otimes \operatorname{det}\right)^{H}
$$

We may assume that $H \neq 1$. Then $\operatorname{dim}\left(S^{1}\right)^{H}=1$ if and only if $H$ is conjugate to the subgroup $\langle\operatorname{diag}(1,-1)\rangle$ in $\mathrm{GL}_{2}\left(\mathbb{F}_{3}\right)$. Similarly $\operatorname{dim}\left(S^{1} \otimes \operatorname{det}\right)^{H}=1$ if and only if $H$ is conjugate to the subgroup $\langle\operatorname{diag}(1,-1)\rangle$ in $\mathrm{GL}_{2}\left(\mathbb{F}_{3}\right)$. Hence we have

$$
\operatorname{dim}\left(S^{1}\right)^{H}=\operatorname{dim}\left(S^{1} \otimes \operatorname{det}\right)^{H}
$$

and this implies that $X_{1,0}$ and $X_{1,1}$ appear in $B G$ with same multiplicity.
