# ON NUMERICAL SEMIGROUPS CLOSED WITH RESPECT TO THE ACTION OF CERTAIN AFFINE MAPS

ABSTRACT. In this paper we study numerical semigroups containing a positive integer and closed with respect to the action of an affine map of the form  $x \mapsto ax + 1$ .

## 1. INTRODUCTION

For any  $a \in \mathbf{N}^*$  and  $b \in \mathbf{N}$  we define the affine map

$$\begin{array}{rccc} \vartheta_{a,b}: \mathbf{N} & \to & \mathbf{N} \\ & x & \mapsto & ax+b. \end{array}$$

We say that a numerical semigroup G is a  $\vartheta_{a,b}$ -semigroup if  $G^* = G \setminus \{0\}$  is closed with respect to the action of the map  $\vartheta_{a,b}$ , namely if  $\vartheta_{a,b}(y) \in G^*$  for any  $y \in G^*$ .

The problem we will deal with along the paper consists in finding the smallest  $\vartheta_{a,1}$ -semigroup containing a positive integer x, where a is a positive integer.

We notice in passing that Thabit numerical semigroups [2], namely semigroups defined for any  $n \in \mathbf{N}$  as

$$T(n) = \langle \left\{ 3 \cdot 2^{n+i} - 1 : i \in \mathbf{N} \right\} \rangle,$$

are  $\vartheta_{2,1}$ -semigroups.

Also Mersenne numerical semigroups [1], namely semigroups defined for any  $n \in \mathbf{N}$  as

$$\langle \{2^{n+i}-1:i\in\mathbf{N}\}\rangle,$$

are  $\vartheta_{2,1}$ -semigroups.

The paper is organized as follows: after a preliminary section, where some notations are introduced, in Section 3 we deal with the aforementioned problem and show how to construct  $\vartheta_{a,1}$ -semigroups.

#### 2. Notations

We introduce some notations, we will use repeatedly along the paper.

**Definition 2.1.** If y and z are two non-negative integers such that y < z, then

$$\begin{array}{lll} [y, z]_{\mathbf{N}} &:= & \{x \in \mathbf{R} : y \le x < z\} \cap \mathbf{N}; \\ [y, z]_{\mathbf{N}} &:= & \{x \in \mathbf{R} : y \le x \le z\} \cap \mathbf{N}; \\ [y, +\infty[_{\mathbf{N}} &:= & \{x \in \mathbf{R} : y \le x < +\infty\} \cap \mathbf{N}. \end{array}$$

If  $\{a, x\} \subseteq \mathbf{N}^*$  and  $k \in \mathbf{N}$ , then we define the sum

$$s_k(a) := \begin{cases} 0 & \text{if } k = 0, \\ \sum_{i=0}^{k-1} a^i & \text{otherwise,} \end{cases}$$

and accordingly

$$t_k(a, x) := \begin{cases} x & \text{if } k = 0, \\ a^k x + s_k(a) & \text{otherwise.} \end{cases}$$

Moreover, we define the set

$$S(a,x) := \{t_k(a,x) : k \in \mathbf{N}\}$$

and, for any non-negative integer k,

$$S_{\tilde{k}}(a,x) := \{ t_k(a,x) : 0 \le k \le \tilde{k} \in \mathbf{N} \}.$$

Finally, we define

$$H(a, x) := \langle S(a, x) \rangle$$

and denote by  $G_{a,1}(x)$  the smallest  $\vartheta_{a,1}$ -semigroup containing x.

3. Structure and construction of  $\vartheta_{a,1}$ -semigroups

We fix once for all this section a subset  $\{a, x\} \subseteq \mathbf{N}^*$ .

In the first part of this section we prove some technical lemmas which let us prove in Theorem 3.5 that

$$G_{a,1}(x) = H(a, x).$$

**Lemma 3.1.** We have that  $S(a, x) \subseteq G_{a,1}(x)$ .

*Proof.* We prove the claim by induction on  $k \in \mathbf{N}$ .

If k = 0, then  $t_0(a, x) = x \in G_{a,1}(x)$ .

Suppose now that  $t_k(a, x) \in G_{a,1}(x)$  for some non-negative integer k. Then,

$$t_{k+1}(a,x) = a \cdot t_k(a,x) + 1 = \vartheta_{a,1}(t_k(a,x)) \in G_{a,1}(x).$$

**Lemma 3.2.** H(a, x) is a subsemigroup of  $(\mathbf{N}, +)$  closed with respect to the action of the map  $\vartheta_{a,1}$ .

*Proof.* By definition, H(a, x) is a subsemigroup of  $(\mathbf{N}, +)$ .

We prove that H(a, x) is closed with respect to the action of the map  $\vartheta_{a,1}$ . Consider an element

$$y = \sum_{k \in K} j_k \cdot t_k(a, x) \in H(a, x),$$

where K is a non-empty finite subset of **N** and  $\{j_k\}_{k \in K}$  is a set of positive integers. Let  $\tilde{k}$  be a chosen element of K. Then,

$$\begin{split} ay+1 &= \sum_{\substack{k \in K \\ k \neq \bar{k}}} aj_k \cdot t_k(a, x) + 1 \\ &= \sum_{\substack{k \in K \\ k \neq \bar{k}}} aj_k \cdot t_k(a, x) + a(j_{\bar{k}} - 1) \cdot t_{\bar{k}}(a, x) + a \cdot t_{\bar{k}}(a, x) + 1 \\ &= \sum_{\substack{k \in K \\ k \neq \bar{k}}} aj_k \cdot t_k(a, x) + a(j_{\bar{k}} - 1) \cdot t_{\bar{k}}(a, x) + (t_{\bar{k}+1}(a, x) - 1) + 1 \\ &= \sum_{\substack{k \in K \\ k \neq \bar{k}}} aj_k \cdot t_k(a, x) + a(j_{\bar{k}} - 1) \cdot t_{\bar{k}}(a, x) + t_{\bar{k}+1}(a, x). \end{split}$$

Since this latter is a linear combination of elements in S(a, x) with coefficients in **N**, we conclude that  $ay + 1 \in H(a, x)$ .

**Lemma 3.3.** If  $\{m, n\} \subseteq \mathbf{N}$ , where  $n \ge x - 1$ , and

 $[mx, mx + n]_{\mathbf{N}} \subseteq H(a, x),$ 

then

$$[mx, +\infty[_{\mathbf{N}} \subseteq H(a, x)].$$

*Proof.* According to Lemma 3.2, H(a, x) is a subsemigroup of  $(\mathbf{N}, +)$  closed with respect to the action of the map  $\vartheta_{a,1}$ .

If y is an integer such that  $y \ge mx$ , then

$$\begin{cases} y - mx = xq + r \\ 0 \le r < x \end{cases}$$

for some non-negative integers q and r, where  $r \leq n$ .

Since

$$mx + r \in [mx, mx + n]_{\mathbf{N}} \subseteq H(a, x)$$

and  $qx \in H(a, x)$ , we conclude that  $y \in H(a, x)$ . Therefore,

$$[mx, +\infty[\mathbf{N} \subseteq H(a, x)].$$

**Lemma 3.4.** For any  $k \in \mathbb{N}$  we have that  $[a^k x, t_k(a, x)]_{\mathbb{N}} \subseteq H(a, x)$ .

*Proof.* We prove the claim by induction on k.

Proving the base step is trivial, since  $x \in H(a, x)$  and

$$[a^0x, t_0(a, x)]_{\mathbf{N}} = [x, x]_{\mathbf{N}} \subseteq H(a, x).$$

Suppose now that  $[a^k x, t_k(a, x)]_{\mathbf{N}} \subseteq H(a, x)$  for some  $k \in \mathbf{N}$ . Then,

$$a \cdot (a^k x + r) = a^{k+1} x + ar \in H(a, x)$$

for any  $r \in [0, s_k(a)]_{\mathbf{N}}$ . Moreover,

$$a^{k+1}x + ar + j \in H(a, x)$$

for any  $r \in [0, s_k(a)]_{\mathbf{N}}$  and any  $j \in [0, a]_{\mathbf{N}}$ , since

$$a^{k+1}x + ar + j = (a - j) \cdot (a^k x + r) + j \cdot (a^k x + r + 1).$$

Therefore,

$$[a^{k+1}x, a^{k+1}x + s_k(a) \cdot a[\mathbf{N} \subseteq H(a, x)]$$

Finally,

$$a^{k+1}x + s_k(a) \cdot a = a^{k+1}x + \sum_{i=1}^k a^i = a \cdot t_k(a, x) \in H(a, x),$$
  
$$t_{k+1}(a, x) = \vartheta_{a,1}(t_k(a, x)) \in H(a, x).$$

All considered, we get that  $[a^{k+1}x, t_{k+1}(a, x)]_{\mathbf{N}} \subseteq H(a, x)$  and the inductive step is proved.

**Theorem 3.5.** If  $\{a, x\} \subseteq \mathbf{N}^*$ , then  $G_{a,1}(x) = H(a, x)$ .

*Proof.* First, we notice that  $H(a, x) \subseteq G_{a,1}(x)$  according to Lemma 3.1.

According to Lemma 3.2, H(a, x) is a subsemigroup of  $(\mathbf{N}, +)$  closed with respect to the action of the map  $\vartheta_{a,1}$ .

Let k be a positive integer such that  $s_k(a) \ge x - 1$ . Then,

$$[a^k x, t_k(a, x)]_{\mathbf{N}} \subseteq H(a, x)$$

according to Lemma 3.4. Moreover, according to Lemma 3.3,  $\mathbf{N} \setminus H(a, x)$  is finite too.

All considered, H(a, x) is a numerical semigroup and  $G_{a,1}(x) = H(a, x)$ .

The following technical lemma let us prove Theorem 3.7. As a consequence of such a theorem we deduce Corollary 3.8, where the embedding dimension  $e(G_{a,1}(x))$  of  $G_{a,1}(x)$ , namely the cardinality of the minimal set of generators of  $G_{a,1}(x)$ , is given.

**Lemma 3.6.** If  $k \in \mathbf{N}^*$  and  $\{j_i\}_{i \in K}$  is a set of positive integers indexed on a non-empty set  $K \subseteq [0, k-1]_{\mathbf{N}}$  such that  $\sum_{i \in K} j_i \cdot a^i \leq a^k$ , then

$$\sum_{i \in K} j_i \cdot t_i(a, x) < t_k(a, x).$$

*Proof.* We distinguish three different cases.

• If  $K = \{0\}$ , then  $j_0 \leq a^k$  and

$$\sum_{i \in K} j_i \cdot t_i(a, x) = j_0 \cdot x < a^k \cdot x + s_k(a) = t_k(a, x).$$

• If  $K \neq \{0\}$  but the cardinality of K is still one, then

$$\sum_{i \in K} j_i \cdot t_i(a, x) = c \cdot t_r(a, x)$$

for some  $r \in [0, k-1]_{\mathbf{N}}$  and some  $c \in [0, a^{k-r}]_{\mathbf{N}}$ . Therefore,

$$\sum_{i \in K} j_i \cdot t_i(a, x) = c \cdot (a^r x + s_r(a))$$

$$\leq a^k x + a^{k-r} \cdot b \cdot s_r(a) = a^k x + \sum_{i=k-r}^{k-1} a^i$$

$$< t_k(a, x).$$

• If the cardinality of K is greater than one, then  $a \neq 1$ . Indeed,

$$\sum_{i \in K} j_i 1^i \le 1^k$$

if and only if |K| = 1 and the only integer  $j_i$  is equal to 1. Therefore, assuming  $a \neq 1$ , we have that

$$\begin{split} \sum_{i \in K} j_i \cdot t_i(a, x) &= \sum_{i \in K} j_i \cdot a^i x + \sum_{i \in K} j_i \cdot s_i(a) \\ &\leq a^k \cdot x + \left(\sum_{i \in K} j_i \cdot \frac{a^i - 1}{a - 1}\right) \\ &= a^k \cdot x + \frac{1}{a - 1} \cdot \left(\sum_{i \in K} j_i \cdot a^i - \sum_{i \in K} j_i\right) \\ &\leq a^k \cdot x + \frac{1}{a - 1} \cdot \left(a^k - \sum_{i \in K} j_i\right) \\ &\leq a^k \cdot x + \frac{1}{a - 1} \cdot (a^k - 2) \\ &< a^k \cdot x + \frac{a^k - 1}{a - 1} = t_k(a, x). \end{split}$$

**Theorem 3.7.** Let  $\tilde{k} := \min\{k \in \mathbf{N} : s_k(a) \ge x - 1\}.$ 

Then, the following hold.

(1) If  $s_{\tilde{k}}(a) = x - 1$ , then  $S_{\tilde{k}}(a, x)$  is a minimal set of generators for  $G_{a,1}(x)$ . (2) If  $s_{\tilde{k}}(a) > x - 1$ , then  $S_{\tilde{k}-1}(a, x)$  is a minimal set of generators for  $G_{a,1}(x)$ .

*Proof.* Let k be a positive integer such that  $s_k(a) < x$ . Then,

t

$$a_k(a,x) \in [a^k x, (a^k+1)x]_{\mathbf{N}}.$$

Consider now an element

$$\sum_{i \in K} j_i \cdot t_i(a, x) \in [0, (a^k + 1)x]_{\mathbf{N}},$$

where  $\{j_i\}_{i \in K}$  is a set of positive integers indexed on a set  $K \subseteq [0, k]_{\mathbb{N}}$ . We have that

$$\sum_{i \in K} j_i \cdot a^i x \quad \leq \quad \sum_{i \in K} j_i \cdot t_i(a, x) < (a^k + 1) \cdot x.$$

As a consequence,

$$\sum_{i \in K} j_i \cdot a^i \leq a^k$$

Hence, in accordance with Lemma 3.6, we have that

$$\sum_{i \in K} j_i \cdot t_i(a, x) < t_k(a, x).$$

All considered, we conclude that

$$t_k(a, x) \notin \langle t_i(a, x) : 0 \le i < k \rangle$$

for any positive integer k such that  $s_k(a) < x$ .

We prove now separately the 2 statements in the claim of the theorem.

(1) If  $s_{\tilde{k}}(a) = x - 1 < x$ , then

$$t_k(a, x) \notin \langle t_i(a, x) : 0 \le i < k \rangle$$

for any positive integer  $k \leq k$ .

Nevertheless,  $S_{\tilde{k}}(a, x)$  is a minimal set of generators for  $G_{a,1}(x)$ , since

$$[a^k x, +\infty]_{\mathbf{N}} \subseteq G_{a,1}(x)$$

according to Lemma 3.3.

(2) If  $s_{\tilde{k}}(a) > x - 1$ , then

$$t_k(a, x) \notin \langle t_i(a, x) : 0 \le i < k \rangle$$

for any positive integer  $k < \tilde{k}$ , while

$$t_{\tilde{k}}(a, x) \in \langle t_i(a, x) : 0 \le i < k \rangle.$$

The latter assertion holds since

$$\begin{cases} t_{\tilde{k}}(a,x) - a^{\tilde{k}}x = qx + r\\ 0 \leq r < x \end{cases}$$

for some non-negative integers q and r. Since

$$a^{\tilde{k}}x \le a^{\tilde{k}}x + r < t_{\tilde{k}}(a, x)$$

we have that

$$a^k x + r \in G_{a,1}(x)$$

according to Lemma 3.4. Indeed,

$$\{a^k x + r, qx\} \subseteq \langle S_{\tilde{k}-1}(a, x) \rangle.$$

Therefore,

$$t_{\tilde{k}}(a,x) \in \langle S_{\tilde{k}-1}(a,x) \rangle,$$

namely  $S_{\tilde{k}-1}(a,x)$  is a minimal set of generators for  $G_{a,1}(x)$ .

**Corollary 3.8.** Let  $\tilde{k} := \min\{k \in \mathbf{N} : s_k(a) \ge x - 1\}$ . Then, the following hold. (1) If  $s_{\tilde{k}}(a) = x - 1$ , then  $e(G_{a,1}(x)) = \tilde{k} + 1$ .

(2) If 
$$s_{\tilde{k}}(a) > x - 1$$
, then  $e(G_{a,1}(x)) = \tilde{k}$ 

*Proof.* The result follows immediately from Theorem 3.7 since  $|S_k(a, x)| = k + 1$  for any  $k \in \mathbb{N}$ .

Remark 3.9. In [2, Theorem 6] it is claimed that e(T(n)) = n + 2 for any  $n \in \mathbb{N}$ . Indeed, if we set

$$x := 3 \cdot 2^n - 1,$$

then

$$x - 1 = 3 \cdot 2^n - 2 = 2^{n+1} + 2^n - 2.$$

If  $k \in \mathbf{N}^*$ , then

$$s_k(2) = \sum_{i=0}^{k-1} 2^i > x - 1$$

 $\mathbf{6}$ 

if and only if

$$k \ge n+2$$

Adopting the notations introduced in the current paper, a = 2 and  $T(n) = G_{2,1}(x)$ . Therefore, according to Corollary 3.8,  $\tilde{k} = n + 2$  and  $s_{\tilde{k}}(2) > x - 1$ . All considered,

$$e(G_{2,1}(x)) = e(T(n)) = n + 2$$

in accordance with [2, Theorem 6].

In the following theorem we estimate the value for the Frobenius number  $F(G_{a,1}(x))$ , which is the greatest integer which does not belong to  $G_{a,1}(x)$ .

**Theorem 3.10.** Let  $\tilde{k} := \min\{k \in \mathbf{N} : s_k(a) \ge x - 1\}$ . Then,

$$a^{k-1}x + ax - 1 \le F(G_{a,1}(x)) \le a^k x - 1.$$

Proof. According to Lemma 3.3, we have that

$$[a^k x, +\infty[\mathbf{N} \subseteq G_{a,1}(x)]$$

Hence,

$$F(G_{a,1}(x)) \le a^k x - 1$$

Consider now the integer

$$a^{\tilde{k}-1}x + ax - 1 = (a^{\tilde{k}-1} + 1)x - 1 + (a-1)x.$$

We notice that

$$(a^{\tilde{k}-1}+1)x - 1 \in [t_{\tilde{k}-1}(a,x) + 1, (a^{\tilde{k}}+1)x]_{\mathbf{N}}.$$

Let

$$T := \sum_{i \in K} j_i \cdot t_i(a, x),$$

where  $K \subseteq [0, \tilde{k} - 1]_{\mathbf{N}}$  and  $\{j_i\}_{i \in K}$  is a set of positive integers.

If  $\tilde{k} - 1 \in K$ , then either  $T = t_{\tilde{k}-1}(a, x)$  or  $T \ge t_{\tilde{k}-1}(a, x) + x$ . In both cases,  $T \ne (a^{\tilde{k}-1} + 1)x - 1$ .

 $T \neq (a^{\tilde{k}-1}+1)x - 1.$ Suppose now that  $K \subseteq [0, \tilde{k}-2]_{\mathbf{N}}.$ If  $\sum_{i \in K} j_i \cdot a^i \leq a^{\tilde{k}-1}$ , then

$$\sum_{i \in K} j_i \cdot t_i(a, x) < t_{\tilde{k}-1}(a, x)$$

according to Lemma 3.6.

If  $\sum_{i \in K} j_i \cdot a^i > a^{\tilde{k}-1}$ , then

$$\sum_{i \in K} j_i \cdot t_i(a, x) \ge (a^{\tilde{k}} + 1)x.$$

All considered,

$$a^{\tilde{k}-1}x + ax - 1 = (a^{\tilde{k}-1} + 1)x - 1 + (a-1)x \notin \langle S_{\tilde{k}-1}(a,x) \rangle.$$

Therefore,

$$a^{k-1}x + ax - 1 \le F(G_{a,1}(x)).$$
