SPREADING ESTIMATES FOR QUANTUM WALKS ON THE INTEGER LATTICE VIA POWER-LAW BOUNDS ON TRANSFER MATRICES

Abstract. We discuss spreading estimates for dynamical systems given by the iteration of an extended CMV matrix. Using a connection due to Cantero– Grünbaum–Moral–Velázquez, this enables us to study spreading rates for quantum walks in one spatial dimension. We prove several general results which establish quantitative upper and lower bounds on the spreading of a quantum walk in terms of estimates on a pair of associated matrix cocycles. To demonstrate the power and utility of these methods, we apply them to several concrete cases of interest. In the case where the coins are distributed according to an element of the Fibonacci subshift, we are able to rather completely describe the dynamics in a particular asymptotic regime. As a pleasant consequence, this supplies the first concrete example of a quantum walk with anomalous transport, to the best of our knowldege. We also prove ballistic transport for a quantum walk whose coins are periodically distributed.

1. INTRODUCTION

In recent years, quantum walks have been studied extensively; see [\[1,](#page-45-1) [4,](#page-45-2) [5,](#page-45-3) [6,](#page-45-4) [7,](#page-45-5) [12,](#page-45-6) [22,](#page-45-7) [23,](#page-45-8) [24,](#page-45-9) [26,](#page-45-10) [27,](#page-45-11) [28,](#page-45-12) [36\]](#page-46-0) for some papers on this subject that have appeared in the past five years. These are quantum analogues of classical random walks. For simplicity, let us focus on the important special case of walks on the integer lattice Z.

A classical (stationary, or time-homogeneous) random walk on the integer lattice Z is given by transition probabilities $\{p_{n,m}\}_{n,m\in\mathbb{Z}}$, where $p_{n,m}\in[0,1]$ denotes the probability of moving from site m to site n . Denote the bi-infinite matrix with these entries by P . We therefore require that each row sum of P is equal to one, that is, $\sum_{n\in\mathbb{Z}}p_{n,m}=1$ for every $m\in\mathbb{Z}$. The state of the system may be specified by a column vector $v = (v_n)_{n \in \mathbb{Z}}$ with entries $v_n \in [0, 1]$, which is normalized in the sense that $\sum_{n\in\mathbb{Z}}v_n=1$ so that v_n describes the probability of the system being at site *n*. The time evolution of this state is then given by $v(k) = P^k v$ for $k \ge 0$ or, if P is invertible, for $k \in \mathbb{Z}$.

An important special case is obtained by only considering nearest-neighbor transitions with symmetric transition probabilities. That is, we have $p_{n,m} = 0$ for $|n-m| > 1$ and $p_{n,m} = p_{m,n}$. In this case the matrix P is tridiagonal and symmetric and hence has the structure of a Jacobi matrix. To emphasize this fact we will write in this case J instead of P for the transition matrix.^{[1](#page-1-1)} Thus, in this case, the evolution of an initial state v is given by $v(k) = J^k v$. In particular, the probability of being at site n at time k is given by

$$
(1.1) \t\t \t\t \langle \delta_n, J^k v \rangle,
$$

where δ_n is the vector with value 1 at position n and value 0 otherwise, and $\langle v^1, v^2 \rangle = \sum_{n \in \mathbb{Z}} \overline{v_n^1} v_n^2$. Here is where our symmetry assumption turns out to be critical. Since J is obviously a bounded self-adjoint operator on $\ell^2(\mathbb{Z})$, an expression like [\(1.1\)](#page-1-2) can be rewritten with the help of the spectral theorem. Indeed, it takes the form $\int_{\mathbb{R}} x^k d\mu_{n,J,v}(x)$, where $\mu_{n,J,v}$ is a complex measure supported by the spectrum of J. Therefore, spectral theory enters the game and the long-time evolution of the classical random walk can be studied by means of a spectral analysis of the transition operator J.

To motivate the discussion of the quantum analogue, we can interpret the transitions as follows. Assuming further that the diagonal elements are zero as well, we have $p_{n-1,n} + p_{n+1,n} = 1$. Thus the transition from n to one of its neighbors $n \pm 1$ corresponds to tossing a coin with probabilities $p_{n-1,n}$ and $1-p_{n-1,n} = p_{n+1,n}$ and transitioning according to the outcome of this coin toss. A quantum walk on the integer lattice is described by assigning a spin to every site $n \in \mathbb{Z}$, which is given by a \mathbb{C}^2 vector, and determining the transitions from n to one of its nearest neighbors $n \pm 1$ with the help of a "quantum coin," which is a unitary 2×2 matrix. The details are described in Subsection [2.4](#page-10-0) below. The upshot, following an important observation of Cantero, Grünbaum, Moral, and Velázquez in [\[5\]](#page-45-3), is the following. The time-evolution may now be described by an extended CMV matrix $\mathcal E$ in place of the Jacobi matrix J above. CMV matrices are the natural unitary analogues of

Jacobi matrices, and they play a canonical role within the class of unitary operators analogous to the canonical role played by Jacobi matrices within the class of (bounded) self-adjoint operators; see [\[33,](#page-46-1) [34\]](#page-46-2) and references therein. Thus, we are now concerned with the study of

$$
(1.2) \t\t \t\t \langle \delta_n, \mathcal{E}^k v \rangle,
$$

where $\mathcal E$ is an extended CMV matrix, and in particular a unitary operator on $\ell^2(\mathbb{Z})$. Again, this allows one to employ spectral theoretical methods to analyze the behavior of the corresponding quantum walk. In particular, one may relate continuity properties of spectral measures with respect to Hausdorff measures on the unit circle $\partial\mathbb{D}$ to spreading properties of the evolution [\(1.2\)](#page-2-0) and hence of the quantum walk; this approach was developed in [\[7\]](#page-45-5) and applied to concrete quantum walks in [\[12\]](#page-45-6).

The approach just mentioned works for arbitrary unitary operators. For extended CMV matrices, one can sometimes do better and obtain improved spreading estimates by using a different method. While the approach above is based on rewriting [\(1.2\)](#page-2-0) by means of integrals over the unit circle with respect to spectral measures, the alternative method we propose and develop in this paper rewrites [\(1.2\)](#page-2-0) by means of integrals over the unit circle with respect to normalized Lebesgue measure (i.e., the measure generated by normalized arc length). The fundamental formula is given in Lemma [3.1](#page-12-1) below and was already observed in $[7].^2$ $[7].^2$ It connects suitable averages of the quantities [\(1.2\)](#page-2-0) to integrals involving matrix elements of the resolvent of \mathcal{E} . This in turn connects time-averaged spreading to growth properties of transfer matrices, as the latter matrices are related to the properties of the resolvent probed by the integral in the fundamental formula. This connection is exceedingly useful in many cases of interest as there is a plethora of tools one can use to study the growth of transfer matrix norms. These tools are CMV analogues of tools originally developed in the Jacobi setting. In fact, some of these CMV versions are developed in the present paper.

This paper consists of two parts. The first part develops the general theory which enables one to deduce spreading estimates for the discrete time dynamics generated by an extended CMV matrix from bounds on transfer matrix norms for spectral parameters off the unit circle, which immediately gives general results when specializing to the case of quantum walks on the line (precise descriptions of the results may be found in Section [2\)](#page-4-2). These general results are analogues for extended CMV matrices of results known for discrete Schrödinger operators. The latter operators generate a continuous time evolution via the Schrödinger equation. The connection between discrete Schrödinger operators, or more generally Jacobi matrices, and CMV matrices is very fruitful and has been explored extensively in recent years. Most of the time results are proved first in the self-adjoint context and are then carried over to the unitary context. There are some notable exceptions, such as Rakhmanov's theorem. Carrying over results from the self-adjoint case to the unitary case, or more concretely from the Jacobi to the CMV setting, is sometimes straightforward, sometimes prohibitively difficult, and sometimes doable but far from straightforward. What we do in this first part of the paper falls in

the middle ground of doable but challenging. We obtain complete CMV analogues of the known Schrödinger results, but proving them required us to overcome quite a few obstacles. This is one of the cases where the ability to carry over the result should not be taken for granted but rather appreciated.

The second part presents various applications of the general theory. These applications range from simple but interesting observations to results that require a significant amount of work. Namely, in Sections [6](#page-23-1) and [8,](#page-38-0) we will discuss lower bounds for the spreading of quantum walks associated with polymer models and the Thue-Morse substitution sequence. These results are relatively easy to establish and rely on the presence of a small set of exceptional values of the spectral parameter upon which the required estimates for the transfer matrix norms hold and are straightforward to verify. Nevertheless they are interesting because the spectral measures are either difficult to study (in the Thue-Morse case) or they are so singular that the approach from [\[7\]](#page-45-5) gives no non-trivial consequence for the spreading rates (for typical realizations of random polymer models). These examples demonstrate the usefulness of the method developed in this paper, which does not rely on spectral continuity properties and yet may be able to produce pretty strong estimates.

The applications that require a substantial amount of work consider the case of quantum walks with Fibonacci coins or with periodic coins. Quantum walks with coins generated by a Fibonacci substitution sequence, discussed in Section [7,](#page-25-0) are interesting because they can exhibit anomalous transport in the sense that the transport exponents (to be defined in the next section) take fractional values. To show this, one needs to establish upper and lower bounds on the spreading behavior of the quantum walk. This is another important advantage of the method developed here over the spectral continuity approach. The latter is incapable of establishing upper bounds purely in terms of spectral continuity (the case of random polymer models neatly demonstrates this). The method put forward here, however, naturally can be used to produce two-sided estimates, and in the Fibonacci case we work out in detail how this may be implemented. This requires quite extensive analysis (which is of dynamical and combinatorial nature) but in the end it produces rather sharp estimates, especially in the regime studied here.

Finally, the case of quantum walks with periodic coins is clearly a fundamental one. Based on the analogy to the Jacobi matrix case one expects ballistic behavior to occur. That is, the walk spreads out in space with a well-defined strictly positive velocity. While such a result has been known for Schrödinger operators since 1998 [\[2\]](#page-45-13), the corresponding result for Jacobi matrices was obtained much more recently [\[11\]](#page-45-14). In Section [9](#page-39-0) we work out the analog for periodic extended CMV matrices and derive the statement for quantum walks with periodic coins as a corollary. While this happens only in the very last section of the paper, we want to emphasize that this is a fundamental quantum walk result, whose proof is in fact independent of the bulk of the paper. Readers familiar with extended CMV matrices and the CGMV connection between quantum walks on the integer lattice and extended CMV matrices may skip ahead to Section 9.

We conclude the introduction with a brief remark on the half-line case. Onesided, or standard, CMV matrices may be used to study quantum walks on \mathbb{Z}_+ , as shown also in [\[5\]](#page-45-3). The general theory we develop in part one of the paper has a natural half-line counterpart. In fact, some of the proofs are slightly simpler in this case. On the other hand, the applications we discuss in the second part of the paper all belong to the family of dynamically defined operators over invertible dynamics, and therefore are more naturally studied in the two-sided setting. One could study their half-line restrictions, but one would encounter possible discrete spectrum which changes the dynamical picture for initial states from the associated spectral subspace. To avoid cluttering the paper, we state and prove all theorems only in the two-sided case, and we describe how the theorems may be adapted to the one-sided setting.

Part 1. General Results

2. Precise Statements

2.1. Unitary Dynamics. We shall adopt the notation and development found in [\[7,](#page-45-5) [16\]](#page-45-15). Consider a unitary operator U acting on the separable Hilbert space \mathcal{H} , equipped with an orthonormal basis $\{\varphi_n\}_{n\in\mathbb{Z}}$. In this paper, we will primarily focus our attention on two closely related scenarios:

- (1) U is an extended CMV matrix acting on $\mathcal{H} = \ell^2(\mathbb{Z})$, equipped with the standard orthonormal basis $\varphi_n = \delta_n, n \in \mathbb{Z}$.
- (2) U is the one-step update rule of a quantum walk on Z, and $\mathcal{H} = \ell^2(\mathbb{Z}) \otimes \mathbb{C}^2$. If we denote the standard basis of \mathbb{C}^2 by $\{e_{\uparrow}, e_{\downarrow}\}\$, then the elementary tensors of the form

(2.1)
$$
\varphi_{2m-1} = \delta_m \otimes e_{\uparrow}, \ \varphi_{2m} = \delta_m \otimes e_{\downarrow}, \ m \in \mathbb{Z}
$$

comprise an orthonormal basis for H.

Given an intial state $\psi \in \mathcal{H}$ normalized by $\|\psi\| = 1$, we are interested in the time evolution of the vector ψ , that is, we want to study the evolution of $\psi(k) = U^k \psi$ as $k \in \mathbb{Z}_+$ grows. To quantify this, we first put

$$
a_{\psi}(n,k) = |\langle \varphi_n, \psi(k) \rangle|^2, \quad k \in \mathbb{Z}, n \in \mathbb{Z},
$$

which can be thought of as the probability that ψ is in the state φ_n at time k. We shall also be interested in the time-averaged probabilities, given by

$$
\widetilde{a}_{\psi}(n,K) = \frac{2}{K} \sum_{k=0}^{\infty} e^{-2k/K} a_{\psi}(n,k), \quad K \in \mathbb{Z}_+, n \in \mathbb{Z}.
$$

To be completely proper, the normalizing factor should really be $(1 - e^{-2/K})$ so that \tilde{a} is also a probability distribution on Z. Of course, $2/K$ is correct to first order in K, and we are primarily interested in quantities in the limit $K \to \infty$, so this distinction does not really matter. In particular, this does not affect the β 's (which will be defined below). We will be interested in such averages throughout the paper, so, for a function $f : \mathbb{Z}_{\geq 0} \to \mathbb{R}$, we introduce the notation $\langle f \rangle$ to denote the average of f . More precisely, we set

$$
\langle f \rangle(K) = \frac{2}{K} \sum_{k=0}^{\infty} e^{-2k/K} f(k).
$$

For example, in this notation, one could write $\tilde{a}_{\psi}(n, K) = \langle a_{\psi}(n, \cdot) \rangle(K)$.

Since U is a unitary operator, $||U^k \psi|| = 1$ for every k. We may then think of $U^k \psi$ as defining a probability distribution on Z. From this point of view, it makes sense to describe the spreading of these distributions in terms of their moments. More precisely, for $p > 0$, $k \in \mathbb{Z}$, and $K \in \mathbb{Z}_+$, define

$$
|X|_{\psi}^{p}(k) = \sum_{n \in \mathbb{Z}} (|n|^{p} + 1) a_{\psi}(n, k),
$$

$$
\langle |X|_{\psi}^{p} \rangle (K) = \sum_{n \in \mathbb{Z}} (|n|^{p} + 1) \widetilde{a}_{\psi}(n, K).
$$

We are interested in the spreading of states which are initially well-localized in the sense that $|X|^p_{\psi}(0) < +\infty$ for all $p > 0$. Consequently, we define

$$
\mathcal{S} = \mathcal{S}(\mathcal{H}) := \left\{ \psi \in \mathcal{H} : \lim_{|n| \to \infty} |n|^p |\langle \varphi_n, \psi \rangle| = 0 \text{ for all } p > 0 \right\}.
$$

Obviously, S depends on the choice of basis, but we will not vary the orthonormal bases of $\ell^2(\mathbb{Z})$ and $\ell^2(\mathbb{Z}) \otimes \mathbb{C}^2$ in this paper, so we will not make this dependence explicit in the notation.

Remark. It is helpful to observe that the probability of finding the wave packet outside of a ball of radius R can be used to find a simple lower bound on the moments, viz.

(2.2)
$$
|X|_{\psi}^{p}(k) \ge R^{p} \sum_{|n| \ge R} a_{\psi}(n,k), \quad \forall R > 0, k \in \mathbb{Z},
$$

(2.3)
$$
\left\langle |X|_{\psi}^{p} \right\rangle(K) \geq R^{p} \sum_{|n| \geq R} \widetilde{a}_{\psi}(n,K), \quad \forall R > 0, K \in \mathbb{Z}_{+}.
$$

In the two situations described above, there is a universal ballistic upper bound on the associated unitary dynamics; compare [\[16,](#page-45-15) Theorem 2.22]. More precisely, if U is an extended CMV matrix or the update rule of a quantum walk, $\psi \in \mathcal{S}$, and $p > 0$, then it is not hard to see that there is a constant $C = C_{\psi, p} > 0$ such that

$$
|X|_{\psi}^p(k) \leq C k^p
$$
 for all $k \in \mathbb{Z}_+$.

Consequently, we would like to compare the growth of the pth moment to polynomial growth of the form $k^{\beta p}$ for a suitable exponent $\beta \in [0,1]$. In light of this, the following transport exponents^{[3](#page-5-0)} are natural objects to consider

$$
\beta_{\psi}^{+}(p) = \limsup_{k \to \infty} \frac{\log (|X|_{\psi}^{p}(k))}{p \log(k)},
$$

 3 Some authors consider Cesàro averages for the moments, instead of the exponential averages which we consider. However, it is not hard to see that either method of averaging yields the same values for $\tilde{\beta}^{\pm}$; compare [\[16,](#page-45-15) Lemma 2.19]

$$
\beta_{\psi}^{-}(p) = \liminf_{k \to \infty} \frac{\log (|X|_{\psi}^{p}(k))}{p \log(k)},
$$

$$
\tilde{\beta}_{\psi}^{+}(p) = \limsup_{K \to \infty} \frac{\log (\langle |X|_{\psi}^{p}(K) \rangle)}{p \log(K)},
$$

$$
\tilde{\beta}_{\psi}^{-}(p) = \liminf_{K \to \infty} \frac{\log (\langle |X|_{\psi}^{p}(K) \rangle)}{p \log(K)}.
$$

By Jensen's inequality, β_{ψ}^{\pm} and β_{ψ}^{\pm} are all non-decreasing functions of p [\[16,](#page-45-15) Lemma 2.7].

2.2. CMV Matrices and the Szegő Cocycle. Given a sequence $\{\alpha_n\}_{n\in\mathbb{Z}}$ of complex numbers where $\alpha_n \in \mathbb{D} = \{z \in \mathbb{C} : |z| < 1\}$ for every $n \in \mathbb{Z}$, the associated extended CMV matrix, $\mathcal{E} = \mathcal{E}_{\alpha}$, is a unitary operator on $\ell^2(\mathbb{Z})$ defined by the matrix representation

(2.4) E = α0ρ−¹ −α0α−¹ α1ρ⁰ ρ1ρ⁰ ρ0ρ−¹ −ρ0α−¹ −α1α⁰ −ρ1α⁰ α2ρ¹ −α2α¹ α3ρ² ρ3ρ² ρ2ρ¹ −ρ2α¹ −α3α² −ρ3α² α4ρ³ −α4α³ α5ρ⁴ ρ5ρ⁴ ρ4ρ³ −ρ4α³ −α5α⁴ −ρ5α⁴ ,

where $\rho_n = (1 - |\alpha_n|^2)^{1/2}$ for every $n \in \mathbb{Z}$. We refer to $\{\alpha_n\}_{n \in \mathbb{Z}}$ as the sequence of Verblunsky coefficients of $\mathcal E$. Note that all unspecified matrix entries are implicitly assumed to be zero. As we have said in the introduction, one may also study (halfline) CMV matrices, which are given by setting $\alpha_{-1} = -1$ and restricting $\mathcal E$ to $\ell^2(\mathbb{Z}_{\geq 0}).$

For $\alpha \in \mathbb{D}$ and $z \in \partial \mathbb{D}$, the corresponding Szegő matrix is defined by

$$
S(\alpha, z) = \frac{1}{\rho} \begin{pmatrix} z & -\overline{\alpha} \\ -\alpha z & 1 \end{pmatrix}, \quad \rho = \sqrt{1 - |\alpha|^2}.
$$

The Szegő transfer matrices associated to \mathcal{E}_{α} are then defined by

$$
T(n,m;z) = \begin{cases} S(\alpha_{n-1},z) \cdots S(\alpha_m,z) & n > m \\ I & n = m \\ S(\alpha_n,z)^{-1} \cdots S(\alpha_{m-1},z)^{-1} & n < m \end{cases}
$$

where $n, m \in \mathbb{Z}$.

Our first main result says that quantitative polynomial bounds on the Szegő matrices imply quantitative lower bounds on the spreading of associated wave packets defined by iterating $\mathcal E$. The precise formulation follows.

Theorem 2.1. Let $\mathcal{E} = \mathcal{E}_{\alpha}$ be an extended CMV matrix whose Verblunsky coefficients are bounded away from ∂D in the sense that

$$
(2.5) \t\t\t M := ||\alpha||_{\infty} < 1.
$$

Suppose further that there exist $C > 0$, $\gamma \geq 0$, such that the following condition holds: for every $R \geq 1$, there exists a nonempty Borel set $A_R \subseteq \partial \mathbb{D}$ such that

(2.6)
$$
\sup_{z \in A_R} \max_{|n|, |m| \le R} ||T(n, m; z)|| \le CR^{\gamma}.
$$

For each $K \in \mathbb{Z}_+$, let $R_K = K^{1/(1+\gamma)}$ and let B_K denote the $1/K$ -neighborhood of the set A_{R_K} in $\partial \mathbb{D}$, i.e.,

$$
B_K = \left\{ z \in \partial \mathbb{D} : |z - z'| < \frac{1}{K} \text{ for some } z' \in A_{R_K} \right\}.
$$

Under the previous assumptions, there exists $\tilde{C} > 0$ such that the following bound holds for $\psi = \delta_0$:

(2.7)
$$
\sum_{|n|\geq R_K/3} \widetilde{a}_{\psi}(n,K) \geq \widetilde{C}|B_K|K^{\frac{-3\gamma}{1+\gamma}} \text{ for all } K \in \mathbb{Z}_+,
$$

where $|\cdot|$ denotes normalized Lebesgue measure on $\partial \mathbb{D}$. Thus, for each $p > 0$, there exists a constant $\widetilde{C}_p > 0$ such that

(2.8)
$$
\left\langle |X|_{\psi}^{p}\right\rangle(K) \geq \widetilde{C}_{p}|B_{K}|K^{\frac{p-3\gamma}{1+\gamma}} \text{ for all } K \in \mathbb{Z}_{+}.
$$

Remark 2.2. Let us make a few remarks about the statement of Theorem [2.1.](#page-6-0)

- (1) The assumptions of the theorem are translation-invariant. More precisely, suppose $\{\alpha_n\}_{n\in\mathbb{Z}}$ is such that there exist C, γ , and A_R as in the statement of the theorem. Then, if $\alpha'_n = \alpha_{n+k}$ for some k and all n, then there exists $C' > 0$ such that [\(2.6\)](#page-7-0) holds (with the same choices for γ and A_R).
- (2) The only step in the proof of Theorem [2.1](#page-6-0) which uses (2.5) is the step which passes between the Szegő and Gesztesy–Zinchenko cocycles (the GZ cocycle will be defined below). In particular, if α is not bounded away from $\partial \mathbb{D}$, then Theorem [2.1](#page-6-0) still holds, but with T replaced by Z .
- (3) Almost no modification is required to state and prove Theorem [2.1](#page-6-0) in the half-line setting. In particular, one need only replace [\(2.6\)](#page-7-0) by

$$
\sup_{z \in A_R} \max_{0 \le n, m \le R} ||T(n, m; z)|| \le CR^{\gamma}.
$$

The conclusions of Theorem [2.1](#page-6-0) then hold verbatim in the half-line case. The modifications to the proof are straightforward and left to the reader.

Notice that Theorem [2.1](#page-6-0) supplies nontrivial dynamical bounds even when A_R consists of a single point for large R . Indeed, this gives a simple direct proof of timeaveraged transport which is nearly ballistic (in the large p limit) for quantum walks in a Thue-Morse quasicrystal environment, and for quantum walks in a random polymer with critical energies, which we will describe in later sections. The latter example also shows that Theorem [2.1](#page-6-0) sometimes can give much more information than results which relate dynamics to fractal dimensions of spectral measures, such as [\[7,](#page-45-5) Proposition 3.9]. Specifically, in random polymer quantum walks, one expects spectral measures to be of pure point type (it should be noted that no rigorous proof of this fact exists). Thus, the results of [\[7\]](#page-45-5) give no information, while Theorem [2.1](#page-6-0) yields almost-ballistic transport (at least in the limit $p \to \infty$).

2.3. The Gesztesy–Zinchenko Cocycle and Dynamical Upper Bounds. In order to relate the Szeg˝o cocycle to quantum dynamical transport behavior, we often need to relate the Szegő cocycle to solutions to the difference equation $\mathcal{E}u = zu$ with $z \in \mathbb{C} \setminus \{0\}$ and $u \in \mathbb{C}^{\mathbb{Z}}$. To that end, consider the matrices

$$
(2.9) \quad P(\alpha, z) = \frac{1}{\rho} \begin{pmatrix} -\overline{\alpha} & z \\ z^{-1} & -\alpha \end{pmatrix}, \quad Q(\alpha, z) = \frac{1}{\rho} \begin{pmatrix} -\alpha & 1 \\ 1 & -\overline{\alpha} \end{pmatrix}, \ \alpha \in \mathbb{D}, z \in \mathbb{C} \setminus \{0\},
$$

where $\rho = (1 - |\alpha|^2)^{1/2}$ as before. Notice that

$$
\det(P(\alpha, z)) = \det(Q(\alpha, z)) = -1 \text{ for all } \alpha \in \mathbb{D}, z \in \mathbb{C} \setminus \{0\}.
$$

These matrices come from [\[19\]](#page-45-16), though we follow the convention of [\[30\]](#page-46-3) and replace α by $-\overline{\alpha}$ in Gesztesy-Zinchenko's definition (the definition of a CMV matrix in [\[19\]](#page-45-16) also replaces our α by $-\overline{\alpha}$. One may use P and Q to capture the recursion described by the difference equation $\mathcal{E}u = zu$ in the following sense. Any extended CMV matrix $\mathcal E$ enjoys a factorization $\mathcal E = \mathcal L \mathcal M$ [\[33,](#page-46-1) Proposition 4.2.4], where $\mathcal L$ and M can be decomposed as direct sums of 2×2 unitary matrices of the form

$$
\Theta(\alpha) = \begin{pmatrix} \overline{\alpha} & \rho \\ \rho & -\alpha \end{pmatrix}
$$

.

If $u \in \mathbb{C}^{\mathbb{Z}}$ is such that $\mathcal{E}u = zu$, then we define $v := \mathcal{M}u$, and we have $\mathcal{E}^{\top}v = zv$. With $\Phi(n) := (u(n), v(n))^\top$, Gesztesy and Zinchenko show that

(2.10)
$$
\Phi(n) = \begin{cases} P(\alpha_n, z)\Phi(n-1) & n \text{ is odd} \\ Q(\alpha_n, z)\Phi(n-1) & n \text{ is even} \end{cases}
$$

for all $n \in \mathbb{Z}$; see also [\[29,](#page-46-4) Proposition 3] for a generalization of this formalism to scattering zippers. This motivates the following definition. Denote $Y(n, z) =$ $P(\alpha_n, z)$ when n is odd and $Y(n, z) = Q(\alpha_n, z)$ when n is even; then, the Gesztesy-Zinchenko cocycle is defined by

(2.11)
$$
Z(n, m; z) = \begin{cases} Y(n - 1, z) \cdots Y(m, z) & n > m \\ I & n = m \\ Y(n, z)^{-1} \cdots Y(m - 1, z)^{-1} & n < m \end{cases}
$$

If u, v , and Φ are as above, we have

(2.12)
$$
\Phi(n-1) = Z(n, m; z)\Phi(m-1) \text{ for all } n, m \in \mathbb{Z}
$$

by [\(2.10\)](#page-8-0); compare [\[19,](#page-45-16) Lemma 2.2]. We will often abbreviate the names and refer to $Z(n, m; z)$ as a GZ matrix.

By using the connection with solutions of the difference equation, (and hence with Green's functions), we can use the GZ matrices to bound the tails of the wave packet; compare [\[14,](#page-45-17) Theorem 7].

Theorem 2.3. Let $\mathcal{E} = \mathcal{E}_{\alpha}$ be an extended CMV matrix, consider the initial state $\psi = \delta_{-1}$, and define

$$
\widetilde{P}_r(N,K) = \sum_{n>N} \widetilde{a}_{\psi}(n,K),
$$

$$
\widetilde{P}_l(N,K) = \sum_{n<-N} \widetilde{a}_{\psi}(n,K).
$$

If α is bounded away from $\partial \mathbb{D}$, there exists a constant $C_0 > 0$ such that

$$
(2.13) \qquad \widetilde{P}_r(N,K) \le C_0 K^3 \int_0^{2\pi} \left(\max_{1 \le n \le N} \left\| Z\left(n,0; e^{1/K + i\theta} \right) \right\|^2 \right)^{-1} \frac{d\theta}{2\pi},
$$

$$
(2.14) \qquad \widetilde{P}_l(N,K) \le C_0 K^3 \int_0^{2\pi} \left(\max_{1 \le -n \le N} \left\| Z\left(n,0; e^{1/K+i\theta}\right) \right\|^2 \right)^{-1} \frac{d\theta}{2\pi}
$$

for all $N, K \in \mathbb{Z}_+$.

We use $\psi = \delta_{-1}$ in Theorem [2.3](#page-8-1) purely for convenience; the result also holds for any finitely supported initial state (the constant C_0 will depend on the choice of the initial state).

We can also use the GZ matrices to bound the tails without averaging, at the cost of an additional power of k.

Theorem 2.4. Let $\mathcal{E} = \mathcal{E}_{\alpha}$ be an extended CMV matrix, consider the initial state $\psi = \delta_{-1}$, and define

(2.15)
$$
P_r(N,K) = \sum_{n>N} a_{\psi}(n,K),
$$

(2.16)
$$
P_l(N,K) = \sum_{n < -N} a_{\psi}(n,K).
$$

If α is bounded away from $\partial\mathbb{D}$, there exists a constant $C_0 > 0$ such that the left and right probabilities can be bounded as follows:

$$
(2.17) \t P_r(N,k) \le C_0 k^4 \int_0^{2\pi} \left(\max_{0 \le n \le N} \left\| Z\left(n,0; e^{1/k + i\theta} \right) \right\|^2 \right)^{-1} \frac{d\theta}{2\pi}
$$

$$
(2.18) \t P_r(N,k) \le C_0 k^4 \int_0^{2\pi} \left(\max_{0 \le n \le N} \| Z\left(n,0; e^{1/k + i\theta} \right) \|^2 \right)^{-1} d\theta
$$

$$
(2.18) \t P_l(N,k) \le C_0 k^4 \int_0^{\infty} \left(\max_{-N \le n \le 0} \left\| Z\left(n,0; e^{1/k + i\theta} \right) \right\|^2 \right) \frac{d\theta}{2\pi}
$$

for all $N, k \in \mathbb{Z}_+$.

These bounds on the tails imply corresponding bounds on the transport exponents in terms of bounds on the GZ matrices (averaged over the spectral parameter).

Theorem 2.5. Given $\mathcal{E} = \mathcal{E}_{\alpha}$, with α bounded away from $\partial \mathbb{D}$, suppose that there exist $C \in (0, \infty)$ and $\gamma \in (0, 1)$ such that

(2.19)
$$
\sup_{K\in\mathbb{Z}_+} K^m \int_0^{2\pi} \left(\max_{0\leq n\leq CK^\gamma} \left\| Z\left(n,0;e^{1/K+i\theta}\right) \right\|^2 \right)^{-1} \frac{d\theta}{2\pi} < \infty,
$$

and

$$
(2.20) \qquad \sup_{K \in \mathbb{Z}_+} K^m \int_0^{2\pi} \left(\max_{1 \le -n \le C K^\gamma} \left\| Z\left(n, 0; e^{1/K + i\theta} \right) \right\|^2 \right)^{-1} \frac{d\theta}{2\pi} < \infty
$$

for all $m \geq 1$. Then $\beta^+_{\psi}(p) \leq \gamma$ for every $p > 0$ and every finitely supported $\psi \in \ell^2(\mathbb{Z}).$

Remark 2.6. Let us conclude with remarks on a few extensions and variations on Theorems [2.3,](#page-8-1) [2.4,](#page-9-0) and [2.5.](#page-9-1)

(1) By general principles, $\hat{\beta}_{\psi}^{+}(p) \leq \beta_{\psi}^{+}(p)$ for any $\psi \in \mathcal{S}$ and any $p > 0$. Specifically, if $\gamma > \beta_{\psi}^+(p)$, then $|X|^p_{\psi}(k) \lesssim k^{\gamma p}$, and it is not hard to use this to show $\langle |X|_{\psi}^p \rangle (K) \lesssim K^{\gamma p}$; compare the proof of [\[10,](#page-45-18) Lemma 7.2], for example. In particular, the previous theorem immediately yields upper bounds on $\widetilde{\beta}_{\psi}^{\pm}(p)$ for finitely supported $\psi \in \ell^2(\mathbb{Z})$.

- (2) Over the course of the proofs, we use the hypothesis that α is bounded away from $\partial \mathbb{D}$ in two places: to pass between $Z(N, 0; z)$ and $Z(2|N/2|, 0; z)$ in the proof of Lemma [4.5,](#page-19-0) and, similarly, to pass between $Z(N, 0; z)$ and $Z(4|N/4|,0;z)$ in the proof of Lemma [4.9.](#page-22-1) Thus, one can modify the statements of Theorems [2.3,](#page-8-1) [2.4,](#page-9-0) and [2.5](#page-9-1) to cover the case of general α 's by restricting n to be a multiple of 4 in the maxes which appear in Theorems [2.3–](#page-8-1)[2.5.](#page-9-1)
- (3) In the half-line case, the "left probabilities" make no sense, since a state cannot propogate to the left of the origin. However, the bounds on the right probabilities (equations (2.15) and (2.17)) still hold true in the halfline setting. In particular, the correct generalization of Theorem [2.5](#page-9-1) to the half-line setting is the following: if (2.19) holds (for some C, some γ , and then all $m \ge 1$), then $\beta_{\psi}^{+}(p) \le \gamma$ for all finitely supported ψ and all $p > 0$.

2.4. Motivation: Quantum Walks on \mathbb{Z} . We now precisely describe quantum walks on the integer lattice and their relationship with extended CMV matrices, following [\[7\]](#page-45-5); see also [\[5\]](#page-45-3). A quantum walk is described by a unitary operator on the Hilbert space $\mathcal{H} = \ell^2(\mathbb{Z}) \otimes \mathbb{C}^2$, which models a state space in which a wave packet comes equipped with a "spin" at each integer site. As noted before, the elementary tensors of the form $\delta_n \otimes e_\uparrow$, and $\delta_n \otimes e_\downarrow$ with $n \in \mathbb{Z}$ comprise an orthonormal basis of H . A time-homogeneous quantum walk scenario is given as soon as coins

(2.21)
$$
C_n = \begin{pmatrix} c_n^{11} & c_n^{12} \\ c_n^{21} & c_n^{22} \end{pmatrix} \in U(2), \quad n \in \mathbb{Z},
$$

are specified. To avoid degenerate decoupling situations, we will always assume that $c_n^{11}, c_n^{22} \neq 0$. As one passes from time t to time $t + 1$, the update rule of the quantum walk is as follows,

(2.22)
$$
\delta_n \otimes e_{\uparrow} \mapsto c_n^{11} \delta_{n+1} \otimes e_{\uparrow} + c_n^{21} \delta_{n-1} \otimes e_{\downarrow},
$$

(2.23)
$$
\delta_n \otimes e_{\downarrow} \mapsto c_n^{12} \delta_{n+1} \otimes e_{\uparrow} + c_n^{22} \delta_{n-1} \otimes e_{\downarrow}.
$$

If we extend this by linearity and continuity to general elements of H , this defines a unitary operator U on H. Next, order the basis of H as in [\(2.1\)](#page-4-3), i.e. $\varphi_{2m-1} =$ $\delta_m \otimes e_\uparrow$, $\varphi_{2m} = \delta_m \otimes e_\downarrow$ for $m \in \mathbb{Z}$. In this ordered basis, the matrix representation of $U: \mathcal{H} \to \mathcal{H}$ is given by

(2.24) U = 0 0 c 21 1 c 22 1 c 11 0 c 12 ⁰ 0 0 0 0 c 21 2 c 22 2 c 11 1 c 12 ¹ 0 0 0 0 c 21 3 c 22 3 c 11 2 c 12 2 0 0 ,

which can be checked readily using the update rule (2.22) – (2.23) ; compare [\[5,](#page-45-3) Section 4].

We can connect quantum walks to CMV matrices using the following observation. If all Verblunsky coefficients with even index vanish, the extended CMV matrix in [\(2.4\)](#page-6-2) becomes

(2.25) E = 0 0 α¹ ρ¹ ρ−¹ −α−¹ 0 0 0 0 α³ ρ³ ρ¹ −α¹ 0 0 0 0 α⁵ ρ⁵ ρ³ −α³ 0 0

The matrix in (2.25) strongly resembles the matrix representation of U in (2.24) . Note, however, that $\rho_n > 0$ for all n, so [\(2.24\)](#page-10-3) and [\(2.25\)](#page-11-0) may not match exactly when c_n^{kk} is not real and positive. However, this can be easily resolved by conju-gation with a suitable diagonal unitary, as shown in [\[5\]](#page-45-3). Concretely, given U as in [\(2.24\)](#page-10-3), write

$$
c_n^{kk} = r_n \omega_n^k
$$
, $n \in \mathbb{Z}$, $k \in \{1, 2\}$, $r_n > 0$, $|\omega_n^k| = 1$,

define $\{\lambda_n\}_{n\in\mathbb{Z}}$ by

$$
\lambda_0 = 1, \lambda_{-1} = 1, \lambda_{2n} = \overline{\omega_n^2} \lambda_{2n-2}, \lambda_{2n+1} = \omega_n^1 \lambda_{2n-1},
$$

and let $\Lambda = \text{diag}(\ldots, \lambda_{-1}, \lambda_0, \lambda_1, \ldots)$. More precisely $\Lambda : \ell^2(\mathbb{Z}) \to \ell^2(\mathbb{Z}) \otimes \mathbb{C}^2$ maps δ_n to $\lambda_n \varphi_n$ for each $n \in \mathbb{Z}$ (where φ_n is as in [\(2.1\)](#page-4-3)). After a short calculation, we see that

$$
\mathcal{E}=\Lambda^*U\Lambda,
$$

where $\mathcal E$ is the extended CMV matrix corresponding to the Verblunsky coefficients

(2.26)
$$
\alpha_{2n} = 0, \quad \alpha_{2n-1} = \frac{\lambda_{2n-2}}{\lambda_{2n-1}} \cdot \overline{c_n^{21}} = -\frac{\lambda_{2n}}{\lambda_{2n+1}} c_n^{12}, \quad n \in \mathbb{Z},
$$

where equivalence of the two expressions for α_{2n-1} follows from unitarity of C_n . Notice that the hypotheses $c_n^{11}, c_n^{22} \neq 0$ imply $\rho_n > 0$ for all $n \in \mathbb{Z}$.

The reader should be warned that many authors (e.g. $[5, 7]$ $[5, 7]$) use the *transpose* of the matrix U in [\(2.24\)](#page-10-3). However, since we imagine a vector ψ as a column vector with U acting on the left, our representation is more appropriate for the present paper. For quantum dynamical purposes, this is not a major concern for the following reason. If \mathcal{E} is an extended CMV matrix, then $\mathcal{E}^{\perp} = S^* \mathcal{E}' S$, where S denotes the left shift on $\ell^2(\mathbb{Z})$ and \mathcal{E}' has Verblunsky coefficients $\alpha'_n = \alpha_{n+1}$. Since all of our theorems are stable under shifting the Verblunsky coefficients, it does not matter whether one considers U or U^{\dagger} in what follows.

Let us conclude with a few words on half-line quantum walks. A quantum walk on \mathbb{Z}_+ has state space $\mathcal{H}_+ = (\ell^2(\mathbb{Z}_+) \otimes \mathbb{C}^2) \oplus \langle \delta_0 \otimes e_{\downarrow} \rangle$, and is specified by coins $C_n \in U(2)$ for $n \geq 1$. Additionally, one specifies a reflecting boundary condition at the origin, e.g.,

$$
C_0 = \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}.
$$

With this choice of boundary condition, one can check that (2.22) and (2.23) define a unitary operator on \mathcal{H}_+^4 \mathcal{H}_+^4 , and that this update rule has the form of a half-line CMV matrix with respect to the ordered basis $\{\varphi_n : n \geq 0\}$, where φ_n is as in $(2.1).$ $(2.1).$

3. POWER-LAW BOUNDS ON SZEGŐ COCYCLES

In this section, we will prove Theorem [2.1.](#page-6-0) We begin by collecting a few useful facts. The following variant of the Parseval formula allows us to connect timeaverages of observables to averages of the resolvent over the spectral parameter.

Lemma 3.1. Suppose U is a unitary operator on $\mathcal{H}, \psi \in \mathcal{H},$ and $\{\varphi_n\}$ is an orthonormal basis of H. For all $K \in \mathbb{Z}_+$ and n, we have

$$
\sum_{k\geq 0} e^{-2k/K} a_{\psi}(n,k) = e^{2/K} \int_0^{2\pi} \left| \left\langle \varphi_n, \left(U - e^{1/K + i\theta} \right)^{-1} \psi \right\rangle \right|^2 \frac{d\theta}{2\pi}.
$$

Proof. This is [\[7,](#page-45-5) Lemma 3.16].

 \Box

Next, we will need a Gronwall-type variational estimate for the Szegő matrices. The key ingredient in this estimate is furnished by the following useful variational lemma. Throughout the remainder of this section, let α be a fixed sequence of Verblunsky coefficients which is bounded away from ∂D.

Lemma 3.2. Let $z \in \partial \mathbb{D}$ and $w \in \mathbb{C}$. Then, for $n \geq 0$, we have

(3.1)
$$
T(n,0;w) = T(n,0;z) - \sum_{\ell=0}^{n-1} (1 - z^{-1}w) T(n,\ell;z) PT(\ell,0;w),
$$

where

$$
P = \begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}.
$$

Proof. This is [\[34,](#page-46-2) Proposition 10.8.1].^{[5](#page-12-3)}

The following bound is an OPUC analog of [\[13,](#page-45-19) Lemma 2.1], which is the corresponding result for Schrödinger cocycles.

Lemma 3.3. Suppose $z \in \partial \mathbb{D}$ and $N \geq 1$. Denote

$$
L(N) = \max\{\|T(n, m; z)\| : |n|, |m| \le N\}.
$$

Then, for $\delta \in \mathbb{C}$ with $|\delta| \leq 1$, we have

(3.2)
$$
\|T(n,0;ze^{\delta})\| \le L(N) \exp(2L(N) \cdot |n| \cdot |\delta|)
$$

for all n with $|n| \leq N$.

⁴In particular, the choice of C_0 implies that $\delta_0 \otimes e_{\downarrow}$ is mapped to $\delta_1 \otimes e_{\uparrow}$ so that U maps \mathcal{H}_+ to itself.

⁵Actually, [\[34,](#page-46-2) Proposition 10.8.1] makes this statement only for $w \in \mathbb{D}$, but the proof given there in fact establishes it for all $w \in \mathbb{C}$. Alternatively, once one has [\(3.1\)](#page-12-4) for all $w \in \mathbb{D}$, the result for arbitrary $w \in \mathbb{C}$ follows immediately from analyticity.

Proof. Let us consider the case $0 \le n \le N$; the proof for $-N \le n < 0$ is similar. By (3.1) , we have

$$
T(n, 0; z e^{\delta}) = T_z(n, 0) - \sum_{\ell=0}^{n-1} (1 - e^{\delta}) T(n, \ell; z) PT(\ell, 0; z e^{\delta}).
$$

Now apply [\(3.1\)](#page-12-4) to each $T(\ell, 0; z e^{\delta})$ and iterate this procedure until all matrices correspond to energy z . Then, we obtain the estimate

$$
||T(n,0;ze^{\delta})|| \leq \sum_{k=0}^{n} {n \choose k} L(N)^{k+1} (2|\delta|)^{k}
$$

= $L(N)(1+2L(N)|\delta|)^{n}$
 $\leq L(N) \exp (2L(N)n|\delta|),$

where we have used $||P|| = 1$ and that $|1 - e^{\delta}| \le 2|\delta|$ for $\delta \in \overline{\mathbb{D}}$.

With these tools, Theorem [2.1](#page-6-0) can be deduced along the lines of [\[13\]](#page-45-19). As noted in $[8]$, the Gesztesy-Zinchenko matrices are related to the Szegő matrices via the two-step conjugacy

(3.3)
$$
z^{-1}S(\alpha, z)S(\beta, z) = D(z)P(\alpha, z)Q(\beta, z)D(z)^{-1},
$$

for all $\alpha, \beta \in \mathbb{D}$ and $z \in \mathbb{C} \setminus \{0\}$, where

$$
D(z) = \begin{pmatrix} 1 & 0 \\ 0 & z \end{pmatrix}.
$$

With this relationship in hand, we can easily relate norm estimates on the two cocycles.

Proof of Theorem [2.1.](#page-6-0) Since $M = \sup_n |\alpha_n| < 1$, we see that

(3.4)
$$
\sup_{n \in \mathbb{Z}} \rho_n \le (1 - M^2)^{-1/2} < \infty.
$$

Using this and [\(3.3\)](#page-13-0), we see that there is a constant $C_0 > 0$ (which depends only on $M = ||\alpha||_{\infty}$ such that

$$
\left\| Z\left(n,m;ze^{1/K}\right) \right\| \leq C_0 \left\| T\left(n,m;ze^{1/K}\right) \right\|
$$

for all $n, m \in \mathbb{Z}$, all $K \in \mathbb{Z}_+$, and every $z \in \partial \mathbb{D}$. Fix $K \in \mathbb{Z}_+$, and let $z \in B_K$ be given. By definition, there exists $z' \in A_{R_K}$ with $|z - z'| < 1/K$, and, by assumption, we have

$$
L=L(R_K,z'):=\sup_{|n|,|m|\leq R_K}\|T(n,m;z')\|\leq CR_K^\gamma
$$

By Lemma [3.3,](#page-12-5) we have the following for each $n \in \mathbb{Z}$ such that $1 \leq n \leq R_K$:

$$
\left\| T\left(n,0;ze^{1/K}\right) \right\| \leq L \exp\left(2L \cdot n \cdot \frac{2}{K}\right)
$$

$$
\leq C R_K^{\gamma} \exp\left(\frac{4CR_K^{\gamma+1}}{K}\right),
$$

where we have used the power-law bound [\(2.6\)](#page-7-0) in the second line. Since $R_K^{\gamma+1} = K$, this yields

$$
\left\| Z\left(n,0;ze^{1/K}\right) \right\| \leq DR_K^{\gamma} \text{ for all } 1 \leq n \leq R_K,
$$

where $D = C_0 C e^{4C}$. Next, we may enlarge D in a (K, z) -independent fashion to get

(3.5)
$$
\left\|Z\left(n,j;ze^{1/K}\right)\right\| \le DR_K^{\gamma} \text{ for all } 1 \le n \le R_K, 0 \le j \le 3.
$$

Now, take $\psi = \delta_0$, and define a pair of ℓ^2 sequences u and v by $u := (\mathcal{E} - z e^{1/K})^{-1} \psi$ and $v := \mathcal{M}u$; put $\Phi(n) = (u(n), v(n))^{\top}$, as before. Throughout the remainder of the argument C_1, C_2, \ldots will denote constants which depend solely on $\mathcal E$ (and neither on K nor z). Using (2.12) and (3.5) , we have

(3.6)
$$
\|\Phi(n)\|^2 \ge C_1 R_K^{-2\gamma} \sum_{j=-1}^2 \|\Phi(j)\|^2 \text{ for all } 1 \le n < R_K.
$$

Notice that this uses $\det(Z) = \pm 1$ to get $||Z^{-1}|| = ||Z||$ by the singular value decomposition. Since $(\mathcal{E} - ze^{1/K})u = \psi$, we have

$$
\overline{\alpha_0} \rho_{-1} u_{-1} - \overline{\alpha_0} \alpha_{-1} u_0 + \overline{\alpha_1} \rho_0 u_1 + \rho_1 \rho_0 u_2 - z e^{1/K} u_0 = \psi_0 = 1.
$$

Consequently, we have

$$
\sum_{j=-1}^{2} \|\Phi(j)\|^2 \ge C_2.
$$

Summing [\(3.6\)](#page-14-1) over $2R_K/3 < n < R_K$, we obtain the lower bound

$$
\sum_{n \geq 2R_K/3} \|\Phi(n)\|^2 \geq \sum_{R_K \geq n \geq 2R_K/3} \|\Phi(n)\|^2 \geq C_3 R_K^{1-2\gamma}.
$$

From the explicit form of M , we see that

$$
|v(n)|^2 \le C_4 \sum_{j=-1}^1 |u(n+j)|^2
$$
 for all $n \in \mathbb{Z}$.

Using this together with the definition of u , we obtain the following lower bound:

$$
(3.7) \qquad \sum_{n \ge R_K/3} \left| \left\langle \delta_n, \left(\mathcal{E} - z e^{1/K} \right)^{-1} \psi \right\rangle \right|^2 = \sum_{n \ge R_K/3} |u(n)|^2 \ge C_5 R_K^{1-2\gamma}.
$$

By Lemma [3.1,](#page-12-1) we have

$$
\widetilde{a}_{\psi}(n,K) = \frac{2}{K} \sum_{k \ge 0} e^{-2k/K} a_{\psi}(n,k)
$$

$$
= \frac{2}{K} e^{2/K} \int_0^{2\pi} \left| \left\langle \delta_n, \left(\mathcal{E} - e^{1/K + i\theta} \right)^{-1} \psi \right\rangle \right|^2 \frac{d\theta}{2\pi}
$$

.

To complete the proof, denote $B'_K = \{ \theta \in [0, 2\pi) : e^{i\theta} \in B_K \}$, and sum over $n \geq R_K/3$ to get

$$
\sum_{n \ge R_K/3} \widetilde{a}_{\psi}(n, K) \ge \frac{2}{K} e^{2/K} \int_{B'_K} \sum_{n \ge R_K/3} \left| \left\langle \delta_n, \left(\mathcal{E} - e^{1/K + i\theta} \right)^{-1} \psi \right\rangle \right|^2 \frac{d\theta}{2\pi}
$$

$$
\ge \frac{\widetilde{C}}{K} |B_K| R_K^{1-2\gamma}
$$

$$
= \widetilde{C} |B_K| R_K^{-3\gamma},
$$

which proves [\(2.7\)](#page-7-1). In the calculation above, we have used [\(3.7\)](#page-14-2) to obtain the second line and $K = R_K^{1+\gamma}$ to get the third. Applying [\(2.3\)](#page-5-1) to [\(2.7\)](#page-7-1) yields [\(2.8\)](#page-7-2).

4. Upper Bounds on Spreading

In this section, we will prove the bounds on left and right time-averaged probabilities from Theorem [2.3.](#page-8-1) The key ingredient is again Lemma [3.1,](#page-12-1) which gives us the following relation between each time-averaged single-site probability and a corresponding energy average^{[6](#page-15-1)} of a matrix element of the resolvent off of $\partial \mathbb{D}$:

(4.1)
$$
\widetilde{a}_{\delta_{-1}}(n,K) = \frac{2}{K} e^{2/K} \int_0^{2\pi} \left| \left\langle \delta_n, \left(\mathcal{E} - e^{1/K + i\theta} \right)^{-1} \delta_{-1} \right\rangle \right|^2 \frac{d\theta}{2\pi}.
$$

Let's take $\varepsilon = 1/K$, and define $G(z) = (\mathcal{E} - z)^{-1}$ for $z \in \mathbb{C} \setminus \sigma(\mathcal{E})$. Using [\(4.1\)](#page-15-2) and the inequality $e^2 < 3\pi$, we then have

(4.2)
$$
\widetilde{P}_r(N,K) < 3\varepsilon \int_0^{2\pi} M_r(N, e^{\varepsilon + i\theta}) \, d\theta,
$$

(4.3)
$$
\widetilde{P}_l(N,K) < 3\varepsilon \int_0^{2\pi} M_l(N, e^{\varepsilon + i\theta}) \, d\theta,
$$

where we have defined

(4.4)
$$
M_r(N, z) = \sum_{n > N} |\langle \delta_n, G(z) \delta_{-1} \rangle|^2,
$$

(4.5)
$$
M_l(N, z) = \sum_{n < -N} |\langle \delta_n, G(z) \delta_{-1} \rangle|^2.
$$

By symmetry, we will only prove the bounds on \widetilde{P}_r , since the argument which proves the bounds on P_l is nearly identical. The overall strategy is to approximate \mathcal{E} by suitable sequences of "truncations" which converge strongly to \mathcal{E} . One can then prove appropriate bounds on the quantities in (4.4) corresponding to the truncations (Lemmas [4.2](#page-17-0) and [4.3\)](#page-19-1). Next, one controls the error incurred in passing between $\mathcal E$ and the truncations (Lemma [4.4\)](#page-19-2). Finally, one puts all of this together to bound M_r (and hence \tilde{P}_r) in terms of the GZ cocycle (Lemma [4.5\)](#page-19-0). The remainder of the section makes this discussion precise.

Given $N \in \mathbb{Z}_+$, define four "truncated" CMV matrices \mathcal{E}_{2N} , $\widetilde{\mathcal{E}}_{2N}$, \mathcal{E}'_{4N} , and $\widetilde{\mathcal{E}}'_{4N}$ by choosing Verblunsky coefficients as follows:

$$
\alpha_{2N}(n) = \begin{cases} \alpha(n) & \text{when } n < 2N, \\ 0 & \text{when } n \geq 2N \text{ and } n \text{ even,} \\ -\frac{3}{4} & \text{when } n > 2N \text{ and } n \text{ odd,} \\ \alpha_{2N}(n) = \begin{cases} \alpha(n) & \text{when } n < 2N, \\ 0 & \text{when } n \geq 2N \text{ and } n \text{ even,} \\ \frac{3}{4} & \text{when } n > 2N \text{ and } n \text{ odd,} \end{cases}
$$

 6 We sometimes refer to the spectral parameter z as "energy," based on the analogy to the setting of discrete Schrödinger operators.

$$
\alpha'_{4N}(n) = \begin{cases} \alpha(n) & \text{when } n < 4N, \\ 0 & \text{when } n \geq 4N \text{ and } n \text{ even,} \\ (-1)^{(n+1)/2} \frac{3}{4} & \text{when } n > 4N \text{ and } n \text{ odd,} \\ \alpha'_{4N}(n) = \begin{cases} \alpha(n) & \text{when } n < 4N, \\ 0 & \text{when } n \geq 4N \text{ and } n \text{ even,} \\ (-1)^{(n-1)/2} \frac{3}{4} & \text{when } n > 4N \text{ and } n \text{ odd.} \end{cases}
$$

For convenience, let us also define

$$
\varepsilon_0 = \log\left(\frac{4}{\sqrt{7}}\right),
$$

\n
$$
\mathcal{R} = \left\{z = e^{i\theta + \varepsilon} \in \mathbb{C} : \theta \in [-\pi/4, \pi/4] \cup [3\pi/4, 5\pi/4], 0 < \varepsilon < \varepsilon_0\right\},\
$$

\n
$$
\mathcal{R}' = \left\{z = e^{i\theta + \varepsilon} \in \mathbb{C} : \theta \in [\pi/4, 3\pi/4] \cup [5\pi/4, 7\pi/4], 0 < \varepsilon < \varepsilon_0\right\}.
$$

Let $(p_+(z,n), r_+(z,n))^{\top}$ be a solution to the GZ recursion subject to the initial conditions $p_+(z, -1) = z$, $r_+(z, -1) = 1$. Similarly, let $(q_+(z, n), s_+(z, n))^{\top}$ be a solution to the GZ recursion with $q_+(z, -1) = z$, $s_+(z, -1) = -1$. More precisely,

(4.6)
$$
\begin{pmatrix} p_{+}(z,n) & q_{+}(z,n) \ r_{+}(z,n) & s_{+}(z,n) \end{pmatrix} = Z(n+1,0;z) \begin{pmatrix} z & z \ 1 & -1 \end{pmatrix},
$$

where Z is as in [\(2.11\)](#page-8-3). Since $\det(P(\alpha, z)) = \det(Q(\alpha, z)) = -1$, we easily compute the Wronskian of these solutions:

(4.7)
$$
W(z,n) := p_+(z,n)s_+(z,n) - q_+(z,n)r_+(z,n) = 2(-1)^n z.
$$

In particular, $|W| = 2|z|$ does not depend on n; moreover W is uniformly bounded on $\mathcal{R} \cup \mathcal{R}'$. Let $M_{\pm}(z)$ denote functions defined as in [\[19,](#page-45-16) (2.137)–(2.140)]. Here, M_{+} is a Carathéodory function, and M_{-} is an anti-Carathéodory function. We recall also that

(4.8)
$$
M_{+}(z) = \int_{\partial \mathbb{D}} \frac{\tau + z}{\tau - z} d\mu_{+}(\tau),
$$

where μ_{+} denotes the spectral measures of the restriction of $\mathcal E$ to the right half-line (see [\[19,](#page-45-16) (2.123) and (2.137)]). Using [\[19,](#page-45-16) (2.57), (2.61), (2.62), (3.5), and (3.7)], (splitting the CMV operator the way we do means setting $k_0 = -1$) we have

(4.9)
$$
\langle (\mathcal{E} - z)^{-1} \delta_{-1}, \delta_n \rangle = d(z) s_+(z, n) + b(z) r_+(z, n),
$$

for $n > -1$, where

(4.10)
$$
d(z) = -\frac{1 + M_{-}(z)}{2z(M_{+}(z) - M_{-}(z))}, \quad b(z) = -\frac{(1 + M_{-}(z))M_{+}(z)}{2z(M_{+}(z) - M_{-}(z))}.
$$

Let $\varepsilon > 0$ and $z \in \mathbb{C}$ with $\log |z| = \varepsilon$ be given. From [\(4.6\)](#page-16-0) and [\(4.9\)](#page-16-1), we obtain

(4.11)
$$
|b(z) - d(z)| = |\langle \delta_{-1}, (\mathcal{E} - z)^{-1} \delta_{-1} \rangle| \leq \frac{1}{e^{\varepsilon} - 1} \leq \varepsilon^{-1}.
$$

The penultimate inequality is a standard consequence of the spectral theorem, while the final inequality follows from $\varepsilon > 0$. Notice that $\text{Re}(M_+(z)) < 0$. Indeed, it is easy to see that

$$
\operatorname{Re}\left(\frac{\tau+z}{\tau-z}\right) = \frac{1-|z|^2}{|\tau-z|^2} < 0
$$

.

for every τ with $|\tau| = 1$, so, by [\(4.8\)](#page-16-2), we have Re $(M_+(z)) < 0$. Consequently,

(4.12)
$$
\arg\left(\frac{b(z)}{d(z)}\right) = \arg(M_+(z)) \in \left(\frac{\pi}{2}, \frac{3\pi}{2}\right)
$$

Combining (4.11) and (4.12) , we obtain

(4.13)
$$
|b(z)| \leq \varepsilon^{-1} \text{ and } |d(z)| \leq \varepsilon^{-1}.
$$

Notice that the bound in [\(4.13\)](#page-17-2) is a purely deterministic result. It holds for any choice of α and then for any $z \in \mathbb{C}$ with $\log|z| = \varepsilon$.

Let us consider the GZ transfer matrices $Y_{2N}(n, z)$ corresponding to the truncated Verblunsky coefficients α_{2N} . Note that for $n \geq N$, we have

$$
Y_{2N}(2n+1,z)Y_{2N}(2n,z) = \frac{1}{\sqrt{1-\left(\frac{3}{4}\right)^2}}\begin{pmatrix} z & \frac{3}{4} \\ \frac{3}{4} & z^{-1} \end{pmatrix}.
$$

This matrix has determinant 1. We can calculate that the eigenvalues are

(4.14)
$$
\lambda_{\pm} = \lambda_{\pm}(z) := \frac{2(z^2 + 1) \pm \sqrt{4z^4 + z^2 + 4}}{\sqrt{7}z}.
$$

We will wait until after Lemma [4.1](#page-17-3) to choose a branch of the square root $\sqrt{4z^4+z^2+4}$. Notice that λ_{\pm} in our notation means something different than λ_{\pm} in [\[14\]](#page-45-17). After a short calculation, we see that the eigenvectors e^{\pm} of $Y_{2N}(2n+1, z)Y_{2N}(2n, z)$ are given by

(4.15)
$$
e^{\pm} = e^{\pm}(z) = \begin{pmatrix} e_1^{\pm}(z) \\ e_2^{\pm}(z) \end{pmatrix} = \frac{1}{3} \begin{pmatrix} \sqrt{7}\lambda_{\pm}(z) - 4z^{-1} \\ 3 \end{pmatrix}
$$

for all $n \geq N$.

Lemma 4.1. For all $z \in \mathcal{R}$, one of $\lambda_{\pm}(z)$ has modulus strictly greater than 1, and the other has modulus strictly less than 1. In fact, λ_{-} is bounded away from $\partial \mathbb{D}$ on $\mathcal{R}, i.e., there exists a constant $c_0 < 1$ with $|\lambda_-(z)| < c_0$ for all $z \in \mathcal{R}$.$

Proof. Consider $\mathcal{E}_{-\infty}$, i.e., the 2-periodic extended CMV matrix with alternating Verblunsky coefficients \dots , 0, $-3/4$, 0, $-3/4$, \dots Using standard calculations from Floquet theory, one can verify that

$$
\Sigma := \sigma(\mathcal{E}_{-\infty}) = \left\{ z \in \partial \mathbb{D} : |\text{Im}(z)| \geq \frac{3}{4} \right\}.
$$

On the other hand, it is easy to see that z is a generalized eigenvalue of $\mathcal{E}_{-\infty}$ if and only if $|\lambda_+(z)| = |\lambda_-(z)| = 1$ (see [\[8,](#page-45-20) Section 3] for definitions and details). Thus, since $\mathcal{R} \cap \Sigma = \emptyset$, the first statement of the lemma follows. To verify the second statement of the lemma, simply note that λ_+ and λ_- are continuous functions of the spectral parameter away from $z = 0$ and that $\mathcal R$ is bounded away from Σ . \square

For $N \in \mathbb{Z}_+$ and $|z| > 1$, define $G_{2N}(z) = (\mathcal{E}_{2N} - z)^{-1}$.

Lemma 4.2. For $n \ge 2N \ge 4$ and $z = e^{i\theta + \varepsilon} \in \mathcal{R}$,

$$
(4.16) \qquad |\langle \delta_n, G_{2N}(z)\delta_{-1}\rangle| \lesssim \varepsilon^{-1} \frac{|z||\lambda_{-}(z)|^{\frac{n}{2}-N}}{|e_1^-(z)p_+(z, 2N-1)-r_+(z, 2N-1)|},
$$

$$
(4.17) \qquad |\langle \delta_n, G_{2N}(z)\delta_{-1}\rangle| \lesssim \varepsilon^{-1} \frac{|z||\lambda_{-}(z)|^{\frac{n}{2}-N}}{|e_1^-(z)q_+(z, 2N-1) - s_+(z, 2N-1)|}.
$$

Proof. Fix $N \in \mathbb{Z}_+$ and consider a GZ recurrence corresponding to α_{2N} . Let $u = G_{2N}(z)\delta_{-1} = (\mathcal{E}_{2N} - z)^{-1}\delta_{-1}$; then $u \in \ell^2(\mathbb{Z})$ and u satisfies $\mathcal{E}_{2N}u = zu + \delta_{-1}$; in particular, u satisfies $\mathcal{E}_{2N} u = zu$ away from site -1 . Let $v = \mathcal{M} u$ and $\Phi = (u, v)^\top$, as usual (notice that $v \in \ell^2$ also). We can write

(4.18)
$$
\Phi(2N-1) = C_+e^+ + C_-e^-,
$$

for some coefficients $C_{\pm} = C_{\pm}(z, 2N - 1) \in \mathbb{C}$, where e^{\pm} are defined in [\(4.15\)](#page-17-4). Using [\(2.12\)](#page-8-2), and $2N \geq 4$, we have

(4.19)
$$
\Phi(2m-1) = C_+ \lambda_+^{m-N} e^+ + C_- \lambda_-^{m-N} e^- \text{ for all } m \ge N.
$$

Note that [\(4.19\)](#page-18-0) doesn't hold for $\Phi(2m)$, since e^{\pm} are the eigenvalues of the two-step matrices $Y_{2N}(2n+1, z)Y_{2N}(2n, z)$. However, using

$$
Y_{2N}(2m, z) = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}
$$
 for $m \ge N$,

we must have $u(2m) = v(2m - 1)$ and $v(2m) = u(2m - 1)$ whenever $m \geq N$.

Consequently, since the entries of Φ are in ℓ^2 we must have $C_+ = 0$. We thus have

$$
\langle \delta_{2N-1}, G_{2N}(z)\delta_{-1} \rangle = u(2N-1) = C_{-}(z, 2N-1)e_1^{-}(z),
$$

and

$$
\langle \delta_{2N}, G_{2N}(z)\delta_{-1} \rangle = u(2N) = v(2N - 1) = C_{-}(z, 2N - 1)e_{2}^{-}(z).
$$

Using (4.9) , we have

$$
(4.20) \t d_{2N}(z)s_+(z, 2N-1) + b_{2N}(z)r_+(z, 2N-1) = C_-(z, 2N-1)e_1^-(z),
$$

$$
(4.21) \t d_{2N}(z)q_{+}(z, 2N-1) + b_{2N}(z)p_{+}(z, 2N-1) = C_{-}(z, 2N-1)e_{2}^{-}(z).
$$

where b_{2N} and d_{2N} are defined by [\(4.10\)](#page-16-4) with $\mathcal E$ replaced by $\mathcal E_{2N}$. More specifically, notice that $Z(n + 1, 0; z)$ only depends on $\alpha_0, \ldots, \alpha_n$. In particular, the p_+, q_+, r_+, s_+ -functions associated to $\mathcal E$ and $\mathcal E_{2N}$ agree for $-1 \le n \le 2N-1$, which suffices to prove [\(4.20\)](#page-18-1) by applying [\(4.9\)](#page-16-1). For [\(4.21\)](#page-18-2), notice that $\alpha_{2N}(2N) = 0$ implies

$$
s_+^{2N}(z, 2N) = q_+^{2N}(z, 2N - 1) = q_+(z, 2N - 1)
$$

$$
r_+^{2N}(z, 2N) = p_+^{2N}(z, 2N - 1) = p_+(z, 2N - 1),
$$

where the superscript 2N's denote quantities associated to \mathcal{E}_{2N} . Recall [\(4.7\)](#page-16-5): the Wronskian is given by

$$
W(z,n):=p_+(z,n)s_+(z,n)-q_+(z,n)r_+(z,n)=2(-1)^nz.\\
$$

Solving (4.20) and (4.21) for $C_-,$ we get

(4.22)
$$
C_{-} = \frac{Wd_{2N}}{e_{1}^{-}p_{+}(2N-1) - e_{2}^{-}r_{+}(2N-1)}
$$

(4.23)
$$
C_{-} = \frac{Wb_{2N}}{-e_1^{-}q_{+}(2N-1) + e_2^{-}s_{+}(2N-1)}.
$$

In light of [\(4.19\)](#page-18-0), this yields

$$
\langle \delta_{2m-1}, G_{2N}(z)\delta_{-1} \rangle = u(2m-1) = \frac{Wd_{2N}\lambda_{-}^{m-N}e_1^-}{e_1^-p_+(2N-1) - e_2^-r_+(2N-1)}
$$

$$
\langle \delta_{2m-1}, G_{2N}(z)\delta_{-1} \rangle = u(2m-1) = \frac{Wb_{2N}\lambda_{-}^{m-N}e_1^-}{-e_1^-q_+(2N-1) + e_2^-s_+(2N-1)}
$$

The statement of the lemma for $n \geq 2N$ odd then follows immediately from [\(4.7\)](#page-16-5), [\(4.13\)](#page-17-2), and [\(4.15\)](#page-17-4). The statement for even $n \geq 2N$ follows from

$$
\langle \delta_{2m}, G_{2N}(z)\delta_{-1} \rangle = u(2m) = v(2m - 1) \text{ for all } m \ge N.
$$

 \Box

Using a completely analogous calculation, we obtain the following lemma for the Green's function of $\widetilde{\mathcal{E}}$.

Lemma 4.3. Define $\widetilde{G}_{2N}(z) = (\widetilde{\mathcal{E}}_{2N} - z)^{-1}$ for $|z| > 1$. Then, for $z = e^{i\theta + \varepsilon} \in \mathcal{R}$ and $n \geq 2N \geq 4$, Δt

$$
(4.24) \qquad \left| \left\langle \delta_n, \widetilde{G}_{2N}(z)\delta_{-1} \right\rangle \right| \lesssim \varepsilon^{-1} \frac{|z||\lambda_{-}(z)|^{\frac{n}{2}-N}}{|e_1^-(z)p_+(2N-1,z)+r_+(2N-1,z)}
$$

$$
(4.25) \qquad \left| \left\langle \delta_n, \widetilde{G}_{2N}(z)\delta_{-1} \right\rangle \right| \lesssim \varepsilon^{-1} \frac{|z||\lambda_{-}(z)|^{\frac{n}{2}-N}}{|e_1^-(z)q_+(2N-1,z)+s_+(2N-1,z)|}
$$

Given $N \in \mathbb{Z}_+$, let us denote $\underline{N} = 2\lfloor N/2 \rfloor$. For $z \notin \partial \mathbb{D}$, define

$$
S(N, z) = \sum_{n=N+1}^{\infty} \left| \left\langle \delta_n, G_{\underline{N}}(z) \delta_{-1} \right\rangle \right|^2,
$$

$$
\widetilde{S}(N, z) = \sum_{n=N+1}^{\infty} \left| \left\langle \delta_n, \widetilde{G}_{\underline{N}}(z) \delta_{-1} \right\rangle \right|^2.
$$

Lemma 4.4. For all $z = e^{i\theta + \varepsilon} \in \mathcal{R}$, we have

(4.26)
$$
\varepsilon^2 S(N, z) \lesssim M_r(N, z) \lesssim \varepsilon^{-2} S(N, z),
$$

(4.27)
$$
\varepsilon^2 \widetilde{S}(N, z) \lesssim M_r(N, z) \lesssim \varepsilon^{-2} \widetilde{S}(N, z).
$$

Proof. Using a standard resolvent identity (e.g. [\[37,](#page-46-5) Lemma 6.5]), we get

$$
(\mathcal{E} - z)^{-1} - (\mathcal{E}_{\underline{N}} - z)^{-1} = -(\mathcal{E} - z)^{-1} (\mathcal{E} - \mathcal{E}_{\underline{N}}) (\mathcal{E}_{\underline{N}} - z)^{-1}.
$$

Since $||(\mathcal{E} - z)^{-1}|| \leq \varepsilon^{-2}$ we then have

$$
M_r(N, z) \leq S(N, z) + \varepsilon^{-2} ||(\mathcal{E} - \mathcal{E}_{\underline{N}})|| \sum_{n=N+1}^{\infty} \left| \left\langle \delta_n, \left(\mathcal{E}_{\underline{N}} - z\right)^{-1} \delta_{-1} \right\rangle \right|^2
$$

$$
\lesssim \varepsilon^{-2} S(N, z).
$$

The proof is similar for the other inequality. The proof in the \widetilde{S} case is identical. \Box **Lemma 4.5.** For all $z = e^{i\theta + \varepsilon} \in \mathcal{R}$, we have

(4.28)
$$
M_r(N,z) \lesssim \varepsilon^{-4} \left(\max_{4 \leq n \leq N} \|Z(n,0;z)\|^2 \right)^{-1}.
$$

The implicit constants depend on $M = ||\alpha||_{\infty}$, but nothing else.

Proof. The previous lemmas show us that

$$
(4.29) \quad M_r(N,z) \lesssim \varepsilon^{-4} \left| \left(\frac{\sqrt{7}}{3} \lambda_-(z) - \frac{4}{3} z^{-1} \right) p_+(\underline{N} - 1, z) - r_+(\underline{N} - 1, z) \right|^{-2},
$$

$$
(4.30) \qquad M_r(N,z) \lesssim \varepsilon^{-4} \left| \left(\frac{\sqrt{7}}{3} \lambda_-(z) - \frac{4}{3} z^{-1} \right) q_+ (\underline{N} - 1, z) + s_+ (\underline{N} - 1, z) \right|^{-2}.
$$

Notice that [\(4.29\)](#page-19-3) and [\(4.30\)](#page-20-0) implicitly use the claim from Lemma [4.1](#page-17-3) that $|\lambda_-| < c_0$ on R to uniformly bound

(4.31)
$$
\sum_{j=0}^{\infty} |\lambda_{-}(z)|^{j} \leq \frac{1}{1 - c_{0}} < \infty
$$

for all $z \in \mathcal{R}$. This step explains the need for several truncations, since we cannot have a bound like (4.31) on \mathcal{R}' , which means that we lose control of the implicit constants in that region with this pair of truncations. Let us denote

(4.32)
$$
U = \left(\frac{\sqrt{7}}{3}\lambda_-(z) - \frac{4}{3}z^{-1}\right)p_+(\underline{N}-1, z) - r_+(\underline{N}-1, z),
$$

(4.33)
$$
\widetilde{U} = \left(\frac{4}{3}z^{-1} - \frac{\sqrt{7}}{3}\lambda_-(z)\right)p_+(\underline{N}-1, z) - r_+(\underline{N}-1, z).
$$

Adding and subtracting the two equations we note that

$$
|U| + |\widetilde{U}| \ge \frac{2}{3} \left| \sqrt{7}\lambda_-(z) - 4z^{-1} \right| |p_+(\underline{N} - 1, z)|,
$$

and also

$$
|U|+|\widetilde{U}| \geq 2|r_+(\underline{N}-1,z)|.
$$

Since $|\lambda_-| < 1$ and $1 < |z| < 4/\sqrt{7}$, we must have $\sqrt{7}\lambda_-(z) - 4z^{-1} \neq 0$. This implies

(4.34)
$$
M_r(N, z) \lesssim \varepsilon^{-4} \left(|p_+(\underline{N} - 1, z)|^2 + |r_+(\underline{N} - 1, z)|^2 \right)^{-1}.
$$

We can similarly also show that

(4.35)
$$
M_r(N,z) \lesssim \varepsilon^{-4} \left(|q_+(\underline{N}-1,z)|^2 + |s_+(\underline{N}-1,z)|^2 \right)^{-1}.
$$

For the sake of notational convenience, in the following calculation let us use p_+, q_+, r_+, s_+ as a shorthand for $p_+(\underline{N-1}, z), q_+(\underline{N-1}, z), r_+(\underline{N-1}, z), s_+(\underline{N-1}, z).$ We can use [\(4.6\)](#page-16-0) to observe that

$$
||Z(\underline{N}, 0; z)||^2 = \sup_{(A, B) \neq (0, 0)} \frac{||A \begin{pmatrix} p_+ \\ r_+ \end{pmatrix} + B \begin{pmatrix} q_+ \\ s_+ \end{pmatrix}||^2}{||A \begin{pmatrix} z \\ 1 \end{pmatrix} + B \begin{pmatrix} z \\ -1 \end{pmatrix}||^2}
$$

\n
$$
\leq \sup_{(A, B) \neq (0, 0)} \frac{(|A|^2 + |B|^2) (|p_+|^2 + |q_+|^2 + |r_+|^2 + |s_+|^2)}{|A + B|^2 + |A - B|^2}
$$

\n
$$
= \frac{1}{2} (|p_+|^2 + |q_+|^2 + |r_+|^2 + |s_+|^2)
$$

\n
$$
\leq \max(|p_+|^2 + |r_+|^2, |q_+|^2 + |s_+|^2).
$$

Since α is bounded away from $\partial \mathbb{D}$, we have $Z(N,0;z) \lesssim Z(\underline{N},0;z)$, which implies $M_r(N, z) \lesssim \varepsilon^{-4} \| Z(N, 0; z) \|^{-2}.$

Observe that $M_r(n, z) \geq M_r(N, z)$ whenever $n \leq N$. Thus, the previous argument gives the following for $4 \leq n \leq N$:

$$
M_r(N, z) \le M_r(n, z) \lesssim \varepsilon^{-4} \left(||Z(n, 0; z)||^2 \right)^{-1}.
$$

Since the preceding inequality holds uniformly in $4 \le n \le N$, we get [\(4.28\)](#page-19-4). \Box

We want to extend all these results to arbitrary $\theta \in [0, 2\pi)$ by using the second pair of truncations of $\mathcal E$. We can then obtain a new version of Lemmas [4.2](#page-17-0) and [4.3.](#page-19-1) Notice that the four-step GZ matrices of the truncated CMV operators take the form

$$
Z'_{4N}(4n+4,4n;z) = \frac{1}{7} \begin{pmatrix} 16z^2 - 9 & 12(z - z^{-1}) \\ -12(z - z^{-1}) & 16z^{-2} - 9 \end{pmatrix}
$$

$$
\widetilde{Z}'_{4N}(4n+4,4n;z) = \frac{1}{7} \begin{pmatrix} 16z^2 - 9 & -12(z - z^{-1}) \\ 12(z - z^{-1}) & 16z^{-2} - 9 \end{pmatrix}
$$

for $n \geq N$. Both have eigenvalues

$$
\lambda'_{\pm}(z) = \frac{8(z^2 + z^{-2}) - 9 \pm \sqrt{(8(z^2 + z^{-2}) - 9)^2 - 49}}{7}
$$

The first has eigenvectors $v_{\pm} = (v_1^{\pm}, v_2^{\pm})^{\perp}$, given by

$$
v_1^{\pm} = \frac{1}{12(z - z^{-1})} \left(7\lambda'_{\pm} - 8(z^2 + z^{-2}) + 9\right) - \frac{2}{3}(z + z^{-1}), \quad v_2^{\pm} = 1.
$$

The second has eigenvector $(-v_1^{\pm}, 1)$ ^{\perp}. Following previous arguments, we can prove bounds for the decay of the corresponding Green's functions as before.

Lemma 4.6. Define $G'_{4N}(z) = (\mathcal{E}'_{4N} - z)^{-1}$ for $|z| > 1$. For $n \ge 4N \ge 8$ and $z=e^{i\theta+\varepsilon}\in\mathcal{R}',$

$$
(4.36) \qquad |\langle \delta_n, G'_{4N}(z)\delta_{-1}\rangle| \lesssim \varepsilon^{-1} \frac{|z||\lambda'_{-}(z)|^{\frac{n}{4}-N}}{|v_1^-(z)p_{+}(z, 4N-1)-r_{+}(z, 4N-1)|},
$$

$$
(4.37) \qquad |\langle \delta_n, G'_{4N}(z)\delta_{-1}\rangle| \lesssim \varepsilon^{-1} \frac{|z||\lambda'_{-}(z)|^{\frac{n}{4}-N}}{|v_1^-(z)q_+(z, 4N-1) - s_+(z, 4N-1)|}.
$$

Lemma 4.7. Define $\widetilde{G}'_{4N}(z) = \left(\widetilde{\mathcal{E}}'_{4N} - z\right)^{-1}$ for $|z| > 1$. For $n \ge 4N \ge 8$ and $z=e^{i\theta+\varepsilon}\in\mathcal{R}',$

 $\overline{}$

$$
(4.38)\qquad \left|\left\langle \delta_n, \widetilde{G}'_{4N}(z)\delta_{-1}\right\rangle\right| \lesssim \varepsilon^{-1} \frac{|z||\lambda'_-(z)|^{\frac{n}{4}-N}}{|v_1^-(z)p_+(4N-1,z)+r_+(4N-1,z)}
$$

$$
(4.39) \qquad \left| \left\langle \delta_n, \widetilde{G}'_{4N}(z)\delta_{-1} \right\rangle \right| \lesssim \varepsilon^{-1} \frac{|z||\lambda'_-(z)|^{\frac{n}{4}-N}}{|v_1^-(z)q_+(4N-1,z)+s_+(4N-1,z)|}
$$

For $z \notin \partial \mathbb{D}$, define

$$
S'(N, z) = \sum_{n=N+1}^{\infty} \left| \left\langle \delta_n, G'_{4\lfloor N/4 \rfloor}(z)\delta_{-1} \right\rangle \right|^2,
$$

$$
\widetilde{S}'(N, z) = \sum_{n=N+1}^{\infty} \left| \left\langle \delta_n, \widetilde{G}'_{4\lfloor N/4 \rfloor}(z)\delta_{-1} \right\rangle \right|^2.
$$

A new version of Lemma [4.4](#page-19-2) is also immediate.

Lemma 4.8. For $z = e^{i\theta + \varepsilon} \in \mathcal{R}'$, we have

(4.40)
$$
\varepsilon^2 S'(N, z) \lesssim M_r(N, z) \lesssim \varepsilon^{-2} S'(N, z),
$$

(4.41) $\varepsilon^2 \widetilde{S}'(N, z) \lesssim M_r(N, z) \lesssim \varepsilon^{-2} \widetilde{S}'(N, z).$

Notice that $v_1^-(z)$ is bounded away from zero for $z \in \mathcal{R}'$. To see this, notice that $(0,1)$ [⊤] is an eigenvector of $Z'_{4N}(4N+4,4N;z)$ if and only if $z-z^{-1}=0$, that is $z = \pm 1$. Since \mathcal{R}' is bounded away from $\{\pm 1\}$, it follows that $v_1^-(z)$ is bounded away from zero. This observation allows us to extend the arguments (and hence the conclusions) of Lemma [4.5](#page-19-0) to spectral parameters in \mathcal{R}' .

Lemma 4.9. For $z = e^{i\theta + \varepsilon} \in \mathcal{R}'$, we have

(4.42)
$$
M_r(N,z) \lesssim \varepsilon^{-4} \left(\max_{4 \leq n \leq N} \|Z(n,0;z)\|^2 \right)^{-1}.
$$

The implicit constants depend on $M = ||\alpha||_{\infty}$, but nothing else.

Proof of Theorem [2.3.](#page-8-1) Follows immediately from Lemmas [4.5](#page-19-0) and [4.9,](#page-22-1) except that we have the max in [\(2.13\)](#page-9-5) running over $n \geq 1$ instead of $n \geq 4$. However, making the appropriate adjustments only modifies the implicit constants in an N-independent fashion, so this is fine.

 \Box

5. Upper Bounds Without Averaging

By using techniques from complex analysis and a version of the residue calculus for normal operators, we can prove variants of the upper bounds from the previous section without averaging in time; compare [\[15\]](#page-45-21).

Lemma 5.1. Let \mathcal{E} be an extended CMV matrix. We have

(5.1)
$$
\langle \delta_n, \mathcal{E}^k \delta_{-1} \rangle = -\frac{1}{2\pi i} \int_{\Gamma} z^k \langle \delta_n, (\mathcal{E} - z)^{-1} \delta_{-1} \rangle dz
$$

for every $k \in \mathbb{Z}$, all $n \in \mathbb{Z}$, and every positively oriented contour Γ in $\mathbb C$ which encloses D.

Proof. This follows from the Dunford functional calculus for normal operators. See [\[17,](#page-45-22) [18,](#page-45-23) [32\]](#page-46-6).

Lemma 5.2. Let \mathcal{E} be an extended CMV matrix, and consider the unaveraged left and right probabilities P_r and P_l . We have

(5.2)
$$
P_r(N,k) \lesssim \int_0^{2\pi} \sum_{n>N} \left| \left\langle \delta_n, \left(\mathcal{E} - e^{1/k + i\theta} \right)^{-1} \delta_{-1} \right\rangle \right|^2 \frac{d\theta}{2\pi}
$$

(5.3)
$$
P_l(N,k) \lesssim \int_0^{2\pi} \sum_{n < -N} \left| \left\langle \delta_n, \left(\mathcal{E} - e^{1/k + i\theta} \right)^{-1} \delta_{-1} \right\rangle \right|^2 \frac{d\theta}{2\pi}
$$

for all $k \in \mathbb{Z} \setminus \{0\}.$

Proof. Consider the contour

$$
\Gamma = \left\{ \exp \left(k^{-1} + it \right) : 0 \le t \le 2\pi \right\}.
$$

We apply Lemma [5.1](#page-22-2) and Jensen's inequality to get

$$
P_r(N,k) = \sum_{n>N} a(n,k)
$$

= $\sum_{n>N} |\langle \delta_n, \mathcal{E}^k \delta_{-1} \rangle|^2$
 $\lesssim \sum_{n>N} \int_0^{2\pi} \left| \langle \delta_n, \left(\mathcal{E} - e^{1/k + i\theta} \right)^{-1} \delta_{-1} \rangle \right|^2 \frac{d\theta}{2\pi},$

which proves (5.2) . The proof of (5.3) is nearly identical.

 \Box

.

With these pieces in place, we are now able to prove Theorem [2.4](#page-9-0) very easily.

Proof of Theorem [2.4.](#page-9-0) Follow the proof of Theorem [2.3,](#page-8-1) but replace (4.2) and (4.3) with Lemma [5.2.](#page-22-5) More specfically, we have

$$
P_r(N,k) \lesssim \int_0^{2\pi} M_r\left(N, e^{1/k+i\theta}\right) \frac{d\theta}{2\pi}
$$

$$
\lesssim k^4 \int_0^{2\pi} \left(\max_{0 \le n \le N} \left\|Z\left(n, 0; e^{1/k+i\theta}\right)\right\|^2\right)^{-1} \frac{d\theta}{2\pi}
$$

The first inequality is (5.2) , and the second is Lemma [4.5.](#page-19-0) The bound on P_l works similarly. \Box

We can use this to prove the bound on the β 's from Theorem [2.5.](#page-9-1)

Proof of Theorem [2.5.](#page-9-1) For $\psi = \delta_{-1}$, this follows immediately from Theorem [2.4.](#page-9-0) More precisely, the assumption [\(2.19\)](#page-9-4) together with Theorem [2.4](#page-9-0) implies that $P_r(Ck^{\gamma}, k) + P_l(Ck^{\gamma}, k)$ goes to zero as $k \to \infty$ faster than k^{-s} for any $s > 0$. Enlarging C if necessary, we may assume that $a_{\psi}(n, k) = 0$ whenever $|n| > Ck + C$. This implies

$$
|X|_{\psi}^{p}(k) = \sum_{n \in \mathbb{Z}} (|n|^{p} + 1) a_{\psi}(n, k)
$$

=
$$
\sum_{\substack{|n| \leq Ck^{\gamma} \\ \leq Ck^{\gamma p} + 1}} (|n|^{p} + 1) a_{\psi}(n, k) + \sum_{\substack{Ck^{\gamma} < |n| \leq Ck + C \\ \leq Ck^{\gamma p} + 1 + (Ck + C)^{p} (P_{r}(Ck^{\gamma}, k) + P_{l}(Ck^{\gamma}, k)) .}} (|n|^{p} + 1) a_{\psi}(n, k)
$$

for all $k \in \mathbb{Z}_+$ and $p > 0$. Consequently, we obtain the theorem for $\psi = \delta_{-1}$. For $\psi = \delta_n$ with $n \in \mathbb{Z}$, the theorem follows by applying the case $\psi = \delta_{-1}$ to the CMV operator $S^{n+1}\mathcal{E}S^{-n-1}$, where $S:\ell^2(\mathbb{Z})\to\ell^2(\mathbb{Z})$ denotes the left shift. The result for finitely supported ψ 's is then obvious.

Part 2. Examples

6. Delocalization for Quantum Walks in Polymers

6.1. Setting. We describe a quantum walk analog of polymer models; compare [\[21\]](#page-45-24). Fix a finite subset $\mathcal{A} \subseteq U(2)$, and let $\mathcal{A}^* = \bigcup_{j=0}^{\infty} \mathcal{A}^j$ denote the free monoid over A , that is, the set of all finite words which can be obtained by concatenating elements of A. A polymer model is given as soon as one chooses $n \geq 2$ and elements

 $u_1, \ldots, u_n \in \mathcal{A}^*$, which we call the *basic chains* of the model. Denote the length of the basic chains by $L_j := |u_j|$ for each j. We can then define the family of quantum walks generated by these basic chains to be those whose sequences of coins may be obtained by concatenating elements of $\{u_1, \ldots, u_n\}$; this can be made precise using a suspension-like construction. More formally, let $\Omega = \{1, \ldots, n\}^{\mathbb{Z}}$, and put $C_j = {\omega \in \Omega : \omega_0 = j}, \Omega_j = C_j \times \{1, \ldots, L_j\}.$ Finally, consider

$$
\widetilde{\Omega} = \bigcup_{j=1}^{n} \Omega_{j}.
$$

Now, define the suspended shift $\tilde{T}: \tilde{\Omega} \to \tilde{\Omega}$ as follows: for $\tilde{\omega} = (\omega, k) \in \tilde{\Omega}$, put

$$
\widetilde{T}(\widetilde{\omega}) = \begin{cases}\n(\omega, k+1) & k < L_{\omega_0} \\
(T\omega, 1) & k = L_{\omega_0}\n\end{cases}
$$

where $T : \Omega \to \Omega$ is the usual left shift, defined by $(T\omega)_n = \omega_{n+1}$ for each $n \in \mathbb{Z}$. Finally, for each $\tilde{\omega} \in \Omega$, we define the update rule $U_{\tilde{\omega}}$ by choosing coins as follows:

$$
C_{\widetilde{\omega},n} = f\left(\widetilde{T}^n \widetilde{\omega}\right),\,
$$

where $f(\omega, k) = u_{\omega_0}(k)$. This is all a rather long-winded way of saying that the sequence of coins of $U_{(\omega,k)}$ is obtained by concatenating $\dots, u_{\omega-1}, u_{\omega_0}, u_{\omega_1}, \dots$ with the position of the origin normalized by k. For each j let $T_i(z)$ denote the Szegő transfer matrix across the coin sequence u_i at spectral parameter z. More precisely, choose any element $\omega \in \Omega_i$, put $\tilde{\omega} = (\omega, 1) \in \Omega$, associate Verblunsky coefficients $\alpha_{\tilde{\omega}}$ as in [\(2.26\)](#page-11-1), and then define

$$
T_j(z) = z^{-L_j} S(\alpha_{\widetilde{\omega}}(2L_j - 1), z) \cdots S(\alpha_{\widetilde{\omega}}(-2), z).
$$

We say that $z \in \partial \mathbb{D}$ is a *critical energy* for the random polymer model if the folloing three conditions hold:

- (1) $|\text{tr}(T_j(z))| \leq 2$ for every $1 \leq j \leq n$.
- (2) $T_j(z)T_k(z) = T_k(z)T_j(z)$ for all $1 \leq j, k \leq n$.
- (3) If $|\text{tr}(T_j(z))| = 2$, then $T_j(z) = \pm I$.

Of course, the Lyapunov exponent vanishes at critical energies, and so any critical energy is contained in the spectrum of every operator of the form $\mathcal{E}_{\tilde{\omega}}$ with $\tilde{\omega} \in \Omega$.

Example 6.1. It is not too hard to construct polymer models with critical energies. For example, notice that

$$
S(\alpha, 1)S(0, 1)S(-\alpha, 1)S(0, 1) = I
$$

for all $\alpha \in \mathbb{D}$. In particular, $z = 1$ is a critical energy for any random polymer model with basic chains of the form $(R_{\theta}, R_{-\theta})$ with $\theta \in (\frac{\pi}{2}, \frac{\pi}{2})$.

In Section [8,](#page-38-0) we will study the a quantum walk modelled on the Thue–Morse subshift. This can also be incorporated into the framework of polymer models, and we will see that this model has many critical energies.

Theorem 6.2. Given a polymer model with a critical energy $z_0 \in \partial \mathbb{D}$, one has $\widetilde{\beta}^{\pm}_{\delta_0}(p) \geq 1 - \frac{1}{p}.$

Proof. Let z_0 denote a critical energy, and put $A_R = \{z_0\}$ for all $R > 0$. Using the definition of critical energy, we can choose $C_0 > 0$ so that (2.6) holds for all $R > 0$ with $\gamma = 0$. Since $|B_K| = 2K^{-1}$, we deduce $\langle |X|_{\delta_0}^p \rangle (K) \gtrsim K^{p-1}$ from [\(2.8\)](#page-7-2). Thus, we get $\widetilde{\beta}_{\delta_0}^-(p) \geq 1 - \frac{1}{p}$. 7. The Fibonacci Quantum Walk

7.1. Setting. In this section, we will discuss a time-homogeneous quantum walk on $\mathbb Z$ with two coins, whose distribution on the line is modulated by the Fibonacci subshift. We will apply both of our general theorems to deduce upper and lower bounds on the corresponding quantum walk. This is by far the most substantial application of our methods; it will require the most effort in order to verify the inputs needed to apply the general theorems. The key observation here is that one can restrict the range of parameters in such a way that the spectra of the canonical periodic approximants exhibit the same combinatorial structure that one sees in the Schrödinger case; compare $[31]$. Since our goal is to demonstrate the use of the transfer matrix method in quantum dynamics, we will freely make various simplifications throughout this section in order to increase clarity (without removing any of the essential obstacles). In particular, we do not attempt to locate optimal parameter ranges, nor do we attempt to find optimal constants in our proofs.

First, we recall how the Fibonacci sequence and subshift are generated. Consider an alphabet A with two symbols, $A = \{a, b\}$, and let A^* denote the free monoid generated by A , i.e., the set of all finite words obtained by concatenating elements of A. The Fibonacci substitution S sends a to ab and b to a. Naturally, S can be extended by concatenation to maps $\mathcal{A}^* \to \mathcal{A}^*$ and $\mathcal{A}^{\mathbb{Z}_+} \to \mathcal{A}^{\mathbb{Z}_+}$ which we will also denote by S . The Fibonacci sequence, which we denote by u_F , is the unique element of $\mathcal{A}^{\mathbb{Z}_+}$ that is invariant under S. It is the limit of the words $s_n = S^n(a)$ as $n \to \infty$ in an obvious sense. More precisely, with $s_0 = a$, $s_1 = ab$, $s_2 = aba$, etc., we see that s_n is a prefix of s_{n+1} for all n, so we define u_F to be the unique sequence in $\mathcal{A}^{\mathbb{Z}_+}$ which has s_n as a prefix for every $n \geq 0$:

$$
u_{\rm F}=abaababaabaab\ldots.
$$

The Fibonacci subshift Ω_F is then defined to be the dynamical hull of u_F in $\mathcal{A}^{\mathbb{Z}}$, the space of two-sided sequences over A ; more precisely,

 $\Omega_{\text{F}} = \{ \omega \in \mathcal{A}^{\mathbb{Z}} : \text{every finite subword of } \omega \text{ occurs in } u_{\text{F}} \}.$

To generate a quantum walk in a Fibonacci environment, choose $\theta_a, \theta_b \in \left(-\frac{\pi}{2}, \frac{\pi}{2}\right)$, and consider the rotations

$$
R_a = \begin{pmatrix} \cos \theta_a & -\sin \theta_a \\ \sin \theta_a & \cos \theta_a \end{pmatrix}, \quad R_b = \begin{pmatrix} \cos \theta_b & -\sin \theta_b \\ \sin \theta_b & \cos \theta_b \end{pmatrix}.
$$

Given $\omega \in \Omega_F$, we associate a sequence of coins $\{C_{\omega,n}\}_{n\in\mathbb{Z}}$ via $C_{\omega,n} = R_{\omega_n}$. The associated unitary operator will be denoted by U_{ω} . Inspecting [\(2.26\)](#page-11-1) one sees that U_{ω} already has the form of an extended CMV matrix with Verblunsky coefficients

 $\alpha_{2n-1} = \sin(\theta_{\omega_n}), \quad \alpha_{2n} = 0$, for all $n \in \mathbb{Z}$.

We will therefore denote U_{ω} by \mathcal{E}_{ω} to emphasize this fact. Notice also that we must avoid $\pm \pi/2$, for if either θ_a or θ_b is $\pm \pi/2$, then we have $|\alpha_{2n-1}| = 1$ for infinitely many $n \in \mathbb{Z}$, so \mathcal{E}_{ω} decouples into a direct sum of finite blocks, which means that the dynamics are trivially localized. By a standard argument using minimality and strong operator approximation, there is a uniform compact set $\Sigma = \Sigma(\theta_a, \theta_b) \subseteq \partial \mathbb{D}$ such that $\Sigma = \sigma(\mathcal{E}_{\omega})$ for every $\omega \in \Omega_F$. To avoid cluttering the notation, we will suppress the dependence of the various objects in this section on the choice of θ_a and θ_h .

We now consider the initial state $\psi = \delta_0$ and study the spreading in space of $\mathcal{E}_{\omega}^n \psi$ as $|n| \to \infty$. For the sake of clarity and simplicity, we will focus on the dynamics generated by the element $\omega_0 \in \Omega_F$ obtained by applying S^2 iteratively to the germ b|a, where the vertical bar separates sites 0 and 1. We may write $\omega_0 = u_F^R ab|u_F$, where u^R denotes the reversal of the word u. Thus, ω_0 agrees with u_F on \mathbb{Z}_+ , and it has the reflection symmetry

(7.1)
$$
\omega_0(-n) = \omega_0(n-1) \text{ for all } n \in \mathbb{Z} \setminus \{0,1\}.
$$

Equivalently, one may write

(7.2)
$$
\omega_0(n) = \begin{cases} a & \{n\varphi^{-1}\} \in [1 - \varphi^{-1}, 1) \\ b & \{n\varphi^{-1}\} \in [0, 1 - \varphi^{-1}) \end{cases},
$$

where $\{x\} = x - \lfloor x \rfloor$ denotes the fractional part of $x \in \mathbb{R}$ and $\varphi = \frac{\sqrt{5}+1}{2}$ denotes the golden ratio. One can deduce [\(7.2\)](#page-26-0) from [\[3,](#page-45-25) Lemma 1], for example.

The structure of the remainder of the section is as follows: In Subsection [7.2,](#page-26-1) we describe the trace-map formalism for the operators \mathcal{E}_{ω} , and we state our dynamical bounds precisely in terms of quantities associated to the trace map. Subsection [7.3](#page-27-0) contains a complete proof of the main theorem, modulo a pair of lemmas which contain some technical estimates on the trace map and on the growth of the Gesztesy– Zinchenko cocycle for this model. Subsection [7.4](#page-32-0) works out a version of Raymond's combinatorial analysis of the spectrum in this setting. Finally, in Subsection [7.5,](#page-34-0) we prove the technical estimates from Lemmas [7.8](#page-30-0) and Lemma [7.9.](#page-30-1)

7.2. Trace-Map Formalism and Fricke-Vogt Invariant. In this section, we fix $\alpha = \alpha_{\omega_0}$ and $\mathcal{E}_0 = \mathcal{E}_{\alpha_{\omega_0}}$. The renormalization map for the Fibonacci sequence will play a key role in our analysis. More concretely, define

$$
M_n(z)=Z(2F_n,0;z),\;n\geq 0,\;z\in\mathbb{C}\setminus\{0\},
$$

where Z denotes the Gesztesy–Zinchenko cocycle as before, and F_n denotes the nth Fibonacci number, normalized by $F_{-1} = F_0 = 1$. We also define

$$
M_{-1}(z) = \sec \theta_b \begin{pmatrix} z & -\sin \theta_b \\ -\sin \theta_b & z^{-1} \end{pmatrix}, \ z \in \mathbb{C} \setminus \{0\}.
$$

The hierarchical structure of the Fibonacci substitution word produces a recursive relationship amongst these matrices, viz.

(7.3)
$$
M_{n+1}(z) = M_{n-1}(z)M_n(z) \text{ for all } n \ge 0 \text{ and all } z \in \mathbb{C}.
$$

By the Cayley-Hamilton Theorem, this leads to a recursion amongst the half-traces $x_n := \frac{1}{2} \text{tr}(M_n(z))$, namely,

(7.4)
$$
x_{n+2} = 2x_n x_{n+1} - x_{n-1} \text{ for all } n \ge 0.
$$

As a consequence of this recursion, the traces have a first integral given by the so-called Fricke–Vogt invariant. More precisely, if we define

$$
I(u, v, w) = u2 + v2 + w2 - 2uvw - 1,
$$

then

(7.5)
$$
I(x_{n+1}, x_n, x_{n-1}) = I(x_{n+2}, x_{n+1}, x_n) \text{ for all } n \ge 0.
$$

Consequently, by abusing notation, we will write $I(z) := I(x_{k+1}(z), x_k(z), x_{k-1}(z))$ for $k \geq 0$ and $z \in \mathbb{C}$. Evidently, $M_k(z)$ is the monodromy matrix for a periodic operator whose sequence of coins is defined by the sequence $\omega_k \in \mathcal{A}^{\mathbb{Z}}$ which repeats s_k periodically. By Floquet theory, the spectra of these periodic operators are given by

$$
\sigma_k:=\{z\in\partial\mathbb{D}:|x_k(z)|\leq 1\},\;k\geq -1.
$$

In this setting, the role of the coupling constant may be played by

(7.6)
$$
\mu = \mu(\theta_a, \theta_b) := \inf_{k \ge -1} \min_{z \in \sigma_k} I(z).
$$

Let us also define

$$
(7.7) \ \kappa = \kappa(\theta_a, \theta_b) = |\sec \theta_a \tan \theta_b - \tan \theta_a \sec \theta_b| = |\sec \theta_a||\sec \theta_b||\sin \theta_a - \sin \theta_b|.
$$

We can now state our main theorem, which describes the dynamics defined by \mathcal{E}_0 in the quantum walk analog of the large coupling limit.

Theorem 7.1. Let $\pi/4 < \theta_b < \pi/2$ be given. There exist constants $m = m(\theta_b)$, $M = M(\theta_b)$, and $\lambda = \lambda(\theta_b)$ such that if $\theta_b < \theta_a < \pi/2$ with $\mu \geq \lambda$, one has

$$
(7.8) \qquad \frac{1}{1+\tau} - \frac{3\tau + \eta}{p(1+\tau)} = \frac{p-3\tau - \eta}{p(1+\tau)} \le \widetilde{\beta}_{\delta_0}^-(p) \le \beta_{\delta_0}^+(p) \le \frac{2\log\varphi}{\log\xi},
$$

where

(7.9)
$$
\xi = m\sqrt{\mu}, \quad \Xi = M\sqrt{\mu}, \quad \eta = \frac{\log \Xi}{\log \varphi} - 1, \quad \tau = \frac{2\log ((\kappa + 2)(2\kappa + 5)^2)}{\log \varphi},
$$

and κ is as in [\(7.7\)](#page-27-1). In particular, $\beta_{\delta_0}^+(p)$ goes to zero at least as fast as constant/ $\log \sqrt{\mu}$ as $\mu \to \infty$.

Remark 7.2. A few remarks are in order.

- (1) The conclusion of the theorem likely still holds with $\mu = \min_{z \in \Sigma} I(z)$. However, our choice of μ makes the proofs somewhat easier, so we use [\(7.6\)](#page-27-2) to make the exposition more digestible.
- (2) Our method of proof for the lower bounds can allow $0 < \theta_b \leq \pi/4$, but the proof of upper bounds breaks at $\theta_b = \pi/4$. However, on heuristic grounds, one may still expect that $\beta \searrow 0$ as $\theta_a \nearrow \pi/2$ for other values of θ_b .
- (3) For any $k \geq 0$, let $s_k = S^k(a)$ and $s'_k = S^k(b)$. Every $\omega \in \Omega_F$ may be decomposed as a concatenation of subfactors of the form s_k and s'_k in a unique way; this is known as the k-partition of ω . Theorem [7.1](#page-27-3) can be extended to arbitrary elements of Ω_F by analyzing various possibilities for the k-partition near the origin, but we will not present the details, since this clutters the presentation without adding substantial new content.

7.3. Proof of Theorem [7.1.](#page-27-3) First, for Theorem [7.1](#page-27-3) to have any interesting content, we need to verify that μ may indeed be made arbitrarily large by suitably choosing θ_a and θ_b . To that end, let us begin by computing I as a function of z. This is done in [\[12\]](#page-45-6), but there are a couple of typos and a sign error, and, most

importantly, we have a substantially simpler expression for $I(z)$. For these reasons, we produce a corrected calculation here for the official record.^{[7](#page-28-0)} We have

$$
M_0(z) = \sec \theta_a \begin{pmatrix} z & -\sin \theta_a \\ -\sin \theta_a & z^{-1} \end{pmatrix}
$$

$$
M_1(z) = \sec \theta_a \sec \theta_b \begin{pmatrix} z^2 + \sin \theta_a \sin \theta_b & * \\ * & \sin \theta_a \sin \theta_b + z^{-2} \end{pmatrix}.
$$

Thus, for $z \in \partial \mathbb{D}$, we have

(7.10) $x_{-1}(z) = \text{Re}(z) \sec \theta_b, \quad x_0(z) = \text{Re}(z) \sec \theta_a,$

(7.11)
$$
x_1(z) = \text{Re}(z^2) \sec \theta_a \sec \theta_b + \tan \theta_a \tan \theta_b.
$$

Consequently,

$$
I(z) = \text{Re}(z)^{2} (\sec^{2} \theta_{a} + \sec^{2} \theta_{b}) + (\text{Re}(z^{2}) \sec \theta_{a} \sec \theta_{b} + \tan \theta_{a} \tan \theta_{b})^{2}
$$

$$
- 2\text{Re}(z)^{2} \sec \theta_{a} \sec \theta_{b} (\text{Re}(z^{2}) \sec \theta_{a} \sec \theta_{b} + \tan \theta_{a} \tan \theta_{b}) - 1
$$

for all $z \in \partial \mathbb{D}$.

Lemma 7.3. For every $z \in \partial \mathbb{D}$, we have

(7.12)
$$
I(z) = \kappa^2 (\text{Im}(z))^2.
$$

Proof. Let $z = e^{it} \in \partial \mathbb{D}$ be given. To compactify notation a bit, denote

$$
c_a = \cos \theta_a, \quad \rho_a = \sec \theta_a, \quad s_a = \sin \theta_a, \quad t_a = \tan \theta_a
$$

\n
$$
c_b = \cos \theta_b, \quad \rho_b = \sec \theta_b, \quad s_b = \sin \theta_b, \quad t_b = \tan \theta_b
$$

\n
$$
c = \text{Re}(z) = \cos t, \quad s = \text{Im}(z) = \sin t, \quad c_2 = \text{Re}(z^2) = \cos(2t).
$$

We have seen above that

$$
I(z) = c2(\rho_a^2 + \rho_b^2) + (c_2 \rho_a \rho_b + t_a t_b)^2 - 2c^2 \rho_a^2 \rho_b^2 (c_2 + s_a s_b) - 1.
$$

After liberally using trigonometric identities, one can deduce [\(7.12\)](#page-28-1). The detailed calculation follows:

$$
I = c^{2}(\rho_{a}^{2} + \rho_{b}^{2}) + (c_{2}\rho_{a}\rho_{b} + t_{a}t_{b})^{2} - 2c^{2}\rho_{a}^{2}\rho_{b}^{2}(c_{2} + s_{a}s_{b}) - 1
$$

\n
$$
= \rho_{a}^{2}\rho_{b}^{2}(c^{2}(c_{a}^{2} + c_{b}^{2}) + (c_{2} + s_{a}s_{b})^{2} - 2c^{2}c_{2} - 2c^{2}s_{a}s_{b}) - 1
$$

\n
$$
= \rho_{a}^{2}\rho_{b}^{2}(c^{2}(c_{a}^{2} + c_{b}^{2}) - c_{2} + s_{a}^{2}s_{b}^{2} - 2s^{2}s_{a}s_{b}) - 1
$$

\n
$$
= \rho_{a}^{2}\rho_{b}^{2}((1 - s^{2})(c_{a}^{2} + c_{b}^{2}) + 2s^{2} - 1 + (1 - c_{a}^{2})(1 - c_{b}^{2}) - 2s^{2}s_{a}s_{b}) - 1
$$

\n
$$
= \rho_{a}^{2}\rho_{b}^{2}(s^{2}(s_{a}^{2} + s_{b}^{2}) - 2s^{2}s_{a}s_{b} + c_{a}^{2}c_{b}^{2}) - 1
$$

\n
$$
= \rho_{a}^{2}\rho_{b}^{2}s^{2}(s_{a} - s_{b})^{2}
$$

\n
$$
= (\text{Im}(z))^{2} (\sec \theta_{a} \tan \theta_{b} - \tan \theta_{a} \sec \theta_{b})^{2},
$$

which proves (7.12) . The third line is obtained by expanding the binomial square and using the identities $c_2 = 2c^2 - 1 = c^2 - s^2$. The fourth line uses $c_2 = 1 - 2s^2$ and the Pythagorean identity. The fifth line is simple algebra (and uses the Pythagorean identities some more).

Remark 7.4. From the expression in [\(7.12\)](#page-28-1), we make several observations.

⁷Note that [\[12\]](#page-45-6) uses the Szegő transfer matrices $\widetilde{M}_n(z) = z^{-F_n}T(2F_n, 0; z)$, and we use the GZ transfer matrices. In light of [\(3.3\)](#page-13-0), this does not affect the value of $x_k(z)$ for $z \in \partial \mathbb{D}$, and therefore does not affect $I(z)$ for such z.

- (1) The invariant is always nonnegative on the spectrum. Indeed, for any $z \in \partial \mathbb{D}, I(z) \geq 0.$
- (2) One cannot make the invariant uniformly large on $\partial \mathbb{D}$ by suitably choosing θ_a , θ_b . Indeed, one always has $I(1) = I(-1) = 0$.
- (3) For any fixed θ_b , one has

$$
\lim_{\theta_a \nearrow \pi/2} \kappa(\theta_a, \theta_b) = \infty.
$$

Thus, for fixed θ_b , we would like to think of $\theta_a \approx \pi/2$ as the quantum walk analog of the large coupling regime. We will see later that one can force the spectrum away from ± 1 for some parameters, which allows us to make the invariant uniformly large on Σ .

(4) Similarly, we think of $\theta_a \approx \theta_b$ as the "small coupling regime," since we can make I uniformly small on $\partial \mathbb{D}$ by making θ_a and θ_b sufficiently close.

Let us note that we can characterize the uniform spectrum of \mathcal{E}_{ω} as the dynamical spectrum, i.e., the set of complex energies at which the associated trace map has a bounded orbit. More precisely:

Proposition 7.5. Fix $\theta_a, \theta_b \in \left(-\frac{\pi}{2}, \frac{\pi}{2}\right)$, let Σ denote the uniform spectrum of every \mathcal{E}_{ω} with $\omega \in \Omega_{\text{F}}$, and put

$$
B_{\infty} = \left\{ z \in \mathbb{C} : (x_n(z))_{n=-1}^{\infty} \text{ is a bounded sequence} \right\}.
$$

Then $\Sigma = B_{\infty}$.

Proof. The inclusion $\Sigma \subseteq B_{\infty}$ is in [\[12,](#page-45-6) Lemma 2.3]. The other inclusion can be proved using ideas from Iochum–Testard [\[20\]](#page-45-26). Namely, given $z \in B_{\infty}$, one can linearize the matrix recursion as in [\[20\]](#page-45-26) and use the assumption of bounded traces to derive a power-law upper bound on the norms of the matrices $||Z(n, 0; z)||$ with $n \in \mathbb{Z}$. Indeed, this proof is nearly identical to the proof of Lemma [7.9.](#page-30-1) Once one has a power-law bound on the growth of the transfer matrices, the z in question belongs to the spectrum by general principles (e.g., [\[8,](#page-45-20) Theorem 6]).

In order to decide whether or not a given $z \in \partial \mathbb{D}$ is a member of B_{∞} , it is helpful to have a computable condition which guarantees escape of the corresponding trace orbit. The following statement is not hard to prove; it is [\[9,](#page-45-27) Lemma 4.3] applied to the special case $\alpha = \varphi^{-1}$.

Lemma 7.6. Fix $z \in \mathbb{C}$ and $\delta \geq 0$. If there exists $k_0 \geq 0$ such that

$$
(7.13) \t|x_{k_0}(z)| > 1 + \delta, \t|x_{k_0+1}(z)| > 1 + \delta, \t and \t|x_{k_0+1}(z)| > |x_{k_0-1}(z)|,
$$

then the sequence $(x_k(z))_{k=-1}^{\infty}$ is unbounded. Moreover, if [\(7.13\)](#page-29-0) holds, then $|x_{k_0+j}(z)| \ge (1+\delta/2)^{F_{j-1}}$ for all $j \ge 0$.

We are now able to verify that the Fricke–Vogt invariant can be made uniformly large on the spectrum in the large coupling regime.

Proposition 7.7. For any $\lambda > 0$, there exist choices of $\theta_a, \theta_b > 0$ such that $\mu \geq \lambda$. More specifically, for any $0 < \theta_b < \frac{\pi}{2}$, there exists $\phi_0 = \phi_0(\theta_b) > \theta_b$ such that $I(z) \geq \lambda$ for all $z \in \sigma_k$ and all $k \geq -1$ whenever $\phi_0 < \theta_a < \frac{\pi}{2}$.

Proof. We will show that we can force the spectrum into the cone where the invariant is large by forcing the escape condition to hold for $k_0 = 0$ and $\delta = 0$ in a

suitable cone containing the real axis. Fix $\theta_b > 0$, and suppose $\theta_a > \theta_b$ is large enough that

(7.14)
$$
\kappa^2 = (\sec \theta_a \tan \theta_b - \tan \theta_a \sec \theta_b)^2 \ge \frac{\lambda}{\sin^2 \theta_b}
$$

(7.15)
$$
(2\cos^2\theta_b-1)+\sin\theta_a\sin\theta_b>\cos\theta_a.
$$

Notice that the second condition can be satisfied by taking θ_a sufficiently close to $+\pi/2$, since

$$
2\cos^2\theta_b - 1 + \sin\theta_b > \cos^2\theta_b > 0.
$$

Now, recall:

$$
x_{-1}(z) = \text{Re}(z) \sec \theta_b, \quad x_0(z) = \text{Re}(z) \sec \theta_a,
$$

$$
x_1(z) = \text{Re}(z^2) \sec \theta_a \sec \theta_b + \tan \theta_a \tan \theta_b.
$$

It is easy to see that

$$
|x_{-1}(z)|, |x_0(z)| > 1
$$

whenever $|\text{Re}(z)| > \cos \theta_b$, since $\theta_a > \theta_b > 0$. We also want to show $|x_1| > |x_{-1}|$, which holds whenever

(7.16)
$$
|\text{Re}(z^2) + \sin \theta_a \sin \theta_b| > |\text{Re}(z)| \cos \theta_a.
$$

By [\(7.15\)](#page-30-2), we see that [\(7.16\)](#page-30-3) holds for all z with $|Re(z)| > cos \theta_b$. Since $|x_{-1}(z)| > 1$ for such z, we also get $|x_1(z)| > 1$ for those values of z, so the escape condition [\(7.13\)](#page-29-0) holds for $k_0 = 0$, $\delta = 0$, and all $z \in \partial \mathbb{D}$ with $|\text{Re}(z)| > \cos \theta_b$. It follows that

$$
\sigma_k \subseteq \sigma_{-1} = \{ z \in \partial \mathbb{D} : |\text{Im}(z)| \ge \sin \theta_b \}
$$
 for all $k \ge -1$.

Consequently, we have $I(z) \geq \lambda$ on σ_k for all $k \geq -1$ by [\(7.12\)](#page-28-1) and [\(7.14\)](#page-30-4). \Box

The proof of Theorem [7.1](#page-27-3) relies on the following pair of technical lemmas. The first lemma establishes upper and lower bounds on the derivatives of the iterates of the trace map, while the second proves power-law bounds on the growth of the GZ cocycle on the periodic spectra; compare [\[25,](#page-45-28) Lemma 5.2], [\[13,](#page-45-19) Proposition 3.2 and Lemma 3.5]. The proofs would distract from the overall narrative flow of the paper; thus we postpone them until the end of the section.

Lemma 7.8. For each $\theta_b > \pi/4$, there exist constants $m = m(\theta_b)$, $M = M(\theta_b)$, and $\lambda = \lambda(\theta_b)$ such that the following holds. If $\theta_b < \theta_a < \pi/2$ and $\mu \geq \lambda$, then, for every $z \in \sigma_k$, we have

$$
(7.17) \qquad \qquad \xi^{k/2} \le |x_k'(z)| \le \Xi^k,
$$

where $\xi = m\sqrt{\mu}$ and $\Xi = M\sqrt{\mu}$, as in the statement of Theorem [7.1.](#page-27-3)

Lemma 7.9. For all θ_a and θ_b as in the statement of Theorem [7.1,](#page-27-3) there is a constant $C > 0$ such that for every $n \in \mathbb{Z}$ with $-2F_k \leq n \leq 2F_k$ with $n \neq 0$, one has

(7.18)
$$
||Z(n,0;z)|| \leq C|n|^{\tau/2}
$$

for all $z \in \sigma_k$, where τ is as in [\(7.9\)](#page-27-4), and Z denotes the Gesztesy–Zinchenko cocycle associated to \mathcal{E}_0 . Consequently, we have

$$
||Z(n, m; z)|| \leq C^2 |n|^\tau
$$

for all $z \in \sigma_k$ and all n, m with $|n|, |m| \leq 2F_k$ and $n \neq 0$.

Proof of Theorem [7.1.](#page-27-3) Fix θ_b and $\theta_a \in (\theta_b, \pi/2)$ sufficiently large. The theorem consists of two nontrivial inequalities: a lower bound on $\tilde{\beta}^-$ and an upper bound on β^+ . We will prove the lower bound using Theorem [2.1](#page-6-0) and the upper bound using Theorem [2.5.](#page-9-1) Recall that $F_k \sim \varphi^k$.

Lower Bound. By Lemma [7.8](#page-30-0) and the Mean Value Theorem, we have $|B_k| \geq 4\Xi^{-k}$ for each band B_k of σ_k . Since $F_k \sim \varphi^k$ and σ_k consists of $2F_k$ bands,

$$
|\sigma_k| \ge 8F_k \Xi^{-k} \gtrsim F_k^{-\eta},
$$

where $\eta = \frac{\log(\Xi)}{\log \varphi} - 1$, as in [\(7.9\)](#page-27-4). Note that the implicit constant on the right hand side depends on Ξ , and hence on μ and θ_b . Combining this lower bound on the measure of the periodic spectra with the polynomial bounds from Lemma [7.9,](#page-30-1) we get the desired conclusion from Theorem [2.1](#page-6-0) by taking $A_R = \sigma_{\ell(R)}$ for each $R > 1$, where $\ell(R) \in \mathbb{Z}_+$ is the unique integer with $F_{\ell-1} < R \leq F_{\ell}$. Specifically, with $R_K = K^{\frac{1}{1+\tau}},$ one has

$$
|A_{R_K}|=|\sigma_{\ell(R_K)}|\gtrsim F_{\ell(R_K)}^{-\eta}\gtrsim R_K^{-\eta}=K^{\frac{-\eta}{1+\tau}},
$$

which, by (2.8) , implies

$$
\left\langle |X|_{\delta_0}^p \right\rangle(K) \gtrsim |A_{R_K}| K^{\frac{p-3\tau}{1+\tau}} \gtrsim K^{\frac{p-3\tau-\eta}{1+\tau}}.
$$

Consequently,

$$
\widetilde{\beta}_{\delta_0}^-(p)\geq \frac{p-3\tau-\eta}{p(1+\tau)},
$$

which proves the lower bound from [\(7.8\)](#page-27-5).

Upper Bound. Define

$$
\sigma_k^{\delta} := \{ z \in \mathbb{C} : |x_k(z)| \leq 1 + \delta \}.
$$

Using the lower bound from (7.17) , one can argue as in [\[14,](#page-45-17) Proposition 3] and use the Koebe Distortion Theorem to see that for every $\delta > 0$ small enough, there is a constant $C_{\delta} > 0$ such that

$$
\sigma_k^{\delta} \subseteq B\left(0, \exp\left(C_{\delta} \xi^{-k/2}\right)\right)
$$

for all $k \in \mathbb{Z}_+$. We now fix $\delta > 0$ small enough that σ_n^{δ} has F_n connected components for all $n \in \mathbb{Z}_+$; the existence of such a δ follows from the argument which proves [\[14,](#page-45-17) Lemma 5]. Let $\nu > 0$ be given, and put

$$
\gamma = \gamma(\nu) = \frac{\log(\xi)}{2(1+\nu)\log(\varphi)}.
$$

Thus, for all $k \in \mathbb{Z}_+$ large enough (depending on ν), we have

(7.19)
$$
\sigma_k^{\delta} \cup \sigma_{k+1}^{\delta} \subseteq B(0, \exp(C_{\delta} F_k^{-\gamma}))
$$

Let K_0 be large enough that $ze^{K_0^{-1}} \in \sigma_{-1}^{\delta}$ whenever $z \in \sigma_{-1}$. Given $K \geq K_0$, define $n = n(K)$ and $N = N(K)$ by

$$
\frac{F_{n-1}^{\gamma}}{C_{\delta}}\leq K<\frac{F_{n}^{\gamma}}{C_{\delta}},\quad N=2F_{n+\sqrt{n}},
$$

where we abbreviate $F_x := F_{\lfloor x \rfloor}$ for real numbers $x.$ In particular, we have $K^{-1} >$ $C_{\delta}F_n^{-\gamma}$, so, for complex numbers of the form $we^{1/K}$ with $w \in \sigma_{-1}$, the escape

condition [\(7.13\)](#page-29-0) holds for some $k_0 \leq n(K)$. On the other hand, (7.13) already holds with $k_0 = \delta = 0$ for all $w \in \partial \mathbb{D} \setminus \sigma_{-1}$ by our choice of parameters, so, since escape is an open condition, we may enlarge K_0 (if necessary) so that [\(7.13\)](#page-29-0) still holds (with $k_0 = \delta = 0$) for all z of the form $we^{K^{-1}}$ with $w \in \partial \mathbb{D} \setminus \sigma_{-1}$ and $K \geq K_0$. Consequently, for every z with $|z| = e^{1/K}$, we have

$$
|x_q(z)| \ge \left(1+\frac{\delta}{2}\right)^{F_{q-n(K)-1}}
$$

for every integer $q \geq n(K)$, by Lemma [7.6.](#page-29-1) For every $\epsilon > 0$, our choice of $N(K)$ implies that there is a constant $c_{\epsilon} > 0$ such that

$$
N(K) \le c_{\epsilon} K^{\gamma^{-1} + \epsilon}
$$

for every $K \in \mathbb{Z}_+$. Putting everything together, we have

$$
\max_{0 \le n \le c_{\epsilon} K^{\gamma - 1 + \epsilon}} \|Z(n, 0; e^{i\theta + 1/K})\| \ge \|Z\left(N(K), 0; e^{i\theta + 1/K}\right)\|
$$

$$
\ge \left|x_{N(K)}\left(e^{i\theta + 1/K}\right)\right|
$$

$$
\ge \left(1 + \frac{\delta}{2}\right)^{F_{\sqrt{n(K)} - 1}}
$$

for all $\theta \in [0, 2\pi)$, where we have used Lemma [7.6](#page-29-1) and $N(K) - n(K) = \sqrt{n(K)}$ to obtain the final line. We then have

$$
\int_0^{2\pi} \left(\max_{0 \le n \le c_{\epsilon} K^{\gamma - 1 + \epsilon}} \left\| Z(n, 0; e^{i\theta + 1/K}) \right\|^2 \right)^{-1} \frac{d\theta}{2\pi} \lesssim \left(1 + \frac{\delta}{2} \right)^{-2F \sqrt{n(K)} - 1}
$$

The right hand side decays faster than any negative power of K , and we can prove a similar bound on the other half-line using the reflection symmetry [\(7.1\)](#page-26-2). Thus, we have $\beta_{\delta_0}^+(p) \leq \gamma(\nu)^{-1} + \epsilon$ for all $p > 0$ by Theorem [2.5.](#page-9-1) Since this holds for all $\epsilon > 0$ and $\nu > 0$, we obtain $\beta_{\delta_0}^+(p) \leq \gamma(0)^{-1}$, which is the upper bound in [\(7.8\)](#page-27-5). \Box

7.4. Band Combinatorics for Fibonacci Quantum Walks. Throughout this subsection, we adopt the standing assumptions $0 < \theta_b < \theta_a < \pi/2$ and $\mu \geq 32$. Notice that the assumption $\mu \geq 32$ implies $\sigma_{k-1} \cap \sigma_k \cap \sigma_{k+1} = \emptyset$ for all $k \geq 0$, since $I(x_{k-1}, x_k, x_{k+1}) \geq \mu$ on σ_k for all k.

Let us say that a band $B_k \subseteq \sigma_k$ is a type A band if $B_k \subseteq \sigma_{k-1}$ and a type B band if $B_k \subseteq \sigma_{k-2}$. The assumption on the θ 's means that σ_0 consists of two bands of type A, and σ_1 consists of four bands of type B. The first claim is an obvious consequence of $0 < \theta_b < \theta_a < \pi/2$, but the second requires an argument, which is supplied by the following lemma.

Lemma 7.10. If $0 < \theta_b < \theta_a < \pi/2$, then $\sigma_{-1} \supseteq \sigma_0 \cup \sigma_1$. If, in addition, $\mu \geq 32$, then $\sigma_0 \cap \sigma_1 = \emptyset$.

Proof. As noted above, the assumptions on θ_a and θ_b immediately give $\sigma_0 \subseteq \sigma_{-1}$. To prove the other inclusion, suppose $z \notin \sigma_{-1}$, i.e., $|\text{Re}(z)| > \cos \theta_b$. Then the assumptions on the θ 's imply

$$
\operatorname{Re}(z^2) > \cos(2\theta_b) > \cos(\theta_a + \theta_b) = \cos\theta_a \cos\theta_b - \sin\theta_a \sin\theta_b.
$$

Consequently,

$$
x_1(z) = \text{Re}(z^2) \sec \theta_a \sec \theta_b + \tan \theta_a \tan \theta_b
$$

.

$$
> (\cos \theta_a \cos \theta_b - \sin \theta_a \sin \theta_b) \sec \theta_a \sec \theta_b + \tan \theta_a \tan \theta_b
$$

= 1,

so $z \notin \sigma_1$. Thus $\sigma_1 \subseteq \sigma_{-1}$. With this in hand, we must have $\sigma_0 \cap \sigma_1 = \emptyset$, since $\mu \geq 32$. $\mu \geq 32.$

With the previous lemma in hand, we know that type A and B bands exhaust the periodic spectra at levels 0 and 1. To see that they exhaust the spectra at all levels, we use the following lemma, which is a CMV variant of [\[25,](#page-45-28) Lemma 5.3]. The proof is nearly identical to the proof in the Schrödinger case – we include detailed arguments for the reader's convenience.

Lemma 7.11. Assume $0 < \theta_b < \theta_a < \pi/2$ and $\mu \geq 32$. For every $k \geq 0$:

- (1) Every type A band of σ_k contains a type B band of σ_{k+2} and no other bands of σ_{k+1} or σ_{k+2} .
- (2) Every type B band of σ_k contains a type A band $B_{k+1} \subseteq \sigma_{k+1}$ and two type B bands from of σ_{k+2} which sandwich B_{k+1} .

Proof. Case A. Suppose $B_k \subseteq \sigma_k$ is a type-A band. By definition, $B_k \subseteq \sigma_{k-1}$, so we must have $B_k \cap \sigma_{k+1} = \emptyset$, since $\mu \geq 32$; equivalently, $|x_{k+1}| > 1$ on B_k . There is a unique $z_1 \in B_k$ such that $x_k(z_1) = 0$. Using the trace map [\(7.4\)](#page-26-3), we have

$$
|x_{k+2}(z_1)| = |x_{k-1}(z_1)| \le 1,
$$

since $z_1 \in B_k \subseteq \sigma_{k-1}$. In particular, $B_k \cap \sigma_{k+2} \neq \emptyset$. Notice also that when $x_k = \pm 1$, we have

$$
|x_{k+2}| \ge 2|x_{k+1}| - |x_{k-1}| > 1,
$$

so any band of σ_{k+2} which intersects B_k must be entirely contained within B_k . Finally, suppose B_{k+2} is a band of σ_{k+2} contained in B_k . By the IVT, B_{k+2} contains a point z_2 for which $x_{k+2}(z_2) + x_{k-1}(z_2) = 0$, so $x_k(z_2)x_{k+1}(z_2) = 0$ by [\(7.4\)](#page-26-3). Since $z_2 \notin \sigma_{k+1}$, $x_k(z_2) = 0$. Thus, there is a *unique* band of σ_{k+2} contained in B_k .

Case B. Suppose $B_k \subseteq \sigma_k$ is a type-B band, i.e. $B_k \subseteq \sigma_{k-2}$; immediately, one has $B_k \cap \sigma_{k-1} = \emptyset$. As above, if $x_k(z_3) = 0$, then

$$
|x_{k+1}(z_3)| = |x_{k-2}(z_3)| \le 1,
$$

whence $B_k \cap \sigma_{k+1} \neq \emptyset$. As in the previous case, $|x_k| = 1$ forces $|x_{k+1}| > 1$, so any band of σ_{k+1} which meets B_k must be contained entirely within the interior of B_k . Moreover, running the argument above again, any band of σ_{k+1} contained within B_k must contain a spectral parameter at which x_k vanishes, and so there is exactly one band of σ_{k+1} contained in B_k . Now we consider bands of σ_{k+2} which meet B_k . Notice that one may iterate the trace recursion to obtain

(7.20)
$$
x_{k+2} = 2x_{k+1}x_k - x_{k-1} = (4x_k^2 - 1)x_{k-1} - 2x_kx_{k-2}.
$$

As before, any band of σ_{k+2} which meets B_k is completely contained in B_k ; specifically, if $|x_k| = 1$, then [\(7.20\)](#page-33-0) forces $|x_{k+2}| > 3 - 2 = 1$. On the other hand, if $x_k = \pm 1/2$, then [\(7.20\)](#page-33-0) forces $|x_{k+2}| = |x_{k-2}| \leq 1$. Consequently, B_k contains at *least* two bands of σ_{k+2} (note that we can't have a single large band, becaue σ_{k+2} cannot meet σ_{k+1} , which contains the zero of x_k in B_k , which separates the points where $x_k = \pm 1/2$. It remains to see that we have no more than two bands of σ_{k+2} in B_k . Notice that

$$
(2x_k \pm 1)(x_{k+2} \pm x_{k-2}) = (4x_k^2 - 1)(x_{k+1} \pm x_{k-1}).
$$

Now, fix a band $B_{k+2} \subseteq B_k$ of σ_{k+2} . We may choose a fixed sign so that $x_{k+1} \pm x_{k-1}$ never vanishes on B_{k+2} . By the IVT, there exists $z_4 \in B_{k+2}$ so that $x_{k+2}(z_4) \pm$ $x_{k-2}(z_4) = 0$. We must then have $x_k(z_4) = \pm 1/2$. Since there are only two energies in B_k where this happens, we are done – there cannot be more than two bands of σ_{k+2} in B_k .

Lemma [7.11](#page-33-1) implies that every band of σ_k is of type A or B for every $k \geq 0$. Moreover, it also implies that σ_k consists of $2F_k$ disjoint bands for all k, that is, σ_k has no closed gaps. Finally, it also implies that $\sigma_{-1} \supseteq \sigma_k$ for all k, and hence $\sigma_{-1} \supseteq \Sigma$ by a strong approximation argument.

7.5. Power-Law Bounds on the Growth of Fibonacci–Szegő Cocycles. In this subsection, we prove Lemmas [7.8](#page-30-0) and [7.9.](#page-30-1) Throughout, we have the standing assumptions that $\pi/4 < \theta_b < \theta_a < \pi/2$ and that μ is large enough, where "large" enough" is a θ_b -dependent statement which becomes harder and harder to satisfy as $\theta_b \searrow \pi/4$. We do not attempt to find optimal constants, and instead opt for lucidity of presentation. Notice that

$$
u^2 + v^2 + w^2 - 2uvw - 1 = I
$$

implies that

$$
w = uv \pm \sqrt{I + (1 - u^2)(1 - v^2)}
$$

via the quadratic formula. This motivates us to define

$$
g_{\pm}(u, v, I) = uv \pm \sqrt{I + (1 - u^2)(1 - v^2)}.
$$

Lemma 7.12. For $I \geq 4$ and $|u|, |v| \leq 1$, we have

$$
\left|\frac{\partial g_{\pm}}{\partial u}(u,v,I)\right|,\ \left|\frac{\partial g_{\pm}}{\partial v}(u,v,I)\right|\leq 1.
$$

Moreover,

$$
\left|\frac{\partial g_{\pm}}{\partial I}(u,v,I)\right| \le \frac{1}{2\sqrt{I}}.
$$

Proof. Since $g_{\pm}(u, v, I) = \frac{1}{2} f_{\pm}(2u, 2v, 2\sqrt{I})$ in Killip–Kiselev–Last's notation, the first two inequalities are immediate from [\[25,](#page-45-28) Lemma 5.4] and the chain rule. In particular, note that $I = \lambda^2/4$ when passing between our notation and theirs. The third bound is obvious.

Lemma 7.13. Suppose $\pi/4 < \theta_b < \pi/2$ is given. There exist constants $m = m(\theta_b)$, $M = M(\theta_b)$, and $\lambda = \lambda(\theta_b)$ such that if $\theta_b < \theta_a < \pi/2$ and $\mu \geq \lambda$, then the following statements hold with $\xi = m\sqrt{\mu}$ and $\Xi = M\sqrt{\mu}$. We have

$$
\xi \le \left| \frac{x'_{k+1}(z)}{x'_k(z)} \right| \le \Xi
$$

for all $z \in B_{k+1}$ if B_{k+1} is a type A band, and

$$
\xi\leq \left|\frac{x'_{k+2}(z)}{x'_k(z)}\right|\leq \Xi
$$

for all $z \in B_{k+2}$ if B_{k+2} is a type B band.

Notation. We adopt the following notation, just over the course of the following proof. Given quantities f and g which depend on θ_a and θ_b (subject to all of our various standing assumptions thereupon), we denote $f \sim g$ if for every θ_b , there exists $C = C(\theta_b)$ with $C^{-1}f \le g \le Cf$.

Proof. One can follow the proofs of [\[13,](#page-45-19) Lemma 3.5] and [\[25,](#page-45-28) Lemma 5.5] and prove these statements by induction, but there are two new difficulties. First, the initial conditions are different in the CMV case, so we must verify that the induction is well-founded. Once this is done, we have to deal with extra terms which arise from the failure of I to be constant on the spectrum. To deal with the first base case, observe that

$$
\left|\frac{x_0'(z)}{x_{-1}'(z)}\right|=\frac{\sec\theta_a}{\sec\theta_b}\sim\sqrt{\mu}
$$

 $|x_{-1}(z)|$ set
for all $z \in \partial \mathbb{D}$. Next, for all $z \in \sigma_1$, we have

$$
-\cos(\theta_a - \theta_b) \le \text{Re}(z^2) \le \cos(\theta_a + \theta_b) < \cos(2\theta_b) < 0
$$

by [\(7.11\)](#page-28-2) and standard trigonometric identities. Consequently, $|\text{Im}(z)| \ge \sin \theta_b$ and $|\text{Im}(z^2)| \ge \sin(\theta_a - \theta_b)$, so we obtain

$$
\left| \frac{x_1'(z)}{x_{-1}'(z)} \right| = \left| \frac{(2z - 2z^{-3}) \sec \theta_a \sec \theta_b}{(1 - z^{-2}) \sec \theta_b} \right|
$$

$$
= 2 \left| \frac{\text{Im}(z^2)}{\text{Im}(z)} \right| \sec \theta_a
$$

$$
\sim \sqrt{\mu}.
$$

Now, we proceed inductively. Notice that the base case (and then each inductive step thereafter) implies $|x'_k| > 1$ on σ_k as long as μ is large enough. Taking $\lambda(\theta_b)$ sufficiently large, we have $|x'_k(z)| > 1$ on σ_k for $k = -1, 0$.

In the argument below, we will need to estimate $(\partial g_{\pm}/\partial I)I'(z)$ for $z \in \sigma_k$. Since $|I'(z)| = |\text{Re}(z)| \kappa^2$ and $|\text{Im}(z)| \ge \sin \theta_b$ for all $z \in \sigma_k$, we have

(7.21)
$$
\left| \frac{\partial g_{\pm}}{\partial I} I'(z) \right| \leq \frac{1}{2\sqrt{\mu}} \cdot \frac{\mu}{\sin^2 \theta_b} = \frac{\sqrt{\mu}}{2 \sin^2 \theta_b}
$$

for all $z \in \sigma_k$ and all $k \geq -1$.

Case 1: Type A Band. Suppose B_{k+1} is a type-A band of σ_{k+1} for some $k \geq 1$; let B_k denote the band of σ_k with $B_{k+1} \subseteq B_k$. Consequently, we have $B_k \cap \sigma_{k-1} = \emptyset$ and $B_k \subseteq \sigma_{k-2}$, so B_k is a type B band. Differentiating the renormalization map (7.4) and dividing by x'_{k} , we get

$$
\frac{x'_{k+1}}{x'_{k}} = 2x_{k-1} + \frac{2x_k x'_{k-1}}{x'_{k}} - \frac{x'_{k-2}}{x'_{k}}.
$$

To estimate the second term on the right hand side, note that x_{k-1} = $g_{\pm}(x_k, x_{k-2}, I)$, so

$$
x'_{k-1} = \frac{\partial g_{\pm}}{\partial u} x'_{k-2} + \frac{\partial g_{\pm}}{\partial v} x'_{k} + \frac{\partial g_{\pm}}{\partial I} I',
$$

which implies

$$
\left|\frac{x'_{k-1}}{x'_k}\right|\leq\left|\frac{x'_{k-2}}{x'_k}\right|+1+\frac{\sqrt{\mu}}{2|x'_k|\sin^2\theta_b}\leq 2+\frac{\sqrt{\mu}}{2\sin^2\theta_b}
$$

on B_{k+1} , where we have used [\(7.21\)](#page-35-0), $B_{k+1} \subseteq B_k \subseteq \sigma_{k-2}$, Lemma [7.12,](#page-34-1) and the inductive hypothesis. Consequently,

(7.22)
$$
\left| \frac{2x_k x'_{k-1}}{x'_k} - \frac{x'_{k-2}}{x'_k} \right| \le 5 + \frac{\sqrt{\mu}}{\sin^2 \theta_b}.
$$

Since $|x_k|, |x_{k-2}| \leq 1$ on B_{k+1} , one can use $x_{k-1} = g_{\pm}(x_k, x_{k-2}, I)$ to see that

$$
\sqrt{\mu}-1\leq |x_{k-1}|\leq \sqrt{\mu}+2
$$

on B_{k+1} . Combining this with [\(7.22\)](#page-36-0) and using the triangle inequality twice, we obtain

$$
\left(2 - \frac{1}{\sin^2 \theta_b}\right)\sqrt{\mu} - 7 \le \left|\frac{x'_{k+1}}{x'_k}\right| \le \left(2 + \frac{1}{\sin^2 \theta_b}\right)\sqrt{\mu} + 9
$$

on B_{k+1} . Note that one needs $\theta_b > \pi/4$ for the lower bound to have any significance, even for large μ .

Case 2: Type B Band. Let us suppose that B_{k+2} is a type-B band of σ_{k+2} for some $k \geq 0$; Let B_k denote the band of σ_k which contains B_{k+2} . There are two subcases to consider. (Notice that $k = 0$ falls in Subcase 2ii, so one need not worry about the x_{-2} 's that might appear in Subcase 2i).

Subcase 2i: B_k is type **B.** This implies $B_{k+2} \subseteq B_k \subseteq \sigma_{k-2}$ and $B_k \cap \sigma_{k-1} = \emptyset$. As in the previous argument, we have

$$
\sqrt{\mu}-1 \le |x_{k+1}| \le \sqrt{\mu}+2
$$

on B_{k+2} , and we may estimate

$$
(7.23)\qquad \qquad \left|\frac{x'_{k-1}}{x'_k}\right| \le 2 + \frac{\sqrt{\mu}}{2\sin^2\theta_b}
$$

on B_{k+2} . Using the trace recursion [\(7.4\)](#page-26-3) and its derivatives, we obtain

$$
\frac{x'_{k+2}}{x'_{k}} = 4x_{k+1} + 2x_{k-2} + (4x_{k}^{2} - 1)\frac{x'_{k-1}}{x'_{k}} - 2x_{k}\frac{x'_{k-2}}{x'_{k}}.
$$

This time, the x_{k+1} term dominates. Using [\(7.23\)](#page-36-1), the inductive hypothesis, and $B_{k+2} \subseteq B_k \subseteq \sigma_{k-2}$ to estimate the remaining terms for $z \in B_{k+2}$, we have

$$
\left|2x_{k-2} + (4x_k^2 - 1)\frac{x'_{k-1}}{x'_k} - 2x_k \frac{x'_{k-2}}{x'_k}\right| \le 2 + 3\left(2 + \frac{\sqrt{\mu}}{2\sin^2\theta_b}\right) + 2
$$

$$
= 10 + \frac{3\sqrt{\mu}}{2\sin^2\theta_b}
$$

on B_{k+2} . Using the triangle inequality again, we have

$$
\left(4 - \frac{3}{2\sin^2\theta_b}\right)\sqrt{\mu} - 14 \le \left|\frac{x'_{k+2}}{x'_k}\right| \le \left(4 + \frac{3}{2\sin^2\theta_b}\right)\sqrt{\mu} + 18
$$

on B_{k+2} .

Subcase 2ii: B_k is type A. We have $B_{k+2} \subseteq B_k \subseteq \sigma_{k-1}$, and $B_k \cap \sigma_{k-2} = \emptyset$. Differentiating the renormalization equation, we get

$$
\frac{x'_{k+2}}{x'_{k}} = 2x_{k+1} + 2x_k \frac{x'_{k+1}}{x'_{k}} - \frac{x'_{k-1}}{x'_{k}}.
$$

Again, $\sqrt{\mu} - 1 \le |x_{k+1}| \le \sqrt{\mu} + 2$ on B_{k+2} , and, like the previous cases, we have $x_{k+1} = g_{\pm}(x_k, x_{k-1}, I)$, so

$$
\left|\frac{x'_{k+1}}{x'_k}\right|\leq 2+\frac{\sqrt{\mu}}{2\sin^2\theta_b}
$$

on B_{k+2} . Therefore, we have

$$
\left|2x_k\frac{x'_{k+1}}{x'_k}+\frac{x'_{k-1}}{x'_k}\right|\leq 5+\frac{\sqrt{\mu}}{\sin^2\theta_b}
$$

on B_{k+2} . Applying the triangle inequality two more times, we have

$$
\left(2 - \frac{1}{\sin^2 \theta_b}\right)\sqrt{\mu} - 7 \le \left|\frac{x'_{k+2}}{x'_k}\right| \le \left(2 + \frac{1}{\sin^2 \theta_b}\right)\sqrt{\mu} + 9
$$

on B_{k+2} .

Proof of Lemma [7.8.](#page-30-0) This follows immediately from Lemma [7.13.](#page-34-2) \Box

Lastly, we will prove the power-law bounds on transfer matrices at spectral parameters in the periodic approximating spectra. To do this, we need trace bounds on these spectra, which the following lemma supplies. The key ingredient is that the escape condition is a bit simpler to check in our situation. Notice that something must be said in our situation, since some choices of θ_a and θ_b can lead to $|x_{-1}(z)| > 1$ for $z \in \Sigma$, whereas one has $x_{-1} \equiv 1$ in the Schrödinger case.

Lemma 7.14. If $0 < \theta_b < \theta_a < \pi/2$, $\mu \geq 32$, and $z \in \partial \mathbb{D}$, the trace orbit $(x_k(z))_{k\geq -1}$ is unbounded if and only if there exists $k_0 \geq 0$ such that

(7.24)
$$
|x_{k_0}(z)|, |x_{k_0+1}(z)| > 1.
$$

Consequently, if $z \in \Sigma = B_{\infty}$, one has $|x_k(z)| \leq \kappa + 2$ for all $n \geq -1$, where κ is as in [\(7.7\)](#page-27-1).

Proof. By Lemma [7.11,](#page-33-1) we have $\sigma_{-1} \supseteq \sigma_k$ for all k, and $\sigma_{-1} \supseteq \Sigma$. There are two possibilities: if $z \notin \sigma_{-1}$, then one has $z \notin \Sigma$ and [\(7.24\)](#page-37-0) holds for some k_0 . On the other hand, if $z \in \sigma_{-1}$, then $|x_{-1}(z)| \leq 1$, and so the existence of k_0 which satisfies [\(7.24\)](#page-37-0) is equivalent to the existence of k_0 which satisfies the general escape condition [\(7.13\)](#page-29-0).

The claimed bound on $|x_k(z)|$ for $z \in B_{\infty}$ follows from a simple observation. Namely, if $|x_k(z)| > 1$ for some $z \in B_\infty$, then $|x_{k\pm 1}(z)| \leq 1$, whence

$$
|x_k| = \left| x_{k-1} x_{k+1} \pm \sqrt{I + (1 - x_{k-1}^2)(1 - x_{k+1}^2)} \right| \le 1 + \sqrt{\kappa^2 + 1} \le 2 + \kappa,
$$

where we have suppressed the dependence of the x's and I on z.

 \Box

Proof of Lemma [7.9.](#page-30-1) Since this is nearly identical to [\[20\]](#page-45-26) and [\[13,](#page-45-19) Lemma 3.2], we only sketch the main steps of the argument. The main idea is to begin by estimating the norms of the matrices M_n , and then to decompose an arbitrary Z-type matrix over an even number of sites into a product of M_j 's by using the fact that every integer has a natural "base Fibonacci" expansion. Finally, one can interpolate to get transfer matrices over an odd number of sites.

First, from Lemma [7.14,](#page-37-1) we have $|x_k(z)| \leq \kappa + 2$ for every $z \in \sigma_k$, where κ is as in [\(7.7\)](#page-27-1). As a first crude estimate, we have

(7.25)
$$
||M_j(z)|| \le (\kappa + 2)^j
$$

for $j \leq k$ and $z \in \sigma_k$. As in [\[13\]](#page-45-19), this follows from the recursive relationship among the M_n -type matrices and the Cayley–Hamilton Theorem:

$$
M_j = x_{j-1} M_{j-2} - M_{j-3}^{-1}.
$$

One also uses the fact that det $M_{\ell} = 1$ for all ℓ , which implies $||M_{j-3}^{-1}|| = ||M_{j-3}||$.

As in [\[20,](#page-45-26) Lemma 5] and [\[13,](#page-45-19) Proposition 3.2], for every $i \geq 2$, $j \geq 1$, we may construct polynomials $P_j^{(1)}, \ldots, P_j^{(4)}$ of degree at most j in x_{i-1}, \ldots, x_j such that

$$
M_k M_{k+j} = P_j^{(1)} M_{i+j} + P_j^{(2)} M_{i+j-1} + P_j^{(3)} M_{i+j-2} + P_j^{(4)} I.
$$

Moreover,

(7.26)
$$
\sum_{\ell=1}^4 \left| P_j^{(\ell)} \right| (|x_{i-1}|, \dots, |x_{i+j}|) \le (2\kappa + 5)^j,
$$

where $|P|$ denotes the polynomial obtained by replacing each coefficient of P by its absolute value. Indeed, [\(7.26\)](#page-38-1) follows from a verbatim repition of the arguments of [\[13,](#page-45-19) [20\]](#page-45-26), since all that is used in those references is Cayley–Hamilton and the trace bounds for indices bounded above by k . By repeating the next step of the argument, we obtain

$$
||Z(2m, 0; z)|| \le d^{b_m}
$$
 for all $1 \le m \le F_k$,

where $d = (\kappa + 2)(2\kappa + 5)^2$ and $b_m = \max\{n : F_n \le m\}$; in particular, $b_m \le k$. Since $F_n \sim \varphi^n$, we have

$$
b_m \le \frac{\log m}{\log \varphi} + D
$$

for some constant D , whence

$$
||Z(2m,0;z)|| \le d^{\frac{\log m}{\log \varphi} + D} = d^D m^{\tau/2}.
$$

We obtain [\(7.18\)](#page-30-6) for all $n > 0$ by interpolating to get odd values of n. The negative case follows from the reflection symmetry [\(7.1\)](#page-26-2). One may also obtain the same the result for T-type matrices by using (3.3) .

8. The Thue-Morse Quantum Walk

Let us consider a quantum walk as in Section [7,](#page-25-0) but for which the coins R_a and R_b are distributed according to an element of the Thue-Morse subshift, rather than the Fibonacci subshift.

More precisely, consider the alphabet $A = \{a, b\}$ as before. The Thue-Morse substitution is defined by

$$
S: a \mapsto ab, \quad b \mapsto ba.
$$

Iterating S on a, we obtain a sequence of words $w_n = S^n(a)$, and an infinite word

$$
u_{\text{TM}} = \lim_{n \to \infty} w_n = abbabaaabaaababa\dots,
$$

and we define the Thue-Morse subshift to be the space of all sequences over the alphabet A with the same local structure as u_{TM} , i.e.,

 $\Omega_{\text{TM}} = \left\{ \omega \in \mathcal{A}^{\mathbb{Z}} : \text{every finite subword of } \omega \text{ occurs in } u_{\text{TM}} \right\}.$

As before, we can associate to each $\omega \in \Omega_{TM}$ a sequence of coins $C_{\omega,n} = R_{\omega_n}$ and a sequence of Verblunsky coefficients α_{ω} as in Section [7.](#page-25-0) Now, consider the transfer

matrices over the words w_n . More precisely, fix $\alpha = \alpha_{\omega_0}$, where $\omega_0 = u_{\text{TM}}^R | u_{\text{TM}} \in$ Ω_{TM} , and define

$$
M_n(z) = Z(2^{n+1}, 0; z), \quad n \ge 0, z \in \mathbb{C}.
$$

Also, define M_{-1} as in the previous section. Let

$$
t_n(z) = \text{tr}(M_n(z)).
$$

The recursive relationship between the M_n 's implies a recursive relationship amongst the t_n 's, viz.

(8.1)
$$
t_{n+1} = t_{n-1}^2(t_n - 2) + 2, n \ge 2.
$$

The sets

$$
\sigma_n=\{z\in\partial\mathbb{D}:|t_n(z)|\leq 2\}
$$

correspond to spectra of quantum walk update rules whose coins are distributed 2^n -periodicially according to w_n . Since the initial conditions are the same as in Section [7,](#page-25-0) we still have

$$
t_{-1}(z) = \text{Re}(z) \sec \theta_b
$$

\n
$$
t_0(z) = \text{Re}(z) \sec \theta_a
$$

\n
$$
t_1(z) = \text{Re}(z^2) \sec \theta_a \sec \theta_b + \tan \theta_a \tan \theta_b
$$

Lemma 8.1. If $z_0 \in \partial \mathbb{D}$ satisfies $t_n(z_0) = 2$ for some $n \geq 3$ and $t_2(z_0) \neq 2$, then z_0 corresponds to a closed gap of σ_n .

Proof. The proof is identical to the proof of the corresponding fact for Schrödinger/Jacobi transfer matrices, so we only sketch the details; compare [\[13,](#page-45-19) Proposition 5.1. Using the trace recurstion (8.1) , the stated conditions on z_0 imply that $t_k(z_0) = 0$ for some $1 \leq k \leq n-2$. One can then use this to show that $M_j(z_0) = I$ for all $j \geq k+1$ (in particular, for $j = n$). Alternatively, one can differentiate (8.1) to see that $t'_i(z_0) = 0$ for all $j \geq k+1$. differentiate [\(8.1\)](#page-39-1) to see that $t'_{j}(z_{0}) = 0$ for all $j \ge k + 1$.

Theorem 8.2. For all $\omega \in \Omega_{TM}$, one has $\tilde{\beta}_{\delta-1}^{-}(p) \geq 1 - \frac{1}{p}$.

Proof. This follows from Lemma [8.1](#page-39-2) and Theorem [2.1,](#page-6-0) just as in the proof of Theorem [6.2.](#page-24-0) In particular, we take $A_R = \{z_0\}$ for all $R \ge 1$, where $z_0 \in \partial \mathbb{D}$ satisifies $t_2(z_0) \neq 2$ and $t_n(z_0) = 2$ for some $n > 3$; compare [13, Theorem 4]. satisifes $t_2(z_0) \neq 2$ and $t_n(z_0) = 2$ for some $n \geq 3$; compare [\[13,](#page-45-19) Theorem 4].

9. Ballistic Wavepacket Propagation for Periodic CMV Matrices

We will say that a CMV matrix $\mathcal E$ is p-periodic if $\alpha_{n+p} = \alpha_n$ for all $n \in \mathbb Z$. If necessary, double p so that it can be assumed to be even throughout this section, which is no problem, since nothing that we will do requires a minimal period. This can be thought of as a crystalline model, so the physical expectation is that resistance should go to zero and transport of wave packets should be free (ballistic). Despite the obvious physical heuristics and the analogy with known results, this statement has not been worked out in this level of generality in this setting, and so we will describe the proof.

Theorem 9.1. Suppose \mathcal{E} is p-periodic for some $p \in \mathbb{Z}_+$. Then, for any $\psi \in \mathcal{S}$, $\beta^{\pm}_{\psi}(q) = \beta^{\pm}_{\psi}(q) = 1$ for all $q > 0$.

It is immediately clear that Theorem [9.1](#page-39-3) generalizes to CMV matrices whose Verblunsky coefficients are *skew-periodic* in the sense that $\alpha_{n+p} = \omega \alpha_n$ for some ω with $|\omega| = 1$ and all $n \in \mathbb{Z}$. This also implies that a quantum walk with periodically distributed coins will exhibit ballistic transport.

Corollary 9.2. Suppose \mathcal{E} is skew-periodic. Then, for any $\psi \in \mathcal{S}$, $\beta_{\psi}^{\pm}(q) =$ $\beta^{\pm}_{\psi}(q) = 1$ for all $q > 0$.

Corollary 9.3. Suppose U is the update rule of a quantum walk whose coins obey $C_{n+p} = C_n$ for all $n \in \mathbb{Z}$. Then, for any $\psi \in \mathcal{S}$, $\beta^{\pm}_{\psi}(q) = \widetilde{\beta}^{\pm}_{\psi}(q) = 1$ for all $q > 0$.

Proof of Corollary [9.2.](#page-40-0) Let $\omega = e^{ip\phi}$ for some $\phi \in \mathbb{R}$, and introduce $\widetilde{\mathcal{E}}$ with coefficients $\tilde{\alpha}$ defined by

$$
\widetilde{\alpha}_j = e^{-ij\phi}\alpha_j, \quad j \in \mathbb{Z}.
$$

It is not hard to see that $\tilde{\alpha}$ is honestly p-periodic, so we may apply Theorem [9.1](#page-39-3) to deduce ballistic transport for $\tilde{\mathcal{E}}$. Moreover, if we define the diagonal unitary Γ on ℓ^2 by

$$
\gamma_k = \exp\left(i(-1)^k \left\lfloor \frac{k}{2} \right\rfloor \phi\right), \quad \langle \delta_j, \Gamma \delta_k \rangle = \delta_{j,k} \gamma_k,
$$

then $\mathcal{E} = e^{-i\phi} \Gamma^* \tilde{\mathcal{E}} \Gamma$. Thus, we deduce ballistic transport for \mathcal{E} .

Proof of Corollary [9.3.](#page-40-1) Let Λ and $\mathcal{E} = \mathcal{E}_{\alpha}$ be as in Section [2.4](#page-10-0) so that $\mathcal{E} = \Lambda^* U \Lambda$. From the explicit form of Λ , we see that it maps $\mathcal{S}(\ell^2(\mathbb{Z}))$ onto $\mathcal{S}(\ell^2(\mathbb{Z})\otimes\mathbb{C}^2)$, and it does not affect transport exponents. Thus, it suffices to deduce ballistic transport for *E*. Examining [\(2.26\)](#page-11-1), we see that $\alpha_{n+2p} = \omega \alpha_n$ for all $n \in \mathbb{Z}$, where ω is given by

$$
\overline{\omega} = \prod_{j=1}^p \omega_j^1 \omega_j^2.
$$

Thus, $\mathcal E$ is skew-periodic, so ballistic transport for U follows from Corollary [9.2.](#page-40-0) \Box

In order to apply the methods of [\[2\]](#page-45-13) and [\[11\]](#page-45-14) to deduce ballistic transport, we need to establish effective estimates on the Heisenberg evolution of the position operator, X, so we want to consider $\mathcal{E}X-X\mathcal{E}$ as in the other cases. We will actually work with a 2-block version of X , as this substantially simplifies the resulting commutators, without affecting the transport exponents.

To set up notation, let $\ell^0 = \ell^0(\mathbb{Z})$ denote the space of finitely supported sequences, and define a 2-block variant of the position operator $X : \ell^0 \to \ell^0$ by

$$
X\delta_n = \underline{n}\delta_n := 2\left\lfloor \frac{n}{2} \right\rfloor \delta_n
$$

for $n \in \mathbb{Z}$. Clearly X is essentially self-adjoint on ℓ^0 . For any observable (read: operator) A, denote its discrete Heisenberg evolution with respect to $\mathcal E$ by

$$
A(j) = \mathcal{E}^j A \mathcal{E}^{-j}, \quad j \in \mathbb{Z}.
$$

Obviously, ℓ^0 is invariant under both $\mathcal E$ and X , so that $X(j)$ is a well-defined symmetric operator which is essentially self-adjoint on ℓ^0 for all $j \in \mathbb{Z}$. As in [\[11\]](#page-45-14), the key ingredient is furnished by a variation on the theme of Asch-Knauf [\[2\]](#page-45-13).

Theorem 9.4. There is a bounded, self-adjoint operator Q such that

$$
\operatorname*{s-lim}_{L\to\infty}\frac{1}{L}X(L)=Q.
$$

Moreover, $\ker Q = \{0\}$, and

$$
\operatorname*{s-lim}_{L\to\infty} f\left(\frac{1}{L}X(L)\right) = f(Q)
$$

for any bounded continuous function f.

Remark 9.5. Notice that Theorem [9.4](#page-41-0) does not follow from [\[11,](#page-45-14) Theorem $1.6(a),(b)$] in any straightforward fashion. In order to deduce our theorem from theirs, one would need to be able to write $\mathcal{E} = e^{iJ}$ with J a Jacobi matrix (or some other self-adjoint operator of finite width), and it is not at all obvious that this is the case. Perhaps more importantly, even if such a proof could be found, it would add no insight to the unitary setting, whereas our proof explicitly constructs Q out of computable functions of \mathcal{E} .

It is important to point out that the result is not trivial, even though we follow the outline of [\[11\]](#page-45-14). In particular, one needs an identity like [\(9.2\)](#page-43-0) to make the argument work, and the more complicated structure of CMV matrices makes such an identity more difficult to prove.

9.1. Direct Integral Decomposition of Periodic CMV Matrices. The key ingredient here is to decompose a periodic CMV operator as a direct integral of unitary operators on \mathbb{C}^p . Since this is standard fare, we only summarize the theorems and provide no proofs. See [\[34,](#page-46-2) Section 11.2] for more details on periodic CMV operators; see also [\[35,](#page-46-8) Chapter 5] for the Jacobi version.

Given a sequence α of Verblunsky coefficients, for notational convenience, introduce a, b, c , and d as in [\[8\]](#page-45-20), i.e.,

$$
a_n = -\overline{\alpha_n} \alpha_{n-1}, \quad b_n = \overline{\alpha_n} \rho_{n-1}, \quad c_n = -\rho_n \alpha_{n-1}, \quad d_n = \rho_n \rho_{n-1}, \quad n \in \mathbb{Z}.
$$

In terms of these parameters, the matrix representation of $\mathcal E$ becomes

E = a⁰ b¹ d¹ c⁰ a¹ c¹ b² a² b³ d³ d² c² a³ c³ b⁴ a⁴ b⁵ d⁴ c⁴ a⁵

If $\mathcal E$ is p-periodic, then a mod-p variant of the Fourier transform diagonalizes $\mathcal E$ into a multiplication operator on $\mathcal{H}_p = L^2([0, 2\pi), \mathbb{C}^p; \frac{d\theta}{2\pi})$, the space of functions $f : [0, 2\pi) \to \mathbb{C}^p$ which are square integrable with respect to Lebesgue measure. More specifically, for each θ , denote

E^θ = a¹ c¹ dpe [−]iθ cpe −iθ b² a² b³ d³ d² c² a³ c³ . . . b⁴ a⁴ . . . bp−³ dp−³ d⁴ c⁴ . . . ap−³ cp−³ . . . bp−² ap−² bp−¹ dp−¹ dp−² cp−² ap−¹ cp−¹ b1e iθ d1e iθ b^p a^p

and define the mod-p Fourier transform $\mathcal{F} : \ell^2(\mathbb{Z}) \to \mathcal{H}_p$ by $u \mapsto \widehat{u}$, where

$$
\widehat{u}_j(\theta) = \sum_{\ell \in \mathbb{Z}} u_{j+\ell p} e^{-i\ell \theta}, \quad 1 \le j \le p, \, \theta \in [0, 2\pi).
$$

Notice that our definition of \mathcal{E}_{θ} has already implicitly used evenness of p; we will not comment on the parity of p again. The inverse of F is given by $\mathcal{H}_p \ni f \mapsto \check{f} \in \ell^2(\mathbb{Z}),$ where

$$
\check{f}_{j+\ell p} = \int_0^{2\pi} f_j(\phi) e^{i\ell \phi} \frac{d\phi}{2\pi}.
$$

For any operator A on $\ell^2(\mathbb{Z})$, we denote by \widehat{A} its action on Fourier space, i.e., $\widehat{A} = \mathcal{F} A \mathcal{F}^{-1}$. After simple calculations, we see that $(\widehat{\mathcal{E}} f)(\theta) = \mathcal{E}_{\theta} f(\theta)$ for each $f \in \mathcal{H}_p$, and almost every $\theta \in [0, 2\pi)$. It is typical (especially in the physics literature) to view the Hilbert space \mathcal{H}_p and the matrix $\widehat{\mathcal{E}}$ as direct integrals of finite-dimensional objects:

$$
\mathcal{H}_p \cong \int_{[0,2\pi)}^{\oplus} \mathbb{C}^p \, \frac{d\theta}{2\pi}, \quad \widehat{\mathcal{E}} \cong \int_{[0,2\pi)}^{\oplus} \mathcal{E}_{\theta} \, \frac{d\theta}{2\pi}.
$$

9.2. Proof of Ballistic Transport. The proofs of Theorem [9.1](#page-39-3) and [9.4](#page-41-0) are similar to those in [\[11\]](#page-45-14), so we will only comment in detail about the challenges which one must overcome to rerun the Asch-Knauf-Damanik-Lukic-Yessen machine in the present setting, and we will be somewhat breezy with those details which are similar to the proofs in [\[11\]](#page-45-14). The main difficulty here is that time is discrete in our case, so we must use discrete derivatives with respect to time parameters, and this causes some minor headaches.

Formally, let $B = [\mathcal{E}, X] = \mathcal{E}X - X\mathcal{E}$. More precisely, B is initially defined on ℓ^0 , and then it is obviously a bounded operator thereupon (since $\mathcal E$ is five-diagonal), and thus, B enjoys a unique extension to a bounded operator on $\ell^2(\mathbb{Z})$ by general nonsense. Now, observe that the Heisenberg evolution of B is (almost) the discrete derivative of the Heisenberg evolution of X :

(9.1)
$$
X(k) = X + \left(\sum_{\ell=0}^{k-1} B(\ell)\right) \mathcal{E}^*.
$$

The post-factor of \mathcal{E}^* , though unsightly, is ultimately irrelevant; more specifically, strong convergence of $\langle B \rangle (L)$ clearly implies strong convergence of $\langle B \rangle (L) \cdot \mathcal{E}^*$ as

,

 $L \to \infty$. A short calculation reveals

B = 0 0 2d¹ 0 0 2c¹ −2b² 0 0 2d³ −2d² 0 0 2c³ −2b⁴ 0 0 −2d⁴ 0 0

Since B is also clearly p-periodic, $\mathcal F$ also diagonalizes it into a direct integral as well. Specifically, we have $\left(\widehat{B}f\right)(\theta) = B_{\theta}f(\theta)$ for all $f \in \mathcal{H}_p$ and almost every $\theta \in [0, 2\pi)$, where

$$
B_{\theta} = \begin{pmatrix} 0 & 2c_1 & & & & -2d_p e^{-i\theta} & 0 \\ -2b_2 & 0 & 0 & 2d_3 & & & \\ -2d_2 & 0 & 0 & 2c_3 & & & \\ & & \ddots & \ddots & \ddots & & \\ & & & -2b_{p-2} & 0 & 0 & 2d_{p-1} \\ & & & & -2d_{p-2} & 0 & 0 & 2c_{p-1} \\ 0 & 2d_1 e^{i\theta} & & & & -2b_p & 0 \end{pmatrix}
$$

Now let $V_{\theta} \in \mathbb{C}^{p \times p}$ denote the diagonal matrix with diagonal entries $\langle e_k, V_{\theta} e_k \rangle =$ $e^{i\underline{k}\theta/p} = e^{2i[k/2]\theta/p}$, i.e.,

V^θ = 1 e 2iθ/p e 2iθ/p . . . e iθ(p−2)/p e iθ(p−2)/p e iθ .

Define

$$
\widetilde{\mathcal{E}}_{\theta} = V_{\theta}^{-1} \mathcal{E}_{\theta} V_{\theta}, \quad \widetilde{B}_{\theta} = V_{\theta}^{-1} B_{\theta} V_{\theta}
$$

By a direct calculation, one can check that

(9.2)
$$
\frac{\partial}{\partial \theta} \widetilde{\mathcal{E}}_{\theta} = -\frac{i}{p} \widetilde{B}_{\theta}.
$$

With this setup, we run the argument from [\[11\]](#page-45-14), which gives us

(9.3)
$$
\lim_{L \to \infty} \frac{1}{L} \sum_{\ell=0}^{L-1} \mathcal{E}_{\theta}^{\ell} B_{\theta} \mathcal{E}_{\theta}^{-\ell} = -ip \sum_{j=1}^{m} \frac{\partial \lambda_j}{\partial \theta}(\theta) P_j(\theta)
$$

for all $\theta \in (0, 2\pi) \setminus {\pi}$, where $\lambda_1(\theta) < \cdots < \lambda_m(\theta)$ are the distinct eigenvalues of \mathcal{E}_{θ} and $P_i(\theta)$ denotes projection onto the eigenspace corresponding to $\lambda_i(\theta)$. Notice that $P_j(\theta)$ is a one-dimensional projection unless $\theta = 0, \pi$. More precisely, let $v_j(\theta)$ be an analytic choice of a normalized element of $\text{ran}(P_j(\theta)) = \text{ker}(\mathcal{E}_{\theta} - \lambda_j(\theta)).$ As in [\[11\]](#page-45-14), with $\tilde{v}_j(\theta) = V_\theta^{-1} v_j(\theta)$, we have

$$
\frac{\partial \lambda_j}{\partial \theta}(\theta) = \frac{\partial}{\partial \theta} \langle v_j(\theta), \mathcal{E}_{\theta} v_j(\theta) \rangle \n= \frac{\partial}{\partial \theta} \langle \tilde{v}_j(\theta), \tilde{\mathcal{E}}_{\theta} \tilde{v}_j(\theta) \rangle \n= \frac{i}{p} \langle \tilde{v}_j(\theta), \tilde{B}_{\theta} \tilde{v}_j(\theta) \rangle \n= \frac{i}{p} \langle v_j(\theta), B_{\theta} v_j(\theta) \rangle.
$$

Additionally,

$$
\lim_{L \to \infty} \frac{1}{L} \left\langle v_j(\theta), \sum_{\ell=0}^{L-1} \mathcal{E}_{\theta}^{\ell} B_{\theta} \mathcal{E}_{\theta}^{-\ell} v_k(\theta) \right\rangle = \lim_{L \to \infty} \frac{1}{L} \sum_{\ell=0}^{L-1} \frac{\lambda_j^{\ell}(\theta)}{\lambda_k^{\ell}(\theta)} \langle v_j(\theta), B_{\theta} v_k(\theta) \rangle
$$
\n
$$
= \begin{cases} \langle v_j(\theta), B_{\theta} v_k(\theta) \rangle & \text{if } j = k \\ 0 & \text{otherwise} \end{cases}
$$

Thus, [\(9.3\)](#page-43-1) follows.

Proof of Theorem [9.4.](#page-41-0) Once one has (9.3) , then we can simply follow the proof of [\[11,](#page-45-14) Theorem 1.6]. In particular, we get the conclusions of Theorem [9.4](#page-41-0) with

$$
Q = -ip\mathcal{F}^{-1}\left(\int_{[0,2\pi)}^{\oplus} \sum_{j=1}^{p} \frac{\partial \lambda_j}{\partial \theta}(\theta) P_j(\theta) \frac{d\theta}{2\pi}\right) \mathcal{F} \mathcal{E}^*.
$$

More specifically, dominated convergence yields

$$
(9.4) \qquad \lim_{L \to \infty} \int_{[0,2\pi)}^{\oplus} \left(\frac{1}{L} \sum_{\ell=0}^{L-1} \mathcal{E}_{\theta}^{\ell} B_{\theta} \mathcal{E}_{\theta}^{-\ell} \right) \frac{d\theta}{2\pi} = -ip \int_{[0,2\pi)}^{\oplus} \sum_{j=1}^{m} \frac{\partial \lambda_j}{\partial \theta}(\theta) P_j(\theta) \frac{d\theta}{2\pi},
$$

where the limit on the left hand side is taken in the operator norm topology. The left hand side is simply

$$
\lim_{L \to \infty} \frac{1}{L} \sum_{\ell=0}^{L-1} \widehat{B(\ell)},
$$

so, we can conjugate both sides of (9.4) by $\mathcal F$ to obtain

$$
\lim_{L \to \infty} \frac{1}{L} \sum_{\ell=0}^{L-1} B(\ell) = Q\mathcal{E}
$$

The theorem then follows from (9.1) and the arguments in [\[11\]](#page-45-14).

Proof of Theorem [9.1.](#page-39-3) This follows from Theorem [9.4](#page-41-0) just as in [\[11\]](#page-45-14), since our choice of X does not change the transport exponents. $\hfill \Box$
