# High-energy waves in superpolynomial FPU-type chains

#### Abstract

We consider periodic traveling waves in FPU-type chains with superpolynomial interaction forces and derive explicit asymptotic formulas for the high-energy limit as well as bounds for the corresponding approximation error. In the proof we adapt twoscale techniques that have recently been developed by Herrmann and Matthies for chains with singular potential and provide an asymptotic ODE for the scaled distance profile.

### 1 Introduction

Hamiltonian lattices appear in many branches of physics and materials science as simple dynamical models for spatially discrete systems with energy conservation. Of particular importance are coherent structures such as traveling waves, which can be regarded as the nonlinear fundamental modes and provide the building blocks for more complex solutions.

From a mathematical point of view, Hamiltonian lattice waves are rather complicate because they are not determined by ODEs – as the counterparts in spatially continuous systems – but by nonlocal advance-delay-differential equations. In the prototypical case of a one-dimensional chain with nearest neighbor interactions, which we refer to as Fermi-Pasta-Ulam or FPU-type chain, the problem consists in finding scalar profile functions  $\mathcal{V}$  and  $\mathcal{R}$  along with a speed  $\sigma$  such that

$$-\sigma \mathcal{R}'(x) = \mathcal{V}\left(x + \frac{1}{2}\right) - \mathcal{V}\left(x - \frac{1}{2}\right), \qquad -\sigma \mathcal{V}'(x) = \Phi'\left(\mathcal{R}\left(x + \frac{1}{2}\right)\right) - \Phi'\left(\mathcal{R}\left(x - \frac{1}{2}\right)\right)$$
(1)

is satisfied for all  $x \in \mathbb{R}$ . Here,  $\Phi'$  is the derivative of the interaction potential and  $x = j - \sigma t$  denotes the continuous phase variable, that is the spatial coordinate in the co-moving frame. The profiles  $\mathcal{V}$ and  $\mathcal{R}$  are related to the atomic velocities and distances, respectively, since we have

 $\dot{u}_j(t) = \mathcal{V}(j - \sigma t), \qquad u_{j+1}(t) - u_j(t) = \mathcal{R}\left(j + \frac{1}{2} - \sigma t\right)$

for any traveling wave in the FPU-type chain  $\ddot{u}_j = \Phi'(u_{j+1} - u_j) - \Phi'(u_j - u_{j-1}).$ 

For the integrable examples – the linear case, the Toda chain, and the hard-sphere model – the complete solution set to the nonlocal equation (1) is known, see [Tes01, DHM06] and the references therein. For general potentials, however, there exists nowadays a sophisticated existence theory for different types of traveling waves, see the discussion below, but only very little is known about their qualitative properties. In particular, there is no result that guarantees the uniqueness or the dynamical stability of traveling waves in a chain with arbitrary but convex interaction potential. Mathematically, this lack of information is intimately related to the characteristic features of (1). First, the advance-delay structure prevents the exploitation of many concepts and methods that have been proven powerful in the context of low-dimensional ODEs and delay equations. Second, the underlying lattice flow is symplectic and exhibits a richer dynamical behavior than dissipative particle systems.

Since a complete understanding of the general case is currently out of reach, we are naturally interested in special potentials and asymptotic regimes that allow for almost explicit or approximate solutions of (1) and hence to investigate the open mathematical problems in a simplified setting. The most prominent example is the near-sonic limit, in which nonlinear lattices can be modeled by the Korteweg-de Vries equation. The advance-delay-differential equations (1) can hence by replaced by a planar ODE, see [FP99, FM02, FM03, Miz11, FML14, HML15] for rigorous approximation formulas, [FP02, FP04a, FP04b, HW08, HW09, Miz13] for stability proofs, and [DP14, GMWZ14, JP14] for generalizations to granular and polyatomic chains. We also refer to [IJ05, DHM06] for the small-amplitude limit, to [Jam12] for the case of near-binary interactions, and to [TV05, SZ09, TV10, SZ12, HMSZ13, TV14] for almost explicit traveling wave solutions in chains with piecewise linear force terms or small perturbations of such systems.

Another asymptotic regime is the high-energy limit for chains with singular potential in which particle interactions can be interpreted as elastic collisions, see [FM02, Tre04]. It has recently been shown in [HM15] by a rigorous twoscale expansion that traveling waves in this limit are determined by an asymptotic ODE initial-value problem, which governs the behavior of the appropriately scaled distance profile. This observation provides a good starting point for further investigations because the limiting ODE problem yields the explicit scaling law for the wave speed as well as global approximation formulas for both the distance and the velocity profile.

In this paper we study the high-energy limit for potentials that do not possess a singularity but grow exponentially. Our overall strategy is similar to [HM15] since we likewise employ local scalings in order to characterize the fine properties of the wave profiles near the critical positions and up to high accuracy. The details, however, are different because we have to impose other scaling relations and to deviate in the justification of the asymptotic estimates. Moreover, the final approximation formulas are more explicit because in our case the asymptotic ODE turns out to be integrable.

#### 1.1 Family of traveling waves and high-energy limit

The literature contains many results that establish the existence of periodic or solitary waves in FPUtype chains with fairly general interaction potential. We refer, for instance, to [FW94, FV99, Her10] for constrained optimization, to [SW97, Pan05] for critical-point techniques, and to [IJ05] for centermanifold reduction. There is, however, no related uniqueness result although it is commonly believed that the different approaches yield – at least for convex potentials – the same family of waves.

In what follows we restrict our considerations to a periodic setting (the solitary case can be studied along the same lines) and construct traveling waves by the constrained maximization of a potential-energy functional subject to certain constraints. More precisely, we study a *normalized* velocity profile V, which is supposed to be 2L-periodic, along with the optimization problem

Maximize 
$$\mathcal{P}_{\delta}(V)$$
 subject to  $||V||_2 = 1$  and  $V \in \mathcal{C}$ , (2)

where the parameter  $\delta > 0$  becomes small in the high-energy-limit. The potential-energy functional

 $\mathcal{P}_{\delta}$  is defined by

$$\mathcal{P}_{\delta}(V) := \int_{-L}^{+L} \Phi\left(\frac{(\mathcal{A}V)(x)}{\delta}\right) \mathrm{d}x, \qquad (\mathcal{A}V)(x) := \int_{x-\frac{1}{2}}^{x+\frac{1}{2}} V(\tilde{x}) \,\mathrm{d}\tilde{x}, \tag{3}$$

where the operator  $\mathcal{A}$  can be viewed as the convolution with the indicator function of the symmetric unit interval and provides the *normalized distance profile* via  $R := \mathcal{A}V$ . Moreover,  $\|\cdot\|_p$  abbreviates for any  $p \in [1, \infty]$  the usual Lebesgue norm, evaluated on the periodicity cell [-L, +L], and the cone  $\mathcal{C}$  consists of all functions that are even, nonnegative, and unimodal on the periodicity cell, i.e.,

$$\mathcal{C} := \left\{ V : V(-x) = V(x) \ge V(\tilde{x}) \ge 0 \text{ for almost all } 0 \le x \le \tilde{x} \le L \right\}.$$
(4)

The key observation, see Proposition 2 below, is that any solution  $V_{\delta}$  to the constrained optimization problem (2) satisfies the integral equation

$$\lambda_{\delta}^2 V_{\delta} = \frac{1}{\delta} \mathcal{A} \Phi' \left( \frac{\mathcal{A} V_{\delta}}{\delta} \right) \tag{5}$$

for some multiplier  $\lambda_{\delta}^2 > 0$ , and differentiation with respect to x reveals

$$R_{\delta}'(x) = V_{\delta}\left(x + \frac{1}{2}\right) - V_{\delta}\left(x - \frac{1}{2}\right), \qquad V_{\delta}'(x) = \frac{1}{\delta\lambda_{\delta}^{2}} \left(\Phi'\left(\frac{R_{\delta}\left(x + \frac{1}{2}\right)}{\delta}\right) - \Phi'\left(\frac{R_{\delta}\left(x - \frac{1}{2}\right)}{\delta}\right)\right), \quad (6)$$

where  $R_{\delta}$  is shorthand for  $\mathcal{A}V_{\delta}$ . In particular, any maximizer of  $\mathcal{P}_{\delta}$  provides via

$$\mathcal{V}_{\delta}(x) := -\lambda_{\delta} V_{\delta}(x) , \qquad \mathcal{R}_{\delta}(x) := \frac{R_{\delta}(x)}{\delta} , \qquad \sigma_{\delta} := \lambda_{\delta} \delta$$
(7)

a solution to (1) and hence a periodic traveling wave in the chain. It is, however, more convenient to work with the normalized profiles  $V_{\delta}$  and  $R_{\delta}$  because these converge in the high-energy limit  $\delta \to 0$  while  $\mathcal{V}_{\delta}$  and  $\mathcal{R}_{\delta}$  become unbounded.

In this paper we fix  $2 < L < \infty$  and assume that the force term  $\Phi'(r)$  grows like  $r^{\mu} \exp(r)$ , where  $\mu \in \mathbb{R}$  is a given parameter. A prototypical example (with  $\mu = m$ ) is

$$\Phi'(r) = \left(r^m + c_{m-1}r^{m-1} + c_1r^1\right)\exp\left(r\right), \qquad m \in \mathbb{N}, \qquad c_1, ..., c_{m-1} \ge 0$$

but our setting also covers (with  $\mu = 0$ ) the Toda case, in which the particles interact via

$$\Phi_{\text{Toda}}'(r) = \exp\left(r\right) - 1.$$
(8)

More generally, in what follows we study the following class of FPU-type chains, where some constants have been normalized to ease the presentation.

Assumption 1 (properties of the force function).  $\Phi'$  can be written as

$$\Phi'(r) = \Psi(r) \exp\left(r\right)$$


where  $\Psi : \mathbb{R}_+ \to \mathbb{R}_+$  is continuously differentiable with

$$\Psi(0) = 0$$

and satisfies

$$\Psi(r) > 0$$
,  $\Psi'(r) + \Psi(r) \ge 0$ ,  $\left| \frac{\Psi(r)}{r^{\mu}} - 1 \right| \le \frac{C}{r}$  for all  $r > 0$ 

and some constants C > 0,  $\mu \in \mathbb{R}$ . In particular, the interaction potential  $\Phi$  is convex on  $\mathbb{R}_+$ , attains a global minimum in 0 and grows like  $r^{\mu} \exp(r)$  as  $r \to \infty$ .

The asymptotic analysis presented below is based on the following result, which is illustrated in Figure 1 and proven in Appendix A using arguments from [Her10]. Notice that the convexity of  $\Phi$  – or equivalently, the monotonicity of  $\Phi'$  – is needed to ensure the existence wave profiles within the cone C.

**Proposition 2** (family of traveling waves and convergence in the high-energy limit). For any  $\delta > 0$  there exist a maximizer  $V_{\delta}$  and a Lagrangian multiplier  $\lambda_{\delta}^2 > 0$  such that

- 1. the traveling wave equations (5) and (6) are satisfied,
- 2.  $V_{\delta}$  fulfills the norm constraints  $||V_{\delta}||_1 = 1$ ,
- 3. both  $V_{\delta}$  and  $R_{\delta}$  are 2L-periodic, belong to C, and are pointwise positive.

Moreover, we have

$$\left\|V_{\delta} - V_{0}\right\|_{2} + \left\|R_{\delta} - R_{0}\right\|_{\infty} \xrightarrow{\delta \to 0} 0, \qquad (9)$$

where  $V_0$  is the indicator function of the interval  $\left[-\frac{1}{2}, +\frac{1}{2}\right]$  and  $R_0 = \mathcal{A}V_0$  is a tent map.

#### 1.2 Main result and discussion

In this paper we improve the convergence part of Proposition 2 by adapting the twoscale approach from [HM15]. The key step is to study the convergence under the *tip scaling* in §2.1, which describes the fine structure of  $R_{\delta}$  in the vicinity of x = 0 and reveals the aforementioned asymptotic ODE initial-value problem. In our case, this problem reads

$$S_0''(y) = 2\exp\left(-S_0(y)\right), \qquad S_0'(y) = S_0(y) = 0, \tag{10}$$

and admits the explicit solution

$$S_0(y) = 2\ln\left(\cosh\left(y\right)\right). \tag{11}$$

Afterwards we employ in §2.2 the transition scaling and the foot scaling in order to characterize the jump-like behavior of the velocity profile  $v_{\delta}$  near  $x = \pm \frac{1}{2}$  and the turn of the distance profiles near  $x = \pm 1$ , respectively. In this way we identify the scaling law for the speed parameter  $\lambda_{\delta}$  as well as refined asymptotic formulas for the normalized profiles, see §2.3 and §2.4, respectively. Our main findings are formulated in Proposition 5 and Theorem 6, and can be summarized as follows.

Main result. In the high-energy limit, the wave profiles from Proposition 2 can be approximated by

$$\overline{V}_{\delta}(x) := \frac{(1+\delta)\sinh\left(\frac{1}{2\delta}\right)}{\cosh\left(\frac{1}{2\delta}\right) + \cosh\left(\frac{x}{\delta}\right)}, \qquad \overline{R}_{\delta}(x) := \left(\delta + \delta^2\right)\ln\left(1 + \frac{\sinh^2\left(\frac{1}{2\delta}\right)}{\cosh^2\left(\frac{x}{2\delta}\right)}\right) \tag{12}$$

and we have

$$\lambda_{\delta}^2 \delta^{\mu} \exp\left(-\frac{1}{\delta}\right) \xrightarrow{\delta \to 0} \exp\left(1\right).$$
 (13)

More precisely, there exist a constant C independent of  $\delta$  such that

$$\left\|V_{\delta} - \overline{V}_{\delta}\right\|_{p} \le C\delta \left\|V_{\delta} - V_{0}\right\|_{p} \le C\delta^{1+1/p}, \qquad \left\|R_{\delta} - \overline{R}_{\delta}\right\|_{p} \le C\delta \left\|R_{\delta} - R_{0}\right\|_{p} \le C\delta^{2}$$
(14)

holds for any  $1 \le p \le \infty$ , where the norms have to be evaluated on the periodicity cell [-L, +L].

A similar result holds in the case of solitary waves  $(L = \infty)$  but the corresponding proof is more technical, see the related remarks to Theorem 6 and in Appendix A. Our method can also be applied to other superpolynomially growing functions  $\Phi'$  but the fundamental scaling relations and the proof details might be different. Unfortunately, the approach does not cover the high-energy limit of polynomial interaction potentials: If  $\Phi'$  is a polynomial of degree m, the solution set to (5) exhibits asymptotically the invariance  $(\delta, V, R, \lambda^2) \leftrightarrow (\eta \delta, \eta V, \eta R, \lambda^2/\eta)$  and the limit  $\delta \to 0$  is hence not governed by an ODE but by the advance-delay-differential equations (6) with  $\delta = 1$  and  $\Phi'(r) = r^m$ . In this case, however, the arguments presented below can be adapted to derive asymptotic formulas for the limit  $m \to \infty$ .

We also recall that [HM15] concerns Lennard-Jones-type potentials with algebraic singularity of order m > 1, which requires to modify the fundamental scaling relations and the details in the asymptotic analysis. Moreover, the corresponding asymptotic ODE  $S_0''(y) = c_m(1 + S_0(y))^{-m-1}$ cannot be integrated analytically, so the resulting approximation formulas are less explicit than (12), and the guaranteed error bounds are not given by (14) but take another form and depend on  $\delta^m$ .

The asymptotic ODE (10) reveals that the dynamics of the distance  $r_j = u_{j+1} - u_j$  between the particles j and j+1 is for some times almost completely determined by  $r_j$  itself and hence independent of  $r_{j-1}$  and  $r_{j+1}$ . On the conceptional level, the high-energy limit can therefore be interpreted as the asymptotic regime in which the interactions between nearest neighbors can be neglected. The similar concept of an anticontinuum limit has been studied for a huge class of many-particle systems such as the discrete nonlinear Schrödinger equation, Klein-Gordan systems, and dimer chains (see, e.g. [MA94, FDMF03, BP13, CBCCMK14]). There is, however, an important difference: The decoupling, which manifests in the tip scaling, describes the effective dynamics of  $r_j$  only for certain times, namely those corresponding to  $-\frac{1}{2} < x < \frac{1}{2}$ , whereas the complete information on the waves can only be obtained by combining the different scalings. The foot scaling, for instance, reflects that for  $-\frac{3}{2} < x < -\frac{1}{2}$  and  $+\frac{1}{2} < x < +\frac{3}{2}$  the dynamics of  $r_j$  is asymptotically governed by  $r_{j+1}$  and  $r_{j-1}$ , respectively.

We conclude the introduction with some comments on the Toda chain (8). For this integrable model, periodic traveling waves can be expressed in terms of Jacobi elliptic functions, see [Tod67, Whi74], and we readily justify that

$$\mathcal{V}_{\mathrm{Toda},\,\beta}(x) := -\frac{2\sinh^2\left(\frac{1}{\beta}\right)}{\cosh\left(\frac{1}{\beta}\right) + \cosh\left(\frac{2x}{\beta}\right)}, \qquad \mathcal{R}_{\mathrm{Toda},\,\beta}(x) := \ln\left(1 + \frac{\sinh^2\left(\frac{1}{\beta}\right)}{\cosh^2\left(\frac{x}{\beta}\right)}\right)$$

along with

$$\sigma_{\mathrm{Toda},\,\beta} := \beta \sinh\left(\frac{1}{\beta}\right)$$

provide for any  $\beta > 0$  an exact solitary wave with unimodal and exponentially decaying wave profiles. We thus infer from (14) that the non-normalized profile functions  $\mathcal{V}_{\delta}$  and  $\mathcal{R}_{\delta}$  from (7) have for small  $\delta > 0$  basically the same shape as the solitary Toda wave with  $\beta = 2\delta$ , but the wave speed and the wave amplitudes scale differently since (13) depends on  $\mu$ , the leading algebraic order of the perturbation term  $\Psi$ .

We also emphasize that for  $\Phi' = \Phi'_{\text{Toda}}$  the error terms  $\|V_{\delta} - \overline{V}_{\delta}\|_p$  and  $\|R_{\delta} - \overline{R}_{\delta}\|_p$  are *not*, as one might guess, exponentially small in  $\delta$  but as large as the related bounds in (14). This seems to be surprising but just means that the formulas in (12) are not optimal for the Toda chain. In fact, our approach applied to (8) also provides high-energy approximations with exponential accuracy, see the discussion at the end of §2.4, but such formulas can directly be derived by asymptotic analysis of Jacobi's elliptic functions. For a nontrivial perturbation term  $\Psi$ , however, there are no explicit solution formulas and numerical results indicate that the estimates in (14) are optimal, see Figure 4.

## 2 Asymptotic analysis

The starting point for our considerations is the second-order advance-delay-differential equation

$$R_{\delta}''(x) = \frac{1}{\delta\lambda_{\delta}^{2}} \left( \Phi'\left(\frac{R_{\delta}(x+1)}{\delta}\right) + \Phi'\left(\frac{R_{\delta}(x-1)}{\delta}\right) - 2\Phi'\left(\frac{R_{\delta}(x)}{\delta}\right) \right), \tag{15}$$

which can be derived from (6) by eliminating the velocity profile  $V_{\delta}$ . It is also convenient to introduce the scalar quantities

$$a_{\delta} := \frac{\delta}{R_{\delta}(0)}, \qquad b_{\delta} := \sqrt{\delta^2 a_{\delta}^{\mu} \lambda_{\delta}^2 \exp\left(-\frac{1}{a_{\delta}}\right)}, \tag{16}$$

which appear naturally in many of the asymptotic formulas and estimates identified below. From (9) we immediately infer that the amplitude parameter  $a_{\delta}$  satisfies

$$\frac{a_{\delta}}{\delta} \quad \xrightarrow{\delta \to 0} \quad \frac{1}{R_0(0)} = 1 \tag{17}$$

but at this moment we do not know how  $b_{\delta}$  depends on  $\delta$ . Below, however, we see that  $b_{\delta}$  is an intrinsic length which determines the width of the transition layers in the velocity profile  $V_{\delta}$  near  $x = \pm \frac{1}{2}$  as well as the fine properties of the distance profile  $R_{\delta}$  near x = 0 and  $x = \pm 1$ . These observations finally imply  $b_{\delta} = 2\delta + O(\delta^2)$  and enable us to identify the scaling law for  $\lambda_{\delta}$ , see Proposition 5.

Throughout the paper, we denote by c and C generic positive constants – being rather small and large, respectively – which are independent of  $\delta$  but can depend on the function  $\Psi$  from Assumption 1 and the periodicity parameter L. In all proofs we further assume – without saying so explicitly– that  $\delta$  is positive but sufficiently small.

#### 2.1 Tip scaling

Our first goal is to describe the 'tip of the tent', that is the asymptotic behavior of the distance profiles near x = 0. To this end we introduce a scaled space variable  $y \in \mathbb{R}$  by

$$x = b_{\delta} y \tag{18}$$

as well as the scaled distance profile  $S_{\delta}$  via

$$S_{\delta}(y) := \frac{1}{a_{\delta}} - \frac{1}{\delta} R_{\delta}(b_{\delta}y) , \qquad (19)$$




Figure 2: The scaled wave profiles  $S_{\delta}$  (*left*),  $W_{\delta}$  (*center*), and  $T_{\delta}$  (*right*) – see (19), (46), and (47) – for the second simulation from Figure 1 as function of the scaled space variable y from (18). The solid gray and dashed black lines represent the exact values for  $\delta = 0$  and the numerical data for  $\delta = 0.09$ , respectively. The shaded region indicates the interval  $I_{\delta}$  from (21) and the corresponding approximation error is shown in Figure 3.

which is even and satisfies

$$S_{\delta}(0) = S_{\delta}'(0) = 0.$$
<sup>(20)</sup>

The key ingredient to our asymptotic analysis is to show that the scaled distance profile satisfies

$$S_{\delta}''(y) \approx 2 \exp\left(-S_{\delta}(y)\right)$$

on the interval

$$I_{\delta} = [-y_{\delta}^*, +y_{\delta}^*], \qquad y_{\delta}^* := \frac{1}{2b_{\delta}},$$
(21)

which corresponds to the domain  $|x| \leq \frac{1}{2}$ . We can therefore approximate  $S_{\delta}$  by  $S_0$  from (11), which is the solution to the ODE initial-value problem (10). The graphs of  $S_{\delta}$  and  $S_0$  are illustrated in the left panel of Figure 2.

**Proposition 3** (convergence under the tip scaling). There exists a constant C such that

$$\sup_{y \in I_{\delta}} |S_{\delta}(y) - S_{0}(y)| + |S_{\delta}'(y) - S_{0}'(y)| + |S_{\delta}''(y) - S_{0}''(y)| \leq C\delta$$
(22)

and

$$\left|y_{\delta}^{*}S_{\delta}'(y_{\delta}^{*}) - y_{\delta}^{*}S_{0}'(y_{\delta}^{*})\right| \leq C\delta, \qquad \int_{I_{\delta}} \left|S_{\delta}'(y) - S_{0}'(y)\right| \mathrm{d}y \leq C\delta$$

$$(23)$$

hold for all sufficiently small  $\delta > 0$ .

*Proof.* <u>Preliminaries</u>: Since  $S_{\delta}$  is even due to  $R_{\delta} \in C$  and (19), it is sufficient to consider values y with

$$0 \le y \le y_{\delta}^* \,. \tag{24}$$

The convergence in (9) and the unimodality of  $R_{\delta}$  ensure

$$\frac{1}{4} \le R_{\delta}\left(\pm\frac{1}{2}\right) \le \frac{3}{4}, \qquad \frac{3}{4} \le R_{\delta}(0) \le \frac{5}{4}$$
 (25)

as well as

$$R_{\delta}(b_{\delta}y \pm 1) \le R_{\delta}\left(\pm \frac{1}{2}\right) \le R_{\delta}(b_{\delta}y) \le R_{\delta}(0) \tag{26}$$

for all y under consideration. In particular,  $S_{\delta}$  is nonnegative on  $I_{\delta}$ .

<u>Perturbed ODE for  $S_{\delta}$ </u>: Combining (19) with the second-order advance-delay differential equation (15) we obtain

$$\frac{\delta^2 \lambda_{\delta}^2}{b_{\delta}^2} S_{\delta}''(y) = 2\Phi' \left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right) - \Phi' \left(\frac{R_{\delta}(b_{\delta}y-1)}{\delta}\right) - \Phi' \left(\frac{R_{\delta}(b_{\delta}y+1)}{\delta}\right)$$
(27)

and infer from (26) that  $S_{\delta}$  is convex on  $I_{\delta}$  ( $S_0$  is convex on  $\mathbb{R}$ ). Due to (19) and since (16) implies

$$\frac{b_{\delta}^2}{\delta^2 \lambda_{\delta}^2} = a_{\delta}^{\mu} \exp\left(-\frac{1}{a_{\delta}}\right),\tag{28}$$

equation (27) can be written as

$$S_{\delta}''(y) = 2\frac{b_{\delta}^2}{\delta^2 \lambda_{\delta}^2} \Phi'\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right) + f_{\delta}(y) = 2\exp\left(-S_{\delta}(y)\right) + f_{\delta}(y) + g_{\delta}(y), \qquad (29)$$

where the error terms are given by

$$f_{\delta}(y) := -\frac{b_{\delta}^2}{\delta^2 \lambda_{\delta}^2} \left( \Phi' \left( \frac{R_{\delta}(b_{\delta}y - 1)}{\delta} \right) + \Phi' \left( \frac{R_{\delta}(b_{\delta}y + 1)}{\delta} \right) \right)$$

and

$$g_{\delta}(y) := 2 \exp\left(-S_{\delta}(y)\right) \left(a_{\delta}^{\mu} \Psi\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right) - 1\right).$$
(30)

<u>Pointwise estimates for  $f_{\delta}$  and  $g_{\delta}$ </u>: The first error term can – due to (17), (25), (26), and (28) – be bounded by

$$\sup_{y \in I_{\delta}} \left| f_{\delta}(y) \right| = a_{\delta}^{\mu} \exp\left(-\frac{1}{a_{\delta}}\right) \left( \Phi'\left(\frac{R_{\delta}(b_{\delta}y-1)}{\delta}\right) + \Phi'\left(\frac{R_{\delta}(b_{\delta}y+1)}{\delta}\right) \right)$$
  
$$\leq C\delta^{\mu} \exp\left(-\frac{1}{a_{\delta}}\right) \Phi'\left(\frac{3}{4\delta}\right) \leq C \exp\left(-\frac{c}{\delta}\right),$$
(31)

where we also used the monotonicity and the asymptotic behavior of  $\Phi'$ . To estimate the second error term, we observe that

$$a_{\delta}^{\mu}\Psi\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right) - 1 = \left(a_{\delta}^{\mu}\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu} - 1\right) + a_{\delta}^{\mu}\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu}\left(\frac{\Psi\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)}{\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu}} - 1\right)$$

and with (19) we conclude

$$\left(a_{\delta}^{\mu}\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu}-1\right)=\left(1-a_{\delta}S_{\delta}(y)\right)^{\mu}-1.$$

Moreover, (17) combined with (19) and (26) guarantees

$$c \leq 1 - a_{\delta} S_{\delta}(y) = \frac{a_{\delta}}{\delta} R_{\delta}(b_{\delta} y) \leq C,$$

so a simple Taylor argument provides

$$\left|a_{\delta}^{\mu}\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu}-1\right| \leq Ca_{\delta}S_{\delta}(y) \leq C\delta S_{\delta}(y).$$

On the other hand, thanks to Assumption 1, (17), and (25)+(26) we estimate

$$a_{\delta}^{\mu} \left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu} \left| \frac{\Psi\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)}{\left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu}} - 1 \right| \le Ca_{\delta}^{\mu} \left(\frac{R_{\delta}(b_{\delta}y)}{\delta}\right)^{\mu-1} \le C\delta$$

and summing the last two results we deduce from (30) that

$$\sup_{y \in I_{\delta}} \left| g_{\delta}(y) \right| \le C\delta \exp\left( -S_{\delta}(y) \right) \left( 1 + S_{\delta}(y) \right) \le C\delta \exp\left( -cS_{\delta}(y) \right).$$
(32)

Upper bound for  $b_{\delta}$ : Employing (17) as well as the properties of  $\Phi'$ ,  $R_{\delta}$ , and  $\mathcal{A}$  we show that

$$\frac{1}{\delta} \left( \mathcal{A}\Phi'\left(\frac{R_{\delta}(x)}{\delta}\right) \right)(x) \leq \frac{1}{\delta}\Phi'\left(\frac{1}{a_{\delta}}\right) \leq \frac{C}{\delta^{\mu+1}} \exp\left(\frac{1}{a_{\delta}}\right) \quad \text{for all} \quad x \,,$$

and testing the traveling wave equation (5) with  $V_0$  gives

$$c\lambda_{\delta}^{2} \leq \lambda_{\delta}^{2} \int_{-1/2}^{1/2} V_{\delta}(x) V_{0}(x) \, \mathrm{d}x \leq \frac{C}{\delta^{\mu+1}} \exp\left(\frac{1}{a_{\delta}}\right)$$

thanks to  $V_{\delta} \to V_0$  and  $\int_{-1/2}^{+1/2} V_0(x)^2 dx = 1$ , see Proposition 2. The estimate

$$b_{\delta} \le C\sqrt{\delta} \tag{33}$$

is therefore granted by (16) and (17). In particular, the interval  $I_{\delta}$  is large and we have

$$y_{\delta}^* > 1. \tag{34}$$

Local approximation estimates: We define

$$d_{\delta}(y) := |S_{\delta}(y) - S_0(y)| + |S'_{\delta}(y) - S'_0(y)|$$

and recall that

$$\left|\exp\left(-S_{\delta}(y)\right) - \exp\left(-S_{0}(y)\right)\right| \le e_{\delta}(z) \left|S_{\delta}(y) - S_{0}(y)\right|,\tag{35}$$

where

$$e_{\delta}(z) := \exp\left(-\min\left\{S_{\delta}(z), S_0(z)\right\}\right)$$

Moreover, by standard arguments we derive from the ODE initial-value problems (10) and (20)+(29) the Gronwall-type inequality

$$d_{\delta}(y) \le C \int_{0}^{y} \left( e_{\delta}(\tilde{y}) d_{\delta}(\tilde{y}) + f_{\delta}(\tilde{y}) + g_{\delta}(\tilde{y}) \right) \mathrm{d}\tilde{y} \,, \tag{36}$$

which controls the growth of  $d_{\delta}$ . More precisely, for  $0 \leq y \leq 1$  and using (31), (32), and (34) we estimate

$$e_{\delta}(y) \le 1$$
,  $f_{\delta}(y) \le C\delta$ ,  $g_{\delta}(y) \le C\delta$ ,

so (36) implies

$$d_{\delta}(y) \le C \int_{0}^{y} d_{\delta}(\tilde{y}) \,\mathrm{d}\tilde{y} + C\delta =: D_{\mathrm{loc},\,\delta}(y)$$

and hence

$$D'_{\mathrm{loc},\,\delta}(y) = Cd_{\delta}(y) \le CD_{\mathrm{loc},\,\delta}(y), \qquad D_{\mathrm{loc},\,\delta}(0) \le C\delta$$

for all  $0 \le y \le 1$ . The comparison principle for scalar ODE thus ensures

$$\sup_{0 \le y \le 1} d_{\delta}(y) \le \sup_{0 \le y \le 1} D_{\operatorname{loc}, \delta}(y) \le C\delta,$$

and this gives

$$\frac{3}{2}S_0(1) \ge S_{\delta}(1) \ge \frac{1}{2}S_0(1) > 0, \qquad S_{\delta}'(1) \ge \frac{1}{2}S_0'(1) > 0.$$
(37)

<u>Lower bound for  $b_{\delta}$ </u>: Combining (37) with the convexity of  $S_{\delta}$  on  $I_{\delta}$  we prove

$$S_{\delta}(y) \ge \max\left\{0, S_{\delta}(1) + S_{\delta}'(1)(y-1)\right\} \ge \max\left\{0, cy - C\right\}$$
(38)

for all y with (24), and evaluating (19) for  $y = y_{\delta}^*$  we establish – using also (25)+(34) – the inequalities

$$\frac{c}{b_{\delta}} \le S_{\delta}(y_{\delta}^*) = \frac{R_{\delta}(0) - R_{\delta}\left(\frac{1}{2}\right)}{\delta} \le \frac{C}{\delta} \,.$$

Rearranging terms we obtain

$$b_{\delta} \ge c\delta \tag{39}$$

and hence

$$\int_{0}^{y} (1+\tilde{y}) \left| f_{\delta}(\tilde{y}) \right| d\tilde{y} \le C \exp\left(-\frac{c}{\delta}\right) \int_{0}^{y_{\delta}^{*}} (1+\tilde{y}) d\tilde{y} = C \exp\left(-\frac{c}{\delta}\right) \left(\frac{1}{b_{\delta}} + \frac{1}{b_{\delta}^{2}}\right) \le C\delta$$
(40)

thanks to the upper bound for  $f_{\delta}$  from (31). Moreover, in view of (32), the lower bound (38) also implies

$$\int_{0}^{y} (1+\tilde{y}) \left| g_{\delta}(\tilde{y}) \right| d\tilde{y} \le C\delta \int_{0}^{\infty} (1+\tilde{y}) \exp\left(-c\tilde{y}\right) d\tilde{y} \le C\delta.$$
(41)

<u>Pointwise estimates on the interval  $I_{\delta}$ </u>: By (38) – which also holds for  $S_0$  – we have

$$e_{\delta}(y) \le C \exp\left(-cy\right) \tag{42}$$

and combining this with (40)+(41), we can simplify the Gronwall estimate (36) to

$$d_{\delta}(y) \leq C \int_{0}^{y} \exp\left(-c\tilde{y}\right) d_{\delta}(\tilde{y}) \,\mathrm{d}\tilde{y} + C\delta =: D_{\mathrm{glob},\,\delta}(y) \,.$$

By direct computations we verify

$$D'_{\text{glob},\,\delta}(y) = C \exp\left(-cy\right) d_{\delta}(y) \le C \exp\left(-cy\right) D_{\text{glob},\,\delta}(y) \,, \qquad D_{\text{glob},\,\delta}(0) \le C\delta$$

and infer from the comparison principle for scalar ODEs the global error estimate

$$\sup_{0 \le y \le y_{\delta}^*} d_{\delta}(y) \le \sup_{0 \le y \le y_{\delta}^*} D_{\text{glob},\,\delta}(y) \le C\delta \exp\left(C\int_0^\infty \exp\left(-c\tilde{y}\right) \mathrm{d}\tilde{y}\right) \le C\delta\,,\tag{43}$$

which yields the desired pointwise estimates for  $S_{\delta} - S_0$  and  $S'_{\delta} - S'_0$  on the interval  $I_{\delta}$ . The corresponding thesis for the second derivatives is a direct consequence of the estimates derived so far and the ODEs (10)+(29). In particular, we have shown (22).

Further estimates on  $I_{\delta}$ : We define

$$G_{\delta}(y) := y S_{\delta}'(y) - S_{\delta}(y)$$

and employ (10), (29), and (35) to obtain

$$\begin{split} \int_{0}^{y_{\delta}^{*}} \left| G_{\delta}'(y) - G_{0}'(y) \right| \mathrm{d}y &= \int_{0}^{y_{\delta}^{*}} \left| y S_{\delta}''(y) - y S_{0}''(y) \right| \mathrm{d}y \\ &\leq \int_{0}^{y_{\delta}^{*}} y \Big( e_{\delta}(y) d_{\delta}(y) + \left| f_{\delta}(y) \right| + \left| g_{\delta}(y) \right| \Big) \mathrm{d}y \,. \end{split}$$

Inserting (40), (41), (42), and (43) gives

$$\int_{0}^{y_{\delta}^{*}} \left| G_{\delta}'(y) - G_{0}'(y) \right| \mathrm{d}y \le C\delta \,, \tag{44}$$

and in view of  $G_{\delta}(0) = G_0(0)$  we arrive at

$$\sup_{0 \le y \le y_{\delta}^*} \left| G_{\delta}(y) - G_0(y) \right| \le C\delta \,,$$

which implies in combination with (22) the first claim in (23). Moreover, integrating the identity

$$S'_{\delta}(y) - S'_{0}(y) = S'_{\delta}(y^{*}_{\delta}) - S'_{0}(y^{*}_{\delta}) - \int_{y}^{y^{*}_{\delta}} S''_{\delta}(\tilde{y}) - S''_{0}(\tilde{y}) \,\mathrm{d}\tilde{y}$$

we obtain

$$\begin{split} \int_{0}^{y_{\delta}^{*}} \left| S_{\delta}'(y) - S_{0}'(y) \right| \mathrm{d}y &\leq y_{\delta}^{*} \left| S_{\delta}'(y_{\delta}^{*}) - S_{0}'(y_{\delta}^{*}) \right| + \int_{0}^{y_{\delta}^{*}} \left| y S_{\delta}''(y) - y S_{0}''(y) \right| \mathrm{d}y \\ &= \left| y_{\delta}^{*} S_{\delta}'(y_{\delta}^{*}) - y_{\delta}^{*} S_{0}'(y_{\delta}^{*}) \right| + \int_{0}^{y_{\delta}^{*}} \left| G_{\delta}'(y) - G_{0}'(y) \right| \mathrm{d}y \,, \end{split}$$

so  $(23)_2$  follows from  $(23)_1$  and (44).

The proof of Proposition 3 reveals that the estimates (22) and (23) can – at least in principle – be improved as follows. Assuming an asymptotic expansion

$$S_{\delta} = S_0 + \delta S_1 + \dots, \qquad a_{\delta} = \delta + \dots, \tag{45}$$




Figure 3: Numerical values of the scaled approximation error  $E_{\delta}(y) := \delta^{-1}(S_{\delta}(y) - S_0(y))$  on the interval  $I_{\delta}$  for  $\delta = 0.27$  (black),  $\delta = 0.09$  (dark gray), and  $\delta = 0.03$  (light gray). The three panels correspond to different derivatives and provide numerical evidence for the optimality of the pointwise estimates in (22).

the identities (10)+(19)+(29) provide a linear but inhomogeneous and non-autonomous ODE for the coefficient function  $S_1$ , which here is not related to  $\delta = 1$  but denotes  $\frac{d}{d\delta}S_{\delta}|_{\delta=0}$ . For instance, in the case  $\Phi'(r) = r^{\mu} \exp(r)$  we find

$$S_{\delta}''(y) = 2(1 + a_{\delta}S_{\delta}(y))^{\mu} \exp\left(-S_{\delta}(y)\right) + f_{\delta}(y)$$

and obtain

$$S_1''(y) = 2\left(\mu S_0(y) - S_1(y)\right) \exp\left(-S_0(y)\right), \qquad S_1(0) = S_1'(0) = 0$$

as equation for the next-to-leading-order term thanks to (31)+(45). Numerical approximations of  $S_1$  can be found in Figure 3 for the data from Figure 1.

We finally mention that the convergence under the tip scaling is considerably better for the Toda chain (8). In fact,  $g_{\delta}(y)$  from (30) is for any  $y \in I_{\delta}$  much smaller than  $O(\delta)$  and thus we show that the error bounds in (22) and (23) are exponentially small in  $\delta$ .

#### 2.2 Transition and foot scaling

We next characterize the transition layer of the velocity profile  $V_{\delta}$  near  $x = -\frac{1}{2}$  as well as the behavior of the distance profile  $R_{\delta}$  near x = -1 ('foot of the tent') by studying the functions

$$W_{\delta}(y) := \frac{b_{\delta}}{\delta} V_{\delta} \left( -\frac{1}{2} + b_{\delta} y \right) \tag{46}$$

and

$$T_{\delta}(y) := \frac{1}{\delta} R_{\delta}(-1 + b_{\gamma} y), \qquad (47)$$

respectively. In particular, we employ our results on the tip scaling and show that  $W_{\delta}$  and  $T_{\delta}$  behave on the interval  $I_{\delta}$  like

$$W_0(y) := \frac{1}{2}S'_0(y) + 1 = 1 + \tanh(y)$$
(48)

and

$$T_0(y) := \frac{1}{2}S_0(y) + y + \ln 2 = \ln \left(2\cosh(y)\right) + y.$$
(49)

As illustrated in Figure 2,  $W_{\delta}|_{I_{\delta}}$  describes  $V_{\delta}$  on the domain  $-1 \leq x \leq 0$ , while  $T_{\delta}|_{I_{\delta}}$  corresponds to  $R_{\delta}$  restricted to  $-\frac{3}{2} \leq x \leq -\frac{1}{2}$ .

**Proposition 4** (convergence under the transition and the tip scaling). There exists a constant C such that

$$\sup_{y \in I_{\delta}} |W_{\delta}(y) - W_{0}(y)| + |W_{\delta}'(y) - W_{0}'(y)| \le C\delta, \qquad \int_{I_{\delta}} |W_{\delta}(y) - W_{0}(y)| \, \mathrm{d}y \le C\delta$$
(50)

and

$$\sup_{y \in I_{\delta}} |T_{\delta}(y) - T_{0}(y)| + |T_{\delta}'(y) - T_{0}'(y)| + |T_{\delta}''(y) - T_{0}''(y)| \le C\delta$$
(51)

hold for all sufficiently small  $\delta > 0$ .

*Proof.* Formulas for  $W_{\delta}$  and  $T_{\delta}$ : Definition (46) and the traveling wave equation (5) provide

$$W_{\delta}(y) = \frac{b_{\delta}}{\delta^2 \lambda_{\delta}^2} \int_{b_{\delta}y-1}^{b_{\delta}y} \Phi'\left(\frac{R_{\delta}(x)}{\delta}\right) \mathrm{d}x \,,$$

and after splitting off the dominant contributions to the integral (coming from  $|x| \leq \frac{1}{2}$ ) and inserting the second-order advance-delay differential relation (15) we obtain

$$W_{\delta}(y) = -\frac{b_{\delta}}{2\delta} \int_{-1/2}^{b_{\delta}y} R_{\delta}''(x) \,\mathrm{d}x + f_{\delta}(y)$$
(52)

with

$$f_{\delta}(y) := \frac{b_{\delta}}{2\delta^2 \lambda_{\delta}^2} \int_{-1/2}^{b_{\delta}y} \left( \Phi'\left(\frac{R_{\delta}(x-1)}{\delta}\right) + \Phi'\left(\frac{R_{\delta}(x+1)}{\delta}\right) \right) \mathrm{d}x + \frac{b_{\delta}}{\delta^2 \lambda_{\delta}^2} \int_{b_{\delta}y-1}^{-1/2} \Phi'\left(\frac{R_{\delta}(x)}{\delta}\right) \mathrm{d}x$$

and

$$f_{\delta}'(y) = \frac{b_{\delta}^2}{2\delta^2 \lambda_{\delta}^2} \left( \Phi'\left(\frac{R_{\delta}(b_{\delta}y-1)}{\delta}\right) + \Phi'\left(\frac{R_{\delta}(b_{\delta}y+1)}{\delta}\right) \right) - \frac{b_{\delta}^2}{\delta^2 \lambda_{\delta}^2} \Phi'\left(\frac{R_{\delta}(b_{\delta}y-1)}{\delta}\right).$$

Similarly, we derive from (5) and (47) the identity

$$T_{\delta}(y) = \frac{1}{\delta^2 \lambda_{\delta}^2} \int_{b_{\delta}y - \frac{3}{2}}^{b_{\delta}y - \frac{1}{2}} \int_{x - \frac{1}{2}}^{x + \frac{1}{2}} \Phi'\left(\frac{R_{\delta}(\tilde{x})}{\delta}\right) \mathrm{d}\tilde{x} \, \mathrm{d}x \,,$$

which can be written as

$$T_{\delta}(y) = \frac{1}{\delta^{2}\lambda_{\delta}^{2}} \int_{-1}^{b_{\delta}y - \frac{1}{2}} \int_{-\frac{1}{2}}^{x + \frac{1}{2}} \Phi'\left(\frac{R_{\delta}(\tilde{x})}{\delta}\right) d\tilde{x} dx + g_{\delta}(y)$$

$$= -\frac{1}{2\delta} \int_{-1}^{b_{\delta}y - \frac{1}{2}} \int_{-\frac{1}{2}}^{x + \frac{1}{2}} R_{\delta}''(\tilde{x}) d\tilde{x} dx + g_{\delta}(y) + h_{\delta}(y),$$
(53)

where the corresponding error terms are given by

$$g_{\delta}(y) := \frac{1}{\delta^2 \lambda_{\delta}^2} \int_{b_{\delta}y - \frac{3}{2}}^{-1} \int_{x - \frac{1}{2}}^{x + \frac{1}{2}} \Phi'\left(\frac{R_{\delta}(\tilde{x})}{\delta}\right) d\tilde{x} dx + \frac{1}{\delta^2 \lambda_{\delta}^2} \int_{-1}^{b_{\delta}y - \frac{1}{2}} \int_{x - \frac{1}{2}}^{-\frac{1}{2}} \Phi'\left(\frac{R_{\delta}(\tilde{x})}{\delta}\right) d\tilde{x} dx$$

and

$$h_{\delta}(y) := \frac{1}{2\delta^2 \lambda_{\delta}^2} \int_{-1}^{b_{\delta}y - \frac{1}{2}x + \frac{1}{2}} \left( \Phi'\left(\frac{R_{\delta}(\tilde{x} - 1)}{\delta}\right) + \Phi'\left(\frac{R_{\delta}(\tilde{x} + 1)}{\delta}\right) \right) \mathrm{d}\tilde{x} \, \mathrm{d}x \, .$$

<u>Pointwise estimates for the error terms</u>: Employing the unimodality of  $R_{\delta}$  as well as (9) we derive

$$\sup_{|x|\geq 1/2} \Phi'\left(\frac{R_{\delta}(x)}{\delta}\right) \leq \Phi'\left(\frac{R_{\delta}(\pm 1/2)}{\delta}\right) \leq \Phi'\left(\frac{3}{4\delta}\right) \leq \frac{C}{\delta^{\mu}} \exp\left(\frac{3}{4\delta}\right),$$

and infer from (16) the estimate

$$\sup_{|x|\geq 1/2} \frac{b_{\delta}^2}{\delta^2 \lambda_{\delta}^2} \Phi'\left(\frac{R_{\delta}(x)}{\delta}\right) \leq C \frac{a_{\delta}^{\mu}}{\delta^{\mu}} \exp\left(-\frac{1}{a_{\delta}}\right) \exp\left(\frac{3}{4\delta}\right).$$

Consequently, and in view of (17) and (39) we conclude

$$\sup_{y \in I_{\delta}} |f_{\delta}(y)| + |f_{\delta}'(y)| \leq C \exp\left(-\frac{c}{\delta}\right), \qquad \int_{I_{\delta}} |f_{\delta}(y)| \,\mathrm{d}y \leq C \exp\left(-\frac{c}{\delta}\right), \tag{54}$$

where we additionally used that

$$-\frac{3}{2} \le b_{\delta}y - 1 \le -\frac{1}{2}, \qquad +\frac{1}{2} \le b_{\delta}y + 1 \le +\frac{3}{2} \qquad \text{for all} \quad y \in I_{\delta}.$$

In the same way we demonstrate that

$$\sup_{y \in I_{\delta}} |g_{\delta}(y)| + |g_{\delta}'(y)| + |g_{\delta}''(y)| + |h_{\delta}(y)| + |h_{\delta}'(y)| + |h_{\delta}''(y)| \leq C \exp\left(-\frac{c}{\delta}\right).$$
(55)

<u>Estimates for  $W_{\delta}$ </u>: Thanks to the definition and evenness of  $S_{\delta}$ , see (19), we derive from (52) the identities

$$W_{\delta}(y) = \frac{1}{2}S_{\delta}'(y) + \frac{1}{2}S_{\delta}'(y_{\delta}^{*}) + f_{\delta}(y), \qquad W_{\delta}'(y) = \frac{1}{2}S_{\delta}''(y) + f_{\delta}'(y), \tag{56}$$

so  $(50)_1$  follows from (48), (54), and Proposition 3 because the properties of  $S_0$  and (33) ensure that

$$S_0'(y_{\delta}^*) - 2 \Big| \le C \exp\left(-c y_{\delta}^*\right) \le C \delta$$
.

Moreover, by (23)+(54)+(56) we find  $(50)_2$  via

$$\int_{I_{\delta}} |W_{\delta}(y) - W_{0}(y)| \, \mathrm{d}y \le C \int_{I_{\delta}} |S_{\delta}'(y) - S_{0}'(y)| \, \mathrm{d}y + C |y_{\delta}^{*}S_{\delta}'(y_{\delta}^{*}) - y_{\delta}^{*}S_{0}'(y_{\delta}^{*})| + C\delta \le C\delta.$$

<u>Estimates for  $T_{\delta}$ </u>: According to (53), we have

$$T_{\delta}(y) = -\frac{1}{2\delta} \int_{-1}^{b_{\delta}y - \frac{1}{2}} \left( R_{\delta}'(x + \frac{1}{2}) - R_{\delta}'(-\frac{1}{2}) \right) dx + g_{\delta}(y) + h_{\delta}(y) \\ = -\frac{1}{2\delta} R_{\delta}(b_{\delta}y) + \frac{1}{2\delta} R_{\delta}(\frac{1}{2}) - \frac{1}{2\delta} R_{\delta}'(\frac{1}{2}) \left( b_{\delta}y + \frac{1}{2} \right) + g_{\delta}(y) + h_{\delta}(y)$$

and using that (19) implies

$$-R_{\delta}(b_{\delta}y) + R_{\delta}\left(\frac{1}{2}\right) = \delta\left(S_{\delta}(y) - S_{\delta}(y_{\delta}^{*})\right), \qquad R_{\delta}'\left(\frac{1}{2}\right) = -\frac{\delta}{b_{\delta}}S_{\delta}'(y_{\delta}^{*})$$

we arrive at

$$T_{\delta}(y) = \frac{1}{2}S_{\delta}(y) + \frac{1}{2}S_{\delta}'(y_{\delta}^{*})y + \frac{1}{2}\left(y_{\delta}^{*}S_{\delta}'(y_{\delta}^{*}) - S_{\delta}(y_{\delta}^{*})\right) + g_{\delta}(y) + h_{\delta}(y)$$
(57)

and

$$T'_{\delta}(y) = \frac{1}{2}S'_{\delta}(y) + \frac{1}{2}S'_{\delta}(y^*_{\delta}) + g'_{\delta}(y) + h'_{\delta}(y), \qquad T''_{\delta}(y) = \frac{1}{2}S''_{\delta}(y) + g''_{\delta}(y) + h''_{\delta}(y).$$

Moreover, thanks to the explicit formula (11) as well as (33) we readily justify

$$\left|y_{\delta}^* S_0'(y_{\delta}^*) - S_0(y_{\delta}^*) - 2\ln 2\right| \le C\delta,$$

so (51) is a consequence of (22), (49), and (55).

#### 2.3 Scaling of the scalar quantities

The following result exploits the approximation under the tip and the transition scaling in order to characterize the asymptotic behavior of the amplitude parameter  $a_{\delta}$ , the width parameter  $b_{\delta}$ , and the speed parameter  $\lambda_{\delta}$  from (5) and (16).

**Proposition 5** (scaling relations for  $a_{\delta}$ ,  $b_{\delta}$ , and  $\lambda_{\delta}$ ). We have

$$b_{\delta} = 2\delta - 2\delta^2 + O(\delta^3), \qquad a_{\delta} = \delta + (2\ln 2 - 1)\delta^2 + O(\delta^3)$$

as well as

$$\lambda_{\delta}^{2} = \frac{1}{\delta^{\mu}} \exp\left(1 + \frac{1}{\delta}\right) \left(1 + O(\delta)\right)$$

for all sufficiently small  $\delta > 0$ .

*Proof.* The unimodality of  $V_{\delta}$  combined with (39)+(46)+(54)+(56) provides

$$0 \le \sup_{1 \le |x| \le L} V_{\delta}(x) \le V_{\delta}(-1) \le \frac{\delta}{b_{\delta}} W_{\delta}(-y_{\delta}^*) \le \frac{\delta}{b_{\delta}} f_{\delta}(-y_{\delta}^*) \le C \exp\left(-\frac{c}{\delta}\right) = O\left(\delta^2\right).$$
(58)

The norm constraint  $||V_{\delta}||_2 = 1$ , see Proposition 2, therefore yields

$$1 = 2 \int_{-1}^{0} V_{\delta}(x)^{2} dx + O(\delta^{2}) = \frac{2\delta^{2}}{b_{\delta}} \int_{I_{\delta}} W_{\delta}(y)^{2} dy + O(\delta^{2}),$$

and since  $S_{\delta}$  is even we compute

$$4 \int_{I_{\delta}} W_{\delta}(y)^{2} dy = \int_{I_{\delta}} \left( S_{\delta}'(y) + S_{\delta}'(y_{\delta}^{*}) \right)^{2} dy + O(\delta)$$
$$= \int_{I_{\delta}} \left( S_{\delta}'(y) \right)^{2} dy + \frac{S_{\delta}'(y_{\delta}^{*})^{2}}{b_{\delta}} + O(\delta)$$
$$= \int_{I_{\delta}} \left( S_{0}'(y) \right)^{2} dy + \frac{S_{0}'(y_{\delta}^{*})^{2}}{b_{\delta}} + O(\delta) ,$$

where we additionally used

ī

$$\left| \int_{I_{\delta}} \left( S_{\delta}'(y) \right)^2 \mathrm{d}y - \int_{I_{\delta}} \left( S_{0}'(y) \right)^2 \mathrm{d}y \right| \le C \int_{I_{\delta}} \left| S_{\delta}'(y) - S_{0}'(y) \right| \mathrm{d}y$$

ī




Figure 4: Scaled approximation errors  $c_1 \delta^{-1} (V_{\delta} - \overline{V}_{\delta})$  (black) and  $c_2 \delta^{-2} (R_{\delta} - \overline{R}_{\delta})$  (gray) as function of x for the data from Figure 1, where the artificial prefactors  $c_1 = 0.5$  and  $c_2 = 2.0$  are chosen for better illustration. The main contributions to the approximation error for the velocity profiles stem from the vicinity of  $x = \pm \frac{1}{2}$ , so  $\|V_{\delta} - \overline{V}_{\delta}\|_1$  is in fact asymptotically smaller than  $\|V_{\delta} - \overline{V}_{\delta}\|_{\infty}$ .

as well as (22)+(23)+(39)+(54)+(56). By direct computations we justify that

$$\int_{I_{\delta}} \left( S'_{0}(y) \right)^{2} \mathrm{d}y = \frac{4}{b_{\delta}} - 8 + O(\delta) , \qquad \frac{S'_{0}(y_{\delta}^{*})^{2}}{b_{\delta}} = \frac{4}{b_{\delta}} + O(\delta)$$

holds due to (33) and the exponential decay of  $S'_0$ . In summary, we obtain

$$1 = 4\frac{\delta^2}{b_{\delta}^2} \left(1 - b_{\delta} + O(\delta b_{\delta})\right) + O\left(\delta^2\right)$$

and hence the desired expansion for  $b_{\delta}$ . Evaluating both (19) and (47) for  $y = y_{\delta}^*$  gives

$$\frac{\delta}{a_{\delta}} - \delta S_{\delta}(y_{\delta}^*) = R_{\delta}\left(\frac{1}{2}\right) = \delta T_{\delta}(y_{\delta}^*) \,,$$

while  $T_{\delta}(y_{\delta}^*) = y_{\delta}^* S_{\delta}'(y_{\delta}^*) + O(\delta)$  is a direct consequence of (55)+(57). Rearranging terms we find

$$\frac{\delta}{a_{\delta}} = 2\delta y_{\delta}^* S_0'(y_{\delta}^*) + \delta \Big( S_0(y_{\delta}^*) - y_{\delta}^* S_0'(y_{\delta}^*) \Big) + O(\delta^2)$$

thanks to Proposition 3, so the properties of  $S_0$  provide via

$$\frac{\delta}{a_{\delta}} = 2\frac{\delta}{b_{\delta}} - \delta \ln 4 + O(\delta^2)$$

the expansion of  $a_{\delta}$ . Finally, by (16) we obtain

$$\delta^{\mu}\lambda_{\delta}^{2}\exp\left(-rac{1}{\delta}
ight) = rac{b_{\delta}^{2}}{\delta^{2}}rac{\delta^{\mu}}{a_{\delta}^{\mu}}\exp\left(rac{1}{a_{\delta}}-rac{1}{\delta}
ight),$$

and this implies the law for  $\lambda_{\delta}$ .

As already discussed at the end of §2.1, our asymptotic estimates can be improved for the Toda potential (8). Specifically, the error bounds in (50) and (51) are exponentially small in  $\delta$  and provide more accurate asymptotic expansions in Proposition 5.

#### 2.4 Approximation formulas

We are now able to proof the main result from §1 about the approximation formulas (12). Numerical results concerning the approximation error are shown in Figure 4.

**Theorem 6** (approximation formulas). There exists a constant C such that

$$\|V_{\delta} - \overline{V}_{\delta}\|_{p} \le C\delta^{1+1/p}, \qquad \|R_{\delta} - \overline{R}_{\delta}\|_{p} \le C\delta^{2}$$

hold for any  $1 \le p \le \infty$  and all sufficiently small  $\delta > 0$ .

Proof. We prove the assertions for p = 1 and  $p = \infty$  only; the estimates in the general case follow by interpolation, i.e., from  $\|\cdot\|_p \leq \|\cdot\|_1^{1/p} \|\cdot\|_{\infty}^{1-1/p}$ . <u>Approximation of  $V_{\delta}$ </u>: Since both  $V_{\delta}$  and  $\overline{V}_{\delta}$  are even functions and because

$$\sup_{1 \le |x| \le L} \left| V_{\delta}(x) \right| + \left| \overline{V}_{\delta}(x) \right| \le C\delta^2$$
(59)

is guaranteed by (12) and (58), it is sufficient to establish the desired estimates on the domain

$$-1 \le x \le 0$$

Moreover, the function  $\widehat{V}_{\delta}$  with

$$\widehat{V}_{\delta}(x) := \frac{\delta}{b_{\delta}} W_0\left(\frac{x+\frac{1}{2}}{b_{\delta}}\right) = \frac{\delta}{b_{\delta}}\left(\tanh\left(\frac{x+\frac{1}{2}}{b_{\delta}}\right) + 1\right)$$

satisfies

$$\sup_{-1 \le x \le 0} \left| \widehat{V}_{\delta}(x) - V_{\delta}(x) \right| \le \sup_{y \in I_{\delta}} \frac{\delta}{b_{\delta}} \left| W_0(y) - W_{\delta}(y) \right| \le C\delta$$
(60)

and

$$\int_{-1}^{0} \left| \widehat{V}_{\delta}(x) - V_{\delta}(x) \right| \mathrm{d}x \le \delta \int_{I_{\delta}} \left| W_0(y) - W_{\delta}(y) \right| \mathrm{d}y \le C\delta^2 \tag{61}$$

according to (46), Proposition 4, and Proposition 5. In order to bound the difference between  $\hat{V}_{\delta}$ and  $\overline{V}_{\delta}$ , we write

$$\overline{V}_{\delta}(x) = \frac{1+\delta}{2} \left( \tanh\left(\frac{x+\frac{1}{2}}{2\delta}\right) - \tanh\left(\frac{x-\frac{1}{2}}{2\delta}\right) \right)$$

and observe that

$$\left|\frac{1}{b_{\delta}} - \frac{1}{2\delta}\right| \le C, \qquad \left|\frac{\delta}{b_{\delta}} - \frac{1+\delta}{2}\right| \le C\delta^2, \qquad \sup_{-1 \le x \le 0} \left|\tanh\left(\frac{x - \frac{1}{2}}{2\delta}\right) + 1\right| \le C\delta^2$$

as well as

$$\left| \tanh\left(\frac{x+\frac{1}{2}}{2\delta}\right) - \tanh\left(\frac{x+\frac{1}{2}}{b_{\delta}}\right) \right| \le C\left(\sup_{\xi \in \mathbb{R}} \left|\xi \tanh'\left(\xi\right)\right|\right) \left|\frac{b_{\delta} - 2\delta}{\delta}\right| \le C\delta$$

and

$$\int_{-1}^{0} \left| \tanh\left(\frac{x+\frac{1}{2}}{2\delta}\right) - \tanh\left(\frac{x+\frac{1}{2}}{b\delta}\right) \right| \, \mathrm{d}x = b_{\delta} \int_{-1/b_{\delta}}^{+1/b_{\delta}} \left| \tanh\left(\frac{b_{\delta}}{2\delta}y\right) - \tanh\left(y\right) \right| \, \mathrm{d}y \le C\delta^{2}$$

are granted by Proposition 5 and the properties of the hyperbolic tangent. We therefore find the desired estimates for  $V_{\delta} - \overline{V}_{\delta}$  by combining (60) and (61) with

$$\sup_{-1 \le x \le 0} \left| \widehat{V}_{\delta}(x) - \overline{V}_{\delta}(x) \right| \le C\delta \,, \qquad \int_{-1}^{0} \left| \widehat{V}_{\delta}(x) - \overline{V}_{\delta}(x) \right| \mathrm{d}x \le C\delta^{2} \,.$$

Approximation of  $R_{\delta}$ : Direct computations yield

$$\overline{V}_{\delta}(x) \xrightarrow{x \to \pm \infty} 0, \qquad \overline{R}_{\delta}(x) \xrightarrow{x \to \pm \infty} 0$$

as well as

$$\overline{R}_{\delta}'(x) = \overline{V}_{\delta}\left(x + \frac{1}{2}\right) - \overline{V}_{\delta}\left(x - \frac{1}{2}\right) \quad \text{for all} \quad x \in \mathbb{R}\,,$$

and using the definition of  $\mathcal{A}$  in (3) we show that

$$\overline{R}_{\delta} = \mathcal{A}\overline{V}_{\delta}$$

holds without any approximation error. Combining this with  $R_{\delta} = AV_{\delta}$  and Young's inequality for convolutions we verify

$$\left\|\overline{R}_{\delta} - R_{\delta}\right\|_{1} \leq \left\|\overline{V}_{\delta} - V_{\delta}\right\|_{1}, \qquad \left\|\overline{R}_{\delta} - R_{\delta}\right\|_{\infty} \leq \left\|\overline{V}_{\delta} - V_{\delta}\right\|_{1},$$

and the proof is complete.

The definitions of  $\overline{V}_{\delta}$  and  $\overline{R}_{\delta}$  in (12) imply

$$\|V_0 - \overline{V}_\delta\|_p \sim \delta^{1/p}, \qquad \|R_0 - \overline{R}_\delta\|_p \sim \delta,$$

so  $\overline{V}_{\delta}$  and  $\overline{R}_{\delta}$  can in fact be regarded as the leading-order terms in the high-energy limit and satisfy (14). We also mention that the bound for  $\|V_{\delta} - \overline{V}_{\delta}\|_1$  from Theorem 6 depends on L due to the rather rough estimate of  $V_{\delta}(x) - \widehat{V}_{\delta}(x)$  on the domain  $1 \leq |x| \leq L$ , see (59). However, adapting the arguments from [HR10, HM15] we can establish exponential decay estimates for  $V_{\delta}$  and in combination with the tail behavior of  $\overline{V}_{\delta}$  we obtain improved bounds which are independent of L and allow us to pass to the solitary limit  $L \to \infty$ . Our main result therefore covers solitary waves, too.

We finally mention that the error bounds in Theorem 6 are optimal for the Toda chain (8) because we still have

$$\frac{1}{b_{\delta}} - \frac{1}{2\delta} \quad \xrightarrow{\delta \to 0} \quad \frac{1}{2}$$

and hence a rather large difference between  $\hat{V}_{\delta}$  and  $\overline{V}_{\delta}$ . The approximation error between  $\hat{V}_{\delta}$  and  $V_{\delta}$ , however, is exponentially small in  $\delta$ .

### A Proof of Proposition 2

The key arguments have been developed in [Her10] and can be sketched as follows.

<u>Existence of maximizer</u>: By standard arguments we show that the convex cone C from (4) is closed under weak L<sup>2</sup>-convergence. Moreover, the convolution operator A from (3) satisfies

$$\|\mathcal{A}V\|_{\infty} \le \|V\|_2 \tag{62}$$

and is – in the periodic setting  $L < \infty$  – compact. These observations imply that the energy functional  $\mathcal{P}_{\delta}$  from (3) is continuous with respect to the weak L<sup>2</sup>-topology and attains its maximum on the weakly compact set

$$\overline{B}_1(0) \cap \mathcal{C} \,, \tag{63}$$

where  $\overline{B}_1(0)$  denotes the closed unit ball with respect to  $\|\cdot\|_2$ . Furthermore, since the map

$$s \mapsto \mathcal{P}_{\delta}(sV)$$

is – due to the monotonicity of  $\Phi'$  – for any fixed  $V \in \mathcal{C}$  strictly increasing with respect to  $s \geq 0$ , we conclude that each maximizer  $V_{\delta}$  of  $\mathcal{P}_{\delta}$  in the set (63) belongs to the sphere  $\partial \overline{B}_1(0)$ .

<u>Verification of the traveling wave equation</u>: Due to the shape constraint  $V_{\delta} \in \mathcal{C}$  it is not obvious that (5) is the Euler-Lagrange equation for a maximizer  $V_{\delta}$  but we can argue as follows: We introduce an 'improvement operator'  $\mathcal{F}_{\delta}$  by

$$\mathcal{F}_{\delta}(V) := \frac{\mathcal{G}_{\delta}(V)}{\|\mathcal{G}_{\delta}(V)\|_{2}}, \qquad \mathcal{G}_{\delta}(V) := \partial \mathcal{P}_{\delta}(V) = \frac{1}{\delta} \mathcal{A} \Phi' \left(\frac{\mathcal{A} V_{\delta}}{\delta}\right),$$

which is well defined on the set

$$\partial \overline{B}_1(0) \cap \mathcal{C} \tag{64}$$

due to  $\mathcal{G}_{\delta}(V) \neq 0$ . By direct computation we verify that  $\mathcal{C}$  is invariant under both the action of  $\mathcal{A}$  and the superposition operator corresponding to  $\Phi'$ , and this implies that (64) is invariant under the action of  $\mathcal{F}_{\delta}$ . Moreover, thanks to the convexity inequality for  $\mathcal{P}_{\delta}$  and the identity  $\|\mathcal{F}_{\delta}(V)\|_2 = \|V\|_2 = 1$ we obtain

$$\mathcal{P}_{\delta}(\mathcal{F}_{\delta}(V)) - \mathcal{P}_{\delta}(V) \geq \langle \mathcal{G}_{\delta}(V), \mathcal{F}_{\delta}(V) - V \rangle$$
  
=  $\|\mathcal{G}_{\delta}(V)\|_{2} \langle \mathcal{F}_{\delta}(V), \mathcal{F}_{\delta}(V) - V \rangle$   
=  $\frac{1}{2} \|\mathcal{G}_{\delta}(V)\|_{2} \|\mathcal{F}_{\delta}(V) - V\|_{2}^{2} \geq 0$ , (65)

where  $\langle \cdot, \cdot \rangle$  stands for the usual L<sup>2</sup>-inner product of 2*L*-periodic functions, so applying  $\mathcal{F}_{\delta}$  increases the potential energy. In particular, any maximizer  $V_{\delta}$  satisfies  $\mathcal{P}_{\delta}(V_{\delta}) = \mathcal{P}_{\delta}(\mathcal{F}_{\delta}(V_{\delta}))$  and (65) implies via  $\|\mathcal{F}_{\delta}(V_{\delta}) - V_{\delta}\|_2 = 0$  the fixed-point identity

$$V_{\delta} = \mathcal{F}_{\delta}(V_{\delta}) \,,$$

which is equivalent to (5) with  $\lambda_{\delta} = \sqrt{\|\mathcal{G}_{\delta}(V_{\delta})\|_2} > 0$ . In other words, the shape constraint does not contribute to the Euler-Lagrange equation and  $\lambda_{\delta}^2$  can be viewed as the Lagrangian multiplier that stems from the norm constraint. A similar result has been derived in [SK12, SK13] by different arguments.

Convergence in the high-energy limit: Thanks to  $\Phi(r) \sim r^{\mu} \exp(r)$  for  $r \gg 1$  we observe that

$$\mathcal{P}_{\delta}(V_{\delta}) \geq \mathcal{P}_{\delta}(V_{0}) = \int_{-L}^{+L} \Phi\left(\frac{R_{0}(x)}{\delta}\right) \mathrm{d}x = 2 \int_{0}^{1} \Phi\left(\frac{r}{\delta}\right) \mathrm{d}r \geq c \exp\left(\frac{1}{\delta}\right) \left(\frac{1}{\delta}\right)^{\mu-1},$$

where  $V_0$  and  $R_0 = \mathcal{A}V_0$  are defined in Proposition 2. On the other hand, with  $R_{\delta} = \mathcal{A}V_{\delta}$  we estimate

$$\mathcal{P}_{\delta}(V_{\delta}) \leq 2L\Phi\left(\frac{R_{\delta}(0)}{\delta}\right) \leq C\exp\left(\frac{R_{\delta}(0)}{\delta}\right)\left(\frac{R_{\delta}(0)}{\delta}\right)^{\mu},$$

and combining this with  $0 \le R_{\delta}(0) \le ||V_{\delta}||_2 = 1$  we arrive at

$$R_{\delta}(0) \xrightarrow{\delta \to 0} 1$$

because otherwise the lower bound for  $\mathcal{P}_{\delta}(V_{\delta})$  would asymptotically exceed the upper bound. The convergence result (9) is now a direct consequence of

$$\|V_{\delta} - V_0\|_2^2 = \|V_{\delta}\|_2^2 + \|V_0\|_2^2 - 2\langle V_{\delta}, V_0 \rangle = 2 - 2R_{\delta}(0)$$

and the estimate (62).

<u>Remarks</u>: An elementary discretization (Riemann sums instead of integrals) of the improvement dynamics

$$V \longrightarrow \mathcal{F}_{\delta}(V) \longrightarrow \mathcal{F}_{\delta}(\mathcal{F}_{\delta}(V)) \longrightarrow$$

was used to compute the numerical wave profiles from Figure 1, see [FV99, EP05] for similar schemes. We finally mention that Proposition 2 holds also in the solitary case  $L = \infty$ . The proof, however, is more complicate because the operator  $\mathcal{A}$  is not compact anymore. The strong compactness of any maximizing sequence has therefore to be derived from the superquadratic grow of  $\Phi$  and a variant of the concentration compactness principle, see again [Her10] for the details.
