## Optimal control of non-stationary second grade fluids with Navier-slip boundary conditions

### Abstract

We consider optimal control problems governed by systems describing the unsteady flows of an incompressible second grade fluid with Navier-slip boundary conditions. We prove the existence of an optimal solution and derive the corresponding necessary optimality conditions.

**Key words.** Optimal control, second grade fluid, Navier-slip boundary conditions, necessary optimality conditions.

## 1 Introduction and main results

The paper is devoted to the study of an optimal control problem associated with a non-stationary viscous, incompressible, second grade fluid. The state equation is given by

$$\begin{cases} \frac{\partial}{\partial t} (\boldsymbol{y} - \alpha \Delta \boldsymbol{y}) - \nu \Delta \boldsymbol{y} + \boldsymbol{curl} (\boldsymbol{y} - \alpha \Delta \boldsymbol{y}) \times \boldsymbol{y} + \nabla \pi = \boldsymbol{u} & \text{in } Q, \\ \text{div } \boldsymbol{y} = 0 & \text{in } Q, \\ \boldsymbol{y} \cdot \boldsymbol{n} = 0, & (\boldsymbol{n} \cdot D \boldsymbol{y}) \cdot \boldsymbol{\tau} = 0 & \text{on } \Sigma, \\ \boldsymbol{y}(0) = \boldsymbol{y}_0 & \text{in } \Omega, \end{cases}$$

where y is the velocity field,  $\alpha \geq 0$  is a viscoelastic parameter,  $\nu > 0$  is the viscosity of the fluid,  $\pi$  is the hydrodynamic pressure, u is a distributed control,  $Q = ]0, T[\times \Omega$  where T is a fixed positive number and  $\Omega \subset \mathbb{R}^2$  is a bounded domain with boundary  $\Gamma$ ,  $\Sigma = ]0, T[\times \Gamma, n = (n_1, n_2)$  and  $\tau = (-n_2, n_1)$  are the unit normal and tangent vectors, respectively, to the boundary  $\Gamma$ ,  $Dy = \frac{1}{2} (\nabla y + \nabla y^{\top})$  is the symmetric part of the velocity gradient and  $y_0 \in H^3(\Omega)$  satisfies the incompressibility condition  $(1.1)_2$  and the boundary conditions  $(1.1)_3$ . As this equation is set in dimension two, the vector  $\boldsymbol{y}$  is written in the form  $\boldsymbol{y} = (y \equiv (y_1, y_2), 0)$  in order to define the curl and the vector product,  $curl \boldsymbol{y} = (0, 0, curl y)$  with  $curl y = \frac{\partial y_1}{\partial x_1} - \frac{\partial y_1}{\partial x_2}$ .

In the inviscid case ( $\nu = 0$ ), the second-grade fluid equations are called  $\alpha$ -Euler equations. Initially proposed as a regularization of the incompressible Euler equations, they are geometrically significant and have been interpreted as a model of turbulence (cf. [15] and [16]). They also

inspired another variant, called the  $\alpha$ -Navier-Stokes equations that turned out to be very relevant in turbulence modeling (cf. [13], [12] and the references therein). These equations contain the regularizing term  $-\nu\Delta(\boldsymbol{y} - \alpha\Delta\boldsymbol{y})$  instead of  $\nu\Delta\boldsymbol{y}$ , making the dissipation stronger and the problem much easier to solve than in the case of second-grade fluids. When  $\alpha = 0$ , the  $\alpha$ -Navier-Stokes and the second grade fluid equations are equivalent to the Navier-Stokes equations.

System  $(1.1)_{1,2,4}$  can be supplemented with different kinds of boundary conditions. The case of Dirichlet boundary conditions have received a lot of attention. It was systematically studied for the first time in [22] and [9] for both steady and unsteady cases. A Galerkin's method in the basis of the eigenfunctions of the operator  $curl(curl(y - \alpha \Delta y))$  was especially designed to decompose the problem into a mixed elliptic-hyperbolic type, looking for the velocity y as a solution of a Stokes-like system coupled to a transport equation satisfied by  $curl(y - \alpha \Delta y)$ . This approach is optimal in the sense that allows the authors to fully solve the two dimensional problem for both steady and unsteady cases and to *automatically* recover  $H^3$  in space regularity. Much work has been done since these pioneering results and, without ambition for completeness, we cite the extensions in [14] and [8] where global existence for small initial data in three dimensions was established, the former work using a Schauder fixed point argument while the latter considers the decomposition method on the system of Galerkin equations previously mentionned.

The case of second grade fluids with Navier boundary conditions has also been particularly considered in the literature and was studied in [6]. These conditions are known to deeply modify the properties of the equations, generating additional difficulties related with boundary terms to be correctly handled. In return, some mathematical aspects turned out to be more easily treatable. This is for example the case when studying the controllability of the Navier-Stokes equations (see [11]). This is also the case when dealing with the inviscid limit of their solutions. Indeed, it is well known that the solution to the Navier-Stokes equations with Navier boundary conditions converges, as  $\nu$  tends to zero, to a solution to the Euler equations, while no similar conclusion can be reached when dealing with Dirichlet boundary conditions, responsible for the formation of boundary layers (cf. [10], [17], [18], [20]). Similar considerations apply when analyzing the asymptotic bahavior of the solutions of second-grade fluid equations when the elastic response  $\alpha$ and/or the viscosity  $\nu$  vanish (cf. [5], [19], [21]).

Our objective here is to match the velocity field to a given target field  $y_d \in L^2(Q)$  and the optimal control problem reads as

$$(P) \quad \begin{cases} \text{minimize} \quad J(u,y) = \frac{1}{2} \int_{Q} |y - y_d|^2 \, dx dt + \frac{\lambda}{2} \int_{Q} |u|^2 \, dx dt \\ \text{subject to} \quad (u,y) \in U_{ad} \times L^{\infty} \left(0,T; H^3(\Omega)\right) \text{ satisfies (1.1) for some } \pi \in L^2(\Omega), \end{cases}$$

where  $\lambda \ge 0$  and  $U_{ad}$ , the set of admissible controls, is a nonempty bounded closed convex subset of  $L^2(I; H(\operatorname{curl}; \Omega)) = \{v \in L^2(Q) \mid \operatorname{curl} v \in L^2(Q)\}.$ 

As is well known when dealing with the optimal control of non-Newtonian fluids, the strong nonlinearity in the state equation induces some additional issues (see *e.g.* [1], [2], [3]). The first of these difficulties arises when studying the differentiability of the control-to-state mapping and, consequently, when exploring the solvability of the associated linearized equation. In the two dimensional case, this equation can be effectively addressed if the coefficients in the main part of the linearized operator are regular: by expanding the system in the special Galerkin basis used to study the state equation, we may prove the existence and uniqueness of a regular solution without restraining the data. This method, particularly interesting in this situation, shows its limits if the required regularity property is not available: this is the case if the control variables (as well as the initial data) are not regular, since the coefficients involve the state variable. The second main difficulty, exacerbated by the complexity of the associated differential operators, is encountered when dealing with the adjoint equation. For both problems, these drawbacks can be overcome by constructing the solutions using the basis of eigenfunctions of the Stokes operator designed in [10] in the case of Navier boundary conditions. Unlike the case of Dirichlet boundary conditions, we are able to derive some corresponding  $H^2$  in space a priori estimates and some related time derivative a priori estimates, and it turns out that these estimates are sufficient to carry out our analysis and prove our main result:

**Theorem 1.1** The optimal control problem (P) admits at least one solution  $(\bar{u}, \bar{y})$ . Moreover, there exists  $\bar{p} \in L^{\infty}(I; H^2(\Omega))$  with  $\frac{\partial \bar{p}}{\partial t} \in L^2(I; H^1(\Omega))$ , unique solution of the following adjoint equation

$$\begin{aligned} & \left( \begin{array}{c} -\frac{\partial}{\partial t} \left( \bar{\boldsymbol{p}} - \alpha \Delta \bar{\boldsymbol{p}} \right) - \nu \Delta \bar{\boldsymbol{p}} - \boldsymbol{curl} \left( \bar{\boldsymbol{y}} - \alpha \Delta \bar{\boldsymbol{y}} \right) \times \bar{\boldsymbol{p}} \\ & + \boldsymbol{curl} \left( \bar{\boldsymbol{y}} \times \bar{\boldsymbol{p}} - \alpha \Delta \left( \bar{\boldsymbol{y}} \times \bar{\boldsymbol{p}} \right) \right) + \nabla \pi = \bar{\boldsymbol{y}} - \boldsymbol{y}_d \quad in \ Q, \\ & \operatorname{div} \bar{\boldsymbol{p}} = 0 & in \ Q, \\ & \bar{\boldsymbol{p}} \cdot \boldsymbol{n} = 0, \quad (\boldsymbol{n} \cdot D \bar{\boldsymbol{p}}) \cdot \boldsymbol{\tau} = 0 & on \ \Sigma, \\ & \bar{\boldsymbol{p}}(T) = 0 & in \ \Omega, \end{aligned}$$

and satisfying the optimality condition

$$\int_{Q} \left(\bar{p} + \lambda \bar{u}, v - \bar{u}\right) dx dt \ge 0 \qquad \text{for all } v \in U_{ad}.$$

The plan of the present paper is as follows. The main results are stated in Section 1. Notation and preliminary results are given in Section 2. Section 3 is devoted to the solvability of the state equation and to the derivation of some corresponding a priori estimates. In Section 4, we establish existence and uniqueness results for the linearized state equation and analyze the Lipschitz continuity and the Gâteaux differentiability of the control-to-state mapping. The solvability of the adjoint equation is considered in Section 5 and the main results are proved in Section 6.

## 2 Notation and preliminary results

Throughout the paper  $\Omega$  is a bounded and simply connected domain in  $\mathbb{R}^2$ . The boundary of  $\Omega$  is denoted by  $\Gamma$  and is sufficiently regular. We will denote by I the interval ]0, T[. For  $u, v \in \mathbb{R}^2$ , we define the scalar product by  $u \cdot v = \sum_{i=1}^2 u_i v_i$ . For  $\eta, \zeta \in \mathbb{R}^{2 \times 2}$ , we define the scalar product by  $\eta : \zeta = \sum_{i,j=1}^2 \eta_{ij} \zeta_{ij}$ . We will also use the following notation

$$(u,v) = \int_{\Omega} u(x) \cdot v(x) \, dx, \qquad (\eta,\zeta) = \int_{\Omega} \eta(x) : \zeta(x) \, dx.$$

The standard Sobolev spaces are denoted by  $W^{k,p}(\Omega)$   $(k \in \mathbb{N}_0 \text{ and } 1 , and their norms$  $by <math>\|\cdot\|_{k,p}$  and  $\|\cdot\|_{0,p} \equiv \|\cdot\|_p$ . We set  $W^{k,2}(\Omega) \equiv H^k(\Omega)$  and  $\|\cdot\|_{k,2} \equiv \|\cdot\|_{H^k}$ . Similarly, the norm in  $L^2(Q)$  will be denoted by  $\|\cdot\|_{2,Q}$ . Since many of the quantities occuring in the paper are vector-valued functions, the notation will be abridged for the sake of brevity and we will omit the space dimension in the function space notation. (The meaning should be clear from the context.)

We also introduce the Hilbert space

$$H(\operatorname{curl};\Omega) = \left\{ v \in L^2(\Omega) \mid \operatorname{curl} v \in L^2(\Omega) \right\}$$

and in order to eliminate the pressure in the weak formulation of the state, the linearized state and the adjoint equations, we consider the following divergence-free spaces

$$H = \left\{ v \in L^2(\Omega) \mid \operatorname{div} v = 0 \quad \text{in } \Omega \quad \text{and} \quad v \cdot n = 0 \quad \text{on } \Gamma \right\},$$
$$V = \left\{ v \in H^1(\Omega) \mid \operatorname{div} v = 0 \quad \text{in} \quad \Omega \text{ and} \quad v \cdot n = 0 \quad \text{on } \Gamma \right\},$$
$$W = \left\{ v \in V \cap H^2(\Omega) \mid (n \cdot Dv) \cdot \tau = 0 \quad \text{on } \Gamma \right\}.$$

In the sequel, we set

$$\sigma(y) = y - \alpha \Delta y \quad \text{for } y \in H^2(\Omega)$$

and denote by  $\mathbb{P}: L^2(\Omega) \longrightarrow H$ , the Helmholtz projector in  $L^2(\Omega)$  and set  $\mathbb{A} = -\mathbb{P}\Delta$ . It is well know that  $\mathbb{P}$  is a linear bounded operator and that is characterized by the equality  $\mathbb{P}y = \tilde{y}$ , where  $\tilde{y}$  is given by the Helmholtz decomposition

$$y = \tilde{y} + \nabla \phi, \quad \tilde{y} \in H \text{ and } \phi \in H^1(\Omega).$$

Let us now present some useful results. The first one is fundamental and deals with a boundary identity related with the Navier-slip boundary conditions. It states in particular that the trace of  $\operatorname{curl} y$  is a linear function on y. (See Proposition 1 in [6].)

**Lemma 2.1** Let  $y \in W$ . Then, the following identity holds

$$\operatorname{curl} y|_{\Gamma} = y \cdot g|_{\Gamma} \qquad \text{where } g = 2 \frac{\partial n}{\partial \tau}$$

with  $\frac{\partial}{\partial \tau} = n_1 \frac{\partial}{\partial x_2} - n_2 \frac{\partial}{\partial x_1}$ .

The next two lemmas will be useful when dealing with a priori estimates for the state, linearized and adjoint state equations. We confer to Lemma 5 in [4], Propositions 3 in [6] and Lemma 2.1 in [8] where similar results are established.

**Lemma 2.2** Let  $y \in W \cap H^3(\Omega)$ . Then, the following estimate holds

$$\|\Delta y + A y\|_{H^1} \le c \, \|y\|_{H^2} \,, \tag{2.1}$$

where c is a positive constant only depending on  $\Omega$ .

**Proof.** From the definition of  $\mathbb{A}$ , there exists  $\phi \in H^1(\Omega)$  such that

$$\Delta y + \mathbb{A}y = \nabla \phi$$

and thus

$$\Delta \phi = \operatorname{div} \left( \nabla \phi \right) = \operatorname{div} \left( \Delta y + \mathbb{A} y \right) = 0$$

On the other hand, by taking into account Lemma 2.1 we obtain

$$\begin{split} \frac{\partial \phi}{\partial n} \Big|_{\Gamma} &= n \cdot \nabla \phi \Big|_{\Gamma} = n \cdot (\Delta y + \mathbb{A} y) \Big|_{\Gamma} \\ &= n \cdot \Delta y \Big|_{\Gamma} = n \cdot \Delta y \Big|_{\Gamma} \\ &= n \cdot \Delta y \Big|_{\Gamma} = -n \cdot \boldsymbol{curl} \left( \boldsymbol{curl} \, \boldsymbol{y} \right) \Big|_{\Gamma} \\ &= -\frac{\partial}{\partial \tau} \left( \boldsymbol{y} \cdot \boldsymbol{g} \right) \Big|_{\Gamma}. \end{split}$$

Since  $\frac{\partial}{\partial \tau} (y \cdot g)$  is well defined, the result follows by using standard trace estimates and the regularity theory for elliptic equations with Neuman boundary conditions.

**Lemma 2.3** Let  $y \in W \cap H^3(\Omega)$ . Then, the following estimates hold

$$\|y\|_{H^2} \le c \left(\|y\|_2 + \|Ay\|_2\right),\tag{2.2}$$

where c is a positive constant only depending on  $\Omega$ .

**Proof.** Let us first recall that for  $f \in H^m(\Omega)$ ,  $m \in \mathbb{N}$ , the following problem

$$\left\{ \begin{array}{ll} -\Delta h + h + \nabla \pi = f & \text{ in } \Omega, \\ \text{div} \, h = 0 & \text{ in } \Omega, \\ h \cdot n = 0, & (n \cdot Dh) \cdot \tau = 0 & \text{ on } \Gamma, \end{array} \right.$$

admits a unique (up to a constant for  $\pi$ ) solution  $(h, \pi) \in H^{m+2}(\Omega) \times H^m(\Omega)$  (see [23]). Classical arguments show that

$$\|h\|_{2}^{2} + 2 \|Dh\|_{2}^{2} = (f,h) \le \|f\|_{2} \|h\|_{2}$$

yielding

$$||h||_2 \le ||f||_2$$
 and  $||Dh||_2 \le \frac{1}{\sqrt{2}} ||f||_2$ . (2.3)

On the other hand, due to the regularity results for the Stokes system, we have

$$\|h\|_{H^2} \le c \|f - h\|_2$$

Taking into account (2.3), we deduce that

$$\|h\|_{H^2} \leq c \, (\|f\|_2 + \|h\|_2) \leq c \, \|f\|_2$$

and the claimed result follows by setting f = y + Ay.

## **3** State equation

In the present section, we state some well known existence and uniqueness results related with the state equation. We first recall an identity relating the nonlinear term in (1.1) to the classical trilinear form

$$b(\phi, z, y) = (\phi \cdot \nabla z, y)$$

used in the Euler and Navier-Stokes equations. For  $y, z \in W \cap H^3(\Omega)$  and  $\phi \in V$ , we have

$$(\operatorname{curl} \sigma(\boldsymbol{y}) \times \boldsymbol{z}, \boldsymbol{\phi}) = (\operatorname{curl} \sigma(\boldsymbol{y}), \boldsymbol{z} \times \boldsymbol{\phi})$$
  

$$= (\sigma(\boldsymbol{y}), \operatorname{curl} (\boldsymbol{z} \times \boldsymbol{\phi})) + \int_{\Gamma} \sigma(\boldsymbol{y}) \times (\boldsymbol{z} \times \boldsymbol{\phi}) \cdot \boldsymbol{n} \, dS$$
  

$$= (\sigma(\boldsymbol{y}), \operatorname{curl} (\boldsymbol{z} \times \boldsymbol{\phi}))$$
  

$$= (\sigma(\boldsymbol{y}), (\operatorname{div} \boldsymbol{\phi}) \boldsymbol{z} + \boldsymbol{\phi} \cdot \nabla \boldsymbol{z} - (\operatorname{div} \boldsymbol{z}) \boldsymbol{\phi} - \boldsymbol{z} \cdot \nabla \boldsymbol{\phi})$$
  

$$= (\sigma(\boldsymbol{y}), \boldsymbol{\phi} \cdot \nabla \boldsymbol{z} - \boldsymbol{z} \cdot \nabla \boldsymbol{\phi})$$
  

$$= b (\boldsymbol{\phi}, \boldsymbol{z}, \sigma(\boldsymbol{y})) - b (\boldsymbol{z}, \boldsymbol{\phi}, \sigma(\boldsymbol{y})) . \qquad (3.1)$$

In view of this result, the state equation is to be understood in the sense of the following definition.

**Definition 3.1** Let  $u \in L^2(I; H(\operatorname{curl}; \Omega))$  and  $y_0 \in W \cap H^3(\Omega)$ . A function  $y \in L^{\infty}(I; W \cap H^3(\Omega))$  with  $\frac{\partial y}{\partial t} \in L^{\infty}(I; V)$  is a solution of (1.1) if  $y(0) = y_0$  in  $\Omega$  and

$$\begin{pmatrix} \frac{\partial y(t)}{\partial t}, \phi \end{pmatrix} + 2\alpha \left( D \frac{\partial y(t)}{\partial t}, D \phi \right) + 2\nu \left( D y(t), D \phi \right) + b \left( \phi, y(t), \sigma \left( y(t) \right) \right) - b \left( y(t), \phi, \sigma \left( y(t) \right) \right)$$

$$= \left( u(t), \phi \right) \quad \text{for all } \phi \in V.$$

$$(3.2)$$

The result in the next proposition deals with the solvability of (1.1) and is proved in [6]. For the convenience of the reader, the corresponding estimates are derived hereafter.

**Proposition 3.2** Assume that  $u \in L^2(I; H(\operatorname{curl}; \Omega))$  and that  $y_0 \in W \cap H^3(\Omega)$ . Then the problem (1.1) admits a unique solution  $y \in L^{\infty}(I; W \cap H^3(\Omega))$  with  $\frac{\partial y}{\partial t} \in L^2(I; V)$ . Furthermore, the following estimates hold

$$\|y\|_{L^{\infty}(I;L^{2}(\Omega))}^{2} + 2\alpha \|Dy\|_{L^{\infty}(I;L^{2})}^{2} + 2\|Dy\|_{2,Q}^{2} \leq 4\left(\|y_{0}\|_{2}^{2} + 2\alpha \|Dy_{0}\|_{2}^{2} + \|u\|_{L^{1}(I;L^{2})}^{2}\right), \quad (3.3)$$

$$\|\operatorname{curl} \sigma(y)\|_{L^{\infty}(I;L^{2})}^{2} \leq 2 \|\operatorname{curl} \sigma(y_{0})\|_{2}^{2} + 2 \|\operatorname{curl} y\|_{L^{\infty}(I;L^{2})}^{2} + 4 \|\operatorname{curl} u\|_{L^{1}(0,T;L^{2})}^{2}, \qquad (3.4)$$

$$\alpha \|y\|_{L^{\infty}(I;H^{3})} \leq c \left( \|y\|_{L^{\infty}(I;H^{1})} + \|\operatorname{curl} \sigma(y)\|_{L^{\infty}(I;L^{2})} \right),$$
(3.5)

$$\left\|\frac{\partial y}{\partial t}\right\|_{2,Q}^{2} + \alpha \left\|D\frac{\partial y}{\partial t}\right\|_{2,Q}^{2} \le c \left(\|u\|_{2,Q}^{2} + \left(\nu^{2} + \|\operatorname{curl}\sigma(y)\|_{L^{\infty}(I;L^{2})}^{2}\right) \|y\|_{L^{2}(I;H^{2})}^{2}\right),$$
(3.6)

where c is a positive constant only depending on  $\Omega$ .

**Proof.** The proof is split into four steps.

Step 1.  $H^1$  in space estimate for y. By setting  $\phi = y(t)$  in the variational formulation (3.2), we obtain

$$\frac{1}{2} \frac{d}{dt} \left( \|y(t)\|_{2}^{2} + 2\alpha \|Dy(t)\|_{2}^{2} \right) + 2\nu \|Dy(t)\|_{2}^{2} \le \|u(t)\|_{2} \|y(t)\|_{2} \\ \le \|u(t)\|_{2} \left( \|y(t)\|_{2}^{2} + 2\alpha \|Dy(t)\|_{2}^{2} \right)^{\frac{1}{2}}$$
(3.7)

yielding

$$\frac{d}{dt} \left( \|y(t)\|_{2}^{2} + 2\alpha \|Dy(t)\|_{2}^{2} \right)^{\frac{1}{2}} \le \|u(t)\|_{2}$$

Upon integration, we obtain

$$\left(\|y(t)\|_{2}^{2} + 2\alpha \|Dy(t)\|_{2}^{2}\right)^{\frac{1}{2}} \leq \left(\|y_{0}\|_{2}^{2} + 2\alpha \|Dy_{0}\|_{2}^{2}\right)^{\frac{1}{2}} + \|u\|_{L^{1}(I;L^{2})}$$

which, together with (3.7), implies that

$$\begin{aligned} \|y(t)\|_{2}^{2} + 2\alpha \|Dy(t)\|_{2}^{2} + 2\nu \|Dy(t)\|_{2}^{2} &\leq \|y_{0}\|_{2}^{2} + 2\alpha \|Dy_{0}\|_{2}^{2} + \int_{0}^{t} \|u(s)\|_{2} \|y(s)\|_{2} ds \\ &\leq \|y_{0}\|_{2}^{2} + 2\alpha \|Dy_{0}\|_{2}^{2} + \|u\|_{L^{1}(I;L^{2})} \|y\|_{L^{\infty}(I;L^{2})} \\ &\leq 4 \left(\|y_{0}\|_{2}^{2} + 2\alpha \|Dy_{0}\|_{2}^{2} + \|u\|_{L^{1}(I;L^{2})}^{2}\right). \end{aligned}$$

Step 2.  $L^2$  estimate in space for curl  $\sigma(y)$ . Applying the curl to (1.1), we obtain

$$\frac{\partial}{\partial t} \left( \operatorname{curl} \sigma(y(t)) \right) - \nu \Delta \left( \operatorname{curl} y(t) \right) + y(t) \cdot \nabla \left( \operatorname{curl} \sigma(y(t)) \right) = \operatorname{curl} u(t)$$

which, for  $\alpha \neq 0$ , is equivalent to

$$\frac{\partial}{\partial t}\left(\operatorname{curl}\sigma(y(t))\right) + \frac{\nu}{\alpha}\operatorname{curl}\sigma(y(t)) + y(t)\cdot\nabla\left(\operatorname{curl}\sigma(y(t))\right) = \operatorname{curl}u(t) + \frac{\nu}{\alpha}\operatorname{curl}y(t)$$

Taking the  $L^2$  scalar product with  $\operatorname{curl} \sigma(y(t))$  yields

$$\begin{aligned} &\frac{1}{2} \frac{d}{dt} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} + \frac{\nu}{\alpha} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} = \left( \operatorname{curl} u(t) + \frac{\nu}{\alpha} \operatorname{curl} y(t), \operatorname{curl} \sigma(y(t)) \right) \\ &\leq \left\| \operatorname{curl} u(t) \right\|_{2} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2} + \frac{\nu}{2\alpha} \left\| \operatorname{curl} y(t) \right\|_{2}^{2} + \frac{\nu}{2\alpha} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} \end{aligned}$$

and thus

$$\begin{split} \frac{d}{dt} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} &+ \frac{\nu}{\alpha} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} &= e^{-\frac{\nu t}{\alpha}} \frac{d}{dt} \left( e^{\frac{\nu t}{\alpha}} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} \right) \\ &\leq \frac{\nu}{\alpha} \left\| \operatorname{curl} y(t) \right\|_{2}^{2} + 2 \left\| \operatorname{curl} u(t) \right\|_{2} \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}. \end{split}$$

Multiplying both sides by  $e^{\frac{\nu t}{\alpha}}$  and integrating, we obtain we obtain

$$\begin{split} \|\operatorname{curl} \sigma(y(t))\|_{2}^{2} &\leq \|\operatorname{curl} \sigma(y_{0})\|_{2}^{2} + \frac{\nu}{\alpha} \int_{0}^{t} e^{\frac{\nu}{\alpha}(s-t)} \|\operatorname{curl} y(s)\|_{2}^{2} \, ds + \int_{0}^{t} 2e^{\frac{\nu}{\alpha}(s-t)} \|\operatorname{curl} u(s)\|_{2} \|\operatorname{curl} \sigma(y(s))\|_{2} \, ds \\ &\leq \|\operatorname{curl} \sigma(y_{0})\|_{2}^{2} + \frac{\nu}{\alpha} \|\operatorname{curl} y\|_{L^{\infty}(I;L^{2})}^{2} \int_{0}^{t} e^{\frac{\nu}{\alpha}(s-t)} \, ds \\ &+ 2 \|\operatorname{curl} \sigma(y)\|_{L^{\infty}(I;L^{2})} \int_{0}^{t} e^{\frac{\nu}{\alpha}(s-t)} \|\operatorname{curl} u(t)\|_{2} \, ds \\ &\leq \|\operatorname{curl} \sigma(y_{0})\|_{2}^{2} + \|\operatorname{curl} y\|_{L^{\infty}(I;L^{2})}^{2} + 2 \|\operatorname{curl} \sigma(y)\|_{L^{\infty}(I;L^{2})} \|\operatorname{curl} u\|_{L^{1}(0,T;L^{2})} \\ &\leq \|\operatorname{curl} \sigma(y_{0})\|_{2}^{2} + \|\operatorname{curl} y\|_{L^{\infty}(I;L^{2})}^{2} + \frac{1}{2} \|\operatorname{curl} \sigma(y)\|_{L^{\infty}(I;L^{2})}^{2} + 2 \|\operatorname{curl} u\|_{L^{1}(0,T;L^{2})}^{2} \, . \end{split}$$

Estimate (3.4) follows immedialtely.

Step 3.  $H^3$  estimate in space for y. Since  $\operatorname{curl} \Delta y(t) \in L^2(\Omega)$  and  $\operatorname{div} (\operatorname{curl} \Delta y(t)) = 0$ , there exists a unique vector-potential  $\psi \in H^1(\Omega)$  such that

$$\left\{ \begin{array}{ll} \operatorname{curl}\psi=\operatorname{curl}\Delta\mathbf{y}(\mathbf{t}) & \quad \text{in }\Omega,\\ \nabla\cdot\psi=0 & \quad \text{in }\Omega,\\ \psi\cdot n=0 & \quad \text{on }\Gamma \end{array} \right.$$

and

$$\|\psi\|_{H^1} \le c \,\|\operatorname{curl} \Delta y(t)\|_2 \,. \tag{3.8}$$

It follows that

 $\operatorname{curl}\left(\Delta y(t) - \psi\right) = 0$ 

and there exists  $\pi \in L^2(\Omega)$  such that

$$\Delta y(t) - \psi + \nabla \pi = 0.$$

Hence y is the solution of the Stokes system

$$\Delta y(t) + \nabla \pi = \psi$$

and satisfies

Step 4. Estimates for the time derivative. By setting  $\phi = \frac{\partial y}{\partial t}(t)$  in the variational formulation (3.2), we obtain

and thus

$$\begin{split} \left\| \frac{\partial y}{\partial t}(t) \right\|_{2}^{2} + \alpha \left\| D \frac{\partial y}{\partial t}(t) \right\|_{2}^{2} &\leq c \left( \left\| u(t) \right\|_{2}^{2} + \nu^{2} \left\| \Delta y(t) \right\|_{2}^{2} + \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} \left\| y(t) \right\|_{\infty}^{2} \right) \\ &\leq c \left( \left\| u(t) \right\|_{2}^{2} + \nu^{2} \left\| y(t) \right\|_{H^{2}}^{2} + \left\| \operatorname{curl} \sigma(y(t)) \right\|_{2}^{2} \left\| y(t) \right\|_{H^{2}}^{2} \right). \end{split}$$

The claimed result follows then by integrating the previous inequality.

# 4 Linearized state equation and analysis of the control-tostate mapping

As well known, the linearized equation associated with the state equation plays a key role in the derivation of the necessary optimality conditions. Its solution coincides with the derivative of the control-to-state mapping and is related to the adjoint state through a suitable Green formula.

The aim of this section is to establish the existence of a unique solution for an auxiliary linear system and to derive useful corresponding estimates . The solvability of the linearized equation, seen as a particular case, the Lipchitz continuity and the Gâteaux differentiability of the control-to-state mapping are then deduced from these results.

Let  $y_1, y_2$  be in  $L^{\infty}(I; W \cap H^3(\Omega))$  and consider the following linear equation

where  $w \in L^2(Q)$ . In analogy to (1.1), and taking into account (3.1), we first propose the following definition for a solution of (4.1).

**Definition 4.1** A function  $z \in L^{\infty}(I; W)$  with  $\frac{\partial z}{\partial t} \in L^{2}(I; V)$  is a solution of (4.1) if z(0) = 0 and

$$\left(\frac{\partial z(t)}{\partial t},\phi\right) + 2\alpha \left(D\frac{\partial z(t)}{\partial t},D\phi\right) + 2\nu \left(Dz(t),D\phi\right) + b\left(\phi,y_1(t),\sigma(z(t))\right) - b\left(y_1(t),\phi,\sigma(z(t))\right) + b\left(\phi,z(t),\sigma(y_2(t))\right) - b\left(z(t),\phi,\sigma(y_2(t))\right) = (w(t),\phi) \quad \text{for all } \phi \in V.$$

The special Galerkin basis used to study the state equation (1.1) does not seem appropriate to study the solvability of both the linearized equation considered in this section and the adjoint state equation that will be considered in Section 5. Indeed, the corresponding technique decomposes the problem into a mixed parabolic-hyperbolic system, looking for z as the solution of a Stokes-like system and for  $\operatorname{curl} \sigma(z)$  as the solution of the following transport equation

$$\frac{\partial}{\partial t} \left( \operatorname{curl} \sigma(z(t)) \right) + \frac{\nu}{\alpha} \operatorname{curl} \sigma(z(t)) + y_1(t) \cdot \nabla \left( \operatorname{curl} \sigma(z(t)) \right) + z(t) \cdot \nabla \left( \operatorname{curl} \sigma(y_2(t)) \right) \\ = \operatorname{curl} w(t) + \frac{\nu}{\alpha} \operatorname{curl} z(t).$$

To (formally) derive the  $L^2$  in space estimate for curl  $\sigma(z)$ , let us multiply the transport equation by curl  $\sigma(z(t))$ 

$$\frac{1}{2} \frac{d}{dt} \left( \|\operatorname{curl} \sigma(z(t))\|_{2}^{2} \right) + \frac{\nu}{\alpha} \|\operatorname{curl} \sigma(z(t))\|_{2}^{2} = \left( \operatorname{curl} w(t) + \frac{\nu}{\alpha} \operatorname{curl} z(t), \operatorname{curl} \sigma(z(t)) \right) \\ - \left( z(t) \cdot \nabla \left( \operatorname{curl} \sigma(y_{2}(t)) \right), \operatorname{curl} \sigma(z(t)) \right).$$

The first term on the right-hand side can be easily handled by using the a priori  $H^1$  estimates established in a first step. The second term, more delicate, can be managed if we guarantee that the coefficient curl  $\sigma(y_2)$  is  $H^2$  in space. In other words, if the state variable  $y_2$  belongs to  $H^5$  in space. Following the regularity results stated in Theorem 5.3 and Remark 5.4 in [8], this property would be available if the pair  $(u_2, y_0)$  belongs to  $L^2(I; H^2(\Omega)) \times H^5(\Omega)$ . These difficulties are aggravated in the case of the adjoint equation because of the operators involved in its definition.

According to these observations, and to the fact that  $H^2$  a priori estimates for the linearized state and the adjoint state are sufficient to carry out our analysis, we will construct our solution by using the basis of eigenfunctions of the Stokes operator designed by Clopeau *et al.* to study the inviscid limit of the solutions of the Navier-Stokes equation with Navier-slip boundary conditions [10]. In order to deal with the pressure term, the standard way to obtain  $H^2$  a priori estimates in space would be to (formally) multiply equation (4.1) by  $\mathbb{A}z$  and to integrate. In our case, the main difficulty is then related with the term

$$(\boldsymbol{curl}\,\sigma(\boldsymbol{z}(t)) imes \boldsymbol{y}_1(t), \mathbb{A}\boldsymbol{z}(t))$$

and is overcome by taking advantage of the nice properties induced by the Navier-slip boundary conditions and stated in Lemma 2.1 and Lemma 2.2.

We first state a lemma that will be used to derive  $H^1$  a priori estimates for the linearized state equation and the adjoint equation. Unlike the Dirichlet boundary conditions for which the corresponding proofs are straightforward, the Navier-slip boundary conditions are more delicate to handle and proving that the boundary terms, induced by the performed integrations by parts, are vanishing is not an obvious issue.

**Lemma 4.2** Let  $y \in W \cap H^3(\Omega)$  and  $z \in W$ . Then

$$|(curl\,\sigma(z) \times y, z)| \le c \, \|y\|_{H^3} \left( (1+\alpha) \|z\|_2^2 + \alpha \, \|Dz\|_2^2 \right), \tag{4.3}$$

where c is a positive constant only depending on  $\Omega$ .

$$= b(z, y, z) + \alpha b(\boldsymbol{z}, \boldsymbol{curl}\,\boldsymbol{y}, \boldsymbol{curl}\,\boldsymbol{z}) + 2\alpha \sum_{k=1}^{2} \left( \nabla \boldsymbol{z}_{k} \times \nabla \boldsymbol{y}_{k}, \boldsymbol{curl}\,\boldsymbol{z} \right) + \alpha I, \qquad (4.4)$$

where

$$I = \int_{\Gamma} \left( y \cdot \nabla z - z \cdot \nabla y \right) \cdot \tau \left( z \cdot g \right) \, dS.$$

Extending the exterior normal n (defined a priori only on the boundary  $\Gamma$ ) inside  $\Omega$  by a vector field still denoted by n, using the Green formula and standard calculation, we can prove that for every  $w \in H^2(\Omega)$  we have

$$\int_{\Gamma} (z \cdot \nabla y - y \cdot \nabla z) \cdot w \, dS$$

Combining (4.4) and (4.5), we deduce that

The claimed result follows then by combining (4.6)-(4.9) and using the Korn inequality. Now we are able to deal with the solvability of problem (4.1). This is the aim of the next result.

**Proposition 4.3** Let w be in  $L^2(Q)$  and let  $y_1, y_2$  be in  $L^{\infty}(I; W \cap H^3(\Omega))$ . Then equation (4.1) admits a unique solution  $z \in L^{\infty}(I; W)$  with  $\frac{\partial z}{\partial t} \in L^2(I; V)$ . Step 4. Passage to the limit. Next, we derive some useful estimates related with the Lipschitz continuity of the state with respect to the control variable. More precisely, if  $u_1$ ,  $u_2$  are two controls and if  $y_{u_1}$ ,  $y_{u_2}$  are the corresponding states then we are interested in estimating the difference  $y_{u_2} - y_{u_1}$  with respect to  $u_2 - u_1$  in adequate topologies. The result is a direct consequence of Proposition 4.3.

**Proposition 4.4** Let  $u_1, u_2 \in L^2(I; H(\operatorname{curl}; \Omega))$  and let  $y_{u_1}, y_{u_2}$  be the corresponding solutions of (1.1). Then the following estimates hold

$$\begin{aligned} \|y_{u_2} - y_{u_1}\|_{L^{\infty}(I;L^2)}^2 + 2\alpha \|D(y_{u_2} - y_{u_1})\|_{L^{\infty}(I;L^2)}^2 &\leq \|u_2 - u_1\|_{2,Q}^2 e^{cT\left(1 + (1+\alpha)\|y_{u_1}\|_{L^{\infty}(I;H^3)}\right)}, \\ \|D(y_{u_2} - y_{u_1})\|_{L^{\infty}(I;L^2)}^2 + \alpha \|\mathbb{A}(y_{u_2} - y_{u_1})\|_{L^{\infty}(I;L^2)}^2 \end{aligned}$$

$$\leq \left(\frac{1}{\nu} \|u_2 - u_1\|_{2,Q}^2 + cT(1+\alpha)M \|y_{u_2} - y_{u_1}\|_{L^{\infty}(I;L^2)}^2\right) e^{\frac{c(1+\alpha)T}{\alpha}M}$$

where  $M = \|y_{u_1}\|_{L^{\infty}(I;H^3)} + \|y_{u_2}\|_{L^{\infty}(I;H^3)}$  and where c is a positive constant only depending on  $\Omega$ .

**Proof.** It is easy to see that  $y = y_{u_2} - y_{u_1}$  is the unique solution of the linear problem (4.1) for  $y_1 = y_{u_1}, y_2 = y_{u_2}$  and  $w = u_2 - u_1$ . The claimed estimates are then a direct consequence of Proposition 4.3.

Finally, we are able to prove that the control-to-state mapping  $u \mapsto y_u$  is Gâteaux differentiable.

**Proposition 4.5** Let  $\rho$  be such that  $0 < \rho < 1$ ,  $y_0 \in W \cap H^3(\Omega)$  and  $(v, w) \in (L^2(I; H(\operatorname{curl}; \Omega)))^2$ . Set  $u_\rho = u + \rho w$  and let  $y_u$  and  $y_\rho$  be the solutions of (1.1) corresponding to u and  $u_\rho$ , respectively. Then, we have

$$y_{\rho} = y_u + \rho z_{uw} + \rho r_{\rho}$$
 with  $\lim_{\rho \to 0} \|r_{\rho}\|_{L^{\infty}(I;H^1)} = 0,$  (4.20)

and

$$J(u_{\rho}, y_{\rho}) = J(u, y_{u}) + \rho \int_{0}^{T} \left( (z_{uw}, y_{u} - y_{d}) + \lambda(u, w) \right) dt + o(\rho),$$
(4.21)

where  $z_{uw} \in L^{\infty}(I; W)$  is the solution of the linearized equation

$$\begin{pmatrix}
\frac{\partial \sigma(\boldsymbol{z})}{\partial t} - \nu \Delta \boldsymbol{z} + \boldsymbol{curl} \, \sigma(\boldsymbol{z}) \times \boldsymbol{y}_{\boldsymbol{u}} + \boldsymbol{curl} \, \sigma(\boldsymbol{y}_{\boldsymbol{u}}) \times \boldsymbol{z} + \nabla \pi = \boldsymbol{w} & \text{in } Q, \\
\nabla \cdot \boldsymbol{z} = 0 & \text{in } Q, \\

**Proof.** Let us first notice that due to Proposition 4.3, equation (4.22) admits a unique solution  $z_{uw}$ . Moreover, easy calculation shows that  $z_{\rho} = \frac{y_{\rho} - y_u}{\rho}$  satisfies

$$\frac{\partial \sigma(\boldsymbol{z}_{\rho})}{\partial t} - \nu \Delta \boldsymbol{z}_{\rho} + \boldsymbol{curl} \, \sigma\left(\boldsymbol{z}_{\rho}\right) \times \boldsymbol{y}_{\boldsymbol{u}} + \boldsymbol{curl} \, \sigma\left(\boldsymbol{y}_{\rho}\right) \times \boldsymbol{z}_{\rho} + \nabla \pi_{\rho} = \boldsymbol{w}_{\rho}$$

and thus  $r_{\rho} = z_{\rho} - z_{uw}$  satisfies

$$- \left( \boldsymbol{curl} \,\sigma \left( \boldsymbol{y}_{\rho}(t) - \boldsymbol{y}_{\boldsymbol{u}}(t) \right) \times \boldsymbol{z}_{\boldsymbol{u}\boldsymbol{w}}(t), \boldsymbol{r}_{\rho}(t) \right)$$

$$= - \left( \boldsymbol{curl} \,\sigma \left( \boldsymbol{r}_{\rho}(t) \right) \times \boldsymbol{y}_{\boldsymbol{u}}(t), \boldsymbol{r}_{\rho}(t) \right) - \left( \boldsymbol{curl} \,\sigma \left( \boldsymbol{y}_{\rho}(t) - \boldsymbol{y}_{\boldsymbol{u}}(t) \right) \times \boldsymbol{z}_{\boldsymbol{u}\boldsymbol{w}}(t), \boldsymbol{r}_{\rho}(t) \right)$$

where we have used identity (3.1). Moreover, due to (4.3), we have

$$\begin{aligned} \left| \left( curl \sigma \left( \boldsymbol{y}_{\rho}(t) - \boldsymbol{y}_{\boldsymbol{u}}(t) \right) \times \boldsymbol{z}_{\boldsymbol{u}\boldsymbol{w}}(t), \boldsymbol{r}_{\rho}(t) \right) \right| \\ &= \left| b \left( r_{\rho}(t), z_{uw}(t), \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right) - b \left( z_{uw}(t), r_{\rho}(t), \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right) \right| \\ &\leq \left( \left\| r_{\rho}(t) \right\|_{4} \left\| \nabla z_{uw}(t) \right\|_{4} + \left\| z_{uw}(t) \right\|_{\infty} \left\| \nabla r_{\rho}(t) \right\|_{2} \right) \left\| \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right\|_{2} \\ &\leq c \left\| z_{uw}(t) \right\|_{H^{2}} \left\| \nabla r_{\rho}(t) \right\|_{2}^{2} + \frac{1}{2} \left\| \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right\|_{2}^{2} \\ &\leq c \left\| z_{uw}(t) \right\|_{H^{2}}^{2} \left( \left\| r_{\rho}(t) \right\|_{2}^{2} + \left\| Dr_{\rho}(t) \right\|_{2}^{2} \right) + \frac{1}{2} \left\| \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right\|_{2}^{2}. \end{aligned}$$

$$(4.25)$$

Combining (4.23)-(4.25) yields

$$\begin{aligned} &\frac{d}{dt} \left( \left\| r_{\rho}(t) \right\|_{2}^{2} + 2\alpha \left\| Dr_{\rho}(t) \right\|_{2}^{2} \right) \\ &\leq \frac{c(1+\alpha)^{2}}{\alpha} \left( \left\| y_{u}(t) \right\|_{H^{3}} + \left\| z_{uw}(t) \right\|_{H^{2}}^{2} \right) \left( \left\| r_{\rho}(t) \right\|_{2}^{2} + 2\alpha \left\| Dr_{\rho}(t) \right\|_{2}^{2} \right) + \left\| \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right\|_{2}^{2} \\ &\leq \frac{c(1+\alpha)^{2}}{\alpha} \left( \left\| y_{u} \right\|_{L^{\infty}(I;H^{3})} + \left\| z_{uw} \right\|_{L^{\infty}(I;H^{2})}^{2} \right) \left( \left\| r_{\rho}(t) \right\|_{2}^{2} + 2\alpha \left\| Dr_{\rho}(t) \right\|_{2}^{2} \right) + \left\| \sigma \left( y_{\rho}(t) - y_{u}(t) \right) \right\|_{2}^{2} \end{aligned}$$

and by applying Gronwall's inequality, we deduce that

$$\|r_{\rho}\|_{L^{\infty}(I;L^{2})}^{2} + 2\alpha \|Dr_{\rho}\|_{L^{\infty}(I;L^{2})}^{2} \leq \|\sigma (y_{\rho} - y_{u})\|_{2,Q}^{2} \exp\left(\frac{cT(1+\alpha)^{2}}{\alpha} \left(\|y_{u}\|_{L^{\infty}(I;H^{3})} + \|z_{uw}\|_{L^{\infty}(I;H^{2})}^{2}\right)\right).$$

On the other hand, by taking into account (2.2), we have

$$\begin{aligned} \|\sigma (y_{\rho} - y)\|_{2,Q} &\leq \|y_{\rho} - y_{u}\|_{2,Q} + c\alpha \|y_{\rho} - y_{u}\|_{L^{2}(I;H^{2})} \\ &\leq c \left(\|y_{\rho} - y_{u}\|_{2,Q} + \alpha \|\mathbb{A} (y_{\rho} - y_{u})\|_{2,Q}\right) \\ &\leq cT^{\frac{1}{2}} \left(\|y_{\rho} - y_{u}\|_{L^{\infty}(I;L^{2})} + \alpha \|\mathbb{A} (y_{\rho} - y_{u})\|_{L^{\infty}(I;L^{2})}\right) \end{aligned}$$

and due to Proposition 4.4, we obtain

$$\begin{aligned} \|y_{\rho} - y_{u}\|_{L^{\infty}(I;L^{2})}^{2} &\leq \rho^{2} \|w\|_{2,Q}^{2} \exp\left(cT\left(1 + (1 + \alpha) \|y_{u}\|_{L^{\infty}(I;H^{3})}\right)\right) \\ &\longrightarrow 0 \qquad \text{when } \rho \to 0 \end{aligned}$$

and

$$\alpha \left\| \mathbb{A} \left( y_{\rho} - y_{u} \right) \right\|_{L^{\infty}(I;L^{2})}^{2} \leq \left( \frac{\rho^{2}}{\nu} \left\| w \right\|_{2,Q}^{2} + cT(1+\alpha)M_{\rho} \left\| y_{\rho} - y_{u} \right\|_{L^{\infty}(I;L^{2})}^{2} \right) \exp\left( \frac{c(1+\alpha)T}{\alpha}M_{\rho} \right),$$

where c is a positive constant independent of  $\rho$  and where  $M_{\rho} = \|y_{\rho}\|_{L^{\infty}(I;H^3)} + \|y_u\|_{L^{\infty}(I;H^3)}$ . In regards to (3.3)-(3.5), it follows that  $(M_{\rho})_{\rho}$  is uniformly bounded and thus

Combining theses estimates, we deduce that

## 5 Adjoint equation

Let  $y \in L^{\infty}(I; W \cap H^{3}(\Omega))$  and  $f \in L^{2}(Q)$ . The aim of this section is to study the solvability of the adjoint equation defined by

$$\begin{aligned} & -\frac{\partial \sigma(\boldsymbol{p})}{\partial t} - \nu \Delta \boldsymbol{p} - \boldsymbol{curl} \, \sigma(\boldsymbol{y}) \times \boldsymbol{p} + \boldsymbol{curl} \, (\sigma(\boldsymbol{y} \times \boldsymbol{p})) + \nabla \pi = \boldsymbol{f} & \text{ in } Q, \\ & \text{div} \, \boldsymbol{p} = 0 & & \text{ in } Q, \\ & \boldsymbol{p} \cdot \boldsymbol{n} = 0, \qquad (\boldsymbol{n} \cdot D \boldsymbol{p}) \cdot \boldsymbol{\tau} = 0 & & \text{ on } \Sigma, \\ & \boldsymbol{p}(T) = 0 & & & \text{ in } \Omega. \end{aligned}$$
(5.1)

Due to (3.1), the term  $curl \sigma(y) \times p$  can be handled as in the case of the nonlinear term in the state equation. In order to manage the term  $curl (\sigma (y \times p))$  and to give an adequate variational setting for the adjoint equation, we need the following result.

**Lemma 5.1** Let y, z be in  $W \cap H^3(\Omega)$  and  $\phi$  be in W. Then

$$(curl \sigma (\boldsymbol{y} \times \boldsymbol{z}), \boldsymbol{\phi}) = b (z, y, \sigma(\boldsymbol{\phi})) - b (y, z, \sigma(\boldsymbol{\phi})).$$

**Proof.** As already observed when dealing with the linearized equation, some specific difficulties related to the boundary terms arise when considering the Navier-slip conditions. If they are not vanishing, these terms need to be managed and satisfactorily estimated.

We will split the present proof into two steps. In order to give a sense to the different boundary terms, we first assume that y, z belong to  $W \cap H^4(\Omega)$ . We next apply a regularization process to prove that the results are still valid for  $y, z \in W \cap H^3(\Omega)$ .

Step 1. Standard arguments show that

$$= b(\boldsymbol{z}, \boldsymbol{y}, \Delta \boldsymbol{\phi}) - b(\boldsymbol{y}, \boldsymbol{z}, \Delta \boldsymbol{\phi}) + I_1 - I_2$$
  

$$= b(\boldsymbol{z}, \boldsymbol{y}, \Delta \boldsymbol{\phi}) - b(\boldsymbol{y}, \boldsymbol{z}, \Delta \boldsymbol{\phi}) + I_1 - I_2$$

with

$$I_1 = \int_{\Gamma} \left( \Delta \left( oldsymbol{y} imes oldsymbol{z}

Let us now prove that  $I_1 - I_2 = 0$ . By taking into account Lemma 2.1, we have

=  $- (\boldsymbol{y} \cdot \nabla \boldsymbol{z} - \boldsymbol{z} \cdot \nabla \boldsymbol{y}) \cdot \boldsymbol{g} (\boldsymbol{\phi} \cdot \boldsymbol{\tau}) \big|_{\Gamma} - \left( (\boldsymbol{y} \cdot \nabla \boldsymbol{g}) \cdot \boldsymbol{z} - (\boldsymbol{z} \cdot \nabla \boldsymbol{g}) \cdot \boldsymbol{y} \right) (\boldsymbol{\phi} \cdot \boldsymbol{\tau}) \big|_{\Gamma}.$  (5.6)

Easy calculations, together with the fact that  $y|_{\Gamma} = (y \cdot \tau) \tau|_{\Gamma}$  and  $z|_{\Gamma} = (z \cdot \tau) \tau|_{\Gamma}$ , show that

$$\begin{aligned} (y \cdot \nabla g) \cdot z \big|_{\Gamma} &- (z \cdot \nabla g) \cdot y \big|_{\Gamma} = (\nabla g \, y) \cdot z \big|_{\Gamma} - (\nabla g \, z) \cdot y \big|_{\Gamma} \\ &= (\nabla g \, (y \cdot \tau) \, \tau) \cdot (z \cdot \tau) \, \tau \big|_{\Gamma} - (\nabla g \, (z \cdot \tau) \, \tau) \cdot (y \cdot \tau) \, \tau \big|_{\Gamma} \\ &= (y \cdot \tau) \, (z \cdot \tau) \, ((\nabla g \, \tau) \cdot \tau - (\nabla g \, \tau) \cdot \tau) \big|_{\Gamma} = 0. \end{aligned}$$
(5.7)

Taking into account (5.5)-(5.7), we deduce that

$$\begin{split} I_1 - I_2 &= 2\sum_{k=1}^2 \int_{\Gamma} \left( \nabla \boldsymbol{y}_k \times \nabla \boldsymbol{z}_k \right) \times \boldsymbol{\phi} \cdot \boldsymbol{n} \, dS \\ &+ \int_{\Gamma} \left( \left( \boldsymbol{\phi} \cdot \boldsymbol{\tau} \right) \left( \boldsymbol{z} \cdot \nabla \boldsymbol{y} - \boldsymbol{y} \cdot \nabla \boldsymbol{z} \right) \cdot \boldsymbol{g} - \left( \boldsymbol{\phi} \cdot \boldsymbol{g} \right) \left( \boldsymbol{z} \cdot \nabla \boldsymbol{y} - \boldsymbol{y} \cdot \nabla \boldsymbol{z} \right) \cdot \boldsymbol{\tau} \right) dS. \end{split}$$

On the other hand, due to Lemma 4.1 in [18] we have

$$(z \cdot \nabla y - y \cdot \nabla z) \cdot n\Big|_{\Gamma} = 0.$$

Observing that  $u \cdot n \big|_{\Gamma} = 0$  implies that

$$\begin{aligned} \left(\phi \cdot \tau\right)\left(u \cdot g\right) - \left(\phi \cdot g\right)\left(u \cdot \tau\right)\Big|_{\Gamma} &= \left(\phi \cdot \tau\right)\left(\left(u \cdot \tau\right)\tau \cdot g\right) - \left(\left(\phi \cdot \tau\right)\tau \cdot g\right)\left(u \cdot \tau\right)\Big|_{\Gamma} \\ &= \left(\phi \cdot \tau\right)\left(u \cdot \tau\right)\left(\tau \cdot g - \tau \cdot g\right)\Big|_{\Gamma} = 0, \end{aligned}$$

we deduce that

$$I_1 - I_2 = 2\sum_{k=1}^2 \int_{\Gamma} \left( \nabla \boldsymbol{y}_k \times \nabla \boldsymbol{z}_k \right) \times \boldsymbol{\phi} \cdot \boldsymbol{n} \, dS$$

Finally, since  $(Du \cdot n) \cdot \tau |_{\Gamma} = 0$  and div u = 0 imply

$$\left(n_2^2 - n_1^2\right)\left(\frac{\partial u_1}{\partial x_2} + \frac{\partial u_2}{\partial x_1}\right) - 2n_1n_2\frac{\partial u_1}{\partial x_1} = 0 \quad \text{on } \Gamma,$$

we obtain

$$\begin{split} \sum_{k=1}^{2} \left( \nabla \boldsymbol{y}_{k} \times \nabla \boldsymbol{z}_{k} \right) \times \boldsymbol{\phi} \cdot \boldsymbol{n} \big|_{\Gamma} &= \sum_{k=1}^{2} \left( \frac{\partial y_{k}}{\partial x_{1}} \frac{\partial z_{k}}{\partial x_{2}} - \frac{\partial y_{k}}{\partial x_{2}} \frac{\partial z_{k}}{\partial x_{1}} \right) \boldsymbol{\phi} \cdot \boldsymbol{\tau} \big|_{\Gamma} \\ &= \left( \frac{\partial y_{1}}{\partial x_{1}} \left( \frac{\partial z_{1}}{\partial x_{2}} + \frac{\partial z_{2}}{\partial x_{1}} \right) - \frac{\partial z_{1}}{\partial x_{1}} \left( \frac{\partial y_{1}}{\partial x_{2}} + \frac{\partial y_{2}}{\partial x_{1}} \right) \right) \boldsymbol{\phi} \cdot \boldsymbol{\tau} \big|_{\Gamma} = 0 \end{split}$$

and thus

 $I_1 - I_2 = 0. (5.8)$ 

The conclusion is then a consequence of (5.3), (5.4) and (5.8).

Step 2. Regularization process. Let us now go back to the case  $y, z \in W \cap H^3(\Omega)$ . We first infer that there exist  $y_{\varepsilon}, z_{\varepsilon} \in W \cap H^4(\Omega)$  such that

$$\lim_{\varepsilon \to 0^+} \|y - y_{\varepsilon}\|_{H^3} = \lim_{\varepsilon \to 0^+} \|z - z_{\varepsilon}\|_{H^3} = 0$$

Indeed, if  $y \in W \cap H^3(\Omega)$ , then it satisfies the following Stokes system

$$\begin{cases}
-\Delta y + y + \nabla \pi = f & \text{in } \Omega, \\
\text{div } y = 0 & \text{in } \Omega, \\
y \cdot n = 0, & (n \cdot Dy) \cdot \tau = 0 & \text{on } \Gamma
\end{cases}$$
(5.9)

with  $f = -\Delta y + y \in H^1(\Omega)$  and  $\pi = 0$ . Using Friedrichs mollifiers, we can construct  $f_{\varepsilon} \in H^2(\Omega)$  such that

$$\lim_{\varepsilon \to 0^+} \|f - f_\varepsilon\|_{H^1} = 0$$

Let  $y_{\varepsilon} \in H^4(\Omega)$  be the solution of (5.9) corresponding to  $f_{\varepsilon}$ . By using classical regularity results, we have

$$\|y - y_{\varepsilon}\|_{H^3} \le c \|f - f_{\varepsilon}\|_{H^1} \longrightarrow 0 \quad \text{when } \varepsilon \to 0$$

On the other hand, by taking into account the first step, we deduce that

$$(\operatorname{curl} \sigma \left( \boldsymbol{y}_{\varepsilon} \times \boldsymbol{z}_{\varepsilon} \right), \boldsymbol{\phi}) = b\left( z_{\varepsilon}, y_{\varepsilon}, \sigma(\boldsymbol{\phi}) \right) - b\left( y_{\varepsilon}, z_{\varepsilon}, \sigma(\boldsymbol{\phi}) \right)$$

and the result follows by passing to the limit.

The identities (3.1) and (5.2) motivate the following variational formulation for the adjoint equation.

**Definition 5.2** A function  $p \in L^{\infty}(I; W)$  with  $\frac{\partial p}{\partial t} \in L^{2}(I; V)$  is a solution of (5.1) if p(T) = 0 and

$$-\left(\frac{\partial p(t)}{\partial t},\phi\right) - 2\alpha \left(D\frac{\partial p(t)}{\partial t},D\phi\right) + 2\nu \left(Dp(t),D\phi\right) + b\left(p(t),\phi,\sigma(y(t))\right) - b\left(\phi,p(t),\sigma(y(t))\right) + b\left(p(t),y(t),\sigma(\phi)\right) - b\left(y(t),p(t),\sigma(\phi)\right) = (f(t),\phi) \quad \text{for all } \phi \in W.$$
(5.10)

The solution of (5.1) in the sense of this definition is constructed using the Galerkin's method defined in the previous section. Existence of an approximate solution and a corresponding a priori  $H^1$  estimate can be established using standard arguments. In order to establish the corresponding  $H^2$  in space estimate (and consequently the time derivative estimates necessary to pass to the limit), we need the following result.

**Lemma 5.3** Let  $y, \psi \in W \cap H^3(\Omega)$  and  $\phi \in V$ . Then

$$\left|\left(\boldsymbol{curl}\left(\sigma\left(\boldsymbol{y}\times\boldsymbol{\psi}\right)\right)-\boldsymbol{curl}\,\sigma\left(\boldsymbol{y}\right)\times\boldsymbol{\psi},\boldsymbol{\phi}\right)\right|\leq c(1+\alpha)\left\|y\right\|_{H^{3}}\left\|\psi\right\|_{H^{2}}\left\|\phi\right\|_{2}+\alpha\left|b\left(\boldsymbol{y},\Delta\boldsymbol{\psi},\boldsymbol{\phi}\right)\right|,$$

where c is a positive constant depending only on  $\Omega$ .

**Proof.** Standard calculations show that

$$\Delta\left(\boldsymbol{y}\times\boldsymbol{\psi}\right) = \boldsymbol{y}\times\Delta\boldsymbol{\psi} - \boldsymbol{\psi}\times\Delta\boldsymbol{y} - 2\sum_{i=1}^{2}\frac{\partial\boldsymbol{\psi}}{\partial x_{i}}\times\frac{\partial\boldsymbol{y}}{\partial x_{i}}$$

and thus

$$\begin{aligned} \boldsymbol{curl} \left( \Delta \left( \boldsymbol{y} \times \boldsymbol{\psi} \right) \right) &= \boldsymbol{curl} \left( \boldsymbol{y} \times \Delta \boldsymbol{\psi} \right) - \boldsymbol{curl} \left( \boldsymbol{\psi} \times \Delta \boldsymbol{y} \right) - 2 \sum_{i=1}^{2} \boldsymbol{curl} \left( \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} \times \frac{\partial \boldsymbol{y}}{\partial x_{i}} \right) \\ &= \left( \operatorname{div} \Delta \boldsymbol{\psi} \right) \boldsymbol{y} + \Delta \boldsymbol{\psi} \cdot \nabla \boldsymbol{y} - \left( \operatorname{div} \boldsymbol{y} \right) \Delta \boldsymbol{\psi} - \boldsymbol{y} \cdot \nabla \left( \Delta \boldsymbol{\psi} \right) \\ &- \left( \operatorname{div} \Delta \boldsymbol{y} \right) \boldsymbol{\psi} - \Delta \boldsymbol{y} \cdot \nabla \boldsymbol{\psi} + \left( \operatorname{div} \boldsymbol{\psi} \right) \Delta \boldsymbol{y} + \boldsymbol{\psi} \cdot \nabla \left( \Delta \boldsymbol{y} \right) \\ &- 2 \sum_{i=1}^{2} \left( \operatorname{div} \left( \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} \right) \frac{\partial \boldsymbol{y}}{\partial x_{i}} + \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} \cdot \nabla \left( \frac{\partial \boldsymbol{y}}{\partial x_{i}} \right) - \operatorname{div} \left( \frac{\partial \boldsymbol{y}}{\partial x_{i}} \right) \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} - \frac{\partial \boldsymbol{y}}{\partial x_{i}} \cdot \nabla \left( \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} \right) \right) \\ &= \Delta \boldsymbol{\psi} \cdot \nabla \boldsymbol{y} - \boldsymbol{y} \cdot \nabla \left( \Delta \boldsymbol{\psi} \right) - \Delta \boldsymbol{y} \cdot \nabla \boldsymbol{\psi} + \boldsymbol{\psi} \cdot \nabla \Delta \boldsymbol{y} \\ &- 2 \sum_{i=1}^{2} \left( \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} \cdot \nabla \left( \frac{\partial \boldsymbol{y}}{\partial x_{i}} \right) - \frac{\partial \boldsymbol{y}}{\partial x_{i}} \cdot \nabla \left( \frac{\partial \boldsymbol{\psi}}{\partial x_{i}} \right) \right). \end{aligned}$$

Therefore

$$\begin{aligned} (\boldsymbol{curl}\left(\Delta\left(\boldsymbol{y}\times\boldsymbol{\psi}\right)\right),\boldsymbol{\phi}) &= b\left(\Delta\psi,y,\phi\right) - b\left(y,\Delta\psi,\phi\right) - b\left(\Delta y,\psi,\phi\right) + b\left(\psi,\Delta y,\phi\right) \\ &-2\sum_{i=1}^{2}\left(b\left(\frac{\partial\psi}{\partial x_{i}},\frac{\partial y}{\partial x_{i}},\phi\right) - b\left(\frac{\partial y}{\partial x_{i}},\frac{\partial\psi}{\partial x_{i}},\phi\right)\right). \end{aligned}$$

On the other hand, by taking into account (3.1), we have

$$(curl(\Delta y) \times \psi, \phi) = b(\phi, \psi, \Delta y) - b(\psi, \phi, \Delta y) = b(\phi, \psi, \Delta y) + b(\psi, \Delta y, \phi).$$

Combining the previous two identities, we obtain

$$\begin{aligned} (\boldsymbol{curl}\left(\Delta\left(\boldsymbol{y}\times\boldsymbol{\psi}\right)\right) - \boldsymbol{curl}\left(\Delta\boldsymbol{y}\right)\times\boldsymbol{\psi},\boldsymbol{\phi}) &= b\left(\Delta\psi,y,\phi\right) - b\left(y,\Delta\psi,\phi\right) - b\left(\Delta y,\psi,\phi\right) - b(\phi,\psi,\Delta y) \\ &-2\sum_{i=1}^{2} \left(b\left(\frac{\partial\psi}{\partial x_{i}},\frac{\partial y}{\partial x_{i}},\phi\right) - b\left(\frac{\partial y}{\partial x_{i}},\frac{\partial\psi}{\partial x_{i}},\phi\right)\right), \end{aligned}$$

which together with the fact that

$$\begin{aligned} (\boldsymbol{curl}\left(\boldsymbol{y}\times\boldsymbol{\psi}\right),\boldsymbol{\phi}) - (\boldsymbol{curl}\,\boldsymbol{y}\times\boldsymbol{\psi},\boldsymbol{\phi}) &= (\boldsymbol{curl}\left(\boldsymbol{y}\times\boldsymbol{\psi}\right),\boldsymbol{\phi}) - (\boldsymbol{y},\boldsymbol{curl}\left(\boldsymbol{\psi}\times\boldsymbol{\phi}\right)) \\ &= (\boldsymbol{\psi}\cdot\nabla\boldsymbol{y} - \boldsymbol{y}\cdot\nabla\boldsymbol{\psi},\boldsymbol{\phi}) - (\boldsymbol{y},\boldsymbol{\phi}\cdot\nabla\boldsymbol{\psi} - \boldsymbol{\psi}\cdot\nabla\boldsymbol{\phi}) \\ &= b\left(\psi,y,\phi\right) - b\left(y,\psi,\phi\right) - b\left(\phi,\psi,y\right) + b\left(\psi,\phi,y\right) \\ &= -b\left(y,\psi,\phi\right) - b\left(\phi,\psi,y\right) \\ &= -b\left(y,\psi,\phi\right) + b\left(\phi,y,\psi\right) \end{aligned}$$

gives

$$\begin{aligned} (\boldsymbol{curl}\left(\sigma\left(\boldsymbol{y}\times\boldsymbol{\psi}\right)\right) - \boldsymbol{curl}\,\sigma\left(\boldsymbol{y}\right)\times\boldsymbol{\psi},\boldsymbol{\phi}) &= b\left(\phi,y,\psi\right) - b\left(y,\psi,\phi\right) - \alpha b\left(\Delta\psi,y,\phi\right) + \alpha b\left(y,\Delta\psi,\phi\right) \\ &+ \alpha b\left(\Delta y,\psi,\phi\right) + \alpha b(\phi,\psi,\Delta y) \\ &+ 2\alpha\sum_{i=1}^{2}\left(b\left(\frac{\partial\psi}{\partial x_{i}},\frac{\partial y}{\partial x_{i}},\phi\right) - b\left(\frac{\partial y}{\partial x_{i}},\frac{\partial\psi}{\partial x_{i}},\phi\right)\right). \end{aligned}$$

Therefore,

$$\begin{split} &|(\boldsymbol{curl}\left(\sigma\left(\boldsymbol{y}\times\boldsymbol{\psi}\right)\right)-\boldsymbol{curl}\,\sigma\left(\boldsymbol{y}\right)\times\boldsymbol{\psi},\boldsymbol{\phi})|\\ &\leq |b\left(\phi,y,\psi\right)|+|b\left(y,\psi,\phi\right)|+\alpha\left|b\left(\Delta\psi,y,\phi\right)|+\alpha\left|b\left(\Delta\psi,y,\phi\right)\right|+\alpha\left|b\left(\phi,\psi,\Delta y\right)\right|\right|\\ &+\alpha\left|b\left(y,\Delta\psi,\phi\right)\right|+2\alpha\sum_{i=1}^{2}\left(\left|b\left(\frac{\partial\psi}{\partial x_{i}},\frac{\partial y}{\partial x_{i}},\phi\right)\right|+\left|b\left(\frac{\partial y}{\partial x_{i}},\frac{\partial\psi}{\partial x_{i}},\phi\right)\right|\right)\\ &\leq (\|\nabla y\|_{4}\|\psi\|_{4}+\|y\|_{4}\|\nabla\psi\|_{4}+\alpha\|\nabla y\|_{\infty}\|\Delta\psi\|_{2}+2\alpha\|\Delta y\|_{4}\|\nabla\psi\|_{4})\|\phi\|_{2}\\ &+\alpha\left|b\left(y,\Delta\psi,\phi\right)\right|+c\alpha\left(\|\nabla y\|_{\infty}\|\psi\|_{H^{2}}+\|y\|_{2,4}\|\nabla\psi\|_{4}\right)\|\phi\|_{2}\\ &\leq c(1+\alpha)\|y\|_{H^{3}}\|\psi\|_{H^{2}}\|\phi\|_{2}+\alpha\left|b\left(y,\Delta\psi,\phi\right)\right| \end{split}$$

which gives the claimed result.

The next result deals with the existence and uniqueness of a solution for the adjoint equation.

**Proposition 5.4** Assume that  $f \in L^2(Q)$ . Then equation (5.1) admits a unique solution  $p \in L^{\infty}(I; W)$  with  $\frac{\partial p}{\partial t} \in L^2(I; V)$ . Moreover, the following estimates hold

$$\begin{split} \|p\|_{L^{\infty}(I;L^{2})}^{2} + 2\alpha \,\|Dp\|_{L^{\infty}(I;L^{2})}^{2} &\leq \|f\|_{2,Q}^{2} \,e^{cT\left(1+(1+\alpha)\|y\|_{L^{\infty}(I;H^{3})}\right)}, \\ \|Dp\|_{L^{\infty}(I;L^{2})}^{2} + \alpha \,\|Ap\|_{L^{\infty}(I;L^{2})}^{2} \\ &\leq \left(\frac{1}{\nu} \,\|f\|_{2,Q}^{2} + cT(1+\alpha) \,\|y\|_{L^{\infty}(I;H^{3})} \,\|p\|_{L^{\infty}(I;L^{2})}^{2}\right) e^{\frac{c(1+\alpha)T}{\alpha} \|y\|_{L^{\infty}(I;H^{3})}}, \\ \left\|\frac{\partial p}{\partial t}\right\|_{2,Q}^{2} + \alpha \,\left\|D\frac{\partial p}{\partial t}\right\|_{2,Q}^{2} &\leq c \left(\|f\|_{2,Q}^{2} + T\left(\nu^{2} + \frac{(1+\alpha)^{2}}{\alpha} \,\|y\|_{L^{\infty}(I;H^{3})}^{2}\right) \|p\|_{L^{\infty}(I;H^{2})}^{2}\right), \end{split}$$

where c is a constant only depending on  $\Omega$ .

**Proof.** Let us first notice that p is solution of the terminal value problem (5.1) if and only if  $\psi$  defined as  $\psi(t) = p(T - t)$  is the solution of the following initial value problem

$$\frac{\partial \sigma(\boldsymbol{\psi})}{\partial t} - \nu \Delta \boldsymbol{\psi} - \boldsymbol{curl} \, \sigma(\tilde{\boldsymbol{y}}) \times \boldsymbol{\psi} + \boldsymbol{curl} \, (\sigma(\tilde{\boldsymbol{y}} \times \boldsymbol{\psi})) + \nabla \tilde{\boldsymbol{\pi}} = \tilde{\boldsymbol{f}} \quad \text{in } Q, \\
\text{div } \boldsymbol{\psi} = 0 & \text{in } Q, \\
\boldsymbol{\psi} \cdot \boldsymbol{n} = 0, \quad (\boldsymbol{n} \cdot D \boldsymbol{\psi}) \cdot \boldsymbol{\tau} = 0 & \text{on } \Sigma, \\
\boldsymbol{\psi}(0) = 0 & \text{in } \Omega,
\end{cases}$$
(5.11)

where  $\tilde{y}(t) = y(T-t)$ ,  $\tilde{f}(t) = f(T-t)$  and  $\tilde{\pi}(t) = \pi(T-t)$ . In regards to (5.10),  $\psi \in L^2(I; W)$  with  $\frac{\partial \psi}{\partial t} \in L^2(I; V)$  is a solution of (5.11) if  $\psi(0) = 0$  and

$$\left(\frac{\partial\psi(t)}{\partial t},\phi\right) + 2\alpha \left(D\frac{\partial\psi(t)}{\partial t},D\phi\right) + 2\nu \left(D\psi(t),D\phi\right) + b\left(\psi(t),\phi,\sigma(\tilde{y}(t))\right) - b\left(\phi,\psi(t),\sigma(\tilde{y}(t))\right) + b\left(\psi(t),\tilde{y}(t),\sigma(\phi)\right) - b\left(\tilde{y}(t),\psi(t),\sigma(\phi)\right) = \left(\tilde{f}(t),\phi\right)$$
 for all  $\phi \in W.$  (5.12)

The rest of the proof is devoted to the solvability of (5.11). The corresponding approximate problem reads as

$$\begin{cases} \text{Find } \psi_k(t) = \sum_{i=1}^k \zeta_i(t)e_i \text{ solution, for } 1 \le j \le k, \text{ of} \\ \left(\frac{\partial \psi_k(t)}{\partial t}, e_j\right) + 2\alpha \left(D\frac{\partial \psi_k(t)}{\partial t}, De_j\right) + 2\nu \left(D\psi_k(t), De_j\right) \\ + b \left(\psi_k(t), e_j, \sigma(\tilde{y}(t))\right) - b \left(e_j, \psi_k(t), \sigma(\tilde{y}(t))\right) \\ + b \left(\psi_k(t), \tilde{y}(t), \sigma(e_j)\right) - b \left(\tilde{y}(t), \psi_k(t), \sigma(e_j)\right) = \left(\tilde{f}(t), e_j\right), \end{cases}$$
(5.13)  
$$\psi_k(0) = 0.$$

where  $(e_j)_j$  is the basis defined by (4.11). This is a linear differential system for  $\zeta(t) = (\zeta_1(t), \ldots, \zeta_k(t))^{\top}$ , of the form

$$A\frac{d\zeta(t)}{dt} + \tilde{N}(t)\zeta(t) = \tilde{F}(t),$$

where A is the nonsingular constant matrix defined by

$$A_{ij} = (e_i, e_j) + 2\alpha \left( De_i, De_j \right) \qquad i, j = 1, \cdots, k,$$

 $\tilde{N}(t)$  is the matrix given by

$$\begin{split} \tilde{N}_{ij}(t) &= 2\nu \left( De_i, De_j \right) - b \left( e_i, e_j, \sigma(\tilde{y}(t)) \right) + b \left( e_j, e_i, \sigma(\tilde{y}(t)) \right) \\ &+ b \left( e_j, \tilde{y}(t), \sigma(e_i) \right) - b \left( \tilde{y}(t), e_j, \sigma(e_i) \right) \qquad i, j = 1, \cdots, k \end{split}$$

and

$$\tilde{F}_i(t) = \left(\tilde{f}(t), e_i\right) \qquad i = 1, \cdots, k.$$

Using the same arguments as for the linearized equation, we can justify that this system has a unique solution  $\zeta \in H^1(0,T)$ .

The remaing proof is split into four steps.

Step 1. Uniform  $H^1$  in space estimate. Multiplying the equation (5.13) by  $\zeta_j(t)$  and taking the sum over  $j = 1, \ldots, k$ , we verify that  $\psi_k(t)$  is a solution of the following equation

$$\frac{1}{2} \frac{d}{dt} \left( \left\| \psi_k(t) \right\|_2^2 + 2\alpha \left\| D\psi_k(t) \right\|_2^2 \right) + 2\nu \left\| D\psi_k(t) \right\|_2^2$$
$$= \left( \tilde{f}(t), \psi_k(t) \right) + \left( \operatorname{curl} \sigma(\tilde{\boldsymbol{y}}(t)) \times \boldsymbol{\psi}_k(t), \boldsymbol{\psi}_k(t) \right) - \left( \operatorname{curl} \sigma(\tilde{\boldsymbol{y}}(t) \times \boldsymbol{\psi}_k(t)), \boldsymbol{\psi}_k(t) \right).$$

Due to (3.1) and (5.2), we have

$$(\boldsymbol{curl}\,\sigma(\tilde{\boldsymbol{y}}(t))\times\boldsymbol{\psi}_{k}(t),\boldsymbol{\psi}_{k}(t)) - (\boldsymbol{curl}\,(\sigma\,(\tilde{\boldsymbol{y}}(t)\times\boldsymbol{\psi}_{k}(t))),\boldsymbol{\psi}_{k}(t))$$
  
=  $-b\,(\psi_{k}(t),\tilde{\boldsymbol{y}}(t),\sigma(\psi_{k}(t))) + b\,(\tilde{\boldsymbol{y}}(t),\psi_{k}(t),\sigma(\psi_{k}(t))) = -\,(\boldsymbol{curl}\,\sigma(\boldsymbol{\psi}_{k}(t))\times\tilde{\boldsymbol{y}}(t),\boldsymbol{\psi}_{k}(t))$ 

and thus

$$\begin{split} &\frac{1}{2} \frac{d}{dt} \left( \|\psi_k(t)\|_2^2 + 2\alpha \|D\psi_k(t)\|_2^2 \right) + 2\nu \|D\psi_k(t)\|_2^2 \\ &= \left( \tilde{f}(t), \psi_k(t) \right) - (\operatorname{\boldsymbol{curl}} \sigma(\boldsymbol{\psi}_k(t)) \times \tilde{\boldsymbol{y}}(t), \boldsymbol{\psi}_k(t)) \,. \end{split}$$

Arguing exactly as in the first step of the proof of Proposition 4.3, we obtain

$$\|\psi_k\|_{L^{\infty}(I;L^2)}^2 + 2\alpha \|D\psi_k\|_{L^{\infty}(I;L^2)}^2 \le \left\|\tilde{F}_1\right\|_{L^1(0,T)} e^{\tilde{G}_1 T},\tag{5.14}$$

where  $\tilde{F}_1(t) = \left\| \tilde{f}(t) \right\|_2^2$  and  $\tilde{G}_1 = c \left( 1 + (1+\alpha) \| \tilde{y} \|_{L^{\infty}(I;H^3)} \right)$ .

Step 2. Uniform  $H^2$  in space estimate. Arguing as in the second step of the proof of Proposition 4.3, we deduce that

$$\begin{split} &\frac{1}{2}\frac{d}{dt}\left(2\left\|D\psi_{k}(t)\right\|_{2}^{2}+\alpha\left\|\mathbb{A}\psi_{k}(t)\right\|_{2}^{2}\right)+\nu\left\|\mathbb{A}\psi_{k}(t)\right\|_{2}^{2}\\ &=\left(\tilde{f}(t),\mathbb{A}\psi_{k}(t)\right)+\left(\boldsymbol{curl}\,\sigma(\tilde{\boldsymbol{y}}(t))\times\boldsymbol{\psi}_{k}(t)-\boldsymbol{curl}\left(\sigma\left(\tilde{\boldsymbol{y}}(t)\times\boldsymbol{\psi}_{k}(t)\right)\right),\mathbb{A}\boldsymbol{\psi}_{k}(t)\right). \end{split}$$

Using the Young inequality and Lemma 5.3, we obtain

$$\begin{split} & \frac{d}{dt} \left( 2 \left\| D\psi_k(t) \right\|_2^2 + \alpha \left\| \mathbb{A}\psi_k(t) \right\|_2^2 \right) + \nu \left\| \mathbb{A}\psi_k(t) \right\|_2^2 \\ & \leq \frac{1}{\nu} \left\| \tilde{f}(t) \right\|_2^2 + 2 \left| \left( \boldsymbol{curl} \, \sigma(\tilde{\boldsymbol{y}}(t)) \times \boldsymbol{\psi}_k(t) - \boldsymbol{curl} \left( \sigma\left( \tilde{\boldsymbol{y}}(t) \times \boldsymbol{\psi}_k(t) \right) \right), \mathbb{A}\boldsymbol{\psi}_k(t) \right) \right| \\ & \leq \frac{1}{\nu} \left\| \tilde{f}(t) \right\|_2^2 + c(1+\alpha) \left\| \tilde{\boldsymbol{y}}(t) \right\|_{H^3} \left\| \boldsymbol{\psi}_k(t) \right\|_{H^2} \left\| \mathbb{A}\boldsymbol{\psi}_k(t) \right\|_2 + \alpha \left| b\left( \tilde{\boldsymbol{y}}(t), \Delta \boldsymbol{\psi}_k(t), \mathbb{A}\boldsymbol{\psi}_k(t) \right) \right|. \end{split}$$

Since

$$b\left(\tilde{y}(t), \Delta\psi_k(t), \mathbb{A}\psi_k(t)\right) = b\left(\tilde{y}(t), \Delta\psi_k(t) + \mathbb{A}\psi_k(t), \mathbb{A}\psi_k(t)\right)$$

by taking into account (2.1) and (2.2), we deduce that

$$\begin{split} & \frac{d}{dt} \left( 2 \| D\psi_k(t) \|_2^2 + \alpha \| \mathbb{A}\psi_k(t) \|_2^2 \right) + \nu \| \mathbb{A}\psi_k(t) \|_2^2 \\ & \leq \frac{1}{\nu} \left\| \tilde{f}(t) \right\|_2^2 + c(1+\alpha) \| \tilde{y}(t) \|_{H^3} \| \psi_k(t) \|_{H^2} \| \mathbb{A}\psi_k(t) \|_2 \\ & \leq \frac{1}{\nu} \left\| \tilde{f}(t) \right\|_2^2 + c(1+\alpha) \| \tilde{y} \|_{H^3} \left( \| \psi_k \|_2^2 + \| \mathbb{A}\psi_k(t) \|_2^2 \right) \\ & \leq \tilde{F}_2(t) + \tilde{G}_2 \left( 2 \| D\psi_k(t) \|_2^2 + \alpha \| \mathbb{A}\psi_k(t) \|_2^2 \right), \end{split}$$

where

$$\begin{split} \tilde{F}_{2}(t) &= \frac{1}{\nu} \left\| \tilde{f}(t) \right\|_{2}^{2} + c(1+\alpha) \left\| \tilde{y} \right\|_{L^{\infty}(I;H^{3})} \left\| \psi_{k} \right\|_{L^{\infty}(I;L^{2})}^{2}, \\ \tilde{G}_{2} &= \frac{c(1+\alpha)}{\alpha} \left\| \tilde{y} \right\|_{L^{\infty}(I;H^{3})}. \end{split}$$

Upon integration, we have

$$2 \|D\psi_k(t)\|_2^2 + \alpha \|\mathbb{A}\psi_k(t)\|_2^2 \le \left\|\tilde{F}_2\right\|_{L^1(0,t)} + \tilde{G}_2 \int_0^t \left(2 \|D\psi_k(s)\|_2^2 + \alpha \|\mathbb{A}\psi_k(s)\|_2^2\right) ds$$

and by using Gronwall's inequality, we deduce that

$$2 \left\| D\psi_k \right\|_{L^{\infty}(I;L^2)}^2 + \alpha \left\| \mathbb{A}\psi_k \right\|_{L^{\infty}(I;L^2)}^2 \le \left\| \tilde{F}_2 \right\|_{L^1(0,T)} e^{\tilde{G}_2 T}.$$
(5.15)

Step 3. Uniform estimate for the time derivative. Let us multiply both sides of (5.13) by  $\frac{d\zeta_j(t)}{dt}$  and sum over  $j = 1, \ldots, k$ . This gives

$$\begin{split} \left\| \frac{\partial \psi_k(t)}{\partial t} \right\|_2^2 + \alpha \left\| D \frac{\partial \psi_k(t)}{\partial t} \right\|_2^2 &= \left( \tilde{f}(t) + \nu \Delta \psi_k(t), \frac{\partial \psi_k(t)}{\partial t} \right) \\ &+ \left( curl \, \sigma(\tilde{\boldsymbol{y}}(t)) \times \boldsymbol{\psi}_k(t) - curl \left( \sigma\left( \tilde{\boldsymbol{y}}(t) \times \boldsymbol{\psi}_k(t) \right) \right), \frac{\partial \boldsymbol{\psi}_k(t)}{\partial t} \right). \end{split}$$

Due to inequality (5.3), we have

$$\begin{split} & \left| \left( \boldsymbol{curl} \, \sigma(\tilde{\boldsymbol{y}}(t)) \times \boldsymbol{\psi}_{k}(t) - \boldsymbol{curl} \left( \sigma\left( \tilde{\boldsymbol{y}}(t) \times \boldsymbol{\psi}_{k}(t) \right) \right), \frac{\partial \boldsymbol{\psi}_{k}(t)}{\partial t} \right) \right| \\ & \leq c(1+\alpha) \left\| \tilde{\boldsymbol{y}}(t) \right\|_{H^{3}} \left\| \boldsymbol{\psi}_{k}(t) \right\|_{H^{2}} \left\| \frac{\partial \boldsymbol{\psi}_{k}(t)}{\partial t} \right\|_{2} + \alpha \left| -b \left( \tilde{\boldsymbol{y}}(t), \frac{\partial \boldsymbol{\psi}_{k}(t)}{\partial t}, \Delta \boldsymbol{\psi}_{k}(t) \right) \right| \\ & \leq c(1+\alpha) \left\| \tilde{\boldsymbol{y}}(t) \right\|_{H^{3}} \left\| \boldsymbol{\psi}_{k}(t) \right\|_{H^{2}} \left\| \frac{\partial \boldsymbol{\psi}_{k}(t)}{\partial t} \right\|_{H^{1}} \\ & \leq c(1+\alpha) \left\| \tilde{\boldsymbol{y}}(t) \right\|_{H^{3}} \left\| \boldsymbol{\psi}_{k}(t) \right\|_{H^{2}} \left( \left\| \frac{\partial \boldsymbol{\psi}_{k}(t)}{\partial t} \right\|_{2} + \left\| D \frac{\partial \boldsymbol{\psi}_{k}(t)}{\partial t} \right\|_{2} \right). \end{split}$$

Therefore, by arguing as in the third step of the proof of Proposition 4.3, we deduce that

$$\left\|\frac{\partial\psi_{k}}{\partial t}\right\|_{2,Q}^{2} + \alpha \left\|D\frac{\partial\psi_{k}}{\partial t}\right\|_{2,Q}^{2}$$

$$\leq c \left(\left\|\tilde{f}\right\|_{2,Q}^{2} + T\left(\nu^{2} + \frac{(1+\alpha)^{2}}{\alpha}\left\|\tilde{y}\right\|_{L^{\infty}(I;H^{3})}^{2}\right)\left\|\psi_{k}\right\|_{L^{\infty}(I;H^{2})}^{2}\right).$$
(5.16)

Step 4. Passage to the limit. Considering estimates (5.14), (5.15) and (5.16), we deduce that the sequences  $(\psi_k)_k$  and  $\left(\frac{\partial \psi_k}{\partial t}\right)_k$  are uniformly bounded in  $L^{\infty}(I; W)$  and  $L^2(I; V)$ , respectively. Then there exists a subsequence, still indexed by k, and function  $\psi \in H^2(\Omega)$  such that

$$\begin{array}{ll} \psi_k \longrightarrow \psi & \mbox{weakly}^* \mbox{ in } L^\infty(I; H^2(\Omega)), \\ \\ \frac{\partial \psi_k}{\partial t} \longrightarrow \frac{\partial \psi}{\partial t} & \mbox{weakly in } L^2(I; H^1(\Omega)). \end{array}$$

These convergence results imply that  $\psi \in C(\bar{I}; H^1(\Omega))$  and as  $\psi_k(0)$  converges to zero in  $H^1(\Omega)$ , we deduce that  $\psi$  verifies the initial condition  $\psi(0) = 0$ . By passing to the limit in  $(5.13)_1$ , we obtain for every  $j \ge 1$ 

$$\begin{pmatrix} \frac{\partial \psi(t)}{\partial t}, e_j \end{pmatrix} + 2\alpha \left( D \frac{\partial \psi(t)}{\partial t}, D e_j \right) + 2\nu \left( D \psi(t), D e_j \right) + b \left( \psi(t), \mathbf{e}_j, \sigma(\tilde{y}(t)) \right) - b \left( \mathbf{e}_j, \psi(t), \sigma(\tilde{y}(t)) \right) \\ + b \left( \psi(t), \tilde{y}(t), \sigma(\mathbf{e}_j) \right) - b \left( \tilde{y}(t), \psi(t), \sigma(\mathbf{e}_j) \right) = \left( \tilde{f}(t), e_j \right)$$

and by density we prove that  $\psi$  is a solution of (5.12). Moreover,  $\psi$  satisfies

$$\begin{split} \|\psi\|_{L^{\infty}(I;L^{2})}^{2} + 2\alpha \|D\psi\|_{L^{\infty}(I;L^{2})}^{2} &\leq \left\|\tilde{f}\right\|_{2,Q}^{2} e^{cT\left(1+(1+\alpha)\|\tilde{y}\|_{L^{\infty}(I;H^{3})}\right)}, \\ & 2 \|D\psi\|_{L^{\infty}(I;L^{2})}^{2} + \alpha \|A\psi\|_{L^{\infty}(I;L^{2})}^{2} \\ &\leq \left(\frac{1}{\nu} \left\|\tilde{f}\right\|_{2,Q}^{2} + cT(1+\alpha) \|\tilde{y}\|_{L^{\infty}(I;H^{3})} \|\psi\|_{L^{\infty}(I;L^{2})}^{2}\right) e^{\frac{c(1+\alpha)T}{\alpha} \|\tilde{y}\|_{L^{\infty}(I;H^{3})}} \\ & \left\|\frac{\partial\psi}{\partial t}\right\|_{2,Q}^{2} + \alpha \left\|D\frac{\partial\psi}{\partial t}\right\|_{2,Q}^{2} \\ &\leq c \left(\|\tilde{f}\|_{2,Q}^{2} + T\left(\nu^{2} + \frac{(1+\alpha)^{2}}{\alpha} \|\tilde{y}\|_{L^{\infty}(I;H^{3})}^{2}\right) \|\psi\|_{L^{\infty}(I;H^{3})}^{2}\right) \|\psi\|_{L^{\infty}(I;H^{2})}^{2}\right), \end{split}$$

where c is a constant only depending on  $\Omega$ . Since (5.11) is linear, the uniquess result is direct consequence of the first estimate.

Summarizing, we have established that (5.11) admits a unique solution in the sense of (5.12) and that this solution satisfies the previous estimates. As a consequence, it follows that problem (5.1) admits a unique solution in the sense of (5.10). By taking into account the fact that

$$\begin{split} \|f\|_{2,Q} &= \|f\|_{2,Q} \,, \qquad \|\tilde{y}\|_{L^{\infty}(I;H^{3})} = \|y\|_{L^{\infty}(I;H^{3})} \,, \\ \|\psi\|_{L^{\infty}(I;L^{2})} &= \|p\|_{L^{\infty}(I;L^{2})} \,, \qquad \|D\psi\|_{L^{\infty}(I;L^{2})} = \|Dp\|_{L^{\infty}(I;L^{2})} \,, \qquad \|\mathbb{A}\psi\|_{L^{\infty}(I;L^{2})} = \|\mathbb{A}p\|_{L^{\infty}(I;L^{2})} \\ \left\|\frac{\partial\psi}{\partial t}\right\|_{2,Q} &= \left\|\frac{\partial p}{\partial t}\right\|_{2,Q} \,, \qquad \left\|D\frac{\partial\psi}{\partial t}\right\|_{2,Q} = \left\|D\frac{\partial p}{\partial t}\right\|_{2,Q} \,, \end{split}$$

we deduce that p satisfies the claimed estimates.

We finish this section by establishing a relation between the adjoint state and the solution of a linearized state equation.

**Proposition 5.5** Let y be in  $L^{\infty}(I; W \cap H^{3}(\Omega))$  and  $f, w \in L^{2}(Q)$ . Then we have

$$\int_0^T (w(t), p(t)) \, dt = \int_0^T (f(t), z(t)) \, dt,$$

where p is the solution of (5.1) and where z is the solution of the linearized system (4.1) corresponding to  $y_1 = y_2 = y$ .

**Proof.** Let  $p_k(t) = \psi_k(T-t)$ , where  $\psi_k$  is the solution of (5.13). Then  $p_k = \sum_{i=1}^k \zeta_i^*(t) e_i$  satisfies

$$\begin{cases} -\left(\frac{\partial p_k(t)}{\partial t}, e_j\right) - 2\alpha \left(D\frac{\partial p_k(t)}{\partial t}, De_j\right) + 2\nu \left(Dp_k(t), De_j\right) \\ + b \left(p_k(t), e_j, \sigma(y(t))\right) - b \left(e_j, p_k(t), \sigma(y(t))\right) \\ + b \left(p_k(t), y(t), \sigma(e_j)\right) - b \left(y(t), p_k(t), \sigma(e_j)\right) = (f(t), e_j) \quad 1 \le j \le k, \end{cases}$$

$$(5.17)$$

$$p_k(T) = 0.$$

Let  $z_k(t) = \sum_{i=1}^k \zeta_i^{**}(t)e_i$  be the solution of (4.12) corresponding to  $y_1 = y_2 = y$ , that is  $z_k(t)$  satisfies

$$\begin{cases} \left(\frac{\partial z_k(t)}{\partial t}, e_j\right) + 2\alpha \left(D\frac{\partial z_k(t)}{\partial t}, De_j\right) + 2\nu \left(Dz_k(t), De_j\right) \\ + b\left(e_j, y(t), \sigma(z_k(t))\right) - b\left(y(t), e_j, \sigma(z_k(t))\right) \\ + b\left(e_j, z_k(t), \sigma(y(t))\right) - b\left(z_k(t), e_j, \sigma(y(t))\right) = (w(t), e_j) \qquad 1 \le j \le k, \end{cases}$$

$$(5.18)$$

$$z_k(0) = 0.$$

Multiplying  $(5.17)_1$  by  $\zeta_i^{**}(t)$  and summing, we obtain

$$-\left(\frac{\partial p_k(t)}{\partial t}, z_k(t)\right) - 2\alpha \left(D\frac{\partial p_k(t)}{\partial t}, Dz_k(t)\right) + 2\nu \left(Dp_k(t), Dz_k(t)\right) + b \left(p_k(t), z_k(t), \sigma(y(t))\right) - b \left(z_k(t), p_k(t), \sigma(y(t))\right) + b \left(p_k(t), y(t), \sigma(z_k(t))\right) - b \left(y(t), p_k(t), \sigma(z_k(t))\right) = (f(t), z_k(t))$$
(5.19)

Similarly, by multiplying  $(5.18)_1$  by  $\zeta_i^*(t)$  and summing, we obtain

$$\left(\frac{\partial z_k(t)}{\partial t}, p_k(t)\right) + 2\alpha \left(D\frac{\partial z_k(t)}{\partial t}, Dp_k(t)\right) + 2\nu \left(Dz_k(t), Dp_k(t)\right) + b \left(p_k(t), y(t), \sigma(z_k(t))\right) - b \left(y(t), p_k(t), \sigma(z_k(t))\right) + b \left(p_k(t), z_k(t), \sigma(y(t))\right) - b \left(z_k(t), p_k(t), \sigma(y(t))\right) = \left(w(t), p_k(t)\right).$$
(5.20)

On the other hand, by applying standard rule of integration by parts we obtain

$$- \left(\frac{\partial p_k(t)}{\partial t}, z_k(t)\right) - 2\alpha \left(D\frac{\partial p_k(t)}{\partial t}, Dz_k(t)\right)$$

$$= - \left(\frac{\partial p_k(t)}{\partial t}, \sigma \left(z_k(t)\right)\right) = \left(p_k(t), \frac{\partial \sigma(z_k(t))}{\partial t}\right) - \frac{d}{dt} \left(p_k(t), \sigma \left(z_k(t)\right)\right)$$

$$= \left(p_k(t), \frac{\partial \sigma(z_k(t))}{\partial t}\right) - \frac{d}{dt} \left((p_k(t), z_k(t)) + 2\alpha \left(Dp_k(t), Dz_k(t)\right)\right)$$

$$= \left(p_k(t), \frac{\partial z_k(t)}{\partial t}\right) + 2\alpha \left(Dp_k(t), D\frac{\partial z_k(t)}{\partial t}\right) - \frac{d}{dt} \left((p_k(t), z_k(t)) + 2\alpha \left(Dp_k(t), Dz_k(t)\right)\right)$$

By integrating and taking into account  $(5.17)_2$  and  $(5.18)_2$  we deduce that

$$\int_{0}^{T} \left( -\left(\frac{\partial p_{k}(t)}{\partial t}, z_{k}(t)\right) - 2\alpha \left(D\frac{\partial p_{k}(t)}{\partial t}, Dz_{k}(t)\right) \right) dt$$
$$= \int_{0}^{T} \left( \left(p_{k}(t), \frac{\partial z_{k}(t)}{\partial t}\right) + 2\alpha \left(Dp_{k}(t), D\frac{\partial z_{k}(t)}{\partial t}\right) \right).$$
(5.21)

Combining (5.19)-(5.21), we finally obtain

$$\int_0^T (f(t), z_k(t)) \, dt = \int_0^T (w(t), p_k(t)) \, dt$$

The claimed result follows by passing to the limit.

## 6 Proof of the main results

### Proof of the existence of an optimal control for (P).

Let  $(u_k, y_k)_k$  be a minimizing sequence. Since  $(u_k)_k$  is uniformly bounded in the closed convex set  $U_{ad} \subset L^2(I; H^1(\Omega))$ , by taking into account (3.4)-(3.6), we deduce that the sequence  $(y_k)_k$  is bounded in  $L^{\infty}(I; W \cap H^3(\Omega))) \cap H^1(I; V)$ . We may then extract a subsequence, still indexed by k, such that  $(u_k)_k$  weakly converges to some  $u \in U_{ad}$  in  $L^2(I; H(\operatorname{curl}; \Omega)), (y_k)_k$  weakly\* converges to some y in the weakly\* topology of  $L^{\infty}(I; H^3(\Omega)) \cap H^1(I; V)$  and, by using compactness results on Sobolev spaces, in the strong topology of  $C(\bar{I}; H^1(\Omega))$ .

Since  $y_k(0) = y_0$ , it follows that  $y(0) = y_0$ . Moreover, by passing to the limit in the variational formulation corresponding to  $y_k$ , we obtain

$$\left(\frac{\partial y(t)}{\partial t},\phi\right) + 2\alpha \left(D\frac{\partial y(t)}{\partial t},D\phi\right) + 2\nu \left(Dy(t),D\phi\right) + b\left(\phi,y(t),\sigma(y(t))\right) - b\left(y(t),\phi,\sigma(y(t))\right) = \left(u(t),\phi\right)$$

for all  $\phi \in V$ , implying that (u, y) satisfies (1.1). From the convexity and continuity of J, it follows the lower semicontinuity of J in the weak topology and

$$J(u, y) \le \liminf_{k} J(u_k, y_k) = \inf(P),$$

showing that (u, y) is a solution for (P).

#### Proof of the necessary optimality conditions for (P).

Taking into account Propositions 3.2, 4.3 and 5.4 and Proposition 4.5, it follows that the corresponding state, linearized state, adjoint state exist and are unique and that the control-to-state mapping is Gâteaux differentiable at  $\bar{u}$ . For  $\rho \in ]0,1[$  and  $v \in U_{ad}$ , let  $u_{\rho} = \bar{u} + \rho(v - \bar{u})$  and  $y_{\rho}$  the corresponding solution of (1.1). Since  $(\bar{u}, \bar{y})$  is an optimal solution and  $(u_{\rho}, y_{\rho})$  is admissible, we have

$$\lim_{\rho \to 0} \frac{J(u_{\rho}, y_{\rho}) - J(\bar{u}, \bar{y})}{\rho} \ge 0.$$

By taking into account Proposition 4.5, we deduce that

$$\int_{0}^{T} \left( z_{\bar{u},v-\bar{u}}(t), \bar{y}(t) - y_{d}(t) \right) + \lambda \left( \bar{u}(t), v(t) - \bar{u}(t) \right) dt \ge 0,$$
(6.1)

where  $z_{\bar{u},v-\bar{u}}$  is the (unique) solution of the linearized equation

$$\begin{cases} \frac{\partial \sigma(\boldsymbol{z})}{\partial t} - \nu \Delta \boldsymbol{z} + \boldsymbol{curl} \, \sigma(\boldsymbol{z}) \times \boldsymbol{\bar{y}} + \boldsymbol{curl} \, \sigma(\boldsymbol{\bar{y}}) \times \boldsymbol{z} + \nabla \pi = \boldsymbol{v} - \boldsymbol{\bar{u}} & \text{in } Q, \\ \operatorname{div} \boldsymbol{z} = 0 & \operatorname{in } Q, \\ \boldsymbol{z} \cdot \boldsymbol{n} = 0, \quad (\boldsymbol{n} \cdot D\boldsymbol{z}) \cdot \boldsymbol{\tau} = 0 & \text{on } \Sigma, \end{cases}$$

$$\boldsymbol{z}(0) = 0$$
 in  $\Omega$ .

Let  $\bar{p}$  be the unique solution of (1.2). By taking into account Proposition 5.5, we deduce that

$$\int_0^T \left( \bar{y}(t) - y_d(t), z_{\bar{u}, v - \bar{u}}(t) \right) dt = \int_0^T \left( v(t) - \bar{u}(t), \bar{p}(t) \right) dt.$$
(6.2)

The result follows by combining (6.1) and (6.2).
