RENEWAL THEOREMS FOR A CLASS OF PROCESSES WITH DEPENDENT INTERARRIVAL TIMES AND APPLICATIONS IN GEOMETRY

SABRINA KOMBRINK

ABSTRACT. Renewal theorems are developed for point processes with interarrival times $W_n = \xi(X_{n+1}X_n \cdots)$, where $(X_n)_{n\in\mathbb{Z}}$ is a stochastic process with finite state space Σ and $\xi: \Sigma_A \to \mathbb{R}$ is a Hölder continuous function on a subset $\Sigma_A \subset \Sigma^{\mathbb{N}}$. The theorems developed here unify and generalise the key renewal theorem for discrete measures and Lalley's renewal theorem for counting measures in symbolic dynamics. Moreover, they capture aspects of Markov renewal theory. The new renewal theorems allow for direct applications to problems in fractal and hyperbolic geometry; for instance, results on the Minkowski measurability of self-conformal sets are deduced. Indeed, these geometric problems motivated the development of the renewal theorems.

1. Introduction and statement of main results

1.1. Renewal Theory. Renewal theorems have found wide applicability in various areas of mathematics (such as fractal and hyperbolic geometry), economics (such as queueing, insurance and ruin problems) and biology (such as population dynamics). They are concerned with waiting times in-between occurrences of a repetitive pattern connected with repeated trials of a stochastic experiment. In classical renewal theory, it is assumed that after each occurrence of the pattern, the trials start from scratch. This means that the trials which follow an occurrence of the pattern form a replica of the whole stochastic experiment. In other words, the *waiting times* in-between successive occurrences of the pattern, also called *interarrival times*, are assumed to be mutually independent random variables with the same distribution (see [\[Fel68,](#page-23-0) Ch. XIII] and [\[Fel71\]](#page-23-1)). The classical renewal theorems have been extended in various ways and to various different settings. One such extension, which is of particular interest to us, is given by Markov renewal theory. By a Markov random walk, we understand a point process for which the interarrival times W_0, W_1, \ldots are not necessarily independent identically distributed (i. i. d.), but Markov dependent on a discrete Markov chain $(X_n)_{n\in\mathbb{N}_0}$. This means that W_n is sampled according to the current and proximate values X_n, X_{n+1} but is independent of the past values X_{n-1},\ldots,X_0 . In the present article, we drop the assumption that $(X_n)_{n\in\mathbb{N}_0}$ is a Markov chain and that W_n is Markov dependent on $(X_n)_{n\in\mathbb{N}_0}$. Instead, we consider a time-homogeneous (i.e. stationary increments) stochastic process $(X_n)_{n\in\mathbb{Z}}$ with finite state space and time-set $\mathbb Z$ and extend to the setting that W_n may depend on the current values X_{n+1}, X_n as well as on the whole past X_{n-1}, X_{n-2}, \ldots of the stochastic process $(X_n)_{n\in\mathbb{Z}}$. The dependence of W_n on X_{n+1}, X_n, \ldots is assumed to be described by a Hölder continuous function. This additionally allows us to treat situations with more strongly dependent interarrival times. Before giving an outline of the theorems we want to provide references to the afore-mentioned. Since the literature on classical and Markov renewal theory is vast, we abstain from presenting a complete list but instead refer to the following monographs and fundamental articles, where further references can be found: [\[Fel68,](#page-23-0) [Fel71,](#page-23-1) Cin75, [Als91,](#page-23-3) [Asm03,](#page-23-4) [MO14\]](#page-24-0).

We let $\Sigma := \{1, \ldots, M\}, M \geq 2$ denote the state space of the time-homogeneous stochastic process $(X_n)_{n \in \mathbb{Z}}$. The admissible transitions are assumed to be governed by a *primitive* $(M \times M)$ - incidence matrix A of zeros and ones, meaning there exists $n \in \mathbb{N}$ such that all entries of A^n are positive. The set of *one-sided infinite admissible* paths through Σ consistent with $A = (A(i, j))_{i,j \in \Sigma}$ is defined by $\Sigma_A := \{x \in \Sigma^{\mathbb{N}} \mid A(x_k, x_{k+1}) = 1 \,\forall \, k \in \mathbb{N}\}.$ Elements of Σ_A are interpreted as paths which describe the history of the process, supposing that the process

has been going on forever. Given $x \in \Sigma_A$, we study the limiting behaviour as $t \to \infty$ of the renewal function

$$
N(t,x) := \mathbb{E}_x \left[\sum_{n=0}^{\infty} \widetilde{f}_{X_n \cdots X_1 x} \left(t - \sum_{k=0}^{n-1} W_k \right) \right],
$$

where \mathbb{E}_x is the conditional expectation given $X_0X_{-1}\cdots = x$, the family $\{\widetilde{f}_y : \mathbb{R} \to \mathbb{R} \mid y \in \Sigma_A\}$ satisfies some regularity conditions (see Sec. [3.1\)](#page-7-0) and for $n = 0$ we interpret $\tilde{f}_{X_n \dots X_1 x}(t - \sum_{k=0}^{n-1} W_k)$ to be $\tilde{f}_x(t)$. For instance, if $\tilde{f}_y := 1_{[0,\infty)}$, then $N(t,x)$ gives the expected number of renewals in the time-interval $(0, t]$ given $X_0 X_{-1} \cdots = x$. A natural assumption in applications is that the recent history of $(X_n)_{n \in \mathbb{Z}}$ has more influence on which state will be visited next than the earlier history. This is reflected in our assumption that the function $\eta: \Sigma_A \to \mathbb{R}$ given by $\eta(ix) := \log \mathbb{P}_x(X_1 = i)$ is α -Hölder continuous for some $\alpha \in (0,1)$ in the sense of Defn. [2.1.](#page-6-0) Here, \mathbb{P}_x is the distribution corresponding to \mathbb{E}_x and $i \in \Sigma$. Note that $\mathbb{P}_x(X_1 = i) := \mathbb{P}(X_1 = i \mid X_0 X_{-1} \cdots = x) > 0$ if $ix \in \Sigma_A$ by definition of Σ_A . Similarly, we assume that there exists $\xi \in \mathcal{F}_{\alpha}(\Sigma_A, \mathbb{R})$ with $W_n = \xi(X_{n+1}X_nX_{n-1}\cdots)$. Here, $F_{\alpha}(\Sigma_A, \mathbb{R})$ denotes the class of real-valued α -Hölder continuous functions on Σ_A , see Def. [2.1.](#page-6-0) This notation allows us to evaluate the conditional expectation and express $N(t, x)$ in a deterministic way. For this, write $S_n \xi := \sum_{k=0}^{n-1} \xi \circ \sigma^k$ for the n-th Birkhoff sum of ξ with $n \in \mathbb{N}$ and $S_0\xi := 0$. Here, $\sigma \colon \Sigma_A \to \Sigma_A$ denotes the (left) shift-map on Σ_A which is defined by $\sigma(\omega_1\omega_2...) := \omega_2\omega_3...$ for $\omega_1\omega_2... \in \Sigma_A$. Notice, $\sigma(\omega)$ describes the path of the process prior to the current time. Then $\sum_{k=0}^{n-1} W_k = S_n \xi(X_n X_{n-1} \cdots)$ and, for $x, y \in \Sigma_A$ with $\sigma^n y = x$, we have $\mathbb{P}(X_n X_{n-1} \cdots = y \mid X_0 X_{-1} \cdots = x) = \exp(S_n \eta(y)).$ Thus,

(1.1)
$$
N(t,x) = \sum_{n=0}^{\infty} \sum_{y \in \Sigma_A : \sigma^n y = x} \widetilde{f}_y(t - S_n \xi(y)) e^{S_n \eta(y)}.
$$

From this, one can deduce the renewal-type equation

$$
N(t,x) = \sum_{y \in \Sigma_A: \sigma y = x} N(t - \xi(y), y) e^{\eta(y)} + \widetilde{f}_x(t),
$$

which justifies calling N a renewal function. Intuitively, interarrival times are non-negative and probabilities take values in [0,1]. However, when considering the deterministic form [\(1.1\)](#page-1-0), we allow ξ to take negative values, provided there exists $n \in \mathbb{N}$ for which $S_n \xi$ is strictly positive. Note that this condition is equivalent to ξ being co-homologous to a strictly positive function, see Rem. [2.3.](#page-6-1) Moreover, we allow η to be chosen freely from the class $\mathcal{F}_{\alpha}(\Sigma_A, \mathbb{R}).$

Notice, the current setting extends and unifies the setting of established renewal theorems: In the context of classical renewal theory for finitely supported measures (in particular of the key renewal theorem), η and ξ only depend on the first coordinate. When $η$ and ξ only depend on the first two coordinates, we are in the setting of Markov renewal theory. If η is the constant zero-function and $f_y(t) = \chi(y) \mathbb{1}_{[0,\infty)}(t)$, where $\chi \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$ is non-negative, we are precisely in the setting of [\[Lal89\]](#page-24-1), where renewal theorems for counting measures in symbolic dynamics were developed. For more details on these connections, see Sec. [3.2.](#page-9-0)

To present the renewal theorems, we now introduce important quantities on which the asymptotic behaviour of $N(t, x)$ as $t \to \infty$ depends. We interpret $(X_{n+1}, W_n)_{n \in \mathbb{N}_0}$ as a stochastic process with state space $\Sigma \times \mathbb{R}$ and define an analogue of a transition kernel $U: \Sigma_A \times (\mathcal{P}(\Sigma) \otimes \mathfrak{B}(\mathbb{R})) \to \mathbb{R}$ by

$$
U(x, \{j\} \times (-\infty, t]) := \mathbb{P}(X_{n+1} = j, W_n \le t \mid X_n X_{n-1} \cdots = x)
$$

$$
= \mathbb{1}_{(-\infty, t]}(\xi(jx))e^{\eta(jx)}
$$

for $x \in \Sigma_A$, $j \in \Sigma$ and $t \in \mathbb{R}$. Here $\mathcal{P}(\Sigma)$ denotes the power set of Σ and $\mathfrak{B}(\mathbb{R})$ denotes the Borel σ -algebra on R. For given $x \in \Sigma_A$ and $j \in \Sigma$, we set $F_{x,j}(t) := U(x,\{j\} \times (-\infty,t])$ which defines a distribution function $F_{x,j}$ of a finite measure with total mass $\exp(\eta(jx))$. Its Laplace transform at $s \in \mathbb{R}$ is given by $(\mathcal{L}F_{x,j})(s) := \int_{-\infty}^{\infty} e^{-sT} dF_{x,j}(T) = e^{\eta(jx)} e^{-s\xi(jx)}$. For a given $s \in \mathbb{R}$ it can be extended to an operator $\mathcal{L}_{\eta-s\xi} : \mathcal{C}(\Sigma_A) \to \mathcal{C}(\Sigma_A)$ acting on the space $\mathcal{C}(\Sigma_A)$ of continuous complex-valued functions on Σ_A (see Sec. [2.2\)](#page-6-2) by

(1.2)
$$
\mathcal{L}_{\eta-s\xi}\chi(x) := \sum_{y \in \Sigma_A: \sigma y = x} \chi(y) e^{\eta(y) - s\xi(y)}.
$$

Then $\mathcal{L}_{\eta-s\xi}1_{[j]}(x) = (\mathcal{L}F_{x,j})(s)$, where $[j] := \{x = x_1x_0 \cdots \in \Sigma_A | x_1 = j\}$ denotes the *cylinder set* of $j \in \Sigma$. The operator $\mathcal{L}_{\eta-s\xi}$ is called the *Ruelle-Perron-Frobenius* operator to the potential function $\eta - s\xi$. The Ruelle-Perron-Frobenius operator is a linear operator which takes the role of the stochastic matrix in the classical Perron-Frobenius theory. (If η and ξ only depend on the first two letters, then $\mathcal{L}_{\eta-s\xi}$ has an interpretation of a matrix $(B_{ij}(s))_{i,j\in\Sigma}$ with entries $B_{ij}(s) := \exp[\eta(ji) - s\xi(ji)]$ if i to j is an allowed transition, and $B_{ij}(s) := 0$ otherwise. Studying this matrix leads to Markov renewal theorems, see Sec. [3.2.3.](#page-10-0)) The *n*-th iterates of the Ruelle-Perron-Frobenius operator given by $\mathcal{L}_{\eta-s\xi}^n \chi(x) = \sum_{y \in \Sigma_A, \sigma^n y = x} \chi(y) e^{S_n(\eta-s\xi)(y)}$ are closely related to the renewal function N. This becomes apparent by multiplying $N(t, x)$ with $\exp(-st)$ and writing $\widetilde{g}_y(t) := \exp(-st) \widetilde{f}_y(t)$, yielding

(1.3)
$$
e^{-st}N(t,x) = \sum_{n=0}^{\infty} \sum_{y \in \Sigma_A: \sigma^n y = x} \widetilde{g}_y(t - S_n \xi(y)) e^{S_n(\eta - s\xi)(y)}.
$$

We let δ denote the unique value of s, for which $\mathcal{L}_{\eta-s\xi}$ has spectral radius one, see Prop. [2.5.](#page-7-1) This is exactly the value of s at which the series in [\(1.3\)](#page-2-0) jumps from being convergent to being divergent (if \tilde{g}_y are sufficiently tame, in particular bounded, which is ensured by regularity conditions on f_y , see Sec. [3.1\)](#page-7-0). The unique eigenfunction of $\mathcal{L}_{\eta-\delta\xi}$ to the eigenvalue one is denoted by $h_{\eta-\delta\xi}$. The associated equilibrium measure, i.e. the fixed-point measure of the dual operator $\mathcal{L}_{\eta-\delta\xi}^*$ acting on the set of Borel probability measures supported on Σ_A , is denoted by $\nu_{\eta-\delta\xi}$. We define $\mu_{\eta-\delta\xi}$ through $d\mu_{\eta-\delta\xi}/d\nu_{\eta-\delta\xi} = h_{\eta-\delta\xi}$. This is the unique σ -invariant Gibbs measure for the potential function $\eta - \delta \xi$. For more details on these terms see Sec. [2,](#page-6-3) [\[Wal01,](#page-24-2) Thm. 2.16, Cor. 2.17] and [\[Bow08,](#page-23-5) Theorem 1.7].

It is well-known that the limiting behaviour of a renewal function depends on the values which the interarrival times assume. Loosely speaking if the possible values of the interarrival times form a spaced pattern we are in the lattice situation and otherwise in the non-lattice situation, see Defn. [2.2.](#page-6-4) This lattice – non-lattice dichotomy also occurs in our main theorems. Briefly, their conclusion is that with $s = \delta$ the term on the right hand side of [\(1.3\)](#page-2-0) converges to a positive and finite constant depending on x as $t \to \infty$, when ξ is non-lattice. When ξ is lattice, we only have convergence along subsequences, so that $N(t, x)$ is asymptotic to a periodic function. Here, we call two functions $f, g : \mathbb{R} \to \mathbb{R}$ asymptotic as $t \to \infty$, written $f(t) \sim g(t)$ as $t \to \infty$, if for all $\varepsilon > 0$ there exists $t^* \in \mathbb{R}$ such that for $t \geq t^*$ the value $f(t)$ lies between $(1 - \varepsilon)g(t)$ and $(1+\varepsilon)g(t)$. If the range of g lies in $\mathbb{R}_{>0}$ then $f(t) \sim g(t)$ as $t \to \infty$ if and only if $\lim_{t\to\infty} f(t)/g(t) = 1$. Our renewal theoretic results are proved via an analytic approach using Ruelle-Perron-Frobenius theory inspired by [\[Lal89\]](#page-24-1). They are summarised in the following theorem. We refer the reader to Sec. [3.1,](#page-7-0) in particular, Thms. [3.2](#page-8-0) and [3.3,](#page-9-1) for further details and the precise meaning of the required regularity conditions.

Renewal Theorem with dependent interarrival times. Assume that the family $\{\widetilde{f}_x(t) \mid x \in \Sigma_A\}$ satisfies some regularity conditions.

(i) If ξ is non-lattice, then

$$
N(t,x) \sim e^{t\delta} \underbrace{\frac{h_{\eta-\delta\xi}(x)}{\int \xi d\mu_{\eta-\delta\xi}} \int_{\Sigma_A} \int_{-\infty}^{\infty} e^{-T\delta} \widetilde{f}_y(T) dT d\nu_{\eta-\delta\xi}(y)}_{=:G(x)}
$$

as $t \to \infty$, uniformly for $x \in \Sigma_A$.

(ii) Assume that ξ is lattice. Then there exists a periodic function \tilde{G}_x such that

$$
N(t,x) \sim e^{t\delta} \widetilde{G}_x(t).
$$

(iii) We always have

$$
\lim_{t \to \infty} t^{-1} \int_0^t e^{-T\delta} N(T, x) dT = G(x).
$$

1.2. An Application – Minkowski content of fractal sets. A direct application of the renewal theorems with dependent interarrival times in geometry, namely existence of the Minkowski content of self-conformal sets, is the focus of the current section. It is this application which led to developing the renewal theorems. Here, we focus on the general ideas as to how to apply the respective renewal theorem and refer to a forthcoming

article by the author for the geometric details (especially concerning the approximation arguments) and extensions to broader classes of fractal sets.

Let $B \subset \mathbb{R}^d$ denote a bounded subset of the d-dimensional Euclidean space $(\mathbb{R}^d, \|\cdot\|_2)$. We wish to understand the asymptotic behaviour of the (e^{-t}) -parallel volume $\lambda_d(B_{e^{-t}})$ of B as $t \to \infty$. Here, $B_{e^{-t}} := \{x \in \mathbb{R}^d \mid \inf_{b \in B} \|b - x\|_2 \le e^{-t}\}\$ for $t \in \mathbb{R}$ and λ_d denotes the d-dimensional Lebesgue measure. More precisely, we study existence of the Minkowski content

$$
\mathcal{M}(B) := \lim_{t \to \infty} e^{t(d-D)} \lambda_d(B_{e^{-t}})
$$

of B and determine its value when the limit exists. The definition of the Minkowski content implicitly assumes existence of the *Minkowski dimension* $D := d + \lim_{t \to \infty} t^{-1} \log \lambda_d(B_{e^{-t}})$, which coincides with the box-counting dimension, see [\[Fal03,](#page-23-6) Prop. 3.2]. If $D \in \mathbb{N}$ and $\lambda_D(B) > 0$ then $\mathcal{M}(B) = \lambda_D(B)$. Otherwise $\lambda_d(B) = 0$ and the Minkowski content, when it exists, can be interpreted as the D-dimensional volume of B, giving a substitute of the notion of volume for non-integer dimensions. Besides this geometric relevance, the Minkowski content plays a major role in the Weyl-Berry conjecture, which is concerned with spectral asymptotics of Laplace operators on domains with irregular boundaries, see [\[Ber79,](#page-23-7) [Ber80,](#page-23-8) [LP93\]](#page-24-3). These are two of the reasons why the Minkowski content has attracted much attention in recent years (see e. g. [\[Kom13\]](#page-24-4) for a more in depth introduction).

For defining self-conformal sets let $X \subset \mathbb{R}^d$ be a non-empty compact set with $X = \overline{\text{int}X}$. Define $\Phi := \{\phi_1, \ldots, \phi_M : X \to X\}$ to be an iterated function system (IFS) consisting of contractive conformal $\mathcal{C}^{1+\alpha}$ -diffeomorphisms ϕ_i with $M \geq 2$, $\alpha \in (0,1)$. Let F be the unique compact non-empty set satisfying $F = \bigcup_{i=1}^{M} \phi_i F$. It exists due to [\[Hut81\]](#page-23-9) and is called the *self-conformal set* associated with Φ . F is called self-similar in the special case of ϕ_i being similitudes, i.e. if $\|\phi_i(x) - \phi_i(y)\|_2 = c_i \|x - y\|_2$ for all $x, y \in X$ and $i \in \{1, \ldots, M\} =: \Sigma$ with $c_i \in (0, 1)$. Self-conformal sets provide prominent examples of fractal sets, see Ex. [1.1](#page-5-0) and Fig. [1.](#page-3-0)

Next, we explain how to obtain the asymptotic behaviour of $\lambda_d(F_{e^{-t}})$ as $t \to \infty$. Assume that Φ satisfies the open set condition (OSC), i.e. there exists a *feasible open set* $O \subset X$, which is non-empty and which satisfies $\phi_iO\subset O$ and $\phi_iO\cap\phi_jO=\varnothing$ for $i\neq j\in\Sigma$. Assume w.l. o. g. that O is bounded. For $\omega=\omega_1\cdots\omega_n\in\Sigma^n$ write $\phi_\omega := \phi_{\omega_1} \circ \cdots \circ \phi_{\omega_n}$. Set $\Gamma := O \setminus \bigcup_{i=1}^M \phi_i O, \Phi \Gamma := \bigcup_{i=1}^M \phi_i \Gamma$ and note that

(1.4)
$$
O = \bigcup_{n=0}^{\infty} \bigcup_{u \in \Sigma^n} \phi_u \Gamma \cup \bigcap_{n=0}^{\infty} \Phi^n O,
$$

where the unions are disjoint. For the sets from Fig. [1](#page-3-0) examples of sets O, with associated sets Φ O and Γ are depicted in Fig. [2.](#page-4-0) We have $\Phi\left(\overline{\bigcap_{n=0}^{\infty} \Phi^n O}\right) = \overline{\bigcap_{n=0}^{\infty} \Phi^n O}$. Thus, $\overline{\bigcap_{n=0}^{\infty} \Phi^n O}$ is either empty or coincides with F by uniqueness of the self-conformal set. Therefore, $\lambda_d \left(\bigcap_{n=0}^{\infty} \Phi^n O \right) \leq \lambda_d(F)$. Let D denote the Minkowski dimension of F. If $D < d$ then $\lambda_d(F) = 0$ and whence $\lambda_d(\bigcap_{n=0}^{\infty} \Phi^n O) = 0$. In the following we assume that O can be chosen so that $\lambda_d(F_{e^{-t}} \cap \Gamma) \in o(e^{t(D-d)})$ with the little Landau symbol \mathfrak{o} . This is a mild condition, which is always satisfied for self-similar systems with any feasible open set O (see [\[Win15\]](#page-24-5)). Then

 (1.4) implies for $D < d$ that

$$
\lambda_d(F_{e^{-t}} \cap O) = \sum_{n=0}^{\infty} \sum_{u \in \Sigma^n} \lambda_d(F_{e^{-t}} \cap \phi_u \Gamma)
$$

=
$$
\sum_{\omega \in \Sigma^m} \sum_{n=0}^{\infty} \sum_{u \in \Sigma^n} \lambda_d(F_{e^{-t}} \cap \phi_u \phi_\omega \Gamma) + \mathfrak{o}(e^{t(D-d)})
$$

for any $m \in \mathbb{N}$. Further, suppose $\lambda_d(F_{e^{-t}} \cap \phi_u \phi_\omega \Gamma) = \lambda_d((\phi_u F)_{e^{-t}} \cap \phi_u \phi_\omega \Gamma)$. By [\[Win15\]](#page-24-5), for self-similar systems this assumption always holds true for some feasible open set O . (The open sets O of Fig. [2](#page-4-0) satisfy the above conditions, see Ex. [1.1.](#page-5-0)) If m is large then $\phi_\omega \Gamma$ is small, as each ϕ_i is strictly contracting. Since conformal maps locally behave like similarities and λ_d is homogeneous of degree d, we can approximate $\lambda_d((\phi_u F)_{e^{-t}} \cap \phi_u \phi_\omega \Gamma)$ by

(1.5)
$$
|\phi_u'(\pi \sigma \omega x)|^d \lambda_d (F_{e^{-t}/|\phi_u'(\pi \sigma \omega x)|} \cap \phi_\omega \Gamma)
$$

with an arbitrary $x \in \Sigma^{\mathbb{N}}$. Here, σ is the shift-map as before and $\pi \colon \Sigma^{\mathbb{N}} \to F$ is the *code map* defined by $\{\pi(\omega)\} := \bigcap_{n=0}^{\infty} \phi_{\omega|n}(X)$, where $\omega|_n := \omega_1 \cdots \omega_n$ is defined to be the *subpath* of length n of ω . In order to bring [\(1.5\)](#page-4-1) into a form to apply the renewal theorem we define $\xi \colon \Sigma^{\mathbb{N}} \to \mathbb{R}$ by

$$
\xi(\omega):=-\log\lvert \phi_{\omega_1}'(\pi\sigma\omega)\rvert.
$$

The function ξ is called the *geometric potential function* associated with the IFS Φ . It carries important geometric information of Φ and F. By definition $\exp(-S_n\xi(u\omega x)) = |\phi'_u(\pi\sigma\omega x)|$. Thus, $\lambda_d(F_{e^{-t}} \cap O)$ can be approximated by

$$
\sum_{e \in \Sigma^m} \sum_{n=0}^{\infty} \sum_{u \in \Sigma^n} e^{-dS_n \xi(u\omega x)} \lambda_d(F_{e^{-t+S_n \xi(u\omega x)}} \cap \phi_\omega \Gamma) + \mathfrak{o}(e^{t(D-d)}).
$$

Setting $f_y(t) := \lambda_d(F_{e^{-t}} \cap \phi_\omega \Gamma)$ for $y \in \Sigma^{\mathbb{N}}, \chi := 1_{\Sigma^{\mathbb{N}}}, \eta := -d\xi$ and assuming the regularity conditions of Sec. [3.1,](#page-7-0) we can apply the renewal theorem with dependent interarrival times (Thm. [3.2\)](#page-8-0) and, if ξ is non-lattice, obtain

$$
\sum_{n=0}^{\infty} \sum_{u \in \Sigma^n} e^{-dS_n\xi(u\omega x)} \lambda_d(F_{e^{-t+S_n\xi(u\omega x)}} \cap \phi_\omega \Gamma) = N(t, \omega x)
$$

$$
\sim e^{t\delta} \frac{h_{-(d+\delta)\xi}(\omega x)}{\int \xi d\mu_{-(d+\delta)\xi}} \int_{-\infty}^{\infty} e^{-T\delta} \lambda_d(F_{e^{-T}} \cap \phi_\omega \Gamma) dT,
$$

where $\delta > 0$ is the unique value for which $P(-(d+\delta)\xi) = 0$. Here, P denotes the topological pressure function, see [\(2.2\)](#page-7-2) and Prop. [2.4.](#page-7-3) It is proven in [\[Bed88\]](#page-23-10) that the Minkowski dimension D of F is the unique solution to $P(-D\xi) = 0$ thus, $d + \delta = D$. Using approximation arguments (based on bounded distortion properties of Φ) we all in all obtain, in the non-lattice situation, that

$$
\lambda_d(F_{\mathrm{e}^{-t}}\cap O)\sim \mathrm{e}^{t(D-d)}\lim_{m\to\infty}\!\!\!\!\!\!\!\sum_{\omega\in\Sigma^m}\frac{h_{-D\xi}(\omega x)}{\int \xi\mathrm{d\mu}_{-D\xi}}\int_{-\infty}^\infty\!\!\!\!\!\mathrm{e}^{-T(D-d)}\lambda_d(F_{\mathrm{e}^{-T}}\cap\phi_\omega\Gamma)\mathrm{d}T.
$$

This shows that ξ being non-lattice implies existence of the Minkowski content which can be determined explicitly. The lattice and the average cases can be treated similarly.

In the special case that F is self-similar, the approximation arguments are not needed and we can assume $m = 0$. Further, $h_{-D\xi} = \mathbb{1}_{\Sigma_A}$ and ξ is constant on cylinder sets of length one, taking the values $-\log(r_i)$ with $r_i := ||\phi'_i||_{\infty}$ and $\mu_{-D\xi}([i]) = r_i^D$, where $||\cdot||_{\infty}$ denotes the supremum-norm. Therefore, for self-similar sets F we obtain

$$
\lambda_d(F_{e^{-t}} \cap O) \sim e^{t(D-d)} \frac{1}{-\sum_{i=1}^M \log(r_i) r_i^D} \int_{-\infty}^{\infty} e^{-T(D-d)} \lambda_d(F_{e^{-T}} \cap \Gamma) dT
$$

if ξ is non-lattice. If ξ is lattice then the respective formula is more involved but we can deduce from part [\(iii\)](#page-2-1) of the renewal theorem for dependent interarrival times (Thm. [3.2\)](#page-8-0) that

(1.6)
$$
\lim_{t \to \infty} t^{-1} \int_0^t e^{-T(D-d)} \lambda_d(F_{e^{-t}} \cap O) dT = \frac{\int_{-\infty}^{\infty} e^{-T(D-d)} \lambda_d(F_{e^{-T}} \cap \Gamma) dT}{-\sum_{i=1}^M \log(r_i) r_i^D}.
$$

Example 1.1. The following self-conformal sets are depicted in Figs. [1](#page-3-0) and [2.](#page-4-0) We will discuss the Minkowski content for the first set [\(A\)](#page-3-0) and restrict ourselves to the definitions and verification of the main conditions for [\(B\)](#page-3-0) and [\(C\).](#page-3-0) In all the examples, $d = 2$.

(a) The Sierpinski gasket F is the self-similar set associated with the IFS $\Phi := \{\phi_1, \phi_2, \phi_3 : \mathbb{R}^2 \to \mathbb{R}^2\}$ given by $\phi_1(x) = x/2$, $\phi_2(x) = x/2 + (1/2, 0)$ and $\phi_3(x) = x/2 + (1/4, \sqrt{3}/4)$. Its Minkowski dimension is $D = \log(3)/\log(2)$. The open triangle O with vertices $(0,0)$, $(1,0)$, $(1/2,\sqrt{3}/2)$ is a feasible open set for Φ . The set Γ is the equilateral triangle with vertices $(1/2,0)$, $(1/4,\sqrt{3}/4)$, $(3/4, \sqrt{3}/4)$, and

$$
\lambda_2(F_{e^{-t}} \cap \Gamma) = \begin{cases} \frac{3}{2}e^{-t} - 3\sqrt{3}e^{-2t} & : t > -\log(\sqrt{3}/12) \\ \frac{\sqrt{3}}{16} & : t \le -\log(\sqrt{3}/12). \end{cases}
$$

Thus, $\lambda_2(F_{e^{-t}} \cap \Gamma) \in \mathfrak{o}(e^{t(D-2)})$. We have $r_i := ||\phi'_i||_{\infty} = 1/2$ for $i \in \{1, 2, 3\}$. Hence, the system is lattice and [\(1.6\)](#page-5-1) yields that

$$
\lim_{t \to \infty} t^{-1} \int_0^t e^{-T(D-2)} \lambda_2(F_{e^{-T}} \cap O) dT
$$

= $\frac{\sqrt{3}^{-(D+1)}}{\log(2)} \left[\frac{1}{2-D} + \frac{2}{D-1} - \frac{1}{D} \right] \approx 1.8126.$

(b) The set F depicted in Fig. $1(B)$ is the image of the Sierpinski gasket under the complex Möbius The set *F* depicted in Fig. 1(B) is
transform $g_1: \mathbb{C} \to \mathbb{C}, z \mapsto -iz/(\sqrt{\pi i})$ $3z -$ √ $\overline{3} - i$. An associated IFS is $\{g_1 \circ \phi_i \circ g_1^{-1} \mid i \in \{1, 2, 3\}\}\$ with ϕ_1, ϕ_2, ϕ_3 as in [\(a\).](#page-5-2) The maps $g_1 \circ \phi_i \circ g_1^{-1}$ are contractive conformal $\mathcal{C}^{1+\alpha}$ -diffeomorphisms, but not similitudes. Indeed, F is self-conformal but not self-similar. It is known that the Minkowski

dimension is stable under bi-Lipschitz maps, see [\[Fal03,](#page-23-6) Ch. 3.2]. Thus, $D = \log(3)/\log(2)$. Since $\partial \Gamma \subseteq F$ is one-dimensional we have that $\lambda_2(F_{e^{-t}} \cap \Gamma) \in \mathfrak{O}(e^{-t})$ with the big Landau symbol $\mathfrak{O},$ whence $\lambda_2(F_{e^{-t}} \cap \Gamma) \in \mathfrak{o}(e^{t(D-d)})$.

(c) In Fig. [1\(C\)](#page-3-0) the image of the Sierpinski gasket under the complex Möbius transform $g_2: \mathbb{C} \to \mathbb{C}$, $z \mapsto (1 - \sqrt{3}i)z/((12 + 10\sqrt{3}i)z - 11 - 11\sqrt{3}i)$ is depicted. Analogous to [\(B\)](#page-3-0) an associated IFS is given by $\{g_2 \circ \phi_i \circ g_2^{-1} \mid i \in \{1, 2, 3\}\}\$ and $\lambda_2(F_{e^{-t}} \cap \Gamma) \in \mathfrak{O}(e^{-t})$.

A special case of the renewal theorems from the present article and of the above-stated geometric results is presented in the author's doctorate thesis [\[Kom11\]](#page-24-6). The setting of self-similar sets has been studied e. g. in [\[LvF06,](#page-24-7) [Fal95,](#page-23-11) [Gat00,](#page-23-12) [Win15\]](#page-24-5). Self-conformal subsets of $\mathbb R$ and limit sets of graph-directed systems in $\mathbb R$, including Fuchsian groups of Schottky type, are treated in [\[KK12\]](#page-23-13) and [\[KK15\]](#page-24-8), where results of [\[Lal89\]](#page-24-1) were applied. However, the setting of [\[Lal89\]](#page-24-1) is too restrictive for higher dimensional Euclidean spaces \mathbb{R}^d , making necessary the renewal theorems developed in the present article.

1.3. Organisation of the article. This article is organised as follows. In Sec. [2](#page-6-3) we introduce the relevant notions from Perron-Frobenius theory, which appear in the statements of the main theorems. Sec. [3](#page-7-4) is broken down into two parts. Sec. [3.1](#page-7-0) is devoted to the presentation of the main results (Thms. [3.2](#page-8-0) and [3.3\)](#page-9-1) and in Sec. [3.2](#page-9-0) several corollaries are provided, demonstrating that the key renewal theorem for discrete measures, Lalley's renewal theorem and certain Markov renewal theorems can be recovered from our main theorems. Finally, in Sec. [4](#page-12-0) we provide the proofs of Thms. [3.2](#page-8-0) and [3.3.](#page-9-1)

2. Ruelle-Perron-Frobenius Theory – the equilibrium distribution

Here, we assemble preliminaries and fix notation. References for the exposition below are [\[Bow08,](#page-23-5) [Wal82\]](#page-24-9).

2.1. Subshifts of finite type – Admissible paths of a random walk through Σ . We call (Σ_A, σ) a subshift of finite type or topological Markov chain, since the transition rule only takes the present position into account and not the past. If all entries of A are ones, then $\Sigma_A = \Sigma^{\mathbb{N}}$ and (Σ_A, σ) is called the full shift on M symbols. The set of *admissible words of length* $n \in \mathbb{N}$ is defined by

(2.1)
$$
\Sigma_A^n := \{ \omega \in \Sigma^n \mid A(\omega_k, \omega_{k+1}) = 1 \text{ for } k \leq n-1 \}.
$$

If ω has infinite length or length $m \geq n$ we define $\omega|_n := \omega_1 \cdots \omega_n$ to be the subpath of length n. Further, $[\omega] := \{u_1 u_2 \cdots \in \Sigma_A \mid u_i = \omega_i \text{ for } i \leq n\}$ is the ω -cylinder set for $\omega \in \Sigma_A^n$.

2.2. Continuous and Hölder-continuous functions. Equip $\Sigma^{\mathbb{N}}$ with the product topology of the discrete topologies on Σ and equip $\Sigma_A \subset \Sigma^{\mathbb{N}}$ with the subspace topology, i.e. the weakest topology with respect to which the canonical projections onto the coordinates are continuous. The spaces of continuous complex- and real-valued functions on Σ_A are respectively denoted by $\mathcal{C}(\Sigma_A)$ and $\mathcal{C}(\Sigma_A, \mathbb{R})$. Elements of $\mathcal{C}(\Sigma_A, \mathbb{R})$ are called potential functions.

Definition 2.1. For $\xi \in \mathcal{C}(\Sigma_A)$, $\alpha \in (0,1)$ and $n \in \mathbb{N}_0$ define

$$
\operatorname{var}_n(\xi) := \sup \{ |\xi(\omega) - \xi(u)| \mid \omega, u \in \Sigma_A \text{ and } \omega_i = u_i \text{ for all } i \in \{1, ..., n\} \},
$$

$$
|\xi|_{\alpha} := \sup_{n \ge 0} \frac{\operatorname{var}_n(\xi)}{\alpha^n},
$$

$$
\mathcal{F}_{\alpha}(\Sigma_A) := \{ \xi \in \mathcal{C}(\Sigma_A) \mid |\xi|_{\alpha} < \infty \} \text{ and } \mathcal{F}_{\alpha}(\Sigma_A, \mathbb{R}) := \mathcal{F}_{\alpha}(\Sigma_A) \cap \mathcal{C}(\Sigma_A, \mathbb{R}).
$$

Elements of $\mathcal{F}_{\alpha}(\Sigma_A)$ are called α -Hölder continuous functions on Σ_A .

Definition 2.2. Functions $\xi_1, \xi_2 \in \mathcal{C}(\Sigma_A)$ are called *co-homologous*, if there exists $\psi \in \mathcal{C}(\Sigma_A)$ such that $\xi_1 - \xi_2 = \psi - \psi \circ \sigma$. A function $\xi \in \mathcal{C}(\Sigma_A, \mathbb{R})$ is said to be *lattice*, if it is co-homologous to a function whose range is contained in a discrete subgroup of R. Otherwise, we say that ξ is non-lattice.

Remark 2.3. $S_n\xi$ being strictly positive for some $n \in \mathbb{N}$ is equivalent to ξ being co-homologous to a strictly positive function ζ . To see this, note that $\zeta, \xi \in \mathcal{C}(\Sigma_A, \mathbb{R})$ are co-homologous if and only if $\widetilde{S}_m\zeta(x) = S_m\xi(x)$ for all $m \in \mathbb{N}$ and $x \in \Sigma_A$ with $\sigma^m x = x$. First, suppose that $S_n \xi$ is strictly positive. Let $\zeta := S_n \xi/n$. Then $S_m\xi(x) = S_m\zeta(x)$ for all $x \in \Sigma_A$ with $\sigma^m x = x$. Second, suppose that $\xi = \zeta + \psi - \psi \circ \sigma$ for some $\psi \in C(\Sigma_A, \mathbb{R})$ and ζ satisfying $\zeta \geq \varepsilon > 0$ for all $x \in \Sigma_A$. Then $S_m \xi(x) = S_m \zeta(x) + \psi(x) - \psi \circ \sigma^{m+1}(x) \geq m\varepsilon + \text{var}_0(\psi) > 0$ for sufficiently large $m \in \mathbb{N}$.

2.3. Topological pressure function and Gibbs measures. The topological pressure function $P: \mathcal{C}(\Sigma_A, \mathbb{R}) \to \mathbb{R}$ is given by the well-defined limit

(2.2)
$$
P(\xi) := \lim_{n \to \infty} n^{-1} \log \sum_{\omega \in \Sigma_A^n} \exp \sup_{u \in [\omega]} S_n \xi(u).
$$

Proposition 2.4. Let $\xi, \eta \in \mathcal{C}(\Sigma_A, \mathbb{R})$ be so that $S_n\xi$ is strictly positive on Σ_A , for some $n \in \mathbb{N}$. Then $s \mapsto P(\eta + s\xi)$ is continuous, strictly monotonically increasing and convex with $\lim_{s\to -\infty} P(\eta + s\xi) = -\infty$ and $\lim_{s\to\infty} P(\eta + s\xi) = \infty$. Hence, there is a unique $\delta \in \mathbb{R}$ for which $P(\eta - \delta \xi) = 0$.

A finite Borel measure μ on Σ_A is said to be a *Gibbs measure* for $\xi \in \mathcal{C}(\Sigma_A, \mathbb{R})$ if there exists a constant $c > 0$ such that

(2.3)
$$
c^{-1} \leq \frac{\mu([\omega|_n])}{\exp(S_n\xi(\omega) - n \cdot P(\xi))} \leq c
$$

for every $\omega \in \Sigma_A$ and $n \in \mathbb{N}$.

2.4. Ruelle's Perron-Frobenius theorem. By [\[Wal01,](#page-24-2) Thm. 2.16, Cor. 2.17] and [\[Bow08,](#page-23-5) Theorem 1.7], for each $\xi \in \mathcal{F}_{\alpha}(\Sigma_A, \mathbb{R})$, some $\alpha \in (0, 1)$, there exists a unique Borel probability measure ν_{ξ} on Σ_A satisfying $\mathcal{L}_{\xi}^* \nu_{\xi} = \gamma_{\xi} \nu_{\xi}$ for some $\gamma_{\xi} > 0$. This equation uniquely determines γ_{ξ} , which satisfies $\gamma_{\xi} = \exp(P(\xi))$ and which coincides with the spectral radius of \mathcal{L}_{ξ} . Further, there exists a unique strictly positive eigenfunction $h_{\xi} \in \mathcal{C}(\Sigma_A, \mathbb{R})$ satisfying $\mathcal{L}_{\xi} h_{\xi} = \gamma_{\xi} h_{\xi}$ and $\int h_{\xi} d\nu_{\xi} = 1$. Define μ_{ξ} by $d\mu_{\xi}/d\nu_{\xi} = h_{\xi}$. This is the unique σ-invariant Gibbs measure for the potential function ξ. Additionally, under some normalisation assumptions we have convergence of the iterates of the Ruelle-Perron-Frobenius operator to the projection onto the one-dimensional subspace generated by its eigenfunction h_{ξ} , namely

(2.4)
$$
\lim_{m \to \infty} \|\gamma_{\xi}^{-m} \mathcal{L}_{\xi}^{m} \psi - \int \psi \, d\nu_{\xi} \cdot h_{\xi}\|_{\infty} = 0 \quad \forall \ \psi \in \mathcal{C}(\Sigma_A, \mathbb{R}).
$$

Prop. [2.4](#page-7-3) and the relation $\gamma_{\xi} = \exp(P(\xi))$ imply the following.

Proposition 2.5. Let $\xi, \eta \in \mathcal{C}(\Sigma_A, \mathbb{R})$ be such that for some $n \in \mathbb{N}$ the n-th Birkhoff sum $S_n\xi$ of ξ is strictly positive on Σ_A . Then $s \mapsto \gamma_{\eta+s\xi}$ is continuous, strictly monotonically increasing, log-convex in $s \in \mathbb{R}$ with lim_{s→−∞} $\gamma_{\eta+s\xi} = 0$ and satisfies lim_{s→∞} $\gamma_{\eta+s\xi} = \infty$. The unique $\delta \in \mathbb{R}$ from Prop. [2.4](#page-7-3) is the unique $\delta \in \mathbb{R}$ for which $\gamma_{n-\delta\xi} = 1$.

Remark 2.6. In the proof of our renewal theorems, we will work with an analytic continuation of the pressure function to the complex domain and with complex Perron Frobenius theory. These complex quantities and their properties will be presented in Sec. [4.1.](#page-12-1)

3. Renewal theorems

We break this section into two parts. In Sec. [3.1](#page-7-0) we give a precise statement of the renewal theorems (Thms. [3.2](#page-8-0) and [3.3\)](#page-9-1). In Sec. [3.2,](#page-9-0) we describe how the classical key renewal theorem for finitely supported measures, Lalley's renewal theorem for counting measures, and versions of Markov renewal theorems can be recovered from the results of Sec. [3.1.](#page-7-0)

3.1. Renewal theorems with dependent interarrival times. Here, we make our assumptions on the renewal function N from [\(1.1\)](#page-1-0) more precise. We fix $x \in \Sigma_A$ and take $\alpha \in (0,1)$. Further, $\xi, \eta \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$ are so that $S_n\xi$ is strictly positive on Σ_A for some $n \in \mathbb{N}$, see also Rem. [2.3.](#page-6-1) Henceforth, we let $\delta > 0$ denote the unique real for which $\gamma_{\eta-\delta\xi}=1$ (see Prop. [2.5\)](#page-7-1). For $y \in \Sigma_A$ and $t \in \mathbb{R}$ we write

$$
f_y(t) = \chi(t) \cdot f_y(t)
$$

with non-negative but not identically zero $\chi \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$, where $f_y \colon \mathbb{R} \to \mathbb{R}$, for $y \in \Sigma_A$, needs to satisfy some regularity conditions. One of these requires equi directly Riemann integrability, a condition which is motivated by an assumption of the classical key renewal theorem (see Sec. [3.2.1\)](#page-9-2).

Definition 3.1. For a function $f: \mathbb{R} \to \mathbb{R}$, $h > 0$ and $k \in \mathbb{Z}$ set

$$
\underline{m}_k(f, h) := \inf \{ f(t) \mid (k - 1)h \le t < kh \} \quad \text{and}
$$
\n
$$
\overline{m}_k(f, h) := \sup \{ f(t) \mid (k - 1)h \le t < kh \}.
$$

The function f is called *directly Riemann integrable* (d, R, i) if for some sufficiently small $h > 0$

$$
\underline{R}(f,h):=\sum_{k\in\mathbb{Z}}h\cdot\underline{m}_k(f,h)\qquad\text{and}\qquad \overline{R}(f,h):=\sum_{k\in\mathbb{Z}}h\cdot\overline{m}_k(f,h)
$$

are finite and tend to the same limit as $h \to 0$. We call a family of functions $\{f_x : \mathbb{R} \to \mathbb{R} \mid x \in I\}$ with some index set I equi directly Riemann integrable (equi d. R. i.) if for some sufficiently small $h > 0$

$$
\underline{R}(h) := \sum_{k \in \mathbb{Z}} h \cdot \inf_{x \in I} \underline{m}_k(f_x, h) \quad \text{and} \quad \overline{R}(f, h) := \sum_{k \in \mathbb{Z}} h \cdot \sup_{x \in I} \overline{m}_k(f_x, h)
$$

are finite and tend to the same limit as $h \to 0$.

D. R. i. excludes wild oscillations of the function at infinity and is stronger than Riemann integrability. For further insights into this notion we refer the reader to [\[Fel71,](#page-23-1) Ch. XI] and [\[Asm03,](#page-23-4) Ch. B.V].

The *regularity conditions* are as follows.

(A) Lebesgue integrability. For any $x \in \Sigma_A$ the Lebesgue-integral

$$
\int_{-\infty}^{\infty} e^{-t\delta} |f_x(t)| dt
$$

exists.

(B) Boundedness of N. There exists $\mathfrak{C} > 0$ such that $e^{-t\delta}N^{abs}(t, x) \leq \mathfrak{C}$ for all $x \in \Sigma_A$ and $t \in \mathbb{R}$, where

$$
N^{\text{abs}}(t,x) := \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y) |f_y(t - S_n \xi(y))| e^{S_n \eta(y)}.
$$

(C) Exponential decay of N on the negative half-axis. There exist $\widetilde{\mathfrak{C}} > 0, s > 0$ and $t^* \in \mathbb{R}$ such that $e^{-t\delta}N^{abs}(t,x) \leq \widetilde{\mathfrak{C}}e^{st}$ for all $t \leq t^*$.

In the non-lattice situation we additionally need the following.

- (D) Non-oscillatory. The renewal function N does not oscillate wildly at infinity, in particular at least one of the following is satisfied.
	- (a) The function $t \mapsto f_x(t)$ is monotonic for any $x \in \Sigma_A$.
	- (b) The family $\{t \mapsto e^{-t\delta}|f_x(t)| \mid x \in \Sigma_A\}$ is equi d. R. i.
	- (c) The oscillation of N is small in the sense that

$$
\liminf_{\varepsilon \to 0} \limsup_{r \to \infty} \sup_{\tilde{\varepsilon} \in [0,\varepsilon]} e^{-(r-\tilde{\varepsilon})\delta} N(r-\tilde{\varepsilon},x)
$$
\n
$$
= \limsup_{\varepsilon \to 0} \liminf_{r \to \infty} \inf_{\tilde{\varepsilon} \in [0,\varepsilon]} e^{-(r-\tilde{\varepsilon})\delta} N(r-\tilde{\varepsilon},x).
$$

Note that Conditions [\(A\)](#page-8-1) to [\(D\)](#page-8-2) are a weakening of imposed assumptions of known renewal theorems. In Thm. [3.3](#page-9-1) it is for instance shown that equi d. R. i. of $\{t \mapsto e^{-t\delta}|f_x(t)| \mid x \in \Sigma_A\}$ and exponential decay of $t \mapsto e^{-t\delta}f_x(t)$ on the negative half-axis imply [\(A\)](#page-8-1) to [\(D\).](#page-8-2) The conditions (A) to [\(C\)](#page-8-3) and [\(Da\)](#page-8-4) are motivated by [\[Lal89\]](#page-24-1).

For $t \in \mathbb{R}$ we write $\lfloor t \rfloor$ for the largest integer $k \in \mathbb{Z}$ satisfying $k \leq t$. Moreover, we set $\{t\} := t - \lfloor t \rfloor \in [0, 1)$. Notice, for $t \in \mathbb{R}$ positive, $|t|$ is the integer part and $\{t\}$ is the fractional part of t.

Theorem 3.2 (Renewal theorem). Assume that $x \mapsto f_x(t)$ is α -Hölder continuous for any $t \in \mathbb{R}$ and that Conditions (A) to (C) hold.

(i) If ξ is non-lattice and [\(D\)](#page-8-2) is satisfied, then

$$
N(t,x) \sim e^{t\delta} \underbrace{\int \xi d\mu_{\eta-\delta\xi}(x)}_{=:G(x)} \int_{\Sigma_A} \chi(y) \int_{-\infty}^{\infty} e^{-T\delta} f_y(T) dT d\nu_{\eta-\delta\xi}(y)
$$

as $t \to \infty$, uniformly for $x \in \Sigma_A$.

(ii) Assume that ξ is lattice and let $\zeta, \psi \in \mathcal{C}(\Sigma_A, \mathbb{R})$ satisfy the relation

$$
\xi - \zeta = \psi - \psi \circ \sigma,
$$

where $\zeta(\Sigma_A) \subseteq a\mathbb{Z}$ for some $a > 0$. Suppose that ξ is not co-homologous to any function with values in a proper subgroup of $a\mathbb{Z}$. Then

$$
N(t,x) \sim e^{t\delta} \widetilde{G}_x(t)
$$

as $t \to \infty$, uniformly for $x \in \Sigma_A$. Here \widetilde{G}_x is periodic with period a and

$$
\widetilde{G}_x(t) := \int_{\Sigma_A} \chi(y) \sum_{l=-\infty}^{\infty} e^{-al\delta} f_y \left(al + a \left\{ \frac{t + \psi(x)}{a} \right\} - \psi(y) \right) d\nu_{\eta - \delta\zeta}(y)
$$

$$
\times e^{-a \left\{ \frac{t + \psi(x)}{a} \right\} \delta} \frac{a e^{\delta \psi(x)}}{\int \zeta d\mu_{\eta - \delta\zeta}} \cdot h_{\eta - \delta\zeta}(x).
$$

(iii) We always have

$$
\lim_{t \to \infty} t^{-1} \int_0^t e^{-T\delta} N(T, x) dT = G(x).
$$

Theorem 3.3. Assume that $x \mapsto f_x(t)$ is α -Hölder continuous for any $t \in \mathbb{R}$ and that the family $\{t \mapsto$ $e^{-t\delta}|f_x(t)| \mid x \in \Sigma_A$ is equi d. R. i. If there exist $\mathfrak{C}', s > 0$ such that $e^{-t\delta}|f_x(t)| \leq \mathfrak{C}'e^{st}$ for $t < 0$ and $x \in \Sigma_A$, then (A) to (D) are satisfied and thus the statements of Thm. [3.2](#page-8-0) all hold.

3.2. Corollaries to Thms. [3.2](#page-8-0) and [3.3.](#page-9-1) In this section we will see how established renewal theorems can be obtained as corollaries to Thms. [3.2](#page-8-0) and [3.3.](#page-9-1)

3.2.1. The key renewal theorem for finitely supported measures. Thms. [3.2](#page-8-0) and [3.3](#page-9-1) deal with renewal functions $N: \mathbb{R} \times \Sigma_A \to \mathbb{R}$. The special case of Thm. [3.3](#page-9-1) that N is independent of Σ_A gives the classical key renewal theorem:

N being independent of Σ_A can be achieved by the following assumptions. First, $\Sigma_A = \Sigma^{\mathbb{N}}$ (i.e. full shift). Second, $f_x = f$ is independent of $x \in \Sigma^{\mathbb{N}}$ implying that $z \colon \mathbb{R} \to \mathbb{R}$ with $z(t) := e^{-\delta t} f(t)$ is d. R. i. Third, $\chi = \mathbb{1}_{\Sigma_A}$. Fourth and most importantly, ξ and η are constant on cylinder sets of length one. To emphasise local constancy, write $s_u := S_n \xi(u_1 \cdots u_n \omega)$ and $p_u := \exp \left[S_n(\eta - \delta \xi)(u_1 \cdots u_n \omega) \right]$ for $u = u_1 \cdots u_n \in \Sigma^n$ and $\omega = \omega_1 \omega_2 \cdots \in \Sigma^{\mathbb{N}}$. Setting $Z(t) := e^{-\delta t} N(t)$ we obtain that

(3.1)
$$
Z(t) = \sum_{n=0}^{\infty} \sum_{\omega \in \Sigma^n} z(t - s_{\omega}) p_{\omega} \text{ and } Z(t) = \sum_{i=1}^{M} Z(t - s_i) p_i + z(t),
$$

for $t \in \mathbb{R}$. The latter equation of [\(3.1\)](#page-9-3) is the *classical renewal equation*. It is equivalent to $Z = Z \star F + z$, where F is the distribution which assigns mass p_i to s_i and where \star denotes the convolution operator. The assumption $S_n\xi > 0$ for some $n \in \mathbb{N}$ implies $s_i > 0$ for all $i \in \Sigma$. Thus, F is concentrated on $(0, \infty)$. On the other hand, any vector (s_1, \ldots, s_M) with $s_1, \ldots, s_M > 0$ determines a strictly positive function $\xi \in \mathcal{F}_\alpha(\Sigma^{\mathbb{N}}, \mathbb{R})$ via $\xi(\omega_1\omega_2\cdots) := s_{\omega_1}$. Furthermore, in the setting of Thm. [3.3,](#page-9-1) (p_1,\ldots,p_M) is a probability vector with $p_i \in (0,1)$ as

$$
0 = P(\eta - \delta \xi) = \lim_{n \to \infty} n^{-1} \log \left(\sum_{i \in \Sigma} p_i \right)^n = \log \sum_{i \in \Sigma} p_i
$$

by Prop. [2.4.](#page-7-3) Thus, F is a probability distribution. On the other hand, any probability vector (p_1, \ldots, p_M) with $p_1, \ldots, p_M \in (0, 1)$ determines $\eta \in \mathcal{F}_\alpha(\Sigma^{\mathbb{N}}, \mathbb{R})$ via $\eta(\omega_1 \omega_2 \cdots) := \log(p_{\omega_1} e^{\delta s_{\omega_1}})$.

Consequently, Thm. [3.3](#page-9-1) provides the asymptotic behaviour of Z under the assumptions that (p_1, \ldots, p_M) is a probability vector and that $s_1, \ldots, s_M > 0$. In order to present the asymptotic terms in a common form, observe that $\mathcal{L}_{\eta-\delta\xi}1=1(x)$ for any $x\in\Sigma^{\mathbb{N}}$, where $1=\mathbb{1}_{\Sigma^{\mathbb{N}}}$. Thus,

$$
h_{\eta-\delta\xi} = \mathbf{1}
$$
 and $\mu_{\eta-\delta\xi}([i]) = \nu_{\eta-\delta\xi}([i]) = p_i$,

where the last equality follows by considering the dual operator of $\mathcal{L}_{\eta-\delta\xi}$. If ξ is lattice then the range of ξ itself lies in a discrete subgroup of \mathbb{R} : If there exist $\zeta, \psi \in \mathcal{C}(\Sigma^{\mathbb{N}}, \mathbb{R})$ with $\xi - \zeta = \psi - \psi \circ \sigma$ and $\zeta(\Sigma^{\mathbb{N}}) \subset a\mathbb{Z}$

for some $a > 0$, then ξ and ζ need to coincide on $\{\omega \in \Sigma^{\mathbb{N}} \mid \omega = \sigma \omega\}$. As every cylinder set of length one contains a periodic word of period one the claim follows. Hence, we can choose $\zeta = \xi$ and ψ to be the constant zero-function. We deduced:

Corollary 3.4 (Key renewal theorem). Let (p_1, \ldots, p_M) be a probability vector with $p_i \in (0,1)$ and $s_i > 0$ $for i \in \{1, ..., M\}, M \geq 2.$ Denote by $z \colon \mathbb{R} \to \mathbb{R}$ a d. R. i. function with $z(t) \leq \mathfrak{C}'e^{st}$ for $t < 0$, some $\mathfrak{C}', s > 0$. Let $Z: \mathbb{R} \to \mathbb{R}$ be as in [\(3.1\)](#page-9-3). Then the following hold:

(i) If $\{s_1, \ldots, s_M\}$ does not lie in a discrete subgroup of R, then as $t \to \infty$

$$
Z(t) \sim \frac{1}{\sum_{i=1}^{M} p_i s_i} \int_{-\infty}^{\infty} z(T) dT.
$$

(ii) If $\{s_1, \ldots, s_M\} \subset a \cdot \mathbb{Z}$ and $a > 0$ is maximal, then as $t \to \infty$

$$
Z(t) \sim \frac{a}{\sum_{i=1}^{M} p_i s_i} \sum_{l=-\infty}^{\infty} z(al+t).
$$

(iii) We always have

$$
\lim_{t \to \infty} t^{-1} \int_0^t Z(T) dT = \frac{1}{\sum_{i=1}^M p_i s_i} \int_{-\infty}^{\infty} z(T) dT.
$$

Remark 3.5. In [\[Fel71,](#page-23-1) Ch. XI] the key renewal theorem is stated for functions z which vanish on the negative half-axis. However, note in the above corollary exponential decay of z on the negative half axis is allowed.

3.2.2. A renewal theorem for counting measures in symbolic dynamics. In [\[Lal89\]](#page-24-1) the case that η is the constant zero-function in conjunction with $f_x := 1_{[0,\infty)}$ for every $x \in \Sigma_A$ is addressed. With these restrictions, Conditions [\(A\)](#page-8-1) and [\(Da\)](#page-8-4) are immediate and [\(B\)](#page-8-5) as well as [\(C\)](#page-8-3) are shown in [\[Lal89,](#page-24-1) Lemma 8.1]. The renewal function from [\(1.1\)](#page-1-0) becomes

$$
\widetilde{N}(t,x) := \sum_{n=0}^{\infty} \sum_{y:\sigma^n y = x} \chi(y) 1\!\!1_{[0,\infty)}(t - S_n \xi(y)),
$$

which is a counting function. Thm. [3.2](#page-8-0) provides its asymptotic behaviour as $t \to \infty$, recovering [\[Lal89,](#page-24-1) Thms. 1 to 3] and yielding an exact asymptotic in the lattice situtation. Since this is not explicitely given in [\[Lal89\]](#page-24-1), we limit ourselves to the lattice case in the following corollary.

Corollary 3.6. For a fixed $\alpha \in (0,1)$, let $\xi, \chi \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$ be such that χ is non-negative but not identically zero and that there exists an $n \in \mathbb{N}$ for which $S_n \xi$ is strictly positive. Assume that ξ is lattice and let $\zeta, \psi \in \mathcal{C}(\Sigma_A)$ denote functions which satisfy $\xi - \zeta = \psi - \psi \circ \sigma$, where $\zeta(\Sigma_A) \subseteq a\mathbb{Z}$ for some $a > 0$. Suppose that ξ is not co-homologous to a function whose range lies in a proper subgroup of a $\mathbb Z$. Uniformly for all $x \in \Sigma_A$ we have, as $t \to \infty$, that

$$
\widetilde{N}(t,x) \sim \frac{ah_{-\delta\zeta}(x)\int \chi(y)e^{\delta a\left[\frac{t}{a}-\frac{\psi(y)-\psi(x)}{a}\right]}d\nu_{-\delta\zeta}(y)}{(1-e^{-\delta a})\int \zeta d\mu_{-\delta\zeta}}.
$$

3.2.3. A Markov renewal theorem. If we assume that η and ξ are constant on cylinder sets of length two, then the point process with interarrival times W_0, W_1, \ldots becomes a Markov random walk: To see this, define $\widetilde{\eta}, \widetilde{\xi} \colon \Sigma_A^2 \to \mathbb{R}$ by $\widetilde{\eta}(ij) := \eta(ij\omega)$ and $\widetilde{\xi}(ij) := \xi(ij\omega)$ for any $\omega \in \Sigma_A$ for which $ij\omega \in \Sigma_A$. Then

$$
\mathbb{P}(X_1 = i \mid X_0 X_{-1} \cdots = x) = e^{\eta(ix)} = e^{\tilde{\eta}(ix_1)} = \mathbb{P}(X_1 = i \mid X_0 = x_1).
$$

Thus, $(X_n)_{n\in\mathbb{Z}}$ is a Markov chain. Further, $W_n = \xi(X_{n+1}X_nX_{n-1}\cdots) = \xi(X_{n+1}X_n)$ implies that the interarrival times W_0, W_1, \ldots are Markov dependent on $(X_n)_{n \in \mathbb{Z}}$. Applying Thms. [3.2](#page-8-0) and [3.3](#page-9-1) to such Markov random walks gives a *Markov renewal theorem*. In order to state it in a common form we present several simplifications and conversions in the following.

Under the current assumptions, the analogue of the transition kernel U from the introduction becomes a transition kernel $\tilde{U}: \Sigma \times (\mathcal{P}(\Sigma) \otimes \mathcal{B}(\mathbb{R})) \to \mathbb{R}$,

$$
\widetilde{U}(i, \{j\} \times (-\infty, t]) := \mathbb{P}(X_{n+1} = j, W_n \le t \mid X_n = i)
$$

$$
= \begin{cases} \mathbb{1}_{(-\infty, t]}(\widetilde{\xi}(ji)) e^{\widetilde{\eta}(ji)} & \colon ji \in \Sigma_A^2 \\ 0 & \colon \text{otherwise.} \end{cases}
$$

Set $\widetilde{F}_{ij}(t) := \widetilde{U}(i, \{j\} \times (-\infty, t])$ and define $F := (\widetilde{F}_{ij})_{i,j \in \Sigma}$ to be the matrix with entries $F_{ij} := ||\widetilde{F}_{ij}||_{\infty} =$ $\exp(\tilde{\eta}(ji))1_{\Sigma_4^2}(ji)$. Then, F is primitive if and only if A is primitive. Moreover, \tilde{F}_{ij} is a distribution function of a distribution function function is called lettice if its set of discontinuities lies in a di of a discrete measure. A distribution function is called *lattice* if its set of discontinuities lies in a discrete subgroup of R. Otherwise, it is called *non-lattice*. Thus, F_{ij} is lattice if and only if ξ is lattice. For $s \in \mathbb{R}$ and $i, j \in \Sigma$ we have

$$
B_{ij}(s) := \int e^{sT} \widetilde{F}_{ij}(\mathrm{d}T) = \begin{cases} \exp(\widetilde{\eta}(ji) + s\widetilde{\xi}(ji)) & : ji \in \Sigma_A^2 \\ 0 & : \text{otherwise.} \end{cases}
$$

Setting $B(s) := (B_{ij}(s))_{i,j \in \Sigma}$ we see that the action of $B(s)$ on vectors coincides with the action of the Ruelle-Perron-Frobenius operator $\mathcal{L}_{\eta+s\xi}$ on functions $g: \Sigma_A \to \mathbb{R}$ which are constant on cylinder sets of length one. That is, setting $\tilde{g}_i := g(ix)$, for $x \in \Sigma_A$ with $ix \in \Sigma_A$, gives

$$
\mathcal{L}_{\eta+s\xi}g(ix) = \sum_{j\in\Sigma, \, j\in\Sigma_A^2} e^{\widetilde{\eta}(ji) + s\widetilde{\xi}(ji)}\widetilde{g}_j = \sum_{j\in\Sigma} B_{ij}(s)\widetilde{g}_j = (B(s)\widetilde{g})_i.
$$

By the Perron-Frobenius theorem for matrices there is a unique s for which $B(s)$ has spectral radius one. By the above this value coincides with the unique s for which $\mathcal{L}_{\eta+s\xi}$ has spectral radius one, which we denoted by δ in Prop. [2.5.](#page-7-1) Similarly, $h_{\eta-\delta\xi}$ is constant on cylinder sets of length one. Thus, setting $h_i := h_{\eta-\delta\xi}(ix)$ for $x \in \Sigma_A$ with $ix \in \Sigma_A$ we obtain a vector $(h_i)_{i \in \Sigma}$ with strictly positive entries which satisfies $B(-\delta)h = h$, since

$$
(B(-\delta)h)_i = \mathcal{L}_{\eta-\delta\xi}h_{\eta-\delta\xi}(ix) = h_{\eta-\delta\xi}(ix) = h_i.
$$

Moreover, the vector ν given by $\nu_i := \nu_{\eta-\delta\xi}([i])$ satisfies $\nu_i > 0$ for all $i \in \Sigma$ and $\nu B(-\delta) = \nu$, since $\mathcal{L}_{\eta-\delta\xi}^* \nu_{\eta-\delta\xi} = \nu_{\eta-\delta\xi}$. By the Perron-Frobenius theorem h and ν are unique with these properties. Additionally assuming $\chi = \mathbb{1}_{\Sigma_A}$ and that f_x only depends on the first letter of $x \in \Sigma_A$ it follows that $N(t, x)$ only depends on the first letter of x. Thus, for $i \in \Sigma$ write $N(t, i) := N(t, ix)$ with $x \in \Sigma_A$ for which $ix \in \Sigma_A$. Now, the renewal equation becomes

(3.2)
\n
$$
N(t,i) = \sum_{j \in \Sigma, \ j i \in \Sigma_A^2} N(t - \tilde{\xi}(ji), j) e^{\tilde{\eta}(ji)} + f_i(t)
$$
\n
$$
= \sum_{j \in \Sigma} \int_{-\infty}^{\infty} N(t - u, j) \tilde{F}_{ij}(\mathrm{d}u) + f_i(t),
$$

for $i \in \Sigma$, where $f_i(t) := f_{ix}(t)$ for $x \in \Sigma_A$ with $ix \in \Sigma_A$. The system of equations given in [\(3.2\)](#page-11-0) for varying $i \in \Sigma$ is called a Markov renewal equation, multivariate renewal equation or system of coupled renewal equations.

Corollary 3.7 (A Markov renewal theorem). Let $M \geq 2$ be an integer. For $i \in \{1, ..., M\}$ let $f_i : \mathbb{R} \to \mathbb{R}$ denote d. R. i. functions. Suppose that there exist $\mathfrak{C}', s > 0$ such that $e^{-\delta t} |f_i(t)| \leq \mathfrak{C}' e^{st}$ for $t < 0$ and $i \in \{1,\ldots,M\}$. Let $\widetilde{F}_{ij}(t)$ be as above and suppose that $F := (\|\widetilde{F}_{ij}\|_{\infty})_{i,j\in\Sigma}$ is primitive. Let $\delta > 0$ denote the unique positive real number for which the matrix $B(-\delta)$ given by $B_{ij}(-\delta) := \int e^{-\delta u} \widetilde{F}_{ij}(du)$ has spectral radius one. Choose vectors ν , h with $\nu B(-\delta) = \nu$, $B(-\delta)h = h$ and $\nu_i, h_i > 0$ for $i \in \Sigma$. Let $N(t, i)$ for $i \in \Sigma$ solve the Markov renewal equation [\(3.2\)](#page-11-0).

(i) If \tilde{F}_{ij} is non-lattice, then

$$
e^{-\delta t} N(t, i) \sim \frac{h_i \sum_{j=1}^M \nu_j \int e^{-\delta T} f_j(T) dT}{\sum_{k,j=1}^M \nu_k h_j \int T e^{-\delta T} F_{kj}(dT)} =: G(i).
$$

(ii) We always have

$$
\lim_{t \to \infty} t^{-1} \int_0^t e^{-T\delta} N(T, i) dT = G(i).
$$

A statement for the lattice situation can likewise be deduced from Thm. [3.3.](#page-9-1)

Remark 3.8. The above theorem is presented in a similar form in [\[Asm03,](#page-23-4) Thm. 4.6]. There, the matrix F is required to be irreducible instead of primitive and the function ξ , which F_{ij} depends on, can be a random variable. On the other hand, each f_i is required to be zero on the half-line $(-\infty, 0)$ whereas here, we allow exponential decay on the negative axis. More general versions of Markov renewal theorems can be found in the literature (see e. g. [\[Als91\]](#page-23-3)).

4. Proofs of the renewal theorems and their corollaries

In Sec. [4.1](#page-12-1) we present essentials from complex Ruelle-Perron-Frobenius theory. These are used to prove the renewal theorems in Sec. [4.2.](#page-13-0)

4.1. Analytic Properties of the Ruelle-Perron-Frobenius Operator. We study analytic properties of the operator-valued function $z \mapsto (I - \mathcal{L}_{\eta + z\xi})^{-1}$, where $\xi, \eta \in \mathcal{F}_{\alpha}(\Sigma_A, \mathbb{R})$ are fixed and $z \in \mathbb{C}$. Below, we collect results from [\[Pol84,](#page-24-10) [Lal89,](#page-24-1) [PP90\]](#page-24-11).

Let $\mathcal{B}(\mathcal{F}_{\alpha}(\Sigma_A))$ denote the set of all bounded linear operators on $\mathcal{F}_{\alpha}(\Sigma_A)$ to $\mathcal{F}_{\alpha}(\Sigma_A)$. Since $\mathcal{F}_{\alpha}(\Sigma_A)$ endowed with $\|\cdot\|_{\alpha} := |\cdot|_{\alpha}+\|\cdot\|_{\infty}$ is a Banach space, also $(\mathcal{B}(\mathcal{F}_{\alpha}(\Sigma_{A})), \|\cdot\|_{\text{op}})$ is a Banach space, [\[Kat95,](#page-23-14) p.150]. Here, $\|\cdot\|_{\text{op}}$ denotes the operator norm, given by $\|B\|_{\text{op}} := \sup_{g \in \mathcal{F}_{\alpha}(\Sigma_A), \|g\|_{\alpha}=1} \|Bg\|_{\alpha}$ for $B \in \mathcal{B}(\mathcal{F}_{\alpha}(\Sigma_A)).$ A function $f: D \to \mathcal{B}(\mathcal{F}_{\alpha}(\Sigma_A))$ defined on an open domain $D \subset \mathbb{C}$ is called *holomorphic* if, for all $z \in D$, there exists $l(z) \in \mathcal{B}(\mathcal{F}_{\alpha}(\Sigma_A))$ such that $\lim_{h\to 0} ||h^{-1}(f(z+h)-f(z)) - l(z)||_{op} = 0$. Following convention, we interchangeably use the terms holomorphic and analytic. (For more insights, see [\[Kat95\]](#page-23-14), especially Ch. III.3 and VII.1.)

For clarity we write $\varrho := \eta + z\xi$ and sometimes $\varrho(z) := \eta + z\xi$ if we want to stress dependence on z. The Ruelle-Perron-Frobenius operator $\mathcal{L}_{\varrho(z)}$ is a bounded linear operator on the Banach space $(\mathcal{F}_{\alpha}(\Sigma_A), \|\cdot\|_{\alpha})$. We write $spec(\mathcal{L}_{\rho(z)}) := {\lambda \in \mathbb{C} \mid \mathcal{L}_{\rho(z)} - \lambda I}$ is not invertible for its spectrum and $spr(\mathcal{L}_{\rho(z)})$ for its spectral radius, i.e. the radius of the smallest closed disc centred at the origin which contains $spec(\mathcal{L}_{\varrho(z)})$. By the spectral radius formula,

(4.1)
$$
\lim_{n \to \infty} \|\mathcal{L}_{\varrho(z)}^n\|_{\text{op}}^{1/n} = \text{spr}(\mathcal{L}_{\varrho(z)}).
$$

For the following statement let $\Re(z)$ and $\Im(z)$ respectively denote the real and imaginary parts of $z \in \mathbb{C}$.

Theorem 4.1 ([\[Pol84\]](#page-24-10)). Let $\alpha \in (0,1)$ and $\xi, \eta \in \mathcal{F}_{\alpha}(\Sigma_A)$. Suppose that $z \in \mathbb{C} \setminus \mathbb{R}$.

- (i) If for some $b \in \mathbb{R}$ the function $(\Im(z)\xi - b)/(2\pi)$ is co-homologous to an integer-valued function, then $e^{ib}\gamma_{\eta+\Re(z)\xi}$ is a simple eigenvalue of $\mathcal{L}_{\eta+z\xi}$, and the rest of the spectrum is contained in a disc centred at zero of radius strictly less than $\gamma_{\eta+\Re(z)\xi}$.
- (ii) Otherwise, the entire spectrum of $\mathcal{L}_{\eta+z\xi}$ is contained in a disc centred at zero of radius strictly less than $\gamma_{\eta+\Re(z)\xi}$.

Below, we present useful results that follow from [\[Lal89\]](#page-24-1) and Thm. [4.1.](#page-12-2) Note that in [\[Lal89\]](#page-24-1) only the special case that η is the constant zero-function is covered. However, the proofs work in the same way when $\eta \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$ is arbitrary. Therefore, we omit the proofs and refer the reader to the respective proofs in [\[Lal89\]](#page-24-1).

Results in regular perturbation theory [\[Kat95,](#page-23-14) Sec. 7.1 and 4.3] imply that $z \mapsto \gamma_{\varrho(z)}, z \mapsto h_{\varrho(z)}$ and $z \mapsto \nu_{\varrho(z)}$ extend to holomorphic functions in a neighbourhood of R such that $\gamma_{\varrho(z)} \neq 0$, $\mathcal{L}_{\varrho(z)} h_{\varrho(z)} = \gamma_{\varrho(z)} h_{\varrho(z)}$, $\mathcal{L}^*_{\rho(z)}\overline{\nu_{\rho(z)}} = \gamma_{\rho(z)}\nu_{\rho(z)}$ and $\nu_{\rho(z)}(h_{\rho(z)}) = \nu_0(h_{\rho(z)}) = 1$ [\[Lal89,](#page-24-1) p. 27].

Proposition 4.2 ([\[Lal89,](#page-24-1) Props. 7.1 and 7.2]). Fix $\alpha \in (0,1)$. Let $\xi, \eta \in \mathcal{F}_{\alpha}(\Sigma_A, \mathbb{R})$ and let $-\delta$ be the unique real zero of $t \mapsto P(\eta + t\xi)$. Then

(i)
$$
z \mapsto (I - \mathcal{L}_{\varrho(z)})^{-1}
$$
 is holomorphic in the half-plane $\Re(z) < -\delta$.

(ii) $z \mapsto (I - \mathcal{L}_{\varrho(z)})^{-1}$ has a simple pole at $z = -\delta$ and for $\chi \in \mathcal{F}_{\alpha}(\Sigma_A)$,

(I - \mathcal{L}_{\varrho(z)})^{-1} \chi = \gamma_{\varrho(z)} (1 - \gamma_{\varrho(z)})^{-1} \int \chi d\nu_{\varrho(z)} \cdot h_{\varrho(z)} + (I - \mathcal{L}_{\varrho(z)}'')^{-1} \chi,
$$

for z in some punctured neighbourhood of $z = -\delta$, where

$$
\mathcal{L}_{\varrho(z)}' := \mathcal{L}_{\varrho(z)} - \mathcal{L}_{\varrho(z)}' \qquad \text{with}
$$

$$
\mathcal{L}_{\varrho(z)}' \chi := \gamma_{\varrho(z)} \int \chi d\nu_{\varrho(z)} \cdot h_{\varrho(z)}.
$$
Moreover, $z \mapsto (I - \mathcal{L}_{\varrho(z)}'')^{-1}$ is a holomorphic operator-valued function in a neighbourhood of $z = -\delta$.

 $with$

The factor $\gamma_{\rho(z)}$ of the first summand of [\(4.2\)](#page-13-1) is missing in [\[Lal89\]](#page-24-1). However, the relevant z-value is $-\delta$, and $\gamma_{-\delta} = 1$.

We are interested in the residue of $z \mapsto (I - \mathcal{L}_{\varrho(z)})^{-1}$ at the simple pole $z = -\delta$. For this, we use that the topological pressure function $t \mapsto P(\eta + t\xi)$ is real-analytic for $t \in \mathbb{R}$ and real-valued $\xi, \eta \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$ and that it satisfies

(4.3)
$$
\frac{\mathrm{d}}{\mathrm{d}t}P(\eta + t\xi) = \int \xi \mathrm{d}\mu_{\eta + t\xi}, \quad t \in \mathbb{R}.
$$

The analyticity of $z \mapsto (I - \mathcal{L}_{\varrho(z)})^{-1}$ can be proved with methods of analytic perturbation theory as presented in [\[Kat95\]](#page-23-14). This method of proof is due to [\[Rue78\]](#page-24-12). Further, since $z \mapsto \gamma_{\varrho(z)}$ has an analytic continuation to a neighbourhood of R and $P(\xi) = \log(\gamma_{\xi})$ for real-valued $\xi \in C(\Sigma_A, \mathbb{R})$, we can extend P analytically by setting $P(\varrho(z)) := \log(\gamma_{\varrho(z)})$. 'Formally this definition can only be made modulo $2\pi i$ since log is multiple valued, although we shall ask that $P(\xi)$ be real-valued when ξ is real-valued' [\[PP90,](#page-24-11) p. 31]. In this way, [\(4.3\)](#page-13-2) extends to a neighbourhood of R. Combined with [\(4.3\)](#page-13-2), Prop. [4.2](#page-12-3)[\(ii\)](#page-13-3) yields the following corollary since $z \mapsto \gamma_{\varrho(z)}$, $z \mapsto \int \chi d\nu_{\varrho(z)}$ and $z \mapsto h_{\varrho(z)}$ are continuous at $z = -\delta$.

Corollary 4.3. Let $\xi \in \mathcal{C}(\Sigma_A, \mathbb{R})$ and $\chi \in \mathcal{F}_\alpha(\Sigma_A, \mathbb{R})$. Then, for $x \in \Sigma_A$, the residue of $(I - \mathcal{L}_{\eta + z\xi})^{-1}\chi(x)$ at $z = -\delta$ is

$$
-\frac{\int \chi \mathrm{d}\nu_{\eta-\delta\xi}}{\int \xi \mathrm{d}\mu_{\eta-\delta\xi}} h_{\eta-\delta\xi}(x).
$$

The residue is given in [\[Lal89,](#page-24-1) p.27]; however, with a different sign.

Proposition 4.4 ([\[Lal89,](#page-24-1) Prop. 7.3]). If ξ is non-lattice then $z \mapsto (I - \mathcal{L}_{\eta + z\xi})^{-1}$ is holomorphic in a neighbourhood of every z on the line $\mathbb{R}(z) = -\delta$ except for $z = -\delta$.

Proposition 4.5 ([\[Lal89,](#page-24-1) Prop. 7.4]). If ξ is integer-valued but not co-homologous to any function valued in a proper subgroup of the integers, then $z \mapsto (I - \mathcal{L}_{\eta + z\xi})^{-1}$ is $2\pi i$ -periodic, and holomorphic at every z on the line $\Re(z) = -\delta$ such that $\Im(z)/(2\pi)$ is not an integer.

4.2. Proof of the renewal theorems.

4.2.1. Proof of the Renewal Thm. [3.2.](#page-8-0) As the statement of Thm. [3.2](#page-8-0) suggests, we need to distinguish between the cases of ξ being lattice or non-lattice. We start with the non-lattice situation, for which we use a useful smoothing argument for showing the desired asymptotic, see [\[Lal89,](#page-24-1) pp. 29 ff.]. For a probability density $\Pi: \mathbb{R} \to \mathbb{R}$ we consider its Fourier-Laplace transform given by

\widehat{\Pi}(\mathbf{i}\theta) := \int_{-\infty}^{\infty} \mathrm{e}^{\mathbf{i}\theta t} \Pi(t) \mathrm{d}t
$$

and introduce the following class of probability densities.

 $\mathfrak{P} := \{ \Pi : \mathbb{R} \to \mathbb{R} \mid \Pi \text{ is a probability density}, \Pi(t) = \Pi(-t) \text{ for } t \in \mathbb{R}.$

 $\widehat{\Pi}(\mathbf{i}\theta)$ is non-negative, \mathcal{C}^{∞} and has compact support}

Note that the function $\widehat{\Pi} : \mathbb{R} \to \mathbb{C}$ given by

(4.4)
$$
\widehat{\Pi}(\mathbf{i}\theta) := \begin{cases} \exp\left(\frac{-\theta^2}{1-\theta^2}\right) & : |\theta| \le 1, \\ 0 & : \text{otherwise} \end{cases}
$$

defines an even probability density $\Pi: \mathbb{R} \to \mathbb{R}$ which lies in \mathfrak{P} . That Π is a probability density is due to Bochner's theorem, see e.g. [\[Kle08,](#page-24-13) Satz 15.29]. Thus, $\mathfrak{P} \neq \emptyset$. For the following, fix Π as such. As Π is an even probability density we know that for all $\varepsilon > 0$ there exists $\tau > 0$ such that

$$
\int_{-\tau}^{\tau} \Pi(t) dt \ge 1 - \varepsilon.
$$

For each $\varepsilon > 0$ fix such a $\tau = \tau(\varepsilon)$. Thus, Π_{ε} which for $\varepsilon > 0$ is defined by

Moreover, it can be verified that $\Pi_{\varepsilon} \in \mathfrak{P}$ for all $\varepsilon > 0$. The smoothing argument is as follows.

Proof. In the proof we distinguish between the different cases of [\(D\).](#page-8-2)

Case [\(Da\)](#page-8-4): Here, $N(t, x)$ is a monotonic function in t and the statement follows from the proof of [\[Lal89,](#page-24-1) Lemma 8.2].

Case [\(Dc\)](#page-8-7): For $r \in \mathbb{R}$ and $\varepsilon > 0$, Condition [\(B\)](#page-8-5) implies that

which tends to 0 as $\varepsilon \to 0$ uniformly for $x \in \Sigma_A$. Moreover, we observe that

\leq \sup_{\tilde{\varepsilon}\in[0,2\varepsilon)} e^{-(r-\tilde{\varepsilon})\delta} N(r-\tilde{\varepsilon},x).

\stackrel{(4.8)}{\leq} \liminf_{\varepsilon \searrow 0} \limsup_{r \to \infty} \sup_{\widetilde{\varepsilon} \in [0, 2\varepsilon)} e^{-(r - \widetilde{\varepsilon})\delta} N(r - \widetilde{\varepsilon}, x)
$$

and likewise that

G(x) \ge \limsup_{\varepsilon \searrow 0} \liminf_{r \to \infty} \inf_{\tilde{\varepsilon} \in [0, 2\varepsilon)} e^{-(r - \tilde{\varepsilon})\delta} N(r - \tilde{\varepsilon}, x).

Using [\(Dc\)](#page-8-7) and the inequalities

= \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y)g_y(t - S_n\xi(y))e^{S_n(\eta - \delta\xi)(y)}.

For showing that [\(4.6\)](#page-14-0) implies $\lim_{r\to\infty} e^{-r\delta} N(r, x) = G(x)$, we consider

+ \mathfrak{C}\varepsilon + \left| e^{-r\delta} N(r,x) \right| \varepsilon

\leq \left| \int_{r-2\varepsilon}^{r} \Pi_{\varepsilon}(r-\varepsilon-T) \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y) e^{S_n(\eta-\delta\xi)(y)}

\times \left[g_y(T-S_n\xi(y)) - g_y(r-S_n\xi(y)) \right] dT \right| + 2\mathfrak{C}\varepsilon

\leq \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y) e^{S_n(\eta-\delta\xi)(y)}

where for the last estimate we have used the Gibbs property [\(2.3\)](#page-7-5) of $\mu_{\eta-\delta\xi}$ with constant c. For simplicity of presentation we first treat the case that ξ is strictly positive. In this case there exists $\kappa > 0$ such that $\xi(x) \geq \kappa$ for all $x \in \Sigma_A$ since ξ is continuous and Σ_A is compact. As we will later be interested in the limiting behaviour when $\varepsilon \to 0$, we can freely assume that $4\varepsilon \leq \kappa$ and set $m := \lfloor \kappa/(2\varepsilon) \rfloor$. Note that $m \geq 2$. Let $\sigma^{-n}(x)$ denote the set of pre-images of x under σ^{n} , that is

\stackrel{(4.13)}{\leq} c \| \chi \|_{\infty} \frac{2}{\kappa} 2\varepsilon \sum_{k \in \mathbb{Z}} d^{2\varepsilon}(k \cdot 2\varepsilon) + 2 \mathfrak{C} \varepsilon.
$$

This implies that

$$
\limsup_{r \to \infty} |G(x) - e^{-r\delta} N(r, x)| \le \limsup_{\varepsilon \to 0} \left(c \| \chi \|_{\infty} 2\varepsilon \frac{2}{\kappa} \sum_{k \in \mathbb{Z}} d^{2\varepsilon} (k \cdot 2\varepsilon) + 2 \mathfrak{C} \varepsilon \right)
$$

(4.10)
(4.10) 0.

Now we treat the case that ξ is not strictly positive. By assumption there exists $n \in \mathbb{N}$ for which $S_n \xi$ is strictly positive. Since ξ is continuous and Σ_A is compact, there exists a $\tilde{\kappa} > 0$ for which $S_n \xi \geq \tilde{\kappa}$. For $l \in \mathbb{N}$ and $j \in \{0, \ldots, n-1\}$ this implies that

(4.14)
$$
S_{ln+j}\xi(x) = \sum_{i=0}^{ln+j-1} \xi(\sigma^i x) = \sum_{m=0}^{l-1} \sum_{i=mn}^{(m+1)n-1} \xi(\sigma^i x) + \sum_{i=ln}^{ln+j-1} \xi(\sigma^i x)
$$

$$
= \sum_{m=0}^{l-1} S_n \xi(\sigma^i(\sigma^{mn} x)) + \sum_{i=ln}^{ln+j-1} \xi(\sigma^i x) \ge l\tilde{\kappa} + \inf_{\substack{x \in \Sigma_A \\ 0 \le i \le n-1}} S_i \xi(x)
$$

From this we can conclude that there exists $m^* \in \mathbb{N}$ such that $S_m \xi$ is strictly positive for all $m \geq m^*$. Thus, there exists $\kappa > 0$ with $S_m \xi \geq \kappa$ for all $m \geq m^*$. In the same way as in the case that ξ is strictly positive we can show that if $y \in \sigma^{-n}(x)$ with $r - S_n \xi(y) \in I_k(\varepsilon)$ then $r - S_{n-m^*} \xi(\sigma^{m^*}y) \notin I_{k+q}(\varepsilon)$ for $q \in \{0, \ldots, \lfloor \kappa/(2\varepsilon)\rfloor - 2\}$ whenever $n \geq m^*$ and $r - S_{n+m^*} \xi(\tilde{y}) \notin I_{k-q}(\varepsilon)$ for all $q \in \{0, \ldots, \lfloor \kappa/(2\varepsilon)\rfloor - 2\}$ where $\widetilde{y} \in \sigma^{-(n+m^*)}(x)$ is such that $\sigma^{m^*}\widetilde{y} = y$. This implies that

$$
\sum_{q=0}^{\lfloor \kappa/(2\varepsilon)\rfloor-2} \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \mu_{\eta-\delta\xi}([y|_n]) \mathbb{1}_{((k+q-1)2\varepsilon,(k+q+1)2\varepsilon]}(r-S_n\xi(y)) \leq 2m^*.
$$

The remainder of the proof follows in the same way as in the case that ξ is strictly positive.

Proof of Thm. [3.2](#page-8-0)[\(i\).](#page-8-6) Inspired by [\[Lal89,](#page-24-1) Thm. 1] we consider for $x \in \Sigma_A$ the Fourier-Laplace transform of $t \mapsto e^{-t\delta} N(t, x)$ at $z \in \mathbb{C}$:

(4.15)
$$
L(z,x) := \int_{-\infty}^{\infty} e^{zT} e^{-T\delta} N(T,x) dT.
$$

Conditions [\(B\)](#page-8-5) and [\(C\)](#page-8-3) imply that $L(\cdot, x): \mathbb{C} \to \mathbb{C}$, $z \mapsto L(z, x)$ is well-defined and analytic on $\{z \in \mathbb{C} \mid \mathbb{C} \mid \mathbb{C} \mid z \neq 0\}$ $-s < \Re(z) < 0$. What is more, for small enough $\varepsilon > 0$, Conditions [\(B\)](#page-8-5) and [\(C\)](#page-8-3) imply that $L(\cdot, x)$ converges absolutely and uniformly on

$$
\{z \in \mathbb{C} \mid -s + \varepsilon \leq \Re(z) \leq -\varepsilon\}.
$$

Now, in every such region, using [\(B\)](#page-8-5) as well as the monotone and dominated convergence theorems, we obtain

$$
L(z,x) = \sum_{n=0}^{\infty} \sum_{y:\sigma^n y = x} e^{S_n(\eta + (z-\delta)\xi)(y)} \chi(y) \int_{-\infty}^{\infty} e^{(z-\delta)T} f_y(T) dT
$$

=
$$
\sum_{n=0}^{\infty} \mathcal{L}_{\eta + (z-\delta)\xi}^n \left(\chi \int_{-\infty}^{\infty} e^{(z-\delta)T} f_\cdot(T) dT \right)(x),
$$

where $f(T) \colon \Sigma_A \to \mathbb{R}$, $x \mapsto f_x(T)$. Note that Conditions [\(A\)](#page-8-1) to [\(C\)](#page-8-3) imply that $\int_{-\infty}^{\infty} e^{(z-\delta)T} f_x(T) dT$ exists if $-s < \Re(z) \leq 0$, since $\chi(x)|f_x(t)| \leq N^{\text{abs}}(t, x)$. Thus, by Thm. [4.1](#page-12-2)[\(ii\),](#page-12-4) the spectral radius formula [\(4.1\)](#page-12-5) and the fact that $\gamma_{\eta-\delta\xi} = 1$ (see Prop. [2.5\)](#page-7-1), the above series converges for $-s < \Re(z) < 0$, and we obtain

$$
L(z,x) = (I - \mathcal{L}_{\eta + (z-\delta)\xi})^{-1} \left(\chi \int_{-\infty}^{\infty} e^{(z-\delta)T} f_{\cdot}(T) dT \right)(x).
$$

By Prop. [4.4,](#page-13-4) the operator-valued function $z \mapsto (I - \mathcal{L}_{\eta + (z - \delta)\xi})^{-1}$ is holomorphic at every z on the line $\Re(z) = 0$ except for $z = 0$, which is a simple pole by Prop. [4.2.](#page-12-3) Thus, according to Cor. [4.3](#page-13-5) the residue of $z \mapsto L(z, x)$ at $z = 0$ is

(4.16)
$$
- \frac{\int_{\Sigma_A} \chi(y) \int_{-\infty}^{\infty} e^{-T\delta} f_y(T) dT d\nu_{\eta-\delta\xi}(y)}{\int \xi d\mu_{\eta-\delta\xi}} h_{\eta-\delta\xi}(x) = -G(x),
$$

where G is as in Thm. [3.2](#page-8-0)[\(i\).](#page-8-6) Thus, $L(z, x)$ has the following representation.

(4.17)
$$
L(z,x) = q(z,x) - \frac{G(x)}{z},
$$

where $q(\cdot, x): \mathbb{C} \to \mathbb{C}, z \mapsto q(z, x)$ is holomorphic in a region containing the strip $\{z \in \mathbb{C} \mid -s + \varepsilon \leq \Re(z) \leq 0\}$ with sufficiently small $\varepsilon > 0$. Conditions [\(B\),](#page-8-5) [\(C\)](#page-8-3) and Lebesgue's dominated convergence theorem now imply for every $\varepsilon \in (0,1]$ that

(4.18)

$$
\int_{-\infty}^{\infty} \Pi_{\varepsilon}(r - T) e^{-T\delta} N(T, x) dT
$$

$$
= \lim_{\beta \searrow 0} \int_{-\infty}^{\infty} \Pi_{\varepsilon}(r - T) e^{-T(\delta + \beta)} N(T, x) dT.
$$

Using the inverse Fourier-Laplace transform $\Pi_{\varepsilon}(t) = \int_{-\infty}^{\infty} e^{-i\theta t} \widehat{\Pi_{\varepsilon}}(i\theta) d\theta/(2\pi)$ and that the integral on the left hand side of (4.18) exists, we can convert the integral from the right hand side of (4.18) for sufficiently small $\beta > 0$ as follows.

$$
\int_{-\infty}^{\infty} \Pi_{\varepsilon}(r-T) e^{-\beta T - T\delta} N(T, x) dT
$$
\n
$$
= \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} e^{-i\theta(r-T)} \widehat{\Pi_{\varepsilon}}(i\theta) \frac{d\theta}{2\pi} e^{-\beta T - T\delta} N(T, x) dT
$$
\n
$$
= \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} e^{(i\theta - \beta)T} e^{-T\delta} N(T, x) \widehat{\Pi_{\varepsilon}}(i\theta) e^{-i\theta r} \frac{d\theta}{2\pi} dT
$$
\n
$$
= \int_{-\infty}^{\infty} L(i\theta - \beta, x) \widehat{\Pi_{\varepsilon}}(i\theta) e^{-i\theta r} \frac{d\theta}{2\pi}
$$
\n
$$
\stackrel{(4.17)}{=} \int_{-\infty}^{\infty} \left(q(i\theta - \beta, x) + \frac{G(x)(i\theta + \beta)}{\theta^2 + \beta^2} \right) \widehat{\Pi_{\varepsilon}}(i\theta) e^{-i\theta r} \frac{d\theta}{2\pi}
$$

The measures given by $\frac{\beta}{\pi(\theta^2+\beta^2)}d\theta$ converge weakly to the Dirac point-mass at zero as $\beta \to 0$ [\[Lal89,](#page-24-1) p. 31]. Moreover, the imaginary part on the right hand side of [\(4.19\)](#page-18-2) can be ignored since the left hand side is real. Using that $\widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta)$ is real and that $\widehat{\Pi_{\varepsilon}}(0) = 1$ for all $\varepsilon \in (0,1]$, we obtain

.

(4.20)
$$
\lim_{\beta \searrow 0} \int_{-\infty}^{\infty} \Pi_{\varepsilon}(r - T) e^{-\beta T - T\delta} N(T, x) dT
$$

$$
= \Re \left(\int_{-\infty}^{\infty} q(\mathbf{i}\theta, x) \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) e^{-\mathbf{i}\theta r} \frac{d\theta}{2\pi} + \frac{G(x)}{2} + G(x) \int_{-\infty}^{\infty} \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) \frac{\mathbf{i} e^{-\mathbf{i}\theta r}}{\theta} \frac{d\theta}{2\pi} \right).
$$

We separately treat the two integrals on the right hand side of (4.20) and begin with the first one. Recall that $\widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) = \widehat{\Pi}(\mathbf{i}\theta\varepsilon/\tau(\varepsilon))$ is \mathcal{C}^{∞} and has compact support, which is contained in $[-\tau(\varepsilon)/\varepsilon, \tau(\varepsilon)/\varepsilon] = [-S, S].$ Also, recall that $q(\cdot, x)$ is analytic in a neighbourhood of $[-\textbf{i}S, \textbf{i}S]$ and continuous in x. As mentioned in [\[Lal89,](#page-24-1) p. 31f.], the Cauchy integral formula for derivatives implies that $\frac{d}{dz}q(z,x)|_{z=i\theta}$ is uniformly continuous in θ and hence bounded on $[-S, S] \times \Sigma_A$. Thus, $\frac{d}{dz}q(z, x)$ is bounded on $[-iS, iS] \times \Sigma_A$. Integration by parts now implies that

(4.21)
$$
\int_{-S}^{S} q(\mathbf{i}\theta, x) \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) e^{-\mathbf{i}\theta r} \frac{d\theta}{2\pi} \n= \mathbf{i}q(\mathbf{i}\theta, x) \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) \frac{e^{-\mathbf{i}\theta r}}{2\pi r} \Big|_{\theta=-S}^{S} + \mathbf{i} \int_{-S}^{S} \frac{d}{d\theta} \left(q(\mathbf{i}\theta, x) \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) \right) \frac{e^{-\mathbf{i}\theta r}}{2\pi r} d\theta.
$$

As the support of $\widehat{\Pi_{\varepsilon}}$ is contained in $[-\mathbf{i}S, \mathbf{i}S]$ and $\widehat{\Pi_{\varepsilon}}$ is \mathcal{C}^{∞} , the first term on the right hand side of [\(4.21\)](#page-18-4) equals zero for all $r > 0$. For the second term on the right hand side of [\(4.21\)](#page-18-4) we use that the definition of $\widehat{\Pi}$ given in [\(4.4\)](#page-13-6) and the fact that $\Pi_{\varepsilon}(\mathbf{i}\theta) = \hat{\Pi}(\mathbf{i}\theta \varepsilon/\tau(\varepsilon))$ imply that $\Pi_{\varepsilon}(\mathbf{i}\theta)$ and $\frac{d}{d\theta}\hat{\Pi}_{\varepsilon}(\mathbf{i}\theta)$ are uniformly bounded for $\varepsilon \in (0,1]$. This shows that the second term on the right hand side of [\(4.21\)](#page-18-4) converges to zero uniformly for $\varepsilon \in (0,1]$ and $x \in \Sigma_A$ as $r \to \infty$. Thus,

(4.22)
$$
\lim_{r \to \infty} \Re \left(\int_{-\infty}^{\infty} q(\mathbf{i}\theta, x) \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) e^{-\mathbf{i}\theta r} \frac{d\theta}{2\pi} \right) = 0
$$

uniformly for $x \in \Sigma_A$. Now, we consider the second integral on the right hand side of [\(4.20\)](#page-18-3):

$$
\Re\left(\int_{-\infty}^{\infty}\widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta)\frac{\mathbf{i}e^{-\mathbf{i}\theta r}}{\theta}\frac{\mathrm{d}\theta}{2\pi}\right)=\int_{-S}^{S}\widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta)\frac{\sin(\theta r)}{\theta}\frac{\mathrm{d}\theta}{2\pi}=\int_{0}^{S}\widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta)\frac{\sin(\theta r)}{\theta}\frac{\mathrm{d}\theta}{\pi}.
$$

Using the sine integral $\text{Si}(t) := \int_0^t$ $\sin(\theta)$ $\frac{\partial \mathbf{d}(\theta)}{\partial \theta}$ and $\lim_{t\to\infty}$ Si $(t) = \pi/2$ we infer that

$$
\lim_{r \to \infty} \int_0^S \frac{\sin(\theta r)}{\theta} \frac{d\theta}{\pi} = \lim_{r \to \infty} \int_0^{rS} \frac{\sin(\theta)}{\theta} \frac{d\theta}{\pi} = \lim_{r \to \infty} \text{Si}(rS)/\pi = 1/2
$$

and remark that inserting the factor $\widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta)$ in the above integrand does not change this limit, since $\widehat{\Pi_{\varepsilon}}$ is uniformly continuous and $\hat{\Pi}_{\varepsilon}(0) = 1$. Thus, for the third term on the right hand side of [\(4.20\)](#page-18-3) we obtain

(4.23)
$$
\lim_{r \to \infty} \Re \left(G(x) \int_{-\infty}^{\infty} \widehat{\Pi_{\varepsilon}}(\mathbf{i}\theta) \frac{\mathbf{i} e^{-\mathbf{i}\theta r}}{\theta} \frac{d\theta}{2\pi} \right) = \frac{G(x)}{2}
$$

uniformly for $x \in \Sigma_A$. Combining [\(4.18\)](#page-18-0), [\(4.20\)](#page-18-3), [\(4.22\)](#page-19-0) and [\(4.23\)](#page-19-1) it follows that

$$
\lim_{r \to \infty} \int_{-\infty}^{\infty} \Pi_{\varepsilon}(r - T) e^{-T\delta} N(T, x) dT = G(x)
$$

uniformly for $x \in \Sigma_A$. An application of Lem. [4.6](#page-14-3) yields the desired result.

Proof of Thm. [3.2](#page-8-0)[\(ii\).](#page-9-4) In the lattice situation we work with discrete Fourier-Laplace transforms inspired by [\[Lal89,](#page-24-1) proof of Thm. 2]. Conditions [\(B\)](#page-8-5) and [\(C\)](#page-8-3) imply that for fixed $\beta \in [0, a)$ and $x \in \Sigma_A$, the function $\widehat{N}^{\beta}(\cdot, x)$ given by

(4.24)
$$
\widehat{N}^{\beta}(z,x) := \sum_{l=-\infty}^{\infty} e^{lz} N(al + \beta - \psi(x), x)
$$

is well-defined and analytic on

$$
\mathcal{Z} := \{ z \in \mathbb{C} \mid -a(s+\delta) < \Re(z) < -a\delta \}.
$$

Note that $S_n \xi = S_n \zeta + \psi - \psi \circ \sigma^n$ and recall that $S_n \zeta \in a\mathbb{Z}$ for all $n \in \mathbb{N}$. Thus, [\(B\)](#page-8-5) and [\(C\)](#page-8-3) imply that we can make the following conversions for $z \in \mathcal{Z}$.

$$
\widehat{N}^{\beta}(z,x) = \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y) e^{S_n \eta(y)} \sum_{l=-\infty}^{\infty} e^{lz} f_y(al + \beta - \psi(x) - S_n \xi(y))
$$

\n
$$
= \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y) e^{S_n \eta(y)} \sum_{l=-\infty}^{\infty} e^{(l+a^{-1}S_n \zeta(y))z} f_y(al + \beta - \psi(y))
$$

\n
$$
= \sum_{n=0}^{\infty} \sum_{y:\sigma^n y=x} \chi(y) e^{S_n(\eta+a^{-1}z\zeta)(y)} \sum_{l=-\infty}^{\infty} e^{lz} f_y(al + \beta - \psi(y))
$$

\n
$$
= \sum_{n=0}^{\infty} \sum_{j+\sigma^n y=x} \chi(y) e^{S_n(\eta+a^{-1}z\zeta)(y)} \sum_{l=-\infty}^{\infty} e^{lz} f_y(al + \beta - \psi(y))
$$

with $f(t): \Sigma_A \to \mathbb{R}, x \mapsto f_x(t)$ as before. For $z \in \mathcal{Z}$ we have that $\Re(a^{-1}z) < -\delta$. Moreover, $h_{\eta-\delta\zeta} =$ $e^{-\delta\psi}h_{\eta-\delta\xi}$ and $\gamma_{\eta-\delta\xi}=\gamma_{\eta-\delta\xi}$. Thus, Prop. [2.5](#page-7-1) yields that $\gamma_{\eta+\Re(a^{-1}z)\zeta}<1$. Thm. [4.1](#page-12-2) (both parts) and the spectral radius formula [\(4.1\)](#page-12-5) now imply, for every $z \in \mathcal{Z}$, that

$$
\widehat{N}^{\beta}(z,x) = (I - \mathcal{L}_{\eta + a^{-1}z\zeta})^{-1} \left(\chi \sum_{l=-\infty}^{\infty} e^{lz} f.(al + \beta - \psi)\right)(x).
$$

Note that $\|\chi\sum_{l=-\infty}^{\infty} e^{iz}f(a\mathbf{l} + \beta - \psi)\|_{\infty}$ is finite for all $z \in \mathcal{Z}$ because of Conditions [\(B\)](#page-8-5) and [\(C\).](#page-8-3)

Because $a^{-1}\zeta$ is integer-valued but not co-homologous to any function valued in a proper subgroup of the integers, we can apply Prop. [4.5.](#page-13-7) Thus, $z \mapsto (I - \mathcal{L}_{\eta + a^{-1}z\zeta})^{-1}$ is $2\pi i$ -periodic and holomorphic at every z on the line $\Re(z) = -a\delta$ such that $\Im(z)/(2\pi)$ is not an integer. Therefore, $z \mapsto (I - \mathcal{L}_{\eta+a^{-1}z\zeta})^{-1}$ has an isolated singularity at $z = -a\delta$ and is holomorphic at each $z = -a\delta + i\theta$, for $0 < |\theta| \le \pi$. By Prop. [4.2](#page-12-3) the singularity of $\widehat{N}^{\beta}(z, x)$ at $z = -a\delta$ is

$$
\frac{\gamma_{\eta+a^{-1}z\zeta}}{1-\gamma_{\eta+a^{-1}z\zeta}}\underbrace{\int_{\Sigma_A}\chi(y)\sum_{l=-\infty}^\infty\mathrm{e}^{lz}f_y(al+\beta-\psi(y))\mathrm{d}\nu_{\eta+a^{-1}z\zeta}(y)h_{\eta+a^{-1}z\zeta}(x)}_{=:E_{x,\beta}(z)}
$$

Since the function $E_{x,\beta}$ is continuous at $-a\delta$, we deduce from [\(4.3\)](#page-13-2) that the singularity of $\hat{N}^{\beta}(z, x)$ at $z = -a\delta$ is a simple pole with residue

$$
C_{\beta}(x) := -\frac{a}{\int \zeta \mathrm{d}\mu_{\eta-\delta\zeta}} E_{x,\beta}(-a\delta).
$$

It follows that $\widehat{N}^{\beta}(\cdot, x) \colon \mathbb{C} \to \mathbb{C}, z \mapsto \widehat{N}^{\beta}(z, x)$ is meromorphic in

$$
\widetilde{\mathcal{Z}}(\varepsilon) := \{ z \in \mathbb{C} \mid -a(\delta + s) < \Re(z) < -a\delta + \varepsilon, \ 0 \le \Im(z) \le \pi \},
$$

for some $\varepsilon > 0$, and that the only singularity in this region is a simple pole at $-a\delta$ with residue $C_\beta(x)$. Additionally, by [\(C\)](#page-8-3)

$$
\sum_{l=-\infty}^{-1} e^{lz} N(al + \beta - \psi(x), x)
$$

is finite for $\Re(z) > -a(\delta + s)$. We conclude that there exists $\varepsilon > 0$ such that

$$
\sum_{l=0}^{\infty} e^{iz} N(al + \beta - \psi(x), x) - \frac{C_{\beta}(x)}{z + a\delta}
$$

is holomorphic in $\widetilde{\mathcal{Z}}(\varepsilon)$. Also observe that $z \mapsto (e^{z+a\delta} - 1)/(z + a\delta)$ is holomorphic in C. Making the change of variable $\tilde{z} := e^{z + a\delta}$ we obtain that

$$
\sum_{l=0}^{\infty} \tilde{z}^l e^{-al\delta} N(al + \beta - \psi(x), x) - \frac{C_{\beta}(x)}{\tilde{z} - 1}
$$

is holomorphic in $\{e^{z+a\delta} \mid z \in \tilde{Z}(\varepsilon)\}\)$. This implies that

$$
L(\widetilde{z},x) := \sum_{l=0}^{\infty} \widetilde{z}^l \left(e^{-al\delta} N(al + \beta - \psi(x), x) + C_{\beta}(x) \right)
$$

is holomorphic in $\{\tilde{z} \mid |\tilde{z}| < \epsilon^{\epsilon}\}$ (compare [\[Lal89,](#page-24-1) p. 27]). Since $\epsilon^{\epsilon} > 1$, the coefficient sequence of the power
series of $I(x, x) \in \mathbb{C} \times \mathbb{R}$ $\ell(x, x)$ converges to zero exponentially fest, more precisel series of $L(\cdot, x)$: $\mathbb{C} \to \mathbb{C}$, $z \mapsto L(z, x)$ converges to zero exponentially fast, more precisely,

$$
e^{-an\delta} N(an + \beta - \psi(x), x) + C_{\beta}(x) \in o((1 + (e^{\varepsilon} - 1)/2)^{-n})
$$

as $n \to \infty$ $(n \in \mathbb{N})$. Thus, for $x \in \Sigma_A$ we have

$$
N(t,x) = N\left(a\underbrace{\left(\frac{t+\psi(x)}{a}\right)}_{=:n} + a\underbrace{\left\{\frac{t+\psi(x)}{a}\right\}}_{=: \beta} - \psi(x), x\right)
$$

\n
$$
\sim -e^{a\left\lfloor\frac{t+\psi(x)}{a}\right\rfloor\delta}C_{a\{(t+\psi(x))/a\}}(x)
$$

\n
$$
= e^{t\delta}e^{-a\left\{\frac{t+\psi(x)}{a}\right\}\delta}e^{\delta\psi(x)}\frac{a}{\int \zeta d\mu_{\eta-\delta\zeta}}h_{\eta-\delta\zeta}(x)
$$

\n
$$
\times \int_{\Sigma_A} \chi(y) \sum_{l=-\infty}^{\infty} e^{-la\delta}f_y\left(a l + a\left\{\frac{t+\psi(x)}{a}\right\} - \psi(y)\right) d\nu_{\eta-\delta\zeta}(y)
$$

\n
$$
= e^{t\delta}\widetilde{G}_x(t)
$$

as $t \to \infty$. Since in all instances where t occurs only the fractional part is involved, it is clear that \tilde{G}_x is periodic with period a, which finishes the proof. periodic with period a, which finishes the proof.

Proof of Thm. [3.2](#page-8-0)[\(iii\).](#page-9-5) First, consider the case that ξ is non-lattice. Since $e^{-t\delta}N(t, x)$ is bounded in t by [\(B\),](#page-8-5) the result from Thm. [3.2](#page-8-0)[\(i\)](#page-8-6) implies Thm. [3.2](#page-8-0)[\(iii\).](#page-9-5)

Second, consider the case that ξ is lattice. Thm. [3.2](#page-8-0)[\(ii\)](#page-9-4) states that

e^{-t\delta} N(t,x) \sim \widetilde{G}_x(t) \text{ as } t \to \infty.

Since $e^{-t\delta}N(t, x)$ is bounded in t by [\(B\),](#page-8-5) and \tilde{G}_x is periodic with period a we have

\lim_{t \to \infty} t^{-1} \int_0^t e^{-T\delta} N(T, x) dT = \lim_{t \to \infty} t^{-1} \int_0^{a \lfloor t/a \rfloor} e^{-T\delta} N(T, x) dT
$$

= \lim_{t \to \infty} t^{-1} \int_0^{a \lfloor t/a \rfloor} \widetilde{G}_x(T) dT
$$

$$
= \lim_{t \to \infty} t^{-1} \left[\frac{t}{a} \right] \int_0^a \widetilde{G}_x(T) dT
$$

$$
= \frac{1}{a} \int_0^a \widetilde{G}_x(T) dT.
$$

The latter integral transforms as follows:

\times \int_{\Sigma_{A}} \chi(y) \sum_{l=-\infty}^{\infty} e^{-al\delta} f_{y} \left(al + a \left\{ \frac{T + \psi(x)}{a} \right\} - \psi(y) \right) d\nu_{\eta - \delta \zeta}(y) dT
$$
\n
$$
= \frac{a e^{\delta \psi(x)}}{\int \zeta d\mu_{\eta - \delta \zeta}} h_{\eta - \delta \zeta}(x) \int_{\Sigma_{A}} \chi(y)
$$
\n
$$
\times \sum_{l=-\infty}^{\infty} \int_{0}^{a} e^{-\left(al + a \left\{ \frac{T + \psi(x)}{a} \right\} \right) \delta} f_{y} \left(al + a \left\{ \frac{T + \psi(x)}{a} \right\} - \psi(y) \right) dT d\nu_{\eta - \delta \zeta}(y)
$$
\n
$$
= \frac{a e^{\delta \psi(x)} h_{\eta - \delta \zeta}(x)}{\int \zeta d\mu_{\eta - \delta \zeta}} \int_{\Sigma_{A}} \chi(y) e^{-\psi(y) \delta} \sum_{l=-\infty}^{\infty} \int_{al - \psi(y)}^{a(l+1) - \psi(y)} e^{-T\delta} f_{y}(T) dT d\nu_{\eta - \delta \zeta}(y)
$$
\n
$$
= \frac{a h_{\eta - \delta \xi}(x)}{\int \zeta d\mu_{\eta - \delta \zeta}} \int_{\Sigma_{A}} \chi(y) \int_{-\infty}^{\infty} e^{-T\delta} f_{y}(T) dT d\nu_{\eta - \delta \xi}(y)
$$
\n
$$
= aG(x),
$$

where for the second to last equality we used that $e^{-\delta\psi}d\nu_{\eta-\delta\zeta} = d\nu_{\eta-\delta\xi}$, $e^{\delta\psi}h_{\eta-\delta\zeta} = h_{\eta-\delta\xi}$ and that $\int \zeta \mathrm{d}\mu_{\eta-\delta\zeta} = \int$ $\xi d\mu_{\eta-\delta\xi}$. \Box

4.2.2. Proof of Thm. [3.3.](#page-9-1) In the setting of Thm. [3.3,](#page-9-1) Condition [\(Db\)](#page-8-8) is automatically satisfied. Thus, Thm. [3.3](#page-9-1) is proved by combining the following three lemmas with Thm. [3.2.](#page-8-0)

Lemma 4.7. If $\{t \mapsto e^{-t\delta} | f_x(t) | \mid x \in \Sigma_A \}$ is equi d. R. i. then [\(A\)](#page-8-1) holds.

Proof. This is clear since d. R. i. implies Lebesgue integrability. \square

Lemma 4.8. If $\{t \mapsto e^{-t\delta}|f_x(t)| \mid x \in \Sigma_A\}$ is equi d. R. i. and there exist $\mathfrak{C}', s > 0$ such that $e^{-t\delta}|f_x(t)| \leq \mathfrak{C}'e^{st}$, $for t < 0$ and $x \in \Sigma_A$ then (C) holds, i.e. there exist $\widetilde{\mathfrak{C}} > 0, t^* \leq 0$ such that $e^{-\delta t} N^{abs}(t, x) \leq \widetilde{\mathfrak{C}} e^{st}$ for $t \leq t^*$.

Proof. In [\(4.14\)](#page-17-0) we have seen that the existence of $n \in \mathbb{N}$ for which $S_n \xi$ is strictly positive implies existence of $m^* \in \mathbb{N}$ such that $S_m \xi$ is strictly positive for all $m \geq m^*$. Set

$$
t^* := \min\bigg\{0, \inf_{x \in \Sigma_A, \, 0 \le m \le m^*} S_m \xi(x)\bigg\}.
$$

Then $t - S_m \xi < 0$ for all $t < t^*$ and $m \in \mathbb{N}$. Additionally using that there exist $\mathfrak{C}', s > 0$ such that $e^{-t\delta}|f_x(t)| \leq \mathfrak{C}'e^{st}$ for $t < 0$ and $x \in \Sigma_A$ we have for $t \leq t^*$,

$$
e^{-\delta t} N^{abs}(t, x) = \sum_{n=0}^{\infty} \sum_{y:\sigma^n y = x} e^{S_n(\eta - \delta \xi)(y)} |\chi(y)| e^{-\delta(t - S_n \xi(y))} |f_y(t - S_n \xi(y))|
$$

$$
\leq \mathfrak{C}' e^{st} \sum_{n=0}^{\infty} \sum_{y:\sigma^n y = x} e^{S_n(\eta - (\delta + s)\xi)(y)} |\chi(y)|
$$

$$
= \mathfrak{C}' e^{st} \sum_{n=0}^{\infty} \mathcal{L}_{\eta - (\delta + s)\xi}^n |\chi(x)|
$$

$$
\leq \mathfrak{C}' e^{st} \sum_{n=0}^{\infty} ||\mathcal{L}_{\eta - (\delta + s)\xi}^n||_{op} ||\chi||_{\infty}.
$$

By Prop. [2.5](#page-7-1) we know that $t \mapsto \gamma_{\eta+t\xi}$ is strictly monotonically increasing and $\gamma_{\eta-\delta\xi} = 1$. Hence, by the spectral radius formula (4.1) the last series converges and the assertion follows.

Lemma 4.9. If $\{t \mapsto e^{-t\delta}|f_x(t)| \mid x \in \Sigma_A\}$ is equi d. R. i. then (B) is satisfied, i. e. there exists $\mathfrak{C} > 0$ such that $e^{-t\delta}N^{abs}(t, x) \leq \mathfrak{C}$ for all $t \in \mathbb{R}$.

Proof. By assumption there exists $n \in \mathbb{N}$ for which $S_n \xi$ is strictly positive. Fix this n, choose $\kappa > 0$ such that $S_n \xi \geq \kappa$ and consider the *n*-th iterate of the renewal equation, namely,

$$
N(t,x) = \sum_{y:\sigma^n y = x} N(t - S_n \xi(y), y) e^{S_n \eta(y)} + \sum_{i=0}^{n-1} \sum_{y:\sigma^i y = x} \chi(y) f_y(t - S_i \xi(y)) e^{S_i \eta(y)}.
$$

The function defined by $M(t, x) := e^{-t\delta} N(t, x)/h_{\eta-\delta\xi}(x)$ satisfies

(4.26)
$$
M(t,x) = \sum_{y:\sigma^n y = x} M(t - S_n\xi(y), y) e^{S_n(\eta - \delta\xi)(y)} \frac{h_{\eta - \delta\xi}(y)}{h_{\eta - \delta\xi}(x)} + \sum_{i=0}^{n-1} \sum_{y:\sigma^i y = x} \chi(y) e^{-\delta(t - S_i\xi(y))} f_y(t - S_i\xi(y)) e^{S_i(\eta - \delta\xi)(y)} \frac{1}{h_{\eta - \delta\xi}(x)}.
$$

Set $g_x(t) := e^{-t\delta} f_x(t)$ and $g_{i,x}(t) := g_x(t - S_i \xi(x))$ for $x \in \Sigma_A$. Then [\(4.26\)](#page-22-0) becomes

(4.27)
$$
M(t,x) = \sum_{y:\sigma^n y = x} M(t - S_n\xi(y), y) e^{S_n(\eta - \delta\xi)(y)} \frac{h_{\eta - \delta\xi}(y)}{h_{\eta - \delta\xi}(x)} + \sum_{i=0}^{n-1} \mathcal{L}_{\eta - \delta\xi}^i(\chi g_{i,\cdot}(t))(x) / h_{\eta - \delta\xi}(x)
$$

with $g_{i,\cdot}(t) \colon \Sigma_A \to \mathbb{R}, x \mapsto g_{i,x}(t)$. Define

(4.28)
$$
\overline{M}(t) := \sup_{\substack{t' \in (t-\kappa,t] \\ x \in \Sigma_A}} M(t',x).
$$

Then [\(4.27\)](#page-22-1) implies that

(4.29)
$$
\overline{M}(t) \leq \sup_{y \in \Sigma_A} \overline{M}(t - S_n \xi(y)) + \sup_{t' \in (t - \kappa, t]} \sum_{i=0}^{n-1} \|\mathcal{L}_{\eta - \delta \xi}^i(\chi g_{i, \cdot}(t'))/h_{\eta - \delta \xi}\|_{\infty},
$$

as $\sum_{y:\sigma^n y=x} e^{S_n(\eta-\delta\xi)(y)} h_{\eta-\delta\xi}(y)/h_{\eta-\delta\xi}(x) = 1$. Iterating [\(4.29\)](#page-22-2) k times and using the abbreviation $I_{\kappa}(t, x^1, \ldots, x^m) := (t - \sum_{j=1}^m S_n \xi(x^j) - \kappa, t - \sum_{j=1}^m S_n \xi(x^j))$ yields that

$$
\overline{M}(t) \leq \sup_{x^1,\dots,x^k \in \Sigma_A} \left[\overline{M} \left(t - \sum_{j=1}^k S_n \xi(x^j) \right) + \sum_{i=0}^{n-1} \sum_{m=0}^{k-1} \sup_{t' \in I_\kappa(t,x^1,\dots,x^m)} \| \mathcal{L}_{\eta-\delta\xi}^i(\chi g_{i,\cdot}(t') / h_{\eta-\delta\xi} \|_{\infty} \right],
$$

where $\sum_{j=1}^{0} S_n \xi(x^j)$ shall be understood to be zero.

Fix $t \in \mathbb{R}$. As $S_n \xi \geq \kappa > 0$ we can find a $k^* \in \mathbb{N}$ such that for all $k \geq k^*$ and $x^1, \ldots, x^k \in \Sigma_A$ we have $t - \sum_{j=1}^{k} S_n \xi(x^j) \le t^* \le 0$ with t^* as in Lem. [4.8.](#page-21-0) Hence by Lem. [4.8](#page-21-0) there exists a constant \mathfrak{C}'' such that

(4.30)
$$
\overline{M}(t) \leq \mathfrak{C}'' + \sup_{x^1, x^2, ... \in \Sigma_A} \sum_{i=0}^{n-1} \sum_{m=0}^{\infty} \sup_{t' \in I_{\kappa}(t, x^1, ..., x^m)} ||\mathcal{L}_{\eta-\delta\xi}^i(\chi g_{i,\cdot}(t'))/h_{\eta-\delta\xi}||_{\infty}.
$$

If $t' \mapsto \|\mathcal{L}_{\eta-\delta\xi}^i(\chi g_{i,\cdot}(t'))/h_{\eta-\delta\xi}\|_{\infty}$ is d. R. i. then $t-\sum_{j=1}^{m+1}S_n\xi(x^j) \leq t-\sum_{j=1}^mS_n\xi(x^j)-\kappa$ for $x^1,\ldots,x^{m+1} \in$ Σ_A implies that the series in [\(4.30\)](#page-23-15) converges for any constellation $x^1, x^2, \ldots \in \Sigma_A$ and thus is uniformly bounded for $x^1, x^2, \ldots \in \Sigma_A$. This proves the assertion. Hence all that remains to be shown is that $t' \mapsto \|\mathcal{L}^i_{\eta-\delta\xi}(\chi g_{i,\cdot}(t'))/h_{\eta-\delta\xi}\|_{\infty}$ is d. R. i. For this, note that using the terminology of Defn. [3.1](#page-8-9)

$$
\underline{m}_k\left(\mathcal{L}_{\eta-\delta\xi}^i(\chi g_{i,\cdot})(x),h\right) \ge \sum_{y:\sigma^iy=x} \chi(y) e^{S_i(\eta-\delta\xi)(y)} \underline{m}_{k-S_i\xi(y)/h}(g_y,h) \text{ and}
$$

$$
\overline{m}_k\left(\mathcal{L}_{\eta-\delta\xi}^i(\chi g_{i,\cdot})(x),h\right) \le \sum_{y:\sigma^iy=x} \chi(y) e^{S_i(\eta-\delta\xi)(y)} \overline{m}_{k-S_i\xi(y)/h}(g_y,h).
$$

Since $\sum_{y:\sigma^iy=x}\chi(y)e^{S_i(\eta-\delta\xi)(y)}=\mathcal{L}^i_{\eta-\delta\xi}\chi(x)$ is finite, the hypothesis of $\{g_x \mid x \in \Sigma_A\}$ being equi d. R. i. implies that $t' \mapsto \|\mathcal{L}^i_{\eta-\delta\xi}(\chi g_{i,\cdot}(t'))/h_{\eta-\delta\xi}\|_{\infty}$ is d. R. i. which finishes the proof.
