Remarks on the Donaldson metric

Abstract

The Donaldson metric is a metric on the space of symplectic twoforms in a fixed cohomology class. It was introduced in [\[2\]](#page-11-0). We compute the associated Levi-Civita connection, describe it's geodesics and compute the formula for the covariant Hessian of an energy functional on the space of symplectic structures in a fixed cohomology class, introduced by S. Donaldson in [\[1\]](#page-11-1).

Let M be a closed oriented Riemannian four-manifold. Denote by g the Riemannian metric on M, denote by dvol $\in \Omega^4(M)$ the volume form of g, and let $* : \Omega^k(M) \to \Omega^{4-k}(M)$ be the Hodge $*$ -operator associated to the metric and orientation. Fix a cohomology class $a \in H^2(M; \mathbb{R})$ such that $a^2 > 0$ and consider the space

$$
\mathscr{S}_a := \left\{ \rho \in \Omega^2(M) \, \middle| \, d\rho = 0, \, \rho \wedge \rho > 0, \, [\rho] = a \right\}
$$

of symplectic forms on M representing the class a . This is an infinitedimensional manifold and the tangent space of \mathscr{S}_a at any element $\rho \in \mathscr{S}_a$ is the space of exact 2-forms on M . The next proposition is proved in [\[2\]](#page-11-0). It summarizes the properties of a family of Riemannian metrics g^{ρ} on M, one for each nondegenerate 2-form ρ (and for each fixed background metric q). For each nondegenerate 2-form define the function u by the equation

$$
2u\text{dvol} = \rho \wedge \rho \tag{1}
$$

Proposition 1 (Symplectic Forms and Riemannian Metrics).

Fix a nondegenerate 2-form $\rho \in \Omega^2(M)$ such that $\rho \wedge \rho > 0$ and define the function $u : M \to (0,\infty)$ by [\(1\)](#page-0-0). Then there exists a unique Riemannian metric g^{ρ} on M that satisfies the following conditions.

- (i) The volume form of g^{ρ} agrees with the volume form of g.
- (ii) The Hodge \ast -operator $\ast^{\rho} : \Omega^1(M) \to \Omega^3(M)$ associated to g^{ρ} is given by

$$
*^{\rho} \lambda = \frac{\rho \wedge * (\rho \wedge \lambda)}{u} \tag{2}
$$

for $\lambda \in \Omega^1(M)$ and by $*^{\rho} \iota(X) \rho = -\rho \wedge g(X, \cdot)$ for $X \in \text{Vect}(M)$.

(iii) The Hodge $*$ -operator $*^{\rho}: \Omega^2(M) \to \Omega^2(M)$ associated to g^{ρ} is given by

$$
*^{\rho} \omega = R^{\rho} * R^{\rho} \omega, \qquad R^{\rho} \omega := \omega - \frac{\omega \wedge \rho}{\text{dvol}_{\rho}} \rho,
$$
 (3)

for $\omega \in \Omega^2(M)$. The linear map $R^{\rho} : \Omega^2(M) \to \Omega^2(M)$ is an involution that preserves the exterior product, acts as the identity on the orthogonal complement of ρ with respect to the exterior product, and sends ρ to $-\rho$. (iv) Let $\omega \in \Omega^2(M)$ be a nondegenerate 2-form and let $J: TM \to TM$ be an

almost complex structure such that $q = \omega(\cdot, J \cdot)$. Define the almost complex structure J^{ρ} by $\rho(J^{\rho} \cdot, \cdot) := \rho(\cdot, J \cdot)$ and define the 2-form $\omega^{\rho} \in \Omega^2(M)$ by $\omega^{\rho} := R^{\rho} \omega$. Then $g^{\rho} = \omega^{\rho}(\cdot, J^{\rho} \cdot)$ and so ω^{ρ} is self-dual with respect to g^{ρ} .

The following is the central object of this paper.

Definition 2. Each nondegenerate 2-form $\rho \in \Omega^2(M)$ with $\rho^2 > 0$ determines an inner product $\langle \cdot, \cdot \rangle_{\rho}$ on the space of exact 2-forms defined by

$$
\langle \hat{\rho}_1, \hat{\rho}_2 \rangle_{\rho} := \int_M \lambda_1 \wedge *^{\rho} \lambda_2, \qquad d\lambda_i = \hat{\rho}_i, \qquad *^{\rho} \lambda_i \in \text{im } d. \tag{4}
$$

These inner products determine a Riemannian metric on the infinite-dimensional manifold \mathscr{S}_a called the **Donaldson metric**.

Definition 3. A vector field $X_{\hat{\rho}}$ is associated to an exact 2-form $\hat{\rho} \in T_{\rho} \mathscr{S}_{a}$ if it is the unique vector field satisfing

$$
- d\iota(X_{\widehat{\rho}})\rho = \widehat{\rho}, \qquad *^{\rho}\iota(X_{\widehat{\rho}})\rho \in \text{im}d. \tag{5}
$$

Every metric has an associated Levi-Civita connection. This is the unique torsion free and Riemannian connection with respect to the metric. The formula and computation is the content of the following theorem.

Theorem 4 (Levi Civita Connection). Let $\rho_t : \mathbb{R} \to \mathscr{S}_a$ be a smooth path of symplectic forms with $\rho := \rho_0$ and $\hat{\rho} := \partial_t|_{t=0} \rho_t$. Let X be the associated vector field of $\widehat{\rho}$. Let $Y_t : \mathbb{R} \to \text{Vect}(M)$ be a smooth path of vector fields such that $*^{\rho} \iota(Y_t) \rho_t$ is exact and define

$$
\widehat{\sigma}_t := -dt(Y_t)\rho_t, \quad \widehat{\sigma} := \widehat{\sigma}_0, \quad Y := Y_0.
$$

The unique Levi-Civita connection associated to the Donaldson metric is given by

$$
\nabla_{\widehat{\rho}}^{\rho}\widehat{\sigma} = \frac{d}{dt}\bigg|_{t=0} \widehat{\sigma}_t + \frac{1}{2}d\iota(Y)\widehat{\rho} + \frac{1}{2}d\iota(X)\widehat{\sigma} - \frac{1}{2}d\iota(\nabla_Y X + \nabla_X Y)\,\rho. \tag{6}
$$

Here $\nabla_X Y$ denotes the covariant derivative of the Levi-Civita connection of the metric g for two vector fields X and Y .

Proof. The Levi-Civita connection of the Donaldson metric is the unique connection that is torsion free and Riemannian with respect to the Donaldson metric. Since the Christoffel symbol given by [\(6\)](#page-2-0) is symmetric in $\hat{\rho}$ and $\hat{\sigma}$, the torsion of the connection ∇^{ρ} vanishes. It remains to show that it is Riemannian. Let Z_t be a smooth path of vector fields such that $*^{\rho_t} \iota(Z_t) \rho_t$ is exact. Denote $\hat{\tau}_t := -d\iota(Z_t)\rho_t$, $\hat{\tau} := \hat{\tau}_0$. We claim that

$$
\left. \frac{d}{dt} \right|_{t=0} \langle \hat{\sigma}_t, \hat{\tau}_t \rangle_{\rho_t} = \langle \nabla_{\hat{\rho}} \hat{\sigma}, \hat{\tau} \rangle_{\rho} + \langle \hat{\sigma}, \nabla_{\hat{\rho}} \hat{\tau} \rangle_{\rho}.
$$

By the definition of the Donaldson metric and since $*^{\rho} \iota(X) \rho = -\rho \wedge \iota(X) g$ by Proposition 3.1 ii) in [\[2\]](#page-11-0),

$$
\langle \hat{\sigma}_t, \hat{\tau}_t \rangle_{\hat{\rho}_t} = \int_M (\iota(Y_t)\rho_t) \wedge *^{\rho} \iota(Z_t)\rho_t = -\int_M (\iota(Y_t)\rho_t) \wedge \rho_t \wedge \iota(Z_t)g
$$

and

$$
\langle \frac{d}{dt} \Big|_{t=0} \hat{\sigma}_t, \hat{\tau} \rangle_{\rho} = -\int_M (\iota(\hat{Y})\rho) \wedge \rho \wedge \iota(Z)g - \int_M (\iota(Y)\hat{\rho}) \wedge \rho \wedge \iota(Z)g
$$

$$
\langle \hat{\sigma}, \frac{d}{dt} \Big|_{t=0} \hat{\tau}_t \rangle_{\rho} = -\int_M (\iota(\hat{Z})\rho) \wedge \rho \wedge \iota(Y)g - \int_M (\iota(Z)\hat{\rho}) \wedge \rho \wedge \iota(Y)g,
$$

where $\widehat{Y} := \frac{d}{dt}\big|_{t=0} Y_t$, $\widehat{Z} := \frac{d}{dt}\big|_{t=0} Z_t$. Hence, d dt $\bigg|_{t=0} \langle \widehat{\sigma}_t, \widehat{\tau}_t \rangle_{\widehat{\rho}_t}$ $=$ \langle d dt $\biggl\vert_{t=0} \widehat{\sigma}_t, \widehat{\tau} \rangle_{\rho} \; \bigcup_{M} (\iota(Y)\rho) \wedge \widehat{\rho} \wedge \iota(Z)g -$ Z $\bigcup_{M} (\iota(Y)\rho) \wedge \rho \wedge \iota(Z)g$ $=$ \langle d dt $\biggl\vert_{t=0} \widehat{\sigma}_t, \widehat{\tau} \rangle_{\rho} \; \bigcup_{M} (\iota(Y)\rho) \wedge \widehat{\rho} \wedge \iota(Z)g -$ Z $\bigcup_{M} (\iota(Z)\rho) \wedge \rho \wedge \iota(Y)g$ $=$ \langle d dt $\bigg|_{t=0} \widehat{\sigma}_t, \widehat{\tau} \rangle_{\rho} + \langle \widehat{\sigma},$ d dt $\bigg|_{t=0}$ $\widehat{\tau}_t$ − Z $\int_M (\iota(Y)\rho) \wedge \widehat{\rho} \wedge \iota(Z)g +$ Z $\bigcup_{M} (\iota(Z)\widehat{\rho}) \wedge \rho \wedge \iota(Y)g.$

Define the Christoffel symbols $\Gamma_{\widehat{\sigma}\widehat{\tau}\widehat{\rho}}$ by

$$
2\Gamma_{\widehat{\sigma}\widehat{\tau}\widehat{\rho}} := (\iota(Y)\rho) \wedge (d\iota(X)\rho) \wedge \iota(Z)g - (\iota(Z)d\iota(X)\rho) \wedge \rho \wedge \iota(Y)g
$$

+
$$
(\iota(Y)\rho) \wedge (d\iota(Z)\rho) \wedge \iota(X)g - (\iota(X)d\iota(Z)\rho) \wedge \rho \wedge \iota(Y)g
$$

-
$$
(\iota(Z)\rho) \wedge (d\iota(Y)\rho) \wedge \iota(X)g + (\iota(X)d\iota(Y)\rho) \wedge \rho \wedge \iota(Z)g.
$$

Then

$$
\Gamma_{\widehat{\sigma}\widehat{\tau}\widehat{\rho}} + \Gamma_{\widehat{\tau}\widehat{\sigma}\widehat{\rho}} = (\iota(Y)\rho) \wedge d\iota(X)\rho \wedge \iota(Z)g - (\iota(Z)d\iota(X)\rho) \wedge \rho \wedge \iota(Y)g
$$

=
$$
(-\iota(Y)\rho) \wedge \widehat{\rho} \wedge \iota(Z)g + (\iota(Z)\widehat{\rho}) \wedge \rho \wedge \iota(Y)g.
$$

Hence, it remains to show that

$$
\int_M \Gamma_{\widehat{\sigma}\widehat{\tau}\widehat{\rho}} = \langle \widehat{\sigma}, \frac{1}{2} dt(Z)\widehat{\rho} + \frac{1}{2} dt(X)\widehat{\tau} - \frac{1}{2} dt(\nabla_Z X + \nabla_X Z)\rho \rangle_{\rho}.
$$

Let

$$
A := (-\iota(Z)dt(X)\rho) \wedge \rho \wedge \iota(Y)g - (\iota(X)dt(Z)\rho) \wedge \rho \wedge \iota(Y)g
$$

\n
$$
B := 2\Gamma_{\widehat{\sigma}\widehat{\tau}\widehat{\rho}} - A
$$

\n
$$
= (\iota(Y)\rho) \wedge (dt(X)\rho) \wedge \iota(Z)g + (\iota(Y)\rho) \wedge (dt(Z)\rho) \wedge \iota(X)g
$$

\n
$$
- (\iota(Z)\rho) \wedge (dt(Y)\rho) \wedge \iota(X)g + (\iota(X)dt(Y)\rho) \wedge \rho \wedge \iota(Z)g.
$$

Since * $\ell(\chi)\rho = -\rho \wedge \iota(X)g$ for any vector field X,

$$
\int_M A = -\int_M \iota(Z) d\iota(X)\rho \wedge \rho \wedge \iota(Y)g - \int_M \iota(X) d\iota(Z)\rho \wedge \rho \wedge \iota(Y)g
$$

= $\langle \hat{\sigma}, d\iota(Z)\hat{\rho} + d\iota(X)\hat{\tau} \rangle_{\rho}.$

Since

$$
Zg(X,Y) + Xg(Y,Z) - Yg(X,Z)
$$

= $g(\nabla_Z X + \nabla_X Z, Y) + g([Y,Z], X) + g([Y,X], Z)$

(see our sign convention for the Lie bracket), we have

$$
\langle \hat{\sigma}, -dt(\nabla_Z X + \nabla_X Z)\rho \rangle_{\rho} = \int_M g(Y, \nabla_Z X + \nabla_X Z) \text{dvol}_{\rho}
$$

=
$$
\int_M (Zg(X, Y) + Xg(Y, Z) - Yg(X, Z))
$$

-
$$
g([Y, Z], X) - g([Y, X], Z)) \text{dvol}_{\rho}.
$$

Here we used that $\langle -d\iota(X)\rho, -d\iota(Y)\rho \rangle_{\rho} = \int_M g(X, Y) d\text{vol}_{\rho}$ for any vector field X and a vector field Y such that $*^{\rho} \iota(Y) \overline{\rho}$ is exact. Then

$$
- \int_{M} g([Y, Z], X) + g([Y, X], Z) \, dvol_{\rho}
$$

= $-\langle d\iota([Y, Z])\rho, d\iota(X)\rho \rangle_{\rho} - \langle d\iota([Y, X])\rho, d\iota(Z)\rho \rangle_{\rho}$
= $-\langle \mathcal{L}_{[Y, Z]}\rho, d\iota(X)\rho \rangle_{\rho} - \langle \mathcal{L}_{[Y, X]}\rho, d\iota(Z)\rho \rangle_{\rho}$
= $\langle [\mathcal{L}_{Y}, \mathcal{L}_{Z}]\rho, d\iota(X)\rho \rangle_{\rho} + \langle [\mathcal{L}_{Y}, \mathcal{L}_{X}]\rho, d\iota(Z)\rho \rangle_{\rho}$
= $-\int_{M} (\iota(Y) d\iota(Z)\rho) \wedge \rho \wedge \iota(X)g + \int_{M} (\iota(Z) d\iota(Y)\rho) \wedge \rho \wedge \iota(X)g$
 $- \int_{M} (\iota(Y) d\iota(X)\rho) \wedge \rho \wedge \iota(Z)g + \int_{M} (\iota(X) d\iota(Y)\rho) \wedge \rho \wedge \iota(Z)g.$

Here we used the identity $\mathcal{L}_{[X,Y]} = -[\mathcal{L}_X, \mathcal{L}_Y]$ for all vector fields X, Y in the third equality. Using the Leibniz rule for the interior product for the first three terms yields,

- \int_M g([Y, Z], X) + g([Y, X], Z) \text{dvol}_\rho
$$

=
$$
\int_M (d\iota(Z)\rho) \wedge (\iota(Y)\rho) \wedge \iota(X)g + \int_M g(X, Y) (d\iota(Z)\rho) \wedge \rho
$$

$$
- \int_M (d\iota(Y)\rho) \wedge (\iota(Z)\rho) \wedge \iota(X)g - \int_M g(X, Z) (d\iota(Y)\rho) \wedge \rho
$$

+
$$
\int_M (d\iota(X)\rho) \wedge (\iota(Y)\rho) \wedge \iota(Z)g + \int_M g(Y, Z) (d\iota(X)\rho) \wedge \rho
$$

+
$$
\int_M (\iota(X) d\iota(Y)\rho) \wedge \rho \wedge \iota(Z)g.
$$

Since

$$
\int_M Xg(Y, Z) \text{dvol}_\rho = \int_M (\iota(X) dg(Y, Z)) \text{dvol}_\rho
$$

$$
= \int_M (dg(Y, Z)) (\iota(X)\rho) \wedge \rho
$$

$$
= - \int_M g(Y, Z) (d\iota(X)\rho) \wedge \rho
$$

for all vector fields X, Y, Z we find

$$
\langle \hat{\sigma}, -d\iota(\nabla_Z X + \nabla_X Z)\rho \rangle_{\rho}
$$

=
$$
\int_M (d\iota(Z)\rho) \wedge (\iota(Y)\rho) \wedge \iota(X)g - \int_M (d\iota(Y)\rho) \wedge (\iota(Z)\rho) \wedge \iota(X)g
$$

+
$$
\int_M (d\iota(X)\rho) \wedge (\iota(Y)\rho) \wedge \iota(Z)g + \int_M (\iota(X)d\iota(Y)\rho) \wedge \rho \wedge \iota(Z)g
$$

=
$$
\int_M B.
$$

Hence

$$
\langle \hat{\sigma}, \frac{1}{2} d\iota(Z) \hat{\rho} + \frac{1}{2} d\iota(X) \hat{\tau} - \frac{1}{2} d\iota(\nabla_Z X + \nabla_X Z) \rho \rangle_{\rho} = \frac{1}{2} \int_M A + B = \Gamma_{\hat{\sigma}\hat{\tau}\hat{\rho}}.
$$

This proves the claim and the theorem.

The following is an immidiate corollary.

Corollary 5 (Geodesic Equation). The geodesic equation on the space \mathscr{S}_a with respect to the Donaldson metric is

$$
\frac{d^2}{dt^2}\rho_t = d\iota(X_t)dt(X_t)\rho_t + d\iota(\nabla_{X_t}X_t)\rho_t,\tag{7}
$$

where X_t is the associated vector field of $\partial_t \rho_t$.

The next lemma gives an alternative forumula for the covariant derivative.

Lemma 6. Let $\rho_t : \mathbb{R} \to \mathscr{S}_a$ be a smooth path of symplectic forms with $\rho := \rho_0$ and $\hat{\rho} := \partial_t |_{t=0} \rho_t$. Let X be the associated vector field of $\hat{\rho}$. Let

 $Y_t : \mathbb{R} \to \text{Vect}(M)$ be a smooth path of vector fields such that * $\ell_t(Y_t) \rho_t$ is exact and define

$$
\widehat{\sigma}_t := -dt(Y_t)\rho_t, \quad \widehat{\sigma} := \widehat{\sigma}_0, \quad Y := Y_0.
$$

Then

$$
\nabla_{\widehat{\rho}}^{\rho}\widehat{\sigma} = -dt(\widehat{Y} + \nabla_X Y)\rho, \qquad \widehat{Y} := \frac{d}{dt}\bigg|_{t=0} Y_t.
$$

Proof. We have

$$
\nabla_{\hat{\rho}}^{\rho}\hat{\sigma} = -\frac{d}{dt}\bigg|_{t=0} dt(Y_t)\rho_t + \frac{1}{2}dt(Y)\hat{\rho} + \frac{1}{2}dt(X)\hat{\sigma} - \frac{1}{2}dt(\nabla_Y X + \nabla_X Y)\rho
$$

=
$$
-dt(\hat{Y})\rho - dt(Y)\hat{\rho} + \frac{1}{2}dt(Y)\hat{\rho} + \frac{1}{2}dt(X)\hat{\sigma} - \frac{1}{2}dt(\nabla_Y X + \nabla_X Y)\rho.
$$

Using the identity $\mathcal{L}_{[X,Y]} = -[\mathcal{L}_X, \mathcal{L}_Y]$ and Cartan's formula for the Lie derivative we compute

$$
-2d\iota(Y)\widehat{\rho} + d\iota(Y)\widehat{\rho} + d\iota(X)\widehat{\sigma} - d\iota(\nabla_Y X + \nabla_X Y)\rho
$$

= $-d\iota(Y)\widehat{\rho} + d\iota(X)\widehat{\sigma} - d\iota(\nabla_Y X + \nabla_X Y)\rho$
= $\mathcal{L}_Y \mathcal{L}_X \rho - \mathcal{L}_X \mathcal{L}_Y \rho - d\iota(\nabla_Y X + \nabla_X Y)\rho$
= $-\mathcal{L}_{[Y,X]}\rho - d\iota(\nabla_Y X + \nabla_X Y)\rho$
= $-2d\iota(\nabla_X Y)\rho$.

Hence,

$$
\nabla_{\widehat{\rho}}^{\rho}\widehat{\sigma} = -dt(\widehat{Y} + \nabla_X Y)\rho.
$$

This proves the lemma.

S. Donaldson introduced the following energy functional on the space of symplectic structures in a fixed cohomology class in [\[1\]](#page-11-1),

$$
\mathscr{E}: \mathscr{S}_a \to \mathbb{R}, \qquad \mathscr{E}(\rho) := \int_M \frac{2|\rho^+|^2}{|\rho^+|^2 - |\rho^-|^2} d\text{vol}.
$$

The functional and the corresponding negative gradient flow with respect to the Donaldson metric are further studied in [\[2\]](#page-11-0) and [\[3\]](#page-11-2). It is shown in [\[2\]](#page-11-0) that the gradient of $\mathscr E$ with respect to the Donaldson metric is the operator

$$
\operatorname{grad} \mathscr{E} : \mathscr{S}_a \to T_\rho \mathscr{S}_a
$$

$$
\rho \mapsto -d*^{\rho} d\Theta^{\rho},
$$

 \Box

where

$$
\Theta^\rho:=*\frac{\rho}{u}-\frac{1}{2}\left|\frac{\rho}{u}\right|^2\rho.
$$

We compute its associated vector field.

Lemma 7. The associated vector field $X_{\text{grad}\mathscr{E}}$ of $\text{grad}\mathscr{E}(\rho)$ is given by the two equivalent equations

$$
*^{\rho} d\Theta^{\rho} = \iota(X_{\text{grad}\mathscr{E}}) \rho \iff d\Theta^{\rho} = \rho \wedge \iota(X_{\text{grad}\mathscr{E}}) g. \tag{8}
$$

In the hyperKähler case,

$$
X_{\text{grad}\mathscr{E}} = -\sum_{i=1}^{3} J_i X_{K_i},
$$

where $K_i := \frac{\omega_i \wedge \rho}{\text{dvol}_i}$ $\frac{\omega_i \wedge \rho_i}{dvol_\rho}$ and X_{K_i} is the Hamiltonian vector field of K_i with respect to the symplectic structure ρ.

Proof. It is immediate that a vector field $X_{\text{grad}\mathscr{E}}$ defined by the first equation of [\(8\)](#page-7-0) satisfies the two conditions [\(5\)](#page-1-0) for $\hat{\rho} = \text{grad} \mathscr{E}(\rho) = -d *^{\rho} d\Theta^{\rho}$. That the second equation is equivalent to the first follows from the identity $*^{\rho} \iota(X) \rho =$ $-\rho \wedge \iota(X)$ g proved in [\[2\]](#page-11-0). In the hyperKähler case it is shown in [2] that $d\Theta^{\rho} = *^{\rho} \sum_{i} \rho(J_i X_{K_i}, \cdot)$. Hence it follows from the first equation in [\(8\)](#page-7-0) that $\rho(X_{\text{grad}\mathscr{E}},\overline{\cdot)} = -\rho(\sum_{i}J_{i}X_{K_{i}},\cdot)$. This proves the lemma. □

The Hessian operator of the energy functional $\mathscr E$ is the operator $\mathcal H$: $T_{\rho}\mathscr{S}_a\to T_{\rho}\mathscr{S}_a$ defined by

$$
\mathcal{H}_{\rho}\widehat{\rho}:=\nabla_{\widehat{\rho}}^{\rho}\mathrm{grad}\mathscr{E}(\rho).
$$

Associated to this operator is the Hessian quadratic form $\mathscr{H}_{\rho}: T_{\rho}\mathscr{S}_{a} \to \mathbb{R}$ given by

$$
\mathscr{H}_{\rho}(\widehat{\rho}) := \langle \mathcal{H}_{\rho}\widehat{\rho}, \widehat{\rho} \rangle_{\rho}.
$$

Since ∇^{ρ} is the Levi-Civita connection of the Donaldson metric, the Hessian quadratic form equals $\frac{d^2}{dt^2}$ dt^2 $\Big|_{t=0}$ $\mathscr{E}(\rho_t)$ for a curve $\mathbb{R} \to \mathscr{S}_a : t \to \rho_t$ satisfying $\rho_0 = \rho, \frac{d}{dt}$ $\frac{d}{dt}\Big|_{t=0} = \widehat{\rho}$ and $\frac{d^2}{dt^2}$ dt^2 $\int_{t=0}^{t=0} \rho_t = 0.$

Theorem 8 (Covariant Hessian). Let $\rho \in \mathscr{S}_a$. Then the following holds. (i) The Hessian operator of the energy functional $\mathscr{E} : \mathscr{S}_a \to \mathbb{R}$ is the linear operator

$$
\mathcal{H}_{\rho}\widehat{\rho} = -d *^{\rho} d\widehat{\Theta} + d *^{\rho} (\widehat{\rho} \wedge \iota(X_{\text{grad}\mathscr{E}})g) - d\iota(\nabla_{X} X_{\text{grad}\mathscr{E}}) \rho, \tag{9}
$$

where $\widehat{\Theta} := \frac{\widehat{\rho} + *^{\rho} \widehat{\rho}}{u} - \Big|$ ρ^+ u $\widehat{\rho}, \nabla$ denotes the Levi-Civita connection of the metric g and X, $X_{\text{grad}\mathscr{E}}$ are the associated vector fields to $\widehat{\rho}$ respectively grad $\mathscr{E}(\rho)$. (ii) The Hessian of $\mathscr E$ is the quadratic form

$$
\mathscr{H}_{\rho}(\widehat{\rho}) := \int_{M} \widehat{\Theta} \wedge \widehat{\rho} + \int_{M} (\iota(X)\widehat{\rho} - \iota(\nabla_{X}X)\rho) \wedge *^{\rho} \iota(X_{\text{grad}\mathscr{E}})\rho. \tag{10}
$$

(iii) In the hyperKähler case the Hessian of $\mathscr E$ is given by

$$
\mathcal{H}_{\rho}(\widehat{\rho}) = \int_{M} \sum_{i} \left(\widehat{H}_{i}^{2} \text{dvol}_{\rho} + \omega_{i}(X, \nabla_{X_{K_{i}}} X) \right) \text{dvol}_{\rho}, \tag{11}
$$

where $\widehat{H}_i := \frac{(d\iota(X)\omega_i)\wedge \rho}{d\text{vol}_{\rho}}$ $\frac{(X)\omega_i|\wedge\rho}{dvol_\rho}$ and $K_i := \frac{\omega_i\wedge\rho}{dvol_\rho}$ $\frac{\omega_i \wedge \rho}{\text{dvol}_{\rho}}.$

Proof. We prove (i). Let X and $X_{\text{grad}\mathscr{E}}$ be the associated vectorfields of $\widehat{\rho}$ and grad \mathscr{E} . Let $\rho_t : \mathbb{R} \to \mathscr{S}_a$ be a path of symplectic forms such that d $\frac{d}{dt}\Big|_{t=0}$ $\rho_t = \hat{\rho}$. By Lemma [6](#page-5-0)

$$
\nabla_{\hat{\rho}}\text{grad}\mathscr{E}(\rho) = -\iota(\widehat{X}_{\text{grad}\mathscr{E}} + \nabla_X X_{\text{grad}\mathscr{E}})\rho
$$

where $\widehat{X}_{\text{grad}\mathscr{E}} = \frac{d}{dt}$ $\frac{d}{dt}\Big|_{t=0} X_{\text{grad}\mathscr{E}}$. By Lemma [7](#page-7-1) we have $d\Theta^{\rho} = \rho \wedge \iota(X_{\text{grad}\mathscr{E}}) g$ and hence

$$
d\widehat{\Theta} = \widehat{\rho} \wedge \iota(X_{\text{grad}\mathscr{E}})g + \rho \wedge \iota\left(\widehat{X}_{\text{grad}\mathscr{E}}\right)g,
$$

where $\widehat{\Theta} = \frac{d}{dt}\big|_{t=0} \Theta^{\rho_t}$. It follows that

$$
\iota(\widehat{X}_{\mathrm{grad}\mathscr{E}})\rho = *^{\rho}(\rho \wedge \iota\left(\widehat{X}_{\mathrm{grad}\mathscr{E}}\right)g) = *^{\rho}d\widehat{\Theta} - *^{\rho}(\widehat{\rho} \wedge \iota(X_{\mathrm{grad}\mathscr{E}})\,g).
$$

Hence,

$$
\nabla_{\hat{\rho}}\text{grad}\mathscr{E}\left(\rho\right) = -d *^{\rho} d\hat{\Theta} + d *^{\rho} (\hat{\rho} \wedge \iota(X_{\text{grad}\mathscr{E}})g) - d\iota\left(\nabla_{X} X_{\text{grad}\mathscr{E}}\right)\rho.
$$

That $\widehat{\Theta} = \frac{\widehat{\rho} + *^{\rho} \widehat{\rho}}{u} - \Big|$ ρ^+ u $\left| \widehat{\rho} \right|$ is proved in [\[2\]](#page-11-0). This proves (i). We prove (ii). By part (i)

$$
\mathcal{H}_{\rho}(\widehat{\rho}) = \langle \mathcal{H}_{\rho}(\widehat{\rho}), \widehat{\rho} \rangle_{\rho}
$$

= $\langle -d *^{\rho} d \left(\frac{\widehat{\rho} + *^{\rho} \widehat{\rho}}{u} - \left| \frac{\rho^{+}}{u} \right|^{2} \widehat{\rho} \right), \widehat{\rho} \rangle_{\rho}$
+ $\langle d *^{\rho} (\widehat{\rho} \wedge \iota(X_{\text{grad}\mathscr{E}})g), \widehat{\rho} \rangle_{\rho} + \langle -d\iota (\nabla_{X} X_{\text{grad}\mathscr{E}}) \rho, \widehat{\rho} \rangle_{\rho}$
=: $A + B + C$.

By the definition of the Donaldson metric

$$
A = \int_M \left(*^{\rho} d \left(\frac{\hat{\rho} + *^{\rho} \hat{\rho}}{u} - \left| \frac{\rho^+}{u} \right|^2 \hat{\rho} \right) \right) \wedge *^{\rho} \iota(X) \rho
$$

=
$$
\int_M \left(\frac{\hat{\rho} + *^{\rho} \hat{\rho}}{u} - \left| \frac{\rho^+}{u} \right|^2 \hat{\rho} \right) \wedge (-d\iota(X) \rho)
$$

=
$$
\int_M \left(\frac{\hat{\rho} + *^{\rho} \hat{\rho}}{u} - \left| \frac{\rho^+}{u} \right|^2 \hat{\rho} \right) \wedge \hat{\rho}.
$$

Likewise,

$$
B = -\int_M \hat{\rho} \wedge (\iota(X_{\text{grad}\mathscr{E}})g) \wedge \iota(X)\rho
$$

=
$$
-\int_M (\iota(X)\hat{\rho}) \wedge (\iota(X_{\text{grad}\mathscr{E}})g) \wedge \rho - \int_M g(X_{\text{grad}\mathscr{E}}, X)\hat{\rho} \wedge \rho
$$

=
$$
\int_M (\iota(X)\hat{\rho}) \wedge *^{\rho} (\iota(X_{\text{grad}\mathscr{E}}) \rho) - \int_M g(X_{\text{grad}\mathscr{E}}, X)\hat{\rho} \wedge \rho.
$$

Since $\langle -d\iota(X)\rho, -d\iota(Y)\rho \rangle_{\rho} = \int_M (\iota(X)\rho) \wedge *^{\rho} \iota(Y)\rho = \int_M g(X, Y) \text{dvol}_{\rho}$ for X associated to $\widehat{\rho}$ and Y an arbitrary vector field we have

$$
C = \int_M g(\nabla_X X_{\text{grad}\mathscr{E}}, X) \, d\text{vol}_\rho
$$

=
$$
\int_M (\iota(X) dg(X_{\text{grad}\mathscr{E}}, X) - g(X_{\text{grad}\mathscr{E}}, \nabla_X X)) \, d\text{vol}_\rho
$$

=
$$
\int_M dg(X_{\text{grad}\mathscr{E}}, X) \wedge (\iota(X)\rho) \wedge \rho - \int_M g(X_{\text{grad}\mathscr{E}}, \nabla_X X) \, d\text{vol}_\rho
$$

=
$$
\int_M g(X_{\text{grad}\mathscr{E}}, X) \, \widehat{\rho} \wedge \rho - \int_M \iota(\nabla_X X) \rho \wedge *^{\rho} \iota(X_{\text{grad}\mathscr{E}}) \rho.
$$

Hence,

$$
A + B + C = \int_M \left(\frac{\hat{\rho} + *^{\rho}\hat{\rho}}{u} - \left| \frac{\rho^+}{u} \right|^2 \hat{\rho} \right) \wedge \hat{\rho} + \int_M (\iota(X)\hat{\rho} - \iota(\nabla_XX)\rho) \wedge *^{\rho}\iota(X_{\text{grad}\mathscr{E}})\rho.
$$

This proves (iii).

We prove (iii). Assume the hyperKähler case. The following identities are proved in [\[2\]](#page-11-0),

$$
\operatorname{grad} \mathcal{E}(\rho) = d \sum_{i}^{3} dK_{i} \circ J_{i}^{\rho}
$$

$$
\widehat{\Theta} = \sum_{i}^{3} \widehat{K}_{i}^{2} \omega_{i}^{\rho} - \frac{1}{2} \sum_{i}^{3} K_{i}^{2} \widehat{\rho}
$$

$$
\int_{M} \widehat{\Theta} \wedge \widehat{\rho} = \int_{M} \sum_{i} \left(\widehat{K}_{i}^{2} \mathrm{d} \mathrm{vol}_{\rho} - \frac{1}{2} K_{i}^{2} \widehat{\rho} \wedge \widehat{\rho} \right),
$$

where $\widehat{K}_i = \frac{\omega_i^{\rho} \wedge \widehat{\rho}}{\text{dvol}_{\rho}}$ $\frac{\omega_i^{\rho}\wedge\widehat{\rho}}{\mathrm{d}\mathrm{vol}_{\rho}},\ \rho(J_i^{\rho})$ $i^{\rho}(\cdot,\cdot) := \rho(\cdot, J_i \cdot)$ and $\omega_i^{\rho} = \omega_i - K_i \rho$. From (i) we have

$$
\mathcal{H}_{\rho}(\widehat{\rho}) = \int_{M} \widehat{\Theta} \wedge \widehat{\rho} - \int_{M} \widehat{\rho} \wedge \iota(X_{\text{grad}\mathscr{E}}) g \wedge \iota(X)\rho
$$

$$
+ \int_{M} g \left(\nabla_{X} X_{\text{grad}\mathscr{E}}, X\right) d\text{vol}_{\rho}
$$

$$
=: \int_{M} \widehat{\Theta} \wedge \widehat{\rho} + D + E.
$$

By Lemma [7](#page-7-1) we have $X_{\text{grad}\mathscr{E}} = -\sum_i J_i X_{K_i}$. Therefore

$$
D = -\int_M \widehat{\rho} \wedge \iota(X_{\text{grad}\mathscr{E}}) g \wedge \iota(X)\rho = \int_M \sum_i \iota(X_{K_i}) \omega_i \wedge \iota(X) \rho \wedge \widehat{\rho}
$$

and

$$
E = \int_M g(\nabla_X X_{\text{grad}\mathscr{E}}, X) \, d\text{vol}_\rho = \int_M \sum_i \omega_i(X, \nabla_X X_{K_i}) \, d\text{vol}_\rho.
$$

It now follows from Lemma 4.3 in [\[2\]](#page-11-0) that

$$
\mathcal{H}_{\rho}(\widehat{\rho}) = \int_{M} \sum_{i} \left(\widehat{K}_{i}^{2} \text{dvol}_{\rho} - \frac{1}{2} K_{i}^{2} \widehat{\rho} \wedge \widehat{\rho} \right) + D + E
$$

=
$$
\int_{M} \sum_{i} \left(\widehat{H}_{i}^{2} \text{dvol}_{\rho} + \omega_{i} \left(X, \nabla_{X_{K_{i}}} X \right) \right) \text{dvol}_{\rho}.
$$

This proves (iii) and the theorem.

Remark 9. The Hessian operator $\mathcal{H}: T_{\rho}\mathscr{S}_a \to T_{\rho}\mathscr{S}_a$ given by [\(9\)](#page-8-0) is a nonlocal differential operator of degree two. It is non-local because of the last term di($\nabla_X X_{\text{grad}S}$) ρ , which involves solving the equation

$$
-dt(X)\rho = \widehat{\rho}, \qquad *^{\rho} \iota(X)\rho \in \text{im}d
$$

for the associated vector field X of $\widehat{\rho}$. Its leading term

$$
-d *^{\rho} d\widehat{\Theta} = -d *^{\rho} d \left(\frac{\widehat{\rho} + *^{\rho} \widehat{\rho}}{u} - \left| \frac{\rho^{+}}{u} \right|^{2} \widehat{\rho} \right)
$$

$$
= -2d \frac{*^{\rho}}{u} d\widehat{\rho}^{+\rho} + d *^{\rho} \left(\frac{du}{u^{2}} \wedge (\widehat{\rho} + *^{\rho} \widehat{\rho}) \right) + d *^{\rho} \left(d \left| \frac{\rho^{+}}{u} \right|^{2} \wedge \widehat{\rho} \right)
$$

$$
= (d^{*^{\rho}} \frac{1}{u} d + d \frac{1}{u} d^{*\rho}) \widehat{\rho} + d *^{\rho} \left(\frac{du}{u^{2}} \wedge (\widehat{\rho} + *^{\rho} \widehat{\rho}) \right)
$$

$$
+ d *^{\rho} \left(d \left| \frac{\rho^{+}}{u} \right|^{2} \wedge \widehat{\rho} \right)
$$

is an elliptic differential operator.
