

A Proof of Onsager's Conjecture

Abstract

For any $\alpha < 1/3$, we construct weak solutions to the 3D incompressible Euler equations in the class $C_t C_x^\alpha$ that have nonempty, compact support in time on $\mathbb{R} \times \mathbb{T}^3$ and therefore fail to conserve the total kinetic energy. This result, together with the proof of energy conservation for $\alpha > 1/3$ due to [Eyink] and [Constantin, E, Titi], solves Onsager's conjecture that the exponent $\alpha = 1/3$ marks the threshold for conservation of energy for weak solutions in the class $L_t^\infty C_x^\alpha$. The previous best results were solutions in the class $C_t C_x^\alpha$ for $\alpha < 1/5$, due to [Isett], and in the class $L_t^1 C_x^\alpha$ for $\alpha < 1/3$ due to [Buckmaster, De Lellis, Székelyhidi], both based on the method of convex integration developed for the incompressible Euler equations by [De Lellis, Székelyhidi]. The present proof combines the method of convex integration and a new "gluing approximation" technique. The convex integration part of the proof relies on the "Mikado flows" introduced by [Daneri, Székelyhidi] and the framework of estimates developed in the author's previous work.

Part I

Introduction

In this work, we consider weak solutions to the 3D incompressible Euler equations (posed on a periodic domain), which we write using the Einstein summation convention and in divergence form as

$$\begin{aligned}\partial_t v^\ell + \nabla_j (v^j v^\ell) + \nabla^\ell p &= 0 \\ \nabla_j v^j &= 0\end{aligned}\tag{1}$$

For continuous velocity and pressure fields $v : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}^3$, $p : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}$, being a weak solution to (1) is equivalent to (1) holding in the sense of distributions, or to the equations

$$\frac{d}{dt} \int_{\Omega} v(t, x) dx = \int_{\partial\Omega} v(t, x) (v \cdot n) dS + \int_{\partial\Omega} p(t, x) n dS\tag{2}$$

$$\int_{\partial\Omega} v(t, x) \cdot n(x) dS = 0\tag{3}$$

holding (as continuous functions of $t \in \mathbb{R}$) for all smooth subregions $\Omega \subseteq \mathbb{T}^3$, where $n = n(x)$ is the inward unit normal vector field on the boundary $\partial\Omega$, and $dS = dS(x)$ is the surface measure on the boundary. Equations (2)-(3) express the balance of momentum and balance of mass for the portion of an incompressible fluid occupying the region Ω , and they are equivalent to (1) holding pointwise for solutions that are continuously differentiable. More detailed discussions of the concept of a weak solution and its physical meaning can be found in [DLS13a].

For C^1 solutions to (1) on a periodic domain, one can prove that any solution on a time interval I is uniquely determined by its values $v(t_0, x)$ at a single initial time $t_0 \in I$, and that the total kinetic energy $:= \int_{\mathbb{T}^3} \frac{1}{2} |v|^2(t, x) dx$ is a constant function of time (i.e., v conserves energy). However, the simple proofs of these results do not apply to weak solutions, and in fact it has been known since the startling discovery of Sheffer [Sch93] and later works of [Shn97, Shn00] that general distributional solutions to (1) in the class $v \in L^2_{t,x}(\mathbb{R} \times \mathbb{R}^2)$ may fail to be unique, may fail to conserve energy, and may even have compact support or have strictly decreasing total kinetic energy.

A longstanding open question has been to determine what degree(s) of regularity must be assumed to guarantee uniqueness or conservation of energy for weak solutions to (1). A folklore conjecture is that uniqueness should fail when $v \in C^1$ is replaced by $v \in C_t C_x^\alpha$ for some $\alpha < 1$. Regarding the conservation of energy, one has the following conjecture, which originates from a 1949 paper by the physicist and chemist Lars Onsager [Ons49]:

Conjecture 1 (Onsager’s Conjecture, Positive Direction). *If $\alpha > 1/3$, then (on a periodic domain and a time interval I), every weak solution to (1) that satisfies the Hölder condition*

$$|v(t, x + \Delta x) - v(t, x)| \leq C |\Delta x|^\alpha, \quad \text{for all } t \in I, \Delta x \in \mathbb{R}^3\tag{4}$$

for some $C \geq 0$ must satisfy the conservation of energy (i.e. $\int_{\mathbb{T}^3} \frac{1}{2} |v|^2(t, x) dx$ is constant in time).

Conjecture 2 (Onsager’s Conjecture, Negative Direction). *For every $\alpha < 1/3$, there exist (periodic) weak solutions to (1) that satisfy (4) (in other words, $v \in L^\infty_t C_x^\alpha$) such that the conservation of energy fails (i.e., $\int_{\mathbb{T}^3} \frac{1}{2} |v|^2(t, x) dx$ fails to be constant in time).*

Onsager’s interest in the possibility of Conjecture 2 came from an effort to explain the primary mechanism driving “anomalous dissipation of energy” in turbulence in terms of “energy cascades” that are modeled by the advective term present in the incompressible Euler equations rather than

the viscosity that is present in the Navier-Stokes equations. He asserted that Conjecture 1 was true to emphasize that, if anomalous dissipation of energy were indeed possible for solutions to the Euler equations, one would have to consider solutions with low regularity. (Onsager’s notion of “weak solution” was based on an equivalent definition in terms of Fourier series.) For further discussion of Onsager’s conjecture and its significance in turbulence theory we refer to [DLS13a, ES06, BT13, Shv10]. See also [CSF12] and the references therein for work on model equations for the energy cascade in the Navier-Stokes equations.

Following the proof of a slightly weaker version of Conjecture 1 by [Eyi94], the positive direction of Onsager’s conjecture was proven by [CET94] using a very short argument. The sharpest result available, obtained in [CCFS08], proves conservation of energy for solutions in the class $L_t^3 B_{3,c(\mathbb{N})}^{1/3} \cap C_t L_x^2$ (on either \mathbb{T}^n or \mathbb{R}^n) where $B_{3,c(\mathbb{N})}^{1/3}$ denotes the closure of C_c^∞ in the Besov space¹ $B_{3,\infty}^{1/3}$. This result allows for the possibility that the failure of energy conservation in Conjecture 2 may also hold in the endpoint case $\alpha = 1/3$, and [Eyi94, CCFS08] provide examples that suggests that fluctuations in kinetic energy should indeed be possible for $\alpha = 1/3$. We refer also to [DR00, Shv09, IO16, CLFNLS15, RRS16] for extensions of these results and alternative proofs.

The first results towards the negative direction of Onsager’s conjecture came in a breakthrough series of papers by De Lellis and Székelyhidi [DLS13b, DLS14] wherein the authors proved that the failure of energy conservation in Conjecture 2 is possible for solutions in $L_t^\infty C_x^\alpha$ if $\alpha < 1/10$. To achieve this result, the authors adapted a method known as “convex integration” – which has its origins in the work of Nash on constructing paradoxical C^1 isometric embeddings [Nas54] – to the (very different) setting of the incompressible Euler equations (1) (see the survey [DLS15] for a thorough discussion). Their method involves explicitly constructing the velocity field v by adding a series of increasingly high frequency, divergence free waves that are specially designed as perturbations of a family of stationary solutions to 3D Euler known as “Beltrami flows”. See [CDLS12, Cho13] for extensions to dimension 2.

In [Ise13b], the author introduced improvements to the convex integration scheme of [DLS13b, DLS14] to establish Conjecture 2 in the range $\alpha < 1/5$. (See also [BDLS13, BDLIS15] for a shorter proof that includes a result on the existence of anomalous dissipation.) A central theme of the above improvements concerns how to deal with the transport of high frequency waves in the construction by a low frequency velocity field, and the importance of improved estimates for the advective derivative $\partial_t + v \cdot \nabla$ as part of improving the regularity of the scheme. In [Ise13b], the author also presented a conjectural “Ideal Case Scenario” that would imply Onsager’s conjecture, and investigated the potential for convex integration to achieve this scenario if the method could be sufficiently improved.

Another direction of research aimed at improvements towards Conjecture 2 in weaker topologies was initiated by the work of Buckmaster [Buc15], who constructed $C_t C_x^{1/5-\epsilon}$ solutions that fail to conserve energy such that for almost every $t \in \mathbb{R}$ the velocity field has Onsager critical spatial regularity $v(t, \cdot) \in C_x^{1/3-\epsilon}$. Using a more involved construction, Buckmaster, De Lellis and Székelyhidi [BDLS16] improved this result to obtain continuous solutions in the class $v \in L_t^1 C_x^{1/3-\epsilon}$ (which means that (4) holds with $\alpha = 1/3 - \epsilon$ not for all $t \in I$, but with a constant $C(t)$ depending on time such that $\int_I |C(t)| dt < \infty$). A possible target of this direction of research suggested in [BDLS16] could be to obtain solutions in a class such as $v \in L_t^3 C_x^{1/3-\epsilon}$, as this class would be borderline with the L^3 type spaces $L_t^3 B_{3,c_0(\mathbb{N})}^{1/3}$ in which one is able to prove energy conservation as in [CET94, CCFS08]. However, obtaining improvements in the uniform topologies $L_t^\infty C_x^\alpha$ – with respect to which Conjecture 2 is formulated above – appears to be far out of reach of these methods.

Our main theorem is the following, which implies a complete solution to the negative direction of Onsager’s conjecture, Conjecture 2.

¹Functions in $B_{3,\infty}^{1/3}$ have, roughly speaking, $1/3$ of a derivative in the spatial variables in a sense measured by an L^3 type norm, rather than the supremum type bound in (4). See [CCFS08] for a precise definition.

Theorem 1. *For any $\alpha < 1/3$, there is a nonzero weak solution to incompressible Euler in the class²*

$$v \in C_{t,x}^\alpha(\mathbb{R} \times (\mathbb{R}/\mathbb{Z})^3), p \in C_{t,x}^{2\alpha}(\mathbb{R} \times (\mathbb{R}/\mathbb{Z})^3)$$

such that v is identically 0 outside a finite time interval. In particular, the solution v above fails to conserve energy.

The strategy of proof for Theorem 1 will be to construct an iteration scheme that establishes the key estimates of the Ideal Case Scenario conjectured in [Ise13b, Sections 10, 13]. As in the previous works on Onsager’s conjecture described above, a large part of this iteration scheme will be based on the method of convex integration. We will rely in particular on the framework of estimates developed in [Ise13b], which had been designed originally to potentially achieve the Ideal Case Scenario.

One of the main difficulties in convex integration is how to control the interference terms that arise when different high frequency waves in the construction interact with each other through the nonlinear term in the equation. Following a suggestion of P. Constantin, the idea in [DLS13b, DLS14] that turned out to be key for addressing this difficulty was to find a way to design high frequency waves in the construction using “Beltrami flows” – a certain family of stationary solutions to 3D incompressible Euler. A version of these Beltrami flows (modified to be well-adapted to the ambient velocity field of the construction) also played a key role in the proof in [Ise13b], but in that treatment they suffered a deficiency that controlling the high frequency interference terms between Beltrami flows required very sharp cutoffs in time that ultimately limited the regularity of the construction to $1/5$ rather than $1/3$.

A key idea in the convex integration part of this work, which comes from a recent paper of Daneri and Székelyhidi [DS16], is to use Mikado flows as an alternative to Beltrami flows to build the waves in the construction. Mikado flows (see Section 11 below), are stationary solutions to Euler built by adding together “straight-pipe” flows supported in disjoint cylinders that point in multiple directions. The key difference between Mikado flows and Beltrami flows is that a Mikado flow on its own does not generate unacceptable error terms over a sufficiently long time scale, even when it is made to be well-adapted to the ambient velocity field as was done in [DS16]. The main difficulty in using Mikado flows to improve the regularity of solutions is that there seems to be no way to control the interference terms that arise when *distinct* Mikado flow-based waves interact with each other over the time scale one requires to improve the regularity. For the h-principle application in [DS16], it was sufficient to use only a single Mikado flow-based wave, and so no interaction terms were present; however, to produce solutions using an iterative convex integration scheme, one requires an unbounded number of waves, since the time scale during which each high-frequency wave remains coherent shrinks to zero as the frequencies become large. To improve on the regularity $1/5$, one must be able to control the interference between these waves over a sufficiently long time scale.

Our new method to address this difficulty of distinct wave interference is the following. Applying convex integration directly would mean generating a sequence of Euler-Reynolds flows $(v, p, R)_{(k)}$ (see Definition 2.1 below), where the k ’th error in solving the Euler equation, called $R_{(k)}$, tends to 0 uniformly and has compact support in time contained in an interval (say, $[0, 1]$). Given $(v, p, R)_{(k)}$, we first find a new Euler-Reynolds flow $(\tilde{v}, \tilde{p}, \tilde{R})_{(k)}$ that is an acceptably small perturbation of the original $(v, p, R)_{(k)}$ obeying essentially the same estimates, such that the new error \tilde{R} decomposes as a sum $\tilde{R} = \sum_I R_I$ such that the R_I are supported in short time intervals that are well-separated from each other. This technique seems related to the construction in [Shn97]. After this procedure (which we call a “gluing approximation technique”), we can apply convex integration to $(\tilde{v}, \tilde{p}, \tilde{R})_{(k)}$ by using a single Mikado-flow based wave to eliminate each R_I up to a small error that is consistent with the Ideal Case Scenario. The distinct Mikado flow-based waves will not interact at all in the convex integration due to their supports being well-separated in time.

²We write $f \in C_{t,x}^\alpha$ if there exists $C \geq 0$ such that $|f(t + \Delta t, x + \Delta x) - f(t, x)| \leq C(|\Delta t| + |\Delta x|)^\alpha$ uniformly in $t, x, \Delta t, \Delta x$.

The challenge of this technique is to construct the $(\tilde{v}, \tilde{p}, \tilde{R})_{(k)}$ such that all of the desired estimates will hold over the desired time scale (which is relatively long). Our method for proving the existence and necessary estimates for the new $(\tilde{v}, \tilde{p}, \tilde{R})$ exploits a special structure in the linearization of the Euler and Euler-Reynolds equations to achieve this goal. This important structure is highlighted in more detail towards the end of Section 7 below.

With the confirmation of Onsager’s conjecture in the standard formulation of Conjecture 2 now completed by Theorem 1, we note that there are several natural generalizations of Conjecture 2 that have been considered in previous work and remain interesting open questions. Most immediately, Conjecture 2 should extend as well to dimensions $d \geq 2$ and to general, nonperiodic domains including the whole space. Our proof extends readily to dimensions $d \geq 3$, but leaves open the case³ $d = 2$ due to the lack of a suitable replacement for Mikado flows. Our proof also does not produce finite energy solutions⁴ in \mathbb{R}^3 due mainly to analysis related to the gluing approximation technique. Further open questions include the extension of Onsager’s conjecture to more general fluid equations including active scalar equations and the Boussinesq equation considered in [CFG11, Shv11, IV15, TZ15, TZ17] and a version of Onsager’s conjecture for the steady state Euler equations considered in [LS15, CS14, Shv17].

1 Organization of Paper

The Main Lemma of the paper is stated as Lemma 2.1 below after some preliminary general notation introduced in Section 2. In Section 3, we introduce the three Main Sublemmas of the paper (The Regularization Lemma, the Gluing Approximation Lemma, and the Convex Integration Lemma) and show that they imply the Main Lemma. Section 4 contains the proof of the Regularization Lemma. The proof of the Gluing Approximation Lemma occupies Sections 5-10.5. The proof of the Convex Integration Lemma occupies Sections 11-17.6. The proof of Theorem 1 using the Main Lemma is then given in Section 18. The Appendix provides proofs or statements of analytical facts that were used in the proofs of the Main Sublemmas of the paper.

2 Notation and Preliminaries

If $x \in \mathbb{R}$, we will write $(x)_+ = \max\{x, 0\}$. We will make use of the following “counting inequality”, which is stated as Lemma 17.1 in [Ise17] and can be shown by induction on m

$$\sum_{i=1}^m (x_i - y)_+ \leq \left(\sum_{i=1}^m x_i - y \right)_+, \quad \text{for all } x_1, x_2, \dots, x_m, y \geq 0 \quad (2.1)$$

We will use the Einstein summation convention to sum over indices that are repeated; for example $\nabla_j v^j = \sum_{j=1}^3 \nabla_j v^j$ is the divergence of a vector field v . Indices are raised or lowered to distinguish covariant and contravariant indices as in the conventions of invariant index notation. The summation

³The best result recorded for the two-dimensional case is the existence of $(1/10-\epsilon)$ -Hölder solutions given in [CDLS12]. convention will be used only to pair a raised index and a lowered index. We will write \mathcal{S} to denote the subspace of $\mathbb{R}^3 \otimes \mathbb{R}^3$ consisting of symmetric $(2, 0)$ tensors.

For partial derivatives, we will distinguish between multi-indices and first order indices by writing a multi-index in vector form. For instance, if $\vec{a} = (a_1, a_2, a_3)$ is a multi-index of order $|\vec{a}| = 3$, then $\nabla_{\vec{a}} = \nabla_{a_1} \nabla_{a_2} \nabla_{a_3}$ is the corresponding third-order partial derivative. In contrast, ∇_a without a vector symbol denotes the first order, a 'th partial derivative. The full derivative of a tensor will be denoted using a superscript; for example $\nabla^k f$ refers to the full, k th derivative of a function f , which takes values in the k -fold tensor product of $(\mathbb{R}^3)^*$.

In what follows we will refer to functions $f : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}$ or $f : \mathbb{T}^3 \rightarrow \mathbb{R}$, but the discussion in this section generalizes immediately to vector fields and tensor fields taking values in \mathbb{R}^n .

For functions $f : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}$, we will use the following notation to describe their time support

$$\text{supp}_t f := \{t \in \mathbb{R} : \text{supp } f \cap \{t\} \times \mathbb{T}^3 \neq \emptyset\}$$

For simplicity, we refer to a function $f : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}$ of space and time as **smooth** if all of its spatial derivatives are continuous on $\mathbb{R} \times \mathbb{T}^3$ (which implies $f \in \bigcap_{k \geq 0} C_t C_x^k(\mathbb{R} \times \mathbb{T}^3)$). We will write C^∞ or $C^\infty(\mathbb{R} \times \mathbb{T}^3) = \bigcap_{k \geq 0} C^k(\mathbb{R} \times \mathbb{T}^3)$ to refer to the usual class of infinitely differentiable functions. The distinction between the two can be safely neglected in reading the argument since all the functions involved that are required in the course of the proof to be “smooth” will in fact be C^∞ ; however, the higher differentiability in time will not be as important.

If $f : \mathbb{T}^3 \rightarrow \mathbb{R}$, we will write $u = \Delta^{-1} f$ to mean the unique function $u : \mathbb{T}^3 \rightarrow \mathbb{R}$ solving

$$\Delta u = (1 - \Pi_0)f, \quad \int_{\mathbb{T}^3} u(x) dx = 0$$

where $\Pi_0 f = |\mathbb{T}^3|^{-1} \int_{\mathbb{T}^3} f(x) dx$ is the average value of f .

Given a subset $S \subseteq \mathbb{R}$ and $\tau \geq 0$, we will denote its τ -neighborhood in \mathbb{R} by

$$N(S; \tau) := \{t + t' : t \in S, |t'| \leq \tau\}$$

If $f : \mathbb{T}^3 \rightarrow \mathbb{R}$ is continuous and $0 < \alpha < 1$, we denote its homogeneous Hölder seminorm by

$$[f]_\alpha = \|f\|_{\dot{C}^\alpha} := \sup_{x \in \mathbb{T}^3} \sup_{h \in \mathbb{R}^3 \setminus \{0\}} \frac{|f(x+h) - f(x)|}{|h|^\alpha} \quad (2.2)$$

For integers $k \geq 0$, a function belongs to $f \in C^{k, \alpha}$ if $f \in C^k(\mathbb{T}^3)$ and $\|\nabla^k f\|_{\dot{C}^\alpha}$ is finite. The mean value theorem leads to the following interpolation inequality

Proposition 2.1. *If $f : \mathbb{T}^3 \rightarrow \mathbb{R}$ is C^1 and $0 < \alpha < 1$, then*

$$\|f\|_{\dot{C}^\alpha} \lesssim_\alpha \|\nabla f\|_{\dot{C}^0}^\alpha \|f\|_{\dot{C}^0}^{(1-\alpha)} \quad (2.3)$$

Part II

The Main Lemma and Sublemmas

To state the Main Lemma, we first recall the concept of an Euler-Reynolds flow from⁵ [DLS13b] and define the notion of frequency-energy levels that will be used in our paper.

⁵In [DLS13b] the definition is given in an equivalent form where $R^{j\ell}$ is required to have 0 trace $\delta_{j\ell} R^{j\ell} = 0$ pointwise.

Definition 2.1. A vector field $v^\ell : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}^3$, function $p : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R}$ and symmetric tensor field $R^{j\ell} : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathcal{S}$ satisfy the **Euler Reynolds Equations** if

$$\begin{aligned}\partial_t v^\ell + \nabla_j (v^j v^\ell) + \nabla^\ell p &= \nabla_j R^{j\ell} \\ \nabla_j v^j &= 0\end{aligned}$$

on $\mathbb{R} \times \mathbb{T}^3$. Any solution to the Euler-Reynolds equations (v, p, R) is called an **Euler-Reynolds Flow**. The symmetric tensor field $R^{j\ell}$ is called the **stress tensor**.

Our notion of frequency energy levels will be based on the one introduced in [Ise17], but simpler in that we do not assume control over the pressure gradient or over the advective derivative of R . This simplification ultimately arises due to a special feature of the gluing approximation technique summarized in Lemma 3.2 below, which is that the stress tensor \tilde{R} arising from the gluing approximation technique turns out to exhibit a suitable estimate on its advective derivative even if the starting Euler-Reynolds flow does not satisfy such a bound. This feature of the argument will also allow us to circumvent the use of the mollification on the flow technique introduced in [Ise17, Section 18], which would otherwise have been needed within the convex integration part of the proof.

Definition 2.2. Let (v, p, R) be a solution of the Euler-Reynolds equation, $\Xi \geq 3$ and $e_v \geq e_R \geq 0$ be non-negative numbers. We say that (v, p, R) have **frequency-energy levels** bounded by (Ξ, e_v, e_R) to order L in C^0 if their spatial derivatives $\nabla^k v$ and $\nabla^k R$ of order k are continuous for all $k \leq L$ and the following estimates hold

$$\|\nabla^k v\|_{C^0} \leq \Xi^k e_v^{1/2}, \quad \text{for all } 1 \leq k \leq L \quad (2.4)$$

$$\|\nabla^k R\|_{C^0} \leq \Xi^k e_R, \quad \text{for all } 0 \leq k \leq L \quad (2.5)$$

The Main Lemma of our paper states the following

Lemma 2.1 (The Main Lemma). *Let $L = 3$ and $\eta > 0$. There exists a constant C depending only on η such that the following holds. Let (v, p, R) be any solution of the Euler-Reynolds equation with frequency-energy levels bounded by (Ξ, e_v, e_R) to order L in C^0 and let J be an open subinterval of \mathbb{R} such that (recalling the notation of Section 2)*

$$\text{supp}_t v \cup \text{supp}_t R \subseteq J.$$

Define the parameter $\widehat{\Xi} = \Xi(e_v/e_R)^{1/2}$. Let N be any positive number obeying the conditions

$$N \geq \max\{\Xi^\eta, (e_v/e_R)^{1/2}\} \quad (2.6)$$

Then there exists a solution (v_1, p_1, R_1) of Euler-Reynolds with frequency-energy levels bounded by

$$(\Xi', e'_v, e'_R) = \left(CN\Xi, \log \widehat{\Xi} e_R, (\log \widehat{\Xi})^{5/2} \frac{e_v^{1/2} e_R^{1/2}}{N} \right) \quad (2.7)$$

such that

$$\text{supp}_t v_1 \cup \text{supp}_t R_1 \subseteq N(J; \Xi^{-1} e_v^{-1/2}) \quad (2.8)$$

and such that the correction $V = v_1 - v$ obeys the bounds

$$\|V\|_{C^0} \leq C(\log \widehat{\Xi})^{1/2} e_R^{1/2} \quad (2.9)$$

$$\|\nabla V\|_{C^0} \leq CN\Xi(\log \widehat{\Xi})^{1/2} e_R^{1/2}, \quad (2.10)$$

Lemma 2.1 will follow from a combination of three Main Sublemmas that we will describe in the following Section 3. The proof of Lemma 2.1 assuming these sublemmas will be included at the end of Section 3.

3 The Main Sublemmas

Here we state the three sublemmas that together will imply our Main Lemma, Lemma 2.1.

Lemma 3.1 (The Regularization Lemma). *There is an absolute constant C_0 such that the following holds. Let (v_0, p_0, R_0) be an Euler-Reynolds flow with frequency-energy levels bounded by (Ξ, e_v, e_R) to order 3 in C^0 such that $\text{supp}_t v_0 \cup \text{supp}_t R_0 \subseteq J$. Define $\widehat{N} := (e_v/e_R)^{1/2}$. Then there exists an Euler-Reynolds flow (v, p, R) such that $\text{supp}_t v \cup \text{supp}_t R \subseteq J$ that obeys the estimates*

$$\|\nabla^k v\|_{C^0} \leq C_0 \widehat{N}^{(k-3)+} \Xi^k e_v^{1/2}, \quad k = 1, \dots, 5 \quad (3.1)$$

$$\|\nabla^k R\|_{C^0} \leq C_0 \widehat{N}^{(k-2)+} \Xi^k e_R, \quad k = 0, \dots, 5 \quad (3.2)$$

$$\|v - v_0\|_{C^0} \leq C_0 e_R^{1/2} \quad (3.3)$$

Furthermore, one can arrange that $v, R \in \bigcap_{k \geq 0} C_t C_x^k$ are smooth.

Lemma 3.2 (The Gluing Approximation). *For any $C_0 \geq 1$ there exist positive constants $C_1 \geq 1$ and $\delta_0 \in (0, 1/25)$ such that the following holds. Let (v, p, R) be a smooth Euler-Reynolds flow that satisfies the estimates (3.1)-(3.2) for C_0 and $\text{supp}_t v \cup \text{supp}_t R \subseteq J$. Define $\widehat{\Xi} := \widehat{N} \Xi = \Xi (e_v/e_R)^{1/2}$. Then for any $0 < \delta \leq \delta_0$ there exist: a constant $\widetilde{C}_\delta \geq 1$, a constant $\theta > 0$, a sequence of times $\{t(I)\}_{I \in \mathbb{Z}} \subseteq \mathbb{R}$ and an Euler-Reynolds flow $(\tilde{v}, \tilde{p}, \tilde{R})$, $\tilde{R} = \sum_{I \in \mathbb{Z}} R_I$, that satisfy the following support restrictions*

$$\text{supp}_t \tilde{v} \cup \text{supp}_t \tilde{R} \subseteq N(J; \frac{1}{3} \Xi^{-1} e_v^{-1/2}) \quad (3.4)$$

$$2^{-1} \delta (\log \widehat{\Xi})^{-2} \Xi^{-1} e_v^{-1/2} \leq \theta \leq \delta (\log \widehat{\Xi})^{-2} \Xi^{-1} e_v^{-1/2} \quad (3.5)$$

$$\text{supp}_t R_I \subseteq \left[t(I) - \frac{\theta}{2}, t(I) + \frac{\theta}{2} \right] \quad (3.6)$$

$$\bigcup_I \bigcup_{I' \neq I} [t(I) - \theta, t(I) + \theta] \cap [t(I') - \theta, t(I') + \theta] = \emptyset \quad (3.7)$$

and the following estimates

$$\|\tilde{v} - v\|_{C^0} \leq C_1 e_R^{1/2} \quad (3.8)$$

$$\|\nabla^k \tilde{v}\|_{C^0} \leq C_1 \Xi^k e_v^{1/2}, \quad k = 1, 2, 3 \quad (3.9)$$

$$\sup_I \|\nabla^k R_I\|_{C^0} \leq \widetilde{C}_\delta \widehat{N}^{(k-2)+} \Xi^k \log \widehat{\Xi} e_R, \quad k = 0, 1, 2, 3 \quad (3.10)$$

$$\sup_I \|\nabla^k (\partial_t + \tilde{v} \cdot \nabla) R_I\|_{C^0} \leq \widetilde{C}_\delta (\log \widehat{\Xi})^3 \Xi e_v^{1/2} \Xi^k e_R, \quad k = 0, 1, 2. \quad (3.11)$$

Lemma 3.3 (The Convex Integration Lemma). *There exists an absolute constant b_0 such that for any $C_1, \widetilde{C}_\delta \geq 1$ and $\delta, \eta > 0$ there is a constant $\tilde{C} = \tilde{C}_{\eta, \delta, C_1, \widetilde{C}_\delta}$ for which the following holds. Suppose J is a subinterval of \mathbb{R} and (v, p, R) is an Euler-Reynolds flow, $R = \sum_I R_I$, that satisfy the conclusions (3.4)-(3.7) and (3.9)-(3.10) of Lemma 3.2 (with (\tilde{v}, \tilde{R}) replaced by (v, R)) for some (Ξ, e_v, e_R) , some $\theta > 0$ and some sequence of times $\{t(I)\}_{I \in \mathbb{Z}} \subseteq \mathbb{R}$. Suppose also that*

$$|\theta| \|\nabla v\|_{C^0} \leq b_0. \quad (3.12)$$

Let $N \geq \max\{\Xi^\eta, (e_v/e_R)^{1/2}\}$. Then there is an Euler-Reynolds flow (v_1, p_1, R_1) with frequency-energy levels in the sense of Definition 2.2 bounded by

$$(\Xi', e'_v, e'_R) = \left(\tilde{C} N \Xi, \log \widehat{\Xi} e_R, (\log \widehat{\Xi})^{5/2} \frac{e_v^{1/2} e_R^{1/2}}{N} \right) \quad (3.13)$$

such that

$$\text{supp}_t v_1 \cup \text{supp}_t R_1 \subseteq N(J; \Xi^{-1} e_v^{-1/2}) \quad (3.14)$$

$$\|v_1 - v\|_{C^0} \leq \tilde{C}(\log \widehat{\Xi})^{1/2} e_R^{1/2} \quad (3.15)$$

Proof of Lemma 2.1. It is now straightforward to show that Lemmas 3.1, 3.2 and 3.3 together imply Lemma 2.1. Indeed, suppose that (v_0, p_0, R_0) and J are the Euler-Reynolds flow and time interval in the hypotheses of Lemma 2.1 and let N and η be the parameters given in the Lemma. Apply Lemma 3.1 to this (v_0, p_0, R_0) to obtain (v_{01}, p_{01}, R_{01}) obeying the conclusions of that Lemma for the constant C_0 . Let C_1, δ_0 be the constants in Lemma 3.2 associated to C_0 . Choose $\delta > 0$ such that $\delta \leq \delta_0$ and $C_1 \delta \leq b_0$, where b_0 is the absolute constant in Lemma 3.3. Apply Lemma 3.2 with this value of δ to the (v_{01}, p_{01}, R_{01}) above to obtain an Euler-Reynolds flow $(\tilde{v}, \tilde{p}, \tilde{R})$ together with parameters θ, C_δ and $\{t(I)\}_{I \in \mathbb{Z}}$ that satisfy the conclusions Lemma 3.2. Observe also that (3.5) and (3.9) imply

$$|\theta| \|\nabla \tilde{v}\|_{C^0} \leq C_1 \delta \leq b_0.$$

We may therefore apply the Convex Integration Lemma 3.3 to $(\tilde{v}, \tilde{p}, \tilde{R})$ with the parameter N to obtain an Euler-Reynolds flow (v_1, p_1, R_1) and a constant \tilde{C} satisfying the conclusions of that Lemma. Note that this constant \tilde{C} depends only on η since C_0 is an absolute constant and C_1 and therefore δ and C_δ depend only on C_0 . The correction $V = v_1 - v_0$ induced by this combination of Lemmas satisfies (using Definition 2.2 in the last line)

$$\begin{aligned} V &= (v_1 - v_0) = (v_1 - \tilde{v}) + (\tilde{v} - v_{01}) + (v_{01} - v_0) \\ \|V\|_{C^0} &\leq A_0 C_\delta (\log \widehat{\Xi})^{1/2} e_R^{1/2} + C_1 e_R^{1/2} + C_0 e_R^{1/2} \\ \|\nabla V\|_{C^0} &\leq \|\nabla v_1\|_{C^0} + \|\nabla v_0\|_{C^0} \\ &\leq \tilde{C} N \Xi (\log \widehat{\Xi})^{1/2} e_R^{1/2} + \Xi e_v^{1/2} \end{aligned} \quad (3.16)$$

The C^0 term is bounded by $\tilde{C}_0 (\log \widehat{\Xi})^{1/2} e_R^{1/2}$ with \tilde{C}_0 some constant, as stated in Lemma 2.1. The lower bound (2.6) on N implies $e_v^{1/2} \leq N e_R^{1/2}$, so the right hand side of (3.16) is bounded by $C N \Xi (\log \widehat{\Xi})^{1/2} e_R^{1/2}$ for some constant C (depending on η) that we can take to be the one whose existence is asserted in Lemma 2.1. Since the containment (2.8) follows from (3.14), we have proved all the conclusions of Lemma 2.1 for the above (v_1, p_1, R_1) . \square

Part III

The Gluing Sublemmas

In this part of the paper, we prove the two lemmas, Lemmas 3.1 and 3.2, related to the gluing approximation procedure.

4 The Regularization Step

Here we prove the Regularization Lemma 3.1. This Lemma is important for the gluing approximation procedure, as the Gluing Approximation Lemma 3.2 loses spatial regularity. We note that the loss of spatial regularity in the Gluing Approximation Lemma 3.2 is inherent to the gluing argument and is distinct from the separate loss of spatial regularity that occurs during the Convex Integration Lemma 3.3, which is addressed by a different mollification technique.

We start by recalling the following quadratic commutator estimate. Proofs of this statement can be found in [CDLS10, Lemma 1] or [Ise13a, Proposition 5.3].

Proposition 4.1. *Let $\eta \in C^\infty(\mathbb{R}^n)$ satisfy $\int_{\mathbb{R}^n} \eta(h) dh = 1$, $(1 + |h|^2)\eta(h) \in L^1(\mathbb{R}^n)$, and define $\eta_\epsilon(h) := \epsilon^{-n}\eta(h/\epsilon)$. If $f, g \in C^1(\mathbb{R}^n)$, then for all $0 \leq k < \infty$ we have*

$$\|\nabla^k(\eta_\epsilon * (fg) - (\eta_\epsilon * f)(\eta_\epsilon * g))\|_{C^0(\mathbb{R}^n)} \lesssim_k \epsilon^{2-k} \|\nabla f\|_{C^0(\mathbb{R}^n)} \|\nabla g\|_{C^0(\mathbb{R}^n)} \quad (4.1)$$

With Proposition 4.1 in hand, the proof of Lemma 3.2 goes as follows. Given (v_0, p_0, R_0) as in Lemma 3.1, set $v = \eta_\epsilon * v_0$ and $p = \eta_\epsilon * p_0$, then $\epsilon = \widehat{\Xi}^{-1} = \widehat{N}^{-1}\Xi^{-1} = (e_v/e_R)^{-1/2}\Xi^{-1}$. By writing the Euler-Reynolds equations in divergence form

$$\partial_t v_0^\ell + \nabla_j(v_0^j v_0^\ell) + \nabla^\ell p_0 = \nabla_j R_0^{j\ell}, \quad \nabla_j v_0^j = 0$$

we see that (v, p, R) satisfies the Euler-Reynolds equations with a new stress given by

$$R^{j\ell} = [\eta_\epsilon * v_0^j \eta_\epsilon * v_0^\ell - \eta_\epsilon * (v_0^j v_0^\ell)] + \eta_\epsilon * R_0^{j\ell} \quad (4.2)$$

The term $\eta_\epsilon * R^{j\ell}$ is easily seen to obey the desired estimate (3.2). For example,

$$\|\nabla^{k+2} \eta_\epsilon * R_0^{j\ell}\|_{C^0} = \|\nabla^k \eta_\epsilon * \nabla^2 R_0^{j\ell}\|_{C^0} \lesssim_k \widehat{\Xi}^k \Xi^2 e_R = \widehat{N}^k \Xi^{k+2} e_R, \quad k \geq 0,$$

while for $k \leq 2$ we have $\|\nabla^k \eta_\epsilon * R_0^{j\ell}\|_{C^0} = \|\eta_\epsilon * \nabla^k R_0^{j\ell}\|_{C^0} \leq \|\nabla^k R_0^{j\ell}\|_{C^0}$.

Let $Q_\epsilon^{j\ell}$ denote the commutator term in (4.2). By (4.1), we have

$$\|Q_\epsilon\|_{C^0} \lesssim \epsilon^2 \|\nabla v_0\|_{C^0}^2 \leq \widehat{\Xi}^{-2} \Xi^2 e_v = e_R.$$

Also, if $\nabla_{b_1} \nabla_{b_2}$ is any second partial derivative operator, we have

$$\begin{aligned} \nabla_{b_1} \nabla_{b_2} Q_\epsilon^{j\ell} &= \eta_\epsilon * (\nabla_{b_1} \nabla_{b_2} v_0^j) \eta_\epsilon * v_0^\ell - \eta_\epsilon * (\nabla_{b_1} \nabla_{b_2} v_0^j v_0^\ell) \\ &\quad + \eta_\epsilon * (\nabla_{b_1} v_0^j) \eta_\epsilon * (\nabla_{b_2} v_0^\ell) - \eta_\epsilon * (\nabla_{b_1} v_0^j \nabla_{b_2} v_0^\ell) + \text{similar terms} \end{aligned}$$

From this expression and (4.1), our control on $\|\nabla^3 v_0\|_{C^0}$ gives us the desired bound (3.2)

$$\begin{aligned} \|\nabla^{k+2} Q_\epsilon^{j\ell}\|_{C^0} &\lesssim_k \epsilon^{2-k} (\|\nabla^3 v_0\|_{C^0} \|\nabla v_0\|_{C^0} + \|\nabla^2 v_0\|_{C^0}^2) \\ &\lesssim_k \widehat{N}^k \Xi^{k+2} e_R \end{aligned}$$

The desired estimate for $\|\nabla Q_\epsilon\|_{C^0}$ follows by interpolating $\|\nabla Q_\epsilon\|_{C^0} \lesssim \|Q_\epsilon\|_{C^0}^{1/2} \|\nabla^2 Q_\epsilon\|_{C^0}^{1/2}$.

The proof of (3.1) follows similarly to the bounds for $\eta_\epsilon * R_0^{j\ell}$ above. Finally, (3.3) follows from $\|v_0 - \eta_\epsilon * v_0\|_{C^0} \lesssim \epsilon \|\nabla v_0\|_{C^0} \leq e_R^{1/2}$.

5 Proof of Gluing Approximation: Outline

Sections 6-10 below are devoted to the proof of the Gluing Approximation Lemma 3.2. The construction of the new Euler-Reynolds flow $(\tilde{v}, \tilde{p}, \tilde{R})$ is described in Sections 6-8. Section 9 contains preliminary facts that will be used in the estimates in the proof of Lemma 3.2. The main estimates of the gluing construction are carried out over Sections 10.1-10.4. These estimates are then applied in Section 10.5 to establish that the $(\tilde{v}, \tilde{p}, \tilde{R})$ defined in Sections 6-8 does indeed satisfy the estimates claimed in Lemma 3.2.

6 The Gluing Construction

We now begin the proof of the Gluing Approximation Lemma 3.2. In this construction, we will use the notation \lesssim for constants that are allowed to depend on the C_0 of Lemma 3.1, while we will write \lesssim_δ if the constant depends on the δ given in the Lemma 3.2.

Let (v, p, R) be the given Euler-Reynolds flow. We desire a new Euler-Reynolds flow $(\tilde{v}, \tilde{p}, \tilde{R})$ such that the new stress \tilde{R} can be decomposed as a sum $\tilde{R} = \sum_I R_I$ in which each piece is localized in time to a time interval that is smaller than the natural time scale of the construction $|\text{supp}_t R_I| \leq |\theta| \lesssim \Xi^{-1} e_v^{-1/2}$. It is also important that the gap between these supports is comparable to the natural time scale of the construction: $\text{dist}(\text{supp}_t R_I, \text{supp}_t R_{I'}) \geq \Xi^{-1} e_v^{-1/2}$ (although we will ultimately miss this goal by a small margin.)

Since we need $\tilde{R} = 0$ to vanish in the gaps between the intervals supporting each R_I , our new solution \tilde{v} has to solve the Euler equations within those gaps. Thus, we construct \tilde{v} by solving the Euler equations on many time intervals of length 8θ , and gluing the solutions together with the following partition of unity construction.

We introduce the velocity increment y^ℓ and the pressure increment \bar{p} , so that the new solution will be given by $\tilde{v}^\ell = v^\ell + y^\ell$, $\tilde{p} = p + \bar{p}$. The pair (y^ℓ, \bar{p}) must satisfy the equation

$$\begin{aligned} \partial_t y^\ell + v^j \nabla_j y^\ell + y^j \nabla_j v^\ell + \nabla_j (y^j y^\ell) + \nabla^\ell \bar{p} &= \nabla_j \tilde{R}^{j\ell} - \nabla_j R^{j\ell} \\ \nabla_j y^j &= 0 \end{aligned} \tag{6.1}$$

For each $I \in \mathbb{Z}$ set $t_0(I) = 8\theta \cdot I$. Define (u_I^ℓ, p_I) to be the unique classical solution to the incompressible Euler that satisfies the initial condition $u_I^\ell(t_0(I), x) = v^\ell(t_0(I), x)$, where v^ℓ is our given Euler-Reynolds flow. It is well-known (see Theorem 2 below) that, for any $\alpha > 0$, if θ times the $C^{1,\alpha}$ norm of the initial data is sufficiently small, then u_I^ℓ is well-defined and remains smooth on the interval $[t_0(I) - 8\theta, t_0(I) + 8\theta]$. (Our θ will be larger than the reciprocal of $C^{1,\alpha}$ norm of the initial data, but we will nonetheless be able to prove existence.)

Define y_I^ℓ and \bar{p}_I so that $u_I^\ell = v^\ell + y_I^\ell$ and $p_I = p + \bar{p}_I$. Then (y_I^ℓ, \bar{p}_I) solve

$$\begin{aligned} \partial_t y_I^\ell + v^j \nabla_j y_I^\ell + y_I^j \nabla_j v^\ell + \nabla_j (y_I^j y_I^\ell) + \nabla^\ell \bar{p}_I &= -\nabla_j R^{j\ell} \\ \nabla_j y_I^j &= 0 \\ y_I^\ell(t(I), x) &= 0 \end{aligned} \tag{6.2}$$

Now choose a partition of unity in time $(\eta_I(t))_{I \in \mathbb{Z}}$ with the following properties:

$$\begin{aligned} \text{supp}_t \eta_I(t) &\subseteq \left[t_0(I) - \frac{9\theta}{2}, t_0(I) + \frac{9\theta}{2} \right] \\ \eta_I(t) &= 1 \quad \text{if } t \in \left[t_0(I) - \frac{7\theta}{2}, t_0(I) + \frac{7\theta}{2} \right] \\ \text{supp}_t \eta_I \cap \text{supp}_t \eta_{I'} &= \emptyset \quad \text{if } |I - I'| > 1 \\ \sum_I \eta_I(t) &= 1 \quad \text{for all } t \in \mathbb{R} \end{aligned} \tag{6.3}$$

$$\sup_I \sup_t \left| \frac{d^k}{dt^k} \eta_I(t) \right| \lesssim |\theta|^{-k}, \quad k = 0, 1, 2 \tag{6.4}$$

An easy way to construct such a partition of unity is to start with the rough partition of unity given by characteristic functions $\chi_I(t) = 1_{(t_0(I)-4\theta, t_0(I)+4\theta)}(t)$, and then regularize it by mollification to obtain

$\eta_I = \psi_\theta * \chi_I$, with $\psi_\theta(t)$ a smooth mollifier, $\int_{\mathbb{R}} \psi_\theta(t) dt = 1$, with support in $|t| < \frac{\theta}{2}$. Now set

$$y^\ell = \sum_I \eta_I y_I^\ell, \quad \bar{p} = \sum_I \eta_I \bar{p}_I$$

From (6.2) and (6.3), one sees that y^ℓ is divergence free and satisfies

$$\begin{aligned} \partial_t y^\ell + v^j \nabla_j y^\ell + y^j \nabla_j v^\ell + \nabla_j (y^j y^\ell) + \nabla^\ell \bar{p} &= \sum_I \eta'_I(t) y_I^\ell + \sum_I \eta_I \eta_{I+1} \nabla_j (y_I^j y_{I+1}^\ell + y_{I+1}^j y_I^\ell) \\ &\quad + \sum_I (\eta_I^2 - \eta_I) \nabla_j (y_I^j y_I^\ell) - \nabla_j R^{j\ell} \end{aligned} \quad (6.5)$$

For each I , we will choose a **symmetric anti-divergence** for y_I^ℓ , by which we mean a symmetric tensor $r_I^{j\ell}$ verifying

$$\nabla_j r_I^{j\ell} = y_I^\ell \quad (6.6)$$

Now set $t(I) = t_0(I) + 4\theta = (8\theta) \cdot I + 4\theta$, and define

$$\begin{aligned} R_I^{j\ell} &= 1_{[t(I)-\theta, t(I)+\theta]} \eta'_I(t) (r_I^{j\ell} - r_{I+1}^{j\ell}) + \eta_I \eta_{I+1} (y_I^j y_{I+1}^\ell + y_{I+1}^j y_I^\ell) \\ &\quad - \eta_I \eta_{I+1} (y_I^j y_I^\ell + y_{I+1}^j y_{I+1}^\ell) \end{aligned} \quad (6.7)$$

Comparing with (6.5) and using the identities $\eta'_I(t) = 1_{[t(I)+\theta, t(I)-\theta]} \eta'_I(t) - 1_{[t(I-1)+\theta, t(I-1)-\theta]} \eta'_{I-1}(t)$ and $\eta_I(1 - \eta_I) = \eta_I \eta_{I+1} + \eta_{I-1} \eta_I$, we see that our goal equation (6.1) holds for y^ℓ and $\tilde{R}^{j\ell} = \sum_I R_I^{j\ell}$ provided that (6.6) holds for all I .

As for θ , we choose $\theta = \delta(\log \widehat{\Xi})^{-2} \Xi^{-1} e_v^{-1/2}$ so that equality holds for the upper bound in (3.5). However, the lower bound, which strengthens condition (3.7), will be important in the proof of Lemma 3.3).

It is now apparent that the containment (3.4) holds using the condition $\delta < \delta_0 < 1/25$, as $y_I = 0$ for all I such that $\text{supp}_t \eta_I$ intersects the complement of $N(J; \Xi^{-1} e_v^{-1/2})$. This fact follows from uniqueness of classical solutions to incompressible Euler (see Theorem 2 below) and the assumption that $\text{supp}_t R \subseteq J$, which implies that v^ℓ already solves the Euler equations outside of $J \times \mathbb{T}^3$. Also, the conditions (3.5)-(3.7) are apparent from the construction above once we show that the y_I and r_I are well-defined on the supports of the η_I .

Our construction is now complete except that we have not proven that y_I^ℓ exists on the required interval for the above formulas to be well-defined, and we have not defined or proven the existence of the tensors $r_I^{j\ell}$ verifying (6.6). We discuss the construction of $r_I^{j\ell}$ in the following Section 7 below. We will then address the existence of y_I^ℓ in Section 8 below.

7 Constructing a Good Anti-Divergence

In this Section, we discuss our construction of a symmetric anti-divergence for the y_I^ℓ of the gluing construction in Section 6. The construction will involve an operator $\mathcal{R}^{j\ell}$ that we define as follows. Recall that any smooth vector field on \mathbb{T}^n has a ‘‘Helmholtz decomposition’’ such that

$$\begin{aligned} U^\ell &= \mathcal{H}U^\ell + \Pi_0 U^\ell + \nabla^\ell \Delta^{-1} [\nabla_b U^b] \\ \Pi_0 U^\ell &:= \frac{1}{|\mathbb{T}^n|} \int_{\mathbb{T}^n} U^\ell dx \\ \nabla_\ell \mathcal{H}U^\ell &= 0, \quad \int_{\mathbb{T}^n} \mathcal{H}U^\ell dx = 0 \end{aligned} \quad (7.1)$$

Given a smooth vector field U on \mathbb{T}^n , $\mathcal{R}^{j\ell}[U]$ is the smooth, symmetric $(2,0)$ tensor on \mathbb{T}^n defined by

$$\mathcal{R}^{j\ell}[U] = \Delta^{-1}(\nabla^\ell \mathcal{H}U^j + \nabla^j \mathcal{H}U^\ell) + \delta^{j\ell} \Delta^{-1}[\nabla_b U^b] \quad (7.2)$$

Then $\mathcal{R}^{j\ell}$ is an operator (of order -1) that satisfies, for all $U \in C^\infty(\mathbb{T}^n)$,

$$\begin{aligned} \nabla_j \mathcal{R}^{j\ell}[U] &= (1 - \Pi_0)U^\ell \\ \int_{\mathbb{T}^n} \mathcal{R}^{j\ell}[U](x) dx &= 0 \end{aligned} \quad (7.3)$$

In particular, $\mathcal{R}^{j\ell}$ inverts the divergence operator when restricted to integral 0 vector fields. (Other inverses for the divergence can be chosen that would be equivalent for our purposes. This choice has the advantage of having a simple formula.)

Using the operator \mathcal{R} above, one can find a solution to (6.6) by taking $r_I^{j\ell}$ equal to $\mathcal{R}^{j\ell}[y_I]$. Indeed, by the conservation of momentum for Euler and Euler-Reynolds, y_I has integral 0, so we have $\nabla_j \mathcal{R}^{j\ell}[y_I] = y_I$. However, the best estimate one has in general for this solution is $\|\mathcal{R}^{j\ell}[y_I]\|_{C^0} \lesssim \|y_I\|_{C^0}$, which leads to an estimate for the R_I in (6.7) of the form

$$\|R_I\|_{C^0} = \|\eta'_I(t)r_I^{j\ell} + \dots\|_{C^0} \lesssim |\theta|^{-1} \|y_I\|_{C^0} + \dots \quad (7.4)$$

Let us assume now that we are able to prove a bound of the order $\|y_I\|_{C^0} \lesssim e_R^{1/2}$, which is essentially the best estimate we can hope for from (6.2) if we neglect the pressure term. Making this assumption, the right hand side of (7.4) is still even larger than

$$\|R_I\|_{C^0} \lesssim \Xi e_v^{1/2} e_R^{1/2} + \dots$$

However, our goal estimate for $\|R_I\|_{C^0}$ is that $\|R_I\|_{C^0} \lesssim e_R$ should be the same size as the original stress $\|R^{j\ell}\|_{C^0}$, so (7.4) is missing the mark by an enormous factor.

One can do better if one uses the evolution equation for y_I^ℓ . Indeed, writing (6.2) in divergence form, one has

$$\begin{aligned} \partial_t y_I^\ell &= -\nabla_j [v^j y_I^\ell + y_I^j v^\ell + R^{j\ell} + \bar{p}_I \delta^{j\ell}] \\ y_I^\ell(t, x) &= \nabla_j \int_{t(I)}^t [y_I^j(\tau) v^\ell(\tau) + y_I^\ell(\tau) v^j(\tau) + R^{j\ell}(\tau) + \bar{p}_I(\tau) \delta^{j\ell}] d\tau \end{aligned} \quad (7.5)$$

If we take the integral in (7.5) as a definition for $r_I^{j\ell}$ and substitute into (7.4), this construction of an anti-divergence leads to a much better estimate of the form

$$\|R_I\|_{C^0} \lesssim \|y_I\|_{C^0} \|v\|_{C^0} + \dots, \quad (7.6)$$

as the integration over time cancels with the large time cutoff factor in (7.4).

Unfortunately, this bound is still way off the mark $\|R_I\|_{C^0} \lesssim e_R$ that we desire, as the bounds we have are of the order $\|y_I\|_{C^0} \lesssim e_R^{1/2}$ and $\|v\|_{C^0} \lesssim 1$. Another problem with the construction of (7.5) is that it does not lead to a good estimate on the advective derivative $\|(\partial_t + \tilde{v} \cdot \nabla)R_I\|_{C^0}$.

A natural attempt to address the latter problem is to obtain $r_I^{j\ell}$ by solving a transport equation, for instance by solving

$$\begin{aligned} (\partial_t + v^i \nabla_i) \nabla_j r_I^{j\ell} &= (\partial_t + v^i \nabla_i) y_I^\ell \\ r_I^{j\ell}(t(I), x) &= 0 \end{aligned} \quad (7.7)$$

In this way one effectively integrates in time over trajectories to obtain $r_I^{j\ell}$, as opposed to formula (7.5), which integrates in time at a fixed point x . Of course, (7.7) is not a well-defined evolution equation for $r_I^{j\ell}$. However, as was observed in [Ise17], in certain cases one can find solutions to (7.7) by solving another evolution equation related to (7.7) by commuting the divergence and using \mathcal{R} above to invert. Here we will follow a similar approach while taking advantage of the evolution equation for y_I^ℓ .

Commuting $v \cdot \nabla$ in (7.7) with ∇_j and using (6.2), the equation we want to solve (7.7) becomes

$$\nabla_j[(\partial_t + v^i \nabla_i) r_I^{j\ell}] = \nabla_j v^i \nabla_i r_I^{j\ell} - y_I^j \nabla_j v^\ell - \nabla_j (y_I^j y_I^\ell) - \nabla_j (\bar{p}_I \delta^{j\ell}) - \nabla_j R^{j\ell}$$

We therefore construct $r_I^{j\ell}$ as a sum of two parts that solve the following system of equations

$$\begin{aligned} r_I^{j\ell} &= \rho_I^{j\ell} + z_I^{j\ell} \\ (\partial_t + v^i \nabla_i) z_I^{j\ell} &= -y_I^j y_I^\ell - \bar{p}_I \delta^{j\ell} - R^{j\ell} \end{aligned} \tag{7.8}$$

$$(\partial_t + v^i \nabla_i) \rho_I^{j\ell} = \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i (\rho_I^{ab} + z_I^{ab}) - y_I^i \nabla_i v^b] \tag{7.9}$$

$$\rho_I^{j\ell}(t(I), x) = z_I^{j\ell}(t(I), x) = 0 \tag{7.10}$$

Existence of a solution to (7.9) will follow as in the arguments of [Ise17] provided y_I remains regular.

At this point, it is quite unclear that our method has any hope of obtaining a solution $r_I^{j\ell}$ that approaches our desired estimate. Indeed, one of the terms in the estimate for ρ_I from (7.9) is

$$\|\rho_I\|_{C^0} \leq |\theta| \|(\partial_t + v \cdot \nabla) \rho_I^{j\ell}\|_{C^0} \leq |\theta| \|\mathcal{R}^{j\ell} [y_I^i \nabla_i v^b]\|_{C^0} + \dots \tag{7.11}$$

The trivial estimate for (7.11) is $\|\mathcal{R}^{j\ell} [y_I^i \nabla_i v^b]\|_{C^0} \lesssim \|y_I\|_{C^0} \|\nabla v\|_{C^0} \lesssim \Xi e_v^{1/2} e_R^{1/2}$, while a better estimate comes by writing $\|\mathcal{R}^{j\ell} \nabla_i [y_I^i v^b]\|_{C^0} \lesssim \|y_I\|_{C^0} \|v\|_{C^0} + \dots \lesssim e_R^{1/2} + \dots$ (pretending for the moment that the 0th order operator $\mathcal{R}^{j\ell} \nabla_i$ is bounded on C^0). Substituting this bound into (7.4), one obtains the same estimate $\|R_I\|_{C^0} \lesssim e_R^{1/2} + \dots$ from (7.6) that we concluded was insufficient when we considered the construction in (7.5).

The key idea for handling this difficulty is to exploit a special structure in the term $\mathcal{R}^{j\ell} [y_I^i \nabla_i v^b]$ and the incompressible Euler and Euler-Reynolds equations that allows one to prove a much better estimate. Specifically, we observe that the estimates available for y_I and v , even taking into account the incompressibility, cannot by themselves yield any estimate stronger than the bound $\lesssim e_R^{1/2} + \dots$ noted above. The key to obtaining an improved estimate will be to bound this term through a dynamical approach that takes advantage of the structure of the evolution equation for y_I derived from the incompressible Euler and Euler-Reynolds equations. This structure leads ultimately to an essentially ideal bound on the resulting R_I , and holds also for the similar linearized Euler term $\Delta^{-1} \nabla_\ell [y_I^i \nabla_i v^\ell]$ that appears as part of the pressure increment \bar{p}_I in (7.8). The calculations used to estimate these terms are presented in the proof of Proposition 10.2 in Section 10.1 (see the Proof of (10.3), $k = 0$) and in Section 10.4 (see the Proof of (10.37)).

8 Existence Considerations

We now address the existence and well-definedness of the solutions to equations (6.2) and (7.8).

The classical local well-posedness theory for incompressible Euler yields the following result:

Theorem 2. *Let $t_0 \in \mathbb{R}$ and $u_0 : \mathbb{T}^n \rightarrow \mathbb{R}^n$ be a smooth divergence free vector field. Then there exists a unique open interval $\tilde{J} \subseteq \mathbb{R}$ containing t_0 such that there exists a solution $u : \tilde{J} \times \mathbb{T}^n \rightarrow \mathbb{R}^n$ to the*

incompressible Euler equations that is smooth $u \in \bigcap_{k \geq 0} C_t C_x^k$ and for all $T^* \in \partial \tilde{J}$ endpoints of \tilde{J} , we have

$$\limsup_{t \rightarrow T^*, t \in \tilde{J}} \|\nabla u(t)\|_{C^0} = \infty \quad (8.1)$$

Furthermore, the u^ℓ above is unique among solutions to incompressible Euler with the regularity $\nabla u \in C^0(\tilde{J} \times \mathbb{T}^n)$.

See for example [BF76], which gives a lower bound for the time of existence depending on the $C^{1,\alpha}$ norm of the initial data.

Theorem 2 therefore provides, for each I , a unique interval of existence \tilde{J}_I and a unique smooth solution (u_I^ℓ, p_I) on $\tilde{J}_I \times \mathbb{T}^3$ to the incompressible Euler equations that realizes the (smooth, divergence free) initial data $u_I^\ell(t_0(I), x) = v^\ell(t_0(I), x)$.

It follows that $y_I^\ell := u_I^\ell - v^\ell$ and $\bar{p}_I = p_I - p$ are well defined and smooth on $\tilde{J}_I \times \mathbb{T}^3$ (since v^ℓ and p are also smooth on that domain). From this, one has from the theory of regular transport equations (Proposition A.1 in the Appendix) that there is a unique solution $z_I^{j\ell}$ to (7.8), (7.10) that is also smooth and well-defined on $\tilde{J}_I \times \mathbb{T}^3$ (since the velocity v and all the terms on the right hand side of (7.8) are smooth and well-defined on that domain). The initial value problem (7.9)-(7.10) for ρ_I has of the form

$$\begin{aligned} (\partial_t + v \cdot \nabla) \rho_I^{j\ell} &= \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i (\rho_I^{ab}) + Z^b] \\ \rho_I^{j\ell}(t(I), x) &= \rho_{I,0}^{j\ell}(x) \end{aligned} \quad (8.2)$$

where $\rho_{I,0}^{j\ell} = 0$ and Z^b are smooth on $\tilde{J}_I \times \mathbb{T}^3$. The well-posedness of equation (8.2), called a *transport-elliptic equation* due to the presence of \mathcal{R} , has been considered in [Ise17]. It follows from the analysis there (see Theorem 4 in the Appendix below) that there exists a solution ρ_I to (7.9)-(7.10) on $\tilde{J}_I \times \mathbb{T}^3$ that is smooth.

The well-definedness of our construction now follows from Propositions 8.1 and 8.2 below.

Proposition 8.1. *If z_I and ρ_I are smooth solutions to (7.8), (7.9), (7.10) on $\tilde{J}_I \times \mathbb{T}^3$, then the tensor $r_I^{j\ell} = \rho_I^{j\ell} + z_I^{j\ell}$ is a symmetric anti-divergence for y_I^ℓ . That is, equation (6.6) is satisfied on $\tilde{J}_I \times \mathbb{T}^3$.*

Proposition 8.2 (The Gluing Proposition). *Let $\alpha = 1/17$ and C_0 be as in the assumptions of Lemma 3.2. Then there exists $\delta_0 \in (0, 1/25)$ depending on C_0 and there exist implicit constants depending on C_0 such that for all $I \in \mathbb{Z}$ and for $\theta_0 = \delta_0 (\log \hat{\Xi})^{-2} \Xi^{-1} e_v^{-1/2}$ we have*

$$\begin{aligned} [t_0(I) - 8\theta_0, t_0(I) + 8\theta_0] &\subseteq \tilde{J}_I \\ \|\nabla^k y_I\|_{C^0} &\lesssim \hat{N}^{(k-2)_+} \Xi^k e_R^{1/2} \\ \|\nabla^k y_I\|_{\dot{C}^\alpha} &\lesssim \hat{\Xi}^\alpha \hat{N}^{(k-2)_+} \Xi^k e_R^{1/2} \\ \|\nabla^k \rho_I\|_{C^0} + \|\nabla^k z_I\|_{C^0} &\lesssim \hat{N}^{(k-2)_+} \Xi^k \hat{\varepsilon} \\ \|\nabla^k \rho_I\|_{\dot{C}^\alpha} + \|\nabla^k z_I\|_{\dot{C}^\alpha} &\lesssim \hat{\Xi}^\alpha \hat{N}^{(k-2)_+} \Xi^k \hat{\varepsilon} \\ \hat{\varepsilon} &:= \frac{1}{\log \hat{\Xi}} \frac{e_R}{\Xi e_v^{1/2}} \end{aligned} \quad (8.3)$$

where the above estimates hold uniformly in I for $t \in [t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]$ and $k = 0, 1, 2, 3$.

Proposition 8.1 on the equality of $\nabla_j r_I^{j\ell} = y_I^\ell$ is not immediate, but rather relies crucially on the fact that both vector fields y_I^ℓ and v^ℓ are divergence free. We give the following proof:

Proof of Proposition 8.1. Taking the divergence of (7.8), (7.9), relabeling indices and summing gives

$$\begin{aligned}
\nabla_j[(\partial_t + v^i \nabla_i) z_I^{j\ell}] &= -\nabla_j(y_I^j y_I^\ell + \bar{p}_I \delta^{j\ell} + R^{j\ell}) \\
\nabla_j[(\partial_t + v^i \nabla_i) \rho_I^{j\ell}] &= \nabla_j \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i r_I^{jb} - y_I^i \nabla_i v^b] \\
&= \nabla_j \mathcal{R}^{j\ell} \nabla_i [\nabla_a v^i r_I^{jb} - y_I^i v^b] \\
&\stackrel{(7.3)}{=} \nabla_i [\nabla_a v^i r_I^{a\ell} - y_I^i v^\ell] = (1 - \Pi_0) \nabla_i [\nabla_a v^i r_I^{a\ell} - y_I^i v^\ell] \\
&= \nabla_j v^i \nabla_i r_I^{j\ell} - y_I^j \nabla_j v^\ell \\
\nabla_j[(\partial_t + v^i \nabla_i) r_I^{j\ell}] &= \nabla_j v^i \nabla_i r_I^{j\ell} - y_I^j \nabla_j v^\ell - \nabla_j (y_I^j y_I^\ell + \bar{p}_I \delta^{j\ell} + R^{j\ell}) \\
(\partial_t + v^i \nabla_i) \nabla_j r_I^{j\ell} &= (\partial_t + v^j \nabla_j) y_I^\ell
\end{aligned}$$

The vector field $f^\ell = \nabla_j r_I^{j\ell} - y_I^\ell$ is thus a smooth solution to $(\partial_t + v \cdot \nabla) f^\ell = 0$ with initial data $f^\ell(t_0(I), x) = 0$. By uniqueness, f^ℓ is identically 0 and Proposition 8.1 follows. \square

We now turn to the proof of Proposition 8.2.

9 Preliminaries for the Gluing Proposition

In this Section we prepare for the proof of The Gluing Proposition 8.2 by introducing some notation and preparatory lemmas. If T is an operator acting on functions (or tensor fields) on \mathbb{T}^3 (or \mathbb{R}^3), then

$$\|T\| := \inf\{A : \forall f \in C^\infty(\mathbb{T}^3), \|Tf\|_{C^0(\mathbb{T}^3)} \leq A\|f\|_{C^0(\mathbb{T}^3)}\}$$

will denote the operator norm of T , regarded as a bounded operator on $C^0(\mathbb{T}^3)$. If $Tf = K * f$ is a convolution operator⁶ with kernel K

$$K * f(x) = \int_{\mathbb{R}^3} f(x+h) K(h) dh, \quad x \in \mathbb{T}^3$$

then we have a bound

$$\|K * \cdot\| \leq \|K\|_{L^1(\mathbb{R}^3)} \tag{9.1}$$

We will use this inequality only in cases where K is a Schwartz function on \mathbb{R}^3 .

We will employ the Littlewood-Paley decomposition of continuous functions (or tensor fields) with the following notation. Choose a radially symmetric, Schwartz function $\chi : \mathbb{R}^3 \rightarrow \mathbb{R}$ whose Fourier transform $\hat{\chi}(\xi)$ has compact support in the ball of radius 2 in frequency space $\widehat{\mathbb{R}^3}$, and such that $\hat{\chi}(\xi) = 1$ for all $|\xi| \leq 1$. Then $\int_{\mathbb{R}^3} \chi(h) dh = 1$. For $q \in \mathbb{Z}$, set $\chi_{\leq q}(h) = 2^{3q} \chi(2^q h)$, so that $\hat{\chi}_{\leq q} \in C_c^\infty(B_{2^q}(\widehat{\mathbb{R}^3}))$ and $\int_{\mathbb{R}^3} \chi_{\leq q}(h) dh = 1$.

Definition 9.1. For any continuous $f : \mathbb{T}^3 \rightarrow \mathbb{R}^n$, we define

$$\begin{aligned}
P_{\leq q} f(x) &= \int_{\mathbb{R}^3} f(x+h) \chi_{\leq q}(h) dh \\
P_q f(x) &= P_{\leq q} f(x) - P_{\leq q-1} f(x) = \chi_q * f(x) \\
\chi_q &= \chi_{\leq q} - \chi_{\leq q-1}
\end{aligned}$$

We will also use the notation $P_{[q_1, q_2]} f := P_{\leq q_2} f - P_{\leq q_1} f$ and $P_{\approx q} f = P_{[q-2, q+2]} f$. With this definition, we have $P_q f = P_{\approx q} P_q f$.

⁶The standard definition for convolution involves $f(x-h)$ rather than $f(x+h)$, but this minor difference will not be important.

Observe that χ_q defined above is Schwartz and

$$\begin{aligned} \text{supp } \hat{\chi}_q &\subseteq \{2^{q-1} \leq |\xi| \leq 2^{q+1}\} \\ \chi_q(x) &= 2^{3q} \chi_0(2^q x) \end{aligned}$$

Every continuous tensor field f on \mathbb{T}^3 has a decomposition that converges weakly in \mathcal{D}'

$$f(x) = \Pi_0 f + \sum_{q=0}^{\infty} P_q f(x) \quad (9.2)$$

The sum here extends only over $q \geq 0$ because the \mathbb{T}^3 -periodicity causes $P_q f$ to vanish for $q < 0$.

We will employ the following (standard) Littlewood-Paley characterization of the \dot{C}^α seminorm. (See the Appendix for a proof.) This estimate implies that (9.2) converges absolutely in C^0 for $f \in C^\alpha$.

Proposition 9.1. *For all $0 < \alpha < 1$, there exist implicit constants depending on α such that for all $f \in C^0(\mathbb{T}^3)$*

$$\|f\|_{\dot{C}^\alpha(\mathbb{R}^3)} \lesssim_\alpha \sup_{q \in \mathbb{Z}} 2^{\alpha q} \|P_q f\|_{C^0} \lesssim_\alpha \|f\|_{\dot{C}^\alpha(\mathbb{R}^3)} \quad (9.3)$$

Moreover, the inequality $\sup_{q \in \mathbb{Z}} 2^q \|P_q f\|_{C^0} \lesssim \|\nabla f\|_{C^0}$ holds in the case $\alpha = 1$.

The Proposition applies as well to tensor fields on \mathbb{T}^3 . The above Littlewood-Paley characterization of the \dot{C}^α seminorm will help us to control \dot{C}^α seminorms of the solutions to our transport equations when combined with the following well-known commutator estimate. (See the Appendix for a proof.)

Proposition 9.2 (Littlewood-Paley Commutator Estimate). *If $0 < \alpha \leq 1$, then there is an implicit constant depending on α (and the dimension n) such that for any smooth vector field $u \in L^\infty(\mathbb{R}^n)$ and for any smooth function $f \in L^\infty(\mathbb{R}^n)$, we have*

$$\|u \cdot \nabla P_q f - P_q(u \cdot \nabla f)\|_{C^0(\mathbb{R}^n)} \lesssim_\alpha 2^{-\alpha q} \|\nabla u\|_{C^0(\mathbb{R}^n)} \|f\|_{\dot{C}^\alpha(\mathbb{R}^n)}. \quad (9.4)$$

In what follows, all implicit constants in the notation \lesssim are allowed to depend on the parameter C_0 in the bounds assumed in Lemma 3.2, but not on δ . The above Propositions 9.1-9.2 will be employed only for the particular choice of $\alpha = 1/17$ of Proposition 8.2 or $\alpha = 1$. (Any other choice of $\alpha \in (0, 1)$ would also suffice.) If an implicit constant depends on the parameter δ , we will write \lesssim_δ .

With these preliminaries in hand, we are now ready to begin the proof of Proposition 8.2.

10 Proof of the Gluing Proposition

We now prove the Proposition 8.2. The analysis draws some inspiration from the methods in [Ise13a].

We start by defining a dimensionless norm for (y_I, ρ_I, z_I) that controls all the quantities we wish to control in Proposition 8.2. We denote this norm by $\mathfrak{h}(t)$. The norm also depends on I , but we will suppress this dependence for simplicity of notation.

Definition 10.1. For $\alpha = 1/17$, we define the dimensionless norm $\mathfrak{h}(t) : \tilde{\mathcal{J}}_I \rightarrow \mathbb{R}$ by

$$\begin{aligned} \mathfrak{h}(t) &:= \frac{1}{e_R^{1/2}} \left(\sum_{k=0}^3 \frac{\|\nabla^k y_I(t)\|_{C^0}}{\widehat{N}^{(k-2)_+} \Xi^k} \right) \\ &+ \frac{1}{\hat{\varepsilon}} \left(\sum_{k=0}^3 \frac{\|\nabla^k \rho_I(t)\|_{C^0} + \|\nabla^k z_I(t)\|_{C^0}}{\widehat{N}^{(k-2)_+} \Xi^k} \right) \\ &+ \frac{1}{\widehat{\Xi}^\alpha \widehat{N} \Xi^3} \left(\frac{\|\nabla^3 y_I(t)\|_{\dot{C}^\alpha}}{e_R^{1/2}} + \frac{\|\nabla^3 \rho_I(t)\|_{\dot{C}^\alpha} + \|\nabla^3 z_I(t)\|_{\dot{C}^\alpha}}{\hat{\varepsilon}} \right) \end{aligned}$$

The definition of $\hat{h}(t)$ and the interpolation inequality (2.3) imply the following bounds for $t \in \tilde{J}_I$

$$\begin{aligned} \|\nabla^k y_I(t)\|_{C^0} + \hat{\Xi}^{-\alpha} \|\nabla^k y_I(t)\|_{\dot{C}^\alpha} &\lesssim \hat{N}^{(k-2)_+} \Xi^k e_R^{1/2} \hat{h}(t), \quad k = 0, 1, 2, 3 \\ \|\nabla^k \rho_I\|_{C^0} + \|\nabla^k z_I\|_{C^0} + \hat{\Xi}^{-\alpha} (\|\nabla^k \rho_I\|_{\dot{C}^\alpha} + \|\nabla^k z_I\|_{\dot{C}^\alpha}) &\lesssim \hat{N}^{(k-2)_+} \Xi^k \hat{\varepsilon} \hat{h}(t), \quad k = 0, 1, 2, 3 \end{aligned} \quad (10.1)$$

The following Proposition is our main estimate on the growth rate of $\hat{h}(t)$.

Proposition 10.1. *There exists a constant B_1 depending on C_0 such that for all $t \in \tilde{J}_I$,*

$$\hat{h}(t) \leq B_1 (\log \hat{\Xi})^2 \Xi e_v^{1/2} \left| \int_{t_0(I)}^t (1 + \hat{h}(\tau))^2 d\tau \right| \quad (10.2)$$

Our main proposition for the Gluing Lemma, Proposition 8.2, follows quickly from Proposition 10.1 by the following argument.

Proof of Proposition 8.2. For simplicity consider the case $I = 0$ so that $t_0(I) = 0$, and restrict to $t \geq 0$. Set $H(\hat{t}) = 1 + \hat{h}([B_1 (\log \hat{\Xi})^2 \Xi e_v^{1/2}]^{-1} \hat{t})$. Then $H(\hat{t})$ is continuous on the appropriate rescaled interval \hat{J} , and, after changing variable, (10.2) gives the estimate

$$H(\hat{t}) \leq 1 + \int_0^{\hat{t}} H(\hat{\tau})^2 d\hat{\tau}$$

It follows by Bihari's inequality (i.e. the nonlinear Gronwall inequality) that

$$H(\hat{t}) \leq (1 - \hat{t})^{-1} \quad \text{for all } \hat{t} \in \hat{J}$$

Returning to $\hat{h}(t)$, we obtain $1 + \hat{h}(t) \leq 2$ for all $t \in \tilde{J}_I$ such that $0 \leq t \leq \frac{1}{2B_1} (\log \hat{\Xi})^{-2} \Xi^{-1} e_v^{-1/2}$. One analogously obtains the same estimate for $-t$ in the same range. Set δ_0 in Proposition 8.2 to be $\delta_0 = \frac{1}{16B_1}$ and let $\theta_0 := \delta_0 (\log \hat{\Xi})^{-2} \Xi^{-1} e_v^{-1/2}$ be as in that Proposition. Then all of the estimates in Proposition 8.2 follow directly from (10.1) for $t \in \tilde{J}_I \cap [t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]$. In particular, $\sup\{\|\nabla y_I(t)\|_{C^0} : t \in \tilde{J}_I \cap [t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]\}$ is finite, so the maximal open interval of existence \tilde{J}_I must therefore contain $[t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]$. (Otherwise one contradicts (8.1) of Proposition 2 using $\|\nabla u_I(t)\|_{C^0} \leq \|\nabla y_I(t)\|_{C^0} + \|\nabla v(t)\|_{C^0}$.) The case of general $I \neq 0$ is equivalent to the $I = 0$ case by a translation in the time variable, so we have finished proving Proposition 8.2. \square

We now continue to the proof of Proposition 10.1.

10.1 Estimates for the Pressure Increment

We start by estimating the pressure increment \bar{p}_I , which appears in both of the equations (6.2) and (7.8). The bounds we obtain are as follows, with implicit constants as usual depending on C_0 .

Proposition 10.2 (Pressure Estimates). *For $t \in \tilde{J}_I$,*

$$\|\nabla^k \bar{p}_I(t)\|_{C^0} \lesssim \hat{N}^{(k-2)_+} \Xi^{|k|} \log \hat{\Xi} e_R (1 + \hat{h}(t))^2, \quad k = 0, 1, 2, 3 \quad (10.3)$$

$$\hat{\Xi}^{-\alpha} \|\nabla^k \bar{p}_I(t)\|_{\dot{C}^\alpha} \lesssim \hat{N}^{(k-2)_+} \Xi^{|k|} \log \hat{\Xi} e_R (1 + \hat{h}(t))^2, \quad k = 0, 1, 2, 3 \quad (10.4)$$

$$\|\nabla^{k+1} \bar{p}_I(t)\|_{C^0} \lesssim \hat{N}^{(k-2)_+} (\Xi e_v^{1/2}) \log \hat{\Xi} \Xi^k e_R^{1/2} (1 + \hat{h}(t))^2, \quad k = 2, 3 \quad (10.5)$$

$$\hat{\Xi}^{-\alpha} \|\nabla^{k+1} \bar{p}_I(t)\|_{\dot{C}^\alpha} \lesssim \hat{N}^{(k-2)_+} (\Xi e_v^{1/2}) \log \hat{\Xi} \Xi^k e_R^{1/2} (1 + \hat{h}(t))^2, \quad k = 2, 3 \quad (10.6)$$

We start with the $k = 0$ case of (10.3), namely $\|\bar{p}_I(t)\|_{C^0} \lesssim \log \hat{\Xi} e_R (1 + \hat{h}(t))^2$

Proof of (10.3), $k = 0$. Taking the divergence of (6.2), and using the fact that both v^ℓ and y_I^ℓ are divergence free, we have

$$\begin{aligned} \nabla_\ell[v^j \nabla_j y_I^\ell] + \nabla_\ell[y_I^j \nabla_j v^\ell] + \nabla_\ell \nabla_j (y_I^j y_I^\ell) + \Delta \bar{p}_I &= -\nabla_\ell \nabla_j R^{j\ell} \\ \bar{p}_I &= -2\Delta^{-1} \nabla_\ell [y_I^j \nabla_j v^\ell] - \Delta^{-1} \nabla_\ell \nabla_j [y_I^j y_I^\ell] - \Delta^{-1} \nabla_\ell \nabla_j R^{j\ell} \end{aligned}$$

We can then decompose $\bar{p}_I = -2\bar{p}_{I,1} - \bar{p}_{I,2} - \bar{p}_{I,3}$ as

$$\bar{p}_{I,1} = \Delta^{-1} \nabla_\ell [y_I^j \nabla_j v^\ell] \quad (10.7)$$

$$\bar{p}_{I,2} + \bar{p}_{I,3} = \Delta^{-1} \nabla_\ell \nabla_j [y_I^j y_I^\ell] + \Delta^{-1} \nabla_\ell \nabla_j R^{j\ell} \quad (10.8)$$

We start by estimating (10.8) as follows. Choose $\hat{q} \in \mathbb{Z}$ such that $2^{\hat{q}-1} < \widehat{\Xi} \leq 2^{\hat{q}}$. Then by (9.2) we have

$$\begin{aligned} \bar{p}_{I,2} + \bar{p}_{I,3} &= \bar{p}_{I,2L} + \bar{p}_{I,3L} + \bar{p}_{I,2H} + \bar{p}_{I,3H} \\ \bar{p}_{I,2L} + \bar{p}_{I,3L} &= \Delta^{-1} \nabla_\ell \nabla_j P_{\leq \hat{q}} [y_I^j y_I^\ell + R^{j\ell}] \end{aligned} \quad (10.9)$$

$$\bar{p}_{I,2H} + \bar{p}_{I,3H} = \sum_{q > \hat{q}} \Delta^{-1} \nabla_\ell \nabla_j P_q [y_I^j y_I^\ell + R^{j\ell}] \quad (10.10)$$

The operator acting on low frequencies is bounded on C^0 by

$$\begin{aligned} \|\Delta^{-1} \nabla_\ell \nabla_j P_{\leq \hat{q}}\| &\leq \sum_{q=0}^{\hat{q}} \|\Delta^{-1} \nabla_\ell \nabla_j P_q\| \\ &\lesssim \sum_{q=0}^{\hat{q}} 1 = (1 + \hat{q}) \lesssim \log \widehat{\Xi}, \end{aligned} \quad (10.11)$$

where we used (9.1) and the fact that $\Delta^{-1} \nabla_\ell \nabla_j P_q = \tilde{K}_q^*$ are convolution operators whose kernels $\tilde{K}_q(h) = 2^{3q} K_0(2^q h)$ are rescaled Schwartz functions satisfying the same L^1 bound. This scaling is due to the multiplier for $\Delta^{-1} \nabla_\ell \nabla_j$ being homogeneous of degree 0. From (10.11), we now obtain

$$\|\bar{p}_{I,2L} + \bar{p}_{I,3L}\|_{C^0} \lesssim \log \widehat{\Xi} (e_R \mathfrak{h}(t)^2 + e_R) \leq \log \widehat{\Xi} e_R (1 + \mathfrak{h}(t))^2$$

For the high-frequency term, we apply $P_q = P_{[q-2, q+2]} P_q = P_{\approx q} P_q$ and use \dot{C}^α control to obtain

$$\begin{aligned} \|\bar{p}_{I,2H} + \bar{p}_{I,3H}\|_{C^0} &\leq \sum_{q > \hat{q}} \|\Delta^{-1} \nabla_\ell \nabla_j P_{\approx q}\| \|P_q [y_I^j y_I^\ell + R^{j\ell}]\|_{C^0} \\ &\stackrel{(9.3)}{\lesssim} \sum_{q > \hat{q}} 2^{-\alpha q} \|y_I^j y_I^\ell + R^{j\ell}\|_{\dot{C}^\alpha} \\ &\lesssim \sum_{q > \hat{q}} 2^{-\alpha q} \widehat{\Xi}^\alpha (e_R \mathfrak{h}(t)^2 + e_R) \\ &\lesssim e_R (1 + \mathfrak{h}(t))^2 \end{aligned}$$

The term $\bar{p}_{I,1}$ in (10.7) is similar to the problematic term that we encountered in the equation (7.9). For this term, we start with a similar decomposition

$$\begin{aligned} \bar{p}_{I,1} &= \bar{p}_{I,1L} + \bar{p}_{I,1H} \\ \bar{p}_{I,1L} &= \Delta^{-1} \nabla_\ell P_{\leq \hat{q}} [y_I^j \nabla_j v^\ell] \\ \bar{p}_{I,1H} &= \sum_{q > \hat{q}} \Delta^{-1} \nabla_\ell P_q [y_I^j \nabla_j v^\ell] \end{aligned} \quad (10.12)$$

For the high frequency term, we can estimate

$$\begin{aligned}
\bar{p}_{I,1H} &\leq \sum_{q>\hat{q}} \|\Delta^{-1}\nabla_\ell P_{\approx q}\| \|P_q[y_I^j \nabla_j v^\ell]\|_{C^0} \\
&\lesssim \sum_{q>\hat{q}} 2^{-q} \|P_q[y_I^j \nabla_j v^\ell]\|_{C^0} \\
&\lesssim \sum_{q>\hat{q}} 2^{-q} 2^{-q} \|\nabla[y_I^j \nabla_j v^\ell]\|_{C^0} \\
&\lesssim \widehat{\Xi}^{-2} (\|\nabla y_I\|_{C^0} \|\nabla v\|_{C^0} + \|y_I\|_{C^0} \|\nabla^2 v\|_{C^0}) \\
&\lesssim \widehat{\Xi}^{-2} \Xi^2 e_v^{1/2} e_R^{1/2} \hat{h}(t) \leq e_R \hat{h}(t)
\end{aligned}$$

In the second line, we used an argument similar to the proof (10.11) to bound the L^1 norm of the kernel for the convolution operator, but in this case the scaling gains an inverse of the frequency 2^q since the multiplier for the operator is -1 -homogeneous rather than 0 -homogeneous.

The low frequency term requires more delicate analysis, as we know already that the bound

$$\|\bar{p}_{I,1L}\|_{C^0} \leq \|\Delta^{-1}\nabla_\ell P_{\leq \hat{q}} \nabla_j\| \|y_I^j v^\ell\|_{C^0}$$

is not sufficient.

First we decompose v into high and low frequencies

$$\begin{aligned}
\bar{p}_{I,1L} &= \bar{p}_{I,1LL} + \bar{p}_{I,1LH} \\
\bar{p}_{I,1LL} &= \Delta^{-1}\nabla_\ell P_{\leq \hat{q}} [y_I^j \nabla_j P_{\leq \hat{q}} v^\ell] \\
\bar{p}_{I,1LH} &= \sum_{q>\hat{q}} \Delta^{-1}\nabla_\ell P_{\leq \hat{q}} [y_I^j \nabla_j P_q v^\ell]
\end{aligned} \tag{10.13}$$

Using that y_I is divergence free, we estimate the LH term by

$$\begin{aligned}
\|\bar{p}_{I,1LH}\|_{C^0} &\leq \sum_{q>\hat{q}} \|\Delta^{-1}\nabla_\ell P_{\leq \hat{q}} \nabla_j\| \|y_I P_q v^\ell\|_{C^0} \\
&\stackrel{(10.11)}{\lesssim} \sum_{q>\hat{q}} (1 + \hat{q}) (e_R^{1/2} \hat{h}(t)) (2^{-q} \|\nabla v\|_{C^0}) \\
&\lesssim (1 + \hat{q}) \widehat{\Xi}^{-1} e_R^{1/2} \hat{h}(t) \Xi e_v^{1/2} \\
&\lesssim \log \widehat{\Xi} e_R \hat{h}(t)
\end{aligned}$$

For the LL term, we use the following technique closely related to the estimates for pressure increments in [Isel3a]. Namely, we decompose this term into *frequency increments* of the form

$$\begin{aligned}
\bar{p}_{I,1LL} &= \sum_{q=-1}^{\hat{q}-1} \Delta^{-1}\nabla_\ell P_{q+1} [y_I^j \nabla_j P_{\leq q+1} v^\ell] + \Delta^{-1}\nabla_\ell P_{\leq q} [y_I^j \nabla_j P_{q+1} v^\ell] \\
&= \sum_{q=-1}^{\hat{q}-1} \bar{p}_{I,1LqA} + \bar{p}_{I,1LqB}
\end{aligned} \tag{10.14}$$

For the first type of term, we use that $P_{\leq q+1} v^\ell$ is restricted to frequencies at most 2^{q+2} to write

$$\Delta^{-1}\nabla_\ell P_{q+1} [y_I^j \nabla_j P_{\leq q+1} v^\ell] = \Delta^{-1}\nabla_\ell P_{q+1} [P_{\leq q+4} y_I^j \nabla_j P_{\leq q+1} v^\ell]$$

That is, the higher frequencies of y_I cannot contribute to the P_{q+1} projections of the product.

By Proposition 8.1, we have that $y_I^j = \nabla_i r_I^{ij}$. By substituting, we then have

$$\begin{aligned}
\|\bar{p}_{I,1LqA}\|_{C^0} &\leq \|\Delta^{-1}\nabla_\ell P_{q+1}\| \|P_{\leq q+4}\nabla_i r_I^{ij}\|_{C^0} \|\nabla_j P_{\leq q+1} v^\ell\|_{C^0} \\
&\lesssim 2^{-q} \|P_{\leq q+4}\nabla_i\| \|r_I\|_{C^0} \|\nabla v\|_{C^0} \\
&\lesssim 2^{-q} \cdot 2^q \cdot (\hat{\varepsilon}h(t)) \Xi e_v^{1/2} \\
\|\bar{p}_{I,1LqA}\|_{C^0} &\lesssim (\log \hat{\Xi})^{-1} e_R h(t)
\end{aligned} \tag{10.15}$$

For the second term in (10.14), we use that $\nabla_j y_I^j = 0$ and the same frequency restrictions to write

$$\begin{aligned}
\bar{p}_{I,1LqB} &= \Delta^{-1}\nabla_\ell P_{\leq q} [y_I^j \nabla_j P_{q+1} v^\ell] = \Delta^{-1}\nabla_\ell P_{\leq q} \nabla_j [y_I^j P_{q+1} v^\ell] \\
&= \Delta^{-1}\nabla_\ell P_{\leq q} \nabla_j [(P_{\leq q+4}\nabla_i r_I^{ij}) P_{q+1} v^\ell],
\end{aligned}$$

From this identity, we conclude

$$\begin{aligned}
\|\bar{p}_{I,1LqB}\|_{C^0} &\leq \|\Delta^{-1}\nabla_\ell P_{\leq q} \nabla_j\| \|P_{\leq q+4}\nabla_i\| \|r_I\|_{C^0} \|P_{q+1} v^\ell\|_{C^0} \\
&\lesssim (2+q) 2^q \hat{\varepsilon}h(t) 2^{-q} \|\nabla v\|_{C^0} \\
&\lesssim (2+q) \hat{\varepsilon}h(t) \Xi e_v^{1/2} = (2+q) (\log \hat{\Xi})^{-1} e_R h(t)
\end{aligned} \tag{10.16}$$

Substituting these estimates into (10.14) gives

$$\begin{aligned}
\|\bar{p}_{I,1LL}\|_{C^0} &\lesssim \sum_{q=-1}^{\hat{q}-1} (2+q) (\log \hat{\Xi})^{-1} e_R h(t) \\
&\lesssim (1+\hat{q})^2 (\log \hat{\Xi})^{-1} e_R h(t) \lesssim \log \hat{\Xi} e_R h(t)
\end{aligned} \tag{10.17}$$

We remark that the above estimates can also be derived without the use of frequency localization of Fourier transforms of products by starting with the terms in a different form such as

$$\Delta^{-1}\nabla_\ell P_{q+1} [y_I^j \nabla_j P_{\leq q+1} v^\ell] = \Delta^{-1}\nabla_\ell P_{q+1} \nabla_i [r_I^{ij} \nabla_j P_{\leq q+1} v^\ell] - \Delta^{-1}\nabla_\ell P_{q+1} [r_I^{ij} \nabla_i \nabla_j P_{\leq q+1} v^\ell].$$

With inequality (10.17) we have concluded the proof of (10.3) for $k = 0$. \square

We now move on to derivatives of order $1 \leq k \leq 3$.

Proof of (10.3). Note that (10.3) for $k = 1$ follows from the $k = 0, 2$ cases by the interpolation inequality $\|\nabla f\|_{C^0} \lesssim \|f\|_{C^0}^{1/2} \|\nabla^2 f\|_{C^0}^{1/2}$. Also, the $k = 3$ case of (10.3) is the same as the $k = 2$ case of (10.5), which will be proven shortly. Thus we consider only the case of $k = 2$ derivatives at this point.

Let $\nabla_{a_1, a_2}^2 = \nabla_{a_1} \nabla_{a_2}$ be a partial derivative operator of order 2. We use the same decompositions and the same calculations as in the $k = 0$ case. For example

$$\nabla_{a_1, a_2}^2 \bar{p}_I = -2\nabla_{a_1, a_2}^2 \bar{p}_{I,1} - \nabla_{a_1, a_2}^2 \bar{p}_{I,2} - \nabla_{a_1, a_2}^2 \bar{p}_{I,3}$$

Taking two derivatives of (10.9), we have

$$\begin{aligned}
\|\nabla_{a_1, a_2}^2 \bar{p}_{I,2L}\|_{C^0} &\lesssim (1+\hat{q}) (\|\nabla^2 (y_I^j y_I^\ell)\|_{C^0} + \|\nabla^2 R\|_{C^0}) \\
&\lesssim \log \hat{\Xi} (\Xi^2 e_R h(t)^2 + \Xi^2 e_R) \\
&\lesssim \log \hat{\Xi} \Xi^2 e_R (1+h(t))^2
\end{aligned}$$

Similarly for (10.10) one has

$$\begin{aligned}
\|\nabla_{a_1, a_2}^2 \bar{p}_{I, 2H}\|_{C^0} &\lesssim \sum_{q > \hat{q}} 2^{-\alpha q} \|\nabla^2(y_I^j y_I^\ell) + \nabla^2 R^{j\ell}\|_{\dot{C}^\alpha} \\
&\lesssim \widehat{\Xi}^{-\alpha} (\|\nabla^2 y_I\|_{\dot{C}^\alpha} \|y_I\|_{C^0} + \|\nabla y_I\|_{\dot{C}^\alpha} \|\nabla y_I\|_{C^0} + \|y_I\|_{\dot{C}^\alpha} \|\nabla^2 y_I\|_{C^0} + \|\nabla^2 R^{j\ell}\|_{\dot{C}^\alpha}) \\
&\lesssim \widehat{\Xi}^{-\alpha} (\widehat{\Xi}^\alpha \Xi^2 e_R \hbar(t)^2 + \widehat{\Xi}^\alpha \Xi^2 e_R) \\
&\lesssim \Xi^2 e_R (1 + \hbar(t))^2
\end{aligned}$$

The point in the above inequality is that the estimates for y_I and R do not start to see factors of $\widehat{\Xi}$ or $\widehat{N}\Xi$ until going beyond the second derivative. Above we interpolate between the $|a| = 2, 3$ cases of (3.2) to bound $\|\nabla^2 R^{j\ell}\|_{\dot{C}^\alpha}$.

Applying $\nabla_{a_1, a_2}^2 = \nabla_{a_1} \nabla_{a_2}$ to (10.13) and commuting the partial derivative through gives

$$\begin{aligned}
\|\nabla^2 \bar{p}_{I, 1LH}\|_{C^0} &\leq \sum_{q > \hat{q}} \|\Delta^{-1} \nabla_\ell P_{\leq \hat{q}} \nabla_j\| \|\nabla^2(y_I P_q v^\ell)\|_{C^0} \\
&\lesssim (1 + \hat{q}) \sum_{q > \hat{q}} \left(\sum_{a+b=2} \|\nabla^a y_I\|_{C^0} \|\nabla^b P_q v\|_{C^0} \right) \\
&\lesssim (1 + \hat{q}) \sum_{q > \hat{q}} 2^{-q} \left(\sum_{a+b=2} \|\nabla^a y_I\|_{C^0} \|\nabla^{b+1} v\|_{C^0} \right) \\
&\lesssim (1 + \hat{q}) \left(\sum_{q > \hat{q}} 2^{-q} \right) \sum_{a+b=2} \Xi^a e_R^{1/2} \hbar(t) \Xi^{(b+1)} e_v^{1/2} \\
&\lesssim (1 + \hat{q}) \widehat{\Xi}^{-1} \Xi^3 e_R^{1/2} \hbar(t) e_v^{1/2} \\
\|\nabla^2 \bar{p}_{I, 1LH}\|_{C^0} &\lesssim \log \widehat{\Xi} \Xi^2 e_R \hbar(t)
\end{aligned}$$

Here we use that no powers of \widehat{N} appear in the estimates (3.1) for v until after the third derivative. Similarly, we obtain

$$\begin{aligned}
\|\nabla^2 \bar{p}_{I, 1LqA}\|_{C^0} &\lesssim (\log \widehat{\Xi})^{-1} \Xi^2 e_R \hbar(t) \\

\|\nabla^2 \bar{p}_{I, 1LL}\|_{C^0} &\lesssim \log \widehat{\Xi} \Xi^2 e_R \hbar(t)
\end{aligned}$$

by applying $\nabla_{a_1} \nabla_{a_2}$ to the formulas that led to the proof of the bounds (10.15), (10.16), (10.17), and noting that each derivative costs a factor $|\nabla| \lesssim \Xi$, $|\nabla|^2 \lesssim \Xi^2$ in the estimates, since we do not consider derivatives beyond $\|\nabla^2 r_I\|_{C^0}$, $\|\nabla^2 y_I\|_{C^0}$, $\|\nabla^3 v\|_{C^0}$. (See also Section 10.4 below, where an analogous term is treated in detail.) \square

Proof of (10.4). This inequality follows by interpolating (10.3) and (10.5). \square

Proof of (10.5). Let $\nabla_{\bar{a}}$ be a partial derivative operator of order $k + 1$; i.e. $\nabla_{\bar{a}} = \nabla_{a_1} \nabla_{a_2} \nabla_{a_3}$ if $k = 2$ or $\nabla_{\bar{a}} = \nabla_{a_1} \nabla_{a_2} \nabla_{a_3} \nabla_{a_4}$ if $k = 3$. (which is enough for (10.5)). Meanwhile, the high frequency part can be bounded by

Performing the analogous computations for $\bar{p}_{I,2} = \Delta^{-1} (\nabla_{\ell} y_I^j \nabla_j y_I^{\ell}) = \bar{p}_{I,2L} + \bar{p}_{I,2H}$ gives

$$\begin{aligned} \|\nabla_{\bar{a}} \bar{p}_{I,2L}\|_{C^0} &\lesssim (1 + \hat{q}) \sum_{\beta+\gamma=k-1} \|\nabla^{1+\beta} y_I\|_{C^0} \|\nabla^{1+\gamma} y_I\|_{C^0} \\ &\lesssim (1 + \hat{q}) \sum_{\beta+\gamma=k-1} (\widehat{N}^{(\beta-1)+} \Xi^{1+\beta} e_R^{1/2} \mathfrak{h}(t)) (\widehat{N}^{(\gamma-1)+} \Xi^{1+\gamma} e_R^{1/2} \mathfrak{h}(t)) \\ &\stackrel{(2.1)}{\lesssim} \log \widehat{\Xi} \widehat{N}^{(k-2)+} \Xi e_R^{1/2} \Xi^k e_R^{1/2} \mathfrak{h}(t)^2 \\ \|\nabla_{\bar{a}} \bar{p}_{I,2H}\|_{C^0} &\lesssim \sum_{q>\hat{q}} 2^{-\alpha q} \|\nabla_{\bar{a}} [\nabla_{\ell} y_I^j \nabla_j y_I^{\ell}]\|_{\dot{C}^{\alpha}} \\ &\lesssim \widehat{\Xi}^{-\alpha} \left(\sum_{\gamma+\beta=k-1} \widehat{\Xi}^{\alpha} [\widehat{N}^{(\gamma-1)+} \Xi^{1+\gamma} e_R^{1/2} \mathfrak{h}(t)] [\widehat{N}^{(\beta-1)+} \Xi^{1+\beta} e_R^{1/2} \mathfrak{h}(t)] \right) \\ &\stackrel{(2.1)}{\lesssim} \widehat{N}^{(k-2)+} \Xi e_R^{1/2} \Xi^k e_R^{1/2} \mathfrak{h}(t)^2 \end{aligned}$$

As for $\bar{p}_{I,3} = \Delta^{-1} \nabla_j \nabla_\ell R^{j\ell} = \bar{p}_{I,3L} + \bar{p}_{I,3H}$, we have the bounds (recalling that $\widehat{N} = (e_v/e_R)^{1/2}$)

\|\nabla_{\bar{a}} \bar{p}_{I,3H}\|_{C^0} &\leq \sum_{q > \hat{q}} \|\nabla_{a_1} \nabla_{a_2} \Delta^{-1} P_{\approx q}\| \|P_q \nabla_{\bar{a}} \nabla_j \nabla_\ell R^{j\ell}\|_{C^0} \\
&\lesssim \sum_{q > \hat{q}} 2^{-\alpha q} \|\nabla_{\bar{a}} \nabla_j \nabla_\ell R^{j\ell}\|_{\dot{C}^\alpha} \\
&\lesssim \widehat{\Xi}^{-\alpha} \widehat{\Xi}^\alpha \widehat{N}^{(k-1)+} \Xi^{k+1} e_R \leq \Xi e_v^{1/2} \widehat{N}^{(k-2)+} \Xi^k e_R^{1/2}
\end{aligned}$$

This bound completes the proof of (10.5). \square

Proof of (10.6). The $k = 2$ case follows by interpolation from (10.5), so we need only consider the case $k = 3$. &\lesssim 2^{-\alpha q} \sum_{|\bar{b}|+|\bar{c}|=2} \|\nabla_{\bar{b}} \nabla_\ell y_I^j \nabla_{\bar{c}} \nabla_j v^\ell\|_{\dot{C}^\alpha}
\end{aligned}$$

$$\begin{aligned}
\|P_q \nabla_{\bar{a}} \bar{p}_{I,1}\|_{C^0} &\lesssim 2^{-\alpha q} \sum_{|\bar{b}|+|\bar{c}|=2} (\|\nabla_{\bar{b}} \nabla_\ell y_I^j\|_{\dot{C}^\alpha} \|\nabla_{\bar{c}} \nabla_j v^\ell\|_{C^0} + \|\nabla_{\bar{b}} \nabla_\ell y_I^j\|_{C^0} \|\nabla_{\bar{c}} \nabla_j v^\ell\|_{\dot{C}^\alpha}) \\
&\lesssim 2^{-\alpha q} \sum_{|\bar{b}|+|\bar{c}|=2} \widehat{\Xi}^\alpha [\widehat{N}^{(|\bar{b}|-1)+} \Xi^{(1+|\bar{b}|)} e_R^{1/2} \mathfrak{h}(t)] [\widehat{N}^{(|\bar{c}|-2)+} \Xi^{(1+|\bar{c}|)} e_v^{1/2}] \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi e_v^{1/2} \Xi^3 e_R^{1/2} \mathfrak{h}(t)
\end{aligned}$$

Performing the same computation for $P_q \nabla_{\bar{a}} \bar{p}_{I,2} = \Delta^{-1} P_q \nabla_{\bar{a}} (\nabla_\ell y_I^j \nabla_j y_I^\ell)$ gives

&\lesssim 2^{-\alpha q} \sum_{\gamma+\beta=2} \widehat{\Xi}^\alpha [\widehat{N}^{(\gamma-1)+} \Xi^{(1+\gamma)} e_R^{1/2} \mathfrak{h}(t)] [\widehat{N}^{(\beta-1)+} \Xi^{(1+\beta)} e_R^{1/2} \mathfrak{h}(t)] \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi e_R^{1/2} \Xi^3 e_R^{1/2} \mathfrak{h}(t)^2
\end{aligned}$$

Similarly, we have

$$\begin{aligned}

\|P_q \nabla_{\vec{a}} \bar{p}_{I,3}\|_{C^0} &\lesssim \|P_q \nabla_{\vec{a}} \partial_j \partial_\ell R^{j\ell}\|_{C^0} \\
&\lesssim 2^{-\alpha q} \|\nabla^4 R\|_{\dot{C}^\alpha} \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha (\widehat{N}^2 \Xi^4 e_R) = 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi e_v^{1/2} \Xi^3 e_R^{1/2}
\end{aligned}$$

Combining these three estimates gives (10.21) and hence (10.6). \square

We have now proven Proposition 10.2. With estimates for the pressure in hand, we turn to the evolution equations (6.2),(7.8),(7.9) for y_I , z_I and ρ_I .

10.2 Estimates for the Velocity Increment

The main result of this Section is the following array of estimates for the velocity increment y_I^ℓ .

Proposition 10.3 (Velocity Estimates). *For all $t \in \widetilde{J}_I$ and for all multi-indices \vec{a} with $0 \leq |\vec{a}| \leq 3$ and for all $q \in \mathbb{Z}$, the following estimates hold*

$$\|(\partial_t + v^j \nabla_j + y_I^j \nabla_j) \nabla_{\vec{a}} y_I(t)\|_{C^0} \lesssim \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} e_R^{1/2} \log \widehat{\Xi} \Xi e_v^{1/2} (1 + \mathfrak{h}(t))^2 \quad (10.24)$$

Observe that (10.24) implies (10.22) by the standard estimates for transport equations (Appendix Proposition A.1). Similarly, (10.23) follows from (10.25) and Proposition A.1 using Proposition 9.1.

&\stackrel{(2.1)}{\lesssim} \widehat{N}^{(|\vec{a}|-2)+} \Xi e_v^{1/2} \Xi^{|\vec{a}|} e_R^{1/2} (1 + \mathfrak{h}(t))^2
\end{aligned} \tag{10.30}$$

The first term in line (10.29) is bounded by

&\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \left[\widehat{N}^{(|\vec{b}|-2)+} \Xi^{|\vec{b}|} e_R^{1/2} \mathfrak{h}(t) \right] \left[\widehat{N}^{(|\vec{c}|-1-3)+} \Xi^{|\vec{c}|-1} e_v^{1/2} \right] \\
&\lesssim \widehat{N}^{(|\vec{a}|-2)+} \Xi e_v^{1/2} \Xi^{|\vec{a}|} e_R^{1/2} \mathfrak{h}(t)

The other terms in (10.29) are bounded by

&\stackrel{(10.27)}{\lesssim} 2^{-\alpha q} [\Xi e_v^{1/2} (1 + \mathfrak{h}(t))] [\widehat{\Xi}^\alpha \widehat{N}^{|\vec{a}|} e_R^{1/2} \mathfrak{h}(t)] \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi e_v^{1/2} \Xi^3 e_R^{1/2} (1 + \mathfrak{h}(t))^2
\end{aligned}$$

Following the proof of (10.30), the term (10.33) obeys (for $|\vec{a}| = 3$)

$$\begin{aligned}
\|(10.33)\|_{C^0} &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} 2^{-\alpha q} \|\nabla_{\vec{b}} u_I^j\|_{\dot{C}^\alpha} \|\nabla_{\vec{c}} \nabla_j y_I^\ell\|_{\dot{C}^\alpha} 1_{|\vec{b}| \geq 1} \\
&\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} (\|\nabla_{\vec{b}} u_I^j\|_{\dot{C}^\alpha} \|\nabla_{\vec{c}} \nabla_j y_I^\ell\|_{C^0} + \|\nabla_{\vec{b}} u_I^j\|_{C^0} \|\nabla_{\vec{c}} \nabla_j y_I^\ell\|_{\dot{C}^\alpha}) 1_{|\vec{b}| \geq 1} \\
&\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \widehat{\Xi}^\alpha [\widehat{N}^{(|\vec{b}|-3)+} \Xi^{|\vec{b}|} e_v^{1/2} (1 + \mathfrak{h}(t))] [\widehat{N}^{(|\vec{c}|-1)+} \Xi^{(|\vec{c}|-1)+} e_R^{1/2} \mathfrak{h}(t)] 1_{|\vec{b}| \geq 1} \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi e_v^{1/2} \Xi^3 e_R^{1/2} (1 + \mathfrak{h}(t))^2.
\end{aligned}$$

Modifying the proof of (10.31) as in the previous computation gives the bound

$$\|P_q \nabla_{\vec{a}} [y_I^j \nabla_j v^\ell]\|_{C^0} \lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha (\widehat{N}^{(3-2)_+} \Xi e_v^{1/2} \Xi^{|\vec{a}|} e_R^{1/2} \mathfrak{h}(t)).$$

The other two terms in (10.34) are bounded by:

$$\begin{aligned} \|P_q \nabla_{\vec{a}} \nabla^\ell \bar{p}_I\|_{C^0} &\stackrel{(10.6)}{\lesssim} 2^{-\alpha q} \widehat{\Xi}^\alpha \log \widehat{\Xi} \widehat{N} \Xi e_v^{1/2} \Xi^3 e_R^{1/2} (1 + \mathfrak{h}(t))^2 \\ \|P_q \nabla_{\vec{a}} \nabla_j R^{j\ell}\|_{C^0} &\lesssim 2^{-\alpha q} \|\nabla^4 R\|_{\dot{C}^\alpha} \lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(4-2)_+} \Xi^4 e_R \\ &\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi e_v^{1/2} \Xi^3 e_R. \end{aligned}$$

This estimate concludes the proof of (10.25). \square

We now proceed to estimate the components of the anti-divergence $r_I^{j\ell} = \rho_I^{j\ell} + z_I^{j\ell}$.

10.3 Estimates for the Anti-Divergence I: z_I

The main result of this Section and the following one is the following array of estimates for the components $z_I^{j\ell}$ and $\rho_I^{j\ell}$ of the anti-divergence $r_I^{j\ell} = \rho_I^{j\ell} + z_I^{j\ell}$. We use the notation \hat{q} to denote the integer $\hat{q} \in \mathbb{Z}$ such that $2^{\hat{q}-1} < \widehat{\Xi} \leq 2^{\hat{q}}$.

Proposition 10.4 (Anti-Divergence Estimates). *For all $t \in \widetilde{J}_I$, and for all multi-indices \vec{a} with $0 \leq |\vec{a}| \leq 3$ and for all $q \in \mathbb{Z}$ with $q > \hat{q}$, the following estimates hold*

$$\|\nabla_{\vec{a}} z_I(t)\|_{C^0} + \|\nabla_{\vec{a}} \rho_I(t)\|_{C^0} \lesssim \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} \widehat{\Xi} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \left| \int_{t_0(I)}^t (1 + \mathfrak{h}(\tau))^2 d\tau \right| \quad (10.35)$$

$$\widehat{\Xi}^{-\alpha} (\|\nabla^3 z_I(t)\|_{\dot{C}^\alpha} + \|\nabla^3 \rho_I(t)\|_{\dot{C}^\alpha}) \lesssim \widehat{N} \Xi^3 \widehat{\Xi} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \left| \int_{t_0(I)}^t (1 + \mathfrak{h}(\tau))^2 d\tau \right| \quad (10.36)$$

$$\|D_t \nabla_{\vec{a}} z_I(t)\|_{C^0} + \|D_t \nabla_{\vec{a}} \rho_I(t)\|_{C^0} \lesssim \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} \widehat{\Xi} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} (1 + \mathfrak{h}(t))^2 \quad (10.37)$$

$$\|D_t P_q \nabla_{\vec{a}} z_I(t)\|_{C^0} + \|D_t P_q \nabla_{\vec{a}} \rho_I(t)\|_{C^0} \lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N} \Xi^3 \widehat{\Xi} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} (1 + \mathfrak{h}(t))^2, \quad \text{if } |\vec{a}| = 3 \quad (10.38)$$

where D_t is the operator $D_t := (\partial_t + v \cdot \nabla)$ and $\widehat{\Xi} = e_R / (\log \widehat{\Xi} \Xi e_v^{1/2})$.

As in the discussion following Proposition 10.3, note that (10.37) implies (10.35). The bounds (10.35) and (10.38) imply (10.36) as follows. From (10.38) and Appendix Proposition A.1, we have

$$\widehat{\Xi}^{-\alpha} \sup_{q > \hat{q}} 2^{\alpha q} (\|P_q \nabla_{\vec{a}} z_I(t)\|_{C^0} + \|P_q \nabla_{\vec{a}} \rho_I(t)\|_{C^0}) \lesssim \widehat{N} \Xi^3 \widehat{\Xi} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \left| \int_{t_0(I)}^t (1 + \mathfrak{h}(\tau))^2 d\tau \right|, \quad |\vec{a}| = 3$$

On the other hand, in the range $q \leq \hat{q}$, we have $2^q \leq 2^{\hat{q}} \leq 2\widehat{\Xi}$, and

$$\widehat{\Xi}^{-\alpha} \sup_{q \leq \hat{q}} 2^{\alpha q} (\|P_q \nabla_{\vec{a}} z_I(t)\|_{C^0} + \|P_q \nabla_{\vec{a}} \rho_I(t)\|_{C^0}) \lesssim \|\nabla_{\vec{a}} z_I(t)\|_{C^0} + \|\nabla_{\vec{a}} \rho_I(t)\|_{C^0}, \quad |\vec{a}| = 3$$

Thus (10.38) together with (10.35) imply (10.36) by the characterization of \dot{C}^α in Proposition 9.1.

In this Section, we address the estimates (10.37) and (10.38) for z_I . The proof of (10.37) and (10.38) for ρ_I will be given in Section 10.4 below.

Proof of (10.37) for z_I . Applying $\nabla_{\vec{a}}$ to (7.8) gives

$$- \nabla_{\vec{a}} [y_I^j y_I^\ell] - \nabla_{\vec{a}} \bar{p}_I \delta^{j\ell} - \nabla_{\vec{a}} R^{j\ell} \quad (10.40)$$

The commutator term of line (10.39) is bounded by (using $|\vec{c}| = |\vec{a}| - |\vec{b}| \leq |\vec{a}| - 1$)

$$\begin{aligned} \|(10.39)\|_{C^0} &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \|\nabla_{\vec{b}} v^i\|_{C^0} \|\nabla_{\vec{c}} \nabla_i z_I^{j\ell}\|_{C^0} \cdot 1_{|\vec{b}| \geq 1} \\ &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \left[\widehat{N}^{(|\vec{b}|-3)+\Xi|\vec{b}|} e_v^{1/2} \right] \left[\widehat{N}^{(|\vec{c}|-1)+\Xi|\vec{c}|+1} \hat{\varepsilon} h(t) \right] \cdot 1_{|\vec{b}| \geq 1} \\ &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \widehat{N}^{(|\vec{b}|-1-2)+} \widehat{N}^{(|\vec{c}|-1-2)+} 1_{|\vec{b}| \geq 1} [\Xi e_v^{1/2} \Xi^{|\vec{a}|} \hat{\varepsilon} h(t)] \\ &\stackrel{(2.1)}{\lesssim} \widehat{N}^{(|\vec{a}|-2)+\Xi} e_v^{1/2} \Xi^{|\vec{a}|} \hat{\varepsilon} h(t) \end{aligned} \quad (10.41)$$

Using $e_R = \log \widehat{\Xi} \Xi e_v^{1/2} \hat{\varepsilon}$, the first term in (10.40) is bounded by

$$\begin{aligned} \|\nabla_{\vec{a}} [y_I^j y_I^\ell]\|_{C^0} &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \|\nabla_{\vec{b}} y_I\|_{C^0} \|\nabla_{\vec{c}} y_I\|_{C^0} \\ &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \left[\widehat{N}^{(|\vec{b}|-2)+\Xi|\vec{b}|} e_R^{1/2} h(t) \right] \left[\widehat{N}^{(|\vec{c}|-2)+\Xi|\vec{c}|} e_R^{1/2} h(t) \right] \\ &\lesssim \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} e_R h(t)^2 \\ &\lesssim \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} \log \widehat{\Xi} \Xi e_v^{1/2} \hat{\varepsilon} h(t)^2 \end{aligned}$$

The other two terms are bounded by

$$\begin{aligned} \|\nabla_{\vec{a}} \bar{p}_I \delta^{j\ell}\|_{C^0} &\stackrel{(10.3)}{\lesssim} \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} \log \widehat{\Xi} e_R (1 + h(t))^2 \\ &\lesssim \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \hat{\varepsilon} (1 + h(t))^2 \\ \|\nabla_{\vec{a}} R^{j\ell}\|_{C^0} &\lesssim \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} e_R \\ &\lesssim \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} \log \widehat{\Xi} \Xi e_v^{1/2} \hat{\varepsilon} \end{aligned}$$

Combining these estimates gives (10.37) for z_I . \square

Proof of (10.38) for z_I . Take $|\vec{a}| = 3$ and apply P_q to equation (10.39)-(10.40) to obtain

$$(\partial_t + v^i \nabla_i) P_q \nabla_{\vec{a}} z_I^{j\ell} = v^i \nabla_i P_q \nabla_{\vec{a}} z_I - P_q [v^i \nabla_i \nabla_{\vec{a}} z_I] \quad (10.42)$$

$$+ \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} c_{\vec{a},\vec{b},\vec{c}} P_q [\nabla_{\vec{b}} v^i \nabla_{\vec{c}} \nabla_i z_I^{j\ell}] \cdot 1_{|\vec{b}| \geq 1} \quad (10.43)$$

$$- P_q \nabla_{\vec{a}} [y_I^j y_I^\ell] - P_q \nabla_{\vec{a}} \bar{p}_I \delta^{j\ell} - P_q \nabla_{\vec{a}} R^{j\ell} \quad (10.44)$$

We estimate (10.42) using Proposition 9.2 by

$$\begin{aligned} \|(10.42)\|_{C^0} &\lesssim 2^{-\alpha q} \|\nabla v\|_{C^0} \|\nabla_{\vec{a}} z_I\|_{\dot{C}^\alpha} \\ \|(10.42)\|_{C^0} &\lesssim 2^{-\alpha q} \Xi e_v^{1/2} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)+\Xi|\vec{a}|} \hat{\varepsilon} h(t) \end{aligned} \quad (10.45)$$

We estimate (10.43) by

$$\begin{aligned}
\|(10.43)\|_{C^0} &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} 2^{-\alpha q} \|\nabla_{\vec{b}} v^i \nabla_{\vec{c}} \nabla_i z_I^{j\ell}\|_{\dot{C}^\alpha} \cdot 1_{|\vec{b}| \geq 1} \\
&\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} (\|\nabla_{\vec{b}} v^i\|_{\dot{C}^\alpha} \|\nabla_{\vec{c}} \nabla_i z_I^{j\ell}\|_{C^0} + \|\nabla_{\vec{b}} v^i\|_{C^0} \|\nabla_{\vec{c}} \nabla_i z_I^{j\ell}\|_{\dot{C}^\alpha}) \cdot 1_{|\vec{b}| \geq 1} \\
&\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \widehat{\Xi}^\alpha \left[\widehat{N}^{(|\vec{b}|-1-2)+} \Xi^{|\vec{b}|} e_v^{1/2} \right] \left[\widehat{N}^{(|\vec{c}|+1-2)+} \Xi^{|\vec{c}|+1} \widehat{\varepsilon} \mathfrak{h}(t) \right] \cdot 1_{|\vec{b}| \geq 1} \\
\|(10.43)\|_{C^0} &\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)+} \Xi e_v^{1/2} \Xi^{|\vec{a}|} \widehat{\varepsilon} \mathfrak{h}(t) \tag{10.46}
\end{aligned}$$

Similarly, the first term of (10.44) is bounded by

$$\begin{aligned}
\|P_q \nabla_{\vec{a}} [y_I^j y_I^\ell]\|_{C^0} &\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \|\nabla_{\vec{b}} y_I^j \nabla_{\vec{c}} y_I^\ell\|_{\dot{C}^\alpha} \\
&\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \widehat{\Xi}^\alpha \left[\widehat{N}^{(|\vec{b}|-2)+} \Xi^{|\vec{b}|} e_R^{1/2} \mathfrak{h}(t) \right] \left[\widehat{N}^{(|\vec{c}|-2)+} \Xi^{|\vec{c}|} e_R^{1/2} \mathfrak{h}(t) \right] \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)+} \Xi^{|\vec{a}|} e_R \mathfrak{h}(t)^2 \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)+} \log \widehat{\Xi} \Xi e_v^{1/2} \Xi^{|\vec{a}|} \widehat{\varepsilon} \mathfrak{h}(t)^2
\end{aligned}$$

Finally, the latter two terms of (10.44) are bounded by

$$\begin{aligned}
\|P_q \nabla_{\vec{a}} \bar{\rho}_I \delta^{j\ell}\|_{C^0} &\lesssim 2^{-\alpha q} \|\nabla_{\vec{a}} \bar{\rho}_I\|_{\dot{C}^\alpha} \\
&\stackrel{(10.4)}{\lesssim} 2^{-\alpha q} \widehat{\Xi}^\alpha \log \widehat{\Xi} \widehat{N}^{(|\vec{a}|-2)+} \Xi^{|\vec{a}|} e_R (1 + \mathfrak{h}(t))^2 \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)+} \Xi^{|\vec{a}|} \widehat{\varepsilon} (1 + \mathfrak{h}(t))^2 \\
\|P_q \nabla_{\vec{a}} R^{j\ell}\|_{C^0} &\lesssim 2^{-\alpha q} \|\nabla_{\vec{a}} R^{j\ell}\|_{\dot{C}^\alpha} \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)+} \Xi^{|\vec{a}|} e_R \\
&\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)+} \Xi^{|\vec{a}|} \widehat{\varepsilon}
\end{aligned}$$

This estimate concludes the proof of (10.38) for z_I . □

10.4 Estimates for the Anti-Divergence II: ρ_I

In this Section, we establish the estimates (10.37)-(10.38) for $\rho_I^{j\ell}$.

Proof of (10.37) for ρ_I . Let $\nabla_{\vec{a}}$ be a partial derivative operator of order $0 \leq |\vec{a}| \leq 3$. Applying $\nabla_{\vec{a}}$ to (7.9), we obtain

$$(\partial_t + v^i \nabla_i) \nabla_{\vec{a}} \rho_I^{j\ell} = \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} c_{\vec{a}, \vec{b}, \vec{c}} \nabla_{\vec{b}} v^i \nabla_{\vec{c}} \nabla_i \rho_I^{j\ell} \cdot 1_{|\vec{b}| \geq 1} \tag{10.47}$$

$$+ \nabla_{\vec{a}} \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i r^{ab}] + \nabla_{\vec{a}} \mathcal{R}^{j\ell} [y_I^i \nabla_i v^b] \tag{10.48}$$

Repeating the proof of the estimate (10.41), the commutator term in (10.47) is bounded by

$$\|(10.47)\|_{C^0} \lesssim \widehat{N}^{(|\vec{a}|-2)+} \Xi e_v^{1/2} \Xi^{|\vec{a}|} \widehat{\varepsilon} \mathfrak{h}(t)$$

Let $f^{j\ell} := \nabla_{\bar{a}} \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i r_I^{ab}]$ denote the first term in (10.48). Using $\nabla_i v^i = 0$, we have

$$f^{j\ell} = \mathcal{R}^{j\ell} \nabla_i [\nabla_{\bar{a}} [\nabla_a v^i r_I^{ab}]]$$

Letting $\hat{q} \in \mathbb{Z}$ be as in the pressure estimates of Section 10.1 ($2^{\hat{q}-1} < \hat{\Xi} \leq 2^{\hat{q}}$), we decompose $f^{j\ell} = f_L^{j\ell} + f_H^{j\ell}$, where

$$\begin{aligned} f_L^{j\ell} &= \mathcal{R}^{j\ell} \nabla_i P_{\leq \hat{q}} [\nabla_{\bar{a}} [\nabla_a v^i r_I^{ab}]] \\ f_H^{j\ell} &= \sum_{q > \hat{q}} \mathcal{R}^{j\ell} \nabla_i P_q [\nabla_{\bar{a}} [\nabla_a v^i r_I^{ab}]] \end{aligned} \quad (10.49)$$

In frequency space, the 0th order operator $\mathcal{R}^{j\ell} \nabla_i$ is represented by a Fourier multiplier $m_{ib}^{j\ell}$

$$\widehat{\mathcal{R}^{j\ell} \nabla_i [U]}(\xi) = m_{ib}^{j\ell}(\xi) \widehat{U}^b(\xi), \quad \xi \in \widehat{\mathbb{R}}^3$$

such that $m_{ib}^{j\ell}(\xi)$ is homogeneous of degree 0 and smooth away from the origin. This fact follows from the formulas (7.1) and (7.2), from which we observe that the corresponding Fourier-multiplier for $\mathcal{R}^{j\ell}$ is smooth away from the origin and homogeneous of degree -1 . Repeating the proof of (10.11), this observation allows us to bound

$$\begin{aligned} \|\mathcal{R}^{j\ell} \nabla_i P_{\leq \hat{q}}\| &\lesssim (1 + \hat{q}) \lesssim \log \hat{\Xi} \\ \|f_L^{j\ell}\|_{C^0} &\lesssim \log \hat{\Xi} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} \nabla_a v^i\|_{C^0} \|\nabla_{\bar{c}} r_I\|_{C^0} \\ &\lesssim \log \hat{\Xi} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [\widehat{N}^{(|\bar{b}|-2)+\Xi^{|\bar{b}|+1} e_v^{1/2}}] [\widehat{N}^{(|\bar{c}|-2)+\Xi^{|\bar{c}|}} \hat{\varepsilon} \mathfrak{h}(t)] \\ \|f_L^{j\ell}\|_{C^0} &\lesssim \log \hat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \end{aligned}$$

Meanwhile, the high-frequency term in (10.49) can be estimated by

$$\begin{aligned} f_H^{j\ell} &= \sum_{q > \hat{q}} \mathcal{R}^{j\ell} \nabla_i P_{\approx q} P_q [\nabla_{\bar{a}} [\nabla_a v^i r_I^{ab}]] \\ \|f_H^{j\ell}\|_{C^0} &\lesssim \sum_{q > \hat{q}} \|\mathcal{R}^{j\ell} \nabla_i P_{\approx q}\| \|P_q [\nabla_{\bar{a}} [\nabla_a v^i r_I^{ab}]]\|_{C^0} \\ &\lesssim \sum_{q > \hat{q}} 2^{-\alpha q} \|\nabla_{\bar{a}} [\nabla_a v^i r_I^{ab}]\|_{\dot{C}^\alpha} \\ &\lesssim \hat{\Xi}^{-\alpha} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} (\|\nabla_{\bar{b}} \nabla_a v^i\|_{\dot{C}^\alpha} \|\nabla_{\bar{c}} r_I\|_{C^0} + \|\nabla_{\bar{b}} \nabla_a v^i\|_{C^0} \|\nabla_{\bar{c}} r_I\|_{\dot{C}^\alpha}) \\ &\lesssim \hat{\Xi}^{-\alpha} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \hat{\Xi}^\alpha [\widehat{N}^{(|\bar{b}|-2)+\Xi^{|\bar{b}|+1} e_v^{1/2}}] [\widehat{N}^{(|\bar{c}|-2)+\Xi^{|\bar{c}|}} \hat{\varepsilon} \mathfrak{h}(t)] \\ \|f_H^{j\ell}\|_{C^0} &\lesssim \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \end{aligned}$$

We now turn to the second term in (10.48), which we call $g^{j\ell} := \nabla_{\bar{a}} \mathcal{R}^{j\ell} [y_I^i \nabla_i v^b]$, which is the dangerous term discussed in Section 7. In proving the pressure estimate (10.3), we have already encountered a term $\bar{p}_{I,1}$ with a similar structure. The term $g^{j\ell}$ will be estimated by similar techniques. We start by decomposing $g^{j\ell} = g_L^{j\ell} + g_H^{j\ell}$, where

&\lesssim \widehat{\Xi}^{-1} \widehat{\Xi}^{-\alpha} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} (\|\nabla_{\bar{b}} y_I\|_{\dot{C}^\alpha} \|\nabla_{\bar{c}} \nabla_i v^b\|_{C^0} + \|\nabla_{\bar{b}} y_I\|_{C^0} \|\nabla_{\bar{c}} \nabla_i v^b\|_{\dot{C}^\alpha}) \\
&\lesssim \widehat{\Xi}^{-1} \widehat{\Xi}^{-\alpha} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \widehat{\Xi}^\alpha [\widehat{N}^{(|\bar{b}|-2)+\Xi|\bar{b}|} e_R^{1/2} \mathfrak{h}(t)] [\widehat{N}^{(|\bar{c}|-2)+\Xi|\bar{c}|+1} e_v^{1/2}] \\
&\lesssim \widehat{\Xi}^{-1} \widehat{N}^{(|\bar{a}|-2)+\Xi|\bar{a}|+1} e_R^{1/2} e_v^{1/2} \mathfrak{h}(t) \\
&\lesssim \widehat{N}^{(|\bar{a}|-2)+\Xi|\bar{a}|} e_R \mathfrak{h}(t) \\
\|g_H\|_{C^0} &\lesssim \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi|\bar{a}|} \widehat{\varepsilon} \mathfrak{h}(t)
\end{aligned}$$

For the low frequency part in (10.50), we further decompose into $g_L^{j\ell} = g_{LL}^{j\ell} + g_{LH}^{j\ell}$, where

$$g_{LL}^{j\ell} = \nabla_{\bar{a}} \mathcal{R}^{j\ell} P_{\leq \hat{q}} [y_I^i \nabla_i P_{\leq \hat{q}} v^b] \quad (10.51)$$

$$g_{LH}^{j\ell} = \sum_{q>\hat{q}} \nabla_{\bar{a}} \mathcal{R}^{j\ell} P_{\leq \hat{q}} [y_I^i \nabla_i P_q v^b] \quad (10.52)$$

We estimate the latter term $g_{LH}^{j\ell}$ using $\nabla_i y_I^i = 0$ to obtain

&\lesssim \log \widehat{\Xi} \sum_{q>\hat{q}} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} y_I\|_{C^0} \|P_q \nabla_{\bar{c}} v^b\|_{C^0} \\
&\lesssim \log \widehat{\Xi} \sum_{q>\hat{q}} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} y_I\|_{C^0} [2^{-q} \|\nabla \nabla_{\bar{c}} v^b\|_{C^0}] \\
&\lesssim \log \widehat{\Xi} \widehat{\Xi}^{-1} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} y_I\|_{C^0} \|\nabla \nabla_{\bar{c}} v^b\|_{C^0} \\
&\lesssim \log \widehat{\Xi} \widehat{\Xi}^{-1} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [\widehat{N}^{(|\bar{b}|-2)+\Xi|\bar{b}|} e_R^{1/2} \mathfrak{h}(t)] [\widehat{N}^{(|\bar{c}|-2)+\Xi|\bar{c}|+1} e_v^{1/2}] \\
&\lesssim \log \widehat{\Xi} \widehat{\Xi}^{-1} \widehat{N}^{(|\bar{a}|-2)+\Xi|\bar{a}|+1} e_R^{1/2} e_v^{1/2} \mathfrak{h}(t) \\
&\lesssim \log \widehat{\Xi} \widehat{N}^{(|\bar{a}|-2)+\Xi|\bar{a}|} e_R \mathfrak{h}(t) \\
\|g_H^{j\ell}\|_{C^0} &\lesssim (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi|\bar{a}|} \widehat{\varepsilon} \mathfrak{h}(t)
\end{aligned}$$

Our technique to estimate the term $g_{LL}^{j\ell}$ in (10.51) is to first decompose into *frequency increments*:

$$\begin{aligned} g_{LL}^{j\ell} &= \sum_{q=-1}^{\hat{q}-1} g_{LLqA}^{j\ell} + g_{LLqB}^{j\ell} \\ g_{LLqA}^{j\ell} &= \nabla_{\bar{a}} \mathcal{R}^{j\ell} P_{q+1} [y_I^i \nabla_i P_{\leq q} v^b] \\ g_{LLqB}^{j\ell} &= \nabla_{\bar{a}} \mathcal{R}^{j\ell} P_{\leq q} [y_I^i \nabla_i P_{q+1} v^b] \end{aligned} \quad (10.53)$$

As in the estimates for (10.14), observe that $P_{\leq q} v^b$ and $P_{q+1} v$ are restricted to frequencies $|\xi| \leq 2^{q+2}$. The Littlewood Paley components of y_I supported in $|\xi| > 2^{q+5}$ thus cannot contribute to the P_{q+1} projection of the products above, and we have

$$\begin{aligned} \|g_{LLqA}^{j\ell}\|_{C^0} &\lesssim \|\mathcal{R}^{j\ell} P_{q+1}\| \|\nabla_{\bar{a}} [P_{\leq q+3} y_I^i \nabla_i P_{\leq q} v^b]\|_{C^0} \\ &\lesssim 2^{-q} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} P_{\leq q+3} y_I^i\|_{C^0} \|\nabla_{\bar{c}} \nabla_i v\|_{C^0} \\ &\lesssim 2^{-q} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|P_{\leq q+3} \nabla_a \nabla_{\bar{b}} r_I^{ai}\|_{C^0} \|\nabla_{\bar{c}} \nabla_i v\|_{C^0} \\ &\lesssim 2^{-q} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|P_{\leq q+3} \nabla_a\| \|\nabla_{\bar{b}} r_I^{ai}\|_{C^0} \|\nabla_{\bar{c}} \nabla_i v\|_{C^0} \\ &\lesssim 2^{-q} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} 2^q [\widehat{N}^{(|\bar{b}|-2)+\Xi^{|\bar{b}|}} \hat{\varepsilon} \mathfrak{h}(t)] [\widehat{N}^{(|\bar{c}|+1-3)+\Xi^{|\bar{c}|+1}} e_v^{1/2}] \\ \|g_{LLqA}^{j\ell}\|_{C^0} &\lesssim \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \end{aligned} \quad (10.56)$$

Using that $\nabla_i y_I^i = 0$ and again applying Proposition 8.1, we estimate (10.55) by

$$\begin{aligned} g_{LLqB}^{j\ell} &= \mathcal{R}^{j\ell} P_{\leq q} \nabla_i \nabla_{\bar{a}} [P_{\leq q+3} \nabla_a r_I^{ai} P_{q+1} v^b] \\ \|g_{LLqB}^{j\ell}\|_{C^0} &\lesssim \|\mathcal{R}^{j\ell} P_{\leq q} \nabla_i\| \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|P_{\leq q+3} \nabla_a\| \|\nabla_{\bar{b}} r_I\|_{C^0} \|P_{q+1} \nabla_{\bar{c}} v\|_{C^0} \\ &\lesssim (2+q) \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} 2^q \|\nabla_{\bar{b}} r_I\|_{C^0} [2^{-q} \|\nabla \nabla_{\bar{c}} v\|_{C^0}] \\ &\lesssim (2+q) \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [\widehat{N}^{(|\bar{b}|-2)+\Xi^{|\bar{b}|}} \hat{\varepsilon} \mathfrak{h}(t)] [\widehat{N}^{(|\bar{c}|+1-3)+\Xi^{|\bar{c}|+1}} e_v^{1/2}] \\ \|g_{LLqB}^{j\ell}\|_{C^0} &\lesssim (2+q) \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \end{aligned} \quad (10.57)$$

Summing the bounds (10.56) and (10.57) in (10.53) gives

$$\begin{aligned} \|g_{LL}^{j\ell}\|_{C^0} &\lesssim \sum_{q=-1}^{\hat{q}-1} (2+q) \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \\ &\lesssim (1+\hat{q})^2 \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \\ &\lesssim (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+\Xi^{|\bar{a}|}} \hat{\varepsilon} \mathfrak{h}(t) \end{aligned}$$

This estimate concludes the proof of (10.37) for $\rho_I^{j\ell}$. \square

We now prove the estimate (10.38) for ρ_I

Proof of (10.38) for ρ_I . Let $\nabla_{\vec{a}}$ be a partial derivative operator of order $|\vec{a}| = 3$, and let P_q , $q \in \mathbb{Z}$ be a Littlewood Paley projection with $q > \hat{q}$. Applying P_q to (10.47)-(10.48), we have

$$+ \nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [\nabla_a v^i \nabla_i r_I^{ab}] + \nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [y_I^i \nabla_i v^b] \quad (10.60)$$

Repeating the arguments leading to (10.45) and (10.46) but with ρ_I in place of z_I , we obtain

To bound the first term in (10.60), we use that $\nabla_i v^i = 0$ and $P_q = P_{\approx q} P_q$ to write

$$\begin{aligned} \nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [\nabla_a v^i \nabla_i r_I^{ab}] &= \mathcal{R}^{j\ell} \nabla_i P_{\approx q} P_q \nabla_{\vec{a}} [\nabla_a v^i r_I^{ab}] \\ \|\nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [\nabla_a v^i \nabla_i r_I^{ab}]\|_{C^0} &\lesssim \|\mathcal{R}^{j\ell} \nabla_i P_{\approx q}\| \|P_q \nabla_{\vec{a}} [\nabla_a v^i r_I^{ab}]\|_{C^0} \\ &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \|P_q \nabla_{\vec{b}} r_I^{ab} \nabla_{\vec{c}} \nabla_a v^i\|_{C^0} \\ &\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \|\nabla_{\vec{b}} r_I^{ab} \nabla_{\vec{c}} \nabla_a v^i\|_{\dot{C}^\alpha} \end{aligned}$$

$$\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} (\|\nabla_{\vec{b}} r_I^{ab}\|_{\dot{C}^\alpha} \|\nabla_{\vec{c}} \nabla_a v^i\|_{C^0} + \|\nabla_{\vec{b}} r_I^{ab}\|_{C^0} \|\nabla_{\vec{c}} \nabla_a v^i\|_{\dot{C}^\alpha})$$

$$\lesssim 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \widehat{\Xi}^\alpha [\widehat{N}^{(|\vec{b}|-2)_+} \Xi^{|\vec{b}|} \hat{\varepsilon} h(t)] [\widehat{N}^{(|\vec{c}|-2)_+} \Xi^{|\vec{c}|+1} e_v^{1/2}]$$

$$\|\nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [\nabla_a v^i \nabla_i r_I^{ab}]\|_{C^0} \lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} \hat{\varepsilon} h(t)$$

To bound the second term in (10.60), we use that $\widehat{\Xi} \leq 2^{\hat{q}} < 2^q$ to obtain

$$\begin{aligned} \nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [y_I^i \nabla_i v^b] &= \mathcal{R}^{j\ell} P_{\approx q} P_q \nabla_{\vec{a}} [y_I^i \nabla_i v^b] \\ \|\nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [y_I^i \nabla_i v^b]\|_{C^0} &\leq \|\mathcal{R}^{j\ell} P_{\approx q}\| \|P_q \nabla_{\vec{a}} [y_I^i \nabla_i v^b]\|_{C^0} \\ &\lesssim 2^{-q} 2^{-\alpha q} \|\nabla_{\vec{a}} [y_I^i \nabla_i v^b]\|_{\dot{C}^\alpha} \\ &\lesssim \widehat{\Xi}^{-1} 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} (\|\nabla_{\vec{b}} y_I^i\|_{\dot{C}^\alpha} \|\nabla_{\vec{c}} \nabla_i v^b\|_{C^0} + \|\nabla_{\vec{b}} y_I^i\|_{C^0} \|\nabla_{\vec{c}} \nabla_i v^b\|_{\dot{C}^\alpha}) \\ &\lesssim \widehat{\Xi}^{-1} 2^{-\alpha q} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \widehat{\Xi}^\alpha [\widehat{N}^{(|\vec{b}|-2)_+} \Xi^{|\vec{b}|} e_R^{1/2} h(t)] [\widehat{N}^{(|\vec{c}|-1)_+} \Xi^{|\vec{c}|+1} e_v^{1/2}] \\ &\lesssim \widehat{\Xi}^{-1} 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)_+} \Xi e_v^{1/2} \Xi^{|\vec{a}|} e_R^{1/2} h(t) \\ &\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} e_R h(t) \\ \|\nabla_{\vec{a}} \mathcal{R}^{j\ell} P_q [y_I^i \nabla_i v^b]\|_{C^0} &\lesssim 2^{-\alpha q} \widehat{\Xi}^\alpha \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} \hat{\varepsilon} h(t) \end{aligned}$$

This bound concludes our proof of (10.38) for ρ_I . \square

Having now proven Propositions 10.3 and 10.4, we are ready to complete the proof of the Gluing Approximation Lemma 3.2.

10.5 Proof of the Gluing Lemma 3.2

In this Section, we prove the Gluing Approximation Lemma 3.2 using the results of Sections 8-10.4.

Observe that Proposition 10.1 follows immediately from Propositions 10.3 and 10.4 and the Definition 10.1 of $h(t)$. Proposition 8.2 has also been proven, as it follows from Proposition 10.1 by the argument following the statement of Proposition 10.1. Thus, the time interval $[t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]$ is contained in the time interval of existence \tilde{J}_I , and the gluing construction is well-defined. Furthermore, recall from the proof of Proposition 8.2 from Proposition 10.1 that the dimensionless norm $h(t)$ associated with each index I satisfies $h(t) \leq 1$ for $t \in [t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]$.

In what follows, set $J_I = [t_0(I) - 8\theta_0, t_0(I) + 8\theta_0]$. We claim the following estimates.

Proposition 10.5. *Let y^ℓ , $\tilde{v}^\ell = v^\ell + y^\ell$ and $r_I^{j\ell} = \rho_I^{j\ell} + z_I^{j\ell}$ be as defined in Sections 6-8.*

$$\sup_{t \in \mathbb{R}} \|\nabla^k y\|_{C^0} \lesssim \widehat{N}^{(k-2)+} \Xi^k e_R^{1/2}, \quad k = 0, 1, 2, 3 \quad (10.61)$$

$$\sup_I \sup_{t \in J_I} \|\nabla^k (\partial_t + \tilde{v} \cdot \nabla) y_I\|_{C^0} \lesssim \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(k-2)+} \Xi^k e_R^{1/2}, \quad k = 0, 1, 2 \quad (10.62)$$

$$\sup_I \sup_{t \in J_I} \|\nabla^k (\partial_t + \tilde{v} \cdot \nabla) r_I\|_{C^0} \lesssim (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(k-2)+} \Xi^k \hat{\varepsilon}, \quad k = 0, 1, 2 \quad (10.63)$$

Proof. The bound (10.61) follows from the definition $y^\ell = \sum_I \eta_I y_I^\ell$ of y^ℓ and the estimate (8.3). To obtain (10.62), let $\nabla_{\bar{a}}$ be a partial derivative operator of order $|\bar{a}| = k \leq 2$. Then

$$\begin{aligned} (\partial_t + \tilde{v}^i \nabla_i) y_I^\ell &= (\partial_t + v^i + y_I^i) \nabla_i y_I^\ell + y^i \nabla_i y_I^\ell - y_I^i \nabla_i y_I^\ell \\ \nabla_{\bar{a}} [(\partial_t + \tilde{v}^i \nabla_i) y_I^\ell] &= \nabla_{\bar{a}} [(\partial_t + v^i \nabla_i + y_I^i \nabla_i) y_I^\ell] + \nabla_{\bar{a}} [(y^i - y_I^i) \nabla_i y_I^\ell] \end{aligned} \quad (10.64)$$

The first term on the right hand side of (10.64) is equal to the sum of the terms in line (10.29). For these terms, we established a bound

$$\begin{aligned} \|\nabla_{\bar{a}} [(\partial_t + v^i \nabla_i + y_I^i \nabla_i) y_I^\ell]\|_{C^0} &\lesssim \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+} \Xi^{|\bar{a}|} e_R^{1/2} (1 + h(t))^2 \\ &\lesssim \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+} \Xi^{|\bar{a}|} e_R^{1/2} \end{aligned}$$

The other term in (10.64) is bounded by

$$\begin{aligned} \|\nabla_{\bar{a}} [(y^i - y_I^i) \nabla_i y_I^\ell]\|_{C^0} &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} (\|\nabla_{\bar{b}} y^i\|_{C^0} + \|\nabla_{\bar{b}} y_I^i\|_{C^0}) \|\nabla_{\bar{c}} \nabla_i y_I\|_{C^0} \\ &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [\widehat{N}^{(|\bar{b}|-2)+} \Xi^{|\bar{b}|} e_R^{1/2}] [\widehat{N}^{(|\bar{c}|-1)+} \Xi^{|\bar{c}+1|} e_R^{1/2}] \\ &\lesssim \Xi e_R^{1/2} \widehat{N}^{(|\bar{a}|-1)+} \Xi^{|\bar{a}|} e_R^{1/2} \leq \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)+} \Xi^{|\bar{a}|} e_R^{1/2} \end{aligned}$$

To obtain (10.63), we compute

$$\begin{aligned} (\partial_t + \tilde{v} \cdot \nabla) r_I &= (\partial_t + v^i \nabla_i) [\rho_I^{j\ell} + z_I^{j\ell}] + y^i \nabla_i r_I^{j\ell} \\ \nabla_{\bar{a}} [(\partial_t + \tilde{v} \cdot \nabla) r_I] &= \nabla_{\bar{a}} [(\partial_t + v^i \nabla_i) r_I^{j\ell}] + \nabla_{\bar{a}} [y^i \nabla_i r_I^{j\ell}] \end{aligned} \quad (10.65)$$

The first term on the right hand side of (10.65) is equal to the sum of the terms in lines (10.40) and (10.48). For these terms, we proved a bound

$$\begin{aligned}\|\nabla_{\bar{a}}[(\partial_t + v^i \nabla_i) r_I^{j\ell}]\|_{C^0} &\lesssim (\log \widehat{\Xi})^2 \widehat{N}^{(|\bar{a}|-2)_+} \Xi e_v^{1/2} \Xi^{|\bar{a}|} \widehat{\varepsilon} (1 + \mathfrak{h}(t))^2 \\ &\lesssim (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)_+} \Xi^{|\bar{a}|} \widehat{\varepsilon}\end{aligned}$$

The other term in line (10.65) can be estimated by

$$\begin{aligned}\|\nabla_{\bar{a}}[y^i \nabla_i r_I^{j\ell}]\|_{C^0} &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} y^i\|_{C^0} \|\nabla_{\bar{c}} \nabla_i r_I\|_{C^0} \\ &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [\widehat{N}^{(|\bar{b}|-2)_+} \Xi^{|\bar{b}|} e_R^{1/2}] [\widehat{N}^{(|\bar{c}|-1)_+} \Xi^{|\bar{c}|} \widehat{\varepsilon}] \\ &\lesssim \Xi e_R^{1/2} \widehat{N}^{(|\bar{a}|-1)_+} \Xi^{|\bar{a}|} \widehat{\varepsilon} \leq \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)_+} \Xi^{|\bar{a}|} \widehat{\varepsilon}\end{aligned}$$

The proof of Proposition 10.5 is now complete. \square

Using the formulas

$$\tilde{v}^\ell = v^\ell + y^\ell$$

$$\begin{aligned}R_I &= 1_{[t(I)-\theta, t(I)+\theta]} \eta'_I(t) (r_I^{j\ell} - r_{I+1}^{j\ell}) + \eta_I \eta_{I+1} (y_I^j y_{I+1}^\ell + y_{I+1}^j y_I^\ell) \\ &\quad - \eta_I \eta_{I+1} (y_I^j y_I^\ell + y_{I+1}^j y_{I+1}^\ell)\end{aligned}$$

$$\widetilde{D}_t R_I = 1_{[t(I)-\theta, t(I)+\theta]} [\eta''_I(t) (r_I^{j\ell} - r_{I+1}^{j\ell}) + \eta'_I(t) \widetilde{D}_t (r_I^{j\ell} - r_{I+1}^{j\ell})] \quad (10.66)$$

$$+ (\eta'_I \eta_{I+1} + \eta_I \eta'_{I+1}) (y_I^j y_{I+1}^\ell + y_{I+1}^j y_I^\ell) \quad (10.67)$$

$$+ \eta_I \eta_{I+1} (\widetilde{D}_t y_I^j y_{I+1}^\ell + y_I^j \widetilde{D}_t y_{I+1}^\ell + \widetilde{D}_t y_{I+1}^j y_I^\ell + y_{I+1}^j \widetilde{D}_t y_I^\ell) \quad (10.68)$$

$$- (\eta'_I \eta_{I+1} + \eta_I \eta'_{I+1}) (y_I^j y_I^\ell + y_{I+1}^j y_{I+1}^\ell) \quad (10.69)$$

$$- \eta_I \eta_{I+1} (\widetilde{D}_t y_I^j y_I^\ell + y_I^j \widetilde{D}_t y_I^\ell + \widetilde{D}_t y_{I+1}^j y_{I+1}^\ell + y_{I+1}^j \widetilde{D}_t y_{I+1}^\ell) \quad (10.70)$$

$$\widetilde{D}_t := (\partial_t + \tilde{v} \cdot \nabla) \quad (10.71)$$

from (6.7) in Section 6 and applying the bounds of Proposition 10.5, we obtain the following estimates

Proposition 10.6. *Uniformly in $t \in \mathbb{R}$, for \widetilde{D}_t as in (10.71) we have*

$$\|\nabla^k \tilde{v}\|_{C^0} \lesssim \Xi^k e_v^{1/2}, \quad k = 1, 2, 3 \quad (10.72)$$

$$\sup_I \|\nabla^k R_I\|_{C^0} \lesssim_\delta \widehat{N}^{(k-2)_+} \Xi^k \log \widehat{\Xi} e_R, \quad k = 0, 1, 2, 3 \quad (10.73)$$

$$\sup_I \|\nabla^k \widetilde{D}_t R_I\|_{C^0} \lesssim_\delta (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(k-2)_+} \Xi^k \log \widehat{\Xi} e_R, \quad k = 0, 1, 2 \quad (10.74)$$

Proof. To obtain (10.72), we use

$$\|\nabla^k v^\ell\|_{C^0} + \|\nabla^k y^\ell\|_{C^0} \lesssim \Xi^k e_v^{1/2} + \widehat{N}^{(k-2)_+} \Xi^k e_R^{1/2} \lesssim \Xi^k e_v^{1/2}, \quad k = 1, 2, 3$$

For (10.73), let $\nabla_{\bar{a}}$ be a partial derivative operator of order $|\bar{a}| = k \leq 3$. Then

$$\begin{aligned}\|\nabla_{\bar{a}} R_I\|_{C^0} &\lesssim \|\eta'_I\|_{C^0} \sup_I \|\nabla_{\bar{a}} r_I\|_{C^0} + \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \sup_I \|\nabla_{\bar{b}} y_I\|_{C^0} \sup_I \|\nabla_{\bar{c}} y_I\|_{C^0} \\ &\lesssim_\delta (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(|\bar{a}|-2)_+} \Xi^{|\bar{a}|} \widehat{\varepsilon} + \widehat{N}^{(|\bar{a}|-2)_+} \Xi^{|\bar{a}|} e_R \\ &\lesssim_\delta \log \widehat{\Xi} \widehat{N}^{(|\bar{a}|-2)_+} \Xi^{|\bar{a}|} e_R\end{aligned}$$

For (10.74), let $\nabla_{\vec{a}}$ be a partial derivative operator of order $|\vec{a}| = k \leq 2$. We estimate $\nabla_{\vec{a}} \tilde{D}_t R_I$ by

$$\begin{aligned}
\|\nabla_{\vec{a}}(10.66)\|_{C^0} &\leq \sup_I [\|\eta_I''\|_{C^0} \|\nabla_{\vec{a}} r_I\|_{C^0} + \|\eta_I'\|_{C^0} \|\nabla_{\vec{a}} \tilde{D}_t r_I\|_{C^0}] \\
&\lesssim_{\delta} [(\log \widehat{\Xi})^2 \Xi e_v^{1/2}]^2 \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} \hat{\varepsilon} \\
&\lesssim_{\delta} (\log \widehat{\Xi})^3 \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} e_R \\
\|\nabla_{\vec{a}}(10.67)\|_{C^0} + \|\nabla_{\vec{a}}(10.69)\|_{C^0} &\lesssim_{\delta} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \sup_I \|\nabla_{\vec{b}} y_I\|_{C^0} \sup_I \|\nabla_{\vec{c}} y_I\|_{C^0} \\
&\lesssim_{\delta} (\log \widehat{\Xi})^2 \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} e_R \\
\|\nabla_{\vec{a}}(10.68)\|_{C^0} + \|\nabla_{\vec{a}}(10.70)\|_{C^0} &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \sup_I \|\nabla_{\vec{b}} y_I\|_{C^0} \sup_I \|\nabla_{\vec{c}} \tilde{D}_t y_I\|_{C^0} \\
&\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} [\widehat{N}^{(|\vec{b}|-2)_+} \Xi^{|\vec{b}|} e_R^{1/2}] [\log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\vec{c}|-2)_+} \Xi^{|\vec{c}|} e_R^{1/2}] \\
&\lesssim \log \widehat{\Xi} \Xi e_v^{1/2} \widehat{N}^{(|\vec{a}|-2)_+} \Xi^{|\vec{a}|} e_R
\end{aligned}$$

Combining these bounds proves (10.74) and finishes the proof of Proposition 10.6. \square

From Proposition 10.6, we have established the estimates claimed in the Gluing Approximation Lemma 3.2 (noting that $\widehat{N}^{(|\vec{a}|-2)_+} = 1$ in (10.74) for $|\vec{a}| \leq 2$). As we have already discussed the proof of the support properties in Sections 6-8 (see in particular the discussion at the end of Section 6), we have finished the proof of Lemma 3.2.

Part IV

The Convex Integration Sublemma

In Sections 11-17.6 below, we prove the Convex Integration Lemma 3.3. The proof of the Lemma is a combination of the framework of estimates in [Ise17] with the construction of Mikado flows in [DS16]. We start by introducing some notation that will be used in this section.

For this proof, the notation $X \lesssim Y$ will mean that there exists a constant C such that $X \leq CY$, and this constant C is allowed to depend on the constants C_1 and C_{δ} and δ provided in the assumptions of Lemma 3.3 (which are the conclusions of Lemma 3.2). If a constant depends on the parameter $\eta > 0$, we will write \lesssim_{η} . We will write $X \leq C_0 Y$ for an inequality involving a constant C_0 that is an absolute constant that is not allowed to depend on C_1 , C_{δ} or η . The value of C_0 may change from line to line.

As opposed to the proof of Lemma 3.2, in this proof the notation $\|f\|_{C^0}$ will refer to the $C^0 = C_{t,x}^0$ norm in both the time and space variables.

If $A = A_i^j \in \mathbb{R}^{3 \times 3}$ is a 3×3 matrix, we will let $|A|$ denote the Frobenius norm of A , namely $|A| = (\sum_{i,j=1}^3 (A_i^j)^2)^{1/2}$. In general, for any tensor field, it is implied that the Frobenius norm is taken pointwise whenever we write a norm such as the C^0 norm.

11 Mikado Flows

We recall the construction of Mikado flows from [DS16].

Let $\mathbb{F} \subseteq \mathbb{Z}^3$ be a finite set of integer lattice vectors. Then there exists a collection of points $(p_f)_{f \in \mathbb{F}}$ in \mathbb{T}^3 and a number $r_0 > 0$ such that if $\ell_f = \{p_f + tf : t \in \mathbb{R}\} \subseteq \mathbb{T}^3$ denotes the periodization of the

line passing through p_f in the f direction, and if $N_\delta(\ell_f) = \{X + h : X \in \mathbb{T}^3, h \in \mathbb{R}^3, |h| \leq \delta\}$ denotes the closed δ -neighborhood of ℓ_f , then

$$N_{3r_0}(\ell_f) \cap N_{3r_0}(\ell_{\tilde{f}}) = \emptyset, \quad \text{for all } f, \tilde{f} \in \mathbb{F}, f \neq \tilde{f}. \quad (11.1)$$

For each $f \in \mathbb{F}$, choose a function $\psi_f(X) : \mathbb{T}^3 \rightarrow \mathbb{R}$ of the form $\psi_f(X) = g_f(\text{dist}(X, \ell_f))$ such that $g_f = g_f(d)$ is a smooth function with compact supported in $\text{supp } g_f \subseteq \{r_0 \leq d \leq 2r_0\}$ and

$$\int_{\mathbb{T}^3} \psi_f(X) dX = 0 \quad (11.2)$$

$$\frac{1}{|\mathbb{T}^3|} \int_{\mathbb{T}^3} \psi_f^2(X) dx = 1 \quad (11.3)$$

Then $\psi_f(X)$ is a smooth function on \mathbb{T}^3 whose level surfaces are concentric periodic cylinders with central axis ℓ_f . From the orthogonality between $\nabla \psi$ and f and (11.1), one has that the vector fields $u_f^\ell = \psi_f(X) f^\ell$ are divergence free and have disjoint support

$$\nabla_\ell \psi_f(X) f^\ell = 0 \quad (11.4)$$

$$\text{supp } \psi_f \cap \text{supp } \psi_{\tilde{f}} = \emptyset \quad \text{for all } f, \tilde{f} \in \mathbb{F}, f \neq \tilde{f} \quad (11.5)$$

Combining (11.4) and (11.5), one has that any linear combination $u^\ell = \sum_{f \in \mathbb{F}} \gamma_f \psi_f(X) f^\ell$ is a stationary solution to incompressible Euler with 0 pressure (i.e. $\nabla_\ell u^\ell = 0$ and $\nabla_j (u^j u^\ell) = 0$). Solutions constructed as above are termed Mikado flows in [DS16].

Letting e_i denote the i th standard basis vector in \mathbb{Z}^3 , we will fix our finite set \mathbb{F} to be

$$\mathbb{F} := \{e_i \pm e_j : 1 \leq i < j \leq 3\} \quad (11.6)$$

and use ψ_f to denote the above chosen ψ_f . Note that the cardinality of \mathbb{F} is $|\mathbb{F}| = 6$.

12 The Coarse Scale Flow and Back-To-Labels Map

Let (v, p, R) be the Euler-Reynolds flow given in the statement of Lemma 3.3. Let $v_\epsilon = \eta_\epsilon * v$ be a mollification of v in the spatial variables, where $\eta_\epsilon : \mathbb{R}^3 \rightarrow \mathbb{R}$ is a standard smooth mollifier $\eta_\epsilon(h) = \epsilon^{-3} \eta(h/\epsilon)$ with compact supported in $\text{supp } \eta_\epsilon(h) \subseteq \{|h| \leq \epsilon\}$. The positive number $\epsilon \leq 1$ will be chosen later in the proof in Section 16 below. Regardless of the choice of $\epsilon > 0$, one has that

$$\|\nabla v_\epsilon\|_{C^0} \leq A_0 \|\nabla v\|_{C^0}$$

with $A_0 = \|\eta_1\|_{L^1(\mathbb{R}^3)}$ an absolute constant, which will later be set to $A_0 = 1$ by taking $\eta \geq 0$.

Associated to v_ϵ we define the **coarse scale flow** as the map $\Phi_s(t, x) : \mathbb{R} \times \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{R} \times \mathbb{T}^3$ by

$$\begin{aligned} \Phi_s(t, x) &= (t + s, \Phi_s^i(t, x)) \\ \frac{d}{ds} \Phi_s^i(t, x) &= v_\epsilon^i(\Phi_s(t, x)), \quad i = 1, 2, 3 \\ \Phi_0(t, x) &= (t, x) \end{aligned} \quad (12.1)$$

Then Φ_s is the flow map of the four-vector field $\partial_t + v_\epsilon \cdot \nabla$ on $\mathbb{R} \times \mathbb{T}^3$, and satisfies $\Phi_s \circ \Phi_{s'} = \Phi_{s+s'}$ for all $s, s' \in \mathbb{R}$. In particular, for all $s \in \mathbb{R}$, Φ_s is a bijection on $\mathbb{R} \times \mathbb{T}^3$ with inverse map Φ_{-s} .

Let $(t(I))_{I \in \mathbb{Z}}$ be as in the assumptions of Lemma 3.3. For each $t(I) \in \mathbb{R}$, we define the **back-to-labels map** Γ_I starting at $t(I)$ as the (unique, smooth) solution to

$$\begin{aligned} (\partial_t + v_\epsilon^i \nabla_i) \Gamma_I(t, x) &= 0 \\ \Gamma_I(t(I), x) &= x \end{aligned}$$

One can regard Γ_I as a map $\Gamma_I : \mathbb{R} \times \mathbb{R}^3 \rightarrow \mathbb{R}^3$ with the symmetry $\Gamma_I(t, x + \ell) = \Gamma_I(t, x) + \ell$ for all $\ell \in \mathbb{Z}^3$, which holds due to the integer periodicity of v_ϵ and uniqueness of solutions to the transport equation. From this symmetry, we can also think of $\Gamma_I : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathbb{T}^3$ as a map on the torus.

Recall that Lemma 3.3 assumes that

$$\theta \|\nabla v\|_{C^0} \leq b_0$$

where b_0 is an absolute constant that remains to be chosen. We will later choose some $b_0 \leq 1$, so that the estimates of the following Proposition hold:

Proposition 12.1. *There exists an absolute constant C_0 such that if $\theta \|\nabla v\|_{C^0} \leq 1$ then for all $t \in [t(I) - \theta, t(I) + \theta]$ and $0 < \epsilon \leq 1$*

$$\|\nabla \Gamma_I\|_{C^0} \leq C_0 \tag{12.2}$$

$$\|(\partial_t + v_\epsilon \cdot \nabla) \nabla \Gamma_I\|_{C^0} \leq C_0 \|\nabla v\|_{C^0} \tag{12.3}$$

$$\|\nabla \Gamma_I - \text{Id}\|_{C^0} \leq C_0 \theta \|\nabla v\|_{C^0} \tag{12.4}$$

Moreover, $\nabla \Gamma_I(t, x)$ is invertible at every point, and the inverse matrix $\nabla \Gamma_I^{-1}$ satisfies the same estimates (12.2)-(12.4) when restricted to $t \in [t(I) - \theta, t(I) + \theta]$.

Proof. The equation for $\nabla \Gamma_I$ is

$$\begin{aligned} (\partial_t + v_\epsilon^i \nabla_i) \nabla_a \Gamma_I^k &= -\nabla_a v_\epsilon^i \nabla_i \Gamma_I^k \\ \nabla_a \Gamma_I^k(t(I), x) &= \text{Id}_a^k = \delta_a^k \end{aligned} \tag{12.5}$$

For $|s| \leq \theta$, let Φ_s be as in (12.1) and $\|\cdot\|^2$ denote the Frobenius norm. Using (12.5), we have

$$\begin{aligned} \frac{d}{ds} \|\nabla \Gamma_I\|^2(\Phi_s(t(I), x)) &= \sum_{a,k=1}^3 (\nabla \Gamma_I)_a^k(\Phi_s) [(\partial_t + v_\epsilon \cdot \nabla) (\nabla \Gamma_I)_a^k](\Phi_s) \\ \left| \frac{d}{ds} \|\nabla \Gamma_I\|^2(\Phi_s(t(I), x)) \right| &\leq C_0 \|\nabla v_\epsilon\|_{C^0} \|\nabla \Gamma_I\|^2(\Phi_s) \\ \text{Gronwall} \quad \Rightarrow \|\nabla \Gamma_I\|^2(\Phi_s(t(I), x)) &\leq \|\text{Id}\| e^{C_0 \|\nabla v_\epsilon\|_{C^0} |s|} \leq \|\text{Id}\| e^{C_0 \|\nabla v\|_{C^0} |s|} \\ |s| \|\nabla v\|_{C^0} \leq 1 \quad \Rightarrow \|\nabla \Gamma_I\|^2(\Phi_s(t(I), x)) &\leq C_0^2 \end{aligned}$$

Since $\Phi_s(t(I), \cdot)$ maps $\{t(I)\} \times \mathbb{T}^3$ onto $\{t(I) + s\} \times \mathbb{T}^3$, (12.2) follows. Then (12.3) follows from (12.5) and (12.2). To obtain (12.4), write

$$\begin{aligned} \nabla \Gamma_I(\Phi_s(t(I), x)) - \text{Id} &= \nabla \Gamma_I(\Phi_s(t(I), x)) - \nabla \Gamma_I(\Phi_0(t(I), x)) \\ &= \int_0^s \frac{d}{d\sigma} \nabla \Gamma_I(\Phi_\sigma(t(I), x)) \\ &= \int_0^s [(\partial_t + v_\epsilon \cdot \nabla) \nabla \Gamma_I](\Phi_\sigma(t(I), x)), \end{aligned}$$

then apply (12.2),(12.3) and $|s| \leq \theta$.

To see the invertibility of $\nabla\Gamma_I$, let Y_b^a be the unique matrix-valued solution to the equation

$$\begin{aligned} (\partial_t + v_\epsilon^i \nabla_i) Y_b^a &= \nabla_i v_\epsilon^a Y_b^i \\ Y_b^a(t(I), x) &= \text{Id}_b^a \end{aligned} \quad (12.6)$$

Then $Y_b^a = (\nabla\Gamma_I^{-1})_b^a$ is also the unique inverse to $\nabla\Gamma_I$, as we have

$$\begin{aligned} (\partial_t + v_\epsilon^i \nabla_i)[(\nabla\Gamma_I)_a^k Y_b^a] &= -\nabla_i \Gamma_I^k \nabla_a v_\epsilon^i Y_b^a + \nabla_a \Gamma_I^k \nabla_i v_\epsilon^a Y_b^i = 0 \\ (\nabla\Gamma_I)_a^k Y_b^a(t(I), x) &= \text{Id}_b^k \end{aligned}$$

The proof of the estimates (12.2)-(12.4) for $(\nabla\Gamma_I^{-1})_b^a$ proceed exactly as for $\nabla\Gamma_I$, but using (12.6). \square

13 Ansatz for the Correction

We now explain the Ansatz for the correction. The Ansatz used here is equivalent to the one in [DS16] with the only significant differences being the presence of time cutoffs and the use of multiple waves.

The new Euler-Reynolds flow (v_1, p_1, R_1) in the conclusion of Lemma 3.3 will have a velocity field of the form $v_1 = v + V$. The correction V is a sum of divergence free vector fields V_J indexed by $J = (I, f) \in \mathbb{Z} \times \mathbb{F}$. The integer part $I \in \mathbb{Z}$ will specify the $t(I) \in \mathbb{R}$ around which V_J is supported in time, while the index $f \in \mathbb{F}$ will correspond to the direction in which V_J takes values.

$$V^\ell = \sum_{J \in \mathbb{Z} \times \mathbb{F}} V_J^\ell, \quad \nabla_\ell V_J^\ell = 0 \quad \text{for all } J \in \mathbb{Z} \times \mathbb{F}$$

The leading order term in each V_J , $J = (I, f) \in \mathbb{Z} \times \mathbb{F}$, has the structure of a Mikado flow (as described in Section 11), but rescaled to have a large frequency $\lambda \in \mathbb{Z}$ and made to move along the coarse scale flow by composition with the back-to-labels map

$$\begin{aligned} V_J^\ell &= \mathring{V}_J^\ell + \delta V_J^\ell \\ \mathring{V}_J^\ell(t, x) &= v_J^\ell(t, x) \psi_f(\lambda \Gamma_I(t, x)), \quad J = (I, f) \end{aligned} \quad (13.1)$$

The leading order term \mathring{V}_J is divergence free to leading order in the large parameter λ , as we will have

$$v_J^\ell \nabla_\ell [\psi_f(\lambda \Gamma_I(t, x))] = 0 \quad (13.2)$$

The lower order term δV_J^ℓ will be chosen such that V_J^ℓ is exactly divergence free.

More precisely, the amplitude v_J^ℓ in (13.1) will have the form

$$v_J^\ell = e_I^{1/2}(t) \gamma_J(t, x) (\nabla\Gamma_I^{-1})_a^\ell f^a \quad (13.3)$$

for functions $e_I^{1/2}(t)$ and $\gamma_J(t, x)$ to be described shortly. The identity (13.2) follows from this Ansatz thanks to the presence of $(\nabla\Gamma_I^{-1})$ and (11.4). The function $e_I^{1/2}(t)$ is required to satisfy

$$\text{supp}_t e_I^{1/2}(t) \subseteq [t(I) - \theta, t(I) + \theta] \quad (13.4)$$

To correct the Ansatz (13.1) and ensure the divergence free condition, for each $f \in \mathbb{F}$ choose a smooth $(2, 0)$ tensor field $\Omega_f^{\alpha\beta} : \mathbb{T}^3 \rightarrow \mathbb{R}^3 \otimes \mathbb{R}^3$ such that $\Omega_f^{\alpha\beta}$ is anti-symmetric in α, β , and

$$\nabla_\alpha \Omega_f^{\alpha\beta}(X) = \psi_f(X) f^\beta \quad (13.5)$$

$$\int_{\mathbb{T}^3} \Omega_f^{\alpha\beta}(X) dX = 0 \quad (13.6)$$

One can take for instance $\Omega_f^{\alpha\beta} = \nabla^\alpha \Delta^{-1}[\psi_f f^\beta] - \nabla^\beta \Delta^{-1}[\psi_f f^\alpha]$. The existence of this choice relies on the fact that $\psi_f(X)f^\ell$ is divergence free and has integral 0 on \mathbb{T}^3 .

We now define

$$V_J^\ell = \lambda^{-1} \nabla_a [(\nabla \Gamma_I^{-1})_\alpha^a (\nabla \Gamma_I^{-1})_\beta^\ell e_I^{1/2}(t) \gamma_J \Omega_f^{\alpha\beta}(\lambda \Gamma_I)], \quad J = (I, f) \in \mathbb{Z} \times \mathbb{F} \quad (13.7)$$

The V_J^ℓ above is divergence free because it is the divergence of an antisymmetric tensor. (The tensor within the brackets is antisymmetric in a, ℓ because $\Omega_f^{\alpha\beta} = -\Omega_f^{\beta\alpha}$ is antisymmetric in α, β .) Expanding the divergence in (13.7) and using (13.5), one sees that V_J^ℓ has the form (13.1) for

$$\delta V_J^\ell = \delta v_{J, \alpha\beta}^\ell \Omega_f^{\alpha\beta}(\lambda \Gamma_I) \quad (13.8)$$

$$\delta v_{J, \alpha\beta}^\ell = \lambda^{-1} \nabla_a [(\nabla \Gamma_I^{-1})_\alpha^a (\nabla \Gamma_I^{-1})_\beta^\ell e_I^{1/2}(t) \gamma_J(t, x)] \quad (13.9)$$

14 The Error Terms

Let (v, p, R) be the given Euler-Reynolds flow obeying the assumptions of Lemma 3.3. The new Euler-Reynolds flow (v_1, p_1, R_1) will have the form $v_1 = v + V$, $p_1 = p + P$, and $R_1^{j\ell}$ that satisfies

$$\nabla_j R_1^{j\ell} = \partial_t V^\ell + \nabla_j [v^j V^\ell + V^j v^\ell + V^j V^\ell + P \delta^{j\ell} + R^{j\ell}]$$

We will define mollifications v_ϵ and R_ϵ to approximate v and R . Recall also the decomposition $V^\ell = \sum_J \check{V}_J^\ell + \delta V_J^\ell$. In terms of these, the new error $R_1^{j\ell}$ will be composed of terms that solve

$$R_1^{j\ell} = R_M^{j\ell} + R_T^{j\ell} + R_S^{j\ell} + R_H^{j\ell} \quad (14.1)$$

$$R_M^{j\ell} = (v^j - v_\epsilon^j) V^\ell + V^j (v^\ell - v_\epsilon^\ell) + (R^{j\ell} - R_\epsilon^{j\ell}) \quad (14.2)$$

$$\nabla_j R_T^{j\ell} = \partial_t V^\ell + v_\epsilon^j \nabla_j V^\ell + V^j \nabla_j v_\epsilon^\ell \quad (14.3)$$

$$R_S^{j\ell} = \sum_{J, K \in \mathbb{Z} \times \mathbb{F}} \delta V_J^j \check{V}_K^\ell + \check{V}_J^j \delta V_K^\ell + \delta V_J^j \delta V_K^\ell \quad (14.4)$$

$$\nabla_j R_H^{j\ell} = \nabla_j \left[\sum_{J \in \mathbb{Z} \times \mathbb{F}} \check{V}_J^j \check{V}_J^\ell + P \delta^{j\ell} + R_\epsilon^{j\ell} \right] \quad (14.5)$$

Note that we used $\nabla_j V_J^j = 0$ to obtain (14.3). Note also that (14.4) is symmetric in j, ℓ due to the double sum over $\mathbb{Z} \times \mathbb{F}$. In order to obtain (14.5), a key cancellation comes from the fact that $\text{supp } \check{V}_J \cap \text{supp } \check{V}_K = \emptyset$ for all $J, K \in \mathbb{Z} \times \mathbb{F}$, $J \neq K$, which eliminates all the cross terms in the product. This disjointness of support follows from (11.5), (13.4) and (3.7).

The amplitudes v_ϵ^j in (13.1)-(13.3) and the correction P to the pressure will be chosen such that

$$\sum_{J \in \mathbb{Z} \times \mathbb{F}} v_J^j v_J^\ell + P \delta^{j\ell} + R_\epsilon^{j\ell} = 0 \quad (14.6)$$

In this way, the ‘‘low-frequency’’ part of (14.5) will cancel out, and (14.5) becomes (using (13.1),(13.3))

$$\nabla_j R_H^{j\ell} = \sum_{J \in \mathbb{Z} \times \mathbb{F}} \nabla_j [v_J^j v_J^\ell (\psi_f^2(\lambda \Gamma_I) - 1)], \quad J = (I, f) \quad (14.7)$$

15 The Algebraic Equation

In this Section, we specify how the $e_I^{1/2}(t)$, $\gamma_J(t, x)$ and P above are chosen so that (14.6) is satisfied.

From Lemma 3.3, there is a decomposition $R = \sum_I R_I$ with $\text{supp}_t R_I \subseteq [t(I) - \frac{\theta}{2}, t(I) + \frac{\theta}{2}]$. We will define $R_\epsilon^{j\ell} = \eta_\epsilon * R^{j\ell}$ by mollifying only in the spatial variables, and hence we obtain an analogous decomposition $R_\epsilon^{j\ell} = \sum_I R_{I,\epsilon}^{j\ell}$, with $R_{I,\epsilon}^{j\ell} = \eta_\epsilon * R_I^{j\ell}$ supported in the same time intervals $\text{supp}_t R_{I,\epsilon}^{j\ell} \subseteq [t(I) - \frac{\theta}{2}, t(I) + \frac{\theta}{2}]$.

Writing $P = \sum_I P_I$, equation (14.6) now reduces to choosing v_J and P_I such that for all $I \in \mathbb{Z}$

$$\sum_{J \in I \times \mathbb{F}} v_J^j v_J^\ell + P_I \delta^{j\ell} + R_{I,\epsilon}^{j\ell} = 0. \quad (15.1)$$

We take $P_I = -e_I(t)$, and (15.1) reduces to

$$\sum_{J \in I \times \mathbb{F}} v_J^j v_J^\ell = e_I(t) \sum_{J \in I \times \mathbb{F}} \gamma_J^2 (\nabla \Gamma_I^{-1})_a^j (\nabla \Gamma_I^{-1})_b^\ell f^a f^b = e(t) \delta^{j\ell} - R_{I,\epsilon}^{j\ell}$$

Assuming that we can divide by $e_I(t)$, this equation will hold if we have for all $I \in \mathbb{Z}$

$$\begin{aligned} \sum_{J \in I \times \mathbb{F}} \gamma_J^2 (\nabla \Gamma_I^{-1})_a^j (\nabla \Gamma_I^{-1})_b^\ell f^a f^b &= \delta^{j\ell} + \varepsilon_I^{j\ell} \\ \varepsilon_I^{j\ell} &= -e_I(t)^{-1} R_{I,\epsilon}^{j\ell} \end{aligned} \quad (15.2)$$

To ensure that the above division is well-behaved, we choose $e_I^{1/2}(t)$ to have the form

$$e_I^{1/2}(t) = [K C_\delta \log \widehat{\Xi} e_R]^{1/2} \eta_{\theta/8} * \mathbf{1}_{[t(I)-3\theta/4, t(I)+3\theta/4]}(t) \quad (15.3)$$

In the above formula, C_δ is the constant in the upper bound (3.10), $\eta_{\theta/8}(\tau)$ is a standard mollifying kernel in the time variable supported in $|\tau| \leq \frac{\theta}{8}$, $\mathbf{1}_{[t(I)-3\theta/4, t(I)+3\theta/4]}$ is the characteristic function of $[t(I) - 3\theta/4, t(I) + 3\theta/4]$ and K is a large constant to be determined shortly. Note that the support restriction (13.4) is satisfied by the above formula.

From the support property of $R_{I,\epsilon}$ and (3.10) (which holds also for $R_{I,\epsilon}$), we have

$$\|\varepsilon_I\|_{C^0} \leq K^{-1} \quad (15.4)$$

Applying $(\nabla \Gamma_I)$ to (15.2), it suffices have for all $I \in \mathbb{Z}$ and all $(t, x) \in [t(I) - \theta, t(I) + \theta] \times \mathbb{T}^3$ that

$$\sum_{J \in \{I\} \times \mathbb{F}} \gamma_J^2 f^j f^\ell = (\nabla \Gamma_I)_a^j (\nabla \Gamma_I)_b^\ell (\delta^{ab} + \varepsilon^{ab}), \quad J = (I, f) \in \mathbb{Z} \times \mathbb{F} \quad (15.5)$$

At each point (t, x) , the right hand side belongs to the space $\mathcal{S} \subseteq \mathbb{R}^3 \otimes \mathbb{R}^3$ of symmetric $(2, 0)$ tensors. From our choice of \mathbb{F} in (11.6), the following claims hold

The tensors $(f^j f^\ell)_{f \in \mathbb{F}}$ form a basis for \mathcal{S} (15.6)

$$\sum_{f \in \mathbb{F}} \frac{1}{4} f^j f^\ell = \delta^{j\ell} \quad (15.7)$$

Viewing the right hand side of (15.5) as a perturbation of $\delta^{j\ell}$, we assume $\gamma_{(I,f)}^2$ will have the form

$$\gamma_{(I,f)}^2(t, x) = \frac{1}{4} + a_{(I,f)}(t, x) + b_{(I,f)}(t, x) \quad (15.8)$$

$$\sum_{f \in \mathbb{F}} a_{(I,f)} f^j f^\ell = [(\nabla \Gamma_I)_a^j (\nabla \Gamma_I)_b^\ell - \text{Id}_a^j \text{Id}_b^\ell] \delta^{ab} \quad (15.9)$$

$$\sum_{f \in \mathbb{F}} b_{(I,f)} f^j f^\ell = (\nabla \Gamma_I)_a^j (\nabla \Gamma_I)_b^\ell \varepsilon_I^{ab} \quad (15.10)$$

Inverting to solve for $b_{(I,f)}$ and $a_{(I,f)}$ (which is possible by Claim (15.6)), we have the following bounds

$$\|a_{(I,f)}\|_{C^0} \leq C_0(1 + \|\nabla\Gamma_I\|_{C^0})\|(\nabla\Gamma_I) - \text{Id}\|_{C^0} \quad (15.11)$$

$$\stackrel{(12.4)}{\leq} C_0\theta\|\nabla v\|_{C^0} \quad (15.12)$$

$$\|b_{(I,f)}\|_{C^0} \leq C_0\|\nabla\Gamma_I\|_{C^0}^2\|\varepsilon_I\|_{C^0} \quad (15.13)$$

$$\stackrel{(15.4)}{\leq} C_0K^{-1} \quad (15.14)$$

We choose K to be an absolute constant such that the last term is bounded by 20^{-1} . The right hand side of (15.12) is bounded by C_0b_0 where b_0 appears in the bound (3.12). We now choose b_0 an absolute constant such that (15.12) is at most 20^{-1} . With these choices, we can take the positive square root in (15.8) to define γ_J , which then solves (15.5) thanks to (15.7).

Note that we have now represented the coefficients $\gamma_J(t, x) = \gamma_{(I,f)}(t, x)$ in the form

$$\gamma_{(I,f)}(t, x) = \gamma_f(\nabla\Gamma_I, \varepsilon_I), \quad (15.15)$$

where $\gamma_f : \overline{K} \rightarrow \mathbb{R}$ is one of 6 smooth functions $(\gamma_f)_{f \in \mathbb{F}}$ that are defined on an appropriate, compact subset $\overline{K} \subseteq \mathbb{R}^{3 \times 3} \times \mathcal{S}$ containing the range of $(\nabla\Gamma_I, \varepsilon_I)$ and that are bounded by $\sup_{\overline{K}} |\gamma_f(\cdot)| \leq 1$.

The construction is now entirely specified except for the definitions of v_ε and R_ε and the choice of the large parameter $\lambda \in \mathbb{Z}$. The choices of these terms will be governed by the estimates we need to prove. We start by defining v_ε and R_ε .

16 The Coarse Scale Velocity Field and Stress Tensor

Following [Ise17], the regularization of $R^{j\ell}$ will have a double mollification structure $R_\varepsilon^{j\ell} := \eta_\varepsilon * \eta_\varepsilon * R^{j\ell}$. The double-mollification structure will play a role in the advective derivative bounds of Proposition 16.1 below. The mollifying kernel η_ε has support in $|h| \leq \varepsilon$ and satisfies the vanishing moment condition $\int_{\mathbb{R}^3} h^a \eta_\varepsilon(h) dh = 0$ for each co-ordinate $a = 1, 2, 3$, so that $\|R - \eta_\varepsilon * R\|_{C^0} \leq C_0\varepsilon^2\|\nabla^2 R\|_{C^0}$ holds⁷. We may also take η even and non-negative for convenience.

The choice of ε here is dictated by the bound on $R - R_\varepsilon$, which is given by

$$\begin{aligned} \|R - R_\varepsilon\|_{C^0} &\leq \|R - \eta_\varepsilon * R\|_{C^0} + \|\eta_\varepsilon * [R - \eta_\varepsilon * R]\|_{C^0} \\ &\leq C_0\varepsilon^2\|\nabla^2 R\|_{C^0} \\ \|R - R_\varepsilon\|_{C^0} &\stackrel{(3.10)}{\lesssim} \varepsilon^2 \log \widehat{\Xi} \Xi^2 e_R \end{aligned}$$

(Recall that constants in the \lesssim notation can depend on the C_1 and C_δ in the hypotheses of Lemma 3.3.)

Take $\varepsilon = \varepsilon_R$ to have the form $\varepsilon_R = c_R N^{-1/2} \Xi^{-1}$, where c_R is a small constant chosen to imply

$$\|R - R_\varepsilon\|_{C^0} \leq \log \widehat{\Xi} \frac{e_R}{500N} \quad (16.1)$$

This choice leads to the estimates

$$\|\nabla^k R_\varepsilon\|_{C^0} \lesssim_k \log \widehat{\Xi} N^{(k-2)_+/2} \Xi^k e_R, \quad (16.2)$$

(which are the same as those in [Ise17] except for the appearance of $\log \widehat{\Xi}$). To prove (16.2), use (3.10) for $0 \leq k \leq 2$ and write $\nabla^k \eta_\varepsilon * \eta_\varepsilon * R = [\nabla^{k-2} \eta_\varepsilon * \eta_\varepsilon] * \nabla^2 R$ for $k > 2$.

⁷A proof of this statement, which is well-known, can be found in [Ise17, Section 14].

To define v_ϵ , consider the error term

$$\begin{aligned} R_{M,v_1}^{j\ell} &= \sum_J (v^j - v_\epsilon^j) \overset{\circ}{V}_J^\ell + \overset{\circ}{V}_J^j (v^\ell - v_\epsilon^\ell), \\ &= \sum_J [(v^j - v_\epsilon^j) v_J^\ell + v_J^j (v^\ell - v_\epsilon^\ell)] \psi_f(\lambda \Gamma_I(t, x)), \quad J = (I, f) \end{aligned}$$

which is part of $R_M^{j\ell}$ in the Mollification term (14.2). Note that v_J^ℓ is not well-defined until $\nabla \Gamma_I$ is chosen; however, the term $\gamma_J = \gamma_f(\nabla \Gamma_I, \varepsilon_I)$ in v_J^ℓ that involves $\nabla \Gamma_I$ is a priori bounded by a constant $\|\gamma_J\|_{C^0} \leq \sup \gamma_f \leq 1$. From (15.3) and (13.3), we obtain an a priori bound

$$\begin{aligned} \sup_J \|v_J^\ell\|_{C^0} &\lesssim (\log \widehat{\Xi})^{1/2} e_R^{1/2} \\ \|R_{M,v_1}^{j\ell}\|_{C^0} &\lesssim \|v - v_\epsilon\|_{C^0} (\log \widehat{\Xi})^{1/2} e_R^{1/2} \\ &\lesssim \epsilon^2 \Xi^2 e_v^{1/2} (\log \widehat{\Xi})^{1/2} e_R^{1/2}, \end{aligned}$$

assuming our mollifier satisfies the same vanishing moment condition as in the R_ϵ case.

Take $\epsilon = \epsilon_v$ to have the form $\epsilon_v = c_v N^{-1/2} \Xi^{-1}$, with c_v is a small constant such that

$$\|R_{M,v_1}^{j\ell}\|_{C^0} \leq (\log \widehat{\Xi})^{1/2} \frac{e_v^{1/2} e_R^{1/2}}{500N} \quad (16.3)$$

This choice of ϵ and (3.9) lead to the bounds

$$\|\nabla^k v_\epsilon\|_{C^0} \lesssim_k N^{(k-2)+/2} \Xi^k e_v^{1/2}. \quad (16.4)$$

These are the same bounds as those satisfied by the v_ϵ in [Ise17, Section 15] in the case of frequency energy levels of order $L = 2$ of the Main Lemma in that paper. This coincidence is due to how we have chosen the same values of ϵ_v and ϵ_R as in that paper.

With the above choices, we obtain the following estimates for the advective derivative of R_ϵ .

Proposition 16.1. *Let $\overline{D}_t = \partial_t + v_\epsilon \cdot \nabla$ denote the coarse scale advective derivative operator. Then*

$$\|\nabla^k \overline{D}_t R_\epsilon\|_{C^0} \lesssim_k (\log \widehat{\Xi})^3 N^{(k-1)+/2} \Xi^{k+1} e_v^{1/2} e_R \quad (16.5)$$

We deduce this Proposition from [Ise17, Proposition 18.6]. The proof of that Proposition is where the double mollification structure of R_ϵ is used to control higher order derivatives.

Proof. Define $\widetilde{R}^{j\ell} = (\log \widehat{\Xi})^{-3} R^{j\ell}$. Then $\widetilde{R}^{j\ell}$ satisfies the bounds

$$\begin{aligned} \|\nabla^k \widetilde{R}\|_{C^0} &\lesssim \Xi^k e_R, \quad k = 0, 1, 2 \\ \|\nabla^k (\partial_t + v \cdot \nabla) \widetilde{R}\|_{C^0} &\leq \Xi^{k+1} e_v^{1/2} e_R, \quad k = 0, 1 \end{aligned}$$

These are the same estimates as those assumed on $R^{j\ell}$ in [Ise17, Definition 10.1] in the case of frequency energy levels to order $L = 2$. Moreover, we have chosen the mollification parameters ϵ_v and ϵ_R to be the same as in [Ise17, Sections 15, 18.3] for the case $L = 2$. Thus the estimates of the $L = 2$ case of [Ise17, Proposition 18.6] (which are the same as (16.5) without the logarithmic factor) apply to \widetilde{R} . We note that [Ise17, Proposition 18.6] involves only the spatial mollification of R (not the mollification in time along the flow) and that the proof does not involve estimates for ∇p . \square

Having specified the mollification parameters and proven bounds on v_ϵ and R_ϵ , we now turn to estimating the terms in the construction.

17 Estimates for the Construction

In Sections 17.1-17.6 below, we prove all the required estimates for Lemma 3.3. The concluding Section 17.6 reviews where each conclusion of Lemma 3.3 has been proven.

17.1 Estimates for Low-Frequency Terms in the Construction

In this Section we prove estimates for the low frequency terms in the construction, namely $(\nabla\Gamma_I)$, $(\nabla\Gamma_I^{-1})$, γ_J , ε_I , and the amplitudes v_J and $\delta v_{J,\alpha\beta}$.

Proposition 17.1. *The following estimates hold for the back-to-labels map*

$$\|\nabla^k(\nabla\Gamma_I)\|_{C^0} + \|\nabla^k(\nabla\Gamma_I^{-1})\|_{C^0} \lesssim_k N^{(k-1)_+/2} \Xi^k, \quad \text{for all } k \geq 0 \quad (17.1)$$

$$\|\nabla^k \overline{D}_t(\nabla\Gamma_I)\|_{C^0} + \|\nabla^k \overline{D}_t(\nabla\Gamma_I^{-1})\|_{C^0} \lesssim_k N^{(k-1)_+/2} \Xi^{k+1} e_v^{1/2}, \quad \text{for all } k \geq 0 \quad (17.2)$$

Proof. The estimates (17.1) and (17.2) for $\nabla\Gamma_I$ follow from Propositions 17.3 and 17.5 of [Ise17]. There the estimates are performed for a solution ξ_I to

$$(\partial_t + v_\varepsilon \cdot \nabla)\xi_I = 0 \quad (17.3)$$

$$\xi_I(t(I), x) = \hat{\xi}_I(x) \quad (17.4)$$

where the initial data $\hat{\xi}_I$ is linear with $|\nabla\hat{\xi}_I| \leq C_0$. Each component Γ_I^k of Γ_I therefore falls into the framework of those estimates. Alternatively, one can adapt the proof of those estimates for the system (12.5) while modifying the dimensionless energy for $\nabla\xi_I$ [Ise17, Definition 17.1] to involve Frobenius norms of the matrix $\nabla\Gamma_I$ and its derivatives. We note that the proof of these estimates does not require control over ∇p , which had been assumed in [Ise17] for the purpose of controlling second order advective derivatives.

The estimates (17.1) and (17.2) for $(\nabla\Gamma_I^{-1})$ can be deduced from those for $\nabla\Gamma_I$ by taking spatial derivatives of the equations

$$\begin{aligned} (\nabla\Gamma_I)(\nabla\Gamma_I^{-1}) &= \text{Id} \\ \overline{D}_t(\nabla\Gamma_I^{-1}) &= -(\nabla\Gamma_I^{-1})[\overline{D}_t(\nabla\Gamma_I)](\nabla\Gamma_I^{-1}) \end{aligned}$$

and using the bound $\|\nabla\Gamma_I^{-1}\|_{C^0} \leq C_0$ of Proposition 12.1. (The second equation comes from applying \overline{D}_t to the first.) Alternatively, since the evolution equation (12.6) for $\nabla\Gamma_I^{-1}$ has the same form as the equation (12.5) for $\nabla\Gamma_I$ (except for the minus sign and order of matrix multiplication), one obtains (17.1) and (17.2) for $(\nabla\Gamma_I^{-1})$ by applying the proof of [Ise17, Propositions 17.3, 17.5] to equation (12.6). \square

The remaining low frequency building blocks of the construction can be estimated as follows

In the proof of Proposition 17.2 below, the implicit constants in the \lesssim notation will in general depend on k , but we will omit this dependence.

From formula (15.3), we have that $e_I^{-1}(t)$ is a constant in time on the support of $R_{I, \varepsilon}$, which is contained in $[t(I) - \theta/2, t(I) + \theta/2]$, and on that domain satisfies a lower bound $\sup_{t \in [t(I) - \theta/2, t(I) + \theta/2]} |e_I^{-1}(t)| \lesssim (\log \widehat{\Xi})^{-1} e_R^{-1}$. The bound (17.5) now follows from (16.2), and similarly (17.6) follows from (16.5) and $\overline{D}_t \varepsilon_I^{j\ell} = -e_I^{-1}(t) \overline{D}_t R_{I, \varepsilon}^{j\ell}$. \square

Proof of (17.7)-(17.8). Recall from Section 15 (in particular Formula (15.15)) that $\gamma_J = \gamma_{(I, f)}$ takes the form $\gamma_J(t, x) = \gamma_f(\nabla \Gamma_I, \varepsilon_I)$, where γ_f belongs to a set of six smooth functions whose domains are a compact subset \overline{K} of $\mathbb{R}^{3 \times 3} \times \mathcal{S}$. We have already shown in Section 15 that $\|\gamma_J\|_{C^0} \leq \sup_{\overline{K}} \gamma_f \leq 1$. Now let $\nabla_{\vec{a}}$ be a partial derivative operator of order $|\vec{a}| = k \geq 1$. We will use $\partial_\Gamma \gamma_f$ to denote a derivative of γ_f in the $\mathbb{R}^{3 \times 3}$ argument, and $\partial_\varepsilon \gamma_f$ to denote a derivative of γ_f in the \mathcal{S} argument. Set $p = (\nabla \Gamma_I, \varepsilon)$. Using the chain rule and product rule, we can expand $\nabla_{\vec{a}} \gamma_J = \nabla_{\vec{a}} [\gamma_f(\nabla \Gamma_I, \varepsilon)]$ in the form

The innermost sum is restricted to certain multi-indices indices such that $\sum_{i=1}^m |\vec{b}_i| + \sum_{j=1}^{m'} |\vec{c}_j| = k$. We now estimate this term by

This estimate concludes the proof of (17.7)-(17.8). \square

Our next task will be to estimate high frequency terms, including the correction V_J .

17.2 Bounds on the Correction

We now proceed to estimate the components of the high frequency correction $V^\ell = \sum_J \mathring{V}_J^\ell + \delta V_J^\ell$ defined in Section 13. In the process, we prove the estimate (3.15), and verify the estimates implied by (3.13) and (2.4) for the new velocity field.

The bounds for high frequency term involve the choice of the parameter λ , which we now describe. Consistent with the frequency level in (3.13), we assume that λ will take the form

$$\lambda = B_\lambda N \Xi$$

The parameter B_λ is the last parameter that remains to be chosen. Unlike all of the constants chosen previously, the choice of B_λ will depend on the parameter η in the assumptions of Lemma 3.3.

To be more precise, there will be a large constant \bar{B}_λ that remains to be chosen depending on (C_0, C_1, δ, η) , and B_λ will be chosen from the interval $B_\lambda \in [\bar{B}_\lambda, 2\bar{B}_\lambda]$ in order to ensure that $\lambda \in \mathbb{Z}$ is an integer. Since B_λ and \bar{B}_λ are equal to within a factor of 2, we can ignore the distinction between them and think of B_λ as the last constant parameter that remains to be chosen.

The bounds we obtain for the correction are as follows

Proposition 17.3 (Correction Estimates). *The following bounds hold for $0 \leq k \leq 3$*

Furthermore, the bound (3.15) holds, and the estimates implied by (3.13) and (2.4) hold for $v_1 = v + V$.

$$\nabla_{\vec{a}} \mathring{V}_J = \sum_{0 \leq m \leq |\vec{a}|} \sum_{\vec{b}, \vec{c}} \nabla_{\vec{b}} v_J \partial^m \psi_f(\lambda \Gamma_I) \lambda^m \prod_{i=1}^m \nabla_{\vec{c}_i} (\nabla \Gamma_I)$$

where the sum ranges over a set of multi-indices such that $|\vec{b}| + m + \sum_{i=1}^m |\vec{c}_i| = |\vec{a}|$, and the empty product equals 1 in the case $m = 0$. Using (17.1) and (17.9) we obtain

$$\begin{aligned} \|\nabla_{\vec{a}} \mathring{V}_J\|_{C^0} &\lesssim (\log \widehat{\Xi})^{1/2} e_R^{1/2} \sum_{0 \leq m \leq |\vec{a}|} \sum_{\vec{b}, \vec{c}} N^{(|\vec{b}|-1)+/2} \Xi^{|\vec{b}|} \lambda^m \prod_{i=1}^m [N^{(|\vec{c}_i|-1)+/2} \Xi^{|\vec{c}_i|}] \\ &\lesssim (\log \widehat{\Xi})^{1/2} e_R^{1/2} \sum_{0 \leq m \leq |\vec{a}|} \sum_{\vec{b}, \vec{c}} N^{(|\vec{a}|-m-1)+/2} \Xi^{|\vec{a}|-m} \lambda^m \\ &\lesssim (\log \widehat{\Xi})^{1/2} e_R^{1/2} \sum_{0 \leq m \leq |\vec{a}|} \sum_{\vec{b}, \vec{c}} N^{(|\vec{a}|-m-1)+/2} \Xi^{|\vec{a}|-m} (B_\lambda N \Xi)^m \\ &\lesssim (\log \widehat{\Xi})^{1/2} e_R^{1/2} (B_\lambda N \Xi)^{|\vec{a}|} \end{aligned}$$

Note that the worst terms occur when all of the derivatives in $\nabla_{\vec{a}}[v_J^\ell \psi_f(\lambda \Gamma_I)]$ fall on the high frequency function $\psi_f(\lambda \Gamma_I)$, in which case each derivative costs a factor of $B_\lambda N \Xi$. This case corresponds to $m = |\vec{a}|$ and $|\vec{c}_i| = 0$ for all $i = 1, \dots, m$ in the above estimate.

Recalling formula (13.8), we treat $\delta V_J^\ell = \delta v_{J, \alpha\beta}^\ell \Omega_f^{\alpha\beta}(\lambda \Gamma_I)$ similarly

$$\begin{aligned} \nabla_{\vec{a}} \delta V_J &= \sum_{0 \leq m \leq |\vec{a}|} \sum_{\vec{b}, \vec{c}} \nabla_{\vec{b}} \delta v_{J, \alpha\beta} \partial^m \Omega_f^{\alpha\beta}(\lambda \Gamma_I) \lambda^m \prod_{i=1}^m \nabla_{\vec{c}_i} (\nabla \Gamma_I) \\ \|\nabla_{\vec{a}} \delta V_J\|_{C^0} &\lesssim \lambda^{-1} \Xi e_R^{1/2} \sum_{0 \leq m \leq |\vec{a}|} \sum_{\vec{b}, \vec{c}} [N^{|\vec{b}|/2} \Xi^{|\vec{b}|}] \lambda^m \prod_{i=1}^m [N^{(|\vec{c}_i|-1)+/2} \Xi^{|\vec{c}_i|}] \\ &\lesssim \lambda^{-1} \Xi e_R^{1/2} \sum_{0 \leq m \leq |\vec{a}|} (B_\lambda N \Xi)^m N^{(|\vec{a}|-m)/2} \Xi^{(|\vec{a}|-m)} \\ &\lesssim \lambda^{-1} \Xi e_R^{1/2} (B_\lambda N \Xi)^{|\vec{a}|} \\ &\lesssim (B_\lambda N \Xi)^{|\vec{a}|-1} \Xi e_R^{1/2} \end{aligned}$$

As before, the worst terms in $\nabla_{\vec{a}}[\delta v_{J, \alpha\beta}^\ell \Omega_f^{\alpha\beta}(\lambda \Gamma_I)]$ occur when every derivative hits the high-frequency function $\Omega_f^{\alpha\beta}(\lambda \Gamma_I)$, each time costing a factor of λ .

The bound (17.24) follows by adding (17.22)-(17.23), summing over $V = \sum_J \mathring{V}_J + \delta V_J$ and noting that at most $|\mathbb{F}| = 6$ of the \mathring{V}_J and δV_J are nonzero at any given time, and that the \mathring{V}_J contribute the dominant term.

The support property (17.25) is clear from the formula (13.7) using (15.3), which implies (13.4).

To check that the new bounds (2.4) are satisfied for (3.13), observe that for all $1 \leq |\vec{a}| \leq 3$

$$\begin{aligned} \nabla_{\vec{a}} v_1 &= \nabla_{\vec{a}} v + \nabla_{\vec{a}} V \\ \|\nabla_{\vec{a}} v_1\|_{C^0} &\lesssim \Xi^{|\vec{a}|} e_v^{1/2} + (\log \widehat{\Xi})^{1/2} (B_\lambda N \Xi)^{|\vec{a}|} e_R^{1/2} \\ &\lesssim (B_\lambda N \Xi)^{|\vec{a}|} (\log \widehat{\Xi} e_R)^{1/2}, \end{aligned} \tag{17.26}$$

where we used that $N \geq (e_v/e_R)^{1/2}$. Note that (17.26) coincides with the bounds required in (17.22)-(17.23).

To check that (3.15) holds, note that (3.15) is equivalent to the $k = 0$ case of (17.24). The bound here is independent of B_λ (and independent of η). \square

We now begin estimating the error terms, beginning with the terms that do not involve solving the divergence equation.

17.3 Stress Terms not Involving the Divergence Equation

In this Section, we begin estimating the terms in the new stress R_1 determined by (14.1). We start with the terms (14.2) and (14.4), which do not require solving the divergence equation.

Proposition 17.4. *There exists a constant \overline{B}_λ such that for all $B_\lambda \geq \overline{B}_\lambda$ the following bounds hold*

$$\|R_M\|_{C^0} + \|R_S\|_{C^0} \leq \log \widehat{\Xi} \frac{e_v^{1/2} e_R^{1/2}}{10N} \tag{17.27}$$

$$\|\nabla_{\vec{a}} R_M\|_{C^0} + \|\nabla_{\vec{a}} R_S\|_{C^0} \lesssim (B_\lambda N \Xi)^{|\vec{a}|} \log \widehat{\Xi} \frac{e_v^{1/2} e_R^{1/2}}{N}, \quad 1 \leq |\vec{a}| \leq 3 \tag{17.28}$$

$$\text{supp}_t R_M \cup \text{supp}_t R_S \subseteq \bigcup_I [t(I) - \theta, t(I) + \theta] \tag{17.29}$$

Proof of (17.27)-(17.29) for R_S . From the formula (14.4) and Proposition 17.3 we have

$$\begin{aligned} R_S^{j\ell} &= \sum_{J,K \in \mathbb{Z} \times \mathbb{F}} \delta V_J^j \mathring{V}_K^\ell + \mathring{V}_J^j \delta V_K^\ell + \delta V_J^j \delta V_K^\ell \\ \|R_S\|_{C^0} &\lesssim [(B_\lambda N \Xi)^{-1} (\log \widehat{\Xi})^{1/2} \Xi e_R^{1/2}] [(\log \widehat{\Xi})^{1/2} e_R^{1/2}] + [(B_\lambda N \Xi)^{-1} (\log \widehat{\Xi})^{1/2} \Xi e_R^{1/2}]^2 \\ &\lesssim (B_\lambda N \Xi)^{-1} \Xi \log \widehat{\Xi} e_R \end{aligned}$$

Here we used that the number of nonzero terms is bounded by $|\mathbb{F}|^2 = 36$ at any given time. For B_λ a sufficiently large constant, this term is bounded by $\log \widehat{\Xi} \frac{e_R}{1000N}$. The term $R_M^{j\ell}$ will obey a similar bound, from which (17.27) will follow. As for the derivatives of R_S , again the term involving \mathring{V}_J dominates the term quadratic in δV_J , and we have

$$\begin{aligned} \|\nabla_{\vec{a}} R_S^{j\ell}\|_{C^0} &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} \sup_J \|\nabla_{\vec{b}} \delta V_J\|_{C^0} \sup_J (\|\nabla_{\vec{c}} \mathring{V}_J\|_{C^0} + \|\nabla_{\vec{c}} \delta V_J\|_{C^0}) \\ &\lesssim \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} [(B_\lambda N \Xi)^{|\vec{b}|-1} \Xi (\log \widehat{\Xi})^{1/2} e_R^{1/2}] [(B_\lambda N \Xi)^{|\vec{c}|} (\log \widehat{\Xi})^{1/2} e_R^{1/2}] \\ &\lesssim \log \widehat{\Xi} (B_\lambda N \Xi)^{|\vec{a}|-1} \Xi e_R. \end{aligned}$$

This bound suffices for (17.28). The support property (17.29) follows from (13.8)-(13.9) and (13.4). \square

Proof of (17.27)-(17.29) for R_M . We recall the following formula from (14.2)

$$R_M^{j\ell} = (v^j - v_\epsilon^j)V^\ell + V^j(v^\ell - v_\epsilon^\ell) + (R^{j\ell} - R_\epsilon^{j\ell}) \quad (17.30)$$

In Lines (16.1) and (16.3), the parameters ϵ_R and ϵ_v for R_ϵ and v_ϵ were chosen such that

$$\begin{aligned} \|R - R_\epsilon\|_{C^0} &\leq \log \widehat{\Xi} \frac{e_R}{500N} \\ \sum_J \|(v^j - v_\epsilon^j)\mathring{V}_J^\ell + \mathring{V}_J^j(v^\ell - v_\epsilon^\ell)\|_{C^0} &\leq (\log \widehat{\Xi})^{1/2} \frac{e_v^{1/2} e_R^{1/2}}{500N} \end{aligned} \quad (17.31)$$

$$\|v^\ell - v_\epsilon^\ell\|_{C^0} \lesssim \frac{e_v^{1/2}}{N} \quad (17.32)$$

To complete the proof of (17.27), we use (17.23) to bound the remaining lower order term by

$$\begin{aligned} R_{M,v2}^{j\ell} &= \sum_{J \in \mathbb{Z} \times \mathbb{F}} (v^j - v_\epsilon^j) \delta V_J^\ell + \delta V_J^j (v^\ell - v_\epsilon^\ell) \\ \|R_{M,v2}^{j\ell}\|_{C^0} &\lesssim \frac{e_v^{1/2}}{N} [(B_\lambda N \Xi)^{-1} \Xi (\log \widehat{\Xi})^{1/2} e_R^{1/2}] \end{aligned}$$

For B_λ sufficiently large, this term also satisfies the estimate (17.31). Thus the C^0 estimate (17.27) holds using also our previous bound $\|R_S\|_{C^0} \leq \log \widehat{\Xi} \frac{e_R}{1000N}$. We now move on to proving (17.28).

Let $\nabla_{\vec{a}}$ be a partial derivative operator of order $1 \leq |\vec{a}| \leq 3$. We start by estimating

$$\begin{aligned} \|\nabla_{\vec{a}}(R^{j\ell} - R_\epsilon^{j\ell})\|_{C^0} &\leq \|\nabla_{\vec{a}} R^{j\ell}\|_{C^0} + \|\nabla_{\vec{a}} R_\epsilon^{j\ell}\|_{C^0} \\ &\stackrel{(3.2)}{\lesssim} \log \widehat{\Xi} (e_v/e_R)^{(|\vec{a}|-2)+/2} \Xi^{|\vec{a}|} e_R + \log \widehat{\Xi} N^{(|\vec{a}|-2)+/2} \Xi^{|\vec{a}|} e_R \\ N \geq (e_v/e_R)^{1/2} &\Rightarrow \lesssim \log \widehat{\Xi} N^{(|\vec{a}|-2)+} \Xi^{|\vec{a}|} e_R \\ |\vec{a}| \geq 1 &\Rightarrow \lesssim \log \widehat{\Xi} N^{|\vec{a}|} \Xi^{|\vec{a}|} \frac{e_R}{N} \end{aligned}$$

Let $R_{M,v}^{j\ell} = R_{M,v1}^{j\ell} + R_{M,v2}^{j\ell}$ denote the term in (17.30) involving $(v - v_\epsilon)$. By (17.32) and (17.24), we obtain

$$\begin{aligned} \|\nabla_{\vec{a}} R_{M,v}^{j\ell}\|_{C^0} &\leq \|v - v_\epsilon\|_{C^0} \|\nabla_{\vec{a}} V\|_{C^0} + \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} (\|\nabla_{\vec{b}} v\|_{C^0} + \|\nabla_{\vec{b}} v_\epsilon\|_{C^0}) \|\nabla_{\vec{c}} V\|_{C^0} \mathbf{1}_{1 \leq |\vec{b}| \leq 3} \\ &\lesssim \frac{e_v^{1/2}}{N} (\log \widehat{\Xi})^{1/2} (B_\lambda N \Xi)^{|\vec{a}|} e_R^{1/2} \end{aligned} \quad (17.33)$$

$$+ \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} (\Xi^{|\vec{b}|} e_v^{1/2} + N^{(|\vec{b}|-2)+/2} \Xi^{|\vec{b}|} e_v^{1/2}) [(B_\lambda N \Xi)^{|\vec{c}|} (\log \widehat{\Xi})^{1/2} e_R^{1/2}] \mathbf{1}_{|\vec{b}| \geq 1} \quad (17.34)$$

$$(17.34) \leq B_\lambda^{|\vec{a}|} \Xi^{|\vec{a}|} (\log \widehat{\Xi})^{1/2} e_v^{1/2} e_R^{1/2} \sum_{|\vec{b}|+|\vec{c}|=|\vec{a}|} N^{(|\vec{b}|-2)+/2+|\vec{c}|} \mathbf{1}_{|\vec{b}| \geq 1} \quad (17.35)$$

$$(17.34) \lesssim (B_\lambda N \Xi)^{|\vec{a}|} (\log \widehat{\Xi})^{1/2} \frac{e_v^{1/2} e_R^{1/2}}{N} \quad (17.36)$$

In the last line, we note that the largest term in (17.35) occurs when $|\vec{b}| = 1$ and $|\vec{c}| = |\vec{a}| - 1 \geq 0$. Combining (17.33) and (17.36) we obtain (17.28) for $R_{M,v}$, which finishes the proof of (17.28) for R_M . \square

17.4 Stress Terms Involving the Divergence Equation

In this Section, we bound the terms (14.3) and (14.5) that compose the remaining part of the new stress R_1 defined in (14.1). The bound we obtain is the following:

Proposition 17.5. *There exists a constant \overline{B}_λ (depending on C_0, C_1, δ, η) such that for all $B_\lambda \geq \overline{B}_\lambda$, there exist symmetric tensors $R_T^{j\ell}$ and $R_H^{j\ell}$ that solve*

$$\nabla_j R_T^{j\ell} = \partial_t V^\ell + v_\epsilon^j \nabla_j V^\ell + V^j \nabla_j v_\epsilon^\ell \quad (17.37)$$

$$\nabla_j R_H^{j\ell} = \nabla_j \left[\sum_{J \in \mathbb{Z} \times \mathbb{F}} \mathring{V}_J^j \mathring{V}_J^\ell + P \delta^{j\ell} + R_\epsilon^{j\ell} \right] \quad (17.38)$$

and satisfy the following bounds

$$\|R_T\|_{C^0} + \|R_H\|_{C^0} \leq (\log \widehat{\Xi})^{5/2} \frac{e_v^{1/2} e_R^{1/2}}{20N} \quad (17.39)$$

$$\|\nabla^k R_T\|_{C^0} + \|\nabla^k R_H\|_{C^0} \lesssim (B_\lambda N \Xi)^k (\log \widehat{\Xi})^{5/2} \frac{e_v^{1/2} e_R^{1/2}}{N}, \quad 1 \leq k \leq 3 \quad (17.40)$$

$$\text{supp}_t R_T \cup \text{supp}_t R_H \subseteq \bigcup_I [t(I) - \theta, t(I) + \theta]$$

The key to the estimates will be a set of crucial cancellations that arise thanks to the Ansatz of Section 13 combined with Proposition 17.6 below (which is inspired by calculations in [DS16]), which gains cancellation while inverting the divergence equation for high frequency right hand sides.

Proof. From Section 13, we can expand the correction V^ℓ in the form

$$V^\ell = \sum_J \left(v_J^\ell \psi_f(\lambda \Gamma_I) + \delta v_{J, \alpha\beta}^\ell \Omega_f^{\alpha\beta}(\lambda \Gamma_I) \right)$$

Substituting into the Transport term (17.37) and using

$$\begin{aligned} (\partial_t + v_\epsilon^j \nabla_j)[\psi_f(\lambda \Gamma_I)] &= 0 \\ (\partial_t + v_\epsilon^j \nabla_j)[\Omega_f^{\alpha\beta}(\lambda \Gamma_I)] &= 0, \end{aligned}$$

we can write the Transport term in the form

$$(17.37) = \sum_J \left(u_{T,J}^\ell \psi_f(\lambda \Gamma_I) + u_{T,J\alpha\beta}^\ell \Omega_f^{\alpha\beta}(\lambda \Gamma_I) \right) \quad (17.41)$$

$$u_{T,J}^\ell = (\overline{D}_t v_J^\ell + v_J^j \nabla_j v_\epsilon^\ell) \quad (17.42)$$

$$u_{T,J\alpha\beta}^\ell = (\overline{D}_t \delta v_{J,\alpha\beta}^\ell + \delta v_{J,\alpha\beta}^j \nabla_j v_\epsilon^\ell) \quad (17.43)$$

For the term (17.38), we recall (14.7) and use the fact in (13.2) that $v_J^j \nabla_j[\psi_f(\lambda \Gamma_I)] = 0$ to obtain

$$\begin{aligned} (17.38) &= \sum_{J \in \mathbb{Z} \times \mathbb{F}} \nabla_j [v_J^j v_J^\ell (\psi_f^2(\lambda \Gamma_I) - 1)] \\ &= \sum_J \nabla_j [v_J^j v_J^\ell] (\psi_f^2(\lambda \Gamma_I) - 1) \end{aligned} \quad (17.44)$$

Observe that the terms (17.41) and (17.44) all have the form $u^\ell \omega(\lambda \Gamma_I)$ for some smooth u^ℓ and some smooth $\omega : \mathbb{T}^3 \rightarrow \mathbb{R}$ that has integral 0 ((11.2), (11.3) and (13.6)). Applying Proposition 17.6 below, we have that for any $D \in \mathbb{Z}_+$ there exist tensors $R_{T,J}^{j\ell}$, $R_{T,J\alpha\beta}^{j\ell}$ and $R_{H,J}^{j\ell}$ that solve

$$\begin{aligned} \nabla_j R_{T,J}^{j\ell} &= (1 - \Pi_0)[u_{T,J}^\ell \psi_f(\lambda \Gamma_I)] \\ \nabla_j R_{T,J\alpha\beta}^{j\ell} &= (1 - \Pi_0)[u_{T,J\alpha\beta}^\ell \Omega_f^{\alpha\beta}(\lambda \Gamma_I)] \\ \nabla_j R_{H,J}^{j\ell} &= (1 - \Pi_0)[u_{H,J}^\ell (\psi_f^2(\lambda \Gamma_I) - 1)] \\ u_{H,J}^\ell &:= \nabla_j [v_J^j v_J^\ell] \end{aligned} \tag{17.45}$$

and that obey the estimates

$$\sup_{0 \leq k \leq 3} \lambda^{-k} \|\nabla^k R_{T,J}^{j\ell}\|_{C^0} \lesssim_D (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) \sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u_{T,J}\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} \tag{17.46}$$

$$\begin{aligned} \sup_{0 \leq k \leq 3} \lambda^{-k} \|\nabla^k R_{T,J\alpha\beta}^{j\ell}\|_{C^0} &\lesssim_D (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) \sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u_{T,J\alpha\beta}\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} \\ \sup_{0 \leq k \leq 3} \lambda^{-k} \|\nabla^k R_{H,J}^{j\ell}\|_{C^0} &\lesssim_D (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) \sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u_{H,J}\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} \end{aligned} \tag{17.47}$$

$$\text{supp}_t R_{T,J} \cup_{\alpha,\beta} \text{supp}_t R_{T,J\alpha\beta} \cup \text{supp}_t R_{H,J} \subseteq [t(I) - \theta, t(I) + \theta], \quad J \in \{I\} \times \mathbb{F}$$

Our goal for these estimates is to gain a factor of λ^{-1} in the bound for each stress term. We choose $D \in \mathbb{Z}_+$ such that $N^{-D/2} \leq N^{-1} \Xi^{-1}$. By the assumption $N \geq \Xi^\eta$ in Lemma 3.3, it suffices to take $D > 2(1 + \eta^{-1})$. With this choice, the $B_\lambda^{-1} N^{-D/2}$ term above can be absorbed into the λ^{-1} term.

We now set $R_T^{j\ell} = \sum_J R_{T,J}^{j\ell} + \sum_{J,\alpha\beta} R_{T,J\alpha\beta}^{j\ell}$ and $R_H^{j\ell} = \sum_J R_{H,J}^{j\ell}$. Then R_T and R_H solve (17.37) and (17.38) respectively, since (using that V^ℓ in (13.7) is the divergence of an antisymmetric tensor)

$$\begin{aligned} \nabla_j R_T^{j\ell} &\stackrel{(17.41)}{=} (1 - \Pi_0)[\partial_t V^\ell + v_\epsilon^j \nabla_j V^\ell + V^j \nabla_j v_\epsilon^\ell] \\ &= (1 - \Pi_0)[\partial_t V^\ell + \nabla_j (v_\epsilon^j V^\ell + V^j v_\epsilon^\ell)] \\ &\stackrel{(13.7)}{=} \partial_t V^\ell + \nabla_j (v_\epsilon^j V^\ell + V^j v_\epsilon^\ell) = (17.37) \\ \nabla_j R_H^{j\ell} &\stackrel{(17.44)}{=} (1 - \Pi_0) \sum_{J \in \mathbb{Z} \times \mathbb{F}} \nabla_j [v_J^j v_J^\ell (\psi_f^2(\lambda \Gamma_I) - 1)] \\ &= \sum_{J \in \mathbb{Z} \times \mathbb{F}} \nabla_j [v_J^j v_J^\ell (\psi_f^2(\lambda \Gamma_I) - 1)] \stackrel{(14.7)}{=} (17.38) \end{aligned}$$

To prepare to bound R_T and R_H , we first bound $u_{T,J}$, $u_{T,J\alpha\beta}$ and $u_{H,J}$ using (17.9) -(17.12)

$$\begin{aligned}
\|\nabla_{\bar{a}} u_{T,J}\|_{C^0} &\lesssim_{|\bar{a}|} \|\nabla_{\bar{a}} \bar{D}_t v_J^\ell\|_{C^0} + \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} v_J^j\|_{C^0} \|\nabla_{\bar{c}} \nabla_j v_\epsilon^\ell\|_{C^0} \\
&\lesssim_{|\bar{a}|} (\log \widehat{\Xi})^{5/2} N^{(|\bar{a}|-1)+/2} \Xi^{|\bar{a}|+1} e_v^{1/2} e_R^{1/2} \\
&\quad + \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [(\log \widehat{\Xi})^{1/2} N^{(|\bar{b}|-1)+/2} \Xi^{|\bar{b}|}] [(\log \widehat{\Xi})^{1/2} N^{(|\bar{c}|-1)+/2} \Xi^{|\bar{c}|}] \\
\|\nabla_{\bar{a}} u_{T,J\alpha\beta}\|_{C^0} &\lesssim_{|\bar{a}|} \|\nabla_{\bar{a}} \bar{D}_t \delta v_{J,\alpha\beta}^\ell\|_{C^0} + \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}} \delta v_{J,\alpha\beta}^j\|_{C^0} \|\nabla_{\bar{c}} \nabla_j v_\epsilon^\ell\|_{C^0} \\
&\lesssim_{|\bar{a}|} \lambda^{-1} (\log \widehat{\Xi})^{5/2} N^{|\bar{a}|/2} \Xi^{|\bar{a}|+2} e_v^{1/2} e_R^{1/2} \\
&\quad + \lambda^{-2} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [(\log \widehat{\Xi})^{1/2} N^{|\bar{b}|/2} \Xi^{|\bar{b}|+1}] [(\log \widehat{\Xi})^{1/2} N^{|\bar{c}|/2} \Xi^{|\bar{c}|+1}] \\
\Rightarrow \|\nabla_{\bar{a}} u_{T,J}\|_{C^0} + \|\nabla_{\bar{a}} u_{T,J\alpha\beta}\|_{C^0} &\lesssim_{|\bar{a}|} N^{|\bar{a}|/2} \Xi^{|\bar{a}|} [(\log \widehat{\Xi})^{5/2} \Xi e_v^{1/2} e_R^{1/2}] \tag{17.48}
\end{aligned}$$

$$\begin{aligned}
\|\nabla_{\bar{a}} u_{H,J}\|_{C^0} &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|+1} \|\nabla_{\bar{b}} v_J\|_{C^0} \|\nabla_{\bar{c}} v_J\|_{C^0} \\
&\lesssim_{|\bar{a}|} \log \widehat{\Xi} \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|+1} [N^{(|\bar{b}|-1)+/2} \Xi^{|\bar{b}|} e_R^{1/2}] [N^{(|\bar{c}|-1)+/2} \Xi^{|\bar{c}|} e_R^{1/2}] \\
&\lesssim_{|\bar{a}|} \log \widehat{\Xi} N^{|\bar{a}|/2} \Xi^{|\bar{a}|+1} e_R \tag{17.49}
\end{aligned}$$

From (17.48) and (17.49) we obtain

$$\sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u_{T,J}\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} + \sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u_{T,J\alpha\beta}\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} \lesssim_\eta (\log \widehat{\Xi})^{5/2} \Xi e_v^{1/2} e_R^{1/2} \tag{17.50}$$

$$\sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u_{H,J}\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} \lesssim_\eta \log \widehat{\Xi} \Xi e_R \tag{17.51}$$

Combining (17.46)-(17.47) with (17.50)-(17.51) and using our choice of D above, $\lambda = B_\lambda N \Xi$, and the universal bound on the number of v_J and $\delta v_{J,\alpha\beta}$ that are nonzero at any given time, we obtain

$$\sup_{0 \leq k \leq 3} \lambda^{-k} \|\nabla^k R_T^{j\ell}\|_{C^0} \lesssim_\eta (B_\lambda N \Xi)^{-1} (\log \widehat{\Xi})^{5/2} \Xi e_v^{1/2} e_R^{1/2} \tag{17.52}$$

$$\sup_{0 \leq k \leq 3} \lambda^{-k} \|\nabla^k R_T^{j\ell}\|_{C^0} \lesssim_\eta (B_\lambda N \Xi)^{-1} \log \widehat{\Xi} \Xi e_R \tag{17.53}$$

We finally choose the parameter B_λ sufficiently large so that (17.39) holds (and such that $\lambda = B_\lambda N \Xi$ is an integer). The other estimates in (17.40) now follow from (17.52)-(17.53) and $\lambda = B_\lambda N \Xi$. \square

17.5 Proof of Proposition 17.6

In this Section we prove Proposition 17.6 below, which was used to bound the error terms in Section 17.4. The implicit constants in this section will depend on the D introduced below.

Proposition 17.6. For every integer $D \geq 1$ and for any smooth $\omega : \mathbb{T}^3 \rightarrow \mathbb{R}$ with $\int_{\mathbb{T}^3} \omega(X) dX = 0$ there exists $C = C_{D,\omega}$ such that if u^ℓ is smooth and satisfies $\text{supp}_t u^\ell \subseteq [t(I) - \theta, t(I) + \theta]$ and

$$\sup_{0 \leq |\bar{a}| \leq D+5} \frac{\|\nabla_{\bar{a}} u\|_{C^0}}{N^{|\bar{a}|/2} \Xi^{|\bar{a}|}} \leq H \quad (17.54)$$

then there exists a symmetric tensor field $Q^{j\ell}$ in the class $C_t C_x^3(\mathbb{R} \times \mathbb{T}^3)$ such that

$$\begin{aligned} \nabla_j Q^{j\ell} &= (1 - \Pi_0)[u^\ell \omega(\lambda \Gamma_I)] \\ \sup_{0 \leq k \leq 3} \lambda^{-k} \|\nabla^k Q\|_{C^0} &\leq C_{D,\omega} (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) H \end{aligned} \quad (17.55)$$

$$\text{supp}_t Q^{j\ell} \subseteq [t(I) - \theta, t(I) + \theta] \quad (17.56)$$

Moreover, one can arrange that Q depends bilinearly on u and ω .

To prove the Proposition, as in calculations of [DS16], we will expand ω in a Fourier series to reduce to the case where $\omega(X) = e^{im \cdot X}$ and then sum over $m \neq 0$. The case of $\omega(X) = e^{im \cdot X}$ will be handled as in [Ise17] using a nonstationary phase argument with nonlinear phase functions. We remark that the nonstationary phase technique in [DS16] based on the earlier [DLS13b] is different in that it proves estimates directly for $Q^{j\ell} = \mathcal{R}^{j\ell}[u \omega(\lambda \Gamma_I)]$ that gain a factor of $\lambda^{-1+\epsilon}$ rather than λ^{-1} .

To prepare for the proof, we start by stating estimates for the phase functions $m \cdot \Gamma_I(t, x)$.

Proposition 17.7. Let $m \in \mathbb{Z}^3 \setminus \{0\}$ and $\xi_m(t, x) := m \cdot \Gamma_I$. Then for $t \in [t(I) - \theta, t(I) + \theta]$, we have

$$\|\nabla_{\bar{a}} \nabla \xi_m\|_{C^0} \lesssim_{|\bar{a}|} |m| N^{(|\bar{a}|-1)_+ \Xi^{|\bar{a}|}} \quad (17.57)$$

$$\|\nabla \xi_m\|_{C^0}^{-1} \lesssim |m|^{-1} \quad (17.58)$$

Proof. If we view $\xi_m(t, x)$ as a map from $\mathbb{R} \times \mathbb{R}^3 \rightarrow \mathbb{R}^3$, then $\xi_m(t, x)$ is the unique solution to

$$\begin{aligned} (\partial_t + v_\epsilon^j \nabla_j) \xi_m &= 0 \\ \xi_m(t(I), x) &= m \cdot x \end{aligned}$$

The gradient of $\xi_m(t, x)$ then satisfies the equation

$$\begin{aligned} (\partial_t + v_\epsilon^j \nabla_j) \nabla_i \xi_m &= -\nabla_i v_\epsilon^j \nabla_j \xi_m \\ \nabla_i \xi_m(t(I), x) &= m_i \end{aligned} \quad (17.59)$$

Then the vector field $\nabla \xi_m$ obeys the same transport equations as the functions $\nabla \xi_I$ used in [Ise17] in the case of frequency-energy levels of order $L = 2$. From [Ise17, Proposition 17.4], we obtain

$$E_M[\xi_m](\Phi_s(t(I), x)) \leq e^{C_M \Xi e^{1/2} |s|} E_M[\xi_m](t(I), x) \quad (17.60)$$

$$E_M[\xi_m](t, x) := \sum_{0 \leq |\bar{a}| \leq M} \Xi^{-2|\bar{a}|} N^{-(|\bar{a}|-1)_+} |\nabla_{\bar{a}} \nabla \xi_m|^2, \quad (17.61)$$

where Φ_s is the coarse scale flow map defined in Section 12. For $|s| \leq \theta$, we have $\Xi e^{1/2} |s| \lesssim 1$ and the initial data satisfies $E_M[\xi_m](t(I), x) \lesssim |m|$, from which the bound (17.57) follows using (17.60)-(17.61).

To obtain (17.58), let p_s denote the point $p_s = \Phi_s(t(I), x)$. Then for $|s| \leq \theta$

$$\begin{aligned} \frac{d}{ds} |\nabla \xi_m|^{-2}(\Phi_s(t(I), x)) &= -2 |\nabla \xi_m|^{-4}(p_s) \nabla^i \xi_m(p_s) [\overline{D}_t \nabla_i \xi_m](p_s) \\ \left| \frac{d}{ds} |\nabla \xi_m|^{-2}(\Phi_s(t(I), x)) \right| &\stackrel{(17.59)}{\lesssim} \|\nabla v_\epsilon\|_{C^0} |\nabla \xi_m|^{-2}(\Phi_s(t(I), x)) \\ \text{Gronwall} \Rightarrow |\nabla \xi_m|^{-2}(\Phi_s(t(I), x)) &\leq e^{C_0 \|\nabla v_\epsilon\|_{C^0} |s|} |\nabla \xi_m|^{-2}(t(I), x) \end{aligned}$$

From $\|\nabla v_\varepsilon\|_{C^0} |s| \lesssim 1$ and $|\nabla \xi_m|^{-2}(t(I), x) = |m|^{-2}$, we have $\|\nabla \xi_m|^{-2}\|_{C^0} \lesssim |m|^{-2}$ implying (17.58). \square

As a step towards proving Proposition 17.6, we now state

Proposition 17.8. *Under the assumptions of Proposition 17.6, if $m \in \mathbb{Z}^3 \setminus \{0\}$, then there exists a (complex-valued) symmetric tensor field $Q^{j\ell} = Q_m^{j\ell} : \mathbb{R} \times \mathbb{T}^3 \rightarrow \mathcal{S} \otimes \mathbb{C}$ such that*

$$\nabla_j Q_m^{j\ell} = (1 - \Pi_0)[u^\ell e^{2\pi i m \cdot \lambda \Gamma t}] \quad (17.62)$$

$$\sup_{0 \leq |\bar{a}| \leq 3} (|m|\lambda)^{-|\bar{a}|} \|\nabla_{\bar{a}} Q_m\|_{C^0} \leq C_{D,\omega} (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) H \quad (17.63)$$

$$\text{supp}_t Q_m^{j\ell} \subseteq [t(I) - \theta, t(I) + \theta]$$

Moreover, one can take $Q_m^{j\ell}$ to depend linearly on u^ℓ .

Proof. Following [Ise17, Section 26], we write our solution using a parametrix expansion of the form

$$Q^{j\ell} = Q_{(D)}^{j\ell} + \tilde{Q}_{(D)}^{j\ell}, \quad Q_{(D)}^{j\ell} = (2\pi\lambda)^{-1} \sum_{k=1}^D e^{2\pi i \lambda \xi_m} q_{(k)}^{j\ell} \quad (17.64)$$

We explain first the case $D = 1$, where the method reduces to writing

$$Q^{j\ell} = (2\pi\lambda)^{-1} e^{2\pi i \lambda \xi_m} q_{(1)}^{j\ell} + \tilde{Q}_{(1)}^{j\ell} \quad (17.65)$$

After we choose a smooth symmetric tensor $q_{(1)}^{j\ell}$ that solves $i\nabla_j \xi_m q_{(1)}^{j\ell} = u^\ell$ pointwise, the first term in (17.65) will be a good approximate solution to $\nabla_j Q^{j\ell} = e^{i\lambda \xi_m} u^\ell$. The remainder term $\tilde{Q}_{(1)}^{j\ell}$ is then chosen to eliminate the error by solving $\nabla_j \tilde{Q}_{(1)}^{j\ell} = -(2\pi\lambda)^{-1} e^{2\pi i \lambda \xi_m} \nabla_j q_{(1)}^{j\ell} = e^{2\pi i \lambda \xi_m} u^\ell - \nabla_j Q_{(1)}^{j\ell}$. This last equation can only be solved exactly when the original $e^{2\pi i \lambda \xi_m} u^\ell$ has integral 0; otherwise, one obtains a solution to (17.62) involving the projection $(1 - \Pi_0)$.

For $D \geq 1$, we repeat this process to determine a sequence of $q_{(k)}^{j\ell}$ and $u_{(k)}^\ell$ such that $u_{(0)}^\ell = u^\ell$ and

$$\begin{aligned} i\nabla_j \xi_m q_{(k)}^{j\ell} &= u_{(k-1)}^\ell \\ u_{(k)}^\ell &= -(2\pi\lambda)^{-1} \nabla_j q_{(k)}^{j\ell} \end{aligned} \quad (17.66)$$

on all of $\mathbb{R} \times \mathbb{T}^3$ for all $1 \leq k \leq D$. To construct a good solution to the underdetermined equation (17.66), we set $q_{(k)}^{j\ell} = \bar{q}^{j\ell}(\nabla \xi_m)[u_{(k-1)}]$, where $\bar{q}^{j\ell} = \bar{q}^{j\ell}(p)[u]$ is a map with the following properties

$$\bar{q}^{j\ell} \in C^\infty(\mathbb{R}^3 \setminus \{0\} \times \mathbb{R}^3) \text{ as a map taking values in } \mathcal{S} \otimes \mathbb{C} \quad (17.67)$$

$$\bar{q}^{j\ell}(p)[u] \text{ is linear in } u \text{ and homogeneous of degree -1 in } p \quad (17.68)$$

$$ip_j \bar{q}^{j\ell}(p)[u] = u^\ell, \quad \text{for all } (p, u) \in \mathbb{R}^3 \setminus \{0\} \times \mathbb{R}^3 \quad (17.69)$$

One can construct such a map \bar{q} by decomposing $u^\ell = u_\perp^\ell + u_\parallel^\ell$, $u_\parallel^\ell = |p|^{-2}(u \cdot p)p^\ell$ and then setting $\bar{q}^{j\ell}(p)[u] = -i(q_\perp^{j\ell} + q_\parallel^{j\ell})$, where $q_\parallel^{j\ell} = |p|^{-2}(u \cdot p)\delta^{j\ell}$ and $q_\perp^{j\ell} = |p|^{-2}(p^j u_\perp^\ell + u_\perp^j p^\ell)$. With this construction, $\bar{q}^{j\ell}$ is symmetric, one has $p_j q_\perp^{j\ell} = u_\perp^\ell$ and $p_j q_\parallel^{j\ell} = u_\parallel^\ell$, and properties (17.67)-(17.69) all hold.

We now begin estimating the above parametrix. By (17.68), the map $\bar{q}^{j\ell}(p)[u]$ can be written in the form $\bar{q}^{j\ell}(p)[u] = \bar{q}_a^{j\ell}(p)u^a$ where the $\bar{q}_a^{j\ell}(p)$ are homogeneous of degree -1 in p and smooth away from 0. Then $q_{(k)}^{j\ell} = \bar{q}_a^{j\ell}(\nabla\xi_m)u_{(k-1)}^a$. We use the homogeneity of the derivatives of $\bar{q}_a^{j\ell}(\nabla\xi_m)$ to write

$$\begin{aligned}\nabla_{\bar{a}}[\bar{q}_a^{j\ell}(\nabla\xi_m)] &= \sum_{r=0}^{|\bar{a}|} \sum_{\bar{a}_i} \partial^r \bar{q}_a^{j\ell}(\nabla\xi_m) \prod_{i=1}^r \nabla_{\bar{a}_i} \nabla\xi_m \\ &= \sum_{r=0}^{|\bar{a}|} \sum_{\bar{a}_i} |\nabla\xi_m|^{-(1+r)} \partial^r \bar{q}_a^{j\ell} \left(\frac{\nabla\xi_m}{|\nabla\xi_m|} \right) \prod_{i=1}^r \nabla_{\bar{a}_i} \nabla\xi_m,\end{aligned}$$

where the sum ranges over a family of multi-indices with $\sum_i |\bar{a}_i| = |\bar{a}|$. Using (17.57)-(17.58) we have

$$\begin{aligned}\|\nabla_{\bar{a}}[\bar{q}_a^{j\ell}(\nabla\xi_m)]\|_{C^0} &\lesssim_{|\bar{a}|} \sum_{r=0}^{|\bar{a}|} \sum_{\bar{a}_i} |m|^{-(1+r)} \sup_{|p|=1} |\partial^r \bar{q}_a^{j\ell}(p)| \prod_{i=1}^r [N^{(|\bar{a}_i|-1)+/2} \Xi^{|\bar{a}_i|} |m|] \\ \|\nabla_{\bar{a}}[\bar{q}_a^{j\ell}(\nabla\xi_m)]\|_{C^0} &\lesssim_{|\bar{a}|} |m|^{-1} N^{(|\bar{a}|-1)+/2} \Xi^{|\bar{a}|} \lesssim N^{|\bar{a}|/2} \Xi^{|\bar{a}|}\end{aligned}\tag{17.70}$$

By induction, we now prove the following estimates for $q_{(k)}^{j\ell} = \bar{q}_a^{j\ell}(\nabla\xi_m)u_{(k-1)}^a$ and $u_{(k)}^\ell = -\lambda^{-1} \nabla_j q_{(k)}^{j\ell}$

$$\|\nabla_{\bar{a}} q_{(k)}^{j\ell}\|_{C^0} \lesssim N^{-(k-1)/2} N^{|\bar{a}|/2} \Xi^{|\bar{a}|} H, \quad \text{for all } 0 \leq |\bar{a}| \leq D - k + 4, \quad 1 \leq k \leq D\tag{17.71}$$

$$\|\nabla_{\bar{a}} u_{(k)}^\ell\|_{C^0} \lesssim B_\lambda^{-1} N^{-k/2} N^{|\bar{a}|/2} \Xi^{|\bar{a}|} H \quad \text{for all } 0 \leq |\bar{a}| \leq D - k + 3, \quad 0 \leq k \leq D\tag{17.72}$$

As a base case, note that (17.72) holds for $k = 0$ (without the B_λ^{-1} factor) because $\|\nabla_{\bar{a}} u_{(0)}\|_{C^0} = \|\nabla_{\bar{a}} u\|_{C^0} \leq N^{|\bar{a}|/2} \Xi^{|\bar{a}|} H$ for all $0 \leq |\bar{a}| \leq D + 5$ by definition of H in (17.54). Now for $k \geq 1$, suppose (17.72) holds for $k - 1$ (without the B_λ^{-1} if $k - 1 = 0$). Then if $0 \leq |\bar{a}| \leq D - k + 4 = D - (k - 1) + 3$

$$\begin{aligned}\|\nabla_{\bar{a}} q_{(k)}^{j\ell}\|_{C^0} &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} \|\nabla_{\bar{b}}[\bar{q}_a^{j\ell}(\nabla\xi_m)]\|_{C^0} \|\nabla_{\bar{c}} u_{(k-1)}\|_{C^0} \\ &\lesssim \sum_{|\bar{b}|+|\bar{c}|=|\bar{a}|} [N^{|\bar{b}|/2} \Xi^{|\bar{b}|}] [N^{-(k-1)/2} N^{|\bar{c}|/2} \Xi^{|\bar{c}|} H] \\ &\lesssim N^{-(k-1)/2} N^{|\bar{a}|/2} \Xi^{|\bar{a}|} H\end{aligned}$$

Then for $u_{(k)}^\ell = -(2\pi\lambda)^{-1} \nabla_j q_{(k)}^{j\ell}$ and $0 \leq |\bar{a}| \leq D - k + 3$ we have

$$\begin{aligned}\|\nabla_{\bar{a}} u_{(k)}^\ell\|_{C^0} &\lesssim \lambda^{-1} \|\nabla_{\bar{a}} \nabla_j q_{(k)}^{j\ell}\|_{C^0} \\ &\lesssim (B_\lambda N \Xi)^{-1} N^{-(k-1)/2} N^{(|\bar{a}+1)/2} \Xi^{(|\bar{a}+1)} H \\ &\lesssim B_\lambda^{-1} N^{-k/2} N^{|\bar{a}|/2} \Xi^{|\bar{a}|} H\end{aligned}$$

To estimate the parametrix in (17.64) we write, for $0 \leq |\bar{a}| \leq 3$,

$$\nabla_{\bar{a}} Q_{(D)}^{j\ell} = \sum_{k=1}^D \sum_{r=0}^{|\bar{a}|} (2\pi\lambda)^{-1+r} \sum_{\bar{b}_i, \bar{c}} e^{2\pi i \lambda \xi_m} \nabla_{\bar{c}} q_{(k)}^{j\ell} \prod_{i=1}^r [\nabla_{\bar{b}_i} \nabla\xi_m]\tag{17.73}$$

where the multi-indices in the summation satisfy $r + |\bar{c}| + \sum_i |\bar{b}_i| = |\bar{a}|$. In the extreme case where all the derivatives hit $q_{(k)}$, note that even for $k = D$, (17.71) provides bounds on at least $|\bar{a}| \leq 3$

derivatives. The worst term is the case $r = |\vec{a}|$ where all the derivatives hit the phase function, each costing a factor of $\lambda|\nabla\xi_m| \lesssim \lambda|m|$ in the estimate. The bound we attain (using $N^{-(k-2)/2} \leq 1$) is

$$\begin{aligned}
\|\nabla_{\vec{a}}Q_{(D)}^{j\ell}\|_{C^0} &\lesssim \sum_{k=1}^D \sum_{r=0}^{|\vec{a}|} \lambda^{-1+r} [N^{-(k-1)/2} N^{|\vec{c}|/2} \Xi^{|\vec{c}|} H] \prod_{i=1}^r [|m| N^{|\vec{b}_i|/2} \Xi^{|\vec{b}_i|}] \\
&\lesssim \lambda^{-1} \sum_{r=0}^{|\vec{a}|} \lambda^r N^{(|\vec{a}|-r)/2} \Xi^{|\vec{a}|-r} |m|^r H \\
&\lesssim \lambda^{-1} \lambda^{|\vec{a}|} |m|^{|\vec{a}|} \sum_{r=0}^{|\vec{a}|} (B_\lambda N \Xi)^{r-|\vec{a}|} N^{(|\vec{a}|-r)/2} \Xi^{|\vec{a}|-r} H \\
&\lesssim \lambda^{-1} (|m|\lambda)^{|\vec{a}|} H
\end{aligned} \tag{17.74}$$

The remainder term $\tilde{Q}_{(D)}^{j\ell}$ in (17.64) is defined to be

$$\tilde{Q}_{(D)}^{j\ell} = \mathcal{R}^{j\ell}[e^{2\pi i\lambda\xi_m} u_{(D)}] \tag{17.75}$$

Since $e^{2\pi i\lambda\xi_m} u_{(D)}^\ell = e^{2\pi i\lambda\xi_m} u^\ell - \nabla_j Q_{(D)}^{j\ell}$ (which can be seen by induction on D) we see that $Q_{(D)}^{j\ell}$ in (17.64) solves the divergence equation (17.62) using (7.3). To estimate $\tilde{Q}_{(D)}$, we use that $\mathcal{R}^{j\ell}$ is a bounded operator on $C^0(\mathbb{T}^3)$. This boundedness can be proven as in the bounds of Section 10.4 by estimating

$$\begin{aligned}
\|\mathcal{R}^{j\ell}[U]\|_{C^0(\mathbb{T}^3)} &\leq \|\mathcal{R}^{j\ell}\| \|U\|_{C^0(\mathbb{T}^3)} \\
\|\mathcal{R}^{j\ell}\| &\leq \sum_{q=0}^{\infty} \|\mathcal{R}^{j\ell} P_q\| \lesssim \sum_{q=0}^{\infty} 2^{-q} \lesssim 1
\end{aligned}$$

Thus, as before in (17.73)-(17.74), if $0 \leq |\vec{a}| \leq 3$, using (17.72) we have that

$$\begin{aligned}
\nabla_{\vec{a}}\tilde{Q}_{(D)}^{j\ell} &= \mathcal{R}^{j\ell} \left[\sum_{r=0}^{|\vec{a}|} \lambda^r \sum_{\vec{c}, \vec{b}_i} e^{i\lambda\xi_m} \nabla_{\vec{c}} u_{(D)} \prod_{i=1}^r [\nabla_{\vec{b}_i} \nabla \xi_m] \right] \\
\|\nabla_{\vec{a}}\tilde{Q}_{(D)}^{j\ell}\|_{C^0} &\lesssim \sum_{r=0}^{|\vec{a}|} \sum_{\vec{c}, \vec{b}_i} \lambda^r [B_\lambda^{-1} N^{-D/2} N^{|\vec{c}|/2} \Xi^{|\vec{c}|} H] \prod_{i=1}^r [|m| N^{|\vec{b}_i|/2} \Xi^{|\vec{b}_i|}] \\
&\lesssim B_\lambda^{-1} N^{-D/2} \lambda^{|\vec{a}|} |m|^{|\vec{a}|} \sum_{r=0}^{|\vec{a}|} \sum_{\vec{c}, \vec{b}_i} (B_\lambda N \Xi)^{r-|\vec{a}|} N^{(|\vec{a}|-r)/2} \Xi^{|\vec{a}|-r} H \\
\|\nabla_{\vec{a}}\tilde{Q}_{(D)}^{j\ell}\|_{C^0} &\lesssim (|m|\lambda)^{|\vec{a}|} B_\lambda^{-1} N^{-D/2} H
\end{aligned} \tag{17.76}$$

Combining (17.74) and (17.76) gives (17.63). It is also clear from (17.75) and the construction of $Q_{(D)}$ that $\text{supp}_t Q_{(D)} \cup \text{supp}_t \tilde{Q}_{(D)} \subseteq \text{supp}_t u \subseteq [t(I) - \theta, t(I) + \theta]$. This containment together with the previous discussion of (17.62) concludes the proof of Proposition 17.8. \square

We are now ready to prove Proposition 17.6.

Proof of Proposition 17.6. Let $\omega : \mathbb{T}^3 \rightarrow \mathbb{R}$ be smooth and have integral 0 as in Proposition 17.6 above. Then the Fourier series

$$\omega(X) = \sum_{m \neq 0} \hat{\omega}(m) e^{2\pi i m \cdot X} \tag{17.77}$$

converges absolutely in $C^0(\mathbb{T}^3)$, and, since ω is real-valued and smooth, the coefficients obey

$$\hat{\omega}(-m) = \overline{\hat{\omega}(m)}, \quad |\hat{\omega}(m)| \lesssim_\omega |m|^{-40} \quad (17.78)$$

For each $m \in \mathbb{Z}^3$, choose a solution $Q_m^{j\ell}$ to $\nabla_j Q_m^{j\ell} = (1 - \Pi_0)[e^{2\pi i \lambda m \cdot \Gamma_I} u^\ell]$ that obeys the conclusions of Proposition 17.8 and set

$$Q^{j\ell} := \frac{1}{2} \sum_{m \in \mathbb{Z}^3 \setminus \{0\}} \left(\hat{\omega}(m) Q_m^{j\ell} + \hat{\omega}(-m) \overline{Q_m^{j\ell}} \right) \quad (17.79)$$

Then $Q^{j\ell}$ is real-valued by (17.78) and belongs to $C_t C_x^3(\mathbb{R} \times \mathbb{T}^3)$ by the following estimate

$$\sup_{0 \leq |\bar{a}| \leq 3} \lambda^{-|\bar{a}|} \|\nabla_{\bar{a}} Q\|_{C^0} \lesssim \sum_{m \in \mathbb{Z}^3 \setminus \{0\}} |\hat{\omega}(m)| |m|^3 \sup_{0 \leq |\bar{a}| \leq 3} (|m|\lambda)^{-|\bar{a}|} \|\nabla_{\bar{a}} Q_m\|_{C^0} \quad (17.80)$$

$$\lesssim \sum_{m \in \mathbb{Z}} |\hat{\omega}(m)| |m|^3 (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) H \quad (17.81)$$

$$\stackrel{(17.78)}{\lesssim} (\lambda^{-1} + B_\lambda^{-1} N^{-D/2}) H \quad (17.82)$$

Thus $Q^{j\ell}$ satisfies (17.55)-(17.56). Taking the divergence of $Q^{j\ell}$ in (17.79) and using that u^ℓ is real-valued,

$$\nabla_j Q^{j\ell} = \frac{1}{2} \sum_{m \in \mathbb{Z}^3} \left(\hat{\omega}(m) (1 - \Pi_0) [e^{2\pi i \lambda m \cdot \Gamma_I} u^\ell] + \hat{\omega}(-m) (1 - \Pi_0) [e^{-2\pi i \lambda m \cdot \Gamma_I} u^\ell] \right) \quad (17.83)$$

$$\nabla_j Q^{j\ell} = (1 - \Pi_0) \left(\sum_{m \in \mathbb{Z}^3} \hat{\omega}(m) e^{2\pi i m \cdot (\lambda \Gamma_I)} u^\ell \right) = (1 - \Pi_0) [u^\ell \omega(\lambda \Gamma_I)] \quad (17.84)$$

This calculation concludes the proof of Proposition 17.6. \square

17.6 Concluding the Proof of the Convex Integration Lemma

In this Section we conclude the proof of Lemma 3.3 by indicating where in the course of the proof the various conclusions of the Lemma have been shown. The constant b_0 whose existence is asserted by the Lemma was chosen following Lines (15.11)-(15.14). The choices of b_0 and K there assure that the square root used to define the coefficients γ_J is well-defined and bounded from below. The bounds implied by (3.13) and Definition 2.2 for the new velocity $v_1 = v + V$ were proven in Proposition 17.3. Inequality (3.15) for the velocity correction was also proven in Proposition 17.3. The bounds implied by (3.13) and Definition 2.2 for the new stress $R_1 = R_M + R_S + R_T + R_H$ follow from the bounds in Propositions 17.4 and 17.5.

To check the statement (3.14) regarding the growth of support, observe that (3.4) and (3.6) imply

$$\text{supp}_t R \subseteq N(J; 3^{-1} \Xi^{-1} e_v^{-1/2}) \cap \bigcup_I [t(I) - 2^{-1}\theta, t(I) + 2^{-1}\theta]$$

Technically, statement (3.14) may not hold if we define $e_I^{1/2}(t)$ by formula (15.3) for all $I \in \mathbb{Z}$. However, we can replace $e_I^{1/2}(t)$ by 0 for I such that R_I is equal to 0 without affecting the proof. Modifying the construction in this way, recalling from Lemma 3.2 and (3.5) that $\theta \leq \delta_0 \Xi^{-1} e_v^{-1/2} \leq 25^{-1} \Xi^{-1} e_v^{-1/2}$,

and letting \mathcal{I} be the subset of \mathbb{Z} such that $R_I \neq 0$, we have

$$\begin{aligned} \text{supp}_t V \cup \text{supp}_t R_1 &\subseteq \bigcup_{I \in \mathcal{I}} [t(I) - \theta, t(I) + \theta] \subseteq N(\text{supp}_t R; 2^{-1}\theta) \\ &\subseteq N(\text{supp}_t R; 50^{-1}\Xi^{-1}e_v^{-1/2}) \subseteq N\left(N(J; 3^{-1}\Xi^{-1}e_v^{-1/2}); 50^{-1}\Xi^{-1}e_v^{-1/2}\right) \\ &\Rightarrow \text{supp}_t V \cup \text{supp}_t R_1 \subseteq N(J; \Xi^{-1}e_v^{-1/2}) \end{aligned}$$

Since $\text{supp}_t v \subseteq N(J; 3^{-1}\Xi^{-1}e_v^{-1/2})$, we also have $\text{supp}_t v_1 = \text{supp}_t(v + V) \subseteq N(J; \Xi^{-1}e_v^{-1/2})$, which confirms the containment (3.14) and hence concludes the proof of Lemma 3.3.

18 Proof of the Main Theorem

In this Section we give a proof of Theorem 1 based on Lemma 2.1. We follow the algorithm for computing regularity in the presence of double exponential frequency growth developed in [Ise17].

For the base case of the iteration, we will use the previous convex integration result of [Ise17], since Lemma 2.1 of the present paper does not include any inputs that would guarantee the nontriviality of the solution. The final solution is then constructed by iteratively applying Lemma 2.1.

Let $\alpha^* < 1/3$ be given. We introduce a parameter δ , $0 < \delta < 1/4$, that will be chosen close to zero depending on α^* . Our proof will lead to the following result, which immediately implies Theorem 1:

Theorem 3. *For any $0 < \delta < 1/4$ there exists a weak solution (v, p) to the incompressible Euler equations with nonempty, compact support in time in $\mathbb{R} \times \mathbb{T}^3$ such that $v \in C_{t,x}^\alpha, p \in C_{t,x}^{2\alpha}$ whenever*

$$-\left(\frac{1}{2} - \delta\alpha\right) \left(1 + \frac{\delta}{2}\right) + \frac{\delta}{2} + \alpha \left(\frac{3}{2} + \delta\right) < 0 \quad (18.1)$$

Note that the left hand side of (18.1) is bounded by $-\frac{1}{2} + \frac{3\alpha}{2} + O(\delta)$. Thus, given $\alpha^* < 1/3$, we can always choose $\delta > 0$ so that (18.1) is satisfied for $\alpha = \alpha^*$, and Theorem 1 now follows.

18.1 Regularity parameters

We start by introducing a few parameters. The parameter $\delta \in (0, 1/4)$ is fixed. We introduce a parameter ϵ , which we set equal to $\epsilon := \frac{\delta}{2}$. We introduce a third parameter η , which we set equal to $\eta := \frac{\epsilon}{16} = \frac{\delta}{32}$. We also define a parameter $r := \frac{20}{\delta^2}$. The parameters have already been chosen in such a way that $\eta \ll \epsilon \ll \delta$, and r is large enough depending on δ and ϵ . We define the constant C_η to be the constant from the conclusion of Lemma 2.1 using the above choice of $\eta > 0$.

There will be two large constant parameters. One parameter is called $N_{(-1)}$. The largest parameter will be called Z ; it depends on the δ, ϵ, η above and will be large compared to $N_{(-1)}$.

There will also be a sequence of parameters $(\Xi_{(k)}, e_{v,(k)}, e_{R,(k)})$ that will represent the frequency-energy level bounds on our approximate solutions. In terms of these, we define $\widehat{\Xi}_{(k)} := \Xi_{(k)} \left(\frac{e_v}{e_R}\right)_{(k)}^{1/2}$.

18.2 The base case: $k = -1$

The base case will rely on the Main Lemma in [Ise17], since this Lemma gives information that will be crucial for proving nontriviality of the solution, and also controls higher derivatives of the Euler-Reynolds flow to make it compatible with the scheme of the current paper.

Consider first the zero solution to the Euler-Reynolds system $(v, p, R)_{-1} = (0, 0, 0)$. It has frequency energy levels (in the sense of [Ise17, Definition 10.1]) to order 3 in C^0 below $(\Xi_{(-1)}, e_{v,(-1)}, e_{R,(-1)}) = (3, 1, 1)$. Let $e^{1/2}(t) \geq 0$ be a smooth function with compact support in \mathbb{R} such that $e^{1/2}(0) = 1$ and

$$\sup_t \left| \frac{d^a}{dt^a} e^{1/2}(t) \right| \leq 10(\Xi_{(-1)} e_{v,(-1)}^{1/2})^r e_{R,(-1)}^{1/2}, \quad a = 0, 1, 2.$$

Let \check{C} be the constant in the Main Lemma (Lemma 10.1) of [Ise17], where we take $L = 3$ and $N_{(-1)} \geq \Xi_{(-1)}^{1/2}$. Applying that lemma with the function $e^{1/2}(t)$ above and $N_{(-1)}$ to be chosen, we obtain an Euler-Reynolds flow $(v, p, R)_{(0)}$, also with compact support in time, with Frequency-Energy levels to order 3 in C^0 (in the sense of Definition 2.2 above) bounded by

$$(\Xi_{(0)}, e_{v,(0)}, e_{R,(0)}) = \left(3\check{C}N_{(-1)}, 1, \frac{1}{N_{(-1)}^{1/2}} \right)$$

For $N_{(-1)}$ sufficiently large, the following inequalities are satisfied in the stage $k = 0$:

$$\log \widehat{\Xi}_{(k)} \leq \left(\frac{e_v}{e_R} \right)_{(k)}^\epsilon \tag{18.2}$$

$$\widehat{\Xi}_{(k)} \leq \frac{1}{r^r} \left(\frac{e_v}{e_R} \right)_{(k)}^{r\epsilon} \tag{18.3}$$

$$e_{R,(k)}^{\frac{\delta r \epsilon}{4}} \Xi_{(k)} \leq 1 \tag{18.4}$$

$$\Xi_{(k)}^\eta \left(\frac{e_v}{e_R} \right)_{(k)}^{-1/2} e_{R,(k)}^\delta \leq 1 \tag{18.5}$$

This choice is possible thanks to our choice of r being large relative to δ and ϵ ; for example, when $k = 0$ the left hand side of (18.4) is bounded above by

$$e_{R,(0)}^{\frac{\delta r \epsilon}{4}} \Xi_{(0)} \leq \check{C} N_{(-1)}^{1 - \frac{\delta r \epsilon}{8}} 3.$$

One obtains (18.3) and (18.5) similarly for sufficiently large $N_{(-1)}$.

Note that inequality (18.2) follows immediately from (18.3) by taking u to be the right hand side of (18.2) in the following elementary inequality

$$\left(1 + \frac{u}{r} \right)^r \leq e^u \quad \text{for all } u \geq 0, r > 0$$

The last conditions we require on $N_{(-1)}$ are the ones that will ultimately guarantee that we construct a nontrivial solution. Observe that Lemma 10.1 of [Ise17] guarantees a bound of

$$\sup_t \left| \int_{\mathbb{T}^3} |v_{(0)}(t, x)|^2 dx - e(t) \right| \leq \check{C} \frac{e_{R,(-1)}}{N_{(-1)}}$$

(Note that, since we start with $v_{(-1)} = 0$, the correction $V = V_{(-1)}$ in this case is equal to our solution $v_{(0)}$.) For $N_{(-1)}$ sufficiently large, we can guarantee that

$$\begin{aligned} .81 = e(0) - .19 &\leq \int_{\mathbb{T}^3} |v_{(0)}(0, x)|^2 dx \leq \|v_{(0)}\|_{C^0}^2, \\ \Rightarrow .9 &\leq \|v_{(0)}\|_{C^0} \end{aligned} \tag{18.6}$$

Finally, let \check{C}_0 be the constant that in the statement of inequality (2.9) in Lemma 2.1 (which is the upper bound on the C^0 norm of the correction). A sufficiently large choice of $N_{(-1)}$ guarantees that

$$5000\check{C}_0(\log \widehat{\Xi}_{(0)})^{1/2} e_{R,(0)}^{1/2} \leq \frac{1}{400} \quad (18.7)$$

We now fix $N_{(-1)}$ to satisfy the above conditions together with (18.2)-(18.5).

18.3 The Sequence of Parameters

The goal of the present section is establish the main properties of the parameters $(\Xi, e_v, e_R)_{(k)}$ that will ultimately be the frequency energy levels of our sequence of Euler-Reynolds flows. The value of $(\Xi_{(0)}, e_{v,(0)}, e_{R,(0)})$ is already determined. The remaining values of the sequence are governed by the parameters δ, ϵ, η and a parameter Z according to the following rules:

$$\Xi_{(k+1)} = C_\eta Z \left(\frac{e_v}{e_R} \right)_{(k)}^{\frac{1}{2} + \frac{5\epsilon}{2}} e_{R,(k)}^{-\delta} \Xi_{(k)} \quad (18.8)$$

$$e_{v,(k+1)} = \left(\frac{e_v}{e_R} \right)_{(k)}^\epsilon e_{R,(k)} \quad (18.9)$$

$$e_{R,(k+1)} = \frac{e_{R,(k)}^{1+\delta}}{Z} \quad (18.10)$$

The constant C_η above is the constant associated to the parameter η by Lemma 2.1, with $\eta = \frac{\delta}{32}$ specified above. We also define the sequence

$$N_{(k)} := Z(\log \widehat{\Xi}_{(k)})^{5/2} \left(\frac{e_v}{e_R} \right)_{(k)}^{1/2} e_{R,(k)}^{-\delta} \quad (18.11)$$

Our choice of Z will be specified later in line (18.18).

The following Proposition will ensure that the iteration proceeds in a well defined way for sufficiently large choices of Z .

Proposition 18.1. *Let $(\Xi_{(0)}, e_{v,(0)}, e_{R,(0)})$ be parameters that satisfy the conditions (18.2)-(18.5) of Section 18.2, with $e_{v,(0)} \geq e_{R,(0)}$ and $e_{R,(0)} < 1 < \Xi_{(0)}$. There exists Z_0 such that for all $Z \geq Z_0$, the sequence determined by (18.8)-(18.10) and (18.11) satisfies conditions (18.2)-(18.5) for all $k \geq 0$ and also*

$$\left(\frac{e_v}{e_R} \right)_{(k)}^{\frac{1}{2}} \leq Z^{1/2} e_{R,(k)}^{-\frac{\delta}{2}} \quad (18.12)$$

$$N_{(k)} \geq \Xi_{(k)}^\eta \quad (18.13)$$

The case $k = 0$. For Z sufficiently large depending on $e_{v,(0)}, e_{R,(0)}$, we can ensure that (18.12) holds for $k = 0$. Also, (18.13) is an immediate consequence of (18.5) and the definition (18.11) of $N_{(k)}$. Thus we may assume the Proposition holds for $k = 0$. We now prove the Proposition for stage $k + 1$. \square

Proof of (18.3) and (18.2) for $k + 1$. Observe that

$$\begin{aligned}\widehat{\Xi}_{(k+1)} \left(\frac{e_v}{e_R} \right)_{(k+1)}^{-r\epsilon} &= \Xi_{(k+1)} \left(\frac{e_v}{e_R} \right)_{(k+1)}^{\frac{1}{2}-r\epsilon} \leq \Xi_{(k+1)} \left(\frac{e_v}{e_R} \right)_{(k+1)}^{-\frac{r\epsilon}{2}} \\ \Xi_{(k+1)} \left(\frac{e_v}{e_R} \right)_{(k+1)}^{-\frac{r\epsilon}{2}} &= \left[C_\eta Z e_{R,(k)}^{-\delta} \left(\frac{e_v}{e_R} \right)_{(k)}^{\frac{1+5\epsilon}{2}} \Xi_{(k)} \right] \left[\left(\frac{e_v}{e_R} \right)_{(k)}^\epsilon Z e_{R,(k)}^{-\delta} \right]^{-\frac{r\epsilon}{2}} \\ &\leq C_\eta Z^{1-\frac{r\epsilon}{2}} \left(\frac{e_v}{e_R} \right)_{(k)}^{\frac{1+5\epsilon}{2}-\frac{r\epsilon^2}{2}} [e_{R,(k)}^{\frac{\delta r\epsilon}{4}} \Xi_{(k)}]\end{aligned}$$

By our choice of r , the power to which Z is raised in the last line is negative and likewise the energy ratio $(e_v/e_R)_{(k)}$ is raised to a positive power. The energy ratio term is therefore at most 1 and the constant term is bounded by r^{-r} for sufficiently large Z . The last term in brackets is at most 1 by the induction hypothesis on (18.4). Finally, as noted previously in Section 18.2, inequality (18.2) follows from (18.3). \square

Proof of (18.4) for $k + 1$. Observe that

$$e_{R,(k+1)}^{\frac{\delta r\epsilon}{4}} \Xi_{(k+1)} = C_\eta Z^{1-\frac{\delta r\epsilon}{4}} \left[\left(\frac{e_v}{e_R} \right)_{(k)}^{\frac{1+5\epsilon}{2}} e_{R,(k)}^{-\delta+\frac{\delta^2 r\epsilon}{4}} \right] e_{R,(k)}^{\frac{\delta r\epsilon}{4}} \Xi_{(k)}$$

The last product involving $e_{R,(k)}$ and $\Xi_{(k)}$ is at most 1 by the induction hypothesis on (18.4). Applying the induction hypothesis of inequality (18.12) and $5\epsilon < 1$ gives

$$e_{R,(k+1)}^{\frac{\delta r\epsilon}{4}} \Xi_{(k+1)} \leq C_\eta Z^{2-\frac{\delta r\epsilon}{4}} e_{R,(k)}^{-2\delta+\frac{\delta^2 r\epsilon}{4}}$$

For Z large enough, the constant term is bounded by 1, and the power to which $e_{R,(k)}$ is raised above is positive by the choice of r , which gives the inequality. \square

Proof of (18.5) and (18.13) for $k + 1$. As before, (18.13) follows from (18.5). To prove (18.5), observe that

$$\begin{aligned}\Xi_{(k+1)}^\eta \left(\frac{e_v}{e_R} \right)_{(k+1)}^{-1/2} e_{R,(k)}^\delta &= \left[C_\eta Z \left(\frac{e_v}{e_R} \right)_{(k)}^{\frac{1+5\epsilon}{2}} e_{R,(k)}^{-\delta} \Xi_{(k)} \right]^\eta \left[Z^{-1/2} \left(\frac{e_v}{e_R} \right)_{(k)}^{-\epsilon/2} e_{R,(k)}^{\frac{\delta}{2}} \right] \frac{e_{R,(k)}^{\delta(1+\delta)}}{Z^\delta} \\ &\leq (C_\eta)^\eta Z^{\eta-\frac{1}{2}-\delta} \left(\frac{e_v}{e_R} \right)_{(k)}^{(\frac{1+5\epsilon}{2})\eta-\frac{\epsilon}{2}} e_{R,(k)}^{\delta(-\eta+\frac{1}{2}+\delta)} [e_{R,(k)}^\delta \Xi_{(k)}^\eta]\end{aligned}$$

By our induction hypotheses on (18.5) and (18.12), the last term in brackets is at most

$$e_{R,(k)}^\delta \Xi_{(k)}^\eta \leq \left(\frac{e_v}{e_R} \right)_{(k)}^{1/2} \leq Z^{1/2} e_{R,(k)}^{-\frac{\delta}{2}}$$

Using this bound and noting that $(e_v/e_R)_{(k)}$ is raised to a negative power by the choice of η gives

$$\Xi_{(k+1)}^\eta \left(\frac{e_v}{e_R} \right)_{(k+1)}^{-1/2} e_{R,(k)}^\delta \leq (C_\eta)^\eta Z^{\eta-\delta} e_{R,(k)}^{\delta(-\eta+\delta)}$$

Since we chose $\eta < \delta$, we see that Z is raised to a negative power and $e_{R,(k)}$ is raised to a positive power in the above estimate. For large Z , the constant term is at most 1 and the estimate follows. \square

Proof of (18.12) for $k + 1$. By the induction hypothesis on (18.12) and using (18.10) and $\epsilon = \frac{\delta}{2}$, we obtain

$$\begin{aligned} \left(\frac{e_v}{e_R}\right)_{(k+1)}^{1/2} &= Z^{1/2} \left(\frac{e_v}{e_R}\right)_{(k)}^{\frac{\epsilon}{2}} e_{R,(k)}^{-\frac{\delta}{2}} \leq Z^{\frac{1}{2}+\frac{\epsilon}{2}} e_{R,(k)}^{-\frac{\delta\epsilon}{2}-\frac{\delta}{2}} \\ &= Z^{\frac{1}{2}} Z^{\frac{\epsilon}{2}-\frac{\delta}{2}\left(\frac{1+\epsilon}{1+\delta}\right)} e_{R,(k+1)}^{-\frac{\delta}{2}\left(\frac{1+\epsilon}{1+\delta}\right)} \leq Z^{1/2} e_{R,(k+1)}^{-\frac{\delta}{2}} \end{aligned}$$

□

18.4 Iteration of the Main Lemma

We now prove Theorem 1 by repeated iteration of Lemma 2.1.

Let $(v_{(0)}, p_{(0)}, R_{(0)})$ be the Euler-Reynolds flow constructed in the base case of Section 18.2, and $(\Xi_{(0)}, e_{v,(0)}, e_{R,(0)})$ be its associated frequency-energy levels, which satisfy the assumptions of Proposition 18.1. Let $I_{(0)}$ be a bounded, closed interval containing $\text{supp}_t v_{(0)} \cup \text{supp}_t R_{(0)}$.

We construct a sequence of Euler-Reynolds flows with supporting time intervals $J_{(k)}$ and frequency-energy levels bounded by $(\Xi_{(k)}, e_{v,(k)}, e_{R,(k)})$ as follows. For $k \geq 0$, apply Lemma 2.1 with the parameter η chosen in Section 18.1 and taking N to be the $N_{(k)}$ defined in (18.11). Note that the parameter $N_{(k)}$ satisfies the admissibility conditions $N_{(k)} \geq (e_v/e_{R,(k)})^{1/2}$ and $N_{(k)} \geq \Xi_{(k)}^\eta$ by Proposition 18.1. Lemma 2.1 then yields an Euler-Reynolds flow $(v_{(k+1)}, p_{(k+1)}, R_{(k+1)})$ such that

$$\text{supp}_t v_{(k+1)} \cup \text{supp}_t R_{(k+1)} \subseteq J_{(k+1)} := N(J_{(k)}; \Xi_{(k)}^{-1} e_{v,(k)}^{-1/2}) \quad (18.14)$$

and such that the frequency energy levels of $(v_{(k+1)}, p_{(k+1)}, R_{(k+1)})$ are bounded by

$$(\Xi'_{(k)}, e'_{v,(k)}, e'_{R,(k)}) = \left(C_\eta Z (\log \widehat{\Xi}_{(k)})^{5/2} e_{R,(k)}^{-\delta} \Xi_{(k)}, (\log \widehat{\Xi}_{(k)}) e_{R,(k)}, \frac{e_{R,(k)}^{1+\delta}}{Z} \right)$$

By inequality (18.2) of Proposition 18.1, we have $\Xi'_{(k)} \leq \Xi_{(k+1)}$ and $e'_{v,(k)} \leq e_{v,(k+1)}$, and we also have $e'_{R,(k)} = e_{R,(k+1)}$. We may therefore regard $(v_{(k+1)}, p_{(k+1)}, R_{(k+1)})$ as an Euler-Reynolds flow with frequency energy levels below $(\Xi_{(k+1)}, e_{v,(k+1)}, e_{R,(k+1)})$, allowing the induction to continue in a well-defined way. Lemma 2.1 also gives the following estimates for $V_{(k)} := v_{(k+1)} - v_{(k)}$

$$\|V_{(k)}\|_{C^0} \leq \check{C}_0 (\log \widehat{\Xi}_{(k)})^{1/2} e_{R,(k)}^{1/2} \quad (18.15)$$

$$\|\nabla V_{(k)}\|_{C^0} \leq C_\eta N_{(k)} \Xi_{(k)} (\log \widehat{\Xi}_{(k)})^{1/2} e_{R,(k)}^{1/2} \quad (18.16)$$

18.5 Continuity and Nontriviality of the Solution

We claim that the sequence of velocity fields $v_{(k)}$ converges uniformly to a limit that is a nontrivial, continuous weak solution to the Euler equations. Indeed, from (18.15) we have that for all $k \geq 0$,

$$\begin{aligned} \|V_{(k+1)}\|_{C^0} &\stackrel{(18.2)}{\leq} \check{C}_0 \left(\frac{e_v}{e_R}\right)_{(k+1)}^{\frac{\epsilon}{2}} e_{R,(k+1)}^{1/2} \stackrel{(18.12)}{\leq} \check{C}_0 Z^{\frac{\epsilon}{2}} e_{R,(k+1)}^{\frac{1}{2}-\frac{\delta}{2}} \leq \check{C}_0 Z^{\frac{\epsilon+\delta-1}{2}} e_{R,(k)}^{(1+\delta)\left(\frac{1-\delta}{2}\right)} \\ \|V_{(k+1)}\|_{C^0} &\leq \check{C}_0 Z^{-\frac{1}{3}} e_{R,(k)}^{\frac{1}{4}} \end{aligned} \quad (18.17)$$

Using $e_{R,(k+1)} \leq \frac{1}{2} e_{R,(k)}$, we can at this point choose Z large enough depending on \check{C}_0 (= the constant in inequality (2.9)) and $e_{R,(0)}$ such that

$$\sum_{k=0}^{\infty} \check{C}_0 Z^{-\frac{1}{3}} e_{R,(k)}^{\frac{1}{4}} \leq \frac{3}{400}. \quad (18.18)$$

It follows that $v_{(k)}$ converges uniformly to a continuous velocity field v .

If we choose the integral 0 normalization for $p_{(k)} = \Delta^{-1} \nabla_j \nabla_\ell R_{(k)}^{j\ell} - \Delta^{-1} \nabla_j \nabla_\ell (v_{(k)}^j v_{(k)}^\ell)$, then since $R_{(k)} \rightarrow 0$ uniformly, we have that $p_{(k)}$ converges weakly in \mathcal{D}' to the pressure $p = -\Delta^{-1} \nabla_j \nabla_\ell (v^j v^\ell)$. One sees by testing the Euler-Reynolds equations for $(v_{(k)}, p_{(k)}, R_{(k)})$ against smooth test functions that the pair (v, p) form a weak solution to the incompressible Euler equations.

To see that v is not the 0 solution, compare the lower bound (18.6) on $\|v_{(0)}\|_{C^0}$ to the upper bound

$$\|v - v_{(0)}\|_{C^0} \leq \|V_{(0)}\|_{C^0} + \sum_{k=0}^{\infty} \|V_{(k+1)}\|_{C^0} \leq \frac{1}{400} + \frac{3}{400} = .01,$$

which follows from (18.7) and (18.17)-(18.18). It now remains to show that v has compact support in time and satisfies the regularity stated in Theorem 3.

18.6 Regularity and Compact Support in Time of the Solution

We now show that the incompressible Euler flow v defined in Section 18.4 above belongs to the class $v \in C_{t,x}^\alpha, p \in C_{t,x}^{2\alpha}$ for all α that satisfy inequality (18.1). The time regularity theory of [Ise13a] shows that if $0 < \alpha < 1$ and (v, p) is an incompressible Euler flow in the class $v \in C_t C_x^\alpha$, then $v \in C_{t,x}^\alpha$ and $p \in C_{t,x}^{2\beta}$ for all $0 \leq \beta < \alpha$. It therefore suffices to show that $v \in C_t C_x^\alpha$ for the stated range of α .

Interpolating (2.9) and (2.10) gives the following bound on the $C_t C_x^\alpha$ norm of each correction

$$\begin{aligned} \|V_{(k)}\|_{C_t C_x^\alpha} &\leq C(N_{(k)} \Xi_{(k)})^\alpha (\log \widehat{\Xi}_{(k)})^{1/2} e_{R,(k)}^{1/2} \\ &\leq CZ^\alpha [(\log \widehat{\Xi}_{(k)})^{\frac{5\alpha}{2}} \left(\frac{e_v}{e_R}\right)_{(k)}^{\frac{\alpha}{2}} e_{R,(k)}^{-\delta\alpha} \Xi_{(k)}^\alpha] (\log \widehat{\Xi}_{(k)})^{1/2} e_{R,(k)}^{1/2} \\ &= CZ^\alpha (\log \widehat{\Xi}_{(k)})^{\frac{5\alpha+1}{2}} \left(\frac{e_v}{e_R}\right)_{(k)}^{\frac{\alpha}{2}} e_{R,(k)}^{\frac{1}{2}-\delta\alpha} \Xi_{(k)}^\alpha \\ \frac{\|V_{(k)}\|_{C_t C_x^\alpha}}{CZ^\alpha} &\stackrel{(18.2)}{\leq} e_{R,(k)}^{\frac{1}{2}-\delta\alpha} \left(\frac{e_v}{e_R}\right)_{(k)}^{1/2} \Xi_{(k)}^\alpha \end{aligned} \quad (18.19)$$

Next define the following sequence of parameter vectors

$$\psi_{(k)} := \begin{bmatrix} \log e_R \\ \log(e_v/e_R) \\ \log \Xi \end{bmatrix}_{(k)}$$

The evolution rules (18.8)-(18.10) can be rephrased as

$$\psi_{(k+1)} = \begin{bmatrix} -\log Z \\ \log Z \\ \log(C_\eta Z) \end{bmatrix} + \begin{bmatrix} 1+\delta & 0 & 0 \\ -\delta & \epsilon & 0 \\ -\delta & \frac{1}{2} + \epsilon & 1 \end{bmatrix} \psi_{(k)} \quad (18.20)$$

We call the 3×3 matrix appearing on the right hand side of (18.20) the “**parameter evolution matrix**” as in [Ise17], and we denote this matrix by T_δ . Since T_δ is lower triangular, the eigenvalues of T_δ are the diagonal entries $(1+\delta, \epsilon = \frac{\delta}{2}, 1)$. For large k , the $\psi_{(k)}$ are (projectively) concentrated near the eigenline corresponding to the largest eigenvalue, $(1+\delta)$, which is spanned by the eigenvector

$$\psi_+ := \begin{bmatrix} -(1 + \frac{\delta}{2}) \\ \delta \\ \frac{3}{2} + \delta \end{bmatrix} \in \text{NS}[T_\delta - (1+\delta)I] = \text{NS} \begin{bmatrix} 0 & 0 & 0 \\ -\delta & -1 - \frac{\delta}{2} & 0 \\ -\delta & \frac{1}{2} + \frac{\delta}{2} & -\delta \end{bmatrix} \quad (18.21)$$

More precisely, let $(\psi_+, \psi_\epsilon, \psi_1)$ be an eigenbasis for T_δ corresponding to the eigenvalues $(1 + \delta, \epsilon, 1)$. In terms of this basis,

$$\psi_{(k)} = c_{+, (k)} \psi_+ + c_{\epsilon, (k)} \psi_\epsilon + c_{1, (k)} \psi_1 \quad (18.22)$$

and $[-\log Z, \log Z, \log(C_\eta Z)]^t = u_+ \psi_+ + u_\epsilon \psi_\epsilon + u_1 \psi_1$. In this basis, (18.20) transforms to

$$c_{+, (k+1)} = u_+ + (1 + \delta) c_{+, (k)} \quad (18.23)$$

$$c_{\epsilon, (k+1)} = u_\epsilon + \epsilon c_{\epsilon, (k)} \quad (18.24)$$

$$c_{1, (k+1)} = u_1 + c_{1, (k)} \quad (18.25)$$

From (18.24) and (18.25), one obtains by induction a linear upper bound of

$$|c_{\epsilon, (k)}| + |c_{1, (k)}| \leq |k|(|u_\epsilon| + |u_1|) + |c_{\epsilon, (0)}| + |c_{1, (0)}| \quad (18.26)$$

As for (18.23), we claim that $u_+ > 0$ and

$$c_{+, (k)} \geq (1 + \delta)^k c_{+, (0)} > 0 \quad \text{for all } k \quad (18.27)$$

To prove the claim, we use the fact that $[1, 0, 0]$ is a $(1 + \delta)$ -row-eigenvector: $[1, 0, 0][T_\delta - (1 + \delta)I] = 0$. It is therefore invariant under the projection to the $1 + \delta$ eigenspace:

$$[1, 0, 0] = [1, 0, 0] \left[\frac{(T_\delta - \epsilon I)}{(1 + \delta - \epsilon)} \frac{(T_\delta - I)}{\delta} \right] \quad (18.28)$$

Applying $[1, 0, 0]$ to (18.22) and using (18.21) and (18.28), one obtains $u_+ = \frac{\log Z}{(1 + \frac{\delta}{2})}$ and $c_{+, (k)} = -\frac{\log \epsilon_{R, (k)}}{(1 + \frac{\delta}{2})}$. From this calculation, the claim (18.27) follows from (18.23) by induction.

We now turn to the estimate (18.19). Let $E_{\alpha, (k)}$ denote the right hand side of the upper bound of (18.19). Then using (18.22) and (18.26)

$$\log E_{\alpha, (k)} = [1/2 - \delta\alpha, 1/2, \alpha] \psi_{(k)} \quad (18.29)$$

$$\log E_{\alpha, (k)} = c_{+, (k)} [1/2 - \delta\alpha, 1/2, \alpha] \psi_+ + O_{\alpha, Z}(|k|) \quad (18.30)$$

The $O(\cdot)$ term above grows linearly in k with an implied constant that depends on α, Z, C_η . The assumption (18.1) on α in Theorem 3 is exactly the condition that

$$[1/2 - \delta\alpha, 1/2, \alpha] \psi_+ = -\left(\frac{1}{2} - \delta\alpha\right) \left(1 + \frac{\delta}{2}\right) + \frac{\delta}{2} + \alpha \left(\frac{3}{2} + \delta\right) < 0 \quad (18.31)$$

Using (18.27), (18.19) and (18.30) we obtain a double-exponential decay for the $C_t C_x^\alpha$ norms of $V_{(k)}$:

$$\frac{\|V_{(k)}\|_{C_t C_x^\alpha}}{C Z^\alpha} \leq E_{\alpha, (k)} \leq e^{-c_\alpha (1 + \delta)^k + O_{\alpha, Z}(|k|)}$$

The constant c_α above is a positive number that depends on α, Z and the initial $(\Xi, e_v, e_R)_{(0)}$. With this bound, we obtain the desired regularity $v \in C_t C_x^\alpha$ for our solution.

We now prove the compact support in time for the solution. By (18.14), it suffices to show that the series $\sum_{k=0}^{\infty} (\Xi_{(k)} e_{v, (k)}^{1/2})^{-1} = \sum_{k=0}^{\infty} e_{R, (k)}^{-1/2} (e_v / e_R)_{(k)}^{-1/2} \Xi_{(k)}^{-1}$ converges to a finite value. As in the analysis from (18.29) to (18.31), it suffices to check that

$$[-1/2, -1/2, -1] \psi_+ = \frac{1}{2} \left(1 + \frac{\delta}{2}\right) - \frac{\delta}{2} - \left(\frac{3}{2} + \delta\right) < 0.$$

This calculation concludes the proof of Theorem 3.

A Appendix

In this Appendix, we gather several general analysis facts that have been used throughout the proofs of Lemmas 3.1-3.3. We start by proving Proposition 9.1, which is the well-known Littlewood-Paley characterization of the \dot{C}^α seminorm. We refer to Section 9 for notation.

Proof of Proposition 9.1. Let $\|f\|_{\dot{B}_{\infty,\infty}^\alpha} := \sup_q 2^{\alpha q} \|P_q f\|_{C^0}$ denote the Littlewood-Paley version of the seminorm. To see that $\|f\|_{\dot{B}_{\infty,\infty}^\alpha} \lesssim_\alpha \|f\|_{\dot{C}^\alpha}$, we use that $\int_{\mathbb{R}^n} \chi_q(h) dh = 0$ to write

$$\begin{aligned} P_q f(x) &= \int_{\mathbb{R}^n} f(x-h) \chi_q(h) dh \\ &= \int_{\mathbb{R}^n} (f(x-h) - f(x)) \chi_q(h) dh \\ |P_q f(x)| &\leq \|f\|_{\dot{C}^\alpha} \int_{\mathbb{R}^n} |h|^\alpha |\chi_q(h)| dh \lesssim_\alpha 2^{-\alpha q} \|f\|_{\dot{C}^\alpha} \end{aligned}$$

Multiplying by $2^{\alpha q}$ and taking a supremum over x and q gives $\|f\|_{\dot{B}_{\infty,\infty}^\alpha} \lesssim_\alpha \|f\|_{\dot{C}^\alpha}$.

To prove $\|f\|_{\dot{C}^\alpha} \lesssim \|f\|_{\dot{B}_{\infty,\infty}^\alpha}$, let $x \in \mathbb{T}^n$, $h \in \mathbb{R}^n$, $h \neq 0$. Choose $\bar{q} \in \mathbb{Z}$ such that $2^{\bar{q}-1} < |h| \leq 2^{\bar{q}}$. Using the decomposition (9.2) and that $\Pi_0 f$ is a constant, we have

$$\begin{aligned} f(x+h) - f(x) &= \sum_{q \leq \bar{q}} [P_q f(x+h) - P_q f(x)] + \sum_{q > \bar{q}} [P_q f(x+h) - P_q f(x)] \\ \left| \sum_{q > \bar{q}} [P_q f(x+h) - P_q f(x)] \right| &\leq \sum_{q > \bar{q}} 2 \|P_q f\|_{C^0} \\ &\leq 2 \sum_{q > \bar{q}} 2^{-\alpha q} \|f\|_{\dot{B}_{\infty,\infty}^\alpha} \\ (0 < \alpha) \Rightarrow &\lesssim_\alpha 2^{-\alpha \bar{q}} \|f\|_{\dot{B}_{\infty,\infty}^\alpha} \lesssim |h|^\alpha \|f\|_{\dot{B}_{\infty,\infty}^\alpha} \end{aligned}$$

For the low-frequency part, apply the Mean Value Theorem and $P_q = P_{\approx q} P_q$ to obtain

$$\begin{aligned} \left| \sum_{q \leq \bar{q}} [P_q f(x+h) - P_q f(x)] \right| &\leq \sum_{q \leq \bar{q}} |h| \|\nabla P_q f\|_{C^0} \\ &\leq |h| \sum_{q \leq \bar{q}} \|\nabla P_{\approx q} P_q f\|_{C^0} \\ &\leq |h| \sum_{q \leq \bar{q}} \|\nabla P_{\approx q}\| \|P_q f\|_{C^0} \\ &\lesssim_\alpha |h| \sum_{q \leq \bar{q}} 2^q [2^{-\alpha q} \|f\|_{\dot{B}_{\infty,\infty}^\alpha}] \\ (\alpha < 1) \Rightarrow &\lesssim_\alpha |h| 2^{(1-\alpha)\bar{q}} \|f\|_{\dot{B}_{\infty,\infty}^\alpha} \leq |h|^\alpha \|f\|_{\dot{B}_{\infty,\infty}^\alpha} \end{aligned}$$

□

We next prove the commutator estimate of Proposition 9.2.

Proof of Proposition 9.2. Let $u \in L^\infty(\mathbb{R}^n)$ be a smooth vector field and $f \in L^\infty(\mathbb{R}^n)$ be a smooth function. Then for all $x \in \mathbb{R}^n$

$$\begin{aligned} u \cdot \nabla P_q f(x) - P_q[u \cdot \nabla f](x) &= u^i(x) \frac{\partial}{\partial x^i} \int_{\mathbb{R}^n} f(x+h) \chi_q(h) dh - \int_{\mathbb{R}^n} u^i(x+h) \frac{\partial}{\partial x^i} f(x+h) \chi_q(h) dh \\ &= \int_{\mathbb{R}^n} (u^i(x) - u^i(x+h)) \frac{\partial}{\partial h^i} f(x+h) \chi_q(h) dh \\ &= \int_{\mathbb{R}^n} (u^i(x) - u^i(x+h)) \frac{\partial}{\partial h^i} [f(x+h) - f(x)] \chi_q(h) dh \end{aligned}$$

Using that $u \in L^\infty(\mathbb{R}^n)$, $f \in L^\infty(\mathbb{R}^n)$ and χ_q is Schwartz, we may integrate by parts in h to obtain

$$u \cdot \nabla P_q f(x) - P_q[u \cdot \nabla f](x) = - \int_{\mathbb{R}^n} (u^i(x) - u^i(x+h)) (f(x+h) - f(x)) \nabla_i \chi_q(h) dh \quad (\text{A.1})$$

$$+ \int_{\mathbb{R}^n} \nabla_i u^i(x+h) (f(x+h) - f(x)) \chi_q(h) dh \quad (\text{A.2})$$

We estimate the terms on the right hand side by

$$\begin{aligned} |(\text{A.2})| &\leq \|\nabla u\|_{C^0} \|f\|_{\dot{C}^\alpha} \int_{\mathbb{R}^n} |h|^\alpha |\chi_q(h)| dh \\ &\lesssim 2^{-\alpha q} \|\nabla u\|_{C^0} \|f\|_{\dot{C}^\alpha} \\ (\text{A.1}) &= \int_{\mathbb{R}^n} \left[\int_0^1 \nabla_a u^i(x + \sigma h) h^a d\sigma \right] (f(x+h) - f(x)) \nabla_i \chi_q(h) dh \\ |(\text{A.1})| &\leq \|\nabla u\|_{C^0} \|f\|_{\dot{C}^\alpha} \int_{\mathbb{R}^n} |h|^{1+\alpha} |\nabla \chi_q(h)| dh \\ &\lesssim 2^{-\alpha q} \|\nabla u\|_{C^0} \|f\|_{\dot{C}^\alpha} \end{aligned}$$

□

Proposition A.1 below lists some standard facts about nonsingular linear transport equations.

Proposition A.1. *Let $t_0 \in \mathbb{R}$ and J be an open interval in \mathbb{R} containing t_0 . Let $u : J \times \mathbb{T}^n \rightarrow \mathbb{R}^n$ be a smooth vector field and $g : J \times \mathbb{T}^n \rightarrow \mathbb{R}$ be a smooth function, i.e. $u \in C_t C_x^k$, $g \in C_t C_x^k$ for all $k \geq 0$. Let $f_0 : \mathbb{T}^n \rightarrow \mathbb{R}$ be smooth. Then there exists $f : J \times \mathbb{T}^n \rightarrow \mathbb{R}$ such that $f \in C^1(J \times \mathbb{T}^n)$, $f \in \bigcap_{k \geq 0} C_t C_x^k$ is smooth in the spatial variables on $J \times \mathbb{T}^n$, and f satisfies*

$$\begin{aligned} (\partial_t + u \cdot \nabla) f &= g, & \text{on } J \times \mathbb{T}^n \\ f(t_0, x) &= f_0(x), & \text{for } x \in \mathbb{T}^n \end{aligned} \quad (\text{A.3})$$

Furthermore, f is unique among solutions to (A.3) in the class $f \in C^1(J \times \mathbb{T}^n)$, and f satisfies

$$\|f(t)\|_{C^0} \leq \|f_0\|_{C^0} + \left| \int_{t_0}^t \|g(\tau)\|_{C^0} d\tau \right|, \quad \text{for all } t \in J \quad (\text{A.4})$$

Proof. We only sketch the proof of (A.4). Let $(t, x) \in J \times \mathbb{T}^n$. Let $\gamma(\cdot) : J \rightarrow \mathbb{T}^n$ be the unique solution to the ODE $\frac{d\gamma}{d\tau}(\tau) = u(\tau, \gamma(\tau))$ with $\gamma(t) = x$. Then for any $f \in C^1(J \times \mathbb{T}^n)$ solving (A.3) and $\tau \in J$, set $\psi(\tau) := f(\tau, \gamma(\tau))$. Then $\frac{d}{d\tau} \psi(\tau) = g(\tau, \gamma(\tau))$ for all $\tau \in J$ and $\psi(t_0) = f_0(\gamma(t_0))$. Integrating from t_0 to t , we have that $|\psi(t)| = |f(t, x)|$ is bounded by the right hand side of (A.4). □

Our proof of the Gluing Approximation Lemma relies on the following Proposition concerning existence of regular solutions to the transport-elliptic equation (8.2). Recall that $\mathcal{S} \subseteq \mathbb{R}^3 \otimes \mathbb{R}^3$ denotes the space of real symmetric $(2, 0)$ tensors.

Theorem 4. *Let J be an open subinterval of \mathbb{R} and $t_0 \in J$. Let $v : J \times \mathbb{T}^3 \rightarrow \mathbb{R}^3$ be a smooth vector field $v \in \bigcap_{k \geq 0} C_t C_x^k$ that is divergence free $\nabla_i v^i = 0$. Let $\rho_0 : \mathbb{T}^3 \rightarrow \mathcal{S}$ be smooth and $Z : J \times \mathbb{T}^3 \rightarrow \mathbb{R}^3$ be a smooth vector field $Z \in \bigcap_{k \geq 0} C_t C_x^k$. Then there exists $\rho : J \times \mathbb{T}^n \rightarrow \mathcal{S}$ such that $\rho \in C^1(J \times \mathbb{T}^3)$, $\rho \in \bigcap_{k \geq 0} C_t C_x^k$ is smooth in the spatial variables, and*

$$\begin{aligned} (\partial_t + v \cdot \nabla) \rho^{j\ell} &= \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i (\rho^{ab}) + Z^b] \\ \rho^{j\ell}(t_0, x) &= \rho_0^{j\ell}(x) \end{aligned} \tag{A.5}$$

Proof. The proof of Theorem 4 proceeds by modifying the work in [Ise17, Sections 27.1-27.3]. There the analysis specialized to the case of $\rho_0^{j\ell} = \mathcal{R}^{j\ell}[U]$ and $Z^b = (\partial_t + v \cdot \nabla)U$ for some vector field U with spatial integral 0 (which suffices for the applications of the present paper). The proof in [Ise17, Sections 27.1-27.3] assumes estimates on v and Z that are uniform in time and emphasizes the a priori estimates on the solution. Here we outline how to adapt the proof to an arbitrary open time interval, and focus on the proof of existence for the solution.

Set $\rho_{(0)}^{j\ell}(t, x) = \rho_0^{j\ell}(x)$, and define $\rho_{(k+1)}^{j\ell}$ to be the unique solution to

$$\begin{aligned} (\partial_t + v \cdot \nabla) \rho_{(k+1)}^{j\ell} &= \mathcal{R}^{j\ell} [\nabla_a v^i \nabla_i (\rho_{(k)}^{ab}) + Z^b] \\ \rho_{(k+1)}^{j\ell}(t_0, x) &= \rho_0^{j\ell}(x) \end{aligned} \tag{A.6}$$

Observe that the functions $\rho_{(k)}^{j\ell} : J \times \mathbb{T}^3 \rightarrow \mathcal{S}$ are well defined on all of $J \times \mathbb{T}^3$ and are smooth in the spatial variables: $\rho_{(k)}, \partial_t \rho_{(k)} \in \bigcap_{k \geq 0} C_t C_x^k$. We claim that for every compact subinterval $\bar{J} \subseteq J$ and every $L \in \mathbb{Z}_+$, the sequence $\rho_{(k)}$ is Cauchy in $C_t C_x^L(\bar{J} \times \mathbb{T}^3)$.

Let \bar{J} be an compact subinterval of J . We claim that for all $L \geq 0$ the sequence $\rho_{(k)}$ is Cauchy in $C_t C_x^L(\bar{J} \times \mathbb{T}^3)$. Let $L \geq 1$ be given. Choose parameters $\bar{\tau}^{-1}, \Lambda > 0$ such that

$$\|\nabla^{k+1} v\|_{C^0} \leq \Lambda^k \bar{\tau}^{-1}, \quad \text{for all } 0 \leq k \leq L \tag{A.7}$$

For any $\rho : J \times \mathbb{T}^n \rightarrow \mathcal{S}$ in the class $\bigcap_{k \geq 0} C_t C_x^k$, define the weighted energy

$$E_L[\rho(t)] = \sum_{K=1}^L \sum_{j,\ell=1}^3 \sum_{|\vec{a}|=K} \int_{\mathbb{T}^n} \frac{|\nabla_{\vec{a}} \rho^{j\ell}(t, x)|^4}{\Lambda^{4K}} dx$$

For $B \geq 1$ to be chosen later and smooth $\rho : \bar{J} \times \mathbb{T}^3 \rightarrow \mathcal{S}$, define the seminorm

$$\|\rho\|_X = \sup_{t \in \bar{J}} e^{-B\bar{\tau}^{-1}|t-t_0|} E_L[\rho(t)]^{1/4}$$

Let T be the map such that $\rho_{(k+1)} = T[\rho_{(k)}]$, which is defined by solving (A.6). We want to show that T is a contraction on $C_t W_x^{L,4}$ if one takes the appropriate norm. Let $\rho, \tilde{\rho} : J \times \mathbb{T}^3 \rightarrow \mathcal{S}$ be smooth $(2, 0)$ tensor fields. Then differentiating equation (A.6) for the difference $T[\rho] - T[\tilde{\rho}]$ and commuting using (A.7), one obtains that for all $1 \leq |\vec{a}| \leq L$ and all $t \in \bar{J}$,

$$\|(\partial_t + v \cdot \nabla) \nabla_{\vec{a}} [T[\rho] - T[\tilde{\rho}]]\|_{L^4(\mathbb{T}^n)} \leq C_{|\vec{a}|} \Lambda^{|\vec{a}|} \bar{\tau}^{-1} (E_L[\rho - \tilde{\rho}]^{1/4} + E_L[T[\rho] - T[\tilde{\rho}]]^{1/4}) \tag{A.8}$$

The computation follows as in the a priori estimate in [Ise17, Propositions 27.1-27.2]. A key input in this estimate is the fact that $\nabla \mathcal{R}^{j\ell}$ acts as a bounded operator on $L^4(\mathbb{T}^3)$, which follows from the Calderon-Zygmund theory on \mathbb{R}^3 as discussed in [Ise17, Proposition 6.2].

Applying (A.8) and using (in a non-essential way) that $\nabla_i v^i = 0$,

$$\begin{aligned} \frac{d}{dt} E_L [T[\rho](t) - T[\tilde{\rho}](t)] &= \sum_{K=1}^L \sum_{j,\ell=1}^3 \sum_{|\bar{\alpha}|=K} \Lambda^{-4K} \int_{\mathbb{T}^n} (\partial_t + v \cdot \nabla) |\nabla_{\bar{\alpha}} [T[\rho]^{j\ell} - T[\tilde{\rho}]^{j\ell}]|^4(t, x) dx \\ \left| \frac{d}{dt} E_L [T[\rho](t) - T[\tilde{\rho}](t)] \right| &\stackrel{(A.8)}{\leq} C_L \bar{\tau}^{-1} (E_L[\rho - \tilde{\rho}]^{1/4} + E_L[T[\rho] - T[\tilde{\rho}]]^{1/4}) E_L [T[\rho] - T[\tilde{\rho}]]^{\frac{3}{4}} \\ &\leq C_L \bar{\tau}^{-1} (E_L[\rho(t) - \tilde{\rho}(t)] + E_L [T[\rho](t) - T[\tilde{\rho}](t)]) \end{aligned} \quad (A.9)$$

$$\left| \frac{d}{dt} E_L [T[\rho](t) - T[\tilde{\rho}](t)] \right| \leq C_L \bar{\tau}^{-1} e^{4B\bar{\tau}^{-1}|t-t_0|} (\|\rho - \tilde{\rho}\|_X^4 + \|T[\rho] - T[\tilde{\rho}]\|_X^4) \quad (A.10)$$

In line (A.9), we applied Young's inequality with the exponents $\frac{1}{4} + \frac{3}{4} = 1$. Integrating the above estimate from $t = t_0$ and observing that $E_L [T[\rho](t_0) - T[\tilde{\rho}](t_0)] = 0$, we obtain

$$\begin{aligned} E_L [T[\rho](t) - T[\tilde{\rho}](t)] &\leq \frac{C_L}{4B} e^{4B\bar{\tau}^{-1}|t-t_0|} (\|\rho - \tilde{\rho}\|_X^4 + \|T[\rho] - T[\tilde{\rho}]\|_X^4) \\ \|T[\rho] - T[\tilde{\rho}]\|_X^4 &\leq \frac{C_L}{4B} \|\rho - \tilde{\rho}\|_X^4 + \frac{C_L}{4B} \|T[\rho] - T[\tilde{\rho}]\|_X^4 \end{aligned} \quad (A.11)$$

Choosing B large enough, the last term in (A.11) can be subtracted from both sides and we obtain that

$$\|T[\rho] - T[\tilde{\rho}]\|_X \leq \frac{1}{2} \|\rho - \tilde{\rho}\|_X \quad (A.12)$$

It is also true that for all $t \in \bar{J}$

$$\int_{\mathbb{T}^3} (T[\rho]^{j\ell}(t, x) - T[\tilde{\rho}]^{j\ell}(t, x)) dx = 0. \quad (A.13)$$

Equation (A.13) follows from the following conservation law, which uses $\nabla_i v^i = 0$ and (A.6):

$$\frac{d}{dt} \int_{\mathbb{T}^n} T[\rho]^{j\ell}(t, x) dx = \int_{\mathbb{T}^n} (\partial_t + v \cdot \nabla) T[\rho]^{j\ell}(t, x) dx = 0.$$

Combining (A.12) and (A.13), we see that T is a contraction on the space of $C_t W_x^{L,4}$ tensor fields $\rho : \bar{J} \times \mathbb{T}^3 \rightarrow \mathcal{S}$ when this space is endowed with the norm $\|\rho\| = \sup_{t \in \bar{J}} |\int_{\mathbb{T}^n} \rho(t, x) dx| + \|\rho\|_X$. In particular, the sequence $\rho_{(k)}^{j\ell}$ is Cauchy in $C_t W_x^{L,4}$ and hence Cauchy in $C_t C_x^{L-1}$ on $\bar{J} \times \mathbb{T}^3$ by Sobolev embedding. Since \bar{J} was an arbitrary compact subinterval of J containing t_0 and L was also arbitrary, we conclude that $\rho_{(k)}^{j\ell}$ converges to a limit ρ that exists on all of $J \times \mathbb{T}^3$ and is smooth $\rho \in \bigcap_{k \geq 0} C_t C_x^k$. It also follows that ρ solves the initial value problem (A.5) (as a distribution), from which we also have that $\rho \in C^1(J \times \mathbb{T}^3)$ and $\partial_t \rho \in \bigcap_{k \geq 0} C_t C_x^k$. \square
