Families of quasi-exactly solvable extensions of the quantum oscillator in curved spaces

Abstract

We introduce two new families of quasi-exactly solvable (QES) extensions of the oscillator in a d-dimensional constant-curvature space. For the first three members of each family, we obtain closed-form expressions of the energies and wavefunctions for some allowed values of the potential parameters using the Bethe ansatz method. We prove that the first member of each family has a hidden $sl(2,\mathbb{R})$ symmetry and is connected with a QES equation of the first or second type, respectively. Onedimensional results are also derived from the d-dimensional ones with $d \geq 2$, thereby getting QES extensions of the Mathews-Lakshmanan nonlinear oscillator.

I INTRODUCTION

During many years, there has been a continuing interest in the classical nonlinear oscillator introduced by Mathews and Lakshmanan [\[1\]](#page-28-0) as a one-dimensional analogue of some quantum field theoretical models. Such a nonlinear oscillator is indeed an interesting example of a system endowed with a position-dependent mass and having periodic solutions with an amplitude-dependent frequency. Since the solutions of its quantum version are also well known [\[2,](#page-28-1) [3,](#page-28-2) [4\]](#page-28-3), it is amenable to applications in many areas of physics.

Its two-dimensional (and more generally d-dimensional) classical generalization was in-troduced by Cariñena, Rañada, Santander, and Senthilvelan [\[5\]](#page-28-4), who established that the nonlinearity parameter λ , entering the definitions of the potential and of the positiondependent mass, can be interpreted as $-\kappa$, where κ is the curvature of the space, so that their model actually describes a harmonic oscillator on the sphere (for $\lambda = -\kappa < 0$) or in a hyperbolic space (for $\lambda = -\kappa > 0$). The corresponding quantum model was also exactly solved in two $[6, 7, 8]$ $[6, 7, 8]$ $[6, 7, 8]$, three $[9]$, and d $[10]$ dimensions. It is worth observing that the oscillator in a spherical geometry had already been studied from a Lie algebraic viewpoint more than forty years ago and is known as the Higgs oscillator [\[11,](#page-28-10) [12\]](#page-28-11).

In a recent work $[10]$, some rational extensions of the quantum oscillator in a ddimensional space of constant curvature were constructed. These are also exactly solvable problems, whose bound-state wavefunctions can be written in terms of exceptional orthogonal polynomials (see, e.g., Ref. [\[13\]](#page-28-12) and references quoted therein), instead of classical orthogonal polynomials for the oscillator alone.

Here, we plan to construct other types of extensions leading to quasi-exactly solvable (QES) Schrödinger equations. The latter occupy an intermediate place between exactly solvable and non-solvable ones in the sense that only a finite number of eigenstates can be found explicitly by algebraic means, while the remaining ones remain unknown. The simplest QES problems, discovered in the 1980s, are characterized by a hidden $sl(2,\mathbb{R})$ algebraic structure [\[14,](#page-28-13) [15,](#page-28-14) [16,](#page-28-15) [17,](#page-28-16) [18\]](#page-29-0) and are connected with polynomial solutions of the Heun equation [\[19\]](#page-29-1). Generalizations of this equation are related through their polynomial

solutions to more complicated QES problems. In such cases, to avoid dealing with highorder recursion relations, it is easier to resort to the functional Bethe ansatz method [\[20,](#page-29-2) [21,](#page-29-3) [22\]](#page-29-4), which has proven very effective in such a context [\[23,](#page-29-5) [24,](#page-29-6) [25\]](#page-29-7).

Our purpose is to consider two families of quantum systems with respective potentials $V_m^{(1)}(r)$ and $V_m^{(2)}(r)$, $m = 1, 2, 3, \ldots, 0 < r < r_{\text{max}}$, generalizing the oscillator potential $V_0(r) = V_0^{(1)}$ $V_0^{(1)}(r) = V_0^{(2)}$ $\sigma_0^{(2)}(r)$ in a d-dimensional constant-curvature space, and to obtain exact solutions for them by means of the Bethe ansatz method. Via some small changes, we will also show that our results are applicable to one-dimensional potentials $V_m^{(1)}(x)$ and $V_m^{(2)}(x)$, $m = 1, 2, 3, \ldots, -x_{\text{max}} < x < x_{\text{max}}$, extending the Mathews-Lakshmanan nonlinear oscillator $V_0(x)$.

This paper is organized as follows. In Section II, we review the quantum problem of the oscillator in a d-dimensional constant-curvature space and its bound-state energies and wavefunctions, as well as their one-dimensional counterparts. In Sections III and IV, the two families of potentials $V_m^{(1)}$ and $V_m^{(2)}$ are defined and closed-form solutions are obtained for their first three members. Section V contains the conclusion.

II THE OSCILLATOR IN A CONSTANT-CURVATURE SPACE

In units wherein $\hbar = 2m = 1$, the quantum version of the one-dimensional Mathews-Lakshmanan oscillator is described by the Hamiltonian [\[2,](#page-28-1) [3\]](#page-28-2)

\hat{H} = -(1 + \lambda x^2) \frac{d^2}{dx^2} - \lambda x \frac{d}{dx} + V_0(x), \qquad V_0(x) = \frac{\beta(\beta + \lambda)x^2}{1 + \lambda x^2}, \tag{2.1}
$$

where β plays the role of the frequency ω in the standard oscillator and the nonlinearity parameter $\lambda \neq 0$ enters both the potential energy term $V_0(x)$ and the kinetic energy one, giving rise there to a position-dependent mass. According to whether $\lambda > 0$ or $\lambda < 0$, the range of the coordinate x is $(-\infty, +\infty)$ or $\left(-\frac{1}{\sqrt{|\lambda|}}, \frac{1}{\sqrt{|\lambda|}}\right)$. Such a Hamiltonian is formally self-adjoint with respect to the measure $d\mu = (1 + \lambda x^2)^{-1/2} dx$.

The corresponding Schrödinger equation

is exactly solvable and its bound-state wavefunctions can be expressed in terms of Gegenbauer polynomials as [\[4\]](#page-28-3)

with corresponding energy eigenvalues

Here the range of n values is determined by the normalizability of $\psi_n(x)$ on the appropriate interval with respect to the measure $d\mu$. It is given by

n = \begin{cases} 0, 1, 2, \dots, n_{\text{max}}, & \frac{\beta}{\lambda} - 1 \le n_{\text{max}} < \frac{\beta}{\lambda}, \quad \text{if } \lambda > 0, \\ 0, 1, 2, \dots & \quad \text{if } \lambda < 0. \end{cases} \tag{2.5}
$$

For $d \geq 2$, the d-dimensional generalization of Hamiltonian (2.1) can be written as [\[6,](#page-28-5) [7,](#page-28-6) [8,](#page-28-7) [9,](#page-28-8) [10\]](#page-28-9)

where $\hat{\Delta}$ denotes the Laplacian in a *d*-dimensional Euclidean space, $r^2 \equiv \sum_i x_i^2$, $\hat{J}^2 \equiv$ $\sum_{i < j} \hat{J}_{ij}^2$, \hat{J}_{ij} is an angular momentum component, and i, j run over $1, 2, ..., d$. The corresponding Schrödinger equation is separable in hyperspherical coordinates and gives rise to the radial equation

where \hat{J}^2 has been replaced by its eigenvalues $l(l+d-2), l = 0, 1, 2, \ldots$ The variable r runs over $(0, +\infty)$ or $(0, 1/\sqrt{|\lambda|})$ according to whether $\lambda > 0$ or $\lambda < 0$ and the differential oper-ator in [\(2.7\)](#page-3-0) is formally self-adjoint with respect to the measure $d\mu = (1 + \lambda r^2)^{-1/2} r^{d-1} dr$.

Equation [\(2.7\)](#page-3-0) is exactly solvable and its bound-state solutions can be expressed in terms of Jacobi polynomials as [\[10\]](#page-28-9)

with corresponding energy eigenvalues

E_n = \beta(2n + d) - \lambda n(n + d - 1), \qquad n = 2n_r + l. \tag{2.9}

Here the range of n values is determined by the normalizability of the radial wavefunctions $\psi_{n_r,l}(r)$ on the appropriate interval with respect to the measure $d\mu$ and is given by

n = \begin{cases} 0, 1, 2, \dots, n_{\text{max}}, & \frac{\beta}{\lambda} - \frac{d+1}{2} \le n_{\text{max}} < \frac{\beta}{\lambda} - \frac{d-1}{2}, & \text{if } \lambda > 0, \\ 0, 1, 2, \dots & \text{if } \lambda < 0. \end{cases} \tag{2.10}
$$

At this stage, it is worth observing that the potentials $V_0(x)$ and $V_0(r)$ may be rewritten as

V_0(x) = \lambda A - \frac{\lambda A}{1 + \lambda x^2}, \qquad V_0(r) = \lambda A - \frac{\lambda A}{1 + \lambda r^2}, \tag{2.11}

where, in both cases, $A = \frac{\beta}{\lambda}$ $\frac{\beta}{\lambda}$ ($\frac{\beta}{\lambda}$ + 1). It is the form [\(2.11\)](#page-4-0) that we will adopt in Sections III and IV.

Furthermore, we may retrieve the one-dimensional results, contained in Eqs. (2.2) – (2.5) , from the d-dimensional ones, given in Eqs. $(2.7)-(2.10)$ $(2.7)-(2.10)$, by performing the changes

with p related to the parity $(-1)^p = +1, -1$, and by extending the range of the variable from $(0, +\infty)$ or $(0, 1/\sqrt{|\lambda|})$ to $(-\infty, +\infty)$ or $(-1/\sqrt{|\lambda|}, 1/\sqrt{|\lambda|})$ according to the sign of λ . From Eqs. (22.5.22) and (22.5.21) of Ref. [\[26\]](#page-29-8), we indeed note that after such substitutions, $P_{n_r}^{\left(l+\frac{d-2}{2},-\frac{\beta}{\lambda}-\frac{1}{2}\right)}(1+2\lambda r^2)$ becomes

so that Eq. [\(2.3\)](#page-3-2) directly follows from Eq. [\(2.8\)](#page-3-3).

Since a similar replacement is valid for the extended potentials to be considered in Sections III and IV, we will only write there the d-dimensional results explicitly.

III FIRST FAMILY OF QES POTENTIALS

In Eq. [\(2.7\)](#page-3-0), let us replace the potential $V_0(r)$ by a potential of the family

where $A, B_1, B_2, \ldots, B_{2m}$ are $2m + 1$ parameters and the range of the variable r is the same as in Section II. In the resulting equation, let us make the changes of variable and of function

where $0 < z < 1$ if $\lambda > 0$ or $1 < z < \infty$ if $\lambda < 0$. This yields the following differential equation for $\tilde{\psi}(z)$,

After a brief inspection of Eq. [\(3.3\)](#page-5-0), we make the transformation

in terms of $m + 1$ parameters a, b_1, b_2, \ldots, b_m , related to the previous ones. The resulting equation

looks rather complicated, but can be drastically simplified when considering the first few m values, as we will now proceed to show.

A First potential of the first family

For the first potential of the family

V_1^{(1)}(r) = \lambda A - \frac{\lambda A}{1 + \lambda r^2} + \lambda B_1 (1 + \lambda r^2) + \lambda B_2 (1 + \lambda r^2)^2

and the gauge transformation

Eq. [\(3.6\)](#page-5-1) reduces to

Provided some additional constraints are satisfied, the latter has exact solutions that are nth-degree polynomials in z,

with distinct roots z_i , $i = 1, 2, ..., n$. Substituting [\(3.12\)](#page-6-0) into [\(3.11\)](#page-6-1) and applying the functional Bethe ansatz method [\[22,](#page-29-4) [24,](#page-29-6) [25\]](#page-29-7), outlined in the Appendix, we obtain

where the roots z_i satisfy the Bethe ansatz equations

The corresponding wavefunctions

are normalizable with respect to the measure $d\mu = (1 + \lambda r^2)^{-1/2} r^{d-1} dr$ provided $b_1 > 0$ if $\lambda > 0$ or $a < \frac{1}{4} - n$ if $\lambda < 0$.

As examples of the above general expressions of the exact solutions, let us consider the first two *n* values. For $n = 0$, we get

provided Δ is real. The function $\psi_{0,l}(r)$ having no node for the allowed values of r represents a ground state, while $\psi_{1,l}(r)$ may describe a ground or first-excited state according to the value taken by z_1 .

It is worth observing that Eq. [\(3.11\)](#page-6-1) being of Heun type, the differential equation corresponding to $V_1^{(1)}$ $I_1^{(1)}(r)$ with the constraints [\(3.10\)](#page-6-2) and $A = (2a + 2n)(2a + 2n + 1)$ has a hidden sl(2, \mathbb{R}) symmetry. It can indeed be rewritten in terms of an element of the sl(2, \mathbb{R}) enveloping algebra acting on $\phi_n(z)$,

are differential operator realizations of the $sl(2,\mathbb{R})$ generators in the $(n + 1)$ -dimensional representation spanned by $\mathcal{P}_{n+1} = (1, z, z^2, \dots, z^n)$. On taking into account that $J_n^+ z^k =$ $(k - n)z^{k+1}, J_n^0 z^k = (k - \frac{n}{2})$ $(\frac{n}{2}) z^k$, $J_n^- z^k = k z^{k-1}$, it is straightforward to write the matrix of the differential operator on the left-hand side of [\(3.20\)](#page-8-0) explicitly. Its diagonalization then provides the admissible energies ϵ_n and corresponding eigenfunctions $\phi_n(z)$. In this way it is possible to rederive the results contained in Eqs. $(3.16)-(3.19)$ $(3.16)-(3.19)$. In the terminology used for QES problems with a hidden $sl(2,\mathbb{R})$ symmetry [\[18\]](#page-29-0), the Schrödinger equation corresponding to the potential $V_1^{(1)}$ $T_1^{(1)}(r)$ is a QES equation of the first type, the parameter ϵ in Eq. (3.3) playing the role of energy E (see Eq. (3.4)).

B Second potential of the first family

For the second potential of the family

As mentioned in Section II for the oscillator alone, the one-dimensional case on the real line for the extended oscillator can be easily retrieved from the d-dimensional one on the half-line for $d \geq 2$ by applying [\(2.12\)](#page-4-2) and extending the range of the variable accordingly. In the transformed wavefunctions, $p = 0, 1$ is related to the parity $(-1)^p = +1, -1$. The normalization conditions with respect to the measure $d\mu = (1 + \lambda x^2)^{-1/2} dx$ remain the same as in $d \ge 2$ dimensions with respect to the measure $d\mu = (1 + \lambda r^2)^{-1/2} r^{d-1} dr$.

For instance, for the first potential $V_1^{(1)}$ $\binom{r^{(1)}}{1}(x)$, with the constraints

In Fig. 1, some examples of extended potentials are plotted and compared with $V_0(x)$ for $\lambda > 0$. The corresponding wavefunctions are displayed in Fig. 2. Figures 3 and 4 show similar comparisons in the $\lambda < 0$ case.

IV SECOND FAMILY OF QES POTENTIALS

Instead of $V_0(r)$ in Eq. [\(2.7\)](#page-3-0), let us now consider a potential of the family

In the terminology used for QES problems with a hidden $sl(2,\mathbb{R})$ symmetry [\[18\]](#page-29-0), the Schrödinger equation corresponding to the potential $V_1^{(2)}$ $T_1^{(2)}(r)$ is a QES equation of the second type: the parameter ϵ , related to the energy E , is fixed through Eq. [\(4.4\)](#page-14-1) and one of the potential parameters, namely A , plays the role of the eigenvalue. This is actually a generalization of the Sturm representation for the Coulomb problem, where the energy is fixed and the charge is quantized.

E_{n,l} = \lambda \Big[2a(4n + 2l + d) + 2n(2n + 1) + 2b_1 \Big(4a + 4n - 2l - d + 3 - 4 \sum_{i} z_i \Big) -16b_2 \Big(\sum_{i} z_i^2 - \sum_{i} z_i \Big) - l(l + d - 1) \Big],\tag{4.25}

together with the normalization condition $2a > l + \frac{d-1}{2}$ $\frac{-1}{2}$ if $\lambda > 0$ or $b_2 > 0$ if $\lambda < 0$.

D The one-dimensional case

To get the one-dimensional results from the $d \geq 2$ ones, we proceed as in Section IIID. The only notable difference is a change in the normalization conditions, which now become $2a > p$ if $\lambda > 0$ or $b_m > 0$ if $\lambda < 0$.

As an example, for the first potential $V_1^{(2)}$ $\zeta_1^{(2)}(x)$, with the constraints

A = 2a(2a+1) + 4b1(2a+1-p), \qquad B1 = 2b1(4a+2b1+3), \qquad B2 = -4b12, \qquad (4.44)
$$

we obtain from [\(4.14\)](#page-17-1)

\psi_{0,p}(x) \propto x^p (1 + \lambda x^2)^{-a} \exp\left(-\frac{b_1}{1 + \lambda x^2}\right),

with $2a > p$ if $\lambda > 0$ or $b_1 > 0$ if $\lambda < 0$. These energy and wavefunction correspond to a ground state for $p = 0$ or to a first-excited state for $p = 1$.

In Fig. 5, some examples of extended potentials are plotted for $\lambda > 0$, the corresponding wavefunctions being displayed in Fig. 6. Figures 7 and 8 show similar comparisons in the $\lambda < 0$ case.

V CONCLUSION

In the present paper, we have discussed bound-state solutions to two families of quantum potentials extending the harmonic oscillator in a d-dimensional constant-curvature space.

We showed that the corresponding radial Schrödinger equation for the first three members of both families is reducible to a QES differential equation. Using the Bethe ansatz approach, we obtained closed-form expressions for the energies and wavefunctions of each potential for some allowed values of its parameters. We also proved that the first member of the two families has a hidden $sl(2,\mathbb{R})$ symmetry and is connected with a QES equation of the first or second type, respectively.

Furthermore, from the d-dimensional radial outcomes, we showed how to derive onedimensional results valid on the line. In this way, we also obtained two families of QES extensions of the Mathews-Lakshmanan oscillator. It is hoped that our findings will lead to new applications for these nonlinear oscillators.

APPENDIX: THE FUNCTIONAL BETHE ANSATZ METHOD

Let us consider the second-order differential equation

where $P(z)$, $Q(z)$, and $W(z)$ are polynomials in z of degree at most $t + 2$, $t + 1$, and t, respectively,

P(z) = \sum_{k=0}^{t+2} p_k z^k, \qquad Q(z) = \sum_{k=0}^{t+1} q_k z^k, \qquad W(z) = \sum_{k=0}^{t} w_k z^k,
$$

 p_k , q_k , and w_k being some constants. The functional Bethe ansatz method [\[22,](#page-29-4) [23,](#page-29-5) [24,](#page-29-6) [25\]](#page-29-7) enables one to find under which conditions $Eq. (A.1)$ $Eq. (A.1)$ admits polynomial solutions of type (3.12) . In the present paper, it will be enough to consider the $t = 3$ case.

On substituting $\phi(z) = \prod_{i=1}^n (z - z_i)$ with distinct roots z_i into Eq. [\(A.1\)](#page-24-0), the latter becomes
