Existence theorems for the Cauchy problem of 2D nonhomogeneous incompressible non-resistive MHD equations with vacuum

Abstract

In this paper, we investigate the Cauchy problem of the nonhomogeneous incompressible non-resistive MHD on \mathbb{R}^2 with vacuum as far field density and prove that the 2D Cauchy problem has a unique local strong solution provided that the initial density and magnetic field decay not too slow at infinity. Furthermore, if the initial data satisfy some additional regularity and compatibility conditions, the strong solution becomes a classical one.

Keywords: 2D nonhomogeneous incompressible non-resistive MHD equations; vacuum; classical solutions

1 Introduction

Nonhomogeneous incompressible non-resistive magnetohydrodynamics (MHD) equations in \mathbb{R}^2 express as follows:

with the initial triplet

and far field behaviors (in some weak sense)

Here $\rho = \rho(t, \mathbf{x})$, $\mathbf{u} = (\mathbf{u}_1, \mathbf{u}_2)(t, \mathbf{x})$, $\mathbf{H} = (\mathbf{H}_1, \mathbf{H}_2)(t, \mathbf{x})$ and $\pi = \pi(t, \mathbf{x})$ represent the unknown density, velocity, magnetic and pressure of the fluid, respectively. $\mu > 0$ stands for the viscosity coefficient.

Magnetohydrodynamics equations describe the motion of conducting fluids in an electromagnetic field, which has a very broad range of applications. Since the dynamic motion of the fluid and the magnetic field interact deeply on each other, the hydrodynamic and electrodynamic effects are strongly coupled, which were stated in [\[2,](#page-23-0)[18\]](#page-24-0) and references therein.

Note that if $H = 0$, the MHD system [\(1.1\)](#page-0-0) reduces to the well-known nonhomogeneous incompressible Navier-Stokes equations, which have been discussed in [\[1,](#page-23-1) [7](#page-23-2)[–9,](#page-23-3) [14,](#page-24-1) [16,](#page-24-2) [17,](#page-24-3) [20,](#page-24-4) [22,](#page-24-5) [25,](#page-24-6) [29\]](#page-24-7) and references therein, while nonhomogeneous incompressible MHD equations have been studied and obtained a few results by many mathematicians in $[6, 23, 24, 28]$ $[6, 23, 24, 28]$ $[6, 23, 24, 28]$ $[6, 23, 24, 28]$ and references therein. As far as the system (1.1) is concerned, it is called the viscous and non-resistive incompressible MHD equations, which describe the conducting fluids with a very high conductivity and the third equation of the system (1.1) means that the magnetic field move along exactly with the fluid, rather that simple diffusing out. The viscous and non-resistive incompressible MHD equations are established on the physical background in $[2, 3, 12, 18]$ $[2, 3, 12, 18]$ $[2, 3, 12, 18]$ $[2, 3, 12, 18]$ and references therein.

There are many results concerning with the multi-dimensional incompressible MHD. For instance, as $\rho \equiv$ constant, i.e., (1.1) is called homogeneous incompressible nonresistive MHD. Jiu and Niu [\[15\]](#page-24-11) established the local existence of solutions in 2D as the initial data in H^s for integer $s \geq 3$. In the remarkable work [\[21\]](#page-24-12), Lin et al. proved the existence of global-in-time solutions for initial data sufficiently close to certain equilibrium solutions in two dimensional Lagrangian coordinates by the modern analysis techniques. Ren et al. [\[27\]](#page-24-13) improved the results in [\[21\]](#page-24-12) without imposing some admissible conditions for initial data and confirmed that the energy of the MHD equations is dissipated at a rate independent of the ohmic resistivity. In 3D periodic domain, Pan et al. [\[26\]](#page-24-14) established the the global existence of classical solutions to incompressible viscous magneto-hydrodynamical system with zero magnetic diffusion if the initial magnetic field is close to an equilibrium state and the initial data have some symmetries. Fefferman et al. [\[10\]](#page-23-7) improved that results of [\[15\]](#page-24-11) to d-dimensional space and then in [\[11\]](#page-23-8) presented an inspiring local-in-time existence and uniqueness solutions in nearly optimal Sobolev space in \mathbb{R}^d ($d = 2, 3$) for $H_0 \in H^s(\mathbb{R}^d)$ and $\mathbf{u}_0 \in H^{s-1+\varepsilon}(\mathbb{R}^d)$ with $s > d/2$ and $0 < \varepsilon < 1$. It is worth noting that Chemin et al. [\[4\]](#page-23-9) proved the local existence in Besov spaces with less regularity assumptions on \mathbf{u}_0 than that of H_0 due to the existence of the diffusive term in the momentum equations, precisely, $\mathbf{u}_0 \in B_{2,1}^{d/2-1}$ $_{2,1}^{d/2-1}(\mathbb{R}^d)$ and $\mathbf{H}_0 \in B_{2,1}^{d/2}$ $_{2,1}^{d/2}$ (\mathbb{R}^{d}).

It is also an important issue to study the fluid equations with vacuum as far field density. Recently, Li et al. [\[19\]](#page-24-15) proved the local existence of strong/classical solutions to the 2-D Cauchy problem of the compressible Navier-Stokes equations on the whole plane \mathbb{R}^2 with vacuum as far field density. With the aid of [\[19\]](#page-24-15), Liang [\[20\]](#page-24-4) and Lv et al. [\[23–](#page-24-8)[25\]](#page-24-6) have obtained the well-posedness for the flows with vacuum as field density, such as nonhomogeneous incompressible Navier-Stokes and the nonhomogeneous incompressible MHD equations with resistive term. However, there are few results about the non-homogeneous incompressible MHD equations without resistive term, specially, the initial density may have compact support. Therefore, we try to discuss on the well-posedness of classic solutions to the system [\(1.1\)](#page-0-0) and then obtain the following existence theorems.

Theorem 1.1 Let η_0 be a positive constant and define

denote

where $1 \leq r \leq \infty$. For constants $q > 2$ and $a > 1$, assume that the initial triplet $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$ satisfy that

Then there exists a positive time $T_0 > 0$ such that the problem (1.1) – (1.3) has a unique strong solution quaternion $(\varrho, \mathbf{u}, \pi, \mathbf{H})$ on $\mathbb{R}^2 \times (0, T_0]$ with div $\mathbf{u} = 0$ and div $\mathbf{H} = 0$, satisfying that

for some constant $N > 0$ and $B_N \triangleq {\mathbf{x} \in \mathbb{R}^2 | \vert \mathbf{x} \vert < N}$.

Moreover, if the initial data $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$ satisfy some additional regularity and compatibility condition, the local strong solution $(\rho, \mathbf{u}, \pi, \mathbf{H})$ obtained in Theorem [1.1](#page-1-0) becomes a classical one, that is,

Theorem 1.2 In addition to (1.5) , suppose that

for some constant $\delta_0 \in (0,1)$. Moreover, assume that the following compatibility condition holds for some $g \in L^2$,

Then, in addition to [\(1.6\)](#page-2-1) and [\(1.7\)](#page-2-2), the strong solution $(\varrho, \mathbf{u}, \pi, \mathbf{H})$ obtained in Theorem [1.1](#page-1-0) satisfies

As far as our existence results are concerned, it is easy to find that as $H = 0$, Theorem [1.1](#page-1-0) is similar to the existence ressult in [\[20\]](#page-24-4). While absenting the more assumptions for initial data as in [\[21\]](#page-24-12) or [\[27\]](#page-24-13) and excluding the higher derives of \bf{H} in the model [\(1.1\)](#page-0-0), it is possible not to expect to obtain the global-in-time solution which is the same to the ones for nonhomogeneous Navier-Stokes equations [\[25\]](#page-24-6), and resistive MHD equations [\[23\]](#page-24-8), but to establish a simple criterion depending only on H , with the motivation of the ideas in [\[5\]](#page-23-10), [\[25\]](#page-24-6) and [\[30\]](#page-25-0), precisely,

where $r > 2$ and T^* is the maximal time of existence local classical solutions. For above claim, we just state it here without giving proof in detail.

In order to check the existence theorems, i.e. Theorem [1.1](#page-1-0) and Theorem [1.2,](#page-2-3) we manage to overcome the following difficulties. Firstly, in the plane, when the far fireld density is vacuum, there is immediate difference between 2D case and 3D one, more precisely, the L^p -norm of **u** could not be bounded directly by the L^2 -norms of $\sqrt{\varrho}$ **u** and ∇ **u**. Therefore, it means that the methods successfully used in [\[6–](#page-23-4)[8\]](#page-23-11) can not be simply applied to our model. Utilizing the remarkable techniques in [\[19,](#page-24-15) [20,](#page-24-4) [22,](#page-24-5) [23\]](#page-24-8), we still treat the strong coupling term between the velocity vector field and the magnetic field, such as the terms $\mathbf{u} \cdot \nabla \mathbf{H}$ and $(\nabla \times \mathbf{H}) \times \mathbf{H}$ and so on. To end it, one will borrow some ideas from [\[23\]](#page-24-8), and establishes the spatial weighted estimates for the magnetic fields and the density. Secondly, there is another difficulty caused by the lack of resistive term in magnetic equation $(1.1)_3$. It is impossible to infer the estimates for higher order derivatives of magnetic fields "H" and " ∇ H". However, due to div $H = 0$, let $\mathbf{H} = (\partial_2 \phi, -\partial_1 \phi)$ for some potential ϕ . It is easy to see that the equation (1.1) ₃ can be written as

which shows that there is the same structure between the equation $(1.1)₁$ and $(1.1)₃$. Whence the techniques to the estimates for the magnetic fields could be a homology with the one for the density, and then one can succeed in obtaining the same regular estimates for the magnetic fields and the density.

The rest of the paper is organized as follows: In Section 2, we collect some elementary facts and inequalities which will be needed in later analysis. Sections 3 and 4 are devoted to the a priori estimates which are needed to obtain the local existence and uniqueness of strong/classical solutions. The main results: Theorem [1.1](#page-1-0) and [1.2](#page-2-3) are proved in Section 5.

2 Preliminaries

First, the following local existence theory on bounded balls, where the initial density is strictly away from vacuum, can be shown by similar arguments as in $[6-8]$ $[6-8]$.

Lemma 2.1 For $R > 0$ and $B_R = {\mathbf{x} \in \mathbb{R}^2 | \mathbf{x} | < R}$, assume that the triplet $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$, satisfies

Then there exist a small time $T_R > 0$ and a unique classical solution $(\varrho, \mathbf{u}, \pi, \mathbf{H})$ to the following initial-boundary-value problem

\mathbf{u} = 0, \mathbf{x} \in \partial B_R, \quad t > 0, \\
(\varrho, \mathbf{u}, \mathbf{H})(0, \mathbf{x}) = (\varrho_0, \mathbf{u}_0, \mathbf{H}_0)(\mathbf{x}), \quad \mathbf{x} \in B_R,\n\end{cases}

on $B_R \times [0, T_R]$ such that

where we denote $L^2 = L^2(B_R)$ and $H^k = H^k(B_R)$ for some positive integer k.

Then, for either $\Omega = \mathbb{R}^2$ or $\Omega = B_R$ with $R \geq 1$, the following weighted L^p -bounds for elements of Hilbert space $\tilde{D}^{1,2}(\Omega) \triangleq \{v \in H^1_{loc}(\Omega) | \nabla v \in L^2(\Omega) \}$ will play a crucial role in our analysis, which can be found in [\[20,](#page-24-4) Lemma 2.3].

Lemma 2.2 Let \bar{x} be as in [\(1.5\)](#page-2-0) and $\Omega = \mathbb{R}^2$ or $\Omega = B_R$ with $R \ge 1$. Suppose that $\rho \in L^1(\Omega) \cap L^{\infty}(\Omega)$ is a non-negative function such that

for some positive constants M_1 , M_2 and $N_1 \geq 1$ with $B_{N_1} \subset \Omega$. Then, for $\varepsilon > 0$ and $\eta > 0$, there is a positive constant C depending solely on ε , η , M_1 , M_2 , N_1 and η_0 such that any $\mathbf{v} \in \tilde{D}^{1,2}(\Omega)$ satisfies

Next, we consider the following Stokes system,

The proof of the following L^p -bound can be found in [\[13,](#page-23-12) Theorem IV.6.1].

Lemma 2.3 Let $\mathbf{u} \in W^{1,q}_0$ $\int_0^{1,q}(B_R)$ be a weak solution of the system [\(2.6\)](#page-4-0), where $q>1$. If $F \in W^{k,q}(B_R)$ for $k \geq 0$, then $\mathbf{u} \in W^{k+2,q}(B_R)$ and

3 A priori estimates (I)

In this section and the next, for $p \in [1,\infty]$ and $k \geq 0$, we denote

Moreover, for $R > 4N_0 \geq 4$, we assume that the smooth triplet $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$ satisfies, in addition to [\(2.1\)](#page-3-0), that

It follows from Lemma [2.1](#page-3-0) that there exists some $T_R > 0$ such that the initial-boundary-value problem [\(2.2\)](#page-4-1) has a unique classical solution ($\varrho, \mathbf{u}, \pi, \mathbf{H}$) on $B_R \times [0, T_R]$ satisfying [\(2.3\)](#page-4-2). For $\bar{\mathbf{x}}, \eta_0, a$ and q as in Theorem [1.1,](#page-1-0) the main aim of this section is to derive the following key a priori estimate on $\phi(t)$ defined by

Proposition 3.1 Assume that $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$ satisfies [\(2.1\)](#page-3-0) and [\(3.1\)](#page-5-0). Let $(\varrho, \mathbf{u}, \pi, \mathbf{H})$ be the solution to the initial-boundary-value problem [\(2.2\)](#page-4-1) on $B_R \times (0, T_R)$ obtained by Lemma [2.1.](#page-3-0) Then there exist positive constants T_0 and M both depending solely on μ, q, a, η_0, N_0 and C_0 such that

C_0 = \|\sqrt{\varrho_0} \mathbf{u}_0\|_{L^2} + \|\nabla \mathbf{u}_0\|_{L^2} + \|\mathbf{H}_0\|_{L^2} + \|\mathbf{H}_0\bar{\mathbf{x}}^a\|_{H^1 \cap W^{1,q}} + \|\varrho_0\bar{\mathbf{x}}^a\|_{L^1 \cap H^1 \cap W^{1,q}}.
$$

The proof of Proposition [3.1](#page-5-1) will be postponed at the end of this section. First, we start with the following energy estimate for $(\varrho, \mathbf{u}, \pi, \mathbf{H})$ and preliminary L^2 -bounds for ∇u.

Lemma 3.2 Let $(\varrho, \mathbf{u}, \pi, \mathbf{H})$ be a smooth solution to the initial-boundary-value problem [\(2.2\)](#page-4-1). Then there exist a positive constant $\alpha = \alpha(q) > 1$ and $aT_1 = T_1(C_0, N_0) > 0$ such that for all $t \in (0, T_1]$,

where in the last inequality we have used

due to $(2.2)_1$ and $(2.2)_4$. Integrating (3.7) over $(0, T_1)$ shows

\leq C \phi^{\alpha}(t),

which implies

\sup_{0 \le s \le t} \|\varrho \bar{\mathbf{x}}^a\|_{L^1} \le C \exp\left(C \int_0^t \phi^\alpha(s) ds\right). \tag{3.10}

By calculation from [\(3.10\)](#page-6-3) and [\(3.9\)](#page-6-2), we conclude that

= -2\frac{d}{dt} \int (\mathbf{H} \cdot \nabla) \mathbf{u} \cdot \mathbf{H} d\mathbf{x} + 2 \int ((\mathbf{H} \cdot \nabla) \mathbf{u} \cdot \nabla) \mathbf{u} \cdot \mathbf{H} d\mathbf{x}
$$

-2 \int ((\mathbf{u} \cdot \nabla) \mathbf{H} \cdot \nabla) \mathbf{u} \cdot \mathbf{H} d\mathbf{x}
$$

$$
+ 2 \int (\mathbf{H} \cdot \nabla) \mathbf{u} \cdot (\mathbf{H} \cdot \nabla) \mathbf{u} d\mathbf{x} - 2 \int (\mathbf{H} \cdot \nabla) \mathbf{u} \cdot (\mathbf{u} \cdot \nabla) \mathbf{H} d\mathbf{x}.

$$

\n
$$
\leq C \phi^{\alpha}(t) + \varepsilon \phi^{-1}(t) \|\nabla^{2} \mathbf{u}\|_{L^{2}}^{2}.
$$

Substituting the above two estimates into [\(3.15\)](#page-7-0), we have given

To estimate the last term on the right-hand side of [\(3.17\)](#page-7-2), it follows from [\(2.7\)](#page-4-4) with $F = \varrho \mathbf{u}_t + \varrho \mathbf{u} \cdot \nabla \mathbf{u} + \mathbf{H} \cdot \nabla \mathbf{H}$ that for $p \in [2, q],$

\leq C \int \varrho |\mathbf{u}| |\mathbf{u}_t| \left(|\nabla \mathbf{u}_t| + |\nabla \mathbf{u}|^2 + |\mathbf{u}| |\nabla^2 \mathbf{u}| \right) d\mathbf{x} + C \int \varrho |\mathbf{u}|^2 |\nabla \mathbf{u}| d\mathbf{x}

+ C \int \varrho |\mathbf{u}_t|^2 |\nabla \mathbf{u}| d\mathbf{x} + C \int |\mathbf{H}| |\mathbf{H}_t| |\nabla \mathbf{u}_t| d\mathbf{x}.

5 Proofs of main theorems

With all the a priori estimates obtained in Section 3 and 4 at hand, now we are ready to prove the main results of this paper in this section.

Proof of Theorem [1.1.](#page-1-0) Let $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$ be as in Theorem 1.1. Without loss of generality, we assume that the initial density ϱ_0 satisfies

\tilde{\mathbf{x}}\tilde{\varrho}^R \to \bar{\mathbf{x}}\tilde{\mathbf{H}}^R \to \bar{\mathbf{x}}\tilde{\mathbf{H}}, \quad \text{in } C(\overline{B_N} \times [0, T_0]), \text{ for any } N > 0,

\tilde{\mathbf{x}}\tilde{\mathbf{H}}^R \to \bar{\mathbf{x}}\tilde{\mathbf{H}}, \quad \text{in } C(\overline{B_N} \times [0, T_0]), \text{ for any } N > 0,

\bar{\mathbf{x}}^a \tilde{\varrho}^R \rightharpoonup \bar{\mathbf{x}}^a \varrho, \quad \bar{\mathbf{x}}^a \tilde{\mathbf{H}}^R \rightharpoonup \bar{\mathbf{x}}^a \mathbf{H}, \quad \text{weakly } \ast \text{ in } L^\infty(0, T_0; H^1(\mathbb{R}^2) \cap W^{1,q}(\mathbb{R}^2)), \tag{5.14}

\sqrt{\tilde{\varrho}^R}\tilde{\mathbf{u}}^R \rightharpoonup \sqrt{\varrho} \mathbf{u}, \quad \nabla \tilde{\mathbf{u}}^R \rightharpoonup \nabla \mathbf{u}, \quad \text{weakly } \ast \text{ in } L^{\infty}(0, T_0; L^2(\mathbb{R}^2)), \tag{5.15}
$$

$$
\nabla^2 \tilde{\mathbf{u}}^R \rightharpoonup \nabla^2 \mathbf{u}, \quad \text{weakly in } L^{(q+1)/q}(0, T_0; L^q(\mathbb{R}^2)) \cap L^2((0, T_0) \times \mathbb{R}^2), \tag{5.16}
$$

$$
t^{1/2}\nabla^2 \tilde{\mathbf{u}}^R \rightharpoonup t^{1/2}\nabla^2 \mathbf{u}, \quad \text{weakly in } L^2(0, T_0; L^q(\mathbb{R}^2)),\tag{5.17}
$$

$$
t^{1/2}\sqrt{\tilde{\varrho}^R}\tilde{\mathbf{u}}_t^R \rightharpoonup t^{1/2}\sqrt{\varrho}\mathbf{u}_t, \quad \nabla \tilde{\mathbf{u}}^R \rightharpoonup \nabla \mathbf{u}, \quad \text{weakly } \ast \text{ in } L^\infty(0, T_0; L^2(\mathbb{R}^2)), \tag{5.18}

Then, letting $R \to \infty$, it follows from [\(5.13\)](#page-20-1)–[\(5.20\)](#page-21-0) that $(\varrho, \mathbf{u}, \mathbf{H})$ is a strong solution of (1.1) – (1.3) on $(0, T_0] \times \mathbb{R}^2$ satisfying (1.6) and (1.7) . Therefore, we have got the existence part of Theorem [1.1.](#page-1-0) However, we can mimic the argument for the uniqueness of Theorem 1.1 in [\[23\]](#page-24-8) to obtain the unique result and then we finish the proof of Theorem [1.1.](#page-1-0) \Box

Proof of Theorem [1.2.](#page-2-3) Let $(\varrho_0, \mathbf{u}_0, \mathbf{H}_0)$ be as in Theorem 1.2. Without loss of generality, assume that

$$
\int_{\mathbb{R}^2} \varrho_0 d\mathbf{x} = 1,
$$

which implies that there exists a positive constant N_0 such that [\(5.1\)](#page-19-1) holds. We construct that $\varrho_0^R = \hat{\varrho}_0^R + R^{-1}e^{-|\mathbf{x}|^2}$ where $0 \leq \hat{\varrho}_0^R \in C_0^{\infty}(\mathbb{R}^2)$ satisfies [\(5.2\)](#page-19-2) and

$$
\begin{cases}\n\nabla^2 \hat{\varrho}_0^R \to \nabla^2 \varrho_0, & \text{in } L^q(\mathbb{R}^2), \\
\bar{\mathbf{x}}^{\delta_0} \nabla^2 \hat{\varrho}_0^R \to \bar{\mathbf{x}}^{\delta_0} \nabla^2 \varrho_0, & \text{in } L^2(\mathbb{R}^2),\n\end{cases} (5.21)
$$

as $R \to \infty$. Then, we also choose $\mathbf{H}_0^R \in \{ \mathbf{w} \in C_0^{\infty}(B_R) | \text{div}\mathbf{w} = 0 \}$ satisfying [\(5.3\)](#page-19-3) and

$$
\begin{cases}\n\nabla^2 \mathbf{H}_0^R \to \nabla^2 \mathbf{H}_0, & \text{in } L^q(\mathbb{R}^2), \\
\bar{\mathbf{x}}^{\delta_0} \nabla^2 \mathbf{H}_0^R \to \bar{\mathbf{x}}^{\delta_0} \nabla^2 \mathbf{H}_0, & \text{in } L^2(\mathbb{R}^2),\n\end{cases} \text{ as } R \to \infty.
$$
\n(5.22)

Then, we consider the unique smooth solution \mathbf{u}_0^R of the following Stokes problem

$$
\begin{cases}\n-\mu \triangle \mathbf{u}_0^R + \nabla \pi_0^R = (\nabla \times \mathbf{H}_0^R) \times \mathbf{H}_0^R - \varrho_0^R \mathbf{u}_0^R + \sqrt{\varrho_0^R} \mathbf{h}^R, & \text{in } B_R, \\
\text{div}\mathbf{u} = 0, & \text{in } B_R, \\
\mathbf{u}_0^R = 0, & \text{on } \partial B_R,\n\end{cases}
$$
\n(5.23)

where $\mathbf{h}^R = (\sqrt{\varrho_0} \mathbf{u}_0 + \mathbf{g}) * j_{1/R}$ with j_δ being the standard mollifying kernel of width δ. Multiplying [\(5.23\)](#page-21-1) by \mathbf{u}_0^R and integrating the resultant equation over B_R show that

$$
\|\sqrt{\varrho_0^R} \mathbf{u}_0^R\|_{L^2(B_R)}^2 + \mu \|\nabla \mathbf{u}_0^R\|_{L^2(B_R)}^2
$$

\n
$$
\leq \int_{B_R} |\mathbf{H}_0^R| |\nabla \mathbf{H}_0^R| |\mathbf{u}_0^R| d\mathbf{x} + \|\sqrt{\varrho_0^R} \mathbf{u}_0^R\|_{L^2(B_R)} \|\mathbf{h}^R\|_{L^2(B_R)}
$$

\n
$$
\leq \varepsilon \left(\|\sqrt{\varrho_0^R} \mathbf{u}_0^R\|_{L^2(B_R)}^2 + \|\nabla \mathbf{u}_0^R\|_{L^2(B_R)}^2 \right) + C(\varepsilon),
$$

which implies that

$$
\|\sqrt{\varrho_0^R} \mathbf{u}_0^R\|_{L^2(B_R)}^2 + \|\nabla \mathbf{u}_0^R\|_{L^2(B_R)}^2 \le C,\tag{5.24}
$$

for some constant C independent of R. From (2.7) , we have

$$
\|\nabla^2 \mathbf{u}_0^R\|_{L^2(B_R)} + \|\nabla \pi_0^R\|_{L^2(B_R)}
$$
\n
$$
\leq C \|\|\mathbf{H}_0^R\|\nabla \mathbf{H}_0^R\|_{L^2(B_R)} + C \|\varrho_0^R \mathbf{u}_0^R\|_{L^2(B_R)} + C \|\sqrt{\varrho_0^R} \mathbf{h}^R\|_{L^2(B_R)}
$$
\n
$$
\leq C.
$$
\n(5.25)\n
$$
\leq C.
$$

Next, extending \mathbf{u}_0^R to \mathbb{R}^2 by defining 0 outside B_R and denoting it by $\tilde{\mathbf{u}}_0^R$, we deduce from [\(5.24\)](#page-21-2) and [\(5.25\)](#page-22-0) that

$$
\|\nabla \tilde{\mathbf{u}}_0^R\|_{H^1(\mathbb{R}^2)} \le C,
$$

which with [\(5.21\)](#page-21-3) and [\(5.24\)](#page-21-2) shows that there exists a subsequence $R_j \to \infty$ and a function $\tilde{\mathbf{u}}_0 \in {\tilde{\mathbf{u}}}_0 \in H^2_{loc}(\mathbb{R}^2) | \sqrt{\varrho_0} \tilde{\mathbf{u}}_0 \in L^2(\mathbb{R}^2), \nabla \tilde{\mathbf{u}}_0 \in H^1(\mathbb{R}^2) \}$ and $\tilde{\nabla} \tilde{\pi}_0 \in L^2(\mathbb{R}^2)$ such that

$$
\begin{cases}\n\sqrt{\varrho_0^{R_j}} \tilde{\mathbf{u}}_0^{R_j} \to \sqrt{\varrho_0} \tilde{\mathbf{u}}_0, & \text{weakly in } L^2(\mathbb{R}^2), \\
\nabla \tilde{\mathbf{u}}_0^{R_j} \to \nabla \tilde{\mathbf{u}}_0, & \text{weakly in } H^1(\mathbb{R}^2), \\
\nabla \pi_0^R \to \nabla \tilde{\pi}_0, & \text{weakly in } L^2(\mathbb{R}^2).\n\end{cases}
$$
\n(5.26)

It is easy to check that $\tilde{\mathbf{u}}_0^R$ satisfies [\(5.23\)](#page-21-1), then one can deduce from [\(5.21\)](#page-21-3), [\(5.22\)](#page-21-4), (5.23) and (5.26) that the pair $(\tilde{\mathbf{u}}_0, \tilde{\pi}_0)$ satisfies

$$
-\mu \triangle \tilde{\mathbf{u}}_0 + \nabla \tilde{\pi}_0 + \varrho_0 \tilde{\mathbf{u}}_0 = (\nabla \times \mathbf{H}_0^R) \times \mathbf{H}_0^R + \varrho_0 \mathbf{u}_0 + \sqrt{\varrho_0} \mathbf{g},
$$

which combined with [\(1.9\)](#page-2-4) yields that

$$
\tilde{\mathbf{u}}_0 = \mathbf{u}_0. \tag{5.27}
$$

Next, we get from [\(5.23\)](#page-21-1) that

$$
\limsup_{R_j\to\infty}\int_{\mathbb{R}^2}\left(|\nabla\tilde{\mathbf{u}}_0^{R_j}|^2+\varrho_0^{R_j}|\tilde{\mathbf{u}}_0^{R_j}|^2\right)d\mathbf{x}\leq \int_{\mathbb{R}^2}\left(|\nabla\mathbf{u}_0|^2+\varrho_0|\mathbf{u}_0|^2\right)d\mathbf{x},
$$

which combined with [\(5.26\)](#page-22-1) shows

$$
\lim_{R_j \to \infty} \int_{\mathbb{R}^2} |\nabla \tilde{\mathbf{u}}_0^{R_j}|^2 d\mathbf{x} = \int_{\mathbb{R}^2} |\nabla \mathbf{u}_0|^2 d\mathbf{x}, \quad \lim_{R_j \to \infty} \int_{\mathbb{R}^2} \varrho_0^{R_j} |\tilde{\mathbf{u}}_0^{R_j}|^2 d\mathbf{x} = \int_{\mathbb{R}^2} \varrho_0 |\mathbf{u}_0|^2 d\mathbf{x}.
$$

This, along with [\(5.26\)](#page-22-1) and [\(5.27\)](#page-22-2), implies that

$$
\lim_{R \to \infty} \left(\|\nabla (\tilde{\mathbf{u}}_0^R - \mathbf{u}_0)\|_{L^2(\mathbb{R}^2)} + \|\sqrt{\varrho_0^R} \tilde{\mathbf{u}}_0^R - \sqrt{\varrho_0} \mathbf{u}_0\|_{L^2(\mathbb{R}^2)} \right) = 0. \tag{5.28}
$$

Similar to [\(5.28\)](#page-22-3), we can also obtain that

$$
\lim_{R\to\infty}\|\nabla^2(\tilde{\mathbf{u}}_0^R-\mathbf{u}_0)\|_{L^2(\mathbb{R}^2)}=0.
$$

Finally, in terms of Lemma [2.1,](#page-3-1) the initial-boundary value problem [\(2.2\)](#page-4-1) with the initial data $(\varrho_0^R, \mathbf{u}_0^R, \mathbf{H}_0^R)$ has a classical solution $(\varrho^R, \mathbf{u}^R, \mathbf{H}^R)$ on $[0, T_R] \times B_R$. Hence, there has a generic positive constant C independent of R such that all those esti-mates stated in Proposition [3.1](#page-5-1) and Lemma [4.1](#page-11-8)[–4.4](#page-16-5) hold for $(\varrho^R, \mathbf{u}^R, \mathbf{H}^R)$. Extending $(\varrho^R, \mathbf{u}^R, \mathbf{H}^R)$ by zero on $\mathbb{R}^2 \setminus B_R$ and denoting

$$
\tilde{\varrho}^R \triangleq \varphi_R \varrho^R, \quad \tilde{\mathbf{u}}^R, \quad \tilde{\mathbf{H}}^R \triangleq \varphi_R \mathbf{H}^R,
$$

with φ_R as in [\(3.6\)](#page-5-7). We deduce from [\(3.3\)](#page-5-6) and Lemma [4.1](#page-11-8)[–4.4](#page-16-5) that the sequence $(\tilde{\varrho}^R, \tilde{\mathbf{u}}^R, \tilde{\mathbf{H}}^R)$ converges weakly, up to the extraction of subsequences, to some limit $(\rho, \mathbf{u}, \mathbf{H})$ satisfying [\(1.6\)](#page-2-1), [\(1.7\)](#page-2-2) and [\(1.10\)](#page-2-5). Moreover, standard arguments shows that $(\rho, \mathbf{u}, \mathbf{H})$ is in fact a classical solution to the problem (1.1) – (1.3) . The proof of Theorem [1.2](#page-2-3) is finished. \Box
