SPARSE DOMINATION VIA THE HELICOIDAL METHOD

Abstract. Using exclusively the localized estimates upon which the helicoidal method was built in [\[BM16\]](#page-57-0), we show how sparse estimates can also be obtained. This approach yields a sparse domination for multiple vector-valued extensions of operators as well. We illustrate these ideas for an n-linear Fourier multiplier whose symbol is singular along a k-dimensional subspace of $\Gamma = \{\xi_1 + \ldots + \xi_{n+1} = 0\}$, where $k < \frac{n+1}{2}$ $\frac{1}{2}$, and for the variational Carleson operator.

1. Introduction

The helicoidal method, which we previously developed in [\[BM16\]](#page-57-0), [\[BM17\]](#page-58-0), represents a new iterative method founded upon very precise local estimates for (quasi)linear and (quasi)multilinear operators and their multiple vector-valued extensions. It allowed us to give positive answers to several questions in harmonic analysis that had been open previously. In particular, we proved that in the local L^2 range, all the multiple vectorvalued extensions of the bilinear Hilbert transform BHT from [\[LT99\]](#page-59-0) have the same range as the scalar operator itself. Before that, it was not known whether there exist any vectorvalued extensions which behave in a similar way to the scalar bilinear Hilbert transform. For more details, see [\[BM16\]](#page-57-0).

In short, the efficiency of the method relies in the sharp localization result, which is rendered global (in a multiple vector-valued form) by an additional stopping time, i.e. an additional decomposition of each of the functiones involved. Through the local estimates and the control of the local operator norm (which are themselves obtained through a stopping time) we can access any triple of Lebesgue exponents from the domain of the bilinear Hilbert transform (including those outside the local L^2 range), obtain the localized vector-valued estimates while keeping track of the operator norm, and eventually convert all these into global estimates. Thus, we are making use of iterated stopping times, and this is one of the main differences between the helicoidal method and the previous approaches to vector-valued extensions for BHT , which had only produced partial results (see [\[Sil14\]](#page-59-1), [\[HLP13\]](#page-58-1)).

In the present work, we will show how the helicoidal method can be naturally adjusted for proving sparse estimates, both for the operator T in question and for any of its multiple vector-valued extension \vec{T} , which takes values in the vector space X (for us, X will consist of iterated Lebesgue spaces). That is, we prove sparse estimates for $\|\vec{T}\|_{L^q(\mathbb{R};X)(v)}^q$, for any $0 < q < \infty$, and any positive, locally integrable function v.

An interesting consequence of such sparse estimates are Fefferman-Stein inequalities for T and its vector-valued extensions, which state that the operator T is controlled by a certain maximal operator in $\|\cdot\|_{L^q(v)}$ (quasi)-norms. Consequently, vector-valued weighted estimates can be deduced.

Our method applies to many operators in harmonic analysis. We will illustrate these ideas for the natural generalization of the bilinear Hilbert transform, which is T_k , an n -linear Fourier multiplier whose symbol is singular along a k -dimensional subspace of $\Gamma = \{\xi_1 + \ldots + \xi_{n+1} = 0\},\$ where $k < \frac{n+1}{2}$ $\frac{1}{2}$. For the time being, no other strategy of proving sparse estimates applies to these operators, while the localization principle and the helicoidal method apply straightaway. We also give a special consideration to T_0 , which corresponds to a multilinear Calderón-Zygmund operator. Specifically, we prove multiple vector-valued (and sparse) inequalities even in the situation when L^{∞} spaces are involved, which was not known before. Estimates involving L^{∞} played an important role in proving mixed-norm estimates for multi-parameter Calderon-Zygmund operators and for deducing Leibniz rules in mixed-norm spaces in [\[BM16\]](#page-57-0).

Another case study is the variational Carleson operator from [\[OST](#page-59-2)⁺12], for which the localization principle produces an extra simplification in the proof: more precise local estimates (which are themselves obtained through stopping times) allow for a clean-cut exceptional set and a simpler stopping time which produces the global estimate. See also the expository paper [\[BM18\]](#page-58-2).

We will see that the *local* property of an operator (or of its bilinear/ multilinear form) is at the heart of "sharp" vector-valued and weighted extensions. The two types of extensions are similar in spirit, in the sense that they both amount to changing the measure space and the Lebesgue exponents in the domain of the operator. For linear operators, it is known that there is a deeper connection between vector-valued and weighted extensions (see [\[GCRdF85\]](#page-58-3)).

In the multilinear case, especially for operators which are not of Calderon-Zygmund type, weighted estimates and the appropriate extrapolation theory were not known until very recently, hence the search for vector-valued extensions was calling for a new approach. For the bilinear Hilbert transform, which should be thought of as the least complex of such operators, partial results were obtained in [\[HLP13\]](#page-58-1) combining time-frequency analysis and UMD spaces techniques, and also in [\[Sil14\]](#page-59-1), where ideas regarding vector-valued estimates from [\[BT13\]](#page-58-4) were incorporated in the time-frequency analysis method.

In [\[Ben15\]](#page-57-1), the interest in vector-valued extensions for the bilinear Hilbert transform was prompted by a *bilinear Rubio de Francia operator for iterated Fourier integrals*:

RF_r(f,g)(x)=\Big(\sum_k\Big|\int\limits_{a_k<\xi_1<\xi_2
$$

which is associated to an arbitrary collection $\{[a_k, b_k]\}_k$ of intervals with bounded overlap, and a Lebesgue exponent $1 \leq r \leq \infty$. Given that in its multiplier form BHT can be written as

BHT(f,g)(x) := \int\limits_{\xi_1 < \xi_2} \hat{f}(\xi_1) \hat{g}(\xi_2) e^{2\pi i x (\xi_1 + \xi_2)} d\xi_1 d\xi_2,
$$

the non-linear operator RF_r can be regarded as a linear ℓ^r -valued extension of the bilinear Hilbert transform. The natural restrictions for r , in the bilinear setting (and which proved to be accurate), seemed to be $1 \leq r \leq \infty$. This should the compared to the linear Rubio de Francia ℓ^r -valued operator associated to arbitrary Fourier projections onto a family of intervals of bounded overlap, where the condition $2 \le r \le \infty$ is necessary. For the linear operator, ℓ^{∞} estimates for the sharp Fourier projections are deduced from the boundedness of Carleson operator; for the bilinear operator RF_r , the case $r = \infty$ can be studied by using the bi-Carleson operator of [\[MTT06\]](#page-59-3) (and again, the Carleson operator).

In dealing directly with the operator RF_r , we developed a proof based on *spatial local*izations, the principle being that in order to control arbitrary frequency scales which are dictated by a quantitative size (a vector-valued square function), a local maximal operator which only retains the spatial information is needed. Stopping times (i.e. a decomposition procedure of the operator according to varying averages) and the local control of the operator by local maximal averages imply the boundedness of the operator.

The same method, i.e. a local control of the operator by localized "sizes" (or local maximal averages), produced in [\[BM16\]](#page-57-0) and [\[BM17\]](#page-58-0) multiple vector-valued extensions for BHT. With an alteration of the stopping time procedure, we will show that it also yields sparse estimates even in the multiple vector-valued setting. More generally, this will apply to operators that admit a decomposition into wave packets indexed after a certain collection P, in the sense that they can be represented as

T_{\mathbb{P}}(f_1,\ldots,f_n)(x)=\sum_{P\in\mathbb{P}}|I_P|^{-\frac{n-1}{2}}\langle f_1,\phi_P^1\rangle\cdot\ldots\langle f_n,\phi_P^n\rangle\phi_P^{n+1}(x).
$$

We claim that sparse and vector-valued estimates are implied by a suitable local estimate for the spatial localization $T_{\mathbb{P}(I_0)}$ of the operator (we only consider tiles $P \in \mathbb{P}$ with the spatial interval I_P contained inside I_0 , which can be written as (2)

\left\|T_{\mathbb{P}(I_0)}(f_1,\ldots,f_n)\right\|^q_{L^q(v^q)}\lesssim \prod_{j=1}^n\Big(\sup_{P\in\mathbb{P}(I_0)^+}\frac{1}{|I_P|}\int_{\mathbb{R}}|f_j(x)|^{s_j}\cdot\tilde{\chi}_{I_P}^Mdx\Big)^{\frac{q}{s_j}}\cdot \Big(\sup_{P\in\mathbb{P}(I_0)^+}\frac{1}{|I_P|}\int_{\mathbb{R}}|v(x)|^{s_{n+1}}\cdot\tilde{\chi}_{I_P}^Mdx\Big)^{\frac{q}{s_{n+1}}}\cdot |I_0|.
$$

Above, $0 < q \le 1$ (on subadditivity grounds), $1 \le s_1, \ldots, s_{n+1} < \infty$ are certain Lebesgue exponents which reflect the operator's properties, and v^q is a positive, locally integrable function. The case $q = 1$ corresponds to the study of the $(n + 1)$ -linear form, and such local estimates were used in [\[BM16\]](#page-57-0). For $q < 1$, the local estimate appeared in [\[BM17\]](#page-58-0), for particular functions that are bounded above by characteristic functions of sets of finite measure. In fact, if the range of exponents (s_1, \ldots, s_{n+1}) for which we want to prove the sparse domination is open, local estimates for restricted type functions are sufficient (see Section [3.2\)](#page-16-0).

We note that our approach yields sparse estimates by making use solely of the local character of the operator (which is an innate property): this is distinct from Lerner's use of local mean oscillation from [\[Ler13\]](#page-58-5), or from Lacey's or Lerner's reiterative slicing from [\[Lac17\]](#page-58-6) or [\[Ler16\]](#page-58-7).

What is more, we obtain a global Fefferman-Stein inequality: provided v^q is a weight satisfying a *reverse Hölder*- $\frac{s_{n+1}}{q}$ inequality, we have that

\|T(f_1,\ldots,\vec{f}_n)\|_{L^q(v^q)} \lesssim \|\vec{\mathcal{M}}_{s_1,\ldots,s_n}(f_1,\ldots,f_n)\|_{L^q(v^q)},
$$

where $\mathcal{\vec{M}}_{s_1,\dots,s_n}$ is the multi(-sub)linear maximal operator

(3)
$$
\vec{\mathcal{M}}_{s_1,\ldots,s_n}(f_1,\ldots,f_n)(x) \coloneqq \sup_{Q\ni x} \prod_{j=1}^n \Big(\frac{1}{|Q|}\int_Q |f_j(y)|^{s_j} dy\Big)^{\frac{1}{s_j}}.
$$

That is, $\mathcal{\tilde{M}}_{s_1,...,s_n}$ (and as a result the product of n Hardy-Littlewood maximal functions $\mathcal{M}_{s_1} \cdot \ldots \cdot \mathcal{M}_{s_n}$, controls the operator T in any $L^q(v^q)$ norm, under certain conditions on s_1, \ldots, s_n .

The first instance of a [\(FS\)](#page-2-0) inequality available for all $0 < q < \infty$ appeared in [\[FS72\]](#page-58-8), and the weighted case in [\[CF74\]](#page-58-9); sometimes they are referred to as Coifman-Fefferman inequalities in the literature. Commonly, the Fefferman-Stein inequalities are obtained as a consequence of good lambda inequalities, which also yield weighted estimates. In the context of Calderón-Zygmund theory, the good lambda inequalities assert that level sets of the maximal function control level sets of Calder´on-Zygmund operators (or of their oscillations/ maximal truncations).

Broadly speaking, the philosophy behind our approach for Fefferman-Stein inequalities or for sparse domination is somewhat similar: first, we know that locally T is controlled by the product of $n+1$ maximal averages. A stopping time will identify the intervals (and associated collections of tiles) where all of the maximal averages are uniformly controlled by averages. Since all these intervals chosen through the stopping time correspond to level sets of localized maximal functions, they are relatively "sparse". This last property allows to recover the global L^q norm of $\mathcal{\vec{M}}_{s_1,\dots,s_n,s_{n+1}}(f_1,\dots,f_n,v)$.

On the other hand, for vector-valued estimates of the type $T: L^{p_1}(\ell^{r_1}) \times ... \times L^{p_n}(\ell^{r_n}) \to$ $L^p(\ell^r)$, i.e. an inequality such as

\|\left(\sum_{k}|T(f_1^k,\ldots,f_n^k)|^r\right)^{\frac{1}{r}}\|_p \lesssim \prod_{j=1}^n \|\left(\sum_{k}|f_j^k|^{r_j}\right)^{\frac{1}{r_j}}\|_{p_j},
$$

each of the the maximal L^{s_j} averages of f_j^k will be converted through a stopping time into L^{r_j} averages, while making sure to save the "spare" information, which is set aside as an operatorial norm. The L^{r_j} averages are summed up via Hölder, and transformed again into L^{s_j} maximal averages of $(\sum_k |f_j^k|^{r_j})^{\frac{1}{r_j}}$, eventually localized. The stopping times, as the $Calderón-Zygmund decomposition, play an important role since they allow to transform$ maximal averages into averages.

Hence, all of the above apply equally to multiple vector-valued extensions of the operator T: in this setting too, we can obtain sparse domination and Fefferman-Stein inequalities. All of these will be made precise shortly.

We recall the linear theory first. If T is a linear operator so that $T: L^p(dx) \to L^p(dx)$ for $p \in Range(T)$, and (\mathcal{W}, μ) is a σ -finite measure space, we want to find $Range(\vec{T}_r)$, the range of exponents r so that

$$
T: L^p(\mathbb{R}; L^r(\mathcal{W}, \mu)) \to L^p(\mathbb{R}; L^r(\mathcal{W}, \mu)).
$$

In the weighted theory, we want to characterize the class of *weights* w (that is, positive, locally integrable functions) for which

(WE)
$$
T: L^p(w dx) \to L^p(w dx).
$$

For Calderón-Zygmund operators, the collection of weights for which [\(WE\)](#page-3-0) holds is the A_p class containing weights w that satisfy

(4)
$$
\sup_{I \text{ interval}} \int_I w(x) dx \cdot \left(\int_I w(x)^{1-p'} dx\right)^{p-1} < \infty.
$$

The quantity in [\(4\)](#page-3-1) represents the A_p *characteristic* of w and is denoted $[w]_{A_p}$. Alternatively, one can describe these weights as being exactly those for which the Hardy-Littlewood maximal function M is a bounded operator on $L^p(w dx)$, for $1 < p < \infty$.

The class A_p turned out to be especially suited for extrapolation: more exactly, if we know that $T: L^p(w dx) \to L^p(w dx)$ for all $w \in A_p$, then

T: L^s(w dx) \to L^s(w dx) \quad \text{for all} \quad w \in A_s,
$$

and moreover, we can also obtain the vector-valued extension:

 $T: L^s(\mathbb{R}; L^r(w dx)) \to L^s(\mathbb{R}; L^r(w dx))$ for all $w \in A_s$ and any $1 < r < \infty$.

As a consequence, vector-valued estimates can be obtained through extrapolation, once weighted estimates in a suitable class are known.

A well-known question in harmonic analysis had been the A_2 conjecture, which predicted a linear dependency of $[w]_{A_2}$ in [\(WE\)](#page-3-0), for Calderón-Zygmund operators, if $p = 2$. Although this was answered positively in [\[Hyt12\]](#page-58-10), simpler proofs were provided([\[Ler13\]](#page-58-5), [\[Lac17\]](#page-58-6), [\[Ler16\]](#page-58-7)), based on an underlying sparse structure that had appeared previously in [\[Ler11\]](#page-58-11), [\[Hyt12\]](#page-58-10) and [\[CUMP12\]](#page-58-12).

As already announced, we will illustrate how the *helicoidal method*, a technique developed in [\[Ben15\]](#page-57-1), [\[BM16\]](#page-57-0) for showing vector-valued estimates for the bilinear Hilbert transform operator BHT, can be used also for obtaining sparse estimates and multiple vector-valued sparse estimates. The singularity of the multiplier of BHT , which is defined by

$$
(f,g) \mapsto \int\limits_{\xi_1 < \xi_2} \hat{f}(\xi_1) \hat{g}(\xi_2) e^{2\pi i x (\xi_1 + \xi_2)} d\xi_1 d\xi_2,
$$

differentiates it from general Calderon-Zygmund operators. A weighted theory for operators similar to BHT was only recently investigated in [\[CDPO16\]](#page-58-13), [\[CUM17\]](#page-58-14), [\[LMO18\]](#page-58-15).

The multiple vector-valued spaces considered here are mixed norm L^p spaces. Let $m \geq 1$ be a natural number, $\{(\mathcal{W}_j, \Sigma_j, \mu_j)\}_{1 \leq j \leq m}$ are totally σ -finite measure spaces and P = (p_1, \ldots, p_m) is an *m*-tuple. Then on the product space $(\mathcal{W}, \Sigma, \mu)$:= (m ∏ $j=1$ W_j , m ∏ $j=1$ $\Sigma_j,$ n ∏ $j=1$ $\mu_j)$

the mixed norm is defined by

$$
||f||_P \coloneqq \left(\int_{\mathcal{W}_1} \ldots \left(\int_{\mathcal{W}_m} |f(w_1,\ldots,w_m)|^{p_m} d\mu_m(w_m)\right)^{\frac{p_{m-1}}{p_m}} \ldots d\mu_1(w_1)\right)^{\frac{1}{p_1}}
$$

In [\[BM16\]](#page-57-0), estimates for *BHT* on such spaces were necessary in the study of multiparameter operators, such as $BHT \otimes \Pi \otimes \ldots \otimes \Pi$ or $\Pi \otimes \Pi \otimes \ldots \otimes \Pi$, where Π is a paraproduct \bilinear Calderón-Zygmund operator.

As mentioned before, one of our case studies is the *n*-linear operator T_k given by a multiplier singular along a k-dimensional subspace of $\Gamma := \{\xi_1 + \ldots + \xi_{n+1} = 0\}$, where $k < \frac{n+1}{2}$ $\frac{1}{2}$. Such operators were studied in [\[MTT02\]](#page-59-4). We note that the case $n = 2, k = 1$ corresponds to the BHT operator of [LT97], [\[LT99\]](#page-59-0), while the case $n = 3, k = 2$, which does not satisfy our sufficient condition $k < \frac{n+1}{2}$ $\frac{1}{2}$, corresponds to the trilinear Hilbert transform and its boundedness is still an open question. More recently, in [\[Kes17\]](#page-58-16), it was proved that no L^p estimates can hold for general multipliers if $k \geq \frac{n+3}{2}$ $\frac{1}{2}$, and consequently, the only undecided case is $k = \left\lceil \frac{n+1}{2} \right\rceil$ $\frac{1}{2}$.

Another situation of particular interest is that when $k = 0$; then the multilinear operator, denoted T_0 , is given by a multiplier that is singular at the origin. Hence we recover multilinear Fourier multipliers (sometimes called "paraproducts"), which are particular cases of multilinear Calderón-Zygmund operators. Sparse estimates for these were studied in [\[LN15\]](#page-58-17), and in Section [6.4](#page-40-0) we discuss multiple vector-valued generalizations.

For an operator as above, we prove the following vector-valued and sparse estimates:

Theorem 1. Let Γ' be a subspace of $\Gamma := \{ \xi \in \mathbb{R}^{n+1} : \xi_1 + \ldots + \xi_{n+1} = 0 \}$ of dimension k where $1 \leq k < \frac{n+1}{2}$. Assume that Γ' is non-degenerate in the sense of [\[MTT02\]](#page-59-4), and that m satisfies the estimate

|\partial^\alpha_\xi m(\xi)|\lesssim \ dist\ (\xi,\Gamma')^{-|\alpha|}
$$

for all partial derivatives ∂_{ξ}^{α} on Γ up to some finite order. Let T_k be an n-linear operator associated to the $(n+1)$ -linear form

(5) \qquad \Lambda(f_1,\ldots,f_{n+1})=\int_{\xi_1+\ldots+\xi_{n+1}=0}m(\xi_1,\ldots,\xi_{n+1})\hat{f}_1(\xi_1)\cdot\ldots\hat{f}_{n+1}(\xi_{n+1})d\xi_1\ldots d\xi_{n+1}.
$$

Then the operator T_k admits multiple vector-valued extensions of depth m

T_k: L^{p_1}(\mathbb{R};L^{R_1}(\mathcal{W},\mu)) \times \ldots \times L^{p_n}(\mathbb{R};L^{R_n}(\mathcal{W},\mu)) \to L^{p'_{n+1}}(\mathbb{R};L^{R'_{n+1}}(\mathcal{W},\mu))
$$

for $(p_1, \ldots, p_n, p_{n+1})$ and m-tuples $(R_1, \ldots, R_n, R_{n+1})$ for which there exist a tuple $(\alpha_1, \ldots, \alpha_{n+1})$ with $\alpha_j \in (0, \frac{1}{2})$ $\frac{1}{2}$) as in [\(57\)](#page-28-0), so that the following conditions are satisfied:

1 < p_j, r_j^l \leq \infty \quad \forall 1 \leq j \leq n, \quad \frac{1}{n} < p'_{n+1}, (r_{n+1}^l)' < \infty \quad \forall 1 \leq l \leq m,
$$

(7)
$$
\frac{1}{p_1} + \ldots + \frac{1}{p_n} + \frac{1}{p_{n+1}} = 1, \qquad \frac{1}{r_1^l} + \ldots + \frac{1}{r_n^l} + \frac{1}{r_{n+1}^l} = 1, \quad \forall 1 \leq l \leq m,
$$

(8)
$$
\frac{1}{p_j} < 1 - \alpha_j, \quad \frac{1}{r_j^l} < 1 - \alpha_j \quad \text{for all } 1 \le j \le n+1, 1 \le l \le m.
$$

Moreover, T_k admits a multiple vector-valued sparse domination in any L^q space, for any $0 < q < \infty$. If X_j denotes the space $L^{R_j}(\mathcal{W}, \mu)$ for all $1 \leq j \leq n$, $X'_{n+1} = L^{R'_{n+1}}(\mathcal{W}, \mu)$, and if there exists a tuple $(\alpha_1, \ldots, \alpha_{n+1})$ with $\alpha_j \in (0, \frac{1}{2})$ $\frac{1}{2}$) as in [\(57\)](#page-28-0) for which

(9)
$$
\frac{1}{r_j^l} < 1 - \alpha_j \quad \text{for all } 1 \le j \le n+1, 1 \le l \le m,
$$

then, given Lebesgue exponents s_j with $\frac{1}{s_j} < 1 - \alpha_j$ for all $1 \le j \le n$ and $\frac{1}{s_{n+1}} < \frac{1}{q}$ $rac{1}{q}$ – α_{n+1} , any vector-valued functions $\bar{f}_1, \ldots, \bar{f}_n$ so that $\|\bar{f}_j(x, \cdot)\|_{X_j}$ are locally integrable, and v a locally q-integrable function, we can construct a sparse collection S depending on the functions f_i and v and the exponents s_j and q for which (10)

\left\| \|T_{k}(\vec{f}_1,\ldots,\vec{f}_n)\|_{X'_{n+1}} \cdot v\right\|_{q}^q \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \|\vec{f}_j(x,\cdot)\|_{X_j}^{s_j} \cdot \tilde{\chi}_Q^M dx \Big)^{q/s_j} \Big(\frac{1}{|Q|} \int_{\mathbb{R}} |v(x)|^{s_{n+1}} \cdot \tilde{\chi}_Q^M dx \Big)^{q/s_{n+1}} |Q|.
$$

- **Remark:.** (i) In the Banach case (i.e. when $1 < r_j^l \leq \infty$ for all $1 \leq j \leq n+1, 1 \leq l \leq m$), if $q = 1$, the sparse estimate above is equivalent to a multiple vector-valued sparse domination for the $n + 1$ -linear form.
	- (ii) We call the estimate in Theorem [1](#page-4-0) a "depth -m" inequality, meaning that the vector spaces correspond to m-tuples. We refer to the classical scalar-valued inequality as a" 0-depth" inequality.
	- (iii) Both the multiple vector-valued and the sparse multiple vector-valued estimates associated to (R_1, \ldots, R_{n+1}) are conditioned by the existence of a tuple $(\alpha_1, \ldots, \alpha_{n+1})$ given by [\(57\)](#page-28-0), for which condition [\(9\)](#page-5-0) holds. Then the Lebesgue exponents p_i in the case of the vector-valued extension (which satisfy (7)), and the Lebesgue exponents s_j in the case of the sparse domination (which we are trying to minimize), must also verify $\frac{1}{p_j} < 1 - \alpha_j$ and $\frac{1}{s_j} < 1 - \alpha_j$, respectively (with the exception of s_{n+1} , which should satisfy $\frac{1}{s_{n+1}} < \frac{1}{q}$ $\frac{1}{q} - \alpha_{n+1}$.

As a consequence of the sparse estimate [\(10\)](#page-5-2), we deduce the following

Corollary 2 (Fefferman-Stein inequality for T_k). Let $(\alpha_1, \ldots, \alpha_{n+1}) \in (0, \frac{1}{2})$ $(\frac{1}{2})^{n+1}$ be a tuple defined by [\(57\)](#page-28-0), and $0 < p < \infty$. For any $s_1, \ldots, s_n, s_{n+1}$ satisfying $\frac{1}{s_j} < 1 - \alpha_j$ for all $1 \leq j \leq n, \frac{1}{s-1}$ $\frac{1}{s_{n+1}} < \frac{1}{p}$ $\frac{1}{p}$ – α_{n+1} and any m-tuples $(R_1,\ldots,R_n,R'_{n+1})$ satisfying [\(9\)](#page-5-0), we have

$$
\|T_k(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R'_{n+1}}(W,\mu)}\|_p \lesssim \|\prod_{j=1}^n \mathcal{M}_{s_j}(\|\vec{f}_j(x,\cdot)\|_{L^{R_j}(W,\mu)})\|_p.
$$

Moreover, if w is a weight in $RH_{\frac{s_{n+1}}{p}}$, we have that

$$
(11) \qquad \left\||T_{k}(\vec{f}_1,\ldots,\vec{f}_n)\right\|_{L^{R_{n+1}'}}\right\|_{L^{p}(w)} \lesssim \left\|\vec{\mathcal{M}}_{s_1,\ldots,s_n}\right(\|\vec{f}_1(x,\cdot)\|_{L^{R_1}},\ldots,\|\vec{f}_n(x,\cdot)\|_{L^{R_n}})\right\|_{L^{p}(w)},
$$

where $\tilde{M}_{s_1,...,s_n}$ is the multi(sub-)linear maximal operator defined in [\(3\)](#page-2-1). The implicit constant in [\(11\)](#page-6-0) depends on the weight w.

For multilinear Calderón-Zygmund operators, a similar result is due to Coifman and Meyer [\[CM75\]](#page-58-18). A weighted estimate involving products of maximal functions appeared in [\[GT02\]](#page-58-19), and in [\[LOP](#page-58-20)⁺ 09a] an inequality as above using the multilinear maximal function was obtained; in both cases, the condition on the weight is that $w \in A_{\infty}$. We sketch the proof of this result in Section [7.1.](#page-44-0)

Together with the weighted estimates that we will prove for $\mathcal{M}_{s_1,\dots,s_n}$ in Proposition [22,](#page-37-0) we deduce the following weighted estimates for T_k :

Corollary 3. Let $(\alpha_1, \ldots, \alpha_{n+1}) \in (0, \frac{1}{2})$ $\frac{1}{2}$)ⁿ⁺¹ be a tuple defined by [\(57\)](#page-28-0), $1 < s_1, ..., s_{n+1} < \infty$ are exponents satisfying $\frac{1}{ }$ $\frac{1}{s_j} < 1 - \alpha_j$ for all $1 \le j \le n$, $\frac{1}{s_{n+1}}$ $\frac{1}{s_{n+1}} < \frac{1}{q}$ $\frac{1}{q}$ – α_{n+1} , while the m-tuples $(R_1, \ldots, R_n, R'_{n+1})$ comply with condition [\(9\)](#page-5-0) of Theorem [1.](#page-4-0) Then for any q_1, \ldots, q_n, q so that $s_j < q_j \leq \infty$ for all $1 \leq j \leq n$ and $\frac{1}{q_1} + \ldots + \frac{1}{q_r}$ $\frac{1}{q_n} = \frac{1}{q}$ $\frac{1}{q}$, the operator T_k satisfies the following vector-valued weighted estimate:

$$
T_k: L^{q_1}(\mathbb{R};L^{R_1}(\mathcal{W},\mu))(w_1^{q_1}) \times \ldots \times L^{q_n}(\mathbb{R};L^{R_n}(\mathcal{W},\mu))(w_n^{q_n}) \to L^{q}(\mathbb{R};L^{R'_{n+1}}(\mathcal{W},\mu))(w_1^{q}),
$$

where $w = w_1 \cdot \ldots \cdot w_n$ and the vector weight $\vec{w} = (w_1^{q_1})$ $u_1^{q_1}, \ldots, u_n^{q_n}$ satisfies the condition

(12)
$$
\sup_{Q} \left(\int_{Q} w^{s_{n+1}} \right)^{\frac{1}{s_{n+1}}} \prod_{j=1}^{n} \left(\int_{Q} w_j^{-\frac{s_j q_j}{q_j - s_j}} \right)^{\frac{1}{s_j} - \frac{1}{q_j}} < +\infty.
$$

Note that we allow $q_j = \infty$ for some of the j, but in that case $w_j \equiv 1$.

Recently, weighted estimates were obtained through extrapolation in [\[CUM17\]](#page-58-14), for the bilinear Hilbert transform operator (though the classes of weights involved are smaller, and L^{∞} spaces do not appear). The method of the proof doesn't allow to recover all the vector-valued estimates from [\[BM16\]](#page-57-0) and [\[BM17\]](#page-58-0). Even more recently, an extrapolation theory for vector weights was developed in [\[LMO18\]](#page-58-15), which, together with the weighted estimates from [\[CDPO16\]](#page-58-13), allow to recover all the vector-valued estimates from [\[BM16\]](#page-57-0) and [\[BM17\]](#page-58-0) (except for the case when L^{∞} spaces are involved). A more comprehensive discussion and a proof of Corollary [3](#page-6-1) will follow in Section [6.3.](#page-36-0)

Remark:. The condition [\(12\)](#page-6-2) on the vector weight is the same as that in [\[LMO18\]](#page-58-15) or [\[CDPO16\]](#page-58-13), but written somehow differently. If $q \ge 1$, the condition on s_{n+1} is that $\frac{1}{s_{n+1}}$ 1 $\frac{1}{q}$ – α_{n+1} , which is the same as $\frac{1}{s_{n+1}} < (1 - \alpha_{n+1}) - \frac{1}{q}$ $\frac{1}{q'}$.

In Corollary [3,](#page-6-1) we don't keep track of the "qualitative" dependency on the vector weight, but it can be traced directly from the sparse form (10) .

The exact range of exponents for the multiple vector-valued inequalities depends closely on the values of the tuple $(\alpha_1,\ldots,\alpha_{n+1})\in (0,\frac{1}{2})$ $\frac{1}{2}$)ⁿ⁺¹. However, if all the exponents $(r_1^l, \ldots, r_{n+1}^l)$ for $1 \leq l \leq m$, are "local L^{2n} exponents (that is, $2 \leq r_j^l \leq \infty$ for all $1 \leq j \leq n+1, 1 \leq l \leq m$), then the range of the depth-m vector-valued extension of T_k corresponding to the tuple (R_1, \ldots, R_{n+1}) coincides with the range of the operator in the scalar case. This is because the constraint in [\(8\)](#page-5-3) reduces to a constraint on the p_j only: $\frac{1}{r_j^l} < 1 - \alpha_j$ is automatically satisfied. An immediate consequence, which can be obtained by using the tools developed in [\[BM16\]](#page-57-0)), is the following result:

Corollary 4. For any $n \ge 1$ and any $0 \le k < \frac{n+1}{2}$ $\frac{1}{2}$, the multi-parameter operator $T_k \otimes T_0 \otimes$ $\dots \otimes T_0$ satisfies the same L^p estimates as the operator T_k itself:

$$
T_k \otimes T_0 \otimes \ldots \otimes T_0: L^{p_1}(\mathbb{R}^m) \times \ldots L^{p_n}(\mathbb{R}^m) \to L^{p'_{n+1}}(\mathbb{R}^m),
$$

for any $(p_1, \ldots, p_n, p'_{n+1}) \in Range(T_k)$.

This extends our previous results from [\[BM16\]](#page-57-0), corresponding to the multi-parameter operator $BHT \otimes \Pi \otimes \ldots \otimes \Pi$.

Also, for T_0 (i.e. a multilinear Hörmander-Mikhlin multiplier) we obtain the following sparse domination:

Theorem 5. Let $(R_1, \ldots, R_n, R'_{n+1})$ be m-tuples so that $1 < r_j^l \leq \infty$ for all $1 \leq l \leq m, 1 \leq j \leq n$ $n, \frac{1}{2}$ $\frac{1}{2} < (r_{n+1}^l)' < \infty$. Let $\epsilon > 0$. For any such tuples R_j , any vector-valued functions $\vec{f}_1, \ldots, \vec{f}_n$ so that $\|\vec{f}_j(x,\cdot)\|_{R_j}$ are locally integrable, and any v a locally q-integrable function, we can construct a sparse collection S depending on the functions f_i and v and the exponents q and ϵ for which

$$
\left\| \left\| T_0(\vec f_1,\ldots, \vec f_n) \right\|_{L^{R_{n+1}'}} \cdot v \right\|_q^q \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \left\| \vec f_j(x,\cdot) \right\|_{\tilde X_j}^{(1+\delta_j)} \cdot \tilde \chi_Q^M dx \Big)^{\frac{q}{1+\delta_j}} \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \left| v(x) \right|^{q+\epsilon_q} \cdot \tilde \chi_Q^M dx \Big)^{\frac{q}{q+\epsilon_q}} \cdot |Q|.
$$

Above, $\delta_j, \epsilon_q \in \{0, \epsilon\}$ with at most m of the $j \neq 0$. If $\|\cdot\|_I^q$ $L^{R'}_{h+1}$ is subadditive, we can take $\epsilon_q = 0$.

In [\[LN15\]](#page-58-17), a pointwise sparse domination was proved for T_0 in the scalar case. The method seems to extend to the case of multiple vector-valued spaces, provided L^{∞} spaces are not involved.

The natural Fefferman-Stein inequality, which in the non-weighted scalar case is due to $[CM75]$, and to $[LOP⁺09b]$ in the weighted scalar case, has the following formulation:

Corollary 6. Let $(R_1, \ldots, R_n, R'_{n+1})$ be m-tuples so that $1 < r_j^l \leq \infty$ for all $1 \leq l \leq m, 1 \leq j \leq m$ $j \leq n, \frac{1}{2}$ $\frac{1}{2} < (r_{n+1}^l)' < \infty$. Let $\epsilon > 0$ and $\delta_j \in \{0, \epsilon\}$ with at most m of the $j \neq 0$. If w is an A_{∞} weight and $0 < q < \infty$, then

$$
\left\| \|T_0(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R_{n+1}'}}^q \right\|_{L^q(w)} \lesssim \left\| \vec{\mathcal{M}}_{1+\delta_1,\ldots,1+\delta_n}(\left\| \vec{f}_1(x,\cdot)\right\|_{L^{R_1}},\ldots,\left\| \vec{f}_n(x,\cdot)\right\|_{L^{R_n}})(x) \right\|_{L^q(w)}.
$$

As a second case study, we obtain (multiple) vector-valued and sparse estimates for the variational Carleson operator:

$$
\mathcal{C}^{var,r}(f)(x) \coloneqq \sup_{K} \sup_{n_0 < ... < n_k} \Big(\sum_{\ell=1}^K \big| \int_{a_{n_{\ell-1}}}^{a_{n_\ell}} \hat{f}(\xi) e^{2\pi i x \xi} d\xi \big|^r \Big)^{\frac{1}{r}},
$$

where $r > 2$.

Theorem 7. If
$$
R = (r^1, ..., r^m)
$$
 is an *m*-tuple with $r' < r^j < \infty$, then we have

$$
C^{var,r}: L^p(\mathbb{R}; L^R(\mathcal{W}, \mu)) \to L^p(\mathbb{R}; L^R(\mathcal{W}, \mu))
$$

for all $r' < p < \infty$.

Further, given $0 < q < \infty$, $\epsilon, \epsilon_q > 0$, \tilde{f} a multiple vector-valued function with $|| f(x, \cdot)||_{L^R(w, \mu)}$ locally integrable and v a locally q-integrable function, there exists a sparse collection \hat{S} of dyadic intervals (depending on the preceding parameters) so that

$$
\left\||\mathcal{C}^{var,r}\|_{L^R(\mathcal{W},\mu)}\cdot v\right\|_{q}^q \lesssim \sum_{Q\in\mathcal{S}}\left(\frac{1}{|Q|}\int_{\mathbb{R}}\|f(x,\cdot)\|_{L^R(\mathcal{W},\mu)}^{r'+\epsilon}\cdot\tilde{\chi}_Q^M(x)dx\right)^{\frac{q}{r'+\epsilon}}\cdot\left(\frac{1}{|Q|}\int_{\mathbb{R}}|v(x)|^{q+\epsilon_q}\cdot\tilde{\chi}_Q^M(x)dx\right)^{\frac{q}{q+\epsilon_q}}\cdot|Q|.
$$

If $q \leq 1$, we can allow for $\epsilon_q = 0$.

We note that the scalar sparse domination result of Theorem [7,](#page-8-0) when $q = 1$, was already obtained in [\[DPDU16\]](#page-58-21). Also, the scalar case for $n = 2, k = 1, q = 1$ $n = 2, k = 1, q = 1$ $n = 2, k = 1, q = 1$ of Theorem 1 was proved in [\[CDPO16\]](#page-58-13). The "localized outer L^p embeddings", formulated in the language of outer measures of [\[DT15\]](#page-58-22), sit at the core of the two papers, and are similar in spirit to the localization principle presented herein. Strictly speaking, this localization principle was first published in [\[Ben15\]](#page-57-1); it was developed in C.B.'s PhD thesis at Cornell University, and afterwards refined in [\[BM16\]](#page-57-0).

As usual, the sparse estimates of Theorem [7](#page-8-0) imply the following weighted inequalities:

Corollary 8. For any $\delta > 0$, and any $r' + \delta < p < \infty$, we have that $\mathcal{C}^{var,r}: L^p(w) \to L^p(w),$

for any weight $w \in A_{\frac{p}{r'+\delta}}$. Moreover, the operatorial norm is bounded by

(13)
$$
\|\mathcal{C}^{var,r}\|_{L^p(w)\to L^p(w)} \lesssim \left([w]_{A_{\frac{p}{r'+\delta}}}\right)^{\max\left(\frac{1}{p-r'-\delta},1\right)}.
$$

Similar estimates hold in the vector-valued case:

$$
\left\|C^{var,r}f(x,\cdot)\right\|_{L^p(\mathbb{R}; wdx; L^R(\mathbb{W},\mu))} \lesssim \left(\left[w\right]_{A_{\frac{p}{r'+\delta}}}\right)^{\max\left(\frac{1}{p-r'-\delta},1\right)} \left\|f(x,\cdot)\right\|_{L^p(\mathbb{R}; wdx; L^R(\mathbb{W},\mu))}.
$$

The scalar case was already obtained in [\[DPDU16\]](#page-58-21), as a consequence of similar sparse estimates. The vector-valued weighted estimates follow through extrapolation.

Remark:. If $p > r'$ is fixed, we obtain weighted estimates for all weights

$$
w \in \bigcup_{r' < p_0 < p} A_{\frac{p}{p_0}},
$$

which coincides with the class $A_{\frac{p}{r'}}$.

A Fefferman-Stein inequality is available, in the multiple vector-valued setting, for the variational Carleson as well:

Corollary 9. For any $0 < p < \infty$, $\epsilon > 0$, and any m-tuple $R = (r^1, \ldots, r^m)$ with $r' < r^j < \infty$, we have

$$
\left\| \left\| \mathcal{C}^{var,r} f(x, \cdot) \right\|_{L^R(\mathcal{W}, \mu)} \right\|_p \lesssim \left\| \mathcal{M}_{r'+\epsilon} \left(\left\| f(x, \cdot) \right\|_{L^R(\mathcal{W}, \mu)} \right) \right\|_p.
$$

Moreover, if $w \in A_{\infty}$, we have that

$$
\left\| \left\| \mathcal{C}^{var,r} f(x,\cdot) \right\|_{L^R(\mathcal{W},\mu)} \right\|_{L^p(w)} \lesssim \left\| \mathcal{M}_{r'+\epsilon} \left(\left\| f(x,\cdot) \right\|_{L^R(\mathcal{W},\mu)} \right) \right\|_{L^p(w)}.
$$

Remark:. The implicit constant in the inequality above depends on the weight w or on its A_{∞} characteristic. We don't track that dependence here.

As mentioned previously, the sparse domination of $||T \cdot v||_q^q$, where T allows for a wave packet decomposition as in [\(1\)](#page-2-2), is implied by a local property of the operator. We present the statement for T_k when $n = 2$ and $q = 1$, as the hypothesis had already appeared in [\[BM16\]](#page-57-0), for a special class of functions.

Proposition 10. Let \mathbb{P} be a collection of tri-tiles and $\Lambda_{\mathbb{P}}$ the trilinear form associated to T. Assume that

$$
|\Lambda_{\mathbb{P}(I_0)}(f,g,h)| \lesssim \left(\sup_{P \in \mathbb{P}(I_0)^+} \frac{1}{|I_P|} \int_{\mathbb{R}} |f(x)|^{s_1} \cdot \tilde{\chi}_{I_P}^M dx\right)^{1/s_1} \cdot \left(\sup_{P \in \mathbb{P}(I_0)^+} \frac{1}{|I_P|} \int_{\mathbb{R}} |g(x)|^{s_2} \cdot \tilde{\chi}_{I_P}^M dx\right)^{1/s_2}
$$

$$
\cdot \left(\sup_{P \in \mathbb{P}(I_0)^+} \frac{1}{|I_P|} \int_{\mathbb{R}} |h(x)|^{s_3} \cdot \tilde{\chi}_{I_P}^M dx\right)^{1/s_3} \cdot |I_0|
$$

holds for any dyadic interval I_0 and any locally integrable functions f, g and h. Then there exists S a sparse family of intervals depending on the functions f, g, h and on the Lebesgue exponents s_1, s_2, s_3 , so that

$$
\left|\Lambda_{\mathbb{P}}(f,g,h)\right| \lesssim \sum_{Q \in \mathcal{S}} \left(\frac{1}{|Q|} \int_{\mathbb{R}} |f|^{s_1} \cdot \tilde{\chi}_Q^{M-1} dx\right)^{1/s_1} \left(\frac{1}{|Q|} \int_{\mathbb{R}} |g|^{s_2} \cdot \tilde{\chi}_Q^{M-1} dx\right)^{\frac{1}{s_2}} \left(\frac{1}{|Q|} \int_{\mathbb{R}} |h|^{s_3} \cdot \tilde{\chi}_Q^{M-1} dx\right)^{1/s_3} \cdot |Q|.
$$

The proof of this result will be presented in Section [3.](#page-13-0)

We now briefly describe the helicoidal method (as used in [\[BM16\]](#page-57-0) and in [\[BM17\]](#page-58-0)). When proving vector-valued inequalities, the sparse property of the three collections produced through the stopping times is built-in, and it doesn't play a role in itself. The study of BHT involves a coupling of L^2 and L^1 information, and this motivated the restriction to functions that are bounded above by characteristic functions of sets of finite measure.

An immediate application of Proposition 6.12 in [\[MS13\]](#page-59-6) is the following estimate for the trilinear form associated to the BHT operator:

(14)
$$
|\Lambda_{BHT}(\mathbb{P}) (f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 \left(\sup_{P \in \mathbb{P}} \frac{1}{|I_P|} \int_{\mathbb{R}} |f_j(x)| \cdot \tilde{\chi}_{I_P}^M(x) dx \right)^{\theta_j} \cdot \|f_j\|_2^{1-\theta_j},
$$

where $0 \le \theta_1, \theta_2, \theta_3 < 1$ and $\theta_1 + \theta_2 + \theta_3 = 1$. The first part is an L^1 quantity, similar to a maximal operator, while the second part is just the L^2 norm. We want to show that $BHT: L^p \times L^q \to L^s$, where $\frac{1}{p}$ + 1 $\frac{1}{q} = \frac{1}{s}$ $\frac{1}{s}$. Invoking multilinear interpolation, we can assume that $|f_j(x)| \leq \mathbf{1}_{E_j}$ for $1 \leq j \leq 3$, and it remains to verify that

$$
|\Lambda_{BHT(\mathbb{P})}(f_1, f_2, f_3)| \lesssim |E_1|^{\alpha_1} \cdot |E_2|^{\alpha_2} \cdot |E_3|^{\alpha_3},
$$

for $(\alpha_1, \alpha_2, \alpha_3)$ arbitrarily close to $(\frac{1}{p})$ $\frac{1}{p}, \frac{1}{q}$ $\frac{1}{q}, \frac{1}{s'}$ $\frac{1}{s'}$), with $\alpha_1 + \alpha_2 + \alpha_3 = 1$ (if we consider $s < 1$, which is natural for bilinear operators, the interpolation statement becomes more involved and will not be presented in the introduction).

This reduces the problem to finding the good combination of θ_1, θ_2 and θ_3 in [\(14\)](#page-9-0) for which we can obtain an expression similar to $|E_1|^{\frac{1}{p}} \cdot |E_2|^{\frac{1}{q}} \cdot |E_3|^{1 \over s'}$. A careful inspection reveals a constraint on the Lebesgue exponents: for the proof strategy to work, we require that

(15)
$$
\left|\frac{1}{p} - \frac{1}{q}\right| \le \frac{1}{2},
$$

and in consequence, the adjoint operators need to be considered as well. In particular, estimates close to $L^1 \times L^{\infty} \to L^1$ cannot be obtained directly, and multilinear interpolation between adjoint operators is needed.

Similarly, the vector-valued inequality reduces to proving

(16)
$$
\left| \sum_{k} \Lambda_{BHT(\mathbb{P})}(f_k, g_k, h_k) \right| \lesssim |F|^{\frac{1}{p}} |G|^{\frac{1}{q}} |H|^{\frac{1}{s'}},
$$

whenever $\vec{f} = \{f_k\}, \vec{g} = \{g_k\}, \vec{h} = \{h_k\}$ are vector-valued functions satisfying $\left(\sum_k |f_k|^{r_1}\right)^{\frac{1}{r_1}} \leq$

$$
\mathbf{1}_F, \left(\sum_{k} |g_k|^r\right)^{\frac{1}{r_2}} \le \mathbf{1}_G, \text{ and } \left(\sum_{k} |h_k|^{r'}\right)^{\frac{1}{r'}} \le \mathbf{1}_H, \text{ with } \frac{1}{r_1} + \frac{1}{r_2} = \frac{1}{r}.
$$

This is achieved through *localization*: the estimate in (14) is remodeled and localized in order to obtain the sharp inequality

$$
\left|\Lambda_{\mathbb{P}(I_0)}(f_k \cdot \mathbf{1}_F, g_k \cdot \mathbf{1}_G, h_k \cdot \mathbf{1}_{H'})\right| \lesssim \left\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\right\| \|f_k \cdot \tilde{\chi}_{I_0}^M\|_{r_1} \|g_k \cdot \tilde{\chi}_{I_0}^M\|_{r_2} \|h_k \cdot \tilde{\chi}_{I_0}^M\|_{r'},
$$

where $\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\|$ $\mathbb{P}(I_0, H)$ represents the operatorial norm that will be described later.

Then we can sum in k via Hölder's inequality the expressions $|| f_k \cdot \tilde{\chi}_{I_0} ||_{r_1}$, which are further transformed into L^p norms (thus the "change of measure space") of the function $\mathbf{1}_F$. In addition, in order to obtain the largest possible range of exponents for the vectorvalued extensions, the constraint [\(15\)](#page-9-1) had to be removed and specific sharp estimates were needed.

As a byproduct of the localization (the 0-depth inequality), the constraint [\(15\)](#page-9-1) which confined us to the region $\left|\frac{1}{p}\right|$ $\frac{1}{p} - \frac{1}{q}$ $\frac{1}{q}$ | < $\frac{1}{2}$ $\frac{1}{2}$ can be removed by using the local estimate

(17)
$$
\Lambda_{BHT;\mathbb{P}(I_0)}(f_1, f_2, f_3) \lesssim \prod_{j=1}^3 \left(\sup_{P \in \mathbb{P}} \frac{1}{|I_P|} \int_{\mathbb{R}} |1_{E_j}(x)| \cdot \tilde{\chi}_{I_P}^M(x) dx \right)^{\frac{1+\theta_j}{2}-\epsilon} \cdot |I_0|,
$$

and an additional stopping time. In this way, we can obtain all the known L^p estimates for BHT without using interpolation of adjoint trilinear forms. This was already contained in [\[Ben15\]](#page-57-1) and [\[BM16\]](#page-57-0).

Note that [\(17\)](#page-10-0) is precisely the estimate needed for deducing sparse domination in Proposition [10.](#page-9-2) Although it initially appeared in the context of restricted-type functions (we assume $|f_j(x)| \leq \mathbf{1}_{E_j}(x)$, it extends to general functions through an argument resembling interpolation (see Proposition [14\)](#page-16-1).

The paper is organized as follows: after introducing some basic notions in Section [2,](#page-11-0) we show in Section [3](#page-13-0) how the local estimate implies almost immediately the sparse domination of the multilinear form and how to remove the restricted-type assumption on the functions. The stopping time that yields the sparse estimates is compared to the one used in [\[BM16\]](#page-57-0) for obtaining vector-valued estimates in Section [4.](#page-20-0) In Sections [5](#page-24-0) and [6](#page-31-0) we present the details of the proof of Theorem [1,](#page-4-0) proving inductively the multiple vector-valued sparse estimates. Weighted estimates that can be deduced directly from the sparse domination are discussed in Section [6.3.](#page-36-0) Finally, in Section [7](#page-44-1) we illustrate our method for the Carleson and variational Carleson operators.

2. Preliminaries

2.1. **Multi-tiles and sizes.** We recall some notions pertaining to time-frequency analysis, yet trying to avoid the prominent technicalities associated to the field. The essential step in our approach to sparse or vector-valued inequalities consists in proving a local estimate, such as the one mentioned earlier in Proposition [10.](#page-9-2) This will be carried out in Section [5,](#page-24-0) and more definitions will be introduced at that point.

Definition 1. We call a Hölder tuple any tuple $(p_1, \ldots, p_n, p_{n+1})$ of exponents satisfying

(18)
$$
\frac{1}{p_1} + \ldots + \frac{1}{p_n} = \frac{1}{p_{n+1}}, \text{ where } 1 < p_1, \ldots, p_n \le \infty, \frac{1}{n} < p_{n+1} < \infty.
$$

The operators fitting our approach are those that allow for a wave packet decomposition, that is, a decomposition in the time-frequency plane.

Definition 2. A tile is a rectangle $P = I_P \times \omega_P$ of area one, with the property that I_P is a dyadic interval, and ω_P is contained in a certain translate of the dyadic grid. A multi-tile is a tuple $P = (P_1, \ldots, P_{n+1})$ where each P_j is a tile, and so that $I_{P_j} = I_P$ for all $1 \leq j \leq n+1$ (that is, all the tiles share the same spatial interval I_P).

Definition 3. A wave packet associated to a tile $P = I_P \times \omega_P$ is a smooth function ϕ_P so that $supp \hat{\phi}_P \subseteq \frac{9}{16}$ $\frac{\partial}{\partial \rho} \omega_P$ and ϕ_P is L^2 -adapted to I_P in the sense that

(19)
$$
|\phi_P^{(k)}(x)| \le C_{k,M} \frac{1}{|I_P|^{\frac{1}{2}+k}} \Big(1 + \frac{\text{dist}(x, I_P)}{|I_P|}\Big)^{-M}
$$

for sufficiently many derivatives k and any $M > 0$.

With the above notation, we can study *n*-linear operators that allow for a model $(n+1)$ linear form representable as

(20)
$$
\sum_{P \in \mathbb{P}} |I_P|^{-\frac{n-1}{2}} a_{P_1} \cdot \ldots \cdot a_{P_{n+1}}.
$$

For the operator introduced in Theorem [1,](#page-4-0) the coefficients are given by $a_{P_j} = \langle f_j, \phi_{P_j} \rangle$, for $1 \leq j \leq n+1$. The Carleson operator, defined by

$$
\mathcal{C}f(x) \coloneqq \sup_{N} \Big| \int_{\xi < N} \hat{f}(\xi) e^{2\pi i x \xi} \, d\xi \Big|,
$$

brings about a measurable function $N(x)$ which attains the supremum in the expression above, hence $a_{P_1} = \langle f_1, \phi_{P_1} \rangle$, $a_{P_2} = \langle f_2, \phi_{P_2} \cdot \mathbf{1}_{\{N(x)\in\omega_{P_2}\}} \rangle$. In the same way, the variational Carleson operator of Theorem [7](#page-8-0) involves several functions $\xi_1(x), \ldots, \xi_K(x)$, and in that case we have $n = 1$ and $a_{P_1} = \langle f_1, \phi_{P_1} \rangle$, $a_{P_2} = \langle f_2, \phi_{P_2} \cdot \mathbf{1}_{\omega_{P_2}}(\xi_k(\cdot)) \rangle$ for some $1 \le k \le K$.

There is no typical way of treating directly these operators, and their study varies greatly upon the properties of their invariants. However, local estimates for these operators can be obtained by looking carefully at the classical boundedness proof and adjusting it accordingly: the goal is now to gather as much information as possible, although at a local level. When passing to the global estimate, much consideration is given to keeping track of the localized operatorial norm.

Now we introduce some notations that will be used throughout the paper. In particular, we keep on using the notion of "size" in spite of it representing henceforth just a maximal average over dyadic intervals (as opposed to its common meaning of a square function over some subcollection of multi-tiles: see Definition [11,](#page-25-0) and its use in [\[LT99\]](#page-59-0), [\[MTT02\]](#page-59-4), [\[MS13\]](#page-59-6), $[MTT04]$).

Notation:. Given $I \subseteq \mathbb{R}$ an interval, $\mathbf{1}_I$ denotes its characteristic function, while $\tilde{\chi}_I$ is a function L^{∞} -adapted to I. For example, we can set

$$
\tilde{\chi}_I(x) \coloneqq \Big(1 + \frac{dist(x, I)}{|I|}\Big)^{-100}.
$$

Then we define the weighted average of a locally integrable function f on I as

(21)
$$
ave_I(f) \coloneqq \frac{1}{|I|} \int_{\mathbb{R}} |f(x)| \cdot \tilde{\chi}_I(x) dx.
$$

Notation:. A collection of multi-tiles will be usually denoted by \mathbb{P} . If I_0 is a fixed dyadic interval and $\not\mathbb{P}$ a collection of multi-tiles, we use the notations

(22)
$$
\mathbb{P}(I_0) \coloneqq \{ P \in \mathbb{P} : I_P \subseteq I_0 \} \quad \text{and} \quad \mathbb{P}(I_0)^+ \coloneqq \mathbb{P}(I_0) \cup P_{I_0}
$$

where P_{I_0} is some multi-tile (not necessarily contained in \mathbb{P}) with spatial interval I_0 .

Finally, the most important notion is that of size:

Definition 4. If \mathbb{P} is a collection of multi-tiles, then we define its size \mathbb{P} with respect to the function f by

(23)
$$
\widetilde{\text{size}}_{\mathbb{P}}(f) \coloneqq \sup_{P \in \mathbb{P}} \frac{1}{|I_P|} \int_{\mathbb{R}} |f(x)| \cdot \widetilde{\chi}_{I_P}^M(x) dx \coloneqq \sup_{P \in \mathbb{P}} \text{ave}_{I_P}(f).
$$

Then $\widetilde{size}_{\mathbb{P}(I_0)}$ and $\widetilde{size}_{\mathbb{P}(I_0)^+}$ denote the sizes associated to the collections $\mathbb{P}(I_0)$ and $\mathbb{P}(I_0)^+$ respectively. Given an interval I_0 , if the collections $\mathbb{P}(I_0)$ is implicitly defined in an unambiguous way, we simply use the notation

$$
\widetilde{size}_{I_0}(f) = \widetilde{size}_{\mathbb{P}(I_0)^+}(f) = \max\Big(\frac{1}{|I_0|}\int_{\mathbb{R}}|f(x)|\cdot \tilde{\chi}_{I_0}^M(x)dx, \widetilde{size}_{\mathbb{P}(I_0)}(f)\Big).
$$

Notation:. We will also use the notations

$$
(24) \quad \widetilde{\text{size}}_{\mathbb{P}(I_0)}^p(f) \coloneqq \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} |f|^p \cdot \widetilde{\chi}_{I_P} dx \right)^{\frac{1}{p}}, \qquad \text{ave}_{I_0}^p(f) \coloneqq \left(\frac{1}{|I_0|} \int_{\mathbb{R}} |f|^p \cdot \widetilde{\chi}_{I_0} dx \right)^{\frac{1}{p}}.
$$

2.2. Sparse collections. Even though the notion of "sparseness" had appeared in various contexts, with various meanings, in the field of harmonic analysis, here it represents the geometric property of a collections of intervals which doesn't allow for too much stacking. Somehow this is a very good property for obtaining sharp weighted estimates.

Definition 5. Let $0 \le \eta \le 1$. A collection S of dyadic intervals is called η -sparse if one can choose pairwise disjoint measurable sets $E_Q \subseteq Q$ with $|E_Q| \geq \eta |Q|$ for all $Q \in S$.

Definition 6. Let $\Lambda > 1$. A family S is called Λ -Carleson if for any dyadic interval Q we have

$$
\sum_{\substack{P \in \mathcal{S} \\ P \subseteq Q}} |P| \leq \Lambda |Q|.
$$

,

As it turns out, the two definitions are equivalent:

Lemma 11 (Lemma 6.3 [\[LN15\]](#page-58-17)). A collection S is η -sparse if and only if it is $\frac{1}{\eta}$ -Carleson.

Another notion of sparse, which implies the one in Definition [5,](#page-12-0) is the following:

Definition 7. Let $0 < \eta < 1$. A collection of dyadic intervals S is said to be η -sparse if for each $Q \in \mathcal{S}$ we have

$$
\sum_{P \in ch_{\mathcal{S}}(Q)} |P| \le (1 - \eta)|Q|,
$$

where $ch_{\mathcal{S}}(Q)$ is the collection of direct descendants of Q in S: the maximal elements of S that are strictly contained in Q.

It is this last notion that is most commonly verified in practice, for example in [\[Lac17\]](#page-58-6), [\[BFP16\]](#page-57-2), [\[Ler16\]](#page-58-7).

3. Sparse Domination via the helicoidal method : local estimates imply sparse domination

In this section we show how the local estimate given by the scalar $\mathcal{P}(0)$ statement (equation [\(25\)](#page-13-1) below) of the helicoidal method from [\[BM16\]](#page-57-0) implies the expected scalar sparse domination of the multilinear form (corresponding to the case $q = 1$). This procedure is quite general, as can be seen from the proof of Theorem [12](#page-13-2) below, but will be illustrated first for trilinear forms.

Later on, provided we have subadditivity, we prove in Proposition [13](#page-15-0) how a local estimate in (quasi-) norm (such as $\mathcal{P}(0)$ of the helicoidal method applied to quasi-Banach spaces in [\[BM17\]](#page-58-0)) implies a sparse domination in (quasi-) norm (estimate [\(10\)](#page-5-2) of Theorem [1\)](#page-4-0).

3.1. The stopping time for the sparse collection. Let I_0 be a fixed dyadic interval, P a rank-1 collection of tri-tiles, and $0 \le \theta_1, \theta_2, \theta_3 < 1$ with $\theta_1 + \theta_2 + \theta_3 = 1$. It was proved in [\[BM16\]](#page-57-0) that

$$
(25) \qquad |\Lambda_{BHT;\mathbb{P}(I_0)}(f,g,h)| \lesssim \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_F\right)^{\frac{1+\theta_1}{2}} \cdot \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_G\right)^{\frac{1+\theta_2}{2}} \cdot \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{H'}\right)^{\frac{1+\theta_3}{2}} \cdot |I_0|,
$$

whenever f, g and h are functions having the property that $|f(x)| \leq \mathbf{1}_F(x), |g(x)| \leq \mathbf{1}_G(x)$ and $|h(x)| \leq \mathbf{1}_{H'}(x)$, where F, G and H' are subsets of R of finite measure.

Using exclusively this local estimate, we obtain a sparse domination for the globallydefined trilinear form $\Lambda_{BHT,F}$. More exactly, we will construct a sparse family S of intervals (depending of course on the functions $\mathbf{1}_F$, $\mathbf{1}_G$, $\mathbf{1}_{H'}$ and the exponents θ_1 , θ_2 and θ_3) so that

$$
\left|\Lambda_{BHT;\mathbb{P}}(f,g,h)\right|\lesssim \sum_{Q\in\mathcal{S}}\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\mathbf{1}_{F}\cdot\tilde{\chi}_{Q}^{M}dx\Big)^{\frac{1+\theta_{1}}{2}}\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\mathbf{1}_{G}\cdot\tilde{\chi}_{Q}^{M}dx\Big)^{\frac{1+\theta_{2}}{2}}\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\mathbf{1}_{H'}\cdot\tilde{\chi}_{Q}^{M}dx\Big)^{\frac{1+\theta_{3}}{2}}\cdot |Q|,
$$

whenever f, g, h are as above. Since the restricted weak-type condition on the functions can be removed (see Proposition [14](#page-16-1) below), we will show in the general context, and for an arbitrary family $\mathbb P$ of tiles, how to obtain the sparse domination result from the local estimate.

Theorem 12. Let $\mathbb P$ be a collection of tiles and assume that

$$
(26) \qquad |\Lambda_{\mathbb{P}(I_0)}(f,g,h)| \lesssim \left(\frac{\delta}{\delta z e_{I_0}} |f|^{s_1}\right)^{1/s_1} \cdot \left(\frac{\delta}{\delta z e_{I_0}} |g|^{s_2}\right)^{1/s_2} \cdot \left(\frac{\delta}{\delta z e_{I_0}} |h|^{s_3}\right)^{1/s_3} \cdot |I_0|,
$$

holds for any dyadic interval I_0 and any locally integrable functions f, g and h. Then there exists a sparse family S of intervals so that

$$
\left|\Lambda_{\mathbb{P}}(f,g,h)\right| \lesssim \sum_{Q \in \mathcal{S}} \left(\frac{1}{|Q|}\int_{\mathbb{R}} |f|^{s_1} \cdot \tilde{\chi}_Q^{M-1} dx\right)^{\frac{1}{s_1}} \left(\frac{1}{|Q|}\int_{\mathbb{R}} |g|^{s_2} \cdot \tilde{\chi}_Q^{M-1} dx\right)^{\frac{1}{s_2}} \left(\frac{1}{|Q|}\int_{\mathbb{R}} |h|^{s_3} \cdot \tilde{\chi}_Q^{M-1} dx\right)^{\frac{1}{s_3}} \cdot |Q|.
$$

Remark:. 1. We note that the scalar-valued functions can be replaced by more general vector-valued norms: a local estimate

$$
|\Lambda_{\mathbb{P}(I_0)}(\vec{f}, \vec{g}, \vec{h})| \lesssim (\widetilde{\text{size}}_{I_0} \|\vec{f}(x, \cdot)\|_{X_1}^{s_1})^{1/s_1} \cdot (\widetilde{\text{size}}_{I_0} \|\vec{g}(x, \cdot)\|_{X_2}^{s_2})^{1/s_2} \cdot (\widetilde{\text{size}}_{I_0} \|\vec{h}(x, \cdot)\|_{X_3}^{s_3})^{1/s_3} \cdot |I_0|
$$

will imply in an analogous way the vector-valued sparse domination

$$
\left|\Lambda_{\mathbb{P}}(\vec{f},\vec{g},\vec{h})\right| \lesssim \sum_{Q\in\mathcal{S}}\left(\frac{1}{|Q|}\int_{\mathbb{R}}\|\vec{f}(x,\cdot)\|_{X_1}^{s_1}\cdot\tilde{\chi}_Q^Mdx\right)^{1/s_1}\left(\frac{1}{|Q|}\int_{\mathbb{R}}\|\vec{g}(x,\cdot)\|_{X_2}^{s_2}\cdot\tilde{\chi}_Q^Mdx\right)^{1/s_2}\left(\frac{1}{|Q|}\int_{\mathbb{R}}\|\vec{h}(x,\cdot)\|_{X_3}^{s_3}\cdot\tilde{\chi}_Q^Mdx\right)^{1/s_3}\cdot|Q|.
$$

2. Similarly, a local estimate for a (vector-valued) $(n + 1)$ -linear form will imply a (vector-valued) sparse domination of the $(n+1)$ -linear form.

Proof. The sparse estimation does not only involve a localization in space onto a certain interval I_0 , but also a restriction to a specific subset of tiles $\mathbb{P}_{I_0} \subseteq \mathbb{P}(I_0)$. We will construct S a sparse family of intervals, where $S = \bigcup$ $k\geq 0$ \mathcal{S}_k and for every $k \geq 0$ we have

$$
\mathcal{S}_{k+1} = \bigcup_{Q_0 \in \mathcal{S}_k} ch_{\mathcal{S}}(Q_0);
$$

that is, the intervals from the $k+1$ level \mathcal{S}_{k+1} are precisely the descendants of the intervals of the k-th level \mathcal{S}_k .

We start by defining S_0 as the collection of maximal dyadic intervals I so that $I = I_P$ for some tri-tile $P \in \mathbb{P}$. Then we show how to construct S_{k+1} , assuming that S_k has already been constructed: for every $Q_0 \in S_k$, the descendants $ch_{\mathcal{S}}(Q_0)$ are maximal dyadic intervals $Q \subseteq Q_0$ so that there exists at least one tri-tile $P \in \mathbb{P}$ with $I_P \subset Q$ and so that one of the following holds:

$$
(27) \qquad \left(\frac{1}{|Q|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_Q^M(x)dx\right)^{1/s_1} > C\cdot \left(\frac{1}{|Q_0|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_{Q_0}^{M-1}(x)dx\right)^{1/s_1} \qquad \text{or}
$$

(28)
$$
\left(\frac{1}{|Q|}\int_{\mathbb{R}}|g(x)|^{s_2}\cdot\tilde{\chi}_Q^M(x)dx\right)^{1/s_2} > C \cdot \left(\frac{1}{|Q_0|}\int_{\mathbb{R}}|g(x)|^{s_2}\cdot\tilde{\chi}_{Q_0}^{M-1}(x)dx\right)^{1/s_2} \quad \text{or}
$$

$$
(29) \qquad \big(\frac{1}{|Q|}\int_{\mathbb{R}}|h(x)|^{s_3}\cdot\tilde{\chi}_Q^M(x)dx\big)^{1/s_3} > C\cdot\big(\frac{1}{|Q_0|}\int_{\mathbb{R}}|h(x)|^{s_3}\cdot\tilde{\chi}_{Q_0}^{M-1}(x)dx\big)^{1/s_3}.
$$

The collection $ch_S(Q_0)$ of such intervals is disjoint due to the maximality condition, and it is not difficult to check that

$$
\sum_{Q \in ch_{\mathcal{S}}(Q_0)} |Q| \le \frac{1}{2} |Q_0|,
$$

provided the constant C is chosen to be large enough. Indeed, we can see that all the intervals satisfying [\(27\)](#page-14-0) are mutually disjoint and they are contained inside the set

$$
\Big\{\mathcal{M}_{s_1}\big(f\cdot\tilde{\chi}_{Q_0}^{\frac{M-1}{s_1}}\big)(x)>C\cdot\big(\frac{1}{|Q_0|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_{Q_0}^{M-1}(x)dx\big)^{1/s_1}\Big\}.
$$

Using the $L^{s_1} \to L^{s_1,\infty}$ boundedness of \mathcal{M}_{s_1} , we can estimate the measure of the set above by

$$
\begin{split} &|\{\mathcal{M}_{s_1}\Big(f\cdot\tilde{\chi}_{Q_0}^{\frac{M-1}{s_1}}\Big)(x)>C\cdot\big(\frac{1}{|Q_0|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_{Q_0}^{M-1}(x)dx\big)^{1/s_1}\big\}| \lesssim \\ &\lesssim C^{-s_1}\cdot\big(\frac{1}{|Q_0|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_{Q_0}^{M-1}(x)dx\big)^{-1}\cdot\big\|\mathcal{M}_{s_1}\Big(f\cdot\tilde{\chi}_{Q_0}^{\frac{M-1}{s_1}}\Big)\big\|_{s_1,\infty}^{s_1}\lesssim C^{-s_1}|Q_0|. \end{split}
$$

This proves the sparse property of the collection \mathcal{S} ; now we need to prove the sparse domination estimate. To this end, for every $Q \in \mathcal{S}$ we define \mathbb{P}_Q to be the collection of tri-tiles $P \in \mathbb{P}(Q)$ so that $I_P \subseteq Q$, but I_P is not contained in any other descendant of Q in \mathcal{S} . This implies in particular that every such tri-tile satisfies

$$
\left(\frac{1}{|I_P|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_{I_P}^M(x)dx\right)^{1/s_1}\leq C\cdot\left(\frac{1}{|Q|}\int_{\mathbb{R}}|f(x)|^{s_1}\cdot\tilde{\chi}_Q^{M-1}(x)dx\right)^{1/s_1},
$$

and similarly for g and h . We obtain in this way

$$
\left(\widetilde{\text{size}\,}_{\mathbb{P}_{Q}}|f|^{s_{1}}\right)^{1/s_{1}} \lesssim C \cdot \left(\frac{1}{|Q|} \int_{\mathbb{R}} |f(x)|^{s_{1}} \cdot \tilde{\chi}_{Q}^{M-1}(x) dx\right)^{1/s_{1}},
$$

and likewise,

$$
\left(\widetilde{\text{size}\,}_{\mathbb{P}_{Q}}|g|^{s_2}\right)^{1/s_2} \lesssim C\cdot \left(\frac{1}{|Q|}\int_{\mathbb{R}}|g(x)|^{s_2}\cdot \tilde{\chi}_Q^{M-1}(x)dx\right)^{1/s_2}, \quad \left(\widetilde{\text{size}\,}_{\mathbb{P}_{Q}}|h|^{s_3}\right)^{1/s_3} \lesssim C\cdot \left(\frac{1}{|Q|}\int_{\mathbb{R}}|h(x)|^{s_3}\cdot \tilde{\chi}_Q^{M-1}(x)dx\right)^{1/s_3}.
$$

 \Box

Noting that $\mathbb{P} = \bigcup$ $Q\bar{\epsilon}S$ \mathbb{P}_Q , we deduce the sparse domination of the trilinear form.

Eventually, the sparse domination we want to obtain doesn't concern the multilinear form, but rather an expression of the form $|| ||T(\vec{f}_1, \ldots, \vec{f}_n)||_{X'_{n+1}} \cdot v||_q^q$ $_q^q$ (estimate [\(10\)](#page-5-2) of Theorem [1\)](#page-4-0), where T is an *n*-(sub)linear operator, $\vec{f}_1, \ldots, \vec{f}_n$ are vector-valued functions and v is a locally q-integrable function, and $0 < q < \infty$. In this case too, the local estimates imply a sparse domination, and *subadditivity* is essential.

Proposition 13. Let $\|\cdot\|_{X_{n+1}}$ be a (quasi-)norm so that $\|\cdot\|_{X_{n+1}}^q$ X_{n+1} is subadditive for some $q > 0$. Let T be a n-(sub)linear operator determined by a collection $\mathbb P$ of multi-tiles, which satisfies the multiple vector-valued local estimate: there exist $s_1, \ldots, s_{n+1} \in (0, \infty)$ so that for any dyadic interval I_0 ,

$$
\|T_{\mathbb{P}(I_0)}(\vec{f}_1,\ldots,\vec{f}_n)\|_{X'_{n+1}}\cdot v\|_{q}^q \lesssim \prod_{j=1}^n \left(\widetilde{size}_{\mathbb{P}(I_0)}^{s_j} \|\vec{f}_j(x,\cdot)\|_{X_j}\right)^q \cdot \left(\widetilde{size}_{\mathbb{P}(I_0)}^{s_{n+1}} v\right)^q \cdot |I_0|.
$$

Then there exists a sparse family S of dyadic intervals, depending on the functions $\vec{f}_1, \ldots, \vec{f}_n, \upsilon$ and the Lebesgue exponents s_1, \ldots, s_{n+1}, q so that

$$
\left\| \|T_{\mathbb{P}}(\vec{f}_1,\ldots,\vec{f}_n)\|_{X'_{n+1}} \cdot v \right\|_{q}^q \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \|\vec{f}_j(x,\cdot)\|_{X_j}^{s_j} \cdot \tilde{\chi}_Q^{M-1} dx \Big)^{\frac{q}{s_j}} \cdot \Big(\frac{1}{|Q|} \int_{\mathbb{R}} |v|^{s_{n+1}} \cdot \tilde{\chi}_Q^{M-1} dx \Big)^{\frac{q}{s_{n+1}}} \cdot |Q|.
$$

Proof. The stopping time is identical to the one in the proof of Theorem [12.](#page-13-2) Once the collection S is defined in an analogous way, and once we have defined for every $Q \in S$ the

collection of descendants $ch_{\mathcal{S}}(Q)$ and the collection of tiles \mathbb{P}_Q , we only need to notice that

$$
\|T_{\mathbb{P}}(\vec{f}_{1},\ldots,\vec{f}_{n})\|_{X'_{n+1}} \cdot v\|_{q}^{q} \lesssim \sum_{Q \in \mathcal{S}} \|T_{\mathbb{P}_{Q}}(\vec{f}_{1},\ldots,\vec{f}_{n})\|_{X'_{n+1}} \cdot v\|_{q}^{q}
$$

$$
\lesssim \prod_{j=1}^{n} (\widetilde{\text{size}}_{\mathbb{P}_{Q}}^{s_{j}} \| \vec{f}_{j}(x,\cdot)\|_{X_{j}})^{q} \cdot (\widetilde{\text{size}}_{\mathbb{P}_{Q}}^{s_{n+1}} v)^{q} \cdot |Q|
$$

$$
\lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^{n} (\frac{1}{|Q|} \int_{\mathbb{R}} \| \vec{f}_{j}(x,\cdot)\|_{X_{j}}^{s_{j}} \cdot \widetilde{\chi}_{Q}^{M-1} dx)^{\frac{q}{s_{j}}} \cdot (\frac{1}{|Q|} \int_{\mathbb{R}} |v|^{s_{n+1}} \cdot \widetilde{\chi}_{Q}^{M-1} dx)^{\frac{q}{s_{n+1}}} \cdot |Q|.
$$

3.2. From restricted-type to general functions. Here we present a technical lemma, which allows to pass from local estimates for restricted-type functions to local estimates for general functions.

Let I_0 be a fixed dyadic interval and $\mathbb P$ a finite collection of tritiles; recall the notations

$$
\mathbb{P}(I_0) \coloneqq \{ P \in \mathbb{P} : I_P \subseteq I_0 \} \quad \text{and} \quad \mathbb{P}(I_0)^+ \coloneqq \mathbb{P}(I_0) \cup P_{I_0},
$$

where P_{I_0} is some tritile (not necessarily contained in \mathbb{P}) with spatial interval I_0 .

Proposition 14 (Mock interpolation). Assume Λ is a trilinear form associated to the collection P, satisfying

$$
\left|\Lambda_{\mathbb{P}(I_0)}(f,g,h)\right| \lesssim \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_{F} \cdot \tilde{\chi}_{I_P} dx\right)^{\alpha_1} \cdot \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_{G} \cdot \tilde{\chi}_{I_P} dx\right)^{\alpha_2} \cdot \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_{H'} \cdot \tilde{\chi}_{I_P} dx\right)^{\alpha_3} \cdot |I_0|,
$$

 $for any F,G and H'$ sets of finite measure and any functions f, g, h such that $|f(x)| \le$ $1_F(x), |g(x)| \leq 1_G(x)$ and $|h(x)| \leq 1_{H'}(x)$. Then for any triple (p_1, p_2, p_3) satisfying $p_i\alpha_i >$ 1, and any functions f, g and h locally integrable, we have

$$
\left|\Lambda_{\mathbb{P}(I_0)}(f,g,h)\right| \lesssim
$$

$$
\sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \left| f \cdot \tilde{\chi}_{I_P} \right|^{p_1} dx \right)^{\frac{1}{p_1}} \cdot \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \left| g \cdot \tilde{\chi}_{I_P} \right|^{p_2} dx \right)^{\frac{1}{p_2}} \cdot \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \left| h \cdot \tilde{\chi}_{I_P} \right|^{p_3} dx \right)^{\frac{1}{p_3}} \cdot |I_0|.
$$

The implicit constants in both inequalities above may depend on the α_i and p_i , but are independent of the collection of tritiles and of the interval I_0 .

Proof. Any function can be decomposed according to its level sets; more exactly, we have

(30)
$$
f = \sum_{k_1} f \cdot \mathbf{1}_{\{2^{k_1-1} \leq |f| \leq 2^{k_1}\}} := \sum_{k_1} 2^{k_1} f_{k_1} := \sum_{k_1} 2^{k_1} f_{k_1} \cdot \mathbf{1}_{F_{k_1}}.
$$

The above notation means that $F_{k_1} = \{2^{k_1-1} \leq |f| \leq 2^{k_1}\}$, and we note that the functions f_{k_1} satisfy $|f_{k_1}(x)| \leq \mathbf{1}_{F_{k_1}}(x)$.

Likewise, $g(x) = \sum_{k_2} 2^{k_2} g_{k_2} \cdot \mathbf{1}_{G_{k_2}}$ and $h(x) = \sum_{k_3} 2^{k_3} h_{k_2} \cdot \mathbf{1}_{H_{k_3}}$.

We estimate the trilinear form, using the multilinearity property and the hypotheses:

$$
\left|\Lambda_{\mathbb{P}(I_{0})}(f,g,h)\right| \leq \sum_{k_{1},k_{2},k_{3}} 2^{k_{1}} 2^{k_{2}} 2^{k_{3}} \left|\Lambda_{\mathbb{P}(I_{0})}(f_{k_{1}},g_{k_{2}},h_{k_{3}})\right|
$$

\n
$$
\lesssim \sum_{k_{1},k_{2},k_{3}} 2^{k_{1}} 2^{k_{2}} 2^{k_{3}} \sup_{P \in \mathbb{P}(I_{0})^{+}} \left(\frac{1}{|I_{P}|} \int_{\mathbb{R}} \mathbf{1}_{F_{k_{1}}} \cdot \tilde{\chi}_{I_{P}} dx\right)^{\alpha_{1}}
$$

\n
$$
\cdot \sup_{P \in \mathbb{P}(I_{0})^{+}} \left(\frac{1}{|I_{P}|} \int_{\mathbb{R}} \mathbf{1}_{G_{k_{2}}} \cdot \tilde{\chi}_{I_{P}} dx\right)^{\alpha_{2}} \cdot \sup_{P \in \mathbb{P}(I_{0})^{+}} \left(\frac{1}{|I_{P}|} \int_{\mathbb{R}} \mathbf{1}_{H_{k_{3}}} \cdot \tilde{\chi}_{I_{P}} dx\right)^{\alpha_{3}} \cdot |I_{0}|.
$$

Now we are left with proving

$$
\sum_{k} 2^{k} \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_{F_k} \cdot \tilde{\chi}_{I_P} dx \right)^{\alpha_1} \lesssim \sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} \left| f \cdot \tilde{\chi}_{I_P} \right|^{p_1} dx \right)^{\frac{1}{p_1}}.
$$

Each of the expressions on the left hand side are $L^{\frac{1}{\alpha_1}}$ maximal averages, and they are summable at the expense of loosing some information; in the end, we will have an L^{p_1} maximal average, with $p_1 > \frac{1}{\alpha}$ $\frac{1}{\alpha_1}$.

Let k_0 be so that

$$
\sup_{P \in \mathbb{P}(I_0)^+} \left(\frac{1}{|I_P|} \int_{\mathbb{R}} |f \cdot \tilde{\chi}_{I_P}|^{p_1} dx \right)^{\frac{1}{p_1}} \sim 2^{k_0}.
$$

We note the following: since $2^{k-1} \cdot \mathbf{1}_{F_k} \leq |f(x)| \cdot \mathbf{1}_{F_k}(x) \leq 2^k \cdot \mathbf{1}_{F_k}$, we have $\mathbf{1}_{F_k}(x) \leq$ $2^{-kp_1}|f(x)|^{p_1}$ and hence

(31)
$$
\frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_{F_k} \cdot \tilde{\chi}_{I_P} dx \lesssim 2^{-kp_1} \frac{1}{|I_P|} \int_{\mathbb{R}} |f(x) \cdot \tilde{\chi}_{I_P}|^{p_1} dx \lesssim 2^{(k_0 - k)p_1}.
$$

Here we need to be more cautious; the adapted weights $\tilde{\chi}_{I_P}$ appearing on the left and right hand side above are not exactly the same, but one of them is a power of the other. Nevertheless, the wave packets associated to the tritiles in $\mathbb P$ can have arbitrary decay, and for that reason we will not worry about the possibly different $\tilde{\chi}_{I_P}$.

On the other hand, we have the trivial inequality

$$
\frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_{F_k} \cdot \tilde{\chi}_{I_P} dx \lesssim 1.
$$

Taking the sup over $P \in \mathbb{P}(I_0)^+$ in the expression above, as well as in [\(31\)](#page-17-0), we obtain that

$$
\sup_{P\in\mathbb{P}(I_0)^+}\left(\frac{1}{|I_P|}\int_{\mathbb{R}}\mathbf{1}_{F_k}\cdot\tilde{\chi}_{I_P}dx\right)^{\alpha_1}\lesssim\min\big(1,2^{(k_0-k)p_1\alpha_1}\big).
$$

Then we are ready for the final estimate:

$$
\sum_{k} 2^{k} \sup_{P \in \mathbb{P}(I_{0})^{+}} \left(\frac{1}{|I_{P}|} \int_{\mathbb{R}} \mathbf{1}_{F_{k}} \cdot \tilde{\chi}_{I_{P}} dx \right)^{\alpha_{1}} \n\lesssim \sum_{k \leq k_{0}} 2^{k} \sup_{P \in \mathbb{P}(I_{0})^{+}} \left(\frac{1}{|I_{P}|} \int_{\mathbb{R}} \mathbf{1}_{F_{k}} \cdot \tilde{\chi}_{I_{P}} dx \right)^{\alpha_{1}} + \sum_{k > k_{0}} 2^{k} \sup_{P \in \mathbb{P}(I_{0})^{+}} \left(\frac{1}{|I_{P}|} \int_{\mathbb{R}} \mathbf{1}_{F_{k}} \cdot \tilde{\chi}_{I_{P}} dx \right)^{\alpha_{1}} \n\lesssim \sum_{k \leq k_{0}} 2^{k} + \sum_{k > k_{0}} 2^{k} 2^{(k_{0} - k)p_{1}\alpha_{1}} \lesssim 2^{k_{0}} + 2^{k_{0}} \sum_{k > k_{0}} 2^{(k - k_{0})(1 - p_{1}\alpha_{1})} \lesssim 2^{k_{0}}.
$$

provided $1 - p_1 \alpha_1 < 0$.

In our application to BHT, we will have $\alpha_j = \frac{1+\theta_j}{2}$ $\frac{1+\theta_j}{2}$ and $\frac{1}{p_j} = \frac{1+\theta_j}{2}$ $\frac{\partial^2 u_j}{\partial x^2} - \epsilon < \alpha_j$, hence the conditions in Proposition [14](#page-16-1) are satisfied.

Using the notation in (24) , the above proposition and (25) imply the following local estimate for the model operator of the bilinear Hilbert transform:

Proposition 15. If I_0 is a fixed dyadic interval and $\Lambda_{\mathbb{P}(I_0)}$ is a model trilinear form associated to the BHT operator, we have

$$
\left|\Lambda_{\mathbb{P}(I_0)}(f,g,h)\right| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{p_1}f\right) \cdot \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{p_2}g\right) \cdot \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{p_3}h\right) \cdot |I_0|,
$$

where $\frac{1}{p_j} = \frac{1+\theta_j}{2}$ $\frac{\partial^2 u}{\partial x^2} - \epsilon$, for any $0 \le \theta_1, \theta_2, \theta_3 < 1$ with $\theta_1 + \theta_2 + \theta_3 = 1$ and any $\epsilon > 0$ small enough. Remark:. The result of Proposition [14](#page-16-1) can be easily extended to a more general setting: if T is a vector-valued operator so that $\|\cdot\|^q_{\frac{1}{r}}$ $\frac{q}{L^{R^{\prime}_{n+1}}}$ and $\|\cdot\|_q^q$ are subadditive, for which we have

$$
\left\| \|T_{\mathbb{P}(I_0)}(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R_{n+1}'}} \cdot \mathbf{1}_{\tilde{E}_{n+1}} \right\|_q^q \lesssim \prod_{j=1}^n \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j} \right)^{\alpha_j} \cdot \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{\tilde{E}_{n+1}} \right)^{\alpha_{n+1}} \cdot |I_0|
$$

for any sets $E_1,\ldots,E_n,\tilde{E}_{n+1}$ of finite measure, any vector-valued functions $\vec{f}_1,\ldots,\vec{f}_n$ such that $\|\vec{f}_j(x)\|_{X_j} \leq \mathbf{1}_{E_j}$ for all $1 \leq j \leq n$, and v a locally q-integrable function so that $|v(x)| \leq$ $\mathbf{1}_{\tilde{E}_{n+1}}$ then also

$$
\|T_{\mathbb{P}(I_0)}(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R_{n+1}'}}\cdot v\|_{q}^q \lesssim \prod_{j=1}^n \left(\widetilde{size\,I_0}^{p_j} \|\vec{f}_j\|_{X_j}\right)^q \cdot \left(\widetilde{size\,I_0}^{p_{n+1}}(v)\right)^q \cdot |I_0|,
$$

for any vector-valued functions $\vec{f}_1, \ldots, \vec{f}_n$, any locally q-integrable function v, and any Lebesgue exponents p_1, \ldots, p_{n+1} satisfying for all $1 \leq j \leq n+1$, $p_j > \frac{q}{q}$ $\frac{q}{\alpha_j}$.

In order to obtain the localized estimates for multiple vector-valued extensions, we make use of the helicoidal method, as presented in the following Section [4.](#page-20-0)

3.3. Additional details on sparse domination via the helicoidal method. With the purpose of making clear and comprehensible the ideas behind our method, we take another look at the BHT example. We've seen in Section [3.1](#page-13-3) that sparse domination for restricted-type functions is implied by the fundamental local estimate from [\[BM16\]](#page-57-0):

(32)
$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 \left(\widetilde{\text{size}\,}_{I_0} \, \mathbf{1}_{E_j}\right)^{\frac{1+\theta_j}{2}} \cdot |I_0|
$$

which holds for all fixed dyadic intervals $I_0 \subseteq \mathbb{R}$ and all functions satisfying $|f_j| \leq \mathbf{1}_{E_j}$ with E_i measurable subsets of the real line having finite measure.

This yields a sparse collection S of dyadic intervals (depending on the functions f_1, f_2 and f_3), for which

(33)
$$
|\Lambda(f_1, f_2, f_3)| \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^3 \left(ave_Q^{p_j} \mathbf{1}_{E_j}\right) \cdot |Q|,
$$

where $\frac{1}{p_j} = \frac{1+\theta_j}{2}$ $\frac{\partial^2 y}{\partial^2}$ for some $0 \le \theta_1, \theta_2, \theta_3 < 1$ with $\theta_1 + \theta_2 + \theta_3 = 1$.

Conversely, assuming [\(33\)](#page-18-0), one can observe that

$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \sum_{\substack{Q \in \mathcal{S} \\ Q \subseteq I_0}} \prod_{j=1}^3 \left(ave_Q^{p_j} \mathbf{1}_{E_j} \right) \cdot |Q| \lesssim \prod_{j=1}^3 \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j} \right)^{\frac{1+\theta_j}{2}} \cdot |I_0|.
$$

This is an easy consequence of the sparseness property of the collection $S: \sum$ \bar{Q} ∈ ${\cal S}$ $Q\subseteq I_0$ $|Q|$ ≲ $|I_0|$.

In other words, the two estimates [\(32\)](#page-18-1) and [\(33\)](#page-18-0) are essentially equivalent to each other. In particular, in order to prove [\(33\)](#page-18-0) for arbitrary functions, all one has to do is prove the local inequality [\(32\)](#page-18-1) for arbitrary functions. Namely, it suffices to prove

(34)
$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 \left(\widetilde{\text{size}}_{I_0}^{p_j} f_j \right) \cdot |I_0|.
$$

Let us recall now how [\(32\)](#page-18-1) has been proved in [\[BM16\]](#page-57-0): start with the generic "size and energy" estimate from [\[MTT04\]](#page-59-7)

(35)
$$
|\Lambda_{\mathbb{P}}(f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 \left(\text{size}_{\mathbb{P}} f_j\right)^{\theta_j} \cdot \left(\text{energy}_{\mathbb{P}} f_j\right)^{1-\theta_j},
$$

valid for all rank-1 collections of tiles $\mathbb P$ and $0 \le \theta_1, \theta_2, \theta_3 < 1$ so that $\theta_1 + \theta_2 + \theta_3 = 1$. Above, size p f is a maximal square function which satisfies size p f \leq size p f, while energy pf \leq |f|2 for any function f nice enough (see Definition 6.1 in $[MTT04]$).

Subsequently, localize [\(35\)](#page-19-0) to a fixed dyadic interval I_0 to get

(36)
$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)} f_j\right)^{\theta_j} \cdot \left(\text{energy}_{\mathbb{P}(I_0)} f_j\right)^{1-\theta_j}.
$$

Hence the estimate [\(32\)](#page-18-1), which is central to proving vector-valued and sparse estimates, follows from the localized "size and energy" inequality [\(36\)](#page-19-1) above, once we prove for all $1 \leq j \leq 3$ and all functions f_j satisfying $|f_j| \leq \mathbf{1}_{E_j}$ that

(37)
$$
\left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} f_j\right)^{\theta_j} \cdot \left(\text{energy}\,_{\mathbb{P}(I_0)} f_j\right)^{1-\theta_j} \lesssim \left(\widetilde{\text{size}\,}_{I_0}^{p_j} \mathbf{1}_{E_j}\right)^{\frac{1+\theta_j}{2}} \cdot |I_0|^{\frac{1-\theta_j}{2}}.
$$

This follows from the fact that the energy $\mathbb P$ localizes well:

energy
$$
\mathbb{P}(I_0) f_j \leq ||f_j \cdot \tilde{\chi}_{I_0}||_{L^2} \leq ||\mathbf{1}_{E_j} \cdot \tilde{\chi}_{I_0}||_{L^2} = (\text{ave }_{I_0} \mathbf{1}_{E_j})^{\frac{1}{2}} \cdot |I_0|^{\frac{1}{2}},
$$

an estimate that had already appeared in a somehow different form in [\[MTT02\]](#page-59-4), and which we prove later on in Lemma [18.](#page-26-0)

Returning now to [\(34\)](#page-18-2), the local estimate for general functions, two comments are in order. First, if [\(34\)](#page-18-2) is true for the indices $p_j = \frac{2}{1+y}$ $\frac{2}{1 + \theta_j}$, then it also holds for $p_j > \frac{2}{1 + \theta_j}$ $\frac{2}{1+\theta_j}$, as an application of Hölder's inequality. And second, in order to prove sparse domination, one does not need [\(34\)](#page-18-2) in its full generality, but only in the particular case when

(38)
$$
\text{ave}_{I_P}^{p_j} f_j \leq \text{ave}_{I_0}^{p_j} f_j, \quad \text{for all } P \in \mathbb{P}(I_0), \quad \text{i.e.} \quad \widetilde{\text{size}}_{I_0}^{p_j} f_j \leq \text{ave}_{I_0}^{p_j} f_j
$$

for all $1 \leq j \leq 3$. This is a simple consequence of the earlier stopping time argument. The reader familiar with the terminology of outer measures of [\[DT15\]](#page-58-22) would recognize that

size
$$
_{\mathbb{P}} f_j \simeq ||F_j||_{\mathcal{L}^{\infty}}
$$
, while energy $_{\mathbb{P}} f_j \simeq ||F_j||_{\mathcal{L}^{2,\infty}}$

when $F_j : \mathbb{P} \to \mathbb{C}$ is defined by $F_j(P) \coloneqq \langle f_j, P \rangle$ for all $P \in \mathbb{P}$. The outer measure spaces \mathcal{L}^q (for $2 < q < \infty$) of [\[DT15\]](#page-58-22) are defined precisely so as to generalize this correspondence.

In particular, the quantity $\left(\text{size}_{\mathbb{P}(I_0)} f_j\right)^{\theta_j} \cdot \left(\text{energy}_{\mathbb{P}(I_0)} f_j\right)^{1-\theta_j}$ of [\(35\)](#page-19-0) interpolates naturally between these two spaces and because of this we will denote it by $||F_j||_{\mathcal{L}^{q_j}_{mock}}$, where 1 $\frac{1}{q_j} := \frac{1-\theta_j}{2}$ $\frac{-\theta_j}{2} + \frac{\theta_j}{\infty}$. Then the original size and energy estimate [\(35\)](#page-19-0) can be written as

(39)
$$
|\Lambda_{\mathbb{P}}(f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 \|F_j\|_{\mathcal{L}_{mock}^{q_j}},
$$

while [\(37\)](#page-19-2) becomes, for all $1 \leq j \leq 3$ and all $p_j > \frac{2}{1+t}$ $\frac{2}{1+\theta_j},$

(40)
$$
||F_j||_{\mathcal{L}_{mock}^{q_j};I_0} \lesssim (\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{p_j} \mathbf{1}_{E_j}) \cdot |I_0|^{\frac{1}{q_j}}.
$$

Equivalently, to prove [\(32\)](#page-18-1), one could have used the estimate

$$
|\Lambda_{\mathbb{P}}(f_1, f_2, f_3)| \lesssim \prod_{j=1}^3 ||F_j||_{\mathcal{L}^{q_j}}
$$

from [\[DT15\]](#page-58-22) instead of [\(39\)](#page-19-3), and also the analogue of [\(40\)](#page-19-4)

(41)
$$
\|F_j\|_{\mathcal{L}^{q_j};\mathbb{P}(I_0)} \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{p_j} \mathbf{1}_{E_j}\right) \cdot |I_0|^{\frac{1}{q_j}}
$$

for $1 \leq j \leq 3$.

Note that [\(41\)](#page-20-1) is a consequence of [\(40\)](#page-19-4) from [\[BM16\]](#page-57-0), since

$$
||F_j||_{\mathcal{L}^{q_j};\mathbb{P}} \lesssim ||F_j||_{\mathcal{L}^{q_j}_{mock};\mathbb{P}}.
$$

A brief proof of this inequality can be found in Proposition 4 of [\[BM18\]](#page-58-2).

To sum up, sparse domination for arbitrary functions would follow from inequality [\(41\)](#page-20-1) under the assumption [\(38\)](#page-19-5), namely that

(42)
$$
\|F_j\|_{\mathcal{L}^{q_j}; \mathbb{P}(I_0)} \lesssim \left(\mathrm{ave}^{p_j}_{\mathbb{P}(I_0)} f_j\right) \cdot |I_0|^{\frac{1}{q_j}}.
$$

The proof of [\(42\)](#page-20-2) for general functions has been worked out in [\[CDPO16\]](#page-58-13), Proposition 4.1. As explained before, this implies sparse domination as in [\(33\)](#page-18-0) for indices p_i that satisfy $p_j > \frac{2}{1+t}$ $\frac{2}{1+\theta_j}$ for all $1 \leq j \leq 3$. Our main observation is that [\(34\)](#page-18-2) follows from the original one [\(32\)](#page-18-1) via a very short interpolation argument. This fact has very important consequences; in particular, it allows us to prove sparse domination also in the multiple vector-valued case essentially without any extra effort, since it is known form [\[BM16\]](#page-57-0) that [\(32\)](#page-18-1) is true in this case as well. For more connections with the theory of outer measures, the reader is referred to Section 2.3 of [\[BM18\]](#page-58-2).

4. Vector-valued estimates via the helicoidal method: a review

Although we present the helicoidal method in the special context of the bilinear Hilbert transform operator, it generalizes to many other operators whose multilinear form can be represented as in [\(1\)](#page-2-2).

4.1. The stopping time for vector-valued estimates. Here we recall some technical aspects from [\[BM16\]](#page-57-0), drawing attention to the stopping times involved in proving the multiple vector-valued estimates, which will be later compared to the stopping times used for proving sparse domination (see the following Section [4.2\)](#page-24-1). The goal is to show that $BHT: L^p(\ell^{r_1}) \times L^q(\ell^{r_2}) \to L^s(\ell^r)$, where (p,q,s) and (r_1,r_2,r) are Hölder tuples, with $r \geq 1$. Since we want to illustrate how the local estimate implies the vector-valued result, we turn away form the slightly more technical cases $r_1 = \infty, r_2 = \infty$ or $r < 1$. Hence, we want to show 1

$$
\left\| \left(\sum_{k} |BHT(f_k, g_k)|^r \right)^{\frac{1}{r}} \right\|_s \lesssim \left\| \left(\sum_{k} |f_k|^{r_1} \right)^{\frac{1}{r_1}} \right\|_p \left\| \left(\sum_{k} |g_k|^{r_2} \right)^{\frac{1}{r_2}} \right\|_q.
$$

By vector-valued restricted weak type interpolation (see, for example [\[BM16\]](#page-57-0)), it is sufficient to prove the following statement:

for any given F, G and H sets of finite measure, there exists $H' \subseteq H$ major subset such that for any vector-valued functions $\vec{f} = \{f_k\}, \vec{g} = \{g_k\}$ and $\vec{h} = \{h_k\}$ satisfying

$$
\left(\sum_{k}|f_{k}(x)|^{r_{1}}\right)^{\frac{1}{r_{1}}}\leq\mathbf{1}_{F},\quad\left(\sum_{k}|g_{k}(x)|^{r_{1}}\right)^{\frac{1}{r_{2}}}\leq\mathbf{1}_{G},\quad\left(\sum_{k}|h_{k}(x)|^{r'}\right)^{\frac{1}{r'}}\leq\mathbf{1}_{H'},
$$

we have

(43)
$$
|\sum_{k} \Lambda_{BHT;\mathbb{P}}(f_k, g_k, h_k)| \lesssim |F|^{\alpha_1} \cdot |G|^{\alpha_2} \cdot |H|^{\alpha_3},
$$

for $(\alpha_1, \alpha_1, \alpha_3)$ a tuple satisfying $\alpha_1 + \alpha_2 + \alpha_3 = 1$, arbitrarily close to $(\frac{1}{n})$ $\frac{1}{p}, \frac{1}{q}$ $\frac{1}{q}, \frac{1}{s'}$ $\frac{1}{s'}$).

Most often, the major subset H' is the part of H where \vec{f}, \vec{g} are under control: if

$$
\Omega \coloneqq \big\{ x : \mathcal{M} \mathbf{1}_F(x) > C \, \frac{|F|}{|H|}, \, \mathcal{M} \mathbf{1}_G(x) > C \, \frac{|G|}{|H|} \big\},
$$

then we set $H' \coloneqq H \setminus \Omega$.

Upon obtaining a proper local estimate, a triple stopping time will be performed, according to the sizes of the functions. For this reason we assume that the tiles satisfy, for $d \geq 0$,

$$
1 + \frac{\text{dist}(I_P, \Omega^c)}{|I_P|} \sim 2^d,
$$

and we need to obtain a certain decay 2^{-10d} in the restricted-type inequality [\(43\)](#page-21-0).

The next step consists in proving, for $1 < r_1, r_2, r' < \infty$, the local estimate

(44)
$$
\left|\Lambda_{\mathbb{P}(I_0)}(f_k \cdot \mathbf{1}_F, g_k \cdot \mathbf{1}_G, h_k \cdot \mathbf{1}_{H'})\right| \lesssim \left\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\right\| \|f_k \cdot \tilde{\chi}_{I_0}^{M}\|_{r_1} \|g_k \cdot \tilde{\chi}_{I_0}^{M}\|_{r_2} \|h_k \cdot \tilde{\chi}_{I_0}^{M}\|_{r'},
$$

where $\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\|$ $\mathbb{P}(I_0, H)$ represents the operatorial norm of the localized trilinear form where the extra information is retained, and it equals

$$
\left\| \Lambda_{\mathbb{P}(I_0)}^{F,G,H'} \right\| = \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_F \right)^{\frac{1+\theta_1}{2} - \frac{1}{r_1} - \epsilon} \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_G \right)^{\frac{1+\theta_2}{2} - \frac{1}{r_2} - \epsilon} \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_{H'} \right)^{\frac{1+\theta_3}{2} - \frac{1}{r'} - \epsilon}.
$$

Then we use Hölder to recover the Lebesgue norms of $1_F, 1_G, 1_{H'}$. If we ignored the operatorial norm $\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\|$ $\mathbb{P}_{\mathbb{P}(I_0)}^{F,G,H'}$, we could only retrieve $|F|^{\frac{1}{r_1}} \cdot |G|^{\frac{1}{r_2}} \cdot |H|^{\frac{1}{r'}}$, which can be very different from the desired expression $|F|^{\frac{1}{p}}|G|^{\frac{1}{q}}|H|^{\frac{1}{s'}}$. So in order to obtain all the possible vector-valued estimates, we had to take into account $\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\|$ $\mathbb{P}(I_0, I_{\mathbb{P}(I_0)})$, and moreover, to secure largest possible exponents for the sizes.

Overall, the constraint we obtained for r_1, r_2, r' and p, q, s' , reduces to the existence of $0 \le \theta_1, \theta_2, \theta_3 < 1$ with $\theta_1 + \theta_2 + \theta_3 = 1$, so that we have simultaneously

$$
\frac{1+\theta_1}{2}>\max\left(\frac{1}{r_1},\frac{1}{p}\right), \qquad \frac{1+\theta_2}{2}>\max\left(\frac{1}{r_2},\frac{1}{q}\right) \quad \text{and} \quad \frac{1+\theta_3}{2}>\max\left(\frac{1}{r'},\frac{1}{s'}\right).
$$

In order to prove [\(44\)](#page-21-1), we use restricted-type interpolation and the local estimate [\(17\)](#page-10-0) that has already appeared in the introduction. Assuming that $|f_k(x)| \leq \mathbf{1}_{E_1}, |g_k(x)| \leq \mathbf{1}_{E_2}$ and $|h_k(x)| \leq \mathbf{1}_{E'_3}$ and that $I \subseteq I_0$ is a fixed dyadic interval, we have

$$
\big|\Lambda_{{\mathbb P}(I)}\big(f_k\cdot\mathbf{1}_F,g_k\cdot\mathbf{1}_G,h_k\cdot\mathbf{1}_{H'}\big)\big|\lesssim \Big(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_F\cdot\mathbf{1}_{E_1}\Big)^{\frac{1+\theta_1}{2}-\epsilon}\cdot \Big(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_G\cdot\mathbf{1}_{E_2}\Big)^{\frac{1+\theta_2}{2}-\epsilon}\cdot \Big(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{H'}\cdot\mathbf{1}_{E'_3}\Big)^{\frac{1+\theta_3}{2}-\epsilon}\cdot |I|.
$$

Through a triple stopping time, we can recover the L^{r_1}, L^{r_2} and $L^{r'}$ norms of the functions f_k, g_k and h_k respectively, while $\|\Lambda_{\mathbb{P}(I_0)}^{F,G,H'}\|$ $\mathbb{P}(I_0, H)$ represents a "surplus" that will be used later on, when deciding the range of exponents p, q, s . This last part in which we retrieve the L^{r_1} norm of f_k and L^{r_2} norm of g_k uses the same argument as the proof of boundedness of BHT from [\[MTT04\]](#page-59-7): the amelioration, which will allow us to obtain the vector-valued estimate, relies in the localization of the energy .

Applying Hölder in (44) , we obtain a vector-valued local estimate corresponding to a vector-valued version of the fundamental local result [\(32\)](#page-18-1):

$$
(45) \quad \left|\sum_{k}\Lambda_{\mathbb{P}(I_{0})}(f_{k},g_{k},h_{k})\right|\lesssim\left(\widetilde{\text{size}\,}_{I_{0}}\mathbf{1}_{F}\right)^{\frac{1+\theta_{1}}{2}-\epsilon}\cdot\left(\widetilde{\text{size}\,}_{I_{0}}\mathbf{1}_{G}\right)^{\frac{1+\theta_{2}}{2}-\epsilon}\cdot\left(\widetilde{\text{size}\,}_{I_{0}}\mathbf{1}_{H'}\right)^{\frac{1+\theta_{3}}{2}-\epsilon}\cdot|I_{0}|.
$$

This will be used, together with a stopping time that will be described shortly, in order to obtain the general vector-valued inequality. The stopping times are, in some sense, reversing the localization procedure: we need to find the good intervals that allow us to sum up the sizes, so that size $I_0\mathbf{1}_F$ should be related somehow to $|F|$, and the same for the functions $\mathbf{1}_G$ and $\mathbf{1}_{H'}$.

The triple stopping time used in [\[BM16\]](#page-57-0) yields three collections of intervals $\mathcal{I}_i^{n_j}$ $j^{\prime\prime}$ (one for each function $\mathbf{1}_F, \mathbf{1}_G$ and $\mathbf{1}_{H'}$, and associated to each of these, a subcollection $\mathbb{P}_{I_i} \subseteq \mathbb{P}$ of tritiles, where $1 \leq j \leq 3$. Once we have these, for every $I_0 = I_1 \cap I_2 \cap I_3$, where $I_j \in \mathcal{I}_j^{n_j}$ $j^{\prime\prime}$, we need to consider $\Lambda_{\mathbb{P}_{I_0}}(f,g,h)$. Here $\mathbb{P}_{I_0} := \bigcap$ $\bigcap_j \mathbb{P}_{I_j}.$

In fact, the trilinear form $\Lambda_{\mathbb{P}}(f_k, g_k, h_k)$ is bounded above by

$$
\left|\Lambda_{\mathbb{P}}(f_k, g_k, h_k)\right| \lesssim \sum_{n_1, n_2, n_3} \sum_{\substack{I_0 = I_1 \cap I_2 \cap I_3 \\ I_j \in \mathcal{I}_j^{n_j}}} \left|\Lambda_{\mathbb{P}_{I_0}}(f_k, g_k, h_k)\right|.
$$

The intervals $I_1 \in \mathcal{I}_1^{n_1}$ and the collections $\mathbb{P}_{I_1} \subseteq \mathbb{P}(I_1)$ of tritiles are chosen so that $\widetilde{\text{size}\,}_{F_1} 1_F \sim 2^{-n_1} \sim \text{ave}\,_{I_1} 1_F$, and similarly for the sizes of 1_G and $1_{H'}$ respectively. Since we will be considering the intersection $\mathbb{P}_{I_0} := \bigcap$ $\bigcap_j \mathbb{P}_{I_j}$, and the size is a maximal function at the level of the tritiles, we want to make sure that

$$
\widetilde{\text{size}\,}_{\mathbb P'_{I_1}} \mathbf 1_F \lesssim \widetilde{\text{size}\,}_{\mathbb P_{I_1}} \mathbf 1_F \sim \text{ave}\,_{I_1} \mathbf 1_F
$$

whenever \mathbb{P}'_{I_1} is a subcollection of \mathbb{P}_{I_1} .

For this reason, we set $\mathbb{P}_{Stock} := \mathbb{P}$, and start with the maximal possible size for $\mathbf{1}_F$ (which is going to be bounded nevertheless by $\min(1, 2^d C |F|)$), say $2^{-\bar{n}_1}$. Then set

$$
\mathbb{P}_{\bar{n}_1} \coloneqq \{ P \in \mathbb{P}_{Stock} : \frac{1}{|I_P|} \int_{\mathbb{R}} \mathbf{1}_F \cdot \tilde{\chi}_{I_P}^M dx \sim 2^{-\bar{n}_1} \}.
$$

The family $\mathcal{I}_1^{\bar{n}_1}$ will consist of maximal dyadic intervals I_1 so that there exists $P \in \mathbb{P}_{\bar{n}_1}$ with $I_P \subseteq I_1$, and moreover, we require that

$$
2^{-\bar{n}_1 - 1} \le \frac{1}{|I_1|} \int_{\mathbb{R}} \mathbf{1}_{F} \cdot \tilde{\chi}_{I_1}^M dx \le 2^{-\bar{n}_1}.
$$

Clearly, $\mathcal{I}_{\bar{n}_1} \neq \emptyset$ unless $\mathbb{P}_{\bar{n}_1} = \emptyset$, and all the intervals $I_1 \in \mathcal{I}_1^{\bar{n}_1}$ are mutually disjoint.

Then we set $\mathbb{P}_{I_1} \coloneqq \{P \in \mathbb{P}_{Stock} : I_P \subseteq I_1\}$, and we note that, for any subset $\mathbb{P}' \subseteq \mathbb{P}_{I_1}$,

$$
\widetilde{\text{size}\,}_{\mathbb{P}'} \mathbf{1}_F \lesssim 2^{-\bar{n}_1}.
$$

Before repeating the algorithm, we set \mathbb{P}_{Stock} := $\mathbb{P}_{Stock} \setminus \bigcup$ I_1 ∈ $\mathcal{I}_1^{\bar{n}_1}$ \mathbb{P}_{I_1} . As a consequence, the

maximal possible size $\mathbf{1}_F$ decreases.

We continue the construction of $\mathcal{I}_1^{\bar{n}_1+1}, \mathcal{I}_1^{\bar{n}_1+2}, \dots$ (which could be empty), until $\mathbb{P}_{Stock} = \emptyset$. Two properties are especially important:

(1) for every n_1 so that $\mathcal{I}_1^{n_1} \neq \emptyset$, we have \sum $I\overline{\epsilon\mathfrak{I}_1^{n_1}}$ $|I| \lesssim 2^{n_1} |F|.$

(2) $\widetilde{\text{size}}_{\mathbb{P}'_1} \mathbf{1}_F \lesssim \widetilde{\text{size}}_{\mathbb{P}_{I_1}} \mathbf{1}_F \lesssim 2^{-n_1} \lesssim \min(1, 2^d |F|/|H|)$, whenever \mathbb{P}'_{I_1} is a subcollection of \mathbb{P}_{I_1} .

The stopping times for size $\mathbf{1}_G$ and size $\mathbf{1}_{H'}$ are very similar, with the exception that $\widetilde{\text{size}} \, \mathbb{P}_{I_3} \mathbf{1}_{H'} \lesssim 2^{-n_3} \lesssim 2^{-Md}$. We end by recalling how to deduce [\(43\)](#page-21-0) from [\(45\)](#page-22-0):

$$
\left| \sum_{k} \Lambda_{\mathbb{P}}(f_{k}, g_{k}, h_{k}) \right| \lesssim \sum_{n_{1}, n_{2}, n_{3}} \sum_{I_{0} = I_{1} \cap I_{2} \cap I_{3}} \sum_{k} \left| \Lambda_{\mathbb{P}_{I_{0}}}(f_{k}, g_{k}, h_{k}) \right|
$$

$$
\lesssim \sum_{n_{1}, n_{2}, n_{3}} \sum_{I_{0} = I_{1} \cap I_{2} \cap I_{3}} \left(\widetilde{\text{size}}_{I_{0}} \mathbf{1}_{F} \right)^{\frac{1+\theta_{1}}{2} - \epsilon} \cdot \left(\widetilde{\text{size}}_{I_{0}} \mathbf{1}_{G} \right)^{\frac{1+\theta_{2}}{2} - \epsilon} \cdot \left(\widetilde{\text{size}}_{I_{0}} \mathbf{1}_{H'} \right)^{\frac{1+\theta_{3}}{2} - \epsilon} \cdot \left| I_{0} \right|
$$

$$
\lesssim \sum_{n_{1}, n_{2}, n_{3}} 2^{-n_{1} \left(\frac{1+\theta_{1}}{2} - \epsilon - \gamma_{1} \right)} \cdot 2^{-n_{2} \left(\frac{1+\theta_{2}}{2} - \epsilon - \gamma_{2} \right)} \cdot 2^{-n_{3} \left(\frac{1+\theta_{3}}{2} - \epsilon - \gamma_{3} \right)} \cdot |F|^{\gamma_{1}} \cdot |G|^{\gamma_{2}} \cdot |H|^{\gamma_{3}},
$$

where $0 \leq \gamma_1, \gamma_2, \gamma_3 \leq 1$, with $\gamma_1 + \gamma_2 + \gamma_3 = 1$. Since

$$
2^{-n_1} \le \min(1, 2^d |F|/|H|), \quad 2^{-n_2} \le \min(1, 2^d |G|/|H|), \quad 2^{-n_3} \le 2^{-Md},
$$

we obtain [\(43\)](#page-21-0) for $0 < \alpha_1 \leq \frac{1+\theta_1}{2}$ $+\theta_1$
2 - ϵ , 0 < $\alpha_2 \leq \frac{1+\theta_2}{2}$ $+\frac{\theta_2}{2} - \epsilon, 0 < \alpha_3 \leq \frac{1+\theta_3}{2}$ $\frac{\alpha_3}{2} - \epsilon$, and $\alpha_1 + \alpha_2 + \alpha_3 = 1$.

Lastly, we present a geometric property of the collection of intervals obtained through the stopping times above.

Proposition 16. The collection $\mathfrak{I}_1 := \bigcup_{n_1} \mathfrak{I}_1^{n_1}$ of dyadic intervals satisfies a κ -Carleson condition, i.e. there exists $\kappa \geq 1$ so that for every $I \in \mathcal{I}_1$, we have

(46)
$$
\sum_{\substack{I' \in \mathcal{I}_1 \\ I' \subseteq I}} |I'| \leq \kappa |I|.
$$

Proof. If $I \in \mathcal{I}_1^n$ and $I' \in \mathcal{I}_1^m$ are so that $I' \subset I$, then $m > n$ and moreover, I' was selected first. This is due to the maximality of the intervals and because, in this situation,

$$
\frac{1}{|I|} \int_{\mathbb{R}} \mathbf{1}_{F} \cdot \tilde{\chi}_{I}^{M} dx \sim 2^{n}, \qquad \frac{1}{|I'|} \int_{\mathbb{R}} \mathbf{1}_{F} \cdot \tilde{\chi}_{I'}^{M} dx \sim 2^{m}.
$$

The above condition can be reinterpreted, so that in fact,

$$
C 2^{m} \cdot \mathbf{1}_{I'}(x) \leq \mathcal{M} \left(\mathbf{1}_{F} \cdot \tilde{\chi}_{I} \right)(x) \cdot \mathbf{1}_{I'}(x).
$$

Then, since all the intervals in \mathcal{I}_1^m are disjoint,

(47)
$$
\sum_{I' \in \mathcal{I}_1^m} |I'| \leq |\{x : \mathcal{M}(\mathbf{1}_{F} \cdot \tilde{\chi}_I)(x) > C \cdot 2^m\}| \leq \tilde{C} C^{-1} 2^{-m} \|\mathbf{1}_{F} \cdot \tilde{\chi}_I\|_1 \leq \tilde{C} 2^{n+1-m} |I|.
$$

Summing in $m > n$, we get the desired conclusion:

$$
\sum_{\substack{I'\subset I\\I'\in\mathcal I_1}}|I'|=\sum_{m>n}\sum_{I'\in\mathcal I_1^m}|I'|\leq \sum_{m>n}\tilde C\,2^{n+1-m}|I|\leq \kappa|I|.
$$

Note that the constant κ depends only on the norm of the maximal operator. \Box

4.2. Conclusions.

As mentioned earlier, Carleson and sparse collections represent the same concept: follow-ing [\[LN15\]](#page-58-17), a κ -Carleson collection of intervals is in fact $\frac{1}{\kappa}$ -sparse, and vice versa.

The stopping time used for proving vector-valued estimates yields three Carleson collections, one for every function. The algorithm starts with the largest possible size $\mathbb{P}_{Stock}1_F$, selects intervals I_1 with

$$
\widetilde{\text{size}} \, \mathbb{P}_{Stock} \, \mathbf{1}_F \sim \frac{1}{|I_1|} \int_{\mathbb{R}} \mathbf{1}_F \cdot \tilde{\chi}_{I_1}^M dx,
$$

and all the tiles in $\mathbb{P}_{Stock} \cap \mathbb{P}(I_1)$, with spatial interval contained in I_1 . Then the procedure resumes, the maximal size decreases, while the intervals in J_1 become larger and larger.

On the other hand, the stopping time for the sparse domination produces one sparse collection S of dyadic intervals. For each $Q \in S$, we also have a subcollection \mathbb{P}_Q of tritiles, which we want to satisfy simultaneously

$$
\widetilde{\text{size}\,}_{\mathbb P_Q} {\bf 1}_F \leq C \frac{1}{|Q|} \int_{\mathbb R} {\bf 1}_F \cdot \widetilde{\chi}_Q^M dx, \quad \widetilde{\text{size}\,}_{\mathbb P_Q} {\bf 1}_G \leq C \frac{1}{|Q|} \int_{\mathbb R} {\bf 1}_G \cdot \widetilde{\chi}_Q^M dx, \quad \widetilde{\text{size}\,}_{\mathbb P_Q} {\bf 1}_{H'} \leq C \frac{1}{|Q|} \int_{\mathbb R} {\bf 1}_{H'} \cdot \widetilde{\chi}_Q^M dx.
$$

We start with the largest possible spatial intervals, and in the selection process we make sure that the above conditions hold. In this case, the spatial intervals are becoming smaller and smaller, and at the same time, the size (which should be regarded as a maximal average) is increasing.

5. A RANK k collection of multi-tiles

Now we prove sparse and multi-vectorial estimates for the operator T_k of Theorem [1,](#page-4-0) the *n*-linear multiplier whose symbol is singular along a k-dimensional subspace, with $k < \frac{n+1}{2}$ $\frac{1}{2}$.

5.1. A few definitions. Here we consider Γ to be the *n*-dimensional vector space

$$
\Gamma \coloneqq \{ \xi \in \mathbb{R}^{n+1} : \xi_1 + \ldots + \xi_{n+1} = 0 \},
$$

and $\Gamma' \subset \Gamma$ a non-degenerate subspace of Γ of dimension $0 \leq k < \frac{n+1}{2}$ $\frac{1}{2}$.

The $(n+1)$ -linear form of an *n*-linear operator which is singular along Γ' is given by (48)

$$
\Lambda(f_1,\ldots,f_{n+1})=\int_{\mathbb{R}^{n+1}}\delta(\xi_1+\ldots+\xi_{n+1})m(\xi_1,\ldots,\xi_{n+1})\hat{f}_1(\xi_1)\cdot\ldots\cdot\hat{f}_{n+1}(\xi_{n+1})d\xi_1\ldots d\xi_{n+1},
$$

where m is a multiplier satisfying

$$
|\partial_{\xi}^{\alpha}m(\xi)| \lesssim \text{ dist } (\xi,\Gamma')^{-|\alpha|}
$$

for all partial derivatives ∂_{ξ}^{α} on Γ up to some finite order.

The model for the multilinear form is given by

(49)
$$
\Lambda_{\mathbb{P}}(f_1,\ldots,f_{n+1})\coloneqq \sum_{P\in\mathbb{P}} |I_P|^{-\frac{n-1}{2}} \langle f_1,\phi_P^1\rangle \cdot \ldots \cdot \langle f_{n+1},\phi_P^{n+1}\rangle,
$$

where $\mathbb P$ is a rank k family of $(n + 1)$ -tiles. This notion will be specified shortly, but it essentially means that there are k independent parameters in frequency.

We recall the order relation on tiles:

Definition 8. If P, P' are tiles, then $P' < P$ if $I_{P'} \nsubseteq I_P$ and $\omega_P \subseteq 3\omega_{P'}$. Also, $P' \leq P$ if $I_{P'} \subseteq I_P$ and $\omega_P \subseteq 100\omega_{P'}$. We write $P' \subseteq P$ if $P' \subseteq P$ or $P' = P$, and $P' \le P$ if $P' \le P$ but $P' \nleq P$.

Our notion of a rank k collection of multi-tiles is somewhat different from the one in [\[MTT02\]](#page-59-4): in order to simplify the presentation, we include in the definition certain properties that were deduced in [\[MTT02\]](#page-59-4).

Definition 9. A collection $\mathbb P$ of multi-tiles is said to have rank k if for any $P, P' \in \mathbb P$ the following conditions are satisfied:

- any k components determine the remaining ones: if $1 \le i_1 < \ldots < i_k \le n+1$ and if $\omega_{P_{i_s}} = \omega_{P'_{i_s}}$ for all $1 \leq s \leq k$, then $\omega_{P_i} = \omega_{P'_i}$ for all $1 \leq i \leq n$.
- any two multi-tiles which are overlapping in k components have (frequency only) dilates that are overlapping in the remaining components: if $1 \leq i_1 < \ldots < i_k \leq n+1$ and if $P'_{i_s} \leq P_{i_s}$ for all $1 \leq s \leq k$, then $P'_i \leq P_i$ for all $1 \leq i \leq n$.
- if the two multi-tiles correspond to different scales and they are overlapping in k components, there will be at least two components which are not overlapping, though their frequency dilates are: if we further assume that $|I_{P'}|\ll |I_P|$, then we have $P'_i \leq P_i$ for at least two choices of i.

It is not difficult to prove that the discretization of the multilinear form from [\(49\)](#page-24-2) admits a rank k model form as in (48) . This is detailed in [\[MTT02\]](#page-59-4). The most well-known example corresponds to $n = 2$ and $k = 1$: the bilinear Hilbert transform BHT is a bilinear operator given by the multiplier sgn($\xi_1 - \xi_2$), which is singular along a line.

The handling of the more general case of a rank k model operator is similar: the multitiles are grouped in subcollections called *trees* according to their *size*. In order to make this statement precise, we need to introduce a few definitions.

Definition 10. For any $1 \leq j \leq n+1$, a j-tree with top $P_T = (I_T \times \omega_{T_1}, \ldots, I_T \times \omega_{T_{n+1}})$ is a subcollection T of $\mathbb P$ so that $P_j \leq P_{T,j}$ for all $P \in T$.

A tree is called j-overlapping if $P_j \leq P_{T,j}$ for all $P \in T$, and j-lacunary if $P_j \leq P_{T,j}$ for all $P \in T$.

Finally, if $1 \leq i_1 < \ldots < i_k \leq n+1$, a subcollection T of $\mathbb P$ is called an (i_1, \ldots, i_k) -tree if T is an i_s -tree for all $1 \leq s \leq k$.

In the case of the bilinear Hilbert transform operator, which corresponds to a rank-1 family of tri-tiles, the convention used in [\[MS13\]](#page-59-6) or [\[MTT04\]](#page-59-7) is that a j-tree is j-overlapping and lacunary in the other two directions. For the general case, things are slightly more complicated since there are k degrees of freedom. However, the notion of rank k from Definition [9](#page-25-1) ensures that once k directions are fixed, one obtains a j-tree for all $1 \leq j \leq n+1$, and moreover, this tree will have at least two lacunary directions. In some sense, for a rank k collection of multi-tiles, the (i_1, \ldots, i_k) -trees represent the "fundamental constituents".

Definition 11. Given \mathbb{P} a rank-k collection of multi-tiles and $1 \leq j \leq n+1$, we define the size of the sequence $((f, \phi_P^j))_{P \in \mathbb{P}}$ by

(50)
$$
size_{\mathbb{P}}(\langle f, \phi_P^j \rangle_{P \in \mathbb{P}}) := \sup_{T \in \mathbb{P}} \left(\frac{1}{|I_T|} \sum_{P \in T} |\langle f, \phi_P^j \rangle|^2 \right)^{\frac{1}{2}}
$$

where T ranges over all j-lacunary trees in $\mathbb P$ (including one multi-tile trees).

It was proved in [\[MTT04\]](#page-59-7) that

size
$$
\mathbb{P}(\langle f, \phi_P^j \rangle_{P \in \mathbb{P}}) \lesssim_M \sup_{P \in \mathbb{P}} \frac{1}{|I_P|} \int_{\mathbb{R}} |f(x)| \cdot \tilde{\chi}_{I_P}^M(x) dx
$$
,

and for this reason we use the notation from Definition [4:](#page-12-2)

(51)
$$
\widetilde{\text{size}\,}_{\mathbb{P}}(f) \coloneqq \sup_{P \in \mathbb{P}} \frac{1}{|I_P|} \int_{\mathbb{R}} |f(x)| \cdot \tilde{\chi}_{I_P}^M(x) dx.
$$

Lemma 17. If T is an (i_1, \ldots, i_k) -tree for some $1 \leq i_1 < \ldots < i_k \leq n+1$, then

$$
\sum_{P\in\mathcal{T}}|I_P|^{-\frac{n-1}{2}}\langle f_1,\phi_P^1\rangle\cdot\ldots\cdot\langle f_{n+1},\phi_P^{n+1}\rangle|\lesssim \prod_{j=1}^{n+1}size_{\mathcal{T}}(\langle f_j,\phi_P^j\rangle)\cdot|I_T|.
$$

Because of the existence of at least two lacunary directions in a (i_1, \ldots, i_k) -tree, we have a way of estimating how the functions act on such "elementary blocks". Further, an important step in the proof is the *decomposition lemma* below, which allows us to organize a collection of tiles into trees of similar size:

Lemma 18. If \mathbb{P}_j is a collection of j-tiles with $size_{\mathbb{P}_j}(\langle f_j, \phi_P^j \rangle) \leq \lambda$, then there exists a decomposition $\mathbb{P}_j = \mathbb{P}'_j \cup \mathbb{P}''_j$ so that $size_{\mathbb{P}'_j}(\langle f_j, \phi^j_P \rangle) \leq \frac{\lambda}{2}$ $\frac{\lambda}{2}$ and \mathbb{P}_j'' is a union $\mathbb{T} = \bigcup_{n=1}^{\infty}$ \widetilde{T} ∈T T of

disjoint trees so that

(52)
$$
\sum_{T \in \mathbb{T}} |I_T| \lesssim \lambda^{-2} \|f_j\|_2^2.
$$

Furthermore, if all the tiles in \mathbb{P}_j have their spatial support contained inside a fixed dyadic interval I_0 , then (52) can be improved to

(53)
$$
\sum_{T \in \mathbb{T}} |I_T| \lesssim \lambda^{-2} \|f_j \cdot \tilde{\chi}_{I_0}\|_2^2.
$$

Proof. The decomposition of the collection \mathbb{P}_j into trees according to their size is a classical result in time-frequency analysis and it corresponds to a Calderón-Zygmund decomposition at the level of the tiles. The selection of the trees in T is the conventional one: we start by choosing the maximal j-lacunary ones which have size greater than $\lambda/2$, and in order to insure orthogonality, some j-overlapping trees are removed as well. Here, we will only elaborate on the localized version, i.e. the estimate [\(53\)](#page-26-2), which follows by proving

$$
\sum_{T \in \mathbb{T}} \sum_{P \in T} |\langle f, \phi_P \rangle|^2 \lesssim \lambda \left(\sum_{T \in \mathbb{T}} |I_T| \right)^{\frac{1}{2}} \| f \cdot \tilde{\chi}_{I_0} \|_2,
$$

or equivalently, by a TT^* argument,

$$
\Big\| \Big(\sum_{T \in \mathbb{T}} \sum_{P \in T} \langle f, \phi_P \rangle \phi_P \Big) \tilde{\chi}_{I_0}^{-\frac{N}{2}} \Big\|_2 \lesssim \lambda \Big(\sum_{T \in \mathbb{T}} |I_T| \Big)^{\frac{1}{2}}.
$$

We perform a decomposition of $\mathbb R$ into dyadic shells around I_0 , which reduces the above estimate to

$$
\Big\| \Big(\sum_{T \in \mathbb{T}} \sum_{P \in T} \langle f, \phi_P \rangle \phi_P \Big) \cdot \mathbf{1}_{10I_0} \Big\|_2 \lesssim \lambda \Big(\sum_{T \in \mathbb{T}} |I_T| \Big)^{\frac{1}{2}}, \quad \Big\| \Big(\sum_{T \in \mathbb{T}} \sum_{P \in T} \langle f, \phi_P \rangle \phi_P \Big) \tilde{\chi}_{I_0, \kappa} \Big\|_2 \lesssim 2^{-\frac{\kappa N}{2}} \lambda \Big(\sum_{T \in \mathbb{T}} |I_T| \Big)^{\frac{1}{2}},
$$

where for every $\kappa \ge 2$, $\tilde{\chi}_{I_0,\kappa}$ is a smooth bump function adapted to the region $2^{\kappa+1}I_0 \setminus 2^{\kappa}I_0$, supported outside $2^{\kappa-1}I_0$ for κ large enough.

In the first term, we ignore the truncation and instead deal with

$$
\Big\| \sum_{T \in \mathbb{T}} \sum_{P \in T} \langle f, \phi_P \rangle \phi_P \Big\|_2 \lesssim \lambda \Big(\sum_{T \in \mathbb{T}} |I_T| \Big)^{\frac{1}{2}}.
$$

This is a standard estimate and it heavily relies on the orthogonality of the selected trees. It remains to prove, for any $\kappa \geq 2$, and any interval $I \subseteq I_0$:

(54)
$$
\left\| \left(\sum_{T \in \mathbb{T}} \sum_{\substack{P \in T \\ I_P = I}} \langle f, \phi_P \rangle \phi_P \right) \tilde{\chi}_{I_0, \kappa} \right\|_2 \lesssim 2^{-\frac{\kappa N}{2}} \frac{|I|^{\frac{3}{2}}}{|I_0|^{\frac{3}{2}}} \lambda \left(\sum_{T \in \mathbb{T}} |I_T| \right)^{\frac{1}{2}},
$$

which implies the desired result upon summation in κ and in $I \subseteq I_0$, details which are left to the interested reader. On the right hand side, any power strictly greater than 2 would be sufficient: it allows us to sum with respect to the scale $|I|/|I_0|$ and the number of intervals of fixed length.

Relying again on a TT^* argument, the left hand side of (54) squared can be written as

$$
\sum_{T \in \mathbb{T}} \sum_{\substack{P \in T \\ I_P = I}} \sum_{\substack{T' \in \mathbb{T} \\ I_{P'} = I}} \sum_{\substack{P' \in T' \\ I_{P'} = I}} \langle f, \phi_P \rangle \overline{\langle f, \phi_{P'} \rangle} \int_{\mathbb{R}} \phi_P(x) \overline{\phi_{P'}(x)} \tilde{\chi}_{I_0, \kappa}^2(x) dx.
$$

Since $|\langle f, \phi_P \rangle \overline{\langle f, \phi_{P'} \rangle}| \lesssim |\langle f, \phi_P \rangle|^2 + |\langle f, \phi_{P'} \rangle|^2$, it will be enough to show, for any fixed tree $T \in \mathbb{T}$ and any fixed multi-tile $P \in \mathbb{T}$ with $I_P = I$, that

(55)
$$
\sum_{T' \in \mathbb{T}} \sum_{P' \in T'} \left| \int_{\mathbb{R}} \phi_P(x) \overline{\phi_{P'}(x)} \tilde{\chi}_{I_0,\kappa}^2(x) dx \right| \lesssim 2^{-\kappa N} \frac{|I|^3}{|I_0|^3}.
$$

This is because the size of every tree is controlled by λ and in consequence

$$
\sum_{T \in \mathbb{T}} \sum_{P \in T} |\langle f, \phi_P \rangle|^2 \lesssim \lambda^2 \sum_{T \in \mathbb{T}} |I_T|.
$$

To deal with [\(55\)](#page-27-1), we note that since $I_P = I = I'_P$, every P' must come from a different tree, and that all the frequency intervals $\omega_{P'}$ (actually $\omega_{P'_j}$, but we ignore the j index here) are mutually disjoint as P' varies in $\cup_{T' \in T} T'$. Moreover, they all have the same length and they are equally spaced. For simplicity, we assume ω_P is centered at 0, so $\omega_P + \omega_{P'}$, which contains the Fourier support of $\phi_P \overline{\phi_{P'}}$, is a subset of $[\text{dist}(\omega_P, \omega_{P'})$, dist $(\omega_P, \omega_{P'})+2|\omega_P|]$. Hence, if $P' \neq P$, and $\Phi^{[M]}(x)$ is a function so that

$$
\frac{d^M}{dx^M}\Phi^{[M]}(x)=\phi_P(x)\overline{\phi_{P'}}(x),
$$

then we have

$$
|\Phi^{[M]}(x)| \lesssim |I|^{-1} \operatorname{dist} (\omega_P, \omega_{P'})^{-M}.
$$

Integrating by parts M times, we obtain

$$
\left| \int_{\mathbb{R}} \phi_P(x) \overline{\phi_{P'}(x)} \tilde{\chi}_{I_0,\kappa}^2(x) dx \right| \lesssim \left| \int_{\mathbb{R}} \Phi^{[M]}(x) \frac{d^M}{dx^M} \tilde{\chi}_{I_0,\kappa}^2(x) dx \right|
$$

$$
\lesssim \left(\frac{\text{dist } (\omega_P, \omega_{P'})}{|\omega_P|} \right)^{-M} 2^{-\kappa M} \left(\frac{|I|}{|I_0|} \right)^M.
$$

Summing over tiles $P' \neq P$ with $I_{P'} = I = I_P$ is now possible and we get [\(55\)](#page-27-1). To deal with the case $P' = P$, we use the fast decay of the L^2 normalized bump function ϕ_P , which is adapted to $I_P = I$, and the fact that $\tilde{\chi}_{I_0,\kappa}$ is supported outside $2^{\kappa-1}I_0$. I_0 .

For a rank-1 family of multi-tiles, the decomposition above can be performed directly on the collection $\mathbb P$ of multi-tiles (this is Lemma 7.7 of [\[MTT02\]](#page-59-4)): if $size_{\mathbb P}(\langle f_j, \phi_P^j \rangle) \leq \lambda$,

then there exists a decomposition $\mathbb{P} = \mathbb{P}' \cup \mathbb{P}''$ so that size $\mathbb{P}'(\langle f_j, \phi_P^j \rangle) \leq \frac{\lambda}{2}$ $\frac{\lambda}{2}$ and \mathbb{P}'' is a union $\mathbb T$ of disjoint *j*-trees (*j*-lacunary or *j*-overlapping) so that

$$
\sum_{T \in \mathbb{T}} |I_T| \lesssim \lambda^{-2} \|f_j\|_2^2.
$$

As explained in Section [3,](#page-13-0) the following localization result plays a key role in the proof of the sparse and vector-valued results of Theorem [1.](#page-4-0)

Theorem 19. Let I_0 be a fixed dyadic interval and \mathbb{P} a rank k collection of multi-tiles, E_1, \ldots, E_{n+1} sets of finite measure, and f_1, \ldots, f_{n+1} functions with the property that $|f_j(x)| \le$ $\mathbf{1}_{E_j}(x), \forall 1 \leq j \leq n+1$. Then we have

(56)
$$
|\Lambda_{\mathbb{P}(I_0)}(f_1,\ldots,f_{n+1})| \lesssim \prod_{j=1}^{n+1} \left(\widetilde{size}_{I_0} \mathbf{1}_{E_j}\right)^{1-\alpha_j} \cdot |I_0|,
$$

where the exponents $\alpha_j \in (0,1/2)$. Moreover, they are defined by

(57)
$$
\alpha_j \coloneqq \sum_{\substack{1 \leq i_1 < \ldots < i_k \leq n+1 \\ i_s = j \text{ for some } 1 \leq s \leq k}} \theta_{i_1, \ldots, i_k}
$$

where $0 \leq \theta_{i_1,\dots,i_k} \leq 1$ are any positive numbers indexed by ordered k-tuples such that

$$
\sum_{1 \le i_1 < \ldots < i_k \le n+1} \theta_{i_1, \ldots, i_k} = 1.
$$

5.2. Proof of Theorem [19:](#page-28-1) the case $k = 1$.

We first present the proof in the case $k = 1, n = 2$, which corresponds to the bilinear Hilbert transform operator. Although the localization result for BHT has already appeared in [\[BM16\]](#page-57-0), we include a short revision, anticipating that the general rank k case will be built upon it.

Thus we have a rank 1 family $\mathbb P$ of tri-tiles, I_0 is a fixed interval, and f_1, f_2, f_3 are restricted-type functions:

$$
|f_1(x)| \leq \mathbf{1}_{E_1}(x), \quad |f_2(x)| \leq \mathbf{1}_{E_2}(x) \quad \text{and} \quad |f_3(x)| \leq \mathbf{1}_{E_3}(x).
$$

We want to prove that

$$
(58) \qquad |\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_1}\right)^{1-\theta_1} \cdot \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_2}\right)^{1-\theta_2} \cdot \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_3}\right)^{1-\theta_3} \cdot |I_0|,
$$

where $0 < \theta_i \leq \frac{1}{2}$ $\frac{1}{2}$ and $\theta_1 + \theta_2 + \theta_3 = 1$.

Using the decomposition result in Lemma [18,](#page-26-0) we obtain the families: $\mathcal{T}_{n_1}, \mathcal{T}_{n_2}$ and \mathcal{T}_{n_3} , where each \mathcal{T}_{n_j} is a union of disjoint *j*-trees satisfying

$$
\sum_{T \in \mathcal{T}_{n_j}} |I_T| \lesssim 2^{2n_j} \|f_j \cdot \tilde{\chi}_{I_0}\|_2^2, \qquad \text{size}_T(f_j) \le 2^{-n_j} \le \widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j} \quad \forall \, T \in \mathcal{T}_j.
$$

If we denote by $\mathcal{T}_{n_1,n_2,n_3}$ the collection of trees $T \coloneqq T_1 \cap T_2 \cap T_3$, where $T_j \in \mathcal{T}_{n_j}$, we have that

$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \sum_{n_1, n_2, n_3} \sum_{T \in \mathcal{T}_{n_1, n_2, n_3}} \sum_{\substack{P \in T \\ P \subseteq I_0}} ||I_P|^{-\frac{1}{2}} \langle f_1, \phi_P^1 \rangle \langle f_2, \phi_P^2 \rangle \langle f_3, \phi_P^3 \rangle|
$$

$$
\lesssim \sum_{n_1, n_2, n_3} 2^{-n_1} 2^{-n_2} 2^{-n_3} \sum_{T \in \mathcal{T}_{n_1, n_2, n_3}} |I_T|.
$$

Then Lemma [18](#page-26-0) implies that

$$
\sum_{T \in \mathcal{T}_{n_1, n_2, n_3}} |I_T| \lesssim 2^{2n_1} \|f_1 \cdot \tilde{\chi}_{I_0}\|_2^2 \lesssim 2^{2n_1} \cdot \Big(\int_{\mathbb{R}} \mathbf{1}_{E_1} \cdot \tilde{\chi}_{I_0}^M dx \Big) \lesssim 2^{2n_1} \Big(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_1} \Big) \cdot |I_0|.
$$

Similarly, we have

$$
\sum_{T \in \mathcal{T}_{n_1, n_2, n_3}} |I_T| \lesssim 2^{2n_2} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_2} \right) \cdot |I_0| \quad \text{and} \quad \sum_{T \in \mathcal{T}_{n_1, n_2, n_3}} |I_T| \lesssim 2^{2n_3} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_3} \right) \cdot |I_0|,
$$

and interpolating the three inequalities above we obtain that

$$
\sum_{T \in \mathcal{T}_{n_1, n_2, n_3}} |I_T| \lesssim 2^{2\theta_1 n_1} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_1}\right)^{\theta_1} \cdot 2^{2\theta_2 n_2} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_2}\right)^{\theta_2} \cdot 2^{2\theta_3 n_3} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_3}\right)^{\theta_3} \cdot |I_0|.
$$

This allows us to estimate the trilinear form by

$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim \sum_{n_1, n_2, n_3} 2^{-n_1(1-2\theta_1)} 2^{-n_2(1-2\theta_2)} 2^{-n_3(1-2\theta_3)} \cdot (\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_1})^{\theta_1} \cdot (\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_2})^{\theta_2} \cdot (\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_3})^{\theta_3} \cdot |I_0|.
$$

Since $2^{-n_1} \n\t\leq \widetilde{\text{size}}_{I_0} \mathbf{1}_{E_1}, 2^{-n_2} \leq \widetilde{\text{size}}_{I_0} \mathbf{1}_{E_2}$ and $2^{-n_3} \leq \widetilde{\text{size}}_{I_0} \mathbf{1}_{E_3}$ from the decomposition, we obtain, provided that $0 \le \theta_1, \theta_2, \theta_3 < \frac{1}{2}$ $\frac{1}{2}$ and $\theta_1 + \theta_2 + \theta_3 = 1$

$$
|\Lambda_{\mathbb{P}(I_0)}(f_1, f_2, f_3)| \lesssim (\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_1})^{1-\theta_1} \cdot (\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_2})^{1-\theta_2} \cdot (\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_3})^{1-\theta_3} \cdot |I_0|.
$$

This is [\(58\)](#page-28-2), which is another way of writing [\(25\)](#page-13-1), but the θ_i in the two equations are different.

5.3. Proof of Theorem [19:](#page-28-1) the case $k > 1$. Applying Lemma [18](#page-26-0) in every component, for every $1 \leq j \leq n+1$ we can write $\mathbb{P}(I_0)$ as

$$
\mathbb{P}(I_0) \coloneqq \bigcup_{l_j} \bigcup_{T_j \in \mathcal{T}_{l_j}} T_j,
$$

where the collection T_j is a j-tree (the order relation needs to hold only in the jth component) satisfying

$$
2^{-l_j-1} \leq \text{size}\, \tau_j\left(\left\right) \leq 2^{-l_j} \lesssim \widetilde{\text{size}}\, \, I_0 \mathbf{1}_{E_j}.
$$

Hence we can write

$$
\mathbb{P}(I_0) \coloneqq \bigcup_{l_1,\dots,l_{n+1}} \bigcup_{T_1 \in \mathcal{T}_{l_1}} \dots \bigcup_{T_{n+1} \in \mathcal{T}_{l_{n+1}}} \big(T_1 \cap \dots \cap T_{n+1}\big).
$$

Equivalently, if we denote $\mathcal{T}_{l_1,\dots,l_{n+1}}$ the collection of multi-tiles $T = T_1 \cap \dots \cap T_{n+1}$, where $T_j \in \mathcal{T}_{l_j}$, we have $\mathbb{P}(I_0) = \cup$ l_1,\ldots,l_{n+1} ⋃ $T \in \mathcal{T}_{l_1,\ldots,l_{n+1}}$ T, and every $T \in \mathcal{T}_{l_1,\dots,l_{n+1}}$ satisfies, for any $1 \leq j \leq n+1$,

size
$$
T((f_j, \phi_P^j)) \leq 2^{-l_j} \leq \widetilde{\text{size}} I_0 \mathbf{1}_{E_j}.
$$

Using Lemma [17,](#page-26-3) we have that

$$
|\Lambda_{\mathbb{P}(I_0)}(f_1,\ldots,f_{n+1})| \lesssim \sum_{l_1,\ldots,l_{n+1}} 2^{-l_1} \cdot \ldots \cdot 2^{-l_{n+1}} \sum_{T \in \mathcal{T}_{l_1,\ldots,l_{n+1}}} |I_T|.
$$

Every subset $T \in \mathcal{T}_{l_1,\dots,l_{n+1}}$ is part of an (i_1,\dots,i_k) -tree (or a "fundamental constituent"), and there are $\binom{n+1}{k}$ $\binom{+1}{k}$ such trees. The reader should recall that in Section [5.2,](#page-28-3) any $T \in \mathcal{T}_{n_1,n_2,n_3}$ is of the form $T = T_1 \cap T_2 \cap T_3$, and hence can be viewed as a subset of a 1-tree, 2-tree or 3-tree, a fact which was used for estimating \sum $T\epsilon\overline{\mathcal{T}_{n_1,n_2,n_3}}$ $|I_T|.$

Similarly, the sum $T \epsilon \mathcal{T}_{l_1,\ldots,l_{n+1}}$ $|I_T|$ can be estimated in $\binom{n+1}{k}$ ways, and by their geometric mean:

$$
\sum_{T \in \mathcal{T}_{l_1,...,l_{n+1}}} |I_T| \lesssim \prod_{1 \leq i_1 < ... < i_k \leq n+1} \Big(\sum_{\substack{T \in \mathcal{T}_{l_1,...,l_{n+1}} \\ T \text{ is a } (i_1,...,i_k) - \text{tree}}} |I_T|\Big)^{\theta_{i_1,...,i_k}}
$$

for $0 \leq \theta_{i_1,\dots,i_k} \leq 1$ with \sum $1 \le i_1 < ... < i_k \le n+1$ $\theta_{i_1,\dots,i_k}=1$

For each multi-index (i_1, \ldots, i_k) we have

$$
(59) \qquad \sum_{\substack{T \in \mathcal{T}_{l_1}, \ldots, l_{n+1} \\ T \subseteq T_{i_1} \cap \ldots \cap T_{i_k} \text{ is a } (i_1, \ldots, i_k) - \text{tree}}} |I_T| \lesssim \sum_{T_{i_1} \in \mathcal{T}_{l_{i_1}}} \ldots \sum_{T_{i_k} \in \mathcal{T}_{l_{i_k}}} |I_{T_{i_1}} \cap \ldots \cap I_{T_{i_k}}| \lesssim \prod_{s=1}^k 2^{2l_{i_s}} \cdot \widetilde{\text{size}} \cdot I_0 \cdot 1_{E_{i_s}} \cdot |I_0|.
$$

If $k = 1$, the inequality is a consequence of the decomposition into trees, and was presented in Section [5.2.](#page-28-3) If $k \geq 2$, \sum $T \in \mathcal{T}_{l_1,\ldots,l_{n+1}}$ $|I_T|$ represents a k-dimensional volume, rather than

a "length"; the trees are k -dimensional and k functions are required for computing this volume.

In order to prove [\(59\)](#page-30-0), we can assume for simplicity that we sum upon collections $T_{i_s} \in \mathcal{T}_{i_s}$ satisfying $I_{T_{i_1}} \supseteq \ldots I_{T_{i_k}}$ (the general case reduces to this particular one, since the collection of dyadic intervals is well-ordered). Then we have to estimate

$$
\sum_{\substack{T_{i_1} \in \mathcal{T}_{i_1}, \ldots, T_{i_k} \in \mathcal{T}_{i_k} \\ I_{T_{i_1}} \supseteq \ldots \supseteq I_{T_{i_k}}}} |I_{T_{i_1}} \cap \ldots \cap I_{T_{i_k}}| = \sum_{\substack{T_{i_1} \in \mathcal{T}_{i_1}, \ldots, T_{i_{k-1}} \in \mathcal{T}_{i_{i_{k-1}}}}}\sum_{\substack{T_{i_k} \in \mathcal{T}_{i_k} \\ I_{T_{i_1}} \supseteq \ldots \supseteq I_{T_{i_{k-1}}}}}|I_{T_{i_k}}|.
$$

For the last term, we have, due to Lemma [18:](#page-26-0)

$$
\sum_{\substack{T_{i_k} \in \mathcal{T}_{i_{i_k}} \\ I_{T_{i_k}} \subseteq I_{T_{i_{k-1}}}}}|I_{T_{i_k}}| \lesssim 2^{2l_{i_k}} \|f_{i_k} \cdot \tilde{\chi}_{I_{T_{i_{k-1}}}}\|_2^2 \lesssim 2^{2l_{i_k}} \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_{E_{i_k}}\right) \cdot |I_{T_{i_{k-1}}}|.
$$

We repeat the procedure, summing now over the trees $T_{i_{k-1}} \in \mathcal{T}_{i_{i_{k-1}}}$, all of which have spatial supports inside $I_{T_{i_{k-2}}}$. Eventually, we obtain [\(59\)](#page-30-0) since all the tiles in $\mathbb{P}(I_0)$, and in consequence all the trees, are localized on I_0 .

Hence, we get

$$
|\Lambda_{\mathbb{P}(I_0)}(f_1,\ldots,f_{n+1})| \lesssim \sum_{l_1,\ldots,l_{n+1}} 2^{-l_1} \cdot \ldots \cdot 2^{-l_{n+1}} \prod_{1 \le i_1 < \ldots < i_k \le n+1} \Big(\prod_{s=1}^k 2^{2l_{i_s}} \cdot \widetilde{\text{size}}_{I_0} \mathbf{1}_{E_{i_s}} \cdot |I_0|\Big)^{\theta_{i_1,\ldots,i_k}} \\
\lesssim \sum_{l_1,\ldots,l_{n+1}} 2^{-l_1(1-2\alpha_1)} \cdot \ldots \cdot 2^{-l_{n+1}(1-2\alpha_{n+1})} \prod_{j=1}^{n+1} \Big(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j} \Big)^{\alpha_j} \cdot |I_0|,
$$

where the α_j are defined by formula [\(57\)](#page-28-0). Recalling that $2^{-l_j} \leq \widetilde{\text{size}}_{l_0} \mathbf{1}_{E_{l_j}}$, we deduce [\(56\)](#page-28-4).

Remark:. The condition that $k < \frac{n+1}{2}$ $\frac{1}{2}$, which is indispensable in the proof, becomes evident in the estimate above: if we let $l_1 = \ldots = l_{n+1} = l$, then \sum l_1,\ldots,l_{n+1} $2^{-l_1}\cdot\ldots\cdot 2^{-l_{n+1}}$ \sum $T \in \mathcal{T}_{l_1,\ldots,l_{n+1}}$ $|I_T|$

becomes

$$
\sum_{l} 2^{-l} \cdot \ldots \cdot 2^{-l} \sum_{T \in \mathcal{T}_{l_1, \ldots, l_{n+1}}} |I_T| \lesssim \sum_{l} 2^{-(n+1)l} \cdot 2^{2kl} \prod_{j=1}^{n+1} \left(\widetilde{size} I_0 \mathbf{1}_{E_j} \right)^{\alpha_j} \cdot |I_0|.
$$

This expression can be finite only if $k < (n+1)/2$.

6. Proof of Theorem [1](#page-4-0)

We want to prove vector-valued and sparse vector-valued estimates for the operator T_k . Moreover, we want a sparse domination for $\| \|T_k(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R'_{n+1}}(W,\mu)} \|_{L^q(w)}$, where $w \ge 0$ is a locally integrable function. In the analysis, there is a natural division between the Banach and the quasi-Banach case: that is, the case when $1 \leq (r_{n+1}^l)' < \infty \forall 1 \leq l \leq m$ and that when $(r_n^{l_0})$ ${n \choose n+1}^{\prime}$ < 1 for some $1 \leq l_0 \leq m$. In the former situation, the space $L^{R'_{n+1}}(\mathcal{W}, \mu)$ is Banach, it has a dual, and the operator can be studied through the associated $(n+1)$ -linear form.

In the quasi-Banach case, our approach relies on methods developed in [\[BM17\]](#page-58-0): we cannot use the multilinear form directly, but "dualization" (in a restricted-type sense) through some $L^{r^{j_0}}$ space is still possible. Further, we need to analyze separately the situation when $q \leq r^{j_0} := \min(1, \min_{1 \leq l \leq m} (r_{n+1}^l)')$ and that when $q > r^{j_0}$. The latter will be deduced from the first one in Proposition [20.](#page-34-0)

We point out that for the sparse estimate [\(10\)](#page-5-2) of Theorem [1,](#page-4-0) the case $q = 1$ is equivalent, in the Banach case, to finding a sparse domination of the multilinear form, and it will be detailed in the next section.

Also, in order to facilitate the presentation, in this section we simply denote the operator T_k by T. Many of the results that we present here generalize to other operators, once the corresponding local estimates are known.

6.1. The Banach case: $1 \le R'_{n+1} < \infty$. Now we present the proof of Theorem [1,](#page-4-0) in the Banach case, when $q = 1$. This will be done inductively, and in the end it is the *scalar* local estimate [\(56\)](#page-28-4) that implies both the vector-valued and the (vector-valued) sparse estimate. In this situation, it suffices to study the multilinear form associated to the operator T_k .

We consider the tuple $(\alpha_1, \ldots, \alpha_{n+1})$ as in [\(57\)](#page-28-0) to be fixed. For any $1 \leq j \leq n+1$, let $R_j = (r_j^1, \ldots, r_j^{m+1})$ be $(m+1)$ -tuples satisfying [\(8\)](#page-5-3). We note that $R_j = (r_j^1, \tilde{R}_j)$, where \tilde{R}_j is an m -tuple (this will be useful in the inductive proof), and hence, the depth $m+1$ -space $L^{R_j}(W,\mu)$ will be denoted X_j , while \tilde{X}_j will stand for the depth-m space $L^{\tilde{R}_j}(\tilde{W},\tilde{\mu})$ (and $m = 0$ corresponds to the scalar case).

Assuming the depth-m localization result

$$
(\text{loc } m) \qquad |\Lambda^m_{\mathbb{P}(I)}(\vec{f}_1,\ldots,\vec{f}_{n+1})| \lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_I \mathbf{1}_{E_j}\right)^{1-\alpha_j-\epsilon} \cdot |I|,
$$

that holds for any given interval I and any vector-valued functions $\vec{f}_1, \ldots, \vec{f}_{n+1}$ satisfying $\|\tilde{f}_j(x,\cdot)\|_{\tilde{X}_j} \leq \mathbf{1}_{E_j}$ for all $1 \leq j \leq n+1$ (here E_1, \ldots, E_{n+1} are sets of finite measure), we will prove the following inequalities:

(i) for any dyadic interval I_0 and any vector-valued function $\vec{g}_1, \ldots, \vec{g}_{n+1}$ satisfying $\|\vec{g}_j(x,\cdot)\|_{X_j} \leq \mathbf{1}_{G_j}$ for all $1 \leq j \leq n+1$, we have a depth- $(m+1)$ localization result:

$$
(\text{loc } m+1) \qquad |\Lambda_{\mathbb{P}(I_0)}^{m+1}(\vec{g}_1, \dots, \vec{g}_{n+1})| \lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{G_j} \right)^{1-\alpha_j-\epsilon} \cdot |I_0|
$$

Remark:. The ϵ in [\(loc](#page-31-2) $m + 1$) might differ from the ϵ in (loc m), but in essence it represents a very small loss.

(ii) the operator T defined through the $(n+1)$ linear form in [\(5\)](#page-5-4) satisfies the depth m vector valued inequality:

$$
(VV \ m) \t\t ||T(\vec{f}_1, \ldots, \vec{f}_n)||_{L^{p'_{n+1}}(\mathbb{R}; \tilde{X}'_{n+1})} \lesssim \prod_{j=1}^n ||\vec{f}_j||_{L^{p_j}(\mathbb{R}; \tilde{X}_j)}
$$

where the Lebesgue exponents satisfy [\(6\)](#page-5-5), [\(7\)](#page-5-1) and [\(8\)](#page-5-3).

(iii) there exists a sparse collection S depending on $\bar{f}_1, \ldots, \bar{f}_{n+1}$ and on s_1, \ldots, s_{n+1} , so that

$$
(\text{VV sparse } m) \qquad \left| \Lambda_{\mathbb{P}}(\vec{f}_1, \ldots, \vec{f}_{n+1}) \right| \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^{n+1} \left(\frac{1}{|Q|} \int_{\mathbb{R}} \| \vec{f}_j(x, \cdot) \|_{\tilde{X}_j}^{s_j} \cdot \tilde{\chi}_Q^M dx \right)^{1/s_j} \cdot |Q|,
$$

given that the Lebesgue exponents satisfy $\frac{1}{s_j} < 1 - \alpha_j \quad \forall 1 \le j \le n + 1$.

The easiest inequality to prove is (VV) sparse m); using Proposition [14,](#page-16-1) we obtain the equivalent of [\(loc](#page-31-2) m) for general vector-valued functions, and then we just need to ap-ply the stopping time described in Section [3.](#page-13-0) This inequality also implies $(VV m)$ for $1 < p_1, \ldots, p_{n+1} \leq \infty$, just by making use of disjointness of the sets $\{E_Q\}_{Q \in \mathcal{S}}$: assuming [\(VV sparse](#page-32-0) m), we have that

$$
\left|\Lambda_{\mathbb{P}}(\vec{f}_{1},\ldots,\vec{f}_{n+1})\right| \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^{n+1} \inf_{y \in Q} \mathcal{M}_{s_{j}}(\|\vec{f}_{j}(x,\cdot)\|_{\tilde{X}_{j}}) \cdot |E_{Q}|
$$

$$
\lesssim \int_{\mathbb{R}} \prod_{j=1}^{n+1} \mathcal{M}_{s_{j}}(\|\vec{f}_{j}(x,\cdot)\|_{\tilde{X}_{j}}) dx \lesssim \prod_{j=1}^{n+1} \|\vec{f}_{j}\|_{L^{p_{j}}(\mathbb{R};\tilde{X}_{j})},
$$

which is true as long as $s_i < p_i$.

We are left with proving [\(loc](#page-31-2) $m \to (\text{loc } m + 1)$). In the Banach case (that is, when all Lebesgue exponents are contained inside $(1, \infty)$, we present an approach that makes use of a local version of the estimate [\(VV sparse](#page-32-0) m). In [\[BM16\]](#page-57-0) however, we used a different stopping time, as presented in Section [4.1;](#page-20-3) the implication [\(loc](#page-31-1) $m \Rightarrow$ (loc $m + 1$) can be proved in a way that does not use the sparseness property explicitly, but here we want to emphasize the connection between $(VV m)$ and $(VV$ sparse m).

Let G_1, \ldots, G_{n+1} be sets of finite measure, I_0 a fixed dyadic interval, and $\vec{g}_1, \ldots, \vec{g}_{n+1}$ vector-valued functions satisfying $\|\vec{g}_j(x,\cdot)\|_{L^{R_j}(W,\mu)} \leq \mathbf{1}_{G_j}$.

Since we argue by induction, we will denote by \vec{g}_{j,w_1} the vector-valued function with the w_1 component fixed. We note that these functions also satisfy $\vec{g}_{j,w_1}(x,\tilde{w}) = \mathbf{1}_{G_j}(x)$. $\vec{g}_{j,w_1}(x,\tilde{w})$, where $\tilde{w} = (w_2,\ldots,w_{n+1})$. Then we use a local version of [\(VV sparse](#page-32-0) m), which can easily be verified because our operator is local. Given $\vec{g}_1, \ldots, \vec{g}_{n+1}, G_1, \ldots, G_{n+1}$ as above, and I a dyadic interval, there exists a collection $\mathcal{S}(I)$ of sparse intervals contained inside I so that

(sparse loc m)

$$
\left|\Lambda_{\mathbb{P}(I)}(\vec{g}_{1,w_1}\cdot\mathbf{1}_{G_1},\ldots,\vec{g}_{n+1,w_1}\cdot\mathbf{1}_{G_{n+1}})\right|\lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_I \mathbf{1}_{G_j}\right)^{\frac{1}{s_j}-\frac{1}{\tau_j}} \sum_{Q\in\mathcal{S}(I)} \prod_{j=1}^{n+1} \left(\frac{1}{|Q|}\int_{\mathbb{R}}\|\vec{g}_{j,w_1}(x,\cdot)\|_{\tilde{X}_j}^{\tau_j}\cdot\tilde{\chi}_Q^M dx\right)^{1/\tau_j}\cdot |Q|,
$$

where $\frac{1}{1}$ $\frac{1}{\tau_j} < \frac{1}{s_j}$ $\frac{1}{s_j}$ = 1− α_j − ϵ for all 1 ≤ j ≤ n+1. Here the τ_j , upon which the sparse domination

depends (together with the functions \vec{g}_{j,w_1}), are so that $\frac{1}{\epsilon}$ $\frac{1}{\tau_j}$ < min $\left(\frac{1}{s_j}\right)$ $\frac{1}{s_j}, \frac{1}{r_j}$ r^1_j $) < 1 - \alpha_j$. As before, by making use of the sparse property of the collection, we can prove that

$$
\left|\Lambda_{\mathbb{P}(I)}(\vec{g}_{1,w_1}\cdot \mathbf{1}_{G_1},\ldots,\vec{g}_{n+1,w_1}\cdot \mathbf{1}_{G_{n+1}})\right|\lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_I \mathbf{1}_{G_j}\right)^{\frac{1}{s_j}-\frac{1}{\tau_j}} \cdot \prod_{j=1}^{n+1} \|\vec{g}_{j,w_1}(x,\cdot)\|_{\tilde{X}_j} \cdot \tilde{\chi}_I^M\|_{L^{\tau_j^1}}.
$$

Since we make appear the maximal operator \mathcal{M}_{τ_j} , these exponents have to be slightly smaller than r_j^1 ; so in fact the operatorial norm can be written as

$$
\prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{G_j} \right)^{\frac{1}{s_j} - \frac{1}{r_j^1} - \epsilon},
$$

similarly to what we would get by applying directly the helicoidal method.

Now we return to the $(n+1)$ -linear form:

$$
|\Lambda_{\mathbb{P}(I_0)}(\vec{g}_1,\ldots,\vec{g}_{n+1})| = |\int_{\mathcal{W}_1} \Lambda_{\mathbb{P}(I_0)}(\vec{g}_{1,w_1} \cdot \mathbf{1}_{G_1},\ldots,\vec{g}_{n+1,w_1} \cdot \mathbf{1}_{G_{n+1}}) dw_1|
$$

$$
\lesssim \int_{\mathcal{W}_1} \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{G_j} \right)^{\frac{1}{s_j} - \frac{1}{r_j^1} - \epsilon} \cdot \prod_{j=1}^{n+1} ||g_{j,w_1}(x,\cdot)||_{\tilde{X}_j} \cdot \tilde{\chi}_{I_0}^M||_{L_x^{r_j^1}} dw_1.
$$

By using Hölder's inequality and Fubini, we get that

$$
|\Lambda_{\mathbb{P}(I_0)}(\vec{g}_1,\ldots,\vec{g}_{n+1})| \lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{G_j} \right)^{\frac{1}{s_j} - \frac{1}{r_j^1} - \epsilon} \cdot \prod_{j=1}^{n+1} \| |g_j(x,\cdot)|_{X_j} \cdot \widetilde{\chi}_{I_0}^M \|_{L_x^{r_j^1}} \leq \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{G_j} \right)^{\frac{1}{s_j} - \epsilon} \cdot |I_0|,
$$

which is similar to [\(loc](#page-31-1) $m + 1$) since $\frac{1}{s_j} = 1 - \alpha_j - \epsilon$.

Remark:. If $q < 1$, the sparse domination estimate [\(10\)](#page-5-2), in the Banach case, will be discussed in the following section. We recall that the case $q = 1$ corresponds to the study of the $(n+1)$ -linear form.

6.2. The quasi-Banach case. We consider separately the case when there exists $1 \le l_0 \le$ m so that $r_n^{l_0}$ $\frac{a_0}{n+1}$ < 1 (in this situation, r^{j_0} < 1). The difference now is that we cannot obtain the full range of exponents just by considering the $(n+1)$ -linear form. Instead, we will use certain inequalities similar to those in [\[BM17\]](#page-58-0).

We look at the scalar case first, corresponding to $m = 0$. The estimates obtained for the multilinear form imply immediately that

$$
||T_{I_0}(f_1,\ldots,f_n)\cdot \mathbf{1}_{\tilde{E}_{n+1}}||_1 \lesssim \prod_{j=1}^n \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j}\right)^{1-\alpha_j-\epsilon} \cdot \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{\tilde{E}_{n+1}}\right)^{1-\alpha_{n+1}-\epsilon} \cdot |I_0|,
$$

for functions f_1, \ldots, f_{n+1} satisfying $|f_j(x)| \leq \mathbf{1}_{E_j}(x)$ for all $1 \leq j \leq n$. Here $E_1, \ldots, E_n, \tilde{E}_{n+1}$ are sets of finite measure.

Under the same assumptions, for any $\tau < 1$, we get a "better" estimate:

$$
||T_{I_0}(f_1,\ldots,f_n)\cdot \mathbf{1}_{\tilde{E}_{n+1}}||_{\tau} \lesssim \prod_{j=1}^n \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j}\right)^{1-\alpha_j-\epsilon} \cdot \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{\tilde{E}_{n+1}}\right)^{1-\alpha_{n+1}-\epsilon-\frac{1}{\tau'}} \cdot |I_0|^{\frac{1}{\tau}}.
$$

Because of the exponent of $\widetilde{\text{size}}_{I_0} \mathbf{1}_{\tilde{E}_{n+1}} : 1 - \alpha_{n+1} - \epsilon - \frac{1}{\tau'}$ $\frac{1}{\tau'}$ > 1 – α_{n+1} – ϵ (here τ' < 0), this estimate is an improvement of what we could deduce by using the multilinear form exclusively.

The inductive multiple vector-valued inequalities that we obtain in this situation are the following:

$$
(60) \qquad \|\|T_{I_0}(\vec{f}_1 \cdot \mathbf{1}_{E_1}, \ldots, \vec{f}_n \cdot \mathbf{1}_{E_n})\|_{L^{R'_{n+1}}} \cdot \mathbf{1}_{\tilde{E}_{n+1}}\|_{p'_{n+1}} \lesssim \prod_{j=1}^n \left(\text{size}\;_{I_0} \mathbf{1}_{E_j}\right)^{1-\alpha_j-\epsilon-\frac{1}{p_j}} \cdot \left(\text{size}\;_{I_0} \mathbf{1}_{\tilde{E}_{n+1}}\right)^{1-\alpha_{n+1}-\epsilon-\frac{1}{p_{n+1}}}\cdot \prod_{j=1}^n \|\vec{f}_j\|_{\tilde{X}_j} \cdot \tilde{\chi}_{I_0}^M\|_{p_j}.
$$

This applies to the case when p_1, \ldots, p_{n+1} satisfy [\(8\)](#page-5-3); note that here $p'_{n+1} < 1$ and hence its harmonic conjugate p_{n+1} is negative.

When the functions satisfy $\|\vec{f}_j(x,\cdot)\|_{\tilde{X}_j} \leq \mathbf{1}_{E_j}$, this becomes $(qB : m)$

$$
\left\| \left\| T_{I_0}(\vec{f}_1,\ldots,\vec{f}_n) \right\|_{L^{R_{n+1}'}} \cdot \mathbf{1}_{\tilde{E}_{n+1}} \right\|_{p'_{n+1}} \lesssim \prod_{j=1}^n \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{E_j} \right)^{1-\alpha_j-\epsilon} \cdot \left(\widetilde{\text{size}}_{I_0} \mathbf{1}_{\tilde{E}_{n+1}} \right)^{1-\alpha_{n+1}-\epsilon-\frac{1}{p_{n+1}}} \cdot |I_0|^{\frac{1}{p'_{n+1}}}.
$$

Using a stopping time as in section [4.1](#page-20-3) or as in [\[BM17\]](#page-58-0), we obtain

$$
(qB VV m) \t\t ||T(\vec{f}_1, ..., \vec{f}_n)||_{L^{p'_{n+1}}(\mathbb{R};L^{R'_{n+1}})} \lesssim \prod_{j=1}^n ||\vec{f}_j||_{L^{p_j}(\mathbb{R};L^{R_j})},
$$

where the Lebesgue exponents p_1, \ldots, p_{n+1} and the m-tuples R_1, \ldots, R_{n+1} satisfy [\(8\)](#page-5-3).

We are left with proving the sparse domination result [\(10\)](#page-5-2). The inequality ($qB : m$) can be extended to

$$
(61) \quad |||T_{I_0}(\vec{f}_1,\ldots,\vec{f}_n)||_{L^{R_{n+1}'}\cdot \mathbf{1}_{\tilde{E}_{n+1}}||_{\tau} \lesssim \prod_{j=1}^n \left(\text{size}\, I_0 \mathbf{1}_{E_j}\right)^{1-\alpha_j-\epsilon} \cdot \left(\text{size}\, I_0 \mathbf{1}_{\tilde{E}_{n+1}}\right)^{1-\alpha_{n+1}-\frac{1}{\tau'}-\epsilon} \cdot |I_0|^{\frac{1}{\tau}},
$$

for any $\tau < 1$. Note that in contrast the Lebesgue exponents p_1, \ldots, p_{n+1} in [\(60\)](#page-34-2) have to satisfy (7) and (8) .

As a consequence of Proposition [13,](#page-15-0) provided $\|\cdot\|_{L^{R'}_{n+1}}^{\tau}$ is *subadditive*, the local estimate from [\(61\)](#page-34-3) can be put to use as in Section [3](#page-13-0) (Proposition [14](#page-16-1) extends also to the context of multiple vector-valued Banach or quasi-Banach spaces; the multilinear form is replaced by a quasi-norm in the second situation) to obtain a sparse domination: for any vectorvalued functions $\tilde{f}_1, \ldots, \tilde{f}_n$ so that $\|\tilde{f}_1(x, \cdot)\|_{X_1}, \ldots, \|\tilde{f}_n(x, \cdot)\|_{X_n}$ are locally integrable, and any locally τ -integrable function v , there exists a sparse collection $\mathcal S$ of dyadic intervals (depending on the functions f_j, v and on the Lebesgue exponents s_j below) so that (62)

$$
\left\|T(\vec{f}_1,\ldots,\vec{f}_n)\right\|_{L^{R'}_{n+1}}\cdot v\right\|_{\tau}^{\tau} \lesssim \sum_{Q\in\mathcal{S}}\prod_{j=1}^n\left(\frac{1}{|Q|}\int_{\mathbb{R}}\left\|\vec{f}_j(x,\cdot)\right\|_{X_j}^{s_j}\cdot\tilde{\chi}_Q^Mdx\right)^{\frac{\tau}{s_j}}\cdot\left(\frac{1}{|Q|}\int_{\mathbb{R}}|v(x)|^{s_{n+1}}\cdot\tilde{\chi}_Q^Mdx\right)^{\frac{\tau}{s_{n+1}}}\cdot|Q|
$$

for any s_j so that $\frac{1}{s_j} < 1 - \alpha_j$ for all $1 \le j \le n$, $\frac{1}{s_n}$ $\frac{1}{s_{n+1}} < \frac{1}{\tau}$ $\frac{1}{\tau} - \alpha_{n+1}.$

Subadditivity is achieved if $\tau < r^{j_0} = \min(1, \min_{1 \leq l \leq m} (r^l)')$ (here we apply directly Propo-sition [13](#page-15-0) since $\|\cdot\|_{LR}^{r^{j_0}}$ $L^{R'}_{n+1}$ is subadditive), but it doesn't hold in general. We can overcome this situation by using the following proposition:

Proposition 20. Let T a multilinear operator, and $X_j = L^{R_j}(W, \mu)$ $\forall 1 \leq j \leq n$, $X_{n+1} =$ $L^{R'_{n+1}}(\mathcal{W},\mu)$ multiple vector-valued spaces as above (that is, the Lebesgue exponents $r^l_j, (r^l)'$ satisfy condition [\(8\)](#page-5-3) for a fixed tuple $(\alpha_1, \ldots, \alpha_{n+1})$). Let $\tau \geq r^{j_0}$. Given functions $\vec{f}_1, \ldots, \vec{f}_n$ so that $\|\tilde{f}_1(x,\cdot)\|_{X_1},\ldots,\|\tilde{f}_n(x,\cdot)\|_{X_n}$ are locally integrable, and v any locally τ -integrable function, there exists a sparse domination collection S of dyadic intervals (depending on the functions \vec{f}_j , v and on the Lebesgue exponents s_j , r_j^l , $(r^l)'$ below) so that

$$
\left\| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}} \cdot v\right\|_{\tau}^{\tau} \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \left\| \vec{f}_j(x,\cdot) \right\|_{X_j}^{s_j} \cdot \tilde{\chi}_Q^M dx \Big)^{\frac{\tau}{s_j}} \cdot \Big(\frac{1}{|Q|} \int_{\mathbb{R}} |v(x)|^{\tilde{s}_{n+1}} \cdot \tilde{\chi}_Q^M dx \Big)^{\frac{\tau}{s_{n+1}}} \cdot |Q|.
$$

for any s_j so that $\frac{1}{s_j} < 1 - \alpha_j$ for all $1 \le j \le n$, $\frac{1}{\tilde{s}_{n+1}} < \frac{1}{\tau} - \alpha_{n+1}$.

Proof. We lack subadditivity because $\tau > r^{j_0}$; however, this means that we can dualize the $L^{\frac{7}{r^j}}$ $\overline{r^{j_0}}$ norm. We start with the observation that

$$
\left\| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}} \cdot v\right\|_{\tau}^{\tau} = \left\| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}}^{r^{j_0}} \cdot v^{r^{j_0}}\right\|_{\frac{\tau}{r^{j_0}}}^{\frac{\tau}{r^{j_0}}} = \left(\int_{\mathbb{R}} \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}}^{r^{j_0}} \cdot v^{r^{j_0}} \cdot u \,dx\right)^{\frac{\tau}{r^{j_0}}},
$$

where $u \in L^{(\frac{\tau}{r^j})}$ $(\frac{\tau}{r^{j_0}})'$, with $||u||_{(\frac{\tau}{r^{j_0}})}$ $\frac{\tau}{r^{j_0}}$ $y' = 1$. Note that the function u depends on the previous data (the function $\vec{f}_1, \ldots, \vec{f}_n, v$, the Lebesgue exponents).

Moreover,

$$
\int_{\mathbb{R}} \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}}^{r^{j_0}} \cdot v^{r^{j_0}} \cdot u \, dx = \| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}} \cdot v \cdot u^{\frac{1}{r^{j_0}}}\|_{r^{j_0}}^{r^{j_0}},
$$

for which we can apply the sparse estimate for the exponent $r^{j_0} < 1$. Then $\|\cdot\|_{X_{n+1}}\|_{r^{j_0}}^{r^{j_0}}$ $\frac{r^{j_0}}{r^{j_0}} =$ $\|\hspace{0.1cm}|\hspace{0.1cm} \cdot\hspace{0.1cm}\|_{L^{R_{n+1}^{\prime}}} \|_{r^{j_0}}^{r^{j_0}}$ $\frac{r^{10}}{r^{j_0}}$ is subadditive (by Proposition 7 of [\[BM17\]](#page-58-0)) and we can deduce the sparse domination

$$
\left\| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}} \cdot v \cdot u^{\frac{1}{r^{j_0}}}\|_{r^{j_0}}^{r^{j_0}} \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \left(\frac{1}{|Q|} \int_{\mathbb{R}} \left\| \vec{f}_j(x,\cdot)\right\|_{X_j}^{s_j} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{r^{j_0}}{s_j}} \cdot \left(\frac{1}{|Q|} \int_{\mathbb{R}} |v(x) \cdot u^{\frac{1}{r^{j_0}}}|^{s_{n+1}} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{r^{j_0}}{s_{n+1}}} \cdot |Q|,
$$

where, in this case, s_{n+1} satisfies $\frac{1}{s_{n+1}} < \frac{1}{r_j^j}$ $\frac{1}{r^{j_0}} - \alpha_{n+1}.$

Now we use Hölder's inequality for the $L^{s_{n+1}}$ average, but we need to be cautious about the Lebesgue exponents: we will have

$$
\left(\frac{1}{|Q|}\int_{\mathbb{R}}|v(x)\cdot u^{\frac{1}{r^{j_0}}}|^{s_{n+1}}\cdot \tilde{\chi}_Q^Mdx\right)^{\frac{1}{s_{n+1}}}\leq \left(\frac{1}{|Q|}\int_{\mathbb{R}}|v(x)|^{p_1}\cdot \tilde{\chi}_Q^Mdx\right)^{\frac{1}{p_1}}\cdot \left(\frac{1}{|Q|}\int_{\mathbb{R}}|u^{\frac{1}{r^{j_0}}}|^{p_2}\cdot \tilde{\chi}_Q^Mdx\right)^{\frac{1}{p_2}},
$$

where $\frac{1}{1}$ $\frac{1}{s_{n+1}} = \frac{1}{p_1}$ $\frac{1}{p_1}$ + 1 \overline{p}_2 and $\frac{p_2}{r^{j_0}} < \left(\frac{\tau}{r^j}\right)$ $(\frac{\tau}{r^{j_0}})'$. The latter condition (the necessity of which will be made clear soon) is equivalent to $\frac{1}{1}$ $\frac{1}{p_2} > \frac{1}{r^j}$ $\frac{1}{r^{j_0}}$ – 1 $\frac{1}{\tau}$, so we can set $\frac{1}{p_2}$ $\frac{1}{p_2} = \frac{1}{r^j}$ $\frac{1}{r^{j_0}}$ – 1 $\frac{1}{\tau} + \epsilon$, where $\epsilon > 0$ is arbitrarily small.

We also want to use Hölder's inequality for the spaces $\ell^{\frac{\tau}{r^j}}$ $\frac{\tau}{r^{j_0}}$ and $\ell^{\left(\frac{\tau}{r^{j_0}}\right)}$ $(\frac{\tau}{r^{j_0}})'$, indexed after the sparse collection of dyadic intervals S . In this way, we have

$$
\|T(\vec{f}_1, \ldots, \vec{f}_n)\|_{X_{n+1}} \cdot v \cdot u^{\frac{1}{r^{j_0}}}\|_{r^{j_0}}^{r^{j_0}}
$$
\n
$$
\lesssim \left(\sum_{Q \in S} \prod_{j=1}^n \left(\frac{1}{|Q|} \int_{\mathbb{R}} \|\vec{f}_j(x, \cdot)\|_{X_j}^{s_j} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{\tau}{s_j}} \cdot \left(\frac{1}{|Q|} \int_{\mathbb{R}} |v(x)|^{p_1} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{\tau}{p_1}} |Q|\right)^{\frac{r^{j_0}}{\tau}}
$$
\n
$$
\cdot \left(\sum_{Q \in S} \left(\frac{1}{|Q|} \int_{\mathbb{R}} |u(x)|^{\frac{p_2}{r^{j_0}}} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{r^{j_0}}{p_2}} \cdot \left(\frac{\tau}{r^{j_0}}\right)' |Q|\right)^{\frac{1}{\left(\frac{\tau}{r^{j_0}}\right)'}}
$$

Using the sparseness properties of the collection S , the term on the last line can be bounded by

$$
\left\|\mathcal{M}_{\frac{p_2}{r^{j_0}}}(u)\right\|_{\left(\frac{\tau}{r^{j_0}}\right)'}\lesssim\|u\|_{\left(\frac{\tau}{r^{j_0}}\right)'}=1,
$$

since p_2 was chosen so that $\frac{p_2}{r^{j_0}} < \left(\frac{\tau}{r^{j_0}}\right)$ $(\frac{\tau}{r^{j_0}})'$. We need to observe that our choice of p_2 implies that

$$
\frac{1}{p_1} = \frac{1}{s_{n+1}} - \frac{1}{p_2} = \frac{1}{s_{n+1}} - \frac{1}{r^{j_0}} + \frac{1}{\tau} - \epsilon.
$$

Hence, if we set $\frac{1}{\epsilon}$ $\frac{1}{\tilde{s}_{n+1}} = \frac{1}{p_1}$ $\frac{1}{p_1} = \frac{1}{s_{n+1}}$ $\frac{1}{s_{n+1}}$ 1 $\frac{1}{r^{j_0}}$ + 1 $\frac{1}{\tau}$, then we have $\frac{1}{\tilde{s}_{n+1}}$ $\frac{1}{\tilde{s}_{n+1}} < \frac{1}{\tau}$ $\frac{1}{\tau}$ – α_{n+1} , which is what we wanted.

As a matter of fact, we have obtained that

$$
\left\| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{X_{n+1}} \cdot v\right\|_{\tau}^{\tau} \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \left(\frac{1}{|Q|} \int_{\mathbb{R}} \left\| \vec{f}_j(x,\cdot) \right\|_{X_j}^{s_j} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{\tau}{s_j}} \cdot \left(\frac{1}{|Q|} \int_{\mathbb{R}} |v(x)|^{\tilde{s}_{n+1}} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{\tau}{\tilde{s}_{n+1}}} |Q|.
$$

Remark:. We note that a consequence of Proposition [20](#page-34-0) is that the $L^{s_{n+1}}$ average of v in the sparse domination of $\|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R'}_{n+1}} \cdot v\|_q^q$, for $q \leq r^{j_0}$, can be replaced by an $L^{\tilde{s}_{n+1}}$ average in the sparse domination of $||T(\vec{f}_1,\ldots,\vec{f}_n)||_{L^{R'_{n+1}}} \cdot v||_{\tau}^{\tau}$ if $\tau > q$, where 1 $\frac{1}{\tilde{s}_{n+1}} = \frac{1}{s_{n+1}}$ $\frac{1}{s_{n+1}} - \frac{1}{q}$ $\frac{1}{q} + \frac{1}{\tau}$ $\frac{1}{\tau}$.

6.3. Weighted estimates. Using the Fefferman-Stein vector-valued inequality from Corol-lary [2,](#page-6-3) we can deduce weighted estimates for the multiple vector-valued extensions of T_k . Alternatively, weighted estimates can be deduced directly from the sparse form, which would probably imply better quantitative estimates. Instead, we use the Fefferman-Stein inequality, which is itself deduced from the sparse domination.

We recall the multi(sub)-linear maximal operator $\mathcal{M}_{s_1,...,s_n}$, defined in [\(3\)](#page-2-1) by

$$
\vec{\mathcal{M}}_{s_1,...,s_n}(f_1,...,f_n)(x) \coloneqq \sup_{Q \ni x} \prod_{j=1}^n \Big(\frac{1}{|Q|}\int_Q |f_j(y)|^{s_j} dy\Big)^{\frac{1}{s_j}}.
$$

We use the inequality

$$
\left\| \|T_{k}(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R'_{n+1}}}\right\|_{L^{q}(w^q)} \lesssim \left\|\vec{\mathcal{M}}_{s_1,\ldots,s_n}\right(\|\vec{f}_1(x,\cdot)\|_{L^{R_1}},\ldots,\|\vec{f}_n(x,\cdot)\|_{L^{R_n}})\right\|_{L^{q}(w^q)},
$$

which holds true for s_1, \ldots, s_{n+1}, q as in Corollary [2,](#page-6-3) provided $w^q \in RH_{\frac{s_{n+1}}{q}}$.

Weighted estimates for $\mathcal{M}_{s_1,\dots,s_n}$ can be obtained, following closely the procedure in [\[LOP](#page-59-5)+09b]. We have the following results:

Proposition 21. Let $\frac{1}{n} < q \le \infty$, $1 \le s_j < q_j \le \infty$, $1 \le j \le n$, and $\frac{1}{q} = \frac{1}{q_j}$ $\frac{1}{q_1} + \ldots + \frac{1}{q_r}$ $\frac{1}{q_n}$. Let ν and w_j be weights (here we set $w_j \equiv 1$ if $p_j = \infty$). Then the inequality

$$
\|\vec{\mathcal{M}}_{s_1,\dots,s_n}(f_1,\dots,f_n)\|_{L^{q,\infty}(\nu)} \leq C \prod_{j=1}^n \|f_j\|_{L^{q_j}(w_j)}
$$

holds for any functions f_1, \ldots, f_n if and only if

(63)
$$
\sup_{Q} \left(\int_{Q} \nu \right)^{\frac{1}{q}} \prod_{j=1}^{n} \left(\int_{Q} w_j^{-\frac{s_j}{q_j - s_j}} \right)^{\frac{1}{s_j} - \frac{1}{q_j}} < +\infty.
$$

Proof. For the necessity, we note that

$$
Q \subseteq \{x : \vec{M}_{s_1,\dots,s_n}(f_1,\dots,f_n)(x) > \prod_{j=1}^n \left(\int_Q |f_j|^{s_j}\right)^{\frac{1}{s_j}},\}
$$

and hence

$$
\Bigl(\!\!\int_Q\nu\Bigr)^{\frac{1}{q}}\,\prod_{j=1}^n\Bigl(\!\!\int_Q|f_j|^{s_j}dx\Bigr)^{\frac{1}{s_j}}\le C\,\Bigl(\!\!\int_Q|f_j|^{q_j}\,w_jdx\Bigr)^{\frac{1}{q_j}}.
$$

Picking $f_j = w$ $rac{1}{s_j-q_j}$ $j_j^{s_j-q_j}$ so that $|f_j|^{s_j} = |f_j|^{q_j} w_j$, we obtain [\(63\)](#page-36-1), since Q was arbitrary.

We adapt the proof from [\[LOP](#page-59-5)⁺09b] in order to show sufficiency. A straightforward application of Hölder's inequality yields that

$$
\vec{\mathcal{M}}_{s_1,\ldots,s_n}(f_1,\ldots,f_n)(x) \leq \sup_{Q} \left(\frac{f}{Q} \nu\right)^{\frac{1}{q}} \prod_{j=1}^n \left(\frac{f}{Q} w_j^{-\frac{s_j}{q_j-s_j}}\right)^{\frac{1}{s_j}-\frac{1}{q_j}} \cdot \prod_{j=1}^n \mathcal{M}_{\nu}\left(|f_j|^{q_j} \frac{w_j}{\nu}\right)^{\frac{1}{q_j}}.
$$

Hölder's inequality for weak L^p spaces and the boundedness of the weighted maximal operator \mathcal{M}_{ν} imply the $L^{q_1}(w_1) \times \ldots \times L^{q_n}(w_n) \to L^{q,\infty}(w)$ boundedness of $\mathcal{M}_{s_1,\ldots,s_n}$. Whenever $q_j = \infty$, the L^{∞} norm of f_j is set on the side, and the problem reduces to the study of an $(n-1)$ -linear maximal operator.

Remark:. Since our study of the T_k operators is focusing on $L^{p_1} \times \ldots \times L^{p_n} \mapsto L^{p'_{n+1}}$ for $1 < p_1, \ldots, p_n \le \infty$, we only consider the boundedness of $\mathcal{\vec{M}}_{s_1,\ldots,s_n}$ operators on $L^{q_1} \times \ldots \times L^{q_n}$ for $q_j > s_j$: for simplicity, we leave out the case $q_j = s_j$.

However, the operators T_k and their vector-valued extensions are controlled by $\mathcal{M}_{s_1,...,s_n}$ in L^q norms and we need a strong-type version of the above result. We continue on following [\[LOP](#page-59-5)⁺09b] and adapt the definitions therein:

Definition 12. Let $1 \le s_j < q_j \le \infty$. Given $\vec{w} = (w_1, \ldots, w_n)$, we set $\nu_{\vec{w}} =$ n ∏ $j=1$ w q qj $j^{\tiny{g_j}}$. We say that \vec{w} satisfies the $A_{\vec{z}}$ condition if

$$
a_1 \ldots a_n \ldots a_n
$$

(64)
$$
\sup_{Q} \left(\oint_{Q} \nu_{\vec{w}} \right)^{\frac{1}{q}} \prod_{j=1}^{n} \left(\oint_{Q} w_j^{-\frac{s_j}{q_j - s_j}} \right)^{\frac{1}{s_j} - \frac{1}{q_j}} < +\infty.
$$

We denote the quantity in [\(64\)](#page-37-1) $[w_1, \ldots, w_n]_{A_{\vec{q}, \vec{s}}}$.

Notation:. Above and everywhere else, whenever $q_j = \infty$, it should be understood that $w_j \equiv 1$.

Then we have the strong-type boundedness of $\mathcal{M}_{s_1,\dots,s_n}$:

Proposition 22. Let $1 \leq s_j < q_j \leq \infty$, $1 \leq j \leq n$, and $\frac{1}{q} = \frac{1}{q_j}$ $\frac{1}{q_1} + \ldots + \frac{1}{q_n}$ $\frac{1}{q_n}$. Let $\vec{w} = (w_1, \ldots, w_n)$ be a vector weight. Then the inequality

$$
\left\|\vec{\mathcal{M}}_{s_1,\ldots,s_n}(f_1,\ldots,f_n)\right\|_{L^q(\nu_{\vec{w}})} \leq C \prod_{j=1}^n \|f_j\|_{L^{q_j}(w_j)}
$$

holds for any functions f_1, \ldots, f_n if and only if \vec{w} satisfies the $A_{\vec{q}, \vec{s}}$ condition.

The proof of the above Proposition (the details of which are left to the interested reader) is based on a *reverse Hölder* property of each of the weights making up the vector weight

(see Theorem 3.6 in [\[LOP](#page-59-5)⁺ 09b] and Lemma 3.2 in [\[LMO18\]](#page-58-15)). This would yield, for some $\alpha < 1$

$$
\vec{\mathcal{M}}_{s_1,\ldots,s_n}(f_1,\ldots,f_n)(x)\leq C\cdot \prod_{j=1}^n \mathcal{M}_{\nu_{\vec{w}}}((|f_j|^{q_j}\frac{w_j}{\nu_{\vec{w}}})^{\alpha})^{\frac{1}{q_j\alpha}},
$$

and such an inequality, together with the strong boundedness of the weighted (sub-)linear maximal function $\mathcal{M}_{\nu_{\tilde{w}}}$ implies the result in Proposition [22.](#page-37-0)

In fact, for proving the boundedness of $\mathcal{\vec{M}}_{s_1,\dots,s_n}$ we need a simpler version than Lemma [23](#page-38-0) below. However, we will see that the vector weight condition [\(64\)](#page-37-1) pairs with a certain reverse Hölder condition to yield the assumption (12) of Corollary [3.](#page-6-1) Hence the required result is similar to Lemma 3.2 from [\[LMO18\]](#page-58-15).

Lemma 23. Let $\vec{w} = (w_1, \ldots, w_n)$ be a vector weight as above. Then

(65)
$$
\sup_{Q} \left(\int_{Q} \nu_{\vec{w}}^{\frac{\beta}{q}} \right)^{\frac{1}{\beta}} \prod_{j=1}^{n} \left(\int_{Q} w_{j}^{-\frac{\beta_{j}}{q_{j}}} \right)^{\frac{1}{\beta_{j}}} < \infty
$$

if and only if ν $\frac{\beta}{\omega}$ \in A_t with t = 1 + β (n ∑ $i=1$ 1 $\frac{1}{\beta_i}$ and for every $1 \leq j \leq n$, w $-\frac{\beta_j}{\beta}$ q_j j^{q_j} $\in A_{t_j}$ where $t_j = 1 + \beta_j \Big(\frac{1}{\beta}\Big)$ $\frac{1}{\beta}$ + $\sum_{i \neq i}$ i≠j 1 $\frac{1}{\beta_i}$). Moreover, if we denote by C the expression in [\(65\)](#page-38-1), we have $[\nu_{\vec{w}}]_{A_t} \leq C^{\beta}$ and $[w]$ $-\frac{\beta_j}{\alpha_j}$ q_j j^{q_j} $\Big]_{A_{t_j}} \leq C^{\beta_j}$.

Proof. We only prove the direct implication, the reverse being an easy consequence of Hölder's inequality. Fix $1 \leq j \leq n$. We want to prove that

$$
\int_Q w_j^{-\frac{\beta_j}{q_j}}\cdot (\int_Q w_j^{\frac{\beta_j}{q_j}(t'_j-1)})^{(t_j-1)}\leq C^{\beta_j}.
$$

First, note that w β_j $\frac{\beta_j}{q_j}(t'_j-1)$ j = n ∏ $i=1$ w $\frac{\beta_i}{q_i}\left(t'_i-1\right)$ $\frac{q_i}{i}$. n ∏ $i=1$ i≠j $w_i^{-\frac{\beta_i}{q_i}\, (t'_i-1)}$ $\int_{i}^{-\frac{a_i}{q_i}(t_i-1)}$, for numbers t'_i $\frac{1}{i}$ that are to be

determined if $i \neq j$. We will also need certain Lebesgue indices r_1, \ldots, r_n satisfying the Hölder condition $\frac{1}{r_1} + \ldots + \frac{1}{r_r}$ $\frac{1}{r_n}$ = 1. With these, we have

$$
\int_{Q}w_j^{\frac{\beta_j}{q_j}(t'_j-1)}dx\leq \Bigl(\!\int_{Q}\prod_{i=1}^n w_i^{\frac{\beta_i}{q_i}\,r_j\,(t'_i-1)}\Bigr)^{\frac{1}{r_j}}\cdot \prod_{\substack{i=1\\i\neq j}}^n \Bigl(\!\int_{Q}w_i^{-\frac{\beta_i}{q_i}\,r_i\,(t'_i-1)}\Bigr)^{\frac{1}{r_i}}.
$$

Now we want to choose the Lebesgue exponents so that

$$
\frac{\beta_i}{q_i} r_j(t'_i - 1) = \frac{q}{q_i} \cdot \frac{\beta}{q} \quad \text{for all} \quad 1 \le i \le n, \qquad \frac{\beta_i}{q_i} r_i(t'_i - 1) = \frac{\beta_i}{q_i} \quad \text{for all} \quad 1 \le i \le n, i \ne j.
$$

Such a choice is possible provided $r_i = r_j \frac{\beta_i}{\beta_i}$ $\frac{\beta_i}{\beta}$ for $i \neq j$ and $r_j = \frac{\beta(t_j-1)}{\beta_j}$ $\frac{\ell_j-1}{\beta_j}$. Moreover, the condition n ∑ $i=1$ 1 $\frac{1}{r_i}$ = 1 determines t_j uniquely: it is given by $t_j = 1 + \beta_j \left(\frac{1}{\beta}\right)$ $\overline{\beta}$ + $\sum_{i \neq j}$ i≠j 1 $\frac{1}{\beta_i}$). In order to prove the desired estimate $\lfloor w \rfloor$ $-\frac{\beta_j}{\alpha_j}$ q_j $\left[\frac{r_j}{q_j}\right]_{A_{t_j}} \leq C^{\beta_j}$, we only need to check that $\frac{t_j - 1}{r_j}$ $\frac{-1}{r_j} = \frac{\beta_j}{\beta}$ $\frac{\partial f}{\partial \beta}$ and

 $t_j - 1$ $\frac{-1}{r_i} = \frac{\beta_j}{\beta_i}$ $\frac{\beta_j}{\beta_i}$, which are immediate consequences of the above choices. The estimate for ν $\frac{\beta}{q}$ is very similar and we skip the details.

Now we are ready to deduce the weighted estimates for T_k .

Proof of Corollary [3.](#page-6-1) The exponents $s_1, \ldots, s_n, s_{n+1}$ satisfy, for $\alpha_1, \ldots, \alpha_{n+1}$ given by [\(57\)](#page-28-0)

$$
\frac{1}{s_j} < 1 - \alpha_j \quad \text{for all} \quad 1 \le j \le n, \qquad \frac{1}{s_{n+1}} < \frac{1}{q} - \alpha_{n+1}.
$$

The Fefferman-Stein inequality from Corollary [2](#page-6-3) implies, under the assumption that w^q $RH_{\frac{s_{n+1}}{q}},$ that

$$
\left\| \|T_k(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R_{n+1}'}}\right\|_{L^q(w^q)} \lesssim \left\|\vec{\mathcal{M}}_{s_1,\ldots,s_n}\left(\|\vec{f}_1(x,\cdot)\|_{L^{R_1}},\ldots,\|\vec{f}_n(x,\cdot)\|_{L^{R_n}}\right)\right\|_{L^q(w^q)},
$$

while Proposition [22](#page-37-0) implies that

$$
\left\|\vec{\mathcal{M}}_{s_1,\ldots,s_n}(f_1,\ldots,f_n)\right\|_{L^q(\nu_{\vec{w}})} \leq C \prod_{j=1}^n \left\|f_j\right\|_{L^{q_j}(w_j^{q_j})},
$$

if the $A_{\vec{q}, \vec{s}}$ condition is satisfied for the vector weight $\vec{w} = (w_1^{q_1})$ $a_1^{q_1}, \ldots, a_n^{q_n}$).

Hence we need to check that [\(12\)](#page-6-2) implies that

(66)
$$
w^{q} \in RH_{\frac{s_{n+1}}{q}} \text{ and } \vec{w} = (w_1^{q_1}, \dots, w_n^{q_n}) \in A_{\vec{q}, \vec{s}}.
$$

We note that in this case $\nu_{\vec{w}} = (w_1 \cdot \ldots \cdot w_n)^q = w^q$. Our main tool is Lemma [23:](#page-38-0) we apply it with $\beta = s_{n+1}$ and $\beta_j = \frac{q_j s_j}{q_j - s_j}$ $\frac{q_j s_j}{q_j - s_j}$ to the joint vector weight condition [\(12\)](#page-6-2)

$$
\sup_{Q} \left(\oint_{Q} w^{s_{n+1}} \right)^{\frac{1}{s_{n+1}}} \prod_{j=1}^{n} \left(\oint_{Q} w_{j}^{-\frac{1}{\frac{1}{s_{j}} - \frac{1}{q_{j}}}} \right)^{\frac{1}{s_{j}} - \frac{1}{q_{j}}} < \infty.
$$

We obtain that

(67)
$$
(w^q)^{\frac{s_{n+1}}{q}} \in A_{1+\frac{s_{n+1}}{q}(\sum\limits_{i=1}^n\frac{q}{\beta_i})}, \quad w_j^{-\beta_j} \in A_{t_j} = A_{1+\beta_j(\frac{1}{s_{n+1}}+\sum\limits_{i\neq j}\frac{1}{\beta_i})}.
$$

But the condition $(w^q)^{\frac{s_{n+1}}{q}} \in A_{1+\frac{s_{n+1}}{q}(\sum\limits_{i=1}^n a_i)}$ $\frac{q}{\beta_i}$) is equivalent to $w^q \in RH_{\frac{s_{n+1}}{q}} \cap A_{1+q(\sum\limits_{i=1}^n a_i)}$ $\frac{1}{\beta_i})$ (here we use that $v \in A_p \cap RH_s \Leftrightarrow v^s \in A_{s(p-1)+1}$). Hence we obtain

(68)
$$
w^q \in RH_{\frac{s_{n+1}}{q}} \quad \text{and} \quad w^q \in A_{1+q(\sum\limits_{i=1}^n \frac{1}{\beta_i})}.
$$

We are left with checking that $\vec{w} \in A_{\vec{q},\vec{s}}$, and for that we use again Lemma [23,](#page-38-0) but in the reverse direction. In this case $\tilde{\beta} = q$, $\tilde{\beta}_j = \beta_j = \frac{q_j s_j}{q_i - s_j}$ $\frac{q_j s_j}{q_j - s_j}$, and

$$
\tilde t=1+\tilde\beta\big(\sum_{i=1}^n\frac{1}{\tilde\beta_i}\big)=1+q\big(\sum_{i=1}^n\frac{1}{\beta_i}\big),\qquad \tilde t_j=1+\tilde\beta_j\big(\frac{1}{\tilde\beta}+\sum_{i\neq j}\frac{1}{\tilde\beta_i}\big)=1+\beta_j\big(\frac{1}{q}+\sum_{i\neq j}\frac{1}{\beta_i}\big).
$$

Lemma [23](#page-38-0) implies that $\vec{w} \in A_{\vec{q}, \vec{s}}$ provided

$$
\nu_{\vec{w}} = w^q \in A_{\tilde{t}} = A_{1+q\big(\sum\limits_{i=1}^n\frac{1}{\beta_i}\big)}, \qquad w^{-\beta_j} \in A_{\tilde{t}_j}
$$

.

The first condition was deduced in [\(68\)](#page-39-0), while the second one follows from [\(67\)](#page-39-1) since $\tilde{t}_j > t_j$ (due to the fact that $\frac{1}{s_{n+1}} < \frac{1}{q}$ $\frac{1}{q} - \alpha_{n+1} < \frac{1}{q}$ $\frac{1}{q}$ and $A_{t_j} \in A_{\tilde{t}_j}$. Therefore the multi(sub-)linear operator does satisfy the weighted estimates we wanted.

We remark that weighted estimates for vector weights satisfying (12) can also be deduced directly from the sparse domination.

6.4. The case $k = 0$. Of particular importance is the case $k = 0$. In this situation, the operator T of Theorem [1](#page-4-0) is a multilinear Fourier multiplier, as introduced by Coifman and Meyer [\[CM97\]](#page-58-23). Weighted estimates for multilinear Calderón-Zygmund operators were achieved in [\[LN15\]](#page-58-17), by proving a pointwise sparse domination, which allowed the authors to treat directly the quasi-Banach case as well.

We note that a rank-0 collection of tiles is one which has 0 *degrees of freedom* in frequency; that means, the tiles are completely characterized by their spatial interval. For that reason, we can index the tiles after a collection I of dyadic intervals.

In the scalar case, that is, when $m = 0, q = 1$, we recover the sparse estimates of [\[LN15\]](#page-58-17) by examining the $(n+1)$ -linear form. In the Banach case, the localization result can be obtained directly for general functions, with L^1 sizes (here we have $\alpha_j = 0$):

$$
(\text{loc } m) \qquad |\Lambda_{\mathbb{P}(I_0)}(f_1,\ldots,f_{n+1})| \lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size }}_{I_0}|f_j|\right) \cdot |I_0|.
$$

To see this, it is enough to observe in the proof of Theorem [19](#page-28-1) that Lemma [18](#page-26-0) can be replaced by the following decomposition algorithm:

Lemma 24. If $\mathbb P$ is a rank-0 collection of tiles with $size_{\mathbb P}(\langle f, \phi_P \rangle) \leq \lambda$, then there exists a decomposition $\mathbb{P} = \mathbb{P}' \cup \mathbb{P}''$ so that size $_{\mathbb{P}'}(\langle f, \phi_P \rangle) \leq \frac{\lambda}{2}$ $\frac{\lambda}{2}$ and \mathbb{P}'' is a union $\mathbb{T} = \bigcup$ $\widetilde{T\epsilon\mathbb{T}}$ T of disjoint trees so that

$$
\sum_{T\in\mathbb{T}}|I_T|\lesssim \lambda^{-1}\|f\|_1.
$$

Proof. The proof is basically contained in Lemma 2.10 and Lemma 2.14 of [\[MS13\]](#page-59-6). \Box

For the quasi-Banach case, when τ < 1, the localization estimate is

(69)
$$
\|T(f_1,\ldots,f_n)\cdot v\|_{\tau} \lesssim \prod_{j=1}^n \left(\widetilde{\text{size}}_{I_0}f_j\right) \cdot \left(\widetilde{\text{size}}_{I_0}^{\tau}v\right) \cdot |I_0|^{\frac{1}{\tau}}.
$$

If v is a characteristic function, the result has already appeared in [\[BM17\]](#page-58-0), and the general case follows as in Proposition [35](#page-50-0) of the later Section [7.5,](#page-54-0) by writing $v = v_1 \cdot v_2$, where $v_1 \in L^1_{loc}$ and $v_2 \in L^{\tau_0}_{loc}$, with $1 < \frac{1}{\tau_0}$ $\frac{1}{\tau} = 1 + \frac{1}{\tau_0}$ $\frac{1}{\tau_0}$.

This further implies the sparse estimate (which depends on the locally integrable functions f_1, \ldots, f_n, v^τ :

$$
||T(f_1,\ldots,f_n)\cdot v||_{\tau}^{\tau} \lesssim \sum_{Q\in\mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|}\int_{\mathbb{R}} |f_j| \cdot \tilde{\chi}_Q^M dx\Big)^{\tau} \Big(\frac{1}{|Q|}\int_{\mathbb{R}} |v(x)|^{\tau} \cdot \tilde{\chi}_Q^M dx\Big) \cdot |Q|,
$$

which is very similar to the quasi-Banach case presentation in [\[LN15\]](#page-58-17).

Reasoning as in Proposition [20,](#page-34-0) we can prove, for $q > 1$ and any $\epsilon > 0$, the sparse domination

$$
\left\|T(f_1,\ldots,f_n)\cdot v\right\|_{q}^q \lesssim \sum_{Q\in\mathcal{S}}\prod_{j=1}^n\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\big|f_j\big|\cdot\tilde{\chi}_Q^M\,dx\Big)^q\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\big|v(x)\big|^{q+\epsilon}\cdot\tilde{\chi}_Q^M\,dx\Big)^{\frac{q}{q+\epsilon}}\cdot|Q|,
$$

where the collection S of dyadic intervals depends on the functions f_1, \ldots, f_n, v and on the Lebesgue exponent q.

 \Box

In the general depth-m case, we are short of obtaining a similar result. An argument similar to that presented in the proof of Theorem [1](#page-4-0) yields a sparse domination of the multilinear form involving $L^{1+\epsilon}$ averages for all functions involved. Using the more careful argument of Section [7.5,](#page-54-0) we can in fact allow "most of the averages" to be in $L¹$. This will be made precise later.

Nevertheless, if all the Lebesgue exponents r_j^l are strictly between 1 and ∞ (so we are in the case of reflexive Banach spaces), we can obtain directly a localization result with L^1 vector-valued averages which entails, in the case $q = 1$, a sparse domination result with $L¹$ averages.

Proposition 25. If $X_j = L^{R_j}(W, \mu)$ are multiple vector-valued spaces with $1 < r_j^l < \infty$ for all $1 \leq l \leq m, 1 \leq j \leq n+1$, we have, for the $(n+1)$ -linear form of a vector-valued multilinear Fourier multiplier:

(70)
$$
|\Lambda_{\mathbb{P}(I_0)}(\vec{f}_1,\ldots,\vec{f}_{n+1})| \lesssim \prod_{j=1}^{n+1} \left(\widetilde{\text{size}}_{I_0} \| \vec{f}_j(x,\cdot) \|_{X_j}\right) \cdot |I_0|.
$$

Proof. We present the proof in the particular case when $n = 2$, $m = 1$, but the generalization is routine. We note that we can write the trilinear form as

$$
\Lambda_{\mathbb{P}(I_0)}(\vec{f},\vec{g},\vec{h})=\sum_k\sum_{\substack{I\in\mathbb{J}\\ I\subseteq I_0}}\frac{1}{|I|^{\frac{1}{2}}}\langle f_k,\varphi_I\rangle\langle g_k,\psi_I\rangle\langle h_k,\psi_I\rangle,
$$

where $\{\psi_I\}_I$ are lacunary and $\{\varphi_I\}_I$ are "overlapping" families of L^2 -adapted wave packets associated to the collection J. In the general case of a $(n+1)$ -linear form, we have at least two lacunary families. The lacunarity condition implies that

$$
\mathcal{S}_{I_0}(g)(x)\coloneqq \big(\sum_{\substack{I\in \mathcal{I}\\ I\subseteq I_0}}\frac{|\langle g,\psi_I\rangle|^2}{|I|}\cdot \mathbf{1}_I(x)\big)^{\frac{1}{2}}
$$

defines a discretized square function as in Chapter 2.3 of [\[MS13\]](#page-59-6). Similarly,

$$
f \mapsto \sup_{\substack{I \in \mathcal{I} \\ I \subseteq I_0}} \frac{|\langle f, \varphi_I \rangle|}{|I|^{\frac{1}{2}}}
$$

plays the role of a maximal operator.

If the vector spaces involved are $\ell^{r_1}, \ell^{r_2}, \ell^{r_3}$, with $\frac{1}{\ell^{r_1}}$ $\frac{1}{r_1}$ + 1 $\frac{1}{r_2}$ + 1 $\frac{1}{r_3}$ = 1, we have the estimate

$$
\begin{split}\n&\Big|\sum_{k}\sum_{I\in\mathcal{I}_0}\frac{1}{|I|^{\frac{1}{2}}}\langle f_k,\varphi_I\rangle\langle g_k,\psi_I\rangle\langle h_k,\psi_I\rangle\Big| \\
&= \Big|\int_{\mathbb{R}}\sum_{k}\sum_{I\in\mathcal{I}_0}\frac{\langle f_k,\varphi_I\rangle}{|I|^{\frac{1}{2}}}\cdot\mathbf{1}_I(x)\frac{\langle g_k,\psi_I\rangle}{|I|^{\frac{1}{2}}}\cdot\mathbf{1}_I(x)\frac{\langle h_k,\psi_I\rangle}{|I|^{\frac{1}{2}}}\cdot\mathbf{1}_I(x)dx\Big| \\
&\lesssim \int_{\mathbb{R}}\Big(\sum_{k}\Big|\sup_{I\in\mathcal{I}_0}\frac{|\langle f_k,\varphi_I\rangle|}{|I|^{\frac{1}{2}}}\cdot\mathbf{1}_{I_0}(x)\Big|^{r_1}\Big)^{\frac{1}{r_1}}\n\cdot\Big(\sum_{k}\Big(\sum_{I\in\mathcal{I}_0}\frac{|\langle g_k,\psi_I\rangle|^2}{|I|}\cdot\mathbf{1}_I(x)\Big)^{\frac{r_2}{2}}\Big)^{\frac{1}{r_2}}\cdot\Big(\sum_{k}\Big(\sum_{I\in\mathcal{I}_0}\frac{|\langle h_k,\psi_I\rangle|^2}{|I|}\cdot\mathbf{1}_I(x)\Big)^{\frac{r_3}{2}}\Big)^{\frac{1}{r_3}}dx\n\end{split}
$$

The first term, corresponding to the maximal operator, can be bounded pointwise by

$$
\Big(\sum_{k}\Big|\inf_{y\in I_0}\mathcal{M}(f_k\cdot\tilde{\chi}_{I_0}^M)(y)\Big|^{r_1}\Big)^{\frac{1}{r_1}}\lesssim \frac{1}{|I_0|}\Big\|\Big(\sum_{k}\Big|\mathcal{M}(f_k\cdot\tilde{\chi}_{I_0}^M)\Big|^{r_1}\Big)^{\frac{1}{r_1}}\Big\|_{1,\infty}.
$$

Invoking the weak-type (1, 1) Fefferman-Stein inequality, we can estimate this by

$$
\frac{1}{|I_0|} \left\| \left(\sum_{k} |f_k|^{r_1} \right)^{\frac{1}{r_1}} \cdot \tilde{\chi}_{I_0}^M \right\|_1 \lesssim \widetilde{\text{size}}_{I_0} \| \vec{f} \|_{\ell^{r_1}}.
$$

Hence

$$
\left|\Lambda_{\mathbb{P}(I_{0})}(\vec{f},\vec{g},\vec{h})\right| \lesssim \widetilde{\text{size}}_{I_{0}} \|\vec{f}\|_{\ell^{r_{1}}} \cdot \frac{1}{|I_{0}|^{\frac{1}{2}}}\left\|\left(\sum_{k}\left(\sum_{\substack{I\in\mathcal{I} \\ I\subseteq I_{0}}}\frac{|\langle g_{k}, \psi_{I}\rangle|^{2}}{|I|} \cdot \mathbf{1}_{I}(x)\right)^{\frac{r_{2}}{2}}\right)^{\frac{1}{r_{2}}}\right\|_{2} \cdot \frac{1}{|I_{0}|^{\frac{1}{2}}}\left\|\left(\sum_{k}\left(\sum_{\substack{I\in\mathcal{I} \\ I\subseteq I_{0}}}\frac{|\langle h_{k}, \psi_{I}\rangle|^{2}}{|I|} \cdot \mathbf{1}_{I}(x)\right)^{\frac{r_{3}}{2}}\right)^{\frac{1}{r_{3}}}\right\|_{2} \cdot |I_{0}|.
$$

So we have, for each of the functions \vec{g} and \vec{h} , an L^2 average of the vector-valued square function. Using a vector-valued John-Nirenberg inequality (a straightforward generaliza-tion of Theorem 2.7 of [\[MS13\]](#page-59-6)), we can obtain a "weak L^1 average":

$$
\sup_{I'\subseteq I_0}\frac{1}{|I'|^{\frac{1}{2}}}\Big\|\Big(\sum_{k}\Big(\sum_{\substack{I\in\mathcal{I}\\I\subseteq I'}}\frac{|\langle g_k,\psi_I\rangle|^2}{|I|}\cdot\mathbf{1}_I(x)\Big)^{\frac{r_2}{2}}\Big)^{\frac{1}{r_2}}\Big\|_2\sim\sup_{I'\subseteq I_0}\frac{1}{|I'|}\Big\|\Big(\sum_{k}\Big(\sum_{\substack{I\in\mathcal{I}\\I\subseteq I'}}\frac{|\langle g_k,\psi_I\rangle|^2}{|I|}\cdot\mathbf{1}_I(x)\Big)^{\frac{r_2}{2}}\Big)^{\frac{1}{r_2}}\Big\|_{1,\infty}.
$$

If $1 < r_2 < \infty$, the ℓ^{r_2} -valued square function is a bounded operator from L^1 into $L^{1,\infty}$, so in the end we get [\(70\)](#page-41-0).

From the proof above, it is clear that, as long as they are not associated to the lacunary directions (i.e. to one of the two square functions), we can allow the Lebesgue exponents r_j^l to be equal to ∞ . But in the general depth-m case, when we let $1 < r_j^l \leq \infty$, we have, as announced in Theorem [5,](#page-7-0) the following: for any $\epsilon > 0$ and any vector-valued functions $\vec{f}_1,\ldots,\vec{f}_{n+1}$ so that $\|\vec{f}_j(x,\cdot)\|_{X_j}$ are locally integrable, there exists a sparse collection S depending on the functions \vec{f}_j for which

$$
\left|\Lambda_{\mathbb{P}}(\vec{f}_1,\ldots,\vec{f}_{n+1})\right| \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^{n+1} \left(\frac{1}{|Q|} \int_{\mathbb{R}} \| \vec{f}_j(x,\cdot) \|_{X_j}^{1+\delta_j} \cdot \tilde{\chi}_Q^M dx\right)^{\frac{1}{1+\delta_j}} \cdot |Q|,
$$

where $\delta_j \in \{0, \epsilon\}$, and we can arrange that at most m of the $\delta_j \neq 0$. However, if $\delta_j \neq 0$, then j is an index so that in the multiple vector space $X_j = L^{\tilde{R}_j}(\mathcal{W}, \mu)$ there are no L^{∞} involved: $r_j^l < \infty$ for all $1 \leq l \leq m$.

As mentioned before, this follows from an analysis similar to that of Section [7.5.](#page-54-0) In the scalar case, when $m = 0$, we can obtain directly a sparse domination with only $L¹$ averages. For $m = 1$, the result with at most one $L^{1+\epsilon}$ average follows from the estimate

$$
\left|\Lambda_{\mathbb{P}(I_0)}(f, f_1^1 \cdot f_1^2, \ldots, f_n^1 \cdot f_n^2)\right| \lesssim \widetilde{\text{size}\,}^{r+\epsilon}_{I_0}(1_F) \cdot |F|^{\frac{1}{r'}} \cdot \prod_{k=1}^n \left(\widetilde{\text{size}\,}^{r'_k}_{I_0} f_k^1\right) \cdot \|f_k^2\|_{r_k},
$$

where $|f(x)| \leq \mathbf{1}_F, \frac{1}{\epsilon}$ $\frac{1}{r_1} + \ldots + \frac{1}{r_2}$ $\frac{1}{r_2} = \frac{1}{r}$ $\frac{1}{r}$, and $1 < r < \infty$, $1 < r_k < \infty$. Then we deduce the vector-valued local result, as in Proposition [37,](#page-54-1) leaving intact the sizes corresponding to ℓ^{∞} , if there are any. In would be interesting to understand whether a multiple vectorvalued sparse domination with L^1 averages can be obtained in the general case, when L^{∞} spaces are allowed. However, it was noticed in [\[LN15\]](#page-58-17) that weighted estimates involving \tilde{L}^{∞} spaces can still be deduced from a sparse domination with exponents strictly between 1 and ∞ , by a careful passage to the limit.

In the quasi-Banach case, if $n = 2$, we can prove using [\(69\)](#page-40-1) that the operator

$$
f \mapsto T_{I_0}(f \cdot \mathbf{1}_F, g_1 \cdot g_2)
$$

maps $L^{r_1,1}$ into $L^r(w)$, with an operatorial norm equal to

$$
\left(\widetilde{\text{size}\,}_{I_0}\mathbf{1}_F\right)^{\frac{1}{r_1'}-\epsilon}\cdot\left(\widetilde{\text{size}\,}_{I_0}^{r_2'}g_1\right)\cdot\left(\widetilde{\text{size}\,}_{I_0}w\right)^{\frac{1}{r}}\|g_2\cdot\widetilde{\chi}_{I_0}^M\|_{r_2},
$$

where $w \ge 0$ is a fixed locally integrable function and $1 < r_1, r_2 \le \infty$, $\frac{1}{r}$ $\frac{1}{r_1}$ 1 $\frac{1}{r_2} = \frac{1}{r}$ $\frac{1}{r} > 1$. Since $r < 1$, we cannot have $r_1 = \infty$ or $r_2 = \infty$. For $n \geq 3$, L^{∞} spaces could appear, and in that situation the analysis is similar to the Banach case described earlier.

Using interpolation (for example, Theorem 1.4.19 of $[Gra08]$), with r_2 fixed, we get that

$$
\|T_{I_0}(f\cdot\mathbf{1}_F,g_1\cdot g_2)\cdot w^{\frac{1}{r}}\|_r^r \lesssim \left[\left(\widetilde{\text{size}\,}_{I_0}\mathbf{1}_F\right)^{\frac{1}{r_1}-\epsilon}\cdot\left(\widetilde{\text{size}\,}_{I_0}^{r_2'}g_1\right)\cdot\left(\widetilde{\text{size}\,}_{I_0} w\right)^{\frac{1}{r}}\right]^r \|f\cdot\widetilde{\chi}_{I_0}^M\|_{r_1}^r \cdot \|g_2\cdot\widetilde{\chi}_{I_0}^M\|_{r_2}^r.
$$

As in Proposition [37,](#page-54-1) this can be used for proving, for vector-valued functions \tilde{f} = $\{f_k\}, \vec{g} = \{g_k\}$ so that $\|\vec{f}(x)\|_{\ell^{r_1}}, \|\vec{g}(x)\|_{\ell^{r_2}}$ are locally integrable, that

$$
\left\| \left(\sum_{k} |T_{I_0}(f_k, g_k)|^r \right)^{\frac{1}{r}} \cdot v \right\|_{\tau}^{\tau} \lesssim \left(\widetilde{\text{size}} \, I_0^{-1+\epsilon} \| \vec{f} \|_{\ell^{r_1}} \right)^{\tau} \cdot \left(\widetilde{\text{size}} \, I_0 \| \vec{g} \|_{\ell^{r_2}} \right)^{\tau} \cdot \left(\widetilde{\text{size}} \, I_0 |v|^{\tau} \right) \cdot |I_0|.
$$

If $\|\cdot\|_{L}^{\tau}$ $\mathcal{L}^{R'_{n+1}}$ is subadditive (a sufficient condition is that $\tau < r^{j_0}$), this generalizes to n -linear Calderón-Zygmund operators, yielding eventually the sparse domination

$$
(71) \quad \|\left\|T(\vec{f}_1,\ldots,\vec{f}_n)\right\|_{L^{R_{n+1}'}} \cdot v\|_{\tau}^{\tau} \lesssim \sum_{Q\in\mathcal{S}}\prod_{j=1}^n\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\|\vec{f}_j(x,\cdot)\|_{\tilde{X}_j}^{(1+\delta_j)} \cdot \tilde{\chi}_Q^Mdx\Big)^{\frac{\tau}{1+\delta_j}}\Big(\frac{1}{|Q|}\int_{\mathbb{R}}\big|v(x)\big|^{\tau}\cdot \tilde{\chi}_Q^Mdx\Big) \cdot |Q|,
$$

where $\delta_j \in \{0, \epsilon\}$, with at most m of the $\delta_j \neq 0$ (in this respect, the situation is similar to the Banach case: the $L^{1+\epsilon}$ averages cannot correspond to multiple vector-valued spaces involving L^{∞}).

In the usual manner, the sparse domination result is to be read as: there exists a sparse family S of dyadic intervals, which depends on the functions $\bar{f}_1, \ldots, \bar{f}_n$ and v, so that [\(71\)](#page-43-0) holds.

Remark:. A careful inspection of the proof of Proposition [38](#page-55-0) reveals that it is essential to have at least one restricted-type function in the estimation of the multilinear form. Also, in order to sum up the averages, we need to lose a bit of information by performing a stopping time in $\mathbf{1}_F$ with respect to $L^{r_1-\epsilon}$.

For $q > r^{j_0}$, we have similarly, the sparse domination

$$
\left\| \|T(\vec{f}_1,\ldots,\vec{f}_n)\|_{L^{R_{n+1}'}} \cdot v\right\|_{q}^q \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \left\| \vec{f}_j(x,\cdot) \right\|_{\tilde{X}_j}^{(1+\delta_j)} \cdot \tilde{\chi}_Q^M dx \Big)^{\frac{q}{1+\delta_j}} \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \left| v(x) \right|^{q+\epsilon_q} \cdot \tilde{\chi}_Q^M dx \Big)^{\frac{q}{q+\epsilon_q}} \cdot |Q|.
$$

Lastly, we present a proof of Corollary [6,](#page-7-1) the Fefferman-Stein inequality for T_0 , which follows immediately from the sparse domination above. Let $0 < p < \infty$, and $w \in A_{\infty}$. The A_{∞} assumption appears twice in the argument: first for invoking a *reverse Hölder* property, and second for deducing that $E_Q \subseteq Q$, $|E_Q| \ge \eta |Q| \Rightarrow w(E_Q) \ge \tilde{\eta} w(Q)$.

Let $(R_1,\ldots,R_n,R_{n+1}')$ be m-tuples so that $1 < r_j^l \leq \infty$ for all $1 \leq l \leq m, 1 \leq j \leq n$, 1 $\frac{1}{2}$ < $(r_{n+1}^l)'$ < ∞ . Then if $p < r^{j_0}$, we have the sparse domination, which depends on the functions and the Lebesgue exponents:

$$
\int_{\mathbb{R}} \|T(\vec{f}_1, \ldots, \vec{f}_n)\|_{L^{R'_{n+1}}}^p w(x) dx \lesssim \sum_{Q \in \mathcal{S}} \prod_{j=1}^n \Big(\frac{1}{|Q|} \int_Q \|\vec{f}_j(x, \cdot)\|_{\tilde{X}_j}^{(1+\delta_j)} dx\Big)^{\frac{p}{1+\delta_j}} \Big(\frac{1}{|Q|} \int_Q w(x) dx\Big) \cdot |Q|.
$$

The sparseness property of the intervals implies the existence of mutually disjoints subsets $E_Q \subseteq Q$ with $|E_Q| \geq \eta |Q|$ and hence $w(E_Q) \geq \tilde{\eta} w(Q)$, which yields

$$
\int_{\mathbb{R}} \|T(\vec{f}_1, \ldots, \vec{f}_n)\|_{L^{R'_{n+1}}}^p w(x) dx \lesssim \sum_{Q \in \mathcal{S}} \inf_{x \in E_Q} \vec{\mathcal{M}}_{1+\delta_1, \ldots, 1+\delta_n} (\|\vec{f}_1(y, \cdot)\|_{L^{R_1}}, \ldots, \|\vec{f}_n(y, \cdot)\|_{L^{R_n}}))^p(y) \cdot w(E_Q)
$$

$$
\lesssim \int_{\mathbb{R}} |\vec{\mathcal{M}}_{1+\delta_1, \ldots, 1+\delta_n} (\|\vec{f}_1(x, \cdot)\|_{L^{R_1}}, \ldots, \|\vec{f}_n(x, \cdot)\|_{L^{R_n}}))(x)|^p w(x) dx.
$$

If $p > r^{j_0}$, the L^1 average of w is replaced by an $L^{1+\epsilon_p}$ average, where ϵ_p can be as small as we wish. Since $w \in A_{\infty}$, it satisfies a reverse Hölder inequality: there exists $\epsilon > 0$ so that

$$
(\oint_Q w^{1+\epsilon})^{\frac{1}{1+\epsilon}} \lesssim \int_Q w, \quad \text{for all intervals } Q.
$$

Hence we obtain again the same estimate as above.

The Fefferman-Stein inequalities for operators T_k of Theorem [1](#page-4-0) or for Carleson and variational Carleson operators can be proved similarly.

7. Another study case: Carleson and variational Carleson operators

7.1. The Carleson operator. Before studying the variational Carleson operator $\mathcal{C}^{var,r}$, we briefly describe the procedure for obtaining vector-valued or sparse estimates for the more classical Carleson operator, which is defined by

(72)
$$
\mathcal{C}f(x) \coloneqq \sup_{N} \left| \int_{\xi < N} \hat{f}(\xi) e^{2\pi i x \xi} d\xi \right|.
$$

Its boundedness on L^p , together with a transference principle, implies a.e. convergence of Fourier series in $L^p(\mathbb{T})$.

The operator C can be linearized by introducing the function $N(x)$ which attains the sup in [\(72\)](#page-44-2), of which nothing is known. Furthermore, the condition $\xi \langle N(x) \rangle$ is replaced by

there exists a dyadic interval ω so that $\xi \in \omega_{\text{left}}$ and $N(x) \in \omega_{\text{right}}$.

As a consequence, the study of $\mathcal C$ is replaced by that of its model operator

$$
\mathcal{C}_{\mathbb{P}}(x) \coloneqq \sum_{P \in \mathbb{P}} \langle f, \phi_P \rangle \phi_P(x) \mathbf{1}_{\{x: N(x) \in \omega_{P_2}\}} \coloneqq \sum_{P \in \mathbb{P}} \langle f, \phi_P \rangle \tilde{\phi}_P(x),
$$

where $\mathbb P$ is a collection of bitiles $P = (I_P \times \omega_{P_1}, I_P \times \omega_{P_2})$ (here ω_{P_1} and ω_{P_2} are the left half and right half of the dyadic interval ω_P).

We need to introduce a new type of size, which captures the behavior of the functions $\tilde{\phi}_P(x)$. Here we follow the presentation in [\[MS13\]](#page-59-6).

Definition 13. If P and P' are distinct bitiles, we say that $P \le P'$ if $I_P \subseteq I_{P'}$ and $\omega_{P'} \subseteq \omega_P$.

Also, we denote by \bar{P} the collection of all possible dyadic bitiles in the plane. If the collection $\mathbb{P}(I_0)$ is localized in space onto a certain dyadic interval I_0 , then $\mathbb{P}(I_0)$ denotes the collection of all possible dyadic bitiles P in the plane with $I_P \subseteq 3I_0$.

Definition 14. If $\mathbb P$ is a finite collection of bitiles, then

$$
size_{\mathbb{P}}(\langle g, \tilde{\phi}_P \rangle) \coloneqq \sup_{P \in \mathbb{P}} \sup_{\substack{P' \in \mathbb{P} \\ P' \ge P}} \frac{1}{|I_P'|} \int_{\mathbb{R}} |g(x)| \tilde{\chi}_{I_{P'}}^M(x) \cdot \mathbf{1}_{\{x: N(x) \in \omega_{P'}\}} dx.
$$

Here we use the classical proof of the boundedness of $\mathcal C$ as a black box, but it will be enough to consider a simpler size , which is larger than the one we introduced above:

$$
\mathrm{size}_{\,\mathbb{P}}(\langle g,\widetilde{\phi}_{P}\rangle)\lesssim\widetilde{\mathrm{size}\,}^{\,\ast}_{\,\mathbb{P}}(g)\coloneqq\sup_{P\in\mathbb{P}}\sup_{\substack{P'\in\mathbb{P}\\P'\geq P}}\frac{1}{|I'_{P}|}\int_{\mathbb{R}}|g(x)|\cdot\widetilde{\chi}_{I_{P'}}^{M}(x)dx.
$$

The proof of [\[MS13\]](#page-59-6) relies on a quantity dual to the size, called *energy*. We can avoid to overtly use the 'energy', but we refer the interested reader to Chapter 7 of [\[MS13\]](#page-59-6). Instead, we use directly the estimate

Proposition 26 (Proposition 7.7 from [\[MS13\]](#page-59-6)). If \mathbb{P} is a finite collection of bitiles, and f and g are measurable functions, then

$$
\|\int_{\mathbb{R}}\mathcal{C}_{\mathbb{P}}(f)(x)g(x)dx\| \lesssim (\widetilde{\text{size}\,}_{\mathbb{P}}f)^{\theta_1} \cdot (\widetilde{\text{size}\,}_{\mathbb{P}}^*(g))^{\theta_2} \cdot \|f\|_2^{1-\theta_1} \cdot \|g\|_1^{1-\theta_2}
$$

for any $0 \le \theta_1 < 1, 0 < \theta_2 \le \frac{1}{2}$ $rac{1}{2}$ with $\theta_1 + 2\theta_2 = 1$.

In order to obtain vector-valued or sparse estimates for $C_{\mathbb{P}}$, we need to work with the localized bilinear form. Here we use the fact that the energy corresponding to g is an L^1 quantity, so for g we don't need to use restricted-type functions.

Lemma 27. If \mathbb{P} is a finite collection of bitiles, I_0 is a fixed dyadic interval, f and g are measurable functions so that $|f(x)| \leq \mathbf{1}_F(x)$, then we have

$$
|\Lambda_{\mathcal{C};\mathbb{P}(I_0)}(f,g)| \lesssim \left(\widetilde{\text{size}\,}_{I_0} \mathbf{1}_F\right)^{\frac{1+\theta_1}{2}} \cdot \left(\widetilde{\text{size}\,}_{I_0}^* g\right)^1 \cdot |I_0|,
$$

for any $0 \le \theta_1 < 1$.

Using the techniques presented in the previous sections, we get the following sparse domination for $C_{\mathbb{P}}$:

Proposition 28. If \mathbb{P} is a finite collection of bitiles, and f and g are locally integrable functions, then for any $\epsilon > 0$ there exists a sparse collection S of dyadic intervals so that

$$
|\Lambda_{\mathcal{C}_{\mathbb{P}}}(f,g)| \lesssim \sum_{Q \in \mathcal{S}} \Big(\frac{1}{|Q|} \int_{\mathbb{R}} |f(x)|^{1+\epsilon} \cdot \tilde{\chi}_Q^M(x) dx\Big)^{\frac{1}{1+\epsilon}} \cdot \Big(\frac{1}{|Q|} \int_{\mathbb{R}} |g(x)| \cdot \tilde{\chi}_Q^M(x) dx\Big) \cdot |Q|.
$$

By applying Proposition 6.4. of [\[BFP16\]](#page-57-2), we recover the known weighted estimates for the Carleson operator: for any $\epsilon > 0$ and any $1 < p < \infty$,

 $C: L^p(w) \to L^p(w)$ for all $w \in A_{p/1+\epsilon}$,

with an operatorial norm

$$
\|\mathcal{C}\|_{L^p(w)\to L^p(w)}\lesssim [w]_{A_{\frac{p}{1+\epsilon}}}^{\max\left(\frac{1}{p-1-\epsilon},1\right)}.
$$

We recall that weighted estimates for the Carleson operator were proved in [\[DPL14\]](#page-58-25). Sparse vector-valued estimates were also proved in [\[Bel18\]](#page-57-3).

The multiple vector-valued and sparse vector-valued estimates that we can get for $\mathcal C$ are the following:

Theorem 29. If $R = (r^1, \ldots, r^m)$ is an m-tuple with $1 < r^j < \infty$, then we have $C: L^p(\mathbb{R};L^R(\mathcal{W},\mu)) \to L^p(\mathbb{R};L^R(\mathcal{W},\mu))$

for all $1 < p < \infty$. Moreover, for any $q > 0$, $\epsilon, \epsilon_q > 0$, any \vec{f} multiple vector-valued functions with $|| f(x, \cdot) ||_{L^R(w, \mu)}$ locally integrable and any locally q-integrable function v, there exists a sparse collection S so that

$$
\left\| \|\mathcal{C}_{\mathbb{P}}(\vec{f})\|_{L^R(W,\mu)} \cdot v \right\|_q^q \lesssim \sum_{Q \in \mathcal{S}} \left(\frac{1}{|Q|} \int_{\mathbb{R}} \|f(x,\cdot)\|_{L^R(W,\mu)}^{1+\epsilon} \cdot \tilde{\chi}_Q^M(x) dx \right)^{\frac{q}{1+\epsilon}} \cdot \left(\frac{1}{|Q|} \int_{\mathbb{R}} |v(x)|^{q+\epsilon_q} \cdot \tilde{\chi}_Q^M(x) dx \right)^{\frac{q}{q+\epsilon_q}} \cdot |Q|.
$$

If $q \leq 1$, we can take $\epsilon_q = 0$.

Remark:. The proof of the vector-valued or sparse estimates follows the same ideas from Sections [3](#page-13-0) and [5,](#page-24-0) and we leave the details to the interested reader.

For the operator of Theorem [1,](#page-4-0) conditions [\(8\)](#page-5-3) point to an open range of Lebesgue exponents. Instead, for Carleson and variational Carleson operators, there exists some sort of endpoint estimate, which remains noticeable also in the sparse domination. Since the adjoint operators C^* and $(C^{var,r})^*$ map L^1 into $L^{1,\infty}$, we should be able to obtain, in the sparse domination of the bilinear form (hence, in the case $q = 1$), an $L¹$ average!

These optimal results, corresponding to $q = 1$ and $\epsilon_q = 0$, are far more involved, but they will be described in detail in the following section, where the variational Carleson operator is examined.

Also, we have the following upper-bound for the Carleson operator:

Corollary 30. For any $0 < p < \infty$, $\epsilon > 0$, and any m-tuple $R = (r^1, \ldots, r^m)$ with $1 < r^j < \infty$, we have

$$
\left\| \left\| \mathcal{C}f(x, \cdot) \right\|_{L^R(\mathcal{W}, \mu)} \right\|_p < \left\| \mathcal{M}_{1+\epsilon} \left(\left\| f(x, \cdot) \right\|_{L^R(\mathcal{W}, \mu)} \right) \right\|_p.
$$

Under the assumption that $w \in A_{\infty}$, we have, for any $0 < p < \infty$

$$
\left\| \|\mathcal{C}_{\mathbb{P}}(\vec{f})\|_{L^R(\mathcal{W},\mu)} \right\|_{L^p(w)} \lesssim \left\| \mathcal{M}_{1+\epsilon} \right\|(\vec{f})\|_{L^R(\mathcal{W},\mu)} \right\|_{L^p(w)}.
$$

The implicit constant in the last inequality might depend on w or on $[w]_{A_{\infty}}$.

7.2. Variational Carleson operator.

Alternatively, one might be interested in finding the rate of convergence of the Fourier series in $L^p(\mathbb{T})$. In that case, the necessary tool is the variational Carleson operator, defined by means of the r-variation norm as

(73)
$$
\mathcal{C}^{var,r}(f)(x) \coloneqq \sup_{K} \sup_{n_0 < ... < n_k} \left(\sum_{\ell=1}^K | \int_{a_{n_{\ell-1}}}^{a_{n_\ell}} \hat{f}(\xi) e^{2\pi i x \xi} d\xi |^r \right)^{\frac{1}{r}}.
$$

We recall the following result from [\[OST](#page-59-2)⁺12] (both conditions $r > 2$ and $p > r'$ are necessary):

Theorem 31 (Oberlin, Seeger, Tao, Thiele, Wright). Suppose that $r > 2$ and $r' < p < \infty$. Then $\mathcal{C}^{var,r}: L^p \rightarrow L^p.$

Our intention here is to present a proof of Theorem [31](#page-46-0) which is based on the same localization principle that was portrayed in Sections [3,](#page-13-0) [4](#page-20-0) and [5.](#page-24-0) Not only will this allow us to obtain a simplified proof (we avoid in this way BMO estimates of $\Sigma_{T\epsilon T} \mathbf{1}_T$), but it will immediately imply sparse estimates and, after applying the helicoidal method, also multiple vector-valued and sparse multiple vector-valued estimates.

More exactly, we will show that the variational Carleson operator has a *local* character as well, and upon obtaining the local inequality (corresponding to the "level 0" estimate in the helicoidal method), we conclude the multi-vectorial sparse estimates described in Theorem [7.](#page-8-0)

7.3. Study of the model operator. By standard techniques, $\mathcal{C}^{var,r}$ can also be linearized: first we fix $K \in \mathbb{Z}^+$, and for every $x \in \mathbb{R}$, there exist measurable real-valued functions $\xi_0(x) < \xi_1(x) < \ldots < \xi_K(x)$ and measurable complex valued functions $a_1(x), \ldots, a_K(x)$ satisfying

$$
\left(\sum_{k=1}^{K} |a_k(x)|^{r'}\right)^{\frac{1}{r'}} = 1
$$

and so that

$$
\mathcal{C}^{var,r}(f)(x) = \sum_{k=1}^K a_k(x) \cdot \int_{\mathbb{R}} \mathbf{1}_{[\xi_{k-1}(x), \xi_k(x)]}(x) \hat{f}(\xi) e^{2\pi i x \xi} d\xi.
$$

Further, assuming that the functions $\xi_k(\cdot)$ take only a finite number of values, the operator can be approximated by a model operator:

(74)
$$
\mathcal{C}_{\mathbb{P}}^{var,r}(f)(x) \coloneqq \sum_{P \in \mathbb{P}} \langle f, \phi_P \rangle \phi_P(x) a_P(x).
$$

The multi-tiles in $\mathbb P$ are of the form $P = I_P \times \omega_P$, where each ω_P is a union of three intervals $\omega_l, \omega_u, \omega_h$. The wave packet ϕ_P contains the information in $I_P \times \omega_u$, while in ω_l (and ω_h) is captured the lowest (or highest) possible frequency information: if $x \in I_P$, then for some $1 \le k \le K$, $\xi_{k-1}(x) \in \omega_l$ (and $\xi_k(x) \in \omega_h$). In that case, $a_P(x) = a_k(x)$, and $a_P(x) = 0$ if no such a k exists.

In addition, since the frequency information represents a Whitney decomposition of the interval $[a_{k-1}(x), a_{k}(x)]$, we can assume that there exist constants $1 \le C_3 < C_2 < C_1$ so that, for every $P \in \mathbb{P}$,

$$
\operatorname{supp}(\hat{\phi}_P) \subset C_3 \omega_u, \quad C_2 \omega_u \cap C_2 \omega_l = \varnothing, \quad C_2 \omega_u \cap C_2 \omega_h = \varnothing, \quad C_2 \omega_l \subset C_1 \omega_u, \quad C_2 \omega_u \subset C_1 \omega_l.
$$

On account of the frequency data being contained in three intervals, we denote by ω_m the convex hull of $C_2\omega_u \cup C_2\omega_l$:

$$
\omega_m \coloneqq \mathrm{conv}(C_2 \omega_u \cup C_2 \omega_l).
$$

Now we are ready to define the trees, which, as usual, play a very important role in the analysis. As in [\[OST](#page-59-2)⁺12], we assume there exists Ξ^{top} , a finite set of admissible tree top frequencies.

Definition 15. A tree $T = (T, I_T, \xi_T)$ with top datum (I_T, ξ_T) , where I_T is a dyadic interval and $\xi_T \in \Xi^{top}$, is a subcollection of multi-tiles $P \in \mathbb{P}$ with the property that

(75)
$$
I_P \subseteq I_T \quad and \quad \omega_T \coloneqq \left[\xi_T - \frac{C_2 - 1}{4|I_T|}, \xi_T + \frac{C_2 - 1}{4|I_T|} \right) \subseteq \omega_m.
$$

A tree (T, I_T, ξ_T) is called l-overlapping if $\xi_T \in C_2 \omega_l$ for every $P \in T$, and l-lacunary if $\xi_T \notin C_2 \omega_l$ for all $P \in T$.

In order to obtain the vector-valued estimate in Theorem [7,](#page-8-0) we need to prove, for $p_0 > r'$

(76)
$$
|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)| \lesssim |\!|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}|\!|\!| |f \cdot \tilde{\chi}_{I_0}|\!|_{p_0} \cdot |\!| g \cdot \tilde{\chi}_{I_0}|\!|_{p_0'},
$$

where $\|\Lambda_{\mathcal{C}^{var,r}; \mathbb{P}(I_0)}\|$ is the operatorial norm given by

(77)
$$
\|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}\| \coloneqq (\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_F)^{\frac{1}{r'}-\frac{1}{p_0}-\epsilon} \cdot (\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_G)^{\frac{1}{p_0}-\epsilon}.
$$

As usual, this will be showed through restricted type-interpolation. If E_1, E_2 are sets of finite measure, it is enough to find $E_2' \subseteq E_2$ a major subset so that, for any restricted-type functions f and g satisfying $|f(x)| \leq \mathbf{1}_{E_1}(x), |g(x)| \leq \mathbf{1}_{E'_2}(x)$, we have

$$
|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)| \lesssim \left\|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}\right\| \cdot |E_1|^{\frac{1}{p}}|E_2|^{\frac{1}{p'}},
$$

for all $p > r'$ in a neighborhood of p_0 .

Interpolation theory then implies that

$$
|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)| \lesssim \left\|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}\right\| \|f\|_{p_0} \cdot \|g\|_{p_0'},
$$

but the estimate [\(76\)](#page-47-0) can be easily deduced by using the decay of the sizes (so here we might loose an ϵ in the exponents of the two sizes).

The proof of Theorem [31](#page-46-0) from $[OST+12]$ is based on a *tree estimate* and two decomposition lemmas: one for the *energy* and one for the *density*. In order to obtain the full range from Theorem [31,](#page-46-0) the authors use a BMO estimates for the tops of the trees (that is, $\|\sum_{T\in\mathbf{T}}\mathbf{1}_{I_T}\|_{BMO}$. This is necessary (via intepolation and the classical $\|\sum_{T\in\mathbf{T}}\mathbf{1}_{I_T}\|_1$ estimate) for defining the exceptional set, which is somehow complicated. By using localizations and two additional stopping times, we obtain a somewhat simpler demonstration. The "energy" and "density" of $[OST+12]$ will be replaced by sizes, an approach which is more similar to the exposition in [\[MS13\]](#page-59-6).

Definition 16.

$$
size_{\mathbb{P}}(f) \coloneqq \sup_{\substack{T \subset \mathbb{P} \\ l\text{-}overlapping\ tree}}\big(\frac{1}{|I_T|}\sum_{P \in T}|\langle f, \phi_P\rangle|^2\big)^{\frac{1}{2}}
$$

For g, the size will be similar to the one appearing in the case of the Carleson operator:

(78)
$$
size_{\mathbb{P}}(g) := \sup_{P \in \mathbb{P}} \sup_{\substack{P' \in \mathbb{P} \\ P' \ge P}} \left(\frac{1}{|I'_P|} \int_{\mathbb{R}} |g(x)|^{r'} \tilde{\chi}_{I_{P'}}^M(x) \cdot \sum_{k=1}^K |a_k(x)|^{r'} \cdot \mathbf{1}_{\omega_{P'}}(\xi_{k-1}(x)) dx \right)^{\frac{1}{r'}}.
$$

Remark:. In the definition of size $p(g)$, we consider the supremum over all admissible tiles P' so that $I_P \subseteq I_{P'}$ and $\omega_{P'} \subset \omega_P$, where

$$
\omega_{P'} \coloneqq \left[\xi_{P'} - \frac{C_2 - 1}{4|I_{P'}|}, \xi_{P'} + \frac{C_2 - 1}{4|I_{P'}|} \right)
$$

for some $\xi_{P'} \in \Xi^{top}$.

Proposition 32 (Similar to Prop. 5.1 of [\[OST](#page-59-2)⁺12]). Let $T \subset \mathbb{P}$ be a tree. Then

(79)
$$
\left| \int_{\mathbb{R}} \sum_{P \in T} \langle f, \phi_P \rangle \phi_P(x) a_P(x) g(x) dx \right| \lesssim size_T(f) \cdot size_T(g) \cdot |I_T|
$$

and also,

(80)
$$
\|\sum_{P\in T} \langle f, \phi_P \rangle \phi_P a_P g\|_{L^{r'}} \lesssim size_T(f) \cdot size_T(g) \cdot |I_T|^{\frac{1}{r'}}.
$$

Furthermore, for $\ell \geq 0$, we have

$$
\|\sum_{P\in T} \langle f, \phi_P \rangle \phi_P a_P g \|_{L^1(\mathbb{R} \times 2^\ell I_T)} \lesssim 2^{-\ell(N-10)} size_T(f) \cdot size_T(g) \cdot |I_T|
$$

and

$$
\|\sum_{P\in T}\langle f,\phi_P\rangle \phi_P a_P g\|_{L^{r'}(\mathbb{R}\times 2^{\ell}I_T)} \lesssim 2^{-\ell(N-10)} size_T(f) \cdot size_T(g) \cdot |I_T|^{\frac{1}{r'}}.
$$

Proof. The proof follows the same reasoning as that of Proposition 5.1 from $[OST^+12]$, which corresponds to the special case when $g(x)$ is a characteristic function. We have to consider l-lacunary trees and l-overlapping trees and in the second case, make use of Lépingle's inequality.

The quantity size $p(g)$ appears naturally in the *tree estimate*. If T is a tree with top I_T , we perform a decomposition of $\mathbb R$ into a collection $\mathcal J$ made of maximal dyadic intervals J with the property that there is no $P \in T$ so that $I_P \subseteq 3J$.

The tree estimate from [\(80\)](#page-48-0) follows by estimating first $\|\sum_{P\in\mathbb{P}}(f,\phi_P)\phi_Papg\|_{L^{r'}(J)}$ for every $J \in \mathcal{J}$. There are two types of intervals $J \in \mathcal{J}$:

1. relatively large intervals J that are supported away from I_P , for $P \in T$. In this case, size $p(g)$ becomes

$$
\sup_{\substack{P\in T \\ |I_P|\leq C''|J|}}\Big(\frac{1}{|I_P|}\int_{\mathbb{R}}|g(x)|^{r'}\tilde{\chi}_{I_P}^M(x)\cdot\sum_{k=1}^K|a_k(x)|^{r'}\cdot{\bf 1}_{\omega_P}(\xi_{k-1}(x))dx\Big)^{\frac{1}{r'}}
$$

2. small intervals J, that are smaller than certain I_P , for $P \in T$. However, in this case, by the maximality of J, there exists $P(J) \in T$ so that $I_{P(J)} \subseteq 3J$, where J is the dyadic parent of J. Hence there exists J' of length comparable to J and I_P so that $I_{P(J)} \subseteq J'$. The size $_P(g)$ that emerges in this situation is

$$
\left(\frac{1}{|J'|}\int_{\mathbb{R}}|g(x)|^{r'}\tilde{\chi}_{J'}^{M}(x)\cdot\sum_{k=1}^{K}|a_{k}(x)|^{r'}\cdot\mathbf{1}_{\omega_{J'}}(\xi_{k-1}(x))dx\right)^{\frac{1}{r'}}
$$

In either case, we can see how size $P(g)$ can be replaced by a similar quantity, more local in nature, defined by

(81)
$$
\sup_{P \in \mathbb{P}} \sup_{\substack{P' \in \mathbb{P} \\ P' \ge P, I_{P'} \subseteq 9I_P}} \left(\frac{1}{|I'_P|} \int_{\mathbb{R}} |g(x)|^{r'} \tilde{\chi}_{I_{P'}}^M(x) \cdot \sum_{k=1}^K |a_k(x)|^{r'} \cdot \mathbf{1}_{\omega_{P'}}(\xi_{k-1}(x)) dx \right)^{\frac{1}{r'}}.
$$

This will be useful later on in Section [7.4,](#page-49-0) for the local estimates. \Box

Remark:. From now on, we will use the definition in [\(81\)](#page-49-1) for $size_{\mathbb{P}}(q)$. We can also see that this quantity is bounded above by an $L^{r'}$ size as defined in [\(24\)](#page-12-1):

$$
size_{\mathbb{P}}(g) \leq \widetilde{size}_{\mathbb{P}}^{r'}(g).
$$

7.4. Localization results and Proof of Theorem [7.](#page-8-0) We adapt the previous notions to a local setting: let I_0 be a fixed dyadic interval. Then $\mathbb{P}(I_0)$ denotes a certain subcollection of multi-tiles:

$$
\mathbb{P}(I_0)\coloneqq\{P\in\mathbb{P}:I_P\subseteq I_0\}.
$$

The strategy is to obtain precise estimates for $\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}$ and afterwards use them to derive the vector-valued and sparse estimates.

Proposition 33. Let I₀ be a fixed dyadic interval and f a function so that $|f(x)| \leq 1_F(x)$ for a.e. x and assume that

$$
1 + \frac{\text{dist (supp } f, I_0)}{|I_0|} \sim 2^{\kappa}, \quad \text{for some } \kappa \ge 0.
$$

Let $\mathbb P$ be a collection of multi-tiles so that $I_P \subseteq I_0$ for all $P \in \mathbb P$ and so that $size_{\mathbb P}(f) \leq \mathcal{E}$. Then there exists a decomposition $\mathbb{P} = \mathbb{P}' \cup \mathbb{P}''$ so that $size_{\mathbb{P}'}(f) \leq \mathcal{E}/2$ and \mathbb{P}'' can be written as a union of trees $\mathbb{P}'' = \bigcup$ $\widetilde{T\epsilon}\mathbf{T}$ T with the property that

(82)
$$
\sum_{T \in \mathbf{T}} |I_T| \lesssim 2^{-M\kappa} \mathcal{E}^{-2} |F|.
$$

Remark:. The proposition above corresponds to a classical "energy decomposition" algorithm, that appeared already in Lemma [18.](#page-26-0)

Similarly, for the "density", we have a decomposition algorithm:

Proposition 34. Let I_0 be a fixed dyadic interval, g a function in $L^{r'}$ and assume that

$$
1 + \frac{\text{dist (supp } g, I_0)}{|I_0|} \sim 2^{\kappa}, \quad \text{for some } \kappa \ge 0.
$$

Let P a collection of multi-tiles so that $size_{\mathbb{P}}(g) \leq \lambda$. Then there exists a decomposition $\mathbb{P} = \mathbb{P}' \cup \mathbb{P}''$ so that $size_{\mathbb{P}'}(g) \leq \lambda/2$ and \mathbb{P}'' can be written as a union of trees $\mathbb{P}'' = \bigcup$ \widetilde{T} ∈T T

with the property that

(83)
$$
\sum_{T \in \mathbb{T}} |I_T| \lesssim 2^{-M\kappa} \lambda^{-r'} \|g\|_{r'}^{r'}.
$$

Using the propositions above, we are able to prove a very precise local estimate, involving an L^1 size of g.

Proposition 35. Let I_0 be a fixed dyadic interval and \mathbb{P} a collection of multi-tiles; F is a set of finite measure, f a function so that $|f| \leq \mathbf{1}_F$, and g is a locally integrable function. Then

(84)
$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f,g)\right| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\epsilon} \cdot \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}g\right) \cdot |I_0|.
$$

Proof. Obtaining an L^1 size of g is important for the sparse estimate of Theorem [7](#page-8-0) (scalar, as well as multiple vector-valued), because the weighted estimates that follow are not optimal if the L^1 size is replaced by an $L^{1+\epsilon}$ average. For vector-valued estimates however, an $L^{1+\epsilon}$ size of a characteristic function would suffice.

Still, size $p(g)$ is inherently an $L^{r'}$ quantity: even though in the *tree estimate* we can replace it by an L^1 size, for the decomposition result in Proposition [34](#page-50-1) we need to regard it as an $L^{r'}$ quantity in order to estimate \sum \bar{T} ∈T $|I_T|.$

As a consequence, we write $g \in L^1$ as

 $g = g_1 \cdot g_2$, where $g_1 \in L^r$ and $g_2 \in L^{r'}$.

This can easily be achieved by setting $g_1(x) = |g(x)|^{\frac{1}{r}}$ and $g_2(x) = g(x)/g_2(x)$ if $g(x) \neq 0$, $q_2(x) = 0$ if $q(x) = 0$.

Now we show how to attain the estimate from (84) . First, we decompose f and g as

$$
f = \sum_{\kappa_1 \ge 0} f \cdot \mathbf{1}_{\{\text{ dist } (x, I_0) \sim (2^{\kappa_1} - 1) | I_0 | \}} := \sum_{\kappa_1 \ge 0} f_{\kappa_1}
$$

and for $1 \leq j \leq 2$

$$
g_j = \sum_{\kappa_2 \geq 0} g_j \cdot \mathbf{1}_{\{\text{ dist } (x, I_0) \sim (2^{\kappa_2} - 1) |I_0|\}} \coloneqq \sum_{\kappa_2 \geq 0} g_{j, \kappa_2}
$$

.

Similarly, $F_{\kappa_1} \coloneqq F \cap \{ \text{ dist } (x, I_0) \setminus (2^{\kappa_1} - 1) |I_0| \}.$ The functions g_1 and g_2 will be localized onto the same set, which corresponds to localizing the function $g = g_1 \cdot g_2$.

Then, for κ_1 and κ_2 fixed, we perform the decomposition of the collection $\mathbb{P}(I_0)$. Ap-plying Proposition [33](#page-49-2) iteratively to f_{κ_1} , we obtain $\mathbb{P}(I_0) = \bigcup \bigcup T$, where the size of \sum_{n_1} T∈T_{n₁, κ_1 </sup>}

each tree $T \in \mathbf{T}_{n_1,\kappa_1} \sim 2^{-n_1}$ and moreover

(85)
$$
\sum_{T \in \mathbf{T}_{n_1, \kappa_1}} |I_T| \lesssim 2^{-M\kappa_1} 2^{2n_1} |F_{\kappa_1}|.
$$

Proposition [34](#page-50-1) applied to g_2 yields an analogous decomposition: $\mathbb{P}(I_0) = \bigcup_{n_2}$ ⋃ $T \epsilon \mathbf{\overline{T}_{\mathnormal{n}\mathnormal{2},\mathnormal{\kappa}\mathnormal{2}}}$ $T,$ where the size of each tree $T \in \mathbf{T}_{n_2,\kappa_2} \sim 2^{-n_2}$ and

$$
\sum_{T\in{\bf T}_{n_2,\kappa_2}}|I_T|\lesssim 2^{-M\kappa_2}2^{r'n_2}\|g_{2,\kappa_2}\|_{r'}^{r'}.
$$

First, we estimate the bilinear form associated to $\mathcal{C}^{var,r}_{\mathbb{P}(I_0)}$:

$$
\begin{split}\n&\left|\int_{\mathbb{R}} \sum_{P \in \mathbb{P}(I_0)} \langle f, \phi_P \rangle \phi_P \, a_P \, g \, dx \right| = \Big| \int_{\mathbb{R}} \sum_{P \in \mathbb{P}(I_0)} \langle f, \phi_P \rangle \phi_P \, a_P \, g_1 \cdot g_2 \, dx \Big| \\
&\lesssim \sum_{\kappa_1, \kappa_2} \sum_{n_1, n_2} \sum_{T \in \mathbf{T}_{n_1, \kappa_1} \cap \mathbf{T}_{n_2, \kappa_2}} \Big| \int_{\mathbb{R}} \Big(\sum_{P \in T} \langle f_{\kappa_1}, \phi_P \rangle \phi_P \, a_P \, g_{1, \kappa_2} \cdot g_{2, \kappa_2} \Big) \cdot \mathbf{1}_{I_T} \, dx \Big| \\
&\quad + \sum_{\ell \geq 0} \sum_{\kappa_1, \kappa_2} \sum_{n_1, n_2} \sum_{T \in \mathbf{T}_{n_1, \kappa_1} \cap \mathbf{T}_{n_2, \kappa_2}} \Big| \int_{\mathbb{R}} \Big(\sum_{P \in T} \langle f_{\kappa_1}, \phi_P \rangle \phi_P \, a_P \, g_{1, \kappa_2} \cdot g_{2, \kappa_2} \Big) \cdot \mathbf{1}_{2^{\ell+1} I_T \times 2^{\ell} I_T} \, dx \Big| := (I) + (II). \n\end{split}
$$

We will only consider the first term; for the second one, the analysis is similar, and it only employs the decay in the tree estimate outside $2^{\ell}I_T$, which was mentioned in Proposition [32.](#page-48-1)

For now, consider κ_1 and κ_2 fixed; we apply Hölder to get

$$
\sum_{T \in \mathbf{T}_{n_1,\kappa_1} \cap \mathbf{T}_{n_2,\kappa_2}} \Big| \int_{\mathbb{R}} \Big(\sum_{P \in T} \langle f_{\kappa_1}, \phi_P \rangle \phi_P \, a_P \, g_{1,\kappa_2} \cdot g_{2,\kappa_2} \Big) \cdot \mathbf{1}_{I_T} \, dx \Big|
$$

\$\lesssim \sum_{T \in \mathbf{T}_{n_1,\kappa_1} \cap \mathbf{T}_{n_2,\kappa_2}} \| g_{1,\kappa_2} \cdot \mathbf{1}_{I_T} \|_r \cdot \Big\| \Big(\sum_{P \in T} \langle f_{\kappa_1}, \phi_P \rangle \phi_P \, a_P \, g_{2,\kappa_2} \Big) \cdot \mathbf{1}_{I_T} \Big\|_{r'}.\end{array}

We want to transform $||g_{1,\kappa_2} \cdot \mathbf{1}_{I_T}||_r$ into some type of average or "size" of g_{1,κ_2} onto I_T . In fact, if $k_2 \neq 0$, this term is equal to 0, but for (II) , we consider dilates of I_T and we will have to face a similar situation.

Hence, we can see that

$$
\frac{1}{|I_T|} \|g_{1,\kappa_2} \cdot \mathbf{1}_{I_T}\|_r^r \le \frac{1}{|I_T|} \|g \cdot \mathbf{1}_{I_T}\|_1 \le \widetilde{\text{size}}_{\mathbb{P}(I_0)}^{-1}(g).
$$

Similarly, for (II) we have

$$
\frac{2^{-\ell M}}{|I_T|}\|g_{1,\kappa_2}\cdot{\bf 1}_{2^{\ell+1}I_T}\|_r^r\leq\frac{2^{-\ell M}}{|I_T|}\|g\cdot{\bf 1}_{2^{\ell+1}I_T}\|_1\leq\frac{1}{|I_T|}\|g\cdot\tilde{\chi}^M_{I_T}\|_1\leq\widetilde{\text{size}}_{\mathbb{P}(I_0)}^1(g).
$$

The above reasoning implies that

$$
||g_{1,\kappa_2} \cdot \mathbf{1}_{I_T}||_r \lesssim (\widetilde{\text{size}}^1_{\mathbb{P}(I_0)} g)^{\frac{1}{r}} \cdot |I_T|^{\frac{1}{r}}.
$$

The tree estimate of Proposition [32,](#page-48-1) and the stopping times in the construction of $\mathbf{T}_{n_1,\kappa_1}$ and $\mathbf{T}_{\mathfrak{n}_2,\kappa_2}$ imply that

$$
\Big\| \Big(\sum_{P \in T} \langle f_{\kappa_1}, \phi_P \rangle \phi_P \, a_P \, g_{2, \kappa_2} \Big) \cdot \mathbf{1}_{I_T} \Big\|_{r'} \lesssim 2^{-n_1} \cdot 2^{-n_2} \cdot |I_T|^{\frac{1}{r'}}.
$$

For the sum of the tree tops $|I_T|$ we have from Propositions [33](#page-49-2) and [34:](#page-50-1)

$$
\sum_{T \in \mathbf{T}_{n_1,\kappa_1} \cap \mathbf{T}_{n_2,\kappa_2}} |I_T| \lesssim \min(2^{-M\kappa_1} 2^{2n_1} |F_{\kappa_1}|, 2^{-M\kappa_2} 2^{r'n_2} \|g_{2,\kappa_2}\|_{r'}^{r'}).
$$

All of the above imply that

$$
\sum_{T \in \mathbf{T}_{n_1,\kappa_1} \cap \mathbf{T}_{n_2,\kappa_2}} \Big| \int_{\mathbb{R}} \Big(\sum_{P \in T} \langle f_{\kappa_1}, \phi_P \rangle \phi_P \, a_P \, g_{1,\kappa_2} \cdot g_{\kappa_2} \Big) \cdot \mathbf{1}_{I_T} dx \Big|
$$
\n
$$
\lesssim \Big(\text{size}^1_{\mathbb{P}(I_0)}(g) \Big)^{\frac{1}{r}} 2^{-n_1} 2^{-n_2} \sum_{T \in \mathbf{T}_{n_1,\kappa_1} \cap \mathbf{T}_{n_2,\kappa_2}} |I_T|
$$
\n
$$
\lesssim \Big(\text{size}^1_{\mathbb{P}(I_0)}(g) \Big)^{\frac{1}{r}} 2^{-n_1} 2^{-n_2} \Big(2^{-M\kappa_1} 2^{2n_1} |F_{\kappa_1}| \Big)^{\theta_1} \cdot \Big(2^{-M\kappa_2} 2^{r'n_2} \| g_{2,\kappa_2} \|_{r'}^{r'} \Big)^{\theta_2},
$$

where $0 \le \theta_1, \theta_2 \le 1$, and $\theta_1 + \theta_2 = 1$.

Now we can sum in κ_1 and κ_2 to get

$$
(86) \qquad (I) \lesssim \left(\text{size}^1_{\mathbb{P}(I_0)}(g)\right)^{\frac{1}{r}} \|1_F \cdot \tilde{\chi}_{I_0}^{\tilde{M}}\|_{1}^{\theta_1} \cdot \|g_2 \cdot \tilde{\chi}_{I_0}^{\tilde{M}}\|_{r'}^{\theta_2 \cdot r'} \sum_{n_1, n_2} 2^{-n_1(1-2\theta_1)} \cdot 2^{-n_2(1-r'\theta_2)}.
$$

Note that $||g_2 \cdot \tilde{\chi}_{I_0}^{\tilde{M}}$ $_{I_0}^{\tilde{M}}\Vert _{r'}^{r'}$ $r'_{r'} = \|g\cdot \tilde{\chi}_{I_0}^{\tilde{\tilde{M}}}$ $\mathbb{Z}_{I_0}^{M}$ ||₁, so, if we can sum in n_1 and n_2 , we would have that

$$
(I) \lesssim (\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_F)^{1-\theta_1} \cdot (\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}^1 g) \cdot |I_0|,
$$

where we used the inequalities

$$
2^{-n_1} \sim \text{size}_T(f) \leq \widetilde{\text{size}}_{\mathbb{P}(I_0)}(f), \qquad 2^{-n_2} \sim \text{size}_T(g) \leq \widetilde{\text{size}}_{\mathbb{P}(I_0)}^{r'} g_2 = \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^1 g\right)^{\frac{1}{r'}}.
$$

The summation is possible only if

$$
1 - 2\theta_1 > 0, \qquad 1 - r'\theta_2 > 0,
$$

or equivalently, if

(87)
$$
\frac{1}{2} > \theta_1 > \frac{1}{r}.
$$

Upon treating the second term (II) in a similar manner, we obtain that

$$
\Big| \int_{\mathbb{R}} \mathcal{C}_{\mathbb{P}(I_0)}^{var,r}(f)(x) g(x) dx \Big| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)} \mathbf{1}_F \right)^{1-\theta_1} \cdot \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)} g \right) \cdot |I_0|.
$$

Choosing $\theta_1 = \frac{1}{r} + \epsilon$, we obtain exactly (84).

Theorem 36. Let I_0 be a fixed dyadic interval, and F, G sets of finite measure. Then for any $p_0 > r'$,

$$
|\Lambda_{\mathcal{C}^{var,r}; \mathbb{P}(I_0)}^{F,G}(f,g)| \lesssim \left(\widetilde{size}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\frac{1}{p_0}-\epsilon}\cdot \left(\widetilde{size}_{\mathbb{P}(I_0)}\mathbf{1}_G\right)^{\frac{1}{p_0}-\epsilon} \|f\cdot \widetilde{\chi}_{I_0}\|_{p_0}\cdot \|g\cdot \widetilde{\chi}_{I_0}\|_{p_0'}.
$$

Proof. We will use the estimates of Proposition [35](#page-50-0) and restricted type interpolation in the form of Proposition 10 of [\[BM17\]](#page-58-0). Let E_1, E_2 be sets of finite measure and we can assume without loss of generality that $|\dot{E}_2| = 1$. We will construct $E'_2 \subseteq E_2$ major subset and show that

$$
|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)| \lesssim \left\|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}\right\| \cdot |E_1|^{\frac{1}{p}},
$$

for $p > r'$ in a neighborhood of p_0 , and all functions f, g with $|f(x)| \leq \mathbf{1}_{E_1}, |g(x)| \leq \mathbf{1}_{E'_2}$ for a.e. x.

 \Box

The exceptional set is defined in a standard way:

$$
\Omega \coloneqq \{x : \mathcal{M}(\mathbf{1}_{E_1 \cap F}) > C | E_1 \cap F| \}
$$

and we set E_2' $y_2' \coloneqq E_2 \setminus \Omega.$

For any $d \geq 0$, we let $\mathbb{P}_d(I_0) \coloneqq \{P \in \mathbb{P}(I_0) : 1 + \frac{\text{dist}(I_P, \Omega^c)}{I_0}\}$ $\frac{(1_P, \Omega)}{|I_P|} \sim 2^d$. Another decomposition will be needed: we consider d fixed, and as in [\[BM16\]](#page-57-0), we will perform a double stopping time which allows us to write

$$
\mathbb{P}_d(I_0) \coloneqq \bigcup_{n_1, n_1} \bigcup_{I \in \mathcal{I}_{n_1} \cap \mathcal{I}_{n_2}} \mathbb{P}_I.
$$

Here \mathcal{I}_{n_1} represents a collection of maximal dyadic intervals contained inside

$$
\{x:\mathcal{M}(\mathbf{1}_{F\cap E_1})(x)>2^{-n_1-1}\}.
$$

More exactly, $I \in \mathcal{I}_{n_1}$ if there exists at least one $P \in \mathbb{P}_{Stock}$ with $I_P \subseteq I$, and I is maximal with the property that

$$
2^{-n_1-1} < \frac{1}{|I|} \int_{\mathbb{R}} \mathbf{1}_{F \cap E_1} \cdot \tilde{\chi}_I^M dx \le 2^{-n_1}.
$$

Then we set

$$
\mathbb{P}_I \coloneqq \{ P \in \mathbb{P}_{Stock} : I_P \subseteq I \}.
$$

This implies that $\widetilde{\text{size}}_{\mathbb{P}_I}(f \cdot \mathbf{1}_F) \leq 2^{-n_1} \leq \widetilde{\text{size}}_{\mathbb{P}(I_0)} \mathbf{1}_{F \cap E_1} \leq 2^d |E_1 \cap F|$, and also \sum I ∈ \mathfrak{I}_{n_1} ∣I∣ ≲

 $2^{n_1} | E_1 \cap F |$.

Similarly for g, we have $\widetilde{\text{size}}_{\mathbb{P}_I}(g \cdot \mathbf{1}_G) \lesssim 2^{-n_2} \lesssim 2^{-Md}$, and \sum $I∈\mathcal{I}_{n_2}$ $|I| \lesssim 2^{n_2} |E_2 \cap G|$. We recall

.

that

$$
\widetilde{\text{size}\,}_{\mathbb{P}_I}(g \cdot \mathbf{1}_G) \lesssim \sup_{P \in \mathbb{P}_I} \sup_{J \supseteq I_P} \frac{1}{|J|} \int_J \mathbf{1}_{E'_2 \cap G} \cdot \widetilde{\chi}_I^{2M} dx \lesssim 2^{-Md}
$$

The decay in 2^{-Md} is a consequence of integrating $\tilde{\chi}_I^M$ over $E'_2 \subset \Omega^c$.

Then we obtain, using Proposition [35](#page-50-0) with F replaced by $E_1 \cap F$ and g by $\mathbf{1}_{E'_2 \cap G}$:

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)\right| \lesssim \sum_{d\geq 0} \sum_{n_1,n_2} \sum_{I\in\mathcal{I}_{n_1\cap\mathcal{I}_{n_2}}} \left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}_I}^{F,G}(f,g)\right|
$$

$$
\lesssim \sum_{d\geq 0} \sum_{n_1,n_2} \sum_{I\in\mathcal{I}_{n_1\cap\mathcal{I}_{n_2}}} \left(\overline{\text{size}\,}_{\mathbb{P}_I} \mathbf{1}_{E_1\cap F}\right)^{\frac{1}{r'}-\epsilon} \cdot \left(\overline{\text{size}\,}_{\mathbb{P}_I} \mathbf{1}_{E_2'\cap G}\right) \cdot |I|.
$$

We note that

$$
\widetilde{\text{size}\,}_{\mathbb{P}_I} \mathbf{1}_{E_1 \cap F} \le \min\left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_F, 2^{-n_1}\right), \quad \widetilde{\text{size}\,}_{\mathbb{P}_I} \mathbf{1}_{E'_2 \cap G} \le \min\left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_G, 2^{-n_2}\right).
$$

Hence, if $0 < \gamma_1 < \frac{1}{\gamma}$ $\frac{1}{r'}$ and $0 < \gamma_2 < 1$, we have

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)\right| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\gamma_1-\epsilon} \cdot \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_G\right)^{1-\gamma_2-\epsilon} \cdot \\ \cdot \sum_{d\geq 0} \sum_{n_1,n_2} 2^{-n_1\gamma_1} \cdot 2^{-n_2\gamma_2} \left(2^{n_1}|E_1 \cap F|\right)^{\theta_1} \left(2^{n_2}|E_2 \cap G|\right)^{\theta_2},
$$

where $0 \le \theta_1, \theta_2 \le 1, \theta_1 + \theta_2 = 1$. On the last line we interpolate between the estimate for ∑ $I∈\mathcal{I}_{n_1}$ |*I*| and the one for \sum $I∈\mathcal{I}_{n_2}$ ∣I∣.

We want to sum in n_1 and n_2 , and this is possible provided $\gamma_1 + \gamma_2 > \theta_1 + \theta_2 = 1$. We can choose $\gamma_1 = \frac{1}{n}$ $\frac{1}{p}$ and $\gamma_2 = \frac{1}{p'}$ $\frac{1}{p'} + \epsilon$, where $p > r'$ is arbitrarily close to p_0 . Summation in d presents no problem due to the fast decay. In the end, all of the above imply that

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^{F,G}(f,g)\right|\lesssim \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\frac{1}{p_0}-\epsilon}\cdot \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}\mathbf{1}_G\right)^{1-\frac{1}{p_0'}-\epsilon}|E_1|^{\frac{1}{p}},
$$

which is precisely what we wanted. (The assumption that $|E_2| = 1$ is only used for simplifying the computations.)

7.5. L^1 sizes for the multiple vector-valued sparse domination.

The local estimate for the variational Carleson $\mathcal{C}^{var,r}$ from Proposition [35,](#page-50-0) which is the equivalent of Lemma [27](#page-45-0) for the Carleson operator, implies, as described in Section [3,](#page-13-0) the following sparse domination result: given $\mathbb P$ a finite collection of multi-tiles, f and g locally integrable functions and $\epsilon > 0$, there exists a sparse family of dyadic intervals S so that

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}}(f,g)\right| \lesssim_{\epsilon} \sum_{Q \in \mathcal{S}} \left(\frac{1}{|Q|} \int_{\mathbb{R}} \left|f(x)\right|^{r'+\epsilon} \cdot \tilde{\chi}_Q^M(x) dx\right)^{\frac{1}{r'+\epsilon}} \cdot \left(\frac{1}{|Q|} \int_{\mathbb{R}} \left|g(x)\right| \cdot \tilde{\chi}_Q^M(x) dx\right) \cdot |Q|.
$$

Using the helicoidal method, we obtain a similar result for multiple vector-valued functions \vec{f}, \vec{g} , but with the L^1 average of \vec{g} replaced by an $L^{1+\epsilon}$ average: given $\epsilon > 0$, \mathbb{P} a finite collection of multi-tiles, \vec{f} and \vec{g} vector-valued functions so that $|| f(x, \cdot) ||_{L^R(w, \mu)}$ and $||g(x, \cdot)||_{L^{R'}(W,\mu)}$ are locally integrable functions, there exists a sparse family of dyadic intervals S so that

$$
|\Lambda_{\mathcal{C}^{var,r}; \mathbb{P}}(\vec{f},\vec{g})|\lesssim_{\epsilon} \sum_{Q\in\mathcal{S}}\big(\frac{1}{|Q|}\int_{\mathbb{R}}\|f(x,\cdot)\|_{L^R(\mathsf{W},\mu)}^{r'+\epsilon}\cdot\tilde{\chi}_Q^M(x)dx\big)^{\frac{1}{r'+\epsilon}}\cdot\big(\frac{1}{|Q|}\int_{\mathbb{R}}\|g(x,\cdot)\|_{L^{R'}(\mathsf{W},\mu)}^{1+\epsilon}\cdot\tilde{\chi}_Q^M(x)dx\big)^{\frac{1}{1+\epsilon}}\cdot |Q|.
$$

However, we can improve on this result, namely by proving that we can indeed have an L¹ average of $||g(x, \cdot)||_{LR'(W,\mu)}$. We will only show this in the case $L^R(W,\mu) = \ell^s$, for some $s > r'$, but our proof can be adapted to the general setting.

In Proposition [35,](#page-50-0) we obtained an L^1 size of g by splitting the function as $g = g_1 \cdot g_2$, where $g_1 \in L^r$ and $g_2 \in L^{r'}$. Because we want to obtain an L^1 average for g, we cannot afford to use restricted-type functions (that is, we cannot assume that $|g(x)| \leq \mathbf{1}_G(x)$ for some finite set $G \subset \mathbb{R}$, and instead we use the above decomposition of the function. The situation will be similar for the vector-valued estimate, in the sense that we will need to find a "good" splitting of \vec{g} .

Proposition 37. Let $s > r'$, \mathbb{P} a finite collection of multi-tiles, I_0 a fixed dyadic interval, and F a set of finite measure. Let $\vec{f} = \{f_k\}_k$ and $\vec{g} = \{g_k\}_k$ be vector-valued functions so that $\|\vec{f}(x)\|_{\ell^s} \leq \mathbf{1}_F(x)$ for a.e. x and $\|\vec{g}(x)\|_{\ell^{s'}}$ is a locally integrable function on \mathbb{R} . Then

(88)
$$
\left|\sum_{k} \Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f_k,g_k)\right| \lesssim \left(\widetilde{size}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\epsilon} \cdot \left(\widetilde{size}_{\mathbb{P}(I_0)}^{\epsilon}\|\vec{g}\|_{\ell^{s'}}\right) \cdot |I_0|.
$$

As a consequence, we obtain the following sparse domination result: given \tilde{f} and \tilde{g} vectorvalued functions so that $\|\bar{f}(x)\|_{\ell^s}$ and $\|\bar{g}(x)\|_{\ell^{s'}}$ are locally integrable functions and $\epsilon > 0$, there exists a sparse family S of dyadic intervals so that

$$
|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}}(\vec{f},\vec{g})| \lesssim_{\epsilon} \sum_{Q \in \mathcal{S}} \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \|\vec{f}(x)\|_{\ell^{s}}^{r'+\epsilon} \cdot \tilde{\chi}_Q^M(x) dx \Big)^{\frac{1}{r'+\epsilon}} \cdot \Big(\frac{1}{|Q|} \int_{\mathbb{R}} \|\vec{g}(x)\|_{\ell^{s'}} \cdot \tilde{\chi}_Q^M(x) dx \Big) \cdot |Q|.
$$

The proof of estimate [\(88\)](#page-54-2) relies on the following localization result:

Proposition 38. Let $q' > r'$, let \mathbb{P} be a finite collection of multi-tiles, I_0 a fixed dyadic interval, F a set of finite measure and f, g_1, g_2 locally integrable functions, with the additional property that $|f(x)| \leq \mathbf{1}_F(x)$ for a.e. x. Then

$$
(89) \qquad \left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f,g_1\cdot g_2)\right| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\frac{1}{q'}-\epsilon} \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{q'}g_1\right) \cdot |F|^{\frac{1}{q'}} \cdot \|g_2\cdot \widetilde{\chi}_{I_0}^M\|_q.
$$

We postpone the proof of Proposition [38](#page-55-0) in order to show how it implies Proposition [37:](#page-54-1)

Proof of Proposition [37.](#page-54-1) We know that $\|\vec{f}(x)\|_{\ell^{s}} \leq \mathbf{1}_{F}(x)$ and we want to estimate

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f_k,g_k)\right| = \left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f_k \cdot \mathbf{1}_F,g_k)\right| := \left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^F(f_k,g_k)\right|.
$$

We write $g_k \coloneqq \tilde{g}_k \cdot \mathfrak{g}$, where $\mathfrak{g} \coloneqq \| \vec{g} \|_{\ell^{s'}}$ (if $\mathfrak{g}(x) = 0$, we simply set $\tilde{g}_k(x) = 0$). Then we apply the result of Proposition [38](#page-55-0) to $\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f_k \cdot 1_F, g_k)$, under the assumption that $|f_k(x)| \leq \mathbf{1}_{E_1}$. In fact, we have $|f_k(x)| \leq \mathbf{1}_{E_1 \cap F}$ (because f_k is supported inside F), and we can ameliorate the estimate of Proposition [38.](#page-55-0) Here we prove the inequality in the case of restricted-type functions, and as a consequence of interpolation theory, we will deduce the general case:

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f_k \cdot \mathbf{1}_F, \mathfrak{g}^{\frac{1}{q'}} \cdot \mathfrak{g}^{\frac{1}{q}} \tilde{g}_k)\right| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)} \mathbf{1}_F\right)^{\frac{1}{r'} - \frac{1}{q'} - \epsilon} \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{q'} \mathfrak{g}^{\frac{1}{q'}}\right) \cdot |E_1|^{\frac{1}{q'}} \cdot \|\mathfrak{g}^{\frac{1}{q}} \tilde{g}_k\|_q
$$

$$
\lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)} \mathbf{1}_F\right)^{\frac{1}{r'} - \frac{1}{q'} - \epsilon} \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^1 \mathfrak{g}\right)^{\frac{1}{q'}} \cdot |E_1|^{\frac{1}{q'}} \|\tilde{g}_k\|_{L^q(\mathfrak{g})}.
$$

Above, we applied Proposition [38,](#page-55-0) with F a fixed set of finite measure and $\mathfrak g$ a fixed locally integrable function, with $g \geq 0$, to obtain that the operator defined by

$$
f\mapsto \mathcal{C}^{var,r}_\mathbb{P}(f\cdot 1_F)
$$

is bounded from $L^{q',1}$ into $L^{q'}(\mathfrak{g})$ with an operatorial norm equal to

$$
\left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\frac{1}{q'}-\epsilon}\left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}^1\mathfrak{g}\right)^{\frac{1}{q'}}.
$$

Upon using restriction onto the sets $\{x : \text{ dist}(x, I_0) \sim (2^{\kappa} - 1)|I_0|\}$ (we can perform a decomposition of f as in the proof of Proposition [35\)](#page-50-0), which entails a decaying factor $2^{-\kappa M}$, and interpolation (q' is arbitrary, and it can vary in a small neighborhood of $s > r'$), we deduce that

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f_k\cdot\mathbf{1}_F,\mathfrak{g}^{\frac{1}{s}}\cdot\mathfrak{g}^{\frac{1}{s'}}\tilde{g}_k)\right|\lesssim \left(\text{size}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{\frac{1}{r'}-\frac{1}{s}-\epsilon}\left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^{-1}\,\mathfrak{g}\right)^{\frac{1}{s}}\cdot \|f_k\cdot\tilde{\chi}_{I_0}^M\|_s\cdot \|\tilde{g}_k\cdot\tilde{\chi}_{I_0}^M\|_{L^{s'}(\mathfrak{g})}.
$$

It is due to the log-convexity in the interpolation (for this, see Theorem 1.2.19 of [\[Gra08\]](#page-58-24)) that we can obtain the suitable exponent for $\widetilde{\text{size}}_{\mathbb{P}(I_0)}^1$ g.

From here on, the proof is standard: we sum in k to get that

$$
\left| \sum_{k} \Lambda_{\mathcal{C}^{var,r}; \mathbb{P}(I_0)}(f_k, g_k) \right| \lesssim \left(\text{size}_{\mathbb{P}(I_0)} \mathbf{1}_F \right)^{\frac{1}{r'} - \frac{1}{s} - \epsilon} \left(\widetilde{\text{size}}^1_{\mathbb{P}(I_0)} \mathfrak{g} \right)^{\frac{1}{s}} \cdot \|\mathbf{1}_F \cdot \widetilde{\chi}_{I_0}^M\|_{s} \cdot \left\| \left(\sum_{k} |\widetilde{g}_k|^{s'} \right)^{\frac{1}{s'}} \cdot \widetilde{\chi}_{I_0}^M \right\|_{L^{s'}(\mathfrak{g})}
$$

$$
\lesssim \left(\text{size}_{\mathbb{P}(I_0)} \mathbf{1}_F \right)^{\frac{1}{r'} - \epsilon} \left(\widetilde{\text{size}}^1_{\mathbb{P}(I_0)} \mathfrak{g} \right) \cdot |I_0|,
$$

where we used that $\left(\sum\right)$ k $|\tilde{g}_k|^{s'}\big)^{\frac{1}{s'}} = 1$ on the set where $\mathfrak{g}(x) \neq 0$ and hence

$$
\|\left(\sum_{k} |\tilde{g}_k|^{s'}\right)^{\frac{1}{s'}} \cdot \tilde{\chi}_{I_0}^M\|_{L^{s'}(\mathfrak{g})} = \|\mathfrak{g} \cdot \tilde{\chi}_{I_0}^{\tilde{M}}\|_{I}^{\frac{1}{s'}}.
$$

If we were allowed to use restricted-type functions, the "weight" g would be replaced by $\mathbf{1}_G$, as in the previous analysis of vector-valued inequalities from [\[BM16\]](#page-57-0).

We end by providing a proof for Proposition [38;](#page-55-0) the case when $q' = r'$ and g_1, g_2 are particular functions (we recall that $||g_1||_r^r = ||g_2||_{r'}^{r'}$ $r'_{r'} = ||g||_1$ was already presented in Proposition [35.](#page-50-0)

Proof of Proposition [38.](#page-55-0) In order to prove the estimate [\(89\)](#page-55-1), we will make use of Proposi-tion [35.](#page-50-0) As in the proof of Theorem [36,](#page-52-0) we perform a stopping time for $\mathbf{1}_F$ with respect to $L^{q'-\epsilon}$ averages, and a stopping time for g_2 with respect to L^q averages.

More exactly, for every n_1 so that $2^{-n_1} \n\t\leq \n\t\leq \n\t\leq \n\t\leq \n\t\leq \n\t\leq \n\t\leq \n\t\leq \n\t\leq 1$, we construct a collection \mathcal{I}^{n_1} of maximal intervals I for which

$$
2^{-n_1} \leq \Big(\frac{1}{|I|}\int_{\mathbb{R}} \mathbf{1}_{F} \cdot \tilde{\chi}_I^M dx\Big)^{\frac{1}{q'-\epsilon}} \leq 2^{-n_1+1},
$$

and for every such interval we have associated a non-empty collection of multi-tiles \mathbb{P}_I so that $\widetilde{\text{size}\,}^{q'-\epsilon}_{\mathbb{P}_I}$ $\int_{\mathbb{P}_I}^{q^{\prime}-\epsilon} \mathbf{1}_F \lesssim 2^{-n_1}$. In particular, we note that

$$
\sum_{I \in \mathcal{I}^{n_1}} |I| \lesssim 2^{n_1(q'-\epsilon)} |F|.
$$

Similarly, for every n_2 so that $2^{-n_2} \leq \widetilde{\text{size}}_{\mathbb{P}(I_0)}^q g_2$, we construct a collection \mathcal{I}^{n_2} of maximal intervals I so that

$$
2^{-n_2} \leq \Big(\frac{1}{|I|}\int_{\mathbb{R}} |g_2(x)|^q \cdot \tilde{\chi}_{I_0}^{Mq} \cdot \tilde{\chi}_{I}^{M} dx\Big)^{\frac{1}{q}} \leq 2^{-n_2+1}.
$$

For the selected intervals $I \in \mathcal{I}^{n_2}$, we assume there exists a multi-tile $P \in \mathbb{P}_{Stock}$ with $I_P \subseteq I$, and consequently a nonempty subcollection of multi-tiles $\mathbb{P}_I \subseteq \mathbb{P}$ so that $\overline{\text{size}}_{\mathbb{P}_I}^q g_2 \leq 2^{-n_2}$. We also obtain that

$$
\sum_{I \in \mathcal{I}^{n_2}} |I| \lesssim 2^{n_2 q} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q.
$$

Once these arrangements are made, we are ready to prove [\(89\)](#page-55-1):

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}(f,g_1\cdot g_2)\right| \lesssim \sum_{n_1,n_2} \sum_{I\in\mathcal{I}^{n_1}\cap\mathcal{I}^{n_2}} \left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}_I}(f,g_1\cdot g_2)\right|
$$

$$
\lesssim \sum_{n_1,n_2} \sum_{I\in\mathcal{I}^{n_1}\cap\mathcal{I}^{n_2}} \left(\widetilde{\text{size}\,}_{\mathbb{P}_I} \mathbf{1}_F\right)^{\frac{1}{r'}-\epsilon} \cdot \left(\widetilde{\text{size}\,}_{\mathbb{P}_I} g_1\cdot g_2\right) \cdot |I|
$$

$$
\lesssim \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)} \mathbf{1}_F\right)^{\frac{1}{r'}-\frac{1}{q'-\epsilon}-\epsilon} \cdot \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}^{\epsilon q'} g_1\right) \sum_{n_1,n_2} \sum_{I\in\mathcal{I}^{n_1}\cap\mathcal{I}^{n_2}} 2^{-n_1} 2^{-n_2} |I|,
$$

and it only remains to prove that

(90)
$$
\sum_{n_1,n_2} \sum_{I \in \mathcal{I}^{n_1} \cap \mathcal{I}^{n_2}} 2^{-n_1} 2^{-n_2} |I| \lesssim |F|^{\frac{1}{q'}} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q.
$$

We note that

$$
\sum_{n_1,n_2}\sum_{I\in \mathcal{I}^{n_1}\cap \mathcal{I}^{n_2}} 2^{-n_1} 2^{-n_2} |I| \lesssim \sum_{n_1}\sum_{n_2} 2^{-n_1} 2^{-n_2}\cdot \min\left(2^{n_1(q'-\epsilon)} |F|, 2^{n_2q}\|g_2\cdot \tilde{\chi}_{I_0}^M\|_q^q\right).
$$

We do not use the interpolation estimate $\min(A, B) \le A^{\theta} \cdot B^{1-\theta}$; instead, we analyze the two possibilities:

(i) if
$$
2^{n_1(q'-\epsilon)}|F| \le 2^{n_2 q} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q
$$
, then $2^{-n_2} \le 2^{-\frac{n_1(q'-\epsilon)}{q}}|F|^{\frac{-1}{q}} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q$ and
\n
$$
\sum_{n_1} \sum_{n_2} 2^{-n_1} 2^{-n_2} \cdot \min\left(2^{n_1(q'-\epsilon)}|F|, 2^{n_2 q} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q\right) \lesssim \sum_{n_1} 2^{-n_1} 2^{n_1(q'-\epsilon)}|F| \sum_{n_2} 2^{-n_2}
$$
\n
$$
\lesssim \sum_{n_1} 2^{-n_1} 2^{n_1(q'-\epsilon)}|F| \cdot 2^{-\frac{n_1(q'-\epsilon)}{q}}|F|^{\frac{-1}{q}} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q \lesssim \sum_{n_1} 2^{-n_1\left(1-\frac{q'-\epsilon}{q'}\right)} \cdot |F|^{\frac{1}{q'}} \cdot \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q.
$$

(ii) on the other hand, if $2^{n_1(q'-\epsilon)}|F| \geq 2^{n_2q} ||g_2 \cdot \tilde{\chi}_{I_0}^M||_q^q$, we obtain that

$$
\sum_{n_1} \sum_{n_2} 2^{-n_1} 2^{-n_2} \cdot \min\left(2^{n_1(q'-\epsilon)} |F|, 2^{n_2 q} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q\right) \lesssim \sum_{n_1} 2^{-n_1} \sum_{n_2} 2^{-n_2} 2^{n_2 q} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q
$$

$$
\lesssim \sum_{n_1} 2^{-n_1} \sum_{n_2} 2^{n_2(q-1)} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q \lesssim \sum_{n_1} 2^{-n_1} 2^{\frac{n_1(q'-\epsilon)(q-1)}{q}} |F|^{\frac{q-1}{q}} \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^{-(q-1)} \cdot \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q
$$

$$
\lesssim \sum_{n_1} 2^{-n_1 \left(1 - \frac{q'-\epsilon}{q'}\right)} |F|^{\frac{1}{q'}} \cdot \|g_2 \cdot \tilde{\chi}_{I_0}^M\|_q^q.
$$

In either case, the series in n_1 are summable and we obtain [\(90\)](#page-56-0).

 \Box

.

Remark:. The same analysis applies in the case of Carleson operator; the statement of Proposition [38](#page-55-0) becomes: for any $q' > 1$, and for any finite collection of tiles $\mathbb{P}(I_0)$, any set of finite measure F and any locally integrable functions f, g_1, g_2 so that $|f(x)| \leq \mathbf{1}_F(x)$ for a.e. x , we have

$$
\left|\Lambda_{\mathcal{C};\mathbb{P}(I_0)}(f,g_1\cdot g_2)\right|\lesssim \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{1-\frac{1}{q'}-\epsilon}\cdot \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}^{q'}g_1\right)\cdot |F|^{\frac{1}{q'}}\cdot \|g_2\cdot \widetilde{\chi}_{I_0}^M\|_q.
$$

And this implies, for any $1 < s < \infty$, and any $\vec{f} = \{f_k\}_k$, $\vec{g} = \{g_k\}_k$ with $\|\vec{f}\|_{\ell^s} \leq \mathbf{1}_F(x)$:

(91)
$$
\left|\sum_{k} \Lambda_{\mathcal{C};\mathbb{P}(I_0)}(f_k,g_k)\right| \lesssim \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{1-\epsilon} \cdot \left(\widetilde{\text{size}}_{\mathbb{P}(I_0)}^1\|\vec{g}\|_{\ell^{s'}}\right) \cdot |I_0|.
$$

Remark:. In the general case of iterated vector spaces, the corresponding inductive statement for the variational Carleson operator is: for any $q' > r'$, and for any finite collection of multi-tiles $\mathbb{P}(I_0)$, any sets of finite measure F and E_1 , and any vector-valued functions $\vec{f}, \vec{g}_1, \vec{g}_2$ so that $|| f(x, \cdot) ||_{L^R(w, \mu)}$, $||g_1(x, \cdot)||_{L^{R'}(W, \mu)}$ and $||g_2(x, \cdot)||_{L^{R'}(W, \mu)}$ are locally integrable functions with $|| f(x, \cdot) ||_{L^R(w, \mu)} \leq \mathbf{1}_{E_1}(x)$ for a.e. x, we have

$$
\left|\Lambda_{\mathcal{C}^{var,r};\mathbb{P}(I_0)}^F(\vec{f},\overrightarrow{(g_1\cdot g_2)})\right|\lesssim \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}\mathbf{1}_F\right)^{1-\frac{1}{q'}-\epsilon}\cdot \left(\widetilde{\text{size}\,}_{\mathbb{P}(I_0)}^{\ q'}\|g_1(x,\cdot)\|_{L^{R'}(\mathbb{W},\mu)}\right)\cdot \left|E_1\right|^{\frac{1}{q'}\cdot}\left\|\left\|g_2(x,\cdot)\right\|_{L^{R'}(\mathbb{W},\mu)}\cdot \widetilde{\chi}_{I_0}^M\right\|_{L_x^q}
$$

Here $\overrightarrow{(g_1 \cdot g_2)}$ denotes the vector-valued function written component-wise as $\overrightarrow{(g_1 \cdot g_2)}(x, w)$ = $\vec{g}_1(x, w) \cdot \vec{g}_2(x, w)$ for a.e. $(x, w) \in \mathbb{R} \times \mathcal{W}$.
