SPARSE ENDPOINT ESTIMATES FOR BOCHNER-RIESZ MULTIPLIERS ON THE PLANE

ROBERT KESLER AND MICHAEL T. LACEY

ABSTRACT. For $0 < \lambda < \frac{1}{2}$, let B_{λ} be the Bochner-Riesz multiplier of index λ on the plane. Associated to this multiplier is the critical index $1 < p_{\lambda} = \frac{4}{3+2\lambda} < \frac{4}{3}$. We prove a sparse bound for B_{λ} with indices (p_{λ}, q) , where $p'_{\lambda} < q < 4$. This is a further quantification of the endpoint weak $L^{p_{\lambda}}$ boundedness of B_{λ} , due to Seeger. Indeed, the sparse bound immediately implies new endpoint weighted weak type estimates for weights in $A_1 \cap RH_{\rho}$, where $\rho > \frac{4}{4-3p_{\lambda}}$.

1. INTRODUCTION

We establish a range of sparse bounds for the Bochner-Riesz multipliers in the plane, at the critical index of p. The Bochner-Riesz multipliers in the plane are defined through the Fourier transform by

$$\mathcal{F}(B_{\lambda}f)(\xi) = (1 - |\xi|^2)^{\lambda}_{+} \mathcal{F}f(\xi), \qquad 0 < \lambda < \frac{1}{2}$$

The case of $\lambda = \frac{1}{2}$ is the critical case in dimension d = 2, where $B_{\frac{1}{2}}$ maps L^p to itself for all $1 , and is of weak-type (1, 1). For <math>0 < \lambda < \frac{1}{2}$, the critical index of p_{λ} is given by

$$(1.1) \quad p_{\lambda} = \frac{4}{3+2\lambda}.$$

The Carleson-Sjölin theorem gives the L^p boundedness of the B_{λ} .

Theorem A. [2] For $0 < \lambda < \frac{1}{2}$, there holds

$$||B_{\lambda}||_{p \to p} < \infty, \qquad p_{\lambda} < p < p'_{\lambda} = \frac{p_{\lambda}}{p_{\lambda} - 1}$$

We recall the notion of a sparse bound, which are a particular quantification of the (weak) L^p -bounds for an operator. They in particular immediately imply weighted and vector-valued inequalities. Given a sublinear operator T, and $1 \leq r, s < \infty$, we set ||T : (r, s)|| to be the infimum over constants C so that for all measurable, bounded, and compactly supported functions f, g,

$$|\langle Tf, g \rangle| \le C \sup \sum_{Q \in \mathcal{S}} \langle f \rangle_{Q,r} \langle g \rangle_{Q,s} |Q|.$$

FIGURE 1. The solid diagonal line indicates the Carleson-Sjölin bounds. The dotted rhombus R_{λ} is the open region for which a sparse bound holds for B_{λ} , see [8]. The solid vertical line above $\frac{1}{p_{\lambda}}$ indicates the range of sparse bounds proved in this paper from which the solid horizontal line is obtained as an immediate consequence. We leave it as a question if B_{λ} satisfies a sparse bound for (p_{λ}, s) , where $\frac{1}{4} \leq \frac{1}{s} < \frac{1+6\lambda}{4}$.

We use throughout the notation $\langle f \rangle_{Q,r} = [|Q|^{-1} \int_Q |f|^r dx]^{\frac{1}{r}}$. The supremum above is formed over all *sparse* collections \mathcal{S} of cubes. A collection \mathcal{S} is sparse if for each $Q \in \mathcal{S}$ there is a set $E_Q \subset S$ so that (a) $|E_Q| \geq \frac{1}{10}|Q|$, and (b) the sets $\{E_Q : Q \in \mathcal{S}\}$ are pairwise disjoint. It is essential that the sparse form be allowed to depend upon f and g. But the point is that the sparse form itself varies over a class of operators with very nice properties.

The sparse variant of the Carleson-Sjölin bounds has been studied in [1, 8].

Theorem B. [8] For $0 < \lambda < \frac{1}{2}$, let R_{λ} be the open rhombus with vertices

$$\frac{1}{p_{\lambda}}, \frac{1}{p_{\lambda}'}$$
), $\left(\frac{1+6\lambda}{4}, \frac{1}{p_{\lambda}'}\right)$, $\left(\frac{1}{p_{\lambda}}, \frac{1+6\lambda}{4}\right)$, $\left(\frac{1}{p_{\lambda}'}, \frac{1}{p_{\lambda}}\right)$.

There holds

 $||B_{\lambda}:(r,s)|| < \infty, \qquad (\frac{1}{r},\frac{1}{s}) \in R_{\lambda}$

Moreover, the inequality above fails for $\frac{1}{r} + \frac{1}{s} \ge 1$, with $(\frac{1}{r}, \frac{1}{s})$ **not** in the closure of R_{λ} .

The rhombus R_{λ} is pictured in Figure 1. At the endpoint in the Carleson-Sjölin theorem, a weak-type estimate holds, as was proved by Seeger [9], extending the work of Christ [4].

Theorem C. For $0 < \lambda < \frac{1}{2}$, there holds

 $||B_{\lambda}||_{p_{\lambda}\to(p_{\lambda},\infty)}<\infty.$

Our main result is a sparse quantification of this last result.

Theorem 1.2. Let $0 < \lambda < \frac{1}{2}$, and p_{λ} as in (1.1), these sparse bounds hold.

 $||B_{\lambda}:(p_{\lambda},q)|| < \infty, \qquad 4 < q < p_{\lambda}' = \frac{p_{\lambda}}{p_{\lambda}-1}.$

An immediate consequence of Theorem 1.2 is that $||B_{\lambda} : (q, p_{\lambda})|| < \infty$ for the same range of q and λ . While the sparse bounds in Theorem B are sharp, up to the boundary, we could not determine sharpness above. Whether $||B_{\lambda} : (p_{\lambda}, q)|| < \infty$ holds for $0 < \lambda < \frac{1}{2}$ and $\frac{4}{1+6\lambda} < q \leq 4$ remains an open question.

Our main result contains Seeger's inequality, as well as some weighted inequalities. While this paper is not the first to show weighted endpoint estimates for the Bochner-Riesz multipliers, the literature on this subject is limited. While Vargas proves that Bochner-Riesz multipliers at the critical index $\frac{n-1}{2}$ are of weak type (1, 1) with respect to any weight in the A_1 -Muckenhoupt class [11], weighted inequalities for Bochner-Riesz multipliers below the critical index are new to our knowledge.

Corollary 1.3. Let $0 < \lambda < \frac{1}{2}$ and $\rho > \frac{4}{4-3p_{\lambda}}$. Then, for every $w \in A_1 \cap RH_{\rho}$ we have the inequality

 $||B_{\lambda}||_{L^{p_{\lambda}}(w)\mapsto L^{p_{\lambda},\infty}(w)}<\infty.$

The implied constant depends only on the A_1 and reverse Hölder characteristic of w.

The notation above is standard. By [6, Thm 1.3], a quantitative version of Corollary 1.3 is that for $0 < \lambda < \frac{1}{2}$, $\rho > \frac{4}{4-3p_{\lambda}}$, and $w \in A_1 \cap RH_{\rho}$,

$$||B_{\lambda}||_{L^{p_{\lambda}}(w)\mapsto L^{p_{\lambda},\infty}(w)} \leq c(n,\rho)[w^{\rho}]_{A_{\infty}}^{1+\frac{1}{p_{\lambda}}} \left([w]_{A_{1}}[w]_{RH_{\rho}}\right)^{\frac{1}{p_{\lambda}}}.$$

The study of sparse bounds for the Bochner-Riesz multipliers was initiated by Benea, Bernicot and Luque [1]; their analysis was recently simplified and extended by one of us, Mena, and Reguera [8]. The reader should consult that paper for more background and references to the sparse literature.

2. Lemmas

To align our discussion with the notation of [9], we expand Bochner-Riesz operator in the following way. For integers $j \ge 0$, let T_j be a smooth radial Fourier projection adapted to $\{|\vec{\xi}| < 1 : \operatorname{dist}(\vec{\xi}, \mathbb{S}^1) \simeq 2^{-j}\}$. Specifically, pick $\phi \in C_0^{\infty}([-2, 2])$ such that $\phi \equiv 1$ on [0, 1] and set $\psi(\xi) = \phi(\xi) - \phi(2\xi)$ along with $\psi_j(\xi) = \psi(2^j\xi)$ for every integer $j \ge 0$. Then $\sum_{j>0} \psi_j(\xi) \equiv 1$ on [0, 1], and consequently $(1 - |\xi|^2)^{\lambda}_+ =$ $\sum_{j\geq 0} (1-|\xi|^2)^{\lambda}_{+} \psi_j (1-|\xi|). \text{ Defining } \widehat{T_j^{\lambda} f}(\xi) = 2^{\lambda j} (1-|\xi|^2)^{\lambda}_{+} \psi_j (1-|\xi|) \widehat{f}(\xi), \text{ we will have for every } \lambda \in (0, \frac{1}{2})$

$$B_{\lambda} = T_0^{\lambda} + \sum_{j \ge 1} 2^{-\lambda j} T_j^{\lambda}.$$

As $|T_0^{\lambda} f(x)| \leq M_{HL} f(x)$ for all locally integrable functions f and $||M_{HL} : (1,1)|| < \infty$, it suffices to prove Theorem 1.2 with B_{λ} replaced by $\sum_{j\geq 1} 2^{-\lambda j} T_j^{\lambda}$. We shall need the following inequality concerning the kernel of T_j^{λ} .

Lemma 2.1. Set
$$T_j^{\lambda} f(x) = \tau_j^{\lambda} * f(x)$$
. For all integers $j, N \ge 1$ and $\lambda \in (0, \frac{1}{2})$,
(2.2) $|\tau_j^{\lambda}(x)| \lesssim_N [2^{-j}|x|]^{-2N} 2^{-\frac{3j}{2}}$, $|x| \ge 2^j$.

While the implied constant depends upon N, it is uniform in $j \ge 0$ and $\lambda \in [0, 1/2]$.

We could not find a source for this estimate, so include a proof here.

Proof. Fix $\lambda \in (0, \frac{1}{2})$ and let $\tau_j^{\lambda} = \tau_j$. Then the Fourier transform of τ_j , $\hat{\tau}_j$, is a radial function, so that it follows from [10, Chap VII 5.12] that for the radial variable u > 0, we have

$$\tau_j(u) = 2\pi \int_0^\infty \widehat{\tau_j}(s) J_0(2\pi u s) \ s \ ds$$

where J_0 is the 0th order Bessel function. For an integer N, apply integration by parts 2N times, integrating the Bessel function each time. A complication arises here due to the presence of the Bessel functions, which is addressed in Lemma 2.3.

We have, using a change of variables and (2.4)

$$\left| \int_0^\infty \widehat{\tau_j}(s) J_0(2\pi u s) \, s \, ds \right| = (2\pi u)^{-2N} \left| \int_0^\infty [M^{-1} D M D]^N \widehat{\tau_j}(s) \cdot J_0(2\pi u s) \, s \, ds \right|.$$

Examine the integral above. The function $[M^{-1}DMD]^N \hat{\tau}_j(s)$ is supported in an interval close to s = 1 of width 2^{-j} . Each derivative applied to $\hat{\tau}_j(s)$ gains a factor of 2^j , so that the function is bounded bounded by $C_N 2^{2jN}$. And, the asymptotics for the Bessel function are

$$|J_0(2\pi u)| \lesssim u^{-\frac{1}{2}} \lesssim C_N 2^{-\frac{j}{2}}$$

Therefore we have the estimate below, which completes the Lemma.

$$|\tau_j(u)| \le C_N [u^{-1} 2^j]^{2N} \cdot 2^{-\frac{3j}{2}}.$$

Lemma 2.3. Let χ be a smooth compactly supported function on $(0, \infty)$. We have

(2.4)
$$\int_0^\infty \chi(s) J_0(s) s \, ds = -\int [M^{-1} D M D \chi(s)] J_0(s) s \, ds,$$

where $D = \frac{d}{dx}$ and $M\phi(s) = s\phi(s)$ is multiplication by the independent variable.

Proof. There are two classical identities concerning the Bessel functions, that we need. Namely,

(2.5)
$$D^{-1}sJ_0(s) = sJ_1(s),$$

$$(2.6) D^{-1}J_1 = -J_0.$$

Using integration by parts, (2.5) and (2.6), in that order we have

$$\int_0^\infty \chi(s) \cdot s J_0(s) \, ds = -\int D\chi(s) \cdot s J_1(s) \, ds$$
$$= -\int MD\chi(s) \cdot J_1(s) \, ds$$
$$= -\int DMD\chi(s) \cdot J_0(s) \, ds$$
$$= -\int M^{-1}DMD\chi(s) \cdot s J_0(s) \, ds.$$

This completes the proof.

The L^p mapping properties of T_j are well known, namely

(2.7)
$$||T_j||_{p \to p} \lesssim \begin{cases} 2^{\frac{j}{2}} & p = 1\\ 2^{\lambda_{pj}} & 1$$

The first is well known, the second is a consequence of Hörmander's version of the Carleson-Sjölin bounds from [7], and the third is due to Córdoba [5]. These estimates are not sufficient for the endpoint case, however. Our proof implicitly relies upon the Theorem below, a key inequality of Seeger [9]. We will appeal to certain consequences of it.

Theorem 2.8. [9, Thm 2.1] Suppose that $1 \le p < \frac{4}{3}$ and $\lambda_p = 2(\frac{1}{p} - \frac{1}{2}) - \frac{1}{2}$. Then there is the inequality

(2.9)
$$\left\|\sum_{j=1}^{\infty} T_j^{\lambda_p} f_j\right\|_p \lesssim \left[\sum_{j=1}^{\infty} 2^{p\lambda_p j} \|f_j\|_p^p\right]^{\frac{1}{p}}.$$

Technically, Theorem 2.1 in [9] yields (2.9) for the family $\{S_j\}_{j\geq 1}$ where $\widehat{S_jf}(\xi) = \eta(\xi)(1-|\xi|^2)^{\lambda_p}_+\psi_j(1-|\xi|)\widehat{f}(\xi)$ where $\eta \in C_0^{\infty}(\mathbb{R}^2)$ has $supp(\eta) \subset \{\xi \in \mathbb{R}^2 : |\xi_1/\xi_2| \leq 10^{-1}, \xi_2 > 0\}$ and ψ_j is the same function as before. However, rotating the Fourier transform of $\{f_j\}$ yields (2.9) for η precomposed with any rotation. It is then straightforward to rewrite for any $j \geq 1$

$$\psi_j(1-|\xi|) = \sum_{k=1}^K \eta_k(\xi)\psi_j(1-|\xi|)$$

where K = O(1) and each $\eta_k = \tilde{\eta}_k \circ R_k$ where R_k is a rotation and $\tilde{\eta}_k \in C_0^{\infty}(\mathbb{R}^2)$ with $supp(\tilde{\eta}_k) \subset \{\xi \in \mathbb{R}^2 : |\xi_1/\xi_2| \leq 10^{-1}, \xi_2 > 0\}$. This naturally leads to a decomposition $T_j^{\lambda_p} = \sum_{k=1}^K T_{j,k}^{\lambda_p}$. By the triangle inequality and the validity of (2.9) on the $\{T_{j,k}^{\lambda_p}\}_{j\geq 1}$ for each $1 \leq k \leq K$ yields (2.9) for $\{T_j^{\lambda_p}\}_{j\geq 1}$ as claimed. The restriction $1 \leq p < \frac{4}{3}$ above, will by duality, lead to the restriction that s > 4 in our main theorem.

3. Proof

The method of proof begins with the analysis of Seeger [9], and finishes with some additional arguments. The analysis depends upon a crucial endpoint estimate Theorem 2.8 above, and a fine Calderón-Zygmund analysis, in the style of Christ [3,4].

To state the main recursive estimate needed in the proof, further set a truncated Bochner-Riesz operator adapted to any dyadic square Q to be

$$T^{\lambda_p,Q}f = \sum_{j \,:\, 2^j < \ell Q} 2^{-\lambda_p j} T_j^{\lambda_p} f, \qquad \lambda_p = 2(\frac{1}{p} - \frac{1}{2}) - \frac{1}{2}.$$

Lemma 3.1. Let 1 , <math>4 < q < p'. For any square E and pair of measurable and bounded functions $f: E \to \mathbb{C}$ and $h: 3E \to \mathbb{C}$ there is a collection \mathcal{B} of disjoint subsquares of E with the properties $|\bigcup_{Q \in \mathcal{B}} Q| \leq \frac{|E|}{100}$ and

(3.2)
$$|\langle T^{\lambda_p, E} f, h \rangle| \lesssim \langle f \rangle_{E, p} \langle h \rangle_{3E, q} |E| + \sum_{Q \in \mathcal{B}} |\langle T^{\lambda_p, Q}(f \mathbf{1}_Q), \mathbf{1}_{3Q} h \rangle|.$$

Below, we will cite two inequalities for the Bochner-Riesz operators from the work of Seeger [9]. But, our application of the estimates differs from their form in [9] in that we will have a truncation T^E in place of the Bochner-Riesz operator. These new inequalities hold, with the same proof as in [9]. This can be seen from the fact that the crucial vector-valued inequality [9, Thm 2.1] trivially extends to the truncated case. And, all of the endpoint interpolation estimates in [9, (3.5-3.14)] extend uniformly.

Proof. Fixing $p \in (1, \frac{4}{3})$, let $T_j = T_j^{\lambda_p}$ for all integers $j \ge 1$ and let $T^Q = T^{\lambda_p,Q}$ for all dyadic squares Q. If E has area one, the Lemma holds with \mathcal{B} being empty. Assume therefore that E has area larger than one. The following argument is not symmetric, in that we perform an L^p Calderón-Zygmund decomposition on f at level $\langle f \rangle_{E,p}$, while the function h remains untouched. This yields f = g + b where $||g||_{L^{\infty}} \lesssim \langle f \rangle_{E,p}$ and $||g||_p \lesssim ||f||_p$. The function b satisfies $b = \sum_{Q \in \mathcal{B}} b_Q$, where \mathcal{B} are disjoint dyadic subsquares of E, with

$$\left|\bigcup_{Q\in\mathcal{B}}Q\right| \le \frac{1}{100}|E|.$$

The functions $b_Q = (f - \langle f \rangle_Q) \mathbf{1}_Q$ are supported on Q, and satisfy $||b_Q||_p^p \lesssim \langle f \rangle_{E,p}^p |Q|$. Here, $\langle f \rangle_Q = |Q|^{-1} \int_Q f \, dx$. The function b is then further decomposed into the sum $\sum_{t=0}^{\infty} \beta_t$, where the index t indexes the side lengths of the squares $Q \in \mathcal{B}$. Namely,

$$\beta_0 := \sum_{Q \in \mathcal{B} : \ell Q \le 0} b_Q, \quad \text{and} \quad \beta_t := \sum_{Q \in \mathcal{B} : \ell Q = 2^t} b_Q, \ 0 < t < \log_2 \ell E$$

where ℓQ and ℓE are the sidelengths of Q and E respectively. We then have the equality below for the truncated Bochner-Riesz operator applied to b. Setting $2^{1+j_E} = \ell E$, we have

$$T^{E}b = \sum_{s \ge 0} \sum_{j=s+1}^{j_{E}} 2^{-\lambda_{p}j} T_{j}\beta_{j-s} + T^{E}\beta_{0} + \sum_{\sigma \ge 1} \sum_{j=0}^{j_{E}} 2^{-\lambda_{p}j} T_{j}\beta_{j+\sigma}.$$

The inner product in (3.1) is estimated by

$$\begin{aligned} |\langle T^E f, h \rangle| &\leq |\langle T^E g, h \rangle| + \sum_{s \geq 0} \left| \left\langle \sum_{j=s+1}^{j_E} 2^{-\lambda(p)j} T_j \beta_{j-s}, h \right\rangle \right| \\ &+ |\langle T^E \beta_0, h \rangle| + \left| \left\langle \sum_{\sigma \geq 1} \sum_{j=0}^{j_E} 2^{-\lambda_p j} T_j \beta_{j+\sigma}, h \right\rangle \\ &=: I + II + III + IV. \end{aligned}$$

We estimate the four terms above in order.

As g is bounded, the estimate for the first term is trivial.

$$I = |\langle g, T^E h \rangle| \lesssim \langle f \rangle_{E,p} |E|^{1/2} ||T^E h||_{L^2(\mathbb{R}^2)}$$

$$\lesssim \langle f \rangle_{E,p} \langle h \rangle_{3E,2} |E| \lesssim \langle f \rangle_{E,p} \langle h \rangle_{3E,q} |E|.$$

This is matches the first term on the right in (3.2).

For term II, we turn to the argument of Seeger, and a consequence of Theorem 2.8. Recall from [9, (3.2)], that for any 1 ,

$$\left\|\sum_{j=s+1}^{j_E} 2^{-j\lambda_p} T_j \beta_{j-s}\right\|_r^r \lesssim 2^{-\frac{1}{2}(\frac{r}{p}-1)s} \langle f \rangle_{E,p}^{r-p} \|b\|_p^p, \qquad s \ge 0.$$

Above, we will take $r = q' = \frac{q}{q-1}$. By construction, $||b||_p \leq \langle f \rangle_{E,p} |E|^{1/p}$. Applying Hölder's inequality, we see that

(3.4)
$$II \lesssim 2^{-\frac{1}{2}(\frac{1}{p}-\frac{1}{r})s} \langle f \rangle_{E,p} \langle h \rangle_{3E,q} |E|.$$

For any choice of r the right side above is summable over s. This again matches the first term on the right in (3.2).

For term *III*, dominate

$$|\langle T^E \beta_0, h \rangle| \le \sum_{j \ge 0} |\langle 2^{-j\lambda_p} T_j \beta_0, h \rangle|.$$

Recall from [9, (3.3)] that for any p < r < 4/3

$$\|2^{-j\lambda_p}T_j\beta_0\|_r^r \lesssim 2^{-\frac{1}{2}(\frac{r}{p}-1)j} \langle f \rangle_{E,p}^{r-p} \|b\|_p^p$$

We arrive at the same estimate as in (3.4):

$$III \lesssim 2^{-\frac{1}{2}(\frac{1}{p}-\frac{1}{r})s} \langle f \rangle_{E,p} \langle h \rangle_{3E,q} |E|.$$

The term IV is treated differently. Recalling (3.3), estimate IV by first inserting a spatial localization term $\mathbf{1}_{3Q}$ for the inner product associated with b_Q .

$$(3.5) \quad IV \leq \sum_{\sigma \geq 1} \left| \left\langle \sum_{j=0}^{j_E} \sum_{Q \in \mathcal{B} : \ell Q = 2^{j+\sigma}} 2^{-\lambda_p j} \mathbf{1}_{(3Q)^c} T_j b_Q, h \right\rangle \right|$$
$$+ \left| \left\langle \sum_{\sigma \geq 1} \sum_{j=0}^{j_E} \sum_{Q \in \mathcal{B} : \ell Q = 2^{j+\sigma}} 2^{-j\lambda_p} \mathbf{1}_{3Q} T_j b_Q, h \right\rangle \right|$$
$$:= IV_1 + IV_2.$$

The term IV_1 is an 'error term,' which is dealt with in Lemma 3.6 below. In particular, the conclusion (3.5) of that Lemma implies upon summation over $\sigma \geq 1$ that

$$IV_1 \lesssim \langle f \rangle_{E,p} \langle h \rangle_{3E,q} |E|.$$

This matches the bound in (3.4).

Turning to IV_2 , first recognize that the sum can be reorganized to see that

$$IV_2 \le \sum_{Q \in \mathcal{B}} |\langle T^Q b_Q, \mathbf{1}_{3Q} h \rangle|.$$

That is, it is close to being the last term in (3.2). Second, recall that $b_Q = [f - \langle f \rangle_Q] \mathbf{1}_Q$. Thus, for any square $Q \in \mathcal{B}$,

$$|\langle T^{Q}b_{Q}, \mathbf{1}_{3Q}h\rangle| \leq |\langle f\rangle_{Q} \cdot \langle T^{Q}\mathbf{1}_{Q}, \mathbf{1}_{3Q}h\rangle| + |\langle T^{Q}f\mathbf{1}_{Q}, \mathbf{1}_{3Q}h\rangle|$$

The second term on the right is exactly as in (3.2). We don't need to argue further about it. For the first term on the right, we just use the L^p -norm bound, Hölder's inequality, and the stopping condition to see that

$$\begin{aligned} |\langle f \rangle_Q \cdot \langle T^Q \mathbf{1}_Q, \mathbf{1}_{3Q} h \rangle| &\lesssim \langle f \rangle_{E,p} \| T^Q \mathbf{1}_Q \|_{q'} \| \mathbf{1}_Q h \|_q \\ &\lesssim \langle f \rangle_{E,p} |Q|^{1/q'} \| \mathbf{1}_{3Q} h \|_q. \end{aligned}$$

The sum over the disjoint squares $Q \in \mathcal{B}$ is clearly seen to be at most

$$\langle f \rangle_{E,p} \sum_{Q \in \mathcal{B}} |Q|^{1/q} \| \mathbf{1}_{3Q} h \|_{q'} \lesssim \langle f \rangle_{E,p} \langle h \rangle_{3E,q} |E|.$$

The proof is complete.

Lemma 3.6. For every integer $\sigma \geq 1$

$$\left|\left\langle \sum_{j=0}^{J_E} \sum_{Q \in \mathcal{B}_{j+\sigma}} 2^{-\lambda_p j} \mathbb{1}_{(3Q)^c} T_j^{\lambda_p} b_Q, h \right\rangle \right| \lesssim 2^{-\sigma} \langle f \rangle_{E,p} \langle h \rangle_{3E,q} |E|$$

where 1 , <math>4 < q < p' and E, $f : E \to \mathbb{C}$, $h : 3E \to \mathbb{C}$, j_E , $\{b_Q\}_{Q \in \mathcal{B}}$, and $\{\mathcal{B}_t\}_{0 \le t < \log_2 \ell E}$ are as in Lemma 3.1.

Proof. Fixing $p \in (1, \frac{4}{3})$, let $T_j = T_j^{\lambda_p}$ for all integers $j \ge 1$. We will show that, uniformly in integers $j \ge 0$, $\sigma \ge 1$, $k \ge 2$, and squares $Q \in \mathcal{B}$

(3.8) $\left|\left\langle 1_{\Delta^{k}Q}T_{j}b_{Q},h\right\rangle\right| \lesssim 2^{\lambda_{p}j}2^{-k}2^{-\sigma}\langle f\rangle_{Q,p}\langle h\rangle_{2^{k}Q,q}|Q|,$

where $\Delta^k Q = 2^k Q \cap (2^{k-1}Q)^c$. Summing on $k \ge 2$ and $0 \le j \le j_E$, we have

$$\begin{split} \left| \left\langle \sum_{j=0}^{J^E} \sum_{Q \in \mathcal{B}_{j+\sigma}} 2^{-\lambda_p j} \mathbf{1}_{(3Q)^c} T_j b_Q, h \right\rangle \right| \\ &\lesssim 2^{-\sigma} \sum_{k \ge 2} \sum_{j \ge 0} \sum_{Q \in \mathcal{B}_{j+\sigma}} \left| \left\langle 2^{-\lambda_p j} \mathbf{1}_{\Delta^k Q} T_j b_Q, h \right\rangle \right| \\ &\lesssim 2^{-\sigma} \sum_{Q \in \mathcal{B}} \langle f \rangle_{Q,p} \inf_{x \in Q} [M|h|^q]^{1/q} |Q|. \end{split}$$

An easy application of Hölder's inequality and appealing to the boundedness of the maximal function proves the Lemma.

The claim (3.8) follows from interpolating two separate inequalities. First, appealing to the kernel estimate (2.2), for any measurable and bounded $F, H : \mathbb{R}^2 \to \mathbb{C}$

(3.9)

$$\begin{aligned} \left| \left\langle 1_{\Delta^{k}Q} T_{j}(1_{Q}F), H \right\rangle \right| &\leq \| 1_{\Delta^{k}Q} T_{j}(1_{Q}F) \|_{L^{\infty}} \| H 1_{\Delta^{k}Q} \|_{1} \\ &\lesssim_{N} 2^{-3j/2} 2^{-(N+2)k} 2^{-N\sigma} \| 1_{Q}F \|_{1} \| H 1_{\Delta^{k}Q} \|_{1} \\ &\lesssim 2^{\frac{j}{2}} 2^{-Nk} 2^{-N\sigma} \langle F \rangle_{Q,1} \langle H \rangle_{2^{k}Q,1} |Q|, \qquad k \geq 2, \ N > 1. \end{aligned}$$

The implied constant depends upon N, and below we will specify a choice of $N = N_{p,q}$.

We will also appeal to the norm bound (2.7) on T_j on L^r for any 1 < r < 4/3. Namely

(3.10)
$$\left|\left\langle 1_{\Delta^{k}Q}T_{j}(1_{Q}F),H\right\rangle\right| \lesssim 2^{\lambda_{r}j}2^{\frac{2k}{r'}}\langle F\rangle_{Q,r}\langle H\rangle_{2^{k}Q,r'}|Q|.$$

As 4 < q < p', we may choose $r = q' \left[2 - \frac{1}{p} - \frac{1}{q}\right]$, interpolate between (3.9) and (3.10), and set $F = b_Q$ and H = h to recover

$$\left|\left\langle 1_{\Delta^{k}Q}T_{j}b_{Q},h\right\rangle\right| \lesssim_{N} 2^{\lambda_{p}j}2^{-k}2^{-\sigma}\langle b_{Q}\rangle_{Q,p}\langle h\rangle_{2^{k}Q,q}|Q|$$

provided
$$N = N_{p,q} \ge \frac{1}{\frac{1}{p} + \frac{1}{q} - 1} \left[1 + \frac{2(2 - \frac{1}{p} - \frac{1}{q})}{(q'[2 - \frac{1}{p} - \frac{1}{q}])'} \right]$$
. As $\langle b_Q \rangle_{Q,p} \lesssim \langle f \rangle_{Q,p}$, (3.8) follows.

Proof of Theorem 1.2. Let $f, h : \mathbb{R}^2 \to \mathbb{C}$ be measurable, bounded, and supported on a (translated) dyadic square E. Indeed, we take the cube E so large, with the supports of f and h deeply contained inside E, so that we have

$$|\langle B_{\lambda_p}f,h\rangle| \le C\langle f\rangle_{E,p}\langle h\rangle_{E,q}|E| + |\langle T^{\lambda_p,E}f,h\rangle|.$$

This is possible to do, as follows from the kernel estimates in Lemma 2.1.

We are now in a position to apply the main recursive estimate of Lemma 3.1. From it, we have

$$|\langle T^{\lambda_p, E} f, h \rangle| \le C \langle f \rangle_{E, p} \langle h \rangle_{E, q} |E| + \sum_{Q \in \mathcal{B}} |\langle T^{\lambda_p, Q}(f \mathbf{1}_Q), \mathbf{1}_{3Q} h \rangle|.$$

The first term on the right we take as the first contribution to our 'sparse' form. We then recursively apply this estimate to the individual terms in the sum over $Q \in \mathcal{B}$. A straightforward recursion produces a collection of sparse cubes $\tilde{\mathcal{S}}$ for which

$$|\langle B_{\lambda_p}f,h\rangle| \lesssim \sum_{Q\in\tilde{S}} \langle f\rangle_{Q,p} \langle h\rangle_{3Q,q} |Q|.$$

Also, each cube Q there is a set $E_Q \subset Q$ with $|E_Q| \ge \frac{1}{100} |Q|$, and the sets $\{E_Q : Q \in \tilde{S}$ are pairwise disjoint. But this last bound does not quite meet the definition of a sparse bound. But we can replace the term $\langle f \rangle_{Q,p}$ by $\langle f \rangle_{3Q,p}$. We then have the sparse bound.
