EXISTENCE AND A PRIORI ESTIMATES OF SOLUTIONS FOR QUASILINEAR SINGULAR ELLIPTIC SYSTEMS WITH VARIABLE EXPONENTS

Abstract. This article sets forth results on the existence, a priori estimates and boundedness of positive solutions of a singular quasilinear systems of elliptic equations involving variable exponents. The approach is based on Schauder's fixed point Theorem. A Moser iteration procedure is also obtained for singular cooperative systems involving variable exponents establishing a priori estimates and boundedness of solutions.

1. INTRODUCTION

In the present paper we focus on the system of quasilinear elliptic equations

(P) \qquad \begin{cases} -\Delta_{p(x)}u = f(u,v) & \text{in } \Omega\\ -\Delta_{q(x)}v = g(u,v) & \text{in } \Omega\\ u,v > 0 & \text{in } \Omega\\ u,v = 0 & \text{on } \partial\Omega, \end{cases}
$$

on a bounded domain Ω in \mathbb{R}^N ($N \geq 2$) with Lipschitz boundary $\partial \Omega$, which exhibits a singularity at zero. Here $\Delta_{p(x)}$ (resp. $\Delta_{q(x)}$) stands for the p(x)-Laplacian (resp. $q(x)$ -Laplacian) differential operator on $W_0^{1,p(x)}(\Omega)$ (resp. $W_0^{1,q(x)}(\Omega)$) with p, q : $\Omega \to [1,\infty),$

1 < p^- \le p^+ < N \quad \text{and} \quad 1 < q^- \le q^+ < N,
$$

which satisfy the log-Hölder continuous condition, i.e., there is constants $C_1, C_2 > 0$ such that

for every $x_i, y_i \in \Omega$ with $|x_i - y_i| < 1/2$, $i = 1, 2$.

Throughout this paper, we denote by

 and q^* the Sobolev critical exponents

and we set

A solution $(u, v) \in W_0^{1, p(x)}(\Omega) \times W_0^{1, q(x)}(\Omega)$ of problem (P) (P) (P) is understood in the weak sense, that is, it satisfies

for all $(\varphi, \psi) \in W_0^{1, p(x)}(\Omega) \times W_0^{1, q(x)}(\Omega)$.

Nonlinear boundary value problems involving $p(x)$ -Laplacian operator are mathematically challenging and important for applications. Their study is stimulated by their applications in physical phenomena related to electrorheological fluids and image restorations, see for instance [\[1,](#page-14-0) [2,](#page-14-1) [6,](#page-14-2) [21\]](#page-15-0). When $p(x) \equiv p$ and $q(x) \equiv q$ are constant functions, $\Delta_{p(x)}$ and $\Delta_{q(x)}$ coincide with the well-known p-Laplacian and q-Laplacian operators. However, it is worth pointing out that $p(x)$ -Laplacian operator possesses more complicated nonlinearity than p-Laplacian since it is inhomogeneous and in general, it has no first eigenvalue, that is, the infimum of the eigenvalues of $p(x)$ -Laplacian equals 0 (see, e.g., [\[14,](#page-14-3) [20\]](#page-15-1)). This point constitute a serious technical difficulty in the study of problem (P) (P) (P) , for which topological methods are difficult to apply. Another serious difficulty encountered in studying system (P) (P) (P) is that the nonlinearities $f(u, v)$ and $g(u, v)$ can exhibit singularities when the variables u and v approach zero. Specifically, we assume that $f, g : (0, +\infty) \times (0, +\infty) \to (0, +\infty)$, are continuous functions satisfying the conditions:

 $(H.f):$

f(s_1, s_2) \le m_1(1 + s_1^{\alpha_1(x)})(1 + s_2^{\beta_1(x)})

 for all $s_1, s_2 > 0$,

with a constant $m_1 > 0$ and continuous functions $\alpha_1, \beta_1 : \overline{\Omega} \longrightarrow \mathbb{R}^*$. $(H,q):$

g(s_1, s_2) \le m_2(1 + s_1^{\alpha_2(x)})(1 + s_2^{\beta_2(x)})
$$
 for all $s_1, s_2 > 0$,

with a constant $m_2 > 0$ and continuous functions $\alpha_2, \beta_2 : \overline{\Omega} \longrightarrow \mathbb{R}^*$.

We explicitly observe that under assumptions (H, f) and (H, q) and depending on the sign of the variable exponents $\alpha_i(\cdot)$ and $\beta_i(\cdot), i = 1, 2$, system ([P](#page-0-0)) presents two types of complementary structures:

 (1.5) $x_2^+, \beta_1^+ < 0$ (competitive structure).

If [\(1.4\)](#page-1-0) holds, we assume

 $\mathbf{H}(f,g)$ ₁:

\sigma := \min\{\inf_{s_1, s_2 > 0} f(s_1, s_2), \inf_{s_1, s_2 > 0} g(s_1, s_2)\} > 0.

This assumption is useful in the subsequent estimates keeping the values of $f(s_1, s_2)$ and $g(s_1, s_2)$ above zero. In the case of competitive system (P) (P) (P) , in addition of (1.5) , we assume

 $H(f,g)_2$: For all constant $M > 0$ it hold

\lim_{s_1 \to 0} \frac{f(s_1, s_2)}{s_1^{p^--1}} = +\infty \text{ for all } s_2 \in (0, M)

and

This type of problem is rare in the literature. Actually, according to our knowledge, the only class of singular problems incorporated in statement (P) (P) (P) patterns the system for $f(u, v) = u^{\alpha_1(x)} v^{\beta_1(x)}$ and $g(u, v) = u^{\alpha_2(x)} v^{\beta_2(x)}$ was studied recently by Alves & Moussaoui [\[3\]](#page-14-4). The authors obtained the existence of solutions through new theorems involving sub and supersolutions for singular systems with variable exponents by dealing with cooperative and competitive structures. However, when the exponent variable functions $p(\cdot), q(\cdot), \alpha_i(\cdot)$ and $\beta_i(\cdot), i = 1, 2$, are reduced to be constants, problem (P) (P) (P) have been thoroughly investigated, we refer to [\[19\]](#page-15-2) for system (P) (P) (P) with cooperative structure, while we quote [\[17,](#page-15-3) [18\]](#page-15-4) for the study of competitive structure in (P) (P) (P) . Furthermore, in the constant exponent context, the singular problem (P) (P) (P) arise in several physical situations such as fluid mechanics, pseudoplastics flow, chemical heterogeneous catalysts, non- Newtonian fluids, biological pattern formation, for more details about this subject, we cite the papers of Fulks & Maybe [\[12\]](#page-14-5), Callegari & Nashman [\[7,](#page-14-6) [8\]](#page-14-7) and the references therein.

Our goal is to establish the existence and regularity of (positive) solutions for problem (P) (P) (P) by processing the cases (1.4) and (1.5) related to the structure of (P) . Our main results are stated as follows.

Theorem 1.1. Let assumptions (H.f), (H.g), $H(f, g)$ ₁ and [\(1.4\)](#page-1-0) hold with

(1.6)
$$
\beta_1(x) \leq \frac{q^*(x)}{p^*(x)} (p^*(x) - 1), \quad \alpha_2(x) \leq \frac{p^*(x)}{q^*(x)} (q^*(x) - 1)
$$

and

(1.7)
$$
\begin{cases} -\frac{1}{N} < \alpha_1^- \leq \alpha_1^+ < 0\\ -\frac{1}{N} < \beta_2^- \leq \beta_2^+ < 0. \end{cases}
$$

Then, problem ([P](#page-0-0)) possesses at least one (positive) solution in $C^1(\overline{\Omega}) \times C^1(\overline{\Omega})$ satisfying

$$

where $d(x) := d(x, \partial \Omega)$ and c_0 is a positive constant.

Theorem 1.2. Under assumptions (H.f), (H.g), $H(f, g)_2$ and [\(1.5\)](#page-1-1) with

(1.9)
$$
\max\{-\frac{1}{N}, -\alpha_1^-\} < \beta_1^- \leq \beta_1^+ < 0 < \alpha_1^- \leq \alpha_1^+ < p^- - 1
$$

and

(1.10)
$$
\max\{-\frac{1}{N}, -\beta_2^-\} < \alpha_2^- \le \alpha_2^+ < 0 < \beta_2^- \le \beta_2^+ < q^- - 1,
$$

problem ([P](#page-0-0)) possesses at least one (positive) solution (u, v) in $C^1(\overline{\Omega}) \times C^1(\overline{\Omega})$ satisfying [\(1.8\)](#page-2-0).

The main technical difficulty consists in the presence of $p(x)$ -Laplacian and $q(x)$ -Laplacian operators in the principle parts of equations in (P) (P) (P) on the one hand and, on the other the presence of singular terms through variable exponents that can occur under hypotheses $(H.f)$ and $(H.g)$. Under cooperative structure [\(1.4\)](#page-1-0), by adapting Moser iterations procedure to problem (P) (P) (P) , together with an adequate truncation, we prove a priori estimates for an arbitrary solution of (P) (P) (P) . In particular, it provides that all solution (u, v) of (P) (P) (P) are bounded in $L^{\infty}(\Omega) \times L^{\infty}(\Omega)$. Taking advantage of this boundedness and applying Schauder's fixed point Theorem we obtain the existence of a solution of problem (P) (P) (P) . To the best of our knowledge, it is for the first time when Moser iterations method is applied for problems with variable exponents.

For system (P) (P) (P) subjected to competitive structure (1.5) , we develop some comparison arguments which provide a priori estimates on solutions of (P) (P) (P) . In turn, these estimates enable us to obtain our main result by applying the Schauder's fixed point theorem. It is worth noting that besides our method is different from that used by Alves & Moussaoui [\[3\]](#page-14-4), our assumptions, precisely $H(f, g)$ ₁, [\(1.9\)](#page-2-1) and [\(1.10\)](#page-2-2), are not satisfied by hypotheses considered there.

We indicate simple examples showing the applicability of Theorems [1.1](#page-2-3) and [1.2.](#page-2-4) Related to system (P) (P) (P) under assumptions above, we can handle singular cooperative systems of the form

\begin{cases}\n-\Delta_{p(x)}u = (u^{\alpha_1(x)} + 1)(v^{\beta_1(x)} + 1) \text{ in } \Omega \\
-\Delta_{q(x)}v = (u^{\alpha_2(x)} + 1)(v^{\beta_2(x)} + 1) \text{ in } \Omega \\
u, v > 0 \text{ in } \Omega \\
u, v = 0 \text{ on } \partial\Omega,\n\end{cases}
$$

and singular competitive systems of type

\begin{cases}\n-\Delta_{p(x)}u = v^{\alpha_1(x)} + v^{\beta_1(x)} \text{ in } \Omega \\
-\Delta_{q(x)}v = u^{\alpha_2(x)} + u^{\beta_2(x)} \text{ in } \Omega \\
u, v > 0 \text{ in } \Omega \\
u, v = 0 \text{ on } \partial\Omega,\n\end{cases}
$$

with variable exponents $\alpha_1, \alpha_2, \beta_1, \beta_1$ as in hypotheses [\(1.6\)](#page-2-5), [\(1.7\)](#page-2-6) and [\(1.9\)](#page-2-1), [\(1.10\)](#page-2-2), respectively.

The rest of this article is organized as follows. Section [2](#page-3-0) deals with a priori estimates and regularity of solutions of cooperative system (P) (P) (P) , whereas Section [3](#page-9-0) presents comparison properties of competitive system (P) (P) (P) . Sections [4](#page-11-0) and [5](#page-13-0) contain the proof of Theorems [1.1](#page-2-3) and [1.2.](#page-2-4)

2. A priori estimates and regularity

Let $L^{p(x)}(\Omega)$ be the generalized Lebesgue space that consists of all measurable real-valued functions u satisfying

\rho_{p(x)}(u) = \int_{\Omega} |u(x)|^{p(x)} dx < +\infty,
$$

endowed with the Luxemburg norm

$$
||u||_{p(x)} = \inf \{ \tau > 0 : \rho_{p(x)}(\frac{u}{\tau}) \le 1 \}.
$$

The variable exponent Sobolev space $W_0^{1,p(\cdot)}(\Omega)$ is defined by

$$
W_0^{1,p(x)}(\Omega) = \{ u \in L^{p(x)}(\Omega) : |\nabla u| \in L^{p(x)}(\Omega) \}.
$$

The norm $||u||_{1,p(x)} = ||\nabla u||_{p(x)}$ makes $W_0^{1,p(x)}(\Omega)$ a Banach space. On the basis of [\(1.2\)](#page-0-1), the following embedding

W_0^{1,p(x)}(\Omega) \hookrightarrow L^{r(x)}(\Omega)
$$

is continuous with $1 < r(x) \le p^*(x)$ (see [\[9,](#page-14-8) Corollary 5.3]).

Lemma 2.1. (i) For any $u \in L^{p(x)}(\Omega)$ we have

||u||_{p(x)}^{p^{-}} \leq \rho_{p(x)}(u) \leq ||u||_{p(x)}^{p^{+}} \quad \text{if} \quad ||u||_{p(x)} > 1,
$$

$$
||u||_{p(x)}^{p^{+}} \leq \rho_{p(x)}(u) \leq ||u||_{p(x)}^{p^{-}} \quad \text{if} \quad ||u||_{p(x)} \leq 1.
$$

(*ii*) For $u \in L^{p(x)}(\Omega) \setminus \{0\}$ we have
(2.2)

||u||_{p(x)} = a \quad \text{if and only if } \rho_{p(x)}(\frac{u}{a}) = 1.
$$

The next result provides a priori estimates for an arbitrary solution of (P) (P) (P) subjected to cooperative structure.

Theorem 2.2. Assume that (1.4) and the growth conditions $(H.f)$ and $(H.g)$ hold with

(2.3)
$$
\begin{cases} \alpha_1^+ < 0 < \beta_1(x) \leq \frac{q^*(x)}{p^*(x)}(p^*(x) - 1) \\ \beta_2^+ < 0 < \alpha_2(x) \leq \frac{p^*(x)}{q^*(x)}(q^*(x) - 1) \end{cases} \text{ in } \Omega.
$$

Then there exist positive constants $C = C(m_1, \beta_1, N, \Omega, p, q)$ and $C' = C'(m_2, \alpha_2, N, \Omega, p, q)$ such that every solution $(u, v) \in W_0^{1,p(x)}(\Omega) \times W_0^{1,q(x)}(\Omega)$ of (P) (P) (P) satisfies the estimate

(2.4) \t\t ||u||_{\infty} \leq C \max(1, \|u\|_{p^*(x)})^{p^+/p^-} (1 + \max(1, \|v\|_{q^*(x)}^{\beta_1^+}))^{\frac{1}{(p^-)^* - p^-}},

(2.5) \t\t ||v||_{\infty} \leq C' \max(1, \|v\|_{q^*(x)})^{q^+/q^-} (1 + \max(1, \|u\|_{p^*(x)}^{\alpha^+})^{\frac{1}{(q^-)^* - q^-}}.
$$

In particular, problem (P) (P) (P) has only bounded solutions.

Proof. Let $\phi : \mathbb{R} \longrightarrow [0, 1]$ be a C^1 cut-off function such that

\phi(s) = \begin{cases} 0 \text{ if } s \leq 0, \\ 1 \text{ if } s \geq 1 \end{cases} \text{ and } \phi'(s) \geq 0 \text{ in } [0, 1].
$$

Given $\delta > 0$, we define $\phi_{\delta}(t) = \phi(\frac{t-1}{\delta})$ for all $t \in \mathbb{R}$. It follows that

(2.6)

\phi_{\delta} \circ z \in W_0^{1,p(x)}(\Omega)
$$
 and $\nabla(\phi_{\delta} \circ z) = (\phi'_{\delta} \circ z) \nabla z$, for $z \in W_0^{1,p(x)}(\Omega)$.

Let $(u, v) \in W_0^{1, p(x)}(\Omega) \times W_0^{1, q(x)}(\Omega)$ be a weak solution of (P) (P) (P) . Acting in the first equation in [\(1.3\)](#page-0-2) with the test function $\varphi = (\phi_{\delta} \circ u)\varphi$ with $\varphi \in W_0^{1,p(x)}(\Omega)$ and $\varphi \geq 0$ in Ω , we obtain

$$
\int_{\Omega} |\nabla u|^{p(x)-2} \nabla u \nabla ((\phi_{\delta} \circ u)\varphi) dx = \int_{\Omega} f(u,v) (\phi_{\delta} \circ u)\varphi dx.
$$

Hence, by [\(3.18\)](#page-10-0), we get

\int_{\Omega} |\nabla u|^{p(x)} (\phi_{\delta}' \circ u) \varphi dx + \int_{\Omega} |\nabla u|^{p(x)-2} \nabla u \nabla \varphi (\phi_{\delta} \circ u) dx = \int_{\Omega} f(u, v) (\phi_{\delta} \circ u) \varphi dx.
$$

Since $\phi_{\delta}' \circ u \ge 0$, it follows that

 $\int_{\Omega} |\nabla u|^{p(x)-2} \nabla u \nabla \varphi \, (\phi_{\delta} \circ u) \, dx \leq \int_{\Omega} f(u,v) (\phi_{\delta} \circ u) \varphi \, dx.$

Letting $\delta \to 0$ we achieve

(2.7)

\int_{\{u>1\}} |\nabla u|^{p(x)-2} \nabla u \nabla \varphi \ dx \leq \int_{\{u>1\}} f(u,v) \varphi \ dx,
$$

for all $\varphi \in W_0^{1,p(x)}(\Omega)$ with $\varphi \geq 0$ in Ω . Repeating the same argument with the second equation in (P) (P) (P) , we get

(2.8)

\int_{\{v>1\}} |\nabla v|^{q(x)-2} \nabla v \nabla \psi \ dx \leq \int_{\{v>1\}} g(u,v) \varphi \ dx,
$$

for all $\psi \in W_0^{1,q(x)}(\Omega)$ with $\psi \geq 0$ in Ω .

Given $M > 0$, define

$$
u_M(x) = \min \{u(x), M\}, \quad v_M(x) = \min \{v(x), M\}.
$$

Observe that $h(s) = s^{k_1 - p^+ + 1}$ is a C^1 function, $h(0) = 0$ and there is a constant $L >$ 0 such that $|h'(s)| \leq L$ for all $0 \leq s \leq M$. By proceeding analogously to the proof of [\[5,](#page-14-9) Proposition XI.5, page 155], it follows that $u_M^{k_1^- p^+ + 1} \in W_0^{1,p(x)}(\Omega) \cap L^\infty(\Omega)$. Similarly we get $v_M^{\overline{k}_1^- q^+ + 1} \in W_0^{1,q(x)}(\Omega) \cap L^{\infty}(\Omega)$.

Inserting $(\varphi, \psi) = (u_M^{k_1^- p^+ + 1}, v_M^{\bar{k}_1^- q^+ + 1})$ in [\(2.7\)](#page-4-0) and [\(2.8\)](#page-4-1), where

(2.9)

\begin{cases} (k_1(x) + 1) p(x) = p^*(x) \\ (\bar{k}_1(x) + 1) q(x) = q^*(x), \end{cases}
$$

one has

(2.10) \qquad \int_{\{u>1\}} |\nabla u|^{p(x)-2} \nabla u \nabla (u_M^{k_1^- p^+ + 1}) \, dx \le \int_{\{u>1\}} f(u,v) u_M^{k_1^- p^+ + 1} \, dx
$$

and

$$
(2.11) \qquad \int_{\{v>1\}} |\nabla v|^{q(x)-2} \nabla v \nabla (v_M^{\bar{k}_1^- q^+ + 1}) \, dx \le \int_{\{v>1\}} g(u,v) v_M^{\bar{k}_1^- q^+ + 1} \, dx,
$$

Step 1. Estimation of the left-hand side in [\(2.10\)](#page-5-0) and [\(2.11\)](#page-5-1)

In what follows denote by $(s-1)^+ := \max\{s, 1\}$ for $s \geq 0$. First, observe that (2.12)

|\nabla u_M|^{p(x)} u_M k_1^{-p(x)} = \frac{1}{(k_1^{-1}+1)^{p(x)}} |\nabla (u_M)^{k_1^{-1}+1} |^{p(x)} \ge \frac{1}{(k_1^{-1}+1)^{p^+}} |\nabla (u_M)^{k_1^{-1}+1} |^{p(x)}.

Then (2.13)

\int_{\{u>1\}} |\nabla u|^{p(x)-2} \nabla u \nabla (u_M^{k_1^- p^+ + 1}) dx = \int_{\{u>1\}} |\nabla u|^{p(x)-2} \nabla u \nabla (u_M)^{k_1^- p^+ + 1} dx
$$

\n= $(k_1^- p^+ + 1) \int_{\{u_M>1\}} |\nabla u_M|^{p(x)} u_M^{k_1^- p^+} dx \ge (k_1^- p^+ + 1) \int_{\{u_M>1\}} |\nabla u_M|^{p(x)} u_M^{k_1^- p(x)} dx$
\n $\ge \frac{k_1^- p^+ + 1}{(k_1^- + 1)^{p^+}} \int_{\{u_M>1\}} |\nabla (u_M^{k_1^- + 1})|^{p(x)} dx.$

On the other hand, using [\(2.2\)](#page-4-2) and through the mean value theorem, there exists $x_0 \in \Omega$ such that

(2.14) \qquad = \int_{\Omega} \left| \frac{((u_M - 1)^+)^{k_1^- + 1}}{\|((u_M - 1)^+)^{k_1^- + 1}\|_{p^*(x)}} \right|^{p^*(x)} \times \left(\frac{\|((u_M - 1)^+)^{k_1^- + 1}\|_{p^*(x)}}{\|(u_M - 1)^+\|_{(k_1^- + 1)p^*(x)}^{k_1^- + 1}} \right)^{p^*(x)}
$$

\n
$$
= \left(\frac{\|((u_M - 1)^+)^{k_1^- + 1}\|_{p^*(x)}}{\|(u_M - 1)^+\|_{(k_1^- + 1)p^*(x)}^{k_1^- + 1}} \right)^{p^*(x)}
$$

which implies

$$
(2.15) \qquad \|((u_M - 1)^+)^{k_1^- + 1} \|_{p^*(x)} = \|(u_M - 1)^+ \|_{(k_1^- + 1)p^*(x)}^{k_1^- + 1}.
$$

Furthermore, from [\(2.2\)](#page-4-2) one has

$$
\int_{\Omega} \left| \frac{\nabla((u_M - 1)^{+})^{k_1^{-}+1}}{\|(u_M - 1)^{+})^{k_1^{-}+1}\|_{1, p(x)}} \right|^{p(x)} dx = 1.
$$

Using the mean value theorem, there exists $x_M \in \Omega$ such that

(2.16)
$$

3. Comparison properties

In this section, we assume that [\(1.9\)](#page-2-1) and [\(1.10\)](#page-2-2) hold. For a fixed $\delta > 0$ small, define \overline{u} and \overline{v} in $C^{1,\gamma}(\overline{\Omega})$, for certain $\gamma \in (0,1)$, as the unique weak solutions of the problems

(3.18) \quad f(\overline{u}, \underline{v}) \le M_1 (1 + \overline{u}^{\alpha_1(x)})(1 + \underline{v}^{\beta_1(x)}) \n\le M_1 (1 + c_4^{\alpha_1(x)} \lambda^{\frac{\alpha_1^+}{p^--1}})(1 + (c_3' d(x))^{\beta_1(x)}) \le \lambda \text{ in } \Omega \setminus \overline{\Omega}_\delta
$$

and

(3.19)
$$
g(\underline{u}, \overline{v}) \le M_2(1 + \underline{u}^{\alpha_2(x)})(1 + \overline{v}^{\beta_2(x)})
$$

$$
\le M_2 \left(1 + (c_3 d(x))^{\alpha_2(x)}\right) \left(1 + (c'_4)^{\beta_2(x)}\lambda^{\frac{\beta_2^+}{q^--1}}\right) \le \lambda \quad \text{in } \Omega \setminus \overline{\Omega}_\delta.
$$

provided that $\lambda > 0$ is large enough. Now we deal with the corresponding estimates on Ω_{δ} . From (H.f), (H.g), [\(3.10\)](#page-10-2), [\(2.13\)](#page-5-4), [\(3.4\)](#page-9-1) and [\(1.3\)](#page-0-2), we get (3.20)

$$
\overline{u}^{\alpha_{1}(x)} f(\overline{u}, \underline{v}) \leq M_{1}(\overline{u}^{\alpha_{1}(x)} + \overline{u}^{2\alpha_{1}(x)})(1 + \underline{v}^{\beta_{1}(x)}) \n\leq M_{1} ((c_{0}d(x)^{\theta_{1}})^{\alpha_{1}(x)} + (c_{0}d(x)^{\theta_{1}})^{2\alpha_{1}(x)}) (1 + (c'_{3}d(x))^{\beta_{1}(x)}) \n\leq M_{1} \max\{(c_{0})^{\alpha_{1}(x)}, (c_{0})^{2\alpha_{1}(x)}\}(d(x)^{\theta_{1}\alpha_{1}(x)} + d(x)^{2\theta_{1}\alpha_{1}(x)}) (1 + (c'_{3}d(x))^{\beta_{1}(x)}) \n\leq C_{1}(d(x)^{\theta_{1}\alpha_{1}^{-}} + d(x)^{2\theta_{1}\alpha_{1}^{-}}) (1 + d(x)^{\beta_{1}^{-}}) \leq \lambda \text{ in } \Omega_{\delta}
$$

and similarly

$$
(3.21) \quad \frac{\overline{v}^{\beta_2(x)}g(\underline{u},\overline{v}) \le M_2(1+\underline{u}^{\alpha_2(x)})(\overline{v}^{\beta_2(x)}+\overline{v}^{2\beta_2(x)})}{\le M_2(1+(c_3d(x))^{\alpha_2(x)})\left((c'_0d(x)^{\theta_2})^{\beta_2(x)}+(c'_0d(x)^{\theta_2})^{2\beta_2(x)}\right) \le \lambda \quad \text{in } \Omega_\delta,
$$

provided that $\lambda > 0$ is sufficiently large. Consequently, [\(3.18\)](#page-10-0), [\(3.19\)](#page-10-7), [\(3.20\)](#page-11-1) and (3.21) allow to infer that (3.12) holds. This ends the proof.

4. Proof of Theorem [1.1](#page-2-3)

For every $z_1, z_2 \in C_0^1(\Omega)$, let us state the auxiliary problem

$$
(P_z) \qquad \begin{cases} -\Delta_{p(x)}u = \tilde{f}(z_1, z_2) & \text{in } \Omega, \\ -\Delta_{q(x)}v = \tilde{g}(z_1, z_2) & \text{in } \Omega, \\ u, v = 0 & \text{on } \partial\Omega, \end{cases}
$$

where

(4.1)
$$
\tilde{f}(z_1, z_2) = f(\tilde{z}_1, \tilde{z}_2) \text{ and } \tilde{g}(z_1, z_2) = g(\tilde{z}_1, \tilde{z}_2),
$$

with

(4.2)
$$
\tilde{z}_i = \min \{ \max\{z_i, c_0 d(x)\}, R \} \text{ for } i = 1, 2.
$$

On account of [\(4.2\)](#page-11-3) it follows that $c_0d(x) \leq \tilde{z}_i \leq R$ for $i = 1, 2$.

The next result establishes an a priori estimate for system (P_z) (P_z) (P_z) . In addition, it shows that solutions (u, v) of problem (P_z) (P_z) (P_z) cannot occur outside the rectangle $[c_0d(x), L_R] \times [c_0d(x), L_R]$, with a constant $L_R > 0$ defined below.

Proposition 4.1. Assume (H.f), (H.g) and [\(1.4\)](#page-1-0) hold. Then all solutions (u, v) of (P_z) (P_z) (P_z) belong to $C^{1,\gamma}(\overline{\Omega}) \times C^{1,\gamma}(\overline{\Omega})$ for some $\gamma \in (0,1)$ and there is a positive constante L_R , depending on R , such that

(4.3)
$$
\|u\|_{C^{1,\gamma}(\overline{\Omega})}, \|v\|_{C^{1,\gamma}(\overline{\Omega})} < L_R.
$$

Moreover, it holds

(4.4)
$$
u(x), v(x) \ge c_0 d(x) \quad in \ \Omega.
$$

[P](#page-11-4)roof. First, we prove the boundedness for solutions of (P_z) in $L^{\infty}(\Omega) \times L^{\infty}(\Omega)$. To this end, we adapt the argument which proves [\[3,](#page-14-4) Lemma 2]. For each $k \in \mathbb{N}$, set

$$
U_{k,R} = \{x \in \Omega : u(x) > kR\} \text{ and } V_{k,R} = \{x \in \Omega : v(x) > kR\},\
$$

where the constant $R > 0$ is given by Proposition [2.1.](#page-8-4) Since $u, v \in L^1(\Omega)$, we have

(4.5)
$$
|U_{k,R}|, |V_{k,R}| \to 0 \text{ as } k \to +\infty.
$$

Using $(u - kR)^+$ and $(v - kR)^+$ as a test function in (P_z) (P_z) (P_z) , we get

(4.6)
$$
\begin{cases} \int_{U_{k,R}} |\nabla u|^p dx = \int_{U_{k,R}} f(\tilde{z}_1, \tilde{z}_2)(u - kR)^+ dx \\ \int_{V_{k,R}} |\nabla v|^q dx = \int_{V_{k,R}} g(\tilde{z}_1, \tilde{z}_2)(v - kR)^+ dx. \end{cases}
$$

By $(H.f)$ and (4.2) observe that

$$
\int_{\Omega} |f(\tilde{z}_1, \tilde{z}_2)|^N dx \le C_1 \int_{\Omega} (1 + \tilde{z}_1^{N\alpha_1(x)})(1 + \tilde{z}_2^{N\beta_1(x)}) dx
$$

\n
$$
\le C_1 (1 + R^{N\beta^+}) \int_{\Omega} (1 + (c_0 d(x))^{N\alpha_1(x)}) dx \le \hat{C}_1 \int_{\Omega} (1 + d(x)^{N\alpha_1^-}) dx.
$$

Since $N\alpha_1^-$ > -1 (see [\(1.7\)](#page-2-6)), [\[16,](#page-15-6) Lemma in page 726] garantees that

$$
\int_{\Omega} d(x)^{N\alpha_1^-} dx < \infty.
$$

Then, it follows that $f(\tilde{z}_1, \tilde{z}_2) \in L^N(\Omega)$ and therefore

(4.7)
$$
\|f(\tilde{z}_1, \tilde{z}_2)\|_{L^N(U_{k,R})} \to 0 \text{ as } k \to +\infty.
$$

Similarly, we obtain

(4.8)
$$
\|g(\tilde{z}_1, \tilde{z}_2)\|_{L^N(V_{k,R})} \to 0 \text{ as } k \to +\infty.
$$

Now, proceeding analogously to the proof of [\[3,](#page-14-4) Lemma 2] provides a constant $k_0 \geq 1$ such that

$$
|u(x)|, |v(x)| \le k_0 R
$$
 a.e in Ω .

Consider now functions w_1 and w_2 defined by

(4.9)
$$
\begin{cases}\n-\Delta w_1 = \tilde{f}(z_1, z_2) & \text{in } \Omega \\
w_1 = 0 & \text{on } \partial\Omega\n\end{cases}\n\text{ and }\n\begin{cases}\n-\Delta w_2 = \tilde{g}(z_1, z_2) & \text{in } \Omega \\
w_2 = 0 & \text{on } \partial\Omega.\n\end{cases}
$$

On account of (4.1) , $(H.f)$, $(H.g)$, (4.2) , (1.4) and (1.7) , one has

(4.10)
$$
\tilde{f}(z_1, z_2) \le C_2 d(x)^{\alpha_1^-}
$$
 and $\tilde{g}(z_1, z_2) \le C'_2 d(x)^{\beta_2^-}$ in Ω ,

for some positive constants C_2 and C_2' . On the basis of [\(1.7\)](#page-2-6) and Thanks to [\[16,](#page-15-6) Lemma in page 726], the right-hand side of problems in [\(4.9\)](#page-12-1) belongs to $H^{-1}(\Omega)$. Consequently, the Minty-Browder theorem (see [\[5,](#page-14-9) Theorem V.15]) implies the existence and uniqueness of w_1 and w_2 in [\(4.9\)](#page-12-1). Moreover, bearing in mind [\(1.7\)](#page-2-6) and [\(4.10\)](#page-12-2), the regularity theory found in [\[15,](#page-14-13) Lemma 3.1] implies that w_1 and w_2 are bounded in $C^{1,\gamma}(\overline{\Omega})$, for certain $\gamma \in (0,1)$.

Thereby, subtracting (4.9) from (P_z) (P_z) (P_z) yields

$$
-div(|\nabla u|^{p(x)-2}\nabla u - \nabla w_1) = 0 \text{ and } -div(|\nabla v|^{q(x)-2}\nabla v - \nabla w_2) = 0,
$$

and the $C^{1,\alpha}$ -boundedness of u and v follows from [\[10,](#page-14-14) Theorem 1.2]. Summarizing, we have obtained that solutions (u, v) of (P_z) (P_z) (P_z) belong to $C^{1,\gamma}(\overline{\Omega}) \times C^{1,\gamma}(\overline{\Omega}),$ for certain $\gamma \in (0,1)$, and there exists a constant $L_R > 0$ such that [\(4.3\)](#page-11-6) holds. Furthermore, a quite similar argument showing the second part of Proposition [2.1](#page-8-4) leads to (4.4) . This completes the proof.

Next we prove the existence result for cooperative system (P) (P) (P) .

Proof of Theorem [1.1.](#page-2-3) Denote by

$$
\mathcal{B}(0, L_R) = \{(u, v) \in C^1(\overline{\Omega}) \times C^1(\overline{\Omega}) : ||u||_{C^1(\overline{\Omega})} + ||v||_{C^1(\overline{\Omega})} < L_R\}
$$

and

$$
\mathcal{O} = \{ (u, v) \in \mathcal{B}(0, L_R) : u(x), v(x) \ge c_0 d(x) \text{ in } \Omega \}.
$$

Let us introduce the operator $\mathcal{P}: \mathcal{O} \to C(\overline{\Omega}) \times C(\overline{\Omega})$ by $\mathcal{P}(z_1, z_2) = (u, v)$, where (u, v) is the solution of problem (P_z) (P_z) (P_z) . Bearing in mind [\(4.10\)](#page-12-2) and [\(1.7\)](#page-2-6), the Minty-Browder theorem together with [\[3,](#page-14-4) Lemma 2] garantee that problem (P_z) (P_z) (P_z) has a unique solution (u, v) in $C^{1,\gamma}(\overline{\Omega}) \times C^{1,\gamma}(\overline{\Omega})$, for certain $\gamma \in (0, 1)$. This ensures the operator P is well defined. Moreover, analysis similar to that in the proof of Theorem 3 in [\[3\]](#page-14-4) imply that P is continuous and compact operator. On the other hand, according to Proposition [4.1,](#page-11-8) it follows that $\mathcal O$ is invariant by $\mathcal P$, that is, $\mathcal{P}(\mathcal{O}) \subset \mathcal{O}$. Therefore we are in a position to apply Schauder's fixed point Theorem to the set O and the map $P : \mathcal{O} \to \mathcal{O}$. This ensures the existence of $(u, v) \in \mathcal{O}$ satisfying $\mathcal{P}(u, v) = (u, v)$, that is, $(u, v) \in C^1(\overline{\Omega}) \times C^1(\overline{\Omega})$ is a solution of problem

$$
\begin{cases}\n-\Delta_{p(x)}u = \tilde{f}(u, v) & \text{in } \Omega, \\
-\Delta_{q(x)}v = \tilde{g}(u, v) & \text{in } \Omega, \\
u, v = 0 & \text{on } \partial\Omega.\n\end{cases}
$$

Finally, thank's to proposition [2.1,](#page-8-4) it turns out that $(u, v) \in C^1(\overline{\Omega}) \times C^1(\overline{\Omega})$ is a (positive) solution of problem (P) (P) (P) .

5. Proof of Theorem [1.2](#page-2-4)

The proof is based on Schauder's fixed point Theorem. Using the functions (u, v) and $(\overline{u}, \overline{v})$ given in [\(3.1\)](#page-9-2), [\(3.2\)](#page-9-3), [\(3.7\)](#page-9-4) and [\(3.8\)](#page-10-1) let introduce the set

$$
\mathcal{K} = \left\{ (y_1, y_2) \in C(\overline{\Omega}) \times C(\overline{\Omega}) : \underline{u} \leq y_1 \leq \overline{u} \text{ and } \underline{v} \leq y_2 \leq \overline{v} \text{ in } \Omega \right\},\
$$

which is closed, bounded and convex in $C(\overline{\Omega}) \times C(\overline{\Omega})$. Then we define the operator $\mathcal{T}: \mathcal{K} \to C(\overline{\Omega}) \times C(\overline{\Omega})$ by $\mathcal{T}(y_1, y_2) = (u, v)$, where (u, v) is required to satisfy

$$
(P_y) \qquad \begin{cases} -\Delta_{p(x)}u = f(y_1, y_2) \text{ in } \Omega \\ -\Delta_{q(x)}v = g(y_1, y_2) \text{ in } \Omega \\ u, v = 0 \text{ on } \partial\Omega. \end{cases}
$$

For $(y_1, y_2) \in \mathcal{K}$, we derive from $(H.f)$, $(H.g)$, (2.13) , (3.4) , (3.5) , and (3.10) the estimates

(5.1)
$$
f(y_1, y_2) \le m_1 (1 + \overline{u}^{\alpha_1(x)}) (1 + \underline{v}^{\beta_1(x)}) \le C_1 d(x)^{\beta_1(x)} \text{ in } \Omega
$$

and

(5.2)
$$
g(y_1, y_2) \le m_2(1 + \underline{u}^{\alpha_2(x)})(1 + \overline{v}^{\beta_2(x)}) \le C_2 d(x)^{\alpha_2(x)} \text{ in } \Omega,
$$

with positive constants C_1 , C_2 . We point out that estimates [\(5.1\)](#page-13-1) and [\(5.2\)](#page-13-2) com-bined with [\(1.9\)](#page-2-1) and [\(1.10\)](#page-2-2) enable us to deduce that $f(y_1, y_2) \in W^{-1,p'(x)}(\Omega)$ and $g(y_1, y_2) \in W^{-1,q'(x)}(\Omega)$. Then the unique solvability of (u, v) in (P_y) (P_y) (P_y) is readily derived from Minty-Browder theorem (see, e.g., [\[5\]](#page-14-9)). Hence, the operator $\mathcal T$ is well defined.

Using the regularity theory up to the boundary (see [\[3,](#page-14-4) Lemma 2]), it follows that $(u, v) \in C^{1,\beta}(\overline{\Omega}) \times C^{1,\beta}(\overline{\Omega})$, with some $\beta \in (0,1)$, and there is a constant $M > 0$ such that $||u||_{C^{1,\beta}(\overline{\Omega})}, ||v||_{C^{1,\beta}(\overline{\Omega})} \leq M$, whenever $(u, v) = \mathcal{T}(y_1, y_2)$ with $(y_1, y_2) \in \mathcal{K}$. Then, analysis similar to that in the proof of [\[3,](#page-14-4) Theorem 3] imply that $\mathcal T$ is continuous and compact operator.

The next step in the proof is to show that $\mathcal{T}(\mathcal{K}) \subset \mathcal{K}$. Let $(y_1, y_2) \in \mathcal{K}$ and denote $(u, v) = \mathcal{T}(y_1, y_2)$. Using the definitions of K and T, on the basis of Proposition [3.1,](#page-10-8) $(H.f)$ and $(H.g)$, it follows that

$$
-\Delta_{p(x)}u(x) = f(y_1(x), y_2(x)) \le f(\overline{u}(x), \underline{v}(x)) \le -\Delta_{p(x)}\overline{u}(x) \text{ in } \Omega,
$$

and similarly

$$
-\Delta_{q(x)}v(x) = g(y_1(x), y_2(x)) \le g(\underline{u}(x), \overline{v}(x)) \le -\Delta_{q(x)}\overline{v}(x) \text{ in } \Omega.
$$

Proceeding in the same way, via Proposition [3.1](#page-10-8) and hypotheses (H, f) , (H, g) , leads to

$$
-\Delta_{p(x)}u(x) = f(y_1(x), y_2(x)) \ge f(\underline{u}, \overline{v}) \ge -\Delta_{p(x)}\underline{u}(x) \text{ in } \Omega,
$$

and similarly

$$
-\Delta_{q(x)}v(x) = g(y_1(x), y_2(x)) \ge g(\overline{u}, \underline{v}) \ge -\Delta_{q(x)}\underline{v}(x) \text{ in } \Omega.
$$

Then from the strict monotonicity of the operators $-\Delta_{p(x)}$ and $-\Delta_{q(x)}$ we get that $(u, v) \in \mathcal{K}$, which establishes that $\mathcal{T}(\mathcal{K}) \subset \mathcal{K}$. Therefore we are in a position to apply Schauder's fixed point Theorem to the set K and the map $\mathcal{T} : \mathcal{K} \to \mathcal{K}$. This ensures the existence of $(u, v) \in \mathcal{K}$ satisfying $(u, v) = \mathcal{T}(u, v)$. Moreover, because the solution $(u, v) \in K$ and $(H.f)$, $(H.g)$, (1.9) and (1.10) are fulfilled, we conclude from [\[3,](#page-14-4) Lemma 2] that $(u, v) \in C^1(\overline{\Omega}) \times C^1(\overline{\Omega})$. This ends the proof.
