Turing instability in a model with two interacting Ising lines: linear stability and non-equilibrium fluctuations

Abstract

This is the second of two articles on the study of a particle system model that exhibits a Turing instability type effect. About the hydrodynamic equations obtained in [\[CSL17\]](#page-26-0), we find conditions under which Turing instability occurs around the null equilibrium solution. In this instability regime: for long times at which the process is of infinitesimal order, we prove that the non-equilibrium fluctuations around the hydrodynamic limit are Gaussian; for times converging to the critical one at which the process is of finite order, we prove that the ± 1 -Fourier modes are uniformly away from zero.

1 Introduction

We continue with the study of the particle system model introduced in [\[CSL17\]](#page-26-0). This model consists of two discrete lines (or toruses) of Ising spins. Each line of spins evolves according to a spin-flip dynamic for which the Gibbs measure associated to a Hamiltonian with ferromagnetic interactions given by macroscopic Kac potentials is reversible. We consider different inverse temperatures β_1 and β_2 in each line, and different potentials ϕ_1 and ϕ_2 with associated ranges of interactions τ_1 and τ_2 . In addition, the first line acts as an external field with intensity λ over the second one, and vice versa with intensity $-\lambda$. In the mentioned article, it is proven the hydrodynamic convergenge of the magnetization fields to the system of PDE's

This system has $\begin{pmatrix} 0 \\ 0 \end{pmatrix}$ 0 \setminus as equilibrium point $(0$ is the function that vanishes everywhere). The main goals of the present article are

- 1. to study linear stability of the hydrodynamic limit around the equilibrium point,
- 2. and to study the fluctuations out of equilibrium of the microscopic system starting with a random perturbation of the equilibrium point.

In the first part, we focus on the study of the Turing instability effect, introduced in [\[Tur52\]](#page-26-1), of the hydrodynamic limit. More precisely, we find conditions on the macroscopic parameters $\{\beta_1, \beta_2, \tau_1, \tau_2, \lambda\}$ under which Turing instability occurs, namely the k-th Fourier mode of the linearized version of system $(1.1-1.2)$ $(1.1-1.2)$ is linearly stable for $k = 0$, and linearly unstable for some other value of the wave number k (linear stability will be defined properly later). Furthermore, conditions are found for which the instability occurs only for $k = \pm 1$, the so called unimodular Turing instablity. This is the content of Theorem [2.4.](#page-3-0)

In the second part, we start the process with a microscopic random perturbation of the macroscopic equilibrium point and prove results for two time scalings:

- 1. at a time that scales as $\log_{10} \gamma^{-\theta}$ — γ^{-1} the number particles, $\theta \in (0, 1)$ —, time at which the process is of infinitesimal order $\gamma^{\frac{1}{2}-\frac{\theta}{2}}$, we prove that, under the proper scaling, the process has Gaussian limiting distribution;
- 2. at a time that converges to the critical time at which the process is of finite order, critical time that scales as $\log \gamma^{-1}$, we prove that the ± 1 -Fourier modes are uniformly away from 0 with probability that goes to 1 as the number of particles goes to ∞ .

These are the contents of Theorems [2.5](#page-4-0) and [2.7.](#page-4-1) The proofs rely on the approximation of the original process by its linearized version by the use of a modified argument that is classical from differential equations and numerical analysis; once this approximation is done, the theorems follow from well known results of convergence of martingales.

2 Definition and statement of the results

We briefly recall the definition of the model introduced in [\[CSL17\]](#page-26-0). Consider the unit (macroscopic) torus T, that we identify with the real interval [0, 1). The microscopic torus Λ_{γ} is defined as $(\gamma^{-1}\mathbb{T}) \cap \mathbb{Z}$, $\gamma^{-1} \in \mathbb{N}$. Elements of Λ_{γ} are denoted by the letters x and y. For every γ , we define a continuous time Markov process $(\sigma_{\gamma}(t))_{t\geq 0} = ((\sigma_{\gamma,1}(t), \sigma_{\gamma,2}(t)))_{t\geq 0}$ with state space $\{-1, 1\}^{\Lambda_{\gamma}} \times \{-1, 1\}^{\Lambda_{\gamma}}$. Unlike [\[CSL17\]](#page-26-0), the initial conditions will not be general here. Instead, we will consider independent centered random spins, namely the family $\{\sigma_{\gamma,i}(0,x):i\in\{1,2\},x\in\Lambda_\gamma\}$ is independent and $\mathbb{P}(\sigma_{\gamma,i}(0,x)=\pm 1)=\frac{1}{2}$ for every $x \in \Lambda_{\gamma}$ and every $i \in \{1,2\}$. In the notation of [\[CSL17\]](#page-26-0), this means $\psi_1 = \psi_2 \equiv 0$. In [CSL17], we considered general Kac kernels; here we consider particular ones. For $i \in \{1, 2\}$, let $\phi_i(r, \tilde{r}) := \sum_{a \in \mathbb{Z}} \tilde{\phi}_i(r, \tilde{r} + a)$, where $\tilde{\phi}_i : \mathbb{R} \times \mathbb{R} \to (0, \infty)$ is the Gaussian kernel with variance $\tau_i > 0$ defined by

(ϕ_i is the periodized version of $\tilde{\phi}_i$). Recall the definition of the discrete convolution:

As before, we have the inverse temperature $\beta_i > 0$ associated to the *i*-th line, and a parameter $\lambda > 0$ that describes the interaction between the two lines. The the spin-flip rates of the generator of our Markov process are given by

R_2(x, \underline{\sigma}_{\gamma}) = \frac{\exp\{-\beta_2 \sigma_{\gamma,2}(x)(\sigma_{\gamma,2} * \phi_2)(x)\}\exp\{\beta_2 \lambda \sigma_{\gamma,2}(x)\sigma_{\gamma,1}(x)\}}{2 \cosh\{\beta_2 (\sigma_{\gamma,2} * \phi_2)(x) - \beta_2 \lambda \sigma_{\gamma,1}(x)\}}.
$$

If, instead of random initial configurations, we consider deterministic ones with vanishing integral against every continuous function, Theorem 2.1 of [\[CSL17\]](#page-26-0) still holds (with the same proof). In particular, if $\eta_{\gamma}(t,x) = \sigma_{\gamma,1}(t,x)\sigma_{\gamma,2}(t,x)$ is the correlation field, the following corollary holds.

Corollary 2.1. Consider a sequence $(\underline{\sigma}_{\gamma}(0))_{\gamma}$ of deterministic initial configurations satisfying $\langle \sigma_{\gamma,i}(0), G \rangle \longrightarrow 0$ for every $G \in C(\mathbb{T}, \mathbb{C})$ and $i \in \{1,2\}$. Then, for every $T > 0$ and $G \in C(\mathbb{T}, \mathbb{C})$, the limits

hold in $\mathbb{P}\text{-}probability.$

Observe that we are taking $\mathbb C$ instead of $\mathbb R$ as the codomain of the test function G. This is because our relevant test functions will be elements of the complex Fourier base $(F^{(k)})_{k\in\mathbb{Z}}$, with $F^{(k)}$ defined as

(Observe that we use a different font for $\mathbf{i} = \sqrt{-1}$). This is an orthonormal basis of $L^2(\mathbb{T}, \mathbb{C})$ with the inner product defined by

(the overline is for the complex conjugate). We mention here that $\hat{\phi}_i^{(k)}$ $\langle k_i^{(k)}:=\langle \phi_i(0,\cdot), F^{(k)}\rangle = e^{-2\pi^2 \tau_i k^2}$ for every $k \in \mathbb{Z}$ and $i \in \{1, 2\}$. If we restrict the domain to $\gamma \Lambda_{\gamma}$, the family $\left\{F^{(k)} : k = 0, \ldots, \gamma^{-1} - 1\right\}$ is an orthonormal basis of $L^2(\gamma\Lambda_{\gamma}, \mathbb{C})$ under the inner product

In particular, for a spin configuration $\sigma_{\gamma} \in \{-1,1\}^{\Lambda_{\gamma}}$, we have

for every $x \in \Lambda_{\gamma}$. See [\[Ter99\]](#page-26-2) for a detailed presentation of discrete Fourier analysis.

2.1 Linear stability of the hydrodynamic equations and Turing instability

In this subsection, we study linear stability of the system of equations [\(1.1-](#page-0-0)[1.2\)](#page-0-1). Using the approximation

we obtain the following linearized version of the hydrodynamic equations:

By taking the k-th Fourier transform —i.e. by applying the transformation $u \mapsto \langle u, F^{(k)} \rangle$ —, and by using that the Fourier transform turns convolutions into products, we obtain the k-th Fourier system

where $\alpha_i := \frac{\beta_i}{[\cosh(\lambda \beta_i)]^2}$. We put a name to the previous matrix:

For every k, the eigenvalues of $A^{(k)}$ are

where $dis^{(k)} := [tr^{(k)}]^{2} - 4 det^{(k)}, \, tr^{(k)} := tr A^{(k)},$ and $det^{(k)} := det A^{(k)}$.

Definition 2.2. We say that the k-th Fourier mode of the hydrodynamic equations is linearly stable if $\max\left\{\Re\left(\mu_1^{(k)}\right)\right\}$ $\binom(k)}{1}, \mathfrak{R}\Big(\mu_2^{(k)}$ $\begin{equation} \begin{pmatrix} \mathbf{R} \ \mathbf{r} \end{pmatrix} \end{equation} \begin{equation} \begin{cases} \mathbf{R} \ \mathbf{r} \end{cases} \begin{equation} \begin{pmatrix} \mathbf{R} \ \mathbf{r} \end{pmatrix} \end{equation} \begin{equation} \begin{cases} \mathbf{R} \ \mathbf{r} \end{cases} \begin{equation} \begin{pmatrix} \mathbf{R} \ \mathbf{r} \end{pmatrix} \end{equation} \begin{equation} \begin{cases} \mathbf{R} \ \mathbf{r} \end{cases} \begin{pmatrix} \mathbf{R} \ \mathbf{r} \end{$ $\left(\begin{matrix} 1 \ 1 \end{matrix} \right), \left(\mathfrak{R} \mu_2^{(k)} \right)$ $\binom{(k)}{2}$ > 0.

Definition 2.3 (Turing instability).

We say that Turing instability occurs if (i) the hydrodynamic equations are linearly stable for $k = 0$, and (ii) are linearly unstable for some other k .

,

We say that unimodular Turing instability occurs if the hydrodynamic equations are linearly unstable for $k = \pm 1$, and linearly stable for $k \neq \pm 1$ —i.e. if the Turing instability occurs and if (ii) holds only for $k = \pm 1$.

From now on, we suppose $\beta_1 \geq \beta_2$. This does not take away generality while analyzing linear stability. Indeed, $\text{tr}^{(k)}$ and $\text{det}^{(k)}$ remain invariant if we switch the role of the pairs (β_1, ϕ_1) and (β_2, ϕ_2) , so the eigenvalues do not change either. Observe also that $A^{(k)} = A^{(-k)}$ for every k.

Theorem 2.4.

(i) Turing instability can only occur in the presence of one of the following situations:

 $\alpha_2 < 1 < \alpha_1$ and $\tau_1 < \tau_2$ or $\alpha_1 < 1 < \alpha_2$ and $\tau_2 < \tau_1$.

- (ii) For $\beta_1 > 1$, $\beta_2 < 1$ and $\beta_1 + \beta_2 < 2$, we can chose values of λ , τ_1 and τ_2 such that Turing instability occurs.
- (iii) Suppose the hypotheses of the previous item hold and suppose in addition that β_2 is sufficiently close to 1. Then the parameters λ , τ_1 and τ_2 can be chosen in such a way that unimodular Turing instability occurs.

Observe that, in item (i), as α_i is not monotone as a function of β_i , assumption $\beta_1 \geq \beta_2$ does not guarantee $\alpha_1 \geq \alpha_2$.

2.2 Instability at the microscopic level: fluctuations out of equilibrium

For $k \in \mathbb{Z}$ and $i \in \{1,2\}$, let $X_{\gamma,i}^{(k)}(t) := \langle \sigma_{\gamma,i}(t), F^{(k)} \rangle_{\gamma} = \gamma \sum_{x} \sigma_{\gamma,i}(t,x) e^{-2\pi i k \gamma x}$, and let $\underline{X}^{(k)}_{\gamma}(t)\mathrel{\mathop:}=$ $\sqrt{ }$ $\overline{1}$ $X_{\gamma,1}^{(k)}$ $\gamma,1^{(\kappa)}(t)$ $X_{\gamma,2}^{(k)}$ $\gamma,2^{(\kappa)}(t)$ \setminus . Our object of study will be the sequence of discrete Fourier modes, namely the stochastic element $\left(\underline{X}_{\gamma}^{(k)}(t)\right)$ We will stand over hypotheses $(3.108-3.109)$ $(3.108-3.109)$ for $k \neq \pm 1$, and (3.110) for $k = \pm 1$. Observe that they are stronger that the unimodular instability obtained in item *(iii)* of Theorem [2.4.](#page-3-0) In particular, these hypotheses imply that $\mu_2^{(\pm 1)} < 0 < \mu_1^{(\pm 1)}$, so \mathbb{C}^2 is a direct sum of their associated eigenvectors. From now on, we will call $\mu = \mu_1^{(\pm 1)}$ the unique positive eigenvalues. For $\underline{z} \in \mathbb{C}^2$, let

be the unique decomposition in the mentioned eigenspaces (for $i \in \{1, 2\}$, $Pr_i(\underline{z})$ is an eigenvector associated to $\mu_i^{(\pm 1)}$).

The following two results are about the fluctuations of the process around the equilibrium solution (0,0) for a time that goes to ∞ as $\gamma \to 0$ (here 0 denotes the null function). In the first result, at a time at which the process is still infinitesimal, we prove that the fluctuations are Gaussian; in the second one, at a time that approaches the time at which the process is of order one, we prove that the ± 1 -Fourier modes are away from $(0, 0)$. Let us motivate the choice of the involved times. At time $t = 0$, the process is of order $\gamma^{\frac{1}{2}}$. As $\mu = \mu_1^{(1)} = \mu_1^{(-1)}$ are the only positive eigenvalues, the leading terms will be the ones associated to the \pm 1-Fourier modes. As these modes increase exponentially, the order of the process at time $t > 0$ is $\gamma^{\frac{1}{2}} e^{\mu t}$. For a parameter $\theta \in [0, 1]$, let t_{θ} be the time at which the process is of order $\gamma^{\frac{1}{2}-\frac{\theta}{2}}$. In this way, the order of the process is increasing in θ , it is of order $\gamma^{\frac{1}{2}}$ at $\theta = 0$, and of order 1 at $\theta = 1$. From identity $\gamma^{\frac{1}{2}} e^{\mu t_{\theta}} = \gamma^{\frac{1}{2} - \frac{\theta}{2}}$, we get $t_{\theta} = \frac{1}{2\mu}$ $\frac{1}{2\mu}\log\gamma^{-\theta}.$

Theorem 2.5. Let $\theta \in (0,1)$. For $k \neq \pm 1$, $\gamma^{\frac{\theta}{2}-\frac{1}{2}} \underline{X}_{\gamma}^{(k)}(t_{\theta})$ converges in distribution to the δ -measure concentrated in $\begin{pmatrix} 0 \\ 0 \end{pmatrix}$ θ \setminus . For $k = \pm 1$, $\gamma^{\frac{\theta}{2} - \frac{1}{2}} \underline{X}^{(k)}_{\gamma}(t_{\theta})$ converges in distribution to

where \underline{U} and \underline{V} are random elements of \mathbb{C}^2 defined as

with $\{U_1^{\mathfrak{R}}$ $\{10^3, U_1^3, U_2^3, U_2^3, V_1^3, V_1^3, V_2^3, V_2^3\}$ an independent family of centered Gaussian random variables with variances

Observe that the limiting distribution in the previous result does not depend on θ .

The next corollary clarifies the notion of pattern formation: the limiting distribution at a microscopic scale is a periodic non-homogeneous function with uniform phase and random amplitude.

Corollary 2.6. Let $G \in C^{\infty}(\mathbb{T}, \mathbb{R})$. Then, for $i \in \{1, 2\}$, $\gamma^{\frac{\theta}{2}-\frac{1}{2}} \langle \sigma_{\gamma,i}(t_{\theta}), G \rangle$ converges in distribution, as $\gamma \to 0$, to $\langle \sqrt{A_i} \sin(2\pi \cdot + \Phi_i), G \rangle$, where A_i and Φ_i respectivelly have gamma and $[0, 2\pi)$ -uniform distributions.

The critical time is defined as $t_c := t_1 = \frac{1}{2a}$ $\frac{1}{2\mu}$ log γ^{-1} . We define the time-rescaled process $\underline{Y}_{\gamma}(\theta) := \underline{X}_{\gamma}(t_c \theta)$. The previous result is then describing the limiting distribution of $\gamma^{\frac{\theta}{2} - \frac{1}{2}} \underline{Y}_{\gamma}(\theta)$ for $\theta \in (0,1)$. Unfortunately, we are not able to give information about the fluctuations at the critical time. Nevertheless, in the next theorem, we are able to give information about the distribution of the ± 1 -Fourier modes for a time that is approaching t_c or, in the rescaled process \underline{Y}_{γ} , that is approaching $\theta = 1$.

Theorem 2.7. Let $T_{\delta} := \frac{1}{2\mu}$ $\frac{1}{2\mu} \log \delta^{-1}$. Then, for $k = \pm 1$,

\lim_{\delta \to 0} \liminf_{\gamma \to 0} \mathbb{P}\left(\left\|\underline{Y}_{\gamma}^{(k)}\left(1 - \frac{T_{\delta}}{t_c}\right)\right\| > \delta\right) = 1. \tag{2.11}

From this theorem, we deduce that

where $\text{Err}(\delta)$ is a error that vanishes as δ converges to 0. In other words, with high probability, pattern formation occurs at a time which converges to the critical one in the sense that the ± 1 -Fourier modes are

away from $\begin{pmatrix} 0 \\ 0 \end{pmatrix}$ 0 \setminus uniformly in γ .

3 Proofs

During the proofs, we work with many constants, about which it is convenient to clarify that, unless explicitly mentioned, they depend only on the macroscopic parameters $\{\beta_1, \beta_2, \tau_1, \tau_2, \lambda\}$ and on universal notions. They will never depend on, for instance, $k \in \mathbb{Z}$ or γ .

3.1 Proof of theorem [2.5](#page-4-0)

We start by establishing the decomposition

For this purpose, we need a brief analysis of the function $f_{\gamma}-g_{\gamma}$ in $[0,\infty)$. It is easy to prove that, for $D > C_3$ and γ sufficiently small, $f_{\gamma} - g_{\gamma}$ has a unique root, before which it is negative and after which it is positive. Since

Proof of lemma [3.2.](#page-8-2) We will analyse just the first component of the vector $\underline{E}^{(k)}_{\gamma}(t)$ as the analysis of the second one is analogous. We first prove that there exists a constant C_1 such that

In this step, we study the convergence in distribution of $\gamma^{\frac{\theta}{2}-\frac{1}{2}}\tilde{X}_{\gamma}^{(k)}$ $\gamma^{(k)}(t_{\theta})$. Actually, the proof of this convergence does not make use of the fact that $\theta < 1$, so it works for every positive θ . By Duhamel's formula [\(3.16\)](#page-7-3), this is equivalent to studying the limit of

The case $k = \pm 1$ is more delicate. We only do the case $k = 1$ as the case $k = -1$ is analogous. During this proof, we omit writing the superscript (1) when it does not create confusions. Using decomposition (2.5) , we can write

- (a) As $\sigma_{\gamma,1}(0)$ and $\sigma_{\gamma,2}(0)$ are independent for every γ , we can conclude if we prove that, for $i \in \{1,2\}$, $\gamma^{-\frac{1}{2}} X_{\gamma,i}(0)$ weakly converges to $U_i^{\mathfrak{R}} + \mathrm{i} U_i^{\mathfrak{I}}$ ³. Let $F_{\Re}(r) := \cos(2\pi r)$ and $F_3(r) := \sin(2\pi r)$ respectively be the real and imaginary parts of $F^{(1)}$. We prove it only for $i = 1$ as the case $i = 2$ is analogous. This goal is equivalent to the convergence of the random \mathbb{R}^2 -element $(\langle \sigma_{\gamma,1}, F_{\Re} \rangle, \langle \sigma_{\gamma,1}, F_{\Im} \rangle)$ to $(U_1^{\mathfrak{R}}$ \mathbb{R}^3 , $U_1^{\mathfrak{I}}$). - (b) We give an explicit construction of the probability space $(\Omega, \mathcal{F}, \mathbb{P})$. It will we the product of two probability spaces $(\Omega_1, \mathcal{F}_1, \mathbb{P}_1)$ and $(\Omega_2, \mathcal{F}_2, \mathbb{P}_2)$, the first one for the initial distribution and the second one for the Markovian evolution. For the first one, we choose $\Omega_1 := \{-1,1\}^{\mathbb{N}} \times \{-1,1\}^{\mathbb{N}}$ with the product σ -algebra and the Bernoulli probability with parameter $p = \frac{1}{2}$. The second one can be any one for which the trajectories are *càdlàg* for every $\omega_2 \in \Omega_2$ (not only almost every): for instance, we can chose Ω_2 to be the set of subsets of \mathbb{R}^2 without limit points, \mathbb{P}_2 to be the Poisson probability with intensity 1 as in [\[MR96\]](#page-26-3), and to construct the Markov process as in [Bré99]. Fix ω_1 such that $\langle \sigma_{\gamma,i}[\omega_1], G \rangle \longrightarrow 0$ (this occurs with \mathbb{P}_1 -probability 1). For simplicity of notation, from now on, the dependence on ω_1 will be ommited. \left|\gamma^{\frac{\theta}{2}-\frac{1}{2}}\langle\sigma_{\gamma,i}(t_{\theta}),G\rangle-\left(\hat{G}(1)\gamma^{\frac{\theta}{2}-\frac{1}{2}}X^{(1)}_{\gamma,i}(t_{\theta})+\hat{G}(-1)\gamma^{\frac{\theta}{2}-\frac{1}{2}}X^{(-1)}_{\gamma,i}(t_{\theta})\right)\right|
$$
\n(3.103)

$$
\leq \left| \gamma^{\frac{\theta}{2} - \frac{1}{2}} \langle \sigma_{\gamma, i}(t_{\theta}), G \rangle - \gamma^{\frac{\theta}{2} - \frac{1}{2}} \left\langle \sigma_{\gamma, 1}(t_{\theta}), \sum_{|k| \leq \gamma^{-\frac{1}{8}(1-\theta)}} \hat{G}(k) F^{(k)} \right\rangle \right| \tag{3.104}
$$

$$
+\left|\gamma^{\frac{\theta}{2}-\frac{1}{2}}\left\langle \sigma_{\gamma,i}(t_{\theta}),\sum_{|k|\leq \gamma^{-\frac{1}{8}(1-\theta)}}\hat{G}(k)F^{(k)}\right\rangle - \left(\hat{G}(1)\gamma^{\frac{\theta}{2}-\frac{1}{2}}X^{(1)}_{\gamma,i}(t_{\theta}) + \hat{G}(-1)\gamma^{\frac{\theta}{2}-\frac{1}{2}}X^{(-1)}_{\gamma,i}(t_{\theta})\right)\right| \quad (3.105)
$$

$$
= \gamma^{\frac{\theta}{2} - \frac{1}{2}} \left| \left\langle \sigma_{\gamma,i}(t_{\theta}), \sum_{|k| > \gamma^{-\frac{1}{8}(1-\theta)}} \hat{G}(k) F^{(k)} \right\rangle \right| + \gamma^{\frac{\theta}{2} - \frac{1}{2}} \sum_{\substack{|k| \le \gamma^{-\frac{1}{8}(1-\theta)} \\ k \neq \pm 1}} \left| \hat{G}(k) \right| \left| X_{\gamma,i}^{(k)}(t_{\theta}) \right|.

The first addend in the last expression vanishes because, since G is C^{∞} , it satisfies $\sum_{k\in\mathbb{Z}}$ $\begin{array}{c} \begin{array}{c} \begin{array}{c} \end{array}\\ \begin{array}{c} \end{array} \end{array} \end{array}$ $\hat{G}(k)$ | $|k|$ ⁿ < ∞ for every $n \in \mathbb{N}$; the second one, as a consequence of Proposition [3.1.](#page-7-4)

To prove the second item, observe that, by decomposing

\n
$$
= 2\Re\left(\hat{G}(1)\right)\gamma^{\frac{\theta}{2}-\frac{1}{2}}\Re\left(X_{\gamma,i}^{(1)}(t_{\theta})\right) + 2\Im\left(\hat{G}(1)\right)\gamma^{\frac{\theta}{2}-\frac{1}{2}}\Im\left(X_{\gamma,i}^{(1)}(t_{\theta})\right).
$$
\n(3.107)

If we call Z_i the limiting distribution of $\gamma^{\frac{\theta}{2}-\frac{1}{2}}X_{\gamma,i}^{(1)}(t_\theta)$ given in Theorem [2.5,](#page-4-0) last expression converges in distribution to $\langle 2[Z_i]_{\Re} \cos(2\pi \cdot) + 2[Z_i]_{\Im} \sin(2\pi \cdot), G \rangle = \langle 2|Z_i| \cos(2\pi \cdot + \Phi_1), G \rangle$, where $\Phi_i = -\arctan \frac{[Z_i]_{\Im}}{[Z_i]_{\Re}}$. In the previous identity, we used that $c_1 \cos \xi + c_2 \sin \xi = \sqrt{c_1^2 + c_2^2} \cos \left(\zeta - \arctan \frac{c_2}{c_1}\right)$. The fact that Φ_i is uniform follows from the rotational invariance of the model. We can conclude from the fact that the square of the euclidean norm of a Gaussian vector has gamma distribution.

3.4 Proof of theorem [2.4](#page-3-0)

Conditions $\mu_1^{(k)} + \mu_2^{(k)} = \text{tr}^{(k)} < 0$ and $\mu_1^{(k)}\mu_2^{(k)} = \text{det}^{(k)} > 0$ are necessary and sufficient for linear stability of the k-th Fourier mode. This is obvious if the eigenvalues are real; if they have nonzero imaginary parts, the equivalence follows from identities $tr^{(k)} = 2\Re\left(\mu_1^{(k)}\right)$ $\binom{k}{1}$ and $\det^{(k)} = \mu_1^{(k)}$ $\begin{bmatrix} k \\ 1 \end{bmatrix}$ 2 (as $A^{(k)}$ is real for every k , complex eigenvalues come in conjugate pairs). In our case, these conditions read

$$
\alpha_1 e^{-\tilde{\tau}_1 k^2} + \alpha_2 e^{-\tilde{\tau}_2 k^2} < 2 \tag{3.108}
$$

and

$$
\left(\alpha_1 e^{-\tilde{\tau}_1 k^2} - 1\right) \left(1 - \alpha_2 e^{-\tilde{\tau}_2 k^2}\right) < \tanh(\lambda \beta_1) \tanh(\lambda \beta_2). \tag{3.109}
$$

Also condition

$$
\det^{(k)} < 0 \iff \left(\alpha_1 e^{-\tilde{\tau}_1 k^2} - 1\right) \left(1 - \alpha_2 e^{-\tilde{\tau}_2 k^2}\right) > \tanh(\lambda \beta_1) \tanh(\lambda \beta_2) \tag{3.110}
$$

is a sufficient condition for linear instability of the k-th Fourier mode (in particular, it implies that the eigenvalues are real). Necessary and sufficient conditions for Turing instability are conditions [\(3.108\)](#page-19-0) and (3.109) for $k = 0$ and condition (3.110) for some $k \neq 0$. As the sufficiency is obvious, we only prove the necessity. Suppose then Turing instability occurs. Conditions [\(3.108\)](#page-19-0) and [\(3.109\)](#page-19-1) for $k = 0$ follow immediately. Let $k_0 \neq 0$ be one of the values where we have linear instability: $\Re(\mu_1^{(k_0)}$ $\binom{(k_0)}{1}$ > 0. Condition (3.108) for $k = 0$ implies the same condition for any k and, in particular, for k_0 : $\mathfrak{R} \big(\mu_1^{(k_0)}$ $\binom{(k_0)}{1}+\mathfrak{R}\Big(\mu_2^{(k_0)}\Big)$ $\binom{(k_0)}{2}$ = tr^(k₀) < 0. Then $\Re\left(\mu_2^{(k_0)}\right)$ $\binom{(k_0)}{2} < 0$ so $\mu_1^{(k_0)}$ $_{1}^{(k_{0})}$ and $\mu_{2}^{(k_{0})}$ $a_2^{(k_0)}$ are real (their real parts are different so they are not pair conjugate), giving (3.110) for k_0 .

(i) Assume Turing instability occurs. Suppose $\alpha_1 \ge \alpha_2$. Condition [\(3.108\)](#page-19-0) for $k = 0$ implies $\alpha_2 < 1$. If $\alpha_1 \leq 1$, then $\left(\alpha_1 e^{-\tilde{\tau}_1 k^2} - 1\right) \left(1 - \alpha_2 e^{-\tilde{\tau}_2 k^2}\right) < 0$ for every k, so condition [\(3.110\)](#page-19-2) cannot occur for any k; then $\alpha_1 > 1$. Finally, suppose $\tau_2 \leq \tau_1$. Think k as a real variable and define $f(k) := \left(\alpha_1 e^{-\tilde{\tau}_1 k^2} - 1\right) \left(1 - \alpha_2 e^{-\tilde{\tau}_2 k^2}\right)$. We are done if we prove that $f(k) \le f(0)$ for every k because, in this case, conditions (3.110) cannot occur for any k. As f is symmetric, it is enough to prove that it is decreasing for $k > 0$. Condition $f'(k) \leq 0$ is equivalent to

$$
\tilde{\tau}_1 + \tilde{\tau}_2 \le \frac{\tilde{\tau}_1 e^{\tilde{\tau}_2 k^2}}{\alpha_2} + \frac{\tilde{\tau}_2 e^{\tilde{\tau}_1 k^2}}{\alpha_1}.\tag{3.111}
$$

Since the right-hand side of [\(3.111\)](#page-19-3) is increasing and the left-hand side is constant, the later condition holds if and only if

$$
\tilde{\tau}_1 + \tilde{\tau}_2 \le \frac{\tilde{\tau}_1}{\alpha_2} + \frac{\tilde{\tau}_2}{\alpha_1},\tag{3.112}
$$

inequality that follows from ous assumptions. The case $\alpha_1 < \alpha_2$ is proved in a similar way.

(ii) We will prove something stronger: [\(3.108\)](#page-19-0) and [\(3.109\)](#page-19-1) for $k = 0$ and [\(3.110\)](#page-19-2) for $k = 1$. As $\alpha_i < \beta_i$, condition [\(3.108\)](#page-19-0) for $k = 0$ follows from the hypothesis $\beta_1 + \beta_2 \leq 2$.

Let $g(\lambda) = (\alpha_1 - 1)(1 - \alpha_2)$ with the domain extended also to $\lambda = 0$. As $\beta_2 < 1 < \beta_1$, $g(0) = (\beta_1 - 1)(1 - \beta_2) > 0$. For $\lambda > 0$, $g'(\lambda) \le 0$ if and only if

$$
\frac{(\alpha_1 - 1)\alpha_2}{\alpha_1(1 - \alpha_2)} \le \frac{\beta_1}{\beta_2} \frac{\tanh(\lambda \beta_1)}{\tanh(\lambda \beta_2)}.
$$

As $\beta_1 > \beta_2$, the right-hand side is strictly larger than 1, so the negativity of the derivative follows if the left-hand side is smaller than 1 or, equivalently, if

$$
2 \leq \frac{[\cosh(\lambda \beta_1)]^2}{\beta_1} + \frac{[\cosh(\lambda \beta_2)]^2}{\beta_2}.
$$

As the hyperbolic cosine is larger than 1, the later inequality follows from inequality $2 \leq \frac{1}{\beta}$ $\frac{1}{\beta_1} + \frac{1}{\beta_2}$ $\frac{1}{\beta_2}$ that follows form inequality $\beta_1 + \beta_2 \leq 2$. Once we know the function $(\alpha_1 - 1)(1 - \alpha_2)$ is decreasing (and using that it is strictly positive at $\lambda = 0$), we can define the parameter $\lambda^* = \lambda^*(\beta_1, \beta_2)$ as the unique positive solution of identity

$$
(\alpha_1 - 1)(1 - \alpha_2) = \tanh(\beta_1 \lambda) \tanh(\beta_2 \lambda).
$$

Figure 1: The parameter λ^* .

Let $\alpha_i^* = \alpha_i|_{\lambda = \lambda^*}$. Think k as a continuous variable and let $f^*(k) = \left(\alpha_1^* e^{-\tilde{\tau}_1 k^2} - 1\right) \left(1 - \alpha_2^* e^{-\tilde{\tau}_2 k^2}\right)$. As f^* is symmetric, we only need to analyze the case $k > 0$. Condition $f^{*'}(k) > 0$ is equivalent to

$$
\frac{\tilde{\tau}_1 e^{\tilde{\tau}_2 k^2}}{\alpha_2^*} + \frac{\tilde{\tau}_2 e^{\tilde{\tau}_1 k^2}}{\alpha_1^*} < \tilde{\tau}_1 + \tilde{\tau}_2. \tag{3.113}
$$

We will ask for f^* to be strictly increasing for $0 < k \leq 1$. As the functions $e^{\tilde{\tau}_1 k^2}$ and $e^{\tilde{\tau}_2 k^2}$ are increasing in k , and taking into consideration (3.113) , a sufficient condition for this is

$$
\frac{\tilde\tau_1e^{\tilde\tau_2}}{\alpha_2^*}+\frac{\tilde\tau_2e^{\tilde\tau_1}}{\alpha_1^*}<\tilde\tau_1+\tilde\tau_2
$$

or, equivalently,

$$
\frac{(\alpha_2^*)^{-1}e^{\tilde{\tau}_2} - 1}{\tilde{\tau}_2} < \frac{1 - (\alpha_1^*)^{-1}e^{\tilde{\tau}_1}}{\tilde{\tau}_1}.\tag{3.114}
$$

Chose τ_1 and τ_2 in order this inequality holds (this is always possible as the right-hand side goes to infinity as $\tau_1 \downarrow 0$. Under these assumptions, we have

$$
f^*(0) = (\alpha_1^* - 1)(1 - \alpha_2^*) = \tanh(\beta_1 \lambda^*) \tanh(\beta_2 \lambda^*)
$$

$$
< f^*(1) = (\alpha_1^* e^{-\tilde{\tau}_1} - 1)(1 - \alpha_2^* e^{-\tilde{\tau}_2}).
$$
 (3.115)

By continuity, we can conclude after choosing $\lambda > \lambda^*$ as a perturbation of λ^* .

(iii) In the previous item, conditions $\beta_2 < 1 < \beta_1$ and $\beta_1 + \beta_2 < 2$ were used only for the good definition of λ^* . Observe that if β_2 is close to 1 also β_1 is in the sense that $\beta_2 > 1 - \delta$ implies $\beta_1 < 1 + \delta$. As $\alpha_2 < 1$, $(\alpha_1 - 1)(1 - \alpha_2)$ vanishes only if $\alpha_1 - 1$ does; let λ_0 be the unique value where it occurs (it is unique because α_1 is decreasing in λ). As λ_0 vanishes as β_2 goes to 1 (because also β_1 goes to 1), and as domination $\lambda^* \leq \lambda_0$ holds, we conclude λ^* also vanishes in this case.

Figure 2: The grey region is where we can guarantee unimodular Turing instability.

The proof is similar than the one of the previous item. In this case, we will get the stronger property $f^*(k) < f^*(0) = \tanh(\lambda \beta_1) \tanh(\lambda \beta_2) < f^*(1)$ for every $k \ge 2$. For $k > 0$, $f^{*\prime}(k) = 0$ if and only if

$$
\frac{\tilde{\tau}_1 e^{\tilde{\tau}_2 k^2}}{\alpha_2^*} + \frac{\tilde{\tau}_2 e^{\tilde{\tau}_1 k^2}}{\alpha_1^*} = \tilde{\tau}_1 + \tilde{\tau}_2.
$$

As the left-hand side is increasing, this can occur at most in one value of $k > 0$. As $f^*(0) > 0$ and $f^*(k) \longrightarrow -1, f^*$ has only one positive root \hat{k} . Then sufficient conditions for unimodular Turing instability are $f^{*'}(k) > 0$ for $0 < k \le 1$ and $\hat{k} < 2$.

Figure 3: The function f^* .

Recall the first one follows from condition [\(3.114\)](#page-20-1). For the second one, observe that, as $1 - \alpha_2^* e^{-\tilde{\tau}_2 k^2}$ never vanishes, $f^*(k) = 0$ if and only if $\alpha_2^* e^{-\tilde{\tau}_2 k^2} - 1 = 0$ or, equivalently,

$$
\tilde{\tau}_1 > \frac{\log \alpha_1^*}{4}.\tag{3.116}
$$

We are done if we see that conditions (3.114) and (3.116) can be simultaneously satisfied. Choose $\tilde{\tau}_1 = \frac{\log \alpha_1^*}{3}$ so condition [\(3.116\)](#page-21-0) is automatically fulfilled. Replacing in the right-hand side of [\(3.114\)](#page-20-1), we get

$$
3\frac{1-(\alpha_1^*)^{-2/3}}{\log \alpha_1^*},
$$

that converges to 2 as $\alpha_1^* \downarrow 1$. As $\alpha_1^* < \beta_1$, it is enough to take β_2 close enough to 1 (and then also β_1) close to 1) for the later quantity to be larger than say $2 - \frac{1}{2}$ $rac{1}{2}$.

To analyze the left-hand side of [\(3.114\)](#page-20-1), we observe that the derivative with respect to $\tilde{\tau}_2$ vanishes at the unique positive solution of

$$
\alpha_2^* = e^{\tilde{\tau}_2} (1 - \tilde{\tau}_2),
$$

solution that we call \hat{c}_2 . As the right-hand side of this expression is 1 at $\tilde{\tau}_2 = 0$, and as it is decreasing, $\hat{\tilde{c}}_2$ tends to zero as $\alpha_2^* \uparrow 1$. As $\hat{\tilde{c}}_2$ satisfies

$$
(\alpha_2^*)^{-1}e^{\hat{\tilde{c}}_2} - 1 = (\alpha_2^*)^{-1}\hat{\tilde{c}}_2e^{\hat{\tilde{c}}_2},
$$

we can replace in the left-hand side of [\(3.114\)](#page-20-1) and obtain that the value of the minimum is $(\alpha_2^*)^{-1}e^{\hat{c}_2}$, that tends to 1 as $\alpha_2^* \uparrow 1$ $(\alpha_2^*$ goes to one because, as mentioned before, λ^* vanishes). We can conclude after taking $\tilde{\tau}_2 = \hat{c}_2$ and $\lambda > \lambda^*$ a perturbation of λ^* .

Lemma 4.1. There exists $C = C(MP)$ such that

Proof of Lemma [4.1.](#page-22-0) We first analyze the case $k = 1$ (the case $k = -1$ is the same as $A^{(1)} = A^{(-1)}$). Let $S^{(1)}$ be the matrix with columns $v_1^{(1)}$ $_1^{(1)}$ and $_2^{(1)}$ $2^{(1)}$. We have

$$
\left\| e^{tA^{(k)}} \right\| \le \left\| S^{(1)} \right\| \left\| \left(\begin{array}{cc} e^{t\mu_1^{(k)}} & 0 \\ 0 & e^{t\mu_2^{(k)}} \end{array} \right) \right\| \left\| \left(S^{(1)} \right)^{-1} \right\| = \left\| S^{(1)} \right\| \left\| \left(S^{(1)} \right)^{-1} \right\| e^{t\mu} . \tag{4.3}
$$

The case $k \neq \pm 1$ will be decomposed in two sub-cases. There exists $C_1 = C_1(MP)$ such that $\begin{array}{c} \begin{array}{c} \begin{array}{c} \end{array}\\ \begin{array}{c} \end{array} \end{array} \end{array}$ $\text{dis}^{(k)}\Big| \geq 2\tanh(\lambda\beta_1)\tanh(\lambda\beta_2)$ for every k such that $|k| \geq C_1$.

We first analyze the sub-case $|k| \geq C_1$. In this case, the matrix is diagonalizable; the difference with the case $k = \pm 1$ is that we have to control coefficients in the variable k. Let $S^{(k)}$ be the matrix with columns $v_1^{(k)}$ $\binom{k}{1}$ and $\frac{v^{(k)}_2}{2}$ $2^{(\kappa)}$. We have

$$
\left\| e^{tA^{(k)}} \right\| \le \left\| S^{(k)} \right\| \left\| \left(\begin{array}{cc} e^{t\mu_1^{(k)}} & 0 \\ 0 & e^{t\mu_2^{(k)}} \end{array} \right) \right\| \left\| \left(S^{(k)} \right)^{-1} \right\| = \left\| S^{(k)} \right\| e^{t\Re\left(\mu_1^{(k)} \right)} \left\| \left(S^{(k)} \right)^{-1} \right\|.
$$
\n(4.4)

There exists $C_2 = C_2(MP)$ such that max $\{ \parallel \}$ $v_1^{(k)}$ $\begin{bmatrix} k \\ 1 \end{bmatrix}$ $\begin{bmatrix} 1 \\ 1 \end{bmatrix}$ $v_2^{(k)}$ $\begin{bmatrix} k \\ 2 \end{bmatrix}$ $\Big\} \leq C_2$, so $||S^{(k)}|| \leq C_2$. As $(S^{(k)})^{-1} = \frac{1}{\det S^{(k)}} \tilde{S}^{(k)}$ with $\tilde{S}^{(k)}$ obtained from $S^{(k)}$ after rearranging the coefficients and changing the signs of some of them, there exists $C_3 = C_3(U)$ such that

$$
\left\| \left(S^{(k)} \right)^{-1} \right\| \le C_3 \left| \det S^{(k)} \right|^{-1} = C_3 \frac{1}{\tanh(\lambda \beta_2) \left| \sqrt{\operatorname{dis}^{(k)}} \right|} \le C_3 \frac{1}{\tanh(\lambda \beta_2) \sqrt{2 \tanh(\lambda \beta_1) \tanh(\lambda \beta_2)}}. \tag{4.5}
$$

We finally analyze the sub-case $k \neq \pm 1$ and $|k| < C_1$. If $\text{dis}^{(k)} \neq 0$, we can proceed as in the case $k = 1$ as we have to control only a finite number of k's. If $dis^{(k)} = 0$, we have $\mu_1^{(k)} = \mu_2^{(k)} = \mu^{(k)}$. The matrix $A^{(k)}$ is not diagonalizable but equivalent to a triangular matrix

$$
T^{(k)} = \begin{pmatrix} \mu^{(k)} & a^{(k)} \\ 0 & \mu^{(k)} \end{pmatrix} \tag{4.6}
$$

via conjugating by orthogonal matrices. Then there exists $C_4 = C_4(\mathbf{U})$ such that

$$
\left\| e^{tA^{(k)}} \right\| \le C_4 \left\| e^{tT^{(k)}} \right\| = C_4 \left\| \begin{pmatrix} e^{t\mu^{(k)}} & a^{(k)} t e^{t\mu^{(k)}} \\ 0 & e^{t\mu^{(k)}} \end{pmatrix} \right\| = C_4 \left(e^{t\mu^{(k)}} + \left| a^{(k)} \right| t e^{t\mu^{(k)}} \right). \tag{4.7}
$$

We conclude by observing that there exists $C_5 = C_5(M)$ such that $e^{t\mu(k)} + |a^{(k)}|te^{t\mu(k)} \leq C_5 e^{\frac{1}{2}t\mu(k)}$ (as we have only finite cases to consider, $|a^{(k)}|$ can be bounded by a constant that depends only on the MP).

Proposition 4.2. For $M \in \mathbb{N}$ and $j \in \{1, ..., M\}$, let $I_j := \left[\frac{j-1}{M}, \frac{j}{M}\right]$ $\left(\frac{j}{M}\right)$. For $f \in L^1(\mathbb{T}, \mathbb{R})$ and $M \in \mathbb{N}$, let f_M be the function such that, for every $j \in \{1,\ldots,M\}$, takes the value $M \int_{I_j} f$ in the interval I_j (f_M is a piece-wise constant approximation of f). Let $f \in C(\mathbb{T}, \mathbb{R})$ such that $\int_0^1 f_M^2 \xrightarrow[M \to \infty]{} N \to \infty$ $\int_0^1 f^2$. Let $(\sigma_i)_{i=0}^{N-1}$ be an independent family with distribution $P[\sigma_i = 1] = P[\sigma_i = -1] = \frac{1}{2}$. Then

$$
Y^{(N)} := \frac{1}{\sqrt{N}} \sum_{i=0}^{N-1} f\left(\frac{i}{N}\right) \sigma_i \tag{4.8}
$$

converges in distribution to $N\left(0, \int_0^1 f^2\right)$.

To prove lemma [4.8,](#page-23-1) we need the following one.

Lemma 4.3. If $f \in L^1(\mathbb{T}, \mathbb{R})$ is such that $f = f_M$ for some $M \in \mathbb{N}$, the assertion of lemma [4.8](#page-23-1) holds. *Proof of lemma [4.3.](#page-23-2)* Let $\Lambda_j^{(N)} := (NI_j) \cap \mathbb{Z}$. We first see that

$$
\tilde{Y}^{(N)} := \frac{1}{\sqrt{M}} \sum_{j=1}^{M} f\left(\frac{j-1}{M}\right) \frac{1}{\sqrt{\left|\Lambda_j^{(N)}\right|}} \sum_{i \in \Lambda_j^{(N)}} \sigma_i
$$
\n(4.9)

converges weakly to $N(0, \int_0^1 f^2)$. Call $X_j^{(N)}$ $j^{(N)} := \frac{1}{\sqrt{|\cdot|}}$ $\left|\Lambda_j^{(N)}\right|$ $\sum_{i\in\Lambda_j^{(N)}}\sigma_i$. For every N, the family $\left\{X_j^{(N)}\right\}$ $\begin{Bmatrix} (N) \ j \end{Bmatrix}$ \int_{j} is independent. Also $X_i^{(N)}$ $j^{(N)}$ converges weakly to $N(0, 1)$ for every j. Then the random vector $\left(X_j^{(N)}\right)$ $j^{(N)}$ j converges weakly to the random vector $(X_j)_{j} \sim N(0, \text{Id}_M)$. Then the random variable [\(4.9\)](#page-23-3) converges weakly to $\frac{1}{\sqrt{2}}$ $\frac{1}{M} \sum_{j=1}^{M} f\left(\frac{j-1}{M}\right) X_j \sim N\left(0, \int_0^1 f^2\right).$

Using that f is bounded, that $V(X_i^{(N)})$ $\binom{N}{j}$ = 1, and that $\sqrt{\frac{\left|\Lambda_j^{(N)}\right|}{N}} \xrightarrow[N \to \infty]{} \frac{1}{\sqrt{N}}$ $\frac{1}{M}$, one can see that $V(\tilde{Y}^{(N)} - Y^{(N)}) \longrightarrow$ 0; then, for every $\tilde{\delta} > 0$, $P\left(\left|\tilde{Y}^{(N)}-Y^{(N)}\right|>\tilde{\delta}\right) \xrightarrow[N\to\infty]{}$ 0. (4.10)

Let $G_{\int_0^1 f^2}$ be the Gaussian probability with zero mean and variance $\int_0^1 f^2$. For $h : \mathbb{R} \to \mathbb{R}$ bounded and uniformly continuous, we have to prove that

$$
\left| E\left(h\left(Y^{(N)}\right)\right) - G_{\int_0^1 f^2}(h) \right| \xrightarrow[N \to \infty]{} 0. \tag{4.11}
$$

(Recall that weak convergence of probabilities is equivalent to convergence of the expectations against bounded uniformly continuous functions.) We have already proved that

$$
\left| E\left(h\left(\tilde{Y}^{(N)}\right)\right) - G_{\int_0^1 f^2}(h) \right| \xrightarrow[N \to \infty]{} 0,
$$
\n(4.12)

so we only need to prove

$$
\left| E\left(h\left(Y^{(N)}\right)\right) - E\left(h\left(\tilde{Y}^{(N)}\right)\right) \right| \xrightarrow[N \to \infty]{} 0. \tag{4.13}
$$

Fix $\varepsilon > 0$ and take $\delta > 0$ such that $|h(y) - h(x)| < \varepsilon$ whenever $|y - x| \leq \delta$. The quantity to control in [\(4.13\)](#page-23-4) is bounded by

$$
E\left(\left|h\left(Y^{(N)}\right)-h\left(\tilde{Y}^{(N)}\right)\right|\mathbf{1}\left\{\left|Y^{(N)}-\tilde{Y}^{(N)}\right|>\delta\right\}\right) + E\left(\left|h\left(Y^{(N)}\right)-h\left(\tilde{Y}^{(N)}\right)\right|\mathbf{1}\left\{\left|Y^{(N)}-\tilde{Y}^{(N)}\right|\leq\delta\right\}\right).
$$
\n(4.14)

The first addend goes to zero because of [\(4.10\)](#page-23-5); the second one is bounded by ε . As ε is arbitrary, we can conclude. \Box

Proof of lemma [4.8.](#page-23-1) Let f_M be the discretized version of f and

$$
Y_M^{(N)} := \frac{1}{\sqrt{N}} \sum_{i=0}^{N-1} f_M\left(\frac{i}{N}\right) \sigma_i.
$$
\n(4.15)

From Chebyshev inequality, there is a constant depending only on f such that, for every $\tilde{\delta} > 0$,

$$
P\left(\left|Y^{(N)} - Y_M^{(N)}\right| > \tilde{\delta}\right) \le \frac{C}{\tilde{\delta}^2 M^2} \tag{4.16}
$$

(observe that this bound is uniform in N). Let $h : \mathbb{R} \to \mathbb{R}$ bounded and uniformly continuous. We have to prove that

$$
\left| E\left(h\left(Y^{(N)}\right)\right) - G_{\int_0^1 f^2}h \right| \xrightarrow[N \to \infty]{} 0. \tag{4.17}
$$

Fix $\varepsilon > 0$ and let $\delta > 0$ be such that $|h(y) - h(x)| < \varepsilon$ whenever $|y - x| \leq \delta$. Take M such that $\left|G_{\int_0^1 f_M^2}h - G_{\int_0^1 f^2}h\right| < \varepsilon$ and $\frac{C}{\delta^2 M^2} < \frac{\varepsilon}{\|h\|_{\infty}}$. The quantity to control in [\(4.17\)](#page-24-1) is bounded by

$$
E\left(\left|h\left(Y^{(N)}\right)-h\left(Y_M^{(N)}\right)\right|\right)+\left|E\left(h\left(Y_M^{(N)}\right)\right)-G_{\int_0^1 f_M^2}h\right|+\varepsilon.\tag{4.18}
$$

Multiply by $1 = 1$ $\left\{ \left| \right. \right.$ $\begin{bmatrix} \mathcal{N} \ M \end{bmatrix} > \delta \Big\} + \mathbf{1} \Big\{ \Big\|$ $\left| \begin{array}{c} \mathcal{L}^{(N)} \ M \end{array} \right| \leq \delta$ inside the first expectation to get the $Y^{(N)} - Y_M^{(N)}$ $Y^{(N)} - Y_M^{(N)}$ upper bound 2ε for it. The second addend goes to zero as N goes to infinity because of Lemma [4.3.](#page-23-2) We conclude as ε is arbitrary. \Box

Lemma 4.4. There exists a constant C such that, for every $\delta > 0$,

$$
\mathbb{P}\left(\sup_{t\in[0,\infty)}\left\|\int_0^t e^{(t-s)A^{(k)}}\underline{M}_{\gamma}^{(k)}(ds)\right\| \le k^2\gamma^{\frac{1}{2}-\delta} \quad \forall k\neq\pm 1\right) \ge 1 - C\gamma^{2\delta} \tag{4.19}
$$

$$
\mathbb{P}\left(\sup_{t\in[0,\infty)}\left\|\int_0^t e^{-sA^{(k)}}\underline{M}_{\gamma}^{(k)}(ds)\right\| \leq \gamma^{\frac{1}{2}-\delta}, \ k=\pm 1\right) \geq 1 - C\gamma^{2\delta} \tag{4.20}
$$

$$
\mathbb{P}\Big(\Big\|\underline{X}_{\gamma}^{(k)}(0)\Big\| \le k^2 \gamma^{\frac{1}{2}-\delta} \quad \forall k \in \mathbb{Z}\Big) \ge 1 - C\gamma^{2\delta}.\tag{4.21}
$$

Proof. We start by proving [\(4.19\)](#page-24-2). Observe that the proof follows once we show that there exists a constant C such that, for all $T > 0$,

$$
\mathbb{P}\left(\exists k \neq \pm 1 : \sup_{t \in [0,T]} \left\| \int_0^t e^{(t-s)A^{(k)}} \underline{M}_{\gamma}^{(k)}(ds) \right\| > k^2 \gamma^{\frac{1}{2}-\delta} \right) \leq C \gamma^{2\delta},\tag{4.22}
$$

which follows from

$$
\sum_{k\neq\pm1} P\left(\sup_{t\in[0,T]} \left\| \int_0^t e^{(t-s)A^{(k)}} \underline{M}_{\gamma}^{(k)}(ds) \right\| > k^2 \gamma^{\frac{1}{2}-\delta} \right) \leq C\gamma^{2\delta}.\tag{4.23}
$$

Observe that by Doob's inequality and Ito's isometry we get the following

$$
\mathbb{P}\left(\sup_{t\in[0,T]}\left|\int_0^t B_{i,j}^{(k)}(t-s)\#M_{\gamma,l}^{(k)}(ds)\right|>\varepsilon\right)\leq \varepsilon^{-2}\mathbb{E}\left[\left(\int_0^t B_{i,j}^{(k)}(t-s)\#M_{\gamma,l}^{(k)}(ds)\right)^2\right]
$$
\n
$$
\leq \varepsilon^{-2}\mathbb{E}\left(\int_0^T B_{i,j}^{(k)}(t-s)^2\Big\langle\#M_{\gamma,1}^{(k)}\Big\rangle(ds)\right)
$$
\n(4.24)

for every $\varepsilon > 0$, i, j, $l \in \{1,2\}$, and $\# \in \{\Re, \Im\}$. By Lemma 5.1 in the Appendix A of [\[KL99\]](#page-26-5), through easy computations, we get that there exists a constant C_1 such that

$$
\left\langle \# M_{\gamma,l}^{(k)} \right\rangle(t) = \int_0^t L_\gamma \left\langle \sigma_{\gamma,l}(s), \# F^{(k)} \right\rangle - 2 \left\langle \sigma_{\gamma,l}(s), \# F^{(k)} \right\rangle L_\gamma \left\langle \sigma_{\gamma,l}(s), \# F^{(k)} \right\rangle ds \le C_1 \gamma t \tag{4.25}
$$

As the maximum of the modulus of the entries of a matrix defines a norm, and as all the norms are equivalent, Lemma [4.1](#page-22-0) guarantees the existence of a constant C_2 such that

$$
\left| B_{i,j}^{(k)}(t-s) \right| \le C_2 e^{\frac{1}{2}\Re\left(\mu_1^{(k)}\right)(t-s)} \tag{4.26}
$$

Plugging the estimations [\(4.25\)](#page-25-1) and [\(4.26\)](#page-25-2) into [\(4.24\)](#page-25-3), we get that,

$$
\mathbb{P}\left(\sup_{t\in[0,T]}\left|\int_0^t B_{i,j}^{(k)}(t-s)\#M_{\gamma,l}^{(k)}(ds)\right|>\varepsilon\right) \leq \varepsilon^{-2}\gamma C_2^2 \int_0^T e^{\Re\left(\mu_1^{(k)}\right)(t-s)}ds \leq \frac{C_2^2}{\Re\left(\mu_1^{(k)}\right)}\varepsilon^{-2}\gamma\tag{4.27}
$$

for every $\varepsilon > 0$, i, j, $l \in \{1,2\}$, and $\# \in \{\Re, \Im\}$. By [\(3.63\)](#page-14-2), we get that

$$
\mu_1^{(k)} = -1 + \frac{\alpha_1 \phi_1^{(k)} + \alpha_2 \phi_2^{(k)}}{2} + \frac{1}{2} \sqrt{\left(\alpha_1 \phi_1^{(k)} - \alpha_2 \phi_2^{(k)}\right)^2 - \tanh(\beta_1 \lambda) \tanh(\beta_2 \lambda)}
$$
(4.28)

Since $\lim_{|k|\to\infty} \Re\Bigl(\mu_1^{(k)}\Bigr)$ $\left\{\begin{matrix} (k) \ 1 \end{matrix}\right\} = -1$, the family $\left\{\Re\left(\mu_1^{(k)}\right)\right\}$ $\binom{k}{1}$ is uniformly lower bounded in k and we can find a common constant C_3 which can replace $\frac{C_2^2}{\Re(\mu_1^{(k)})}$ in the right hand side of [\(4.27\)](#page-25-4). Then, by decomposing $\int_0^t e^{(t-s)A^{(k)}} \underline{M}_{\gamma}^{(k)}(ds)$ first into the two coordinates and after into their real and immaginary parts, we can conclude that, for all $\zeta > 0$ and for all $k \neq \pm 1$

$$
\mathbb{P}\left(\sup_{t\in[0,T]}\left\|\int_0^t e^{(t-s)A^{(k)}}\underline{M}_\gamma^{(k)}(ds)\right\|>\zeta\right)\leq C_4\zeta^{-2}\gamma\tag{4.29}
$$

[\(4.23\)](#page-24-3) follows after taking $\zeta = k^2 \gamma^{\frac{1}{2} - \delta}$ into [\(4.29\)](#page-25-5). The proof for [\(4.20\)](#page-24-4) is similiar, so we will omit it. We proceed with the proof of [\(4.21\)](#page-24-5).

As before, it is enough to prove that

$$
\mathbb{P}\left(\left|\#X_{\gamma,i}^{(1)}\right| \geq \tilde{\varepsilon}\right) \leq \tilde{\varepsilon}^{-2}\gamma\tag{4.30}
$$

 \Box

for every $\tilde{\varepsilon} > 0$, $i \in \{1,2\}$, and $\# \in \{\Re, \Im\}$; [\(4.30\)](#page-25-6) is a consequence of Chebyshev inequality.
