WEAK HARNACK ESTIMATES FOR SUPERSOLUTIONS TO DOUBLY DEGENERATE PARABOLIC EQUATIONS

ABSTRACT. We establish weak Harnack inequalities for positive, weak supersolutions to certain doubly degenerate parabolic equations. The prototype of this kind of equations is

$$\partial_t u - \operatorname{div} |u|^{m-1} |Du|^{p-2} Du = 0, \quad p > 2, \quad m+p > 3.$$

Our proof is based on Caccioppoli inequalities, De Giorgi's estimates and Moser's iterative method.

1. INTRODUCTION

Harnack inequality for non-negative solutions of the linear parabolic equations was established by Moser [23]. Furthermore, Aronson and Serrin [1], Trudinger [26] and Ivanov [11] independently extended Moser's result to the quasilinear case. Later DiBenedetto [4] established intrinsic Harnack inequality for weak solutions to the parabolic *p*-Laplace equations. The proof is based on the idea of time-intrinsic geometry, maximum principle and comparison to Barenblatt solutions. Recently, DiBenedetto, Gianazza and Vespri [6, 7] extended this result to the parabolic equations with general quasi-linear structure.

The issue of the Harnack inequality for weak supersolutions to quasi-linear parabolic equations was settled by Trudinger [26]. However, the weak supersolutions may not be continuous and they do not, in general, satisfy an intrinsic Harnack inequality (see for instance [22]). In [18], Kuusi proved that any non-negative weak supersolutions to a certian evolutionary *p*-Laplace equations satisfy an integral form of the intrinsic Harnack inequality. Similar result for the degenerate porous medium equations was announced by DiBenedetto, Gianazza and Vespri [6] and later proved by Lehtelä [21]. This kind of weak Harnack inequality was used by Kuusi, Lindqvist and Parviainen [20] to the study of summability of unbounded supersolutions.

In this work, we are interested in the doubly degenerate parabolic equations whose prototype is

$$\frac{\partial u}{\partial t} - \operatorname{div} |u|^{m-1} |Du|^{p-2} Du = 0.$$
(1.1)

This equation models the filtration of a polytropic non-Newtonian fluid in a porous medium (see for example [17]). Porzio and Vespri [25] and Ivanov [12] independently proved that the weak solutions to (1.1) are Hölder continuous. The Harnack inequality of weak solutions to doubly degenerate parabolic equations has been established by Vespri [?] and the case of equations with general quasi-linear structure was treated by Fornaro and Sosio

[8]. Motivated by these work, we are interested in finding the weak Harnack inequalities for positive, weak supersolutions to this kind of parabolic equations.

The aim of this paper is to establish both local and global Harnack estimates for positive, weak supersolutions to (1.1) in the range p + m > 3 and p > 2. Our proof is in the spirit of [7, chapter 3] which reduce the proof to the consideration of hot alternative and cold alternative. Our first goal is to prove the Caccioppoli estimates. The treatment of the weak supersolutions is different from weak solutions, since the test function should be non-negative. Unlike the argument in [8], it is not convenient to use Steklov average in the context of supersolutions. Instead, we use the time mollification introduced by Naumann [24]. This kind of the time mollification was also used by Kinnunen and Lindqvist [14]-[16] to establish the priori estimates of supersolutions. The major difficulty in the proof of Caccioppoli estimates for the cold alternative stems from the fact that any supersolution to (1.1) plus a constant may not be a supersolution anymore. We have to use the dampening function introduced by Lehtelä [21] to construct a suitable test function in the proof. This idea has also been used by Ivert, Marola and Masson [13] in a different context. Subsequently, we establish a result concerning expansion of positivity and iterate the expansion of positivity to obtain the hot alternative proposition. Furthermore, we have to work with the cold alternative invented by Kuusi [18, section 5]; see also [21, section 4].

An outline of this paper is as follows. We set up notations and state the main results in Section 2. In Section 3, we prove some parabolic Sobolev inequalities which will be used in Section 7. Subsequently, Section 4 establishes the Caccioppoli estimates, which play a crucial role in the remainder of the proof. Section 5 contains a discussion of the expansion of positivity, while in Section 6 we prove the desired estimate in the hot alternative. In Section 7, we use Moser's iterative method to obtain a lower bound for the supersolution in the cold alternative. Finally, in Section 8.2, we finish the proof of the local and global weak Harnack inequalities.

2. STATEMENT OF THE MAIN RESULTS

Throughout the paper, *E* will denote a bounded domain in \mathbb{R}^N and ∂E stand for the boundary of *E*. For T > 0, let E_T be the cylindrical domain $E \times (0, T]$. Points in \mathbb{R}^{N+1} will be denoted by z = (x, t) where $x \in \mathbb{R}^N$ and $t \in \mathbb{R}$.

For $f \in C^1(E_T)$, we denote by Df the differentiation with respect to the space variables, while $\partial_t f$ stands for the time derivative. The spaces $L^p(E)$ and $W^{1,p}(E)$ are the locally Lebesgue and Sobolev spaces. A function $f \in L^p_{loc}(E)$ if $f \in L^p(K)$ for all compact subset $K \subset E$. Similarly, the function $f \in W^{1,p}_{loc}(E)$ if $f \in W^{1,p}(K)$ for all compact subset $K \subset E$.

Let k be any real number and for a function $v \in W^{1,p}(E)$ the truncations are defined by

$$(v - k)_{+} = \max\{v - k; 0\}$$

 $(v - k)_{-} = \max\{-(v - k); 0\}$

For $\rho > 0$ and $y \in \mathbb{R}^N$, denote by $K_{\rho}(y)$ the cube centered at y, with sides parallel to the coordinate axes, and with sides of length ρ . If y is the origin, we abbreviate $K_{\rho}(y)$ to K_{ρ} . For $A \subset \mathbb{R}^{N+1}$ we denote by |A| the Lebesgue measure of A. We define χ_A be the characteristic function of A.

Let $T_1, T_2 \in \mathbb{R}$ and $T_1 < T_2$. Consider quasi-linear parabolic equations of the form

$$\frac{\partial u}{\partial t} - \operatorname{div} A(z, u, Du) = 0 \quad \text{weakly in} \quad E \times (T_1, T_2), \tag{2.1}$$

where the function $A : E \times (T_1, T_2) \times \mathbb{R} \times \mathbb{R}^N \to \mathbb{R}^N$ are assumed to be measurable and subject to the structure conditions

$$\begin{cases} A(x, t, u, Du) \cdot Du \ge C_0 |u|^{m-1} |Du|^p, \\ |A(x, t, u, Du)| \le C_1 |u|^{m-1} |Du|^{p-1}, \end{cases}$$
(2.2)

for almost all $(x, t) \in E \times (T_1, T_2)$, with

$$m + p > 3, \quad p > 2$$
 (2.3)

and C_0 , C_1 positive constants. We now give the definition of weak supersolutions to doubly degenerate parabolic equations.

Definition 2.1. A function $u : E \times (T_1, T_2] \rightarrow \mathbb{R}$ is said to be a local weak supersolution of (2.1)-(2.3) if

$$u \in C_{loc}(T_1, T_2; L^2_{loc}(E)), \quad u^{\alpha} \in L^p_{loc}(T_1, T_2; W^{1,p}_{loc}(E)) \quad \text{where} \quad \alpha = \frac{m+p-2}{p-1}$$
(2.4)

and the inequality

$$-\int_{T_1}^{T_2} \int_E u \frac{\partial \varphi}{\partial t} dx dt + \int_{T_1}^{T_2} \int_E A(x, t, u, Du) \cdot D\varphi \, dx dt \ge 0$$
(2.5)

holds for any non-negative test function $\varphi \in C_0^{\infty}(E \times (T_1, T_2))$ *.*

We remark that the gradient of u in (2.2) is interpreted as $Du = \alpha^{-1}u^{1-\alpha}Du^{\alpha}$. Throughout this paper, we assume that weak supersolution u is *positive* almost everywhere, i.e., |[u = 0]| = 0.

The following theorems are our main results. We prove that for any positive, weak supersolutions to (2.1)-(2.3) defined above, local weak Harnack estimate takes the following form.

Theorem 2.2. Let u be a positive, weak super-solution to (2.1)-(2.3) in an open set which compactly contains E_T . For $y \in E$, let $\varrho > 0$ be so small that $K_{32\varrho}(y) \subset E$. There exist positive constants c and γ , depending only upon m, p, N, C_0 and C_1 , such that for almost every $s \in (0, T)$,

$$\int_{K_{\varrho}(y)} u(x,s)dx \le c \left(\frac{\varrho^p}{T-s}\right)^{\frac{1}{m+p-3}} + \gamma \operatorname{ess\,inf}_{\mathcal{Q}_{\varrho,\theta}} u, \tag{2.6}$$

where $Q_{\varrho,\theta} = K_{4\varrho}(y) \times \left(s + \frac{1}{2}\theta \varrho^p, s + \theta \varrho^p\right)$ and

$$\theta = \min\left\{c\frac{T-s}{\varrho^p}, \quad \left(\int_{K_\varrho(y)} u(x,s)dx\right)^{3-m-p}\right\}.$$
(2.7)

In the global case, Theorem 2.2 can be sharpened to the following result.

Theorem 2.3. Let u be a positive, weak super-solution to (2.1)-(2.3) in $\mathbb{R}^N \times (0, T]$. There exists a positive constant γ , depending only upon m, p, N, C_0 and C_1 , such that for all $(y, s) \in \mathbb{R}^N \times (0, T), \rho > 0$ and T' > 0 such that s + T' < T, there holds

$$\int_{K_{\varrho}(y)} u(x,s)dx \le \gamma \left(\frac{\varrho^p}{T'}\right)^{\frac{1}{m+p-3}} + \gamma \left(\frac{T'}{\varrho^p}\right)^{\frac{N}{p}} (\operatorname*{ess\,inf}_{\tilde{\mathcal{Q}}_{\varrho,T'}} u)^{\frac{\lambda}{p}}, \tag{2.8}$$

where $\lambda = N(p + m - 3) + p$ and $\tilde{Q}_{\varrho,T'} = K_{4\varrho}(y) \times \left(s + \frac{1}{2}T', s + T'\right]$.

Note that in the case m = 1, doubly degenerate parabolic equations (2.1)-(2.3) reduce to the evolutionary *p*-Laplace equations. In this case, Theorem 2.2 and Theorem 2.3 were proved in [18] and [7, chapter 3]. Our proof will focus on two cases p > 2, m > 1 and 0 < m < 1, m + p > 3.

3. PARABOLIC SOBOLEV INEQUALITIES

In this section, we collect some parabolic Sobolev inequalities which will be used in Section 5-7. Here and subsequently, the function space $W_0^{1,p}(E)$ is defined as the set of functions $v \in W^{1,p}(E)$ whose trace on ∂E is zero. In the following, we present some of the results obtained in [4, chapter I].

Proposition 3.1. [4, Chapter I, Proposition 3.1] Let $p \ge 1$ and $r \ge 1$. There exists a constant γ depending only upon N, p and r such that for every $v \in L^{\infty}(0,T;L^{r}(E)) \cap L^{p}(0,T;W_{0}^{1,p}(E))$, there holds

$$\iint_{E_T} |v(x,t)|^q dz \le \gamma \iint_{E_T} |Dv(x,t)|^p dz \left(\operatorname{ess\,sup}_{0 < t < T} \int_E |v(x,t)|^r dx \right)^{\frac{p}{N}}$$
(3.1)

where $q = p \frac{N+r}{N}$.

Lemma 3.2. [4, Chapter I, Theorem 2.1] Let $v \in W_0^{1,p}(E)$ with $p \ge 1$. For $s \ge 1$ there exists a constant *C* depending only upon *N*, *p* and *s* such that

$$\left(\int_{E} |v|^{q} dx\right)^{\frac{1}{q}} \leq C \left(\int_{E} |Dv|^{p} dx\right)^{\frac{q}{p}} \left(\int_{E} |v|^{s} dx\right)^{\frac{1-\alpha}{s}}$$
(3.2)

where $\alpha \in [0, 1]$, $p \ge 1$, $q \ge 1$ and

$$\alpha = \left(\frac{1}{s} - \frac{1}{q}\right) \left(\frac{1}{N} - \frac{1}{p} + \frac{1}{s}\right)^{-1}.$$
(3.3)

We remark that the estimate (3.2) is also known as Gagliardo-Nirenberg interpolation inequality and this will be used in the proof of the following result.

Proposition 3.3. Let $p \ge 1$ and r > 0. Set

$$Q_1 = K_1 \times \Lambda_1 = \left[-\frac{1}{2}, \frac{1}{2}\right]^N \times [0, 1].$$

Then there exists a constant γ depending only upon N, p and r such that, for any $v \in L^{\infty}(0, 1; L^{r}(K_{1})) \cap L^{p}(0, 1; W_{0}^{1,p}(K_{1}))$, the following holds:

In the case p < N, there holds

$$\iint_{Q_1} |v(x,t)|^{p\frac{N+r}{N}} dz \le \gamma \iint_{Q_1} |Dv(x,t)|^p dz \left(\operatorname{ess\,sup}_{0 < t < 1} \int_{K_1} |v(x,t)|^r dx \right)^{\frac{1}{N}}.$$
 (3.4)

In the case p > N, the estimate

$$\iint_{Q_1} |v(x,t)|^{p+\frac{r}{q}} dz \le \gamma \iint_{Q_1} |Dv(x,t)|^p dz \left(\operatorname{ess\,sup}_{0 < t < 1} \int_{K_1} |v(x,t)|^r dx \right)^{\frac{1}{q}}$$
(3.5)

holds for any q > 1. In the case p = N, there holds

$$\iint_{Q_1} |v(x,t)|^{p+\frac{r}{2}} dz \leq \gamma \iint_{Q_1} |Dv(x,t)|^p dz \left(\operatorname{ess\,sup}_{0 < t < 1} \int_{K_1} |v(x,t)|^r dx \right)^{\frac{1}{2}}.$$
 (3.6)

Proof. Our proof strategy is to use Hölder's inequality together with Sobolev's inequality. In the case p < N, the proof is due to DiBenedetto [4, page 8] and we include the proof here for the sake of completeness. Applying Sobolev embedding theorem slicewise to $v(\cdot, t)$, we obtain

$$\left(\int_{K_1} |v(\cdot,t)|^{\frac{pN}{N-p}} dx\right)^{\frac{N-p}{N}} \leq C(N,p) \int_{K_1} |Dv(\cdot,t)|^p dx.$$

This yields

$$\iint_{Q_{1}} |v|^{p\frac{N+r}{N}} dz \leq \int_{0}^{1} \left(\int_{K_{1}} |v(x,t)|^{\frac{pN}{N-p}} dx \right)^{\frac{N-p}{N}} \left(\int_{K_{1}} |v(x,t)|^{r} dx \right)^{\frac{p}{N}} dt$$
$$\leq C(N,p) \iint_{Q_{1}} |Dv|^{p} dz \left(\operatorname{ess\,sup}_{0 < t < 1} \int_{K_{1}} |v(x,t)|^{r} dx \right)^{\frac{p}{N}},$$

and (3.4) is proved. We now turn to the case p > N. In this case, the proof is due to Kuusi [19]. We use the Sobolev's inequality slicewise on K_1 and obtain

$$\sup_{x \in K_1} |v(\cdot, t)| \le C(N, p) \left(\int_{K_1} |Dv(\cdot, t)|^p dx \right)^{\frac{1}{p}}.$$

Then, for any $\bar{q} > 1$, there holds

$$\left(\int_{K_1} |v(\cdot,t)|^{p\bar{q}} dx\right)^{\frac{1}{\bar{q}}} \le \left(\sup_{x \in K_1} |v(x,t)|\right)^p \le C(N,p) \int_{K_1} |Dv(\cdot,t)|^p dx.$$

Choosing $\bar{q} = q/(q-1)$, we conclude from Hölder's inequality that

$$\iint_{Q_{1}} |v|^{p+\frac{r}{q}} dz \leq \int_{0}^{1} \left(\int_{K_{1}} |v(x,t)|^{p\bar{q}} dx \right)^{\frac{1}{q}} \left(\int_{K_{1}} |v(x,t)|^{r} dx \right)^{\frac{1}{q}} dt$$
$$\leq C \iint_{Q_{1}} |Dv|^{p} dz \left(\operatorname{ess\,sup}_{0 < t < 1} \int_{K_{1}} |v(\cdot,t)|^{r} dx \right)^{\frac{1}{q}},$$

and (3.5) follows. Finally, we come to the case p = N which is the limiting case of Sobolev's inequality. We apply Lemma 3.2 (3.2) with p = s = N, q = 2N and $\alpha = \frac{1}{2}$ to obtain

$$\int_{\Omega} |v(\cdot,t)|^{2N} dx \le C \int_{\Omega} |Dv(\cdot,t)|^N dx \int_{\Omega} |v(\cdot,t)|^N dx.$$
(3.7)

Note that $v(\cdot, t) \in W_0^{1,p}(K_1)$ for almost every $t \in [0, 1]$. Applying Friedrichs' inequality slicewise to $v(\cdot, t)$, we get

$$\int_{\Omega} |v(\cdot,t)|^N dx \le C(N) \int_{\Omega} |Dv(\cdot,t)|^N dx.$$
(3.8)

We plug (3.8) back into (3.7), there holds

$$\int_{\Omega} |v(\cdot,t)|^{2N} dx \le C \left(\int_{\Omega} |Dv(\cdot,t)|^N dx \right)^2.$$

By Hölder's inequality, we deduce

$$\iint_{Q_1} |v|^{N+\frac{r}{2}} dx dt \le \int_0^1 \left(\int_{K_1} |v(x,t)|^{2N} dx \right)^{\frac{1}{2}} \left(\int_{K_1} |v(x,t)|^r dx \right)^{\frac{1}{2}} dt$$
$$\le C \iint_{Q_1} |Dv|^N dz \left(\operatorname{ess\,sup}_{0 \le t \le 1} \int_{K_1} |v(\cdot,t)|^r dx \right)^{\frac{1}{2}},$$

which completes the proof.

Remark 3.4.

- (1) Compared with Proposition 3.1, the condition for r in Proposition 3.3 is relaxed and 0 < r < 1 is admissible. For the applications, we shall use Proposition 3.1 together with De Giorgi's estimates in Section 5-6. Proposition 3.3 will be used in the proof of Lemma 7.1 and Lemma 7.2 in Section 7.
- (2) After finishing this paper, we became aware of [2], which proves Proposition 3.3 in a more general Sub-Riemannian homogeneous spaces. However, our approach make the argument simpler and easier.

4. CACCIOPPOLI ESTIMATES

Throughout this section, Q denotes the open subset of E. We shall use parabolic cylinders of the form $Q_T = Q \times [0, T]$. Let $\partial_P Q_T = \partial Q \times [0, T] \cup Q \times \{0\}$ denote the parabolic boundary of Q_T . For the fixed $t_1, t_2 \in \mathbb{R}$ with $t_1 < t_2$, if the test function $\phi(x, t)$ is required to vanish only on the lateral boundary $\partial Q \times [t_1, t_2]$, then the boundary terms

$$\int_{Q} u(x,t_1)\phi(x,t_1)dx := \lim_{\nu \to 0} \frac{1}{\nu} \int_{t_1}^{t_1+\nu} \int_{Q} u(x,t)\phi(x,t)dxdt$$
(4.1)

and

$$\int_{Q} u(x,t_2)\phi(x,t_2)dx := \lim_{\nu \to 0} \frac{1}{\nu} \int_{t_2-\nu}^{t_2} \int_{Q} u(x,t)\phi(x,t)dxdt$$
(4.2)

have to be included. Next we shall derive an inequality involving the boundary terms which is an equivalent form of (2.5). Let $v < \frac{1}{4}(t_2 - t_1)$ be a fixed positive number. We introduce the Lipschitz function $\theta_v(t)$ by

$$\theta_{\nu}(t) = \begin{cases} 0, & t < t_1, \\ \frac{1}{\nu}(t-t_1), & t_1 \le t < t_1 + \nu, \\ 1, & t_1 + \nu \le t < t_2 - \nu, \\ \frac{1}{\nu}(t_2 - t), & t_2 - \nu \le t < t_2, \\ 0, & t \ge t_2. \end{cases}$$
(4.3)

Let *u* be a weak supersolution to (2.1)-(2.3) in an open set which compactly contains $Q_{t_1,t_2} = Q \times [t_1, t_2]$ and ϕ be the smooth function mentioned above, we choose the test function $\varphi = \phi(x, t)\theta_v(t)$ in (2.5) and pass to the limit $v \downarrow 0$. Then we obtain from (4.1) and (4.2) that

$$-\int_{t_1}^{t_2} \int_{\mathcal{Q}} u \frac{\partial \phi}{\partial t} dx dt + \int_{t_1}^{t_2} \int_{\mathcal{Q}} A(x, t, u, Du) \cdot D\phi dx dt + \int_{\mathcal{Q}} u(x, t_2) \phi(x, t_2) dx - \int_{\mathcal{Q}} u(x, t_1) \phi(x, t_1) dx \ge 0.$$

$$(4.4)$$

We remark that (4.4) is an equivalent form of (2.5) and this will be used in the proof of Proposition 4.2. Specifically, in the case when ϕ is independent of *t*, we have

$$\int_{Q} u(x,t_2)\phi(x)dx \ge \int_{Q} u(x,t_1)\phi(x)dx - \iint_{Q_{t_1,t_2}} A(x,t,u,Du) \cdot D\phi dz.$$
(4.5)

This inequality is only needed in the proof of Proposition 7.4 in Section 7.

In order to deal with the possible lack of differentiability in time of weak supersolutions, the following time mollification of functions v has proved to be useful. We now define

$$v^*(x,t) = \frac{1}{\sigma} \int_0^t e^{(s-t)/\sigma} v(x,s) ds$$

Some elementary properties of this mollification are listed in the following lemma (see for example [15, Lemma 2.9], [3, Appendix B], [24, page 36]).

Lemma 4.1. Let
$$q \ge 1$$
.
(1) If $v \in L^q(Q_T)$, then
 $\|v^*\|_{L^q(Q_T)} \le \|v\|_{L^q(Q_T)}$

and

$$\frac{\partial v^*}{\partial t} = \frac{1}{\sigma} (v - v^*) \in L^q(Q_T).$$
(4.6)

Moreover, $v^* \rightarrow v$ *in* $L^q(Q_T)$ *as* $\sigma \downarrow 0$ *.*

- (2) If, in addition, $Dv \in L^q(Q_T)$, then $D(v^*) = (Dv)^*$ and $Dv^* \to Dv$ in $L^q(Q_T)$ as $\sigma \downarrow 0.$
- (3) If $v \in C(\overline{Q}_T)$, then

$$v^*(x,t) + e^{-t/\sigma}v(x,0) \rightarrow v(x,t)$$

uniformly in \overline{Q}_T as $\sigma \downarrow 0$.

The following result is due to Kinnunen and Lindqvist [14]-[16], which is crucial in the proof of Caccioppoli estimates. For completeness sake we include the proof here.

Proposition 4.2. Let u be a weak supersolution to (2.1)-(2.3) in an open set which compactly contains Q_T . If $\sigma < T/4$, then

$$\iint_{Q_T} \left(\left[A(x, t, u, Du) \right]^* \cdot D\phi + \phi \frac{\partial u^*}{\partial t} \right) dz \ge 0$$
(4.7)

valid for all non-negative function $\phi \in L^p(0, T; W_0^{1,p}(Q))$.

Before we can prove the Proposition 4.2, we need an approximation lemma.

Lemma 4.3. Let $v \in L^p(0,T; W_0^{1,p}(Q))$. For any $\varepsilon > 0$, there exists a smooth function \tilde{v} vanishing on the lateral boundary $\partial Q \times [0, T]$ such that

$$\|v-\tilde{v}\|_{L^p(Q_T)}+\|Dv-D\tilde{v}\|_{L^p(Q_T)}<\varepsilon.$$

Proof. We apply Proposition 6.29 of [10, page 200] with $X = W_0^{1,p}(Q)$. There exist $\theta_i \in C_0^{\infty}(0,T)$ and $w_i \in W_0^{1,p}(Q)$ with $i = 1, 2, \dots, n$, such that

$$\|\sum_{i=1}^n w_i\theta_i-v\|_{L^p(Q_T)}+\|\sum_{i=1}^n \theta_i Dw_i-Dv\|_{L^p(Q_T)}<\frac{\varepsilon}{2}.$$

Let $\psi_i \in C_0^{\infty}(Q)$ be such that

$$\|w_i - \psi_i\|_{L^p(Q)} + \|Dw_i - D\psi_i\|_{L^p(Q)} < \frac{\varepsilon}{2^i \max\{1, \|\theta_i\|_{L^p[0,T]}\}}$$

for any $i = 1, 2, \dots, n$. If we choose $\tilde{v} = \sum_{i=1}^{n} \psi_i \theta_i$, then the lemma follows by triangle inequalities. *Proof of Proposition 4.2.* Let us assume initially that ϕ is a non-negative smooth function vanishing on the lateral boundary $\partial Q \times [0, T]$. For a fixed $s \in (0, T)$, we apply (4.4) with $t_1 = 0, t_2 = T - s$ and choose the test function $\phi(x, t + s)$ to obtain

$$\int_{s}^{T} \int_{Q} -u(x,t-s)\frac{\partial\phi}{\partial t} + A(x,t-s,u(x,t-s),Du(x,t-s)) \cdot D\phi dx dt$$
$$+ \int_{Q} u(x,T-s)\phi(x,T)dx - \int_{Q} u(x,0)\phi(x,s)dx \ge 0.$$

Multiplying both sides by $\sigma^{-1}e^{-s/\sigma}$ and integrating over [0, T] with respect to s, we get

$$\int_0^T \int_Q \left([A(x,t,u,Du)]^* \cdot D\phi - u^* \frac{\partial \phi}{\partial t} \right) dx dt + \int_Q u^*(x,T) \phi(x,T) dx$$
$$\geq \int_Q u(x,0) \left(\frac{1}{\sigma} \int_0^T \phi(x,s) e^{-s/\sigma} ds \right) dx.$$

Using integration by parts and noting that $u^*(x, 0) = 0$, we have

$$\int_0^T \int_Q \left([A(x,t,u,Du)]^* \cdot D\phi + \phi \frac{\partial u^*}{\partial t} \right) dx dt \ge \int_Q u(x,0) \left(\frac{1}{\sigma} \int_0^T \phi(x,s) e^{-s/\sigma} ds \right) dx.$$

It follows that (4.7) holds for any non-negative smooth functions ϕ which vanishes on the lateral boundary $\partial Q \times [0, T]$. Finally, we turn our attention to the case when $\phi \in L^p(0, T; W_0^{1,p}(Q))$. According to Lemma 4.3, there exists a sequence of smooth functions $\{\phi_j\}_{i=1}^{\infty}$ which satisfy

$$\int_0^T \int_Q \left([A(x,t,u,Du)]^* \cdot D\phi_j + \phi_j \frac{\partial u^*}{\partial t} \right) dx dt \ge 0$$

and $\phi_j \to \phi$ in $L^p(0, T; W_0^{1,p}(Q))$ as $j \to \infty$. We use Lemma 4.1 (1) with q = p/(p-1) and Hölder's inequality to find that

$$\int_0^T \int_Q \left[A(x,t,u,Du) \right]^* \cdot D\phi_j dx dt \to \int_0^T \int_Q \left[A(x,t,u,Du) \right]^* \cdot D\phi dx dt$$

as $j \to \infty$. As for the term involving time derivative, we use (4.6) with q = p to infer that $\partial u^* / \partial t \in L^p(Q_T)$. Let p' = p/(p-1). Since p > 2, we have $\phi_j \to \phi$ in $L^{p'}(Q_T)$ as $j \to \infty$. By Hölder's inequality, we conclude that

$$\int_0^T \int_Q \phi_j \frac{\partial u^*}{\partial t} dx dt \to \int_0^T \int_Q \phi \frac{\partial u^*}{\partial t} dx dt$$

as $j \to \infty$, which proves the proposition.

We are now in a position to study the Caccioppoli estimates. The Caccioppol inequality stated in next proposition, was first announced by Fornaro and Sosio [8, (4.7)], deals with the case $m \ge 1$ and p > 2. However, there is no proof given for this estimate in [8]. We shall prove this result in the following.

Proposition 4.4. Let m > 1 and p > 2. Let u be a positive, weak supersolution to (2.1)-(2.3) in an open set which compactly contains Q_T . There exists a positive constant γ depending only upon m, p, C_0 and C_1 , such that for every cylinder $Q_{t_1,t_2} = Q \times (t_1, t_2) \subset$

 Q_T , every k > 0 and every piecewise smooth, nonnegative cutoff function ζ vanishing on $\partial Q \times [t_1, t_2]$,

$$\frac{1}{2} \operatorname{ess\,sup}_{t_{1} \leq \tau \leq t_{2}} \int_{Q} (u-k)^{2}_{-}(\cdot,\tau)\zeta^{p}(\cdot,\tau)dx + \iint_{Q_{t_{1},t_{2}}} u^{m-1}|D(u-k)_{-}|^{p}\zeta^{p}dz \\
\leq \frac{1}{2} \iint_{Q_{t_{1},t_{2}}} (u-k)^{2}_{-} \left|\frac{\partial\zeta^{p}}{\partial t}\right| dz \\
+ \frac{1}{2} \int_{Q} (u-k)^{2}_{-}(\cdot,t_{1})\zeta^{p}(\cdot,t_{1})dx \\
+ \gamma \iint_{Q_{t_{1},t_{2}}} u^{m-1}(u-k)^{p}_{-}|D\zeta|^{p}dz.$$
(4.8)

Proof. Since the supersolution multiplied by a cut-off function cannot be used as testing function in the formula (4.7), we have to construct a suitable testing function. Let $\alpha = \frac{m+p-2}{p-1}$ and observe that $\alpha > 1$. For a fixed $\delta > 0$, we construct a function $G_{\delta}(v)$ by

$$G_{\delta}(v) = \begin{cases} v^{\frac{1}{\alpha}}, & \text{if } v > \delta, \\ \delta^{\frac{1}{\alpha}} + \frac{1}{\alpha} \delta^{\frac{1}{\alpha} - 1}(u - \delta), & \text{if } v \le \delta. \end{cases}$$

It can be easily seen that $G_{\delta}(v)$ is a Lipschitz function with respect to v. Moreover, for a fixed λ with $0 < \lambda < \frac{1}{10}k$, we introduce an auxiliary function

$$F_{\lambda}(s) = \begin{cases} 0, & \text{if } s \ge k, \\ k - s, & \text{if } \lambda < s < k, \\ k - \lambda, & \text{if } s \le \lambda. \end{cases}$$

Alternatively, $F_{\lambda}(s) = [(s - \lambda)_{+} + \lambda - k]_{-}$ for all s > 0. It is easy to check that $F_{\lambda}(s)$ is a Lipschitz function as well. At this stage, we define

$$\tilde{F}(v) = F_{\lambda}[G_{\frac{\lambda^{\alpha}}{2}}(v)].$$

We conclude from (2.4) and [28, Theorem 2.1.11] that $\tilde{F}(u^{\alpha})(\cdot, t) \in W^{1,p}(Q)$ for almost every $t \in (0, T)$ and there holds

$$\frac{\partial}{\partial x_{i}}\tilde{F}(u^{\alpha}) = -\chi_{[\lambda < G_{\frac{1}{2}\lambda^{\alpha}}(u^{\alpha}) < k]} \frac{\partial}{\partial x_{i}} G_{\frac{\lambda^{\alpha}}{2}}(u^{\alpha}) = -\chi_{[\lambda < u < k]} G'_{\frac{\lambda^{\alpha}}{2}}(u^{\alpha}) \frac{\partial u^{\alpha}}{\partial x_{i}}
= -\alpha^{-1} \chi_{[\lambda < u < k]} u^{1-\alpha} \frac{\partial u^{\alpha}}{\partial x_{i}}$$
(4.9)

where $i = 1, \dots, N$. Hence $\tilde{F}(u^{\alpha}) \in L^p(0, T; W^{1,p}(Q))$ and $D\tilde{F}(u^{\alpha}) = -\chi_{[\lambda < u < k]}Du$.

We are now in a position to construct the testing function. Let $\tau \in (t_1, t_2)$ be a fixed instant and $Q_{\tau} = Q \times (t_1, \tau)$. Set $\theta_{\nu} = \theta_{\nu}(t)$ be as in (4.3) with t_2 replaced by τ . In the inequality (4.7) we choose $\phi = \tilde{F}(u^{\alpha})\zeta^{p}\theta_{\nu}$ as a testing function. Since $\tilde{F}(u^{\alpha}) = F_{\lambda}(u)$, we conclude that

$$\iint_{Q_{\tau}} F_{\lambda}(u)\zeta^{p}\theta_{\nu}\frac{\partial u^{*}}{\partial t}dz + \iint_{Q_{\tau}} \left[A(x,t,u,Du)\right]^{*} \cdot D\left[F_{\lambda}(u)\zeta^{p}\theta_{\nu}\right]dz \ge 0.$$
(4.10)

From (4.6), we have $\partial u^*/\partial t = (u - u^*)/\sigma$. We decompose the first integral as follows

which implies that

(4.11)

The task is now to estimate the right hand side of (4.11). We set $f_{\lambda}(s) = \int_{s}^{k} F_{\lambda}(r) dr$ and observe that

$$f_{\lambda}(s) = \begin{cases} \frac{1}{2}(k-\lambda)^{2} + (\lambda - s)(k-\lambda), & 0 < s \le \lambda, \\ \frac{1}{2}(k-s)^{2}, & \lambda < s \le k, \\ 0, & s > k. \end{cases}$$

Moreover, we see that

Using integration by parts and noting that $\theta_{\nu}(t_1) = \theta_{\nu}(\tau) = 0$, we obtain

$$\iint_{Q_{\tau}} F_{\lambda}(u^{*})\zeta^{p}\theta_{\nu}\frac{\partial u^{*}}{\partial t}dz = \iint_{Q_{\tau}} f_{\lambda}(u^{*})\zeta^{p}\frac{\partial \theta_{\nu}}{\partial t}dz + \iint_{Q_{\tau}} f_{\lambda}(u^{*})\theta_{\nu}\frac{\partial \zeta^{p}}{\partial t}dz.$$
(4.13)

By substituting (4.13) into (4.11), we obtain from (4.10) that

$$\iint_{Q_{\tau}} \left[A(x,t,u,Du) \right]^* \cdot D \left[F_{\lambda}(u) \zeta^p \right] \theta_{\nu} dz$$

$$\geq -\iint_{Q_{\tau}} f_{\lambda}(u^*) \zeta^p \frac{\partial \theta_{\nu}}{\partial t} dz - \iint_{Q_{\tau}} f_{\lambda}(u^*) \theta_{\nu} \frac{\partial \zeta^p}{\partial t} dz.$$
(4.14)

Taking (4.12) into consideration, we check at once that $f_{\lambda}(s)$ is a Lipschitz function with respect to *s*. Therefore we can pass to the limit $\sigma \downarrow 0$ in (4.14). We first let $\sigma \downarrow 0$ and then $\nu \downarrow 0$ in (4.14), there holds

$$\iint_{Q_{\tau}} A(x, t, u, Du) \cdot D\left(F_{\lambda}(u)\zeta^{p}\right) dz + \iint_{Q_{\tau}} f_{\lambda}(u) \frac{\partial \zeta^{p}}{\partial t} dz + \int_{Q} f_{\lambda}(u)(\cdot, t_{1})\zeta^{p}(\cdot, t_{1}) dx$$

$$\geq \int_{Q} f_{\lambda}(u)(\cdot, \tau)\zeta^{p}(\cdot, \tau) dx.$$
(4.15)

At this stage, we decompose the first term on the left hand side,

$$\iint_{Q_{\tau}} A(x, t, u, Du) \cdot D(F_{\lambda}(u)\zeta^{p}) dz$$

$$= \iint_{Q_{\tau}} F'_{\lambda}(u)\zeta^{p}A(x, t, u, Du) \cdot Dudz$$

$$+ \iint_{Q_{\tau}} p\zeta^{p-1}F_{\lambda}(u)A(x, t, u, Du) \cdot D\zeta dz$$

$$=: T_{1}(\lambda) + T_{2}(\lambda).$$
(4.16)

To estimate $T_1(\lambda)$, we use (2.2) to obtain

$$T_1(\lambda) \le -C_0 \iint_{\mathcal{Q}_{\tau} \cap [\lambda < u < k]} u^{m-1} |Du|^p \zeta^p dz =: -C_0 S(\lambda), \tag{4.17}$$

with the obvious meaning of $S(\lambda)$. To proceed further, we check that $S(\lambda) < +\infty$ for any $\lambda > 0$. This can be seen as follows

$$S(\lambda) = \frac{1}{\alpha^p} \iint_{\mathcal{Q}_\tau \cap [\lambda < u < k]} u^{-\frac{m-1}{p-1}} |Du^{\alpha}|^p \zeta^p dz \le \frac{\lambda^{-\frac{m-1}{p-1}}}{\alpha^p} \iint_{\mathcal{Q}_\tau} |Du^{\alpha}|^p \zeta^p dz < +\infty,$$

since $Du = \alpha^{-1}u^{1-\alpha}Du^{\alpha}$, m > 1 and p > 2. Now we come to the estimate of $T_2(\lambda)$. Applying Young's inequality and (2.2), we obtain

$$T_{2}(\lambda) \leq C_{1} p \alpha^{1-p} k \iint_{\mathcal{Q}_{\tau} \cap [u \leq \lambda]} |Du^{\alpha}|^{p-1} \zeta^{p-1} |D\zeta| dz + \frac{C_{0}}{2} \iint_{\mathcal{Q}_{\tau} \cap [\lambda \leq u \leq k]} u^{m-1} |Du|^{p} \zeta^{p} dz + \frac{2p^{p'} C_{1}^{p'}}{C_{0}(p')^{2}} \iint_{\mathcal{Q}_{\tau}} u^{m-1} (u-k)_{-}^{p} |D\zeta|^{p} dz.$$

$$(4.18)$$

where p' = p/(p-1). Combining estimates (4.15)-(4.18) and taking into account that $S(\lambda) < +\infty$, we absorb $S(\lambda)$ into the left hand side and obtain the estimate

$$\iint_{\mathcal{Q}_{\tau}\cap[u>\lambda]} u^{m-1} |D(u-k)_{-}|^{p} \zeta^{p} dz + \int_{\mathcal{Q}} f_{\lambda}(u)(\cdot,\tau) \zeta^{p}(\cdot,\tau) dx \\
\leq \iint_{\mathcal{Q}_{\tau}} f_{\lambda}(u) \left| \frac{\partial \zeta^{p}}{\partial t} \right| dz + \int_{\mathcal{Q}} f_{\lambda}(u)(\cdot,t_{1}) \zeta^{p}(\cdot,t_{1}) dx \\
+ \gamma k \iint_{\mathcal{Q}_{\tau}\cap[u\leq\lambda]} |Du^{\alpha}|^{p-1} \zeta^{p-1} |D\zeta| dz + \gamma \iint_{\mathcal{Q}_{\tau}} u^{m-1} (u-k)^{p}_{-} |D\zeta|^{p} dz,$$
(4.19)

where γ depends only on m, p, C_0 and C_1 . Our task now is to pass to the limit $\lambda \downarrow 0$ in (4.19). We observe from (4.12) that $f_{\lambda}(s)$ is decreasing with respect to λ . By monotone convergence theorem, we deduce

as $\lambda \downarrow 0$. Furthermore, we conclude from (2.4) and Lebesgue dominated theorem that

$$\iint_{\mathcal{Q}_{\tau}\cap[u\leq\lambda]} |Du^{\alpha}|^{p-1} \zeta^{p-1} |D\zeta| dz \to 0 \quad \text{as} \quad \lambda \downarrow 0,$$

hence that

Finally, we use monotone convergence theorem again to the integral involving gradient, there holds

Taking into account that u > 0 almost everywhere in Q_T , we arrive at

and taking the supremum over $\tau \in (t_1, t_2)$ proves the Proposition.

Proposition 4.5. Let m + p > 3 and 0 < m < 1. Let u be a positive, weak supersolution to (2.1)-(2.3) in an open set which compactly contains Q_T . There exists a positive constant γ depending only upon m, p, C_0 and C_1 , such that for every cylinder $Q_{t_1,t_2} = Q \times (t_1,t_2) \subset Q_T$, every k > 0 and every piecewise smooth, nonnegative cutoff function ζ vanishing on $\partial Q \times [t_1, t_2]$,

$$\begin{aligned} \underset{t_{1} \leq \tau \leq t_{2}}{\text{ess sup}} & \int_{Q} (u-k)_{-}^{2}(\cdot,\tau) \zeta^{p}(\cdot,\tau) dx + k^{m-1} \iint_{Q_{t_{1},t_{2}}} |D(u-k)_{-}|^{p} \zeta^{p} dz \\ \leq & \gamma k \int_{Q} (u-k)_{-}(\cdot,t_{1}) \zeta^{p}(\cdot,t_{1}) dx \\ & + \gamma k \iint_{Q_{t_{1},t_{2}}} (u-k)_{-} \left| \frac{\partial \zeta}{\partial t} \right| dz \\ & + \gamma k^{m+p-1} \iint_{Q_{t_{1},t_{2}}} \chi_{[u \leq k]} |D\zeta|^{p} dz. \end{aligned}$$

$$(4.20)$$

Proof. To start with, we fix a $\tau \in (t_1, t_2)$ and define $Q_{\tau} = Q \times (t_1, \tau)$. Let $\theta_{\nu}(t)$ be as in (4.3) with $t_2 = \tau$. We observe from the assumption m + p > 3 and 0 < m < 1 that $\alpha < 1$. This motivates us to choose the testing function

$$\phi(x,t) = \left[u(x,t)^{\alpha} - k^{\alpha}\right]_{-} \zeta(x,t)^{p} \theta_{\nu}(t)$$
(4.21)

in the weak form (4.7). From (2.4), we check that $\phi \in L^p(0, T; W_0^{1,p}(Q))$. Therefore, ϕ is an admissible test function and this yields

Concerning the second integral on the left hand side, we use (4.6) to write

$$= \iint_{Q_{\tau}} [(u^{*})^{\alpha} - k^{\alpha}]_{-} \zeta^{p} \theta_{\nu} \frac{\partial u^{*}}{\partial t} dz$$

$$+ \iint_{Q_{\tau}} \zeta^{p} \theta_{\nu} [(u^{\alpha} - k^{\alpha})_{-} - ((u^{*})^{\alpha} - k^{\alpha})_{-}] \frac{u - u^{*}}{\sigma} dz.$$
(4.23)

Notice that the function $f(s) = (s^{\alpha} - k^{\alpha})_{-}$ is decreasing with respect to s, we have

$$\iint_{Q_{\tau}} \zeta^{p} \theta_{\nu} \left[(u^{\alpha} - k^{\alpha})_{-} - ((u^{*})^{\alpha} - k^{\alpha})_{-} \right] \frac{u - u^{*}}{\sigma} dz \le 0.$$

Combining (4.22)-(4.34), we arrive at

$$\iint_{Q_{\tau}} \left[(u^*)^{\alpha} - k^{\alpha} \right]_{-\zeta} \zeta^p \theta_{\nu} \frac{\partial u^*}{\partial t} dz + \iint_{Q_{\tau}} \left[A(x, t, u, Du) \right]^* \cdot D \left[(u^{\alpha} - k^{\alpha})_{-\zeta} \zeta^p \theta_{\nu} \right] dz \ge 0.$$
(4.25)

To proceed further, we use the method as employed in the proof of [9, Proposition 2.1] to deal with the first integral on the left hand side of (4.25). We first observe that

$$\frac{\partial u^*}{\partial t}[(u^*)^{\alpha}-k^{\alpha}]_{-}=-\frac{\partial}{\partial t}\int_{u^*}^k(k^{\alpha}-s^{\alpha})_{+}ds.$$

At this stage, we combine the estimates (4.25)-(4.26) and pass to the limits $\sigma \downarrow 0$ and $\nu \downarrow 0$. We arrive at

Since $\alpha p - \alpha + 1 = m + p - 1$, the previous estimate yields (4.20).

Up to now we have studied Caccioppoli estimates involving the truncated functions $(u - k)_-$, which will be used in Section 5-6. However, in order to perform the Moser's iteration, we need Caccioppoli estimates of the following type. Our proof is in the spirit of [21, Lemma 2.4]. Since the weak supersolution multiplied by a cut-off function cannot be used as a testing function in the weak form (4.7), we have to perform a refined analysis to overcome this difficulty.

Proposition 4.6. Let p > 2, m + p > 3 and $\varepsilon \in (-1, 0)$. Suppose that u is a positive, weak supersolution to (2.1)-(2.3) in an open set which compactly contains Q_T . There exists a positive constant γ depending only upon m, p, C_0 and C_1 , such that for every cylinder $Q_{t_1,t_2} = Q \times (t_1, t_2) \subset Q_T$ and every non-negative function $\varphi \in C_0^{\infty}(Q_T)$,

\leq \gamma \left(\frac{1}{|\varepsilon|^{p}} \iint_{Q_{t_{1},t_{2}}} u^{m+p+\varepsilon-2} |D\varphi|^{p} dz + \iint_{Q_{t_{1},t_{2}}} u^{1+\varepsilon} \frac{1}{\varepsilon(1+\varepsilon)} \frac{\partial \varphi^{p}}{\partial t} dz \right).$$

If, in addition, $\varphi = 0$ on $Q \times \{t_2\}$, then

Proof. Our first destination is to construct a suitable testing function. Let $\delta = -\frac{\varepsilon}{\alpha}$. For $\lambda > 0$, we invoke the auxiliary function

where γ depends only upon *m*, *p*, C_0 and C_1 . The task now is to show the convergence of the integrals in (4.40) as $\lambda \downarrow 0$. $$\iint_{Q_{\tau_{1},\tau_{2}}} h_{\lambda}(u) \left(-\frac{\partial\varphi^{p}}{\partial t}\right)_{+} dz \to \iint_{Q_{\tau_{1},\tau_{2}}} \frac{u^{1+\varepsilon}}{1+\varepsilon} \left(-\frac{\partial\varphi^{p}}{\partial t}\right)_{+} dz \tag{4.42}$$

as $\lambda \downarrow 0$, by the monotone convergence theorem. To handle the first term on the right hand side of (4.41), we calculate

which proves (4.29) by setting $\tau_1 = t_1$ and $\tau_2 = t_2$. Moreover, if $\varphi = 0$ on $Q \times \{t_2\}$, then we choose $\tau_2 = t_2$ and take the supremum over $\tau_1 \in (t_1, t_2)$ in (4.45). This proves estimate (4.30). The proof of the proposition is now complete.

5. EXPANSION OF POSITIVITY

In this section, we will prove the expansion positivity property for positive, weak supersolutions of doubly degenerate parabolic equations. This property asserts that some positive information of *u* at some time level *s*, over the cube $K_{\varrho}(y)$, propagates to further times $s + \theta \varrho^2$, and a larger cube $K_{2\varrho}(y)$. Here and subsequently, $Q_{\varrho}^{\pm}(\theta)$ stand for "forward" and "backward" parabolic cylinders of the form

$$Q_{\varrho}^{+}(\theta) = K_{\varrho} \times (-\theta \varrho^{p}, 0], \quad Q_{\varrho}^{-}(\theta) = K_{\varrho} \times (0, \theta \varrho^{p}],$$

where θ is a positive parameter. To start with, we prove the following De-Giorgi type Lemma.

Lemma 5.1. Let u be a positive, weak supersolution of (2.1)-(2.3) in an open set which compactly contains $Q_{2\varrho}^-(\theta)$ and $a \in (0, 1)$ be a fixed number. There exists a number ν_- depending only upon m, p, C_0 , C_1 and a, such that if

Proof. The argument is standard and we just sketch the proof. For $n = 0, 1, 2, \cdots$ set

To proceed further, we first consider the case m + p > 3 and 0 < m < 1. We apply the Caccioppoli estimate (4.20) on the cylinder Q_n for $(u - k_n)_-$ to obtain

$$\begin{aligned} \underset{-\theta\varrho_{n}^{p} < t \leq 0}{\text{ess sup}} & \int_{K_{n}} (u - k_{n})_{-\zeta}^{2} \zeta^{p} dx + k_{n}^{m-1} \int_{-\theta\varrho_{n}^{p}}^{0} \int_{K_{n}} |D(u - k_{n})_{-}|^{p} \zeta^{p} dz \\ & \leq \gamma k_{n} \frac{2^{p(n+1)}}{\theta\varrho^{p}} \iint_{Q_{n}} (u - k_{n})_{-} dz + \gamma k_{n}^{m+p-1} \iint_{Q_{n}} \chi_{[u \leq k_{n}]} |D\phi|^{p} dz \\ & \leq \gamma \frac{2^{np} M^{m+p-1}}{\varrho^{p}} \left(1 + \frac{1}{\theta M^{m+p-3}}\right) |Q_{n} \cap [u < k_{n}]|. \end{aligned}$$

At this stage, we use Proposition 3.1 together with (5.3) to infer that

where $b = 2\frac{p^2}{N} + p + p\frac{N+2}{N}$ and γ depends only upon N, m, p, C_0 and C_1 . From Lemma 4.1 of Chapter I in [4], it follows that $Y_n \to 0$ as $n \to \infty$, provided $Y_0 \le \nu_-$ where

$$\nu_{-} = \gamma^{-\frac{N}{p}} b^{-\frac{N^{2}}{p^{2}}} (1-a)^{N+2} \frac{(\theta M^{m+p-3})^{\frac{N}{p}}}{(1+\theta M^{m+p-3})^{1+\frac{N}{p}}}.$$
(5.4)

Finally, using the same argument as in the proof of [8, Lemma 3.3], we can easily carry out the proof of this lemma in the case p > 2 and m > 1, with ν_{-} defined in (5.4). We omit the details.

The next lemma deals with the expansion of positivity which translates a positive information to further times but within the same cube.

Lemma 5.2. Let u be a positive, weak supersolution of (2.1)-(2.3) in an open set which compactly contains E_T . Suppose that for $(y, s) \in E_T$ and $\varrho > 0$ there holds

$$\left| \left[u(\cdot, s) \ge M \right] \cap K_{\varrho}(y) \right| \ge \mu |K_{\varrho}(y)| \tag{5.5}$$

for some M > 0 and some $\mu \in (0, 1)$. There exist κ and δ in (0, 1), depending only upon the data p, m, N, C_0 , C_1 and μ , independent of M, such that

Proof. Without loss of generality, we may assume (y, s) = (0, 0). This is always possible by using a translation. For k > 0 and t > 0 set $A_{k,\varrho}(t) = [u(\cdot, t) < k] \cap K_{\varrho}$. The assumption (5.5) yields $|A_{M,\varrho}(0)| \le (1 - \mu)|K_{\varrho}|$.

We now apply Caccioppoli estimates for the truncated functions $(u - M)_{-}$ over cylinder $K_{\varrho} \times (0, \theta \varrho^{p}]$ where $\theta > 0$ is to be determined. The cut-off function ζ is taken of the form $\zeta = \zeta(x)$ and such that $\zeta = 1$ on $K_{(1-\sigma)\varrho}$, and $|D\zeta| \leq (\sigma \varrho)^{-1}$. In the case m + p > 3, 0 < m < 1, we use Caccioppoli estimate (4.20) to obtain

$$\begin{aligned} \underset{t \in (0,\theta\varrho^{p}]}{\operatorname{ess sup}} & \int_{K_{(1-\sigma)\varrho}} (u-M)_{-}^{2}(\cdot,t) dx \\ & \leq \gamma M \int_{K_{\varrho}} (u-M)_{-}(\cdot,0) \zeta^{p}(\cdot,0) dx + \gamma M^{m+p-1} \int_{0}^{\theta\varrho^{p}} \int_{K_{\varrho}} \chi_{[u

$$(5.7)$$$$

In the case p > 2, m > 1, we use Caccioppoli estimate (4.8) to obtain

$$\begin{aligned} \underset{t\in(0,\theta\varrho^{p}]}{\operatorname{ess\,sup}} &\int_{K_{(1-\sigma)\varrho}} (u-M)_{-}^{2}(\cdot,t) dx \\ &\leq \frac{1}{2} \int_{K_{\varrho}} (u-M)_{-}^{2}(\cdot,0) \zeta^{p}(\cdot,0) dx + \gamma \int_{0}^{\theta\varrho^{p}} \int_{K_{\varrho}} u^{m-1} (u-M)_{-}^{p} |D\zeta|^{p} dx dt \\ &\leq \frac{1}{2} \int_{K_{\varrho}} (u-M)_{-}^{2}(\cdot,0) dx + \gamma \frac{M^{m+p-1}}{(\sigma\varrho)^{p}} \int_{0}^{\theta\varrho^{p}} \int_{K_{\varrho}} \chi_{[u

$$(5.8)$$$$

Combining estimates (5.7) and (5.8), we conclude that, in either case, the estimate

$$\int_{K_{(1-\sigma)\varrho}} (u-M)_{-}^{2}(\cdot,t) dx \leq \gamma M^{2} \left((1-\mu) + \frac{\theta M^{m+p-3}}{\sigma^{p}} \right) |K_{\varrho}|$$

holds for all $t \in (0, \theta \rho^p]$. Furthermore, we estimate the left hand side from below

$$\int_{K_{(1-\sigma)\varrho}} (u-M)^2_{-}(\cdot,t)dx \ge \int_{K_{(1-\sigma)\varrho}\cap [u<\kappa M]} (u-M)^2_{-}(\cdot,t)dx \ge M^2(1-\kappa)^2 |A_{\kappa M,(1-\sigma)\varrho}(t)|,$$

where κ is to be determined later. Recalling from the proof of Lemma 1.1 in [7, chapter 2] that $|A_{\kappa M,\varrho}(t)| \leq |A_{\kappa M,(1-\sigma)\varrho}(t)| + N\sigma |K_{\varrho}|$, we obtain

$$\begin{aligned} |A_{\kappa M,\varrho}(t)| &\leq \frac{1}{M^2(1-\kappa)^2} \int_{K_{(1-\sigma)\varrho}} (u-M)^2_{-}(\cdot,t) dx + N\sigma |K_{\varrho}| \\ &\leq \frac{1}{(1-\kappa)^2} \left(1-\mu+\frac{\gamma}{\sigma^p} \theta M^{m+p-3} + N\sigma\right) |K_{\varrho}|. \end{aligned}$$

We have established an estimate for the measure of level set, and now we choose

$$\theta = \delta M^{3-p-m}, \quad \sigma = \frac{\mu}{64N}, \quad \delta = \frac{\mu^{p+1}}{4^{3p+4}\gamma N} \quad \text{and} \quad \kappa = \frac{1}{64}\mu.$$
(5.9)

Then for such choices the lemma follows.

With the help of the preceding two lemmas, we can now prove the main result of this section. Our proof is based on the idea from [7, chapter 2].

Proposition 5.3. Let u be a positive, weak supersolution of (2.1)-(2.3) in an open set which compactly contains E_T . Suppose that for some $(y, s) \in E_T$ and some $\rho > 0$ there holds

Moreover, the functional dependence of η on the parameter μ is of the form

$$\eta = \eta_0 \mu B^{-\mu^{-d}} \tag{5.12}$$

for constants η_0 , *B*, *d* depending only upon the data *p*, *m*, C_0 and C_1 .

Proof. Without loss of generality, we may prove the proposition in the case that (y, s) = (0, 0). This is always possible by using a translation. In the following, we divide our proof in three steps.

Step 1. Changing the time variable. Observe that assumption (5.10) implies

$$\left| [u(\cdot, 0) > \sigma M] \cap K_{\varrho} \right| \ge \mu |K_{\varrho}|$$

for all $\sigma \le 1$. We now use Lemma 5.2 with *M* replaced by σM and conclude that, with κ , δ defined in (5.9), there holds

For $\tau \ge 0$, set

$$\sigma = e^{-\frac{\tau}{p+m-3}}, \quad t(\tau) = \frac{e^{\tau}}{M^{p+m-3}}\delta\varrho^p \text{ and } \nu(\tau) = \frac{1}{M}e^{\frac{\tau}{p+m-3}}(\delta\varrho^p)^{\frac{1}{p+m-3}}.$$

At this stage, we set $v(x, \tau) = v(\tau)u(x, t(\tau))$. Notice from (5.13) that

$$\left| \left[v\left(\cdot,\tau\right) > M_0 \right] \cap K_{\varrho} \right| \ge \frac{1}{2} \mu |K_{\varrho}| \tag{5.14}$$

for all $\tau \ge 0$, where $M_0 := \kappa(\delta \varrho^p)^{1/(p+m-3)}$. Denote by $\tilde{A} : E \times \mathbb{R}^+ \times \mathbb{R}^{N+1} \to \mathbb{R}^N$ the vector field:

$$\tilde{A}(x,\tau,v,Dv) = v(\tau)^{p+m-2} A\left[x,t(\tau),u(x,t(\tau)),Du(x,t(\tau))\right]$$

Then the function v is a weak supersolution to $\partial_{\tau}v - \text{div}\tilde{A}(x, \tau, v, Dv) = 0$, i.e., the inequality

$$-\int_{0}^{+\infty}\int_{E}v\frac{\partial\phi}{\partial\tau}dxd\tau+\int_{0}^{+\infty}\int_{E}\tilde{A}(x,\tau,v,Dv)\cdot D\phi dxd\tau\geq 0$$

holds for any non-negative test function $\phi \in C_0^{\infty}[E \times (0, +\infty)]$. The structure conditions for $\tilde{A}(x, \tau, v, Dv)$ are as follows:

$$\begin{cases} \tilde{A}(x,\tau,v,Dv) \cdot Dv \ge \tilde{C}_0 |v|^{m-1} |Dv|^p, \\ |\tilde{A}(x,\tau,v,Dv)| \le \tilde{C}_1 |v|^{m-1} |Dv|^{p-1}, \end{cases}$$

for some constants \tilde{C}_0 and \tilde{C}_1 depending only upon *m*, *p*, *C*₀ and *C*₁. For the proof, see for example [8].

Step 2. Expanding the positivity of v. Let ζ be a piecewise smooth cut-off function vanishes on the parabolic boundary $Q_{16o}^+(\theta)$ such that

$$\zeta = 1 \quad \text{in} \quad Q_{8\varrho}(\theta) := K_{8\varrho} \times (\theta(8\varrho)^p, \theta(16\varrho)^p], \quad |D\zeta| \le \frac{1}{8\varrho} \quad \text{and} \quad |\partial_t \zeta| \le \frac{1}{\theta(8\varrho)^p}$$

In the case m > 1 and p > 2, we use the Caccioppoi estimate (4.8) for $(v - k)_{-}$ and the test function ζ defined above to infer

$$\begin{split} \iint_{\mathcal{Q}_{8\varrho}(\theta)} v^{m-1} |D(v-k)|^p dx d\tau \\ &\leq \frac{1}{2} \iint_{\mathcal{Q}_{16\varrho}^+(\theta)} (v-k)_-^2 \left| \frac{\partial \zeta^p}{\partial \tau} \right| dx d\tau + \gamma \iint_{\mathcal{Q}_{16\varrho}^+(\theta)} v^{m-1} (v-k)_-^p |D\zeta|^p dx d\tau \quad (5.15) \\ &\leq \gamma \left(\frac{k^2}{\theta(8\varrho)^p} + \frac{k^{p+m-1}}{(8\varrho)^p} \right) |\mathcal{Q}_{8\varrho}(\theta)|. \end{split}$$

In the case m + p > 3 and 0 < m < 1, we apply the Caccioppoi estimate (4.20) for $(v - k)_{-}$ with the same cut-off function ζ as above to get a gradient estimate

$$\iint_{\mathcal{Q}_{\delta\varrho}(\theta)} |D(v-k)_{-}|^{p} dx d\tau \\
\leq \gamma k^{2-m} \iint_{\mathcal{Q}_{16\varrho}^{+}(\theta)} (v-k)_{-} \left| \frac{\partial \zeta}{\partial \tau} \right| dx d\tau + \gamma k^{p} \iint_{\mathcal{Q}_{16\varrho}^{+}(\theta)} \chi_{[v \leq k]} |D\zeta|^{p} dx d\tau \qquad (5.16) \\
\leq \gamma \frac{k^{p}}{(8\varrho)^{p}} \left(1 + \frac{1}{\theta k^{p+m-3}} \right) |\mathcal{Q}_{8\varrho}(\theta)|.$$

At this point, we introduce the levels $k_j = 2^{-j}M_0$ with $j = 0, 1, \dots, j_*$ where j_* is to be taken depending on μ , m, p, C_0 and C_1 . In the gradient estimates (5.15) and (5.16), we choose $k = k_j$ and

$$\theta = k_{j_*}^{3-p-m} = (2^{j_*} M_0^{-1})^{p+m-3}.$$
(5.17)

If we set $v_j = \max\{k_{j+2}, v\}$, then the estimates (5.15) and (5.16) imply that

$$\iint_{\mathcal{Q}_{\delta\varrho}(\theta)} |D(v_j - k_j)|^p dx d\tau \le \gamma \frac{k_j^p}{(\vartheta\varrho)^p} |\mathcal{Q}_{\delta\varrho}(\theta)|.$$
(5.18)

To proceed further, we set

$$A_j(\tau) = \{v_j(\cdot, \tau) < k_j\} \cap K_{8\varrho} \quad \text{and} \quad A_j = \{v_j < k_j\} \cap Q_{8\varrho}(\theta).$$

We observe from the definition of v_j that $v_j = v$ on the set $A_j(\tau) \setminus A_{j+1}(\tau)$. Then we use Lemma 2.2 in [4, chapter I] and (5.14) to infer that

$$\frac{1}{2}k_{j}|A_{j+1}(\tau)| \leq \gamma \mu^{-1} \varrho \int_{[k_{j+2} < \nu(\cdot, \tau) < k_{j}] \cap K_{8\varrho}} |D\nu(\cdot, \tau)| dx.$$
(5.19)

Integrating both sides of (5.19) with respect to τ over $(\theta(8\varrho)^p, \theta(16\varrho)^p)$, using Hölder's inequality and taking into account (5.18), we conclude that

$$\frac{k_j}{2}|A_{j+1}| \leq \frac{\gamma\varrho}{\mu} \left(\iint_{\mathcal{Q}_{8\varrho}(\theta)} |D(v-k_j)|^p dx d\tau \right)^{\frac{1}{p}} |A_j \setminus A_{j+1}|^{\frac{p-1}{p}} \leq \frac{\gamma k_j}{\mu} |\mathcal{Q}_{8\varrho}(\theta)|^{\frac{1}{p}} |A_j \setminus A_{j+1}|^{\frac{p-1}{p}}.$$

We now proceed as in the proof of Proposition 4.1 in [7, chapter 2]. From the estimate above, we obtain

$$\left| \{ \nu < k_{j_*} \} \cap \mathcal{Q}_{8\varrho}(\theta) \right| = |A_{j_*}| \le \frac{1}{\mu} \left(\frac{\gamma}{j_*} \right)^{\frac{p-1}{p}} |\mathcal{Q}_{8\varrho}(\theta)|,$$
(5.20)

where j_* is to be chosen. At this stage, we are ready to invoke Lemma 5.1. With the choice of θ in (5.17), we obtain from (5.4) that $v_- = \gamma^{-\frac{N}{p}} 2^{-2N-3-\frac{3N}{p}-\frac{2N^2}{p}}$. We now choose j_* be an

Then we apply Lemma 5.1 to v with $M = k_{j_*}$ and $a = \frac{1}{2}$ over the parabolic cylinder $Q_{8\rho}(\theta) = (0, \tau_*) + Q_{8\rho}^-(\theta)$ where $\tau_* = \theta(16\rho)^p$, and conclude that

$$v(x,\tau) \ge \frac{1}{128} 2^{-j_*} \mu(\delta \varrho^p)^{\frac{1}{p+m-3}}$$
 a.e. in $(0,\tau_*) + Q^-_{4\varrho}(\theta)$. (5.21)

Step 3. Expanding the positivity of u. We shall adopt the same procedure as in the proof of Proposition 4.1 in [8]. As τ ranges over the interval $(\theta(16\varrho)^p - \theta(4\varrho)^p, \theta(16\varrho)^p)$, the function $e^{\frac{\tau}{p+m-3}}$ ranges over

$$b_1 := \exp\left\{\frac{(16^p - 4^p)2^{j_*(p+m-3)}}{(p+m-3)\delta\mu^{p+m-3}}\right\} \le e^{\frac{\tau}{p+m-3}} \le \exp\left\{\frac{16^p 2^{j_*(p+m-3)}}{(p+m-3)\delta\mu^{p+m-3}}\right\} =: b_2.$$

Let $\eta = (128b_2)^{-1}2^{-j_*}\mu$. Transforming (5.21) back to the time variable *t*, we have

$$u(x,t) \ge \eta M$$
 a.e. in $K_{2\varrho} \times \left(\frac{C^{p+m-3}}{(\eta M)^{p+m-3}}\frac{1}{2}\delta\varrho^p, \frac{C^{p+m-3}}{(\eta M)^{p+m-3}}\delta\varrho^p\right)$

for a suitable *C* depending only upon *p*, *m*, *C*₀, *C*₁ and μ . We have thus proved the proposition.

6. The Hot Alternative

The proof of Theorem 2.2 can be reduced by considering two alternatives. In this section, we shall discuss a situation which will be called the hot alternative. Before proceeding further, we remark that the exponential decay of η on parameter μ in Proposition 5.3 need to be improved. The next Lemma asserts that the functional dependence (5.12) can be sharpened to $\eta_* = \eta_0 \mu^{d+1}$. Our proof follows the scheme of [7, chapter 3, Proposition 7.1], which makes no use of covering arguments.

Lemma 6.1. Let u be a positive, weak supersolution of (2.1)-(2.3) in an open set which compactly contains E_T . Suppose that for some $(y, s) \in E_T$ and some $\rho > 0$ there holds

$$\left| \left[u(\cdot, s) \ge M \right] \cap K_{\varrho}(y) \right| \ge \mu |K_{\varrho}(y)| \tag{6.1}$$

for some M > 0 and some $\mu \in (0, 1)$. There exist constants η_0 , δ in (0, 1) and C, d > 0 depending only upon m, p, N, C_0 and C_1 , such that

$$u(\cdot, t) \ge \eta_* M \quad \text{a. e.} \quad \text{in} \quad K_{2\varrho}(y) \times \left(s + \frac{C^{p+m-3}}{(\eta_* M)^{p+m-3}} \frac{1}{2} \delta \varrho^p, s + \frac{C^{p+m-3}}{(\eta_* M)^{p+m-3}} \delta \varrho^p\right], \quad (6.2)$$

where $\eta_* = \eta_0 \mu^{d+1}$.

Proof. It suffices to prove the lemma in the case that (y, s) = (0, 0). This is always possible by using a translation. By Lemma 5.2, there exist δ and κ defined in (5.9), such that

$$\left| [u(\cdot, t) \ge \kappa M] \cap K_{\varrho}(y) \right| \ge \frac{1}{2} \mu |K_{\varrho}(y)|$$
(6.3)

for almost every $t \in (0, \delta M^{3-m-p} \varrho^p]$. In the following, the proof will be split into two steps.

Step 1. The estimate (6.3) revisited. We claim that there exists a time level t_1 in the range

$$M^{3-m-p}\frac{1}{2}\delta\varrho^p < t_1 \le M^{3-m-p}\delta\varrho^p, \tag{6.4}$$

and $x_0 \in K_{\rho}$ such that, with $\eta_* = \eta_1 \mu^{d_1}$,

$$\left| \left[u(\cdot, t_1) > \frac{1}{2} \kappa M \right] \cap K_{\eta_* \varrho}(x_0) \right| > \frac{1}{2} |K_{\eta_* \varrho}(x_0)|$$
(6.5)

where d_1 , η_1 are the constants depending only upon *m*, *p*, C_0 and C_1 .

In order to prove this assertion, we shall use Caccioppoli estimates in Proposition 4.4 and Proposition 4.5 for $(u - M)_{-}$ with the choice of a cut-off function ζ such that

$$\zeta = 1$$
 in Q , $\zeta = 0$ on $\partial_P Q'$,

and

$$0 \leq \frac{\partial \zeta}{\partial t} \leq \frac{4^p}{\delta M^{3-m-p} \varrho^p}, \quad |D\zeta| \leq \frac{4}{\varrho},$$

where

$$Q := K_{\varrho} \times \left(\frac{1}{2} \frac{\delta}{M^{p+m-3}} \varrho^p, \frac{\delta}{M^{p+m-3}} \varrho^p\right], \quad Q' := K_{2\varrho} \times \left(0, \frac{\delta}{M^{p+m-3}} \varrho^p\right].$$

In the case p > 2 and m > 1, we apply Caccioppoli estimate (4.8) for $(u - M)_{-}$ with the cut-off function ζ defined above to obtain

$$\begin{split} \iint_{Q} u^{m-1} |D(u-M)_{-}|^{p} dz &\leq \iint_{Q'} u^{m-1} |D(u-M)_{-}|^{p} \zeta^{p} dz \\ &\leq \iint_{Q'} (u-M)_{-}^{2} \left| \frac{\partial \zeta^{p}}{\partial t} \right| dz + 2\gamma \iint_{Q'} u^{m-1} (u-M)_{-}^{p} |D\zeta|^{p} dz \\ &\leq \gamma \frac{1}{\delta M^{1-m-p} \varrho^{p}} |Q|. \end{split}$$

If we introduce a cut-off function $v = \max \{u, \frac{1}{4}\kappa M\}$, then we obtain the estimate

$$\begin{split} \left(\frac{\kappa M}{4}\right)^{m-1} \iint_{Q} |D(v-M)_{-}|^{p} dz &\leq \iint_{Q} v^{m-1} |D(v-M)_{-}|^{p} dz \\ &= \iint_{Q \cap [v=u]} v^{m-1} |D(v-M)_{-}|^{p} dz + \iint_{Q \cap [v>u]} v^{m-1} |D(v-M)_{-}|^{p} dz \\ &\leq \iint_{Q} u^{m-1} |D(u-M)_{-}|^{p} dz \\ &\leq \gamma \frac{1}{\delta M^{1-m-p} \varrho^{p}} |Q|, \end{split}$$

since m > 1. Recalling from (5.9), we rewrite the above estimate as follows:

$$\iint_{Q} |D(v-M)_{-}|^{p} dz \leq \frac{\gamma M^{p}}{\delta \mu^{m-1} \varrho^{p}} |Q|.$$
(6.6)

From the definition of v and (6.3), we conclude that

$$\left| \left[v(\cdot, t) \ge \kappa M \right] \cap K_{\varrho}(y) \right| \ge \frac{1}{2} \mu |K_{\varrho}(y)| \tag{6.7}$$

for almost every $t \in (0, \delta M^{3-m-p} \rho^p]$. To proceed further, we introduce the change of variables

$$y = \frac{x}{\varrho}, \quad \tau = \frac{t}{\delta M^{3-m-p} \varrho^p} \quad \text{and} \quad \tilde{v} = \frac{(M-v)_+}{M}.$$

It follows from (5.9) and (6.6) that

$$\int_{\frac{1}{2}}^{1} \int_{K_1} |D\tilde{v}(y,\tau)|^p dy d\tau \le \frac{\gamma}{\mu^{m+p}}.$$
(6.8)

Moreover, we rewrite the estimate (6.7) in terms of \tilde{v} as follows:

$$|[\tilde{\nu}(\cdot,\tau) < 1 - \kappa] \cap K_1| \ge \frac{1}{2}\mu \quad \text{for all} \quad \tau \in \left(\frac{1}{2}, 1\right].$$
(6.9)

From (6.8) and (6.9), there exists a time level $\tau_1 \in (\frac{1}{2}, 1]$ such that

$$\int_{K_1} |D\tilde{v}(\cdot,\tau_1)| dy \leq \frac{\gamma}{\mu^{\frac{m+\mu}{p}}} \quad \text{and} \quad |[\tilde{v}(\cdot,\tau_1) < 1-\kappa] \cap K_1| \geq \frac{\mu}{2}.$$

At this point, we infer that there exists a $y_0 \in K_1$ such that,

$$\left| \left[\tilde{\nu}(\cdot, \tau_1) < 1 - \frac{1}{2}\kappa \right] \cap K_{\eta_*}(y_0) \right| \ge \frac{1}{2} |K_{\eta_*}(y_0)|, \quad \text{where} \quad \eta_* = \eta_1 \mu^{d_1}, \tag{6.10}$$

and d_1 , η_1 depending only upon *m* and *p* (see for instance [5]). Transforming the above estimate back to the original variables *x*, *t* and original function *v*, we see that there exists a time level t_1 in the range (6.4) and

$$\left| \left[\nu(\cdot, t_1) > \frac{1}{2} \kappa M \right] \cap K_{\eta, \varrho}(x_0) \right| > \frac{1}{2} |K_{\eta, \varrho}(x_0)|.$$
(6.11)

Recalling from $v = \max\left\{u, \frac{1}{4}\kappa M\right\}$ that

$$\left[v(\cdot,t_1)>\frac{1}{2}\kappa M\right]\cap K_{\eta,\varrho}(x_0)=\left[u(\cdot,t_1)>\frac{1}{2}\kappa M\right]\cap K_{\eta,\varrho}(x_0).$$

Then the estimate (6.11) implies (6.5), which proves the claim for the case p > 2 and m > 1.

We now turn our attention to the case p + m > 3 and 0 < m < 1. We use Caccioppoli estimate (4.20) for $(u - M)_{-}$ with the same cut-off function ζ to obtain

$$\begin{split} M^{m-1} \iint_{\mathcal{Q}'} |D(u-M)_{-}|^{p} \zeta^{p} dz &\leq \gamma M \iint_{\mathcal{Q}'} (u-M)_{-} \left| \frac{\partial \zeta}{\partial t} \right| dz + \gamma M^{m+p-1} \iint_{\mathcal{Q}'} \chi_{[u \leq M]} |D\zeta|^{p} dz \\ &\leq \gamma \frac{M^{p+m-1}}{\delta \varrho^{p}} |Q|, \end{split}$$

which yields

$$\iint_{Q} |D(u-M)_{-}|^{p} dz \leq \gamma \frac{M^{p}}{\delta \varrho^{p}} |Q|.$$
(6.12)

Observe that (6.12) is even better than (6.6) and the claim follows by the same method as in the previous case.

Step 2. Iterative arguments. The proof of this part follows in a same manner as the proof of [7, chapter 3, Proposition 7.1] and we just sketch the proof. By Proposition 5.3, there exist $\tilde{\eta}$ and $\tilde{\delta}$ in (0, 1) and *C* depending only upon the data *p*, *m*, *C*₀ and *C*₁, such that

$$u(\cdot, t_2) \ge \frac{1}{2} \kappa \tilde{\eta} M$$
 a.e. in $K_{2\eta_* \varrho}(x_0)$, (6.13)

for all times

$$t_1 + \frac{C^{p+m-3}}{(\kappa\tilde{\eta}M)^{p+m-3}} \frac{1}{2} \tilde{\delta}(\eta_*\varrho)^p \le t_2 \le t_1 + \frac{C^{p+m-3}}{(\kappa\tilde{\eta}M)^{p+m-3}} \tilde{\delta}(\eta_*\varrho)^p.$$

At this stage, we use Proposition 5.3 again from (6.13) with *M* replaced by $\frac{1}{2}\kappa\tilde{\eta}M$ and $\mu = 1$. This implies that there exist $\bar{\eta}$ and $\bar{\delta}$ in (0, 1) and \bar{C} depending only upon the data *p*, *m*, *C*₀, *C*₁, such that

$$u(\cdot, t_3) \ge \frac{1}{2} \kappa \bar{\eta} \tilde{\eta} M, \tag{6.14}$$

for almost every $x \in K_{4\eta_*\varrho}(x_0)$ and all times

$$t_{2} + \frac{\bar{C}^{p+m-3}}{(\kappa\bar{\eta}\tilde{\eta}M)^{p+m-3}} \frac{1}{2} \bar{\delta}(2\eta_{*}\varrho)^{p} \le t_{3} \le t_{1} + \frac{\bar{C}^{p+m-3}}{(\kappa\bar{\eta}\tilde{\eta}M)^{p+m-3}} \bar{\delta}(2\eta_{*}\varrho)^{p}.$$
(6.15)

From (6.14) and (6.15), repeated application of Proposition 5.3 with $\mu = 1$ enable us to deduce that

$$u(\cdot,t) \ge \frac{1}{2}\kappa\bar{\eta}^n\tilde{\eta}M$$
 a.e. in $K_{2^{n+2}\eta_*\varrho}(x_0),$

for any time level t satisfies

$$t_{n+1} + \frac{\bar{C}^{p+m-3}}{(\kappa\bar{\eta}^n\tilde{\eta}M)^{p+m-3}} \frac{1}{2}\bar{\delta}(2^{n+2}\eta_*\varrho)^p \le t \le t_{n+1} + \frac{\bar{C}^{p+m-3}}{(\kappa\bar{\eta}^n\tilde{\eta}M)^{p+m-3}}\bar{\delta}(2^{n+2}\eta_*\varrho)^p.$$

The iteration stops when $2^{n+2}\eta_* = 2$ and the estimate (6.1) follows with the choice

$$d = -d_1 \log_2 \bar{\eta}$$
 and $\eta_0 = 128^{-1} \bar{\eta}^{-2} (\frac{2}{\eta_1})^{\log_2 \bar{\eta}} \tilde{\eta}$

The proof of the lemma is now complete.

We now state the main result of this section. Here and subsequently, the condition (6.17) introduced in the following proposition is referred as *hot alternative*.

Proposition 6.2. Let d, η_0 and C be as in Lemma 6.1. Suppose that u is a positive, weak super-solution in an open set which compactly contains $K_2 \times (0, S_1]$ where

If there exist a time level $t_0 \in (0, 1]$ and a k > 1, such that

Proof. By reducing η_1 in (6.10), we deduce $1 + \frac{1}{2}C^{m+p-3}\eta_0^{-(p+m-3)}\delta \leq C^{m+p-3}\eta_0^{-(p+m-3)}\delta$. The estimate (6.18) follows immediately from Lemma 6.1 with $\varrho = 1$, $M = k^{1+\frac{1}{d}}$ and $\mu = k^{-\frac{1}{d}}$. This completes the proof.

7. The Cold Alternative

In this section, we consider the case complement to the hot alternative. We shall prove an analogue result of Proposition 6.2 in this case. The proof is based on a suitable modifications of Moser's iteration technique [23] following the adaptation of the Kuusi's technique [18] to doubly degenerate parabolic equations with ideas from [21]. To start with, we prove the following higher integrability result which plays a crucial role in the proof of the uniform estimates.

Lemma 7.1. Let u be a positive, weak supersolution in an open set which compactly contains $K_1 \times (0, 1]$. There exists a number v(p, N) depending only upon p and N, with 0 < v(p, N) < 1 such that for all q in the range

$$p + m - 3 < q < p + m - 2 + v(p, N)$$

and all s given by

$$s = p + m - 3 + (1 + v(p, N))^{-(n+1)} (q - (p + m - 3)), \quad n = 1, 2 \cdots$$

the following holds: if there exists a constant \tilde{C} depending only upon m, p, N, C_0 and C_1 , such that

$$\int_{0}^{1} \int_{K_{1}} u^{s} dx dt \leq \tilde{C}$$

$$\int_{0}^{a^{p}} \int_{K_{a}} u^{q} dx dt \leq C$$
(7.1)

for all $a \in (\frac{1}{2}, \frac{8}{9})$ and the constant C depending only upon m, p, N, C_0 , C_1 , s and q.

Proof. Throughout the proof, we set

$$\varrho_0 = 1, \quad \varrho_j = 1 - (1 - a) \frac{1 - 2^{-j}}{1 - 2^{-n-1}}, \quad K_j = K_{\varrho_j} \quad \text{and} \quad Q_j = K_{\varrho_j} \times (0, \varrho_j^p)$$

where $j = 0, 1, \dots, n + 1$. Moreover, we choose non-negative, smooth functions φ_j with support lying in Q_j , such that

$$\varphi_j = 1$$
 on Q_{j+1} , $\varphi_j = 0$ on $\partial Q_j \setminus (K_j \times \{0\})$,

$$|D\varphi_j| \le \frac{2^{j+1}}{1-a}$$
 and $0 \le -\frac{\partial \varphi_j}{\partial t} \le \frac{2^{p(j+1)}}{(1-a)^p}$, where $j = 0, 1, \cdots, n$.

Let $\varepsilon \in (-1, 0)$ be as in Proposition 4.5. At this stage, we want to apply parabolic Sobolev embedding estimates from Proposition 3.3.

In the case p < N, set

$$\sigma = p + m - 2 + \varepsilon, \quad \kappa = 1 + \frac{p(1 + \varepsilon)}{N(p + m - 2 + \varepsilon)}, \quad \beta = \frac{p(p + m - 2 + \varepsilon)}{1 + \varepsilon}.$$

We point out that $(\kappa - 1)N$ may less than one provided p is large and we cannot use the inequality (3.1) for $r = (\kappa - 1)N$. Instead, we use parabolic Sobolev inequality (3.4) to obtain

(7.2)

In the case p > N, set

$$\sigma = p + m - 2 + \varepsilon, \quad \kappa = 1 + \frac{N(1 + \varepsilon)}{p(p + m - 2 + \varepsilon)}, \quad \beta = \frac{p(p + m - 2 + \varepsilon)}{1 + \varepsilon}.$$

Using the parabolic Sobolev inequality (3.5) with

$$v = u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}}, \quad q = \frac{p}{N} \quad \text{and} \quad r = \frac{p(1+\varepsilon)}{p+m-2+\varepsilon},$$

then

we conclude that

$$\iint_{Q_{j+1}} u^{\kappa\sigma} dz \leq \iint_{Q_j} (u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}})^{p+\frac{r}{q}} dz$$

$$\leq \gamma \iint_{Q_j} |D(u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}})|^p dz \left(\operatorname{ess\,sup}_{0 < t < \varrho_j^p} \int_{K_j} (u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}})^{\frac{p(1+\varepsilon)}{p+m-2+\varepsilon}} dx \right)^{\frac{N}{p}}$$

$$= \gamma \iint_{Q_j} |D(u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}})|^p dz \left(\operatorname{ess\,sup}_{0 < t < \varrho_j^p} \int_{K_j} u^{1+\varepsilon} \varphi_j^p dx \right)^{\frac{N}{p}}.$$
(7.3)

In the case p = N, set

$$\sigma = N + m - 2 + \varepsilon, \quad \kappa = 1 + \frac{1 + \varepsilon}{2(N + m - 2 + \varepsilon)}, \quad \beta = \frac{N(N + m - 2 + \varepsilon)}{1 + \varepsilon}.$$

Applying the parabolic embedding estimate (3.6) with

$$v = u^{\frac{\sigma}{N}} \varphi_j^{\frac{\beta}{N}}$$
 and $r = \frac{N(1+\varepsilon)}{N+m-2+\varepsilon}$,

we deduce that

$$\iint_{\mathcal{Q}_{j+1}} u^{\kappa\sigma} dz \leq \iint_{\mathcal{Q}_{j}} (u^{\frac{\sigma}{N}} \varphi_{j}^{\frac{\beta}{N}})^{N+\frac{r}{2}} dz$$

$$\leq \gamma \iint_{\mathcal{Q}_{j}} |D(u^{\frac{\sigma}{N}} \varphi_{j}^{\frac{\beta}{N}})|^{p} dz \left(\operatorname{ess\,sup}_{0 < t < \mathcal{Q}_{j}^{N}} \int_{K_{j}} (u^{\frac{\sigma}{N}} \varphi_{j}^{\frac{\beta}{N}})^{\frac{N(1+\varepsilon)}{N+m-2+\varepsilon}} dx \right)^{\frac{1}{2}} \qquad (7.4)$$

$$= \gamma \iint_{\mathcal{Q}_{j}} |D(u^{\frac{\sigma}{N}} \varphi_{j}^{\frac{\beta}{N}})|^{p} dz \left(\operatorname{ess\,sup}_{0 < t < \mathcal{Q}_{j}^{N}} \int_{K_{j}} u^{1+\varepsilon} \varphi_{j}^{N} dx \right)^{\frac{1}{2}}.$$

Combining estimates (7.2)-(7.4) and set

$$\nu(p,N) = \begin{cases} \frac{p}{N}, & p < N, \\ \frac{1}{2}, & p = N, \\ \frac{N}{p}, & p > N, \end{cases}$$
(7.5)

we conclude that in either case, with

$$\sigma = p + m - 2 + \varepsilon, \quad \kappa = 1 + \nu(p, N) \frac{1 + \varepsilon}{p + m - 2 + \varepsilon}, \quad \beta = \frac{p(p + m - 2 + \varepsilon)}{1 + \varepsilon},$$

there holds

$$\iint_{\mathcal{Q}_{j+1}} u^{\kappa\sigma} dz \leq \gamma \iint_{\mathcal{Q}_j} |D(u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}})|^p dz \left(\operatorname{ess\,sup}_{0 < t < \mathcal{Q}_j^p} \int_{K_j} u^{1+\varepsilon} \varphi_j^p dx \right)^{\nu(p,N)}.$$
(7.6)

We now apply Caccioppoli estimate (4.30) to obtain

$$\operatorname{ess\,sup}_{0 < t < \mathcal{Q}_j^p} \int_{K_j} u^{1+\varepsilon} \varphi_j^p dx \le \frac{\gamma}{|\varepsilon|^p (1+\varepsilon)^p} \left(\iint_{\mathcal{Q}_j} u^{m+p+\varepsilon-2} |D\varphi_j|^p dz + \iint_{\mathcal{Q}_j} u^{1+\varepsilon} \left| \frac{\partial \varphi_j}{\partial t} \right| dz \right)$$

and

$$\begin{split} \iint_{Q_j} |D(u^{\frac{\sigma}{p}} \varphi_j^{\frac{\beta}{p}})|^p dz \\ &\leq \gamma \bigg(\iint_{Q_j} u^{m-2+\varepsilon} |Du|^p \varphi_j^p dz + \frac{1}{(1+\varepsilon)^p} \iint_{Q_j} u^{m+p+\varepsilon-2} |D\varphi_j|^p dz \bigg) \\ &\leq \frac{\gamma}{|\varepsilon|^p (1+\varepsilon)^p} \bigg(\iint_{Q_j} u^{m+p+\varepsilon-2} |D\varphi_j|^p dz + \iint_{Q_j} u^{1+\varepsilon} \left| \frac{\partial \varphi_j}{\partial t} \right| dz \bigg). \end{split}$$

Then we conclude that

$$\begin{split} \iint_{Q_{j+1}} u^{p+m-2+\varepsilon+(1+\varepsilon)\nu(p,N)} dz \\ &\leq \left[\frac{\gamma}{|\varepsilon|^p (1+\varepsilon)^p} \left(\iint_{Q_j} u^{m+p+\varepsilon-2} |D\varphi_j|^p dz + \iint_{Q_j} u^{1+\varepsilon} \left| \frac{\partial \varphi_j}{\partial t} \right| dz \right) \right]^{1+\nu(p,N)} \\ &\leq \left[\frac{\gamma}{|\varepsilon|^p (1+\varepsilon)^p} \frac{2^{p(j+1)}}{(1-a)^p} \left(\iint_{Q_j} u^{p+m+\varepsilon-2} dz + \iint_{Q_j} u^{1+\varepsilon} dz \right) \right]^{1+\nu(p,N)}. \end{split}$$

Furthermore, we obtain from Young's inequality that

$$\begin{split} u^{1+\varepsilon} &\leq u^{p+m+\varepsilon-2} + \frac{p+m-3}{p+m+\varepsilon-2} \left(\frac{p+m+\varepsilon-2}{1+\varepsilon}\right)^{-\frac{1+\varepsilon}{p+m-3}} \\ &\leq u^{p+m+\varepsilon-2} + \left(\frac{p+m-3}{1+\varepsilon}\right)^{-\frac{1+\varepsilon}{p+m-3}} \\ &\leq u^{p+m+\varepsilon-2} + \max\left\{1, e^{-\frac{1}{p+m-3}\ln(p+m-3)}\right\}, \end{split}$$

which implies

$$\iint_{\mathcal{Q}_{j+1}} u^{p+m-2+\varepsilon+(1+\varepsilon)\nu(p,N)} dz \leq \left[\frac{\gamma}{|\varepsilon|^p (1+\varepsilon)^p} \frac{2^{p(j+1)}}{(1-a)^p} \left(\iint_{\mathcal{Q}_j} u^{p+m+\varepsilon-2} dz + 1\right)\right]^{1+\nu(p,N)} dz$$

.

To proceed further, we set

$$\bar{h} = 1 + \nu(p, N), \quad \varepsilon_j = \bar{h}^j(\varepsilon_0 + 1) - 1, \quad \sigma_j = p + m - 2 + \varepsilon_j,$$

where $-1 < \varepsilon_0 < -1 + h^{-n}$. These choices imply the estimate

$$\iint_{\mathcal{Q}_{j+1}} u^{\sigma_{j+1}} dz \leq \left[\frac{\gamma}{|\varepsilon_j|^p (1+\varepsilon_j)^p} \frac{2^{p(j+1)}}{(1-a)^p} \left(\iint_{\mathcal{Q}_j} u^{\sigma_j} dz + 1 \right) \right]^{\bar{h}}$$

for $j = 0, 1, \dots, n$. Choosing $\varepsilon_0 = -1 + \bar{h}^{-1-n}(q - (p + m - 3))$, we see that

$$\frac{1}{|\varepsilon_j|^p (1+\varepsilon_j)^p} \le \frac{1}{|\varepsilon_n|^p (1+\varepsilon_0)^p} =: \bar{\gamma}(s, p, q, N)$$

and we finally have

Since $\sigma_0 = s$ and $\sigma_{n+1} = q$, then the estimate (7.1) follows by induction. The proof is completed.

Lemma 7.2. Let u be as in Lemma 7.1 and let d be as in Lemma 6.1. We assume that

$$[u(\cdot,t) > k^{1+\frac{1}{d}} \cap K_1]| \le k^{-\frac{1}{d}}|K_1|$$
(7.7)

for all $t \in (0, 1]$ and all level $k \ge 1$. Let v(p, N) be as in (7.5). Then for all q with

$$p + m - 3 < q < p + m - 2 + \nu(p, N)$$
(7.8)

there exists a constant γ depending only upon m, p, N, C₀, C₁ and q such that

$$\int_0^{\left(\frac{3}{4}\right)^p} \int_{K_{\frac{3}{4}}} u^q dx dt \le \gamma.$$
(7.9)

Proof. Set $\delta = 2^{-1}(d+1)^{-1}$. We deduce from (7.7) that

$$\int_{K_1} u^{\delta}(\cdot, t) dx \le \frac{2}{\delta} |K_1| \quad \text{for a. e.} \quad t \in (0, 1).$$

$$(7.10)$$

Fix time levels *s* and *r* with 7/8 < s < r < 1 and set $Q_s = K_s \times (0, 1]$, $Q_r = K_r \times (0, 1]$. Let $\varphi = \varphi(x)$ be a non-negative smooth function in K_r such that $0 \le \varphi \le 1$, $\varphi = 1$ in K_s and $|D\varphi| \le (r-s)^{-1}$. We now apply Proposition 3.3 and repeat the argument (7.2)-(7.6) in the proof of Lemma 7.1 with ε replaced by $\delta - 1$,

We are now in a position to use Caccioppoli estimate (4.29) with $\varepsilon = \delta - 1$,

At this stage, we deduce from [7, Preliminaries Lemma 5.2] that

Lemma 7.3. Let u be as in Lemma 7.2. Then there exists a constant $\tilde{\gamma}$ depending only upon m, p, N, C₀ and C₁ such that

$$\int_{0}^{\left(\frac{5}{8}\right)^{p}} \int_{K_{\frac{5}{8}}} u^{m-1} |Du|^{p-1} dx dt \le \tilde{\gamma}.$$
(7.11)

Proof. By Hölder's inequality

$$\begin{split} \iint_{\mathcal{Q}_{\frac{5}{8}}} u^{m-1} |Du|^{p-1} dz &= \iint_{\mathcal{Q}_{\frac{5}{8}}} (u^{m-1} u^{-\frac{(p-1)(m-\delta-2)}{p}}) (u^{\frac{(p-1)(m-\delta-2)}{p}} |Du|^{p-1}) dz \\ &\leq \left(\iint_{\mathcal{Q}_{\frac{5}{8}}} u^{p+m-\delta-2+\delta p} dz \right)^{\frac{1}{p}} \left(\iint_{\mathcal{Q}_{\frac{5}{8}}} u^{m-\delta-2} |Du|^{p} dz \right)^{\frac{p-1}{p}}, \end{split}$$

where $\delta = [4(p-1)]^{-1} v(p, N) < 1$. By Lemma 7.2, we see that

$$\iint_{Q_{\frac{5}{8}}} u^{p+m-\delta-2+\delta p} dz \le \gamma.$$

Moreover, we choose a test function $\varphi \in C^{\infty}(Q_{\frac{7}{8}})$, such that $0 \le \varphi \le 1$,

$$\varphi = 0$$
 on $\partial Q_{\frac{7}{8}} \setminus K_{\frac{7}{8}} \times \{0\}, \quad \varphi = 1$ on $Q_{\frac{5}{8}}$ and $|D\varphi| + \left(-\frac{\partial \varphi}{\partial t}\right)_+ \leq \gamma.$

Applying Caccioppoli estimate (4.30), with $\varepsilon = -\delta$ and the test function φ as defined above, the integral involving gradient is estimated by

$$\iint_{\mathcal{Q}_{\frac{5}{8}}} u^{m-\delta-2} |Du|^p dz \le \iint_{\mathcal{Q}_{\frac{7}{8}}} u^{m-\delta-2} |Du|^p \varphi^p dz$$
$$\le \gamma \iint_{\mathcal{Q}_{\frac{7}{8}}} u^{m+p-\delta-2} |D\varphi|^p dz + \gamma \iint_{\mathcal{Q}_{\frac{7}{8}}} u^{1-\delta} \left(-\frac{\partial \varphi}{\partial t}\right)_+ dz.$$

The Lemma follows by Lemma 7.2 and Hölder's inequality. We omit the details.

The following proposition is our main result in this section.

Proposition 7.4. There exist positive constants θ_0 , S_2 and η_1 , depending only upon m, p, N, C_0 and C_1 , such that if u is a positive, weak supersolution in an open set which compactly contains $K_2 \times (0, T_2]$,

$$\int_{K_{\frac{1}{2}}} u(x,0)dx \ge 2\theta_0,$$
(7.12)

and the condition (7.7) holds for all $t \in (0, 1]$ and all level $k \ge 1$, then there holds

$$u \ge \eta_1$$
 a.e. in $K_2 \times \left(1 + \frac{1}{2}S_2, S_2\right]$. (7.13)

Proof. In the inequality (4.5) we choose $\phi = \varphi(x)$ as a test function, where $\varphi \in C_0^{\infty}(K_{\frac{5}{8}})$, $0 \le \varphi \le 1, \varphi = 1$ in $K_{\frac{1}{2}}$ and $|D\varphi| \le 8$. Then, we infer from (7.12) that

$$\begin{split} \int_{K_{\frac{5}{8}}} u(x,t)dx &\geq \int_{K_{\frac{5}{8}}} u(x,t)\varphi(x)dx \\ &\geq \int_{K_{\frac{5}{8}}} u(x,0)\varphi(x)dx - \int_{0}^{(\frac{5}{8})^{p}} \int_{K_{\frac{5}{8}}} A(x,t,u,Du) \cdot D\varphi dxdu \\ &\geq \int_{K_{\frac{1}{2}}} u(x,0)dx - \int_{0}^{(\frac{5}{8})^{p}} \int_{K_{\frac{5}{8}}} u^{m-1}|Du|^{p-1}|D\varphi|dxdt \\ &\geq 2\theta_{0} - \tilde{\gamma} \geq \theta_{0} \end{split}$$

for any $t \in (0, (\frac{5}{8})^p]$, provided $\theta_0 \ge \tilde{\gamma}$. On the other hand, we use Lemma 7.2 to obtain

$$\int_0^{(\frac{5}{8})^p} \int_{K_{\frac{5}{8}}} u(x,t)^q dx dt \leq \gamma$$

for some q > 1 in the range (7.8). Then, there exists a time level $t_1 \in \left(0, \left(\frac{5}{8}\right)^p\right]$ such that

$$\int_{K_{\frac{5}{8}}} u(x,t_1) dx \ge \theta_0 \quad \text{and} \quad \int_{K_{\frac{5}{8}}} u(x,t_1)^q dx \le \gamma.$$

Hence, it follows from [18, Lemma 5.9] that

$$|[u(\cdot,t_1) \ge \frac{1}{2}\theta_0] \cap K_{\frac{5}{8}}| \ge \left(\frac{1}{2}\right)^{\frac{q}{q-1}} \gamma^{-\frac{1}{q-1}} |K_{\frac{5}{8}}|.$$

By Lemma 6.1, there exist constants η_0 , δ in (0, 1) and C, η_* , d > 0 depending only upon m, p, N, C_0 and C_1 , such that

$$u \ge \frac{1}{2}\eta_*\theta_0 \quad \text{a. e.} \quad \text{in} \quad K_2 \times \left(t_1 + \frac{C^{p+m-3}}{(\eta_*\theta_0)^{p+m-3}}\frac{1}{2}\delta, t_1 + \frac{C^{p+m-3}}{(\eta_*\theta_0)^{p+m-3}}\delta\right],$$

where

$$\eta_* = \eta_0 \left(\left(\frac{1}{2}\right)^{\frac{q}{q-1}} \gamma^{-\frac{1}{q-1}} \right)^{d+1}.$$

Therefore the estimate (7.13) follows by choosing

$$\eta_1 = \frac{1}{2}\eta_*\theta_0 \quad \text{and} \quad S_2 = \frac{C^{p+m-3}}{(\eta_*\theta_0)^{p+m-3}}.$$
(7.14)

This finishes the proof of Proposition 7.4.

8. Proofs of the Main Results

In this section we will prove the weak Harnack inequalities of positive, weak supersolutions to doubly nonlinear parabolic equations. The method of the proof has its origin in [18, 7]. Since most of the arguments are standard by now, we will only sketch the proof and refer the read to [7, chapter 3, section 13-14] for the details. 8.1. **Proof of Theorem 2.2.** Let $\tilde{\gamma}$ be the constant defined as in (7.11). Let $(y, s) \in E_T$ be a fixed point. We set $\tilde{M} = \int_{K_{\rho}(y)} u(x, s) dx$ and $M = (3\tilde{\gamma})^{-1}\tilde{M}$. We assume that M > 0, otherwise there is nothing to prove. Moreover, we introduce the change of variables

$$x' = \frac{x - y}{2\varrho}, \quad t' = M^{p+m-3} \frac{t - s}{\varrho^p} \quad \text{and} \quad v(x', t') = \frac{1}{M} u(y + 2\varrho x', s + M^{m+p-3} \varrho^p t').$$

From (2.5), it is easily seen that

$$-\int_{-M^{m+p-3}s\varrho^{-p}}^{M^{m+p-3}(T-s)\varrho^{-p}} \int_{K_8} v \frac{\partial \phi}{\partial t'} dx' dt' + \int_{-M^{m+p-3}s\varrho^{-p}}^{M^{m+p-3}(T-s)\varrho^{-p}} \int_{K_8} \tilde{A}(x',t',v,D_{x'}v) \cdot D_{x'}\phi \, dx' dt' \ge 0$$

for any non-negative test function $\phi = \phi(x', t')$ with

$$\phi \in C_0^{\infty} \left[K_8 \times (-M^{m+p-3} s \varrho^{-p}, M^{m+p-3} (T-s) \varrho^{-p}) \right],$$

where

$$\tilde{A}(x',t',v,D_{x'}v) = \frac{\varrho^{p-1}}{M^{p+m-2}} A\left(y + 2\varrho x', s + M^{p+m-3}\varrho^{p}t', Mv, \frac{M}{2\varrho}D_{x'}v\right).$$

From (2.2), we deduce

$$\begin{cases} \tilde{A}(x',t',v,D_{x'}v) \cdot D_{x'}v \ge 2^{1-p}C_0|v|^{m-1}|Dv|^p, \\ |\tilde{A}(x',t',v,D_{x'}v)| \le 2^{1-p}C_1|v|^{m-1}|Dv|^{p-1}, \end{cases}$$

which implies that v is a weak supersolution to the doubly degenerate parabolic equation

$$\partial_{t'} v - \operatorname{div} \tilde{A}(x', t', v, D_{x'} v) = 0$$

in the cylinder $K_8 \times (-M^{m+p-3}s\varrho^{-p}, M^{m+p-3}(T-s)\varrho^{-p})$. Furthermore, we observe that

$$\int_{K_{\frac{1}{2}}} v(x',0)dx' = 3\tilde{\gamma}.$$
(8.1)

Let S_1 and S_2 be as in (6.16) and (7.14) respectively. By reducing η_0 , we assume, without loss of generality, that min{ S_1, S_2 } ≥ 1 . Furthermore, we need only consider the case

$$M^{p+m-3}\frac{T-s}{\varrho^p} > \max\{S_1, S_2\} > 1,$$

since otherwise there is nothing to prove. We infer from (8.1) that either Proposition 6.2 or Proposition 7.4 holds. By a suitable modification of the constants, there exist constants η_* and T_* depending only upon *m*, *p*, *N*, *C*₀ and *C*₁, such that

$$v \ge \eta_*$$
 a.e. in $K_2 \times \left(1 + \frac{1}{2}T_*, T_*\right)$

Transforming back to the original variables, we obtain the desired estimate (2.6). We omit the details.

8.2. **Proof of Theorem 2.3.** Without loss of generality, we may prove the theorem in the case that (y, s) = (0, 0). This is always possible by using a translation. It suffices to prove the theorem in the case that

$$\int_{K_{\varrho}} u(x,0)dx > 2c \left(\frac{\varrho^p}{T'}\right)^{\frac{1}{p+m-3}}.$$
(8.2)

We set $v(x, t) = u(\delta \rho x, (\delta \rho)^p t)$, where $\delta > 1$ is to be chosen. Then v is a positive, weak supersolution in $\mathbb{R}^N \times (0, T'(\delta \rho)^{-p}]$. Let c and γ be as in Theorem 2.2. We need only consider the case

$$\int_{K_1} v(x,0)dx > 2c \left(\frac{(\delta\varrho)^p}{T}\right)^{\frac{1}{p+m-3}}.$$
(8.3)

We now use Theorem 2.2 for v to obtain

$$\int_{K_1} v(x,0) dx \le c \left(\frac{(\delta \varrho^p)}{T} \right)^{\frac{1}{p+m-3}} + \gamma \operatorname{ess\,inf}_{\mathcal{Q}_*} v,$$

where

$$Q_* = K_* \times (\frac{1}{2}T_*, T_*)$$
 and $T_* = c^{m+p-3} \left(\frac{1}{2} \int_{K_1} v(x, 0) dx\right)^{3-m-p} < \frac{T}{(\delta p)^p}$

It follows from (8.3) that

$$\int_{K_1} v(x,0)dx \le 2\gamma \operatorname{ess\,inf}_{\mathcal{Q}_*} v. \tag{8.4}$$

At this point, we choose

$$\delta^{p} = c^{3-m-p} \frac{T'}{\varrho^{p}} \left(\frac{1}{2} \int_{K_{1}} v(x,0) dx \right)^{p+m-3}.$$
(8.5)

Moreover, the estimate (8.3) yields

$$\delta^{\lambda} \geq c^{3-m-p} \frac{T'}{\varrho^p} \left(\frac{1}{2} \int_{K_{\varrho}} u(x,0) dx \right)^{p+m-3},$$

where $\lambda = N(p + m - 3) + p$. This inequality together with (8.2) ensures $\delta > 1$. Finally, we conclude from (8.3)-(8.5) that

$$\int_{K_{\mathcal{Q}}} u(x,0)dx \le 2\gamma\delta^{N} \inf_{\mathcal{Q}'} u \le 2\gamma(c\gamma)^{\frac{N(p+m-3)}{p}} \left(\frac{T'}{\mathcal{Q}^{p}}\right)^{\frac{N}{p}} \left(\operatorname{ess\,inf} u\right)^{\frac{N(p+m-3)}{p}}$$
(8.6)

where $Q' = K_{4\delta\varrho} \times (\frac{1}{2}T', T')$. This finishes the proof, the detailed verification of (8.6) being left to the reader.

Remark 8.1.

It would be interesting to establish similar results of Theorem 2.2 and Theorem 2.3 for the case m + p > 3 and 0 .
