Grand Fujii-Fujii-Nakamoto operator inequality dealing with operator order and operator chaotic order

Abstract. In this paper, we shall prove that a grand Fujii-Fujii-Nakamoto operator inequality implies operator order and operator chaotic order under different conditions.

Key words. operator order, operator chaotic order, Furuta inequality.

1 Introduction

A capital letter, such as T, stands for a bounded linear operator on a Hilbert space \mathcal{H} . $T \geq 0$ means T is a positive operator and T > 0 means T is a positive and invertible operator.

 $A \geq B$ and $\log A \geq \log B$ are called operator order and operator chaotic order, respectively.

There are many sufficient conditions and necessary conditions of operator order and operator chaotic order, such as[1], [2], [3], [5].

In 1993, M. Fujii, T. Furuta and E. Kamei obtained the following result on operator chaotic order.

Theorem 1.1([3]). If A, B > 0 satisfy

$$(B^{\frac{1}{2}}A^{\frac{1-t}{2}}B^tA^{\frac{1-t}{2}}B^{\frac{1}{2}})^{\frac{1}{2}} \ge B$$
 (1.1)

for all t > 1, then $\log B \ge \log A$.

In 2014, J. I. Fujii, M. Fujii and R. Nakamoto proposed an extension of Theorem 1.1, by which they make use of a beautiful operator inequality (we call it Fujii-Fujii-Nakamoto operator inequality here).

Theorem 1.2([2]). If A, B > 0 satisfy

$$(B^{\frac{s}{2}}A^{\frac{s-t}{2}}B^{t}A^{\frac{s-t}{2}}B^{\frac{s}{2}})^{\frac{1}{2s}} \ge B \tag{1.2}$$

for some t > s > 0, then the following result hold:

- (I) If $t \geq 3s 2 \geq 0$, then $\log B \geq \log A$, and if $t \geq s + 2$ is additionally assumed, then $B \geq A$;
- (II) If $0 < s < \frac{1}{2}$, then $\log B \ge \log A$, and if $t \ge s + 2$ is additionally assumed, then $B \ge A$.

In this paper, we will extend Theorem 1.2 and show some results on operator order and operator chaotic order.

In order to prove our results, we list a famous operator inequality here, which is called Furuta inequality.

Theorem 1.3 ([4].) If $A \geq B \geq 0$, then

$$(A^{\frac{r}{2}}A^{p}A^{\frac{r}{2}})^{\frac{1}{q}} \ge (A^{\frac{r}{2}}B^{p}A^{\frac{r}{2}})^{\frac{1}{q}}$$

and

$$(B^{\frac{r}{2}}A^pB^{\frac{r}{2}})^{\frac{1}{q}} \ge (B^{\frac{r}{2}}B^pB^{\frac{r}{2}})^{\frac{1}{q}}$$

hold for $r \ge 0, p \ge 0, q \ge 1$ with $(1+r)q \ge p+r$.

2 Main Results

In this section, we shall show the main results and prove them.

Theorem 2.1. If A, B > 0, satisfying

$$\left(\underbrace{B^{\frac{s}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}\cdots B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{s}{n}}}_{A^{\frac{s-t}{n}}B^{\frac{s}{n}})^{\frac{n}{(n+2)s+(n-2)t}}} \ge B$$

$$(2.1)$$

for some t>s>0 and $n\geq 2,$ then the following results hold:

(I) If $(n+2)s + (n-2)t > n \ge 3s - t$, then $\log B \ge \log A$, and if additional condition $t - s \ge n$ is assumed, then $B \ge A$;

(II) If $(n+2)s + (n-2)t \le n$, then $\log B \ge \log A$, and if additional condition $t-s \ge n$ is assumed, then $B \ge A$.

Proof of (I). Firstly, put
$$A_1 = (\underbrace{B^{\frac{s}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}\cdots B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{s}{n}}}_{n})^{\frac{n}{(n+2)s+(n-2)t}},$$

$$A^{\frac{s-t}{n}} \text{ appears } n \text{ times, } B^{\frac{2t}{n}} \text{ appears } n-1 \text{ times}$$

 $l=\frac{(n+2)s+(n-2)t}{n}$. Obviously, $l>1,\,2\frac{t-s}{n}>0$ and conditions in Furuta inequality are satisfied.

It follows that

$$\left(B^{\frac{t-s}{n}}A_1^l B^{\frac{t-s}{n}}\right)^{\frac{1+2\frac{t-s}{n}}{l+2\frac{t-s}{n}}} \ge B^{1+2\frac{t-s}{n}}.$$
(2.1)

Then we have

$$\underbrace{\left(B^{\frac{t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}} \cdots B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{t}{n}}\right)^{\frac{n+2(t-s)}{nl+2(t-s)}}}_{n} \ge B^{\frac{n+2(t-s)}{n}}$$

$$A^{\frac{s-t}{n}} \text{ appears } n \text{ times, } B^{\frac{2t}{n}} \text{ appears } n-1 \text{ times}$$

$$= (B^{\frac{t}{n}}A^{\frac{s-t}{n}}B^{\frac{t}{n}})^{n\frac{n+2(t-s)}{nl+2(t-s)}}$$
(2.2)

Notice that $n \frac{n+2(t-s)}{nl+2(t-s)} \ge 1$ due to the fact that $n \ge 3s-t$. Apply Löwner-Heinz inequality to (2.2), then the following inequality is obtained.

$$B^{\frac{t}{n}}A^{\frac{s-t}{n}}B^{\frac{t}{n}} \ge B^{\frac{s+t}{n}},\tag{2.3}$$

which is equivalent to

$$A^{\frac{s-t}{n}} \ge B^{\frac{s-t}{n}}. (2.4)$$

Taking reverse and then taking logarithm on both sides of (2.4), $\log B \ge \log A$ is obtained.

If $t-s \ge n$, taking reverse and applying Löwner-Heinz inequality to $0 < \frac{n}{t-s} \le 1$, $B \ge A$ holds, obviously.

Proof of (II). According to Löwner-Heinz inequality, (2.1) implies that

$$\underbrace{B^{\frac{s}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}\cdots B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{s}{n}}}_{n} \geq B^{\frac{(n+2)s+(n-2)t}{n}}.$$

$$(2.5)$$

It follows that

$$\underbrace{B^{\frac{t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}\cdots B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{2t}{n}}A^{\frac{s-t}{n}}B^{\frac{t}{n}}}_{n} \geq B^{s+t}}_{A^{\frac{s-t}{n}} appears \ n \ times, \ B^{\frac{2t}{n}} appears \ n-1 \ times} \geq B^{s+t}$$

$$= (B^{\frac{t}{n}}A^{\frac{s-t}{n}}B^{\frac{t}{n}})^{n}$$

$$(2.6)$$

Then we have

$$B^{\frac{t}{n}}A^{\frac{s-t}{n}}B^{\frac{t}{n}} \ge B^{\frac{s+t}{n}} \tag{2.7}$$

by Löwner-Heinz inequality.

(2.7) is equivalent to $A^{\frac{s-t}{n}} \ge B^{\frac{s-t}{n}}$.

By the same discussion as in proof in (I), we complete the proof. \Box

Corollary 2.1. If A, B > 0, satisfying

$$\left(B^{\frac{s}{3}}A^{\frac{s-t}{3}}B^{\frac{2t}{3}}A^{\frac{s-t}{3}}B^{\frac{2t}{3}}A^{\frac{s-t}{3}}B^{\frac{s}{3}}\right)^{\frac{3}{5s+t}} \ge B \tag{2.8}$$

for some t > s > 0, then the following results hold:

- (I) If $5s + t > 3 \ge 3s t$, then $\log B \ge \log A$, and if additional condition $t s \ge 3$ is assumed, then $B \ge A$;
- (II) If $5s + t \le 3$, then $\log B \ge \log A$.

Proof. We only need to set n = 3 in Theorem 2.1.

Remark 2.1. If n = 2, Theorem 2.1 is just Theorem 1.2.

Similarly, we can obtain another generalized Fujii-Fujii-Nakamoto operator inequality which extend Theorem 1.2.

Theorem 2.2. If A, B > 0 satisfy

$$(B^{\frac{s}{p}}A^{\frac{s-t}{p}}B^{\frac{2t}{p}}A^{\frac{s-t}{p}}B^{\frac{s}{p}})^{\frac{p}{4s}} \ge B \tag{2.9}$$

for some t > s > 0, then the following result hold:

- (I) If $4s > p \ge 3s t$, then $\log B \ge \log A$, and if $t s \ge p$ is additionally assumed, then $B \ge A$;
- (II) If $p \ge 4s$, then $\log B \ge \log A$, and if $t s \ge p$ is additionally assumed, then $B \ge A$.

Remark 2.2. The proof of Theorem 2.2 is the same as in [2], and we omit it here. If p = 2, Theorem 2.2 is just Theorem 1.2.

Corollary 2.2. If A, B > 0 satisfy

$$\left(B^{\frac{s}{3}}A^{\frac{s-t}{3}}B^{\frac{2t}{3}}A^{\frac{s-t}{3}}B^{\frac{s}{3}}\right)^{\frac{3}{4s}} \ge B \tag{2.10}$$

for some t > s > 0, then the following result hold:

- (I) If $4s > 3 \ge 3s t$, then $\log B \ge \log A$, and if $t s \ge 3$ is additionally assumed, then $B \ge A$;
- (II) If $3 \ge 4s$, then $\log B \ge \log A$, and if $t s \ge 3$ is additionally assumed, then $B \ge A$.

Proof. We only need to set p = 3 in Theorem 2.2.
