HIGHER-ORDER BOUNDARY REGULARITY ESTIMATES FOR NONLOCAL PARABOLIC EQUATIONS

ABSTRACT. We establish sharp higher-order Hölder regularity estimates up to the boundary for solutions to equations of the form $\partial_t u - Lu = f(t, x)$ in $I \times \Omega$ where $I \subset \mathbb{R}, \Omega \subset \mathbb{R}^n$ and f is Hölder continuous. The nonlocal operators L that we consider are those arising in stochastic processes with jumps, such as the fractional Laplacian $(-\Delta)^s$, $s \in (0,1)$.

Our main result establishes that, if f is C^{γ} is space and $C^{\gamma/2s}$ in time, and Ω is a $C^{2,\gamma}$ domain, then u/d^s is $C^{s+\gamma}$ up to the boundary in space and u is $C^{1+\gamma/2s}$ up the boundary in time, where d is the distance to $\partial\Omega$. This is the first higher order boundary regularity estimate for nonlocal parabolic equations, and is new even for the fractional Laplacian in C^{∞} domains.

1. INTRODUCTION

In this paper we address the boundary regularity for solutions of nonlocal parabolic equations of the form

$$
\partial_t u - Lu = f(t, x). \tag{1.1}
$$

Here, L is a nonlocal operator of the form

$$
Lu(t, x) = \text{P.V.} \int_{\mathbb{R}^n} \left(u(t, x + y) - u(t, x) \right) K(y) dy
$$

with $K(y) = K(-y)$,

$$
0 < \frac{\lambda}{|y|^{n+2s}} \le K(y) \le \frac{\Lambda}{|y|^{n+2s}} \quad \text{and} \quad K(y) \text{ homogeneous.}
$$

Equivalently, L can be written as

$$
Lu(t, x) = \int_{\mathbb{R}^n} \left(u(t, x + y) + u(t, x - y) - 2u(t, x) \right) \frac{a(y/|y|)}{|y|^{n+2s}} dy, \tag{1.2}
$$

with $s \in (0,1)$ and $a: S^{n-1} \longrightarrow [\lambda, \Lambda]$, for some ellipticity constants $0 < \lambda \leq \Lambda$. In fact, to prove our higher-order regularity estimates we will also require the kernels to be regular, see Theorem [1.1](#page-2-0) below.

Operators of this form arise naturally in the study of L´evy processes with jumps, where the infinitesimal generators of stable processes take the form [\(1.2\)](#page-0-0). These operators have been studied both from the point of view of Probability and Analysis

and have become quite popular to model very different phenomena in Physics, Finance, Image processing, or Ecology; see [\[Ap04,](#page-20-0) [CT16,](#page-20-1) [MK00,](#page-20-2) [ST94\]](#page-21-0) and references therein. The most canonical and important example of such operators is given by the case where $a \equiv$ ctt on S^{n-1} and L becomes a multiple of the fractional Laplacian $-(-\Delta)^s$:

$$
Lu(x) = c_{n,s} \int_{\mathbb{R}^n} \frac{u(x+y) + u(x-y) - 2u(x)}{|y|^{n+2s}} dy,
$$

see [\[BV16,](#page-20-3) [AV17,](#page-20-4) [Ga17,](#page-20-5) [La72,](#page-20-6) [Go16\]](#page-20-7) and references therein.

The regularity theory for integro-differential *elliptic* equations started already in the fifties and sixties, and has experienced a huge development in the last 20 years; see for example [\[Ro16\]](#page-20-8) and references therein. In particular, an important question in this context is to understand the boundary regularity of solutions, which presents many differences and challenges with respect to the case of local second order equations. Such question has been studied in the works [\[Bo97,](#page-20-9) [BKK08,](#page-20-10) [BKK15,](#page-20-11) [Gr15,](#page-20-12) [Gr14,](#page-20-13) [RS16,](#page-21-1) [RS16b,](#page-21-2) [SW99\]](#page-21-3), and it is now quite well understood. For Dirichlet problems of the form

$$
\begin{cases}\nLu &= f \text{ in } \Omega \\
u &= 0 \text{ in } \mathbb{R}^n \setminus \Omega,\n\end{cases}
$$
\n(1.3)

with L as above, the main known results of $[Gr15, Gr14, RS16, RS16b]$ $[Gr15, Gr14, RS16, RS16b]$ $[Gr15, Gr14, RS16, RS16b]$ $[Gr15, Gr14, RS16, RS16b]$ establish that, if $d(x)$ is the distance to $\partial\Omega$:

(a) If Ω is $C^{1,1}$, then

$$
f \in L^{\infty}(\Omega)
$$
 \implies $u/d^{s} \in C^{s-\varepsilon}(\overline{\Omega})$ for all $\varepsilon > 0$,

(b) If Ω is $C^{2,\gamma}$ and $a \in C^{1,\gamma}(S^{n-1})$, then

$$
f \in C^{\gamma}(\overline{\Omega}) \implies u/d^{s} \in C^{\gamma+s}(\overline{\Omega}) \quad \text{for } \gamma \in (0, s),
$$

whenever $\gamma + s$ is not an integer.

(c) If Ω is C^{∞} and $a \in C^{\infty}(S^{n-1})$, then

$$
f \in C^{\gamma}(\overline{\Omega}) \implies u/d^s \in C^{\gamma+s}(\overline{\Omega}) \quad \text{for all } \gamma > 0,
$$

whenever $\alpha + s \notin \mathbb{Z}$. In particular, $u/d^s \in C^{\infty}(\overline{\Omega})$ whenever $f \in C^{\infty}(\overline{\Omega})$.

Part (a) was proved in [\[RS16\]](#page-21-1) (for any $a \in L^1(S^{n-1})$); (b) was established in [\[RS16b\]](#page-21-2) in the more general context of fully nonlinear equations; and (c) was established in [\[Gr15,](#page-20-12) [Gr14\]](#page-20-13) for elliptic pseudodifferential operators satisfying the s-transmission property. Furthermore, when $s + \gamma$ is an integer in (c), more information is given in [\[Gr14\]](#page-20-13) in terms of Hölder-Zygmund spaces C_*^k . We refer to the expository paper [\[Ro17\]](#page-21-4) and to [\[Gr14\]](#page-20-13) for more details.

In case of *parabolic* equations, the interior regularity theory has been developed in the last years, and is now well understood; see [\[CD14,](#page-20-14) [CK15,](#page-20-15) [FR16,](#page-20-16) [JX15,](#page-20-17) [SS16,](#page-21-5) [Se15\]](#page-21-6). However, in such evolutionary setting, the boundary regularity is not so well understood. The results of [\[RS16\]](#page-21-1) were extended to the parabolic setting by Fernández-Real and the first author in [\[FR16\]](#page-20-16), and more recently the case $f \in L^p$

was treated by Grubb in [\[Gr17\]](#page-20-18). These results correspond to the case (a) above, and yield at best an expansion near the boundary of order $2s - \varepsilon$ in space and $1 - \varepsilon$ in time. No higher order boundary regularity result like those in (b) or (c) above is known in the parabolic setting.

It is important to notice that parabolic estimates for nonlocal equations offer new specific challenges over elliptic ones. Indeed, this already happens in the setting of interior regularity, where even solutions to the fractional heat equation $\partial_t u$ + $(-\Delta)^s u = 0$ in B_1 are always C^{∞} in space but in general not C^1 in time.

In the context of boundary regularity, a related counterexample was recently found by G. Grubb [\[Gr18\]](#page-20-19): solutions to $\partial_t u + (-\Delta)^s u = f$ in $(0,T) \times \Omega$, with $u = 0$ in $(0,T) \times \Omega^c$, do not satisfy in general $u/d^s \in C_x^{s+\varepsilon}(\overline{\Omega})$ for any $\varepsilon > 0$, not even when f and Ω are C^{∞} . This is in sharp contrast with the elliptic case, in which solutions satisfy $u/d^s \in C^\infty(\overline{\Omega})$.

The aim of this paper is to extend the boundary regularity result (b) above to the parabolic setting. For this, we develop a parabolic version of the boundary blow-up methods developed by the first author and Serra in [\[RS16b\]](#page-21-2). Our main result gives an expansion near the boundary of order $2s + \gamma$ in space and $1 + \gamma/2s$ in time, for $\gamma \in (0, s)$, and reads as follows.

Theorem 1.1. Let $s \in (0,1)$, and $\gamma \in (0,s)$ *such that* $\gamma + s$ *is not an integer. Let* Ω *be any* $C^{2,\gamma}$ *domain, and* $u(t,x)$ *be any solution of*

$$
\begin{cases}\n\partial_t u - Lu & = f \quad in \quad (-1,0) \times (B_1 \cap \Omega) \\
u & = 0 \quad in \quad (-1,0) \times (B_1 \setminus \Omega)\n\end{cases} \tag{1.4}
$$

with *L* of the form [\(1.2\)](#page-0-0). Assume $a \in C^{1,\gamma}(S^{n-1})$ and $f \in C_{t,x}^{\frac{\gamma}{2s},\gamma}((-1,0) \times \overline{\Omega})$ *.* Let

$$
C_0 = \|u\|_{C_t^{\gamma/2s}((-1,0)\times\mathbb{R}^n)} + \|f\|_{C_{t,x}^{\gamma/2s,\gamma}((-1,0)\times\overline{\Omega})}.
$$

Then,

$$
\|\partial_t u\|_{C^{\gamma/2s,\gamma}_{t,x}\left(\left(-\frac{1}{2},0\right)\times\overline{\Omega}\cap B_{1/2}\right)} + \|u/d^s\|_{C^{1/2+\gamma/2s,s+\gamma}_{t,x}\left(\left(-\frac{1}{2},0\right)\times\overline{\Omega}\cap B_{1/2}\right)} \le CC_0.
$$
 (1.5)

The constant C *depends only on* γ *,* $||a||_{C^{1,\gamma}(S^{n-1})}$ *, n, s, and the ellipticity constants.*

Notice this is an estimate of order $2s + \gamma$ in space and $1 + \gamma/2s$ in time. This is precisely the order one expects for this equation. In fact, for the local case (say when $L = \Delta$) one actually has $u \in C_x^{2+\gamma}$ and $u \in C_t^{1+\gamma/2}$ $t_t^{\frac{1+\gamma}{2}}$. Our estimate [\(1.5\)](#page-2-1) extends for the first time the results of [\[RS16b\]](#page-21-2) to the parabolic setting (in case of linear equations). It is new even for the fractional Laplacian in C^{∞} domains. Furthermore, in view of the above mentioned counterexample of Grubb, our Theorem is sharp (or almost-sharp) in the sense that it cannot hold for $\gamma > s$.

Notice also that the assumption that $u \in C_t^{\gamma/2s}$ $t^{\gamma/2s}((-1,0)\times\mathbb{R}^n)$ is necessary, even for the interior regularity. Indeed, in [\[FR16\]](#page-20-16) the first author and Fernández-Real showed that for any $\varepsilon > 0$ one can construct a solution to the homogeneous fractional heat equation $\partial_t u + (-\Delta)^s u = 0$ in $(-1,0) \times B_1$ which is in $C_t^{\gamma/2s-\varepsilon}$ $t^{\gamma/2s-\varepsilon}((-1,0)\times\mathbb{R}^n)$ and not $C_t^{1+\gamma/2s}$ $t_t^{1+\gamma/2s}$ in $(-1,0) \times B_{1/2}$.

As for the regularity assumption on the function a in (1.2) and the domain Ω , it is needed in the proof of Proposition [3.3.](#page-7-0) These are the same assumptions as in the elliptic case. Indeed, since $L(d^s)$ does not vanish identically (something that does happen in the case of a flat boundary, where we have $L(x_n)_+^s = 0$) we need to control over $[L(d^s)]_{C}$. Such an estimate is obtained in terms of the $C^{1,\gamma}$ norm of a and the $C^{2,\gamma}$ norm of Ω ; see Lemma 8.3 in [\[RS16b\]](#page-21-2).

As an immediate consequence of Theorem [1.1,](#page-2-0) we get the following result for the Dirichlet problem.

Corollary 1.2. Let $s \in (0,1)$ *, and* $\gamma \in (0,s)$ *such that* $\gamma + s$ *is not an integer. Let* L be any operator of the form (1.2) and Ω be any bounded $C^{2,\gamma}$ domain. Suppose *that* u(t, x) *is the solution of*

$$
\begin{cases}\n\partial_t u - Lu &= f \quad \text{in } \Omega, \ T > t > 0 \\
u &= 0 \quad \text{in } \mathbb{R}^n \setminus \Omega, \ T > t \ge 0, \\
u(0, \cdot) &= u_0 \quad \text{in } \Omega, \ t = 0,\n\end{cases}
$$
\n(1.6)

Assume in addition that $a \in C^{1,\gamma}(S^{n-1})$, and denote

$$
C_0 = ||u_0||_{L^2(\Omega)} + ||f||_{C_{t,x}^{\gamma/2s,\gamma}((0,T)\times\Omega)}.
$$

Then, we have

$$
\|\partial_t u\|_{C_{t,x}^{\gamma/2s,\gamma}\left((t_0,T)\times\overline{\Omega}\right)} + \|u/d^s\|_{C_{t,x}^{1/2+\gamma/2s,\gamma+s}\left((t_0,T)\times\overline{\Omega}\right)} \le CC_0,\tag{1.7}
$$

for any $0 < t_0 < T$ *where* C *depends only on* n, s, Ω , t_0 , T , $||a||_{C^{1,\gamma}(S^{n-1})}$ *and the ellipticity constants.*

Remark 1.3. Notice that $\gamma + s$ could be bigger than 1 (and is always less than 2). This calls for some care when defining the Hölder seminorm being used, as well as the full norm. When $\gamma + s < 1$ there is no issue and the norm is defined as usual, i.e.

$$
[w]_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}=\sup_{\substack{t,t'\in I\\x,x'\in\Omega}}\frac{|w(t,x)-w(t',x')|}{|t-t'|^{\frac{s+\gamma}{2s}}+|x-x'|^{s+\gamma}}
$$

and

$$
||w||_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}=||w||_{L^{\infty}(I\times\Omega)}+[w]_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}.
$$

However, when $\gamma + s > 1$ we need a higher order Hölder seminorm. As in [\[FR16\]](#page-20-16), we define in this case

$$
[w]_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)} = [w]_{C^{\frac{s+\gamma}{2s}}_t(I\times\Omega)} + [\nabla w]_{C^{\frac{\gamma+s-1}{2s},\gamma+s-1}_{t,x}(I\times\Omega)}
$$

where

$$
[w]_{C_t^{\alpha}(I\times\Omega)}=\sup_{x\in\Omega}[w(\cdot,x)]_{C^{\alpha}(I)}
$$

$$
\|w\|_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}=\|w\|_{L^\infty(I\times\Omega)}+\|\nabla w\|_{L^\infty(I\times\Omega)}+[w]_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}
$$

Finally, in Proposition [4.1](#page-11-0) we are going to need the case $\alpha + \beta + s$ possibly bigger than 2. So in that case, again as in [\[FR16\]](#page-20-16), we set

$$
[w]_{C^{\frac{\alpha+\beta+s}{2s},\alpha+\beta+s}(I\times\Omega)}=[\partial_t w]_{C^{\frac{\alpha+\beta-s}{2s},\alpha+\beta-s}_{t,x}(I\times\Omega)}+[\nabla w]_{C^{\frac{\alpha+\beta-s}{2s},(I\times\Omega)}_t}+[D^2_xw]_{C^{\frac{\alpha+\beta-3s}{2s},\alpha+\beta+s-2}_{t,x}(I\times\Omega)}
$$

and

$$
||w||_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}=||w||_{L^\infty(I\times\Omega)}+||\nabla w||_{L^\infty(I\times\Omega)}+||D^2w||_{L^\infty(I\times\Omega)}+[w]_{C^{\frac{s+\gamma}{2s},s+\gamma}_{t,x}(I\times\Omega)}.
$$

To prove Theorem [1.1](#page-2-0) we extend the ideas from [\[RS16b\]](#page-21-2) to the parabolic setting. Namely, we need to develop a parabolic version of the higher order boundary blowup (elliptic) methods of [\[RS16b\]](#page-21-2), and then combine this with appropriate interior estimates in order to get the fine regularity estimate for u up to the boundary.

Remark 1.4*.* Besides its own interest, sharp boundary regularity estimates find usually applications in free boundary problems; see for example [\[DS16\]](#page-20-20). We think that the ideas introduced in this paper could be used in order to establish the higher regularity of free boundaries in the obstacle problem for the fractional Laplacian, at least in case $s > 1/2$; see [\[BFR17\]](#page-20-21).

The paper is organized as follows. We first prove a Liouville-type theorem in Section [2.](#page-4-0) Then, in Section [3](#page-6-0) we prove the main proposition, namely Proposition [3.3.](#page-7-0) Finally, in Section [4](#page-11-1) we prove Theorem [1.1,](#page-2-0) and in the Appendix we prove Proposition [4.1.](#page-11-0)

2. A Liouville-type theorem in the half space

In this section we prove a Liouville type theorem in the half space for nonlocal parabolic equations. Let us define first the parabolic cylinders:

$$
Q_r(t, x) = (t - r^{2s}, t) \times B_r(x),
$$

where $B_r(x)$ is the ball of radius r around x. Moreover, we will denote $Q_r(0,0)$ by Q_r and $(-r^{2s}, 0) \times (B_r \cap \{x_n > 0\})$ by Q_r^+ .

Theorem 2.1. *Let* $s \in (0,1)$ *,* $\gamma \in (0,s)$ *,* $\beta \in (\gamma,1)$ *and* $\alpha = s + \gamma - \beta \in (0,s)$ *. Let* w *satisfy*

$$
\begin{cases}\n(\partial_t - L)(w(\cdot + \tau, \cdot + h) - w(\cdot, \cdot)) = 0 & \text{in } (-\infty, 0) \times \mathbb{R}^n_+ \\
w = 0 & \text{in } (-\infty, 0) \times \mathbb{R}^n_-\n\end{cases}
$$

 $for h \in \mathbb{R}^n, h_n \geq 0, \tau < 0$ where L is an operator of the form [\(1.2\)](#page-0-0) and assume that w *satisfies the growth condition*

$$
[w/(x_n)_+^s]_{C_{t,x}^{\beta/2s,\beta}(Q_R^+)}\leq CR^\alpha,\quad R\geq 1
$$

.

for some positive constant C*. Then*

$$
w(x) = (x_n)_+^s (p \cdot x + q)
$$

for some $p \in \mathbb{R}^n$ *and* $q \in \mathbb{R}$ *. If* $\alpha + \beta < 1$ *then* $p = 0$ *.*

Proof. First let $h_n = 0$ and $v(t, x) = w(t + \tau, x + h) - w(t, x)$. Then v satisfies

$$
\begin{cases} \partial_t v - Lv &= 0 \text{ in } (-\infty, 0) \times \mathbb{R}^n_+ \\ v &= 0 \text{ in } (-\infty, 0) \times \mathbb{R}^n_- . \end{cases}
$$

Moreover,

$$
||v(t,x)/(x_n)^s + ||_{L^{\infty}(Q_R)} \leq CR^{\alpha},
$$

so

$$
||v||_{L^{\infty}(Q_R)} \leq CR^{\alpha+s}
$$

for $R \geq 1$. Then we can apply Theorem 4.11 in [\[FR16\]](#page-20-16) (note that $\alpha + s < 2s$) to get that

$$
v(t, x) = K(x_n)_+^s
$$

for some constant K . In particular, this implies that w is constant as a function of time and

$$
w(t, x + h) - w(t, x) = K(x_n)_+^s
$$

for any h such that $h_n = 0$. Therefore,

$$
w(t, x) = K(x_n)_+^s (a \cdot x + b) + \psi(x_n)
$$

for some one dimensional function ψ .

Now, by Lemma 5.5 in $[RS16b]$ and the fact that w is constant in time and solves the equation we have

$$
L(w(t, \cdot + h) - w(t, \cdot)) = L(\psi(\cdot + h_n) - \psi(\cdot)) = 0 \quad \text{in} \quad \mathbb{R}^n_+
$$

for $h_n \geq 0$ so ψ satisfies:

$$
\begin{cases}\nL(\psi(\cdot+h_n)-\psi(\cdot)) = 0 \text{ in } \mathbb{R}_+ \\
\psi = 0 \text{ in } \mathbb{R}_-.\n\end{cases}
$$

Moreover, because of the hypothesis on w, ψ has the growth control

 $[\psi/(x_n)^s]_{C^{\beta}([0,R])} \leq CR^{\alpha}, \quad R \geq 1.$

so we can apply Lemma 5.3 in [\[RS16b\]](#page-21-2) to get

$$
\psi(x_n) = C_1(x_n)_+^s + C_2(x_n)_+^{1+s},
$$

and the result follows.

3. Main proposition

In this section we take the main step towards the proof of Theorem [1.1,](#page-2-0) namely we prove Proposition [3.3.](#page-7-0) We start with th following technical lemma that allows us to take limits.

Lemma 3.1. *Let* $s \in (0,1)$ *and* $\{L_m\}_{m \in \mathbb{N}}$ *be a sequence of operators of the form* [\(1.2\)](#page-0-0)*.* Let $\{w_m\}_{m\in\mathbb{N}}$ and $\{f_m\}_{m\in\mathbb{N}}$ be sequences of functions satisfying

$$
(\partial_t - L)(w_m(\cdot + h, \cdot + \tau) - w_m(\cdot, \cdot)) = f_m \text{ in } I \times K
$$

in the weak sense for a given bounded interval $I \subset (-\infty, 0]$ *and a bounded domain* $K \subset \mathbb{R}^n$. Assume that L_m are given by [\(1.2\)](#page-0-0) for some $a_m : S^{n-1} \mapsto [\lambda, \Lambda]$ that *converge uniformly to some* a*. Let* L *be the operator associated to such* a*, and suppose that, for some functions* w *and* f*, the following hypotheses hold:*

- *(1)* w_m *converges to* w *uniformly in compact sets of* $(-\infty, 0] \times \mathbb{R}^n$,
- *(2)* $f_m \to f$ *uniformly on* $I \times K$ *,*
- (3) sup_{t∈I} $|w_m(t + \tau, x + h) w_m(t, x)| \leq C (1 + |x|^{2s-\varepsilon})$ *for some* $\varepsilon > 0$ *, and for* $all \ x \in \mathbb{R}^n$.

Then, w *satisfies*

$$
(\partial_t - L)(w(\cdot + h, \cdot + \tau) - w(\cdot, \cdot)) = f \text{ in } I \times K
$$

in the weak sense.

Proof. Using the definition of weak solution we get, for each m and $\eta \in C_c^{\infty}(I \times K)$:

$$
\int_{I\times K} (w_m(\cdot + h, \cdot + \tau) - w_m(\cdot, \cdot)) (-\partial_t - L_m) \eta \, dt dx = \int_{I\times K} f_m \eta \, dt dx.
$$

Because of the uniform convergence a_m to a we have that $(-\partial_t - L_m)\eta$ converges to $(-\partial_t - L)\eta$ thanks to the dominated convergence theorem. Also, since η is compactly supported we easily find $|L_m \eta(x)| \leq C(1+|x|^{n+2s})^{-1}$, so we just need to prove a growth condition on the difference quotients that allows us to pass to the limit, i.e. we want

$$
\left| (w_m(\cdot + h, \cdot + \tau) - w_m(\cdot, \cdot))(-\partial_t - L_m)\eta \right| \le \frac{C}{1 + |x|^{n+\varepsilon}}
$$

for some positive ε . Because of the previous observation, this ammounts to show that

$$
\left| \left(w_m(\cdot + h, \cdot + \tau) - w_m(\cdot, \cdot) \right) \right| \le C \left(1 + |x|^{2s - \varepsilon} \right)
$$

but since that is exactly the third assumption, the result follows. \Box

Next we are going to prove Proposition [3.3.](#page-7-0) First, let us give the following definition:

Definition 3.2. We say that Γ is a $C^{2,\gamma}$ surface splitting \mathbb{R}^n into Ω^+ and Ω^- with norm smaller than 1 if the following holds:

• $\Gamma \subset \mathbb{R}^n$ is the graph of a $C^{2,\gamma}$ function with $C^{2,\gamma}$ norm less than 1

- the two disjoint domains Ω^+ and Ω^- partition \mathbb{R}^n , i.e. $\mathbb{R}^n = \overline{\Omega^+} \cup \overline{\Omega^-}$ and $\Omega^+ \cap \Omega^- = \emptyset$
- $\Gamma = \partial \Omega^+ = \partial \Omega^-$ and $0 \in \Gamma$
- $\nu(0) = e_n$ where ν is the normal vector to Γ .

Moreover, we will denote by $d(x)$ any $C^{2,\gamma}(\overline{\Omega^+})$ function that coincides with $dist(x,\Omega^-)$ in a neighborhood of $\Gamma \cap B_4$ and vanishes outside B_5 .

Then we have the following result:

Proposition 3.3. *Let* $s \in (0,1)$ *,* $\gamma \in (0,s)$ *,* $\beta \in (\gamma,1)$ *and* $\alpha = s + \gamma - \beta \in (0,s)$ *.* Let Γ be any $C^{2,\gamma}$ surface splitting \mathbb{R}^n into Ω^+ and Ω^- with norm smaller than 1. *Let* u *be any solution of*

$$
\begin{cases}\n\partial_t u - Lu & = f \quad in \quad (-1,0) \times (B_1 \cap \Omega^+) \\
u & = 0 \quad in \quad (-1,0) \times \Omega^-\n\end{cases} \tag{3.1}
$$

with L *an operator of the form* [\(1.2\)](#page-0-0)*. Assume that*

$$
[u/d^s]_{C^{\beta/2s,\beta}_{t,x}((-1,0)\times\Omega^+)} \le 1 \quad \text{and} \quad ||f||_{C^{\gamma/2s,\gamma}_{t,x}((-1,0)\times(B_1\cap\Omega^+))} \le 1 \quad (3.2)
$$

and $a \in C^{1,\gamma}(S^{n-1})$ *.*

Then for any $r > 0$

$$
r^{-\alpha} \left[u/d^s - (p_r \cdot x + q_r) \right]_{C_{t,x}^{\beta/2s, \beta} ((-r^{2s}, 0) \times (B_r \cap \Omega^+))} \le C \tag{3.3}
$$

where C *is a constant depending only on* n, s, α , β , $\|a\|_{C^{1,\gamma}(S^{n-1})}$, and the ellipticity *constants and* $p_r \cdot x + q_r$ *is the least square approximation of* u/d^s *in* $(-r^{2s}, 0) \times$ $(B_r \cap \Omega^+), \ i.e.$

$$
p_r \cdot x + q_r = \arg\min_{\mathcal{P}} \int_{-r^{2s}}^0 \int_{B_r \cap \Omega^+} \left(u/d^s - (p \cdot x + q) \right)^2 dx dt \tag{3.4}
$$

where P *is the space of all polynomials of degree at most* $|\alpha + \beta|$ *(i.e.,* $p_r = 0$ *if* $\alpha + \beta < 1$).

Proof. The proof is by contradiction. Assume [\(3.3\)](#page-7-1) does not hold. Then there are sequences Γ_k , u_k , L_k and f_k satisfying:

- Γ_k is a $C^{2,\gamma}$ surface splitting \mathbb{R}^n into Ω_k^+ and Ω_k^- with norm less than 1
- L_k is of the form (1.2) and $a_k \in C^{1,\gamma}(S^{n-1})$
- $[u_k/d_k^s]_{C_{t,x}^{\beta/2s,\beta}((-1,0)\times\Omega_k^+)} \leq 1$ and $||f_k||_{C_{t,x}^{\gamma/2s,\gamma}((-1,0)\times(B_1\cap\Omega_k^+))} \leq 1$
- u_k is a solution of

$$
\begin{cases}\n\partial_t u_k - L_k u_k &= f_k \quad \text{in } (-1,0) \times (B_1 \cap \Omega_k^+) \\
u_k &= 0 \quad \text{in } (-1,0) \times \Omega_k^-.\n\end{cases} \tag{3.5}
$$

such that

$$
\sup_{k} \sup_{r>0} r^{-\alpha} \big[u_k / d_k^s - (p_{r,k} \cdot x + q_{r,k}) \big]_{C_{t,x}^{\beta/2s,\beta} ((-r^{2s}, 0) \times (B_r \cap \Omega_k^+))} = \infty
$$

where

$$
p_{r,k} \cdot x + q_{r,k} = \arg\min_{\mathcal{P}} \int_{-r^{2s}}^{0} \int_{B_r \cap \Omega_k^+} (u_k/d_k^s - (p \cdot x + q))^2 \, dx \, dt. \tag{3.6}
$$

Define

$$
\theta(r) := \sup_{k} \sup_{r' > r} (r')^{-\alpha} \big[u_k / d_k^s - (p_{r',k} \cdot x + q_{r',k}) \big]_{C_{t,x}^{\beta/2s,\beta}((-(r')^{2s},0) \times (B_{r'} \cap \Omega_k^+))}.
$$

Notice that θ is a nondecreasing function of r that goes to ∞ as $r \to 0$. Moreover, since for any fixed r we have $\theta(r) < \infty$ we can find a sequence $r'_m \geq 1/m$, $r'_m \searrow 0$ and k_m such that

$$
(r'_m)^{-\alpha} \left[u_{k_m} / d_{k_m}^s - p_{r'_m, k_m} \cdot x - q_{r'_m, k_m} \right]_{C_{t,x}^{\beta/2s, \beta}((-(r'_m)^{2s}, 0) \times (B_{r'_m} \cap \Omega_{k_m}^+))} \geq \frac{1}{2} \theta(1/m) \geq \frac{1}{2} \theta(r'_m).
$$

Let us denote

 $u_m = u_{k_m}, \quad p_m = p_{r'_m, k_m}, \quad \text{and} \quad q_m = q_{r'_m, k_m}$

and

$$
\overline{\Gamma}_m = \frac{1}{r'_m} \Gamma_{k_m}, \quad \overline{\Omega}_m^+ = \frac{1}{r'_m} \Omega_{k_m}^+, \quad \text{and} \quad \overline{d}_m(x) = \frac{1}{r'_m} d_{k_m}(r'_m x).
$$

Notice that $\overline{\Gamma}_m$ converges to $\{x_n=0\}$, $\overline{\Omega}_m^+$ converges to \mathbb{R}^n_+ and \overline{d}_m^s converges locally uniformly to $(x_n)_+^s$ as $m \to \infty$. Further, let us simplify the notation by defining

$$
Q_{r,k}^+ = (-r^{2s}, 0) \times (B_r \cap \Omega_k^+) \quad \text{and} \quad \overline{Q}_{r,m}^+ = (-r^{2s}, 0) \times (B_r \cap \overline{\Omega}_m^+).
$$

We define the blow-up sequence:

$$
v_m(t,x) = \frac{u_m((r_m')^{2s}t, r_m'x)/(r_m'\bar{d}_m(x))^s - (p_m \cdot (r_m'x) + q_m)}{(r_m')^{\alpha+\beta} \theta(r_m')}.
$$

Notice that

$$
[v_m]_{C^{\beta/2s,\beta}_{t,x}(\overline{Q}^+_{1,m})} \ge 1/2
$$
\n(3.7)

and that

$$
\int_{-1}^{0} \int_{B_1 \cap \overline{\Omega}_m^+} v_m(p \cdot x + q) \, dx \, dt = 0 \tag{3.8}
$$

for all $p \in \mathbb{R}^n$ and $q \in \mathbb{R}$ because of the minimization condition [\(3.6\)](#page-8-0).

Let us show next that

$$
[v_m]_{C^{\beta/2s,\beta}(\overline{Q}_{R,m}^+)} \leq CR^{\alpha} \tag{3.9}
$$

for $1 \leq R \leq \frac{1}{r'}$ $\frac{1}{r'_m}$. For this need an estimate of the form

$$
\left[p_{k_m, R r'_m} \cdot x - q_{k_m, R r'_m} - (p_{k_m, r'_m} \cdot x + q_{k_m, r'_m})\right]_{C_{t,x}^{\beta/2s, \beta}(Q_{r'_m, R, k_m})} \leq (R r'_m)^{\alpha} \theta(r'_m) \tag{3.10}
$$

which actually amounts to bound $|p_{k, Rr} - p_{k,r}|$. This will be achieved via a dyadic estimate, i.e. for $R = 2^k$, $k \ge 1$ (notice that the estimate holds if $R \in [1, 1/r_m]$) by

the definition of v_m). We will also prove here only the case where $\alpha + \beta > 1$, the case $\alpha + \beta < 1$ is analogous. Let us first estimate the difference when $R = 2$:

$$
\frac{|p_{k,2r} - p_{k,r}|r^{1-\beta}}{r^{\alpha}\theta(r)} \leq \frac{[(p_{k,2r} - p_{k,r}) \cdot x]_{C_{t,x}^{\beta/2s,\beta}(Q_{r,k}^{+})}}{r^{\alpha}\theta(r)}
$$
\n
$$
= \frac{[p_{k,2r} \cdot x + q_{k,2r} - p_{k,r} \cdot x - q_{k,r}]_{C_{t,x}^{\beta/2s,\beta}(Q_{r,k}^{+})}}{r^{\alpha}\theta(r)}
$$
\n
$$
\leq \frac{2^{\alpha}\theta(2r)}{\theta(r)} \frac{[u_{k}/d_{k}^{s} - p_{k,2r} \cdot x - q_{k,2r}]_{C_{t,x}^{\beta/2s,\beta}(Q_{2r,k}^{+})}}{(2r)^{\alpha}\theta(2r)}
$$
\n
$$
+ \frac{[u_{k}/d_{k}^{s} - p_{k,r} \cdot x - q_{k,r}]_{C_{t,x}^{\beta/2s,\beta}(Q_{r,k}^{+})}}{r^{\alpha}\theta(r)}
$$
\n
$$
\leq C,
$$

where we have used the definition of θ and its monotonicity. Now if $R = 2^k$ we have

$$
|p_{k,2^{k}r} - p_{k,r}| \leq \sum_{j=1}^{k} |p_{k,2^{j}r} - p_{k,2^{j-1}r}|
$$

$$
\leq C \sum_{j=1}^{k} (2^{j-1}r)^{\alpha+\beta-1} \theta(2^{j-1}r)
$$

$$
\leq C \theta(r) (2^{k}r)^{\alpha+\beta-1},
$$

using that $\alpha + \beta - 1 > 0$ and this readily implies [\(3.10\)](#page-8-1). Now we can apply (3.10) as follows:

$$
\begin{array}{rcl}\n[v_{m}]_{C_{t,x}^{\beta/2s,\beta}(\overline{Q}_{R,m}^{+})} & = & \frac{1}{(r'_{m})^{\alpha}\theta(r'_{m})} [u_{m}/d_{m}^{s} - (p_{m} \cdot x + q_{m})]_{C_{t,x}^{\beta/2s,\beta}(Q_{r'_{m}R,k_{m}}^{+})} \\
& = & \frac{R^{\alpha}}{(Rr'_{m})^{\alpha}\theta(r'_{m})} [u_{m}/d_{m}^{s} - (p_{m} \cdot x + q_{m})]_{C_{t,x}^{\beta/2s,\beta}(Q_{r'_{m}R,k_{m}}^{+})} \\
& \leq & \frac{R^{\alpha}}{(Rr'_{m})^{\alpha}\theta(r'_{m})} [u_{m}/d_{m}^{s} - (p_{k_{m},Rr'_{m}} \cdot x + q_{k_{m},Rr'_{m}})]_{C_{t,x}^{\beta/2s,\beta}(Q_{r'_{m}R,k_{m}}^{+})} \\
& & + \frac{R^{\alpha}}{(Rr'_{m})^{\alpha}\theta(r'_{m})} [p_{k_{m},Rr'_{m}} \cdot x - q_{k_{m},Rr'_{m}} - (p_{m} \cdot x + q_{m})]_{C_{t,x}^{\beta/2s,\beta}(Q_{r'_{m}R,k_{m}}^{+})} \\
& \leq & \frac{R^{\alpha}\theta(Rr'_{m})}{\theta(r'_{m})} + C \frac{R^{\alpha}}{(Rr'_{m})^{\alpha}\theta(r'_{m})} (Rr'_{m})^{\alpha}\theta(r'_{m}) \\
& \leq & CR^{\alpha},\n\end{array}
$$

and we get (3.9) .

When $R = 1$, [\(3.9\)](#page-8-2) implies that the oscillation of v_m in Q_1^+ is bounded by some universal constant C , which in turn implies

$$
||v_m - M||_{L^{\infty}(Q_{1,m}^+)} \leq C
$$

for some M . This gives, by (3.8)

$$
||v_m||_{L^{\infty}(Q_{1,m}^+)} \leq C.
$$

Finally, the bound on the Hölder seminorm [\(3.9\)](#page-8-2) and the L^{∞} bound in Q_1^+ give

$$
||v_m||_{L^{\infty}(Q_{R,m}^+)} \leq CR^{\alpha+\beta}.
$$
\n(3.11)

By the Arzelà-Ascoli theorem, the previous bounds imply that a subsequence of $\{v_m\}$ converges uniformly on compact subsets of $(-\infty, 0) \times \mathbb{R}^n$ to a uniformly continuous function v. Let

$$
w_m(t,x) := v_m(t,x)\bar{d}_m^s(x) = \frac{u_m((r'_m)^{2s}t, r'_m x)}{(r'_m)^{\alpha+\beta+s}\theta(r'_m)} - \frac{\bar{d}_m^s(x)(p_m \cdot r'_m x + q_m)}{(r'_m)^{\alpha+\beta}\theta(r'_m)}
$$
(3.12)

and $w(t, x) = v(t, x)(x_n)_+^s$.

We claim that w satisfies the hypothesis of the Liouville-type Theorem [2.1.](#page-4-1) To see this, note that, by [\(3.5\)](#page-7-2) (and for fixed h and τ) and the scaling of the equation

$$
\frac{(\partial_t - L_{k_m})(u_m((r'_m)^{2s}(t+\tau), r'_m(x+h)) - u_m((r'_m)^{2s}t, r'_m x))}{(r'_m)^{\alpha+\beta+s}\theta(r'_m)}
$$
\n
$$
= \frac{f_{k_m}((r'_m)^{2s}(t+\tau), r'_m(x+h)) - f_{k_m}((r'_m)^{2s}t, r'_m x)}{(r'_m)^{\alpha+\beta-s}\theta(r'_m)} \leq \frac{C[f_{k_m}]_{C_{t,x}^{1/2s,\gamma}(Q_1^+)}{(r'_m)^{\alpha+\beta-s}\theta(r'_m)}
$$

in $\overline{\Omega}_m^+$ and this last term goes to 0 as $m \to \infty$ (recall $\alpha + \beta = s + \gamma$).

On the other hand, using Lemma 8.3 in [\[RS16b\]](#page-21-2) and the definition of \bar{d}_m we get

$$
L_{k_m}(\bar{d}_m^s(x+h)(p_m \cdot r'_m(x+h) + q_m) - \bar{d}_m^s(x)(p_m \cdot r'_m x + q_m))
$$

\$\leq C(r'_m)^{s+\gamma}(|p_m| + |q_m|).

So we need to get the appropriate bounds on $|p_m|$ and $|q_m|$. But with the same proof as in Proposition 8.2 in [\[RS16b\]](#page-21-2) we get that, for $r \in [2^{-i}, 2^{-i+1}]$

$$
\frac{|p_{k,r}| + |q_{k,r}|}{\theta(r)} \le C \sum_{j=0}^i \frac{\theta(2^{-j})}{\theta(r)} (1/2)^{j(\alpha+\beta-1)}.
$$

which goes to 0 as $r \searrow 0$. Hence, recalling [\(3.12\)](#page-10-0), we have that

$$
(\partial_t - L_{k_m})(w_m(t + \tau, x + h) - w_m(t, x)) \longrightarrow 0
$$

uniformly on compact sets as $m \to \infty$. But thanks to Lemma [3.1](#page-6-1) (condition 3) follows easily from [\(3.9\)](#page-8-2), [\(3.11\)](#page-10-1) and the definition of α and β), this implies

$$
\partial_t(w(t + \tau, x + h) - w(t, x)) - L(w(t + \tau, x + h) - w(t, x)) = 0
$$

in \mathbb{R}^n_+ for $h \in \mathbb{R}^n$, $h_n \geq 0$, $\tau < 0$ and some L of the form [\(1.2\)](#page-0-0). Also $w = 0$ in \mathbb{R}^n_- by the uniform convergence.

Moreover, because of (3.9) w also satisfies the growth condition

$$
[w/(x_n)_+^s]_{C_{t,x}^{\beta/2s,\beta}(Q_R^+)} \leq C R^\alpha, \quad R \geq 1
$$

so we can apply by Theorem [2.1](#page-4-1) and we get that $w(t, x) = (x_n)_+^s (p \cdot x + q)$ for some $p \in \mathbb{R}^n$ and $q \in \mathbb{R}$ or, equivalently, $v(t, x) = p \cdot x + q$. This, together with [\(3.8\)](#page-8-3) gives that $v \equiv 0$ so passing to the limit in [\(3.7\)](#page-8-4) we get a contradiction.

The following proposition gives a plane (the same) for all r .

Proposition 3.4. *Let* $\alpha, \beta \in (0,1)$ *with* $\alpha + \beta \neq 1$ *and let v satisfy*

$$
\sup_{r>0} r^{-\alpha} [v - (p_r \cdot x + q_r)]_{C_{t,x}^{\beta/2s,\beta}((-r^{2s}, 0) \times (B_r \cap \Omega^+))} \le C_0
$$
\n(3.13)

with $p_r = 0$ *if* $\alpha + \beta < 1$ *, if not assume that* $|p_1| \leq C_0$ *. Then there exist* $p \in \mathbb{R}^n$ *and* $q \in \mathbb{R}$ *such that*

$$
p = \lim_{r \to 0} p_r \quad and \quad q = \lim_{r \to 0} q_r
$$

and for all $r > 0$

$$
||v - (p \cdot x + q)||_{L^{\infty}((-r^{2s},0) \times (B_r \cap \Omega^+)))} \leq CC_0 r^{\alpha + \beta} \quad |p| \leq CC_0
$$

where C *depends only on* α *and* β *.*

Proof. The proof is the same as in Lemma 7.4 in [\[RS16b\]](#page-21-2). \Box

4. Proof of the main theorem

In this section we prove Theorem [1.1.](#page-2-0) We will need the following decay on the Hölder norm (recall the definition of the seminorm in Remark [1.3\)](#page-3-0):

Proposition 4.1. *Let* $s \in (0,1)$ *,* $\gamma \in (0,s)$ *,* $\beta \in (\gamma,1)$ *and* $\alpha = s + \gamma - \beta \in (0,s)$ *. Let* w *be a solution of*

$$
\partial_t w - Lw = f \quad in \quad (-1,0) \times B_1(e_n)
$$

 $with e_n = (0, ..., 0, 1)$ *.* Assume that $a \in C^{1, \gamma}(S^{n-1})$, $f \in C_{t, x}^{\frac{\gamma}{2s}, \gamma}((-1, 0) \times B_1(e_n))$ *and*

$$
||w||_{L^{\infty}((-\infty,0)\times\mathbb{R}^n)} < \infty, \quad ||w||_{L^{\infty}(Q_r)} \le Cr^{\alpha+\beta+s}, \quad [w]_{C^{\beta/2s,\beta}_{t,x}(Q_r(-(2r)^{2s},2re_n))} \le Cr^{\alpha+s}
$$

for all $r > 0$ *. Then, we have*

$$
[w]_{C_{t,x}^{\frac{\alpha+\beta}{2s}, \alpha+\beta}(Q_{r/2}(-(2r)^{2s}, 2re_n))} \leq Cr^s
$$

and

$$
[w]_{C^{\frac{\alpha+\beta+s}{2s},\alpha+\beta+s}_{t,x}(Q_{r/2}(-(2r)^{2s},2re_n))} \leq C.
$$

We will prove Proposition [4.1](#page-11-0) in the Appendix. The next proposition, combined with the interior estimates, will give the proof of Theorem [1.1:](#page-2-0)

Proposition 4.2. Let $s \in (0,1)$, Γ be $C^{2,\gamma}$ surface splitting \mathbb{R}^n into Ω^+ and Ω^- and u *be a solution of*

$$
\begin{cases}\n\partial_t u - Lu & = f \quad in \quad (-1,0) \times \Omega^+ \cap B_1 \\
u & = 0 \quad in \quad (-1,0) \times \Omega^- \n\end{cases} \tag{4.1}
$$

with L of the form [\(1.2\)](#page-0-0). Assume $a \in C^{1,\gamma}(S^{n-1})$ and $f \in C_{t,x}^{\frac{\gamma}{2s},\gamma}((-1,0) \times \Omega^+ \cap B_1)$ *with* $\gamma \in (0, s)$ *and* $\gamma + 2s$ *and* $\gamma + s$ *not integers. Let*

$$
C_0 = ||u||_{C_t^{\gamma/2s}((-1,0)\times\mathbb{R}^n)} + ||f||_{C_{t,x}^{\gamma/2s,\gamma}((-1,0)\times\Omega^+\cap B_1)}.
$$

$$
C_0^{\gamma/2s,\gamma}((-1/2,0)\times\overline{B_{1/2}}) \text{ and } u/d^s \in C_t^{1/2+\gamma/2s,s+\gamma}((-1/2,0)\times\overline{\Omega^+}\cap B_1).
$$

Then, $\partial_t u \in C_{t,x}^{\gamma/2s,\gamma}((-1/2,0) \times \overline{B_{1/2}})$ *and* $u/d^s \in C_{t,x}^{1/2+\gamma/2s,s+\gamma}((-1/2,0) \times \overline{\Omega^+} \cap B_{1/4})$ *and*

$$
\|\partial_t u\|_{C_{t,x}^{\gamma/2s,\gamma} \left(\left(-\frac{1}{2},0\right) \times \overline{B_{1/2}} \right)} + \|u/d^s\|_{C_{t,x}^{1/2+\gamma/2s,s+\gamma} \left(\left(-\frac{1}{2},0\right) \times \overline{\Omega^+} \cap B_{1/4} \right)} \leq CC_0. \tag{4.2}
$$

The constant C *depends only on* γ *,* $||a||_{C^{1,\gamma}(S^{n-1})}$ *, n, s, and the ellipticity constants. Proof.* Let us assume that

$$
||u||_{C_t^{\gamma/2s}((-1,0)\times\mathbb{R}^n)} + ||f||_{C_{t,x}^{\gamma/2s,\gamma}((-1,0)\times\Omega^+\cap B_1)} \leq 1,
$$

then we want to show that

$$
\|\partial_t u\|_{C^{\gamma/2s,\gamma}_{t,x}\left(\left(-\frac{1}{2},0\right)\times B_{1/2}\right)} + \|u/d^s\|_{C^{1/2+\gamma/2s,s+\gamma}_{t,x}\left(\left(-\frac{1}{2},0\right)\times\overline{\Omega^+}\cap B_{1/4}\right)} \leq C. \tag{4.3}
$$

We will bound each term separately and combine interior estimates with estimates close to the boundary.

Step 1: spatial regularity. Let $(t_0, x_0) \in (-1/2, 0) \times \overline{\Omega^+} \cap B_{1/4}$, $2r = \text{dist}(x_0, \Gamma) < 1/4$,

we will start with the following estimate:

$$
||u/d^{s}||_{C_{t,x}^{1/2+\gamma/2s,\gamma+s}(Q_r(t_0,x_0))} \leq C \tag{4.4}
$$

for a universal constant C. Thanks to Lemma 4.8 in $[FR16]$, [\(4.4\)](#page-12-0) ammounts to bound $[u/d^s]_{C_{t,x}^{1/2+\gamma/2s,\gamma+s}(Q_r(t_0,x_0))}$. We will prove the case $\gamma+s>1$ which is more difficult, the case $\gamma + s < 1$ follows similarly.

By Propositions [3.3](#page-7-0) and [3.4,](#page-11-2) we have that for $z \in \Gamma$ such that

$$
dist(x_0, \Gamma) = dist(x_0, z)
$$

there exist $l(x)$ defined by

$$
l(x) = p(t_0, z) \cdot x + q(t_0, z)
$$

such that

$$
||u/d^{s} - l||_{L^{\infty}(Q_{2r}(t_0, x_0))} \leq C r^{\alpha + \beta}.
$$

and

$$
[u/d^s - l]_{C_{t,x}^{\beta/2s,\beta}(Q_{2r}(t_0,x_0))} \le Cr^{\alpha}
$$

(with $\beta \in (\gamma, 1)$ and $\alpha = s + \gamma - \beta \in (0, s)$). This implies

$$
||u - d^{s}||_{L^{\infty}(Q_{2r}(t_0, x_0))} \leq C r^{\alpha + \beta + s}.
$$
\n(4.5)

and

$$
[u - d^{s}l]_{C_{t,x}^{\beta/2s,\beta}(Q_{2r}(t_0,x_0))} \leq Cr^{s+\alpha}.
$$
\n(4.6)

Then, the estimates on Proposition [4.1](#page-11-0) give

$$
[u - d^s l]_{C_t^{\frac{\alpha+\beta}{2s}}(Q_r(t_0, x_0))} + [\nabla (u - d^s l)]_{C_{t,x}^{\frac{\nu}{2s},\nu}(Q_r(t_0, x_0))} \leq Cr^s
$$
 (4.7)

with $\nu = \gamma + s - 1$.

Let $(t, x), (t', x') \in Q_r(t_0, x_0)$. We want to show

$$
\left| u(t,x)/d^{s}(x) - u(t',x)/d^{s}(x) \right| \leq C|t-t'|^{\frac{\alpha+\beta}{2s}} \tag{4.8}
$$

with C independent of x and

$$
\left|\nabla(u(t,x)/d^s(x)) - \nabla(u(t',x')/d^s(x'))\right| \le C(|t-t'|^{\nu/2s} + |x-x'|^{\nu}).\tag{4.9}
$$

 (4.8) follows using (4.7) and noting that the only t dependence is by u and that d^s and r^s are comparable. More precisely:

$$
u(t,x)/d^{s}(x) - u(t',x)/d^{s}(x) \leq d^{-s}(x)[u - d^{s}l]_{C_{t}^{\frac{\alpha+\beta}{2s}}(Q_{r}(t_{0},x_{0}))}|t - t'|^{\frac{\alpha+\beta}{2s}} \leq C d^{-s}(x)r^{s}|t - t'|^{\frac{\alpha+\beta}{2s}} \leq C|t - t'|^{\frac{\alpha+\beta}{2s}}.
$$

For (4.9) we have

$$
\nabla(u(t,x)/d^s(x)) = \nabla u(t,x)/d^s(x) + u(t,x)\nabla(d^{-s}(x)).
$$

Let us write

$$
\nabla(u(t,x)/d^s(x)) - \nabla(u(t',x')/d^s(x')) = \mathcal{A} + \mathcal{B} + \mathcal{C},
$$

with

$$
\mathcal{A} = \frac{\nabla(u(t,x) - d^s(x)l(x)) - \nabla(u(t',x') - d^s(x')l(x'))}{d^s(x)}
$$
\n
$$
\mathcal{B} = (d^{-s}(x) - d^{-s}(x'))\nabla(u(t',x') - d^s(x')l(x'))
$$
\n
$$
\mathcal{C} = (u(t,x) - d^s(x)l(x))\nabla d^{-s}(x)
$$
\n
$$
-(u(t',x') - d^s(x')l(x'))\nabla d^{-s}(x').
$$

Now, by (4.7) we have

$$
|\mathcal{A}| \le Cr^s d^{-s}(x) (|t-t'|^{\frac{\nu}{2s}} + |x-x'|^{\nu}) \le C(|t-t'|^{\frac{\nu}{2s}} + |x-x'|^{\nu})
$$

since d^s and r^s are comparable.

Now we need to bound \mathcal{B} :

$$
|\mathcal{B}| = |(d^{-s}(x) - d^{-s}(x'))\nabla(u(t',x') - d^{s}(x')l(x'))|.
$$

On one hand, we have

$$
|d^{-s}(x) - d^{-s}(x')| \le Cr^{-s}
$$

(see Lemma 5.5 in $[RS16]$). On the other hand, (4.6) and (4.7) imply

$$
|\nabla(u(t',x') - d^s(x')l(x'))| \le Cr^{\alpha + \beta + s - 1}
$$

hence

$$
|\mathcal{B}| \leq Cr^{\alpha+\beta-1} \leq C(|t-t'|^{\frac{\nu}{2s}}+|x-x'|^{\nu})
$$

since $r^{\delta} \sim |t-t'|^{\frac{\delta}{2s}} + |x-x'|^{\delta}$.

Finally, by a classical interpolation inequality in Hölder spaces,

$$
|\mathcal{C}| \leq \|\nabla d^{-s}\|_{L^{\infty}(B_r(x_0))}[u - d^s l]_{C_{t,x}^{\beta/2s,\beta}(Q_r(t_0,x_0))}(|t - t'|^{\frac{\beta}{2s}} + |x - x'|^{\beta})
$$

$$
+ \|u - d^s l\|_{L^{\infty}(Q_r(t_0,x_0))} |\nabla d^{-s}|_{C^{\beta}(B_r(x_0))}(|t - t'|^{\frac{\beta}{2s}} + |x - x'|^{\beta})
$$

$$
\leq C r^{-s-1} r^{\alpha+s} r^{\beta} + r^{\alpha+\beta+s} r^{-s-\beta} r^{\beta} \leq C r^{\alpha+\beta-1}
$$

and we get (4.9) and hence (4.4) .

To pass from [\(4.4\)](#page-12-0) to bound the second term on the left hand side of [\(4.3\)](#page-12-1) just notice that we can cover $(-1/2, 0) \times \overline{\Omega^+} \cap \{x_0 \in B_{1/4} : dist(x_0, \Gamma) < 1/8\}$ by a universal (dependent on Γ) number of balls in which [\(4.4\)](#page-12-0) holds and use interior estimates for the points in $(-1/2, 0) \times \overline{\Omega^+} \cap \{x_0 \in B_{1/4} : dist(x_0, \Gamma) \geq 1/8\}.$

Step 2: time regularity. For the time regularity, Proposition [4.1](#page-11-0) gives

$$
[u - d^s l]_{C^{\frac{\beta + \alpha + s}{2s}, \beta + \alpha + s}_{t, (Q_{2r}(t_0, x_0))}} \leq C
$$

for any r sufficiently small. Since the function d^{sl} is independent of time, this implies

$$
[\partial_t u]_{C^{\frac{\alpha+\beta-s}{2s},\beta+\alpha-s}_{t,x}(Q_r(t_0,x_0))} \leq C.
$$

Now recalling that $\alpha + \beta = s + \gamma$, we find

$$
[\partial_t u]_{C^{\gamma/2s,\gamma}_{t,x}(Q_r(t_0,x_0))} \leq C.
$$

Hence,

$$
\|\partial_t u\|_{C_{t,x}^{\gamma/2s,\gamma}(Q_r(t_0,x_0))} \leq C. \tag{4.10}
$$

The bound on the first term of the left hand side of [\(4.3\)](#page-12-1) follows similarly as the second term followed from (4.4) .

Proof of Theorem [1.1.](#page-2-0) The Theorem follows combining the interior estimates from [\[FR16\]](#page-20-16) with the boundary estimates from the previous Proposition.

Finally, we can also give the

Proof of Corollary [1.2.](#page-3-1) The proof is the same as that of Corollary 1.6 in [\[FR16\]](#page-20-16) but we sketch it here for completeness. We can cover Ω with a (finite, universal) number of balls in which we can apply Proposition [4.2](#page-12-2) to get

$$
\|\partial_t u\|_{C^{\gamma/2s,\gamma}_{t,x}\big((1/2,1)\times\overline{\Omega}\big)}+\|u/d^s\|_{C^{1/2+\gamma/2s,s+\gamma}_{t,x}\big((1/2,1)\times\overline{\Omega}\big)}\le CC_1.
$$

with

$$
C_1 = \|u\|_{C_t^{\gamma/2s}((1/4,1)\times\mathbb{R}^n)} + \|f\|_{C_{t,x}^{\gamma/2s,\gamma}((1/4,1)\times\Omega)}
$$

so we just need to bound $||u||_{C_t^{\gamma/2s}((1/4,1)\times\mathbb{R}^n)}$ properly (after that the result follows scaling in time). But notice that by Lemma 6.1 in [\[FR16\]](#page-20-16) with $c_0 = ||f||_{L^{\infty}((0,1)\times\Omega)}$ and $t \ge t_0 = 1/4$,

$$
||u||_{L^{\infty}((\frac{1}{4},1)\times\Omega)} \leq C \left(||u(1/4,\cdot)||_{L^{\infty}(\Omega)} + ||f||_{L^{\infty}((\frac{1}{4},1)\times\Omega)} \right) \leq C \left(||u(0,\cdot)||_{L^{2}(\Omega)} + ||f||_{L^{\infty}((0,1)\times\Omega)} \right).
$$

Since we have estimates for $||u||_{C_t^{\gamma/2s}((1/4,1)\times\mathbb{R}^n)}$ given in terms of $||u||_{L^{\infty}((\frac{1}{4},1)\times\Omega)}$ we are done (recall $u \equiv 0$ outside Ω).

5. Appendix

In this Appendix we prove Proposition [4.1.](#page-11-0) The proof will follow the same compactness argument as the boundary regularity. We start with the following Liouville type result:

Lemma 5.1. *Let* $s \in (0,1)$, $\beta \in (0,1)$ *and* $\alpha \in (0,s)$ *satisfying* $\alpha + \beta < 2s$ *. Let* w *satisfy*

$$
(\partial_t - L)(w(\cdot + \tau, \cdot + h) - w(\cdot, \cdot)) = 0 \quad \text{in} \quad (-\infty, 0) \times \mathbb{R}^n
$$

for all $h \in \mathbb{R}^n$ *and* $\tau < 0$ *. Assume also that*

$$
[w]_{C^{\frac{\beta}{2s},\beta}_{t,x}(Q_R)} \leq C R^{\alpha+s} \tag{5.1}
$$

.

for all $R \geq 1$ *. Then*

$$
w(t, x) = at + x^T A x + p \cdot x + q
$$

for some $p \in \mathbb{R}^n$ *and* $a, q \in \mathbb{R}$ *. Moreover, if* $\alpha + \beta < s$ *then* $a = 0$ *, if* $\alpha + \beta + s < 2$ *then* $A = 0$ *, and if* $\alpha + \beta + s < 1$ *then* $p = 0$ *.*

Proof. Let $\rho > 0$ and define

$$
v(t,x) = \frac{w(\rho^{2s}(t+\tau), \rho(x+h)) - w(\rho^{2s}t, \rho x)}{\rho^{\alpha+s}(|\rho\tau|^{\beta/2s} + |\rho h|^{\beta})}
$$

Note that

 $\partial_t v - Lv = 0$

in Q_1 and, by (5.1) ,

$$
||v||_{L^{\infty}(Q_R)} \leq C R^{\alpha+s}
$$

for all $R \geq 1$ and in particular

$$
||v||_{L^{\infty}(Q_1)} \leq C.
$$

Then, by the interior estimates of Theorem 1.3 in [\[FR16\]](#page-20-16) with can get, for $\theta > \alpha + s$

$$
||v||_{C^{\theta/2s,\theta}_{t,x}(Q_{1/2})} \leq C.
$$

Hence, the incremental quotients of order β of w are uniformly bounded in $C_{t,x}^{\theta/2s,\theta}$. This implies (see [\[CC95\]](#page-20-22), Lemma 5.6) $w \in C_{t,x}^{\frac{\theta+\beta}{2s},\theta+\beta}$ and scaling back we get

$$
[w]_{C^{\frac{\alpha+\beta+s}{2},\alpha+\beta+s}_{t,x^{2s},\alpha+\beta+s}(Q_{\rho})}\le [w]_{C^{\frac{\theta+\beta}{2s},\theta+\beta}_{t,x}(Q_{\rho})}\le \rho^{\alpha+s-\theta}
$$

and when we let $\rho \to \infty$ we get

$$
[w]_{C^{\frac{\alpha+\beta+s}{2},\alpha+\beta+s}_{t,x}((-\infty,0)\times\mathbb{R}^n)}=0.
$$

This gives the desired result.

The next proposition is the main tool to prove Proposition [4.1.](#page-11-0)

Proposition 5.2. *Let* $s \in (0,1)$ *,* $\gamma \in (0,s)$ *,* $\beta \in (\gamma,1)$ *and* $\alpha = s + \gamma - \beta \in (0,s)$ *. Let* w *be a solution of*

$$
\partial_t w - Lw = f \quad in \ Q_1
$$

with L an operator of the form [\(1.2\)](#page-0-0). Assume $w \in C^{\frac{\beta}{2s},\beta}_{t,x}((-\infty,0) \times \mathbb{R}^n)$, $a \in$ $C^{1,\gamma}(S^{n-1})$ and $f \in C_{t,x}^{\frac{\gamma}{2s},\gamma}(Q_1)$. Then

$$
\sup_{r>0} r^{-\alpha-s} [w - (a_r t + x^T A_r x + p_r \cdot x + q_r)]_{C_{t,x}^{\frac{\beta}{2s},\beta}(Q_r)} \leq C[w]_{C_{t,x}^{\frac{\beta}{2s},\beta}((-\infty,0)\times\mathbb{R}^n)}
$$
(5.2)

where

$$
a_r t + x^T A_r x + p_r \cdot x + q_r = \arg\min_{\mathcal{P}} \int_{-r^{2s}}^0 \int_{B_r} (w - (at + x^T A x + p \cdot x + q))^2 dx dt. \tag{5.3}
$$

where P *is the space of all polynomials of degree at most* $|(\alpha + \beta + s)/2s|$ *in* t and $|\alpha + \beta + s|$ *in* x *(i.e., and* $a_r = 0$ *if* $\alpha + \beta < s$ *,* $A_r = 0$ *if* $\alpha + \beta + s < 2$ *, and* $p_r = 0$ *if* $\alpha + \beta + s < 1$.

In particular

$$
[w]_{C^{\frac{\alpha+\beta+s}{2s},\alpha+\beta+s}_{t,x}(Q_{1/2})} \leq C[w]_{C^{\frac{\beta}{2s},\beta}_{t,x}((-\infty,0)\times\mathbb{R}^n)}.
$$
\n(5.4)

Proof. The proof is similar to that of Proposition [3.3.](#page-7-0) Assume [\(5.2\)](#page-16-0) does not hold. Then there are sequences w_k , L_k and f_k satisfying:

- L_k is of the form (1.2) and $a_k \in C^{1,\gamma}(S^{n-1})$
- $w_k \in C_{t,x}^{\beta/2s,\beta}((-\infty,0) \times \mathbb{R}^n)$ and $f_k \in C_{t,x}^{\gamma/2s,\gamma}(Q_1)$
- w_k is a solution of

$$
\partial_t w_k - L_k w_k = f_k \quad \text{in } Q_1 \tag{5.5}
$$

such that

$$
\sup_{k} \sup_{r>0} r^{-\alpha-s} [w_k - (a_{r,k}t + x^T A_{r,k}x + p_{r,k} \cdot x + q_{r,k})]_{C_{t,x}^{\beta/2s,\beta}(Q_r)} = \infty.
$$

with

$$
a_{r,k}t + x^T A_{r,k}x + p_{r,k} \cdot x + q_{r,k} = \arg\min_{\mathcal{P}} \int_{-r^{2s}}^0 \int_{B_r} (w_k - (at + x^T A x + p \cdot x + q))^2 dx dt.
$$

Define

$$
\theta(r) := \sup_{k} \sup_{r' > r} (r')^{-\alpha - s} [w_k - (a_{r',k}t + x^T A_{r',k} x + p_{r',k} \cdot x + q_{r',k})]_{C_{t,x}^{\beta}, \beta}(Q_{r'})}.
$$

As before, θ is a nondecreasing function of r that goes to ∞ as r goes to 0. Moreover, since for any fixed r we have $\theta(r) < \infty$, if we take the sequence $1/m$ there are r'_m and k_m such that $r'_m \geq 1/m$ and

$$
(r'_m)^{-\alpha-s}[w_{k_m} - (a_{r'_m,k_m}t + x^TA_{r'_m,k_m}x + p_{r'_m,k_m}\cdot x + q_{r'_m,k_m})]_{C_{t,x}^{\beta/2s,\beta}(Q_{r'_m})} \geq \frac{1}{2}\theta(1/m) \geq \frac{1}{2}\theta(r'_m).
$$

Let's denote

$$
w_m = w_{k_m} \quad A_m = A_{r'_m, k_m} \quad p_m = p_{r'_m, k_m} \quad q_m = q_{r'_m, k_m} \quad a_m = a_{r'_m, k_m}
$$

to make the notation cleaner, and further denote

$$
P_{r,m}(t,x) = a_m r^{2s} t + x^T A_m x r^2 + p_m \cdot rx + q_m.
$$

With this notation we define the blow-up sequence

$$
v_m(t,x) = \frac{w_m((r'_m)^{2s}t, r'_mx) - P_{r'_m,m}(t,x)}{(r'_m)^{\alpha+\beta+s}\theta(r'_m)}.
$$

Notice that

$$
[v_m]_{C_{t,x}^{\beta/2s,\beta}(Q_1)} \ge 1/2
$$
\n(5.6)

and that

$$
\int_{-1}^{0} \int_{B_1} v_m(at + x^T A x + p \cdot x + q) dx dt = 0
$$
\n(5.7)

for all $A \in \mathbb{R}^{n \times n}$, $p \in \mathbb{R}^n$ and $a, q \in \mathbb{R}$ because of the minimization condition [\(5.3\)](#page-16-1). Next we show that

$$
[v_m]_{C^{\beta/2s,\beta}(Q_R)} \le CR^{\alpha+s} \tag{5.8}
$$

for any $R \geq 1$. As before, this requires an estimate of the form

$$
[P_{Rr'_{m},m} - P_{r'_{m},m}]_{C_{t,x}^{\beta/2s,\beta}(Q_{Rr'_{m}})} \leq \theta(r'_{m})(Rr'_{m})^{\alpha+s}.
$$
 (5.9)

The only difference between the proof [\(5.9\)](#page-17-0) and [\(3.10\)](#page-8-1) is the presence of a quadratic term so, to keep the presentation clear, let us assume for simplicity that the linear terms vanish and prove the bound for the quadratic term.

Hence, proceeding dyadically as in Proposition [3.3,](#page-7-0) we have to show that

$$
[x^T A_{2^k r'_m, m} x - x^T A_{r'_m, m} x]_{C^{\beta/2s, \beta}_{t, x}(Q_{R r'_m})} \leq C \theta(r'_m) (R r'_m)^{\alpha+s}.
$$

Let us start with $k = 1$ and noticing that

$$
\frac{1}{(r_m')^{\alpha+s}\theta(r_m')}|x^T(A_{2r_m',m}-A_{r_m',m})x|(r_m')^{2-\beta} \leq \frac{1}{(r_m')^{\alpha+s}\theta(r_m')}[x^TA_{2r_m',m}x-x^TA_{r_m',m}x]_{C_{t,x}^{\beta/2s,\beta}(Q_{r_m'})} \leq \frac{2^{\alpha+s}\theta(2r_m')}{\theta(r_m')} \frac{[w_m-x^TA_{2r_m',m}x]_{C_{t,x}^{\beta/2s,\beta}(Q_{2r_m')}}{(2r_m')^{\alpha+s}\theta(2r_m')} \frac{1}{(r_m')^{\alpha+s}\theta(r_m')}[w_m-x^TA_{r_m',m}x]_{C_{t,x}^{\beta/2s,\beta}(Q_{r_m'})} \leq C
$$

so that, denoting by $\|\cdot\|$ is the L^2 matrix norm, i.e. $\|M\| = \sup_{|x|=1} |x^T M x|$ and taking supremum over x

$$
||A_{2r'_m,m} - A_{r'_m,m}|| \leq C(r'_m)^{\alpha+\beta+s-2}\theta(r'_m).
$$

But on the other hand,

$$
[x^T A_{2r'_m,m} x - x^T A_{r'_m,m} x]_{C_{t,x}^{\beta/2s,\beta}(Q_{2r'_m})} \leq C \|A_{2r'_m,m} - A_{r'_m,m}\|(r'_m)^{2-\beta}
$$

so the result follows in this case. For $R = 2^k$ just use a telescopic sum as in Proposition [3.3.](#page-7-0)

Using [\(5.9\)](#page-17-0) we have

$$
[v_{m}]_{C_{t,x}^{\beta/2s,\beta}(Q_{R})} = \frac{1}{(r'_{m})^{\alpha+s}\theta(r'_{m})} [w_{m} - P_{r'_{m},m}]_{C_{t,x}^{\beta/2s,\beta}(Q_{Rr'_{m}})}
$$

\n
$$
= \frac{R^{\alpha+s}}{(Rr'_{m})^{\alpha+s}\theta(r'_{m})} [w_{m} - P_{r'_{m},m}]_{C_{t,x}^{\beta/2s,\beta}(Q_{Rr'_{m}})}
$$

\n
$$
\leq \frac{R^{\alpha+s}}{(Rr'_{m})^{\alpha+s}\theta(r'_{m})} [w_{m} - P_{Rr'_{m},m}]_{C_{t,x}^{\beta/2s,\beta}(Q_{Rr'_{m}})}
$$

\n
$$
+ \frac{R^{\alpha+s}}{(Rr'_{m})^{\alpha+s}\theta(r'_{m})} [P_{Rr'_{m},m} - P_{r'_{m},m}]_{C_{t,x}^{\beta/2s,\beta}(Q_{Rr'_{m}})}
$$

\n
$$
\leq \frac{R^{\alpha+s}\theta(Rr'_{m})}{\theta(r'_{m})} + C \frac{R^{\alpha+s}}{(Rr'_{m})^{\alpha+s}\theta(r'_{m})} (Rr'_{m})^{\alpha+s}\theta(r'_{m})
$$

\n
$$
\leq CR^{\alpha+s}
$$

and we get [\(5.8\)](#page-17-1). From [\(5.8\)](#page-17-1) the bound

$$
||v_m||_{L^{\infty}(Q_R)} \leq CR^{\alpha+\beta+s} \tag{5.10}
$$

follows as in Proposition [3.3.](#page-7-0)

By the Arzelà-Ascoli theorem, [\(5.8\)](#page-17-1) and [\(5.10\)](#page-18-0) imply that a subsequence of $\{v_m\}_m$ converges uniformly on compact subsets of $(-\infty,0) \times \mathbb{R}^n$ to a uniformly continuous function v . Let's check that v satisfies the hypotheses of Lemma [5.1.](#page-15-1) As in Proposition [3.3](#page-7-0) we have

$$
(\partial_t - L_{k_m})(v_m(t + \tau, x + h) - v_m(t, x)) \longrightarrow 0
$$

as $m \to \infty$ (notice that the quadratic term can only appear when $s > 1/2$ and in this case the operator is well defined on linear functions and vanishes identically). So, again using Lemma [3.1](#page-6-1)

$$
(\partial_t - L)(v(t + \tau, x + h) - v(t, x)) = 0
$$

for some L of the form (1.2) . Finally, because of (5.8) , v also satisfies the growth condition of Lemma [5.1.](#page-15-1) Hence

$$
v(t, x) = at + x^T A x + p \cdot x + q,
$$

and by [\(5.7\)](#page-17-2) we obtain $v \equiv 0$. But passing to the limit in [\(5.6\)](#page-17-3) we get a contradiction, so (5.2) holds. The fact that (5.2) implies (5.4) is quite standard.

Proof of Proposition [4.1.](#page-11-0) Fix $r > 0$ and consider the following rescaling of w:

$$
\tilde{w}(t,x) = \frac{1}{r^{\alpha+\beta+s}} w(r^{2s}t, rx).
$$

Then \tilde{w} will satisfy

$$
\|\tilde{w}\|_{L^{\infty}((-\infty,0)\times\mathbb{R}^n)} < \infty \quad \text{ and } \|\tilde{w}\|_{L^{\infty}(Q_R)} \leq CR^{\alpha+\beta+s}.
$$

Let now η be a cut-off function in space that vanishes outside $B_1(e_n)$. More precisely, let $\eta \in C_c^{\infty}(B_1(e_n))$ with $\eta \equiv 1$ in $B_{5/6}(e_n)$. Notice that $\tilde{\psi}\eta$ satisfies an equation like the one in Proposition [5.2.](#page-16-3) Indeed, because $a \in C^{1,\gamma}(S^{n-1})$ we have that,

$$
\partial_t \tilde{w}\eta - L\tilde{w}\eta = \tilde{f} \quad \text{in} \quad (-1,0) \times B_{3/4}(e_n)
$$

and hence [\(5.4\)](#page-16-2) gives (recall $\tilde{w} = \tilde{w}\eta$ in $B_{1/2}$)

$$
[\tilde{w}]_{C^{\frac{\alpha+\beta+s}{2s},\alpha+\beta+s}_{t,x}((-1,0)\times B_{1/2}(e_n))}\leq C[\tilde{w}]_{C^{\frac{\beta}{2s},\beta}_{t,x}((-1,0)\times B_{1}(e_n))},
$$

and in particular also

$$
[\tilde{w}]_{C^{\frac{\alpha+\beta}{2s},\alpha+\beta}_{t,x}((-1,0)\times B_{1/2}(e_n))} \leq C[\tilde{w}]_{C^{\frac{\beta}{2s},\beta}_{t,x}((-1,0)\times B_1(e_n))}.
$$

Rescaling this estimate back we get

$$
[w]_{C^{\frac{\alpha+\beta+s}{2s},\alpha+\beta+s}_{t,x}((-r^{2s},0)\times B_{r/2}(e_n))} \leq r^{-\alpha-s}C[w]_{C^{\frac{\beta}{2s},\beta}_{t,x}((-1,0)\times B_r(e_n))} \leq Cr^{-\alpha-s}r^{s+\alpha}=C
$$

and

$$
[w]_{C^{\frac{\alpha+\beta}{2s},\alpha+\beta}_{t,x}((-r^{2s},0)\times B_{r/2}(e_n))} \leq r^{-\alpha}C[w]_{C^{\frac{\beta}{2s},\beta}_{t,x}((-1,0)\times B_r(e_n))} \leq Cr^{-\alpha}r^{s+\alpha} = Cr^s,
$$

as wanted. \square
