NON-EXISTENCE OF EXTREMALS FOR THE ADIMURTHI-DRUET INEQUALITY

ABSTRACT. The Adimurthi-Druet [\[1\]](#page-15-0) inequality is an improvement of the standard Moser-Trudinger inequality by adding a L^2 -type perturbation, quantified by $\alpha \in [0, \lambda_1)$, where λ_1 is the first Dirichlet eigenvalue of Δ on a smooth bounded domain. It is known [\[3,](#page-15-1) [9,](#page-15-2) [13,](#page-16-0) [18\]](#page-16-1) that this inequality admits extremal functions, when the perturbation parameter α is small. By contrast, we prove here that the Adimurthi-Druet inequality does not admit any extremal, when the perturbation parameter α approaches λ_1 . Our result is based on sharp expansions of the Dirichlet energy for blowing sequences of solutions of the corresponding Euler-Lagrange equation, which take into account the fact that the problem becomes singular as $\alpha \to \lambda_1$.

1. INTRODUCTION

Let Ω be a smooth bounded domain of \mathbb{R}^2 . We let H_0^1 be the usual Sobolev and Hilbert space of functions in Ω , endowed with the scalar product

$$
\langle u, v \rangle_{H_0^1} = \int_{\Omega} \nabla u. \nabla v \, dy,
$$

and with the associated norm denoted by $\|\cdot\|_{H_0^1}$. For all $\alpha \geq 0$, we let $C_{\alpha}(\Omega)$ be given by

$$
C_{\alpha}(\Omega) = \sup_{\left\{u \in H_0^1 \text{ s.t. } \|\nabla u\|_2 = 1\right\}} \int_{\Omega} \exp\left(4\pi u(y)^2 \left(1 + \alpha \|u\|_2^2\right)\right) dy. \tag{1.1}
$$

Then, the Adimurthi-Druet [\[1\]](#page-15-0) inequality claims that

$$
C_{\alpha}(\Omega) < +\infty \Leftrightarrow \alpha < \lambda_1 ,
$$

where $\lambda_1 > 0$ is the first eigenvalue of $\Delta = -\partial_{xx} - \partial_{yy}$ in Ω with zero Dirichlet boundary condition on $\partial\Omega$.

While the existence of an extremal function for $\alpha = 0$, i.e. for the standard Moser-Trudinger inequality, was obtained by Carleson-Chang [\[3\]](#page-15-1), Struwe [\[18\]](#page-16-1) and Flucher [\[9\]](#page-15-2), Yang and Lu [\[13\]](#page-16-0) were able to prove that there exists an extremal function for [\(1.1\)](#page-0-0) for all $\alpha \geq 0$ sufficiently close to 0. More recently, still concerning the original Adimurthi-Druet inequality [\(1.1\)](#page-0-0), it was explained in Yang [\[20\]](#page-16-2) that the existence of extremals for more general α 's closer to λ_1 is left open. We prove here that, surprisingly, there is no extremal function for [\(1.1\)](#page-0-0) for all $\alpha < \lambda_1$ sufficiently close to λ_1 . Then, our main result is stated as follows.

Theorem 1.1 (Non existence of extremals). Let Ω be a smooth, bounded and connected domain of \mathbb{R}^2 . Let $\lambda_1 > 0$ be the first eigenvalue of Δ with zero Dirichlet boundary condition. Then there exists $\alpha_0 \in (0, \lambda_1)$ such that, for all $\alpha \in [\alpha_0, \lambda_1)$, there is no extremal function for [\(1.1\)](#page-0-0).

The proof of Theorem [1.1](#page-1-0) relies on the recent progresses concerning the blow-up analysis of Moser-Trudinger equations (see [\[8,](#page-15-3) [14\]](#page-16-3)). The difficulty in this problem is a cancellation of the first terms in the Dirichlet energy expansions of Section [2,](#page-2-0) which enforces to carry out in Section [3](#page-3-0) a very precise blow-up analysis. For instance, the estimates obtained in [\[1\]](#page-15-0) and [\[13\]](#page-16-0) are far from being sufficient to conclude here. Note that a similar cancellation was already observed by Martinazzi-Mancini [\[15\]](#page-16-4) in the radial case, namely when Ω is the unit disk \mathbb{D}^2 of \mathbb{R}^2 . Even in this more particular case, the authors had to carry out a very careful blow-up analysis of the next lower order terms in order to conclude. To be able to deal with the general (non necessarily radial) situation, we use here the techniques developed in Druet-Thizy [\[8\]](#page-15-3). But, a new additional serious difficulty here is that the problem becomes singular when α gets close to λ_1 . By *singular*, we mean here that the kernel of the operator obtained by linearizing the limiting equation at 0 does not only contain the zero function. Here (see (2.4) , (2.6) and (2.9)), this operator is $\Delta - \lambda_1$ with zero Dirichlet boundary condition and we have to compute carefully (see Step [3.4\)](#page-11-0) what happens in its kernel.

As already observed by Del Pino-Musso-Ruf [\[5\]](#page-15-4) in the non-singular case, the critical exponential non-linearity $\exp(u^2)$ in dimension 2 is more difficult to handle than the Sobolev critical non-linearity $u^{\frac{n+2}{n-2}}$ in higher dimensions $n > 2$, and getting sharp energy expansions of positive blow-up solutions reveals to be delicate in this case. Besides, even for Sobolev critical problems in higher dimensions, understanding the behavior of positive blow-up solutions turned out to be very challenging in the singular case. This difficulty was overcome while solving Lin-Ni's conjecture (see Druet-Robert-Wei [\[7\]](#page-15-5), Rey-Wei [\[17\]](#page-16-5) and Wei-Xu-Yang [\[19\]](#page-16-6) and the references therein), where the limiting linearized operator is Δ with zero Neumann boundary condition, whose kernel is the set of the constant functions.

As far as we know, Theorem [1.1](#page-1-0) is the first result proving the non-existence of extremals for an explicit Moser-Trudinger type inequality with critical exponent on bounded domains. Indeed, similar results had so far been proven only for implicit perturbations of the Moser-Trudinger inequality [\[16\]](#page-16-7), or for sub-critical inequalities on \mathbb{R}^2 [\[11\]](#page-16-8), where blow-up of maximizing sequences cannot occur.

The paper is organized as follows. Theorem [1.1](#page-1-0) is proved in Section [2.](#page-2-0) This proof relies on the key energy estimates of Proposition [3.1,](#page-3-2) whose proof is given in Section [3.](#page-3-0)

2. Proof of Theorem [1.1](#page-1-0)

Assume by contradiction that there exists a sequence $(\alpha_i)_i$ such that $\alpha_i \to \lambda_1^$ and such that there exists an extremal function $u_{\alpha_i} \geq 0$ for $C_{\alpha_i}(\Omega)$. For simplicity, we drop the indexes *i*'s. Then the u_{α} 's satisfy

$$
\begin{cases}\n\Delta u_{\alpha} = A_{\alpha} u_{\alpha} + 2\beta_{\alpha} \lambda_{\alpha} u_{\alpha} \exp(\beta_{\alpha} u_{\alpha}^{2}) \text{ in } \Omega, & u_{\alpha} = 0 \text{ in } \partial\Omega, \\
\|\nabla u_{\alpha}\|_{2}^{2} = 1, & \beta_{\alpha} = 4\pi \left(1 + \alpha \|u_{\alpha}\|_{2}^{2}\right), \\
A_{\alpha} = \frac{\alpha}{1 + 2\alpha \|u_{\alpha}\|_{2}^{2}} < \lambda_{1},\n\end{cases}
$$
\n(2.1)

for some positive λ_{α} 's, and in particular, the u_{α} 's are smooth. Indeed, the Moser-Trundinger inequality gives that

$$
u \in H_0^1 \implies \exp(u^2) \in L^p,
$$

for all $1 \le p < +\infty$, and then standard elliptic theory applies. Since $C_{\lambda_1}(\Omega) = +\infty$, we get that

$$
C_{\alpha}(\Omega) \to +\infty \tag{2.2}
$$

as $\alpha \to \lambda_1^-$, by the monotone convergence theorem. Then, by Lions [\[12,](#page-16-9) Theorem I.6], we have that, up to a subsequence,

$$
u_{\alpha} \rightharpoonup 0 \text{ in } H_0^1, \quad u_{\alpha} \to 0 \text{ in } L^p \text{ for all } p < +\infty, \quad \|u_{\alpha}\|_{L^{\infty}} \to +\infty \tag{2.3}
$$

and thus that

$$
\beta_{\alpha} \to 4\pi \text{ and } A_{\alpha} \to \lambda_1^-, \tag{2.4}
$$

as $\alpha \to \lambda_1^-$. Now we rephrase everything in terms of

$$
v_{\alpha} := \sqrt{\beta_{\alpha}} u_{\alpha} \,. \tag{2.5}
$$

We have that

$$
\begin{cases}\n\Delta v_{\alpha} = v_{\alpha} \left(A_{\alpha} + \Lambda_{\alpha} \exp(v_{\alpha}^{2}) \right) \text{ in } \Omega, \quad v_{\alpha} = 0 \text{ in } \partial \Omega, \\
\beta_{\alpha} = 4\pi \left(1 + \frac{\alpha}{\beta_{\alpha}} ||v_{\alpha}||_{2}^{2} \right), \\
A_{\alpha} = \frac{\alpha}{1 + 2\frac{\alpha}{\beta_{\alpha}} ||v_{\alpha}||_{2}^{2}} \left(\langle \alpha \langle \lambda_{1} \rangle, \right.\n\end{cases} \tag{2.6}
$$

where $\Lambda_{\alpha} = 2\beta_{\alpha}\lambda_{\alpha} > 0$. Moreover, $\|\nabla u_{\alpha}\|_{2}^{2} = 1$ implies

$$
\|\nabla v_{\alpha}\|_2^2 = \beta_{\alpha} \,. \tag{2.7}
$$

We also get that $||v_{\alpha}||_2 \to 0$ as $\alpha \to \lambda_1^-$ and the second line of [\(2.6\)](#page-2-2) implies

$$
\beta_{\alpha} = 2\pi \left(1 + \sqrt{1 + \frac{\alpha \int_{\Omega} v_{\alpha}^2 dy}{\pi}} \right)
$$

= $4\pi \left(1 + \frac{\alpha \int_{\Omega} v_{\alpha}^2 dy}{4\pi} - \frac{\alpha^2 \left(\int_{\Omega} v_{\alpha}^2 dy \right)^2}{16\pi^2} + O\left(\left(\int_{\Omega} v_{\alpha}^2 dy \right)^3 \right) \right).$ (2.8)

Now, we have that

$$
\int_{\Omega} \exp(v_{\alpha}^2) dy = \int_{\Omega} \exp(\beta_{\alpha} u_{\alpha}^2) dy = C_{\alpha}(\Omega) \to +\infty,
$$

and, independently, that

$$
\Lambda_{\alpha} \int_{\Omega} v_{\alpha}^{2} \exp(v_{\alpha}^{2}) dy = \int_{\Omega} |\nabla v_{\alpha}|^{2} dy - A_{\alpha} \int_{\Omega} v_{\alpha}^{2} dy = 4\pi + o(1),
$$

so that there must be the case that

$$
\Lambda_{\alpha} \to 0 \tag{2.9}
$$

as $\alpha \to \lambda_1^-$, since $e^t \leq 1 + te^t$ for $t \geq 0$. We are now in position to use Proposition [3.1](#page-3-2) below: we have that

$$
\|\nabla v_{\alpha}\|_{2}^{2} = 4\pi \left(1 + \frac{A_{\alpha}}{4\pi} \int_{\Omega} v_{\alpha}^{2} dy + o\left(\left(\int_{\Omega} v_{\alpha}^{2} dy\right)^{2}\right)\right)
$$
(2.10)

as $\alpha \to \lambda_1^-$. Then, expanding the third line of [\(2.6\)](#page-2-2), we get

$$
A_{\alpha} = \alpha - \frac{\alpha^2 \int_{\Omega} v_{\alpha}^2 dy}{2\pi} + O\left(\left(\int_{\Omega} v_{\alpha}^2 dy\right)^2\right). \tag{2.11}
$$

Now, [\(2.10\)](#page-3-3) and [\(2.11\)](#page-3-4) give

$$
\beta_{\alpha} = 4\pi \left(1 + \frac{\alpha}{4\pi} \int_{\Omega} v_{\alpha}^2 dy - \frac{\alpha^2}{8\pi^2} \left(\int_{\Omega} v_{\alpha}^2 dy \right)^2 + o\left(\left(\int_{\Omega} v_{\alpha}^2 dy \right)^2 \right) \right). \tag{2.12}
$$

But (2.8) and (2.12) have to match, then we get

$$
-\frac{\lambda_1^2}{16\pi^2} \left(\int_{\Omega} v_\alpha^2 dy \right)^2 = o\left(\left(\int_{\Omega} v_\alpha^2 dy \right)^2 \right),\tag{2.13}
$$

which is the contradiction we look for.

3. Blow-up analysis on [\(2.6\)](#page-2-2)

Proposition 3.1. Let $(v_\alpha)_\alpha$ be a sequence of smooth solutions of

$$
\begin{cases}\n\Delta v_{\alpha} = v_{\alpha} \left(A_{\alpha} + \Lambda_{\alpha} \exp(v_{\alpha}^2) \right), & v_{\alpha} > 0 \text{ in } \Omega, \\
v_{\alpha} = 0 \text{ in } \partial \Omega,\n\end{cases}
$$
\n(3.1)

for $A_\alpha \in [0, \lambda_1)$ and $\Lambda_\alpha > 0$, for all α slightly smaller than λ_1 . We let $\beta_\alpha > 0$ be given by [\(2.7\)](#page-2-4) and we assume that [\(2.4\)](#page-2-1) and [\(2.9\)](#page-3-1) hold true. We also assume that the v_{α} 's blow-up, namely that

$$
\gamma_{\alpha} := \max_{\Omega} v_{\alpha} = v_{\alpha}(x_{\alpha}) \to +\infty, \qquad (3.2)
$$

as $\alpha \to \lambda_1^-$, for $x_\alpha \in \Omega$. Then, we have that

$$
\gamma_{\alpha}^{2} \int_{\Omega} v_{\alpha}^{2} dy \to +\infty , \qquad (3.3)
$$

that

$$
\Lambda_{\alpha} = o\left(\frac{1}{\gamma_{\alpha}^2}\right) \tag{3.4}
$$

and that [\(2.10\)](#page-3-3) hold true as $\alpha \to \lambda_1^-$.

Note that [\(3.3\)](#page-3-6) and [\(3.4\)](#page-3-7) (proved in Step [3.4\)](#page-11-0) are specific to our singular case $A_{\alpha} \to \lambda_1^-$: they would not hold true if the limit of the A_{α} 's were in $[0, \lambda_1)$.

Now we turn to the proof of this result. In order to prove Proposition [3.1,](#page-3-2) we study the asymptotic behavior of the v_{α} 's as $\alpha \to \lambda_1^-$. We make the assumptions of Proposition [3.1.](#page-3-2) First, by these assumptions on $(\Lambda_{\alpha})_{\alpha}$ and $(A_{\alpha})_{\alpha}$, the family $(f_{\alpha})_{\alpha}$ of functions, given by

$$
f_{\alpha}(t) = t(A_{\alpha} + \Lambda_{\alpha} \exp(t^2)),
$$

is of uniform critical growth in the sense of [\[6,](#page-15-6) Definition 1]. Also, as in [\[6\]](#page-15-6) (see also the original argument in [\[2\]](#page-15-7)), if μ_{α} is given by

$$
\mu_{\alpha}^{-2} := \frac{\Lambda_{\alpha}}{4} \gamma_{\alpha}^{2} \exp(\gamma_{\alpha}^{2}) \to +\infty ,
$$
\n(3.5)

then there exists a sequence of positive numbers $(R_{\alpha})_{\alpha}$ such that $R_{\alpha} \to +\infty$, $R_{\alpha}\mu_{\alpha} \ll d(x_{\alpha}, \partial \Omega)$, and

$$
\left\|\gamma_{\alpha}\left(\gamma_{\alpha}-v_{\alpha}\left(x_{\alpha}+\mu_{\alpha}\cdot\right)\right)-T_{0}\right\|_{C^{2}(B_{0}(R_{\alpha}))}\to 0\tag{3.6}
$$

as $\alpha \to \lambda_1^-$, where $T_0 := \log (1 + |\cdot|^2)$. We recall that T_0 solves the Liouville equation

$$
\Delta T_0 = 4 \exp(-2T_0) \tag{3.7}
$$

in \mathbb{R}^2 . Note that [\(3.1\)](#page-3-8), [\(3.2\)](#page-3-9) and $||v_\alpha||_{H_0^1} = O(1)$ imply that

$$
\Lambda_{\alpha} \exp(\gamma_{\alpha}^2) \to +\infty \,, \tag{3.8}
$$

as $\alpha \to \lambda_1^-$. Moreover, the PDE in [\(3.1\)](#page-3-8) is autonomous and the f_{α} 's are increasing in $[0, +\infty)$. Therefore, as pointed out in [\[1\]](#page-15-0), the arguments in de Figueiredo-Lions-Nussbaum [\[4\]](#page-15-8) and Han [\[10\]](#page-15-9) give that the $x_α$'s do not go to the boundary of $Ω$. Then, up to a subsequence,

$$
x_{\alpha} \to \bar{x} \tag{3.9}
$$

as $\alpha \to \lambda_1^-$, for some $\bar{x} \in \Omega$. Let B_α be the radially symmetric solution around x_α of

$$
\begin{cases}\n\Delta B_{\alpha} = B_{\alpha} \left(A_{\alpha} + \Lambda_{\alpha} \exp \left(B_{\alpha}^{2} \right) \right), \\
B_{\alpha}(x_{\alpha}) = \gamma_{\alpha} .\n\end{cases}
$$
\n(3.10)

Let \bar{v}_{α} be given by

$$
\bar{v}_{\alpha}(z) = \frac{1}{2\pi|x_{\alpha} - z|} \int_{\partial B_{x_{\alpha}}(|x_{\alpha} - z|)} v_{\alpha}(y) d\sigma(y)
$$
(3.11)

for all $z \in \Omega \backslash \{x_\alpha\}$ and $\bar{v}_\alpha(x_\alpha) = v_\alpha(x_\alpha)$. Also we let t_α be given by

$$
t_{\alpha}(y) = \log\left(1 + \frac{|y - x_{\alpha}|^2}{\mu_{\alpha}^2}\right) = T_0\left(\frac{y - x_{\alpha}}{\mu_{\alpha}}\right). \tag{3.12}
$$

By abuse of notations, we will write sometimes $B_{\alpha}(r)$, $t_{\alpha}(r)$ or $\bar{v}_{\alpha}(r)$ instead of $B_{\alpha}(z)$, $t_{\alpha}(z)$ or $\bar{v}_{\alpha}(z)$ respectively, for $|z - x_{\alpha}| = r$. For any $\delta \in (0,1)$, we let $r_{\alpha,\delta} > 0$ be given by

$$
t_{\alpha}(r_{\alpha,\delta}) = \delta \gamma_{\alpha}^{2} \,. \tag{3.13}
$$

Observe that [\(3.13\)](#page-4-0) implies

$$
r_{\alpha,\delta}^2 = \mu_\alpha^2 \exp\left(\delta \gamma_\alpha^2 + o(1)\right) \gg \mu_\alpha^2,\tag{3.14}
$$

as $\alpha \to \lambda_1^-$. At last, by [\[6,](#page-15-6) Proposition 2], there exists $D_0 > 0$ such that

$$
|\cdot - x_{\alpha}| |\nabla v_{\alpha}| v_{\alpha} \le D_0 \text{ in } \Omega \tag{3.15}
$$

for all $0 < \lambda_1 - \alpha \ll 1$. The first rather elementary step is as follows.

Step 3.1. As $\alpha \to \lambda_1^-$, we have that

$$
|\log \Lambda_{\alpha}| = o(\gamma_{\alpha}^2). \tag{3.16}
$$

Moreover, for all $\delta \in (0,1)$ and all sequences $(z_{\alpha})_{\alpha}$ of points $z_{\alpha} \in B_{x_{\alpha}}(r_{\alpha,\delta}),$ we have that

$$
v_{\alpha}(z_{\alpha}) \ge \gamma_{\alpha}(1 - \delta + o(1)),\tag{3.17}
$$

and in particular $r_{\alpha,\delta} < d(x_\alpha, \partial\Omega)$.

Proof of Step [3.1.](#page-4-1) Let $R_0 > 0$ be such that $\overline{\Omega} \subset B_{\overline{x}}(R_0)$. Let also Ω_{α} be given by $\Omega_{\alpha} = B_{x_{\alpha}}(R_0) \backslash B_{x_{\alpha}}(\mu_{\alpha})$. We extend v_{α} by 0 outside Ω . Let V_{α} be the unique harmonic function in Ω_{α} such that $V_{\alpha} = v_{\alpha}$ in $\partial \Omega_{\alpha}$. Then, by construction of V_{α} , we know that

$$
\int_{\Omega_{\alpha}} |\nabla V_{\alpha}|^2 dy \le \int_{\Omega_{\alpha}} |\nabla v_{\alpha}|^2 dy, \qquad (3.18)
$$

for all α . Let now $\check{A}_{\alpha} > 0$ be such that $\Psi_{\alpha} := \check{A}_{\alpha} \log \frac{R_0}{|\cdot - x_{\alpha}|}$ and $\gamma_{\alpha} - \frac{t_{\alpha}}{\gamma_{\alpha}}$ coincide on $\partial B_{x_\alpha}(\mu_\alpha)$. Then, we easily get from [\(3.5\)](#page-4-2) that

$$
\check{A}_{\alpha} = \frac{\gamma_{\alpha}^2 - \log 2}{\gamma_{\alpha} \log \frac{R_0}{\mu_{\alpha}}} = \frac{\gamma_{\alpha} (1 + o(1))}{\log \frac{1}{\mu_{\alpha}}}.
$$
\n(3.19)

By [\(3.6\)](#page-4-3) and elliptic estimates, we get that

$$
|\nabla V_{\alpha} - \nabla \Psi_{\alpha}| \le o\left(\frac{1}{\gamma_{\alpha}|\cdot - x_{\alpha}|}\right) \text{ in } \Omega_{\alpha}
$$
 (3.20)

for all $0 < \lambda_1 - \alpha \ll 1$. Then, we get from [\(3.19\)](#page-5-0) and [\(3.20\)](#page-5-1) that

$$
\int_{\Omega_{\alpha}} |\nabla V_{\alpha}|^2 dy = \pi \check{A}_{\alpha}^2 \log \frac{1}{\mu_{\alpha}^2} (1 + o(1))
$$

$$
= \frac{4\pi \gamma_{\alpha}^2 (1 + o(1))}{\log \frac{1}{\mu_{\alpha}^2}}.
$$
(3.21)

By [\(3.18\)](#page-5-2), [\(3.21\)](#page-5-3), and since $||v_{\alpha}||_{H_0^1}^2 \leq 4\pi + o(1)$, we get that

$$
\log \frac{1}{\mu_{\alpha}^2} \ge (1 + o(1))\gamma_{\alpha}^2,
$$

which concludes the proof of (3.16) using also (2.9) and (3.5) . Now we prove (3.17) . Observe that [\(3.5\)](#page-4-2), [\(3.14\)](#page-4-6) and [\(3.16\)](#page-4-4) imply $r_{\alpha,\delta} \to 0$, as $\alpha \to \lambda_1^-$. Let $\bar{\delta}$ be given in $(0, d(\bar{x}, \partial \Omega))$, for \bar{x} as in [\(3.9\)](#page-4-7). Let now $\tilde{A}_{\alpha} > 0$ be such that $\tilde{\Psi}_{\alpha} := \tilde{A}_{\alpha} \log \frac{\bar{\delta}}{|\cdot - x_{\alpha}|}$ and $\gamma_{\alpha} - \frac{t_{\alpha}}{\gamma_{\alpha}}$ coincide on $\partial B_{x_{\alpha}}(\mu_{\alpha})$. Using [\(3.5\)](#page-4-2) and [\(3.16\)](#page-4-4), we easily get that

$$
\tilde{A}_{\alpha} = \frac{2 + o(1)}{\gamma_{\alpha}}.
$$
\n(3.22)

But since $0 = \Delta \tilde{\Psi}_{\alpha} \leq \Delta v_{\alpha}$ in $\tilde{\Omega}_{\alpha} := B_{x_{\alpha}}(\bar{\delta}) \backslash B_{x_{\alpha}}(\mu_{\alpha})$ and since $\tilde{\Psi}_{\alpha} \leq v_{\alpha} + o(\gamma_{\alpha}^{-1})$ in $\partial \tilde{\Omega}_{\alpha}$, we get from [\(3.6\)](#page-4-3) and the maximum principle that

\tilde{\Psi}_{\alpha} \le v_{\alpha} + o(\gamma_{\alpha}^{-1}) \text{ in } \tilde{\Omega}_{\alpha}.
$$
\n(3.23)

But by [\(3.5\)](#page-4-2), [\(3.13\)](#page-4-0), [\(3.14\)](#page-4-6) and [\(3.22\)](#page-5-4), for $z_{\alpha} \in B_{x_{\alpha}}(r_{\alpha,\delta})$, we have that

As a by-product of Step [3.2,](#page-6-0) B_{α} is radially decreasing in $B_{x_{\alpha}}(r_{\alpha,\delta})$.

Proof of Step [3.2.](#page-6-0) Let $w_{1,\alpha}$ be given by

First, we give precise asymptotic expansions of $\Delta w_{1,\alpha}$ in $B_{x_\alpha}(\rho_{1,\alpha})$, as $\alpha \to \lambda_1^-$. \n(3.30)

in $B_{x_\alpha}(r_{\alpha,\delta})$. Since $B_{\alpha} > 0$ in $B_{x_\alpha}(\rho_{1,\alpha})$, we get from [\(3.10\)](#page-4-8) that $B_{\alpha} \leq \gamma_{\alpha}$ in this ball. Then [\(3.30\)](#page-6-1) implies

in $B_{x_\alpha}(\rho_{1,\alpha})$. Since $t_\alpha = O(\gamma_\alpha^2)$ in $B_{x_\alpha}(r_{\alpha,\delta})$, applying the useful inequality

= 1 + \frac{t_{\alpha}^{2} + 2w_{1,\alpha}}{\gamma_{\alpha}^{2}} + O\left(\frac{(1 + t_{\alpha}^{4}) \exp(t_{\alpha}^{2}/\gamma_{\alpha}^{2})}{\gamma_{\alpha}^{4}}\right)
$$
\n(3.34)

in $B_{x_\alpha}(\rho_{1,\alpha})$. Then, using [\(3.5\)](#page-4-2), [\(3.32\)](#page-6-5), [\(3.33\)](#page-6-6), [\(3.34\)](#page-7-0), we get that

\Lambda_{\alpha} B_{\alpha} \exp(B_{\alpha}^{2})

$$
= \frac{4 \exp(-2t_{\alpha})}{\mu_{\alpha}^{2} \gamma_{\alpha}} \left[1 + \frac{2w_{1,\alpha} + t_{\alpha}^{2} - t_{\alpha}}{\gamma_{\alpha}^{2}} + O\left(\frac{(1 + t_{\alpha}^{4}) \exp(t_{\alpha}^{2}/\gamma_{\alpha}^{2})}{\gamma_{\alpha}^{4}}\right) \right]
$$
\n(3.35)

in $B_{x_\alpha}(\rho_{1,\alpha})$. Now, by [\(3.7\)](#page-4-9), [\(3.10\)](#page-4-8), [\(3.31\)](#page-6-7), and [\(3.35\)](#page-7-1), we get that

Next, we estimate the growth of the function $w_{1,\alpha} - S_{\alpha}$. In the sequel, restricting to $B_{x_\alpha}(r_{\alpha,\delta})$ gives that $2-\frac{t_\alpha}{\gamma_\alpha^2} \geq 2-\delta > 1$ and then, a sufficiently good decay of the error term $(1+t_{\alpha}^4) \exp(t_{\alpha}(-2+(t_{\alpha}/\gamma_{\alpha}^2)))$. for all $0\leq r\leq \rho_{1,\alpha}$ and all $0<\lambda_1-\alpha\ll 1.$ Now we prove that

\mu_{\alpha} \|(w_{1,\alpha} - S_{\alpha})'\|_{L^{\infty}([0,\rho_{1,\alpha}])} = O\left(\frac{1}{\gamma_{\alpha}^2}\right).

Otherwise, we assume by contradiction that

in $B_{x_\alpha}(r_\alpha)$, using also [\(3.13\)](#page-4-0), [\(3.16\)](#page-4-4), [\(3.25\)](#page-6-2) and [\(3.27\)](#page-6-8) to get $\exp(B_\alpha^2) \gg \lambda_1$. Summarizing, the v_{α} 's satisfy [\(3.1\)](#page-3-8) and [\(3.53\)](#page-9-1), and the B_{α} 's satisfy [\(3.27\)](#page-6-8) in $B_{x_{\alpha}}(r_{\alpha,\delta})$, while [\(3.25\)](#page-6-2) holds true. Moreover, the w_{α} 's satisfy [\(3.56\)](#page-9-3) in $B_{x_{\alpha}}(r_{\alpha})$. Then, argu-ing exactly as in [\[8,](#page-15-3) Section 3] dealing with the case $A_{\alpha} = 0$, we get the following result.

in $B_{x_\alpha}(r_{\alpha,\delta})$. Since $\delta < 1$, we can argue as in [\(3.37\)](#page-7-3) to estimate the exponential in the error term. Specifically, we can find $\kappa > 1$ such that

in $B_{x_\alpha}(r_{\alpha,\delta}).$

Now we focus on the behavior of the v_{α} 's in $\Omega \backslash B_{x_{\alpha}}(r_{\alpha,\delta})$. Assume that $0 < \delta' <$ δ < 1. We let \tilde{v}_{α} be given by

for $0 < \lambda_1 - \alpha \ll 1$, since $r_{\alpha,\delta}/\mu_\alpha \to +\infty$ and using [\(3.5\)](#page-4-2) and [\(3.6\)](#page-4-3). Since $R > 0$ is arbitrary, we obtain

for all α . Putting together [\(3.69\)](#page-11-6), [\(3.70\)](#page-11-4), [\(3.77\)](#page-12-5) and [\(3.78\)](#page-12-6), we have obtained that there exists $C, \overline{C} > 0$ such that

Note that the term of order γ_{α}^{-2} in [\(3.97\)](#page-14-2) vanishes since, by [\(3.24\)](#page-5-6) and [\(3.25\)](#page-6-2), we get

$$
A_0 = \int_{\mathbb{R}^2} \Delta S_0 dz = \int_{\mathbb{R}^2} 4 \exp(-2T_0) T_0 dz.
$$

Then [\(3.14\)](#page-4-6) and [\(3.97\)](#page-14-2) imply

$$
\Lambda_{\alpha} \int_{B_{x_{\alpha}}(r_{\alpha,\delta})} v_{\alpha}^{2} \exp(v_{\alpha}^{2}) dy = 4\pi + O\left(\frac{1}{\gamma_{\alpha}^{4}}\right). \tag{3.98}
$$

Independently, we compute

$$
\int_{B_{x_{\alpha}}(r_{\alpha,\delta})^c} v_{\alpha}^2 \exp(v_{\alpha}^2) dy
$$
\n
$$
= O\left(\int_{B_{x_{\alpha}}(r_{\alpha,\delta})^c} \left(\|v_{\alpha}\|_{p}^2 + \frac{1}{\gamma_{\alpha}^2} \left(\log \frac{C}{|x_{\alpha} - y|}\right)^2\right) \times \exp\left(\left[\frac{1 + o(1)}{\gamma_{\alpha}} \log \frac{1}{|x_{\alpha} - y|^2} + o(1)\right]^2\right) dy\right),
$$
\n
$$
= O\left(\|v_{\alpha}\|_{p}^2 + \frac{1}{\gamma_{\alpha}^2}\right).
$$
\n(3.99)

arguing as in (3.92) , using (3.64) , (3.68) , (3.93) and the dominated convergence theorem. At last, we easily get from [\(3.68\)](#page-11-9) and [\(3.80\)](#page-12-7) that

$$
\int_{\Omega} v_{\alpha}^{2} dy = ||v_{\alpha}||_{p}^{2} \int_{\Omega} v^{2} dy + o(||v_{\alpha}||_{p}^{2}).
$$
\n(3.100)

Then, we conclude from $(3.98)-(3.100)$ $(3.98)-(3.100)$ with (3.4) and (3.80) that (3.96) holds true, which concludes the proof of Proposition [3.1.](#page-3-2) \Box
