# A NOTE ON COMMUTATOR IN THE MULTILINEAR SETTING

#### Abstract

Let $m \in \mathbb{N}$ and $\vec{b}=\left(b_{1}, \cdots, b_{m}\right)$ be a collection of locally integrable functions. It is proved that $b_{1}, b_{2}, \cdots, b_{m} \in B M O$ if and only if $$
\sup _{Q} \frac{1}{|Q|^{m}} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-\left(b_{i}\right)_{Q}\right)\right| d \vec{x}<\infty
$$ where $\left(b_{i}\right)_{Q}=\frac{1}{|Q|} \int_{Q} b_{i}(x) d x$. As an application, we show that if the linear commutator of certain multilinear Calderón-Zygmund operator [ $\Sigma \vec{b}, T$ ] is bounded from $L^{p_{1}} \times \cdots \times L^{p_{m}}$ to $L^{p}$ with $\sum_{i=1}^{m} 1 / p_{i}=1 / p$ and $1<p, p_{1}, \cdots, p_{m}<\infty$, then $b_{1}, \cdots, b_{m} \in B M O$. Therefore, the result of Chaffee [2] (or Li and Wick [11]) is extended to the general case.


## 1. Introduction

In this paper we resolve a problem that has been open for a while in the multilinear Calderón-Zygmund theory. Namely, whether the boundedness of the linear commutator of multilinear Calderón-Zygmund operator can be used to characterize the BMO space.

We briefly summarize some classical and recent works in the literature, which lead to the results presented here. The space $B M O$ of functions with bounded mean oscillation was introduced by John and Nirenberg in [8] and plays a crucial role in harmonic analysis and partial differential equations; see for example, [5, 13]. There are a number of classical results that demonstrate $B M O$ functions are the right collections to do harmonic analysis on the boundedness of commutators. A well-known result of Coifman, Rochberg and Weiss [4] states that the commutator

$$
[b, T](f)=b T(f)-T(b f)
$$

is bounded on some $L^{p}, 1<p<\infty$, if and only if $b \in B M O$, where $T$ is the Riesz transform. Janson extended the result in [7] via the commutators of certain CalderónZygmund operators with smooth homogeneous kernels. The theory was then extended and

[^0]generalized to several directions. For instance, Bloom [1] investigated the same result in the weighted setting; Uchiyama [14] extended the boundednss results on the commutator to compactness; Krantz and Li in [9] and [10] have applied commutator theory to give a compactness characterization of Hankel operators on holomorphic Hardy spaces $H^{2}(D)$, where $D$ is a bounded, strictly pseudoconvex domain in $\mathbb{C}^{n}$. It is perhaps for this important reason that the boundedness of $[b, T]$ attracted ones attention among researchers in PDEs

Many authors are interested in multilinear operators, which is a natural generalization of linear case. Multilinear Calderón-Zygmund operators were introduced by Coifman and Meyer [3] but were not systematically studied for about a quarter century until the appearance of [6]. In 2003, Pérez and Torres in [12] defined the $m$-linear commutator of $\vec{b}=\left(b_{1}, \cdots, b_{m}\right)$ and the $m$-linear Calderón-Zygmund operator $T$ to be

$$
[\Sigma \vec{b}, T](\vec{f})=\sum_{i=1}^{m}\left[b_{i}, T\right]_{i}(\vec{f})
$$

where each term is the commutator of $b_{i}$ and $T$ in the $j$ th entry of $T$, that is,

$$
\left[b_{i}, T\right]_{i}(\vec{f})(x)=b_{i} T\left(f_{1}, \cdots, f_{i}, \cdots, f_{m}\right)-T\left(f_{1}, \cdots, b_{i} f_{i}, \cdots, f_{m}\right)
$$

This definition coincides with the linear commutator $[b, T]$ when $m=1$. They proved that if $1<p, p_{1}, \cdots, p_{m}<\infty$ and $1 / p=1 / p_{1}+\cdots+1 / p_{m}$, then

$$
b_{1}, \cdots, b_{m} \in B M O \Longrightarrow[\Sigma \vec{b}, T]: L^{p_{1}} \times \cdots \times L^{p_{m}} \rightarrow L^{p}
$$

It was recently obtained by Chaffee [2] that if $1<p, p_{1}, \cdots, p_{m}<\infty$ and $1 / p=1 / p_{1}+\cdots+$ $1 / p_{m}$, then

$$
\left[b_{i}, T\right]_{i}: L^{p_{1}} \times \cdots \times L^{p_{m}} \rightarrow L^{p} \Longrightarrow b_{i} \in B M O
$$

is bounded from $L^{p_{1}} \times \cdots \times L^{p_{m}}$ to $L^{p}$, then $b_{i} \in B M O$. It was then also revisited by Li and Wick [11] using different techniques. In both cases the results are also consider only one term $\left[b_{i}, T\right]_{i}$. In this paper, we will extend the result of Chaffee [2] (or Li and Wick [11]) to the general case, that is,

$$
[\Sigma \vec{b}, T]: L^{p_{1}} \times \cdots L^{p_{m}} \rightarrow L^{p} \Longrightarrow b_{1}, \cdots, b_{m} \in B M O
$$

We now recall that the definition of $m$-linear Calderón-Zygmund operators. In order to define $m$-linear Calderón-Zygmund operators, we first define the class of Calderón-Zygmund kernels. Let $K\left(x, y_{1}, \cdots, y_{m}\right)$ be a locally integrable integrable function defined away from the diagonal $x=y_{1}=\cdots=y_{m}$. If for some parameters $A$ and $\epsilon$, both positive, we have

$$
\left|K\left(y_{0}, y_{1}, \cdots, y_{m}\right)\right| \leq \frac{A}{\left(\sum_{k, l=0}^{m}\left|y_{k}-y_{l}\right|\right)^{m n}}
$$

and

$$
\left|K\left(y_{0}, \cdots, y_{j}, \cdots, y_{m}\right)-K\left(y_{0}, \cdots, y_{j}^{\prime}, \cdots, y_{m}\right)\right| \leq \frac{A}{\left(\sum_{k, l=0}^{m}\left|y_{k}-y_{l}\right|\right)^{m n+\epsilon}}
$$

whenever $0 \leq j \leq m$ and $\left|y_{j}-y_{j}^{\prime}\right| \leq \frac{1}{2} \max _{0 \leq k \leq m}\left|y_{j}-y_{k}\right|$, then we say $K$ is an $m$-linear Calderón-Zygmund kernel. Then for some $m$-linear $T$ defined by

$$
T\left(f_{1}, \cdots, f_{m}\right)(x)=\int_{\left(\mathbb{R}^{n}\right)^{m}} K\left(x, y_{1}, \cdots, y_{m}\right) f_{1}\left(y_{1}\right) \cdots f_{m}\left(y_{m}\right) d \vec{y}
$$

where $K$ is a Calderón-Zygmund kernel. If

$$
T: L^{p_{1}} \times \times L^{p_{m}} \rightarrow L^{p},
$$

for some $1<p_{1}, \cdots, p_{m}<\infty$ satisfying $1 / p=\sum_{i=1}^{m} 1 / p_{i}$, we say $T$ is an $m$-linear CalderónZygmund operator. Many basic properties of these operators were studied by Grafakos and Torres in [6]. In addition, we say that an operator is of homogeneous operator if the kernel $K\left(x, y_{1}, \cdots, y_{m}\right)$ is actually of the form $K\left(x-y_{1}, \cdots, x-y_{m}\right)$.

Theorem 1.1. Let $m \in \mathbb{N}$ and $1<p, p_{1}, \cdots, p_{m}<\infty$ with $1 / p=\sum_{i=1}^{m} 1 / p_{i}$. For a bilinear operator $T$ defined on $L^{p_{1}} \times \cdots \times L^{p_{m}}$ which can be represented as

$$
T\left(f_{1}, \cdots, f_{m}\right)(x)=\int_{\left(\mathbb{R}^{n}\right)^{m}} K\left(x-y_{1}, \cdots, x-y_{m}\right) f_{1}\left(y_{1}\right) \cdots f_{m}\left(y_{m}\right) d \vec{y}
$$

for all $x \notin \cap_{i=1}^{m} \operatorname{supp} f_{i}$, where $K$ is a homogeneous kernel such that on some ball $B \subset \mathbb{R}^{m n}$, we have that the Fourier series of $1 / K$ is absolutely convergent. We then have that

$$
[\Sigma \vec{b}, T]: L^{p_{1}} \times \cdots L^{p_{m}} \rightarrow L^{p} \Longrightarrow b_{1}, \cdots, b_{m} \in B M O
$$

Remark 1.1. As in Corollary 2 in [6], they listed a specific multilinear Calderón-Zygmund kernel of the form

$$
K\left(x_{1}, \cdots, x_{m}\right)=\frac{\Omega\left(\frac{\left(x_{1}, \cdots, x_{m}\right)}{\left|\left(x_{1}, \cdots, x_{m}\right)\right|}\right)}{\left|\left(x_{1}, \cdots, x_{m}\right)\right|^{m n}}
$$

where $\Omega$ is an integrable function with mean value zero on the sphere $\mathbb{S}^{m n-1}$. The multilinear Riesz transforms are special examples of this form.

Remark 1.2. In [12], Pérez and Torres showed that $b_{1}, \cdots, b_{m} \in B M O$ was sufficient to show the boundedness of commutators with m-linear Calderón-Zygmund operator. Combined with Theorem 1.1, this immediately gives us that $b_{1}, \cdots, b_{m} \in B M O$ are necessary and sufficient conditions for the boundedness of commutators with certain multilinear CalderónZygmund operator.

Remark 1.3. It will be difficult to discuss the similar problem for the case of $p<1$ in the target space. Since our proof required the use of Hölder's inequality with $p$ and $p^{\prime}$. For this reason the case $p>1$ and $p<1$ have been occasionally treated separately in the literatures and by different arguments. The results of Chaffee [2] and Li and Wick [11] are also under the assumption $p>1$. Finally, in [15], we extend this results to $p<1$. Unfortunately, some of the techniques employed in the study of $\left[b_{i}, T\right]_{i}$ in [15] can not apply to $[\vec{b}, T]$.

Throughout this paper, the letter $C$ denotes constants which are independent of main variables and may change from one occurrence to another. $Q(x, r)$ denotes a cube centered at $x$, with side length $r$, sides parallel to the axes.

## 2. Proof of Theorem 1.1

To obtain the desired result, we need the following lemma.
Lemma 2.1. Let $m \in \mathbb{N}$ and $\vec{b}=\left(b_{1}, \cdots, b_{m}\right)$ be a collection of locally integrable functions. The following statements are equivalent:
(a) There exists a constant $C_{a}$ such that

$$
[\vec{b}]_{*}:=\sup _{Q} \frac{1}{|Q|^{m+1}} \int_{Q} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}(x)-b_{i}\left(y_{i}\right)\right)\right| d \vec{y} d x \leq C_{a} .
$$

(b) There exists a constant $C_{b}$ such that

$$
[\vec{b}]_{* *}:=\sup _{Q} \frac{1}{|Q|^{m}} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-\left(b_{i}\right)_{Q}\right)\right| d \vec{x} \leq C_{b} .
$$

(c) There exists a constant $C_{c}$ such that

$$
[\vec{b}]_{* * *}:=\sup _{Q} \frac{1}{|Q|^{2 m}} \int_{Q^{m}} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right)\right| d \vec{y} d \vec{x} \leq C_{c} .
$$

(d) $b_{1}, \cdots, b_{m} \in B M O$.

Proof. It is a simple observation that $(a) \Rightarrow(b)$ and $(b) \Rightarrow(c)$ are obvious, we need only give the proofs of $(c) \Rightarrow(d)$ and $(d) \Rightarrow(a)$.
$(c) \Rightarrow(d)$. We first give the proof of the following inequality. Let

$$
\Omega_{m}=\left\{\vec{\sigma}_{m}=\left(\sigma_{1}, \cdots, \sigma_{m}\right): \sigma_{i} \in\{-1,1\}, i=1, \cdots, m\right\} .
$$

For any $a_{i} \in \mathbb{R}^{n}$, we then have the following.

$$
\begin{equation*}
\sum_{i=1}^{m}\left|a_{i}\right| \leq \sum_{\vec{\sigma}_{m} \in \Omega_{m}}\left|\sum_{i=1}^{m} \sigma_{i} a_{i}\right| . \tag{2.1}
\end{equation*}
$$

For $k=2$, from the fact that $\left|a_{1}\right|,\left|a_{2}\right| \leq\left|a_{1}-a_{2}\right|+\left|a_{1}+a_{2}\right|$, we have

$$
\sum_{i=1}^{2}\left|a_{i}\right| \leq \sum_{\vec{\sigma}_{2} \in \Omega_{2}}\left|\sum_{i=1}^{2} \sigma_{i} a_{i}\right|
$$

We assume that the inequality (2.1) holds for $m=k \geq 2$. That is,

$$
\sum_{i=1}^{k}\left|a_{i}\right| \leq \sum_{\vec{\sigma}_{k} \in \Omega_{k}}\left|\sum_{i=1}^{k} \sigma_{i} a_{i}\right|
$$

then for $m=k+1$,

$$
\begin{aligned}
\sum_{i=1}^{k+1}\left|a_{i}\right| & =\sum_{i=1}^{k}\left|a_{i}\right|+\left|a_{k+1}\right| \\
& \leq \sum_{\vec{\sigma}_{k} \in \Omega_{k}}\left|\sum_{i=1}^{k} \sigma_{i} a_{i}\right|+\left|a_{k+1}\right| \\
& \leq \sum_{\vec{\sigma}_{k} \in \Omega_{k}}\left(\left|\sum_{i=1}^{k} \sigma_{i} a_{i}\right|+\left|a_{k+1}\right|\right) \\
& \leq \sum_{\vec{\sigma}_{k} \in \Omega_{k}} \sum_{k+1}\left|\sum_{i=1}^{k} \sigma_{i} a_{i}+\sigma_{k+1} a_{k+1}\right| \\
& \leq \sum_{\vec{\sigma}_{k+1} \in \Omega_{k+1}}\left|\sum_{i=1}^{k+1} \sigma_{i} a_{i}\right| .
\end{aligned}
$$

Then we prove the inequality (2.1).
Applying the inequality (2.1), we obtain that for any cube $Q$,

$$
\begin{aligned}
& \frac{1}{|Q|^{2 m}} \int_{Q^{2 m}} \sum_{i=1}^{m}\left|b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right| d \vec{x} d \vec{y} \\
& \leq \sum_{\vec{\sigma}_{k+1} \in \Omega_{k+1}} \frac{1}{|Q|^{2 m}} \int_{Q^{2 m}}\left|\sum_{i=1}^{m} \sigma_{i}\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right)\right| d \vec{x} d \vec{y} \\
& \leq \sum_{\vec{\sigma}_{k+1} \in \Omega_{k+1}}[\vec{b}]_{* * *} \\
& \leq C[\vec{b}]_{* * *} .
\end{aligned}
$$

Which yields that for $i=1, \cdots, m$,

$$
\frac{1}{|Q|} \int_{Q}\left|b_{i}\left(x_{i}\right)-\left(b_{i}\right)_{Q}\right| d x_{i} \leq \frac{1}{|Q|^{2}} \int_{Q^{2}}\left|b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right| d x_{i} d y_{i} \leq C[\vec{b}]_{* * *} .
$$

Then $b_{1}, \cdots, b_{m} \in B M O$.
$(d) \Rightarrow(a)$. For any cube $Q$, we conclude that

$$
\begin{aligned}
& \frac{1}{|Q|^{m+1}} \int_{Q} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}(x)-b_{i}\left(y_{i}\right)\right)\right| d \vec{y} d x \\
& \leq \sum_{i=1}^{m} \frac{1}{|Q|^{2}} \int_{Q^{2}}\left|b_{i}(x)-b_{i}\left(y_{i}\right)\right| d y_{i} d x \\
& \leq \sum_{i=1}^{m}\left(\frac{1}{|Q|} \int_{Q}\left|b_{i}(x)-\left(b_{i}\right)_{Q}\right| d x+\frac{1}{|Q|} \int_{Q}\left|b_{i}\left(y_{i}\right)-\left(b_{i}\right)_{Q}\right| d y_{i}\right) \\
& \leq C \sum_{i=1}^{m}\left\|b_{i}\right\|_{B M O} .
\end{aligned}
$$

Thus, we complete the proof of Lemma 2.1.

Proof of Theorem 1.1. Let $z_{0} \in \mathbb{R}^{n}$ such that $\left|z_{0}\right|>m \sqrt{n}$ and let $\delta \in(0,1)$ small enough. Take $\mathcal{B}=B\left(\left(z_{0}, 0, \cdots, 0\right), \delta \sqrt{m n}\right) \subset \mathbb{R}^{m n}$ be the ball for which we can express $\frac{1}{K}$ as an absolutely convergent Fourier series of the form

$$
\frac{1}{K\left(y_{1}, \cdots, y_{m}\right)}=\sum_{k} a_{k} e^{i v_{k} \cdot\left(y_{1}, \cdots, y_{m}\right)}, \quad\left(y_{1}, \cdots, y_{m}\right) \in \mathcal{B}
$$

with $\sum_{k}\left|a_{k}\right|<\infty$ and we do not care about the vectors $v_{k} \in \mathbb{R}^{m n}$, but we will at times express them as $v_{k}=\left(v_{k}^{1}, \cdots, v_{k}^{m}\right)$.

Set $z_{1}=\delta^{-1} z_{0}$ and note that

$$
\left(\left|y_{1}-z_{1}\right|^{2}+\left|y_{2}\right|^{2}+\cdots+\left|y_{m}\right|^{2}\right)^{1 / 2}<\sqrt{m n} \Rightarrow\left(\left|\delta y_{1}-z_{0}\right|^{2}+\left|\delta y_{1}\right|^{2}+\cdots+\left|\delta y_{m}\right|^{2}\right)^{1 / 2}<\delta \sqrt{m n}
$$

Then for any $\left(y_{1}, \cdots, y_{m}\right)$ satisfying the inequality on the left, we have

$$
\begin{equation*}
\frac{1}{K\left(y_{1}, \cdots, y_{m}\right)}=\frac{\delta^{-m n}}{K\left(\delta y_{1}, \cdots, \delta y_{m}\right)}=\delta^{-m n} \sum_{k} a_{k} e^{i \delta v_{k} \cdot\left(y_{1}, \cdots, y_{m}\right)} \tag{2.2}
\end{equation*}
$$

Let $Q=Q\left(x_{0}, r\right)$ be any arbitrary cube in $\mathbb{R}^{n}$. Set $\tilde{z}=x_{0}+r z_{1}$ and take $Q^{\prime}=Q(\tilde{z}, r) \subset \mathbb{R}^{n}$. So for any $x \in Q$ and $y_{1}, \cdots, y_{m} \in Q^{\prime}$, we obtain that for any $i, j \in\{1,2, \cdots, m\}$ with $i \neq j$,

$$
\left|\frac{x-y_{i}}{r}-z_{1}\right| \leq\left|\frac{y_{i}-\tilde{z}}{r}\right|+\left|\frac{x-x_{0}}{r}\right| \leq \sqrt{n}
$$

and

$$
\left|\frac{y_{i}-y_{j}}{r}\right| \leq \sqrt{n}
$$

It follows that

$$
\left(\left|\frac{x-y_{i}}{r}-z_{1}\right|^{2}+\sum_{j \neq i}\left|\frac{y_{j}-y_{i}}{r}\right|^{2}\right)^{1 / 2} \leq \sqrt{m n}
$$

We conclude that

$$
\frac{1}{K\left(\frac{y_{i}-x_{i}}{r}, \frac{y_{i}-y_{1}}{r}, \cdots, \frac{y_{i}-y_{i-1}}{r}, \frac{y_{i}-y_{i+1}}{r}, \cdots, \frac{y_{i}-y_{m}}{r}\right)}
$$

can be expressed as an absolutely convergent Fourier series as (2.2) for all $x \in Q$ and $y_{1}, \cdots, y_{m} \in Q^{\prime}$.

On the other hand, observe that

$$
\sum_{i=1}^{m} \sum_{j \neq i}\left(b_{j}\left(y_{j}\right)-b_{i}\left(y_{i}\right)\right)=0
$$

it follows that

$$
\begin{aligned}
\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right) & =\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right)+\sum_{i=1}^{m} \sum_{j \neq i}\left(b_{j}\left(y_{j}\right)-b_{i}\left(y_{i}\right)\right) \\
& =\sum_{i=1}^{m}\left(\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right)+\sum_{j \neq i}\left(b_{j}\left(y_{j}\right)-b_{i}\left(y_{i}\right)\right)\right)
\end{aligned}
$$

Which shows that

$$
\begin{aligned}
& \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-\left(b_{i}\right)_{Q^{\prime}}\right)\right| d \vec{x} \\
& =\frac{1}{|Q|^{m}} \int_{Q^{m}}\left|\int_{\left(Q^{\prime}\right)^{m}} \sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right) d \vec{y}\right| d \vec{x} \\
& =\frac{1}{|Q|^{m}} \int_{Q^{m}}\left|\int_{\left(Q^{\prime}\right)^{m}} \sum_{i=1}^{m}\left(\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right)+\sum_{j \neq i}\left(b_{j}\left(y_{j}\right)-b_{i}\left(y_{i}\right)\right)\right) d \vec{y}\right| d \vec{x} \\
& \leq \sum_{i=1}^{m} \frac{1}{|Q|} \int_{Q}\left|\int_{\left(Q^{\prime}\right)^{m}}\left(\left(b_{i}\left(x_{i}\right)-b_{i}\left(y_{i}\right)\right)+\sum_{j \neq i}\left(b_{j}\left(y_{j}\right)-b_{i}\left(y_{i}\right)\right)\right) d \vec{y}\right| d x_{i} \\
& =\sum_{i=1}^{m} \frac{1}{|Q|} \int_{Q} \int_{\left(Q^{\prime}\right)^{m}}\left(\left(b_{i}\left(y_{i}\right)-b_{i}\left(x_{i}\right)\right)+\sum_{j \neq i}\left(b_{i}\left(y_{i}\right)-b_{j}\left(y_{j}\right)\right)\right) d \vec{y} \cdot s_{i}\left(x_{i}\right) d x_{i},
\end{aligned}
$$

where

$$
s_{i}\left(x_{i}\right)=\operatorname{sgn}\left(\int_{\left(Q^{\prime}\right)^{m}}\left(\left(b_{i}\left(y_{i}\right)-b_{i}\left(x_{i}\right)\right)+\sum_{j \neq i}\left(b_{i}\left(y_{i}\right)-b_{j}\left(y_{j}\right)\right)\right) d \vec{y}\right) .
$$

For any $i \in\{1,2, \cdots, m\}$, we write

$$
f_{1}^{i, k}\left(x_{i}\right)=e^{-i \frac{\delta}{r} \nu_{k}^{1} \cdot x_{i}} s_{i}\left(x_{i}\right) \chi_{Q}\left(x_{i}\right),
$$

f_{2}^{i, k}\left(y_{1}\right)=e^{-i \frac{\delta}{r} \nu_{k}^{2} \cdot y_{1}} \chi_{Q^{\prime}}\left(y_{1}\right), \\
\vdots \\

f_{i+1}^{i, k}\left(y_{i+1}\right)=e^{-i \frac{\delta}{r} \nu_{k}^{2} \cdot y_{i+1}} \chi_{Q^{\prime}}\left(y_{i+1}\right), \\
\vdots \\
f_{m}^{i, k}\left(y_{m}\right)=e^{-i \frac{\delta}{r} \nu_{k}^{m} \cdot y_{m}} \chi_{Q^{\prime}}\left(y_{m}\right)
\end{gathered}

& \quad \times K\left(y_{i}-x_{i}, y_{i}-y_{1}, \cdots, y_{i}-y_{i-1}, y_{i}-y_{i+1}, \cdots, y_{i}-y_{m}\right) \\

& \leq \sum_{i=1}^{m} \sum_{k}\left|a_{k}\right| \delta^{-m n}|Q|^{m-1} \int_{\mathbb{R}^{n}}\left|[\Sigma \vec{b}, T]\left(f_{1}^{i, k}, \cdots, f_{m}^{i, k}\right)\left(y_{i}\right)\right|\left|g^{i, k}\left(y_{i}\right)\right| d y_{i} \\
& \leq \sum_{i=1}^{m} \sum_{k}\left|a_{k}\right| \frac{|Q|^{m} \delta^{-m n}}{|Q|^{1 / p}}\left\|[\Sigma \vec{b}, T]\left(f_{1}^{i, k}, \cdots, f_{m}^{i, k}\right)\right\|_{L^{p}} \\
& \leq C|Q|^{m}\|[\Sigma \vec{b}, T]\|_{L^{p_{1} \times \cdots \times L^{p m} \rightarrow L^{p}}} \sum_{k}\left|a_{k}\right| .

Which implies that

\frac{1}{|Q|^{m}} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-\left(b_{i}\right)_{Q}\right)\right| d \vec{x} & \leq \frac{C}{|Q|^{m}} \int_{Q^{m}}\left|\sum_{i=1}^{m}\left(b_{i}\left(x_{i}\right)-\left(b_{i}\right)_{Q^{\prime}}\right)\right| d \vec{x} \\
& \leq C\|[\Sigma \vec{b}, T]\|_{L^{p_{1} \times \cdots \times L^{p_{m}} \rightarrow L^{p}}} \sum_{k}\left|a_{k}\right|
\end{aligned}
$$

By lemma [2.1, we get $b_{1}, \cdots, b_{m} \in B M O$.
