Existence, uniqueness and homogenization of nonlinear parabolic problems with dynamical boundary conditions in perforated media

Abstract

We consider a nonlinear parabolic problem with dynamical boundary conditions in a media perforated by periodically distributed holes of size ε . The existence and uniqueness of solution is analyzed. Moreover, passing to the limit when ε goes to zero, a new nonlinear parabolic problem defined on a unified domain without holes with zero Dirichlet boundary condition and with extraterms coming from the influence of the dynamical boundary conditions is rigorously derived.

1 Introduction and setting of the problem

Partial differential equations with dynamic boundary conditions have the main characteristic of involving the time derivative of the unknown on the boundary of the domain. Its use dates back at least to 1901 in the context of heat transfer in a solid in contact with a moving fluid. From the second half of the 20th century until today, they have been studied in many disciplines.

Several approaches have been used for these problems in a periodically perforated domain, like the theory of Homogenization. For a linear model, the asymptotic behavior of the solution, when the size of the perforations tends to zero, is studied in Timofte [\[10\]](#page-19-0). But to our knowledge, there does not seem to be in the literature any study of the asymptotic behavior of the solution of nonlinear models associated to this kind of problems (up to the stochastic framework, see Wang and Duan [\[12\]](#page-19-1)).

Let us introduce the model we will be involved with in this paper. Let Ω be a bounded connected open set in \mathbb{R}^N ($N \geq 2$), with smooth enough boundary $\partial \Omega$. Let $Y = [0, 1]^N$ be the representative cell in \mathbb{R}^N and F an open subset of Y with smooth enough boundary ∂F , such that $\overline{F} \subset Y$. We denote $Y^* = Y \setminus \bar{F}.$

For $k \in \mathbb{Z}^N$, each cell $Y_{k,\varepsilon} = \varepsilon k + \varepsilon Y$ is similar to the unit cell Y rescaled to size ε and $F_{k,\varepsilon} = \varepsilon k + \varepsilon F$ is similar to F rescaled to size ε . We denote $Y_{k,\varepsilon}^* = Y_{k,\varepsilon} \setminus \overline{F}_{k,\varepsilon}$. We denote by F_{ε} the set of all the holes contained in Ω , i.e. $F_{\varepsilon} = \cup_{k \in K} \{ F_{k,\varepsilon} : \overline{F}_{k,\varepsilon} \subset \Omega \}$, where $K := \{ k \in \mathbb{Z}^N : Y_{k,\varepsilon} \cap \Omega \neq \varnothing \}$.

Let $\Omega_{\varepsilon} = \Omega \backslash \bar{F}_{\varepsilon}$. By this construction, Ω_{ε} is a periodically perforated domain with holes of the same size as the period. Let us suppose that the holes do not intersect the boundary $\partial\Omega$.

We consider the following problem for a nonlinear reaction-diffusion equation with dynamical boundary conditions on the surface of the holes and zero Dirichlet condition on the exterior boundary,

where \vec{n} is the outer normal to ∂F_{ε} , $T > 0$, and

We also assume that the functions f and $g \in C(\mathbb{R})$ are given, and satisfy that there exist exponents p and q such that 0.37

It is easy to see from (1.6) and (1.7) that there exists a constant $C > 0$ such that

In this paper, our main motivation is to study the asymptotic behavior, as $\varepsilon \to 0$, of the solution u_{ε} of [\(1.1\)](#page-1-1). As we mentioned before, we only have references in the literature of this approach in the stochastic context. In that sense, a particularly interesting situation is treated in Wang and Duan [\[12\]](#page-19-1) with the help of the two-scale convergence. There, the authors obtain the asymptotic behavior of the solution of a stochastic partial differential equation with dynamical boundary conditions, under the restrictive assumption $g(s) = s$, i.e. the nonlinearity does not appear in the boundary. However, we will obtain the asymptotic behavior of the solution of [\(1.1\)](#page-1-1) where the nonlinearity also appears in the boundary. We use the energy method of Tartar [\[9\]](#page-19-2), which has been considered by many authors (see, for instance, Cioranescu and Donato [\[1\]](#page-19-3)) and the technique introduced by Vanninathan [\[11\]](#page-19-4) for the Steklov problem which transforms surface integrals into volume integrals. This technique was already used as a main tool to homogenize the non homogeneous Neumann problem for the elliptic case by Cioranescu and Donato [\[1\]](#page-19-3).

In this sense, when $\varepsilon \to 0$, we have got a new nonlinear reaction-diffusion equation with constant coefficient defined on $\Omega \times (0,T)$, with zero Dirichlet boundary condition on the boundary, and with a constant extra-term in front of the derivative which comes from the well-balanced contribution of the dynamical part of the boundary condition on the surface of the holes.

The structure of the paper is as follows. In Section [2,](#page-2-1) we give some notations which are used in the paper. In Section [3,](#page-4-0) we give a weak formulation of the problem, the concept of weak solution, and establish the existence and uniqueness of solution using the monotonicity method. Some a priori estimates are rigorously stablished in Section [4.](#page-6-0) A compactness result, which is the main key when we will pass to the limit later, is addressed in Section [5.](#page-12-0) In Section [6,](#page-14-0) the main goal of proving the asymptotic behavior of the solution is finally established in Theorem [6.1.](#page-14-1)

2 Some notations

In this section, we give some notations which are used in the paper.

We denote by $\chi_{\Omega_{\varepsilon}}$ the characteristic function of the domain Ω_{ε} .

We denote by $(\cdot, \cdot)_{\Omega_{\varepsilon}}$ (respectively, $(\cdot, \cdot)_{\partial F_{\varepsilon}}$) the inner product in $L^2(\Omega_{\varepsilon})$ (respectively, in $L^2(\partial F_{\varepsilon})$), and by $\lvert \cdot \rvert_{\Omega_{\varepsilon}}$ (respectively, $\lvert \cdot \rvert_{\partial F_{\varepsilon}}$) the associated norm. We also denote $(\cdot, \cdot)_{\Omega_{\varepsilon}}$ the inner product in $(L^2(\Omega_{\varepsilon}))^N$.

If $r \neq 2$, we will also denote $(\cdot, \cdot)_{\Omega_{\varepsilon}}$ (respectively, $(\cdot, \cdot)_{\partial F_{\varepsilon}}$) the duality product between $L^{r'}(\Omega_{\varepsilon})$ and $L^r(\Omega_{\varepsilon})$ (respectively, the duality product between $L^{r'}(\partial F_{\varepsilon})$ and $L^r(\partial F_{\varepsilon})$). We will denote $|\cdot|_{r,\Omega_{\varepsilon}}$ (respectively $|\cdot|_{r,\partial F_{\varepsilon}}$) the norm in $L^r(\Omega_{\varepsilon})$ (respectively in $L^r(\partial F_{\varepsilon})$).

By $\|\cdot\|_{\Omega_{\varepsilon}}$ we denote the norm in $H^1(\Omega_{\varepsilon})$, which is associated to the inner product $((\cdot,\cdot))_{\Omega_{\varepsilon}}:=$ $(\nabla \cdot, \nabla \cdot)_{\Omega_{\varepsilon}} + (\cdot, \cdot)_{\Omega_{\varepsilon}}$.

 $\text{By } || \cdot ||_{\Omega_{\varepsilon},T}$ we denote the norm in $L^2(0,T;H^1(\Omega_{\varepsilon}))$. By $|\cdot |_{r,\Omega_{\varepsilon},T}$ (respectively $|\cdot |_{r,\partial F_{\varepsilon},T})$, we denote the norm in $L^r(0,T;L^r(\Omega_\varepsilon))$ (respectively $L^r(0,T;L^r(\partial F_\varepsilon)))$.

We denote by γ_0 the trace operator $u \mapsto u|_{\partial \Omega_{\varepsilon}}$. The trace operator belongs to $\mathcal{L}(H^1(\Omega_{\varepsilon}), H^{1/2}(\partial \Omega_{\varepsilon}))$, and we will use $\|\gamma_0\|$ to denote the norm of γ_0 in this space.

We will use $\|\cdot\|_{\partial\Omega_{\varepsilon}}$ to denote the norm in $H^{1/2}(\partial\Omega_{\varepsilon})$, which is given by $\|\phi\|_{\partial\Omega_{\varepsilon}} = \inf\{\|v\|_{\Omega_{\varepsilon}}$: $\gamma_0(v) = \phi$. We remember that with this norm, $H^{1/2}(\partial \Omega_{\varepsilon})$ is a Hilbert space.

Finally, we denote by $H_{\partial\Omega}^r(\Omega_\varepsilon)$ and $H_{\partial\Omega}^r(\partial\Omega_\varepsilon)$, for $r\geq 0$, the standard Sobolev spaces which are closed subspaces of $H^r(\Omega_{\varepsilon})$ and $H^r(\partial\Omega_{\varepsilon})$, respectively, and the subscript $\partial\Omega$ means that, respectively, traces or functions in $\partial\Omega_{\varepsilon}$, vanish on this part of the boundary of Ω_{ε} , i.e.

3 Existence and uniqueness of solution

We state in this section a result on the existence and uniqueness of solution of problem (1.1) . Instead of working directly with our equation, we will apply a general result which is a slight modification of Theorem 1.4, Chapter 2 in Lions [\[7\]](#page-19-5).

In the sequel, we assume that

Remark 3.2. If a pair of functions $(u_{\varepsilon}, \psi_{\varepsilon})$ satisfies [\(3.15\)](#page-4-1)–[\(3.18\)](#page-4-2), then there exists a version of these functions satisfying [\(3.14\)](#page-4-3). The function ψ_{ε} is the $L^2_{\partial\Omega}(\partial\Omega_{\varepsilon})$ -continuous version of $\gamma_0(u)$ (see (3.23) – (3.25) below).

We have the following result.

Theorem 3.3. Under the assumptions [\(1.2\)](#page-1-2)–[\(1.9\)](#page-2-2), there exists a unique solution ($u_{\varepsilon}, \psi_{\varepsilon}$) of the problem (1.1) . Moreover, this solution satisfies the energy equality

Proof. The proof of this result is standard. For the sake of completeness, we give a sketch of a proof.

First, we prove that V_1 is densely embedded in H. In fact, if we consider $(w, \phi) \in H$ such that

\vec{u}_{\varepsilon}(0) = (u_{\varepsilon}^0, \psi_{\varepsilon} 0). \tag{3.25}
$$

Applying a slight modification of [\[7,](#page-19-5) Ch.2,Th.1.4], it is not difficult to see that problem [\(3.23\)](#page-5-0)–[\(3.25\)](#page-6-1) has a unique solution. Moreover, \vec{u}_{ε} satisfies the energy equality

$$
\frac{1}{2}\frac{d}{dt}|\vec{u}_{\varepsilon}(t)|_{H}^{2} + \sum_{i=1}^{3} \langle A_{i}(\vec{u}_{\varepsilon}(t)), \vec{u}_{\varepsilon}(t) \rangle_{i} = (\vec{h}(t), \vec{u}_{\varepsilon}(t))_{H} \quad \text{a.e. } t \in (0, T),
$$

where $\langle \cdot, \cdot \rangle_i$ denotes the duality product between V'_i and V_i .

This last equality turns out to be just [\(3.20\)](#page-4-5).

4 A priori estimates

Let us begin with a variant of the Trace Theorem in Ω_{ε} .

Lemma 4.1. There exists a positive constant C independent of ε , such that

\varepsilon |\gamma_0(v)|_{p,\partial F_{\varepsilon}}^p \le C \left(|v|_{p,\Omega_{\varepsilon}}^p + \varepsilon^p |\nabla v|_{p,\Omega_{\varepsilon}}^p \right), \quad 1 \le p < \infty,

\n(4.26)

for any $v \in W^{1,p}(\Omega_\varepsilon)$, $v = 0$ on $\partial \Omega$.

Proof. For any function $v(y) \in W^{1,p}(Y^*)^N$, using the Trace Theorem (see Chapter 5, Section 5.5, Theorem 1 in Evans [\[6\]](#page-19-6), for more details), we have for every $k \in \mathbb{Z}^N$

\int_{\partial (F+k)} |\gamma_0(v)|^p d\sigma(y) \le C \left(\int_{Y^*+k} |v|^p dy + \int_{Y^*+k} |\nabla v|^p dy \right), \quad 1 \le p < \infty,

where the constant C depends only on p and Y .

By the change of variable

y = \frac{x}{\varepsilon}, \quad d\sigma(y) = \varepsilon^{-(N-1)} d\sigma(x), \quad \partial_y = \varepsilon \partial_x,
$$
\n(4.28)

we rescale [\(4.27\)](#page-6-2) from $Y^* + k$ to $Y^*_{k,\varepsilon}$ and from $F + k$ to $F_{k,\varepsilon}$. This yields that, for any function $v(x) \in W^{1,p}(Y^*_{k,\varepsilon})^N$, one has

$$
\varepsilon\int_{\partial F_{k,\varepsilon}}|\gamma_0(v)|^pd\sigma(x)\leq C\left(\int_{Y^*_{k,\varepsilon}}|v|^pdx+\varepsilon^p\int_{Y^*_{k,\varepsilon}}|\nabla v|^pdx\right),
$$

with the same constant C as in [\(4.27\)](#page-6-2). Summing the inequalities, for every $k \in K$, gives the desired result [\(4.26\)](#page-6-3).

Let us obtain some a priori estimates for u_{ε} .

Lemma 4.2. Under the assumptions (1.2) – (1.9) and (3.13) , there exists a constant C independent of ε , such that the solution u_{ε} of the problem [\(1.1\)](#page-1-1) satisfies

||u_{\varepsilon}||_{\Omega_{\varepsilon},T} \leq C. \tag{4.29}
$$

Proof. By (3.20) and taking into account (1.6) , (1.7) and (3.22) , we have

\frac{d}{dt} \left(|(u_{\varepsilon}(t), \psi_{\varepsilon}(t))|_{H}^{2} \right) + \frac{2 \min \{1, \kappa\}}{1 + ||\gamma_{0}||^{2}} \left(||u_{\varepsilon}(t)||_{\Omega_{\varepsilon}}^{2} + ||\psi_{\varepsilon}(t)||_{\partial F_{\varepsilon}}^{2} \right) \n+ 2\alpha_{1} (|u_{\varepsilon}(t)|_{p,\Omega_{\varepsilon}}^{p} + \varepsilon |\psi_{\varepsilon}(t)|_{q,\partial F_{\varepsilon}}^{q}) \n\leq 2\beta (|\Omega_{\varepsilon}| + \varepsilon |\partial F_{\varepsilon}|) + |h(t)|_{\Omega_{\varepsilon}}^{2} + \varepsilon |\rho(t)|_{\partial F_{\varepsilon}}^{2} + |u_{\varepsilon}(t)|_{\Omega_{\varepsilon}}^{2} + \varepsilon |\psi_{\varepsilon}(t)|_{\partial F_{\varepsilon}}^{2},
$$
\n(4.30)

where $|\Omega_{\varepsilon}|$ and $|\partial F_{\varepsilon}|$ denote the measure of Ω_{ε} and ∂F_{ε} , respectively.

Integrating (4.30) between 0 and t and using (1.3) , we obtain

$$
\begin{split}\n& |(u_{\varepsilon}(t), \psi_{\varepsilon}(t))|_{H}^{2} + \frac{2 \min\{1, \kappa\}}{1 + ||\gamma_{0}||^{2}} \int_{0}^{t} \left(||u_{\varepsilon}(s)||_{\Omega_{\varepsilon}}^{2} + ||\psi_{\varepsilon}(s)||_{\partial F_{\varepsilon}}^{2} \right) ds \\
& + 2\alpha_{1} \int_{0}^{t} (|u_{\varepsilon}(s)|_{p,\Omega_{\varepsilon}}^{p} + \varepsilon |\psi_{\varepsilon}(s)|_{q,\partial F_{\varepsilon}}^{q}) ds \\
&\leq 2\beta t (|\Omega_{\varepsilon}| + \varepsilon |\partial F_{\varepsilon}|) + |(u_{\varepsilon}^{0}, \psi_{\varepsilon}^{0})|_{H}^{2} + \int_{0}^{T} (|h(s)|_{\Omega_{\varepsilon}}^{2} + \varepsilon |\rho(s)|_{\partial F_{\varepsilon}}^{2}) ds \\
& + \int_{0}^{t} |(u_{\varepsilon}(s), \psi_{\varepsilon}(s))|_{H}^{2} ds.\n\end{split} \tag{4.31}
$$

By Lemma [4.1](#page-6-4) with $p = 2$, we can deduce

$$
\varepsilon \, |\rho(t)|^2_{\partial F_{\varepsilon}} \leq C \left(|\rho(t)|^2_{\Omega_{\varepsilon}} + \varepsilon^2 |\nabla \rho(t)|^2_{\Omega_{\varepsilon}} \right) \leq C ||\rho(t)||^2_{\Omega_{\varepsilon}},
$$

which together with [\(1.3\)](#page-1-3) gives

\int_0^T \left(|h(s)|^2_{\Omega_{\varepsilon}} + \varepsilon |\rho(s)|^2_{\partial F_{\varepsilon}} \right) ds \le C. \tag{4.32}
$$

On the other hand, the number of holes is given by

Now, taking into account [\(3.13\)](#page-4-6), [\(4.32\)](#page-7-1)-[\(4.34\)](#page-7-4) in [\(4.31\)](#page-7-3), we get [\(4.29\)](#page-6-6).

Now, if we want to take the inner product in [\(1.1\)](#page-1-1) with u'_{ε} , we need that $u'_{\varepsilon} \in L^2(0,T; H^1_{\partial\Omega}(\Omega_{\varepsilon})) \cap$ $L^p(0,T;L^p(\Omega_\varepsilon))$ with $\gamma_0(u'_\varepsilon) \in L^q(0,T;L^q_\varepsilon)$ ${}_{\partial\Omega}^{q}(\Omega_{\varepsilon})$. However, we do not have it for our weak solution. Therefore, we use the Galerkin method and the following lemma in order to prove, rigorously, new a priori estimates for u_{ε} .

Lemma 4.3 (Lemma 11.2 in Robinson [\[8\]](#page-19-7)). Let X, Y be Banach spaces such that X is reflexive, and the inclusion $X \subset Y$ is compact. Assume that $\{u_m\}$ is uniformly bounded in $L^{\infty}(0,T;X)$,

\text{ess} \sup_{t \in [0,T]} \|u_m(t)\|_X \le C,
$$

and that $u_m \rightharpoonup u$ weakly in $L^2(0,T;X)$, then

\text{ess}\sup_{t\in[0,T]}\|u(t)\|_X\leq C.

Furthermore, if $u \in C([0,T];Y)$, then $u(t) \in X$ for all $t \in [0,T]$ and

\sup_{t \in [0,T]} \|u(t)\|_X \le C.
$$

Let us observe that the space $H^1_{\partial\Omega}(\Omega_\varepsilon)\times H^{1/2}_{\partial\Omega}$ $\frac{dI}{d\Omega}(\partial\Omega_{\varepsilon})$ is compactly imbedded in H, and therefore, for the symmetric and coercive linear continuous operator $A_1: V_1 \to V'_1$, where A_1 is given by [\(3.21\)](#page-5-2), there exists a non-decreasing sequence $0 < \lambda_1 \leq \lambda_2 \leq \ldots$ of eigenvalues associated to the operator A₁ with $\lim_{j\to\infty}\lambda_j=\infty$, and there exists a Hilbert basis of H, $\{(w_j,\gamma_0(w_j)) : j\geq 1\} \subset D(A_1)$, with $span\{(w_j, \gamma_0(w_j)) : j \geq 1\}$ densely embedded in V_1 , such that

$$
A_1((w_j, \gamma_0(w_j))) = \lambda_j(w_j, \gamma_0(w_j)) \quad \forall j \ge 1.
$$

Remark 4.4. It can be proved that if $p = q \geq 2$, then span $\{(w_j, \gamma_0(w_j)) : j \geq 1\}$ is densely embedded in $V_1 \cap H_p$.

Taking into account the above facts, we denote by

$$
(u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t)))=(u_{\varepsilon,m}(t;0,u^0_{\varepsilon},\psi^0_{\varepsilon}),\gamma_0(u_{\varepsilon,m}(t;0,u^0_{\varepsilon},\psi^0_{\varepsilon})))
$$

the Galerkin approximation of the solution $(u_\varepsilon(t; 0, u_\varepsilon^0, \psi_\varepsilon^0), \gamma_0(u_\varepsilon(t; 0, u_\varepsilon^0, \psi_\varepsilon^0)))$ to (1.1) for each integer $m \geq 1$, which is given by

(u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))) = \sum_{j=1}^m \delta_{\varepsilon m j}(t)(w_j,\gamma_0(w_j)),\tag{4.35}
$$

and is the solution of

$$
\frac{d}{dt}((u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))),(w_j,\gamma_0(w_j)))_H + \langle A_1((u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))),(w_j,\gamma_0(w_j)))\rangle \n+ (f(u_{\varepsilon,m}(t)),w_j)_{\Omega_{\varepsilon}} + \varepsilon(g(\gamma_0(u_{\varepsilon,m}(t))),\gamma_0(w_j))_{\partial F_{\varepsilon}}\n= (h(t),w_j)_{\Omega_{\varepsilon}} + \varepsilon(\rho(t),\gamma_0(w_j))_{\partial F_{\varepsilon}}, \quad j = 1,\ldots,m,
$$
\n(4.36)

with initial data

$$
(u_{\varepsilon,m}(0), \gamma_0(u_{\varepsilon,m}(0))) = (u_{\varepsilon,m}^0, \gamma_0(u_{\varepsilon,m}^0)),
$$
\n(4.37)

where

$$
\delta_{\varepsilon m j}(t) = (u_{\varepsilon,m}(t), w_j)_{\Omega_{\varepsilon}} + (\gamma_0(u_{\varepsilon,m}(t)), \gamma_0(w_j))_{\partial F_{\varepsilon}},
$$

and $(u_{\varepsilon,m}^0, \gamma_0(u_{\varepsilon,m}^0)) \in span\{(w_j, \gamma_0(w_j)) : j = 1,\ldots,m\}$ converge (when $m \to \infty$) to $(u_{\varepsilon}^0, \psi_{\varepsilon}^0)$ in a suitable sense which will be specified below.

Lemma 4.5. Suppose that in addition to the assumptions [\(1.2\)](#page-1-2)–[\(1.9\)](#page-2-2), we have $p = q \ge 2$. Then, for any initial condition $(u_\varepsilon^0, \psi_\varepsilon^0) \in V_1 \cap H_p$, there exists a constant C independent of ε , such that the solution u_{ε} of the problem [\(1.1\)](#page-1-1) satisfies

$$
\sup_{t \in [0,T]} \|u_{\varepsilon}(t)\|_{\Omega_{\varepsilon}} \le C. \tag{4.38}
$$

Proof. Let $(u_{\varepsilon}^0, \psi_{\varepsilon}^0) \in V_1 \cap H_p$. For all $m \geq 1$, by Remark [4.4,](#page-8-0) there exists $(u_{\varepsilon,m}^0, \gamma_0(u_{\varepsilon,m}^0)) \in$ $span\{(w_j,\gamma_0(w_j)) : 1 \leq j \leq m\}$, such that $\{(u_{\varepsilon,m}^0,\gamma_0(u_{\varepsilon,m}^0))\}$ converges to $(u_{\varepsilon}^0,\psi_{\varepsilon}^0)$ in V_1 and in H_p . Then, in particular we know that there exists a constant C such that

||(u_{\varepsilon,m}^0, \gamma_0(u_{\varepsilon,m}^0))||_{V_1} \le C, \quad |(u_{\varepsilon,m}^0, \gamma_0(u_{\varepsilon,m}^0))|_{H_p} \le C. \tag{4.39}

For each integer $m \ge 1$, we consider the sequence $\{(u_{\varepsilon,m}(t), \gamma_0(u_{\varepsilon,m}(t)))\}$ defined by $(4.35)-(4.37)$ $(4.35)-(4.37)$ with these initial data.

Multiplying by the derivative $\delta'_{\epsilon m j}$ in [\(4.36\)](#page-8-3), and summing from $j = 1$ to m, we obtain

We observe that

(g(\gamma_0(u_{\varepsilon,m}(t))), \gamma_0(u'_{\varepsilon,m}(t)))_{\partial F_{\varepsilon}} = \frac{d}{dt} \int_{\partial F_{\varepsilon}} \mathcal{G}(\gamma_0(u_{\varepsilon,m}(t))) d\sigma(x).

\begin{split}\n& |(u'_{\varepsilon,m}(t),\gamma_0(u'_{\varepsilon,m}(t)))|^2_H + \frac{1}{2}\frac{d}{dt}(\langle A_1((u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t)))) , (u_{\varepsilon,m}(t),\gamma_0(u_{\varepsilon,m}(t))))\rangle \\
&\leq \frac{1}{2}|h(t)|^2_{\Omega_{\varepsilon}} + \frac{1}{2}|u'_{\varepsilon,m}(t)|^2_{\Omega_{\varepsilon}} + \varepsilon \frac{1}{2}|\rho(t)|^2_{\partial F_{\varepsilon}} + \varepsilon \frac{1}{2}|\gamma_0(u'_{\varepsilon,m}(t))|^2_{\partial F_{\varepsilon}} \\
&\quad - \frac{d}{dt}\int_{\Omega_{\varepsilon}} \mathcal{F}(u_{\varepsilon,m}(t))dx - \varepsilon \frac{d}{dt}\int_{\partial F_{\varepsilon}} \mathcal{G}(\gamma_0(u_{\varepsilon,m}(t)))d\sigma(x).\n\end{split}
$$

Integrating now between 0 and t, taking into account the definition of A_1 and (3.22) , and using (1.11)

and [\(1.12\)](#page-2-5), we obtain that

$$
\int_{0}^{t} |(u'_{\varepsilon,m}(s), \gamma_0(u'_{\varepsilon,m}(s)))|_{H}^{2} ds + \frac{\min\{1, \kappa\}}{1 + ||\gamma_0||^{2}} ||(u_{\varepsilon,m}(t), \gamma_0(u_{\varepsilon,m}(t)))||_{V_{1}}^{2} \n+2\widetilde{\alpha}_{1}|(u_{\varepsilon,m}(t), \gamma_0(u_{\varepsilon,m}(t)))|_{H_{p}}^{p} \n\leq \max\{1, \kappa\} ||(u^{0}_{\varepsilon,m}, \gamma_0(u^{0}_{\varepsilon,m}))||_{V_{1}}^{2} + \int_{0}^{T} (|h(s)|_{\Omega_{\varepsilon}}^{2} + \varepsilon |\rho(s)|_{\partial F_{\varepsilon}}^{2}) ds \n+2\widetilde{\alpha}_{2}|(u^{0}_{\varepsilon,m}, \gamma_0(u^{0}_{\varepsilon,m}))|_{H_{p}}^{p} + 4\widetilde{\beta}(|\Omega_{\varepsilon}| + \varepsilon |\partial F_{\varepsilon}|),
$$
\n(4.40)

for all $t \in (0, T)$.

Taking into account (4.39) and using $(4.32)-(4.33)$ $(4.32)-(4.33)$ in (4.40) , we have proved that the sequence $\{(u_{\varepsilon,m},\gamma_0(u_{\varepsilon,m}))\}\$ is bounded in $C([0,T];V_1\cap H_p)$, and $\{(u'_{\varepsilon,m},\gamma_0(u'_{\varepsilon,m}))\}\$ is bounded in $L^2(0,T;H)$, for all $T > 0$.

If we work with the truncated Galerkin equations $(4.35)-(4.37)$ $(4.35)-(4.37)$ instead of the full PDE, we note that the calculations of the proof of Lemma [4.2](#page-6-7) can be following identically to show that $\{(u_{\varepsilon,m}, \gamma_0(u_{\varepsilon,m}))\}$ is bounded in $L^2(0,T;V_1)$, for all $T > 0$.

Moreover, taking into account the uniqueness of solution to [\(1.1\)](#page-1-1) and using Aubin-Lions compact-ness lemma (e.g., cf. Lions [\[7\]](#page-19-5)), it is not difficult to conclude that the sequence $\{(u_{\varepsilon,m},\gamma_0(u_{\varepsilon,m}))\}$ converges weakly in $L^2(0,T;V_1)$ to the solution $(u_\varepsilon,\gamma_0(u_\varepsilon))$ to (1.1) . Since the inclusion $H^1(\Omega_\varepsilon) \subset L^2(\Omega_\varepsilon)$ is compact and $u_{\varepsilon} \in C([0,T]; L^2(\Omega_{\varepsilon}))$, it follows using Lemma [4.3](#page-8-4) that the estimate [\(4.38\)](#page-9-1) is proved.

Lemma 4.6. Under the assumptions in Lemma [4.5,](#page-9-2) assume that $f, g \in C^1(\mathbb{R}), h \in W^{1,2}(0,T; L^2(\Omega))$ and $\rho \in W^{1,2}(0,T; H_0^1(\Omega))$, then there exists a constant C independent of ε , such that the solution u_{ε} of the problem [\(1.1\)](#page-1-1) satisfies

||u'_{\varepsilon}||_{\Omega_{\varepsilon},T} \leq C. \tag{4.41}
$$

Proof. We first note that under the conditions imposed we have that

As we are assuming that $f, g \in C^1(\mathbb{R}), h \in W_{loc}^{1,2}(\mathbb{R}; L^2(\Omega))$ and $\rho \in W_{loc}^{1,2}(\mathbb{R}; H_0^1(\Omega))$, we can differentiate with respect to time in [\(4.36\)](#page-8-3), and then, multiplying by the derivative δ'_{emj} and summing from $j = 1$ to m, we obtain

\frac{1}{2}\frac{d}{dt}\left|\left(u'_{\varepsilon,m}(t),\gamma_0(u'_{\varepsilon,m}(t))\right)\right|_H^2 + \left\langle A_1((u'_{\varepsilon,m}(t),\gamma_0(u'_{\varepsilon,m}(t)))) , (u'_{\varepsilon,m}(t),\gamma_0(u'_{\varepsilon,m}(t))) \right\rangle = -(f'(u_{\varepsilon,m}(t))u'_{\varepsilon,m}(t), u'_{\varepsilon,m}(t))_{\Omega_{\varepsilon}} - \varepsilon(g'(\gamma_0(u_{\varepsilon,m}(t)))\gamma_0(u'_{\varepsilon,m}(t)),\gamma_0(u'_{\varepsilon,m}(t)))_{\partial F_{\varepsilon}} +(h'(t),u'_{\varepsilon,m}(t))_{\Omega_{\varepsilon}} + \varepsilon(\rho'(t),\gamma_0(u'_{\varepsilon,m}(t)))_{\partial F_{\varepsilon}}.

Integrating between r and t

\begin{split} &\left| (u'_{\varepsilon,m}(t),\gamma_0(u'_{\varepsilon,m}(t))) \right|^2_H + \frac{2\min\left\{1,\kappa\right\}}{1+\|\gamma_0\|^2} \int_r^t \left\| (u'_{\varepsilon,m}(s),\gamma_0(u'_{\varepsilon,m}(s))) \right\|^2_{V_1} ds \\ \leq & \left| (u'_{\varepsilon,m}(r),\gamma_0(u'_{\varepsilon,m}(r))) \right|^2_H + (2l+1) \int_r^t |(u'_{\varepsilon,m}(s),\gamma_0(u'_{\varepsilon,m}(s)))|^2_H ds \\ & \quad + \int_r^t (|h'(s)|^2_{\Omega_{\varepsilon}} + \varepsilon|\rho'(s)|^2_{\partial F_{\varepsilon}}) ds, \end{split}
$$

for all $0 \le r \le t$. Now, integrating with respect to r between 0 and t,

for all $t \in (0, T)$.

By Lemma [4.1](#page-6-4) with $p = 2$, we can deduce

 $\epsilon |\rho'(t)|^2_{\partial F_{\varepsilon}} \leq C (|\rho'(t)|^2_{\Omega_{\varepsilon}} + \varepsilon^2 |\nabla \rho'(t)|^2_{\Omega_{\varepsilon}}) \leq C ||\rho'(t)||^2_{\Omega_{\varepsilon}},$

which, taking into account that $h \in W^{1,2}(0,T; L^2(\Omega))$ and $\rho \in W^{1,2}(0,T; H_0^1(\Omega))$, gives

Then, the sequence $\{(u'_{\varepsilon,m}, \gamma_0(u'_{\varepsilon,m}))\}$ converges weakly in $L^2(0,T;V_1)$ to $(u'_{\varepsilon}, \gamma_0(u'_{\varepsilon}))$, for all $T > 0$, and using the lower-semicontinuity of the norm and (4.45) , in particular we get

= C \left(1 + \|(u_{\varepsilon}^0, \psi_{\varepsilon}^0)\|_{V_1}^2 + |(u_{\varepsilon}^0, \psi_{\varepsilon}^0)|_{H_p}^p\right),
$$

which, jointly with $(u_{\varepsilon}^0, \psi_{\varepsilon}^0) \in V_1 \cap H_p$, implies [\(4.41\)](#page-10-2).

4.1 The extension of u_{ε} to the whole $\Omega \times (0,T)$

Since the solution u_{ε} of the problem [\(1.1\)](#page-1-1) is defined only in $\Omega_{\varepsilon} \times (0,T)$, we need to extend it to the whole $\Omega \times (0, T)$. We denote by \tilde{v} the zero extension to the whole $\Omega \times (0, T)$ for any function v defined on $\Omega_{\varepsilon}\times(0,T)$. For finding a suitable extension \tilde{u}_{ε} into all $\Omega\times(0,T)$, we shall use the following well-known extension Lemma.

Lemma 4.7 (Lemma 1 in Cioranescu and Saint Jean Paulin [\[4\]](#page-19-8)). Every function $\varphi_{\varepsilon} \in H^1(\Omega_{\varepsilon})$, with $\varphi_{\varepsilon} = 0$ on $\partial \Omega$, can be extended to a function $\tilde{\varphi}_{\varepsilon} \in H_0^1(\Omega)$, such that

where the constant C does not depend on ε .

Let us obtain some a priori estimates for the extension of u_{ε} to the whole $\Omega \times (0,T)$.

Corollary 4.8. Assume the assumptions in Lemma [4.6.](#page-10-3) Then, there exists an extension \tilde{u}_{ε} of the solution u_{ε} of the problem [\(1.1\)](#page-1-1) into $\Omega \times (0,T)$, such that

Proof. Using Lemma [4.7](#page-12-1) together with the estimate (4.29) (respectively the estimate (4.38)), we obtain the first estimate in [\(4.46\)](#page-12-2) (respectively the estimate [\(4.47\)](#page-12-3)).

By the Sobolev injection Theorem, if $N = 2$ we have the continuous embedding $H_0^1(\Omega) \subset L^p(\Omega)$ and if $N > 2$ we have the continuous embedding $H_0^1(\Omega) \subset L^{2N/(N-2)}(\Omega)$ which, jointly with the assumption [\(1.4\)](#page-1-4), yields the continuous embedding $H_0^1(\Omega) \subset L^p(\Omega)$.

Therefore, the continuous embedding $H_0^1(\Omega) \subset L^p(\Omega)$ implies that using Lemma [4.7](#page-12-1) together with the estimate [\(4.29\)](#page-6-6), we can deduce the second estimate in [\(4.46\)](#page-12-2).

Finally, using the continuous embedding $H_0^1(\Omega) \subset L^p(\Omega)$, Lemma [4.7](#page-12-1) and the estimate [\(4.41\)](#page-10-2), we can deduce the estimate [\(4.48\)](#page-12-4). \Box

5 A compactness result

In this section, we obtain some compactness results about the behavior of the sequence \tilde{u}_{ε} satisfying the a priori estimates given in Corollary [4.8.](#page-12-5)

Due to the periodicity of the domain Ω_{ε} , from Theorem 2.6 in Cioranescu and Donato [\[2\]](#page-19-9) one has, for $\varepsilon \to 0$, that

where ξ_{ε} is given by [\(5.50\)](#page-13-0).

Moreover, if we suppose that there exists a constant $l > 0$ such that

Proof. By [\(4.46\)](#page-12-2), we see that the sequence $\{\tilde{u}_{\varepsilon}\}\)$ is bounded in $L^2(0,T;H_0^1(\Omega)) \cap L^p(0,T;L^p(\Omega))$, for all $T > 0$. Let us fix $T > 0$. Then, there exists a subsequence $\{\tilde{u}_{\varepsilon}\}\subset \{\tilde{u}_{\varepsilon}\}\$ and function $u \in$ $L^2(0,T;H_0^1(\Omega)) \cap L^p(0,T;L^p(\Omega))$ such that

By the estimate [\(4.47\)](#page-12-3), for each $t \in [0, T]$, we have that $\{\tilde{u}_{\varepsilon}(t)\}\)$ is bounded in $H_0^1(\Omega)$, and since we have [\(5.58\)](#page-13-1), we can deduce

 $\tilde{u}_{\varepsilon'}(t) \rightharpoonup u(t)$ weakly in $H_0^1(\Omega)$, $\forall t \in [0, T]$.

Now, we analyze the convergence for the nonlinear term f . By the estimate [\(4.48\)](#page-12-4), we see that the sequence $\{\tilde{u}'_{\varepsilon}\}\)$ is bounded in $L^p(0,T;L^p(\Omega))$, for all $T>0$. Then, we have that $\tilde{u}_{\varepsilon}(t):[0,T]\longrightarrow L^p(\Omega)$ is an equicontinuous family of functions.

By Rellich-Kondrachov Theorem and [\(1.4\)](#page-1-4), for $p \ge 2$, if $N = 2$ we have the compact embedding $H_0^1(\Omega) \subset L^p(\Omega)$ and if $N > 2$, using that $p \leq 2N/(N-2)$, we also have the compact embedding $H_0^1(\Omega) \subset L^p(\Omega).$

Since, for each $t \in [0,T]$, we have that $\{\tilde{u}_{\varepsilon}(t)\}\$ is bounded in $H_0^1(\Omega)$, the compact embedding $H_0^1(\Omega) \subset L^p(\Omega)$, implies that it is precompact in $L^p(\Omega)$.

Then, applying the Ascoli-Arzelà Theorem, we deduce that $\{\tilde{u}_{\varepsilon}(t)\}\$ is a precompact sequence in $C([0,T]; L^p(\Omega))$. Hence, since we have [\(5.59\)](#page-13-1), we can deduce that

Thanks to [\(1.10\)](#page-2-3), applying Theorem 2.4 in Conca et al. In particular, from [\(5.60\)](#page-13-2), we have

Finally, from the estimate [\(4.29\)](#page-6-6) and [\(5.50\)](#page-13-0), we have $|\tilde{\xi}_{\varepsilon}|_{\Omega,T} \leq C$, and hence, up a sequence, there exists $\xi \in L^2(0,T,L^2(\Omega))$ such that $\tilde{\xi}_{\varepsilon''} \rightharpoonup \xi$ weakly in $L^2(0,T;L^2(\Omega))$.

By the uniqueness of solution of the limit problem [\(6.63\)](#page-15-0), we deduce that the above convergences hold for the whole sequence and therefore, by the arbitrariness of $T > 0$, all the convergences are satisfied, as we wanted to prove.

6 Homogenized model

In this section, we identify the homogenized model.

Firstly, for the integrals on Ω we only require to use Proposition [5.1](#page-13-5) and the convergence [\(5.49\)](#page-12-6), secondly for the integrals on the boundary of the holes we make use of a convergence result based on a technique introduced by Vanninathan [\[11\]](#page-19-4). Finally, we pass to the limit, as $\varepsilon \to 0$, in [\(6.66\)](#page-15-1).

Step 1. Passing to the limit, as $\varepsilon \to 0$, in the integrals on Ω :

From [\(5.52\)](#page-13-6)-[\(5.53\)](#page-13-6) and [\(5.49\)](#page-12-6), we have respectively, for $\varepsilon \to 0$,

\kappa \int_0^T \varphi(t) \int_{\Omega} \chi_{\Omega_{\varepsilon}} \tilde{u}_{\varepsilon}(t) v dx dt \to \kappa \frac{|Y^*|}{|Y|} \int_0^T \varphi(t) \int_{\Omega} u(t) v dx dt,
$$

and

$$
\int_0^T \varphi(t) \int_{\Omega} \chi_{\Omega_{\varepsilon}} f(\tilde{u}_{\varepsilon}(t)) \nu dx dt \to \frac{|Y^*|}{|Y|} \int_0^T \varphi(t) \int_{\Omega} f(u(t)) \nu dx dt.
$$

By (5.52) and (5.49) , we have

$$
\varphi(0)\left(\int_{\Omega}\chi_{\Omega_{\varepsilon}}\tilde{u}_{\varepsilon}(0)vdx\right)\to \varphi(0)\frac{|Y^*|}{|Y|}\int_{\Omega}u(0)vdx,\quad \forall v\in\mathcal{D}(\Omega).
$$

By the assumption [\(1.3\)](#page-1-3), [\(5.49\)](#page-12-6) and using Lebesgue's Dominated Convergence Theorem, we get

$$
\int_0^T \varphi(t) \int_{\Omega} \chi_{\Omega_{\varepsilon}} h(t) \nu dx dt \to \frac{|Y^*|}{|Y|} \int_0^T \varphi(t) \int_{\Omega} h(t) \nu dx dt.
$$

On the other hand, using [\(5.55\)](#page-13-6), we obtain, for $\varepsilon \to 0$

$$
\int_0^T \varphi(t) \int_{\Omega} \tilde{\xi}_{\varepsilon} \nabla v dx dt \to \int_0^T \varphi(t) \int_{\Omega} \xi \nabla v dx dt.
$$

Step 2. Passing to the limit, as $\varepsilon \to 0$, in the surface integrals on the boundary of the holes:

We make use of the technique introduced by Vanninathan [\[11\]](#page-19-4) for the Steklov problem which transforms surface integrals into volume integrals. This technique was already used as a main tool to homogenize the non homogeneous Neumann problem for the elliptic case by Cioranescu and Donato [\[1\]](#page-19-3).

By Definition 3.2 in Cioranescu and Donato [\[1\]](#page-19-3), let us introduce, for any $h \in L^{s'}(\partial F)$, $1 \le s' \le \infty$, the linear form μ_h^{ε} on $W_0^{1,s}$ $L_0^{1,s}(\Omega)$ defined by

$$
\langle \mu_h^\varepsilon,\varphi\rangle=\varepsilon\int_{\partial F_\varepsilon}h\left(\frac{x}{\varepsilon}\right)\varphi d\sigma,\quad \forall \varphi\in W^{1,s}_0(\Omega),
$$

with $1/s + 1/s' = 1$. It is proved in Lemma 3.3 in Cioranescu and Donato [\[1\]](#page-19-3) that

$$
\mu_h^{\varepsilon} \to \mu_h \quad \text{strongly in } (W_0^{1,s}(\Omega))', \tag{6.67}
$$

where $\langle \mu_h, \varphi \rangle = \mu_h \int_{\Omega} \varphi dx$, with

$$
\mu_h = \frac{1}{|Y|} \int_{\partial F} \phi(y) d\sigma.
$$

In the particular case in which $h \in L^{\infty}(\partial F)$ or even when h is constant, we have

$$
\mu_h^{\varepsilon} \to \mu_h \quad \text{strongly in } W^{-1,\infty}(\Omega).
$$

In what follows, we shall denote by μ_1^{ε} the above introduced measure in the particular case in which $h = 1$. Notice that in this case μ_h becomes $\mu_1 = |\partial F|/|Y|$.

Observe that using Corollary 4.2 in Cioranescu et al. [\[3\]](#page-19-11) with [\(5.51\)](#page-13-6), we can deduce, for $\varepsilon \to 0$,

$$
\varepsilon \int_{\partial F_{\varepsilon}} \gamma_0(u_{\varepsilon}(t)) \gamma_0(v) d\sigma(x) = \langle \mu_1^{\varepsilon}, \tilde{u}_{\varepsilon|\Omega_{\varepsilon}}(t)v \rangle \to \mu_1 \int_{\Omega} u(t)v dx = \frac{|\partial F|}{|Y|} \int_{\Omega} u(t)v dx,
$$

for all $v \in \mathcal{D}(\Omega)$, which integrating in time and using Lebesgue's Dominated Convergence Theorem, gives

$$
\varepsilon \int_0^T \frac{d}{dt} \varphi(t) \left(\int_{\partial F_{\varepsilon}} \gamma_0(u_{\varepsilon}(t)) \gamma_0(v) d\sigma(x) \right) dt \to \frac{|\partial F|}{|Y|} \int_0^T \frac{d}{dt} \varphi(t) \left(\int_{\Omega} u(t) v dx \right) dt.
$$

Moreover, using Corollary 4.2 in Cioranescu et al. [\[3\]](#page-19-11) with [\(5.51\)](#page-13-6), we can deduce, for $\varepsilon \to 0$,

$$
\varepsilon \int_{\partial F_{\varepsilon}} \gamma_0(u_{\varepsilon}(0)) \gamma_0(v) d\sigma(x) = \langle \mu_1^{\varepsilon}, \tilde{u}_{\varepsilon}|_{\Omega_{\varepsilon}}(0)v \rangle \to \mu_1 \int_{\Omega} u(0)v dx = \frac{|\partial F|}{|Y|} \int_{\Omega} u(0)v dx, \quad \forall v \in \mathcal{D}(\Omega).
$$

On the other hand, note that using (6.67) with $s = 2$, taking into account (1.3) and by Lebesgue's Dominated Convergence Theorem, we can deduce, for $\varepsilon \to 0$,

$$
\varepsilon \int_0^T \varphi(t) \int_{\partial F_{\varepsilon}} \rho(t) \gamma_0(v) d\sigma(x) dt = \int_0^T \varphi(t) \langle \mu_1^{\varepsilon}, \rho(t) v \rangle dt \to \frac{|\partial F|}{|Y|} \int_0^T \varphi(t) \int_{\Omega} \rho(t) v dx dt.
$$

From (5.57) and (6.67) , with $s = p'$, we conclude

$$
\varepsilon \int_{\partial F_{\varepsilon}} g(\gamma_0(u_{\varepsilon}(t))) \gamma_0(v) d\sigma(x) = \langle \mu_1^{\varepsilon}, g(\tilde{u}_{\varepsilon}(t))v \rangle \to \frac{|\partial F|}{|Y|} \int_{\Omega} g(u(t))v dx,
$$

for all $v \in \mathcal{D}(\Omega)$, which integrating in time and using Lebesgue's Dominated Convergence Theorem, gives

$$
\varepsilon \int_0^T \varphi(t) \int_{\partial F_{\varepsilon}} g(\gamma_0(u_{\varepsilon}(t))) \gamma_0(v) d\sigma(x) dt \to \frac{|\partial F|}{|Y|} \int_0^T \varphi(t) \int_{\Omega} g(u(t)) v dx dt.
$$

Step 3. Passing to the limit, as $\varepsilon \to 0$, in [\(6.66\)](#page-15-1):

All the terms in [\(6.66\)](#page-15-1) pass to the limit, as $\varepsilon \to 0$, and therefore taking into account the previous steps, we get

$$
-\varphi(0)\left(\frac{|Y^*|}{|Y|} + \frac{|\partial F|}{|Y|}\right)\left(\int_{\Omega}u(0)vdx\right) - \left(\frac{|Y^*|}{|Y|} + \frac{|\partial F|}{|Y|}\right)\int_0^T\frac{d}{dt}\varphi(t)\left(\int_{\Omega}u(t)vdx\right)dt
$$

$$
+ \int_0^T\varphi(t)\int_{\Omega}\xi\nabla vdxdt + \kappa\frac{|Y^*|}{|Y|}\int_0^T\varphi(t)\int_{\Omega}u(t)vdxdt
$$

$$
+ \frac{|Y^*|}{|Y|}\int_0^T\varphi(t)\int_{\Omega}f(u(t))vdxdt + \frac{|\partial F|}{|Y|}\int_0^T\varphi(t)\int_{\Omega}g(u(t))vdxdt
$$

$$
= \frac{|Y^*|}{|Y|}\int_0^T\varphi(t)\int_{\Omega}h(t)vdxdt + \frac{|\partial F|}{|Y|}\int_0^T\varphi(t)\int_{\Omega}\rho(t)vdxdt.
$$

Hence, ξ verifies

$$
\left(\frac{|Y^*|}{|Y|} + \frac{|\partial F|}{|Y|}\right)\frac{\partial u}{\partial t} - \text{div}\xi + \frac{|Y^*|}{|Y|}(\kappa u + f(u)) + \frac{|\partial F|}{|Y|}g(u) = \frac{|Y^*|}{|Y|}h(t) + \frac{|\partial F|}{|Y|}\rho(t), \quad \text{in } \Omega \times (0, T). \tag{6.68}
$$

It remains now to identify ξ . The proof is standard, so we omit it. Following, for example, the proof of Theorem 4.7 in Cioranescu and Donato [\[1\]](#page-19-3), we conclude that

$$
\xi = Q\nabla u, \quad \text{in } \Omega \times (0, T), \tag{6.69}
$$

 \Box

where $Q = ((q_{i,j}))$ is given by [\(6.64\)](#page-15-2). Then, taking into account [\(6.69\)](#page-18-0) in [\(6.68\)](#page-18-1), we have the homogenized model [\(6.63\)](#page-15-0).

Definition 6.2. A weak solution of (6.63) is any function u, satisfying

$$
u \in C([0, T]; L^{2}(\Omega)), \quad \text{for all } T > 0,
$$
\n
$$
u \in L^{2}(0, T; H_{0}^{1}(\Omega)) \cap L^{p}(0, T; L^{p}(\Omega)), \quad \text{for all } T > 0,
$$
\n
$$
\begin{cases}\n\left(\frac{|Y^{*}|}{|Y|} + \frac{|\partial F|}{|Y|}\right) \frac{d}{dt}(u(t), v) + (Q\nabla u(t), \nabla v) + \frac{|Y^{*}|}{|Y|} \kappa(u(t), v) + \frac{|Y^{*}|}{|Y|} (f(u(t)), v) + \frac{|\partial F|}{|Y|} (g(u(t)), v) \\
= \frac{|Y^{*}|}{|Y|} (h(t), v) + \frac{|\partial F|}{|Y|} (\rho(t), v), \\
\text{in } \mathcal{D}'(0, T), \text{ for all } v \in H_{0}^{1}(\Omega) \cap L^{p}(\Omega), \\
u(0) = u_{0}.\n\end{cases}
$$

Remark 6.3. Applying a slight modification of Theorem 1.4, Chapter 2 in Lions [\[7\]](#page-19-5), we obtain that the problem [\(6.63\)](#page-15-0) has a unique solution.
