# A model of Josephson Junctions on Boson Systems - Currents and Entropy Production Rate -

Abstract: Non-equilibrium steady states (NESS), in the sense of D. Ruelle [Comm. Math. Phys. 224, 3–16 (2001)], of Boson systems with Bose–Einstein condensation (BEC) are investigated with the aid of the C<sup>∗</sup> algebraic method. The model consists of a quantum particle and several bosonic reservoirs. We show that the mean entropy production rate is strictly positive, independent of phase differences provided that the temperatures or the chemical potentials of reservoirs are different. Moreover, Josephson currents occur without entropy production, if the temperatures and the chemical potentials of reservoirs are identical.

Keywords: CCR algebra, BEC, NESS, Mourre estimate, Spectrum of the adjacency operator of graphs. AMS subject classification: 82B10

# 1 Introduction

In the present paper, we study non-equilibrium steady states (NESS) of a model, which consists of a quantum particle and several bosonic reservoirs with Bose–Einstein condensation (BEC) (figure [1\)](#page-1-0). The reservoirs consist of free Bose particles on  $\mathbb{R}^d$  or on graphs. We denote the annihilation and the creation operators of

the system (resp. the *k*-th reservoir) by *a* and  $a^{\dagger}$  (resp.  $a_{x,k}$  and  $a^{\dagger}_{x,k}$ ). These operators satisfy Canonical Commutation Relations (CCR):

$$
\left[a, a^{\dagger}\right] = 1, \qquad \left[a_{x,k}, a^{\dagger}_{y,l}\right] = \delta_{k,l}\delta(x-y), \quad k, l = 1, \dots, N,
$$
\n(1.1)

where *N* is the number of reservoirs. In the case of  $\mathbb{R}^d$ , the Hamiltonian *H* of our coupled model is formally given by

where  $\lambda > 0$  and

$$
H_0 = \Omega a^{\dagger} a + \sum_{k=1}^{N} \int_{\mathbb{R}^d} dp \frac{|p|^2}{2} a^{\dagger}_{p,k} a_{p,k}, \quad W_k = \int_{\mathbb{R}^d} dp \Big\{ \overline{g_k(p)} a^{\dagger} a_{p,k} + g_k(p) a a^{\dagger}_{p,k} \Big\}.
$$

When we consider the case of graphs, we replace the integral part of  $(1.3)$  by the sum over the set of vertices of graphs and  $|x|^2/2$  by the adjacency operators of graphs. Following ideas of D. Ruelle [\[19\]](#page-20-0), we say that a state is a NESS, if it is a weak ∗-limit point of the net

$$

where  $\omega_0$  is the initial state and  $\alpha_t$  is the Heisenberg time evolution of our coupled model defined by  $\alpha_t(Q)$ *e itH Qe*−*itH* for a quantum observable *Q*. The initial state is given by a product state of a state of a finite system and equilibrium states with the temperatures, the chemical potentials, and BEC. The mathematical studies of BEC has a long history (cf. [\[23\]](#page-20-1)). Our line of research is based on a classical paper of J.T. Lewis and J. V. Pulè [\[14\]](#page-20-2) and papers of F. Fidaleo et al. [\[7\]](#page-19-0), F. Fidaleo [\[8\]](#page-19-1), and T. Matsui [\[16\]](#page-20-3) . We obtain explicit formulas of NESS, currents, and the mean entropy production rate. We prove rigorously that the mean entropy production rate is strictly positive, if the temperatures or the chemical potentials of reservoirs are different and if there exists an open channel, specified in Section [4.](#page-11-0) Moreover, we show that Josephson currents occur without entropy production, if the temperatures and the chemical potentials of reservoirs are identical.

V. Jakšić, C.-A. Pillet, and their coworkers investigated various aspects of NESS (to take a few examples, [\[1,](#page-19-2) [2,](#page-19-3) [4,](#page-19-4) [5,](#page-19-5) [9,](#page-19-6) [10,](#page-19-7) [12\]](#page-20-4)). However, the case of bosonic reservoirs with BEC was hardly studied before except works of S. Tasaki and T. Matsui [\[21\]](#page-20-5).

In Section [2,](#page-2-0) we have an explicit formula of the coupled time evolution (Theorem [2.3\)](#page-16-0). In Section [3,](#page-6-0) we define the initial state on the Weyl CCR algebra and obtain an explicit formula of NESS (Theorem [3.3\)](#page-16-0). Section [4](#page-11-0) contains our main results: explicit formulas of currents and the (strict) positivity of the mean entropy production rate (Corollary [4.1,](#page-15-0) Proposition [4.2,](#page-15-1) and Theorem [4.3\)](#page-16-0). In Section [5,](#page-13-0) we give calculations of currents in the case of  $\mathbb{R}^d$ ,  $d \geq 3$ , and of graphs. To verify our conditions for the adjacency operators of undirected graphs, we introduce works of M. Măntoiu et al. [\[15\]](#page-20-6). They studied the spectrum of the adjacency operators of undirected graphs using Mourre estimate techniques. After introduction of notations, we consider typical examples of graphs: periodic graphs and comb graphs.

## <span id="page-2-0"></span>2 Time Evolutions

In this section, we briefly recall the definition of the Weyl CCR algebras and give an explicit formula of the coupled time evolution.

### 2.1 Weyl Operators and Weyl CCR Algebras

Let h be a subspace of a Hilbert space  $\mathfrak{H}$ . On the Bose–Fock space  $\mathcal{F}_+(h)$ , we can define the annihilation operators  $a(f)$ , and the creation operators  $a^{\dagger}(f)$ ,  $f \in \mathfrak{h}$ . (See e.g. [\[3\]](#page-19-8).) The operators  $a(f)$  and  $a^{\dagger}(f)$  are closed and satisfy the equations:

$$
[a(f), a(g)] = 0 = [a†(f), a†(g)], \quad [a(f), a†(g)] = \langle f, g \rangle \mathbb{1}, \quad f, g \in \mathfrak{h}, \tag{2.1}
$$

where  $[A, B] = AB - BA$ . The field operators  $\Psi(f)$  are defined by

$$
\Psi(f) = \frac{1}{\sqrt{2}} \overline{\{a(f) + a^\dagger(f)\}}^{\text{op.cl.}}, \quad f \in \mathfrak{h}, \tag{2.2}
$$

where  $\overline{A}^{\text{op.cl.}}$  means the closure of operator *A*. Then the operators  $\Psi(f)$  are (unbounded) self-adjoint and satisfy CCR:

$$
[\Psi(f), \Psi(g)] = \text{Im}\langle f, g \rangle \mathbb{1} := \sigma(f, g)\mathbb{1}, \quad f, g \in \mathfrak{h}.

The Weyl operators *W*(*f*) are defined by

W(f) = \exp(i\Psi(f)), \quad f \in \mathfrak{h},\tag{2.4}
$$

and satisfy the following equations:

$$
W(0) = 1, \quad W(f)^* = W(-f), \quad W(f)W(g) = e^{-i\frac{\sigma(f,g)}{2}}W(f+g), \quad f, g \in \mathfrak{h}.
$$

The Weyl CCR algebra  $W$ (b) is the unital C<sup>∗</sup>-algebra generated by unitaries  $W(f)$ ,  $f \in \mathfrak{h}$ . Generally, the Weyl CCR algebra  $W$ (b) is the unital universal C<sup>∗</sup>-algebra generated by unitaries  $W(f)$ ,  $f \in \mathfrak{h}$ , which satisfy [\(2.5\)](#page-2-1). (See e.g. [\[3,](#page-19-8) Theorem 5.2.8.].)

#### 2.2 Time Evolutions

In this subsection, we give an explicit formula of the coupled time evolutions. The model is defined on the Boson–Fock space  $\mathcal{F}_+(\mathcal{K})$  over the Hilbert space  $\mathcal{K} := \mathbb{C} \oplus (\bigoplus_{k=1}^N \mathfrak{K}_k)$  equipped with the inner product

$$
\left\langle \begin{pmatrix} c^{(1)} \\ \psi_1^{(1)} \\ \vdots \\ \psi_N^{(1)} \end{pmatrix} \right|, \begin{pmatrix} c^{(2)} \\ \psi_1^{(2)} \\ \vdots \\ \psi_N^{(2)} \end{pmatrix} \right\rangle = \overline{c^{(1)}}c^{(2)} + \sum_{k=1}^N \left\langle \psi_k^{(1)}, \psi_k^{(2)} \right\rangle_k, \tag{2.6}
$$

where  $c^{(1)}$ ,  $c^{(2)} \in \mathbb{C}$ , for each  $k = 1, ..., N$ ,  $\Re_k$  is a Hilbert space with the inner product  $\langle \cdot, \cdot \rangle_k$ , and  $\psi_k^{(1)}$  $\psi_k^{(1)}, \psi_k^{(2)} \in \mathcal{R}_k.$ The free Hamiltonian  $H_0$  on  $\mathcal{F}_+(\mathcal{K})$  is given by  $H_0 = d\Gamma(h_0)$ , where  $d\Gamma$  is the second quantization (see e.g. [\[3,](#page-19-8) Section 5.2]),  $h_0$  is the positive self-adjoint operator on  $\mathcal K$  defined by

 $\Omega > 0$ ,  $c \in \mathbb{C}$ ,  $h_{0,k}$  is the positive one-particle Hamiltonian on each reservoirs,  $k = 1, \ldots, N$ , and  $\psi_k$  is a vector in the domain of  $h_{0,k}$ . The Hamiltonian *H* of our coupled model is given by  $H = d\Gamma(h)$ , where *h* is the self-adjoint operator on  $K$  defined by

$$
h\begin{pmatrix} c \\ \psi_1 \\ \vdots \\ \psi_N \end{pmatrix} = \begin{pmatrix} \Omega c + \lambda \sum_{k=1}^N \langle g_k, \psi_k \rangle \\ h_{0,1} \psi_1 + \lambda c g_1 \\ \vdots \\ h_{0,N} \psi_N + \lambda c g_N \end{pmatrix} =: (h_0 + \lambda V) \begin{pmatrix} c \\ \psi_1 \\ \vdots \\ \psi_N \end{pmatrix},
$$

 $\lambda > 0$ , and  $g_k \in \mathcal{R}_k$ ,  $k = 1, ..., N$ . On the Weyl CCR algebra  $W(K)$ , the map  $\alpha_t$ ,  $t \in \mathbb{R}$ , defined by

$$
\alpha_t(W(f)) = e^{it d\Gamma(h)} W(f) e^{-it d\Gamma(h)} = W(e^{ith} f), \quad f \in \mathcal{K},
$$
\n(2.9)

is a one-parameter group of automorphisms on  $W(K)$ .

For simplicity, we denote vectors  ${}^{t}(\psi_1,\ldots,\psi_N)$ ,  ${}^{t}(g_1,\ldots,g_N)$ , and the self-adjoint operator  $\bigoplus_{k=1}^{N} h_{0,k}$  by  $\psi$ , *g*, and  $h_{0,0}$ , respectively, where  $t($ ...) means transposition.

To obtain an explicit formula of the coupled time evolution, we need some conditions.

(Abs) For  $k = 1, ..., N$ , a pair  $(\psi, \xi)$  of vectors  $\psi, \xi \in \mathcal{R}_k$  satisfy

$$
\sup_{\nu \in \mathbb{R}, \varepsilon > 0} \left| \left\langle \psi, (\nu - h_{0,k} \pm i\varepsilon)^{-1} \xi \right\rangle \right| < \infty.

For simplicity, if vectors  $\psi_k, \xi_k \in \Omega_k, k = 1, \ldots, N$ , satisfy condition (Abs), then we say that  $(\psi, \xi)$  has condition (Abs).

- (A) The form factor *g* defined in [\(2.8\)](#page-3-0) has condition (Abs), i.e., (*g*, *g*) has condition (Abs).
- (B) We define the function  $\eta(z)$  by

$$
\eta(z) := z - \Omega - \lambda^2 \int_{\sigma_0} \frac{1}{z - \nu} d\langle g, E_0(\nu)g \rangle, \tag{2.11}
$$

where  $E_0$  is the spectral measure of  $h_{0,0}$  and  $\sigma_0$  is the set of spectrum of  $h_{0,0}$ . Then  $1/\eta_+ \in L^{\infty}(\mathbb{R})$ , where  $\eta_+(x) = \lim_{\varepsilon \searrow 0} \eta(x + i\varepsilon).$ 

**Remark 2.1.** *By condition* (A)*, there exists a constant*  $C_g > 0$  *such that* 

$$
\sup_{\nu \in \mathbb{R}, \varepsilon > 0} \left| \left\langle g, (\nu - h_{0,0} \pm i\varepsilon)^{-1} g \right\rangle \right| < C_g. \tag{2.12}

*If*  $\Omega \in \sigma_0$ ,  $\lambda$  *is sufficiently small, and there exists a constant*  $C > 0$  *such that*

*for a.e.*  $v \in [\Omega - 2\lambda^2 C_g, \Omega + 2\lambda^2 C_g]$ , then the function  $\eta$  satisfies condition (B).

We define the sets  $\mathfrak{h}_k(g_k)$  and  $\mathfrak{h}(g)$  by

$$
\mathfrak{h}_k(g_k) = \{ \psi \in \mathfrak{R}_k \mid (\psi, g_k) \text{ has condition (Abs)} \}, \quad \mathfrak{h}(g) = \left\{ \begin{array}{c} \mathfrak{k}(\psi_1, \dots, \psi_N) \mid \psi_k \in \mathfrak{h}_k(g_k) \end{array} \right\}.

For any  $c \in \mathbb{C}$  and any  $\psi \in b(g)$ , we put  $f = {}^{t}(c, \psi)$ ,

$$
F(v; f) := c + \lambda \Big\langle g, (v - h_{0,0} - i0)^{-1} \psi \Big\rangle \Bigg( = c + \lambda \lim_{\varepsilon \searrow 0} \Big\langle g, (v - h_{0,0} - i\varepsilon)^{-1} \psi \Big\rangle \Bigg), \quad \text{a.e. } v \in \mathbb{R},

Let  $\mathfrak F$  be a Hilbert space. For any  $\xi, \zeta, \psi \in \mathfrak H$ , we set

$$
(\xi \otimes \zeta)\psi = \langle \zeta, \psi \rangle \xi, \tag{2.15}

where  $\langle \cdot, \cdot \rangle$  is the inner product of  $\mathfrak{H}$ .

**Proposition 2.2.** *Let h<sub>0</sub> and h be the operators defined in* [\(2.7\)](#page-3-1) *and* [\(2.8\)](#page-3-0)*. Then we have*

*and the function*  $\eta(z)$  *is defined in* [\(2.11\)](#page-3-2).

Proof. By resolvent formula, we have

Since *V* is a finite rank operator, *B*(*z*) has the form of

for some  $\xi_1(z)$ ,  $\xi_2(z) \in \xi$ . By multiplying the equation [\(2.18\)](#page-4-0) by  $z - h$  from the right, we have

By [\(2.19\)](#page-4-1), we obtain the equation

Thus, we get the equation [\(2.17\)](#page-4-2).  $\blacksquare$ 

**Theorem 2.3.** *Under conditions* (A) *and* (B)*, for any*  $c, d \in \mathbb{C}$  *and any*  $\psi, \xi \in \mathfrak{h}(g)$ *, which*  $(\psi, \xi)$  *has condition* (Abs)*, eith has the following form:*

$$
\left\langle \left(\begin{array}{c}d\\ \xi\end{array}\right), e^{ith}\left(\begin{array}{c}c\\ \psi\end{array}\right)\right\rangle = dc(t) + \langle \xi, \psi(t) \rangle, \tag{2.24}

To prove the above theorem, we will use the following lemma.

**Lemma 2.4.** Assume that conditions (A) and (B). For any  $R > ||h_{0,0}||$  and any  $\zeta, \xi \in b(g)$ , which  $(\zeta, \xi)$  has *condition* (Abs)*, we have the following equations:*

# <span id="page-6-0"></span>3 NESS

In this section, we give the initial state and an explicit formula of NESS. In the present paper, we consider the case that  $h_{0,k}$  is the multiplication operator of  $|p|^2/2$ ,  $p \in \mathbb{R}^d$ , on  $L^2(\mathbb{R}^d)$ ,  $d \geq 3$ , or  $h_{0,k} = ||A_{G_k}|| \mathbb{1} - A_{G_k}$ , where *G<sup>k</sup>* are undirected connected graphs with bounded degree, with countable infinite vertices, with no loops, and with no multiple edges and  $A_{G_k}$  is the adjacency operator of  $G_k$  for each  $k = 1, ..., N$ . We recall the definition of Perron–Frobenius weights (PF weights, for short).

If  $h_{0,k}$  is the multiplication operator of  $|p|^2/2$ , then we define the PF weight  $v_k$  by  $v_k := \delta$ , where  $\delta$  is the Dirac's delta function.

Let *G* be an undirected connected graph with bounded degrees, with countable infinite vertices, with no loops, and with no multiple edges. We denote the set of vertices of *G* by *VG*.

Fix a positive preserving operator *B* acting on  $\ell^2(VG)$ . The sequence  $\{v(x)\}_{x \in VG}$  is called a PF weight if it has positive entries and

$$
\sum_{y \in VG} B_{xy} v(y) = \text{spr}(B)v(x), \quad x \in VG,
$$
\n(3.1)

where "spr" stands for spectral radius. If such a vector belongs to  $\ell^2(VG)$  it is a standard eigenvector for *B*. For the adjacency operator  $A_G$  of G, the existence of *v* proved in [\[7,](#page-19-0) Proposition 4.1]. We regard a PF weight *v* as a densely defined linear functional on  $\ell^2(VG)$ . We define the domain  $\mathcal{D}(v)$  of *v* by

$$
\mathcal{D}(v) = \left\{ \psi \in \ell^2(VG) \middle| \sum_{x \in VG} v(x) |\psi(x)| < \infty \right\},\tag{3.2}
$$

where  $\psi(x) = \langle \delta_x, \psi \rangle$  and  $\delta_x$  is the delta function such that  $\delta_x(y) = 0$  for any  $y \neq x$  and  $\delta_x(x) = 1$ . If  $\psi \in \mathcal{D}(v)$ , we denote  $\sum_{x \in VG} v(x)\psi(x)$  by  $\langle v, \psi \rangle$ . Note that PF weights for the adjacency operator of an infinite graph may not be unique. (See e.g. [\[7\]](#page-19-0), [\[8\]](#page-19-1), and [\[17\]](#page-20-7).) When *v* is a PF weight for *AG*, we say that *v* is a PF weight for  $||A_G|| \mathbb{1} - A_G.$ 

For an operator *A* on a Hilbert space, we denote the domain of *A* by  $\mathcal{D}(A)$ . For each  $k = 1, \ldots, N$ , we denote the inverse temperature and the chemical potential of *k*-th reservoir by  $\beta_k > 0$  and  $\mu_k \leq 0$ , respectively. Let  $v_k$  be PF weights for  $h_{0,k}$ ,  $k = 1, ..., N$ . We set  $\mathcal{D}(v) = \bigoplus_{k=1}^N \mathcal{D}(v_k)$  and  $(\psi_k) = {}^t(0, 0, ..., 0, \psi_k, 0, ..., 0)$ for  $\psi_k \in \mathcal{R}_k$ , i.e.  $(\psi_k)$  means the *k*-th component is equal to  $\psi_k$  and the others are equal to zero. Suppose  $\psi_k \in \mathcal{D}(v_k) \cap \mathcal{D}((e^{\beta_k(h_{0,k}-\mu_k)}-1)^{-1/2})$ . We consider the initial state  $\omega_0$  of the *k*-th reservoir given by

$$
\omega_0(W((\psi_k))) = \exp\left(-\frac{1}{2}\langle\psi_k, (\mathcal{N}_k(h_{0,k}) + 1/2)\psi_k\rangle\right) e^{i\Theta_k((v_k,\psi_k))},\tag{3.3}
$$

where

and  $\Theta_k$  is real valued real linear functional on  $\mathbb{C}$ . Detail forms of  $\Theta_k(\langle v_k, \cdot \rangle)$  is given in Section [5.](#page-13-0) We assume that if  $\mu_k$  < 0, then  $\Theta_k$  = 0. To obtain an explicit formula of NESS, we assume that the following conditions for initial states and form factors:

(C) The initial state  $\omega_0$  satisfies

$$
\left|\omega_0(a^{\natural_1}a^{\natural_2}\cdots a^{\natural_n})\right|\leq n!K_n,\quad n\in\mathbb{N},\tag{3.5}
$$

where  $a^{\dagger j} = a(^{t}(1,0))$  or  $a^{\dagger}(^{t}(1,0))$  and  $K_n(>0)$  satisfies  $\lim_{n\to\infty} K_{n+1}/K_n = 0$ .

(D) The form factors  $g_k$  are in  $\mathcal{D}(v_k) \cap \mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2}), k = 1, ..., N$ .

**Lemma 3.1.** If the form factors  $g_k$  and vectors  $\psi_k$  belong to  $\mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2})$ , then  $P_k e^{ith t}(c, \psi_1, \dots, \psi_N)$  is *in*  $\mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2})$  *for any t* ∈ R *and c* ∈ C, *k* = 1, ..., *N*, where  $P_k$  *is the projection from* K *onto*  $\mathcal{R}_k$ *.* 

**Proof.** For simplicity, we assume that  $t > 0$ . For any  $c \in \mathbb{C}$  and  $\psi_k \in \mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2}), k = 1, \ldots, N$ , we have that

$$
e^{ith}\left(\begin{array}{c} c \\ \psi \end{array}\right) = \sum_{n\geq 0} \lambda^n i^n \int_0^t dt_n \cdots \int_0^{t_2} dt_1 \alpha_{t_1}^0(V) \alpha_{t_2}^0(V) \cdots \alpha_{t_n}^0(V) e^{ith_0}\left(\begin{array}{c} c \\ \psi \end{array}\right)
$$
(3.6)

by Dyson series expansion, where  $\alpha_t^0(V) = e^{ith_0}Ve^{-ith_0}$ , *V* is the operator defined in [\(2.8\)](#page-3-0), and  $\psi = {}^t(\psi_1, \dots, \psi_N)$ . For  $n \geq 1$ , we obtain

$$
\alpha_{t_1}^0(V)\alpha_{t_2}^0(V)\cdots\alpha_{t_n}^0(V)e^{ith_0}\left(\begin{array}{c}c\\ \psi\end{array}\right)=\left(\left(\begin{array}{c}1\\ 0\end{array}\right),e^{-it_1h_0}\alpha_{t_2}^0(V)\cdots\alpha_{t_n}^0(V)e^{ith_0}\left(\begin{array}{c}c\\ \psi\end{array}\right)\right)e^{it_1h_0}\left(\begin{array}{c}0\\ g\end{array}\right)\\
+\left(\left(\begin{array}{c}0\\ g\end{array}\right),e^{-it_1h_0}\alpha_{t_2}^0(V)\cdots\alpha_{t_n}^0(V)e^{ith_0}\left(\begin{array}{c}c\\ \psi\end{array}\right)\right)e^{it_1h_0}\left(\begin{array}{c}1\\ 0\end{array}\right)\tag{3.7}

\left\| (e^{\beta_k h_{0,k}} - 1)^{-1/2} P_k e^{ith} \left( \begin{array}{c} c \\ \psi \end{array} \right) \right\| \leq \left\| (e^{\beta_k h_{0,k}} - 1)^{-1/2} \psi_k \right\| + \left\| (e^{\beta_k h_{0,k}} - 1)^{-1/2} g_k \right\| \left\| \left( \begin{array}{c} c \\ \psi \end{array} \right) \right\| \sum_{n \geq 1} \lambda^n \|V\|^{n-1} \frac{t^n}{n!}
$$

= \left\| (e^{\beta_k h_{0,k}} - 1)^{-1/2} \psi_k \right\| + \frac{e^{\lambda t \|V\|} - 1}{\|V\|} \left\| (e^{\beta_k h_{0,k}} - 1)^{-1/2} g_k \right\| \left\| \left( \begin{array}{c} c \\ \psi \end{array} \right) \right\| < \infty. \tag{3.9}
$$

This completes the proof of Lemma [3.1.](#page-15-0)  $\blacksquare$ 

**Remark 3.2.** *Note that*  $\mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2}) = \mathcal{D}((h_{0,k})^{-1/2})$ *. (cf. Paragraphs before* [\[8,](#page-19-1) Theorem 4.5]*.) In fact, we consider the continuous function*

$$
q(x) = \begin{cases} -\frac{1}{2} & x = 0\\ (e^x - 1)^{-1} - x^{-1} & x > 0 \end{cases}
$$
 (3.10)

*The function q is bounded on*  $[0, \infty)$  *and*  $(e^x - 1)^{-1} = q(x) + x^{-1}$ ,  $x \in (0, \infty)$ *. For any*  $\varepsilon > 0$ *, the following equation holds:*

$$
\left\langle \psi, (e^{\beta_k(h_{0,k}+\varepsilon)}-1)^{-1}\psi \right\rangle = \left\langle \psi, q(\beta_k(h_{0,k}+\varepsilon))\psi \right\rangle + \left\langle \psi, (\beta_k(h_{0,k}+\varepsilon))^{-1}\psi \right\rangle. \tag{3.11}

*If*  $\psi \in \mathcal{D}(e^{\beta_k h_{0,k}} - 1)^{-1/2}$ , then

 $By the boundedness of q, \lim_{\varepsilon \downarrow 0} \left\langle \psi, (\beta_k (h_{0,k} + \varepsilon))^{-1} \psi \right\rangle < \infty$ . Thus,  $\mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2}) \subset \mathcal{D}((h_{0,k})^{-1/2})$ . By similar discussion, we obtain  $\mathcal{D}((h_{0,k})^{-1/2}) \subset \mathcal{D}((e^{\beta h_{0,k}} - 1)^{-1/2})$ . As a consequence, we have that  $\mathcal{D}((e^{\beta_k h_{0,k}} - 1)^{-1/2}) =$  $\mathcal{D}((h_{0,k})^{-1/2}).$ 

We define the upper half-plane  $\mathbb{C}_+$  on  $\mathbb{C}$  by  $\mathbb{C}_+ := \{ z \in \mathbb{C} \mid \text{Im} z > 0 \}$  and the Hardy space  $\mathbb{H}^{\infty}(\mathbb{C}_+)$  on the upper half-plane defined by

$$

since  $\xi_l = g_l$  or  $h_{0,l}g_l$  and  $\langle g_l, (h_{0,l})^{-1}\xi_l \rangle$  is real valued. If  $\xi_l = g_l$  (resp.  $\xi_l = h_{0,l}g_l$ ), then we have the equation  $(4.6)$  (resp.  $(4.7)$ ).■

For each  $l = 1, \ldots, N$ , we define Josephson currents at NESS by

If  $\mu_l \neq 0$ , then  $\Theta_l \equiv 0$  and if  $\Theta_l \neq 0$ , then  $\mu_l = 0$ . Thus, the last term of [\(4.18\)](#page-13-1) is equal to zero. It follows that

Thus, we have done.

By the above proposition, the mean entropy production rate is independent of phase terms. Thus, Josephson currents  $\text{Jos}_l(\omega_+)$  may occur without entropy production, if the temperatures and the chemical potentials of reservoirs are identical.

For any  $k, l \in \{1, \ldots, N\}$ , the function

corresponds to the "total transmission probability" ([\[2\]](#page-19-3), [\[24\]](#page-20-10), and [\[25\]](#page-20-11)). As in [\[2\]](#page-19-3), we say that the channel  $k \rightarrow l$  is open if the set

has a positive Lebesgue measure. If  $\beta_k \neq \beta_l$  or  $\mu_k \neq \mu_l$ , then the function

is strictly positive for any finite interval. Thus, we obtain the following theorem.

**Theorem 4.3.** If there exists an open channel  $k \to l$  such that either  $\beta_k \neq \beta_l$  or  $\mu_k \neq \mu_l$  for some  $k, l \in \{1, ..., N\}$ , *then*  $Ep(\omega_+) > 0$ *.* 

# <span id="page-13-0"></span>5 Examples

In this section, we give calculations of currents on  $\mathbb{R}^d$  and graphs.

#### 5.1 *L* <sup>2</sup>( $\mathbb{R}^d$ ), *d*  $\geq$  3, case

In this subsection, we put  $\Re_k = L^2(\mathbb{R}^d)$ ,  $d \geq 3$ , for any  $k = 1, ..., N$ . The case that a model consists of a quantum particle and two reservoirs is calculated in [\[20\]](#page-20-12) and [\[21\]](#page-20-5). We consider the case of the number of reservoirs more than two and the case of phase terms different from [\[21\]](#page-20-5). The Hamiltonians *h*0,*<sup>k</sup>* are Fourier transform of positive Laplacian on  $L^2(\mathbb{R}^d)$ , i.e. the multiplication operator of  $|p|^2/2$ ,  $p \in \mathbb{R}^d$ . If  $g_k \in C_0^{\infty}(\mathbb{R}^d)$ and  $g_k$  are continuous with respect to |*x*| for any  $k = 1, ..., N$ , then  $g_k$  satisfies condition (A) and we have that

$$
\lim_{\varepsilon \searrow 0} \text{Im} \Big\langle g_k, (\nu - h_{0,k} - i\varepsilon)^{-1} g_k \Big\rangle = \begin{cases} C(d) \nu^{\frac{d-1}{2}} \Big| g(\sqrt{2\nu}) \Big|^2 & (\nu \ge 0) \\ 0 & (\nu < 0) \end{cases},\tag{5.1}
$$

where  $C(d)$  is the dimension dependent constant. Thus, we can find  $\lambda > 0$  and  $\Omega > 0$  such that the function  $\eta(z)$ , defined in [\(2.11\)](#page-3-2), satisfies condition (B). We fix such *g*,  $\lambda$ , and  $\Omega$ .

Since the form factors  $g_k$  are in  $C_0^{\infty}(\mathbb{R}^d)$ , there are compact sets  $K_k \subset \mathbb{R}^d$  such that supp $g_k \subset K_k$  for any  $k = 1, \ldots, N$ . Let  $\mathcal{K}_1$  and  $\mathcal{K}_2$  be the Hilbert spaces defined by

$$
\mathcal{K}_1 = \mathbb{C} \oplus \left( \bigoplus_{k=1}^N L^2(K_k) \right), \quad \mathcal{K}_2 = 0 \oplus \left( \bigoplus_{k=1}^N L^2(\mathbb{R}^d \setminus K_k) \right). \tag{5.2}
$$

Note that  $\mathcal{K} = \mathcal{K}_1 \oplus \mathcal{K}_2$ ,  $h \upharpoonright_{\mathcal{K}_2} = h_0 \upharpoonright_{\mathcal{K}_2}$ ,  $h\mathcal{K}_1 \subset \mathcal{K}_1$ , and  $h\mathcal{K}_2 \subset \mathcal{K}_2$ . As a consequence, we have that

on  $K_1 \oplus K_2$ . Since *h*  $\upharpoonright_{K_1}$  and *h*<sub>0</sub>  $\upharpoonright_{K_1}$  are bounded, we can use Lemma [2.4](#page-16-1) and obtain an explicit formula for  $e^{ith} \upharpoonright_{\mathcal{K}_1}$ .

For any  $\psi, \xi \in C_0^{\infty}(\mathbb{R}^d)$ , we have that  $(\psi, \xi)$ ,  $(\psi, g)$ , and  $(\xi, g)$  satisfy condition (Abs) by using Mourre estimate techniques. (See e.g. [\[24\]](#page-20-10) and [\[25\]](#page-20-11).) Since  $d \ge 3$ ,  $C_0^{\infty}(\mathbb{R}^d) \subset \mathcal{D}((h_{0,k})^{-1/2})$ . The PF weight for  $|x|^2/2$  is the delta function  $\delta(x)$ . We put  $\mathfrak{h} = \bigoplus_{k=1}^{N} C_0^{\infty}(\mathbb{R}^d)$ . For  $k = 1, ..., N$ , we set  $\mu_k = 0$  and

$$
\Theta_k^{(1)}(\alpha) = e^{i\tau_k} D_k^{1/2} \alpha + e^{-i\tau_k} D_k^{1/2} \overline{\alpha},\tag{5.4}
$$

$$
\Theta_k^{(2)}(\alpha) = s_{1,k} D_k^{1/2} \text{Re}\alpha + s_{2,k} D_k^{1/2} \text{Im}\alpha,\tag{5.5}

where  $\alpha \in \mathbb{C}$ ,  $\tau_k \in [0, 2\pi)$ ,  $D_k > 0$ ,  $s_1, s_2 \in \mathbb{R}$  and  $\overline{\alpha}$  is the complex conjugate for  $\alpha$ . The terms  $\Theta_k^{(1)}$  $\binom{1}{k}$  and  $\Theta_k^{(2)}$ *k* appear in a component of a factor decomposition of quasi-free states with BEC. (See [\[3,](#page-19-8) Section 5.2.5], [\[16,](#page-20-3) (1.18)], and [\[13,](#page-20-13) Theorem 4.5].) For  $\psi_k \in C_0^{\infty}(\mathbb{R}^d)$ , we define the initial states  $\omega_0^{(1)}$  $\omega_0^{(1)}$  and  $\omega_0^{(2)}$  $_0^{(2)}$  by

We assume that  $\omega_0^{(1)}$  $\omega_0^{(1)}$  and  $\omega_0^{(2)}$ <sup>(2)</sup> satisfy condition (C). Since the vectors  $g, \psi \in \mathfrak{h}$  satisfy conditions (Abs), (A), (B), and (D), there are  $\omega_+^{(1)}$  and  $\omega_+^{(2)}$  and we have that

#### 5.2 Graphs

In this subsection, we give calculations of currents on periodic graphs and comb graphs. To verify our condi-tions for the adjacency operators of undirected graphs, we apply results of M. Măntoiu et al. [\[15\]](#page-20-6).

Let  $G = (VG, EG)$  be an undirected graph, where  $VG$  is the set of vertices in  $G$  and  $EG$  is the set of edges in *G*. Two vertices *x*, *y* ∈ *VG* are said to be adjacent, if there exists an edge  $(x, y)$  ∈ *EG* joining *x* and *y*, and we write *x* ∼ *y*. For any *x* ∈ *VG*, we denote the degree of vertex *x* ∈ *VG* by deg<sub>*G*</sub>(*x*), i.e.

$$
\deg_G(x) = \sharp \{ y \in VG \mid (x, y) \in EG \},\tag{5.10}
$$

and

$$
\deg_G := \sup_{x \in VG} \deg_G(x). \tag{5.11}
$$

In this paper, we assume that *G* is connected with no loops and with no multiple edges, *VG* is a countable set, and deg<sub>*G*</sub> <  $\infty$ . Let  $\ell^2(VG)$  be the set of square summable sequence labeled by the vertices in *VG*. Let  $A_G$  be the adjacency operator of *G* defined by

$$
\langle \delta_x, A_G \delta_y \rangle = \begin{cases} 1 & \text{if } (x, y) \in EG \\ 0 & \text{if } (x, y) \notin EG \end{cases} . \tag{5.12}
$$

#### 5.2.1 Adapted Graphs

We recall the definition of adapted graphs introduced in [\[15\]](#page-20-6). For any  $x \in VG$ , we denote the set of neighbors of *x* by  $N_G(x)$ , i.e.  $N_G(x) := \{ y \in VG \mid (x, y) \in EG \}.$ 

<span id="page-15-0"></span>**Definition 5.1.** ([\[15,](#page-20-6) Definition 3.1.]) *A function*  $\Phi : G \to \mathbb{R}$  *is adapted to the graph G if the following conditions hold:*

- (i) *There exists c*  $\geq 0$  *such that*  $|\Phi(x) \Phi(y)| \leq c$  *for any*  $x, y \in VG$  *with*  $(x, y) \in EG$ .
- (ii) *For any x, y*  $\in$  *VG, one has*

$$
\sum_{z \in N(x) \cap N(y)} \{2\Phi(z) - \Phi(x) - \Phi(y)\} = 0.
$$

(iii) *For any x, y*  $\in$  *VG, one has* 

$$
\sum_{z \in N(x) \cap N(y)} \{ \Phi(z) - \Phi(x) \} \{ \Phi(z) - \Phi(y) \} \{ 2\Phi(z) - \Phi(x) - \Phi(y) \} = 0.

*A pair* (*G*, Φ) *is said to be adapted if* Φ *is adapted to G.*

Let  $(G, \Phi)$  be an adapted graph. We define the unbounded multiplication operator  $\Phi$  on  $\ell^2(VG)$  by  $(\Phi f)(x)$  =  $\Phi(x)f(x)$ ,  $x \in VG$ , where  $f \in \ell^2(VG)$  with  $\sum_{x \in VG} \Phi(x)^2 |f(x)|^2 < \infty$ . We denote the domain of  $\Phi$  by  $\mathcal{D}(\Phi)$ . We define the operator *K* on  $\ell^2(VG)$  by

$$
(K\xi)(x) := i \sum_{y \in N(x)} {\{\Phi(y) - \Phi(x)\}\xi(y), \quad \xi \in \ell^2(VG), \quad x \in VG.}
$$
 (5.15)

The operator *K* is self-adjoint and bounded by condition (i) in Definition [5.1.](#page-15-0) Note that *K* and  $A_G$  are commute. Since *K* is self-adjoint, we have that the orthogonal decomposition of  $\ell^2(VG)$  by

<span id="page-15-2"></span>
$$
\ell^2(VG) = \ker K \oplus \overline{\text{ran}K},\tag{5.16}
$$

where ran*K* is the range of *K*. We denote the restriction of  $A_G$  onto ran*K* by  $A_{G,0}$ .

<span id="page-15-1"></span>Theorem 5.2. [\[15,](#page-20-6) Theorem 3.3] *Let* (*G*, Φ) *be an adapted graph.*

(i) *For any*  $\xi \in \text{ran} K \cap \mathcal{D}(\Phi)$ *, there exists a constant c<sub>* $\xi$ *</sub> > 0 such that* 

$$
\sup_{\mu \in \mathbb{R}, \varepsilon > 0} \left| \left\langle \xi, (\mu - A_{G,0} \pm i\varepsilon)^{-1} \xi \right\rangle \right| \le c_{\xi}.
$$
\n(5.17)

(ii) *The operator AG*,<sup>0</sup> *has purely absolutely continuous spectrum.*

#### 5.2.2 Radon–Nikodym Derivative for the Spectral Measure of the Adjacency Operators

In this subsection, we collect facts of the Radon–Nikodym derivative of the adjacency operator of an adapted graph  $(G, \Phi)$ . We use the same notation in the above subsection. By Theorem [5.2,](#page-15-1) we have the following lemma:

<span id="page-16-0"></span>**Lemma 5.3.** *Let*  $(G, \Phi)$  *be an adapted graph. Then for any*  $\xi, \zeta \in \text{ran}K \cap \mathcal{D}(\Phi)$ *, there exists*  $c_{\xi, \zeta} > 0$  *such that* 

$$
\sup_{\mu \in \mathbb{R}, \varepsilon > 0} \left| \left\langle \xi, (\mu - A_{G,0} \pm i\varepsilon)^{-1} \zeta \right\rangle \right| < c_{\xi,\zeta}.\tag{5.18}
$$

Proof. By polarization identity, we have that

$$
4\langle \xi, (\mu - A_{G,0} \pm i\varepsilon)^{-1} \zeta \rangle = \sum_{k=0}^{3} (-i)^k \langle (\xi + i^k \zeta), (\mu - A_{G,0} \pm i\varepsilon)^{-1} (\xi + i^k \zeta) \rangle.
$$
 (5.19)

Since  $\xi + i^k \zeta \in \text{ran} K \cap \mathcal{D}(\Phi)$ , we obtain the statement by Theorem [5.2.](#page-15-1)

By the above lemma, for any  $\zeta, \xi \in \text{ran} K \cap \mathcal{D}(\Phi)$ , the function  $\langle \xi, (z - A_{G,0})^{-1} \zeta \rangle$  is in  $\mathbb{H}^{\infty}(\mathbb{C}_{+})$ .

<span id="page-16-1"></span>**Lemma 5.4.** For any  $\xi, \zeta \in \text{ran} K \cap \mathcal{D}(\Phi)$ , the function  $f_{\xi,\zeta}(z) := \langle \xi, (z - A_{G,0})^{-1} \zeta \rangle$  is in  $\mathbb{H}^{\infty}(\mathbb{C}_{+})$ . Moreover, for *Lebesgue a.e*  $x \in \mathbb{R}$ *, the limit* 

$$
f_{\xi,\zeta}^+(x) := \lim_{\varepsilon \searrow 0} f_{\xi,\zeta}(x + i\varepsilon) \tag{5.20}
$$

*exists and*  $f^+_{\xi,\zeta} \in L^\infty(\mathbb{R}, dx)$ *.* 

**Proof.** Since  $A_{G,0}$  is self-adjoint,  $f_{\xi,\zeta}$  is holomorphic in  $\mathbb{C}_+$ . By [\[11,](#page-20-9) Theorem 3.13] and Lemma [5.3,](#page-16-0) we have the statement.

For any  $\xi, \zeta \in \text{ran}K \cap \mathcal{D}(\Phi)$ , there exists the Radon–Nikodym derivative  $d\langle \xi, E(\nu)\zeta \rangle / d\nu$ , where *E* is the spectral measure of *AG*,0.

**Lemma 5.5.** *For any*  $\xi$ ,  $\zeta \in \text{ran}K \cap D(\Phi)$ , *Radon–Nikodym derivative d* $\langle \xi, E(\nu)\zeta \rangle / dv$  *exists and is in*  $L^p(\mathbb{R})$  *for any*  $p \in \mathbb{N} \cup \{\infty\}$ *. Moreover,*  $d\langle \xi, E(\nu)\zeta \rangle / d\nu$  *is given by* 

$$
\frac{d\langle \xi, E(\nu)\zeta \rangle}{d\nu} = \lim_{\varepsilon \searrow 0} \frac{1}{\pi} \Big\{ \Big\langle \xi, (\nu - A_{G,0} - i\varepsilon)^{-1} \zeta \Big\rangle - \Big\langle \xi, (\nu - A_{G,0} + i\varepsilon)^{-1} \zeta \Big\rangle \Big\} \tag{5.21}
$$

*for Lebesgue a.e.*  $v \in \mathbb{R}$ *. The support of the function*  $d\langle \xi, E(v)\zeta \rangle/dv$  *is contained in the set of the spectrum of*  $A_{G,0}$ .

**Proof.** Since the measure  $d\langle \xi, E(\lambda)\zeta \rangle$  is a finite complex measure and absolutely continuous with respect to Lebesgue measure, by Radon–Nikodym theorem (see e.g. [\[18,](#page-20-14) 6. 10]), the Radon–Nikodym derivative  $d\langle \xi, E(\nu)\zeta \rangle / d\nu$  is in *L*<sup>1</sup>(ℝ). Note that for Lebesgue a.e.  $\nu \in \mathbb{R}$ ,

$$
\frac{d\langle \xi, E(\nu)\zeta \rangle}{d\nu} = \frac{1}{\pi} \lim_{\varepsilon \searrow 0} \left\{ \langle \xi, (\nu - A_{G,0} - i\varepsilon)^{-1}\zeta \rangle - \langle \xi, (\nu - A_{G,0} + i\varepsilon)^{-1}\zeta \rangle \right\}
$$
(5.22)

by [\[11,](#page-20-9) Theorem 4.15] and polarization identity. Since  $\langle \xi, (\nu - A_{G,0} \pm i0)^{-1} \zeta \rangle$  is in *L*<sup>∞</sup>(R) by Lemma [5.4,](#page-16-1)  $d\langle \xi, E(\nu)\zeta \rangle / d\nu$  is in  $L^p(\mathbb{R})$  for any  $p \in \mathbb{N} \cup \{\infty\}$ . If  $\nu \notin [-||A_G||, ||A_G||]$ , i.e.  $\nu$  is in the resolvent set of  $A_{G,0}$ , then  $(\nu - A_{G,0})^{-1}$  is bounded, and

$$
\lim_{\varepsilon \to 0} (\nu - A_{G,0} \pm i\varepsilon)^{-1} = (\nu - A_{G,0})^{-1}
$$
\n(5.23)

in norm sense. Thus, we have the statement.

# **5.2.3**  $\mathbb{Z}^d, d \ge 3$ , case

In this subsection, we consider  $\mathbb{Z}^d$ ,  $d \ge 3$ , as graphs. We note that  $\mathbb{Z}^d$  has an adapted function  $\Phi$  defined by

<span id="page-16-2"></span>
$$
\Phi((x_1, \dots, x_d)) = \sum_{k=1}^d x_k,
$$
\n(5.24)

where  $x_k \in \mathbb{Z}$ . Then the operator *K* defined in [\(5.15\)](#page-15-2) has the form of

$$
K\delta_x = i \sum_{k=1}^d (\delta_{x-e_k} - \delta_{x+e_k}), \qquad (5.25)
$$

where  $x \in \mathbb{Z}^d$  and  $e_k$  is the element of  $\mathbb{Z}^d$  and the *k*-th component of  $e_k$  is equal to 1 and otherwise equal to 0. We put  $\Re_k = \ell^2(\mathbb{Z}^d)$ ,  $h_{0,k} = ||A_{\mathbb{Z}^d}|| \mathbb{1} - A_{\mathbb{Z}^d}$ , and

$$
\mathfrak{h}_k := \operatorname{span}\{e^{ith_{0,k}}\delta_x \mid t \in \mathbb{R}, x \in \mathbb{Z}^d\}
$$
\n
$$
(5.26)
$$

for any  $k = 1, \ldots, N$ . For example, we set

$$
g_k = K\delta_{x_k} = i \sum_{j=1}^d (\delta_{x_k - e_j} - \delta_{x_k + e_j})
$$
\n(5.27)

for some  $x_k \in \mathbb{Z}^d$ . By Theorem [5.2,](#page-15-1)  $g_k$  satisfies condition (A). Using the Fourier transformation, we have that

$$
\lim_{\varepsilon \searrow 0} \text{Im} \Big\{ g_k, (\nu - h_{0,k} - i\varepsilon)^{-1} g_k \Big\} = (2\pi)^{-d/2} \pi \int_{\mathbb{T}^d} \delta(\nu - \sum_{j=1}^d \sin^2(\theta_j/2)) \left| \sum_{j=1}^d \sin \theta_j \right|^2 d\theta. \tag{5.28}
$$

We put  $\lambda^2 > 0$  such that  $\lambda^2 C_g < 1$  and there exists  $\Omega \in (0, ||h_{0,0}||)$  such that the right hand side of [\(5.28\)](#page-17-0) has some strictly positive lower bound for any  $v \in [\Omega - \lambda^2 C_g, \Omega + \lambda^2 C_g]$ . Thus, condition (B) are satisfied. Since  $h_{0,k}$  are transient, i.e.

<span id="page-17-0"></span>
$$
\sup_{x \in \mathbb{Z}^d} \left\langle \delta_x, (h_{0,k})^{-1} \delta_x \right\rangle < \infty,\tag{5.29}
$$

by *d* ≥ 3, the form factor *g* satisfies condition (D). Note that  $\bigoplus_{k=1}^{N} (\mathfrak{h}_k \cap \text{ran} K) \subset \mathfrak{h}(g)$  by Lemma [5.3,](#page-16-0) where  $h(g)$  is the set defined in [\(2.14\)](#page-3-3). For an initial state  $\omega_0$  with condition (C) and with the form of [\(3.3\)](#page-7-0), there exists NESS  $\omega_+$  which is a state on  $W(\mathfrak{k}, \sigma)$ , where  $\mathfrak{k} = \mathbb{C} \oplus \left( \bigoplus_{k=1}^N (\mathfrak{h}_k \cap \text{ran} K) \right)$ . If the PF weight *v* is defined by  $v(x) = 1$  for any  $x \in \mathbb{Z}^d$ , then  $\langle v_k, g_k \rangle = 0$  for any  $k = 1, ..., N$ . Thus,  $\text{Jos}_l(\omega_+) = 0$  for any  $l = 1, ..., N$ .

#### 5.2.4 Regular Admissible Graphs

A graph *G* is called regular, if for any  $x, y \in VG$ ,  $\deg_G(x) = \deg_G(y)$ . Recall the definition of admissible graphs (cf.  $[15]$ ). In this subsection, we assume that *G* is deduced from a directed graph, i.e., some relation < is given on *G* such that, for any  $x, y \in VG$ ,  $x \sim y$  is equivalent to  $x \lt y$  or  $y \lt x$ , and one can not both  $y \lt x$  and  $x \lt y$ . We also write  $y > x$  for  $x < y$ . Then for any  $x \in VG$ , the neighbor of  $x, N_G(x)$ , decompose into a disjoint union  $N_G(x) = N_G^+$  $G_G^+(x) \cup N_G^-(x)$ , where

$$
N_G^+(x) := \{ y \in VG \mid x < y \}, \quad N_G^-(x) := \{ y \in VG \mid y < x \}. \tag{5.30}
$$

When directions have been fixed, we use the notation  $(G, \lt)$  for the directed graph and say that  $(G, \lt)$  is subjacent to *G*.

Let  $p = x_0 x_1 \cdots x_n$  be a path. We define the index of path *p* by

$$
\text{ind}(p) := \left| \{ j \mid x_{j-1} < x_j \} \right| - \left| \{ j \mid x_{j-1} > x_j \} \right| \tag{5.31}
$$

Definition 5.6. [\[15,](#page-20-6) Definition 5.1] *A directed graph* (*G*, <) *is called admissible if*

(i) *It is univoque, i.e., any closed path in G has index zero.*

(ii) *It is uniform, i.e., for any*  $x, y \in X$ *,*  $\sharp \left(N_G^{-}(x) \cap N_G^{-}(y)\right) = \sharp \left(N_G^{+}(x) \cap N_G^{-}(y)\right)$  $G$ <sup>+</sup> $(G)$  ∩  $N_G^+$  $G^+(y)$ .

*A graph G is called admissible if there exists an admissible directed graph* (*G*, <) *subjacent to G.*

**Definition 5.7.** [\[15,](#page-20-6) Definition 5.2] *A position function on a directed graph*  $(G, \leq)$  *is a function*  $\Phi : G \to \mathbb{Z}$ *satisfying*  $\Phi(x) + 1 = \Phi(y)$  *if*  $x < y$ .

Lemma 5.8. [\[15,](#page-20-6) Lemma 5.3]

(i) A directed graph  $(G, \leq)$  is univoque if and only if it admits a position function.

(ii) *Any position function on an admissible graph G is surjective.*

(iii) *A position function on a directed graph G is unique up to constant.*

Remark 5.9. *If G is an admissible graph, then there exists a position function* Φ*. The function* Φ *satisfies Definition [5.1.](#page-15-0) Thus, an admissible graph is an adapted graph as well.*

Remark 5.10. *When G is an infinite regular graph, we only consider the PF weight v for the adjacency operator*  $A_G$  *defined by*  $v(x) = 1$  *for any*  $x \in VG$ .

<span id="page-18-1"></span>**Proposition 5.11.** *Let G be an admissible regular graph. Assume that*  $g \in \mathfrak{h} \cap \text{ran} K$ , where  $\mathfrak{h}$  *is defined by* 

$$
\mathfrak{h} := \operatorname{span}\left\{ e^{it(\|A_G\| \mathbb{1} - A_G)} \delta_x \mid x \in VG, t \in \mathbb{R} \right\}.
$$
\n
$$
(5.32)
$$

*Then*  $\langle v, g \rangle = 0$ *.* 

**Proof.** Note that  $\mathfrak{h} \subset \mathcal{D}(\mathfrak{v})$  by [\[8,](#page-19-1) Theorem 4.5]. Since  $g \in \mathfrak{h} \cap \text{rank}$ , there exists  $\zeta \in \ell^2(VG)$  such that  $g = K\zeta$ , where  $K$  is the operator defined in  $(5.15)$ . Then the vector  $g$  has the form of

<span id="page-18-0"></span>
$$
\langle \delta_x, g \rangle = i \sum_{y \in N_G^+(x)} \zeta(y) - i \sum_{y \in N_G^-(x)} \zeta(y), \tag{5.33}
$$

where  $\zeta(y) = \langle \delta_y, \zeta \rangle$ . Then we have that

$$
\langle v, g \rangle = i \left\{ \sum_{x \in VG} \sum_{y \in N_G^+(x)} \zeta(y) - \sum_{x \in VG} \sum_{y \in N_G^-(x)} \zeta(y) \right\} = 0. \tag{5.34}
$$

Thus, we have done.

By the above proposition, we have the following theorem:

**Theorem 5.12.** Let  $G_k$ ,  $k = 1, ..., N$ , be admissible regular graphs. Fix  $g \in \bigoplus_{k=1}^{N} (b_k \cap \text{ran} K_k)$ , where  $h_k$  *are defined in* [\(5.32\)](#page-18-0) *and K<sub>k</sub> are the operators defined in* [\(5.15\)](#page-15-2)*. For any k* = 1,...,*N*, *we assume that*  $h_{0,k} = ||A_{G_k}|| \mathbb{1} - A_{G_k}$  is transient, there exist  $\Omega, \lambda > 0$  such that the function  $\eta(z)$  defined in [\(2.11\)](#page-3-2) satisfies<br>condition (B) and the initial state  $\omega_k$  satisfies condition (C). Then there exists NESS  $\omega_k$  wh *condition* (B), and the initial state  $\omega_0$  satisfies condition (C). Then there exists NESS  $\omega_+$  which is a state on  $W(\mathfrak{k}, \sigma)$ , where  $\mathfrak{k} = \mathbb{C} \oplus \bigoplus_{k=1}^N (\mathfrak{h}_k \cap \text{ran} K_k)$ . Moreover, for any  $l = 1, ..., N$ , we have that

$$
\omega_{+}(J_{l})=2\pi\lambda^{4}\sum_{k=1}^{N}\int_{\sigma_{l}}\frac{1}{|\eta_{-}(\nu)|^{2}}(N_{l}(\nu)-N_{k}(\nu))\frac{d\langle g_{k},E_{k}(\nu)g_{k}\rangle}{d\nu}d\langle g_{l},E_{l}(\nu)g_{l}\rangle,
$$
(5.35)

*where J<sup>l</sup> is defined in* [\(4.1\)](#page-11-3)*.*

**Proof.** By assumptions, Theorem [3.3,](#page-16-0) Corollary [4.1,](#page-15-0) and Proposition [5.11,](#page-18-1) we have the statement.

#### 5.3 Comb Graphs

In this subsection, we consider typical example of non-regular graphs: comb graphs. BEC on comb graphs studied in [\[6\]](#page-19-9), [\[7\]](#page-19-0), and [\[8\]](#page-19-1). In [\[6\]](#page-19-9), R. Burioni et al. calculated the spectral measure of the adjacency operators of comb graphs  $\mathbb{Z}^d$  +  $\mathbb{Z}$ . Using their results, we calculate currents on comb graphs. First, we recall the definition of comb graphs.

**Definition 5.13.** Let  $G_1$  and  $G_2$  be graphs, and let  $o \in VG_2$  be a given vertex. Then the comb product  $X := G_1 + (G_2, o)$  *is a graph with vertex*  $V X := V G_1 \times V G_2$ *, and*  $(g_1, g_2)$ *,*  $(g'_1, g'_2) \in V X$  *are adjacent if and only if*  $g_1 = g'_1$  and  $g_2 \sim g'_2$  *or*  $g_2 = g'_2 = o$  and  $g_1 \sim g'_1$ . We call  $G_1$  the base graph, and  $G_2$  the fiber graph. When  $o \in VG_2$  *is understood from the context, we omit it, and write*  $G_1 \dashv G_2$ .

We consider the graphs  $G_d := \mathbb{Z}^d + (\mathbb{Z}, 0), d \geq 3$ . As the case of  $\mathbb{Z}^d$ , the function  $\Phi$  defined in [\(5.24\)](#page-16-2) is adapted to  $G_{d-1}$ . Put  $h_{0,l} = ||A_{G_d}|| ||1 - A_{G_d}$  for any  $l = 1, ..., N$ . For  $J \in \mathbb{Z}^d$  and  $x \in \mathbb{Z}$ , the operators  $K_l$ ,  $l = 1, \ldots, N$ , have the form of

$$
K\delta_{J,x} = \begin{cases} i\delta_{J,x-1} - i\delta_{J,x+1} & (x \neq 0) \\ i\sum_{l=1}^{d} (\delta_{J-e_l,x} - \delta_{J+e_l,x}) + i\delta_{J,-1} - i\delta_{J,1} & (x = 0) \end{cases}
$$
(5.36)

Put  $g_l = K \delta_{J_l, x_l}$ ,  $l = 1, ..., N$ , where  $J_l \in \mathbb{Z}^d$  and  $x_l \in \mathbb{Z}$  with  $|x_l| >> 1$ . Then, by Theorem [5.2](#page-15-1) and [\[7,](#page-19-0) Theorem 10.14], the form factor *g* satisfies conditions (A) and (D). By [\[7,](#page-19-0) Lemma 9.4], a PF weight *v* has the following form:

$$
v(J, x) = \frac{e^{-|x|\theta_d}}{2\left\|(2\sqrt{d^2 + 1} - A_{\mathbb{Z}})^{-1}\delta_0\right\|\sinh\theta_d}, \quad J \in \mathbb{Z}^d, \quad x \in \mathbb{Z},
$$
\n(5.37)

with  $2 \cosh \theta_d = 2 \sqrt{d^2 + 1}$ . Another example of *v* is given in [\[8\]](#page-19-1). The form of the spectral measure of  $A_{G_d}$  is in [\[6\]](#page-19-9). Thus, we can find  $\Omega$ ,  $\lambda > 0$  which satisfy condition (B).

The pairing of  $g_l$  and the PF weight  $v_l = v$  has the form of

$$
\langle v, g_l \rangle = i \frac{e^{-|x_l - 1|\theta_d}}{2 \left\| (2\sqrt{d^2 + 1} - A_{\mathbb{Z}})^{-1} \delta_0 \right\| \sinh \theta_d} - i \frac{e^{-|x_l + 1|\theta_d}}{2 \left\| (2\sqrt{d^2 + 1} - A_{\mathbb{Z}})^{-1} \delta_0 \right\| \sinh \theta_d}
$$
  
=  $i \frac{e^{-|x_l|\theta_d}}{\left\| (2\sqrt{d^2 + 1} - A_{\mathbb{Z}})^{-1} \delta_0 \right\|}.$  (5.38)

Thus, we define the initial states  $\omega_0^{(1)}$  $_{0}^{(1)}$  and  $\omega_{0}^{(2)}$  with condition (C) by

$$
\omega_0^{(1)}(W((\psi_k))) = \exp\left\{-\frac{1}{4}\left\langle\psi_k, (e^{\beta_k h_{0,k}} - 1)^{-1}\psi_k\right\rangle + i\Theta_k^{(1)}(\langle v_k, \psi_k \rangle)\right\},\tag{5.39}
$$

$$
\omega_0^{(2)}(W((\psi_k))) = \exp\left\{-\frac{1}{4}\left\langle\psi_k, (e^{\beta_k h_{0,k}} - 1)^{-1}\psi_k\right\rangle + i\Theta_k^{(2)}(\langle v_k, \psi_k \rangle)\right\}
$$
(5.40)

for  $\psi_k \in \mathfrak{h}_k \cap \text{rank}$ , where  $\Theta_k^{(1)}$ <sup>(1)</sup> defined in [\(5.4\)](#page-14-0) and  $\Theta_k^{(2)}$  $\bigoplus_{k}^{(2)}$  defined in [\(5.5\)](#page-14-1). Note that  $\mathfrak{k} := \bigoplus_{k=1}^{N} (\mathfrak{h}_k \cap \text{rank}) \subset \mathfrak{h}(g)$ by Lemma [5.3.](#page-16-0) Thus, there exists NESS  $\omega_+$ , which is a state on  $W(\mathfrak{k}, \sigma)$ . If the temperatures are identical, then Josephson currents have the form of

$$
\omega_{+}^{(1)}(J_{l}) = \text{Jos}_{l}(\omega_{+}^{(1)}) = \frac{4\pi^{3}\lambda^{2}}{\eta(0)} \sum_{k=1}^{N} D_{k}^{1/2} D_{l}^{1/2} \sin(\tau_{k} - \tau_{l}) \frac{e^{-(|x_{k}| + |x_{l}|)\theta_{d}}}{\left\| (2\sqrt{d^{2} + 1} - A_{\mathbb{Z}})^{-1} \delta_{0} \right\|^{2}},
$$
\n(5.41)

$$
\omega_{+}^{(2)}(J_{l}) = \text{Jos}_{l}(\omega_{+}^{(2)}) = \frac{\pi^{3} \lambda^{2}}{\eta(0)} \sum_{k=1}^{N} D_{k}^{1/2} D_{l}^{1/2} \{s_{1,k} s_{2,l} - s_{1,l} s_{2,k}\} \frac{e^{-(|x_{k}| + |x_{l}|)\theta_{d}}}{\left\| (2\sqrt{d^{2} + 1} - A_{\mathbb{Z}})^{-1} \delta_{0} \right\|^{2}}.
