The asymptotic behavior of primitive equations with multiplicative noise [∗]

Abstract

This paper is concerned with the existence of invariant measure for 3D stochastic primitive equations driven by linear multiplicative noise under non-periodic boundary conditions. The common method is to apply Sobolev imbedding theorem to proving the tightness of the distribution of the solution. However, this method fails because of the non-linearity and non-periodic boundary conditions of the stochastic primitive equations. To overcome the difficulties, we show the existence of random attractor by proving the compact property and the regularity of the solution operator. Then we show the existence of invariant measure.

1 Introduction

The paper is concerned with the stochastic primitive equations (PEs) in a cylindrical domain

The unknowns for the 3D stochastic PEs are the fluid velocity field $(v, w) = (v_1, v_2, w) \in \mathbb{R}^3$ with $v = (v_1, v_2)$ and $v^{\perp} = (-v_2, v_1)$ being horizontal, the temperature T and the pressure p . $f = f_0(\beta +$ y) is the given Coriolis parameter, Q is a given heat source. $\nabla = (\partial_x, \partial_y)$ is the horizontal gradient operator and $\Delta = \partial_x^2 + \partial_y^2$ is the horizontal Laplacian. Let $\alpha_i, \beta_i \in \mathbb{R}, i = 1, 2, \dots, n$, $\{w_i^1, w_i^2, i = 1, 2, \dots, n\}$ $1, 2...n$ } be a sequence of one-dimensional, independent, identically distributed Brownian motions. Here, we take $\sum_{k=1}^{n} \alpha_k v \circ dw_k^1$ and $\sum_{k=1}^{n} \beta_k T \circ dw_k^2$ to be Stratonovich multiplicative noise.

The viscosity and the heat diffusion operators L_1 and L_2 are given by

where ν_1, μ_1 are the horizontal and vertical Reynolds numbers and ν_2, μ_2 are the horizontal and vertical heat diffusivity. Without loss of generality, we assume that

The boundary of $\mathcal O$ is partitioned into three parts: $\Gamma_u \cup \Gamma_b \cup \Gamma_s$, where

Here h is a sufficiently smooth function. Without loss of generality, we assume $h = 1$.

We impose the following boundary conditions on the 3D stochastic PEs.

where $\eta(x, y)$ is the wind stress on the surface of the ocean, γ is a positive constant, τ is the typical temperature distribution on the top surface of the ocean and \vec{n} is the norm vector to Γ_s. For the sake of simplicity, we assume that Q is independent of time and $\eta = \tau = 0$. It is worth pointing out that all results obtained in this paper are still valid for the general case by making some simple modifications.

Integrating (1.3) from -1 to z and using (1.5) , (1.6) , we have

The primitive equations are the basic model used in the study of climate and weather prediction, which can be used to describe the motion of the atmosphere when the hydrostatic assumption is enforced (see [\[15,](#page-24-0) [19,](#page-24-1) [20\]](#page-25-0) and the references therein). This model has been intensively investigated because of the interests stemmed from physics and mathematics. As far as we know, their mathematical study was initiated by Lions, Temam and Wang (see e.g. [\[25,](#page-25-1) [26,](#page-25-2) [27,](#page-25-3) [28\]](#page-25-4)). For example, the existence of global weak solutions for the primitive equations was established in [\[26\]](#page-25-2). Guillén-González et al. obtained the global existence of strong solutions to the primitive equations with small initial data in [\[18\]](#page-24-2). The local existence of strong solutions to the primitive equations under the small depth hypothesis was established by Hu et al. in [\[21\]](#page-25-5). Cao and Titi developed a beautiful approach to dealing with the L^6 -norm of the fluctuation \tilde{v} of horizontal velocity and obtained the global well-posedness for the 3D viscous primitive equations in [\[9\]](#page-24-3). Subsequently, in [\[23\]](#page-25-6), Kukavica and Ziane developed a different method to handle non-rectangular domains and boundary conditions with physical reality. The existence of the global attractor was established by Ju in [\[22\]](#page-25-7). For the global well-posedness of 3D primitive equations with partial dissipation, we refer the reader to some papers, see e.g. [\[5](#page-24-4), [6](#page-24-5), [7](#page-24-6), [8](#page-24-7), [10\]](#page-24-8).

Along with the great successful developments of deterministic primitive equations, the random case has also been developed rapidly. In [\[16\]](#page-24-9), Guo and Huang obtained some kind of weak type compactness properties of the strong solution under the condition that the momentum equation is driven by an additive stochastic forcing and the thermodynamical equation is driven by a deterministic heat source. Debussche, Glatt-Holtz, Temam and Ziane concerned the global well-posedness of strong solution when the primitive equations are driven by multiplicative stochastic forcing in [\[12\]](#page-24-10). The ergodic theory and large deviations for the 3D stochastic primitive equations were studied by Dong, Zhai and Zhang in [\[13,](#page-24-11) [14\]](#page-24-12). When the primitive equations are driven by an infinitedimensional fractional noise taking values in some Hilbert space, the latter author of this paper obtained the existence of random attractor in [\[30\]](#page-25-8). Under the periodic conditions, Glatt-Holtz, Kukavica, Vicol and Ziane constructed an invariant measure for the 3D PEs in [\[17\]](#page-24-13), where some delicate and careful techniques are involved. However, it seems that in their paper, the conditions on the noise don't cover the linear multiplicative noise.

In this article, we aim to prove the existence of invariant measures for 3D stochastic PEs driven by linear multiplicative noise under non-periodic boundary conditions. The common method is to apply Krylov-Bogoliubov lemma (see [\[11\]](#page-24-14)) which requires a uniform estimates with respect to the initial data in $H^2(\mathcal{O})$. However, it is quite difficult because of highly non-linear drift terms and non-periodic boundary conditions. Instead of using that method, we provide a new method to find a compact absorbing set in $H^1(\mathcal{O})$, which guarantees the existence of random attractor in $H^1(\mathcal{O})$. The main idea is that we firstly prove the solution operator of 3D stochastic PEs is compact in $H^1(\mathcal{O})$, P-a.s.. Then we can construct a compact absorbing ball in $H^1(\mathcal{O})$ by the compact property of solution operator. It's important to point out that the random attractor we obtained is stronger than that in [\[16\]](#page-24-9). Specifically, the random attractor we obtain is compact in $H^1(\mathcal{O})$, P-a.s. and attracts any orbit starting from $-\infty$ in the strong topology of $H^1(\mathcal{O})$ while the random attractor in [\[16\]](#page-24-9) is not necessarily a compact subset in $H^1(\mathcal{O})$. In addition, the linear multiplicative noise as well as non-periodic boundary conditions are handled at the same time in this paper, which are different from [\[17\]](#page-24-13).

Taking into account the asymptotical compact property of the solution operator, we can prove the existence of invariant measures by showing that the one-point motions associated with the flow generated by 3D PEs define a family of Markov processes. Up to now, there are no works on the

existence of invariant measures for the stochastic PEs subject to non-periodic boundary conditions. Maybe it is an attempt to solve this problem by proving the asymptotic compact property of the solution operator.

The remaining of this paper is organized as follows. In section 2, some preliminaries of 3D stochastic primitive equations are stated. In section 3, the global well-posedness of 3D stochastic primitive equations is proved. In section 4, we establish the existence of random attractor. Finally, in section 5, the existence of invariant measures for 3D stochastic primitive equations is obtained. As usual, constants C may change from one line to the next, unless, we give a special declaration. Denote by $C(a)$ a constant which depends on some parameter a.

2 Preliminaries

For $1 \leq p \leq \infty$, let $L^p(\mathcal{O}), L^p(M)$ be the usual Lebesgue spaces with the norm

In particular, $|\cdot|$ and (\cdot, \cdot) represent norm and inner product of $L^2(\mathcal{O})$ (or $L^2(M)$), respectively. For $m \in \mathbb{N}_+$, $(W^{m,p}(\mathcal{O}), \|\cdot\|_{m,p})$ stands for the classical Sobolev space, see [\[1\]](#page-24-15). When $p=2$, we denote by $H^m(\mathcal{O}) = W^{m,2}(\mathcal{O})$ with norm $\|\cdot\|_m$. Without confusion, we shall sometimes abuse notation and denote by $\|\cdot\|_m$ the norm in $H^m(M)$. Let

3 Global well-posedness of [\(1.9\)](#page-1-1)-[\(1.14\)](#page-2-0)

In this section, we aim to prove the global well-posedness of $(1.9)-(1.14)$ $(1.9)-(1.14)$ $(1.9)-(1.14)$. Firstly, we introduce the following definition. Given $\mathcal{T} > 0$, fix a single stochastic basis $(\Omega, \mathcal{F}, \{\mathcal{F}_{t_0,t}\}_{t\in[t_0,\mathcal{T}]}, \mathbb{P})$, where

Then, for $\mathbb{P}\text{-}a.s.,\ \omega \in \Omega$, there exists a stopping time T^* > 0 such that (u,θ) is a strong *solution of the system* $(3.16)-(3.21)$ $(3.16)-(3.21)$ *on the interval* $[t_0, T^*]$.

The proof of the existence of local solutions to $(3.16)-(3.21)$ $(3.16)-(3.21)$ is similar to [\[18\]](#page-24-2), we omit it. Before showing the global well-posedness of the strong solution, we recall the following Lemma, a special case of a general result of Lions and Magenes [\[24\]](#page-25-9), which will help us to show the continuity of the solution with respect to time in $(H^1(\mathcal{O}))^3$. For the proof, see [\[29\]](#page-25-10).

Lemma 3.1 Let V, H, V' be three Hilbert spaces such that $V \subset H = H' \subset V'$, where H' and V' are the dual spaces of H and V, respectively. Suppose $u \in L^2(0,T;V)$ and $\frac{du}{dt} \in L^2(0,T;V')$. Then u *is almost everywhere equal to a continuous function from* [0, T] *into* H*.*

Theorem 3.2 [Existence of global solution to (3.16) - (3.21)] *If* $Q \in L^2(\mathcal{O}), v_0 \in V_1, T_0 \in V_2$ *, and* $\mathcal{T} > 0$ *. Then, for* $\mathbb{P}\text{-}a.s., \omega \in \Omega$ *, there exists a unique strong solution* (u, θ) *of the system* (3.16) ²¹/^{3.21}</sup> or equivalently (v, T) to the system (1.9) ²/^{1.1}/₄ $)$ on the interval $[t_0, T]$.

Proof. Let $[t_0, \tau_*)$ be the maximal interval of existence of the strong solution, for fixed $\omega \in \Omega$, we will establish various norms of this solution in the interval $[t_0, \tau_*)$. In particular, we will show that if $\tau_* < \infty$ then H^1 –norm of the strong solution is bounded over the interval $[t_0, \tau_*).$ A priori estimates: Referring to [\[9\]](#page-24-3), define

\leq \varepsilon ||v||_2^2 + C\alpha^{-4} ||v||^2 ||v_2||^2 ||v_2||_2^2.

With the help of the Hölder inequality, we deduce that

-\alpha^{-1} \int_{\mathcal{O}} \Phi(\upsilon_1) T_z L_2 T + \alpha^{-1} \Phi(\upsilon) \partial_z T_2 L_2 T

= J_1(t) + J_2(t) + J_3(t) + J_4(t).
$$

By the Agmon inequality, we get that

J_1(t) + J_2(t) \leq \alpha^{-1} |v_1|_{\infty} |\nabla T| |L_2 T| + \alpha^{-1} |v|_4 |\nabla T_2|_4 |L_2 T|
$$

\leq C\alpha^{-1} \|v_1\|_2^{\frac{1}{2}} \|v_1\|_2^{\frac{1}{2}} \|T\| \|T\|_2 + C\alpha^{-1} \|v\| \|T_2\|_2 \|T\|_2
$$

\n

\leq \varepsilon \|T\|_2^2 + C\alpha^{-2} \|v\|^2 \|T_2\|_2^2 + C\alpha^{-2} \|v_1\| \|v_1\|_2 \|T\|^2.

Taking an similar argument as $K_2(t)$, we obtain

\leq C\alpha^{-1} ||T||_2^{\frac{3}{2}} ||T||^{\frac{1}{2}} \int_{-1}^{0} ||v_1||_{H^1(M)}^{\frac{1}{2}} ||v_1||_{H^2(M)}^{\frac{1}{2}} dz

\leq C\alpha^{-1} ||T||_2^{\frac{3}{2}} ||T||^{\frac{1}{2}} ||v_1||^{\frac{1}{2}} ||v_1||_2^{\frac{1}{2}}

\leq \varepsilon ||T||_2^2 + C\alpha^{-4} ||T||^2 ||v_1||^2 ||v_1||_2^2.

\leq \alpha^{-1} \Big(\int_{-1}^{0} ||T||_{H^2(M)} ||T_2||_{H^1(M)}^{\frac{1}{2}} ||T_2||_{H^2(M)}^{\frac{1}{2}} dz \Big) \int_{-1}^{0} |\nabla \cdot v|_{L^4(M)} dz
$$

\n
$$
\leq C\alpha^{-1} ||T||_2 ||T_2||^{\frac{1}{2}} ||T_2||_2^{\frac{1}{2}} ||v||^{\frac{1}{2}} ||v||_{2}^{\frac{1}{2}}
$$

\n
$$
\leq \varepsilon ||T||_2^2 + \varepsilon ||v||_2^2 + C\alpha^{-4} ||T_2||^2 ||T_2||_2^2 ||v||^2.
$$

Denote

$$
\eta(t) := \|v(t)\|^2 + \|T(t)\|^2,
$$

\n
$$
\xi(t) := \alpha^{-2} \|v_1\| \|v_1\|_2 + \alpha^{-4} \|v_1\|^2 \|v_1\|_2^2
$$

\n
$$
+ \alpha^{-4} \|v_2\|^2 \|v_2\|_2^2 + \alpha^2 \|v_2\|_2^2 + \alpha^2 \|T_2\|_2^2 + \alpha^{-4} \|T_2\|^2 \|T_2\|_2^2 + 1.
$$

Notice that $|\nabla v|^2 + |\partial_z v|^2$ is equivalent to $||v||^2$ and $|\nabla T|^2 + |T_z|^2 + |T(z=0)|^2_{L^2(M)}$ is equivalent to $||T||^2$, letting ε be small enough, we deduce from the above estimates of $K_1 - K_6$ and $J_1 - J_4$ that

Therefore, we proved that for any $t \in (t_0, \infty), (u(t), \theta(t))$ is Lipschitz continuous in $V_1 \times V_2$ with respect to the initial data $(u(t_0), \theta(t_0))$, which is equivalent to that strong solution $(v(t), T(t))$ of $(1.9)-(1.14)$ $(1.9)-(1.14)$ $(1.9)-(1.14)$ is Lipschitz continuous in $V_1 \times V_2$ with respect to the initial data (v_{t_0}, T_{t_0}) , for any $t \in (t_0,\infty).$

Remark 3.1

(1) *In the above theorem, we have obtained the continuity of the strong solution with respect to initial data in* $(H^1(\mathcal{O}))^3$. This is a key to prove the compact property of the solution operator in V. Notice that the authors only proved the strong solution is Lipschitz continuous in the space $(L^2(\mathcal{O}))^3$ with respect to the initial data in [\[16\]](#page-24-9), which is not enough to obtain the asymptotical *behavior in* $(H^1(\mathcal{O}))^3$.

(2) *With the help of Lemma [3.1,](#page-5-1) we have established the the continuity of strong solution with respect to time in* V *and a priori estimates to prove the compact property of the solution operator in* V *.*

(3) We release the regularity of Q from $H^1(\mathcal{O})$ to $L^2(\mathcal{O})$, which is more natural.

4 Existence of random attractor

In this section, we establish the existence of random attractor. Firstly, we recall some preliminaries from [\[3\]](#page-24-16).

Denote by $C_0(\mathbb{R}; X)$ the space of continuous functions with values in X and equal to 0 at $t = 0$. Let (X, d) be a polish space and $(\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}})$ be a probability space, where $\tilde{\Omega}$ is the two-sided Wiener space $C_0(\mathbb{R};X)$.

Definition 4.1 *A family of maps* $S(t, s; \omega): X \to X$, $-\infty < s \le t < \infty$, parametrized by $\omega \in \tilde{\Omega}$, *is said to be a stochastic flow, if* \tilde{P} *-a.s.*,

(i) $S(t, r; \omega)S(r, s; \omega)x = S(t, s; \omega)x$ *for all* $s \leq r \leq t$, $x \in X$,

(ii) $S(t, s; \omega)$ *is continuous in* X, *for all* $s \le t$,

(iii) *for all* $s < t$ *and* $x \in X$ *, the mapping*

$$
\omega \mapsto S(t, s; \omega)x
$$

is measurable from $(\tilde{\Omega}, \tilde{\mathcal{F}})$ *to* $(X, \mathcal{B}(X))$ *where* $\mathcal{B}(X)$ *is the Borel* σ *-algebra of* X,

(iv) *for all* $t, x \in X$, the mapping $s \mapsto S(t, s; \omega)$ *is right continuous at any point.*

Definition 4.2 *A set-valued map* $K : \tilde{\Omega} \to 2^X$ taking values in the closed subsets of X is said to *be measurable if for each* $x \in X$ *the map* $\omega \mapsto d(x, K(\omega))$ *is measurable, where*

$$
d(A, B) = \sup\{\inf\{d(x, y) : y \in B\} : x \in A\} \text{ for } A, B \in 2^X, A, B \neq \emptyset,
$$

and $d(x, B) = d({x}, B)$ *. Since* $d(A, B) = 0$ *if and only if* $A \subset B$ *, d is not a metric.*

Definition 4.3 *A closed set valued measurable map* $K : \tilde{\Omega} \to 2^X$ *is called a random closed set.*

Definition 4.4 *Given* $t \in \mathbb{R}$ *and* $\omega \in \tilde{\Omega}$, $K(t, \omega) \subset X$ *is called an attracting set at time t if for all bounded sets* $B \subset X$,

$$
d(S(t, s; \omega)B, K(t, \omega)) \to 0, \quad provided \ s \to -\infty.
$$

Moreover, if for all bounded sets $B \subset X$ *, there exists* $t_B(\omega)$ *such that for all* $s \le t_B(\omega)$

$$
S(t, s; \omega)B \subset K(t, \omega),
$$

we say $K(t, \omega)$ *is an absorbing set at time t.*

Let $\{\vartheta_t: \tilde{\Omega} \to \tilde{\Omega}\}, t \in T = \mathbb{R}$, be a family of measure preserving transformations of the probability space $(\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}})$ such that for all $s < t$ and $\omega \in \tilde{\Omega}$, the following

(a) $(t, \omega) \rightarrow \vartheta_t \omega$ is measurable,

- (b) $\vartheta_t(\omega)(s) = \omega(t+s) \omega(t)$.
- (c) $S(t, s; \omega)x = S(t s, 0; \vartheta_s \omega)x,$

hold. Then, $(\vartheta_t)_{t\in T}$ is a flow and $((\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}}), (\vartheta_t)_{t\in T})$ is a measurable dynamical system.

Definition 4.5 *Given a bounded set* $B \subset X$ *, the set*

$$
\Omega(B, t, \omega) = \bigcap_{T \le t} \overline{\bigcup_{s \le T} S(t, s, \omega)B}
$$

is said to be the Ω *-limit set of* B *at time t. Obviously, if denote* $\Omega(B, 0, \omega) = \Omega(B, \omega)$, we have $\Omega(B, t, \omega) = \Omega(B, \vartheta_t \omega).$

It's easy to identify

$$
\Omega(B, t, \omega) = \left\{ x \in X : \text{there exists } s_n \to -\infty \text{ and } x_n \in B \text{ such that } \lim_{n \to \infty} S(t, s_n, \omega) x_n = x \right\}.
$$

Furthermore, if there exists a compact attracting set $K(t, \omega)$ at time t, it is not difficult to check that $\Omega(B, t, \omega)$ is a nonempty compact subset of X and $\Omega(B, t, \omega) \subset K(t, \omega)$.

Definition 4.6 For all $t \in \mathbb{R}$ and $\omega \in \tilde{\Omega}$, a random closed set $\omega \to \mathcal{A}(t, \omega)$ is called the random $attractor, if $\tilde{\mathbb{P}}-a.s.,$$

- (1) $A(t, \omega)$ *is a nonempty compact subset of* X,
- (2) $A(t, \omega)$ *is the minimal closed attracting set, i.e., if* $\tilde{A}(t, \omega)$ *is another closed attracting set, then* $\mathcal{A}(t,\omega) \subset \mathcal{A}(t,\omega),$
- (3) *it is invariant, in the sense that, for all* $s \le t$, $S(t, s; \omega)A(s, \omega) = A(t, \omega)$.

Let $\mathcal{A}(\omega) = \mathcal{A}(0, \omega)$, then the invariance property can be written as

$$
S(t, s; \omega) \mathcal{A}(\vartheta_s \omega) = \mathcal{A}(\vartheta_t \omega).
$$

We will prove the existence of the random attractor using Theorem 2.2 in [\[3\]](#page-24-16). For the convenience of reference, we cite it here.

Theorem 4.1 *Let* $(S(t, s; \omega))_{t>s, \omega \in \tilde{\Omega}}$ *be a stochastic dynamical system satisfying* (i)-(iv). Assume *that there exists a family of measure preserving mappings* $\vartheta_t, t \in \mathbb{R}$ such that(a)- (c) hold and there *exists a compact attracting set* $K(\omega)$ *at time* 0*, for* $\tilde{\mathbb{P}}$ *-a.s.. Set*

$$
\mathcal{A}(\omega) = \overline{\bigcup_{B \subset X, B \text{ bounded}} \Omega(B, \omega)}
$$

where the union is taken over all the bounded subsets of X. Then we have $\mathbb{P}\text{-}a.s.,$

- (1) $A(\omega)$ *is a nonempty compact subset of X. If X is connected, it is a connected subset of* $K(\omega)$ *.*
- (2) *The family* $\mathcal{A}(\omega)$, $\omega \in \Omega$, *is measurable.*
- (3) $A(\omega)$ *is invariant in the sense that* $S(t, s; \omega)A(\vartheta_{s}\omega) = A(\vartheta_{t}\omega)$, $s \leq t$.
- (4) It attracts all bounded sets from $-\infty$: for bounded $B \subset X$ and $\omega \in \tilde{\Omega}$

$$
d(S(t, s; \omega)B, \mathcal{A}(\vartheta_t \omega)) \to 0, \text{ when } s \to -\infty.
$$

Moreover, it is the minimal closed set with this property: if $\tilde{A}(\vartheta_t\omega)$ *is a closed attracting set, then* $\mathcal{A}(\vartheta_t\omega) \subset \mathcal{A}(\vartheta_t\omega)$.

- (5) For any bounded set $B \subset X$, $d(S(t, s; \omega)B, \mathcal{A}(\vartheta_t\omega)) \to 0$ in probability when $t \to \infty$.
- *And if the time shift* $\vartheta_t, t \in \mathbb{R}$ *is ergodic,*
- (6) *there exists a bounded set* B ⊂ X *such that*

$$
\mathcal{A}(\omega) = \mathcal{A}(B, \omega),
$$

(7) $A(\omega)$ *is the largest compact measurable set which is invariant in sense of Definition [4.6.](#page-18-0)*

Before showing the existence of random attractor, we recall the Aubin-Lions Lemma, which is vital to the proof of Theorem [4.2.](#page-19-0)

Lemma 4.1 Let B_0, B, B_1 be Banach spaces such that B_0, B_1 are reflexive and $B_0 \subseteq B \subset B_1$. For $0 < T < \infty$, set

$$
X := \left\{ h \middle| h \in L^2([0, T]; B_0), \frac{dh}{dt} \in L^2([0, T]; B_1) \right\}.
$$

Then X is a Banach space equipped with the norm $|h|_{L^2([0,T];B_0)} + |h'|_{L^2([0,T];B_1)}$. Moreover,

$$
X \stackrel{c}{\subset} L^2([0,T];B).
$$

The main result is:

Theorem 4.2 Let $Q \in L^2(\mathcal{O}), v_0 \in V_1, T_0 \in V_2$. Then the solution operator $(S(t, s; \omega))_{t \geq s, \omega \in \tilde{\Omega}}$ of *3D* stochastic PEs^{(1.9)} (1.14) *:* $S(t, s; \omega)(v_s, T_s) = (v(t), T(t))$ satisfies (i) (iv) in Definition [4.1](#page-17-0) *and possesses a compact absorbing ball* $\mathcal{B}(0,\omega)$ *in* V *at time* 0*. Furthermore, for* $\tilde{\mathbb{P}}$ *-a.s.* $\omega \in \Omega$ *, set*

$$
\mathcal{A}(\omega) = \overline{\bigcup_{B \subset V} \Omega(B, \omega)}
$$

where the union is taken over all the bounded subsets of V. Then $A(\omega)$ *is the random attractor of stochastic PEs [\(1.9\)](#page-1-1)-[\(1.14\)](#page-2-0) and possesses the properties* (1)-(7) *of Theorem [4.1](#page-18-1) with space* X *replaced by space* V.

Proof. Denote by $w = (w_1 := \sum_{k=1}^n \alpha_k w_k^1, w_2 := \sum_{k=1}^n \beta_k w_k^2)$ the \mathbb{R}^2 -valued Brownian motion, which has a version ω in $C_0(\mathbb{R}, \mathbb{R}^2) := \tilde{\Omega}$, the space of continuous functions which are zero at zero. In the following, we consider a canonical version of w given by the probability space

 $(C_0(\mathbb{R}, \mathbb{R}^2), \mathcal{B}(C_0(\mathbb{R}, \mathbb{R}^2)), \tilde{\mathbb{P}})$, where $\tilde{\mathbb{P}}$ is the Wiener-measure generated by w and $\mathcal{B}(C_0(\mathbb{R}, \mathbb{R}^2))$ is the family of Borel subsets of $C_0(\mathbb{R}, \mathbb{R}^2)$. Now, define the stochastic flow $(S(t, s; \omega))_{t \geq s, \omega \in \tilde{\Omega}}$ by

$$
S(t, s; \omega)(v_s, T_s) = (\alpha^{-1}(t)u(t, \omega_1), \beta^{-1}(t)\theta(t, \omega_2)),
$$
\n(4.63)

where (v, T) is the strong solution to [\(1.9\)](#page-1-1)-[\(1.14\)](#page-2-0) with $(v_s, T_s) = (\alpha^{-1}(s)u_s(s, \omega_1), \beta^{-1}(s)\theta_s(s, \omega_2))$ and (u, θ) is the strong solution to [\(3.16\)](#page-4-0)-[\(3.21\)](#page-5-0). It can be checked that assumptions (i)-(iv) and (a)-(c) of stochastic dynamics are satisfied with $X = V$. Indeed, properties (i),(ii),(iv) of the solution operator $(S(t, s; \omega))_{t\geq s, \omega \in \tilde{\Omega}}$ follows by Theorem [3.2](#page-5-3) and property (iii) of the solution operator also holds with the help of the global existence of strong solution to $(1.9)-(1.14)$ $(1.9)-(1.14)$ rest upon Faedo-Galerkin method. Furthermore, $(\tilde{\Omega}, \mathcal{B}(C_0(\mathbb{R}, \mathbb{R}^2)), \tilde{\mathbb{P}}, \vartheta)$ is an ergodic metric dynamical system.

In the following, we will prove the existence of the random attractor. Let $(u(t,\omega; t_0, u_0), \theta(t, \omega; t_0, \theta_0))$ be the solution to $(3.16) - (3.21)$ $(3.16) - (3.21)$ $(3.16) - (3.21)$ $(3.16) - (3.21)$ with initial value $u(t_0) = u_0$ and $\theta(t_0) = \theta_0$. By the law of the iterated logarithm, we have

$$

Obviously, $t \to \beta^2(t)e^{\lambda t}$ is pathwise integrable over $(-\infty, 0]$, where λ is positive. And we have

\lim_{t \to -\infty} \beta^2(t)e^{\lambda t} = 0, \quad \tilde{\mathbb{P}} - a.e.. \tag{4.65}
$$

In view of [\(3.30\)](#page-6-3), [\(3.31\)](#page-7-0) and [\(4.65\)](#page-20-0), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, there exists a random variable $r_1(\omega)$, depending only on λ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -4$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $\theta(t, \omega; t_0, \theta_0)$ satisfies

$$
\sup_{t \in [-4,0]} |\theta(t,\omega;t_0,\theta_0)|^2 + \int_{-4}^0 \|\theta(s)\|^2 ds \le r_1(\omega). \tag{4.66}
$$

In view of [\(3.33\)](#page-7-7) and [\(4.66\)](#page-20-1), taking a similar argument as (4.66), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, we deduce that there exists random variable $r_2(\omega)$, depending only on λ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -4$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $u(t, \omega; t_0, u_0)$ satisfies

$$
\sup_{t \in [-4,0]} |u(t,\omega; t_0, u_0)|^2 + \int_{-4}^0 ||u(s)||^2 ds \le r_2(\omega). \tag{4.67}
$$

By [\(3.40\)](#page-8-0), repeating the argument as in [\(4.66\)](#page-20-1), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, there exists random variable $r_3(\omega)$, depending only on λ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -4$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $\theta(t, \omega; t_0, \theta_0)$ satisfies

$$
\sup_{t \in [-4,0]} |\theta(t,\omega;t_0,\theta_0)|_4^2 \le r_3(\omega). \tag{4.68}
$$

Integrating (3.44) with respect to time over $[t, -3]$ yields,

$$
|\tilde{u}(-3)|_4^2 \leq \left(|\tilde{u}(t)|_4^2 + C \int_t^{-3} \alpha^2(s) \beta^{-2}(s) |\theta(s)|_4^2 ds \right) e^{C \int_t^{-3} \alpha^{-2}(s) \|u(s)\|^2 (1+\alpha^{-2}(s)|u(s)|^2) ds}, \quad (4.69)

|\tilde{u}(-3)|_4^2 \le \left(\int_{-4}^{-3} |\tilde{u}(t)|_4^2 ds + C \int_{-4}^{-3} \alpha^2(s) \beta^{-2}(s) |\theta(s)|_4^2 ds \right) \times e^{C \int_{-4}^{-3} \alpha^{-2}(s) ||u(s)||^2 (1 + \alpha^{-2}(s) |u(s)|^2) ds} .
$$
\n(4.70)

Therefore, by virtue of [\(4.66\)](#page-20-1)-[\(4.68\)](#page-20-3), we conclude that for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, there exists random variable $C_1(\omega)$, depending only on λ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -4$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $\tilde{u}(-3, \omega; t_0, u_0)$ satisfies

$$
|\tilde{u}(-3)|_4^2 \le C_1(\omega). \tag{4.71}
$$

Integrating (3.44) with respect to time over $[-3, t]$, we get

$$
|\tilde{u}(t)|_4^2 \le \left(|\tilde{u}(-3)|_4^2 + C \int_{-3}^t \alpha^2(s) \beta^{-2}(s) |\theta(s)|_4^2 ds \right) e^{C \int_{-3}^t \alpha^{-2}(s) \|u(s)\|^2 (1+\alpha^{-2}(s)|u(s)|^2) ds}.
$$
 (4.72)

In view of [\(4.66\)](#page-20-1)-[\(4.68\)](#page-20-3) and [\(4.71\)](#page-21-0), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, we deduce that there exists random variable $r_4(\omega)$ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -3$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $u(t, \omega; t_0, u_0)$ satisfies

$$
\sup_{t \in [-3,0]} |\tilde{u}(t,\omega;t_0,\tilde{u}_0)|_4^2 \le r_4(\omega). \tag{4.73}
$$

Taking integration of (3.43) with respect to time over $[-3, 0]$ yields,

$$
\int_{-3}^{0} (|\nabla (|\tilde{u}|^{2})|^{2} + |\partial_{z}(|\tilde{u}|^{2})|^{2} + |\tilde{u}|\nabla \tilde{u}||^{2} + |\tilde{u}|\partial_{z}\tilde{u}||^{2})dt
$$
\n
$$
\leq |\tilde{u}(-3)|_{4}^{2} + C \int_{-3}^{0} \alpha^{2} \beta^{-2} |\theta|_{4}^{2} |\tilde{u}|_{4}^{2} + C \int_{-3}^{0} (\alpha^{-2} ||u||^{2} + \alpha^{-4} |u|^{2} ||u||^{2}) |\tilde{u}|_{4}^{2}.
$$
\n(4.74)

By [\(4.67\)](#page-20-4), [\(4.68\)](#page-20-3) and [\(4.74\)](#page-21-1), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, we infer that that there exists random variable $C_2(\omega)$ such that for $\rho > 0$ there exists $t(\omega) \leq -3$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $\tilde{u}(t, \omega; t_0, u_0)$ satisfies

$$
\int_{-3}^{0} (|\nabla (|\tilde{u}|^2)|^2 + |\partial_z (|\tilde{u}|^2)|^2 + |\tilde{u}|\nabla \tilde{u}||^2 + |\tilde{u}|\partial_z \tilde{u}||^2) dt \le C_2(\omega). \tag{4.75}
$$

By [\(3.46\)](#page-11-0), [\(4.68\)](#page-20-3) and [\(4.75\)](#page-21-2), proceeding as [\(4.73\)](#page-21-3), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, there exists random variable $C_3(\omega)$ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -2$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $\bar{u}(t, \omega; t_0, \bar{u}_0)$ satisfies

$$
\sup_{t \in [-2,0]} |\nabla \bar{u}(t,\omega; t_0, \bar{u}_0)|^2 \le C_3(\omega). \tag{4.76}
$$

In view of [\(3.49\)](#page-12-0) and [\(4.76\)](#page-21-4), following the steps in [\(4.73\)](#page-21-3), for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, there exists a random variable $r_5(\omega)$, such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -1$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, satisfies

$$
\sup_{t \in [-1,0]} |\partial_z u(t,\omega; t_0, u_0)|^2 + \int_{-1}^0 |\nabla u_z(s,\omega; t_0, u_0)|^2 ds \le r_5(\omega). \tag{4.77}
$$

Regarding [\(3.53\)](#page-13-2), [\(4.66\)](#page-20-1), [\(4.67\)](#page-20-4) and [\(4.77\)](#page-21-5), we repeat the procedures of deriving [\(4.73\)](#page-21-3) and [\(4.74\)](#page-21-1). For $\mathbb{P}-a.e.$ $\omega \in \Omega$, there exists a random variable $r_6(\omega)$ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -1$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $u(t, \omega; t_0, u_0)$ satisfies

$$
\sup_{t \in [-1,0]} |\nabla u(t,\omega; t_0, u_0)|^2 + \int_{-1}^0 |\Delta u(s,\omega; t_0, u_0)|^2 ds \le r_6(\omega). \tag{4.78}
$$

By [\(3.55\)](#page-13-1), [\(4.66\)](#page-20-1), [\(4.77\)](#page-21-5) and [\(4.78\)](#page-21-6), proceeding as above, for $\tilde{\mathbb{P}}$ −a.e. $\omega \in \tilde{\Omega}$, there exists a random variable $r_7(\omega)$ such that for arbitrary $\rho > 0$ there exists $t(\omega) \leq -1$ such that for all $t_0 \leq t(\omega)$ and $(u_0, \theta_0) \in V$ with $||u_0|| + ||\theta_0|| \leq \rho$, $\theta(t, \omega; t_0, \theta_0)$ satisfies

$$
\sup_{t\in[-1,0]}\|\theta(t,\omega;t_0,\theta_0)\|^2\leq r_7(\omega).
$$

Now we are ready to prove the desired compact result. Let $r(\omega) = r_5(\omega) + r_6(\omega) + r_7(\omega)$, then $B(-1, r(\omega))$, the ball of center $0 \in V$ and radius $r(\omega)$, is an absorbing set at time -1 for $(S(t, s; \omega))_{t>s, \omega \in \tilde{\Omega}}$. According to Theorem [4.1,](#page-18-1) in order to prove the existence of the random attractor in the space V, we need to to construct a compact absorbing set at time 0 in V. Let β be a bounded subset of V , set

$$
\mathcal{C}_T:=\Big\{\Big(A_1^{\frac{1}{2}}v,A_2^{\frac{1}{2}}T\Big)\Big|(v(-1),T(-1))\in\mathcal{B},(v(t),T(t))=S(t,-1;\omega)(v(-1),T(-1)),t\in[-1,0]\Big\}.
$$

We claim that C_T is compact in $L^2([-1,0];H)$. Indeed, the space $V_1 \times V_2 \subset H_1 \times H_2$ is compact as $V_i \subset H_i$ is compact. Let $(v(-1), T(-1)) \in \mathcal{B}$, by the argument of step 2 in the proof of Theorem [4.1,](#page-18-1) we have

$$
(A_1^{\frac{1}{2}}u, A_2^{\frac{1}{2}}\theta) \in L^2([-1,0]; V_1 \times V_2), \quad (\partial_t A_1^{\frac{1}{2}}u, \partial_t A_2^{\frac{1}{2}}\theta) \in L^2([-1,0]; V_1' \times V_2').
$$

Therefore, we deduce the result from Lemma [4.1](#page-19-1) with

$$
B_0 = V_1 \times V_2
$$
, $B = H_1 \times H_2$, $B_1 = V'_1 \times V'_2$.

Now, we aim to show that for any fixed $t \in (-1,0], \omega \in \tilde{\Omega}, S(t,-1;\omega)$ is a compact operator in V. Taking any bounded sequences $\{(\nu_{0,n}, \tau_{0,n})\}_{n\in\mathbb{N}}$ in B, for any fixed $t \in (-1, 0], \omega \in \tilde{\Omega}$, we devote

to extracting a convergent subsequence from $\{S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n})\}$. Since $\{(\overline{A}_1^{\frac{1}{2}}v, \overline{A}_2^{\frac{1}{2}}T)\}\subset \mathcal{C}_T$, by Lemma [4.1,](#page-19-1) there is a function $(\nu_*, \theta_*) \in L^2([-1, 0]; V)$ and a subsequence of ${S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n})}_{n \in \mathbb{N}}$ still denoted by ${S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n})}_{n \in \mathbb{N}}$ such that

$$
\lim_{n \to \infty} \int_{-1}^{0} \|S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n}) - (\nu_*(t), \theta_*(t))\|^2 dt = 0.
$$
\n(4.79)

By the measure theory, we know that the convergence in mean square implies almost sure convergence. Therefore, it follows from [\(4.79\)](#page-22-0) that there exists a subsequence $\{S(t, -1; \omega) (\nu_{0,n}, \tau_{0,n})\}_{n \in \mathbb{N}}$ such that

$$
\lim_{n \to \infty} ||S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n}) - (\nu_*(t), \theta_*(t))|| = 0, \quad a.e. \ t \in (-1, 0]. \tag{4.80}
$$

Fix any $t \in (-1,0]$. By [\(4.80\)](#page-22-1), we can select a $t_0 \in (-1, t)$ such that

$$
\lim_{n \to \infty} ||S(t_0, -1, \omega)(\nu_{0,n}, \tau_{0,n}) - (\nu_*(t_0), \theta_*(t_0))|| = 0.
$$

Then by the continuity of $S(t - t_0, t_0; \omega)$ in V with respect to the initial value, we have

$$
S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n}) = S(t - t_0, t_0; \omega)S(t_0, -1; \omega)(\nu_{0,n}, \tau_{0,n})
$$

$$
\rightarrow S(t - t_0, t_0; \omega)(\nu_*(t_0), \theta_*(t_0)), \text{ in } V.
$$

Hence, for any $t \in (-1,0]$, we can always find a convergent subsequence of ${S(t, -1; \omega)(\nu_{0,n}, \tau_{0,n})}_{n \in \mathbb{N}}$ in V, which implies that for any fixed $t \in (-1, 0], \omega \in \Omega, S(t, -1; \omega)$ is a compact operator in V. Set

$$
\mathcal{B}(0,\omega) = \overline{S(0,-1;\omega)B(-1,r(\omega))},
$$

then, $\mathcal{B}(0,\omega)$ is a closed set of $S(0,-1;\omega)B(-1,r(\omega))$ in V. Using the above argument, we know that $\mathcal{B}(0,\omega)$ is a random compact set in V. Precisely, $\mathcal{B}(0,\omega)$ is a compact absorbing set in V at time 0. Indeed, for $(\nu_{0,n}, \tau_{0,n}) \in \mathcal{B}$, there exists $s(\mathcal{B}) \in \mathbb{R}_-$ such that for any $s \leq s(\mathcal{B})$, we have

$$
S(0, s; \omega)(\nu_{0,n}, \tau_{0,n}) = S(0, -1; \omega)S(-1, s; \omega)(\nu_{0,n}, \tau_{0,n}) \subset S(0, -1; \omega)B(-1, r(\omega)) \subset \mathcal{B}(0, \omega).
$$

Therefore, we conclude the result from Theorem [4.1.](#page-18-1)

5 Existence of invariant measure

Up to now, we are ready to prove the existence of invariant measure of the system $(1.9)-(1.14)$ $(1.9)-(1.14)$.

Let $U_0 = (v_0, T_0) \in V$, $U(t, \omega; U_0) := (v(t, \omega; t_0, v_0), T(t, \omega; t_0, T_0))$ is the solution to $(3.16)-(3.21)$ $(3.16)-(3.21)$ with the initial value U_0 . Following the standard argument, we can show that $U(t, \omega; U_0), t \in [t_0, \mathcal{T}]$ is Markov process in the sense that for every bounded, $\mathcal{B}(V)$ -measurable $F: V \to \mathbb{R}$, and all $s, t \in [t_0, \mathcal{T}], t_0 \leq s \leq t \leq \mathcal{T},$

$$
\mathbb{E}(F(U(t,\omega;U_0))|\mathcal{F}_s)(\omega)=\mathbb{E}(F(U(t,s,U(s)))) \ \ \text{ for } \ \tilde{\mathbb{P}}-a.e. \ \omega \in \Omega,
$$

where $\mathcal{F}_s = \mathcal{F}_{t_0,s}$ (see [\(3.15\)](#page-4-1)), $U(t, s, U(s))$ is the solution to [\(1.9\)](#page-1-1)-[\(1.14\)](#page-2-0) at time t with initial data $U(s).$

For $B \in \mathcal{B}(V)$, define

$$
\tilde{\mathbb{P}}_t(U_0, B) = \tilde{\mathbb{P}}((U(t, \omega; U_0) \in B).
$$

For any probability measure ν defined on $\mathcal{B}(V)$, denote the distribution at time t of the solution to $(1.9)-(1.14)$ $(1.9)-(1.14)$ with initial distribution ν by

$$
(\nu \tilde{\mathbb{P}}_t)(\cdot) = \int_V \tilde{\mathbb{P}}_t(x, \cdot) \nu(dx).
$$

For $t \geq t_0$ and any continuous and bounded function $f \in C_b(V;\mathbb{R})$, we have

$$
\tilde{\mathbb{P}}_t f(U_0) = \mathbb{E}[f(U(t,\omega;U_0)] = \int_V f(x)\tilde{\mathbb{P}}_t(U_0, dx).
$$

Definition 5.1 Let ρ be a probability measure on $\mathcal{B}(V)$. ρ is called an invariant measure for $\tilde{\mathbb{P}}_t$, if

$$
\int_{V} f(x)\rho(dx) = \int_{V} \tilde{\mathbb{P}}_{t}f(x)\rho(dx)
$$

for all $f \in C_b(V;\mathbb{R})$ *and* $t \geq 0$.

Let μ be a transition probability from $\tilde{\Omega}$ to V, i.e., μ is a Borel probability measure on V and $\omega \to \mu(P)$ is measurable for every Borel set $B \subset V$. Denote by $\mathcal{P}_{\tilde{\Omega}}(V)$ the set of transition probabilities with μ and ν identified if $\tilde{\mathbb{P}}\{\omega : \mu_{\omega} \neq \nu_{\omega}\} = 0$.

In view of Proposition 4.5 in [\[4\]](#page-24-17), the existence of random attractor obtained in Theorem [4.2](#page-19-0) implies the existence of invariant Markov measure μ . $\in \mathcal{P}_{\tilde{\Omega}}(V)$ for S such that $\mu_{\omega}(\mathcal{A}(\omega)) = 1$, \mathbb{P} -a.e.. Therefore, referring to [\[2\]](#page-24-18), there exists an invariant measure for the markov semigroup $\tilde{\mathbb{P}}_t$ and it is given by

$$
\rho(B) = \int_{\tilde{\Omega}} \mu_{\omega}(B) \tilde{\mathbb{P}}(d\omega),
$$

where $B \subseteq V$ is a Borel set. If the invariant measure ρ for \tilde{P} is unique, the invariant Markov measure μ . for S is unique and given by

$$
\mu_{\omega} = \lim_{t \to \infty} S(0, -t, \omega)\rho.
$$

Based on the above, we arrive at

Theorem 5.1 *The Markov semigroup* $(\tilde{\mathbb{P}}_t)_{t\geq0}$ *induced by the solution* $(U(t,\omega;U_0))_{t\geq0}$ *to* (1.9) *-[\(1.14\)](#page-2-0)* has an invariant measure ρ with $\rho(\mathcal{A}(\omega)) = 1$ $\tilde{\mathbb{P}}$ -a.e..
