Proof nets and the instantiation overflow property

Abstract

Instantiation overflow is the property of those second order types for which all instances of full comprehension can be deduced from instances of atomic comprehension. In other words, a type has instantiation overflow when one can type, by atomic polymorphism, "expansion terms" which realize instances of the full extraction rule applied to that type. This property was investigated in the case of the types arising from the well-known Russell-Prawitz translation of logical connectives into System F, but is not restricted to such types. Moreover, it can be related to functorial polymorphism, a well-known categorial approach to parametricity in System F.

In this paper we investigate the instantiation overflow property by exploiting the representation of derivations by means of linear logic proof nets. We develop a geometric approach to instantiation overflow yielding a deeper understanding of the structure of expansion terms and Russell-Prawitz types. Our main result is a characterization of the class of types of the form $\forall XA$, where A is a simple type, which enjoy the instantiation overflow property, by means of a generalization of Russell-Prawitz types.

1 Introduction

In his 1903, Principles of Mathematics, Bertrand Russell showed that the connectives $\neg, \land, \lor, \exists$ can be expressed in the \Rightarrow, \forall -fragment of second order logic. Russell's translation was later extended by Prawitz ([Pra65]) to derivations, providing an embedding of full second order logic into its \Rightarrow, \forall -fragment. The Russell-Prawitz translation (*RP* translation for short) can be described as a method which allows to associate with any connective \star defined by natural deduction introduction rules¹

$$\frac{\Gamma_i}{\star} \star^{\mathrm{I}_i}$$

a formula $RP(\star) = \forall X((\Gamma_1 \Rightarrow X) \Rightarrow \ldots \Rightarrow (\Gamma_n \Rightarrow X) \Rightarrow X)^2$ belonging to this fragment.

When restricting to intuitionistic logic, the \Rightarrow , \forall -fragment of second order logic corresponds to the polymorphic λ -calculus or System F ([Gir72, Rey74]). The most characteristic rule of this system is the \forall -elimination rule

$$\frac{\forall XA}{A[B/X]} \tag{1}$$

also called extraction rule, which allows to give type A[B/X], for any type B, to a term having type $\forall XA$. This rule expresses an impredicative comprehension principle and is responsible for the failure, in second order logic, of the subformula principle.

A salient feature of the types of the form $RP(\star)$ (let us call them RP types) is the so-called *instantiation overflow* property, first described in [Fer06]. A type of the form $\forall XA$ has this property when any instance of the full extraction rule 1 can be deduced in System F_{at} ([FF13]), that is, the subsystem of F in which rule 1 is replaced by the atomic extraction rule below

$$\frac{\forall XA}{A[Y/X]} \tag{2}$$

More precisely, the type $\forall XA$ has instantiation overflow when for any second order type B, there exists an "expansion term" $IO_A(B)$ which can be given type $\forall XA \Rightarrow A[B/X]$ in F_{at} . In other words, this property amounts to the possibility, for a given type, to deduce full comprehension from atomic, hence predicative, comprehension.

The instantiation overflow property of RP types was exploited in [Fer06] and [FF13] to define a variant of the RP translation based on atomic polymorphism. However, instantiation overflow is not restricted to RP types: in [FD16] is shown that it holds for all types $\forall XA_n$, where $A_0 = Y \Rightarrow X$ and $A_{n+1} = A_n \Rightarrow X$.

In [TPP16] instantiation overflow was related to functorial polymorphism ([BFSS90]), by exploiting a well-known connection between the RP translation and dinaturality. We recall that functorial polymorphism is the semantics of System F in which types are interpreted as functors

(in a generalized, "multivariant", sense, see [EK66]) over a cartesian closed category, and welltyped terms as dinatural transformations between such functors. This semantics was proposed as a formalization of parametric polymorphism, one of the most investigated aspects of System F (see [JFM⁺96] for an historical survey on parametricity). In particular, all parametric models of System F are dinatural models, as parametricity implies dinaturality ([PA93]).

The fact that the type $RP(\star)$ preserves all properties of the original connective \star corresponds to the dinaturality condition for the type $RP(\star)$. In categorial terms, this means that the RPtranslation preserves universal properties of connectives only in parametric models of System F([PA93, Has09]). In proof-theoretic terms, this means that the RP translation, while preserving β -equivalence in all models, preserves η -equivalence and permuting conversions only up to the equational theory generated by dinaturality ([TPP17]).

When $\forall XA$ is a RP type, the expansion terms $IO_A(B)$ realizing instantiation overflow can be described in a "functorial" way, by considering the fact that A must be of the form $A_1 \Rightarrow$ $\ldots \Rightarrow A_n \Rightarrow X$, where the A_i only contain positive occurrences of X. Such A_i correspond then to covariant endofunctors over the category generated by derivations: given a derivation u of hypothesis B and conclusion C, one can construct a derivation $A_i(u)$, of hypothesis $A_i[B/X]$ and conclusion $A_i[C/X]$. Then, for any B, one can construct a F_{at} derivation of $\forall XA \Rightarrow A[B/X]$ as illustrated in figure 1, by exploiting the functoriality of the A_i over the derivation $Elim_B$ of hypothesis B, B_1, \ldots, B_n and conclusion Y (where B is of the form $\forall \overline{Y}_1(B_1 \Rightarrow \forall \overline{Y}_2(B_2 \Rightarrow$ $\ldots \Rightarrow \forall \overline{Y}_n(B_n \Rightarrow \forall Y_{n+1}Y)\ldots)))$, made only of elimination rules. When $\forall XA$ is the RP translation of disjunction, conjunction or absurdity, such derivations correspond exactly to those described in [FF13]. Moreover, in the equational theory generated by dinaturality, the expansion terms just described are equivalent to the derivations consisting only of one instance of the full extraction rule ([TPP16]). This means in particular that expansion terms and instances of full extractions have the same denotations in all parametric models of System F. In other words, atomic polymorphism and full polymorphism for RP types are indistiguishable modulo dinaturality/parametricity.

In this paper we investigate the instantiation overflow property by exploiting, in addition to the functorial intuition, the representation of derivations by means of linear logic proof nets. Proof nets can be considered as a unified framework for structural and categorial proof theory, as they provide a well-known bridge between the sequent calculus of linear logic and the language of symmetric monoidal closed as well as *-autonomous categories ([See89, Blu93, BCST96]), refining a paradigm originating in Lambek's investigations on categories as deductive systems [Lam69]. Proof nets for Intuitionistic Multiplicative Linear Logic (without units), *IMLL*⁻, essentially correspond to Eilenberg-Kelly-MacLane graphs (see [EK66, Blu93, Hug12]), a graphical formalism playing a central role in several coherence theorems (see [KM71, KL80]). Moreover, *IMLL*⁻ types (that we call linear types) can be described as multivariant functors over the category generated by proof nets/allowable graphs.

We develop a geometric approach to instantiation overflow yielding a deeper understanding of the structure of expansion terms and Russell-Prawitz types. Our main result is a characterization of instantiation overflow for the types of the form $\forall XA$, where A is a simple type (theorem 7): we define a class of types which generalize the RP translation and we show that, when A is a simple type, $\forall XA$ has instantiation overflow if and only if it is either derivable or logically equivalent to a product of types belonging to this class.

We use proof nets to investigate the expansion property for the types of the linear simply typed λ -calculus $\lambda_{-\circ}$. A linear type is expansible when, for all B, there exists a variable Y and a proof net of hypothesis A[Y/X] and conclusion A[B/X], for some variable Y. When considering RP_X^3 types in $\lambda_{-\circ}$ (called linear RP_X types), the expansion terms, as the one in figure 1, correspond to proof nets called "simple expansion graphs". In figure 2 is shown the simple expansion graph for the type $(A \multimap B \multimap X) \multimap X$ (associated to the RP translation of the multiplicative conjunction $A \otimes B$). Similarly to instantiation overflow, the expansion property is not limited to linear RP_X types: for instance the types $C = ((X \multimap X) \multimap X) \multimap X$ and $D = (X \multimap X) \multimap (X \multimap X)$ are expansible but are not linear Russell-Prawitz types.

Simple expansion graphs can be defined for any type having an equal number of positive and negative occurrences of a variable X. However, such graphs need not be proof nets, that is, satisfy the correction criterion. We show that the correctness of such graphs depends on the possibility of pairing the occurrences of X following a particular pattern (called an internal pairing). This property leads to introduce, for any variable X, the class of generalized Russell-Prawitz types in X (gRP_X types), which capture the geometrical properties of RP_X types. We prove that a linear type is expansible if and only if it is logically equivalent to a gRP_X type. For instance, the type C above and (as soon as intuitionsitic implication is replaced by linear implication) all types A_n introduced in [FD16]) are gRP_X; the type D above is not gRP_X, but logically equivalent to the gRP_X type $D' = X - \circ X$.

The result just stated is actually a bit stronger, as it exploits a strict notion of logical equivalence, called *collapse*, related to Craig interpolation: a type A collapses into a type B when B is an interpolant of a derivation of $A \multimap A$. For instance, the type D above collapses into the type D'. Proof net interpolation algorithms are known from the literature ([BdG96, Car97]). As our results involve the implicational fragment of some intuitionistic systems, we had to consider the well-known fact that such fragments satisfy interpolation in a weaker form (see [Kan06]). To implement weak proof net interpolation in $\lambda_{-\infty}$, we adapted the algorithm in [BdG96].

The characterization of expansible linear types is extended to the simply typed λ -calculus λ_{\Rightarrow} , by exploiting a folklore linearization argument relating simply typed λ -terms and proof nets. The characterization of expansible simple types is slightly different as one must consider that, if a type is derivable (that is, if there exists a closed term of that type), then, by weakening, it is also expansible, and that weak interpolation for λ_{\Rightarrow} is sensibly more complex than in the case of $\lambda_{-\circ}$. We prove that a simple type is expansible iff it is either derivable or logically equivalent to the product of a finite family of gRP_X types.

We finally adapt these results to F_{at} : we show that a suitable extension of the expansion property yields a similar characterization of instantiation overflow for the types of the form $\forall XA$, where A is a simple type: as mentioned above, such types are either derivable or logically equivalent (in F_{at}) to the product of a finite family of gRP types (i.e. types of the form $\forall XB$, where B is gRP_X).

There are many natural questions which are left open by the present investigations. In particular, we do not know whether the instantiation overflow property is decidable (as our characterization depends on the notions of derivability and logical equivalence, which are both

undecidable in the case of F_{at}), nor how the ideas and techniques here presented can be extended to the case of an arbitrary second order type of the form $\forall XA$. Finally, the relation between gRP types and the RP translation should be investigated in more detail. We briefly discuss some of these questions at the end of the paper.

Related work The instantiation overflow phenomenon was first introduced in [Fer06] and later investigated in [FF13] as a property of the Russell-Prawitz translation of disjunction. In particular, it is shown there that the usual Russell-Prawitz translation of logical connectives into F can be transformed into a translation into F_{at} by exploiting instantiation overflow. Similar results were independently proved in [San08].

The first investigation on the general class of formulas enjoying instantiation overflow is in [FD16], where the "Prawitz formulas of level n" are introduced. The results are the following: (1) Prawitz formulas of level 2 have instantiation overflow, (2) there exist Prawitz formulas of arbitrary level (the formulas A_n mentioned above) having instantiation overflow, (3) the formula $X \Rightarrow Y$ does not have instantiation overflow. Such results can be deduced from our characterization, since (1) Prawitz formulas of level 2 correspond to Russell-Prawitz types, (2) the formulas A_n correspond to generalized Russell Prawitz types and (3) $X \Rightarrow Y$ is not logically equivalent to any product of generalized Russell-Prawitz types.

As already mentioned, the functorial formulation of instantiation overflow as well as the result that the instantiation overflow derivations are equivalent to instances of full extraction modulo dinaturality first appeared in [TPP16] and will appear in a sequel paper to the journal version [TPP17]. These papers present the functorial interpretation of Russell-Prawitz types and their relation with dinaturality within a natural deduction frame.

Categories of allowable graphs are well-known in the literature since [KM71] and are used to establish coherence results (see [KL80]). Several proof net formalisms for *IMLL* have been used to establish coherence for symmetric monoidal categories, *-autonomous categories and weakly distributive categories ([BCST96, LS04]). The main technical delicacy in such approaches involves the treatment of multiplicative unities 1 and \perp . For this reason we limited ourselves to the system *IMLL*⁻ and its –o-fragment λ_{-o} . [Hug12] shows that this approach can be extended to treat \perp , yielding a representation of the free *-autonomous category. Following [HHS17], allowable graphs for *IMLL*⁻ should yield a representation of the free symmetric semi-monoidal closed category. Our category \mathcal{A} of allowable graphs essentially follows [Hug12, HHS17]. A major difference is that we define shapes as rooted DAGs, incorporating the correctness criterion for Lamarche essential nets ([Lam08, MO03]).

Interpolation for linear logic and proof nets was investigated in [Roo91], [BdG96] and [Car97]. Weak interpolation for the implicational fragment of intuitionistic logic was investigated in [Wro84, Pen97, Kan06]. Our proof of weak interpolation for $\lambda_{-\infty}$ (in appendix A) is essentially a variant of the one in [BdG96].

Structure of the paper The paper can be subdivided in two parts. The first part, from section 2 to section 4, is preliminary to the treatment of instantiation overflow: we first introduce type systems, proof-nets and their categorial and functorial interpretations, and then we discuss proof net interpolation and some useful applications. The second part, from section 5 to section 6, is devoted to Russell-Prawitz types and the characterization of the expansion property and instantiation overflow.

More in detail, in section 2 we recall the four type systems $(\lambda_{-\circ}, \lambda_{\Rightarrow}, F, F_{at})$ used in the paper and we describe the syntactic categories they generate as well as their functorial interpretations. Moreover, we introduce a graphical representation of linear terms through a category of allowable graphs (similarly to [Hug12]), corresponding to essential nets ([Lam08, MO03]). In section 3 we recall previous results on interpolation in $IMLL^-$ and we prove a weak interpolation result for the fragment $\lambda_{-\circ}$. Then we exploit this result to prove the positivity lemma 3.3, a fundamental result which allows to extract, through interpolation, a type containing only positive occurrences of a variable from any type for which a "functorial" action on arrows is defined. In section 4 we extend these results to λ_{\Rightarrow} , by exploiting a linearization theorem.

In section 5 we describe instantiation overflow and Russell-Prawitz types and their relationship with functorial polymorphism. We also introduce generalized Russell-Prawitz types and the expansion property, which are investigated in the last two sections. In section 6 we investigate the expansion property for linear types. We prove our first "density theorem": a linear type is expansible iff it collapses into a linear generalized Russell-Prawitz type. This section contains our geometrical investigation of instantiation overflow through simple expansion graphs. In section 7 we prove a similar "density theorem" for simple types and we apply it to characterize simple types enjoying instantiation overflow.

Finally, in section 8 we discuss some open problems and further directions.

2 λ -terms, proof nets and categories

We recall the type systems which will be used in the paper and we introduce proof nets for Intuitionistic Multiplicative Linear Logic without units $IMLL^-$, by defining a category \mathcal{A} of *allowable graphs* similarly to [Hug12]. Then, we recall the syntactic categories generated by simply typed λ -terms and System F typable λ -terms and their functorial interpretation, which will be exploited in section 5 to describe the instantiation overflow property for Russell-Prawitz types.

2.1 Type systems

We introduce the four type systems which will be used throughout the text:

- the simply typed λ -calculus λ_{\Rightarrow} ;
- the linear simply typed λ -calculus $\lambda_{-\circ}$;
- the polymorphic λ -calculus or System F ([Gir72, Rey74]);
- the atomically polymorphic λ -calculus or System F_{at} ([FF13]).

Given a basic set of types \mathcal{T} , built over a set of variables \mathcal{V} , we will consider two notions of λ -terms:

1. λ -terms, defined by the grammar below

$$t, u := x \mid tu \mid \lambda x^A.t$$

$(\lambda x.t)u \simeq_{\beta} t[u/x]$	$(\Lambda X.t)B \simeq_{\beta} t[B/X]$
$\lambda x.tx \simeq_{\eta} t \ (x \notin FV(t))$	$\Lambda X.tX \simeq_{\eta} t \ (X \notin FV(t))$

Figure 3: β and η equivalences

where $A \in \mathcal{T}$; t is linear in x if x occurs exactly once free in t;

2. λ^2 -terms, defined by the grammar below

$$t, u := x \mid tu \mid \lambda x^{A} \cdot t \mid \Lambda X \cdot t \mid tA$$

where $A \in \mathcal{T}$ and $X \in \mathcal{V}$.

Observe that the definitions above depend on the choice of \mathcal{T} . This dependence will be often omitted, if it can be deduced from the context.

 λ -terms and λ^2 -terms are considered up to renaming of bound variables, as usual. Given a λ -term (resp. λ^2 -term) u, we let FV(u) indicate the set of its free term (resp. term and type) variables, and BV(u) indicate the set of its bound term (resp. term and type) variables.

For λ -terms and λ^2 -terms we let $\simeq_{\beta\eta}$ indicate usual $\beta\eta$ -equivalences, generated by the schemas in figure 3. By a *normal* λ -term (resp. λ^2 -term) we indicate a term to which no β -reduction can be applied. Following [Bar85], by a λ -theory (resp. a λ^2 -theory) we indicate any set T of equations over λ (resp. λ^2) terms such that $T^+ = T$, where T^+ is obtained by adding the $T \beta$ and η equivalence as well as the usual axioms and rules of the λ -calculus.

For any normal λ -term u, we define the set Subt(u) of its subterms as follows: if $u = \lambda x_1 \dots \lambda x_n \cdot y$ has no application, then $Subt(u) = \{\lambda x_i \cdot \lambda x_{i+1} \dots \lambda x_n \cdot y \mid 1 \leq i \leq n\}$; otherwise, $M = \lambda x_1 \dots \lambda x_n \cdot y u_1 \dots u_p$, then $Subt(u) = \{\lambda x_i \cdot \lambda x_{i+1} \dots \lambda x_n \cdot y u_1 \dots u_p \mid i \leq i \leq n\} \cup Subt(u_1) \cup \dots \cup Subt(u_p)$. We call a subterm $v \in Subt(u)$ proper if $v \neq u$.

We introduce now the type systems. By a *context* in \mathcal{T} we indicate a list Γ of type declarations $x_1 : A_1, \ldots, x_n : A_n$, where the A_i are types of \mathcal{T} and the x_i are pairwise distinct term variables. We will indicate contexts as Γ, Δ, \ldots . Concatenation of contexts is indicated by comma Γ, Δ .

All systems below include the exchange rule Ex

$$\frac{\Gamma \vdash u : A}{\sigma \Gamma \vdash u : A} Ex$$

where Γ is a context in \mathcal{T} , A is a type in \mathcal{T} and $\sigma\Gamma$ indicates a context obtained from Γ by permuting the order of its elements.

By a partition of a context Γ , we indicate a list $\Gamma_1, \ldots, \Gamma_p$ of contexts such that $\Gamma_1, \ldots, \Gamma_p = \sigma \Gamma$.

- $(\lambda_{-\circ})$ the set of linear types $\mathcal{L}_{-\circ}$ is generated by the grammar $A, B := X | A \multimap B$; the typing rules for linear λ -terms are Ex and those shown in figure 4a;
- (λ_{\Rightarrow}) the set of simple types $\mathcal{L}_{\Rightarrow}$ is generated by the grammar $A, B := X \mid A \Rightarrow B$; the typing rules for λ -terms are Ex, W and those in figure 4b;
- (F) the set of second order types $\mathcal{L}_{\Rightarrow,\forall}$ is generated by the grammar $A, B := X \mid A \Rightarrow B \mid \forall XA$; the typing rules for λ^2 -terms are those of λ_{\Rightarrow} plus those shown in figure 4c;
- (F_{at}) same types as F; the typing rules for λ^2 -terms are those of λ_{\Rightarrow} plus those shown in figure 4d;

Observe that the usual rules of contraction and weakening are derivable in λ_{\Rightarrow} , F, F_{at} . For any type A in any of the systems above, we let FV(A) (resp. BV(A))) indicate the set of its free (resp. bound) variables. There exist obvious inverse translations from $\Rightarrow : \mathcal{L}_{\neg} \to \mathcal{L}_{\Rightarrow}$ and $\neg^{\circ} : \mathcal{L}_{\Rightarrow} \to \mathcal{L}_{\neg^{\circ}}$, given by $X^{\Rightarrow} = X$, $X^{\neg^{\circ}} = X$, $(A \multimap B)^{\Rightarrow} = A^{\Rightarrow} \Rightarrow B^{\Rightarrow}$ and $(A \Rightarrow B)^{\neg^{\circ}} =$ $A^{\neg^{\circ}} \multimap B^{\neg^{\circ}}$. If $\Gamma \vdash u : A$ is derivable in $\lambda_{\neg^{\circ}}$, then $\Gamma^{\Rightarrow} \vdash u : A^{\Rightarrow}$ is derivable in λ_{\Rightarrow} , where $\Gamma^{\Rightarrow} = x_1 : A_1^{\Rightarrow}, \dots, x_n : A_n^{\Rightarrow}$, for $\Gamma = x_1 : A_1, \dots, x_n : A_n$.

A type $B \in \mathcal{L}_{\Rightarrow,\forall}$ will be generally written $\forall \overline{Y}_1(B_1 \Rightarrow \forall \overline{Y}_2(B_2 \Rightarrow \ldots \Rightarrow \forall \overline{Y}_n Z))$, where $\forall \overline{Y}_i$ is shorthand for a finite, possibly empty, sequence of quantifications $\forall Y_{i_1} \ldots \forall Y_{i_k}$.

Given any of the systems above, we say that a type A is *derivable* if there exists a closed term u having type A. We say that two types A, B are *logically equivalent* if there exist closed terms u, v having type $A \multimap B, B \multimap A$, respectively, in the case of $\lambda_{-\circ}$, and $A \Rightarrow B, B \Rightarrow A$, respectively, in all other cases. If, moreover, $\lambda x^A \cdot v(ux) \simeq_{\beta\eta} \lambda x^A \cdot x$ and $\lambda x^B \cdot u(vx) \simeq_{\beta\eta} \lambda x^B \cdot x$, then A and B are called *isomorphic*. Finally, given types A, B_1, \ldots, B_n , we say that A is *logically* equivalent to the product of B_1, \ldots, B_n when there exist closed terms u_1, \ldots, u_n, u having types $A \multimap B_1, \ldots, A \multimap B_n, B_1 \multimap \cdots \multimap B_n \multimap A$, respectively (in the case of $\lambda_{-\circ}$) and types $A \Rightarrow B_1, \ldots, A \Rightarrow B_n, B_1 \Rightarrow \ldots \Rightarrow B_n \Rightarrow A$, respectively, in all other cases.

In any of the systems above, given a normal λ -term u such that $\Gamma \vdash u : A$, we introduce the following terminology:

- *i*. any variable x occurring free or bound in u is assigned a unique type A that we indicate by [x];
- *ii.* any $v \in Subt(u)$ is assigned a unique type, that we indicate by [v];
- *iii.* u is said in η -long normal form when for any $v \in Subt(u)$, if $[v] = B \Rightarrow C$ or $[v] = B \multimap C$, then $v = \lambda x^B \cdot v'$, for some variable x and term $v' \in Subt(u)$.

Observe that, if u is in η -long normal form, then for any type B occurring positively (resp. negatively) in A there exists $v \in Subt(u)$ (resp. $x \in BV(u)$) such that [u] = B (resp. [x] = B).

2.2 Proof nets and the category of allowable graphs

We introduce proof nets for Intuitionistic Multiplicative Linear Logic without units, $IMLL^-$, that is, the system obtained by adding to $\lambda_{-\circ}$ the \otimes connective. Typed λ -calculi for IMLL can be found in the literature (see [Abr93, BBdPH93]).

We recall that proof nets for *IMLL* and its subsystems can be considered as a graphical representation of λ -terms or as a graphical formalism for arrows in free monoidal closed categories. Our definition merges the two viewpoints: on the one hand, our definition corresponds to the usual definition of *essential nets* for *IMLL*⁻ ([Lam08, MO03]), characterizing linearly typable λ -terms; on the other hand, we introduce proof-structures by means of a category of graphs following [Hug12]; in particular, the correction criterion of essential nets generates the subcategory of allowable graphs.

We first define a category \mathcal{G} of graphs, which are defined as certain morphisms between signed sets, i.e. sets whose elements are assigned a polarity +, -. Then we introduce shapes as certain rooted DAGs whose leaves form a signed set and we define a category \mathcal{A} of allowable graphs, corresponding to graphs in \mathcal{G} satisfying the correction criterion. [Hug12] shows that this category can be extended to treat \perp , yielding a representation of the free *-autonomous category. Following [HHS17], \mathcal{A} might be seen as a representation of the free symmetric semi-monoidal closed category.

The objects of \mathcal{G} are signed sets, i.e. finite sets whose elements are assigned a polarity $\epsilon \in \{+, -\}$ (i.e. edges (s, α) , where $\alpha : s \to \{+, -\}$); Given $\epsilon \in \{+, -\}$, we let $\overline{\epsilon}$ be the opposite polarity; given a signed set s, we let \overline{s} be the signed set whose underlying set is the same as s and whose polarities are reversed. Given two signed sets s, t, we let s + t denote their disjoint union.

Arrows $f: s \to t$ in \mathcal{G} , called *graphs*, are bijections $s^+ + t^- \to s^- + t^+$ (where + indicates disjoint union). Equivalently, a graph $f: s \to t$ is a set of disjoint *edges*, i.e. disjoint edges of elements of $\overline{s} + t$ which can be of three types:

Type I: $e = (x^{\epsilon}, y^{\overline{\epsilon}})$, where $x \in s, y \in t$, for $\epsilon \in \{+, -\}$;

Type II: $e = (x^+, y^-)$, where $x, y \in \overline{s}$;

Type III: $e = (x^+, y^-)$, where $x, y \in t$.

A graph can be illustrated as a directed acyclic graph (as in fig 5a) by orienting edges from positive to negative. We will call a graph *pure* when it only consists of type I edges.

Composition of graphs is finite directed path composition (see [Hug12]), as illustrated in figure 5b. More precisely, given $f: s \to t$ and $g: t \to u$, $g \circ f$ is the bijection $h: s^+ + u^- \to s^- + u^+$ where

$$h(x) = \begin{cases} (f \circ g)^n f(x) & \text{if } x \in s^+ \text{ and } n \text{ minimum s.t.} (f \circ g)^n f(x) \in s^- + u^+ \\ (g \circ f)^n g(x) & \text{if } x \in u^- \text{ and } n \text{ minimum s.t.} (g \circ f)^n g(x) \in s^- + u^+ \end{cases}$$

The definition of $g \circ f$ relies on the following:

Lemma 2.1. If $f: s \to t$ and $g: t \to u$, then for each $x \in s^+$ (resp. $y \in u^-$) there exists an n such that $(f \circ g)^n f(x) \in s^- + u^+$ (resp. $(g \circ f)^n g(y) \in s^- + u^+$).

Proof. By a maximal chain in $f \circ g$ we indicate a sequence e_0, \ldots, e_{2k-1} of even length obtained by alternating a type III edge $e_{2i} \in f$ and a type II edge $e_{2i+1} \in g$ such that, for $i \leq k-1$, if e_{2i} is $(y^{\epsilon'}, z^{\epsilon})$, then e_{2i+1} is $(z^{\overline{\epsilon}}, w^{\epsilon''})$ and, moreover, $e_{2k-1} = (y^{\epsilon}, z^{\epsilon})$, where $z \in s^- + u^+$. If N is the cardinality of $t^+ + t^-$, then any chain in $f \circ g$ must have length < N. Now, if $x \in s^+$, then

either $f(x) \in s^-$ (then put n = 0), or $f(x) \in t^+$ is the start of a chain in $f \circ g$. Then for some n < N, the chain ends in some $z \in s^- + u^+$, and then $(f \circ g)^n f(x) = z$.

In order to introduce allowable graphs, we first define shapes. A shape corresponds to the switching of the syntactic tree of a $IMLL^-$ type. Hence, on the one hand the leaves of the shape form a signed set, so that an arrow between two shapes corresponds to a graph between the associated signed sets; on the other hand, by joining the graph with the shapes, we obtain a correction graph on which we can check the essential nets correction criterion ([MO03]).

Definition 2.1 (shape). A shape S is a rooted and labeled DAG whose leaves form a signed set vS, called the variable set of S. The nodes of a shape are either leaves (hence labeled by + or -) or labeled by \multimap^+ (resp. \otimes^+) or \multimap^- (resp. \otimes^-). The root of S is called the conclusion cS of S. If S is a shape, by \overline{S} we indicate the shape obtained from S by reversing the sign of its leaves and replacing all labels \multimap^{ϵ} - resp. \otimes^{ϵ} - by $\multimap^{\overline{\epsilon}}$ - resp. $\otimes^{\overline{\epsilon}}$. Shapes are defined inductively as follows:

- I is the shape +, $vI = \{+\}, cI = +;$
- if S, T are shapes, $S \multimap^+ T$ is the shape in figure 6a, $v(S \multimap^+ T) = v\overline{S} + vT$ and $c(S \multimap^+ T) = \multimap^+$; $c\overline{S}$ and cT are called, respectively, left and right premises of the node $c(S \multimap^+ T)$.
- if S, T are shapes, $S \multimap^{-} T$ is the shape in figure 6b, $v(S \multimap^{-} T) = vS + v\overline{T}$ and $c(S \multimap^{-} T) = -v^{-}$; cS and $c\overline{T}$ are called, respectively, left and right premises of the node $c(S \multimap^{-} T)$.
- if S, T are shapes, $S \otimes^+ T$ is the shape in figure 6c, $v(S \otimes^+ T) = vS + vT$ and $c(S \otimes^+ T) = \otimes^+$; cS and cT are called, respectively, left and right premises of the node $c(S \otimes^+ T)$.
- if S, T are shapes, $S \otimes^{-} T$ is the shape in figure 6d, $v(S \otimes^{-} T) = v\overline{S} + v\overline{T}$ and $c(S \otimes^{-} T) = \otimes^{-}$; $c\overline{S}$ and $c\overline{T}$ are called, respectively, left and right premises of the node $c(S \otimes^{-} T)$.

Given shapes S, T, by a graph $f: S \to T$ we indicate a graph $f: vS \to vT$. More generally, given a (non-empty) list $\Gamma = \{S_1, \ldots, S_n\}$ of shapes and a shape T, by a graph $f: \Gamma \to T$ we indicate a graph $f: S_1 \otimes \cdots \otimes S_n \to T$. Clearly, for any shape T there exists a pure graph $id_T: T \to T$. Given graphs $f_1: \Gamma_1 \to A_1, \ldots, f_n: \Gamma_n \to A_n$, we let $f_1 \otimes \cdots \otimes f_n: \Gamma_1, \ldots, \Gamma_n \to A_1 \otimes \cdots \otimes A_n$ be the graph $f_1 \cup \cdots \cup f_n$.

For any graph $f: S \to T$, the *correction graph* of f, noted $f \rightleftharpoons S \multimap T$, is the rooted directed graph $f \cup S \multimap T$, with root $c(S \multimap T)$, called the *conclusion* of $f \rightleftharpoons S \multimap T$.

Definition 2.2 (allowable graph). Let S, T be shapes and $f: S \to T$ be a graph. f is allowable (or correct) for $S \to T$ if $f \rightleftharpoons S \multimap T$ satisfies:

(acyclicity) $f = S \multimap T$ is a connected DAG;

(functionality) for every \multimap^+ node of $f \rightleftharpoons S \multimap T$, every path going from the conclusion to the left premiss of the node passes through the node.

In figure 7 the correction graph $id_S \rightleftharpoons S \to S$ is illustrated, where S is the shape $(I \otimes I) \multimap I$.

The category \mathcal{A} of allowable graphs has shapes S, T as objects and allowable graphs $f: S \to T$ as morphisms (with composition defined as in \mathcal{G}). \mathcal{A} can be presented also as a symmetric multicategory ([Lei04]) $m\mathcal{A}$ whose objects are shapes and whose multiarrows are graphs $f: \Gamma \to$ S, where Γ is a (possibly empty) list of shapes. Multicomposition is defined as follows: given (multi)arrows $f: B_1, \ldots, B_n \to C, g_1: \Delta_1 \to B_1, \ldots, g_n: \Delta_n \to B_n$, where the Δ_i indicate finite lists of shapes, one can define $f \circ_m (g_1, \ldots, g_n): \Delta_1, \ldots, \Delta_n \to C$ as $f \circ (g_1 \otimes \cdots \otimes g_n)$. Observe that, in $m\mathcal{A}$ one can consider arrows $f: \emptyset \to S$, corresponding to closed proofs. Due to the absence of the tensor unit in $IMLL^-$, such arrows do not exist in \mathcal{A} . In the following we will often confuse \mathcal{A} and $m\mathcal{A}$.

We let $\mathcal{A}^{-\circ}$ (resp. $m\mathcal{A}^{-\circ}$) indicate the subcategory of \mathcal{A} (resp. the sub-multicategory of $m\mathcal{A}$) whose shapes do not contain \otimes^+ and \otimes^- .

We let $\mathcal{L}_{\to,\otimes}$ be the language given by the grammar $A, B := X | A \multimap B | A \otimes B$, where $X \in \mathcal{V}$. Any linear type $A \in \mathcal{L}_{\to,\otimes}$ is obviously assigned a shape S_A and a *labeling*, i.e. a map $l_A : vS_A \to \mathcal{V}$ associating the leafs of S_A with a variable. $f : S \to T$ is a *labeled graph* (or, simply, a graph when no ambiguity occurs) $f : A \to B$ if $S_A = S, S_B = T$ and, by letting $l = l_A \cup l_B$, $(x, y) \in f \Rightarrow l(x) = l(y)$. A labeled graph (illustrated in figure 5c) can be though as a graph over signed multisets of variables. Given $X \in \mathcal{V}$, if $e = (x, y) \in f$ and l(x) = l(y) = X, then we say that the e is over X. Clearly, for any $A \in \mathcal{L}_{\to,\circ}$, if $S_A = T$, then id_T (which we will

note simply id_A) is a correct pure labeled graph from A to A. In the following we will often confuse between a linear type and its associated shape. We will also often confuse the context $\Gamma = \{x_1 : A_1, \ldots, x_n : A_n\}$ of linear types with the list of shapes $\Gamma = S_{A_1}, \ldots, S_{A_n}$.

If $f: A \to B$ is any (non necessarily correct) graph, then for any $X \in \mathcal{V}$, f induces a Xpairing of $A \multimap B$, i.e. a partition of all occurrences of X in $A \multimap B$ in pairs whose elements have opposite polarity.

We say that two types $A, B \in \mathcal{L}_{-\circ,\otimes}$ are *isomorphic* when there exist correct graph $f : A \to B$ and $g : B \to A$ such that $g \circ f = id_A$, $f \circ g = id_B$.

We conclude the presentation of allowable graphs by showing how to associate to any normal linear λ -term u such that $\Gamma \vdash u : A$ is derivable in $\lambda_{-\circ}$, an allowable graph $\mathcal{G}(u) : \Gamma \to A^4$. The definition of $\mathcal{G}(u)$ actually depends on Γ and A, so it should be written more pedantically as $\mathcal{G}_{\Gamma}^A(u)$, as different typings of the same λ -term give rise to different labeled graphs⁵).

For any linear type $A \in \mathcal{L}_{-\infty}$ we let $\pi A \subseteq \{1, \mathbf{r}\}^*$ (where 1 stands for "left" and \mathbf{r} stands for "right") be the set of all paths, i.e. all finite sequences of elements of $\{1, \mathbf{r}\}$, leading to variables in the syntactic tree of A. Given a context Γ and a linear type A, any element of $\overline{v\Gamma} + v(A)$, where $\overline{v\Gamma} = \overline{vA_0} + \cdots + \overline{vA_{n-1}}$ and $\Gamma = \{A_0, \ldots, A_{n-1}\}$, is uniquely determined by a pair (i, π) made of an index $i \in \{0, \ldots, n\}$ (by letting $A_n = A$) and a path $\pi \in \{1, \mathbf{r}\}^*$ such that $\pi \in \pi A_i$. Let $p(\Gamma, A)$ be the set of such pairs. There exists then a bijection $\alpha_{\Gamma,A} : p(\Gamma, A) \to \overline{v\Gamma} + v(A)$ where $\alpha(i, \pi)$ is the node corresponding to the path π in the syntactic tree of A_i . In case $\Gamma = \emptyset$, then there is a canonical bijection $\alpha_A : \pi A \to vA$ such that $\alpha_A(\pi)$ is the node corresponding to π in the syntactic tree of A. The translation can then be defined inductively as follows:

- 1. if u = x, then n = 1, $\Gamma = \{A_0\}$, $A_0 = A_1 = A$ and we have $x : A \vdash x : A$. Then $\mathcal{G}(u) = \{(\alpha_{A,A}(0,\pi), \alpha_{A,A}(1,\pi)) \mid \pi \in \pi A\};$
- 2. if $u = \lambda x^B . u'$, then we have $\Gamma, x : B \vdash u' : C$, so by induction hypothesis, the graph $\mathcal{G}(u')$ is defined. Observe that $\alpha_{\Gamma,B\multimap C} : p(\Gamma,B\multimap C) \to \overline{v\Gamma} + \overline{vB} + vC$ is defined by $\alpha_{\Gamma,B\multimap C}(i,\pi) = \alpha_{\Gamma\cup\{B\},C}(i,\pi)$ when i < n-1 and $\pi \in \pi A_i$, $\alpha_{\Gamma,B\multimap C}(n,1\cdot\pi) = \alpha_{\Gamma\cup\{B\},C}(n,\pi)$, when $\pi \in \pi B$ and $\alpha_{\Gamma,B\multimap C}(n,\mathbf{r}\cdot\pi) = \alpha_{\Gamma\cup\{B\},C}(n+1,\pi)$, when $\pi \in \pi B$. We put then $\mathcal{G}(u) := \alpha_{\Gamma,B\multimap C}(\alpha_{\Gamma\cup\{B\},C}^{-1}(\mathcal{G}(u')))$.
- 3. if $u = yu_1 \dots u_p$, where $y : C = B_1 \multimap \dots \multimap B_p \multimap A$, and $\Gamma_i \vdash u_i : B_i$, where the Γ_i form a partition of $\Gamma - \{C\}$, then by induction hypotheses the graphs $\mathcal{G}(u_i)$ are defined and we have bijections $\alpha_{\Gamma_i,B_i} : p(\Gamma_i,B_i) \to \overline{v\Gamma_i} + vB_i$ and $\alpha_C : \pi C \to vC, \alpha_A : \pi A \to vA$. $\alpha_{\Gamma,A} : p(\Gamma,A) \to \overline{v\Gamma} + vA$ is defined by $\alpha_{\Gamma,A}(\sum_{j < i} k_j + l,\pi) = \alpha_{\Gamma_i,B_i}(l,\pi)$, where $i < n - 1 \ \pi \in \pi A_i, \ k_j$ is the cardinality of Γ_j and $l \le k_i, \ \alpha_{\Gamma,A}(n - 1,\pi) = \alpha_C(\pi)$, for $\pi \in \pi C$ and $\alpha_{\Gamma,A}(n,\pi) = \alpha_A(\pi)$, for $\pi \in \pi A$. Then $\mathcal{G}(u) = \alpha_{\Gamma,A}(\alpha_{\Gamma_1,A_1}^{-1}(\mathcal{G}(u_1))) \cup \cdots \cup \alpha_{\Gamma,A}(\alpha_{\Gamma_p,B_p}^{-1}(\mathcal{G}(u_p))) \cup \{(\alpha_C(1^p \cdot \pi), \alpha_A(\pi)) \mid \pi \in \pi A\}$, where $\mathbf{r}^p \cdot \pi$ indicates $\underbrace{\mathbf{r} \cdots \mathbf{r}}_{p \text{ times}} \cdot \pi$.

We recall some standard results relating the λ -term u and its graph $\mathcal{G}(u)$:

Theorem 1 (adequacy, sequentialization and normalization, [Lam08, MO03]). Let u, v be normal λ -terms.

• If $\Gamma \vdash u : A$ is derivable in $\lambda_{-\circ}$, then $\mathcal{G}(u) : \Gamma \to A$ is allowable;

⁴Observe that we are here confusing the list $\Gamma = A_1, \ldots, A_n$ with the context $\Gamma = x_1 : A_1, \ldots, x_n : A_n$. We will often confuse them, if it creates no ambiguity.

⁵Indeed all such graphs can be obtained by suitable expansions from the graph $\mathcal{G}_{\Gamma_0}^{A_0}(u)$, where $\Gamma_0 \vdash u : A_0$ is a *principal typing* of u.

- if $f: \Gamma \to A$ is allowable, then for some normal u such that $\Gamma \vdash u: A$, $f = \mathcal{G}(u)$;
- if $\Gamma \vdash u : A$ and $x : A \vdash v : B$, then $\mathcal{G}(u) \circ \mathcal{G}(v) = \mathcal{G}(w)$, where w is the β -normal form of u[v/x].

2.3 Categories of typed λ -terms and their functorial interpretation

Since Lambek's pioneering work ([Lam69]), it has become standard to treat deductive systems as syntactic (multi)categories whose objects are formulas or types and whose arrows are equivalence classes of derivations. The categorial treatment of deductive systems allows to introduce their functorial interpretation in an internal way, i.e. by considering types as endofunctors over the syntactic categories of types and terms, and well-typed terms as dinatural transformations between such functors.

In the previous subsection we described the category \mathcal{A} generated by proof nets and we observed that, by suitably extending proof nets to unities, the syntactic category obtained corresponds either to the free *-autonomous category ([LS04, Hug12]) or to the free symmetric monoidal closed category ([BCST96]). We now briefly recall the categorial description of the simply typed λ -calculus and System F.

We let \mathcal{T} be the category generated by λ_{\Rightarrow} : the types of \mathcal{T} are the simple types and the arrows $u : A \to B$ are λ -terms u with exactly one free variable, such that $x : A \vdash u : B$ is derivable in λ_{\Rightarrow} , considered up to $\beta\eta$ -equivalence and up to renaming of its unique free variable. We will often note an arrow $u[z] : A \to B$, where z indicates its unique free variable. When no variable is indicated, we let x denote by convention the unique free variable of an arrow $u : A \to B$. The composition of arrows $u : A \to B$ and $v : B \to C$ is the arrow $v[u/x] : A \to C$, where x is the unique free variable in v. The symmetric multicategory $m\mathcal{T}$ can be defined in a similar way. As in the case of \mathcal{A} , when indicating a a multiarrow $u : \Gamma \to A$, we will confuse the list A_1, \ldots, A_n with the context $\Gamma = x_1 : A_1, \ldots, x_n : A_n$. As already mentioned, we will often confuse a category and its associated multicategory.

As is well-known, if λ_{\Rightarrow} is extended with finite products constructions, then the syntactic category obtained is the free cartesian closed category ([LS88]). Finally, we consider the syntactic categories \mathcal{F} and \mathcal{F}_{at} (and the respective multi-categories), defined similarly to $\mathcal{T}: \mathcal{F}$ (resp. \mathcal{F}_{at}) is the category having as objects the types in $\mathcal{L}_{\Rightarrow,\forall}$ and such that an arrow $u: A \to B$ is a λ -term (up to $\beta\eta$ -equivalence and renaming of its unique free variable) with exactly one free variable such that $x: A \vdash u: B$ is derivable in \mathcal{F} (resp. in \mathcal{F}_{at}).

Functorial polymorphism ([BFSS90]) is the interpretation of types as multivariant functors over a category (either symmetric monoidal closed or *-autonomous in the linear case - see [Blu93] - and cartesian closed in the non linear case -[GSS92]) and of typed terms as dinatural transformations between such types. We recall that, given a category C and multivariant functors $F, G : C^{op} \times C \to C$, a dinatural transformation between F and G is a family of arrows θ_A indexed by the objects of C such that, given objects A, B in C and an arrow $f : A \to B$, the following diagram commutes:



We can now define functorial interpretation by considering the categories \mathcal{A} , \mathcal{T} and \mathcal{F} . By considering the category \mathcal{A} (resp. \mathcal{T} , \mathcal{F}), any linear type (resp. simple type) A, depending on a variable X, can be interpreted as a multivariant endofunctor $A : \mathcal{A}^{op} \otimes \mathcal{A} \to \mathcal{A}$ (resp. $A : \mathcal{T}^{op} \times \mathcal{T} \to \mathcal{T}, A : \mathcal{F}^{op} \otimes \mathcal{F} \to \mathcal{F}$), which is covariant when A is p-X and contravariant when A is n-X.

Given types A, B, C in any of the above categories, we indicate by A[B, C] the type obtained by substituting B for the negative occurrences of X in A and C for the positive occurrences of X in A. Given types B, B', C, C' and arrows $u: B \to B', v: C \to C'$ we can define the arrow $A(u, v): A[B', C] \to A[B, C']$ in λ -calculus notation by induction on A as follows:

$$Y(u,v) = \begin{cases} v & \text{if } X = Y \\ Y & \text{otherwise} \end{cases}$$
$$(A_1 \Rightarrow A_2)(u,v) = A_1(v,u) \Rightarrow A_2(u,v)$$
$$\forall YA(u,v) = \Lambda Y.'A[Y'/Y](u,v)(xY')$$

where, given arrows $u[z]: B \to B'$ and $v[z']: C \to C'$, $(u \Rightarrow v)[x]: (B' \Rightarrow C) \to (B \Rightarrow C')$ is the arrow $\lambda y^B \cdot v[x(u[y/z])/z']$.

It is a standard result ([Blu93, GSS92]) that any arrow $f : A \to B$ in \mathcal{A} (resp. $u : A \to B$ in \mathcal{T}) corresponds to a dinatural transformation between the functors associated to A and B, respectively. This means that any arrow $u : A \to B$ in \mathcal{T} yields a dinatural transformation between A, and B, by letting $u_C : A(C, C) \to B(C, C)$ be u[C/X], that is, given any arrow $v : C \to C'$, the equation below

$$B(C,v) \circ u_C \circ A(v,C) = B(v,C') \circ u_{C'} \circ A(C',v)$$

$$(3)$$

where $u \circ v = \lambda x. u(vx)$, holds modulo $\beta \eta$ -equivalence.

This fact does not extend to \mathcal{F} ([dL09]): there exist well-typed System F terms which are not dinatural. This means that dinaturality generates an equational theory over System F terms which strictly extends $\beta\eta$ -equivalence (see [TPP17] for a proof theoretic discussion). We let T_{ε} indicate the λ^2 -theory generated by all equations 3 between arrows in \mathcal{F} . The equivalence \simeq_{ε} induced by T_{ε} captures then all equations between System F terms which hold when interpreting such terms in an arbitrary dinatural model of System F.

The functorial interpretation can be extended to proof nets and λ -terms with undischarged assumptions or free variables, respectively, by considering the *polynomial categories* $\mathcal{A}[x_1, \ldots, x_n]$, $\mathcal{T}[x_1, \ldots, x_n], \mathcal{F}[x_1, \ldots, x_n]$ (see [LS88]) obtained by adding to \mathcal{A}, \mathcal{T} and \mathcal{F} new arrows $x_i : \emptyset \to A_i$, for some types A_1, \ldots, A_n . This extension allows to consider the functorial action of types over terms with undischarged assumptions: for instance, let $x_1 : \emptyset \to A_1, \ldots, x_n : \emptyset \to A_n$ be "variable arrows" and $u : A_1, \ldots, A_n, C \to C', b : A_1, \ldots, A_n : D \to D'$ in \mathcal{T} ; then the functorial action of the type $A = X \Rightarrow X$ in $\mathcal{T}[x_1, \ldots, x_n]$ corresponds to an arrow A(u, v) : $A_1, \ldots, A_n, A[C', D] \to A[C, D']$ in \mathcal{T} . When considering polynomial categories, the theory T_{ε} can be defined in a more general and uniform way as the λ^2 -theory generated by all equations

$$B(C, yx) \circ u_C \circ A(yx, C) = B(yx, C') \circ u_{C'} \circ A(C', yx)$$

$$\tag{4}$$

where $u: A \to B$ in \mathcal{F} and $yx: C \to C'$ in the polynomial category $\mathcal{F}[y]$ generated by the variable arrow $y: \emptyset \to C \Rightarrow C'$. Observe that all instances of 3 can be deduced from 4 by using standard identity axioms (which hold in any λ^2 -theory).

As it will be clear in section 5, the functorial action of types over open terms is a basic tool in the functorial formulation of instantiation overflow for Russell-Prawitz types.

3 Proof net interpolation and the positivity lemma

In this section we discuss interpolation from the viewpoint of proof nets and we use it to prove the positivity lemma, which shows that, whenever a type A has a covariant (resp. contravariant) action over \mathcal{A} , then A is equivalent to a type containing only positive (resp. negative) occurrences of X. This result is in some sense the converse of the remark that a type containing only positive (resp. negative) occurrences of a variable is a covariant (resp. contravariant) endofunctor over \mathcal{A} (see section 5).

First, we recall proof net interpolation for $IMLL^-$ and we define the interpolation order \prec_I over linear types; then, we consider weak proof net interpolation for the fragment $\lambda_{-\infty}$ (proved in appendix A by adapting the argument in [BdG96] for $IMLL^-$ interpolation). Weak interpolation will be exploited to. Finally, we deduce the positivity lemma from proof net interpolation.

3.1 Proof net interpolation in *IMLL*⁻

Craig Interpolation for sequent calculus is usually formulated as follows (see [ST00]): given a cut-free natural deduction derivation of $\Gamma, \Delta \vdash A$, there exists a type *I*, called the *interpolant* of the derivation, such that the variables of *I* occur in both Γ and Δ, A and there exist two derivations of conclusions respectively $\Gamma \vdash I$ and $\Delta, I \vdash A$.

Sequent calculus interpolation for linear logic was first investigated in [Roo91], when it was realized that the statement above can be strengthened by considering proof nets. Indeed, by taking $\Delta = \emptyset$, interpolation yields a procedure to "split" the type II and type III parts of a proof net, yielding two graphs $f_1 : \Gamma \to I$, $f_2 : I \to A$, where f_1 contains the type II part of f, f_2 contains the type III part of f and both f_1 and f_2 contain the type I part of f.

This idea appears in two different approaches to proof net interpolation, the one in [BdG96] (inspired from [Roo91]) for $IMLL^-$, which we recall here, and the one in [Car97], based on flow graphs for the classical sequent calculus LK.

Let $A, B \in \mathcal{L}_{\multimap}$ and $\Gamma = \{B_1, \ldots, B_n\}$ be a finite multiset of types. We say that A *injects into* B (resp. A *injects into* Γ), noted $A \hookrightarrow B$ (resp. $A \hookrightarrow \Gamma$) if there exists an injective function $h: vA \to vB$ $(h: vA \to \sum_i vB_i)$ preserving polarities and labels.

The proof net interpolation problem for *IMLL*⁻ can be described as follows

Definition 3.1 (*IMLL*⁻ interpolation problem). Given $f: \Gamma \to A$ in \mathcal{A} , where $f_I, f_{II}, f_{III} \subseteq f$ denote its type I, type II and type III parts, respectively, find a linear type I, called the interpolant of f, such that $f_{II} \cup f_I : \Gamma \to I$ and $f_I \cup f_{III} : I \to A$ in \mathcal{A} .

Observe that, following definition 3.1, interpolation forces $I \hookrightarrow A$ and $I \hookrightarrow \Gamma$, as there exist type I edges connecting any variable occurrence of I with variable occurrences in both Γ and A.

The interpolation problem can be reformulated by considering graphs with cuts (as in [BdG96]). Let us add to the class of shapes the shapes cut^+ and cut^- in figure 8a and 8b, respectively. By cut we will generically indicate either cut^+ or cut^- .

By a graph with cuts we indicate a correct graph $f : \Gamma, cut, \ldots, cut \to A$, where Γ and A have no occurrence of cut. By a graph with n splitting cuts we indicate a graph with cuts $f : \Gamma, \underbrace{cut, \ldots, cut}_{n \text{ times}} \to A$ such that no type I edge of f connects Γ and A and no type II edge of f

connects any cut. A graph with splitting cuts can be described as a graph $f : \Gamma_1, \ldots, \Gamma_p \to A$, where $\Gamma_i = \Delta_i, cut, \ldots, cut$, where the Δ_i form a partition of Γ , and the correction graph is as in figure 9.

The interpolation problem can then be formulated as follows: given a graph $f : \Gamma \to A$ in \mathcal{A} , find a type $I \in \mathcal{L}_{-\infty,\otimes}$ such that the correction graph of f (illustrated in figure 10a) can be split

into a graph with one splitting cut as in figure 10b, preserving correctness. A simple example of interpolation is illustrated in figure 11b.

Theorem 2 ([BdG96], [Car97]). Any IMLL⁻ interpolation problem has a solution.

Interpolation allows to introduce an order over types, the *interpolation order* \prec_I , where $A \prec_I B$ holds if A is the interpolant of an allowable graph $f: B \to B$. Observe that, if $A \prec_I B$, then A and B are interderivable and $A \hookrightarrow B$. When $A \prec_I B$, we will say that B linearly collapses into A. If for no $A, A \prec_I B$, then B will be called \prec_I -minimal.

For example, the type $(X \multimap X) \multimap (X \multimap X)$ is not \prec_I -minimal, as it linearly collapses into the \prec_I -minimal type $X \multimap X$.

Observe that, if A linearly collapses into B and B linearly collapses into C, then A linearly collapses into C.

Let $\ell(A)$ indicate the number of variable occurrences in A (equivalently, the length of vA). If $A \prec_I B$, then $\ell(A) < \ell(B)$. Types with different lengths cannot be isomorphic:

Proposition 3.1. If $\ell(A) < \ell(B)$, then A is not isomorphic to B.

Proof. Suppose $f : A \to B$ and $g : B \to A$, then $f \circ g : B \to B$ contains both type II and type III edges, hence it cannot be the identity.

We deduce that, if A linearly collapses into B, then A cannot be isomorphic to B. The following is an immediate consequence of interpolation:

Lemma 3.1 (linear collapse lemma for $IMLL^{-}$). For any $A \in \mathcal{L}_{-\infty,\otimes}$, if $f : A \to A$ in \mathcal{A} contains at least one type III (or type II) edge, then A is not \prec_{I} -minimal.

The linear collapse lemma states that if a type A is \prec_I -minimal, then any correct graph $f: A \to A$ must be pure (hence a permutation of the identity graph). As an example we mention the graph $f: D \to D$, where $D = (X \multimap X) \multimap X$ shown in figure 11a: as the graph f is not pure, the type D is not minimal with respect to linear collapse. Indeed D linearly collapses onto X and the two graphs $g: D \to X, h: X \to D$, shown in figure 11b, are obtained by decomposing f.

3.2 Weak proof net interpolation in $\lambda_{-\circ}$

We now consider proof net interpolation for $\lambda_{-\circ}$. Interpolation 3.1 fails for this fragment: the interpolant of the graph $f: Y, Z \to (Y \multimap Z \multimap X) \multimap X$ is the type $Y \otimes Z \notin \mathcal{L}_{-\circ}$ and there is no interpolant for f in $\mathcal{L}_{-\circ}$.

It is well-known that interpolation similarly fails in the \Rightarrow -fragment of propositional intuitionistic logic (see [Kan06]). One usually considers a weak form of interpolation, which consists in admitting multiple interpolants. In the case of $\lambda_{-\circ}$, we can formulate weak interpolation as follows:

Definition 3.2 (weak $\lambda_{-\circ}$ interpolation problem). Given $f: \Gamma \to A$ in \mathcal{A} , where $f_I, f_{II}, f_{III} \subseteq f$ denote its type I, type II and type III parts, respectively, find a partition $\Gamma_1, \ldots, \Gamma_p$ of Γ , a partition f_I^1, \ldots, f_I^p of f_I , a partition $f_{II}^1, \ldots, f_{II}^p$ of f_{II} and types I_1, \ldots, I_p such that $f_{II}^i \cup f_I^i$: $\Gamma_i \to I_i$ and $f_I \cup f_{III}: I_1, \ldots, I_p \to A$ in \mathcal{A} .

Weak interpolation forces $I_i \hookrightarrow A$ and $I_i \hookrightarrow \Gamma_i$ for all $1 \le i \le p$.

The weak interpolation problem can be formulated by means of graphs with cuts as follows: given a graph $f: \Gamma \to A$ in \mathcal{A} find a partition $\Gamma_1, \ldots, \Gamma_p$ of Γ and p types I_1, \ldots, I_p such that the correction graph (figure 10a) can be split into a graph with p splitting cuts as in figure 12, preserving correctness.

By an argument similar to the one in [BdG96] we prove that weak interpolation problems admit solutions in $\lambda_{-\circ}$.

Theorem 3 (weak λ_{\sim} -interpolation). Any weak interpolation problem for λ_{\sim} admits a solution.

Proof. Proof in appendix A.

Remark 3.1. For a graph $f : A \to B$, weak interpolation coincides with interpolation. Indeed, by definition 3.2, if the weak interpolation problem for f has a solution, then there exist types I_1, \ldots, I_p and partitions f_I^i, f_{II}^i such that, for one i, say i = c, $f_{II}^i \cup f_I^i : A \to I_c$ and for all $i \neq c$, $f_{II}^i \cup f_I^i : \emptyset \to I_i$. However, as there can be no type III free graph $g : \emptyset \to I_i$, it must be p = 1 and I_c is the unique interpolant of f.

Remark 3.1 allows to extend the interpolation order to $\lambda_{-\circ}$: $A \prec_I B$ if A is the unique interpolant of an arrow $f: B \to B$ in \mathcal{A} . The linear collapse lemma can then be immediately extended to $\lambda_{-\circ}$:

Lemma 3.2 (linear collapse lemma for $\lambda_{-\infty}$). For any type A, if $f : A \to A$ is allowable and contains at least one type III (or type II) edge, then A is not \prec_I -minimal.

The linear collapse lemma states that if a type A is \prec_I -minimal, then any correct graph $f: A \to A$ must be pure a permutation of the identity graph.

3.3 The positivity lemma for *IMLL*⁻

By exploiting interpolation, we prove a fundamental lemma which characterizes the types which have a positive action over allowable graphs: if A is such a type (relatively to a variable X) then A collapses into a type containing only positive occurrences of X.

For any variable X, we say that a type $A \in \mathcal{L}_{-\infty}$ is p-X (resp. n-X) if it has no negative (resp. positive) occurrence of X.

Definition 3.3 (definable \mathcal{A} -morphism). A covariant (resp. contravariant) \mathcal{A} -morphism is given by a map F over shapes along with a map over allowable graphs in any polynomial extension $\mathcal{A}[x_1, \ldots, x_n]$ of \mathcal{A} such that:

- if $f: S \to T$ in $\mathcal{A}[x_1, \dots, x_n]$, then $F(f): F(S) \to F(T)$ (resp. $F(f): F(T) \to F(S)$ in $\mathcal{A}[x_1, \dots, x_n]$).
- F(f) preserves labelings: if $f : A \to B$, then $F(f) : F(A) \to F(B)$.

Given $X \in \mathcal{V}$, a type $A \in \mathcal{L}_{-\infty}$ is a definable covariant (resp. contravariant) \mathcal{A} -morphism in X if there is a covariant (resp. contravariant) \mathcal{A} -morphism F such that, for any shape S, F(S) = A[S/X].

Since p-X (resp- n-X) types are correspond to endofunctors $A : \mathcal{A}[x_1, \ldots, x_n] \to \mathcal{A}[x_1, \ldots, x_n]$ (resp. $A : \mathcal{A}^{op}[x_1, \ldots, x_n] \to \mathcal{A}[x_1, \ldots, x_n]$), they are in particular definable \mathcal{A} -morphisms.

Proposition 3.2. For all $X \in \mathcal{V}$, if $A \in \mathcal{L}_{-\infty,\otimes}$ is p-X (resp. n-X), then it is a definable covariant (resp. contravariant) \mathcal{A} -morphism in X.

Proof. By induction on A.

Conversely, a \mathcal{A} -morphism need not be an endofunctor over \mathcal{A} . If a type A is logically equivalent to a p-X type B, then one can define a positive action over allowable graphs for Astarting from the covariant functorial action of B. However, this action need not be functorial. For instance, since the type $A = (X \multimap X) \multimap X$ collapses into X, one can define a covariant action of A over allowable graphs by pre-composing and post-composing the functorial action of X with the arrows $g : A \to X$ and $h : X \to A$. However, with such definitions, A is not a functor, as the graph $A(id_X) = h \circ id_X \circ g$ has a type III edge, so $A(id_X) \neq id_X$.

We now show that a definable \mathcal{A} -morphism always collapses into a p-X type. By reasoning as above, this fact shows that p-X (resp. n-X) types are essentially the unique definable covariant endofunctors $A : \mathcal{A} \to \mathcal{A}$ (resp. $A : \mathcal{A}^{op} \to \mathcal{A}$).

Proposition 3.3 (positivity lemma). For all $X \in \mathcal{V}$, if $A \in \mathcal{L}_{-\infty,\otimes}$ is a definable covariant (resp. contravariant) \mathcal{A} morphism in X, then either A is p-X, or A linearly collapses into a p-X (resp. n-X) type.

Proof. Let $A \in \mathcal{L}_{\to,\otimes}$ be a definable \mathcal{A} -morphism in X. Let Y be a variable not occurring free in A and let f be the only labeled graph such that $f: X \to Y, X \to Y$ in $\mathcal{M}A$. Since f is an arrow $f: X \to Y$ in $\mathcal{A}[x]$, where $x: \emptyset \to X \to Y$ is a variable arrow, by hypothesis, there exists an arrow $A(f): A \to A[Y/X]$ in \mathcal{A} , corresponding to a graph $A(f): X \to Y, \ldots, X \to Y, A \to A[Y/X]$ in $\mathcal{M}A$. Observe that all type I edges over Y of A(f) are directed upwards (as Y only occurs positively in the hypotheses of f) and all edges over X of A(f) are type II, as X does not occur in the conclusion of f.

Let f^* be the graph obtained from A(f) by contracting all such edges as illustrated in figure 13. We have then $f^* : A \to A^*$, where A^* is the result of replacing, in A[Y/X] all (positive) occurrences of Y corresponding to type I edges of A(f) by X. Observe that A^* has no negative occurrence of X. Moreover, f^* is correct since all the paths in the correction graph of f^* come from paths in the correction graph of A(f) (as the latter contains a path from Y^+ to X^-).

Now two cases arise: if f^* has no type III edge over Y, then $A^*[Y/X] = A[Y/X]$ and A is p-X. Otherwise, if f^* has some type III edge over Y, we can apply theorem 2 : we find then

a type $A' \hookrightarrow A^*$ with no occurrence of Y and only positive occurrences of X and two correct graphs $g: A \to A'$ and $h: A' \to A^*$, with $h \circ g = f^*$. Since all edges over Y in h are type III, by a renaming $Y \mapsto X$ we see that $h: A' \to A$, since $A^*[X/Y] = A$. We conclude then that $A' \hookrightarrow A$ and A, A' are interderivable.

By proposition 3.3 and proposition 3.1 we deduce that the property of being p-X (resp. n-X) is stable under isomorphism:

Proposition 3.4. For any $X \in \mathcal{V}$ and $A \in \mathcal{L}_{-\infty}$ and $B \in \mathcal{L}_{-\infty}$ p-X (resp. n-X), A is isomorphic to B only if A is p-X (resp. n-X).

4 Interpolation and collapse in λ_{\Rightarrow}

In this section we extend the positivity lemma to λ_{\Rightarrow} , by proving a similar result for definable \mathcal{T} -morphisms. We exploit the linearization theorem, a folklore result in linear logic, which shows that arrows in \mathcal{T} factor through arrows in \mathcal{A} . Linearization allows to apply proof net (weak) interpolation to simply typable λ -terms, yielding a new weak interpolation result for λ_{\Rightarrow} , from which we deduce the positivity lemma similarly to the previous section.

4.1 The linearization theorem

The basic ingredient to generalize theorem 3 to $\mathcal{L}_{\Rightarrow}$ is theorem 4 below, which establishes a precise connection between \mathcal{T} and \mathcal{A} : any arrow in \mathcal{T} can be factorized through an arrow in \mathcal{A} . We first define linear expansions of types $A \in \mathcal{L}_{\Rightarrow}$.

We first define finear expansions of types $A \in \mathcal{L}_{\Rightarrow}$.

Definition 4.1 (linear expansions). For any type $A \in \mathcal{L}_{\Rightarrow}$, we define the sets $\mathcal{E}^+(A), \mathcal{E}^-(A) \subseteq \mathcal{L}_{\Rightarrow}$ of its positive and negative linear expansions, respectively, by induction on A:

- if A = X, then $\mathcal{E}^+(A) = \mathcal{E}^-(A) = \{A\}$;
- if $A = B_1 \Rightarrow \ldots \Rightarrow B_n \Rightarrow Z$, then

$$\mathcal{E}^+(A) = \{C_{11} \multimap \cdots \multimap C_{1k_1} \multimap \cdots \multimap \cdots \multimap C_{n1} \multimap \cdots \multimap C_{nk_n} \multimap Z \mid k_1, \dots, k_n \in \mathbb{N}, C_{ij} \in \mathcal{E}^-(B_i), \forall 1 \le i \le n, 1 \le j \le k_i\}$$
$$\mathcal{E}^-(A) = \{C_1 \multimap \cdots \multimap C_n \multimap Z \mid C_i \in \mathcal{E}^+(B_i)\}$$

The following are easily established.

Proposition 4.1. • *if* $B \in \mathcal{E}^+(A)$ *, then there exists* $u : B^{\Rightarrow} \to A$ *in* \mathcal{T} *;*

• if $B \in \mathcal{E}^{-}(A)$, then there exists $u : A \to B^{\Rightarrow}$ in \mathcal{T} .

We can now prove the linearization theorem.

Theorem 4 (Linearization). Let $u: \Gamma \to A$ be an arrow in \mathcal{T} , where $\Gamma = \{A_1, \ldots, A_p\}$. Then there exist integers d_1, \ldots, d_p , linear types $A_{ij}^- \in \mathcal{E}^-(A_i), A^+ \in \mathcal{E}^+(A)$, arrows $LIN_{ij}: A_i \to (A_{ij}^-)^{\Rightarrow}$, $coLIN: (A^+)^{\Rightarrow} \to A$ in \mathcal{T} and an arrow $\partial u: \Gamma^- \to A^+$ in \mathcal{A} , where $\Gamma^- = \{A_{ij}^- \mid 1 \leq i \leq p, 1 \leq j \leq d_i\}$, such that the following diagram commutes in \mathcal{T} (by seeing $\partial u: (\Gamma^-)^{\Rightarrow} \to (A^+)^{\Rightarrow}$ as an arrow in \mathcal{T})

where $LIN = (LIN_1, \ldots, LIN_p)$ and $LIN_i = (LIN_{i1}, \ldots, LIN_{id_i})$, that is,

$$coLIN[\partial u[LIN_{ij}/x_{ij}]/x] \simeq_{\beta\eta} u$$

Proof. Induction on the typing derivation of u:

- if u = x, then we have $x : A \vdash x : A$, so we put $A^- = A^+ = A^{-\circ}$, $d_1 = 1$ and $\partial u = u$;
- if $u = \lambda z^{B_1} . u'$, then we have $\frac{\Gamma, z : B_1 \vdash u' : B_2}{\Gamma \vdash u : B_1 \Rightarrow B_2}$, where $\Gamma = \{A_1, \ldots, A_p\}$, then by induction hypothesis there exist integers $e_1, \ldots e_{p+1}$, types $C_{11}, \ldots, C_{pe_p}, D_1, \ldots, D_{e_{p+1}}, D$, arrows $v_{ij} : A_j \to C_{ij}, v'_l[y] : B_1 \to D_l, w : D \to B_2$ and a linear term $\partial u'$ such that $x_{11} : C_{11}, \ldots, x_{pe_p} : C_{pe_p}, y_1 : D_1, \ldots, y_{e_{p+1}} : D_{e_{p+1}} \vdash \partial u : D$ and $w \left[\partial u'[v_{ij}/x_{ij}, v'_l/y_l]/x \right] \simeq_{\beta\eta} u'$.

We let then $d_1 = e_1, \ldots, d_p = e_p, A_{ij}^- = C_{ij}, A^+ = D_1 \Rightarrow \ldots \Rightarrow D_{e_{p+1}} \Rightarrow D$, and moreover $LIN_{ij} := u_{ij}, coLIN = \lambda z^{B_1} \cdot w [x(v_1'[z/y]) \ldots (v_{e_{p+1}}'[z/y])/x]$ and $\partial u := \lambda y_1^{D_1} \ldots \lambda y_{e_{p+1}}^{D_{e_{p+1}}} \cdot \partial u'$. We can compute then $coLIN(\partial u [LIN_{ij}/x_{ij}]) \simeq_{\beta\eta} \lambda z^{B_1} \cdot u' \simeq_{\beta\eta} u$

• if $u = xu_1 \dots u_q$, then $[x] = B_1 \Rightarrow \dots \Rightarrow B_q \Rightarrow A$ and $\Gamma \vdash u_i : B_i$, where $\Gamma = \{A_1, \dots, A_p\}$ and $A_k = B_1 \Rightarrow \dots \Rightarrow B_q \Rightarrow A$, for some $1 \le k \le p$, hence by induction hypothesis for all $1 \le l \le q$ there exist integers e_1^l, \dots, e_p^l , types $C_{11}^l, \dots, C_{pe_p}^l, C^l$, arrows $v_{ij}^l : B_l \Rightarrow P_{ij}^l$, $w^l[y] : C^l \to B_l$ and a linear term ∂u_l such that $x_{11}^l : C_{11}^l, \dots, x_{pe_p}^l : C_{pe_p}^l \vdash \partial u_l : C^l$ and $w^l[\partial u_l[v_{ij}^l/x_{ij}^l]/x] \simeq_{\beta\eta} u_l$.

We let then, for $1 \leq i \leq q$, $d_i := \sum_l^q e_i^l$, for $i \neq k$, and $d_k = (\sum_l^q e_k^l) + 1$, we let, for $i \neq k$ the A_{ij}^- be all C_{ij}^l , for all $1 \leq l \leq q$; for $j \leq d_k - 1$, we let the A_{jk}^- be all C_{kj}^l , for all $1 \leq l \leq q$, and we finally let $A_{d_kk}^-$ be $C^1 \Rightarrow \ldots \Rightarrow C^q \Rightarrow A$. Also, for $i \neq k$, we let the LIN_{ij} be all v_{ij}^l and for $j \leq d_k - 1$, the LIN_{kj} be all v_{kj}^l , and we let $LIN_{kd_k}[x] = \lambda z_1^{C_1} \dots \lambda z_q^{C_q} x(w^1[z_1/y]) \dots (w^q[z^q/y])$ and coLIN = x. We finally let $\partial u := x_{kd_k} \partial u_1 \dots \partial u_q$. We can compute then $coLIN[\partial u[LIN_{ij}/x_{ij}]/x] \simeq_{\beta}$ $LIN_{kd_k} (w^1[\partial u_1[v_{ij}^1/x_{ij}^1]/y]) \dots (w^q[\partial u_q[v_{ij}^q/x_{ij}^q]/y])) \simeq_{\beta\eta} u$.

Let us call a λ -term *clean* if $FV(u) \cap BV(u) = \emptyset$ and for any $x \in BV(u)$ there exists in u exactly one abstraction of the form λx . Clearly, any λ -term u is α -equivalent to a clean term, that we indicate u^* .

For any λ -term u, and any variable $x \in FV(u^*) \cup BV(u^*)$, let $s_x(u)$ indicate the number of occurrences of x in u^* . More precisely, we let

$$s_x(y) = \begin{cases} 1 & \text{if } x = y \\ 0 & \text{otherwise} \end{cases}$$
$$s_x(tu) = s_x t + s_x u$$
$$s_x(\lambda y.t) = \begin{cases} s_x(t) + 1 & \text{if } x = y \\ s_x(t) & \text{otherwise} \end{cases}$$

Let then the size of u, noted s(u), be the sum of all $s_x(u)$, for $x \in FV(u^*) \cup BV(u^*)$. Linearization preserves the size, in the following sense:

Lemma 4.1. Let $u : \Gamma \to A$ be an arrow in \mathcal{T} and $\partial u : \Gamma^- \to A^+$ be defined as in theorem 4. Then $s(u) = s(\partial u)$.

Proof. Simple verification by inspecting the proof of theorem 4.

4.2 Weak interpolation in λ_{\Rightarrow}

Similarly to the case of $\lambda_{\neg\circ}$, interpolation fails for λ_{\Rightarrow} (i.e. for the \Rightarrow -fragment of intuitionistic propositional logic): the interpolant of $\lambda z^{A\Rightarrow B\Rightarrow X}.zxy: A, B \rightarrow (A \Rightarrow B \Rightarrow X) \Rightarrow X$ is the product type $A \wedge B$ which is not a type in $\mathcal{L}_{\Rightarrow}$.

Weak interpolation for λ_{\Rightarrow} was investigated in [Wro84, Pen97, Kan06]. In particular, [Kan06] shows that, by suitably modifying the algorithm in [Pra65], one can always find strongest interpolants. By exploiting linearization and weak interpolation for $\lambda_{-\circ}$ we immediately obtain a new weak interpolation theorem for λ_{\Rightarrow} , theorem 5 below.

Due to the loss of linearity, the requirement that interpolant types inject into the conclusion and the context is replaced by the weaker requirement that the free type variables of the interpolant types be included into the free variables shared by the conclusion and the context.

Theorem 5 (weak interpolation for \mathcal{T}). Let $u : \Gamma \to A$ in \mathcal{T} and suppose ∂u is not pure. Then there exist simple types I_1, \ldots, I_p and arrows $v_j : \Gamma \to I_j, w : I_1, \ldots, I_p \to A$ such that

- 1. $FV(I_j) \subseteq FV(A) \cap FV(\Gamma);$
- 2. $(\sum_{j=1}^{p} s(v_j)) + s(v) < s(u);$
- 3. $v[v_1/x_1,\ldots,v_p/x_p] \simeq_{\beta\eta} u.$

Proof. By theorem 3 there exists an integer p, a partition $(\Gamma_1^-, \ldots, \Gamma_p^-)$ of Γ^- , types I_1, \ldots, I_p and a splitting of ∂u in \mathcal{A} into $v_j : \Gamma_j^- \to I_j$ and $v : I_1, \ldots, I_p \to A^+$.

Observe that, while the logical complexity of weak interpolants for an arrow $f: \Gamma \to A$ in \mathcal{A} is bounded by A, this need not be the case in \mathcal{T} . For instance, let $A = (X \Rightarrow X) \Rightarrow (X \Rightarrow X)$ and $u_k: A \to A$ be the term $\lambda y_1^{X \Rightarrow X} . \lambda y_2^X . y_1^k(xy_1y_2)$, for $k \in \mathbb{N}$. Let, for all $k \in \mathbb{N}$, $A_k = \underbrace{(X \multimap X) \multimap \cdots \multimap (X \multimap X)} \multimap A^{\multimap}$. Then $\partial u_{k+1}: A^{\multimap} \to A_{k+2}$ is not pure (see figure

¹⁴⁾ and can be split into $u_1 : A^{\rightarrow} \rightarrow A_{k+1}$ and $u_2 : A_{k+1} \rightarrow A_{k+2}$. We deduce that u_k is split into $v_1 : A \rightarrow A_{k+1}^{\Rightarrow}$ and $v_2 : A_{k+1}^{\Rightarrow} \rightarrow A$. The problem of investigating the growth in

complexity of interpolants is well investigated in the literature (see [SP98]). Observe that, while the size of interpolants might grow, the size of the terms decreases (condition 2. in theorem 5), as $s(v_1) < s(u)$ (one can easily compute $v_1 = u_k$).

Remark 3.1 cannot be extended to λ_{\Rightarrow} . In particular, an arrow $u : A \to B$ in \mathcal{T} might well have more than one interpolant. Take for instance $u : C \to C$, where $C = (X \Rightarrow X) \Rightarrow$ $(((A \Rightarrow X) \Rightarrow X) \Rightarrow ((B \Rightarrow X) \Rightarrow X) \Rightarrow X) \Rightarrow X$ and $u[x] = \lambda x_1^{C_1} \cdot \lambda x_2^{C_2} \cdot x_1(x_2 u_1 u_2)$, where $C_1 = X \Rightarrow X$, $C_2 = ((A \Rightarrow X) \Rightarrow X) \Rightarrow ((B \Rightarrow X) \Rightarrow X) \Rightarrow X$ and $u_1 = \lambda z^{A \Rightarrow X} \cdot x(\lambda y^X \cdot y(\lambda y_1^{(A \Rightarrow X) \Rightarrow X} \cdot \lambda y_2^{(B \Rightarrow X) \Rightarrow X} \cdot y_1 z)), u_2 = \lambda z^{B \Rightarrow X} \cdot x(\lambda y^X \cdot y(\lambda y_1^{(A \Rightarrow X) \Rightarrow X} \cdot \lambda y_2^{(B \Rightarrow X) \Rightarrow X} \cdot y_1 z)), u_2 = (A \Rightarrow X) \Rightarrow X$ and $I_2 = (B \Rightarrow X) \Rightarrow X$.

We define then the weak interpolation order \prec_{wI} as follows: $A \prec_{wI} B$ if A is among the interpolants of some arrow $u: B \to B$ in \mathcal{T} . When $\Gamma = \{I_1, \ldots, I_p\}$ are the interpolants of some arrow $u: B \to B$, we say that B collapses into Γ . If for no Γ , B collapses into Γ , then B is called \prec_{wI} -minimal.

The linear collapse lemma 3.1 can be extended to $\mathcal{L}_{\Rightarrow}$:

Lemma 4.2 (collapse lemma for \mathcal{T}). Let $u : A \to A$ be an arrow in \mathcal{T} such that ∂u contains a type III edge. Then A is not \prec_{wI} -minimal.

For instance, the arrow $u: C \to C$ discussed above shows that C is not \prec_{wI} -minimal and collapses into two minimal types I_1, I_2 .

4.3 The positivity lemma for λ_{\Rightarrow}

By exploiting weak interpolation, we now extend the positivity lemma 3.3 to λ_{\Rightarrow} .

The notions of p-X and n-X types for $\mathcal{L}_{\Rightarrow}$ are defined as for \mathcal{L}_{\multimap} . Observe that, if $B \in \mathcal{E}^{\epsilon}(A)$, then B is p-X (resp n-X) iff A is. We define definable \mathcal{T} -morphisms similarly to the case of \mathcal{A} .

Definition 4.2 (definable \mathcal{T} -morphism). A covariant (resp. contravariant) \mathcal{T} -morphism is given by a map F over simple types along with a map over arrows in any polynomial extension $\mathcal{T}[x_1, \ldots, x_n]$ of \mathcal{T} , such that, if $u : A \to B$ is an arrow in $\mathcal{T}[x_1, \ldots, x_n]$, then $F(u) : F(A) \to F(B)$ (resp. $F(u) : F(B) \to F(A)$) is an arrow in $\mathcal{T}[x_1, \ldots, x_n]$.

Given $X \in \mathcal{V}$, a simple type $A \in \mathcal{L}_{\Rightarrow}$ is a definable covariant (resp. contravariant) \mathcal{T} morphism in X if there is a covariant (resp. contravariant) \mathcal{T} morphism F such that, for any
simple type B, F(B) = A[B/X].

As for \mathcal{A} , for one direction, the fact that p-X (resp n-X) types correspond to covariant (resp. contravariant) functors can be deduced from the fact that all types are multivariant functors.

Proposition 4.2. For all $X \in \mathcal{V}$, if A is p-X (resp. n-X), then it is a covariant (resp. contravariant) definable \mathcal{T} -morphism in X. *Proof.* By induction on A.

The following proposition extends proposition 3.3 to \mathcal{T} .

Proposition 4.3. For all $X \in \mathcal{V}$, if $A \in \mathcal{L}_{\Rightarrow}$ is a covariant (resp. contravariant) definable \mathcal{T} -morphism in X, then either A is p-X (resp. n-X) or A collapses into a finite set of p-X (resp. n-X) types.

Proof. Let $A \in \mathcal{L}_{\Rightarrow}$ be a covariant definable \mathcal{T} -morphism in X. Let Y be a variable not occurring free in A and let $u = xy : X \Rightarrow Y, X \to Y$ in $m\mathcal{T}$. Since u is an arrow $u : X \to Y$ in $\mathcal{T}[x]$, where $x : \emptyset \to X \Rightarrow Y$ is a variable arrow, by hypothesis, there exists an arrow $A(u) : A \to A[Y/X]$, i.e. a λ -term $v = A(u) : X \Rightarrow Y, A \to A[Y/X]$.

By theorem 4, v is $\beta\eta$ -equivalent to $LIN(\partial v[LIN_j/x_j])$, where $\partial v : X \multimap Y, \ldots, X \multimap Y, A_1^-, \ldots, A_r^- \to A^+[Y/X]$, where $A_i^- \in \mathcal{E}^-(A)$ and $A^+ \in \mathcal{E}^+(A)$.

Suppose now A is not p-X; we deduce that A^+ is not p-X either. By reasoning similarly to the proof of proposition 3.3 we deduce that, if ∂v has no type III edge over X, then A^+ (and a fortiori A) is p-X, while if ∂v has a type III edge over X, then there exist p-X types $A_1, \ldots, A_p \in \mathcal{L}_{\to}$ such that $A_i \hookrightarrow A^+$ and linear terms v_1, \ldots, v_p, w such that $v_i : A_1^-, \ldots, A_{r_i}^- \to A_i$ and $w : A_1, \ldots, A_p \to A^+$. We conclude that A collapses into the p-X types $A_1^{\Rightarrow}, \ldots, A_p^{\Rightarrow}$.

By proposition 4.3 and the fact (proved in [BDCL91]) that type isomorphism $\mathcal{L}_{\Rightarrow}$ is trivial, i.e. $A \simeq B$ iff A = B, we have:

Proposition 4.4. For any $A \in \mathcal{L}_{\Rightarrow}$ and $B \in \mathcal{L}_{\Rightarrow}$ p-X (resp. n-X), A is isomorphic to B only if A is p-X (resp. n-X).

5 Instantiation overflow and Russell-Prawitz types

In this section we introduce the instantiation overflow property and its relation to Russell-Prawitz types. Moreover, we introduce some classes of types which generalize Russell-Prawitz types, though preserving the instantiation overflow property, and which will play a central role in the next sections. Our formulation of instantiation overflow essentially follows the functorial approach developed in [TPP16], which yields expansion terms equivalent to those in [FF13].

Functorial polymorphism is a useful tool to investigate the Russell-Prawitz translation, as the requirement that the translated connectives satisfy all properties of the original connectives corresponds to a dinaturality condition ([Has09]). In categorial terms, this requirement corresponds to asking that the RP translation preserves universal properties of connectives: for instance, that the RP translation of conjunction and disjunction preserve the universal properties of products and coproducts, respectively. In proof-theoretic terms, this means asking that the RP translation preserves the equational theory over derivations generated by β , η -equivalences and permuting conversions (see [TPP17]).

We will now describe instantiation overflow within the functorial framework introduced in subsection 2.3 and show that, when A is a RP type, the expansion term $IO_A(B) : \forall XA \rightarrow A[B/X]$, is equivalent, modulo dinaturality, to the term xB, corresponding to an instance of full extraction.

Definition 5.1 (instantiation overflow). A type of the form $\forall XA$ has the instantiation overflow property (IO for short) if, for any $B \in \mathcal{L}_{\Rightarrow,\forall}$, there exists an arrow $IO_A(B) : \forall XA \to A[B/X]$ in \mathcal{F}_{at} .

As it was discussed in the introduction, the types figuring as the Russell-Prawitz translation of logical connectives are examples of types having *IO*. These are types of the form $\forall X(A_1 \Rightarrow \dots \Rightarrow A_p \Rightarrow X)^6$, where the A_i are in turn of the form $B_i^1 \Rightarrow \dots \Rightarrow B_i^{n_i} \Rightarrow X$, with $X \notin FV(B_i^j)$.

Observe that the types A_i are p-X. This remark allows to define RP types formally as follows:

Definition 5.2 (*RP* type). For any $X \in \mathcal{V}$, a type $A \in \mathcal{L}_{\Rightarrow,\forall}$ is called a Russell-Prawitz type in X (*RP_X* for short) if $A = A_1 \Rightarrow \ldots \Rightarrow A_p \Rightarrow X$, where the A_i are p-X.

A type $A \in \mathcal{L}_{\Rightarrow,\forall}$ is called a Russell-Prawitz type (RP for short) if $A = \forall XA'$, where A' is RP_X .

We now show how to construct expansion terms for RP types by exploiting the functoriality of p-X types.

Proposition 5.1. Any RP type has IO.

Proof. Let B be the type $\forall \overline{Y}_1(B_1 \Rightarrow \forall \overline{Y}_2(B_2 \Rightarrow \ldots \Rightarrow \forall \overline{Y}_n(B_n \Rightarrow \forall \overline{Y}_{n+1}Z)))$. We let $Elim_B : B, B_1, \ldots, B_n \to Z$ be the term below

$$Elim_B := x\overline{Y}_1 x_1 \overline{Y}_2 x_2 \dots \overline{Y}_n x_n \overline{Y}_{n+1}$$

where \overline{Y}_i denotes a sequence of type variables $Y_{i1} \dots Y_{ik_i}$. We have that $x : B, \Delta \vdash Elim_B : Z$, where $\Delta = \{x_i : B_i \mid 1 \leq i \leq n\}$. For any arrow $u : \Gamma, \Delta \to Z$, where Δ is as before, we let $Intro_B(u)$ be the term below

$$Intro_B(u) = \Lambda \overline{Y}_1 . \lambda x_1^{B_1} . \Lambda \overline{Y}_2 . \lambda x_2^{B_2} . \dots . \Lambda \overline{Y}_n . u$$

where $\Lambda \overline{Y}_i$ indicates a finite sequence of abstractions $\Lambda Y_{i1} \dots \Lambda Y_{ik_i}$. We have that $\Gamma \vdash Intro_B(u) : B$

Let now $A = A_1 \Rightarrow \ldots \Rightarrow A_p \Rightarrow X$ be RP_X . We can define $IO_A(B)$ as follows:

$$IO_A(B) = \lambda x_1^{A_1[B/X]} \dots \lambda x_p^{A_p[B/X]} . Intro_B \left(xZ(A_1(Elim_B) \dots (A_p(Elim_B))) \right)$$

where $A_i(Elim_B)$ denotes the application of the definable \mathcal{T} -morphism A_i to the arrow $Elim_B$: $B \to X$ in \mathcal{T} and x_i is the unique variable of $A_i(Elim_B)$ of type $A_i[B/X]$.

The term $IO_A(B)$ corresponds to the derivation illustrated in figure 1 in the introduction.

We now show that the arrows $IO_A(B) : \forall XA \to A[B/X]$ in \mathcal{F}_{at} are equivalent, modulo dinaturality, to the arrows $xB : \forall XA \to A[B/X]$ in \mathcal{F} , obtained by one instance of the full extraction rule. This fact says that atomic polymorphism and full polymorphism for RP types are indistiguishable modulo dinaturality/parametricity.

We recall that \simeq_{ε} , introduced in subsection 2.3, indicates the λ^2 -theory extending $\beta\eta$ -equivalence and generated by dinaturality.

Proposition 5.2. Let $\forall XA \in \mathcal{L}_{\Rightarrow}$ be RP. Then, for all $B \in \mathcal{L}_{\Rightarrow,\forall}$, $IO_A(B) \simeq_{\varepsilon} xB$.

Proof. Let $A = A_1 \Rightarrow \ldots \Rightarrow A_p \Rightarrow X$, where the A_i are p-X. For all $B = \forall \overline{Y}_1(B_1 \Rightarrow \ldots \forall \overline{Y}_n(B_n \Rightarrow \forall \overline{Y}_{n+1}Z) \ldots)$, let us consider the polynomial category $\mathcal{F}[x_1, \ldots, x_n]$, with variable arrows $x_i : \emptyset \to B_i$.

⁶Here, for simplicity, we only consider types translating propositional connectives. A more general treatment of Russell-Prawitz types requires to define them as types of the form $\forall X \forall \overline{Y}_1(A_1 \Rightarrow \ldots \Rightarrow \forall \overline{Y}_p(A_p \Rightarrow X))$, in order to account also for the translation of second order existential quantification $\exists YA$ as $\forall X (\forall Y(A \Rightarrow X) \Rightarrow X)$.

Let, for any type C, $ext_C[x]$ indicate the term xC; we have that $A(Elim_B, Z) \circ ext_Z = ext_Z(A_1(Elim_B)) \dots (A_p(Elim_B)) : \forall XA \to A[Z, Z]$, hence $IO_A(B)$ can be written as

$$IO_A(B) = \lambda z_1^{A_1[B/X]} \dots \lambda z_p^{A_p[B/X]} Intro_B(A(Elim_B, Z) \circ ext_Z)$$

Observe that $A(Elim_B, Z) : A[Z, Z] \to A[B, Z]$ and $A(B, Elim_B) : A[B, B] \to A[B, Z]$. Hence, dinaturality yields

$$\begin{array}{c} \forall XA \xrightarrow{ext_{Z}[x]} & A[Z, Z] \\ ext_{B}[x] \downarrow & \downarrow A(Elim_{B}, Z) \\ A[B, B] \xrightarrow{A(B, Elim_{B})} & A[B, Z] \end{array}$$

i.e. $A(Elim_B, Z) \circ ext_Z \simeq_{\varepsilon} A(B, Elim_B) \circ ext_B$, and we can compute $A(B, Elim_B) \circ ext_B \simeq_{\beta\eta} \lambda z_1^{A_1[B/X]} \dots \lambda z_p^{A_p[B/X]} Elim_B[ext_B z_1 \dots z_n/x]$. We finally deduce

$$IO_A(B) = \lambda z_1^{A_1[B/X]} \dots \lambda z_p^{A_p[B/X]} . Intro_B(Elim_B[ext_B[x]z_1 \dots z_p/x]) \simeq_{\beta\eta} ext_B[x]$$

We introduce now two classes of types, quasi Russell-Prawitz types and generalized Russell-Prawitz types, which will play a central role in the next sections. These classes generalize definition 5.2 though preserving the instantiation overflow property.

Definition 5.3 (*qRP* and *gRP* types). A quasi Russell-Prawitz type in X (*qRP_X*) is a type of the form $A_0[R/X]$, where A_0 is p-X and has a unique occurrence of X and R is RP_X . If $\mathcal{X} \subset \mathcal{V}$, a quasi Russell-Prawitz type in \mathcal{X} (*qRP_X*) is a type which is *qRP_X* for all $X \in \mathcal{X}$;

A generalized Russell-Prawitz type in X (gRP_X) is a type of the form $A[X/X_1, \ldots, X/X_p]$, where A is $qRP_{\{X_1,\ldots,X_p\}}$.

For all $A \in \mathcal{L}_{\Rightarrow}$, the type $\forall XA$ is called quasi Russell-Prawitz, qRP for short (resp. generalized Russell-Prawitz, gRP for short), when A is qRP_X (resp. A is gRP_X).

An example of a qRP type is the type $\forall X((X \Rightarrow X) \Rightarrow C) \Rightarrow D)$, where $X \notin FV(C), FV(D)$. Examples of gRP types are $\forall X((X \Rightarrow X) \Rightarrow X) \Rightarrow X), \forall X(X \Rightarrow (((A \Rightarrow X) \Rightarrow X) \Rightarrow B) \Rightarrow X)$, where $x \notin FV(A), FV(B)$.

In section 8 we briefly discuss the relation between gRP types and the Russell-Prawitz translation. As it will be clear from the next section, qRP and gRP types generalize RP types in the sense that we can construct expansion terms $IO_A(B)$ for them in a way similar to RP types. Indeed, one can easily extend instantiation overflow to quasi Russell-Prawitz types by exploiting the functoriality of A_0 . The extension to generalized Russell-Prawitz types is a bit more involved and will be treated in the following sections, through an equivalent inductive definition of gRP_X types.

Generalized Russell-Prawitz types can be seen as qRP_{χ} types from which we deleted informations about how to localize its Russell-Prawitz subtypes. However, we will show (proposition 7.5) that, given a closed term of type a gRP_X type, one can always "separate variables", i.e. rename variables so to transform the term into a term of type a qRP_{χ} type.

The definition of RP_X , qRP_X and gRP_X types can be adapted to $\lambda_{-\circ}$. Linear Russell-Prawitz types are defined as follows:

Definition 5.4 (linear RP_X type). For any variable X, a type $A \in \mathcal{L}_{-\infty}$ is called a linear Russell-Prawitz type in X if $A = A_1 - \cdots - A_p - X$, where all A_i have no occurrence of X but one, which is p-X and has exactly one positive occurrence of X. For instance, the type $C = (A \multimap B \multimap X) \multimap X$ (we suppose $X \notin FV(A), FV(AB)$), translating the linear connective $A \otimes B$, is linear RP_X . Clearly, if A is a linear RP_X type, then A^{\Rightarrow} is RP_X . However the converse need not hold: for instance, while $(A \Rightarrow X) \Rightarrow (B \Rightarrow X) \Rightarrow X$ is RP_X (again, we suppose $X \notin FV(A), FV(AB)$) the type $(A \multimap X) \multimap (B \multimap X) \Rightarrow X$ is not a linear Russell-Prawitz type in X.

Linear qRP_X and gRP_X types are defined as in definition 5.3. For instance, let $D = (A \multimap B \multimap X) \multimap X$, where $X \notin FV(A)$, FV(B) be the linear RP_X type discussed above. The type $(D \multimap Y) \multimap (Y \multimap Y) \multimap Z$ is linear qRP_X . The types $((X \multimap X) \multimap X') \multimap X'$ and $(D \multimap Y) \multimap (D[X'/X] \multimap Y) \multimap Z$ are linear $qRP_{\{X,X'\}}$. Finally, the types $((X \multimap X) \multimap X) \multimap X) \multimap X$ and $(D \multimap Y) \multimap (D \multimap Y) \multimap Z$ are linear gRP_X .

6 The linear expansion property

In this section we characterize the types $A \in \mathcal{L}_{-\circ}$ which have the *linear expansion property*: for any $B \in \mathcal{L}_{-\circ}$, there exists an arrow $EXP_A(B) : A[Z/X] \to A[B/X]$ in \mathcal{A} , where Z is the rightmost variable in B. This property is obviously related to instantiation overflow: if A is linearly expansible, then $\forall X A^{\Rightarrow}$ has instantiation overflow.

We characterize the class of linearly expansible types by showing that linear gRP_X types are "dense" in that class. More precisely, we show that, if a type A is linearly expansible, then either A is gRP_X or A linearly collapses into a gRP_X type. Our argument is based on two graphical characterizations of linear gRP_X types as (1) those types admitting an internal pairing (proposition 6.2) and (2) those paired types for which all simple expansion graphs are correct (proposition 6.6).

6.1 Linearly expansible types and simple expansion graphs

We fix for all this section a variable X. For any type A, we indicate by n(A) the number of occurrences of X in A and by $n^+(A)$ (resp. $n^-(A)$) the number of positive (resp. negative) occurrences of X in A, respectively. We will call a type A paired in $n^+(A) = n^-(A)$.

Definition 6.1. A type $A \in \mathcal{L}_{\neg \circ}$ is weakly linearly expansible in X (resp. linearly expansible in X) if for every linear types $C_1, \ldots, C_p \in \mathcal{L}_{\neg \circ}$, there exists a graph (resp. an allowable graph) $EXP_A(B) : A \to A[B/X]$, where B is $C_1 \multimap \cdots \multimap C_p \multimap X$.

Dually, a type $A \in \mathcal{L}_{-\infty}$ is weakly co-linearly expansible in X (resp. co-linearly expansible in X) if for every linear types $C_1, \ldots, C_p \in \mathcal{L}_{-\infty}$, there exists a graph (resp. an allowable graph) $coEXP_A(B): A[B/X] \to A$, where B is $C_1 \multimap \cdots \multimap C_p \multimap X$.

If A is linearly expansible then, for any linear type $B = B_1 \multimap \cdots \multimap B_n \multimap Y$, there exists a correct graph $f : A[Y/X] \to A[B/X]$: indeed, by definition 6.1 there exists a correct graph $f : A \to A[C/X]$, where $C = B'_1 \multimap \cdots \multimap B'_n \multimap X$, and the B'_i are such that $B'_i[Y/X] = B_i$, hence in particular, f is a correct graph $f : A[Y/X] \to A[B/X]$. Conversely, if for any linear type $B = B_1 \multimap \cdots \multimap B_n \multimap Y$, there exists a correct graph $f : A[Y/X] \to A[B/X]$, then for any types C_1, \ldots, C_n , f is a correct graph $f : A \to A[D/X]$, where $D = C_1 \multimap \cdots \multimap C_n \multimap X$.

Let $A, B \in \mathcal{L}_{\rightarrow}$, $B = B_1 \longrightarrow \cdots \longrightarrow B_n \longrightarrow X$ and $f : A \to A[B/X]$, not necessarily correct. f is called a simple B-expansion of A if $id_A \subseteq f$. Dually, a graph $f : A[B/X] \to A$ is called a simple B-coexpansion of A if $id_A \subseteq f$.

Examples of simple *B*-expansions and *B*-coexpansions are shown in figure 15, for the paired types $X \multimap X$ and $(Y \multimap X) \multimap (X \multimap Z)$, respectively. Simple expansions might fail to be correct. For instance the simple $Y \multimap X$ -expansion in figure 15b is not correct.

The following proposition characterizes weakly linearly expansible types:

Proposition 6.1. A is weakly linearly expansible (resp. weakly co-linearly expansible) iff A is paired.

Proof. If a type A is paired, then let p(A) be the set of its X-pairings, i.e. the set of all partitions of the occurrences of X in A into edges of occurrences of opposite polarity. Hence, for any $p \in p(A)$ and $B = B_1 \longrightarrow \cdots \longrightarrow B_n \longrightarrow X$, we can define a simple B-expansion $f_p: A \to A[B/X]$ by joining id_A with edges connecting occurrences of B_i of opposite polarity corresponding to edges in p. One can similarly define a simple B-coexpansion $f_p: A[B/X] \to A$.

If A is not paired then, by letting Y be a variable not appearing in A and $B = Y \multimap X$, there can be no graph $f: A \to A[B/X]$, since the number of occurrences of Y in $A \multimap A[B/X]$ is odd.

To investigate linearly expansible types we must take into consideration the correction criterion for simple expansion graphs. In the following subsections we will show that the paired types whose simple expansion graphs are always corrects are exactly the linear gRP_X types.

6.2 Linear generalized Russell-Prawitz types

In the rest of this section, by a RP_X (resp. qRP_X, gRP_X) we will indicate a linear Russell-Prawitz type in X (resp. quasi Russell-Prawitz in X, generalized Russell-Prawitz in X).

If the linear types A_1, \ldots, A_n are qRP_X (resp. qRP_X, gRP_X) and $Z \neq X$ (resp. $Z \notin \mathcal{X}$, $Z \neq X$), then the type $A_1 \multimap \cdots \multimap A_n \multimap Z$ is called $co - qRP_X$ (resp. $co - qRP_X$, $co - gRP_X$).

We given now a different, inductive, definition of gRP_X and $co-gRP_X$ types. The equivalence of definition 5.3 and the one below is proved at the end of this section (proposition 6.3). The inductive definition will allow us to obtain two different graphical characterizations of gRP_X types.

Definition 6.2 (linear gRP_X type, inductive definition). We define by mutual induction the classes gRP_X^n , $co - gRP_X^n \subseteq \mathcal{L}_{\rightarrow}$, for $n \in \mathbb{N}$, as follows:

1. if A has no occurrence of X, then $A \in gRP_X^0$, $co - gRP_X^0$;

- 2. $X \in co gRP_X^1;$
- 3. if $B \in gRP_X^p$ and $C \in co gRP_X^q$, then $B \multimap C \in co gRP_X^{p+q}$;
- 4. if $B \in co gRP_X^p$ and $C \in gRP_X^q$, then $B \multimap C \in gRP_X^{p+q}$;
- 5. if $A_1 \in co gRP_X^{n_1}, \ldots, A_p \in co gRP_X^{n_p}$ and for at least one $1 \leq i \leq p, i \neq 0$, then $A_1 \multimap \cdots \multimap A_p \multimap X$ is in $gRP_{(\sum_i^p i_i)-1}^X$.
- We let $gRP_X := gRP_X^0$ (resp. $co gRP_X = co gRP_X^0$).

It can be verified by induction that

- if $A \in gRP_X^0$ or $A \in co gRP_X^0$, then $n^+(A) = n^-(A)$;
- if $A \in co gRP_X^n$, then $n^+(A) = n^-(A) + n$;
- if $A \in gRP_X^n$, then $n^-(A) = n^+(A) + n$.

Given a linear type $A \in \mathcal{L}_{-\infty}$, we indicate each occurrence of X in A by a distinct label $\alpha \in \mathbb{N}$. We introduce the notion of (n, ϵ) -pairing:

Definition 6.3 (pairing). Let $A \in \mathcal{L}_{-\infty}$ be such that $n^+(A) = n^-(A) + q$ (resp. $n^-(A) = n^+(A) + q$). A (q, +)-pairing (resp. (q, -)-pairing) of A is a pair $(\mathfrak{p}, \mathfrak{a})$ where $\mathfrak{a} = \{\alpha_1, \ldots, \alpha_q\}$ is a set containing labels of distinct positive (resp. negative) occurrences of X in A and \mathfrak{p} is a pairing of the remaining $2 \cdot n^+(A)$ occurrences of X in A.

For instance, $((X_{\alpha}^+, X_{\beta}^-), \{X_{\gamma}^+\})$ is a (1, +) pairing of the linear type $(X_{\alpha} \multimap X_{\beta}) \multimap X_{\gamma}$ and $((X_{\gamma}^+, X_{\beta}^-), \{X_{\alpha}^-\})$ is a (1, -) pairing of the linear type $X_{\alpha} \multimap X_{\beta} \multimap X_{\gamma}$.

The definition below associates with any gRP_X or $co - gRP_X$ type A a set of pairings P(A).

Definition 6.4. To any $A \in gRP_X^n$ (resp. $A \in co - gRP_X^n$) we associate a set of (n, -)-pairings (resp. (n, +)-pairings) $P_n(A)$ as follows;

- 1. if A has no occurrence of X, then $P_0(A) = \{(\emptyset, \emptyset)\};$
- 2. if $A = X_{\alpha}$, then $P_1(A) = \{(\emptyset, \{\alpha\})\};$
- 3. if $A = B \multimap C$, where $B \in gRP_X^{n_1}, C \in co-gRP_X^{n_2}$, then $P_d(A)$, where $d = n_1+n_2$, contains all (d, +)-pairings of the form $(\mathfrak{p} \cup \mathfrak{q}, \mathfrak{a} \cup \mathfrak{b})$, where $(\mathfrak{p}, \mathfrak{a}) \in P_{n_1}(B)$, $(\mathfrak{q}, \mathfrak{b}) \in P_{n_2}(C)$;
- 4. if $A = B \multimap C$, where $B \in co-gRP_X^{n_1}, C \in gRP_X^{n_2}$, then $P_d(A)$, where $d = n_1+n_2$, contains all (d, -)-pairings of the form $(\mathfrak{p} \cup \mathfrak{q}, \mathfrak{a} \cup \mathfrak{b})$, where $(\mathfrak{p}, \mathfrak{a}) \in P_{n_1}(B)$, $(\mathfrak{q}, \mathfrak{b}) \in P_{n_2}(C)$;
- 5. if $A = A_1 \multimap \cdots \multimap A_k \multimap X_{\alpha}$, with $A_i \in co gRP_X^{n_i}$ and for some $1 \le k \le i, k \ne 0$, then $P_d(A)$, where $d = (\sum_i^p n_i) 1$ contains all (d, -)-pairings of the form $(\mathfrak{p}_1 \cup \cdots \cup \mathfrak{p}_k \cup \mathfrak{p} \cup \{(\beta, \alpha)\}, \mathfrak{c})$, where $(\mathfrak{p}_i, \mathfrak{a}_i) \in P_{n_i}(A_i), \beta \in \bigcup_i \mathfrak{a}_i$ and $\mathfrak{c} = \bigcup \mathfrak{a}_i \{\beta\}$.

If $A \in gRP_X$ or $A \in co - gRP_X$, then we let $P(A) = \{ \mathfrak{p} \mid (\mathfrak{p}, \emptyset) \in P_0(A) \}.$

We will now show that gRP_X and $co - gRP_X$ types can be characterized by the properties of their pairings.

We introduce some terminology about correction graphs: with abuse of notation, we will make no distinction between the type A and the shape S_A . In particular, by a $-o^+$ -node (resp. $-o^-$ -node) in A we indicate a positive (resp. negative) occurrence of a type B - o C in A. By

the positive branch (illustrated in figure 16a) of a \multimap^+ -node l we indicate the list of all \multimap^+ -node which are reachable in S_A going upwards from l plus the positive occurrence of a variable appearing at the end of this branch. Similarly, by a negative branch (illustrated in figure 16b) of a \multimap^- -node we indicate the list of all \multimap^- -node from which l is reachable in S_A plus the negative occurrence of a variable from which all such nodes are reachable going downwards.

Also, by the *tree of a node* \multimap^{ϵ} we indicate the subtree having the node as root (and also the corresponding occurrence of a subtype of A). By the *maximal tree of a* \multimap^+ (*resp.* \multimap^-) node l we indicate the subtree having as root the first (resp. last) \multimap^+ (resp. \multimap^-) node l' of the positive (resp. negative) branch of l.

Let A be a type and $e = (X_{\alpha}^+, X_{\beta}^-)$ indicate an edge made, respectively, of a positive and a negative occurrence of X in A. We will say that e is a *jump out* edge in A if either X_{α} is the conclusion of the positive branch starting in a $-\circ^+$ -node and X^- occurs outside of the maximal tree of this node, or X_{α} is lefthand premiss of a $-\circ^-$ -node.

The dual notion is that of a *jump in* edge in A, that is an edge $e = (X_{\alpha}^+, X_{\beta}^-)$ such that either X_{β}^- is the start of the negative branch ending in a $-\infty^-$ -node and X^+ occurs outside of the maximal tree of this node, or X_{β}^- is lefthand premises of a $-\infty^+$ -node.

An edge $e = (X_{\alpha}^+, X_{\beta}^-)$ which is not a jump out in A, i.e. such that X_{α}^+ is the conclusion of the positive branch of a \multimap^+ node l and X_{β}^- occurs inside the maximal tree of l, is called an *internal edge*.

For instance, in the type $((X_{\alpha}^{-} \multimap X_{\alpha'}^{+}) \multimap X_{\beta}^{-}) \multimap X_{\beta'}^{+}$ the edge $(X_{\beta'}^{+}, X_{\alpha}^{-})$ is internal, the edge $(X_{\alpha'}^{+}, X_{\beta}^{-})$ is a jump out edge and the edge $(X_{\alpha'}^{+}, X_{\alpha}^{-})$ is both internal and a jump in edge.

The proposition below characterizes gRP_n^X and $co - gRP_n^X$ types by properties of their (n, ϵ) -pairings. In particular, it characterizes gRP_X types as those which have a pairing made of internal edges.

Proposition 6.2. For any $A \in \mathcal{L}_{\neg}$ and $n \in \mathbb{N}$,

- i. $A \in gRP_X^n$ iff A has a (n, -)-pairing with no jump out;
- ii. $A \in co gRP_X^n$ iff A has a (n, +)-pairing with no jump in.

Proof. For one direction it suffices to verify that, if $A \in gRP_X^n$ (resp. $A \in co - gRP_X^n$), then any $p \in P_n(A)$ has no jump out (resp. jump in). This can be done by induction on definition 6.2.

For the converse direction we argue by induction on A; if A has no occurrence of X, then the claims are trivially true, so we will suppose that A contains at least one occurrence of X. If A = X claim i. is trivially true (as A has no (n, -)-pairing) and claim ii. is true, as $A \in co - gRP_X^n$.

Let then $A = A_1 \multimap \cdots \multimap o A_k \multimap Z$:

a. if A admits a (n, -)-pairing $(\mathfrak{p}, \mathfrak{a})$ with no jump out, then two cases arise:

- a1. if $Z \neq X$, then \mathfrak{p} splits into $\mathfrak{p}_1 \cup \cdots \cup \mathfrak{p}_k$, where the variables in \mathfrak{p}_i occur in A_i , since any edge $(X_{\alpha}^+, X_{\beta}^-)$ with $X_{\alpha}^+ \in A_i$ and $X_{\beta}^- \in A_j$ and $j \neq i$ is a jump out. As the $\alpha_1, \ldots, \alpha_n \in \mathfrak{a}$ are distributed among the A_i , we deduce that there exist integers n_1, \ldots, n_k such that $\sum_i^k n_i = n$, a partition of $\mathfrak{a}_1, \ldots, \mathfrak{a}_k$ of \mathfrak{a} , where \mathfrak{a}_i has cardinality n_i , and that $(\mathfrak{p}_i, \mathfrak{a}_i)$ is a $(n_i, +)$ -pairing of A_i with no jump in. By induction hypothesis we get $A_i \in co - gRP_X^{n_i}$ and we conclude $A \in gRP_X^n$ by clause 4.
- a2. if $Z = X_{\alpha}^+$, then X_{α}^+ is paired in p with a positive occurrence X_{β} in some A_i , say A_c . By reasoning as above, we obtain that \mathfrak{p} splits into $\mathfrak{p}_1 \cup \cdots \cup \mathfrak{p}_{c-1} \cup \mathfrak{p}_c \cup \mathfrak{p}_{c+1} \cup \cdots \cup \mathfrak{p}_n \cup \{(X_{\alpha}, X_{\beta})\}$ where the variables in \mathfrak{p}_i occur in A_c . As β and the $\alpha_1, \ldots, \alpha_n$ in \mathfrak{a} are distributed among the A_i , we deduce that there exist integers n_1, \ldots, n_k such that $\sum_i^k n_i = n + 1$, a partition $\mathfrak{a}_1, \ldots, \mathfrak{a}_n$ of \mathfrak{a} , where \mathfrak{a}_i has cardinality n_i , and that $(\mathfrak{p}_i, \mathfrak{a}_i)$, for $i \neq c$ is a $(n_i, +)$ -pairing of A_i^- with no jump in, while $(\mathfrak{p}_c, \mathfrak{a}_c \cup \{\beta\})$ is a $(n_c, +)$ -pairing of A_c with no jump in. By applying the induction hypothesis we get $A_i \in co - gRP_X^{n_i}$ and we conclude $A \in gRP_X^n$ by clause 5.
- b. if A admits a (n, +)-pairing $(\mathfrak{p}, \mathfrak{a})$ with no jump in, then if $Z = X_{\alpha}^+$, X_{α}^+ cannot occur in any edge in \mathfrak{p} , since any edge containing X_{α}^+ and any X_{β}^- in some A_i is a jump in. Hence \mathfrak{p} splits into $\mathfrak{p}_1 \cup \cdots \cup \mathfrak{p}_k$, where the variables in \mathfrak{p}_i occur in A_i , since any edge $(X_{\alpha}^+, X_{\beta}^-)$ with $X_{\alpha}^+ \in A_i$ and $X_{\beta}^- \in A_j$ and $j \neq i$ is a jump out. As the $\alpha_1, \ldots, \alpha_n$ in \mathfrak{a} are distributed among the A_i and possibly Z, we deduce that there exist integers n_1, \ldots, n_k such that either $\sum_i^k n_i = n$ (if $Z \neq X_{\alpha}$) or $\sum_i^k (n_i) = n - 1$ (if Z = X), a partition $\mathfrak{a}_1, \ldots, \mathfrak{a}_n$ of $\mathfrak{a} - \{X_{\alpha}^+\}$, where \mathfrak{a}_i has cardinality n_i and that $(\mathfrak{p}_i, \mathfrak{a}_i)$ is a $(n_i, -)$ -pairing of A_i with no jump out. By the induction hypothesis we get $A_i \in gRP_X^{n_i}$ and we conclude $A \in co - gRP_X^n$ by clause 3.

Proposition 6.2 provides a decidable criterion to test whether a linear type is gRP_X : it suffices to check among its X-pairings whether there is one made of internal edges. For instance, the type $((X_{\alpha}^- \multimap X_{\alpha'}^+) \multimap X_{\beta}^-) \multimap X_{\beta'}^+$ has the X-pairing $\{(X_{\alpha'}^+, X_{\alpha}^-), (X_{\beta'}^+, X_{\beta}^-)\}$ made of internal edges, hence it is gRP_X . The type $(X_{\alpha}^+ \multimap X_{\alpha'}^-) \multimap (X_{\beta}^- \multimap X_{\beta'}^+)$ has no X-pairing made of internal edges (as any pair (X_{α}^+, X^-) is a jump out) so it is not gRP_X .

Moreover, proposition 6.2 allows to prove the equivalence of the definitions 5.3 and 6.2 of gRP_X types:

Proposition 6.3. Definitions 5.3 and 6.2 of linear gRP_X types are equivalent.

Proof. Suppose $A = A'[X/X_1, \ldots, X/X_p]$, where A' is qRP in $\mathcal{X} = \{X_1, \ldots, X_p\}$. Then, for any $X_i \in \mathcal{X}$, A' has exactly two occurrences of X_i , one positive and one negative, which form an internal pair. All such edges, for $1 \leq i \leq p$, induce a X-pairing of A made of internal edges. We conclude, by proposition 6.2, that $A \in qRP_X$.

For the converse direction, it can be verified by induction on definition 6.2 that, if $A \in gRP_X^n$ (resp. $A \in co - gRP_X^n$), then given a (n, -)-pairing (resp. a (n, +)-pairing) $(\mathfrak{p}, \mathfrak{a})$ of A, by renaming the edges in \mathfrak{p} with distinct variables X_1, \ldots, X_p , we obtain a type A' which is qRP(resp. co-qRP) in $\mathcal{X} = \{X_1, \ldots, X_p\}$. Hence, if $A \in gRP_X$, we obtain a type A' with no occurrence of X which is qRP in some finite set \mathcal{X} .

If $f: \Gamma \to A$ is a graph in $\mathcal{A}^{-\circ}$, then its correction graph being a directed acyclic graph, it induces a partial order relation \prec_f over all variable occurrences in Γ and A: $Y_{\alpha} \prec_f Z_{\beta}$ holds when the unique path in the correction graph of f from the conclusion to Z_{β} passes through Y_{α} .

The following lemma relates the edges in $\Gamma \to A$ and the order \prec_f of any correct graph $f: \Gamma \to A$.

Lemma 6.1. Let $f : A_1, \ldots, A_n \to A$ in $\mathcal{A}^{-\circ}$. Then, by letting $A' = A_1 \multimap \cdots \multimap A_n \multimap A$, for any edge $e = (X_{\alpha}^+, X_{\beta}^-)$ in A', the following hold:

- *i.* if e is an internal edge, then $X^+_{\alpha} \prec_f X^-_{\beta}$;
- ii. if e is a jump out edge, then either $e \in f$ or $X^+_{\alpha} \not\prec_f X^-_{\beta}$.

Proof. To prove claim *i*., for any positive occurrence of variable Y_{α}^+ in A', let A_Y^{α} be the type occurring positively in A' whose rightmost variable is Y_{α}^+ . Let us define a distance $d(Y_{\alpha}^+, Z_{\beta}^-)$ between a variable Y_{α}^+ positively occurring in A' and a variable Z_{β}^- negatively occurring in A_Y^{α} : $d(Y_{\alpha}^+, Z_{\beta}^-) = 0$ if $A_Y^{\alpha} = C_1 \multimap \cdots \multimap C_{i-1} \multimap Z_{\beta} \multimap C_{i+1} \multimap \cdots \multimap C_p \multimap Y_{\alpha}; d(Y_{\alpha}^+, Z_{\beta}^-) = k+1$ if $A_Y^{\alpha} = C_1 \multimap \cdots \multimap C_{i-1} \multimap D \multimap C_{i+1} \multimap \cdots \multimap C_p \multimap Y_{\alpha}, D = D_1 \multimap \cdots \multimap D_{j-1} \multimap E \multimap D_{j+1} \multimap \cdots \multimap D_q \multimap Y'_{\alpha'}$ and $E = E_1 \multimap \cdots \multimap E_r \multimap Z'_{\gamma}$, where $d((Z')_{\gamma}^+, Z_{\beta}^-) = k$.

We can argue then by induction on $d = d(Y_{\alpha}^+, Z_{\beta}^-)$ that if Z_{β}^- occurs in the maximal tree of the \multimap^+ -node at the root of A_Y^{α} , then $Y_{\alpha}^+ \prec_f Z_{\beta}^-$. If d = 0, then this follows by functionality. If d = k + 1, then by functionality, inspection of the correction graph (which contains a path from $(Y')_{\alpha'}^-$ to $(Z')_{\gamma}^+$) and the induction hypothesis we have $Y_{\alpha}^+ \prec_f (Y')_{\alpha'}^- \prec_f (Z')_{\gamma}^+ \prec_f Z_{\beta}^-$.

For point *ii*., since any correct graph is sequentializable, we will argue by induction on a normal λ -term u such that $\Gamma \vdash u : A$, by relying on theorem 1. We will suppose w.l.o.g. that the sequent $\Gamma \vdash A$ contains at least two occurrences of X (the claim being trivially valid otherwise).

- 1. if u = x, then $x : A \vdash x : A$, $\mathcal{G}(u) = id_A$ and we argue by a sub-induction on A:
 - 1*a.* if A = X, then there is exactly one edge $e = (X_{\alpha}^{-}, X_{\beta}^{+}) \in f$;
 - 1b. if $A = B \multimap C$, let $e = (X_{\alpha}^+, X_{\beta}^-)$ be a jump out edge in $A' = (B^+ \multimap C^-) \multimap (B^- \multimap C^+)$. e can be of four kinds: (1) a jump out edge in either C^+ or B^+ , (2) a jump in edge in either B^- or C^- or (3) a jump out edge with one occurrence in either B^+ or B^- and one in either C^+ or C^- or (4) a jump out edge between either B^+ and B^- or between C^+ and C^- . Moreover, as all edges in id_A are type I, it cannot be $e \in f$. The correction graph of id_A is as illustrated in figure 17a.

We claim that there exists a path from the conclusion $A \multimap A$ to X_{β}^{-} not passing through X_{α}^{+} . In all four cases we can conclude by inspection of the correction graph and by the induction hypothesis.

- 2. if $u = \lambda x^B . u'$, then $\frac{\Gamma, x : B \vdash u' : C}{\Gamma \vdash \lambda x^B . u' : B \multimap C}$, and then the claim immediately follows by the induction hypothesis, as the partial order induced by the correction graph of $\mathcal{G}(u)$ is the same as the one induced by the correction graph of $\mathcal{G}(u')$.
- 3. if $u = xu_1 \dots u_p$, then $x : B_1 \multimap \dots \multimap B_p \multimap A$, Γ is partitioned into $\Gamma_1, \dots, \Gamma_p, x : B_1 \multimap \dots \multimap B_p \multimap A$ and, for $1 \leq i \leq p$, $\Gamma_i \vdash u_i : B_i$. We let B'_i be the type $C_{i_1} \multimap \dots \multimap C_{p_i} \multimap B_i$, where $\Gamma_i = x_{i_1} : C_{i_1}, \dots, x_{i_{p_i}} : C_{i_{p_i}}$. To avoid confusion we call A' the occurrence of A in the declaration of x. Let then e be a jump out edge in A' and suppose $e \notin f$. Two subcases must be considered. First, if e is a jump out edge in A or an edge $(X^{\epsilon}_{\alpha}, X^{\epsilon'}_{\beta})$, with X_{α} occurring in A and X_{β} occurring in A', then the claim follows by remarking that the correction graph restricted to A and A' is the same as the correction graph of the identity graph $id_A : A \to A$, so we can argue as in case 1. Second, if e is a jump out edge $(X^+_{\alpha}, X^-_{\beta})$, with $X^+_{\alpha} \in B'_i$ and $X^-_{\beta} \in B'_j$, then, if i = j, we can apply the induction hypothesis to u_i ; if $i \neq j$, then the claim follows by inspection of the correction graph (figure 17b), by remarking that, for any variable X_{α} in B'_i and X_{β} in B'_j , $X_{\alpha} \not\prec_f X_{\beta}$.

Let $f: \Gamma \to A$ be a graph in \mathcal{A}^{\multimap} and let $e = (X^+_{\alpha}, X^-_{\beta})$ be an edge over X in A. We say that e is an *expansible edge* if for any $B_1, \ldots, B_n \in \mathcal{L}_{\multimap}$, the graph $f': \Gamma \to A'$, where A' is obtained from A by replacing the two occurrences of X in e by $B = B_1 \multimap \cdots \multimap B_n \multimap X$ and f' is obtained from f by adding type III edges over the variables of B_1, \ldots, B_n as in figure 18, is correct.

By the functionality condition, if an edge $e = (X_{\alpha}^+, X_{\beta}^-)$ is expansible then it must be $X_{\alpha}^+ \prec_f X_{\beta}^-$ (the dotted path in figure 18) in the correction graph of f. It can easily be verified that the converse also holds. This leads to the following:

Lemma 6.2. Let $f : \Gamma \to A$ be a graph in \mathcal{A}^{\multimap} and let e be an edge over X in A. Then e is an expansible edge iff $e \in f$ or e is internal.

Proof. By the remark above and lemma 6.1.

We are now in a position to prove that the simple expansions of gRP_X types are correct:

Proposition 6.4. If $A \in gRP_X$, then A is linearly expansible.

Proof. If $A \in gRP_X$, then A admits a X-pairing made of internal edges. Hence, by lemma 6.2, all such edges induce a correct simple B-expansion of id_A , for any $B \in \mathcal{L}_{-\infty}$.

We conclude this presentation of gRP_X types by relating them to qRP_X types: any closed proof of a gRP_X type is actually (up to variable renaming) a proof of a qRP_X type in some $\mathcal{X} \subset \mathcal{V}$. In other words, one can "separate the variables" following a pairing made of internal edges.

Proposition 6.5. Let $f: \Gamma \to A$ in \mathcal{A}^{\multimap} , where $\Gamma = \{A_1, \ldots, A_n\}$ is a context made of $co-gRP_X$ types and A is gRP_X . Then there exists a finite set $\mathcal{X} = \{X_1, \ldots, X_n\} \subset \mathcal{V}$, a context $\Gamma' = A'_1, \ldots, A'_n$ made of $co - qRP_X$ types such that $A'_i[X/X_1, \ldots, X/X_p] = A_i$ and a type A qRP_X such that $A'[X/X_1, \ldots, X/X_p] = A$ and $f: \Gamma' \to A'$.

Proof. We will argue by induction on the number of applications in a normal linear λ -term u in η -long normal form such that $\Gamma \vdash u : A$. If u has no applications, then either $u = x_i$, where $[x_i] = A_i$, or $u = \lambda y^Z \cdot y$. If $u = x_i$, since $[x_i] = A_i = A \in gRP^X \cap co - gRP_X, X \notin FV(A)$, hence the claim trivially holds; if $u = \lambda y^Z \cdot y$, then $\Gamma = \emptyset$ and $A = Z \multimap Z \in gRP_X$. Then, either $Z \neq X$, so the claim trivially holds, or X = Z, then $A = X \multimap X \in qRP_X$.

Suppose now u has k + 1 applications, i.e. $u = \lambda x_1^{A_1} \dots \lambda x_p^{A_p} y u_1 \dots u_q$. Then $A = A_1 \multimap \dots \multimap A_p \multimap Z$ and two cases arise:

- $(Z \neq X)$ it must be $A_i \in co gRP_X$ for all $1 \leq i \leq p$ and from $[y] \in co gRP_X$ it follows that $[u_j] \in gRP_X$ for all $1 \leq j \leq q$. Suppose $y \neq x_i$, for all $1 \leq i \leq p$. Then there exists a partition $\Gamma_1, \ldots, \Gamma_q$ of $\Gamma - \{[u_j]\}$ and a partition (s_1, \ldots, s_q) of $\{1, \ldots, p\}$ such that, for each $1 \leq j \leq q$, $\Gamma_j, \Delta_j \vdash u_j : [u_j]$, where $\Delta_j = \{x_{i_1} : A_{i_1}, \ldots, x_{i_{p_j}} : A_{i_{p_j}}\}$, $s_j = \{i_1, \ldots, i_{p_j}\}$; by the induction hypothesis, then, there exists sets $\mathcal{X}_j \subset \mathcal{V}$ contexts Γ'_j , Δ'_j of types $co - qRP_{\mathcal{X}_j}$ and a type $C_j qRP_{\mathcal{X}_j}$ such that $\Gamma'_j, \Delta'_j \vdash u_j : C_j$. W.l.o.g. we can suppose all \mathcal{X}_j disjoint. Let $\mathcal{X} = (\bigcup_j \mathcal{X}_j)$. We have then $\Gamma'_1, \ldots, \Gamma'_q, \Delta'_1, \ldots, \Delta'_q, y : C_1 \multimap$ $\cdots \multimap C_q \multimap Z \vdash yu_1 \ldots u_q : Z$, so we can conclude. One can argue similarly if $y = x_i$ for some $1 \leq i \leq p$.
- (Z = X) it must be $A_i \in co gRP_X$ for all $1 \le i \le p$ but for one $A_c \in co gRP_1^X$. Observe that this forces $y = x_c$. We have that $A_c = [u_1] \multimap \cdots \multimap [u_q] \multimap X$. Now, let $A'_c = [u_1] \multimap \cdots \multimap [u_q] \multimap X'$, for some X' not occurring elsewhere. Then $A'_c \in co - gRP_X$, and we deduce that $[u_j] \in gRP_X$, for all $1 \le j \le q$. Now, there exists a partition $\Gamma_1, \ldots, \Gamma_q$ of Γ and a partition (s_1, \ldots, s_q) of $\{1, \ldots, p\} - \{c\}$ such that, for each $1 \le j \le q$, $\Gamma_j, \Delta_j \vdash u_j : [u_j]$, where $\Delta_j = \{x_{i_1} : A_{i_1}, \ldots, x_{i_{p_j}} : A_{i_{p_j}}\}$, $s_j = \{i_1, \ldots, i_{p_j}\}$; by the induction hypothesis, then, there exists sets $\mathcal{X}_j \subset \mathcal{V}$ contexts Γ'_j, Δ'_j of types $qRP_{\mathcal{X}_j}$ and a type $C_j qRP_{\mathcal{X}_j}$ such that $\Gamma'_j, \Delta'_j \vdash u_j : C_j$. W.l.o.g. we can suppose all \mathcal{X}_j disjoint and not containing X'. Let $\mathcal{X} = (\bigcup_j \mathcal{X}_j) \cup \{X'\}$. We have then $\Gamma'_1, \ldots, \Gamma'_q, \Delta'_1, \ldots, \Delta'_q, x_c : C_1 \multimap \cdots \multimap C_q \multimap X' \vdash x_c u_1 \ldots u_q : X'$, so we can conclude.

6.3 Characterization of linearly expansible types

We show that gRP_X types are "dense" in the class of linearly expansible types in the following sense: any linearly expansible type is either a gRP_X or it linearly collapses into a set of gRP_X types. We also show that gRP_X types are exactly those types for which all simple expansion graphs are correct.

Let $f: \Gamma \to A[B/X]$ in $\mathcal{A}^{-\circ}$, where $B = Y \multimap X$ and $Y \notin FV(\Gamma)$, FV(A). The edges over Y of f form then a pairing $f_Y \subset f$ made of type III edges. Moreover, $f - f_Y : \Gamma \to A$ is allowable: its correction graph is obtained from the correction graph of f by the transformation illustrated in figure 19 (in which the dotted path is forced by functionality), which preserves correctness.

Lemma 6.3. Let $f : \Gamma \to A[B/X]$ in $\mathcal{A}^{-\circ}$, where $B = Y \multimap X$ and $Y \notin FV(\Gamma)$, FV(A). Then the correction graph of f contains no configuration of the form shown in figure 20a.

Proof. If such a configuration exists, then, by functionality, there must be a path from the leftmost $-\infty^-$ -link to $Y_{u'}^-$. As this path cannot pass through $Y_{v'}^+$, its existence implies a configuration as illustrated in figure 20b, which contains two isomorphic copies of configuration 20a. There must be then a new path from the leftmost $-\infty^-$ -link in 20b to $Y_{u''}^-$. As all paths are finite (by acyclicity), we must conclude that this is impossible.

Lemma 6.4. Let $f : \Gamma \to A[B/X]$ in \mathcal{A}^{\sim} , where $B = Y \multimap X$ and $Y \notin FV(\Gamma)$, FV(A). Then, for any type III edge e_X over X of f, there exists a type III edge e_Y over Y of f "next to e_X ", *i.e.* as in figure 21a.

Proof. Suppose the correction graph of f has a configuration as the one in figure 21b. Then, by functionality for the rightmost $-\infty^+$ -link, either there exists a path from the rightmost $-\infty^-$ -link to the leftmost $-\infty^+$ -link or there is a path from Y_v^+ to the leftmost $-\infty^+$ -link. The first case is impossible by lemma 6.3; the second case forces u = u' and v = v', as from Y_v^+ one must get to the minor premiss $Y_{v''}^-$ of a $-\infty^+$ -link where the path ends (since all negative occurrences of Y are within positive occurrences of $Y - \infty X$). So it must be v' = v and u = u', hence the configuration is as in 21a.

By lemma 6.4, any type III edge e_X over X in $f : \Gamma \to A[B/X]$ is coupled with a type III edge e_Y over Y as in figure 21a. We can deduce then that interpolation over $f - f_Y : \Gamma \to A$ induces interpolation over f in the following sense:

Lemma 6.5. Let $f : \Gamma \to A[B/X]$ in $\mathcal{A}^{-\circ}$, where $B = Y \to X$ and $Y \notin FV(\Gamma), FV(A)$. Suppose moreover f has a type III edge over X. Then, the splitting of $f' = f - f_Y : \Gamma \to A$ into p graphs $f_i : \Gamma_i \to A_i$ obtained by weak interpolation induces a splitting of f into p graphs $g_i : \Gamma_i \to A_i[B/X]$, where $f_i = g_i - f_Y$.

Proof. By lemma 6.4, the Y-pairing of f can be partitioned in two sets p_1, p_2 , where p_1 contains those edges which are coupled with type III edges over X and p_2 contains those edges which occur close to type I edges over X. The edges in p_2 induce then a pairing p of the type I edges over X, with edges $(e, e') \in p$ when e contains X^+_{α} , e' contains X^-_{β} and the two occurrences $Y^-_{\alpha'}$ and $Y^+_{\beta'}$ occurring next to X^+_{α} and X^-_{β} , respectively, form a type III edge e_Y in p_2 . After weak interpolation is performed, the correction graph is as in figure 22. Indeed, by functionality for the rightmost $-\infty^+$ link, there must be a path from $X^-_{\alpha'}$ to $X^+_{\alpha'}$, which can only be a path through a negative branch in the shape of $A^{\overline{e}}_i$. By duality, there is then a positive branch in the shape of $A^{\overline{e}}_i$, hence, by functionality for the leftmost $-\infty^+$ link, there must be a path from X^-_{γ} to X^+_{γ} .

Under these conditions, the edge $(X_{\beta'}^{-}, \beta')$ is expansible in A_i (by lemma 6.2), so we can "transport" the edge (Y_v^+, Y_u^-) onto A_i as shown in figure 23, preserving correctness. By arguing in this way for all edges in p_2 we obtain correct graphs $g_i : \Gamma_i \to A_i[Y \multimap X/X]$.

By exploiting the previous lemmas, proposition 6.2 as well as lemma 6.2 we can prove the proposition below, which is the fundamental step to characterize linearly expansible types.

Lemma 6.6. Let $f : \Gamma \to A[B/X]$ in \mathcal{A}^{\sim} , where $B = Y \multimap X$ and $Y \notin FV(\Gamma), FV(A)$. Then either $A \in gRP_X$ or $f - f_Y : \Gamma \to A$ has gRP_X interpolants.

Proof. Suppose $A \notin gRP_X$. By lemma 6.1 A is paired and by lemma 6.2, any X-pairing of A contains a jump out edge. We deduce that for any Y-pairing of A[B/X], one can find occurrences of $(Y_{\alpha} \multimap X_{\alpha})^+, (Y_{\beta} \multimap X_{\beta})^-$ such that the edge $(X_{\alpha}^+, X_{\beta}^-)$ is a jump out edge.

Let then $e = (X_{\alpha}^+, X_{\beta}^-)$ be such a jump out edge and let us consider the correction graph of $f': \Gamma \to A$. By lemma 6.1 it follows that either $X_{\alpha}^+ \not\prec_{f'} X_{\beta}^-$ or $e = (X_{\alpha}^+, X_{\beta}^-) \in f'$. The first case is impossible: as there is a path in the correction graph of f' going from the conclusion to X_{β}^- without passing through X_{α}^+ , the functionality condition must fail, as illustrated in figure 24, contradicting the hypothesis that f' is correct.

Hence $e = (X_{\alpha}^+, X_{\beta}^-) \in f'$. We can now apply weak interpolation to eliminate all type III

edges from f', included e. By lemma 6.5, we conclude that there exists a partition $\Gamma_1, \ldots, \Gamma_p$ of Γ , types $A_1, \ldots, A_p \hookrightarrow A$, with $\sum_i n(A_i) < n(A)$ and correct graphs g_1, \ldots, g_p , where $g_i : \Gamma_i \to A_i[B/X]$ and $g_i - f_Y : \Gamma_i \to A_i$, where the latter have no type III edge.

Now it must be $A_i \in gRP_X$ as, by the same argument as above, if $A_i \notin gRP_X$, then $g_i - f_Y$ has a type III edge over X, which is impossible.

By applying lemma 6.6 with $\Gamma = \{A\}$, as well as remark 3.1, we get:

Theorem 6. $A \in \mathcal{L}_{-\infty}$ is linearly expansible iff either A is gRP_X or A linearly collapses into a gRP_X type.

By putting together lemma 6.2, proposition 6.2 and lemma 6.6, we obtain a nice characterization of gRP_X types:

Proposition 6.6. $A \in gRP_X$ iff for any type B there exists a correct simple B-expansion of A.

Proof. By proposition 6.2, $A \in gRP_X$ iff it admits a X-pairing p with no jump out. Hence, if $A \in gRP_X$, then, by lemma 6.2, for any B the p_B -expansion of id_A is correct. If $A \notin gRP_X$, by reasoning as in the proof of lemma 6.6 we can conclude that, by letting $B = Y \multimap X$, any correct graph $f : A \to A[B/X]$ contains a type III edge over X, hence it is not a simple B-expansion.

Proposition 6.6 refines proposition 7.1, as it shows that if $A \in gRP_X$, then it is not only linearly expansible, but, for any type $B = B_1 \multimap \cdots \multimap B_n \multimap X$, the graph $EXP_A(B)$: $A \to A[B/X]$ is a simple *B*-expansion graph. If a type *A* is linearly expansible but not gRP_X , then, by theorem 6, *A* linearly collapses into a gRP_X type *A'*. By proposition 6.6, the simple *B*-expansion graphs of *A* are not correct. However, *A* can be expanded by composing arrows $A \to A' \to A'[B/X] \to A[B/X]$. The resulting graph is not a simple expansion graph. Indeed, as the last arrow in the chain comes from interpolation, the graph has a type III edge over *X*. For example, the type $C = (X \multimap X) \multimap (X \multimap X)$, which is not gRP_X , has two simple $Y \multimap X$ -expansion graphs, shown in figure 25, both not correct. However, as C linearly collapses into the gRP_X type $X \multimap X$, C is linearly expansible: a correct expansion of D is obtained by collapsing it on $X \multimap X$, as shown in figure 26.

7 From the expansion property to instantiation overflow

In this section we establish our main result, that is, that a simple type A has instantiation overflow if and only if $\forall XA$ is either derivable or logically equivalent to a product of gRP types.

First, we consider generalized Russell-Prawitz types in λ_{\Rightarrow} and we prove that a simple type A is expansible iff it is either derivable or logically equivalent to a product of gRP_X types. The characterization is slightly different from the one given for $\lambda_{-\circ}$, as one must consider that derivable types are expansible in λ_{\Rightarrow} , though not in $\lambda_{-\circ}$, and that weak interpolation in λ_{\Rightarrow} is significantly more complex than weak interpolation in $\lambda_{-\circ}$.

Then we consider the instantiation overflow problem for the types $\forall XA$, with $A \in \mathcal{L}_{\Rightarrow}$. We suitably extend the expansion property and the notion of collapse to F_{at} and we prove (1) that a type A is F_{at} -expansible iff $\forall XA$ is either derivable or logically equivalent to a product of gRP types and (2) that A has instantiation overflow iff it is F_{at} -expansible.

7.1 Expansible and generalized Russell-Prawitz types

Similarly to the previous section, we fix a variable $X \in \mathcal{V}$. A type $A \in \mathcal{L}_{\Rightarrow}$ will be called *expansible* when for every simple types $C_1, \ldots, C_p \in \mathcal{L}_{\Rightarrow}$, there exists an arrow $EXP_A(B) : A \to A[B/X]$ in \mathcal{T} , where B is $C_1 \Rightarrow \ldots \Rightarrow C_p \Rightarrow X$.

Similarly to the last section, we let a simple type be $co - gRP_X$ when it is of the form $A_1 \Rightarrow \ldots \Rightarrow A_n \Rightarrow Z$, where $Z \neq X$ and the A_i are gRP_X . We provide an equivalent inductive definition of gRP_X and $co - gRP_X$ types in $\mathcal{L}_{\Rightarrow}$:

Definition 7.1. We define by mutual induction the classes gRP_X^n , $co - gRP_X^n$, for $n \in \mathbb{N}$:

- 1. if A has no occurrence of X, then $A \in gRP_X^0$, $co gRP_X^0$;
- 2. $X \in gRP_X^0, co gRP_X^1;$
- 3. if $B \in gRP_X^p$ and $C \in co gRP_X^q$, then $B \Rightarrow C \in co gRP_X^{p+q}$;
- 4. if $B \in co gRP_X^p$ and $C \in gRP_X^q$, then $B \Rightarrow C \in gRP_X^{p+q}$;
- 5. if $A_1 \in co gRP_X^{n_1}, \ldots, A_p \in co gRP_X^{n_p}$, then the type $A_1 \Rightarrow \ldots \Rightarrow A_p \Rightarrow X$ is in gRP_X^q for all $q < \sum_{i=1}^{p} n_i$.
- We let $gRP_X := gRP_X^0$ (resp. $cogRP_X := co gRP_X^0$).

We highlight some differences between definition 6.2 and definition 7.1. The type X is gRP_X but not linear gRP_X . This corresponds to the fact that X is expansible in λ_{\Rightarrow} but not in λ_{\multimap} . As we already observed, the type $D = (A \Rightarrow X) \Rightarrow (B \Rightarrow X) \Rightarrow X$, where $X \notin FV(A), FV(B)$ is gRP_X , while the corresponding linear type D^{\multimap} is not linear gRP_X .

 gRP_X types in $\mathcal{L}_{\rightarrow}$ and $\mathcal{L}_{\Rightarrow}$ are related by the following facts, which are easily proved by induction on a type $B \in \mathcal{L}_{\Rightarrow}$:

Lemma 7.1. For all types $A \in \mathcal{L}_{\rightarrow}$, $B \in \mathcal{L}_{\Rightarrow}$ and $k \in \mathbb{N}$, the following hold:

- if $A \in \mathcal{E}^+(B)$ and $A \in gRP_X^k$, then there exists $h \leq k$ such that $B \in gRP_{X^h}$;
- if $A \in \mathcal{E}^{-}(B)$ and $A \in co gRP_X^k$, then there exists $h \leq k$ such that $B \in co gRP_X^h$.

From lemma 7.1 we deduce that for all $A \in \mathcal{L}_{\rightarrow}, B \in \mathcal{L}_{\Rightarrow}$:

- if A is gRP_X , then A^{\Rightarrow} is gRP_X ;
- if $A \in \mathcal{E}^+(B)$ and A is gRP_X , then B is gRP_X .

The following proposition shows that gRP_X types are expansible.

Proposition 7.1 (simple expansions). For all simple types $A, B = B_1 \Rightarrow ... \Rightarrow B_k \Rightarrow X \in \mathcal{L}_{\Rightarrow}$ and $k \in \mathbb{N}$, if $A \in gRP_X^k$ (resp. $A \in co - gRP_X^k$), there exist an arrow $EXP_A(B) : \Delta, A \rightarrow A[B/X]$ (resp. $coEXP_A(B) : \Delta, A[B/X] \rightarrow A$) in $m\mathcal{T}$, where $\Delta = x_1 : B_1, ..., x_n : B_n$ if $k \ge 1$ and $\Delta = \emptyset$ if k = 0.

In case k = 0 we call $EXP_A(B)$ (resp. $coEXP_A(B)$) the simple B-expansion (resp. simp B-coexpansion of A.

Proof. Induction on clauses 1.-5.:

- 1. if $X \notin FV(A)$, then $EXP_A(B) = coEXP_A(B) = x$;
- 2. if A = X, then $EXP_A(B) = Intro_B x$ and $coEXP_A(B) = Elim_B x$;
- 3. if $A = A_1 \Rightarrow A_2$, then $coEXP_A(B) = EXP_{A_1}(B) \Rightarrow coEXP_{A_2}(B)$;
- 4. if $A = A_1 \Rightarrow A_2$, then $EXP_A(B) = coEXP_{A_1}(B) \Rightarrow EXP_{A_2}(B)$;
- 5. if $A = A_1 \Rightarrow \cdots \Rightarrow A_p \Rightarrow X$, where $A_i \in cogRP_{p_i}^X$ and for at least one *i*, say i = c, $p_c = k + 1$, then

$$EXP_A(B) = \lambda x_1^{A_1[B/X]} \dots \lambda x_p^{A_p[B/X]} . Intro_B \left(x(coEXP_{A_1}(B)[x_1/x]) \dots (coEXP_{A_p}(B)[x_p/x]) \right)$$

We extend the notion of simple *B*-expansion in accordance with theorem 4: given $A \in \mathcal{L}_{\rightarrow}$, $B \in \mathcal{L}_{\Rightarrow}$, by a generalized simple *B*-expansion of *A* we indicate a graph $f : A \to C$ such that $id_A \subseteq f$, where *C* is obtained from *A* by replacing positive (resp. negative) occurrences of *X* by some $B' \in \mathcal{E}^+(B)$ (resp. $B' \in \mathcal{E}^-(B)$); dually, a generalized simple *B*-expansion is a graph $f : C \to A$ such that $id_A \subseteq f$, where *C* is obtained from *A* by replacing positive (resp. negative) occurrences of *X* by some $B' \in \mathcal{E}^-(B)$ (resp. $B' \in \mathcal{E}^+(B)$).

The fact that $EXP_A(B)$, $coEXP_A(B)$ are called simple expansions and coexpansions respectively comes from the following property:

Proposition 7.2. Let $A \in \mathcal{L}_{\Rightarrow}$ be gRP_X (resp. $co - gRP_X$). Then, for any $B \in \mathcal{L}_{\Rightarrow}$, the graph of $\partial EXP_A(B)$ (resp. $\partial coEXP_A(B)$) is a generalized simple expansion graph (resp. a generalized simple coexpansion graph).

Proof. Given $A \in gRP_k^X$ (resp. $A \in co - gRP_k^X$), it suffices to show that the graph $\partial EXP_A(B)$ (resp. $\partial coEXP_A(B)$) contains id_A . We argue by induction on clauses 1.-5.. For clauses 1.-2. the claim is immediate. For clauses 3.-4. we argue as follows: first, given graphs $g: C_1 \to D_1$, $h: D_2 \to C_2$ corresponding to λ -terms u_g and u_h , the graph of the λ -term $u_g \Rightarrow u_h$ is simply the graph $g \multimap h := g + h : (D_1 \multimap D_2) \to (C_1 \multimap C_2)$. Now the claim follows from the

fact that, if g is a simple co-expansion (resp. expansion) and h a simple expansion (resp. co-expansion), then $g \multimap h$ is a simple expansion (resp. co-expansion). Indeed, if $id_{D_1} \subseteq g$ (resp $id_{C_1} \subseteq g$) and $id_{D_2} \subseteq h$ (resp. $id_{C_2} \subseteq h$), then $id_{D_1 \multimap D_2} = id_{D_1} + id_{D_1} \subseteq g \multimap h$ (resp. $id_{C_1 \multimap C_2} = id_{C_1} + id_{C_2} \subseteq g \multimap h$).

Finally, in case 5., that id_A is contained in the graph f of $\partial EXP_A(B)$ can be seen from the fact that the graphs of the terms $\partial coEXP_{A_i}(B)$ are contained in f, where $A_1 \multimap \cdots \multimap A_p \multimap X$, as well as the graph id_X , as illustrated in figure 27 (where we only drew the edges over A). We conclude that $id_A = id_X + \sum_i^p id_{A_i} \subseteq f$.

As in the previous section, we label distinct occurrences of X in a simple type with integers $\alpha \in \mathbb{N}$. The notion of (n, ϵ) -pairing is replaced, in this context, by the notion of (n, ϵ) -tiling:

Definition 7.2. Let $A \in \mathcal{L}_{\Rightarrow}$. A list $L = (X_{\alpha_0}^{\epsilon}, X_{\alpha_1}^{\overline{\epsilon}}, \dots, X_{\alpha_n}^{\overline{\epsilon}})$ is a tile in A (resp. a co-tile in A) if X_{α_0} is a positive (resp. negative) occurrence of X in A and the X_{α_i} , for $1 \leq i \leq n$ are distinct negative (resp. positive) occurrences of X in A.

A (n, ϵ) -tiling (resp. a (n, ϵ) -co-tiling) of A is a pair $(\mathfrak{p}, \mathfrak{a})$, where \mathfrak{a} is a set containing labels of distinct positive (resp. negative) occurrences of X in A and \mathfrak{p} is a tiling (resp. a co-tiling) of all remaining occurrences of X in A.

We will call a $(0, \epsilon)$ -tiling (resp. a $(0, \epsilon)$ -co-tiling) simply a tiling (resp. a co-tiling).

The notion of jump out is extended to the case of tiles: a tile $(X_{\alpha_0}^+, X_{\alpha_1}^-, \ldots, X_{\alpha_n}^-)$ is a jump out tile in A if for some $1 \le i \le n$, $(X_{\alpha_0}^+, X_{\alpha_i}^-)$ is a jump out edge in $A^{-\circ}$. Similarly, a co-tile $(X_{\alpha_0}^-, X_{\alpha_1}^+, \ldots, X_{\alpha_n}^+)$ is a jump in co-tile in A if for some $1 \le i \le n$, $(X_{\alpha_0}^-, X_{\alpha_i}^+)$ is a jump in edge in $A^{-\circ}$. A tile which is not a jump out will be called an internal tile.

The proposition below is the analogous, in this frame, of proposition 6.2. We omit the proof as the argument is similar to that of proposition 6.2.

Proposition 7.3. For any type A and $n \in \mathbb{N}$,

- $A \in gRP_X^n$ iff A has a (n, -)-tiling with no jump out;
- $A \in co gRP_X^n$ iff A has a (n, +)-co-tiling with no jump in.

Proof. Similar to the proof of proposition 6.2.

Proposition 7.3 allows to prove the equivalence of the two definitions of gRP_X types:

Proposition 7.4. gRP_X types following definitions 5.3 and 7.1 coincide.

Proof. Similar to the proof of proposition 6.3, with tilings in place of pairings.

Also proposition 6.5 can be straightforwardly extended to λ_{\Rightarrow} :

Proposition 7.5. Suppose $u: \Gamma \to A$ in \mathcal{T} is normal and η -long, where $\Gamma = x_1: A_1, \ldots, x_n: A_n$ is a context made of $co - gRP_X$ types and A is gRP_X . Then there exists a finite set $\mathcal{X} = \{X_1, \ldots, X_n\} \subset \mathcal{V}$, a context $\Gamma' = A'_1, \ldots, A'_n$ made of qRP_X types such that $A'_i[X/X_1, \ldots, X/X_p] = A_i$ and a qRP_X type A such that $A'_i[X/X_1, \ldots, X/X_p] = A$ and $u': \Gamma' \to A'$, where u' is an appropriate renaming of the types appearing in u.

Proof. Similar to the proof of proposition 6.5.

7.2 Characterization of expansible types

We adapt to λ_{\Rightarrow} the argument in subsection 6.3 that generalized Russell-Prawitz types are "dense" in the class of expansible types.

Let $u: \Gamma \to A[B/X]$ in \mathcal{T} be normal and η -long, where $B = Y \Rightarrow X$ and $Y \notin FV(A), FV(\Gamma)$. Let $v_C \in Subt(u)$ be a term such that $[v_C] = C[B/X]$, where C is a type of the form $C_1 \Rightarrow \ldots \Rightarrow C_p \Rightarrow X$ occurring positively in A. Then v_C is of the form $\lambda x_1^{C_1[B/X]} \ldots \lambda x_p^{C_p[B/X]} \lambda y^Y . zu_1 \ldots u_q$ We say that u is good when for all $v_C \in Subt(u)$ as above, whenever $q \ge 1$ and $[u_q] = Y$, then $u_q = y$.

If u is good then u is linear in all variables y such that [y] = Y: if y is one of such variables and u has a subterm v of the form $\lambda x_1^{C_1} \dots \lambda x_p^{C_p} . zu_1 \dots u_{i-1} yu_{i+1} \dots u_q$, then $[z] = [u_1] \Rightarrow$ $\dots \Rightarrow [u_{i-1}] \Rightarrow [Y] \Rightarrow [u_{i+1}] \Rightarrow \dots \Rightarrow [u_q] \Rightarrow Z$ forces q = i and Z = X, hence $v = v_C$ for some positive subtype of A of the form $D_1 \Rightarrow \dots \Rightarrow D_{p-1} \Rightarrow X$, $C_j = D_j[B/X]$ for $1 \le j \le p-1$, $C_p = Y$ and $x_p = y$.

Observe that we can always transform a normal η -long term $u : \Gamma \to A[B/X]$ into a good one by replacing u_q by y in any subterm v_C of the appropriate form.

We can now prove the analogous of lemma 6.6:

Lemma 7.2. If $A \in \mathcal{L}_{\Rightarrow}$ and there is a term $u : A \to A[B/X]$, where $B = Y \Rightarrow X$, with $Y \notin FV(A), FV(\Gamma)$, then either A is derivable or A is gRP_X or u has gRP_X interpolants.

Proof. We can suppose w.l.o.g. that u is good. Then, for some $d \in \mathbb{N}$, $\partial u : A_1^-, \ldots, A_d^- \to C$ in \mathcal{A}^{\multimap} , where $C \in \mathcal{E}^+(A[B/X])$. Suppose A is not derivable nor gRP_X ; then $d \neq 0$ and, from the fact that u is linear in all y such that [y] = Y we deduce that C is of the form $A^+[Y \multimap X/X]$, for some $A^+ \in \mathcal{E}^+(A)$. Indeed, C is obtained by replacing, in some type $A^+ \in \mathcal{L}^+(A)$, all negative occurrences of X by $Y \multimap X$ and all positive occurrences of X by $\underbrace{Y \multimap \cdots \multimap Y}_{p \text{ times}} \multimap X$, for some

 $p \in \mathbb{N}$ corresponding to the number of occurrences in u of some y such that [y] = Y.

Hence $\partial u : A_1^-, \ldots, A_d^- \to A^+[Y \multimap X/X]$, where $Y \notin FV(A_j^-)$ and $Y \notin FV(A^+)$ and we can apply lemma 6.6: either $A^+ \in gRP_X$ or ∂u has gRP_X interpolants.

By proposition 7.1 *b.*, $A^+ \notin gRP_X$. We conclude then that ∂u has gRP_X interpolants C_1, \ldots, C_p , whence, by proposition 7.1 *a.*, *u* has gRP_X interpolants $C_1^{\Rightarrow}, \ldots, C_p^{\Rightarrow}$.

We finally get:

Proposition 7.6. $A \in \mathcal{L}_{\Rightarrow}$ is expansible iff either A is derivable, A is gRP_X or A collapses into a finite family of gRP_X types.

From theorem 7.6 we obtain immediately the following:

Theorem 7. A simple type is expansible iff it is either derivable or logically equivalent to a product of gRP_X simple types.

Observe that, differently from the case of linear expansible terms, derivable types are always expansible: if there is a closed term u of type A, then one can form a closed term u' of type A[B/X], for all $B \in \mathcal{L}_{\Rightarrow}$, hence $\lambda x^A \cdot u : A \to A[B/X]$, for all $x \notin FV(A)$. That this does not hold for linear expansible term is shown by the linear type $C = (X \multimap Y) \multimap (X \multimap Y)$ which is derivable but has a unique edge over X, which is a jump out. As C is clearly \prec_I -minimal, by proposition 6.1, C is not expansible.

7.3 Characterization of instantation overflow for simple types

In this section we introduce the F_{at} -expansion property and we prove (1) that a F_{at} -expansible simple type A is either derivable or such that $\forall XA$ is equivalent in F_{at} to the conjunction of a family of gRP types and (2) that for a simple type A, instantiation overflow for $\forall XA$ coincides with the F_{at} -expansibility of A.

Let $A \in \mathcal{L}_{\Rightarrow}$ and $u : \forall XA \to \forall XA$ in \mathcal{F}_{at} . By deleting second order constructs, we obtain an arrow $u_0 : A[Z_1/X], \ldots, A[Z_n/X] \to A$ in \mathcal{T} , for some variables Z_1, \ldots, Z_n . We first show that we can suppose $Z_1, \ldots, Z_n \in FV(A)$:

Lemma 7.3. Let $A \in \mathcal{L}_{\Rightarrow}$ and $u : \forall XA \to \forall XA \text{ in } \mathcal{F}_{at}$. Then there exists $u^* : A[Y_1/X], \ldots, A[Y_n/X] \to A \text{ in } \mathcal{T}$, where $FV(A) = \{Y_1, \ldots, Y_n\}$.

Proof. We can suppose w.l.o.g. u normal. By deleting second order constructs, we obtain a term u_0 such that $y_1 : A[Y_1/X], \ldots, y_n : A[Y_n/X], z_1 : A[Z_1/X], \ldots, z_p : A[Z_p/X] \vdash u_0 : A$ is derivable in λ_{\Rightarrow} , where the variables Z_1, \ldots, Z_p do not occur in A. If we consider the graph $\mathcal{G}(\partial u)$, it is clear that all edges over Z_j , for $1 \leq j \leq p$, are of type II. By renaming all such edges as Y_1 , we obtain the graph $\mathcal{G}(\partial u')$ of a term u' such that $y_1 : A[Y_1/X], \ldots, y_n : A[Y_n/X], z_1 : A[Y_1/X], \ldots, z_p : A[Y_1/X] \vdash u_0 : A$. We can thus put $u^* = u'[y_1/z_1, \ldots, y_1/z_p]$.

From lemma 7.3 we deduce that the interpolants of an arrow $u : \forall XA \to \forall XA$ in \mathcal{F}_{at} are formulas whose free variables are included in those of A. This leads to the following definition:

Definition 7.3 (F_{at} -collapse). Let $A, B_1, \ldots, B_p \in \mathcal{L}_{\Rightarrow}$. A F_{at} -collapses into B_1, \ldots, B_p if $FV(B_j) \subseteq FV(A)$ for all $1 \leq j \leq p$ and there exist arrows $u_j : A[Y_1/X], \ldots, A[Y_n/X] \to B_j$ and $u : B_1, \ldots, B_p \to A$, where $FV(A) = \{Y_1, \ldots, Y_n\}$.

If A F_{at} -collapses into B_1, \ldots, B_p , then $\forall XA$ is logically equivalent to the product of the $\forall XB_1, \ldots, \forall XB_p$. F_{at} -collapse is not equivalent to collapse: for instance the type $(Y \Rightarrow X) \Rightarrow X$ F_{at} -collapses into Y, but $(Y \Rightarrow X) \Rightarrow X$ does not collapse into Y.

We introduce F_{at} -expansible types:

Definition 7.4 (F_{at} -expansible type). A type $A \in \mathcal{L}_{\Rightarrow}$ is F_{at} -expansible if for every types $C_1, \ldots, C_p \in \mathcal{L}_{\Rightarrow}$ there exists an arrow $EXP_A(B) : A[Y_1/X], \ldots, A[Y_n/x] \to A[B/X]$, where $B = C_1 \Rightarrow \ldots \Rightarrow C_p \Rightarrow X$ and $FV(A) = \{Y_1, \ldots, Y_n\}$.

Similarly to lemma 7.2, we can characterize F_{at} -expansible types as those which F_{at} -collapse into gRP_X types:

Proposition 7.7. $A \in \mathcal{L}_{\Rightarrow}$ is F_{at} -expansible iff either A is derivable or A is gRP_X or A F_{at} collapses into a family of gRP_X types.

Proof. We can argue similarly to lemma 7.2. Suppose A is neither derivable nor gRP_X , let $Y \notin FV(A)$ and suppose there is an arrow $u : A[Y_1/X], \ldots, A[Y_n/X] \to A[Y \Rightarrow X/X]$, where $FV(A) = \{Y_1, \ldots, Y_n\}$. Then we obtain gRP_X interpolants A_1, \ldots, A_p of u, into which A $F_{at-collapses}$.

Similarly to the previous subsection, if Γ, Δ, Σ are contexts, Y a variable not occurring in any of them nor in a simple type A and $u: \Gamma, \Delta[Y \Rightarrow X/X], \Sigma[Y/X] \to A[B/X]$ in \mathcal{T} is normal and η -long, where $B = Y \Rightarrow X$, we can consider all $v_C \in Subt(u)$ such that $[v_C] = C[B/X]$, where C is a type of the form $C_1 \Rightarrow \ldots \Rightarrow C_p \Rightarrow X$ occurring positively in A. Then v_C is of the form $\lambda x_1^{C_1[B/X]}, \ldots, \lambda x_p^{C_p[B/X]}, \lambda y^Y, zu_1, \ldots u_q$. We say that u is good when for all $v_C \in Subt(u)$ as above, whenever $q \ge 1$ and $[u_q] = Y$, then $u_q = y$. We will suppose that all such arrows are good.

To prove our final result, i.e. the equivalence of instantiation overflow and the F_{at} -expansion property, we need the lemma below.

Lemma 7.4. Let Γ, Δ, Σ be contexts, $A \in \mathcal{L}_{\Rightarrow}$ and Y be a variable not occurring in $\Gamma, \Delta, \Sigma, A$.

- a. for any arrow $u : \Gamma, \Delta[Y \Rightarrow X/X], \Sigma[Y/X] \rightarrow A$ there exists an arrow $u^* : \Gamma, \Delta[Y \Rightarrow X/X], \Sigma \rightarrow A;$
- b. for any arrow $u : \Gamma, \Delta[Y \Rightarrow X/X], \Sigma[Y/X] \rightarrow A[Y \Rightarrow X/X]$ there exists a arrow $u^* : \Gamma, \Delta[Y \Rightarrow X/X], \Sigma \rightarrow A[Y \Rightarrow X/X];$
- c. for any arrow $u: \Gamma, \Delta[Y \Rightarrow X/X], \Sigma[Y/X] \to A[Y/X]$ there exists an arrow $u^*: \Gamma, \Delta[Y \Rightarrow X/X], \Sigma \to A$.

Proof. For any variable y and context Σ , we let $y \in \Sigma$ indicate that the variable y is declared in Σ . We argue by induction on the number of applications of u. If $u = \lambda x_1^{A_1} \dots \lambda x_p^{A_p} y$, then

a. if $y \in \Gamma$, $u^* = u$; if $y \in \Delta[Y \Rightarrow X/X]$ or $y \in \Sigma[Y/X]$, then $X \notin FV([y])$, so $u^* = u$;

b. if $y \in \Delta[Y \Rightarrow X/X]$, $u^* = u$; if $y \in \Gamma$ or $y \in \Sigma[Y/X]$, then $X \notin FV([y])$, so $u^* = u$;

c. if $y \in \Sigma[Y/X]$, $u^* = u$; if $y \in \Gamma$ or $y \in \Delta[Y \Rightarrow X/X]$, then $X \notin FV([y])$, so $u^* = u$.

If $u = \lambda x_1^{A_1} \dots \lambda x_p^{A_p} y u_1 \dots u_q$, for some $q \ge 1$, then we must consider nine cases, three for each case a, b, c. We only consider case a1 - a3. and case b2. as all other cases can be treated similarly:

- a1. if $y \in \Gamma$ or $y = x_i$, for some $1 \le i \le p$, then $[u_j] = C_j$ has no occurrence of Y, for $1 \le j \le q$; by the induction hypothesis a., we deduce $u_j^* : \Gamma, A_1, \ldots, A_p, \Delta[Y \Rightarrow X/X], \Sigma \to C_j$, so we put $u^* = \lambda x_1^{A_1} \ldots \lambda x_p^{A_p} . yu_1^* \ldots u_p^*$;
- a2. if $y \in \Delta[Y \Rightarrow X/X]$, then $[y] = C[Y \Rightarrow X/X]$ for some $C = C_1 \Rightarrow \ldots \Rightarrow C_{q'} \Rightarrow Z$. If $Z \neq X$, then $[u_j] = C_j[Y \Rightarrow X/X]$, for $1 \leq j \leq q$; by the induction hypothesis b., we deduce $u_j^* : \Gamma, A_1, \ldots, A_p, \Delta[Y \Rightarrow X/X], \Sigma \to C_j[Y \Rightarrow X/X]$, so we put $u^* = \lambda x_1^{A_1} \ldots \lambda x_p^{A_p}.yu_1^* \ldots u_p^*$. If Z = X, then q = q' + 1, $[u_j] = C_j[Y \Rightarrow X/X]$, for $1 \leq j \leq q'$ and $[u_q] = Y$; by the induction hypothesis c. there exists then an arrow $u_q^* : \Gamma, A_1, \ldots, A_p, \Delta[Y \Rightarrow X/X], \Sigma \to X$, so we put $u^* = \lambda x_1^{A_1} \ldots \lambda x_p^{A_p}.u_q^*$;
- a3. if $y \in \Sigma[Y/X]$, then $[u_j] = C_j[Y/X]$, for $1 \le j \le q$; by the induction hypothesis c., we deduce $u_j^* : \Gamma, A_1, \ldots, A_p, \Delta[Y \Rightarrow X/X], \Sigma \to C_j$, so we put $u^* = \lambda x_1^{A_1} \ldots \lambda x_p^{A_p} . yu_1^* \ldots u_p^*$;

b2. if $y \in \Delta[Y \Rightarrow X/X]$, then $[y] = C[Y \Rightarrow X/X]$ for some $C = C_1 \Rightarrow \ldots \Rightarrow C_{q'} \Rightarrow Z$. If $Z \neq X$, then $[u_j] = C_j[Y \Rightarrow X/X]$, for $1 \leq j \leq q$; by the induction hypothesis b, we deduce $u_j^* : \Gamma, \Delta[Y \Rightarrow X/X], A_1, \ldots, A_p, \Sigma \to C_j[Y \Rightarrow X/X]$, so we put $u^* = \lambda x_1^{A_1} \ldots \lambda x_p^{A_p} .yu_1^* \ldots u_p^*$. If Z = X, then q = q' + 1, $A_p = Y$, $u_q = x_p$ (as we supposed u is good) and for $1 \leq j \leq 1'$, $[u_j] = C_j[Y \Rightarrow X/X]$, and $x_p \notin FV(u_j)$; by the induction hypothesis b. we deduce then $u_j^* : \Gamma, \Delta[Y \Rightarrow X/X], A_1, \ldots, A_{p-1}, \Sigma \to C_j[Y \Rightarrow X/X]$, so we can put $u^* = \lambda x_1^{A_1} \ldots \lambda x_p^{A_p} .yu_1^* \ldots u_q^* x_p$.

From lemma 7.4 we deduce that IO is equivalent to the F_{at} -expansion property:

Proposition 7.8. For all $A \in \mathcal{L}_{\Rightarrow}$, $\forall XA$ has IO iff A is F_{at} -expansible.

Proof. For one direction, for all $B \in \mathcal{L}_{\Rightarrow,\forall}$, we can define $IO_A(B)[x] = EXP_A(B)[xZ/x]$, where Z is the rightmost variable of B.

For the converse direction, let $Y \notin FV(A)$ and $IO_A(Y \Rightarrow X) : \forall XA \to A[Y \Rightarrow X/X]$. By deleting second order constructs in $IO_A(Y \Rightarrow X)$ we obtain an arrow $u : A[Z_1/X_1], \ldots, A[Z_p/X_p]$, $A[Y_1/X_1], \ldots, A[Y_q/X_q] \to A[Y \Rightarrow X/X]$, where $Z_1, \ldots, Z_p \in FV(A)$ and $Y_1, \ldots, Y_q \notin FV(A)$. By reasoning as in the proof of lemma 7.3 we can suppose w.l.o.g. q = 1 and $Y_1 = Y$, i.e. $u : A[Z_1/X], \ldots, A[Z_r/X], A[Y/X] \to A[Y \Rightarrow X/X]$. By applying lemma 7.4 b. and possibly identifying some variables we obtain an arrow $u^* : A[Z_1/X], \ldots, A[Z_n/X], A \to A[Y \Rightarrow X/X]$. Now we can argue as in proposition 7.7: A is either derivable, or gRP_X or F_{at} -collapses to some gRP_X types. In all such cases A is F_{at} -expansible.

We then finally get:

Theorem 8. Let A be a simple type. Then $\forall XA$ has instantiation overflow iff it is either derivable or logically equivalent to a product of gRP types.

8 Some open questions

By exploiting ideas coming from linear logic and functorial polymorphism, we provided the first general investigation of the instantiation overflow phenomenon, providing a characterization of the types $\forall XA$, with A a simple type, satisfying this property, as well as a characterization of the linear and simple types satisfying the related expansion property. As it can be expected, there are many questions which naturally arise and are left open by the results contained in this paper. In the following lines we mention some of them.

First, it is not clear how to extend our characterization of instantiation overflow in terms of Russell-Prawitz types to all System F types, as the following example shows: let E be the second order type $\forall X(X \Rightarrow \forall ZZ \Rightarrow D)$, where $X \notin FV(D)$; then we can define, for $B = \forall \overline{Y}_1(B_1 \Rightarrow \dots \Rightarrow \forall Y_p(B_p \Rightarrow \forall Y_{p+1}Z)\dots)$, an expansion term $IO_D(B) : \forall XE \to E[B/X]$ in \mathcal{F}_{at} as follows

$$IO_D(B) = \lambda y^B \cdot \lambda z^{\forall ZZ} \cdot xZElim_B \left[EXP_Z(B_1)[z/x]/x_1, \dots, EXP_Z(B_p)[z/x]/x_p \right] z$$

Hence E has instantiation overflow, though it does not seem to be logically equivalent to any gRP_X type.

A second important question is about the decidability of the instantiation overflow property. For a simple type A, to decide whether $\forall XA$ enjoys IO one must check (1) whether A is derivable,

(2) whether A is gRP_X and (3) whether $\forall XA$ is logically equivalent to (better, F_{at} -collapses into) the product of a family of gRP_X types. Problems (1) and (2) are surely decidable for the restricted case considered in this paper (the property of being gRP_X for a simple type can be decided by checking its tilings). Problem (3) is surely decidable in the case of linear types, as one must only consider types with smaller logical complexity than A and variables included in those of A. The decidability of (3) remains open in the case of simple types and F_{at} .

In the case of full System F types, the instantiation overflow property is most likely to be undecidable, as (1) is undecidable in System F. Worse, (1) remains undecidable even if one restricts derivability to F_{at} , as this system, in spite of its weak expressive power, is undecidable. This follows from the fact that F_{at} is equivalent to $IFOL_{mon}^{1}$ the \Rightarrow, \forall -fragment of first-order intuitionistic logic over a language with one monadic predicate p(x) and no function symbol, which is known to be undecidable (see [Gab81], Th. 1, p. 234). The equivalence results from the bijective translation below

$$X_i^* = p(x_i) \qquad (A \Rightarrow B)^* = A^* \Rightarrow B^* \qquad (\forall X_i A)^* = \forall x_i A^*$$

which can be extended into a bijective translation of the rules of F_{at} and $IFOL_{mon}^{1}$.

Another natural question concerns the relationship between gRP types and logical connectives: if RP types correspond to the translation of logical connectives, what about gRP types? Proposition 7.5 shows that gRP_X types can be seen as qRP_X types whose variables have been identified. This suggests that gRP types can be seen as types translating connectives obtained by composing different basic connectives. For instance, the gRP_X type $((((A \Rightarrow B \Rightarrow X) \Rightarrow X) \Rightarrow X) \Rightarrow (C \Rightarrow X)) \Rightarrow X$ can be renamed as a $((((A \Rightarrow B \Rightarrow X_2) \Rightarrow X_2) \Rightarrow (C \Rightarrow X_1)) \Rightarrow X_1$, which is $qRP_{\{X_1, X_2\}}$ and yields a translation of the composed connective $(A \land B) \lor C$.

Finally, the problem of extending proposition 5.2, i.e. the equivalence of instantiation overflow and full extraction modulo dinaturality, to general Russell-Prawitz types should be considered, as the result does not seem to scale in a striaghtforward way to gRP types.

A Weak interpolation for $\lambda_{-\circ}$ nets

We show that every weak interpolation problem (definition 3.2) admits a solution in $\lambda_{-\circ}$. The arguments adapts the proof in [BdG96] of interpolation for $IMLL^{-}$ nets.

We first reformulate the splitting lemma for essential nets (see [MO03]):

Lemma A.1 (splitting). Let $f: \Gamma \to A$ in \mathcal{A}^{\multimap} , where $\Gamma = A_1, \ldots, A_m$ and $A = A_{m+1} \multimap \cdots \multimap A_{m+n} \multimap Z$. Then, for some $1 \leq i \leq m+n$, where $A_i = B_1 \multimap \cdots \multimap B_p \to Z$, there exists a partition $\mathscr{P} = \{\mathfrak{d}_1, \ldots, \mathfrak{d}_p\}$ of $\{1, \ldots, i-1, i+1, \ldots, m+n\}$ in p sets $\mathfrak{d}_1 = \{i_{11}, \ldots, i_{1k_1}\}, \ldots, \mathfrak{d}_p = \{i_{p1}, \ldots, i_{pk_p}\}$, where k_j denotes the cardinality of the j-th element of the partition, such that $f = g_1 \cup \cdots \cup g_p \cup \{(Z^-, Z^+\}, where g_j : \Gamma_j \to B_j \text{ is a correct net, for } \Gamma_j = A_{i_{j1}}, \ldots, A_{i_{jk_j}}, \text{ for } 1 \leq j \leq p.$

A graph $f : \Gamma \to A$ with *n* splitting cuts (see subsection 3.2) is *reduced* when all cuts are positive and any Γ_i is of the form Δ_i, cut , i.e. with a unique cut link.

Let $f: \Gamma \to A$ in \mathcal{A} . Given a directed path γ in the correction graph and a type B occurring in either A or Γ , we say the γ crosses B if γ passes through some node in vS_B .

We prove the following *splitting property* of correct graphs:

Proposition A.1 (splitting property). Let $f : \Gamma \to A$ in $\mathcal{A}^{-\circ}$, where $\Gamma = A_1, \ldots, A_m$ and $A = A_{m+1} \multimap \cdots \multimap A_{m+n} \multimap Z$. Let n_1, n_2 be two nodes in the correction graph of f such that there exist two paths from the conclusion to n_1 and to n_2 , respectively. Then, for no path γ_1 starting from n_1 and path γ_2 starting from n_2, γ_1 and γ_2 cross the same type A_i , for all $1 \leq i \leq m+n$.

Proof. By induction on the number k of nodes in the correction graph. If k = 2, then the claim is trivially true. Otherwise, by the splitting lemma A.1, f splits into $f_1 : \Gamma_1 \to B_1, \ldots, f_p : \Gamma_p \to B_p$, where, for some $1 \le i \le m + n$, $A_i = B_1 \multimap \cdots \multimap B_p \multimap Z$. Hence, the path starting from A reaches Z^+ , then passes through a negative occurrence of A_i and splits at all the \multimap^- -nodes in it. If n_1 and n_2 belong to the correction graphs of f_i, f_j for $i \ne j$, then we are done. If n_1, n_2 belong to the correction graphs of the same f_i , then we can apply the induction hypothesis as all paths γ_1, γ_2 belong to the correction graph of f_i and f_j , respectively.

The following lemma is the analogous of lemmas 7.1 and 7.2 in [BdG96] and provides an algorithm to construct the weak interpolants of an allowable graph.

Lemma A.2. Any graph with splitting cuts can be transformed into a reduced one.

Proof. We define an algorithm to transform a graph with splitting cuts into a reduced one.

1. For any cut^- , check if there is some cut^+ which is connected to cut^- by a path which never gets out of the subtree of A:



In this case then transform the graph as follows:



It can be easily verified that the new correction graph is still acyclic and functional. Once all such transformations are done or if there is no negative cut, go to step 2.

2. Choose one cut^- . If there is none go to step 3. Then there is a cut^+ which is connected to cut^- by a path which never gets out of the part of the graph over Δ_i :



This follows from the existence of a unique path from A to cut^- . In this case then transform the graph as follows:



It can be easily verified that the new correction graph is still acyclic and functional. Observe that the number of negative cuts decreases by one. If there is still one negative cut go back to step 1. Otherwise go to step 3.

3. Now all cuts are positive. If the graph is not yet reduced, then there exists two positive cuts as below:



By the splitting property, Δ_i splits then into two contexts Δ_i^1 and Δ_i^2 :



We can conclude that the graph is now reduced.

We can now prove the weak interpolation theorem.

Proof of theorem 3. Given $f: \Gamma \to A$, transform the graph in 10a into a graph with cuts, by replacing type I edges by either positive or negative cut links:



Now apply lemma A.2 to obtain a reduced graph with splitting cuts. The cut types I_1, \ldots, I_p are then the interpolants of f.
