

ASYMPTOTIC DILATION OF REGULAR HOMEOMORPHISMS

ABSTRACT. We study the asymptotic behavior of the ratio $|f(z)|/|z|$ as $z \rightarrow 0$ for mappings differentiable a.e. in the unit disc with non-degenerated Jacobian. The main tools involve the length-area functionals and angular dilatations depending on some real number p . The results are applied to homeomorphic solutions of a nonlinear Beltrami equation. The estimates are illustrated by examples.

1. INTRODUCTION

1.1. A very interesting problem of classical Complex Analysis is to extend Schwarz's Lemma to more general classes of functions than analytic ones. A result of such type has been established by Teichmüller [18] for quasiconformal mappings. He proved the existence of limit of $|f(z)|/|z|$ at the origin and called it *asymptotic dilation* assuming the finiteness of the integral of a form $\int_{|z|<1} (K_f(z) - 1)/|z|^2 dx dy$. Here $K_f(z)$ stands for the real coefficient of quasiconformality of the mapping f . Later the same result has been obtained by a different method (Ahlfors' inequalities) by Wittich [19]. For extensions of such results see also [3], [13], [14] and others. The most of these results involve the module technique (extremal lengths).

In the paper we apply the length-area method originated in 1920's and isoperimetric inequality; see, e.g. [1], [4], [10], [17].

Throughout the paper we consider sense-preserving homeomorphisms from the Sobolev class $W^{1,1}$ in the unit disc requiring regularity and possessing Lusin's (N) -property (preservation of sets with zero measure). The regularity of a mapping in a domain means its differentiability almost everywhere (a.e.) and nonvanishing Jacobian a.e. Since we study the $W^{1,1}$ -homeomorphisms, the differentiability a.e. follows *a priori*; see, e.g. [11]. Note that nonvanishing Jacobian is equivalent to Lusin's (N^{-1}) -property.

In this paper the asymptotic behavior (asymptotic dilation) of such mappings is studied under assumption that some integral mean of the angular dilatation is finite.

1.2. There are various counterparts of directional dilatations in the plane; see, e.g. [2], [9], [15]. These dilatations are much flexible than the classical (inner, outer, linear) ones and provide the important tools for investigation of local properties of quasiconformal mappings in the Euclidian and more general metric spaces (cf. [5], [6], [8]).

We use the following definition. Let D be a domain in \mathbb{C} and $f: D \rightarrow \mathbb{C}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$. For any $p > 1$, the quantity

$$(1.1) \quad D_p(z, 0) = D_p(re^{i\theta}, 0) = \frac{|f_\theta(re^{i\theta})|^p}{r^p J_f(re^{i\theta})}$$

is called *p-angular dilatation* of f at a point $z \in D$, $z \neq 0$, with respect to the origin. For simplicity of notations, we write $D_p(z) = D_p(z, 0)$.

1.3. Let $B_r = \{z \in \mathbb{C} : |z| < r\}$, $\gamma_r = \{z \in \mathbb{C} : |z| = r\}$, and $\mathbb{B} = B_1$. Our first result states:

Theorem 1.1. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$ possessing Lusin's (N)-property, and $f(0) = 0$. Suppose that there exists k such that for $p > 2$,*

$$(1.2) \quad \liminf_{r \rightarrow 0} \left(\frac{1}{\pi r^2} \iint_{B_r} D_p^{\frac{1}{p-1}}(z) dx dy \right)^{p-1} \leq k < \infty.$$

Then

$$(1.3) \quad \liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} \leq c_p k^{\frac{1}{p-2}} < \infty,$$

where c_p is a positive constant depending only on p .

Some results related to (1.3) are given in [7], [12], [16].

2. AUXILIARY RESULTS

We present several needed preliminary results. Some of those have an intrinsic interest.

2.1. For a measurable function $Q: D \rightarrow [0, +\infty]$ and $p > 1$, denote

$$(2.1) \quad q_p(r) = \left(\frac{1}{2\pi r} \int_{\gamma_r} Q^{\frac{1}{p-1}}(z) |dz| \right)^{p-1}.$$

When $Q(z) = D_p(z)$, we write $q_p(r) = d_p(r)$.

The following statement provides a differential inequality for the area functional $S(r) = m(f(B_r))$, where m denotes the two dimensional Lebesgue measure.

Lemma 2.1. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular $W_{\text{loc}}^{1,1}$ -homeomorphism with Lusin's (N) -property, and $p > 1$. Then for a.a. $r \in [0, 1]$,*

$$(2.2) \quad S'(r) \geq 2\pi^{\frac{2-p}{2}} r^{1-p} d_p^{-1}(r) S^{\frac{p}{2}}(r).$$

Proof. Denote by $L(r)$ the length of curve $f(re^{i\theta})$, $0 \leq \theta \leq 2\pi$. For a.a. $r \in [0, 1]$,

$$L(r) = \int_0^{2\pi} |f_\theta(re^{i\theta})| d\theta = \int_0^{2\pi} \left[D_p(re^{i\theta}) \right]^{\frac{1}{p}} \left[J_f(re^{i\theta}) \right]^{\frac{1}{p}} r d\theta,$$

and by Hölder's inequality,

$$(2.3) \quad L^p(r) \leq \left(\int_0^{2\pi} \left[D_p(re^{i\theta}) \right]^{\frac{1}{p-1}} r d\theta \right)^{p-1} \int_0^{2\pi} J_f(re^{i\theta}) r d\theta.$$

Due to Lusin's (N) -property and the Fubini theorem,

$$S(r) = \iint_{B_r} J_f(z) dx dy = \int_0^r \int_0^{2\pi} J_f(te^{i\theta}) t dt d\theta;$$

hence, for a.a. $r \in [0, 1]$,

$$S'(r) = \int_0^{2\pi} J_f(re^{i\theta}) r d\theta.$$

Estimating the last integral by (2.3) and using (2.1) for $Q(z) = D_p(z)$, one obtains

$$(2.4) \quad S'(r) \geq \frac{L^p(r)}{(2\pi r)^{p-1} d_p(r)}.$$

Combining (2.4) with the planar isoperimetric inequality $L^2(r) \geq 4\pi S(r)$ implies the desired relation (2.2). \square

The inequality (2.4) allows us to derive a counterpart of the classical length-area principle for conformal and quasiconformal mappings; see, e.g. [17].

Integrating (2.4), one gets for $0 < r_1 < r < r_2 < 1$,

$$\int_{r_1}^{r_2} \frac{L^p(r) dr}{(2\pi r)^{p-1} d_p(r)} \leq S(r_2) - S(r_1) \leq S(r_2).$$

2.2. The upper bounds for the images of B_r under regular homeomorphisms of Sobolev class $W^{1,1}$ are established in the following statement for any $p > 2$. For the case $p = 2$, we refer to [4, Proposition 3.7].

Lemma 2.2. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular $W_{\text{loc}}^{1,1}$ -homeomorphism with Lusin's (N) -property, and $p > 2$. Then for a.a. $r \in [0, 1]$,*

$$(2.5) \quad S(r) \leq \pi(p-2)^{-\frac{2}{p-2}} \left(\int_r^1 \frac{dt}{t^{p-1} d_p(t)} \right)^{-\frac{2}{p-2}}.$$

Proof. By (2.2) for a.a. $r \in [0, 1]$,

$$\frac{S'(r) dr}{S^{\frac{p}{2}}(r)} \geq 2\pi^{\frac{2-p}{2}} \frac{dr}{r^{p-1} d_p(r)},$$

and integrating over the segment $[r, 1]$, we obtain

$$\int_r^1 g'_p(t) dt \geq 2\pi^{\frac{2-p}{2}} \int_r^1 \frac{dt}{t^{p-1} d_p(t)},$$

where $g_p(t) = \frac{2}{2-p} S^{\frac{2-p}{2}}(t)$. This function is nondecreasing on $[0, 1]$, and

$$\int_r^1 g'_p(t) dt \leq g_p(1) - g_p(r) = \frac{2}{2-p} \left(S^{\frac{2-p}{2}}(1) - S^{\frac{2-p}{2}}(r) \right).$$

Combining the last two inequalities, we have

$$\frac{S^{\frac{2-p}{2}}(1) - S^{\frac{2-p}{2}}(r)}{2-p} \geq \pi^{\frac{2-p}{2}} \int_r^1 \frac{dt}{t^{p-1} d_p(t)}.$$

This implies the inequality (2.5), because for $p > 2$,

$$S^{\frac{2-p}{2}}(r) \geq S^{\frac{2-p}{2}}(r) - S^{\frac{2-p}{2}}(1) \geq \pi^{\frac{2-p}{2}} (p-2) \int_r^1 \frac{dt}{r^{p-1} d_p(t)}.$$

□

2.3. The following result estimates the integrals of the type (2.1) in the terms of integral averages for Q .

Lemma 2.3. *Let $p > 1$ and $Q: \mathbb{B} \rightarrow [0, \infty]$ be locally integrable with the exponent $\frac{1}{p-1}$ in \mathbb{B} . Then for any $\varepsilon \in [0; \frac{1}{2}]$ the following estimate*

$$\left(\int_{\varepsilon}^{2\varepsilon} \frac{dr}{r^{p-1} q_p(r)} \right)^{-1} \leq 2^{p-1} \varepsilon^{p-2} \left(\frac{1}{4\pi\varepsilon^2} \iint_{B_{2\varepsilon}} Q^{\frac{1}{p-1}}(z) dx dy \right)^{p-1},$$

holds, where $q_p(r)$ is defined by (2.1).

Proof. Notify that

$$\varepsilon = \int_{\varepsilon}^{2\varepsilon} \frac{1}{\left(\int_{\gamma_r} Q^{\frac{1}{p-1}}(z) |dz| \right)^{\frac{p-1}{p}}} \cdot \left(\int_{\gamma_r} Q^{\frac{1}{p-1}}(z) |dz| \right)^{\frac{p-1}{p}} dr,$$

one obtains by Hölder's inequality with the exponents p and $p' = p/(p-1)$,

$$\varepsilon^p \leq \int_{\varepsilon}^{2\varepsilon} \frac{dr}{\left(\int_{\gamma_r} Q^{\frac{1}{p-1}}(z) |dz| \right)^{p-1}} \cdot \left(\int_{\varepsilon}^{2\varepsilon} \int_{\gamma_r} Q^{\frac{1}{p-1}}(z) |dz| dr \right)^{p-1}.$$

Now by the Fubini theorem,

$$\left(\int_{\varepsilon}^{2\varepsilon} \frac{dr}{\left(\int_{\gamma_r} Q^{\frac{1}{p-1}}(z) |dz| \right)^{p-1}} \right)^{-1} \leq 4^{p-1} \pi^{p-1} \varepsilon^{p-2} \left(\frac{1}{\pi(2\varepsilon)^2} \iint_{B_{2\varepsilon}} Q^{\frac{1}{p-1}}(z) dx dy \right)^{p-1},$$

which completes the proof. \square

2.4. We also provide a lower bound for $S(r)$ when $1 < p < 2$.

Lemma 2.4. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular $W_{\text{loc}}^{1,1}$ -homeomorphism possessing Lusin's (N)-property, and $1 < p < 2$. Then for a.a. $r \in [0, 1]$,*

$$(2.6) \quad S(r) \geq \pi(2-p)^{\frac{2}{2-p}} \left(\int_0^r \frac{dt}{t^{p-1} d_p(t)} \right)^{\frac{2}{2-p}}.$$

Proof. Integrating (2.2) along the segment $[0, r]$, and arguing similar to the proof of Lemma 2.2, we arrive at

$$\frac{S^{\frac{2-p}{2}}(r) - S^{\frac{2-p}{2}}(0)}{2-p} \geq \pi^{\frac{2-p}{2}} \int_0^r \frac{dt}{t^{p-1} d_p(t)},$$

which implies (2.6), because $S(0) = 0$. \square

Lemma 2.4 yields that for any homeomorphism $f: \mathbb{B} \rightarrow \mathbb{B}$ satisfying its assumptions, the integral $\int_0^1 dt/(t^{p-1} d_p(t))$ always converges.

Indeed, for $1 < p < 2$, we have the estimate

$$\pi(2-p)^{\frac{2}{2-p}} \left(\int_0^r \frac{dt}{t^{p-1} d_p(t)} \right)^{\frac{2}{2-p}} \leq S(r) \leq \pi,$$

which implies

$$\int_0^r \frac{dt}{t^{p-1} d_p(t)} \leq \frac{1}{2-p}, \quad \forall r \in (0, 1).$$

Now letting $r \uparrow 1$, one obtains

$$\int_0^1 \frac{dt}{t^{p-1} d_p(t)} \leq \frac{1}{2-p} < \infty.$$

3. PROOFS OF UPPER BOUNDS AND ILLUSTRATING EXAMPLES

3.1. We start with the proof of Theorem 1.1.

Proof. Let $l_f(r) = \min_{|z|=r} |f(z)|$. Since $f(0) = 0$, $\pi l_f^2(r) \leq S(r)$, or equivalently,

$$(3.1) \quad l_f(r) \leq \sqrt{\frac{S(r)}{\pi}}.$$

It follows from combining Lemmas 2.2 and 2.3 that for $p > 2$,

$$(3.2) \quad \frac{S(r)}{\pi r^2} \leq c'_p \left(\frac{1}{4\pi r^2} \iint_{B_{2r}} D_p^{\frac{1}{p-1}}(z) dx dy \right)^{\frac{2(p-1)}{p-2}},$$

where $r \in [0, \frac{1}{2}]$ and c'_p is a positive constant depending only on p . Here we have weakened the inequality (2.5) replacing the limits r and 1 by r and $2r$, $r \in [0, \frac{1}{2}]$.

Now by (3.1), (3.2) and (1.2),

$$\begin{aligned} \liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} &= \liminf_{r \rightarrow 0} \frac{l_f(r)}{r} \leq \liminf_{r \rightarrow 0} \sqrt{\frac{S(r)}{\pi r^2}} \\ &\leq \liminf_{r \rightarrow 0} \sqrt{c'_p \left(\frac{1}{4\pi r^2} \iint_{B_{2r}} D_p^{\frac{1}{p-1}}(z) dx dy \right)^{\frac{2(p-1)}{p-2}}} \leq c_p k^{\frac{1}{p-2}}, \end{aligned}$$

with $c_p > 0$ depending only on p . This completes the proof. \square

3.2. We now illustrate the sharpness of the growth order in the inequality (1.3).

Example 3.1. Consider $f: \mathbb{B} \rightarrow \mathbb{B}$ given by $f(z) = kz$, $0 < |k| \leq 1$.

By a direct calculation, letting $z = re^{i\theta}$, the partial derivatives

$$f_\theta = kire^{i\theta}, \quad f_r = ke^{i\theta}$$

and

$$J_f(re^{i\theta}) = \frac{1}{r} \operatorname{Im}(f_\theta \cdot \overline{f_r}) = |k|^2.$$

Hence,

$$D_p(re^{i\theta}) = \frac{|f_\theta|^p}{r^p J_f(re^{i\theta})} = |k|^{p-2},$$

and therefore,

$$\lim_{r \rightarrow 0} \left(\frac{1}{\pi r^2} \iint_{B_r} D_p^{\frac{1}{p-1}}(z) dx dy \right)^{p-1} = |k|^{p-2}.$$

On the other hand,

$$\lim_{z \rightarrow 0} \frac{|f(z)|}{|z|} = |k|.$$

3.3. The next example shows that the condition (1.2) in Theorem 1.1 cannot be omitted.

Example 3.2. Assume that $p > 2$ and f is an automorphism of the unit disc \mathbb{B} of the form

$$f(z) = \left(1 + (p-2) \int_{|z|}^1 \frac{dt}{t^{p-1} (\ln \frac{e}{t})^{p-1}} \right)^{\frac{1}{2-p}} \frac{z}{|z|}, \quad \text{for } z \neq 0,$$

and $f(0) = 0$.

We shall use the notations

$$I(r) = 1 + (p-2) \int_r^1 \frac{dt}{t^{p-1} \left(\ln \frac{e}{t}\right)^{p-1}}$$

for $r \neq 0$, $R(r) = I^{-\frac{1}{p-2}}(r)$, if $r \neq 0$, and extend $R(r)$ to the origin by $R(0) = 0$.

Then $f(z) = R(r)e^{i\theta}$, where $z = re^{i\theta}$. Note that f is a diffeomorphism in $\mathbb{B} \setminus \{0\}$, which implies that $f \in W_{\text{loc}}^{1,2}(\mathbb{B} \setminus \{0\})$, although f belongs to $W^{1,1}$ in the whole disc \mathbb{B} . Denote by λ_1 and λ_2 the maximal and minimal stretchings of f at $z = re^{i\theta}$, $0 < r < 1$, then $\lambda_1 = R(r)/r$, $\lambda_2 = R'(r) = R(r)r^{1-p} \ln^{1-p}(e/r)I^{-1}(r)$, and

$$\iint_{B_r} \lambda_1 dx dy = \iint_{B_r} \frac{R(|z|)}{|z|} dx dy \leq M_r \iint_{B_r} \frac{dx dy}{|z|} = 2\pi r M_r < \infty,$$

where $M_r = \max_{z \in \overline{B}_r} |f(z)|$, $\overline{B}_r = \{z \in \mathbb{C} : |z| \leq r\}$. By a direct calculation, $f_r = R'(r)e^{i\theta}$, $f_\theta = iR(r)e^{i\theta}$, and

$$J_f(re^{i\theta}) = \frac{1}{r} \text{Im}(f_\theta \cdot \overline{f_r}) = \frac{R(r)R'(r)}{r}.$$

Hence,

$$D_p(re^{i\theta}) = \frac{|f_\theta|^p}{r^p J_f(re^{i\theta})} = \frac{R^{p-1}(r)}{r^{p-1} R'(r)} = \left(\ln \frac{e}{r}\right)^{p-1},$$

and therefore,

$$\liminf_{r \rightarrow 0} \frac{1}{\pi r^2} \iint_{B_r} D_p^{\frac{1}{p-1}}(z) dx dy = \infty.$$

Now instead of (1.3), we have by L'Hopital's rule,

$$\liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} = \infty.$$

3.4. As the consequences of Theorem 1.1, we obtain

Corollary 3.3. *If $D_p(z) \leq k < \infty$ for a.a. $z \in \mathbb{B}$, then*

$$\liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} \leq c_p k^{\frac{1}{p-2}},$$

with a positive constant c_p depending only on p .

Corollary 3.4. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$, possessing Lusin's (N)-property and satisfying $f(0) = 0$. Assume that $p > 2$ and*

$$\liminf_{r \rightarrow 0} \frac{1}{\pi r^2} \iint_{B_r} D_p^{\frac{1}{p-1}}(z) \, dx dy = 0.$$

Then

$$\liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} = 0.$$

We illustrate the last corollary by

Example 3.5. Take a radial stretching $f(z) = z|z|^\alpha$, $\alpha > 0$, of the unit disc \mathbb{B} .

Then, letting $z = re^{i\theta}$, $f(z) = r^{\alpha+1}e^{i\theta}$,

$$f_\theta = ir^{\alpha+1}e^{i\theta}, \quad f_r = (\alpha+1)r^\alpha e^{i\theta}$$

and

$$J_f(re^{i\theta}) = \frac{1}{r} \text{Im}(f_\theta \cdot \bar{f}_r) = (\alpha+1)r^{2\alpha}.$$

Therefore,

$$D_p(re^{i\theta}) = \frac{|f_\theta|^p}{r^p J_f(re^{i\theta})} = \frac{1}{\alpha+1} \cdot r^{\alpha(p-2)},$$

and for $p > 2$,

$$\lim_{r \rightarrow 0} \frac{1}{\pi r^2} \iint_{B_r} D_p^{\frac{1}{p-1}}(z) \, dx dy = 0.$$

On the other hand,

$$\lim_{z \rightarrow 0} \frac{|f(z)|}{|z|} = 0.$$

3.5. The asymptotic dilation of regular homeomorphisms $f: \mathbb{B} \rightarrow \mathbb{B}$ can be established also by applying a different assumption, which we call lim sup condition.

Theorem 3.6. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$ possessing Lusin's (N)-property and normalized by $f(0) = 0$. Suppose that $p > 2$ and there exists k_0 such that*

$$k_0 = \limsup_{r \rightarrow 0} r^{p-2} \int_r^1 \frac{dt}{t^{p-1} d_p(t)}.$$

Then

$$(3.3) \quad \liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} \leq (p-2)^{\frac{1}{2-p}} k_0^{\frac{1}{2-p}}.$$

Proof. Arguing similarly to the beginning of the proof of Theorem 1.1 and applying the upper bound (2.5) for $S(r)$, one gets

$$\begin{aligned} \liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} &\leq \liminf_{r \rightarrow 0} \sqrt{\frac{S(r)}{\pi r^2}} \\ &\leq \liminf_{r \rightarrow 0} \frac{(p-2)^{\frac{1}{2-p}}}{r} \left(\int_r^1 \frac{dt}{t^{p-1} d_p(t)} \right)^{\frac{1}{2-p}} = (p-2)^{\frac{1}{2-p}} k_0^{\frac{1}{2-p}}. \end{aligned}$$

□

The sharpness of the upper bound (3.3) in Theorem 3.6 is illustrated by Example 3.1. Indeed, by (2.1) $D_p(z) = |k|^{p-2}$, thus, $d_p(t) = |k|^{p-2}$ for all $t \in (0, 1)$. Therefore,

$$\limsup_{r \rightarrow 0} r^{p-2} \int_r^1 \frac{dt}{t^{p-1} d_p(t)} = \frac{1}{(p-2)|k|^{p-2}}.$$

Denoting $k_0 = \frac{1}{(p-2)|k|^{p-2}}$, we have $|k| = (p-2)^{\frac{1}{2-p}} k_0^{\frac{1}{2-p}}$, which coincides with $\lim_{z \rightarrow 0} |f(z)|/|z|$.

4. LOWER AND UPPER BOUNDS FOR THE RATIO $|f(z)|/|z|$ AND FOR JACOBIAN

4.1. The asymptotic dilation of regular homeomorphisms $f: \mathbb{B} \rightarrow \mathbb{B}$ can be derived by applying the following limsup conditions.

Theorem 4.1. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$ possessing Lusin's (N)-property, and $f(0) = 0$. Suppose that $1 < p < 2$ and there exists k_0 such that*

$$k_0 = \limsup_{r \rightarrow 0} r^{p-2} \int_0^r \frac{dt}{t^{p-1} d_p(t)}.$$

Then

$$(4.1) \quad \limsup_{z \rightarrow 0} \frac{|f(z)|}{|z|} \geq (2-p)^{\frac{1}{2-p}} k_0^{\frac{1}{2-p}}.$$

Proof. Denote $\mathcal{L}_f(r) = \max_{|z|=r} |f(z)|$. Since $f(0) = 0$, we have $\pi \mathcal{L}_f^2(r) \geq S(r)$, or equivalently,

$$\mathcal{L}_f(r) \geq \sqrt{\frac{S(r)}{\pi}}.$$

Thus,

$$\begin{aligned} \limsup_{z \rightarrow 0} \frac{|f(z)|}{|z|} &\geq \limsup_{r \rightarrow 0} \sqrt{\frac{S(r)}{\pi r^2}} \\ &\geq \limsup_{r \rightarrow 0} \frac{(2-p)^{\frac{1}{2-p}}}{r} \left(\int_0^r \frac{dt}{t^{p-1} d_p(t)} \right)^{\frac{1}{2-p}} = (2-p)^{\frac{1}{2-p}} k_0^{\frac{1}{2-p}}. \end{aligned}$$

□

We illustrate the sharpness of the lower bound (4.1) in Theorem 4.1 by the same example (Example 3.1). Indeed, the condition (4.1) is fulfilled with $k_0 = |k|^{2-p}(2-p)^{-1}$, and $\lim_{r \rightarrow 0} |f(z)|/|z| = |k| < \infty$.

4.2. As a consequence of Theorems 4.1 and 3.6, one obtains, when the ratio $|f(z)|/|z|$ has only one limit point, the following statement.

Theorem 4.2. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$ possessing Lusin's (N)-property, and $f(0) = 0$. Suppose that $1 < p < 2$ and there exist k_1 and k_2 such that*

$$\begin{aligned} k_1 &= \limsup_{r \rightarrow 0} r^{p-2} \int_0^r \frac{dt}{t^{p-1} d_p(t)}, \\ k_2 &= \limsup_{r \rightarrow 0} r^{p'-2} \int_r^1 \frac{dt}{t^{p'-1} d_{p'}(t)}. \end{aligned}$$

Then, if $\lim_{z \rightarrow 0} |f(z)|/|z| = A$, the following double estimate

$$(4.2) \quad (2-p)^{\frac{1}{2-p}} k_1^{\frac{1}{2-p}} \leq A \leq (p'-2)^{\frac{1}{2-p'}} k_2^{\frac{1}{2-p'}},$$

holds. Here $p' = p/(p-1)$, $2 < p' < \infty$.

Proof. The proof immediately follows from the assertions of the above theorems for p , $1 < p < 2$, and $p' = p/(p-1)$, $2 < p' < \infty$. □

Remark 4.3. The inequality (4.2) provides the following relation between the constants k_1 and k_2 in Theorem 4.2,

$$k_1 \leq \frac{(p-1)^{p-1}}{(2-p)^p k_2^{p-1}}, \quad 1 < p < 2.$$

4.3. The estimates established in Lemmas 2.2 and 2.4 imply the following result concerning the area derivative and the Jacobian at the origin.

Theorem 4.4. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphism of Sobolev class $W_{\text{loc}}^{1,1}$ possessing Lusin's (N)-property. Suppose that for real numbers p and s , $1 < p < 2 < s < \infty$, there exist and coincide the following limits*

$$\lim_{r \rightarrow 0} (2-p)^{\frac{2}{2-p}} \left(r^{p-2} \int_0^r \frac{dt}{t^{p-1} d_p(t)} \right)^{\frac{2}{2-p}} = \lim_{r \rightarrow 0} (s-2)^{\frac{2}{2-s}} \left(r^{s-2} \int_r^1 \frac{dt}{t^{s-1} d_s(t)} \right)^{\frac{2}{2-s}} = A.$$

Then, the area derivative μ_f exists at 0, and

$$\mu_f(0) = \lim_{r \rightarrow 0} \frac{S(r)}{\pi r^2} = A.$$

Proof. Applying Lemmas 2.2 and 2.4 to $S(r)/\pi r^2$, and letting $r \rightarrow 0$, one obtains the assertion of Theorem 4.4. \square

Corollary 4.5. *If $z_0 = 0$ is a point of differentiability of f , then $J_f(0) = A$.*

5. NONLINEAR BELTRAMI EQUATION

5.1. Let D be a domain in \mathbb{C} and $\mu: D \rightarrow \mathbb{C}$ be a measurable function with $|\mu(z)| < 1$ a.e. in D . The linear PDE

$$(5.1) \quad f_{\bar{z}} = \mu(z) f_z.$$

is called the Beltrami equation; here $z = x + iy$,

$$f_{\bar{z}} = \frac{1}{2}(f_x + if_y), \quad f_z = \frac{1}{2}(f_x - if_y).$$

The function μ is called the complex dilatation, and

$$K_\mu(z) = \frac{1 + |\mu(z)|}{1 - |\mu(z)|}$$

is the real dilatation coefficient (or Lavrentiev coefficient) of (5.1).

For the case when K_μ is not essentially bounded, i.e. $\|K_\mu\|_\infty = \infty$, (5.1) is called the degenerate Beltrami equation.

5.2. Let $\sigma: D \rightarrow \mathbb{C}$ be a measurable function, and $m \geq 0$. We consider the following nonlinear equation

$$(5.2) \quad f_r = \sigma(re^{i\theta}) |f_\theta|^m f_\theta,$$

written in the polar coordinates (r, θ) . Here f_r and f_θ are the partial derivatives of f in r and θ , respectively, satisfying

$$r f_r = z f_z + \bar{z} f_{\bar{z}}, \quad f_\theta = i(z f_z - \bar{z} f_{\bar{z}}).$$

The equation (5.2) in the Cartesian coordinates has the form

$$(5.3) \quad f_{\bar{z}} = \frac{A(z)|zf_z - \bar{z}f_{\bar{z}}|^m - 1}{A(z)|zf_z - \bar{z}f_{\bar{z}}|^m + 1} \frac{z}{\bar{z}} f_z,$$

where $A(z) = \sigma(z)|z|i$, or

$$f_{\bar{z}} = \frac{A(z)(|z|^2|f_z|^2 - 2\operatorname{Re}(z^2 f_z \bar{f}_{\bar{z}}) + |z|^2|f_{\bar{z}}|^2)^{m/2} - 1}{A(z)(|z|^2|f_z|^2 - 2\operatorname{Re}(z^2 f_z \bar{f}_{\bar{z}}) + |z|^2|f_{\bar{z}}|^2)^{m/2} + 1} \frac{z}{\bar{z}} f_z.$$

Note that in the case $m = 0$, the equation (5.2) is the usual Beltrami equation (5.1) with the complex dilatation

$$\mu(z) = \frac{z A(z) - 1}{\bar{z} A(z) + 1}.$$

5.3. Now we present an application of the main result to homeomorphic solutions of the non-linear equation (5.2).

Theorem 5.1. *Let $f: \mathbb{B} \rightarrow \mathbb{B}$ be a regular homeomorphic solution of the equation (5.2) which belongs to Sobolev class $W_{\text{loc}}^{1,2}$, and normalized by $f(0) = 0$. Assume that the coefficient $\sigma: \mathbb{B} \rightarrow \mathbb{C}$ satisfies the following condition*

$$(5.4) \quad \liminf_{r \rightarrow 0} \left(\frac{1}{\pi r^2} \iint_{B_r} \frac{dx dy}{|z| (\operatorname{Im} \bar{\sigma}(z))^{m+1}} \right)^{m+1} \leq \sigma_0 < \infty.$$

Then

$$\liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} \leq c_m \sigma_0^{\frac{1}{m}} < \infty,$$

where c_m is a positive constant depending on the parameter m .

Proof. In the polar coordinates, the Jacobian of a sense-preserving mapping f has the form $J_f(re^{i\theta}) = \frac{1}{r} \operatorname{Im}(\bar{f}_r \cdot f_\theta)$, then the equalities (1.1) and (5.2) yield,

$$D_p(z) = \frac{|f_\theta|^p}{r^{p-1} |f_\theta|^{m+2} \operatorname{Im}(\bar{\sigma}(z))}.$$

Letting $p = m + 2$, one rewrites the condition (1.2) as

$$\liminf_{r \rightarrow 0} \left(\frac{1}{\pi r^2} \iint_{B_r} \frac{dx dy}{|z| (\operatorname{Im}(\bar{\sigma}(z)))^{\frac{1}{m+1}}} \right)^{m+1} \leq \sigma_0.$$

Then, by Theorem 1.1,

$$\liminf_{z \rightarrow 0} \frac{|f(z)|}{|z|} \leq \tilde{c}_m \sigma_0^{\frac{1}{m}},$$

which completes the proof. Here $\tilde{c}_m = c_{m+2}$ (from Theorem 1.1) depends only on m . \square

Example 5.2. Assume that $m > 0$ and $\kappa > 0$. Consider the equation

$$(5.5) \quad f_r = \frac{-i}{\kappa r^{m+1}} |f_\theta|^m f_\theta,$$

in the unit disc.

Now $\sigma = -i\kappa^{-1}r^{-m-1}$ and satisfies the condition (5.4) with $\sigma_0 = \kappa$. It is easy to check that $f = \kappa^{\frac{1}{m}} r e^{i\theta}$ is a solution of the equation (5.5), for which

$$\lim_{z \rightarrow 0} \frac{|f(z)|}{|z|} = \kappa^{\frac{1}{m}} < \infty.$$
