# Spectral representations of quasi-infinitely divisible processes

#### Abstract

In this work we first introduce quasi-infinitely divisible (QID) random measures and formulate spectral representations. Then, we introduce QID stochastic integrals and present integrability conditions and continuity properties. Further, we introduce QID stochastic processes, *i.e.* stochastic processes with QID finite dimensional distributions. For example, a process *X* is QID if there exist two ID processes *Y* and *Z* such that  $X + Y \stackrel{d}{=} Z$  with *Y* independent of *X*. The class of QID processes is strictly larger than the class of ID processes. We provide spectral representations and Lévy-Khintchine formulations for potentially all QID processes. Finally, we prove that QID random measures are dense in the space of random measures under convergence in distribution. Throughout this work we present many examples.

Key words: quasi-infinitely divisible distributions, random measure, stochastic integral, Lévy-Khintchine formulation, infinitely divisible.

# <span id="page-1-0"></span>1 Introduction

Infinitely divisible (ID) distributions represents one of the main class of probability distributions. Their development goes back to the work of L´evy and De Finetti. Concerning ID processes, one of the most pivotal work in the field is given by the Rajput and Rosinski paper in 1989 [\[23\]](#page-43-0). This work provides extremely useful results on the spectral representation of discrete and centred continuous ID process.

Recently, a series of works shed new light on a broader class of distributions called quasi-ID (QID) distributions, where the Lévy measure is now a signed measure (thus taking negative values). The recent work of Lindner, Pan and Sato [\[15\]](#page-42-0) represents one of the most important papers of this series. It shows for example that the set of QID distributions is dense in the set of all probability distributions with respect to weak convergence. Moreover, they proved that a distribution concentrated on the integers is QID if and only if its characteristic function does not have zeroes. This last result is extended in [\[1\]](#page-42-1) to distributions which can be written as the sum of a distribution concentrated on the integers and a distribution which is absolutely continuous w.r.t. the Lebesgue measure. An interesting result shown in [\[1\]](#page-42-1) states that a distribution which has a Lévy measure with complex values cannot exist.

QID distributions have been shown to have links to the field of prime numbers as well. Indeed, in [\[18\]](#page-42-2) it is shown that  $\frac{\xi(\sigma - it)}{\xi(\sigma)}$ , where  $\xi$  is the complete Riemann zeta function and  $t, \sigma \in \mathbb{R}$ , has a characteristic function which is QID, but not ID, for  $\sigma > 1$ . In addition, in [\[19\]](#page-43-1) it is shown that any zeta distribution defined by Dirichlet series  $\sum_{n=1}^{\infty} a(n)n^{-s}$  with  $a(1) > 0$ ,  $a(n) \ge 0$  when  $n \ge 2$  and  $a(n) = O(n^{\varepsilon})$  for any  $\varepsilon > 0$  is quasi infinitely divisible if  $\Re(s) > 1$  is sufficiently large. Further, QID distributions turn out to be of importance in mathematical physics too, as seen in [\[2\]](#page-42-3) and [\[5\]](#page-42-4).

Therefore, it appears natural to see to what extent the results in [\[23\]](#page-43-0) extend to the QID case. This is part of the content of the present work. Indeed, this work extends the results of the celebrated 1989 paper by Rajput and Rosinski to the QID framework. However, we also investigate general questions like: What is the Lévy-Khintchine representation of QID processes? What is the Lévy-Khintchine representation when the QID process belongs to *l*<sup>2</sup> (the Hilbert space of square summable sequences)? What is the connection between QID processes and Lévy processes? Are QID random measures dense in the space of random measures?

This work is structured as follows. Section [2](#page-1-1) introduces the notation and preliminaries, including the introduction of QID random measures. Section [3](#page-5-0) shows the connections between QID and ID random measures. In Section [4](#page-8-0) we present general results on QID random measures and show explicit cases in which they arise. In Section [5](#page-10-0) QID stochastic integrals are defined. We extend the measure theoretical results at the heart of the Rajput and Rosinski's 1989 paper ([\[23\]](#page-43-0)) to the signed measure framework, and provide a Lévy-Khintchine representation and integrability conditions for QID stochastic integrals. In Section [6](#page-26-0) we show a continuity property of the QID stochastic integral. In Section [7](#page-29-0) quasi-Lévy measures on  $l_2$  and QID processes are defined. We prove that *X* is QID if there exist two ID processes *Y* and *Z* such that  $X + Y \stackrel{d}{=} Z$  with *Y* independent of *X*. In this case we say that *X* is *generated* by *Y* and *Z*, and the class of such QID processes is called *generated QID processes*. We provide a Lévy-Khintchine representation for generated QID processes on  $l_2$ and for generated QID processes of any arbitrary index set, and present a spectral representation for discrete parameters generated QID processes *à la* Rajput and Rosinski. In the last subsection of Section [7,](#page-29-0) we show further results on general QID processes and provide some examples. Finally, in Section [8,](#page-37-0) we discuss the atomless condition of random measures in the QID framework and then show that QID random measures are dense in the space of random measures under convergence in distribution.

# <span id="page-1-1"></span>2 Notation and Preliminaries

In this section we introduce the notation and the preliminaries needed in this work.

By a measure on a measurable space  $(X, \mathscr{G})$  we always mean a positive measure on  $(X, \mathscr{G})$ , namely an [0,∞]-valued <sup>σ</sup>-additive set function on G that assigns the value 0 to the empty set. Given a non-empty

set *X*, the symbol  $\mathcal{B}(X)$  stands for the Borel  $\sigma$ -algebra of *X*, unless stated differently. The law and the characteristic function of a random variable *X* will be denoted by  $\mathscr{L}(X)$  and by  $\mathscr{L}(X)$ , respectively. We will use term *measure* for a positive measure and the term *signed measure* for a signed measure. Finally, due to their frequent use we abbreviate the following words: random variable by r.v., random measure by r.m., characteristic function by c.f. and characteristic triplet by c.t..

Given the importance of signed measures in this work we recall now the definition and some properties.

<span id="page-2-1"></span>**Definition 2.1** (signed measure). *Given a measurable space*  $(X, \Sigma)$ *, that is, a set X with a* σ-algebra Σ *on it, an extended signed measure is a function*  $\mu : \Sigma \to \mathbb{R} \cup {\infty, -\infty}$  *s.t.*  $\mu(\emptyset) = 0$  *and*  $\mu$  *is sigma additive, that is, it satisfies the equality*  $\mu(\bigcup_{n=1}^{\infty} A_n) = \sum_{n=1}^{\infty} \mu(A_n)$  where the series on the right must converge in R ∪ {∞,−∞} *absolutely (namely the value of the series is independent of the order of its elements), for any sequence*  $A_1, A_2, \ldots$  *of disjoint sets in*  $\Sigma$ *.* 

As a consequence any extended signed measure can take plus or minus infinity as value but not both. Recall also that the *total variation* of a signed measure  $\mu$  is defined as the measure  $|\mu| : \Sigma \to [0, \infty]$  defined by

$$
|\mu|(A) := \sup \sum_{j=1}^{\infty} |\mu(A_j)| \tag{1}
$$

where the supremum is taken over all the partitions  $\{A_i\}$  of  $A \in \Sigma$ . The total variation  $|\mu|$  is finite if and only if  $\mu$  is finite. By the Hahn decomposition theorem, for any signed measure  $\mu$ , there exist disjoint Borel sets *C*<sup>+</sup> and *C*<sup>−</sup> with *C*<sup>+</sup> ∪*C*<sup>−</sup> = *X* and *C*<sup>+</sup> ∩*C*<sup>−</sup> =  $\emptyset$  s.t.  $\mu(A \cap C^+) \ge 0$  and  $\mu(A \cap C^-) \le 0$  for every  $A \in \Sigma$ . In the following, we present the definition of mutually singular measures and the Jordan decomposition theorem.

**Definition 2.2.** *Two measures*  $\mu$  *and*  $\nu$  *on*  $(X, \Sigma)$  *are said to be* mutually singular *if there are disjoint sets*  $A, B \in \Sigma$  *with*  $X = A \cup B$  *and*  $\mu(A) = 0$  *while*  $\nu(B) = 0$ *. In this case, we write*  $\mu \perp \nu$ *.* 

**Theorem 2.3** (Jordan Decomposition Theorem). Let  $\mu$  be a signed measure on  $(X, \Sigma)$ . Then there exist two *mutually singular positive measures*  $\mu^+$  *and*  $\mu^-$  *such that*  $\mu = \mu^+ - \mu^-$ *. Furthermore, if*  $\lambda$  *and*  $\nu$  *are any two positive measures with*  $\mu = \lambda - \nu$ , then for each  $E \in \Sigma$  we have  $\lambda(E) \ge \mu^+(E)$  and  $\nu(E) \ge \mu^-(E)$ . *Finally, if*  $\lambda \perp v$ *, then*  $\lambda = \mu^+$  *and*  $v = \mu^-$ *.* 

Recall that while the Jordan decomposition is unique the Hahn decomposition is only essential unique, indeed  $\mu$ -null sets can be transferred from  $C^+$  to  $C^-$  and vice versa.

Definition 2.4 (Signed bimeasure). *Let* (*X*,Σ) *and* (*Y*,Γ) *be two measurable spaces,* Σ × Γ *the Cartesian product of* Σ *and* Γ *(to be distinguished from* Σ⊗Γ*, which stands for the product* <sup>σ</sup>*-algebra of* Σ *and* Γ*). A* signed bimeasure *is a function*  $M : \Sigma \times \Gamma \to [-\infty, \infty]$  *such that:* 

(i) *the function*  $A \to M(A, B)$  *is a signed measure on*  $\Sigma$  *for every*  $B \in \Gamma$ *,* 

(i) *the function*  $B \to M(A, B)$  *is a signed measure on*  $\Gamma$  *for every*  $A \in \Sigma$ *.* 

For a signed bimeasure *M*, we denote by  $M^+$  and  $M^-$  the Jordan decomposition of  $M(A, B)$  for fixed  $A \in \Sigma$ , and  $M_+$  and  $M_-$  the Jordan decomposition of  $M(A, B)$  for fixed  $B \in \Gamma$ .

Now, we introduce the concept of a quasi-Lévy type measure. Although it is called measure it is not always a measure. This explains the need of the following definitions, which we recall from [\[15\]](#page-42-0):

<span id="page-2-0"></span>**Definition 2.5.** Let  $\mathscr{B}_r(\mathbb{R}) := \{B \in \mathscr{B}(\mathbb{R}) | B \cap (r,r) = \emptyset\}$  for  $r > 0$  and  $\mathscr{B}_0(\mathbb{R}) := \bigcup_{r > 0} \mathscr{B}_r(\mathbb{R})$  be the class *of all Borel sets that are bounded away from zero. Let*  $v : \mathscr{B}_0(\mathbb{R}) \to \mathbb{R}$  *be a function such that*  $v_{|\mathscr{B}_r(\mathbb{R})}$  *is a finite signed measure for each r* > 0 *and denote the total variation, positive and negative part of*  $v_{\vert \mathscr{B}_r(\mathbb{R})}$  *by*  $|v_{\mathscr{B}_r(\mathbb{R})}|$ ,  $v_{\mathscr{B}_r(\mathbb{R})}^+$  *and*  $v_{\mathscr{B}_r(\mathbb{R})}^-$  respectively. Then the total variation  $|v|$ , the positive part  $v^+$  *and the* negative **part v<sup>−</sup>** *of* **v** *are defined to be the unique measures on* (ℝ, Ø(ℝ)) *satisfying* 

$$
|v|(\{0\}) = v^+(\{0\}) = v^-(\{0\}) = 0
$$
  
and 
$$
|v|(A) = |v|_{\mathscr{B}_r(\mathbb{R})}|, v^+(A) = v^+_{|\mathscr{B}_r(\mathbb{R})}(A), v^-(A) = v^-_{|\mathscr{B}_r(\mathbb{R})}(A),
$$

*for*  $A \in \mathscr{B}_r(\mathbb{R})$ *, for some r* > 0*.* 

As mentioned in [\[15\]](#page-42-0), v is not a a signed measure because it is defined on  $\mathscr{B}_0(\mathbb{R})$ , which is not a  $\sigma$ algebra. In the case it is possible to extend the definition of v to  $\mathscr{B}(\mathbb{R})$  such that v will be a signed measure then we will identify v with its extension to  $\mathscr{B}(\mathbb{R})$  and speak of v as a signed measure. Moreover, the uniqueness of  $|v|$ ,  $v^+$  and  $v^-$  is ensured by the Carathéodory's extension theorem.

**Remark 2.6.** *For the sake of clarity, notice that*  $\mathscr{B}_0(\mathbb{R}) = \{B \in \mathscr{B}(\mathbb{R}) : 0 \notin \overline{B}\} \neq \{B \in \mathscr{B}(\mathbb{R}) : 0 \notin B\}$ . *Indeed, consider the set*  $A = \{\frac{1}{n} : n \in \mathbb{N}\}$  *then* A *is a Borel set since it is a countable intersection of closed Borel sets. Notice that*  $A \in \{B \in \mathcal{B}(\mathbb{R}) : 0 \notin B\}$ *. Moreover, observe that for every*  $\varepsilon > 0$  *we can find an element of A that do not belong to*  $\mathscr{B}_{\varepsilon}$ *. Hence,*  $A \notin \mathscr{B}_0(\mathbb{R})$ *.* 

Throughout this work we define the centering function  $\tau$  (on a general Hilbert space) as

$$
\tau(x) := \begin{cases} x & \text{if } ||x|| \le 1, \\ \frac{x}{||x||} & \text{if } ||x|| > 1. \end{cases}
$$

where  $\|\cdot\|$  is the norm of the Hilbert space considered. Notice that this centering function satisfies equation (1) in [\[15\]](#page-42-0). The following definition has been introduced for the first time in [\[15\]](#page-42-0).

**Definition 2.7** (quasi-Lévy type measure, quasi-Lévy measure, QID distribution). *A quasi-Lévy type measure is a function*  $v : \mathcal{B}_0(\mathbb{R}) \to \mathbb{R}$  *satisfying the condition in Definition* [2.5](#page-2-0) *and such that its total variation*  $|v|$  *satisfies*  $\int_{\mathbb{R}} (1 \wedge x^2) |v| (dx) < \infty$ .

Let  $\mu$  be a probability distribution on  $\mathbb R$ . We say that  $\mu$  is quasi-infinitely divisible if its characteristic *function has a representation*

$$
\hat{\mu}(\theta) = \exp\left(i\theta\gamma - \frac{\theta^2}{2}a + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta\tau(x)v(dx)\right)
$$

*where*  $a, \gamma \in \mathbb{R}$  *and*  $\gamma$  *is a quasi-Lévy type measure. The characteristic triplet*  $(a, \gamma, \gamma)$  *of*  $\mu$  *is unique* (see *[[\[26\]](#page-43-2), Exercise 12.2]), and a is called the* Gaussian variance *of* µ*.*

*A quasi-Lévy type measure v is called* quasi-Lévy measure, *if additionally there exist a quasi-infinitely divisible distribution*  $\mu$  *and some a,*  $\gamma \in \mathbb{R}$  *such that*  $(a, \nu, \gamma)$  *is the characteristic triplet of*  $\mu$ *. We call*  $\nu$  *the quasi-Lévy measure of*  $\mu$ *.* 

The above definition extend to the  $\mathbb{R}^d$  case (for  $d > 1$ ) as shown in Remark 2.4 in [\[15\]](#page-42-0).

A quasi-Lévy measure is always a quasi-Lévy type measure, while the converse is not true as pointed out in Example 2.9 of [\[15\]](#page-42-0). Moreover, we say that a function  $f$  is *integrable with respect to quasi-Lévy type measure*  $v$  if it is integrable with respect to  $|v|$ . Then, we define:

$$
\int_B f d\nu := \int_B f d\nu^+ - \int_B f d\nu^-, \quad B \in \mathscr{B}(\mathbb{R}).
$$

Given the above discussions, it appears clear why it is sometimes useful to work with the characteristic pair  $(\zeta, \gamma)$  instead of  $(a, v, \gamma)$  where  $\zeta$  is a signed measure defined as:

$$
\zeta(B) = a\delta_0(B) + \int_B (1 \wedge x^2) v(dx), \quad B \in \mathscr{B}(\mathbb{R})
$$

Then, the representation of c.f. of  $\mu$  becomes:

$$
\hat{\mu}(\theta) = \exp\left(i\theta\gamma + \int_{\mathbb{R}} g_{\tau}(x,\theta)\zeta(dx)\right)
$$

where  $g_{\tau} : \mathbb{R} \times \mathbb{R} \to \mathbb{C}$  defined by

$$
g_{\tau}(x,\theta) = \begin{cases} (e^{i\theta x} - 1 - i\theta \tau(x))/(1 \wedge x^2), & x \neq 0, \\ -\frac{\theta^2}{2}, & x = 0. \end{cases}
$$

The function  $g_{\tau}(\cdot,\theta)$  is bounded for each fixed  $\theta \in \mathbb{R}$  and is continuous at zero (see [\[15\]](#page-42-0) for further details). Let us now mention one of the few known explicit results on QID distributions.

**Theorem 2.8** (Theorem 4.3.4 in [\[3\]](#page-42-5)). Let  $d \in \mathbb{N}$ . The c.t.  $(\gamma, 0, v)$ , where v is a finite quasi-Lévy type *measure, is the c.t. of a QID distribution on*  $\mathbb{R}^d$  *if and only if*  $exp(v) := \sum_{n=1}^{\infty} \frac{v^{*n}}{n!}$ *n*! *is a measure. In that case,*  $\mu \sim (\gamma, 0, v)$  *is given by* 

$$
\mu = \frac{\delta_{\gamma} * \exp(\nu)}{\exp(\nu(\mathbb{R}^d))}.
$$

We introduce next the framework needed to work with ID (and QID) processes.

Throughout the paper, we denote by *S* an arbitrary non-empty set and by  $\mathscr S$  a  $\delta$ -ring with the additional condition that there exists an increasing sequence of sets  $S_1, S_2, \dots \in \mathscr{S}$  s.t.  $\bigcup_{n \in \mathbb{N}} S_n = S$ . In this framework *S* does not need to belong to  $\mathscr S$  (thus  $\mathscr S$  is not necessarily an algebra) and arbitrary subsets of *S* do not need to satisfy the condition  $\bigcup_{n\in\mathbb{N}} A_n \in \mathscr{S}$  (thus  $\mathscr{S}$  is not necessarily a  $\sigma$ -ring).

**Definition 2.9** (Signed measure on a ring). A real-valued, non-negative set function  $\mu(A)$  defined on the *elements of a ring*  $\mathcal{R}$  *will be called a signed measure, if*  $\mu(\emptyset) = 0$  *and if for every sequence*  $A_1, A_2, ...$  *of disjoint sets of*  $\mathscr R$  *for which*  $A = \bigcup_{k=1}^\infty A_k \in \mathscr R$  we have

$$
\mu(A) = \sum_{k=1}^{\infty} \mu(A_k)
$$
 (2)

*and the relation [\(2\)](#page-4-0) holds absolutely (namely independent of the order of its elements).*

Similarly, it is possible to extend the definition of bimeasures on rings.

Moreover, we remark that it is possible to see that in our framework we can find a positive and a negative part (as we have done for quasi-Lévy measures) at least for any signed measures  $\mu$  on  $\mathscr{S}$  s.t.  $\mu(S_n) < \infty$  for every  $n \in \mathbb{N}$ . Indeed, consider such measure  $\mu$ . Notice that  $(S_n, \{S_n \cap B : B \in \mathcal{S}\})$  is a  $\sigma$ -algebra. Then  $\mu$  on  $(S_n, \{S_n \cap B : B \in \mathcal{S}\})$  is a signed measure as in Definition [2.1](#page-2-1) and so we can extract the two unique mutually singular finite measures  $\mu_{\vert s}^+$  $\frac{1}{|S_n}$  and  $\mu_{|S_n}^ \overline{s}_n$  on  $(S_n, \{S_n \cap B : B \in \mathscr{S}\})$ . Since for any  $B \in (S_k, \{S_k \cap B : B \in \mathscr{S}\})$  we have that  $\mu_{\vert s}^+$  $\frac{1}{|S_n}(B) = \mu_{|S_n}^+$  $|S_k(t)|$  for any  $n \geq k$  and since for every  $n \in \mathbb{N}$  we have that  $\mu_{|S_k|}^+$  $|S_n(S_n)|$  is finite, then we can uniquely extent  $\mu_{\text{S}}^+$  $|S_n|$  to a  $\sigma$ -finite measure which we denote by  $\mu^+$  on  $(S, \sigma(\mathscr{S}))$  (and the same holds for  $\mu_{\text{ls}}^+$  $|S_n|$ ). Then for every  $B \in \mathscr{S}$  we have that  $\mu(B) = \mu^+(B) - \mu^-(B)$ .

<span id="page-4-4"></span>**Definition 2.10** (QID Lévy random measure). Let  $\Lambda = {\Lambda(A) : A \in \mathscr{S}}$  *be a real stochastic process defined on some probability space* (Ω, ℱ, ℙ). We call  $\Lambda$  *to be an independently scattered r.m., if, for every sequence*  ${A_n}$  *of disjoint sets in*  $\mathscr{S}$ *, the r.v.*  $\Lambda(A_n)$ *, n* = 1,2*,..., are independent, and, if*  $\bigcup_{n=1}^{\infty} A_n \in \mathscr{S}$ *, then we have*  $\Lambda(\bigcup_{n=1}^{\infty}A_n)=\sum_{n=1}^{\infty}\Lambda(A_n)$  a.s. (where the series is assumed to converge almost surely). In addition, if  $\Lambda(A)$ *is a QID (ID) r.v., for every A*  $\in \mathcal{S}$ *, then we call*  $\Lambda$  *a QID (ID) r.m..* 

In this work  $\Lambda = {\Lambda(A) : A \in \mathscr{S}}$  will denote a QID r.m.. Since, for every  $A \in \mathscr{S}$ ,  $\Lambda(A)$  is a QID r.v., its c.f. can be written in the Lévy-Khintchine form:

$$
\hat{\mathscr{L}}(\Lambda(A))(\theta) := \mathbb{E}(e^{i\theta\Lambda(A)}) = \exp\left(i\theta v_0(A) - \frac{\theta^2}{2}v_1(A) + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta\tau(x)F_A(dx)\right) \tag{3}
$$

where  $-\infty < v_0(A) < \infty$ ,  $0 \le v_1(A) < \infty$  and  $F_A$  is a quasi-Lévy measure on  $\mathbb{R}$ , for  $A \in \mathcal{S}$ .

For the sake of completeness we report here Proposition 2.1 of [\[23\]](#page-43-0).

<span id="page-4-2"></span>Proposition 2.11 (Proposition 2.1 in [\[23\]](#page-43-0)). (a) *Let* Λ *be an ID r.m. with the c.f. given by*

$$
\mathbb{E}(e^{i\theta\Lambda(A)}) = \exp\left(i\theta\mathbf{v}_0(A) - \frac{\theta^2}{2}\mathbf{v}_1(A) + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta\tau(x)F_A(dx)\right)
$$
(4)

*Then*  $v_0: \mathscr{S} \mapsto \mathbb{R}$  *is a signed-measure,*  $v_1: \mathscr{S} \mapsto [0, \infty)$  *is a measure,*  $F_A$  *is a Lévy measure on*  $\mathbb{R}$ *, for every*  $A \in \mathscr{S}$ , and  $\mathscr{S} \ni A \mapsto F_A(B) \in [0, \infty)$  *is a measure, for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ .

(b) Let  $v_0$ ,  $v_1$  and F. satisfy the conditions given in (a). Then there exists a unique (in the sense of finite*dimensional distributions) ID r.m.* Λ *such that* ([4](#page-4-1)) *holds.*  $(c)$  *Let*  $v_0$ *,*  $v_1$  *and F. as in* (a) *and define* 

$$
\lambda(A) = |v_0|(A) + v_1(A) + \int_{\mathbb{R}} (1 \wedge x^2) F_A(dx), \quad A \in \mathcal{S}.
$$

*Then*  $\lambda: \mathscr{S} \mapsto [0,\infty)$  is a measure such that  $\lambda(A_n) \to 0$  implies  $\Lambda(A_n) \stackrel{p}{\to} 0$  for every  $\{A_n\} \subset \mathscr{S}$ ; further if  $\Lambda(A'_n) \stackrel{p}{\rightarrow} 0$  for every  $\{A'_n\} \subset \mathscr{S}$  s.t.  $A'_n \subset A_n \in \mathscr{S}$ , then  $\lambda(A_n) \rightarrow 0$ .

Moreover, we recall the following result from the work of Prékopa (Theorem 2.1 in [\[21\]](#page-43-3)). In doing this we also correct a typo in that statement.

<span id="page-5-1"></span>Theorem 2.12 (Theorem 2.1 in [\[21\]](#page-43-3)). *In order that a finitely additive random measure* ξ (*A*) *defined on* the elements of the ring  $\mathcal R$  should be countably additive it is necessary and sufficient that, for every non*increasing sequence of sets*  $B_1, B_2, ...$  *with*  $B_k \in \mathcal{R}$   $(k = 1, 2, ...)$  *and*  $B_n \searrow \emptyset$ ,  $\xi(B_n) \stackrel{p}{\rightarrow} 0$  *as*  $n \rightarrow \infty$ .

We conclude this section with the following remark on the conditions under which a quasi-Lévy type measure is a signed measure. From the discussion done in this section we have not mentioned *when* a quasi-Lévy measure is a signed measure, namely when we can extend v from  $\mathscr{B}_0(\mathbb{R})$  to the  $\sigma$ -algebra  $\mathscr{B}(\mathbb{R})$ . The idea behind this is that v is the difference of two Lévy measures  $\mu_1$  and  $\mu_2$  and when these measures are both infinite then we cannot find a signed measure such that  $v = \mu_1 - \mu_2$ . This is because we get the form ∞ – ∞, which is not defined. However, a sufficient condition is that one of the two Lévy measures is finite because then  $v = \mu_1 - \mu_2$  defines a signed measure. Further, we do not make any general assumption about it but we remark that in almost all the interesting cases considered in the existing literature, mainly in [\[15\]](#page-42-0), quasi-Lévy measures are signed measures.

### <span id="page-5-0"></span>3 The connection between ID and QID random measures

In this section, we investigate the connection between ID and QID random measures. We start with the following simple lemma, which follows from the preliminaries introduced in the previous section. Indeed, it is a formalisation of some of the concepts of Definition [2.5.](#page-2-0)

<span id="page-5-2"></span>**Lemma 3.1.** A set function  $v : \mathscr{B}_0(\mathbb{R}) \to \mathbb{R}$  is a quasi-Lévy type measure if and only if there exist two Lévy *measures*  $v^{(1)}$  *and*  $v^{(2)}$  *s.t.*  $v_{|\mathscr{B}_r(\mathbb{R})}(A) = v^{(1)}_{|\mathscr{B}_r(\mathbb{R})}$  $\chi^{(1)}_{|\mathscr{B}_r(\mathbb{R})}(A) - \mathcal{V}^{(2)}_{|\mathscr{B}_r}$  $\mathbb{E}^{(2)}_{\mathcal{B}_r(\mathbb{R})}(A)$  *for every*  $A \in \mathcal{B}_r(\mathbb{R})$  with  $r > 0$ . Moreover, <sup>ν</sup> *is unique.*

*Proof.*  $\Rightarrow$ : Let v be a quasi-Lévy type measure. Recall that we denote the positive and the negative part of v by  $v^+$  and  $v^-$ , respectively. Since  $v^+({0}) = v^-({0}) = 0$  and  $\int_{\mathbb{R}}(1 \wedge x^2)|v|(dx) < \infty$  which implies that  $\int_{\mathbb{R}} (1 \wedge x^2) v^+(dx) < \infty$  and  $\int_{\mathbb{R}} (1 \wedge x^2) v^-(dx) < \infty$ , then  $v^+$  and  $v^-$  are two Lévy measure on R.  $\Leftarrow$ : Let  $v^{(1)}$  and  $v^{(2)}$  s.t.  $v_{|\mathscr{B}_r(\mathbb{R})} = v^{(1)}_{|\mathscr{B}_r(\mathbb{R})} - v^{(2)}_{|\mathscr{B}_r(\mathbb{R})}$  $\mathcal{B}_r^{(2)}(\mathbb{R})$  for every  $A \in \mathcal{B}_r(\mathbb{R})$  with  $r > 0$ . Since  $v_{|\mathcal{B}_r}^{(1)}$ and  $|\mathscr{B}_r(\mathbb{R})$  $v^{(2)}$  $\binom{2}{\mathscr{B}_r(\mathbb{R})}$  are two finite measures then  $v_{\mathscr{B}_r(\mathbb{R})}$  is a finite signed measure. Thus, we denote by  $v_{\mathscr{B}_r(\mathbb{R})}^+$  and  $v_{\vert \mathscr{B}_r(\mathbb{R})}^-$  its (unique) Jordan decomposition. Notice that  $v_{\vert \mathscr{B}_r(\mathbb{R})}^+(A) = v_{\vert \mathscr{B}_s(\mathbb{R})}^+(A)$  for every  $A \in \mathscr{B}_r(\mathbb{R})$  with  $0 < s \leq r$ . Moreover, let  $v^+(\{0\}) = v^+(\{0\}) = 0$ . Then, by Carathéodory's extension theorem we obtain the existence of two unique  $\sigma$ -finite measures  $v^+$  and  $v^-$  on  $(\mathbb{R}, \mathscr{B}(\mathbb{R}))$ . It is possible to see that they satisfy the conditions of Definition [2.5.](#page-2-0) Moreover, the uniqueness of v comes from the uniqueness of  $v^+$  and  $v^-$ .  $\Box$ 

The above result obviously extends to the  $\mathbb{R}^d$  case. Note that saying that a property holds "for every  $A \in$  $\mathscr{B}_r(\mathbb{R})$  with  $r > 0$ " is equivalent to saying that it holds "for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ ". In the following result represents a partial QID analogue of Proposition [2.11.](#page-4-2)

<span id="page-6-0"></span>**Lemma 3.2.** Let  $v_0: \mathcal{S} \mapsto \mathbb{R}$  be a signed measure,  $v_1: \mathcal{S} \mapsto \mathbb{R}$  be a measure,  $G_A$  be a Lévy measure on  $\mathbb{R}$  *for every*  $A \in \mathscr{S}$  *and*  $\mathscr{S} \ni A \mapsto G_A(B) \in [0, \infty)$  *be a measure for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ *. Let* M *be defined as G. Let*  $F_A(B) := G_A(B) - M_A(B)$  *for every*  $B \in \mathcal{B}(\mathbb{R})$  *s.t.* 0 ∉  $\overline{B}$  *and*  $A \in \mathcal{S}$ *. Then, there is a unique quasi-Lévy type measure*  $F_A$  *for every*  $A \in \mathcal{S}$ *. Moreover,*  $\mathcal{S} \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *is a signed measure for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ .

*Further, if*  $(v_0(A), v_1(A), F_A)$  *is the characteristic triplet of a QID random variable*  $\forall A \in \mathcal{S}$ *. Then there exists a unique (in the sense of finite-dimensional distributions) QID random measure* Λ *such that* ([3](#page-4-3)) *holds, and*  $F_A$  *is a quasi-Lévy measure for every*  $A \in \mathcal{S}$ *.* 

*Proof.* Since  $G_A$  and  $M_A$  are Lévy measures and since  $F_A(B) = G_A(B) - M_A(B)$  for every  $B \in \mathcal{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ and  $A \in \mathscr{S}$ , then there is a unique quasi-Lévy type measure  $F_A$  for every  $A \in \mathscr{S}$ . Moreover, since  $F_A(B)$  =  $G_A(B) - M_A(B)$ , it follows immediately that  $A \mapsto F_A(B)$  is a signed measure for every  $B \in \mathcal{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ . If  $(V_0(A), V_1(A), F_A)$  is the characteristic triplet of a QID random variable then  $B \mapsto F_A(B)$  is by definition a quasi-Lévy measure. Moreover, the existence of a finitely additive independently scattered random measure  $\Lambda = {\lambda(A) : A \in \mathscr{S}}$  follows by a standard application of Kolmogorov extension theorem. To prove that  $\Lambda$  is countable additive let  $A_n \searrow \emptyset$  with  $\{A_n\} \subset \mathscr{S}$ . Then, by definition of (signed) measures,  $v_0(A_n) \to 0$ ,  $v_1(A_n) \to 0$ ,  $G_{A_n}(B) \to 0$  and  $M_{A_n}(B) \to 0$  for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ . Notice that  $G_A(B) \ge F_A^+(B)$  and  $M_A(B) \ge F_A^-(B)$  for all  $A \in \mathcal{S}$  and  $B \in \mathcal{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ . Then, we obtain that

$$
\int_{\mathbb{R}} (1 \wedge x^2) |F_{A_n}| (dx) \leq \int_{\mathbb{R}} (1 \wedge x^2) G_{A_n}(dx) + \int_{\mathbb{R}} (1 \wedge x^2) M_{A_n}(dx) \to 0 \quad \text{as } n \to \infty
$$

Now, by the Lévy continuity theorem we obtain that  $\Lambda(A_n) \stackrel{d}{\to} 0$ , which implies that  $\Lambda(A_n) \stackrel{p}{\to} 0$  and, thus, by Theorem [2.12](#page-5-1) the countable additivity of Λ. The uniqueness follows by the one to one relation between  $(v_0(A), v_1(A), F_A)$  and  $\Lambda(A)$ , for every  $A \in \mathcal{S}$ . □

Now, we present the first link between ID and QID random measures.

<span id="page-6-1"></span>**Proposition 3.3.** *For every*  $A \in \mathscr{S}$ , let  $\Lambda(A)$  be a random variable and let two ID random measures  $\Lambda_1$  and  $\Lambda_2$  with  $\Lambda(A) + \Lambda_2(A) \stackrel{d}{=} \Lambda_1(A)$  s.t.  $\Lambda_2(A)$  is independent of  $\Lambda(A)$ . Then, there exists a unique QID random *measure*  $\Lambda = {\Lambda(A) : A \in \mathscr{S}}$ *. In this case, we say that the r.m.*  $\Lambda$  *is generated by two ID random measures.* 

Remark 3.4. *The above result can be restated using instead of the condition that* Λ(*A*) *is a random variable and there exist two ID random measures*  $\Lambda(A) + \Lambda_2(A) \stackrel{d}{=} \Lambda_1(A)$ *, such that*  $\Lambda_2(A)$  *is independent of*  $\Lambda(A)$ *,*  $\forall A \in \mathcal{S}$ , the equivalent alternative conditions:

(i)  $\forall A \in \mathcal{S}$  *and*  $\theta \in \mathbb{R}$ ,  $\mathcal{L}(\Lambda(A))$  *is a distribution and* 

$$
\hat{\mathcal{L}}(\Lambda(A))(\theta) = \frac{\hat{\mathcal{L}}(\Lambda_1(A))(\theta)}{\hat{\mathcal{L}}(\Lambda_2(A))(\theta)},
$$
\n(5)

(ii)  $\forall A \in \mathscr{S}$   $\mathscr{L}(\Lambda(A))$  *is a distribution and the c.t. of*  $\Lambda(A)$  *can be rewritten as the difference of the c.t. of*  $\Lambda_1(A)$  *and*  $\Lambda_2(A)$ *.* 

*Proof.* Let  $v_0^{(j)}$  ${\mathsf v}_0^{(j)},\ {\mathsf v}_1^{(j)}$  $I_1^{(j)}$  and  $F_1^{(j)}$  the measures corresponding to  $\Lambda_j$ , for  $j = 1, 2$  (see Proposition [2.11\)](#page-4-2). Let  $v_0(A) := v_0^{(1)}$  $v_0^{(1)}(A) - v_0^{(2)}$  $v_0^{(2)}(A), v_1(A) := v_1^{(1)}$  $v_1^{(1)}(A) - v_1^{(2)}$  $\mathcal{A}_{1}^{(2)}(A)$  for all  $A \in \mathcal{S}$ . Moreover, let  $F_A$  be the unique quasi-Lévy measure defined by the difference between the Lévy measures  $F_A^{(1)}$  $F_A^{(1)}$  and  $F_A^{(2)}$  $F_A^{(2)}$ , namely  $F_A(B) :=$  $F^{(1)}_{\scriptscriptstyle{A}}$  $F_A^{(1)}(B) - F_A^{(2)}$  $A^{(2)}(B)$  for all  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$  and  $|F_A|(\{0\}) = 0$ , for all  $A \in \mathscr{S}$ . Then  $v_0$ ,  $v_1$  and *F*· satisfies the conditions of Lemma [3.2.](#page-6-0)

Further, the condition that  $\Lambda(A)$  is a random variable together with  $\Lambda(A) + \Lambda_2(A) \stackrel{d}{=} \Lambda_1(A)$  implies that  $\mathscr{L}(\Lambda(A))$  is QID with c.t.  $(v_0(A), v_1(A), F_A)$ , hence, by Lemma 2.7 in [\[15\]](#page-42-0) we have  $v_1(A) \geq 0$ ,  $\forall A \in \mathscr{S}$ .

Then, by Lemma [3.2](#page-6-0) we obtain the stated result (including the statement that  $\Lambda$  is uniquely determined).  $\Box$ 

In the following we present two results, where the second represent a partial "only if" result of Proposition [3.3.](#page-6-1)

<span id="page-7-0"></span>**Lemma 3.5.** Let  $\Lambda$  be a QID random measure and let  $K(B): A \mapsto K_A(B)$  be a measure s.t.  $K_A(B) \geq F_A(B)$ , *for every*  $A \in \mathscr{S}$  *and*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ *. Assume that*  $K_A(\cdot) : B \mapsto K_A(B)$  *is Lévy measure for every*  $A \in \mathscr{S}$ *. Then*  $v_0: \mathscr{S} \mapsto \mathbb{R}$  *is a signed measure*,  $v_1: \mathscr{S} \mapsto [0, \infty)$  *is a measure,*  $F_A$  *is a quasi-Lévy measure on*  $\mathbb{R}$ *, for every*  $A \in \mathscr{S}$ , and  $\mathscr{S} \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *is a signed measure, for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ .

*Proof.* First, since  $\Lambda$  is a QID r.m. it follows that  $F_A$  is a quasi-Lévy measure on R, for every  $A \in \mathcal{S}$ . Now, let  $\{A_k\}_{k=1}^n$  be pairwise disjoint sets in  $\mathscr{S}$ . By the uniqueness of the Lévy-Khintchine representation of a quasi-ID distribution, it follows, using  $\hat{\mathscr{L}}(\Lambda(\bigcup_{k=1}^{n} A_k)) = \prod_{k=1}^{n} \hat{\mathscr{L}}(\Lambda(A_k))$ , that all three set functions  $v_0$ ,  $v_1$  and  $F(B)$  (for every fixed  $B \in \mathcal{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ ) are finitely additive. Let now  $\{A_n\} \subset \mathcal{S}, A_n \setminus \emptyset$ . Then since  $\Lambda(A_n) \stackrel{p}{\to} 0$  we have that  $v_0(A_n) \to 0$ ,  $v_1(A_n) \to 0$  and  $\int_{\mathbb{R}} (1 \wedge x^2) F_{A_n}(dx) \to 0$ . Concerning  $F_{A_n}(B)$ , observe that  $K_{A_1}(B) \ge K_{A_2}(B) \ge \dots$  and that  $K_{A_j}(B) \ge F_{A_j}^+(B)$ , where  $j \in \mathbb{N}$ , for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ by assumption. Then,

$$
\lim_{n\to\infty}\int_{\mathbb{R}}(1\wedge x^{2})F_{A_{n}}^{+}(dx)\leq \lim_{n\to\infty}\int_{\mathbb{R}}(1\wedge x^{2})K_{A_{n}}(dx)=\lim_{n\to\infty}\int_{|x|<\varepsilon}(1\wedge x^{2})K_{A_{n}}(dx)+\lim_{n\to\infty}\int_{|x|\geq\varepsilon}(1\wedge x^{2})K_{A_{n}}(dx)
$$

$$
\leq \int_{|x|<\varepsilon}(1\wedge x^{2})K_{A_{1}}(dx)+\lim_{n\to\infty}K_{A_{n}}(\{|x|\geq\varepsilon\}).
$$

The second addend goes directly to zero for every  $\varepsilon > 0$  because  $K(B)$  is a measure, while for the first we obtain the convergence to zero by letting  $\varepsilon \to 0$ . Moreover, since

$$
\int_{\mathbb{R}} (1 \wedge x^2) F_{A_n}(dx) \to 0 \text{ as } n \to \infty, \text{ then } \int_{\mathbb{R}} (1 \wedge x^2) F_{A_n}^-(dx) \to 0 \text{ as } n \to \infty.
$$

Applying the arguments of the proof of Proposition 2.1 point (i) in [\[23\]](#page-43-0), namely by the Chebychev's inequality

$$
F_{A_n}^+(\{|x|\geq \varepsilon\})\leq \varepsilon^{-2}\int_{\mathbb{R}}(1\wedge x^2)F_{A_n}^+(dx),
$$

we obtain that  $F_{A_n}^+(B) \to 0$  for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ ; and the same holds for  $F_{A_n}^-(B)$ . Therefore, we have  $|F_{A_n}(B)| \to 0$ , and thus  $F_{A_n}(B)$  is a signed measure, for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ .  $\Box$ 

**Corollary 3.6.** Let  $\Lambda$  be a QID random measure with  $F^+(B): A \mapsto F_A^+(B)$  a measure for every  $B \in \mathscr{B}(\mathbb{R})$ *s.t.*  $0 \notin \overline{B}$ . Then  $v_0 : \mathscr{S} \mapsto \mathbb{R}$  *is a signed measure,*  $v_1 : \mathscr{S} \mapsto [0, \infty)$  *is a measure,*  $F_A$  *is a quasi-Lévy measure on*  $\mathbb{R}$ *, for every*  $A \in \mathscr{S}$ *, and*  $\mathscr{S} \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *is a signed measure, for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ *. Moreover, we have that*  $\mathscr{S} \ni A \mapsto F_A^-(B) \in [0, \infty)$  *is a measure, for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ .

**Remark 3.7.** *Notice that we could use the assumption*  $F^-(\mathbb{R})$  :  $A \mapsto F^-_A(\mathbb{R})$  *is a measure, instead. Then, the arguments would be the same.*

*Proof.* It follows from the same arguments of Lemma [3.5.](#page-7-0)

Proposition 3.8. *Let* Λ *be QID random measure and let KA*(*B*) *as in Lemma [3.5.](#page-7-0) Then, there exist two ID random measures*  $\Lambda_1$  *and*  $\Lambda_2$  *with*  $\Lambda(A) + \Lambda_2(A) \stackrel{d}{=} \Lambda_1(A)$  *such that*  $\Lambda_2(A)$  *is independent of*  $\Lambda(A)$  *and has zero Gaussian part,*  $\forall A \in \mathcal{S}$ .

*Proof.* Let  $F_A^{(1)}$  $K_A^{(1)} := K_A, F_A^{(2)}$  $F_A^{(2)}(B) := K_A(B) - F_A(B)$  for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$  and  $F_A^{(2)}$  $T_A^{(2)}(\{0\}) = 0.$  In addition, let  $v_0^{(1)}$  $v_0^{(1)}:=2v_0,~v_0^{(2)}$  $v_0^{(2)} := v_0, v_1^{(1)}$  $v_1^{(1)} := v_1$ , and  $v_1^{(2)}$  $T_1^{(2)} := 0$ . By Lemma [3.5,](#page-7-0) we obtain that  $F_A^{(j)}$  $\binom{J}{A}(\cdot)$  :  $\mathscr{B}(\mathbb{R}) \to [0,\infty), F^{(j)}(B) : \mathscr{S} \to [0,\infty) \text{ for any } B \in \mathscr{B}(\mathbb{R}) \text{ s.t. } 0 \notin \overline{B}, v_0^{(j)}$  $v_0^{(j)}$  :  $\mathscr{S} \to [0, \infty)$  and  $v_0^{(j)}$  $\mathcal{O}_0^{(j)}: \mathscr{S} \to [0,\infty)$ are all measures, for  $j = 1, 2$ . In addition, since  $F_A$  is a quasi-Lévy measure and  $K_A$  is a Lévy measure then

□

 $F^{(2)}_{\scriptscriptstyle{A}}$  $A^{(2)}$  is Lévy measure.

Then, by Proposition 2.1 point (ii) of [\[23\]](#page-43-0) we know that there exist two unique ID random measures  $\Lambda_1$  and  $\Lambda_2$  such that, for every  $A \in \mathscr{S}$ , they have c.t. given by  $(v_0^{(1)})$  $v_0^{(1)}(A), v_1^{(1)}$  $F_A^{(1)}(A), F_A^{(1)}$  $\mathcal{N}_{A}^{(1)}$ ) and  $(\mathcal{V}_{0}^{(2)})$  $v_0^{(2)}(A), v_1^{(2)}$  $F_A^{(2)}(A), F_A^{(2)}$  ${\cal{A}}^{(2)}),$ respectively. Finally, it is possible to see that the following relation hold: for every  $A \in \mathscr{S}$  and  $\theta \in \mathbb{R}$ ,  $\hat{\mathscr{L}}(\Lambda(A))(\boldsymbol{\theta}) = \frac{\hat{\mathscr{L}}(\Lambda_1(A))(\boldsymbol{\theta})}{\hat{\mathscr{L}}(\Lambda_2(A))(\boldsymbol{\theta})}.$ 

**Remark 3.9.** *The reason why*  $\Lambda_1$  *and*  $\Lambda_2$  *are not determined uniquely by*  $\Lambda$  *is because given*  $v_0$  *we cannot* exclude the possibility of finding two measures  $\tilde{v}_0^{(1)}$  $\tilde{v}_0^{(1)}$  and  $\tilde{v}_0^{(2)}$  $v_0^{(2)}$  such that  $v_0(A) = \tilde{v}_0^{(1)}$  $\mathfrak{v}_0^{(1)}(A)-\mathfrak{v}_0^{(2)}$  $\int_0^{(2)}$ (A), where  $\tilde{\mathbf{v}}_0^{(1)}$  $\chi_0^{(1)}(A) \neq 2v_0(A)$  and  $\tilde{v}_0^{(2)}$  $\lambda_0^{(2)}(A) \neq \nu_0(A)$ . This leads to two measures  $\tilde{\Lambda}_1$  and  $\tilde{\Lambda}_2$  such that they satisfies the *same conditions as*  $\Lambda_1$  *and*  $\Lambda_2$ *. Moreover, the same reasoning applied to*  $v_0$  *may also applies to*  $F_A$ *.* 

In the following example we observe that the condition on  $F_A^+(B)$  being a measure is not always satisfied even if we restrict to random measure  $\Lambda$  with  $\mathscr{L}(\Lambda(A))$  concentrated on  $\mathbb{Z}, \forall A \in \mathscr{S}$ .

**Example 3.10.** Consider  $F_A = \sum_{l \in \mathbb{Z}, l \neq 0} b_l^A \delta_l$  where  $b_l^A$  are real numbers, then  $|F_A| = \sum_{l \in \mathbb{Z}, l \neq 0} |b_l^A| \delta_l$ . Such *a quasi-Levy measure arises when we consider a distribution supporte ´ d on the integers whose c.f. has no zeroes (see Theorem 8.1 in [\[15\]](#page-42-0)). While*  $F_A^+$  and  $F_A^-$  are Lévy measure for every fixed  $A \in \mathscr{S}$  they are not *always measures for fixed B* ∈  $\mathcal{B}(\mathbb{R})$ *. Indeed, consider*  $A = A_1 \cap A_2$  *with*  $A_1 \cap A_2 = \emptyset$ *. Since*  $F_A$  *is a signed* measure then  $b_k^{A_1\cup A_2}=b_k^{A_1}+b_k^{A_2}$ . However, it might happen that  $b_k^{A_1}$  and  $b_k^{A_2}$  have different sign. This implies that  $F_{A_1\cup A_2}^+(\{k\}) \neq F_{A_1}^+(\{k\}) + F_{A_2}^+(\{k\})$  and  $F_{A_1\cup A_2}^-(\{k\}) \neq F_{A_1}^-(\{k\}) + F_{A_2}^-(\{k\})$ .

*On the other hand, this example shows that if we consider*  $F_A = \sum_{l \in \mathbb{Z}, l \neq 0} b_l^A \delta_l$  such that  $b_l^A$ , with  $l \in \mathbb{Z}$ , do *not change sign for all*  $A \in \mathcal{S}$ *, then this represents an example where the theory presented so far applies.* 

### <span id="page-8-0"></span>4 QID random measure

In the previous section we have seen that under certain conditions two ID random measure generates a QID random measure and vice versa. In this section we are going to explore other cases and show necessary and sufficient conditions for the existence and uniqueness of QID random measure.

#### <span id="page-8-1"></span>4.1 The distribution concentrated on the integers

In this section we are going to investigate the case where  $supp(\mathcal{L}(\Lambda(A)))\subset \mathbb{Z}$ . In other words, we consider  $\mathscr{L}(\Lambda(A)) = \sum_{m \in \mathbb{Z}} a_m \delta_m$ , for  $a_m \in \mathbb{R}$ . We start by showing the equivalent of Proposition 2.1 of [\[23\]](#page-43-0).

<span id="page-8-2"></span>**Proposition 4.1.** (i) Let  $\Lambda$  be a QID random measure with supp $(\mathscr{L}(\Lambda(A)))\subset \mathbb{Z}$ ,  $\forall A \in \mathscr{S}$ . Then for each  $A \in \mathscr{S}$ ,  $v_1(A) = 0$ , the drift of  $\mathscr{L}(\Lambda(A)) \in \mathbb{Z}$  and  $F_A$  is a quasi-Lévy measure concentrated on  $\mathbb{Z} \setminus \{0\}$  and *finite. Moreover,*  $v_0: \mathscr{S} \mapsto \mathbb{R}$  *is a signed measure,*  $v_1: \mathscr{S} \mapsto \mathbb{R}$  *is the zero measure,*  $F_A$  *is a quasi-Lévy measure on*  $\mathbb{R}$ *, for every*  $A \in \mathscr{S}$ *, and*  $\mathscr{S} \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *is a signed measure, for every*  $B \in \mathscr{B}(\mathbb{R})$ *.* (ii) Let  $v_0$ ,  $v_1$  and F be as in (i) and such that ([3](#page-4-3)) is the c.f. of a distribution and has no zeros, for each  $A \in \mathcal{S}$ . *Then there exists a unique (in the sense of finite-dimensional distributions) quasi-ID random measure* Λ *s.t.* ([3](#page-4-3)) *holds.*

*Proof.* (i) The first assertion is the content of Theorem 8.1 of [\[15\]](#page-42-0). For the finite additivity of  $v_0$ ,  $v_1$  and *F*: (*B*) we follow the first part of the proof of Proposition 2.1 of [\[23\]](#page-43-0). Indeed, let  $\{A_k\}_{k=1}^n$  be pairwise disjoint sets in  $\mathscr S$ . By the uniqueness of Lévy-Khintchine representation of the c.f. of a QID distribution and by  $\mathscr{L}(\Lambda(\bigcup_{k=1}^{n} A)) = \prod_{k=1}^{n} \mathscr{L}(\Lambda(A_k))$ , we obtain the finite additivity property. Now, let  $\{A_n\} \subset \mathscr{S}, A_n \setminus \emptyset$ . Since  $\Lambda(A_n) \to 0$  then  $\mathscr{L}(\Lambda(A_n)) \to \hat{\delta}_0$  and by Theorem 8.5 of [\[15\]](#page-42-0) we obtain that  $v_0(A_n) \to 0$ ,  $v_1(A_n) \to 0$ and  $\sum_{l\in\mathbb{Z}}|F_{A_n}(\{l\})|\to 0$ . Now, observe that since  $F_{A_n}=\sum_{l\in\mathbb{Z},l\neq 0}b_{n,l}\delta_l$  for some  $b_{n,l}\in\mathbb{R}$ , then  $|F_{A_n}|=$  $\sum_{l\in\mathbb{Z},l\neq0} |b_{n,l}|\delta_l$ , and since  $F_{A_n}(\lbrace l \rbrace)=b_{n,l}$ , we obtain that  $|F_{A_n}|(\mathbb{R})\to0$ , because we have that  $F_{A_n}(\lbrace k \rbrace)\to0$  $\forall k \in \mathbb{Z}$ . Therefore, we deduce that  $F_{A_n}(B) \to 0$  for every  $B \in \mathscr{B}(\mathbb{R})$ .

(ii) From Theorem 8.5 of [\[15\]](#page-42-0) we obtain that  $(v_0(A), v_1(A), F_A)$  is the characteristic triplet of a QID random variable  $\forall A \in \mathscr{S}$ . Further, the existence of a finitely additive independently scattered random measure  $\Lambda = \{\lambda(A): A \in \mathscr{S}\}\$ follows by the Kolmogorov extension theorem. To prove that  $\Lambda$  is countable additive let  $A_n \searrow \emptyset$  with  $\{A_n\} \subset \mathscr{S}$ . Then, by definition of (signed) measures,  $v_0(A_n) \to 0$ ,  $v_1(A_n) \to 0$  and  $F_{A_n}(B) \to 0$ for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ . From the last limit and since  $F_{A_n}$  is concentrated on the integers, we obtain that  $|F_{A_n}|(\mathbb{R}) \to 0$ . Therefore, we have that  $\Lambda(A_n) \stackrel{p}{\to} 0$ , hence  $\Lambda$  is countably additive. □

Open Question 4.2. *Following Corollary 8.2 in [\[15\]](#page-42-0), it might be possible to extend the above result to the case of distributions concentrated on a lattice of the form*  $r + h\mathbb{Z}$  *where*  $r \in \mathbb{R}$  *and*  $h > 0$ *. Is it really possible?* 

#### <span id="page-9-0"></span>4.2 The distribution with an atom of mass greater than 1/2

In this section we are going to explore the case where a random measure is such that  $\mathcal{L}(\Lambda(A))(\{k_A\}) > 1/2$ for some  $k_A \in \mathbb{R}$ . We have the following result for  $k_A = 0$ .

**Proposition 4.3.** (i) Let  $\Lambda$  be an independent scattered random measure with  $p_A := \mathcal{L}(\Lambda(A))({0}) > 1/2$ ,  $\forall A \in \mathcal{S}$ . Then  $\Lambda$  *is a QID random measure and*  $v_1(A) = 0$ , the drift of  $\mathcal{L}(\Lambda(A))$  equal zero, and  $F_A$  *is a finite quasi-Levy measure given by ´*

$$
F_A = \left(\sum_{m=1}^{\infty} \frac{1}{m} (-1)^{m+1} \left(\frac{1-p_A}{p_A}\right)^m \left(\delta_0 * \sigma_A\right)^{*m}\right)_{\mathbb{R}\setminus\{0\}},\tag{6}
$$

*where*  $\sigma_A = (1 - p_A)^{-1} (\mathcal{L}(\Lambda(A)) - p_A \delta_0)$ , for every  $A \in \mathcal{S}$ ,

*Moreover,*  $v_0: \mathscr{S} \mapsto \mathbb{R}$  *and*  $v_1: \mathscr{S} \mapsto \mathbb{R}$  *are the zero measure,*  $F_A$  *is a quasi-Lévy measure on*  $\mathbb{R}$ *, for every*  $A \in \mathscr{S}$ , and  $\mathscr{S} \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *is a signed measure, for every*  $B \in \mathscr{B}(\mathbb{R})$ *.* 

(ii) Let  $v_0$  and  $v_1$  be the zero measures, let  $\mu_A$  be a distribution with c.t.  $(0,0,F_A)$  where  $F_A$  is a quasi-Lévy *measure on*  $\mathbb{R}$ *, for every*  $A \in \mathcal{S}$ *, and*  $\mathcal{S} \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *is a signed measure, for every*  $B \in \mathcal{B}(\mathbb{R})$ *. In particular, let*

$$
F_A = \left(\sum_{m=1}^{\infty} \frac{1}{m} (-1)^{m+1} \left(\frac{1-p_A}{p_A}\right)^m (\delta_0 * \sigma_A)^{*m}\right)_{\mathbb{R}\setminus\{0\}},
$$

*where*  $p_A = \mu_A(\{0\}) > 1/2$  and  $\sigma_A = (1 - p_A)^{-1}(\mu_A - p_A\delta_0)$ ,  $\forall A \in \mathscr{S}$ . Then there exists a unique (in the *sense of finite-dimensional distributions) quasi-ID random measure*  $\Lambda$  *s.t.*  $\mathscr{L}(\Lambda(A)) = \mu_A$ *, for every*  $A \in \mathscr{S}$ .

*Proof.* (i) The first statement is the content of Theorem 4.3.7 in [\[3\]](#page-42-5) (see also Theorem 3.1 of [\[15\]](#page-42-0)). Now, the finite additivity follows from the same arguments used before (see the proof of Proposition [4.1\)](#page-8-2). For countable additivity, let  $\{A_n\} \subset \mathscr{S}, A_n \searrow \emptyset$ . Since  $\Lambda(A_n) \stackrel{p}{\to} 0$ , then  $\mathscr{L}(\Lambda(A_n)) \to \delta_0$ , which implies that  $p_{A_n} \to 1$ . Then, from ([6](#page-9-2)) and using the fact that  $F_{A_n}$  is finite we get  $F_{A_n}(B) \to 0$  for every  $B \in \mathscr{B}(\mathbb{R})$ .

(ii) The existence and the finite additivity of  $\Lambda$  are straightforward. Concerning the countable additivity, notice that if  $F_{A_n}(B) \to 0$  for every  $B \in \mathscr{B}(\mathbb{R})$ , then  $p_{A_n} \to 1$ , which implies that  $\mathscr{L}(\Lambda(A_n)) \stackrel{d}{\to} \delta_0$ .  $\Box$ 

#### <span id="page-9-1"></span>4.3 The strictly negative Lévy measure

Under certain conditions, it is possible to have QID distributions with strictly negative quasi-Lévy measure. An example of such conditions are presented in Lemma 2.8 in [\[15\]](#page-42-0). Thus, we have the following corollary.

Corollary 4.4. *All the results presented in Section II of [\[23\]](#page-43-0) apply* mutatis mutandis *to the case of QID random measures with quasi-Levy measure which take only non-positive values. ´*

*Proof.* Consider  $F_A(\cdot)$  to be our non-positive quasi-Lévy measure, where  $A \in \mathscr{S}$ . Then all the results in Section II of [\[23\]](#page-43-0) hold for the total variation  $|F_A|(\cdot)$ . But since  $F_A = -|F_A|$  we obtain the stated result.  $\Box$ 

# <span id="page-10-0"></span>5 QID Stochastic integrals

In this and in the following subsections of this section we investigate different results concerning QID stochastic integrals, including the necessary and sufficient conditions for their existence. The presentation of these subsections are similar. However, each section has its own framework and its own particular result. This section represents the QID extension of Chapter II in [\[23\]](#page-43-0), which is at the heart of the theory of ID r.m. and processes.

#### <span id="page-10-1"></span>5.1 The generating two ID random measure case

In this section we focus on the cases seen in Section [3.](#page-5-0) In particular, the setting is the one of Lemma [3.2](#page-6-0) (or equivalently of Proposition [3.3\)](#page-6-1), which is more general than the one of Lemma [3.5.](#page-7-0) Indeed, all the results presented in this section apply to the setting of Lemma [3.5](#page-7-0) and they are obtained by simply substituting *G* by *K* (or  $F^+$ ) and *M* by  $K - F$  (or  $F^-$ ).

The first result regards the construction of the control measure of  $\Lambda$ .

Proposition 5.1. *Let*  $v_0$ ,  $v_1$  *and F. be as in Lemma* [3.2.](#page-6-0) *Define* 

<span id="page-10-2"></span>
$$
\lambda(A) = |v_0|(A) + v_1(A) + \int_{\mathbb{R}} (1 \wedge x^2) G_A(dx) + \int_{\mathbb{R}} (1 \wedge x^2) M_A(dx), \quad A \in \mathcal{S}.
$$
 (7)

*Then*  $\lambda : \mathscr{S} \mapsto [0, \infty)$  *is a measure such that*  $\lambda(A_n) \to 0$  *implies*  $\Lambda(A_n) \stackrel{p}{\to} 0$  *for every*  $\{A_n\} \subset \mathscr{S}$ .

*Proof.* First, notice that all the element on the right hand side of ([7](#page-10-2)) are measures. Hence,  $\lambda$  is a measure. Further, let  $A_n \searrow \emptyset$  with  $\{A_n\} \subset \mathscr{S}$ . Since  $G_{A_1}(B) \geq G_{A_n}(B)$  for every  $n \geq 1$  and  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ , we have that

$$
\lim_{n \to \infty} \int_{\mathbb{R}} (1 \wedge x^2) G_{A_n}(dx) = \lim_{n \to \infty} \int_{|x| < \varepsilon} (1 \wedge x^2) G_{A_n}(dx) + \lim_{n \to \infty} \int_{|x| \ge \varepsilon} (1 \wedge x^2) G_{A_n}(dx)
$$
\n
$$
\le \int_{|x| < \varepsilon} (1 \wedge x^2) G_{A_1}(dx) + \lim_{n \to \infty} G_{A_n}(\{|x| \ge \varepsilon\})
$$

The second addend goes directly to zero for every  $\varepsilon > 0$  and for the first we obtain the convergence to zero by letting  $\varepsilon \to 0$ . The same holds for *M*. Hence,  $\lambda$  is countably additive. Moreover, using Theorem 4.3 point (a) in [\[15\]](#page-42-0) or the Lévy continuity theorem it is straightforward to see that if  $\lambda(A_n) \to 0$  then  $\Lambda(A_n) \to 0$ .

**Definition 5.2.** *Since*  $\lambda(S_n) < \infty$ ,  $n = 1, 2, ...$  *we extend*  $\lambda$  *to a*  $\sigma$ *-finite measure on*  $(S, \sigma(\mathscr{S}))$ *; we call*  $\lambda$  *the* control measure *of* Λ*.*

It is possible to use different control measure then the one mentioned, for example  $\tilde{\lambda} = \lambda_G + \lambda_M$ , where  $\lambda_G$  and  $\lambda_M$  are the control measure of  $\Lambda_G$  and  $\Lambda_M$ . This  $\tilde{\lambda}$  has the additional property that if  $\Lambda_G(A'_n) \to 0$  and  $\Lambda_M(A'_n) \stackrel{p}{\rightarrow} 0$  for every  $\{A'_n\} \subset \mathscr{S}$  s.t.  $A'_n \subset A_n \in \mathscr{S}$ , then (by Proposition [2.11\)](#page-4-2)  $\lambda(A_n) \rightarrow 0$ .

The reason why we prefer  $\lambda$  is because it is potentially the smallest (up to a constant) measure such that  $\lambda \gg \log \mathcal{L}(\Lambda)(\theta)$  for every  $\theta \in \mathbb{R}$ . The reason why  $\lambda$  is only "potentially" the smallest has to do with an old and classical problem, the Maharam's Problem posed in 1947 by Maharam [\[16\]](#page-42-6), which has been solved in 2008 by Talagrand [\[27\]](#page-43-4). In few words and applied to our case, the solution of this problem states that an exhaustive submeasure (think of  $A \mapsto F_A^+(B)$ ) is not always absolutely continuous w.r.t. a measure. Indeed, by considering that there exists two generating ID r.m., we impose that  $G_A \ge F_A^+$  and  $M_A \ge F_A^-$ , and thus solving the issue. We will see in the next two sections how to obtain a control measure without this assumption (but with other assumptions).

Since in this section we are concerned with QID random measures then it is of secondary importance which specific couple of ID r.m. generate  $\Lambda$ . Indeed, given two ID r.m.  $\Lambda_G$  and  $\Lambda_M$  with c.f.  $(v_0^G, v_1^G, G)$ 

and  $(v_0^M, v_1^M, M)$  that generate the QID r.m.  $\Lambda$ , we can always find two different ID r.m. with (for example) c.t.  $(0, v_1, G)$  and  $(-v_0, 0, M)$  which also generate Λ.

Throughout this section we let  $\Lambda_G \sim (0, v_1, G)$  and  $\Lambda_M \sim (-v_0, 0, M)$ . We denote by  $\lambda_G$  and  $\lambda_M$  the control measure of  $\Lambda_G$  and  $\Lambda_M$ , namely  $\lambda_G(A) = v_1(A) + \int_{\mathbb{R}} (1 \wedge x^2) G_A(dx)$  and  $\lambda_M(A) = ||v_0||(A) + \int_{\mathbb{R}} (1 \wedge x^2) G_A(dx)$  $(x^2)M_A(dx)$ .

The following result is a corollary of Lemma 2.3 in [\[23\]](#page-43-0).

<span id="page-11-0"></span>Corollary 5.3. *Let F*· *be as in Lemma [3.5.](#page-7-0) Then there exist two unique* <sup>σ</sup>*-finite signed measures G and M on*  $\sigma(\mathcal{S}) \otimes \mathcal{B}(\mathbb{R})$  *such that* 

$$
G(A \times B) = G_A(B) \quad \text{and} \quad M(A \times B) = M_A(B), \quad \text{for all } A \in \mathcal{S}, B \in \mathcal{B}(\mathbb{R}).
$$

*Moreover, there exist two functions*  $\rho_G$ ,  $\rho_M : S \times \mathscr{B}(\mathbb{R}) \mapsto [-\infty, \infty]$  *such that* (i)  $\rho_G(s, \cdot), \rho_M(s, \cdot)$  *are Lévy measures on*  $\mathscr{B}(\mathbb{R})$ *, for every s*  $\in$  *S,* (ii)  $\rho_G(\cdot, B), \rho_M(\cdot, B)$  *are Borel measurable function, for every B*  $\in \mathscr{B}(\mathbb{R})$ *,* (iii)  $\int_{S\times\mathbb{R}} h(s,x)G(ds, dx) = \int_S \int_{\mathbb{R}} h(s,x)\rho_G(s, dx)\lambda(ds)$ , for every  $\sigma(\mathscr{S}) \otimes \mathscr{B}(\mathbb{R})$ *-measurable function h* :  $S \times \mathbb{R} \mapsto [0, \infty]$ , and the same holds for M. This equality can be extended to real and complex-valued functions *h.*

*Proof.* The above statement is almost identical to Lemma 2.3 in [\[23\]](#page-43-0). The only differences are two: a different function, call it  $\tilde{\rho}_G$ , instead of  $\rho_G$ , and  $\lambda_G$  instead of  $\lambda$ . In the proof of Lemma 2.3 in [\[23\]](#page-43-0)  $\tilde{\rho}_G$  := *d*λ<sup>0</sup>  $\frac{d\lambda_0}{d\lambda_G}(s)$  $(1 \wedge x^2)^{-1}q(s, dx)$  where  $q(s, B)$  is such that  $s \mapsto q(s, B)$  is Borel measurable and  $B \mapsto q(s, B)$  is a probability measure. Moreover, it is shown that  $G(A, B) = \int_A q(s, B) \lambda_0 ds$ . Now, let

$$
\rho_G(s, dx) = \frac{d\lambda_0}{d\lambda}(s)(1 \wedge x^2)^{-1}q(s, dx).
$$

It is possible to see that  $s \mapsto \rho_G(s, B)$  is still measurable and since  $\lambda_0(A) \geq \lambda(A)$  then  $B \mapsto \rho_G(s, B)$  is still a Levy measure too. Finally, by the properties of the Radon-Nikodym derivative we get  $\int_{S\times\mathbb{R}}h(s,x)G(ds,dx)$  =  $\int_S \int_{\mathbb{R}} h(s,x) \tilde{\rho}_G(s,dx) \lambda_G(ds) = \int_S \int_{\mathbb{R}} h(s,x) \rho_G(s,dx) \lambda(ds).$ П

<span id="page-11-2"></span>**Proposition 5.4.** *Let F. be as in Lemma* [3.5.](#page-7-0) *Then there exists a unique function*  $\rho : S \times \mathscr{B}_0(\mathbb{R}) \mapsto [-\infty, \infty]$ *s.t.*

$$
\rho(s,B) = \rho_G(s,B) - \rho_M(s,B), \quad s \in S, B \in \mathscr{B}(\mathbb{R}) \text{ s.t. } 0 \notin \overline{B}
$$

*The function*  $\rho(s, \cdot)$  *is a quasi-Lévy type measure on*  $\mathscr{B}(\mathbb{R})$  *for every s*  $\in$  *S. Moreover, its positive and negative*  $p$ art are two unique functions  $\rho^+, \rho^-: S\times \mathscr{B}(\mathbb{R}) \mapsto [0,\infty]$  such that

(i)  $\rho^+(s,\cdot), \rho^-(s,\cdot)$  are Lévy measures on  $\mathscr{B}(\mathbb{R})$ , for every  $s \in S$ ,

(ii)  $\rho^+(\cdot,B), \rho^-(\cdot,B)$  are Borel measurable function, for every  $B \in \mathscr{B}(\mathbb{R})$ ,

*Moreover, there exist two unique*  $\sigma$ -finite measures  $\tilde{F}$ <sup>+</sup> and  $\tilde{F}$ <sup>−</sup> *on*  $\sigma(\mathscr{S}) \otimes \mathscr{B}(\mathbb{R})$  *such that* 

<span id="page-11-1"></span>
$$
\int_{S\times\mathbb{R}} h(s,x)\tilde{F}^+(ds,dx) = \int_S \int_{\mathbb{R}} h(s,x)\rho^+(s,dx)\lambda(ds),\tag{8}
$$

*for every*  $\sigma(\mathscr{S})\otimes\mathscr{B}(\mathbb{R})$ -measurable function  $h : S\times\mathbb{R} \mapsto [0,\infty]$ , and the same holds for F<sup>−</sup>. This equality *can be extended to real and complex-valued functions h. Finally, for every A*  $\in \mathcal{S}$  *and for every real*  $\mathcal{B}(\mathbb{R})$ *measurable function g s.t.*  $\int_A \int_{\mathbb{R}} g(x) |\rho|(s,dx) \lambda(ds) < \infty$ *, we have that* 

$$
\int_{\mathbb{R}} g(x) F_A(dx) = \int_A \int_{\mathbb{R}} g(x) \rho(s, dx) \lambda(ds)
$$

*and for every*  $B \in \mathcal{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ ,

$$
\tilde{F}^+(A,B) \ge F_A^+(B)
$$
 and  $\tilde{F}^-(A,B) \ge F_A^-(B)$ .

**Remark 5.5.** *The reason why there is no a signed measure*  $\tilde{F}$  *on*  $\sigma(\mathcal{S}) \otimes \mathcal{B}(\mathbb{R})$  *s.t.*  $\tilde{F}(C) = \tilde{F}^+(C) - \tilde{F}^-(C)$ *is that both*  $\tilde{F}$ <sup>+</sup> *and*  $\tilde{F}$ <sup>−</sup> *might have infinite values.* 

*Proof.* Since, for every  $s \in S$ ,  $\rho_G(s, B)$  and  $\rho_M(s, B)$  are two Lévy measures, we obtain the first statement by the definition of quasi-Lévy type measure.

This implies that, for each  $s \in S$ ,  $\rho(s, B)$  has a positive and negative part defined as measures on  $(\mathbb{R}, \mathscr{B}(\mathbb{R}))$ . Then, it is easy to obtain (i). Concerning (ii), we have the following. Let  $f : \mathbb{R} \to \mathbb{R}$  be s.t.  $\int_{\mathbb{R}} f(x) |\rho|(s, dx)$  $\infty$  for every  $s \in S$  and let  $f^+(x) := f(x) \vee 0$  and  $f^-(x) := -f(x) \vee 0$ . Observe that the following are all measures

$$
B \mapsto \int_B f^+(x)\rho^+(s,dx), \quad B \mapsto \int_B f^+(x)\rho^-(s,dx),
$$
  

$$
B \mapsto \int_B f^+(x)\rho_G(s,dx), \quad \text{and} \quad B \mapsto \int_B f^+(x)\rho_M(s,dx).
$$

Moreover, we have that

$$
\int_B f^+(x)\rho^+(s,dx) - \int_B f^+(x)\rho^-(s,dx) = \int_B f^+(x)\rho(s,dx) = \int_B f^+(x)\rho_G(s,dx) - \int_B f^+(x)\rho_M(s,dx).
$$

Since  $B \mapsto \int_B f^+(x) \rho^+(s,dx) - \int_B f^+(x) \rho^-(s,dx)$  is a finite signed measure, it has a Hahn decomposition. Denote it by  $E^+$  and  $E^-$ . Further, since  $\rho^+(s, B)$  and  $\rho^-(s, B)$  are mutually singular we have that

$$
\int_{E^+} f^+(x)\rho^+(s,dx) - \int_{E^+} f^+(x)\rho^-(s,dx) = \int_{E^+} f^+(x)\rho^+(s,dx)
$$

and similarly for  $E^-$ . Therefore, we have that for every  $B \in \mathcal{B}(\mathbb{R})$  we deduce that

$$
\int_B f^+(x)\rho^+(s,dx) = \int_{B\cap E^+} f^+(x)\rho^+(s,dx) = \int_{B\cap E^+} f^+(x)\rho_G(s,dx) - \int_{B\cap E^+} f^+(x)\rho_M(s,dx).
$$

Observe that the last two terms are Borel measurable functions because  $\rho_G(s, B)$  and  $\rho_M(s, B)$  are Borel measurable functions thanks to Corollary [5.3.](#page-11-0) Since the difference of two measurable function is measurable we conclude that  $\int_B f^+(x) \rho^+(s, dx)$  is measurable and this holds for every  $B \in \mathscr{B}(\mathbb{R})$ . The same holds for  $\int_B f^+(x)\rho^-(s, dx)$  and for  $\int_B f^-(x)\rho^+(s, dx)$  and  $\int_B f^-(x)\rho^-(s, dx)$ . Therefore, since

$$
\int_{B} f(x)\rho^{+}(s, dx) = \int_{B} f^{+}(x)\rho^{+}(s, dx) - \int_{B} f^{-}(x)\rho^{+}(s, dx)
$$

(and similarly for  $\rho^-$ ) for every  $B \in \mathscr{B}(\mathbb{R})$ , we obtain that  $\int_B f(x)\rho^+(s,dx)$  and so  $f(x)\rho^+(s,dx)$  are Borel a measurable functions.

Let us now take  $f(x) = 1 \wedge x^2$ , it is possible to see that it is a valid choice since  $\int_{\mathbb{R}} (1 \wedge x^2) |\rho|(s, dx) < \infty$ . Then  $s \mapsto (1 \wedge x^2) \rho^+(s, dx)$  is a measurable function and so (as done in the proof of Lemma 2.3 in [\[23\]](#page-43-0)) we have that

$$
\rho^+(s, dx) = (1 \wedge x^2)^{-1} (1 \wedge x^2) \rho^+(s, dx)
$$

is a Borel measurable function. The same applies to  $\rho^-(s, dx)$  and, therefore, we obtain (ii).

Now, notice that the set function

$$
\tilde{F}^+(C):=\int_S\int_{\mathbb{R}}\mathbf{1}_C(s,x)\rho^+(s,dx)\lambda(ds),\quad C\in\sigma(\mathscr{S})\otimes\mathscr{B}(\mathbb{R})
$$

is a well defined measure on  $\sigma(\mathscr{S})\otimes\mathscr{B}(\mathbb{R})$ . Then, using standard measure theoretical arguments we get [\(8\)](#page-11-1).

The last statement follows by simple computations. Indeed, let  $g(x)$  be s.t.  $\int_A \int_{\mathbb{R}} g(x) |\rho|(s, dx) \lambda(ds) < \infty$ (notice that this includes also  $g(x) = \mathbf{1}_B(x)$  for every  $B \in \mathcal{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ ). Then, for every  $A \in \mathcal{S}$ ,  $s \mapsto$  $\mathbf{1}_{A}(s)g(x)\rho(s, dx)$  is a Borel measurable function and

$$
\int_A \int_{\mathbb{R}} g(x) \rho(s, dx) \lambda(ds) = \int_S \int_{\mathbb{R}} \mathbf{1}_A(s) g(x) \rho^+(s, dx) \lambda(ds) - \int_S \int_{\mathbb{R}} \mathbf{1}_A(s) g(x) \rho^-(s, dx) \lambda(ds)
$$

$$
= \int_{S} \int_{\mathbb{R}} \mathbf{1}_{A}(s)g(x)\rho_{G}(s, dx) \lambda(ds) - \int_{S} \int_{\mathbb{R}} \mathbf{1}_{A}(s)g(x)\rho_{M}(s, dx) \lambda(ds) = \int_{\mathbb{R}} g(x)G_{A}(dx) - \int_{\mathbb{R}} g(x)M_{A}(dx) = \int_{\mathbb{R}} g(x)F_{A}(dx).
$$

Further, let  $g(x) \ge 0$  (e.g.  $\mathbf{1}_B(x)$ ) and let  $E_A^+$  and  $E_A^-$  be the Hahn decomposition of R under  $F_A(\cdot)$ , then

$$
\int_{\mathbb{R}} g(x) F_A^+(dx) = \int_{E_A^+} g(x) F_A(dx) = \int_S \int_{E_A^+} \mathbf{1}_A(s) g(x) \rho(s, dx) \lambda(ds)
$$
  

$$
\leq \int_S \int_{E_A^+} \mathbf{1}_A(s) g(x) \rho^+(s, dx) \lambda(ds) \leq \int_S \int_A g(x) \rho^+(s, dx) \lambda(ds) = \int_{\mathbb{R}} g(x) \tilde{F}^+(A, dx).
$$

We present now one of the key results of this section, because it represents the first step for the construction of the c.f. of  $\int_S f \Lambda$ . Moreover the following results is frequently used in the field of (applied) probability especially when we the control measure is the Lebesgue measure.

<span id="page-13-0"></span>Proposition 5.6. *The characteristic function of* Λ(*A*) *can be written as:*

$$
\mathbb{E}(e^{i\theta\Lambda(A)})=\exp\left(\int_A K(\theta,s)\lambda(ds)\right), \quad \theta\in\mathbb{R}, A\in\mathscr{S},
$$

*where*

$$
K(\theta,s) = i\theta a(s) - \frac{\theta^2}{2}\sigma^2(s) + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta \tau(x)\rho(s,dx),
$$

 $a(s) = \frac{dv_0}{d\lambda}(s)$ ,  $\sigma^2(s) = \frac{dv_1}{d\lambda}(s)$  and  $\rho$  has been introduced in Proposition [5.4,](#page-11-2) and  $exp(K(\theta, s))$  is the charac*teristic function of a QID random variable if it exists. Moreover, we have*

$$
|a(s)| + \sigma^2(s) + \int_{\mathbb{R}} (1 \wedge x^2) \rho_G(s, dx) + \int_{\mathbb{R}} (1 \wedge x^2) \rho_M(s, dx) = 1, \qquad \lambda \text{-} a.e..
$$

*Proof.* The first statement follows from the Lévy-Khintchine formulation, Corollary [5.3](#page-11-0) and Proposition [5.4.](#page-11-2) In particular, since  $\int_A \int_{\mathbb{R}} (1 \wedge x^2) |\rho|(s,dx) \lambda(ds) < \infty$  then

$$
\int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta \tau(x) F_A(dx) = \int_A \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta \tau(x) \rho(s, dx) \lambda(ds)
$$

and so

$$
\mathbb{E}(e^{i\theta\Lambda(A)}) = \exp\left(i\theta v_0(A) - \frac{\theta^2}{2}v_1(A) + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta\tau(x)F_A(dx)\right)
$$

$$
= \exp\left(\int_A i\theta a(s) - \frac{\theta^2}{2}\sigma^2(s) + \int_{\mathbb{R}} \left(e^{i\theta x} - 1 - i\theta\tau(x)\right)\rho(s, dx)\lambda(ds)\right)
$$

The second statement follows from the fact that for every  $A \in \mathcal{S}$ , we have

$$
\int_A \left( |a(s)| + \sigma^2(s) + \int_{\mathbb{R}} (1 \wedge x^2) \rho_G(s, dx) + \int_{\mathbb{R}} (1 \wedge x^2) \rho_M(s, dx) \right) \lambda(ds)
$$
  
=  $|v_0|(A) + v_1(A) + \int_{\mathbb{R}} (1 \wedge x^2) G_A(dx) + \int_{\mathbb{R}} (1 \wedge x^2) M_A(dx) = \lambda(A) = \int_A \lambda(ds).$ 

 $\Box$ 

The following definition of the stochastic integral is the same as the one presented in [\[23\]](#page-43-0) but extended to the framework of QID random measure.

<span id="page-14-0"></span>**Definition 5.7.** Let  $f(s) = \sum_{j=1}^{n} x_j \mathbf{1}_{A_j}(s)$  be a real simple function on S, where  $A_j \in \mathcal{S}$  are disjoint. Then, *for every*  $A \in \sigma(\mathcal{S})$ *, we define* 

$$
\int_A f d\Lambda = \sum_{j=1}^n x_j \Lambda(A \cap A_j).
$$

*Further, a measurable function*  $f:(S, \sigma(S)) \to (\mathbb{R}, \mathcal{B}(\mathbb{R}))$  *is said to be A-integrable if there exists a sequence* { *fn*} *of simple functions such that*

(i)  $f_n \rightarrow f$ ,  $\lambda$ *-a.e.*,

(ii) *for every*  $A \in \sigma(\mathscr{S})$ *, the sequence*  $\{\int_A f_n d\Lambda\}$  *converges in probability as*  $n \to \infty$ *.* 

*If f is* Λ*-integrable, then we write*

$$
\int_A f d\Lambda = \mathbb{P} - \lim_{n \to \infty} \int_A f_n d\Lambda
$$

*where*  $\{f_n\}$  *satisfies* (i) *and* (ii).

Notice that for a simple function  $f(s) = \sum_{j=1}^{n} x_j \mathbf{1}_{A_j}(s)$  we have the following representation of the c.f.:

$$
\mathbb{E}\left(e^{i\theta \int_A f d\Lambda}\right) = \prod_{j=1}^n \mathbb{E}\left(e^{i\theta x_j \Lambda(A \cap A_j)}\right)
$$
  
= 
$$
\prod_{j=1}^n \exp\left(\int_{A \cap A_j} i\theta x_j a(s) - \frac{\theta^2 x_j^2}{2} \sigma^2(s) + \int_{\mathbb{R}} \left(e^{i\theta x_j x} - 1 - i\theta x_j \tau(x)\right) \rho(s, dx) \lambda(ds)\right)
$$
  
= 
$$
\exp\left(\int_A i\theta f(s) a(s) - \frac{\theta^2 f^2(s)}{2} \sigma^2(s) + \int_{\mathbb{R}} \left(e^{i\theta f(s)x} - 1 - i\theta f(s)\tau(x)\right) \rho(s, dx) \lambda(ds)\right).
$$

In the following result, we prove that  $\int_A f dA$  does not depend on the approximating sequence, hence it is well defined. This does not follow from [\[28\]](#page-43-5) or from [\[24\]](#page-43-6) since they focus on ID random variables, however we use some of their arguments. In particular, in [\[28\]](#page-43-5) (which is the work cited in [\[23\]](#page-43-0)) the random measures considered is *atomless* (see Section [8](#page-37-0) for the definition and for further details) while we (and [\[24\]](#page-43-6)) do not have such a restriction.

**Lemma 5.8.** Let  $\Lambda$  be a QID random measure and let f be  $\Lambda$ -integrable then  $\int_A f d\Lambda$  is well defined, for *every*  $A \in \sigma(\mathscr{S})$ 

*Proof.* Let  $\{f_n\}$  and  $\{g_n\}$  be two real simple functions on *S* as in the Definition [5.7](#page-14-0) and satisfying (i) and (ii) with the same limit. Let  $h_n = f_n - g_n$  ( $n = 1, 2, ...$ ). Then, the sequence  $\{h_n\} \to 0$   $\lambda$ -a.e. and  $\int_A h_n d\Lambda$ converges in probability for every  $A \in \sigma(\mathcal{S})$ . It remains to show that  $\int_A h_n d\Lambda \stackrel{p}{\to} 0$  for every  $A \in \sigma(\mathcal{S})$ . Let  $N_n(A) = \int_A f_n d\Lambda$  then  $N_n$  is a measure on  $L_0(\Omega, \mathscr{F}, \mathbb{P}; \mathbb{R})$ , which is the set of all measurable random elements defined on  $(\Omega,\mathscr{F},\mathbb{P})$  with values in R. In particular,  $N_n$  is absolutely continuous with respect to  $\lambda$ and for every  $A \in \sigma(\mathscr{S})$  we have that  $N(A) := \lim_{n \to \infty} N_n(A)$  exists. In particular the existence is guaranteed by the convergence of  $\int_A h_n d\Lambda$ . Applying the Hahn-Saks-Vitali theorem we obtain that *N* is a measure on  $L_0(\Omega, \mathscr{F}, \mathbb{P}; \mathbb{R})$  and  $N \ll \lambda$ .

Since  $\{h_n\}$  converges  $\lambda$ -a.e., we can apply the Egorov (or more correctly Lusin) theorem and obtain that for every set *A* in  $\sigma(\mathscr{S})$  we have  $A = \bigcup_{k=0}^{\infty} A_k$  where  $A_k$ 's are pairwise disjoint sets belonging to  $\sigma(\mathscr{S})$ s.t.  $\lambda(A_0) = 0$  and  $h_n \to 0$  uniformly on every set  $A_k$ 's for  $k > 0$ . Then, for every  $A_k$  we have

$$
\mathscr{L}(N(A_k)) = \lim_{n \to \infty} \mathscr{L}(N_n(A_k)) = \lim_{n \to \infty} \exp\left(\int_{A_k} K(\theta h_n(s), s) \lambda(ds)\right)
$$
  
= 
$$
\lim_{n \to \infty} \exp\left(\int_{A_k} i\theta h_n(s) a(s) - \frac{\theta^2}{2} h_n^2(s) \sigma^2(s) + \int_{\mathbb{R}} \left(e^{i\theta h_n(s)x} - 1 - i\theta h_n(s)\tau(x)\right) \rho(s, dx) \lambda(ds)\right) = 1,
$$

using the dominated convergence theorem and that  $\sup h_n(s) \to 0$  as  $n \to \infty$ . Hence,  $N(A_k) = 0$  in probability *s*∈*A<sup>k</sup>* for every  $k > 0$ . Then, since  $N(A)$  is a measure we have that  $N(A) = \sum_{k=0}^{\infty} N(A_k) = 0$ , for every  $A \in \sigma(\mathcal{S})$ .

It is now possible to give a representation of the c.f. of  $\int_S f dA$ .

<span id="page-15-1"></span>**Proposition 5.9.** If f is  $\Lambda$ -integrable, then  $\int_S |K(\theta f(s), s)| \lambda(ds) < \infty$ , where K is given in Proposition [5.6,](#page-13-0) *and*

$$
\hat{\mathscr{L}}\left(\int_{S} f d\Lambda\right)(\theta) = \exp\left(\int_{S} K(\theta f(s), s) \lambda(ds)\right), \quad \theta \in \mathbb{R}.
$$

*Proof.* The statement follows from the same arguments used in the proof of Proposition 2.6 of [\[23\]](#page-43-0). Let us sketch them. First, notice that the statement holds for simple function as in Definition [5.7.](#page-14-0) Let  $\{f_n\}$  be a sequence of simple functions. Let  $\mu_{\theta,n}(A) := \int_A K(\theta f_n(s), s) \lambda(ds)$  where  $A \in \sigma(\mathscr{S})$  and observe that it is a complex measure for every  $\theta \in \mathbb{R}$  and  $n \in \mathbb{N}$ . Since

$$
\lim_{n\to\infty}\mu_{\theta,n}(A)=\lim_{n\to\infty}\log\hat{\mathscr{L}}\left(\int_A f_n d\Lambda\right)(\theta)=\log\hat{\mathscr{L}}\left(\int_S f d\Lambda\right)(\theta)=\mu_{\theta}(A),
$$

for every  $A \in \sigma(\mathscr{S})$  and  $\theta \in \mathbb{R}$ , we conclude that by the Hahn-Saks-Vitali theorem  $\mu_{\theta}$  is a countably additive complex measure. Further, since  $\mu_{\theta} \ll \lambda$  then  $\mu_{\theta}(A) = \int_A h_{\theta}(s) \lambda(ds)$ . By the continuity of  $K(\cdot, s)$  for each  $s \in S$  we deduce that  $K(\theta f_n(s), s) \to K(\theta f(s), s)$  a.e.- $\lambda$ , and using Egorov (Lusin) theorem we have that  $S = \bigcup_{j=0}^{\infty} A_j$ , where  $\lambda(A_0) = 0$  and  $\lambda(A_j) < \infty$  and with  $K(\theta f_n(s), s) \to K(\theta f(s), s)$  a.e.- $\lambda$  uniformly in  $s \in A_j$  for  $j \in \mathbb{N}$ . Thus,  $h_\theta(s) = K(\theta f(s), s)$  a.e.- $\lambda$  on  $A_j$  with  $j \ge 1$  because for every  $A \in \sigma(\mathcal{S})$ 

$$
\int_{A\cap A_j} h_{\theta}(s)\lambda(ds) = \mu_{\theta}(A\cap A_j) = \lim_{n\to\infty} \int_{A\cap A_j} K(\theta f_n(s), s)\lambda(ds) = \int_{A\cap A_j} K(\theta f(s), s)\lambda(ds)
$$

But since  $A_0$  is a  $\lambda$ -null set then  $h_\theta(s) = K(\theta f(s), s)$  a.e.- $\lambda$  on *S*.

We are now ready to present the main result of this subsection, which concerns the integrability conditions for R *S f d*Λ.

<span id="page-15-0"></span>**Theorem 5.10.** *Let*  $f : S \to \mathbb{R}$  *be a*  $S$ *-measurable function. Then*  $f$  *is*  $\Lambda$ -*integrable if the following three conditions hold:*

 $\int_S |U(f(s),s)| \lambda(ds) < \infty$ , (ii)  $\int_S |f(s)|^2 \sigma^2(s) \lambda(ds) < \infty$ ,  $\int_{S}V_0(f(s),s)\lambda(ds)<\infty,$ 

where 
$$
U(u,s) = ua(s) + \int_{\mathbb{R}} \tau(xu) - u\tau(x)\rho(s,dx), \quad V_0(u,s) = \int_{\mathbb{R}} (1 \wedge |xu|^2)|\rho|(s,dx),
$$

*Further, the c.f. of*  $\int_S f dΛ$  *can be written as*  $\hat{\mathcal{L}}\left(\int_{\mathcal{S}} f d\Lambda\right)\left(\theta\right) = \exp\left(i\theta a_f - \frac{1}{2}\right)$  $\frac{1}{2}\theta^2\sigma_f^2 + \int_{\mathbb{R}}e^{i\theta x} - 1 - i\theta\,\tau(x)F_f(dx)\Big),$  where  $a_f =$  $\int_S U(f(s),s)\lambda(ds), \quad \sigma_f^2 = \int$  $\int_{S} |f(s)|^2 \sigma^2(s) \lambda(ds)$ , and

 $F_f$  is the unique quasi-Lévy measure determined by the difference of the Lévy measures  $\tilde{F}_f^+$  and  $\tilde{F}_f^-$ , which *are defined as: for every*  $B \in \mathcal{B}(\mathbb{R})$ 

$$
\tilde{F}_f^+(B) = \tilde{F}^+(\{(s,x)\in S\times\mathbb{R}: f(s)x\in B\setminus\{0\}\}) \text{ and } \tilde{F}_f^-(B) = \tilde{F}^-(\{(s,x)\in S\times\mathbb{R}: f(s)x\in B\setminus\{0\}\})
$$

口

*Proof.* In this proof we follow some of the arguments used in the proof of Theorem 2.7 in [\[23\]](#page-43-0). Assume that (i), (ii), (iii) hold. Consider the sets  $S_1, S_2, ... \in \mathscr{S}$  s.t.  $\bigcup_{n \in \mathbb{N}} S_n = S$ . Let  $A_n = \{s : |f(s)| \le n\} \cap S_n$ . We have that  $\{A_n\} \subset \mathscr{S}$  and  $A_n \nearrow S$ . Consider a sequence  $(f_n)$  of simple  $\mathscr{S}$ -measurable functions, s.t.  $f_n(s) = 0$  if  $s \in A_n$ ,  $|f_n(s) - f(s)| \leq \frac{1}{n}$  if  $s \in A_n$ , and  $|f_n(s)| \leq |f(s)|$  for all  $s \in S$ . Then,  $f_n \to f$  everywhere on S as *n* → ∞. Further, notice that for every  $A \in \sigma(\mathcal{S})$  and  $n, m \ge 1$ ,  $|(f_n(s) - f_m(s)) \mathbf{1}_A(s)| \le 2|f(s)|$ . Then by Lemma [5.11](#page-16-0) (see the next result) we derive

$$
|U((f_n(s) - f_m(s)) \mathbf{1}_A(s), s)| \leq 2|U(f(s), s)| + 27V_0(f(s), s).
$$

Thus, by the dominated convergence theorem, we obtain that for every  $A \in \sigma(\mathcal{S})$ ,

$$
\lim_{n,m\to\infty}\int_{S}U((f_n(s)-f_m(s)),\mathbf{1}_A(s),s)\lambda(ds)=0,
$$
\n(9)

<span id="page-16-2"></span>
$$
\lim_{n,m \to \infty} \int_{S} (f_n(s) - f_m(s))^2 \mathbf{1}_A(s) \sigma^2(s) \lambda(ds) = 0,
$$
\n(10)

<span id="page-16-3"></span>and 
$$
\lim_{n,m \to \infty} \int_{S} V_0((f_n(s) - f_m(s))\mathbf{1}_A(s), s)\lambda(ds) = 0.
$$
 (11)

Then, from (i), (ii), (iii) and Proposition [5.6](#page-13-0) it is possible to obtain (iv) for the simple measurable functions  $(f_n(s) - f_m(s))$ **1**<sub>A</sub>. Indeed, let  $g_{n,m,A}(s) := (f_n(s) - f_m(s))$ **1**<sub>A</sub>, we have

$$
\mathscr{L}\left(\int_{S}g_{n,m,A}d\Lambda\right)(\theta)
$$
\n
$$
= \exp\left(i\theta a_{g_{n,m,A}} - \frac{1}{2}\theta^{2}\sigma_{g_{n,m,A}}^{2} + \int_{S}\int_{\mathbb{R}}\left(e^{i\theta g_{n,m,A}(s)x} - 1 - i\theta g_{n,m,A}(s)\tau(x)\right)\rho(s,dx)\lambda(ds)\right)
$$
\n
$$
= \exp\left(i\theta a_{g_{n,m,A}} - \frac{1}{2}\theta^{2}\sigma_{g_{n,m,A}}^{2} + \int_{S}\int_{\mathbb{R}}\left(e^{i\theta g_{n,m,A}(s)x} - 1 - i\theta g_{n,m,A}(s)\tau(x)\right)\rho^{+}(s,dx)\lambda(ds)\right)
$$
\n
$$
- \int_{S}\int_{\mathbb{R}}e^{i\theta g_{n,m,A}(s)x} - 1 - i\theta g_{n,m,A}(s)\tau(x)\rho^{-}(s,dx)\lambda(ds)\right)
$$
\n
$$
= \exp\left(i\theta a_{g_{n,m,A}} - \frac{1}{2}\theta^{2}\sigma_{g_{n,m,A}}^{2} + \int_{\mathbb{R}}e^{i\theta x} - 1 - i\theta\tau(x)\tilde{F}_{g_{n,m,A}}^{+}(dx) - \int_{\mathbb{R}}e^{i\theta x} - 1 - i\theta\tau(x)\tilde{F}_{g_{n,m,A}}^{-}(dx)\right)
$$
\n
$$
= \exp\left(i\theta a_{g_{n,m,A}} - \frac{1}{2}\theta^{2}\sigma_{g_{n,m,A}}^{2} + \int_{\mathbb{R}}e^{i\theta x} - 1 - i\theta\tau(x)F_{g_{n,m,A}}(dx)\right)
$$

Now, using (iv) for simple functions, [\(9\)](#page-16-1), [\(10\)](#page-16-2), and [\(11\)](#page-16-3), we get  $\lim_{n,m\to\infty} \mathscr{L}\left(\int_{S} (f_n(s) - f_m(s)) \mathbf{1}_A d\Lambda\right) (\theta) = 1$ for every  $\theta \in \mathbb{R}$  and  $A \in \sigma(\mathcal{S})$ . Therefore, the sequence  $\{\int_A f_n d\Lambda\}_{n=1}^{\infty}$  converges in probability for every  $A \in \sigma(\mathcal{S})$ , namely *f* is Λ-integrable and, then, the c.f. of  $\int_S f d\Lambda$  can be written as in (iv). □

<span id="page-16-0"></span>**Lemma 5.11.** *For every*  $u \in \mathbb{R}$ *,*  $s \in S$  *and*  $d > 0$ *,* 

$$
\sup\{|U(cu,s)|:|c|\leq d\}\leq d|U(u,s)|+(1+d)^3V_0(u,s).
$$

*Proof.* Let  $|c| \le d$ . Define  $R(c, u, s) := \int_{\mathbb{R}} \tau(xcu) - c\tau(ux)\rho(s, dx)$ . We can rewrite  $U(cu, s)$  as follows

$$
U(cu,s) = cua(s) + \int_{\mathbb{R}} \tau(xcu) - cu\tau(x)\rho(s,dx)
$$
  
= 
$$
cua(s) + c \int_{\mathbb{R}} \tau(xu) - u\tau(x)\rho(s,dx) + \int_{\mathbb{R}} \tau(xcu) - c\tau(ux)\rho(s,dx) = cU(u,s) + R(c,u,s).
$$

Observe that  $\tau(xcu) - c\tau(ux) = 0$  if  $|ux| \leq (1 \wedge |c|^{-1})$  and  $|\tau(xcu) - c\tau(ux)| \leq 1 + d$  otherwise. Thus, we obtain, using Chebychev's inequality, that

$$
|R(c, u, s)| \le (1+d) \int_{|ux| > (1 \wedge |c|^{-1})} |\rho|(s, dx) \le (1+d) |\rho|(s, \{x : (1 \wedge |ux|) \ge (1 \wedge |c|^{-1})\})
$$
  

$$
\le \frac{1+d}{(1 \wedge |c|^{-2})} \int_{\mathbb{R}} (1 \wedge |ux|^2) |\rho|(s, dx) \le (1+d)^3 V_0(u, s).
$$

The reason why it is not possible to get an "only if" result is because we have

$$
\int_{\mathbb{R}} (1 \wedge x^2) |F_f|(dx) \leq \int_{S} \int_{\mathbb{R}} (1 \wedge |f(s)x|^2) |\rho|(s, dx) \lambda(ds),
$$

where  $|F_f|$  is the total variation of the quasi-Lévy measure  $F_f$ . Hence, we do not have an equality but only an inequality, which implies that if  $\int_{\mathbb{R}}(1 \wedge x^2)|F_f|(dx) < \infty$  then it is not necessarily true that  $\int_S \int_{\mathbb{R}}(1 \wedge$  $|f(s)x|^2$ )| $\rho$ | $(s, dx)$  $\lambda(ds) < \infty$  (*i.e.* point (iii) in Theorem [5.10\)](#page-15-0). Indeed, notice that

$$
\int_{\mathbb{R}} (1 \wedge x^2) |F_f|(dx) \leq \int_{\mathbb{R}} (1 \wedge x^2) \tilde{F}_f^+(dx) + \int_{\mathbb{R}} (1 \wedge x^2) \tilde{F}_f^-(dx) = \int_{S} \int_{\mathbb{R}} (1 \wedge |f(s)x|^2) |\rho|(s, dx) \lambda(ds),
$$

where the inequality comes from the following argument. Recall that  $\tilde{F}_f^+(B) = \tilde{F}^+(\{(s,x) \in S \times \mathbb{R} : f(s)x \in S \times \mathbb{R} \times \mathbb{R} \times \mathbb{R} \times \mathbb{R}$ *B* \{0}}), for every  $B \in \mathscr{B}(\mathbb{R})$  and let  $C^+ \in \sigma(\mathscr{S}) \otimes \mathscr{B}(\mathbb{R})$  s.t.  $\tilde{F}^+(A) > 0$  for every  $A \subset C^+$  and similarly we define  $C^-$  for  $\tilde{F}^-$ . We have that  $\tilde{F}^+_f(B) \geq F^+_f(B)$  because there might exist two sets  $A_1, A_2 \in \sigma(\mathscr{S}) \otimes \mathscr{B}(\mathbb{R})$ with  $A_1 \in C^+$  and  $A_2 \in C^-$  s.t.  $f(s)x \in B \in \mathcal{B}(\mathbb{R})$  for every  $(s, x) \in A_1$  and  $(s, x) \in A_2$ . So, for this specific *B* we will have both  $\tilde{F}_f^+(B)$  and  $\tilde{F}_f^-(B)$  strictly positive, thus explaining the inequality. For example, think of  $(s, x) \in A_1$  and  $(s', x') \in A_2$ , it might happen that  $f(s)x = f(s')x'$ , especially if the image of f is the whole R.

However, by adding a further assumption we have the following result.

<span id="page-17-0"></span>**Theorem 5.12.** Let  $f : S \to \mathbb{R}$  be a  $S$ -measurable function. Then, if f is integrable with respect to  $\Lambda_G$  and Λ*M, the three conditions* (i)*,* (ii) *and* (iii) *of Theorem [5.10](#page-15-0) hold, namely f is* Λ*-integrable. Further, the c.f. of* R *S f d*Λ *can be written as in point* (iv) *of Theorem [5.10.](#page-15-0)*

*Proof.* From the fact that  $|\hat{\mathscr{L}}(\int_S f d\Lambda_G)|^2$  and  $|\hat{\mathscr{L}}(\int_S f d\Lambda_M)|^2$  are the c.f. of ID-random variables it follows that

$$
\left|\mathscr{L}\left(\int_{S} f d\Lambda_{G}\right)(\theta)\right|^{2} = \exp\left(-\theta^{2} \sigma_{G,f}^{2} + 2 \int_{\mathbb{R}} \cos(\theta x) - 1 G_{f}(dx)\right).
$$

where  $G_f(B) = G(\{(s, x) \in S \times \mathbb{R} : f(s)x \in B \setminus \{0\}\})$  and where  $\sigma_{G,f}^2 = \int_S |f(s)| \sigma_G^2(s) \lambda_G(ds)$ . By the properties of the Radon-Nikodym derivative we have that

$$
\sigma_{G,f}^2 = \int_S |f(s)| \sigma_G^2(s) \lambda_G(ds) = \int_S |f(s)| \frac{d\mathbf{v}^{(1)}}{d\lambda_G}(s) \lambda_G(ds) = \int_S |f(s)| \frac{d\mathbf{v}^{(1)}}{d\lambda}(s) \lambda(ds) = \sigma_f^2
$$

Therefore we get that  $\sigma_f^2 < \infty$  and that

$$
\int_{\mathbb{R}} (1 \wedge y^2) \tilde{F}_f^+(dy) + \int_{\mathbb{R}} (1 \wedge y^2) \tilde{F}_f^-(dy) \le \int_{\mathbb{R}} (1 \wedge y^2) G_f(dy) + \int_{\mathbb{R}} (1 \wedge y^2) M_f(dy) < \infty,
$$

where  $M_f$  is defined similarly to  $G_f$ , and thus we obtain (ii) and (iii). Further, since  $|\tau(x) - \sin(x)| \le$  $2(1 \wedge x^2)$ , (i) follows from noticing that

$$
|U(u,s)| \leq \left|ua(s) + \int_{\mathbb{R}} \sin(xu) - u\tau(x)\rho(s,dx)\right| + \left|\int_{\mathbb{R}} \tau(xu) - \sin(xu)|\rho|(s,dx)\right| \leq |\text{Im}\,K(u,s)| + 2V_0(u,s),
$$

which is finite because of (iii) and of Proposition [5.9.](#page-15-1)

We end this section with the following result, which links  $\int_A f_n d\Lambda$  with  $\int_A f_n d\Lambda_G$  and  $\int_A f_n d\Lambda_M$ .

<span id="page-18-3"></span>**Proposition 5.13.** Let f be integrable w.r.t.  $\Lambda_G$  and  $\Lambda_M$ . Then, for every  $\theta \in \mathbb{R}$ , we have

<span id="page-18-1"></span>
$$
\hat{\mathscr{L}}\left(\int_{S} f d\Lambda\right)(\theta) = \frac{\hat{\mathscr{L}}\left(\int_{S} f d\Lambda_{G}\right)(\theta)}{\hat{\mathscr{L}}\left(\int_{S} f d\Lambda_{M}\right)(\theta)}.
$$
\n(12)

*Proof.* There are at least two ways to prove this result. The first is to use the properties of the Radon-Nikodym derivative and use point (iv) in Theorem [5.10.](#page-15-0) The second is consider the sequence of simple functions  $(f_n)$  of the proof of Theorem [5.10](#page-15-0) together with Proposition [5.9](#page-15-1) and Theorem [5.12.](#page-17-0) Let's show the latter in detail.

Consider *f* to be  $\Lambda^{(1)}$  and  $\Lambda^{(2)}$  integrable. Then we know that *f* is also  $\Lambda$ -integrable by Theorem [5.12.](#page-17-0) Now consider the sequence  $(f_n)$  as in the proof of Theorem [5.10,](#page-15-0) then we know that  $\{\int_A f_n d\Lambda\}_{n=1}^{\infty}$ ,  $\{\int_A f_n d\Lambda G\}_{n=1}^{\infty}$ and  $\{\int_A f_n d\Lambda_M\}_{n=1}^\infty$  converges in probability for every  $A \in \sigma(\mathscr{S})$ . Since for every  $n \in \mathbb{N}$ 

$$
\hat{\mathscr{L}}\left(\int_{S} f_n d\Lambda\right)(\theta) = \frac{\hat{\mathscr{L}}\left(\int_{S} f_n d\Lambda_G\right)(\theta)}{\hat{\mathscr{L}}\left(\int_{S} f_n d\Lambda_M\right)(\theta)}
$$

then we have that

$$
\hat{\mathscr{L}}\left(\int_{S} f d\Lambda\right)(\theta) = \lim_{n \to \infty} \hat{\mathscr{L}}\left(\int_{S} f_n d\Lambda\right)(\theta) = \lim_{n \to \infty} \frac{\hat{\mathscr{L}}\left(\int_{S} f_n d\Lambda_G\right)(\theta)}{\hat{\mathscr{L}}\left(\int_{S} f_n d\Lambda_M\right)(\theta)} = \frac{\hat{\mathscr{L}}\left(\int_{S} f d\Lambda_G\right)(\theta)}{\hat{\mathscr{L}}\left(\int_{S} f d\Lambda_M\right)(\theta)}.
$$

As we mentioned at the beginning of this section we have that  $\Lambda_G \sim (0, v_1, G)$  and  $\Lambda_M \sim (-v_0, 0, M)$ , however all the results hold for more general ID r.m.. A sufficient condition for two generic ID r.m. (call them  $\Lambda_J$  and  $\Lambda_H$ ) is that  $\Lambda_J$  and  $\Lambda_H$  generate  $\Lambda$  and that their control measure, call them  $\lambda_X$  and  $\lambda_Y$ , are s.t.  $\lambda_X(A) \leq C\lambda(A)$  and  $\lambda_X(A) \leq C'\lambda(A)$  where  $C, C' \in (0, \infty)$  for every  $A \in \sigma(\mathscr{S})$ . For the sake of brevity we left to the curious reader to check this statement. However, it would interesting to have the weakest possible conditions that two generating ID r.m. must satisfy in order to satisfy all the results presented in this section, which mean satisfy [\(12\)](#page-18-1).

Open Question 5.14. *Given a QID r.m., what is the largest class of generating ID r.m. that satisfy [\(12\)](#page-18-1)?*

The answer to this question is also linked with Theorem [7.20a](#page-35-0)nd Open Question [7.21.](#page-35-1)

#### <span id="page-18-0"></span>5.2 The bounded case

In this section we will work with the following assumptions. We let  $\mathscr S$  be a  $\sigma$ -algebra,  $F(A, B)$  be a bimeasure on  $\mathscr{S} \times \mathscr{B}(\mathbb{R})$  and

<span id="page-18-2"></span>
$$
\sup_{I} \sum_{i \in I} |F_{A_i}(B_i)| < \infty,\tag{13}
$$

where the supremum is taken over all the finite sets  $(A_i, B_i)_{i \in I}$  of elements of  $\mathscr{S} \times \mathscr{B}(\mathbb{R})$  such that the rectangles  $A_i \times B_i$  are disjoint.

Let us introduce the set function  $v(A): \mathscr{S} \mapsto [0, \infty)$  such that

$$
v(A) := \sup_{I_A} \sum_{i \in I_A} |F_{A_i}(B_i)|,
$$

where  $I_A$  is defined as *I* but with the constraint that  $A_i \subset A$ . To have a better idea of what kind of object v is, compare it with the definition of total variation of a signed measure ([1](#page-2-2)). We start with the following proposition on the control measure.

<span id="page-19-1"></span>**Proposition 5.15.** Let  $\Lambda$  be a QID random measure. Let  $v_0 : \mathcal{S} \mapsto \mathbb{R}$  be a signed measure,  $v_1 : \mathcal{S} \mapsto \mathbb{R}$ *be a measure, F<sub>A</sub> be a quasi-Lévy measure on*  $\mathbb R$  *for every*  $A \in \mathscr S$ ,  $\mathscr S \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *be a signed measure for every B*  $\in \mathcal{B}(\mathbb{R})$  *s.t.*  $(v_0(A), v_1(A), F_A)$  *is the characteristic triplet of*  $\Lambda(A), \forall A \in \mathcal{S}$ *. Assume that F satisfies* ([13](#page-18-2))*. Define*

<span id="page-19-3"></span>
$$
\lambda(A) = |v_0|(A) + v_1(A) + v(A).
$$
\n(14)

*Then*  $\lambda : \mathscr{S} \mapsto [0, \infty)$  *is a measure such that*  $\lambda(A_n) \to 0$  *implies*  $\Lambda(A_n) \stackrel{p}{\to} 0$  *for every*  $\{A_n\} \subset \mathscr{S}$ .

*Proof.* From Theorem 4 in [\[9\]](#page-42-7) we have that  $v(A)$  defines a measure. Then it is straightforward to see that  $\lambda(A)$  is a measure. Now if  $v(A_n) \to 0$  then  $F_{A_n}^+(B) \to 0$  and  $F_{A_n}^-(B) \to 0$  for every  $B \in \mathscr{B}(\mathbb{R})$ , hence by the Lévy continuity theorem we obtain the stated result.  $\Box$ 

Before presenting one of the main results of this section, which consists of an extension of Proposition 2.4 in [\[23\]](#page-43-0), we give a remark on its topology.

Remark 5.16. *Proposition 2.4 in [\[23\]](#page-43-0) is stated for a* standard Borel space*, where a measurable space* (*X*,Γ) *is said to be* standard Borel space *if there exists a metric on X which makes it a complete separable metric space in such a way that* Γ *is then the Borel* <sup>σ</sup>*-algebra* B(*X*)*. However, the following result holds for more general topological spaces: the* Lusin measurable spaces*. Lusin measurable spaces are measurable spaces isomorphic to a measurable space*  $(H,\mathcal{B}(H))$ *, where H is homeomorphic to a Borel subset of a compact metrizable space. Notice that H is usually called Lusin space or more correctly Lusin metrizable space. In this remark, we do not provide an extensive discussion (indeed, see [\[4\]](#page-42-8), [\[9\]](#page-42-7) and [\[10\]](#page-42-9) for further details), we just mention that H can be any Polish space (thus, including the real line).*

<span id="page-19-2"></span>**Theorem 5.17.** *Let*  $(X, \mathcal{B})$  *be a Lusin measurable space and let*  $(T, \mathcal{A})$  *be an arbitrary measurable space. Let*  $Q_0(A, B)$  *be a (possibly negative) function of*  $A \in \mathcal{A}$ ,  $B \in \mathcal{B}$ *, satisfying:* (a) *for every*  $A \in \mathcal{A}$ ,  $Q_0(A, \cdot)$  *is a signed measure on*  $(X, \mathcal{B})$ *,* 

(b) *for every*  $B \in \mathcal{B}$ ,  $Q_0(\cdot, B)$  *is a signed measure on*  $(T, \mathcal{A})$ *,* 

(c)  $\sup \sum_{i \in I} |Q_0(A_i, B_i)| < \infty$ .

*I* Let  $v(A) := \sup \sum_{i \in I} |Q_0(A_i, B_i)|$ . Then there exists a unique finite signed measure Q on the product  $\sigma$ -*IA algebra* A ⊗B *s.t.*

<span id="page-19-0"></span>
$$
Q(A \times B) = Q_0(A, B) = \int_A q(t, B)v(dt), \qquad (15)
$$

*with Jordan decomposition*

$$
Q^{+}(C) = \int_{T} \int_{X} I_{C}(x,t) \tilde{q}_{+}(t, dx) v(dt) \quad and \quad Q^{-}(C) = \int_{T} \int_{X} I_{C}(x,t) \tilde{q}_{-}(t, dx) v(dt)
$$

*for every A* ∈  $\mathscr{A}, B \in \mathscr{B}, C \in \mathscr{A} \otimes \mathscr{B}$  where  $q : T \times \mathscr{B} \to [-1,1]$  *fulfils the following conditions:* (d) *for every t,*  $q(t, \cdot)$  *is a signed measure on*  $\mathcal{B}$ *,* 

(e) *for every B,*  $q(\cdot, B)$  *is*  $\mathscr A$ -measurable,

*and where*  $\tilde{q}_{+}(t, \cdot)$  *and*  $\tilde{q}_{-}(t, \cdot)$  *are the Jordan decomposition of q*(*t*, ·).

*Further, if*  $q_1(\cdot, \cdot)$  *is some other function satisfying* ([15](#page-19-0)), (d) *and* (e)*, then off a set of* v-measure zero,  $q_1(t,\cdot) = q(t,\cdot).$ 

*Proof.* First, recall that, by Theorem 4 in [\[9\]](#page-42-7),  $v(\cdot)$  is a measure. Notice that by definition  $v(\cdot) \gg Q_{0,+}(\cdot, B)$ and  $v(\cdot) \gg Q_{0,-}(\cdot,B)$  for every  $B \in \mathcal{B}$ , where  $Q_{0,+}(\cdot,B)$  and  $Q_{0,-}(\cdot,B)$  are the Jordan decomposition of  $Q_0(\cdot,B)$ . Then, by the Radon-Nikodym theorem we have that  $Q_{0,+}(A,B) = \int_A \tilde{q}_+(x,B)v(dx)$  and  $Q_{0,-}(A,B) =$  $\int_A \tilde{q}-(x,B)v(dx)$ . Hence,  $Q_0(A,B) = \int_A q(x,B)v(dx)$  and  $q(x,B) = \tilde{q}_+(x,B) - \tilde{q}_-(x,B)$  is v-a.s. uniquely defined (since  $\tilde{q}_+(x, B)$  and  $\tilde{q}_-(x, B)$  are the unique Radon-Nikodym derivatives) and, for every  $B \in \mathcal{B}, q(\cdot, B)$ is  $\mathscr A$ -measurable.

Observe also that by definition  $v(A) \geq Q_{0,+}(A,B)$  and  $v(A) \geq Q_{0,+}(A,B)$  for every  $A \in \mathcal{A}$  and every

 $B \in \mathscr{B}(\mathbb{R})$ . Then,  $\tilde{q}_+(x,B) \leq 1$  and  $\tilde{q}_-(x,B) \leq 1$ , v-a.e.. Further, since  $O(A, \cdot)$  is a (signed) measure for any  $A \in \mathscr{A}$  then  $q(x, \cdot)$  is also a (signed) measure with  $|q(x, B)| \leq 1$  for every  $B \in \mathscr{B}$ . This is possible to see by adapting the arguments of the proof of Theorem 4 in [\[9\]](#page-42-7) when the function considered is the indicator function. Indeed, using their formalism  $Q(A, 1_B) := \int_X 1_B(y)Q(A, dy)$ , hence  $Q(A, 1_B) = Q(A, B)$ , and by the uniqueness of the Radon-Nikodym derivative  $q(x, 1_B) = q(x, B)$ , v-a.e..

Again by adapting the arguments of Theorem 4 in [\[9\]](#page-42-7) we get that there exists a finite signed measure  $Q(A \times B) = \int_A q(x, B) v(dx)$ . Moreover, by the uniqueness of *q* we have that this signed measure is unique.

We prove now the stated Jordan decomposition of *Q*. From the proof of Theorem 4 in[\[9\]](#page-42-7) it is shown, using our notation, that  $Q(C) = Q^+(C) - Q^-(C)$  for any  $C \in \mathcal{B} \otimes \mathcal{A}$ . However, it is not mentioned that  $Q^+$ and *Q* <sup>−</sup> are the Jordan decomposition of *Q*, but this is indeed the case and we are going to prove it here. If we apply the arguments of the proof of Proposition 6 in [\[9\]](#page-42-7) to indicator functions then it is possible to see that the decomposition of  $q(\cdot, 1_B)$  into  $q^+(\cdot, 1_B)$  and  $q^-(\cdot, 1_B)$  in [\[9\]](#page-42-7) is actually the Jordan decomposition since  $q^+(\cdot, 1_B)$  is defined as

$$
q^+(\cdot, \mathbf{1}_B) := \underset{0 \le g \le \mathbf{1}_B}{\text{ess}} q(\cdot, g)
$$

where *g* are measurable functions uniformly bounded on absolute values on the finite measure space  $(T, \mathscr{A}, v)$ s.t.  $g(y) \leq 1_B(y)$ , v-a.e.. Now, since we can approximate any such *g* with indicator functions, namely the set of indicator functions are dense in the set of measurable functions with compact support (in this case *B*) and bounded by 1, then by standard density arguments we can substitute the *g*'s by indicator functions and using the fact that  $q(x, 1_B) = q(x, B)$  v-almost everywhere we have

$$
q^+(\cdot,B):=\sup_{K\subset B}q(\cdot,K)
$$

which is the definition of the positive measure of the Jordan decomposition of the signed measure  $q(x, \cdot)$ . Further, since  $q^-(\cdot,B)$  is defined as  $q^-(\cdot,B) := q^+(\cdot,B) - q(\cdot,B)$  then it coincides with the negative measure of the Jordan decomposition.

Since  $Q(C) = \int_A \int_B \mathbf{1}_C(x,t) \tilde{q}_+(t,dx) \nu(dt) - \int_A \int_B \mathbf{1}_C(x,t) \tilde{q}_-(t,dx) \nu(dt)$ , and  $\int_A \int_B \mathbf{1}_C(x,t) \tilde{q}_+(t,dx) \nu(dt)$  and  $\int_A \int_B \mathbf{1}_C(x,t) \tilde{q}_-(t, dx) v(dt)$  are mutually singular then we have the stated Jordan decomposition of *Q*. □

**Remark 5.18.** *Notice that it is not always true that*  $q^+ = \tilde{q}_+$  *since*  $Q_{0,+}(A,\cdot)$  *and*  $Q_{0,-}(A,\cdot)$  *are not necessarily measures (on the contrary Q*0,+(·,*B*) *and Q*0,−(·,*B*) *are measures since they are the Jordan decomposition of*  $Q_0(\cdot, B)$ . The only thing we know is that  $q_+(x, B) - q_-(x, B) = \tilde{q}_+(x, B) - \tilde{q}_-(x, B)$ , where all the four *functions are positive and with values less or equal than 1. In particular, the fact that*  $q^+(x,B) \leq 1$  *and*  $q^-(x, B) \leq 1$  *for*  $v$ -almost every  $x \in T$  and for every  $B \in \mathcal{B}$  comes from the fact that  $|q(x, B)| \leq 1$  *for every*  $B \in \mathscr{B}$ *.* 

<span id="page-20-0"></span>**Lemma 5.19.** Let F. be as in Proposition [5.15.](#page-19-1) Then there exists a unique finite measure F on  $\mathscr{S} \otimes \mathscr{B}(\mathbb{R})$ *such that*

$$
F(A \times B) = F_A(B)
$$
, for all  $A \in \mathcal{S}, B \in \mathcal{B}(\mathbb{R})$ .

*Moreover, there exists a function*  $\rho : S \times \mathscr{B}(\mathbb{R}) \mapsto [-\infty, \infty]$  *such that* (i)  $\rho(s, \cdot)$  *is a quasi-Lévy type measure on*  $\mathscr{B}(\mathbb{R})$ *, for every s*  $\in$  *S,* (ii)  $\rho(\cdot, B)$  *is a Borel measurable function, for every*  $B \in \mathcal{B}(\mathbb{R})$ *,* (iii)  $\int_{S\times\mathbb{R}}h(s,x)F(ds,dx)=\int_{S}\int_{\mathbb{R}}h(s,x)\rho(s,dx)\lambda(ds)$ , for every  $\mathscr{S}\otimes\mathscr{B}(\mathbb{R})$ -measurable function  $h:S\times\mathbb{R}\mapsto$ [0,∞]*. This equality can be extended to real and complex-valued functions h.*

*Proof.* Using Theorem [5.17,](#page-19-2) we have that  $F_A(B) = F(A \times B) = \int_A q(t, B) v(dt)$  where *q* satisfies point (d) and (e) in that theorem. Since  $\lambda \ll v$ , then defining

$$
\rho_+(s,dx) := \frac{d\mathbf{v}}{d\lambda}(s)\tilde{q}_+(s,dx), \quad \rho_-(s,dx) := \frac{d\mathbf{v}}{d\lambda}(s)\tilde{q}_-(s,dx)
$$

and 
$$
\rho(s, dx) := \rho_+(s, dx) - \rho_-(s, dx)
$$

we have that (ii) is satisfied and that

$$
\int_{\mathbb{R}} (1 \wedge x^{2}) |\rho|(s, dx) = \frac{d\mathbf{v}}{d\lambda}(s) \int_{\mathbb{R}} (1 \wedge x^{2}) \tilde{q}_{+}(s, dx) + \frac{d\mathbf{v}}{d\lambda}(s) \int_{\mathbb{R}} (1 \wedge x^{2}) \tilde{q}_{-}(s, dx)
$$
\n
$$
\leq \frac{d\mathbf{v}}{d\lambda}(s) \int_{\mathbb{R}} \tilde{q}_{+}(s, dx) + \frac{d\mathbf{v}}{d\lambda}(s) \int_{\mathbb{R}} \tilde{q}_{-}(s, dx) \leq \frac{d\mathbf{v}}{d\lambda}(s) + \frac{d\mathbf{v}}{d\lambda}(s) \leq 2,
$$

where the last inequality comes from the fact that we can always assume that  $\frac{dv}{d\lambda}(s) \le 1$  for all *s* (and the same for  $v$ ). This proves (i).

Therefore, we have immediately (iii) since

$$
\int_{S}\int_{\mathbb{R}}\mathbf{1}_{C}(s,x)\rho(s,dx)\lambda(ds)=\int_{S}\int_{\mathbb{R}}\mathbf{1}_{C}(s,x)\tilde{q}(s,dx)\nu(ds)=F(C).
$$

 $\Box$ 

 $\Box$ 

The extension to real and complex integrand follows by standard arguments (*e.g.* see [\[9\]](#page-42-7)).

<span id="page-21-1"></span>**Corollary 5.20.** *Under the setting of Proposition* [5.15,](#page-19-1) we have  $F^+(C) = \int_S \int_{\mathbb{R}} I_C(s,x) \rho^+(s,dx) \lambda(ds)$  and  $F^{-}(C) = \int_{S} \int_{\mathbb{R}} I_{C}(s, x) \rho^{-}(s, dx) \lambda(ds).$ 

*Proof.* First, notice that  $\int_S \int_{\mathbb{R}} \mathbf{1}_C(s,x) \rho^+(s,dx) \lambda(ds)$  and  $\int_S \int_{\mathbb{R}} \mathbf{1}_C(s,x) \rho^-(s,dx) \lambda(ds)$  are measures on  $\mathscr{S} \otimes$  $\mathscr{B}(\mathbb{R})$  and that  $F(C) = \int_S \int_{\mathbb{R}} \mathbf{1}_C(s, x) \rho^+(s, dx) \lambda(ds) - \int_S \int_{\mathbb{R}} \mathbf{1}_C(s, x) \rho^-(s, dx) \lambda(ds)$ . Finally, let  $E_s^+$  and  $E_s^+$ the Hahn decomposition of  $\rho(s, \cdot)$  (which is the same as the one of  $q(s, \cdot)$ ). Define  $C^+ := \{(s, x) \in S \times \mathbb{R} :$  $x \in E_s^+$  and  $C^- := \{(s, x) \in S \times \mathbb{R} : x \in E_s^- \}$ . It is possible to see that  $C^+$  and  $C^-$  form an essential decomposition of  $S \times \mathbb{R}$  and so the measures  $\int_S \int_{\mathbb{R}} \mathbf{1}_C(s,x) \rho^+(s,dx) \lambda(ds)$  and  $\int_S \int_{\mathbb{R}} \mathbf{1}_C(s,x) \rho^-(s,dx) \lambda(ds)$ are singular, thus concluding the proof.

Notice that an alternative proof follows directly from Theorem [5.17](#page-19-2) and Lemma [5.19.](#page-20-0)

Under the same setting as in Proposition [5.15,](#page-19-1) we obtain the following proposition.

<span id="page-21-0"></span>Proposition 5.21. *Under the setting of Proposition [5.15,](#page-19-1) the c.f. of* Λ(*A*) *can be written in the form:*

$$
\mathbb{E}(e^{i\theta\Lambda(A)})=\exp\left(\int_A K(\theta,s)\lambda(ds)\right), \quad \theta\in\mathbb{R}, A\in\mathscr{S},
$$

*where*

$$
K(\theta, s) = i\theta a(s) - \frac{\theta^2}{2}\sigma^2(s) + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta \tau(x)\rho(s, dx),
$$

 $a(s) = \frac{dv_0}{d\lambda}(s)$ ,  $\sigma^2(s) = \frac{dv_1}{d\lambda}(s)$  and  $\rho$  is given by Lemma [5.19,](#page-20-0) and  $exp(K(\theta, s))$  is the characteristic function *of a QID random variable if it exists. Moreover, we have*

$$
|a(s)| + \sigma^2(s) + \frac{d\mathbf{v}}{d\lambda}(s) = 1 \quad \lambda \text{-}a.e.
$$

*Proof.* The first statement follows from the Lévy-Khintchine formulation ([3](#page-4-3)) and Lemma [5.19.](#page-20-0)

The second statement follows from the fact that for every  $A \in \mathcal{S}$ , we have

$$
\int_{A} \left( |a(s)| + \sigma^{2}(s) + \frac{d\mathbf{v}}{d\lambda}(s) \right) \lambda(ds) = |\mathbf{v}_{0}|(A) + \mathbf{v}_{1}(A) + \mathbf{v}(A) = \lambda(A) = \int_{A} d\lambda(ds).
$$

**Proposition 5.22.** Under the setting of Proposition [5.15,](#page-19-1) if f is  $\Lambda$ -integrable, then  $\int_S |K(tf(s),s)| \lambda(ds) < \infty$ , *where K is given in Proposition [5.21,](#page-21-0) and*

$$
\mathscr{L}\left(\int_{S} f d\Lambda\right)(\theta) = \exp\left(\int_{S} K(\theta f(s), s) \lambda(ds)\right), \quad \theta \in \mathbb{R}.
$$

*Proof.* The statement follows from the same arguments used in the proof Proposition [5.9.](#page-15-1)

Differently to Theorem [5.10](#page-15-0) in the following we have directly and if and only if result for the integrability conditions of  $\int_S f dΛ$ .

<span id="page-22-2"></span>**Theorem 5.23.** Let  $f : S \to \mathbb{R}$  be a  $S$ -measurable function and consider the same setting as in Proposition *[5.15.](#page-19-1) Then f is* Λ*-integrable if and only if the following three conditions hold:*  $\int_S |U(f(s),s)| \lambda(ds) < \infty$ , (ii)  $\int_S |f(s)|^2 \sigma^2(s) \lambda(ds) < \infty$ ,

 $\int_{S}V_0(f(s),s)\lambda(ds)<\infty,$ 

where 
$$
U(u,s) = ua(s) + \int_{\mathbb{R}} \tau(xu) - u\tau(x)\rho(s,dx), \quad V_0(u,s) = \int_{\mathbb{R}} (1 \wedge |xu|^2)|\rho|(s,dx),
$$

*Further, if f is* Λ*-integrable, then the c.f. of* R *S f d*Λ *can be written as*  $\hat{\mathcal{L}}\left(\int_{\mathcal{S}} f d\Lambda\right)\left(\theta\right) = \exp\left(i\theta a_f - \frac{1}{2}\right)$  $\frac{1}{2}\theta^2\sigma_f^2 + \int_{\mathbb{R}}e^{i\theta x} - 1 - i\theta\,\tau(x)F_f(dx)\Big),$  where

$$
a_f = \int_S U(f(s), s) \lambda(ds), \quad \sigma_f^2 = \int_S |f(s)|^2 \sigma^2(s) \lambda(ds), \quad \text{and}
$$
  

$$
F_f(B) = F(\{(s, x) \in S \times \mathbb{R} : f(s) \times \{0\}\}), \quad B \in \mathcal{B}(\mathbb{R}).
$$

*Proof.*  $\Leftarrow$ : Under the framework of this section we have that *F* is a finite signed measure (see Lemma [5.19\)](#page-20-0) and so  $\int_{\mathbb{R}}(1\wedge y^2)|\tilde{F}_f|(dy) < \infty$ . Moreover, since *F* is a finite signed measure then by Corollary [5.20](#page-21-1) we have

$$
\int_{S}\int_{\mathbb{R}}(1\wedge|f(s)x|^{2})|\rho|(s,dx)\lambda(ds)\leq\int_{S}\int_{\mathbb{R}}|\rho|(s,dx)\lambda(ds)<\infty.
$$

We conclude this part of the proof with the same arguments used in the proof of Theorem [5.12.](#page-17-0) ⇒: It follows from similar arguments as the ones used in the proof of Theorem [5.10.](#page-15-0)

#### <span id="page-22-0"></span>5.3 The general case

In this section we extend the results presented in the previous section. We will work with the assumption that  $\mathscr S$  is a  $\sigma$ -algebra and that  $F(A, \cdot)$  is a signed measure for every  $A \in \mathscr S$  and  $F(\cdot, B)$  is a signed measure for every  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ . We define for every  $A \in \mathscr{S}$  and  $B \in \mathscr{B}(\mathbb{R})$ 

$$
J(A,B) := \int_B (1 \wedge x^2) F_A(dx)
$$

and notice that it is a signed bimeasure on  $\mathscr{S} \times \mathscr{B}(\mathbb{R})$ . We will assume that

<span id="page-22-1"></span>
$$
\sup_{I} \sum_{i \in I} |J(A_i, B_i)| < \infty. \tag{16}
$$

Informally, the above assumption is weaker than assuming the "total variation" of the signed bimeasure *J* to be finite.

Let us introduce the set function  $\xi(A)$ :  $\mathscr{S} \mapsto [0,\infty)$  such that

$$
\xi(A):=\sup_{I_A}\sum_{i\in I_A}|J(A_i,B_i)|.
$$

Notice that ξ is indeed a measure (see the proof of Theorem 4 in [\[9\]](#page-42-7)). We point out that it might be possible to assume a weaker condition than ([16](#page-22-1)), which is assuming that  $\xi(A)$  is a measure. This is possible by

 $\Box$ 

looking at the proof of Theorem 4 in [\[9\]](#page-42-7). However, for the sake of clarity we keep the assumption ([16](#page-22-1)). Now, let  $E_A^+$  and  $E_A^-$  the Hahn decomposition of R under the signed measure  $F_A$ . Observe that

$$
\xi(A) = \sup_{I_A} \sum_{i \in I_A} |J(A_i, B_i)| \ge \int_{E_A^+} (1 \wedge x^2) F_A(dx) - \int_{E_A^-} (1 \wedge x^2) F_A(dx) = \int_{\mathbb{R}} (1 \wedge x^2) |F_A|(dx). \tag{17}
$$

Therefore, since  $\xi(S)$  is finite by assumption we have that  $\int_{\mathbb{R}} (1 \wedge x^2) |F_A|(dx) < \infty$ .

The name of this section comes from the fact that if  $\mathscr S$  is a  $\sigma$ -algebra then the assumptions on *F* presented in the previous sections (Sections [5.1](#page-10-1) and [5.2\)](#page-18-0), are stricter then the ones of this section. Indeed, for the bounded case, notice that if  $F(A,B)$  is a bimeasure on  $\mathscr{S} \times \mathscr{B}(\mathbb{R})$  and  $\sup \sum_{i \in I} |F_{A_i}(B_i)| < \infty$ , then *F* immediately satisfies the assumptions of this section. For the case of the two generating ID r.m., observe that

$$
\int_B (1 \wedge x^2) F_A(dx) = \int_B (1 \wedge x^2) G_A(dx) - \int_B (1 \wedge x^2) M_A(dx)
$$

and so using the fact  $S \in \mathscr{S}$  (since  $\mathscr{S}$  is a  $\sigma$ -algebra) we have that

$$
\xi(S) = \sup_{I} \sum_{i \in I} |J(A_i, B_i)| \le \sup_{I} \sum_{i \in I} \int_{B_i} (1 \wedge x^2) G_{A_i}(dx) + \int_{B_i} (1 \wedge x^2) M_{A_i}(dx)
$$

$$
\le \int_{\mathbb{R}} (1 \wedge x^2) G_S(dx) + \int_{\mathbb{R}} (1 \wedge x^2) M_S(dx) < \infty
$$

We are now ready to present the first results of this section.

<span id="page-23-0"></span>**Proposition 5.24.** *Let*  $\Lambda$  *be a QID random measure. Let*  $v_0: \mathcal{S} \mapsto \mathbb{R}$  *be a signed measure,*  $v_1: \mathcal{S} \mapsto \mathbb{R}$  *be a measure, F<sub>A</sub> be a quasi-Lévy measure on*  $\mathbb R$  *for every A*  $\in \mathcal S$ ,  $\mathcal S \ni A \mapsto F_A(B) \in (-\infty, \infty)$  *be a signed measure for every*  $B \in \mathscr{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$  *and s.t.*  $(v_0(A), v_1(A), F_A)$  *is the characteristic triplet of*  $\Lambda(A), \forall A \in \mathscr{S}$ *. Assume that F satisfies* ([16](#page-22-1))*. Define*

<span id="page-23-2"></span>
$$
\lambda(A) = |v_0|(A) + v_1(A) + \xi(A). \tag{18}
$$

*Then*  $\lambda : \mathscr{S} \mapsto [0, \infty)$  *is a measure s.t.*  $\lambda(A_n) \to 0$  *implies*  $\Lambda(A_n) \stackrel{p}{\to} 0$  *for every*  $\{A_n\} \subset \mathscr{S}$ .

*Proof.* Since by Theorem 4 in [\[9\]](#page-42-7) we know that  $\xi$  is a measure, it is straightforward to see that  $\lambda(A)$  is a measure. Now, let  $\lambda(A_n) \to 0$  then we have that  $|v_0|$ ,  $v_1$  and  $\xi$  goes to zero. Then since  $\xi(A_n) \to 0$  implies that  $\int_{\mathbb{R}} (1 \wedge x^2) |F_{A_n}|(dx) \to 0$ , then we have that  $\Lambda(A_n) \stackrel{p}{\to} 0$  for every  $\{A_n\} \subset \mathscr{S}$ . □

<span id="page-23-1"></span>**Lemma 5.25.** *Let F. be as in Proposition* [5.24.](#page-23-0) *There exists a function*  $\rho : S \times \mathcal{B}(\mathbb{R}) \mapsto [-\infty, \infty]$  *such that* (i)  $\rho(s, \cdot)$  *is a quasi-Lévy type measure on*  $\mathscr{B}(\mathbb{R})$ *, for every s*  $\in$  *S,* 

(ii) the positive and negative part of  $\rho(\cdot,B)$ , denoted by  $\rho^+(\cdot,B)$  and  $\rho^-(\cdot,B)$  are Borel measurable functions, *for every*  $B \in \mathscr{B}(\mathbb{R})$ ,

*Moreover, there exist two unique*  $\sigma$ -finite measures  $F^+$  and  $F^-$  on  $\mathscr{S} \otimes \mathscr{B}(\mathbb{R})$  s.t.  $\int_{S\times\mathbb{R}}h(s,x)F^+(ds,dx)$  $\int_S\int_\mathbb{R} h(s,x)\rho^-(s,dx)\lambda(ds)$ , for every  $\mathscr{S}\otimes\mathscr{B}(\mathbb{R})$ -measurable function  $h:S\times\mathbb{R}\mapsto[0,\infty]$ , and the same holds *for F<sup>−</sup>. This equality can be extended to real and complex-valued functions h. Finally, for every A*  $\in \mathcal{S}$  *and* for every  $\mathscr{B}(\mathbb{R})$ -measurable real function g s.t.  $\int_A \int_{\mathbb{R}} g(x) |\rho|(s,dx) \lambda(ds) < \infty$ , we have that

$$
\int_{\mathbb{R}} g(x) F_A(dx) = \int_A \int_{\mathbb{R}} g(x) \rho(s, dx) \lambda(ds),
$$

*and for every*  $B \in \mathcal{B}(\mathbb{R})$  *s.t.*  $0 \notin \overline{B}$ ,

$$
\tilde{F}^+(A,B) \geq F_A^+(B)
$$
 and  $\tilde{F}^-(A,B) \geq F_A^-(B)$ .

*Proof.* First, notice that  $J(A, B)$  satisfies the assumptions of Theorem [5.17](#page-19-2) with  $(T, \mathscr{A}) = (S, \mathscr{S})$  and  $(X, \mathscr{B}) =$  $(\mathbb{R},\mathscr{B}(\mathbb{R}))$ . Therefore, there exists a finite signed measure *Q* on the product  $\sigma$ -algebra  $\mathscr{S}\otimes\mathscr{B}(\mathbb{R})$  such that

$$
Q(A \times B) = J(A, B) = \int_A q(s, B) \xi(ds) = \int_A \tilde{q}^+(s, B) \xi(ds) - \int_A \tilde{q}^-(s, B) \xi(ds),
$$

where *q* satisfies (*d*) and (*e*) of Proposition 2.4 in [\[23\]](#page-43-0). Since  $\lambda \gg \xi$ , define

$$
\rho_+(s,dx) := \frac{d\xi}{d\lambda}(s)(1\wedge x^2)^{-1}\tilde{q}_+(s,dx), \quad \text{and} \quad \rho_-(s,dx) := \frac{d\xi}{d\lambda}(s)(1\wedge x^2)^{-1}\tilde{q}_-(s,dx).
$$

Notice that

$$
\int_{\mathbb{R}} (1 \wedge x^2) \rho^+(s, dx) = \frac{d\xi}{d\lambda}(s) \int_{\mathbb{R}} \tilde{q}^+(s, dx) \le 1,
$$

where the last inequality comes from the fact that we can always assume that  $\frac{d\xi}{d\lambda}(s) \le 1$  for all  $s \in S$ . Hence,  $\rho^+(s, \cdot)$  is a Lévy measure on R for all  $s \in S$ . The same is true for  $\rho^-(s, \cdot)$ . Further, let

 $\rho(s, B) := \rho_+(s, B) - \rho_-(s, B)$  for all  $s \in S, B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$ .

Then  $\rho(s, \cdot)$  is a quasi-Lévy type measure, thus obtaining (i). Using the fact that  $\rho_+(s, B)$  and  $\rho_-(s, B)$  are mutually singular for every  $B \in \mathcal{B}(\mathbb{R})$  s.t.  $\overline{B}$ , we obtain (ii). Now, let

$$
\tilde{F}^+(C) = \int_S \int_{\mathbb{R}} \mathbf{1}_C(s, x) \rho^+(s, dx) \lambda(ds),\tag{19}
$$

where  $C \in \mathscr{S} \otimes \mathscr{B}(\mathbb{R})$ , then  $\tilde{F}^+$  is a well defined signed measure that satisfies, for every  $A \in \mathscr{S}$  and  $B \in$  $\mathscr{B}(\mathbb{R}),$ 

$$
\tilde{F}^+(A \times B) = \int_A \int_B \rho^+(s, dx) \lambda(ds) = \int_A \int_B (1 \wedge x^2)^{-1} q^+(s, dx) \xi(ds) \n= \int_{A \times B} (1 \wedge x^2)^{-1} Q^+(ds, dx) \ge \int_B (1 \wedge x^2)^{-1} J_+(A, dx) = \int_B F_A^+(dx) = F_A^+(B),
$$

where we recall that the notation  $M_+$  and  $M_-$  for a bimeasure stands for the Jordan decomposition of  $M(A, B)$ for fixed *A*. Finally, notice that for any  $\mathscr{B}(\mathbb{R})$ -measurable real function *g* s.t.  $\int_A \int_{\mathbb{R}} g(x) |\rho|(s, dx) \lambda(ds) < \infty$ we have

$$
\int_A \int_{\mathbb{R}} g(x) \rho(s, dx) \lambda(ds) \n= \int_A \int_{\mathbb{R}} g(x) \rho^+(s, dx) \lambda(ds) - \int_A \int_{\mathbb{R}} g(x) \rho^-(s, dx) \lambda(ds) \n= \int_{A \times \mathbb{R}} g(x) (1 \wedge x^2)^{-1} Q(ds, dx) = \int_{\mathbb{R}} g(x) (1 \wedge x^2)^{-1} J(A, dx) = \int_{\mathbb{R}} g(x) F_A(dx).
$$

Using the above results, we obtain the following proposition.

<span id="page-24-0"></span>Proposition 5.26. *Under the setting of Proposition [5.24,](#page-23-0) the c.f. of* Λ(*A*) *can be written in the form:*

$$
\mathbb{E}(e^{i\theta\Lambda(A)})=\exp\left(\int_A K(\theta,s)\lambda(ds)\right),\quad \theta\in\mathbb{R}, A\in\mathscr{S},
$$

*where*

$$
K(\theta, s) = i\theta a(s) - \frac{\theta^2}{2}\sigma^2(s) + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta \tau(x)\rho(s, dx),
$$

 $a(s) = \frac{dv_0}{d\lambda}(s)$ ,  $\sigma^2(s) = \frac{dv_1}{d\lambda}(s)$  and  $\rho$  is given by Lemma [5.25,](#page-23-1) and  $exp(K(\theta, s))$  is the characteristic function *of a QID random variable if it exists. Moreover, we have*

$$
|a(s)| + \sigma^2(s) + \frac{d\xi}{d\lambda}(s) = 1, \qquad \lambda \text{-}a.e.
$$

*Proof.* The first statement follows from the Lévy-Khintchine formulation ([3](#page-4-3)) and Lemma [5.25.](#page-23-1)

The second statement follows from the fact that for every  $A \in \mathscr{S}$ , we have

$$
\int_A \left( |a(s)| + \sigma^2(s) + \frac{d\xi}{d\lambda}(s) \right) \lambda(ds) = |v_0|(A) + v_1(A) + \xi(A) = \lambda(A) = \int_A d\lambda(ds).
$$

**Proposition 5.27.** Under the setting of Proposition [5.24,](#page-23-0) if f is  $\Lambda$ -integrable, then  $\int_S |K(tf(s),s)| \lambda(ds) < \infty$ , *where K is given in Proposition [5.26,](#page-24-0) and*

$$
\mathscr{L}\left(\int_{S} f d\Lambda\right)(\theta) = \exp\left(\int_{S} K(\theta f(s), s) \lambda(ds)\right), \quad \theta \in \mathbb{R}.
$$

*Proof.* The statement follows from the same arguments used in the proof of Proposition [5.9.](#page-15-1)

 $\Box$ 

□

We state now the main theorem of this subsection on the integrability conditions of  $\int_S f dΛ$ .

<span id="page-25-2"></span>**Theorem 5.28.** Let  $f : S \to \mathbb{R}$  be a  $S$ -measurable function and consider the setting of Proposition [5.24.](#page-23-0) *Then f is* Λ*-integrable if the following three conditions hold:*

 $\int_S |U(f(s),s)| \lambda(ds) < \infty$ , (ii)  $\int_S |f(s)|^2 \sigma^2(s) \lambda(ds) < \infty$ ,  $\int_{S}V_0(f(s),s)\lambda(ds)<\infty,$ 

where 
$$
U(u,s) = ua(s) + \int_{\mathbb{R}} \tau(xu) - u\tau(x)\rho(s,dx), \quad V_0(u,s) = \int_{\mathbb{R}} (1 \wedge |xu|^2)|\rho|(s,dx).
$$

*Further, the c.f. of* R *S f d*Λ *can be written as*  $\hat{\mathcal{L}}\left(\int_{\mathcal{S}} f d\Lambda\right)\left(\theta\right) = \exp\left(i\theta a_f - \frac{1}{2}\right)$  $\frac{1}{2}\theta^2\sigma_f^2 + \int_{\mathbb{R}}e^{i\theta x} - 1 - i\theta\,\tau(x)F_f(dx)\Big)$ , where  $a_f =$  $\int_S U(f(s),s)\lambda(ds), \quad \sigma_f^2 = \int$  $\int_{S} |f(s)|^2 \sigma^2(s) \lambda(ds)$ , and

 $F_f(B)$  is the unique quasi-Lévy measure determined by the difference of the Lévy measures  $\tilde{F}_f^+$  and  $\tilde{F}_f^-$ , *which are defined as: for every*  $B \in \mathcal{B}(\mathbb{R})$ 

$$
\tilde{F}_f^+(B) = \tilde{F}^+(\{(s,x) \in S \times \mathbb{R} : f(s)x \in B \setminus \{0\}\}) \text{ and } \tilde{F}_f^-(B) = \tilde{F}^-(\{(s,x) \in S \times \mathbb{R} : f(s)x \in B \setminus \{0\}\}).
$$

*Proof.* It follows from similar arguments as the ones used in the proof of Theorem [5.10.](#page-15-0)

#### <span id="page-25-0"></span>5.4 The symmetric case

We conclude this section with a discussion on the symmetric case, namely the case where  $\bar{\Lambda}(A) = \Lambda(A)$  –  $\Lambda'(A)$  and  $\Lambda'(A)$  is an independent copy of  $\Lambda(A)$ . We start with the following general lemma.

<span id="page-25-1"></span>**Lemma 5.29.** Let  $\mu$  be a QID distribution. Then, the symmetrisation and the dual of  $\mu$  are QID distributions.

*Proof.* The dual is straightforward. Regarding the symmetrisation, we have  $|\mu|^2 = \mu * \tilde{\mu}$ , where  $\tilde{\mu}$  denotes the dual of  $\mu$ . Since the class of QID distributions is closed under convolution (see Remark 2.6 of [\[15\]](#page-42-0)), then  $|\mu|^2$  is QID.  $\Box$ 

Then, we have the following result in the framework of Section [5.2.](#page-18-0)

**Proposition 5.30.** *Let*  $\bar{\Lambda}(A) = \Lambda(A) - \Lambda'(A)$  *where*  $\Lambda'(A)$  *is an independent copy of*  $\Lambda(A)$  *for every*  $A \in \mathcal{S}$ *. Then,* Λ¯ *is a QID random measure. Further, under the setting of Proposition [5.15,](#page-19-1) for an arbitrary function*  $f : S \mapsto \mathbb{R}$ , *f* is  $\overline{\Lambda}$ *-integrable if and only if it is*  $\Lambda$ *-integrable.* 

□

*Proof.* By Lemma [5.29](#page-25-1) we have that  $\bar{\Lambda}(A)$  is a QID r.v. fore every  $A \in \mathcal{A}$ . Moreover, using the notations used before and Proposition 2.5 in [\[26\]](#page-43-2), we have that

$$
\mathscr{L}(\bar{\Lambda}(A))(\theta) = |\mathscr{L}(\Lambda(A))(\theta)|^2 = \exp\left(-\theta^2 v_1(A) + 2 \int_{\mathbb{R}} \cos(\theta x) - 1 F_A(dx)\right)
$$

$$
= \exp\left(\int_A \left(-\theta^2 \sigma^2(s) + 2 \int_{\mathbb{R}} \cos(\theta x) - 1 \rho(s, dx)\right) \lambda(ds)\right).
$$

Then, by applying Theorem [5.23](#page-22-2) we obtain the stated result.

Remark 5.31. *An "if" result for the framework of Section [5.1](#page-10-1) is also possible if f is* Λ*<sup>G</sup> and* Λ*<sup>M</sup> integrable, where*  $\Lambda_G$  *and*  $\Lambda_M$  *are the ID r.m. that generate*  $\Lambda$ *.* 

## <span id="page-26-0"></span>6 Continuity of the stochastic integral mapping

In this section we are going to explore the set of Λ-integrable functions and show a continuity property of the linear the stochastic integral mapping  $f \to \int_S f d\Lambda$  from this space into the  $L_p$  space (more precisely to  $L_p(\Omega, \mathbb{P})$ ). In particular, the space of integrable function is a subset of the corresponding Musielak-Orlicz modular space defined in Chapter III of [\[23\]](#page-43-0). We begin with some preliminaries. Let  $q \in [0, \infty)$ . Consider the following condition:

$$
\mathbb{E}[|\Lambda(A)|^q] < \infty, \qquad \text{for all } A \in \mathcal{S}.
$$

Observe that for  $q = 0$  every  $\Lambda$  satisfies this condition. Throughout this section, we shall assume that the above condition is satisfied. Further, we assume that for all  $s \in S$ 

<span id="page-26-1"></span>
$$
\int_{|x|>1} |x|^q \rho^+(s, dx) < \infty. \tag{20}
$$

.

 $\Box$ 

From the arguments in the previous section we have that

$$
\int_A \int_{|x|>1} |x|^q \rho^+(s,dx) \lambda(ds) \ge \int_{|x|>1} |x|^q F_A^+(dx)
$$

and then by Theorem 6.2 point (a) in [\[15\]](#page-42-0) the assumption [\(20\)](#page-26-1) implies that

$$
\int_{|x|>1}|x|^qF_A^-(dx)<\infty\quad\text{and}\quad\int_{\mathbb{R}}|x|^q\mathscr{L}(\Lambda(A))(dx)<\infty.
$$

Observe that while Theorem 6.2 point (a) in [\[15\]](#page-42-0) is stated for the centering function  $\tau(x) = x\mathbf{1}_{|x| \leq 1}$ , the result holds for any centering function since the proof is based on results on ID distributions with no restrictions on the choice of the centering function (see Theorem 25.3 of [\[26\]](#page-43-2)).

Now, define, for  $0 \le p \le q$ ,  $u \in \mathbb{R}$  and  $s \in S$ ,

<span id="page-26-2"></span>
$$
\Phi_p(u,s) = U^*(u,s) + u^2 \sigma^2(s) + V_p(u,s),
$$
\n(21)

where

$$
U^*(u,s) = \sup_{|c| \le 1} |U(cu,s)| \quad \text{and} \quad V_p(u,s) = \int_{\mathbb{R}} |xu|^p \mathbf{1}_{|xu|>1}(x) + |xu|^2 \mathbf{1}_{|xu| \le 1}(x) |\rho|(s,dx).
$$

In the following lemma, which is an equivalent of Lemma 3.1 in [\[23\]](#page-43-0) in our framework, we abuse the notation and consider  $\lambda$  to take all the different formulations it has taken in this work, namely ([7](#page-10-2)), ([14](#page-19-3)) and ([18](#page-23-2)).

#### Lemma 6.1. *The following are satisfied:*

(i) *for every s*  $\in$  *S*,  $\Phi_p(\cdot, s)$  *is a continuous non-decreasing function on*  $[0, \infty)$  *with*  $\Phi_p(0, s) = 0$ *,* (ii)  $\lambda({s : \Phi_p(u, s) = 0 \text{ for some } u = u(s) \neq 0}) = 0$ , (iii) *there exists a constant*  $C > 0$  *such that*  $\Phi_p(2u, s) \leq C \Phi_p(u, s)$ *, for all*  $u \geq 0$  *and*  $s \in S$ *.* 

*Proof.* Points (i) and (iii) are proved adapting the same arguments of the proof of the points (i) and (iii) of Lemma 3.1 in [\[23\]](#page-43-0) to our framework. We sketch them for the sake of completeness. First, it is easy to prove that, for any fixed *s*,  $U(\cdot, s)$  is continuous and so that  $U^*(\cdot, s)$  is continuous. Then by dominated convergence theorem, we obtain the continuity of  $\Phi_p(\cdot, s)$ . Further, notice that  $U^*(\cdot, s)$  is non-decreasing and that

<span id="page-27-0"></span>
$$
|ux|^p I(|ux|>1) + |xu|^2 I(|xu| \le 1) = \begin{cases} (|xu|^p \wedge |xu|^2) & \text{if } 0 \le p \le 2, \\ (|xu|^p \vee |xu|^2) & \text{if } p > 2. \end{cases}
$$
(22)

is increasing in  $x \ge 0$ . To prove (iii) observe that from [\(22\)](#page-27-0) and Lemma [5.11](#page-16-0) we have

$$
\Phi_p(2u,s) \le 2|U(u,s)| + 27V_0(u,s) + 4u^2\sigma^2(s) + (2^p + 4)V_p(u,s) \le (2^p + 31)\Phi_p(u,s).
$$

To prove point (ii) we proceed as follow. Recall that we have different formulations of  $\lambda$ . If  $\Phi_p(u,s) = 0$  for some  $u = u(s) \neq 0$  then  $\sigma^2(s) = 0$ ,  $|\rho|(s, \mathbb{R}) = 0$  and  $U(u, s) = 0$ . The last two equalities imply that  $a(s) = 0$ . Thus,

$$
S_0 := \{ s : \Phi_p(u, s) = 0 \text{ for some } u = u(s) \neq 0 \} = \{ s : a(s) = \sigma^2(s) = |\rho|(s, \mathbb{R}) = 0 \},
$$

which shows also that  $S_0$  is a measurable set. Let *A* be any measurable set in  $S_0$  and notice that  $v_0(A)$  =  $\int_A a(s)\lambda(ds) = 0$ , hence we obtain that  $|v_0|(S_0) = 0$ .

Now, observe that given the above arguments we have that

$$
\int_{S_0} \int_{\mathbb{R}} (1 \wedge |x|^2) |\rho|(s, dx) \lambda(ds) = 0,
$$
  

$$
\nu(S_0) = \sup_{I_{S_0}} \sum_{i \in I_{S_0}} |F_{A_i}(B_i)| = \sup_{I_{S_0}} \sum_{i \in I_{S_0}} \left| \int_{A_i} \int_{B_i} \rho(s, dx) \lambda(ds) \right| = 0,
$$

and

$$
\xi(S_0) = \sup_{I_{S_0}} \sum_{i \in I_{S_0}} |\int_{B_i} (1 \wedge x^2) F_{A_i}(dx)| = \sup_{I_{S_0}} \sum_{i \in I_{S_0}} \left| \int_{A_i} \int_{B_i} (1 \wedge x^2) \rho(s, dx) \lambda(ds) \right| = 0.
$$

□

Therefore, we get (in its different formulations) that  $\lambda(S_0) = 0$ .

**Lemma 6.2.** *Let*  $\{\mu_n\}$  *be a sequence of QID probability distributions on*  $\mathbb R$  *with c.t.*  $(a_n, \sigma_n, G_n)$ *. Let*  $a_n \to 0$ *,*  $\sigma_n^2 \to 0$  ad  $\int_{\mathbb{R}} (1 \wedge |x|^2) |G_n|(dx) \to 0$ . Assume that  $\int_{|x|>1} |x|^b |G_n|(dx) < \infty$  for all  $n \in \mathbb{N}$ . Then, for every  $b > 0$ ,

$$
\int_{|x|>1}|x|^b|G_n|(dx)\to 0\Rightarrow \int_{\mathbb{R}}|x|^b\mu_n(dx)\to 0.
$$

*Proof.* For every  $n \in \mathbb{N}$ , let  $\mu_n^+$  and  $\mu_n^-$  the ID distributions with c.t.  $(a_n, \sigma_n^2, G_n^+)$  and  $(0, 0, G_n^-)$  respectively. Then, from Lemma 3.2 in [\[23\]](#page-43-0) we obtain that

$$
\int_{|x|>1} |x|^b G_n^+(dx) \to 0 \Rightarrow \int_{\mathbb{R}} |x|^b \mu_n^+(dx) \to 0.
$$

and

$$
\int_{|x|>1} |x|^b G_n^-(dx) \to 0 \Rightarrow \int_{\mathbb{R}} |x|^b \mu_n^-(dx) \to 0.
$$

Now, for every  $n \in \mathbb{N}$ , let  $X_n$ ,  $X_n^+$  and  $X_n^-$  be the real valued r.v. with distributions  $\mu_n$ ,  $\mu_n^+$  and  $\mu_n^-$ , respectively; thus,  $X_n + X_n^- \stackrel{d}{=} X_n^+$  with  $X_n$  and  $X_n^-$  independent. Notice that for  $b \le 1$  we have

$$
\mathbb{E}[|X_n|^b] \le \mathbb{E}[|X_n + X_n^{-}|^b] + \mathbb{E}[|X_n^{-}|^b] = \mathbb{E}[|X_n^{+}|^b] + \mathbb{E}[|X_n^{-}|^b]
$$

while for  $b > 1$  we have

$$
\mathbb{E}[|X_n|^b] \leq \lceil b \rceil \left( \mathbb{E}[|X_n + X_n^-|^{[b]}] + \mathbb{E}[|X_n^-|^{[b]}] \right) = \lceil b \rceil \left( \mathbb{E}[|X_n^+|^{[b]}] + \mathbb{E}[|X_n^-|^{[b]}] \right)
$$

where  $\lceil b \rceil$  stands for the lowest natural number greater than *b*. Finally, by sending  $n \to \infty$  we obtain the stated result. □

Before presenting the main result of this section, we need some preliminaries. Define the Musielak-Orlicz space as in [\[23\]](#page-43-0):

$$
L_{\Phi_p}(S;\lambda) = \left\{ f \in L_0(S;\lambda): \int_S \Phi_p(|f(s)|,s) \lambda(ds) < \infty \right\}.
$$

The space  $L_{\Phi_p}(S; \lambda)$  is a complete linear metric space with the *F*-norm defined by

$$
||f||_{\Phi_p} = \inf_{c>0} \left\{ \int_S \Phi_p(c^{-1}|f(s)|,s) \lambda(ds) \leq c \right\}.
$$

Simple functions are dense in  $L_{\Phi_p}(S;\lambda)$  and  $L_{\Phi_p}(S;\lambda) \hookrightarrow L_0(S;\lambda)$  is continuous, where in the present case  $L_0(S; \lambda)$  is equipped with the topology of convergence in  $\lambda$  measure on every set of finite  $\lambda$ -measure. More- $\text{over, } \|f_n\|_{\Phi_p} \to 0 \Leftrightarrow \int_S \Phi_p(|f(s)|,s)\lambda(ds) \to 0.$ 

We remark that the above definitions and results hold both in the case  $\lambda$  is atomless and when it is not (see Chapter III of [\[23\]](#page-43-0) and Musielak's book [\[17\]](#page-42-10)).

**Theorem 6.3.** *Let*  $0 \le p \le q$  *and*  $\Phi_p$  *defined as in* ([21](#page-26-2))*. Then* 

$$
\left\{f: f \text{ is } \Lambda\text{-integrable and } \mathbb{E}\left[\left|\int_{S} f d\Lambda\right|^{p}\right] < \infty\right\} \supset L_{\Phi_{p}}(S; \lambda)
$$

*and the linear mapping*

$$
L_{\Phi_p}(S;\lambda) \ni f \mapsto \int_S f d\Lambda \in L_p(\Omega; \mathbb{P})
$$

*is continuous.*

**Remark 6.4.** *When*  $p = 0$  *the statement becomes*  $\{f : f \text{ is } \Lambda\text{-integrable}\}\supset L_{\Phi_0}(S; \lambda)$ .

*Proof.* We partially follow the proof of Theorem 3.3 in [\[23\]](#page-43-0). Let  $f \in L_{\Phi_p}(S; \lambda)$ , which is equivalent to consider  $\int_S \Phi_p(|f(s)|, s) \lambda(ds) < \infty$ . The conditions (i), (ii) and (iii) of Theorem [5.28](#page-25-2) (and also Theorems [5.10,](#page-15-0) [5.12](#page-17-0) and [5.23\)](#page-22-2) are satisfied. Then, we have that

$$
\int_{\{|u|>1\}} |u|^p |F_f|(du) \le \int_S \int_{\{|f(s)x|>1\}} |f(s)x|^p |\rho|(s, dx)\lambda(ds)
$$
  

$$
\le \int_S V_p(|f(s)|, s)\lambda(ds) \le \int_S \Phi_p(|f(s)|, s)\lambda(ds) < \infty.
$$

Hence, thanks to Theorem 6.2 point (a) in [\[15\]](#page-42-0) we have that  $\mathbb{E}[\left| \int_S f d\Lambda \right|^p] < \infty$ .

 $\Box$ 

## <span id="page-29-0"></span>7 Spectral representation of generated QID processes

In this section we are going to introduce QID stochastic processes, and present various spectral representation for generated QID processes (see Theorem [7.3](#page-29-1) below). We start with the definition of QID processes.

<span id="page-29-2"></span>**Definition 7.1** (QID processes). Let T be an arbitrary index set. A stochastic process  $X = \{X_t; t \in T\}$  is said *to be a QID* process *if and only if for every finite set of indices*  $t_1, \ldots, t_k$  *in the index set T* 

$$
X_{t_1,\ldots,t_k}:=(X_{t_1},...,X_{t_k})
$$

*is a multivariate QID random variable.*

The existence of QID processes is ensured by the Kolmogorov extension theorem. From Definition [7.1,](#page-29-2) it is clear that the class of QID processes is strictly larger than the class of ID processes.

Before presenting other results we introduce some preliminaries. We use the general framework introduced in [\[25\]](#page-43-7). Let *T* be an arbitrary (possibly uncountable) index set,  $\mathbb{R}^T$  denote the space of all functions *x* :  $T \to \mathbb{R}$  and  $\mathscr{B}^T$  be its cylindrical product  $\sigma$ -algebra. Given an underlying probability space  $(\Omega, \mathscr{F}, \mathbb{P})$ , for a stochastic process  $X = (X_t)_{t \in T}$  we define its law  $\mathscr{L}(X)$  as a probability measure on  $(\mathbb{R}^T, \mathscr{B}^T)$  such that

$$
\mathscr{L}(X)(A) = \mathbb{P}(\{\boldsymbol{\omega} \in \Omega : (X_t(\boldsymbol{\omega}))_{t \in T} \in A\}), \quad A \in \mathscr{B}^T
$$

We denote by  $x_S$  the restriction of  $x$  to  $S \subset T$  and by  $0_S$  the origin of  $\mathbb{R}^S$ , which depending on the setting is a point or a one-point set. Further, we let  $\hat{T}$  to be defined as  $\hat{T}:=\{I\subset T: 0<\text{Card}(I)<\infty\},$  let  $\pi_S:\mathbb{R}^T\to \mathbb{R}^S$ be the projection from  $\mathbb{R}^T$  onto  $\mathbb{R}^S$  (namely  $\pi_S(x) = x_S$ ) and let  $\mathcal{B}_{00}^S := \{B \in \mathcal{B}^S : 0_S \notin B\}$ . Finally, we uses as a cutoff function the bounded measurable function  $\chi$  defined as  $\chi : \mathbb{R} \to \mathbb{R}$  such that  $\chi(v) = 1 + o(|v|)$ as  $v \to 0$  and  $\chi(v) = O(|v|^{-1})$  as  $|v| \to \infty$ . Then, the truncation of  $v = (v_1, ..., v_n) \in \mathbb{R}^n$  is defined by  $[[v]] =$  $(v_1 \chi(|v_1|),...,v_n \chi(|v_n|))$  and of  $x \in \mathbb{R}^S$  by  $[[x]](s) = x(s) \chi(|x(s)|), s \in S$ . Let  $\{v_I : I \in \hat{T}\}$  be a family of finite dimensional Lévy measures on  $(\mathbb{R}^J, \mathscr{B}^J)$  s.t. for every  $I, J \in \hat{T}$  with

*I* ⊂ *J*

$$
v_J \circ \pi_{IJ}^{-1} = v_I \text{ on } \mathscr{B}_{00}^I,
$$

where  $\pi_{IJ} : \mathbb{R}^J \to \mathbb{R}^I$  is the natural projection. Then we say that  $\{v_I : I \in \hat{T}\}\$ is *consistent* (see Definition 2.6 in [\[25\]](#page-43-7)). Moreover, we say that a family of probability measures is *projective* if the above condition is satisfied on the whole  $\mathcal{B}^S$  (and not just on  $\mathcal{B}^I_{00}$ ).

The first result of this section concerns a general property of QID distributions.

#### <span id="page-29-3"></span>Proposition 7.2. *All the marginal distributions of a multivariate QID distribution are QID.*

*Proof.* Let  $d \in \mathbb{N}$  and  $X = (X_1, ..., X_d)$  be QID. Then there exists at least two ID r.v. *Y* and *Z* s.t.  $X + Y \stackrel{d}{=} Z$ . Consider any  $I \subset \{1, ..., d\}$ . Let  $\theta = (\theta_1, ..., \theta_d) \in \mathbb{R}^d$  be s.t.  $\theta_i = 0$  for  $i \notin I$  and let  $\theta_I \in \mathbb{R}^I$  containing all the non-zero element of <sup>θ</sup>. Then

<span id="page-29-4"></span>
$$
\hat{\mathcal{L}}(X_I)(\theta_I) = \hat{\mathcal{L}}(X)(\theta) = \frac{\hat{\mathcal{L}}(Z)(\theta)}{\hat{\mathcal{L}}(Y)(\theta)} = \frac{\hat{\mathcal{L}}(Z_I)(\theta_I)}{\hat{\mathcal{L}}(Y_I)(\theta_I)}.
$$
\n(23)

Thus, we obtain the stated results by Theorem 3.1 in [\[8\]](#page-42-11), namely by the fact that all the marginal distributions of a multivariate ID distribution are ID. □

Recall from Proposition 3.2 in [\[12\]](#page-42-12) that for two stochastic processes  $X^{(1)}$  and  $X^{(2)}$  we have that  $X^{(1)} \stackrel{d}{=}$  $X^{(2)}$  if and only if  $(X^{(1)}_{t_1},...,X^{(1)}_{t_k}) \stackrel{d}{=} (X^{(2)}_{t_1},...,X^{(2)}_{t_k})$  where  $t_1,...,t_k \in T$  and  $k \in \mathbb{N}$ . We have the following simple result.

<span id="page-29-1"></span>**Theorem 7.3.** Let T be an arbitrary index set. A stochastic process  $X = \{X_t; t \in T\}$  is QID if there exist two *ID processes Y and Z such that*  $X + Y \stackrel{d}{=} Z$  with Y independent of X. In this case, we say that X is generated *by Y and Z and that X is a* generated QID process

*Proof.* Let *X* be a stochastic process and let *Y* and *Z* two ID processes s.t.  $X + Y \stackrel{d}{=} Z$  with *Y* independent of *X*. Consider any finite set of indices  $t_1, ..., t_k$  in the index set *T*. Since  $(Y_{t_1}, ..., Y_{t_k})$  and  $(Z_{t_1}, ..., Z_{t_k})$  are ID distributed,  $(X_{t_1},...,X_{t_k})$  is QID distributed. Then by definition the process  $X = \{X_t; t \in T\}$  is QID.

We sometimes also say that *Y* and *Z* are the *generating ID process of X*. Moreover, we remark that while for any given two ID processes there exist a unique QID process (when it exists), it might happen that for a given QID processes there exist more than just two generating ID processes. We present now the main question left open from this work.

Open Question 7.4. *Is it true that any QID process is generated by two ID processes? In other words, is it true that any QID process is a generated QID process?*

The answer of this question is not trivial. It lies on the capacity of building canonical ID distributions from QID distributions and it involves the use of the axiom of choice. In particular, the axiom of choice is used to show the existence of a family of ID probability measures (actually there exist uncountably many such families). Then, in order to use the Kolmogorov extension theorem we need to show that this family of probability measures is consistent. However, despite Proposition [7.2](#page-29-3) and equation [\(23\)](#page-29-4), which provide consistency for each finite set of indices, it is not clear how to obtain the result as shown in the following example.

**Example 7.5.** *Consider the c.t. of a QID r.v.*  $X = (X_1, X_2)$  *on*  $\mathbb{R}^2$  *given by*  $(\gamma, \theta, v)$ *. Let*  $(\gamma_1, \theta_1, v_1)$  *and*  $(\gamma_2, \theta_2, \nu_2)$  *the c.t. of*  $X_1$  *and*  $X_2$ *. Hence, from Proposition* [7.2](#page-29-3) *we have*  $v_1(A) = v((A, \mathbb{R}))$  *and*  $v_2(B) = v(A, \mathbb{R})$  $v((\mathbb{R},B))$  *for every*  $A,B \in \mathscr{B}_{00}(\mathbb{R})$ . Assume that the quasi-Lévy measures are signed measures and consider their Jordan decomposition. For example let  $E_1^+$  and  $E_2^+$  be the Hahn decomposition of  $\R$  under the signed *measure*  $v_1$  *and assume* w.l.o.g. that  $\{0\} \notin E_1^+$ . Then,  $0 \le v_1^+(\mathbb{R}) = v_1(E_1^+) = v((E_1^+, \mathbb{R}))$ . Applying the same *argument to*  $v_2$  *we have that*  $0 \le v_2^+(\mathbb{R}) = v_2(E_2^+) = v((\mathbb{R}, E_2^+))$ *. Then we have that*  $(E_1^+, \mathbb{R}) \cup (\mathbb{R}, E_2^+)$ *is a subset of* R <sup>2</sup> *where* <sup>ν</sup> *is positive. On the other hand by applying the same arguments we have that*  $(E_1^- \setminus \{0\}, \mathbb{R}) \cup (\mathbb{R}, E_2^+ \setminus \{0\})$  *is a subset of*  $\mathbb{R}^2$  *where v is negative. But these two sets have intersections,* which means that the marginals of the Jordan decompositions of  $v$  (call them  $v^+$  and  $v^-$  with marginals  $\tilde{v}_1^+$ ,  $\tilde{v}_2^+$ ,  $\tilde{v}_1^-$  and  $\tilde{v}_2^-$ ) are s.t.  $v_1^+(\mathbb{R}) = v_1(E_1^+) = v((E_1^+, \mathbb{R})) \le v^+((E_1^+, \mathbb{R})) \le v^+((\mathbb{R}, \mathbb{R})) = \tilde{v}_1^+(\mathbb{R})$ , where the last equality comes from the fact that  $v^+$  is a Lévy measure of a ID r.v. whose marginals exist and are ID *thanks to Theorem 3.1 in [\[8\]](#page-42-11). A similar result hold for the other cases.*

*This implies that the projection of*  $v^+$  *is not always*  $v_1^+$ *, and similarly for*  $v^-$ *. In other words, the positive* and negative part of a quasi-Lévy measure are always not consistent (and, hence, projective). Hence, given  $X + Y \stackrel{d}{=} Z$  where  $Z = (Z_1, Z_2)$  and  $Y = (Y_1, Y_2)$  are two ID r.v. on  $\mathbb{R}^2$  with quasi-Lévy measures  $V^+$  and ν <sup>−</sup> *respectively, it is not always true that Z*<sup>1</sup> *and Y*<sup>1</sup> *have quasi-Levy measure given by the positive and ´ negative part of* <sup>ν</sup>1*, and similarly for Z*<sup>2</sup> *and Y*2*. Therefore, a family of ID probability measures where each probability measure has the Lévy measure given by the positive (or negative) part of the quasi-Lévy measure of the respective QID probability measure is not always projective.*

For the moment let index set *T* to be countable. Let  $\mathcal{B}^{l_2}$  be the Borel  $\sigma$ -algebra on *l*<sub>2</sub>. We note that since  $l_2$  is separable the Borel and cylindrical  $\sigma$ -algebras coincide (see page 38 in [\[14\]](#page-42-13)). Then, we have the following definition.

<span id="page-30-0"></span>**Definition 7.6** (quasi-Lévy type measure on  $(l_2, \mathcal{B}^{l_2})$ ). Let  $\mathcal{B}_r^{l_2} := \{B \in \mathcal{B}^{l_2} | B \cap \{x \in l_2 : ||x|| < r\} = \emptyset\}$  and  $\mathscr{B}_0^{l_2} := \bigcup_{r>0} \mathscr{B}_r^{l_2}$ . Let  $v : \mathscr{B}_0^{l_2} \to \mathbb{R}$  be a set function s.t.  $v_{|\mathscr{B}_r^{l_2}}$  is a finite signed measure for each  $r > 0$  and *denote the total variation, positive and negative part of*  $v_{\vert \mathscr{B}_r^{\downarrow}}$  *by*  $|v_{\vert \mathscr{B}_r^{\downarrow}}|$ *,*  $v_{\vert \mathscr{B}_r^{\downarrow}}^+$ <sup>+</sup> and **ν**<sup>−</sup><br>|B<sup>l2</sup></sub> and **ν**<sup>−</sup> |B *l*2 *r respectively. Then the* total variation |ν|*, the* positive part <sup>ν</sup> <sup>+</sup> *and the* negative part <sup>ν</sup> <sup>−</sup> *of* <sup>ν</sup> *are defined to be the unique measures on*  $(l_2, \mathcal{B}^{l_2})$  *satisfying*

|\nu(\{0_T\})| = \nu^+(\{0_T\}) = \nu^-(\{0_T\}) = 0
$$

and 
$$
|v|(A) = |v_{|\mathcal{B}_r^{\prime 2}}|, v^+(A) = v^+_{|\mathcal{B}_r^{\prime 2}}(A), v^-(A) = v^-_{|\mathcal{B}_r^{\prime 2}}(A),
$$

*for*  $A \in \mathcal{B}_r^{l_2}$ *, for some r* > 0*.* 

*A* quasi-Lévy type measure on  $(l_2, \mathscr{B}^{l_2})$  *is a function*  $v : \mathscr{B}_0^{l_2} \to \mathbb{R}$  *with the above properties and s.t.*  $\int_{l_2}(1\wedge$  $||x||^2$ )| $v|(dx) < \infty$ .

**Lemma 7.7.**  $\mathcal{B}_r^{l_2}$  is a σ-algebra.

*Proof.* Since the space  $Y_r := \{x \in l_2 : ||x|| \ge r\}$  is a non-empty subspace of  $l_2$  then we have  $Z_r := \{B \subseteq Y_r | B \in$  $\mathscr{B}^{l_2}$  =  $\mathscr{B}_r^{l_2}$ . Observe now that  $Y_r$  is measurable (namely  $Y_r \in \mathscr{B}^{l_2}$ ) because  $l^2$  is a complete separable metric space and the norm is continuous, then  $Z_r$  is the restriction of  $\mathcal{B}^{l_2}$  on  $Y_r$ . Hence,  $\mathcal{B}^{l_2}_r$  is a  $\sigma$ -algebra and the argument applies to any  $r > 0$ . П

If  $v : \mathcal{B}_0^{l_2} \to \mathbb{R}$  is s.t.  $v_{|\mathcal{B}_r^{l_2}}$  is a finite signed measure for each  $r > 0$ , then we have that  $|v_{|\mathcal{B}_r^{l_2}}|(A) =$  $|V_{\mathcal{B}_s^{\mathcal{B}_2}}|(A)$  for every  $A \in \mathcal{B}_r^{\mathcal{B}_2}$  with  $0 < s \leq r$  and the same applies to  $V_{\mathcal{B}_s}^+$  $\big| \mathcal{B}_r^l$  and  $v^-$ <br> $\big| \mathcal{B}_r^l$  $\int_{\mathbb{R}^{l_2}}^{\mathbb{R}^l}$ . Moreover, since we are in the countable framework (the index set considered *T* is countable since  $l_2 \subset \mathbb{R}^N$  hence  $0_T \in \mathcal{B}^{l_2}$ ) then |v|, v<sup>+</sup> and v<sup>-</sup> are well defined and the condition  $|v({0})| = v^+({0}) = v^-({0}) = 0$  together with the Carath´eodory's extension theorem ensure their uniqueness. Notice that we have the equivalent of Lemma [3.1](#page-5-2) in this framework.

<span id="page-31-0"></span>**Lemma 7.8.** A set function  $v : \mathcal{B}_0^{l_2} \to \mathbb{R}$  is a quasi-Lévy type measure if and only if there exist two Lévy *measures*  $v^{(1)}$  *and*  $v^{(2)}$  *s.t.*  $v_{|\mathscr{B}_r(\mathbb{R})}(A) = v^{(1)}_{|\mathscr{A}|}$  $\frac{\mathcal{L}^{(1)}}{|\mathscr{B}^l_r}(A)-\mathcal{V}_{|\mathscr{B}^l_r}^{(2)}$  $\frac{d^{(2)}}{d\mathbb{F}_r^{l_2}}(A)$  *for*  $A \in \mathcal{B}_r^{l_2}$ *, for some r* > 0*. Moreover, v is unique.*

*Proof.* It follows from the same arguments used in the proof of Lemma [3.1.](#page-5-2)

We have the following representation of a certain QID processes.

<span id="page-31-2"></span>Theorem 7.9. Let X be a discrete parameter QID process with values in  $l_2$  *s.t. there exist two generating ID processes with values in l<sub>2</sub>. Then there exists an unique triplet*  $(z_0, \mathcal{K}, v)$  *consisting of*  $z_0 \in l_2$ *, a non-negative definite function operator*  $\mathscr{K}: l_2 \to \mathbb{R}$  *and a quasi-Lévy type measure*  $\mathsf{v}$  *on*  $(l_2, \mathscr{B}^{l_2})$  *s.t.*

$$
\mathscr{L}(X)(y) = \exp\left(i\langle z_0, y \rangle - \frac{1}{2}\langle y, \mathscr{K}y \rangle + \int_{l_2} \left(e^{i\langle y, x \rangle} - 1 - i\langle \tau(x), y \rangle\right) v(dx)\right)
$$
(24)

 $\Box$ 

*where*  $y \in l_2$ *.* 

*Proof.* Since *X*, *Y* and *Z* are *l*<sub>2</sub>-valued stochastic processes, then they can be seen as three r.v. on  $(l_2, \mathcal{B}^{l_2})$ , with the property that  $X + Y \stackrel{d}{=} Z$  with *Y* independent of *X*. Now, let  $v^{(1)}$  and  $v^{(2)}$  be the Lévy measures of the  $l_2$  valued ID processes  $Z$  and  $Y$ , respectively. Then, we have

$$
\mathscr{L}(X)(y) = \mathscr{L}(Z)(y)/\mathscr{L}(Y)(y) = \exp\left(i\langle z_0, y \rangle -\frac{1}{2}\langle y, \mathscr{K}y \rangle + \int_{l_2} \left(e^{i\langle y, x \rangle} - 1 - i\langle \tau(x), y \rangle\right) v^{(1)}(dx) - \int_{l_2} \left(e^{i\langle y, x \rangle} - 1 - i\langle \tau(x), y \rangle\right) v^{(2)}(dx)\right)
$$

Let  $v : \mathscr{B}_0^{\prime_2} \to \mathbb{R}$  be a set function s.t.  $v_{\vert \mathscr{B}_r^{\prime_2}}(A) = v_{\vert \mathscr{B}_r^{\prime}}^{(1)}$  $\frac{1}{|\mathscr{B}^l_r}(A)-\mathcal{V}_{|\mathscr{B}^l_r}^{(2)}$  $\big|\frac{\mathscr{B}}{\mathscr{B}_r^l}(A) \big|$  for every  $A \in \mathscr{B}_r^{l_2}$  with  $r > 0$ . Then by Lemma [7.8,](#page-31-0) v is uniquely determined by the difference  $v^{(1)} - v^{(2)}$ . Indeed the absence of uniqueness of  $v^{(1)} - v^{(2)}$  will violate the condition  $X + Y = Z$  due to the uniqueness of the Lévy-Khintchine representation on *l*<sup>2</sup> (see Theorem 4.10 Chapter 4 in [\[20\]](#page-43-8)). Hence, we obtain the expression [\(24\)](#page-31-1). Finally, it directly follows that  $z_0$  and  $\mathscr K$  are uniquely determined.  $\Box$  **Theorem 7.10.** *Conversely for every*  $(z_0, \mathcal{K}, v)$  *as above there exists a QID process with values in*  $l_2$ *.* 

*Proof.* It is enough to see that the positive and negative part of v, namely  $v^+$  and  $v^-$ , are Lévy measures on  $\mathcal{B}^{l_2}$ . Hence, we can extract two ID processes with values in  $l_2$ . Then, these two processes generate a QID with values in  $l_2$ .  $\Box$ 

Open Question 7.11. *In Theorem [7.9](#page-31-2) we have the condition that discrete parameter QID process with values in l*<sup>2</sup> *must be generated by two generating ID processes with values in l*2*. In order to get rid of this condition we need to prove that for every discrete parameter QID process with values in l<sub>2</sub> <i>there exist two generating ID processes with values in l*2*. Is this possible?*

#### <span id="page-32-0"></span>7.1 Lévy-Khintchine representation of generated QID processes

In this section we are going to investigate the representation of generated QID processes. For the first result we will assume that the quasi-Lévy measure of QID processes, whose definition is going to be provided below, is a signed measure. This situation happens when one of the two generating ID processes has a finite Lévy measure (see Definition 2.1 in [\[25\]](#page-43-7)). This is because in that case  $v = v_1 - v_2$  is a signed measure. On the other hand, the second result concerns general generated QID processes.

We introduce now the definition of quasi-Lévy type measure in this framework.

**Definition 7.12.** A signed measure  $v$  on  $(\mathbb{R}^T, \mathcal{B}^T)$  is said to be a quasi-Lévy type measure if the following *two conditions hold*

 $(QL1)$  *for every t*  $\in$  *T we have*  $\int_{\mathbb{R}^T} |x(t)|^2 \wedge 1 |v|(dx) < \infty$ ,

 $(QL2)$  *for every*  $A \in \mathscr{B}^T$  *we have*  $|v(A)| = v_*^+(A \setminus 0_T) + v_*^-(A \setminus 0_T)$ *, where*  $v_*^+$  *and*  $v_*^+$  *are the inner measures of the Jordan decomposition of* <sup>ν</sup>*.*

We can present now the first main result of this section, namely the Lévy-Khintchine formulation of QID processes with quasi-Lévy measure being a signed measure.

<span id="page-32-2"></span>**Theorem 7.13.** Let T be an arbitrary index set and let  $X = (X_t)_{t \in T}$  be a QID process s.t. there exists two of *generating ID process with one having finite Lévy measure. Then there exists a unique triplet*  $(\Sigma, \nu, b)$  *where*  $\Sigma$  *is a non-negative definite function on*  $T \times T$ ,  $\nu$  *is a quasi-Lévy type measure on*  $(\mathbb{R}^T, \mathscr{B}^T)$  *and a function*  $b \in \mathbb{R}^T$  s.t. for every  $I \in \hat{T}$  and  $\theta \in \mathbb{R}^I$ 

<span id="page-32-1"></span>
$$
\hat{\mathscr{L}}(X_I)(\theta) = \exp\left(i\langle \theta, b_I \rangle - \frac{1}{2}\langle \theta, \Sigma_I \theta \rangle + \int_{\mathbb{R}^T} (e^{i\langle \theta, x_I \rangle} - 1 - i\langle \theta, [[x_I]] \rangle) v(dx)\right),\tag{25}
$$

*where* Σ*<sup>I</sup> is the restriction of* Σ *to I* × *I. The triplet* (Σ,ν,*b*) *is called the generating triplet of X and* <sup>ν</sup> *the quasi-Levy measure of X. ´*

*Proof.* Let  $X^1$  and  $X^2$  the ID processes generating X, with one having finite Lévy measure, and denote by  $v^{(1)}$  and  $v^{(2)}$  the respective Lévy measures on  $(\mathbb{R}^T, \mathscr{B}^T)$ . Let  $v := v^{(1)} - v^{(2)}$ . Then v is a well-defined signed measure on  $(\mathbb{R}^T, \mathcal{B}^T)$ . Moreover, we have for *I*  $\in \hat{T}$ 

$$
\hat{\mathscr{L}}(X_I) = \frac{\hat{\mathscr{L}}(X_I^1)}{\hat{\mathscr{L}}(X_I^2)} = \exp\left(i\langle \theta, b_I \rangle - \frac{1}{2}\langle \theta, \Sigma_I \theta \rangle \right)
$$

$$
+ \int_{\mathbb{R}^T} (e^{i\langle \theta, x_I \rangle} - 1 - i\langle \theta, [[x_I]] \rangle) v^{(1)}(dx) - \int_{\mathbb{R}^T} (e^{i\langle \theta, x_I \rangle} - 1 - i\langle \theta, [[x_I]] \rangle) v^{(2)}(dx) \right)
$$

$$
= \exp\left(i\langle \theta, b_I \rangle - \frac{1}{2}\langle \theta, \Sigma_I \theta \rangle + \int_{\mathbb{R}^T} (e^{i\langle \theta, x_I \rangle} - 1 - i\langle \theta, [[x_I]] \rangle) v(dx) \right),
$$

which gives [\(25\)](#page-32-1). From the above we also deduce that the  $v \circ \pi_I^{-1} = v_I$  on  $\mathcal{B}_{00}^I$ ,  $I \in \hat{T}$ , where  $v_I$  is the quasi-Lévy measure of *X*<sub>*I*</sub>.

Notice that  $\forall t \in T$  we have that  $\int_{\mathbb{R}^T} |x(t)|^2 \wedge 1 |v|(dx) \leq \int_{\mathbb{R}^T} |x(t)|^2 \wedge 1 v^{(1)}(dx) + \int_{\mathbb{R}^T} |x(t)|^2 \wedge 1 v^{(2)}(dx) < \infty$ . Now let  $v^+_*$  and  $v^+_*$  are the inner measures of the Jordan decomposition of v. Since for every  $A \in \mathcal{B}^T$  we have that  $v^{(1)}(A) = v^{(1)}_*(A \setminus 0_T)$  and  $v^{(2)}(A) = v^{(2)}_*(A \setminus 0_T)$ , and  $v^{(1)}(A) \ge v^+(A) = v^+(A)$  and  $v^{(2)}(A) \ge v^+(A)$  $v^-(A) = v^-(A)$  then  $|v(A)| = v^+(A \setminus 0_T) + v^-(A \setminus 0_T)$ . Therefore, v is a quasi-Lévy measure on  $(\mathbb{R}^T, \mathcal{B}^T)$ and, additionally,  $v^+$  and  $v^-$  are Lévy measures on  $(\mathbb{R}^T, \mathcal{B}^T)$ . In particular, notice that  $v_I^+ = v^+ \circ \pi^{-1}$  and  $v_I^- = v^- \circ \pi^{-1}$  are Lévy measures such that  $v_I(A) = v_I^+(A) - v_I^-(A)$  for every  $A \in \mathcal{B}(\mathbb{R})$ , for  $I \in \hat{T}$  (although it is not necessarily true that  $v_I^+$  and  $v_I^-$  are mutually singular on  $(\mathbb{R}^I, \mathcal{B}(\mathbb{R}^I))$ .

Let us prove uniqueness. Notice that the arguments used in the proof of Lemma [3.1,](#page-5-2) which were applicable for the  $(\mathbb{R}^d, \mathscr{B}(\mathbb{R}^d))$  and  $(l_2, \mathscr{B}^{l_2})$  cases, do not apply here due to the different topological framework. Assume that there exists another quasi-Lévy type measure  $\tilde{v}$  on  $(\mathbb{R}^T, \mathscr{B}^T)$  (hence  $\tilde{v}^+$  and  $\tilde{v}^-$  are two Lévy measures on  $(\mathbb{R}^T, \mathcal{B}^T)$ ) s.t.

<span id="page-33-0"></span>
$$
\hat{\mathscr{L}}(X_I) = \exp\left(i\langle\theta,b_I\rangle - \frac{1}{2}\langle\theta,\Sigma_I\theta\rangle + \int_{\mathbb{R}^T} (e^{i\langle\theta,x_I\rangle} - 1 - i\langle\theta,[[x_I]]\rangle)\tilde{v}(dx)\right),\tag{26}
$$

but with  $\tilde{v} \neq v$ . Notice that [\(26\)](#page-33-0) together with the uniqueness of quasi-Lévy measures imply that  $v_I =$  $\tilde{\mathbf{v}} \circ \pi_I^{-1} =: \tilde{\mathbf{v}}_I$  on  $\mathcal{B}_{00}^I$ ,  $I \in \hat{T}$ , and that there exists a QID process  $\tilde{X}$  with c.t.  $(\Sigma, \tilde{\mathbf{v}}, b)$  s.t.  $\tilde{X} \stackrel{d}{=} X$ .

However, observe that since  $\tilde{v} \neq v$  then  $\tilde{v}^+ - \tilde{v}^- \neq v^+ - v^-$ . Recall that by Corollary 2.9 that for every c.t.  $(\Sigma, \mu, b)$  where  $\mu$  is a Lévy measures there exist a unique (in distribution) ID process. Let  $b^{(1)}$  and  $b^{(2)}$ two functions in  $\mathbb{R}^T$  s.t.  $b = b^{(1)} - b^{(2)}$  and let  $(\Sigma, v^+, b^{(1)})$ ,  $(0, v^-, b^{(2)})$ ,  $(\Sigma, \tilde{v}^+, b^{(1)})$  and  $(0, \tilde{v}^-, b^{(2)})$  the c.t. of the ID processes *Z*, *Y*,  $\tilde{Z}$  and  $\tilde{Y}$ , respectively. Then observe that  $X - Y \stackrel{d}{=} Z$  and  $\tilde{X} - \tilde{Y} \stackrel{d}{=} \tilde{Z}$ . Moreover, we have that, for every  $I \in \hat{T}$ ,

$$
\frac{\hat{\mathcal{L}}(Z_I)}{\hat{\mathcal{L}}(Y_I)} = \frac{\hat{\mathcal{L}}(\tilde{Z}_I)}{\hat{\mathcal{L}}(\tilde{Y}_I)} \Rightarrow \hat{\mathcal{L}}(Z_I)\hat{\mathcal{L}}(\tilde{Y}_I) = \hat{\mathcal{L}}(\tilde{Z}_I)\hat{\mathcal{L}}(Y_I). \tag{27}
$$

Now, let  $v_I^{Z\tilde{Y}} := v_I^+ + \tilde{v}_I^-$  and  $v_I^{\tilde{Z}Y} := \tilde{v}_I^+ + v_I^-$ . It is possible to see that  $\{v_I^{\tilde{Z}Y} : I \in \hat{T}\}\$  and  $\{v_I^{Z\tilde{Y}} : I \in \hat{T}\}\$ two consistent families of Lévy measures. Hence, they generate two unique Lévy measures  $v^{ZY}$  and  $v^{Z\tilde{Y}}$  on  $(\mathbb{R}^T, \mathscr{B}^T)$ . Observe that  $v^+ + \tilde{v}^-$  and  $\tilde{v}^+ + v^-$  are two Lévy measure on  $(\mathbb{R}^T, \mathscr{B}^T)$  because the sum of two Lévy measures on  $(\mathbb{R}^T, \mathscr{B}^T)$  is still a Lévy measure. Since  $v^{ZY} \circ \pi_I^{-1} = v_I^{\tilde{Z}Y} = \tilde{v}_I^+ + v_I^- = (v^+ + \tilde{v}^-) \circ \pi_I^{-1}$ *I* Every *I* ∈  $\hat{T}$  and by the uniqueness of Lévy measures on ( $\mathbb{R}^T$ ,  $\mathcal{B}^T$ ), we conclude that  $v^{\tilde{Z}Y} = v^+ + \tilde{v}^-$  and  $\tilde{V}$ similarly that  $v^{Z\tilde{Y}} = \tilde{v}^+ + v^-$ . However, from [\(27\)](#page-33-1) we have that  $v^{Z\tilde{Y}} = v^{ZY}_I$  which implies that  $v^+ + \tilde{v}^ \tilde{v}^+ + v^-$ , hence a contradiction to  $\tilde{v}^+ - \tilde{v}^- \neq v^+ - v^-$  and, so, to  $\tilde{v} \neq v$ .  $\Box$ 

Another way of proving the uniqueness when v is finite is the following. Let  $\lambda_I := v_I - \tilde{v}_I = 0$  on  $\mathscr{B}_0(\mathbb{R}^I), I \in \hat{T}$ . Observe that  $\{\lambda_I : I \in \hat{T}\}$  forms a consistent family of Lévy measures. Then by uniqueness of Lévy measures on  $(\mathbb{R}^T, \mathscr{B}^T)$  (see Theorem 2.8 and Corollary 2.9 in [\[25\]](#page-43-7)) we have that  $\lambda \circ \pi_L^{-1} = \lambda_I = 0$ and in particular  $\lambda = 0$ . Moreover, following Theorem 2.8 in [\[25\]](#page-43-7) for any other measure  $\rho$  on  $(\mathbb{R}^T, \mathscr{B}^T)$  such that  $\rho \circ \pi_I^{-1} = \lambda_I = 0$  we have that  $\rho \ge \lambda$ , hence  $\rho \ge 0$ . Hence, whenever  $v - \tilde{v}$  defines a measure (which is true for example when either v or  $\tilde{v}$  is finite) we have  $v - \tilde{v} \ge 0 \Rightarrow v \ge \tilde{v}$ . However, we may apply the same arguments to  $\bar{\lambda}_I := \tilde{v}_I - v_I = 0$ , concluding that  $v - \tilde{v} \ge 0 \Rightarrow v \ge \tilde{v} \Rightarrow v = \tilde{v}$ .

# Theorem 7.14. *Conversely for every* (Σ,ν,*b*) *as in Theorem [7.13](#page-32-2) there exists a QID process which is unique in distribution.*

*Proof.* It is enough to see that the positive and negative part of v, namely  $v^+$  and  $v^-$ , are Lévy measures on  $(\mathbb{R}^T, \mathcal{B}^T)$ . Hence, we can extract two ID processes which in turn generate a QID process which is unique in distribution.  $\Box$ 

From the arguments used in the previous result we have the following Lévy-Khintchine representation of general QID processes, namely the QID equivalent of Theorem 2.8 in [\[25\]](#page-43-7).

**Theorem 7.15.** Let T be an arbitrary index set and let  $X = (X_t)_{t \in T}$  be a generated QID process. Then there *exists a triplet*  $(\Sigma, (v^+, v^-), b)$  *where*  $\Sigma$  *and b are as in the Theorem* [7.13](#page-32-2) *and*  $(v^+, v^-)$  *is a couple of Lévy*  $measure$  on  $(\mathbb{R}^T,\mathscr{B}^T)$  s.t. for every  $I \in \hat{T}$  and  $\theta \in \mathbb{R}^D$ 

$$
\hat{\mathscr{L}}(X_I) = \exp\left(i\langle \theta, b_I \rangle - \frac{1}{2} \langle \theta, \Sigma_I \theta \rangle \right)
$$

$$
+ \int_{\mathbb{R}^T} (e^{i\langle \theta, x_I \rangle} - 1 - i\langle \theta, [[x_I]] \rangle) v^+(dx) - \int_{\mathbb{R}^T} (e^{i\langle \theta, x_I \rangle} - 1 - i\langle \theta, [[x_I]] \rangle) v^-(dx)\right).
$$
(28)

□

 $(\Sigma, (v^+, v^-), b)$  *is called the generating triplet of X, and it is unique up to other couples of Lévy measures*  $(v^Y, v^Z)$  of ID processes that generate X. Conversely for every  $(\Sigma, (v^+, v^-), b)$  as above there exists a QID *process which is unique in distribution.*

*Proof.* It follows from the same arguments used in the proof of Theorem [7.13.](#page-32-2)

**Remark 7.16.** The reason why we have the uniqueness "up to other couples of Lévy measures  $(v^Y, v^Z)$  of *ID processes that generate X" is because given two ID processes, say Y and Z, that generate X we cannot exclude that there exist two other ID processes, say*  $\bar{Y}$  *and*  $\bar{Z}$  *that generate. In other words, there might exist four (or more) Lévy measures call them*  $v^Y$ ,  $v^Z$ ,  $v^Y$  *and*  $v^Z$  *corresponding to*  $Y$ ,  $Z$ ,  $\bar{Y}$  *and*  $\bar{Z}$ , *respectively*, *s.t. for every*  $I \in \hat{T}$  and  $\theta \in \mathbb{R}^I$ 

$$
\int_{\mathbb{R}^T} (e^{i\langle \theta, x_l \rangle} - 1 - i\langle \theta, [[x_l]] \rangle) v^Z(dx) - \int_{\mathbb{R}^T} (e^{i\langle \theta, x_l \rangle} - 1 - i\langle \theta, [[x_l]] \rangle) v^Y(dx)
$$
  
= 
$$
\int_{\mathbb{R}^T} (e^{i\langle \theta, x_l \rangle} - 1 - i\langle \theta, [[x_l]] \rangle) \overline{v}^Z(dx) - \int_{\mathbb{R}^T} (e^{i\langle \theta, x_l \rangle} - 1 - i\langle \theta, [[x_l]] \rangle) \overline{v}^Y(dx).
$$

Notice that  $v := v^+ - v^-$  might not be defined for two reasons. First, because we might have  $\infty - \infty$ . Second because we cannot apply the arguments used for the definitions of the quasi-Lévy measures on  $(\mathbb{R}^d, \mathscr{B}(\mathbb{R}^d))$  or on  $(l_2, \mathscr{B}^{l_2})$  (see Definitions [2.5](#page-2-0) and [7.6\)](#page-30-0).

Open Question 7.17. *It is not possible to extend the arguments applied to the definition of quasi-Lévy type measure in* R *<sup>d</sup> or in l*2*, because the restrictions do not form* <sup>σ</sup>*-algebras. However it might be possible to still obtain a sensible definition of quasi-Lévy type measure on*  $\mathbb{R}^T$  without necessarily being a signed measure. *In other words, is it possible to obtain a triplet from the above quadruplet?*

#### <span id="page-34-0"></span>7.2 Spectral representation of discrete parameters QID processes

Before presenting the result we need some preliminaries. Let  $X = \{X_n : n = 1, 2, ...\}$  be a discrete parameters QID process with generating ID processes *Y* and *Z*; let  $b_n > 0$  be s.t.  $\{b_n X_n\}, \{b_n Y_n\}, \{b_n Z_n\} \in l_2$  almost surely. Let  $\mathcal{L}(\{b_nX_n\}) \sim (z_0, \mathcal{K}, M)$ , where  $z_0 \in l_2, \mathcal{K}$  is the covariance operator and *M* is the quasi Lévy measure of  $\mu$ . Notice that since  $X + Y \stackrel{d}{=} Z$  then  $\{b_n X_n\} + \{b_n Y_n\} \stackrel{d}{=} \{b_n Z_n\}$ , which implies that  $\{b_n Y_n\}$  with c.t.  $(z_0^{(Y)}$  $\mathcal{U}_{0}^{(Y)}, \mathcal{K}^{(Y)}, M^{(Y)}$  and  $\{b_n Z_n\}$  with c.t.  $(z_0^{(Z)})$  $\mathcal{X}^{(Z)}_0, \mathcal{X}^{(Z)}_0, M^{(Z)}$  are such that  $z_0 = z_0^{(Z)} - z_0^{(Y)}$  $\mathcal{X}^{(Y)}$ ,  $\mathcal{K} = \mathcal{K}^{(Z)}$  –  $\mathscr{K}^{(Y)}$  and *M* is uniquely generated by  $M^{(Z)}$  and  $M^{(Y)}$ . However, notice that we can consider w.l.o.g. that  ${b_nZ_n} \sim (0, \mathcal{K}, M^{(Z)})$  and  ${b_nY_n} \sim (-z_0, 0, M^{(Y)})$ . This is because of the following argument. Let *Q* and *R* be two *l*<sub>2</sub> ID process with c.t.  $(0, \mathcal{K}, M^{(Z)})$  and  $(-z_0, 0, M^{(Y)})$ , thus,  $\{b_n X_n\} - R \stackrel{d}{=} Q$ . Then, we have that  $X - \{b_n^{-1}R_n\} \stackrel{d}{=} \{b_n^{-1}Q_n\}$ , and that  $\{b_n^{-1}R_n\}$  and  $\{b_n^{-1}Q_n\}$  are ID (where the latter can be seen from their finite dimensional distributions). Therefore, throughout this section for any discrete parameters QID process we consider such generating ID processes.

Let us continue with the preliminaries. For every  $y \in l_2$ , we have that

$$
\mathscr{K}(y) = \sum_{j=1}^\infty \beta_j \langle e_j, y \rangle e_j,
$$

where  $\beta_j \geq 0$ ,  $\sum_{j=1}^{\infty} \beta_j < \infty$  and  $\{e_j\}$  is an orthonormal set in *l*<sub>2</sub>. Moreover, let

$$
v_0 = \begin{cases} ||z_0||\delta_{(z_0/||z_0||)} & \text{if } z_0 \neq 0, \\ 0 & \text{if } z_0 = 0, \end{cases} \quad \text{and} \quad v_1 = \sum_{j=1}^{\infty} \beta_j \delta_{(e_j)}
$$

to be two finite measures on  $\mathscr{B}(\partial U)$ . Let us recall and reformulate Lemma 4.1 and Proposition 4.2 in [\[23\]](#page-43-0)

Proposition 7.18 (Part of Lemma 4.1 and of Proposition 4.2 in [\[23\]](#page-43-0)). *Let M be a Lévy measure on l*<sub>2</sub>, let ∂*U be the boundary of the unit ball in*  $l_2$  *and let*  $\Psi$  *be the map*  $\Psi$  :  $\partial U \times \mathbb{R}^+ \to l_2 \setminus \{0\}$  *s.t.*  $\Psi(u,x) = xu$ . Then *F* is a unique measure on  $\mathscr{B}(\partial U \times \mathbb{R}^+)$  satisfying

$$
M = F \circ \psi^{-1}.
$$

*Moreover, let*  $F_A(\cdot) = F(A \times \cdot)$ *. Then*  $F_A(\cdot)$  *can be naturally extended to*  $\mathbb R$  *and is a Lévy measure on*  $\mathbb R$ *.* 

*Proof.* See Lemma 4.1, Proposition 4.2 and the preliminaries of Section VI in [\[23\]](#page-43-0).

 $\Box$ 

From the above we let  $F_A^{(Z)}$  $F_A^{(Z)}$  and  $F_A^{(Y)}$  $A^{(Y)}_A$  be the unique Lévy measures associated with  $M^{(Z)}$  and  $M^{(Y)}$ , for every  $A \in \mathcal{B}(\partial U)$ . Let  $F_A$  be the unique quasi-Lévy type measure generated by  $F_A^{(Z)}$  $F_A^{(Z)}$  and  $F_A^{(Y)}$  $A^{(1)}$ . Let  $\Lambda_Z$  and  $\Lambda_Y$  be the associate ID random measure of *Z* and *Y*, namely  $\Lambda_Z \sim (0, v_1, F^{(Z)}_z)$  and  $\Lambda_Y \sim (-v_0, 0, F^{(Y)}_z)$ . Similarly we have the following definition.

**Definition 7.19.** *Let X, v*<sub>0</sub>, *v*<sub>1</sub> *and F be as above, then the QID random measure on*  $\mathcal{B}(\partial U)$  *with parameters*  $(v_0, v_1, F)$  *will be called* the associated QID random measure of *X*, *if it exists. Let us denote it by*  $\Lambda$ .

Observe that the control measure  $\lambda$  of  $\Lambda$  is given by  $\lambda(A) = v_0(A) + v_1(A) + \int_{\mathbb{R}} (1 \wedge x^2) F_A^{(Z)} + \int_{\mathbb{R}} (1 \wedge x^2) F_A$  $(x^2) F_A^{(Y)}$  $A_A^{(Y)}$  for every  $A \in \mathscr{B}(\partial U)$ . Moreover, denote by  $\pi_j$  the *j*-th coordinate projection in *l*<sub>2</sub>. We can now finally present the main result of this section.

<span id="page-35-0"></span>**Theorem 7.20.** *Let*  $X = \{X_n\}$  *be a discrete parameters QID process and consider its two generating discrete parameters ID processes Y and Z as above. Then, assuming that*  $\{\int_{\partial U} f_n dΛ\}_{n∈\mathbb{N}}$  *is independent of X, we have*

$$
\{X_n\}_{n\in\mathbb{N}} - \left\{ \int_{\partial U} f_n d\Lambda \right\}_{n\in\mathbb{N}} \stackrel{d}{=} \left\{ \int_{\partial U} f_n d\Lambda_Z \right\}_{n\in\mathbb{N}}.
$$

*Moreover, if the associated QID random measure of X exists then fn's are* Λ*-integrable and*

<span id="page-35-2"></span>
$$
\{X_n\}_{n\in\mathbb{N}} \stackrel{d}{=} \left\{ \int_{\partial U} f_n d\Lambda \right\}_{n\in\mathbb{N}}.
$$
 (29)

*Proof.* Observe that thanks to Theorem 4.9 in [\[23\]](#page-43-0) for any fixed  $k \in \mathbb{N}$  and  $a_1, ..., a_k \in \mathbb{R}$  we have that

$$
\mathscr{L}\left(\sum_{j=1}^k a_j b_n X_n\right) = \frac{\mathscr{L}\left(\sum_{j=1}^k a_j b_n Z_n\right)}{\mathscr{L}\left(\sum_{j=1}^k a_j b_n Y_n\right)} = \frac{\mathscr{L}\left(\sum_{j=1}^k a_j \int_{\partial U} f_j d\Lambda_Z\right)}{\mathscr{L}\left(\sum_{j=1}^k a_j \int_{\partial U} f_j d\Lambda_Y\right)}
$$

Thus, we obtain first statement. For the second we have that  $f_n$ 's are integrable thanks to [5.12,](#page-17-0) where notice that Λ*<sup>G</sup>* and Λ*<sup>M</sup>* there are Λ*<sup>Z</sup>* and Λ*<sup>Y</sup>* here. Moreover, thanks to Proposition [5.13](#page-18-3) we have that for any fixed  $k \in \mathbb{N}$  and  $a_1, ..., a_k \in \mathbb{R}$  we have that

$$
\frac{\mathscr{L}\left(\sum_{j=1}^k a_j \int_{\partial U} f_j d\Lambda_Z\right)}{\mathscr{L}\left(\sum_{j=1}^k a_j \int_{\partial U} f_j d\Lambda_Y\right)} = \mathscr{L}\left(\sum_{j=1}^k a_j \int_{\partial U} f_j d\Lambda\right),\,
$$

hence, obtaining the result.

<span id="page-35-1"></span>Open Question 7.21. *Is it possible to show that for every discrete parameters QID process there exists a QID r.m. s.t. we have the representation* ([29](#page-35-2))*? In other words for every X there exists a* Λ *s.t.* ([29](#page-35-2)) *holds?*

 $\Box$ 

#### <span id="page-36-0"></span>7.3 Further results and examples of QID processes

We move now to the presentation of additional results on QID processes and of some examples. Recall that a process *X* is QID if  $X + X^{(2)} \stackrel{d}{=} X^{(1)}$  where  $X^{(2)}$  and  $X^{(1)}$  are ID processes with  $X^2$  independent of *X*. From this we have many examples. However, let us start with some results.

The first idea that might come to mind is: If  $X^{(2)}$  and  $X^{(1)}$  are Lévy processes is *X* a QID process without being an ID process? The answer is negative, as shown in the following result.

**Proposition 7.22.** Let  $X^{(1)}$  and  $X^{(2)}$  be two Lévy processes with generating triplets  $(a^{(1)}, \sigma^{(1)}, v^{(1)})$  and  $(a^{(2)}, \sigma^{(2)}, v^{(2)})$ . Let X be a stochastic process independent of  $X^{(2)}$ . The equality  $X_t + X_t^{(2)} \stackrel{d}{=} X_t^{(1)}$  for every  $t \geq 0$  *holds only if*  $\sigma^{(1)} \geq \sigma^{(2)}$  and  $v^{(1)} \geq v^{(2)}$ . In this case  $X_t$  is an ID r.v. for every  $t \geq 0$ .

*Proof.* If  $\sigma^{(1)} < \sigma^{(2)}$  then  $X_1$  will not be a random variable. If  $v^{(1)} < v^{(2)}$  then  $X_t$  is a QID r.v. for every *t*  $\geq$  0 without being ID. But then, for every *n* we would have that  $X_{\frac{1}{n}}$  is a QID r.v. hence for every  $n \in \mathbb{N}$  we would have that  $\mathscr{L}(X_1) = (\mathscr{L}(X_1))^n$ , which implies that  $X_1$  thus a contradiction. However, if  $\sigma^{(1)} \ge \sigma^{(2)}$ and  $v^{(1)} \ge v^{(2)}$  then  $X_t$  is a ID r.v. for every  $t \ge 0$ , hence, *X* might potentially be a Lévy process. □

However, we have the following positive general result. We use the representation function  $c(\cdot)$  (see [\[15\]](#page-42-0)) which is a function  $c : \mathbb{R} \to \mathbb{R}$  which is bounded, Borel measurable and satisfies  $\lim_{x\to 0}$   $(c(x)-x)/x^2 = 0$ .

<span id="page-36-1"></span>Proposition 7.23. *Let X*<sup>0</sup> *be any QID random variable and let* (*a*,σ,ν) *be its characteristic triplet. Then*

$$
\hat{\mathscr{L}}(X_t) := \exp\left(i\theta h(t) + i\theta a_t f(t) - \frac{1}{2}\sigma_t^2 f(t)^2 \theta^2 + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta c(x) v_t (f(t)^{-1} dx)\right)
$$

*is the characteristic function of a QID random variable for every t*  $\geq$  0, where h $(\cdot)$ , a.,  $f(\cdot)$  and  $\sigma$  are real *valued functions with*  $f(t) \neq 0$  *and*  $\sigma_t^2 \geq \sigma^2$  *for all*  $t \geq 0$ ,  $v_t(\cdot)$  *is a set function such that*  $v_t(A) \geq v(A)$  *for every*  $t \geq 0$  *and*  $A \in \mathscr{B}_0(\mathbb{R})$ *, and*  $c(\cdot)$  *is any representation function.* 

*Moreover, let*  $k \in \mathbb{N}$  and let  $X_0^{(1)},...,X_0^{(k)}$  $\sigma_0^{(k)}$  be QID random variables. Let  $h^{(j)}(\cdot)$ ,  $a^{(j)}$ ,  $f^{(j)}(\cdot)$ ,  $\sigma^{(j)}$  and  $v^{(j)}_t(\cdot)$ satisfy the above respective properties and similarly define  $\mathscr{L}(X^{(j)}_t)$ *t* )*. Then*

$$
\hat{\mathscr{L}}(Y) := \hat{\mathscr{L}}(X_{t_1}^{(1)}) \cdots \hat{\mathscr{L}}(X_{t_k}^{(k)})
$$

*is the characteristic function of a QID random variable for every*  $t_1, ..., t_k \geq 0$ *.* 

*Proof.* Let for the moment  $f(t) = 1$  and  $h(t) = 0$  for every  $t \ge 0$ . Since for any QID distribution  $\mu$  with c.t.  $(\gamma, b, \eta)$  if there exists  $b' \ge b$  and  $\eta'(A) \ge \eta(A)$  for every  $A \in \mathcal{B}_0(B)$  then the c.t.  $(\gamma - \gamma, b' - b, \eta' - \eta)$ , where  $\gamma' \in \mathbb{R}$ , is the c.t. of a ID distribution, call it  $\tilde{\mu}$ , (see Remark 2.6 point (a) in [\[15\]](#page-42-0)) hence since the class of QID distributions is closed under convolution then we have that  $\mu' = \mu * \tilde{\mu}$  is QID with c.t.  $(\gamma', b', \eta')$  (see Remark 2.6 point (c) in [\[15\]](#page-42-0)). Thus, we have that

$$
\exp\left(a_t\theta - \frac{1}{2}\sigma_t^2\theta^2 + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta c(x)v_t(dx)\right)
$$

is the c.f. of a QID distribution. Now, since the class of QID distributions is closed under shifts and dilation (see Remark 2.6 point (b) in [\[15\]](#page-42-0)) then

$$
\exp\left(i\theta\left(\tilde{h}(t)+\int_{\mathbb{R}}c(mx)-mc(x)v_t(dx)+a_tf(t)\right)-\frac{1}{2}\sigma_t^2f(t)^2\theta^2+\int_{\mathbb{R}}e^{i\theta x}-1-i\theta c(x)v_t(f(t)^{-1}dx)\right)
$$

is the c.f. of QID distribution, where  $\tilde{h}$  is any real valued function. Hence, by setting  $\tilde{h}$  such that  $h(t)$  =  $\tilde{h}(t) + \int_{\mathbb{R}} c(mx) - mc(x)v_t(dx)$  we have the first statement.

The second statement follows by the fact that the class of QID distributions is closed under convolution.

 $\Box$ 

Corollary 7.24. *Under the same conditions of Proposition [7.23](#page-36-1) we have that for every t* ≥ 0 *there exist two QID random variables Y<sup>t</sup> and Z<sup>t</sup> such that*

$$
\mathscr{L}(Y_t) = \exp\left(i\theta a_t - \frac{1}{2}\sigma_t^2 \theta^2 + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta c(x)v_t(dx)\right)
$$

*and*

$$
\hat{\mathscr{L}}(Z_t) = \exp\left(i\theta h(t) + i\theta a f(t) - \frac{1}{2}\sigma^2 f(t)^2 \theta^2 + \int_{\mathbb{R}} e^{i\theta x} - 1 - i\theta c(x) v(f(t)^{-1} dx)\right).
$$

 $\Box$ 

*Proof.* It follows directly from Proposition [7.23.](#page-36-1)

A first example of QID process has been investigated in [\[29\]](#page-43-9), although they mostly focus on the level of distributions and in particular on a subclass of QID distributions call discrete pseudo-compound Poisson distributions, which have applications in insurance mathematics. Moreover, from the formulation  $X + X^{(2)} \stackrel{d}{=}$  $X^{(1)}$  and from the previous results many examples can be constructed. We do not deal with the existence of particular QID stochastic processes since it is a major topic and we leave it for further research. We only point out that most of the potential results seem to rely on the multidimensional extension of the results presented in [\[15\]](#page-42-0). Hence, the following question.

Open Question 7.25. *Is it possible to extend the results in [\[15\]](#page-42-0) and [\[1\]](#page-42-1) to the multidimensional case, namely to distributions on* R *d?*

### <span id="page-37-0"></span>8 The atomless condition and the density of QID r.m.

One of the main properties that independently scattered random measure might satisfy is the atomless con-dition. Indeed, the work of Prékopa [\[22\]](#page-43-10) is centred on this condition and in Theorem 2.2 of [22] he proves that if an independently scattered random measure satisfies the atomless condition then it is an ID random measure. Recall that every  $\sigma$ -ring is a  $\delta$ -ring, but not every  $\delta$ -ring is a  $\sigma$ -ring, and that every  $\sigma$ -algebra is a <sup>σ</sup>-ring, but not every <sup>σ</sup>-ring is a <sup>σ</sup>-algebra.

**Definition 8.1** (atom, atomless). Let Λ be a completely additive set function defined on a σ-ring *S*. A set  $A \in \mathscr{S}$  *is called an atom relative to the set function*  $\Lambda$  *if for every*  $C \subseteq A$  *with*  $C \in \mathscr{S}$  *we have either*  $\Lambda(C) = 0$ *or* Λ(*C*) = Λ(*A*)*. Moreover, the completely additive set function* Λ *will be called* atomless *if for every atom A* we have  $\Lambda(A) = 0$ .

The atomless condition is for random measures what the continuity in probability is for continuous time stochastic processes. Notice that we have mentioned explicitly continuous time processes because for discrete time ones the condition is meaningless.

Then, we have the following result.

Corollary 8.2. *It does not exist a QID r.m. on a* <sup>σ</sup>*-ring which is atomless and which is not ID.*

*Proof.* The result is straightforward since any atomless independently scattered r.m. is ID, see Theorem 2.2 in [\[22\]](#page-43-10). П

In Section [3,](#page-5-0) we have shown the connections between QID and ID random measure. From this discussion it appears clear that in case the ID random measures considered are atomless the generated QID r.m. is indeed an ID r.m.. This lead us to the following question: is it true that ID r.m. are always atomless? The answer is negative. This is because in case either the drift  $v_0$  or the Gaussian part  $v_1$  or the measure  $F(B)$  for some  $B \in \mathscr{B}(\mathbb{R})$  s.t.  $0 \notin \overline{B}$  have at least one atom then the corresponding ID measure is not atomless. Therefore, the results shown in Section [3](#page-5-0) applies to any possible ID and QID r.m.. We refer to Chapter 3.3 in [\[13\]](#page-42-14) for a lucid exposition of ID random measures.

We point out that the atomless condition is not relevant for the spectral representation of the discrete parameter QID process presented in Section [7.](#page-29-0) The associated r.m. might potentially have atoms and this is true also in the ID framework.

We present now some interesting results. We will restrict to the framework of [\[13\]](#page-42-14), which is still very general.

*Notation:* For the rest of this section for "random measure" we mean a " $\mathbb{R}_+$ -valued random measure", and for "random signed measure" we mean "R-valued random measure"

Let  $(S,d)$  be a separable and complete metric space. Let S the associated metric topology and let  $\hat{S}$  be the ring composed by bounded Borel sets in *S*. Let  $\hat{C}_S$  be the space of all bounded continuous functions  $f: S \to \mathbb{R}_+$  with bounded support. Let  $\mathcal{M}_S$  be the space of locally finite measures, namely  $\mu \in \mathcal{M}_S$  if  $\mu(B) < \infty$  for every  $B \in \hat{S}$ . The space  $\mathcal{M}_S$  might be endowed with the vague topology, denoted by  $B_{\mathcal{M}_S}$ , generated by the integration maps  $\pi_f : \mu \mapsto \int f(x) \mu(dx)$ , for all  $f \in \hat{C}_S$ . The vague topology is the coarsest topology making all  $\pi_f$  continuous. The measurable space  $(M_s, \mathbf{B}_{\mathscr{M}_S})$  is a Polish space. The associated notion of vague convergence denoted by  $\mu_n \stackrel{\nu}{\to} \mu$  is defined by the condition  $\int f(x)\mu_n(dx) \to \int f(x)\mu(dx)$ for all  $f \in \hat{C}_S$ .

A random measure  $\xi$  on *S*, with underlying probability space  $(\Omega, \mathscr{F}, \mathbb{P})$ , is a function  $\Omega \times S \to [0, \infty]$ , such that  $\xi(\omega, B)$  is a  $\mathscr F$ -measurable in  $\omega \in \Omega$  for fixed *B* and a locally finite measure in  $B \in S$  for fixed  $\omega$ .<sup>[2](#page-38-0)</sup> Then, convergence in distribution of  $\xi_n$  to  $\xi$  means that  $\mathbb{E}[g(\xi_n)] \to \mathbb{E}[g(\xi)]$  for every bounded continuous function *g* on  $\mathcal{M}_S$ , or equivalently that  $\mathcal{L}(\xi_n) \stackrel{w}{\to} \mathcal{L}(\xi)$ , where for any bounded measures  $\mu_n$  and  $\mu$ , the weak convergence  $\mu_n \stackrel{w}{\to} \mu$  means that  $\int g(y)\mu_n(dy) \to \int g(y)\mu(dy)$  for all *g* as above. We write  $\xi_n \stackrel{vd}{\to} \xi$ to stress that the convergence of distribution is for random measures considered as random elements in the space M*<sup>S</sup>* with vague topology. In this setting, a fixed atom of a random measure ξ is an element *s* ∈ *S* such that  $\mathbb{P}(|\xi({s})| > 0) > 0$ .

We would like to consider QID random measures on  $(S, S)$  as independently scattered random measures s.t.  $\xi(B)$  is QID for every  $B \in \hat{S}$ . This is the usual definition of QID (and similarly of Poisson and of ID) random measures on (*S*,S). However, our previous definition (see Definition [2.10\)](#page-4-4) is different. In Definition [2.10,](#page-4-4) QID random measure are real valued (stochastic processes) and so they cannot take infinite values, which in this framework means that they can only be defined on a ring  $U \subseteq S$ . Thus, the question is how can we combine the two definitions? The answer is the following. By starting with the QID random measures as defined in Definition [2.10,](#page-4-4) we consider only the ones which are  $\mathbb{R}_+$ -valued and then, thanks to a result by Harris (see [\[6\]](#page-42-15)), we can uniquely extend them to random measures on (*S*,S). Let us report here the mentioned result by Harris.

**Theorem 8.3** (see Theorem 2.15 in [\[13\]](#page-42-14)). *Given a process*  $\eta \ge 0$  *on a generating ring*  $U \subset \hat{S}$ *, there exists a random measure*  $\xi$  *on S with*  $\xi$  (*U*) =  $\eta$  (*U*) *a.s. for all*  $U \in U$ *, iff* (i)  $\eta(A \cup B) = \eta(A) + \eta(B)$  *a.s.,*  $A, B \in U$  *disjoint,* (ii)  $\eta(A_n) \stackrel{P}{\to} 0$  as  $A_n \searrow \emptyset$  along **U**.

*In that case,* ξ *is a.s. unique.*

Observe that a QID random measure as defined in Definition [2.10](#page-4-4) satisfies the above conditions, and so it extends uniquely to *S*. Therefore, following our definitions, any QID random measure on (*S*,S) is the unique extension of QID random measure on  $\hat{S}$  or on any generating ring  $U \subset \hat{S}$ .

The practical example one should think when dealing with this framework (and in general with the framework of this work) is the following: a random measure on  $\mathscr{B}_b(\mathbb{R})$  (*i.e.* the set of bounded intervals of

<span id="page-38-0"></span><sup>&</sup>lt;sup>2</sup>An equivalent definition is the following: a random measure  $\xi$  is a measurable mapping from  $(\Omega, \mathscr{F}, \mathbb{P})$  to  $(\mathscr{M}_S, \mathscr{B}_{\mathscr{M}_S})$ , where  $\mathscr{B}_{\mathscr{M}_S}$  is the topology generated by all projection maps  $\pi_B : \mu \mapsto \mu(B)$  with  $B \in S$ , or, equivalently, by all integration maps  $\pi_f$  with measurable  $f \ge 0$ . From Lemma 4.1 in [\[11\]](#page-42-16) or Theorem 4.2 in [\[13\]](#page-42-14), we know that  $\mathscr{B}_{\mathscr{M}_S}$  and  $\mathbf{B}_{\mathscr{M}_S}$  coincide. Hence it is equivalent to consider a random measure as a measurable mapping from  $(\Omega, \mathscr{F}, \mathbb{P})$  to  $(\mathscr{M}_S, \mathbf{B}_{\mathscr{M}_S})$  or to  $(\mathscr{M}_S, \mathscr{B}_{\mathscr{M}_S})$ .

R), which has almost surely finite values for any  $B \in \mathscr{B}_b(\mathbb{R})$ . Observe that  $\mathscr{B}_b(\mathbb{R})$  is not an algebra because  $\mathbb{R} \notin \mathscr{B}_b(\mathbb{R})$  and this is why it is important to work with rings. In this example, using the notation of this work, we have that  $S = \mathbb{R}$  and  $\mathscr{S} = \hat{S} = \mathscr{B}_b(\mathbb{R})$ . Moreover, notice that the same applies to the case of  $\mathscr{B}_b(\mathbb{R}_+)$  instead of  $\mathscr{B}_b(\mathbb{R})$ . From this example, it also appears clear and natural the condition that imposes the existence of an increasing sequence of sets  $S_1, S_2, \dots \in \mathcal{B}_b(\mathbb{R})$  s.t.  $\bigcup_{n \in \mathbb{N}} S_n = S$ ; indeed, take  $S_n$  to be concentric balls of radii *n*. This condition is at the base of our work, of the work of Rajput and Rosinski [\[23\]](#page-43-0), and of Kallenberg's book (see page 15 in [\[13\]](#page-42-14)).

We report now another fundamental result by Harris, see [\[6\]](#page-42-15).

<span id="page-39-0"></span>**Theorem 8.4** (see Theorem 4.11 in [\[13\]](#page-42-14)). *Let*  $\xi$ ,  $\xi_1$ ,  $\xi_2$ ,... *be random measures on S. Then these conditions are equivalent:*

 $(i)$  ξ<sub>*n*</sub>  $\stackrel{vd}{\rightarrow}$  ξ<sub>*r*</sub>  $f(x) \xi_n(dx) \stackrel{d}{\to} \int f(x) \xi(dx)$  *for all*  $f \in \hat{C}_S$ *,*  $\mathbb{E}[\exp(-\int f(x)\xi_n(dx))] \to \mathbb{E}[\exp(-\int f(x)\xi(dx))]$  *for all*  $f \in \hat{C}_S$  *with*  $f \leq 1$ *.* 

We are ready to present the following density result.

<span id="page-39-1"></span>Theorem 8.5. *QID random measures are dense in the space of independently scattered random measures, considered as random elements in* M*<sup>S</sup> endowed with the vague topology, under the convergence in distribution.*

*Proof.* From Theorem 7.1 [\[11\]](#page-42-16) we know that any independently scattered random measure has the following unique representation

$$
\xi \stackrel{a.s.}{=} \alpha + \sum_{j=1}^K \beta_j \delta_{s_j}
$$

with  $K \leq \infty$ , where  $\{s_j : j \geq 1\}$  is the set of fixed atoms of  $\xi$ ,  $\alpha$  is a random measure without fixed atoms with independent increments (hence,  $\alpha$  is an atomless ID r.m.), and  $\beta_j$ ,  $j \ge 1$ , are  $\mathbb{R}_+$ -valued r.v., which are mutually independent and independent of  $\alpha$ .

Let  $\xi_n$  be an independently scattered r.m. defined as

$$
\xi_n \stackrel{a.s.}{=} \alpha + \sum_{j=1}^K \beta_{n,j} \delta_{s_j}
$$

with  $\beta_{n,j}$  QID random variables s.t.  $\beta_{n,j} \stackrel{d}{\to} \beta_j$  as  $n \to \infty$ , for every  $j \ge 1$ , and where  $\alpha$  and  $\{s_j : j \ge 1\}$  are the same as above. First, notice that for fixed *j* the sequence  $\beta_{1,j}, \beta_{2,j}$ , ... exists thanks to Theorem 4.1 from [\[15\]](#page-42-0). Second, observe that, for each  $n \in \mathbb{N}$ ,  $\xi_n$  is a QID random measure because  $\alpha$  is ID and  $\beta_j$  are QID and they are independent of each other.

Now, we need to show that  $\xi_n \stackrel{vd}{\to} \xi$ . From Theorem [8.4,](#page-39-0) it is sufficient to show that  $\int f(x)\xi_n(dx) \stackrel{d}{\to}$  $\int f(x)\xi(dx)$  for all  $f \in \hat{C}_S$ . Since  $\alpha$  is both an element of  $\xi_n$  and  $\xi$  and it is independent of the  $\beta_{n,j}$ ,  $j \ge 1$ , this reduces to prove that  $\sum_{j=1}^K f(s_j)\beta_{n,j} \stackrel{d}{\to} \sum_{j=1}^K f(s_j)\beta_j$  for all  $f \in \hat{C}_S$ . If K is finite for any bounded set then the result follows easily from independence of the  $\beta_{n,j}$ ,  $j = 1,...,K$ , from the fact that  $\beta_{n,j} \stackrel{d}{\rightarrow} \beta_j$  as  $n \to \infty$ , for every  $j = 1, ..., K$  and from the continuous mapping theorem. Thus, assume that *K* is infinite, formally that there are countably many fixed point for at least one bounded set. Consider any  $f \in \hat{C}_S$ . Then, we need to show that  $\sum_{j=1}^{\infty} f(s_j) \beta_{n,j} \stackrel{d}{\to} \sum_{j=1}^{\infty} f(s_j) \beta_j$ . This convergence also holds true for the same arguments as the ones mentioned for the case of *K* finite, however we need to be careful because of the infinities. First, observe that, for each  $n \in \mathbb{N}$ ,  $\sum_{j=1}^{\infty} f(s_j) \beta_{n,j} < \infty$  a.s. and that  $\sum_{j=1}^{\infty} f(s_j) \beta_j < \infty$  a.s.. This is because  $f \in \hat{C}_S$ , hence, by denoting *B* the support of *f*, we have that almost surely  $\xi_n(B) < \infty$ ,  $n \in \mathbb{N}$ , and  $\xi(B) < \infty$  since

 $B \in \hat{S}$ , and that *f* is bounded. Then, looking at the characteristic functions, using the continuity of  $e^z$ , for  $z \in \mathbb{C}$ , and the dominated convergence theorem, we have that for every  $\theta \in \mathbb{R}$ 

$$
1 \geq \mathbb{E}\bigg[\exp\bigg(i\theta\sum_{j=1}^{\infty}f(s_j)\beta_{n,j}\bigg)\bigg] = \mathbb{E}\bigg[\lim_{N \to \infty}\exp\bigg(i\theta\sum_{j=1}^{N}f(s_j)\beta_{n,j}\bigg)\bigg] = \lim_{N \to \infty}\mathbb{E}\bigg[\exp\bigg(i\theta\sum_{j=1}^{N}f(s_j)\beta_{n,j}\bigg)\bigg]
$$

$$
= \lim_{N \to \infty}\prod_{j=1}^{N}\mathbb{E}\bigg[\exp\bigg(i\theta f(s_j)\beta_{n,j}\bigg)\bigg] = \prod_{j=1}^{\infty}\mathbb{E}\bigg[\exp\bigg(i\theta f(s_j)\beta_{n,j}\bigg)\bigg]
$$

Since  $\beta_{n,j} \stackrel{d}{\to} \beta_j$  then by continuous mapping theorem we have  $f(s_j)\beta_{n,j} \stackrel{d}{\to} f(s_j)\beta_j$  and so

$$
\prod_{j=1}^{\infty} \mathbb{E}\bigg[\exp\bigg(i\theta f(s_j)\beta_{n,j}\bigg)\bigg] \to \prod_{j=1}^{\infty} \mathbb{E}\bigg[\exp\bigg(i\theta f(s_j)\beta_j\bigg)\bigg] = \mathbb{E}\bigg[\exp\bigg(i\theta \sum_{j=1}^{\infty} f(s_j)\beta_j\bigg)\bigg], \quad \text{as } n \to \infty.
$$

Thus, we have that  $\sum_{j=1}^{\infty} f(s_j) \beta_{n,j} \stackrel{d}{\rightarrow} \sum_{j=1}^{\infty} f(s_j) \beta_j$  and since *f* was any function in  $\hat{C}_S$  we obtain the stated result.  $\Box$ 

It is possible to consider also the set of bounded measures, denoted by  $\mathcal{M}_S$ , which can be endowed with the vague topology, as for  $\mathcal{M}_S$ , but also with the weak topology. The weak topology on  $\mathcal{M}_S$  is the topology generated by the integration maps  $\pi_f$  for all bounded continuous functions. Then, for random measures  $\xi$ , $\xi_1$ , $\xi_2$ ,... considered as random elements in  $\mathcal{M}_s$ , endowed with the weak topology, we will denote by  $\xi_n \stackrel{wd}{\to} \xi$  the convergence in distribution. Observe that in this setting a QID random measures as defined in Definition are QID random measures on (*S*,S) (hence we do not need to extend them) because for every  $B \in S$  they are all a.s. bounded.

We will use the following result of Kallenberg to prove our next result.

<span id="page-40-0"></span>**Theorem 8.6** (see Theorem 4.19 in [\[13\]](#page-42-14)). *Let*  $\xi$ ,  $\xi_1$ ,  $\xi_2$ ,... *be a.s. bounded random measures on S. Then these conditions are equivalent*

 $(i)$  ξ<sub>*n*</sub>  $\stackrel{wd}{\rightarrow}$  ξ<sub>*i*</sub>  $(i) \xi_n \stackrel{vd}{\to} \xi$ *, and*  $\xi_n(S) \stackrel{d}{\to} \xi(S)$ *.* 

We are now ready to present our next result, which is similar to Theorem [8.5,](#page-39-1) but applies to  $\mathcal{M}_S$  and involves both the vague and the weak topology.

Theorem 8.7. *QID random measures are dense in the space of independently scattered random measures, considered as random elements in* Mˆ *<sup>S</sup> endowed with the vague topology or with the weak topology, under the convergence in distribution.*

*Proof.* Consider first the case of  $\mathcal{M}_S$  endowed with the vague topology. Then, by the same arguments as the ones used in the proof of Theorem [8.5](#page-39-1) we obtain the result.

For the weak topology case, by the same arguments as the ones used in the proof of Theorem [8.5](#page-39-1) we have that  $\xi_n \stackrel{vd}{\to} \xi$ . Hence, according to Theorem [8.6](#page-40-0) it remains to prove that  $\xi_n(S) \stackrel{d}{\to} \xi(S)$ , namely that  $\alpha(S)$  +  $\sum_{j=1}^{\infty} \beta_{n,j} \stackrel{d}{\rightarrow} \alpha(S) + \sum_{j=1}^{\infty} \beta_j$ . However, this has been proved in the proof of Theorem [8.5](#page-39-1) – indeed, consider *f*  $\equiv$  1 and notice that  $\xi(S)$  <  $\infty$  a.s. since  $\xi$  is almost surely bounded. Thus, the proof is complete.  $\Box$ 

So far in this section we have only discussed measures and random measures which take only nonnegative values. The main reason is because, as far as we know, there are no results in the literature on convergence of *real valued* random measures, namely of random signed measures. This is a pity since the random measures considered in this work are real valued (*e.g.* see Definition [2.10](#page-4-4) of QID random measures). We believe in fact that our density results extend to the general (signed) case, at least for bounded random measures. Proving this requires the extension of several results of the first four chapters of [\[13\]](#page-42-14) to the signed

case. Although we leave this as a topic of further research, we present next a first important result in this direction.

Let  $\mathcal{M}_S^-$  be the space of locally finite signed measures. Recall that for a signed measure  $|\mu(B)| < \infty$  iff  $|\mu|(B) < \infty$ . Hence,  $\mu \in \mathcal{M}_S^-$  if  $|\mu(B)| < \infty$  for every  $B \in \hat{S}$ . The next result is an extension of Theorem 7.1 in [\[11\]](#page-42-16) and Lemma 2.1 in [\[7\]](#page-42-17).

Theorem 8.8. *Every signed measure on S has an atomic decomposition:*

$$
\mu=\gamma+\sum_{j=1}^N\lambda_j\delta_{t_j}
$$

 $\forall x$   $\forall y \in \mathbb{Z}_+ \cup \{\infty\}, t_1, t_2, \ldots \in S$ ,  $\gamma$  *is an atomless measure, and*  $\lambda_j$ ,  $j \geq 1$ , *are non-negative constants.* 

*Moreover, any random signed measure* ξ *on S with independent increments has the following almost sure unique representation:*

$$
\xi = \alpha + \sum_{j=1}^K \beta_j \delta_{s_j}
$$

*for some fixed*  $K \in \mathbb{Z}_+ \cup \{\infty\}$  *and*  $s_1, s_2, \dots \in S$ *, some infinitely divisible independently scattered random signed measure* <sup>α</sup> *without fixed atoms, and some* R*-valued r.v.* β*<sup>j</sup> , j* ≥ 1*, which are mutually independent and independent of* <sup>α</sup>*.*

*Proof.* The first statement follows from the fact that every measure  $\mu^+$  on *S* can be written as  $\mu^+ = \gamma^+ + \gamma^+$  $\sum_{j=1}^{N^+} \lambda_j^+ \delta_{t_j^+}$ . Then by Jordan decomposition we know that there exist two measures  $\mu^+$  and  $\mu^-$  such that  $\mu = \mu^+ - \mu^-$  and  $\mu^+ \perp \mu^-$ , hence we obtain the stated representation.

Regarding the second statement, we have that  $\xi$  has at most countably many fixed atoms. To see this, observe that it is sufficient to prove that for fixed bounded set and  $\varepsilon > 0$  there cannot be infinitely many atoms  $\{s_n | n \in \mathbb{N}\}\$  s.t.  $\mathbb{P}(|\xi(\{s_n\})| \geq \varepsilon) \geq \varepsilon$ . Assume that this is true then  $\mathbb{P}(\limsup|\xi|(s_n) \geq \varepsilon) \geq \varepsilon$ , hence *n*→∞  $\sum_{n=1}^{\infty} |\xi|(s_n)$  cannot converge, thus we obtain a contradiction.

Once we subtract the fixed atoms we are left with an atomless independently scattered random measure  $\alpha$  and, by Theorem 2.2 in [\[22\]](#page-43-10), we conclude that it is ID. Finally, the independence follows from the independently scattered property of  $\xi$  and the atomless property of  $\alpha$ .  $\Box$ 

We end this section with the aforementioned conjecture. Let  $\mathcal{M}_S^-$  be the space of bounded signed measures. Observe that this space is quite interesting. First, it is a vector space since it is closed under summation and multiplication by a constant. Moreover, the total variation defines a norm, which makes  $\hat{\mathcal{M}}_S^-$  a Banach space. Indeed, this space has been intensively studied under various properties of the signed measures and of the space *S* (*e.g.* see the Riesz-Markov-Kakutani representation theorem).

Conjecture 8.9. *Real valued QID random measures are dense in the space of independently scattered real valued random measures, considered as random elements in* M<sup>−</sup> *S endowed with the vague topology, under the convergence in distribution.*

*Similarly, bounded real valued QID random measures are dense in the space of bounded independently scattered real valued random measures, considered as random elements in* Mˆ<sup>−</sup> *S endowed with the vague topology or with the weak topology, under the convergence in distribution.*

# Conclusion

In this work we have extended the theory of QID distributions to random measures and stochastic processes. In particular, we studied the existence and uniqueness of QID r.m. and how they are related to ID r.m.. We have seen how to define stochastic integrals w.r.t. QID r.m. and show for which conditions on a functions *f*

we have that *f fd*Λ is defined. Moreover, we have investigated various representations of a QID r.m. and of a QID stochastic process. We ended with density results for QID random measures.

There are several and pivotal questions that are left open. First, we know that QID distributions are dense in the space of all probability distributions under the weak convergence and we showed that similar results hold for QID random measures. Can we extend this processes? In other words, can we prove that for any stochastic process there is a sequence of QID processes that converge to it in distribution? Or at least in finite dimensional distribution, namely without tightness?

Second, what properties does a OID process satisfy? Is there a similar Lévy-Itô decomposition?

Third, it has been seen that QID distributions are related to the Riemann zeta function. What insights on this function can we extract from QID random measures and stochastic processes?
