Transversal special parabolic points in the graph of a polynomial obtained under Viro's patchworking *

Abstract

In this article we focus on the study of special parabolic points in surfaces arising as graphs of polynomials, we give a theorem of Viro's patchworking type to build families of real polynomials in two variables with a prescribed number of special parabolic points in their graphs. We use this result to build a family of degree d real polynomials in two variables with (d-4)(2d-9) special parabolic points in its graph. This brings the number of special parabolic points closer to the upper bound of (d-2)(5d-12) when $d \ge 13$, which is the best known up until now.

1 Introduction

Points in a surface immersed in a 3-dimensional affine space are classified in terms of the contact order of their tangent lines to the surface. On generic surfaces, parabolic points appear along a curve which separates the hiperbolic domain from the elliptic domain and, among parabolic points, there are points where the highest contact order is reached in the direction of its only asymptotic line. These points are called *special parabolic points* or *Gaussian cusps*.

Finding the number of special parabolic points in the graph of a generic polynomial of degree d, has been of special interest for the last century. For example, in [8], an upper bound of 2d(d-2)(11d-24) special parabolic points in generic algebraic surfaces of degree d in \mathbb{RP}^3 is given. In [12], A. Ortiz-Rodríguez builds a family of polynomials whose graphs describe generic surfaces with d(d-2) special parabolic points. And in [5], together with Hernández-Martínez and Sánchez-Bringas, she proves that there are at most (d-2)(5d-12) special parabolic points in the graph of a polynomial of degree d.

Viro's patchworking was introduced in the late seventies [16] as a technique to glue simple algebraic curves in order to construct real algebraic non-singular curves with prescribed topology. Details on this technique can be found for example in [17]. Among its many applications, it has been used by E. Brugallé and B. Bertrand to construct examples of real algebraic hypersurfaces in the projective plane with $(d-4)^2$ compact connected components in their parabolic curves [2], and by E. Brugallé and L. López de Medrano to construct examples of real algebraic curves in the projective plane with the maximum number of real inflection points [3].

In this article, we glue simple graphs in order to build a new graph with a prescribed number of special parabolic points in it. Our main result is a theorem of Viro's patchworking type:

Theorem 8.6(Viro's Theorem for transversal special parabolic points) Let $\Delta \subset \mathbb{R}^2$ be a polyhedron with vertices in \mathbb{Z}^2 and let τ be the convex polyhedral subdivision of Δ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f \in \mathbb{R}[x, y]$ be a polynomial with non-singular Hessian curve and support in Δ . If f_t is the patchworking polynomial of f induced by λ , then there exists $\delta > 0$ such that for $0 < |t| < \delta$, there is an inclusion

$$\varphi_t: TSPP(f,\tau)^* \hookrightarrow TSPP(f_t)^*.$$

Here

$$TSPP(f,\tau)^* := \bigcup_{E \in \tau} \{ (E,p); p \in TSSP(f|_E)^* \},\$$

where for $E \in \tau$, $TSPP(f|_E)^*$ denotes the set of transversal special parabolic points in the graph of the restriction map $f|_E$ that lie in $\pi^{-1}(\mathbb{R}^{*2})$.

We use this theorem to disprove a conjecture that first appeared in 2002 in Ortiz's Phd dissertation [11], which was written under Arnold's supervision. In [6], Hernández-Martínez, A. Ortiz. and F. Sánchez-Bringas, give a degree 4 polynomial with 2 special parabolic points above the bound of d(d-2) given by A. Ortiz. Since $d(d-2)+2 \leq (d-4)(2d-9)$ if $d \geq 13$, our theorem bring us closer to the bound (d-2)(5d-12) special parabolic points given in [5] in this case.

In Section 2, we give preliminaries on the classification of points in a surface and recall known results to characterise special parabolic points in the graph of a function f as the zero set of three polynomials H_f , $E_{1,f}$ and $E_{2,f}$ defined in terms of f. In Section 3, we recall known results on convex triangulations and describe Viro's patchworking technique. In Sections 4, and 5, we describe how the variety defined by H_f , $E_{1,f}$ and $E_{2,f}$ behaves under the oneparameter perturbation $f + t g_t$ given in terms of polynomials $g_t \in \mathbb{R}[t][x, y]$; and in Sections 6 and 7, we analyse how the number of transversal special parabolic points is preserved under quasihomotheties of the form $(x, y) \mapsto (t^{\alpha}x, t^{\beta}y)$ for $t \neq 0$.

In Section 8, we state our main result to describe the behaviour of transversal special parabolic points under Viro's patchworking. Lastly, in Section 9, we use Corollary 8.7 to build a one-parameter family $f_t \in \mathbb{R}[t][x, y]$ of polynomials of degree d with at least (d-4)(2d-9) transversal special parabolic points in their graphs for sufficiently small values of t.

2 Classification of points in a surface

Definition 2.1. Let $S \subset \mathbb{R}^3$ be a surface defined by the vanishing set of a differentiable function $F : \mathbb{R}^3 \to \mathbb{R}$, that is, $S = \{(x, y, z) \in \mathbb{R}^3; F(x, y, z) = 0\}$. Take $p \in S$ and let $l : \mathbb{R} \to \mathbb{R}^3$ be the linear parametrisation of a line with $p = l(t_0)$. The line l has contact order $k \in \mathbb{N}$ with S at p if and only if the partial derivatives satisfy

 $(F \circ l)^{(m)}(t_0) = 0$, for $m = 0, \dots, k-1$; and $(F \circ l)^{(k)}(t_0) \neq 0$.

Tangent lines to a point in a regular surface have contact order $k \ge 2$. Salmon G. [14] used this property to classify the points in a surface according to the following criteria.

Definition 2.2. Let p be a point in the regular surface $S \subset \mathbb{R}^3$. A line with contact order $k \geq 3$ at $p \in S$ is called an *asymptotic direction*. A point $p \in S$ is called

- 1) *elliptic* if all tangent lines to S at p have contact order equal to two;
- 2) hyperbolic if it has exactly two asymptotic directions; or
- 3) *parabolic* if it has either one or more than two asymptotic directions. A parabolic point p is also called
 - a) generic if it has only one asymptotic direction l and the contact order of l at p is 3;
 - b) special if it has only one asymptotic direction l with contact order $k \ge 4$; or
 - c) degenerate if it has more than two asymptotic directions.

The set of parabolic points in a non-degenerate surface $S \subset \mathbb{R}^3$ forms a curve called the *parabolic* curve of S.

Let $S \subset \mathbb{R}^3$ be locally expressed as the graph

$$\Gamma_{\rm f} = \{(x, y, z) \in \mathbb{R}^3 | f(x, y) = z\}$$

of a differentiable function $f : \mathbb{R}^2 \to \mathbb{R}$. We will consider from now on the standard projection $\pi : \mathbb{R}^3 \to \mathbb{R}^2$ on the *xy*-plane and we will denote by SPP(f) the set of special parabolic points in Γ_f , and by $SPP(f)^*$ the points in SPP(f) that lie in $\pi^{-1}(\mathbb{R}^{*2})$.

Hereafter, we will denote the vanishing set of a function f as V(f).

Definition 2.3. Let $f : \mathbb{R}^2 \to \mathbb{R}$ be a differentiable function. We will refer to the curve $V(H_f)$, defined by the Hessian $H_f(x, y) := f_{xx}f_{yy} - f_{xy}^2$ of f, as the Hessian curve of f.

Note that the Hessian H_f of f is the determinant of its Hessian matrix $Hess(f) = \begin{pmatrix} f_{xx} & f_{xy} \\ f_{yx} & f_{yy} \end{pmatrix}$.

When the graph of a function is a non-degenerate surface, the Hessian of the function, along with the following three functions, plays an important role in finding special parabolic points.

Definition 2.4. Let $f : \mathbb{R}^2 \to \mathbb{R}$ be a differentiable function. We consider the functions $C_f, E_{1,f}$ and $E_{2,f}$ given by

i)
$$C_f(x,y) := \begin{pmatrix} -(H_f)_y & (H_f)_x \end{pmatrix} \begin{pmatrix} f_{xx} & f_{xy} \\ f_{yx} & f_{yy} \end{pmatrix} \begin{pmatrix} -(H_f)_y \\ (H_f)_x \end{pmatrix}$$
; and
ii) $\begin{pmatrix} E_{1,f} \\ E_{2,f} \end{pmatrix} = \begin{pmatrix} f_{xx} & f_{xy} \\ f_{yx} & f_{yy} \end{pmatrix} \begin{pmatrix} -(H_f)_y \\ (H_f)_x \end{pmatrix}$,

where $(H_f)_x$ and $(H_f)_y$ are the partial derivatives of the Hessian of f with respect to x and y, respectively.

Note that

$$C_f(x,y) = Q_f(-(H_f)_y, (H_f)_x),$$
(1)

where Q_f is the quadratic form

$$Q_f(x,y) = \begin{pmatrix} dx & dy \end{pmatrix} \begin{pmatrix} f_{xx} & f_{xy} \\ f_{yx} & f_{yy} \end{pmatrix} \begin{pmatrix} dx \\ dy \end{pmatrix},$$

while the polynomials $E_{1,f}$ and $E_{2,f}$ were introduced by V. I. Arnold in [1].

Proposition 2.5. Let $S \subset \mathbb{R}^3$ be locally expressed as the graph Γ_f of a differentiable function $f : \mathbb{R}^2 \to \mathbb{R}$ and let H_f be the Hessian of f.

- i) The projection on the xy-plane of the parabolic curve of $\Gamma_{\rm f}$ is the Hessian curve of f. A tangent vector to the parabolic curve of $\Gamma_{\rm f}$ at a point p projects to a vector which is a multiple of the vector $(-(H_f)_y(\pi(p)), (H_f)_x(\pi(p))) \in \mathbb{R}^2$, tangent to the Hessian curve of f at q.
- ii) Let $l : \mathbb{R} \to \mathbb{R}^3$, $t \mapsto p + tu$ with $u \in \mathbb{R}^3$, parametrise a line with contact order $k \ge 2$ at $p \in \Gamma_f$. Then l is an asymptotic direction of Γ_f if and only if the projection $\pi(u)$ is a zero of the quadratic form Q_f .
- iii) If the Hessian curve of f is non-singular, then the set of special parabolic points in $\Gamma_{\rm f}$ is defined by the intersection of the tangent curves $V(H_f)$ and $V(C_f)$.

The proof of i) and ii) are straight forward and part iii) is given in [5].

Our next result allows us to find special parabolic points in the graph of a differentiable function in terms of its Hessian curve and the curves $V(E_{1,f})$ and $V(E_{2,f})$.

Proposition 2.6. Let $p = (q, f(q)) \in \mathbb{R}^3$ be in the graph Γ_f of a differentiable function $f : \mathbb{R}^2 \to \mathbb{R}$. If the Hessian curve of f is non-singular at q, then $p \in \Gamma_f$ is an special parabolic point if and only if q lies in the intersection of the curves $V(H_f)$, $V(E_{1,f})$ and $V(E_{2,f})$.

Proof. We will prove the forward implication. From Proposition 2.5, $p = (q, f(q)) \in \Gamma_{\rm f}$ is a special parabolic point if and only if $q \in V(H_f) \cap V(C_f)$. The condition $Q_f(-(H_f)_y(q), (H_f)_x(q)) = C_f(q) = 0$ given by (1) implies, following Prop. 2.5 ii), that the line l in the tangent plane to $\Gamma_{\rm f}$ passing through $p \in \Gamma_{\rm f}$ in the direction $u \in \mathbb{R}^3$, with $(0,0) \neq \pi(u) = (-(H_f)_y(q), (H_f)_x(q)) \in \mathbb{R}^2$, is an asymptotic direction of $\Gamma_{\rm f}$ at p.

The vector $\pi(u) = (-(H_f)_y(q), (H_f)_x(q))$ is the only zero in $\mathbb{R}^2 \setminus \{(0,0)\}$ of the normal curvature function $v \mapsto C_f(v)$. Since $\mathbb{R}^2 \setminus \{(0,0)\}$ is homotopically equivalent to S^1 , then $\pi(u)$ is either a maximum or a minimum of the normal curvature function and, thus, $\pi(u)$ is the only eigenvector of the Hessian matrix of f. Let λ be the eigenvalue associated to $\pi(u)$, then we have 0 = $\pi(u) \begin{pmatrix} f_{xx} & f_{xy} \\ f_{yx} & f_{yy} \end{pmatrix} \pi(u)^{t} = \lambda \parallel \pi(u) \parallel^2$. Since $\pi(u) \neq (0,0)$, this implies that

$$\begin{pmatrix} E_{1,f}(q) \\ E_{2,f}(q) \end{pmatrix} = \begin{pmatrix} f_{xx} & f_{xy} \\ f_{yx} & f_{yy} \end{pmatrix} \begin{pmatrix} -(H_f)_y(q) \\ (H_f)_x(q) \end{pmatrix} = \begin{pmatrix} 0 \\ 0 \end{pmatrix}.$$

The backward implication is straightforward from Definition 2.4.

Corollary 2.7. Let f be a differentiable function $f : \mathbb{R}^2 \to \mathbb{R}$ and let Γ_f be the graph of f. If the Hessian curve of f is non-singular, then

$$SPP(f) = \{ p \in \Gamma_{f}; \pi(p) \in V(H_{f}) \cap V(E_{1,f}) \cap V(E_{2,f}) \}$$

Proof. It follows from Proposition 2.6.

3 Viro's patchworking

In this section we will recall Viro's patchworking technique. This procedure was introduced in the late seventies as a technique to glue simple algebraic curves in order to construct real algebraic non-singular curves with prescribed topology.

Let $f \in \mathbb{R}[x, y]$ be a polynomial, the *support* of f is the finite set of pairs $(i, j) \in \mathbb{Z}^2$ whose entries are the exponent of a monomial in f. That is, given $f(x, y) := \sum a_{i,j} x^i y^j$,

Supp
$$(f) := \{(i, j) \in \mathbb{Z}^2; a_{i,j} \neq 0\}.$$

For any subset $A \subset \mathbb{R}^2$, we define the *restriction of* f to A by

$$f|_A(x,y) := \sum_{(i,j)\in A\cap \operatorname{Supp}(f)} a_{i,j} x^i y^j.$$

Let $\Delta \subset \mathbb{R}^2$ be a polyhedron and let τ be a polyhedral subdivision of Δ . We say that τ is *convex* if there exists a convex piecewise linear function $\lambda : \Delta \to \mathbb{R}_{\geq 0}$, taking integer values on the vertices of the subdivision τ , whose restriction to the polyhedra of τ is linear; and with the property that it is not linear in the union of any two distinct polyhedra of τ . We will say in this case that λ induces the convex polyhedral subdivision τ .

Given a convex polyhedral subdivision τ induced by the function λ , the graph Γ_{λ} forms a polytope called the *compact polytope with polyhedral subdivision induced by* λ . We will refer to the set of 2-dimensional faces that lie in Γ_{λ} by $T(\lambda)$.

The projection $\pi : \mathbb{R}^3 \to \mathbb{R}^2$ on the *xy*-plane induces a bijection between the faces of $T(\lambda)$ and the polyhedra in τ . The inverse of this bijection will be denoted by μ , that is,

$$\mu: \tau \to T(\lambda), E \mapsto \pi^{-1}(E) \cap \Gamma_{\lambda}.$$

Let $\Delta \subset \mathbb{R}^2$ be a polyhedron and let $\lambda : \Delta \to \mathbb{R}_{\geq 0}$ be a convex linear function inducing τ , a convex polyhedral subdivision of Δ . Let $f(x, y) = \sum_{(i,j)\in\Delta} a_{i,j} x^i y^j \in \mathbb{R}[x, y]$ be a polynomial

whose support is contained in Δ . The polynomial $f_t(x,y) := \sum_{(i,j)\in\Delta} a_{i,j} t^{\lambda(i,j)} x^i y^j \in \mathbb{R}[t][x,y],$

will be called the *patchworking polynomial of* f induced by λ . Given $\widetilde{S} \subset \mathbb{R}^3$, the restriction of f_t to S is given by

$$f_t|_{\widetilde{S}} := \sum_{(i,j,\lambda(i,j))\in\widetilde{S}} a_{ij} t^{\lambda(i,j)} x^i y^j$$

Given $\widetilde{E} \in T(\lambda)$ and $E \in \tau$ such that $\pi(\widetilde{E}) = E$, then $f_t|_{\widetilde{E}}$ is the patchworking of f_E induced by $\lambda|_E$.

Definition 3.1. Let $\Delta \subset \mathbb{R}^2$ be a polyhedron and let τ be a convex polyhedral subdivision of Δ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f(x, y) = \sum_{(i,j)\in\Delta} a_{i,j} x^i y^j \in \mathbb{R}[x, y]$ be a polynomial with support contained in Δ and let f_t be the patchworking polynomial of f induced by λ . Given $r \in \mathbb{R}_{\geq 0}$, we will denote by $f_t^{[r]}$ the restriction of f_t to $\lambda^{-1}(r)$, i.e.,

$$f_t^{[r]}(x,y) := t^r \sum_{\{(i,j)\in\Delta;\lambda(i,j)=r\}} a_{i,j} x^i y^j.$$

Set $r := \min_{(i,j)\in \text{Supp}(f)} \lambda(i,j)$, then $\widetilde{E} := \{(a,b,c)\in \Gamma_{\lambda}; c=r\}$ is a face of $T(\lambda)$ and

$$f_t|_{\widetilde{E}} = f_t^{[r]} = t^r f|_{\pi(\widetilde{E})} = t^r f|_E, \text{ where } E = \pi(\widetilde{E}).$$

$$\tag{2}$$

Let $\Delta \subset \mathbb{R}^2$ be a polyhedron with vertices in the integer lattice \mathbb{Z}^2 and let $f \in \mathbb{R}[x, y]$ be a polynomial with support in Δ . Let τ be the convex polyhedral subdivision of Δ induced by $\lambda: \Delta \to \mathbb{R}_{\geq 0}$. Denote by $CC(f)^*$ the set of compact connected components of $V(f) \setminus \{xy = 0\}$ and define

$$CC(f,\tau)^* := \bigcup_{E \in \tau} \{ (E, \mathscr{C}); \mathscr{C} \in CC(f|_E)^* \}.$$

Viro's construction implies that, under some generic conditions, if $f_t \in \mathbb{R}[t][x, y]$ is the patchworking polynomial of f induced by λ , then there exists $\delta > 0$ such that there is an inclusion

$$CC(f,\tau)^* \hookrightarrow CC(f_t)^*$$

for $0 < |t| < \delta$. The main purpose of this article is to extend this result to special parabolic points.

Example 1. Set $f(x,y) := x^2y^2(1+x+y+y^2)$, let $\Delta := Conv(\{(2,2), (3,2), (2,3), (2,4)\})$ be the Newton polyhedron associated to f, and let $\lambda : \Delta \to \mathbb{R}_{>0}$ be the convex function defined as follows

$$\lambda(i,j) = \begin{cases} 0 & if \ i+j \le 5, \\ i+j-5 & if \ i+j > 5. \end{cases}$$

The subdivision of Δ induced by λ , is $\tau := \{\Delta_1, \Delta_2\}$ where $\Delta_1 := Conv(\{(2, 2), (3, 2), (2, 3)\})$ and $\Delta_2 := Conv(\{(3,2),(2,3),(2,4)\})$. The patchworking polynomial of f induced by λ is $f_t = x^2y^2(1+x+y+ty^2)$. For 0 < |t| < 0.3, we have the following pictures.



Figure 1: Figure a) shows $E1_{f|\Delta_1}$, $E2_{f|\Delta_1}$ and $H_{f|\Delta_1}$; figure b) shows $E1_{f|\Delta_2}$, $E2_{f|\Delta_2}$ and $H_{f|\Delta_2}$; and figure c) shows $E1_{f_t|\Delta}$, $E2_{f_t|\Delta}$ and $H_{f_t|\Delta}$.

4 On Perturbation Theory

In this section we recall some definitions and statements on perturbation theory of polynomials and curves. These statements are consequences of general results in differential topology (see for example [7]) and are closely related to the concept of transversality. Detailed proofs are also written in [4].

Two non-empty curves $C_1, C_2 \subset \mathbb{R}^2$ intersect transversally at $q \in C_1 \cap C_2$, denoted by $C_1 \pitchfork_q C_2$, if they are non-singular at q and their tangent lines at q are transversal.

Definition 4.1. Let $p = (q, f(q)) \in \mathbb{R}^3$ be a special parabolic point of the graph of $f \in \mathbb{R}[x, y]$. We will say that p is a *transversal special parabolic point* of f if the curve $V(H_f)$ is non-singular at $q \in \mathbb{R}^2$ and $V(E_{1,f}) \pitchfork_q V(E_{2,f})$. We will denote by TSPP(f) the set of transversal special parabolic points of Γ_f .

For i = 1, 2 the tangent space to any smooth point $(x, y) \in \mathbb{R}^2$ in the curve $V(E_{i,f})$ is given by $\ker dE_{i,f}|_{(x,y)}$. A smooth point $p = (q, f(q)) \in \mathbb{R}^3$ is a transversal special parabolic point in the graph of f, if

$$\mathbb{R}^2 \simeq \ker dE_{1,f}|_q + \ker dE_{2,f}|_q. \tag{3}$$

Platonova's genericity condition [13] implies that special parabolic points are generically transversal.

Let $f \in \mathbb{R}[x, y]$ be a polynomial. A family of functions $F_t = f + tg_t$, where $g_t \in \mathbb{R}[t][x, y]$, will be called a *perturbation* of f. Let C := V(f) be the curve defined by the zero set of $f \in \mathbb{R}[x, y]$, the family of curves $C_t := V(F_t)$, defined by a perturbation of f will be called a *perturbation* of C.

Given a point $q \in \mathbb{R}^2$, we will denote by D(q, r), the closed disc of radious r centered at q.

Proposition 4.2. Let $F_t \in \mathbb{R}[t][x, y]$ be a perturbation of $f \in \mathbb{R}[x, y]$. For $\delta > 0$, let $\{q_t\}_{t \in (-\delta, \delta)}$ be a collection of points in $D(q, r) \subset \mathbb{R}^2$ such that $\lim_{t \to 0} q_t = q$, then $\lim_{t \to 0} F_t(q_t) = f(q)$.

Proposition 4.3. Let $C_t, D_t \subset \mathbb{R}^2$ be perturbations of the curves $C, D \subset \mathbb{R}^2$. If $C \pitchfork_q D$, then for any r > 0 there exists $\delta > 0$ such that, for $|t| < \delta$, the curves C_t and D_t intersect transversally at some point $q_t \in D(q, r)$. Moreover, q_t can be chosen so that $\lim_{t \to 0} q_t = q$.

The condition of transversality is crucial in Proposition 4.3.

Example 2. Let $C_t := V(y - x^2 - t), D_t := V(y + x^2 + t)$ be perturbations of the curves $C := V(y - x^2), D := V(y + x^2)$. The curves C and D have one intersection point, but $C \cap_{\underline{0}} D$, is non-transversal. For positive values of t the intersection $C_t \cap_{\underline{0}} D_t$ inside $D(\underline{0}, r)$ is empty, while for negative values of t the intersection $C_t \cap_{\underline{0}} D_t$ inside $D(\underline{0}, r)$ has two points, so the number of points in the intersection of C and D is not preserved under small perturbations.

Proposition 4.3 cannot be extended to more than two curves.

Example 3. Let $C_t := V(x - t)$, $D_t := V(y - t)$ and $E_t := V(y + x + t)$ be perturbations of the curves C := V(x), D := V(y) and E := V(y + x). The curves C, D and E have only one transversal intersection point. For small values of |t| the intersection $C_t \cap D_t \cap E_t$ inside $D(\underline{0}, r)$ is empty, so the number of points in the intersection of C, D and E is not preserved under small perturbations.

Proposition 4.4. Let $C_t := V(F_t) \subset \mathbb{R}^2$ be a perturbation of the curve $C := V(f) \subset \mathbb{R}^2$. Let C be non-singular inside D(q, R) for $q \in C$. Then there exists $\delta > 0$ such that for $|t| < \delta$, the intersection $C_t \cap D(q, R)$ is non-empty and non-singular.

Given a non-empty subset $A \subset \mathbb{R}^2$ and $\varepsilon > 0$, we will denote by $\operatorname{Tub}_{\varepsilon}(A) \subset \mathbb{R}^2$, the set of points whose distance to A is no greater than ε and call it the *tubular neighbourhood* of radious ε centered along A, that is,

$$\operatorname{Tub}_{\varepsilon}(A) := \bigcup_{q \in A} D(q, \varepsilon).$$

We will denote by Int $\operatorname{Tub}_{\varepsilon}(A)$, the interior of the tubular neighbourhood $\operatorname{Tub}_{\varepsilon}(A)$.

Proposition 4.5. Let $C_t := V(F_t) \subset \mathbb{R}^2$ be a perturbation of the curve $C := V(f) \subset \mathbb{R}^2$. Given $\varepsilon > 0$, R > 0 and $q \in C$, there exists $\delta > 0$ such that for $|t| < \delta$, the intersection $C_t \cap D(q, R)$ is contained in the tubular neighbourhood $\operatorname{Tub}_{\varepsilon}(C)$.

5 Transversal special parabolic points under perturbation of functions

Special parabolic points can be determined by the intersection of two tangent curves (see Proposition 2.5 iii)), or the intersection of three curves (see Proposition 2.6); however, as we have seen in examples 2 and 3, both of these situations are generally not preserved under small perturbations.

In [9], E. Landis states that, under some general conditions, special parabolic points are preserved under perturbations. He doesn't give a proof of this fact. We gather that this fact is a consequence of Platonova's work. However, here we give a detailed proof for transversal special parabolic points.

Proposition 5.1. Let $f \in \mathbb{R}[x, y]$ be a polynomial of degree $d \geq 3$. If $V(F_t) \subset \mathbb{R}^2$ is a perturbation of the curve V(f), then the curves defined by the polynomials H_{F_t} , E_{1,F_t} and E_{2,F_t} , are perturbations of the curves defined by H_f , $E_{1,f}$ and $E_{2,f}$, respectively.

Proof. The Hessian of $F_t(x, y) = f(x, y) + t g_t(x, y)$ is given by $H_{F_t}(x, y) = H_f(x, y) + t h_t(x, y)$, where $\tilde{h}_t := (f_{xx}g_{tyy} + g_{txx}f_{yy} - 2f_{xy}g_{txy}) + t H_{g_t}$ and H_f , H_{g_t} are the Hessians of f and g_t , respectively. Hence, the curve $V(H_{F_t})$ is a perturbation of the curve $V(H_f)$.

By definition, the polynomials E_{1,F_t} and E_{2,F_t} , are given by

$$E_{1,F_t}(x,y) := (-H_{F_t})_y(F_t)_{xx} + (H_{F_t})_x(F_t)_{xy} = E_{1,f}(x,y) + t\tilde{e_{1t}}(x,y) \text{ and } E_{2,F_t}(x,y) := (-H_{F_t})_y(F_t)_{xy} + (H_{F_t})_x(F_t)_{yy} = E_{2,f}(x,y) + t\tilde{e_{2t}}(x,y),$$

where $\tilde{e}_{1t}(x,y) = \psi_1 + t(\psi_2 + tE_{1,g_t})$ and $\tilde{e}_{2t}(x,y) = \xi_1 + t(\xi_2 + tE_{2,g_t})$ are perturbations of $\psi_1 = -(H_f)_y g_{txx} + (H_f)_x g_{txy} - \varphi_y f_{xx} + \varphi_x f_{xy}$ and $\xi_1 = -(H_f)_y g_{txy} + (H_f)_x g_{tyy} - \varphi_y f_{xy} + \varphi_x f_{yy}$, respectively. The remaining polynomials are given by $\psi_2 = -\varphi_y g_{txx} + \varphi_x g_{txy} - (H_{g_t})_y f_{xx} + (H_g)_x f_{xy}$ and $\xi_2 = -\varphi_y g_{txy} + \varphi_x g_{tyy} - (H_{g_t})_y f_{xy} + (H_{g_t})_x f_{yy}$, which are given in terms of the Hessians of f and g_t . This way, the curves $V(E_{1,F_t})$ and $V(E_{2,F_t})$ are perturbations of the curves $V(E_{1,f})$ and $V(E_{2,f})$, respectively, as claimed.

Corollary 5.2. Let $f \in \mathbb{R}[x, y]$ be a polynomial of degree $d \geq 3$ and let $\Omega \subset \mathbb{R}^2$ be a bounded region in \mathbb{R}^2 . If F_t is a perturbation of f and the curve $V(H_f)$ is non-singular inside the closure of Ω , then the Hessian curve $V(H_{F_t})$ of F_t is non-singular in Ω for sufficiently small values of t.

Proof. Direct consequence of Propositions 4.4 and 5.1.

Lemma 5.3. Let q be a point in $V(E_{1,f}) \cap V(E_{2,f})$ and let $k = H_f(q)$. If $k \neq 0$, then q is a singular point of the level set curve $H_f^{-1}(k) = \{(x,y) \in \mathbb{R}^2; H_f(x,y) = k\}$ defined by the Hessian of f.

Proof. Take $q \in V(E_{1,f}) \cap V(E_{2,f})$ and suppose that $q \in H_f^{-1}(k)$ with $k \neq 0$. Since

$$\begin{pmatrix} 0\\0 \end{pmatrix} = \begin{pmatrix} E_{1,f}(q)\\E_{2,f}(q) \end{pmatrix} = \begin{pmatrix} f_{xx}(q) & f_{xy}(q)\\f_{yx}(q) & f_{yy}(q) \end{pmatrix} \begin{pmatrix} -(H_f)_y(q)\\(H_f)_x(q) \end{pmatrix},$$

the vector $v(q) := (-(H_f)_y(q), (H_f)_x(q))^{\mathsf{t}} \in \ker \begin{pmatrix} f_{xx}(q) & f_{xy}(q) \\ f_{yx}(q) & f_{yy}(q) \end{pmatrix} \cap T_q H_f^{-1}(k)$, where $T_q H_f^{-1}(k)$ is the tangent space to $H_f^{-1}(k)$ at q. If $v(q) \neq (0,0)$, then rank $\begin{pmatrix} f_{xx}(q) & f_{xy}(q) \\ f_{yx}(q) & f_{yy}(q) \end{pmatrix} \leq 1$ so $q \in V(H_f)$ and we reach a contradiction. Hence v(q) = (0,0), which implies that q is a singular point of $H_f^{-1}(k)$.

Our next theorem allows us to relate the transversal special parabolic points in the graph of a function to those in the graph of any of its perturbations.

Theorem 5.4. Let $f \in \mathbb{R}[x, y]$ be a polynomial of degree $d \geq 3$ with non-singular Hessian curve and let F_t be a perturbation of f. Then, for every $(q, f(q)) \in TSPP(f)$ and $\forall \varepsilon > 0$, there exists $\delta > 0$ such that for $|t| < \delta$ there is a point $(q_t, F_t(q_t)) \in TSPP(F_t)$ with q_t inside the closed disc $D(q, \varepsilon) \subset \mathbb{R}^2$ of radious ε .

Proof. Let $p = (q, f(q)) \in \mathbb{R}^3$ be a transversal special parabolic point in the graph of f and let $\pi : \mathbb{R}^3 \to \mathbb{R}^2$ be the projection on the xy-plane.

Since p is a transversal special parabolic point, then $V(H_f)$ is non-singular at q. By Corollary 5.2, the Hessian curve of F_t is non-singular inside $D(q, \varepsilon)$ for small values of t, and by Proposition 2.6 there exists $\delta_1 > 0$ so that, for $|t| < \delta_1$,

$$\pi \left(TSPP(F_t) \right) \cap D(q,\varepsilon) = V(H_{F_t}) \cap V(E_{1,F_t}) \cap V(E_{2,F_t}) \cap D(q,\varepsilon).$$

By Proposition 4.3, there exists $\delta_2 > 0$ so that for $|t| < \delta_2$ the curves $V(E_{1,F_t})$ and $V(E_{2,F_t})$ intersect transversally at some $q_t \in D(q, \varepsilon)$ with $\lim_{t \to 0} q_t = q$.

We claim that $(q_t, F_t(q_t)) \in TSPP(F_t)$. To prove our claim it is enough to show that $q_t \in V(H_{F_t})$. Suppose that $H_{F_t}(q) = k_t \neq 0$, by Lemma 5.3, $q_t \in D(q, \varepsilon)$ is a singular point of $V^{k_t} := \{(x, y) \in \mathbb{R}^2; H_{F_t}(x, y) = k_t\}$. The vector $v(q_t) := (-(H_{F_t})_y(q_t), (H_{F_t})_x(q_t)) = (0, 0)$, defines then a sequence with

$$(0,0) \neq (-(H_f)_y(q), (H_f)_x(q)) = \lim_{t \to 0} (-(H_f)_y(q_t), (H_f)_x(q_t)) \stackrel{Prop. 4.2}{=} \lim_{t \to 0} \upsilon(q_t) = (0,0).$$

Therefore for $|t| < min\{\delta_1, \delta_2\}$, the point $q_t \in V(E_{1,F_t}) \cap V(E_{2,F_t})$ lies also in $V(H_{F_t}) \cap D(q, \varepsilon)$ and $(q_t, F_t(q_t)) \in SPP(F_t)$ is, henceforth, a transversal special parabolic point in the graph of F_t with $q_t \in D(q, \varepsilon)$.

Corollary 5.5. Let $f \in \mathbb{R}[x, y]$ be a polynomial of degree $d \geq 3$ with non-singular Hessian curve and let $F_t \in \mathbb{R}[t][x, y]$ be a perturbation of f. Then, for $\varepsilon > 0$ there exists $\delta > 0$ such that for $0 < |t| < \delta$ there exists an inclusion

$$\psi_t : TSPP(f) \hookrightarrow TSPP(F_t) \tag{4}$$

such that $\pi(\psi_t(p)) \in D(\pi(p), \varepsilon)$. Furthermore, choosing ε small enough, we also have

$$\psi_t : TSPP(f)^* \hookrightarrow TSPP(F_t)^*.$$
(5)

Proof. The set TSPP(f) is finite. Let $0 < \varepsilon_1 < \varepsilon$ be such that for any $q, q' \in \pi (TSPP(f))$ with $q \neq q', D(q, \varepsilon_1) \cap D(q', \varepsilon_1) = \emptyset$ and $D(q, \varepsilon_1), D(q', \varepsilon_1) \subset (\mathbb{R}^*)^2$. By Theorem 5.4, for any $q \in \pi(TSPP(f))$, there exists $\delta_q > 0$ such that, for $|t| < \delta_q$, there is a point $(q_t, F_t(q_t)) \in TSPP(F_t)$ with $q_t \in D(q, \varepsilon_1)$.

Let
$$\delta := \min_{q \in \pi(TSPP(f))} \delta_q > 0$$
 and for $p = (q, f(q)) \in TSPP(f)$ define $\psi_t(p) := (q_t, F_t(q_t)).$

6 On quasihomothetic maps

In this section, we show some properties of a special type of transformations, called *quasiho-motheties* by O. Y. Viro [15]. Quasihomotheties are maps

$$\rho_s^{(\alpha,\beta)} : \mathbb{R}^2 \to \mathbb{R}^2$$
$$(x,y) \mapsto (s^{\alpha}x, s^{\beta}y).$$

for some $\alpha, \beta \in \mathbb{Z}$ and $s \in \mathbb{R}$. For $s \neq 0$ the function $\rho_s^{(\alpha,\beta)}$ is one-to-one, and the differential $d\rho_s^{(\alpha,\beta)}|_{(x,y)}$ corresponds to the isomorphism defined by the matrix $\begin{pmatrix} s^{\alpha} & 0\\ 0 & s^{\beta} \end{pmatrix}$.

Lemma 6.1. Let $h_{s^{\alpha_i}} : \mathbb{R} \to \mathbb{R}, x \mapsto s^{\alpha_i} x$. Given $\alpha_1 < \alpha_2$, for any two intervals $[a, b], [c, d] \subset \mathbb{R} \setminus \{0\}$, there exists $\delta > 0$ such that for $0 < |s| < \delta$ we have $h_{s^{\alpha_1}}([a, b]) \cap h_{s^{\alpha_2}}([c, d]) = \emptyset$.

Proof. We will give the proof in the case where $[a, b], [c, d] \subset \mathbb{R}_{>0}$. Consider $\delta_1 = \left(\frac{a}{d}\right)^{\frac{1}{\alpha_2 - \alpha_1}}$. If s > 0 or α_1, α_2 are even, then $h_{s^{\alpha_1}}([a, b]) = [s^{\alpha_1}a, s^{\alpha_1}b]$ and $h_{s^{\alpha_2}}([c, d]) = [s^{\alpha_2}c, s^{\alpha_2}d]$, thus choosing $0 < |s| < \delta_1$ gives $s^{\alpha_2 - \alpha_1} < \frac{a}{d}$, so $s^{\alpha_2}d < s^{\alpha_1}a$ and $h_{s^{\alpha_1}}([a, b]) \cap h_{s^{\alpha_2}}([c, d]) = \emptyset$. If s < 0 and $\alpha_1 + \alpha_2$ is odd, then either $h_{s^{\alpha_1}}([a, b]) \subset \mathbb{R}_{>0}$ and $h_{s^{\alpha_2}}([c, d]) \subset \mathbb{R}_{<0}$; or $h_{s^{\alpha_1}}([a, b]) \subset \mathbb{R}_{<0}$ and $h_{s^{\alpha_2}}([c, d]) \subset \mathbb{R}_{>0}$, so the result follows. If s < 0 and α_1, α_2 are odd, then $h_{s^{\alpha_1}}([a, b]) = [s^{\alpha_1}b, s^{\alpha_1}a]$ and $h_{s^{\alpha_2}}([c, d]) = [s^{\alpha_2}d, s^{\alpha_2}c]$, hence $|s| < \delta_1$ gives $s > -(\frac{a}{d})^{\frac{1}{\alpha_2 - \alpha_1}}$, thus $0 < -s < (\frac{a}{d})^{\frac{1}{\alpha_2 - \alpha_1}}$, and $s^{\alpha_1}a < s^{\alpha_2}d$, so $h_{s^{\alpha_1}}([a, b]) \cap h_{s^{\alpha_2}}([c, d]) = \emptyset$.

For the cases where $[a, b] \subset \mathbb{R}_{>0}$ and $[c, d] \subset \mathbb{R}_{<0}$; $[a, b] \subset \mathbb{R}_{<0}$ and $[c, d] \subset \mathbb{R}_{>0}$; or $[a, b], [c, d] \subset \mathbb{R}_{<0}$, it is enough to consider 0 < |s| smaller than $\delta_2 = |\frac{a}{c}|^{\frac{1}{\alpha_2 - \alpha_1}}$, $\delta_3 = |\frac{b}{d}|^{\frac{1}{\alpha_2 - \alpha_1}}$, $\delta_4 = (\frac{b}{c})^{\frac{1}{\alpha_2 - \alpha_1}}$ to have $h_{s^{\alpha_1}}([a, b]) \cap h_{s^{\alpha_2}}([c, d]) = \emptyset$, respectively. Taking $\delta := \min\{\delta_1, \delta_2, \delta_3, \delta_4\}$, the result follows.

Proposition 6.2. Given $(\alpha, \beta) \neq (\alpha', \beta') \in \mathbb{Z}^2$, let $A, B \subset (\mathbb{R}^*)^2$ be finite sets of points and let $\varepsilon > 0$ be such that for all $q \in A \cup B$, the closed disc $D(q, \varepsilon) \subset (\mathbb{R}^*)^2$. Then, there exists $\delta > 0$ such that for $0 < |s| < \delta$,

$$\rho_s^{(\alpha,\beta)}\left(Tub_{\varepsilon}(A)\right)\bigcap\rho_s^{(\alpha',\beta')}\left(Tub_{\varepsilon}(B)\right)=\emptyset.$$

Proof. Suppose that $\alpha \neq \alpha'$ and let $\pi_1 : \mathbb{R}^2 \to \mathbb{R}$ be the projection $(x, y) \mapsto x$. Let $[a, b], [e, f] \subset \mathbb{R}_{<0}$, and $[c, d], [g, h] \subset \mathbb{R}_{>0}$ be intervals such that

$$\pi_1(Tub_{\varepsilon}(A)) \subseteq [a,b] \cup [c,d] \text{ and } \pi_1(Tub_{\varepsilon}(B)) \subseteq [e,f] \cup [g,h].$$

Then,

$$\pi_1\left(\rho_s^{(\alpha,\beta)}(Tub_{\varepsilon}(A))\right) = \left\{s^{\alpha}x; x \in \pi_1\left(Tub_{\varepsilon}(A)\right)\right\} \subseteq h_{s^{\alpha}}([a,b]) \cup h_{s^{\alpha}}([c,d]) \text{ and}$$
$$\pi_1\left(\rho_s^{(\alpha',\beta')}(Tub_{\varepsilon}(B))\right) = \left\{s^{\alpha'}x; x \in \pi_1(Tub_{\varepsilon}(B))\right\} \subseteq h_{s^{\alpha}}([e,f]) \cup h_{s^{\alpha}}([g,h]).$$

Taking these intervals two-to-two, the result follows from Lemma 6.1.

If, on the other hand, $\alpha = \alpha'$ and $\beta \neq \beta'$, then with the projection $\pi_2 : \mathbb{R}^2 \to \mathbb{R}, (x, y) \mapsto y$ and a similar process we obtain the result wanted.

7 Special parabolic points under quasihomothetic maps

In this section we show how the number of transversal special parabolic points is preserved under quasihomotheties.

Given $\alpha, \beta, r \in \mathbb{Z}$, we will consider the transformation

$$\widetilde{h}_{(\alpha,\beta,r)} : \mathbb{R}[x,y] \to \mathbb{R}[s][x,y]$$

$$f(x,y) \mapsto \widetilde{h}_{(\alpha,\beta,r)}(f)(x,y) = s^r f \circ \rho_s^{(\alpha,\beta)}(x,y).$$
(6)

Note that $\widetilde{h}_{(\alpha,\beta,r)}(f)$ does not define a perturbation of $f \in \mathbb{R}[x,y]$. However, if we consider the translation $T_1 : \mathbb{R}[s][x,y] \to \mathbb{R}[s][x,y], f(x,y,s) \mapsto f(x,y,s+1)$, then the composition $T_1 \circ \widetilde{h}_{(\alpha,\beta,r)}(f)$ is a perturbation of the polynomial f.

Lemma 7.1. Let $\Omega \subset \mathbb{R}^2$ be a bounded region. If the Hessian curve of $f \in \mathbb{R}[x, y]$ is nonsingular inside the closure of Ω , then for $s \neq 0$ and $r \in \mathbb{Z}$,

- i) $(x, y, f(x, y)) \in SPP(f) \cap \pi^{-1}(\Omega)$ if and only if $(x, y, \widetilde{h}_{(0,0,r)}(f)(x, y)) \in SPP(\widetilde{h}_{(0,0,r)}(f)) \cap \pi^{-1}(\Omega)$.
- $\text{ii)} \ (x,y,f(x,y)) \in SPP(f)^* \cap \pi^{-1}(\Omega) \text{ if and only if } (x,y,\widetilde{h}_{(0,0,r)}(f)(x,y)) \in SPP(\widetilde{h}_{(0,0,r)}(f))^* \cap \pi^{-1}(\Omega).$

Proof. Set $\tilde{f}(x,y) := \tilde{h}_{(0,0,r)}(f)(x,y) = s^r f(x,y)$, and let $\pi : \mathbb{R}^3 \to \mathbb{R}^2$ be the projection on the *xy*-plane, by Proposition 2.6 the set of special parabolic points in the graph of \tilde{f} is given by the set $SPP(\tilde{f}) \cap \pi^{-1}(\Omega) = \{(x,y,\tilde{f}(x,y)); (x,y) \in V(H_{\tilde{f}}) \cap V(E_{1,\tilde{f}}) \cap V(E_{2,\tilde{f}})\} \cap \pi^{-1}(\Omega)$, where

$$H_{\tilde{f}}(x,y) = \det \begin{pmatrix} \tilde{f}_{xx}(x,y) & \tilde{f}_{xy}(x,y) \\ \tilde{f}_{yx}(x,y) & \tilde{f}_{yy}(x,y) \end{pmatrix} = \det \begin{pmatrix} s^{r} f_{xx}(x,y) & s^{r} f_{xy}(x,y) \\ s^{r} f_{yx}(x,y) & s^{r} f_{yy}(x,y) \end{pmatrix} = s^{2r} H_{f}(x,y), \text{ and } (7)$$

$$\begin{pmatrix} E_{1,\tilde{f}}(x,y) \\ E_{2,\tilde{f}}(x,y) \end{pmatrix} = \begin{pmatrix} \tilde{f}_{xx}(x,y) & \tilde{f}_{xy}(x,y) \\ \tilde{f}_{yx}(x,y) & \tilde{f}_{yy}(x,y) \end{pmatrix} \begin{pmatrix} -(H_{\tilde{f}})_{y}(x,y) \\ (H_{\tilde{f}})_{x}(x,y) \end{pmatrix}$$

$$= \begin{pmatrix} s^{r} f_{xx}(x,y) & s^{r} f_{xy}(x,y) \\ s^{r} f_{yx}(x,y) & s^{r} f_{yy}(x,y) \end{pmatrix} \begin{pmatrix} -s^{2r} (H_{f})_{y}(x,y) \\ s^{2r} (H_{f})_{x}(x,y) \end{pmatrix} = s^{3r} \begin{pmatrix} E_{1,f}(x,y) \\ E_{2,f}(x,y) \end{pmatrix}.$$
(8)

Since the Hessian curve of f is non-singular inside Ω , by equation (7) also the Hessian curve of \tilde{f} is non-singular inside Ω . Since we have $SPP(f) \cap \pi^{-1}(\Omega) = \{(x, y, f(x, y)); (x, y) \in V(H_f) \cap V(E_{1,f}) \cap V(E_{2,f})\} \cap \pi^{-1}(\Omega)$, equations (7) and (8) give the results wanted for $s \neq 0$. \Box

Lemma 7.2. Let $\Omega \subset \mathbb{R}^2$ be a bounded region. If the Hessian curve of $f \in \mathbb{R}[x, y]$ is nonsingular inside the closure of Ω , then for $s \neq 0$ and $r \in \mathbb{Z}$,

i)
$$(x, y, f(x, y)) \in TSPP(f) \cap \pi^{-1}(\Omega)$$
 if and only if $(x, y, \tilde{h}_{(0,0,r)}(f)(x, y)) \in TSPP(\tilde{h}_{(0,0,r)}(f)) \cap \pi^{-1}(\Omega)$.
ii) $(x, y, f(x, y)) \in TSPP(f)^* \cap \pi^{-1}(\Omega)$ if and only if $(x, y, \tilde{h}_{(0,0,r)}(f)(x, y)) \in TSPP(\tilde{h}_{(0,0,r)}(f))^* \cap \pi^{-1}(\Omega)$.

Proof. A smooth point $p = (q, f(q)) \in \mathbb{R}^3$ is a transversal special parabolic point in the graph of f if it satisfies equation (3). By equations (7) and (8) we have that $\mathbb{R}^2 \simeq \ker dE_{1,\tilde{f}}|_q + \ker dE_{2,\tilde{f}}|_q$, and by Lemma 7.1 we have the result. \Box

Set $\widetilde{\varphi}_s^{(\alpha,\beta,r)}$ to be the transformation given by

$$\widetilde{\varphi}_{s}^{(\alpha,\beta,r)}:\Gamma_{f}\to\Gamma_{\widetilde{h}_{(\alpha,\beta,r)}(f)}$$

$$(x,y,f(x,y))\mapsto\left(s^{-\alpha}x,s^{-\beta}y,\widetilde{h}_{(\alpha,\beta,r)}(f)\left(\rho_{s}^{(-\alpha,-\beta)}(x,y)\right)\right).$$

$$(9)$$

Proposition 7.3. Let $\Omega \subset \mathbb{R}^2$ be a bounded region. If the Hessian curve of $f \in \mathbb{R}[x, y]$ is non-singular inside the closure of Ω , then for $s \neq 0$, and $\alpha, \beta, r \in \mathbb{Z}$, the mapping $\widetilde{\varphi}_s^{(\alpha,\beta,r)}$ gives a one-to-one correspondence between $SPP(f) \cap \pi^{-1}(\Omega)$ and $SPP(\widetilde{h}_{(\alpha,\beta,r)}(f)) \cap \pi^{-1}(\rho_s^{(-\alpha,-\beta)}(\Omega))$. Moreover, $\widetilde{\varphi}_s^{(\alpha,\beta,r)}$ gives a one-to-one correspondence between $SPP(f)^* \cap \pi^{-1}(\Omega)$ and the set $SPP(\widetilde{h}_{(\alpha,\beta,r)}(f))^* \cap \pi^{-1}(\rho_s^{(-\alpha,-\beta)}(\Omega))$.

Proof. By Lemma 7.1, it is enough to prove that $\tilde{\varphi}_s^{(\alpha,\beta,r)}$ gives a one-to-one correspondence for r = 0. Set $\hat{f}(x,y) := \tilde{h}_{(\alpha,\beta,0)}(f)(x,y) = f(\rho_s^{(\alpha,\beta)}(x,y))$. By Proposition 2.6, the set of special parabolic points in the graph of \hat{f} is described by the set

$$SPP(\widehat{f}) \cap \pi^{-1}(\Omega) = \{(x, y, \widehat{f}(x, y)); (x, y) \in V(H_{\widehat{f}}) \cap V(E_{1, \widehat{f}}) \cap V(E_{2, \widehat{f}})\} \cap \pi^{-1}(\Omega),$$

where

$$\begin{aligned} H_{\widehat{f}}(x,y) &= \det \begin{pmatrix} \widehat{f}_{xx}(x,y) & \widehat{f}_{xy}(x,y) \\ \widehat{f}_{yx}(x,y) & \widehat{f}_{yy}(x,y) \end{pmatrix} = \det \begin{pmatrix} s^{2\alpha} f_{xx}(\rho_s^{(\alpha,\beta)}(x,y)) & s^{\alpha+\beta} f_{xy}(\rho_s^{(\alpha,\beta)}(x,y)) \\ s^{\alpha+\beta} f_{yx}(\rho_s^{(\alpha,\beta)}(x,y)) & s^{2\beta} f_{yy}(\rho_s^{(\alpha,\beta)}(x,y)) \end{pmatrix} \\ &= s^{2(\alpha+\beta)} H_f(\rho_s^{(\alpha,\beta)}(x,y)), \text{ and} \end{aligned}$$
(10)
$$\begin{pmatrix} E_{1,\widehat{f}}(x,y) \\ E_{2,\widehat{f}}(x,y) \end{pmatrix} = \begin{pmatrix} \widehat{f}_{xx}(x,y) & \widehat{f}_{xy}(x,y) \\ \widehat{f}_{yx}(x,y) & \widehat{f}_{yy}(x,y) \end{pmatrix} \begin{pmatrix} -(H_{\widehat{f}})_y(x,y) \\ (H_{\widehat{f}})_x(x,y) \end{pmatrix} \\ &= \begin{pmatrix} s^{2\alpha} f_{xx}(\rho_s^{(\alpha,\beta)}(x,y)) & s^{\alpha+\beta} f_{xy}(\rho_s^{(\alpha,\beta)}(x,y)) \\ s^{\alpha+\beta} f_{yx}(\rho_s^{(\alpha,\beta)}(x,y)) & s^{2\beta} f_{yy}(\rho_s^{(\alpha,\beta)}(x,y)) \end{pmatrix} \begin{pmatrix} -s^{2(\alpha+\beta)} (H_f)_y(s^{\alpha}x,s^{\beta}y) \\ s^{2(\alpha+\beta)} (H_f)_x(s^{\alpha}x,s^{\beta}y) \end{pmatrix} \\ &= \begin{pmatrix} s^{4\alpha+3\beta} E_{1,f}(\rho_s^{(\alpha,\beta)}(x,y)) \\ s^{3\alpha+4\beta} E_{2,f}(\rho_s^{(\alpha,\beta)}(x,y)) \end{pmatrix}. \end{aligned}$$
(11)

By equation (10), the Hessian curve $V(H_{\hat{f}})$ of \hat{f} is non-singular inside Ω for $s \neq 0$; and by equations (10) and (11), $\tilde{\varphi}_s^{(\alpha,\beta,r)}$ is one-to-one between the sets $SPP(f) \cap \pi^{-1}(\Omega)$ and $SPP(\tilde{h}_{(\alpha,\beta,r)}(f)) \cap \pi^{-1}(\rho_s^{(-\alpha,-\beta)}(\Omega))$. Moreover, since for $s \neq 0$, $s^{\alpha}x = 0$ if and only if x = 0, and $s^{\beta}y = 0$ if and only if y = 0, the latest claim is proved.

Proposition 7.4. Let $\Omega \subset \mathbb{R}^2$ be a bounded region. If the Hessian curve of $f \in \mathbb{R}[x, y]$ is nonsingular inside Ω , then for $s \neq 0$ and $\alpha, \beta, r \in \mathbb{Z}$, $\tilde{\varphi}_s^{(\alpha,\beta,r)}$ gives a one-to-one correspondence between $TSPP(f) \cap \pi^{-1}(\Omega)$ and $TSPP(\tilde{h}_{(\alpha,\beta,r)}(f)) \cap \pi^{-1}(\rho_s^{(-\alpha,-\beta)}(\Omega))$. Moreover, $\tilde{\varphi}_s^{(\alpha,\beta,r)}$ is a oneto-one correspondence between $TSPP(f)^* \cap \pi^{-1}(\Omega)$ and $TSPP(\tilde{h}_{(\alpha,\beta,r)}(f))^* \cap \pi^{-1}(\rho_s^{(-\alpha,-\beta)}(\Omega))$.

Proof. By Corollary 7.2, it is enough to prove the proposition for r = 0. Set $\widehat{f}(x, y) := \widetilde{h}_{(\alpha,\beta,0)}(f)(x,y) = f \circ \rho_s^{(\alpha,\beta)}(x,y)$. By Proposition 7.3, it is enough to show that if $\mathbb{R}^2 \simeq$

 $\ker dE_{1,f}|_{(x,y)} + \ker dE_{2,f}|_{(x,y)}, \text{ then there exists } \delta > 0 \text{ such that for } 0 < |s| < \delta \text{ we have } \mathbb{R}^2 \simeq \ker dE_{1,\widehat{f}}|_{\rho_s^{(-\alpha,-\beta)}(x,y)} + \ker dE_{2,\widehat{f}}|_{\rho_s^{(-\alpha,-\beta)}(x,y)}.$

$$dE_{1,\widehat{f}}|_{(x,y)} = s^{4\alpha+3\beta} dE_{1,f}|_{\rho_s^{(\alpha,\beta)}(x,y)} \cdot \begin{pmatrix} s^{\alpha} & 0\\ 0 & s^{\beta} \end{pmatrix}, \text{ and}$$
$$dE_{2,\widehat{f}}|_{(x,y)} = s^{3\alpha+4\beta} dE_{2,f}|_{\rho_s^{(\alpha,\beta)}(x,y)} \cdot \begin{pmatrix} s^{\alpha} & 0\\ 0 & s^{\beta} \end{pmatrix},$$

then $\ker dE_{i,\hat{f}}|_{\rho_s^{(-\alpha,-\beta)}(x,y)}$ is the image of $\ker dE_{i,f}|_{(x,y)}$ under the isomorphism defined by the matrix $d\rho_s^{(\alpha,\beta)}|_{(x,y)} = \begin{pmatrix} s^{\alpha} & 0\\ 0 & s^{\beta} \end{pmatrix}$, for i = 1, 2. Therefore, if $\mathbb{R}^2 \simeq \ker dE_{1,f}|_{(x,y)} + \ker dE_{2,f}|_{(x,y)}$, then $\ker dE_{1,\hat{f}}|_{\rho_s^{(-\alpha,-\beta)}(x,y)} + \ker dE_{2,\hat{f}}|_{\rho_s^{(-\alpha,-\beta)}(x,y)} \simeq \mathbb{R}^2$.

Let $f \in \mathbb{R}[x, y]$ be a polynomial and let f_t be a perturbation of f. For $t \in \mathbb{R}$, set $h_{(\alpha,\beta,r)}$ to be the transformation

$$\begin{aligned} h_{(\alpha,\beta,r)} &: \mathbb{R}[t][x,y] \to \mathbb{R}[t][x,y] \\ f_t(x,y) &\mapsto h_{(\alpha,\beta,r)}(f_t)(x,y) = t^r f_t \circ \rho_t^{(\alpha,\beta)}(x,y). \end{aligned}$$

Note that $h_{(\alpha,\beta,r)}$ can be obtained by extending the transformation $\tilde{h}_{(\alpha,\beta,r)}$ in (6) to polynomials $f_t \in \mathbb{R}[t][x,y]$ and composing with $\varrho : \mathbb{R}[s,t][x,y] \to \mathbb{R}[t][x,y], P(s,t,x,y) \mapsto P(t,t,x,y)$. Set $\varphi_t^{(\alpha,\beta,r)}$ to be the transformation given by

$$\varphi_t^{(\alpha,\beta,r)} : \Gamma_{f_t} \to \Gamma_{h_{(\alpha,\beta,r)}(f_t)}$$
$$(x, y, f_t(x, y)) \mapsto \left(t^{-\alpha}x, t^{-\beta}y, h_{(\alpha,\beta,r)}(f_t) \circ \rho_t^{(-\alpha,-\beta)}(x, y)\right).$$

Note that $\varphi_t^{(\alpha,\beta,r)}$ can be obtained by extending the transformation $\widetilde{\varphi}_s^{(\alpha,\beta,r)}$ in (9) to polynomials $f_t \in \mathbb{R}[t][x,y]$ and composing with $\varrho : \mathbb{R}[s,t][x,y] \to \mathbb{R}[t][x,y]$, $P(s,t,x,y) \mapsto P(t,t,x,y)$.

Proposition 7.5. Let $f \in \mathbb{R}[x, y]$ be a polynomial with non-singular Hessian curve and let $f_t \in \mathbb{R}[t][x, y]$ be a perturbation of f. Then, for any bounded region $\Omega \subset \mathbb{R}^2$ there exist $\delta > 0$ such that for $0 < |t| < \delta$, $\varphi_t^{(\alpha,\beta,r)}$ is a one-to-one correspondence between

i) $SPP(f_t) \cap \pi^{-1}(\Omega)$ and $SPP(h_{(\alpha,\beta,r)}(f_t)) \cap \pi^{-1}\left(\rho_t^{(-\alpha,-\beta)}(\Omega)\right)$,

ii)
$$SPP(f_t)^* \cap \pi^{-1}(\Omega)$$
 and $SPP(h_{(\alpha,\beta,r)}(f_t))^* \cap \pi^{-1}\left(\rho_t^{(-\alpha,-\beta)}(\Omega)\right)$,

iii) $TSPP(f_t) \cap \pi^{-1}(\Omega)$ and $TSPP(h_{(\alpha,\beta,r)}(f_t)) \cap \pi^{-1}\left(\rho_t^{(-\alpha,-\beta)}(\Omega)\right)$, and

iv)
$$TSPP(f_t)^* \cap \pi^{-1}(\Omega)$$
 and $TSPP(h_{(\alpha,\beta,r)}(f_t))^* \cap \pi^{-1}\left(\rho_t^{(-\alpha,-\beta)}(\Omega)\right)$

for any $(\alpha, \beta, r) \in \mathbb{Z}^3$.

Proof. Since H_f is non-singular in the closure of Ω , by Corollary 5.2, there exists $\delta > 0$ such that for $0 < |t| < \delta$, H_{f_t} has no singularities inside Ω . By Proposition 7.3, making s = t, we have i) and ii). And, by Proposition 7.4, we have iii) and iv).

8 Viro's Theorem for transversal special parabolic points

In this section we will adapt Viro's patchworking technique to the study of transversal special parabolic points on the graphs of polynomials.

Proposition 8.1. Given a convex polyhedral subdivision τ of $\Delta \subset \mathbb{R}^2$ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$, there exists $d \in \mathbb{Z}_{>0}$ such that $d \cdot \lambda(\Delta \cap \mathbb{Z}^2) \subset \mathbb{Z}$.

Proof. Take $\alpha \in \Delta \cap \mathbb{Z}^2$. If α is a 0-dimensional polyhedron in τ , then $\lambda(\alpha) \in \mathbb{Z}$. Otherwise, let $F \in \tau$ be the polyhedron with vertices V_1, \ldots, V_s such that $\alpha \in F$. There exist rational numbers $\alpha_i \in \mathbb{Q}$ such that $\alpha = \sum_{i=1}^s \alpha_i V_i$ and thus $\lambda(\alpha) = \sum_{i=1}^s \alpha_i \lambda(V_i) \in \mathbb{Q}$. The result follows from the fact that $\lambda(\Delta \cap \mathbb{Z}^2)$ is a finite set. \Box

Lemma 8.2. Let $\Delta \subset \mathbb{R}^2$ be a polyhedron and let τ be the polyhedral subdivision of Δ induced by the convex function $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. If $\lambda(\Delta \cap \mathbb{Z}^2) \subset \mathbb{Z}$, then for $\widetilde{E} \in T(\lambda)$ the only vector of the form $(\alpha, \beta, 1) \in \mathbb{R}^3$ that is orthogonal to \widetilde{E} has integer coordinates.

Proof. Let $(x_1, y_1, \lambda(x_1, y_1)), (x_2, y_2, \lambda(x_2, y_2)), (x_3, y_3, \lambda(x_3, y_3)) \in \widetilde{E} \cap \mathbb{Z}^3$ be points with the property that there are no points with integer coordinates inside the triangle $\Delta(v_1, v_2, v_3)$ with vertices $v_1 = (x_1, y_1), v_2 = (x_2, y_2), v_3 = (x_3, y_3) \in \mathbb{Z}^2$, that is,

$$1 = area\left(\Delta(v_1, v_2, v_3)\right) = |(v_2 - v_1) \cdot (v_3 - v_1)|.$$
(12)

A vector $(\alpha, \beta, 1) \in \mathbb{R}^3$ is orthogonal to \widetilde{E} if $(\alpha, \beta, 1) \cdot (x_k, y_k, \lambda(x_k, y_k))$ is constant for k = 1, 2, 3. The system of equations in the real variables α, β and r,

$$\begin{pmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ \alpha & \beta & 1 \end{pmatrix} \begin{pmatrix} x_k \\ y_k \\ \lambda(x_k, y_k) \end{pmatrix} = \begin{pmatrix} x_k \\ y_k \\ r \end{pmatrix} \quad k = 1, 2, 3,$$
(13)

sending \widetilde{E} to the horizontal plane $\{Z = r\}$ is equivalent to the system of three equations $\begin{pmatrix} x_1 & y_1 & 1 \\ x_2 & y_2 & 1 \\ x_3 & y_3 & 1 \end{pmatrix} \begin{pmatrix} \alpha \\ \beta \\ -r \end{pmatrix} = \begin{pmatrix} -\lambda(x_1, y_1) \\ -\lambda(x_2, y_2) \\ -\lambda(x_3, y_3) \end{pmatrix}$. The determinant of the 3 × 3 matrix involved, given by $(x_2y_3 - y_2x_3) - (x_1y_3 - x_3y_1) + (x_1y_2 - x_2y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_2 - y_1), x_2 - x_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_2 - y_1), x_2 - x_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_1), x_3 - y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_3 - y_3), y_3 - y_3)$

by $(x_2y_3 - y_2x_3) - (x_1y_3 - x_3y_1) + (x_1y_2 - x_2y_1) = (x_3 - x_1, y_3 - y_1) \cdot (-(y_2 - y_1), x_2 - x_1) = (v_3 - v_1) \cdot (v_2 - v_1)^{\perp}$, is equal to ± 1 by (12), so the existence of integer solutions $\alpha, \beta, r \in \mathbb{Z}$ to the system (13) is granted.

Lemma 8.3. Let $\Delta \subset \mathbb{R}^2$ be a polyhedron and let τ be the polyhedral subdivision of Δ induced by the convex function $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. If $\lambda(\Delta \cap \mathbb{Z}^2) \subset \mathbb{Z}$ and $(\alpha, \beta, 1) \in \mathbb{Z}^3$ is orthogonal to $\widetilde{E} \in T(\lambda)$, then the linear transformation $l_{(\alpha,\beta)} : \mathbb{R}^3 \to \mathbb{R}^3$ defined by the matrix $\begin{pmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ \alpha & \beta & 1 \end{pmatrix}$,

satisfies $l_{(\alpha,\beta)}(\widetilde{E}) \subset \{Z=r\}$ where $r := \min\{(\alpha,\beta,1) \cdot v; v \in T(\lambda)\}$ is an integer number.

Proof. The linear transformation $l_{(\alpha,\beta)}$ sends the face $\widetilde{E} \in T(\lambda)$ to a face in $T(\widetilde{\lambda})$ contained in the horizontal plane $\{Z = r\}$, where $\widetilde{\lambda}(i, j) = \lambda(i, j) + i\alpha + j\beta$; while the remaining 2-dimensional faces in $T(\lambda)$ are sent to faces in $T(\widetilde{\lambda})$ above this horizontal plane, thus $r = \min\{(\alpha, \beta, 1) \cdot v; v \in T(\lambda)\} \in \mathbb{Z}$.

From now on, and without loss of generality, by Proposition 8.1, all our convex polyhedral subdivisions will be induced by convex functions sending points with integer coordinates to integer values.

Let τ be a convex polyhedral subdivision of $\Delta \subset \mathbb{R}^2$ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f \in \mathbb{R}[x, y]$ be a polynomial with support in Δ . Given $(\alpha, \beta) \in \mathbb{Z}^2$ the mapping

$$\widetilde{\lambda}: (i,j) \mapsto \lambda(i,j) + \alpha i + \beta j$$

is also a convex function inducing τ . Let f_t be the patchworking polynomial of f induced by λ and let \tilde{f}_t be the patchworking polynomial induced by $\tilde{\lambda}$, then

$$\widetilde{f}_t = h_{(\alpha,\beta,0)}(f_t) = t^r f_t(t^\alpha x, t^\beta y)$$
(14)

for some integer value $r \in \mathbb{Z}$.

Proposition 8.4. Let τ be a convex polyhedral subdivision of $\Delta \subset \mathbb{R}^2$ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f \in \mathbb{R}[x, y]$ be a polynomial with support in Δ and let f_t be the patchworking polynomial of f induced by λ . If the vector $(\alpha, \beta, 1) \in \mathbb{Z}^3$ is orthogonal to $\widetilde{E} \in T(\lambda)$, then the patchworking polynomial \widetilde{f}_t induced by $\widetilde{\lambda}(i, j) = \lambda(i, j) + i\alpha + j\beta$ satisfies $h_{(\alpha, \beta, 0)}(f_t|_{\widetilde{E}}) = \widetilde{f}_t^{[r]}$ for some constant $r \in \mathbb{Z}$.

Proof. This result is direct consequence of (14) and Lemma 8.3.

Theorem 8.5. Let $\Delta \subset \mathbb{R}^2$ be a polyhedron with vertices in \mathbb{Z}^2 and let τ be a convex polyhedral subdivision of Δ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f \in \mathbb{R}[x, y]$ be a polynomial with support in Δ and let f_t be the patchworking polynomial of f induced by λ . If the vector $(\alpha, \beta, 1) \in \mathbb{Z}^3$ is orthogonal to $\widetilde{E} \in T(\lambda)$ and $\gamma = -\min\{(\alpha, \beta, 1) \cdot v; v \in T(\lambda)\}$ then $h_{(\alpha, \beta, \gamma)}(f_t)$ is a perturbation of $f|_{\pi(\widetilde{E})}$.

Proof. Set $f(x,y) = \sum_{(i,j)\in\Delta} a_{i,j}x^iy^j \in \mathbb{R}[x,y]$. By Proposition 8.4, the patchworking polynomial

 $\widetilde{f}_t \text{ induced by } \widetilde{\lambda}(i,j) = \lambda(i,j) + i\alpha + j\beta \text{ satisfies } h_{(\alpha,\beta,0)}(f_t|_{\widetilde{E}}) = \widetilde{f}_t^{[r]} \text{ for } r = \min\{(\alpha,\beta,1) \cdot v; v \in T(\lambda)\} \in \mathbb{Z}. \text{ The polynomial } h_{(\alpha,\beta,-r)}(f_t)(x,y) = t^{-r}\widetilde{f}_t(t^\alpha x, t^\beta y) = \sum_{(i,j)\in\Delta} a_{i,j}t^{\lambda(i,j)+i\alpha+j\beta-r}x^iy^j \in C(\lambda)$

 $\mathbb{R}[t][x,y] \text{ is the patchworking polynomial } \widehat{f}_t \text{ induced by the convex function } \widehat{\lambda} : \Delta \to \mathbb{R}_{\geq 0},$ $\widehat{\lambda}(i,j) := \lambda(i,j) + i\alpha + j\beta - r. \text{ In particular, } h_{(\alpha,\beta,-r)}(f_t|_{\widetilde{E}}) = \widehat{f}_t^{[0]}. \text{ Expressing } \widehat{f}_t \text{ as the finite sum of level sets } \widehat{\lambda}^{-1}(r_0), \dots \widehat{\lambda}^{-1}(r_m) \text{ of } \widehat{\lambda} \text{ corresponding to the values } 0 = r_0 < r_1 < \dots < r_m,$ we have that $\widehat{f}_t(x,y) = f|_{\pi(\widetilde{E})} + t\varphi_t$, with $\varphi_t(x,y) = \sum_{l=1}^m a_{i,j} t^{r_l-1} \widehat{f}_t^{[r_l]}(x,y) \in \mathbb{R}[t][x,y], \text{ as wanted.}$ Let $\Delta \subset \mathbb{R}^2$ be a polyhedron with vertices in the integer lattice \mathbb{Z}^2 and let $f \in \mathbb{R}[x, y]$ be a polynomial with support in Δ . Let τ be the convex polyhedral subdivision of Δ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Denote by $TSPP(f, \lambda)^*$ the set of pairs

$$TSPP(f,\tau)^* := \bigcup_{E \in \tau} \{ (E,p); p \in TSSP(f|_E)^* \}.$$

Theorem 8.6. (Viro's Theorem for transversal special parabolic points) Let $\Delta \subset \mathbb{R}^2$ be a polyhedron with vertices in \mathbb{Z}^2 and let τ be the convex polyhedral subdivision of Δ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f \in \mathbb{R}[x, y]$ be a polynomial with non-singular Hessian curve, and support in Δ . If f_t is the patchworking polynomial of f induced by λ , then there exists $\delta > 0$ such that for $0 < |t| < \delta$, there is an inclusion

$$\varphi_t : TSPP(f,\tau)^* \hookrightarrow TSPP(f_t)^*.$$

Proof. Let $(\alpha, \beta, 1) \in \mathbb{Z}^3$ be an orthogonal vector to the face $\widetilde{E} \in T(\lambda)$ and let $r := -\min\{(\alpha, \beta, 1) \cdot v; v \in T(\lambda)\} \in \mathbb{Z}$. Then, by Theorem 8.5, the polynomial $h_{(\alpha,\beta,r)}(f_t)(x,y)$ defines a perturbation of $f|_E$, where $E = \pi(\widetilde{E})$ is in τ .

For each face E in τ , set $C_E := \pi(TSPP(f|_E)^*)$. Choose $\varepsilon > 0$ small enough such that, for any $q, q' \in C_E$, we have $D(q, \varepsilon), D(q', \varepsilon) \subset (\mathbb{R}^*)^2$ and $D(q, \varepsilon) \cap D(q', \varepsilon) \neq \emptyset$. By Corollary 5.5, there exists $\delta_1 > 0$ such that for $0 < |t| < \delta_1$ there is an inclusion

$$\psi_t^E : TSPP(f|_E)^* \hookrightarrow TSPP(h_{(\alpha,\beta,r)}(f_t))^*$$

satisfying $\pi(\psi_t^E(p)) \in D(\pi(p), \varepsilon)$. Thus, for each $q \in C_E$, $\pi(TSPP(h_{(\alpha,\beta,r)}(f_t))^* \cap D(q,\varepsilon) \neq \emptyset$. By Proposition 7.5, there exists $\delta_2 > 0$ such that for $0 < |t| < \delta_2$,

$$\left(\varphi_t^{(\alpha,\beta,r)}\right)^{-1}$$
: $TSPP(h_{(\alpha,\beta,r)}(f_t))^* \to TSPP(f_t)^*$

is a bijection. Hence, for $0 < |t| < \min\{\delta_1, \delta_2\}$, we have the inclusion

$$\varphi_t^E : TSPP(f|_E)^* \stackrel{\psi_t^E}{\hookrightarrow} TSPP(h_{(\alpha,\beta,r)}(f_t))^* \stackrel{(\varphi_t^{(\alpha,\beta,r)})^{-1}}{\longrightarrow} TSPP(f_t)^*.$$

By Proposition 6.2, there exists $\delta_3 > 0$, such that, for $|t| < \delta_3$, $\operatorname{Im}(\varphi_t^E) \cap \operatorname{Im}(\varphi_t^{E'}) = \emptyset$ for $E \neq E'$. Therefore, for $0 < |t| < \delta := \min\{\delta_1, \delta_2, \delta_3\}$, we obtain an inclusion

$$\varphi_t : TSPP(f,\tau)^* \hookrightarrow TSPP(f_t)^*.$$

Corollary 8.7. Let $\Delta \subset \mathbb{R}^2$ be a polyhedron with vertices in \mathbb{Z}^2 and let τ be the convex polyhedral subdivision of Δ induced by $\lambda : \Delta \to \mathbb{R}_{\geq 0}$. Let $f \in \mathbb{R}[x, y]$ be a polynomial with support in Δ . If f_t is the patchworking polynomial of f induced by λ , then there exists $\delta > 0$ such that for $0 < |t| < \delta$, we have

$$|TSPP(f,\tau)^*| \le |TSPP(f_t)^*|.$$

Proof. It follows from Theorem 8.6.

9 An Application of Corollary 8.7

In this section, we give an example to show how to use Corollary 8.7 to build families of polynomials with a prescribed number of transversal especial parabolic points.

Let $\Delta\{a, b, c\} \subset \mathbb{R}^2$ denote the triangle with vertices $a, b, c \in \mathbb{R}^2$. We will denote by

- $\Delta_d := \Delta\{(2,2), (d-2,2), (2,d-2)\},\$
- $\Delta^1_{(i,2)} := \Delta\{(i,2), (i+1,2), (i,3)\},\$
- $\Delta^2_{(k,l)} := \Delta\{(k+1,l), (k,l+1), (k,l+2)\},$ and
- $\Delta^3_{(k,l)} := \Delta\{(k+1,l), (k,l+2), (k+1,l+1)\}$

for $d, i, k, l \in \mathbb{Z}_{\geq 2}$.



The triangular subdivision τ of Δ_d obtained by dividing Δ_d into $\Delta_{(i,2)}^1, \Delta_{(k,l)}^2, \Delta_{(k,l)}^3$ with $i \in \{2, 3, \ldots, d\}$, $k \in \{2, 3, \ldots, d-2\}$ and $l \in \{2, \ldots, d-k-2\}$, is convex. This subdivision is induced by a convex function $\lambda : \Delta_d \to \mathbb{R}_{\geq 0}$ that has been used in several works, for example in [2] and [10]. Consider the polynomial types: $P_{(i,2)}^1(x,y) := x^i y^2 (1+x+y), P_{(k,l)}^2(x,y) := x^k y^l (x+y+y^2)$ and $P_{(k,l)}^3(x,y) := x^k y^l (x+xy+y^2)$, whose support lies in $\Delta_{(i,2)}^1, \Delta_{(k,l)}^2$ and $\Delta_{(k,l)}^3$, respectively.

Theorem 9.1. Let $f = x^2 y^2 g(x, y)$ be the degree d polynomial with support in the triangle Δ_d , where $g \in \mathbb{R}[x, y]$ is a complete polynomial of degree d-4. Let τ be the polyhedral subdivision induced by $\lambda : \Delta_d \to \mathbb{R}_{\geq 0}$ as above, and let $f_t \in \mathbb{R}[x, y]$ be the patchworking polynomial of finduced by λ . Then, for $d \leq 10,000$, there exists $\varepsilon > 0$ such that

$$|TSPP(f_t)^*| \ge (d-4)(2d-9)$$

for $0 < |t| < \varepsilon$.

Proof. The convex polytope $T(\lambda)$ is the union of d-2 triangular faces of type $\widetilde{\Delta}^1_{(i,2)}$ and $\frac{(d-4)^2-(d-4)}{2} = \frac{(d-5)(d-4)}{2}$ faces of type $\widetilde{\Delta}^2_{(k,l)}$ and $\widetilde{\Delta}^3_{(k,l)}$, respectively, whose proyections on the xy-plane are given by $\pi\left(\widetilde{\Delta}^1_{(i,2)}\right) = \Delta^1_{(i,2)}, \pi\left(\widetilde{\Delta}^2_{(k,l)}\right) = \Delta^2_{(k,l)}$ and $\pi\left(\widetilde{\Delta}^3_{(k,l)}\right) = \Delta^3_{(k,l)}$.

The restrictions of f to the faces in $T(\lambda)$ are equal to

$$f|_{\Delta^1_{(i,2)}} = P^1_{(i,2)}, \quad f|_{\Delta^2_{(k,l)}} = P^2_{(k,l)} \text{ and } f|_{\Delta^3_{(k,l)}} = P^3_{(k,l)}.$$

Using computer software Mathematica [18], we can see that, given $d \leq 10000$, $|TSPP(P_{(i,2)}^1)^*| = 1$ for $i \geq 2$, $|TSPP(P_{(k,l)}^2)^*| = 1$ and $|TSPP(P_{(k,l)}^3)^*| = 3$ for $k \in \{2, 3, \ldots, d-2\}$ and $l \in \{2, \ldots, d-k-2\}$. Corollary 8.7 guarantees that the number of transversal special parabolic points in the graph of $f_t \in \mathbb{R}[t][x, y]$ satisfies

$$|TSPP(f_t)^*| \ge 1(d-4) + 4\left(\frac{(d-5)(d-4)}{2}\right) = (d-4)(2d-9),$$

for sufficiently small values of $t \neq 0$.

Although we haven't found a proof of the fact that the inequality $|TSPP(P_{(k,l)}^3)^*| \geq 3$ holds for $k, l \in \mathbb{Z}_{\geq 2}$, we firmly believe that the bound we give in the statement of Theorem 9.1 works in general so the restriction on the degree can be removed from its hypotheses.
