ALTERNATIVE PROOF OF EXISTENCE OF GIBBS MEASURE AT HIGH TEMPERATURE

Abstract. Mathematical models in equilibrium statistical mechanics describe physical systems with many particles interacting with an external force and with one another. Gibbs measure is a fundamental concept in this theory. In existing literature infinite-volume models are constructed as limits of finite models and existence of Gibbs measure for them is proven through DLR formalism. The general existence proofs are quite complicated and involve topology and cluster expansion.

In this paper we develop a more transparent and more constructive proof of existence of infinite Gibbs measure for a particular case of interaction model at high temperature. The proof is based on a limiting procedure and involves estimates of series of semi-invariants and graph-related estimates.

1. INTRODUCTION

Mathematical models of statistical mechanics are described in many publications; see, for example, $[2]$, $[7]$, $[8]$, $[9]$, $[1]$ and $[12]$. A generalised model of a physical system with many particles is based on a probability space. When an infinite model is constructed as a limit of finite models, there occurs a problem of existence of its probability measure (Gibbs measure). The general mathematical proof of existence of Gibbs measure was constructed using DLR approach. It was described in several books: [\[11\]](#page-17-6), [\[10\]](#page-17-7), [\[8\]](#page-17-2), [\[3\]](#page-17-8), and in most general form in [\[4\]](#page-17-9). The general existence proof is quite complicated and involves topology, cluster expansion, and conditional probabilities.

In this paper we provide a straightforward existence proof for a less general model. In [\[5\]](#page-17-10) and [\[6\]](#page-17-11) we studied a concept of an interaction model. The interaction model describes an equilibrium physical system at high temperature with many particles interacting with an external force and with one another. In this paper we improve the concept of interaction model by giving a more general and detailed definition. For the infinite case of this model we prove existence of Gibbs measure as a limiting case of probability measures on the finite models. Our proof involves only basic probability, calculus and combinatorics, and is more transparent and constructive than the general proof. We believe that the constructions in this paper are of interest on their own even though the existence of infinite Gibbs measure is a well-known fact.

In Section [2](#page-1-0) we introduce a probability space and characteristics for a finite interaction model, and give a definition of this model. In Section [3](#page-3-0) we use some

estimations in graphs to describe one of interaction characteristics in a physical system (Lemma [3.11\)](#page-5-0). Next in this section we state Convergence Theorem and use it to construct an infinite interaction model; then we briefly justify that the Ising and Potts models are particular cases of the interaction model, and its generalization includes the n-model.

The remaining Sections [4](#page-8-0) and [5](#page-13-0) give a detailed proof of the Convergence Theorem. In particular, in Section [4](#page-8-0) we produce more graph-related estimations and apply them to semi-invariants and their series. In Section [5](#page-13-0) we show that the probability $P_N(A)$ of an event A in a finite model can be written as a series of semi-invariants. We finalise the proof of the Convergence Theorem in Section [5](#page-13-0) by proving absolute and uniform convergence of the aforementioned series for $P_N(A)$ and taking a limit as $N \to \infty$.

2. Finite Interaction Model

2.1. Gibbs Modification. Gibbs modification is used to modify a given probability in order to describe interaction between particles.

For any probability measure P on (Ω, Σ) denote $\langle \cdot \rangle_P$ the expectation with respect to P.

Definition 2.1. *Suppose* P *is a probability measure on* (Ω, Σ) *and* U *is a bounded random variable on* (Ω, Σ) *.*

Gibbs modification *of the probability measure* P *by the random variable* U *is denoted* P_U *and is defined as follows. For any event* $A \in \Sigma$ *:*

$$
P_U(A) = \frac{\langle I_A e^U \rangle_P}{\langle e^U \rangle_P},
$$

where I_A denotes the indicator of the event A .

Lemma 2.2. *In conditions of the previous definition:*

- *1)* P_U *is a probability measure on* (Ω, Σ) *;*
- *2)* for any random variable Y on (Ω, Σ) , $\langle Y \rangle_{P_U} = \frac{\langle Y e^U \rangle_P}{\langle e^U \rangle_P}$ $\frac{1}{\langle e^U \rangle_P}$.

Proof is well-known and can be found, for example, in [\[6\]](#page-17-11).

2.2. Construction of Probability Space.

Definition 2.3. *We introduce some objects that will be used to construct an interaction model.*

1) Fix a natural number $\nu \geq 1$ *and consider a v-dimensional integer lattice:*

$$
\mathbb{Z}^{\nu} = \{ \boldsymbol{t} = (t_1, \ldots, t_{\nu}) \mid t_i \in \mathbb{Z}, i = 1, \ldots, \nu \}
$$

with the distance between any two points $s, t \in \mathbb{Z}^{\nu}$ *defined by:*

$$
\|\bm{s} - \bm{t}\| = \sum_{i=1}^{\nu} |s_i - t_i|.
$$

2) For any $t \in \mathbb{Z}^{\nu}$ we denote $\Omega_t = \mathbb{R}$ and Σ_t the Borel σ -algebra on \mathbb{R} ; we fix a *probability measure* P_t *on* (Ω_t, Σ_t) *.*

We call $\{P_t, t \in \mathbb{Z}^{\nu}\}\$ *the initial probabilities.*

Definition 2.4. *1) By the Hahn-Kolmogorov theorem, for any integer*

 $k > 1$ and distinct $t_1, \ldots, t_k \in \mathbb{Z}^{\nu}$ there exists a unique probability space $(\Omega_{t_1} \times \ldots \times \Omega_{t_k}, \Sigma_{t_1...t_k}, P_{t_1...t_k})$, where $\Sigma_{t_1...t_k}$ is the σ -algebra generated by *elements of the Cartesian product* $\Sigma_{t_1} \times \ldots \times \Sigma_{t_k}$ *and the probability measure* P_{t_1,\ldots,t_k} *has the property:*

$$
P_{\mathbf{t}_1 \ldots \mathbf{t}_k}(F_1 \times \ldots \times F_k) = P_{\mathbf{t}_1}(F_1) \times \ldots \times P_{\mathbf{t}_k}(F_k)
$$

for any $F_i \in \Sigma_{t_i}$ $(i = 1, \ldots, k)$.

- *2)* By the Kolmogorov extension theorem, there exists a probability space (Ω, Σ, P_0) , *where the elements are described as follows.*
	- *(a)* $\Omega = \mathbb{R}^{\mathbb{Z}^{\nu}}$, that is $\Omega = {\omega \mid \omega : \mathbb{Z}^{\nu} \to \mathbb{R}}.$ *An element* ω *of* Ω *is called a configuration and is interpreted as a state of a physical system.*
	- *(b)* Σ *is the* $σ$ -algebra generated by sets of the form $\{ω ∈ Ω \mid ω(t) ∈ F\}$ for all $t \in \mathbb{Z}^{\nu}$ and $F \in \Sigma_t$.
	- *(c)* P_0 *is a unique probability measure on* (Ω, Σ) *such that for any integer* $k > 1$ *,* distinct $\mathbf{t}_1, \ldots, \mathbf{t}_k \in \mathbb{Z}^\nu$ and $F_1 \in \Sigma_{\mathbf{t}_1}, \ldots, F_k \in \Sigma_{\mathbf{t}_k}$:

$$
P_0(\omega(\mathbf{t}_1) \in F_1, \ldots, \omega(\mathbf{t}_k) \in F_k) = P_{\mathbf{t}_1 \ldots \mathbf{t}_k}(F_1 \times \ldots \times F_k).
$$

Thus, P_0 *is uniquely defined by the initial probabilities* $\{P_t, t \in \mathbb{Z}^{\nu}\}.$

3) For any $t \in \mathbb{Z}^{\nu}$ a function $X_t : \Omega \to \mathbb{R}$ is defined by the following:

$$
X_{t}(\omega)=\omega(t).
$$

 X *denotes* $\{X_t | t \in \omega\}.$

For the rest of the paper we fix the objects \mathbb{Z}^{ν} , (Ω, Σ, P_0) , and X from these definitions. For brevity we denote $\langle \cdot \rangle_{P_0}$ as $\langle \cdot \rangle_0$.

Lemma 2.5. $\{X_t | t \in \mathbb{Z}^{\nu}\}\$ is an independent random field on the probability space (Ω, Σ, P_0) .

Proof. Proof follows from the definitions. □

Definition 2.6. *1) Consider a* graph (V, E)*, where the set of vertices* V *is a finite subset of* Z ^ν *and* E *is the set of edges; each edge can be regarded as a pair of distinct vertices (there are no loops). The length of each edge is the distance between its end vertices.*

The graph (V, E) *is called* 1-connected *if it is connected and the length of any of its edges equals 1.*

2) For a finite set ^B [⊂] ^Z ^ν *with at least two elements define its* size S(B) *as the minimum number of edges of 1-connected graphs* (V, E) *such that* $B \subseteq V$ *.*

Remark. For any finite set B there is a cube in \mathbb{Z}^{ν} containing B; this cube with all its edges of length 1 is a 1-connected graph. So $S(B)$ is always defined.

Notation 2.7. For any finite subset B of \mathbb{Z}^{ν} denote Σ_B the σ -algebra generated *by sets of the form* $\{\omega \in \Omega \mid \omega(t) \in F\}$ *for all* $t \in B$ *and* $F \in \Sigma_t$ *.*

Definition 2.8. *Here we introduce three characteristics* λ , r , Φ *of an interaction model and a set* B*.*

- *1)* $\lambda \in \mathbb{R}, \lambda \geqslant 0$. λ *is inversely proportional to the temperature of the physical system.*
- *2)* $r \in \mathbb{R}, r \geq 1$ *. r is called the radius of interaction.*

3) Denote $\mathfrak{B} = \{ B \subset \mathbb{Z}^{\nu} \mid 1 \leqslant S(B) \leqslant r \}.$

4) For each $B \in \mathfrak{B}$, Φ_B is a random variable on (Ω, Σ_B) that satisfies the condition:

 $|\Phi_B| \leq \lambda$.

 Φ *denotes* $\{\Phi_B \mid B \in \mathfrak{B}\}\$. Φ *is called the potential of the system.*

Remarks. 1) Clearly, if $B \in \mathfrak{B}$, then B is finite.

2) Two particles (represented by points of \mathbb{Z}^{ν}) interact only if they both belong to some set B ($B \in \mathfrak{B}$), and Φ_B is the interaction energy of all elements of B.

3) In our definition of \mathfrak{B} we have only sets with $S(B) \geq 1$, i.e. sets with at least two elements. The general case (that includes one-element sets B) can be reduced to this case by a single Gibbs modification as shown in [\[6\]](#page-17-11), pg.343-344.

2.3. Finite Interaction Model.

Definition 2.9. *A finite interaction model with characteristics* λ , r , Φ , $\{P_t\}$ $t \in \mathbb{Z}^{\nu}$ *is a sequence* $(\Lambda, U_{\Lambda}, P_{\Lambda})$ *of three objects defined as follows.*

- *1)* Λ *is an arbitrary finite subset of the lattice* \mathbb{Z}^{ν} *.*
- *2) A* function $U_Λ$: $Ω → ℝ$ *is called the interaction energy of* Λ *and is defined by the following:*

for any
$$
\omega \in \Omega
$$
, $U_{\Lambda}(\omega) = \sum_{B \in \mathfrak{B}, B \subseteq \Lambda} \Phi_B(\omega)$,

where the set B *is defined in Definition [2.8.](#page-3-1)*

 $U_{\Lambda}(\omega)$ *characterizes the energy of configuration* ω *in* Λ *.*

3) Denote $P_{\Lambda} = (P_0)_{U_{\Lambda}}$, the Gibbs modification of the probability P_0 by the inter*action energy* UΛ*.*

In [\[6\]](#page-17-11) it was shown that $(\Omega, \Sigma, P_{\Lambda})$ is a probability space.

3. Infinite Interaction Model

3.1. Tracks in Graphs.

Definition 3.1. *A* track is a sequence $tr = (t_0, t_1, \ldots, t_n)$ of points in \mathbb{Z}^{ν} such *that* $t_0 = t_n$ *and* $||t_i - t_{i-1}|| = 1, i = 1, ..., n$ *.*

Lemma 3.2. *Fix* $t_0 \in \mathbb{Z}^{\nu}$ *and* $n > 1$ *. The number of tracks of the form* (t_0, t_1, \ldots, t_n) *is not greater than* $(2\nu)^{n-1}$ *.*

Proof. The first element t_0 is fixed. There are 2ν choices for element t_1 , at most 2ν choices for element t_2 , at most 2ν choices for element t_3, \ldots , and only one choice for element t_n , since $t_n = t_0$. So the total number of tracks is at most $(2\nu)^{n-1}$. \Box

Definition 3.3. Suppose B is a finite subset of \mathbb{Z}^{ν} and $m = S(B)$. There is a *1-connected graph* (V, E) *such that* $B \subseteq V$ *, and the number of edges in this graph is minimal and equals m. We denote* G_B *the first (in lexicographic order) of such graphs and call it the* associated graph *of* B*.*

Lemma 3.4. *Suppose* B *is a finite subset of* \mathbb{Z}^{ν} *and* $m = S(B)$ *. Then the graph* G_B *is a tree with* m *edges and* $m + 1$ *vertices.*

Proof. A tree is a connected graph with no cycles. The definition of size implies that G_B is connected.

If G_B has a cycle, then we can remove one edge of the cycle thus reducing the number of edges while the graph remains connected with the same set of vertices. That contradicts the choice of G_B as the graph with minimal number of edges.

By the definition G_B has m edges. Since it is a tree, the number of its vertices is $m + 1$.

Definition 3.5. *Suppose B is a finite subset of* \mathbb{Z}^{ν} *and* $m = S(B)$ *. We create the* associated track tr_B of B in the following two steps.

1. We obtain a graph G'_B from the associated graph G_B by adding for every its *edge another edge with the same ends.*

2. The new graph G'_B has $2m$ edges and each of its vertices has an even degree. *Therefore there is an Eulerian path in* G'_B *, i.e. a closed path that includes every edge of the graph exactly once. We denote* $(e_1, e_2, \ldots, e_{2m})$ *the first (in lexicographic order) of such paths.*

We define tr_B as the corresponding sequence $(t_0, t_1, t_2, \ldots, t_{2m})$ *of vertices, that is* $\{t_{i-1}, t_i\}$ *are the ends of* e_i $(i = 1, 2, ..., 2m)$ *.*

Definition 3.6. *Suppose* $B \in \mathcal{B}$ *. Its associated track has the form* $tr_B = (\mathbf{t}_0, \mathbf{t}_1, \mathbf{t}_2, \dots, \mathbf{t}_{2m})$, where $m = S(B)$ and $m \leq r$.

We define the extended track $tr'_B = (\boldsymbol{t}_0, \boldsymbol{t}_1, \boldsymbol{t}_2, \dots, \boldsymbol{t}_{2m}, \boldsymbol{t}_{2m+1}, \dots, \boldsymbol{t}_{2r})$ *of B by the following:*

- *for* $i = 1, \ldots, r-m$ *each point* t_{2m+i} *is obtained from* t_{2m+i-1} *by increasing its first coordinate by 1;*
- *for* $i = r m + 1, \ldots, 2r 2m$ *each point* t_{2m+i} *is obtained from* t_{2m+i-1} *by decreasing its first coordinate by 1.*

Lemma 3.7. *1)* For any finite subset B of \mathbb{Z}^{ν} , tr_B is a track. *2)* For any $B \in \mathfrak{B}$, tr'_B is a track.

Proof. Follows from the definitions. □

3.2. Estimations in Graphs.

Lemma 3.8. *Suppose* $tr = (\mathbf{t}_0, \mathbf{t}_1, \mathbf{t}_2, \dots, \mathbf{t}_{2r})$ *is a track. Then there are at most* 2^{2r-1} sets $C \in \mathfrak{B}$ such that $t_0 \in C$ and $tr'_C = tr$.

Proof. Since the track tr is a closed path, we have $t_0 = t_{2r}$. Denote V_1 = $\{\boldsymbol{t}_1, \boldsymbol{t}_2, \ldots, \boldsymbol{t}_{2r-1}\}$. If a set $C \in \mathfrak{B}$ has $tr'_C = tr$, then

$$
(1) \tC \setminus \{t_0\} \subseteq V_1.
$$

Since V_1 has at most 2^{2r-1} different subsets, so there are at most 2^{2r-1} sets C with property [\(1\)](#page-4-0). \Box

Lemma 3.9. Suppose $t_0 \in \mathbb{Z}^{\nu}$. Then there are at most $(4\nu)^{2r-1}$ sets $C \in \mathfrak{B}$ with $t_0 \in C$.

Proof. For each set $C \in \mathfrak{B}$ with $t_0 \in C$ we have an extended track tr'_C ; since a track is a closed path, we can assume tr_C' starts at t_0 . So there is a correspondence between sets $C \in \mathfrak{B}$ with $t_0 \in C$ and tracks of the form $(t_0, t_1, \ldots, t_{2r})$. By Lemma [3.8](#page-4-1) at most 2^{2r-1} sets correspond to each track and by Lemma [3.2](#page-3-2) the total number of such tracks starting at t_0 is not greater than $(2\nu)^{2r-1}$. Therefore the number of sets $C \in \mathfrak{B}$ with $t_0 \in C$ is not greater than $2^{2r-1}(2\nu)^{2r-1} = (4\nu)^{2r-1}$ \Box **Definition 3.10.** *1. For any* $B \in \mathcal{B}$ *denote* $l(B)$ *the number of sets* $C \in \mathcal{B}$ *that intersect with* B*.*

2. Denote $L = max\{l(B) | B \in \mathfrak{B}\}.$

Clearly, L depends only on ν and r.

Lemma 3.11. *In the interaction model the number* L *is defined and*

$$
L \leqslant (4\nu)^{2r-1}(r+1).
$$

Proof. Fix an arbitrary $B \in \mathfrak{B}$. It is sufficient to show:

$$
l(B) \leqslant (4\nu)^{2r-1}(r+1).
$$

Since $S(B) \leq r$, we have $|B| \leq r + 1$. Any set $C \in \mathfrak{B}$ that intersects with B contains one of the $(r + 1)$ elements of B. By Lemma [3.9,](#page-4-2) for each element $t_0 \in B$ there are at most $(4\nu)^{2r-1}$ sets $C \in \mathfrak{B}$ with $t_0 \in C$. So the total number of sets $C \in \mathfrak{B}$ that intersect with B is not greater than $(4\nu)^{2r-1}(r+1)$.

Remarks. 1) L is a characteristic of interaction in the physical system.

2) We did not aim to obtain the most accurate estimate of L. However, it is not hard to get more accurate estimates in particular cases. For example, in the Ising, Potts and n-vector models $L = 4\nu - 1$ because in these models only neighboring points in \mathbb{Z}^{ν} interact, i.e. each set in \mathfrak{B} is a set of two neighboring points.

3.3. Convergence Theorem.

Definition 3.12. *Define* $\lambda_0 = \frac{1}{50 L(S)}$ $\frac{1}{50L(8\nu)^{2r}}$, where L was introduced in Definition *[3.10.](#page-5-1)2.*

Clearly, λ_0 depends only on ν and r .

Notation 3.13. For any $N \in \mathbb{N}$ denote a cube in \mathbb{Z}^{ν} :

$$
\Lambda_N = \{ \mathbf{t} = (t_1, \ldots, t_\nu) \in \mathbb{Z}^\nu \mid |t_i| \leq N \text{ for each } i = 1, \ldots, \nu \}.
$$

Notation 3.14. *Suppose* Q *is a finite subset of* \mathbb{Z}^{ν} *and its size* $q = S(Q)$ *. 1)* Denote $\mathbb{N}_Q = \{ N \in \mathbb{N} \mid Q \subseteq \Lambda_N \}$ *. For any* $N \in \mathbb{N}_Q$ *:*

- $(\Lambda_N, U_{\Lambda_N}, P_{\Lambda_N})$ *is the finite interaction model with characteristics* λ *, r*, Φ *,* ${P_{t} | t \in \mathbb{Z}^{\nu}}$ *from Definition [2.9;](#page-3-3)*
- • *for brevity denote* $U_N = U_{\Lambda_N}$ *and* $P_N = P_{\Lambda_N}$ *.*

2) For any $A \in \Sigma_Q$ define:

(2)
$$
P_{\lambda,Q}(A) = \lim_{N \to \infty} P_N(A).
$$

Theorem 3.15 (Convergence Theorem). *Suppose* $0 \le \lambda \le \lambda_0$. Then the following *hold.*

1) For any finite set $Q \subset \mathbb{Z}^{\nu}$ and any $A \in \Sigma_Q$ the limit in [\(2\)](#page-5-2) exists.

2) $P_{\lambda,Q}$ *is a probability measure on* (Ω,Σ_Q) *.*

This theorem will be proven in Sections [4](#page-8-0) and [5.](#page-13-0)

Corollary 3.16. *Suppose* $0 \le \lambda \le \lambda_0$ *. There exists a unique probability measure* P_{λ} *on* (Ω, Σ) *such that for any finite set* $Q \subset \mathbb{Z}^{\nu}$ *and any* $A \in \Sigma_Q$ *:*

$$
P_{\lambda}(A) = P_{\lambda,Q}(A).
$$

Proof. For any integer $k > 1$, distinct $t_1, \ldots, t_k \in \mathbb{Z}^{\nu}$ and $F_i \in \Sigma_{t_i}$ $(i = 1, \ldots, k)$ denote

 $P_{\lambda,\boldsymbol{t}_1...\boldsymbol{t}_k}(F_1\times \ldots \times F_k)=P_{\lambda,\{\boldsymbol{t}_1,...,\boldsymbol{t}_k\}}(\mathcal{F}_1\cap \ldots \cap \mathcal{F}_k),$ where $\mathcal{F}_i = {\omega \in \Omega \mid \omega(\mathbf{t}_i) \in F_i}, i = 1, \ldots, k.$

By Theorem [3.15.](#page-5-3)2), each $P_{\lambda, \{t_1,\ldots,t_k\}}$ is a probability measure on $(\Omega, \Sigma_{\{t_1,\ldots,t_k\}})$. Then each $P_{\lambda, t_1...t_k}$ is a probability measure on $(\Omega_{t_1} \times ... \times \Omega_{t_k}, \Sigma_{t_1...t_k})$ that was introduced in Definition [2.4.](#page-2-0)1). These probabilities satisfy the following two consistency conditions.

1) For any distinct $t_1, \ldots, t_k \in \mathbb{Z}^{\nu}$, permutation π of $\{1, 2, \ldots, k\}$, and $F_i \in \Sigma_{t_i}$ $(i = 1, \ldots, k)$:

$$
P_{\lambda,\mathbf{t}_{\pi(1)}\ldots\mathbf{t}_{\pi(k)}}(F_{\pi(1)}\times\ldots\times F_{\pi(k)})=P_{\lambda,\mathbf{t}_1\ldots\mathbf{t}_k}(F_1\times\ldots\times F_k).
$$

2) For any distinct $t_1, \ldots, t_k, t_{k+1} \in \mathbb{Z}^{\nu}$ and $F_i \in \Sigma_{t_i}$ $(i = 1, \ldots, k)$:

$$
P_{\lambda, \mathbf{t}_1 \ldots \mathbf{t}_k}(F_1 \times \cdots \times F_k) = P_{\lambda, \mathbf{t}_1 \ldots \mathbf{t}_k \mathbf{t}_{k+1}}(F_1 \times \cdots \times F_k \times \mathbb{R}).
$$

Hence the corollary follows from the Kolmogorov extension theorem. \Box

The probability measure P_{λ} is called the **Gibbs measure.**

3.4. Infinite Interaction Model.

Definition 3.17. *Suppose* $0 \le \lambda \le \lambda_0$ *. A infinite interaction model with characteristics* λ , r , Φ , $\{P_t \mid t \in \mathbb{Z}^{\nu}\}\$ is the probability space $(\Omega, \Sigma, P_{\lambda})$, where P_{λ} *is the probability measure from Corollary [3.16.](#page-6-0)*

The probability space $(\Omega, \Sigma, P_\lambda)$ *is also called the thermodynamic limit or* **macroscopic limit** of the finite interaction models (Λ_N, U_N, P_N) as $N \to \infty$.

Next we show that several well-known models can be considered as particular cases of the interaction model.

3.5. Potts model as a particular case of interaction model. The standard Potts model is based on the interaction energy (also called Hamiltonian):

$$
U_\Lambda = \sum_{\substack{\pmb{s}, \pmb{t} \in \Lambda \\ \|\pmb{s} - \pmb{t}\|=1}} J_{\pmb{st}} \delta(X_{\pmb{s}}, X_{\pmb{t}}),
$$

where J_{st} are coupling constants and the random variables X_t (interpreted as site colors) take values $1, 2, \ldots, q$ with equal probabilities;

$$
\delta(x, y) = \begin{cases} 1 \text{ if } x = y, \\ 0 \text{ if } x \neq y. \end{cases}
$$

Applying Definition [2.8](#page-3-1) we take an arbitrary $\nu \geq 1$, an arbitrary $\lambda \geq 0$, $r = 1$, and the probabilities $\{P_t \mid t \in \mathbb{Z}^{\nu}\}$ such that for any Borel set A:

$$
P_{t}(A) = \frac{|A \cap \{1, 2, \dots, q\}|}{q},
$$

where the numerator is the cardinality of the set $A \cap \{1, 2, ..., q\}$.

Since $r = 1$, then $\mathfrak{B} = \{ \{s, t\} \subset \mathbb{Z}^{\nu} \mid ||s - t|| = 1 \}$ and for any $B \in \mathfrak{B}$ with $B = \{s, t\}$:

$$
\Phi_B(\omega) = \lambda K_{st} \delta(\omega(s), \omega(t)),
$$

where $|K_{st}| \leq 1$.

When $0 \le \lambda \le \lambda_0$ and $N \to \infty$ (i.e. $\Lambda \to \mathbb{Z}^{\nu}$), the Potts model becomes a particular case of the infinite interaction model.

3.6. Ising model as a particular case of interaction model. The Ising model is equivalent to the Potts model for $q = 2$. The Ising model is based on the interaction energy:

$$
U_{\Lambda} = \sum_{\substack{\boldsymbol{s}, \boldsymbol{t} \in \Lambda \\ \|\boldsymbol{s} - \boldsymbol{t}\| = 1}} J_{\boldsymbol{s}\boldsymbol{t}} X_{\boldsymbol{s}} X_{\boldsymbol{t}} - \sum_{\boldsymbol{t} \in \Lambda} h_{\boldsymbol{t}} X_{\boldsymbol{t}},
$$

where J_{st} , h_t are constants and the random variables X_t take values ± 1 with equal probabilities.

To eliminate the second sum in U_{Λ} (representing an external magnetic field) we apply a single Gibbs modification described in [\[6\]](#page-17-11), pg.343-344, and get the probabilities $\{P_t | t \in \mathbb{Z}^{\nu}\}\$ such that for any Borel set A:

(3)
$$
P_t(A) = \frac{1}{e^{h_t} + e^{-h_t}} \sum_{\substack{x \in A \\ x = \pm 1}} e^{-xh_t}.
$$

Applying Definition [2.8](#page-3-1) we take an arbitrary $\nu \geq 1$, an arbitrary $\lambda \geq 0$, the probabilities $\{P_t \mid t \in \mathbb{Z}^{\nu}\}\$ given by [\(3\)](#page-7-0), and $r = 1$.

Then $\mathfrak{B} = \{ \{s, t\} \subset \mathbb{Z}^{\nu} \mid ||s - t|| = 1 \}$ and for any $B \in \mathfrak{B}$ with $B = \{s, t\}$:

$$
\Phi_B(\omega) = \lambda K_{st} \omega(s) \omega(t),
$$

where $|K_{st}| \leq 1$.

When $0 \le \lambda \le \lambda_0$ and $N \to \infty$ (i.e. $\Lambda \to \mathbb{Z}^{\nu}$), the Ising model becomes a particular case of the infinite interaction model.

3.7. **n-vector model.** In the *n*-vector model classical spins s_i ($i \in \mathbb{Z}^{\nu}$) are *n*dimensional vectors with unit length; the interaction energy of the n -vector model is given by:

$$
U_{\Lambda} = -J \sum_{\substack{i,j \in \Lambda \\ \|i-j\|=1}} \mathbf{s}_i \cdot \mathbf{s}_j,
$$

where \cdot denotes scalar product.

Our interaction model can be easily generalised to the case when X_t has values in \mathbb{R}^n : in Definition [2.3](#page-1-1) we take $\Omega_t = \mathbb{R}^n$ and Σ_t as the Borel σ -algebra on \mathbb{R}^n . The construction of Definition [2.4](#page-2-0) still applies producing $\Omega = \{ \omega \mid \omega : \mathbb{Z}^{\nu} \to \mathbb{R}^{n} \}$. It can be shown that the n-vector model is a particular case of this generalised interaction model, similarly to the process in the previous two subsections.

Particular cases of the *n*-vector model are the Ising model $(n = 1)$, XY model $(n = 2)$, and Heisenberg model $(n = 3)$.

4. Technical Definitions and Estimations

The rest of the paper is devoted to the proof of the Convergence Theorem (Theo-rem [3.15\)](#page-5-3). For the rest of the paper we fix Ω , Σ , characteristics λ , r , Φ , $\{P_t \mid t \in \mathbb{Z}^{\nu}\},$ a finite set $Q \subset \mathbb{Z}^{\nu}$ with size $q = S(Q)$, and an event $A \in \Sigma_Q$. We will consider only integers $N \in \mathbb{N}_Q$.

Section [4](#page-8-0) contains some technical concepts and lemmas, which lead to the proof of the Convergence Theorem in Section [5.](#page-13-0)

4.1. **Semi-Invariants.** Denote $\langle \cdot, \ldots, \cdot \rangle_0$ a semi-invariant with respect to the probability measure P_0 . The definition and properties of semi-invariants are described in literature, see for example [\[9\]](#page-17-3) and references in it.

Notation 4.1. *For a random variable Y on* (Ω, Σ) *and a sequence* $\gamma = (B_1, \ldots,$ Bn) *of elements of* B *denote*

$$
\langle Y, \Phi_{\gamma} \rangle_0 = \langle Y, \Phi_{B_1}, \Phi_{B_2}, \dots, \Phi_{B_n} \rangle_0.
$$

If
$$
n = 0
$$
, then $\langle Y, \Phi_{B_1}, \dots, \Phi_{B_n} \rangle_0 = \langle Y \rangle_0$.

Definition 4.2. *A sequence* $\gamma = (B_0, B_1, ..., B_n)$ *of subsets of* \mathbb{Z}^{ν} *is called con*nected *if the following graph is connected:*

a) its set of **vertices** is $\{0, 1, \ldots, n\}$;

b) a pair of vertices i, j is connected with an edge if and only if $B_i \cap B_j \neq \emptyset$.

Lemma 4.3. *Suppose* $B_1, \ldots, B_n \in \mathfrak{B}$ *and the sequence* (Q, B_1, \ldots, B_n) *is not connected. Then*

$$
\langle I_A, \Phi_{B_1}, \ldots, \Phi_{B_n} \rangle_0 = 0.
$$

Proof. Proof can be found in [\[8\]](#page-17-2), page 29 (property C). \Box

4.2. Families.

Definition 4.4. *1) A* family *(of elements of* B*) is a set of pairs*

 $\Gamma = \{ (C_1, n_1), \ldots, (C_k, n_k) \},$ where C_1, \ldots, C_k are distinct elements of **B** and $n_i \geqslant 1$ *for each* $i = 1, \ldots, k$.

- *2)* The number n_i is called the **multiplicity** of element C_i in the family Γ .
- *3)* We denote the **length** of the family Γ as $|\Gamma| = n_1 + n_2 + \ldots + n_k$ and

$$
\Gamma! = n_1! \cdot n_2! \cdot \ldots \cdot n_k!
$$

$$
\text{4) } u_j(\Gamma) = \sum_{j:C_i \cap C_j \neq \varnothing} n_j. \text{ Clearly, } u_j(\Gamma) \geqslant n_j.
$$

5) For a random variable Y *on* (Ω, Σ) *denote*

$$
\langle Y, \Phi_{\Gamma} \rangle_0 = \langle Y, \underbrace{\Phi_{C_1}, \dots, \Phi_{C_1}}_{n_1 \text{ times}}, \dots, \underbrace{\Phi_{C_k}, \dots, \Phi_{C_k}}_{n_k \text{ times}} \rangle_0.
$$

6) The family $\Gamma = \{ (C_1, n_1), \ldots, (C_k, n_k) \}$ *is called Q-connected if the sequence* (Q, C_1, \ldots, C_k) *is connected.*

Definition 4.5. We say that a sequence $\gamma = (B_1, \ldots, B_n)$ reduces to a family $\{(C_1,n_1),\ldots,(C_k,n_k)\}\text{, if } C_1,\ldots,C_k \text{ are the elements } B_1,\ldots,B_n \text{ written without }$ *repetitions, and each* n_i *is the number of times that* C_i *is repeated in* γ *.*

Clearly, $n_1 + ... + n_k = n$.

Lemma 4.6. *For each family* Γ *of length n there are* $\frac{n!}{\Gamma!}$ *sequences that reduce to* Γ*.*

Proof. The lemma follows from the definitions and combinatorics.

Lemma 4.7. *If a sequence* γ *reduces to a family* Γ, *then*

 $\langle Y, \Phi_{\gamma} \rangle_0 = \langle Y, \Phi_{\Gamma} \rangle_0.$

Proof. The lemma follows from the fact that the value of a semi-invariant does not does depend on the order of random variables.

In the following two subsections we produce some estimates, which will be used to prove convergence in Section [5.](#page-13-0) We are not looking for most accurate estimates, since we are not interested in the speed of the convergence.

4.3. Estimating the Number of Families.

Lemma 4.8. Fix a natural number $n > 1$. The number of all Q-connected *families* Γ *of length n is less than* $2^{2q} (2(8\nu)^{2r})^n$.

Proof. Denote ∗ the operation of concatenation of two arbitrary sequences. Thus, for sequences $\alpha = (\alpha_0, \ldots, \alpha_m)$ and $\tau = (\tau_0, \ldots, \tau_l)$:

$$
\alpha * \tau = (\alpha_0, \ldots, \alpha_m, \tau_0, \ldots, \tau_l).
$$

We also denote:

$$
\alpha * \Big|_{j} \tau = (\alpha_0, \ldots, \alpha_j, \tau_0, \ldots, \tau_l, \alpha_{j+1}, \ldots, \alpha_m); j = 1, \ldots, m,
$$

which means inserting the sequence τ between two consecutive elements of α . Clearly,

$$
\alpha * \Big|_{m} \tau = \alpha * \tau.
$$

Denote $h = 2q$ and $p = 2r$. Fix the associated track tr_Q of the set Q :

$$
tr_Q=(\boldsymbol{t}_{00},\ldots,\boldsymbol{t}_{0h}).
$$

For each Q-connected family Γ we will construct a sequence Tr_{Γ} as follows. Consider a Q-connected family $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$ of length n. By induction on j $(j = 0, 1, ..., k)$ we will construct a track Tr_j and a sequence of pairs Tr_j . *Case* $j = 0$.

Define

$$
Tr_0=tr_Q \text{ and } \widetilde{Tr}_0=((a_{00},\boldsymbol{t}_{00}),\ldots,(a_{0h},\boldsymbol{t}_{0h}))\text{, where } a_{0i}=\left\{\begin{array}{ll} 0 \text{ if } \boldsymbol{t}_{0i} \notin Q, \\ 1 \text{ if } \boldsymbol{t}_{0i} \in Q.\end{array}\right.
$$

Inductive Step. Assume we have constructed a track Tr_{j-1} and a sequence Tr_{i-1} . Due to connectedness,

$$
(Q\cup C_1\cup\ldots\cup C_{j-1})\cap\left(\bigcup_{i=j}^k C_i\right)\neq\varnothing.
$$

Select t_{β_i} as the first element of the track Tr_{j-1} that belongs to this intersection (but not the start element of Tr_{j-1}). Without loss of generality we can assume

$$
\boldsymbol{t}_{\beta_j}\in (Q\cup C_1\cup\ldots\cup C_{j-1})\cap C_j.
$$

Choose an extended track tr_j of the set C_j : $tr_j = (\mathbf{t}_{j0}, \mathbf{t}_{j1}, \dots, \mathbf{t}_{jp})$. Since the track is a closed path, we can assume it starts at the point $\mathbf{t}_{\beta_j}: \mathbf{t}_{j0} = \mathbf{t}_{\beta_j}$. Define

$$
Tr_j=Tr_{j-1}*\Big|_{\beta_j}({\boldsymbol{t}}_{j1},\ldots,{\boldsymbol{t}}_{jp}).
$$

Denote Tr'_{j-1} the sequence Tr_{j-1} , where the element with index β_j is changed from (a, t) to $(n_i + 1, t)$.

Define

$$
\widetilde{Tr}_j = Tr'_{j-1} * \Big|_{\beta_j} ((a_{j1}, \boldsymbol{t}_{j1}), \ldots, (a_{jp}, \boldsymbol{t}_{jp})) \,, \text{ where } a_{ji} = \left\{ \begin{array}{ll} 0 & \text{if } \boldsymbol{t}_{ji} \notin C_j, \\ 1 & \text{if } \boldsymbol{t}_{ji} \in C_j. \end{array} \right.
$$

At the end of this process we take $Tr_{\Gamma} = \widetilde{Tr}_k$.

Next we estimate the number of sequences of the form Tr_{Γ} . A sequence Tr_{Γ} Tr_k has $(1 + h + kp)$ elements; each of these elements is a pair of a number and a point in \mathbb{Z}^{ν} . The $(1+h)$ points of tr_Q are fixed. For each of the remaining kp points there are at most 2ν choices, so there are at most $(2\nu)^{kp} \leq (2\nu)^{np}$ ways to choose second elements of the pairs in Tr_{Γ} .

Next we estimate the number of choices for first elements of the pairs in Tr_{Γ} . There are $\binom{n+k-1}{k-1}$ ways to split n into a sum $n = n_1 + \ldots + n_k$. If n_1, \ldots, n_k are chosen, there are $\binom{h+kp}{k}$ ways to assign the numbers

 $(n_1 + 1), \ldots, (n_k + 1)$ to first elements of some of the pairs in Tr_{Γ} . There are 2^{kp-k} ways to assign 0 and 1 to first elements of the remaining pairs (since the points of tr_Q are fixed). So the total number of choices for first elements of the pairs in Tr_{Γ} is at most

$$
\sum_{k=1}^{n} {n+k-1 \choose k-1} \cdot {h+kp \choose k} \cdot 2^{kp-k} \leq \sum_{k=1}^{n} 2^{n+k-1} \cdot 2^{h+kp} \cdot 2^{kp-k}
$$

= $2^{n+h-1} \sum_{k=1}^{n} 2^{2kp} \leq 2^{n+h-1} \sum_{j=1}^{2np} 2^j < 2^{n+h-1} \cdot 2^{2np+1} = 2^h \cdot 2^{n(2p+1)}$.

So the total number of sequences of the form Tr_{Γ} is less than

$$
(2\nu)^{np} \cdot 2^h \cdot 2^{n(2p+1)} = 2^h \left(2^{3p+1} \nu^p\right)^n = 2^h \left(2(8\nu)^p\right)^n = 2^{2q} \left(2(8\nu)^{2r}\right)^n
$$

In order to prove the same estimation for the number of Q -connected families Γ with $|\Gamma| = n$ it is sufficient to show that a family Γ can be restored from a sequence Tr_{Γ} and it is unique (then each Tr_{Γ} corresponds to only one Γ).

Consider one of the previously constructed sequences and denote it Tr . We will restore the family Γ such that $Tr = Tr_{\Gamma}$. Tr is a sequence of pairs that contains a sequence $((b_{00}, t_{00}), \ldots, (b_{0h}, t_{0h}))$ corresponding to the sequence $tr_Q =$ $(t_{00},..., t_{0h})$. We can assume that the sequence Tr starts with the pair $(1, t_{00})$.

Denote k the number of the pairs in Tr , whose first elements are greater than 1, and denote these first elements m_1, \ldots, m_k . Then $n_i = m_i - 1$ $(i = 1, \ldots, k)$, according to our construction. So $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$. It remains to find the sets C_j (j = 1, ..., k). We will restore each set C_j and each sequence Tr_{j-1} by induction on $k - j$.

Case $k - j = 0$.

Then $j = k$; $\widetilde{Tr}_k = Tr$. Find the last pair in \widetilde{Tr}_k , whose first element is greater than 1, and next p pairs in \widetilde{Tr}_k . Then \widetilde{Tr}_{k-1} is obtained from the sequence \widetilde{Tr}_k

.

by removing all these pairs and C_k is the set of all second elements of these pairs that have 1 on the first place.

Inductive Step. Assume we have restored sets C_k, \ldots, C_{j+1} and a sequence Tr_j . Find the last pair in Tr_j , whose first element is greater than 1, and next p pairs in Tr_j . Then Tr_{j-1} is obtained from the sequence Tr_j by removing all these pairs and C_j is the set of all second elements of these pairs that have 1 on the first place.

Clearly, this induction process produces the unique family $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$ with $Tr_{\Gamma} = Tr.$

4.4. Estimation of Semi-Invariants.

Lemma 4.9. *For any* Q-connected family $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}$ of length n:

$$
|\langle I_A, \Phi_{\Gamma} \rangle_0| \leqslant \frac{9}{2} P_0(A) \lambda^n (n+1) 3^n \prod_{j=1}^k (u_j+1)^{n_j},
$$

where each $u_j = u_j(\Gamma)$.

Proof. Let us fix a sequence $\gamma = (B_1, \ldots, B_n)$ that reduces to Γ (such a sequence always exists, according to Lemma [4.6\)](#page-9-0). Denote $\gamma' = (Q, B_1, \ldots, B_n)$.

For $i = 1, 2, ..., n$ denote v_i the number of elements of γ' that intersect with B_i . Denote v_0 the number of elements of γ' that intersect with Q .

 I_A and all Φ_{B_i} are random variables on (Ω, Σ) . According to Lemma [4.7](#page-9-1) and Theorem 1 in [\[8\]](#page-17-2), pg. 69,

$$
|\langle I_A, \Phi_{\Gamma} \rangle_0| = |\langle I_A, \Phi_{\gamma} \rangle_0| \le C_f \cdot \frac{3}{2} \prod_{i=0}^n (3v_i).
$$

Here $C_f = \max \Big| \langle I_A \cdot \prod_{i \in M_1} \Phi_{B_i} \rangle_0 \langle \prod_{i \in M_2} \Phi_{B_i} \rangle_0 \dots \langle \prod_{i \in M_l} \Phi_{B_i} \rangle_0 \Big|,$

where the maximum is taken over all partitions $\{\{0\} \cup M_1, M_2, \ldots, M_l\}$ of the set $\{0, 1, 2, \ldots, n\}.$

Each $|\Phi_{B_i}| \leq \lambda$, so $C_f \leq P_0(A)\lambda^n$. Hence

$$
|\langle I_A, \Phi_{\Gamma} \rangle_0| \le P_0(A)\lambda^n \cdot \frac{3}{2} \prod_{i=0}^n (3v_i) = \frac{3}{2} P_0(A)\lambda^n 3^{n+1} \prod_{i=0}^n v_i = \frac{9}{2} P_0(A)\lambda^n 3^n \prod_{i=0}^n v_i.
$$

For $j = 1, 2, ..., k$ denote w_j the number of elements of γ' that intersect with C_j . Each C_j is repeated n_j times in γ , so

$$
\prod_{i=0}^{n} v_i = v_0 \prod_{i=1}^{n} v_i = v_0 \prod_{j=1}^{k} (w_j)^{n_j}.
$$

Since $v_0 \leq n+1$ and each $w_j \leq u_j+1$, we have:

$$
\prod_{i=0}^{n} v_i \leqslant (n+1) \prod_{j=1}^{k} (u_j + 1)^{n_j} \text{ and}
$$

$$
|\langle I_A, \Phi_{\Gamma} \rangle_0| \leqslant \frac{9}{2} P_0(A) \lambda^n 3^n (n+1) \prod_{j=1}^{k} (u_j + 1)^{n_j}.
$$

Lemma 4.10. *For any* Q-connected family $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}$ of length n*:*

$$
\prod_{j=1}^{k} (u_j + 1)^{n_j} < (eL)^n \prod_{j=1}^{k} (n_j)^{n_j},
$$

where each $u_j = u_j(\Gamma)$.

Proof.

$$
u_j + 1 = \left(1 + \frac{1}{u_j}\right)u_j
$$

and

(4)
$$
\prod_{j=1}^{k} (u_j + 1)^{n_j} = \prod_{j=1}^{k} \left(1 + \frac{1}{u_j}\right)^{n_j} \prod_{j=1}^{k} u_j^{n_j}.
$$

From Definition 4.4 we get $n_j \leqslant u_j,$ so

$$
\prod_{j=1}^{k} \left(1 + \frac{1}{u_j}\right)^{n_j} \leq \prod_{j=1}^{k} \left(1 + \frac{1}{n_j}\right)^{n_j} < \prod_{j=1}^{k} e = e^k \leqslant e^n.
$$

Thus,

(5)
$$
\prod_{j=1}^{k} \left(1 + \frac{1}{u_j}\right)^{n_j} < e^n.
$$

By Theorem 4.1 in [\[5\]](#page-17-10) we have:

(6)
$$
\sum_{j=1}^{k} \left(n_j \ln \frac{u_j}{n_j} \right) \leqslant n \ln L.
$$

Since

$$
\prod_{j=1}^k \left(\frac{u_j}{n_j}\right)^{n_j} = e^{\sum_{j=1}^k \left(n_j \ln \frac{u_j}{n_j}\right)},
$$

we imply from [\(6\)](#page-12-0):

$$
\prod_{j=1}^k \left(\frac{u_j}{n_j}\right)^{n_j} \leqslant e^{n \ln L} = L^n.
$$

So

(7)
$$
\prod_{j=1}^{k} u_j^{n_j} \leq L^n \prod_{j=1}^{k} n_j^{n_j}.
$$

From (4) , (5) and (7) we get:

$$
\prod_{j=1}^k (u_j + 1)^{n_j} < e^n L^n \prod_{j=1}^k n_j^{n_j} = (eL)^n \prod_{j=1}^k n_j^{n_j}.
$$

Lemma 4.11. *Suppose* Γ *is a Q-connected family of length* n *and* $n > 3$ *. Then* $|\langle I_A, \Phi_\Gamma \rangle_0| < P_0(A) \lambda^n (3e^2L)^n (n+1)\Gamma!$

 \Box

Proof. By Lemmas [4.9](#page-11-0) and [4.10,](#page-12-4)

$$
|\langle I_A, \Phi_{\Gamma} \rangle_0| \leqslant \frac{9}{2} P_0(A) \lambda^n (n+1) 3^n \prod_{j=1}^k (u_j+1)^{n_j} < \frac{9}{2} P_0(A) \lambda^n (n+1) 3^n (eL)^n \prod_{j=1}^k n_j^{n_j}
$$
\nBy Stirling formula,

\n
$$
q^q < \frac{1}{\sqrt{2\pi q}} q! e^q \text{ for any natural } q > 0.
$$
\nSo

.

$$
\begin{split} |\langle I_A, \Phi_{\Gamma} \rangle_0| &< \frac{9}{2} P_0(A) \lambda^n (n+1) (3eL)^n \prod_{j=1}^k \left(\frac{1}{\sqrt{2\pi n_j}} n_j! \, e^{n_j} \right) \\ &\leqslant \frac{9}{2} P_0(A) \lambda^n (3eL)^n (n+1) \frac{1}{(2\pi)^{\frac{k}{2}} \sqrt{n_1 n_2 \dots n_k}} \, e^n \prod_{j=1}^k n_j! \\ &= P_0(A) \lambda^n (3e^2L)^n (n+1) \frac{9}{2(2\pi)^{\frac{k}{2}} \sqrt{n_1 n_2 \dots n_k}} \, \Gamma! \end{split}
$$

since $\Gamma! = \prod^k$ $\prod_{j=1} n_j!$. It remains to prove:

$$
\frac{9}{2(2\pi)^{\frac{k}{2}}\sqrt{n_1n_2\ldots n_k}} < 1.
$$

Consider two cases.

Case 1.
$$
k = 1
$$
.
\nThen $n_1 = n \ge 4$, $(2\pi)^{k/2} = \sqrt{2\pi} > 2.5$ and
\n
$$
\frac{9}{2(2\pi)^{\frac{k}{2}}\sqrt{n_1 n_2 ... n_k}} = \frac{9}{2\sqrt{2\pi}\sqrt{n_1}} < \frac{9}{2 \times 2.5 \times 2} < 1.
$$
\nCase 2. $k \ge 2$.
\nThen $(2\pi)^{k/2} \ge 2\pi > 6$ and $\frac{9}{2(2\pi)^{k/2}\sqrt{n_1 n_2 ... n_k}} < \frac{9}{2 \cdot 6 \cdot 1} < 1$.

5. Proof of the Convergence Theorem

Here we use results from the previous section to prove Theorem [3.15.](#page-5-3)

Notation 5.1. *Denote*

$$
J_A(N,n) = \sum_{\Gamma} \frac{1}{\Gamma!} \langle I_A, \Phi_{\Gamma} \rangle_0,
$$

where the sum is taken over all Q-connected families $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$ *of length n such that each* $C_i \subseteq \Lambda_N$ *.*

Lemma 5.2. *Suppose* $0 \le \lambda \le \lambda_0$ *. Then*

$$
P_N(A) = \sum_{n=0}^{\infty} J_A(N, n).
$$

Proof. Fix λ such that $0 \le \lambda \le \lambda_0$. We use the method from [\[8\]](#page-17-2), page 34. For real x, z define

$$
f(x, z) = \ln \langle \exp(xI_A + zU_N) \rangle_0.
$$

By the definition of semi-invariants:

$$
\frac{\langle I_A e^{zU_N} \rangle_0}{\langle e^{zU_N} \rangle_0} = \frac{\partial}{\partial x} f(x, z) \Big|_{x=0} = \sum_{n=0}^{\infty} \frac{z^n}{n!} \langle I_A, \underbrace{U_N, \dots, U_N}_{n \text{ times}} \rangle_0
$$

$$
= \sum_{n=0}^{\infty} \frac{z^n}{n!} \langle I_A, \sum_{B_1 \in \mathfrak{B}, B_1 \subseteq \Lambda_N} \Phi_{B_1}, \dots, \sum_{B_n \in \mathfrak{B}, B_n \subseteq \Lambda_N} \Phi_{B_n} \rangle_0
$$

$$
= \sum_{n=0}^{\infty} \frac{z^n}{n!} \sum_{\substack{B_1, \dots, B_n, \\ \text{each } B_i \in \mathfrak{B}, B_i \subseteq \Lambda_N}} \langle I_A, \Phi_{B_1}, \dots, \Phi_{B_n} \rangle_0.
$$

Thus,

$$
\frac{\langle I_A e^{zU_N}\rangle_0}{\langle e^{zU_N}\rangle_0} = \sum_{n=0}^{\infty} \frac{z^n}{n!} \sum_{\gamma} \langle I_A, \Phi_{\gamma} \rangle_0,
$$

where the inner sum is taken over all sequences $\gamma = \{B_1, \ldots, B_n\}$ such that each $B_i \in \mathfrak{B}$ and $B_i \subseteq \Lambda_N$.

Substituting $z = 1$ and using the definition of P_N , we get:

$$
P_N(A) = \frac{\langle I_A e^{U_N} \rangle_0}{\langle e^{U_N} \rangle_0} = \sum_{n=0}^{\infty} \frac{1}{n!} \sum_{\gamma} \langle I_A, \Phi_{\gamma} \rangle_0.
$$

By Lemma [4.3,](#page-8-1) the inner sum can be taken only over sequences $\gamma = (B_1, ..., B_n)$ of elements of \mathfrak{B} such that $(Q, B_1, ..., B_n)$ is connected and each $B_i \subseteq \Lambda_N$.

By Lemmas [4.6](#page-9-0) and [4.7:](#page-9-1)

$$
P_N(A) = \sum_{n=0}^{\infty} \frac{1}{n!} \sum_{\gamma} \langle I_A, \Phi_{\gamma} \rangle_0 = \sum_{n=0}^{\infty} \frac{1}{n!} \sum_{\Gamma} \frac{n!}{\Gamma!} \langle I_A, \Phi_{\Gamma} \rangle_0 = \sum_{n=0}^{\infty} \sum_{\Gamma} \frac{1}{\Gamma!} \langle I_A, \Phi_{\Gamma} \rangle_0.
$$

The first inner sum has only sequences $\gamma = (B_1, \ldots, B_n)$ such that (Q, B_1, \ldots, B_n) are connected. Therefore the last inner sum has only Q-connected families Γ and

$$
P_N(A) = \sum_{n=0}^{\infty} J_A(N, n).
$$

Lemma 5.3. *Suppose* $0 \le \lambda \le \lambda_0$ *and* $n > 3$ *. Then*

$$
\Bigl|J_A(N,n)\Bigr|\leqslant 2^{2q}P_0(A)0.9^n(n+1).
$$

Proof. Suppose $0 \le \lambda \le \lambda_0$ and $n > 3$.

$$
\left| J_A(N,n) \right| \leqslant \sum_{\Gamma} \frac{1}{\Gamma!} \left| \langle I_A, \Phi_{\Gamma} \rangle_0 \right|,
$$

where the sum is taken over all Q-connected families $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$ of length n (we omit the restriction $C_i \subseteq \Lambda_N$). By Lemma [4.8](#page-9-2) the number of addends in this sum is less than $2^{2q} (2(8\nu)^{2r})^{\overline{n}}$.

By Lemma [4.11,](#page-12-5)

$$
\Big|\langle I_A, \Phi_\Gamma\rangle_0\Big|\leqslant P_0(A)(n+1)\lambda^n(3e^2L)^n\Gamma!
$$

and

$$
\left|J_A(N,n)\right| \leqslant \sum_{\Gamma} \frac{1}{\Gamma!} P_0(A)(n+1)\lambda^n (3e^2L)^n \Gamma! = \sum_{\Gamma} P_0(A)(n+1)\lambda^n (3e^2L)^n
$$

$$
\leqslant 2^{2q} \left(2(8\nu)^{2r}\right)^n P_0(A)(n+1)\lambda^n (3e^2L)^n = 2^{2q} P_0(A)(n+1) \left[\lambda \cdot 6e^2L(8\nu)^{2r}\right]^n.
$$

Since $0 \leqslant \lambda \leqslant \lambda_0$, then by the Definition 3.12 of λ_0 we have:

$$
\lambda \cdot 6e^2 L(8\nu)^{2r} \le \lambda_0 \cdot 6e^2 L(8\nu)^{2r} = \frac{6e^2}{50} < 0.9
$$
 and

$$
|J_A(N,n)| \le 2^{2q} P_0(A)(n+1)0.9^n.
$$

Lemma 5.4. *Suppose* $0 \le \lambda \le \lambda_0$ *. Then the series*

$$
\sum_{n=0}^{\infty} J_A(N, n)
$$

converges absolutely and uniformly for all $N \in \mathbb{N}_Q$.

Proof. This follows from Lemma [5.3,](#page-14-0) since the series $\sum_{n=0}^{\infty} 0.9^n(n+1)$ converges. \Box

Lemma 5.5. *Suppose* $0 \le \lambda \le \lambda_0$ *. Then for any n the following limit exists:*

$$
\lim_{N \to \infty} J_A(N, n).
$$

Proof. Denote $\mathbf{0} = (0, \ldots, 0)$, the origin in \mathbb{Z}^{ν} , and $d = \min\{\|\mathbf{t} - \mathbf{0}\| \; | \mathbf{t} \in Q\}$; d is the distance of the set Q from the origin.

For any *n* denote $M_n = r(n + 1) + q + d$. We will prove that for any $N \geq M_n$:

(8)
$$
J_A(N,n) = J_A(M_n,n).
$$

Then for any fixed n, $\lim_{N \to \infty} J_A(N, n)$ exists and $\lim_{N \to \infty} J_A(N, n) = J_A(M_n, n)$.

Proof of [\(8\)](#page-15-0)

Consider any $N \geqslant M_n$. Then $\Lambda_{M_n} \subseteq \Lambda_N$, which implies the following.

(9) If $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$ is a Q -connected family of length n

such that each $C_i \subseteq \Lambda_{M_n}$, then each $C_i \subseteq \Lambda_N$.

 \Box

It remains to prove:

(10) If
$$
\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}
$$
 is a Q -connected family of length n
such that each $C_i \subseteq \Lambda_N$, then each $C_i \subseteq \Lambda_{M_n}$.

Then from [\(9\)](#page-15-1) and [\(10\)](#page-15-2) we imply that $J_A(N, n)$ and $J_A(M_n, n)$ are sums over the same set of families Γ. Hence $J_A(N,n) = J_A(M_n,n)$.

Proof of [\(10\)](#page-15-2)

Consider a Q-connected family $\Gamma = \{(C_1, n_1), \ldots, (C_k, n_k)\}\$ of length n such that each $C_i \subseteq \Lambda_N$. Fix $i = 1, ..., k$. To prove that $C_i \subseteq \Lambda_{M_n}$, we fix an arbitrary $t \in C_i$ and prove that $t \in \Lambda_{M_n}$.

For some $t_0 \in Q$, $d = ||t_0 - \mathbf{0}||$. Since (Q, C_1, \ldots, C_n) is connected, there are a subsequence (C_{j_1},\ldots,C_{j_m}) of the sequence (C_1,\ldots,C_k) and points $\bm{t}_1,\bm{t}_2,\ldots,\bm{t}_m,\bm{t}_{m+1}$ such that

$$
\mathbf{t}_1 \in C_i \cap C_{j_1}, \ \mathbf{t}_2 \in C_{j_1} \cap C_{j_2}, \ \ldots, \mathbf{t}_m \in C_{j_{m-1}} \cap C_{j_m}, \text{ and } \mathbf{t}_{m+1} \in C_{j_m} \cap Q.
$$

Then
$$
m \leq k \leq n
$$
 and

$$
||\boldsymbol{t}-\boldsymbol{0}|| \leq ||\boldsymbol{t}-\boldsymbol{t}_1|| + ||\boldsymbol{t}_1-\boldsymbol{t}_2|| + \ldots + ||\boldsymbol{t}_m-\boldsymbol{t}_{m+1}|| + ||\boldsymbol{t}_{m+1}-\boldsymbol{t}_0|| + ||\boldsymbol{t}_0-\boldsymbol{0}||
$$

$$
\leq r(m+1)+q+d \leq r(n+1)+q+d=M_n.
$$

So $\|\boldsymbol{t} - \boldsymbol{0}\| \leqslant M_n$ and $\boldsymbol{t} \in \Lambda_{M_n}$. .

Proof of Theorem [3.15](#page-5-3)

Proof. 1. Suppose $0 \le \lambda \le \lambda_0$. By Lemma [5.2,](#page-13-1)

(11)
$$
P_N(A) = \sum_{n=0}^{\infty} J_A(N, n).
$$

Due to Lemmas [5.4,](#page-15-3) [5.5](#page-15-4) and a property of uniform convergence, $\lim_{N\to\infty} P_N(A)$ exists and

(12)
$$
P_{\lambda,Q}(A) = \lim_{N \to \infty} P_N(A) = \sum_{n=0}^{\infty} \lim_{N \to \infty} J_A(N,n).
$$

2. To prove that P_{λ} is a probability measure on (Ω, Σ_Q) we check three probability axioms.

$$
P_{\lambda,Q}(\varnothing) = \lim_{N \to \infty} P_N(\varnothing) = \lim_{N \to \infty} 0 = 0.
$$

$$
P_{\lambda,Q}(\Omega) = \lim_{N \to \infty} P_N(\Omega) = \lim_{N \to \infty} 1 = 1.
$$

To complete the proof it remains to check the axiom of σ -additivity. Consider a sequence of disjoint events $A_i \in \Sigma_Q$ $(i = 1, 2, ...)$ and denote $D = \bigcup_{i=1}^{\infty}$ $\bigcup_{i=1} A_i$. By [\(11\)](#page-16-0),

(13)
$$
P_N(D) = \sum_{i=1}^{\infty} P_N(A_i) = \sum_{i=1}^{\infty} \sum_{n=0}^{\infty} J_{A_i}(N, n).
$$

By Lemma [5.3,](#page-14-0) for $n > 3$ and $i = 1, 2, ...,$

$$
|J_{A_i}(N,n)| \leq 2^{2q} P_0(A_i) 0.9^n (n+1).
$$

Since for $0 < x < 1$, $\sum_{n=0}^{\infty} x^n (n+1) = \frac{1}{(1 - x)^n}$ $\frac{1}{(1-x)^2}$, we have:

$$
\sum_{i=1}^{\infty} \sum_{n=0}^{\infty} 2^{2q} P_0(A_i) 0.9^n (n+1) = 2^{2q} \sum_{i=1}^{\infty} P_0(A_i) \sum_{n=0}^{\infty} 0.9^n (n+1)
$$

=
$$
2^{2q} \sum_{i=1}^{\infty} P_0(A_i) \frac{1}{(1-0.9)^2} = 2^{2q} 100 \sum_{i=1}^{\infty} P_0(A_i) = 2^{2q} 100 P_0(D).
$$

So the series on the right-hand side of [\(13\)](#page-16-1) converges absolutely and uniformly for all $N \in \mathbb{N}_Q$. Taking a limit in [\(13\)](#page-16-1) and using [\(12\)](#page-16-2), we get:

$$
P_{\lambda,Q}(D) = \lim_{N \to \infty} P_N(D) = \sum_{i=1}^{\infty} \sum_{n=0}^{\infty} \lim_{N \to \infty} J_{A_i}(N,n) = \sum_{i=1}^{\infty} P_{\lambda,Q}(A_i).
$$

This proves that

$$
P_{\lambda,Q}\left(\bigcup_{i=1}^{\infty} A_i\right) = \sum_{i=1}^{\infty} P_{\lambda,Q}(A_i).
$$

\Box
