COMPLETING PERFECT COMPLEXES

Abstract. This note proposes a new method to complete a triangulated category, which is based on the notion of a Cauchy sequence. We apply this to categories of perfect complexes. It is shown that the bounded derived category of finitely presented modules over a right coherent ring is the completion of the category of perfect complexes. The result extends to non-affine noetherian schemes and gives rise to a direct construction of the singularity category. The parallel theory of completion for abelian categories is compatible with the completion of derived categories.

There are three appendices. The first one by Tobias Barthel discusses the completion of perfect complexes for ring spectra. The second one by Tobias Barthel and Henning Krause refines for a separated noetherian scheme the description of the bounded derived category of coherent sheaves as a completion. The final appendix by Bernhard Keller introduces the concept of a morphic enhancement for triangulated categories and provides a foundation for completing a triangulated category.

1. INTRODUCTION

This note proposes a new method to complete a triangulated category, and we apply this to categories of perfect complexes [\[17\]](#page-35-0). For any category \mathcal{C} , we introduce its *sequential completion* \hat{e} , which is a categorical analogue of the construction of the real numbers from the rationals via equivalence classes of Cauchy sequences, following Cantor and Méray $[5, 27]$ $[5, 27]$.

When a ring Λ is right coherent, then the category mod Λ of finitely presented modules is abelian and one can consider its bounded derived category $\mathbf{D}^b(\text{mod }\Lambda)$, which contains the category of perfect complexes $\mathbf{D}^{\text{per}}(\Lambda)$ as a full triangulated subcategory. The following theorem describes $\mathbf{D}^b(\text{mod }\Lambda)$ as a completion of $\mathbf{D}^{\text{per}}(\Lambda)$.

Theorem 1.1. *For a right coherent ring* Λ *there is a canonical triangle equivalence*

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\Lambda)}^b \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\mathrm{mod}\,\Lambda)
$$

which sends a Cauchy sequence in $\mathbf{D}^{\text{per}}(\Lambda)$ *to its colimit.*

The description of $\mathbf{D}^b(\text{mod }\Lambda)$ as a completion extends to non-affine schemes. Thus for a noetherian scheme X there is a canonical triangle equivalence

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\mathbb{X})}^b \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\operatorname{coh} \mathbb{X}).
$$

In particular, this provides a direct construction of the singularity category (in the sense of Buchweitz and Orlov [\[3,](#page-35-2) [37\]](#page-36-1)) as the Verdier quotient

$$
\frac{\widehat{\mathbf{D}^{\mathrm{per}}(\mathbb{X})}^b}{\mathbf{D}^{\mathrm{per}}(\mathbb{X})}.
$$

The completion \hat{C} of a category C comes with an embedding $C \to \hat{C}$ so that the objects in \hat{C} are precisely the colimits of Cauchy sequences in C, and \hat{C} identifies with a full subcategory of the ind-completion of $\mathfrak C$ in the sense of Grothendieck and Verdier [\[14\]](#page-35-3).

When C is triangulated, there is a natural finiteness condition such that C inherits a triangulated structure with exact triangles given as colimits of Cauchy sequences of exact triangles in C. This involves the notion of a phantom morphism and Milnor's exact sequence [\[28\]](#page-36-2). In order to explain this, let us assume for simplicity that C identifies with the full subcategory of compact objects of a compactly generated triangulated category T. Fix a class X of sequences $X_0 \to X_1 \to X_2 \to \cdots$ in C that is stable under suspensions. We consider their homotopy colimits and have

$$
\text{Ph}(\text{hocolim } X_i, \text{hocolim } Y_j) = 0 \quad \text{for all} \quad X, Y \in \mathfrak{X}
$$

if and only if

$$
\lim_i \frac{1}{i} \operatorname{colim}_{j} \operatorname{Hom}(X_i, Y_j) = 0 \quad \text{for all} \quad X, Y \in \mathfrak{X},
$$

where Ph(U, V) denotes the set of phantom morphisms $U \to V$. It is this finiteness condition which is satisfied for categories of perfect complexes, and it enables us to establish a triangulated structure for the completion of C with respect to X .

The idea of completing a triangulated category C is not new; the method is always to identify the completion $\mathcal D$ with a category of certain cohomological functors $\mathbb{C}^{op} \to$ Ab. Note that the category of all cohomological functors is equivalent to the ind-completion of C. In most cases, C identifies with the category of compact objects of a compactly generated triangulated category \mathcal{T} , and \mathcal{D} is another triangulated subcategory of T. Let us mention the paper of Neeman [\[29\]](#page-36-3) that addresses the question when a category of cohomological functors carries the structure of a triangulated category. In [\[38\]](#page-36-4), Rouquier identifies various natural choices of cohomological functors $\mathbb{C}^{op} \to Ab$. The recent work of Neeman [\[34,](#page-36-5) [35\]](#page-36-6) employs the notion of 'approximability'; it is crucial for understanding the case of non-affine schemes and recommended as an alternative approach via Cauchy sequences.

We also include a discussion of completions for abelian categories. Again, some finiteness condition is needed so that the completion is abelian. For instance, we show for a noetherian algebra Λ over a complete local ring that the completion of the category fl Λ of finite length modules identifies with the category of artinian Λ-modules. Using Matlis duality, this yields for $\Gamma = \Lambda^{\rm op}$ triangle equivalences

$$
\mathbf{D}^b(\operatorname{mod} \Lambda)^{\rm op} \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\widehat{\mathrm{fl}\,\Gamma}) \stackrel{\sim}{\longrightarrow} \widehat{\mathbf{D}^b(\mathrm{fl}\,\Gamma)}^b.
$$

This paper has three appendices. The first one by Tobias Barthel discusses completions for stable homotopy categories. In particular, we see that Theorem [1.1](#page-0-0) generalises to ring spectra.

The second one by Tobias Barthel and Henning Krause refines for a separated noetherian scheme the description of the bounded derived category of coherent sheaves as a completion. It is shown that the objects are precisely the colimits of Cauchy sequences of perfect complexes that satisfy an intrinsic boundedness condition.

In the final appendix, Bernhard Keller introduces the notion of a *morphic enhancement* of a triangulated category, following [\[19\]](#page-35-4). This allows us to capture the notion of standard triangle and of coherent morphism between standard triangles, generalising analogous approaches via stable model categories or stable derivators. Morphic enhancements provide a setting for turning a completion into a triangulated category. In fact, we see that in Theorem [1.1](#page-0-0) the completion of the morphic enhancement of $\mathbf{D}^{\text{per}}(\Lambda)$ identifies with the morphic enhancement of $\mathbf{D}^b(\text{mod }\Lambda)$.

After completion of this work, Neeman published a survey [\[36\]](#page-36-7) which discusses metrics in triangulated categories, following work of Lawvere from the 1970s. Completing with respect to such metrics yields an alternative method of completing triangulated categories; it does not depend on an enhancement and we recommend a comparison.

2. The sequential completion of a category

Let $\mathbb{N} = \{0, 1, 2, \ldots\}$ denote the set of natural numbers, viewed as a category with a single morphism $i \rightarrow j$ if $i \leq j$.

Now fix a category $\mathcal C$ and consider the category $\text{Fun}(\mathbb N, \mathcal C)$ of functors $\mathbb N \to \mathcal C$. An object X is nothing but a sequence of morphisms $X_0 \to X_1 \to X_2 \to \cdots$ in C, and the morphisms between functors are by definition the natural transformations. We call X a *Cauchy sequence* if for all $C \in \mathcal{C}$ the induced map $\text{Hom}(C, X_i) \rightarrow$ Hom (C, X_{i+1}) is invertible for $i \gg 0$. This means:

$$
\forall C \in \mathcal{C} \; \exists n_C \in \mathbb{N} \; \forall j \ge i \ge n_C \; \text{Hom}(C, X_i) \xrightarrow{\sim} \text{Hom}(C, X_j).
$$

Let $\text{Cauch}(\mathbb{N}, \mathbb{C})$ denote the full subcategory consisting of all Cauchy sequences. A morphism $X \to Y$ is *eventually invertible* if for all $C \in \mathcal{C}$ the induced map $Hom(C, X_i) \to Hom(C, Y_i)$ is invertible for $i \gg 0$. This means:

$$
\forall C \in \mathcal{C} \; \exists n_C \in \mathbb{N} \; \forall i \geq n_C \; \text{Hom}(C, X_i) \xrightarrow{\sim} \text{Hom}(C, Y_i).
$$

Let S denote the class of eventually invertible morphisms in Cauch(\mathbb{N}, \mathcal{C}).

Definition 2.1. The *sequential completion* of C is the category

$$
\widehat{\mathcal{C}} := \mathrm{Cauch}(\mathbb{N}, \mathcal{C})[S^{-1}]
$$

that is obtained from the Cauchy sequences by formally inverting all eventually invertible morphisms, together with the *canonical functor* $C \rightarrow \hat{C}$ that sends an object X in C to the constant sequence $X \stackrel{\text{id}}{\rightarrow} X \stackrel{\text{id}}{\rightarrow} \cdots$.

A sequence $X\colon\mathbb{N}\to\mathbb{C}$ induces a functor

 $\widetilde{X}: \mathcal{C}^{\mathrm{op}} \longrightarrow \text{Set}, \quad C \mapsto \operatornamewithlimits{colim}_{i} \text{Hom}(C, X_{i}),$

and this yields a functor

$$
\widehat{\mathcal{C}} \longrightarrow \text{Fun}(\mathcal{C}^{\text{op}}, \text{Set}), \quad X \mapsto \widetilde{X},
$$

because the assignment $X \mapsto \widetilde{X}$ maps eventually invertible morphisms to isomorphisms. We will show that this functor is fully faithful.

Let D be a category and S a class of morphisms in D . There is an explicit description of the localisation D[S −1] provided that the class S *admits a calculus of left fractions* in the sense of [\[12\]](#page-35-5), that is, the following conditions are satisfied:

- (LF1) The identity morphism of each object is in S. The composition of two morphisms in S is again in S .
- (LF2) Each pair of morphisms $X' \stackrel{\sigma}{\leftarrow} X \rightarrow Y$ with $\sigma \in S$ can be completed to a commutative diagram

such that $\tau \in S$.

(LF3) Let $\alpha, \beta \colon X \to Y$ be morphisms. If there is $\sigma \colon X' \to X$ in S such that $\alpha \sigma = \beta \sigma$, then there is $\tau \colon Y \to Y'$ in S such that $\tau \alpha = \tau \beta$.

If S admits a calculus of left fractions, then the morphisms in $\mathcal{D}[S^{-1}]$ are of the form $\sigma^{-1}\alpha$ given by a pair of morphisms $X \stackrel{\alpha}{\to} Y' \stackrel{\sigma}{\leftarrow} Y$ in $\mathcal D$ with $\sigma \in S$, where we identify a morphism in $\mathcal D$ with its image under the canonical functor $\mathcal D \to \mathcal D[S^{-1}]$. For pairs (α_1, σ_1) and (α_2, σ_2) we have $\sigma_1^{-1}\alpha_1 = \sigma_2^{-1}\alpha_2$ in $\mathcal{D}[S^{-1}]$ if and only if there exists a commutative diagram

with σ in S; see [\[12\]](#page-35-5).

Lemma 2.2. *The eventually invertible morphisms in* Cauch(N, C) *admit a calculus of left fractions.*

We need some preparations for the proof of this lemma. Given functors $f: \mathbb{N} \to \mathbb{N}$ and $X: \mathbb{N} \to \mathbb{C}$, let X_f denote the composite $X \circ f$. Call f *cofinal* if $n \leq f(n)$ for all $n \in \mathbb{N}$. In this case there is a natural morphism $f_X: X \to X_f$.

A straightforward computation of filtered colimits in Set yields the following.

Lemma 2.3. *Let* $X, Y : \mathbb{N} \to \mathbb{C}$ *be functors.*

- (1) *Given a morphism* $\phi: \widetilde{X} \to \widetilde{Y}$ *, there exists a cofinal* $f: \mathbb{N} \to \mathbb{N}$ *and a morphism* $\alpha: X \to Y_f$ *such that* $\widetilde{f_Y} \phi = \widetilde{\alpha}$ *.*
- (2) *Given morphisms* $\alpha, \beta \colon X \to Y$ *such that* $\tilde{\alpha} = \tilde{\beta}$ *, there exists a cofinal* $f: \mathbb{N} \to \mathbb{N}$ *such* $f_Y \alpha = f_Y \beta$.

Proof. (1) Fix $n \in \mathbb{N}$ and suppose f has been defined for all $m < n$. There exists $n' \geq \max(n, f(n-1))$ and $\alpha_n: X_n \to Y_{n'}$ such that the composite

$$
\operatorname{Hom}(X_n,X_n)\to \operatorname{colim}_i \operatorname{Hom}(X_n,X_i)\xrightarrow{\phi} \operatorname{colim}_i \operatorname{Hom}(X_n,Y_i)
$$

maps id_{X_n} to the image of α_n under $\mathrm{Hom}(X_n, Y_{n'}) \to \mathrm{colim}_i \mathrm{Hom}(X_n, Y_i)$. We set $f(n) = n'$ and can make this choice consistent such that the α_n yield a morphism $X \to Y_f$.

(2) Fix $n \in \mathbb{N}$ and suppose f has been defined for all $m \leq n$. The fact that α and β induce the same map colim_i Hom $(X_n, X_i) \to \text{colim}_i \text{Hom}(X_n, Y_i)$ yields $n' \geq \max(n, f(n-1))$ such that $\text{Hom}(X_n, Y_n) \to \text{Hom}(X_n, Y_{n'})$ maps α_n and β_n to the same element. Then set $f(n) = n'$.

Let S denote the class of eventually invertible morphisms. If $X: \mathbb{N} \to \mathbb{C}$ is Cauchy and $f: \mathbb{N} \to \mathbb{N}$ is cofinal, then X_f is Cauchy and the canonical morphism $f_X: X \to X_f$ is in S. Moreover, for any $\sigma: X \to Y$ in S there exists a cofinal $f: \mathbb{N} \to \mathbb{N}$ and a morphism $\sigma' : Y \to X_f$ such that $\sigma' \sigma = f_X$. This follows by applying Lemma [2.3](#page-3-0) to $\tilde{\sigma}^{-1}$.

Proof of Lemma [2.2.](#page-3-1) The condition (LF1) is clear. To check (LF2) fix a pair of morphisms $X' \xleftarrow{\sigma} X \xrightarrow{\alpha} Y$ with $\sigma \in S$. Choose $\sigma' : X' \to X_f$ such that $\sigma' \sigma = f_X$. Then we obtain the following commutative square with $f_Y \in S$.

To check (LF3) fix a pair of morphisms $\alpha, \beta \colon X \to Y$. Let $\sigma \colon X' \to X$ in S such that $\alpha \sigma = \beta \sigma$. This implies $\tilde{\alpha} = \tilde{\beta}$, and it follows from Lemma [2.3](#page-3-0) that there exists a cofinal $f : \mathbb{N} \to \mathbb{N}$ such that $f \circ \alpha = f \circ \beta$. Note that $f \circ \epsilon S$. a cofinal $f: \mathbb{N} \to \mathbb{N}$ such that $f_Y \alpha = f_Y \beta$. Note that $f_Y \in S$.

Proposition 2.4. *The canonical functor* $\hat{C} \rightarrow \text{Fun}(\mathcal{C}^{\text{op}}, \text{Set})$ *is fully faithful; it identifies* \hat{e} *with the colimits of sequences of representable functors that correspond to Cauchy sequences in* C. Also, the canonical functor $C \rightarrow \widehat{C}$ *is fully faithful.*

Proof. We use the fact that the class S of eventually invertible morphisms in Cauch(N, C) admits a calculus of left fractions. Then every morphism in \hat{C} is of the form $\sigma^{-1}\alpha$ given by a pair of morphisms $X \stackrel{\alpha}{\to} Y' \stackrel{\sigma}{\leftarrow} Y$ in Cauch(N, C) with $\sigma \in S$.

Fix Cauchy sequences $X, Y \colon \mathbb{N} \to \mathbb{C}$. We need to show that the canonical map

 $Hom(X, Y) \longrightarrow Hom(\widetilde{X}, \widetilde{Y}), \quad \sigma^{-1}\alpha \mapsto \widetilde{\sigma}^{-1}\widetilde{\alpha},$

is a bijection. The map is surjective, because Lemma [2.3](#page-3-0) yields for any morphism $\phi \colon \widetilde{X} \to \widetilde{Y}$ a cofinal $f \colon \mathbb{N} \to \mathbb{N}$ and $\alpha \colon X \to Y_f$ such that $\phi = \widetilde{f_Y}^{-1} \widetilde{\alpha}$. Now fix a pair of morphisms $\sigma_1^{-1} \alpha_1$ and $\sigma_2^{-1} \alpha_2$ in \hat{e} such that $\widetilde{\sigma_1}^{-1} \widetilde{\alpha_1} = \widetilde{\sigma_2}^{-1} \widetilde{\alpha_2}$. Use (LF2) to complete σ_1 and σ_2 to a commutative diagram

$$
\begin{array}{ccc}\nY & \xrightarrow{\sigma_2} & Y'' \\
\sigma_1 & & \downarrow{\tau_2} \\
Y' & \xrightarrow{\tau_1} & Z\n\end{array}
$$

with $\tau_1, \tau_2 \in S$. Then we have $\widetilde{\tau_1 \alpha_1} = \widetilde{\tau_2 \alpha_2}$ and there exists a cofinal $f : \mathbb{N} \to \mathbb{N}$ such that $f_Z \tau_1 \alpha_1 = f_Z \tau_2 \alpha_2$. This implies $\sigma_1^{-1} \alpha_1 = \sigma_2^{-1} \alpha_2$ in \widehat{C} .

Colimits in Fun(\mathcal{C}^{op} , Set) are computed 'pointwise'. Thus for X in Fun(\mathbb{N}, \mathcal{C}) the functor \overline{X} is the colimit of the sequence

$$
Hom(-, X_0) \to Hom(-, X_1) \to Hom(-, X_2) \to \cdots
$$

in Fun($\mathcal{C}^{\mathrm{op}}$, Set). It follows that $\hat{\mathcal{C}}$ identifies with the colimits of sequences of representable functors that correspond to Cauchy sequences in C.

Finally, the canonical functor $C \to \widehat{C}$ is fully faithful, since the composition with \to Fun(C^{op} , Set) is fully faithful by Yoneda's lemma. $\widehat{\mathcal{C}} \to \text{Fun}(\mathcal{C}^{\text{op}}, \text{Set})$ is fully faithful by Yoneda's lemma.

Corollary 2.5. *For* $X, Y \in \hat{\mathcal{C}}$ *we have a natural bijection*

 $\text{Hom}(X, Y) \xrightarrow{\sim} \lim_{i} \text{colim}_{j} \text{Hom}(X_i, Y_j).$

Proof. Combining Proposition [2.4](#page-4-0) and Yoneda's lemma, we have

$$
\text{Hom}(X, Y) \cong \text{Hom}(\text{colim Hom}(-, X_i), \text{colim Hom}(-, Y_j))
$$
\n
$$
\cong \lim_{i} \text{Hom}(\text{Hom}(-, X_i), \text{colim Hom}(-, Y_j))
$$
\n
$$
\cong \lim_{i} \text{colim Hom}(X_i, Y_j).
$$

Call C *sequentially complete* if every Cauchy sequence in C has a colimit in C. Clearly, C is sequentially complete if and only if the canonical functor $C \rightarrow \widehat{C}$ is an equivalence. We do not know whether $\widehat{\mathcal{C}}$ is always sequentially complete.

Remark 2.6*.* From Proposition [2.4](#page-4-0) it follows that the sequential completion of C identifies with a full subcategory of the ind-completion $\text{Ind}(\mathcal{C})$ in the sense of [\[14,](#page-35-3) §8].

Remark 2.7. Let $F: \mathcal{C} \to \mathcal{D}$ be a functor.

(1) Suppose that F admits a left adjoint. Then F preserves Cauchy sequences and induces therefore a functor \widehat{F} : $\widehat{C} \to \widehat{D}$ such that

(2.1)
$$
\widehat{F}(X) = \operatorname{colim}_{i} F(X_{i}) \quad \text{for} \quad X \in \widehat{C}.
$$

(2) Suppose that D admits filtered colimits. Then F extends via [\(2.1\)](#page-5-0) to a functor $\widehat{\mathcal{C}} \to \mathcal{D}$.

(3) If (F, G) is an adjoint pair of functors that preserve Cauchy sequences, then $(\widehat{F}, \widehat{G})$ is an adjoint pair since

$$
\text{Hom}(\widehat{F}(X), Y) \cong \text{Hom}(\operatorname{colim}_{i} F(X_{i}), \operatorname{colim}_{j} Y_{j})
$$
\n
$$
\cong \lim_{i} \operatorname{colim}_{j} \text{Hom}(F(X_{i}), Y_{j})
$$
\n
$$
\cong \lim_{i} \operatorname{colim}_{j} \text{Hom}(X_{i}, G(Y_{j}))
$$
\n
$$
\cong \text{Hom}(X, \widehat{G}(Y)).
$$

The notion of a Cauchy sequence goes back to work of Bolzano and Cauchy (providing a criterion for convergence), while the construction of the real numbers from the rationals via equivalence classes of Cauchy sequences is due to Cantor and Méray $[5, 27]$ $[5, 27]$. The sequential completion generalises this construction.

Example 2.8. View the rational numbers $\mathbb{Q} = (\mathbb{Q}, \leq)$ with the usual ordering as a category and let $\mathbb{R}_{\infty} = (\mathbb{R} \cup \{\infty\}, \le)$. Taking a Cauchy sequence to its limit yields a functor

$$
\widehat{\mathbb{Q}} \longrightarrow \mathbb{R}_{\infty}, \quad (x_i) \mapsto \lim_{i \to \infty} x_i.
$$

For $x \in \mathbb{R}_{\infty}$, there are precisely two isomorphism classes of objects in $\widehat{\mathbb{Q}}$ with limit x when x is rational (depending on whether the sequence is eventually constant or not); otherwise there is precisely one isomorphism class in $\widehat{\mathbb{Q}}$ with limit x ^{[1](#page-5-1)}

Proof. A Cauchy sequence $x \in \text{Cauch}(\mathbb{N}, \mathbb{Q})$ is by definition a sequence $x_0 \leq x_1 \leq x_2$ $x_2 \leq \cdots$ of rational numbers that is either bounded, so converges to $\bar{x} \in \mathbb{R}$, or it is unbounded and we set $\bar{x} = \infty$. Given a morphism $x \to y$ in Cauch(N, Q) that is eventually invertible, we have $\bar{x} = \bar{y}$. Conversely, if $\bar{x} = \bar{y}$, then we define $u \in \text{Cauch}(\mathbb{N}, \mathbb{Q})$ by $u_i = \min(x_i, y_i)$ and have morphisms $x \leftarrow u \rightarrow y$. It is easily checked that $u \to x$ is eventually invertible, except when x is eventually constant and y is not. Thus the assignment $x \mapsto \bar{x}$ yields the desired functor $\widehat{\mathbb{Q}} \to \mathbb{R}_{\infty}$. \square

Let $\mathbb{I} = \{0 \leq 1\}$ denote the poset consisting of two elements. For any category C, the category of morphisms in C identifies with $\mathcal{C}^{\mathbb{I}} = \text{Fun}(\mathbb{I}, \mathcal{C})$.

Example 2.9. Let C be a category that admits an initial object and set $\mathcal{D} = \mathcal{C}^{\mathbb{I}}$. Then there is a canonical equivalence $\widehat{\mathbb{C}}^{\mathbb{I}} \xrightarrow{\sim} \widehat{\mathcal{D}}$.

Proof. The equivalence

$$
F: \operatorname{Fun}(\mathbb{I}, \operatorname{Fun}(\mathbb{N}, \mathcal{C})) \xrightarrow{\sim} \operatorname{Fun}(\mathbb{I} \times \mathbb{N}, \mathcal{C}) \xrightarrow{\sim} \operatorname{Fun}(\mathbb{N}, \operatorname{Fun}(\mathbb{I}, \mathcal{C}))
$$

restricts to an equivalence

 F_0 : Fun(I, Cauch(N, C)) \rightarrow Cauch(N, Fun(I, C)).

In order to see this, let $\phi: X \to Y$ be a morphism in Fun(N, C) and $\alpha: C \to D$ a morphism in C. Suppose X and Y are in Cauch(N, C). Thus there is $n \in \mathbb{N}$ such that $\text{Hom}(C, X_i) \to \text{Hom}(C, X_{i+1})$ and $\text{Hom}(D, Y_i) \to \text{Hom}(D, Y_{i+1})$ for $i \geq n$. Then $\text{Hom}(\alpha, \phi_i) \to \text{Hom}(\alpha, \phi_{i+1})$ for $i \geq n$. Thus $F(\phi)$ is in Cauch(N, Fun(I, C)). On the other hand, if $F(\phi)$ is in Cauch(N, Fun(I, C)), then we choose $\alpha = id_C$ and $\alpha: I \to D$ (*I* the initial object in C) to see that X and Y are in Cauch(N, C). It is easily checked that F_0 induces a functor $\widehat{\mathbb{C}}^{\mathbb{I}} \to \widehat{\mathbb{C}}^{\mathbb{I}}$, and we claim that it is an equivalence. Recall from Remark [2.6](#page-5-2) that there is a canonical embedding $\hat{C} \rightarrow$ Ind(C). So it remains to use the fact that $\text{Ind}(\mathcal{C})^{\mathbb{I}} \stackrel{\sim}{\to} \text{Ind}(\mathcal{C}^{\mathbb{I}})$, which follows from Propositions 8.8.2 and 8.8.5 in [\[14\]](#page-35-3). \Box

Let us generalise the definition of the completion \hat{e} , because later on we need to modify the underlying choice of Cauchy sequences. We fix a class $\mathfrak X$ of objects in Fun(N, C). The *completion of* C *with respect to* X is the category $\widehat{\mathcal{C}_{\mathcal{X}}}$ with class of objects $\mathfrak X$ and

 $Hom(X, Y) = \lim_{i} \text{colim}_{j} Hom(X_i, Y_j)$ for $X, Y \in \mathcal{X}$.

It follows from the definition that the assignment $X \mapsto \text{colim}_i \text{Hom}(-, X_i)$ induces a fully faithful functor $\mathfrak{C}_{\mathfrak{X}} \to \text{Fun}(\mathcal{C}^{op}, \text{Set})$. Clearly, $\widehat{\mathfrak{C}}$ identifies with $\widehat{\mathfrak{C}}_{\mathfrak{X}}$ when \mathfrak{X} equals the class of Cauchy sequences, by Corollary [2.5.](#page-5-3)

Example 2.10. Let C be an exact category and let X denote the class of sequences X such that each $X_i \to X_{i+1}$ is an admissible monomorphism. Then $\mathfrak{C}^{\sim} := \mathfrak{C}_{\mathfrak{X}}$ admits a canonical exact structure and is called *countable envelope* of C [\[18,](#page-35-6) Appendix B].

3. The sequential completion of an abelian category

Let $\mathfrak C$ be an additive category.

Lemma 3.1. *The sequential completion* \hat{e} *is an additive category and the canonical functor* $C \rightarrow \widehat{C}$ *is additive.*

Proof. The assertion follows from the fact that $Cauch(N, \mathcal{C})$ is additive and that the eventually invertible morphisms admit a calculus of left fractions [\[12,](#page-35-5) I.3.3]. \Box

It follows that the assignment $X \mapsto \tilde{X}$ yields a fully faithful additive functor $\hat{\mathcal{C}} \to \text{Add}(\mathcal{C}^{\text{op}}, \text{Ab})$ into the category of additive functors $\mathcal{C}^{\text{op}} \to \text{Ab}$.

Lemma 3.2. *If* \mathcal{C} *admits kernels, then* $\widehat{\mathcal{C}}$ *admits kernels and* $\mathcal{C} \rightarrow \widehat{\mathcal{C}}$ *is left exact.*

Proof. A morphism $X \to Y$ in $\widehat{\mathcal{C}}$ is up to isomorphism given by a morphism $\phi \colon X \to Y$ Y in Cauch(N, C). Then $K := (\text{Ker } \phi_i)_{i>0}$ is a Cauchy sequence, and this yields the kernel in \widehat{C} , because the sequence $0 \to \widetilde{K} \to \widetilde{X} \to \widetilde{Y}$ is exact in Add($\mathcal{C}^{\mathrm{op}},$ Ab). \square

Let A be an abelian category. We write A for the full subcategory of objects having finite composition length, and art A denotes the full subcategory of artinian objects. For $X \in \mathcal{A}$ the *socle* soc X is the sum of all simple subobjects. One defines inductively socⁿ $X \subseteq X$ for $n \geq 0$ by setting soc⁰ $X = 0$, and socⁿ⁺¹ X is given by the exact sequence

$$
0 \longrightarrow \operatorname{soc}^n X \longrightarrow \operatorname{soc}^{n+1} X \longrightarrow \operatorname{soc}(X/\operatorname{soc}^n X) \longrightarrow 0.
$$

Example 3.3. Let $\mathcal{A} = \text{Mod }\Lambda$ be the module category of a commutative noetherian local ring Λ . Then the sequential completion of fl A identifies with art A.

Proof. Set $C = flA$. It is well known that a Λ -module X is artinian if and only if its socle has finite length. In that case the socle series $(\operatorname{soc}^{i} X)_{i>0}$ of X yields a Cauchy sequence in C with $\text{colim}_i(\text{soc}^i X) = X$.

Now let $X \in \widehat{C}$. The assignment $X \mapsto \overline{X} := \text{colim}_i X_i$ yields a fully faithful functor $\hat{C} \rightarrow A$. Let S denote the unique (up to isomorphism) simple object in A. Then soc \bar{X} has finite length, since soc $\bar{X} \cong \text{Hom}(S, \bar{X}) \cong \text{colim}_i \text{Hom}(S, X_i)$. Thus \bar{X} is artinian.

The preceding example suggests a general criterion such that the sequential completion of an abelian category is abelian.

Let us fix a *length category* C. Thus C is an abelian category and every object has finite length. We call C *ind-artinian* if

- (1) C has only finitely many isomorphism classes of simple objects,
- (2) C is *right Ext-finite*, that is, for every pair of simple objects S and T the $\text{End}(S)$ -module $\text{Ext}^1(S,T)$ has finite length, and
- (3) C satisfies the descending chain condition on subobjects of socle stable sequences in C.

Here, we consider sequences $X = (X_i \rightarrow X_{i+1})_{i\geq 0}$ of morphisms in C, so functors $(N, \leq) \to \mathcal{C}$, and X is *socle stable* if $X_i \xrightarrow{\sim} \text{soc}^i X_j$ for all $j \geq i$. A subobject $X \subseteq Y$ is given by a morphism of functors $X \to Y$ such that $X_i \to Y_i$ is a monomorphism for all $i \geq 0$.

Proposition 3.4. *Let* A *be a Grothendieck category with a fully faithful functor* $C \rightarrow A$ *that identifies* C *with the full subcategory of finite length objects in* A. *Suppose that every object in* A *is the union of its finite length subobjects. Then the following are equivalent:*

- (1) *The category* C *is ind-artinian.*
- (2) *The category* C *has only finitely many isomorphism classes of simple objects, and an object in* A *is artinian if its socle has finite length.*
- (3) *The category* A *admits an artinian cogenerator.*

In this case an object in A *is artinian if and only if it is the colimit of a Cauchy sequence in* C*.*

Proof. Let us begin with the observation that for every artinian object $X \in \mathcal{A}$ the socle series (socⁱ X)_i>₀ is a Cauchy sequence in C with colimit X. To see this, note that $X_i := \operatorname{soc}^i X \in \mathcal{C}$ for all i since X_i/X_{i-1} is semisimple and artinian, so of finite

length. Furthermore, each object $C \in \mathcal{C}$ satisfies socⁿ $C = C$ for some n, and then every morphism $C \to X$ factors through X_n . Thus $\text{Hom}(C, X_i) \to \text{Hom}(C, X_{i+1})$ for all $i \geq n$, and $X = \bigcup_i \operatorname{soc}^i X$.

 $(1) \Rightarrow (2)$: Let $X \in \mathcal{A}$ and suppose that soc X has finite length. An injective envelope $X \to E$ induces an isomorphism soc $X \to \infty$ as E. So we may assume that X is injective. Set $X_i := \operatorname{soc}^i X$ for $i \geq 0$. The assumption on C implies that X_n has finite length for all $n > 0$. This follows by induction from the defining exact sequence for socⁿ as follows. Let $S = \bigoplus_i S_i$ be the direct sum of a representative set of simple objects. For $n > 0$ we have an isomorphism of $End(S)$ -modules

$$
Hom(S, X/X_n) \cong Ext^1(S, X_n),
$$

and their length equals the length of $\operatorname{soc}(X/X_n)$. Thus $X_n \in \mathcal{C}$ for all $n > 0$.

The sequence $(X_i \to X_{i+1})_{i>0}$ is socle stable, and the subobjects $U \subseteq X$ identify with subobjects of this socle stable sequence by taking U to the sequence $(U_i \rightarrow$ $(U_{i+1})_{i\geq 0}$ given by $U_i := \text{soc}^i U = U \cap X_i$. The inverse map takes a subsequence $(V_i \to V_{i+1})_{i\geq 0}$ given by subobjects $V_i \subseteq X_i$ to $\bigcup_i V_i \subseteq X$. Thus X is artinian.

 $\bigoplus_i S_i$ of a representative set of simple objects. Then E is an injective cogenerator $(2) \Rightarrow (3)$. Choose an injective envelope $E = E(S)$ in A for the direct sum $S =$ which is artinian since soc $E \cong S$.

 $(3) \Rightarrow (1)$: Choose an artinian cogenerator E of A, and we may assume E is injective since for each simple S the injective envelope $E(S)$ is a direct summand of E . The number of isoclasses of simple objects is bounded by the length of soc E and is therefore finite. Fix simple objects $S, T \in \mathcal{A}$ and choose a monomorphism $T \to E$. Then $\text{Hom}(S, E/T) \cong \text{Ext}^1(S, T)$ and the length of $\text{Ext}^1(S, T)$ as $\text{End}(S)$ -module is bounded by the length of $\operatorname{soc}(E/T)$ which is finite since E/T is artinian. It follows that C is right ext-finite. Now fix a socle stable sequence $(X_i \to X_{i+1})_{i>0}$ in C and set $X = \operatorname{colim}_i X_i$. Note that $X_i \cong \operatorname{soc}^i X$ for all $i \geq 0$. Then X embeds into the injective envelope $E(X_1)$ and is therefore artinian. Subobjects of $(X_i \rightarrow X_{i+1})_{i\geq 0}$ correspond to subobjects of X by the first part of the proof. Thus $\mathfrak C$ is ind-artinian.

It remains to establish the last assertion. We have already seen that any artinian object is the colimit of a Cauchy sequence in C. Conversely, let $X \in \mathcal{A}$ be the colimit of a Cauchy sequence $(X_i)_{i>0}$ in C and let $n \in \mathbb{N}$ such that for every simple object S we have $\text{Hom}(S, X_i) \to \overline{\text{Hom}}(S, X_{i+1})$ for all $i \geq n$. Then soc $X = \text{soc } X_n$ is in C, and therefore X is artinian.

Recall that an abelian category satisfies the (AB5) condition if for every directed set of subobjects $(A_i)_{i\in I}$ of an object A and $B \subseteq A$ one has

$$
\left(\sum_{i\in I}A_i\right)\cap B=\sum_{i\in I}(A_i\cap B).
$$

Corollary 3.5. *Let* C *be a length category and suppose* C *is ind-artinian. Then* \widehat{C} *is an abelian category with injective envelopes, satisfying the* (AB5) *condition,* and every object is artinian. Moreover, the canonical functor $C \rightarrow \widehat{C}$ induces an $equivalence \mathcal{C} \xrightarrow{\sim} \mathcal{A} \widehat{\mathcal{C}}.$

Proof. We embed C into a Grothendieck category via the functor

$$
\mathcal{C} \longrightarrow \mathcal{A} := \text{Lex}(\mathcal{C}^{op}, Ab), \quad X \mapsto \text{Hom}(-, X),
$$

where Lex(\mathcal{C}^{op} , Ab) denotes the category of left exact functors $\mathcal{C}^{op} \to$ Ab; see [\[11\]](#page-35-7). Then \hat{C} identifies with a subcategory of A via Proposition [2.4,](#page-4-0) and Proposition [3.4](#page-7-0) implies that $\mathcal{C} = \text{art}\,\mathcal{A}$. From this the assertion follows.

Example 3.6. Let Λ be a noetherian algebra over a complete local ring and set $\mathcal{A} = Mod \Lambda$. Then fl A is ind-artinian and fl A identifies with art A.

Proof. There are only finite many simple Λ-modules, up to isomorphism, and their injective envelopes are artinian. Thus $\text{fl } \mathcal{A}$ is ind-artinian by Proposition [3.4,](#page-7-0) and therefore $\widehat{\mathbb{H}}\widehat{\mathcal{A}}$ identifies with art \mathcal{A} .

Example 3.7. Let Λ be a ring and $\mathcal{C} \subseteq \mathcal{N}$ a full subcategory of its module category that contains Λ . Then $\mathfrak C$ is sequentially complete.

Proof. Let $X \in \text{Cauch}(\mathbb{N}, \mathbb{C})$. We have $\text{Hom}(\Lambda, X_i) \cong X_i$, and therefore $X_i \xrightarrow{\sim} X_{i+1}$ for $i \gg 0$. Thus colim_i X_i belongs to C.

4. The sequential completion of a triangulated category

Let T be a triangulated category and suppose that countable coproducts exist in T. Let

$$
X_0 \xrightarrow{\phi_0} X_1 \xrightarrow{\phi_1} X_2 \xrightarrow{\phi_2} \cdots
$$

be a sequence of morphisms in T. A *homotopy colimit* of this sequence is by definition an object X that occurs in an exact triangle

$$
\Sigma^{-1}X \longrightarrow \coprod_{i\geq 0} X_i \xrightarrow{\operatorname{id} - \phi} \coprod_{i\geq 0} X_i \longrightarrow X.
$$

We write hocolim_i X_i for X and observe that a homotopy colimit is unique up to a (non-unique) isomorphism [\[2\]](#page-35-8).

Recall that an object C in $\mathcal T$ is *compact* if Hom $(C, -)$ preserves all coproducts. A morphism $X \to Y$ is *phantom* if any composition $C \to X \to Y$ with C compact is zero [\[7,](#page-35-9) [8\]](#page-35-10). The phantom morphisms form an ideal and we write $\text{Ph}(X, Y)$ for the subgroup of all phantoms in $\text{Hom}(X, Y)$. Let us denote by \mathcal{T}/Ph the additive category which is obtained from T by annihilating all phantom morphisms.

Lemma 4.1. Let $C \in \mathcal{T}$ be compact. Any sequence $X_0 \to X_1 \to X_2 \to \cdots$ in \mathcal{T} *induces an isomorphism*

$$
\underset{i}{\text{colim}} \text{Hom}(C, X_i) \xrightarrow{\sim} \text{Hom}(C, \text{hocolim } X_i).
$$

Proof. See [\[20,](#page-35-11) §5.1] or [\[30,](#page-36-8) Lemma 1.5]. □

Recall that for any sequence $\cdots \rightarrow A_2 \stackrel{\phi_2}{\longrightarrow} A_1 \stackrel{\phi_1}{\longrightarrow} A_0$ of maps between abelian groups the inverse limit and its first derived functor are given by the exact sequence

$$
0 \longrightarrow \lim_{i} A_{i} \longrightarrow \prod_{i \geq 0} A_{i} \xrightarrow{\mathrm{id} - \phi} \prod_{i \geq 0} A_{i} \longrightarrow \lim_{i} A_{i} \longrightarrow 0.
$$

The following result goes back to work of Milnor [\[28\]](#page-36-2) and was later extended by several authors, for instance in [\[7,](#page-35-9) [8\]](#page-35-10).

Lemma 4.2. Let $X = \text{hocolim}_i X_i$ be a homotopy colimit in $\mathcal T$ such that each X_i *is a coproduct of compact objects. Then we have for any* Y *in* T *a natural exact sequence*

$$
0 \longrightarrow \mathrm{Ph}(X,Y) \longrightarrow \mathrm{Hom}(X,Y) \longrightarrow \lim_{i} \mathrm{Hom}(X_i,Y) \longrightarrow 0
$$

and an isomorphism

$$
\text{Ph}(X,\Sigma Y) \cong \lim_{i}^{1} \text{Hom}(X_i, Y).
$$

Proof. Apply Hom(−, Y) to the exact triangle defining hocolim_i X_i and use that a morphism $X \to Y$ is phantom if and only if it factors through the canonical morphism $X \to \coprod_{i \geq 0} \Sigma X_i$. Let $\mathcal{C} \subseteq \mathcal{T}$ be a full additive subcategory consisting of compact objects and consider the restricted Yoneda functor

$$
\mathfrak{T} \longrightarrow \text{Add}(\mathcal{C}^{\text{op}}, \text{Ab}), \quad X \mapsto h_X := \text{Hom}(-, X)|_{\mathcal{C}}.
$$

Note that for any sequence $X_0 \to X_1 \to X_2 \to \cdots$ in C we have by Lemma [4.1](#page-9-0)

(4.1)
$$
X = \operatorname{colim}_{i} \operatorname{Hom}(-, X_{i}) = h_{\operatorname{hocolim}_{i} X_{i}}.
$$

Lemma 4.3. Let $X = \text{hocolim}_i X_i$ be a homotopy colimit in T such that each X_i *is a coproduct of objects in* C*. Then we have for any* Y *in* T *a natural isomorphism*

$$
\frac{\text{Hom}(X,Y)}{\text{Ph}(X,Y)} \longrightarrow \text{Hom}(h_X, h_Y).
$$

Proof. Using the preceding lemmas, we have

$$
\frac{\text{Hom}(X,Y)}{\text{Ph}(X,Y)} \cong \lim_{i} \text{Hom}(X_i, Y)
$$

\n
$$
\cong \lim_{i} \text{Hom}(h_{X_i}, h_Y)
$$

\n
$$
\cong \text{Hom}(\text{colim } h_{X_i}, h_Y)
$$

\n
$$
\cong \text{Hom}(h_X, h_Y).
$$

Proposition 4.4. *Let* $C \subseteq T$ *be a full additive subcategory consisting of compact objects. Taking a sequence* $X_0 \to X_1 \to X_2 \to \cdots$ *in* C *to its homotopy colimit induces a fully faithful functor* $\hat{C} \rightarrow \mathcal{T}/ Ph$ *.*

Proof. We have the functor

$$
\widehat{C} \longrightarrow \text{Add}(\mathcal{C}^{op}, Ab), \quad X \mapsto \widetilde{X},
$$

which is fully faithful by Proposition [2.4.](#page-4-0) Now combine [\(4.1\)](#page-10-0) and Lemma [4.3.](#page-10-1) \Box

Definition 4.5. Let C be a triangulated category and X a class of sequences $(X_i)_{i>0}$ in C that is stable under suspensions, i.e. $(\Sigma^n X_i)_{i>0}$ is in X for all $n \in \mathbb{Z}$. We say that X is *phantomless* if for any pair of sequences X, Y in X we have

(4.2)
$$
\lim_{i} \frac{1}{j} \operatorname{colim}_{i} \operatorname{Hom}_{i}(X_{i}, Y_{j}) = 0.
$$

The following lemma justifies the term 'phantomless'.

Lemma 4.6. *Let* $C \subseteq T$ *be a full triangulated subcategory consisting of compact objects and* X *a class of sequences* $(X_i)_{i>0}$ *in* C *that is stable under suspensions. Consider the full subcategory*

$$
\mathcal{D} := \{ \operatorname{hocolim}_{i} X_{i} \in \mathfrak{T} \mid X \in \mathfrak{X} \} \subseteq \mathfrak{T}.
$$

Then the following are equivalent:

- (1) *The class* X *is phantomless.*
- (2) We have $\text{Ph}(U, V) = 0$ for all $U, V \in \mathcal{D}$.
- (3) *The functor* $\mathcal{D} \to \text{Add}(\mathcal{C}^{\text{op}}, \text{Ab})$ *taking* X *to* Hom $(-, X)|_{\mathcal{C}}$ *is fully faithful.*
- (4) *The assignment* $X \mapsto \text{hocolim}_i X_i$ *yields an equivalence* $\widehat{\mathbb{C}_X} \xrightarrow{\sim} \mathcal{D}$.

In this case the homotopy colimit of a Cauchy sequence in C *is actually a colimit in* D*, provided that* X *contains all constant sequences consisting of identities only.*

Proof. (1) \Leftrightarrow (2): Combine Lemmas [4.1](#page-9-0) and [4.2.](#page-9-1)

 $(2) \Leftrightarrow (3)$: Apply Lemma [4.3.](#page-10-1)

 $(2) \Leftrightarrow (4)$: Apply Proposition [4.4.](#page-10-2)

The final assertion follows from the identity (4.1) for any sequence X in C, since $\mathcal D$ identifies with a full subcategory of Add($\mathcal{C}^{\text{op}},$ Ab).

Recall that a triangulated category is *algebraic* if it is triangle equivalent to the stable category $St(A)$ of a Frobenius category A. A morphism between exact triangles

in $St(\mathcal{A})$ will be called *coherent* if it can be lifted to a morphism

$$
0 \longrightarrow \tilde{X} \longrightarrow \tilde{Y} \longrightarrow \tilde{Z} \longrightarrow 0
$$

$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$

$$
0 \longrightarrow \tilde{X}' \longrightarrow \tilde{Y}' \longrightarrow \tilde{Z}' \longrightarrow 0
$$

between exact sequences in A (so that the canonical functor $A \to St(A)$ maps the second to the first diagram). Note that any commutative diagram

$$
\begin{array}{ccc}\nX & \longrightarrow & Y \\
\downarrow & & \downarrow \\
X' & \longrightarrow & Y'\n\end{array}
$$

in $St(\mathcal{A})$ can be completed to a coherent morphism of exact triangles as above.

The following theorem establishes a triangulated structure for the sequential completion of a triangulated category C. Let us stress that we use a relative version of this result for our applications, as explained in Remark [4.10](#page-13-0) below; it depends on the choice of a class X of sequences in C which is phantomless.

Theorem 4.7. *Let* C *be an algebraic triangulated category, viewed as a full subcategory of its sequential completion* Cb*. Suppose that the class of Cauchy sequences is phantomless. Then* \hat{C} *admits a unique triangulated structure such that the exact triangles are precisely the ones isomorphic to colimits of Cauchy sequences that are given by coherent morphisms of exact triangles in* C*.*

Let us spell out the triangulated structure for $\widehat{\mathcal{C}}$. Fix a sequence of coherent morphisms $\eta_0 \to \eta_1 \to \eta_2 \to \cdots$ of exact triangles

$$
\eta_i \colon X_i \longrightarrow Y_i \longrightarrow Z_i \longrightarrow \Sigma X_i
$$

in C and suppose that it is also a sequence of morphisms $X \to Y \to Z \to \Sigma X$ of Cauchy sequences in C. This identifies with the sequence

$$
\operatornamewithlimits{colim}_i X_i \longrightarrow \operatornamewithlimits{colim}_i Y_i \longrightarrow \operatornamewithlimits{colim}_i Z_i \longrightarrow \operatornamewithlimits{colim}_i \Sigma X_i
$$

in \hat{e} , and the exact triangles in \hat{e} are precisely sequences of morphisms that are isomorphic to sequences of the above form.

Theorem [C.8](#page-32-0) provides a substantial generalisation, from algebraic triangulated categories to triangulated categories with a morphic enhancement. Moreover, in some interesting cases the morphic enhancement extends to a morphic enhancement of the completion; see Section [C.8.](#page-34-0)

Proof. The proof is given in several steps.

(1) The assumption on $\mathfrak C$ to be algebraic implies that $\mathfrak C$ identifies with the stable category St(A) of a Frobenius category A. Let A^{\sim} denote the countable envelope of A which is a Frobenius category containing A as a full exact subcategory; see Example [2.10.](#page-6-0) Then C identifies with a full triangulated subcategory of compact objects of $\mathfrak{T} := \mathrm{St}(\mathcal{A}^*)$.

For any sequence of coherent morphisms $\eta_0 \to \eta_1 \to \eta_2 \to \cdots$ of exact triangles

$$
\eta_i \colon X_i \longrightarrow Y_i \longrightarrow Z_i \longrightarrow \Sigma X_i
$$

in C there is in T an induced exact triangle

(4.3)
$$
\operatorname{hocolim}_{i} X_{i} \longrightarrow \operatorname{hocolim}_{i} Y_{i} \longrightarrow \operatorname{hocolim}_{i} Z_{i} \longrightarrow \Sigma(\operatorname{hocolim}_{i} X_{i}).
$$

Let us sketch the argument. We can lift the sequence $(\eta_i)_{i\geq 0}$ to a sequence of exact sequences

$$
\tilde{\eta}_i\colon 0\longrightarrow \tilde{X}_i\longrightarrow \tilde{Y}_i\longrightarrow \tilde{Z}_i\longrightarrow 0
$$

in A and obtain a commutative diagram with exact rows

$$
\begin{array}{ccc}\n0 & \longrightarrow \coprod_{i \geq 0} \tilde{X}_i \longrightarrow \coprod_{i \geq 0} \tilde{Y}_i \longrightarrow \coprod_{i \geq 0} \tilde{Z}_i \longrightarrow 0 \\
\downarrow & \downarrow & \downarrow \\
0 & \longrightarrow \coprod_{i \geq 0} \tilde{X}_i \longrightarrow \coprod_{i \geq 0} \tilde{Y}_i \longrightarrow \coprod_{i \geq 0} \tilde{Z}_i \longrightarrow 0\n\end{array}
$$

in $A^{\tilde{}}$. The vertical morphism are induced by the morphisms $\tilde{\eta}_i \to \tilde{\eta}_{i+1}$, and taking mapping cones of the vertical morphisms (given by cokernels in A^{γ}) yields the desired exact triangle [\(4.3\)](#page-12-0).

 (2) The assumption on Cauchy sequences in C to be phantomless implies that the functor $\hat{C} \to \hat{T}$ taking a sequence to its homotopy colimit induces an equivalence

$$
\widehat{\mathcal{C}} \xrightarrow{\sim} \mathcal{D} := \{ \operatorname{hocolim}_{i} X_{i} \in \mathcal{T} \mid X \in \operatorname{Cauch}(\mathbb{N}, \mathcal{C}) \}.
$$

This follows from Lemma [4.6.](#page-10-3) In particular, the homotopy colimit of a Cauchy sequence in C is actually a colimit in D.

(3) We claim that $\mathcal D$ is a triangulated subcategory of $\mathcal T$ and that the exact triangles in D are up to isomorphism the colimits of Cauchy sequences given by coherent morphisms of exact triangles in C.

For a Cauchy sequence given by coherent morphisms of exact triangles $X_i \rightarrow$ $Y_i \to Z_i \to \Sigma X_i$ in C, we form in D its colimit and obtain an exact triangle [\(4.3\)](#page-12-0); it does not depend on any choices.

Conversely, fix an exact triangle $\eta: \bar{X} \to \bar{Y} \to \bar{Z} \to \Sigma \bar{X}$ in $\mathcal D$ that is given by $X, Y \in \text{Cauch}(\mathbb{N}, \mathbb{C})$ with $\overline{X} = \text{colim}_i X_i$ and $\overline{Y} = \text{colim}_i Y_i$. The morphism $\bar{X} \to \bar{Y}$ is up to isomorphism given by a morphism $\phi \colon X \to Y$ in Cauch(N, C), so of the form $\text{colim}_i \phi_i$. Now complete the $\phi_i \colon X_i \to Y_i$ to a sequence of coherent morphisms between exact triangles $X_i \to Y_i \to Z_i \to \Sigma X_i$ in C. It is easily checked that $(Z_i)_{i\geq 0}$ is a Cauchy sequence; set $\tilde{Z} := \operatorname{colim}_i Z_i$. This yields an exact triangle $\eta' : \bar{X} \to \bar{Y} \to \tilde{Z} \to \Sigma \bar{X}$ in T, keeping in mind the above remark about homotopy colimits of exact triangles. It follows that D is closed under the formation of cones and therefore a triangulated subcategory of T . Clearly, η and η' are isomorphic triangles. Thus any exact triangle in D is up to isomorphism a colimit of exact triangles in \mathcal{C} .

Corollary 4.8. *Let* T *be an algebraic triangulated category with countable coproducts and* $C \subseteq T$ *a full triangulated subcategory consisting of compact objects. Suppose the class of Cauchy sequences in* C *is phantomless. Then the full subcategory*

$$
\{\operatorname{hocolim}_{i} X_{i} \in \mathcal{T} \mid X \in \operatorname{Cauch}(\mathbb{N}, \mathcal{C})\} \subseteq \mathcal{T}
$$

is a triangulated subcategory which is triangle equivalent to Cb*. The exact triangles are precisely the ones isomorphic to colimits of Cauchy sequences given by coherent morphisms of exact triangles in* C*.*

Remark 4.9*.* To be phantomless is a condition which can be checked for a specific sequence $Y = (Y_i)_{i>0}$ in C. Given $C \in \mathcal{C}$, call a subgroup

$$
U \subseteq Y(C) = \operatorname{colim}_{j} \operatorname{Hom}(C, Y_j)
$$

of finite definition if it arises as the image of a map $\widetilde{Y}(D) \to \widetilde{Y}(C)$ for some morphism $C \to D$ in C; see [\[15\]](#page-35-12). The descending chain condition (dcc) for subgroups of finite definition implies that (4.2) holds for all sequences X in C, since it implies the Mittag-Leffler condition for

$$
\cdots \longrightarrow \widetilde{Y}(X_2) \longrightarrow \widetilde{Y}(X_1) \longrightarrow \widetilde{Y}(X_0).
$$

The dcc for subgroups of finite definition is equivalent to Y being Σ -pure-injective when viewed as an object in $Ind(\mathcal{C})$, by [\[9,](#page-35-13) §3.5]. On the other hand, when $\mathcal T$ is a compactly generated triangulated category, then $Z \in \mathcal{T}$ is pure-injective if and only if $Ph(-, Z) = 0$, by [\[22,](#page-35-14) Theorem 1.8].

Let C be a triangulated category and fix a cohomological functor $H: \mathcal{C} \to \mathcal{A}$ into an abelian category. Set $H^n := H \circ \Sigma^n$ for $n \in \mathbb{Z}$. We call a sequence $(X_i)_{i \geq 0}$ in C *bounded* if

$$
\operatornamewithlimits{colim}_i H^n(X_i)=0\quad\text{for}\quad |n|\gg 0
$$

and write

$$
\widehat{\mathcal{C}}^b := \{ X \in \widehat{\mathcal{C}} \mid X \text{ bounded} \}
$$

for the full subcategory of bounded objects.

Remark 4.10*.* Suppose for all $C \in \mathcal{C}$ that $H^{n}(C) = 0$ for $|n| \gg 0$. Then we may restrict ourselves to bounded Cauchy sequences, and if this class is phantomless, then the conclusion of Theorem [4.7](#page-11-0) holds for \tilde{C}^b .

More generally, fix a class $\mathfrak{X} \subseteq \text{Fun}(\mathbb{N}, \mathcal{C})$ that is closed under suspensions and cones. When $\mathfrak X$ is phantomless, then the conclusion of Corollary [4.8](#page-12-1) holds for

$$
\widehat{\mathcal{C}_{\mathfrak{X}}} \xrightarrow{\sim} \{ \operatorname{hocolim}_{i} X_{i} \in \mathfrak{T} \mid X \in \mathfrak{X} \}.
$$

For more details, cf. Section [C.5.](#page-31-0)

Example 4.11. Let Λ be a quasi-Frobenius ring of finite representation type. Then the class of all sequences in the stable category $St(mod \Lambda)$ is phantomless. In fact, this holds for any locally finite triangulated category [\[24,](#page-36-9) [41\]](#page-36-10) and can be deduced from Remark [4.9.](#page-13-1)

The following example is a continuation of our discussion in Section [3.](#page-6-1) For an abelian category A let $\mathbf{D}^b(\mathcal{A})$ denote its bounded derived category. An object in A is *locally finite* if it is a directed union of finite length subobjects.

Example 4.12. Let k be a commutative ring and A a k-linear Grothendieck category such that $\text{Hom}(X, Y)$ is a finite length k-module for all $X, Y \in \text{fl } \mathcal{A}$. Suppose that there are only finitely many isomorphism classes of simple objects and that the injective envelope of each simple object is locally finite and artinian. Then the class of Cauchy sequences in $\mathbf{D}^b(\mathbf{f}|\mathcal{A})$ is phantomless and we have triangle equivalences

$$
\mathbf{D}^b(\widehat{\mathfrak{fl}\mathcal{A}})\xrightarrow{\sim} \mathbf{D}^b(\mathrm{art}\mathcal{A})\xrightarrow{\sim} \widehat{\mathbf{D}^b(\mathfrak{fl}\mathcal{A})}^b.
$$

 \mathbf{L}

Proof. The first equivalence is clear from Proposition [3.4;](#page-7-0) so we focus on the second one. We may assume that all objects in A are locally finite. For all $X, Y \in D^b(\mathbf{fl}, \mathcal{A})$ the k-module $Hom(X, Y)$ has finite length, since $Extⁿ(S, T)$ has finite length for

all simple S, T and $n \geq 0$ by our assumptions on A. It follows that the class of Cauchy sequences in $\mathbf{D}^b(\text{fl } \mathcal{A})$ is phantomless by the Mittag-Leffler condition. We wish to apply Corollary [4.8](#page-12-1) and choose for \mathcal{T} the category $\mathbf{K}(\text{Inj}\,\mathcal{A})$ of complexes up to homotopy, where $\text{Inj } A$ denotes the full subcategory of injective objects in A . Set inj $A = \text{Inj } A \cap \text{art } A$. Then $\mathbf{D}^b(\text{fl } \mathcal{A})$ identifies with \mathcal{T}^c via

$$
F: \mathbf{D}^b(\operatorname{art}\mathcal{A}) \xrightarrow{\sim} \mathbf{K}^{+,b}(\operatorname{inj}\mathcal{A}) \hookrightarrow \mathbf{K}(\operatorname{Inj}\mathcal{A}),
$$

by [\[23,](#page-36-11) Proposition 2.3]. Set $\mathcal{C} := \mathbf{D}^b(\mathcal{H}, \mathcal{A})$. Then Corollary [4.8](#page-12-1) yields a triangle equivalence

$$
\widehat{\mathcal{C}} \xrightarrow{\sim} \mathcal{D} := \{ \operatorname{hocolim}_{i} X_{i} \in \mathcal{T} \mid X \in \operatorname{Cauch}(\mathbb{N}, \mathcal{C}) \}.
$$

We claim that F induces an equivalence

$$
\mathbf{D}^b(\mathrm{art}\,\mathcal{A})\xrightarrow{\sim} \mathcal{D}^b:=\{X\in \mathcal{D}\mid \operatornamewithlimits{colim}_i H^n(X_i)=0\ \text{for}\ |n|\gg 0\}.
$$

Any object $M \in \text{art } A$ is the colimit of the Cauchy sequence $(\text{soc}^i M)_{i>0}$ in fl A by Proposition [3.4,](#page-7-0) and this yields a Cauchy sequence in $\mathbf{D}^b(\text{fl}\,\mathcal{A})$. Thus F maps art A into \mathcal{D}^b , and therefore also $\mathbf{D}^b(\text{art}\mathcal{A})$, since F is an exact functor and $\mathbf{D}^b(\text{art}\mathcal{A})$ is generated by art A as a triangulated category. Conversely, let $\bar{X} = \text{colim}_i X_i$ be an object in \mathcal{D}^b . We may assume that the complex \bar{X} is homotopically minimal, as in [\[23,](#page-36-11) Appendix B]. The Cauchy condition implies for each simple $S \in \mathcal{A}$ and $n \in \mathbb{Z}$ that $\text{Hom}(S, \Sigma^n \overline{X})$ has finite length over k, so the degree n component of \overline{X} is artinian. Thus \bar{X} belongs to $\mathbf{K}^{+,b}(\text{inj }\mathcal{A})$, and this yields the claim.

5. Homologically perfect objects

Let $\mathfrak T$ be a compactly generated triangulated category and denote by $\mathfrak T^c$ the full subcategory of compact objects. We fix a cohomological functor $H: \mathcal{T} \to \mathcal{A}$ into an abelian category. For $n \in \mathbb{Z}$ set $H^n := H \circ \Sigma^n$.

Definition 5.1. We say that an object X in $\mathcal T$ is *homologically perfect* (with respect to H) if X can be written as homotopy colimit of a sequence $X_0 \to X_1 \to X_2 \to \cdots$ in \mathcal{T}^c such that the following holds:

(HP1) The sequence $(X_i)_{i\geq 0}$ is a Cauchy sequence in \mathcal{T}^c , that is, for every $C \in \mathcal{T}^c$

 $Hom(C, X_i) \to Hom(C, X_{i+1})$ for $i \gg 0$.

(HP2) For every $n \in \mathbb{Z}$ we have $H^n(X_i) \xrightarrow{\sim} H^n(X_{i+1})$ for $i \gg 0$. (HP3) For almost all $n \in \mathbb{Z}$ we have $H^n(X_i) = 0$ for $i \gg 0$.

When $\mathcal T$ is the derived category of an abelian category, then our choice of H is the natural one given by the degree zero cohomology of a complex, unless stated otherwise.

It is clear that the above definition depends on the choice of H ; so a different choice of H may yield a different class of homologically perfect objects. However, in our applications there are natural choices for H , for instance when $\mathcal T$ is the derived category of an abelian category. It is a remarkable fact that in those cases there is an intrinsic description of homologically perfect objects that depends only on T. That means some choices of H are more natural than others. The following Lemma [5.3](#page-15-0) makes this precise when the cohomological functor H is given by a compact generator. For noetherian schemes that are non-affine, the natural choice for H admits the same intrinsic description of homologically perfect objects, but the proof is more involved and we refer to Theorem [B.1.](#page-21-0)

We begin with an elementary but useful observation.

Lemma 5.2. *Let* C *be a triangulated category and* $G \in C$ *an object that generates* C*, that is,* C *admits no proper thick subcategory containing* G*. Then a sequence* $X_0 \to X_1 \to X_2 \to \cdots$ *in* C *is Cauchy if and only if for all* $n \in \mathbb{Z}$ *we have* $\text{Hom}(\Sigma^n G, X_i) \xrightarrow{\sim} \text{Hom}(\Sigma^n G, X_{i+1})$ *for i* ≫ 0*.* □

The following yields an intrinsic description of homologically perfect objects.

Lemma 5.3. Let G be a compact object in T that generates \mathfrak{T}^c as a triangulated *category. Then for* $X \in \mathcal{T}$ *the following are equivalent:*

- (1) *The object* X *is homologically perfect with respect to* $H = \text{Hom}(G, -)$ *.*
- (2) *The object* X *can be written as homotopy colimit of a Cauchy sequence in*
	- \mathfrak{T}^c *, and for every* $C \in \mathfrak{T}^c$ *we have* $\text{Hom}(C, \Sigma^n X) = 0$ *for* $|n| \gg 0$ *.*

Proof. The assumption on H implies that the conditions (HP1) and (HP2) are equivalent, thanks to Lemma [5.2.](#page-15-1) Condition (HP3) means $Hⁿ(X) = 0$ for $|n| \gg 0$, since $H^{n}(X) \cong \text{colim}_{i} H^{n}(X_{i})$ by Lemma [4.1.](#page-9-0) Thus (HP3) is equivalent to the condition that for every $C \in \mathcal{T}^c$ we have $\text{Hom}(C, \Sigma^n X) = 0$ for $|n| \gg 0$, since G generates \mathfrak{T}^c .

Now fix a ring Λ . We write $\mathbf{D}(\Lambda)$ for the derived category of the abelian category of all Λ -modules. Let $\mathbf{D}^{\text{per}}(\Lambda)$ denote the full subcategory of *perfect complexes*, that is, objects isomorphic to bounded complexes of finitely generated projective modules. The triangulated category $\mathbf{D}(\Lambda)$ is compactly generated and the compact objects are precisely the perfect complexes.

Let mod Λ denote the category of finitely presented Λ -modules and proj Λ denotes the full subcategory of finitely generated projective modules. When Λ is a right coherent ring, then $mod \Lambda$ is abelian and we consider its derived category $\mathbf{D}^b(\text{mod }\Lambda)$ using the following identifications

$$
\begin{array}{ccc}\n\mathbf{K}^b(\operatorname{proj}\nolimits \Lambda) & \longrightarrow & \mathbf{K}^{-,b}(\operatorname{proj}\nolimits \Lambda) \\
\downarrow & & \downarrow \wr \\
\mathbf{D}^{\operatorname{per}}(\Lambda) & \longrightarrow & \mathbf{D}^b(\operatorname{mod} \Lambda)\n\end{array}
$$

where the top row consists of categories of complexes of modules in $proj \Lambda$ up to homotopy. Note that $\mathbf{D}^{\text{per}}(\Lambda) = \mathbf{D}^b(\text{mod }\Lambda)$ if and only if every finitely presented Λ-module has finite projective dimension.

We provide an intrinsic description of the objects from $\mathbf{D}^b(\text{mod }\Lambda)$, which uses for any complex X the sequence of truncations

$$
\cdots \longrightarrow \sigma_{\geq n+1}X \longrightarrow \sigma_{\geq n}X \longrightarrow \sigma_{\geq n-1}X \longrightarrow \cdots
$$

given by

In the following lemma we use the notion of a homologically perfect object with respect to the functor that takes degree zero cohomology of a complex, keeping in mind Lemma [5.3.](#page-15-0)

Lemma 5.4. Let Λ be a right coherent ring. Then X in $D(\Lambda)$ is homologically *perfect if and only if* X *belongs to* $\mathbf{D}^b(\text{mod }\Lambda)$ *.*

Proof. Let X be a complex in $\mathbf{K}^{-,b}(\text{proj}\,\Lambda) = \mathbf{D}^b(\text{mod}\,\Lambda)$ and write X as homotopy colimit of its truncations $X_i = \sigma_{\geq -i} X$ which lie in \mathbf{K}^b (proj Λ). It is clear that X is homologically perfect. In fact, $\overline{\mathbf{D}^{\text{per}}(\Lambda)}$ is generated by Λ ; so it suffices to check the

functor $H^n = \text{Hom}(\Lambda, \Sigma^n)$ for every $n \in \mathbb{Z}$. We have $H^n(X_i) \xrightarrow{\sim} H^n(X_{i+1})$ for $i \gg 0$ and $H^{n} X = 0$ for $|n| \gg 0$. On the other hand, if X is homologically perfect, then $H^n X$ is finitely presented for all n, so X lies in $\mathbf{D}^b(\text{mod }\Lambda)$.

6. The bounded derived category

Let Λ be a ring. We consider the category mod Λ of finitely presented Λ modules and its bounded derived category $\mathbf{D}^b(\text{mod }\Lambda)$. Our aim is to identify $\mathbf{D}^b(\text{mod }\Lambda)$ with a completion of $\mathbf{D}^{\text{per}}(\Lambda)$ when Λ is right coherent; compare this with Rouquier's [\[38,](#page-36-4) Corollary 6.4].

Lemma 6.1. *Let* Λ *be a ring and set* $\mathcal{P} = \text{proj}\,\Lambda$ *. Then the functor*

$$
\mathbf{K}^{-,b}(\mathcal{P}) \longrightarrow \text{Add}(\mathbf{K}^b(\mathcal{P})^{\text{op}},\text{Ab}), \quad X \mapsto h_X := \text{Hom}(-,X)|_{\mathbf{K}^b(\mathcal{P})},
$$

is fully faithful.

Proof. We view $\mathbf{K}^{-,b}(\mathcal{P})$ as a subcategory of $\mathbf{D}(\Lambda)$. Let X, Y be objects in $\mathbf{K}^{-,b}(\mathcal{P})$ and write X as homotopy colimit of its truncations $X_i = \sigma_{\geq -i} X$ which lie in $\mathbf{K}^b(\mathcal{P})$. Let C_i denote the cone of $X_i \to X_{i+1}$. This complex is concentrated in degree $-i-1$; so $Hom(C_i, Y) = 0$ for $i \gg 0$. Thus $X_i \to X_{i+1}$ induces a bijection

$$
Hom(X_{i+1}, Y) \xrightarrow{\sim} Hom(X_i, Y) \text{ for } i \gg 0.
$$

This implies

$$
\mathrm{Hom}(X,Y)\xrightarrow{\sim}\lim_i\mathrm{Hom}(X_i,Y)
$$

and therefore $Ph(X, Y) = 0$ by Lemma [4.2.](#page-9-1) From Lemma [4.3](#page-10-1) we conclude that

$$
Hom(X, Y) \xrightarrow{\sim} Hom(h_X, h_Y).
$$

Let C be a triangulated category and fix a cohomological functor $H: \mathcal{C} \to \mathcal{A}$. Recall that an object X in \hat{C} is *bounded* if $\text{colim}_i H^n(X_i) = 0$ for $|n| \gg 0$, and $\hat{\mathcal{C}}^b$ denotes the full subcategory of bounded objects in $\hat{\mathcal{C}}$. From Theorem [4.7](#page-11-0) and Remark [4.10](#page-13-0) we know that \hat{c}^b admits a canonical triangulated structure when C is algebraic and bounded Cauchy sequences are phantomless.

Theorem 6.2. *For a right coherent ring* Λ *there is a canonical triangle equivalence*

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\Lambda)}^b \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\mathrm{mod}\,\Lambda)
$$

which sends a Cauchy sequence in $\mathbf{D}^{\text{per}}(\Lambda)$ *to its colimit.*

Proof. We consider the functor

$$
\mathbf{D}^b(\operatorname{mod} \Lambda) \longrightarrow \operatorname{Add}(\mathbf{D}^{\rm per}(\Lambda)^{\rm op},\operatorname{Ab}), \quad X \mapsto \operatorname{Hom}(-,X)|_{\mathbf{D}^{\rm per}(\Lambda)},
$$

which is fully faithful by Lemma [6.1.](#page-16-0) On the other hand, we have the functor

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\Lambda)}^b \longrightarrow \mathrm{Add}(\mathbf{D}^{\mathrm{per}}(\Lambda)^{\mathrm{op}}, \mathrm{Ab}), \quad X \mapsto \widetilde{X},
$$

which is fully faithful by Proposition [2.4.](#page-4-0) Both functors have the same essential image by Lemma [5.4,](#page-15-2) because we can identify this with a full subcategory of $\mathbf{D}(\Lambda)$ by Lemma [4.6.](#page-10-3) This yields a triangle equivalence, since the triangulated structures of both categories identify with the one from $\mathbf{D}(\Lambda)$; see Corollary [4.8](#page-12-1) plus Remark [4.10.](#page-13-0) \Box

Remark 6.3. The triangulated category $\mathbf{D}^{\text{per}}(\Lambda)$ admits a morphic enhancement which is given by $\mathbf{D}^{\text{per}}(\Lambda_1)$, with Λ_1 the ring of upper triangular 2×2 matrices over Λ. This enhancement can be completed and yields a morphic enhancement of $\widehat{\mathbf{D}^{\text{per}}(\Lambda)}^b$ that identifies with the morphic enhancement of $\mathbf{D}^b(\text{mod }\Lambda)$; see Section [C.8.](#page-34-0) This observation enriches the triangle equivalence of Theorem [6.2.](#page-16-1)

For a noetherian algebra over a complete local ring, there is another description of $\mathbf{D}^b(\text{mod }\Lambda)$ which is obtained by completing the category of finite length modules over Λ^{op} .

Proposition 6.4. *Let* Λ *be a noetherian algebra over a complete local ring and set* $\Gamma = \Lambda^{\rm op}$ *. Then there are triangle equivalences*

$$
\mathbf{D}^b(\operatorname{mod} \Lambda)^{\rm op} \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\widehat{\mathrm{fl}\,\Gamma}) \stackrel{\sim}{\longrightarrow} \widehat{\mathbf{D}^b(\mathrm{fl}\,\Gamma)}^b.
$$

Proof. Matlis duality gives an equivalence $(\text{mod }\Lambda)^{\text{op}} \xrightarrow{\sim} \text{art }\Gamma$, so $\mathbf{D}^b(\text{mod }\Lambda)^{\text{op}} \xrightarrow{\sim}$ $\mathbf{D}^b(\text{art } \Gamma)$, and we have $\text{art } \Gamma \xrightarrow{\sim} \widehat{\text{fl } \Gamma}$ by Example [3.6.](#page-8-0) This yields the first functor, and the second is from Example [4.12.](#page-13-2) \Box

7. Pseudo-coherent objects

Let T be a triangulated category and $H: \mathcal{T} \to \mathcal{A}$ a cohomological functor into an abelian category. Set

 $\mathfrak{T}^{>n} := \{ X \in \mathfrak{T} \mid H^i X = 0 \text{ for all } i \leq n \}$

and

$$
\mathfrak{T}^{\leq n} := \{ X \in \mathfrak{T} \mid H^i X = 0 \text{ for all } i > n \}.
$$

We suppose for all $X, Y \in \mathcal{T}$ and $n \in \mathbb{Z}$ the following:

(TS1) There is an exact triangle

$$
\tau_{\leq n} X \longrightarrow X \longrightarrow \tau_{>n} X \longrightarrow \Sigma(\tau_{\leq n} X)
$$

with $\tau_{\leq n} X \in \mathfrak{T}^{\leq n}$ and $\tau_{>n} X \in \mathfrak{T}^{>n}$.

(TS2) Hom $(X, Y) = 0$ for $X \in \mathfrak{T}^{\leq n}$ and $Y \in \mathfrak{T}^{> n}$.

Thus the category T is equiped with a *t-structure* [\[1\]](#page-35-15).

We will use the following observation.

Lemma 7.1. For any morphism $X \to Y$ in T we have

$$
\tau_{>n} X \xrightarrow{\sim} \tau_{>n} Y \quad \iff \quad H^i X \xrightarrow{\sim} H^i Y \text{ for all } i > n.
$$

Proof. Note that for any object X the morphism $X \to \tau_{\geq n} X$ induces an isomorphism $H^i X \to H^i(\tau_{>n} X)$ for all $i > n$. Thus $H^i X \xrightarrow{\sim} H^i Y$ for all $i > n$ if and only if $H^i(\tau_{>n}X) \xrightarrow{\sim} H^i(\tau_{>n}Y)$ for all $i \in \mathbb{Z}$.

Now suppose that $\mathcal T$ is compactly generated and write $\mathcal T^c$ for the full subcategory of compact objects.

Definition 7.2. An object $X \in \mathcal{T}$ is called *pseudo-coherent* (with respect to the chosen t-structure) if X can be written as homotopy colimit of a sequence $X_0 \rightarrow$ $X_1 \to X_2 \to \cdots$ in \mathcal{T}^c such that $\tau_{>-i} X_i \xrightarrow{\sim} \tau_{>-i} X$ for all $i \geq 0$. We say that X has *bounded cohomology* if $H^n X = 0$ for $|n| \gg 0$.

Lemma 7.3. *The functor*

 $\mathfrak{T} \longrightarrow \text{Add}((\mathfrak{T}^c)^{\text{op}}, \text{Ab}), \quad X \mapsto h_X := \text{Hom}(-, X)|_{\mathfrak{T}^c},$

is fully faithful when restricted to pseudo-coherent objects with bounded cohomology.

Proof. Let X, Y be objects in T. Suppose that $X = \text{hocolim}_i X_i$ is pseudo-coherent and $H^{n}Y = 0$ for $n \ll 0$. Let C_i denote the cone of $X_i \to X_{i+1}$. The induced morphism $\tau_{>-i}X_i \to \tau_{>-i}X_{i+1}$ is an isomorphism since $\tau_{>-i}\tau_{>-i+1} = \tau_{>-i}$. Thus $C_i \in \mathfrak{T}^{\leq -i}$ and therefore $\text{Hom}(X_{i+1}, Y) \xrightarrow{\sim} \text{Hom}(X_i, Y)$ for $i \gg 0$. It follows from Lemma [4.2](#page-9-1) that $Ph(X, Y) = 0$, so

$$
Hom(X, Y) \xrightarrow{\sim} Hom(h_X, h_Y)
$$

by Lemma [4.3.](#page-10-1) \Box

Example 7.4. Let Λ be a ring and $\mathcal{T} = \mathbf{D}(\Lambda)$ the derived category of the category of all Λ-modules with the standard t-structure. Then the canonical functor $\mathbf{K}^{-}(\text{proj}\,\Lambda) \rightarrow \mathbf{D}(\Lambda)$ identifies $\mathbf{K}^{-}(\text{proj}\,\Lambda)$ with the full subcategory of pseudocoherent objects in $\mathbf{D}(\Lambda)$.

Proof. For $X \in \mathbf{K}^-(\text{proj}\,\Lambda)$ and $i \geq 0$ set $X_i := \sigma_{\geq -i}X$. Then we have $X =$ hocolim_i $X_i = X$ and $\tau_{>-i} X_i \stackrel{\sim}{\rightarrow} \tau_{>-i} X$ for all $i \geq 0$. Thus X is pseudo-coherent. The other implication is left to the reader. \Box

The example shows that for a right coherent ring Λ and any object X in $\mathcal{T} =$ $\mathbf{D}(\Lambda)$ the following are equivalent:

(PC) X is pseudo-coherent and has bounded cohomology.

 (HP) X is homologically perfect.

This seems to be a common phenomenon (cf. Propositions [8.1](#page-18-0) and [A.1\)](#page-20-0) though we do not have a general proof.

Let C be a triangulated category and fix a cohomological functor $H: \mathcal{C} \to \mathcal{A}$. Call a sequence $(X_i)_{i>0}$ in C *strongly bounded* if $\text{colim}_i H^n(X_i) = 0$ for $|n| \gg 0$, and if for every $n \in \mathbb{Z}$ we have $H^n(X_i) \to H^n(X_{i+1})$ for $i \gg 0$. By abuse of notation, we write $\hat{\mathcal{C}}^b$ for the full subcategory of strongly bounded objects in $\hat{\mathcal{C}}^2$ $\hat{\mathcal{C}}^2$.

Lemma 7.5. Suppose that $(PC) \Leftrightarrow (HP)$ for all $X \in \mathcal{T}$, and set $\mathcal{C} := \mathcal{T}^c$. Then *the functor*

$$
F \colon \widehat{\mathcal{C}}^b \longrightarrow \mathcal{T}, \quad X \mapsto \operatorname{hocolim}_{i} X_i,
$$

is fully faithful functor and identifies \hat{C}^b *with the full subcategory of pseudo-coherent objects having bounded cohomology. When* T *admits a morphic enhancement, then* F *is a triangle functor.*

Proof. The first assertion follows from Lemmas [4.6](#page-10-3) and [7.3.](#page-17-0) For the second assertion, see Lemma [C.10.](#page-34-2)

8. Noetherian schemes

We fix a noetherian scheme X. Let Qcoh X denote the category of quasi-coherent sheaves on X, and coh X denotes the full subcategory of coherent sheaves. We consider the derived categories

$$
\mathbf{D}^{\mathrm{per}}(\mathbb{X}) \hookrightarrow \mathbf{D}^b(\mathrm{coh}\,\mathbb{X}) \hookrightarrow \mathbf{D}(\mathrm{Qcoh}\,\mathbb{X}).
$$

The triangulated category $\mathbf{D}(\mathrm{Qcoh}\,\mathbb{X})$ is compactly generated and the full subcategory of compact objects agrees with the category $\mathbf{D}^{\text{per}}(\mathbb{X})$ of perfect complexes [\[31\]](#page-36-12). We use the standard t-structure and then the above notion of a pseudo-coherent object identifies with the usual one; see [\[17,](#page-35-0) $\S 2.3$], [\[40,](#page-36-13) $\S 2.2$], and [\[39,](#page-36-14) $\S 0$ DJM]. A precise reference is [\[39,](#page-36-14) [Lemma 0DJN\]](http://stacks.math.columbia.edu/tag/0DJN), which uses approximations and builds on work of Lipman and Neeman [\[25\]](#page-36-15).

We obtain the following description of the objects in $\mathbf{D}^b(\mathrm{coh}\,\mathbb{X})$. For a refinement, see Theorem [B.1.](#page-21-0) We use the notion of a homologically perfect object with respect to the functor that takes degree zero cohomology of a complex.

Proposition 8.1. *For an object* X *in* D(Qcoh X) *the following are equivalent:*

- (1) X *belongs* to $\mathbf{D}^b(\mathrm{coh}\,\mathbb{X})$.
- (2) X *is pseudo-coherent and has bounded cohomology.*
- (3) X *is homologically perfect.*

²The condition $H^n(X_i) \to H^n(X_{i+1})$ for $i \geq 0$ is automatic for a Cauchy sequence X when $H = \text{Hom}(C, -)$ for an object $C \in \mathcal{C}$.

Proof. (1) \Leftrightarrow (2): See [\[40,](#page-36-13) Example 2.2.8].

 $(2) \Rightarrow (3)$: Let $X = \text{hocolim}_{i} X_{i}$ be pseudo-coherent and C a perfect com-plex. The argument in the proof of Lemma [7.3](#page-17-0) shows that $(X_i)_{i\geq 0}$ is a Cauchy sequence in $\mathbf{D}^{\text{per}}(\mathbb{X})$. More precisely, the cone of $X_i \to X_{i+1}$ belongs to $\mathfrak{T}^{\leq -i}$, and therefore $Hom(C, X_i) \rightarrow Hom(C, X_{i+1})$ for $i \gg 0$; see [\[39,](#page-36-14) §[09M2\]](http://stacks.math.columbia.edu/tag/09M2). Also, $H^{n}(X_i) \rightarrow H^{n}(X_{i+1})$ for all $i > -n$. Finally, for almost all $n \in \mathbb{Z}$ we have $H^{n}(X_i) \cong H^{n}(X) = 0$ for $i \gg 0$, since X has bounded cohomology.

 $(3) \Rightarrow (1)$: Let $X = \text{hocolim}_{i} X_{i}$ be homologically perfect and $n \in \mathbb{Z}$. Then $H^n(X) \cong \text{colim}_i H^n(X_i)$ equals the cohomology of some perfect complex, so $H^n(X)$ is coherent. Also, $H^n(X) = 0$ for $|n| \gg 0$.

The following is now the analogue of Theorem [6.2](#page-16-1) for schemes that are not necessarily affine. The proof is very similar; see also Lemma [7.5](#page-18-2) for the general argument.

Theorem 8.2. *For a noetherian scheme* X *there is a canonical triangle equivalence*

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\mathbb{X})}^b \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\operatorname{coh} \mathbb{X})
$$

which sends a Cauchy sequence in $\mathbf{D}^{\text{per}}(\mathbb{X})$ to its colimit.

Proof. We consider the functor

$$
\mathbf{D}^b(\operatorname{coh} \mathbb{X}) \longrightarrow \operatorname{Add}(\mathbf{D}^{\rm per}(\mathbb{X})^{\rm op},\operatorname{Ab}), \quad X \mapsto \operatorname{Hom}(-,X)|_{\mathbf{D}^{\rm per}(\mathbb{X})},
$$

which is fully faithful by Lemma [7.3](#page-17-0) and Proposition [8.1.](#page-18-0) On the other hand, we have the functor

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\mathbb{X})}^{b} \longrightarrow \mathrm{Add}(\mathbf{D}^{\mathrm{per}}(\mathbb{X})^{\mathrm{op}}, \mathrm{Ab}), \quad X \mapsto \widetilde{X},
$$

which is fully faithful by Proposition [2.4.](#page-4-0) Both functors have the same essential image by Proposition [8.1,](#page-18-0) because we can identify this with a full subcategory of $\mathbf{D}(\text{Qcoh }\mathbb{X})$ by Lemma [4.6.](#page-10-3) This yields a triangle equivalence, since the triangulated structures of both categories identify with the one from $\mathbf{D}(\text{Qcoh }\mathbb{X})$; see Corollary [4.8](#page-12-1) plus Remark [4.10.](#page-13-0)

An immediate consequence is the following.

Corollary 8.3. *The singularity category of* X *(in the sense of Buchweitz and Orlov* [\[3,](#page-35-2) [37\]](#page-36-1)*) identifies with the Verdier quotient*

$$
\widehat{\frac{\mathbf{D}^{\rm per}(\mathbb{X})}{\mathbf{D}^{\rm per}(\mathbb{X})}}^{b}.
$$

Appendix A. Homologically perfect objects in homotopy theory

by Tobias Barthel

Let R be an associative ring spectrum and let \mathcal{D}_R be the derived category of right R-module spectra as constructed for example in [\[10\]](#page-35-16); if no confusion is likely to arise, we will refer to an object in \mathcal{D}_R simply as an R-module. If R is connective, then \mathcal{D}_R inherits the standard t-structure from the stable homotopy category, and we denote by $\mathcal{D}_R^b \subseteq \mathcal{D}_R$ the full triangulated subcategory of bounded R-module spectra, i.e., those R-modules M with $\pi_i M$ finitely presented over $\pi_0 R$ and $\pi_i M = 0$ for $|i| \gg 0$. As usual, $\mathcal{D}_R^c \subseteq \mathcal{D}_R$ is the full subcategory of compact R-modules or, equivalently, the thick subcategory generated by the right R-module R.

Throughout this appendix, we will employ homological grading, so for example the pseudo-coherence condition $\tau_{>-i}M_i \stackrel{\sim}{\to} \tau_{>-i}M$ introduced in Section [7](#page-17-1) translates to $\pi_j M_i \stackrel{\sim}{\to} \pi_j M$ for all $j < i$. Furthermore, the notion of homologically perfect object used here will always be with respect to the homological functor π_0 .

Proposition A.1. *Suppose* R *is a connective associative ring spectrum with* $\pi_0 R$ *right coherent and* $\pi_i R$ *finitely presented over* $\pi_0 R$ *for all* $i \geq 0$ *. The following conditions on* $M \in \mathcal{D}_R$ *are equivalent:*

- (1) M *is pseudo-coherent and has bounded homotopy.*
- (2) M *is homologically perfect.*
- (3) *M belongs* to \mathcal{D}_R^b .

Proof. The implication $(1) \Rightarrow (2)$ is proven as in Proposition [8.1\[](#page-18-0) $(2) \Rightarrow (3)$]: indeed, it suffices to test against compact objects of the form $C = \Sigma^n R$ for all $n \in \mathbb{Z}$, for which the claim is clear. In order to see that $(2) \Rightarrow (3)$, we first observe that any compact R-module has finitely presented homotopy groups by assumption on R. Therefore, any homologically perfect $M \in \mathcal{D}_R$ can only have finitely many nonzero homotopy groups, all of which must be finitely presented over π_0R by the Cauchy condition. Thus, M is bounded.

Now assume that $M \in \mathcal{D}_R^b$, then M has bounded homotopy and it remains to show that M has to be pseudo-coherent. To this end, we use a mild variant of the cellular tower construction of [\[10,](#page-35-16) Thm. III.2.10] or [\[16,](#page-35-17) Prop. 2.3.1], in which we only attach R-cells of a fixed dimension in each step. Indeed, let $M \in \mathcal{D}_R$ be a bounded below R-module with finitely presented homotopy groups and assume without loss of generality that the lowest nonzero homotopy group is in degree 0. Inductively, we construct a tower of R-modules $(M^k)_{k\geq 0}$ under M with:

- (i) $M^0 = M$.
- (ii) For all $k \geq 0$, there is a cofiber sequence

$$
F^k = \bigoplus_{G(k)} \Sigma^k R \longrightarrow M^k \longrightarrow M^{k+1},
$$

where the direct sum is indexed by a set $G(k)$ of generators of the finitely presented $\pi_0 R$ -module $\pi_k M^k$.

It follows by induction on k , the assumption on R , and the long exact sequence in homotopy that $\pi_* M^{k+1}$ is finitely presented over $\pi_0 R$ in all degrees and zero below degree $k + 1$, which allows us to construct the map $F^{k+1} \to M^{k+1}$ and to proceed with the induction.

Set $M_k = \text{fib}(M \to M^k)$. The octahedral axiom provides fiber sequences

$$
(A.1) \t M_k \longrightarrow M_{k+1} \longrightarrow F^k
$$

and a sequence of R-modules

$$
M_0 \longrightarrow M_1 \longrightarrow M_2 \longrightarrow \dots
$$

over M. The fiber sequences [\(A.1\)](#page-20-1) imply that $\pi_i M_k \to \pi_i M_{k+1}$ and hence $\pi_i M_k \to$ π_iM for all $i < k$, which then also shows that the homotopy colimit over $(M_k)_{k>0}$ is equivalent to M by a connectivity argument. Moreover, because M_k is built from finitely many R-cells, M_k is compact for any $k \geq 0$. It follows that M is pseudo-coherent as desired.

In light of Lemma [7.5,](#page-18-2) we obtain the following consequence.

Corollary A.2. *With notation as in Proposition [A.1,](#page-20-0) taking homotopy colimits* $induces an equivalence \,\widehat{\mathcal{D}_R^c}^b \xrightarrow{\sim} \mathcal{D}_R^b$ of triangulated categories.

In particular, the corollary applied to the Eilenberg–Mac Lane ring spectrum $H\Lambda$ of a right coherent ring Λ recovers Theorem [6.2.](#page-16-1)

Lemma A.3. *Let* R *be as in Proposition [A.1](#page-20-0) and assume additionally that the right* $global$ dimension of $\pi_0 R$ is finite, then \mathcal{D}_R^b coincides with the thick subcategory of \mathcal{D}_R^b generated by the Eilenberg–Mac Lane R-module $H\pi_0R$.

Proof. Since $\pi_0 R$ has finite right global dimension, any finitely presented $\pi_0 R$ module N admits a finite length resolution by finitely presented projective $\pi_0 R$ modules. This implies that the R-module spectrum HN belongs to Thick($H\pi_0R$). A Postnikov tower argument then shows that any $M \in \mathcal{D}_R^b$ is in Thick $(H\pi_0 R)$.

Conversely, since the R-module H_{π_0R} is bounded, so is any R-module that belongs to Thick($H\pi_0R$).

The stable homotopy category identifies with \mathcal{D}_R for the sphere spectrum $R = S^0$ and we obtain the following consequence, a variant of which has appeared independently in work of Neeman [\[36,](#page-36-7) Ex. 22].

Corollary A.4. *For a spectrum* X *in the stable homotopy category the following conditions are equivalent:*

- (1) X *is pseudo-coherent and has bounded homotopy.*
- (2) X *is homologically perfect.*
- (3) X *belongs to the thick subcategory generated by the spectrum* HZ*.*

In particular, a homologically perfect spectrum X *is compact if and only if* X = 0*.*

Proof. By the finite generation of the stable homotopy groups of spheres and because $\pi_0 S^0 \cong \mathbb{Z}$, the sphere spectrum $R = S^0$ satisfies the conditions of the previous lemma, so we have $\mathcal{D}_{S^0}^b = \text{Thick}(H\mathbb{Z})$.

A theorem of Serre says that a finite spectrum must have infinitely many nonzero homotopy groups, so this result implies in particular that a homologically perfect spectrum X is compact if and only if $X = 0$.

Note that, in contrast to the perfect derived categories of right coherent rings or noetherian schemes, the category $\mathcal{D}_{S^0}^b$ does not contain $\mathcal{D}_{S^0}^c$ as a subcategory.

Appendix B. Homologically perfect objects on noetherian schemes

by Tobias Barthel and Henning Krause

Throughout this appendix, all schemes will be assumed to be separated and noetherian. For a scheme \mathbb{X} , we write $\mathbf{D}(\text{Qcoh }\mathbb{X})$ for the derived category of quasicoherent sheaves on X and $G_{\mathbb{X}}$ denotes a compact generator of $\mathbf{D}(\mathrm{Qcoh}\,\mathbb{X})$, which exists by [\[4,](#page-35-18) Thm. 3.3.1]. The notion of homologically perfect object considered in this appendix is defined with respect to the cohomological functor H^0 , taking the degree zero cohomology of an object in $\mathbf{D}(\mathrm{Qcoh}\,\mathbb{X})$. Our goal is to give an intrinsic description of the homologically perfect objects in $\mathbf{D}(\mathrm{Qcoh}\,\mathbb{X})$ that does not depend on the chosen t-structure. For affine schemes, this has already been observed in Lemma [5.3,](#page-15-0) but the non-affine case is more complicated and relies crucially on Neeman's work on approximability [\[33,](#page-36-16) [34\]](#page-36-5). The main result is:

Theorem B.1. Let X be a separated noetherian scheme. An object $X \in D(Qcoh X)$ *belongs to* $\mathbf{D}^b(\text{coh }\mathbb{X})$ *if and only if* X *is the homotopy colimit of a sequence* $X_0 \to$ $X_1 \rightarrow X_2 \rightarrow \cdots$ of perfect complexes on X satisfying the following conditions for $every \ C \in {\bf D}^{\rm per}({\mathbb{X}})$:

- (1) $\text{Hom}(C, X_s) \xrightarrow{\sim} \text{Hom}(C, X_{s+1})$ *for* $s \gg 0$ *, and*
- (2) $\text{Hom}(C, \Sigma^n X) = 0 \text{ for } |n| \gg 0.$

Before we give the proof of the theorem at the end of this appendix, we record the following consequence, which is an immediate application of Proposition [8.1](#page-18-0) and Theorem [B.1.](#page-21-0) It shows in particular that the completion

$$
\widehat{\mathbf{D}^{\mathrm{per}}(\mathbb{X})}^b \stackrel{\sim}{\longrightarrow} \mathbf{D}^b(\operatorname{coh} \mathbb{X})
$$

depends only on the triangulated structure of $\mathbf{D}^{\text{per}}(\mathbb{X})$.

Corollary B.2. *The homologically perfect objects on a separated noetherian scheme* X *with respect to the standard t-structure depend only on the triangulated structure* of **D**(Qcoh X).

We will prepare for the proof of the theorem with three lemmata which make use of Neeman's study of strong generators and approximability for triangulated categories.

Lemma B.3. *Let* $i: \mathbb{U} \to \mathbb{X}$ *be an open immersion.* If (X_s) *is a Cauchy sequence in* $\mathbf{D}^{\text{per}}(\mathbb{X})$ *, then* (i^*X_s) *s is a Cauchy sequence in* $\mathbf{D}^{\text{per}}(\mathbb{U})$ *.*

Proof. First note that, because i is an open immersion and thus automatically quasi-compact, i^* exhibits $\mathbf{D}(\text{Qcoh}\,\mathbb{U})$ as the essential image of a smashing Bousfield localisation on $\mathbf{D}(\operatorname{Qcoh} \mathbb{X})$. Therefore, i^* preserves homotopy colimits and compact object and it has a fully faithful right adjoint $\mathbf{R}i_{*}$. In particular, $i^{*}G_{\mathbb{X}}$ is a compact generator of $\mathbf{D}(\mathrm{Qcoh}\,\mathbb{U})$, which we will denote by $G_{\mathbb{U}}$. Moreover, it follows from the projection formula that for every $Y \in D(Qcoh X)$ there is a canonical quasiisomorphism

(B.1)
$$
\mathbf{R}i_*i^*Y \simeq (\mathbf{R}i_*\mathbf{O}_{\mathbb{U}}) \otimes^{\mathbf{L}} Y,
$$

where $\mathcal{O}_{\mathbb{U}}$ is the structure sheaf of U.

In order to prove the lemma, it suffices by Lemma [5.2](#page-15-1) to show that for every $k \in \mathbb{Z}$ there exists an $s(k)$ such that for all $s > s(k)$:

$$
\operatorname{Hom}(\Sigma^k G_{\mathbb{U}}, i^* X_s) \xrightarrow{\sim} \operatorname{Hom}(\Sigma^k G_{\mathbb{U}}, i^* X_{s+1}).
$$

Without loss of generality, we will demonstrate the existence of $s(0)$; the remaining cases follow by an analogous argument applied to the shifts of $G_{\mathbb{U}}$. By adjunction, choice of $G_{\mathbb{U}} = i^* G_{\mathbb{X}}$, and substituting [\(B.1\)](#page-22-0), we thus have to show that there exists an integer $s(0)$ such that for all $s > s(0)$ and $\mathcal{F} = \mathbf{R}i_*\mathcal{O}_{\mathbb{U}} \in \mathbf{D}(\text{Qcoh }\mathbb{X})$:

(B.2)
$$
\text{Hom}(G_{\mathbb{X}}, \mathcal{F} \otimes^{\mathbf{L}} X_s) \xrightarrow{\sim} \text{Hom}(G_{\mathbb{X}}, \mathcal{F} \otimes^{\mathbf{L}} X_{s+1}).
$$

Note that the class of objects $\mathcal{F} \in \mathbf{D}(\text{Qcoh }\mathbb{X})$ for which $(B.2)$ holds is closed under retracts and arbitrary direct sums as $G_{\mathbb{X}}$ is compact and $\otimes^{\mathbf{L}}$ commutes with direct sums.

The object \mathcal{O}_U is perfect on U, so we may invoke Neeman's result [\[33,](#page-36-16) Thm. 0.18]: there exist A_0, B_0, N_0 with $A_0 \leq B_0$ such that $\mathbf{R}i_* \mathbb{O}_{\mathbb{U}} \in \overline{\langle G_{\mathbb{X}} \rangle}_{N_0}^{A_0, B_0}$ $\frac{N_{0},D_{0}}{N_{0}},$ i.e., $\mathbf{R}i_{*}\mathcal{O}_{\mathbb{U}}$ can be built from the collection $(\Sigma^k G_{\mathbb{X}})_{A_0 \leq k \leq B_0}$ using direct sums, retracts, and at most N_0 extensions; we refer to [\[33\]](#page-36-16) for the precise definition of $\overline{\langle G_{\mathbb{X}} \rangle_N}^{A,B}$. For $\mathcal{F} = \Sigma^k G_{\mathbb{X}}$ and writing $G_{\mathbb{X}}^{\vee}$ for the dual of $G_{\mathbb{X}}$, the Cauchy property applied to $C = G_{\mathbb{X}} \otimes^{\mathbf{L}} \Sigma^{-k} G_{\mathbb{X}}^{\vee}$ provides an integer t_k such that for all $s > t_k$ there is an isomorphism

$$
\mathrm{Hom}(G_{\mathbb{X}} \otimes^{\mathbf{L}} \Sigma^{-k} G_{\mathbb{X}}^{\vee}, X_s) \xrightarrow{\sim} \mathrm{Hom}(G_{\mathbb{X}} \otimes^{\mathbf{L}} \Sigma^{-k} G_{\mathbb{X}}^{\vee}, X_{s+1}).
$$

Set $f(1, A, B) = \max\{t_k \mid k \in [A, B]\}$, then $(B.2)$ holds for all $s > f(1, A, B)$ and $\mathcal{F} \in \overline{\langle G_{\mathbb{X}} \rangle}^{A,B}_1$ $\frac{1}{1}$.

We will proceed by induction on N, proving the following claim: for any $N \geq 1$ and any $A \leq B$ there exists an integer $f(N, A, B)$ such that for all $s > f(N, A, B)$ and $\mathcal{F} \in \overline{\langle G_{\mathbb{X}} \rangle_N^{A,B}}$ there is an isomorphism

$$
\operatorname{Hom}(G_{\mathbb{X}}, \mathcal{F} \otimes^{\mathbf{L}} X_s) \xrightarrow{\sim} \operatorname{Hom}(G_{\mathbb{X}}, \mathcal{F} \otimes^{\mathbf{L}} X_{s+1}).
$$

This will then imply the existence of $s(0) := f(N_0, A_0, B_0)$.

We have just checked that the claim holds for $N = 1$ and arbitrary $A \leq B$. Assume the claim has been proven for $N \geq 1$ and let $\mathcal{F} \in \overline{\langle G_{\mathbb{X}} \rangle}_{N+1}^{A,B}$, i.e., \mathcal{F} is a retract of an object \mathcal{F}' which fits in a triangle

$$
\mathcal{E}\longrightarrow \mathcal{F}'\longrightarrow \mathcal{G}\longrightarrow \Sigma \mathcal{E}
$$

with $\mathcal{E} \in \overline{\langle G_{\mathbb{X}} \rangle}^{A,B}_{1}$ A, B ₁ and $\mathcal{G} \in \overline{\langle G_{\mathbb{X}} \rangle_N}^{A,B}$. We thus obtain a morphism of exact sequences $\text{Hom}(G_{\mathbb{X}}, \Sigma^{-1}\mathcal{G} \otimes^{\mathbf{L}} X_s) \longrightarrow$ α_1 Ļ $\text{Hom}(G_{\mathbb{X}}, \mathcal{E} \otimes^{\mathbf{L}} X_s)$ —— α_2 ļ $\text{Hom}(G_{\mathbb{X}}, \mathcal{F}' \otimes^{\mathbf{L}} X_s) \longrightarrow$ α³ Ļ $\text{Hom}(G_{\mathbb{X}}, \mathcal{G} \otimes^{\mathbf{L}} X_s)$ — α⁴ ļ $\mathrm{Hom}(G_{\mathbb{X}}, \Sigma \mathcal{E} \otimes^{\mathbf{L}} X_s)$ α_5 Ļ $\mathrm{Hom}(G_{\mathbb{X}}, \Sigma^{-1}\mathcal{G} \otimes^{\mathbf{L}} X_{s+1})\longrightarrow \mathrm{Hom}(G_{\mathbb{X}}, \mathcal{E} \otimes^{\mathbf{L}} X_{s+1})\longrightarrow \mathrm{Hom}(G_{\mathbb{X}}, \mathcal{F} \otimes^{\mathbf{L}} X_{s+1})\longrightarrow \mathrm{Hom}(G_{\mathbb{X}}, \mathcal{G} \otimes^{\mathbf{L}} X_{s+1})\longrightarrow \mathrm{Hom}(G_{\mathbb{X}}, \mathcal{G} \otimes^{\mathbf{L}} X_{s+1})\longrightarrow \mathrm{Hom}(G_{\mathbb{X}}, \mathcal{G} \otimes^{\mathbf{L}} X_{$ Note that $\Sigma^{-1}\mathcal{G} \in \overline{\langle G_{\mathbb{X}} \rangle_N^{A-1,B-1}}$ and $\Sigma \mathcal{E} \in \overline{\langle G_{\mathbb{X}} \rangle_1^{A+1,B+1}}$ $\frac{1}{1}$. Therefore, if we set $f(N+1, A, B) = \max\{f(1, A, B), f(1, A+1, B+1), f(N, A, B), f(N, A-1, B-1)\},\$

then the morphisms $\alpha_1, \alpha_2, \alpha_4, \alpha_5$ in the above diagram are isomorphisms, hence so is α_3 by the five lemma. Consequently, $f(N+1, A, B)$ has the desired properties, and we conclude by induction. \Box

Lemma B.4. *If* $X \in D(Qcoh X)$ *is the homotopy colimit of a Cauchy sequence* (X_s) _s in $\mathbf{D}^{\text{per}}(\mathbb{X})$, then X has coherent cohomology sheaves.

Proof. Suppose U is an open affine subscheme of X and denote by $i: U \to X$ the corresponding inclusion. By Lemma [B.3,](#page-22-2) $(i^*X_s)_s$ is a Cauchy sequence in $\mathbf{D}^{\text{per}}(\mathbb{U})$, so for any n the sequence

$$
(H^n(i^*X_s))_s \cong (\text{Hom}(\Sigma^{-n}\mathcal{O}_{\mathbb{U}}, X_s))_s
$$

stabilises for $s \gg 0$, where the isomorphism is because U is affine. It follows that the homotopy colimit i^*X of $(i^*X_s)_s$ has coherent cohomology. Since coherence is a local property, the cohomology sheaves of X are coherent. \Box

Next we identify the objects having bounded cohomology, using the following criterion. We are grateful to Amnon Neeman for suggesting a proof.

Lemma B.5. An object X in $D(Qcoh X)$ belongs to $D^b(Qcoh X)$ if and only if for *all compact* C *we have* $\text{Hom}(C, \Sigma^n X) = 0$ *for* $|n| \gg 0$ *.*

Proof (Neeman). Fix a compact generator $G = G_{\mathbb{X}}$ and an object X in $\mathbf{D}(\text{Qcoh }\mathbb{X})$.

If X is in $\mathbf{D}^b(\text{Qcoh }\mathbb{X})$, then the fact that $\text{Hom}(G,\Sigma^n X) = 0$ for $|n| \gg 0$ is standard; see [\[39,](#page-36-14) §[09M2\]](http://stacks.math.columbia.edu/tag/09M2).

If $\text{Hom}(G, \Sigma^n X) = 0$ for $n \gg 0$, then X is in $\mathbf{D}^-(\text{Qcoh } \mathbb{X})$, by [\[25,](#page-36-15) Thm. 4.2]. Set $\mathfrak{T} := \mathbf{D}(\mathrm{Qcoh}\,\mathbb{X})$. The object G generates a t-structure by setting for $n \in \mathbb{Z}$

$$
\mathfrak{T}^{\geq n}_G:=\{X\in\mathfrak{T}\mid \mathrm{Hom}(G,\Sigma^iX)=0\text{ for all }i\leq n\}
$$

and

$$
\mathfrak{T}_G^{\leq n}:=\{X\in\mathfrak{T}\mid \mathrm{Hom}(X,\mathfrak{T}_G^{>n})=0\}.
$$

It follows from [\[34,](#page-36-5) Ex. 3.6] that this t-structure is *equivalent* to the standard t-structure on T in the following sense: there exist $p \geq q$ in Z such that

$$
\mathfrak{T}_G^{>p}\subseteq \mathfrak{T}^{>0}\subseteq \mathfrak{T}_G^{>q}.
$$

Thus $\text{Hom}(G, \Sigma^n X) = 0$ for $n \ll 0$ implies

$$
X \in \bigcup_{n \in \mathbb{Z}} \mathcal{T}_G^{>n} = \bigcup_{n \in \mathbb{Z}} \mathcal{T}^{>n} = \mathbf{D}^+(\operatorname{Qcoh} \mathbb{X}).
$$

Note that the proof in [\[34\]](#page-36-5) requires the scheme to be quasi-compact and separated.

Proof of Theorem [B.1.](#page-21-0) First assume that X belongs to $\mathbf{D}^b(\cosh X)$. Then the implication (1) \Rightarrow (3) of Proposition [8.1](#page-18-0) shows that X can be written as the homotopy colimit of a Cauchy sequence in $\mathbf{D}^{\text{per}}(\mathbb{X})$, keeping in mind the comments about pseudo-coherent objects before Proposition [8.1.](#page-18-0) Condition (2) follows from Lemma [B.5.](#page-23-0)

Conversely, suppose X is the homotopy colimit of a Cauchy sequence in $\mathbf{D}^{\text{per}}(\mathbb{X})$ satisfying Condition (2) . It follows from Lemma [B.5](#page-23-0) that X has bounded cohomol-ogy, while Lemma [B.4](#page-23-1) guarantees that X has coherent cohomology sheaves, hence X belongs to $\mathbf{D}^b(\mathrm{coh}\,\mathbb{X})$. $(\cosh \mathbb{X})$.

Appendix C. Morphic enhancements and triangle completions

by Bernhard Keller

For a category C, we denote by MC the category of morphisms $f: X_1 \to X_0$ of C. Let A be an abelian category and DA its derived category. We have the cone functor

 $DMA \rightarrow DA$

taking a morphism of complexes f to its mapping cone. It allows us to capture the notion of standard triangle and of coherent morphism between standard triangles. In this appendix, we recall the axiomatization of the links between DMA and DA given in Section 6 of [\[19\]](#page-35-4) and apply it to the construction of triangulated completions of triangulated categories. Our treatment is slightly different from that of [\[19\]](#page-35-4) because we work with triangulated categories instead of suspended categories.

C.1. Morphic enhancements. Let $\mathcal T$ and $\mathcal T_1$ be triangulated categories and

$$
Q_0\colon \mathfrak{T} \to \mathfrak{T}_1
$$

a fully faithful triangle functor admitting a left adjoint P_0 and a right adjoint P_1 . We define an additive functor

$$
M: \mathfrak{T}_1 \to \mathfrak{M}\mathfrak{T} ,\ X \mapsto MX = (\alpha X: P_1X \to P_0X)
$$

by requiring that $Q_0 \alpha X$ equals the composition of the adjunction morphisms

$$
Q_0 P_1 X \to X \to Q_0 P_0 X.
$$

For example, with the above notations, we can take $\mathcal{T} = \mathcal{D}\mathcal{A}$ and $\mathcal{T}_1 = \mathcal{D}\mathcal{M}\mathcal{A}$. We identify the objects of DMA with morphisms of complexes. With this convention, the functor Q_0 takes a complex X to its identity morphism and the functors P_i take a morphism of complexes $f: X_1 \to X_0$ to X_i , $i = 0, 1$. Then the functor $M: \mathcal{DMA} \to \mathcal{MDA}$ takes a morphism of complexes $f: X_1 \to X_0$ to its image in the category of morphisms of the derived category DA (each morphism of complexes yields a morphism in the derived category).

Recall that the triple (P_0, Q_0, P_1) yields a canonical recollement [\[1\]](#page-35-15)

(C.1)
$$
\mathfrak{T} \xleftarrow{\begin{array}{c} P_0 \\ \longleftarrow Q_0 \longrightarrow \end{array}} \mathfrak{T}_1 \xleftarrow{\begin{array}{c} Q'_1 \\ \longleftarrow P'_2 \longrightarrow \end{array}} \mathfrak{T}_1/\mathfrak{T}.
$$

Recall that a functor is an *epivalence* if it is conservative (i.e. it detects isomorphisms), full and essentially surjective.

Theorem C.1. *The following are equivalent:*

- (i) *The functor* $M: \mathcal{T}_1 \to \mathcal{MT}$ *is an epivalence.*
- (ii) In the above recollement, we have $\text{Ker } P_0 \subseteq (\text{Ker } P_1)^{\perp}$ and the composition P1Q′ 1 *is an equivalence.*

Definition C.2. The triangle functor $Q_0: \mathcal{T} \to \mathcal{T}_1$ is a *morphic enhancement of* \mathcal{T} if the equivalent conditions of the theorem hold.

For example, it is easy to check that the functor $M: \mathcal{DMA} \rightarrow MDA$ is an epivalence if A is an abelian category. For more examples, we refer to Section [C.2](#page-27-0) below.

Proof of Theorem [C.1.](#page-24-0) We prove the implication from (i) to (ii). We start by constructing a right adjoint $P_{1\rho}$ of P_1 . Let Y be an object of T. Since M is an epivalence, we can find an object $P_{1\rho}Y$ and an isomorphism in ${\mathcal{MT}}$

For X in \mathfrak{T}_1 , consider the map

$$
\mathcal{T}_1(X, P_{1\rho}Y) \to \mathcal{T}(P_1X, Y)
$$

taking f to $(\phi Y)(P_1 f)$. Since M is full, it is surjective. Suppose that $f: X \to P_{1\rho}Y$ is in the kernel. Form a triangle

$$
X \xrightarrow{f} P_{1\rho} Y \xrightarrow{g} Z \xrightarrow{ } \Sigma X.
$$

Its image under M is the morphism of triangles

$$
P_1 X \xrightarrow{0} P_1 P_{1\rho} Y \xrightarrow{P_1 g} P_1 Z \longrightarrow \Sigma P_1 X
$$

$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$

$$
P_0 X \xrightarrow{0} 0 \longrightarrow P_0 Z \longrightarrow \Sigma P_0 X.
$$

This shows that Mg admits a retraction in MT. Since M is full and conservative, this implies that g admits a retraction and f vanishes. Thus we have the right adjoint $P_{1\rho}$ of P_1 . Since P_1 is a localization functor, $P_{1\rho}$ is fully faithful. By construction, its image is Ker P_0 . Therefore, the functors P_1 and $P_{1\rho}$ induce quasiinverse equivalences between $\mathcal T$ and Ker P_0 . We also know that Q'_1 and P'_2 induce quasi-inverse equivalences between $\mathcal{T}_1/\mathcal{T}$ and Ker P_0 . Thus, the functor $P_1Q'_1$ is an equivalence. Now let X be in Ker P_1 , Y in Ker P_0 and let $f: X \to Y$ be a morphism. Form a triangle

$$
X \xrightarrow{f} Y \xrightarrow{g} Z \xrightarrow{ } \Sigma X.
$$

Its image under M is the morphism of triangles

$$
0 \longrightarrow P_1 Y \longrightarrow P_1 Z \longrightarrow \Sigma 0
$$

$$
P_0 X \longrightarrow 0 \longrightarrow P_0 Z \longrightarrow \Sigma P_0 X.
$$

It follows that Mg admits a retraction. Since M is full and conservative, g admits a retraction and f vanishes.

We prove the implication from (ii) to (i). Let X be in \mathfrak{T}_1 and Y in T. We have

$$
\mathfrak{T}(P_1X,Y)\xrightarrow{\sim} \mathfrak{T}(P_1X,P_1Q_1'(P_1Q_1')^{-1}Y)\xrightarrow{\sim} \mathfrak{T}(Q_0P_1X,Q_1'(P_1Q_1')^{-1}Y).
$$

We have the triangle

$$
Q_0 P_1 X \longrightarrow X \longrightarrow Q_2' P_2' X \longrightarrow \Sigma Q_0 P_1 X.
$$

Since there are no nonzero morphisms from $\text{Ker } P_1 = \text{Im } Q'_2$ to $\text{Ker } P_0 = \text{Im } Q'_1$, it follows that we have a bijection

$$
\mathfrak{T}(P_1X,Y) \xrightarrow{\sim} \mathfrak{T}(X,Q'_1(P_1Q'_1)^{-1}Y).
$$

Thus, the functor P_1 admits the right adjoint $Q_1 = Q'_1 (P_1 Q'_1)^{-1}$. Since P_1 is a localization functor, Q_1 is fully faithful. We have $\text{Im } Q_1 = \text{Im } Q'_1 = \text{Ker } P_0$. We prepare for the proof of the fullness of M . Let X be in \mathcal{T}_1 . We form the triangle

(C.2) $X \longrightarrow Q_0P_0X \oplus Q_1P_1X \longrightarrow Y \longrightarrow \Sigma X$

over the morphism whose components are the adjunction morphisms. The adjunctions yield a canonical isomorphism

$$
P_1Q_0P_0X \oplus P_1Q_1P_1X \xrightarrow{\sim} P_0X \oplus P_1X.
$$

Using this we see that the image of the triangle $(C.2)$ under M is the morphism of triangles

$$
\begin{array}{ccc}\nP_1X & \xrightarrow{\begin{bmatrix} \alpha X \\ \text{id} \end{bmatrix}} P_0X \oplus P_1X & \xrightarrow{\begin{bmatrix} \beta & \gamma \end{bmatrix}} P_1Y \longrightarrow \Sigma P_1X \\
\downarrow \qquad & \
$$

In particular, Y belongs to Ker P_0 and $\beta: P_0 X \xrightarrow{\sim} P_1 Y$ yields a canonical isomorphism $Q_1 P_0 X \xrightarrow{\sim} Y$. Thus the triangle [\(C.2\)](#page-26-0) is isomorphic to a functorial triangle

(C.3)
$$
X \longrightarrow Q_0 P_0 X \oplus Q_1 P_1 X \longrightarrow Q_1 P_0 X \longrightarrow \Sigma X.
$$

Let Z be in \mathcal{T}_1 . If we apply $\mathcal{T}_1(Z, ?)$ to this triangle and use the adjunctions, we obtain a bifunctorial exact sequence

$$
\mathfrak{T}(\Sigma P_1 Z, P_0 X) \longrightarrow \mathfrak{T}_1(Z, X) \longrightarrow \mathcal{MT}(MZ, MX) \longrightarrow 0.
$$

This shows in particular that $M: \mathfrak{I}_1 \to \mathfrak{MT}_0$ is full. We claim that its kernel is an ideal of square 0. Indeed, suppose that $g: X \to Y$ and $f: Y \to Z$ belong to the kernel. Consider the morphisms of triangles

$$
\Sigma^{-1}Q_1P_0X \longrightarrow X \longrightarrow Q_0P_0X \oplus Q_1P_1X \longrightarrow Q_1P_0X
$$

\n
$$
\downarrow 0
$$

\n
$$
\Sigma^{-1}Q_1P_0Y \longrightarrow Y \longrightarrow Q_0P_0Y \oplus Q_1P_1Y \longrightarrow Q_1P_0Y
$$

\n
$$
\downarrow 0
$$

\n
$$
\Sigma^{-1}Q_1P_0Z \longrightarrow Z \longrightarrow Q_0P_0Z \oplus Q_1P_1Z \longrightarrow Q_1P_0Z.
$$

Clearly g factors through $\Sigma^{-1}Q_1P_0Y \to Y$ and f factors through

$$
Y \to Q_0 P_0 Y \oplus Q_1 P_1 Y.
$$

It follows that fg vanishes. Since M is full, it follows that it is conservative. Let us show that it is essentially surjective. Let $f: X_1 \to X_0$ be an object of MT and consider the componentwise split short exact sequence of MT

$$
0 \longrightarrow X_1 \xrightarrow{\begin{bmatrix} \mathrm{id} \\ f \end{bmatrix}} X_1 \oplus X_0 \xrightarrow{\begin{bmatrix} -f \mathrm{id} \\ \mathrm{id} \end{bmatrix}} X_0 \longrightarrow 0
$$

$$
0 \longrightarrow X_0 \xrightarrow{\mathrm{id}} X_0 \longrightarrow X_0 \longrightarrow 0.
$$

The middle and the right hand term lift respectively to $Q_1X_1 \oplus Q_0X_0$ and Q_1X_0 . Since M is full, the morphism between the middle and the right hand term lifts to a morphism $g: Q_1X_1 \oplus Q_0X_0 \rightarrow Q_1X_0$. It is easy to see that $f: X_1 \rightarrow X_0$ is isomorphic to MY , where Y is defined by the triangle

$$
\Sigma^{-1}Q_1X_0 \longrightarrow Y \longrightarrow Q_1X_1 \oplus Q_0X_0 \stackrel{g}{\longrightarrow} Q_1X_0.
$$

C.2. **Examples.** As we have already seen, if A is abelian, then the derived category DMA yields a morphic enhancement of DA.

More generally, if $\mathcal T$ is an algebraic triangulated category, i.e. triangle equivalent to the stable category $\underline{\mathcal{E}}$ of a Frobenius category \mathcal{E} , then it admits a morphic enhancement given by the functor

$$
X \mapsto (\mathrm{id} \colon X \to X)
$$

from $\underline{\mathcal{E}}$ to the stable category $\underline{\mathcal{E}}$ of the category \mathcal{E} of inflations $X_1 \to X_0$ of \mathcal{E} endowed with the class of short exact sequences inducing conflations in the two components and in the cokernel, cf. Example b) of Section 6.1 in [\[19\]](#page-35-4).

More generally, if $\mathcal T$ is the base category of a (strong) stable derivator $\mathbb D$ in the sense of [\[13\]](#page-35-19), then the value of $\mathbb D$ on the index category $\{0 \leq 1\}$ yields a morphic enhancement of T. Since the homotopy category of each combinatorial stable model category is the base of a stable derivator (cf. $[6]$ [\[13\]](#page-35-19)), the triangulated categories arising commonly in algebra and topology admit morphic enhancements.

More generally, if $\mathcal T$ is the base of an epivalent tower of triangulated categories in the sense of $[19]$, then $\mathcal T$ has a morphic enhancement given by the first floor of the tower.

C.3. **Properties.** Let $Q_0: \mathcal{T} \to \mathcal{T}_1$ be a morphic enhancement in the sense of Section [C.1.](#page-24-1) Part b) of the following proposition shows that the underlying additive categories of T and \mathfrak{T}_1 and the additive functor $Q_0: \mathfrak{T} \to \mathfrak{T}_1$ determine the triangulated structure of T.

Proposition C.3. a) *There is an infinite sequence of adjoint functors*

... $+ P_n + Q_n + P_{n+1} + Q_{n+1} + \ldots, n \in \mathbb{Z}$.

We have natural isomorphisms $\Sigma Q_n \overset{\sim}{\to} Q_{n+3}$ and $\Sigma P_n \overset{\sim}{\to} P_{n-3}$ for all *integers* n. Each $Q_n: \mathcal{T} \to \mathcal{T}_1$ *is a morphic enhancement with associated recollement*

$$
\mathfrak{T} \xleftarrow{\begin{array}{c} P_n \\ \longleftarrow Q_n \longrightarrow \end{array}} \mathfrak{T}_1 \xleftarrow{\begin{array}{c} Q_{n+1} \\ \longleftarrow P_{n+2} \longrightarrow \end{array}} \mathfrak{T} \right.
$$

b) We have a canonical isomorphism $\Sigma \to P_{-1}Q_1$. For each $X \in \mathfrak{T}_1$, there is *a functorial triangle*

$$
P_1 X \xrightarrow{\alpha X} P_0 X \xrightarrow{\qquad} P_{-1} X \xrightarrow{\qquad} \Sigma P_1 X,
$$

where the first two morphisms are given by the adjunctions and the third one is the composition

$$
P_{-1}X \to P_{-2}X \xrightarrow{\sim} \Sigma P_1X.
$$

Each triangle of T *is isomorphic to a triangle of this form.*

c) The kernel of $M: \mathfrak{T}_1 \to \mathfrak{MT}$ *is an ideal of square zero. For* $X, Y \in \mathfrak{T}_1$, *there is a bifunctorial exact sequence*

$$
\mathfrak{T}(\Sigma P_1 X, P_0 Y) \to \mathfrak{T}_1(X, Y) \to \mathfrak{MT}(MX, MY) \to 0.
$$

Proof. a) In the proof of Theorem [C.1,](#page-24-0) we have constructed the adjoint Q_1 as $Q'_1 (P_1 Q'_1)^{-1}$. Since $P_1 Q'_1$ is an equivalence and Q'_1 admits the right adjoint P'_2 , the functor Q_1 admits a right adjoint P_2 . We have Im $Q_1 = \text{Ker } P_0$. Whence a short exact sequence

$$
0 \longrightarrow \mathfrak{T} \xrightarrow{Q_1} \mathfrak{T}_1 \xrightarrow{P_0} \mathfrak{T} \longrightarrow 0
$$

and a recollement

$$
\mathfrak{T} \xleftarrow{\begin{array}{c} P_1 \\ \hline \longleftarrow Q_1 \longrightarrow \end{array}} \mathfrak{T}_1 \xleftarrow{\begin{array}{c} Q_{-1} \\ \hline \longleftarrow P_0 \longrightarrow \end{array}} \mathfrak{T}.
$$

We need to show that $Q_1: \mathcal{T} \to \mathcal{T}_1$ is a morphic enhancement. We have Ker $P_2 =$ Im Q_0 and for $X \in \mathcal{T}$ and $Y \in \text{Ker } P_1$, we have

$$
\mathcal{T}_1(Q_0X, Y) \xrightarrow{\sim} \mathcal{T}(X, P_1Y) = 0.
$$

Thus, we have Ker $P_1 \subseteq (\text{Ker } P_2)^{\perp}$. We need to check that P_2Q_{-1} is an equivalence. For $X \in \mathcal{T}$, we have the triangle

$$
Q_1 P_2 Q_{-1} X \longrightarrow Q_{-1} X \longrightarrow Q_0 P_0 Q_{-1} X \longrightarrow \Sigma Q_1 P_2 Q_{-1} X.
$$

By applying P_1 to this triangle we find the triangle

$$
P_2Q_{-1}X \longrightarrow 0 \longrightarrow P_0Q_{-1}X \longrightarrow \Sigma P_2Q_{-1}X
$$

and therefore we have $X \to \Sigma P_2 Q_{-1} X$. Therefore, the functor $P_2 Q_{-1} : \mathfrak{T} \to \mathfrak{T}$ is an equivalence isomorphic to Σ^{-1} . Thus, the functor $Q_1: \mathcal{T} \to \mathcal{T}_1$ is a morphic enhancement. By induction, we get a sequence of adjoints

 $P_0 + Q_0 + P_1 + Q_1 + \ldots + P_n + Q_n + \ldots$

Since our assumption is self-dual, we also get a sequence of adjoints

$$
\ldots \dashv P_{-n} \dashv Q_{-n} \dashv \ldots \dashv P_0 \dashv Q_0.
$$

We have already constructed an isomorphism $P_2Q_{-1} \xrightarrow{\sim} \Sigma^{-1}$ and we have $\Sigma^{-1} \xrightarrow{\sim}$ $P_2\Sigma^{-1}Q_2$. Whence an isomorphism $P_2\Sigma Q_{-1} \stackrel{\sim}{\rightarrow} P_2Q_2$. We have Im Q_{-1} = $\text{Ker } P_1 \subseteq (\text{Ker } P_2)^{\perp}$. By the recollement

$$
\mathfrak{T}\xleftarrow{\begin{array}{c}P_0\\ \hline\longleftarrow Q_0\longrightarrow\end{array}}\mathfrak{T}_1\xleftarrow{\begin{array}{c}Q_1\\ \hline\longleftarrow P_2\longrightarrow\end{array}}\mathfrak{T}
$$

we also have $\text{Im } Q_2 = \text{Ker } P_1 \subseteq (\text{Ker } P_2)^{\perp}$. Since the restriction of P_2 to $(\text{Ker } P_2)^{\perp}$ is an equivalence, we get an isomorphism $\Sigma Q_{-1} \stackrel{\sim}{\rightarrow} Q_2$. By induction, we get $\Sigma Q_n \xrightarrow{\sim} Q_{n+3}$ and by adjunction $\Sigma^{-1} P_n \xrightarrow{\sim} P_{n+3}$ for all integers n.

b) We have seen in the proof of a) that there is a canonical isomorphism $P_2Q_{-1} \xrightarrow{\sim}$ Σ^{-1} . By passing to the left adjoints we get an isomorphism $Q_1P_{-1} \to \Sigma$. As it follows from the proof of a), we have a recollement

$$
\mathfrak{T} \xleftarrow{\begin{array}{c} P_{-1} \\ \longleftarrow Q_{-1} \longrightarrow \end{array}} \mathfrak{T}_1 \xleftarrow{\begin{array}{c} Q_0 \\ \longleftarrow P_1 \longrightarrow \end{array}} \mathfrak{T} \right.
$$

Thus, for $X \in \mathcal{T}_1$, we have the functorial triangle

$$
Q_0 P_1 X \longrightarrow X \longrightarrow Q_{-1} P_{-1} X \longrightarrow \Sigma Q_0 P_1 X.
$$

By applying P_0 to this triangle we get the functorial triangle

$$
P_1X \longrightarrow P_0X \longrightarrow P_{-1}X \longrightarrow \Sigma P_1X.
$$

Since M is essentially surjective, each triangle of $\mathcal T$ is isomorphic to a triangle of this form.

c) This was already shown in the proof of the implication from (ii) to (i) in Theorem [C.1.](#page-24-0) \Box

We keep the assumptions on $Q_0: \mathfrak{T} \to \mathfrak{T}_1$.

Definition C.4. A *standard triangle* is a triangle of T

 $P_1X \longrightarrow P_0X \longrightarrow P_{-1}X \longrightarrow \Sigma P_0X$

associated with an object X of T1. A *coherent morphism between standard triangles* is a morphism

$$
P_1X \longrightarrow P_0X \longrightarrow P_{-1}X \longrightarrow \Sigma P_0X
$$

\n
$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$

\n
$$
P_1Y \longrightarrow P_0Y \longrightarrow P_{-1}Y \longrightarrow \Sigma P_1Y
$$

induced by a morphism $X \to Y$ of \mathfrak{T}_1 .

The following lemma will be crucial in checking the axioms of a triangulated category for a completion.

Lemma C.5. *Let* $f: X \to Y$ *be a morphism of* \mathcal{T}_1 *. Let*

 $X' = Q_{-1}P_{-1}X \oplus Q_0P_0X \oplus Q_1P_1X$

and let $f' : X \to Y \oplus X'$ be the morphism whose components are f and the adjunc*tion morphisms. Let*

$$
X \xrightarrow{f'} Y \oplus X' \longrightarrow Z \longrightarrow \Sigma X
$$

be a triangle. Then the standard triangle

$$
P_1 Z \longrightarrow P_0 Z \longrightarrow P_{-1} Z \longrightarrow \Sigma P_1 Z
$$

is isomorphic to the mapping cone [\[32,](#page-36-17) Section 1.3] *over the morphism of triangles*

$$
P_1X \longrightarrow P_0X \longrightarrow P_{-1}X \longrightarrow \Sigma P_1X
$$

\n
$$
\downarrow P_1f \qquad \qquad P_0f \qquad \qquad P_{-1}f \qquad \qquad \downarrow \Sigma P_1f
$$

\n
$$
P_1Y \longrightarrow P_0Y \longrightarrow P_{-1}Y \longrightarrow \Sigma P_1Y.
$$

Proof. For an object X of \mathcal{T}_1 , let

$$
P_1 X \xrightarrow{\alpha X} P_0 X \xrightarrow{\beta X} P_{-1} X \xrightarrow{\gamma X} \Sigma P_0 X
$$

be the standard triangle and let TX be the complex obtained by glueing the following triangles along their boundaries

$$
\Sigma^p P_1 X \xrightarrow{\alpha_p X} \Sigma^p P_0 X \xrightarrow{\beta_p X} \Sigma^p P_{-1} X \xrightarrow{\gamma_p X} \Sigma^{p+1} P_1 X , p \in \mathbb{Z},
$$

where $\alpha_p X = (-1)^p \Sigma^p \alpha X$, $\beta_p X = (-1)^p \Sigma^p \beta X$ and $\gamma_p X = (-1)^p \Sigma^p \gamma X$. We have to show that TZ is isomorphic to the mapping cone over the morphism $Tf: TX \rightarrow$ TY. For a complex $C = (C^p, d^p)$, let IC be the complex with components $C^p \oplus C^{p+1}$ and the differential

$$
\left[\begin{smallmatrix} 0 & \mathrm{id} \\ 0 & 0 \end{smallmatrix}\right] : C^p \oplus C^{p+1} \to C^{p+1} \oplus C^{p+2}
$$

and let $i_C : C \to IC$ be the morphism of complexes with the components

$$
\left[\begin{smallmatrix} \mathrm{id} \\ d^p \end{smallmatrix}\right] : C^p \to C^p \oplus C^{p+1}.
$$

One checks easily that TX' is canonically isomorphic to ITX and that the morphism $X \to X'$ whose components are the adjunction morphisms induces the morphism $i_{TX} : TX \to ITX$. Thus, the morphism $f : X \to Y \oplus X'$ induces the morphism

$$
\begin{bmatrix} Tf \\ i_{TX} \end{bmatrix} : TX \to TY \oplus ITX.
$$

Notice that this is a componentwise split monomorphism whose cokernel is canonically isomorphic to the mapping cone over $T f: TX \to TY$. Now the triangle

$$
X \xrightarrow{\quad f'} Y \oplus X' \xrightarrow{\qquad} Z \xrightarrow{\qquad} \Sigma X
$$

yields a componentwise split exact sequence

$$
0 \longrightarrow TX \longrightarrow T(Y \oplus X') \longrightarrow TZ \longrightarrow 0.
$$

It follows that TZ is canonically isomorphic to the cone over Tf .

C.4. Morphic functors, compact objects. Let $Q_0: S \to S_1$ and $Q_0: \mathcal{T} \to \mathcal{T}_1$ be morphic enhancements. A *morphic functor* $S \to \mathcal{T}$ is given by a square of triangle functors

$$
\begin{array}{ccc}\n & \mathcal{S} & \xrightarrow{Q_0} & \mathcal{S}_1 \\
F & & \downarrow & \downarrow \\
\mathcal{F} & & \downarrow & \mathcal{F}_1 \\
\mathcal{T} & \xrightarrow{Q_0} & \mathcal{T}_1 & \n\end{array}
$$

commutative up to given isomorphism such that the canonical morphisms

$$
P_0F_1 \to FP_0
$$
 and $FP_1 \to P_1F_1$

are invertible. Examples of morphic functors are provided by morphisms of epivalent towers of triangulated categories [\[19\]](#page-35-4) and by morphisms of stable derivators [\[13\]](#page-35-19).

Lemma C.6. *If* $F: \mathcal{S} \to \mathcal{T}$ *is a morphic functor, we have canonical isomorphisms* $P_nF_1 \xrightarrow{\sim} FP_n$ and $Q_nF \xrightarrow{\sim} F_1Q_n$

for all integers n*.*

Proof. Since Q_{-1} : S → S₁ and Q_{-1} : T → T₁ are again morphic enhancements, it is enough to show the claim for Q_{-1} and P_{-1} . Indeed, by induction it will then follow for Q_n and P_n for all $n < 0$ and by duality for all $n \geq 0$. The image of the canonical morphism $Q_{-1}F \to F_1Q_{-1}$ under P_0 fits into the commutative square

Thus, it is invertible. The image of $Q_{-1}F \to F_1Q_{-1}$ under P_1 is the identity of the zero object. Since M is conservative, it follows that the morphism $Q_{-1}F \to F_1Q_{-1}$ is invertible. Now consider the canonical morphism

$$
P_{-1}F_1 \to FP_{-1}.
$$

For each X of S_1 , it fits into a morphism of triangles

Thus, it is invertible. \Box

The inclusion of the subcategory of compact objects in a compactly generated triangulated category with a morphic enhancement is an example of a morphic functor, as shown by the next lemma.

Lemma C.7. Let $Q_0: \mathcal{T} \to \mathcal{T}_1$ be a morphic enhancement. Then \mathcal{T} is compactly *generated if and only if* \mathcal{T}_1 *is compactly generated. In this case, an object* X of \mathcal{T}_1 *is compact if and only if* P_0X *and* P_1X *are compact and the functor* Q_0 *induces a* morphic enhancement $\mathcal{T}^c \to \mathcal{T}_1^c$, where \mathcal{T}^c is the subcategory of compact objects. *Moreover, the inclusion* $\mathcal{T}^c \to \mathcal{T}$ *is a morphic functor.*

Proof. The localization functor $P_1: \mathcal{T}_1 \to \mathcal{T}$ admits two successive right adjoints. Thus it commutes with arbitrary coproducts and preserves compactness. Therefore, if \mathcal{T}_1 is compactly generated, then so is \mathcal{T} . For the converse implication, note that all the functors Q_n commute with arbitrary coproducts and preserve compactness (for the same reason). So if $\mathcal T$ is compactly generated, so are the subcategories Im Q_0 and Im Q_2 of \mathfrak{T}_1 and their inclusions commute with arbitrary coproducts. Since each object of \mathfrak{T}_1 is an extension of an object of Im Q_2 by an object of Im Q_0 , it follows that \mathfrak{T}_1 has arbitrary coproducts and is generated by the compact objects in Im Q_2 and Im Q_0 . Suppose that T and \mathcal{T}_1 are compactly generated. The functors P_1 and P_0 preserve compactness and so do Q_{-1} and Q_1 . If an object X of \mathfrak{T}_1 has compact P_0X and P_1X , then it is itself compact because of the triangle

$$
Q_{-1}P_0X \longrightarrow X \longrightarrow Q_1P_1X \longrightarrow \Sigma Q_{-1}P_0X.
$$

Now suppose that \mathcal{T}_1 and \mathcal{T}_1 are compactly generated. As we have seen, the functor $Q_0: \mathcal{T} \to \mathcal{T}_1$ induces a functor $Q_0: \mathcal{T}^c \to \mathcal{T}_1^c$ and P_0 and P_1 induce left and right adjoints. It is now clear that the epivalence $M: \mathfrak{T}_1 \to \mathfrak{MT}$ induces an epivalence $M: \mathfrak{T}^c_1 \to \mathfrak{MT}^c$ and that the inclusion $\mathfrak{T}^c \to \mathfrak{T}^c_1$ is a morphic functor.

C.5. **Completion.** Let \mathcal{T} be a triangulated category with a morphic enhancement $Q_0: \mathcal{T} \to \mathcal{T}_1$. Let X be a class of sequences

$$
X_0 \to X_1 \to \ldots \to X_p \to \ldots
$$

of $\mathfrak T$. We assume that the following hold for $\mathfrak X$:

- a) X is stable under passage to cofinal sequences i.e. if (X_n) belongs to X and (i_p) is a strictly increasing sequence of positive integers, then (X_{i_p}) belongs to $\mathfrak{X}.$
- b) X is stable under Σ and Σ^{-1} i.e. if (X_p) belongs to X so do (ΣX_p) and $(\Sigma^{-1}X_p).$
- c) X is stable under cones i.e. if $f: X \to Y$ is a morphism of sequences of X and for each $p \geq 0$, the object Z_p of \mathfrak{T}_1 lifts the object $f_p \colon X_p \to Y_p$ of MT and the morphism $Z_p \to Z_{p+1}$ lifts the morphism

of MT, then the sequence $(P_{-1}Z_p)$ belongs to X. d) $\mathfrak X$ is *phantomless* i.e. for X and Y in X, we have

$$
\lim_{p} \frac{1}{q} \operatorname{colim}_{q} \mathfrak{T}(X_p, Y_q) = 0.
$$

Let Mod T be the category of additive functors $\mathcal{T}^{\mathrm{op}} \to$ Ab. For $X \in \mathcal{T}$, let X^{\wedge} be the functor $\mathfrak{T}(?, X)$ represented by X. Define the completion $\widehat{\mathfrak{T}_{\mathfrak{X}}}$ to be the full subcategory of $Mod \mathcal{T}$ whose objects are the colimits

$$
LX = \operatornamewithlimits{colim}_p X_p^\wedge
$$

of sequences X of $\mathfrak X$. Note that by Proposition [2.4,](#page-4-0) this agrees with the definition in the main text. Define $\Sigma: \tilde{\mathcal{T}}_{\mathcal{X}} \to \tilde{\mathcal{T}}_{\mathcal{X}}$ to be the functor induced by $X \mapsto \Sigma X$. For a sequence (Z_p) of \mathcal{T}_1 such that (P_1Z_p) and (P_0Z_p) belong to \mathcal{X} , define the *standard triangle* associated with Z to be the Σ–sequence

$$
L(P_1Z_p) \longrightarrow L(P_0Z_p) \longrightarrow L(P_{-1}Z_p) \longrightarrow \Sigma L(P_1Z_p).
$$

Thus, the standard triangles of $\widehat{\mathfrak{T}_{\mathfrak{X}}}$ are exactly the colimits of sequences of coherent morphisms between standard triangles of T, cf. Definition [C.4.](#page-29-0) Define a *triangle* of $\widehat{\mathcal{T}}_{\mathcal{X}}$ to be a Σ –sequence isomorphic to a standard triangle.

Theorem C.8. *Endowed with the suspension functor* Σ *and the above triangles the completion* $\widehat{T_X}$ *is a triangulated category. If* $\mathfrak X$ *contains the constant sequences consisting of identities only, we have a canonical triangle embedding* $\mathcal{T} \to \widehat{\mathcal{T}_{\mathcal{X}}}$.

Proof. Let X be a sequence in X . We need to show that

$$
LX \xrightarrow{\text{id}} LX \xrightarrow{\hspace*{1cm}} 0 \xrightarrow{\hspace*{1cm}} \Sigma LX
$$

is a triangle (TR0). In fact, it is the standard triangle associated with the sequence (Q_0X_p) . Let X and Y be sequences in X and let $f: LX \to LY$ be a morphism. After passing to cofinal sequences we may assume that f is in fact a morphism of sequences. We lift each object $f_p: X_p \to Y_p$ of MT to an object Z_p of \mathfrak{T}_1 and each morphism

$$
X_p \xrightarrow{f_p} Y_p
$$

\n
$$
\downarrow \qquad \qquad \downarrow
$$

\n
$$
X_{p+1} \xrightarrow{f_{p+1}} Y_{p+1}
$$

to a morphism $Z_p \to Z_{p+1}$ of \mathfrak{T}_1 . Then the standard triangle associated with (Z_p) yields a triangle whose first morphism identifies with $f: LX \to LY$ and we have proved TR1. Let

be a commutative diagram of $\widehat{\mathcal{T}}_X$ whose rows are triangles. We will show that there is a morphism $LZ \to LZ'$ completing the diagram to a morphism of triangles whose mapping cone is still a triangle. This implies the rotation axiom TR2 (take $LX' = LY' = LZ' = 0$, the axiom about the missing morphism TR3 and axiom TR4' of Section 1.4 of [\[32\]](#page-36-17). By Proposition 1.4.6 of [\[32\]](#page-36-17), the octahedral axiom TR4 follows. We may assume that the given triangles are the standard triangles associated with sequences U and V of \mathfrak{T}_1 . The given commutative diagram

is a morphism in $\widetilde{M} \mathcal{T}_{\mathcal{X}}$. As in Example [2.9,](#page-6-2) we see that the canonical functor $(\widetilde{M} \mathcal{T})_{\mathcal{M}\mathcal{X}} \to \widetilde{M} \mathcal{T}_{\mathcal{X}}$ is an equivalence where $\widetilde{M} \mathcal{X}$ is the class of sequences of mor- $(\widehat{\mathcal{MT}})_{\mathcal{M}\mathcal{X}} \to \widehat{\mathcal{MT}_{\mathcal{X}}}$ is an equivalence, where \mathcal{MX} is the class of sequences of morphisms $(X_{1p} \to X_{0p})$ with (X_{1p}) and (X_{0p}) in X. So the given commutative diagram may be viewed as a morphism

$$
LMU \to LMV
$$

in $(\widehat{MT})_{\widehat{MX}}$. We claim that it suffices to lift it to a morphism of sequences $U \to V$ of \mathfrak{T}_1 . Indeed, once we have such a lift, we can form triangles

$$
U_p \longrightarrow V_p \oplus U'_p \longrightarrow W_p \longrightarrow \Sigma U_p
$$

as in Lemma [C.5](#page-29-1) and morphisms of triangles

$$
U_p \longrightarrow V_p \oplus U'_p \longrightarrow W_p \longrightarrow \Sigma U_p
$$

$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$

$$
U_{p+1} \longrightarrow V_{p+1} \oplus U'_{p+1} \longrightarrow W_{p+1} \longrightarrow \Sigma U_{p+1}.
$$

By Lemma [C.5,](#page-29-1) the standard triangle associated with W will be the mapping cone over the morphism of standard triangles associated with $U \to V$. The given morphism $LMU \rightarrow LMV$ identifies with an element of

$$
\lim_{p} \mathop{\mathrm{colim}}\limits_{q} \mathcal{MT}(MU_p, MV_q).
$$

It suffices to show that the natural map

$$
\lim_p \underset{q}{\text{colim}}\, \mathfrak{T}_1(U_p,V_q)\to \lim_p \underset{q}{\text{colim}}\, \mathcal{MT}(MU_p, MV_q)
$$

is surjective. By part c) of Proposition C.3, for each $p \geq 0$, we have an exact sequence

$$
\underset{q}{\text{colim}} \mathfrak{T}(\Sigma P_1 U_p, P_0 V_q) \to \underset{q}{\text{colim}} \mathfrak{T}_1(U_p, V_q) \to \underset{q}{\text{colim}} \mathfrak{M} \mathfrak{T}(MU_p, MV_q) \to 0.
$$

Let us abbreviate it to

$$
A_p \to B_p \to C_p \to 0.
$$

Let A'_{p} be the image of A_{p} in B_{p} . We have the exact sequence

$$
0 \to \lim A'_p \to \lim B_p \to \lim C_p \to \lim^1 A'_p.
$$

Since \lim^1 is right exact, we have a surjection $\lim^1 A_p \to \lim^1 A'_p$. Since X is phantomless, the group $\lim^1 A_p$ vanishes. So

$$
\lim B_p \to \lim C_p
$$

is surjective as required.

C.6. Functoriality. The construction of the completion is functorial with respect to morphic triangle functors. Let us spell this out: Let $\mathcal T$ and $\mathcal T'$ be skeletally small triangulated categories and $Q_0: \mathcal{T} \to \mathcal{T}_1$ and $Q_0: \mathcal{T}' \to \mathcal{T}_1'$ be morphic enhancements. Let $F: \mathfrak{T} \to \mathfrak{T}'$ be a morphic triangle functor with enhancement $F_1: \mathfrak{T}_1 \to \mathfrak{T}'_1$. Let X and X' be classes of sequences of T and T' satisfying the assumptions of Section [C.5](#page-31-0) and such that $F\mathfrak{X} \subseteq \mathfrak{X}'$.

Lemma C.9. *The functor* F *induces* a canonical triangle functor $\widehat{F}: \widetilde{\mathcal{I}}_{\mathcal{X}} \to \widetilde{\mathcal{I}}'_{\mathcal{X}'}$.

Proof. This is a straightforward verification based on the fact that (F, F_1) is compatible with all the adjoints as checked in Lemma [C.6.](#page-30-0)

$$
\Box
$$

C.7. Completion inside a compactly generated category. Let T be a compactly generated triangulated category with a morphic enhancement $Q_0: \mathcal{T} \to \mathcal{T}_1$. By Lemma [C.7,](#page-31-1) we have an induced morphic enhancement $Q_0: \mathcal{T}^c \to \mathcal{T}_1^c$ between the subcategories of compact objects and the inclusion $\mathcal{T}^c \to \mathcal{T}$ is morphic. Let X be a class of sequences of \mathcal{T}^c satisfying the hypotheses of Section [C.5.](#page-31-0) For a sequence X in X, we define hocolim_p X_p as in Section [4.](#page-9-2) As we have seen there, the facts that each sequence $X \in \mathfrak{X}$ is formed by compact objects and that \mathfrak{X} is phantomless and stable under Σ imply that for X, Y in X, we have a canonical bijection

 $\widehat{\mathcal{T}_{\mathfrak{X}}^c}(LX,LY) = \lim_{p} \mathop{\mathrm{colim}}\limits_q \mathfrak{T}^c(X_p,Y_q) \xrightarrow{\sim} \mathfrak{T}(\text{hocolim }X,\text{hocolim }Y).$

Thus we have a fully faithful functor

$$
F\colon\widehat{\mathfrak{T}^c_{\mathfrak{X}}}\to \mathfrak{T}
$$

taking LX to hocolim X. Clearly, F is endowed with a canonical isomorphism $F\Sigma \xrightarrow{\sim} \Sigma F.$

Lemma C.10. F *is a triangle functor.*

Proof. Let

(C.4)
$$
LP_1 X \longrightarrow LP_0 X \longrightarrow LP_{-1} X \longrightarrow \Sigma LP_0 X
$$

be the standard triangle associated with a sequence X of \mathfrak{T}^c_1 such that P_0X and P_1X belong to X. Put

$$
Y = \operatorname*{hocolim}_{p} X_{p}
$$

in \mathcal{T}_1 . Using the fact that P_1 , P_0 and P_{-1} commute with coproducts, it is easy to see that the standard triangle

$$
P_1Y \xrightarrow{\qquad} P_0Y \xrightarrow{\qquad} P_{-1}Y \xrightarrow{\qquad} \Sigma P_1Y
$$

is isomorphic to the image of the triangle $(C.4)$ under F.

C.8. Completions of morphic enhancements. Let $\mathcal T$ be a triangulated category with a morphic enhancement $Q_0: \mathcal{T} \to \mathcal{T}_1$ and let X be a class of sequences of T satisfying the assumptions of Section [C.5.](#page-31-0) It is natural to ask whether the triangulated category \mathcal{T}_X admits a morphic enhancement given by a completion of \mathfrak{T}_1 . Clearly, the class of sequences \mathfrak{X}_1 of \mathfrak{T}_1 needed for this is formed by the sequences X such that P_1X and P_0X belong to X. Let $Q_0^j: \mathfrak{T}_1 \to \mathfrak{T}_2$, $j = 1, 2$, be morphic enhancements of \mathcal{T}_1 such that the categories \mathcal{T}_1 , \mathcal{T}_2 together with the given functors and their needed adjoints satisfy the axioms for the first three floors of an epivalent tower of triangulated categories [\[19\]](#page-35-4). Then it is not hard to show that \mathfrak{X}_1 satisfies assumptions a), b), and c) of Section [C.5.](#page-31-0) We cannot expect that \mathfrak{X}_1 is phantomless in general but this is the case in many examples. Indeed, if $\mathfrak T$ is the perfect derived category of a right coherent ring Λ, then the canonical morphic enhancement for $\mathfrak T$ is the perfect derived category $\mathfrak T_1$ of the ring Λ_1 of upper triangular 2×2 matrices over Λ. Notice that Λ_1 is still right coherent. If X is the class of bounded Cauchy sequences in \mathfrak{I} , then \mathfrak{X}_1 is easily seen to be the class of bounded Cauchy sequences of \mathcal{T}_1 . So in this example, \mathcal{X}_1 is still phantomless. We can iterate this process to see that the epivalent tower associated with the bounded derived category of mod Λ is the bounded Cauchy completion of the tower associated with the perfect derived category of Λ . An analogous statement holds for the stable derivators, defined on the 2-category of finite directed categories, associated with the bounded derived category of mod Λ and with the perfect derived category of Λ . cf. the appendix [\[21\]](#page-35-21) to [\[26\]](#page-36-18) for these derivators.

Let MX be the class of sequences $(X_{p1} \rightarrow X_{p0})$ of morphisms of T such that (X_{p1}) and (X_{p0}) belong to \mathfrak{X} .

Lemma C.11. \mathfrak{X}_1 *is phantomless in* \mathfrak{I}_1 *if and only if* $\mathfrak{M} \mathfrak{X}$ *is phantomless in* $\mathfrak{M} \mathfrak{I}$ *.*

Proof. Let X and Y be in \mathfrak{X}_1 . By part c) of Lemma C.3, for all $p, q \geq 0$, we have an exact sequence

$$
\mathfrak{T}(\Sigma P_1 X_p, P_0 Y_q) \to \mathfrak{T}_1(X_p, Y_q) \to \mathcal{MT}(MX_p, MY_q) \to 0.
$$

We pass to the colimit over q to get an inverse system of exact sequences

$$
A_p \to B_p \to C_p \to 0.
$$

Since \lim^1 is right exact, it induces an exact sequence

$$
\lim^1 A_p \to \lim^1 B_p \to \lim^1 C_p \to 0.
$$

Now since X is phantomless, the group $\lim^1 A_p$ vanishes.
