#### Abstract

Let K be a compact set in the complex plane consisting of a finite number of continua. We study the rate of approximation of K from the outside by lemniscates in terms of level lines of the Green function for the complement of K.

**Keywords:** Hilbert's theorem, Green's function, equilibrium measure, quasiconformal curve, lemniscate.

## 1. Introduction and main results

Let  $K \subset \mathbf{C}$  be a compact set in the complex plane  $\mathbf{C}$  consisting of disjoint closed connected sets (continua)  $K^j, j = 1, 2, ..., \nu$ , i.e.,

$$K = \bigcup_{j=1}^{\nu} K^{j}; \quad K^{j} \bigcap K^{k} = \emptyset \text{ for } j \neq k; \quad \operatorname{diam}(K^{j}) > 0;$$

where diam(S) is the diameter of  $S \subset \mathbf{C}$ . We always assume that  $\Omega := \overline{\mathbf{C}} \setminus K$  is connected. Here,  $\overline{\mathbf{C}} := \mathbf{C} \cup \{\infty\}$  is the extended complex plane.

According to the Hilbert lemniscate theorem (see [12, p. 159]), for any open neighborhood U of K, there exists a polynomial p such that

(1.1) 
$$\frac{|p(z)|}{||p||_{K}} > 1, \quad z \in \mathbf{C} \setminus U,$$

where  $||f||_S$  denotes the uniform norm of  $f: S \to \mathbb{C}$  on  $S \subset \mathbb{C}$ . Certainly, the degree of p depends on U.

Let  $\mathbf{P}_n, n \in \mathbf{N} := \{1, 2, \dots\}$  be the set of all polynomials of degree at most n. Denote by  $g_{\Omega}(z)$  the Green function for  $\Omega$  with pole at  $\infty$ . It will be convenient for us to extend the Green function to K by setting it equal to zero there. Let  $s_n(K), n \in \mathbf{N}$  be the infimum of s > 0 for which there exists  $p \in \mathbf{P}_n$  such that (1.1) holds with

$$U = U_s := \{ z : g_{\Omega}(z) < s \}.$$

A result by Siciak [14, Theorem 1] for the Fekete polynomials yields that

(1.2) 
$$s_n(K) = O\left(\frac{\log n}{n}\right) \quad \text{as } n \to \infty$$

(cf. [3, Theorem 1], [9, Theorem 2], [11, Theorem 2.2]).

**Theorem 1** Under the above assumptions,

(1.3) 
$$s_n(K) = O\left(\frac{(\log \log n)^2}{n}\right) \quad as \ n \to \infty.$$

We also would like to demonstrate that if more information is known about the geometry of K, (1.3) can be further improved in the following way. A Jordan curve  $L \subset \mathbf{C}$  is called *quasiconformal* (see [1], [10, p. 100] or [8]) if for every  $z_1, z_2 \in L$ ,

$$\operatorname{diam}(L(z_1, z_2)) \le \Lambda_L |z_2 - z_1|,$$

where  $L(z_1, z_2)$  is the smaller subarc of L between  $z_1$  and  $z_2$ ; and  $\Lambda_L \ge 1$  is a constant that depends only on L. A *quasidisk* is a Jordan domain bounded by the quasiconformal curve.

**Theorem 2** If each  $K^j$  is a closed quasidisk, then

(1.4) 
$$s_n(K) = O\left(\frac{1}{n}\right) \quad as \ n \to \infty.$$

See [3, Theorem 2] for a special case of this result.

Our proof for Theorem 2 yields insights that can be leveraged to obtain other results. Specifically, that for sufficiently large n there exists polynomial  $p_n \in \mathbf{P}_n$  such that  $G(p_n) := \{z : |p_n(z)| \leq 1\}$  consists of exactly  $\nu$  disjoint Jordan domains and

$$K \subset G(p_n) \subset U_{C/n}$$

holds with a constant C = C(K) > 0. Moreover, using reasoning from [6, Section 3] it can be shown that  $p_n$  may be chosen such that all its zeros belong to K.

It is worth pointing out that (1.4) is optimal in the following sense. Let K be a closed quasidisk, i.e.  $\nu = 1$ , for which there exist  $\zeta \in \partial K, \delta > 0$  and  $1 < \beta < 2$  such that a circular sector with center at  $\zeta$ , radius  $\delta$  and opening  $\beta \pi$  is a subset of  $\overline{\Omega}$ . Then, according to [3, Theorem 3],

$$s_n(K) \ge \frac{\varepsilon}{n}, \quad n \in \mathbf{N}$$

is true with some constant  $\varepsilon = \varepsilon(K) > 0$ .

Furthermore, in the case  $\nu = 1$  it is natural to approximate K by lemniscates given by Faber polynomials  $F_n = F_n(K)$ . It was shown in [3, pp. 300-301] that for the quasidisk K constructed by Gaier [7], the inequality (1.1) does not hold for  $p = F_n, U = U_{\alpha \log n/n}$ , some constant  $\alpha = \alpha(K)$  and an infinite number of  $n \in \mathbf{N}$  (cf. (1.2)-(1.4)).

In what follows, we use following notation.

$$d(S_1, S_2) := \inf_{z_1 \in S_1, z_2 \in S_2} |z_2 - z_1|, \quad S_1, S_2 \subset \mathbf{C}.$$

For a Jordan curve  $L \subset \mathbf{C}$ , denote by  $\operatorname{int}(L)$  the bounded connected component of  $\overline{\mathbf{C}} \setminus L$ .

For a (Borel) set  $S \subset \mathbf{C}$ , denote by |S| its linear measure (length) and by  $\sigma(S)$  its two-dimensional Lebesgue measure (area).

In what follows, we denote by  $c, c_1, \ldots$  positive constants that are either absolute or they depend only on K. For the nonnegative functions a and b we write  $a \leq b$  if  $a \leq c_1 b$ , and  $a \approx b$  if  $a \leq b$  and  $b \leq a$  simultaneously.

## 2. Construction of auxiliary polynomials

In this section we review (in more general setting) the construction of the monic polynomials suggested in [15, 16, 4, 6]. For the convenience of the reader, we repeat the relevant material from these papers without proofs, thus making our exposition self-contained.

We start with some general facts from potential theory which can be found, for example, in [17, 12, 13]. The Green function  $g(z) = g_{\Omega}(z)$  has a multiple-valued harmonic conjugate  $\tilde{g}(z)$ . Let

$$\Phi(z) := \exp(g(z) + i\tilde{g}(z)),$$
  
$$K_s := \{z : g(z) = s\}, \quad s > 0.$$

Note that

(2.1) 
$$\operatorname{cap}(K_s) = e^s \operatorname{cap}(K).$$

Here  $\operatorname{cap}(S)$  is the logarithmic capacity of a compact set  $S \subset \mathbf{C}$ .

Let  $s_0 > 0$  be such that for  $0 < s < s_0$ , the set  $K_s = \bigcup_{j=1}^{\nu} K_s^j$  consists of  $\nu$  mutually disjoined Jordan curves, where  $K_s^j$  is the curve surrounding  $K^j$ . Moreover, we fix a positive number  $s^* < s_0/10$  so small that for each  $j = 1, \ldots, \nu$ ,

(2.2)  $d(\zeta, K^j) \le d(\zeta, K^j_{s_0}), \quad \zeta \in \operatorname{int}(K^j_{s^*}).$ 

Let  $\mu = \mu_K$  be the equilibrium measure of K and let  $\omega_j := \mu(K^j)$ . The function  $\phi_j := \Phi^{1/\omega_j}(\zeta)$  is a conformal and univalent mapping of  $\Omega^j := \operatorname{int}(K_{s_0}^j) \setminus K^j$  onto the annulus  $A^j := \{w : 1 < |w| < e^{s_0/\omega_j}\}$  as well as

$$K_s^j = \{ \zeta \in \Omega^j : |\phi_j(\zeta)| = e^{s/\omega_j} \}, \quad 0 < s < s_0.$$

Note that for  $\mu_s := \mu_{K_s}$ ,

$$\mu_s(K_s^j) = \mu(K^j) = \omega_j, \quad 0 < s < s_0.$$

Furthermore, for an arc

$$\gamma = \{ \zeta \in K_s^j : \theta_1 \le \arg \phi_j(\zeta) \le \theta_2 \}, \quad 0 < \theta_2 - \theta_1 \le 2\pi,$$

we have

$$\mu_s(\gamma) = \frac{(\theta_2 - \theta_1)\omega_j}{2\pi} \,.$$

Assuming that  $m \in \mathbf{N}$  is sufficiently large, i.e.  $m > 10/(\min_j \omega_j)$  we let

$$m_j := \lfloor m\omega_j \rfloor, \quad j = 1, 2, \dots, \nu - 1,$$
$$m_{\nu} := m - (m_1 + \dots + m_{\nu-1}),$$

where |a| means the integer part of a real number a.

Therefore,

(2.3) 
$$0 \le m_{\nu} - m\omega_{\nu} = \sum_{j=1}^{\nu-1} (m\omega_j - m_j) \le \nu - 1.$$

Next, for  $0 < s < s^*$ , we represent each  $K_s^j$  as the union of closed subarcs  $I_{s,k}^j, k = 1, \ldots, m_j$  such that

$$I_{s,k}^{j} \bigcap I_{s,k+1}^{j} =: \xi_{s,k}^{j}, \quad k = 1, \dots, m_{j} - 1,$$

and  $I_{s,m_j}^j \cap I_{s,1}^j =: \xi_{s,m_j}^j =: \xi_{s,0}^j$  are points of  $K_s^j$  ordered in a positive direction, as well as

$$\mu_s(I_{s,k}^j) = \frac{\omega_j}{m_j}, \quad k = 1, \dots, m_j$$

Consider also  $\psi_j := \phi_j^{-1}$ ,

$$\tilde{D}_{s,k}^{j} := \left\{ t = re^{i\eta} : \psi_{j}(e^{s/\omega_{j}+i\eta}) \in I_{s,k}^{j}, 0 \le e^{s/\omega_{j}} - r \le \frac{e^{s/\omega_{j}} - 1}{64} \right\},\$$
$$D_{s,k}^{j} := \psi_{j}(\tilde{D}_{s,k}^{j}), \quad D_{s}^{j} := \bigcup_{k=1}^{m_{j}} D_{s,k}^{j}, \quad D_{s} := \bigcup_{j=1}^{\nu} D_{s}^{j}.$$

**Lemma 1** Let  $m, q \in \mathbf{N}$  and  $c := 640\pi \max_j e^{s^*/\omega_j}$ . Then for  $m \geq m_0 :=$  $\lfloor 2cq/s^* + 10\nu/\min_j \omega_j \rfloor, s = cq/m < s^*, j = 1, ..., \nu$  and  $k = 1, ..., m_j$ , we have

(2.4) 
$$\frac{d(\xi_{s,k}^j, K^j)}{c^2 q} \le |\xi_{s,k}^j - \xi_{s,k-1}^j| \le \operatorname{diam}(I_{s,k}^j) \le |I_{s,k}^j| \le \frac{d(I_{s,k}^j, K^j)}{10q}.$$

Moreover, if q = 1 then

(2.5) 
$$\sigma(D_{s,k}^{j}) \ge \frac{d(\xi_{s,k}^{j}, K^{j})^{2}}{c^{2}}$$

as well as

(2.6) 
$$\operatorname{diam}(D_{s,k}^{j}) \leq \frac{1}{2}d(\xi_{s,k}^{j}, K^{j}).$$

For the proof of Lemma 1, see Section 3.

Next, we construct the points  $\,\zeta^j_{s,k,l}, l=1,\ldots,q\,$  as follows. For  $\,s=cq/m\,$  as in Lemma 1 and  $\,u=1,\ldots,q\,,$  let

$$m_{s,k,u}^{j} := \frac{1}{\mu_{s}(I_{s,k}^{j})} \int_{I_{s,k}^{j}} (\xi - \xi_{s,k}^{j})^{u} d\mu_{s}(\xi).$$

Consider the system of equations

$$\sum_{l=1}^{q} (r_{s,k,l}^{j})^{u} = q m_{s,k,u}^{j} =: \tilde{m}_{s,k,u}^{j}, \quad u = 1, \dots, q.$$

We interpret  $r_l := r_{s,k,l}^j$  as the roots of the polynomial  $z^q + a_{q-1}z^{q-1} + \ldots + a_0$ whose coefficients satisfy Newton's identities

(2.7) 
$$\tilde{m}_u + a_{q-1}\tilde{m}_{u-1} + \ldots + a_{q-u+1}\tilde{m}_1 = -ua_{q-u}, \quad u = 1, \ldots, q,$$

where  $\tilde{m}_u := \tilde{m}_{s,k,u}^j$  satisfy  $|\tilde{m}_u| \le q d^u, d = d_{s,k}^j := \operatorname{diam}\left(I_{s,k}^j\right)$ .

According to (2.7),

$$|a_{q-u}| \le q^u d^u, \quad u = 1, \dots, q,$$

which implies

 $|r_{s,k,l}^j| \le 2qd_{s,k}^j.$ (2.8)

See [6, Section 2] for more details.

Let  $\zeta_{s,k,l}^j := \xi_{s,k}^j + r_{s,k,l}^j$ . By virtue of (2.4) and (2.8),

(2.9) 
$$\frac{|\zeta_{s,k,l}^j - \xi_{s,k}^j|}{d(\xi_{s,k}^j, K^j)} \le \frac{|r_{s,k,l}^j|}{d(I_{s,k}^j, K^j)} \le \frac{1}{5},$$

as well as for  $\xi \in I^j_{s,k}$ ,

(2.10) 
$$\frac{|\xi - \xi_{s,k}^{j}|}{d(\xi_{s,k}^{j}, K^{j})} \le \frac{d_{s,k}^{j}}{d(I_{s,k}^{j}, K^{j})} \le \frac{1}{10}.$$

By [5, p. 23, Lemma 2.3], which is an immediate consequence of Koebe's onequarter theorem, and (2.2), we have the following lemma. Recall that  $\psi_j$  is defined in  $A^j := \{\tau : 1 < |\tau| < e^{s_0/\omega_j}\}$ . Let  $E^j := \{w : 1 < |w| < e^{s^*/\omega_j}\}$ .

**Lemma 2** Let  $w \in E^j, \tau \in A^j$  and  $\xi = \psi_j(w), \zeta = \psi_j(\tau)$ . Then

(2.11) 
$$\frac{1}{4}\frac{d(\xi, K^j)}{|w| - 1} \le |\psi'_j(w)| \le 4\frac{d(\xi, K^j)}{|w| - 1}$$

Moreover, if either  $|\tau - w| \le (|w| - 1)/2$  or  $|\zeta - \xi| \le d(\xi, K^j)/2$ , then

(2.12) 
$$\frac{1}{16} \frac{|\tau - w|}{|w| - 1} \le \frac{|\zeta - \xi|}{d(\xi, K^j)} \le 16 \frac{|\tau - w|}{|w| - 1}.$$

Next, we claim that for  $z \in K_{10s}^j, s < s^*$ ,

(2.13) 
$$|z - \xi_{s,k}^j| \ge \frac{1}{2} d(\xi_{s,k}^j, K^j).$$

Indeed, if we assume, contrary to (2.13), that

$$|z - \xi_{s,k}^j| < \frac{1}{2}d(\xi_{s,k}^j, K^j),$$

then, according to the left-hand side of (2.12),

$$e^{10s/\omega_j} - e^{s/\omega_j} \leq |\phi_j(z) - \phi_j(\xi_{s,k}^j)|$$
  
$$\leq 16(e^{s/\omega_j} - 1)\frac{|z - \xi_{s,k}^j|}{d(\xi_{s,k}^j, K^j)} < 8(e^{s/\omega_j} - 1),$$

which contradicts to the obvious inequality

$$e^{10x} - e^x \ge 8(e^x - 1), \quad x \ge 0.$$

Hence, (2.13) is proven.

A major component of the proof of (1.3) and (1.4) is the polynomial

$$P_n(z) := \prod_{j=1}^{\nu} \prod_{k=1}^{m_j} \prod_{l=1}^{q} (z - \zeta_{s,k,l}^j), \quad n = qm, s = \frac{cq}{m} \le s^*.$$

For  $z \in K_{10s}$ ,

$$mg_{\Omega_{s}}(z) + m\log \operatorname{cap}(K_{s}) = m \int_{K_{s}} \log|z - \xi| d\mu_{s}(\xi)$$

$$= \sum_{j=1}^{\nu} \sum_{k=1}^{m_{j}} \left(m - \frac{m_{j}}{\omega_{j}}\right) \int_{I_{s,k}^{j}} \log|z - \xi| d\mu_{s}(\xi)$$

$$+ \sum_{j=1}^{\nu} \sum_{k=1}^{m_{j}} \frac{1}{\mu_{s}(I_{s,k}^{j})} \int_{I_{s,k}^{j}} \log|z - \xi| d\mu_{s}(\xi)$$

$$=: \Sigma_{1}(z) + \Sigma_{2}(z).$$

Since

$$\int_{K_s} |\log |z - \xi| |d\mu_s(\xi) \leq |\log \operatorname{diam}(K_{s_0})| + \int_{K_s} \log \frac{\operatorname{diam}(K_{s_0})}{|z - \xi|} d\mu_s(\xi) \\ \leq 2 |\log \operatorname{diam}(K_{s_0})| - g_{\Omega_s}(z) - \log \operatorname{cap}(K_s) \preceq 1,$$

according to (2.3), for  $z \in K_{10s}$ , we obtain

$$|\Sigma_1(z)| \preceq \int_{K_s} |\log|z - \xi| |d\mu_s(\xi) \preceq 1.$$

Next, for the same  $z \in K_{10s}$ ,

$$\log |P_n(z)| - q\Sigma_2(z)$$

$$= \sum_{j=1}^{\nu} \sum_{k=1}^{m_j} \sum_{l=1}^q \left( \log |z - \zeta_{s,k,l}^j| - \frac{1}{\mu_s(I_{s,k}^j)} \int_{I_{s,k}^j} \log |z - \xi| d\mu_s(\xi) \right)$$

$$= \sum_{j=1}^{\nu} \frac{m_j}{\omega_j} \sum_{k=1}^{m_j} \sum_{l=1}^q \int_{I_{s,k}^j} \log \left| \frac{z - \zeta_{s,k,l}^j}{z - \xi} \right| d\mu_s(\xi).$$

Moreover, (2.4), (2.8), (2.13) and Taylor's theorem [2, pp. 125-126] imply

$$\log\left(\frac{z-\zeta_{s,k,l}^{j}}{z-\xi}\right) = \log\left(1-\frac{\zeta_{s,k,l}^{j}-\xi_{s,k}^{j}}{z-\xi_{s,k}^{j}}\right) - \log\left(1-\frac{\xi-\xi_{s,k}^{j}}{z-\xi_{s,k}^{j}}\right)$$
$$= \sum_{u=1}^{q} \frac{1}{u} \left(\left(\frac{\xi-\xi_{s,k}^{j}}{z-\xi_{s,k}^{j}}\right)^{u} - \left(\frac{\zeta_{s,k,l}^{j}-\xi_{s,k}^{j}}{z-\xi_{s,k}^{j}}\right)^{u}\right) + B_{s,k,l}^{j}(z),$$

where

$$|B_{s,k,l}^j(z)| \preceq \left(\frac{2qd_{s,k}^j}{d(z,I_{s,k}^j)}\right)^{q+1}.$$

Since

$$\sum_{l=1}^{q} \int_{I_{s,k}^{j}} \left( (\xi - \xi_{s,k}^{j})^{u} - (\zeta_{s,k,l}^{j} - \xi_{s,k}^{j})^{u} \right) d\mu_{s}(\xi)$$

$$= \sum_{l=1}^{q} \left( \frac{\omega_{j}}{m_{j}} m_{s,k,u}^{j} - (r_{s,k,l}^{j})^{u} \frac{\omega_{j}}{m_{j}} \right) = \frac{\omega_{j}}{m_{j}} \sum_{l=1}^{q} \left( m_{s,k,u}^{j} - (r_{s,k,l}^{j})^{u} \right)$$

$$= \frac{\omega_{j}}{m_{j}} \left( \tilde{m}_{s,k,u}^{j} - \sum_{l=1}^{q} (r_{s,k,l}^{j})^{u} \right) = 0,$$

for  $z \in K_{10s}$ , we have

$$\begin{aligned} |\log |P_{n}(z)| &- ng_{\Omega_{s}}(z) - n\log \ \operatorname{cap}(K_{s})| \leq q|\Sigma_{1}(z)| + |\log |P_{n}(z)| - q\Sigma_{2}(z)| \\ \preceq & q + \left|\sum_{j=1}^{\nu} \frac{m_{j}}{\omega_{j}} \sum_{k=1}^{m_{j}} \sum_{l=1}^{q} \int_{I_{s,k}^{j}} \Re \left(\sum_{u=1}^{q} \frac{1}{u} \left( \left(\frac{\xi - \xi_{s,k}^{j}}{z - \xi_{s,k}^{j}}\right)^{u} - \left(\frac{\zeta_{s,k,l}^{j} - \xi_{s,k}^{j}}{z - \xi_{s,k}^{j}}\right)^{u} \right) \right. \\ & + B_{s,k,l}^{j}(z) \right) d\mu_{s}(\xi)| \\ \leq & q + \left|\sum_{j=1}^{\nu} \frac{m_{j}}{\omega_{j}} \sum_{k=1}^{m_{j}} \sum_{u=1}^{q} \left(\frac{1}{u(z - \xi_{s,k}^{j})^{u}} \sum_{l=1}^{q} \int_{I_{s,k}^{j}} \left((\xi - \xi_{s,k}^{j})^{u} - (\zeta_{s,k,l}^{j} - \xi_{s,k}^{j})^{u}\right) d\mu_{s}(\zeta) \right. \\ & \left. + \sum_{l=1}^{q} \int_{I_{s,k}^{j}} B_{s,k,l}^{j}(z) d\mu_{s}(\xi) \right) \right| \\ \preceq & q \left(1 + \sum_{j=1}^{\nu} \sum_{k=1}^{m_{j}} \left(\frac{2qd_{s,k}^{j}}{d(z, I_{s,k}^{j})}\right)^{q+1}\right). \end{aligned}$$

To summarize, according to (2.1) and the identity

$$g_{\Omega_s} = g_{\Omega}(z) - s, \quad z \in \mathbf{C} \setminus U_s,$$

for  $z \in K_{10s}, s < s^*$ , we have

(2.14) 
$$|\log |P_n(z)| - ng_{\Omega}(z) - n \log \operatorname{cap}(K)|$$
$$\leq q^2 + q \sum_{j=1}^{\nu} \sum_{k=1}^{m_j} \left( \frac{2qd_{s,k}^j}{d(z, I_{s,k}^j)} \right)^{q+1}.$$

# 3. Distortion properties of $\phi_j$ and $\psi_j$

**Proof of Lemma 1.** Only the first and the last inequalities in (2.4) are not trivial. According to our assumption

$$\frac{1}{2} \le \frac{m\omega_j}{m_j} \le 2, \quad j = 1, \dots, \nu.$$

Let  $\eta_0^j < \eta_1^j < \ldots < \eta_{m_j}^j = \eta_0^j + 2\pi$  be determined by  $t_{s,k}^j := \phi_j(\xi_{s,k}^j) = \exp(s/\omega_j + i\eta_k^j)$ , i.e.,  $\eta_k^j - \eta_{k-1}^j = 2\pi/m_j$ .

Let  $c_2 := \max_j e^{s^*/\omega_j}$ . For  $t \in \tilde{I}^j_{s,k} := \phi_j(I^j_{s,k})$ ,

$$\begin{aligned} |t - t_{s,k}^{j}| &\leq e^{s/\omega_{j}} |e^{i\eta_{k}^{j}} - e^{i\eta_{k-1}^{j}}| \\ &\leq c_{2} \frac{4\pi}{m_{j}} \leq \frac{1}{32} \frac{cq}{m\omega_{j}} = \frac{1}{32} \frac{s}{\omega_{j}} < \frac{1}{32} \left( e^{s/\omega_{j}} - 1 \right). \end{aligned}$$

Since (2.12) implies for  $\xi \in I_{s,k}^j$ ,

(3.1) 
$$\frac{|\xi - \xi_{s,k}^j|}{d(\xi_{s,k}^j, K^j)} \le 16 \frac{|t - t_{s,k}^j|}{e^{s/\omega_j} - 1} < \frac{1}{2},$$

by (2.11), for  $t \in \tilde{I}^j_{s,k}$ , we have

$$|\psi_j'(t)| \le 8 \frac{d(\xi_{s,k}^j, K^j)}{e^{s/\omega_j} - 1} \le 16 \frac{d(I_{s,k}^j, K^j)}{e^{s/\omega_j} - 1}.$$

Hence,

$$\begin{split} |I_{s,k}^{j}| &\leq e^{s/\omega_{j}} \int_{\eta_{k-1}^{j}}^{\eta_{k}^{j}} |\psi_{j}'(e^{s/\omega_{j}+i\theta})| d\theta \leq 16c_{2} \frac{d(I_{s,k}^{j}, K^{j})}{e^{s/\omega_{j}} - 1} (\eta_{k}^{j} - \eta_{k-1}^{j}) \\ &\leq \frac{32\pi c_{2}}{cq} \frac{\omega_{j}m}{m_{j}} d(I_{s,k}^{j}, K^{j}) \leq \frac{64\pi c_{2}}{cq} d(I_{s,k}^{j}, K^{j}) \leq \frac{d(I_{s,k}^{j}, K^{j})}{10q}, \end{split}$$

which proves the last inequality in (2.4).

The first inequality in (2.4) follows from (2.12) and (3.1):

$$\frac{|\xi_{s,k}^{j} - \xi_{s,k-1}^{j}|}{d(\xi_{s,k}^{j}, K^{j})} \geq \frac{|\psi_{j}(\xi_{s,k}^{j}) - \psi_{j}(\xi_{s,k-1}^{j}|)}{16(e^{s/\omega_{j}} - 1)}$$
$$\geq \frac{1}{16\pi} \frac{2}{\pi} \frac{2\pi}{m_{j}} \frac{\omega_{j}m}{c_{2}cq} \geq \frac{1}{c^{2}q}.$$

For  $\zeta \in D_{s,k}^j$  and  $\zeta^* := \psi_j((e^{s/\omega_j} - 1)\phi_j(\zeta)/|\phi_j(\zeta)|)$  by virtue of (2.12), we have

$$d(\zeta, I_{s,k}^j) \le |\zeta - \zeta^*| < \frac{1}{4} d(\zeta^*, K^j).$$

Therefore, by (2.4),

$$\begin{aligned} |\zeta - \xi_{s,k}^{j}| &\leq |\zeta - \zeta^{*}| + |\zeta^{*} - \xi_{s,k}^{j}| \\ &\leq \frac{1}{4} \left( |\zeta^{*} - \xi_{s,k}^{j}| + d(\xi_{s,k}^{j}, K^{j}) \right) + |\zeta^{*} - \xi_{s,k}^{j}| \\ &\leq \left( \frac{5}{40} + \frac{1}{4} \right) d(\xi_{s,k}^{j}, K^{j}), \end{aligned}$$

which yields (2.6).

Moreover, (2.11) implies for  $\tau = \phi(\zeta)$  and  $\zeta \in D^{j}_{s,k}$ ,

$$|\psi_{j}'(\tau)| \ge \frac{1}{4} \frac{d(\zeta, K^{j})}{e^{s/\omega_{j}} - 1} \ge \frac{1}{8} \frac{d(\xi_{s,k}^{j}, K^{j})}{e^{s/\omega_{j}} - 1}$$

which yields (2.5) as follows

$$\begin{split} \sigma(D_{s,k}^{j}) &= \int \int_{\tilde{D}_{s,k}^{j}} |\psi_{j}'(\tau)|^{2} d\sigma(\tau) \geq \frac{1}{64} \frac{d(\xi_{s,k}^{j}, K^{j})^{2}}{(e^{s/\omega_{j}} - 1)^{2}} \sigma(\tilde{D}_{s,k}^{j}) \\ &= \frac{1}{64} \frac{d(\xi_{s,k}^{j}, K^{j})^{2}}{e^{s/\omega_{j}} - 1} |\tilde{I}_{s,k}^{j}| \geq \frac{1}{64} \frac{2\pi}{m_{j}} \frac{\omega_{j}}{c_{2}s} d(\xi_{s,k}^{j}, K^{j})^{2} \geq \frac{d(\xi_{s,k}^{j}, K^{j})^{2}}{c^{2}}. \end{split}$$

1		-	

Since by Lemma 1 and (2.13) for  $z \in K_{10s}$ ,

$$\frac{2qd_{s,k}^j}{d(z,I_{s,k}^j)} \le \frac{2}{5},$$

according to (2.14) we have

$$|\log |P_n(z)| - ng_{\Omega}(z) - n\log \operatorname{cap}(K)|$$
  
$$\preceq q^2 + q^3 \left(\frac{2}{5}\right)^q \sum_{j=1}^{\nu} \sum_{k=1}^{m_j} \left(\frac{d_{s,k}^j}{d(z, I_{s,k}^j)}\right)^2.$$

Furthermore, by Lemma 1, (2.5) and (2.13), for  $z \in K_{10s}$ ,

$$\sum_{j=1}^{\nu} \sum_{k=1}^{m_j} \left( \frac{d_{s,k}^j}{d(z, I_{s,k}^j)} \right)^2 \preceq \sum_{j=1}^{\nu} \sum_{k=1}^{m_j} \frac{\sigma(D_{s,k}^j)}{d(z, D_{s,k}^j)^2} \preceq \int \int_{D_s} \frac{d\sigma(\zeta)}{|\zeta - z|^2}.$$

Since by the Loewner inequality (see [5, p. 27, Lemma 2.5]),  $d(z, K_s) \succeq s^2$ , using polar coordinates with center at z, we obtain

$$\int \int_{D_s} \frac{d\sigma(\zeta)}{|\zeta - z|^2} \preceq \log \frac{\operatorname{diam}(K_{s_0})}{d(z, K_s)}, \preceq \log \frac{s_0}{s},$$

which yields

(3.2) 
$$|\log |P_n(z)| - ng_{\Omega}(z) - n\log |\operatorname{cap}(K)| \leq q^2 + 2^{-q}\log m.$$

**Proof of Theorem 1.** Without loss of generality, we assume that n is sufficiently large. First, let n = mq, where  $q = q_m := \lfloor 2 \log \log m \rfloor$ . Then by (3.2), for  $z \in K_{10cq/m}$ ,

$$|\log |P_n(z)| - ng_{\Omega}(z) - n\log |\operatorname{cap}(K)| \leq (\log \log m)^2 \asymp (\log \log n)^2$$

Thus, the maximum principle implies that for  $P_n^* := P_n \operatorname{cap}(K)^n$ ,  $s = cq/m = cq^2/n$  and  $z \in \mathbf{C} \setminus U_{10s}$ ,

$$\exp\left(ng_{\Omega}(z) - c_3(\log\log m)^2\right) \le |P_n^*(z)| \le \exp\left(ng_{\Omega}(z) + c_3(\log\log m)^2\right).$$

Therefore,

$$||P_n^*||_K \le ||P_n^*||_{K_{10s}} \le \exp\left(c_3(\log\log n)^2\right).$$

At the same time, for  $z \in \mathbf{C} \setminus U_{\delta}, \delta = 3c_3(\log \log n)/n$ ,

$$|P_n^*(z)| \ge \exp\left(2c_3(\log\log m)^2\right) > ||P_n^*||_K,$$

which proves (1.3) for  $n = mq_m$ .

For arbitrary (sufficiently large) n we find  $m \in \mathbf{N}$  such that

 $mq_m \le n < (m+1)q_{m+1}.$ 

Since

$$1 \le \frac{n}{mg_m} \le \frac{(m+1)q_{m+1}}{mq_m} \to 1 \quad \text{as } n \to \infty,$$

we obtain

$$s_n(K) \le s_{mq_m}(K) \preceq \frac{(\log \log m)^2}{mq_m} \preceq \frac{(\log \log n)^2}{n},$$

which completes the proof of (1.3).

From now on we assume that each  $K^j$ ,  $j = 1, ..., \nu$  is a quasidisk. Since  $\partial \Omega^j$  consists of two quasiconformal curves,  $\phi_j$  can be extended to a  $Q_j$ -quasiconformal homeomorphism of a neighborhood of  $\overline{\Omega^j}$  to a neighborhood of  $\overline{A^j}$  with some  $Q_j \geq 1$ . Therefore, repeating the proof of [5, p. 29, Theorem 2.7] we can establish the following result.

**Lemma 3** Let  $\zeta_k \in \Omega^j, w_k := \phi_j(\zeta_k), k = 1, 2, 3$ . Then:

(i) the conditions  $|\zeta_1 - \zeta_2| \leq C_1 |\zeta_1 - \zeta_3|$  and  $|w_1 - w_2| \leq C_2 |w_1 - w_3|$  are equivalent; besides, the constants  $C_1$  and  $C_2$  are mutually dependent and depend on  $Q_j$  and K;

(*ii*) if 
$$|\zeta_1 - \zeta_2| \le C_1 |\zeta_1 - \zeta_3|$$
, then

$$\frac{1}{C_3} \left| \frac{w_1 - w_3}{w_1 - w_2} \right|^{1/Q} \le \left| \frac{\zeta_1 - \zeta_3}{\zeta_1 - \zeta_2} \right| \le C_3 \left| \frac{w_1 - w_3}{w_1 - w_2} \right|^Q,$$

where  $Q := \max_{j} Q_{j}$  and  $C_{3} = C_{3}(C_{1}, Q, K) > 1$ .

For  $\zeta \in \Omega^j$  let  $\tilde{\zeta} := \psi_j(\phi_j(\zeta)/|\phi_j(\zeta)|)$ . We fix  $\zeta_j^* \in K_{s_0}^j$ . By Lemma 3, for  $\zeta \in K_s^j$  and  $z \in K_{10s}^j, s < s^*$ ,

(3.3) 
$$\frac{d(\zeta, K^j)}{|\zeta - z|} \le \left| \frac{\zeta - \tilde{\zeta}}{\zeta - z} \right| \preceq \left( \frac{s}{|\phi_j(\zeta) - \phi_j(z)|} \right)^{1/Q},$$

(3.4) 
$$d(\zeta, K^j) \le |\zeta - \tilde{\zeta}| \asymp \left| \frac{\zeta - \tilde{\zeta}}{\zeta - \zeta_j^*} \right| \preceq \left| \frac{\phi_j(\zeta) - \phi_j(\tilde{\zeta})}{\phi_j(\zeta) - \phi_j(\zeta_j^*)} \right|^{1/Q} \asymp s^{1/Q}.$$

Furthermore, by virtue of Lemma 1, for  $z \in K_{10s}$  and  $q \in \mathbf{N}$ ,

$$\int_{K_s^j} \frac{d(\zeta, K^j)^q}{|\zeta - z|^{q+1}} |d\zeta| = \sum_{k=1}^{m_j} \int_{I_{s,k}^j} \frac{d(\zeta, K^j)^q}{|\zeta - z|^{q+1}} |d\zeta|$$
  

$$\succeq \sum_{k=1}^{m_j} \frac{d(I_{s,k}^j, K^j)^q |I_{s,k}^j|}{d(z, I_{s,k}^j)^{q+1}} \succeq \sum_{k=1}^{m_j} \left(\frac{d_{s,k}^j}{d(z, I_{s,k}^j)}\right)^{q+1}.$$

Therefore, according to (2.14) for  $z \in K_{10s}^r, r = 1, \ldots, \nu$ ,

$$\begin{aligned} |\log|P_n(z)| &- ng_{\Omega}(z) - n\log \ \operatorname{cap}(K)| \\ \preceq & 1 + \sum_{j=1, j \neq r}^{\nu} \int_{K_s^j} d(\zeta, K^j)^q |d\zeta| + \int_{K_s^r} \frac{d(\zeta, K^r)^q}{|\zeta - z|^{q+1}} |d\zeta| \end{aligned}$$

Let  $q := \lfloor 2Q \rfloor$  and  $w = \phi_r(z)$ . Then by (2.11), (3.3) and (3.4),

$$\int_{K_s^j} d(\zeta, K^j)^q |d\zeta| \quad \preceq \quad \frac{1}{s} \int_{|\tau|=e^{s/\omega_j}} d(\psi_j(\tau), K^j)^{q+1} |d\tau|$$
$$\quad \preceq \quad s^{(q+1)/Q-1} \preceq 1.$$

as well as

$$\int_{K_s^r} \frac{d(\zeta, K^r)^q}{|\zeta - z|^{q+1}} |d\zeta| \quad \preceq \quad \frac{1}{s} \int_{|\tau| = e^{s/\omega_r}} \left( \frac{d(\psi_r(\tau), K^r)}{|\psi_r(\tau) - \psi_r(w)|} \right)^{q+1} |d\tau|$$
$$\quad \preceq \quad \frac{1}{s} \int_{|\tau| = e^{s/\omega_r}} \frac{s^{(q+1)/Q}}{|\tau - w|^{(q+1)/Q}} |d\tau| \leq 1.$$

Thus, the maximum principle implies that for  $P_n^*(z) := P_n(z) \operatorname{cap}(K)^n$  and  $s = cq/m = cq^2/n, n = qm, m > m_0$ ,

(3.5) 
$$\frac{1}{c_4}e^{ng_{\Omega}(z)} \le |P_n^*(z)| \le c_4 e^{ng_{\Omega}(z)}, \quad z \in \mathbf{C} \setminus U_{10s}.$$

**Proof of Theorem 2.** Without loss of generality, we assume that n is sufficiently large. First, let n = mq be such that (3.5) holds. We have

$$|P_n^*||_K \le ||P_n^*||_{K_{10s}} \le c_4 \exp\left(10cq^2\right).$$

If we let

$$c_5 := 2\log c_4 + 11cq^2,$$

then for  $z \in \mathbf{C} \setminus U_{c_5/n}$ , we get

$$|P_n^*(z)| \ge \frac{1}{c_4} \exp(c_5) > c_4 \exp(10cq^2),$$

which shows that  $s_n(K) \leq c_5/n$ .

If  $mq < n \le m(q+1)$ , then

$$s_n(K) \le \frac{c_5}{mq} \le \frac{2c_5}{m(q+1)} \le \frac{2c_5}{n}.$$

Hence, in both cases we have (1.4).
